Singh alleged that their joining proves the wrestlers' protests against him were part of a conspiracy orchestrated by the grand old party, with former Haryana chief minister Bhupinder Singh Hooda as the mastermind. The two wrestlers led a major protest against Singh in 2023, accusing him of sexually harassing several female wrestlers during his time as WFI chief. Singh also said that he is facing three major cases and the matter is subjudice. He mentioned that his statements are on camera and as things unfold, the opposition will not be in a position to comment. In its first list of 32 candidates for the Haryana assembly election, Congress fielded Vinesh Phogat as it's candidate from Julana constituency in Jind district. On Sunday, Vinesh Phogat received a warm welcome from party workers and supporters in Julana as she kicked off her campaign. "Whatever I have won in wrestling, it was because of people. Hopefully, I will be successful in this as well. I will talk about the wrestlers' protest at Jantar Mantar later, BJP had allowed us to sit there. Torture of convict in Vellore: FIR on prison DIG, 13 cops

VELLORE: In connection with the alleged harassment and torture of a prisoner sentenced to life at the Vellore Central Prison, CB-CID registered an FIR on Friday against 14 prison officials, including Vellore Range Prison DIG R Rajalakshmi,

The court instructed the CB-CID SP in Chennai to initiate criminal proceedings based on the CJM's report and to submit an action-taken report by September 20. Further probe is under way.

Tiruchy-Karaikal DEMU passenger train halted after fire scare, passengers evacuated

TIRUCHY: Southern Railway suspended the operation of the Tiruchy-Karaikal DEMU passenger (Train no. 06880) on Saturday after smoke was detected in the rear carriage of the train. No casualty was reported as all the passengers were immediately evacuated and the smoke was put out within 10 minutes. Hundreds of passengers were on board at the

time of the incident after the train started the trip from Tiruchy railway junction at 8.35 am. The smoke was noticed by the guard when the train reached Thiruverumbur station about 9 am. The train was halted there and the onward service was cancelled.

The railway's rapid response team and Tiruchy Divisional Railway Manager MS Anbalagan, along with other senior officials, headed to the spot and held inspections. The passengers who had deboarded were shifted to the Sawantwadi Road-Velankanni Special (Train no. 00107). This train was then allotted stoppages at all stations en route to ensure that the passengers on the Tiruchy-Karaikal train don't get affected from its cancellation. Sources said the special train left Thiruverumbur about 9.30 am.

Motivational speaker Mahavishnu arrested in Chennai over controversial remarks

CHENNAI: Police arrested Mahavishnu, a self-proclaimed motivational speaker, soon as he arrived at the Chennai international airport from Australia on Saturday. The speaker, founder of Paramporul Foundation, was arrested under the charges of provoking enmity between different groups of people and intentionally insulting a person with disability. During a programme at the Saidapet government school on August 28, Mahavishnu made controversial remarks about past-life sins and disability.He allegedly insulted a visually impaired teacher, who questioned the appropriateness of his speech. The video of the incident went viral on social media,

sparking a huge outrage from rationalists and disability rights activists.In a video statement on Friday night, he said he would meet presspersons at the airport regarding the allegations levelled against him. However, he was picked up by the police for questioning before the meeting. Sources said a police team was waiting for him at the airport and questioned him at an undisclosed location.Based on a complaint from N Vijayaraj, Saidapet police inspector K Settu registered an FIR under sections 192, 196 (1) (a), 352, and 353 (2) of the BNSS as well as section 92 of The Rights of Persons with Disabilities Act, 2016. The complainant said the speaker had insulted a visually impaired



teacher and contended that students would lose respect for their teachers if the latter were addressed in such a language in front of them. Meanwhile, the chairman of the School Management Committee of Ashok Nagar Girls' Higher Secondary School, M Chitrakala, refuted allegations by the school headmistress and teacher that the speaker was invited by the

committee to deliver a motivational talk.She claimed neither the headmistress nor the teachers informed the committee about such an event. "The school who is part of the SMC, organised the meeting," she said. The election for the SMC was conducted only on August 24, she said, and the meeting for the committee itself has not been convened yet. Home guards, constables of West Odisha get one-day Nuakhai leave

SAMBALPUR/BHUBANESWAR: In a rare gesture, Odisha Police on Saturday announced a one-day Nuakhai leave for its lower ranked personnel posted in western Odisha.IG, Northern Range Himansu Lal told The New Indian Express, that the police personnel in the rank of home guard and constables have been given a day's leave to celebrate the festival. Sources said as the Armed Police Reserve (APR) and lower rank personnel will remain off duty on Sunday, personnel from neighbouring districts will be deployed in Sambalpur to maintain law and order during the festival, which will coincide with Chief Minister Mohan Charan Majhi's visit to the district.

However, police officers in the rank of ASI and above will report to work and may be allowed to avail a compensatory off at a later date, said sources. Sambalpur SP, Mukesh Kumar Bhamoo said, "Considering the significance of Nuakhai for the people of western Odisha, the district police force except officers have been given a holiday for Nuakhai.

Since the officers have better threat perception of the local areas, they have been asked to remain present at their respective stations given the chief minister's visit. Additionally, extra forces have been sent from the headquarters to oversee security arrangements during the chief minister's visit.

The officers will be compensated with a special leave later, he added Meanwhile, security has been tightened for the two-day visit of the chief minister to the district. As many as 30 platoons of police force has been deployed in the city. The chief minister will attend the launch of CM-Kisan Yojna in Sambalpur and attend Nuakhai Bhetghat events in the city.

Monsoon preparedness: Tenders floated for 550 dewatering pumps in Chennai

CHENNAI: Chennai Corporation has floated tenders for the supply of 466 tractor-driven and 88 diesel enginedriven dewatering pumps, to address any waterlogging during the upcoming monsoon season, at an estimated cost of Rs 21 crore.The corporation aims to deploy these pumps across all 15 zones in the city - north region (zones 1 to 5) will get 120 pumps, central (zones 6 to 10) will get 170 pumps, and south (ones 11 to 15) will get 176 pumps. Each tractor-driven ring pump, equipped with 4"x4 suction and delivery pipes, will be contracted for 300 hours per pump in order to dewater flooded areas, especially low lying areas, in the event of heavy rain. Depending on the severity of rainfall, the



equipment will be in operation from September to December.Designed to handle sewage water mixed with debris like plastic bottles, stones, glass, and other solid waste, the dewatering pump will

MALKANGIRI: Odisha Hydro Power Corporation (OHPC) Limited, will set up a 500 MW solar-based pumped storage project (PSP) in the vicinity of Balimela hydroelectric station. The PSP will generate 1,095 million units (MU) power as part of Odisha Renewable Energy Policy which provides multiple incentives including provision of Viability Gap Funding (VGF) to promote pumped storage projects in the state. The solar based project will have two units, each with capacity of generating 250

MW power. At present, the Balimela Hydro Electric Project (HEP) generates 510 MW power.

The hydro-electric project at Balimela is capable of producing average annual energy output of 1,183 MU. At present, OHPC is preparing a detailed project report (DPR) to construct a 500 MW (2 x 250 MW) the vicinity of Balimela town. The proposed Balimela PSP will utilise the existing Balimela reservoir as an upper reservoir and a new lower reservoir will be constructed at Kharika Jhora Nala, and it will be used to store water for pumping it to the upper reservoir in a closed cycle operation, Bhubaneswar-based OHPC Limited corporate office director (operations) Asish Kumar Mohanty told The New Indian

PSP at Kharika Jhora Nala, located in The proposed PSP will have an underground powerhouse located near the lower reservoir at Kharika Jhora Nala, equipped with two vertical-axis reversible-type francis hydroelectric units having capacity of 250 MW each. The pre-feasibility report of Balimela PSP was prepared by OHPC through THDC India Ltd, a consultancy service provider. Water and Power Consultancy Services(WAPCOS) Limited has been engaged for preparing the DPR for the project. Mohanty said the topographical survey, surface geological mapping and hydrology study has been completed. A geotechnical investigation to access the rock quality is underway.

Minor rape survivor's parents allege assault by Chennai cops, police deny charge

Parents of a minor rape survivor in Chennai have alleged that they were assaulted and detained for hours at a police station after they reported the case.

>Girl's father claims police mistreated family, video surfaces ➤ Mother got to know about rape on August 30 after medical tests **▶**Police deny misconduct, arrest 14-year-old juvenile Chennai. The parents of a 10-yearold rape survivor in Chennai have alleged that they were beaten by cops and detained at a police station for hours on August 31. However, the police denied the allegations. On August 30, the child's mother noticed a strong odour coming from her daughter after school. Suspecting something was amiss, she took the girl to a local clinic. Medical professionals there suspected sexual abuse and referred the family to a government hospital. According to the FIR, the mother initially withheld the information from her husband, but later sought further medical evaluation at the hospital. The doctors confirmed that the girl



had been sexually assaulted. According to the mother's complaint, the minor took the name of a man named Satish, a water delivery person, as the accused. The child even told her mother that Satish had abused her over a period of seven days and threatened her with dire consequences if she reported the abuse. Hours later, a police team arrived at the hospital to

record the mother's statement. The cops also questioned the minor and the medical staff. The situation took a dramatic turn with the release of a video purportedly recorded by an NGO worker. In the video, the girl's father, a construction worker, alleged that police officers had physically assaulted him and treated him unfairly.He also claimed that officers questioned his wife's behaviour and threatened to file a counter-complaint against him. "They raised questions about my wife's behaviour and even threatened to file an FIR against me," the father was heard speaking

Woman found dead by road with burn marks in Ghaziabad

Ghaziabad. A partially burnt body was found from an underpass near Behta Hajipur in the Loni Border area on Saturday. According to the police, the woman appears to be around 30 years old. Her face, neck and feet have burn marks. While waiting for the post-mortem results, the police have undertaken legal proceedings and are conducting an investigation into the recent cases of missing persons in the area.

4 of a family injured as roof caves in after rain

Noida: Four members of a family were injured when the roof of their house collapsed following heavy rainfall early Saturday morning in Cholas village of Jarcha in Greater Noida. Among the injured are the house owner, Saifu (35), his sons Sohan (4) and Ali Khan (2), and a 50-year-old relative, Salil. Man gets 20 yrs' jail for teen's rape in '19

Noida. A 30-year-old man was sentenced to 20 years of imprisonment for raping a 16-year-old girl in Surajpur in 2019. Chawanpal Singh, special public prosecutor, said that the survivor lived in Surajpur with her family. The accused lived nearby and ran a grocery shop. According to the complaint of the girl's mother filed on July 21, 2019, she had gone out to buy medicine while her husband, a construction worker, was at work. During this time, the accused entered their home and raped her daughter. "He also tied her hands and threatened her with dire consequences if she told anyone about the incident," Singh said.

Based on the complaint, police registered a case and arrested the accused, who was produced in court and then placed in judicial custody. The chargesheet was filed on Dec 6, 2019, and the charges were framed on Jan 23, 2020. The prosecution presented seven witnesses, including the girl, her mother, a doctor, and police officials. During the trial, the survivor testified that the accused had barged into her room and raped her. "I tried to raise an alarm but he overpowered me. When my mother returned home, I told her about the incident. She went to the accused's house, but his family members hurled abuses and began quarrelling with her. Then my mother filed a police complaint," she said.Kajal Jain, the doctor who conducted the survivor's medical examination, confirmed that she had abrasions and injury marks on her private parts. Additionally, forensic examination revealed the presence of the accused's sperm in the survivor's body.

Ajit Bhati, the accused's lawyer, presented a local resident as a defence witness, who said that the accused had gone to the survivor's house to collect his grocery dues. "He was enquiring about the dues, and this led to an argument. He then returned home. The girl's mother later filed an FIR against him," he said.Saurabh Dwivedi, special judge Pocso Act, convicted the accused on Friday. "He is sentenced to 20 years of rigorous imprisonment under Section 4 of the Pocso Act; five years of imprisonment under Section 452 (trespass) of IPC," the court said. Additionally, he was

Worried over score, 2 Class 8 students flee Noida school, found at Anand Vihar rail station

Noida. Two Class 8 students who went missing from outside their school in Sector 56 on Sept 5 morning were found at Anand Vihar Railway station on Saturday. The boys were apparently nervous after their exam results were announced and feared their parents might scold them. The boys, both 13, were allegedly spotted leaving Uttarakhand Public School together around 11 am from a back gate of the campus by their classmates even as one of their parents was waiting outside the school's front gate on Thursday. The school got over early on Thursday, around 10.45 am, due to Teacher's Day programme.

Seven police teams scanned footage of at least 500 CCTV cameras to trace them after a complaint was lodged by their parents on Friday."Our teams scanned the school's CCTV camera feeds first and found the two boys took an auto from outside the campus and were dropped off at a CNG station. To find more clues, our teams were deployed across Delhi borders. From CCTV footage of over 500 cameras, placed at different corners of the city, including petrol pumps, shops and streets, we finally traced them to the railway station. When we reached the boys, they were hiding under a staircase at the station and were not willing to return," SHO Sector 58 Amit Kumar said. Additional DCP (Noida) Manish Kumar Mishra said cops accessed footage of cameras installed at various societies, metro stations and shops from Delhi to Ghaziabad and all adjacent border areas. "The team that traced the children was awarded a prize money of Rs 20,000 by the police commissioner," he said. Father of one of the boys told TOI it was a blessing that the children returned home safely. "Don't know what bothered him so much, but from now onwards we will be aware and try to understand his situation more," he said.

Rush hour is Ghaziabad's rash hour too: Most accidents between 6 pm & 9pm

Ghaziabad: The evening rush hour is also the most dangerous time to be on the city's roads. A recent survey by Ghaziabad police has revealed that most road crashes in the city were recorded between 6 pm and 9 pm this year. Between Jan 1 and July 31, a total of 61 accidents were reported over these three hours which left 23 dead and 51 injured, the data shows. Forty road crashes were reported between 6am and 9am, the morning rush hour. At least 27 people died — the highest number of fatalities to be recorded within a span of three hours — and 43 others were injured in

these crashes, the data shows. An estimated 1 lakh vehicles use Ghaziabad roads daily. The traffic pressure increases by an estimated 30% during the rush hours. Between 9am and 12pm, when the morning rush-hour traffic starts to ease, Ghaziabad saw 30 accidents that left seven dead - the least number of fatalities — and 34 injured. In contrast, 25 people were killed — the second-highest in terms of road crash fatalities - were reported between 9 pm and 12 am when the city recorded 55 crashes.Between 3am and 6am, 15 accidents were reported that left nine dead and as many injured. In all, a total of 329 accidents were recorded in the first seven months of the year, which left 145 dead and 322 injured.

Court initiates trial against doctor after family alleges negligence

Gurgaon. A district court initiated trial against a doctor accused of medical negligence by the family of a 22-yearold woman who died during treatment at a private hospital around two years ago. Over the past 21 months, the woman's family claimed to have lodged multiple complaints against the doctor but the police didn't act on it and the medical board gave him a clean chit. An FIR was registered against the woman's family on a countercomplaint filed by the doctor."In April 2023, a false FIR was filed by Dr Rahul Lalit against the bereaved family of the late Simran Chhabra amid medical negligence allegations. The FIR was cancelled in June 2024 on the direction of the court," said advocate Nishant Bharihoke, counsel for the deceased's family.On January

21, 2023, Simran Chhabra went to Judicial magistrate Deepanshu Sarkar, in Jagdamba Hospital around 1pm as she had fever, cough and body pain. According to Bharihoke, Simran developed complications while undergoing treatment, presumably due to an allergic reaction to the drug injected - Dynapar 75. Then, on the advice of the accused, she was taken to another hospital on Railway Road around 1.30pm, where she was declared dead. After months of running from pillar to post to get proceedings against the accused started, Simran's family faced disappointment when a district medical negligence board set up in June 2023 for inquiry into the case gave the doctor a clean chit in its interim report. Following this, the family challenged this report and inaction by the police in court.

his order dated September 4, observed that there were several discrepancies in the statements made by the doctor before the district medical board and the actual chain of events.

'Adverting to the discrepancies in the statements made by Dr Rahul Lalit before the inquiry board against the chain of events which could have taken place as per the material available on record, it shows that there is sufficient material on record for prima facie proceedings against the doctor for medical negligence under section 304A of IPC," the order read.

"Dr Rahul Lalit is directed to be summoned by the court to face trial for the commission of the offence punishable under section 304A of IPC," it added.

Ghaziabad Master Plan for 2031 passes test in 5th attempt

Ghaziabad: After almost two years of hectic deliberations, the GDA board on Friday approved the draft of the unified Master Plan 2031, which encompasses areas of Ghaziabad, Loni and Modinagar/Muradnagar. The new plan covers an overall developed area of about 33,543.1 hectares, including 18,687.8 hectares in Ghaziabad, 6,874.9 hectares in Modinagar and 7,980.4 hectares in Loni. With the city's population estimated to touch 48 lakh by 2031, GDA has reserved about 39.8% (12873.1 hectares) of the area for residential development. About 2.2% of land (702.85 hectares) is earmarked for commercial use.

The plan also incorporates TOD zones along the 1.5km-long rapid rail (4,261.43 hectares) and 500m along the Red Line and Blue Line metro corridors (616.61 hectares). A Special Development Area (909.82 hectares) will also come up around the Duhai RRTS depot.The master plan draft will now be sent to the state

HC refers 'misleading' affidavit by DGP

GURGAON. Finding the stand of the Haryana DGP as a "deliberate attempt to create a maze by mischievous use of expression and filing misleading affidavits" regarding compliance of directions of Supreme Court (SC) for installation of CCTV cameras in all police stations, the Punjab and Haryana high court has referred the DGP's affidavit to apex court for consideration. The court observed that even though the office of Haryana DGP made an attempt to initially portray CCTV cameras had been installed at all places by using the word "police stations" mischievously, only on being confronted did it acknowledge that CCTV cameras were not bound to be installed at all investigation cells — such as CIA, EOW and IT cells, which may be and are used as interrogation rooms — as they are not notified as police stations. "This court would have ordinarily proceeded against the top police officers of the state for deliberately creating a maze by mischievous use of expression and filing of misleading affidavits before this court; however, in the fitness of things and considering judicial discipline since the SC is also seized of the matter, I deem it appropriate at this juncture to keep proceedings for contempt against the DGP in abeyance and am of the view that the matter needs to be brought to the notice of the SC bench dealing with the enforcement of the order in the case titled Paramvir Singh Saini," the HC ordered. The HC directed the registrar general of the HC to send a copy of the order along with affidavits filed by the DGP, Haryana, to the SC. The registrar general of the SC has also been requested to bring this order to the notice of the bench of the SC for passing appropriate

orders. On a previous date of hearing, the HC had issued contempt notices to the Haryana DGP to show cause why contempt proceedings be not taken against him for wilful disobedience of orders passed by the SC.Responding to the contempt notice, an affidavit was filed by DGP, stating that as the matter relates to disobedience of direction of the SC, if any, the contempt proceedings for non-compliance of the order of the SC cannot be initiated before or by HC. Raging wildfire scorches area near California national park, evacuations ordered

World Evacuations were expanded Saturday as a wildfire with leaping flames scorched the foothills of a national forest east of Los Angeles, amid a days-long heat wave that pushed temperatures into the triple digits across the region. The so-called Line Fire was burning uncontrolled along the edge of the San Bernardino National Forest, about 65 miles (105 kilometers) east of LA. As of Saturday afternoon, the blaze charred about 11 square miles (28 sq. km.) of grass and chaparral, leaving a thick cloud of dark smoke blanketing the area. The fire began Thursday evening, and the cause is under investigation. About 500 firefighters were battling the blaze, supported by waterdropping helicopters that hovered over homes and hillsides, along with aircraft.

Firefighters said the blaze had the "potential for large fire growth" in the next 12 hours. The fire produced coiling clouds of dense smoke, and flames could be seen cresting hillside ridges.No injuries were reported, and no homes or other structures had been damaged or destroyed. The National Weather Service said downtown Los Angeles hit a high of 112 degrees Fahrenheit (44 Celsius) Friday, which marked the third time since 1877 that a high of 112 degrees or more has been reached there.

Rare ancient copy of US Constitution, missing for centuries, up for auction

World Historical document appraiser and collector Seth Kaller spreads a broad sheet of paper across a desk. It's in good enough condition that he can handle it, carefully, with clean, bare hands. There are just a few creases and tiny discolourations, even though it's just a few weeks shy of 237 years old and has spent who knows how long inside a filing cabinet in North Carolina. At the top of the first page are familiar words but in regular type, instead of the sweeping Gothic script we're used to seeing: "WE, the People ..."And people will get a chance to bid for this copy of the U.S. Constitution — the only of its type thought to be in private hands — at a sale by Brunk Auctions on September 28 in Asheville, North Carolina. The minimum bid for the auction of \$1 million has already been made. There is no minimum price that must be reached. This copy was printed after the Constitutional Convention finished drafting the proposed framework of the nation's government in 1787 and sent it to the Congress of the ineffective first American government under the Articles of Confederation, requesting they send it to the states to be ratified by the people.

It's one of about 100 copies printed by the secretary of that Congress, Charles Thomson. Just eight are known to still exist, and the other seven are publicly owned.

Multiple people shot along highway in US state of Kentucky



WASHINGTON. Multiple people were shot along a highway in the southern US state of Kentucky, authorities said Saturday, as police hunted for a suspect considered "armed and dangerous."our to six people had been shot, Kentucky State Police spokesman Scottie Pennington told local media. There were "multiple severe injuries" but no confirmed deaths, local news station WYMT reported, citing the Laurel County Sheriff's Office. Authorities were searching for Joseph Couch, 32, considered a person of interest in the shooting that closed Interstate 75 in both directions due to the "active shooter situation.""Consider armed and dangerous," the sheriff's office said in its Facebook post about Couch, following its initial report of

"numerous persons" shot. "Do not attempt to approach.

"The suspect has not been caught at this time we are urging people to stay inside!" Pennington posted on Facebook.He later told the Louisville Courier Journal that "we have no clue where (the suspect) is at.'

Trump rebukes woman who accused him of assault ahead of debate with Kamala Harris

World Shortly after appearing in court for an appeal of a decision that found him liable for sexual abuse, Donald Trump stepped in front of television cameras on Friday and brought up a string of past allegations of other acts of sexual misconduct, potentially reminding voters of incidents that were little-known or forgotten. The former president has made hitting back at opponents and accusers a centrepiece of his political identity, but his performance at his namesake Manhattan office tower was startling even by Trump's combative standards. At times, he seemed to relish using graphic language and characterisations of the case brought by advice columnist E. Jean Carroll, which could expose the former president to further legal challenges from Carroll's attorneys. His remarks were especially striking given that they came four days before Trump will debate Vice President Kamala Harris, with early voting about to begin in some parts of the country and Election Day just two months away. Trump is doing his best to stay in the public eye while Harris prepares for the debate in private, meeting with her

advisers in Pittsburgh. That's a reflection of their divergent campaign styles, with Trump frequently engaging with reporters — albeit often in friendly settings — while Harris has done just one interview and no news conferences since taking President Joe Biden's place atop the Democratic ticket. His team had billed Friday's appearance as a press conference and Trump repeatedly brought up Harris' lack of news conferences. But Trump took no questions and instead talked about the cases against him for an hour while hardly mentioning any campaign issues."I'm running for president, and I have all these cases all of a sudden come," he said. "And they're fake cases."Trump's campaign raised tens of millions of dollars off his previous indictments, convictions and appearances in court. But it's unclear how focusing on his legal woes will help him now as he works to win over undecided voters including independents and those on the fence in critical swing states, ahead of a critical debate on Tuesday that will likely draw tens of millions of viewers.TRUMP HAS DISREGARDED HIS AIDES'

He said of a woman who had accused him of sexual misconduct on a plane in the 1970s, "she would not have been the chosen one," and of Carroll, "I never touched

Israeli strikes 'targeting Hamas militants' across Gaza kill 61 in 48 hours

World Israeli military strikes across the Palestinian Gaza Strip killed at least 61 people in the space of 48 hours, medics said on Saturday, as Israeli forces battled Hamas-led militants in the territory.

Eleven months into the war, numerous rounds of diplomacy have so far failed to clinch a ceasefire deal to end the conflict and bring the release of Israeli and foreign hostages held in Gaza. The Israeli military said the strikes targeted Hamas gunmen who were operating in the compound. Five more people were killed in a strike on a house in Gaza City, Palestinian medics said, with a total of 28 people killed on Saturday. The armed wings of the Hamas, Islamic Jihad and Fatah groups said they had fought Israeli troops across Gaza with anti-tank rockets and mortar bombs, and in some incidents detonated bombs to target tanks and other army vehicles.

The two warring sides continued to blame one another for the failure of mediators,

including Qatar, Egypt and the United States, to broker a ceasefire. The U.S. is preparing to present a new proposal, but the prospects of a breakthrough appear slim as gaps between the sides remain POLIO VACCINATIONS CONTINUE wide.CIA Director William Burns, the On Thursday, U.S. Secretary of State chief U.S. negotiator, told an event in London that a more detailed proposal would be made in the coming days.

"Donald's always been a fan of mine, he has been to my concerts many, many times, so I have always been friendly toward him. I thank him for his support," the singer added. US believes Iran has transferred short-range ballistic missiles to Russia

WASHINGTON.The United States has informed allies that it believes Iran has transferred short-range ballistic missiles to Russia for its war in Ukraine, according to two people familiar with the matter. They did not offer any details about how many weapons have been delivered or when the transfers may have occurred, but they confirmed the US intelligence finding. They spoke on condition of anonymity to discuss a matter that has not been publicly disclosed. The White House declined to confirm the weapons transfer but reiterated its concern that Iran is deepening its support of Russia. The White House has been warning Iran for months not to transfer ballistic missiles to Russia."Any transfer of Iranian ballistic missiles to Russia would represent a dramatic escalation in Iran's support for

Russia's war of aggression against Ukraine and lead to the killing of more Ukrainian civilians," National Security Council spokesman Sean Savett said in a statement. "This partnership threatens European security and illustrates how Iran's destabilizing influence reaches beyond the Middle East and around the world."The US finding comes as the Kremlin tries to repel Ukraine's surprise offensive that has led to the seizure of about 500 square miles (1,300 kilometers) of Russia's Kursk region. Meanwhile, Ukraine's president, Volodymyr Zelenskyy, is pressing allies to allow his country to use Westernsupplied missiles to strike deep inside Russia and hit sites from which Moscow launches aerial attacks. Iran, as it has with previous US intelligence findings, denied providing Russia with weapons

for its war in Ukraine."Iran considers the provision of military assistance to the parties engaged in the conflict - which leads to increased human casualties, destruction of infrastructure, and a distancing from ceasefire negotiations to be inhumane," according to a statement from Iran's mission to the United Nations. "Thus, not only does Iran abstain from engaging in such actions itself, but it also calls upon other countries to cease the supply of weapons to the sides involved in the conflict."CIA Director William Burns, who was in London on Saturday for a joint appearance with his British intelligence counterpart, warned of the growing and "troubling" defense relationship involving Russia, China, Iran and North Korea that he said threatens both Ukraine and Western allies in the Middle East.

Pak man arrested in Canada for plotting terror attack on Jews in New York

The 20-year-old Pakistani citizen. Khan aka Shahzeb Jadoon, planned a terrorist attack in New York City (NYC) around October 7, according to officials.

New York. A 20-year-old Pakistani citizen, residing in Canada, has been arrested and charged by the US for planning a terror attack targeting Jews in New York City around the October 7 anniversary of Hamas' attack on Israel.Khan, or Shahzeb Jadoon, planned a terrorist attack in New York City (NYC) around October 7 with the "goal of slaughtering, in the name of the Islamic State of Iraq and al-Sham (ISIS), as many Jewish people as possible," Attorney General Merrick Garland said in a statement on Friday.Identified as an ISIS supporter, Muhammad Shahzeb Khan was arrested on Wednesday in Ormstown town, about 60 km south of Montreal in Canada, and approximately 20 km from the US-Canada border. He also faces three charges in Canada.He was arrested in connection with a complaint filed in the Southern District of New York for attempting to provide material support and resources to ISIS.

If convicted, Khan faces a maximum sentence of 20 years in prison.

Hamas militants based in the Gaza Strip launched an unprecedented attack on Israel by land, air and sea on October 7, 2023.As per Khan's preparation in connection with the planned attack, Khan attempted to reach the US-Canada border. He used three separate cars to travel across Canada towards the US before being stopped near Ormstown. Thanks to the investigative work of the American agency, "and the quick action of our Canadian law enforcement partners, the defendant was taken into custody", said Canadian Broadcasting Corporation (CBC News) and added that Khan now faces three charges in Canada. The charges are, 'Attempting to



leave Canada to commit an offence for a terrorist group', 'Participating in the activities of a terrorist group', and 'Conspiracy to commit an offence by violating US immigration law - entering or attempting to enter the US unlawfully', it added. According to the complaint filed in New York, Khan attempted to travel from Canada to New York City, where he intended to use automatic and semiautomatic weapons to carry out a mass shooting in support of the IS at a Jewish centre in Brooklyn, New York.Khan began posting on social media and communicating with others on an encrypted messaging application about his support for the IS in or

other things, Khan distributed IS propaganda videos and literature."If we succeed with our plan, this would be the largest attack on US soil since 9/11," he said in one of the messages.Khan began communicating with two undercover law enforcement officers, the statement said, adding, during those conversations, Khan confirmed that he and a US-based IS supporter, identified only as Associate-1 in the complaint, had been planning to carry out an attack in a particular US city, identified as 'City-1.'Among other things, Khan said that he had been actively attempting to create "a real offline cell" of IS supporters to carry out a "coordinated assault" in the city using AR-style rifles to "target Israeli Jewish Chabad... scattered all around" (the city). During subsequent conversations, Khan repeatedly instructed the undercover officers to obtain AR-style assault rifles, ammunition, and other materials to carry out the attacks and identified the specific locations in the city where the attacks would take place, the

The government should form a new commission to select a new national anthem."Hossain said Bangladesh, as a neighbouring country, wants a friendly relationship with India."We have heard

MADURAI: The Madurai Bench of the Madras High Court issued notice to the state government on a public interest litigation (PIL) petition seeking compensation of Rs 20 lakh for the families of the victims of the 2021 firecracker unit blast in Virudhunagar district, based on a direction by the National Green Tribunal (NGT). A division bench of Justices R Subramanian and L Victoria Gowri was hearing the petition filed by S Vijay Andrew (31) of Virudhunagar. The petitioner submitted that lakhs of people were employed in 305 fireworks factories, under the control of district revenue officers, and 775 factories under the control of Petroleum and Explosives Safety Organisation (PESO) in the district. Hundreds of workers were killed in different cracker blast incidents in the last five years. Particularly, 27 people were killed and 26 others injured in a blast at Sree Mariyammal Fireworks Factory on February 12, 2021 in Achankulam village, Virudhunagar.Following the explosion, the central and state governments announced a solatium of Rs 5 lakh for the family of the deceased and Rs 1.5 lakh for the injured persons. Subsequently, the NGT took suo moto cognizance of the incident and formed a committee which later filed a report. Based on the report, the NGT ordered a solatium of Rs 20 lakh for the bereaved families and Rs 2 to Rs 15 lakh for the injured depending on the degree of injuries, said the petitioner.He further submitted that the state, challenging the NGT order, filed an appeal in the Supreme Court, which was dismissed by the apex court. Moreover eight out of the 27 families of the deceased are yet to receive the solatium announced by the government. This apart, all the 27 families and 26 injured are yet to receive the NGT-directed compensation as

High prices of vegetables dent household budget across Odisha's Sundargarh

ROURKELA: The price of potato may have cooled down to some extent but the prices of other vegetables have risen sharply in the last few days in Rourkela city and rest of Sundargarh district. The price of onion in the district has shot up to Rs 55 per kg. Since the district depends on Maharashtra and a few other states for onions, the rise in price of the bulb is at the source. Similarly, drumstick is selling for Rs 120 per kg and capsicum for Rs 80 per kg. Bottle gourd, pointed-gourd and carrot are priced at Rs 60 per kg while the smaller variety of teasel gourd is selling for Rs 200 per kg. The larger variety of the vegetable can be had for Rs 60 per kg. While the price of tomato has somehow moderated to Rs 40 per kg, brinjal and plantain continue to be sold at Rs 60 per kg. Even pumpkin and papaya have become costlier by Rs 10 and are being sold at Rs 30 per kg. Similarly, cow pea, cucumber and ridgegourd are available for Rs 40 per kg. Bottle gourd too has seen a rise in price and is selling for Rs 30 per piece. The price of coriander leaf has shot up to Rs 300 per kg while garlic is priced at Rs 380 per kg and ginger at Rs 360 per kg. Green chilli is comparatively affordable at Rs 100 per kg. Vegetable vendors attributed rise in price at Rourkela markets to inadequate supply from farmers in adjacent Nuagaon, Bisra, Lathika and Kuanrmunda blocks of the district. The district has set a target to grow vegetables on 35,800 hectare land during the ongoing kharif season.

Chief district agriculture officer Harihar Nayak said given the usual vegetable cultivation pattern in the district shortage in the market during and after monsoon is quite common. He said new vegetable crops would start arriving soon.

30-year-old Odisha YouTuber hosts rooster contest to bring villagers together

SAMBALPUR: In a novel initiative, a 30year-old YouTuber hosted a rooster catching contest in his native Andhari village in Kayakud gram panchayat of Jujumura block to unite locals during good and bad times.

COIMBATORE: Several districts in Tamil Nadu seem to be facing acute shortage of DPT (diphtheria, tetanus, and pertussis) vaccine as Primary Health Centres (PHCs) in these districts have run out of stock of

the vaccine that's part of the immunisation schedule of children.A senior health official in Coimbatore said, "We need 380 doses per week for Coimbatore district and we usually have a buffer stock for three months. But the situation now is at 'just sufficient' level and there is nil buffer stock in the district. The shortage is reflecting in the field, but the situation is being managed as children who suffer from cold would not be administered the vaccine until they recover. Since cold is common among children, we are able to manage the vaccine shortage. We have made a request to the state health department to give us enough vaccine doses to manage the demand.'

doctor attached to the health department in Madurai said," There is a large shortage of DPT vaccine in almost all PHCs in Madurai district. The second booster dose for children in the age group of 5-6 years is unavailable in every PHC in Madurai for the past one month. Officials have promised to send us vaccine stocks in the next few weeks," he said. Speaking to this daily, Health Minister Ma Subramanian said that he would look into the issue and



would ask the Director of Public Health and Preventive Medicine about the demand and availability of the vaccine. "We are procuring the vaccine from the

central government," the minister said. Director of Public Health TS Selvavinayagam, however, said the state has sufficient vaccine stock. Recently a purported video recorded by a parent in

Selvapuram area in Coimbatore city showed him arguing with a nurse at a PHC about lack of vaccines at the

Some of the health staff that TNIE spoke to also said that there was shortage of DPT vaccines in Chengalpattu and Tambaram too. "The shortage is there for the last two months," a PHC staff

Inder the government's immunisation programme, the state health department offers free vaccines to children and pregnant mothers to protect them from various diseases including TB, Diptheria, Pertussis, Hepatitis-B, Haemophilus influenzae B, Tetanus, Polio, Measles and Rubella. The immunisation programme aims to reduce mortality and morbidity, particularly among children, due to

Vaccine Preventable Diseases (VPDs). While the vaccines are administered at PHCs in cities, they are administered through outreach programme in schools and at anganwadi centres through village health nurses in rural areas.

The gardener who prevents suicides

55-year-old Babuli Behera has saved more than 50 people from drowning after they attempted suicide by jumping into the Mahanadi river. Arabinda Panda speaks to him about his initiative

CUTTACK: While tending to plants in the Jobra park at Cuttack, Babuli Behera keeps a close watch on the Mahanadi barrage. His vigilant eyes do not miss any suspicious movement or act. When he notices a person At the age of 15, Behera saw a woman jumping jumping into the river, he just dives and there's not a single time that he has come out of the river without saving a life. The 55year-old garden supervisor of Cuttack Municipal Corporation has so far foiled over 50 such attempts. Belonging to the local fishermen community, he dropped out of school in Class VII to assist his parents in fishing. With their help, he learnt how to swim and navigate strong currents."There was no concrete barrage over Mahanadi then. There was a wooden barrage a few

metres above the present barrage. I had mastered the trick of taking the perfect dive into Mahanadi from the wooden barrage,"

from the barrage while he was fishing in the river. "I was throwing my net into the river when I saw a woman jumping into the Mahanadi. Fortunately, before she was swept away in the strong water current, I could get a hold of her and took her to the river bank," he said.

Behera earned the appreciation of many who were standing on the river bank and since then, there has been no looking back. Of the people he has saved so far, Behera said at least 15 would have been students while the



rest were women. "When we ask them why they want to end their lives, the students would blame it on exam failure. The women mostly jumped into the river due to failed affairs, marriages or domestic violence,"

said Behera who keeps a rubber tube and a plastic rope handy. He has bought them with his savings.He credits his wife Tukuni in assisting him in saving people from drowning. The couple has many times taken the survivors to hospitals and attended to them till their families arrived. Back in 2018, their son Chandan had also helped save many lives when a passenger bus skidded off the barrage and fell into the

Behera's last rescue was in the month of July when he saved an elderly woman who jumped into river Mahanadi from Jobra barrage. He fractured his left leg in the process. Prior to that, he had saved a girl from the same spot in the river.



Amar Prasad Satpathy calls for introspection as leaders quit BJD one after another

Senior BJD leader and former minister Amar Prasad

The party needs the leadership of Naveen Patnaik and a strong organisation to win elections. Anything less will not do," Satpathy said. Taking exception to remarks made by some of his party colleagues on the two Rajya Sabha MPs after they quit BJD, Satpathy said their approach was not acceptable. They are trying to create a situation which is not healthy for the party, he said."It gives a wrong signal when frontline leaders and members of Parliament leave the party. We must take the situation seriously and evaluate why this has happened. Timely corrective measures are required to plug the holes," he added. Reacting to assertion of a few BJP leaders including Rajya Sabha MP Mamata Mohanta, who resigned from the Upper House and the BJD on August 31, that many BJD leaders are in touch with the saffron party, Satpathy said he was not aware of what they

Advocate Mohini Tomar's murder sparks outrage among lawyers

Mohini Tomar has sparked widespread outrage among the legal community in Agra and surrounding districts. Lawyers

staged protests at the Agra Civil Court, demanding justice and calling for the immediate arrest and capital punishment of those responsible. Tomar, a respected advocate at the Kasganj District Court, disappeared mysteriously from the court's main gate. Her body was later found in the Rekhpur Minor canal near Rajpura village. Police retrieved the body and sent it for a post-mortem, which confirmed she was murdered before being thrown into the water,

ruling out drowning as the cause of death. Tomar's body was taken to her home in

Agra. The murder of senior advocate Madhopuri Colony, where senior judicial officials, including district judge Syed Mauz Bin Qasim, visited to pay their



In Agra, lawyers gathered at the district court, protesting and demanding swift justice. Senior Advocate Naseem Qureshi urged the government to implement the Advocate Protection Act, citing increasing attacks on lawyers in the state. He accused the authorities of failing to act against

these growing threats. The High Court Bench Establishment Struggle Committee, meeting at the Agra Bar Association auditorium, expressed deep resentment over the murder. The committee demanded the state provide Rs 50 lakh in compensation to Tomar's family. An 11-member lawyer delegation from Agra will travel to Kasganj to meet the family.

The Agra legal community held a candlelight vigil at the Martyr's Memorial, praying for Tomar and issuing an ultimatum: arrest the culprits within 48 hours and fast-track the trial with a verdict

in two months. They also called for Rs 1 crore in compensation for Tomar's family.

All eyes on Jats' resurgent politics in Haryana

AFTER 10 long years, things seem to be looking up for the Jats of Haryana. A Jat Chief Minister is a possibility in the upcoming Assembly elections. Even though the Jat community makes up just 26-28 per cent of the population, it has dominated the political and social landscape of the state because of its land-owning clout, its hold on government jobs and its sway over things that matter in the countryside. Jats were synonymous with Haryana until the BJP came to power in 2014. After winning the Assembly elections in the state for the first time on its own - without the crutch of a regional ally — the BJP installed a non-Jat Chief Minister, Manohar Lal Khattar, and began to patronise non-Jat communities such as other backward classes (OBCs), scheduled castes (SCs) and Punjabis, who had helped it win the polls. This diminished the Jat hegemony in the state civil secretariat and the channels of power that flow from it.

Before 2014, the BJP had been a junior coalition partner of a regional giant like the Indian National Lok Dal (INLD) led by Om Prakash Chautala or the Haryana Vikas Party of strongman Bansi Lal. Three Chief Ministers prior to 2014 — the Congress' Bhupinder Singh Hooda, Chautala and Bansi Lal — who together ruled for almost two decades, pursued pro-Jat policies, and the community called the shots in governance. But as the Jat community began to be seen as a beneficiary of state largesse in government jobs and contracts, there was the inevitable disenchantment among the OBCs and SCs. The BJP successfully tapped into this resentment in the run-up to the 2014 Assembly elections, winning 47 of the 90 seats. Khattar, a Punjabi from Karnal, was appointed the CM, prompting derogatory remarks from prominent Jat figures in Haryana. But few could fault the BJP for breaking free from the Jat identity politics in Haryana, and the party quickly filled a political vacuum first created in the mid-1990s by non-Jat CM Bhajan Lal, a Bishnoi.

Less than a year and a half after the 2014 state polls, the Jats led a violent agitation for reservation in government jobs in the OBC category. It was preceded by months of acrimony between non-Jat BJP MP Raj Kumar Saini and some Jat khap leaders; the former had threatened to resign from his seat if Jats were given reservation. For about 10 days, Jat youth went on the rampage, causing destruction in which 20 persons died and over 200 were injured. Houses and commercial establishments of Sainis and other non-Jats in the Rohtak-Jhajjar Jat strongholds were vandalised. A cleavage between the two caste blocs began to take shape. The Jat angst seemed to stem from its fall from an exalted position and sudden political marginalisation, leading many observers to point out that this was the community's way of getting back at the powers who had "usurped their clout"

In the 2019 Assembly polls, the saffron party fell short of a majority but managed to form the government with the help of the Jannayak Janta Party (JJP), which is led by the great-grandson of former Deputy PM Devi Lal, Dushyant Chautala. The JJP — splintered from the parent INLD — won 10 seats from its Jat stronghold, but the very act of aligning with the BJP government infuriated its Jat base. The party's vote share shrank to a mere 0.87 per cent in the recent Lok Sabha elections. The Jats have clearly hit back at the JJP for supping with the enemy.So, what's happening in this proud and once formidable community in the run-up to the state elections? Sensing that, perhaps, this is the time when it may be possible to reclaim the levers of power from non-Jats, the Jats are seeing value in unity. The polarisation between the two caste blocs that had its genesis in the 2016 Jat reservation agitation has taken root, and it will manifest itself during the elections.

India must give its African outreach a new lease of life

The India-Africa Forum Summit can be an opportunity to devise a more contemporary agenda with a view to global rebalancing and strengthening of the Global South.



AFRICA is being wooed by many nations. China has been remarkably consistent with its three-yearly summits; the ninth edition of the Forum on China-Africa Cooperation was held from September 4 to 6 in Beijing. Over the past two years, leaders of 54 African nations have been hosted by US President Joe Biden, his Russian counterpart Vladimir Putin and Italian PM Giorgia Meloni.

China's loan-giving spree has waned from \$28.4 billion in 2016 to \$1 billion in 2022 due to a slowdown in economic growth and its desire for a more sustainable development model, a shift away from direct infrastructure financing towards trade credit for regional exports, with the African Continental Free Trade Agreement offering businesses access to a larger unified African market.

African economies have benefited from China's unprecedented growth, but they must now adapt to a deceleration of export volumes, investments and loans. According to the International Monetary Fund (IMF), everypercentage point decline in China's real GDP growth rate leads to about 0.25 percentage point decline in Sub Sahara Africa's total GDP growth within a year. Despite oil prices being high since 2021, China, the US and Europe are buying less crude oil from Africa, resulting in lesser earnings and a significantly heavier debt burden — on average, about 85 per cent of the GDP. This severely impacts the ability to close the \$400-billion financing gap that, according to the African Development Bank, the continent needs to meet the Sustainable Development Goals and achieve a just energy transition, especially for the poorer countries.

As China adjusts its approach to Africa to less costly commitments, the interest of several nations, including


Russia, India, the UAE, Turkey and Brazil, has increased. What keeps the spotlight on Africa, despite the conflicts in Gaza and Ukraine, is its growing population, high concentration of critical minerals and 54 votes at the UN. Africa has emerged as one of world's fastest growing regions with an estimated \$6.7-billion spending. Africa continues to have a seat at many high tables, and countries find it advantageous to negotiate with all African nations at once. This 'diplomatic polycentricity' presents opportunities while raising several questions.AAWorld Bank figures show that Africa has not significantly moved beyond primary production, and manufacturing has declined as a percentage of the GDP in sub-Sahara Africa. Most African countries are locked in a colonialstyle trading relationship as exporters of raw materials and importers of finished goods. They may not have deepened their trading relations but have certainly broadened them which, nevertheless, carries the risk of borrowing too much with resultant defaults in payments. The IMF estimates that 25 African countries are on the verge of debt distress. Kenya's efforts to repay debt by overtaxing people backfired as massive street protests forced it to roll back its decision. Where does all this place India? Since 2008, when India substantially upgraded its traditional relations by holding the first India-Africa Forum Summit, the policy has been to help Africa help itself. The focus areas have been capacity-building, skill development, trade and investment, agriculture, energy, blue and ocean economy, infrastructure, education, health, peace and security, and cooperation in multilateral fora.SIndia is Africa's third largest trading partner with \$85 billion in trade and \$75 billion in investments. India

also provides capacity-building in line with AU priorities such as 'Educate an African Fit for the 21st Century'. The opening of the IIT-Madras' Tanzania campus and the Indian National Forensic Sciences University's Uganda campus are recent examples. India's help to bridge the digital divide in Africa with tele-education and telemedicine services is valued. During the Covid-19 pandemic, India aided Africa with medical supplies and equipment. The defence dialogue with Africa has reemphasised the Indo-Pacific continuum. The Indian Ocean littoral states of Africa are crucial to the monitoring and protection of sea lanes. The AU vision of peace and security coincides with India's vision of SAGAR (Security and Growth for All in the Region). We extend e-visa facilities to 33 African countries. Africa also stands to benefit from India's three significant multilateral initiatives: the International Solar Alliance, the Global Biofuel Alliance and the Coalition for Disaster Resilient Infrastructure. India and Africa have made effective contributions to protecting the interests of developing countries at international fora, including the Agriculture Framework Proposal and IP (intellectual property) waiver for Covid vaccines at the World Trade Organisation. India played a major role in the inclusion of African Union (AU) as a full member of G20. To provide a voice to Africa in the UN, India stands behind the AU's Ezulwini Consensus and the Sirte Declaration. India is among the biggest contributors to the United Nations Peacekeeping Force; we have 46 embassies in Africa. The twin shocks of Covid-19 and the Ukraine war have dealt a heavy blow to the African economies, which are reeling under debt distress. At the 19th CII India Africa Business Conclave held last month in New Delhi, Vice President Jagdeep Dhankhar said, "India is aligned with Africa's imperative to reduce its dependence on commodity exports and better integrate its production and trade activities into the global economy." The India-Africa growth partnership is a building block of the India-Global South partnership. The inordinate delay in holding the fourth India-Africa Forum Summit is worrisome; the previous editions were held in Delhi (2008 and 2015) and Addis Ababa, Ethiopia (2011).

in this era of geopolitical competition and realignment, leveraging the historical partnership with Africa is imperative. India should work closely with the AU regarding the India-Africa Forum Summit and build on the gains made at the G20 Summit by spelling out the agenda, especially in areas like clean technology, climate-resilient agriculture, maritime security, connectivity and the blue economy. The India-Africa summit can be an opportunity to devise a more contemporary agenda for global rebalancing and strengthening of the Global South. Indian leaders should also resume bilateral visits to the continent.

SC rap to Dhami

Blocks feudal approach to appointment



In its sharp criticism, the Supreme Court reminded the CM that we were not living in a 'feudal era' in which leaders could bypass the due process. Justice BR Gavai's remark that Dhami should have provided detailed reasoning for his decision reflects a broader concern about the transparency of executive actions,

particularly in matters involving environmental conservation. Even though the officer concerned has



since been removed from the post, the court's timely intervention shows that it takes swift action when deemed fit. The prompt action in this case underscores the need to preserve the delicate ecological balance in wildlife reserves, as also the fact that compromises with the integrity of the system, including in appointments, undermine conservation efforts.

This episode serves as a reminder to all authorities across the country that governance must remain accountable, transparent and in the service of public and environmental interests. It raises concerns about political influence over appointments critical to environmental conservation. Political leaders must remember that their decisions can have long-lasting repercussions on sensitive ecological matters. Dhami's decision to ignore the objections of experts and sideline the due process reflects a worrying trend in which political considerations take precedence over environment. In a country already grappling with ecological degradation, such decisions jeopardise

the wildlife and weaken the campaign against environmental crises.

IC 814 lays bare an uncomfortable truth

THE GREAT GAME: Web series makes us realise that we were weak, and maybe, perhaps, still are

THE problem with a web series that looks like real life is that it brings back too many memories. The problem with IC 814: Kandahar Hijack is that it makes India look weak. Infirm. Enervated. Incapacitated. The problem is that the Narendra Modi government wants to bury those dark days and nights that broke between Christmas Eve and New Year's Eve of 1999, when the Atal Bihari Vajpayee government released three terrorists in exchange for the safety of more than 300 passengers — and replace them with the fuzzy warmth and feel-good that comes with allying yourself to a strong leader who leads a strong state. The problem is that history takes no such prisoners. It was what it was. Here are some vignettes from that time. Indian negotiators looked and felt weak in Kandahar because they had little or no leverage. The Vajpayee government was blindsided with the families of passengers on the aircraft who threatened all kinds of harm if the government didn't do a deal. Omar Sheikh, the Britain-educated-and-accented terrorist — one of the three released by the Indian government — when asked by Anand Arni, an Indian intelligence official on the ground in Kandahar, what it meant to be free, let loose a string of expletives in reply. Pakistan's ISI, which was in control, changed the ground rules even during the negotiation — on December 29, the agreement was to release only Masood Azhar, but by the 30th morning the hijackers were demanding that three terrorists be released. It was what it was

The problem, sometimes, is that people look at the past in the context of the present. They are embarrassed by the fact that then External Affairs Minister Jaswant Singh flew to Kandahar in the same aircraft with the three terrorists sitting a few seats behind him, loudly abusing him. He shouldn't have gone, many say, why did he demean his position by going?

But go back into the archives of The Tribune and look



at where India was in 1999. The nuclear tests had taken place a year prior and India was still in the international doghouse — the Clinton visit was still to come in the following summer. Hardly a few months before, the Kargil conflict with Pakistan had ended. That week when the hijacked plane flew from Kathmandu to Kandahar, via Amritsar, Jaswant Singh tried to call several of his counterparts in the US, UK and elsewhere for help — but no one took his call. It was also New Year's Eve. When a troubled man from a Third World country calls you when you would be rather celebrating, all you can think of is, why can't he take care of his own problems? That is what constitutes real weakness. When no one wants to take your call, even when you're desperate.

According to then RAW chief AS Dulat, Jaswant Singh was "a lonely man" that week in Delhi. He realised that if a senior person didn't personally go to oversee the exchange, something might happen at the last minute that could endanger the lives of the passengers. The truth is that Indian negotiators looked and felt weak in Kandahar because they had little or no leverage. The plane was in hostile territory. The ISI was the master puppeteer. It held all the cards. The Netflix series forces all those Indians watching to come to terms with this uncomfortable truth. That we are not the state we believe we are. That we were weak, and maybe, perhaps, still are. The web series has touched a chord with all of us because when the lights are out and we are

confronted just with ourselves, we know what's true and what's not. We know that we are not as strong as we think we are. Some may say that 25 years is a long time and that India has moved on — they point to the hard line PM Modi has taken with regard to talks with Pakistan. Others point to the never-before surgical strikes in 2016, when the Indian armed forces crossed the LoC and successfully carried out operations against terrorists being backed by the Pakistan army.

And yet, we know, the weakness remains, within and without. In Ladakh, where the Chinese have not allowed your soldiers to patrol large parts of territory they could patrol until 2020 — notwithstanding the swipe PM Modi took against the Chinese in Singapore earlier this week. In the Jammu region, where 18 armed forces personnel have been killed by terrorists. In Sindhudurg, where a statue of Shivaji collapsed within months because the contractor used material of a bad quality. In Punjab, where the drug problem is far worse than you can imagine it to be. In Manipur, where Meitei radicals are using drones against fellow Manipuris. So much better to admit that you cannot stand up to the Chinese. At least there's honesty in that admission. They are five times larger than you, in any case. So much better to confront the issue and ask yourself, Why, pray, can't you stand up to the Chinese?

Why is China's economy five times larger than India's, even though Mao's Long March ended in Beijing about the same time (in 1949) that India became independent? The answer is not always that China is a dictatorship and India is — a self-congratulatory pat included — a democracy. There's worse. The Shivaji statue contractor has finally been arrested, but it reminds us of the old Modi slogan, Na khaaonga, na khaane doonga - I will never be corrupted, and I won't let anyone be corrupt either.

Generally, the monsoon withdrawal usually begins around September 17 and is completed by October 15. Although these dates are tentative, deviations are common. Last year, for instance, the monsoon withdrawal was delayed until September 25. This year, the system seems to be following a similar pattern, hinting at a possible extension of the season.As of September 7, India experienced an 8 per cent above average rainfall, offering much-needed respite to its However, several states have agrarian economy. Despite the overall positive outlook, monsoon distribution across the country has

surplus, which is crucial for its typically arid landscape, Manipur suffered a 30 per cent deficit, raising concerns about water scarcity and agricultural stress.India's diverse climatic conditions often lead to varied rainfall patterns, which can be classified into five major categories: Large Deficient (-99 per cent to -60 per cent), Deficient (-59 per cent to -20 per cent), Normal (-19 per cent to 19 per cent), Excess (20 per cent to 60 per cent), and Large Excess (60 per cent to 99 per cent). No state has experienced the extremes of Large Deficient or Large Excess rainfall this year.

experienced deficient rainfall. Manipur faced a significant shortfall at -30 per cent, closely



followed by Bihar at -26 per cent. Punjab and Jammu and Kashmir registered -23 per cent and -20 per cent, respectively. Similarly, Pradesh recorded deficiencies at -21 per cent and -22 per cent.Some states have normal but still below-

average rainfall. Uttar Pradesh reports a -14 per cent shortfall, with Assam at -13 per cent. Haryana and Kerala face a -10 per cent deficit.

Himachal Pradesh and Arunachal Other states, including Odisha (-12 per cent), Jharkhand (-13 per cent), West Bengal (-7 per cent), Mizoram (-11 per cent) and Meghalaya (-3 per

cent), similarly recorded belownormal rainfall levels. Delhi, on the other hand, stood at the threshold of the Excess category, recording a 19 per cent surplus in rainfall. Meanwhile, Madhya Pradesh received slightly above-average rainfall at 7 per cent.

Conversely, many states recorded abundant rainfall. Rajasthan led the pack with a notable 57 per cent excess in rainfall, followed closely by Tamil Nadu and Gujarat, both at a 51 per cent surplus. Goa experienced a 45 per cent surplus, while Ladakh recorded a 44 per cent increase. Andhra Pradesh (42 per cent), Telangana (40 per cent), Maharashtra (28 per cent), and Karnataka (23 per cent), Tripura (22 per cent) and Sikkim (21 per cent) also witnessed substantial excess rainfall.

Railways initiate process to relieve Vinesh Phogat, **Bajrang Punia: Source**

According to a source, the Northern Railway has initiated the process of accepting the resignation of wrestlers Vinesh Phogat and Bajrang Punia as they joined Congress party recently.

New Delhi. The Northern Railway has initiated the process of accepting the resignation of wrestlers Vinesh Phogat and Bajrang Punia, with both players expected to be relieved "as early as possible," railway sources said on Sunday.Both Punia and Phogat recently joined the Congress and the latter has been given a ticket to contest election from Julana assembly constituency in Haryana.

"The provision of serving three-month notice period after resigning by a railway employee will not come in the way of relieving these two players as we have decided to relax the norm in their cases," a senior railway official told PTI.

Railways sources said both the players "will be relieved possibly today or as early as possible."The Northern Railway (NR) had earlier issued show cause notices to them after they met Congress leader Rahul Gandhi to join his party. The NR had said the show cause notice was part of the service norm as they were government employees. Following the notice, both resigned from the Railways. Speculation was rife that Phogat might not be able to contest elections in view of the threemonth notice period norm. According to election rules, she needs to get officially relieved from the Railways to be eligible to contest election. Now, since Railways has initiated her resignation acceptance process, there is no be hurdle in her contesting election, a Northern Railway official said.

12 injured in jackal attack in UP's Pilibhit amid wolf terror in Bahraich

A pack of jackals attacked people in two villages in Uttar Pradesh's Pilibhit district in which at least 12 people, including seven children, were injured.

New Delhi. At least 12 people, including five children, were injured after being attacked by a pack of jackals in two villages in Uttar Pradesh's Pilibhit district. According to the locals, the jackals first attacked children in Suswar and Pansoli villages in Jahanabad area when they were playing outside their homes. When some elderly people rushed to protect the children, the wild animal also attacked them.

After the attack, all 12 people were admitted to Jahanabad's Community Health Centre (CHC), where they were receiving necessary treatment. Enraged by the attack from the jackals, the locals then kill one of them. Upon receiving an alert about the jackal attacks, a team from the local administration and forest department rushed to the spot and started an investigation into the incident.

The attack by jackals in Pilibhit came at a time when wolf attacks in neighbouring Bahraich district have killed a total of 10 people, including several children. About 36 people, including women, children and the elderly have also been injured in wolf attacks in Bahraich.

Speaking about the attacks by a pack of jackals, Pilibhit's District Forest Officer (DFO) Manish Singh said some villagers earlier claimed that the attack was done by a pack of wolves but it was later confirmed that a jackal was behind it."We are monitoring the

These jackals have become aggressive because the rains have flooded their hiding places, forcing them out. Also, it is their mating period, during which they tend to be more aggressive. We are keeping a close watch on them."Meanwhile, Pilibhit's MP Jitin Prasada also spoke to the locals about the incident over the phone.

Death Penalty For Rape-Murder For Minor Victim In West Bengal

New Delhi: A court in Siliguri, West Bengal, sentenced a Rape-Murder convict named MD Abbas, to death for his involvement in the rape and murder of a minor girl On Saturday. The heinous crime, which occurred last year, has been met with a strict judicial response. Additional District and Sessions Judge Anita Mehrotra Mathur delivered the verdict after a thorough legal process.

The tragic incident took place on August 21, 2023, when a young girl was on her way to school. She was brutally raped and murdered in an isolated area within the jurisdiction of the Matigara Police Station. Swift police action led to the arrest of MD Abbas within six hours of the crime, reflecting the urgency and seriousness with which the authorities treated the case.



Legal Proceedings

Special Public Prosecutor Bivas Chatterjee argued for the death penalty, emphasizing the severity of the crime. He highlighted that the case involved charges under three sections, including Section 302 (murder) and Section 6 of the Protection of Children from Sexual Offences (POCSO) Act, both of which carry the maximum punishment. Chatterjee presented his case as one of the "rarest of the rare" instances, leading to a prolonged oneand-a-half-hour hearing focused on securing the death penalty. Judge Anita Mehrotra Mathur's judgment came after recording testimonies from 33 witnesses and meticulously considering the prosecution's case. This sentencing coincides with ongoing national protests over another highprofile case involving the brutal rape and murder of a trainee doctor at the state-run RG Kar Medical College and Hospital in Kolkata. The case has drawn significant public and media attention. The Central Bureau of Investigation (CBI) has recently stated that the accused, Sanjay Roy, a civic volunteer, acted alone and that there was no gang rape involved, contrary to earlier

New Delhi:Exiled Bangladeshi author Taslima Nasreen is not only concerned about the recent political upheaval in uncertainty about her future in India. She claims her Indian residence permit, which expired in July, is yet to be renewed by the government."I like living in India, but it's been about a month and a half and my residence permit hasn't been renewed yet," Nasreen tells India Today's sister channel AajTak Bangla.Nasreen holds Swedish citizenship and has lived in India since 2011. She says she is "not getting any answers" from government officials regarding the

renewal of her residence permit, and is unsure of whom to contact within the Union Home Ministry for assistance. her motherland, but also faces I don't talk to anyone," she says. "I keep checking my status online but haven't received any confirmation vet. Even now the status on the website shows 'updating'. This has never happened before."Asked if the current situation in Bangladesh is getting in the way of her permit renewal, she categorically denies any connection."I have nothing to do with Bangladesh and its politics," she tells AajTak Bangla. "People think that I have connections with the government and politicians, but it's not so," she says. "Because if I don't get the permit, I will surely die, now I am in no condition to go anywhere." Nasreen claims that deposed Prime Minister Sheikh Hasina and former premier Khaleda Zia played a role in keeping her out of Bangladesh. "Both of them did not

allow me to stay in Bangladesh.

Manipur forces seize arms, ammunition amid growing tensions after fresh attack

Manipur Chief Minister N Biren Singh held an emergency meeting with MLAs from the ruling coalition and also met the Governor in the wake of the fresh violence that killed five on Saturday.

New Delhi: A massive combing operation to trace militants was underway in Manipur a day after at least five people were killed in fresh violence in Jiribam district amid drone and rocket attacks. The security agencies recovered large caches of weapons in a significant arms haul in the state, which has been on the boil since the ethnic violence began in May last year.

The seized weapons include sniper rifles,

mortars, grenades, and long-range rocket bombs, among other ammunition. Following the attack, Manipur Chief Minister N Biren Singh held an emergency meeting with ruling coalition MLAs to review the situation. Later, he also met Governor L Acharya to appraise him about the security situation in the state.

MANIPUR VIOLENCE: LATEST **DEVELOPMENTS**

Massive security measures have been put in place in Manipur after Saturday's violence killed five people. A military helicopter was deployed for patrolling and conducting aerial surveys, and a combing operation is also underway. Inspector General of Police, Intelligence, K Kabib claimed that the situation has been brought under control.Manipur Police say the Kuki militants deployed long-range rockets among the civilian population in attacks on two locations in Bishnupur district. This occurred after the militants entered the house of a person who lived alone and shot him dead in his

ongoing combing operation, a large number of sophisticated arms, ammunition, explosives, and grenades were recovered on Saturday. A total of



nine sophisticated arms, 21 different types of ammunition, 21 explosives, grenades, and a wireless set were recovered, officials said. Security forces also destroyed three bunkers of militants in Churachandpur district after insurgents launched rocket attacks in adjoining Bishnupur, killing one person and injuring six others. The bodies of three armed militants were recovered in Jiribam. There was an attempt to loot arms from Manipur

repelled the attempt. Some vehicles belonging to the miscreants were also damaged, according to officials.Manipur Police also deployed anti-drone systems in response to recent drone and rocket attacks on civilians. On Friday, people near Bishnupur and Imphal East districts turned off their lights after multiple drones were sighted. Similar drones were also used by the militants on Saturday. A group of Meitei civil society organisations, the Coordinating Committee on Manipur Integrity (COCOMI), declared an indefinite emergency in the state, citing increased Kuki aggression in the region. However, Kuki groups denied carrying out aerial bombing via drones. The apex body of the Kuki tribe has denied accusations that Kuki-Zo Village Volunteers used drones to drop bombs, claiming that their use of drones is limited to surveillance in adherence to

What to do when you have more than one boss

Sometimes, circumstances conspire to turn you into a 'shared resource' where you have to dance to the tunes of not one, but two or more bosses!

So how do you walk the tight rope and emerge victorious? Dealing with one boss can be a challenge. But imagine dealing with two bosses, neither of whom is willing to cut you some slack in view of your multiple duties. You confront conflicting deadlines, confused priorities and dual expectations. In all the chaos, it seems impossible for you to ever take a break or get a breather. But it is possible to navigate this quagmire and many have done it before with success. Anil Salvi, group head, HR, JM Financial Institutional Securities Ltd was placed in such a dilemma early on in his career. "At my first job itself, I was a shared resource between two bosses and had faced a lot of challenges as both bosses used to wonder for whom I was working more. Since I was a beginner, one of the ways that I used to adopt was to be brutally honest about my challenges with both of them and most of the times, they understood. And



there was the first lesson of the career that honesty works and it works well. Till date after 25 years of my career, that stint remains the most cherished one," he says. If your strategy is to let both your bosses remain in blissful ignorance about the other, you may be charting dangerous territory. It may not be pleasant to turn down a plum opportunity, but if it clashes with a commitment you've already made to your other boss, honesty really would be the best policy.

Being extremely organised is your bet as a shared resource. "It is the toughest position to be in since every

manager wants full attention and contribution from the individual. The best thing for the individual to do is to set the objectives and role expectations with every manager

they report to. Maintain a list of things to do h and follow up whenever required. Let the otheres managers know if there are any priorities that you are working on, which could potentially delay theirs. It is key that a constant review and discussion is done with all managers to course correct if there are any gaps in their expectations," advises Mukund Menon, director HR and communications, HR and communications, International Paper

Salvi warns against showing one boss in bad light to the other in order to gain sympathy, "Being very honest is the most critical part as that would give you credibility. Being solution-oriented would be the next thing as at the end of the day, you are responsible for yourself, so you would need to take that initiative. Third, never ever play one boss against another as remember that they are

your bosses and you never know when they would share notes and also simply, it is not a right thing to do. Fourth, when you can't find a solution pertaining to the bosses, don't be ashamed to approach them and seek their help in finding one.'

Of course, the above tips assume that all managers concerned are willing to make allowances for the employee. In some cases, bosses behave as though the other boss doesn't exist at all and all 8.5 hours of the employee are theirs to command. Menon agrees, "Most of

> the bosses are not empathetic. Everyone has their own priorities and there is competition for attention as people suffer from the 'first service syndrome'. The best thing is to let the other bosses know on a constant basis how you are managing the issues and

deliverables and build rapport and trust. It is mutual respect and honesty that brings it together. The key is to manage each person's ego. Additionally, having an informal chat will also help." A Thiru, president corporate HR, JK Organisation lays the onus of empathy at the bosses' doors, "Bosses are expected to be empathetic in such a situation. If they are not, it is their problem and not that of the shared resource as long as the shared resource does hisher best under the prevailing situation and stays tuned to the purpose (serving the external customer betterfaster) than responding (wasting time) based on organisational hierarchy."

As Salvi says, continue to work hard and smart for the bosses as you are learning twice as much, compared to others who have a single

The upcoming demerger of our diverse verticals that represent more than 15 commodities, will see us progress from being asset managers to asset owners," Agarwal said in a latest report.As the company passes hrough the transition phase, Vedanta is focusing on consolidating and strengthening its asset base to emerge as worldleader in each of its verticals, the Chairman said.

Diversified natural resources company Vedanta Ltd has filed the demerger scheme with the National Company Law Tribunal (NCLT) after receiving a nod from lenders and is hopeful of completing the process by the end of this fiscal. Vedanta has received approval from 75 per cent of secured creditors for the proposed demerger of its businesses. The demerger will help in simplifying the company's corporate structure by creating independent businesses. Moreover, it will offer global investors direct investment opportunities in pure-play companies linked to the country's impressive growth.

From FY24 onwards, the company is investing USD 1.9

billion as growth capex across its businesses. Vedanta reported a 36.5 per cent rise in consolidated net profit at Rs 3,606 crore for the quarter ended June 30, 2024, due to improved margins and robust cost reduction across all operations. Air India sees 60 per cent fall in losses at Rs 4,444 crore

NEW DELHI. Tata Group-owned Air India reported 60% fall in losses to Rs 4,444.10 crore in FY24 over the previous year, as per Tata Sons annual report for FY24. The airline had reported a loss of Rs 11,387.96 crore in FY23. The turnover grew 23.69% to Rs 38,812 crore during the reporting year as against a turnover of Rs 31,377 crore, the report statedIt said the group is consolidating its aviation presence with the merger of AirAsia India (AIX Connect) with Air India Express and the ongoing merger of Vistara with Air India. The airline also said Air India has recorded its highest consolidated annual operating revenues of Rs 51,365 crore, up 24.5% over FY23 driven by growth in capacity to 1,059 million available seat kilometres, which was 21% higher over the previous year, it said.

It saw an improvement in passenger factor to 85% against 82% 2022-23. Banks To Hire Young Graduates As Apprentices With Rs 5,000 Monthly Stipend, Check Details Here



New Delhi Banks are mulling to hire graduates under 25 years of age as apprentices in a month. The move follows a budget announcement by Finance Minister Nirmala Sitharaman, under which the government is targeting to provide internships at top-500 companies for up to 1 crore youth over the next five years.

The scheme is likely to be implemented within a month. StipendLenders will be paying a stipend of Rs 5,000 a month to such candidates who will get trained on a specialised skill set during the stint, industry lobby grouping Indian Banks Association's chief executive Sunil Mehta told news agency PTI.

Explaining the banks' role in implementing the scheme, Mehta added, "There are a lot of areas where we don't need any skilled manpower for example marketing, recoveries. We can give them training in those areas and they can create employment for themselves."

Eligibility

The candidates applying for apprentice should be a graduate between 21-25 years of age, should not be a taxpayer and must not possess a degree from top institutions like IIT or IIM, Mehta said.Mehta also hinted that such apprentices, who can be hired for up to 12 months, will also be hired in other areas like working as business correspondents to take the banking services

to the last mile. **Post-Apprentice Prospects**

Such candidates will not "vanish" after their stints at banks, Mehta said, adding that there is also a possibility of some of them getting absorbed as employees.He, however, did not share the total number of interns or apprentices that the banks will be hiring but added that all banks will be participating in the initiative.

India's power generation and transmission sectors 2.2 times by FY2030

and transmission sectors are expected to witness significant growth in the coming years, according to a recent report by Jefferies. The report projects that the power generation and transmission sectors will grow 2.2 times to \$280 billion between FY24 and FY30 compared to FY17-23. Additionally, to sustain the economy's rapid growth, power consumption is expected to increase by more than 7 per cent annually. By FY30, India's total power generation capacity will need to rise from 442 GW in FY24 to 673 GW to prevent power shortages

Thermal power plants, currently operating at around 65-70 per cent plant load factor (PLF), will play a crucial role in meeting the demand. The average annual PLF for thermal power plants is expected to exceed the peak levels observed in FY08 by FY28, with thermal utilisation rates already reaching 74 per cent in FY25 to date. However, the report also highlights



that peak power deficits are becoming more frequent due to years of underinvestment in the sector. To avoid regular power shortages, the focus will be on accelerating capacity additions and increasing investment in power

equipment.Capacity additions are expected to increase significantly, particularly in thermal power, where the annual addition rate is set to rise from the current 2-5 GW to 17 GW.Renewable energy capacity will also grow rapidly, with the annual capacity addition expected to increase 3.5 times between FY24 and FY27 compared to FY10-20. India has set a target to achieve 450 GW of renewable energy by 2030.

The power transmission sector is also poised for significant growth, with the bid pipeline increasing seven-fold over the past three years, from less than Rs 150 billion in February 2021 to Rs 1 trillion in projects currently up for bidding.

This rapid expansion will be driven by the government's focus on expanding renewable energy capacity and the growing needs for storage, green hydrogen, data centres, and electric

Edtech: Focus shifts to offline mode

BENGALURU: The edtech landscape has been witnessing a rollercoaster ride since the pandemic, which led to a surge in online edtech start-ups and funding. Covid lockdowns shifted the Online to offline centres centres. However, the trend reversed as the effects of Covid started fading. The online coaching and tuition companies stopped getting the generous funding they got used to during the pandemic, and many online start-ups that started during Covid had to shut down. Unacademy, Byju's, Teachmint, Skill-Lync and Vedantu had fired many employees. Now, these online companies have started focusing on offline centres. The fall of Byju's, valued at \$22 billion in 2022, has raised many questions including scope of online edtech and its future. Currently, Byju's has over 250 offline centres. Other edtech firms like Unacademy, Cuemath and Physics Wallah are also expanding their presence offline.

Physics Wallah operates over 120 offline centres. The edtech company, which has a presence in online, offline and hybrid modes, became a unicorn in 2022, and its revenue in FY23 stood at Rs 772 crore. Over 2 lakh students are studying in offline centres.

focus to online from offline coaching Ganesh Mahadevan, Partner, thinksyng consulting, says it is disheartening that edtech firms wasted the tailwind provided by Covid, which did all the selling for this industry by getting a large mass of relevant target segment to buy into the service and try them for a sufficiently long time. Mahadevan, who is also mentor to several start-ups, says if there are major drop-offs from customers after trials, it only points to the product not delivering. "The question to ask then is whether the product is good enough for the students to move from classroom to online," he adds.As per market intelligence firm Tracxn data, there are 7,431 offline and 16,333 online edtech companies. Till August 2024, online edtech companies raised \$223 million and offline firms raised \$21.1 million.

Since many edtech start-ups are opening offline centres, has the online modellost

its relevance? Mahadevan says moving offline doesn't seem to be a strategic decision, the business edtech firms were trying to disrupt is being given a thumbs up by moving offline.

Rather than addressing the core product-market fit problem with online education, the industry is jumping ship. For a developing country like India, online education is truly relevant with its ease of access and low-cost delivery. Abandoning this ship is doing injustice to a large mass of not so rich student community who can't afford high-cost offline education, he explains. Hybrid learning model

Somdutta Singh, founder & CEO Assiduus, and Angel Investor, says a survey by FICCI says 70% of students prefer a hybrid learning model that combines online and offline classes. This preference is echoed by broader trends. A report indicates 82% of students choose hybrid learning environments over traditional models, highlighting effectiveness of integrating both formats. Benefits of hybrid learning are manifold.

The e-vehicle evolution is messier than we thought

New Delhi The government seems to be getting cold feet about continuing its raft of incentives for electric vehicles (EVs). Does the recent statement by Union minister for Road Transport Nitin Gadkari signal a possible derailment of long term goals?

Addressing a green mobility convention in Delhi, Gadkari said subsidies for electric vehicles (EVs) may no longer be necessary for consumers. He said EVs are charged a GST of just 5% compared to 48% for gasoline vehicles. If after this, people are expecting further subsidies from the government, "then my honest opinion is now we don't need the subsidies."The minister said considering the lowering battery costs, and the increasing volume of sales, he expected price parity soon between e-vehicles and their dirtyfuel cousins. So where's the need for government intervention? The minister's school of thought seems to be growing. The Delhi government has just announced it was rolling back the waiver of road tax on electric vehicles in its new policy. The old policy had made EVs cheaper by 10%, but the new impost has now resulted in a near-standstill of sales, one business daily reported.

Currently a slew of demand incentives by the Union and state governments have allowed EVsto compete with similar diesel/petrol models. The FAME incentives for instance subsidizes EV cars by Rs 1.5 lakh and 2-wheelers by Rs 20,000 each. Despite these incentives, EVs continue to be more expensive than their fuel counterparts.India being an extremely price sensitive market, has therefore been lagging on its EV targets. Despite the lofty goal of 30% conversion to EVs by 2030, since 2018 only 5.3% of all 2-wheelers sold are EVs, while cars account for just 2%. On the other hand, globally, about 20% of all cars sold in 2023 were electric.

The plateauing of demand for EVs has forced a change of business plans for many internationa auto makers

Volvo Cars of Sweden has abandoned its EV-only target by 2030, and will now aim instead for a 90% mix of plug-in hybrids and EVs. It has cited a decrease in demand for electric cars as well as increasing tariff barriers in the US, and Europe against made-in China cars. Volvo is majorityowned by the Chinese company, Geely. This is not to say that EVs are on reverse gear. In fact, in the US, projection for 2024 show EV sales rising by 9% - from one million units last year to 1.2 million this yearBut what IS happening is the EV revolution is taking longer than we expected. As the initial consumer excitement wanes, Ford US is delaying its three-row electric SUV and the launch of its pick-up EV truck has been rescheduled to 2027. Lithium Americas announced recently that General Motors had agreed to delay an additional investment worth \$330 million in the miner until the end of the year.

GST Council to deliberate on taxation of insurance premium, report on online gaming

Sources said the Council would deliberate on the status of taxation on the sector and any change in tax rates is unlikely. Besides, the Council is likely to be apprised about the ongoing drive against fake registration, the success of the drive and action taken against such entities.

NEW DELHI: The GST Council on Monday is expected to deliberate on a host of issues, including taxation of insurance premium, GoM's suggestions on rate rationalisation, and a status report on online gaming, sources said. Sources said the fitment committee, comprising Centre and state tax officials, will present a report on GST levied on life, health and reinsurance premiums and the revenue implications. The GST Council, chaired by Finance Minister Nirmala Sitharaman and comprising state ministers, will decide on whether to reduce the tax burden on health insurance from the



current 18 per cent or exempt certain categories of individuals, like senior citizens. The deliberations will also happen with regard to the goods and services tax (GST) cut on life insurance premium. In 2023-24, the Centre and states collected Rs 8,262.94 crore through GST on health insurance premium, while Rs 1,484.36 crore was collected on account of GST on health reinsurance premium. The issue of taxation on insurance premium figured in Parliament discussions with opposition

members demanding that health and life insurance premiums be exempt from GST. Even Transport Minister Nitin Gadkari wrote to Sitharaman on the issue.Finance Minister Nirmala Sitharaman in her reply to discussion on the Finance Bill had said 75 per cent of the GST collected goes to states and opposition members should ask their state finance ministers to bring the proposal at the GST Council.West Bengal Finance Minister Chandrima Bhattacharya had raised the issue in the

on rate rationalisation last month and the matter was referred to the fitment committee for further data analysis. The GoM had opined against any tinkering of four-tier GST slab of 5, 12, 18, and 28 per cent for the time being. The panel, however, had asked the fitment committee to look into any scope for rationalisation of rates of goods and services. With regard to online gaming, Centre and state tax officers will present a "status report" before the GST Council. The report would include GST revenue collection from the online gaming sector before and after October 1, 2023. From October 1, 2023, entry-level bets placed on online gaming platforms and casinos were subject to 28 per cent GST.we bet you didn't know these crazy facts about Vietnamese foodPrior to that, many online gaming companies were not paying 28 per cent GST, arguing that there were differential tax rates for games of skill and games of chance. Sabalenka finished her Grand Slam season this year at 18-1. Her only defeat came against teenager Mirra Andreeva in the French Open. She missed the Wimbledon and Paris Olympics. After successfully defending her Australian Open title earlier this year, she also lifted the US Open at Flushing Meadows.

Rebecca Cheptegei's death exposes a tragic pattern in Kenyan athletics community

Marathoner Rebecca Cheptegei, who competed in the Paris Olympics last month, was tragically set on fire by her boyfriend this week, according to police. This incident marks the fourth horrific killing of an Olympian in Kenya in the past three years. The rising statistics on domestic violence in Kenya underscore a troubling trend, with these tragedies bringing renewed global attention to the issue.

New Delhi. The death of Ugandan Olympian Rebecca Cheptegei in Kenya has brought back painful memories for the athletics community. Cheptegei was set on fire by her boyfriend, marking the fourth female athlete in Kenya to lose her life to domestic violence in the past three years. Her loss is felt far beyond the track. Cheptegei, a 33-year-old Ugandan runner, died on Thursday in Eldoret, Kenya, after suffering burns to 80

that her boyfriend doused her in petrol and set her alight during an argument. Despite efforts to save her, Cheptegei succumbed to her injuries after four days in the hospital. Her boyfriend, who was also injured in the attack, remains under treatment, but no formal charges have been filed against him yet.Just a month before her death, Cheptegei had competed in the women's marathon at the Paris Olympics, finishing in 44th place. She had recently built a home in Kenya's high-altitude training region, an area known for producing world-class distance runners. It was here, in this renowned athletic hub, that her life came to a sudden end.

FOUR FEMALE ATHLETES MURDERED SO FAR

The story of Cheptegei's death closely mirrors the 2021 murder of Kenyan runner Agnes Tirop, one of the brightest stars in Kenya's track and field community, who was also killed in a domestic dispute. Tirop, just 25 at the time, was found stabbed to death in her home in Iten, a hub for elite runners near Eldoret. Her husband, who fled after the attack, was later arrested and charged with her murder. Tirop had recently returned from competing at the Tokyo Olympics and had set a world record in the 10-kilometer road

race just a month before her death. Her killing sent shockwaves through the athletics world and sparked widespread outrage, particularly among Kenyan athletes and the public. It also highlighted the ongoing issue of gender-based violence within the running community, an aspect often overlooked despite the pressures female athletes face. The tragedy did not stop with Tirop. Just days later, Edith Muthoni, a 200-metre and 400-metre specialist, was also murdered by her husband in a domestic dispute in Kerugoya. Violence continued to affect the athletic world. Six months later, a decomposed body of Damaris Muthee

had switched allegiance to Bahrain, was discovered in a rental house in Iten. Her boyfriend was identified as the prime suspect, with post-mortem results indicating strangulation. After Tirop's death, athletes across Kenya, both male and female, spoke out against domestic violence. Many shared their own stories of abuse, breaking the silence on an issue long shrouded in stigma. Former African steeplechase champion Ruth

Bosibori and marathon runner Joan Chelimo both revealed their experiences with violent partners, voicing their fears for their lives. Their testimonies underscored the depth of the problem and the urgent need for change. CRIME AGAINST WOMEN IN KENYA

Statistics on domestic violence in Kenya paint a grim picture. In 2022, 725 women were killed in gender-related violence, the highest number recorded since 2015, according to the United Nations Office on Drugs and Crime. Femicide Count Kenya, which tracks media-reported cases, reported that 152 women were killed in 2023, though advocates believe the actual number is likely much higher.



Explained: Why Iran's Sadegh was disqualified from Paralympics javelin final

Men's Javelin Throw F41 at the Paris Paralympics, only to be shockingly disqualified for a code violation, turning India's Navdeep Singh's silver into an unexpected gold.

New Delhi The athletics fraternity was left in shock when Iran's Beit Sadegh, who initially won the gold medal in the Men's Javelin Throw F41 at the Paris Paralympics, was stripped of his title due to disqualification. Sadegh's record-breaking effort of 47.64 meters, which seemed to have secured him the top spot, was nullified by the Paralympics regulatory committee on the grounds of a violation of the code of

This unexpcted turn of events marked a significant shift in fortunes for India's Navdeep Singh, who had finished with a silver medal. With Sadegh's disqualification, Navdeep's best attempt of 47.32 meters was upgraded to gold, a surprising yet celebrated victory for the Indian contingent.



What happened to Sadegh?

Sadegh appeared to have clinched the gold with his impressive fifth attempt of 47.64 meters, outdoing all other competitors. Navdeep Singh, whose best throw was 47.32 meters, was expected to settle for silver. Sadegh and his team were already preparing to celebrate his triumph, with his family cheering from the stands. However, the celebrations were abruptly halted when Sadegh and his team were informed of his

disqualification. The decision was made under rule 8.1 of the World Para Athletics Rules and Regulations, which pertains to the Code of Conduct and Ethics. World Para Athletics (WPA) is committed to maintaining the highest standards of integrity, ethics, and conduct in the sport of Para athletics. All participants in the sport, including athletes, coaches, officials, and administrators, have a responsibility to uphold these standards and ensure that the sport is conducted in a fair, honest, and transparent manner," WPA's statement read. What was the reason for Sadegh's disqualification?

The exact reason for Sadegh's disqualification has not been officially disclosed by the Paris Paralympics committee. However, speculation suggests that it may have been related to Sadegh flaunting a cryptic flag after his victory. The flag in all black, had Arabic texts written on it in red, which has now become a talking point amongst fans on social media. The situation remains a subject of intense discussion within the athletics community, as the reason behind the decision continues


