#### Shashi Tharoor moves SC in defamation case Sanjay Kumar

New Delhi, Sep 9: Congress MP Shashi Tharoor on Monday sought an urgent hearing in the Supreme Court on his plea against a Delhi High Court verdict refusing to quash the defamation proceedings against him on a complaint over his alleged "scorpion on Shivling" remarks targeting Prime Minister Narendra Modi. A top court bench headed by Chief Justice D Y Chandrachud, who held the court till 6 pm as against the usual 4 pm, was requested by a lawyer that the plea be heard on Tuesday or else, the Congress leader will have to appear in a Delhi court in connection with the private defamation complaint the same day. The Delhi High Court refused to quash the defamation proceedings against Tharoor on August 29. It had said prima facie, imputations like "scorpion on Shivling" against the prime minister are "despicable and deplorable". The high court had said prima facie, the remarks defamed the prime minister, the ruling Bharatiya Janata Party (BJP) as well as its office-bearers and members. The high court, which had on October 16, 2020 stayed the criminal proceedings against the Congress MP from Thiruvananthapuram in Kerala in the defamation complaint, vacated the interim order and directed the parties to appear before the trial court on Tuesday (September 10).

# Kolkata horror: Supreme Court flags missing post-mortem challan

New Delhi, Sep 9:Surprised over a missing challan of the body of the RG Kar Medical

College and Hospital rape and murder case victim when it was handed over for post-mortem, the Supreme Court on Monday asked the State of West Bengal to produce the crucial document on September 17. "See the third column on the top, the constable is supposed to carry this (form). It has been struck off. So there is no reference of this challan when the dead body is sent for examination. You need to explain, if this document is missing, then something is amiss," a Bench of CJI DY Chanddrachud, Justice JB Pardiwala and Justice Manoj Misra said after perusing the status reports submitted by the CBI and the West Bengal Government. Solicitor General Tushar Mehta, who represented the CBI, said, "In the absence of mention in the post-mortem report, the possibility of it having been created subsequently cannot be ruled out." Senior counsel Kapil Sibal, representing the West Bengal

Maharashtra BJP chief Bawankule's son's Audi hits multiple vehicles in Nagpur

Nagpur, Sep 9: A luxury car owned by Maharashtra BJP chief Chandrashekhar Bawankule's son Sanket hit several vehicles in the early hours of Monday in the Ramdaspeth area of Nagpur, following which two occupants, including the driver, were arrested, a police official said. According to the Sitabuldi police station official, the Audi car first collided with complainant Jitendra Sonkamble's car at 1 am and then with a moped, leaving two youth riding it injured. "The Audi car struck some more vehicles moving towards the Mankapur area. At T point there, the vehicle hit a Polo car. Its occupants chased the Audi and stopped it near Mankapur bridge. Three occupants, including Sanket Bawankule, fled," he said. "The car's driver, Arjun Hawre, and one more occupant, Ronit Chittamwar, were stopped by the occupants of Polo car. They were taken to the Tehsil police station, from where they were handed over for further probe to the Sitabuldi police," he said. The official said the occupants of the Audi were returning from a beer bar in Dharampeth when the incident took place, though he did not give information on whether anyone of them was drunk.



This is the third such contract signed by India in a little more than a year to strengthen energy security.

# RSS and BJP want women to stay at home, Rahul Gandhi tells Indian diaspora in US

Washington, Sep 9: Love, respect and humility are missing in Indian politics, Congress leader Rahul Gandhi said while addressing the Indian American community in Texas, where he also accused RSS and BJP of believing that women should stay at home. Gandhi was addressing the Indian American community in Texas on Sunday in Dallas during his first interaction with the Indian diaspora after becoming Leader of the Opposition in Lok Sabha this summer. During an interaction at another event, Gandhi said that the attitude of Indian men towards women needs to change. The 54-year-old said he is a supporter of women's participation in politics starting with the women's reservation bill. Gandhi said women should be supported financially if they want to start a business and they should be treated equally to men. "BJP and RSS believe that women should be restricted to a particular role. They should stay at home, they



should aspire to whatever they want to do," the Congress leader said. "RSS believes that India is one idea. We believe that India is a multiplicity of ideas," he said during his address to the Indian

should cook the food, they should not talk American community. "Very much like too much and we believe that women the United States, we believe everybody should be allowed to participate. We

believe that everybody should be allowed to dream, (and) everybody should be given space, regardless of their caste, language, religion, tradition, history," he said. "This is the fight. The fight crystallised in the election when millions of people in India clearly understood that the Prime Minister of India was attacking the Constitution of India. Because what I am saying to you is the union of states, respect to languages, respect to religions, respect to traditions, respect to caste. This is all in the Constitution," Gandhi added. Gandhi said his role was to inject values of love, respect and

humility into Indian politics. "I think what is missing in our political systems and across parties is love, respect and humility. Love to all human beings, not necessarily only people of one religion, one com-

munity, one caste, one State, or to those who speak one language," he said. "Respect to everybody who is trying to build an India, not just the most powerful, but the weakest and humility, not in others, but in oneself. I think that is how I see my own," he added. Making an indirect reference to the Lok Sabha results in which BJP failed to get a majority on its own, Gandhi said, "The people were saying BJP is attacking our tradition, attacking our language, etc. What they understood was that anybody who is attacking the Constitution of India is also attacking our religious tradition." "We saw that immediately, within minutes of the election result, nobody in India was scared of BJP, of the Prime Minister. These are huge achievements. These are huge achievements of the people of India who realised democracy, of the people of India who realised that we are not going to accept an attack on our Constitution. We're not going to accept an attack on our religion.

# LPG cylinder, petrol bottle, matchboxes found on tracks in Kanpur

Lucknow, Sep. 9: A major train accident was averted as the Bhiwani-Prayagraj Kalindi Express was brought to a screeching halt after hitting an LPG cylinder placed on the tracks here, police said on Monday, adding a bottle of petrol and matchboxes were also recovered from the site hinting at a sabotage bid. They said the incident occurred around 8.20 pm on Sunday when the train was running at a high speed. An FIR has been registered in the matter and multiple teams have been formed to probe the incident. Deputy Commissioner of Police (West) Rajesh Kumar Singh said the Uttar Pradesh Anti Terrorist Squad (ATS) has launched an investigation separately. "An attempt was made to derail the Kalindi Express by placing the LPG cylinder on the tracks. Soon after receiving information about the incident around 8.20 pm on Sunday, senior officials rushed to the site and launched an investigation," police said. A forensics

#### Kharge attacks Modi for 'abject failure' in ending Manipur violence

New Delhi, Sep 9: Congress chief Mallikarjun Kharge attacked Manipur chief minister N Biren Singh saying he has set a record in "shamelessly brazening out his rank incompetence" Opposition Congress chief Mallikarjun Kharge on Monday attacked Prime Minister Narendra Modi for "abject failure" in ending ethnic vio-

lence in Manipur, calling it unforgivable. "People Manipur are asking, why doesn't Modi ji want to end violence in the state?" he asked on X The violence, which was triggered in May last year, has escalated with the use of drones and rockets in attacks over the last week. A former



soldier was killed after he accidentally crossed the "buffer zone' between the Meitei and Kuki areas late on Sunday night. Kharge said former governor Anusuiya Uikey echoed Manipur's people when she said they were upset and sad and wanted Modi to visit them. He said Modi has not spent a single second in Manipur over the past 16 months even as violence continues unabated in the state and people suffer the consequences of the "complicity" of the prime minister and Union home minister Amit Shah. Kharge attacked Manipur chief minister N Biren Singh saying he has set a record in "shamelessly brazening out his rank incompetence" and reportedly demanded the transfer of the Unified Command to the state government to oversee security operations. Kharge noted a team of Union home ministry officials, the state security adviser, and the army were handling the command.



# Train hits LPG cylinder on rail tracks in Kanpur, cops hint at sabotage

Kanpur. A passenger train hit an LPG cylinder placed on a stretch of railway tracks in Uttar Pradesh's Kanpur district on Sunday, police said. No passenger was hurt in the incident.

According to the police, the incident happened when Kalindi Express, travelling from Prayagraj to Bhiwani in Haryana, was passing through Kanpur's Shivrajpur area.

The locomotive pilot spotted an LPG cylinder and other suspicious items on the tracks, after which he applied brakes, but even after that, the train hit the cylinder before coming to a halt. After the incident, senior police officials of the Kanpur Police and Anti-Terrorism Squad (ATS) arrived at the spot and recovered the LPG cylinder along with a bottle of petrol, explosives and matchboxes.

The train was stationed at the incident site for about 20 minutes. It was again stopped at Kanpur's Bilhaur station for an investigation, the police said. An FIR was registered by the Kanpur Police in connection with the incident and at least two people were also detained for questioning.

The Kanpur Police has also constituted five teams to investigate the case. Additional Commissioner of Police of Kanpur Harish Chander said, "Railway authorities informed the police that a train, travelling from Prayagraj to Bhiwani, hit a gas cylinder. Senior officials and a forensics team are present at the spot. The police have recovered a damaged cylinder and other objectionable items. We are probing the incident and strict action will be taken against the accused after that."

Last month, 22 coaches of the Sabarmati Express, en route from Varanasi to Sabarmati, derailed in Kanpur, triggering panic among passengers.

# Diwali air fares up to 3 times higher than usual

Ahmedabad. Those booking air tickets for vacations in the Diwali holidays are having to cough up between 38% and 212% higher

For major cities such as Delhi, Hyderabad, Bengaluru, Chennai or Kolkata, you could pay between 20% and 102% higher.

With demand high, airfares for the holidays have spiked. A return flight to Chandigarh, which usually costs around Rs 10,500, is priced at Rs 32,835 on the peak Diwali holiday dates, Oct 29 to Nov 4. The situation is similar for flights to Kochi, Bagdogra and Dehradun, where connectivity is relatively

"With fewer direct flights to destinations such as Kochi, Dehradun, Chandigarh and Bagdogra, these fares are particularly high. This is because these sectors have higher tourist footfalls in the vacation season as they're gateways to popular holiday destinations," said Virendra Shah, chairman of the Gujarat chapter of the Travel Agents' Association of India (TAAI).

'Wherever you travel, the average return fare from Ahmedabad for these dates is between Rs 12,000 and Rs 15,000 per person. Airlines tend to raise prices ahead of the Diwali holidays anticipating high demand. In many cases, travel agents also make bulk bookings for tickets to hot destinations," he added. When booked through bulk booking agents, attractive fares are available which are very much in line with normal fares. For instance, Kochi return flights are priced at Rs 10,000, Bagdogra at Rs 12,400, Dehradun at Rs 8,400, Srinagar at Rs 11,000, Goa at Rs 6,900, and so on.

#### Isro study identifies Ahmedabad's heat islands

Ahmedabad. A new study by scientists at Isro's Space Applications Centre has found significant temperature disparities within Ahmedabad, known as Intra-Urban Heat Islands (IUHI). The study employed a mobile vehicle equipped with a HOBO thermo-hygrometer to measure air temperature in various zones, including commercial areas, residential localities, near water bodies and in green spaces.

The mobile experiments by Neeru Jaiswal, Sanjib Deb, Sambit Panda Anup K Mandal, Aman Khan and C M Kishtawal of the Atmospheric and Oceanic Sciences Group at Isro-SAC demonstrated noticeable temperature variations, sometimes within a distance of less than 1km. These variations were particularly prominent in urban areas, traffic junctions, market zones, and near water bodies. A 2.5°C difference was noted within a 10km range through Ahmedabad's central region. The team measured temperature during month of May since 2019, focusing on how urban structures and green spaces contribute to heat exposure. "Areas with higher vegetation, water bodies or barren land displayed a cooling effect." the study states. Temperature dropped by 0.8°C near Ghuma, while rose by 1.5°C as the vehicle passed through Bopal market. It further adds, "The temperature at traffic junctions is higher by 1°C than in nearby areas." Areas like Vikram Nagar, Sanand and Paldi showed temperature variations due to a combination of vegetation, market activity and traffic conditions.

# 38,094 Ganesha idols immersed in Mumbai, half in artificial tanks

MUMBAL As many as 38,094 Ganesha idols were immersed in the city till 9pm on Sunday -a marginal drop from last year's 38,415 idols-as chants and the beating of drums filled the air on Day 2 of the 10-day festival. Over 49% of these idols were immersed in artificial tanks created by BMC across the city. Last year, that figure hovered at 45%.

Only 195 of the 38,094 idols were sarvajanik community ones, while 37,879 were from households and 20 were Hartalika idols. Among the 18,696 idols immersed in artificial tanks, 143 were community ones, 18,537 from households and 16 Hartalika idols. As per a BMC release, no untoward incident was reported during the immersion processions. Naresh Dahibavkar, president of Brihanmumbai Sarvajanik Ganeshotsav Samanvay Samiti, said, "Among household idols, a

majority seemed to be eco-friendly. The artificial tanks are getting a good response. There is an increasing trend towards making Ganeshotsav environmentfriendly. There has been an increase in household idols, especially among the youth, including students, and those who moved to the city for employment."

He suggested that govt provide subsidies to those making eco-friendly idols "as plaster of Paris is still attractive in terms of costs". CM Eknath Shinde had last Friday urged people to celebrate the festival in an ecofriendly way.Devotees thronged several sites, including Girgaum Chowpatty, which typically sees the most immersions in the city. Various civic services and facilities have been provided by D ward officials to devotees at Girgaum Chowpatty. According to deputy municipal commissioner Prashant

Sapkale, preparations at the site began two months ago, and 478 steel plates and 43 German rafts have been arranged at various locations to allow for immersions of small idols to prevent vehicles from getting stuck in the sand. Forty-eight motorboats with 761 lifeguards have been deployed at the site. For collection of garlands and flowers offered by devotees, 274 'Nirmalya' vehicles, along with 163 'Nirmalya Kalashas', have also been provided by the civic body.

#### **ED** files conspiracy against executive chairperson of financial firm

MUMBAI. The Enforcement Directorate (ED) on Friday filed a criminal conspiracy case against Rashmi Saluja, the executive chairperson of an investment and financial services holding company, and other executives after it was found out that the agency's investigation into a money laundering case was based on dubious information provided by her.

The case was filed after the ED discovered that a money laundering investigation they were conducting based on an FIR filed by one Vaibhav Gawali at Matunga earlier against former promoters of Religare Enterprises Ltd (REL) was non-credible and had been filed on the instructions of Saluja. The other accused mentioned in the FIR are Nitin Aggarwal and Nishant Singhal.

Ahmedabad.A man accused of defrauding people by claiming connections with high-level politicians, including the Prime Minister's Office (PMO) and Chief Minister's Office (CMO), was arrested in Haryana by the Ahmedabad Crime Branch. Bharat Chhabra, who posed as a CBI officer, was caught after a monthslong search. The arrest follows a peculiar case in which Chhabra, 40, impersonated a CBI officer at a hotel in Ahmedabad and fled without settling his bill. Gujarat police had been on the lookout for Chhabra for over a month and a half. He was arrested in Karnal, Haryana. According to the police, Chhabra also solicited Rs 2.22 lakh

from an individual to secure the release of a prisoner from jail. He claimed to have sway over matters pertaining to the CBI, Home Ministry, PMO, and even influential figures in the BJP and RSS. Promising extraordinary favours, he would even encourage people to call him at midnight to demonstrate his supposed clout. Chhabra, originally from Haryana's Karnal, is said to have used his skills to weave an intricate web of deception across

several states, including Haryana, Jammu and Kashmir, and Telangana. His reputation for political connections was so widespread in Haryana that Gujarat Police faced significant challenges in arresting him. Assistant Commissioner of Police (ACP) Bharat Patel of the Ahmedabad Crime Branch said that Chhabra, who holds a Bachelor of Computer Applications (BCA) degree, had been engaging in such fraudulent activities for the past four years."He is a frequent traveller to Ahmedabad and has multiple cases registered against him, both at the Ahmedabad Crime Branch and Adalaj Police Station," ACP Patel stated.

# It may not be smooth sail for Rao Narbir as BJP sees revolt ahead of assembly polls

**Gurgaon.** Former Haryana minister Rao Narbir Singh clinched BJP's nomination from Badshapur assembly seat in Gurgaon despite pushback against his candidature within the party, but his battle is far from over. Fighting for a second term from Badshapur, a first for the MLA, Narbir Singh won't just have to fight off an electoral contest from rivals in other parties, but also within his own. Sources told TOI that there may be resentment on the ground from the supporters of BJP's district president Kamal Yadav and former state secretary Manish Yadav, both of whom were denied tickets from the constituency. Other than that, Narbir Singh's nomination was opposed by prominent BJP faces, including Union minister former MP Sudha Yadav, they said. According to a party source, Sudha Yadav had called for disciplinary action against Narbir for allegedly criticising his own party in recent years. Narbir Singh, ahead of the announcement of assembly election schedule in Haryana, had said at an event in South City that if denied a BJP ticket, he would consider running for Congress.Narbir Singh's path to get the ticket wasn't without its hurdles. In the 2019 assembly polls, BJP fielded Manish Yadav, who lost the election, though Narbir was backed by then chief minister Manohar Lal Khattar. Since then, Narbir Singh has remained consistently active in the constituency and engaged with the electorate.

It is this engagement that also makes him a strong favourite to win the seat. He is backed by Yadavs, a key voter base in Badshapur, and leads a team with strong organisational skills to run a campaign. His influence extends to both rural and urban areas, and during his tenure as a minister in the Khattar cabinet from 2014 to 2019, he gained a reputation for addressing issues flagged by common people. Badshapur's electorate has risen 35.5% over the past five years, with the constituency of 5.1 lakh registered voters now the largest in Haryana in this count. An increased voter turnout could play a crucial role in determining the outcome of the coming election.

# Woman (23) strangled in pvt guest house, man arrested

Gurgaon. A 23-year-old woman was allegedly throttled to death by a 40-year-old man at a private guest house in Jharsa on Saturday evening following a dispute over payment. The accused, Anil Pahal, a customs broker, was arrested on Sunday for murder and rape.

According to police, the woman, originally from Uttar Pradesh, had come to the city two months ago to work as a consultant massage therapist but was also soliciting clients for sexual services online. Pahal had asked her to come over through the internet, agreeing to pay Rs 5,000. However, after the meeting,, the woman reportedly demanded an additional Rs 2,500, which led to a heated argument. Police said, "Anil transferred Rs 5,000 to a man who dropped the woman at the guest house. After the dispute over extra payment, he strangled her and fled, taking her phone and locking the door."uest house staff grew suspicious when Pahal hurriedly left, leaving the woman behind. Upon opening the room, they found her unconscious and immediately called the police. She was declared dead at the Civil Hospital in Sector 10.

"Through CCTV footage, room booking details, and call records, police were able to trace both the accused and the woman," said a Gurgaon police spokesperson.

A case was registered against the accused under BNS sections 103 (1) (murder) and 64 (rape) on Sunday

# Roads riddled with craters, no lights: Residents protest, flag safety fears

Gurgaon. Scores of residents from Sector 109, drenched in rain and holding posters, staged a protest on Sunday against DTCP and MCG for failing to address their civic grievances. Their main concern is the deteriorating condition of a 24-metre internal road that connects major residential societies like ATS Tourmaline, Chintels Serenity, Brisk Lumbini, and Sobha Villas. The 500-meter stretch, laid by developers during construction, has been in disrepair for the past four years. Deep potholes, frequent waterlogging, and the absence of street lighting have made the road unsafe, especially at night. Despite multiple complaints, residents say the developers refuse to maintain the road, and DTCP and MCG have failed to take action. The MCG, in particular, has distanced itself, claiming the road is outside its jurisdiction, despite collecting house taxes from the residents.

"While we continue to suffer with unsafe and poorly maintained roads, the authorities and developers are simply shirking their responsibility," said Gaurav Prakash, a resident of Brisk Lumbini.

Amit Vats, a resident of Chintels Serenity, added, "Despite assurances from DTP planning, there has been no meeting of all the stakeholders to address this issue. We are still waiting for the DTP to issue written directions to the developers."According to residents, the problem stems from policy loopholes regarding shared responsibility among developers, who each built portions of the road within their licensed areas. After project completion, these sections should have been handed over to the DTCP and local authorities, but this process is not properly enforced, leaving residents to deal with the consequences.NK Sharma, president of Brisk Lumbini RWA, called for immediate action: "It's been nearly a decade of suffering from poor infrastructure. We need a permanent solution, not a quick fix."Responding to the concerns, senior town planner Renuka Singh said, "We will call a meeting with stakeholders and developers to resolve the issue and ensure compliance."

# Elongated tortoise spotted in Damdama for first time

Gurgaon. An elongated tortoise was spotted in Damdama area for the first time on Sunday. The reptile, known for its yellowish-brown to olive shell adorned with black blotches, was not documented to be present in the region under Wildlife Institute of India (WII) study conducted in 2016. The species is widely distributed across northeast India, Bangladesh, Nepal, Bhutan, Thailand, Vietnam, Cambodia, Laos, and Malaysia. Specifically, it is found in the Manas-Bhutan transboundary landscape, Corbett-Rajaji-Nepal Terai landscape, and northeast Myanmar and northeast Bangladesh transboundary landscape, with an isolated presence in Odisha. However, the species, which has the scientific name Indotestudo elongata, is not abundant in any region and is listed in Appendix II of the Convention on International Trade in Endangered Species of Flora and Fauna (CITES).

Sunil Harsana, an animal enthusiast and wildlife researcher who encountered the tortoise in Damdama, along with his teammate Nitesh Kaushik, had deployed numerous cameras in and around the Asola Bhatti Wildlife sanctuary and the

project, supported by the organisation Coexistence Consortium, that requires him to analyse animal movement around Damdama. "This is an incredibly rare find. An elongated tortoise has never been observed in the region before," he said, adding that it was found in a nearby waterbody and left undisturbed in its natural habitat. The path and colony of the tortoise remains unknown.

Meanwhile, experts have emphasised the importance of connecting fragmented habitats of the species through increasing the number of community forests and participatory monitoring in the vicinity of the Aravallis for wildlife conservation.

The species, also referred to as the Sal Forest Tortoise, typically inhabits open deciduous forest patches, including Sal (Shorea Robusta) and evergreen forest habitats, dry thorn forests, and savannah grasslands.Robin Panjikar, a wildlife biologist, herpetologist, and assistant professor at Delhi University, said, "Nowadays, people are exploring new territories, leading to spotting of more rare species." The sighting comes at a time when the population of elongated tortoise is declining, he added.

# NBCC out with three-phase plan to ready 50k Supertech flats in 3 years

New Delhi. Providing a confidence boost to several thousand homebuyers, staterun NBCC has proposed a three-phase construction plan spread over three years to complete all the 50,000 apartments spanning across 17 projects of Supertech Ltd, which is being run by an insolvency professional and whose promoter is facing multiple charges including fund diversion and money laundering. The public sector construction company has sought the National Company Law Appellate Tribunal's (NCLAT) permission to enter as a project management consultant, a task it is performing at Amrapali. NBCC has estimated the cost of completing all the projects at close to Rs 9,500 crore and the receivables are pegged at Rs 16,000 crore, including Rs

14,000 crore that can be generated from unsold inventory of 10,000 apartments. The insolvency resolution professional had estimated the construction cost at Rs 6,406 crore. Tentative time period for completion of various projects shall vary from 12 to 36 months from 'Day Zero'," it has proposed. Day zero includes everything from access to land to receipt of approvals and availability of funds. Underlining the availability of funds as a key, NBCC has sought an "unencumbered designated project account", where an initial Rs 100 crore will be required. Besides, it has sought the support of local authorities and from Supertech as well as homebuyers.NBCC proposes to charge a fee of 8% on the actual cost of work and 1% marketing fees.

# Rain brings relief from humidity, max temperature drops by 5°C

Gurgaon. The city on Sunday witnessed The India Meteorological Department a rainfall measuring 21mm until 8.30 am. ### Philippines arrests pastor wanted by US for child trafficking, no extradition

World The Philippines is not currently looking to extradite a Filipino pastor wanted for child sex trafficking in the United States, President Ferdinand Marcos said Monday after the suspect's arrest.

Apollo Quiboloy, a self-proclaimed "Appointed Son of God" and ally of former president Rodrigo Duterte, surrendered in the southern city of Davao on Sunday amid a massive two-week police search of his sect's sprawling compound. The US charged the Kingdom of Jesus Christ preacher in 2021 with sex trafficking of girls and women aged 12-25 to work as personal assistants, who were allegedly required to have sex with him. For the moment, we are not looking at extradition. We are focusing on the cases filed in the Philippines," Marcos told reporters on the sidelines of a Manila conference.It is not known if the United States has formally sought the extradition of Quiboloy, aged at least 74, according to the FBI.Quiboloy, whose sect claims millions of followers, is facing charges in Manila of child abuse, sexual abuse and human trafficking.Marcos also congratulated the police for arresting the pastor.

"We will demonstrate once again to the world that our judicial system in the Philippines is active, is vibrant, and is working well," the president said.

### Israeli strikes in Syria kill 4, damage highway, claims state media

World. A series of Israeli strikes hit multiple areas in central Syria late Sunday, killing at least four people, wounding 13 and sparking fires, state media reported. Syria's state news agency SANA reported that Syrian air defenses "confronted an aggression that targeted several points in the central region,' damaging a highway in Hama province and sparking fires that firefighting teams were battling to control early Monday. At least four dead and 13 wounded people arrived at the Masyaf National Hospital in western Hamas province, SANA said, citing hospital head Faysal Haydar. It was not immediately clear if they were civilians or militants. The Syrian Observatory for Human Rights, a U.K.-based war monitor, reported that one of the strikes targeted a scientific research center in Maysaf and other sites where "Iranian militias and experts are stationed to develop weapons in Syria." Local media also reported strikes around the coastal city of Tartous.

There was no immediate comment from the Israeli military.Israel has carried out hundreds of strikes on targets inside government-controlled parts of war-torn Syria in recent years, but it rarely acknowledges or discusses the operations.

The proposed reform, which would see the election of judges

of the Supreme Court and other tribunals as well as magistrates, has sparked diplomatic tensions with the United States, prompted protests by opponents, and upset financial markets. # Marine Le Pen urges Macron to hold referendum in bid to break political deadlock

World. French far-right leader Marine Le Pen on Sunday urged President Emmanuel Macron to hold a referendum on key issues such as immigration, suggesting that giving the French a direct vote might help break the political deadlock.

Last week Macron appointed the centre-right Michel Barnier, a 73-year-old former foreign minister who acted as the European Union's Brexit negotiator, as prime minister, seeking to move forward after June-July snap elections that resulted in a hung parliament.But analysts say the country is set for a period of instability, with Barnier's hold on power seen as fragile and dependent on support from Le Pen's eurosceptic, anti-immigration National Rally (RN) party, which is the largest party in the new National Assembly.A left-wing coalition, which emerged as France's largest political bloc after the elections, although short of an overall majority, is also piling pressure on Barnier.

ore than 100,000 left-wing demonstrators rallied across France on Saturday to protest against his nomination and denounce Macron's "power grab". Le Pen, who leads RN lawmakers in parliament, has

said her party would not be part of the new cabinet. 'POWER TO DECIDE DIRECTLY'

On Sunday, she urged Macron to conduct a referendum on key issues such as immigration, health care and security to give the people a direct vote. The RN "will unreservedly support any approach aimed at giving people the power to decide directly", Le Pen said, speaking in the northern town of Henin-Beaumont, the far-right's traditional stronghold.

"Emmanuel Macron himself, in the chaos he has created, has levers to keep our democracy live," she added. To prevent the RN from having an absolute majority and forming a government, around 200 candidates stood down ahead of the final round of the snap legislative polls in July, sparking the far-right's outrage.

Le Pen also indicated she would watch Barnier's every move."If, in the coming weeks, the French are once again forgotten or mistreated, we will not hesitate to censure the government," she added.

The news of this heinous crime committed on a young trainee doctor while on duty numbed and shocked each of us at the sheer ruthlessness, brutality and disregard of human life," said Dipti Jain, an organiser of the global protests. Ms Jain, now a British citizen and alumni of the Calcutta National Medical College and Hospital, had last month organised a female doctors protest in the UK. #### Scandals that hit Kerala's power corridors

THIRUVANANTHAPURAM. Kerala politics had its first accidental brush with a sex scandal about six decades ago when a senior politician met with a minor accident. Not only did it cost him his position within the party and the government but also led to the formation of a regional party that eventually altered the course of state

politics. The MeToo storm that has hit the Malayalam film industry has rekindled memories of sex scandals rocking the political milieu, which saw stalwarts losing their ministerial berths.

A regional political party in the state was born because of a sex scandal that shook the R Sankar ministry in 1964. If not for the ouster of 49-year-old Congress stalwart P T Chacko from the ministry, and his subsequent death due to a heart attack, Kerala Congress would not have come into existence. Interestingly, Chacko had to step down as home, revenue and law minister as he was seen travelling with a woman Congress leader, Padmam S Menon, in his car. Kerala has since then seen a slew of political sex scandals that have also tickled the conservative minds of society.

At least a few politicians were guarded in their approach when controversies raged in the aftermath of the Justice Hema Committee report's release in August.

# CPM unhappy with ADGP row, but won't disown CM Pinarayi Vijayan

The stance of the party was spelt out by CPM state secretary MV Govindan, who termed UDF's attempts to drag the CM into the controversy as "absurd".

THIRUVANANTHAPURAM. Wary of the political damage ADGP M R Ajith Kumar's meeting with the RSS leadership would cause, the CPM has distanced itself from the episode, calling it an issue that does not concern the party but the government. However, the CPM made it clear that it would resist attempts by the Opposition UDF to derive political mileage by alleging that the meeting was held at the behest of Chief Minister Pinarayi Vijayan to scuttle the Thrissur Pooram and give BJP the advantage.

The stance of the party was spelt out by CPM state secretary M V Govindan, who termed UDF's attempts to drag the CM into the controversy as "absurd". Speaking to reporters in Kasaragod on Sunday, Govindan expressed, though indirectly, the party's displeasure over the controversy. "Do you think I am pleased?" he shot back when reporters asked him about the LDF ally CPI's displeasure over the senior police officer's meeting with the RSS functionaries."Who someone meets is not our concern. The attempt to link this with the CPM is baseless. Everyone knows where the CPM stands on the matter," said Govindan. The CPM leader said the RSS



was an organisation that was responsible for the deaths of hundreds of CPM members, underscoring the ideological opposition between the two groups.

Govindan also accused the UDF of forging ties with the BJP and pointed out that the UDF votes had drifted to the BJP in Thrissur during the Lok Sabha elections. He also criticised the practice of exaggerating minor incidents, using the phrase "turning a goat into a dog" to describe the Opposition's tactics.

Meanwhile, the home department feels there is nothing unusual in ADGP's personal meetings with RSS leaders.

However, considering the sentiments within the CPM, the government is weighing its options on the next possible course of action, including moving the ADGP out of his current position. The government is also likely to come out with an explanation on the whole controversy surrounding Ajith Kumar.

# **CBI** arrests **CGST** official seeking Rs 60L bribe after dramatic chase

MUMBAI. A central GST (CGST) superintendent, accused of detaining a businessman for 18 hours and demanding a bribe of Rs 60 lakh, was nabbed by CBI last week after a dramatic chase in the middle of the night near Oshiwara police station.

In his bid to escape, the official, Sachin Gokulka, dumped one of his aides - a consultant who had allegedly accepted the bribe on his behalf - on the road but was soon caught by the CBI team in pursuit. The consultant and a chartered accountant (CA) were also arrested, and an FIR was filed against two IRS officers - additional commissioner, CSGST, Deepak Kumar Sharma, and joint commissioner Rahul Kumar -as well as three other CGST superintendents.

CGST officials coerced bizman into arranging Rs 30L for release

Rahul Kumar, currently posted in another state but who previously worked in Mumbai, is accused of facilitating the deal by contacting Sharma. CBI has searched the premises of Sharma, the four superintendents and the other two aides.

As per a complaint, Gokulka and the other three GST superintendents - Nitin Kumar Gupta, Nikhil Agrawal and Bijender Janawa - detained a Goregaon businessman for 18 hours on Sept 4 and threatened to arrest him if he failed to pay a bribe of 60 lakh - reduced from the original demand of 80 lakh - to settle a pharmaceutical company's issue. The businessman was allegedly abused and slapped multiple times, and coerced into calling a relative to arrange 30 lakh, which was to be delivered to a middleman, chartered accountant (CA) Raj Aggarwal, through hawala

Further, he appealed to people to stay alert as there was a possibility of flash floods and more landslides. In Visakhapatnam, continuous downpours triggered landslides in Gopalapatnam, particularly near the







Under MLA Gana Babu's direction, officials have evacuated residents from the most vulnerable areas and moved them to safer locations."We have successfully evacuated all individuals from the affected areas and ensured their safety in rescue shelters. We have cut off power to all electric poles in the area to prevent further risk. We are

currently in talks with engineers to explore options for diverting the water flow and mitigating potential damage in this area. Our goal is to prevent additional harm and minimise the impact of the situation," said Gana Babu. Despite these efforts, many homes remain at risk, prompting the Greater Visakhapatnam Municipal Corporation (GVMC) to urge residents to stay alert. The area is home to several houses built along the hillside, increasing anxiety among locals.

# With 18 buses hired in a day, it's double bell for KSRTC's wedding trips

KOCHI. While private luxury buses are often hired for marriage trips, the growing popularity of the Budget Tourism Cell initiative of the Kerala State Road Transport Corporation (KSRTC) shows that the 'common man's vehicle' is increasingly becoming a preferred choice for wedding rides.A total of 18 KSRTC buses were hired for private marriage trips on Sunday alone, with the corporation raking in around Rs 3 lakh.

It was in Pathanamthitta that the highest number of KSRTC buses were booked on Sunday, an auspicious day for weddings. Here, nine buses, including two AC lowfloor buses, became a part of the most memorable moment of the lives of newlywed couples.

This was closely followed by Alappuzha, where seven buses with floral decorations were hired by private parties for the grand celebration. One bus each was hired in Kollam (Pathanapuram depot) and Thiruvananthapuram (Attingal depot) districts, also on Sunday."My wish came



true today. I've rented out two Fast Passenger buses for the wedding of my son Ananthu, who married Athirambuzha native Sajjaana. The buses becoming part of my son's marriage lent an altogether different experience. The crew was very co-operative," said a beaming Uthayappan

(59), a native of Cherthala.

'I was a regular user of KSRTC buses. Also, I worked in a PSU until my retirement and wanted to hire the buses of the public entity. My only concern was whether the buses would come on time," he said with a laugh. "And they did! The floral arrangements were simple. Also, they washed the buses which were neat and clean," said Uthayappan, who retired as an employee of Autokast Ltd, Cherthala.

While the Fast Passenger buses, with green and yellow paint, are the most hired ones, the AC buses too fit the bill.

"Two out of the five buses hired from Pathanamthitta depot were AC low-floor buses. Three buses also operated the wedding trips from Adoor. In Alappuzha district, three buses operated from Mavelikkara, two from Harippad and two from Cherthala," said a senior BTC official. "The demand is mostly in the central parts. A total of 22 wedding trips were operated from April 21 to September 1," the official said.

HYDERABAD. In a significant development, Justice B Vijaysen Reddy of the Telangana High Court has directed the Secretary of the Telangana legislative assembly to present three pending writ petitions before the Speaker, seeking the disqualification of MLAs who defected from the Bharat Rashtra Samithi (BRS) to the Congress. The directive includes fixing a schedule for filing of pleadings, submission of documents, and personal hearings in the matter.

The High Court instructed the Secretary to submit a status report regarding the Speaker's schedule to the Judicial Registry within four weeks. Justice Reddy also made it clear that if the Speaker failed to act and schedule hearings on the disqualification petitions, the court would reopen the cases and issue further orders.

Among the three petitions, one petition was filed by Aleti Maheshwar Reddy, a BJP MLA from Nirmal. He urged the court to direct the Speaker to disqualify Khairatabad MLA Danam Nagender, who defected from the BRS to join the Congress and contested in the recent Lok Sabha elections. Maheshwar Reddy claimed that his efforts to submit the petition to the Speaker's office on July 1, 2024, were thwarted as he was denied an acknowledgement by the staff.

The second petition was filed by Huzurabad MLA Padi Kaushik Reddy seeking the disqualification of Danam Nagender. The third petition was filed by Kuna Pandu Vivekananda, seeking the disqualification of Bhadradri Kothagudem MLA Venkata Rao Tellam and Ghanpur (SC Reserved) MLA Kadiyam Srihari, who defected to the Congress from the BRS.

# GOOD SPORT: Para-athletes, champions all

In a cruel world that emphasises limitations, the greatest service a para-athlete performs for society is to normalise physical disability to bring it right under the public eye, and then perform sporting acts of such skill and courage that even 'normal' people can't emulate.

Several years ago, when a para-athlete was awarded the Khel Ratna, the country's highest award for sportspersons, hitherto won only by 'normal' athletes, a colleague couldn't hide his contempt: "These 'non-elite' athletes getting the top sports award - the very idea!"

Having watched para-sports over the years, this person is now a fan, for the story of each paraathlete, medal-winner or not, is fascinating and inspirational, worthy of a book.

Let's talk about, say, Sumit Antil, just one among the para-heroes. Javelin in his right hand, a spring in his steps, Antil jogs rather than sprints to the white line. With a mighty heave, he sends the spear flying. There's a hush. There's a roar. Antil looks at the giant screen flashing the distance the spear has travelled - it's over 70 metres. It's a personal best. It's good for gold. Antil turns around and slaps his right thigh - he's very unlikely to ever slap his left thigh because it's a prosthetic limb. It's due to this artificial left limb that he jogs rather than sprints; it's this artificial left limb that presents him the greatest difficulty in his dream of hitting the 80-metre mark. My left leg, which is my blocking leg, is an artificial limb. It's difficult to balance on it. There are just two nails at the base of the prosthetic that get a grip on the ground. Balancing your entire body on just two nails is very difficult," said Antil a day after winning gold at the Paris Paralympics. "After your hip has done its role while throwing, the blocking leg has to move into action. I was losing my balance a couple of times, which is why I couldn't throw even better."

"When I will be at my peak, just once in life, I want to touch the 80m mark. I want to know how it feels when the javelin crosses that distance," said Antil, 26.Antil, two Paralympics gold medals to his credit, wants to expand his horizons.Life shrinks or expands in proportion to one's courage. The courage of the para-athlete reshapes perceptions, breaks down physical and emotional barriers, and redraws the limits of possibilities. Antil has had to be very courageous - there was no other option after a motorcycle accident led to the amputation of his left leg when he was just 17. Sheetal Devi, born without arms, had to be very courageous. The archer, who hits bull's-eye using her feet, won a Paralympics medal last week. "Before, I used to live in a small village. And then I started para archery, I saw that people with disabilities could also achieve something," Sheetal, 17, wrote on social media. "There was a time when I felt incomplete and sought external validation. It took time to embrace my true self, but the moment I did, magic unfolded."Sport does create magic. But, as Anais Nin wrote, life indeed does shrink or expand in proportion to courage - and it's not just about bravery, it's more about stepping out of our comfort zone and confronting and defeating fears.

# Steppe eagles, the vanishing voyagers from Central Asia

The morning mist was rising slowly as we stepped into the ochre-coloured grasslands of Tal Chappar in Rajasthan, known as a haven for birds of prey. Staring across the open expanse, a large silhouette caught the eye. On training the...

The morning mist was rising slowly as we stepped into the ochre-coloured grasslands of Tal Chappar in Rajasthan, known as a haven for birds of prey. Staring across the open expanse, a large silhouette caught the eye. On training the binoculars, it turned out to be a Steppe eagle, the ubiquitous post-monsoon visitor across many parts of India, undertaking long and arduous migrations each year to spend the winter in the temperate climates of the Indian subcontinent, as well as Southeast Asia, Middle East and Africa. A large raptor with a wingspan of over 2 metres, the Steppe eagle (Aquila nipalensis) is a member of the 'booted eagle' family, meaning it has feathered legs. As the name suggests, grasslands or 'steppes' constitute the bird's natural habitat. While it mainly breeds and resides in Central Asian countries, including Kazakhstan, Russia and Mongolia, as temperatures drop in these regions, it undertakes an annual migration southward. Like many migratory species, it has remarkable navigational skills, using the same route year after year, guided by an array of cues like the Earth's magnetic field, position of the stars and wind patterns to traverse thousands of kilometres. There are a few unique characteristics that set the Steppe eagle apart from other eagles. It prefers to nest on the ground as opposed to the canopy, a factor of its natural habitat, and prefers to walk or 'strut' a lot, spending far lesser time soaring in the air like other birds of prey. A specialised predator of squirrels, it also hunts other small mammals like hare and reptiles, and when fresh prey is scarce, also consumes dead animals, or 'carrion'.

In terms of appearance, it can often be confused with the tawny eagle or the spotted eagle, and an easy way to distinguish it in the field is its elongated 'gape' or the end of the beak, and oval-shaped nostrils. Despite its fierce expression, it is quite approachable and relatively tame, and can adjust to a moderate level of human presence.

The Steppe eagle is not just a casual visitor. It provides important ecosystem services. As an apex predator and scavenger, it controls the rodent population and consumes carrion, preventing the spread of diseases and maintaining the health of their habitat. This natural 'clean-up' service reduces the reliance on chemical pestcontrol methods and promotes a healthy ecosystem. Their presence signifies a well-balanced environment with adequate prey availability and minimal human

However, the species faces a multitude of threats today. Rapid urbanisation, agricultural expansion, and infrastructure development are encroaching upon open grasslands and wetlands, leading to habitat loss and diminishing prey availability. Increasing use of pesticides in agricultural fields is resulting in secondary



poisoning, as they consume prey exposed to harmful chemicals. Collision with overhead powerlines and wind turbines is also emerging as a key threat. These factors have led to a rapid decline in their population. In Kazakhstan, a major breeding ground, the population has halved in just 15-20 years, while surveys in India have revealed a long-term decline of nearly 31 per cent. As the threats to these avians persist, the species has been classified as 'endangered' by the International Union for Conservation of Nature (IUCN).


Concerted efforts are needed to protect this keystone species that plays a crucial role in maintaining ecosystems across continents. Awareness campaigns highlighting the ecological importance of these raptors can encourage local communities and civil society to participate in conservation efforts. Better enforcement of regulations on pesticide use, and encouraging sustainable agricultural practices can help reduce

instances of indirect poisoning. Driving around a bend in the meandering mountain roads of Uttarakhand, the sight of branches of a pine tree struggling to bear the weight of their occupants made us bring the car to a quick halt.

About a dozen Steppe eagles crowded the canopy surrounding a carcass dumping site, far out from their usual habitats or rolling grasslands. Trying to get a clear sighting, one couldn't help but marvel at their amazing adaptability, travelling mind-boggling distances so nonchalantly, and keeping a diverse range of ecosystems healthy. Yet, it also felt as if they were clinging to the dwindling branches of survival. Their flight, a testament to the freedom of the skies, now carries the weight of a world struggling to remember that without its wild guardians, it loses more than just eagles. It is up to us to ensure that these majestic creatures continue to grace our skies for generations to come.

# Punjab bites the bullet

Unpopular' moves will test AAP govt's resolve

It is hoped that AAP wll stay the course, which is a tough one but a must to help the state make an economic turnaround. Constantly living beyond one's means is a recipe for disaster, with the CAG red-flagging a 'continuous mismatch' between receipts and expenditure. Commendably, the Congress government in neighbouring Himachal Pradesh has shown the way by insisting on financial discipline. The

sustainability of scaling down or withdrawing populist measures will be put to the test in both states.

The shop was well stocked with provisions. A beaming, handsome, 6 foot tall young boy came and stood there. In this part of India, people are generally good looking. The mountains and woods all around are a wanderer's delight.

The lad insisted that the Armymen come to his house. Another good-looking young man came out. He had long, curly brown hair. A tall man who looked in his sixties stood outside the simple house in a salwar kameez. He welcomed the officers and took them to a drawing room with plastic chairs and a centre table.A matronly woman came and sat next to the man. Another young man fetched tea, almonds, pistachios and biscuits. The tea was thick-sweet buffalo milk with just a whiff of tea leaves. In rural communities, such tea is an honour. Not much different from the customary offerings in the Colonel's native Haryana.

The young men were shy and there was a tall young girl, their sister, who went away briskly. The boys had come home from their regiments on leave. It was Eid and homecoming season. The father was strong, dignified and had little to say. Clouds of sadness remained settled on the mother's face. The father of the boys got up and went into another room, returning with a framed medal. It had a green ribbon and a bronze circular disc with the Ashokan wheel. On the mother's face, the lines of sadness and memory became deeper. The boy to whom the medal belonged had left the world.

The brave woman had five sons. She had permitted all of them to wear the olive green. One of them had

given up his life in the service of the nation. Darkness set in on the mountain slope. It was time to leave. The Captain sat quietly. The Colonel got up, saluted the parents and the patrol started walking back.Rifleman Aurangzeb was conferred the Shaurya Chakra, the third highest gallantry award, posthumously in 2018. Jai Hind!

The boards were put up mainly by local pro-Hindutva outfits such as Bhairav Sena, according to an Indian Express report." Warning: Non-Hindus/ Rohingya Muslims and hawkers are prohibited from roaming in the village and doing business. If caught anywhere in the village, punitive and legal action will be taken," the board read, as per the report.

According to locals, boards have been put up to prevent unknown individuals and unfamiliar vendors from entering, following incidents of theft in the villages.

A resident of Fata village said locals installed these signboards around 20-25 days ago after reports of outsiders being involved in thefts at temples and homes. Such signboards have been put up in villages such as Sirsi, Rampur-Nyalsu, and others.The signboards initially called for a ban on "non-Hindus," but the phrasing was later changed to "ban on outsiders" after intervention by police, according to villagers. If there is continuous abstention from work despite the facilities given, there will be likelihood of action in future," said the CJI."We want to ensure that doctors resume work. They are in a system to render service. We will provide facilities but they have to reciprocate. If doctors do not resume work, then we cannot stop the government from taking disciplinary action," he

Senior advocate Kapil Sibal, appearing for West Bengal, ensured that doctors who resume duty will not facing action. The Chief Justice noted Bengal government's submission that mass abstention of resident doctors at medical colleges in the state for 28 days had severely disrupted healthcare services. In its affidavit, the state health department said 23 people

died due to doctors' strike. Senior advocate Geeta Luthra submitted that senior doctors were on duty while the junior doctors were not and they were facing threats and bullying. The CJI said he's aware of the ground situation, but the doctors must now resume work. Junior doctors cannot say seniors are working, so they won't, he added.

The ministry noted that the national Integrated Disease Surveillance Programme (IDSP) is actively monitoring to identify any mpox clusters in the country. Points of entry such as airports have intensified health screening of incoming travellers and the laboratory network under the Indian



Council of Medical Research (ICMR) has been strengthened to test samples from suspect cases,

States should pay special attention to healthcare workers, especially those in skin and STD (sexually transmitted diseases) clinics, to know about common signs and symptoms of mpox and actions that need to be taken after diagnosis, the advisory stated. # **Council to discuss GST on RWA** maintenance charges

**NEW DELHI.** In a significant development for residents and Resident Welfare Associations (RWAs) across the country, the GST Council in its 54th meeting on September 9, is expected to deliberate on increasing the threshold limit for the Goods and Services Tax (GST) applicable on maintenance charges.

According to sources, the threshold limit may be increased to R9,000-R10,000 per month. Currently, maintenance charges paid by residents to RWAs are exempt from GST up to R7,500 per month per member. However, should the monthly charge exceed this limit, GST is levied on the entire amount, provided the aggregate turnover of the RWA reaches R20 lakh or more.

Also, the GST applicability on the transfer of development rights within the joint development agreements (JDAs) in the real estate will likely be discussed. A JDA is a legal contract that facilitates collaboration between landowners and developers to undertake construction projects on the landowner's property.In India, JDAs have become a prevalent method for real estate development across various sectors. In addition, the Council may deliberate on under-construction properties as well. The panel on real estate is reportedly in favour of reducing GST rates on underconstruction properties to enhance housing affordability.

In related news, there remains ongoing ambiguity regarding the imposition of GST on commercial transactions processed through PoS machines,QR Codes and net banking for amounts below R2,000. Sources indicate that while the GST authorities have raised tax demands on certain transactions in this category, clarity on the GST applicability is still pending In the upcoming meeting, imposition of an 18% GST rate on such transactions may be discussed. Earlier, this newspaper had reported that the council meeting will focus on proposals aimed at rationalizing the current GST structure, which imposes an 18% tax on mediclaim premiums.

According to sources, among the proposals under consideration are options to allow mediclaim firms to charge a reduced GST rate of 5% without the benefit of input tax credit (ITC) or to implement a uniform 5% GST rate specifically for B2C supplies. Another important item on the agenda will be the clarification regarding the valuation of payments for services received from related parties, particularly in light of recent cases involving Infosys. This clarification is expected to provide muchneeded guidance to businesses that engage in inter-company transactions under the GST

# Unsustainable': Adani Group warns Bangladesh over \$500 million in unpaid power dues

The Financial Times reports that Bangladesh currently owes \$500 million to Adani, a situation the company deems "unsustainable."The situation presents itself as a big challenge for Nobel laureate Muhammad Yunus's new administration, which took power last month after the removal of former Prime Minister Sheikh Hasina.It may be noted that Yunus's government has been vocal about the costly infrastructure



agreements made under Hasina's leadership, particularly the deal with Adani for coal power from the 1,600megawatt Godda plant in India.In a statement to the Financial Times, Adani Power reaffirmed its commitment to Energy crisis in Bangladesh despite the financial strain.

situation where we are meeting not just our supply commitment but also commitments to our lenders and suppliers in spite of rising receivables," the company said.

Broad praised the young seamer's technique and said that he will improve on his speed as well with time."I have been really impressed. He has been picked on attributes. His height, his bounce, getting the ball to swing back into the right-handed batter. An average of 83mph is fine in Test match cricket but he will get quicker the older he

gets. I think his run-up will evolve over time. I don't think it will stay as long as it is at the moment. The big thing for me is that his feet and hips are facing the target - he is aligned really nicely to make the batters play," Broad added.

He played a crucial role in Leicestershire's triumph in the 2023 One-Day Cup picking 17 wickets from nine matches at an average of 24.23. 
**Bobby Deol Gets Emotional About Wife** Tania, Calls Her His 'Backbone'; Says He's The 'Youngest' She Cares For
