#### I never offered cash to victim parents: WB CM

Kolkata, Sep. 10: Amid claims made by the family members of the raped and murdered junior lady doctor of the RG Kar Medical College Hospital that they were offered money by the powers that be, Chief Minister Mamata Banerjee on Monday denied such reports saying false claims were being made against her. The junior doctors had been raped and murdered on the morning of August 8 kicking up a countrywide storm which was still blowing violently over Bengal with the junior doctors' cease work protest reaching almost a month on Monday. Asking for oral evidence of such offer if any the Chief Minister on Monday said that she had never made such proposal. "I never said that money should be offered. Please show me the proof where I spoke about money. These are all false allegations, conspiracy and untrue propaganda...rather I told the parents of the victim that money can never be an alternative and that the State Government will always be by their side if need be," Banerjee said. Curiously the Chief Minister was silent about the allegations made on camera by the parents of the victim that they had indeed been approached by a senior IPS officer who had offered a packet stuffed with cash. "Not only the police seemed to be in a hurry to cremate the body of my daughter ... they also did not cooperate with us ... tried to get a signature on a blank paper ... they also did not allow us to see the body for more than three hours during which we were sitting inside the hospital," the father of the victim said.

### Junior doctors defy SC order, vow to continue strike

Kolkata, Sep 10: Doctors shout slogans during a protest demanding justice following the rape and murder of a trainee medic at a hospital in Kolkata. Reuters/File Agitating junior doctors in West Bengal on Monday evening said they would continue their 'cease work' to demand justice for the RG Kar hospital medic who was raped and murdered, despite Supreme Court directions to resume duties by 5 pm on Tuesday. Demanding the resignation of the state's health secretary and



director of health education (DHE), the striking medics said that they would also take out a rally to 'Swasthya Bhavan' - the headquarters of the health department in Salt Lake - on Tuesday noon. "Our demands are unfulfilled and justice is not meted out to the victim. We will continue our agitation as well as the 'cease work'. We want the health secretary and DHE to resign. Tomorrow noon, we will hold a rally to the Swasthya Bhavan," one of the protesting doctors told PTI after their governing body meeting here. The body of the postgraduate trainee was found with injury marks in a seminar room of state-run RG Kar Medical College and Hospital in Kolkata. She was allegedly raped and killed while on duty. The incident has triggered nationwide outrage and protests. The junior doctors have been observing 'cease work' at state-run hospitals for nearly a month now. Earlier in the day, the Supreme Court directed the striking medics to resume their duties by 5 pm on Tuesday to avoid adverse action by the state government. The court passed the direction after the West Bengal government assured it that no action, including punitive transfers, shall be taken against the protesting doctors if they resume work.

Patna, Sep 10: RJD leader Tejashwi Yadav ruled out all future alliances with Nitish Kumarled Janata Dal (United) Rashtriya Janata Dal (RJD) leader Tejashwi Yadav on Tuesday claimed that Bihar chief minister Nitish Kumar "apologised with folded hands" when he visited the former's residence. The former Bihar deputy chief minister claimed that the event unfolded in the presence of his MLAs. "Hamare ghar iab aave to haath jodkar maafi maang rahe the. He had asked for forgiveness in front of all the MLAs, they were all witnesses. How many times in the House has he apologised with folded hands, saying that he had made a mistake and that he will not join the BJP now?" ANI quoted Yadav as saying. Ruling out any future alliance with Kumar's party Janata Dal (United), Yadav said,"His oath has no value. No one trusts him, as he may change his mind anytime. Twice we took pity on him and gave him life and both times he showed his real form. This time there is no meaning." #### Tensions flare in Manipur as students clash with police

New Delhi, Sep 10: Manipur remained on the boil on Tuesday with an indefinite curfew being imposed in Imphal West and Imphal East and prohibitory orders under Section 163 (2) of the Bharatiya Nyaya Suraksha Sanhita being imposed in Thoubal. This action came a day after student protests demanding restoration of law and order in the state rocked Imphal, exposing chinks in the armour of chief minister N Biren Singh who continues to fire fight. Biren Singh, who has handed over an ambitious wish list to the Centre including the trans-



fer of the 12 member unified command control to him, is learnt to be losing support of the BJP MLAs with some having pressed upon the ruling party to consider President's Rule in the state. Biren Singh has already met the state governor twice in the past four days with no peace in sight. "Due to the developing law and order situation in the district, earlier orders of curfew relaxation stand cancelled with immediate effect from 11 am of September 10. Hence, there is total curfew in Imphal East district with immediate effect until further orders," an order issued by the district magistrate said. In a separate direction district magistrate of Imphal West said, "In supersession of all earlier orders, curfew relaxation period for September 10 is hereby lifted with effect from 11 am of today. Restriction on the movement of people outside their respective residences was lifted from September 1 last year," it said. Essential services will not fall under the purview of the curfew, the order said. Fresh clamp down follows students' plans to escalate protests demanding the removal of DGP and security advisor to Manipur government for failure to control the situation. At least seven people have been killed in the past week with rocket propelled drones in the state as Kuki insurgents have targetted Meitei dominated areas. ### 1L paid at cops' behest? Case transferred, HC told

Mumbai. Bombay high court on Monday was informed that DCP (Zone IX) has transferred to Juhu police the probe into a case where the Khar police allegedly detained two men, seized their mobile phones, and transferred Rs 1 lakh to their employer.

Justices Revati Mohite-Dere and Prithviraj Chavan took note of the affidavit of the senior inspector (SI), Khar police station, that as per the Aug 21 order, the DCP has also assigned the inquiry into the July 17 complaint by the men to ACP, Bandra division. The ACP has issued a show-cause notice to PSIs Laxman Kakade and Manisha Chougule. The SI has also seized the CCTV footage of July 16 and 17 and handed it over to the DCP

Subhojit Day (27) and Shashank Pawar (29) worked at Sparsh Liaison Services as operational executives. Day had resigned to start his own business and was serving his notice period until July 31. His employer, Indrajeet Singh, was unhappy about it. He learnt that Pawar assisted him. On July 16, around 10.45 am, Khar police called them saying there was a data theft complaint against them. At the police station, around 11 am, Chougule seized their official and personal mobile phones. Singh arrived there and claimed that Day owed him Rs 10 lakh. Kakade demanded Day's GPay pin and Singh transferred Rs 1 lakh to his partner and sister, Chanchal Singh. The transfer with a second bank account failed. However, Pawar's GPay account had a low balance. Both men were sent home without their mobile phones after 8 pm. They moved high court on Aug 7.

#### Govt yet to frame rules for amended co-op societies act

Gandhinagar. More than six months have passed since the Gujarat legislative assembly enacted the Gujarat Cooperative Societies (Amendment) Bill 2024, but govt has not yet formulated the rules governing the implementation of the act.

One of the primary rules that needs to be framed is the capping of the transfer fee when a unit of a residential society is sold. When the bill was passed in the budget session of the assembly in Feb this year, top sources in the state govt had indicated that the transfer fee is likely to be capped at Rs 50,000. The governor granted his assent to the bill in March this year.

The proposed rules for the act are currently under deliberation, but no final decision has been reached yet. The govt might consider further consultation with various stakeholders, which could require additional time. A notification can be issued only after the rules are approved," a senior government functionary said.

Among other rules, the state govt will have to decide on the "development charges" that are levied by many societies. According to highly placed sources in the state govt, a proposal to eliminate development charges altogether is being contemplated.

The state govt had declared that the intention of the legislation was to "ensure that the administration and management of co-operative societies is conducted in a better manner and the interests of the members of the society are safeguarded".

Through the amendment, govt inserted a new section in the Gujarat Co-operative Societies Act, 1961, which states "a cooperative housing society or a cooperative housing service society shall not collect transfer fee more than the transfer fee as may be prescribed".

### Man refuses money for cigarettes, killed

Ahmedabad. A 45-year-old man named Amit Parmar, who was staying below a bridge in Bapunagar, was stoned to death after he allegedly refused to give money to buy cigarettes to the accused, Pravin Jadav, who was also staying under the same bridge.

Bapunagar PI A D Gamit said that the murder took place on Sunday. The victim's parents are staying in the Bapunagar area, but the victim was staying under the bridge and was not living with his parents.

Bapunagar cops said that a complaint of murder has been registered against Jaday, who was detained late on Monday night. Jivan Parmar (61), a resident of Hardasnagar, Bapunagar, and the father of the deceased, has registered the complaint of murder.Police said Pravin came to Amit and asked for money to buy cigarettes. Amit, however, refused to give the money, which angered Pravin, and he started abusing Amit. Later, Pravin picked up a stone lying there and hit Amit on the head, causing serious injuries that led to his death. Later, Pravin left the spot but was detained late on Monday night.

THIRUVANANTHAPURAM: Aggravating the troubles for the CPM, already struggling to explain its government's deafening silence over the controversial ADGP-RSS meet, differences within the party leadership came to the fore on Monday with Speaker A N Shamseer openly justifying M R Ajith Kumar meeting parivar leaders and Finance Minister K N Balagopal terming RSS "communal". LSG Minister M B Rajesh reminded the speaker that the Sangh fountainhead was banned post-Mahatma Gandhi assassination.

'A senior police officer met an RSS leader. The RSS is a prominent organisation in the country. The officer himself has clarified that he was accompanied by a friend. There's no need to take this seriously, and I don't find anything wrong with the meeting," said Shamseer in Kozhikode, indicating that it was a personal visit and the whole controversy was unnecessary.

Shamseer's remarks came at a time when the Left leadership, including LDF convener T

## Kerala agriculture minister P Prasad scripts success in floriculture

Flower farming is being carried out on a large scale in Cherthala, Prasad's assembly constituency in this Onam.

ALAPPUZHA. The flower farming initiative of Agriculture Minister P Prasad at his rented house at Cherthala has been a huge success. The minister, aided by local residents, began harvesting the flowers, mostly marigolds, on nearly 30 cents of land at his house on Monday. Prasad said he mainly farmed marigolds of three colours. "The flowers have bloomed and the harvesting started. Many people are coming here to buy them. The same experiment last year was a success, and so it was decided to carry out farming on a larger scale. Around 3,000 orange, white and yellow marigold flowers have been cultivated, along with vegetables and arrowroot plants," Prasad said. Buyers can purchase the flowers from the minister's residence at reasonable rates during Onam. "After harvesting is over, the land will be used for vegetable farming," he said Flower farming is being carried out on a large scale in Cherthala, Prasad's assembly constituency, this Onam. A number of farmers, women's self-help groups, and farmer groups are cultivating marigold, Ceylon slitwort, Globe amaranth, and other flowers on vast swathes of land. Meanwhile, in Kanjikuzhy grama panchayat, which is a significant producer of flowers in the region, floriculture has been undertaken on more than 25 acres. ## Gurgaon, let's clean up: Garbage is everywhere and waiting for a solution isn't helping. So how about we find one

Gurgaon. Earlier this year, a new word entered our daily lives. We had seen, felt and suffered as a result of it for months, but there was now a term for it. Exigency. In June, taking cognisance of the garbage mess across the city, Haryana govt sought to take corrective measures by declaring a solid waste exigency in Gurgaon under the Disaster Management Act. It also formed a committee that was tasked with cleaning things up. The task is Herculean, in a city that needs to get back to the drawing board

to get its basic waste disposal practices right, right from collection and segregation to treatment. And get it right it must, for at stake is image and reputation. A city positioned as one of the engine rooms of India's corporate growth, a growing hub of startups and a talent magnet, and replete with upscale homes that reflect aspirations needs to see that ambition matched in the streets. A city built to look like the West can't lose itself in waste. But problems, as boardroom pep talk never fails to reiterate, also present opportunities. Though in the same civic domain, unlike broken roads and dysfunctional streetlights that are local to a particular area, the problem of garbage is a shared one because it manifests itself only when it accumulates.It's, therefore, safe to say that the most effective solution will be a shared one. The city's only landfill at Bandhwari is choked and has itself become an environmental hazard, with instructions from National Green Tribunal to remove it fully. There are crores that have already been spent to clean it, and yet around 9 lakh tonnes of garbage still lie rotting at the landfill. Many more tonnes, meanwhile, accumulate along roadsides. Much of this is unsegregated garbage from households. This is where a shared solution will help. Discipline in segregation right from the household itself can go a long way in reducing the total volume of waste that needs to be picked up by garbage collectors and taken to a landfill. Local composting facilities and a mechanism to recycle can further reduce the output of waste from a sector or a society. Unsegregated waste can neither be recycled, nor composted and ends up as trash heaps. In the way the city is structured, Gurgaon has an advantage. Almost all its residential areas have local managements in the form of AOAs or RWAs. So, it's not hard to build mechanisms to reduce garbage generated collectively by a condominium or society.

### Power supply to data centre this yr Discom starts laying cables

Noida. The Uttar Pradesh Power Transmission Corporation Limited (UPPTCL) has begun work on providing a power connection to the upcoming data centre at DLF Techpark in Sector 143. While 100 MW of power is required for the data centre, UPPTCL on Monday began laying 132 kV transmission lines, which will be completed by the end of Dec or by early Jan. For this, a gas-insulated switchgear (GIS) bay (including disconnectors, voltage and current transformers, surge arresters, bushings and cable-end boxes, and gas density monitors) will be made at the 400 kV substations at sectors 123B and 148. Power supply to the data centre will be provided from two sources from these two substations to avoid disruption in case one source is down. UPPTCL will take Rs 30 crore as supervision charges.

A total of Rs 600 crore will be spent on the power infrastructure of the project, which will include a separate substation of 132 kV for the data centre alone. The data centre is part of the upcoming Rs 3,400 crore DLF Techpark project, which is spread over 25 acres in Sector 143, of which 1.2 million square feet will include housing, an IT block, and a data centre. The IT block and data centre alone will come up in a total space of about 4 lakh square feet."We have begun laying 132 kV transmission lines for the data centre of the proposed DLF Techpark. The project worth Rs 3,400 crore is the second largest investment in UP and is personally monitored by chief minister Yogi Adityanath. With the Congress fielding Anirudh Chaudhary against his cousin and BJP candidate Shruti Choudhry, the election contest in Haryana's Tosham assembly seat has become a direct contest between two branches of former CM Bansi Lal's political family, potentially splitting loyalties among voters.

Both Anirudh and Shruti are the grandkids of Bansi Lal. So far, Bansi Lal's political lineage had helped Shruti's mother, Kiran Choudhry, retain Tosham seat in the past few terms. But, with Anirudh entering the fray, the contest in Tosham is now just not about political ideology, but familial legacy and ties. This is the second time that members of Bansi Lal's next generation are fighting elections against each other. In 1998, Shruti's father Surender Singh had defeated Anirudh's father Ranbir Singh Mahendra from Bhiwani Lok Sabha seat. At that time, Surender was contesting from Haryana Vikas Party, an outfit founded by Bansi Lal, and Ranbir was contesting on a Congress ticket. When he was alive, Bansi Lal was closer to Surrender, whom he had

declared his political heir. However, on account of Surender's death in a chopper crash in 2005, Bansi Lal had declared his granddaughter Shruti as his successor in politics. Surender's wife, Rajya Sabha MP Kiran Choudhry, had entered state politics in 2005. She had no experience in Haryana politics and had earlier served as a legislator in Delhi. In her first assembly bypoll, which was held after the demise of her husband in Tosham, she won by securing 99.37 % votes. At that time, no prominent party in the state had fielded their candidate against her as a mark of tribute to her husband, who was a minister in Bhupinder Singh Hooda govt when he died. She had also served as cabinet minister twice in the Hooda-led Congress govt. Chaudhary was given a ticket by the Congress in 2009 from Bhiwani-Mahendragarh Lok Sabha seat and she was elected. Kiran and Shruti, however, joined BJP in June this year due to differences with leader of opposition Bhupinder Singh Hooda.Mahendra had an estranged relationship with Bansi Lal and Surender. The bitterness between

Bansi Lal and Mahendra could be gauged from the fact that the latter had not even invited his father to his daughter's marriage. Even after Bansi Lal's death, a massive dispute over the former CM's property took place between Shruti and Mahendra.Mahendra had contested assembly elections on a Congress ticket in 2000, 2005, 2009, 2014 and 2019, but could win only in 2005. He had contested only from Badhra or erstwhile Mudhal Khurd assembly seats. He is now in his late 70s. Both Mahendra and Anirudh are sports administrators and have served as functionaries of the Board of Control for Cricket in India (BCCI). Mahendra was its chief from 2004 to 2005. The Tosham constituency in Bhiwani district of Haryana came into existence in 1972. Of the 12 elections in Tosham, nine have been won by a member of Bansi Lal family. In all, the family has contested 11 of these polls. Bansi Lal won thrice, Surender twice, and Kiran Chaudhary has won four times. Bansi Lal's ancestral village, Golagarh, falls in Tosham.

## Biden lied, pulled out US forces from Afghanistan against military advice: Report

World US President Joe Biden was adamant on getting out of Afghanistan, and ignored the advice of the US military, the Afghanistan government and Nato. This was revealed in a House Foreign Affairs Committee's report, which was a result of a more than two-year investigation into America's Afghanistan withdrawal in August 2021, according to a report discussed by a report on September 8. "During his decades-long tenure as a Delaware US senator, eight years as Vice President of the United States and nearly four years as president, Mr Biden has demonstrated distrust of America's military experts and advisors and has prioritised politics and his personal legacy over America's national security interests," the 350-page report revealed.

The involvement of Kamala Harris or any kind of blame has not been mentioned in the report. The sparse mention of Harris in the report led to the resignation of the senior investigator, Jerry Dunleavy, according to the New York Post. The report also added that the Biden administration constantly lied to the American people to get them to support its end to the 20-year-old war in Afghanistan, the review added.

Former US President Donald Trump's administration created and entered the Doha Agreement with the Afghan government and the Taliban regarding America's war in Afghanistan.But Biden did not pay attention to the terms of the agreement that the US would withdraw its troops from Afghanistan if its demands were heard.

### Russian 'spy whale' was not shot, died due to stick stuck in mouth: **Police**

World. A beluga whale, believed to have been trained by Russia as a "spy," was not shot, according to a police investigation. The whale, named Hvaldimir, was found dead earlier this month, but police say it died because a stick got stuck in its mouth, not from human activity.

Hvaldimir became famous in 2019 when he was found in Norwegian waters wearing a camera. He was discovered floating near Risavika, on Norway's southwest coast, on September 1st.Two animal rights groups, One Whale and Noah, had reported the whale's death, claiming he had been shot. They said there were visible bullet wounds on his body. Regina Haug, founder of One Whale, said she saw "multiple bullet wounds," and photos shared by the group appeared to show these injuries. Noah's director, Siri Martinsen, called the wounds "alarming" and suggested the whale might have been killed intentionally. However, a police autopsy found a 35cm stick lodged in the whale's mouth, which likely caused his death. Other injuries on Hvaldimir's body were minor and not serious. The police confirmed, "There was no evidence suggesting that Hvaldimir was shot."Because of these findings, police decided not to continue their investigation. A full report will be released in two weeks.

Hvaldimir first gained attention in 2019 when he was spotted in Norwegian waters wearing a harness labeled "Equipment of St Petersburg," leading to speculation that he was trained by Russia for spying.

The whale's name is a mix of the Norwegian word for whale, "hval," and Russian President Vladimir Putin's first name.

### Judge orders change of venue in University of Idaho student murder case

World An Idaho judge has ordered that the trial of Bryan Kohberger, the man accused of fatally stabbing four University of Idaho students, be moved to a different city.In an order issued on Friday, Idaho Second District Judge John C. Judge expressed concerns about Kohberger's ability to receive a fair trial at the Latah County courthouse in Moscow.He cited extensive media coverage and public statements implying the defendant's guilt, as well as logistical issues, stating that "the courthouse isn't large enough to accommodate the case, and the county sheriff's office lacks sufficient deputies to manage security." The judge did not specify the new trial location, as reported by Associated Press.Kohberger's defence team requested the change, arguing that intense emotions within the tight-knit community, combined with relentless media coverage, would make it impossible to find an impartial jury in Moscow, where the killings occurred.

Prosecutors, however, suggested that any potential bias could be addressed by selecting a larger pool of jurors and rigorously questioning them.Kohberger, a former criminal justice student at Washington State University in nearby Pullman, is charged with four counts of murder in connection with the deaths of Ethan Chapin, Xana Kernodle, Madison Mogen, and Kaylee Goncalves. The students were found murdered in a rental house near the University of Idaho campus in the early hours of 13 November 2022. Police arrested Kohberger six weeks later at his parents' home in Pennsylvania, where he was spending his winter break.

## Russia records lowest birth rate in decades, births in June dip below 100,000

Moscow Russia recorded its lowest birth rate since 1999 in the first six months of this year, according to official data published on Monday, with births in June below 100,000, marking their first monthly decline.

WHY IT'S IMPORTANT

The conjuncture of declining births and rising mortality has led to a decrease in Russia's population, posing an issue for the Kremlin as it wages a protracted war in Ukraine, which Moscow launched with a full-scale invasion in 2022. The Kremlin in July called Russia's low birth rates a disaster for the country.

#### **BYTHE NUMBERS**

According to data published by the statistics service Rosstat, 599,600 children were born in Russia in the first half of 2024, which is 16,000 fewer than in the same period in 2023 and the lowest since 1999.In June, the number of newborns fell 6%, to 98,600, which is the first time the number fell below 100,000, Russian media reported.Russia's



natural decline of population accelerated this year, with 325,100 deaths recorded

between January and June, or 49,000 more than in the corresponding period of last year.

The population decline was somewhat offset by 20.1 per cent growth in migrants in January-June, data showed. KEYQUOTES

'This is catastrophic for the future of the nation," Kremlin's spokesperson Dmitry Peskov said in July, according to Russian state news agencies.Nina Ostanina, the head of the Committee for the Protection of Families at the Duma, Russia's lower house of parliament, told the state RIA news agency that a "special demographic operation" is needed to improve the birth rate.

We must organise ourselves and conduct another special operation," Ostanina said. "Just like a special military operation - a special demographic

Moscow calls its actions in Ukraine "a special military operation," while Kyiv and its allies call it an unprovoked aggression to grab land.

World With early voting fast approaching, "Those involved in unscrupulous behaviour the rhetoric by Republican presidential nominee Donald Trump has turned more ominous with a pledge to prosecute anyone who "cheats" in the election, in the same way, he believes they did in 2020, when he falsely claimed he won and attacked those who stood by their accurate

He also told a gathering of police officers last Friday that they should "watch for the voter fraud," an apparent attempt to enlist law enforcement that would be legally dubious.Trump has contended, without providing evidence, that he lost the 2020 election only because of cheating by Democrats, election officials and other,

On Saturday, Trump promised that this year those who cheat "will be prosecuted to the fullest extent of the law" should he win in November. He said he was referencing everyone from election officials to attorneys, political staffers and donors.

will be sought out, caught, and prosecuted at levels, unfortunately, never seen before in our Country," Trump wrote in the post on his social media network Truth Social that he later also posted on X, the site once known as Twitter. The former President's warning - he prefaced it with the words "CEASE & DESIST" - is the latest increase in rhetoric that mimics that used by authoritarian leaders. "But I know that we are not going to be bullied," said Byrum, a Democrat. "We are civil servants that signed up to make

sure every qualified registered voter has the opportunity to exercise their right to vote, and we will do that."To be clear, Trump lost the 2020 election to President Joe Biden in both the Electoral College and in the popular vote, where Biden received 7 million more votes. Trump's own attorney general said there was no evidence of widespread fraud, Trump lost dozens of lawsuits challenging the results and an Associated Press investigation showed there was no level of fraud that could have tipped the election.

and audits in the battleground states where Trump contested his loss all confirmed Biden's win.Trump, who has spoken warmly of authoritarians and mused recently that "sometimes you need a strongman," has already pledged to prosecute his political adversaries if he returns to power. ## Kim Jong Un vows to increase North Korea's nuclear weapons exponentially

**World.** North Korea's leader vowed to bolster his nuclear weapons capabilities exponentially and prepare his troops for combat as he accused the US and its allies of expanding a "nuclear-based military bloc" in the region. In a speech marking the 76th founding anniversary of his country, Kim Jong Un said he'll get his nuclear force "fully ready for combat" and there's no limit to how much he'll expand his military muscle, official Korean Central News Agency reported on Tuesday."We are now perfectly carrying out the policy on building the nuclear armed forces on increasing the number of nuclear weapons by geometrical progression," Kim said, characterizing the task as a "duty and right to existence."The pledge comes as Pyongyang seeks to counter South Korea's moves to strengthen its defense partnership with the US and Japan after the three nations signed a pact on military training in July. The agreement built on a major trilateral summit hosted by President Joe Biden at Camp David in August of 2023. North Korea last month said it would deploy to frontline military units 250 new mobile launchers for ballistic missiles that can deliver nuclear

strikes on its neighbor to the south and US forces stationed there, in one of its biggest displays of its rocket prowess under Kim. It followed the missile initiative by unveiling new suicide attack drones.North Korea may be considering a nuclear test near the time of the November US presidential election to raise its profile, South Korean President Yoon Suk Yeol's national security adviser Shin Wonsik said in July, when he was serving as defense minister.In his remarks this week, Kim said North Korea "secured wonderful military strength by making important achievements.

## 'Israeli strike on tent camp in Gaza humanitarian zone kills at least 40 people': Palestinian officials

The Nasser Hospital in Khan Younis, one of three hospitals to receive casualties, said around two dozen bodies had been brought in from the strike.

DEIR AL-BALAH. An Israeli strike on a crowded tent camp housing Palestinians displaced by the war in Gaza killed at least 40 people and wounded 60 others early Tuesday, Palestinian officials said.

Israel said it targeted "significant" Hamas militants, allegations denied by the militant group. The Civil Defense, first responders operating under the Hamas-run government, said it had recovered 40 bodies from the strike in a designated humanitarian zone known as Mawasi and was still looking for people. It said entire families had been killed as they huddled in tents. An Associated Press cameraman saw three large craters at the scene, where first responders and displaced people were sifting through the sand and

rubble with garden tools and their bare hands by the light of mobile phones after the predawn strike. The Nasser Hospital in Khan Younis, one of three hospitals to receive casualties, said around two dozen bodies had been brought in from the strike. The Israeli military said it had struck Hamas militants who were operating in a command-and-control centre. It said its forces had used precise munitions, aerial surveillance and other means to avoid civilian casualties. Israel says it has tried to avoid harming civilians throughout the 11month war ignited by Hamas' Oct. 7 attack. It blames Hamas for their deaths because the militants often operate in residential areas and are known to position tunnels, rocket launchers and other infrastructure near homes, schools and mosques. Hamas released a statement denying any militants were in the area. Neither Israel nor Hamas provided evidence to substantiate their claims. The war has caused vast destruction and displaced around 90 per cent of Gaza's population of 2.3 million, often multiple times. Israeli evacuation orders, which now cover around 90 per cent of the territory, have pushed hundreds of thousands of



people into Mawasi, a sprawling line of squalid tent camps along the coast.

Aid groups have struggled to provide even basic services in Mawasi, and Israel has occasionally struck targets there despite

designating it as a humanitarian zone. Gaza's Health Ministry says over 40,000 Palestinians have been killed in Gaza since the war began. It does not differentiate between fighters and civilians in its count.Hamas-led militants killed some 1,200 people, mostly civilians, in their Oct. 7 attack. They abducted another 250 people and are still holding around 100 after

releasing most of the rest in exchange for Palestinians imprisoned by Israel during a weeklong cease-fire last November. Around a third of the remaining hostages are believed to be dead. The main U.N. agency providing aid to Palestinians said the Israeli military stopped a convoy for more than eight hours on Monday, despite coordinating with the troops.

UNRWA head Philippe Lazzarini said the staffers who were held had been trying to work on a polio vaccination campaign in northern Gaza and Gaza City.

The convoy was stopped at gunpoint just after the Wadi Gaza checkpoint with threats to detain UN staff," he wrote on the social platform X. "Heavy damage was caused by bulldozers to the UN armoured vehicles."

With humility, it also brings you face to face with your own vulnerabilities in a way you have never considered before, and with that, a new perspective on everything."The royal family has been buffeted by health concerns for much of this year, beginning with the announcement in January that the king



would receive treatment for an enlarged prostate and Kate would undergo abdominal surgery.In February, Buckingham Palace announced that Charles was receiving treatment for an undisclosed type of cancer. Six weeks later, Kate said she, too, was undergoing treatment for cancer, quieting the relentless speculation about her condition that had circulated on social media since her surgery. While the announcements triggered an outpouring of good wishes for the ailing royals, they also put the royal family under tremendous pressure. Queen Camilla and Princess Anne, the king's sister, took on additional duties to cover the seemingly endless list of public events that make up the daily routine of the House of Windsor. William also took time off to support his wife and their three young children. ## Cops shut 'suicide' case, HC finds it 'suspicious'

Mumbai. Bombay high court (HC) has sought to know from additional commissioner of police Paramjit Dahiya what action will be taken in a case that had been closed by MIDC police station, Andheri (E), stating that a 37-year-old man (37) from Kolkata died in Mumbai by suicide although his father claimed it was

"There is something more than meets the eye... This is not the way matters are investigated. Just because you saw the body hanging, you came to a conclusion it was suicide," said Justices Revati Mohite-Dere and Prithviraj Chavan. They directed Dahiya "to go through the petition and the papers of investigation and thereafter inform the court on Wednesday of the action proposed" since the accidental death report in the case was closed on Jul 12.

The man's father, Pankaj Kumar Datta (77), moved HC to direct registration of FIR. On receiving a call from MIDC police officials that his son had died by suicide, he came to Mumbai on Sept 24, 2021. He was shown the body in a prostrate position. He identified him by his clothes. He was pressured to hurriedly cremate Abhishek's

The police took Datta to the flat. He was told a fireman broke open the door as the room was locked from the inside. There was no sign of any damage. There was blood on the floor and Abhijeet's belongings were scattered. Convinced that his son was murdered and with pictures of the spot, Datta went to police on Sept 26, but they did not accept his complaint. He made several representations but in vain. His petition said in Aug 2021 Abhijeet had purchased commercial premises in Gurugram to start a business. He was to return to Kolkata but why he went to Mumbai and took premises on rent for a new job in MIDC is a mystery. Datta's advocate Chetan Damre said Abhijeet was murdered sometime between Sept 18 and 21, 2021.

## Anti-TB drug: Half the dosage works, finds study

Mumbai. Ahead of the rollout of the shortest treatment for drug-resistant TB, called BPaL, Indian doctors published a study proving that halving the dose of one of the three drugs in the six-month treatment worked just as well.

The BPaL regimen includes bedaquiline, pretomanid, and linezolid, with/without moxifloxacin (BPaLM). It's already prescribed in 40 countries with a daily dosage of antibiotic linezolid at 1,200mg. However, a three-year-long Indian clinical trial, which preceded the Indian govt's approval, found Indian patients doing well with a daily dose of 600mg.

Terming it a "revolutionary outcome", Dr Vikas Oswal, who led the Mumbai leg of the trial that began in Aug 2021, said, "Lower dosages of linezolid are also as effective as high dosage, which was 1,200mg in the global Zenix trial. The Indian study proves that 600mg to 300mg is also as effective as 1,200mg.

The study, published in 'Clinical Infectious Diseases' on Monday, provides the first look at BPaL's India trial led by ICMR's National Institute for Research in Tuberculosis in Chennai. Of the 403 patients with drugresistant TB enrolled in the trial, 352 were cured while one patient with COPD died. Eleven patients had a recurrence while 19 others had serious adverse reactions in the 12-month follow-up.

### KSEB gets two hydel projects after 14 years, adds 100 MW to grid

KOCHI. Struggling to meet the surging power demand during peak hours, the completion of two hydel projects - the 60 MW Pallivasal Extension and the 40 MW Thottiyar project- will bring relief to the KSEB. Though a small step, the completion of the projects, which were abandoned at one stage due to the withdrawal of the Chinese agency, comes as a morale booster to the state power entity. Both projects will be commissioned by Chief Minister Pinarayi Vijayan on October 19.

The Pallivasal Extension and Thottiyar project were launched in 2007 and the machinery, including the main inlet valve, turbine and generator, were imported in 2009. However, the Chinese company withdrew from the project citing various reasons, including dollar conversion issue. Left in the dark, the KSEB abandoned the project in 2012 and the machinery was dumped in temporary sheds. However, in 2019, the KSEB constituted a team of experts, who studied the drawings of the machines and started installing them. Celebrating the successful functional spinning of the generators, the KSEB says it is the biggest achievement as the team has mastered the technical knowhow for the

turbines and generators. "It is a major achievement for the KSEB as the projects were completed without support from the Original Equipment Manufacturer (OEM).

## Long wait time: Motorists demand U-turn system at Edayarpalayam Junction in Coimbatore

This



helped reduce traffic congestion and motorists breathed a sigh of

Now, motorists and residents of

Edayarpalayam have sought a similar arrangement at the junction of Thadagam-Aanaikatti Road. "The waiting time at the signal is about 140 seconds. While the red signal is fixed at about 140 seconds, the time given to cross the junction is a mere 30 seconds. Due to this, not all vehicles can cross the junction despite waiting for nearly two and a half minutes. Many vehicles have to wait for another two minutes to cross the spot," said Aakash Ravikumar, a motorist from Edayarpalayam.

Aakash suggested that officials implement the U-turn system at the junction considering the high number of vehicles at the spot.

Speaking to TNIE, Divisional Engineer of the State Highways Department (Road Safety) G Manuneethi said, "So far, we have removed 29 traffic signals across the city and replaced them with Uturn or a roundabout.

We already turned off the traffic signals, implemented a temporary roundabout at the Edayarpalayam junction and conducted a trial run for 3 days. Before we could have a full-fledged trial run, police removed the make-shift roundabout and turned on the signals citing traffic issues. Even after it was removed, we received demands from people to introduce

If we get enough support from the police department and the public, we are ready to make the required changes at the junction."

When inquired about it, S Ashok Kumar, Deputy Commissioner of Police (Traffic) told TNIE that he would immediately check the place soon and take steps to address the issue.

## 5 ring roads with dedicated bus lanes planned for seamless drive across Mumbai

MUMBAI. Five ring roads are in development as part of a metropolis interlinking project. The southernmost will incorporate the upcoming Orange Gate tunnel, which will connect Freeway with Coastal Road at Marine Drive (see graphic). Five ring roads are in development to decongest the city and improve connectivity with neighbouring regions like Thane, Palghar and Alibaug. They will be built on existing and partially-existing infrastructure, including Eastern Freeway, WEH and Coastal Road, through connecting bridges and tunnels.

The next three will connect south Mumbai with suburbs, Mumbai with Thane, and the city with Palghar-Alibaug. The fifth, the northernmost ring road, may take some time to materialize, as the Virar-Alibaug multimodal corridor is still in the planning stage. "The development of new roads and additional thoroughfares will enable



traffic to move in a circular pattern, not only within Mumbai but the surrounding Mumbai Metropolitan Region," said Sanjay Mukherjee, commissioner, MMRDA. BMC, MMRDA and MSRDC have invested over Rs 70,000 crore for the

The inter-linking project was undertaken after a study by MMRDA. 'Mumbai's ring

roads will have dedicated bus lanes'

The new roads will help alleviate traffic congestion on the city's internal roads by providing alternative circular routes," said Mukherjee. "Also, it has been very difficult to provide a dedicated bus lane on the existing roads but on the new roads that are being built there will be a dedicated bus lane and bus stops like on Coastal Road." Connecting Thane via ring roads will be a key factor in decongesting internal roads. The extension of Eastern Freeway, the construction of Thane Coastal Road, and Ghodbunder Road developments will be crucial in connecting Mumbai's north to Thane and Eastern Freeway. Transport activist TV Shenoy said the concept of ring roads is beneficial in the long term. "But there is a lack of planning for interconnectivity between road infrastructure, which will create bottlenecks," he said

## Fbd highway chase-murder a case of mistaken identity

GURGAON. Aryan, his family said, was good friends with Harshit, their landlord's son. On the night of Aug 23, the two decided on a sleepover. Around 10pm on Aug 23, Harshit, his brother Shanky, their mother and their neighbour Kriti Sharma planned to go to Vardhaman Mall and have noodles. Aryan tagged along. "They had noodles at a stall near the mall and were on their way back home in their Duster around 1.30am. On the way, a Swift started tailing the Duster, blowing the horn occasionally," said an officer at NIT police station. Shanky, who is an accused in an attempt to murder case, thought they were being chased either by cops in civvies or members of a family he had attacked earlier. "He asked his brother Harshit to step on the accelerator. As the Duster sped, the Swift kept up the chase," the officer added. The two cars took the Delhi-Agra highway via Badhkal road and continued for almost 20km. At one point, there was a barrage of bullets from the Swift. As one of them hit Aryan in the head, Harshit pulled the car over near Gadpuri toll plaza. Anil and the others, according to sources, got off the Swift and walked up to the Duster's window where Aryan was seated. They fired at him again — this time directly in the neck from close range."They took a close look at Aryan and fled, probably realising it was a mistaken identity. Plus, there were women seated behind," a police officer said. The deceased, Aryan was rushed to SSB Hospital in Faridabad, where he succumbed to his injuries on Aug 24 afternoon. Siya Nand — who once was attached to bike taxi aggregators but is currently unemployed - said his landlord Keval Krishna woke him up around 3.30am, saying Aryan had suffered a bullet injury somewhere in Palwal. They rushed to SSB Hospital at the break of dawn, when Aryan was critical. In his initial complaint, Siya Nand alleged the attackers probably planned to kill Shanky, who already had a criminal case against him for attempted murder. Based on his complaint, a case was registered under Sections 103 (1) (murder), 190 (unlawful assembly), and 191 (3) (rioting armed with deadly weapons) of BNS and Section 25 of the Arms Act against two persons known to the Gulati family, said an official. A team of cops and crime branch sleuths searched the houses of the two persons initially thought to have orchestrated the attack, but ruled out their involvement after a few rounds of questioning.ACP (crime) Aman Yadav said they made the arrests after CCTV footage showed Anil and his aides Varun, Krishan, Adesh, and Saurabh — all of whom are from Faridabad. After the arrests last week, the accused were remanded in judicial custody. According to Yadav, they had admitted before interrogators that the attack on Aryan was a case of "mistaken identify""It was Anil Kaushik who opened fire at the youth - four rounds in total. During questioning, the five accused claimed they were just going around in their Swift when they suspected that occupants of the Duster were involved in some criminal activity. So, they gave it a chase and fired at it occasionally. There was no previous enmity between them. Thought cops were chasing us':

## **India-US relations** need a reality check

THE Leader of the Opposition (LoP) in the Lok Sabha, Rahul Gandhi, is on a visit to the US. The visit has few precedents. The Biden administration is giving considerable importance to it, as was evident when US Ambassador to India Eric Garcetti met Congress president Mallikarjun Kharge on September 3 to discuss the details of this trip. Enjoying the status of a Cabinet minister as LoP, Rahul is expected to meet senior officials in the US administration, business and technology leaders, diplomats, academics and members of the Indian diaspora. Not many Cabinet ministers get such wide

Last year, PM Modi's state visit to the US in June had generated considerable excitement. President Biden had then described the India-US ties as "one of the most defining relationships in the 21st century". That visit had led to several major agreements about providing technologies for manufacturing F-414 jet engines in India, setting up of new semiconductor plant, sale of 31 MQ-9B SkyGuardian drones, cooperation in other critical and emerging, space technologies and other fields. Though it was clear even at that time that India and the US had differing positions on several issues, including the Ukraine conflict, as India had refused to criticise Russia directly in view of its close and historical ties. On the issue of human rights too, the two countries had different perspectives, though Biden had downplayed the issue when pointed questions were raised about the human rights record of the Modi government. However, during the G20 Summit in New Delhi in September 2023, both countries showed better cooperation as India, with support from the US, was successful in forging consensus on many difficult issues such as the Ukraine war, climate change, admission of African Union as a new member and a separate agreement on the India-Middle East-Europe Economic Corridor. The G20 had emerged as a robust platform against the prevailing pessimism where the developed, socialist and developing countries could come together to negotiate on complex problems. Serious differences, however, had begun to emerge between India and the US immediately after the summit. Biden had reportedly wanted to hold a joint press conference with PM Modi. But India was reluctant because of the possibility of Biden indulging in a veiled criticism of India's human rights policies following the arrest of some Opposition leaders earlier. India did not want to mar a successful summit with criticism of its human rights record before G20 leaders. Biden did his presser after reaching Hanoi but nursed a grievance that he was denied that opportunity in New Delhi.These differences on the issue of human rights deepened when Canadian PM Justin Trudeau claimed (without furnishing evidence) in September last year that there were 'credible allegations' of the Indian government's involvement in the murder of Hardeep Singh Nijjar, a Khalistani activist, who was killed outside a gurdwara in Surrey in June 2023. In November 2023, the US government said it had arrested Indian national Nikhil Gupta in Prague for allegedly conspiring to assassinate another Khalistani terrorist, Gurpatwant Singh Pannun, on American soil. The US claimed that Gunta, a businessman, had tried to hire a professional killer who turned out to be an undercover US drug enforcement agent, and was acting on the advice of an Indian government employee engaged in security and intelligence work.

Since the US allegations pointed to a nexus between organised criminals, gun-runners, terrorists and others, India agreed to set up a high-level inquiry committee to investigate the matter.

## J&K deserves a govt that can deliver

## Failed promises have been the hallmark of the Centre's administration of the UT

ON December 11, 2023, the Supreme Court directed that Jammu and Kashmir's statehood be restored 'as soon as possible'. The learned judges, led by none other than the Chief Justice of India, also noted that the Legislative Assembly elections need not await the restoration of statehood, and issued a direction that the polls be conducted before September 30, 2024. A simple reading of the judgment will amply demonstrate how the spirit of the law was conveniently circumvented by reliance on the letter of the law.In a telling statement in the concluding pages of his judgment, Justice Sanjay Kishan Kaul pleaded that the Union set up a "truth and reconciliation Commission" just like South Africa did after the apartheid era. "This Commission should be set up expediently before memory escapes. The

exercise should be time-bound. There is already an entire generation of youth that has grown up with feelings of distrust and it is to them that we owe the greatest duty of reparation," he wrote. This was the voice of an anguished Kashmiri at what had become of his people, echoing what had been the demand of a former Chief Minister while in office — Omar Abdullah.


Now a Union Territory, the erstwhile state was brought through a Home Ministry notification under its administrative control to the extent of being as close to the Union Government's administration as is the UT of Delhi. And it is to the executive of this entity that elections will be underway soon, but without Ladakh, which is a separate UT without a legislature.

At issue in this election is the restoration of self-government to the people of J&K, a status enjoyed by the citizens of every state in India, ruled by governments of their

choice through a system of elections envied by many of the world's democracies — from legislative assemblies down to the level of panchayats. The restoration of statehood is the centrepiece of the campaign of the Congress' Rahul Gandhi, Set against this is only a string of failed promises and outright flops that have been the hallmark of the Home Ministry's administration of the UTs of J&K and Ladakh. This is then the issue at the core of the campaign since the people across the two UTs will no longer countenance a government that cannot deliver. In a remarkable pretence at restoring democracy, District

Development Councils (DDCs), crafted with dexterity by talented bureaucrat BVR Subrahmanyam, then Chief Secretary of J&K, had been established in 2020. In an election swept by an alliance of UT parties, it was elected with no more authority than a cipher for the local police

station house officer. The Smart City signage across Srinagar marks sites of sewage effluents, potholed roads, damaged culverts or open manholes, supposedly under repair but with not a labourer in sight, only harassed citizens. Yes, there has been much activity in road-building in the main streets of Srinagar, but these, including the fabled boulevard, have been rendered unmotorable. That's because wide pavements, used as I have seen for myself, by no strollers whatsoever, have been built along the roadside, strangling motor traffic, which now has to crawl nose to tail. A proud young Municipal Commissioner escorted me to the renovated upmarket Polo View market that bridges the Residency and Maulana Azad roads, which together pass off as



Srinagar's Connaught Place. Apart from the fact that the dashing young man was unable to step into the market without being surrounded by 10 armed men in black with LMGs cocked, there were no customers in the market despite it being the high noon of the tourist season. And I was told that this frenetic building activity was being ably conducted by seasoned contractors from prosperous Gujarat, with migrant labour from UP, Bihar and West Bengal. So, what did the Kashmiris get out of this? Sadly, the tale is the same with every other promise, Rates of employment have fallen sharply despite the promise of jobs, with many of the vacancies filled both in Jammu and Kashmir divisions with recruits from elsewhere. The recent extension of Scheduled Tribe facilities to Pahari or Rajput communities in Jammu division amidst a loud proclamation by Home Minister

Amit Shah has gone nowhere since there are no jobs to be had, reserved or otherwise. Medical facilities have suffered, with nursing homes shutting down and patients travelling to Delhi for remedies. The prestigious Sher-i-Kashmir Institute of Medical Sciences, instead of being restored to its heyday of the 1980s, when it was equipped with state-of-the-art facilities - and where I was pulled back from the brink of death after an accident in 1993 when I was the Divisional Commissioner of Kashmir is now languishing under a junior bureaucrat.

This will also explain why Farooq Abdullah's National Conference (NC), in alliance with the Congress, has struck a chord with the people, be it his admirers or adversaries of yore. He is seen as the tallest regional


leader who led his party to victory in Kashmir (winning two seats out of three) in the 2024 Lok Sabha elections; in Ladakh, the NC-backed independent candidate won. He also led the PAGD (People's Alliance for Gupkar Declaration) to a win in the DDC elections.

This also explains why there is such a proliferation of candidates, even those that have had a declared separatist outlook. State Congress head Tariq Qarra has complained on TikTok that this is a ploy by the ruling party at the Centre to divide the Opposition. The release of several former leaders of the banned Jamaat-e-Islami from prolonged detention in the recent past and their grudging willingness to consider participating in the electoral process would appear to offer such a view. It might be recalled that their foremost leader at the close of the 20th century was Ali Shah Geelani, the apostle of the stridently separatist Hizbul Mujahedeen.

Nevertheless, while the integration of a former Hurriyat leader like People's Conference chairperson Sajjad Lone into 'mainstream politics' was anything but painless, the success of Engineer Rasheed in the parliamentary elections, which he won from Baramulla - worsting none other than Omar Abdullah — has opened a door to dissidents, which in turn will open the way for universal participation in the electoral process, a process which to my mind holds the key to the ultimate resolution of the integration of J&K into India. Whether the upcoming election is looked upon as an exercise in futility as it will end up by forming a legislature with scant authority, the very fact of wide public participation will demonstrate that democracy has at last come into its own in J&K and give India the roadmap to its future with what was and hopefully will be 'the people of the state of J&K'.

## The Kargil admission

#### Pakistan must do more to bridge trust deficit



It is common knowledge that the Kargil misadventure was orchestrated by then army chief Gen Pervez Musharraf. Smarting from the 1971 defeat, Pakistan tried to turn the tables on India but came a cropper. Why would Gen Munir mention it now, weeks after India



celebrated 25 years of the Kargil triumph? After all, the Pakistani military is firmly in the saddle, with the Sharif brothers under its control and the 'uncooperative' ex-PM Imran Khan behind bars. This could be an attempt to give the impression that Pakistan is finally coming to terms with its unpleasant past and is keen to learn from its historical blunders. Notably, PM Shehbaz Sharif said at the same event that his country desired peace with all neighbours. Despite these statements, coupled with overtures such as Pakistan's invitation to PM Narendra Modi to attend the SCO meeting in Islamabad next month, India has no reason to let its guard down. The trust deficit persists, with the Jammu region reeling under a spate of attacks linked to Pakistan-trained terrorists. Ironically, Pakistan is itself battling a surge in terrorism in Balochistan and Khyber-Pakhtunkhwa.

Gen Munir would be well advised to clear the air about his military's role in terror attacks across the LoC.

## Unreliable data inevitably leads to flawed conclusions

## Appropriateness of the metric of a measurement is immensely important.

IN his January 2023 address, then UK Prime Minister Rishi Sunak had stated that the country needed to reimagine its 'approach to numeracy' since we live "in a world where data is everywhere and statistics underpin every job.'

But should data always be trusted? In 2020, then Conservative UK PM Boris Johnson had stated that there were 1,00,000 fewer children living in poverty at the time than at the end of the previous Labour government's tenure. However, Labour leader Sir Keir Starmer claimed that 6,00,000 more children were living in poverty under Conservative rule. Interestingly, the government's statistics backed both claims, according to Georgina Sturge, statistician of the House of Commons Library. Thus, both were correct, but how?

Sturge's 2022 book Bad Data: How Governments, Politicians and the Rest of Us Get Misled by Numbers shows how crucial data, including that from the government, is riddled with inconsistencies, guesswork and uncertainty. Data disasters from recent political history, including some of Brexit's antecedents, are used to illustrate the book, which is upfront about the flaws and gaps in the data.

Sturge examines case studies of some of the most contentious topics, including gender disparity, immigration, Brexit, hate crimes, poverty and the state of education and healthcare. There is some dispute about what constitutes poverty, contributing to the discrepancy between Starmer's and Johnson's numbers. Sturge queries the definition of poverty. Is it a failure to provide for fundamental needs? And should television and access to the Internet be included among them? Also, should it cover the capacity, say, to pay an unexpected bill of a moderate amount? Neither the unemployment data in the 1980s nor the crime statistics of the 1990s or 2000s for the UK were reliable. The UK government has altered the definition of unemployment and the method for registering and counting unemployed people numerous times over the past 50 years. Once the union insurance claims were added to the claimant count, it was then expanded to include anyone who was 'actively seeking work'. Broader metrics are currently being used, and they account for those who are actively seeking employment as well as the larger group of people who are not, for various reasons. Sturge claims that nine 'significant' changes have been noted by the UK Office for National Statistics, making it impossible to compare the series over time.

Understandably, in such a scenario, it is difficult to assess whether the situation is getting better or worse, since we either do not count certain things or we do not count them consistently. According to Sturge, irregularities occur in the UK crime or health statistics since the same people who are responsible for reducing crime incident or disease numbers are responsible for recording those numbers. "We don't know... how many people died from Covid-19 or whether crime is going up or down," she wrote. Furthermore, disparities in the approach often distort the meaning. For instance, the data from telephone interviews used for the crime survey during the Covid-19 pandemic may not be comparable to the data from in-person interviews conducted before and after the pandemic.

Besides, if we don't know the underlying narrative, data just can't paint the whole picture. Sturge's book has the lovely historical anecdote of the origin of the term 'cobra effect'. Apparently, in 19th-century Delhi, a reward was offered for those who caught and killed the cobras that were overrunning the city. The public health risk posed by the venomous snakes,



however, persisted even after locals reported wheelbarrow loads of dead cobras to the authorities. It eventually became evident that many people had chosen to breed cobras with the intention of killing them and claiming a reward, and a significant number of these farmed cobras were escaping and attacking

Again, only data is not enough; the appropriateness of the metric of a measurement is immensely important. For example, rather than revealing general gender differences, the gender pay gap highlights the underrepresentation of women in top posts at firms. So, while helpful, this statistic is not very nuanced. In his 2019 book Bad Data: Why We Measure the Wrong Things and Often Miss the Metrics That Matter, Canadian urban designer Peter Schryvers drew attention to the drawbacks of data analysis and stressed the need to apply appropriate metrics before making key decisions in the environment, corporate and healthcare sectors. Economist Joseph Stiglitz,

recipient of the 2001 Nobel Prize, once stated: "What we measure informs what we do. And if we're measuring the wrong thing, we're going to do the wrong thing." Of course, there are tons of other examples beyond those two books on bad data. The GDP, which is frequently criticised as an inappropriate indicator of growth, is a crucial one. A small number of wealthy individuals contribute far too much to the GDP. Besides, there are more flaws in the GDP calculation process. In mid-2013, the US Bureau of Economic Advisers had modified its GDP calculation methodology, resulting in an overnight growth of 3 per cent in the US economy. Ghana moved its base year from 1993 to 2006 in 2010, resulting in a GDP

growth of 60 per cent and its transformation from a low to a lower-middle-income country. Similarly, Nigeria's GDP grew by 89 per cent all at once when this was 'rebased' in 2014; it surpassed South Africa to become Africa's largest economy. And all that magic happened without any additional economic action. Artificial intelligence (AI), too, is not always correct and unbiased. Bad training data or the intrinsic bias of the data used to train AI models is one of the primary reasons for that. Training data should be vetted to be free of racism, sexism and any other form of discrimination. However, it's almost impossible to guarantee that, particularly since AI requires massive amounts of training data. Therefore, statistical literacy is important for both our daily lives and politics, and data alone is insufficient for the purpose. However, the more general query still stands: Is it possible to draw any significant conclusions from data that seems flawed? Is no data preferable to bad data?

## Trinamool debunks RG Kar's treatment claim on 28-year-old man's death

The Trinamool Congress disputed claims by Kolkata's RG Kar Hospital that a 28-year-old man who died there received timely treatment, instead citing the mother's testimony that alleges medical negligence and lack of doctors.

New Delhi.The Trinamool Congress (TMC) on Tuesday challenged the assertion by Kolkata's RG Kar Medical College and Hospital that a 28-year-old man, who died at the institution last week, received In the video posted by TMC on X, timely treatment. The party posted a video of the dead patient's mother confronting a senior doctor at the hospital and debunking his claims.

Bikram Bhattachajee, a resident of "I brought him to the hospital at 9 Konnagar in Hooghly, around 25 km from Kolkata, was admitted to the state-run hospital after being run over by a truck. He succumbed to his injuries on Friday, September 6.

was the result of a delay in treatment due to the absence of doctors in the emergency ward. The hospital, however, refutes these allegations. Dr Punyabrata Guin, Convenor of the

Joint Forum for Doctors, had earlier

stated that Bikram Bhattachajee had received appropriate treatment on time, a claim now strongly contested by the grieving family.

Bikram's mother, Kabita, is seen speaking on the phone to a person who identifies himself as Dr Guin.



## **Explained: Why Paytm shares** jumped 9% in early trade

**New Delhi** Paytm shares saw a strong rise of over 9% in early trading on Tuesday, hitting Rs 687.40 per share on the Bombay Stock Exchange (BSE). This marked the second day in a row that the stock gained momentum.

While the exact reason for the sharp increase is unclear, but many believe it could be due to the GST Council's decision not to impose any new GST rules on UPI transactions under Rs 2,000. It may be noted shares of One 97 Communications, Paytm's parent company, have been climbing steadily. In the past week, Paytm's share price has risen by more than 13%, and in the last month, it has gone up by over 30%. Over the last three months, Paytm's stock has jumped by more than 74%.

Paytm's share price is now almost 120% higher than its

52-week low of Rs 310, reached on May 9, 2024.

On August 28, Paytm announced that it received approval from the Ministry of Finance to invest in its payment services business. With this approval, Paytm Payments Services Ltd (PPSL) will move forward in resubmitting its payment aggregator application. Meanwhile, PPSL will continue providing online payment services to its existing partners.

What's next for Paytm shares?

Analysts say that Paytm shares are still looking strong. However, they caution that the stock might face resistance in the Rs 710 to Rs 730 range.

If it breaks through this level, the share price could reach Rs 800. Ganesh Dongre, Senior Manager at Anand Rathi told livemint.com that investors with a medium-term outlook could hold onto the stock, aiming for the Rs 800 target. He advised maintaining a stop-loss below the previous day's close and buying on dips if the stock drops significantly.

## Narayana Murthy criticizes coaching classes, advocates for genuine learning and critical thinking


New Delhi. Narayana Murthy, co-founder of Infosys, has expressed strong reservations about the effectiveness of coaching classes, particularly those in high-pressure environments like Kota. Speaking at the launch of Paul Hewitt's 13th edition of Conceptual Physics in Bengaluru, Murthy argued that coaching centres are not the optimal solution for students aiming to excel in examinations. Murthy emphasized that the true purpose of education should be to cultivate critical skills such as observation, analysis, and hypothesis testing skills essential for addressing real-world problems. According to him, the reliance on coaching classes is indicative of a larger issue within India's education system, which often prioritizes rote memorization over meaningful learning.

He observed that many students resort to coaching centres because they do not fully engage with their school curriculum. This, coupled with parents' increasing dependence on these centres, highlights a troubling trend. "The growing coaching industry, now worth over Rs 58,000 crore annually and expanding at 19-20% per year, underscores a sstemic problem," Murthy stated. Murthy advocates for an educational approach focused on understanding and critical thinking rather than mere memorization. He reflected on a 1993 workshop at Infosys where he defined innovation as the pursuit of better, faster, and cheaper methods whether in daily tasks or complex problem-

## PLI scheme for chip: 20 requests pending

**NEW DELHI.** Nearly 20 applications are pending with the Ministry of Electronics and Information Technology for evaluation and approval for semiconductor under the production linked incentive scheme, a senior government official said on Monday.

As per Akash Tripathi, CEO of the India Semiconductor Mission, the country is expected to have more than 10 semiconductor units within the next decade to meet its domestic and global demand. "India should have at least 10 semiconductor units including fabs to meet the demand for chips both in India and worldwide," said Tripathi. The government announced an incentive of Rs 76,000 crore to develop semiconductor ecosystem in 2021. It has so far approved several semiconductor projects including a chip fabrication unit in Dholera, Gujarat, and four chip packaging units: three in Sanand, Gujarat, and one in Morigaon, Assam. The cumulative



investment in these projects is Rs 1.50 lakh crore.

As the capital announced for the scheme is nearing exhaustion, the government is expected to announce a second tranche of incentives for semiconductor soon. Tripathi mentioned that if necessary, the government will increase the allocation to develop the semiconductor ecosystem in the country.

When the mission was started, it was anticipated that at least 10 years of support would be needed until we become mature. If the funds need to be expanded, we will do it," said Tripathi. The government recently approved a Rs 3,307 crore proposal for an outsourced assembly and testing (OSAT) unit by Mysuru-based Kaynes Semicon. The OSAT unit will be set up in Sanand, Gujarat, with a total capacity of 6.3 million chips per day. Meanwhile, the Maharashtra government announced that it had approved a \$10 billion chip plant to be jointly established by Israel's Tower Semiconductor and the Adani Group. Regarding this, Tripathi said Israel's Tower Semiconductor has submitted its application, but the Ministry of Electronics and Information Technology (MeitY) has requested more details including information about its technology partner and financial model.

Nifty Financial Services also struggled, falling 0.62%. The auto sector faced pressure with Nifty Auto decreasing by 0.31%. Nifty Oil & Gas dipped 0.33%, while Nifty FMCG fell 0.16%.

# Gautam Adani's \$1.85 billion airport deal in Kenya hits legal roadblock

The deal faced opposition from various groups in Kenya, with a key legal challenge filed by the Kenya Human Rights Commission and the Law Society of Kenya

NEW DELHI. A recent legal ruling has halted a \$1.85 billion deal between Adani Airport Holdings Ltd and the Kenyan government, which would have allowed the company to manage Nairobi's Jomo Kenyatta International Airport (JKIA) for the next 30 years. The Kenyan High Court has suspended the agreement until further legal discussions can take place, reported Financial Times,

The deal faced opposition from various groups in Kenya, with a key legal challenge filed by the Kenya Human Rights Commission and the Law Society of Kenya, reported Bloomberg. The plaintiffs argue that leasing the airport, considered a vital national asset, to a private company violates key constitutional principles like good

governance, transparency, and responsible use of public resources. They believe the decision to lease JKIA was not in the best interest of the country.

Concerns over the deal

Faith Odhiambo, president of the Law Society of Kenya, expressed concern about the financial burden this deal could place on the country. She highlighted that the agreement could lead to job losses and place undue fiscal risk on the public, while providing little to no value for Kenyan taxpayers.

The opposition also claims that Kenya has the capacity to fund airport expansions without resorting to long-term leasing.

On the other hand, the Kenyan government defends the decision. It points to the urgent need for improvements at JKIA, which is currently operating beyond its capacity. Henry Ogoye, acting Managing Director of the Kenya Airports Authority, said that the deal would go through strict reviews to ensure it complies with publicprivate partnership regulations. He also mentioned that the investment required for JKIA's upgrades is significant, and



without private sector involvement, it would be challenging for the government to meet these financial needs.

Adani's expansion plans Gautam Adani, who is Asia's secondrichest person, has been rapidly expanding his airport business. Adani Enterprises already manages eight airports in India, handling 23% of the country's air traffic. JKIA would have been Adani's first airport venture outside India, marking an important step in the company's international expansion strategy. As part of the project in Kenya, Adani Airport Holdings plans to invest \$750 million by 2029 to build a new terminal and taxiway. By 2035, the company aims to invest an additional \$92 million for further upgrades. The long-term plan is to list the airport business on stock exchanges by the fiscal year 2028, which could help finance more global projects.

Opposition from workers and political figures

However, the proposed deal has sparked resistance within Kenya. The Kenya Aviation Workers Union, which represents about 10,000 employees, initially planned a strike over fears of job losses and the potential impact of the deal on their livelihoods. These concerns have added to the challenges facing the agreement.In India, opposition leaders from the Congress party have also raised concerns, with Jairam Ramesh warning that the protests in Kenya could lead to negative sentiments towards India. The ongoing backlash highlights the complexity of such international deals, especially when national assets are involved.

### Afghanistan vs New Zealand Test in limbo due to poor facilities in Greater Noida

New Delhi. The much-anticipated one-off Test between New Zealand and Afghanistan at the Shaheed Vijay Singh Pathik Sports Complex in Greater Noida, Uttar Pradesh seems to be in limbo due to substandard infrastructure, including a poor drainage system, at the cricket ground. After the opening day of the Test match was washed out due to rain on Monday, September 9, the start of the second day's play was delayed on Tuesday morning due to a wet outfield.

The woeful facilities an

d drainage system at the Greater Noida stadium have come under severe scrutiny. Greater Noida has been witnessing persistent rain over the last few days. Afghanistan and New Zealand struggled to complete practice sessions in the leadup to the Test due to the soggy condition of the outfield. Despite clear weather on



Monday morning, overnight rain had left the outfield wet.

The on-field umpires had as many as six inspections on Day 1 before calling it off. The field, particularly around the midon and mid-wicket areas, was rendered unplayable as large patches of soggy, muddy outfield posed a significant risk for players. Ground staff scrambled to manage the situation, resorting to covering the affected areas with sawdust. However, these makeshift efforts were far from adequate. On Tuesday, a concerning sight was the staff digging up sections of the outfield and filling them with dry soil and grass in a desperate attempt to make it playable. The affected area stretched around two-three feet, and even with these efforts, the outfield remained far from suitable for Test match conditions. Although rain began only late in the evening on Day 1, it worsened the already damp outfield. An inspection was scheduled for noon on September 10, but both teams, anticipating another delay, remained in their hotels. Ground staff, numbering around 20-25, including 15 outsourced workers, were seen battling the conditions with inadequate resources. Despite the availability of five super

## How realistic is Joe Root's threat to Sachin Tendulkar's record

England batter Joe Root is slowly closing in on Sachin Tendulkar in the list of leading run scorers in Test cricket. Here's a look at their numbers at different stages of their career.

New Delhi. Joe Root has been on a sensational run in Test cricket in recent times and has made a rapid rise in the list of leading run scorers of the format. The 33-year-old is currently the sixth-highest run-scorer in the history of cricket's oldest format with 12,402 runs to his name from 146 matches (267 innings) at an average of 50.62 with 34 hundreds and 48 fifties. He also has the sixth most hundreds to his name in Test cricket as he continues to climb up in the list full of legends such as Sunil Gavaskar, Alastair Cook, Brian Lara, Ricky Ponting, amongst others. Root's numbers didn't look as massive as they do now as he had 7,823 runs from 97 Tests till 2020 at an average of 47.99 with 17 hundreds and 49 fifties.

However, ever since 2021, he has been the best batter in the format accumulating 4579 runs from 49 matches (90 innings) at an average of 55.84 with 17 hundreds and 15 fifties. Root's sensational run has made him a top contender to surpass the legendary Sachin Tendulkar and become the leading run scorer in the history of Test cricket. The legendary

batter is the highest run scorer in Test cricket with 15921 runs to his name from 200 matches at an average of 53.78 with 51 hundreds and 68 fifties. Root is 3,519 runs away from levelling Tendulkar at the top of the list and has six more Tests this year still to play, three in Pakistan and as many in New Zealand. Given his current form, he will be expected to shorten the gap between him and Tendulkar further as he's just 71 runs away from becoming England's all-time highest run

scorer in Tests surpassing Alastair Cook (12,472 runs). With Root constantly closing the gap between him and Tendulkar, one must wonder where the legendary Indian batter was after 267 innings in his career.

Sachin's numbers after 267 innings

Notably, the Mumbai-born cricketer had 13091 runs to his name at an average of 55 with 44 hundreds and 54 fifties at the same stage where Root is currently at in his career. From there onwards, Tendulkar witnessed the last peak in international cricket where he plundered over 1601 runs in the next 23 innings and became the first batter to score 14000 runs in the format.

At the landmark 100th Test mark, there was a stark difference between the two players as Root had 8,507 runs at an average of 50.33 from 183 innings with 20 hundreds and 49 fifties. On the other hand, Tendulkar had

8405 runs from 160 innings after 100 Tests at an average of 57.96 with 30 hundreds and 34 fifties. With age on Root's side, Tendulkar's record is all set to be brokenThe numbers clearly show Root's low conversion rate early on in his career, which he has improved upon massively since 2021, having converted 17 out of his 32 fifties into centuries. Having an average of over 45 in seven out of the ten countries he's played in, Root is rated among the best performers all across the globe. The only major nation he's struggled while playing in is Australia, where he averages 35.68 from 14 matches, scoring 892 runs with the help of nine fifties.

On the other hand, Tendulkar has the feat of averaging over 40 in all the ten countries he's played in. Comparing the England star with the legendary batter would be sheer absurdity, as Tendulkar holds the edge over the England batter in several departments, be

it consistency, better performance across the world and better conversion

However, Root is far from done in his career and will turn 34 this December. Given his current form and the legacy he's created for himself, he's set to play for his country for at least three more years and has a great chance to leave Tendulkar behind in the all-time list if he continues his form.

More importantly, Joe Root is one of the busiest Test batters since the start of 2020, playing 57 matches. England are one of the busiest Test sides even

after the advent of the World Test Championship cycle. Root has played 57 matches since the start of 2020, 11 more than his nearest rival Zak Crawley.

Root is far ahead of his contemporaries when it comes to the frequency of Test matches. Among the Fab Four of the modern era (Root, Virat Kohli, Kane Williamson and Steve Smith), the England batter has played the most number of Tests in the said period.FAB 4 SINCE 2020

Joe Root - 57 matches Steve Smith - 37 matches

Virat Kohli - 29 matches

Kane Williamson - 22 matches

Root averages 12 Tests per year and he is increasingly becoming a Test specialist for England. However, it remains to be seen if Root can sustain his sensational form as he heads into the twilight period of his career.



As per a Pinkvilla report, it has already earned Rs 3.2 crore in 10 days of re-release. Reportedly, the film's rerelease is likely to outperform its original release. The publication mentioned that the film is particularly doing well in Pune, where the majority of its revenue has come from. Rehnaa Hai Terre Dil Mein has received roughly Rs 75 lakh in 10 days in the city, which is quite rare for most films.

Post the re-release of the film, Dia Mirza and R Madhavan resorted to social media to thank their fans for their support. They also held a live Instagram session, during which they discussed many topics. The duo uploaded a clip from their live session and wrote, "We just wanted to say a BIG thank you #RHTDM for all the love you have shown us over the last 23 years and the love you are giving the film in theatres right now." During the session, she also recalled their shooting day and mentioned, "We were travelling from one place to another for 14-18 hours, constantly going from one place to another. We would often catch up on our sleep on the flight. The film was also shot that way - we had shot in South Africa, New Zealand, Australia, and Mumbai. The film's release date was announced before we finished the

Meanwhile, on the work front, R Madhavan was last seen in Shaitaan, co-starring Ajay Devgn. The film earned rave reviews from both fans and critics. He will next act in Shankara and De De Pyaar De 2, co-starring Ajay Devgn and Rakul Preet Singh. Dia Mirza was last seen in the film IC 814- The Kandahar Hijack which also starred Vijay Varma, Pankaj Kapur and others.
