MUMBAI. The state govt has permitted the use of loudspeakers until midnight on three specific days during Navratri, with a 10pm

Newborn baby found buried in Bengaluru, rescued

BENGALURU. A newborn baby boy who was buried alive, was rescued by an alert villager who had gone to attend nature's call in Katriguppe Dinne village in Sarjapur police station limits around 9am

Police suspect the accused must have buried the baby in the dark, when there were few people around. The baby is suspected to have survived for two to three hours. Luckily, street dogs did not spot the baby as it was covered with mud.

The villager saw the baby by chance, after hearing him cry. The baby was buried near some bushes in a secluded area. Luckily, he was not buried deep inside, and was covered loosely with mud. The villager lifted the baby and brushed off the mud before informing others. News spread among the other villagers who informed the jurisdictional Sarjapur police.

The baby was admitted to Dommasandra government hospital for treatment. Doctors said since he was rescued on time, he is recovering with minor injuries. Police notified the district child protection unit to take custody of the baby.

"Asha from the child protection unit and her team visited the hospital and are looking into the matter. The baby is out of danger. We are checking CCTV footage of the area to get clues about the accused. It appears the accused are not locals, and they buried the baby in a hurry, fearing they would get caught," said an officer.

67 cases against seer over Prophet Mohammed remarks, Bombay High Court told

Mumbai. The Maharashtra government submitted before the Bombay High Court that about 67 FIRs have been registered across the state against religious leader Mahant Ramgiri Maharaj over his alleged derogatory remarks against Islam and Prophet Mohammed at an event in Nashik.

The government further told the court on Monday that the objectionable material containing the alleged derogatory remarks, which was shared online, is being taken down by the cyber crime police.

Maharashtra Advocate General Dr Birendra Saraf made this submission while opposing a petition which sought registration of an FIR against Maharashtra Chief Minister Eknath Shinde for sharing a stage with Ramgiri Maharaj after FIRs were registered against him. The petition had been filed by advocate Mohammad Wasi Sayed and others, alleging



that since 2014 there is "a steep rise in Islamophobic customs are protected and conserved by the state and Union governments, thereby giving rise to moblynchings, riots, and boycotting of Muslims". Advocate Ejaz Naqvi on Monday, representing the petitioners, argued that instead of initiating action against Ramgiri

CBI busts cybercrime cell targeting victims globally

HYDERABAD. The Central Bureau of Investigation (CBI) has busted a organised cybercrime network by arresting 26 people following raids in 32 separate locations in Pune, Hyderabad, Ahmedabad and Visakhapatnam.

The illegal call centres facilitated the accused to target their victims globally. In a statement, the CBI said that acting on inputs, its international operations division registered a case on September 24 under Sections 61 and 318 of the BNSS, 2023, and 66-D read with 75 of the Information Technology Act of 2000 as part of ongoing Operation Chakra-III.

The CBI then conducted coordinated searches from the evening of September 26 during which it intercepted 170 persons engaged in ongoing online criminal activities across four call centres and seized crucial digital evidence and incriminating material like mobile phones, laptops, financial information, communication records, as well as Rs 58.45 lakh in cash, locker keys and three luxury vehicles. While 26 - 10 from Pune, five from Hyderabad and 11 from Visakhapatnam - of the 170 persons intercepted were placed under arrest, the CBI is investigating the role of the others."The cybercriminals were involved in a range of illicit activities, including impersonating tech support services and approaching victims, especially in the US, claiming that the victim's systems have been hacked," the statement said.

It added that the victims were convinced by the criminals that their identities had been stolen and that a large number of unauthorised transactions were being made in their bank accounts. The scammers told the victims that they were under the scanner of investigation agencies.

'The cybercriminals then induced the victims to transfer their bank holdings into new bank accounts given by cybercriminals in the guise of safeguarding their finances. In some instances, the cybercriminals intimidated the victims into transferring funds to them through international gift cards or crypto currency.

Extensive wrongful losses were incurred by the victims targeted by this criminal network," the CBI said. It said that investigations into the broader network and on international leads are ongoing in close coordination with HSI (US) and other foreign law enforcement agencies.

THIRUVANANTHAPURAM. The The movement of sound in the atmosphere unusual light seen in the eastern skies of the capital city on Sunday night was 'heat lightning', R Jayakrishnan, Honorary Director of the Astronomical Observatory of the University of Kerala, has said.

The rare phenomenon had stirred up a discussion among residents and the observatory had received several phone calls from the public seeking explanation regarding the phenomenon.

"Heat lightning is a term commonly used to describe lightning from a distant thunderstorm which is too far away that the actual cloud-to-ground flash cannot The faint flash seen by the observer is the be seen nor the accompanying thunder can be heard," he explained.

depends on the temperature and density of air. As temperature and density vary with height, the sound of the thunder is refracted through the troposphere. This refraction results in spaces through which the thunder does not propagate.

'Many think that heat lightning is a specific type of lightning. But in fact, it is simply the light produced by a distant thunderstorm. Often, mountains, hills, trees or just the curvature of the earth prevents the observer from seeing the actual lightning flash," Jayakrishnan

light being reflected off higher-level clouds. Also, the thunder can only be heard for about 10 miles from a flash. This sound often reflects off the Earth's surface and the resultant rumbling sound is partly due to these reflections. This reflection and refraction can leave voids where thunder cannot be heard.

According to the scientist, the troposphere usually reflects the light, and leaves out the sound.

In such cases, some fraction of the light emanating from distant thunderstorms, whose clouds may be so low to the horizon as to be essentially invisible, is scattered by the upper atmosphere and thus visible to remote observers. Scattering by different constituents in the air results in various colors, he

MYSURU. More than 30 passengers, including students, were injured after the KSRTC bus they were travelling in struck a stationary canter and overturned on the service road of the Mysuru-Bengaluru access-controlled highway near Sanjo Hospital in Mandya on Monday.

The bus, which was ferrying around 60 passengers from Tumakuru to Mysuru around 9.50 am, took a sudden turn to enter the service road. Four of 'Pardi' gang arrested for looting Gzb jewellery shop

Ghaziabad. Four members of 'Pardi' gang, two of whom carried rewards of Rs 50,000 each on their arrest, were nabbed following a gunfight in Loni on Monday. The accused, from Guna district of MP, had allegedly stolen jewellery from a shop in Loni in Jan and fled with valuables worth Rs 50 lakh. The arrested accused -- Bhagat Pardi (22), Khalnayak Pardi (23), Vinod Pardi (55), and Rahul Pardi (24) -- belong to the Pardi tribe of Madhya Pradesh and have robbed houses and shops in different states, said ACP (Ankur Vihar) Bhaskar Verma. Two country-made pistols with live cartridges and some silver coins were recovered from their possession. Police spotted the suspects while checking the Loni border. Cops said they followed two of them when they did not stop despite their directions and tried to flee. "The two accused fired at the cops. In a retaliatory gunfight, they received bullet injuries. The other two were arrested during combing. During the interrogation, they revealed they were on their way to rob another shop in Loni," the ACP added. The gang members would recce different target areas for robbery under the garb of hawkers selling balloons and toys. They would observe people's schedules and decide their targets accordingly," he said. Explaining the modus operandi, he added, "The gang would divide itself into three groups. One would rob houses masked with weapons and rods, another would keep a watch outside for police, and the others would flee

Woman who lost 9L in job fraud kills self, father-son duo held

Ghaziabad. A father-son duo was charged with abetment to suicide on Sunday after a woman, who was cheated of nearly Rs 10 lakh on the pretext of a job at the home ministry, hung herself earlier this month.

On Sept 13, 34-year-old Deepa, a resident of Ram Nagar pipe market in Sahibabad, hung herself from a ceiling fan at home. She used to run a public service centre near her house. After her death, her husband Vikash Vana filed a complaint against two people, alleging that they had defrauded his wife, leading to her death.

The accused were identified as Sandeep Shival, a resident of Indraprastha Colony in Tila Mor, and his son Yashi Shival. Vana told cops that the accused were acquainted with his family. In Oct last year, Sandeep came to the centre Deep ran and introduced his brother-in-law as an official from the ministry of home affairs. He allegedly promised Deepa he could get her a job at the ministry and could also get her children admission at a central school."Subsequently, Deepa discussed the admission of her two children and her brother's daughters. The accused took Rs 40,000 for admission to Shahdara KV and provided some ID cards. Later, in January, they started taking money from her under the pretence of securing a job," he said. Deepa gave the accused around Rs 9.5 lakh over some time. The accused even provided her with a fake joining letter. However, neither her job nor her children's admission was ever actually finalised. "When my wife asked them to return the money, the accused threatened her with consequences. When she didn't find any solution, she committed suicide. We learnt about it after checking her phone and then we made a police complaint," Vana added.

An FIR has been registered against Sandeep and his son under BNS Section 108 (abetment of suicide). "One team has been formed to nab the accused, but both are absconding at the moment," ACP (Sahibabad) Rajneesh Upadhyay said. In another case, a 20-year-old law student allegedly jumped to her death from the 8th floor of a building in Swarn Residency in Sahibabad on Sunday night.

Festive relief No planned shutdown till Nov 15: Discom

Noida. The power department will launch a maintenance drive from Tuesday to Nov 15. Officials said there will be no planned shutdown during the upcoming festivals, like Navratri and Diwali. Special teams will be deployed around Durga puja pandals and Ramlila grounds to fix faults or address electrical snags.

Maintenance and repair work addressing tripping, overloading, network distribution, and equipment replacement will also be done across GB Nagar. Faulty cables, rusty poles, overloaded transformers, and switch gears will be repaired during this period.

The most affected areas are rural parts of the district like Sudamapuri, Etehra, Bishnoli in Dadri, while in urban areas sectors 46, 47, 158, Surajpur are more prone to outages because of poor equipment and old, dilapidated infrastructure. Under the maintenance drive, the power department has begun to identify cable lines of 33 kV with maximum faults, either due to damaged switch gear or dilapidated cables. Plans are also underway to assess damaged poles, faulty cables, overloaded transformers, and fix dual source cables which have been damaged because of digging

'The maintenance and repair drive will conclude on Nov 15. During this period, both long and short-term work will be undertaken. Short-term tenders will also be issued to address smaller electrical snags and get them fixed within days," Harish Bansal, chief zonal engineer of the Noida power department, PVVNL, told

For seamless supply during festivals, the power department will deploy special teams. "I have sought a list of puja pandals and Ramlila grounds to ensure that electrical safety measures are in place there. Special teams will be deployed at those locations to fix any faults and safety issues there," said Bansal.

Most voters here, Fbd seeks way out of clutter

Faridabad. With almost 18 lakh voters, Faridabad district, which comprises six assembly constituencies, is the biggest in Haryana. We will also work to resolve the problems faced by the public regarding property IDs, family ID and other govt portals," he said. Former CM Bhupinder Singh Hooda visited Badkhal and Dushyant Chautala Tigaon the same day, Sept 24, to campaign for Congress candidates. Hooda also promised a sports city and metro connectivity to Gurgaon and Palwal.Ravi Dagar, the AAP candidate from Faridabad NÍT constituency, said voters have been "exploited and deprived of basic civic amenities". "Roads are broken, and sewage is overflowing onto most roads. Heaps of garbage are dumped along roads and waste management is a major issue in the area, which will be resolved. I'll also ensure round-the-clock power supply in the area," he said.

Residents, meanwhile, are frustrated with such promises."The BJP-led govt announced metro connectivity to Gurgaon several years ago, but no progress has been made. Given the current rate of work, it appears that this will be yet another broken promise. Metro connectivity is vital because a significant number of workers from Faridabad travel to Gurgaon every day. Politicians shouldn't make such promises if they have no intention of fulfilling them," said Surender Sharma, another resident.

"Faridabad's infrastructure has not kept up with the standards expected from an NCR city. Despite the city's proximity to the national capital, we are facing numerous challenges, including potholed roads, choked drains and sewage overflow, waterlogging, garbage dumping and insufficient streetlights. Urban voters prioritise these issues when casting their ballots. But in the older areas of the city, voters tend to support candidates from their own communities and castes. For them, these issues take a backseat and caste plays a pivotal role," said Manisha Bhadana, a resident of Sector 16.

The key election issue is the lack of proper infrastructure. Even newly-built roads deteriorate quickly as corruption is rampant. Rain floods roads due to poor drainage, power supply is erratic and we are supplied dirty drinking water. Pollution is also a big issue as Faridabad is the one of the country's most polluted cities, yet no politician is talking about it. Garbage is scattered everywhere and stray cattle, dogs and monkeys are a menace. Our MLA hasn't even visited our area even once after being," said Rattan Singh, a resident of Sector 15.Former councillor Adlakha of BJP is contesting against Congress' Vijay Pratap in the Badhkal assembly segment. Pratap is the son of former minister Mahender Pratap, who unsuccessfully contested the Lok Sabha elections against Krishan Pal Gurjar.Faridabad NIT will witness a battle between outgoing MLA Neeraj Sharma of Congress, BJP's Satish Phagna, and Nagender Bhadana, who is contesting as an Independent after being denied a ticket by BJP. Cow vigilante Bittu Bajrangi, an accused in the Nuh riots case, is also contesting from the NIT segment.In the Faridabad assembly segment, the contest will be between Vipul Goel (BJP), who served as an MLA here from 2014 to 2019, and Congress candidate Lakhan Singla, who lost the last Assembly polls from the same seat by margin of 21,000 votes to BJP's Narender Gupta. In 2014, Singla, who was fielded by Congress from Ballabhgarh, had lost to BJP's Mool Chand Sharma.Ballabhgarh is set for a three-cornered contest between Mool Chand Sharma, Parag Sharma from Congress, and Sharda Rathore, who is contesting as an Independent after being denied a ticket by the Congress.

Alto crashes into tractor head-on, four out for late-night dinner die

41-yr-old handed life term for killing wife, 2 daughters over dowry in 2011

Noida: A Surajpur court on Monday found a 41year-old man guilty of killing his wife and two minor daughters over dowry demands in 2011 and sentenced him to life imprisonment. Four of his family members were also awarded two years in jail. The case dates to Jan 2011, when Parmanand, a resident of Kudi Khera village in Greater Noida, filed a complaint alleging that his daughter Bhumika (24) and two granddaughters were missing for two days. Bhumika got married to Omdutt, a factory worker in 2004, and the couple had three children - two daughters aged 5 and 2, and a son (3)Parmanand alleged that Omdutt, then 28 years old, his parents Kalicharan Sharma and Harwati, and two brothers Satish and Suresh, were demanding Rs lakh as dowry from Bhumika. "They physically and mentally tortured her. Twenty days before she went missing, Omdutt dropped Bhumika to her maternal home and said she should only return when she had Rs 1 lakh. We later asked her to return to her husband's place," Parmanand said in the complaint. He told cops that Omdutt's neighbours called them on Jan 12 and told them that Bhumika and the two girls were missing "Omdutt told cops during interrogation that he strangled Bhumika and his daughters Sakshi (5) and Prachi (2) on Jan 10. He then dumped their bodies into the Upper Ganga Canal after throwing acid on their faces," said Ratan Singh Bhati, additional district govt counsel. Police on Jan 13 recovered the bodies of Bhumika and Sakshi in the canal in Badalpur, but could not find Prachi's remains.Omdutt was arrested on Jan 14. His parents and brothers were also charged under

the Dowry Prohibition Act, and the trial began on May 11, 2011. Dr Rakesh Kumar, who had carried out the post-mortem examinations, told

Bangladesh sees fresh protests over increasing age limit for government jobs

World Protesters took to the streets of Dhaka on Monday demanding the Bangladesh caretaker government to increase the age limit from 31 to 35 for government jobs. The fresh protest in the capital city came as the crisis-hit nation is still recovering from the political turmoil that erupted in August, leading to the ouster of former Prime Minister Sheikh Hasina.On Monday morning, the protesters gathered in front of the National Museum in the city's Shahbagh. From there, they started their march to Chief Advisor Muhammad Yunus's official residence, Jamuna in Minto Road.According to local media reports, the protesters ignored a police restriction on rallies and gatherings in front of the Chief Advisor's residence and attempted to occupy the premises. As the protest march proceeded, police personnel deployed in the area tried to block the demonstrators from moving ahead, leading to clashes and scuffles between the two sides. In an attempt to disperse the protesters, the police then resorted to firing tear gas shells and rubber bullets. This is not the first time that Bangladesh witnessed protests demanding an increase to the age limit. During Sheikh Hasina's Awami League-led regime, several such demonstrations took place, but the then government rejected the demand. Despite the formation of a new caretaker government in the wake of the political crisis two months ago, lawlessness is still evident across Bangladesh.

Israeli troops enter Hezbollah tunnels amid ongoing ground raids in Lebanon

World The Israel Defense Forces (IDF) on Tuesday announced that it began "limited, localised and targeted" ground raids against Hezbollah targets and infrastructure in southern Lebanon, in yet another escalation of the ongoing hostilities between the Jewish nation and the Iran-backed Lebanese militant group.Meanwhile, A Wall Street Journal report said that Israeli troops had already entered Hezbollah tunnels near the nation's border with Lebanon before the IDF made the ground invasion announcement on Tuesday morning, The army said the targets were located in villages close to the Israel-Lebanon border and "pose an immediate threat to Israeli communities in northern Israel".Just hours before the IDF announcement. Israel warned residents in Dahieh, a Hezbollah stronghold in Beirut's southern suburbs, to evacuate. The warning was followed by a series of strikes in Beirut.

The IDF's ground operation comes days after Hezbollah chief Hassan Nasrallah was killed in an Israeli airstrike in Beirut.Meanwhile. more than 1,000 people have died in the past two weeks since the cross-horder hostilities first started, while up to a million others are likely to have been displaced.

Turkey's Erdogan urges UN to recommend force if Israel doesn't stop attacks

Ankara. Turkish President Tayyip Erdogan said on Monday that the United Nations General Assembly should recommend the use of force, in line with a resolution it passed in 1950, if the UN Security Council fails to stop Israel's attacks in Gaza and Lebanon.

NATO member Turkey has denounced Israel's devastating attack in Gaza against Palestinian militant group Hamas, and condemned its recent attacks in Lebanon targeting Hezbollah militants. It has halted all trade with Israel and applied to join a genocide case against Israel at the World Court, which Israel rejects."The UN General Assembly should rapidly implement the authority to recommend the



use of force, as it did with the 1950 Uniting for Peace resolution, if the Security Council can't show the necessary will," Erdogan said after a cabinet meeting in Ankara. The resolution says the UN General Assembly can step in if disagreements among the Security Council's five permanent veto-wielding powers -Britain, China, France, Russia and the United States - mean they fail to maintain international peace. The Security Council is the only UN body that can normally make legally binding decisions, such as authorising use of force and imposing sanctions.

Erdogan also said he was sad to see Muslim countries failing to take a more active stance against Israel, urging them to take economic, diplomatic, and political measures against Israel to pressure it into accepting a ceasefire.

"For the peace of everyone in our region, from Muslim to Jew to Christian, we call on the international community and Muslim world to mobilise," Erdogan said, adding Israel's attacks would target Muslim countries too if it is not stopped soon.

Brazilians choke as Amazon rainforest faces worst fire in 14 years

Brasilia With as much as 80 per cent of Brazil under a blanket of smoke from historic wildfires, face masks last used during the coronavirus pandemic are coming out again. South America's biggest country has for weeks been choking on pollution along with much of the rest of the continent battling extreme drought and record fires. Millions of hectares of forest and farmland have burnt in Argentina, Brazil, Bolivia, Colombia, Ecuador, Paraguay and Peru. The Amazon basin, usually one of the wettest places on Earth, is experiencing its worst fires in nearly two decades, according to the EU's Copernicus observatory. And last week, satellite images from the National Institute for Space Research (INPE),



showed 80 percent of Brazil affected by smoke."I am a smoker but I've been coughing more than usual," student Luan Monteiro, 20, told AFP in the port of Rio de Janeiro.Indeed, experts say that inhaling smoke from the fires has effects comparable to smoking four or five cigarettes a day. Air pollution can worsen bronchitis and asthma, and the risk is

greater the longer the exposure, according to paediatrician Renato Kfouri, vice president of the Brazilian Immunizations Society.In one of the biggest hospitals in the capital Brasilia, the number of patients treated for respiratory problems in recent days was more than 20 times higher than usual.In Brasilia, which has seen 160 days without rain, homemaker Valderes Lovola said she had bought a fan she uses to blow over wet towels and buckets of water to try and add some moisture to the dry air."When I go out, I put on my mask," the 72-year-old told AFP.Sao Paulo, Latin America's biggest metropolis, for several days last week was ranked the world's most polluted city by Swiss-based monitoring firm IQAir.

UPDATED The Solimoes, one of the two largest tributaries of the Amazon River in Brazil, fell to its lowest level ever on Monday in the worst drought on record in the Amazon region, leaving villages on its banks stranded without food, water and transport. At Manacapuru, some 100 km (63 miles) upriver from state capital Manaus where it meets the Rio Negro to form the mighty Amazon, the depth of the Solimoes measured at just 3 m (9.8 feet), according to the Civil Defense agency. That is 11 cm (4.3 inches) lower than the previous record low registered on October 25 last year. With almost another month to go before the rains come to end the dry season, the level of the Solimoes, which flows down from the Andes in Peru, is expected to drop further in coming weeks, deepening the crisis for riverine communities. Villages have been left isolated, without transport on water too shallow for boats to travel on, and they are lacking food supplies and, more critically, drinking water. The exposed Solimoes riverbed as turned into a massive long sandbank that the villagers have to walk across for two hours to get home carrying their shopping under a blazing sun."This is very hard. Everyday we have to this long walk along the beach carrying our things," said Taciara Souza Oliveira, a young woman. Boats were stranded on river banks and some were trapped in ponds of water in the sand dunes, in areas that were once navigable for large boats."The drought is bad and it is getting worse. There is still a month to go of dry season. We have to make this sacrifice to get home," said riverside resident Manuel de Castro.

Fishing is the main source of protein for river communities and the Indigenous people of the rainforest, but the fish have disappeared, and many have died in shallow waters that are too warm for them to survive in.Environmentalists say climate change and global warming are drying up rivers in the Amazon and leading to unprecedented wildfires that are destroying parched vegetation.

Ground report: How Lebanon's largest public hospital is dealing with heavy casualties

Beirut, Lebanon Israel continues to pound areas in southern Lebanon even after the killing of Hezbollah chief Hassan Nasrallah and several other commanders of the Iranbacked militant outfit. The wave of attacks has resulted in the deaths of over 1,000 Lebanese and forced lakhs of people to flee their homes, according to the Lebanese government.

The increased casualties due to Israeli airstrikes have resulted in the hospitals

being swarmed with patients. India Today TV's Ashraf Wani, the only Indian reporter on the ground in Lebanon, reached Rafik Hariri University Hospital on the outskirts of southern Beirut to report how the doctors have been dealing with the healthcare crisis. Speaking to India Today TV, Dr Jihad Saadeh, Director of the Rafik Hariri University Hospital, said the hospital received over 300 people injured by airstrikes today. "These injuries may be mild, moderate, severe, or disabling. So it's a war, a real war," he said.He also talked about the indiscriminate

airstrikes by Israel which have resulted in many people turning up at the hospital."They (Israel) don't care if they kill 100-150 people for just one Hezbollah member," said Dr Saadeh.

Despite the increased number of patients, Dr Saadeh said his team is prepared well to deal with this situation."We are trained very well," he said, noting the experience they



have gained since the Israeli attacks and subsequent wars started from as early as 1976.Dr Saadeh recalled an incident from his childhood which left a lasting impression on him. "We have experienced many wars since 1976. When Israeli attacked its neighbours, they dropped bombs called Napalm, which burned bodies. I still remember that I could not speak when I saw, as a 10-year-old, these bodies, which are all burned," he said.

Dr Saadeh said when the Gaza war started in October last year. his team worked on organising the procedure which we do when we deal with injured patients.

Dr Saadeh said since they are short staffed to deal with such a large number of surgeries, they have to prioritise people with life-threatening injuries. "We are postponing eye surgeries as eyes do not usually bleed when they are injured. Same thing applies for

fingers," he said. The latest actions by Israel indicate that it has no intention of slowing down its offensive against Iran's proxies in the region, including Hezbollah in Lebanon and Houthis in Yemen. While Hezbollah has vowed revenge against Israel over the killing of its leader Hassan Nasrallah, the Lebanese government is seeking a diplomatic route for a ceasefire.

Biden plans survey of devastation in North Carolina as Helene's death toll tops 130

ASHEVILLE. President Joe Biden was set to survey the devastation in the mountains of Western North Carolina on Wednesday, where exhausted emergency workers continued to work around-the-clock to clear roads, restore power and cellphone service, and reach people left stranded by Hurricane Helene. The storm killed at least 133 people and hundreds more were still unaccounted for on Monday night, four days after Helene initially made landfall.Meanwhile, election officials across the South were making emergency preparations to ensure displaced residents would be able to vote in the upcoming presidential election.Officials in the hard-hit tourism hub of Asheville said their water system suffered "catastrophic" damage that could take weeks to fully repair. Government officials, aid groups and volunteers were working to deliver supplies by air, truck and even mule to the town and surrounding mountain communities. At least

40 people died in the county that includes Asheville. The North Carolina death toll included one horrific story after another of people who were trapped by floodwaters in their homes and vehicles or were killed by falling trees. A courthouse security officer died after being submerged inside his truck. A couple and a 6-year-old boy waiting to be rescued on a rooftop drowned when part of their home collapsed.Rescuers did manage to save dozens, including an infant and two others stuck on the top of a car in Atlanta. More than 50 hospital patients and staff in Tennessee were plucked by helicopter from the hospital rooftop in a daring rescue operation. How some of the worst-hit areas are copingThe storm unleashed the worst flooding in a century in North Carolina. Rainfall estimates in some areas topped more than 2 feet (61 centimeters) since Wednesday, and several main routes into Asheville were washed away or blocked by



mudslides. That includes a 4-mile (6.4kilometer) section of Interstate 40 that was heavily damaged. Joey Hopkins, North Carolina's secretary of transportation, asked people on Monday to stay off the roads."The damage is severe, and we're continuing to tell folks if you don't have a reason to be in North Carolina, do not travel on the roads of

western North Carolina," Hopkins said at a news conference. "We do not want you here if you don't live here and you're not helping with the storm."At an Ingles grocery store in Asheville, Elizabeth Teall-Fleming was standing in line with dozens of others waiting to get inside and hoping to find some non-perishable food, since they have no power. She planned to heat up some canned food over a camping stove for her family."I'm just glad that they're open and that they're able to let us in," she said. Teall-Fleming said she was surprised by the ferocity of the storm. "Just seeing the little bit of news that we've been able to see has been shocking and really

sad."In one neighborhood, residents were collecting creek water in buckets to flush their toilets. Others waited in a line for more than a block at Mountain Valley Water to fill up milk jugs and whatever other containers they could find with drinking water.

Travel agents dupe Umrah pilgrims of Rs 1 crore, one held

BHUBANESWAR . The Economic Offences Wing (EOW) of Crime Branch has arrested a Mumbai-based travel agent for allegedly cheating pilgrims from Odisha on the promise of facilitating their Umrah (pilgrimage) in Mecca. By offering very affordable tour packages they managed to lure many pilgrims and swindled around Rs 1.2 crore from them, the EOW officials said.

The agency has arrested one of the proprietors of Al-Adam Tour and Travels, Nabeel Abdul Mubin Shaikh from Mumbai and brought him to Odisha. He was produced before a court in Balasore on Monday

Investigation revealed, the two other co-owners of Al-Adam are Nabeel's mother Firdos Bi Abdul Mubin Shaikh and his sister Saima Anjum Shaikh. The trio in association with proprietor of Al-Izma Tours and Travel in West Mumbai, MD Bismillah Shaikh, cheated around 189 pilgrims in various parts of Odisha like Balasore, Bhadrak and Baripada between 2019 and 2023.

The accused had allegedly posted advertisements on social media and distributed leaflets offering two lucrative tour packages of Rs 45,786 and Rs 50,786 per person to perform Umrah in the holy cities of Mecca and Medina in Saudi Arabia

Initially, they facilitated the visit of some pilgrims and managed to build trust. Soon, more pilgrims came to them and transferred the money in the bank accounts of Nabeel and his mother Firdos Bi, while some also handed cash to them. However, in the later part of 2023, the accused switched off their mobile phones and closed their office. They neither arranged the tour or refunded the money to the people. In a few instances, they handed over cheques to some persons but they were not honoured by the bank.

BJD cracks whip sends show cause to 4 four rebel leaders

I will give my reply within the stipulated time and you will come to know about it then. I have full confidence in my leader, the party president, and will abide by whatever decision he takes," Jena said.

Jena, however, said that two leaders of the party are creating all the problems. "It is the responsibility of the MLAs or MLA candidates to keep unity among members of the party in their constituencies. This is not happening here," he said.BMC corporator of Ward-59, Mahasupakar said no one in the BJD is above the party. Each member of the party irrespective of their position should be treated equally when it comes to disciplinary

It became a major issue after the power backup mechanism failed. The issue was resolved after a new power generator was



brought in following protests. While KSEB provides the high-tension supply, the PWD wing manages the electrical work at the hospital.In light of the controversy, KSEB denied responsibility, citing the poor condition of the hospital's electrical equipment as a contributing factor for the outage. As a referral hospital for women and children, power outages lasting over three hours, along with subsequent protests, have become an

embarrassment for the health department.

Thiruvananthapuram Deputy Mayor P K Raju described the incident as a serious oversight by the authorities. On Monday, councillors from both the BJP and the Congress staged protests in response to the situation. The hospital has two generators while another generator supplied by HLL remains unused.

Power minister gives clean chit to KSEB Electricity Minister K Krishnankutty on Monday reiterated that the KSEB was not at fault on the power outage that occurred at the SAT Hospital.On Sunday night itself, the minister had given a

clean chit to the KSEB. Minister's office informed that they had done maintenance work at the SAT Hospital for two hours from 3:30pm onwards which was initiated after informing the hospital authorities. A KSEB official told TNIE, "The equipment had rust on it which revealed a lack of periodic maintenance. The KSEB officials worked along with the electrical section of the PWD officials".

Telangana HC orders contempt notices to CS, DGP over police reforms

HYDERABAD. A bench of justices Abhinand Kumar Shavili and Laxmi Narayana Alishetty on Monday issued notices to top state officials, including Chief Secretary A Santhi Kumari and former and incumbent DGPs Dr Jitender and Ravi Gupta, directing them to respond to the contempt notices by appearing in person or through legal representation on October 25.

The Telangana High Court bench was hearing a contempt petition filed by the Forum Against Corruption, represented by its president Vijay Gopal, under Sections 10 to 12 of the Contempt of Courts Act, 1971, "for willfully violating the court's earlier order in a PIL".

The petition alleged that the government failed to implement key

reforms. including the mandatory minimum service duration of two years for officers of the ranks of IG, DIG, SP and CI.



The petition also pointed out the non-separation of investigative functions from law and order duties within the police force, as well as the failure to establish the Police Establishment Board and operationalise the District and State Police Complaints Authorities.

The petitioner sought maximum imprisonment for the respondents, along with a fine of Rs 5 lakh each for their continued non-compliance despite previous notices. The petition also requested the court to direct the respondents to provide a clear timeline for implementing all the required reforms. The case has been adjourned to October 25 for further hearing.

HC ALLOWS COLORPLAST TO PARTICIPATE IN TENDER PROCESS

Suspending the debarment order of the Transport department, the Telangana High Court has allowed Delhi-based smart card supplying company Colorplast to participate in the department's tender process. The HC observed that the department does not have the power to debar the company under the terms and conditions of the tender notice dated August 8. On September 18, the department debarred Colorplast after its responses were deemed unsatisfactory regarding compliance with SCOSTA guidelines.

While the strategically-located five-storey shopping complex at Angamaly bus depot, built to augment the non-operational income of the Kerala State Road Transport Corporation (KSRTC), is finally enjoying a decent occupancy rate, the 30-odd tenants there are crying foul over the "lackadaisical attitude" of the authorities in maintaining the facility despite collecting a hefty amount every year towards its upkeep. That, they say, is driving away potential customers and affecting the business of the 30 shops now functioning at the Angamaly bus terminalcum-shopping complex.

We cough up around 45 lakh per annum for maintenance alone. However, the facilities are not being maintained properly," said Poly Kuriakose, president, Angamaly KSRTC Bus Terminal Shop Owners' Association.Of a total of eight lifts, only four are functioning, he pointed out.

The cellar parking area is in a dilapidated condition and gets waterlogged quickly during heavy rains due to a lack of drainage



facilities. The toilet facilities too are poorly maintained. Parking is another issue. With the parking space in front of the building given to the general public, our customers find it difficult to park their vehicles," Poly said.KSRTC initiated the shopping complex project in tandem with the Kerala Transport Development Finance Corporation (KTDFC), which was appointed the nodal agency for the project in 2008 by the then LDF government.

Four shopping complexes were built at Angamaly, Thampanoor, Tiruvalla and Kozhikode at Rs 204 crore. Almost half of the total commercial space at these buildings lay vacant for years, forcing the

KTDFC to even slash the rent, from Rs 70 to Rs 40 per sq ft for the ground floor at Angamaly. "The commercial space in the first, second, third and fourth levels at Angamaly were mostly lying vacant for years. The ground floor and the fifth floor were, however, nearly fully occupied. Now, a majority of the total one lakh sq ft have been rented out. Only around 3,000 sq ft area on the second floor lies unoccupied. But of late, prominent clients like Carnival Cinemas have opted out," a source said.

Transport Minister K B Ganesh Kumar admitted that the facility, despite being located at a prominent location and enjoying a good footfall of customers, is not being properly maintained.

The bus terminal featured big in our scheme of things and there were plans to make it an inter-transit hub. Recently, I visited the facility and felt sad at how it's being maintained. Will be taking up the matter with the KTDFC, which is now entrusted with the shopping complexes," Ganesh

Haryana's legacy of Aaya Ram, Gaya Ram

Haryana, which goes to the polls on October 5, has had several 'double-engine' governments over the decades, with the same party in power in the state as well as at the Centre. Even when no party could muster a majority in the Assembly, the ruling party at the Centre was able to form a government in the state.

Haryana is no stranger to defections by politicians, who set aside ethical or moral considerations. Poaching of MLAs and hiding them in resorts to keep them away from the lure of monetary benefits and promises of ministerial berths have become the new norm in Indian politics.

In 1967, political defections became an accepted phenomenon. Haryana set the trend when MLA Gaya Lal changed his political affiliation thrice in a day. Hence, the term 'Aaya Ram, Gaya Ram' was coined to denote defections. Gaya Lal's son Udai Bhan, the current president of the Haryana Congress, was once a member of the Lok Dal.

In the 2019 Lok Sabha polls, the BJP had given the party ticket to five Haryana leaders with a Congress background. The defection of Rao Inderjit Singh, Arvind Sharma, Ramesh Chander Kaushik, Dharambir Singh and Chaudhary Birender Singh from the Congress to the BJP helped the saffron party consolidate its position in the state. By the 1980s, Haryana's politicians had mastered the craft of defection. In 1980, fearing the dismissal of his government after the return of Indira Gandhi as PM, Bhajan Lal, then Chief Minister, defected with his entire Cabinet from the Janata Party to the Congress. One had witnessed defections of legislators, but a CM jumping ship with his entire Cabinet was virtually unheard of. This happened decades before the BJP came up with 'Operation Lotus' to engineer mass defections. The ruling party feared that their members would defect and join the Opposition ranks and destabilise the government. The Opposition parties, too, feared that their members would be poached by the ruling party. In 2009, the Congress, falling short of a majority in the state, lured five MLAs of the Haryana Janhit Congress and one MLA of the BSP to form a majority.

The anti-defection law of 1985 was meant to stop elected representatives from deserting the parties on whose symbol they had been elected. In order to circumvent the law, a new modus operandi was devised: make some elected members resign from their seats, hence reducing the strength of the opponents, and then get them elected from the party they had switched their allegiance to. In recent years, 'Operation Lotus' failed in Himachal Pradesh and Rajasthan, but was successful in Madhya Pradesh.

Indian politics exemplifies the crassness associated with Machiavellian tactics. 'Ghar wapsi'is a term used by these uncanny politicians to describe their return to the party they had left. 'Homecoming' is considered as 'rediscovering one's roots. Chaudhary Birender Singh moved from the Congress to the BJP in 2014 and was back in the grand old party earlier this year. This is a classic case of 'ghar wapsi' or the return of the prodigal son. In the current Assembly elections, party-hopping is again the flavour of the season. Voters are confused that their representatives, elected on the symbol of a particular party in the previous elections, are now contesting from the very party that they had opposed five years ago. The Jannayak Janta Party (JJP) is on a sticky wicket as several of its elected members, including ministers, have defected to other parties, leaving the mother-son duo (Naina and Dushyant Chautala) to fend for themselves. The BJP, which regarded itself as a party strongly rooted in ideology, had no qualms about letting Kiran Choudhry and her daughter join its ranks and also getting her elected as a member. In 1996, the BJP had formed an alliance with Bansi Lal's Haryana Vikas Party, ignoring what its leaders had said about the former Congress stalwart's role during the Emergency So, one can infer that ideology often takes a back seat in Indian politics and ethical pronouncements are just for public consumption. All parties need 'notable' and 'electable' leaders to garner votes and extend their social support base, and that is why they have no compunction about co-opting leaders who hold diametrically opposite views.

Systemic change, not a quick fix, can tackle gender violence

Instead of solely advocating harsher penalties, it is crucial to focus on understanding the victim's psychology.

From the horrific 2012 Nirbhaya case in Delhi to the chilling Abhaya case in Kolkata, India has witnessed a surge in legal reforms meant to curb sexual violence and ensure justice for victims. Laws have become stricter, India's low conviction rates are partly due to judges' sentences harsher and policies more rigid. Yet, despite these legal advancements, the ground reality remains

largely unchanged. A haunting question arises: why do these laws fail to bring about the expected change in society?Andhra Pradesh's Disha Bill, Maharashtra's Shakti Bill and West Bengal's Aparajita Bill are quick-fix solutions to a deep, underlying rot. While the process of making a law is typically long and deliberate, the Aparajita Bill was introduced less than a month after the Kolkata rape-murder. The Disha and Shakti Bills were also swiftly enacted following heinous crimes against women. Criminal laws fall under the Concurrent List, requiring the President's nod, and enacting such laws suggest political manoeuvring and diffusing responsibility, while simultaneously brushing real issues under the carpet.Laws, however well-crafted, are inanimate - they exist on paper. The challenge lies in how these laws are implemented, interpreted, and enforced. This is where the animate components of the justice system - the police officers, judges, and society - come into play, breathing life into the inanimate laws. If these animate

components fail to respond adequately, even the most stringent laws become ineffective. We must recognise this distinction, or we will continue to struggle in achieving true justice. Historically, efforts to achieve gender equality often provoke a backlash that can lead to an increase in crimes against women, particularly sexual offences, until genuine equality is realised. Research studies and reports from the UN and WHO show that progress in gender equality can trigger hostility and increased violence against women as a means to reassert traditional power structures. This pattern, noted in journals like Violence Against Women and Lancet, highlights the need for comprehensive strategies to address both gender biases and the protection of women during these changes. From 2018 to 2022, conviction rate in rape cases in India was around 28 per cent, the second lowest among serious crimes, including murder, kidnapping, rioting and grievous hurt, according to the National Crime Records Bureau.

In contrast, Britain's rape conviction rate was 60.2 per cent in 2023-24 and 63.5 per cent the year before, according

evidence. Besides, stricter laws, combined with the fact that most victims know their assailant, suggest a higher risk of murder in such cases. Instead of solely advocating for harsher penalties, it is crucial to focus on understanding the victim's psychology and effectively rebutting defence arguments. The Swedish approach, which led to a 75 per cent increase in rape conviction rates over two years after a 2018 law change, emphasises the importance of removing the need to prove violence or threats. The term 'fast-track' courts is self-defeating; despite advocating speedy trial, rape cases in India still take a long time due to inadequate judicial infrastructure and a shortage of judicial officers, cops, judges and public prosecutors. The high pendency of cases increases the likelihood of flawed investigations, potentially allowing perpetrators to escape justice. Hasty investigations can lead to tampering with evidence and coercion of crucial witnesses. Completing the investigation in even 21 days is practically impossible. Once an FIR is filed, the investigating officer must collect evidence, ensure the survivor's safety, conduct medical examinations, request police custody

for further investigation, address rehabilitation schemes, conduct identification parades and prepare for numerous court hearings. Additionally, the officer must corroborate evidence, prepare the chargesheet, coordinate with the public prosecutor, and frame charges. If the offender is absconding in another state,

arresting them becomes more complex and time-consuming. A proper trial typically requires at least five hearings, involving the survivor, police, public prosecutor, accused, defence counsel, witnesses and the court itself. Completing all this in three or four weeks increases the possibility of a shoddy

Sexual violence survivors often face secondary victimisation, particularly during stressful and judgmental police interviews. This can result in incomplete statements, poor investigation and conviction. To address this, there is an urgent need for trauma-informed policing. Such police forces understand the impact of trauma and incorporate practices such as specialised training, interdisciplinary collaboration and empathy. Effective leadership is crucial for implementing these best practices and improving responses to rape cases.

Good laws alone do not create a just society; what is needed above all is a change in mindset," said Chief Justice of India DY

Chandrachud, addressing issues concerning women in India. This sentiment was echoed by Vice-President Jagdeep Dhankhar, who emphasised that our malecentric society must change its mindset before it is too late. In indictment of this societal decay, we have witnessed the horrifying spectacle of fathers violating their own daughters, and even children, perpetrating such heinous acts. The recent incident in Ujjain, where bystanders filmed rather than help a rape victim, further highlights this moral decline.


Unless we develop a comprehensive strategy to address sexual violence, rather than resorting to measures like the death penalty for rapists, we merely risk appeasing public sentiment without addressing the root causes. Such superficial steps are intended to pacify the public with a short memory and limited understanding of the complexities of violent sexual crimes. We end up creating symbolic victim identities like Nirbhaya and Abhaya, whose bravery is reduced to case studies in legal and social journals. To truly honour and protect victims, we must implement deep systemic changes that tackle the underlying issues of gender violence.

Chinese temerity stems partly from a dominant position on the trade front - India seems helpless in reducing its heavy dependence on imports from its northern neighbour. The double challenge for India is to stand up to China militarily as well as economically.

Nasrallah killing worsens West Asia crisis

What began as Israel's reprisal against Hamas has been expanded into a genocidal war

ENTROPY is defined as the absence of order or predictability and the gradual and irreversible decline into disorder. The last week of September has witnessed developments that have sharply increased both regional and global strategic entropy. The audacious killing of Hezbollah leader Sayyed Hassan Nasrallah in Beirut by Israel has the potential to plunge Lebanon and swathes of West Asia into greater turmoil. Much will depend on how Iran and non-state groups such as Hamas and the Houthis respond to this Israeli attack. Tactically, the discredited Israeli intelligence leviathan that was unable to pre-empt the October 7, 2023, Hamas terror attack has redeemed itself, but the strategic prudence of targeting the Hezbollah leadership is a moot point. It is evident that Israeli Prime Minister Benjamin Netanyahu has chosen to escalate the level of violence that he had unleashed after the Hamas attack on Israel. What began as an intense reprisal against Hamas in Palestine has been expanded with impunity into a genocidal war. With Hezbollah having entered the fray, Netanyahu has upped the ante by taking recourse to a lethal combination of telecom sabotage (pager explosions) and conventional airstrikes to decapitate the top leadership of Hezbollah. Adding to the violence, the Yemen-based Houthi militia launched a barrage of missiles and drones against US naval ships in the Red Sea on September 27. While these were intercepted and neutralised with no damage to the warships, this points to a steady uptick in hostilities in West Asia in the run-up to the first anniversary of the Hamas attack. This has grave implications for maritime security and the global supply chain. Washington has claimed that it was not in the loop with regard to the Nasrallah killing. While this may sound incredulous, given the depth of the US-

Israel relationship and American intel capabilities, the fact that PM Netanyahu cut short his US visit after addressing the UN General Assembly points to domestic politics ahead of the presidential election. Neither candidate (Kamala Harris and Donald Trump) can afford to take an unambiguous position on PM Netanyahu and the disproportionate violence he has unleashed. While there are courageous voices in Israel that want an end to this war, domestic political compulsions and the fear that he may be indicted for other transgressions have emboldened Netanyahu to press the 'death accelerator' with impunity. Hence, the first anniversary of the October 7 attack will pass off with no tangible prospect of a

cessation of hostilities. The war in West Asia will enter the second year, with the global community wringing its hands in ineffectual despair.

The war that jolted the world when Russia embarked upon its 'special operations' and invaded Ukraine in February 2022 is back in focus, with Russian President Vladimir Putin issuing an explicit nuclear warning to his adversaries. He announced changes in the Russian nuclear doctrine.Russia's 2010 nuclear doctrine, which stated that the use of nuclear weapons would be allowed as a response to conventional aggression that threatens the very existence of the state, has now been revised and made more elastic. The 2010

formulation was that nuclear weapons could be used by Russia "in response to the use of nuclear and other types of weapons of mass destruction against it or its allies, and also in case of aggression against Russia with the use of conventional weapons when the very existence of the state is threatened". This was refined in June 2020 when President Putin signed an executive order titled 'Fundamentals of Russia's Nuclear Deterrence State Policy', which, in essence, endorsed the use of nuclear weapons in response to a non-nuclear strike. Experts aver that this was due to the improved capabilities of America's conventional weapons. This 2020 formulation was a significant departure by Russia from the core principles of nuclear deterrence, which envisioned the nuclear weapon as having only one role or core mission - to 'deter' the use or threat of use of another N-weapon. The changes to the 2020 policy and the new threats that could elicit a nuclear response by Moscow


include the following: aggression against Russia by a non-nuclear country, but with the participation or support of a nuclear country would be viewed as a joint attack on Russia; reliable information about a massive takeoff of strategic or tactical planes towards Russia or the launch of cruise missiles, drones, hypersonic weapons towards its territory may be interpreted as a sufficient reason for a nuclear response by Moscow; reserving the right to use nuclear weapons in case of aggression against itself and its ally Belarus; and any critical threat to Russian sovereignty with conventional weapons. Any of these exigencies will be sufficient for a nuclear response. Toddlers remember good times for life

According to researchers from the Utah-based Brigham Young University, babies are more likely to remember an <u>incident if there is a positive emotion or</u> affect that accompanies it.

"People study memory in infants, they study discrimination in emotional affect, but we are the first ones to study how these emotions influence memory," said lead author and psychology professor Ross Flom.

The researchers monitored the infants' eye movements and how long they look at a test image. The babies were set in front of flat-panelled monitors and then exposed to a person on screen speaking to them with either a happy, neutral or angry voice. Immediately following the emotional exposure, they were shown a geometric shape. To test their memory, the team did follow-up tests five minutes later and again one day later. In the follow-up test, babies were shown two side-by-side geometric shapes: a brand new one, and the original one from the study

The researchers then were able to record how many times the baby looked from one image to the next and how long they spent looking at each image. The babies' memories did not improve if the shape had been paired with a negative voice, but they performed significantly better at remembering shapes attached to positive voices. "We think what happens is that the positive affect heightens the babies' attentional system nd arousal," the authors added.



"Public Safety Paramount, Temple, Dargah On Road Must Go": Supreme Court

The Supreme Court stressed India is a secular country and its directions for bulldozer action and anti-encroachment drives will be for all citizens

New Delhi: Public safety is paramount and any religious structure encroaching upon a road, water bodies, or rail tracks must go, the Supreme Court said today. The court stressed that India is a secular country and its directions for bulldozer action and anti-encroachment drives will be for all citizens, irrespective of their religion.

The bench of Justice BR Gavai and Justice KV Viswanathan was hearing petitions challenging bulldozer action against people accused of crimes. The trend, which has caught on in several states, is often referred to as 'bulldozer justice'. The state authorities have, in the past, maintained that only illegal structures were demolished in such cases. Solicitor General Tushar Mehta appeared for three states -- Uttar Pradesh, Gujarat and Madhya Pradesh. Asked if being accused in a criminal case can be a ground for facing bulldozer action, Mr Mehta replied, "No absolutely not, even for heinous crimes like rape or terrorism. Like my lord said it cannot also be that the notice issued is stuck one day before, it has to be in advance. One of the concerns was that notice has to be issued... most municipal laws, depending on the subject matter they are dealing with, have provisions for issuance of notice. Your Lordships may read that a notice be issued via registered post.

The bench said there are different laws for municipal corporations and panchayats. "There should also be an online portal so people are aware, once you digitise it there is a record."The Solicitor General then said he was worried that the court was issuing directions based on a few instances alleging that one community was being targeted."We are a secular country and our directions will be for all, irrespective of religion or community. Of course, for encroachment we have said... if it is on a public road, footpath, water body or railway line area, it has to go, public safety is paramount. If there is any religious structure in the middle of the road, be it gurudwara or dargah or temple, it cannot obstruct public," the court said. Justice Gavai said, "For unauthorised construction,

there has to be one law, it is not dependent on religion or faith or beliefs."Senior Advocate Vrinda Grover appears for UN Rapporteur and makes arguments on housing availability. The Solicitor General objected. "I know for whom they are, we don't want this to internationalise. Our Constitutional courts are powerful enough and our government is assisting non-adversarialy. We don't need an international agency to come in," he said. This is a new practice. Different counsels mention the same case for listing and once a judge blinks, you get some date. This is the practice that is emerging. A little bit of discretion which I have as the Chief Justice will never be exercised in your favour. You cannot take the court for a ride. My personal credibility is at stake. I have to follow standard rules for all," the Chief Justice



said. During several recent hearings, the Chief Justice of India has pulled up lawyers mentioning matters out of turn. He has repeatedly asked them to follow the procedure, file an application and raise the matter accordingly.

Maintaining decorum in the courtroom and ensuring proper processes are followed has been a key focus area of Chief Justice of India DY Chandrachud since he took over.Lawyers have often been pulled up for interfering in matters and addressing the bench loudly.

A new study has revealed that exposure of children to pets in early life does not increase the risk of their allergies to these animals later in life.

The researchers followed a group of children from birth until they reached adulthood. And at age 18 years, 565 study participants supplied blood samples to the researchers, who measured antibodies to dog and cat allergens in the samples.

They found that being exposed to the specific animal in the first year of life was the most important exposure period, and the exposure appeared protective in some groups.

F&O frenzy: SEBI gives markets a breather by skipping any action

MUMBAI. The board of the markets regulator SEBI which met Monday, has left a much-awaited decision on curbing the fast rising derivatives play by retail investors who have been losing heavily from that but has taken a slew of other pro-investor measures.

Some of the key decisions include slashing the number of days to complete a rights issue to just 23 working days from the present 317 days, increasing the T+0 settlement to top 500 stocks from the present 25 and has also decided not to push for instantaneous settlement. Measures to deepen the bond markets by easing disclosure norms about debenture trustees and introduced single filing system for listed and to be listed entities to file relevant reports, documents etc on one exchange which will be automatically disseminated at the other exchanges. Among others.

Market has been closely watching today's board meeting outcome to see if the regulator would rollout a new framework to govern index derivatives. But in an anticlimax, the regulator did not make any changes to the index-derivatives rules at all at the meeting which was the first since a volley of allegations were raised against the chairperson Madhabi Puri Buch mid-August by a US short-seller Hindenburg and the main opposition party Congress accusing her of conflicts of interest and favouring certain corporates where her husband Dhaval Buch has some pro-profit assignments.

At the 207th meeting of the board was held in Mumbai, SEBI approved the much-anticipated introduction of the regulatory framework for a new investment product/asset class in the mutual fund business by introducing the liberalised MF lite (MF Lite) framework for passively managed fund schemes.

Amending the mutual funds regulations of 1996, the Sebi introduced new investment product called MF lite under the existing mutual fund framework. The new product will bridge the gap between MFs and portfolio management services in terms of flexibility in portfolio construction. The new product also aims to curtail the proliferation of unregistered and unauthorized investment schemes/entities, which often promise unrealistic high returns and exploit investors' expectations for better yields, leading to potential financial risks. It has also allowed investors the option to trade in the secondary market (cash segment) either using UPI block mechanism (Asba-like for secondary markets), or 3-in-1 trading facility in addition to the current mode of trading. The regulator has said from now on one of the two facilities have to be mandatorily offered by stock brokers and other incidental matters.

Tech Mahindra Shares Rally 4% After CLSA Upgrade Ahead Of Earnings On Margin Boost



New Delhi. Shares of IT major Tech Mahindra rallied 4.2 per cent to a day's high of Rs 1,642.20 on the BSE after the global brokerage firm CLSA upgraded the stock to an 'Outperform' rating from an earlier 'Hold,' with a target price of Rs 1,749 per share.

In its note, CLSA mentioned that Tech Mahindra is already seeing an expansion in its EBIT margin, with the next key milestone being the order book. However, a broad-based growth revival for Tech Mahindra is not expected until FY26. The financial services, healthcare, and manufacturing sectors are expected to drive the majority of this growth.CLSA views the company's EBIT margin target of 15 per cent by FY27 as achievable and not overly ambitious, noting that the recent upward trend in EBIT margins provides scope for further rerating.Last month, Citi had assigned a 'Sell' recommendation on Tech Mahindra, with a price target of Rs 1,260 per share. Citi said the IT stock's growth is still difficult in the current environment.Out of the 44 analysts that have coverage on Tech Mahindra, 18 of them have a 'Buy' rating, 11 of them say 'Hold', while 15 have a 'Sell' call. The consensus implies a potential downside of about 4 per cent from the current levels. Since May 2023, the stock has been on an upward trajectory.

Consumers await fuel price relief as OMCs pocket huge gains

The report highlights that recent reductions in crude oil prices have improved marketing margins for Indian OMCs. Despite this, fuel prices in India remain elevated, with petrol still exceeding Rs 100 per litre in many states and diesel

Experts suggest that OMCs now have an opportunity to lower prices, potentially offering relief ahead of upcoming state elections in Maharashtra and Haryana. The price of

crude oil significantly impacts the profitability of fuel retailers, particularly OMCs that control about 90% of India's fuel retail market. As global crude prices have fallen, these companies have widened their marketing margins. New Delhi. The government has confirmed that the current interest rates for small savings schemes will stay the same for the October to December 2024 quarter. This means there will be no changes in the rates during this period. The post office savings schemes included in this decision are the Public Provident Fund (PPF), Senior Citizen Savings Scheme (SCSS), Sukanya Samriddhi Yojana (SSY), National Savings Certificate (NSC), Post Office Time Deposits (POTD), Mahila Samman Savings Certificate, and the Post Office Monthly Income Scheme (POMIS). In a press release dated 30th September 2024, the finance ministry said, "The rates of interest on various Small Savings Schemes for the third quarter of FY 2024-25 starting from 1st October 2024 and ending on 31st December 2024 shall remain unchanged from those notified for the second quarter of FY 2024-25." As a result, the PPF will continue to earn an interest rate of 7.1% from October to December 2024. How are interest rates determined?Small savings schemes, offered through the post office, are backed by the central government and are considered a safe investment option. They also provide tax benefits under section 80C of the Income-tax Act, 1961, for schemes like NSC, SCSS, and PPF. The government adjusts the interest rates on these schemes every quarter. The rates are set based on recommendations from the Shyamala Gopinath Committee, which suggests that the interest rates should be 25 to 100 basis points higher than government bond yields of the same

This approach ensures the schemes remain attractive to investors by offering competitive returns. The last significant adjustment to interest rates for small savings schemes occurred for the quarter ending December 2023. Some small savings schemes saw rate hikes, but the PPF rate has stayed at 7.1% since April-June 2020. There is growing curiosity about when small savings scheme rates might begin to decrease. Some experts suggest that the government could eventually lower rates, especially after the United States Federal Reserve recently cut its rates by 50 basis points. However, any decision on this is expected to be made cautiously. Since the Reserve Bank of India (RBI) has maintained its interest rates in recent meetings, it is unlikely that the government will make any drastic reductions to small savings scheme rates in the near future. Investors can expect rates to stay stable for the time being, especially given the slight increases seen in recent quarters. Experts believe that a gradual decrease in small savings interest rates could happen over the next six months to a year. With the US Federal Reserve already starting to lower its rates, it signals a possible downward trend globally.

India's factory growth cools to eight-month low in September

New Delhi. Growth in India's manufacturing industry cooled to an eight-month low in September as solid demand and output eased slightly, according to a business survey that also showed weaker price increases despite rising input cost inflation. Factory production growth has been weakening since June and is likely to have further affected the expansion rate in Asia's third-largest economy last quarter, after the rise in gross domestic product (GDP) softened to 6.7% in April-June.The HSBC final India Manufacturing Purchasing Managers' Index INPMI=ECI, compiled by S&P Global, fell to 56.5 last month from 57.5 in August - the weakest since January - and slightly below a preliminary estimate of 56.7. However,

the reading has been above the 50mark, which separates growth from contraction, since July 2021."Momentum in India's manufacturing sector softened in September from the very strong growth in the summer months," noted Pranjul Bhandari, chief India economist at HSBC.New orders - a key gauge of demand - grew at the weakest pace since December, though were still robust, while output was at an eightmonth low. International demand took a bigger hit and export growth eased to a level not seen in a year-and-a-



half. Only 6% of firms surveyed reported an increase in overseas orders. Shan Masood's self-respect questioned, Pakistan media urged to show respect

New Delhi. Pakistan Test captain Shan Masood found himself in an awkward situation during a recent press conference, prompting the Pakistan Cricket Board's (PCB) media director to step in and defend the skipper. Masood was confronted with a question about his self-respect at the press conference, held ahead of Pakistan's

upcoming home Test series against England. The tense moment occurred when a journalist bluntly asked Masood whether he had considered stepping down as captain due to Pakistan's poor performance in recent matches. "(Aapne bola jub tak woh mauka de rahe hain, avail karenge. Kabhi khud say koi khuddari nahi aati ki 'yaar haar gaye, performance nahi ho rahi, chod ke chale jayein?) You said till PCB gives chances you will avail them. Don't you have the selfrespect to call it quits since the team is losing and not able to perform? Masood, visibly caught off guard by the phrasing, briefly glanced at the PCB's media director, Sami ul Hasan, before responding minimally and moving on without directly answering the question. The interaction sparked an immediate reaction from Hasan, who stepped in at the end of the press conference to address the tone of the inquiry.



"Pakistan ka captain baitha hai, aap bilkul sawal karein (Pakistan captain is sitting, you can definitely ask questions). But please show respect...It was not the appropriate way of asking the Pakistan captain the question that you asked.'

This incident marked Masood's first press conference since being retained as Pakistan's Test captain, despite a string of defeats. Pakistan has lost all five Tests under Masood's leadership since he succeeded Babar Azam, raising questions about the PCB's decision to stick with him. Masood's captaincy has been heavily criticized following Pakistan's struggles, including a 0-2 whitewash at home against Bangladesh earlier this year. Despite the challenging results, Masood remains at the helm as Pakistan prepares to face England in a threematch Test series, set to begin on October 7

'Selfless approach and play to win': Manjrekar on Rohit Sharma's legacy

Former India cricketer Sanjay Manjrekar lauded Rohit Sharma's selfless approach after Day 4 of the Kanpur Test match. Speaking on ESPNcricinfo Manjrekar said that the India Test captain had secured his legacy in the Indian team. Under Rohit's leadership, India deflated the Bangladesh side on Day 4, with their firebrand cricket.

Despite losing more than two days of cricket due to wet outfield and rain, India came out with an aggressive approach on the

And he leads by example, exactly how he did in the 50-overs World Cup. So, this is what Rohit Sharma will leave behind as his contribution to Indian cricket," Manjrekar said on ESPNcricinfo.

His sole start came in a League Cup match against Watford, while he's been mostly

relegated to the bench in the Premier League. However, speaking ahead of City's upcoming Champions League fixture against Slovan Bratislava in Slovakia, Guardiola expressed confidence that Foden is nearing his best form. Maybe I can have some doubts in many things, but Phil Foden is going to be back! As much as he feels good, he will be back," Guardiola told reporters. "In 30 minutes at St James' Park (against Newcastle), I already saw something I liked that I didn't see against



Watford."

Foden is still waiting to open his goal tally for the season, but Tuesday's match against Bratislava, who were hammered 5-1 by Celtic in their group stage opener, could provide the perfect stage for him to make his mark.Guardiola noted that Foden's slow start could be attributed to fitness issues. "Don't forget after the Euros he didn't have any training for two months, he had problems with some niggles and his health," Guardiola said. "But now he is smiling, he's in his rhythm. He was the best player in the

Premier League last season, so we need him. I have no doubts about his passion, and he will be back."City opened their Champions League campaign with a goalless draw at home to Inter Milan, and they will be looking to secure a more convincing result in Slovakia. Guardiola warned, though, that they cannot afford to be complacent."I have incredible respect for all the teams in the Champions League, especially when you play away,' he said. "Hopefully we can be aggressive and take the result that we need. Nothing

is for granted, nothing comes for free."City defender John Stones echoed his manager's caution, recalling England's narrow 2-1 victory over Slovakia in Euro 2024. "We know the quality that they've got," said Stones. "That game went right to the wire, and tomorrow night, they will be well-organized, and it will be an incredible atmosphere." Vaibhav Suryavanshi's 58-ball hundred is only behind former England all-rounder Moeen Ali, who hit a 56-ball hundred for England Under-19 in 2005. Vaibhav hit 14 boundaries and 4 sixes in a destructive knock. He was run out when batting on 104 in just 62 deliveries as India came up with a strong response to Australia's first innings total of 293. Vaibhav's batting style has drawn comparisons to established players like Prithvi Shaw and Shikhar Dhawan, with his distinctive bat swing and ability to play shots with both feet off the ground. His innings featured a variety of shots, including a square drive, a pull over deep mid-wicket, and a classic cover drive, highlighting his versatility and skill. 
