Lucknow, Oct 10: Ahead of the upcoming Uttar Pradesh assembly by-elections, Samaiwadi Party chief Akhilesh Yadav expressed confidence in the INDIA alliance. Ahead of the upcoming Uttar Pradesh Assembly by-elections, Samajwadi Party chief Akhilesh Yadav expressed confidence in the victory, claiming that the SP, along with the INDIA alliance, will win all the seats. However, when asked about the seat-sharing arrangements within the INDIA bloc, he stated that it is still to be discussed, after which considerations will be made. Earlier in the day amid speculations of a rift in INDIA in Uttar Pradesh, Kannauj MP Akhilesh Yadav said on Thursday that the Opposition alliance will remain intact and the Samajwadi Party and Congress



will fight together in the upcoming UP by-polls. After offering tribute on the second death anniversary of Samajwadi party patriarch Mulayam Singh Yadav, Akhilesh Yadav addressed the media in which he told about the current scenario of alliance in UP by-elections. On Wednesday, the Samajwadi Party (SP) announced six candidates for the upcoming by-elec tions to the State Legislative Assembly. Tej Pratap Yadav will contest from Karhal, while other candidates include Naseem Solanki from Sisamau, Mustafa Siddiqui from Phulpur, Ajit Prasad from Milkipur, Shobhavati Verma from Katehari, and Dr. Jyoti Bind from Majhwan. However, soon after the announcement, Congress State Incharge Avinash Pandey said that no information was given to them about it and no discus sion was held with the coordination committee of the INDIA bloc. "It is true that no information was given to us about it. There has been no discussion with the coordination committee of the INDIA alliance yet. Tata, a man worth his salt: India bids farewell to her favourite son

Mumbai, Oct 10: India's financial capital on Thursday bid an emotional farewell to Ratan Tata, one of her most illustrious sons who defined both her enterprise and humility as thousands, from ordinary citizens to luminaries, paid tributes to him before his last journey. The final rites of the industry titan-philanthropist were performed with full state honours at a crematorium in Worli in the evening after Mumbai police personnel accorded him a gun salute, a day after he died at a city hospital, marking end of an era. The last rites were performed as per the Parsi tradition, one of the priests present at the crematorium said. After the funeral, there will be three more days of rituals which will be conducted at the late business tycoon's bungalow in Colaba, south Mumbai, he said. After his death late on

India bans Hizb ut-Tahrir as terrorist group: Amit Shah

New Delhi, Oct 10: The ministry of home affairs (MHA) on Thursday banned Hizb-Ut-Tahrir, an international Islamic organization formed in Jerusalem in 1953 with branches in many parts of the world under the Unlawful Activities Prevention Act (UAPA) for its involvement in radicalising youth to join violent jihad. Announcing the decision on X, Union home minister Amit Shah said "Pursuing Narendra Modi Ji's policy of zero tolerance towards terrorism, the MHA today declared Hizb-Ut-Tahrir as a terrorist organisation". "The outfit is involved in various acts of terror, including radicalizing the gullible youths to join terrorist organizations and raise funds for terror activities, posing a serious threat to the national security and sovereignty of India. The Modi government is committed to securing Bharat by dealing (with) the forces of terror with an iron fist," Shah added. In a formal notification, MHA said the outfit was involved "in radicalisation and motivation of gullible youth to join terrorist organisations, such as ISIS, and raising funds for terror activities". "Hizb-Ut-Tahrir (HuT) is an organisation which aims to establish Islamic State and caliphate globally including in India by overthrowing democratically elected governments through jihad and terrorist activities by involving citizens of the country, which is a grave threat to the democratic setup and inter-

One dies after students clash at Chennai Central station

CHENNAI. A 21-year-old Presidency College student died at Rajiv Gandhi Government General Hospital (RGGGH) on Wednesday morning. The man was admitted there on Friday after five Pachaiyappa's College students attacked him. The five men were arrested on Friday evening.A police source said security has intensified at the railway station and colleges to avoid untoward incidents.

The Periamet police said that the deceased man A Sundar, of Ponpadi village near Tiruttani in the Tiruvallur district, was a first-year political



science student. On Friday afternoon, as Sundar and two of his friends were outside the suburban train terminal at the Central Station, the five-member gang Pachaiyappa's

College students waylaid them and started attacking them. While the other two escaped, Sundar sustained severe injuries. He was rushed to RGGGH for treatment.

Based on a complaint, the police traced and arrested Chandhru, Yuvraj, Easwar, Hari Prasad and Kamaleshwaran. They were booked under the charges of attempted murder and were sent to judicial remand. However, after Sundar's death on Wednesday, the case was altered to murder. Sundar's body was handed over to his parents after the postmortem.

Madras HC allows state's appeal against compensation for injured student

MADURAI. The Madurai Bench of the Madras High Court recently allowed an appeal filed by the state school education department against the compensation awarded by a single bench of the court to a boy, who lost vision in his right eye allegedly after an accident at his school in May 2010.

According to an order passed by a bench of Justices P Velmurugan and KK Ramakrishnan, the boy was attending special classes held for students entering Class 10 at a private school in Kanniyakumari district.

It was alleged that on May 5, 2010, another student of the school attacked the boy with a stone on the school's premises, causing injuries in his right eye, eventually resulting in loss of vision. When the injured boy's parent moved the high court seeking compensation, a single bench reportedly directed the government to pay Rs 25 lakh compensation to the boy's family, challenging which the government filed an appeal.

During the hearing, it was pointed out that the school, a minority institution, had conducted classes during holidays in violation of the government's instructions. Yet, no action was taken against the correspondent and headmaster of the school, the boy's parents alleged. They also contended that the incident would not have occurred if the classes had not been conducted.

However, the division bench pointed out that it could not find an iota of material to prove the cause of the injury. Cases of this nature require evidence and the writ court, without any proper pleadings and documentary evidence, ought not to have decided the matter, the judges said and set aside the single

Artificial intelligence cannot replace core engineering courses, experts opine

CHENNAI. Artificial intelligence (AI) is simply a tool and can never replace the need for core engineering technology, opined industry experts and academicians, calling for support from all stakeholders to popularise traditional engineering courses.

Concerned over the declining popularity of core engineering courses such as civil, mechanical and electrical engineering, the higher education department on Wednesday organised a brainstorming session at Anna University in which various stakeholders participated. Industry experts and academicians advised the state government to take measures to promote interdisciplinary engineering courses where students, along with core engineering courses, can also study AI and other Machine Learning (ML) courses.

Higher Education Secretary K Gopal said that in view of India's ambitious goals, from sustainable urbanisation to energy independence, the country depends heavily on the work of core engineers. "As we work towards our goals, we need a new generation of professionals who are not only well-versed in cutting-edge technology but also grounded in the principles and practices of core engineering disciplines. Without a balance in engineering courses, we will face in future a shortage of skilled professionals in core disciplines," he said. J Innocent Divya, managing director of the Tamil Nadu Skill Development Corporation, highlighted the various initiatives taken under the Naan Mudhalvan scheme to bridge the gap between the industry and academia.

Kerala govt to bring in comprehensive legislation for cinema industry

THIRUVANANTHAPURAM. The state government will bring in comprehensive legislation to ensure complete protection to all stakeholders in the Malayalam film industry. This was informed by Minister for Cultural Affairs Saji Cherian in the assembly on Wednesday.

Raising the issue in the assembly, IUML legislator Manjalamkuzhi Ali asked about the status of the governmentconstituted committee other than the Internal Complaints Committee (ICC).

Saji Cherian replied that ICC has been ensured in all film sets and also a special legislation would be brought in to ensure complete protection to the film industry. The minister of cultural affairs also said that currently, the law department is considering the recommendations towards formulating the new Bill."In the backdrop of the Justice Hema Committee report, the LDF government is planning to bring in a piece of legislation. The state government is also considering



introducing ICCs in all film sets," said Saji Cherian. He also said that as per the directive of the High Court to the state government certain pages from the Justice Hema Committee report were removed and released. He was responding to a question raised by IUML legislator N Shamsudheen on the reason behind the delay in releasing the Justice Hema Committee report.

Woman waiting for bus run over by car on e-way

Gurgaon. A 40-year-old woman died when she was hit by a car on NH-8 on Tuesday evening.

The accident occurred at Bilaspur, when Jyothi was waiting for a bus to go to Dharuhera. She was declared dead on arrival at a private hospital in the city.

"Jyothi suffered a severe head injuries. She was bleeding profusely from her nose. I was near the accident spot and quickly got her shifted to Paras hospital in an ambulance. But she was declared dead on arrival," Jyothi's brother-in-law Raj Kumar said, adding that the accused fled from the spot after the accident.

"He stopped his vehicle around 50 metres ahead of the accident spot. As a crowd started gathering around Jyothy, he fled from the spot, abandoning his vehicle," Raj Kumar said.Police seized the car, and based on a complaint by Raj Kumar, registered a case under sections 106 (causing death due to negligence) and 281 (rash driving on a public way) of the Bharatiya Nyaya Sanhita (BNS). An autopsy was conducted, and the victim's body handed over to her family members on Wednesday."We have seized the car and initiated an investigation to identify the accused. We will arrest him soon," SI of Bilaspur police station, Satpal, said.

According to the latest report by National Crime Records Bureau, the number of accidental deaths in Haryana rose 8% from 14,830 in 2021 to 16,041 in 2022. A total of 10,654 road accidents were reported in the state in 2022. Of 5,228 deaths on roads, 2,812 people who died were two-wheeler riders and 1,663 were pedestrians.

Truck crashes into bike, girl (6) on way home from school dies



Noida. A 6-year-old girl died, and four others were injured after a speeding truck crashed into their bike in the Pushta area on Wednesday. Police have seized the truck and detained the driver.

The deceased, Nandini, originally from Shahjahanpur, was living with her family in Wazidpur, Sector 135.

"Nandini and three other minor girls were returning from school on their neighbour Kishan's bike when a speeding truck rammed into their vehicle," said an official. A police team was dispatched to the scene around 2.20 pm after locals who witnessed the accident alerted authorities via the emergency number."All five of them, who were riding on the bike, were taken to a nearby hospital. Nandini was declared dead on arrival by hospital authorities, while the other four injured individuals are receiving treatment," added the official.

2-hr window for green crackers on Diwali, 35 mins on X-mas & NY

Gurgaon. The district administration on Wednesday prohibited the manufacture, sale and use of firecrackers from Oct 22 to Jan 31 in view of increasing air pollution. The online sale of firecrackers through e-commerce sites has also been prohibited. Every year, the administration, in accordance with the NGT order, bans sale and use of firecrackers before Diwali to curb pollution.

However, on Diwali and other festivals like Gurupurab, burning of green firecrackers will be allowed between 8pm and 10pm. On Christmas and New Year, they would be allowed between 11.55pm and 12.30am. In orders issued under the explosives act, deputy commissioner Nishant Yadav stated that there would be a complete ban on the production and sale of loud firecrackers and firecracker chains. The administration authorised the pollution board, municipal corporation, police, revenue officials, panchayat, and block officers to enforce compliance with the ban and raid places found to be flouting the rules. In addition to this, all govt agencies and departments were required to submit a daily report to the administration about the compliance of the ban.

On Diwali, especially, all police stations of Gurgaon were directed to keep an eye on the sale and use of firecrackers and people were urged to file a complaint at police control rooms in case they come across incidents of people burning firecrackers outside of the stipulated time."The ban was imposed in view of pollution, and it will be enforced strictly," said Yadav.

Meanwhile, city residents said they wanted the government to focus on other major factors contributing to the spike in air pollution during the winter months. Construction activities, industry, vehicles and stubble burning cause pollution. The contribution of firecrackers, an integral part of festivals, is very small," said Anuj Mishra, resident of Sector 14. Air pollution was on a high from Oct to Jan, which was detrimental to the health of people, particularly the vulnerable sections like children, elderly, and people with pre-existing respiratory illnesses, Yadav added. Firecrackers can increase the air pollution index by 2.5 to 10 points.

361 plots up for grabs near airport, 1.9L apply for them

Noida. Nearly 1.9 lakh applicants will be part of a draw of lots for allotment of 361 residential plots offered by the Yamuna Expressway Industrial Development Authority (YEIDA) near Noida International Airport. The draw of lots will be held on Thursday at the India Expo Centre located in Greater Noida.

Interest in plots near the airport and along the Yamuna Expressway has increasingly gone up after the foundation laying ceremony of the airport was conducted in Nov 2021.On an average, 518 applicants have applied for each residential plot.

Launched in July this year, YEIDA's latest scheme includes residential plots in sectors 16, 18, 20 and 22D. The plot sizes range from 120sqm to 4,000sqm, and are priced at Rs 29,500 per sqm.A YEIDA scheme introduced last year for 1,184 plots saw nearly 1 lakh applicants. In 2022, demand saw a surge for the first time, with the authority receiving 64,000 applicants for 477 plots.Response to schemes was lukewarm before late 2021, primarily due to considerable distance from Noida and Greater Noida."The scheme has generated substantial interest



among applicants primarily due to its Sood added that this interest in residential strategic proximity to the upcoming Noida International Airport, which is poised to significantly enhance the region's real estate market. In addition to the airport, several major projects, including Film City, Semiconductor Park, Japanese City, Korean City, Software Park, and Medical Device Park are in the works," Avneesh Sood, director of Eros Group, said on Wednesday.

Trees felled, land levelled & wall built in Aravalis again

Gurgaon:On the protected Aravali land in Mangar, around 70 trees have been Any form of non-forest activity, felled and land has been levelled to make way for plots that are fenced off with boundary walls even though forest department and other eforcement agencies conduct checks.

The first incident occurred on Saturday when half an acre of Aravali land in Mangar village was levelled, and around 50 trees were axed. The next day, an illegal wall was found constructed on one acre of land, and on Monday, around 20 trees were felled at a nearby area..The area where tree felling took place, is close to Mangar Bani buffer area, and is safeguarded under sections 4 and 5 of the PLPA.

Construction activities within a 500m buffer zone around the 677-acre Mangar Bani forests are banned. And the PLPA legislation enacted in 1990 to protect the forested area from erosion restricting land excavations. It shields the ecologically fragile Aravali land in 10 districts — Gurgaon, Panchkula, Ambala, Yamunanagar,

Mahendragarh, Rewari, and Bhiwani. including felling of trees, land encroachment, or initiating construction, is strictly prohibited in these areas. The land where the illegal construction took place is classified as 'gair mumkin pahar'.Responding to the incidents, locals said illegal activities were on the rise in the area and expressed disappointment in the authorities' failure to address them.

"Such incidents are being reported often. They can lead to an irreversible damage to the ecologically fragile zone and even disrupt the delicate balance of wildlife. There is an urgent need for stringent enforcement of laws," a villager said. Meanwhile, a forest department officer in Faridabad said action had been initiated to prevent a repeating of such incidents. "We have already filed a forest offence report. To prevent further encroachments and construction in the forest area, we will also carry out plantations, "he said. Environmentalists pointed out that the area falls under the natural conservation zone of Faridabad municipal corporation. Vaishali Rana, an environmentalist, said, "This is happening in an area that is protected under sections 4 and 5 of the PLPA. Such non-forest activities are illegal and detrimental to the entire ecosystem.

These land grab attempts are often orchestrated by local land sharks."Earlier this year, on May 26, an acre of Aravali land protected under the PLPA was found levelled with soil in Mangar village and approximately 100 trees across a two-acre area of the Aravalis near Mangar Bani were set ablaze in the early hours of May 13.In May 2023, around 50 trees spread over one acre in Aravalis near Mangar Par were chopped illegally.angar Bar the only region in NCR to host different tree species that are native the Aravalis. Life-threatening hurricane Milton makes landfall in Florida, flash floods likely

World Hurricane Milton, now a Category 3 storm, made landfall and struck Florida near the coastal community of Siesta Key, after weakening from a Category 5 storm on Wednesday morning.hile Milton slightly weakened on Wednesday afternoon to a Category 3 hurricane, the third-highest level, it was growing in size as it approached Florida and remained extremely dangerous with maximum sustained winds of 120 mph (195 kph), the hurricane centre said.

More than 1 million homes and businesses were without power Wednesday in Florida, reports said. The highest number of outages were in Sarasota County and neighboring Manatee County. Heavy rains were also likely to cause flooding inland along rivers and lakes as Milton traverses the Florida peninsula as a hurricane. In a state already battered by Hurricane Helene two weeks ago, as many as two million people were ordered to evacuate, and at least a million others live in the projected path of the storm. Both storms are expected to cause untold

billions of dollars in damage. Once past Florida, it should weaken over the western Atlantic, possibly dropping below hurricane strength on Thursday night.

Kamala Harris's campaign raises \$1 billion since she became presidential candidate

Washington. Vice President Kamala Harris' presidential campaign and related political committees have raised \$1 billion since she became the Democratic candidate in July, a source briefed on the matter told Reuters.Since Harris replaced President Joe Biden on July 21, dollars have flowed into her campaign coffers and affiliated political action committees and Democratic Party at an unprecedented pace. Harris raised \$25 million on the day she was named the candidate, and had amassed \$500 million in about a month.Former President Donald Trump and the Republican Party raised \$130 million in August, leaving \$295 million cash on hand at the end of that month, vs. Harris and Democrats' \$404 million. Harris' race against Trump remains close, with her lead nationally narrowing, new Reuters/Ipsos polling shows, and the race a tossup in many battleground state

The money haul reflect donors' enthusiasm going into the November 5 election, the source said, and will be used on advertising, operations in battleground states and staff.

Milton made landfall in Florida on Wednesday as an "extremely dangerous" Category 3 hurricane, packing lifethreatening storm surge, extreme winds and flash flooding, the AFP quoting National Hurricane Center said."Data indicate the eye of Hurricane Milton has made landfall near Siesta Key in Sarasota County along the west coast of Florida," the NHC said in an 8:30 pm (0030 GMT Thursday) bulletin. The Guardian quoting CNN said that Milton is the fifth hurricane to make landfall in the US this year, more than from 2021 to 2023 combined.Hurricane Milton has now knocked out power to more than 2 million Florida customers, according to utility tracker, The Guardian updated. According to The Associated Press, the cyclone had maximum sustained winds of 120 mph (205 kph) when it roared ashore near Siesta Key, Florida, at 8:30 p.m., the Miami-based National Hurricane Center said. The storm was bringing deadly storm surge to much of Florida's Gulf Coast, including densely populated areas such as Tampa, St. Petersburg, Sarasota and Fort Myers.Hurricane Milton spawns multiple tornadoes across FloridaMultiple tornadoes spawned by the hurricane tore across Florida, the twisters acting as a dangerous harbingers of Milton's approach. Three Florida offices of the National Weather Service in Miami, Tampa and Melbourne issued more than 130 tornado warnings associated with Hurricane Milton by Wednesday evening. Videos posted to Reddit and other social media sites showed large funnel clouds over neighborhoods in Palm Beach County and

elsewhere in the state. Luke Culver, a meteorologist with the National Weather Service in Miami, said he wasn't sure whether Milton had spawned a record number of tornados, but he pointed out that only 64 Florida tornado warnings were associated with Hurricane Ian, which hit the Tampa Bay area as a massive storm in 2022.

Dozens killed as Israeli troops pound central, northern Gaza

Gaza's Health Ministry said it recovered 40 bodies from Jabaliya from Sunday until Tuesday, and another 14 from communities farther north.

World Israel's bombardment of central and northern Gaza has killed dozens of people and trapped thousands in their homes, Palestinian officials said Wednesday, as the death toll in the yearlong war passed 42,000.Gaza's Health Ministry said it recovered 40 bodies from Jabaliya from Sunday until Tuesday, and another 14 from communities farther north. The toll is likely higher as there are bodies buried under the rubble and in areas that can't be accessed, it said.Rear Adm. Daniel Hagari, the military spokesperson, said that Israeli forces were operating in Jabaliya to prevent Hamas from regrouping and had killed about 100 militants, without providing evidence.Israel says it only targets militants and blames civilian deaths on Hamas because it fights in residential areas.

Civilians trapped in North Gaza Israel expanded an ongoing military operation

around Jabalia in the north of Gaza, where around 400,000 people are trapped, according to Philippe Lazzarini, head of the UN agency for Palestinian refugees (UNRWA).Posting on social media platform X, Lazzarini said there was "no end to hell" in the area and that "recent evacuation orders from the Israeli authorities are forcing people to flee again & again". The army surrounded the town of Jabalia and its refugee camp over the weekend and was shelling it on Wednesday, preventing the delivery of aid, the Palestinian territory's civil defence agency said.ashington said it was "incredibly concerned" about the humanitarian situation in north Gaza as Israel tightens its siege, adding that it had been "the subject of some very urgent discussions between our two governments".

The comments came after a hotly anticipated phone call between Netanyahu and US President Joe Biden, their first in seven weeks, which had been expected to focus on Israel's response to last week's missile barrage by Îran.During the call, Biden told Netanyahu to "minimise harm" to civilians in Lebanon, particularly in "densely populated areas of Beirut", the White House said. "There should be no kind of military action in Lebanon that looks anything like Gaza and leaves a result anything like Gaza," State Department spokesman Matthew Miller told journalists.Netanyahu said in a video address to the people of Lebanon on Tuesday: "You have an opportunity to save Lebanon before it falls into the abyss of a long war that will lead to destruction and suffering like we see in Gaza."

Turkish Airlines flight makes emergency landing in New York after pilot dies

A Turkish Airlines pilot died midair, forcing the Istanbul-bound flight to make an emergency landing in New York. The flight had taken off from Seattle.

World A Turkish Airlines flight bound for Istanbul from Seattle was forced to make an emergency landing in New York on Wednesday after the captain collapsed mid-air, an airline official said.

Pilot Ilcehin Pehlivan, 59, lost consciousness after Flight 204 took off from Seattle on Tuesday night. Turkish Airlines spokesperson Yahya Ustun said in a statement posted on X. He could not be revived despite medical intervention, following which a second pilot and a co-



pilot took over the controls. According to data from tracking site FlightAware, the flight landed at John F Kennedy International Airport in New York just before 6 am on Wednesday. The plane landed in New York eight hours after it took off from Seattle.Pehlivan had been working with Turkish Airlines since 2007.

He had undergone a periodic health examination on March 8, which found no health problem that would have prevented him from working, Ustun said.

Arrangements were being made for passengers to reach their destination from New York," the airline spokesperson said.

The cause of the pilot's death was not known. Generally, pilots have to undergo medical examinations every 12 months, while those above 40 years of

Biden, Netanyahu speak as Israel warns attack on Iran would be 'lethal'

World US President Joe Biden and Israeli Prime Minister Benjamin Netanyahu spoke on Wednesday amid tensions with Iran while Israeli Defence Minister Yoav Gallant said an Israeli strike against Iran will be "lethal, precise and surprising."The call, confirmed by both countries, was the first known chat for Biden and Netanyahu since August and coincided with a sharp escalation of Israel's conflict with both Iran and the Iranbacked Lebanese Hezbollah with no sign of an imminent ceasefire to end the conflict with Iranbacked Hamas in Gaza. The Middle East has been on edge awaiting Israel's response to a missile attack last week that Tehran carried out in retaliation for Israel's military escalation in Lebanon. The Iranian attack ultimately killed no one in Israel and Washington called it ineffective. After describing Iran's Oct. 1 missile attack as a failure, Gallant said in a video issued by his office: "Whoever attacks us will be hurt and will pay a price. Our attack will be deadly, precise and above all surprising, they will not understand what happened and how it happened, they will see the results."Netanyahu has promised that arch-foe Iran will pay for its missile attack, while Tehran has said any retaliation would be met with vast destruction, raising fears of a wider war in the oilproducing region which could draw in the United States. The White House did not respond to a request for comment.Relations between Biden and Netanyahu have been tense, strained over the Israeli leader's handling of the war in Gaza and the conflict with Hezbollah.In "War," a book out next week, journalist Bob Woodward reports that Biden regularly accused Netanyahu of having no strategy, and shouted "Bibi, what the fuck?" at him in July, after Israeli strikes near Beirut and in Iran. Asked about the book, one US official familiar with the two leaders' past interactions said Biden has used sharp, direct, unfiltered and colorful language both with and about Netanyahu while in office.

Israel needs to urgently address 'catastrophic conditions' in Gaza, says ally US

US Ambassador to the UN Linda Thomas-Greenfield said that Israel needs to stop "intensifying suffering" by limiting aid deliveries in Gaza.

World Israel needs to address urgently "catastrophic conditions" among Palestinian civilians in the besieged Gaza Strip and stop "intensifying suffering" by limiting aid deliveries, its ally the United States told the UN Security Council on Wednesday.

Referring to reports of squalid conditions in south and central Gaza, US Ambassador to the UN Linda Thomas-Greenfield said: "These catastrophic conditions were predicted months ago, and yet, have still not been addressed. That must change, and now."The 15-member Security Council met over the humanitarian crisis a year after a deadly attack by Palestinian militants Hamas on southern Israel sparked the war in Gaza. Israel has since laid to waste much of the enclave and almost the entire population of 2.3 million has been displaced.

Israel says Hamas militants killed some 1,200 people on Oct. 7, 2023, while health authorities in Gaza say nearly 42,000 people have been killed so far during Israel's retaliation.homas-

Greenfield also addressed a recent Israeli order for civilians in Gaza's north to evacuate again, saying they must be able to return to communities to rebuild."There must be no demographic or territorial change in the Gaza Strip, including any actions that reduce the territory of Gaza, Thomas-Greenfield said.

Philippe Lazzarini, the head of the U.N. Palestinian refugee agency UNRWA, told the Security Council: "Hundreds of thousands of people are again being pushed



to move to the south, where living conditions are intolerable."Yet again, Gazans are teetering on the edge of a manmade famine," he said.NO **RESTRICTIONS**

The UN has long complained of obstacles to getting aid into Gaza and distributing it during the war.Reuters reported last week that food supplies to Gaza have fallen sharply in recent weeks because Israeli authorities have introduced a new customs rule on some humanitarian aid and are

separately scaling down deliveries organized by businesses.

We need to see fewer barriers to the delivery of aid, not more of them,' Thomas-Greenfield said.Israel's UN Ambassador Danny Danon defended his country's record: "Israel imposes no restrictions on humanitarian aid. In fact, 82% of all requests for humanitarian coordination have been approved and

He accused Hamas of diverting aid from those in Gaza who need it.Britain's UN Ambassador Barbara Woodward told the council that Israel "must do much more" to avoid civilian casualties and ensure the UN and aid groups can operate safely and effectively in Gaza."Delivery of humanitarian assistance is being hindered, and humanitarian workers are constantly under threat," French U.N. Ambassador Nicolas de Riviere said.

More than 2 million without power as Hurricane Milton slams Florida; causes deaths, flooding

TAMPA. Hurricane Milton plowed into Florida as a Category 3 storm Wednesday, bringing misery to a coast still ravaged by Helene, pounding cities with winds of over 100 mph (160 kph) after producing a barrage of tornadoes, but sparing Tampa a direct hit.

The storm tracked to the south in the final hours and made landfall in Siesta Key near Sarasota, about 70 miles (112 kilometers) south of Tampa. The situation in the Tampa area was still a major emergency as St. Petersburg recorded over 16 inches (41 centimeters) of rain, prompting the National Weather Service to warn of flash flooding.

Tropicana Field, the home of the Tampa Bay Rays in St. Petersburg, appeared to be badly damaged. Television images Wednesday night showed that the fabric that serves as the domed building's roof had been ripped to shreds. It was not immediately clear if there was damage inside the stadium. More than 2 million homes and businesses were without power in Florida, according to poweroutage.us, which tracks utility reports. The highest number of outages were in Hardee County, as well as neighboring Sarasota and Manatee counties.Before Milton even made landfall, tornadoes were touching down across the state. The Spanish Lakes Country Club near Fort Pierce, on Florida's Atlantic Coast, was hit particularly hard, with homes destroyed and some residents killed."We have lost some life," St. Lucie County Sheriff Keith Pearson told WPBF News, though he wouldn't say how many people were killed. About 125 homes

were destroyed before the hurricane came ashore, many of them mobile homes in communities for senior citizens, said Kevin Guthrie, the director of the Florida Division of Emergency Management. About 90 minutes after making landfall, Milton was downgraded to a Category 2 storm. By late Wednesday, the hurricane had maximum sustained winds of about 105 mph (165 kph) and storm surge warnings were in effect for parts of Florida's Gulf and Atlantic coastlines. Heavy rains were also likely to cause flooding inland along rivers and lakes as Milton traverses the Florida Peninsula as a hurricane, eventually to emerge in the Atlantic Ocean on Thursday. It is expected to impact the heavily populated Orlando area. The storm slammed into a region still

reeling two weeks after Hurricane Helene flooded streets and homes in western Florida and left at least 230 people dead across the South. In many places along the coast, municipalities raced to collect and dispose of debris before Milton's winds and storm surge could toss it around and compound any damage.Officials had issued dire warnings to flee or face grim odds of survival."This is it, folks," said Cathie Perkins, emergency management director in Pinellas County, which sits on the peninsula that forms Tampa Bay. "Those of you who were punched during Hurricane Helene, this is going to be a knockout. You need to get out, and you need to get out now."By late afternoon, some officials said the time had passed for such News box

57,325 applications filed for liquor shop licences

VIJAYAWADA. In all 57,325 applications for liquor shop licences have been received by the Prohibition and Excise Department netting Rs 1,146.6 crore towards non-refundable fee, even as the State government has extended the last date by two more days to October 11. The applications were originally scheduled to be received from October 1 to 9 but the date was extended following numerous requests from

An order was issued by the Excise Department Director Nishant Kumar extending both the last date of applications as well as extending the existing policy till October 15. "Applications are allowed till October 11 up to 7 pm, and verification process will be conducted on October 12 and 13," the order read. Excise officials anticipate that applications for liquor shops will flood following the deadline extension. "We are expecting more than 5,000 applications in the next two days, which will generate Rs 100 crore revenue," said an excise official.

According to official data, the notification regarding the issuance of licences for 3,396 liquor shops in the State attracted a staggering 57,325 applications so far and of the total shops, 10% were allotted to the toddy tappers community. Soon after the change of guard in the State with the TDP-led government forming the government, Chief Minister N Chandrababu Naidu announced that a new excise policy will be brought in instead of the government running liquor shops. Following the instructions of Naidu, Excise Minister Kollu Ravindra directed officials to formulate the policy by including some best practices being implemented in other States. According to data obtained from the Excise Department, NTR district topped the list by receiving 4,399 applications for 113 shops, followed by Eluru with 3,820 for 144 shops, Vizianagaram with 3,677 for 153 shops, and West Godavari with 3,490 for 170 shops. "A shop allocated to NTR 96 sector has received the highest number of 110 applications," according to the official

Incomplete building collapses, Two injured

DHENKANAL. At least two workers were critically injured after an under-construction five-storey building collapsed at Mahisapata on Wednesday afternoon.

The two workers who sustained critical injuries in the incident are Kailash Rout and Samarendra Rout of Khuntujhari village within Dhenkanal Sadar police limits. Police said, they were rescued from the debris and rushed to the district headquarters hospital. While unconfirmed reports stated a worker died in the incident, it was denied by the local administration. Sources said over 20 workers were engaged in the construction when the incident occurred. "It is unclear whether there are any casualties as the debris is still being cleared," said sub-collector Bibhudha Garnaik.

He, however, said more workers may still be trapped in the rubble. Fire personnel and other organisations are clearing the debris using machines. A probe will be conducted into the incident and whoever is found guilty will be dealt with as per law. Sources said the under-construction building is that of a hotel. Collector Somesh Upadhyay and SP Abhinav Sonkar who rushed to the spot said the rescue operation is still on and no efforts are being spared to clear the debris and rescue any other worker.

Dhenkanal MP Rudra Narayan Pany asked officials concerned to conduct a thorough inquiry into the incident and spare nobody if found guilty.

The Kancheepuram district police came down heavily on the protesting Samsung workers since midnight Tuesday, days after the government's attempt to persuade CITU to give up the protests failed. The police arrested 10 persons from their houses in Sunguvarchatram on Tuesday midnight, and later on Wednesday, detained 616 others who continued to protest even after police dismantled the temporary shed from where they had been protesting for the last month.

While eight persons were let off after the judicial magistrate refused to remand them, two others have been remanded in judicial custody, according to union members.Kancheepuram district secretary of CITU, E Muthukumar, told TNIE the protests will continue from Thursday at usual site near the Samsung plant with the court giving the nod for peaceful protests on Wednesday. According to CITU members, the Kancheepuram police went to the houses of 10 Samsung workers, who were also office-bearers of the union, at



midnight to arrest them. They allegedly refused to brief the family members on the charges against them. The police then proceeded to dismantle the temporary shed on a vacant private land they were protesting from.Police sources said the arrests were in connection with workers allegedly shoving an SSI, who came to the spot, after a load van in which a group of protesting Samsung workers were travelling in, fell sideways when the driver lost control of the overloaded vehicle.

The workers did not push the SSI or anyone else. The entire incident has been staged in order to keep the workers and us from protesting any further," Muthukumar

We have been constantly in touch with the owner of the land where the protest is happening and he has no complaints with the protest continuing. This is not an illegal protest. We have done everything by the book, including issuing a strike notice to Samsung," he added.Union members also said the police began the crackdown on workers

from Tuesday when they began checking private vehicles, including buses, for those wearing the Samsung uniform to ask them their names, identity cards and details of where they were heading to.Despite this, workers began arriving at the protest site on Wednesday morning and continued the agitation even as it rained heavily until 616 protesting workers and union members, including CITU state president A Soundararajan, were detained. They were let off later in the day. Speaking to media, Soundararajan alleged that the state government has been a mute spectator to the police excess.

ROURKELA. In a relief for travellers on Bhubaneswar-Rourkela-Kolkata route during the festive season, Alliance Air Aviation Ltd (AAAL) has reportedly arranged an alternate ATR-72 aircraft to prevent flight cancellations.

On Tuesday afternoon, the existing ATR-72 aircraft met with a minor mishap at Bhubaneswar airport during landing. The mishap rendered the aircraft unfit to fly for at least one month. Sources in Airports Authority of India (AAI) informed the tail of the aircraft from Rourkela hit one of the approach lights while landing in Bhubaneswar. While no passenger was hurt, the aircraft's tail was damaged in the incident. As the aircraft remains grounded at Bhubaneswar airport, a team of Directorate General of Civil Aviation (DGCA) has initiated investigation to ascertain the circumstances and reason of the incident and the extent of damage to the aircraft. Even after the damaged portion of the aircraft is repaired, it may take at least a month to resume flight services on the route after necessary clearance from DGCA.

While AAAL had officially announced cancellation of the flight on the route only for Wednesday, there were enough indications of more such cancellations. However, despite AAAL facing acute scarcity of ATR-72 aircraft it was forced to urgently draft an aircraft from another route to prevent flight cancellations during the festive season when all tickets are already booked.

A frequent flier and former general secretary of Steel Executives' Federation of India (SEFI) Bimal Kumar Bisi on Tuesday sent an urgent request to acting CEO of AAAL Ram Babu to arrange an alternate aircraft to avoid cancellation of flight for a long period citing the festive season.

Bisi on the day quoting the CEO of AAAL said another ATR-72 type aircraft has been drafted from a different sector to cater to the need of the Bhubaneswar-Rourkela-Kolkata sector. He said the immediate intervention of Union Tribal Affairs minister Jual Oram was crucial.

Indianise certainly, but also demystify defence

THREE weeks in London were invigorating. I visited Royal United Services Institute, the International Institute of Strategic Studies, Chatham House and Policy Exchange, among several think tanks, and the Royal College of Defence Studies, where I studied — to simply imbibe the new flavours of the land. Each new prime minister or government orders a strategic defence review (SDR), the last being done in 2015. It is updated periodically with an integrated review, which was done in 2021, followed by a defence, development and foreign policy review in 2023. Capability and spending reviews are interspersed, ensuring targets are met and there are no surprises. In July, the new Labour government ordered a root and branch review of the SDR, which will deliver its report before July 2025. The spending review has found a hole of GBP 3.9 billion, which the government has pledged to meet by raising taxes in the budget due on October 30. Whether Labour or Tory, defence spending enjoys rare consistency, with a target of 2.5 per cent of the GDP, which, at present, is 2.3 per cent.Lord Karan Bilimoria, whom I met, has advocated in Parliament since 2019 that the UK should spend 3 per cent of the GDP on defence. He told the Peers that the term Indo-Pacific, for which there is a minister now, was coined by Policy Exchange, of which he is a trustee. Our Navy's Capt Vijay Sakhuja, with the Kalinga International Foundation, had claimed to have invented it. Bilimoria told Parliament that Britain must upgrade relations with India, the emerging power centre, and apologise for its 'monstrous act' in Jallianwala Bagh. Britain has a smallsized military, but it fields state-of-the-art equipment. Robust debates on defence are held in both Houses of Parliament and the media. Its Strategic Nuclear Force, operational since 1962, is reliant solely on Continuous at Sea Deterrence (CASD). The debate in the UK is over a backup second delivery system of the other two legs of the Triad - aircraft or land-based - and maintaining 180-200 nuclear ballistic missiles of its Credible Minimum Deterrent.

India's military is rapidly modernising. But it is also focused on dismantling the colonial legacy, as directed by PM Modi in 2021, and replacing it with Indian political strategic culture and indigenisation.So, the Vivekanand Foundation begins its programmes by invoking Hindu gods. The Indian Navy has introduced kurta pajama as its mess kit. The Army is engaged in collating pearls of ancient Indian wisdom from the Gita, Panchatantra, Arthashastra, Chanakya Neeti and Thirukkural.But absent are modern defence planning and budgetary fiscal and defence allocation as a percentage of the GDP, like 3 per cent recommended by several Standing Committees on Defence. The annual defence budgets are, predictably, the previous year's budget allocation plus inflation and, sometimes, less than the Revised Estimates.

An SDR has never been done nor have capability and spending reviews been done. Still, often, defence forces are unable to spend the meagre moneys allotted for modernisation. There is no documented National Security Strategy (NSS), which the CDS, Anil Chauhan, says is not needed, making India the only democracy with no NSS.No parliamentary debate has been permitted on the China threat despite intrusions and loss of territory over the past five years and two books by former Army Chiefs have been blocked as they are critical of the government.

With the fifth largest economy (it just surpassed that of the UK) and the third biggest standing military, India's defence spending was less than 2 per cent in 2024-25 despite multiple and collusive threats. The UK, with the 11th largest military, will spend nearly 2.5 per cent of the GDP with comparably less substantial threats.

While the UK will not let its deterrent blunt, Indian political leaders believe there will be no war: 'Not an era of war; we are the land of Buddha, not yuddh."So, the Agniveer scheme was imposed to reduce manpower and pension costs in the guise of having a youthful Army, which former Army and Navy Chiefs have decried. So was 'atmanirbharata', about which the late CDS.

Unlock India-Canada economic potential via CEPA

The unexploited potential of trade between India and Canada amounts to as much as 50 per cent of the present level.

Interdependence of countries is the order of the day. The scale of dependence has converted the world into a global village. Communication technology has reduced distances. Intercountry flows of goods, services and financial transfers has integrated the world at a level never seen before. There is a specificity to the development of partnership between Canada and India. This is expressed in terms of a large Indian diaspora in Canada. This diaspora is integrated in the Canadian society and is active, socially and politically. Some of them have done very well economically and are interested in developing their ancestral land. The formation of the World Trade Organisation in 1995 formalised the framework of global economic integration. Since then, the scale of economic exchanges between countries has increased and given a fillip to the rise of emerging economies. India is one of the beneficiaries of globalisation. As of 2023, India's economy reached \$3.57 trillion (3.40 per cent of the global GDP), while Canada's stood at \$2.14 trillion (2.03 per cent). Both are market-oriented economies wellintegrated into global trade networks, with a total recorded bilateral trade of \$7.55 billion in 2023. This trade includes \$3.77 billion in Indian exports to Canada and \$3.78 billion in imports. These figures, while significant, represent a smaller portion of the global trade compared to the two countries' combined economic contributions. However, in percentage terms, the trade between the two big economies is much lower than their share in the global income. At an aggregate level, the trade between the two countries should be equal to their average share of income in the global economy. This average works out to be 2.72 per cent, but actual trade is less than 2 per cent. This means that the unexploited potential of trade between India and Canada amounts to as much as 50 per cent of the present level. This potential expansion could be facilitated by India's substantial diaspora in Canada, which provides a strong base for trade in goods and services that cater to the Indian community's cultural preferences. The Census data of 2021 shows that migrants from India constitute 3.6 per cent of Canada's population. If children born to Indian migrants in Canada are included, the population with Indian ancestry rises to 5.1 per cent. This population continues to follow Indian food patterns, with a large component of items imported from India or other South Asian countries. They include long grain rice (basmati), spices, clothes, jewelry etc. The Indian diaspora also continues to maintain close contacts with the people and places of their origin. This foundation of demand underscores the untapped trade potential, yet there are challenges to address for these opportunities to be fully



grow, it is crucial to overcome certain trade barriers. In a competitive world, the countries must compete with their rival suppliers to access their respective markets. This requires each country's producers to improve efficiency and product quality continually. Moreover, sufficient surplus products must be available to meet each other's demands. Overcoming these economic barriers involves addressing non-economic challenges, such as regulatory and policy constraints. On the Indian side, the supply of agricultural goods such as long grain rice or coarse grains, vegetables, fruits or dairy products must be free from pesticide residues and preferably produced by organic farming. Since the distance between the two countries is long, perishable items have to be transported through refrigerated containers or cold supply chains. This would require a lot of investment to improve production, storage and transport technology to access the Canadian market. Given the present level of dynamism of development, India can achieve this in the near future. This can enable Canada to break the monopoly of California in the supply of fruits and vegetables. Another area in which India has the capacity and advantage in price and quality is the service sector. In software technology, India has established itself in the world, but the presence of Indian software companies in Canada is not sufficient. The export of pharmaceutical products is only at the level of telemedicine or testrelated services. India can improve her position in Canada in this field. There is a lot of pressure on medical services in Canada. India can help in easing it through medical tourism. The current list of exports from India comprises consumer goods such as jewelry, worked diamond, long grain rice etc. The other goods are

chemicals, plastic, rubber, metallic and non-metallic minerals. The scale of the existing exports from India can be raised and more goods and services added to the list.Similarly, the Canadian list of exports to India can be enlarged. The present list of exports from Canada to India includes metallic and non-metallic minerals, farm products, fishing food and energy products. Nearly half of the Indian imports of lintels come from Canada.Further economic cooperation between Canada and India can be supported through increased Canadian investments in Indian manufacturing, aimed at producing goods and services for export. Additionally, increasing daily flights between Indian and Canadian cities would support business travel and cultural exchange, further enhancing trade and investment opportunities.It is a question of increasing economic cooperation between the two countries for mutual benefits. To expand partnerships, both the countries must be on board. The diplomatic hurdles that cropped up a couple of years back, involving citizens in the breach of safety and security of the two countries, must be cleared.Similarly, a large number of Indian students studying in Canada are facing problems due to changes in its migration policies. With the resolution of these issues, the two countries can take economic relations to greater heights. India and Canada must resume negotiations to discuss the Comprehensive Economic Partnership Agreement (CEPA) to expand and achieve the full potentials of trade and investment. The two countries have differences in factor endowment: there is an abundance of young and skilled population in India while Canada has scarcity of labour. Both the countries fall in different climatic zones, which creates complementarity

J&K's clear verdict

Mandate for NC-Cong signals a fresh start

JAMMU and Kashmir has spoken, and in no uncertain terms. The decisive victory of the National Conference-Congress alliance marks a new beginning for the five-year-old Union Territory. Getting a chance to have their say in the Assembly elections after 10 years, the voters have chosen stability over a fractured mandate. The prospects of detested political manipulations in case of a hung House have been rejected. A clear majority also puts paid to the controversy over the nomination of five legislators — who have voting rights — by the Lieutenant-Governor. Now begins the real test for the winning alliance and the Centre - how to negotiate the handover and exercise of power. Equally important is building trust, and the onus for it is on these two entities. A confrontational start would amount to sheer

disrespect of the people's verdict. In Jammu and Kashmir, the residue of past events informs the present to a great



extent. The trauma of violence, the regional divide, the communal tensions, the perceived sense of injustice and a heightened notion of victimhood - it's been tough going for the erstwhile state. After a long time, the spectre of poll boycott and contempt for the electoral process has been lifted. Voters' enthusiastic participation in the election campaign lends

The new government, thus, has the added responsibility of grasping the message sent by the electorate - shift the focus from political wrangling to what the people really want, improve their lives and give them the agency they deserve. The NC-Congress alliance is not new to holding the reins of power, but it must recognise the altered reality. There is no room for a repetition of mistakes. The restoration of statehood may be a legitimate demand, but

it must to look beyond the rhetoric and work for social cohesion and economic prosperity.

Rahul's missteps & BJP's gains

Setbacks in Haryana and J&K signal tough road ahead for Congress

THE outcome of the Haryana Assembly polls has enhanced Prime Minister Narendra Modi's stature and the BJP's standing within the NDA. On the other hand, the Rahul Gandhi-led Congress will find making seat adjustments in Maharashtra and Jharkhand more challenging than before. Both the Congress and the BJP suffered setbacks in Haryana and Jammu & Kashmir, as the election results did not meet their expectations, but there is greater dismay in the grand old party. The Congress campaign in Haryana went horribly wrong due to Rahul Gandhi's overconfidence. He chose to travel to the USA amid electioneering, relied heavily on regional satrap Bhupinder Singh Hooda, and delegated ticket distribution to inhouse pollster Sunil Kanugolu, Kanugolu, who enjoys Rahul's support, overruled Bhupinder Hooda, Selja and AICC general secretary Deepak Babaria in ticket allocation. Until the last night of the campaign, Kanugolu was asserting that the party would cross the 60-seat mark. Former pollster Yogendra Yadav had also made Rahul believe the tally would reach 60 or higher. Multiple inhouse surveys had predicted a Congress landslide in Haryana and Kanugolu micromanaged the entire communication campaign thereFor the BJP, J&K has been a setback as it failed to stop the National Conference-Congress alliance. Prime Minister Narendra Modi and J&K

Lt Governor Manoj Sinha now face a demanding state government seeking full statehood and various concessions, which have the potential to strain Centre-state ties. For the BJP, a hung Assembly with a chief minister from the Jammu region would have been ideal. However, National Conference leader

Farooq Abdullah quickly understood the BJP's strategy of fielding proxies. The NC did what it does best - working on ground, fielding Omar Abdullah in two constituencies, and performing impressively even after the Assembly segments were significantly altered during delimitation.

While the Abdullahs managed their campaign with ease and confidence, Rahul could not achieve the same in Haryana. He remained diffident and his rhetoric of "Kisan, Jawan, Pehalwan" seemed uninspired. Attacks on Modi and the Central Government did not resonate and Dalits, who united against Bhupinder Hooda. When Selja, the state PCC chief, expressed her displeasure for two weeks, Rahul did not adopt a hands-on approach. Instead, he relied on a group comprising TS Singh Deo, Ajay Makan and Mallikarjun Kharge to act as peacemakers. The BJP, wary of Rahul's effective campaign during the Lok Sabha elections on Dalit reservation insecurity, swung into action. The RSS cadre capitalised on Rahul's statement

that reservations would end with a 100 per cent quota based on a caste census. This narrative of Rahul seeking to end reservations was effectively amplified on social media. Rahul's focus on a caste census and caste-based reservation was high on rhetoric but lacked the necessary support. In his team and the AICC secretariat, the Yadavs are dominant, while other OBC representatives are largely absent. Rahul was frequently accompanied There is an additional headache for the Congress and by Ajay Yadav, Anil Yadav, Subhashini Yadav and Yogendra Yadav. This created a sense of exclusion among other OBC and Dalit leaders. The Congress has a big problem in hand now. After Madhya Pradesh, Rajasthan and Chhattisgarh, this is the



fourth time that a regional satrap has failed and faltered. Kamal Nath was given a free hand in November 2023. As in Haryana now, many pollsters, opinion makers and inhouse surveys had predicted a Congress victory then, but the party was routed. There was a similar story in Chhattisgarh, where Bhupesh Baghel led the Congress to a defeat, and in Rajasthan, where Ashok Gehlot kept claiming that he would win.

Rahul within the INDIA grouping. Several alliance partners - namely, Udhav Thackeray, Arvind Kejriwal and Omar Abdullah - have begun taunting the Congress, attributing the Haryana defeat to its 'overconfidence'. Mamata Banerjee and

Akhilesh Yadav are likely to join the bandwagon of restless allies.

Rahul will now be under pressure to advance the INDIA alliance story instead of focusing on his own party's revival. Maharashtra would be a litmus test for Rahul and the grand old party.

Once specific aspect of the results would gladden hearts in the BJP — after the Lok Sabha polls, the RSS significantly backed the BJP in Haryana and the Jammu region. The RSS appears to have realised that it depends on Modi and the BJP for survival. During the 2024 Lok Sabha elections, reports suggested that the RSS and BJP had differed on some issues. BJP insiders attach significant weight to RSS Sarsanghchalak Mohan Bhagwat's recent call for Hindu unity. If the RSS indeed supported Modi in Haryana, it is likely that

similar backing will extend to Maharashtra.In Kashmir, the National Conference benefited significantly from the anti-PDP and anti-BJP sentiment. The NC gained largely due to the previous PDP-BJP alliance, especially after Ram Madhav was appointed as the point man. Madhav had earlier worked out the PDP-BJP alliance that had seen Mufti Mohammad Sayeed becoming chief minister.

Dalit man assaulted, urinated upon for demanding wages in Bihar

A Dalit man was thrashed, abused and urinated upon by a father-son duo after he had demanded his wages for the work he did at a poultry farm in Bihar's Muzaffarpur district.

New Delhi: A Dalit man in Bihar's Muzaffarpur district was thrashed, spat on his face and urinated upon by a father-son duo for demanding his pending wages for the work he did at a poultry farm. The incident occurred on October 4 when the man, Rinku Manjhi, went to the poultry farm of the accused, Ramesh Patel, demanding wages for the two days of work that he did, according to the victim's complaint.Infuriated over his wage demand, Rinku was thrashed by Ramesh Patel, his brother Arun Patel and his son Gaurav Kumar, the complaint said, adding that Ramesh Patel and his son Gaurav Kumar also urinated upon the victim and they also spat on his face.



A video of the incident was shared by Rinku Manjhi with the police as evidence against the accused in his complaint that was filed on October 8. Upon receiving the complaint, a case was registered against the accused under relevant sections of the Bharatiya Nyaya Sanhita (BNS) and SC/ST Act, and an investigation was launched into the matter.

Speaking about the incident, Muzzafarpur's Superintendent of Police (Rural), Vidha Sagar said, "A daily wage worker was abused with casteist slurs by Ramesh Patel, who lives in

Caffeine addiction

Telcos' ARPU rises to Rs 157.45 in June quarter

NEW DELHI. The average revenue per user (ARPU) of telecom service providers in India increased by 2.55% to Rs 157.45 in the June quarter of 2024, according to the Telecom Regulatory Authority of India (TRAI).

The TRAI's Indian Telecom Services Performance Indicators report shows ARPU of all telecom operators rose from Rs 153.54 in March 2024 to Rs 157.45 in the quarter. ARPU measures how much money telecom service providers such as Reliance Jio, Bharti Airtel, and Vodafone Idea Limited (VIL) earn from each customer per month.

The ARPU saw a significant annual growth, up 8.11% in June quarter as against the same period last year. Both prepaid and postpaid ARPU saw increases, with prepaid ARPU rising from Rs 150.74 in March 2024 to Rs 154.80 in June 2024. Postpaid ARPU rose from Rs



187.85 to Rs 189.17 in the quarter.

In terms of ARPU, Airtel reported the highest at Rs 211, followed by Jio at Rs 181.70, while VIL had the lowest ARPU of Rs 146 in the quarter. Regarding revenue, the gross revenue (GR) of the telecom service sector for June was Rs 86,031 crore, a fall of 2.16% as against the previous quarter. The Applicable Gross Revenue (ApGR) fell by 1.02% to Rs 83,087 crore, while the adjusted gross revenue (AGR) increased by 0.13% to Rs. 70.555 crore.

The report also noted that the overall Minutes of Usage (MOU) per subscriber per month declined by 2.16%. from 995 in March 2024 to 974 in June 2024. Prepaid MOU per subscriber stood at 1,010, while postpaid MOU per subscriber was 539 in the June quarter.

Star health data hack: More than 3 crore customers' information up for sale online

BENGALURU. A hacker claims to have data of over 31 million customers of Star Health Insurance and that it is available for sale at \$150,000. On Wednesday, customers of the insurance company were shocked as a hacker identified as xenZen claims to have all details of customers including date of birth, phone number, PAN Card, among other details.

The insurance company in a statement to TNIE acknowledged that they were the victim of a targeting malicious cyberattack, resulting in unauthorised and



illegal access to certain data.

"We make it absolutely clear that our operations remain unaffected, and all services continue without disruption. A thorough and rigorous forensic investigation, led by independent cybersecurity experts is underway, and we are working closely with government and regulatory authorities at every stage of this investigation, including by duly reporting the incident to the insurance and cybersecurity regulatory authorities apart from filing a criminal complaint," the statement added.

The issue opens on October 15. Employees have a Rs 186 discount apiece from the declared price band. While at the upper end of price band, the company will raise Rs 27,870 crore, making it the largest-ever IPO, breaking record set by LIC in May 2022, raising Rs 23,000 crore. At the upper-end the company is commanding a premium of 159x.

Also, investors should learn from the growth of the Tata empire that a long-term investment horizon is required to really participate in the wealth creation that happens through the capital market. In a bull market like the present one, there will always be valuation concerns. But great companies like the ones Ratan Tata built will create wealth for investors in the long run," he added

War on inflation is almost won: RBI **Governor Das**



MUMBAI. The Reserve Bank on Wednesday retained the retail inflation projection at 4.5% for fiscal 2025, with Governor Shaktikanta Das stressing that the central bank will have to closely monitor the price situation given the rising risks to imported inflation as crude prices have vaulted over 18% in the past one week following the flare up war between Israel and Iran.Das offered some banter to the press when he quipped, in response to a media query, as to how the inflation description has moved from 'a wild elephant' till recently to a 'nearly tamed horse', saying "in a war, both elephants and horses are used and that if needed the RBI will deploy again the arsenals from Arjuna to sharpen its attack and focus.'

When inflation was sticky for long and sticking around in double-digit, Das used to repeatedly say that the RBI MPC will not rest till the elephant is sent back to forest and ensured that the wily animal remains there for a durable time so that the economy grows at a higher pace sustainably longer. However, the RBI monetary policy committee (MPC) retained the CPI projection for FY25 at 4.5%, with Q2 at 4.1%; Q3 at 4.8%; and Q4 at 4.2%. CPI inflation for Q1FY26 is projected at 4.3%. Unveiling the bimonthly monetary policy, the governor said the flexible inflation targeting (FIT) framework, which has completed eight years since its introduction in September 2016, is a major structural reform of the 21st century India.Under FIT, the RBI has ensured that the consumer price index (CPI) based retail inflation remains at 4% with a margin of 2% on either side. "The CPI print for September is expected to see a big jump due to unfavourable base effects and pick-up in food price momentum, caused by the lingering effects of a shortfall in the production of onion, potato and gram in FY24, among other factors," Das said.

He added that the headline inflation trajectory, however, is projected to sequentially moderate in Q4FY25 due to good kharif harvest, ample buffer stocks of cereals and a likely good crop in the ensuing rabi season. Unexpected weather events and worsening of geopolitical conflicts constitute major upside risks to inflation. International crude oil prices have become volatile in October, Das added.

Country's mango export now tastes global success

THIRUVANANTHAPURAM: Mango export in India has made huge

strides by utilising radiation processing to meet international phytosanitary standards, particularly for markets like the USA. After resuming exports in 2007, India has seen steady growth with shipments reaching 2,500 tonnes in 2023 and 3,000 tonnes in 2024. India resumed mango exports in 2007 after an 18year break, following the commissioning of the KRUSHAK irradiation facility. In 2006, KRUSHAK was upgraded to quarantine treat mangoes, and received approval from the USDA for exporting Indian mangoes to the USA. Though Andhra Pradesh, Uttar Pradesh, Karnataka, Bihar, Gujarat and Tamil Nadu produce mangoes, export is mostly made from Maharashtra and Gujarat.A total of 28 food irradiation plants are there in India. The Maharashtra State Agricultural Marketing Board (MSAMB) has leased KRUSHAK to irradiate mangoes, onions, spices,



and food grain. This treatment ensures mangoes are free from pests, allowing them to meet the phytosanitary requirements of many countries. It also increases the shelf life and the ability to supply highquality, irradiated fruit. According to data from BARC, India's mango exports have shown steady growth since 2007 when 157 tonnes were exported to the US. The numbers climbed consistently, with 1,150 tonnes exported by 2017, 2,500 tons in 2023, and projections reaching 3,000 tonnes by 2024."This shows the increasing global demand for Indian mangoes and the success of

radiation processing in meeting international quality standards, said P A Hassan, scientist and associate director of bio science group at Homi Bhabha National Institute. The US has been a major importer of Indian mangoes since 2007, and India has successfully made it into other markets as well. Australia joined the list of export destinations in 2017, Malaysia in 2022, and South Africa more recently

in 2023. India's mango export industry marked another milestone last year with its first successful searoute shipment to the US. Utilising BARC-developed Standard Operating Procedures (SOPs) and radiation-treated mangoes, 16 tonnes of the fruit were shipped and it reached the USA in 25 days. The shift from air to sea-route exports has brought many advantages for stakeholders. The cost of sea shipping is just one-eighth of air freight, drastically reducing the overall costs of export. Also, the sea route allows for larger shipments.
