New Delhi, Oct 15: The Assembly polls in Maharashtra will be held in a single phase on November 20, while the Jharkhand polls will be held in two phases on November 13 and 20, the Election Commission of India announced on Tuesday. "There are 9.63 crore eligible voters in Maharashtra, while the number of eligible voters in Jharkhand is 2.6 crore," Chief Election Commissioner Rajiv Kumar said at a press conference here. Bypolls will also be held in 48 assembly seats and two Lok Sabha seats, the CEC said. Bypolls to the Kedarnath assembly seat in Uttarakhand and the Nanded Lok Sabha seat in Maharashtra will be held on November 20. Bypolls to the Basirhat Lok Sabha seat in West Bengal and Milkipur in Uttar Pradesh were not announced as election petitions are pending for the two seats. Kumar said elections will be held in both the states on Wednesdays to address the problem of urban apa-



Maharashtra polls: Why is it a survival test for Sharad Pawar, Uddhav Thackeray

Mumbai, Oct 15: Both Sharad Pawar and Uddhav Thackerav have endured testing times after their respective parties NCP and Shiv Sena were split in the last two years. Maharashtra will vote in a single phase election to its 288-mem-

ber assembly on November 20, Election Commission the announced. The upcoming election is a direct contest between the ruling Mahayuti coalition and the opposition Maha Vikas Aghadi (MVA) bloc. The electoral battle is a tough test for the Bharatiya Janata Party (BJP) and its ruling allies Shiv Sena and Nationalist Congress Party (NCP). But the election won't easy for the opposition MVA, which scripted a stupendous performance in the Lok Sabha elec-

tions. All eyes are on two leaders, who are facing a survival test this autumn. Sharad Pawar and Uddhav Thackeray. Both the regional satraps have endured testing times after their

respective parties NCP and Shiv Sena were split in the last two years. It is now or never for these two netas as the Maharashtra elections will determine their future. Just three days before the assembly elections in the state in 2019, Sharad Pawar braved heavy rain while addressing a rally in Satara. Many believed that the



Maratha strongman's political career. In the general elections held that year, the NCP had won just four seats and the political pundits had

October 2019 as Sharad Pawar emerged as the kingmaker and architect of the MVA. He was instrumental in stitching an alliance comprising Shiv Sena, Congress and his party NCP. He thwarted a near-successful coup by his nephew Ajit Pawar, who took oath as the deputy chief minister in Devendra Fadnavis's short-lived government. In May last year, Pawar shocked everyone by announcing his decision to step down as NCP chief. However, he withdrew his decision days later. But he did not know what lay in store for him. His ambitious nephew Ajit successfully split the party the veteran leader had formed after being expelled from the Congress in 1999. Ajit Pawar is currently the deputy to chief minister Eknath Shinde. Earlier this year, the Election Commission recognised Ajit Pawar's faction as the real NCP. However, the party could win just one seat in the Lok Sabha elections. If the NCP (SP) under 83-yearold Pawar pulls off an exceptional performance, it would bolster his morale in reclaiming the party he had founded. In 2019, Uddhav Thackeray walked out of the NDA over the issue of rotational chief ministership after the Maharashtra assembly elections.

UP bypolls on Nov 13; SP questions 'delaying elections' in Milkipur

Lucknow, Oct 15: The Election Commission of India on Tuesday announced that the bypolls to nine out of the ten vacant assembly seats in Uttar Pradesh will take place on November 13. The only constituency left out is the Milkipur assembly seat in Ayodhya, sparking a political war of words between the opposition and ruling Bharatiya Janata Party (BJP). The Samajwadi Party, shortly after the poll schedule was announced, alleged that the BJP is trying to "stall" the bypolls in the Milkipur seat as it was "afraid" of its defeat in Ayodhya. The assembly seats where bye-elections will be held are Katehari, Karhal, Meerapur, Kundarki, Phulpur, Sisamau, Ghaziabad, Majhawan and Kahir. However, the polls in Milkipur were not announced by the ECI as an election petition is pending in the high court against the candidate who had won the seat earlier. In a veiled jibe at the BJP, SP president Akhilesh Yadav posted on X, "Whoever has postponed the war, consider that he has lost the war." SP spokesperson Anurag Bhadauria said, "When election is being held on nine seats, why it can't be held on

the 10th seat - Milkipur. What report the state government has given to the EC. It should be made clear." SP leader Awadhesh Prasad, who won from the Faizabad seat in the 2024 Lok Sabha elections, told ANI, "Samajwadi Party is confident that we will win all the nine seats (in UP bypolls). I resigned from the Milkipur seat on June 12 and this seat was vacant. BJP has understood that they will lose the election and Samajwadi Party will win with majority.

That is why they have delayed the election." However, the Bharatiya Janata Party defended the EC's decision to not announcing the polls in Milkipur, saying that the petition filed in court by two candidates from the seat has not been disposed yet. BJP spokesperson Harischandra Srivastava told PTI, "The licence of the person who got the notary done in the nomination filed by SP's Awadhesh Prasad, who won Milkipur in the 2022 assembly elections, was revoked five years ago. Against this, two candidates Gorakhnath and Ram Murti had filed a petition in the court, which has not been disposed of yet. That is why bypoll was not declared on this seat."

Baba Siddique murder: 1 more person held

Mumbai, Oct 15: The Mumbai police have arrested one more person in connection with the killing of NCP leader Baba Siddique, officials said on Tuesday. Harishkumar Balakram (23), hailing from Bahraich in Uttar Pradesh was involved in providing money and other logistical support to the shooters, an official said. Balakram worked as a scrap dealer in Warje area of Maharashtra's Pune, he said. A crime branch team apprehended him from Bahraich on Monday and brought him to Mumbai on Tuesday morning, the official said. With this, four persons have so far been arrested in connection with Siddique's killing. Police had earlier arrested Haryana resident Gurmail Baljit Singh (23), Uttar Pradesh native Dharmaraj Rajesh Kashyap (19), both alleged shooters, and 'co-conspirator' Pravin Lonkar from Pune. Another suspected shooter, Shivkumar Gautam, who hails from Bahraich, is on the run. Balakram, along with Kashyap, Gautam, Pravin Lonkar and the latter's brother Shubham Lonkar, was part of the conspiracy to kill three-time MLA Baba Siddique, the official said. Baba Siddique (66) was waylaid by three persons in Mumbai's Nirmal Nagar area, just outside his MLA son Zeeshan Siddique's office, and shot at on Saturday night.

V-P Dhankhar warns of 'demographic

New Delhi, Oct 15: Echoing the sentiments recently expressed by RSS chief Mohan Bhagwat, Vice-President Jagdeep Dhankhar on Tuesday expressed deep concerns over the growing threat of demographic disorder in the country. "Demographic disorder is no less severe in consequences than a nuclear bomb," he said. Addressing the gathering as the chief guest at the inaugural session of the International Conference for CA members at Birla Auditorium, Jaipur, Vice-President Dhankhar said, "Demographic dislocation is turning certain regions into political fortresses, where elections have no real meaning. It is alarming to see how some areas have been affected by this strategic



shift, turning them into impenetrable strongholds where democracy loses its essence." He elaborated on the broader implications of this issue for India's future, stating that Bharat must remain a stabilising global force. "This force has to emerge. This century has to belong to Bharat and that will be good for humanity, that will contribute to peace and harmony on the planet. However, it would be a disservice to the nation if we turn a blind eye to the dangers of demographic upheavals that are taking place in this country," the VP warned. He said organic, natural demographic change is never upsetting but a demographic change brought about in a strategic manner to achieve an object offers a scene that is frightening. The Vice-President underscored that analysing this demographic shift over the last few decades reveals a disturbing pattern that offers a challenge to our values, to our civilizational ethos, to our democracy. "If this alarmingly worrisome challenge is not addressed systematically, it would escalate into an existential threat for the nation. It has happened in the world. I need not name countries that have lost their identity 100 percent because of this demographic disorder, demographic earthquake," he said. Vice-President Dhankhar stressed the need for preserving the inclusivity that defines Bharat, saying, 'We as a majority are all embracing.

Kolkata horror: SC questions West Bengal govt over 'unverified' civil volunteers working with state police

New Delhi, Oct 15: Expressing apprehensions over political patronage given to unverified civil volunteers working with the West Bengal Police, the Supreme Court on Tuesday directed the state government to disclose details of the process of recruitment for hiring them. "This is a nice way to confer political patronage on selected individuals who are totally unverified," a Bench led by Chief Justice of India DY Chandrachud said during hearing on a suo motu case initiated by the top court on the rape and murder of a trainee doctor at the RG Kar Medical College and Hospital, Kolkata, on August 9 that triggered nationwide outrage and protests. "Who recruits these civic volunteers? We need to know what their qualifications are. We need to know that such volunteers do not operate in hospitals, schools which are

sensitive in nature," it said, directing the West Bengal Government to furnish details on their recruitment. The top court asked the West Bengal Government to file

an affidavit detailing the legal source of authority for recruitment of civic volunteers; the modalities for their recruitment; the qualifications prescribed; verifications carried out before the recruitment; institutions where they were assigned duties;

payments made to them on a daily/monthly basis; and the budget outlay. The Bench asked the state government to give details on the steps taken to

ensure that the civil volunteers did not operate in particularly vulnerable and sensitive establishments such as hospitals and schools and sought to know the number of civic volunteers involved in police stations and crime investigation. Senior advocate Rakesh Dwivedi, representing the West Bengal Government, submitted that security staff at hospitals was recruited as per norms prescribed under the Private Security Agencies (Regulation) Act, 2005. The order

came after senior advocate Karuna Nundy submitted on behalf of a doctors' body that the state government's 'Ratire Sathi' initiative to protect women working at night shifts was fraught with serious consequences as it involved civic volunteers.

Citing the Salwa Judum case verdict (2011) in which the top court had disapproved of giving arms and police powers to private individuals, she said around 1,500 such civil volunteers were working in West Bengal. On behalf of the victim's parents, advocate Vrinda Grover pointed out that accused Sanjay Roy was also a volunteer having criminal civil antecedents who had access to a police vehicle registered in the name of Kolkata Police Commissioner. Expressing dissatisfaction over the tardy pace at which the National Task Force (NTF), constituted by it to formulate a protocol for ensuring the safety and security of doctors and other health care professionals was working, the Bench asked it to expedite its work. The Bench was surprised to know that the NTF had not held any meetings since September 9. Its first meeting was held on August 27. "What has the task force done after September 9? Why no meetings after September 9?

Slice of justice: Man's legal battle over 24 paise ends with 1k fine

- Ahmedabad. What started as a fight for 24 paise spiralled into a hefty Rs 1,000 fine! A man took a local pizza chain to court, alleging he had been overcharged by just a fraction of a rupee under the pretext of rounding off the bill. However, the consumer commission did not share his sense of outrage. Calling the case a "mockery of justice" and a waste of its time, the commission slapped him with a penalty. Patel's fight for pocket change ended up costing him dearly.
- Prashant Patel from Detroj-Rampura village took legal action after visiting a pizzeria on Jan 10 this year. The eatery presented him with a bill of Rs 665 for pizza and soft drinks, but Patel argued that the actual amount should have been Rs 664.76 after applying a discount and GST. Patel objected to the extra 24 paise, which he believed was overcharging. He was told that his complaint would be conveyed to the management and he would receive a message regarding the issue or refunded the excess if he had been charged wrongfully or by mistake.

When the restaurant did not respond, he escalated the issue to the Consumer Dispute Redressal Commission in Gandhinagar. The complainant submitted that under the pretext of rounding off the final amount, the restaurant charged more from its customers, revealing its intention to earn more. He argued that it should be fined heavily to stop it from duping its customers.

Pettah-Thiruvananthapuram's commercial centre of yore

THIRUVANANTHAPURAM.

Once a happening town of merchants, Pettah was the main gateway to the city of Thiruvananthapuram. Its strategic coastal location and proximity to the renowned Padmanabhaswamy Temple made it a favoured destination for traders and pilgrims alike.

The Kotte Heritage Foundation, dedicated to restoring the ancient capital of the Sinhalese kingdom of Kotte in Sri Lanka, throws light on the historical significance of the name 'Pettah.' This term, an Anglo-Indian adaptation of the Tamil word 'pettai,' was introduced by the British and referred to areas identified by the Dutch as the 'oude stad' or old town. The Pettah market in Colombo, however, has long been a hub for trade, even during the Dutch era. After that, this term might have been shared by several



markets including the one in Thiruvananthapuram.

There were two major markets in Thiruvananthapuram one is Ananthapuri Pettah and another one is Thirumadhura Pettah," explains historian Malayinkeezh Gopalakrishnan. "Ananthapuri Pettah later evolved into Chalai

Market, while Thirumadhura Pettah became known as Pettah. The term 'Pettah' denotes a commercial or trading centre. Historians continue to debate whether the name 'Thirumadhura Pettah' originated from traders who arrived here from Madurai," he explains.

In ancient times, he says, waterways were the primary path for trade and transport. Even before the construction of the man-made Parvathi Puthanar canal, there were smaller water channels in the area, as per the records. "The construction of Parvathy Puthanar only strengthened these waterways. Some historians note that goods from various regions were brought to Pettah, where surplus products were sold and exported. And also, thanks to its proximity to the sea, the area became a key trading post for spices such as pepper and cardamom," he says. The historians also say the place was a significant centre for early However, this area, located on the Christians in Travancore. The Kollam-Thiruvananthapuram railway line, which started in 1918, ended at Pettah.

The 'Memoir of the Survey of Travancore and Cochin States' by Lieutenants Benjamin Swain Ward and Peter Eyre Conner document Pettah's prominence as a trading centre and densely populated community, primarily made up of traders and members of the 'Mukkuva' community. It is said that this place is also known as a gathering centre for spiritual assemblies of figures such as Chattampi Swamikal, P Sundaram Pillai, Swaminatha Desikar, Velutheri Kesavan Vaidyan, Perunnelli Krishnan Vaidyar, and Narayana Guru.

The prominence of the Pettah market has decreased over time, while Chalai Market continues to thrive.

Rare comet likely to dazzle morning skies this month

BENGALURU. Skywatchers are in for a rare celestial spectacle as the Comet C/2023 A3 (Tsuchinshan-ATLAS) is expected to be visible in the early morning skies until October 20. This comet, which has travelled for thousands of years from the distant reaches of the solar system, could become one of the brightest objects in the sky.

What makes this comet special is not only its potential brightness, but also the fact that this is a once-in-a-lifetime event --C/2023 A3 won't return for tens of thousands of years, making it a unique opportunity for stargazers.

Dr BS Shylaja, scientist and former However, there is a possibility that the director of the Jawaharlal Planetarium, said the comet was discovered by two observatories earlier this year -- the Tsuchinshan Observatory in China and the ATLAS (Asteroid Terrestrial-impact

Last Alert System) project. Hence it bears the name C/2023 A3 (Tsuchinshan-ATLAS), with "C" indicating that it is a non-periodic comet and "2023 A3" reflecting its identification in early January 2023. Tsuchinshan and ATLAS are credited for spotting it independently, and its name honours both observatories. As Comet C/2023 A3 nears the Sun, it will form a glowing atmosphere, known as a coma, and a long tail made of dust and gas that stretches for millions of kilometres," Dr Shylaja said, adding that this tail will create a stunning sight as it reflects the sunlight.

comet could break apart due to the Sun's intense heat and gravitational forces, but if it holds together, it promises to be one of the most brilliant comets seen in recent years, she added. Dr BR Guruprasad, Director of the Planetarium, said, "C/2023 A3 (Tsuchinshan-ATLAS) comet is truly unique, taking about 80,000 years to complete one orbit around the Sun, so it is something none of us will see again in our lifetime. However, comets are notoriously unpredictable - some, expected to be brilliant, end up fading out. We're still waiting to see how bright this one will get."In the first week of November, another comet is expected to be visible in the morning sky. With advancements in technology and modelling, scientists mentioned that they hope to improve the ability to predict how these comets will behave in the future. However, they highlighted that a degree of uncertainty will always remain as each comet can exhibit unique and unpredictable characteristics.

Mumbai road rage: Biker killed in front of fasmily, 9 held

MUMBAI. A 28-year-old Hyderabad-based man, visiting his parents' home for Navratri, was beaten to death by a mob of 9-10 men in a case of road rage in Malad (E) on Saturday. Akash Maeen and his wife were on their motorcycle when an auto overtook them, leading to a heated argument, which escalated when the latter summoned his associates. Dindoshi police have arrested 9 people, including the auto driver, on the charge of murder, reports Nitasha Natu.Maeen worked in a tech company and had tied the knot only 7 months ago. He had booked a new car and was keen to take delivery on Dussehra. At 5.30pm Saturday, he and his wife were returning from the showroom when at Shivaji Chowk, an auto driver, Avinash Kadam almost brushed the bike, leading to the heated exchange. Maeen's mother, Deepali, an MNS functionary, said she and her husband were in another auto at the time and rushed to the spot to de-escalate the fight after their daughter-in-law called them.

Official apathy puts Varkala tourists at risk amid repeated cliff collapses

Residents complain of cracks in walls, peeling cement and lack of proper water facility.

THIRUVANANTHAPURAM. In the wake of escalating erosion and repeated collapse of portions of Varkala Cliff, the district disaster management authority (DDMA) on Monday directed Varkala municipality The Geological Survey of India (GSI) is to take stringent measures to prevent unauthorised parking at the helipad, the site of the latest collapse. On Friday, after heavy rain, parts of the cliff give way near the helipad, sparking widespread concern.

Varkala Cliff, a rare geological formation, has been severely impacted by rain, improper "After a preliminary study, we gave our wastewater management, and uncontrolled vehicle movement, resulting in several instances of collapse over the past few months. According to sources, the DDMA has directed the Varkala municipal secretary to take steps to ban human activities, especially parking, 20 metres from the edge of the cliff at the helipad, where hundreds of tourists arrive every day. Despite stringent orders, a lack of coordination between the revenue and tourism departments and the municipal

authorities have led to unchecked activities and violations, triggering further destruction of the cliff and putting tourists at risk.

Man handed 20-year RI for abducting & raping minor

News box

- Gurgaon. Three years after a man abducted a minor from Panipat and raped her, a fast-track court sentenced the 28-year-old youth to 20 years of rigorous imprisonment.In 2021, Shiva Kumar, who hailed from UP, abducted the minor, took her to Punjab and raped her repeatedly. The survivor was rescued by her parents with the intervention of the police.
- The additional sessions judge of the fast-track (Protection of Children from Sexual Offences) court of Panipat, in its order dated Oct 10, observed it found no inconsistency in the statement of the survivor and rejected the allegation that the accused was falsely implicated.A close analysis of the facts and circumstances of the case and the nature of the evidence available unequivocally establish the accused as the perpetrator of the sexual assault, the court, which also imposed a fine of Rs 50,000, said.
- The court also directed the district legal service authority to pay compensation of Rs 2 lakh to the survivor for her rehabilitation. The case was registered on Feb 26, 2021 at Samalkha police station under Section 6 of the POCSO Act and sections 365, 363, 366A, 376(2)(n) and 506 against Shiva Kumar, a resident of Shahjanpur in Lucknow, UP.On Feb 25, 2021, the survivor was searching for her brother when she met her friend, who took her to Anaj Mandi in Samalkha in Panipat district. From there, she was taken to a park where the accused, Shiva, was present. The minor was offered a soft drink and she fell unconscious. When she regained consciousness, she found herself in a room where Shiva tried to rape her. She was kept in custody and the accused repeatedly raped and physically assaulted her when she resisted. She was rescued with the intervention of the police and her parents from Punjab. She was counselled by the team from women and child welfare and underwent a medical examination

Daily wager killed by coworker over Rs 500 debt in Faridabad

Gurgaon: A 42-year-old daily wager was allegedly murdered by a colleague in Faridabad's Imamuddinpur for not repaying Rs 500 he had borrowed recently. No arrest was made in the case till late on Monday evening. On Saturday evening, Salauddin was sitting at home when Pawan, another daily wager, arrived on a bike. The two had an argument over the money and Pawan allegedly forced Salauddin to accompany him somewhere on his bike."Pawan barged into our house and abused my husband for not returning the money to him. Earlier, too, he had fought with my husband a few times and even threatened to kill him if he did not get his money back. That day, he forced my husband to go with him on his bike. Pawan did not say where he was taking him," said Dilshadan, Salauddin's wife.

Around 9pm, Pawan dropped an unconscious Salauddin back at home. Their neighbours called a local doctor, who suggested that the daily wager be taken to hospital. "I heard a sound and rushed out, only to find my husband lying unconscious in the courtyard. My daughter and I lifted him somehow and brought him inside the house. A doctor examined my husband and found him unresponsive. We took him to civil hospital, where he was declared dead on arrival. My husband was murdered. It was Pawan who killed him," Dilshadan said in her complaint at Chhansa police station.A case was registered against Pawan under Section 103 (1) (murder) of BNS."There was no mark of injury on his body. An autopsy was done to ascertain the cause of death. As soon as the autopsy report is out, we will take appropriate action," said sub-inspector Umesh of Chhansa police station.

Wrong-side driving: Commuters paid Rs 1.5cr fine in Sept as cases saw 4-time rise in a month

Gurgaon. Wrong-side driving — one of the deadliest habits on roads - has shown no signs of abating and collective consciousness against it remains elusive in a city where more than 400 people die every year in accidents.Data handed out by traffic police has shown that commuters in the city paid fines amounting to Rs 1.5 crore through Sept because of wrong-side driving. A total of 26,700 challans were issued for the menace last month."Traffic cops deployed on roads slapped 26,700 challans for driving on the wrong side. The fines, which were issued under the Motor Vehicles Act, were worth Rs 1.5 crore in total," DCP (traffic) Virender Vij said. "A campaign against wrong-side driving will continue for now," he added. The rising number of offences show that commuters in the city throw caution to the wind to save a few minutes and litres of

fuel despite an awareness drive by cops in various locations.In Aug this year, 6,300 challans were issued for wrong-side driving, which means the number of fines increased by more than four times in a month."See, the practice of driving on the



wrong side to take a shortcut was always there. The number of challans does not necessarily mean that the menace has increased. It's only that police vigil has increased on the roads," an expert on city traffic said.Apart from awareness drives, police have increased the fine amount for wrong-side driving by five times to deter people.According to the MV Act, the

challan amount for wrong-side driving is only Rs 500. But cops in the city have been including the charge of dangerous driving while issuing a challan. So, the total fine amount comes to Rs 5,500-Rs 500 for wrong-side driving and Rs 5,000 for dangerous driving. The traffic police have also identified 38 spots in the city where people drive on the wrong side with

impunity."Despite stringent fines and focus on these blackspots, there hasn't been any significant dip in the number of wrong-side driving cases. People continue to flout the rule at will," a police officer said. According to police, wrongside driving accounts for almost a fifth of the total fines issued in the city for various traffic violations. More than 15% of fatal accidents are caused by this menace, data shows.Vij said it was important for cops to be visible on the roads to deter people from violating rules. He asserted that the campaign to make roads safer would continue for now."People should be extra careful while driving on the road. By driving against the traffic flow, they not only endanger the lives of others but their own as well," the DCP added.

According to the data released by cops, a total of 31,870 challans were issued for wrong-side driving in 2023, while there were 40,315 incidents in 2022. The year before saw 32,618 fines for driving on the wrong side while 39,765 fines were issued in 2020. In 2019, 49,761 challans were slapped.

Gurgaon civic body starts safety checks, deploys staff at Bandhwari landfill after fire

Gurgaon. A day after a massive fire erupted at the Bandhwari landfill site, MCG officials led by additional commissioner Balpreet Singh visited the spot on Monday and deployed staffers for the site's round-the-clock surveillance. Staff members, who would be assigned three shifts of 8 hours each to keep a watch at the site, will be penalised if any such incidents repeat, Singh said.Earlier too, the corporation had made its employees, including engineers, responsible for ensuring that no such incidents occur, but the manpower was diverted after Solid Waste Environment Exigency Programme (SWEEP) was implemented following the declaration of a



solid waste management exigency in the city. We are going to ensure that the site is under surveillance for 24 hours. We will engage our workers in monitoring the site, instead of engineers, who have their fieldwork and other duties and are unable to devote time to monitoring. Drop in wind speed likely to turn city's air 'poor' in next two days

Gurgaon. The city's air quality index (AQI) remained in the "moderate" range for the third consecutive day on Monday though Delhi and other NCR cities like Noida Ghaziabad witnessed 'poor" air. The city's AQI improved slightly to 108 on Monday compared to 169 on the previous day. Throughout Oct, Gurgaon hasn't witnessed "poor" air days. Instead, it has logged four "satisfactory" days and 10 "moderate" days.However, an HSPCB official said local surface winds are likely to remain calm for next two days, resulting in deterioration of air quality to "poor" category. "Surface winds are expected to remain calm, at around 8kmph, for the next two days. This will not help disperse pollutants, with AQI likely to deteriorate to "poor," he said.

So far, the average AQI was recorded at 113 from Oct 1 to 14, which is better than the past six years. Last year, the average AQI was clocked at 176 during

the same period, while it was 114 in 2022, 141 in 2021, 194 in 2020, 132 in 2019 and 223 in 2018. According to experts, though the region witnessed less showers and low wind speed this month, long-range transportation of pollutants was less than previous years. In the last two weeks, the southeast wind direction prevented pollutants from farm fires from reaching the city, resulting in a minor difference in air quality compared to previous years. However, the recent change in wind direction to northwest is expected to have an impact on the AQI. Shubhansh Tiwari, a research associate

at the Centre for Science and Environment (CSE), explained the situation. "The first half of Oct was much better this year. This change is because farm fires didn't pick up in Sept and till the first week of Oct. We are witnessing a rise now, so it is impacting Delhi's AQI. Also, a few

As Delhi's air quality has worsened, with the daily AQI reaching 234, the authorities have implemented stage-I of GRAP to control air pollution. Crackers burst, effigies burnt: AQI dips to 'poor' as smoke shrouds NCR

Noida. A smoky haze returned to Delhi-NCR on Monday morning as the region saw a jump in pollution levels after residents flouted the ban on firecrackers during Dussehra. The city, which experienced clear skies and abundant sunshine on Saturday, recorded two 'poor' air days on the trot. Its 24-hour Air Quality Index nosedived from 136 (moderate) on Saturday to settle at 243 and 268 on Sunday and Monday respectively While the air quality in Noida has been largely recorded in the 'moderate' category over the last fortnight, on two days — Oct 4 (228) and 8 (217) — the city has recorded 'poor' AQI. The city also saw two 'poor' air days on Sept 24 (210) and 25 (250).UPPCB Noida regional officer Utsav Sharma attributed the sharp deterioration in air quality to a combination of factors: bursting of firecrackers during Dussehra and low wind speed that prevented pollutants from dispersing. With wind speed unlikely to pick up, AQI may remain 'poor' for the next few days.Except for Gurgaon, where the AQI has stayed at the 'moderate' level throughout the month, Greater Noida, Ghaziabad and Delhi too had two consecutive davs of 'poor' AQI.On Monday, Greater Noida's AQI was recorded at 274, up from 228 on Sunday and 150 (moderate) on Saturday. Ghaziabad's AQIs were recorded at 271 on Monday, 265 on Sunday and 177 on Saturday. In Delhi, the AQIs were 234, 223 and 155 on these three days respectively.Gurgaon's AQI was 108 on Monday, which is better than Sunday's 169 and Saturday's 120.Last year, the air quality had started to deteriorate from the first week of Oct across Delhi-NCR especially in Greater Noida which saw only one 'moderate' air day and 13 'poor' ones when the AQI oscillated between 214 and 292. Noida and Delhi saw five 'poor' AQI days last Oct. In the corresponding period this year, the two cities saw four and two such days respectively. Ghaziabad saw four 'poor' air days in Oct 2023 and five in the same period this year. Gurgaon recorded four 'poor' days in Oct 2023. With the air quality deteriorating to the 'poor' category, pollutioncontrol measures under stage I of the Graded Response Action Plan (GRAP) will be imposed across Delhi-NCR from 8am on Tuesday.GRAP Stage-I implemented once air quality reaches between 201 and 300, mandates dust control and mitigation measures at construction sites, regular lifting of municipal solid waste, periodic mechanised sweeping and sprinkling water on roads, scientific disposal of dust at designated landfills."We have held meetings and asked different stakeholders, like Noida Authority, traffic police, transport department, etc to take measures from their end. Developers have also been told to ensure compliance. We will conduct enforcement drives too,' Sharma said.

Noida: The Noida Authority plans to use Rs 30.89 crore in funds received under the National Clean Air Programme (NCAP) to purchase anti-smog guns, hybrid smoke guns, and water sprinklers to combat winter pollution. Of this, around 10 crore will be allocated for road resurfacing and to fix potholes across several stretches in the city. Noida CEO Lokesh M said the authority is committed to tackling pollution during the winter season. "We have received Rs 30.89 crore as NCAP funds to check pollution. We have already purchased five anti-smog guns and are in the process of buying ten more. In addition to this, we have also issued tenders to buy 12 hybrid smog guns," he said. Hybrid anti-smog guns are devices that help reduce air pollution by spraying fine mist or water droplets into the air to reduce particulate matter and other airborne pollutants. "We are also planning to sprinkle water from high rises in Noida so that the dust particles come down. Usually, the water is sprinkled from the ground and it covers a certain height. If the water is sprinkled from top down, it will yield

Kamala Harris slams Trump's 'enemy from within' remarks, calls him unstable

Pennsylvania Democratic presidential candidate Kamala Harris on Monday slammed Donald Trump for his ominous comments about "the enemy within" the United States and the threat to deploy the military domestically, in a renewed effort to paint her Republican opponent as a threat to democracy. In a rare move at her campaign rally in the political swing state Pennsylvania, the US vice president showed a clip of Trump, the former president, telling his supporters "those people are more dangerous -the enemy from within - than Russia."Harris, 59, has recently pressed Trump to release his health records, as she has, and knocked him for meandering tangents and focus on fictional characters such as Hannibal Lecter.A second Trump term would be a huge risk for America, and dangerous. Donald Trump is increasingly unstable and unhinged," Harris told the Erie crowd after playing the clip.She went on to say that Trump poses a danger because he believes those who do not agree with him are the enemy.Trump in recent rally speeches has hinted about facing "an enemy from within," more dangerous than a foreign adversary. His campaign did not immediately return a request for comment.In an interview on Sunday on the Fox News program "Sunday Morning Futures," host Maria Bartiromo asked Trump if he was expecting "chaos" on Election Day, and he appeared to suggest the military could be deployed against citizens."I think the bigger problem is the enemy from within," Trump said. "We have some very bad people. We have some sick people, radical left lunatics."

- He added: "It should be very easily handled by, if necessary, by National Guard, or if really necessary, by the military, because they can't let that happen." Trump would not be able to give orders to either National
- Guard or active-duty military units on Election Day on November 5 because he is not president.
- Harris' trip to Pennsylvania on Monday is her 10th to the battleground state since becoming the Democratic candidate in July. The state's 19 electoral college votes will be pivotal to the election outcome. She kicked off her trip to Erie with a stop at a Black-owned coffee shop for a sit-down discussion with Black men. Her campaign is concerned about slipping support from Black voters. Harris unveiled new policy proposals aimed at Black men on Monday that include forgivable small business loans

and access to a new legal recreational marijuana industry.

Russia-Ukraine war which started in 2022 The ongoing war has led to the loss of life UKRAINIAN OFFICIALS RAID A of 10,582 Ukrainian civilians with many more wounded. With a decrease in the number of people, Ukraine is making an all-out effort to recruit men.While many of the conscription raids conducted were in Ukraine's capital, Kyiv, the wedding celebration was in the Ukrainian town of Lviv.These raids should be seen in the context of a law passed in April wherein Ukrainian men aged 25-60 can apply for conscription and men aged 18-60 are not allowed to leave Ukraine, reported The Associated Press. 

Who am I A South Korean adoptee finds answers about the past just not the ones she wants

- SEOUL. Rebecca Kimmel sat in a small room, stunned and speechless, staring at the baby photo she had just unearthed from her adoption file.
- It was a black-and-white shot of an infant, possibly taken at an orphanage in Gwangju, the South Korean city where Kimmel had heard all her life that she'd been abandoned. But something about the photo - the eyes, the ears, an uneasy feeling deep in her gut - confirmed what she'd long suspected: This baby was not her.
- Overcome, she started howling like a strange, wounded animal. This photo meant that the stories she had been told about herself were a lie. So who was she? Who IS she?Thousands of South Korean adoptees are looking to satisfy a raw, compelling urge that much of the world takes for granted: the search for identity. Like many of them, Kimmel has stumbled into a web of switched photos, made-up stories and false documents, all designed to erase the very identity she desperately wants to find. These adoptees live with the consequences of a tacit partnership by the South Korean government, Western nations and adoption agencies that has supplied some 200,000 children to parents overseas, despite warnings of widespread fraud.
- For decades, South Korea tried to get rid of children from biracial parents, poor families, orphanages and unwed mothers, ignoring illicit practices. Western families in turn were eager to adopt from abroad, after access to birth control and abortion crushed the supply of domestic babies. While many adoptions ended happily, the desires of both sides also resulted in the unnecessary removal of generations of children from their families based on fake paperwork.As Kimmel sat weeping in that room in the Seoul adoption agency, she knew little of this background. All she knew was that she needed answers.Kimmel, an artist, thinks she is about 49; her exact age is one of the many things about herself she does not know. She throws herself with intensity into almost everything she does, particularly her allconsuming quest for her roots.

UN Security Council voices concern for peacekeepers after Israeli attacks

New York. The United Nations Security Council on Monday expressed strong concern after several UN peacekeeping positions in southern Lebanon came under fire amid clashes between the Israeli military and Iran-backed Hezbollah militants.

In a statement adopted by consensus, the 15-member council also urged all parties - without naming them - to respect the safety and security of the personnel and premises of the UN peacekeeping mission, known as UNIFIL."UN peacekeepers and UN premises must never be the target of an attack," said the council, reiterating its support for UNIFIL and the operation's importance Israeli Prime Minister Benjamin for regional stability. The Security Council also called for the full implementation of its resolution 1701, which was adopted in 2006 with the aim of keeping peace on the border between UN peacekeeping chief Jean-Pierre Lebanon and Israel. The council Lacroix said on Monday that UN troops "recognised the need for further practical measures to achieve that outcome," but did not offer specifics.

Since the start of Israeli ground operations in Lebanon on October 1, UNIFIL positions have been affected 20 times, including by direct fire and an incident on

Sunday when two Israeli tanks burst through the gates of a UNIFIL base, the UN said."Five peacekeepers have been injured during these incidents, including one peacekeeper who sustained a bullet wound," UN spokesperson Stephane Dujarric told reporters on Monday. "The source of that gunfire has yet to be confirmed by UNIFIL."For the past two weeks, Israel has been telling UN peacekeepers to move 5 km (3 miles) back from the socalled Blue Line - a UN-mapped line separating Lebanon from Israel and the Israeli-occupied Golan Heights - for their

own safety.

Netanyahu said on Sunday in a statement addressed to UN Secretary-General Antonio Guterres: "The time has come for you to withdraw UNIFIL.

The Security Council authorized UNIFIL - under resolution 1701 - "to assist" Lebanese forces in ensuring southern Lebanon is "free of any armed personnel, assets and weapons other than those of the government of Lebanon.""We have to stand against ... every suggestion that if resolution 1701 was not implemented it's because UNIFIL did not implement, which was never its mandate," said Lacroix, stressing that UNIFIL had a supporting role.Danon said last week that the

Lebanese army and UNIFIL had failed to gain control of the area.

He argued that Israel was now acting to enforce resolution 1701, telling the Security Council: "Our soldiers are now in the field, along the border in Lebanon, exposing and dismantling Hezbollah's infrastructure."The United States and France have said that strengthening Lebanon's army would be crucial to implementing resolution 1701.

"UNIFIL cannot prevent hostilities," Russian UN Ambassador Vassily Nebenzia said on Monday. "UNIFIL is being jeopardized and endangered and one country openly threatens its personnel, which is unacceptable.'

UNIFIL is also authorised under resolution 1701 "to assist" - if requested by the Lebanese government - in preventing the illicit transport of weapons into the country. The resolution 1701 also bans parties from crossing the Blue Line by ground or air. UN officials have long reported violations by both sides.

Danon told the Security Council last week that it "must ensure the right mechanisms are in place for the Lebanese army and UNIFIL to meet their obligations.'

Dasara festival leaves Palike grappling with mounds of garbage

BBMP collects 17,733 MT of waste in last 3 days against daily collection of 4,900 MT



BENGALURU. In the backdrop of the three-day Dasara festival, the Bruhat Bengaluru Mahanagara Palike (BBMP) collected 6,306 metric tonnes (MT) of waste from across eight zones on October 12 against the normal daily collection of approximately 4,900 MT.

Waste Management Ltd said during the Dasara festival, plantain leaves and stems, pumpkins and flowers were sold in all markets and on roadsides for Ayudha Puja. The unsold items were left behind by sellers and BSWML has been continuously cleaning them. Officials attached to the Bengaluru Solid "Approximately, 4,900 MT of waste is

generated in the city every day. But during this Dasara festival, 6,306 MT waste was generated on October 12, 5,561 MT on October 13 and 5,866 MT on October 14. Raw waste was disposed of at treatment plants and mixed waste at the landfill," said an engineer with BSWML.

In the last two days (Saturday and Sunday), 414 MT of waste has been disposed of from 12 markets, including major ones like KR Market, Gandhi Bazaar, Devasandra, KR Pura, Malleswaram, Madiwala and Russel Market and Palike Bazaar. On Monday, more than 150 MT of waste was disposed of, the official added.

Due to the excess production of waste in the market and roadsides, health

officials, senior engineers and marshals of the solid waste department were deployed in respective zones. Additional earthmovers were used to collect the garbage. Auto tippers and compactors did repeated trips in most of the wards to collect and dispose of garbage.

Chennai records 6.9 cm rainfall amid monsoon preparations

- CHENNAI. Chennai has recorded an average rainfall of 6.9 cm between 8:30 am on Monday and 8:00 am on Tuesday, according to the Regional Meteorological Centre (RMC), Chennai. Ennore reported the highest rainfall at 10 cm, followed by Manali, Kolathur, T.V.K. Nagar, Ponneri, and Royapuram, each receiving 9 cm.
- A report from the Greater Chennai Corporation's Integrated Command and Control Centre (ICCC) indicated that Manali New Town experienced the most rainfall, with 9.21 cm recorded since Monday. Kolathur and Perambur in the Thiru-Vi-Ka Nagar zone closely followed, each receiving 9 cm of rainfall.
- In just one hour between 7:00 am and 8:00 am on Tuesday, Ayapakkam saw 3.3 cm of rain, while Mugalivakkam in the Alandur zone received 3.09 cm. Heavy rainfall resulted in waterlogging in several areas, including Pulianthope, Vyasarpadi, and OMR. Staff from the Greater Chennai Corporation were deployed to pump out stagnant water using motor pumps.
- Late on Tuesday night, around 12:30 am, Deputy Chief Minister Udhayanidhi Stalin conducted an inspection of areas around Narayanapuram Lake, between Pallikaranai and Kovilambakkam. He also visited the canal on Ambedkar Road, which diverts surplus water from Kilkattalai Lake to Narayanapuram Lake, and interacted with local residents to understand their concerns. Additionally, he inspected Chepauk and Royapettah.

Addressing the media, Udhayanidhi Stalin assured that preparations for the monsoon season were underway to prevent a recurrence of the problems experienced in previous years. "Water stagnation is already being addressed in several areas, and the situation will continue to be monitored regularly," he said.

Heavy rains likely in Andhra Pradesh for next three days

VIJAYAWADA. Several districts in Andhra Pradesh, including Nellore, Tirupati, Prakasam, and Annamayya, witnessed heavy rainfall starting early Monday morning, due to the formation of a low-pressure over the Southeast Bay of Bengal.By 10 pm on Monday, Kodavaluru in Nellore district recorded the highest rainfall at 11 cm. According to the India Meteorological Department (IMD), the low-pressure system is expected to intensify into a well-marked lowpressure area by Tuesday over the central parts of the south Bay of Bengal. It is likely to continue moving west-northwest, affecting northern Tamil Nadu and southern Andhra Pradesh in the coming days.

The IMD forecast predicts that the coastal and Rayalaseema regions of Andhra Pradesh will experience heavy rains with thunderstorms and lightning between October 14 and 17. These weather conditions are expected to affect both South Coastal Andhra Pradesh (SCAP) and North Coastal Andhra Pradesh (NCAP).In response to the situation, Chief Minister N Chandrababu Naidu has directed all district administrations to remain on high alert for the next four days. Special emphasis has been placed on monitoring water bodies and preparing for potential flash floods.

The public has been advised to avoid crossing canals and streams during periods of heavy rainfall and flooding. During a review meeting with Minister for Water Resources Nimmala Ramanaidu and senior officials, the Chief Minister stressed the importance of providing advance warnings to residents in areas expected to receive heavy rainfall.

An official release from ISRO stated that the recognition celebrates India's contribution to space exploration.

"Celebrations underway in Milan as we continue to strive for new frontiers," ISRO posted on 'X' on Monday. The award ceremony was held on October 14 during the 75th International Astronautical Congress in Milan, Italy. The IAF recognised the mission's achievement where India was the first country to land near the lunar South Pole on August 23, 2023. The IAF on its

website posted: "Chandrayaan-3 mission by ISRO exemplifies the synergy of scientific curiosity and cost-effective engineering, symbolising India's commitment to excellence and the vast potential that space exploration offers humanity. Rapidly unveiling previously undiscovered facets of the Moon's composition and geology, the mission stands as a global testament to innovation. Achieving a historic milestone, Chandrayaan-3 becomes the first to touch down near the lunar South Pole, showcasing both aspiration and technological prowess on an international scale."India is also among the elite group of nations like United States, Russia and China to have completed a successful soft landing on the Moon's surface.

At the event, scientists also made a special note of the lander Vikram and rover Pragyan, which were designed to explore the Moon's surface and conduct experiments to better understand the Moon's composition and geology.

revised Rs 5.54 crore proposal to organise summit at Amaravati on Oct 22 and 23

VIJAYAWADA. The State government has appointed the Drone Federation of India (DFI) as the preferred event and knowledge partner for organising Amaravati Drone Summit 2024 at a cost of Rs 5.54 crore (exclusive of GST). Orders to this effect were issued on Monday.

Chief Minister N Chandrababu Naidu on August 6, 2024, emphasised the strategic importance of promoting drone technology for problem-solving across departments and directed the AP Drone Corporation (APDC) to take the lead in organising a national-level event.

Union Minister for Civil Aviation K Rammohan Naidu, in his review meeting, proposed that the Ministry of Civil Aviation (MoCA) should extend technical guidance and support to the Andhra Pradesh government in organising the National Drone Conference.

The Agenda will include the development of diverse applications for drones across sectors such as agriculture, health care, urban planning and law and order as well as research and development, manufacturing, testing and policy creation.

In line with these directions, the APDC has proposed to organise a two-day national level drone conference tentatively named 'Amaravati Drone Summit 2024' on October 22 and 23 in Amaravati

The expected outcome of this conference includes the identification of drone use cases and their commercialisation potential, engagement with industry stakeholders, investors and academia, preparation of a road map to establish Drone City, including components, and exploration of collaborative opportunities with investors and industry experts.

Accordingly, the APDC has invited the Drone Federation of India (DFI) to collaborate for organising the proposed two-day national level drone event in Amaravati.

The DFI in turn has submitted its initial proposal for organising the summit at a cost of Rs 6.37 crore (exclusive of GST) which includes costs for the two-day summit at CK Convention, Mangalagiri to host 500-600 delegates and guests across the industry and academia, along with cultural events at Berm Park, Vijayawada.

MoCA has been requested to sanction the proposed budget (expected after negotiations) of Rs 6 crore (exclusive of GST) as a grant-in-aid to AP Drones Corporation Limited to facilitate the organisation of the prestigious event. Later on a further site assessment, the DFI submitted a revised proposal for Rs 5.54 crore (Exclusive of GST).

Not criminalising marital rape smacks of patriarchy

IN an affidavit before the Supreme Court, the Union government has taken a stand against the criminalisation of marital rape. In the affidavit before the apex court, the Home Ministry mentioned that a man has no fundamental right to force sex on his wife as there are enough laws to protect women against sexual violence and that criminalisation of marital rape would be an extremely "harsh measure." The Supreme Court is hearing a number of petitions seeking to amend the British-era law that a man cannot be prosecuted for rape within marriage, even though violence within marriage is rampant in India. According to a recent government survey, one in every 25 women has faced sexual violence from their husbands. In January 2023, the Supreme Court appointed two advocates as nodal counsels to streamline the proceedings by compiling a common document of relevant materials from all parties.Currently, marital rape is outlawed in more than a hundred countries around the world. It was outlawed in the Great Britain in 1991. India is one of the few countries, along with Pakistan, Afghanistan, and Saudi Arabia, where the marital rape law remains in force. The Indian Government, in its affidavit, highlighted the fact that Parliament, in its wisdom, has deliberately chosen to retain the marital rape exception and urges the court to defer to legislative judgment in such sensitive matters. Parliament is directly elected by the people and is aware of the understanding of the people in such delicate, sensitive issues. In the affidavit, the government urged the court to exercise judicial restraint and leave the regulation of marital relations to the wisdom of Parliament. A number of petitions have been filed by different women's rights groups to strike down Section 375 of the IPC, which mentions several situations in which having sex is not considered rape, one of them being sex by a man with his wife, if she is not a minor. According to the campaigners, this kind of argument is medieval and unacceptable in modern times. The United Nations, Human Rights Watch and Amnesty International have raised concerns about India's refusal to criminalise marital rape. The Delhi High Court has given a split verdict, which remains pending for the Supreme Court's final judgment, in which one judge has held that marital rape is "morally repugnant" while the other expressed the view that the exception to Section 375 of the IPC is valid and should continue to exist.

It has to be borne in mind that the marital exception in the IPC and the definition of marital rape were drafted on the basis of Victorian norms that did not recognise men and women as equal and merged the identity of husband and wife under the "Doctrine of coverture."Further, marital rape violates the right to equality enshrined in Article 14 of the Indian Constitution. Hence, it creates two classes of women based on their marital status and immunises action perpetrated by men against their wives. There is no other reason for the victimisation of women other than their married status. Moreover, it becomes difficult for married women to avoid abusive conditions because of their financial dependence on their husbands. The exemption is also violative of Article 21 of the Constitution, which includes the right to life and encompasses the right to health, privacy, and dignity. The Supreme Court has recognised the right to abstain from sexual activity for all women, irrespective of their

Why US is acting in tandem with Israel to carry out missile attacks against Iran

ON October 11, Iran launched its third missile strike on several targets in Israel, including on the capital city of Tel Aviv. According to an Israeli Defense Forces statement, nearly 300 ballistic missiles were involved in the attack but most were reportedly intercepted and neutralised by Israel and US forces based in Qatar, working together. The first missile strike took place on April 13, in retaliation for the targeted killing of Iranian diplomats in an Israeli bombing attack on an Iranian consulate in Syria. However, Iran gave advance warning of the attack and avoided causing major damage. It also announced that it did not want to escalate the conflict beyond

this retaliatory attack. Nevertheless, this missile attack was the very first direct attack from Iranian soil on Israel and therefore a significant departure from the past.

The proxy war against Israel conducted hitherto through Iranian proxies such as Hamas in Gaza, Hezbollah in Lebanon and Houthis in Yemen, had now graduated to a direct clash of arms between the two major adversaries in West Asia and the Gulf.

Israel did not respond directly to the Iranian attack, but it chose to inflict damage on Iran by targeting both the Hamas and Hezbollah leadership in Lebanon. It carried out the brazen assassination of the Hamas chief, Ismail Haniyeh, in the Iranian capital, Tehran, just hours after he had attended the inauguration of the new Iranian President Masoud Pezeshkian on July 31. This was a humiliating blow to Iran, demonstrating Israel's ability to strike at will at targets within Iran, leveraging its superior It is against this backdrop that Iran chose to launch yet intelligence capabilities. More importantly, Iran's attempt at deterrence by launching its April missile attack on Israel had failed.Israel then upped the ante with the bold assassination of the Hezbollah chief, Hassan Nasrallah, on September 27 in a suburb of the Lebanese capital, Beirut. Not just Nasrallah but several other senior leaders of this Shia militia were also killed in the targeted bombing of their headquarters. This was a prelude to the start of a major Israeli ground offensive into southern Lebanon with the objective of flushing out Hezbollah forces spread across southern Lebanon. Iran's second missile barrage against Israel came soon

too, reportedly caused little damage. Assisted by the US, Israel was able to intercept and shoot down most of the missiles. Unlike the April attack, however, Iran gave no advance warning about the attack. Nor did it declare its intent to avoid further escalation.

As anticipated, Israel declared its intention to retaliate against Iran and promised that it would be "painful."While in April, US President Biden had urged restraint on Israel, this time there was no such advice from Washington. On the contrary, US National Security Advisor Jake Sullivan, promised severe consequences for Iran and said the U.S. would "work with Israel to make that the case."

This change in US stand has not been fully appreciated. This is no longer just an Iran-Israel conflict. It is now a US-Iran conflict and that changes the nature of the confrontation unfolding in the region with serious consequences.

another missile barrage against Israel on October 10, reportedly using hypersonic missiles which it may have developed itself or may have obtained from Russia. There may have been greater damage inflicted on Israel than in the earlier attacks but it is difficult to assess the scale of such damage. The US announced that it had worked together with Israel to shoot down most of the missiles. This time President Biden declared that the US was "fully, fully, fully supportive of Israel."One should now jettison the view of the US acting as a restraint on Israel, in favour of avoiding escalation and a wider regional war. We will now increasingly see the US acting in tandem with Israel to carry out devastating aerial

and missile attacks against Iran. Three categories of targets are being mentioned: Iran's nuclear facilities, its oil and gas facilities and terminals and military targets, including the command-and-control centres of the Iranian Revolutionary Guards.


The longstanding effort of Benyamin Netanyahu, the Israeli leader, to drag the US into a war against Iran, has finally succeeded.It may be noted that a wider war in the region will have relatively less impact on the US since it is no longer dependent on energy supplies from the region. It would be less worried about an Iran lashing out by attacking oil and gas facilities of the Gulf countries or blockading

the Hormuz Straits, through which most of oil and gas supplies are exported to markets both in Europe and Asia. It would be prudent to plan for another era of very high oil prices. India will be seriously impacted.

Iran may be seriously weakened and face a debilitating economic crisis. Its proxies may also be weakened even if they are not neutralised. They will respond as such groups always do - by engaging in asymmetrical warfare. There will likely be an uptick in international terrorism. Even a weakened Iran may finally cross the nuclear threshold and acquire a nuclear arsenal despite the immense sacrifices this may entail. It will be convinced that it is only as a nuclear weapon state that it could ensure its survival. This could have a cascading effect in the region, with Saudi Arabia and Egypt choosing to embrace the nuclear option. None of the countries of the region can escape a negative fallout from a war against Iran. They have tried to shield themselves by pretending that they do not have skin in the game, but they always did. If they had intervened early in the day to impose some penalty on Israel to stop its brutal war against Gaza and now in Lebanon, the trajectory of events may have been different. But their silence meant that Israel saw no downside to its aggressive policies. We may be on the threshold of another major war and one on our western flank where nine or more million Indians live and work. Our energy supplies may be significantly disrupted. That India has so few levers to influence events in its strategically critical neighbourhood is a sobering thought.

Holding your breath on an India-Pak encounter



India and Pakistan are now at a point where even if they want to sit across a table and talk to each other publicly, they cannot do so for fear of enraging domestic constituencies.

THE visit of External Affairs Minister S Jaishankar to Pakistan to participate in the October 15-16 meeting of the Shanghai Cooperation Organisation (SCO) is unlikely to have a thawing effect on the 10-year freeze in bilateral relations. This much the minister has made clear, ruling out any bilateral agenda. "The visit will be for a multilateral event. I'm not going there to discuss India-Pakistan relations. I'm going there to be a good member of the SCO," he said.Jaishankar's statement is almost identical to that of then foreign minister Bilawal Bhutto Zardari in May 2023, before he arrived in Goa for the SCO Council of Foreign Ministers meeting: "My decision to attend this meeting illustrates Pakistan's strong commitment to the charter of the SCO...during my visit, which is focused exclusively on the SCO, I look forward to constructive discussions with my counterparts from friendly countries.

Nonetheless, bilateral drama is written into the script of every India-Pakistan encounter, or even a nonencounter. That was how it was in Goa, where Zardari and Jaishankar managed to have a showdown without exchanging a single bilateral word. It may be the same in Islamabad.Jaishankar claimed the other day that he is a "civil and courteous person, and will behave accordingly." That was possibly selfdeprecatory humour.He is no Diljit Dosanjh who won Pakistani hearts the other day by calling up Pakistani singer Hania Aamir on stage during his Europe tour. The galleries back home would be terribly put out if Jaishankar returns without his signature-style tough talk against Pakistan, this time on Pakistani soil. After all, this is what India-Pakistan diplomacy has been reduced to, not just now, but over several years — a performance for domestic audiences defined by the need to demonstrate toughness toward the other, even in body language.

So, Jaishankar's "namaste" to the Pakistan minister in Goa last year got approving media coverage, as "Jaishankar gives the cold shoulder to Zardari."

India and Pakistan are now at a point where even if they want to sit across a table and talk to each other publicly, they cannot do so for fear of enraging domestic constituencies. This is a logiam that can be broken only with statesmanship and political will. A back-channel process between the two NSAs in 2016-2017, and another the UAE claimed it had mediated in 2020-21 shows a willingness to speak.

When the process makes progress, as in February 2021 when the two armies reaffirmed their commitment to the two-decade-old ceasefire on the Line of Control, things freeze up again, because then the process must be made public. The lessons of the past are not helpful. Prime Minister Atal Bihari Vajpayee's visit in 2004 came after several years of back-channel contacts and a massive shift in relations between the US and Pakistan after 9/11.

Prime Minister Manmohan Singh continued the engagement that began then, but India-Pakistan ties have never recovered from the 2008 Mumbai attacks. Prime Minister Narendra Modi's outreach lasted only a week, from his Christmas Day stopover in Lahore on his way back to Delhi, to the Jaish e-Mohammed (JeM) attack on Pathankot.Today, the dynamic has changed from what it was even 10 years ago. Jaishankar will arrive in Islamabad after the successful holding of an election in the post-August 5, 2019 truncated Jammu & Kashmir. In Kashmir, the victory of the National Conference (NC) is viewed as a verdict against Delhi and the changes the Modi government wrought on August 5, 2019. But the NC knows, and has said as much, that in running the government, a confrontation with the Centre is not



the way forward.From Delhi's point of view, Pakistan's internal turmoil is a further disincentive for engagement. Who to talk to in Pakistan - the civilian government or the army - was a question even in normal times. But now, General Asim Munir, the embattled army chief, is in the midst of a selfinflicted do-or-die battle with not just the untameable and ever-growing popularity of the jailed Imran Khan, but also sections within his own force.Prime Minister Shehbaz Sharif and his brother, Prime Minister Emeritus Nawaz Sharif, once thought of as the most likely of the Pakistani political class to make paradigm shift in relations with India, are now beholden to Munir for their survival.

The Beijing-Islamabad relationship, the increasingly communal lens in India on ties with Pakistan plus Delhi's demand for a review of the Indus Waters Treaty further complicate the relationship.

For his part, Munir has not spoken his mind on India. What Delhi can see and feel is that the Pakistan army's preoccupations, including with the Tehreek-e-Taliban Pakistan and its Afghan Taliban patrons, the resurgence in Baloch militancy — with Chinese nationals in their crosshairs — have not led to the quietening of groups like the JeM and Lashkar-e-Toiba. A shadowy group, the so-called 'People's Force Against Fascism', has owned the regular attacks in Jammu since 2021, but Indian security agencies link it to the LeT and JeM.Delhi believes it can handle the costs of cross-border terrorism and leave ties in deep freeze. But flip the script for a moment. Imagine that Jaishankar is taking with him the message, like Vajpayee in 2004, that Modi has accepted Pakistan's invitation to attend the SAARC summit it has been waiting to host since 2016.

India's unquiet quitting of SAARC due to tensions with Pakistan is one reason why it faces so much resentment from smaller countries in the neighbourhood. When India laments the growing influence of China in the region, it needs to recognise its own role in letting the region go.

A revival of SAARC would put the energy back into India's neighbourhood policy and earn it the goodwill of neighbours. It would certainly put some pressure on Pakistan to conduct itself responsibly. The revival of SAARC may or may not resolve the differences between India and Pakistan, but it will provide bilateral engagement opportunities, normalise interactions in multilateral fora and make them less of a circus than they are now.

Bonus: An India engaged with Pakistan may help Prime Minister Modi to be taken more seriously by the world in his efforts to stop the war between Ukraine and Russia — and give that peace initiative greater heft.

L-G Saxena grants MCD commissioner financial powers over solid waste projects

UD Minister Saurabh **Bhardwaj** delayed approving crucial files, hampering MCD services due to lack of financial sanction.

NEW DELHI. In a move that is set to escalate the confrontation between the AAP-led government and Rajniwas, L-G VK Saxena on Monday granted financial powers enjoyed by the Municipal Corporation of Delhi's Standing Committee to the civic body's commissioner by approving his authority to take financial decisions on the management of solid waste amounting to more than Rs 5 crore. Under the Delhi Municipal Corporation (DMC) Act that governs

the MCD, proposals worth over Rs 5 crore have to be passed by the standing committee. Rajniwas said the move would ease the existing problem of municipal solid waste in the city due to the non-existence of the standing committee.

"In a step that will help ease the existing problem of municipal solid waste in the city due to non-existence of a standing committee in MCD and intransigence of the UD



Minister, Saurabh Bhardwaj, the L-G has approved the delegation of financial powers exceeding the current Rs 5 crore to the MCD commissioner," a statement issued from the L-G House read."On July 10, the MCD had moved the GNCTD to delegate financial powers to the MCD as per the provisions of Section 202 of the DMC Act, 1957. However, the UD Minister, Saurabh Bhardwaj kept the file pending at his level,

severely affecting municipal services due to lack of financial sanction since the Standing Committee was not in place," it added.

'The L-G Secretariat has recalled the file on two occasions. However, the file was not yet sent by the minister and remains untraceable," the statement said.

'Finally, contracts for collection and transportation of municipal solid waste and street sweeping were approved on Monday by the L-G by delegating financial powers upon the

MCD commissioner," the statement added. Mumbai. Shubham Lonkar, who made a social media post claiming responsibility for the murder on behalf of gangster Lawrence Bishnoi, supplied weapons to the shooters responsible for the murder of former Maharashtra minister Baba Siddiqui.

Shubham's brother, Pravin Lonkar, played a pivotal role in providing both financial and logistical support to the shooters. The two brothers, along with several accomplices, held multiple meetings in Pune to plan the murder.

The 66-year-old leader was shot dead while leaving his office for his residence in Bandra West on Saturday night. A total of six rounds of bullets were fired at Baba Siddique, three of which struck him. The NCP leader was declared dead after being taken to the hospital.

Sources revealed that a meeting between Shubham Lonkar, Shiv, Dharmaraj, and Gurmail Singh took place in Pune to finalise details of the murder. Though no specific amount was promised to the shooters initially, they were assured a significant sum after the successful execution of the murder. Each shooter was, however, given Rs 50,000 upfront for expenses related to the operation.

The main target, as confirmed by the police, was not Zeeshan Siddiqui but Baba Siddiqui. The shooters were given a photograph of Baba Siddiqui along with a flex banner to identify him. "There was no fixed amount promised, but they were assured a big reward," an investigator familiar with the case said.

The shooters arrived in Mumbai in September, with Dharmaraj and Shiv Kumar coming first, and Gurmail Singh joining them later from Haryana. The attackers reportedly fired at the NCP leader from a distance of six to seven feet, with Dharmaraj using pepper spray to escape the scene. After shooting Baba Siddique, Dharmaraj Kashyap used pepper spray in the air to create a diversion and flee the scene. Despite the chaos, the shooters managed to escape initially.

The police are currently investigating the authenticity of social media posts claiming responsibility for the murder. Both Facebook and Instagram have been contacted to verify if the Lawrence Bishnoi gang was involved as

JNU alleges arbitrary extension of faculty probation, raises concern over rector appointment



NEW DELHI. The Jawaharlal Nehru University Teachers' Association (JNUTA) on Monday alleged that several newly appointed faculty members have had their probation periods arbitrarily extended, as it also raised objection to the appointment of Rector I, claiming that it was done in violation of the seniority rule. Terming these actions "illegal" and "detrimental" to the institution's ethos, the JNUTA in a statement alleged that the appointment of Rector I was made in violation of Ordinance 5 (Clause 4), which states "if there are two or more rectors, the rector who has the longest continuous period of service shall be the senior most".

The JNUTA claimed that by disregarding the clause, the vice chancellor "is willingly committing an illegality that has repercussions for the university, given that it involves an office as important as that of Rector I". According to JNUTA, the move has already had its implications as the newly-appointed rector

Rajya Sabha polls in 4 J&K seats to be held after nearly 4 years: Sources



- Srinagar. Elections in four Rajya Sabha seats in Jammu and Kashmir will be held after nearly four years following the swearing-in of the National Conferenceled government on October 16, sources told .
- Lt Governor Manoj Sinha had invited National Conference leader Omar Abdullah to take oath as the Jammu and Kashmir Chief Minister on October 16.
- According to sources, the National Conference-Congress is expected to win three Rajya Sabha seats. The alliance won a majority in the just-held Assembly polls in the Union Territory, securing 48 of 90 seats. Other parties, including CPI-M, AAP and five Independents are supporting the alliance, pushing the overall tally to 55.
- The BJP, which finished second with a best-haul of 29 seats, could get one Rajya Sabha seat, sources said.
- National Conference supremo Farooq Abdullah is likely to be nominated to Rajya Sabha while BJP may send one of its senior leaders to the Upper House, they added.
- Former Deputy Chief Ministers Nirmal Singh and Kavinder Gupta, who were denied tickets for Assembly polls, are the frontrunners for the BJP's Rajya Sabha nomination, sources further said. The last Rajya Sabha polls in the erstwhile state were held in 2015 and the four seats have remained vacant since 2021 after the elected members completed their sixyear tenures.
- In the Assembly polls held after a decade in Jammu and Kashmir, the National Conference won 42 seats, Congress 6, BJP 29, PDP 3 and one each by the People's Conference, CPI-M and AAP. Seven independents also emerged victorious.

He also questioned if Bishnoi was being "actively used" by the Modi government and being given a "free hand intentionally"."The government is best equipped to answer the Canadian claims... However, the role and status of Lawrence Bishnoi is something that the government must come clean on," the Trinamool MP said. The Washington Post has claimed that during their meeting with Ajit Doval last week, Canadian officials outlined alleged evidence showing that India had enlisted the Bishnoi gang's networks to carry out the killing of Khalistani terrorist Hardeep Singh Nijjar and attacks on Sikh separatists.Doval acknowledged that Bishnoi was "capable of orchestrating violence from wherever he is incarcerated" and "was known to be up to no good from his jail cell", the report claimed.



Most of the other broader market indices were trading in positive territory in early trade, with decent gains in smallcap and midcap stocks.Among sectoral indices, Nifty Bank, Nifty Financial Services and Nifty IT gained, providing support to the benchmark indices. However, heavyweight Reliance Industries Limited fell nearly 1% in early trade after its net profit declined 5% in the second quarter of FY25. The top gainers on the Nifty50 were BPCL, Bajaj Finserv, Bharti Airtel, Infosys and ICICI Bank. On the other hand, the top losers were ONGC, Tata Steel, Hindalco, JSW Steel and M&M.

Retrospective levy of cess bleeds automobile sector

- NEW DELHI. The retroactive clarification issued by the GST Council regarding compensation cess is causing significant turmoil in India's automobile sector as companies are now facing show cause notices demanding payment on past vehicle sales.
- As per sources, carmakers have received tax notices worth Rs 10,000 crore for failing to pay compensation cess, which is part of the goods and services tax (GST), on utility vehicles sold prior to the issuance of clarification in 2022. This issue affects several popular models in the segment, including Mahindra's Thar and Scorpio, Tata Motors' Safari and Harrier, and Maruti's Brezza, among others.In 2022, the Council had issued a clarification about application of cess on all utility vehicles and SUVs with certain criteria for prior period. The companies are now getting the show cause retices "The most demonstrate of this actuaction." notices."The most damaging aspect of this retroactive application is that companies can't pass the tax burden to customers. Vehicles have already been sold and automakers can't go back and charge the cess to previous buyers," said Abhishek Rastogi, founder of Rastogi Chambers.Sudipta Bhattacharjee, partner with Khaitan & Co, said, "Unfortunately, the ghost of retrospective taxation seems to have reared its head yet again. Power generation capacity needs to rise four-fold by 2047, says Min Manohar Lal Khattar

NEW DELHI. The country will be required to increase its power capacity fourfold by 2047 to meet anticipated demand of 708 gigawatts, according to Power Minister Manohar Lal Khattar.Speaking at the two-day Brainstorming Session on the Indian Power Sector Scenario 2047, he emphasised the critical role of renewable energy in the country's future energy mix.

- By 2047, we anticipate our power demand to reach 708 Gw. To meet this, we need to increase our capacity by four times, i.e. 2,100 gigawatts," said the minister. "This is not just about increasing capacity; it's about reimagining our entire energy landscape."The minister also highlighted the goal of achieving 500 Gw of nonfossil energy capacity by 2033, stating that this transition aligns with India's commitment to reducing carbon emissions by one billion tonnes by 2030.
- The power minister also launched the National Electricity Plan (Transmission), which outlines the necessary transmission infrastructure to support 500 Gw of renewable energy capacity by 2030, with an increase to over 600 Gw by 2032. The plan includes innovative features such as the integration of 10 Gw of offshore wind farms, 47Gw of battery energy storage systems, and 30 Gw of pumped storage plants. It also addresses the power needs of green hydrogen and green ammonia manufacturing hubs and includes cross-border interconnections. With a planned addition of 190,000 circuit kilometers of transmission lines and 1,270 gigavolt-amperes (GVA) of transformation capacity over the next decade, the plan represents an investment opportunity exceeding '9 lakh crore in the transmission sector.

Openda had been a bright spot, winning the missed penalty after being brought down by William Saliba and later



scoring a well-timed header from Timothy Castagne's cross.

France, without Kylian Mbappe, held firm despite Belgium's pressure and saw a goal disallowed for handball before Kolo Muani's decisive second goal. With Italy leading the group on 10 points and France just behind on nine, both teams are in strong contention for the quarter-finals. Belgium, with four points, still have work to do.

Leweling stars for Germany on debut

Germany's Jamie Leweling marked his international debut in style, scoring the decisive goal in a 1-0 win over the Netherlands in their Nations League Group A3 clash on Monday. The 23-year-old midfielder, one of two new faces in the squad, had an early goal disallowed for offside in the second minute. However, he made no mistake in the 64th minute, smashing the ball into the top corner after the Dutch failed to clear a corner.Germany dominated from the outset, keeping the Netherlands under constant pressure.

Kylian Mbappe, LaLiga president accuse FIFA of destroying football ecosystem

New Delhi. A players' union, the European leagues' group, and Spain's LaLiga have jointly filed a complaint against FIFA, alleging "abuse" regarding the governing body's international match schedule. The complaint was submitted to European Union antitrust regulators amid grouping Union antitrust regulators amid growing concerns over player well-being, with many athletes facing fatigue, injuries, and mental strain despite their substantial salaries

The complaint asserts that FIFA's control over the international calendar constitutes an abuse of dominance and violates EU law. according to FIFPRO Europe, European Leagues, and LaLiga in a joint statement. The European Leagues, an association that includes major leagues like the Premier League, Bundesliga, Serie A, and Ligue 1-excluding LaLiga-has voiced specific concerns about the revamped Club World Cup set to take place next year. The tournament will expand from



seven to 32 clubs and is scheduled for nearly a month in the U.S., potentially disrupting clubs' pre-season tours aimed at enhancing global fan engagement.Premier League CEO Richard Masters expressed that the situation has reached a "tipping point," emphasising feedback from players who feel overwhelmed by the excessive number of matches.LaLiga President Javier Tebas criticised FIFA for prioritizing its own interests while disregarding the broader impact on the football ecosystem.

In a video statement during a news conference held by the three organisations, French captain Kylian Mbappe echoed these sentiments, stating, "When it's too much, it's too much."FIFA, however, maintains that the international calendar was established with input from representatives across all continents, including Europe, and in consultation with FIFPRO and various leagues. In addition to the expanded Club World Cup, the upcoming World Cup will also grow from 32 to 48 nations. UEFA has similarly adjusted its schedule with a new Champions League format but has not been included in the current complaint, as FIFA is seen as responsible for the international calendar. Mathieu Moreuil, Premier League director of international football relations and EU affairs, noted that relations with UEFA are different due to ongoing dialogue.

Kannada Actor Darshan And Pavithra Gowda Denied Bail In Renukaswamy Murder Case: Report



he bail petitions of popular Kannada actor Darshan Thoogudeepa and his friend Pavithra Gowda were rejected by a Bengaluru sessions court on Monday in connection with the high-profile Renukaswamy murder case. The case has captured significant attention, as Darshan, a beloved figure in the Kannada film industry, has been embroiled in this serious legal matter for several months. The case revolves around the murder of 33-year-old Renukaswamy, reportedly a fan of Darshan, whose body was discovered near a stormwater drain in Sumanahalli, Bengaluru, on June 9. Police sources indicate that the tragic events were allegedly set in motion when Renukaswamy sent inappropriate and obscene messages to Pavithra Gowda, Darshan's friend. These messages reportedly enraged the actor, leading to the chain of events that culminated in Renukaswamy's murder.

According to police, Renukaswamy had been communicating with Pavithra since February, with their interaction turning more explicit in June when he allegedly sent indecent photos. Despite the inappropriate nature of the messages, instead of contacting the police, Pavithra and Darshan reportedly chose to take matters into their own hands.Prosecutors argue that this decision led to Renukaswamy being abducted by a gang linked to the Akhila Karnataka Darshan Thoogudeepa Sena, a fan organization. It is claimed that Renukaswamy was taken to a shed in Pattanagere, where he was assaulted by the gang members before Darshan and Pavithra arrived. Upon their arrival, Renukaswamy was reportedly beaten again, which prosecutors allege ultimately resulted in his death.Darshan, who has been in judicial custody since June 11, has been fighting to secure bail over the past few months.
