India stays away from signing China's OBOR initiative at SCO meet

Islamabad, Oct 16: India didn't join the other nine members of the Shanghai Cooperation Organisation (SCO) in backing China's One Belt, One Road (OBOR) connectivity and infrastructure initiative during a key meeting of the bloc in Islamabad on Wednesday. External affairs minister S Jaishankar speaks during the 23rd meeting of the SCO Council of Heads of

Government, in Islamabad, Pakistan, on Wednesday. (PTI) The move was in keeping with India's stated position on OBOR, a flagship initiative of Chinese President Xi Jinping, that New Delhi has said doesn't offer a level playing field for Indian firms. In the past too, India has refrained from endorsing the OBOR or the Belt and Road Initiative (BRI) in joint documents issued after SCO meetings. The joint communique issued at the conclusion of the SCO Council

of Heads of Government meeting, hosted by Pakistan, said the other member states backed the OBOR and efforts to link the China-led initiative with the Eurasian Economic Union. The statement said Belarus, Iran, Kazakhstan, Kyrgyzstan, firmed "support for the People's Republic of China's One Belt, One Road (OBOR) initiative",



and "noted ongoing work on joint implementation of the project, including efforts to bridge the Eurasian Economic Union and OBOR". India has for long also opposed the China-Pakistan Economic Corridor (CPEC), a key part of the OBOR, as it runs through Pakistan-occupied Kashmir (PoK).

Pakistan, Russia, Tajikistan and Uzbekistan reaf- India is among a small number of countries in Asia that never signed on for OBOR despite China's invitations to join the initiative. Pakistan Prime


Minister Shehbaz Sharif, who chaired the meeting, called for creating a SCO connectivity framework by expanding projects the BRI, CPEC and International North-South Corridor (INSC). External affairs minister S Jaishankar, who spoke after Sharif, said cooperation within SCO on connectivity and trade should recognise territorial integrity and sovereignty, and cannot be built on "unilateral agendas". As expected, Jaishankar, the first Indian foreign minister to travel to Islamabad in almost a decade, didn't hold any bilateral meetings with the Pakistani leadership. As at a dinner for the visiting SCO leaders on Tuesday night, Jaishankar was welcomed by Sharif when he arrived at the venue for Wednesday's meeting. Jaishankar briefly 🔄 shook hands with Sharif, as his Pakistani counterpart Ishaq Dar looked on, and then went

into the venue. This was in contrast to the scenes at a SCO foreign ministers' meeting in Goa last year, when Jaishankar greeted his then Pakistani counterpart Bilawal Bhutto Zardari with a namaste,

Omar Abdullah takes oath as first J&K UT chief minister

Srinagar, Oct 16: National Conference Vice President and CM-designate Omar Abdullah during his visit to the Hazratbal Shrine ahead of the swearingin-ceremony of J&K new government, in Srinagar. After taking over as the Jammu and Kashmir Chief Minister, Omar Abdullah on Wednesday chose party leader Surender Choudhary from Nowshera in Jammu as his deputy, saying he did so to give a voice to people of the region and make his government inclusive. "Our endeavour will be to take everyone along," the National Conference leader told reporters after being sworn in. Five ministers - Sakina Masood (Itoo), Javed Dar, Javed Rana, Surinder Choudhary and Satish



Sharma - also took the oath of office. He said Choudhary - a former member of the PDP and the BJP who emerged a giant killer when he defeated BJP's J-K president Ravinder Raina from Nowshera by 7,819 votes - was chosen as deputy chief minister so people of Jammu do not feel left out from the government. "I had said that we will not allow Jammu to feel that they do not have a voice or representatives in this government. I have chosen a deputy chief minister from Jammu so that the people of Jammu feel that this government is as much theirs as it is of the rest," he said. In the 2014 assembly elections, Raina won the Nowshera seat by defeating Choudhary, who was then fighting on a PDP ticket, by a margin of over 10,000 votes. Choudhary resigned from the PDP in 2022 to join the BJP before ending his over a year-long association with the party to join the NC in July last year. This is the first elected government since 2019 when Article 370 was abrogated from Jammu and Kashmir and the state was bifurcated into the union territories of Jammu and Kashmir, and Ladakh. In the assembly elections held recently, the National Conference won 42 out of the 90 seats while alliance partner Congress bagged six. Together, the two pre-poll allies hold a majority in the 95-member assembly - five members are to be nominated by the LG.

Bahraich violence: Internet remains suspended for third day in a row

Lucknow, Oct 16: Mobile internet and broadband services remained suspended for the third day in a row on Wednesday after communal violence in Maharajganj town of UP's Bahraich district. Bahraich: Security personnel deployed to maintain law & order in a violence-affected area in Bahraich on October 15. However, no untoward incident has been reported since Tuesday, and the situation is returning to normalcy amid heavy police deployment, according .The violence broke in the district broke after Ram Gopal Mishra, 22, a resident of Rehua Mansoor village, was shot dead and about half a dozen people were injured in stone pelting and firing during a Durga idol immersion procession on Sunday. Tension gripped the town as thousands of people gathered near Bahraich Medical College and blocked roads demanding justice for the youth. Several houses were set on fire and vehicles were vandalized by the angry mob on Monday, prompting heavy security deployment in the area. About 52 people involved in the arson were arrested by the police. Of these, 26 were sent to jail on Monday and 26 on Tuesday. "No untoward incident has been reported since Tuesdav.

Yogi meets victim's kin, says culprits won't be spared

Lucknow, Oct. 16: Chief Minister Yogi Adityanath on Tuesday met the family of 22-year-old Ram Gopal Mishra, who was killed in the recent violence in Bahraich. The victim's family, accompanied by local MLA Sureshvar Singh, expressed their demand for strict action against the culprits, detailing the brutality inflicted upon Ram Gopal. His wife stated that "blood will be avenged with blood", emphasising the need for justice. Ram Gopal's father was seen crying and pleading for justice with folded hands in front of the chief

minister. During the 30-minute meeting in Lucknow, Ram Gopal's wife, mother, and father were visibly distressed. Yogi reassured them, stating that justice would be served. He instructed officials to provide assistance to the family and ensured they would not face any hardships. The CM also inquired

about the full details of the incident from lakh, a house under the Pradhan Mantri lences, describing the event as unfortu-



nate and reaffirmed that providing justice to the victim's family is the government's top priority. He promised that the culprits of this grievous incident would face severe consequences. Additionally, the CM announced a compensation package for the family, including Rs 10 night, attempting to set it on fire.

Meanwhile, police have arrested 26 individuals in connection with the Bahraich violence, which resulted in one death. Increased police patrolling is underway in a 20km radius around Hardi and Mahsi, with police vehicles

actively monitoring the area. Entry to affected neighbourhoods is restricted and requires identification verification. Sources said that despite a heavy police presence, miscreants vandalised a religious site in Nakwa village late Monday

New Delhi, Oct. 16: Prime Minister Narendra Modi-led Union Cabinet on

Wednesday approved the Varanasi-Pt Deen Dayal Upadhyaya (DDU) multitracking project with an estimated cost of Rs 2,642 crore. The proposed project includes a new rail-cum-road bridge across the Ganga river and the addition of third and fourth railway lines between Varanasi and DDU Junction route, among other infrastructural upgrades. "The proposed multi-tracking project will ease operations and reduce congestion, providing the much-required infrastructural development on the busiest sections across Indian Railways. The project traverses through Varanasi and Chandauli districts in Uttar Pradesh,"

a government statement said. It added, "Varanasi Railway Station, a crucial hub in Indian Railways, connects key zones and serves as a gateway for pilgrims, tourists and the local population." According to the statement, the Varanasi-DDU Junction route, vital for both passenger and freight traffic, faces heavy congestion due to its role in transporting goods like coal, cement, and food grains, as



well as serving growing tourism and industrial demands. "To address this issue, infrastructure upgrades are needed, including a new rail-cumroad bridge over the Ganga River and the addition of 3rd and 4th railway lines. These enhancements aim to improve capacity, efficiency and support the region's socio-economic growth," the statement said. "Apart from relief in congestion in the stretch, 27.83

MTPA (million tonnes per annum) freight is anticipated on the proposed stretch," it added. Highlighting the enhancement of employment/self-employment opportunities, the official release stated that the project is result of PM-Gati Shakti National Master Plan for multi-modal connectivity which has been possible through integrated planning and will provide seamless connectivity for movement of people, goods and services. According to the government, the project, covering two districts in Uttar Pradesh, will increase the existing network of Indian Railways by about 30 kilometres. "The Railways being an environmentally friendly and energy

efficient mode of transportation, will help both in achieving climate goals and minimizing logistics cost of the country and lower CO2 emissions (149 crore kg) which is equivalent to plantation of six crore trees," the statement said.

Firm asked to recover 5L from staffer who quit without notice

Ahmedabad. A local court here ordered the recovery of Rs 5 lakh from an employee by her employer towards damages for quitting the job without notice and for her unexplained absenteeism. The court allowed the company to recover the amount in an order passed in an ex-parte hearing as the employee did not participate in the court proceedings.

This case involved Mariya Rajput, who was appointed as trainee associate (finance) by Jensen Kobain Solutions Pvt Ltd in Feb 2021 on a probation of six months. After the completion of the probation period, her appointment was confirmed on certain service conditions. The terms of her employment contract required her to submit a written resignation notice 30 days prior to her intended last day of work.

According to the suit filed by the company, after her appointment, Rajput's attendance was irregular, and she used to remain absent from work without obtaining prior approval.

When the firm issued an absconding notice to her in Nov 2022, she sent her resignation through an email. The firm told her that her resignation was not in accordance with the employment agreement and advised her to withdraw it and requested her to work at least until her notice period was over.

However, the employee continued to remain absent. The firm then issued a notice to her through an advocate, asking her to pay Rs 5 lakh for quitting the job in violation of employment terms, but the notice was not replied to. The company filed a suit for breach of contract, specifically citing employment agreement violations, which led to the claimed monetary loss and harm to the company's reputation.

'State poised to become fibre-to-fashion hub'

Ahmedabad. The industry believes the new policy will help the state become an integrated textile hub, covering the entire spectrum from raw materials to finished garments.Rahul Shah, co-chairman of the Gujarat Chamber of Commerce and Industry (GCCI) textile taskforce, said, "Capital subsidy is a welcome move. Other states started offering capital subsidies to the textile industry, and due to that, Gujarat was not competitive in getting new investments. But now, that will change. It will serve as a booster for Gujarat to set up a garment ecosystem and become a fibre-to-fashion

Chintan Thaker, chairman of Assocham Gujarat State Council, said, "Capital subsidy has been included for the first time. It will offer much-needed handholding to a new unit during its critical five-year gestation period."

He believes this will attract fresh investments and support MSMEs looking to expand. The PM Mitra Park, Thaker says, will further draw global giants and create thousands of jobs, with special incentives for companies with over 4,000 workers.

A senior official in the industries department said, "The policy aims to make Gujarat the hub of the entire textile value chain. Expansion, modernisation and diversification will get a boost."

Gaurang Bhagat, secretary of the GCCI, said, "Standalone cotton spinning units will not benefit out of the policy as the state already has a huge capacity in the sector, but polyester and viscose are included in the new policy. However, cotton spinning activity in the integrated projects will be benefited."

Mevani moves privilege motion against senior cop

Gandhinagar. Congress MLA from Vadgam constituency, Jignesh Mevani, moved a motion for breach of privilege against additional director general of police (SC-ST Cell) Rajkumar Pandian. Mevani wrote to the assembly speaker, seeking action against the police officer, who he claimed was "rude and arrogant with him when he visited his office on Tuesday". Mevani said in the letter addressed to the speaker, Shankar Chaudhary, that he and state Congress SC cell chairman Hitendra Pithadiya visited Pandian's office on Tuesday afternoon to make a representation about issues concerning Dalits in the state.

'Pandian directed us to deposit our mobile phones outside his chamber, and when we sought to know under what rule this direction was issued, Pandian got enraged and asked his staff to take our phones, saying that we might be recording the conversation," Mevani alleged in the letter.

The MLA mentioned in the letter that he told Pandian he was "not behaving in a courteous manner with an MLA" and added that there is a protocol that officers have to courteously receive and see off elected representatives like MPs and MLAs who visit their offices.

"In response, Pandian retorted by saying that the meeting was over and that we should leave. He added that he will not give us another opportunity to visit his office. I told the police officer that I will keep coming here to make representations about issues concerning Dalits. If you refuse to hear me, I will have to approach the DGP, govt, and even approach the HC with a petition," Mevani said. Mevani added that Pandian commented on his attire, saying that "despite being an MLA, I was wearing a T-shirt."Arjun Modhwadia, who joined the BJP this March, too had moved a privilege motion against Pandian about 20 years ago.

Chocked Ennore wetland leaves North Chennai residents in fear of flooding


CHENNAI. Members of the fishing community in Ennore have raised an alarm about the growing flood risk in North Chennai as a vigorous northeast monsoon is on cards.

In an open letter to the state government, fishers alleged the degradation of the Ennore wetland and tidal sections of the Kosasthalaiyar river has led to environmental decline, thereby increasing the frequency of flood in the Chennai metropolitan area.

The community traces the roots of the problem to unchecked industrial activity that began in the 1960s with the establishment of the first thermal power plant in Ennore.In 2022, the National Green Tribunal (NGT) ordered the state government to notify the wetland and to remove 56.7 lakh metric Environmental activist Durga tonnes of fly ash choking the Kosasthalaiyar river. The tribunal also directed the government to prepare a restoration plan for the wetland. However, the fishing community notes that no significant restoration efforts have been made on the ground.

On October 3, responding to a petition filed by an Ennore fisherman, the water resources department assured the NGT that it will begin removal of Kaaka Aazhi (the invasive mussel) from three sections of the river - Kattupalli, Athipattu a n d Puzhuthivakkam.

Moorthy told the removal was carried only in one location, which is not enough. She said foreign ships docking at Kamarajar and L&T Ports have introduced invasive mussel species, which has infested local waters and further obstructed tidal flows. This, combined with industrial waste, has restricted boat movements and water flow, exacerbating the risk of

Week on, no arrest yet in accountant murder case, cops

Gurgaon. It has been a week since the murder of 29-year-old accountant Abhishek Rai in a deserted lane near Basai Road, just 500m away from his home on Wednesday. He was stabbed to death, and his cellphone and Rs 50,000 cash were missing.

Rai, who worked for a real estate company in Sector 90, stayed in Krishna Nagar, Sector 10, with his mother. His wife and daughter live in their native place, Ballia in UP.On Oct 9, Abhishek spoke to his mother around 7pm and told her he would return home soon. "He did not return till late in the night. We tried to contact him, but his phone was switched off," Abhishek's brother, Ashish Rai, told police. The next day, locals at Basai Ashish Rai, told police. The next day, locals at Basai Road alerted police about a body near the shed of a bike repair shop in Basai Road. "The victim was stabbed in the left thigh with a sharp-edged weapon," the then Shivaji Nagar inspector Mahender Pathak said after the murder. According to Abhishek's family, he was carrying Rs 50,000 cash and a cell phone. Police, however, did not recover it on the victim when they found the body. "There were no CCTV cameras in they found the body."There were no CCTV cameras in the lane where the body was found. We are verifying the footage from nearby cameras. The call data analysis of the victim did not provide any clues. We did not find Rs 50,000 cash with the victim. His phone is missing and it is still switched off," said an official investigating the case. The accused in another case of attempted murder is also absconding. Sandeep, a water purifier seller from Sector 10, was shot multiple times by his former business associate Mandeep and two others in Heera Nagar on Sunday due to a long-standing business feud. Sandeep managed to escape with injuries and is undergoing treatment at a private hospital in city.

Police said he is out of danger now.

'Sandeep and Mandeep are from Jind. Our teams raided Mandeep's house in Jind and his Gurgaon residence. The three men are absconding. Our teams have launched a manhunt to nab them," Gurgaon police spokesperson Sandeep Kumar said.

Monsoon gone, 7km drain network will be desilted soon

Gurgaon. To address waterlogging around Subhash Chowk and Sohna Road, GMDA will carry out the desilting of a 6.6 km drainage network.

At an estimated cost of Rs 3.3 crore, the project will involve cleaning the drainage network from Tau Devi Lal Stadium to Leg-III (Badshapur drain), covering Subhash Chowk and Marble Market in Sector 34 using super-sucker machines. Though GMDA has set a timeline of 10 months for the completion of the desilting work, the official said they will wrap up the work before the deadline to make the drainage system ready for the next monsoon season. This is the first major cleaning effort for this drain since 2018.

"The desilting of the drain along this stretch aims to facilitate the quick discharge of stormwater during heavy rains in the surrounding areas of Subhash Chowk and Sohna Road. Work has been allotted, and we are planning to complete desilting before the next monsoon season. CCTV inspection will also be conducted during the execution to ensure the quality of the work," a senior official of GMDA said. Subhash Chowk has been one of the worst-affected spots in the city, with severe traffic jams and waterlogging after even moderate rains. Commuters have been urging the authorities to find a

MCG takes pvt firm's help to clear Swachh test

Gurgaon: After finishing 140th out of 446 cities in the Swachh Survekshan rankings released in Jan this year—its worst performance since the rankings were introduced by the Ministry of Housing and Urban Affairs (MoHUA) in 2016—the MCG is gearing up for the next survey with a series of initiatives. On Tuesday, a special orientation workshop was held at the municipal office to provide detailed information and training for Swachh Survekshan, one of the largest urban sanitation and cleanliness surveys. To raise awareness about source segregation and waste minimisation, the MCG has hired a private agency. Planned initiatives include zero waste events, water plus initiatives, source segregation, interpersonal communication, waste-towealth activities, clean ward competitions, and selfreliant wards.

Rakesh Bhatt, an expert from the agency, said his team will provide technical assistance to the MCG, including data collection, fieldwork, document preparation, and information, education, and communication (IEC) activities. "The agency will focus on educating the public and promoting best practices in waste management to reduce overall waste generation in the city. This time, the corporation will ensure maximum citizen participation as part of a public movement,' Bhatt added. Under Swachh Survekshan, the MCG has identified 9,500 points in Gurgaon, divided into three categories: 5,705 points for service level progress, 2,500 points for certification, and 1,295 points for public movement activities. "Service level progress includes segregated waste collection, waste processing and disposal, and used water management," said an

On first day of GRAP, Rs 1L fine on pvt firm for road dust in Greater Noida

Noida. On the day stage I of GRAP came into effect in Delhi-NCR, the UP pollution control board slapped a Rs 1 lakh fine on a private contractor for dumping loose soil at the site of two under-construction foot overbridges near Jagat Farm and Kailash Hospital, in violation of rules set by the National Green Tribunal (NGT).

In 2013, Greater Noida Authority officials hired private agencies for the construction of eight overbridges. Lion India Limited, allotted the tender to construct the two overbridges on the busy Surajpur-Kasna Road, started the construction earlier this month.

A complaint submitted by residents said the construction of the two overbridges involved extensive excavation and the contractor had dumped the soil, thus dug up, uncovered by the roadside. This loose soil billowed clouds of dust into the air as vehicles passed by causing significant pollution, they said.Officials from pollution control board inspected the two sites on Monday and slapped penalties worth Rs 50,000 each on the firm for violation

CPR-SPR link plan on drawing board, Vatika Chk loop to help cut travel time

Gurgaon. GMDA is set to hire a detailed design consultant for the elevated corridor stretching from Vatika Chowk to the Central Peripheral Road (CPR)-Southern Peripheral Road (SPR) junction on NH-8. According to a GMDA official, the tendering process to engage the consultant is expected to be initiated within a month.The consultant will be responsible for the comprehensive design of the structure, cost estimation, and technical assessments."Technical aspects will be examined to study the feasibility of connecting the proposed corridor with the Delhi-Mumbai Expressway via an interchange loop at Vatika Chowk," said Arun Dhankhar, chief engineer of GMDA (infra-I).

The state govt approved the elevated corridor project in July this year, aiming at constructing a 5.5km signalfree stretch connecting the Dwarka Expressway with the Delhi-Mumbai Expressway."The Vatika Chowk

interchange will ease the commute from Dwarka Expressway or Jaipur towards Sohna or Faridabad or Delhi-Mumbai expressway," the official added. At present, those travelling on the mentioned route have to pass through Rajiv Chowk or Subhash Chowk. As per GMDA's proposal, the signal-free route will have a six-lane main carriageway, three-lane service roads on each side, 3-metre-wide footpaths, and 2.5-metre-wide cycle tracks. Additionally, the plan includes the development of green spaces along the corridor. The project, estimated to cost around Rs 750 crore, will see Rs 620 crore allocated for the construction of the elevated section, with an additional Rs 130 crore set aside for land acquisition at Vatika Chowk to ensure seamless connectivity with the Delhi-Mumbai Expressway and Sohna. The GMDA aims for the corridor's completion within two years of the project's commencement. The elevated corridor

was a revision of an earlier plan, where the proposal involved building eight flyovers on the 14 km stretch of SPR from Ghata T-point to NH-8 at an estimated cost of Rs 845.5 crores. However, after concerns over low traffic volume between Vatika Chowk and NH-8, the proposal was revised to elevate the 5.5 km portion, ensuring seamless travel from Shiv Murti in Delhi to the Delhi-Mumbai Expressway. The elevated corridor is expected to offer an alternative route to commuters and ease traffic congestion on critical routes like Golf Course Road and Sohna Road. To fund the project, the GMDA plans to raise Rs 63.9 crore from External Development Charges (EDC), Rs 262.7 crore from developers through the Town and Country Planning Department (T&CP), and Rs 336.2 crore via a cess on property and land. The remaining amount will be sourced through other revenue streams such as advertisement rights, according to officials.

Gir cage in Jhabua to capture Sariska tiger Gurgaon. Four weeks after a tiger from Sariska trekked more than 120km to take up residence in a small patch

of forest surrounded by wide open farmland at Jhabua in south Haryana's Rewari, the forest department has borrowed a cage from Gir National Park in Gujarat to trap the elusive cat and take him back to the Rajasthan reserve. The cage, a steel enclosure that is roughly the size of a 12x20 feet room, arrived in Rewari on Wednesday on a truck. The Haryana forest department has smaller cages, which are typically used to capture leopards that are

commonly sighted here. A tiger, however, is an entirely different proposition. It can be more than two times the size of a leopard, and therefore, needed a cage from Gir, which is home to lions. So far, the forest department has used calves as bait three times to pull the tiger into one of the smaller cages and tranquilise him. But ST-2303 thwarted the attempts made on Aug 21, 29 and Sept 4. It took the bait but swiftly retreated into thick foliage before foresters could shoot the tranquiliser dart. The tiger has made two attempts to return to Sariska, sneaking out of Jhabua at night to cross the border and reach Rajasthan, once on Aug 30 and again on Sept 7. On both occasions, it changed its mind and returned to Jhabua the next morning. With a large cage now available, the bait will be placed inside it, tied to steel bars at the opposite end from the trap door. Once ST-2303 enters, his weight should trigger the cage to snap shut." A spacious cage has arrived in Jhabua to capture the tiger safely. But it will not be an easy task," said AP Pandey, additional principal chief conservator of forests (south Haryana). Ghaziabad. The proposed Harnandipuram township will now be developed on 521 hectares, instead of the proposed 541 hectares, to skirt around a power substation and canopy areas of eight high-tension power lines.

GDA secretary Rajesh Kumar Singh said during a recent survey, the Authority found a power substation, spread over 10,000 sqm, at Nangla Ferozepur — one of the eight villages from where land is proposed to be acquired for the project."Eight high-tension powerlines also pass through the villages earmarked for the township. Earlier, GDA has proposed to acquire the highest of 247.8 hectares of land from Nangla Ferozepur and another 124 hectares from Shamsher. The six other villages from which land will be acquired are Shahpur Morta (54.2 ha), Bhowapur (53.3 ha), Champat Nagar (39.2 ha), Bhanera Khurd (11.8 hectares), Mathurapur (8.7 ha), and

Godrej Projects ordered to refund 4cr to homebuyers

Gurgaon: Country's apex consumer commission, NCDRC, has ordered realty major Godrej Projects to refund over Rs 4 crore to homebuyers in five separate cases for its failure to deliver its promises, which included a 24-metre-wide road and other essential amenities even seven years after making bookings. The homebuyers had booked flats in the 'Godrej Summit' project in Sector 104 in Gurgaon.

The National Consumer Disputes Redressal Commission (NCDRC) also directed the builder to pay 9% interest on the refund amount.

As per the orders, the NCDRC panel, led by presiding member Ram Surat Ram Maurya and member Bharat Kumar Pandya, held the builder accountable for "failing to deliver on its promises", particularly the construction of a 24-metre-wide road and other essential amenities that the builder had promised. The bench observed that even after the offer of possession, seven years have expired, but the promised road has not been constructed on the spot. It said expensive flats were sold representing that the project is connected with Dwarka Expressway through the wide road. Separate entry and exit points were also promised for each of the three parcels — A, B and C — in the society."The homebuyers agreed for sale price on these prime features. Now the OP (builder) has constructed an alternative entrance and exit gate to parcel A on 10.06 meters wide revenue road, which too is under encroachments. In order to reach the flats in parcel

Johnson & Johnson to pay \$15 million to man who blamed baby powder for cancer

Connecticut. Johnson & Johnson (J&J) must pay \$15 million to a Connecticut man who alleges that he developed mesothelioma, a rare form of cancer, as a result of using the company's talc powder for decades, a jury found on Tuesday. Plaintiff Evan Plotkin sued the company in 2021 soon after his diagnosis, saying he was sickened by inhaling J&J's baby powder. The jury in Fairfield County, Connecticut Superior Court also found that the company should pay additional punitive damages, which will be determined later by the judge overseeing the case. Evan Plotkin and his trial team are thrilled that a jury once again decided to hold Johnson & Johnson accountable for their marketing and sale of a baby powder product that they knew contained asbestos," Ben Braly, a lawyer for Plotkin, said in an email.Erik Haas, J&J's worldwide vice president of litigation, said in a statement that the company would appeal "erroneous" rulings by the trial judge that kept the jury from hearing critical facts about the case."Those facts show that the verdict is irreconcilable with the decades of independent scientific evaluations confirming talc is safe, does not contain asbestos and does not cause cancer," Haas said.Tuesday's verdict comes as J&J seeks to resolve claims by more than 62,000 people who say that they got ovarian and other



gynaecological cancers from talc through a nearly \$9 billion settlement in bankruptcy. The bankruptcy deal, which faces legal challenges from some plaintiffs' lawyers, has put the lawsuits over gynaecological cancers on hold, but does not affect the much smaller number of mesothelioma claims like Plotkin's. The company has previously settled some of

those claims but has not proposed a nationwide settlement.Plaintiffs in all of the lawsuits say that J&J's talc products, like its once iconic baby powder, were tainted with asbestos, a carcinogen known to cause mesothelioma and other cancers.

Several families in Punjab worried over India, Canada diplomatic fallout

CHANDIGARH. As relations between India and Canada have hit an all time low, after the diplomatic fallout now the parents and families of students and others from Punjab who have gone to Canada on study visas or currently working there are apprehensive on getting PR while those who got permanent residency or citizenship are anxious on how this might cause hindrance in travelling back to India.

Talking with this newspaper, the parents and others expressed lot of apprehension and were worried about the outcome of this diplomatic row between countries and how it will be effect their families and children, as they expressed the feared that they will face difficulties in securing visas to meet familes, children and relatives in Canada. Reacting to the fresh development, DP Singh who lives in Mohali has sent his children to Canada he is apprehensive that this deteriorating relationship should not have a negative effect on the permanent residency and citizenship of the children. " After spending so much the children have gone to Canada for higher studies and once they complete their studies they look to settle down there, but this present diplomatic row should not become hindrance in their permanent residency and afterwards citizenship," he says.

Canada-Another parent Jaswant Singh whose son and daughter are studying in Canada, says that the day by day the Canadian Government is tightening the grip on intentional students as they have changed the rules and regulations and not only that the students will now face more difficulties in getting permanent residency (PR) and thus they fear they might be deported back and students will then be forced to apply for refugee status.

US warns Israel to boost humanitarian aid into Gaza or risk losing weapons funding

WASHINGTON. The Biden administration has warned Israel that it must increase the amount of humanitarian aid it is allowing into Gaza within the next 30 days or it could risk losing access to U.S. weapons funding.

Secretary of State Antony Blinken and Defense Secretary Lloyd Austin warned their Israeli counterparts in a letter dated Sunday that the changes must occur.

The letter, which restates U.S. policy toward humanitarian aid and arms transfers, was sent amid deteriorating conditions in northern Gaza and an Israeli airstrike on a hospital tent site in central Gaza that killed at least four people and burned others. A similar letter that Blinken sent to Israeli officials in April led to more humanitarian assistance getting to the Palestinian territory, State Department spokesman Matthew Miller said Tuesday. But that has not lasted. "In fact, it's fallen by over 50% from where it was at its peak," Miller said at a briefing. Blinken and Austin "thought it was appropriate to make clear to the government of Israel that there are changes that they need to make again, to see that the level of assistance making it into Gaza comes back up from the very, very low levels that it is at today."For Israel to continue qualifying for foreign military financing, the level of aid getting into Gaza must increase to at least 350 trucks a day, Israel must institute additional humanitarian pauses and provide increased security for humanitarian sites, Austin and Blinken said in their letter. They said Israel had 30 days to respond to the requirements."The letter was not meant as a threat," White House national security spokesman John Kirby told reporters. "The letter was simply meant to reiterate the sense of urgency we feel and the seriousness with which we feel it, about the need for an increase, a dramatic increase in humanitarian assistance."An Israeli official confirmed a letter had been delivered but did not discuss the contents. That official, speaking on condition of anonymity to discuss a diplomatic matter, confirmed the U.S. had raised "humanitarian concerns" and was putting pressure on Israel to speed up the flow of aid

people a future that is inclusive and reflective of the shared aspirations of all member states," he said.Prime Minister Shehbaz highlighted, "We are at a historic moment of transition where sweeping transformations are reshaping the global social, political, e c o n o mi c, a n d s e c u r i t y landscape."He reaffirmed Pakistan's "commitment to regional peace, stability, enhanced connectivity, and sustainable socio-economic development."He also emphasized that the SCO "embodies the collective

voice and wishes of over 40 percent of the global population, anchored in the Shanghai spirit.""Your presence here today underscores our shared commitment to fulfilling the aspirations of our people by ensuring collective security and enhancing mutually beneficial cooperation for the sustainable development and prosperity of the SCO region," he stated.He called the summit a testament to the strength of ties and collaboration among the SCO's diverse nations."Together, we have the potential to drive socio-economic progress, enhance regional peace and stability, and improve the quality of life for our



citizens," the premier said. Imran Khan isolated in dark cell, no calls to sons, jail cook on leave: Ex-wife

World Jemima Goldsmith, the former wife of Pakistan's jailed ex-Prime Minister Imran Khan, has levelled some serious allegations against the Shehbaz Sharif-led government. She claimed that her former husband was being kept in solitary confinement with authorities cutting off the electricity supply in his jail cell and was no longer allowed to make weekly calls to his

Goldsmith's allegations come as the Pakistan government is hosting the ongoing two-day SCO Summit in Islamabad, which has drawn top leaders from member states, including External Affairs Minister S Jaishankar, and turned the capital city into a fortress.In the days leading to the summit, authorities also arrested hundreds of Imran Khan's supporters who attempted to march in Islamabad, demanding his release.In a social media post on Tuesday, Goldsmith, who was married to Imran Khan from 1995 to 2004, alleged that the Pakistani authorities have postponed all court hearings and also completely stopped



visits by the former Prime Minister's friends and family.Khan is presently lodged at the Adilala Jail in Rawalpindi, following his arrest on August 5, 2023. "In addition to cutting off in-person visits, and in defiance of a court order, his weekly calls to his sons, Sulaiman and Kasim Khan, who are British and who live in London, were stopped on September 10," she said, while

referring to the couple's two sons. We have received reports that the authorities have now turned off the lights and electricity in his cell and he is no longer allowed to leave his cell at any time. The jail cook has been sent on leave. He is now completely isolated,

in solitary confinement, literally in the dark, with no contact with the outside world. His lawyers are concerned about his safety and well-being."

Goldsmith further alleged that the Pakistan government was not only mistreating Imran Khan, but also other members of his family in an "attempt to silence them and all political opposition"."Imran's nephew, Hassan Niazi, a civilian, has been detained in military custody since August 2023. More recently, Imran Khan's sisters, Uzma and Aleema Khan, who have continued to speak out on his behalf, have also been arrested as they made their way peacefully to a demonstration, and they are currently being held in jail, despite there being no proper or lawful basis for their imprisonment," she said, while calling for all of their release. Imran Khan, 72, served as Prime Minister from 2018 to 2022, when he was ousted in a parliamentary no-confidence vote after falling out with the powerful military establishment considered Pakistan's political kingmakers.

World Canadian Sikh leader Jagmeet Singh, a former ally of Prime Minister Justin Trudeau, was ridiculed by journalists when he called for sanctions on Indian diplomats and walked out of the press conference as he faced a volley of tough questions from reporters amid an escalating diplomatic row between the two countries."We need to bring severe sanctions on Indian diplomats. We got the RCMP saying that Indian diplomats are hiring criminal elements to shoot at Canadians. I mean why would we do sanctions on Indian diplomats," Jagmeet Singh, a known Khalistani sympathiser, and the leader of the New Democratic Party (NDP) said."The Modi government has to be held accountable and we all need to be unified as Canadian leaders. All of us have to be unified in denouncing (PM Narendra) Modi, making sure we protect Canadians by putting their safety first and foremost," he said before ending his press conference.As Jagmeet Singh was walking out of the room, some journalists tried to raise their questions to him, with one of them mocking the leader, saying, India also said Trudeau's hostility to India "That's not how it works," drawing laughter from the audience. The

development came after the Royal Canadian Mounted Police (RCMP) claimed that Indian agents present in Canada were working with the Lawrence Bishnoi gang to target pro-Khalistan elements.Jagmeet Singh had supported Trudeau's Liberal government for over two years before pulling the plug last month, accusing the Canadian Prime Minister of not fulfilling his promises. Two held for derogatory comments on Surekha

HYDERABAD. The Cyberabad cyber crime police on Tuesday apprehended two persons for allegedly posting derogatory comments on social media against Medak MP Raghunandan Rao and Forests and Environment Minister Konda Surekha.

The accused, Devanna and Mahesh, were apprehended from their hometown, the Cyberabad cybercrime police said. While Devanna is a former sarpanch from Nizamabad, Mahesh is a businessman from Jagtial. On September 3, the MP lodged a complaint with the cybercrime police against six persons for defaming him and outraging the modesty of the minister. In his complaint, Raghunandan Rao said that Konda Surekha, who is also the in-charge Minister for the erstwhile Medak district, attended the Shaadi Mubarak programme at Dubakka on September 26.

During the event, the MP and the minister distributed Shaadi Mubarak cheques to the beneficiaries. Later, the MP placed a cotton garland, which was handwoven by the Dubakka weavers' community, around the minister's neck.

However, this act triggered derogatory posts and comments on social media platforms. The MP named six individuals - M.R. (X handle), Mahesh Anumulla, Mohd Moizoddin, SouthPaw (X handle), Jai Telangana (X handle) and Devesh Konapur (X handle).

These individuals spread this defamatory content on various platforms, including WhatsApp, Facebook, Instagram and other social media channels, allegedly at the instigation of T Harish Rao, KTR and other BRS party leaders," read the complaint letter. The MP claimed that this act was deliberately done to damage the reputation of the two leaders. The Cyberabad Cyber Crime police booked a case under Sections 79 (insult to modesty of woman), 356 (defamation) of BNS and 67 of the IT Act.

BENGALURU. With increasing incidents of urban flooding in metros like Bengaluru, Delhi, Chennai and Mumbai, the parameters for urban flooding have been changed.

A senior official from the India Meteorological Department said, "Now when rainfall forecast is of 5 cm or less, we issue a vellow alert, asking government agencies to stay on alert and citizens to stay indoors. Earlier, the advisory and alert used to be issued when the rainfall forecast was for 7 cm."

As the number of incidents of urban flooding are increasingly being reported in multiple places, including Bengaluru, for the safety of citizens, the Ministry of Earth Sciences, Delhi, and IMD, Pune, directed changing the parameters for yellow alert, the official said.

'Since there are no drains and no proper management for rainwater, the disaster management officials have also agreed to the change in the parameters and definition. We are also deliberating if the parameters for issuing alerts and caution can be altered based on cities," the official added.

IMD officials said the new parameters have been followed for the last two-three months. While there has not been heavy rainfall in Bengaluru, in other cities, the change in announcements and alerts has helped citizens.

Cybercrime cops refund Rs 38 lakh to victim



HYDERABAD. In case you fall victim to cyber fraud, register a complaint at the earliest so that the chances of recovery of lost money are higher, the cybercrime police insisted.

In a recent case, the Hyderabad cybercrime police helped in refunding '39 lakh to a 34year-old man who had lost '78 lakh in a stock trading fraud. The victim was allegedly cheated by cyberconmen who approached him under the pretext of helping him with stock trading. Trusting the fraudsters, the victim transferred a total of '78.70 lakh to several bank accounts provided by the accused persons.

However, once the victim realised that he was tricked by the fraudsters, he filed a complaint with the cybercrime police, who registered a case and quickly sprung to action. In light of the recent refund case, the DCP said, "There is a possibility to get a refund of at least part of the lost and 'put on hold' amount, if it is reported immediately." She requested victims of cyber fraud to report immediately through the helpline number 1930 or file a complaint on the national cybercrime reporting portal.

Family escapes unharmed as car catches fire on NH-16

Meanwhile, helping hand extended by city hotel Crown located close to the national highway, assisted fire services personnel in containing the blaze effectively and reducing the risk on other vehicles moving on the route.

Crown IHCL SeleQtions director Debasish Patnaik said swift action was taken after they came to know of the incident. "We laid down the hose pipes till the mishap spot immediately and also extinguished the fire to a significant extent using the

Kerala govt removes NSS coordinator; to kickstart selection as per manual

THIRUVANANTHAPURAM. In the run-up to the appointment of a state programme coordinator for the National Service Scheme (NSS) Higher Secondary wing as per the NSS manual, the state government has removed the incumbent officer who was given repeated extensions to the key post, in violation of rules, since 2017.

TNIE had reported that the continuance of Jacob John as state coordinator constituted a violation of the conditions laid down in the NSS manual and would affect the Union Government's assistance to the scheme. In an order issued on Tuesday, the government gave temporary charge of NSS state programme coordinator to the Joint Director (Academic) of the Higher Secondary wing. According to sources, a regular appointment will be made to the post through a proper selection process, as laid down in the rules.

As per the rules, the Plus-II level state programme coordinator has to be appointed on deputation/short-term contract for three years and could be extended by one more year subject to satisfactory performance. Citing RTI documents, TNIE had reported that John was appointed to the post six times, of which four orders issued by the Higher Education Department pertained to the extension of his tenure for one year each.

As per the NSS manual, the upper age limit of the state programme coordinator is 50 years at the time of selection. John, who is well above the upper age limit, is ineligible for reappointment or extension of tenure. However, the officer's proximity to the LDF dispensation is cited as the reason why he has not been replaced. With 1,570 units and 1.4 lakh volunteers, the higher secondary wing is the biggest NSS cell in the state and receives the largest chunk



48-year-old man sets himself ablaze at Kerala's Poojappura, suffers severe burns

The injured has been identified as Baiju, a native of Karakulam. Poojappura police sources said the man set himself ablaze after pouring petrol. Baiju had domestic issues with his wife, who later left him. After break-up, the woman stayed at the Mahila Mandiram at Poojappura for a while and later left the place.

Unaware of his wife leaving the place, Baiju arrived at the Mandiram with his two children and demanded to meet her. When he was turned away, Baiju reportedly bought petrol and poured it overhead. Seeing this, the locals informed the police and the fire and rescue services. However, he set himself on fire when they arrived. A civil police officer sustained burns on his hand while trying to prevent Baiju from setting himself on

Baiju reportedly sustained 70 per cent burns and is in a serious condition. He has been admitted to the Medical College Hospital.

The Medical College authorities denied the allegation that there was laxity in attending to the patient at the casualty. They blamed the ambulance driver for trying to dump the critically ill patient before the casualty block. "The ambulance driver dropped the patient at the portico and tried to make him walk. There was no lapse on the part of the hospital staff. As soon as they came to know about the condition of the patient they arranged for a clean trolley as it was a burns patient. He was immediately shifted to the burns ICU," said hospital superintendent Dr B S Sunilkumar. He said the resident medical officer checked the CCTV footage and found no lapse on the part of the staff.

What kind of military power does India need

SOME unrelated events of the last week draw attention to India's modest trans-border military (TBM) capability and the manner in which certain disruptive technologies are impacting the conduct of war. The military operations in the ongoing Russia-Ukraine war (that began in February 2022) and the spiral of violence triggered by the Hamas terror attack on Israel (in October 2023), now roiled by the entry of Hezbollah and Iran, testify to the latter trend to a certain degree. Some preliminary policy inferences can be drawn that are relevant for India. The first development pertains to the October 9 Cabinet Committee on Security approval for the acquisition of two nuclear propelled submarines (SSN); these platforms are also referred to as attack-submarines or hunter-killers. They will be indigenously designed and built at Visakhapatnam. This is a major policy decision and an ambitious one at that.

India was yet to acquire the requisite level of technological competence to design and build a conventional diesel-electric submarine, but yet it had moved straight to design and build a SSBN (a nuclear powered submarine with nuclear-tipped ballistic missiles) — the INS Arihant. The SSBN has a strategic role, which is to ensure credible second-strike capability to render nuclear deterrence more robust. India joined this select group of nations in 2018, one which includes the USA, Russia, the UK, France and China.

After a long gestation period of almost 17 years since the acquisition of an SSN was first mooted, India is now embarking on the project, though this approval has to be followed by adequate budgetary allocations. An SSN is a totally different platform by way of technological features and as is the case with the first type of any naval platform, the journey will be long, arduous and expensive. The two SSNs are reported to cost Rs 15,000 crore each, though this is an initial estimate. When these two boats enter service in an operational manner — with full ordnance package, which means submarine-launched missiles — India will have a credible underwater capability, wherein the SSN can be tasked with attack, surveillance and special operations roles, depending on the tactical exigency. In essence, the SSN can remain on extended underwater 'prowl' and unfriendly navies will have to factor this capability when operating in maritime areas of relevance to India.n the same week, on October 7, the CCS also approved phase III of the Space Based Surveillance system (SBS), which will allow India to launch 52 spy satellites in low earth and geostationary orbits. Expected to cost Rs 27,000 crore, the trans-border surveillance capability of this cluster will be enhanced by artificial intelligence and give a fillip to India's comprehensive TBM index.Air power is a core element of a nation's TBM capability and this aspect came into focus with the assumption of office by the new air chief, Air Chief Marshal Amar Preet Singh, who took over in end-September. During the traditional media interaction in the run-up to the Air Force Day on October 8, ACM Singh noted the gap between India and its principal strategic challenger, China, in the air power domain and dwelt on the need to ramp up domestic production of fighter jets to redress dwindling numbers. Moreover, he said, his first effort would be not to allow "the fighter aircraft strength go down below 30 squadrons' and that HAL should stick to its promise to deliver 24 aircraft every year to bridge the numbers gap.

The 30 squadron figure has to be seen against the aspiration of the IAF to have 42 fighter squadrons to deal with a two-front operational requirement against China and Pakistan. This number was arrived at after the 1965 war with Pakistan; and none other than the legendary JRD Tata, an accomplished pilot and founder of Air India, was a member of the group that made this assessment.

The manner in which air power has been transmuted is evident in the Russia-Ukraine war as well as the violence in West Asia, where the use of relatively less expensive unmanned drones and missiles/rockets have replaced the once-familiar deployment of fighter aircraft and long-range

Himachal's financial struggle in a centralised system

Minister JP Nadda has made claims regarding the fiscal crisis in Himachal Pradesh. Nadda has argued that the state government, led by Chief Minister Sukhvinder Singh Sukhu, is financially dependent on the Central government. He has claimed that Rs 500 crore was being provided as a fiscal deficit grant, with an additional Rs 800 crore given monthly to keep the state financially afloat. However, these statements are not merely a reflection of the fiscal concerns but also a political attack on the Congress-led Himachal government, raising questions about the state's fiscal management. Nadda's comments can be seen as part of a broader trend of undermining fiscal federalism in India, particularly targeting smaller states like Himachal Pradesh.But do the smaller

Himalayan states truly depend on the Centre

for survival? And why has fiscal centralisation intensified in recent years? Himachal Pradesh ranks just below Kerala in terms of human development indices, thanks to successive governments which have invested heavily in education and social welfare. By the mid-1980s, the state had achieved full electrification despite its low population density and challenging terrain. Human resource development has been a significant driver of growth even though the state has remained industrially underdeveloped.Himachal Pradesh also contributes significantly to national resources, particularly in water and electricity generation, thanks to its large reservoirs and hydroelectric power stations. However, this has come at the cost of environmental degradation in the state. While the state's expenditure on social welfare remains high, it plays a vital role in national infrastructure. The financial landscape of India over the last decade has increasingly shifted towards centralisation, weakening the fiscal autonomy of states. Contrary to Nadda's assertions, the Centre's financial assistance is not an act of mercy but rather a constitutionally mandated part of India's federal structure. Article 270 of the Constitution outlines the distribution of taxes collected by the Union between the Centre and the states, based on the Finance Commission's recommendations. These taxes include corporation

However, the BJP leader's claim ignores the larger issue of cess and surcharge, which are collected by the Centre but not shared with the states. In 2024-25, cesses and surcharges are estimated to constitute 23 per cent of the Central government's gross tax



receipts, depriving the states of their share. The total tax revenue for 2022-23, 2023-24 (revised estimates) and 2024-25 (budget estimates) are projected to be Rs 30.5 lakh crore, Rs 34.4 lakh crore, and Rs 38.8 lakh crore, respectively. Of this, the states' share will be only Rs 9.5 lakh crore, Rs 11.0 lakh crore, and Rs 12.2 lakh crore. It is significantly lower than the 41 per cent share recommended by the 15th Finance Commission.

Initially meant for specific, temporary purposes, cesses and surcharges have now become permanent fixtures in India's tax system. The share of cesses and surcharges in the Centre's gross tax revenue increased from 10.4 per cent in 2011-12 to 20.1 per cent in 2020-21. This shift has eroded the share of taxes devolved to states, significantly affecting their revenue. Even though various finance commissions have repeatedly advised that cesses and surcharges be levied sparingly, the Central government has increasingly relied on these measures. States have little-to-no control over these revenues, which are often used for Centrally-sponsored schemes. This has undermined the spirit of fiscal federalism, leaving states with reduced fiscal independence.

For example, the GST compensation cess, intended to cover shortfalls in tax collection after the GST's introduction, is being used primarily to repay loans taken for compensation purposes. The Centre's

reliance on these levies has not only weakened the financial position of the states but also raised concerns about the transparency and accountability of how these funds are used. Does the given fiscal architecture mean that the larger game plan is to destabilise the Opposition-ruled state governments

in the country?JP Nadda, hailing from Himachal Pradesh and having served as a Cabinet minister in the state, should recognise the unique fiscal challenges faced by the mountain states. Himachal, which shares an international border, has particular fiscal needs and requires special attention from the Centre. After achieving statehood, Himachal enjoyed a strong partnership with the Central government, which facilitated its remarkable developmental progress. This collaboration was built on mutual trust and shared responsibility for development, not on condescension or political ridicule. If Nadda truly wants to help HP, he should advocate for the state's rightful demands rather than demean it for political purposes. HP's fiscal concerns are longstanding and deserve attention. They include issues related to the Bhakra Beas Management Board (BBMB), the Punjab Reorganisation Act and the water cess dispute — all of which have significant financial implications for the state. The Supreme Court has upheld Himachal's claims in these matters. The Central government should work to resolve them fairly. Himachal Pradesh is not merely surviving on the Centre's largesse; it is an integral part of India's development, contributing to national resources while balancing its own fiscal needs. The state has made considerable progress in human development, largely through its investments in education, health and social welfare. However, the increasing centraliaation of fiscal powers, particularly through cesses and surcharges, has limited the state's financial independencFor fiscal federalism to thrive, the Centre must recognise the importance of states like Himachal and work collaboratively to address their concerns. Restoring the balance between the Centre and the states that ensures a fair distribution of resources is essential for the long-term development of India's federal system.Rather than perpetuating political attacks, the Centre should focus on promoting the rightful fiscal interests of Himachal Pradesh and fostering a more cooperative approach to governance.

It is essential to guard against a citizen versus citizen binary the people suffer? The normalisation of disruption is a taking root. than five people. This is unimaginable in Punjab. That is why we must further nurture the tradition of talking truth to power, but not at the cost of societal disjointedness.

Young doctors must introspect, too

They should also raise their voice against the dehumanisation of modern biomedical system

AS I write this piece from Kolkata, I see young doctors In fact, the power discourse implicit in the hegemonic coming to the street, raising their voice, exposing the huge network of corruption, or the tyranny of 'threat culture' that operates in government hospitals in West Bengal, and demanding safety and protection in their workplaces. Will it be possible for young doctors to feel somewhat uneasy with the way their profession has been transformed into a trade or a profit-making business? Yes, their determinism, or their courage to fight the ruling political establishment, is indeed praiseworthy. Yet, I feel like appealing to them and their senior colleagues to widen their horizons, become sufficiently self-reflexive, and also critically examine the discontents of the hegemonic biomedicine — its power discourse, its commodification, and innumerable malpractices associated with it. Well, I too adore doctors; and I am aware of the remarkable achievements of modern medicine. Take insulin, control your diabetes, and lead life reasonably smoothly; or, go for a knee replacement surgery, and walk once again confidently — yes, the heroic tales of modern medicine can be heard in every household. But then, these achievements notwithstanding, I cannot deny my ambivalence, and even some serious critique of the modern biomedical establishment. And I want young doctors-particularly, because they have not yet lost their critical thinking, to reflect on this critique, and give a new meaning to their struggle. Well, young doctors need to reflect on the prevalent politics of knowledge. Isn't it a fact that it is fairly easy to debunk 'traditional' medical systems like ayurveda, unani or homeopathy? If, as a patient, you dare to speak of the discontents of the modern biomedical system, you are likely to be reminded that you are merely a layperson; and hence, it would be better to accept everything your doctor suggests or prescribes.

biomedicine, as Ivan Illich articulated with great insight in his classic 'Limits to Medicine', "disempowers the patient." But then, as a patient, you are not just a discrete body with a set of measurable parameters (say, your blood culture, or the findings of

your biopsy report); you are also a living soul with consciousness and agency; and you might have your own choice regarding the way you wish to live or die.

protesters and public alike.

Should you pass through a painful process of chemotherapy in the ICU of a superspecialty hospital, and live with a faint hope that you might get temporary relief from the pain of 'acute myeloid leukemia', and survive for another two months?

Or, should you refuse to reduce yourself into an object of experimentation and choose to go back to your home, and eventually leave the world amid the presence of the loved ones in your own bedroom?

Nobody — not even the best doctors with the power and aura of 'scientism', and the technology of artificial life-support systems -- should be allowed to deprive you of your choice or your agency.

However, the irony is that because of the hegemonic biomedicine, and, to use Illich's words, the resultant "medicalization of death", most of us seem to have lost our control over the experience of living and dying. Not to say 'yes' to everything the doctors and associated pharmaceutical industry suggest is often ridiculed as an act of irresponsibility, or a demonstration of one's 'anti-science' temperament! Likewise, will it be possible for young doctors to feel

somewhat uneasy with the way their profession has

been transformed into a trade or a profit-making business? Of course, doctors need to earn and live a decent life. But then, we are witnessing how, because of the absence of good facilities in our overcrowded Is it the reason why middle class parents are willing to government hospitals (don't forget that public health spending for financial year 2024 is merely 2.2 per



cent of the GDP), corporate super-specialty hospitals do not hesitate in selling 'good health' as a commodity with an 'appropriate' price list — say, ICU: Rs. 90,000 per day; or deluxe room: Rs 75,000 per day; or attractive 'packages' or 'discounts' for bypass surgery and kidney transplant. No wonder, health insurance companies seek to "bring smiles to happy consumers", and advise you "not to worry about cost limit, and focus only on your recovery"!

However, if you acquire the courage to keep your eyes open, you can easily see the speedy transformation of a noble profession into an ugly trade involving the

chain of corporate hospitals and nursing homes, allpervading health insurance companies, and, above all, the \$65-billion pharmaceutical industry.

sell their property, and send their children to dubious private medical colleges so that they can become

'doctors'? And, finally, should the practitioners of modern biomedicine recognise the social/economic dimension of disease and illness? For instance, can a doctor cure your chronic bronchitis only through costly medicine, if you are constantly exposed to polluted air because of vour social location as a construction worker or a labourer in a coalmine? Or, for that matter, can even the best doctor help you to free yourself from the recurrence of stomach ailments and jaundice, if the state fails to provide clean and safe drinking water to the slum you live in and you don't have the money to buy

heavily priced filtered water bottles? Possibly, 'valueneutral' medical science does not want to ask difficult social/political questions; instead, it is easier to see the patient as just a 'discrete' body and ask him to go to clinical labs for a battery of 'tests' he can seldom afford!Yes, as Kolkata has demonstrated, young doctors are bold enough to protest for their rights and dignity. But then, will it be altogether wrong if you and I expect some amount of self-introspection from them so that they can also raise their voice against the pathology that has dehumanised the modern biomedical system?

The reason is that Mexico's capital is 7,350 ft (2,240 m) above sea level, making it the eighth-highest capital city in the world and the highest in North America. Oh, and that's another thing: Mexico is part of North America, not South America or Central America as many people

South of Mexico City there are canals in an area called Xochimilco. Here, the Aztecs built fertile banks on the lake, in which they grew one-third of the produce needed to feed the city. These canals stood the test of time and still exist today. Nowadays, you can rent a colourful boat called a trajinera and float down the canal with friends, enjoying the music of mariachis and a cold beer or two.

9. You're unaware that it's the city with the most museums in the world.

According to the National Council for Culture and Arts, Mexico's capital has more museums than any other city. Whatever your interest, be it archaeology, art, toys, or even chocolate, you'll find a museum or two or three for you.

10. You didn't know there's an Aztec pyramid right in the heart of the city.

Right in the main square next to the cathedral is the Templo Mayor-huei teocalli in Nahuatl, the language of the Aztecs (or Mexica, as they were known). The Spanish built their cathedral on top of the temple, but years later, parts of the temple were excavated by archaeologists. Still, much of the Aztec city of Tenochtitlan remains buried, often discovered as new metro lines are built underground.

Istanbul

Istanbul, the largest city in Turkey and the fifth-largest city in the world by population, is considered European, yet it occupies two different continents. One part of Istanbul lies in Europe and the other part lies in Asia. Istanbul's European part is separated from its Asian part by the Bosphorus strait, a 31-km-long waterway that connects the Black Sea with the Sea of Marmara, and forms a natural boundary between the two continents. Two suspension bridges across the Bosphorus—the Bosphorus Bridge and the Fatih Sultan Mehmet Bridge, also called Bosphorus Bridge II-connect the two sides, yet many tourists prefer to visit

the European side of Istanbul because of its historical significance. The European side is also the city's commercial center with banks, stores and corporations and two-third of its population. The Asian side feels more relaxed, with wide boulevards, residential neighbourhoods and fewer hotels and tourist attractions. Istanbul is one of the few cities in the world to be shared by two continents. Examples of other cities that are half-European and half-Asian include the Russian cities of Orenburg and Magnitogorsk, and Atyrau, a city in western Kazakhstan. Similarly, Suez, an Egyptian city straddling the Suez Canal, belongs to both Africa and Asia. But Istanbul is by far the largest, and the only metropolis in the world to do so.

Being the only water route between the Mediterranean Sea and the Black Sea, the Bosphorus has been the site of significant settlements and cities for a long time. Of particular importance is the Golden Horn, an estuary that joins Bosphorus Strait at the immediate point where the strait meets the Sea of Marmara, and forms a large, sheltered harbour. It was here, on the European side of



the Bosphorus, that the city of Byzantium (which later became Istanbul) was founded by ancient Greeks around

When Constantine the Great became the Roman emperor, the city was renamed Constantinople in 330 AD. For the next sixteen centuries, Constantinople served as the capital of the Roman Empire, the Byzantine Empire, the Latin Empire and the Ottoman Empire. During this period, over 120 emperors and sultans ruled over this land. Istanbul was a Christian city during Roman and Byzantine times, before the Ottomans conquered the city in 1453 and transformed it into an Islamic stronghold and the seat of the last caliphate. After the Turkish War of Independence, the modern Republic of Turkey was established in 1923, and although Ankara was chosen as its capital, the city did not lose its significance. Many palaces and imperial mosques still line Istanbul's hills as visible reminders of the city's previous central role. Today, Istanbul is a huge metropolis connecting continents, cultures, and religions. Home to 15 million people, it is one of the greatest business and cultural centers



Why Lawrence Bishnoi is at the centre of India-Canada row over Nijjar killing

Amid its diplomatic row with India, Canada has accused the PM Narendra Modi-led government of colluding with the Bishnoi gang to carry out criminal operations even though it has not provided any concrete evidence.

New Delhi:Lawrence Bishnoi, the dreaded gangster imprisoned in Ahmedabad's Sabarmati Central Jail, has emerged as a new focal point in the India-Canada diplomatic row. The Royal Canadian Mounted Police (RCMP) has accused India of colluding with his gang to carry out criminal operations in Canada even though it has not provided any concrete evidence.A Washington Post report claimed that National Security Adviser (NSA) Ajit Doval held a secret meeting with his Canadian counterpart in Singapore,

where they discussed Bishnoi's alleged involvement in the killing of Khalistani terrorist Hardeep Singh Nijjar in Canada.India has strongly rejected these accusations, dismissing Ottawa's claims of New Delhi's involvement in the murder as a "deliberate strategy to smear India for political gain".

HARDEEP NIJJAR'S MURDER AND BISHNOI GANG



On June 18, 2023, Hardeep Singh Nijjar was shot dead outside a gurdwara in British Columbia, Canada. Three sharpshooters fired 34 rounds at him. Nijjar, designated as a terrorist by India's National Investigation Agency (NIA), had a Rs 10 lakh bounty. He was accused of carrying out targeted killings of Hindu leaders in Punjab in collaboration with Pakistan's intelligence agency, ISI, and had been involved in terrorist activities in Punjab. Intelligence agencies also reported that Nijjar had undergone traning in

Pakistan. Almost a year later, in May 2024, Canadian police arrested four men of Indian origin -- three initially and one later -- in connection with the murder. Karan Brar and Kamal Preet Singh, both 22, along with 28-year-old Karan Preet Singh, reportedly confessed to the killing, according to Canadian officials. A fourth suspect, 22-year-old Amardeep Singh, was later arrested and also claimed involvement in the murder. All four had arrived in Canada on student visas and were staying there. Before the police made any official statement, a Canadian newspaper reported that the four arrested men were linked to the Lawrence Bishnoi gang. The report claimed that Bishnoi's men, allegedly at the behest of India's Research and Analysis Wing (RAW), carried out Nijjar's murder by sending four shooters from Punjab to Canada. On October 15, amid reports of the Bishnoi gang's hand in the murder of an NCP leader and former

Canada reiterated that Indian agents working with the Lawrence Bishnoi gang were targeting pro-Khalistan elements. However, the Canadian police have yet to provide any concrete evidence beyond the names of the four men from Punjab.According to Canadian authorities, members of the Bishnoi gang were also responsible for the killing of another Khalistani terrorist, Sukhdool Singh, in Winnipeg, Canada, in September last year. Sukhdool Singh, also known as Sukha Dunike, had fled India and was associated with the rival Bambiha gang. The Bishnoi gang later took responsibility for the murder, declaring, "We will find and eliminate our enemies, wherever they may be". An official from India's intelligence agency stated that many gangsters and terrorists from Punjab flee to Canada, where they are given refuge by the government. According to him, a gang war is going on between.

Punjab Should Declare Itself Helpless": Supreme Court On Delhi Air Pollution

New Delhi: The Supreme Court - as Delhi faces (predictably) worsening air pollution levels in the city and the national capital region - slammed the Punjab and Haryana governments Wednesday, calling them out for failing to act on June 2021 orders to prosecute violators of anti-pollution laws. The court seemed to dare the Punjab government to declare itself "helpless" to deal with multiple violations. "Let them declare 'we cannot do anything... we are helpless," it said, as it noted that Punjab and Haryana - ruled by the AAP and BJP, respectively - had not prosecuted violators, particularly farmers burning stubble, or agricultural waste, since 2021, and only imposed nominals fines. The Commission for Air Quality Management - the central government panel that had issued orders to prosecute pollution law violators - was also criticised. It was called a "toothless wonder" for failing to enforce its own orders and its members' competence was questioned.

A bench of Justice Abhay S Oka, Justice AG Masih, and Justice A Amanullah - hearing the issue of noncompliance with CAQM directions - set a one-week deadline to prosecute violators."Why is there no prosecution for violation of orders? This is not a political issue... it is about implementation of statutory directions by CAQM under Section 12..." Justice Oka said"We will take penal action against (CAQM) officers... only then there will be action. No political considerations will apply here," he added, as the court called out the Haryana government over nearly 200 recorded cases of farm fires for which "only nominal fine has been recovered". The court pointed out states were fed detailed information - by the Indian Space Research Organisation - about the location and size of fires caused by burning farm stubble.

'So you cannot say locations were not found... but nobody is going to prosecute, nobody is going to take action (against the violators)," he continued, "They will pay a nominal fine...""What is all this going on?" an angry court asked, also demanding to know if prosecution was being halted or slowed "at the instance of somebody else". "... we will issue summons to them also. What is this hesitation in prosecuting people?" the court asked of the state governments. Earlier this month too, the CAQM was slammed for "total non-compliance" with the law."Have committees been constituted? Please show us a single step taken... show us a single direction issued..." the court said, unimpressed when told the CAQM meets once in three months.

New Delhi:The Supreme Court on Wednesday reprimanded Punjab and Haryana over the issue of stubble burning, stating that no effective action has been taken by the states to address the problem, which exacerbates air pollution levels in Delhi and its neighbouring regions during the winter season. Noting that there has been a substantial increase in stubble burning cases in both the states and calling it an "absolute defiance" of

direction by the Commission of Air Quality Management (CAQM), the court summoned Haryana Chief Secretary on October 23."We see that the affidavit by Haryana is full of non-compliance. We direct Commission to take penal action against State Officers under Section 14. We direct Chief Secretary Mr Prasad to be physically present on next Wednesday. Commission will make statement about coercive action taken against State officials. Chief

Secretary holds an explanation to court not only for non-compliance but also for not taking stringent action against violators," Justice AS Oka said. The Supreme Court was hearing a case of

SpiceJet meets DGCA's safety norms, out of enhanced surveillance regime

NEW DELHI. In a major relief for SpiceJet, aviation regulator DGCA on Tuesday said it has removed the low-cost carrier from enhanced surveillance regime. This actions comes as the regulator is satisfied that SpiceJet is taking actions to rectify deficiencies following the fundraising. The Directorate General of Civil Aviation (DGCA) had placed Spicejet under enhanced surveillance on September 13, 2024 over a severe cash crunch at the airline which had impacted its ability to discharge mandatory obligations of aircraft maintenance. This action had resulted in increased spot checks and night surveillance to ensure the safety of the airline's operations. DAGCA said 266 spot checks were conducted at various locations as part of monitoring effort. It said deficiencies identified during these checks were addressed appropriately by the airline.

'In light of the same and the financial infusion of additional funds into the company, SpiceJet has been taken off the enhanced surveillance regime," DGCA said in a statement. DGCA will continue to carry random spot checks across the airline's operational fleet to ensure safety standards. Since the enhanced surveillance was placed, SpiceJet has successfully raised Rs 3,000 crore via sale of shares to qualified institutional buyers. It is using this money to pay lenders and expand its fleet. SpiceJet said on Tuesday it has settled a \$23.39 million dispute with Aircastle (Ireland) Designated Activity Company and Wilmington Trust SP Services (Dublin) Limited for an aggregate sum of \$5 million, together with agreement in relation to the treatment of certain aircraft engines. This came a day after it was reported that SpiceJet is staring at fresh insolvency proceedings initiated by aircraft lessor Aviator ML 29641 Ltd over unpaid dues amounting to Rs 58 crore. The lessor claimed that SpiceJet failed to pay rental charges for a Boeing 737 that it had leased. Creditors

Much appreciated: Elon Musk on Centre confirming no spectrum auction

New Delhi. Starlink CEO Elon Musk reacted to the announcement made by Telecom Minister Jyotiraditya Scindia denying spectrum auction in India and said that the move is 'much appreciated' on Wednesday. In a recent announcement by Telecom Minister Jyotiraditya Scindia, confirmed that India would allocate spectrum administratively, following global norms.Responding to the news, Musk took to \vec{X} (formerly Twitter) and said, "Much appreciated! We will do our best to serve the people of India with Starlink." Musk had previously been vocal about his stance against the auction of satellite spectrum, a position that contrasts with the preferences of Indian telecom giants like Mukesh Ambani's Reliance Jio and Sunil Bharti Mittal's Bharti Airtel.

INDIA FOLLOWS GLOBAL **PRACTICES**

During the announcement, Telecom Minister Scindia explained that India's decision aligns with international standards."Satellite spectrum across the

world is allocated administratively. So, India is not doing anything different from the rest of the world," Scindia said, clarifying the government's stance. The decision to adopt the administrative allocation of spectrum comes after Elon Musk and his company Starlink, along with other global satellite players such as Amazon's Project Kuiper, voiced their support for this method. According to Musk, the International Telecommunication Union (ITU), a United Nations agency, classifies satellite spectrum as shared, and therefore, it should not be auctioned. India is a member of the ITU, which further administrative allocation.

MUSK'S CRITICISM OF SPECTRUM **AUCTIONS**

The debate over how satellite spectrum should be allocated gained significant attention after Mukesh Ambani's Reliance Jio pushed for a spectrum auction. Musk, however, openly criticised the idea, calling the auction process "unprecedented." He argued that such a move would be an outlier in global satellite communication practices and could hinder the expansion of satellitebased internet services like Starlink in India.Just a day before the government's announcement, Musk had responded to reports about Reliance Jio's stance, questioning the logic behind auctioning satellite spectrum. He expressed concerns that the auction route could create unnecessary barriers for companies like Starlink that aim to provide affordable satellite internet access, especially in rural and remote areas of India.

strengthens the argument for Elon Musk has long been eyeing the Indian market for Starlink, his satellite internet venture. Starlink aims to offer high-speed internet in remote and underserved areas by deploying a large constellation of lowearth orbit (LEO) satellites. Musk believes that the administrative allocation of spectrum will help accelerate Starlink's entry into India and improve internet access in regions where traditional telecom infrastructure is lacking. The administrative allocation approach, widely adopted by countries across the globe, enables companies like Starlink to operate without the burden of hefty auction fees. This approach is considered more conducive for expanding satellite-based services, which are crucial for connecting areas with limited access to traditional broadband networks. While the government's decision is a win for Musk and other satellite service providers, it has met with opposition from Indian telecom giants. Mukesh Ambani, head of Reliance Jio, had been lobbying for an auction of the satellite spectrum, arguing that an auction would create a level playing field. Sunil Bharti Mittal's Bharti Airtel had also been in favour of an auction process.Despite their arguments, the government's stance appears firm, siding with the global practice of administrative spectrum

According to an internal circular dated October 8, 2024, the new portal, part of Before launching the new portal, the Project IEC 3.0, will replace the current system and introduce advanced features for smoother and more secure filing of income tax returns. The existing ITR efiling system, known as IEC 2.0, is

coming to the end of its operational phase. The new system, IEC 3.0, will not only continue offering all the current services but will also come with enhancements that aim to create a more user-friendly and secure en viron men t for taxpayers. According to the Income Tax Department's internal circular, the IEC platform allows taxpayers to electronically file their Income Tax Returns (ITRs), submit statutory forms, and access other services. The Centralised Processing Centre

(CPC) handles the processing of these returns through the portal. In addition to this, there is a Back-Office (BO) portal that tax officers use to access data related to taxpayer filings and processing. Project IEC 3.0 will continue all these functions, but with a focus on improving user experience and providing faster, more efficient services.

PUBLIC SUGGESTIONS SOUGHT BEFORE LAUNCH

Income Tax Department is seeking feedback from the public and stakeholders. The department believes that the new platform will have a major impact on how both taxpayers and tax



officers work in the future, so they are encouraging users to share their opinions and suggestions.A committee will be formed to gather input from various stakeholders, including taxpayers, tax professionals, and officers of the department. This committee, led by a senior officer not below the rank of CIT (Commissioner of Income Tax), will be tasked with gathering feedback on the current system's strengths and weaknesses and identifying areas for improvement in IEC 3.0. The committee will be formed within a week of the order, and all suggestions are expected to be submitted by November 30, 2024.

IMPROVEMENTS EXPECTED IN IEC

Chartered Accountant Ashish Niraj, Partner at A S N & Company, believes that the transition to IEC 3.0 will make the system more user-friendly. He expects that the new portal will process ITRs more quickly, potentially speeding up refunds for taxpayers. He also hopes that common issues such as problems with downloading past tax returns or forms, server failures, and payment issues will be resolved in the upgraded

system. There were some technical glitches in IEC 2.0, but with the highspeed technology expected in IEC 3.0, I am optimistic that these problems will be reduced," said Niraj.Chartered Accountant Hardik Kakadiya, President of the Chartered Accountants Association, Surat, also commented on the potential improvements. He noted that there have been ongoing issues with the current portal, and a case has even been filed in the Gujarat High Court regarding the glitches. Kakadiya hopes that the new portal will be able to handle the increasing number of taxpayers more efficiently and prevent similar problems in the future.

Now, with a revamped coaching setup and key player retentions, they are determined to secure a place in the PKL 11 Playoffs. For this season, the Thalaivas have adopted a dualcoach system, appointing Udaya Kumar as head coach and former PKL champion Dharmaraj Cheralathan as the strategy coach. This collaborative approach is

expected to bring fresh ideas and guidance to the team. Although Tamil Thalaivas weren't amongst the busiest teams during the Season 11 Player Auction, they made headlines by signing star raider Sachin for a record INR 2.15 crores. With their core squad intact, here's a breakdown of the Thalaivast' strengths, weaknesses, opportunities, and threats heading into the Strengths

One of Tamil Thalaivas' key strengths is their ability to retain most of their core players from last season. Star raider Narender, who has accumulated 429 raid points in two seasons, will once again be the focal point of their attack. Adding to this is the acquisition of Sachin, who boasts 952 raid points in his PKL career and holds the record for the most do-or-die raid points (233) in league history. Together, Narender and Sachin form a formidable raiding duo, providing the team with a powerful offensive unit. The Thalaivas' depth in raiding is further strengthened by backup options like Vishal Chahal, who made an impressive debut last season with 34 raid points, and the experienced Chandran Ranjit, who has tallied 534 raid points in his PKL career.In defence, the team has maintained continuity

Abishek, Sahil Gulia, Himanshu, Mohit, and Amirhossein Bastami. Sahil Gulia and Sagar were among the top 10 defenders last season, with 69 and 66 tackle points respectively, ensuring the Thalaivas have a solid defensive

Weaknesses

Despite their strong roster, the Thalaivas' depth in defence could be a concern if key defenders like Sahil Gulia or Sagar suffer injuries or experience a dip in form. Sagar's absence for several matches last season significantly affected the team's defensive balance, and a similar situation this season could expose their backup defenders, such as M. Abishek, Himanshu, Mohit, and Bastami,

who will need to step up under pressure.

Opportunities

For Sachin, this season presents an opportunity to further cement his status as one of the league's premier raiders. Just 48 raid points away from reaching 1000 in his PKL career, he will aim to surpass the 200 raid points mark in a season for the first time. With the support of Narender, who will share the raiding responsibilities, Sachin finds himself in an ideal setup to achieve his personal and team goals.

One potential threat for the Thalaivas is the lack of an experienced all-rounder in their squad. All-rounders are crucial for providing balance, contributing on both offense and defense. Iranian Moein Safaghi is the team's only designated all-rounder, but he has yet to make his PKL debut. Relying solely on him to fill this vital role could be risky, especially if key players are sidelined due to injuries. Without a proven all-rounder, the Thalaivas may struggle to maintain balance if they face personnel challenges throughout the season. As Season 11 approaches, Tamil Thalaivas will look to build on their strengths while addressing these potential weaknesses and threats, as they aim to make a deep playoff

The former Sri Lanka captain, who was instrumental in their title triumphs, replaced Mark Boucher, who was in charge of the team for the 2022 and 2023 seasons."He will work alongside current Bowling Coach Lasith Malinga, as part of the coaching team under Head Coach, Mahela Jayawardene. He has been a part of the Mumbai Indians coaching team earlier as well, celebrating title wins in the IPL and the Champions League T20," Mumbai Indians said in a statement.

Paras Mhambrey played two Tests and three ODIs for India after making his debut in 1996. A medium-pace bowler, Mhambrey picked 5 wickets in international cricket. Mhambrey played domestic cricket for Mumbai, featuring in 91 first-class matches and taking 284 wickets and 83 List A matches with 111 wickets.

Yusuf Dikec Exclusive: Viral Turkish shooter reflects on meteoric rise to stardom

New Delhi. The Dr. Karni Singh Shooting Range in New Delhi was buzzing with excitement during the ISSF World Cup 2024, and much of that energy centred around one man -- Yusuf Dikec. The Turkish marksman, famous for his unconventional style and relaxed demeanour, was a major draw for fans and fellow athletes alike. Dikec failed to qualify for the final in the 10m air pistol event on October 15, but his performance mattered little for those who queued up to catch a glimpse of him.Dikec's rise to global fame started during the 2024 Paris Olympics, where his unorthodox stance and minimalistic gear turned heads. Competing in the mixed team 10m air pistol event, he secured a historic silver medal for Turkey—the country's firstever Olympic medal in shooting. But it wasn't just his performance that stole the spotlight; it was his casual approach. While most elite shooters are decked out in high-tech gear with custom lenses, visors, and elaborate ear protection, Dikec stood out for keeping things simple. He wore standard glasses, and yellow earplugs, and, in a style that has since gone viral, often kept one hand casually tucked in his pocket—looking more like a relaxed spectator than an Olympic marksman. When asked about his now-iconic shooting pose, Dikec's response was as cool as his demeanour. "I started shooting and continued to shoot in this position only," he told India Today, almost shrugging off the fame that's come with it."But after the medal in the Olympics, I have gained popularity. But I have been shooting in this position."For Dikec, his minimal gear and style aren't just for show—they're part of his strategy to stay relaxed under pressure. "The idea is to be relaxed," he emphasised. It's that effortless style that has turned Dikec into a viral sensation, with athletes from football to basketball imitating his stance in their own celebrations."Football, basketball, several athletes have done it very good," he said when asked who had nailed the best imitation of his pose post-Olympics. This move—often likened to that of a hitman or a casual observer—has now become more than just a quirky shooting technique. It has morphed into a symbol of confidence and coolness, widely adopted across the sports world. Dikec's journey to the top wasn't an overnight sensation, though. Born in 1973 in Turkey, his love for shooting developed early. He made his Olympic debut back in 2008 and has spent years honing his craft to become one of the most respected shooters in the sport. Despite his years of experience, it was only recently that his laid-back style catapulted him into the

In a recent interview with NewsX Live, Raveena shared that Mumbai Police indicated the attack was pre-planned. She also mentioned that her friend, actress Richa Chadha experienced a similar mob incident the next day. Raveena expressed concern over these intimidation tactics and said that Richa had to settle the matter because there were no CCTV cameras to capture the truthRaveena said, "Unfortunately, this has been going on in Mumbai, which is a planned kind of a thing. Jo ki darane ki baat hai (to intimidate). Jab ye mob ka incident hua (When this mob incident happened), in fact, the next day, my friend Richa Chadha called me. She said, 'Raveena, you won't believe it, the same thing happened!' The same thing happened with Richa, and unfortunately, no CCTV cameras to record the truth. In fact, she had to pay up. She had to settle the matter. The cops told her that settle it. She, in fact, the poor thing, went ahead and settled."

Raveena Tandon said that the police believe her mob incident was planned to get money. She described how the mob tried to break into her house while her children were inside and her husband was away. Raveena and her staff blocked the gate to stop them, insisting that the police should take care of it.

"I remember, the mob was so aggressive. They were entering my house. My children were upstairs at home. My husband wasn't at home. Jo mere male members of staff dikh rahe the unko, wo kheech ke maar rahe the unko. In fact, gate pe main khadi ho gayi aur meri jo do domestic staff ki members hain, jo saalo se hain mere sath, hum gate par khade ho gaye the that no one will enter the house. Aur wo dhakka de de ke bol rahe the aap bas driver ko bahar bhej dijiye. Toh maine kaha uski galti hai toh police ko aa jane dijiye, fir aap le jaye usko. (They were bashing up male members of my staff. Me and two female members of my staff stood at the gate so that no one enters the house. They kept pushing and demanding us to surrender the driver. I said if the driver is at fault, let the police come and take him). Who are you to give justice? Who are you to lynch him? Aap kyu maara peeti karna chahte ho? No hitting! Please don't hit anyone. But ek jo mob frenzy ho jati hai na jab sab sath mein ho jate hain (it was like a mob frenzy, when everyone gets together)," Raveena added.
