New Delhi, Oct 17: The Congress president shared the previous incidents in which people lost their lives after allegedly consuming spurious liquor in Bihar Congress president Mallikarjun Kharge on Thursday criticised the Bihar government for failing to stop the illicit liquor trade in the state. Kharge's statement comes in wake of the latest hooch tragedy in Bihar that claimed 36 lives in Siwan and Saran districts. In a post written in Hindi on his official X (formerly Twitter) account, the

senior Congress leader expressed his condolences on the deaths calling it "painful and sad". "So far, 36 people have died due to poisonous liquor in 16 villages of Siwan and Saran in Bihar, which is very painful and sad. Our deepest condolences to the bereaved families of the victims. Request the government to give the strictest punishment to the culprits", his post read. "Earlier, many people have lost their lives due to illegal liquor in other districts, which shows how unsuccessful the Bihar government is in stopping the illegal liquor business", he added. December 2022: 71 people died in Chapra and dozens of people lost their eyesight. March 2022: 12 people died in Banka. November 2021: 43 people died due to consumption of poisonous liquor in Gopalganj, Bettiah and Muzaffarpur", Kharge wrote. New Delhi, Oct 17: Senior Congress leader Captain Ajay Singh Yadav on Thursday quit the party saying he had been treated "shabbily" since Sonia Gandhi stepped down as the party's president. His resignation came days after the Congress stunningly lost the Haryana assembly elections. "I have sent my resignation letter to Congress President Mallikarjun Kharge ji from Chairman AICC OBC Department and also from the primary membership of Indian National Congress Yadav posted on X. "This decision of resigning was really hard decision with whom my family had 70 years of association as my father late Rao Abhey Singh became MLA in 1952 and there after I continued with family tradition but am disillusioned with the party high command for treating me shabbily after Sonia Gandhi left the post of Congress President" Yadav posted on X. He is scheduled to travel to Maharashtra on Friday for discussions regarding seat-sharing, expressing optimism that a decision will be reached soon. While addressing journalists, Yadav reiterated the unity and strength of the INDIA bloc. When asked about the Maharashtra assembly elections, he stated: "I am going to Maharashtra tomorrow... We will strive to contest alongside the INDIA bloc.

We have requested seats and hope to

emphasised that seat-sharing discus-

sions in Maharashtra are expected to

conclude soon, and he expressed confidence that similar negotiations in UP would also be resolved shortly. He is set to embark on a two-day visit to



Maharashtra, with programmes planned in Malegaon and Dhule, where he will engage with the public. The SP is actively working to expand its influence beyond UP, indicating that it may contest elections as part of the INDIA bloc. The party claims a significant presence in 30 seats but is particularly

focused on 10-12 constituencies, notably those with sizeable Muslim populations and migrants from UP. Reports suggest that the SP may secure 3-4 seats in the Maha Vikas

Aghadi alliance. Currently, the SP holds two MLAs in the Maharashtra assembly: Abu Azmi from Shivaji Nagar and Raees Sheikh from Bhiwandi. Recently, Yadav convened a meeting with Maharashtra unit leaders in Lucknow to strategise for the upcoming elections. Should the SP officially join the INDIA bloc, Yadav is expected to actively campaign in Maharashtra. In response, SP MLA Abu Azmi

took to X, stating, "If any party within the Mahavikas Aghadi-be it Congress, the Nationalist Congress Party, or Shiv Sena—issues an assembly candidate list without consulting the Samajwadi Party, it indicates that they do not regard us as a part of the Mahavikas

#### Netherlands delegation inspects Kalyan's solid waste management initiatives

KALYAN. Thierry van Helden, Consulate General of the Kingdom of the Netherlands, along with a delegation, conducted an inspection of the solid waste processing project initiated by the Kalyan Dombivli Municipal Corporation (KDMC).

The visit aimed to assess the ongoing solid waste management efforts and explore best practices for effective waste processing.

During the inspection, the delegation presented an audio-visual overview of various initiatives taken out in Netherlands, including the solid waste project, waste-toenergy and biogas projects, air pollution control measures, and strategies for maintaining clean rivers and minimising air and water pollution.

Following the presentations, the delegation, along with municipal officials, toured the Umbarde Integrated Solid Waste Project, the Adharwadi Biomining Project, and the Waldhuni River to gain firsthand insight into the projects.

The collaboration between the Govt of Maharashtra and the Netherlands, formalised through a Memorandum of Understanding (MoU), aims to implement solid waste processing initiatives across India. The delegation emphasised that India generates approximately 60 million metric tons of solid waste annually, urging the need for modern technological solutions to address the growing waste management challenges.KDMC Commissioner Dr. Indurani Jakhar stated that the projects would be rolled out in phases as funding becomes available through central govt initiatives and MMRDA.

#### Thane police file charges against 10 in Rs 16.48 lakh



THANE. Thane police have filed a case against 10 individuals for allegedly defrauding a 71-year-old man and his friend out of Rs 16.48 lakh by promising returns on cryptocurrency investments. The accused claimed to represent a cryptocurrency company with offices in Mumbra and Dombivli, both in Thane district, Maharashtra.

In March of last year, they convinced the elderly man and his friend, residents of Chembur, Mumbai, to invest in cryptocurrency, collecting Rs 16,48,405 from them over time, according to an official from Mumbra police station.

When the victims did not receive any returns or their original investment back, they reported the matter to the police.

On Wednesday, a case was registered against the 10 accused, who are residents of Diva, Dombivli in Thane, and Uttar Pradesh, under sections relevant to cheating and criminal breach of trust, the official said

#### NID director meets faculty, student protest continues



Ahmedabad. The protest by National Institute of Design (NID) students against the reshuffle of faculty members spilled into the third day on Wednesday, with many sitting outside the office of Ashok Mondal, the new director. Mondal had not met the students till late evening, sources said.

He however, met faculty members who had been transferred and discussed the future course of action for their specific departments.After assuming charge last week, Mondal shifted no fewer than 20 faculty members across Ahmedabad, Gandhinagar and Bengaluru campuses, including changing leads and co-leads of several key disciplines. Students started the protest on Monday after a meeting with Mondal in a public forum on issues including the removal of almost all women from key positions and the reshuffle right after assuming charge.

"The director promised to send a response to our email queries, which has not been received so far by the students. The change in the middle of the term may have detrimental effects on both, the students and faculty members. We learned that the director had one-on-one meetings with several key faculty members, possibly to discuss their new roles and responsibilities. We hope to get answers from the director soon," said a student on the condition of anonymity. Sources informed that the director is not in the favour of reversing the transfers, even as the dissent is likely to be escalated to the ministry.

## Stormwater drain weighs down lives of hundreds in Vivekananda Nagar, Chennai

Avadi Corporation constructed a stormwater drain in the area about four years ago. Since then, even during light showers, his house on the ground floor gets inundated. The 100-odd families in the area said they shared the same fate. Even a day after rain stopped, many

houses in Sampangi Street were inundated. Some residents bailed out, while some chose to wait for the water on the street to recede. C Chandrasekar, another resident, said this problem began after the corporation built a stormwater drain one and a half feet deep and

above ground level.

Water from all surrounding areas When contacted, a senior flows into this drain. The main chamber on the road is 10 feet deep and seven feet wide, and is connected to this one-and-halffeet stormwater drain, which, not being able to carry all the water gushing into it, overflows.

The water from here drains into Puzhal lake, contaminating the potable water. Representations were submitted to the Avadi Corporation officials several

times, but no action ensued," he lamented. AP Sudarshan, another resident said, "I have been living here for decades, and had never faced this problem until the stormwater drain was constructed."

corporation official told TNIE that a team of officers had inspected the area, and identified that the width of the stormwater drain was smaller than the main drain. The elevated slope of the drain has been hindering the natural flow of water. #### High hopes for site allotments in Dr. Shivarama Karanth layout as court hears cases

With nearly 100 writ petitions filed by landowners against the BDA, the upcoming court decision on October 25 could finally pave the way for the allotment of 34,000 sites in the longawaited layout.



BENGALURU. It has been a year since the allotment of sites at the fully planned Dr Shivarama Karanth Layout of BDA kept in abeyance. With the High Court hearing cases against the Layout at a stretch for three consecutive days this week, concluding on Wednesday. The hopes of getting the green signal for site allotments are high. BDA has already invested nearly Rs 1,800 crore on the project which has 34,000 sites.

Nearly 100 writ petitions have been filed by landowners against BDA in the court, with a few others at lower courts too. A top official told TNIE, "Until now, the special bench heard the case only once a week. But this week, it was heard three consecutive days. BDA officials are expecting a nod from the court to go ahead with the allotment of sites. The next hearing is on October 25." The original allotment deadline was December 2023.

The layout was completed under the supervision of the Justice A V Chandrashekar committee in September 2023. With landlosers set to be allotted sites on priority, general public will get 10,000 sites. The cost has been fixed at Rs 4,900 per sqft.

Another official said there is no work pending on the formation of sites. "Laying of roads, electricity supply, water and drainage connections are on at present. Nearly 60% of the work is completed.

The facilities will be ready before allottees start building on their sites," he said. BDA has decided to levy betterment charges in all the villages, with the value of the property expected to soar. Different rates have been fixed for different areas.

## Political clash erupts in Bengaluru amidst flooding crisis

The heavy rains that flooded Bengaluru's IT corridors have led to sharp political accusations.



BENGALURU. After heavy rain caused flooding in Bengaluru, particularly in the IT corridors, a political clash erupted between the ruling Congress and opposition parties.

Rain disrupted traffic and inundated areas like Manyata Tech Park and Whitefield, prompting sharp accusations from opposition party leaders over poor infrastructure in the state capital.

Janata Dal Secular pointed out that former Prime Minister HD Deve On tweets from opposition leaders on Gowda had laid the foundation for Bengaluru's IT boom with great foresight, but successive Congress governments had squandered the vision into a real estate debacle and exploitation of land.

In response, Deputy Chief Minister and Bengaluru Development Minister DK Shivakumar lashed out at the

opposition parties for shaming Bengaluru for rain fury. "It is impossible to control nature. The government is doing its best to manage the rain havoc. Opposition parties must stop tarnishing the image of Bengaluru. Since there are chances of more rain, the public should plan accordingly," he said. As a precautionary measure, a holiday has been declared and a meeting with BBMP, police and fire department officials will be held, he added.

#### HC stays MCG action against 2 firms hired to manage bulk waste

**Gurgaon.** Punjab and Haryana high court has set aside an order issued by MCG to de-empanel two private firms that were hired to assist bulk waste generators

The court also instructed the civic body to issue a new show-cause notice to the two firms and pass a fresh order after giving them an opportunity to be heard. The ruling came in response to a petition filed by the two agencies, who argued that they were not given a fair chance to present their case before being deempanelled in July.

"Let the authorities issue a fresh show-cause notice to the petitioners and pass a fresh order after affording the due opportunity of hearing to all the concerned parties," Justice Harsh Bunger said in his order passed on Oct 1. In March, MCG hired 15 private agencies for technical support and guidance to the BWGS of the city. In Sept, MCG ended contracts with 14 private agencies. The agencies were de-empanelled for dumping inert waste at garbage-vulnerable points instead of transporting it to the designated waste collection centres. However, after all the agencies raised objections, the orders were withdrawn. The agencies claimed that the de-empanelment was being done for the benefit of a private agency.

Gurgaon: Union minister of state for rural development and communications Chandra Sekhar Pemmasani said on Wednesday the tireless contribution of 'Lakhpati Didis', who are successfully running self-help groups (SHGs), will be significant in the country's economic progress and added, rural India is gradually transforming into global India.

"The determination to overcome poverty and the creative strength of the women participating in the Saras Fair in Gurgaon are clearly visible," he said.

This fair seems to be realising the PM's vision for empowering women, the minister said, adding, experts have been invited to provide digital platforms like Amazon and Flipkart for marketing, designing, packaging, and quality improvement of the products of the SHGs.Two special enclaves for knowledge and learning have been set up for this purpose.

Rural development ministry secretary Shailesh Kumar Singh said there are currently 90 lakh SHGs under the National Rural Livelihood Mission, involving over 10 crore women."The Saras Fair offers a glimpse of India's art and culture," Singh said. Additional secretary of the ministry of rural development Charanjit Singh, joint secretaries Swati Sharma and Smriti Sharan and 'Lakhpati Didis' Sita Pradhan from Sikkim and Afsana Ayat from Jammu and Kashmir also shared their views.

# Is AQI really 'moderate' Power failure hits monitor as city chokes on smoke

**Gurgaon.** "Power failure" leading to a dearth of authoritative data to evaluate air quality worsened the situation even as residents in Sector 56 and numerous other areas in the city encountered an acrid stench of smoke during the early hours of Wednesday. While several residents experienced respiratory distress, the monitoring station in Sector 51 ceased operations on Wednesday. The malfunction triggered concern among residents who rely on the station's data to assess air quality.On Wednesday, the city's AQI was categorised as moderate. However, the authenticity of the air quality being "moderate" remains uncertain. With data accessible from only two out of the four stations in the city to calculate a 24-hour average for Wednesday, ascertaining the precision of this assessment of the pollution level is arduous. Nonetheless, it constitutes the official data.

The Sector 51 monitor is the most pivotal one for the district. It is located at Gurugram University. Highrises, hospitals, schools and markets fall in this area within a 10km radius.During night

also, dumpers, trucks and sand carrying wagons traverse these sectors which renders the area highly polluted.

On visiting the areas, which the air monitor caters to, TOI observed that the construction materials are lying exposed along the roadside and the heavy vehicles transporting such materials contribute to PM 2.5.A large number of allotted or sold plots are lying unused throughout these sectors, which make it very convenient for indiscriminate dumping of C&D waste, mixed garbage and horticulture waste which then are left to cause uncontrolled pollution.On being asked about

#### US strikes five underground Houthi weapons storage sites in Yemen

Yemen. The United States conducted precision strikes on Wednesday against five underground weapons storage locations in Houthi-controlled areas of Yemen, US Defence Secretary Lloyd Austin said in a statement."US forces targeted several of the Houthis' underground facilities housing various weapons components of types that the Houthis have used to target civilian and military vessels throughout the region,' Austin said. The attack comes after the US military earlier this month carried out 15 strikes against targets linked to Iran-aligned Houthi fighters in Yemen, where residents reported blasts at military outposts and an airport.Houthi fighters in Yemen have carried out nearly 100 attacks on ships crossing the Red Sea since November and say they are acting in solidarity with Palestinians in Israel's year-long war in Gaza. They have sunk two vessels, seized another and killed at least four seafarers.

The US Central Command (CENTCOM) said in a post on social media website X that its battle damage assessments were underway and do not indicate civilian casualties.

#### **UK** government to impose sanctions on Israeli ministers

LONDON. British Prime Minister Keir Starmer said Wednesday that the government was considering sanctions against far-right Israeli ministers Itamar Ben Gvir and Bezalel Smotrich. Asked in parliament if the government would sanction the two officials, Starmer said: "We are looking at that because there are obviously abhorrent comments along with other really concerning activity in the West Bank."National Security Minister Ben Gvir and Smotrich, who is finance minister, are vocal supporters of settlements in the West Bank, which are considered illegal under international law.Smotrich has also triggered international uproar by suggesting it would be justified to starve two million Gazans to free Israeli hostages in the Palestinian territory. After Starmer's comments, Smotrich remained defiant, vowing to fight Israel's enemies in Gaza, Lebanon and Iran while working to prevent the establishment of a Palestinian state.

"No threat will stop me from doing what is right and moral for the citizens of Israel," Smotrich posted on X.Earlier this week, former foreign secretary David Cameron revealed that the previous Conservative government had been "working on" sanctions against the "extreme" politicians.Starmer's Labour government announced separate sanctions Tuesday against seven Israeli settler outposts and organisations.Israeli settler violence and military raids have intensified in the occupied territory following October 7, after Israel launched its war on Gaza. Pointing to the "dire" humanitarian situation in Gaza, Starmer also called for Israel to "take all possible steps to avoid civilian casualties, to allow aid into Gaza in much greater volume

Foreign Secretary David Lammy meanwhile announced that Britain, France and Algeria had called an urgent meeting of the UN Security Council after UN reports that "barely any food has entered" North Gaza in

#### Israeli strikes kill dozens in Lebanon's Qana, where Israel has dark history of killing civilians

QANA.Israeli airstrikes pounded areas across Lebanon, killing at least 25 people, officials said Wednesday, including more than a dozen in a southern town where Israeli bombardments in previous conflicts are seared into local memory. Elsewhere in the south, a city's mayor was among the dead in a strike that Lebanese officials said targeted a meeting to coordinate relief efforts. The Israeli military said they were targeting a Hezbollah commander in the strikes late Tuesday on the southern town of Qana, where 15 people were killed. Associated Press photos and video of the scene showed several flattened buildings and others with their top floors collapsed. Rescue workers carried away the remains of dead people and used a bulldozer to remove rubble, as they searched for more victims.Israel said the target was Jalal Mustafa Hariri, Hezbollah's commander in charge of the Qana area.In 1996, Israeli artillery shelling on a United Nations compound housing hundreds of displaced people in Qana killed at least 100 civilians and wounded scores more people, including four U.N. peacekeepers. During the 2006 war, an Israeli strike on a residential building killed nearly three dozen people, a third of them children. Israel said at the time that it struck a Hezbollah rocket launcher behind the building."Qana always gets its share," Mayor Mohammed Krasht told the AP, referring to the town's grim history.Lebanon's caretaker prime minister, Najib Mikati, meanwhile accused Israel of "intentionally targeting" a municipal council meeting to discuss relief efforts in Nabatiyeh, where six people were killed. What solution can be hoped for in light of this reality?" he asked in a statement.Strikes continued across Lebanon, including in the eastern Bekaa Valley and Nabatiyeh, in southern Lebanon, where the Israeli military said it targeted.

and "peace-loving Canadian citizen" who was killed as he was trying to mobilise Canadian Sikhs to participate and vote in the 'Khalistan referendum'.

"High Commissioner Verma, as the head of India's mission in Canada, must be held accountable for Nijjar's assassination, which in every sense is act of state terrorism by India. The

assassination of a Canadian citizen by India on Canadian soil is an unprecedented and unconscionable attack on Canada's sovereignty and on the lives and liberties of all Canadians," Pannun wrote.It further claimed that Verma either knew or ought to have known of the plot to assassinate Nijjar and accused him of "cracking down on those peacefully advocating for Sikh human rights". Sikhs for Justice asked for the expulsion of Verma, claiming there was a risk of further violence in the country.

World A new report from the Global Commission on the Economics of Water (GCEW) warns that inaction on the water crisis could jeopardize over half of the world's food production by 2050. Nearly 3 billion people currently live in regions where total water storage is projected to decline, raising alarms about the sustainability of global food systems.

The report highlights that the water crisis could lead to an average GDP drop of 8% for high-income countries and as much as 15% for lower-income nations. Disruptions to the water cycle have driven by changing precipitation patterns, rising temperatures due to climate change, and a lack of access to clean water and sanitation. To address this critical issue, the report calls for recognizing the water cycle as a "global common good" and urges a transformation in water governance at all levels. It emphasizes the



need to eliminate harmful subsidies in water-intensive sectors and redirect resources toward water-saving solutions, especially for vulnerable populations.

significant global economic repercussions, Co-chair Ngozi Okonjo-Iweala, Director-General of the World Trade Organization, stated, "The costs of taking action are minor compared to the damage caused by continued inaction." The report both a dire warning and a call to action, underscores the importance of proper water pricing and incentives to ensure efficient and equitable water use across all sectors. The findings reveal that current

water management strategies have failed to account for the diverse values of water, leading to excessive use and misplacement of water-intensive industries in vulnerable areas. Addressing these issues is not just a necessity for economic stability but also for ensuring food security and human development.

Johan Rockström, Director of the Potsdam Institute for Climate Impact Research, noted, "We are pushing the global water cycle out of balance for the first time in human history." The report warns that half of the world's population already faces water scarcity, which threatens food security and overall well-being.

The lawmaker also expressed concern for the safety of Hindu-Canadians, many of whom feel threatened by the recent surge in Khalistani activity. The United States has been courting India as a growing partner, seeing common cause between the world's two largest democracies faced with the rise of China, despite concern voiced by activists about an authoritarian turn under Prime

Canada has separately alleged that India arranged a plot on its soil that ended in the killing last year of a Sikh separatist, who was a naturalized Canadian citizen, outside a Vancouver temple.

Unlike the United States, Canada has highlighted its concerns publicly and at the highest level, with Prime Minister Justin Trudeau

criticizing India's actions.Canada and India on Monday expelled each other's ambassadors as Ottawa said that the Indian campaign went further than previously reported. At a parliamentary inquiry Wednesday on foreign interference, Trudeau said India had clearly violated Canada's sovereignty and that its intimidation tactics were not limited exclusively to the Sikh community.

#### Man accused of rape after not marrying woman acquitted

Ahmedabad. A city sessions court acquitted a 30-year-old man of rape charges filed on the grounds that he had promised to marry the victim. The decision was taken after it was established that he could not marry the victim because his family members were against

According to the case details, a 25-year-old woman, who is a divorcee and a mother, filed an FIR with Shaherkotda police on Sep 29, 2019, against her neighbour Akash Pawar for allegedly raping her after falsely promising to marry her. They had eloped three weeks before the filing of FIR and gone to Delhi. They lived in a rented house for eight days until the accused disappeared. The woman was brought back to Ahmedabad by her

During the trial, it was revealed that the woman and the accused were in love for over a year before they eloped. A few days after the couple eloped, Pawar's mother and other family members visited them in Delhi. There was a quarrel between Pawar and his family members. The next day, he disappeared. The woman filed an FIR three days after returning to Ahmedabad.

After the trial, additional sessions judge P K Khanchandani acquitted Pawar of the rape charge by giving him the benefit of the doubt. The court stated in its order that to hold the accused guilty, it is necessary to prove that from the beginning he had an intention of not marrying the victim, and that he made false promises of marriage.

The court stated in its order, "The evidence showed that the accused was ready to marry and accept the victim with her minor daughter. But his mother and family members did not agree to the marriage. They had a quarrel with Pawar in Delhi and the marriage was not possible."

#### Unravelling the mystery of two road 'accidents' in Thiruvananthapuram

THIRUVANANTHAPURAM. How easy is it to pass off murder attempts as casual road accidents? Very simple, thought a 58-year-old man and his hitmen, who planned to murder a 22-year-old in Thiruvananthapuram earlier this year.

If it had not been for the diligence shown by the investigators from Mannanthala police station, the culprits could've found their hunch turning true. Anujith, a resident of Vencode, had two back-to-back road accidents within about 30 days. The first incident occurred on July 24 within the Vattappara police station limit, while the second incident took place on August 27 at the Mannanthala police station limit.

Anujith was riding a two-wheeler on both occasions and the vehicles that knocked him down could not be identified. The Vattappara but they could not trace the vehicle - a red car. Almost a month later, another accident occurred when Anujith was knocked down by a two-wheeler.

The Mannanthala cops initially did not suspect any foul play. However, Anujith felt being hit with a heavy object from behind by one of the passengers travelling in the two-wheeler. When he told the police about this, their curiosity was piqued. Little did Station House Officer Gopi D and his team thought they were about to unravel a well-hatched conspiracy. There were no CCTV cameras in the accident spot. But the cops managed to retrieve footage from a camera located some 300 metres away. In the visual, a scrap dealer was seen walking along the road and the cops felt he would've witnessed the whole episode.

candidates to the written exam, indirectly reduced the number of posts available for reserved categories. Mohan contended that this order sought to dilute the constitutionally recognised reservations for disadvantaged groups.

Senior counsel KG Krishna Murthy further argued that the previous government



policy required category-wise selection of candidates for the written examination. and questioned why this practice was suddenly changed. He expressed concerns over the rationale behind the alteration.

Additionally, senior counsel L Ravichander pointed out discrepancies in the examination process, arguing that reservations for persons with disabilities

should not be applied vertically. He also noted that the total reservations had breached the constitutionally mandated 50% cap, reaching 63%. He criticised the process as being riddled with illegalities and constitutional violations.

On behalf of the state, counsel S Rahul Reddy dismissed the petitions as based on "casual pleading" and argued that they did not merit any relief.

After hearing the arguments, the court refused to stay the examination but stated that any selections made as a result of the Group-I mains would be subject to the final outcome of the case. The court granted the state seven days to file a counter-affidavit, with the petitioners allowed to file a rejoinder within 10 days thereafter. The matter has been posted for final hearing on November 20.

The project, implemented at a cost of Rs 75 crore, has three floors with separate commercial and office spaces. "The basement is allocated for parking. The ground and first floors will be allocated for the existing vendors. The first floor has spaces for an electrical room and FMP section, while the sewage treatment plant for the building is provided in the basement.

The second and third floors are currently open spaces with no partitions, providing ample commercial or office space, which Kochi Corporation can further utilise for leasing," said an official with the CSML, adding that the facility has 275 shops. Also, solar panels, having a capacity of 40 KV, will be installed on the top floor to power the common area lighting.

The coordination between the trade unions, associations, and people's representatives has made the renovation of the market complex possible. The task seemed impossible, but we followed it up thoroughly," said Kochi Corporation Mayor M Anilkumar, adding that the projects implemented by CSML in the city would be landmark projects.

He said that the maintenance of the three-storey construction was more important. "We need to maintain the facility properly after the inauguration. Now we have entrusted the company to maintain it. ### The larger message from **Ottawa**

AN important story of global migration flows of the past decade has been the sharp rise in Indian emigration. From the US to Australia, from Singapore to Dubai and from Portugal to Israel, Indians have been emigrating in ever-increasing numbers. A mere 38,364 Indians became permanent citizens in Canada in 2014. By 2022 this number hit an all-time high of 1,18,095. By contrast, in 2022, only a little over 30,000 Chinese moved home to Canada. Canada has been a go-to place for Indian, especially Punjabi, emigrants for decades and was a strategic partner that helped in the building of India's nuclear capability. Why, then, have relations between the two countries hit an all-time low?Indian diplomats and other government officials have blamed Prime Minister Justin Trudeau, charging him with mixing up selfserving domestic political stratagems with foreign policy and national security. He needs the Canadian Sikh vote and so he is pandering to their Khalistani aspirations. The charge is even more severe. Trudeau's government has been accused of harbouring drug peddlers, criminals and anti-India terrorists.For their part, the Trudeau government has accused Indian intelligence operatives and diplomats of conspiring to assassinate Canadian citizens.

What began as a diplomatic kerfuffle soon escalated into a major spat and blew up when the US entered the game and linked the assassination of a Canadian Sikh to a similar attempt on a US Sikh. The Indian complaint about pro-Khalistani activism in Canada, the US and Britain is based on domestic security concerns, but the question remains unanswered as to how serious such activism has been in recent times, and whether it required such an explosive blow-up in diplomatic relations between democracies

The view of the Modi government that western governments have not been sensitive to Indian concerns is understandable. However, the charges of culpability levelled by Canada and the US against an assortment of Indians, including diplomats and senior government officials, are serious. Two questions arise. First, why did the Canadian and US governments go public? Second, where does the buck stop on the Indian side? On the second question, both the US and Canada have mentioned names and placed the onus of proving innocence on the Indians concerned. The first question is important because Canada and the US have had reasonably good diplomatic relations with India and could have been expected to handle matters with greater discretion. The official Indian charge, with respect to the first question, is that Trudeau is playing partisan politics, hoping to seal an electoral deal with Canadian Sikh voters. This sounds very much like Pakistan accusing Indian politicians of making political capital out of charges relating to alleged 'cross-border' terrorist attacks. Mixing national security issues with domestic politics cuts both ways and one must be careful about how third parties view such imputations. Will international public opinion view the Indian charge with greater sympathy than they would view Canada's charges? Should one care?Perhaps, some would, understandably, take the view that India can afford to ignore the Trudeau government. That was a dominant view in New Delhi when the initial charges pertaining to the killing of Hardeep Singh Nijjar were made. Then, the US upped the ante by not only accusing Indian officials of plotting a similar killing on US soil, of Gurpatwant Singh Pannun, but also launching legal proceedings. Is all this just a misunderstanding and bad faith between friends or are larger issues involved? That the Anglosphere countries of Australia Britain, Canada, New Zealand and the US share intelligence through their 'Five Eyes' alliance is well known. Given this, merely accusing Trudeau of trying to pick up more votes does not sound a very credible response. More importantly, the question must be asked as to why the Indian government believes it is being targeted by western democracies. That there is a problem between India and the Anglosphere is becoming clear. It is not clear how serious it is and what is being done to mend fences.

### The man who steered Indian business into global waters

#### Ratan Tata also became wedded to the need to become environmentally responsible. He junked the idea of making diesel autos.

WHen a long public life like that of Ratan Tata comes to an end, Indians have a tradition of heaping lavish praise on the memory of the departed, leaving aside some of the not-so-palatable parts of the departed's story. So, a measured assessment of the person's position in the history books must wait for some Now let is retell the story in terms of flesh and blood, time. But within these limitations, a view has to be

taken right away on what Ratan Tata did and did not do. And ask ourselves if he has left behind what is worth remembering.

In fairness, it can be said that the economic consequences of the life and legacy of Ratan Tata made public life richer and better. He should be a role model for upcoming scions and startup new promoters which, hopefully, will take the economy forward and make the country a better and kinder place to live in. Tata took over India's largest business conglomerate in 1990 when India had not yet started opening up but he made the group move with the times and helped make the

economy incalculably more robust and selfconfident. The symbol of this is the Tata Consultancy Services, the most profitable group company, which grew under the umbrella of the group's leadership to become one of the most globally respected information technology players that enabled India to coin the slogan 'Make in India, for the world'.

He was born (1937) when India was still ruled by the British but now leaves behind it as the fifth largest economy in the world. Under his leadership, the group restructured internally, and in the beginning of the current millennium went forth across the world to acquire some of the most globally known brands. Successes were totted up even as mistakes were owever, the group saw a challenge in long term made, but today the group is able to stand up on its own feet in the global business arena and keep going forward. Here are some numbers 'which give an idea of the transformation that the group went through between 1991 when Ratan Tata took over the leadership of the group and 2013 when he retired. Revenue went up from Rs 600 crore to Rs 5,000 crore (rounded off). The bottomline, profit after tax (PAT), went up from Rs 9 crore to Rs 17 crore.

On the other hand, return on equity (what the group's own money earned) fell from 16 per cent to 12 per cent (again rounded off). So the group paid a price to be able to go global. Market capitalisation (market value of all the shares), however, rose from Rs 9,000 crore to Rs 5 lakh crore. Thus, despite the group expressed confidence in the group leader by raising by multiple amount the public-quoted value.

When Tata took over, the group was led by biggies like Telco (now Tata Motor), Tisco (now Tata Steel), Tata Electric companies, Tata Hydro-Electric, Andhra Valley Supply, Associated Cement (ACC) and Tata Chemicals. Through the nineties the group also acquired consumer goods portfolios through Lakme (cosmetics), Tata Oil Mills (soaps), Goodlass Nerolac (paints), Merind (pharmaceuticals), Voltas (air-conditioners), Titan (watches), Tata Tea, Tata Coffee and Tata Press (printing). Plus, very importantly, the group was an important player in computer hardware with joint venture with IBM and telecom equipment through Tata Telecom in partnership with AT&T.

Tata Motors acquired the heavy vehicles' unit of Daewoo Motors, thus becoming one of the top global truck motors. Thereafter came the big acquisition, Jaguar Land Rover, again catapulting the Tata player, Tata Motors, to become one of the leading global players

in the field. Then Tata Steel acquired Corus, seeking to become a leading global steel player.

seeing a fall in its own money, the capital market With such mega acquisitions taking place, not every turn out to be a winner. The acquisition of Corus did not become a success. Former Tata Steel managing director JJ Irani described the action as an

"acquisitional mistake".n the category of mistakes, also comes the Nano project with which Tata saw the vision of producing a Rs 1-lakh people's car that would allow the family on a scooter to switch to a car. But its cost went up and most importantly the car couldn't meet the upwardly mobile picture of an aspirational car owner. Eventually, the product was closed down.

Hard business apart, Ratan Tata was known for his ethical leadership style and his values of trust and reputation. He was also known for his modest and unassuming style. Under his leadership, the group became known for its employee-centric approach while offering a variety of benefits and welfare programmes. For example, Tata Motors has a


health and wellness programme that includes insurance, medical facilities, and health check-ups. On Glassdoor, the Tata Group has an employee rating of 4.0 out of 5 stars.Ratan Tata also became wedded to the need to become environmentally responsible. Initially, he thought diesel autos made business sense but he changed his mind when he realised that diesel produced a lot of very small particulates which travelled and stayed put in our respiratory system.

Overall, it can be said that he looked forward and took risks. Some of them paid off, some didn't. But he went on, keeping in view the need to be a responsible employer and environmental practitioner. So, he has given a role model which can make the economy richer in an environmentally sustainable manner.

We can end with two anecdotes which tell more than numbers and names do. When he was put up at a posh hotel suite in Washington as leader of the corporate team that accompanied Prime Minister Manmohan Singh, he sought out and moved to a single modest room. In 1984, when many Sikh truck owners' vehicles were destroyed in the anti-Sikh riots after the death of Indira Gandhi, Tata Motors immediately replaced all the destroyed trucks without any condition of repayment. Ratan Tata's logic was that if we have prospered by them, we will stand by them in their hour of the greatest need.

Moreover, reusable technology is a greener approach as it reduces material waste and space debris, aligning with global efforts to minimise environmental impact. Global collaboration could expand this innovation's reach, allowing space agencies such as NASA, ESA and ISRO to explore joint missions and advance human spaceflight. SpaceX's technology provides a promising roadmap for future partnerships, benefiting agencies, scientists and the next generation of STEM

professionals. Once the stuff of science fiction, reusable rockets are now becoming a reality.

### It's time Coast Guard was delinked from Navy

Apart from the Quad-at-Sea missions, the ICG will also be useful for the protection of commercial sea lanes originating from India.

THE Quadrilateral Security Dialogue (Quad), aimed at promoting regional security and economic cooperation in the Indo-Pacific region, has come up with a seminal initiative by announcing the first-ever joint Coast Guard mission at sea, at its recent Leaders' Summit in Wilmington, USA. The official statement made it clear that the coast guards of the USA, India, Japan and Australia would work together closely and that the four maritime security organisations "plan to launch a first-ever Quad-at-Sea Ship Observer Mission in 2025 in the Indo-Pacific to improve interoperability. Members of the Japan Coast Guard, the Australian Border Force, and the Indian Coast Guard will spend time on board a US Coast Guard vessel operating in the Indo-Pacific. The Quad intends to continue with further missions in the Indo-Pacific." As part of this mission, smaller countries in the Indo-Pacific will be trained in maritime security. This is clearly in response to the coercive and intimidating manoeuvres by Chinese ships and planes in the South China Sea (SCS), intended to compel other nations bordering these disputed waters to cede control.Recent clashes, including the ramming of vessels of the Chinese and the Philippine Coast Guard in the SCS, have further heightened these concerns.

Though the Observer Mission, scheduled for launch in 2025, appears very limited in its scope with only one operating US vessel, further missions, as intended, would enhance the scope and level of participation in this first-of-its-kind Quad cooperation at sea. Its significance lies in the fact that it's the Coast Guard and not the navies, which are involved. The strategic offensive role of a navy is projection of force into areas beyond a country's shores. And a multi-lateral naval presence in troubled waters, against a force like the PLA Navy, would be fraught with an ominous signature of a direct military threat. Moreover, the



Coast Guard is primarily tasked with law enforcement, maritime policing and humanitarian missions and require less integration than the naval forces, where cooperation is more combat-oriented.

Since its birth in 1978, the Indian Coast Guard (ICG) has been acting as a maritime law enforcement and search and rescue agency in the EEZ (exclusive economic zone). It actively patrols India's vast coastline. Functioning under the Ministry of Defence, it has evolved into an established and capable force that can intercept any illegal activities at sea and provide a full spectrum of non-military maritime services to the nation. It has also been carrying out joint sea exercises as far as Japan and South Korea. The ICG achieved a historic operational success in October 1999, with the recapture of a Panamanian-registered Japanese cargo ship, MV Alondra Rainbow, at high seas, hijacked off Indonesia. This was the first successful prosecution of armed pirates in over a century.

After the 2008 Mumbai attacks in which the terrorists entered India from Pakistan via the sea route, the Indian government initiated a programme to expand the ICG force, assets and infrastructure for enhanced protection and surveillance of the Indian waters. The ICG has a fleet of 152 ships and 78 aircraft, with a target of 200 vessels and 100 aircraft by 2030.

The other Coast Guard of the Quad nations, while having similar roles, are distinctly different from their navies in terms of government control. The US Coast Guard operates under the Department of Homeland Security while the Japan Coast Guard works under the oversight of the Ministry of Land, Infrastructure, Transport and Tourism.

From its very inception, the ICG has existed in the shadow of the Indian Navy. While this may have been

necessary in its initial years due to dependence for equipment, training, manning and officering of this new force, it may need a review now.

The Indian Navy is a large and growing service with a third aircraft carrier and more nuclear-powered submarines in the pipeline. These are clearly indicative of its power and reach, which now has to go far beyond the Malacca Straits and the Gulf of Aden in terms of force-projection capability.

r an emerging power like India, a large and modern navy is a most essential service. However, this deep blue-water navy has to be delinked from the ICG, especially in peacetime. The logical step, thus, would be for the ICG to be under the control of Ministry of Home Affairs (MHA) and not the Ministry of Defence. This would also be in line with the way the Coast Guard of most developed countries operate, and would enhance its distinct identity while working with its counterparts in the foreign seas. Our borderguarding forces deployed on land borders, also come under the MHA. Looking ahead, apart from the Quad-at-Sea missions, the ICG will be most useful for roles like the protection of commercial sea lanes originating from India. One such commitment would be the India-Middle East-Europe Economic Corridor (IMEC) that aims to bolster economic development by fostering connectivity and economic integration between Asia, the Persian Gulf and Europe. It has not yet taken concrete shape due to the geopolitical turmoil and conflicts in West Asia, but is an idea which should fructify in future. Initiatives like the Quad missions will have a beneficial spinoff for India in different ways. The sequencing of China's force structure investments indicates the prioritisation of its strategic objectives. This also indicates that Taiwan and the SCS continue to have precedence over China's wider global ambitions.






If you're making your own smoothie, it needs to contain two pieces of fruit such as a banana and a pear, or one portion of fruit and a small glass of pure fruit juice.

A portion of fresh fruits or veggies is 80 grams. The World Health Organisation recommends at least 400 grams of fruits and vegetables daily to prevent obesity, heart disease, cancer and type 2 diabetes. So breaking this 400 into five servings means each serving should be around 80 grams.

portions? Studies show our health may benefit even more with greater intakes of fruits-veggies. The World Cancer Research Fund recommends that, in future, we should aim for at least 600g of fruits and veggies daily; equivalent to six portions. Meanwhile, a study published carrot.

earlier this year in the European Heart Journal found people who ate eight portions of fruits and veggies each day had a 22 per cent lower chance of dying from heart disease than those who ate three portions. For each extra portion added, the risk was lowered by 4 per cent.

Should we eat different fruits and veggies? To get the most health benefits, it's best to vary your choices as different fruits and veggies contain different combinations of fibre, vitamins, minerals and antioxidants. Aim to eat five differently-coloured fruits and veggies each day.

How can we get kids to eat five-aday? Don't be tempted to hide fruits and veggies in dishes as it would only keep them away. Children need to learn that fruits and veggies are tasty as well as beneficial for them, so get them involved in helping prepare meals and snacks that contain fruits and veggies.

acting on a tip, set up a joint operation with local police in Mathura. Around 4 a.m, they spotted Raju on a motorcycle near Baad railway station on the Agra-Mathura Highway, police said.



When Raju saw the police, he fired three shots. Officers returned fire with two rounds in self-defence. Raju was hit in the left leg and taken to the hospital, police said. Authorities recovered a .32-caliber pistol,

seven live rounds, three spent cartridges, and an unregistered motorcycle from the scene.

### Court asks man to chant 'Bharat Mata ki Jai', salute Tricolour in granting bail

The high court ordered the man to salute the Tricolour and chant 'Bharat Mata ki Jai' on the first and fourth Tuesday of every month till the end of his trial.

New Delhi. The Madhya Pradesh High Court has granted bail to a man accused of shouting a pro-Pakistan slogan and directed him to salute the national flag at a Bhopal police station 21 times and raise 'Bharat Mata ki Jai' slogan twice a month till the end of the trial.

The accused, identified as Faizal alias Faizan, was arrested in May following the registration of an FIR at Bhopal's Misrod police station. He was charged under Section 153B of the Indian Penal Code, which addresses imputations and assertions that can incite enmity between different groups. The prosecution contended that Faizan's actions promoted discord and undermined the country's integrity.

In the court's ruling, Justice Paliwal stated that Faizan could be released on bail upon furnishing a personal bond of Rs 50,000, along with one solvent surety of the same amount. This measure was put in place to ensure his regular appearance before the trial court throughout the legal

Furthermore, the court imposed several unique conditions as part of the bail. Faizan is required to report to the Misrod police station on the first and fourth Tuesday of every month until the conclusion of his trial.

During these visits, he must salute the 'national flag unfurled at the police station 21 times and chant the slogan 'Bharat Mata ki Jai' twice. The court emphasised that these conditions were designed to instil in him a greater sense of pride for the country in which he was born and raised.

'After investigation, a charge sheet has been filed," the court order noted.

The prosecution's case rested on evidence including a video in which Faizan was seen openly shouting slogans supportive of Pakistan while denouncing India.

The state government's counsel opposed the bail request, arguing that Faizan was a habitual offender with a concerning criminal history, which reportedly includes 14 previous cases against him.

In response, Faizan's defence counsel maintained that he had been falsely implicated in this matter, insisting that the charges were unfounded. However, the court acknowledged the evidence presented, which suggested otherwise.

### Couple, Army and IAF officers, die by suicide 240 km apart: Cremate us together

New Delhi.An Indian Air Force Flight Lieutenant allegedly died by suicide in Agra. Unable to bear the shock, his Army officer wife also took her own life by hanging herself inside a guest house at the Delhi Cantonment.

of the incident only on Wednesday. According to information, Deep took the drastic step on Monday night, and Renu followed a day later. Police found Renu's body hanging from a fan inside the guest house on Tuesday night. The reason for Deep killing himself is yet to be determined.

### 20 dead in Bihar's Siwan after consuming spurious liquor



New Delhi. At least 20 people have died after consuming spurious liquor in Bihar's Siwan. Bihar Chief Minister Nitish Kumar announced compensation of Rs 4 lakh each for the families of those who died in the incident. However, he said that the families would need to give a written undertaking in support of alcohol ban in the state.

A top police official said that people fell sick after consuming spurious liquor on October 15. He added that three individuals have been arrested while FIRs have been filed against eight others.

Police said that the spurious liquor came from Siwan and that teams have been formed to probe the matter. The official claimed that raids are being conducted in connection with the case and information about the substance will only be known after the post-mortem report comes out.

Meanwhile, the RJD slammed the NDA government in Bihar over deaths due to consumption of spurious liquor. "People have lost their lives by drinking spurious liquor. It is very sad and a matter of concern that despite the liquor ban law being in force in Bihar, spurious liquor is available. Every time during Holi and Diwali, it is seen how people die due to spurious liquor. The NDA government is directly responsible for this," RJD leader Mrityunjay Tiwari said.

Siwan Councillor Sushil Kumar Dablu accused the government of hiding the exact number of casualties. He said the number of deaths in the incident is nearing 50 while as many are hospitalised.

"The administration always reports false figures... They are trying to cover up. Had the administration been alert, such an incident would never have happened. Ever since liquor has been banned in the state, such incidents have happened very frequently," he said.

Former Deputy Chief Minister Tejashwi Yadav said people haven't died but have been "murdered". He said the number of casualties has increased to 30 while several have even lost their eyesight.

### Centre hands over security of nine 'highrisk' VIPs to CRPF, removes commandos

The transfer of duties between the two forces under the Minister of Home Affairs is expected to be completed within a month, officials said.

New Delhi. The Union government has ordered the complete withdrawal of the counter-terrorist commando force NSG from VIP security duties and handing over its nine "high-risk" VIPs to the CRPF by the next month, official sources said Wednesday.

The Ministry of Home Affairs (MHA) has also sanctioned a fresh battalion of specially trained personnel, recently withdrawn from Parliament security duties, to be attached to the CRPF VIP security wing. Sources said the protection of nine 'Z plus' category VIPs being guarded by the 'black cat' commandos of the National Security Guard (NSG) -- Uttar Pradesh Chief Minister Yogi Adityanath, his predecessor and BSP supremo Mayawati, Union defence minister Rajnath Singh, veteran BJP leader and former deputy prime minister L K Advani, Union shipping minister Sarbananda Sonowal, BJP leader and ex Chhattisgarh Chief Minister Raman



Singh, former Jammu and Kashmir Chief Minister and Democratic Progressive Azad Party (DPAP) president Ghulam Nabi Azad, National Conference (NC) president Farooq Abdullah and Andhra Pradesh Chief Minister N Chandrababu Naidu-- will now be guarded by the Central Reserve Police Force (CRPF). The transfer of duties between the two forces under the MHA is expected to be completed within a month, they said. The CRPF, which has six VIP security battalions, has been asked to absorb a seventh

battalion for this purpose. The fresh battalion is the one that used to guard the Parliament till a few months back. After a security breach that took place last year, the Parliament security was handed over to the CISF from the CRPF, a senior officer told .As part of the taking over the new task, a team of Andhra Pradesh Police was in Delhi recently for the change of its chief minister's security from the NSG to the CRPF, the sources said. Two among these nine VIPs will also

have the advanced security liaison (ASL) protocol being undertaken by the CRPF-- Defence Minister Rajnath Singh and UP Chief Minister Adityanath, as per the sources.

ASL involves an advance reconnaissance of the location to be visited by the VIP. The CRPF undertakes such a protocol for five of its VIPs including Home Minister Amit Shah, former Prime Minister Manmohan Singh and three Gandhi family Congress leaders.

#### 'DDA NOC not required for power meters in unauthorised colonies': Delhi CM

NEW DELHI. The Delhi government has removed the requirement for a No Objection Certificate (NOC) from DDA to install electricity meters in unauthorised colonies. Announcing the decision at a press conference on Wednesday, Chief Minister Atishi said that the move is aimed at tackling corruption and making the process smoother for residents who previously faced delays due to bureaucratic inefficiencies.

"Previously, those who paid bribes could get electricity connections, while others were left powerless," Atishi stated. "We've issued directives to prevent any further obstacles in these areas. The NOC process often led to unnecessary delays, forcing people to bribe officials and go through a tiresome ordeal just to get the certificate," she added. Atishi said that many residents from unauthorised colonies had raised complaints about difficulties in obtaining electricity connections. According to her, there are currently 1,731 illegal colonies in Delhi, where residents will now be able to install electricity meters without requiring a NOC.

The Chief Minister also accused the Delhi Development Authority (DDA) of causing unnecessary problems for people in these colonies, assuring that the Delhi government would ensure residents are not further troubled. Vijender Gupta, Leader of the Opposition in the Delhi Assembly, called the announcement misleading. "Atishi's press conference was filled with half-truths. The NOC requirement had already been lifted by the Lieutenant Governor on October 1, following public demand. Residents have been receiving electricity connections since then, and this new announcement is just an attempt by the AAP government to take undeserved credit," Gupta said.He added that the NOC was originally tied to the DDA and had already been abolished, rendering the Delhi government's latest decision redundant. Electricity and its related issues have become a contentious issue as the Delhi assembly elections are only months away.





### Hyundai IPO: Big drop in GMP on day 3, should you subscribe

New Delhi. Hyundai Motor India's initial public offering (IPO), the largest in India's history, is struggling to gain traction on its final day, with just 46% subscription so far. Despite its size, the IPO hasn't attracted much interest from investors, unlike other recent public issues that saw massive oversubscriptions.

So far, qualified institutional buyers (QIBs) have subscribed to only 65% of the shares reserved for them, while non-institutional buyers (like high net worth individuals) have subscribed 29%. Retail investors have subscribed to 41% of the shares allotted to them, while only the employee portion has been oversubscribed. According to market analysts, the Hyundai IPO is struggling due to concerns about its valuation. Many analysts believe the company is overvalued at its current price range, which has made potential investors cautious.

LATEST GREY MARKET PREMIUM (GMP)

The grey market premium (GMP), a common measure of investor sentiment, has also dropped significantly. As of now, the GMP stands at just Rs 17, suggesting a mere 0.87% listing gain at Rs 1,977 compared to the IPO price of Rs 1,960. While GMP is not always a reliable indicator of how a stock will perform on listing day, this drop aligns with analysts' views on the IPO's valuation. SHOULD YOU SUBSCRIBE?

Most analysts caution investors against expecting quick gains from Hyundai's listing, recommending instead that they focus on the company's long-term growth potential. With a solid presence in the Indian market, Hyundai plans to expand its product lineup and focus on premium vehicles. However, some experts caution that the high valuation of the IPO leaves less room for shortterm gains. Amar Nandu from SAMCO Securities points out that Hyundai is priced much higher than its competitor Maruti Suzuki, which could limit returns for investors looking for a quick profit.

Moreover, because the IPO is so large, many applicants are expected to receive shares. This wide distribution could prevent a big price surge after the listing, reducing short-term profit potential.

### TRAI refuses to issue consultation paper for spectrum allocation

NEW DELHI. The Telecom Regulatory Authority of India (TRAI) on Wednesday refused to issue a new consultation paper for spectrum allocation to satellite communication players.

This move goes against the demand of India's top telecom service provider, Reliance Jio, which advocates for an auction method for satellite spectrum allocation. Anil Kumar Lahoti, chairman of TRAI, said it is reviewing the comments on the existing consultation paper on spectrum allocation to firms from all stakeholders. However, he didn't address the possibility of issuing another consultation paper.

"We are receiving, and we keep on receiving multiple views from various stakeholders. They are in different dimensions and directions. As a regulator, we consider all stakeholders' views and then take a considered view that is in the best interest of all," said Lahoti.

TRAI released paper on September 27, 2024, seeking comments on frequency bands, pricing models, and spectrum assignment duration for satellite companies. Jio has urged TRAI to revise the paper to ensure a level playing field by including the option for satellite spectrum auction. While Bharti Airtel initially supported administrative allocation, has since shifted its stance in favour of auction.

#### Over Rs 75 per kg for tomatoes, Rs 50 per kg for onions: 29% households cut down vegetable consumption

NEW DELHI. Amid rising prices and budgetary constraints, close to 29 per cent Indian households that were part of a thin-sample survey reported having reduced the consumption of essential and green vegetables to cope with the unbridled price rise in the last few months.

One out of two Indian households are now paying over Rs 75 per kg for tomatoes, Rs 50 plus per kg for onions and over Rs 40 per kg for potatoes, the survey conducted by LocalCircles said. "In the case of potato, tomato, onion and other vegetables this may be a difficult choice if they are intrinsic to the family diet," it said. The survey said 29 per cent out of 14,619 consumers included in the study said that they "have reduced consumption somewhat to stay within budget", 42 per cent stated that they "have kept consumption the same and paid more while 29 per cent stated that they "have kept consumption the same but buying from sources that sell at lower prices". Nearly 56 per cent of 15,260 consumers who responded to the survey said that they bought "tomato for Rs 75 or more, potato for Rs 40 or more and onion for Rs 50 or more" while 29 per cent said that they bought "tomato for Rs 50-75, potato for Rs 30-40 and onion for Rs 40-50" and 6 per cent of respondents said they bought "tomato for Rs 50 or less, potato for Rs 30 or less and onion for Rs 40 or less". Though the government has stepped in to procure onion and sell it at subsidised prices, this benefit is restricted to residents in a few cities. The government should either ensure such interventions are at a national level or provide relief by reducing petrol and diesel prices to assist with the budget squeeze faced by many households. Vegetable prices have spiked in most cities due to disruption in supplies and damage to several crops. While the summer monsoon is over, adequate supplies of many crops like onion, tomato, green leafy vegetables is not arriving in the wholesale markets leading to higher-than-normal prices in the retail market, such that the central government through state-owned organisations is providing subsidised onions in cities like Delhi.

The demand for oil, gas, coal, electricity, and renewable energy will rise sharply, making India a key player in the global energy market. As the country continues to grow, it is adding over 12,000 cars to its roads daily. Additionally, the built-up space in India is expanding at an space in India is expanding at an

incredible rate, increasing by more than 1 b i 1 l i o n s q u a r e m e t r e s annually—equivalent to the total built space in South Africa today. These trends are expected to continue through 2035.

POWER DEMAND FROM AIR

## Meta job cuts hit WhatsApp, Instagram teams as tech layoffs drag on

**NEW DELHI.** Meta, the parent company of Facebook, Instagram, and WhatsApp, has once again begun laying off employees across various divisions, including WhatsApp, Instagram, and Reality Labs. The layoffs were reported by The Verge and mark another chapter in the ongoing wave of job reductions that have been affecting the tech industry. Some of the affected employees, such as

Jane Manchun Wong, who was part of Meta's Threads team and known for uncovering new app features, have openly shared their experiences of being laid off. Wong joined Meta in 2023 and was involved with developing its Threads platform. Meta spokesperson Dave Arnold commented on the situation, explaining that these layoffs are part of the company's strategy to reorganise its resources to better align with its longterm goals."When a role is eliminated, we work hard to find other opportunities for impacted



The recent layoffs follow a pattern of restructuring that Meta has been pursuing for more than a year. Earlier this year, Meta's Reality Labs division, which focusses on developing virtual and augmented reality products, was hit with job cuts. These moves have been part of CEO Mark Zuckerberg's larger "year of efficiency" plan, aimed at making the company more streamlined and effective. streamlined and effective.

In November 2022, Meta initiated its first round of major layoffs, cutting around 11,000 jobs after the company's workforce grew rapidly during the pandemic. At the time, Meta had misjudged the continued demand for digital services after lockdowns ended, which led to an over-expansion of its staff. When the anticipated growth did not materialise, the company found itself overstaffed and began the process of scaling back. The layoffs resumed in 2023, when another 10,000 jobs were

2023, when another 10,000 jobs were cut as part of Meta's efficiency drive.

These cuts targeted different parts of the company, including recruiting and technical roles. Zuckerberg described 2023 as Meta's "year of efficiency" focusing on strenglining efficiency," focusing on streamlining operations, reducing redundancy, and shifting resources to priority areas such as the development of the metaverse and AI-driven technologies. Meta is not alone in reducing its workforce. The broader tech industry has experienced a wave of layoffs over the past year, as companies adjust to the post-pandemic economic landscape.Companies like Google, Amazon, and Microsoft have also announced layoffs, reflecting a

## India's merchandise trade deficit narrows to five-month low in Sept

NEW DELHI. The country's five-month low to \$20.78 billion in September, attributed to a slowdown in import growth to 1.6% and a slight increase in merchandise exports by 0.5%. Goods trade deficit had reached a 10-month high of \$29.7 billion in August.Goods exports amounted to \$34.58 billion, while imports reached \$55.36 billion. Commerce Secretary Sunil Barthwal noted that despite various challenges, merchandise exports showed strong performance in the first half of FY24.Sequentially, goods exports have shown a fall in recent months, recording \$29.65 billion in August, \$33.98 billion in July, \$35.20 billion in June, and \$38.13 billion in May. Briefing media, Barthwal



highlighted the resilience of exports in the face of challenging conditions. He said engineering goods now represent nearly a quarter of total exports. Growth in sectors such as organic and inorganic chemicals, plastics, pharma and readymade garments has contributed to this these sectors have been pivotal in driving export growth, bolstering India's position as a major player in global trade.In September, goods imports totalled \$55.36 billion, slightly higher than \$54.49 billion in the same month last year but significantly lower than August's \$64.36 billion. # Hoax bomb threat on flights: Aviation industry's new financial headache

In the past few days, Indian airlines have faced multiple hoaxes, forcing flight diversions and delays, piling up massive operational costs.

NEW DELHI. Imagine boarding a flight, excited for a long-awaited holiday, only to hear the captain announce a sudden diversion due to a bomb threat. The chaos and confusion that follows aren't just stressful for passengers but are now becoming a costly headache for airlines. In the past few days, Indian airlines have faced multiple hoaxes, forcing flight diversions and delays, piling up massive operational costs. What seems like a harmless prank to some is quickly turning into a financial storm for an industry already battling sky-high expenses during its busiest travel season. The latest being a Vistara flight operating from Frankfurt to Mumbai. It received a

security threat on social media on Wednesday, an airline spokesperson said, adding that the aircraft was taken to an isolation bay for inspection after landing safely at the Chhatrapati Shivaji Maharaj International Airport.In the past three days, Indian airlines have experienced 13 bomb hoaxes, forcing flight diversions, delays, and cancellations. While these threats often turn out to be false alarms, they are causing real financial losses for airlines, which

are already struggling with rising expenses in one of the busiest travel periods of the year."While we don't have an exact figure yet, airlines are facing major costs related to crew, passengers, and preserving goodwill. We are not in a good position to manage these diversions, especially with the festive season ramping up occupancy," reported BusinessToday quoting a industry insider. When a bomb threat is received, airlines are required to take immediate action, which includes diverting flights, conducting security checks, and ensuring the safety of passengers and crew. These measures come with significant costs.



Airlines face extra expenses such as overtime pay for crew, additional fuel for detours, and hotel stays for stranded passengers. One example is an Air India flight from Mumbai to New York, which had to be rerouted to Delhi due to a bomb scare. According to CNBC TV18 report, the diversion cost the airline around Rs 24 lakh for fuel alone, with a further Rs 12 lakh spent on accommodating passengers in Delhi. Similar scenarios have unfolded with other airlines, leading to mounting losses. Flight delays also add to the problem. Rerouting planes mid-air and rescheduling departures not only increase fuel costs but also disrupt crew schedules. In some cases, airlines must

arrange overnight stays for passengers, book new landing slots, and bring in fresh crew due to duty limitations. All of this makes handling bomb threats a costly affair. Airlines aren't the only ones affected. Airport operations are also thrown into chaos as authorities carry out security checks and investigations. Delays can cause a domino effect, impacting other flights and leading to further disruptions. The Ministry of Civil Aviation (MoCA), along with other agencies like the Bureau of Civil Aviation Security (BCAS) and the Ministry of Home Affairs (MHA), is actively working to address the issue. A Bomb Threat Assessment Committee has been formed to assess the risks and recommend countermeasures to prevent future hoaxes.Law enforcement agencies are also involved in identifying the sources of these hoax calls. Once the culprits are apprehended, the Ministry is considering adding them to a no-fly list to prevent future incidents. Civil Aviation Minister Ram Mohan Naidu has held meetings with the Directorate General of Civil Aviation (DGCA) and ministry officials to discuss the way forward.
