#### NDA partners AJSU Party to contest 10 seats, JD(U) 2, LJP (Ram Vilas) 1 in J'Khand polls

New Delhi, Oct. 18: Assam Chief Minister Himanta Biswa Sarma, also the BJP's co-in-charge for Jharkhand Assembly elections, on Friday said Democratic Alliance



(NDA) constituents AJSU Party will contest 10 seats, JD(U) two and LJP (Ram Vilas) one. Sarma said while the seat-sharing arrangement is nearly finalised, the BJP is adopting a "wait and watch" strategy as rival parties, including the Jharkhand Mukti Morcha, are yet to disclose their plans. The elections for the 81member Jharkhand Assembly will be held in two phases, on November 13 and November 20, with the count-

ing of votes scheduled for November 23. Sarma said, "NDA allies AJSU Party will contest 10 seats, JD(U) 2, and LJP (Ram Vilas) 1 in Jharkhand as per the seat-sharing arrangement,

which is almost finalised." AJSU Party will contest from Silli, Ramgarh, Gomia, Ichagarh, Mandu, Jugsalai, Dumri, Pakur, Lohardaga, and Manoharpur. JD(U) will field candidates in Jamshedpur West and Tamar, while LJP (Ram Vilas) will contest from Chatra, he said. Sarma made these remarks in the presence of Agriculture Minister Shivraj Singh Chouhan and AJSU Party chief Sudesh Mahto. As per the arrangement, the BJP will con-

test 68 seats, but discussions are ongoing, and a final decision will be made soon. "We will fight the elections under the leadership of Prime Minister Narendra Modi and on the agenda of development," Sarma said. Chouhan said the central leadership has decided the NDA will jointly contest the elections in the state to "save the identity of Jharkhand and to protect 'Mati, Beti, and Roti' (land, daughter, and

#### Personal laws can't hinder law preventing child marriage: SC

New Delhi, Oct 18: The Supreme Court on Friday said the Prohibition of Child Marriage Act cannot be stunted by traditions under any personal law and observed marriages involving children violate the free will to choose a life partner. A bench comprising Chief Justice of India (CJI) D Y Chandrachud and Justices J B Pardiwala and Manoj Misra further issued a slew of guidelines for the effective implementation of the law on prevention of child marriages in the country. The bench, however, noted the issue whether the Prohibition of Child Marriage Act (PCMA) would prevail over personal laws was pending with the Parliament for consideration. The Centre had urged



the apex court to hold the PCMA to prevail over personal laws. "While the PCMA seeks to prohibit child marriages. It does not stipulate big social malaise of marriages fixed in the minority of a child which also have the effect of violating the rights to choice...It takes away from them, their choice of partner and life paths before they mature and form the ability to assert their agency...," the CJI said. The court noted that child marriages require an intersectional approach that acknowledges the overlapping vulnerabilities experienced by children, especially girls, from marginalised communities. "Inter-sectionality involves considering factors like gender, caste, socio-economic status and geography, which often increase the risks of early marriage" the CJI said. Preventive strategies should be tailored to the unique needs of various communities besides focusing on addressing the root causes of child marriage, such as poverty, gender, inequality, lack of education, the judgement said. The PCMA as a social legislation will only succeed through the collective efforts of all stakeholders to address the issue within a broader social framework, which emphasises the need for multi sectoral coordination," it added. According to the top court, the scenario necessitated the enhancement of reporting mechanisms, expansion of public awareness campaigns and investment in the training and capacity building of law enforcement.

#### PM Modi proposes holding NDA leaders conclave twice every year

New Delhi, Oct 18: Prime Minister Narendra Modi has described the meeting of NDA leaders in Chandigarh on Thursday as the largest get-together of non-Congress political parties post 1975, the year Emergency was imposed, and called for holding such a conclave twice every year, a BJP statement said. Making a point about the deeper connect his government enjoys with people compared to the previous Congress-led UPA government, he said at the meeting that he has received over 4.5 crore letters in the past 10 years compared to only 5 lakh letters received by his predecessor. Manmohan Singh headed the UPA government during 2004-14. Modi

said at the conclave attended by 17 chief ministers and 18 deputy chief ministers from the BJP and its several allies that smooth governance, fast decision-making and transparency in governance have helped in attracting investors and investment in the states ruled by the NDA. The NDA is fulfilling the rising aspirations of the common citizens and it has been the distinction of its government to ensure the last mile delivery which has helped in building the trust in public towards the government since 2014, he said. Modi dwelt on the concept of pro-people pro-active good gover-



nance (P2G2), stressing the need for greater interaction between all NDA-ruled states, as also among ministers and MLAs and advocated the use of social media for this. The prime minister lauded the BJP's win in Haryana as significant and historic, saying the NDA has secured the trust and support of all sections of society. The opposition, he said, tried to portray a false narrative of the NDA being anti-farmer whereas it was the farmers who came out in large numbers to support the ruling party. People gave a clear message that they stand with progress and the good governance agenda of the NDA. He said good governance ultimately means finding solutions to people's problems, asserting that solution-centric governance with focus on grievance-redressal is a distinctive identity of all NDA state governments. #### Allow one-time withdrawal from NSS schemes: GCCI

Ahmedabad. The central govt has issued a directive regarding the National Savings Scheme (NSS), mandating that depositors withdraw their funds by Sep 30, with the subsequent cessation of interest payments effective from Oct 1, 2024. Top officials of the department of posts have stated that the directive applies only to those depositors who have NSS 87 and NSS 92 accounts. The Gujarat Chamber of Commerce and Industry (GCCI) has demanded that since the withdrawal is taxable, the govt should allow a one-time withdrawal option until March 31,

A top official from the department of posts in Ahmedabad said, "The NSS 87 was discontinued from Oct 1,1992, and NSS 92 was discontinued from Nov 1, 2002. Both these schemes do not see new investments, and many accounts are already closed. So the ministry of finance has issued directives to encourage people to withdraw their funds from these schemes and to invest in other

GCCI has written to the Central Board of Direct Taxes (CBDT) regarding the issue. Jainik Vakil, chairman of the GCCI direct tax committee, said, "This decision has raised significant concerns among long-term depositors who relied on this scheme for their financial security. The NSS, introduced in 1987, provided an attractive investment option with an initial interest rate of 11%, which was subsequently adjusted to 7.5%. Under this scheme, depositors were permitted to invest up to Rs 40,000 annually, enjoying the added benefit of tax deductions under Section 80C of the Income Tax Act, 1961. The scheme's flexibility allowed savers to withdraw both their principal deposits and the accrued interest after a lock-in period of four years, contributing to its popularity among investors. The official regulations stipulate that any amount withdrawn from NSS is subject to taxation in the year of withdrawal. However, if the depositor chooses not to withdraw the funds, the interest earned on those deposits remains tax-free, provided the funds remain in the account." Moreover, should a depositor's heirs withdraw the funds following the depositor's death, the entire amount is treated as tax-free. This provision has incentivised many account holders to maintain their accounts over the years, he added.

## Metal barrier to protect solar roof cycling track in Hyderabad

HYDERABAD. Concerned about the frequent damage to India's first 23-km Solar Roof Cycle Track along the Outer Ring Road (ORR), the Hyderabad Growth Corridor Limited (HGCL) has decided to protect the track by installing "W" Metal Beam Crash Barriers.

These barriers will span 19.2 km from Nanakramguda to Telangana Police Academy (TGPA) and from Himayasatsagar to Narsingi to Kollur, at an estimated cost of Rs 8.05 crore.On average, two to three accidents occur monthly, primarily due to speeding vehicles colliding with the track, especially since the widening of the

BENGALURU. Bruhat Bengaluru Mahanagara Palike (BBMP) on Thursday launched a pilot project - Kukur Tihar (festival of dogs) - to provide food to strays. Under the pilot project, the civic body has identified eight 'feeding spots' in each of its eight zones. If it is successful, the project will be scaled up across the city.

BBMP Special Commissioner (Health) Suralkar Vikas, who inaugurated the project, said, "Stray dogs are often viewed with fear due to the concern that they may bite and attack. This festival is to do away with this fear. There are over 2.7 lakh strays

After discussions with animal welfare volunteers, veterinarians and experts, we found that one of the major reasons for dog bites and aggression is that they lack food."

He said the project is part of the BBMP's One Health initiative under which pourakarmikas, health officials, animal lovers, pet owners and interested citizens will collect leftover food from hotels and restaurants and feed it to stray dogs at designated

Vikas said the primary goal is to provide food to dogs regularly, and they aim to distribute food once a day. He said hoteliers have agreed to provide healthy, non-spicy, oil-free food for the dogs.

The feeding spots will have food, water bowls and a signboard indicating that it is a feeding station. The pilot project will be monitored for a month, and based on feedback, the feeding location, timings and other shortcomings will be addressed before scaling up the project for the entire city."

And the tea shop continued to witness regular tete tete over a cup of hot tea and breakfast delicacies in the morning and warm snacks in the evening. And no one would pass by without packing the famous 'Rasavada' to take home. It never saw a slow day over the past eight decades. However, the



shop is now a memory for the old timers to recall. "Gopakumaran's shop was taken over as part of the Vattivoorkavu development project. My shop also comes in the project course, and I also shifted from the spot a few years ago. Sometimes, we hear that the

project will take off, but it seems to be in fits and starts," says K Jayadharan Nair, an entrepreneur who runs two business establishments in the area. He, however, feels it's all talk, and the project is just an eyewash. "I have no hope; we have been hearing

this talk for the past 10 years," he says. Regular commuters agree as they point to the bottleneck the junction turns into during peak hours. But Thiruvananthapuram Development Authority (TRIDA) officials feel otherwise. A highly placed source in the authority told TNIE that the land acquisition process for rehabilitation of displaced is complete and works are in full swing for 'meaningful rehabilitation'.

The aim is to finish the construction work for rehabilitation by March 2025," says the official. #### 8th Paradiso tower with 60 families is now dubbed unsafe

Gurgaon. The Central Building Research Institute (CBRI) has deemed Tower A of Chintels Paradiso unfit for living, marking the eighth tower in the ninebuilding complex to be declared unsafe.

The recent audit revealed significant structural deterioration in Tower A, primarily because of severe corrosion caused by high chloride content and poorquality concrete — similar to issues found in the other towers. Tower A comprises 64 flats, 60 of which are occupied.Structural audits by IIT-Delhi earlier had already declared six other towers — D, E, F, G, H, and J - unsafe, with the demolition of these buildings expected to start next month. IIT had then classified Towers A, B, and C as safe, but warned of potential deterioration in the future. In response, Chintels India initiated a new round of audits through CBRI to further assess the condition of all towers.The CBRI report highlighted that almst all structural elements in Tower A were compromised because of corrosion and poor concrete quality, making the structure non-compliant with Indian safety standards, especially in seismic zone IV.A spokesperson for the developer said, "Once Tower A is vacated, we will offer compensation to flat owners or allow them to opt for reconstruction. JNU's Prof. Mazhar Asif--Concerns Over His Candidacy As Jamia Millia Islamia VC

New Delhi: Jawaharlal Nehru University (JNU) Professor Mazhar Asif faces allegations of severe castebased harassment against Reena, a Scheduled Tribe (S.T) employee. The complaint, reviewed by JNU authorities, accuses Asif of deliberately giving Reena low grades, blocking promotions, and favoring ineligible candidates during his tenure as Associate Dean. The case raises concerns over his potential appointment as Vice-Chancellor of Jamia Millia Islamia. Reena fought the injustice in Delhi High Court and the National Commission for Scheduled Tribes. After an independent review, her grades were revised from 5.5 to 8.66, proving unjust actions by Asif. Despite this, Asif has managed to suppress the case through political and personal connections. His candidacy for Jamia's Vice-Chancellor now raises serious concerns for SC/ST students and staff. The case brings up crucial questions about the leadership of central universities. There are growing calls for the government and judiciary to take strict action against Prof. Asif to ensure that casteism and discrimination have no place in educational institutions.

#### 8-year-old boy dies shielding his younger sister from bike in Gzb

Ghaziabad. An eight-year-old boy on way home with food for his mother died shielding his younger sister from a road accident in Vaishali on Wednesday afternoon. Anmol and his sister Reshma were crossing a road when he saw a biker hurtling down at them at high speed. He pushed his sister away to a corner of the road, but failed to jump to safety himself. Passersby took him to Max Hospital in Vaishali, where he succumbed to injuries during treatment.

Swatantra Singh, ACP (Indirapuram), said they received information about the fatal accident from the hospital authorities." Around 3.15pm, the two children were crossing the road when they were alerted by a biker



frantically sounding the horn. The boy pushed his sister away, but was himself hit by the speeding bike," he added. Anmol and Reshma would beg on the streets. Their mother, who is separated from her husband, was high on drugs at their home in a Vaishali slum when the accident occurred, Singh said. Their father is believed to live somewhere in Nepal.

"The two kids were returning home after buying food with whatever they could earn for the day when the bike hit the boy. We haven't yet received any complaint. But the body has been sent for an autopsy. We are checking CCTV footage from cameras installed in nearby areas to identify the biker," Singh said.

In another accident, a 34-year-old woman died while her six-year-old son and husband suffered grievous injuries when their bike was hit by a truck near Dasna bridge on Thursday.Nikki Singh, her husband Yatendra (36) and their son Krishna were on their way home in Madhuban Bapudham when the accident occurred around 6am. Abhishek Srivastava, ACP (Kavi Nagar), said the truck hit the bike from behind near Govindpuram police chowki."A police team rushed to the spot after getting information and took the injured family members to a nearby hospital for treatment. Nikki, who suffered critical injuries to her head, died during treatment. Her son Krishna, too, is seriously injured. Only Yatendra wore a helmet, which is why he is stable now," he added.

## Streetlights out, dark spots raise safety risk here

Noida. Residents of Greater Noida have raised complaints regarding nonfunctional streetlights across several sectors, including Sectors Alpha, Beta, Delta, Mu, Xu, Sigma, among others. GNIDA officials conducted ground checks earlier this week, but no redress has been seen so far, residents said.

GNIDA ACEO Prerna Singh, along with a team of officials, undertook ground checks on Tuesday and Wednesday and noted several dark spots in the city across both residential and industrial sectors.

Affected areas include the service lanes of Sectors 37, Mu, Xu, and towards the police post near Omaxe Mall in Beta-2. along with the service lane between Sigma and Sector 36. Residential sectors such as Beta, Alpha, Delta, and more, were also found to be in the dark. Additionally, 50% of the streetlights in industrial sector Ecotech 3 were found to be non-functional as well."It's been several months since we complained about non-functional street lights in our sector, like in H, C, B, etc blocks. There are many lights which are faulty, leading to dark spots. These lead to issues of safety and security of the residents," said Rishipal Bhati, RWA general secretary of Delta 1.ACEO Singh directed officials to



repair or replace all non-functional lights before Diwali. She also directed that the lights be monitored through the control room built in the GNIDA office. Additionally, LED lights will be installed to illuminate key areas of Greater Noida including main roads, intersections and important govt buildings – in preparation for Diwali.Residents can raise complaints on contact number 7982300721 and helpline number 18008332314, officials said. Meanwhile, residents also demanded sanitation drives be conducted ahead of the festival. "Untended garbage, C&D waste and

clogged sewers are common problems across several sectors. There is no regular sweeping of roads or cleanliness of parks and green spaces. All this leaves the city looking dirty and unhealthy. Given the scenario, the festive spirit is also affected. We made several complaints to the Authority, but no action has been taken so far," said Harinder Bhati, a resident of

Taking note of residents' woes, GNIDA CEO NG Ravi Kumar has directed special cleanliness drives before Diwali.

The CEO has assigned responsibilities across several departments - including public health, civil, horticulture, electrical, etc – so that cleaning, repair and beautification work in all sectors can be completed on time.

Work including sweeping, cleaning, and garbage disposal along with repair of curb stones, RCC poles, and wire fencing installed on the roadside, painting work to pruning of trees in parks, cutting grass, and repairing parks, etc., will be done under this drive," said a GNIDA official.

#### VK Singh's daughter files FIR against bizman for Rs 3.5 crore fraud

**Ghaziabad.** Yogja Singh, the daughter of former Union minister General V K Singh (retd), has filed an FIR at the Kavinagar police station in Ghaziabad accusing a local businessman named Anand Prakash of committing a fraud amounting to approximately Rs 3.5 crore."In her complaint, Yogja Singh claimed that she entered into an agreement to purchase a house at Rajnagar Colony for Rs 5.5 crore. But despite the payment of Rs 3.5 crore, the seller failed to finalise the sales deed. The agreement was made in 2014, and she subsequently provided additional

funds via cheque for the property's renovation," assistant commissioner of police Abhishek Srivastav said. The former Army chief's daughter claimed in her complaint that in Aug this year, Anand Prakash sent her a notice based on false information.In her response, she accused Prakash of attempting to misappropriate the funds she had given to him."She also alleged that Prakash fabricated a receipt to support an eviction suit against her, and that she found out that a loan had been taken against the house with efforts underway to increase the loan amount.

## 3 ministers from NCR, 6 from south Haryana as Team Saini takes oath

Gurgaon. In the 14-member state cabinet led by chief minister Nayab Singh Saini, who is starting as head of govt afresh after a short term as CM before the assembly elections, south Haryana has found a significant place.

The region, which has remained a BJP fortress since 2014, will have six ministers in the cabinet - three from NCR (two from Faridabad and one from Gurgaon) and one each from Palwal, Mahendergarh and Bhiwani.

Rao Narbir Singh and Vipul Goel, who were ministers in the first BJP govt led by Manohar Lal Khattar from 2014-19, made comebacks. Aarti Rao, daughter of Gurgaon MP and Union minister Rao Inderjit Singh, Shruti Choudhary, who along with her mother Kiran Choudhary switched to BJP from Congress before the election, Rajesh Nagar and first-time MLA Gaurav Gautam are the others to become ministers. The Ahirwal region, where BJP won 10 out of 11 seats, will have two faces in the ministry in Narbir and Arti, who has earned a cabinet berth in her debut innings as MLA after winning a close election in Ateli. This is the highest representation for south Haryana in the three BJP terms (two with single-party majority and one in coalition with JJP). In the first BJP govt under Khattar, south Haryana had five ministers, which reduced to three in the second term when JJP was an alliance partner. The govt led by Saini, after he replaced Khattar as CM this March, had five ministers from south Haryana. Signifying his seniority in the cabinet, Narbir was the fourth to take oath on Thursday after Saini, former home minister Anil Vij and Israna MLA Krishan Lal Panwar. Ministries have not been allocated yet.

Goel, who was first elected MLA from Faridabad in 2014, had become a minister in 2016 during the cabinet reshuffle. But relations soured between him and the party after he was denied a ticket in 2019. This election, he was given the green light to contest again and won, putting him among leading contenders for induction into the cabinet.Shruti, granddaughter of former CM Bansi Lal, first contested elections from Mahendergarh-Bhiwani Lok Sabha constituency in 2009 and defeated Ajay Singh Chautala of INLD to become MP. In 2014 and 2019, she was defeated by BJP MP Choudhary Dharambir Singh. In the 2024 LS election, Congress denied her a ticket and fielded Bhupinder Singh Hooda's loyalist Rao Dan Singh. Before the assembly polls, Shruti and Kiran switched to BJP. Shruti contested her first assembly election from Tosham, defeating cousin and Congress candidate Aniruddh Choudhary by 14,257 votes.Besides Arti, another MLA elected to the assembly for the first time is Gaurav Gautam, who represents Palwal. BJP replaced its sitting MLA Deepak Mangla with the young Gautam and it paid off.

The induction of six ministers from South Haryana is not surprising. The region deserves its share in governance. It has been supporting BJP. Besides, south Haryana has been making maximum contribution to the state's coffers," said political expert Dr Kushal Pal, who is principal of Indira Gandhi National College,

#### Anaemia, diabetes key health issues in adults: Survey

Gurgaon: A door-to-door screening drive, which covered around 4 lakh people in the district, found prevalence of malnourishment and lowbirth weight among children even as anaemia, tuberculosis, diabetes and hypertension among adults were the "key health issues". While 5,543 people were found to be suffering from anaemia, 4,648 suffered from hypertension, 3,529 from diabetes, 267 with cardiac diseases and 23 with cancer. The survey was conducted as part of the Nirogi Haryana Yojana, under which health checkups are to be conducted once every two years to identify and reduce the burden of disease.

The identified population has been categorised into six age groups for check-ups. "Health workers have been conducting check-ups for eligible individuals and directing them to facilities for comprehensive testing. To enhance this process, the state govt plans to develop health packages," chief medical officer Virender Yadav said. In Gurgaon, 44 lakh tests have been conducted so far since Nov 1, 2022. The tests also helped diagnose 17 cases of TB and 21 patients who were unaware of neurological strokes. The state govt aims to screen 1.2 crore people with an annual income of less than Rs 1.8 lakh.Since its launch in 2022, around 4.3 crore tests have been

#### Pakistan on-campus rape: Violent protests in Lahore; properties damaged, one killed

World Police in Pakistan used tear gas and batons to disperse student protesters on Thursday after they ransacked a college building. The protests erupted over an alleged on-campus rape in Lahore that has sparked anger and demonstrations in four

Reports of the incident spread on social media, increasing tensions on college campuses. Students in Rawalpindi, Punjab province, burned furniture and blocked a key road before vandalizing a college

Earlier, a security guard died during clashes between student protesters and police in Gujrat, also in Punjab province. Authorities arrested one person related to the guard's death and another for spreading misinformation about the alleged rape.

In Lahore, over two dozen students were injured earlier this week while demanding justice for the alleged victim, who students claim was raped at the Punjab Group of Colleges. In response to the growing unrest, the government banned rallies in Punjab The Federal Investigation Agency filed cases against 36 people accused of spreading misinformation on social media. Authorities, including the Punjab chief minister, and the woman's parents denied any assault happened. However, Punjab police called on the public to share any

information regarding the alleged rape. The unrest seems to have started spontaneously, as student unions in Pakistan have been banned since 1984.

These protests also come after a woman reported being gang-raped during a polio vaccination drive in Sindh province last month. Police arrested three men involved, but the woman's husband expelled her from home, citing damage to the family name.

#### **US Sanctions 2 Indians** For Alleged Ties With Houthis

New York. The US has sanctioned two Indians for their alleged ties to a Houthi network transporting Iranian oil to raise funds for its activities in disrupting shipping in the Red Sea region and attacking Israel.

Both are linked to a Sharjah-based Indo Gulf Ship Management (IGSM) company -- Rahul Rattanlal Warikoo Rattanlal as Managing Director and Dipankar Mohan Keot as Technical Manager, according to the US Treasury Department. Under the sanctions, all their property and any others in which they have more than 50 per cent interest are frozen in the US. State Department Spokesperson Matthew Miller asserted on Thursday that they had ties to the network of Houthi financial operative Sa'id al-Jamal, who in turn was backed by the Iran-based Islamic Revolutionary Guard Corps-Qods Force.

The Treasury Department said that IGSM served as the operator of a vessel that was used by the al-Jamal network to ship several millions of dollars worth of Iranian fuel oil Rattanlal, who is based in India and the UAE has served in management roles for USdesignated companies Safe Seas Ship Management FZE and Aurum Ship Management FZC, "which have been implicated in Iranian oil shipments for Iran's Ministry of Defense and Armed Forces Logistics (MODAFL) and the al-Jamal network", the Department said. Keot, who is based in India and Hong Kong, as the technical manager of Indo Gulf Ship Management "is responsible for monitoring vessel operations, including the budget and expenditure of the vessels under Indo Gulf Ship Management LLC's oversight", the Treasury Department said.

# Hezbollah says it will escalate war with Israel after killing of Hamas chief



Jerusalem. Lebanon's Hezbollah militant group said on Friday it was moving to a new and escalating phase in its war against Israel, while Iran said "the spirit of resistance will be strengthened" after the killing of Hamas leader Yahya Sinwar.Sinwar, a mastermind of the October 7, 2023, attack that triggered the Gaza war, was killed during an operation by Israeli soldiers in the Palestinian enclave on Wednesday, a pivotal event in the year-long conflict. Western leaders said his death offered an opportunity for the conflict to end, but Israeli Prime Minister Benjamin Netanyahu said the war would go on until the hostages seized by Hamas militants were returned."Today we have settled the score. Today evil has been dealt a blow but our task has still not been completed," Netanyahu said in a recorded video statement after the death was confirmed on Thursday."To the dear hostage

We will continue full force until all your loved ones, our loved ones, are home."Sinwar, who was named as Hamas' overall leader following the assassination of political chief Ismail Haniyeh in Tehran in July, was believed to have been hiding in the warren of tunnels Hamas has built under Gaza over the past two decades. He was killed during a gun battle in southern Gaza on Wednesday by Israeli troops who were initially unaware that they had caught

Israeli officials said. The military released drone video of what it said was Sinwar, sitting on an armchair and covered in dust inside a destroyed building. Hamas has not made any comment itself, but sources within the group have said the indications they have seen suggest Sinwar was indeed killed by Israeli troops.

Despite Western hopes of a ceasefire, Sinwar's death could dial up hostilities in the Middle East where the prospect of an even wider conflict has grown.

Israel has launched a ground campaign in Lebanon over the past month and is now planning a response to an Oct. 1 missile attack carried out by Iran, ally of Hamas and Lebanon's Hezbollah.

But the demise of the man who planned the attack last year in which fighters killed 1,200 people in Israel and captured more than 250 hostages, according to Israeli tallies, could

also help push forward stalled efforts to end the war in which Israel has killed more than 42,000 Palestinians, according to Gaza health authorities.U.S. President Joe Biden, who spoke to Netanyahu by phone to congratulate him, said Sinwar's death provided a chance for the conflict in Gaza to finally end and for Israeli

hostages to be brought home. The U.S. wants to kick-start talks on a proposal to achieve a ceasefire and secure the release of hostages, U.S. State Department spokesperson Matthew Miller said, calling Sinwar the "chief obstacle" to ending the war. "That obstacle has obviously been removed. Can't predict that that means whoever replaces (Sinwar) will agree to a ceasefire, but it does remove what has been in recent months the chief obstacle to getting one," he said. In recent weeks, Sinwar had refused to negotiate at all, Miller said.

## Canada's ex-NSA explains how cops changed tack in Nijjar killing probe

World In a fresh twist in the investigation into the murder of Khalistani terrorist Hardeep Singh Nijjar, Canada's former national security adviser (NSA) Jody Thomas testified that initial intelligence and police probe suggested the killing was a retaliation for the murder of Ripudaman Singh Malik, who was accused of involvement in the 1985 Air India Kanishka bombing.

Thomas, who was NSA at the time Nijjar was gunned down in Surrey last year, appeared before Canada's foreign interference inquiry and claimed that certain members of the Canadian Sikh community were not satisfied with the assessment that Nijjar's killing was a tit-for-tat for Malik's murder."It [Nijjar's killing] was the second high-profile murder in the same gurdwara," Thomas and "Malik's marder had become said. "Mr Malik's murder had occurred almost exactly the year before. The initial hypothesis was that it was a retaliation. But the community was raising concern."Ripudaman Singh Malik, a Sikh



activist acquitted in the 1985 Air India Kanishka terror bombing, was shot dead in Surrey on July 15, 2022. Malik's death came after a public smear campaign against him by Nijjar, the leader of the Khalistan Tiger Force, who had labelled him a traitor and called for his social boycott. However, as the investigation progressed, further intelligence indicated that Nijjar's assassination might have been an extra-judicial killing. "Through very good intelligence and policing work, we learnt that there was a high probability that this was an extra-judicial killing,

Thomas stated.In response to Malik's killing in 2022, sources in Indian intelligence agencies told India Today that it was part of a broader conspiracy involving pro-separatist forces, possibly supported by Pakistan's ISI. They also said that the role of Nijjar in the killing could not be ruled out.

Thomas's testimony coincided with Prime Minister Justin Trudeau's appearance before the same commission, where he accused India of violating Canada's sovereignty. In response, the Ministry of External Affairs stated again that Canada has not provided India any evidence of the allegations.India has consistently criticised Trudeau's government for its leniency towards Khalistan supporters in Canada. The tension between the two nations escalated last year after Trudeau's explosive claim in parliament that Indian agents were involved in Nijjar's death. India dismissed the allegations as "absurd" and

#### Good day for Israel: Joe Biden on killing of Hamas chief Yahya Sinwar

UPDATED. President Joe Biden said Thursday that the killing of Hamas leader Yahya Sinwar by Israeli troops is a "good day for Israel, for the United States, and for the world," calling it an "opportunity" to free hostages held by the terrorist group and end the yearlong war in Gaza.US officials expressed measured optimism that the killing of a terrorist characterised by national security adviser Jake Sullivan as a "massive obstacle to peace" might breathe new life into cease-fire talks that have failed to produce a breakthrough despite periodic signs of progress."Over the past few weeks, there have been no negotiations for an end to the war because Sinwar has refused to negotiate," State Department spokesman Matthew Miller told reporters Thursday. "We now see an opportunity with him having been removed from the battlefield, being removed from the leadership of Hamas, and we want to seize that opportunity."Biden, in a statement as he was on his way to Germany, compared the reaction to Sinwar's death to the feeling in the US after the killing of al-Qaida leader Osama bin Laden, who was responsible for the September 11, 2001, attacks. He said the killing of the mastermind of the October 7, 2023, attacks on Israel "proves once again that no terrorists anywhere in the world can escape justice, no matter how long it takes."Biden said he would speak with Israeli Prime Minister Benjamin Netanyahu and other Israeli leaders to congratulate them "and to discuss the pathway for bringing the hostages home to their families, and for ending this war once and for all." Some 100 hostages are still inside Gaza, about a third of whom are believed to be dead. The inability to reach a cease-fire that could end the war in Gaza and also deliver the return of the hostages has bedeviled negotiators from the start. The US has been working with fellow mediators Egypt and Qatar on a cease-fire proposal in Gaza since the war began a year ago, sending Secretary of State Antony Blinken and other envoys to the Middle East multiple times to try to broker a deal without

## Taiwan president thanks air force for 'outstanding' work during China war games

TAIPEI. Taiwan President Lai Ching-te thanked the air force on Friday for their "outstanding" work during Chinese war games around the island earlier this week, telling them to keep up the good work.

China's military said Monday's day of war games were a warning to "separatist acts", vowing to take further action against the democratically governed island Beijing claims as its own territory if needed.

Visiting air force headquarters in Taipei, was connected by radio to what sounded like a fighter pilot who the president identified by their call sign, "Viper One", in a video released by the presidential office."Thank you for your hard work for



our country. Please continue to guard the airspace of the Taiwan Strait national security, and have a safe and smooth flight," Lai said, before adding in English "happy landing".In subsequent comments made to personnel inside air force command, Lai praised their

performance."We were all on full alert during these Chinese exercises and did our best. The performance was outstanding. Thank you very much and please keep up the good work in our duty to protect and defend our country."Taiwan's air force, which is dwarfed by that of China's, has repeatedly scrambled in to see off almost daily missions by the Chinese military around the island. During Monday's drills, Taiwan said it had detected 153 Chinese aircraft, the highest figure for a single day.Lai and his government reject Beijing's sovereignty claims. ## Ex-RAW official charged in US over plot to murder Khalistani terrorist Pannun

The indictment claimed that the former Indian RAW official, along with his co-conspirator, plotted to kill Pannun in the summer of 2023 and hired an individual who demanded \$100,000 for the job. The individual turned out to be an FBI informant. World The United States has charged a former RAW official, Vikash Yadav, for allegedly orchestrating a failed plot to assassinate Khalistani terrorist Gurpatwant Singh Pannun residing in New York City.The US Justice Department has charged the former Indian intelligence officer with murder-for-hire and money laundering."Today's charges demonstrate that the Justice Department will not tolerate attempts to target and endanger Americans and to undermine the rights to which every US citizen is entitled," US Attorney General Merrick B Garland said. The plot reportedly began in May 2023, spearheaded by Yadav, then an employee of the Indian government. Yadav allegedly collaborated with individuals in India and abroad to orchestrate the assassination of Gurpatwant Singh Pannun, a designated terrorist in India.Meanwhile, Nikhil Gupta, an

Prague last June after travelling from India. Gupta has since been extradited to the US and pleaded not guilty to charges of conspiracy to commit murder. The indictment details Yadav's alleged plan, including hiring Gupta to "orchestrate the assassination of the victim in the United States."According to US officials, urgency surrounded the plot following the murder of Hardeep Singh Nijjar, another Khalistani terrorist, in Canada in 2023. Gupta believed that there was "now no need to wait" for Pannun's assassination after Nijjar's death. The indictment reveals that Yadav and Gupta contracted an individual to carry out the assassination for \$100,000, only to discover that the hired assassin was actually an FBI informant. Just days before Indian Prime Minister Narendra Modi's visit to the US, the informant received a \$15,000 advance for the murder in a car in New York, with photographic



Yadav reportedly instructed Gupta and the informant to postpone the killing until after PM Modi's visit to prevent diplomatic fallout during the high-profile event. A message from Yadav to Gupta suggested the need for verification before proceeding with the assassination.

In response to the allegations, the Indian Ministry of External Affairs confirmed that the individual named in the US Justice Department's indictment is no longer affiliated with the Indian government."The US State Department informed us that the individual in the Justice Department indictment is no longer

employed by India. I confirm that he is no longer an employee of the Government of India," MEA spokesperso Randhir Jaiswal stated.US State Department Spokesperson Matthew Miller added that the Indian delegation had met with an inter-agency team from the

FBI, Department of Justice, and State Department, highlighting ongoing cooperation in the investigation."They did inform us that the individual who was named in the Justice Department indictment is no longer an employee of the Indian government. #### Indian national accused of being recruited by Yadav, was arrested in Elon Musk now offers \$100 to mobilise swing state voters in support of Trump

World With the US presidential election in its final stretch, billionaire Elon Musk is ramping up his support for Republican candidate Donald Trump's campaign by offering \$100 to people who refer registered voters in a crucial battleground state to sign his petition supporting free speech and the right to bear arms. The petition, floated by Musk's America PAC, aims to gather 1 million signatures from swing state voters in support of the First and Second Amendments of the US Constitution. The PAC was formed with backing from Musk and other tech entrepreneurs specifically to support Trump's campaign.Musk tweeted, "If you're a registered Pennsylvania voter, you & whoever referred you will now get \$100 for signing our petition in support of free speech & right to bear arms. Earn money for supporting something you already believe

in! Offer valid until midnight on Monday."The offer marks a substantial increase from an earlier promise of \$47 to voters who referred others to sign the petition. If recruiters manage to gather 1 million signatures from swing-state voters, the Tesla boss would face a \$100 million payout. To curb potential fraud, the Tesla and SpaceX boss said that cheques will only be mailed to addresses listed in state voter rolls. The legality of pay-per-signature compensation varies by state, and while some states permit it, critics warn that it could lead to fraud. America PAC, based in Texas, operates in a state without specific regulations on this practice.



Pennsylvania is a key battleground in the election, with both Kamala Harris and Donald Trump focusing considerable resources on the state, according to an NBC News report. Recent data shows that one in four dollars spent on presidential campaign ads from September 1 to 20 was targeted at Pennsylvania. In the Electoral College, Pennsylvania holds the most electoral votes among swing states, making it pivotal to both candidates' paths to the White House. Recent opinion polls indicate the race in Pennsylvania is tight, with a Quinnipiac University survey showing Harris leading by 3 percentage points, and a Wall

Street Journal survey showing Trump leading by 1 point.

#### NID deadlock: Director leaves for Delhi

Ahmedabad. Ashok Mondal, the newly appointed director of the National Institute of Design (NID), left for a visit to Delhi on Thursday. This was his first trip after assuming charge on Friday. The visit is considered significant due to the ongoing protest by the students at the premier design institute against Mondal's decision to reshuffle several faculty members and discipline leads soon after assuming charge.

Sources close to the development said that the visit is seen in light of the protests, as the ministry of commerce and industry, which oversees the administration of NID, might have taken note of the dissent. The student body had approached the ministry officials, according to sources.

Meanwhile, yet another meeting with the director by the student body late on Wednesday failed to yield conclusive results. Sources said the students remained firm in their demand for clarity on the changes in various design disciplines and to resolve the matter in a timely manner.

The director only assured them that the faculty members are being utilised differently and not relocated. Among the issues discussed was also the order transferring NID's immediate past director, Praveen Nahar, to the Bengaluru campus. When the students asked the director about the responsibilities of the previous leads of different disciplines, he told them that he was working on the details and would issue an official order soon," said sources.

On Monday, the students, dressed in black attire, began their demonstration in front of the director's office. Discussions took place between the director and student representatives on Monday, Tuesday and Wednesday to arrive at an amicable solution to the situation. The students argued that the sweeping changes made in the middle of the semester could affect their studies.

#### Woman made to undress during 'digital arrest', extorted of Rs 5 lakh in Ahmedabad

AHMEDABAD. A woman from Naranpura, aged 27, lodged a police complaint stating that unknown individuals, posing as officers from central agencies, extorted Rs 5 lakh from her by threatening her with legal action under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

The cybercriminals also allegedly forced the woman to undress in front of a webcam during her 'digital arrest'.

According to the FIR filed with Naranpura police, the victim, Hemali Pandya, who resides in Samarpan Tower on the 132 Feet Ring Road, received a call on Oct 13 from a man claiming to be a courier firm employee.

He informed her that a parcel containing three laptops, two cell phones, 150 grams of mephedrone and 1.5 kg of clothes was sent to Thailand using her name. The caller instructed Pandya to contact cybercrime immediately. Soon after disconnecting the call to reach out to the cybercrime helpline, Pandya received a WhatsApp call from someone claiming to be an officer from Delhi

The officer informed Pandya that her name cropped up during a probe in a narcotics case and asked her to join a video conference. She then received messages containing allegedly forged letters from Delhi Cybercrime and the CBI naming her as a suspect in a narcotics smuggling and money laundering case.A frightened Pandya joined the video call, where a man posing as a CBI officer, without showing his face, allegedly coerced her into disrobing to reveal all her birthmarks.

#### CGST scam: ED files case under PMLA

Ahmedabad. Teams from the Enforcement Directorate (ED) on Thursday launched a widespread search operation in Gujarat after filing a case under the Prevention of Money Laundering Act (PMLA) in a multi-crore CGST scam unearthed recently. The teams searched 23 premises, including commercial

and residential properties, on Thursday. ED sources said that around 100 officials conducted searches at 23 locations in Ahmedabad, Surat, Rajkot, Junagadh, Gir Somnath and Bhavnagar districts.

The action comes days after Mahesh Langa, a senior journalist from a national English daily, was arrested along with seven others in connection with the case. A note by the ED stated that the investigation so far indicated that PAN, mobile numbers and email IDs related to 34 GST registration numbers were used to create another 186 registrations, including 50 in Gujarat. Sources said that the primary and additional registrations were later cancelled."It appears that an organised web of fake and shell entities is being operated by the accused persons, involving more than 200 such firms, thus passing on the fraudulent input tax credit (ITC) to the tune of crores of rupees to ineligible firms," stated the ED note. Details are yet to emerge as officials said that it will take time to assess the valuables and documents, including both paper and digital evidence, they added. The ED is also looking at the roles of other entities in this GST evasion case as it probes the allegations of "a wider conspiracy and generation of purported proceeds of crime",

Some parts that were inundated on Wednesday, including Mullai Nagar in Vyasarpadi, parts of Pulianthope and Pattalam, were cleared, barring a few streets like Kanakaraya Thottam and Ansari street in Pattalam where water mixed with sludge, say residents. A part of Valluvar Kottam high road was still waterlogged, along with a few roads in Velachery's Dhandeeswaram.

Work orders have been issued for urgent storm water drain repair work in areas like Aziz Mulk street and Peters road. The corporation has deployed 1,233 motor pumps across the city and is handling 7,470 complaints that it has received through its helpline numbers from Wednesday to Thursday.

Rainwater harvesting

The corporation has also proposed to set up

revamped rain water harvesting structures in 770 locations, mostly in parks and Chennai: Minister T M Anbarasan on playgrounds, at an outlay of Rs 8.4 crore. As per plan, 320 structures will be set up in the south region, 200 in the central region and 250 in north region.

"We did have rain water harvesting structures in some parks but these are

#### Explain non-disclosure of forest guard exam marks: HC to GSSSB

Ahmedabad. The Gujarat high court has sought an explanation from the Gujarat Subordinate Services Selection Board (GSSSB) for not disclosing the marks of the candidates on the merit list prepared for the recruitment of forest guards. The HC issued notices to the state govt, GSSSB and Tata Consultancy Services Ltd after 108 candidates, who participated in the recruitment process, challenged the selection process. Over 7 lakh candidates applied for the test conducted for the recruitment of 813 positions of forest guard.

After the merit list was declared, the unsuccessful candidates approached the HC through advocates Vikram Thakor and Bhushan Oza, raising questions about the propriety of the recruitment process.

They objected to the board's last-minute decision to change the mode of examination from OMR to computer-based recruitment test (CBRT). They also pointed out that the board did not mention the marks obtained by the candidates who were selected.

After hearing the submissions, Justice Nirzar Desai stated that non-disclosure of the marks obtained by the candidates who qualified would raise questions regarding the transparency of the recruitment process. The court sought an explanation in this regard, stating: "The respondents are directed to file an affidavit, justifying their action of not disclosing the marks of each of the qualified candidates against their names, while preparing the selection list by way of CBRT. Further, considering the fact that non-disclosure of the marks, against the name of each qualified candidate, has given rise to the speculations that the exam was not conducted properly, it shall be further clarified that as to whether the non-disclosure of marks against the name of each qualified candidate was done under any policy decision taken by the authorities.

#### 'Project Anantha' to boost development of Thiruvananthapuram airport

The highlight of the project is a new terminal of international standards with a touch of local heritage.

THIRUVANANTHAPURAM. The Thiruvananthapuram International Airport is set for a makeover with 'Project Anantha', a development project mooted at the recently concluded TRV Growth Conclave. The project was presented at the event attended by political leaders, bureaucrats, travel, tourism and trade representatives and airport

The highlight of the project is a new terminal of international standards with a touch of local heritage. The airport will see an investment of rs 1,300 crore over the next three years as part of the project. Its Terminal 2 will be expanded to cater to the growing demands of passengers.

The present 45,000 sq.m terminal can handle only 3.2 million passengers per annum. Under the expansion plan, the capacity will be expanded to 165,000 square metres to handle almost 12 million passengers each year, with a multi-level curb integrated terminal.

The terminal will also have a forecourt with a plaza, a hotel, and a commercial and administration block all under one roof. The airport handles 118 air traffic movements per day. As the connectivity improves the present capacity of the airport is unable to meet the demand. The 93-year-old airport is at a crucial point, trying to overcome longstanding legacy issues.

According to the DGCA, TRV, a code E airport, should operate on 1,200 acres. But the airport currently functions on just 585 acres, about one-third the size of CIAL.

#### BEE unveils new guidelines to 3,500 to Rs 4,500 per sq ft. This is achieve climate goals faster

The accreditation procedure sets standards for accredited carbon verification agencies (ACVs), which will audit emission reduction claims, ensuring the accuracy and fairness of the carbon credit system.

#### AI & other lessons from the Nobels

ONE technology that is linked to both the physics and chemistry Nobel prizes this year is artificial intelligence (AI). The physics laureates — John Hopfield and Geoffrey Hinton — applied principles and tools of physics to develop methods that have facilitated machine learning. Hopfield used the principle of atomic spin to create a structure that can store and reconstruct information, while Hinton invented a method that can independently discover properties in data forming the basis for the large artificial neural networks now in use. These discoveries, over the decades, have helped powerful computers mimic human functions like memory and learning. The chemistry Nobel has gone to David Baker of the University of Washington; Demis Hassabis and John M Jumper of Google DeepMind. Baker has been awarded for his work on computational protein design and the DeepMind researchers get the other half of the prize for developments in protein structure prediction. Proteins are essential for cellular functions in living bodies. They are intricately folded, depending on their atomic structure and water molecules surrounding them. In a single protein, there could be trillions of potential interactions, creating countless possible shapes. Baker developed computational tools for designing new proteins, which, in turn, has opened the door for new therapies and treatments. The Google DeepMind researchers have developed an AI system called AlphaFold that predicts the three-dimensional structure of proteins from their amino acid sequences.

The physics, chemistry and medicine Nobel prizes again demonstrate that fundamental research is vital for knowledge creation and there is no substitute for basic research. This point has to be re-emphasised in the Indian context because every time, we bemoan that no Indian has got a Nobel for scientific research done in India after CV Raman. Hargobind Khorana, S Chandrasekhar and Venki Ramakrishnan won their Nobels for research conducted in foreign universities. Along with applied research and technology development, sustained investments are needed in fundamental research for breakthroughs. The Nobel is usually given for pathbreaking work that leads to transformative tools and technologies. Hopfield, who is 91, began working on what came to be known as the 'Hopfield network' and associative memory in the 1980s. So did Hinton, with his 'Boltzmann machine' method. Their methods enabled the machine learning revolution decades later, in 2010. And finally, we have consumer products like ChatGPT. Similarly, chemistry laureate Baker has been working on protein structures for decades. He came up with the first tool for protein structure prediction, Rosetta, in 1998. The edifice of AI is based on many building blocks created over the decades. Not many know that Indian scientists have also contributed to this process. At a time when AI was just emerging as a possibility and engaging the attention of scientists along with the development of digital computers in the 1950s, physicist-turned-statistician Prasanta Chandra Mahalanobis developed a concept which came to be known as the Mahalanobis Distance. It helps detect outliers in data and measure dissimilarities in data points. Subsequently, Mahalanobis Distance found wide applications in computer science and AI. At the Indian Statistical Institute (ISI) founded by him, Mahalanobis recognised the importance of cybernetics and invited its pioneer Norbert Wiener to spend time in the institute as a visiting professor in 1955. Wiener initiated ISI researchers like Dwijesh Datta Majumder to work in pattern recognition, fuzzy logic and neural networks.In 1966, Raj Reddy, a young Indian doctoral student in America, pioneered the development of systems for recognising continuous speech. He developed a new system called Hearsay I for continuous speech recognition. Along with giving computers the capability to memorise and learn like humans, making them capable of recognising human speech was a critical step towards achieving AI. Reddy later developed Hearsay II, Harpy and Dragon systems, which are the basis of commercial speech recognition technology used in computers as well as robots.

## Diplomacy, restraint and respect, Israel's need of the hour

The Foreign Minister of Israel overstepped the limits of his office when he declared the UN Secretary-General as persona non grata.

A simple, matter-of-fact statement issued by United Nations Secretary-General (UNSG) Antonio Guterres on October 1, caused an unprecedented diplomatic storm. "I condemn the broadening of the Middle East conflict, with escalation after escalation. This must stop. We absolutely need a ceasefire," the Secretary-General said in his statement. Another statement, issued on the same day on Lebanon by the Secretary-General's spokesperson Stéphane Dujarric, reflected a similar

concern. The statement read, "The Secretary-General is extremely concerned with the escalation of the conflict in Lebanon. He appeals for an immediate ceasefire. An all-out war must be avoided in Lebanon at all costs."Though Guterres' statement did not mention any country per se, use of the jargon "escalation after escalation" and "broadening of the Middle East conflict" touched a raw nerve causing alarm in Israel, and drew a swift reaction from its combative Foreign Minister Israel Katz. The Foreign Minister overstepped the limits of his office to declare the UN Secretary-General as persona non grata. The term is normally used to expel a diplomat

whenever his/her presence in the country of his/her posting becomes 'undesirable'. To equate as such the Secretary-General of the United Nations, of which Israel has been a 'difficult' member since the beginning, is beyond all canons of law of international organisation and the corpus of immunities and privileges of the diplomatic personnel. More importantly, the 'declaration' by Katz about the UN Secretary-Genral does not apply to international organisations. The UN and its staff are governed by a special Convention on the Privileges and Immunities of the United Nations. Called the "General Convention", it was negotiated and adopted immediately after establishment of the UN. As provided for in Article 105 of the UN Charter, the Convention was adopted by the UN General Assembly (UNGA) at its first session on February 13, 1946, (Resolution 22 A (I)), and it entered into force on September 17, 1946. The General Convention specifies the notion of "functional" personality and immunity of the UN. It contains detailed provisions on the privileges and immunities enjoyed by UN officials.

The overboard Israeli reaction was unwarranted. It is a

classic example of 'shooting the messenger' who has often been troubled by the habitual and wilful defiance of international law in the Middle East by various state actors (Israel, Iran, etc.) and non-state actors (Hamas, Hezbollah, Houthi, etc.). The UN Secretary-General has sought to act within the remit of mandate of his office. However, the tone, tenor and phraseology of the Israeli minister's declaration was not unexpected, especially in the aftermath of Prime Minister Netanyahu's defiant address to the



UN General Assembly on September 27. In diplomatic parlance, any such statement prohibiting entry of the UN Secretary-General is tantamount to coercive action against the Chief Administrative Officer (Article 97) of the 193-member political organisation of sovereign states. This kind of outburst, however, is not new in the UN history. Several other member countries, some overtly and others covertly, have sought to dissuade the Secretary-General from visiting their country. Yet, the sheer weight of the office of the UN Secretary-General is beyond insults. All Secretary-Generals, who take their task seriously, had to face this professional hazard from ill-tempered heads of government or their representatives. The UN history is replete with such stories. To control the damage, after a discussion on the Middle East situation on October 3, the 15-member UN Security Council issued a joint statement that indirectly chided Israel. Expressing its full support to the Secretary-General, the Council said, "Any decision not to engage with the UN Secretary-General or the United Nations is counterproductive, especially in the context of escalating tensions in the Middle East."

The founders of the UN Charter envisaged the role of

the 'secretariat' (Chapter XV; Articles 97-101) as a fulcrum around which the entire edifice of the organisation would revolve. During his seven years as the head of the Secretariat, Guterres has been a trailblazer and sought to walk-the-talk as liaison officer for all principal organs of the UN. Invoking a series of instrumentalities of annual reports, special reports, periodic updates, briefings, statements and as the most visible face of the UN, the Secretary-General (along with his team) has been fire-fighting

all the time on literally any issue 'under the

The regular updates provided personally by the Secretary-General to the Council have become a stuff of legends. When Antonio Guterres walks into the hallowed chamber of the Security Council (or for that matter, the General Assembly), he brings along his lifetime experience as a statesman, including as the Prime Minister of Portugal, with him. The crisp statements, laden with facts, figures and relevant data as well as authentic updates from the ground speak for themselves. We have not seen in recent decades a Secretary-General speaking with such authenticity, sincerity and candour.

Guterres, especially during his second term, has shown that where is a will there is a way. He has drawn power, whenever required, as mentioned in the Charter. Invoking his 'implied powers', Guterres took an unprecedented step on December 6, 2023, by sending a letter to the President of the UN Security Council. This letter invoked Article 99 (Chapter XV) of the Charter. This rarely used provision can be construed as a repository of an extraordinary power conferred upon the Secretary-General since he can "bring to the attention of the Security Council any matter which in his opinion may threaten the maintenance of international peace and security". The Secretary-General's 2023 letter was propelled by the "appalling human suffering, physical destruction and collective trauma across Israel and the Occupied Palestinian Territory."

All UN member countries need to exercise restraint and sobriety in consonance with highest standards of diplomatic etiquettes so as not to shoot the messenger but to pay heed to his words of wisdom and empathy that underscore that there is no substitute for peace.

#### Wayanad marks a new chapter for Congress

PRIYANKA Gandhi Vadra's candidacy from Wayanad marks a significant development for the Congress party. Entering the electoral fray five years after her active political engagement began, Priyanka's nomination to contest the bypoll on November 13 is a step toward consolidating the Gandhi family's influence within Parliament.

Priyanka's journey in the Congress has evolved from behind-the-scenes support to frontline leadership, showcasing her strategic acumen and ability to connect with the masses. She initially focused on strengthening the party's organisational base, especially in regions where it had weakened, such as Uttar Pradesh. Her successful campaigns in Himachal Pradesh and role in the 2024 Lok Sabha elections, where the Congress improved its seat tally, have cemented her reputation as a key figure. Her Wayanad campaign leverages this approach, focusing on regional issues while presenting her as a familiar Gandhi figure. Posters declaring her as "Wayanadinte Priyankari" (Wayanad's beloved)



reflect growing local support. She has promised to continue Rahul's work in the constituency. Though the Congress adopted a "one-family-one-ticket" rule at its Udaipur Chintan Shivir in 2022, Priyanka's candidacy underscores the rule's flexibility for seasoned family members who meet the five-year party commitment criterion. This exception, also applied to Rahul, reflects the Congress's continued reliance on the Gandhis' influence.

The bypoll is significant beyond Wayanad as it tests the Congress's new direction with Privanka at the helm. If she wins, her role could shift from family figure to influential political leader, strengthening the Congress's position to contest BJP policies. Her opponents in Wayanad include the BJP, which is aiming to expand its base in Kerala, and the CPI(M), which has a deep-rooted base in the Left-leaning state. Privanka is poised to navigate these ideological challenges in her bid to redefine her role in politics and come out of the coat-tails of Rahul and

Just when one thought that the spat with Canada's In the present crisis, Australia has issued a Prime Minister Trudeau couldn't get any dirtier, it did. Not only did his officials threaten sanctions on India, but also went wailing to the 'Five Eyes' partners — an intelligence grouping that includes Australia, the UK, the US and New Zealand — about the alleged actions of the Indian government and its diplomatic corps. Trudeau, battling the insecurities of a minority government and facing predictions from state intelligence about a public revolt over a dire economic situation, seems to be hitting out in all directions. India has now become a target, after he had dodged accusations about China's meddling in the 2022 elections. A recent report by the Royal Canadian Mounted Police on 'Foreign Interference' in Canada, while noting 'increased' Indian activity, also mentions China 33 times. But while Trudeau's Foreign Minister Melanie Joly has threatened sanctions on India, no such threat has been heard against China. That's unsurprising. Exports to China were about \$30 billion while imports were \$89 billion on a rising curve. With India, it's just about \$8.4 billion. Money talks.

Incidentally, the heavily redacted report also accuses another five or more states. Clearly countries vitally important to Canada. Trouble dealt with, and then go on with the matter in hand, which is a rising China, now heavily involved in cyber espionage into Australian business and government circles. The UK Government, while backing the Canadian judicial system, has also been circumspect. This is as mischievous as it gets. First, officials never quote sensitive meetings. Second, the spin on what the NSA said. It is all very unbelievable and would not have been cleared for publication without some



checking with US sources in the government.

But the State Department seems to have other ideas. While its spokesperson Mathew Miller reiterated the 'serious allegations', he underlined that the arrival of an Indian team, led reportedly by the Deputy National Security Adviser from India on the case on Gurpatwant Singh Panun, was entirely 'coincidental' and had nothing to do with the Canadian charges

In another move, the tweet that had announced the arrival of an Indian team was quietly deleted. It also appears that the R&AW officer, who initiated a reckless and mysteriously unprofessional operation to hit Pannun, has been arrested.

It also accuses Indian intelligence of killing a known criminal, Sukhdool Singh Gill, an alleged ally of the Bambiha gang. That murder was claimed by Bishnoi, and his group's feud with the Bambiha group had been going on for years, with killings in both countries. Canada's inter-gang rivalry includes not just Sikh groups but also Mexico-based cartels, among others. Strangely, Gill's killing occurred a day after India's National Investigation Agency marked him as a wanted terrorist.

## Top court closes Isha Foundation case: Proceedings can't be to malign institutions

While closing the matter, Chief **Justice DY** Chandrachud pulled up the Madras High Court over its orders for a police inquiry, and said proceedings cannot be used to malign people and institutions.

New Delhi.The Supreme Court on Friday closed proceedings in an illegal confinement against Sadhguru Jaggi Vasudev's Isha Foundation following statements from two women who said they are voluntarily residing at the organisation's ashram without coercion. While closing the matter, the bench headed by Chief Justice DY Chandrachud pulled up the Madras High Court over its orders for a police investigation on a habeas corpus (produce the body) plea.

"These proceedings cannot be to malign people and malign institutions," the Chief Justice remarked during the hearing. The habeas corpus plea, originally filed by the parents of the two women aged 39 and 42. alleged that they were being held against their will at the Isha Foundation's ashram in Coimbatore. The Madras High Court called for a police inquiry and questioned the women, which led to the current Supreme Court review. Despite their statements



affirming they were free to leave, the case lingered in the courts.

The Tamil Nadu Police also raised broader concerns about the Isha Foundation. In a counter-petition, the police highlighted missing persons cases linked to the foundation. According to Coimbatore Superintendent of Police K Karthikeyan, six missing persons cases have been registered at the Alandurai Police Station over the past 15 years, with five cases closed and one still

under investigation.During the hearing on Friday, senior advocate Mukul Rohatgi, representing Isha Foundation, informed the top court that the women had voluntarily joined the ashram when they were 24 and 27 years old and that the claims of illegal confinement were unfounded."The women even participated in public events, like a 10 km marathon, and are in regular contact with their parents," Rohatgi said.

After a virtual interaction with the two women, Chief Justice Chandrachud said the court had spoken to both women and recorded their statements. He stated that the case should have been dropped after both women testified that they were living at the ashram of their own free will."We have spoken to both individuals, who have clearly expressed their voluntary stay at the Isha Foundation. Once that is established, no further direction is needed in this habeas

#### Central agencies to rope in VPN providers in probe into bomb threats to flights

Central agencies will rope in VPN service providers to trace the origins of the bomb threats that were received by around 20 Indian flights this week.

New Delhi. Central agencies in India are set to approach VPN service providers in an effort to trace the origins of recent bomb hoax calls targeting Indian flights. Sources from the Civil Aviation Ministry revealed that many of these threatening calls have utilised virtual private networks (VPNs), complicating the tracking process. The agencies have expressed concern over the increasing frequency of these hoax threats, which have reportedly been linked to IP addresses located in countries such as London and Germany.

This trend has prompted authorities to seek cooperation from VPN providers to help identify the original source of the calls.

This comes after 20 flights of Indian carriers both domestic and international - received bomb threats this week. On Monday, three international flights were threatened, followed by 10 more on Tuesday, and at least six additional threats were reported the following day. All threats were later declared false after thorough security checks.In the wake of multiple bomb threats to Indian flights, authorities have identified a suspect linked to an X handle, 'schizobomber777'. The handle was created just days ago and has since been suspended after posting seven hoax messages that triggered significant air security alerts. The suspect allegedly used VPN services to obscure their location, with IP addresses traced back to London and Germany. This routing made it challenging for investigators to pinpoint the exact origin of the threats, as the IP addresses "bounced off" various countries. Multiple agencies, including the Indian Cyber Crime Coordination Centre (I4C) and the Indian Computer Emergency Response Team (CERT-In), are collaborating to identify the individual behind the X handle. They are also exploring connections to other recent hoax bomb threats that have targeted flights.

#### NEW LEGISLATION TO PENALISE HOAX CALLERS SOON?

The government is reportedly working on new legislation to deter people from making hoax calls and penalise those found guilty. Concerned over an alarming rise in the number of bomb hoaxes, the government is discussing multiple solutions, including adding the accused to a 'no-



On Thursday night, the moon was just 351,519 kilometres away from Earth, appearing about 14% larger and 30% brighter than usual. Several social media users took to X to post pictures of the supermoon as it dazzled the night sky.

## Personal laws can't prevail over Child Marriage Act: Court issues guidelines

The Supreme Court said marriages involving children violate the free will to have a life partner of choice. The top court was hearing a petition that alleged a rise in child marriages in the country.

New Delhi.The Supreme Court on Friday held that personal laws and traditions cannot prevail over the Prohibition of Child Marriage Act and issued a host of

guidelines to achieve the "whole purpose" of the legislation.

The Supreme Court bench, led by Chief Justice of India DY Chandrachud, said marriages involving children violate the free will to have a life partner of choice. The Supreme Court

was hearing a petition that alleged a rise in child marriages in the country and nonimplementation of the law in "letter and spirit". Calling for communitypreventive strategies should be tailored to different communities. "The law will only succeed when there is multi-sectoral coordination.



Training and capacity building of law enforcement officers needs to be there," the CJI said.

The top court said authorities must focus on child marriage prevention and

offenders as a last resort. However, the court pointed out that there were certain gaps in the Prohibition of Child Marriage Act.

The CJI noted that the law said nothing about the validity of such marriages.

"Legal questions are kept open to be decided by the constitutional court. Interlinking of personal laws with the Prohibition of Child Marriage Act is a point to be looked at," the court said.

A bill to amend the law to give overriding effect over personal laws is pending before a parliamentary committee. The Prohibition of

Child Marriage Act came into force in 2006 to prevent child marriage and ensure the eradication of the practice. The Act replaced the Child Marriage

#### Did not run away, will return to India: Byju Raveendran amid insolvency crisis

New Delhi Byju Raveendran, the founder of troubled edtech giant Byju's addressed misconceptions surrounding his move to Dubai and reaffirmed his commitment to reviving the company, which has been facing severe financial and legal challenges.

Speaking during his first virtual press conference in four years, Raveendran refuted rumours that he had fled India to avoid the ongoing insolvency crisis.

'It's very unfortunate that people think that I ran to Dubai because I had to. I came to Dubai for a year for my father's treatment, which led to our ongoing stay. But let me be clear, I did not run away," said Raveendran said as quoted by Moneycontrol in its report.In the candid discussion, he spoke about his plans to restore Byju's to its former glory, which once stood as a leader in the edtech industry."I'll come to India, and I'll fill stadiums... The timing has not been decided, but it will be soon," he said.

Raveendran expressed optimism, even in the face of the company's current troubles. "I only need to se a 1% chance to make it work. I'm not worried about what order will come. Whatever comes, I'll find a way out," he added."If they are willing to work with me, I am willing to give them money back before I take a single rupee out. We paid \$140 million but they wanted the entire \$1.2 billion which we had already committed or invested by then. There is no way we could have given them back for a long time. Most lenders wanted to settle but one or two wanted to make a killing out of it," said

Raveendran as quoted by PTI.

Once valued at \$22 billion in 2022, Byju's has seen its fortunes take a sharp downturn due to mounting debts and legal disputes. The company is currently embroiled in a significant financial struggle with creditors over \$1 billion in unpaid loans, leading to insolvency proceedings in both India and the United States

In June 2024, insolvency proceedings against Byju's were initiated after the Board of Control for Cricket in India (BCCI) alleged that the company had defaulted on a Rs 158.9 crore payment related to a sponsorship deal. USbased financial creditor Glas Trust also objected to a settlement between Byju's and the BCCI, claiming that funds had been misappropriated.

#### Sensex, Nifty decline in early trade; Manappuram Finance tanks 15%

**New Delhi** Benchmark stock indices dipped in early Friday trade, pressured by a decline in IT stocks after bellwether Infosys reported disappointing Q2 results.

The S&P BSE Sensex was down 400.17 points to 80,606.44 at 10:12 am, while the NSE Nifty50 declined 96.85 points to trade at 24,653.All the other broader market indices were also trading in negative territory as volatility dampened the mood on Dalal Street. IT stocks were the biggest losers after Infosys' weak forecast. The top five gainers on the Nifty50 were Axis Bank, Wipro, Eicher Motors, Tata Motors and HDFC Life. On the other hand, the top losers were Infosys, Tech Mahindra, ITC, BPCL and Nestle India.

Meanwhile, shares of Manappuram Finance tanked 15% after Reserve Bank of India (RBI) action against its subsidiary Asirvad Micro Finance. The RBI has asked it to stop sanctions and disbursals of loans.Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, "The 6% correction in Nifty from the peak has made India an under-performer with only 13.83% return YTD in contrast to the 23.16% return in S&P 500 YTD. The Hang Seng index with 23.16% return YTD has been the best performing market in recent weeks assisted by massive buying by FIIs."

"The high valuations in India has been the main trigger for the sustained selling by FIIs, and recent developments like consensus downward revision of FY25 earnings estimates to below 10% and Bajaj Auto's concerns regarding weak demand during the festive season dampened the sentiments resulting in big selling in auto stocks," he added. "Trends indicate that FII selling and DII buying is likely to continue. A bounce back is likely in the next two or three days but it is unlikely to sustain since sentiments have turned weak," Vijayakumar

#### RBI bars Asirvad Micro Finance, Navi Finance, two other NBFCs

MUMBAI. Within a fortnight off issuing a stern warning and asking to them to behave, the RBI on Thursday took stringent regulatory action against four non-bank lenders and a micro finance player, citing material, supervisory breaches, and has asked them to cease and desist from sanctioning and disbursing loans effective October 21. The lenders are the Chennai-based micro lender Asirvad Micro Finance, Kolkata- based micro lender Arohan Financial Services, and Delhi-based non-bank lender DMI Finance, and the Bengaluru-



headquartered non-bank lender Navi Finserv, the central bank said in a notification Thursday.

Announcing the monetary policy on October 9, governor Shaktikanta Das had asked NBFCs to follow the 'compliance first' culture and also to behave. The RBI has been repeatedly flagging NBFC, MFIs and gold loan players in the past and has brought more or less complete parity in their regulations on par with commercial banks. Das warned them on October 9 when he had asked them to follow a 'compliance first culture' and has advised them to "self correct," else warning that the heavy hand of the regulator will be

## RBI takes action against Navi Finserv, 3 other NBFCs: What it means for customers

New Delhi The Reserve Bank of India (RBI) has taken strict regulatory action (RBI) has taken strict regulatory action against four Non-Banking Financial Companies (NBFCs), halting their loan sanctioning and disbursal activities starting from October 21, 2024. The RBI said it has taken this step in accordance with Section 45L(1)(b) of the Reserve Bank of India Act, 1934, and targets NBFCs like Asirvad Micro Finance Limited Archan Financial Services Limited, Arohan Financial Services Limited, DMI Finance Private Limited, and Navi Finserv Limited. The directive comes in response to concerns over their loan pricing policies and other regulatory violations, sparking questions about the implications for customers.

WHY DID RBI TAKE REGULATORY **ACTION?** 

The central bank flagged several issues in the pricing policies of these NBFCs, specifically related to their Weighted Average Lending Rate (WALR) and Interest Spread over the cost of funds.

According to the RBI, these institutions were charging excessive interest rates, going beyond the regulatory limits. This non-compliance was seen as a violation of the RBI's Master Directions for Microfinance Loans, updated in July 2022, and the Non-Banking Financial Company-Scale Based Regulation guidelines, revised in March 2024.

Over the last few months, the Reserve Bank has been sensitising its Regulated Entities through various channels on the need to use their regulatory freedom responsibly and ensure fair, reasonable and transparent pricing, especially for small value loans. However, unfair

and usurious practices continued to be seen during the course of onsite examinations as well as from the data collected and analysed offsite," RBI said. Additionally, these companies failed to properly assess the household incomes of their borrowers or factor in their current or future repayment capacities. As a result, many microfinance loans were being sanctioned without adequate evaluation, risking both the financial health of borrowers and the long-term



sustainability of the lending companies. IMPACT ON NBFCS and THEIR

For Asirvad Micro Finance, Arohan Financial Services, DMI Finance, and Navi Finsery, the RBI's move is a big setback. The NBFCs must now focus on compliance, reviewing their pricing structures, and ensuring that all loans are sanctioned in accordance with proper household income assessments and repayment ability evaluations. Until these

reviewed, the companies won't be allowed to resume loan disbursals.

However, it is important to note that this restriction doesn't prevent these firms from servicing their existing customers. Loan collection and recovery processes are still allowed, provided they comply with the current regulatory framework. The RBI has assured that it will lift the restrictions once these companies demonstrate compliance with guidelines, particularly in areas such as risk management, customer service, and fair pricing policies.

## WHAT DOES IT MEAN FOR EXISTING AND NEW CUSTOMERS?

For current borrowers of these NBFCs, the impact is minimal in the short term. Customers will still be able to continue their repayment schedules, and existing loans will not be affected. However, the halt in new loan disbursals could affect future borrowers, especially those reliant on microfinance loans from these

## **Explained: Why Infosys shares** fell 5% after Q2 results

NEW DELHI. Shares of Infosys saw a sharp drop of 5% on Friday, following the release of its Q2 FY25 results. The stock price fell to Rs 1,869 as investors reacted to lower-than-expected financial performance and revenue guidance. Although Infosys raised its FY25 revenue growth guidance to 3.74%-4.5%, up from the previous estimate of 3%-4%, analysts mentioned that this fell short of market expectations. Domestic brokerage Motilal Oswal pointed out that while there was broad-based revenue growth, Infosys' cautious outlook on discretionary spending caused disappointment. The company highlighted ongoing challenges, particularly outside the US banking sector, with limited recovery in discretionary expenditures. Infosys also postponed wage hikes for the fourth quarter of FY25 and the first quarter of FY26, signalling uncertainties in the near term. Motilal Oswal said, "The guidance was



upgraded by just 50 basis points at the top end, despite a strong 3.5% compound quarterly growth rate (CQGR) in the first half of the year. This suggests a muted CQGR of approximately 0.5% for the second half of FY25. This indicates that while client pessimism may be stabilising, a significant rebound in discretionary spending is yet to materialise."There was some optimism, however, regarding the company's performance in smaller deals, those worth less than USD 50 million in total contract value. While Infosys refrained from calling

this a trend, Motilal Oswal believes it could signal early signs of business flow returning to both the company and the sector, potentially positioning it favourably for FY26.On Thursday, after the market closed, Infosys reported a profit after tax (PAT) of Rs 6,506 crore for the second quarter ending in September 2024. This represented a 5% year-on-year (YoY) increase from Rs 6,212

crore in the same period last year. However, the PAT figure was below the Street's expectations, which had forecasted Rs 6,700 crore.Revenue from operations grew by 5% YoY, reaching Rs 40,986 crore, compared to Rs 39,360 crore in the same quarter last year. In constant currency terms, revenues grew by 3.3% YoY and 3.1% quarter-on-quarter (QoQ). Infosys also declared an interim dividend of Rs 21 per equity share, with October 29, 2024, as the record date. The dividend is set to be paid on November 8, 2024.

#### Wipro shares gain 4% post Q2 results, bonus issue news. Time to buy

NEW DELHI. Shares of IT major Wipro surged by up to 4% on Friday, hitting a day's high of Rs 550.55 on the Bombay Stock Exchange (BSE). The rally came after Wipro announced its second-quarter (Q2) results for the fiscal year 2025 (FY25), posting a 21.3% year-on-year (YoY) jump in net profit to Rs 3,209 crore. Wipro's strong performance surprised the market as it secured large contracts, with the total contract value (TCV) rising 8% on a quarterly basis. However, the comments has guided for basis. However, the company has guided for revenue growth to range between -2% and 0% quarter-on-quarter (QoQ) in constant currency terms for the third quarter, citing weak seasonality due to the furloughs and the holiday season in the December quarter. Nomura expects Wipro's USD revenue to decline by 2.1% YoY in FY25, with a rebound of 5.2% YoY growth in FY26. Despite challenges, Wipro's IT EBIT margin saw a 30 basis points increase to 16.8% in Q2, supported by one month of salary hikes and ongoing optimisation efforts. Looking ahead, Nomura believes Wipro is on track to achieve its medium-term EBIT margin target of 17-17.5%, predicting an overall margin improvement of 130 basis points YoY to 16.5% in FY25. The brokerage has maintained a target price of Rs 670.On the other hand, Jefferies, which has an underperform rating and a target price of Rs 465, pointed out broad-based revenue pressures and disappointing Q3 guidance. While Wipro's management signalled potential growth in the banking, financial services, and insurance (BFSI) sector, Jefferies believes the weak guidance reflects a challenging outlook for the company.Citi has a sell rating on Wipro with a target price of Rs 500. The brokerage described the quarter as decent, with both revenues and margins slightly above expectations. However, Citi cautioned that forward-looking indicators still seem weak, including the Q3 revenue guidance, which suggests a 1% QoQ decline at the midpoint, a 4.4% YoY headcount reduction. and an 11% YoY decline in total trailing twelve months (TTM) TCV.

Domestic brokerage Motilal Oswal has increased its FY25 earnings per share (EPS) estimate for Wipro by 2%, reflecting the margin beat. However, it has kept the FY26 and FY27 EPS estimates mostly unchanged. The firm maintained a neutral rating on the stock, with a target price of Rs 500, which implies a 20x multiple on September 2026 expected EPS.

Alongside its Q2 earnings, Wipro also announced a bonus issue of shares in the ratio of 1:1. This means that shareholders holding Wipro shares in their demat accounts as of the record date will receive one additional share for every share they hold. However, the company has yet to announce

## **Explained: Why European Central Bank cut interest rates again**

New Delhi The European Central Bank (ECB) has reduced interest rates once again, marking the second consecutive cut as inflation in the eurozone cools more rapidly than expected. On Thursday, the ECB lowered its benchmark deposit rate by a quarterpoint, following a similar cut in September. This move brings the rate down to 3.25%, after peaking at 4%.

This marks the first time the ECB has implemented back-to-back rate cuts since it began its current cycle of easing in response to falling inflation rates. The latest decision came after September's inflation data was revised downward, showing consumer prices in the eurozone rose by 1.7% year on year—slightly below the original estimate of 1.8%. The ECB said the latest data confirmed that inflation is cooling as expected, with prices likely to increase in the coming months before returning to the central bank's 2% target next year. The rate-setting committee met in Slovenia as part of its regular tour outside its Frankfurt headquarters, deciding to cut rates for



the third time since the peak. The ECB had previously raised rates aggressively in response to soaring inflation driven by the COVID-19 pandemic and Russia's invasion of Ukraine. However, the recent lowerthan-expected inflation numbers have reassured policymakers that prices are stabilizing. Additionally, signs of weakness in the eurozone economy have further prompted the ECB to ease borrowing costs, providing some relief to households and businesses. "Recent surprises on the downside in

economic activity indicators have increased confidence that inflation is headed toward the 2% target," the ECB stated. Analysts, such as ING's Carsten Brzeski, believe the swift rate cuts indicate the ECB is more concerned about the eurozone's growth outlook than before. There is now even a risk that inflation could undershoot the target, he warned. Economists suggest that Thursday's cut signals the ECB's urgency to bring rates down quickly. Although the ECB is taking a cautious "data-dependent" approach, meaning it will assess economic conditions before deciding on future rate cuts, analysts expect more reductions are

Amazon AWS CEO Matt Garman defended the decision to implement a fiveday in-office work week starting in January 2024.

NEW DELHI. Amazon Web Services (AWS) CEO Matt Garman has issued a clear warning to staff who are unhappy with the company's new return-to-office policy, reported news agency Reuters. Speaking at an all-hands meeting on Thursday, Garman defended the decision to implement a five-day in-office work week starting in January 2024. He made it clear that employees who do not support the policy have the option to leave the company. Garman's comments come after some employees expressed frustration with the change, which moves away from the current three-day-a-week office requirement. He explained that while most workers support the shift,



those who feel it is not suitable for them can seek employment elsewhere.

If there are people who just don't work well in that environment and don't want to, that's okay, there are other companies around," Garman said, according to a transcript of the meeting reviewed by Reuters. He added that working in the office is important for innovation and collaboration, and the company has found it difficult to develop new products when employees are not physically present. The policy has drawn criticism

from some Amazon staff who argue that commuting is time-consuming and that the benefits of working from the office are not supported by independent studies. Many employees feel that the flexibility of remote work, which became more common during the pandemic, should continue.Amazon had previously been enforcing a three-day in-office policy. However, in August, Amazon's CEO, Andy Jassy, announced the shift to a fiveday office schedule, emphasising the importance of working together in person

to "invent, collaborate, and be connected."This hard stance has created tension within the company. Some employees who were not following the previous three-day policy were informed that they were "voluntarily resigning" and were locked out of Amazon's systems. This action has led to increased dissatisfaction among parts of the workforce, particularly those who believe that working remotely is more efficient.Amazon, which employs more than 1.5 million people globally, has taken a stricter approach to the return-tooffice mandate than many of its peers in the tech industry. Companies like Google, Meta, and Microsoft have adopted more flexible policies, typically requiring employees to be in the office two to three days a week. As the world's second-largest private employer, after Walmart, Amazon's decisions on workplace policies are closely watched. The company believes that being physically together in the office is essential for fostering creativity and collaboration, particularly as it works on new products and services.

"Unfortunately, the knee. The ball went and had surgery on. So, he has got a little bit of swelling on it. The muscles are bit tender at this point of time. It's a precautionary measure," Rohit stated during the postmatch press conference.

I want to come to your temple for worship, but let's have a zoom call first and we can have some more talks after the worship. Believe me, these talks are for your benefit. It will be a great favour if you can share your mobile number. Thank you," Ali wrote on Instagram. Her post comes on the heels of the murder of former Maharashtra minister and NCP leader Baba Siddique, a close associate of Salman Khan. The Lawrence Bishnoi gang claimed responsibility for the attack, issuing a warning to anyone associated with the actor. Consequently, Salman Khan's security was tightened. According to the police, the animosity between Lawrence Bishnoi and Salman Khan first became public in 2018 when the gangster said during a court appearance in Jodhpur, "We will kill Salman Khan. Everyone will know once we take action. I have not done anything as of now, they are accusing me of crimes for no

Since then, the popular actor has received multiple threats to his life, with the matter reaching a tipping point in April this year when gunshots were fired outside Salman's Bandra residence by two shooters reportedly belonging to the Bishnoi gang who were later arrested. The enmity stems from the infamous blackbuck poaching case involving Salman Khan which took place in 1998 during the filming of Hum Saath-Saath Hain in Rajasthan, irking the Bishnoi community which revers the animal.
