#### Bring original records of decision blocking 2023 BBC documentary on Gujrat riots: SC to Centre ST Correspondent

New Delhi, Oct 21: The Supreme Court on Monday asked the Centre to produce within three weeks the original records relating to its decision to block a 2023 two-part BBC documentary series on the 2002 Gujarat riots. A bench of Justices Sanjiv Khanna and Sanjay Kumar directed the Centre to file its response on the pleas filed by veteran journalist N Ram, Trinamool Congress MP Mahua Moitra, activist lawyer Prashant Bhushan and lawyer M L Sharma challenging the government's decision. The bench allowed the rejoinder affidavit to be filed by petitioners in two weeks there after and posted the matter for final hearing in January 2025. "This matter requires consideration. It cannot be disposed of in 10 minutes," the bench said, asking the Centre to comply with its February 2023 direction for

producing the original records of the decision Solicitor General Tushar Mehta said the government hadn't filed a response and required another two weeks for the same. Senior advocate C U Singh, appearing for the petitioners objected to Mehta's plea and said the government was aware that it had to file a reply but hadn't done it still. Singh submitted it was an executive decision and the court could proceed even without the Centre filing its reply. Justice Khanna, however, said the court needs to see the Centre's response in the matter. On February 3, 2023, the top court had directed the Central government to produce the original records relating to its decision and issued a notice on the batch of pleas. Singh then submitted the government had invoked emergency powers under the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021 to block the documentary. One of the petitioners alleged the ban on the documentary titled "India: The Modi question" was "malafide, arbitrary and unconstitutional". Ram and others, in their pleas, have sought a direction to restrain the government from curbing their right to "receive and disseminate information" on the documentary.

# Back to 2020 situation: India, China reach pact on patrolling along LAC in eastern Ladakh

New Delhi, Oct 21: India on Monday announced that the issue of patrolling along the Line of Actual Control (LAC) in eastern Ladakh had been resolved with China. A "patrolling arrangement" has been worked out and the "situation has gone back to the one in 2020" in terms of disengagement of the troops along the LAC. External Affairs Minister S Jaishankar and Foreign Secretary Vikram Misri announced the development at separate events on Monday. Speaking in New Delhi, Jaishankar said, "We have reached an agreement with China on patrolling. With this disengagement, we have gone back to the 2020 situation. We can say that the disengagement process with China has been completed." On patrolling, Jaishankar said, "There are areas, which for various reasons after 2020, (China) had blocked... We had also blocked (some



Jaishankar said, "Obviously, we had to opt for counter-deployments, but along with it, we had been negotiating since September 2020." He said, "Hopefully, we will be able to come back to peace and tranquillity with this development. We

Earlier in the day, addressing the media ahead of Prime Minister Narendra Modi's visit to Russia for the BRICS summit, Misri said, "An agreement has been reached on patrolling arrangements along the LAC in the India-China border leading to disengagement and a resolution of the issues that had risen in the areas in 2020." Misri said

Indian and Chinese diplomatic and military negotiators had remained in close contact. Answering a question, Misri said, "We have reached an agreement... and this will eventually lead to resolution of issues." The armies of the two sides are

locked in a stand-off since April 2020. There have been a few clashes, including the one at Galwan in June 2020 when the Indian Army lost 20 soldiers and China lost a unspecified number of soldiers. Though Misri did not specify which patrolling points at the LAC were part of the "arrangement", sources said the pending issues included the unhindered right of the Indian troops to patrol points 10, 11, 12 and 13. These are the routes going eastwards of the "bottleneck" - a geographical feature — on the 972-sq km Depsang plateau in eastern Ladakh. The second is the buildup at Charding La nullah (also termed Demchok nullah). The Chinese approach the Charding La — a 19,120-foot-high pass from its southern approach. The peak is on the LAC and is patrolled by the Indian Army along the nullah. The Chinese army has to use the route, which the Indian Army had been blocking.

# Maharashtra polls: MVA has reached consensus on 210 seats: Sanjay Raut

Mumbai, Oct 21: Shiv Sena (UBT) leader Sanjay Raut on Monday said the Maha Vikas

Aghadi had arrived on a consensus on 210 of the 288 Maharashtra Assembly seats, while the state's Congress chief Nana Patole claimed discussions had been completed on his party's 96 seats. Both, however, were united in claiming the Bharatiya Janata Party was spreading misinformation in the run-up to the polls, which are to be held in a single phase on November 20. The results will be declared on November 23. The Shiv Sena (UBT) and the Congress are constituents of the Maha Vikas Aghadi along with Sharad Pawar's NCP (SP). The aim

was to ensure the defeat of forces looting Maharashtra, Raut said in a swipe at the ruling alliance comprising Chief Minister Eknath Shinde's Shiv Sena, the BJP and Ajit Pawar-led NCP. "We have arrived at a consensus on 210 seats. It is a significant achievement. We aim to contest polls as a joint force, and we will defeat the forces looting Maharashtra," said Raut, a Rajya Sabha MP and key strategist for the Shiv Sena (UBT).

Speaking to reporters in Delhi, Patole asserted there are no disagreements within the MVA, adding that discussions on seat-sharing were underway and would conclude soon. "So far, discussions on 96 seats for Congress have been completed. Tomorrow, further talks will be held with Nationalist Congress Party (SP) president Sharad Pawar and Shiv Sena chief Uddhav Thackeray. After these discussions,

ve will try to announce the list of candidates tomorrow itself," he said. Patole and other state leaders of the Congress are in Delhi to finalise seats and candidates for the assembly polls. Raut's comments came amid a flurry of news channel reports that the Uddhav Thackeray-led party may break away from the MVA and contest all 288 seats on its own. The past few days have seen hectic parleys among the three main opposition paries to finalise a seat-sharing deal, with speculation doing the rounds of the Congress and Shiv Sena (UBT) not being on the same page. The

statement from Raut also comes amid speculation that Union Home Minister Amit Shah had a phone conversation with him, hinting at the Shiv Sena (UBT) and BJP, which were allies for decades before going their separate ways in 2019, getting back together.

# EAM Jaishankar slams Canada for its 'double standards'

New Delhi, Oct 21: External Affairs Minister S Jaishankar on Monday hit out at Canada for its "double standards" as the ties between New Delhi and Ottawa came under severe strain over the killing of Sikh sepa-



ratist Hardeep Singh Nijjar on Canadian soil last year. "Double standards is a very mild word for it," Jaishankar said while explaining how Canada treats other diplomats and the "licence" their diplomats try to use while in India. Last week, New Delhi expelled Canadian Charge d'Affaires Stewart Wheeler and five other diplomats following Ottawa's fresh allegations of the Indian government's involvement in Nijiar's killing in British Columbia. India also recalled its high commissioner and five more diplomats, who are on their way back to India. The Canadian government had said the Indian diplomats were expelled from the country. "I think there are some very specific issues. Canada asked us to subject our high commissioner to a police inquiry and we chose to withdraw the high commissioner and diplomats," Jaishankar said at the NDTV World Summit. "They seem to have a problem if Indian diplomats are even trying to make efforts to find out what is happening in Canada on matters which directly pertain to their welfare and security. "But look what happens in India. Canadian diplomats have no problem going around collecting information on our military, police, profiling people, targeting people to be stopped in Canada," he said. "So apparently, the licence that they give themselves is totally different from the kind of restrictions that they impose on diplomats in Canada.





### News box **MUDA: ED takes away** 800 pages of papers, hard disk

MYSURU: Directorate of Enforcement (ED) officials, probing the MUDA site allotment scam, involving Chief Minister Siddaramaiah's wife Parvathi BM, concluded their two-day raid and took away 800 pages of documents and a hard disk from the Mysore Urban Development Authority (MUDA). The officers carried out searches till 2.30 am on Sunday and sought documents related to sites allotted under the 50:50 ratio. MUDA Commissioner AN Raghunandhan and other officers furnished all the correspondence related to 3 acres 18 guntas of land in Kesare owned by Parvathi and 24 sites allotted to her by MUDA in the upmarket Vijayanagar. The ED officials took both soft and hard copies and got them photocopied. The seized documents were

packed and moved under police security. During the 41-hour raid, the ED officials camped in the MUDA office with round-theclock protection from around 20 armed CRPF personnel along with local police.

Raghunandan told reporters that MUDA officials completely cooperated with ED officials during the investigation. "MUDA will resume its normal operations from Monday," he said. The Lokayuktha police, meanwhile, who are also probing the MUDA site scam, interrogated former deputy commissioner and Raichur MP Kumar Naik, who had served in Mysuru and denotified the land in Kesare.

### Three flights in Karnataka receive hoax bomb threats

BENGALURU: Two flights - one arriving at Bengaluru's Kempegowda International Airport (KIA) and one departing - received hoax threat calls on Sunday, said sources. Security checks were carried out and calls were declared a hoax. According to an informed source, one of them was an Alliance Air flight (AI 528) that departed from Vidyanagar (Jindal Vijayanagara Airport) in vidyanagar (Jindai Vijayanagara Airport) in Toranagallu."We received news around 1.15 pm from the Bengaluru airport about a bomb being placed on AI 528. The flight with 46 passengers was just about to land at KIA," the source added.Soon after it landed at Terminal 2 of KIA, dog squad and bomb squad personnel were pressed into service. "All security protocols were followed. We confirmed it as hoax. The flight had to return to Vidyanagar and it departed quite late," the source added

Airport sources in Bengaluru confirmed the incident. A top police official also said that an IndiGo flight taking off from Bengaluru to Delhi too received a hoax call. "The airline authorities assessed the impact and decided it was a non-specific call and not a serious one. They told us they preferred not to file a complaint," the police said.Meanwhile, an FIR has been registered at the KIA police station on a complaint filed by KIA Duty Manager of Akasa Air, Haribabu Bandi, on a threat the airline received through platform 'X' about explosives placed onboard a flight (QP 1373) that departed from Bagdogra airport in Siliguri and landed in Bengaluru on October 15.

# **Pineapple farmers in Kerala hit sweet spot as price spike prolongs**

#### Prices have remained robust at Rs 57-60/kg for 12-18 months due to rise in demand, especially in north Indian markets

KOCHI: Pineapple farmers are enjoying the fruit of their labour. They have not had it this good in a long time, especially in Vazhakulam, near Muvattupuzha,

considered the hub of the tropical plant's cultivation in the country. The farm gate price of pineapple,

which is grown mostly in Idukki, Pathanamthitta, Kottayam and Ernakulam districts, has been hovering around a robust Rs 57-60/kg for the last 12-18 months. This is a far cry from 2016 when prices plunged to as low as Rs 10/kg, pushing many farmers into distress. The healthy price has encouraged more and more farmers to return to pineapple cultivation by leasing large tracts of land, and in many instances getting rid of rubber trees. The area in the state under pineapple cultivation, which declined from 12,775 hectares in 2005-06 to 7,911 hectares in 2015-16, has risen to anywhere in the region of Rocketing output 22,000 and 23,000 hectares now,

reckons James George Thottumariyil, president of the All Kerala Pineapple Farmers'

Association (AKPFA). "The higher price is due to rise in demand, especially in north Indian markets such as Delhi and Mumbai. The market for pineapple has also expanded significantly over the last few years. Additionally, due to the harsh summers, people are consuming more of the fruit," James says."Luckily for farmers, there has not been any disruption in demand from north Indian markets in the last one-two years. The 2018 and 2019 floods and the Covid pandemic affected transportation of the fruit," points out Thomas Varghese, president of the Vazhakulam Merchants' Association.

On a daily average, Vazhakulam sees around 1,200 tonnes loaded onto trucks headed for the northern states. This jumps to 1,500 tonnes during the summer months.

Kerala's pineapple production soared from 1.09 lakh tonnes in 2005-06 to 5.5 lakh tonnes in 2023. In 2024, it is expected to

touch 6.5 lakh tonnes, based on AKPFA's calculation. Production had declined to 88,033 tonnes in 2019-20 when prices nosedived.

An acre can produce up to 12-14 tonnes, which translates into earnings of Rs 7-8 lakh for the farmer. "The cost of farming averages about Rs 3.5 lakh/acre. This means a profit of at least Rs 3 lakh per acre after deducting all sundry expenses. This is good,' stresses James. According to Thomas, many farmers who gave up pineapple farming after prices hit rock bottom during the pandemic - at Rs 19 to Rs 40/kg - have made a comeback, bolstered by healthy prices. "Pineapple farmers are raking in the moolah. But, I don't think this has attracted many new players. For a new entrant, planting would cost as high as Rs 4-4.5 lakh per acre as the price of seedlings has also risen in recent months," says Thomas, who has leased land to farm the fruit. Inflation boost



M C Saju, a farmer in Ernakulam district's Koothattukulam, says a major reason for the steady high prices of pineapple can be attributed to the rise in food inflation. "If you look at other fruits, they are all trading above Rs 100/kg. Pineapple is a cheap alternative," he says. 'One pineapple weighs nearly 2.5kg, and costs around Rs 135-

150," Saju explains, adding that

contract farmers are now ready to lease land for pineapple cultivation for six years, offering Rs 1 lakh a year. "They are also ready to pay five years' money in advance. This is unprecedented," Saju adds.It also helps that pineapple is not very seasonal. "Output is generally high between end-October and January. It slows down after that," says James, adding, "Most farmers eye the month of Ramadan."Farmers need to flower the plant by October-end to ensure that it bears fruit after six months," he said. "One advantage of pineapple farming is that it takes only 12 months to decide the return on the crop. This is significant, as far as farmers are concerned," he adds. "Further, the entire return is

considered agricultural income and is not taxed," points out Saju. There is also an abundant number of labourers from the northern states, such as Bengal, who are available for farm work in pineapple fields, he says.

### TN train crash: GRP finds rail switch points tampered

TN man misses interest payment, Nellai 'loanshark' beats his mother to death

TIRUNELVELI: A 61-year-old woman died after allegedly being brutally beaten by a moneylender and his relative on Saturday, as her son was unable to pay the exorbitant monthly interest on a loan of Rs 1 lakh. Both of them were arrested the same day by Tirunelveli city police, who are also searching for a third suspect. According to police, the deceased has been identified as S Savithri of CN Village, a roadside vegetable vendor near Tirunelveli Junction. Her son Kannan (35) is employed as a loadman at the Nainarkulam market."Kannan had borrowed Rs 1 lakh from one Kaliraj (42) from the same area to cover his mother's medical expenses. He had been

paying around Rs 10,000 as monthly interest. However, last month, he could not make the payment, leading to Kaliraj (42) and his relative Anandraj (42) confronting Savithri at her home," said sources. Following this, Savithri lodged a plaint with the Tirunelveli Junction police against the duo. Angered by this, Kaliraj and Anandraj allegedly attacked Kannan with a knife at Nainarkulam



admitted to the Tirunelveli Medical College Hospital (TvMCH) for treatment, sources said.

"Subsequently, on Saturday, Kaliraj and Anandraj went to Savithri's house again

and brutally beat her with an iron rod. Her neighbours rushed her to TvMCH, where she succumbed to her severe injuries," police said.

Mom claimed son was drunk, ended life Consequently, the family members conspired to kill Sivakumar, police said. "Sivakumar was unmarried and became an alcoholic following the death of his brothers. From December 2023 to July 2024 he underwent treatment at a drug rehabilitation centre in Avinashi. However, his time in the rehab seemed to have little effect on his alcoholism," police said. "As per their plan, on the night of October 17, Moorthi's friends R Jeevanandham, (22) and R Mayandi (24) drank with Sivakumar. Once he was in an inebriated state, Jeevanandham and Mayandi attacked Sivakumar and pushed him into the farm well. On October 18, Ponnuthai informed the



CHENNAI: The Government Railway Police (GRP), investigating the Mysuru-Darbhanga Bagmati Express derailment at Kavaraipettai near Gummidipundi on October 12, suspects sabotage due to external tampering of the switch points and other infrastructure. However, police stated that the investigation will explore all aspects, including technical failure due to which the green signal for the main line remained unchanged when the track was realigned for the loop route. The derailment occurred around 8.30 pm on October 12 when the Bagmati Express,

heading to Darbhanga, entered a loop line where a freight train was stationed at Kavaraipettai station. Despite having been given a green signal to continue on the main line, the track set for the loop line, leading to derailment of 12 coaches which left 20 injured. As a result, more than 50 trains were cancelled or diverted for the next two days. There were 1,800 passengers onboad the train when the incident took place.

According to police sources, the initial inquiry revealed that the signalling gears and switch point connecting rods were tampered with, and bolts and nuts were found loosened. A similar incident at Ponneri last month is also under investigation, with call detail records retrieved for both locations.A retired senior railway official told TNIE that in the case of tampering or infrastructure failure, the signal should have turned red. However, in this case, it remained green for both the loop and main lines, despite the removal of bolts and nuts.

The interlocking signalling system should not have allowed the signal to stay green when the tongue rail got detached from mainline and connected to the loop line. Given these conditions, the signal should have turned red. The signal and telecommunication department has a lot to explain."When questioned, a police officer said that the MEMU train, which passed Kavaraipettai just minutes before the Bagmati Express, may have further compromised the signal box. "The S&T department of the Railways has answered some of our questions. Our probe will also cover potential technical failure as well," the officer said. In the backdrop of this incident, the GRP has deployed round-theclock police protection for the tracks at Kavaraipettai and Wimco Nagar. The Railway Protection Force (Chennai division) has also written to Southern Railway to install surveillance cameras along the tracks between Basin Bridge and Sulurpetta.An official mentioned that except for the Korukkupet railway bridge and Ponneri railway lines, there are no CCTV cameras along the route, and they have asked for fencing along the tracks to prevent unauthorised entry.

- VISAKHAPATNAM: Deepavali is fast approaching, but for the potters of Adavivaram in Simhachalam, this year brings an unfamiliar struggle.For generations, these artisans crafted earthen diyas and festive items, but road-widening work last year claimed part of their homes, leaving many displaced.
- Unable to work as they once did, the potters were forced to purchase diyas from traders for the first time in centuries. Now, they sell what little they can from the streets outside their partially demolished houses, marking a painful shift in their time-honoured way of life."Our families have lived here for generations. This is the first time we could not make divas for Deepavali. We do not have space to store clay, produce diyas, or bake them in kilns. After last year's road work, half of our houses were torn down,' explained G Ravi, a potter from the community.
- "We haven't received any compensation, nor were we offered land elsewhere. They said they'd give us plots in residential areas, but who will allow potters there when our work involves mud and baking?" he questionedThere are around 15 families involved in pottery, either fully or partially. Some have moved to rented houses, continuing their work in their halfdemolished homes, while others remain in these unsafe structures. The number of active potters has declined due to age, a shift to other professions, and the fact that pottery no longer generates enough income to support a family.
- Although the government has provided free pottery wheels to some artisans in Narsipatnam, Parawada, and Vemulapudi, the Adavivaram potters are still waiting for theirs. Rising cost of clay, transportation, unexpected rainfall, and dwindling demand have further strained their livelihood

#### GVMC chief promises to resolve issue of potters

"Despite everything, we continue to work out of passion. We requested small sheds by the roadside to store our goods, but we were denied permission. Irrespective of incessant rain or scorching heat, we sit on the roadside and sell what we can. If nothing is done soon, our houses could collapse completely in heavy rain," Ravi added, highlighting the vulnerability they face daily.Sharing concerns for the future, another potter expressed, "Pottery is physically demanding, but the returns are meagre.

KASARAGOD: As part of Jal Shakti Abhiyan (JSA), the district administration is planning to rehabilitate water sources by reviving Surangas or tunnel wells to raise the groundwater level in Kasaragod.By incorporating Suranga restoration into the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), the district administration seeks to promote water conservation, improve livelihoods, and foster women's leadership in community development through the

"Nari Shakthi Se Jal Shakthi" campaign. District Collector Inbasekar K said, "Our primary objective is to turn the status of Kasaragod block panchayat from critical groundwater category to semi-critical and later to safe groundwater category. At present, four blocks are in the safe category, except Manjeshwar and Kasaragod. Surangas are the traditional



water source, and reviving them will help increase the groundwater level."Surangas were traditionally used by farmers, as many of the tunnels provided water during the summer. A Suranga is essentially a tunnel carved into a laterite hill that allows water to seep through and collect at the other end. Kasaragod is one of the districts in the state that faces acute water shortage in the summer.

A groundwater department officer said, We will collect the number of surangas in Kasaragod with the help of Kudumbashree and renovate them through MGNREGS. We are planning to execute the project as part of JSA. In the initial phase, we plan to conduct a survey to determine the number of Surangas in the district. Kasaragod is divided into six blocks, of which Kasaragod block is considered a critical block as the majority of the recharged water is used and Manjeshwar block is considered a semicritical block."The 2023 Central Groundwater Department report shows a decline in the district's groundwater development from 79.64% in 2017 and 76.40% in 2020 to the current level of 72.75%, which is classified as semicritical.

### News box DTCP asks 11 markets to remove encroachments in a week

Gurgaon. The department of town and country planning (DTCP) has issued a notice to 11 upscale markets, including DLF 1 shopping mall, Galleria market in DLF 4, and Vyapar Kendra in Sushant Lok 1, to remove encroachments within a week. Demolitions will be carried out and penalties imposed if the markets fail to comply. The move came after the deputy commissioner's directive to free common areas of markets and malls from encroachments ahead of the festive season.After a recent meeting with officials from various departments, including the DTCP, GMDA, HUDA, and MCG, DTCP's team inspected several commercial complexes across New Gurgaon on Oct 16. They identified illegal structures, such as kiosks, stalls, and temporary installations in common areas and walkways, that obstruct pedestrian movement.DTCP enforcement officer Manish Yadav emphasised the seriousness of the campaign. "This encroachment drive is part of our larger efforts to ensure the smooth functioning of public spaces in licensed colonies. After seven days, we will reinspect these markets. If encroachments persist, we will initiate action as per the law, which could involve demolishing unauthorized structures."Rakesh Mehta, a resident of DLF Phase 4, said, "We've been asking for these encroachments to be removed for a long time. It's become impossible to walk in the common areas."

Shweta Anand, a resident who visits the Galleria Market frequently, said: "These temporary stalls block the entire corridor. It's chaotic during peak hours. Clearing them will make shopping much more comfortable."

## S+4 floor policy: Architects issuing OCs in 'violation' of rules to get a hearing

Gurgaon. The department of town and country planning (DTCP) in Haryana has decided to offer architects, who issued occupation certificates (OCs) for four-storey buildings with stilt parking in violation of regulations, a chance to be heard. The director of the department, who took the decision, proposed imposing a fine of ?2 lakh for each violation. Senior town planners (STPs) have been directed to conduct hearings for 18 architects involved in the issuance of illegal OCs.

After these hearings, it will be determined whether their registrations will remain cancelled or if they will be allowed to continue by paying the penalty.

- STP, Gurgaon, Renuka Singh confirmed that "all legal procedures and investigations will be completed before any action is taken". On Feb 23, 2023, the Haryana govt imposed a ban on the construction of four-storey buildings with stilt parking. However, several buildings in the city managed to bypass this regulation.
- These structures initially had plans approved for two or three floors but went ahead to construct four floors.
- With the connivance of certain architects, occupation certificates were issued for these illegal constructions.

# UP approves 'New Noida' plan, first phase to be ready in 3 yrs

Noida. UP govt approved two master plans listing development projects to be carried out by Noida Authority and Yamuna Expressway Industrial Development Authority (YEIDA) over the next 15 years. The Noida master plan 2041 focuses primarily on the expansion of the Dadri-Noida-Ghaziabad Investment Region (DNGIR), commonly referred to as New Noida. The project will involve acquiring land from 80 villages across Gautam Budh Nagar and Bulandshahr districts.It was in Aug last year that the Authority board approved the plan. After public feedback, it was submitted with the state govt, which granted its final approval last week.New Noida will come up in four phases – the first one across 3,165 hectares by 2027. Between 2027 and 2032, another 3,798 hectares will be developed, followed by 5,908 hectares by 2037 and 8,230 hectares by 2041.The Authority has so far allocated around Rs 1,000 crore for land acquisition.Of the total land, 40% is designated for industries, 13% for residential development, and 18% for green areas and recreational spaces. The new city,



designed to accommodate around 6 lakh residents, will also have commercial zones covering 4% of the total area and institutional areas spanning over 8% of the land.YEIDA's master plan ill include 55 villages of Bulandshahr, taking the total area to be covered by it to 226 - 131of them from GB Nagar. The area covered by phase 1 of the project has been increased from 583sqkm initially to 769sqkm. As a result of this expansion,

the population in the YEIDA region is expected to reach 37 lakh by 2041.A major highlight of this master plan is the expansion of the aviation hub around Noida airport in Jewar, with the total area dedicated to the airport increasing from 5,000 to 6,286.7 hectares. Apart from expansion of the airport, industrial units related to aviation, such as those involved in aircraft engine manufacturing, will be established in the region. The plan also

introduces two new land-use categories multiple use hospitality and multiple use industrial, both of which will be developed near the airport. These areas will combine residential and industrial zones, providing housing for workers and space for industries. To prevent illegal constructions around the airport, land will be acquired for industrial sectors 8A, 8B, 8C, 8D, 8E, and multi-use sectors 7, 8, and 31B. Additionally, land has already been allocated for hospitality sectors like 23G, 23I, and 23E. The master plan area has been extended up to the Delhi-Howrah route, with a proposal for direct railway connectivity, and a logistics hub spanning 1,500 hectares adjacent to Chola station near the airport railway line. The plan will include provision for an Olympic Park in sectors 22F and 23B, where Olympic-level sports infrastructure will be developed. Furthermore, two new sectors - Sector 4A (365 hectares) and Sector 5A (395 hectares) - are planned for multiple land-use industries, with proposals for the development of a Korean City in Sector 4A and a Japanese City in Sector 5A.

# Malaria cases on rise in Hry; tally 168 now, double last year's count

Gurgaon: Haryana has recorded a spike in the tally of malaria cases, which has reached 168 so far this year, nearly twice the number reported in 2023. NCR districts have been the most severely affected, with Sonipat reporting 35, followed by Jhajjar 26, Faridabad 25 and Charkhi Dadri 8. This significant increase is in sharp contrast to the numbers recorded in the past few years, with 85 cases in 2023, 52 in 2022, 54 in 2021 and 111 in 2020. Health officials have observed that the peak

risk period for malaria in Haryana usually extends from Feb to Sept. However, recent patterns suggest a slight change, with the state reporting cases in Oct also. Residents have been The department has also geo-tagged all urged to take preventive measures, such as using insect repellent and eliminating standing water where mosquitoes breed. Apart from NCR, Panchkula and Hisar have each reported 21 malaria cases so far. The



alarming increase in malaria cases has prompted health officials to intensify their efforts in controlling spread of the disease. Public health campaigns focusing on mosquito control and awareness about prevention strategies are being strengthened across the state.

in Chandigarh. This year, Gurgaon has recorded two cases so far. The city reported no malaria cases in 2023, and a district can be declared "malaria-free" if it maintains a casefree status for three consecutive years. The World Health Organization (WHO) defines vectorborne diseases as "human illnesses caused by parasites, viruses, and bacteria transmitted by vectors.'

CMO Virender Yadav expressed concern about the changing pattern of malaria cases, stating, "The period of greatest risk earlier in the state has been between Feb and Sept. Cleanliness is essential for preventing infections, especially in moisture-prone areas like feet and between fingers. Regular hand washing, drying off properly, and using protective powders or lotions are simple but effective practices. It's also important to keep our surroundings clean, regularly clean air conditioners, and use disinfectants to reduce infection risks."

### 1 more banker held for links with cyber cons; 21st arrest this year

Gurgaon. A UCO Bank staffer and his associate were arrested on Saturday by the cyber police in connection with a Rs 24-lakh investment fraud case registered at Cyber West police station in July 2024. Since Feb this year, police have arrested 21 bankers for helping cons open bank accounts to park defrauded money. The accused-- identified as Ram Avtar, a resident of Kusum Vihar in Jaipur, and Kanishka Vijay Vargiya of Mangrol-were nabbed from Rajasthan, said cybercrime ACP Priyanshu Diwan.In July 2024, a victim of cyber fraud had approached Cyber West Police, alleging that he was duped of Rs 24.6 lakh by unknown fraudsters who lured him to invest in the stock market via them to get huge profits. "After the victim transferred the amount to a bank account as per their instructions, the accused showed him "profits" he made virtually, on a webpage created by them. But when he said he wanted to withdraw the amount, the accused stopped all communication with him and the webpage also became inaccessible," said police. A case of cheating was registered."Kanishka Vijay Vargiya told us that the account was opened using fake documents by UCO Bank's deputy manager Ram Avtar. We arrested Ram Avtar based on this confession,' police spokesperson Sandeep said.Ram Avtar worked at the bank's Mansarovar branch in Jaipur. "Details of the bank account fraudulently opened were provided to cyber fraudsters by Kanishka. Both the accused used to get Rs 7,000 each for providing bank accounts to cyber fraudsters," e added.

### Hezbollah deputy Naim Qassem flees to Iran fearing assassination bid: Report

- World Hezbollah's second-in-command and deputy secretary general Naim Qassem has fled from Lebanon to Iran amid Israel's attacks on Lebanon, according to a report in UAE-based Erem News. The report quoted an Iranian source as saying that Qassem left Beirut on October 5 in an aircraft used by Iran's Foreign Minister Abbas Araghchi for a state visit to Lebanon and Syria. His transfer was ordered by top leaders of the Islamic Republic due to fear of assassination by Israel, the source was quoted as saying.Qassem delivered three speeches since the killing of Hezbollah chief Hassan Nasrallah by Israel on September 27, one from Beirut and the other two from Tehran, the report said.Notably, Israel has killed several Hezbollah leaders since the beginning of the war with Hamas.
- One of the founding members of Hezbollah, Naim Qassem, has taken a more public role since Nasrallah's death.Qassem's political activism began with the Lebanese Shi'ite Amal Movement. He left the group in 1979 in the wake of Iran's Islamic Revolution.
- He took part in meetings that led to the formation of Hezbollah, established with the backing of Iran's Revolutionary Guards after Israel's invasion of Lebanon in 1982, news agency Reuters reported.

### Israel says it will target Hezbollah's financial arm and announces imminent strikes in Lebanon

DEIR AL-BALAH. Israel's military announced Sunday it will now take aim at the Lebanon-based Hezbollah's financial arm and plans to attack a "large number of targets" in the coming hours in Beirut and elsewhere.Israeli military spokesman Rear Adm. Daniel Hagari said they will issue evacuation warnings for people in parts of Beirut, and "anyone who will be near the sites used to finance Hezbollah's terrorist activity is required to stay away from them immediately."The strikes will target al-Qard al-Hassan "all over Lebanon," a senior Israeli intelligence official said. Al-Qard al-Hassan is a unit in Hezbollah that's used to pay operatives of the Iran-backed militant group and help buy arms, the official added, speaking on condition of anonymity in line with army regulations. The registered nonprofit, sanctioned by both the U.S. and Saudi Arabia, provides financial services and is also used by ordinary Lebanese. A year of escalating tensions between Israel and Hezbollah over the war in Gaza turned into all-out war last month, and Israel sent ground troops into Lebanon early this month.

Israel's announcement came a day after U.S. Defense Secretary Lloyd Austin called civilian casualties in Lebanon "far too high" in the Israel-Hezbollah war, and urged Israel to scale back some strikes, especially in and around Beirut.Iran supports the Lebanonbased Hezbollah, and the United States is investigating an unauthorized release of classified documents indicating that Israel was moving military assets into place for a military strike in response to Iran's ballistic missile attack on Oct. 1, according to three U.S. officials. They spoke on condition of anonymity because they weren't authorized to discuss the matter publicly.

# **Beirut sees mass evacuations as Israel** prepares to attack Hezbollah sites

Beirut/Cairo Hundreds of Beirut residents fled their homes late on Sunday after Israel said it was preparing attacks on sites linked to the financial operations of Lebanon's Hezbollah group and told people to leave those areas immediately.Soon after the Israeli warning, several blasts were heard, and a large fire was seen in Beirut's southern suburbs. There was no immediate information on what caused the explosions, or details of any casualties.Panicked crowds clogged the streets and caused traffic jams in some parts of Beirut as they tried to get to neighbourhoods thought to be safer, witnesses said."Residents of Lebanon, the IDF (Israeli military) will begin attacking infrastructure belonging to the Hezbollah Al-Qard Al-Hassan Association - get away from it immediately," the Israeli military's spokesperson said in a statement on X.Al-Qard al-Hassan which the US has said is used by Iran-backed Hezbollah to manage its finances - has more than 30

branches across Lebanon including 15 in densely populated parts of central Beirut and its suburbs. There was no immediate statement from the organisation, Hezbollah or the Lebanese government.Asked by journalists whether the branches could be considered military targets. a senior Israeli intelligence official said: "The purpose of this strike is to target the ability of Hezbollah economic function both during the war but also afterwards to rebuild and to rearm ... on the day after."Cross-border fighting between Israel and Hezbollah erupted a year ago when the group began launching rockets in support of Palestinian militant group Hamas in Gaza.At the start of October, Israel launched a ground assault inside Lebanon in an attempt to stabilise the border region for its citizens who had fled rocket attacks in northern Israel. Israel has intensified its military campaigns both in Gaza and Lebanon, days after the killing of



Hamas leader Yahva Sinwar raised hopes of an opening for ceasefire negotiations to end more than a year of conflict.With US elections approaching, officials, diplomats and other sources in the region say Israel is seeking through military operations to try to shield its borders and ensure its rivals cannot regroup.Israel is also preparing to retaliate for an Iranian missile barrage earlier this month, though Washington has pressed it not to strike Iranian energy facilities or nuclear sites.Earlier on Sunday, Israel said it hit Hezbollah's intelligence headquarters and an underground weapons workshop in

Beirut.Fighter jets killed three Hezbollah commanders, the Israeli military said.Hezbollah made no immediate comment on those strikes, but said it had fired missiles at Israeli forces in Lebanon and at a base in northern Israel.A 41-year-old Israeli colonel was killed, and another officer was wounded

in combat in northern Gaza on Sunday, the Israeli military said. Israel's Channel 12 and public broadcaster Kan reported an explosive device had gone off under a tank.Officials said rescuers were still recovering people from the rubble after an Israeli attack on the northern Gaza city of Beit Lahiya that left 87 people dead or missing on Saturday, according to the health ministry - one of the highest death tolls for months from a single attack. The strike came two weeks into a major assault around Jabalia, just south of Beit Lahiya, where Israel says its troops have been trying to root out remaining Hamas fighters.

# Brazil's Lula cancels Russia visit for BRICS Summit due to minor brain haemorrhage

Brasilia. Brazilian President Luiz Inacio Lula da Silva on Sunday cancelled his trip to Russia for the BRICS Summit, following medical advice to temporarily avoid long-haul flights after a head injury at home that caused a minor brain haemorrhage.

In a statement, the presidential office said Lula, 78, will now participate in the BRICS meeting via videoconference. He was initially scheduled to depart at 5 p.m. on Sunday.Lula's doctor, Roberto Kalil, said in an interview with GloboNews TV channel that the president suffered a fall that caused "great" trauma to the back of his head, requiring stitches for the injury and resulting in a "small brain haemorrhage" in the temporal-frontal region."It's a condition that will require



repeat tests throughout the week. Any brain haemorrhage, theoretically, can worsen in the following days, so observation is important," he said.Kalil added that Lula is doing well and can engage in normal activities. According to a medical report issued earlier on Sunday by the Sirio Libanes Hospital in Brasilia, Lula suffered a laceration to the "occipital

region" in the back of his head on Saturday. The report said Lula "was advised to avoid longdistance air travel but is otherwise able to carry out his regular duties". The government said in a post on X that Foreign Minister Mauro Vieira has been designated to lead the Brazilian delegation in the BRICS Summit, departing later on Sunday.

The diplomatic forum founded 15 years ago by major emerging markets Brazil, Russia, India, China has since expanding to include South Africa, Egypt, Ethiopia, Iran and the United Arab Emirates.Congresswoman Gleisi Hoffmann, president of Lula's Workers Party, posted on social media that she had spoken with the president and that "he is doing very well, just avoiding a long trip."

The former US President stopped by a McDonald's in Feasterville-Trevose, Pennsylvania, in an apparent challenge to his Democratic rival Kamala Harris's claims of having a "middle-class background". Harris has frequently referenced her time working at McDonald's in her campaign ads and speeches.At the McDonald's stop, Trump took off his suit jacket, put on a black and yellow apron, and cooked batches of french fries, as one employee demonstrated him how to dunk baskets of fries into the fryer, salt them, and use a scoop to place the fries into boxes. The Republican candidate joked it was something he had "wanted to do all my life". Harris, the present US Vice President, had mentioned that she worked at the McDonald's fast-food chain during her college years in California in the 1980s

Ottawa, Canada Describing Canada's allegations as "politically motivated," India's top diplomat in the country has strongly rejected any role in the killing of Khalistani separatist Hardeep Singh Nijjar, who was shot and killed in British Columbia last year.High Commissioner Sanjay Kumar Verma made these remarks before leaving Canada, as tensions between the two countries pushed diplomatic ties to their lowest point. "Nothing at all," Verma said when directly asked about any alleged connection to the killing in an exclusive interview with CTV, in which he added that

"no evidence has been presented" for the "politically motivated" claims."Trump's Pennsylvania closing argument is literal junk. In a Pennsylvania rally speech his campaign team billed as 'the beginning of his closing argument in the final stretch,' Donald Trump focused on the issue most important to voters in this election: a deceased golfer's âWhen asked if the Indian government has ever targeted individuals with the intent of causing their deaths, Verma replied, "Never." This statement aligns with the Indian government's earlier rebuke of Canada, where it said that

the Trudeau government's claims about the involvement of senior Indian diplomats in the Nijjar probe "serve the political agenda of the current regime."Strongly rejecting Canadian claims, it attributed the allegations to "the political agenda" of the Trudeau government that is "centred around vote bank politics." New Delhi has repeatedly criticised Ottawa for being soft on supporters of the Khalistan movement who live in Canada and promote anti-India activities in the country. INDIA-CANADAROW

High Commissioner Verma's latest

comments come just days after the Canadian government accused Indian diplomats in Canada of engaging in activities related to crimes, including homicides and extortion. Tensions between Canada and India escalated following Prime Minister Justin Trudeau's statement last year about "credible allegations" linking Indian government agents to Nijjar's killing.In response to the allegations, Canada expelled six diplomats, including Verma, prompting India to Canadian diplomats. Meanwhile, New Delhi expelled.

Jerusalem, Israel A security cabinet meeting was held in Tel Aviv on Sunday during which "new ideas" regarding a deal to free Gaza hostages were discussed by high-level Israeli officials. The crucial meeting came as Israel is weighing a strong response to Iran following the missile attack and alleged attempt to assassinate Prime Minister Netanyahu's home.

In a statement, Prime Minister Benjamin Netanyahu's spokesperson said discussions were held during a high-level security cabinet meeting, which has now wrapped up, **ISRAEL'S STRIKES** The Times of Israel reported. "During the Lebanon's official National News Agency

meeting, new ideas were brought up to examine their feasibility for a hostage release proposal," the statement said.On Sunday, fighting raged on two fronts as Israel targeted what it said was a Hezbollah "command centre" in the Lebanese capital. Meanwhile, in Gaza rescuers reported 73 people killed in a single air strike. The strikes on Hezbollah's south Beirut stronghold came after Netanyahu accused the Iranbacked group of attempting to assassinate him by targeting his residence.

# Stray dog birth control campaign begins in Pollachi

News box

COIMBATORE: Pollachi Municipal administration has begun the stray dog sterilization process and has planned to perform the Animal Birth Control (ABC) procedure on around 20 dogs a week.According to a survey to start ABC procedures, in all 36 wards of Pollachi Municipality, around 1,300 stray dogs were identifed. However, due shortage of manpower, it was delayed. After a sudden spike in dog bite cases (281 patients in July), TNIE carried news 'No vet, Animal birth control not performed in Pollachi for one year' on August 8.N Shyamala, the municipal chairperson said that they could not carry out ABC for the past year due to the non-availability of a veterinarian and that had led to the increase in the stray dog population, increasing dog bites.She added, "We have roped an NGO from Tiruppur for temporary measure until we appoint a permanent veterinarian. As of now, the dogs will be taken to Tiruppur for sterilization and will be released back to Pollachi. We are planning to pay Rs 1,650 per dog. Simultaneously we are working for a permanent solution.

A senior official from Pollachi municipality, said, "With the help of volunteers from Tiruppur, the process has started. In the first phase, for the next six months, ABC will be performed on 500 dogs. After a week of sterilization, the dogs will be released to the same area from where they were captured. About 20 will be captured every week and will be taken to Tiruppur for vaccination and sterilization."

# Coastal districts in Andhra Pradesh on alert as Cyclone Dana brews

VIJAYAWADA: Cyclone Dana, the season's first tropical storm, is likely to form over the Bay of Bengal by October 23. It may take the shape of a severe category storm and move in the northwest direction towards north Odisha and West Bengal coasts, the India Meteorological Department (IMD) said on Sunday.Subsequently, administrations of all coastal districts in Andhra Pradesh have been put on alert. A low-pressure area is very likely to form over the East-central Bay of Bengal and adjoining north Andaman Sea over the next 24 hours. It is likely to move westnorthwestwards and intensify into a depression by Tuesday morning and into a cyclonic storm by October 23 over East Central Bay of Bengal. Heavy rains are likely at isolated places across the State on Monday. Highest rainfall recorded in Nellore & Kadapa districts

Thunderstorms and lightning are likely across the State on Monday. Light to moderate rains are also forecast for some areas. In the 24 hours ending 8.30 am on Sunday, heavy rains were recorded in Nellore and Kadapa districts, with the highest rainfall of 10 cm at Udayagiri in Nellore district and 7 cm in Kondapuram in Kadapa districts.

# Scrapping yet to pick up pace in Karnataka, only 3k vehicles reach facilities so far

BENGALURU: It has been nearly a year since two Registered Vehicle Scrapping Facilities (RVSF) became operational in the state. However, according to data from the RVSF dashboard of the Ministry of Road Transport and Highways, these facilities have not gained the momentum anticipated by the state transport department, with just over 3,000 vehicles (both government and private) scrapped till date.Many private vehicle users prefer to continue using their old vehicles which are over 15 years. As per Karnataka's Registered Vehicle Scrappage Policy 2022, all government vehicles that are 15 years old and private vehicles that have completed 15 years and have not passed the fitness test should be scrapped.

Commercial vehicles, which must get their fitness certificates renewed every year, are also subject to scrapping if they fail the test. The RVSF facilities are designed

to conduct scrapping scientifically without causing any damage to the environment. Besides the scrapped materials are recycled.Additional Commissioner of Transport (Enforcement) C Mallikarjuna said that as per the data available with the state transport department, nearly 10,000 vehicles- both government and private vehicles have been scrapped so far. However, the numbers will take time to reflect on the MoRTH RVSF dashboard. Meanwhile, people said that more



He emphasised that while scrapping of government vehicles which have completed 15 years is mandatory, private vehicles owners have the option to keep their vehicles if they pass the fitness test. "As long as the private vehicles pass the fitness test, we cannot compel them to scrap the old vehicles. If old vehicles are scrapped, they get a Certificate of Deposit, which offer a concession on motor vehicle tax," Mallikarjuna said.

awareness should be created about vehicle scrapping policy for them to come forward and get their vehicles scrapped without polluting the environment.

They urged the state transport department to take up mass campaigns by showing videos on how an old vehicle is scrapped scientifically and how this will help prevent pollution.Mallikarjuna said the department will intensify these efforts to encourage people to scrap old vehicles.

### Odisha University of Agriculture and Technology issues cyclone advisory for farmers

BHUBANESWAR: Amid the India Meteorological Department (IMD) prediction of cyclone Dana hitting the state coast, the Odisha University of Agriculture and Technology on Sunday issued a detailed advisory on dos and don'ts for farmers.In its advisory, the directorate of extension education of OUAT has recommended a contingency plan for farmers to minimise damage and save their kharif crops and vegetables while advising them not to be panic.

- As paddy dominated the cropped area during Kharif and is in the maturity stage, farmers are advised to harvest an early variety of paddy with 85 per cent maturity and keep it in a safe place. If possible, separate the paddy grains from the crop by threshing, else cover the harvested crops with polythene to keep it dry, said the advisory. In case of medium and long duration paddy crops, farmers were advised to drain out excess water by providing drainage channel at an interval of every three feet distance if lodged. The lodged plants should be straightened to avoid rotting of emerged panicles.
- As heavy rainfall may aggravate the infestation of cut worms in late rice, the advisory recommended the use of plant protection measures by spraying chlorpyrifos at the rate of 2 ml per litre water.

For pulses and oil seed crops, steps must be taken for draining out water from the field and pick matured pods instead of waiting for the total maturity of pods to avoid viviparous germination in the pod itself. "Pick the matured pod as soon as possible and dry and thresh the harvested pods for safe storage. Heavy rainfall may aggravate pest attacks on prerabi pulses. Go for plant protection measures as per the advice of the field staff of the Agriculture department or officials of Krishi Vigyan Kendras," the advisory said.

### Kadapa teenager set ablaze by youngster succumbs to injuries, accused arrested

KADAPA: The teenager, who was set ablaze by a youngster in Gopavaram mandal of YSR district on Saturday, succumbed to her injuries early on Sunday while undergoing treatment at RIMS Hospital, Kadapa.Police arrested the accused, identified as Vignesh Jakkala (19), a few hours after the incident. Police had formed four special teams and nabbed the accused soon after the incident came to light.Elaborating on the incident, Kadapa Superintendent of Police V Harshavardhan Raju said the horrific incident occurred on October 19 in a forest area near PPKunta in Gopavaram mandal.

- Preliminary investigation revealed that the victim, a 16-year-old student of a private college in Badvel, was allegedly in a relationship with Vignesh, who had married another woman around six months ago. The accused lured the girl to the forest, where he assaulted her, set her on fire and fled the scene. During interrogation, Vignesh admitted that he committed the crime as the girl had been asking him to marry her.
- With the help of police, the victim managed to reach Badvel Hospital and was later shifted to RIMS Kadapa. She suffered 80% burns. She breathed her last in the wee hours of Sunday. "Our teams acted swiftly and located the suspect. He was apprehended on the outskirts of Kadapa on Sunday," the SP reaid said

Each AEO ordered to conduct a digital crop survey of 5,000 acres

THIRUVANANTHAPURAM: The Fort Police probing the loss of an antique brass bowl from the high-security zone of Sree Padmanabhaswamy temple in Thiruvananthapuram arrested an Australian citizen of Indian origin on Sunday and recovered the artifact from him. However, he was charged under 'dishonest misappropriation of property' - a lighter section - after it was found that the bowl, which has antique value, was not stolen, but rather "inadvertently taken away" by Gangesh Jha during his visit to the temple along with his wife and a friend Jha, 52, was taken into custody from Gurugram with the help of Haryana Police and brought to Thiruvananthapuram on Sunday. His wife and their friend also came along though they were not arraigned in the case. Jha was later released as the section charged was bailable.

The police said during the interrogation it was revealed that Jha did not steal the brass bowl, which is used for purification rituals in the temple. The bowl reportedly dates back to the 15th century and had Tamil and Malayalam inscriptions on it.Police sources said when Jha was waiting in the queue for darshan on October 13 — Vijayadasami day — he collapsed and a tray he was carrying fell on the floor along with the pooja offerings in it. Seeing this, some of the devotees standing nearby helped him get up, collected the offerings from the ground, and put them in another bowl which was lying outside the place of darshan, the officer said.

The officer said Jha did not even know that the bowl belonged to the temple. He thought that it belonged to one of the devotees, who had helped him.Jha told the police that he considered the bowl as a gift from god and took it with him, the source said

'From the CCTV visuals, it was evident that he did not steal it. He was under the impression that the bowl was given to him by one of the persons who helped him. He had lost his tray and in return someone gave him the bowl. He considered it as a gift from god and took it with him," the officer said. The police identified Jha from the CCTV footage and later tracked him down to a posh hotel in Gurugram, where he was staying. Police sources said the three of them were Australian citizens and they set out for a month-long pilgrimage to various temples in the country to honour the wishes of Jha's late father who was a college professor. The police said the bowl was recovered from Jha as he had kept it with him, counting it as a souvenir. After Thiruvananthapuram, the trio visited Rameswaram and Trichy and returned to Delhi. "They were regularly travelling during this time and did not spare a thought about the bowl they were carrying." the police sources said.

#### NALGONDA: Agriculture Extension Officers (AEOs) have announced that they would launch an agitation to protest against the alleged increased workload and harassment by higher officials in the department. The decision comes after they were informed that the department was planning to suspend 170 AEOs for allegedly neglecting to conduct digital crop survey.

The AEOs accused the state authorities

of not following the guidelines issued by the Union government regarding the crop survey. Citing guidelines, they said that they should do the survey with support from officials from other departments. "But, we are being asked to do the strenuous task all alone," they alleged.The Central government has brought the Digital Agri Mission scheme with the aim of creating Digital Public Infrastructure (DPI) in the agriculture sector. As part of this, in the first phase, 12 states have been selected. The main purpose of the digital crop survey is to take pictures of every plot of land in those states along with latitude and longitude and make an online database of the crops.



"The Agriculture department has ordered the AEOs to conduct a digital survey in Telangana and download a mobile app to know the guidelines and targets. The survey will map the crops being cultivated in each area," the statement said. It added that the AEOs are directed to take selfies and photos from a distance of 20 metres upon visiting the fields and identify irrigation sources there.

Considering there are about 12,000 grama panchayats in the state, they have been divided into 2,604 clusters with one AEO appointed to each. The statement said with about 1.5 crore acres of agricultural land, each AEO has been ordered to conduct a digital survey of 5,000 acres.Association leaders of AEOs told TNIE that it is extremely difficult to conduct a single survey. "Our appeal to the authorities to provide additional workforce did not yield any result. We are already burdened with 49 different tasks like conducting soil tests, awareness camps for farmers, farmer insurance, loans and others," they lamented.

They also expressed dismay over having to walk in hilly areas every day for the survey. They said, "In some areas, we have to wait for long periods for the internet to upload pictures on the app. The state government has given us one SIM card with one GB internet limit which makes the survey more difficult."

**Central guidelines** 

As per the guidelines from the Central government, the officials have been advised to take support from villagers and staff from various departments including Revenue, Panchayat Raj, Horticulture, Sericulture, Animal husbandry and AEOs. It is reported that around 14-20 thousand local youths in Karnataka and Madhya Pradesh are assisting in the conduct of the digital crop survey.

# Legendary Admiral of the old school

It was December 18, 1961, off the coast of Goa. The communication console on the bridge of the antiaircraft frigate INS Betwa crackled to life with a message from the Chief of the Naval Staff (CNS). It read, "Personal from CNS. Capture me a Portuguese frigate please." The captain of Betwa swung into action. The other ships patrolling in company — INS Beas and INS Cauvery — were told to join in. What followed was a battle in which Betwa's accurate gunfire crippled the Albuquerque and the frigate surrendered. Betwa's captain's message to the Naval Headquarters read, "Albuquerque has been destroyed and is now lying sunk in Goa harbour." A day later, the Governor-General surrendered, marking the end of over 450 years of Portuguese rule in Asia. The captain of Betwa was Commander Rustom Khushro Shapoorjee Ghandhi, Rusi to friends.

Rusi Ghandhi had a long and distinguished career in public service. A Jabalpur boy, born on July 1, 1924, Rusi joined the Royal Indian Navy in January 1943. His 36-year career saw him rise to the rank of Vice Admiral, command ships in all major conflicts, win the Vir Chakra for gallantry, head both the Eastern and Western Fleets, and serve as Commander-in-Chief of the Western Naval Command. After retirement, he spent five years as the Chairman and Managing Director of the Shipping Corporation of India. Concurrently, Rusi was the Captain Commandant of the Executive Branch of the Navy, an honour conferred upon retired flag officers who serve as a 'Distinguished Elder'. From 1986 to 1990, he served as the Governor of Himachal Pradesh. Some years later, 1993 to 1996, he was a member of the minorities commission. The vast canvas and wide variety of assignments would testify to his ability, experience and acceptability.

Rusi was quite the destiny's child! He took part in World War II as a young trainee, saw action in Atlantic and Indian Oceans, and was on board the W-class destroyer HMS Wakeful at Tokyo Bay during the surrender of Japan, marking the end of hostilities of WW-II. During the Royal Indian Navy uprising in 1946, he was on the river-class frigate HMIS Shamsher, the only ship in Bombay which did not mutiny. Interestingly, Rusi, as the gunnery officer, wanted to bombard the Royal Bombay Yacht Club, seen as a symbol of British colonialism, and even advised his Commanding Officer to do so.

As the aide-de-camp (ADC) to the last Viceroy of India, Lord Louis Mountbatten, with whom he forged a lasting friendship, he was present at Rashtrapati Bhavan on August 15, 1947, when 'India awakened to life and freedom', and witnessed the swearing in of the first Prime Minister, Jawaharlal Nehru. Thus, even before he was 25, he had a ringside view to some of the most seminal events of the 20th century.

In the late 1950s, Rusi took over as the skipper of INS Cauvery, the first of his many command tenures. In 1960, he commissioned the Betwa as her first captain and a year later, achieved poetic justice in putting out of action a frigate named after the second Viceroy of Portuguese India and the first Duke of Goa, Alfonso de Albuquerque.

In the 1965 Indo-Pak war, he commanded the ASW frigate — INS Khukri — and was the Senior Officer (F14) of the 14th Frigate squadron, which included INS Kirpan and INS Kuthar. Though continuously deployed, he experienced the frustration of the Indian fleet being assigned a defensive role and restrictions imposed on action against the enemy. When war broke out in 1971, Rusi as captain of the flagship of the Western Fleet, INS Mysore, was the de-facto chief adviser to the Fleet Commander, Rear Admiral EC Kuruvilla. The Western Fleet carried out the devastating missile boat attack on Karachi (Op Python) on December 8, undertook raids on the Makran coast, apprehended the Pakistani merchant vessel 'Madhumati', choked access to Pakistani ports and exercised control of North Arabian Sea. Rusi was awarded the Vir Chakra for "gallantry, leadership and devotion to duty of a high order'

# The many facets of Chukar partridge, a Himalayan gem

Summers in Ladakh can be deceptively sultry, as I discovered one afternoon going back and forth along the Markha river looking for birds. There weren't many rewards for my toils, except dehydration from the thin air and lack of shade....

A pall of dejection hung over the evening, till the time a slow, delicate movement around the bend caught a corner of the eye. It was a Chukar partridge, a plump, mediumsized bird that is much venerated in popular culture and lore. The Chukar partridge (Alectoris chukar) is native to the arid mountainous regions of West and Central Asia, and the western and trans-Himalayan regions. In India, it can be found in high-altitude regions of Ladakh, Jammu and Kashmir, Himachal Pradesh and Uttarakhand. The striking plumage makes it easy to spot in the field — black and white stripes run across a brownish upper body and creamy belly, the bright red beak and legs adding to the contrast.Ground-dwelling birds that are adept at navigating the rocky and rugged landscapes of their habitat, Chukars have short, rounded wings which make them strong flyers. They typically prefer to run swiftly to escape predators. Their diet primarily consists of seeds, grains and small insects.

Chukars play a vital role in the ecosystem by contributing to seed dispersal, promoting plant growth in otherwise barren areas. Their feeding habits also help control insect populations, indirectly benefiting agricultural activities. Additionally, as prey for larger predators such as eagles, hawks, and foxes, Chukars are an important part of the food chain in their mountainous habitats where resources for survival are scarce.

Their most discerning characteristic is their cultural symbolism, particularly in India. A representation of the bird gazing longingly towards the moon, yearning for it, is used to symbolise unattainable love, a metaphor for desiring something one can never possess. This imagery is found in poems, songs and paintings in many cultures across North India, from popular tales of unrequited love to the relentless pursuit of the unattainable divine in Sufism. The mythical bird Chakora in Hindu mythology is believed to be based on the Chukar, and also considered the etymological origin of the name. This fact is often debated though, with some theories positing the name's origin to Persian or Urdu, as the partridge holds symbolic meanings



across several West and Central Asian cultures, where it is idolised as a symbol of beauty and resilience. Since ancient times, the Chukar partridge has been prized as game, hunted for both meat and sport. Archaeological findings from the Byzantine era have revealed ornaments made from its bones, and visual depictions are also seen in church mosaics. It was widely introduced in parts of Europe, America and Australasia for this purpose in the late 19th and early 20th century. While the Chukar partridge is currently listed as a species of "Least Concern" by the International Union for Conservation of Nature (IUCN) Red List, its population is declining in several regions. Despite its adaptability, the bird faces several threats in the wild.

Habitat loss is one of the most pressing challenges, as human population expands, and infrastructure projects encroach into previously undisturbed areas. Road construction, agricultural expansion, and tourism development in high-altitude areas lead to habitat degradation and fragmentation, limiting the availability of foraging grounds and nesting sites.

Hunting is another significant threat. While it has been a traditional practice in many regions, over-hunting and the illegal capture of wild populations for commercial breeding are serious concerns. In some areas, hunting has reduced local populations to dangerously low levels. Although laws exist to

regulate hunting, enforcement is often weak, owing to the remoteness of the regions the birds inhabit.

Climate change poses a more long-term threat, as the Chukar's high-altitude barren habitat is especially vulnerable to changing weather patterns. Rising temperatures, altered precipitation and changing vegetation can all impact the bird's ability to find food and nesting sites. As glaciers melt and water sources become scarcer, both wildlife and human populations face increased competition for dwindling resources, placing indirect pressure on the species.Efforts to conserve the Chukar must focus on protecting and restoring natural habitats. This includes regulating grazing, preventing habitat fragmentation and ensuring that infrastructure development projects consider their impact on local wildlife. Involving youth and local communities in birdwatching and eco-tourism initiatives could provide alternative sources of income and create incentives to protect wildlife.

The next moring, as we hiked out of the village, I finally the saw the bird strike its quintessential pose, standing on a hillock and calling out into the sky, perhaps not a believer in the lunar lore as it was the middle of the afternoon with no moon in sight. A testament to nature's resilience, the Chukar reminds us that even in the harshest of environments, hope and beauty can endure.— The writer is a climate expert and outdoor enthusiast

Apart from getting rid of accumulated rubbish — though not in our minds and lives — this process is supposed to welcome good luck and wealth. This may well be true, as good luck and wealth disdain dirt. How one wishes that this was also true of the entire country, where rubbish does not spare high hilltops and oncepristine beaches. However, let's leave that tirade for another time and come back to the innards of domestic cleaning. Just about everything in the house is being turned upside down and inside out. Our backs are also being bent. Moans, groans and topical analgesics accompany the aches and pains that follow. Surprises spring from unseen corners and dust hidden for weeks, if not months, shames us and our supposed housekeeping. This time, one let ambition get the better of good sense and we entered the store. This is a place where things that cannot be thrown, but



should have been tossed out as quickly as possible, accumulate over months and years. It is like a grand convention of uneaten leftovers gathering in the fridge or elsewhere, and where the question is, 'should the item under question be thrown out now, or preserved for some weeks and only then be thrown?'Led by yours truly, into the store went the cleaners. There were piles to the left of us and piles to the right of us. We stood, then stared. Then, overwhelmed by the task before us, exited and locked the door. A council of war took place. It was now or never. Back we went. Why did we keep that tricycle used ages ago by our sons? Or that old swing? Things that will never be used and the dust on them has smothered all traces of 'sentimental value'. That is not to say that the store does not have many things that, for now, will not be thrown or given away.Mustering courage that had more to do with the mind than what little brawn one possesses, I first took on the old chest of drawers. The top one is what I call my heart-break drawer. In this are bits of the past that have both roots and tentacles. It holds all the little things that I do not have in my heart to remove or banish. There is a pair of unfinished bright red gloves that my mother had started knitting for one of our sons and could not finish; illness and then death got in

the way of clicking needles. There is my father's shaving kit and his much-treasured Solingen cutthroat razor that I never saw him use. There are drawings made by the now-grown children. The same chest has a drawer which I may well call the 'good effort' compartment. This is beholden to the English language and is the embodiment of one of its most vacuous phrases, 'good effort', even 'good attempt'. The phrase does not explain much. It does not pin down if something is actually good or bad, or terrible or excellent. All it says is that we do not want to say anything. The 'good effort' drawer has various things. It has bits of embroidery once done by family members who were learning the fine art of the crossstitch and left them at the stage of 'good attempt'. Worse, that drawer was also packed with the presumption of writings that I had done in school, college and later. These, even to me, would fall in the category of 'poor attempt'. Without further ado, these were collected and mercilessly tossed in the garbage bin. The elephant in the store was not in those drawers. That was in the reams of paper. Old letters, documents and publications. That's when the cleaning came to a standstill. Battle-hardened by the first skirmish, I opened one box of papers. That box has been taken out of the store and it is close to me as I type out this column. Some of what the box holds has come from friends and acquaintances of my parents. So far, I have read through the four issues of Harijan that was brought out by Gandhiji; these date back to 1940 and are in almost-pristine condition. There are sheets of Dawn, the paper started by Mohammed Ali Jinnah, and I've just finished reading its wobbly argument written in 1947.



# "Want To Put Culprits On No-Fly List": **Aviation Minister On Hoax Bomb Calls**

Ram Mohan Naidu said safety is the government's top priority and it is trying to minimise inconvenience. New Delhi: After nearly 100 flights received bomb threats in seven days since October 14, Union Civil Aviation Minister Ram

Mohan Naidu has said safety is the government's top priority and rules are being amended to put people who make such calls on the no-fly list. Making such threats will also be made a cognisable offence, with provisions for punishment and fines.Addressing a press conference on Monday, Mr Naidu said even though the threats have turned out to be hoaxes, there is a strict protocol that is followed by his department and airlines. "It is a very sensitive situation when it comes to such threats, there is an international procedure that we have to follow," he

said. The minister said multiple meetings have been held with stakeholders since the spate of calls began and amendments are being considered in the Aircraft (Security) Rules so that the people making such threats can be put on the no-fly list after they are identified. The other approach, Mr Naidu said, is amending

the Suppression of Unlawful Acts against the Safety of Civil Aviation (SUASCA) Act, 1982,



and consultations are being held with other ministries."If you look at the last week, eight flights have been diverted. Each threat is assessed individually and our response has been efficient and dynamic. We are also not compromising on safety and security. Even though most of them are hoax threats, we cannot take them lightly. The lives of passengers are important, the security situation is important and protocol is important. We have enhanced security at airports," the minister said.

Emphasising that the protocol is very rigid and strict procedures have to be followed, Mr Naidu said several meetings have been held with airlines and their opinion has been sought to minimise inconvenience to them as well as passengers.

We are all working towards a common goal. Even one plane getting diverted or delayed is not what we want ... There has to be some kind of deterrent and that is what we are doing with our planned amendments to the rules and the Act. We are working with the

Ministry of Home Affairs and state law enforcement agencies to speed up the investigations into the threats. The safety and security of passengers and their convenient travel is our utmost priority," he said. "With the collective efforts of everyone, we are going to see a much better picture in the coming days," the minister added.

## "You Don't Want India To Be Secular?": Supreme Court **On Preamble Petitions**

The Supreme Court was hearing a PIL seeking the removal of the terms "socialist" and "secular" from the Preamble to the Constitution.

New Delhi: The terms "socialist" and "secular" are part of the Constitution's basic structure and the courts have repeatedly emphasised this in multiple judgments, the Supreme Court said today. The court made the remarks while hearing a Public Interest Litigation seeking the removal of the terms from the Preamble to the Constitution. Among the petitioners is BJP leader and former MP Subramanian Swamy.

Arguing before the bench of Justice Sanjiv Khanna and Justice PV Sanjay Kumar, petitioner and advocate Vishnu Shankar Jain said the 42nd Amendment to the Constitution in 1976, which affected these changes, was never debated in Parliament.Justice Khanna responded that the matter has been debated at length. "Please see Mr Jain, the words have varied interpretation. Both words have different interpretations today. Even our courts have declared them, time and again, as part of the basic structure (of the Constitution)," he said.

"Socialism can also mean there has to be fair opportunity for all, the concept of equality. Let's not take it in the Western concept. It can have some different meaning as well. Same with the word secularism," he added.Advocate Ashwini Upadhyay, also a petitioner, referred to the Emergency imposed by the Indira Gandhi government during which this amendment was affected. "I don't want to say much on what Justice HR Khanna did and saved us," Mr Upadhyay said.

The reference was to the Supreme Court's 1976 judgment that held that a person's right to not be unlawfully detained could be suspended in the interest of the State. Justice HR Khanna was the lone dissenting voice in the 4-1 judgment of the Constitution bench. Justice Sanjiv Khanna is Justice HR Khanna's nephew.Responding to the lawyers' arguments, Justice Khanna asked, "You don't want India to be secular?"

Advocate Jain responded, "We are not saying India is not secular. We are challenging this amendment.""If one looks at the right to equality and the word 'fraternity' used in (the) Constitution as well as the rights under Part III, there is a clear indication that secular has been held as the core feature of (the) Constitution. I can cite cases for you. When secularism was debated, there was only the French model. The Supreme Court has struck down statutes that go against secularism. You may look at Article 25. For socialism, we have not followed the Western concept and we are happy on it," Justice Khanna said.

New Delhi: A day after an explosion at a school in Rohini set off a multi-agency investigation, Delhi Police has written to authorities in the Telegram app, seeking information about a handle named 'Justice League India', sources have said.Last evening, the Telegram handle posted CCTV footage of the blast and claimed responsibility for it. According to police sources, they have yet to receive a response from Telegram to their query. No known terror organisation's name has emerged in the probe into the blast so far. At 7.47 am yesterday, a loud blast damaged the wall of the CRPF school in Rohini's Prashant Vihar area. While no one was injured, the explosion shattered windows of cars parked near the school and hoardings of shops in the area. A cloud of smoke was seen billowing after the blast.

- Soon after the incident, police reached the spot. Fire engines and a bomb squad were called in. Later, sniffer dogs were pressed into action to look for clues. A forensic team examined the spot and collected samples, including a white powder-like substance.Anti-terror probe body National Investigation Agency and the National Security Guard joined the investigation too. A case has been registered under the Explosives Act and the area has been cordoned off.
- The blast, police sources said, appears to have been caused by a crude bomb. Police are scanning CCTV footage in the area to identify who planted it. According to sources, poice are not ruling out a conspiracy angle. The explosion has, meanwhile, triggered a political blame game. Delhi Chief Minister Atishi targeted the Centre, which controls Delhi Police, over the law and order situation in the national capital

In a post on X, Ms Atishi said the blast had exposed Delhi's "crumbling" law and order system. "The responsibility to maintain law and order in Delhi is with BJP's central government. But BJP ignores this and uses its time to disrupt the work of Delhi's elected governments. This is why Delhi's situation is now that of Mumbai during the era of the Underworld. Bullets are being fired in the open, gangsters are extorting money and criminals are upbeat. The BJP neither has the intent nor the ability (to handle this)," she said. "If by mistake, Delhiites give them (BJP) charge of Delhi government, the condition of hospitals, power and water supply will become the same as the law and order situation in Delhi," the Chief Minister added.Hitting back, BJP's Shazia Ilmi told NDTV, "The puppet CM is known for this. If you make her speak on any topic, it is always about the Centre. Something very serious has happened. The situation is totally in control. 

## Wipro shares gain 1% in early trade. What investors need to know

NEW DELHI. Wipro shares rose over 1% in early trading on Monday, continuing their positive momentum following the company's Q2 FY25 earnings report last week. By 11:20 AM, Wipro shares were trading 0.87% higher at Rs 553.50 on the Bombay Stock Exchange (BSE). The stock's rise comes after Wipro posted better-than-expected Q2 results, including a 21.3% year-onyear (YoY) increase in net profit to Rs 3,209 crore and the announcement of a 1:1 bonus issue.Despite the broader Nifty IT index trading lower, Wipro shares continued to gain, following a 4% jump in the previous session, where they hit an intra-day high of Rs 550.55.Wipro's Q2 performance surprised many, with the company securing large deals and its total contract value (TCV) rising by 8% quarter-on-quarter (QoQ). However, for Q3, the company expects revenue growth to range between -2% and 0%, citing seasonality and holiday-related furloughs. Analysts remain divided on Wipro's outlook. Nomura expects a 2.1% YoY decline in USD revenue for FY25, followed by a 5.2% rebound in FY26. The brokerage sees long-term margin improvements, forecasting EBIT margins to rise to 16.5% in FY25, and maintained a target price of Rs 670.

On the other hand, Jefferies remains cautious with an underperform rating and a target price of Rs 465, citing broad-based revenue pressure and disappointing Q3 guidance. Citi has a sell rating with a target of Rs 500, noting weak forward indicators such as a 4.4% YoY decline in headcount and an 11% drop in trailing twelve monthe TCV. months TCV.

## Why non-bank lenders continue to come under regulatory axe

- MUMBAI. Non-bank Financial Companies (NBFCs) have never been under so much regulatory fire like they are in 2024. To be factually correct, the Reserve Bank's axe has fallen on even large banks such as HDFC Bank, Bank of Baroda and Kotak Mahindra in recent times. What is more noteworthy is that all these are happening right under the watch of the present governor Shaktikanta Das, whose six-year stint on the 18th floor corner office of the Mint Road Headquarters is coming to end on December 10.Does this mean that the regulator has become hyper-active or is it that regulated regulator has become hyper-active or is it that regulated entities have become less responsive to the regulatory demands? Or is it a mix of both, along with the fast-changing technological landscape that's sweeping the financial services industry?
- Analysts are in unison in placing most of the blame on the regulated entities saying the number of black-sheep is growing as the pie is galloping--there are over 9,000 RBI-registered NBFCs and close to two dozens of them are systematically important upper tier NBFCs. "It's not a question of regulatory overarching or that the monetary authority is over-zealous in applying its breaks. The present governor has been most considerate in getting the industry views along while framing regulations," the head of the BFSI vertical at a foreign brokerage told TNIE.

# **RBL Bank shares crash 15% after Q2** results: What analysts are saying

#### RBL Bank share price: The private lender's shares plunged in intraday trading following the release of its Q2 FY25 earnings over the weekend.

**NEW DELHI.** Shares of RBL Bank declined sharply on Monday after the bank reported a sharp decline in its Q2 FY25 profit. At 1:10 pm, shares of the bank were down 14.21% to Rs 176.25 on the Bombay Stock Exchange (BSE). Earlier in the trading session, it hit a 52-week low of Rs 175.50. The private lender posted a 24.33% year-

on-year (YoY) drop in profit after tax (PAT), which came in at Rs 222.52 crore for the quarter ended September 30, 2024, compared to Rs 294.08 crore during the same period last year. Despite the significant decline in profit, RBL Bank reported some positive metrics. Its net interest income (NII) rose by 9% YoY to

Rs 1,615 crore, while net interest margins (NIMs) stood at 5.04%. Additionally, the bank's operating profit saw a 24% YoY growth, reaching Rs 910 crore for the quarter.

ANALYSTS ON RBL Q2 RESULTS It may be noted that Centrum Broking has maintained a 'Buy' rating on RBL Bank with a target price of Rs 291, suggesting a potential upside of 65.81% from its current low. The brokerage acknowledged that the bank faced challenges during the quarter, particularly with asset quality issues affecting key profitability areas.

However, Centrum adjusted its credit growth estimate to a 16% compound annual growth rate (CAGR) for FY24-27, which is lower than the bank's projection of 18%.Centrum also revised its return on assets (RoA) forecast to an average of 1.1% for FY26 and FY27, falling short of RBL's management target of over 1.3%. In light of these adjustments, Centrum has lowered its target price-to-adjusted book value (P/ABV) multiple from 1.25x to

1.0x, reflecting challenges in meeting the expected return profile and ongoing



valuation pressures in the broader banking sector.Despite the sharp fall in RBL's stock, Centrum believes that the concerns over growth, asset quality, and profitability are already reflected in the current share price. The bank's CASA (current account and savings account) ratio also improved, rising by 100 basis points to 33.6%

from 32.6% in the previous quarter. This growth was attributed to the bank's initiatives to strengthen its liability franchise. While RBL's liquidity position remains strong with loan-to-deposit (LDR) and liquidity coverage (LCR) ratios at comfortable levels of 81% and 129%, respectively, the bank's margins were impacted by an interest income reversal of Rs 120 crore, driven by higher gross non-performing assets (GNPA) in the microfinance and credit card portfolios

Starbucks revenue in the September quarter grew at a subdued rate of 2%, which the company attributes to the overall slowness in the QSR segment. The revenue growth was 4% in the previous quarter. In the previous financial year (2023-24), Starbucks had posted a revenue growth of 12% at R1,218 crore. Starbucks accounts for around 8% of Tata Consumer Products' consolidated revenue.Sunil A D'Souza, the CEO of Tata Consumer Products, says that the revenue growth from Starbucks is in line with what "we are hearing of across the overall QSR space." He says traffic has been an issue but not the ticket size."Once the consumer enters, we do see spending," D'Souza said in an analysts' call. He added that the team has put together a range of initiatives to drive traffic including launching a new classic range across both food and coffee segments with key focus on the pricing. Further elaborating the sluggish revenue growth in Starbucks, D'Souza calls it an overall consumer spending issue, especially in urban areas.

Core operating profit, excluding trading income, saw a 10% YoY rise to Rs 9,601 crore.Commenting on the results, Axis Bank's MD & CEO Amitabh Chaudhry highlighted the balance between digital expansion and physical branch openings. In Q2, the bank opened 150 new branches across both urban and rural areas, reinforcing its commitment to customer outreach.

This was a rare instance of New Zealand winning a Test match in India. In fact, this was only the first time that New Zealand had won a Test match in the country in 36 years.Coming into Day 5 of the game, India knew that they were banking on their pacers to deliver in Bengaluru. It had rained overnight in the city and there was a fair amount of rain in the morning as well before the start of play. However, the dependence turned into a nightmare after only Jasprit Bumrah turned up for the team on the final day of the game. Mohammed Siraj, who was the second pacer in the side did not threaten the NZ batters consistently, despite the conditions being overwhelmingly favourable for fast bowling. This was in



keeping with Siraj's performances at home this year.

The pacer has looked off colour more often than not in home Tests in 2024. If one would go back to the England Test series earlier this year, one would remember that Siraj was rested from the Test team after the first Test match at Hyderabad, having taken 0 wickets in the 1st Test against the Ben Stokes side.IND vs NZ, Bengaluru Test: Match ReportOverall, Siraj has played 7 home Tests this season and has only 12 wickets at an average of 42.83. This is in sharp contrast to Jasprit Bumrah who has picked 33 wickets from 7 games at the same tenure.

This milestone, achieved on October 21, 2024, during round 2 of Ranji Trophy against Chhattisgarh, underscores Pujara's relentless dedication and unparalleled skill in the red ball format. With the century, Pujara overtook legendary Brian Lara in the list of most First-Class hundreds. The India batter, who is currently out of the Test team, also completed 21,000 runs while batting in the Round 2 of the Ranji Trophy match.Born on January 25, 1988, in Rajkot, Gujarat, Pujara was nurtured in a

cricketing family. His father, Arvind Pujara, and uncle, Bipin Pujara, were both Ranji Trophy players for Saurashtra, laying the foundation for Cheteshwar's future in the game. Pujara made his first-class debut for Saurashtra in December 2005, and since then, he has been a cornerstone of the team.Pujara's domestic career is replete with impressive feats. success, Pujara has also made a significant impact in county cricket. Playing for Sussex

in the County Championship, he has demonstrated his adaptability and skill in different conditions. In April 2022, Pujara and Tom Haines became the first batters to score double centuries in the same innings of a first-class match while following-on, a rare feat that showcases his endurance and batting prowess.Pujara's performance in county cricket has not gone unnoticed. He scored his fifth century of the 2022 county season as Sussex captain against Middlesex, further solidifying his reputation as a reliable and prolific runscorer.

Despite the evolving landscape of cricket, with younger players often preferring the more aggressive and counterattacking styles, Pujara remains a beacon of traditional batting values. His ability to grind down opposition bowling attacks and his fitness tailored for long innings have made him a role model for aspiring cricketers.

Former Australian coach Justin Langer has praised Pujara's concentration and batting technique, noting that his ability to watch the ball closely is unmatched, even by the likes of Sachin Tendulkar and Rahul Dravid. This high praise underscores the respect Pujara commands within the cricketing fraternity.

Amelia delivered a sensational all-round performance, scoring 43 runs from 38 balls to help New Zealand set a competitive total of 158. She also took three wickets, showcasing her heroic skills on the field.I don't necessarily believe you deserve things



in sport, but if any two people do, it's Sophie and Suzie. I think back to myself as a kid, batting with Sophie and Suzie in the nets. When I was in primary school, I wrote about winning a World Cup with them. So to be here now, having done that, is probably why I'm so emotional out on the field. It's something so special when I think back to my younger self and to achieve this with two of New Zealand's best-ever players," she added.New Zealand's squad featured a strong blend of youth and experience. The calming presence of captain Sophie Devine, Suzie Bates, and Lea Tahuhu helped them navigate a challenging period leading up to the tournament. Having gone winless in ten

T20Is before the event, they gained momentum by beating pre-tournament favourites India in their opening match.Bates, 37, was the top scorer for New Zealand in the World Cup, amassing 150 runs, while Devine contributed 114 runs across six matches. Amelia scored 135 runs and topped the bowling charts with 15 wickets throughout the tournament.

Sophie Devine mentioned that the ODI Ŵorld Cup triumph in 2000 inspired many current cricketers, and she hopes that their T20 World Cup success will do the same for future generations in New Zealand.Yeah, look, we've spoken about the 2000 World Cup-winning side and the motivation it provided to the likes of Melie, yourself, and me, as well as many young kids at that time. I'm really hopeful that tonight's victory can inspire the next generation-not just young girls, but young boys as well—to pick up a cricket bat and ball."It still feels pretty surreal at the moment, and I hope the impact of what we achieved tonight will be longlasting and far-reaching. Everyone loves a winner, don't they? So, it's going to be pretty cool for us to see the potential impact." she added.

New Delhi Kagiso Rabada achieved a major milestone on Day 1 of the 1st Test between Bangladesh and South Africa at the Sher-e-Bangla Stadium in Dhaka on Monday, October 21. Rabada became the sixth South African bowler to take 300 Test wickets, joining a league of legends, which includes Dale Steyn, Shaun Pollock and Allan Donald.Kagiso Rabada achieved the feat during his first spell on Monday morning, bowling a ripper to dismiss former Bangladesh captain Mushfiqur Rahim for 11. Rabada bowled a good length delivery that jagged back and shattered the stumps.Kagiso Rabada is also the third-fastest South African bowler after Dale Steyn and Allan Donald to take 300 wickets in the traditional format. While Rabada achieved the milestone in his 65th Test match, Steyen achieved it in 2013 in his 61st Test and Donald in his 63rd Test in 2000.

Wolvaardt and Anneke Bosch fell to the impressive Amelia Kerr in the same over, while Rosemary Mair took three wickets to further stifle South Africa's chances.

#### Women's T20 World Cup Final, NZ vs SA: **Match Report**

Earlier in the match, South Africa had chosen to bowl after winning the toss, but their plans were quickly derailed when Georgia Plimmer was dismissed for just nine runs in the second over. New Zealand capitalised on this early setback, posting a commendable total of 158 runs, the second-highest in a Women's T20 World Cup final, with a remarkable 73 runs scored in the final six overs.Suzie Bates, playing in a record 334th international match, led the White Ferns with 32 runs before being bowled by Nonkululeko Mlaba. Despite losing their captain Sophie Devine, Kerr (43 off 38) and Brooke Halliday (38) steadied.
