ISRO targets December launch for historic space docking experiment

Chandigarh, Oct 23: The Indian Space Research Organisation (ISRO) has set December-end as the target for the launch of its



first space docking experiment, which, if successful, would pave the way for future inter-planetary missions and propel it into a select global league of three such operators. A key spin off of this technology would be extending the operational life of existing satellites. "Space assets like geo-stationary satellites are very expensive but have a life of 8 to 10 years when their propulsion units run out of fuel even though their other onboard systems and sensors are fully functional. Space docking technology would enable replacing propulsion units repeatedly, enabling them to remain effective for several more vears," Dr KV Sriram, director of ISRO's laboratory for Electro-Optics Systems (LEOS) told The Tribune during his visit to Chandigarh on Wednesday. "Two satellites designated simply as 'Chaser' and Target' that have been assembled and integrated by a private firm have been received and would be launched on board a single PSLV-class vehicle, which would couple at an altitude of about 700 km," he said. Each satellite weighs about 400 kg. Besides validating the docking technology, the mission christened Space Docking Experiment (SPADEX), would also carry several payloads for undertaking scientific studies, he added. A host of critical simulations and end-stage special reviews by scientists at ISRO establishments are currently in progress. Space docking is the process of two individual manned or unmanned spacecraft locating each other and physically connecting in space and thereafter operating as a single unit for various purposes such as replenishment, repair and crew exchange, till they are separated by command. So far, the United States, Russia and China have developed this technology. Dr Sriram said that a single spacecraft cannot out complex missions such as inter-planetary exploration, sample collection from space bodies, manned space flights or operating space stations, and require more than one vehicle such as an ascender and descender.

Convene meeting to approve artificial rain plan for Delhi: Gopal Rai

New Delhi, Oct. 23: Environment Minister Gopal Rai on Wednesday said he has written to the central government reiter-

ating his request to convene a meeting of all stakeholders to approve a cloud seeding proposal to artificially induce rain to combat air pollution in Delhi. This comes amid Delhi's worsening air quality. A thick layer of smog enveloped the national capital on Wednesday morning as its air quality remained in the 'very poor' category with an overall Air Quality Index (AQI) of 363. The Central Pollution Control Board (CPCB) on Monday invoked the second stage of the Graded Response Action Plan in the national capital, imposing restrictions on

the use of coal and firewood as well as diesel generator sets. In his letter to Union Environment Minister Bhupender Yadav, Rai emphasised the need for emergency measures, including cloud seeding, to mitigate the health risks posed by hazardous smog and pollution levels. He also reminded Yadav of his previous letters dated August 30 and



October 10 in this regard. "Delhi's air quality has already reached alarming levels and the government has implemented the Winter Action Plan from September 25, 2024, to combat pollution. However, in case the situation worsens, we are exploring alternative solutions for immediate relief," Rai said. Cloud seeding, a process that involves artificially inducing rainfall to wash pollutants from the atmosphere, has been explored by the Delhi government before. However, it requires clearances from various central government agencies, including the Ministry of Defence, Directorate General of Civil Aviation and the Airports Authority of India, he said. Given the potential for the air quality to turn severe in November, Rai said a meeting of all relevant stakeholders should be convened to tackle the problem. He underlined the importance of coordinating efforts between agencies such as the CPCB, the India Meteorological Department (IMD), and the Bureau of Civil Aviation to implement cloud seeding as a potential emergency measure. Rai's letter also included a presentation by IIT Kanpur outlining the feasibility of cloud seeding. "Considering the worsening pollution levels, it is imperative that we evaluate this method's feasibility in Delhi's context."

JMM releases 2nd list, Rajya Sabha MP Mahua Maji to contest from Ranchi

Ranchi, Oct 23: The JMM on Wednesday released its second list of candidates for the upcoming Jharkhand assembly polls, fielding Rajya Sabha MP Mahua Maji from Ranchi. Maji, who was elected unopposed to the Rajya



Sabha in June 2022, previously served as the chairperson of the Jharkhand State Commission for Women and was the former president of the JMM's women's wing. She had contested the Ranchi assembly seat unsuccessfully in 2014 and 2019. NDA constituent BJP has fielded incumbent legislator CP Singh from Ranchi. Meanwhile, sources said there was resentment among INDIA bloc constituent Congress over JMM's nominee from the seat. Earlier in 2022, when Maji's name was announced as Rajya Sabha candidate, the Congress maintained that there was "a contradiction between what was discussed in Delhi and the decision that was taken by the JMM". The Jharkhand Mukti Morcha is in alliance with Congress and the RJD in Jharkhand. Earlier in the day, the JMM released its first list of 35 candidates and nominated Chief Minister Hemant Soren from Barhait, Kalpana Soren from Gandey and Basan Soren from Dumka. The Assembly elections are set to take place in two phases on November 13 and 20, with results to be announced on November 23. Filing of nomination papers for 43 assembly constituencies of Jharkhand, which are going to polls on November 13 in the first phase, began on Friday and will continue till October 25. Altogether 2.60 crore electors, including 11.84 lakh first-time voters and 1.13 lakh persons with disabilities (PwD), third gender and senior citizens over 85 years of age, are eligible to exercise their franchise in the upcoming

HC refuses to recall order on consolidating all suits ST Correspondent

New Delhi, Oct. 23: The Allahabad High Court on Wednesday rejected an application to recall its January 11 order that consolidated all suits of the Hindu side filed in the Krishna Janmabhoomi-Shahi Idgah dispute of Mathura. Counsel Tasneem Ahmadi, who appeared on behalf of the Muslim said, had sought recall of the order contending that the matter is in a premature stage and cases should not be consolidated before framing of issues and collecting evidence. Opposing the application from the Hindu side, it was submitted that once the court is of the opinion that reliefs are the same, the property is the same and further that the defendants are the same it is the domain of the court to consolidate the cases and no party has right to challenge the same. It was also alleged that the objective of the application was to delay court proceedings. The High Court had on August 1 2024, ordered the framing of issues but no issues have been framed till now and the court is only hearing applications. The counsel from the Hindu side, Hari Shanker Jain, had submitted that the consolidation of cases did not mean that the right to contest all the cases would be stopped. Consolidation of cases is a discretionary power of the court and it cannot be changed by anyone, he submitted. The court fixed November 6 as the next date of hearing. On January 11, the high court "in the interest of iustice" directed that the 15 suits on an application filed by the Hindu plaintiff be consolidated.

New Delhi, Oct 23: Jagdambika Pal, who heads the Parliamentary committee on Waqf Bill, on Wednesday rejected the Opposition's allegations that he had violated norms by going public about TMC MP Kalyan Banerjee smashing a glass bottle and hurling it at the chair during a meeting of the panel. "I have not revealed any proceedings or deliberations of the committee. I have only made statement about an incident of violence during the committee meeting by a member and his subsequent suspension," Pal said. DMK member A Raja and AAP member Sanjay Singh had alleged that Pal had violated rules of procedure for conduct of Parliamentary committee meetings, which were conducted in-camera. "I have always adhered to the rules of parliamentary procedure and upheld the dignity of the House." Pal said. He said as the chairman of the joint committee on Waqf (Amendment) Bill, he made a statement on the incident of violence during the meeting of the panel on Tuesday involving a member and the subsequent action against him. Priyanka Gandhi kicks off poll debut with massive roadshow, files nomination

Wayanad, Oct 23: Congress general secretary Priyanka Gandhi Vadra, who kicked off her electoral debut with a massive roadshow in Kalpetta here and filed her nomination for the Wayanad Lok Sabha bypoll, on Wednesday said she has 35 years of experience in the political arena beginning from the age of 17 years when she campaigned for her late father Rajiv Gandhi in 1989. Priyanka, who reached Wayanad on Tuesday night with her mother and Congress Parliamentary party chairperson Sonia Gandhi, led a massive roadshow along with her brother -- Leader of Opposition Rahul Gandhi - in Kalpetta and then addressed the thousands who were gathered here to give her rousing welcome with placards, balloons and drum beats. Addressing the massive gathering ahead of filing nominations for the November 13 bypoll, she said, "At the age of 17 years, I first campaigned for my father in 1989. It has been 35 years now (since then). "I have campaigned for my mother, for my brother and for many of my (party) colleagues. This is the first time I am campaigning for

Wayanad Lok Sabha bypoll candidate Navya Haridas said she was more experienced in repre-

senting people than Priyanka. Sonia Gandhi, Rahul, Congress chief Mallikarjun Kharge, Karnataka CM Siddaramaiah, Telangana CM A Revanth Reddy and other senior party leaders were present on the dais during Priyanka's speech. During her public address, Priyanka further said that she was deeply grateful to Kharge for giving her the "privilege" of being the UDF candidate from Wayanad and "it is my honour to represent you (people of Wayanad), if you give me a chance". She also referred to her visit to Wayanad after the massive landslides which destroyed three villages in the hill district and claimed over 200 lives, and said everyone she met was engaged in help-

ing others. "Your courage deeply touched me. It would be a big honour and a great privilege to me to be a part of your community and your family," she said. She further said that the people of Wayanad stood with her brother Rahul when the whole world had turned its back on him. "My whole family will always remain indebted to you



and grateful to you for this support. He (Rahul) is sad to leave you, but I have promised him that I will only strengthen the bond between you and him. "I am here to fight your battles, stand by you through thick and thin, be your voice, and I will not let you down," she said. Attacking the BJP government at the Centre, Priyanka said that the

present times were one where those in power were trying to divide the people who voted them to power. "They do not hesitate to subvert democracy. It is not the politics on which our nation was founded," she said. The Congress leader also said that all religious texts, be it the Bible, Gita or Quran, teaches love, humility and equality. Rahul, who also addressed the gathering, asked the people of the hill region to take care of his sister, Priyanka Gandhi, just as they had protected and looked after him when he needed it most. Rahul, who represented Wayanad from 2019 to 2024, also said that he would be the unofficial MP from the constituency, while his sister would be the official

MP. "So, there will be two MPs from Wayanad in Parliament," he said. The by-election for Wayanad LS seat became necessary after Rahul Gandhi, who won the Lok Sabha polls from there and Rae Bareli constituency this year, decided to vacate Wayanad. Kharge, who also spoke at the event, said that Priyanka is in Wayanad not just to file her nomination, but as a relentless champion for the people of the hill district. "Bless her, and she will deliver the results," he said. After their public address, Priyanka left for the collectorate where she filed her nomination papers in the presence of Sonia Gandhi, Rahul Gandhi, Kharge and AICC general secretary K C Venugopal. Subsequently, Priyanka and Rahul visited the Puthumala mass burial ground and paid tribute to those who lost their lives in the Wayanad landslides. Earlier in the day, she was given a rousing welcome by thousands of UDF workers and supporters as well as members of the general public of all age groups, who were waiting since early morning, carrying placards with Priyanka and Rahul Gandhi's photographs, balloons in the party colours and drum beats. Balloons in the party colours of the Congress and its ally Indian Union Muslim League (IUML) dominated the scene as they were also lined up on both sides of the nearly two kilometer long roadshow route.

CHENNAI. The state government will partially fund 'pink autorickshaws' that will be operated by women in Chennai to ensure the safe travel of women and children. The government will provide '1 lakh each as grant to 250 women residing in Chennai to buy CNG/hybrid autorickshaws. Loan will be provided for the rest of the amount required to purchase the vehicle

Women in the age group of 25-45 can apply for the scheme, and priority would be given to widows and destitute women. The applicants should be residents of Chennai, should have passed the SSLC examination and possess a driving licence.

The release added that eligible women who wish to avail the scheme should send an application to the social welfare officer, 8th floor, Singaravelar Maaligai, Chennai-600001, by November 23. Hoax bomb threat at Kochi airport: X approached for details of two accounts

KOCHI. With four bomb hoaxes reported on flights from Kochi airport in three days, the police have started attempting to collect details of two X handles which were involved in three such threats. Nedumbassery police have approached the social media platform regarding the false messages sent to flight operators on Saturday and Sunday.

According to the police, the first message received on the X handle of Alliance Air was from an account named adamlanza111, claiming to have placed bombs on its Kochi-Bengaluru flight on Saturday afternoon. On Sunday, two threats were issued to the X handle of Akasa Air, claiming that 12 persons carrying bombs were on six of its flights. The hoax was sent from the X account schizophrenia111.

These two accounts were involved in a majority of the hoaxes received by various flight operators across India. We have approached the platform X, seeking details of these two accounts. The IP address of the device used for issuing the threats has been sought.We suspect the messages were sent by the same person. Also, it is suspected that the accused used a virtual private network (VPN) to access the X account and issue the threats. Most likely, the X accounts were created and threats were issued via mobile phones," a police officer said.

The police will coordinate with other state police forces. "Over 70 flights operating from all major airports in the country received bomb hoaxes last week. Cases have been registered for false bomb threats in other states as well. We are looking to collect information from other state police forces. Also, we are checking similar threats issued to airline companies in the past to know more about the pattern.

As we suspect the usage of VPN in posting threats on X, there is the possibility of someone within the country being behind the act," the officer said.On receiving the hoaxes, a Bomb Threat Assessment Committee (BTAC) was convened to assess the situation and the threat was classified as "non-specific". On Monday, a passenger was detained after he told security persons that he was carrying a bomb during the security

Death toll in Bengaluru building collapse reaches five; three remain trapped, 13 rescued

BENGALURU. The death toll from the collapse of an under-construction building in Bengaluru's Babusapalya has risen to five, with three people still trapped under the debris.

The collapse occurred around 3:40 pm on Tuesday amid heavy rainfall in the city. A total of 21 labourers from Bihar, Chittoor in Andhra Pradesh, and Yadgir in Karnataka were trapped when the under-construction building gave way. CCTV footage showed the building's first floor collapsing before the entire six-story structure leaned and then split into two parts.A night-long rescue operation involving the NDRF, SDRF, police, and fire emergency services is underway to save the trapped death toll has increased to five, with three people still believed to be trapped complaints from the injured once the

Is Bengaluru Kambala animal cruelty? Karnataka govt to file response in High Court



BENGALURU. The Karnataka High Court on Tuesday adjourned to Wednesday hearing of a public interest litigation filed by the People for the Ethical Treatment of Animals (PETA)-India, seeking directions to restrain the state government from permitting 'Kambala' (buffalo race) scheduled for October 26 in the city.

A division bench of Chief Justice N V Anjaria and Justice K V Aravind adjourned the hearing after the government advocate sought time on behalf of Advocate General Shashikiran Shetty to submit the government's response on Wednesday on whether holding Kambala in Bengaluru amounts to cruelty to animals or not.

Senior advocate Dhyan Chinnappa, appearing on behalf of the petitioner, argued that Kambala is permitted to be conducted only in two districts --Udupi and Dakshina Kannada -- where it is considered a traditional sport as per an affidavit filed by the state government before the Supreme

f the event is permitted to be conducted in Bengaluru, buffaloes will be brought from Dakshina Kannada, which is 300 km away from the city, he said, adding that this amounts to cruelty. This is also a commercial event, which is not permissible as the organisers will sell tickets, set up food courts, etc., he argued.

The petitioner sought the court's directions to the state government to enforce the provisions of the Prevention of Cruelty to Animals (Second Karnataka Amendment) Act, 2017, and the observations by the Supreme Court in the case of the Animal Welfare Board of India and others.

The accused persons have not divulged information about those who bought the

Water supplier and 2 others arrested for assaulting condo security guards

Gurgaon. A private water supplier and his two associates were arrested for assaulting three security guards at an under-construction condominium on Oct 18. An argument over water supply at the construction site resulted in the altercation. The accused attacked the guards with sticks, threatening to kill them if water was procured from any other supplier.

Based on the complaint of Pankaj Tiwari, one of the guards, a case was registered at Rajendra Park police station. The accused—Lala Kataria alias Manish Kataria, Lalit Janghu and Deepak Punia were arrested on Tuesday. Around 10pm on Oct 18, the accused arrived at ATS Homecraft Society's site near Daultabad flyover in Sector 15, Tiwari alleged. "They got out of their vehicle and started attacking me with sticks once I tried to stop them from entering the site. They damaged the furniture in the guard room, sales office, and also the CCTV cameras. When I raised an alarm, two of my colleagues, Sriram Tiwari and Nilesh Dube, came to my rescue. The accused assaulted them too. They left the place only after threatening to kill us if water for the project is procured from anyone else other than Kataria," Tiwari said. A case was registered under sections 115 (voluntarily causing hurt), 3 (5) (common intention), 324 (4) (mischief causing damage to the amount of twenty thousand rupees and more but less than one lakh rupees), 333 (housetrespass after preparation for hurt, assault or wrongful restraint), and 351 (2) (criminal intimidation) of BNS

After Kochi, Aqua Line stns will also offer power banks

Noida: Commuters on Aqua Line trains can now charge their mobile phones on the go. The Noida Metro Rail Corporation (NMRC) has hired an agency to provide a power bank facility on a pay-and-use basis starting Wednesday. An NMRC official said that each station on the Aqua Line, which spans Noida and Greater Noida, will be equipped with three power bank vending machines, each with at least 24 slots for mobile power backups."These on-the-go power banks will be available for use and can be returned to any metro station's power bank vending machines," said the official. A similar facility is already operational at the Kochi Metro.To access the service, commuters must download the mobile app of the service provider, scan the QR code on the machine, and release a power bank. They can use the power bank during their commute and return it at the exit station. Speaking about how daily commuters can benefit from this facility, Dhruv Kumar, a commuter, told TOI, "This is a bustling city, and people are always on the move, whether for work, college, meetings, or social gatherings. Often, phone batteries die while traveling, which can be very inconvenient, especially when we rely on them for staying connected, navigation, payments, etc. Having power banks available at metro stations will make commuting hassle-free and ensure people stay

Man 'beaten to death' after clash; 2 arrested

Noida. Police arrested two persons after a 28-year-old man succumbed to injuries allegedly after a fight over some dispute with his friends in Greater Noida's Dadri area on Monday night. Police have arrested two of the named accused after a case was registered under BNS ion 103(1) (murder). According to a complait filed by the brother of the victim — Prashant alias Chhotu he engaged in a fight with Jitendra alias Chinche, Kamal, Anuj and Gabba.Prashant's elder brother later told police the former had a dispute with his friends over "removing the motorcycle" near a liquor shop in the area a day earlier. However, police said Prashant was a "habitual drinker". "On Sunday, he got into a fight with the accused, all of whom were his friends. Prashant allegedly suffered minor injuries and went to the police station, but his brother took him away," an official said.On Monday, Prashant went to Jitendra's house in an inebriated state and picked another fight with the accused. He reportedly suffered serious injuries this time and then tried to leave on his motorcycle. "He lost control of his bike near a construction site and fell unconscious. He was taken to a hospital where he was declared dead," the officer said.

Noida DM wants action plan to fix 29 black spots, background checks on school bus drivers

Noida. The Noida DM Manish Verma has directed the three development authorities to prepare an action plan to fix 29 black spots and illegal cuts across the district.

The DM, who presided over a district road safety meeting on Tuesday, also asked the transport department to carry out fitness checks of school buses and bar unfit vehicles from plying. He has also asked cops to carry out background checks of drivers and crackdown on overloaded vehicles. Noida, which reported 1,176 road crashes in 2023, saw at least 773 accidents in the first eight months of this year, which is 6.6% more than the 725 recorded in the corresponding period last year. In Sept, the city saw at least 80 crashes, several of these in the 29 black spots — road stretches that see a high number of accidents and fatalities —that have been identified by the traffic police. Some of these busy and crash-prone areas are the busy Rajnigandha Chowk, Sector 21/25 roundabout near Modi Mall, Mahamaya Flyover, GIP Mall, Hajipur underpass, Yamaha Cut in Surajpur, Sector 37, Noida Expressway zero point near Sector 168 and NH-24 zero point in Sector 58.According to officials, at least six of these black spots have been reengineered and revamped recently to reduce accidents and will be struck off the list once a joint team from the administration inspects the junctions and issues a compliance report.

Proposals to reengineer the other black spots will be reviewed in the next meeting, Verma said.

Tweaks in plan to escalate cost, GMDA wants NHAI to share funds for elevated road project

Gurgaon. GMDA has urged NHAI to share the financial burden of Hero Honda Chowk-Umang Bharadwaj Chowk stretch after changes in the redevelopment plan have led to an increase of around Rs 140 crore in the project cost. The original plan - which included the widening of the 2.2kilometre stretch and the construction of a single flyover at Umang Bharadwaj Chowk — was initially pegged at Rs 138 crore, fully funded by GMDA. The flyover with three lanes at the intersection, as proposed earlier, included three spans of 30m, 20m and 20m with ramps around 450m in each direction.

However, a revised plan now calls for a fully elevated six-lane corridor, pushing the total cost to Rs 280 crore. This difference of around Rs 140 crore is what led to GMDA proposing NHAI partially fund it. The proposal will be submitted to the state govt, which will take it up with the ministry of road transport and highways (MoRTH) for final approval, a GMDA official said."The revised plan aligns with the city's traffic demands and a fully elevated corridor will help avoid future bottlenecks. We are proposing that NHAI share the financial cost. The



proposal will be submitted to the state govt soon," a senior GMDA official said. An NHAI official, who is privy to the matter, confirmed the same, adding, it is

"working on the financial modality" of the project. The matter was also discussed during a review meeting chaired by GMDA CEO A Sreenivas on Monday. The GMDA CEO discussed the obstructions in the project and directed the officials to explore "an alternative land" for the

substation, which currently lies in the project's alignment. This project was part of a broader plan, first approved in 2017, to widen and improve the 5.6 km stretch between Hero Honda Chowk and Dwarka Expressway. While GMDA completed its work on the 3-km section between Umang Bharadwaj Chowk and Dwarka Expressway and NHAI operationalised the underpass on the expressway, the work on the 2.2-km stretch between Hero Honda Chowk and Umang Bharadwaj is

yet to take off. The project was originally financed by GMDA, while HSVP was responsible for handing over the land required for the revamp of the 2.2-km stretch.The revamp plan underwent several revisions. Initially, NHAI proposed to widen the road into six lanes with a flyover at Umang Bharadwai Chowk and the work for this was originally supposed to start in 2019.But later, it was decided that the project would be merged with the Gurugram-Pataudi-Rewari Highway, pushing the start date to Nov 2021 with a deadline of Nov 2023.Later in 2022, Gurgaon MP and Union minister Rao Inderjit Singh insisted on the construction of an elevated road between Hero Honda and Umang Bharadwaj Chowk, citing demand from RWAs and industrial associations. Subsequently, the approval of metro expansion works cast a shadow of doubt on the project.It could not be decided whether at-grade redevelopment works should be taken up; an elevated road along with a metro pillar should be constructed; or a double-decker with an elevated structure and metro on a single pier should be made.

MCG gets 71 plaints, resolves 14 on Day 1 of grievance meet

Gurgaon. On the inaugural day of the grievance redress meeting held at the MCG office, officials took up a total of 71 complaints. Of these, 14 complaints were resolved immediately at the meeting. For the remaining 57 complaints, MCG commissioner Narhari Singh Banger set deadlines for resolution. Following the govt directive, civic body offices are required to organise daily camps to address public grievances. These camps will be conducted at all four MCG offices, one in each zone, and will operate from 9am to 11am every day. The initiative aims to provide a platform for citizens to voice their concerns and have their issues resolved promptly by municipal authorities. The commissioner has directed all officials to be present daily in these meetings

Sector 51 station recorded the highest AOI at 256, followed by Teri Gram (240) and Vikas Sadan (197). No data was available at Gwalpahari monitoring station. According to the System of Air Quality and Weather Forecasting and Research (SAFAR), surface winds with speeds ranging from 4 kmph to 12 kmph are expected in the region for the next six days. The AQI is likely to deteriorate to 'very poor' in the coming days as the prevailing meteorological conditions and calm winds are unfavourable for the effective dispersion of pollutants.

According to an analysis by Climate Trends, a think tank, Haryana and Punjab recorded fluctuations in fire incidents between 2019 and 2023, with notable reductions in 2022 and 2023. The think tank's analysis of satellite data on fire incidents in Haryana showed that the fire counts dropped from 14,122 in 2019 to 7,959 in 2023, with fire activity consistently higher between Sept and Dec. While Gurgaon, Mewat, and Jhajjhar showed notable rises, Karnal and Kaithal had approximately 86% and 78% fewer cases of stubble burning, respectively. The report also stated that Delhi's air health was significantly impacted by these fire incidents. On days without fires, the city's AQI averaged 175 (moderate). However, during the same

Hry suspends 24 officials for failing to curb stubble burning

resolution camps will not only bridge Gurgaon. The Haryana govt on Tuesday suspended 24 officials over alleged failure to take adequate steps to prevent stubble burning incidents in their respective areas.

The Supreme Court in the last hearing had pulled up the Punjab and Haryana governments for not acting against those found guilty of stubble burning. It also summoned the state chief secretaries to appear before it on October 23 for an explanation. Apart from suspending these 24 agriculture department officials, the Haryana government has so far arrested 18 farmers in the Kaithal district for burning crop residue and has blacklisted around 400 farmers for stubble burning and has barred them from selling their crops at mandis for a period of two years. The arrested farmers were later let off on bail.

The officials, who have been placed under suspension, include agriculture inspectors, supervisors and agriculture development officers from nine districts -- Jind, Panipat, Hisar, Kaithal, Karnal, Fatehabad, Kurukshetra, Sonipat and Ambala. There have been over 1500 cases of stubble burning in Punjab so far this season, while this figure for Haryana is around 400 so far. "We are trying whatever we can to keep the stubble burning cases to a minimum level. We are providing resources for farmers which will prevent them from burning crop residue. The action that has been taken against the farmers as well as the agriculture department officials is because they have failed to comply with the directions of the Supreme Court," said an official. The main opposition party Congress has hit out against the BJP govt for taking such action against the farmers. "This is an anti-farmer govt and therefore it is arresting them. It just wants to put up a show in the court that it is doing something to prevent stubble burning by arresting these farmers, but in reality it has failed to prevent and find a lasting solution to this problem," said a Congress leader. Punjab said it had registered 874 FIRs and lodged 471 daily dairy reports

US elections: Harris says she's ready if Trump prematurely declares victory, isn't worried about sexism

WASHINGTON. Vice President Kamala Harris said Tuesday that her team is prepared to challenge Donald Trump if he tries to prematurely declare victory in the 2024 election—but she's first focused on beating the Republican nominee.

Harris spoke to NBC News just two weeks before Election Day, as part of a media blitz meant to deliver her closing argument before as many persuadable voters as possible. She said she was not concerned about the role sexism could play in the election, as she stands to be the first woman elected to the White House, and again defended President Joe Biden's fitness for office. Harris said the Democrats "have the resources and the expertise" should Trump try to subvert the election."This is a person, Donald Trump, who tried to undo the—a free and fair election, who still denies the will of the people, who incited a violent mob to attack the United States Capitol and some 140 law enforcement officers were attacked. Some—were killed. This is a very serious matter," she said. Trump has been criminally charged with trying to overturn the 2020 election and refuses to admit he lost to President Joe Biden.After a failed legal effort to overturn the results, a mob of Trump supporters rioted at the U.S. Capitol on Jan. 6, 2021, attacking law enforcement in an effort to stop the certification of the race.At Harris' rallies, some of her supporters chant "Lock him up," something Trump often said about his former Democratic rival, Hillary Clinton. Harris often replies: "The courts will take care of that. We'll take care of November.'

PM Modi to hold bilateral talks with Chinese President Xi on sidelines of BRICS summit

KAZAN. Prime Minister Narendra Modi and Chinese President Xi Jinping will hold a bilateral meeting on the sidelines of the BRICS summit here on Wednesday, Foreign Secretary Vikram Misri said.

"I can confirm that there will be a bilateral meeting between Prime Minister Modi and Chinese President Jinping tomorrow," Misri said at a media briefing. The meeting follows the announcement by India on Monday that both countries had reached an agreement on resolving their standoff in eastern Ladakh.

"Over the last several weeks, Indian and Chinese diplomatic and military negotiators have been in close contact with each other in a variety of forums. As a result of these discussions, an agreement has been made for patrolling arrangements along the LAC leading to disengagement and a resolution of the issues that had arisen in these areas in 2020. We will be taking the next steps on this," said Misri on Monday, ahead of PM Modi leaving for Kazan.

China on Tuesday confirmed that a deal had been reached."Over a recent period of time, China and India have kept close communication through diplomatic and military channels on issues related to the China-India border," Chinese Foreign Ministry spokesman Lin Jian told a media briefing in Beijing. Now, the two sides have reached a resolution on the 'relevant matters', he said. He added that China will work with India to implement it but declined to provide details. Confirming Sinwar's death, Hamas official Khalil al-Hayya said in a video statement on October 18 that the militant group was mourning the loss of its "great


Trudeau's Ministers Junked RCMP Embargo, **Gave Classified** Information On India To **Washington Post**

Ottawa, Canada Despite the Royal Canadian Mounted Police (RCMP) putting an embargo on publicly announcing sensitive information pertaining to India, Canadian Prime Minister Justin Trudeau's national security adviser and deputy foreign minister went ahead and leaked classified information to US-based newspaper the Washington Post.

Canadian newspaper The Globe and Mail, who first reported the development, also said that actions of Trudeau's top national security and intelligence adviser, and David Morrison, deputy minister at Global Affairs (Canadian counterpart of the Indian ministry of external affairs), are in contrast to how Trudeau said he feels about leaks of classified information. Trudeau had earlier criticized the leaking of classified information about China's interference to The Globe and Mail,

calling that leak "a criminal act". But the leak in India's case, where the Trudeau government cast aspersions that Indian government was involved in homicides in Canada, did not spark any reaction from Trudeau, even in front of the foreign interference committee where he gave a testimonial last week.

Overton Pounder hardware in 10 Quarter Pounder hamburgers in 10 states, led by Colorado, where 26 people were sickened, the US Centers for Disease Control said on

The E. coli outbreak, linked to one of McDonald's most popular menu items, has sickened 49 people and sent 10 to the hospital, officials say. The strain involved, E. coli O157:H7, can cause serious illness and was the source of a 1993 outbreak that killed four children who ate undercooked hamburgers at Jack in the Box restaurants.

Shares of the world's largest fast-food chain were down about 6% in extended trading. A livestock trader said the outbreak also could pressure US cattle futures on Wednesday by threatening demand for beef. Everyone interviewed as part of an investigation into the outbreak has reported eating at McDonald's before their illness started, and most mentioned eating

the illness has not been identified but investigators are focused on fresh, slivered onions and fresh beef patties, the CDC said.Most of the illnesses were reported in Colorado and Nebraska."The initial findings from the investigation indicate that a subset of illnesses may be

Quarter Pounder and sourced by a single supplier that serves three distribution centers," McDonald's North America Chief Supply Chain Officer Cesar Piña said in a statement.McDonald's has proactively removed the slivered onions and beef patties used for the Ouarter Pounder hamburgers from stores in the affected states while the investigation continues, the company informed the CDC.US food safety attorney Bill Marler, who represented a victim in the Jack in the Box outbreak, said more

McDonald's is temporarily removing the Quarter Pounder from restaurants in the impacted areas, including Colorado, Kansas, Utah and Wyoming, it said in a statement, adding it was working with suppliers to replenish supply in the coming week.Symptoms for E. coli include severe s t o m a c h c r a m p s, diarrhoea and vomiting. Most people who suffer an infection will start feeling sick three to four days after sick three to four days after eating or drinking something that contains the bacteria, Colorado's public health department said. However, illnesses can start anywhere from

one to 10 days after exposure, the department added.In 2015, burrito chain Chipotle saw its sales battered and reputation hit due to E.coli outbreaks in several states. That outbreak was linked to a different strain of E. coli that typically causes less severe illness than E. coli O157:H7.In addition to Colorado, the CDC said small clusters of a few people fell ill after eating a Quarter Pounder in Nebraska, Utah and Wyoming. Kansas, Missouri, Oregon, Iowa, Wisconsin and Montana had one illness apiece.

Why Hasina's missing letter is fuelling a storm in Bangladesh

World After the Prime Minister, it is the President of Bangladesh who's in the eye of the storm. Fresh protests have broken out against President Mohammed Shahabuddin, with angry protesters storming the presidential palace and seeking his removal. The new crisis in Bangladesh is over former Prime Minister Sheikh Hasina's resignation letter, or the non-existence of it. The Sheikh Hasina regime was toppled by weeks of protests and bloodshed across Bangladesh and the killing of over 300 people. Hasina was forced to flee Bangladesh on August 5 as hundreds of thousands of protesters marched towards her official residence, Ganabhaban. Hasina managed to escape in the nick of time as the mob later ransacked Ganabhaban. She wanted to record a farewell speech but with the sea of protesters fast approaching Ganabhaban, the army gave her 45 minutes to pack up and leave Bangladesh to save her life.

Those last moments are what have fuelled the latest frenzy. According to reports, Sheikh Hasina, along with her younger sister Rehana, arrived at the helipad at the Tejgaon Air Base, adjoining her official residence. Some of her belongings were loaded onboard. It was reported that she then went to Bangabhobon, the President's house, where she tendered her formal resignation to President Mohammed Shahabuddin.But there is no resignation letter, at least not that President Shahabuddin knows of. That's what Shahabuddin said in an interview with Janatar Chokh. He said that he had only heard that Hasina had resigned, but had no evidence of her resignation."I tried

[to collect the resignation letter] many times but failed. Maybe she did not have the time." Shahabuddin told Janatar Chokh.

WHY IS SHEIKH HASINA'S RESIGNATION LETTER IMPORTANT

Why Hasina's resignation letter is important is because it legitimises the caretaker government headed by Muhammad Yunus. Otherwise, the government would be likened to being an illegitimate one that grabbed power amid a power vacuum in Bangladesh. Those critical of the government have already started questioning it over Hasina's missing resignation letter."Sheikh Hasina did not resign from her prime Minister post, and she is still alive. Therefore, the Yunus government is illegal," said exiled

Bangladeshi writer Taslima Nasreen. It could take 350 years to rebuild Gaza if it

remains under Israeli blockade: UN report World United Nations agencies have long warned that it could take decades to rebuild Gaza after Israel's offensive against Hamas, one of the deadliest and most destructive military campaigns since World War II.Now, more than a year into the war, a new report speaks in terms of centuries. The UN Conference on Trade and Development said in a report released Monday that if the war ends tomorrow and Gaza returns to the status quo before Hamas' Oct. 7, 2023, attack on Israel, it could take 350 years for its battered economy to return to its precarious prewar level. Before the war, Gaza was under an Israeli and Egyptian blockade imposed after Hamas seized power in 2007. Four previous wars and divisions between Hamas and the Western-backed Palestinian Authority in the West Bank also took a toll on Gaza's economy. The current war has caused staggering destruction across the territory, with entire neighbourhoods obliterated and roads and critical infrastructure in ruins. Mountains of rubble laced with decomposing bodies and unexploded ordnance would have to be cleared before

rebuilding could begin."Once a ceasefire



is reached, a return to the pre-October 2023 status quo would not put Gaza on the path needed for recovery and sustainable development," the report said."If the 2007–2022 growth trend returns, with an average growth rate of 0.4 percent, it will take Gaza 350 years just to restore the GDP levels of 2022."

Even then, GDP per capita would decline "continuously and precipitously" as the population grows, it said. Israel says the blockade is needed to prevent Hamas from importing arms and blames the militant group for Gaza's plight."There is no future for the people of Gaza as long as their people continue to be occupied by Hamas," Israel's ambassador to the UN,

Danny Danon, said in response to the report.350 years is more of a calculation than a predictionThree hundred and fifty years is a long time. It would be as though England and the Netherlands were only now recovering from the wars they fought against each other in the late 1600s.Rami Alazzeh, author of the report, said he based the calculation on the decimation of the economy during the first seven months

of the war and how long it would take to restore it at the GDP growth rate Gaza averaged from 2007 until 2022. Gross domestic product, or GDP, is the sum total of all goods and services produced in a country or territory."The message is the recovery in Gaza depends on the conditions in which the recovery would happen," he said."We're not saying that it will take Gaza 350 years to recover because that means that Gaza will never recover."At the end of January, the World Bank estimated \$18.5 billion of damage nearly the combined economic output of the West Bank and Gaza in 2022. Bangladesh tense as protesters storm President's residence, seek his resignation

World Bangladesh is witnessing renewed tensions after hundreds of protesters stormed Bangabhaban, or the President's residence, in Dhaka on Tuesday night, demanding the removal of President Mohammed Shahabuddin for "lying" about deposed Prime Minister Sheikh Hasina's resignation in August. The renewed protests came months after the political crisis in August ended Sheikh Hasina's 16-year reign and prompted her to flee to India. Last week, President Shahabuddin told a local newspaper that he did not have any evidence of Sheikh Hasina's resignation on August 5 and had only heard about it." I tried (to collect the resignation letter) many times but failed. Maybe she did not have the time," he said.

However, in an address to the public on the night of August 5, Shahabuddin said: "You know Prime Minister Sheikh Hasina has tendered her resignation letter to the president and I have received it."On Monday, Asif Nazrul, the Law Affairs Adviser, said the President 'lied" and his remarks were "tantamount to violation of his oath of office", adding that there was a constitutional provision to remove him from office.

According to Bangladeshi media outlets, the protests began on Tuesday evening with protesters marching towards Bangabhaban. As more people joined the demonstration, the police resorted to firing stun grenades in a bid to disperse the crowd.But the protesters marched ahead, leading to clashes with law enforcement

The Daily Star newspaper said that at least five people, including two journalists, were injured, while the police used tear gas and batons against the protesters.Late Tuesday night, Hasnat Abdullah and Sarjis Alam -- two of the most prominent figures of the Anti-discrimination campaign to oust Sheikh Hasina -- arrived at the protest site and requested the demonstrators to leave, The Daily Star reported. While Hasnat assured of talking to political parties to choose a new President by Thursday, Sarjis said that if no one was appointed by the deadline, they would also "join you in the streets"

The two student leaders also laid a five-point demand, including the scrapping of Bangladesh's 1972 Constitution."Our first point (of the fivepoint demand) is immediate scrapping of the 'pro-Mujb (Bangladesh's founding leader) 1972 Constitution' which kept Chuppu (president's nickname) in office," PTI news agency quoted Hasnat as saying. "The (1972) Constitution will have to be replaced by writing a new one against the backdrop of 2024 mass upheaval."

Hashem Safieddine, Hasan Nasrallah's likely heir, is dead: Israeli military

Tel Aviv/Jerusalem/Cairo, Israel on Tuesday confirmed it had killed Hashem Safieddine, the heir apparent to Hezbollah leader Hassan Nasrallah who was previously killed in an Israeli attack last month on the Iran-backed Lebanese militant group. The military said Safieddine was killed in a strike carried out three weeks ago in Beirut's southern suburbs, its first confirmation of his death. Earlier this month, Israel said he had probably been eliminated. There was no immediate response from Hezbollah to Israel's statement that it had killed Safieddine.Israel has been carrying out an escalating offensive after a year of border clashes with Hezbollah, which is reeling from a spate of killings of its senior commanders in Israeli airstrikes. The group is the most formidably armed of Iran's proxy forces across the Middle East and has been acting in support of Palestinian militants fighting Israel in Gaza.

A relative of Nasrallah, Safieddine was appointed to its Jihad Council - the body responsible for its military operations - and to its executive council, overseeing Hezbollah's financial and administrative affairs. Safieddine assumed a prominent role speaking for Hezbollah during the last year of hostilities with Israel, addressing funerals and other events that Nasrallah had long been unable to attend for security reasons.

Israeli strikes have been pummelling Lebanon's south, eastern Bekaa Valley and southern suburbs of Beirut - all Hezbollah strongholds. The group's fighters have been trying to push back Israeli ground incursions. Israel has so far shown no sign of relenting in its Gaza and Lebanon campaigns even after assassinating several leaders of Hamas and



Hezbollah, which lost Nasrallah, its powerful secretary-general, in a September 27 airstrike.Diplomats say Israel aims to lock in a strong position before a new US administration takes over following the November 5 election between Vice President Kamala Harris and former President Donald Trump.

BLINKEN ON MIDEAST TOUR

Israel's confirmation of Safieddine's death came as US Secretary of State Antony Blinken pressed Israeli Prime Minister Benjamin Netanyahu on Tuesday to capitalise on the killing of Hamas' leader Yahya Sinwar by securing the release of the October 7 attack hostages and ending the war in Gaza. After repeated abortive attempts to broker a ceasefire between Israel and Hamas, Blinken was making his 11th trip to the Middle East since the Gaza war erupted - and the last before a presidential election that could upend US policy.

Blinken was also seeking ways to defuse the conflict between Israel and Hezbollah in Lebanon, where overnight at least 18 people

were killed, including four children, and 60 injured by an Israeli airstrike near Beirut's main state hospital.Blinken faced an uphill struggle on both fronts.He spelt out US hopes that the death of Hamas leader Sinwar - blamed for triggering a year of devastating warfare by planning the deadly militant assault from Gaza on Israeli territory on October 7 last year - will provide a new opportunity for peace."The Secretary underscored the need to capitalise on Israel's successful action to bring Yahya Sinwar to justice by securing the release of all hostages and ending the conflict in Gaza in a way that provides lasting security for Israelis and Palestinians alike," the US State Department said in a statement on the Jerusalem meetings. In a statement issued by his office, Netanyahu said Sinwar's elimination "may have a positive effect on the return of the hostages, the achievement of all the goals of the war, and the day after the war".

But there was no mention of a possible ceasefire after a year of war in which Hamas military capabilities have been greatly degraded and Gaza largely reduced to rubble with most of its 2.3 million Palestinians

World South Korea has issued a stern warning, suggesting it may provide weapons to Ukraine, in response to reports that North Korea has allegedly sent troops to support Russia in its ongoing conflict. This move is aimed at pressuring Russia to avoid involving North Korean forces in its war against Ukraine.South Korean officials have condemned the alleged deployment of North Korean troops as a "grave security threat" to both South Korea and the international community, describing North Korea as a "criminal group" that forces its youth to serve as mercenaries in Russia's unjustifiable war, as reported by Associated Press.The situation remains tense, with both Russia and North Korea denying the allegations. Ukrainian President Volodymyr Zelenskyy has claimed that 10,000 North Korean troops are being prepared to join Russian forces .South Korea's concern is that Russia may reward North Korea with advanced weapons technology, enhancing its nuclear and missile capabilities, and directly threatening South Korea's security. HYDERABAD. A 23-year-old woman died after allegedly falling from the DSL Mall, Ramanthapur main road, Uppal, on Tuesday.

The deceased, Pinnapati Haritha, a resident of Tukaram Gate, used to work as a customer relations executive at Client Service Solutions. She would go to work around 5 pm and usually return home after her duty the next morning at 4 am.

According to the first information report (FIR), the father of the deceased stated that he got a call from her daughter's colleague on Tuesday around 2 am informing him that she had fallen from the building. The police said Haritha fell from the 11th floor of the mall.

Meanwhile, Haritha was rushed to a nearby private hospital where she was declared dead. A case under Section 194 (death under suspicious circumstances) of the Bharatiya Nagarik Suraksha Sanhita (BNSS) was registered at the Uppal police station. Further investigation is underway, said the police.

Road rage: Police give clean chit to mayor, MLA

THIRUVANANTHAPURAM. The Cantonment police, in its report on the road rage incident in Palayam, have said that it could not be confirmed that Thiruvananthapuram Mayor Arya Rajendran and her husband, Balussery MLA Sachin Dev, committed the offences alleged by the KSRTC driver.

The police filed the report on Tuesday before the Judicial First Class Magistrate (JFMC), following up on a complaint filed by driver H L Yedu. Sources said the police did not arrest the mayor and her husband for lack of confirmation of the alleged offences. The police said the allegation that the MLA trespassed into the bus was not true and it was Yedu who himself opened the hydraulic door after which the legislator entered the bus. Also, the witnesses did not testify the mayor and her husband used foul language against Yedu, the police report said.

However, the police said it managed to identify the fourth and fifth accused, who allegedly took part in the offence committed against Yedu, and a mahasar of the car which the mayor used at the time was prepared.

The report also said the CCTV footage of the incident - which happened in front of the Saphalyam Complex at Palayam - were recovered. The case will now be considered on October 29. Yedu had approached the court seeking a court-monitored probe on the case against the mayor, her husband, and three others.

The police were reluctant to register the case initially but were finally forced to do so after the magistrate's court intervened. Yedu sought judicial intervention alleging that the cops were not carrying out the probe seriously. When the case was considered on October 10, the police did not present its report. Yedu's counsel said it was because of the strong intervention of the court that the police prepared the report and filed it within 12 days. The road rage incident involving the mayor and Yedu took place on April 27.

The mayor, along with her husband and the copassengers in the car, blocked the bus and entered into a heated dispute with Yedu, alleging that he had made obscene gestures at her from his driving seat. Though Yedu was the first to lodge a complaint, the police registered a case of sexual harassment against Yedu based on the mayor's complaint.

PURI. Puri beach wore a deserted look on Tuesday as most of the tourists left the pilgrim town and headed towards safety in wake of the impending cyclone Dana.

Secretary of Puri hotel association Rajkishore Patra said with tourists abandoning their holiday plans, the hoteliers have landed in a tight spot as they have to return the money against cancellation of bookings.

'After the cyclone warning, new arrival of

tourists is negligible while those who booked for week-long stays are trying to return. Long queues of tourists are being witnessed at railway booking counters for return tickets. The general occupancy has dropped below 20 per cent," Patra rued. On the day, lifeguards and volunteers were seen advising the remaining handful of tourists not to enter the sea. The district administration also put up red flags on the beach to warn

tourists against bathing in the sea. Fishermen too were asked not to venture into the sea. The Archaeological Survey of India (ASI) ordered closure of the Sun temple at Konark and the museum ahead of the cyclone.

Heavy-duty pumps have been kept ready to drain out water from the Sun temple premises.District fire officer Pravat Kumar Rout said a mock drill was conducted on cyclone preparedness on the day. "We have kept 65 cutter machines including plasma, concrete and hydraulic cutters to clear trees and electricity poles from the roads after the cyclone. Electricity staff are also ready to restore power supply at the earliest,"

The administration has opened a control room to monitor the relief and rescue operations.

The Fire Service department has formed 18 teams to deal with the post-cyclone situation. Emergency lighting systems have been kept in reserve. Government officials have asked to remain alert at their places of duty.

When clouds burst and lakes overflow in Yelahanka

Residents of 10 layouts in Yelahanka marooned without food, electricity NDRF, SDRF ferry citizens to safety as apartments flood City gets 23.6mm rain

BENGALURU. A cloudburst over Yelahanka doubled the misery of residents on Tuesday. Already soaked to the bone by incessant rain over the past inundated. Thousands of residents of 10 layouts and surrounding areas were left marooned, without food, electricity and even internet connection.

Surrounded by water from all directions, National Disaster Response Force (NDRF) and State Disaster Response Force (SDRF) swung into action, deploying rescue personnel and boats to ferry citizens to safety.

Each downpour has brought a fresh nightmare, filling up lakes in Yelahanka and flooding the localities. The Met department recorded 157mm in Chowdeshwari Nagar, 141mm in Yelahanka, 109mm in Vidyaranyapura, 98mm in Jakkur, and 81.5mm in



people had to be rescued in boats. The About 3,000 residents of Kendriya Vihar Apartments (KVA), which is affected during every rain, were stranded as the basement was completely flooded, submerging parked vehicles. At least 26 dinghies were pressed into service to evacuate residents.

Due to heavy rain which filled up 10 lakes, 4,000 homes in the area have been impacted. Kendriya Vihar Apartments were severely impacted, and we have deployed boats," BBMP Chief Commissioner Tushar Girinath said. Food, milk and water was supplied to people, and

Kiran, a resident of Sarovara Layout in Byatarayanapura, said, "From Monday midnight, all residents are awake and inconvenienced. We don't know for how many years we have to face this ordeal

Evacuation from low-lying areas in Balasore, Mayurbhanj on focus

Balasore collector Suryawanshi Mayur Vikas said necessary measures have been taken to face the impeding cyclone. The government machinery has been readied in vulnerable areas for evacuation of people.

At least 144 cyclone shelters and 728 temporary shelters have been readied for people who will be evacuated from the low-lying areas. The district administration has decided to start the evacuation drive from Thursday, he said.

District emergency officer Sai Krushna Jena said three teams of National Disaster Response Force (NDRF) and eight teams of Odisha Disaster Rapid Action Force (ODRAF) are ready to deal with the emergencies arising out of the situation. All the officials concerned have also been put on alert and asked to keep a close watch on vulnerable areas.

Similarly in Mayurbhanj, the district administration has geared up machinery to tackle the cyclone threat. On Tuesday, Housing and Urban Development minister Krushna Chandra Mahapatra reviewed the administration's cyclone preparedness in presence of Mayurbhanj collector Hema Kant Say, SP Varun Guntupalli and other officials.

Lack of heavy duty dewatering pumps challenge for BMC ahead of Cyclone Dana

The BMC may seek commissioning of some of these pumps in localities vulnerable to severe waterlogging.

BHUBANESWAR. With the Bhubaneswar Municipal Corporation (BMC) identifying 80 locations vulnerable to waterlogging ahead of Cyclone Dana, shortage of heavy duty pumps for dewatering may emerge as a challenge for the civic body in dealing with the crisis.

Sources said the civic body has identified eight more cyclone shelters in addition to 72 others, for rescue of people belonging to low-lying and vulnerable localities. At least 30 of these localities including Jayadev Vihar, Iskcon road, Tankapani road, Jagannath Nagar, ITER area and Chintamaniswar face severe waterlogging and urban deluge during heavy rainfall due to encroachment of natural storm water

channels and poor drainage system in the city. A senior official from the Fire Services department said heavy duty pumps of around 1,000 to 1,600 litre per minute (LMP) are needed for immediate dewatering of flooded areas. But sources



such pumps while the remaining 32 have lesser capacity. This lack of adequate heavy duty pumps has, meanwhile, posed a challenge for the BMC in tackling possible waterlogging situations that may arise after the cyclone considering the IMD forecast of heavy rainfall in the state. in the BMC said the civic body has four BMC officials, however, said they are well-

prepared to deal with the situation and if need arises, they will seek help of the fire services for commissioning of large pumps in the vulnerable localities of the city. Sources said the Fire Services department in the city has 28 dewatering pumps including 20 heavy duty pumps. The BMC may seek commissioning of some of these pumps in localities vulnerable to severe waterlogging. Meanwhile, keeping in view the

Dealing with China: Why India should rethink strategy

Signage or pictographic characters of the Mandarin language, the psyche of the Communist dictator as well as actions on the ground by China's highly "controlled state" must be linked together to understand, analyse, anticipate and then deal with the Sons of Heaven, eternally ensconced in the Forbidden City — Beijing.Let's face it, the Communist Party of China (CPC), founded by Mao Zedong, is no run-of-the-mill 1648 Treaty of Westphalia-origin nation state or the so-called model democracy of the West. Since 1949, the CPC is the People's Republic of China (PRC) and the PRC is the CPC. And the primary instrument of the party-state or the state-party is the People's Liberation Army (PLA). All other organs are either subservient to the Communist High Command or owe their influence to the hereditary connect with the CPC. Hence, the imperial tradition of the Chinese Emperor who insisted on the supremacy of the Han, has been continued by the Communist dictator these past several decades. A Communist in name only, the dictator of the CPC state has not even changed the official name of the country, Zhong Guo (Middle Kingdom). Mao was the king, so is his successor Xi Jinping, who claims to be the reincarnation of Mao. However, Xi's task is more than what Mao dealt with — a backward, poverty-stricken and famine-afflicted country, in which he chased his utopian projects of the Great Leap Forward, followed by a demonic Cultural Revolution from the 1950s to 1960s. Xi, however, cannot afford to do the same, being Deng Xiaoping's successor, with a legacy to make China number one in the world. China has to feed, finance and fulfil the desire of her 1.5 billion people so that the dictatorship can maintain its pomp, power, prestige and position. However, the CPC must constantly do something out of the box to keep outsiders as well as all non-Chinese, especially India, on tenterhooks, by creating chaos, confusion and confrontation all the time.

And that's exactly what the world is facing now, in the form of the BRI (the Belt and Road Initiative), CPEC (China-Pakistan Economic Corridor), RCEP (Regional Comprehensive Economic Partnership), and a host of other China-sponsored projects that bear the Chinese brand of imperialism in an effort to influence and imperil five targeted continents — Asia's landlocked terrain and the waterways surrounding Beijing; Africa's mineral and agriculture belts; ports of South America, Europe, South Asia and Australia's raw material and consumer market.

Interestingly, India, since the beginning, has been a steady and standout target of China, whether it is Tibet, territory, trade, terror and now telecom, transport, technology domination as well as its billion-plus consumer market. Moreover, the dragon dictator Mao would feel uncomfortable when compared to Pandit Jawaharlal Nehru, who was much more widely known, acceptable and affable and democratic. Mao, on the other hand was often seen as a Communist warlord.

Unfortunately, over the past 75 years India's political leaders and diplomats have never effectively read the mind of the CPC dictator. Successive Indian leaders have offered him an olive branch, their efforts often ending in a fiasco.

What was a mere border and territorial issue of a common Himalayan frontier between India and Tibet for hundreds of years, has become a boundary issue between Bharat and Beijing. Territory expansion has been one of the core issues of the dictator. The CPC's psyche needs to be analysed because China will never accept India as an equal sovereign, just like the West has never recognised Russia as a European state, as was stated by then German naval chief in February 2022 in New Delhi. Of course, the German navy chief was sacked the moment he reached home for making such a politically incorrect statement.

For India, China is a multidimensional threat today in every possible area — economy, politics, commerce, industry, telecommunication, frontier issues, terror and diplomatic ties.

Why Punjab alone can't be blamed for stubble burning

Scientists, policy-makers and the government must engage with farmer leaders and come out with mutually acceptable solutions.

Come October and there is an outcry over the ensuing paddy-straw burning and the consequent air pollution in the national capital region (NCR) and its adjoining areas. Paradoxically, it has been a usual

phenomenon for the past couple of years. Earlier, only Punjab used to be blamed for polluting the NCR's air quality. It was conveniently forgotten that the Commission for Air Quality Management in National Capital Region and Adjoining Areas Act, 2021, mandates the commission to monitor and manage the air quality in NCR besides Punjab, Haryana, Uttar Pradesh and Rajasthan.

However, the CAQM has failed to carry out its mandate as is clear from the rapping it received by the Supreme Court on September 27, 2024. The SC Bench

comprising Justice Abhay S Oka and Justice Augustine George Masih said, "Not a single committee has been formed to tackle the issue. Every year, we witness stubble burning, indicating total non-compliance of the CAQM Act." The Bench further said that the CAQM has been merely a silent spectator. Such an observation by the top court is a serious reflection on politico-bureaucratic will and vision regarding policymakig and implementation thereof.

Significantly, this year, Prime Minister's Office (PMO) has also taken a serious note of the recurring phenomenon of stubble burning. Principal Secretary to PM, PK Mishra, while chairing a high-level meeting of task force on air pollution, asked the Delhi-NCR and the states of Punjab, Haryana and UP to implement the anti-stubble burning plans as committed. According to CAQM chairman Rajesh Verma, over 1.5 lakh crop residue management (CRM) machines will be available in Punjab and 90,945 in Haryana. It is learnt that ever since 2018, when the Central Government started providing subsidy to purchase CRM machines, Punjab has been supplied 1,38,022 machines between 2018 and 2023. The target is to provide 36,020 additional machines in 2024. These machines are aimed at insitu incorporation of the paddy straw. Punjab generated 19.52 million metric tonnes (MMT) of paddy straw while Haryana produced 8.10 MMT, out of which a lion's share is to be managed by insitu incorporation as per the target. The past experience, however, shows otherwise. The

fundamental question is that why has there been no it. satisfactory solution to paddy-straw burning and the The launch of the National Hydrogen Mission by consequent air pollution? Apparently, deep-rooted reasons behind the problem, knowingly or



unknowingly, are not being addressed by the powers that be. It is being alleged that the in-situ incorporation of the paddy straw is mainly being enforced under the pressure of the machinery and fertiliser lobbies, though agricultural scientists and the government are arguing that it is necessary for maintaining soil fertility. Why, do then, farmers prefer to burn crop residue over the in-situ incorporation, knowing fully well its ill-effects on the soil as well as human health? Is it due to additional cost-component and the small-window period between the paddy harvesting and wheat sowing, as is being argued by the farmers?

Scientists and economists also argue that production of compressed biogas (CBG) from crop residue and solid waste can be a game changer, as it would translate waste into wealth. Besides addressing the air pollution, it would also generate enormous amount of renewable clean-energy as well as employment and income for the farmers and the government in the form of GST. Its by-product, namely bio-manure, would meet the organic matter need of the soil, besides lowering the use of chemical fertilisers. Significantly, a number of countries, especially Scandinavian countries, are already using such energy in the transportation sector.Generating hydrogen energy from crop and solid waste is another potent alternative. The developed countries are already investing heavily in hydrogen technology and infrastructure, and many of them have set huge targets to produce hydrogen as a source of energy. Japan has already taken a lead in

India in 2023 is an indicator that hydrogen will become a major future source of energy in the face of

> limited stocks of conventional sources. There may be a number of other options, including biomass pellets, which can convert agricultural and solid waste into renewable energy, besides being environment-friendly and an alternative to the fossil fuel. There is, thus, a need to have an informed public and scientific discourse on all available options of using agricultural and solid waste, which could be sustainable and environmentally friendly. This will also be in tune with the UN-2030 Sustainable Development Goals.

Such a discourse is, however, missing and hence there is no comprehensive policy to use crop residue and solid waste as a source of energy as well as addressing environmental issues. Such an approach would also help the policy makers and the government to understand the phenomenon better and provide practical solutions. The farmers' unions, too, must come forward with their genuine concerns and viable solutions rather than stubbornly supporting stubble burning and opposing alternative uses of crop residue. Scientists, policy-makers and the government must engage with farmer leaders to address their apprehensions and perceptions about the ill effects of alternative uses of agri-stubble and come out with mutually acceptable solutions.

The national and state agriculture policies then must include these agreed upon solutions. Such an approach would help in the effective implementation of the policy. The SC Bench might be having such a policy approach in mind while advising the CAQM for formulating the relevant committees to understand the issue in its entirety and come out with viable policies and a roadmap.

It needs to be understood that management of crop residue and solid waste is not an option but a necessary choice as currently it is causing a huge burden on environment, health, law and order and judicial system. Besides, it is demonising the farmers which could have serious politicoeconomic implications. All this necessitates a comprehensive, cost-benefit analysis of the existing machine-based CRM and all other available options keeping in mind the huge financial burden.

Ganderbal shocker

Central, UT govts must go all out to

THE euphoria over the peaceful conduct of the Assembly elections and the installation of an elected government in Jammu and Kashmir has unfortunately proved to be short-lived. The Ganderbal terror attack, which claimed the lives of a doctor and six labourers at a tunnel construction site, leaves no room for doubt that Pakistan will persist with its nefarious policy of bleeding India — and J&K in particular — with a thousand cuts. It's no less worrisome that this attack took place jus days after External Affairs Minister S Jaishankar had an informal interaction with his Pakistani counterpart Ishaq Dar on the sidelines of the Shanghai Cooperation Organisation summit in Islamabad.

New Delhi has repeatedly made it clear that talks cannot be resumed unless Islamabad/Rawalpindi turns off the terror tap. But it is no coincidence that the terror attack has taken place in Ganderbal, the constituency of J&K's new Chief Minister



Omar Abdullah. Clearly, Pakistan-backed terror groups are sending the unmistakable message — after targeting the Jammu region in recent months — that the remarkably

peaceful polls in the UT could not have taken place without the Pakistan military establishment's tacit agreement. The terror groups are now turning the spotlight back on Kashmir. The attempt to disrupt an infrastructure project is aimed not just at stalling development in the Valley and scaring away migrant labourers and tourists who have a crucial role in boosting J&K's economy, it is also to demonstrate that no one in Kashmir is fully safe. That's why Central and UT governments need to work in tandem to restore peace and normalcy.

Clearly, Pakistan's army chief, Gen Asim Munir, has a second message to his own government, in response to former PM Nawaz Sharif telling visiting Indian journalists last week, "We have lost the last 75 years and it is important we don't

lose the next 75." Which is, that hosting an Indian foreign minister on Pakistani soil is all very well, but the Army cannot be kept out of any conversation with India.

Intel agencies need parliamentary oversight

In stark contrast, intelligence organisations around the world have a solid legal footing

The government's answers in Parliament pertaining to the legal basis of intelligence agencies were intriguing, if not enigmatic. With regard to the Intelligence Bureau (IB), it stated: "The Intelligence Bureau figures in Schedule 7 of the Constitution under the Union List." When pressed that possibly this may not be the correct answer, the government unequivocally reiterated: "The Intelligence Bureau finds mention at Serial Number 8 in the Union List under the Seventh Schedule of the Constitution.'

Entry 8 in the Union List merely gives the legislative power to enact a statute to bring a Central Bureau of Intelligence, to be called by whatever name (IB or BI), into existence. The mere mention of a subject in the list of legislative powers neither gives an organisation statutory life or legal legitimacy. Had the legislative initiative I had proposed 13 years ago fructified into a law, the unnecessary and avoidable embarrassment that India is being subjected to today with regard to allegations by the governments of Canada and US, could have been very well avoided. We could have argued, and rightly so, that we have a comprehensive, holistic and vigorous external oversight mechanism at the apex level of our national legislature, that is more than competent to exercise 'broad superintendence' over our intelligence structures. Any wild cards or loose cannons could have been effectively proscribed.

In response to a question pertaining to the legal underpinnings of India's external intelligence service, the Research and Analysis Wing (R&AW), the government did not befuddle. It candidly admitted, "There is no separate/specific statute governing the functions/mandate of the R&AW." However, in 2000, following the report of the Task Force on Intelligence Apparatus, which examined the entire intelligence system in the country, "a formal charter listing the scope and mandate of the R&AW was formally approved by the government of India".In stark contrast, intelligence organisations around the world have a solid legal footing and in most cases are subject to penetrating parliamentary oversight that, if the need arises, goes into operational aspects also in closed-door sessions.

The Central Intelligence Agency (CIA) of the United States, created by the National Security Act of 1947, was specifically empowered by the Central Intelligence Agency Act of 1949 to carry out the duties assigned to it by the 1947 Act. The House and Senate intelligence committees in the US are regularly and extensively briefed by the American intelligence ecosystem consisting of 18 organisations, including the military intelligence programme.MI5, the domestic intelligence service of the United Kingdom, draws its legal authority from The Security Services Act, 1989, and its sister organisation, MI6 or the SIS, from the 1994 Intelligence Services Act, thereby subjecting its activities to the scrutiny of the British Parliament's Intelligence and Security Committee. The Australian intelligence agencies are regulated by the Intelligence Services Act of 2001 and they are accountable to the Parliamentary Joint Committee on Intelligence and Security. The Canadian intelligence services are regulated by the Canadian Security and Intelligence Services Act, 1984, and superintended by the National Security and Intelligence Committee of Parliamentarians. In New Zealand, the Intelligence and Security Act of 2017 is the ground norm and the activities of the intelligence services are subject to monitoring by the Parliamentary Intelligence and Security Committee. These are the Five Eyes. The Foreign Intelligence Service of Russia



draws its legal basis from the Law on Foreign Intelligence Organs, 1996. Nominal parliamentary control is exercised under Article 24 of the law. The German Federal Intelligence Service, Bundesnachrichtendienst, draws its legal sustenance from the Federal Intelligence Service Law, 1990, as amended in 2016. Its activities are supervised by the Parliamentary Control Commission for intelligence services which, in turn, is empowered by the Act on the Parliamentary Control of Intelligence Activities, 1978, as amended on July 29, 2009.

In Japan, the Public Security Intelligence Agency, which after its reorganisation in 1996 started focusing on foreign intelligence collection, is empowered by the Subversive Activities Prevention Law that came into force on July 21, 1952. The

Cabinet Intelligence and Research Office is another intelligence agency mandated under the cabinet law. Oversight is exercised by the Japanese Parliament

Diet through the Board of Oversight and Review of Specially Designated Secrets. All this led to a sustained exercise over a period of two years in collaboration with the Observer Research Foundation, wherein a cross-section of stakeholders were extensively consulted to try and conceptualise a law to put the IB, the R&AW and the National Technical Research Organisation on a proper legal footing. There was broad support for the need of such a law within the retired echelons of the intelligence community. There were a few sceptics also. On August 5, 2011, I moved the Bill in the Lok Sabha.

This Bill aimed to regulate the functioning and the exercise of powers of Indian intelligence agencies within and beyond the territory of India and provide for coordination, control and oversight over such agencies. The proposed oversight is robust parliamentary supervision by a Parliamentary Committee consisting of the Rajya Sabha Chairman, Lok Sabha Speaker, Prime Minister, Minister of Home Affairs, Leader of the Opposition in the Lok Sabha and the Rajya Sabha, one member each from both Houses to be nominated by the presiding officers of the respective Houses as members. This is as responsible a slate of people that you can get in a parliamentary democracy, though it is still heavily loaded in favour of the government if you look at the current cast of eminences.

There was a buzz around the Bill after it was introduced in the Lok Sabha, but the proposed legislation lapsed when I became a minister in 2012.

There are many places to visit in Matheran, such as Sunset Point, Sunrise Point, Louisa Point, Echo Point and Honeymoon Point. Also popular are Charlotte Lake, King George Point, One Tree Hill Point, Alexander Point and Panorama Point that compel you to appreciate nature even more. Hand-pulled rickshaws and horses are used as modes of transportation inside the town. One man quoted INR 600 (negotiable) for a horse for 3 hours for around 10-15 sightseeing points. We thought of not doing things in a hurry and hence decided to walk on foot so that we can closely interact with the place. Horses are a good option if you are in Matheran just for a day or you want to visit some place too far with a steep hike. Mainly old people are seen availing the facility of hand-pulled rickshaws.

How to reach

Mumbai is the nearest metro city to Matheran. You can take a local train till Neral (don't get confused with Nerul—another station in Mumbai—as the two are very far from each other). After reaching Neral, you can either opt for a toy train or a shared taxi to reach Matheran. Both these options cost almost the same (INR 70), but with a trade-off between an enjoyable experience and time. Toy train takes almost 2.5 hours while halting at various small stations. It provides a closer view of varying landscapes on one side and mountains on the other. On the other hand, taxi takes a maximum of 20 minutes to reach the town. I enjoyed the experience of toy train while going to Matheran, and decided to save time by taking taxi while heading back to Mumbai. A compulsory tax of INR 50 is levied on every visitor, and it has to be paid while entering the town.

Panorama Point

Panorama Point is the most exciting and the farthest viewpoint in Matheran. It is almost 7.5 km away from the marketplace. Taking a horse is probably the best. Another option is to take a toy train from the marketplace to the next station, but you will be required to walk at least 2 km. Horse ride takes 45-60 minutes to transport you from your hotel to this fairyland. The path is little bit rocky and hence, your back might start hurting after a while, but it's an unforgettable odyssey-you go through the forest hearing singing birds, breeze and horse's clip-clop, while having occasional glimpses of varying landscapes. The views from Panorama Point are incredibly stunning and beyond my words. This point offers a 360-degree view of Matheran and surrounding areas. You can also spot Sunset Point from here. Being remotely located, this point is even more secluded than Honeymoon Point. You can lie down in the lap of nature and thank god for introducing you to this heaven on earth. This place is also a good picnic spot and a photographer's paradise. One can click multiple panoramic pictures here without any intervention. Spend some time admiring some mesmerising views, while inhaling fresh air that is a rarity in cities. Panorama Point also serves as a good sunrise and sunset point. People often trek to this place from their hotel at dawn to see the sunrise. Don't forget to carry your Matheran's entry ticket along as you'll re-enter the town after returning from Panorama Point. Alexander Point

Alexander Point is almost 1.5 km from the marketplace (a 20-minute walk), and is easy to reach in terms of distance, navigation and slope. It's a very pleasant walk from one's hotel to this point as you walk through woods, on a very narrow path over red soil, interacting with green trees. The peak offers good views of other points of the region and the valley below. I will call this point as a bigger version of Sunrise Point (Khandala Point) because it gives the same view as Sunrise Point, but comparatively has ample space. No doubt that it is more crowded as compared to other places because it's quite close to the toy train station. Alexander Point has some snack stalls that serve fresh juice, soda and Maharashtrian snacks to satiate your hunger. During the peak season, there is zip-lining option available from here to Rambaug Point, costing INR 350-500 per head. I am very cautious about the safety measures taken by adventure sports organisers. I saw a few Europeans doing it and they told me that Matheran's zip-lining is quite safe as compared to a few popular tourist destinations in Europe.

One Tree Hill Point

One Tree Hill Point is almost 4 km away from the marketplace, taking around an hour to walk up to this place. It's better to take a horse or a hand-pulled rickshaw. This point is named as One Tree Hill Point because a tree stands right on the top of the peak, and there is no other vegetation around except some grass. This beauty is at its best in the monsoon season. Some other tourist group told us that this is the southernmost tip of Matheran. The view from this peak is really spectacular as you can see Karjat, Mumbai-Pune highway,

Panvel city, Chowk village and a few other vantage points of Matheran. To get the best view of this peak, walk all the way to the edge and then only you'll be able to notice that why this point is called One Tree Hill. There is a trekking path from Ambewadi to One Tree Hill Point, which is pretty easy and can be done by beginners also. It takes almost 3.5 hours to climb up and 2.5 hours to descend. I'll advise to avoid this trek during monsoons or hire a

Matheran

King George Point

King George Point is almost 2.7 km (a 40minute walk) from the marketplace. It takes around 10 minutes to walk here from Charlotte Lake. Many people say that it's a sin to go to Matheran and come back without visiting this vantage point. The sight from this peak is really majestic as it offers a picturesque view of the lake and waterfalls, and a large valley surrounded by three hills. The view is mesmerising and nature lovers can definitely sit here for hours. People prefer to come here in groups in the evening, take a walk, watch the sunset and enjoy baked corn with a cup of ginger tea. Sounds amazing, isn't it!

Charlotte Lake

Charlotte Lake is almost 2.5 km away from the marketplace, which is approximately a 35minute walk. Although the walk is a bit tiring, the breathtaking view and cold breeze take away all the fatigue. There is a little waterfall near the lake which is a treat for the eyes during monsoons. During other seasons, either it is dry or the water is too less. Clear lake water, green backdrop and flawless waterfall look amazing. For a moment, you would certainly think of owning a house at a place that would offer such view. Lake area has got amazing birdlife and we got to know this when we met some passionate bird photographers here. Some people also like to visit Pisarnath Temple, which is situated to the left of the lake. You should stay here to watch the sunset because it looks stunning when the red-golden light reflects on the water. Locals told us that this lake supplies drinking water to Matheran and hence, swimming, fishing and boating are strictly prohibited. Any activity that tends to contaminate the lake water is banned. Nonetheless, it is a good picnic spot; just make sure that you don't leave any wrapper or garbage behind. It can be quite a hike while going back to your hotel, so if you are tired, take a horse or hand-pulled rickshaw.

Honeymoon Point

Honeymoon Point is very tranquil and offers a wonderful view of Matheran's splendid mountains. From here, one can see Prabal Fort, various valleys accommodating civilisations and a beautiful sky that changes colours at dusk. The view of mountains from Honeymoon Point is such that you would call them 'Indian Grand Canyon'. There is no factual explanation as to why this point has been named Honeymoon Point. I brainstormed and came up with a few reasons. One hypothesis says that this place is a little secluded because you actually need to cross some bushes to reach here. Second is that it offers a romantic view. Both facts are good enough to name this peak as Honeymoon Point. My group spent perfect 30 minutes of mindfulness hearing nothing but the sound of air and leaves, which left us rejuvenated. It was like meditation. Not many people visit this point, so you spend undisturbed moments lying down and gazing at the sky while talking to your partner. Some people even enjoy picnicking here. Make sure that you carry your trash with you and dispose off in a dustbin. This

point is very close to Louisa Point and Echo Point; and similar to them, it is a very good subject to be captured through lens as it is rarely crowded. Hence, it gives the freedom to amateur photographers to experiment with different angles and lenses to capture a variety of pictures and improve their skill.

Echo Point

Echo Point lies in the vicinity of Louisa Point, which can be seen from here. As the name suggests, you hear your screams and yells echo at this peak. High-pitched kids are a common sight here. We even saw adults going crazy to hear their voice back. We got to know about it when a group of almost 20 screaming people captured my attention. Funny, isn't it?

The vantage point offers the best view of the Western Ghats and is very crowded during daytime. So, it's advisable to visit here early in the morning. One of the best experiences we had here was crossing the valley by zip-lining. Mostly, zip-lining is offered by

some local tour operators during the peak tourist season. There are a few stalls here that offer a variety of local food like vada pay and kandha poha, along with bottled water and soda. So, it's good to relax here for a while and admire nature in its full glory.

Louisa Point

Louisa Point is almost 1.5 km away from the marketplace and will take around 20 minutes to reach here on foot. If it's a clear sunny day, this place will offer you breathtaking views that will

This is a unique point in Matheran as it offers two different picturesque views. From one point, you can see the sky touching the mountains and a civilisation located far in a valley. If you visit during monsoon, you'll also be captivated by waterfalls. Another view is of Lake Charlotte that looks like a diamond necklace when seen from here. Louisa Point also offers a clear view of Prabal Fort. All these different views are intriguing and one can spend hours gazing at them. We sat there, soaked in the beauty of the place and relishing moments of silence.

This place is known as a photographer's paradise in Matheran because it offers panoramic views of mountains, peaks, valleys, lake and waterfalls. In most of the travel portals, blogs and magazines, Matheran has been represented by using Louisa Point's pictures. During the peak season, photo points are a little crowded and sometimes you need to be patient for your view to be 'people free', but all your waiting time is worth those beautiful, dreamy and wallpaper pictures. Some people also stay at Louisa Point to watch the

Sunrise Point

Sunrise Point, also known as Khandala Point, is located alongside the marketplace. This place is serene in the morning as very few people are able to make it to the sunrise. Sitting here quietly works wonders as you hear the chirping of birds, sound of breeze striking against trees and music composed by tree leaves. Our ancestors used to say that when you see a rising sun, it gives you tremendous energy. Sun rising above glorious mountains with golden reddish sky forming the backdrop unquestionably make for a beautiful sight and give you positive energy. I did yoga at sunrise for 20 minutes and definitely felt very energetic that day as compared to other days where I follow a different lifestyle. It's 5-15 minutes' walk from the marketplace, depending on the location of your hotel. Ask some local person or the receptionist of your hotel about sunrise time for the next day, before you go to bed at night. Sunrise time mentioned on the internet



can be wrong sometimes and you obviously don't want to miss this sight. Videos recorded at sunrise are just perfect and can be used in any of your travel videos. I ended up with a shaky sunrise video because my view was obstructed by other photo enthusiasts and hands started trembling after a couple of minutes. So, I recommend taking your tripod along, if you intend to record the sunrise. While heading back to your hotel after seeing the sunrise, I would propose to indulge your taste buds in lip-smacking breakfast that has kandha poha and jalebi.

"Abetting Crime": Centre Blasts 'X' After 100 Flight Bomb Threats In A Week

New Delhi: Amid a barrage of bomb threats received by airlines over the past few days, the Union Ministry of Electronics and IT today blasted social media platform X (formerly Twitter) through which many of these hoaxes were circulated.

Joint Secretary Sanket S Bhondve chaired a virtual meeting with representatives of airlines and social media platforms such as X and Meta. The official said that the situation amounts to "X abetting crime" and questioned its

representatives on the steps taken to stop such alarming rumours from spreading, sources have said. More than 120 flights operated by Indian carriers have received bomb threats over the past few days. Even yesterday, 30 flights operated by IndiGo, Vistara and Air India received such threats. The airlines said they followed standard operating procedures: authorities were alerted and security protocols were followed.During a briefing on the



situation on Monday, Civil Aviation Minister K Rammohan Naidu said the government is trying to tackle it without compromising passengers' safety. He added that those circulating such hoax threats will face tough action, including being put on a no-fly list. The government plans to amend the Suppression of Unlawful Acts against Safety of Civil Aviation Act so that action could be initiated for offences when an aircraft is on the ground. largely cover in-flight offences.

We are trying to make amendments and the legal team has worked on it... We need consultations with other ministries also... we are definitively pushing forward to have changes in the Act also so that it addresses offences that happen when the flight is on the ground and also make it cognizable offence," he said. Muslim men can register more than one marriage, rules Bombay High Court

The court was hearing an application filed by a Muslim man who sought to register his third marriage with a woman from Algeria in February 2023.

New Delhi: The Bombay High Court has ruled that Muslim men can register more than one marriage as their personal laws entitle them to have four wives at a time. The court was hearing an application filed by a Muslim man who sought to register his third marriage with a woman from Algeria in February 2023 but was rejected on grounds of a marriage act in Maharashtra.

The Thane Municipal Corporation refused to issue the couple their marriage certificate on the basis that under the Maharashtra Regulation of Marriage Bureaus and Registration of Marriage Act, the definition of marriage contemplates only a single marriage and not multiple unions. During



the hearing on October 15, a High Court bench comprising Justices BP Colabawalla and Somasekhar Sundareshan termed the authority's refusal as "wholly misconceived" and said the Act does not bar Muslim men from registering more than one marriage since the same is permitted under Muslim personal law.

"Under the personal laws for Muslims, they are entitled to have four wives at a time. Once this is the case, we are unable to accept the submission of the authorities that, under the provisions of the Maharashtra Regulation of Marriage Bureaus and Registration of Marriages Act, only one marriage can be registered, even in the case of a Muslim male," it said."There is absolutely nothing in this Act to indicate that the personal laws of Muslims have been excluded."The bench also highlighted that the Thane Municipal Corporation had registered the petitioner's marriage with his second wife. The couple was asked to submit all relevant documents within two weeks after the municipal body claimed that they had not them while trying to register their marriage.

The court said that once the docuents were submitted, the municipal body would have 10 days to either issue a marriage certificate or refuse following a personal hearing. Until then, no coercive steps should be taken against the petitioner woman whose passport expired in May

Not Oil, This Tanker In Bihar Has 200 **Boxes Of Alcohol Hidden Inside**

New Delhi: An oil tanker was found carrying liquor in Bihar, officials said on Wednesday. About 200 beer crates were found in the Hindustan petroleum tanker and brought to the excise police station. The Nagalandregistered tanker was seized from Muzaffarpur while the smugglers fled.Officials said the excise department had received a tip about the liquor consignment, after which they formed a team to arrest the smugglers. The officials set up a road blockade, seeing which the smugglers turned the tanker towards a national highway.



'After being chased, the driver and the liquor trader left the tanker on the national highway and fled," said Vijay Shekhar Dubey, Assistant Excise

The seized liquor was made in Arunachal Pradesh. The local trader who had smuggled in the liquor is being identified and raids are on to arrest him, the official said, adding that a case has been registered against him.

The sale of liquor is banned in Bihar, due to which people resort to innovative ways to source alcohol. Smugglers often come up with new ways to transport liquor sometimes in ambulances and trucks. There have been instances where smugglers have built compartments inside petrol tanks to store liquor bottles.

"Mere Eyewash": Supreme Court Raps Punjab, Haryana Over Stubble Burning

New Delhi: The Supreme Court grilled the central - and Punjab and Haryana - governments on Wednesday as arguments over states' non-compliance with, and failure to enforce, anti-pollution measures, rolled into yet another hearing, even as air quality in Delhi and the national capital region remains 'very poor' and prompts concern over the risk of increased respiratory diseases.

A bench of Justice Abhay S Oka, Justice A Amanullah, and Justice AG Masih, dismissed as "mere eyewash" the Punjab and Haryana governments' efforts to stamp out farm fires - i.e., farmers burning agricultural waste - that contribute to toxic air smothering Delhi annually. The state governments were questioned over the lack of



prosecution, or even imposition of commensurate financial penalties, of farmers violating the law, and, in the case of Haryana, even suggested the failure to enforce was a "policy devised by you" to favour some farmers over others.

The top court also rapped the union government over "toothless" environmental protection laws, observing that laws meant to control pollution, specifically the Commission for Air Quality Management (CAQM) Act of 2021 had been passed sans the administrative machinery to ensure implementation. It was also pointed out that Section 15 of the Environmental Protection Actwhich covers penalties for violating anti-pollution laws had amended so "procedure for imposing penalty cannot be followed". Section 15 was the "only section for enforcing the EPA", it was pointed out, to which Additional Solicitor General Aishwarya Bhati, appearing for the centre, said it would be "fully operationalised" in 10 days. Not A Single Prosecution...'

Punjab was the first to feel the court's wrath, with Justice Oka doubting its claim that 44 people had been prosecuted. "Your Advocate-General said nothing was done..." the court told senior advocate Abhishek Singhvi, appearing for the Punjab government, "... not a single prosecution."The court was told that 11 lakh had been recovered, as fines, from 417 people violating the stubble burning laws, but declared itself unhappy at the "nominal" amounts charged.

Secularism means live and let live, says Supreme Court in Madrasa Act case

New Delhi: The Supreme Court of India has reserved its judgement on the challenge to the striking down of the Uttar Pradesh Board of Madarsa Education Act, 2004 by the Allahabad High Court. The court emphasised that "secularism means to live and let live," highlighting the importance of accommodating diverse religious instruction in education. During the hearing, the High Court noted that the education provided under the Madarsa Education Act, 2004 is "certainly not equivalent" to that in other state-

recognized educational institutions, raising concerns about the quality and universality of madrasa education.Chief Justice DY Chandrachud, leading the three-judge bench, remarked, "Ultimately, we have to see it through the broad sweep of the country-religious instructions are there in Hindus, Sikhs, Christians, etc. The country ought to be a melting pot of



bathwater." Justice JB Pardiwala addressed arguments made by senior advocate Gurukrishna Kumar, stating, "The study of religion is therefore not prohibited by the Constitution, and this is where your argument that they are being deprived of mainstream education fails."Kumar argued that the madrasa syllabus primarily consists of theological studies, stating, "What is provided as syllabus and course cultures, civilisations, and religions." 

Rediscovering the wonders of Pune



Heritage and history have always been a part of the city's charm. Over the next few days, we will showcase what we believe to be our city's 15 wonders. We have also organised visits to some of these heritage destinations.

Nana Wada

History: The Nana Wada, built in 1780, adopting Gothic structures, used to be the home of Nanasaheb Phadnavis, an influential minister and statesman of the Maratha empire during the Peshwa administration. This wada is a large sixquadrangled, perimeter-protected construction. Back then, the Krishna river used to flow beside the Nana Wada, which had steps leading to the river. The Nana Wada has been a preferred location for many Bollywood filmmakers to shoot their movies. Mrityudand, Goonj Uthi Shehnai, Jis Desh Me Ganga Rehata Hai, and Swades are a just a few such examples.

To see: Among the things to look out for are the few temples behind the Nana Wada that have beautiful Peshwai pictures on their walls. Another interesting thing is a huge bell housed in the temple premises which was won by the Peshwas in the war of Vasai in 1707 against the British. Nana Wada can be visited from 11 am to 6 pm daily.

University of Pune

History: The main building of the University of Pune was made in 1864. During the British Raj, it was the official residence of the governor of Bombay and postindependence, the building was restored for academic and official purposes.

Inspired by Prince Albert Osborne's house on the Isle of Wight, it was built at a cost of around 1,75,000 Sterling Pound, which was nearly six times the amount raised by the sale of the previous Governor's residence.

To see: A little ahead of the building is a small pond, with a stone prison right in the middle of it. During the British era, crocodiles were kept in the pond that surrounded the prisoners in their cells. The University can be visited between 8 am-6 pm with prior

History: Located at a height of 2,100

Parvati

feet above sea level, Parvati is one of the highest points in the city and gives an excellent panoramic bird's eye view of Pune. The Parvati houses a temple complex and one needs to climb and a total of 103 steps to reach the top. The main temple was built by Shrimant Nana Saheb Peshwa in 1749 and was visited by the Prince of Wales, Albert Edward, during his visit to India in 1875. Apart from its historical importance, it is also a hot favourite among fitness enthusiasts, who come here daily for their morning and evening walks.

To see: Other than the temple, the complex also has a museum housing artefacts from the Peshwa period. The Parvati gates are open for the general public from 5.00 am to 8.00 pm.

Its cobbled streets, beautiful monuments, streets filled with music and art and charming old square make it a wonderful option for an enchanting history rich getaway.

New Delhi Benchmark stock market indices opened the trading session on a positive note on Wednesday despite volatility keeping Dalal Street investors on the edge.

The S&P BSE Sensex was up 162.52 points to 80,383.24 at 9:57 am, while the NSE Nifty50 rose 46.45 points to trade at 24,518.55.Most other broader market indices were also trading in the green, but with marginal gains. This shows that investors are trading cautiously amid volatility. The Nifty IT index was among the top gainers among sectoral indices, while Nifty Bank and Nifty Financial Services also rose.Bajaj Finance, Bajaj Finserv, Bajaj-Auto, HDFC Bank, and Adani Enterprises were the top five gainers on the Nifty50. On the other hand, the top losers were NTPC, Power Grid, M&M, Eicher Motors and Sun Pharma.Bajaj Finserv and Bajaj Finser rose after the latter reported its Q2FY25 results a day ago. Zomato shares also rose nearly 2% after the company reported strong results in the second quarter. Paytm shares also jumped nearly 5% after reporting a net profit in Q2.Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, "The ongoing trend of largecaps outperforming mid and smallcaps is likely to sustain, going forward. FII selling and the countervailing trend of DII buying is likely to continue." This will impart strength to largecap financials, particularly banking stocks like HDFC, ICICI, Axis and Kotak which are fairly valued in that market with elevated valuations. Investors need not rush to buy the beaten down mid and smallcaps since there is more pain left in this segment where valuations continue to remain very high," he added. "There can be individual cases of sharp rebounds in this segment. Zomato's Q2 results indicate continuing acceleration in revenue and profitability. This is a stock to watch."

SC sets aside NCLAT order stopping insolvency proceedings against ed-tech firm Byju's

NEW DELHI. The Supreme Court on Wednesday set aside the National Company Law Appellate Tribunal's verdict that had stopped insolvency proceedings against embattled ed-tech firm Byju's. A bench headed by Chief Justice DY Chandrachud also reversed the order of the NCLAT approving Byju's Rs 158.9 crore dues settlement with the Board of Control for Cricket in India (BCCI). It directed the cricket board to deposit the (BCCI).It directed the cricket board to deposit the settlement amount of Rs 158.9 crore with a committee of creditors. The bench, also comprising justices J B Pardiwala and Manoj Misra, delivered its verdict on an appeal by US firm Glas Trust Company LLC against the NCLAT order.

Observing that the NCLAT did not apply its mind while closing that the NCLAI did not apply its mind while closing the insolvency proceedings against the ed-tech major, the bench ordered fresh adjudication in the case. The NCLAT, on August 2, granted relief to the embattled ed-tech firm by setting aside the insolvency proceedings against it after approving its Rs 158.9 crore dues settlement with the BCCI.

The NCLAT verdict had come as a huge relief for Byju's, as it had effectively put its founder, Byju Raveendran, back in control of the company's finances and operations. However, the relief remained short-lived as the top court, on August 14, termed the NLAT verdict "unconscionable."It also stayed the operation of the NCLAT order while issuing notices to Byju's and others on the appeal of Glas Trust Company LLC, the ed-tech firm's US-based creditor, against the judgement of the insolvency appellate tribunal.

Increased retail presence in derivatives a matter of concern: Sebi official

India accounts for largest volume of F&O globally, more than 50% of F&O volumes globally are done in India.

Sebi Wholetime Member Ashwani Bhatia on Tuesday warned against the increased retail participation in the derivative segment (futures & options) and other risky products. "While it is encouraging to see increase of retail investors in securities market, increased retail participation in derivative segment and other risky products is a matter of concern," Bhatia said. Close to 93 per cent, or 9 out of 10 individual traders, in the equity F&O segment incurred losses, with aggregate loss exceeding Rs 1.8 lakh crore between FY2022 and FY2024, Sebi data shows.India accounts for largest volume of F&O globally, more than 50%

"This crown is worn by India, and this is a crown we do not wish to wear," Bhatia said while speaking at the Morningstar Investment Conference.F&O cannot be a national pastime, we need to do serious investing and investors should participate in wealth that is being created in the country through pooled vehicles like mutual funds or directly," he said.Sebi had recently released a set of six measures to strengthen

According to G20 Sherpa Amitabh Kant, with structural reforms, India has become far more efficient economy, without leakages, and with a strong digital infrastructure which no other country in the world has. "India has pursued a very different model versus

other Western nations. In India we have created a digital layer on top of which we have allowed the private sector to compete, everyone is competing in the marketplace and huge innovation is taking place," Kant said. The Bank of International Settlement has said what India has achieved in the last 7 years, it would have normally taken India 50 years had it not been for what we have achieved in digital infrastructure, Kant said.

India remains the largest growing economy in the world, a senior official from the International Monetary Fund said, observing that the country's macroeconomic fundamentals are good."India is said to remain the largest growing economy in the world. Inflation is expected to decline to 4.4 percent in FY24-25, despite some volatility as food prices normalise," Krishna Srinivasan, Director for the IMF Asia Pacific Department, told PTI in an interview on Tuesday. In terms of other fundamentals, he said, "despite elections, the fiscal consolidation remains on track. Reserve position is pretty good. Mamentals, generally speaking, for India are good."e suggested that the country's reform priorities post-eacro fundlections need to be in three areas."One is, there's an issue about creating jobs in India and so on In that context. The company's order book, executable over the next 12 months, now stands at \$1.3 billion, reflecting a strong 40% year-on-year increase.CEO Sudhir Singh commented on the results, expressing optimism for continued growth, driven by a robust pipeline of large deals and a stronger order



book. He also highlighted the successful integration of Cigniti, which has outperformed expectations in terms of synergies and margin expansion.Coforge's workforce grew significantly, increasing by 5,871 employees to a total of 32,483. We don't see any need for tariff hikes now," said Robert Ravi,



Chairman and Managing Director of BSNL. The statement holds significance as all private telecom operators, including Reliance Jio, Bharti Airtel and Vodafone Idea, collectively raised their mobile plan tariffs by up to 25%. Following this tariff hike, telcos lost subscribers substantially, with many users switching to BSNL. Notably, BSNL increased its subscriber base for the first time in recent years.

Authority of India (TRAI), Bharti Airtel lost 1.69 million subscribers, Vodafone Idea 1.4 million and Jio lost 758,463 subscribers. shares was driven by mixed brokerage insights, despite an overall bullish outlook on the stock.

ZOMATO SHARE PRICE TARGET

Brokerage firm Nuvama has raised its target price to Rs 325 (from Rs 285) and maintained a 'buy' rating. They pointed out that Blinkit's dark store expansion is progressing faster than expected, although profitability may be delayed due to higher initial costs. Nuvama believes this aggressive approach is necessary for maintaining Zomato's competitiveness in the quick-commerce sector.HSBC also holds a positive outlook, maintaining a 'buy' rating with a target price of Rs 330. The brokerage said that while Zomato's food delivery business met expectations, Blinkit exceeded projections. They see Zomato's recent fundraising efforts as

crucial for staying ahead in a competitive

Nomura has raised its target price from Rs 280 to Rs 320, reiterating a 'buy' recommendation. They highlighted Zomato's focus on quick-commerce growth, especially through Blinkit, and expect a neutral EBITDA in the near term.Despite some concerns about profitability in the near term, Zomato remains well-positioned in both the food delivery and quick-commerce markets, with several brokerages forecasting strong growth and improved margins over the next few years.

Zomato's stock recovery and strong Q2FY25 results indicate positive momentum, backed by a growing quickcommerce business and sustained food delivery margins.

While some analysts remain utious due to competitive pressures, the majority of brokerages maintain a bullish outlook, forecasting significant upside in the stock price. Investors should weigh both the long-term potential and short-term challenges as Zomato continues to navigate a highly competitive landscape.

And not because of the three goals but because of his character; he's extraordinary," Ancelotti said. d'Or, that's for sure. He is a player who gets whistled at because he can make a difference.

While Head had set the record back in the 2021-22 Marsh Cup while representing South Australia in their match against Queensland, Tamil Nadu's Jagadeesan equalled the record against Arunachal Pradesh in the Vijay Hazare Trophy 2022.Playing in his 100th List A match, Bowes scored 205 runs off 110 balls with the help of 27 fours and seven sixes at the Hagley Oval in Christchurch. On the back of his knock, Canterbury scored 343 for the loss of nine wickets after being asked to bat first.



Matthew Bacon, who picked up a five-wicket haul, dismissed Bowes in the 39th over.

So far, Rahul has played 132 IPL matches, amassing 4,683 runs with a strike rate of 134.61, including four centuries and 37 fifties. Despite his strong track record, the franchise seems prepared to move on and explore other options. While Rahul is expected to be released, the franchise is reportedly keen on retaining three key players: pace sensation Mayank Yadav, legspinner Ravi Bishnoi, and West Indies' wicketkeeper-batter Nicholas Pooran.Mayank Yadav, who has emerged as a valuable asset for LSG, is set to be retained at a significant price. Yadav's raw pace,

which often clocks over 155 kmph, has left opposition batters struggling. Although he only played four matches in the 2024 season before being sidelined by injury, he impressed with seven wickets, including notable performances against the likes of Cameron Green. Following his T20I debut for India against Bangladesh, Mayank's value has skyrocketed, and LSG is expected

to keep him for around Rs 11 to Rs 14 crore. Leg-spinne Ravi Bishnoi, another young talent, is also on LSG's retention list. The former world No. 1 T20I bowler had a relatively quiet season in 2024, taking 10 wickets in 14 matches, but his potential and previous success make him a vital part of LSG's plans. Bishnoi is set to receive a significant pay raise, having previously earned Rs 4 crore as an uncapped player. Nicholas Pooran, who served as the team's stand-in captain during one match in the previous edition, is also likely to be retained. The West Indian wicketkeeperbatter played a crucial role in the middle order and provided much-needed stability with the bat. LSG is reportedly prepared to retain Pooran at a hefty price, reflecting his value to the team.
