

PM Modi Launches C-295 Aircraft Facility In Gujarat

Vadodara, Oct. 28: Prime Minister Narendra Modi yesterday jointly inaugurated the TATA Aircraft Complex for manufacturing C-295 aircraft with his Spanish counterpart Pedro Sanchez in Gujarat's Vadodara. A total of 56 aircraft are there under the C- 295 programme of which 16 are being delivered directly by the aircraft manufacturing company Airbus from Spain, and the remaining 40 will be built at the facility, which is the first private sector Final Assembly Line (FAL) for military aircraft in India. It will involve the full development of a complete ecosystem from the manufacture to assembly, test and qualification, to delivery and maintenance of the complete lifecycle of the aircraft. The Ministry of Defence in 2021 signed a Rs 21,935-crore contract with Airbus Defense and Space SA, Spain for the supply of 56 aircraft. Speaking at the inauguration ceremony, PM Modi said the aircraft manufactured at the Vadodara facility will also be exported in the future. "The Tata-Airbus manufacturing facility will strengthen the India-Spain relations and the 'Make in India, Make for the World' mission," PM Modi, who laid the foundation stone of the



October 2022, said. He also paid tribute to former Tata Sons chairman Ratan Tata, who is said to be the brains behind the project. Mr Tata died

New Delhi, Oct 28: The much-delayed decadal census exercise and the work to update the National Population Register (NPR) are likely to begin early 2025 and the data will be declared by 2026, thus changing future census cycles completely, official sources said. However, no decision has been taken yet on whether caste census will also be carried out along with the general census. The country's population count has been conducted every 10 years since 1951, but the census work in 2021 could not be carried out due to the COVID-19 pandemic. So far, no formal announcement has been made on its next schedule. "In all probability, the work for the census and the NPR will begin early next year and the population data will be announced by 2026. With this, the census cycle is likely to be changed. So, it will be 2025-2035 and then 2035-2045 and so on in future," sources privy to the thinking

of the government said. The Office of the General and Census Registrar Commissioner had prepared 31 questions to be asked to the citizens during the census exercise. These questions include

"The government has not yet taken any decision on caste census," a source said. It is to be seen whether the government will go ahead with the delimitation exercise,

year 2026 have been published, it shall not be necessary to readjust the allocation of seats in the House of the People to the States as readjusted on the basis of the 1971 census". It means if census is conducted in 2025 and data published in 2026, delimitation exercise cannot be carried out based on 2025 census data. If it happens, then the Article 82 has to be amended. "All these factors will have to look into before any decision is taken on delimitation," a sources said. The 31 questions to be asked to each family under the census exercise include the total number of persons normally residing in the household, whether the head of the household is a woman, the number of dwelling rooms exclusively in possession of the household, the number of married couple(s) living in the household among others. The questions also include whether a family has telephone, internet connection, mobile or smartphone, bicycle, scooter or motorcycle or moped, and whether they own a car, jeep or a van.

Disposal of stale 'aravana' progressing at Sabarimala

PATHANAMTHITTA: The stockpile of stale 'aravana' at the Sabarimala Ayyappa Temple, totalling 6.65 lakh cans, is being moved out to be disposed of scientifically. According to Travancore Devaswom Board (TDB) president P S Prasanth, the cans are being transported from the hill shrine using tractors and trailer trucks, amounting to around 300 tractor-loads of material.TDB officials have been present in Pamba since Saturday to speed up the process and to overview the preparedness ahead of the main pilgrimage season, he said. A Rs 1.16-crore contract for the disposal of 'aravana' has been given to the Indian Centrifuge Engineering Solutions. 'Aravana', made with rice and jaggery, is one of the major sources of income for the hill shrine. The cans will be transported to Ettumanur, where they will be checked by the TDB officials.

Subsequently, the material will be sent to Hyderabad to be dried and processed into animal feed and manure.Prepared for the 2022-23 pilgrimage season, the 'aravana' that has gone stale was worth Rs 5.5 crore. Its sale has been restrained by a Kerala High Court order which was issued after the Government Analyst's Laboratory and the Spices Board Laboratory found that the cardamom used in the preparation contained pesticide levels above the permissible limit. Though there was another verdict from the apex court favouring the use of the 'aravana', by then, it had already decayed.

Congress wary of dissidents playing spoilsport in Chelakkara

THIRUVANANTHAPURAM: A section within the Congress camp is apprehensive of their own party workers' votes going in favour of the BJP candidate in Chelakkara. But a senior Congress leader told TNIE that still there is apprehension about grassroots-level leaders showing their displeasure against Ramya when Chelakkara goes to polls on November 13."It's been more than a week since the candidature has been announced. Still the party is being berated on Ramya and Rahul's candidature. The issue with Ramya started ahead of the Alathur Lok Sabha election which saw her tasting defeat. Now the party's top brass has issued a strict directive to work united in Chelakkara and Palakkad. Maharashtra tiger relocated to Odisha's Similipal Tiger Reserve to boost big cat gene pool

BHUBANESWAR: Odisha on Sunday set the ball rolling for the ambitious tiger relocation project in Similipal landscape with arrival of the first big cat from Maharashtra."The female tiger has been brought from Tadoba-Andhari Tiger Reserve (TATR). The translocation project to supplement the existing tiger population in Similipal Tiger Reserve (STR) is a significant step towards conservation of big cats in Odisha," said Forest and Environment minister Ganesh Ram Singhkhuntia. After being tranquillised on Saturday, the big cat from TATR travelled around 900 km in a special transport vehicle to reach Similipal. Two teams comprising officials and staff of Similipal and members of rapid response team escorted the vehicle. Sources said the tiger was supposed to be brought by October 23. However, the plan was delayed due to multiple reasons including cyclone Dana. "The tiger will remain in observation for the night. It will be soft-released to the special enclosure created in the core area of the tiger reserve on Monday," said PCCF (wildlife)



Susanta Nanda. Nanda, also the Chief Wildlife Warden, said the two-hectare enclosure in the core of Similipal south division and free from any kind of human intervention, will be the place where the big cat will be kept for next one to two weeks before being released into the tiger

During its stay in the enclosure, the female tiger will be radio-collared for monitoring its movement. A six-member team comprising forest frontline staff of Similipal and a GIS expert have undergone training at Nawegaon-Nagzira Tiger Reserve (NNTR) in Maharashtra to track the radio-collar and assist STR

authorities in monitoring activities. The translocation is considered significant as it is the first big cat relocation project in the state since suspension of a similar programme between Odisha and Madhya Pradesh in 2019.Forest officials said following the approval of the National Tiger Conservation Authority (NTCA), the Maharashtra government agreed to give two female tigers from TATR to Odisha for the big cat supplementation programme in

The second female tiger will also be brought from TATR soon. The Forest department has also received nod from the NTCA to introduce three more tigers, two male and a female, in Debrigarh Wildlife Sanctuary from Madhya Pradesh and Maharashtra.

The state has also got green signal to resume the suspended tiger relocation programme in Satkosia subject to compliance to certain conditions including voluntary relocation of villages, creation of more inviolate space

Amrabad Tiger Reserve in Telangana to be a human-free zone

HYDERABAD: The state government is taking measures to transform the Amrabad Tiger Reserve into a human-free area soon. As part of this initiative, the government has begun the process of relocating villages within the reserve and in a significant first step, residents of four villages have agreed to relocate. The Amrabad Tiger Reserve covers a total area of 2,611.39 sq.km, with 2,166.37 sq.km designated as the core area. Surrounding forest areas, spanning 445.02 sq.km, constitute the buffer zone.

Within the core area, there are 45 villages classified as critical tiger habitat. Currently, four villages—Sarlapally, Kudichintala Bailu, Thatigundal Penta and Kollampenta-are proposed for voluntary relocation. These villagers have lived in the core area for the past 75 years. Out of 417 families, with a population of 956



individuals, 310 families are non-tribals and 107 are tribals. The state government has identified a relocation site in Bacharam Forest Block, outside the Amrabad Tiger Reserve in Nagarkurnool district. The Hyderabad-based NGO, Hyderabad Tiger Conservation Society, is assisting the villagers in the relocation process. To support this process, the government plans to provide Rs 15 lakh per family and provide houses through the Indiramma Housing Scheme. The estimated cost for relocating these four villages is Rs 62.55 crore.

Odisha government fixes hefty penalty for release of vehicles seized in illegal mining cases

BHUBANESWAR: The state government release of vehicles, equipment and excavators seized for illegal extraction or transportation of minor minerals in consonance with the guidelines of the National Green Tribunal (NGT). As per a recent notification issued by the Steel and Mines department, the highest penalty of Rs 4 lakh will be imposed for release of vehicles/equipment/excavators with showroom value of more than Rs 25 lakh and less than five-year-old. The seized minor minerals will be released after realisation of the penalty amount as stipulated. The realisation cost of the seized minor minerals as per the prevailing rules will be decided taking into account the basic rate of materials stipulated in the latest schedule of rate (SOR) published by the Works department which is in force.he state government has also prepared a standard operating procedure for environmental and ecological damage for



illegal mining."The compensation towards environmental and ecological damage for illegal extraction and transportation will be recovered for the seized minor minerals. Law student spills water on senior at party, thrashed

Ghaziabad: A first-year law student was allegedly assaulted by his seniors, days after a spat at a fresher's party in a private college earlier this month. An FIR was registered against Ajay Bhati and 10 other students of Mewar Institute following a complaint by the father of Om Chaudhury, who was thrashed on Oct

According to the complaint, Om – who took admission in a BA LLB course at the college – attended the fresher's party on Oct 19. He accidentally spilled water on Bhati, his senior at the college, leading to a heated argument between them.A timely intervention by a teacher, however, stopped the tussle from escalating into a possible clash. The next day, Bhati called Om to college and asked him to apologise publicly. As he did so, Om's seniors recorded a video to circulate it among their classmates as a testimony to the public apology.

Despite the apology, Om was accosted by his seniors while he was on his way home with a friend from college. Led by Bhati, the group of 18 students allegedly abused Om outside the college gate."Bhati and the others pounced upon Om, pinned him to the ground and rained kicks and punches. They left him bleeding on the road and fled after a while," said Swatantra Singh, ACP, Indirapuram.An FIR was registered against the students under sections 191(2) (rioting), 115(2) (assault), and 351(2) (criminal intimidation) of BNS at Indirapuram police station. The students, police said, are aged between 20 and 25 years. College officials could not be reached for a comment.Bhati and the others pounced upon Om, pinned him to the ground and rained kicks and punches. They left him bleeding on the road and fled after a while," said Swatantra Singh, ACP, Indirapuram.

Garbage piles up in Greater Noida, clogged drains wait to be cleaned

Noida: Heaps of garbage and lack of sanitation have become a bane for residents of several Greater Noida sectors including Beta 1 and 2, Alpha 2, Gamma 2, Delta 2, Omicron etc."Apart from dirt accumulation in our sector, roads have not been repaired for 7 to 8 years. The sector has broken stretches at many places. Additionally, sewer overflows have become common and most of the streetlights are covered by unpruned trees," said Harinder Bhati, a resident of Sector Beta 1, Greater Noida.Bhati also said heaps of rubble can be seen across sectors Xu 1, Beta 2, Alpha 2 and Gamma 2. Also, water pressure is low and the drain on the 24-meter road has not been cleaned for a while. "Furthermore, the kerb stones have not been painted and drain covers are missing at many locations," said

While Subhash Bhati complained abou the unkempt main road of Sector Alpha 2, Ashish Sharma from Sector Gamma 2 spoke about damaged green spaces, traffic snarls. Alok Nagar, vice president of Greater Noida Federation of RWAs said, "The situation has exacerbated due to the negligence of the officials of Greater Noida Authority and the recurrent strike of sanitation workers. The result is heaps of garbage everywhere."Nagar, who is also the RWA general secretary of Sector Delta 2, said the situation has worsened to the point where garbage piles are visible everywhere. Nagar goes on, "While residents across the city are engaged in extensive cleaning of their homes and distributing sweets ahead of Diwali, significant garbage and dirt is accumulating in

This road to NH-9 is now a dumpsite, trucks unload trash here

Ghaziabad: A new dumpsite has emerged along a service road connecting NH-9 with Siddharth Vihar. Garbage trucks can be seen unloading their contents at this spot, creating an unsightly and unhygienic environment, residents said."Authorities have been notified about the issue, but no concrete action has been taken thus far. The lack of proper waste management and disposal systems has led to the emergence of such unauthorised dumping grounds across the city. It is crucial for the authorities to address this problem promptly and find sustainable solutions to ensure the well-being of the citizens and the environment," said NK Negi, a resident of the area.

The accumulated waste attracts pests and emits foul odours, making it hard for people to walk or drive past the area. Moreover, the dumping site is in close proximity to residential neighbourhoods, raising fears of contamination and the spread of diseases"The road



has been littered with construction and demolition waste for an extended period, and it remains unaddressed. The lane, frequently used by numerous residents, has received minimal cleaning attention. Various spots along the lane are marred by scattered garbage, including easily noticeable construction debris, plastic and horticulture waste," said Priyanka Bhardwaj another resident. The lack of proper waste management and regular cleaning has led to an unsightly and unhygienic environment for those who rely on this road daily. The prolonged presence of the waste suggests a disregard for the well-being of the residents and the overall cleanliness of the area.

Residents are required by law to properly dispose of construction and demolition waste, but the civic body has been unsuccessful in implementing these regulations effectively.

Punjab & Haryana lost 64.6bn cubic metres of groundwater in 17 years: Study

Gurgaon: Punjab and Haryana have lost a staggering 64.6 billion cubic metres of groundwater in the 17 years between 2003 to 2020, a study has found, underscoring the possible effect of urbanisation on this rapidly depleting

resource. To put it into perspective, this volume of groundwater could fill around 25 million Olympic-sized swimming pools, researchers from IIT-Delhi and Nasa's Hydrological Sciences Laboratory estimate. The depletion, the highest in India, is correlated with higher demand of water by industries and households, agriculture and population growth, researchers said. The study, titled 'Detection and Social Economic Attribution of Groundwater Depletion in

India', was published on Oct 1 in the Hydrogeology Journal. The paper cited other research to note that "substantial groundwater depletion" was observed in Gurgaon and Faridabad, where water-

intensive paddy cultivation is minimal -indicating that much of the resource in these areas was likely because of the urban sprawl. "Long-term implications of groundwater loss include reduced agricultural productivity and degraded



soil quality. This will have societal implications for an agriculturedominated state," Manabendra Saharia, assistant professor in the department of civil engineering at IIT-Delhi, said. Saharia is one ofhe co-authors of the

study. Asked how Haryana could slow down this plunder, Saharia said rainwater harvesting and precision agriculture were key to recharge aquifers.Researchers relied on data from the Central Ground Water Board (CGWB), at-site

> inspections, satellite data and hydrological models to analyse groundwater levels across the country. These figures were then correlated with socio-economic parameters of regions. For instance, data from India Meteorological Department (IMD) was studied to examine any change in rinfall patterns over the same period. Based on its analysis, the paper shortlisted five hotspots with highest levels of groundwater depletion in India - Punjab and Haryana topped the list, followed by UP, West Bengal, Chhattisgarh

Kerala. While irrigation for agriculture was a common reason for groundwater extraction in all five hotspots, other possible reasons in Punjab and Haryana include expansion of industries, population growth and urbanisation, the study noted.

Data showed that groundwater level declined 8-10% in Punjab and Haryana from 2000 to 2015. In the two states, the growth rate of factories was 69% in FY 2004-2005 and this went up to 170% in FY 2018-2019. Similarly, urbanisation growth was 10% in 201, and this went up to 20% by 2011."During this decade (2001 to 2011), the level of urbanisation, i.e., percentage of urban population, has increased by 10%-20%, representing one of the highest increases in urban population across the country... In addition, groundwater demands for domestic and industrial use show a significant increase of 26%-228%. Thus, despite government interventions and no perceptible decline in precipitation, groundwater demand has accelerated leading to depletion." the study said. Other studie corroborate the paper's findings.Groundwater levels in Gurgaon have been classified as 'overexploited' since 2013 by the Central Ground Water Authority (CGWA).

8k Gr Noida flats registered under UP govt's rehab policy, 8k more likely by March next yr

Noida: A total of 8,106 flats were registered in Greater Noida since Feb this year after developers came forward to adopt UP govt's policy aimed at reviving stalled real estate projects in the state. Another 8,000 flats are likely to be registered by March next year, according to a report presented to the Greater Noida Industrial Development Authority's (GNIDA) board on Sunday. The policy, based on recommendations of a committee headed by retired bureaucrat Amitabh Kant, required builders to pay 25% of their recalculated dues upfront if they want a zero period waiver on interest incurred during two years of the pandemic.In Greater Noida, the report said, developers of 73 group housing projects - accounting for 32,435 unregistered flats - had opted for the

policy. The registration of flats this year has yielded GNIDA around Rs 547 crore, with an additional Rs 1,300 crore expected through next year. To protect homebuyers' interests, GNIDA has adopted a tripartite 'sale agreement' model, similar to that in Noida and Yamuna Expressway authorities. The agreement is signed between builders, homebuyers and the authority concerned once buyers have made a 10% down payment. This legally binding agreement, required for all future housing projects, ensures timely payment of stamp duty. Earlier, registration was done only after buyers had paid in full. In an attempt to standardise industrial plot allocation policies across Noida, Greater Noida, and Yamuna Expressway areas, GNIDA and the two other authorities have appointed SARC and Associates as consultant to develop guidelines for eligibility, lease rent, and other processes.

Earlier, the three authorities formed a committee to prepare a standard operating procedure (SOP) with input from finance controllers and general managers. While they decided to conduct e-auctions for plots up to 8,000sqm and interviews for larger land parcels in Aug, there was no govt order on this. Now, based on the consultant's recommendations, a uniform policy is expected to be framed. The board also approved a new policy to facilitate flat registrations at Senior Citizen Home Complex Welfare society, where many original allottees have sold their flats without executing

Air turns 'very poor', official blames Pakistan for farm fires

Noida: Air quality dipped to 'very poor' in the NCR cities of Noida, Greater Noida and Ghaziabad on Sunday, prompting a senior pollution board official to blame Pakistan for the plummeting levels. While Noida recorded an AQI of 304 – a significant plunge from 169 the previous day - Greater Noida also registered a decline at 312. Neighbouring Ghaziabad recorded an AQI of 324. While Noida and Ghaziabad recorded AQI levels upwards of 300 on Aug 23, this is the first time that Greater Noida breathed 'very poor' air this season."This is the first time this year that all three cities of Noida, Greater Noida and Ghaziabad saw 'very poor' air quality on the same day. And our neighbouring country - Pakistan - needs to be blamed for this. Increasing instances of stubble



Will map Hindon floodplains by July next yr, UP tells NGT

Ghaziabad: The UP govt has sought time till July next year to demarcate Hindon floodplains in Ghaziabad and GB Nagar.In a reply submitted before the National Green Tribunal on Oct 17, the irrigation department said six teams, equipped with drones, are expected to complete surveying an 850 sq km area along the river in the two districts over the next two months under the supervision of the Survey of India."Each team will cover about 75 sq km per month. We have already surveyed about 30 sqkm, the rest will be completed by Dec 31. Thereafter, pillars demarcating the floodplain zone on both sides of the Hindon in the two districts will be erected. It is

official said.Used in digital cartography and geographic information systems (GIS), DEM and DSM are the most common basis for representing a terrain. Mom-son duo among 4 held for snatchings

Noida: Four people, including a mother-son duo, were arrested in connection with several chain snatching cases in the city on Saturday. The accused, all from Ghaziabad, were identified as Aditya (27), Zoheb (20), Sunny (23) and the latter's mother, Mamta. As part of their modus operandi, which was revealed during interrogation, Sunny and Aditya would target those wearing gold chains and travelling alone. They would brandish their gun and threaten the victims with dire consequences before fleeing with their ornaments on their bike. Then, they would hand the chains over to Mamta, who in turn gave them to a Ghaziabad-based jeweller Zoheb. The jeweller would remould the jewellery and sell it. The proceeds were then divided among the four.Deputy commissioner of police, Noida, Rambadan Singh said the arrests were made jointly by the Sector 113 police and the oida surveillance team. First, Aditya and

Sunny were taken into custody on charges of snatching jewellery from people on FNG Road, and after they provided further information, their two accomplices were arrested.Both Aditya and Sunny have an extensive criminal history in Gautam Budh Nagar and Ghaziabad, DCP Singh said, with cases registered against them under the Indian Penal Code, BNS, Arms Act, and Narcotic Drugs and Psychotropic Substances Act. Mamta and Zoheb also have several criminal cases registered against them. Police

McDonald's rules out beef patties as source of E Coli outbreak that killed 1

Washington DC. McDonald's on Sunday ruled out beef patties as a source of the E Coli outbreak linked to Quarter Pounder hamburgers, which has killed at least one person and sickened nearly 75 others."We remain very confident that any contaminated product related to this outbreak has been removed from our supply chain and is out of all McDonald's restaurants," the fast-food chain's Chief Supply Chain Officer Cesar Pina said in a statement. The Colorado Department of Agriculture said that all subsamples from multiple lots of McDonald's brand fresh and frozen beef patties had tested negative for E Coli, adding that it had completed beef testing and does not anticipate receiving further samples.McDonald's said it would resume distribution of fresh supplies of the Quarter Pounder and that it is expected to be available in all restaurants in the coming week, according to the statement. Regulators had been investigating whether McDonald's beef patties could be affected. The US Food and Drug Administration and the US Department of Agriculture didn't immediately respond to a Reuters request for comment.E Coli is killed in beef when cooked properly. The McDonald's Quarter Pounder is served with raw and slivered onions and affected restaurants will serve the burgers without such onions.US fastfood chains have pulled fresh onions out of their menu items after the vegetable was named as the likely source of an E Coli outbreak.McDonald's has pulled the Quarter Pounder from about one-fifth of its US restaurants, including in Colorado, Kansas, Utah and Wyoming, and in parts of Idaho, Iowa, Missouri, Montana, Nebraska, Nevada, New Mexico and Oklahoma.Past E Coli outbreaks have hampered sales at big fast-food restaurants as customers avoid

From Immigration To Abortion: 5 Issues At Stake In The US Election

Washington, United: Tax breaks for families with children? Supporting Ukraine? Drilling for oil?From taxes, to immigration, to abortion -- here are the five key issues which are at stake as Donald Trump and Kamala Harris enter a final sprint in the race for the White House.

Economy

Trump, who cut taxes for businesses and the wealthy during his 2017-2021 presidency, plans to impose tariffs of more than 10 percent on all US imports, which he says will enable him to lower taxes for Americans.

The Republican has also vowed to make the United States the "crypto capital of the planet," and launched his own cryptocurrency platform with his sons in September.Democrat Harris, meanwhile, is appealing to the middle class with her promise to create an "opportunity economy," while pitching moderate tax hikes for the richest people. The 60-year-old has also promoted child tax credits, support for firsttime homebuyers, and help for small businesses.

Immigration

Trump has taken a hard-line approach on immigration, saying that he will order mass deportations of millions of undocumented migrants if reelected. The former president, who in 2016 promised to build a wall along the US-Mexico border, has accused immigrants of "poisoning the blood of our country."For her part, Harris has pledged a tough stance and warned of "consequences" for people who enter the country illegally. She has supported President Joe Biden's plan to tighten up immigration policy, notably by investing in physical barriers on the border.Reproductive rights are a big issue for some US voters after the federal right to abortion was removed in 2022 with the overturning of Roe v Wade, resulting in total abortion bans in some states.

Egypt proposes 2-day Gaza ceasefire with hostage-prisoner exchange

Cairo. Egypt has proposed an initial two-day ceasefire in Gaza to exchange four Israeli hostages of Hamas for some Palestinian prisoners, Egypt's president said on Sunday as Israeli military strikes killed 45 Palestinians across the enclave. Egyptian leader Abdel Fattah al-Sisi made the announcement as efforts to defuse the devastating, more than year-long war resumed in Qatar with the directors of the CIA and Israel's Mossad intelligence agency taking part.Speaking alongside Algerian President Abdelmadjid Tebboune during a press conference in Cairo, Sisi also said that talks should resume within 10 days of implementing the temporary ceasefire in efforts to reach a permanent one.

There was no immediate comment from Israel or Hamas but a Palestinian official close to the mediation effort told Reuters: "I expect Hamas would listen to the new offers, but it remains determined that any agreement must end the war and get Israeli forces out of Gaza."Israel has said the war cannot end until Hamas has been wiped out as a military



force and governing entity in Gaza. The US, Qatar and Egypt have been spearheading negotiations to end the war that erupted after Hamas fighters stormed into southern Israel on October 7 last year, killing 1,200 people and taking more than 250 hostages, by Israeli tallies.he death toll from Israel's retaliatory air and ground onslaught in Gaza is approaching 43,000, Gaza health officials say, with the denselypopulated enclave in ruins. An official briefed on the talks told Reuters earlier on Sunday that negotiations in Doha will seek a short-term ceasefire and the release of some hostages being held by Hamas in exchange fr Israel's release of

The objective, still elusive after multiple mediation attempts, is to get Israel and Hamas to agree to a halt in fighting for less than a month in the hope this would lead to a more permanent ceasefire. At least 43 of those killed in Gazaon Sunday were in the north of the enclave, where Israeli troops have returned to root out Hamas fighters who it says have regrouped there.

Japan gets hung parliament after polls, PM Ishiba's coalition loses majority

Prime Minister Shigeru Ishiba's ruling coalition failed to secure a majority in the elections in Japan amidst the rising economic challenges and a tense security situation.

Tokyo. The make-up of Japan's future government was in flux on Monday after voters punished Prime Minister Shigeru Ishiba's ruling coalition, leaving no party with a clear mandate to lead the world's fourth-largest economy. The uncertainty sent the yen currency to a three-month low as investors and analysts prepared for days, or

possibly weeks, of political wrangling to form a government and potentially a change of leader. That comes as the country faces economic headwinds, a tense security situation fuelled by an assertive China and nuclear-armed North Korea, and less than a week before US voters head to the polls in another unpredictable election

Ishiba's Liberal Democratic Party (LDP) and its junior coalition partner Komeito took 215 seats in the lower house of parliament, down from 279 seats, as voters punished the incumbents over a funding scandal and a cost-of-living crunch. Two cabinet ministers and Komeito's leader, Keiichi Ishii, lost their seats. The biggest winner of the

night, the main opposition Constitutional Democratic Party of Japan (CDPJ), had 148 seats, up from 98 previously, but also still well short of the 233 majority. As mandated by the constitution, the parties now have 30 days to figure out a grouping that can govern, and there remains uncertainty over how long Ishiba - who became premier less than a



month ago - can survive after the drubbing. Smaller parties also made gains and their role in negotiations could prove key."Whether or not Prime Minister Shigeru Ishiba resigns as LDP leader today, it seems unlikely that he will survive to lead a new government as prime minister ... though it is possible he could stay on as caretaker," said Tobias Harris, founder of Japan Foresight, a political risk advisory firm.Ishiba is scheduled to hold a press conference at 2 pm (local time). Ahead of the election, the LDP had been planning to convene parliament on Nov. 7 to confirm the prime minister, according to Japanese media including Jiji and the Yomiuri newspaper.

CDPJ leader Yoshihiko Noda has said he would work with other parties to try and oust the incumbents, though analysts see this as a more remote possibility.

The LDP has ruled Japan for almost all of its post-war history and the result marked its worst election since it briefly lost power in 2009 to a precursor of the CDPJ.n a statement, the head of Japan's most powerful business lobby said the country needed political stability to steer an economy that faced urgent tasks such as boosting the supply of nuclear energy and maintaining the momentum for wage hikes.

We strongly hope for policy-oriented politics through the establishment of a stable government centred on the LDP-Komeito (coalition)," Keidanren Chairman Masakazu

Biden slams Elon Musk after report of illegally working in US: Violation of law

Addressing an event in Pittsburg, the US President slammed Tesla CEO Elon Musk after a media report showed that he once worked illegally in the United States when he was supposed to be studying at Stanford University.

New York. President Joe Biden slammed Elon Musk for hypocrisy on immigration after a published report that the Tesla CEO once worked illegally in the United States. The South Africa-born Musk denies the allegation."That wealthiest man in the world turned out to be an illegal worker here. No, I'm serious. He was supposed to be in school when he came on a student visa. He wasn't in

And he's talking about all these illegals coming our way?" Biden said while campaigning on Saturday in Pittsburgh at a union hall.he Washington Post reported that Musk worked illegally in the country while on a student visa. The newspaper, citing company documents, former business associates and court documents, said Musk arrived in Palo Alto, California in 1995 for a graduate program at Stanford University "but never enrolled in courses, working instead on his

Musk wrote on X in reply to a video post of Biden's comments: "I was in fact allowed to work in the US." Musk added, "The Biden puppet is lying."Investors in Musk's company, Zip2, were concerned about the



possibility of their founder being deported, according to the report, and gave him a deadline for obtaining a work visa. The newspaper also cited a 2005 email from Musk to his Tesla co-founders acknowledging that he did not have

started Zip2.

According to the account, that email was submitted as evidence in a now-closed California defamation lawsuit and said that Musk had apllied to Stanford so he could stay in the country legally. Musk is today the world's richest man. He has committed more than \$70 million to help Republican presidential nominee Donald Trump and other GOP candidates win on Nov. 5, and is one of the party's biggest donors this campaign season. He has been headlining events in the White House race's final stretch, often echoing

Trump's dark rhetoric against immigration. Trump has pledged to give Musk a role in his administration if he wins next month. There was no immediate response to messages left with X and Tesla seeking Musk's comment.

12 Nagai fishers held by Sri Lankan Navy

NAGAPATTINAM: Around 12 fishermen from Nagapattinam district fishing near Kodiyakarai on Saturday night were arrested by the Sri Lankan Navy for allegedly crossing IMBL.According to sources, 10 of the arrested fishers hail from Akkaraipettai and two are from Pushpavanam. The group was fishing amongst a cluster of boats around 12 nautical miles southeast from Kodiyakarai around 11.30 pm. Suddenly, a group of personnel from Sri Lanka's Northern Naval Command intercepted the



fishing boat in their fast-attack craft. The Lankan Navy apprehended the fishers and seized their boat and fishing gear. They also seized hundreds of kilograms of fish catch. The mechanised boat belonging to an Akkaraipettai resident named S Silambuselvan was also impounded.

According to the Lankan Navy, their personnel have seized 62 Indian fishing boats and arrested 462 fishermen so far in 2024. In a statement on Sunday, the Navy said it continues to conduct operations to curb "illegal fishing by foreign boats", taking into account the impact of those practices on the livelihood of local fishermen

Hurt by blast, Zamra convention centre in Kochi still battling for business

KOCHI: October 29, 2023, will be remembered as a day that changed the lives of many -and not for the better. One casualty of the twin blasts at the Jehovah's Witnesses prayer meeting, which left eight dead and several injured, has been the Zamra International Convention and Exhibition Centre in Kalamassery. Since the blat, the event venue, which saw good business yearround, has seen a drop in revenue. The tragic incident has blighted its reputation. Speaking to TNIE, Nishaf, manager of the convention centre, said, "People hesitate to hold auspicious functions here." In the immediate aftermath of the blast, 26 bookings were cancelled. "We lost around Rs 80 lakh in revenue. Ramadan used to be followed by plenty of bookings for various functions. That too has stopped, "he added. The months from October used to be a packed schedule for the convention centre.

A further hit has been the drying up of meetings, incentives, conferences, and exhibitions (MICE) bookings from companies based in Infopark. "We used to get a lot of such bookings. But, now the companies are giving us a wide berth. And we can't blame them. Nearly all IT companies have their head offices in the US, the UK or other European countries. Once they find out what happened at the centre, they issue a stern no," said Nishaf. He points out that despite the drop in bookings, expenditure remains high. "The convention centre is seven to eight years old and we have to carry out maintenance work. Then there are the salaries of employees."But, Nishaf adds, "Things are slowly picking up. Since August, we have been receiving bookings for wedding ceremonies and parties. For December, we have around eight bookings. We hope the tide will change and things will turn around in 2025."

Residents of Balasore's cyclone-hit areas allege inadequate relief despite receding floodwaters

BALASORE: Even as the water level of Budhabalanga river has started receding, residents of low-lying areas are worried about damage to their property and inadequate relief. Sources said Budhabalanga river is flowing at 7.40 metre near Gobindpur against its danger level of 8.13 metres. Similarly, Jalaka river is flowing at 5.06 metre, below its danger level of 6.40 metre. However, those residing in low-lying areas of Remuna, Basta, Balasore Sadar, Khantapada, Oupada and Nilagiri blocks alleged they have not been provided adequate relief. The affected residents were given cooked food and other essential items when they were accommodated at cyclone shelters. The residents said they were given flattened rice, jaggery and drinking water which will last a few days.

Bikartan Khilar and Debasmita So of Kasmila village in Haripur panchayat of Remuna block alleged they were not given any relief. Around 20,000 people in the block were affected by the cyclone. They said no official, be it from the block or the district headquarters visited the affected areas to assess the damage to property and standing crops. The affected people said owing to poor drainage, low-lying areas of the cyclone-hit blocks are now waterlogged due to the ingress of excess water from Sono river at Kaptipada and Similipal Tiger Reserve in Mayurbhanj district."We requested the district administration and field-level officers to visit the waterlogged areas of Sadar block and arrange free kitchen and relief for the affected people.

Kerala: Kalamassery blast survivor yearns for promised aid, normal life

On the eve of the first anniversary of the Kalamassery twin blasts that claimed the lives of eight people, TNIE revisits the tragedy and examines the impact it has had on people and places.

KOCHI: When Moly Cyriac left her home in Adimali at the break of dawn on October 29, 2023, all she hoped to do was attend the baptism of her cousin's daughter and whet her curiosity for the

rituals of Jehovah's Witnesses. Never in her wildest dreams did she expect her life to be upended over the next few hours.As the scars and the mental trauma wrought by the blasts at the Zamra International Convention and Exhibition Centre in Kalamassery, where the baptism was to be held on the day of the convention, refuse to recede, the 59-year-old survivor is having difficulty leading a normal life. She still shuttles between Adimali and

the Ernakulam Medical Centre (EMC) hospital for regular follow-up treatment and check-ups.

A Roman Catholic, Moly was invited to attend the baptism of her beloved Venus. "I did not want to miss the ceremony for the world. I don't belong to the community and had not attended any of the sect's events. However, since that fateful day, life has been a constant struggle."Moly sustained more than 50%

burns and was admitted to the intensive care unit of EMC. "I was under treatment for more than two months. My recovery was a distant hope. Despite the extensive treatment, I am still not able to



walk or sleep properly. There are burns wounds all over my body, hands, and thighs. I can only sleep on my stomach due to the injuries on my back. Even now I experience pain, itching, and other difficulties. We appointed a home nurse for a brief time. It was financially impossible for us to continue," she said. She travels to Kochi to consult her doctor once every month. "The doctor said he wants to see me for further treatment. I

take a taxi from Adimali. I have spent around Rs 16 lakh for my treatment in the last one year," she said, adding that most of the expenses were met by the Jehovah's Witnesses. Venus was also

> injured in the blast and was admitted to a private hospital in Kochi. "She made a quick recovery and left the hospital after 37 days," said Moly.

As many as 52 people were admitted to various hospitals in Ernakulam following the twin blasts.Moly said that many of the survivors have still not been provided financial assistance by the state government. "The chief minister, governor, and other ministers were among those who visited us in the following days with promises of financial and

other assistance. However, I have not received any assistance. I tried to apply for aid by submitting my hospital bills. However, there has been no update," says Moly, a daily wager. She has two daughters. The eldest is married and lives with her family in Peerumedu, while the youngest is in between jobs in Dubai. Moly is a single mother, having separated from her husband when her younger daughter was three years old.

Building illegal, but BBMP babus allowed it, says complainant

BENGALURU: A woman, to save her 15x20 sqft home from an illegal construction next to her house, had in 2022 approached the Bruhat Bengaluru Mahanagara Palike chief engineer, assistant executive engineer, assistant director of town planning (ADTP), BBMP and assistant engineer of town planning. The woman alleged that instead of taking action, the engineers helped the violator put up a six-storeyed multi-dwelling unit on Gosaiah Street in Akkithimmanahalli at Shanti Nagar, hardly a few hundred metres from the BBMP head office. The complainant, Berta Albert Thomas, charged that when she filed the complaint, the ADTP also asked her to bring her husband or children to the office. With the recent building collapse at Babusapalya, the family is spending sleepless nights, she added."In 2022, I approached the BBMP engineers, but they kept ignoring me. In June 2024, I again met Zonal Commissioner Snehal R and on the same day, I approached ADTP Liaquat and AE of Town Planning Suresh. The zonal commissioner gave false assurance of action, while ADTP got upset for repeatedly coming to his office and asked me to bring my husband or children to his office.AE Suresh came to the spot and instead of taking action, he spent over one hour at the violator's home. At that time, the building had about four floors. Because of the BBMP negligence, the owner added two more floors," she claimed and added that the illegal building has 16 units. The woman alleged that ward AEE Savithri also deliberately ignored her complaint.

Health department of Coimbatore to focus on private ambulance fitness

COIMBATORE: The health department officials of the district plan to request the Road Transport Officials (RTOs) to conduct thorough checks on the fitness of private ambulances that have been discontinued from production. The request comes after an incident where a private ambulance, using a vehicle which was no longer in production, experienced multiple breakdowns while admitting a heart patient to a private hospital on Mettupalayam Road in the city recently.

The officials who noticed the ambulance assisted the patient and sent him to the hospital in another ambulance. During the inquiry, it was found that it was a vehicle that was discontinued a few years ago and the owner of the vehicle had purchased it from

another person. As a result, health department officials are urging road transport officials to implement stricter measures to ensure the fitness of ambulance vehicles. Joint



Director of Medical and Rural Health Services of Coimbatore district NN Rajasekaran said using such vehicles as ambulances is highly risky."A few private ambulance services and some private hospitals have been

using such discontinued vehicles as ambulances. Due to its compact size, the operators prefer these vehicles to pass easily even during heavy traffic. However, since they are discontinued, maintaining them is a challenge. As they are not officially in production, the spare parts for these vehicles might not be original. Therefore, they cannot be maintained with quality spare parts and proper service provided by the manufacturer. Deploying such vehicles to save the lives of the

Mounting Aarogyasri dues leave pvt hospitals in Telangana under financial crisis

HYDERABAD: Many private hospitals empanelled in the Aarogyasri Healthcare Scheme are facing severe financial difficulties due to outstanding reimbursements from the government, some of which have been pending for over a year. These delayed payments are prompting several hospitals to consider deempaneling themselves from the scheme. Additionally, the Employee Health Services (EHS) dues are also reported to be overdue. According to the official website of the Aarogyasri HealthCare Trust, there are 327 corporate hospitals empaneled, with 54 located in Hyderabad. However, many hospitals are withdrawing from the scheme due to financial strain.One recognised multispecialty hospital, still listed on the Rajiv Aarogyasri Healthcare Trust website, told TNIE that it ceased to provide healthcare services under Arogyasri and refused to disclose the reasons.

The Telangana Aarogyasri Network Hospitals Association (TANHA) said that dues have been outstanding for over a year. They submitted a representation to the health minister in April, who assured them that all dues would be cleared soon. Vaddiraju Rakesh, president of TANHA, told TNIE,

"Private hospitals are willing to extend the Aarogyasri services to beneficiaries, but it should not jeopardise their financial viability. For the past decade, we have been urging the government to revise package rates by 7% to account for inflation, as the current rates make it challenging to provide services. We also seek the release of old dues, a redraft of the MoU, and adjustments to miscellaneous deductions and cancellations."

As outlined in the Aarogyasri MoU, reimbursements are supposed to be processed within 40 days of treatment, but this has not been adhered to, leading to significant delays, Rakesh added.Notably, in August, the government announced an extension of Aarogyasri insurance coverage from Rs 5 lakh to Rs 10 lakh, along with the addition of 163 new procedures, bringing the total to 1835 under the health scheme."If the government plans to implement changes to the scheme, it must communicate with service providers about its intentions and how to effectively implement the proposals. Network hospitals were not invited for any discussions, and we currently lack clarity on the new procedures and enhanced packages. Given the challenging circumstances we are facing, how can we accommodate these changes?" Rakesh added.Aarogyasri officials denied these claims, stating that dues have been paid monthly since the new government took office.RV Karnan, director of the Aarogyasri Healthcare Trust, told TNIE, The trust is prioritising payments, clearing dues first for dialysis centres, NIMS, private hospitals, and lastly government hospitals.

Hyderabad metro rail phase-II works to complete within four years

This phase will cover 76.4 km across five corridors at a cost of Rs 24,269 crore.

HYDERABAD: The state government announced plans to complete the second phase of Metro rail in Hyderabad within four years. This phase

across five corridors. Following the state cabinet's approval of the detailed project report (DPR) for these corridors, officials have begun the process of submitting the DPR

to the Union government for approval. The total estimated cost of the project is Rs 24,269 crore. Of this, the state government will bear Rs 7,313 crore (30%), while it expects the Centre to provide Rs 4,230 crore (18%).

Additionally, Rs 11,693 crore (48%) will be sourced through loans from multilateral agencies such as JICA, ADB, NDB, backed by the Centre's sovereign guarantee. The remaining Rs 1,033 crore (4%) will be raised through a publicprivate partnership (PPP) model.Initially, the state government planned to construct a



metro line spanning a total of 116.4 km across six corridors. So far, the DPR for five corridors has been prepared and feasibility tests for the remaining corridor, from the Airport to Fourth City, are ongoing.In the first phase, previous governments constructed a metro network covering 69 km across three corridors through a PPP model at a cost of Rs 22,000

crore. Currently, about 5 lakh passengers use the Metro daily. Once the second phase is completed, the total length of the Metro line Hyderabad will extend to 115.4 km, with the second phase expected to accommodate an additional 8 lakh passengers daily.Officials said that the previous government neglected the extension of the Metro in the city. They stated: "Initially, Hyderabad metro stood at second place, after Delhi. However, due to the expansion of Metro in other cities, Hyderabad has fallen to 9th place in terms of length. Cities like Delhi, Mumbai, Bengaluru, Chennai, Kolkata,

Pune, Nagpur and Ahmedabad now have more extensive Metro networks. Therefore, Chief Minister A Revanth Reddy intends to expand the Metro network in Hyderabad."

IAF transport fleet & loads of memories

Military courier flights serve as an air bridge between the operational areas and the communication centres or administrative bases located in the hinterland for transportation of personnel and stores. The reduction in travel time also affords an opportunity to troops to avail shorter stints of leave without jeopardising operational readiness levels. Courier flights mostly comprise the transport fleet of the Indian Air Force; however, commercial flights are also commonly used. My first experience of couriers was as a Second Lieutenant deployed in Sri Lanka, as a part of the Indian Peace Keeping Force (IPKF). With only six days of leave sanctioned to attend a wedding, my ability to do so was shrouded in doubt considering the distance to be traversed. My hopes were pinned on allotment of vacancies on courier flights to Chennai and onwards to New Delhi.

The allotment process appeared to be quite a mystery for someone at the bottom of the pecking order. The grapevine, without a shred of evidence, was about out-of-proportion cornering of vacancies by the headquarter staff vis a vis the forward troops. An unscheduled courier had arrived at Trincomalee, and an early morning ringing of the telephone in the tent that I shared with my Company Commander announced the allotment of that elusive vacancy. I had just enough time to throw in a couple of clothes into a rucksack. I slowly absorbed the commercial flight courier — the comfortable seats, array of switches overhead and, of course, the elegantly dressed airhostesses in the midst of a sea of combat uniforms. Despite the short duration of the flight, breakfast was served. Seeing my untouched food, my co-passenger indicated the overhead button. I sheepishly requested for toothpaste and the air-hostess was kind enough to hand me one from her vanity bag. Thanking her profusely, I freshened up and savoured the breakfast, a memorable one indeed.

The Chennai to New Delhi courier flight was a service aircraft and I was told that my name did not feature in the manifest list cleared for boarding. Buying an air ticket at such short notice would have burnt a huge hole in my pocket. My more experienced coursemates advised me to wait it out as the Air Force pilots rarely left anyone stranded, especially young officers. Lady luck smiled and I was permitted to board in the last batch (compassionate cases).

The colossal size of the newly-acquired IL-76 was awe-inspiring and the arrangements much at variance from the morning flight, starting from the boarding ramp instead of steps, the rugged steel benches for seating, luggage and empty ration cartons piled up in the aisle and, of course, the absence of refreshments and air-hostesses.

Another time, while proceeding on an officers' course to India from Sri Lanka, the course detailment was received at the last moment and there were no courier vacancies. The parachute regiment coursemates, who enjoyed an excellent rapport with transport aircraft pilots by virtue of the jumps they undertook, came to our rescue. This was an AN-32 aircraft, much smaller than an IL-76, and the airfield was Palaly, a major logistic base for IPKF in Jaffna. Of a batch of three, two officers managed to get manifested and we requested that the third be tucked in behind empty ration cartons in the aisle, surreptitiously. The naivety of this exercise dawned on us much later.

In another case, an officer deployed in the forward areas was to proceed on posting and had kept his pet dog with him. With the area snowbound, the only way out was via couriers and pets were of course not permitted. So, a special breathable box was created, the dog was sedated and the box was passed off as stores, though its loading was monitored by the officer himself.

How birds are woven into the fabric of beliefs and rituals

In Indian mythology, trees, animals and birds are intrinsically woven into the fabric of beliefs, rituals and worship. Birds, especially, have been associated with several Indian gods and goddesses, holding a position of importance in religious and cultural practices. Feeding crows during the period of Shraadh is a common practice in many regions in India. It is believed that crows are messengers connecting the world of the living with that of their departed ancestors. Garuda, an eaglelike creature, is closely associated with Lord Vishnu as his vahana, symbolising courage, strength, speed and loyalty.Laxmi, the goddess of fortune and wealth, is seen riding a Barn Owl named Uluka. In many cultures, owls symbolise wisdom and the ability to discern hidden truths, attributes required to acquire great wealth. The Indian Peacock is a bird of great beauty and symbolic significance. The peacock is associated with deities like Goddesses Laxmi and Saraswati, besides Lord Kartikeya. Lord Krishna wore a peacock feather in his hair. As a symbol of such grace and elegance, this iconically beautiful bird holds a unique place in Indian mythology, culture and art. Peacocks were feted by royals, and continue to be depicted in Indian art and architecture and in temples and textiles.

Today, the peacock has become synonymous with India. Interestingly, there are three species of peacocks in the world. One is endemic to the Congo in Africa, while the other two are found in India. Despite being a common sight, the beauty of the Indian Peacock never ceases to amaze. It is believed that the bird's iridescent colours have a divine origin and were bestowed upon the peacock by Lord Indra himself out of gratitude for saving his life. Scientifically, the peacock gets its earthy rust and brown colours from the presence of melanin in the feathers. The iridescent colours, however, are a result of (structural colouration) the way light interacts with the feathers. Simplistically speaking, peacock feathers are made up of barbules coated with keratin. When light falls on the feathers, it refracts and reflects off the barbules, resulting in the




shimmering hues of blue, green and violet reminiscent of the magic pencil box of our childhood, which would change colour when moved at different angles. The peacock dancing to the rhythm of raindrops is a sight to behold! With a bevy of females looking on, he launches into his dance of love. Its beautiful long train with the hypnotic ocelli (eye-like patterns) come to life as it sways and shivers, mesmerising potential mates. Though the peahen is rather drab, it supports a beautiful crest like the peacock. There is a purpose to nature's ways. Peahens lay their eggs in a shallow dugout on the ground. The dull-coloured feathers help in camouflaging the bird while it incubates the eggs. The peachicks are nidifugous. Like hatchlings of other ground-nesting species, they are born with fine feathers covering their bodies. They are up and running as soon as they hatch. Like all species of fowls, a peacock lives with a harem of several breeding females. It is unfortunate that in spite of our ancestors venerating birds to the extent of giving them godlike status, the modern world does not accord them the same reverence. Several wild

species of birds are persecuted in the name of the very rituals for which they are worshipped.During religious festivals, many owl species — Barn Owls, Eagle Owls, Scops Owls — are trapped and sacrificed in the belief that having lost her vahana, Goddess Laxmi (wealth) will continue to be in their homes. Similarly, the demand for the peacock's train feathers also escalates during this time. Peacocks molt their old train once the mating season is over. These feathers can be gathered ethically as they lie scattered on the ground. Unfortunately, there is no deterrent to greed. The demand for these feathers is so great that illegal poaching of the bird becomes a grave threat to its existence.

In 1963, Indian Peacock was officially selected as the National Bird of India over the Great Indian Bustard while replacing the Indian Vulture. The peacock became a symbol of beauty and cultural heritage. This status accorded the bird protection from hunting and poaching. The Great Indian Bustard was a loser in every respect. Today, its habitat is taken over by wind farms, its numbers are sadly depleted and it depends on captivity breeding.

Permission was granted and my little granddaughter, Lila, squatted next to me, eagerly watching me do the traditional ritual. She asked me many questions and I told her that the goddess of wealth, Laxmi, steps in wherever she sees these inviting footprints. 'Who is Laxmi?'

she asked next. So I explained that she is a beautiful goddess who has four arms (her eyes opened wide in disbelief at that), she blesses her worshippers with gold coins and stands on a lotus. By now, Lila could take no more. 'She stands on a lotus?' she repeated slowly. Then came her clincher, 'So how come she doesn't drown?

Myths, rituals and superstition can never really stand 'woke' scrutiny, but it appears harder for this new generation of de-racinated Indians to believe so wholeheartedly that our gods came in many shapes and forms, could perform superhuman feats and yet were as dear to us as a beloved aunt or uncle. Children particularly, and those who never went to school, are the most ardent believers in miracles and acts of divine valour because they accept uncritically whatever their grandmothers tell them. Every religion has this quotient of unbelievable myths: Jesus being born to a Virgin Mother, the Prophet flying on a divine horse to heaven or Moses guiding the Jews out of Egypt by parting the seas. As for the fantastic tales that form the religious beliefs of Aboriginal tribes or nature worshippers whose gods are the

primal forces of Nature, their wisdom and respect for the natural world goes far beyond the scientific explanations for climate change.

Science has its own place in the modern world, but can we allow individual beliefs, rituals and myths their own place too? The culture that arises from the



Bishnoi Gang's Rival Fires At Delhi Businessman's House, Leaves A Note

New Delhi: Two men affiliated with the Bambiha Gang, the rival of the incarcerated gangster Lawrence Bishnoi, opened fire at the residence of a businessman in Delhi, police said today. The shooting occurred in North West Delhi's Rani Bagh around 8.40 am on Saturday and the two accused, who were on a bike, threw a chit on which 'Bambiha Gang' was written. At least six to seven rounds were fired outside the house, officials said. However, no call has so far been received regarding extortion.

Delhi has witnessed an increase in

firing incidents as part of extortion attempts recently.Last month, three sensational incidents of firing occurred in the capital -- at a car showroom in Naraina in west Delhi, a hotel in southwest Delhi and the sweet shop, all were linked to extortion activities by gangsters. In the first incident, shots were fired at a second-hand car showroom called 'Car Street Mini' in southwest Delhi's Naraina,



barely a kilometre from the Naraina police station. Officials said at least 20 rounds were fired by three men who entered the showroom, causing panic in the area. The shooters left behind a slip, reading "Bhau Gang, Since 2020". The "Bhau Gang" mention was seen as a reference to wanted gangster Himanshu Bhau, who fled the country in 2022 and is currently believed to be in Portugal. He had also claimed responsibility for the murder of a

man at a food outlet in Delhi.In May, a similar shooting was carried out at a car showroom in West Delhi's Tilak Nagar and the same gang was suspected to be behind the attack. Sources ₹ 5 crore was demanded from the owners of the 'Fusion Cars' showroom. The second shooting took place in southwest Delhi's Mahipalpur when a bike-borne shooter fired at least 5-6 rounds at the Hotel Impress and damaged its glass gate.According to sources, the firing was done to extort money and take over the hotel. Last year, a man had threatened the hotel owner in the name of Canada-based gangster Goldie Brar.

Brar, along with gangster Lawrence Bishnoi, who is currently lodged in a jail in Gujarat, are also accused of carrying out a shooting outside the Mumbai residence of Bollywood actor Salman Khan earlier this year.

Centre to begin census from 2025, Lok Sabha seats delimitation by 2028: Sources

The government plans to begin the long-delayed Census in 2025, which will be followed by delimitation of Lok Sabha seats, sources said

New Delhi: The government is expected to begin the census, an official survey of the country's population, in 2025 after a four-year-long delay, sources said on Monday. The process will begin in 2025 and is expected to continue until 2026. Following the Census, the delimitation of Lok Sabha seats will commence, and this exercise is likely to be completed by 2028, the sources added. This development comes amid demands from several opposition parties for a caste census. However, the government has not yet made a decision, and the details of the census process are yet to be made public.

However, sources indicate that next year's census may also include surveys of sub-sects within the General and SC-ST categories, in addition to the



usual categorisation by religion and social class, as well as counts of General, Scheduled Castes, and Scheduled Tribes.Following the reports regarding the census, the discussion on the caste census has restarted. Congress leader Manickam Tagore, said that the central government's refusal to conduct a caste census constitutes a betrayal of OBC communities. He tweeted, Modi's refusal to conduct a Caste Census is a clear betrayal of OBC communities. Ignoring the voices demanding justice, he's denying our people their due representation--all because of political arrogance," Tagore said, also asking, "Will RSS, JDU, &TDP stand with the people or stay silent?"

The census, typically conducted every ten years to update the National Population Register (NPR), was scheduled for 2021 but had to be postponed due to the Covid pandemic. Now, the census cycle is also expected to change. Tirupati's ISKCON Temple Gets Bomb Threat, 4th Hoax Mail In 3 Days

New Delhi: Tirupati's ISKCON temple received a bomb threat on Sunday. Temple authorities registered a complaint with the police about receiving a threatening email, claiming ISIS terrorists would blow up the temple. Tirupati police initiated immediate action and conducted searches. The local police got bomb squads and dog units to check for any explosives. However, no explosives or any other objectionable items were



recovered from the temple premises.Circle Inspector Srinivasulu confirmed the news and assured that appropriate and necessary efforts were underway to identify those responsible for the threats. The police is suspecting it to be yet another hoax mail.

This is the fourth hoax mail the temple town of Tirupati received in the last three days. Earlier on Saturday, two hotels also received bomb threats, which were later confirmed as hoax threats. Before that, three other hotels in the town received bomb threats, heightening the anxiety among residents and devotees. The threat reportedly mentioned the alleged drug trafficking network kingpin Jaffer Sadiq, who was arrested in Tamil Nadu by the Narcotics Control Bureau and the Enforcement Directorate.

Biker, father held for injuring cops after being stopped for modified motorcycle silencer in Delhi

NEW DELHI: A police inspector and a constable have been injured after being allegedly attacked by a man and his 24-year-old son in southeast Delhi on Saturday night while initiating action against them for an unlawfully modified motorcycle silencer, officials said. The incident occured when police personnel stopped the man, Asif, when his Royal Enfield motorcycle was making excess noise. An altercation ensued between the police and the accused when the latter attempted to initiate legal action over the matter, which led to a scuffle, injuring Inspector Narpal Singh and Constable Ramkesh.

Around 8.45 pm, when the SHO along with the patrolling staff reached Batla House in Jamia Nagar, he

⊳Days after a breakthrough in border talks with China, defence sources have confirmed that disengagement at Eastern Ladakh's Depsang and Demchok is in its final phase, with the first patrols set to resume by month's end.

New Delhi: Days after a recent breakthrough have confirmed that disengagement in Eastern Ladakh's Depsang and Demchok areas is nearing completion. The first patrols along the Line of Actual Control (LAC)—where tensions have remained high since the 2020 Galwan Valley clash-are expected to resume by the end of the month, sources said. The disengagement process, now in its final phase, involves both sides dismantling temporary structures and fortifications built over the past four-and-a-half years in these contested areas after the border standoff in 2020, sources said. The temporary structures being dismantled include prefabricated sheds and tents used to house equipment, vehicles, and troops. Sources indicate that crossverification of the dismantling is likely to be completed by tomorrow (October 29), a step required for official acknowledgment of the



disengagement.

Once verification is finalised, both India and China will confirm the cessation of tensions in these areas.External Affairs Minister S Jaishankar announced on Sunday (October 27) that India and China would soon resume patrolling along the Line of Actual Control (LAC) in Ladakh, restoring the arrangement as it was in April 2020, before the border

Banks' unsecured loans grow at double-digit rate

NEW DELHI. Despite persistent concerns raised by the banking regulator, the unsecured retail loan portfolios of banks have been growing but at a calibrated rate, early second quarter bank results

HDFC Bank, the largest private sector bank, reported a 10% growth in the unsecured loan portfolio in the September quarter. ICICI Bank, the second largest private sector bank, posted 17% growth in personal loans while 28% growth in credit card loans. Kotak Mahindra Bank saw its personal and consumer durables loans grow at 17%, while credit card loans grew at 15%.Personal loan disbursal by Yes Bank contracted by 5% even though credit card loans surged by 48.6%. For Yes Bank, personal loans account for 15% of its total advances, while credit cards are just 6% of the loan portfolio.

HDFC Bank CFO Srinivasan Vaidyanathan, in an analyst call, said that in the recent year, the bank slowed the unsecured loan to a rate of growth of 10%. "In the recent time periods, 1 to 2 quarters this year, we slowed it down to between 9% and 10% rate of growth. And if you look at the year before, we grew at 19%..." he said.Ashok Vaswani, CEO, Kotak Mahindra Bank, said in an analyst call that the bank's unsecured retail business 'has dipped a little bit to a shy of over 11%. He admitted that in the credit card business, they have also seen some level of credit stress due to the overleveraging of certain kinds of customers. Among PSU banks, Bank of Baroda reported a 25% year-on-year growth in personal loan.

For the bank, personal loans account for around 13.8% of total advances in the second quarter, compared to 13.22% in the year-ago period. The third quarter may, however, see a strong growth in unsecured lending by banks due to the festive season. Among the sectors, logistics and operations experienced the highest growth, with a 70% increase in job postings. Retail and ecommerce followed with a 30% rise, while the restaurant and hospitality sector grew by 25%.

Logistics and mobility leaders like Rapido, Delhivery. Ekart, and Shiprocket have posted over 30,000 openings for roles such as warehouse managers, logistics associates, inventory managers, and delivery drivers. The retail and e-commerce sector is expanding, adding 18,000 roles, including Category Growth Managers, Sales Associates, and Customer Support Managers, to enhance the consumer experience.In hospitality, 14,000 jobs have opened for positions like restaurant managers, front office staff, and administrative personnel.

Tier-2 and Tier-3 cities are also experiencing a significant rise in job opportunities. While tier-1 cities have seen a 20% increase in job postings, the demand in tier-2 and tier-3 cities is even more

Karnataka's proposal will hit beer industry very hard: **Brewers Association**

BENGALURU. The Karnataka government's proposed amendments to reclassification of beer will hit the beer industry in the state very hard, said the Brewers Association of India (BAI), which represents the country's largest beer makers. Also, it has proposed a hike in the minimum beer price.

Last month, the Karnataka government proposed amendments to restructuring of taxes as well as reclassification of beer, asking manufacturers to declare the sugar content in the beer and limit the addition of sugar to 25% in beer.

Brewers in Karnataka have already objected to these proposals, and on Sunday, the BAI said the proposed amendments would work against both the government and



industry.Vinod Giri, the Director general of the BAI, said, "Beer has no sugar in it. There is a definition of beer set by the FSSAI which is followed by all

states, and we don't see the need to change them by one state."He said the larger concern is regarding putting it up on the label. "Beer labels are already cluttered with so much statutory information and warnings. Adding more information, especially when it is not even relevant, will just make them more cluttered and unappealing," he added. Also, on the proposed hike in the minimum price of beer, he said, if implemented, it would be the third increase in tax on beer in the last 15 months. The draft notification proposes to increase the excise duty on strong beer by 100% to Rs 20 per bulk litre and increases the minimum billing price for beer in the state to Rs 300 per case. In its letter to the government, the association states that the taxes on beer have already been increased twice in the last year.

Many just cannot reconcile to the fact that after their term of Life Cover ends at a specified age, they will not get any pecuniary benefit or returns for the premium paid.

Now, if one starts looking at pure (term) life insurance as an 'investment', then the only way to maximise returns would be to hope to die soon after taking a policy, before the next premium becomes payable. The return on investment in such a case would be phenomenal!!!

On a more serious note, while many recognise the emotional turmoil and void left behind by a death in a family, most still prefer to turn a blind eye to the huge financial void too that it often also leaves

behind. I have seen far too many cases of families used to leading a very comfortable, if not luxurious life, suddenly finding their world turning upside down following the death of an uninsured or under-insured breadwinner.It is heartbreaking, even from a distance, to see the way the dreams and aspirations of the children, especially in such families, come crashing down. It is thus prudent for everyone who has even a single financial dependent to not just insure but adequately insure themselves.

How one arrives at the figure of 'adequate' insurance to ensure that every dream one has for loved ones is met is not something that can be captured merely with an arithmetical calculation as many websites and 'experts' profess.

It requires a detailed evaluation session with one's advisor, who can take a holistic view of where exactly one stands with their current investments and what it would cost 'financially' to replace one in the event of an untimely exit.

A no-frills insurance term plan will usually serve the objective of pure life insurance most costeffectively. And for those that live in the big cities and towns especially, it is worth looking at a critical illness cover top-up too.Rest assured, if one remains healthy and stays on after adequately insuring oneself, nobody will complain. But do not make the mistake of not insuring or underinsuring yourself. It could make all the difference to not just the lifestyle but also the dreams and aspirations of one's

Sensex rises 900 points. What's behind the stock market rally

IndiGo share price tumbles over 10% after Q2 results. Buy, hold or sell

IndiGo shares plunged over 10% in early trade on Monday after its parent company, InterGlobe Aviation, reported a net loss of Rs 987 crore in the September 2024 quarter.

The shares crashed as much as 13% on Monday, reaching a low of Rs 3,778.50. At 10:54 am, shares of the company were trading 7.66% lower to Rs 4,030.35. The loss, attributed to elevated fuel costs and disruptions due to grounded aircraft, contrasts sharply with the Rs 189 crore profit the airline posted in the same quarter last year and the Rs 2,728 crore profit from the June 2024 quarter. Despite the dip in profitability, the company reported a 14% year-on-year growth in revenue from operations, which rose to Rs 16,970 crore. While the market had braced for a weak quarterly report, the actual figures were more disappointing than anticipated. IndiGo noted that the second quarter is typically softer, but challenges related to aircraft groundings and higher fuel prices compounded these pressures.

Jefferies, which has retained a buy rating with a revised target price of Rs 5,100 (from Rs 5,225), highlighted the significant costs linked to grounded aircraft but expressed optimism for capacity improvements in coming quarters.

While current yields have taken a hit, Jefferies maintains a positive view for medium-term growth.Kotak Institutional Equities, which also

How retirement planning is tough in India

NEW DELHI. It is that time of the year when you are in a spending mode. You are buying something for yourself or your loved ones. You care about your family and ensure you are with them to celebrate your time together. You do that year after year.At some point in your life, you would like your children or loved ones to do the same thing for you and their families. You need to do financial planning to ensure a smooth transition of responsibilities from one generation to another. That must start when you are not the responsible one. When young and independent for the first time, you are keen to explore the world. There is barely any time to think about financial planning or retirement. A real estate firm Anarock survey for the industry body FICCI showed that the two younger generations, Gen Z and Millennials (people born after 1980), barely think about retirement planning. There is very little interest in the subject among the young. That is perhaps a systemic problem in India.

In the 80s and 90s or even 2000s, there were fewer people under the age of 30 or 40 who were wealthy. However, India today boasts the highest number of billionaires after the United States.

There is a surge in entrepreneurship and the gig economy that is putting money into the hands of people much earlier than the previous generations. Tax-friendly policies and easier tax compliance processes mean more people are filing returns and paying taxes than ever. The government's personal tax collection is higher than corporate taxes for the first time. More people are filing returns as professionals. Retirement planning among gig economy professionals like actors, creative support staff, or those employed in sports and related events is virtually nonexistent due to the lumpy nature of their income.

When you talk about retirement planning, a thumb rule is that you can withdraw 4% of your savings without affecting the future growth of their value. However, a study published earlier this year and quoted in the latest National Stock Exchange monthly bulletin shows that it is hard for Indian retirees. Considering inflation over 20 of retirement portfolios skewed towards fixed deposits, retirees in India can withdraw much less than 3.5% of their savings yearly. That means you need to do two things. You need to start

retirement planning early and ensure a meaningful asset allocation to ensure that you can beat inflation and have enough resources to pay for 20–25 years of retirement expenses. There is a lot of merit in making retirement planning a key focus area for the government. The current government schemes of defined benefits have fiscal implications and cannot be overextended. The National Pension Scheme's success and increased adoption show interest in defined contribution schemes that offer market returns. The government should consider making pension income taxfree for senior citizens. Everything that individuals take out as retirement is long gestation money. That money should not be taxed into the hands of the individual.Tax benefits should apply to retirement savings withdrawn 20 years or later. That would provide an incentive for everyone to start retirement planning early. What can you do?

India's reliance on imported oil, natural gas grows as stagnant domestic production lags demand growth

NEW DELHI. India's reliance on imported crude oil and natural gas grew further in the first half of the current financial year as the delta between consumption growth and the more or less stagnant domestic production continued

The country's oil import dependency in April-September (H1) was 88.2 per cent, up from 87.6 per cent in the year-ago period and 87.8 per cent for the full financial year 2023-24 (FY24), per latest data from the oil ministry's Petroleum Planning & Analysis Cell (PPAC). Import dependency in the case of natural

gas was 51.5 per cent in the first six months of FY25, up from 46.8 per cent a year ago and 47.1 per cent for the full FY24.India's energy demand has been rising rapidly, leading to higher oil and gas imports. Reliance on imported oil has been growing continuously over the past few years, except in FY21, when demand was suppressed due to the COVID-19 pandemic. The country's oil import dependency stood at 87.8 per cent in FY24, 87.4 per cent in FY23, 85.5 per cent in FY22, 84.4 per cent in FY21, 85 per cent in FY20, and 83.8 per cent in FY19Heavy dependence on imported crude oil makes the Indian economy vulnerable to global oil price volatility, apart from having a bearing on the country's trade deficit, foreign exchange reserves, rupee's exchange rate, and inflation. The government wants to reduce India's reliance on imported crude oil but sluggish domestic oil output in the face of incessantly growing demand for petroleum products has been the biggest roadblock. In the case of natural gas, the government wants to increase its consumption and share in the country's primary energy mix to 15 per cent by 2030 from over 6 per cent currently. The rationale behind the push for natural gas, even though it

would lead to higher gas imports, is rather simple. Festive offer

Natural gas is far less polluting than conventional hydrocarbons like crude oil

and coal, and is usually cheaper than oil.



It is also seen as a key transition fuel. To be sure though, the government has also been pushing India's oil and gas companies to increase domestic production of natural gas in a bid to keep import dependency levels under check.India's crude oil imports rose to 120.5 million tonnes in H1 from 115.9 million in the year-ago period, while domestic production declined slightly to 14.4 million tonnes, per PPAC data. The country's gross oil import bill in the first

six months of FY25 rose nearly 12 per cent year-on-year to \$71.3 billion. Natural gas imports rose 23 per cent yearon-year to 18.98 billion cubic metres in H1, and cost \$7.7 billion against \$6.5 billion a year ago.In early 2015, the government had set a target to reduce

reliance on oil imports to 67 per cent by 2022 from 77 per cent in 2013-14, but the dependency has only grown since. Cutting costly oil imports continues to be a key focus area for the government, which has taken a number of policy measures to incentivise investments in India's oil and gas exploration and production sector.Reducing oil imports is also one of the fundamental objectives of the government's push for electric mobility, biofuels, and other alternative fuels for transportation as

well as industries. While there has been a pick-up in electric mobility adoption and blending of biofuels with conventional fuels, it is not enough to offset petroleum demand growth. Total domestic consumption of petroleum products in April-September was 117.7 million tonnes, of which just 13.8 million tonnes came from domestically produced crude oil, resulting in a self-sufficiency level of 11.8 per cent, per PPAC data.

Love how teams are playing Tests now: MS Dhoni backs resultoriented approach

New Delhi. Former India captain MS Dhoni has praised the aggressive, result-oriented approach, known as "Bazball," that teams are embracing in Test cricket today. This style, popularly known as "Bazball," coined after current England captain Brendon McCullum, emphasizes risk-taking and bold strategies to achieve a result rather than settling for a draw. Dhoni, known for his astute cricketing mind and calm demeanor on the field, emphasized how Test cricket has evolved to fit this era of aggression and positive results. "You can give cricket any term that you want to," Dhoni said. "What we have seen is cricket has evolved. The way people are playing cricket is very different. There was a time when in ODIs something was considered a safe score; now that score is not safe in T20s too."Reflecting on the days when he represented India in 90 Test matches, Dhoni revealed how he sometimes found it challenging to maintain motivation during matches that seemed destined for a draw. "For me, the most difficult time during a Test match was the fifth dayâ€æwhen you knew that 100% it is going to be a draw," he noted. "I would still need to keep for nearly 2.5 sessions, and that was the most tiring part. You see there is no result happening; you are just going through the motions."

For Dhoni, this old-style Test cricket meant extended hours of physical and mental exertion with no reward, a sentiment shared by many players who understand the intensity of a five-day game. His endorsement of the aggressive approach stems from a desire to maintain fan engagement and ensure that the result speaks for itself, offering viewers a more dynamic experience. Dhoni has always been vocal about the entertainment value of cricket, and he believes the new approach addresses the lingering issue of inconclusive results in Test cricket. "Imagine telling someone who doesn't know much about cricket: we play over five days, and after all that, we don't get a result. That's not nice for the game," he said. The thrill of competitive action, and the challenge of swinging a match in four days or even after a weather delay, Dhoni said, speaks to the "beauty of Test cricket."The "Bazball" approach has not only increased the number of results but has also injected new life into Test matches, attracting fans who might otherwise prefer the high-octane excitement of limited-overs cricket.

Arsenal boss Mikel Arteta rues more injury additions after draw vs Liverpool

New Delhi. Arsenal manager Mikel Arteta praised his team's resilience after managing a 2-2 draw with Liverpool on Sunday but expressed frustration over a worsening injury crisis as the Gunners' push for the Premier League title faces mounting challenges. Despite the positive result, Arteta's squad saw two more defenders added to an already long injury list. The Gunners were missing several key players from the start, including captain Martin Odegaard and defender Riccardo Calafiori, both sidelined with injuries, while William Saliba was absent due to suspension. The defensive issues worsened when Gabriel Magalhaes and Jurrien Timber were both forced off during the second half, leaving a depleted backline to handle the closing stages. After the match, Arteta praised his squad's tenacity but admitted the situation was difficult. "I'm very proud of the team, especially with the situation we're going through at the moment," he said, referring to the injuries. "We have to adapt, and we will continue to adapt. The courage they showed today was unbelievable."

Gabriel's injury seemed particularly worrying for Arteta, who admitted, "He could not run. I don't know if it's the knee joint or the ankle." Timber's condition also remains uncertain, adding to the defensive uncertainty. Despite the injuries, Arsenal took an early lead when Bukayo Saka, returning from injury, scored his 50th Premier League goal in the ninth minute. "I just had this game in my mind, that I would do everything I can to come back for it," Saka told Sky Sports, highlighting his determination to contribute in such a highstakes clash.

The 2-2 draw leaves Arsenal in third place with 18 points, trailing behind Liverpool on 22 points and leaders Manchester City on 23. Arteta remained optimistic but conceded that he would rather be five points ahead of City than five behind. "The team is alive, the team wants it," he emphasized, underscoring Arsenal's ambition despite their injury setbacks. The Gunners hope for a quick recovery for Odegaard, who has been out since September. The Norwegian hinted in the matchday program that he's nearing a return, but Arteta cautioned, saying he's "still a bit far" from playing again. Reflecting on the challenging circumstances, Arteta remained determined. "This is football. Circumstances are going to make us better, they are making us better," he concluded, keeping a positive outlook as Arsenal look to navigate the season's physical demands.

Shikhar Dhawan backs Rohit Sharma: 'A good captain is not just about wins and losses'

Former opener Shikhar Dhawan, while speaking to IndiaToday.in has backed Rohit Sharma, saying that it is unfair to judge the Indian captain after just one Test series loss to New Zealand. Dhawan said that captaincy is not just about wins or losses.

New Delhi. Rohit Sharma may have become the first India captain to lose a home Test series in 12 years, but his friend and former opening partner Shikhar Dhawan does not see the New Zealand loss as a point of In Pune, the Indian captain's strategy of concern. The former opener reckons questioning Rohit after just one series loss is unfair, especially when he led India to the ICC Men's T20 World Cup title triumph just six months ago."The pressure you all talk

about isn't something we feel. While there is pressure in the game, we don't dwell on losses or wins; that's part of the game," Dhawan told IndiaToday.in. "I feel that's neither a fair nor a practical approach toward anything," he added, defending his captain and close friend.

Rohit's captaincy came under the scanner during the first Test against New Zealand in Bengaluru, where he admitted to a significant misjudgement of pitch conditions. India suffered a historic collapse after Rohit decided to bat first in

Bengaluru, bowled out for their lowest total (46) at home, and lost to New Zealand for the first time in 36 years. The series only grew more contentious when Rohit Sharma's cautious captaincy on Day 1 in Pune drew criticism from prominent voices in the cricketing world, including Sunil Gavaskar, Ravi Shastri, and Simon Doull.

Formula One: Carlos Sainz wins Mexico GP as Max Verstappen gets penalised twice

New Delhi. Carlos Sainz clinched an emotional victory at the Mexico City Grand Prix, marking Ferrari's first win at the venue since 1990 and the fourth of his career. Meanwhile, Red Bull's Max Verstappen, who started on the front row with Sainz, encountered a challenging race. Verstappen received two 10-second penalties following aggressive encounters with McLaren's Lando Norris, who later criticised the Dutch driver as "dangerous" over team radio. Verstappen ultimately finished sixth, surrendering some ground in the championship, as Norris's second-place finish reduced Verstappen's lead to 47 points with just four races left. Ferrari's Charles Leclerc completed the podium, having initially run close to Sainz, but fell to third after Norris overtook him in the closing laps. Despite missing out on a Ferrari one-two, Leclerc secured an additional point for setting the fastest lap. The race saw Verstappen take the lead from Sainz on the long opening straight, but a safety car intervention after an opening-lap collision between Yuki Tsunoda and Alex Albon neutralised his advantage. Sainz reclaimed the lead soon after the restart, overtaking Verstappen with the help of DRS on lap nine. Verstappen's penalties, served on lap 27, pushed him back to 15th, forcing a fierce battle to recover places.

Mercedes drivers Lewis Hamilton and George Russell finished fourth and fifth, respectively, following a tense duel in the race's final stages. Kevin Magnussen of Haas achieved a solid seventh-place finish, followed by McLaren's Oscar Piastri in eighth and Haas teammate Nico Hulkenberg in ninth. Pierre Gasly of Alpine rounded out the top 10, bringing his team closer to seventh place in the Constructors' standings, currently held by Williams.Sergio Perez faced a disappointing home race. The Mexican Red Bull driver was penalised for a false start after lining up outside the designated grid box and ended up 17th after a series of on-track scuffles, including a collision with Liam Lawson that damaged his car.The crowd witnessed yet another captivating battle between Verstappen and Norris, as stewards took a strict stance after the previous weekend's controversies in Austin. The incident-packed race concluded with Sainz comfortably ahead of Norris by 4.7 seconds, while Leclerc trailed 34.3 seconds behind his Ferrari teammate. Aston Martin's Fernando Alonso was forced to retire on lap 15 due to cooling and brake issues in his milestone 400th Formula One



me during the weekend," said Martin.


