EC rejects Congress's allegations of irregularities in Haryana poll

New Delhi, Oct 29: The Election Commission on Tuesday rejected allegations levelled by the Congress over irregularities in the just-held



Haryana assembly polls, saying the party was raising "the smoke of a generic doubt" about the credibility of an entire electoral outcome like it did in the past. "This is least expected of a national political party. The commission appreciates the criticality of the considered views of political parties in sustaining and strengthening electoral democracy in the country and assures that it will remain committed towards timely grievance redressal," it said in a letter to Congress president Mallikarjun Kharge. The poll authority said that "once again", it

was compelled to note that with "no evidence whatsoever" of any statutory electoral step being compromised, the Congress has once again raised the smoke of a generic doubt" about the credibility of an entire electoral outcome exactly in a similar manner as it has done in recent past". "At the same time, the commission sincerely urges the INC to take firm and concrete steps, match-

ing with the party's long and illustrious standing, to amend their .. approach...," it added. The commission said that such "frivolous and unfounded" doubts have the potential of creating "turbulence" when crucial steps like polling and counting are in live play, a time when both public and political parties' anxiousness is peaking.

Govt creating system that gives opportunity to every youngster: PM Modi

New Delhi, Oct 29: Asserting that it is his government's commitment to providing

employment to a maximum number of youngsters, Prime Minister Narendra Modi said on Tuesday that a system is being created that gives opportunity to every youth and allows them to fulfil their aspirations. Addressing a 'Rozgar Mela' after distributing appointment letters for government jobs to over 51,000 people, he spoke of his government's efforts to boost the presence of new technologies and modern sectors such as space and semiconductors so that new employment opportunities are created. In his video address, Modi said earlier governments lacked in policy and intent, leading to India falling behind the world in rising sectors, including in modern technologies. Old and outdated technologies used to be brought to the country, he added. "A

mindset existed that believed modern technologies cannot develop in our country. This mindset did us a lot of harm," he said, stressing that if industries which generated employment in the modern world did not exist in the country, then creating new

employment opportunities would be difficult. "We and airports underway in the country, Water and began work to rid the country of this old mindset of earlier governments," Modi said, adding that poli-

cies and decisions of the government have a direct bearing on employment. The prime minister said it is his government's commitment to give jobs to maximum number of people and cited the allaround infrastructure works such as the construction of expressways, highways, ports, rail networks

gas pipelines are being laid, and schools and universities are being opened, he said, asserting that

development works are not only giving facilities to people but also creating employment opportunities. ED cracks down on Fairplay betting app, Rs 4 crore seized in latest raids

New Delhi, Oct 29: The Enforcement Directorate (ED) has conducted searches at eight locations in Mumbai and Kutch, Gujarat, in connection with the Fairplay betting app case, seizing documents, cash and electronic devices worth Rs 4 crore. This brings the total seizure in the case to Rs 117 crore. ED's investigation was prompted by an FIR filed by Viacom18 Media Pvt Limited with the Nodal Cyber Police, Mumbai, against Fairplay Sport LLC and others for violating various sections of the IPC, Information Technology Act, and Copyright Act, resulting in revenue loss of over Rs 100 crore.



New Delhi, Oct 29: The Congress on Tuesday levelled fresh conflict of interest charges against SEBI chief Madhabi Puri Buch, with Rahul Gandhi claiming a "Monopoly Bachao Syndicate" was at work, at the core of which was a "dangerous nexus" among the Adani Group, key regulatory bodies, and the BJP. The opposition party alleged that Buch rented out her property to a company associated with an individual connected to the IndiaBulls Group which was under the stock market regulator's scanner. There was no immediate reaction from either Buch or the Adani group on the allegations. However, previously both the SEBI chief and the Adani group had separately dismissed allegations of any wrongdoing. The opposition party also alleged that Buch has been associated with Predible Health Private Limited, holding equity in it, and she continued to hold shares in the company even after becomparty further pointed out that Jacesa Investments Limited, which is based out of



St Vincent and The Grenadines and invested in Predible Health Private Limited, is listed in offshore leaks by Paradise Papers shared by ICIJ. Addressing a press conferhead Pawan Khera also alleged that Ananth Narayan Gopalkrishnan, who

became a whole time member at SEBI on October 10, 2022, also rented out his property in Mumbai to a stockbroker hired by a brokerage firm called IMC India Securities, which is regulated by SEBI, and received Rs 64.8 lakhs in rent. "This betrayal compromises national security and jeopardises our youth's future," Gandhi said. "Previously, we exposed how the 'Adani Bachao Syndicate' thrives through the complicity of institutions like SEBI under Madhubi Buch, who is accused of manipulating the system to protect Adani's inflated valuations," he said. Gandhi said Buch's role raises serious questions about regulatory capture and the erosion of institutional integrity in favour of corporate interests. "The Congress party has consistently raised alarms about this growing syndicate, exposing how Buch and others are serving those in authority.

"Of the 14 men, aged between 18 to 40 years, held in Jagargunda, three carried a bounty of ?1 lakh each. The trio included Barse Hadma (25), a militia commander, and Barse Nagesh (20) and Hemla Jitu (18), who were working with CNM (Chetna Natya Mandli, a frontal wing of

Maoists)," the statement added. The five Maoists arrested from Bhejji were allegedly involved in the murder of a villager in Bhandarpadar in September and an electrician engaged in laying a power transmission line in the same village in February this year.

No plans to hand over IMH to NGOs, clarifies TN health minister

CHENNAI: Health Minister Ma Subramanian, on Monday, said that the Institute of Mental Health will not be handed over to any NGOs or private organisations, as reported on social media platforms.Responding to queries from reporters on Monday, Subramanian said that in all hospitals, activities under Corporate Social Responsibility (CSR) funds are taken up and the same will be encouraged in IMH. However, IMH is not going to be transferred to NGOs or private companies. This comes after Health Secretary Supriya Sahu's recent letter to the Director of Medical Education Dr J Sangumani to prepare a proposal to convert the Institute of Mental Health into an organisation managed by a not-for-profit wholly government-owned company, registered under Section 8 of the Companies Act.In the letter dated October 23, the health secretary said this would ensure the government company setup has financial and administrative flexibility and get the required expertise from the company's board. The health secretary had said, the present organisational set-up is not capable of handling the transformational change that is required at IMH.

Burns ward IN kmc WILL HAVE 25 BEDS Health Minister Ma Subramanian opened an exclusive burns ward at the Government Kilpauk Medical College Hospital for treating cracker burns during Deepavali. The ward with 25 beds started functioning on Monday. Of 25 beds, 12 were allotted for men, eight for women and five for children.

Telangana govt to develop 17K kilometres of rural roads in PPP mode

HYDERABAD: The state government aims to construct and develop 17,300 km of rural roads in all constituencies in Public Private Partnership (PPP) mode.Currently, a total road network of 68,539.27 km is under the Panchayat Raj department. This includes 26,146.83 km of BT (black top) roads, 7,752.10 km of WBM (Water Bound Macadam) roads, 4,146.63 km of CC (cement concrete) roads and 30,493.72 km of earthen roads. These roads have been damaged by heavy rains in recent years, especially from July to September this year.

Based on recent damage assessment and reports from various districts, the government has decided to prioritise the restoration of 17,300 km of roads. According to sources, the government now aims to construct BT roads connecting every village panchayat to the mandal headquarters, by eliminating the WBM and earthen roads.

As per the Panchayat Raj department's estimates, Rs 12,000 crore is required to develop and construct these roads. The government aimed to complete the construction and developing of 5,000 km roads in 2024-25, 4,000 km in 2025-26, 5,000 km in 2026-27, and 3,300 km in 2027-28. The government's plan includes upgrading the current road capacity from 10 metric tonnes to 30 metric tonnes.

Andhra government sanctions Rs 895 crore for free cylinder

VIJAYAWADA: The TDP-led NDA government has given administrative sanction to release Rs 895 crore towards the payment of subsidy to oil companies to launch Deepam scheme in the State on Deepavali.As part of the scheme, eligible people will receive three cylinders per year for free. Chief Minister N Chandrababu Naidu is likely to handover the first refill to a beneficiary in Somepeta of Srikakulam district on November 1. The amount of Rs 895 crore will be credited into the Pool Account with Oil Marketing Companies by the State government. Payment of State subsidy to the beneficiaries will be made after delivery of the cylinder through PFMS (Public Finance Management System) asDBTL(Direct Benefit Transfer of LPG).

Providing three LPG cylinders per year is one promise among the 'Super Six' guarantees announced by TDP and Jana Sena in the run upto the general elections. It was estimated that Rs 2,684.75 crore is required for the supply of three LPG cylinders annually.

The State Cabinet recently gave its approval for implementation of the scheme from Deepavali. It is learnt that Chief Minister N Chandrababu Naidu will hand over the free LPG cylinder to a beneficiary in Sompeta of Srikakulam district on that day. Stating that all the eligible women will get the three gas refills at a free of cost per year under 'Deepam' scheme, Civil Supplies Minister Nadendla Manohar said that LPG connection, white ration card and Aadhaar card are enough to get the benefit under the scheme. Booking of cylinders will begin on October 29 and the delivery will be made on October 31.Out of all the three gas cylinders to be supplied at a free of cost per year, beneficiaries can get the first cylinder before March 31, second one before July 31 and the third one before November 30.

After booking, it will take 24 hours and 48 hours for delivery of the LPG refills in urban and rural areas respectively and the subsidy will be directly credited into the accounts of the beneficiaries within 48 hours after the delivery of the cylinder. Customers can lodge their complaints if any to toll free

University of Madras to implement **NEP's Academic Bank of Credits**

CHENNAI: Though the state government is still maintaining its stand against the National Education Policy (NEP), it may be making its way into state universities. The University of Madras, in its recent Senate meeting, has decided to implement the Academic Bank of Credits (ABC), an essential component of NEP. The NEP 2020 calls for the implementation of a creditbased system as it facilitates flexible and integrated education opportunities. ABC envisages digitally storing academic credits earned by students from various recognised higher educational institutions (HEIs). The system has been designed to support the seamless transfer and redemption of credits across HEIs in the country. It helps in the implementation of multiple exit and entry systems. The Senate has passed a resolution to create ABC IDs for all students enrolled in undergraduate, postgraduate and diploma courses in the university and its affiliated colleges and also for students of the Institute



of Distance Education (IDE)."UGC has set a deadline of December 31 for the creation of ABC IDs. If we defy it, it will end any opportunities for us to get funding from it. The senate also passed a resolution to rename Adding to it, our students will also suffer," said a faculty in the university. "With no funding from the state government and no clarity on the implementation of State

Education Policy (SEP), it may not be wise to disobey all orders of UGC," said a varsity official.

the university's Human Resource Development (HRD) Centre as Malaviya Mission Teacher Training Centre, which is also a part of NEP. UGC has mandated the

renaming of these HRD centres, which are funded by it, across the country. According to official sources, since last year, UGC has asked them to change the name of the centre and conduct capacity-building programmes among college teachers for the implementation of NEP 2020. However, the university had been sitting over it."It was essential to pass both the resolutions as we have been avoiding them for too long. However, a final call on the implementation of these decisions will be taken by the state government as we are not an autonomous body," said a member of the Senate.

However, few Senate members opposed the implementation of these decisions as the state government has been opposing the NEP."Just because the Centre and State are not on the same page and have differences over NEP, five of our state universities are suffering without vice-chancellors. Then how can we allow implementation of these resolutions," said another Senate member.

A year after Attibele cracker blast, fire department on toes this Deepavali

around the corner, the fire and emergency services department has increased vigilance and is enforcing stringent safety protocols for firecracker stalls, especially in the wake of last year's firecracker blast mishap in Attibele in which 17 people lost their lives. However, the department's three-day training programme to educate wholesalers and retailers on safety measures that they should follow has witnessed poor response.Senior department officials told The New Indian Express that all cracker stalls must have requisite safety equipment.

The department has issued a circular outlining the safety measures that must be included while setting up temporary cracker stalls. The stalls should have a minimum of 10x10-sqft space and should be built only with non-combustible materials. There should be two doors -one at the front and another at the back. Each shop should keep a five-metre gap



from others. Stall owners should mandatorily keep fire extinguishers, sand, buckets, a first-aid kit and 200 litres of water in drums, the circular said. There should also be 'No Smoking' boards. They should also have the emergency contact numbers of the fire department and the jurisdictional police. A senior officer said they have instructed retail shop owners not to use their outlet space

should not store gas cylinders, waste paper or packaging material and use only ISI-marked electrical wires. The department has also advised retail store owners to install smoke or heat detectors and fire alarms. Another officer said cracker stall owners should undergo the three-day training programme. The training covers topics such as types of crackers, their explosive potential and preventive measures to minimise risks.He added that minor accidents can be avoided if stall owners and workers are properly trained. However, no shop keepers have come forward to attend the programme, he said. Before the stalls are set up, the fire department will inspect the areas to ensure that there is adequate open space with a minimum six-metre space for unobstructed movement of fire tenders and to check if the stalls are away from residential areas and school premises. "The fire department will deploy fire tenders as a precautionary measure near the stalls.

Telangana Skill Varsity construction to begin on November 6

HYDERABAD: The state government has finalised the designs for the Young India Skill University (YISU) buildings and Chief Minister A Revanth Reddy will formally launch the construction works on November 6.The deadline for the completion of the stateof-the-art buildings will be eight to 10 months, according to highly placed sources. It has been decided to take up construction of the administration building, academic block, workshops, girls' and boys' hostel buildings, dining hall and staff quarters on the 57-acre university site near Meerkhanpet in Kandukur mandal of Rangareddy

district.Additionally, these designs have been prepared to include an auditorium, a library, a public ground and a parking area. To accomodate 6K students

The buildings are designed in such a way that there will be open spaces and greenery



in the spacious premises. Construction will be undertaken in the campus to provide skill training and accommodation facilities for up to 6,000 students. Solar power plants will be installed on all buildings. In addition to these, workshops and academic buildings will be built with advanced designs with care being taken to ensure that they have ample light and are well ventilated. This will eliminate for ACs reduce power consumption. The chief minister instructed the architects, engineers and representatives of the Megha Engineering and Infrastructure Limited (MEIL), which has undertaken the responsibilities of construction, to build the university campus with worldclass infrastructure that can attract the attention of the entire country.It may be recalled that recently, MEIL donated Rs 200 crore for the construction of YISU. The Adani Group has also donated Rs 100 crore. Apart from these, all the funds

collected in the form of donations from various corporate companies are being deposited into the corpus fund. With this, the government hopes to ensure that the management of the university does not face any financial problems in the future.

Illegal cattle transport, slaughter continue in Palnadu, Andhra

GUNTUR: In response to growing concerns over illegal livestock transportation and slaughter in Palnadu district, authorities have announced new measures to enforce animal welfare laws and curb these activities. Despite strict regulations, unauthorised livestock transport and slaughter, especially involving cattle have continued, drawing criticism from animal welfare advocates and political leaders alike.Narasaraopet MP Lavi Sri Krishna Devarayulu recently brought attention to the issue on social media, expressing alarm over the ongoing animal cruelty and regulatory violations. He noted that many companies involved in cattle transport fail to meet legal standards, such as obtaining veterinary certificates, providing adequate space, and ensuring essential animal care.

These companies are not only neglecting welfare standards but are also collecting Rs 34,000 per vehicle illegally while disregarding Chapter IV of the Transport of Animals Rules, 1978," he stated. The MP called for immediate legislative and governmental action to enforce these laws and protect animals' rights.Recent incidents have highlighted the problem's severity. Over 50 buffaloes were reportedly crammed into a single lorry and transported illegally to an animal market in Chilakaluripet without sufficient space, food, water, or veterinary provisions. Such practices contravene the Prevention of Cruelty to Animals Act, 1960, and the Transportation of Animals Rules, 2001, which mandate adequate care, proper loading conditions, and visibly marked animal carrier boards.In light of plthis, district officials have planned to intensify inspections along highways and at cattle markets. Special teams comprising police, revenue, transport officials, and veterinary doctors will conduct regular checks. Palnadu District Collector Arun Babu has also directed market management committees to educate vendors about animal welfare laws and penalties for violations. District Superintendent of Police (SP) Srinivasa Rao added that police will increase patrols on key roads to deter illegal livestock transport.

Animal rights groups and local NGOs have also voiced their concerns, urging stricter enforcement of existing laws. Following a series of complaints, district officials conducted raids last Saturday, seizing multiple trucks involved in illegal transport and shutting down the animal market temporarily. Animal welfare activists are now calling for a permanent solution and greater vigilance. They emphasised that under the AP Prevention and Prohibition of Slaughter Act, 1977, and Transport of Animal Rules, 1978 and 2001, only certified cattle should be transported in approved vehicles with limits on the number of

State Cabinet decides to implement SC sub-quota

BENGALURU: The state cabinet on Monday decided to implement internal reservation for Scheduled Castes (SCs) and is constituting a one-man commission headed by a retired judge to study and gather empirical data, based on which the government will take further steps. The commission will be given three months to submit its report to the government. Until then, all recruitment processes will be put on hold, said Minister for Law and Parliamentary Affairs HK Patil after the cabinet meeting. However, the government did not seem to have any clarity on how to implement the internal quota for Scs.

SCs currently have 17 percent of the total reservation, and there are 101 castes among SCs in the state. The allocation of the quota was based on the 2011 census, which revealed that the SC population in Karnataka was 17.5 percent, while that of Scheduled Tribes was 6.95 percent. Many sub-castes among SCs have been demanding internal reservation, feeling they have not received adequate representation according to their population. The Basavaraj Bommai government, just before the Assembly polls in 2023, had recommended a 6 percent internal quota for SC (Left), 5.5 percent for SC (Right), 4.5 percent for

touchables, including Bhovi and Korcha, and 1 percent for others. In August of this year, the Supreme Court ruled that state governments are now constitutionally empowered to make sub-classifications within SCs.Patil told reporters that there had been a demand and discussion regarding the implementation of internal reservation. "The cabinet approved the constitution of the commission headed by a retired high court judge. The commission will collect empirical data within three months. We will decide once we receive the report," he said.

'Recruitments on Hold for at Least Three Months'

The cabinet has no clarity on how the empirical data will be collected by the commission, but stated that the government will release the terms of reference. The press conference was attended by Social Welfare Minister HC Mahadevappa, RDPR Minister Priyank Kharge, and Food and Civil Supplies Minister KH Muniyappa. No decision has been made regarding who will head the commission.Patil announced that the cabinet decided to postpone all upcoming recruitments for at least three months, until the commission submits its



report. "Starting Monday, no recruitment notification will be issued," he said. Mahadevappa noted that the BJP government had rejected the Justice Sadashiva Commission report in 2022. "Our party announced in our manifesto that internal reservation will be implemented, and we are committed to it. Various castes among SCs, including Bhovi, Lambani, SC-Left, and SC-Right, have discussed it, and they are not against internal reservation," he said. The current census report, however, does not provide data on sub-castes. Muniyappa, who

has been working on this issue for the past

many years, stated that there has been a demand for internal reservation for the last 30 to 35 years.

China Faces Stormy Future As Confidence In President Xi Jinping Crumbles

Beijing: Recently circulating on social media was a photo of a Chinese soldier wedding his bride. Behind them, an enormous slogan was emblazoned: "Listen to Chairman Xi's command; Be responsible to Chairman Xi; Let Chairman Xi rest assured." These were the kinds of slogans prevalent during the Cultural Revolution of the 1960s, promoting a personality cult for Mao Zedong. There can be no questioning the centrality of Xi in China but as the country's economy increasingly struggles, many are questioning the direction Chairman Xi Jinping has taken China. One who is critical of Xi is Desmond Shum, a Hong Kongraised businessman who was once married to billionaire businesswoman Duan Weihong. Witnessing the direction Xi was taking China, Shum departed China in 2015 and, six years later, wrote Red Roulette, a book that describes corruption within the Chinese Communist Party (CCP). In mid-October, he posted public criticism of Xi on social media, saying, "Xi is systematically dismantling the most valuable asset of the CCP: public trust. Over the past few weeks, we've witnessed the wreckage of Xi's financial policies unfolding in real-time."

Shum continued: "To me, the more pressing issue isn't merely the financial mishaps but how Xi is eroding the longstanding trust and confidence the Chinese people once had in CCP governance. While this is probably unintentional on his part, it is definitely systematic and far-reaching."He said previous Chinese leaders like Deng Xiaoping, Jiang Zemin and Hu Jintao were generally pragmatic.

Nepal Ready To Fight India? New Currency Note Set To Test New Delhi's Patience - Analysis

World. Nepalese Prime Minister KP Sharma Oli's inclination towards China is not hidden from anyone. Such is his desire to bond with China that the Nepal government is taking steps that could prove detrimental to Kathmandu's relations with New Delhi. For those uninitiated, Nepal had staked a claim on three Indian territories in 2020 -Limpiyadhura-Kalapani-Lipulekh. The disputed area, a 370-square-kilometer stretch situated in the northwestern corner of the country, has been administered by India for many years. While Nepal added these regions to its map via constitutional amendment in 2020, the areas have been under Indian control for over 200 years. Nepal shares a border of over 1,800 km with five Indian states- Sikkim, Bihar, Uttar Pradesh, Uttarakhand and West Bengal. India had maintained that unilateral decisions on paper cannot change ground reality. Now, recently, the Oli cabinet approved the inclusion of its new map with these three Indian territories on its currency note of Nepali Rs 100. The printing of the new notes will test Kathmandu's relations with India. Notably, Nepal has awarded the contract of printing its new currency notes to China Banknote Printing and Minting Corporation.

US Presidential Election 2024: Trump And Harris Present Dueling Visions Of America In Final Campaign Stretch

World. US Presidential Elections 2024 Uncertainty reigns entering the final full week of the 2024 campaign with Democrat Kamala Harris and Republican Donald Trump locked in a fiercely competitive presidential contest. What happens in the coming days will be pivotal in deciding the winner of next week's election. Trump on Sunday held a rally at Madison Square Garden where several speakers made racist and crude remarks, including comedian Tony Hinchcliffe, who described Puerto Rico as "a floating island of garbage." Shortly after those remarks, Puerto Rican reggaeton artist Bad Bunny endorsed Harris. Trump is holding a rally in Atlanta on Monday evening while Harris is making several campaign stops in Michigan, including a rally with singer-songwriter Maggie Rogers.

Harris told young voters: 'You are rightly impatient for change'. Harris urged young voters Monday in Ann Arbor, Michigan, to take the baton from "generations of Americans" who preserved freedom and back her over Trump. The pitch urged young voters, many of whom were in the audience from the nearby University of Michigan, to seize the power they want and protect a series of rights.

Harris specifically called out abortion rights, a key issue for younger voters. "Generations of Americans before us fought for freedom and now the baton is in our hands," Harris said. "I love your generation," Harris told the young audience.

Trump claimed that the US towns are being 'invaded and conquered' by 'blood-thirsty criminals'. Trump described the U.S. as an occupied nation due to illegal immigration, claiming undocumented migrants were more invasive and dangerous than a hostile occupying military. "I will rescue every city and town that has been invaded and conquered," Trump said. "You know, they have been invaded," Trump said of towns across the country, "just as though a foreign enemy was invading, a military was invading, and probably just as vicious or more vicious," the former president said.

Washington Post loses 2 lakh subscribers amid Harris endorsement row: Report

World. The Washington Post has lost over 2 lakh subscribers in the wake of the newspaper's billionaire owner and Amazon founder, Jeff Bezos, deciding not to endorse any of the two candidates for the November 5 US presidential elections, according to media reports.On Monday, Bezos defended the Washington Post's decision, saying that it "right" and "principled", and it was taken internally, not influenced by either Donald Trump or Kamala Harris. The newspaper's editorial staff were prepared to endorse Democratic nominee Harris, but publisher Will Lewis said on October 25 that the decision to choose a candidate relied on "our readers' ability to make up their own minds". In a report citing sources, the NPR media outlet said that over 2 lakh people had cancelled their digital subscriptions of the Washington Post by Monday afternoon. Monday's cancellations represented about 8 per cent of over 2 million paid subscribers, which also include for the newspaper's print edition. Not all the cancellations took effect immediately.Speaking to NPR, Marcus
Brauchli, a former Washington Post "There was no substantive serious deliberation



Executive Editor, said the cancellations were 'colossal" and the subscribers did not even know why the no-endorsement decision was taken.Marty Baron, another former Washington Post Executive Editor, expressed apprehensions about the move that came just weeks before the high-stakes

The Washington Post published a "note from our owner" on Monday evening, in which Bezos said, "Presidential endorsements do nothing to tip the scales of an election. What presidential endorsements actually do is

create a perception of bias. A perception of non-independence."Ending them is a principled decision, and it's the right one.

The billionaire businessman wrote that he wished the newspaper would end the tradition of endorsing presidential candidates "in a moment further from the election and the emotions around it. That was inadequate planning, and not some intentional strategy".

"I would also like to be clear that no quid pro quo of any kind is at work here. Neither campaign nor candidate was consulted or informed at any level or in any way about this decision. It was made entirely internally," he

Bezos further said that there was no connection between the decision and a meeting between Republican presidential candidate Donald Trump and Blue Origin CEO, Dave Limp, on October 25."I didn't know about the meeting beforehand... The meeting was scheduled quickly that morning. There is no connection between it and our decision on presidential endorsements, and any suggestion otherwise is false," he noted.

The once luxurious palace of Bangladesh's autocratic ex-leader Sheikh Hasina will become a museum to honour the revolution that ousted her, the leader of the caretaker government said Monday."The museum should preserve memories of her misrule and the people's anger when they removed her from power," Nobel Peace Prize winner Muhammad Yunus said as he toured the battered Ganabhaban palace, the former official residence of the prime minister. The 84-year-old

UN body for Palestine banned from operating in Israel despite West's concerns

Jerusalem/Cairo. Israel's Parliament passed a law on Monday to ban the UN relief agency UNRWA from operating inside the country, alarming some of Israel's Western allies who fear it will worsen the already dire humanitarian situation in Gaza. The lawmakers who drafted the law cited what they described as the involvement of some United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) staffers in the October 7, 2023, attack on southern Israel and staffers having membership in Hamas and other armed groups. The vote came the same day Israeli tanks thrust deeper into two north Gaza towns and a refugee camp, trapping about 100,000 civilians, the Palestinian emergency service said, in what Israel's military said were operations to eliminate regrouping Hamas terrorists. The Israeli military said soldiers captured around 100 suspected Hamas terrorists in a raid into Kamal Adwan Hospital in the Jabalia camp. Hamas and medics have denied any terror presence at the hospital. The Gaza Strip's health ministry said at least 19 people were killed by Israeli airstrikes and bombardment on Monday.

The Palestinian Civil Emergency Service said around 100,000 people were marooned in Jabalia, Beit Lahiya and Beit Hanoun without medical or food supplies. Reuters could not verify the number independently. The emergency service said its operations had come to a halt because of the three-week Israeli assault into northern Gaza, where Israel had said it wiped out Hamas combat forces earlier in the year-long

China Continues Military Activity Near Taiwan: 6 Aircraft, 9 Vessels Detected

World. Taiwan's Ministry of National Earlier, twenty-two Chinese aircraft and Defence (MND) reported Chinese military activity near the island on Tuesday and said that by 6 am (local time), six Chinese aircraft and nine naval vessels were detected in the region. The MND further reported that four of these aircraft crossed the median line, entering Taiwan's northern and southwestern Air Defence Identification Zone (ADIZ).

Sharing a post on X, Taiwan MND said, "6 PLA aircraft and 9 PLAN vessels operating around Taiwan were detected up until 6 a.m. (UTC+8) today. 4 of the aircraft crossed the median line and entered Taiwan's northern and southwestern ADIZ. We have monitored the situation and responded accordingly."

New Castle, Delaware. President Joe Biden has cast an early ballot in the 2024 general election. It's a bittersweet moment for Biden, who decided to end his reelection campaign in July because of growing concerns about his health and Democrats's worries about his chances of defeating former President Donald Trump. Biden voted on Monday at

the state of Delaware Department of Elections, not far from his home outside Wilmington, Delaware at an early voting site, where voters were lined up down the street to cast ballots.Biden chatted with voters as he waited in line to cast his ballot, and helped push an older woman in a wheelchair who was ahead of him. The president waited in line for about 40 minutes before he cast his ballot.

He handed his identification to the election worker, who had him sign a form and announced, "Joseph Biden now voting." As the president cast his ballot behind a black drape, some firsttime voters were announced and the room erupted in cheers for them. Outside the polling place, Biden was asked if he thought Democrats - including Vice President Kamala Harris - would win. "I think we will," he said. For all but a few years since 1970, Biden has either held office or been running for one during election season.But this year, his hopes lie with a newer generation of Democrats, including three on



the Delaware ballot looking to make history. Harris, whom Biden endorsed after dropping out, is vying to become the first Black woman and first person of South Asian descent to serve as president.State Senator Sarah McBride is looking to become the first openly transgender member of the US House.McBride, a longtime friend of the Biden family, had served as an aide in then-President Barack Obama's administration and on the campaigns in 2006 and 2010 for the president's late son Beau Biden's runs for Delaware attorney general. She also worked for former Delaware Governor Jack Markell.

Biden on Sunday evening formally endorsed Blunt Rochester, cutting a video for her campaign in which he called her "Delaware through and through".Blunt Rochester is vying to succeed Senator Tom Carper, who has held the seat since 2001 in the solidly Democratic state. He is retiring.Early voting in Delaware began on Saturday (October 26).

Ballot boxes burnt in US's Washington and Oregon, cops suspect arson

Washington. Police believe three suspected arsons at ballot drop boxes in the northwestern US states of Washington and Oregon are linked, and have identified what they believe is a suspect vehicle in Oregon, officials said on Monday.

Two separate blazes erupted on Monday in Portland, Oregon, damaging three ballots, and Vancouver, Washington, destroying hundreds, officials said. They said the two blazes resembled a third fire at a Vancouver ballot box on October 8 that did not succeed in damaging any ballots."We don't know the motive," Amanda McMillan, assistant chief of the Portland Police Department, told a news conference on Monday. "But we do know that acts like this are targeted and intentional."Potential charges for the suspect include possession of a destructive device and illegal acts related to voting machines,

among others, a Portland Police official said.

Footage from Vancouver news outlet KATU on Monday showed smoke pouring out of a ballot box in that city with multiple ballots appearing to be in flames. Local officials said voters who put their ballots in the box after 3.30 pm PDT on Saturday should contact election officials. The Vancouver Police Department said it responded to an arson attack at 4 am PDT on Monday and removed a "suspicious device" located next to the ballot box.Earlier on Monday morning, police responded to a similar incident at a ballot box in Portland, Oregon, iust across the Columbia River, caused by an incendiary device. Multnomah County's election director said only three ballots were damaged in that fire, and that those voters will be contacted to fill out replacement



ballots.Fire suppressant installed inside the boxes mitigated the damage in Portland and the first Vancouver fire, but did not function in Monday's fire in Vancouver. The Washington Secretary of State's office urged voters to check the status of their ballots online and to request a replacement if theirs was unaccounted for."I strongly denounce any acts of terror that aim to disrupt lawful and fair elections in Washington state,' Secretary of State Steve Hobbs said in a statement. "Despite this incident, I have complete confidence in our county elections officials' ability to keep Washington's elections safe and secure for all voters."The Vancouver boxes were located in the state's 3rd District, the site of one of the most competitive US House of Representatives races, featuring Democratic Representative Marie Gluesenkamp Perez and Republican challenger Joe Kent.Gluesenkamp Perez called for overnight law enforcement monitoring of ballot boxes in the district. The 36-year-old car mechanic won her race in 2022 by fewer than 3,000 votes. In Phoenix, a man was arrested.

Girl taking selfie falls into 15-ft gorge, rescued after 20 hours

TUMAKURU: None including her parents and rescuers believed that Hamsa S. Gowda (20) would come out alive after sliding into a 15-foot gorge at the sluice of Mydala tank near here and being stuck there overnight.It was a rebirth for Hamsa, who is studying in her 3rd semester of chemical engineering at Siddaganga Institute of Technology.Around 3:30 p.m. on Sunday, Hamsa and her schoolmate Keerthana visited Mandaragiri Hills, a picnic spot. The waterfall at the sluice of the tank attracted them. While taking a selfie, Hamsa slipped and was washed away. Keerthana called Hamsa's parents, who then informed the police.

A police team, led by DySP Chandrashekar and Kyathsandra PSI Chethan Kumar, along with the fire brigade, launched the operation. However, they could not trace Hamsa until 7 p.m. The operation resumed at 8 a.m. on Monday. They restricted the water flow by placing sandbags and then could hear Hamsa's screams. Though Hamsa had suffered some bruises, she was able to wave from the crevice. She was pulled out by noon, after spending nearly 20 hours in the dark space. She was shifted to the hospital, and her condition is stable. Hamsa said, "I gathered courage by praying to God and my parents. I had faith, as I had seen such rescue operations being successful on TV. I am grateful to the rescuers. I appeal to everyone not to be obsessed with selfies.'

Minister N Lokesh to meet 'suspended' RTC driver soon

VIJAYAWADA: In a surprising turn of events, HRD and IT Minister N Lokesh has come to the rescue of an RTC driver, who was recently suspended for dancing to a song from a film-Devara. The incident occurred two days ago when an RTC bus driver, Lovaraju, from Tuni bus depot stopped his bus near Koduru as the narrow road was blocked by a tractor. The bus, ferrying students from Rowthulapudi was forced to stop, and in a moment of spontaneity, Lovaraju stepped out of the bus, dancing to a popular song from Devara. The students captured the dance video and soon it became viral in social media. While the video brought smiles on many faces, the less impressed RTC higher ups reportedly suspended Lovaraju, citing a breach in

In a surprising turn of events, a video of an RTC bus driver dancing to a hit song from the film 'Devara' went viral, leading to his suspension. However, HRD Minister Nara Lokesh, currently on an official visit to the United States, has promised to stand by the driver and ensure his reinstatement. When the IT minister came across the incident through social media, he gathered the details from RTC officials and learnt that the road was blocked by a tractor. Lokesh questioned the need for such harsh action against the driver. Taking to social media platform 'X', Lokesh assured that the suspension will be revoked and he would be taken into the work immediately. Telangana govt to conduct caste survey with 52 queries

HYDERABAD: The state government is learnt to have prepared a questionnaire with some 52 questions to conduct the Kula Ganana (caste census), the comprehensive survey enumerating the socio, economic, educational, employment, political and caste aspects of households across the state.

According to sources, the government is planning to conduct the survey manually with enumerators visiting households to collect details. The questionnaire aims to find out social inequalities, educational barriers, economic opportunities and the effectiveness of government policies aimed at improving the living conditions of marginalised groups, sources added. The questionnaire includes the details pertaining to name, relationship with the head of the family, gender (duly recognizing the third gender), religion, caste (dividing into SC/ST/BC/OC), sub-caste, age, mother tongue, Aadhaar and voted ID numbers, whether handicapped, marital status, age at the time of marriage, whether children ioined school before the age of six years, nature of school, educational qualification, school dropouts from age between six to 16, reasons for not continuing studies between 17 to 40 years, reasons in case of illiterates, nature of employment, in case selfemployed - details thereof, in case unorganised sector workers - details thereof and details of caste occupation, if applicable. The queries are include those related to annual income, details of bank account, whether income tax assesse, whether suffering from any caste occupation related diseases, details of benefits obtained through reservations in terms of education and employment, whether obtained a caste certificate in case of SCs, STs, BCs, EBCs, whether belongs to nomadic community, political background in terms of currently holding post, number of terms of holding the post, number of years working as a people's representative, whether a member of nominated or corporation.

KOCHI: When Moly Cyriac left her home in Adimali at the break of dawn on October 29, 2023, all she hoped to do was attend the baptism of her cousin's daughter and whet her curiosity for the rituals of Jehovah's Witnesses. Never in her wildest dreams did she expect her life to be upended over the next few hours.As the scars and the mental trauma wrought by the blasts at the Zamra International Convention and Exhibition Centre in Kalamassery, where the baptism was to be held on the day of the convention, refuse to recede, the 59-year-old survivor is having difficulty leading a normal life. She still shuttles between Adimali and the Ernakulam Medical Centre (EMC) hospital for regular followup treatment and check-ups.

A Roman Catholic, Moly was invited to attend the baptism of her beloved Venus. "I did not want to miss the ceremony for the world. I don't belong to the community and had not attended any of the sect's events. However, since that fateful day, life has been a constant struggle."Moly sustained more than 50% burns and was admitted to the intensive care unit of EMC. "I was under treatment for more than two months. My recovery



was a distant hope. Despite the extensive treatment, I am still not able to walk or sleep properly. There are burns wounds all over my body, hands, and thighs. I can only sleep on my stomach due to the injuries on my back. Even now I experience pain, itching, and other difficulties. We appointed a home nurse for a brief time. It was financially impossible for us to continue," she said. She travels to Kochi to consult her doctor once every month. "The doctor said he wants to see me for further treatment. I

take a taxi from Adimali. I have spent around Rs 16 lakh for my treatment in the last one year," she said, adding that most of the expenses were met by the Jehovah's Witnesses. Venus was also injured in the blast and was admitted to a private hospital in Kochi. "She made a quick recovery and left the hospital after 37 days," said Moly. As many as 52 people were admitted

to various hospitals in Ernakulam following the twin blasts. Moly said that many of the survivors have still not been provided financial assistance by the state government. "The chief minister, governor, and other ministers were among those who visited us in the following days with promises of financial and other assistance.

However, I have not received any assistance. I tried to apply for aid by submitting my hospital bills. However, there has been no update," says Moly, a daily wager. She has two daughters. The eldest is married and lives with her family in Peerumedu, while the youngest is in between jobs in Dubai. Moly is a single mother, having separated from her husband when her younger daughter was three years old.

Mix-up sends baby on two district tour

PHULBANI: Tension erupted at the district headquartershospital (DHH) after a shocking mix-up left a couple, blessed with a baby boy, in emotional distress.Last week, Liza Mukhi, a resident of Panji Sahi in Phulbani town, gave birth to a baby boy at the hospital. Due to concerns over the newborn's low birth weight, the baby was transferred to the Special Newborn Care Unit (SNCU) for specialised care. Doctors at the SNCU found the newborn needed additional treatment and on Saturday, referred the baby to MKCG medical college and hospital in Berhampur. However, in a confusing turn of events, while the couple was preparing to leave for Berhampur, the hospital staff mistakenly handed them a baby girl wrapped securely in a

The couple, believing they were carrying their son, reached MKCG medical college and hospital only to be informed by doctors that the infant was, in fact, a healthy baby girl, not the baby boy they were expecting. The news shocked the couple, prompting them to return immediately to the district headquarters hospital.Upon their return, they sought clarification on the bewildering mix-up. The staff at the district headquarters hospital stated the baby boy was still in the SNCU, safe and under observation. The hospital authorities acknowledged the mistake and arranged an ambulance to take the couple to MKCG medical college and hospital.ADMO Dolamani Pradhan, said an internal investigation would be initiated to ascertain the cause of the critical mix-up. He said a thorough report will be sought from the SNCU in-charge to ensure appropriate steps to prevent similar incidents in future.

PT teacher held for assaulting student in Hosur

KRISHNAGIRI: The physical education teacher of government-aided school in Hosur was arrested on Monday for assaulting a class 9 girl. The suspect M Thiyagarajan (35) of Dharmapuri is working in a government-aided school at Hosur.He was booked under sections of 115 the BNS Act, section 4 of The Prohibition of Harassment of Women Act, and Section 75 of the Juvenile Justice Act. Based on a complaint from the girl's parent, Bagalur police arrested the teacher.A school education department officer told TNIE, "On October 23, 16 students and two teachers went to a private school near Bagalur for a sports event. Post-event, a private school teacher went to the restroom. He removed her wristwatch placed it outside and left without taking it. The class 9 student who saw the watch tried to give it to him, but since the students were in a hurry to catch the bus, she kept it with her. Meanwhile, the teacher told Thiyagarajan that she had



lost her watch and that students from his school were near the restroom. When he enquired, the class 9 girl handed it over to him and told what happened."The official added, "The teacher assaulted the girl and informed her mother over the phone. The mother allegedly asked the teacher to

beat her more. Then he brutally assaulted the girl on the road in front of the private school."The video of the assault went viral on social media, following which Krishnagiri Chief Education Officer A Muniraj (in-charge) directed District Education Officer (DEO) RV Ramavathy to hold an inquiry in the aided school and another DEO Gopalappa (Matriculaion) to inquire in the private school. Israel-Iran face-off adds fuel to West Asia fire

AFTER reaching an understanding with the Joe Biden administration, Israel despatched about 100 aircraft to bomb 20 select targets in Tehran, Khuzestan and Ilam provinces of Iran on October 26, reportedly including its air defence systems such as S-400, S-300, missile and drone manufacturing units and other military targets. The Israeli strike was in response to more than 180 missiles which Iran had fired at Israel on October 1 to damage its military bases. Since the US and its allies had insisted that Iran's nuclear installations and oil production facilities must not be attacked to prevent a wider war, the Israelis focused on making Iran 'defenceless', destroying its radar facilities for future strikes. Israel also decided not to attack the top Iranian leadership to avoid provoking the Iranian military to retaliate with a second strike on Israel. The Iranian Foreign Minister had told Arab governments earlier that Iran did not want a wider war and it could absorb an Israeli retaliatory strike if military sites were targeted rather than sensitive oil or nuclear facilities. The extent of the damage to Iranian military facilities is not clear as the Islamic regime has prohibited its people from revealing details in order to prevent a national uproar. The Ayatollah Khomeini international airport in Tehran was reopened for normal flights after the Israeli military announced that its overnight attacks on Iran had concluded. The US had warned Iran that if it decided to retaliate, it (US) would join the war on behalf of Israel and cause massive damage. Israel also bombed military targets in Syria and Iraq; there were reports of fire at several places. Iran's reaction so far has been restrained. It has stated that the Israeli strike had resulted in only 'limited' damage and it would humiliate Israel again. But Iran is not talking about taking any punitive action against Israel immediately. Iran needs time to rebuild its proxies like Hezbollah, Hamas and others which have been dealt a devastating blow by Israel.President Biden monitored the progress of the Israeli strikes from his office. The 'controlled and limited' conflict allowed both Israel and Iran to save face domestically without triggering a wider conflict which could damage their economies and those of other countries. A full-blown regional war would have carried significant repercussions for US domestic politics as Democratic Party candidate Kamala Harris is in a close race against Republican nominee Donald Trump in the upcoming presidential elections. Harris has called for de-escalation of this conflict to attract the support of Black, Arab, Muslim and Hispanic voters. What are the lessons from the Iran-Israel conflict? First, Iran has buttressed its comprehensive national power by mastering the nuclear fuel cycle and manufacturing advanced weapons. After this round, it is likely that Iran would augment its security by taking remaining steps to build a nuclear weapon. Iran has reportedly reached an agreement with Russia to begin manufacturing the advanced Sukhoi-35 fighter aircraft in exchange for setting up similar facilities in Russia to manufacture various missiles. It is already building drones, autonomous vehicles, submarines and other advanced weapons. Iran is also likely to seek more advanced air defence systems such as S-400 from Russia to protect its sensitive installations. With its revolutionary Islamic ideology strongly guiding its foreign policy, Iran would continue to the political or economic framework of the region. Second, though the US continues to wield predominant influence in West Asia, it can't impose a solution of its choice anymore in the region. The Great Powers' rivalry has intensified, with Russia and China actively supporting Iran, Syria and others. It will become more difficult for the US to impose sanctions against the sale of oil by Iran in future as many BRICS countries are now keen to transact oil purchases in local currencies, bypassing Western mechanisms.

India, China must overcome trust deficit

Return to pre-Galwan patrolling protocols is a prerequisite for satisfactory disengagement

THE most significant takeaway from the 16th BRICS Summit hosted by Russian President Vladimir Putin in Kazan was the brief meeting between the leaders of India and China. It may be interpreted as the beginning of a nascent thaw in the troubled bilateral relationship that had been vitiated by the 2020 Galwan incident. Chinese troops violated the peace and tranquillity agreement of 1993 when they transgressed the Line of Actual Control (LAC). Soldiers were killed on both sides in the ensuing clash. Chinese troops occupied five sectors beyond the LAC — Galwan, Gogra Hot Springs, Pangong Lake, Depsang and Demchok — and prevented Indian soldiers from patrolling these points as per the earlier protocols. Since then, there has been no high-level contact between the two Asian giants.In the run-up to the BRICS Summit, India stated on October 21 that an 'agreement' had been reached between the two nations, "leading to disengagement and a resolution of the issues that had arisen in these areas in 2020". This tentative rapprochement enabled the leaders to engage in a meeting. Prime Minister Narendra Modi met Chinese President Xi Jinping on October 23 on the sidelines of the Kazan event. This was the first proper meeting between the two leaders since 2019. It should be welcomed cautiously. Suggestions about a breakthrough would be invalid, for there was no joint communiqué regarding the meeting, let alone about any 'agreement' as regards the border issue. While Xi noted that China and India should manage their differences properly, Modi asserted that mutual trust, respect and sensitivity would guide bilateral relations. It is instructive that while the statement by India's Ministry of External Affairs (MEA) was forthcoming about an 'agreement', the Chinese Foreign Ministry was reticent and opaque about the Kazan meeting. The Indian statement noted: "Welcoming the recent agreement for complete disengagement and resolution of issues that arose in 2020 in the India-China border areas, Prime Minister Modi underscored the importance of properly handling differences and disputes and not allowing them to disturb peace and tranquility." It added that the two leaders agreed that the SRs (Special Representatives) on the India-China boundary question would meet at an early date and explore a fair, reasonable and mutually acceptable solution to the boundary question.On the Chinese

side, official news agency Xinhua reported: "The two leaders commended the important progress the two sides had recently made through intensive communication on resolving the relevant issues in the border areas. Modi made suggestions on improving and developing the relationship, which Xi agreed to in principle."India has sought a return to the pre-Galwan status quo and at this stage, it is not evident if China has agreed to this formulation. Furthermore, what has dismayed India is the manner in which Beijing chose to violate previous agreements. They include the 1993 peace and



tranquillity agreement and the 1996 military confidence-building agreement. These agreements are now in tatters and the challenge for India is to restore the sanctity of these pacts, the first of which was shepherded by then PM Narasimha Rao and President Jiang Zemin.

The fine print of how the disengagement along the LAC will proceed and the patrolling by India as per the pre-Galwan pattern in all sectors will be restored will have to be verified on the ground. The latest reports indicate that the process of disengagement of troops has begun in the Depsang plains and Demchok. While they have a legacy (they predate Galwan), disengagement there would be important in reaching a final settlement. Depsang remains a contentious area, and a consensual patrolling arrangement there could pave the way for moving towards de-escalation. The Army Chief, Gen For India, in the context of the LAC, the desirable Upendra Dwivedi, has dwelt on the need to 'build trust' in the first instance; this prudence is not misplaced. Whether China has disengaged, as sought by India, will be more evident next summer, when more robust patrolling would be possible.

Dwivedi has added that the two sides "need to reassure each other that we are not creeping into buffer zones that are created and build trust before tackling disengagement, de-escalation, and deinduction phases". The buffer-zone concept along the LAC came into existence after the Galwan clash; it referred to a demilitarised area at the five friction points where India and China agreed to a limited disengagement. These zones were stabilised by September 2022, and the implication was that Indian troops were not allowed to access areas they had patrolled in the pre-Galwan period. Thus, the

erasure of the buffer zone in all contested sectors and a verified return to the pre-Galwan patrolling protocols along the LAC would be a prerequisite for a satisfactory disengagement, which could lead to de-escalation and deinduction. These complex tactical issues call for strategic patience and prudence on both sides.

Speaking about the Kazan summit, Chinese Foreign Minister Wang Yi noted on October 25 that the BRICS nations had a shared pursuit. He added that China had called for joint efforts "to build BRICS into a primary channel for strengthening solidarity and cooperation among Global South nations" and emerge as a vanguard

for advancing global governance reform. The current US-led global system has been less than effective in dealing with the challenges that threaten peace and security across the world. The wars in Ukraine and West Asia, climate change and nuclear sabre-rattling are bleak examples of such ineptitude. However, the aspiration for BRICS to become a more credible grouping cannot be realised unless there is a major review and rearrangement of the India-China relationship. The received wisdom based on China's actions in relation to India is that it seeks multipolarity at the global level (to reduce US primacy), but wants to impose Chinese unipolarity in Asia. This is a conundrum that the guardians of the Middle Kingdom will have to grapple with. Whether the Kazan meeting will lead to such objective introspection in Beijing is a moot point.

Israel keeps West Asia on the boil



Israel has dismissed reports that it avoided hitting Iranian gas and oil facilities because of US pressure, but it is apparent that Tel Aviv is reluctant to start a full-blown war against Iran. Already grappling with Hamas and Hezbollah, Israel has intended to send out a strong message to Iran's Supreme Leader and military commanders.



However, even the presumably limited scope of the Israeli operations is enough to infuriate Iran. If Israel has the

right to self-defence, so does Iran. If this vicious cycle of retaliation and counterretaliation continues, regional tensions are bound to escalate

American President Joe Biden is hopeful that the Israeli strike would mark the end of the confrontation. His optimism is clearly misplaced as Iran is keen to keep Israel on tenterhooks, either directly or through its military proxies. Exercising restraint is alien to both nations, but they do need to carefully consider the ramifications of this destructive course not only for West Asia but also the world at large. Warmongers such as Israeli Minister of National Security Itamar Ben-Gvir, who called the October 26 strike "a good beginning in order to target Iran's strategic assets, which needs to be the next phase", must not be

given free rein by the Netanyahu government.

Hoax bomb threats reveal gaps in aviation security

malls, colleges and other institutions across the country, but with over 100 hoax calls in a few days and their multi-dimensional effects, the aviation sector is the most vulnerable to disruption. These hoaxes impose enormous indirect costs on

society, disrupting operations, inciting fear and diverting crucial resources. They have created mayhem in the aviation sector, with estimates indicating that the economic cost of a single hoax ranges from lakhs of rupees in the domestic sector to as much as Rs 15-20 crore on international routes.

These threats create a ripple effect of consequences, including stress and anxiety for passengers, unexpected delays and disruptions in tourism and business activities. Additionally, Indian carriers face a competitive disadvantage. Security and intelligence resources are strained and diverted from genuine terrorist threats, which can have disastrous consequences. The consistency of the hoaxes and the sophistication and planning involved suggest the involvement of a non-state actor or a deep state influence in the attacks.


Hoaxers and terrorist groups employ anonymising tools and networks to evade detection, such as the Tor network and VPNs, which mask their IP addresses and encrypt communications. They use end-to-end encrypted services and operate on the dark web to ensure that their messages are unreadable to outsiders. Caller ID and email spoofing complicates traceability. They route communications through multiple proxy servers and relay chains, use public wi-fi and compromised devices to avoid detection and rely on burner phones and disposable email accounts, botnets for distributed and automated attacks, making it challenging to pinpoint the source of threats.

security agencies reveal a pattern in which threats are communicated via social media or phone calls, often followed by a surge of similar threats occurring in a short time frame. The investigations have traced the originating IP addresses to locations in London and Germany, where users are employing VPNs to

conceal their online identities and send tweets from remote servers. Dealing with such acts is a challenging proposition. Along with strict adherence to the standard operating procedures, comprehensive response plans and modernisation of rapid response teams through regular simulation drills are essential. Public awareness campaigns should be encouraged to educate citizens about the seriousness of threats and the legal consequences of such acts. Technological advancements should be fine-tuned, including the development of AI and machine-learning algorithms that analyse threat communications to identify patterns indicating hoaxes versus credible threats. These algorithms can analyse communication patterns, detect anomalies and identify potential bomb threats in real

time, enabling prioritisation for immediate response. Additionally, integrating data from various sources, such as social media, past incidents and intelligence reports, allows for a rapid assessment of threat credibility. Communication interception and analysis tools are also crucial as they trace the origins of emails and phone calls — even those using anonymisation techniques —and help identify perpetrators swiftly. Furthermore, sentiment analysis can detect the tone and urgency of threats, assisting in distinguishing serious threats from likely hoaxes.

Bharatiya Nyaya Sanhita (BNS) and Section 3(1)(d) of the Suppression of Unlawful Acts against Safety of Civil Aviation Act, 1982, in connection with the recent hoax bomb threats. The authorities should not hesitate from applying stringent provisions of the Unlawful Activities (Prevention) Act, whenever necessary.

This collaboration enables effective identification, tracking and neutralisation of hoaxes through shared resources and expertise. Additionally, fostering publicprivate partnerships with entities like telecommunications companies can enhance efforts to trace the origins of bomb threats. Legal measures must include harmonised legislation across countries for consistent prosecution of hoaxers and stronger extradition treaties to ensure that

NEW DELHI: The Delhi High Court on Monday scheduled a hearing for October 29 on a plea filed by BJP MLAs seeking an order to compel the Delhi government to send 12 pending Comptroller and Auditor General (CAG) reports on critical issues like liquor duty, pollution and financial management to the lieutenant governor (LG) for presentation before the Delhi Assembly.A bench led by Chief Justice Manmohan, along with Justice Tushar Rao Gedela, listed the plea after it was brought up

for urgent consideration by a senior counsel representing the petitioners. "Tomorrow (Tuesday)," responded the bench, agreeing to expedite the matter.Leader of Opposition Vijender Gupta, along with fellow BJP legislators Mohan Singh Bisht, Om Prakash Sharma, Ajay Kumar Mahawar, Abhay Verma, Anil Kumar Bajpai, and Jitendra Mahajan, filed the petition on Saturday. They This deliberate withholding of critical contend that the reports, which span from the fiscal years 2017-18 to 2021-22, have remained pending with Delhi's Chief Minister Atishi, who also oversees the finance



portfolio. The petition asserts that despite repeated requests from the LG, the reports have not been forwarded to him for submission before the Assembly. Filed by advocates Neeraj and Satya Ranjan Swain, the plea claims BJP MLAs had approached various officials, including the chief minister, the chief secretary, and the assembly speaker, yet no steps were taken to release the reports.

NEW DELHI: The Delhi High Court, on Monday, directed candidates from the recent Delhi University Students' Union (DUSU) elections to submit an undertaking promising not to deface public property in the future. This decision was part of an effort to hold the candidates accountable for the mess created during election campaigns and grant them additional time to clean up the university campuses. The bench, comprising Chief Justice Manmohan and Justice Tushar Rao Gedela, instructed candidates who showed "remorse" to file affidavits accompanied by photographs as proof of their cleanup efforts across Delhi University's North and South campuses. "Candidates are required to submit affidavits with photographs demonstrating the



removal of posters, banners, graffiti, and any other defacement they contributed to," the court directed, adding that they must pledge not to harm public property going forward.

Previously, the court had paused the vote count due to alarming campaign videos that showed vehicles blocking roads and even one car "drag racing" through a street. The court highlighted the importance of the Lyngdoh Committee guidelines, which set limits on election expenses and conduct during student elections, underscoring the need for Delhi University to enforce these standards strictly. In consideration of their student status, the court refrained from ordering FIRs against the candidates, instead offering them a chance to participate in campus restoration. The bench urged candidates to be role models, stating, "You should be setting a positive example for other students, not creating chaos on

The court had also summoned 16 students, all DUSU candidates in the 2024-25 elections held on September 27, to participate in the hearing. All but one attended on Monday.Addressing the candidates, the court remarked, "You do not have the right to deface university walls or private property. Imagine how you would feel if someone spray-painted slogans on your home.'

Interestingly, the court noted that many candidates were enrolled in the Buddhist Studies program, suggesting that students might be joining this course as a way to contest elections.

The permission has been granted to the Anti-Corruption Bureau to investigate two assistant engineers (AEs) and three junior engineers (JEs) of the electrical division in PWD,

NEW DELHI: Delhi's 10,000 bus marshals whose services were terminated last year, are set to make return within a week and their services will be utilised in on ground zero in the fight against pollution, Delhi Chief Minister Atishi announced on Monday. These marshals and CVDs will reinforce pollution checks, border inspections and awareness campaigns.Delhi CM Atishi, in a press conference alongside Environment Minister Gopal Rai, said that to ensure women's safety on buses, the government deployed bus marshals in 2017-18. These marshals worked in about three shifts to address any issues women might face on public transport.CM Atishi noted that for the past year, these bus marshals and CDVs have been tirelessly fighting on the streets, fully backed by the Delhi government, its ministers, and AAP MLAs. Whether it meant facing police resistance or enduring physical confrontation, Delhi's ministers and MLAs



stood shoulder-to-shoulder with the marshals in their struggle, she highlighted. "Finally, their efforts bore fruit, and the central government had to relent, agreeing to the Delhi government's long-standing demand to reinstate the bus marshals."Recently, we announced that these 10,000 bus marshals and civil defense volunteers will now be deployed in Delhi's ongoing battle against pollution," asserted the chief minister.CM Atishi shared that some bus marshals will be assigned to the Transport Department, which



This missed the Street's expectations, as analysts had estimated a net profit of around Rs 3,525 crore. The company's revenue from operations remained nearly unchanged year-over-year, recording Rs 35,589 crore for the quarter versus Rs 35,535 crore in the same period last year. While revenue saw a marginal increase of 0.15%, it fell short of the market's projected figure, with analysts anticipating a higher contribution from Maruti's sales amid strong consumer demand.A major factor impacting Maruti's Q2 net profit was a rise in deferred tax expenses, which surged to Rs 1,017 crore from Rs 83 crore in the year-ago period. This increase weighed heavily on the company's bottom line, reducing overall

Maruti's EBITDA (Earnings Before Interest, Tax, Depreciation, and Amortisation) for the quarter was Rs 4,417 crore, lower than analysts' estimates of Rs 4,690 crore. This reflects a yearon-year decline of 7.7%.

The EBITDA margin also contracted by 100 basis points to 11.9% compared to 12.9% in the same quarter last year, further underscoring the impact of higher expenses and lower-thanexpected revenue.

Can Diwali week light up Dalal Street amid volatility and FII

As the festive spirit of Diwali fills the air, market watchers are left wondering: Can Diwali week bring sustained cheer to Dalal Street amid shifting investor sentiments?

New Delhi. As Diwali week begins, a sense of optimism is returning to Dalal Street. After a tough six-day losing streak, the Nifty index made a surprising comeback with a 158-point rally. The lift has many investors feeling hopeful, despite foreign institutional investors (FIIs) selling off a significant Rs 3,228 crore in shares, which outweighed domestic institutional purchases of Rs 1,401 crore.

Despite today's dip on Dalal Street, market experts remain optimistic about the

outlook for investors, highlighting several positive developments. Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, suggested that Monday's rally shows resilience in the market.He pointed out that while FII selling has eased somewhat, concerns about India's high valuations and economic growth for FY25 may keep some pressure on the market. An interesting feature of yesterday's 158 point rally in the Nifty

is that the up move happened despite the FII sell number at Rs 3,228 crore being higher than the DII buy number of Rs 1,401 crore. The implication of this change in trend, despite the persistence of FII selling, is that the retail investors are back in buying mode," he said.

The decline in the intensity of FII selling bodes well for the market but FIIs may continue to sell since the premium valuations of the Indian market is being questioned now in the context of concerns regarding FY25 growth and weakness in urban consumption," he added. However, he noted a positive trend as some



previously overvalued stocks, particularly in defence and railways, have corrected. This could open the door for more quality investments, especially in private-sector financials.

A positive trend in the market is that some froth in valuations has been removed as evidenced by the sharp correction in the overvalued defence-related stocks and Railways stocks. The shift to quality observable in the accumulation of quality private sector financials is a healthy trend that can sustain," Vijayakumar explained. Adding to the good news, oil prices have

dropped below \$68 per barrel as tensions in the Middle East eased. This is another boost for investors in the Nifty.Prashanth Tapse, Senior VP of Research at Mehta Equities, said, ""This Diwali week brings optimism to Dalal Street as Nifty traders celebrate a significant drop in oil prices, now below \$68 a barrel, following reports that Israeli airstrikes did not target critical Iranian facilities."He highlighted that banking stocks played

a key role in the market's lift, driven by strong quarterly earnings from ICICI Bank, Bandhan Bank, Indian Bank, and Bank of Baroda. CCPA to probe Ola Electric's plaint resolution claim

The Department of Consumer Affairs is reviewing Ola Electric's claim of resolving 99% of over 10,000 complaints regarding its escooters, following a show-cause notice issued by the Central Consumer Protection Authority (CCPA) earlier this month. As per sources, the department is investigating the company's assertion and plans to reach out to customers to verify their experiences. Earlier, Ola Electric said it has a strong system for addressing has a strong system for addressing customer complaints. "Of the 10,644 complaints received via the CCPA, 99.1% were resolved to the complete satisfaction of the customer, as per Ola Electric's robust redressal mechanism," the company claimed in a statement to the exchanges. The CCPA issued its show-cause notice to Ola Electric on October 7, accusing the company of violating consumer rights, misleading advertising, and unfair



trade practices. It had informed that over 10,000 consumer complaints were logged with the National Consumer Helpline, most of which were related to the company's after-sales service. Shortly after, the Ministry of Heavy Industries (MHI) involved the Automotive Research Association of India (ARAI) to verify if Ola Electric is meeting its warranty commitments and maintaining adequate service centers.

The Ministry of Transport has also sought

an explanation from Ola Electric regarding the quality concerns raised by customers about its escooters.Last week, the CCPA, under Chief Commissioner Nidhi Khare, expressed concerns about Ola Electric's refund policy, which currently offers future ride coupons instead of cash refunds. The CCPA has instructed Ola to make its refund process more consumer-friendly.Mkt share,



NEW DELHI. Benchmark stock market indices opened lower on Tuesday, following Monday's rally after six days of declines. Caution lingered amid an underwhelming earnings season and consistent foreign investor outflows. At 9:54 am, the NSE Nifty50 shed 109.60 points to 24,225.55 points, while the BSE Sensex fell 369.17 points to 79,635.87. The Nifty50 and Sensex saw gains on Monday, driven by ICICI Bank's strongerthan-expected quarterly results, but momentum stalled as eight of the 13 major sectors recorded losses.Information Technology (IT) and Auto sectors led the declines during early trade today.
Small- and mid-cap indices, largely focused on the domestic market, remained mostly flat.

Investor sentiment was influenced by global factors, including upcoming US jobs data and uncertainties around the US presidential election. "Caution prevails due to a lackluster earnings season, ongoing foreign outflows, and premium valuations being questioned amid



concerns around FY25 growth," noted Prashanth

Tapse, Senior VP of Research at Mehta Equities. Most of the time, I don't think about the money; I just play for love or fun," Alcaraz shared with reporters. "But you have to be realistic. You have to think that you want to earn money, you know, and that's itâ€æ in Arabia is the most highest prize money ever in the history, so that was a good motivation, at least for me."

The East Coast is nine-and-a-half hours behind India and the country's viewers can catch the action live, but Los Angeles is 12-and-a-half hours behind which could be detrimental from a viewership point. Wasserman said during a Business of Sports Summit in Austin, Texas, that the LA28 organisers would like to maximise cricket viewership in India, according to website 'sportico.com'.Wasserman, who headed the successful LA28 bid and became president of the Organizing Committee, wasn't specific about which venue on the East Coast could host cricket matches. Cricket is among six sports, along with baseball, softball, flag football, squash and lacrosse, added to the LA28 Olympic roster. It was in the Olympic Games once before, in 1900. It is likely that pre-existing infrastructure could be used to achieve "more than USD 150 million in savings and new revenue to help maintain a balanced budget (for the Olympics)," Wasserman has said earlier this year, according to 'Sportico'.

MS Dhoni recalls asking Sourav Ganguly to lead India in his farewell Test

MS Dhoni has recalled handing over the captaincy to Sourav Ganguly during his farewell Test against Australia in 2008. The gesture was spontaneous and meant to honour Ganguly's legacy.

New Delhi. Former Indian captain MS Dhoni recalled the unforgettable moment he handed the captaincy of the Indian team to Sourav Ganguly during his farewell Test against Australia in Nagpur in November 2008. Ganguly, one of India's most influential captains, had announced that it would be the final international appearance of his illustrious career. During a recent promotional event, Dhoni shared the



heartfelt reasoning behind his decision, describing it as a spontaneous but deeply meaningful act to honor a player who had done so much for Indian cricket.Dhoni, speaking of that symbolic moment on the fifth day of the match, revealed that there was no pre-planning involved. "Being one of the greatest captains that India has ever produced, what better farewell can you give from your side?" Dhoni remarked. "Last day (of his career), he is standing on a Test match field, playing the game. If he can say 'goodbye' leading for a while, then why not? It doesn't really change the result of the game. That was the reason behind it."

As India's captain at the time, Dhoni took this opportunity to celebrate Ganguly's contribution to Indian cricket uniquely. "I don't know whether he enjoyed it or not because it came all of a sudden. It wasn't

planned, like 'this is what you should do.' I thought this was the best way for him to say farewell, leading on the field. Even if it is for 15-20 minutes, why not?" he added.

Ganguly's career spanned an impressive 113 Test matches, where he scored 7,212 runs at an average of 42.17, including 16 centuries and 35 half-centuries. His ODI career was equally remarkable, with 11,363 runs from 311 matches, featuring 22 centuries and 72

Ganguly was not just a batsman but an inspiring captain who ignited a sense of competitiveness in Indian cricket, especially on foreign soil. His fearless approach and confidence in his players paved the way for talents like Dhoni, Virender Sehwag, Yuvraj Singh, Zaheer Khan, and Suresh Raina, who would become instrumental in India's successes in the years that followed. While Dhoni and Virat Kohli went on to surpass Ganguly in terms of the number of victories and ICC trophies, many argue that Ganguly laid the foundation for a winning culture in Indian cricket. Under Ganguly, India emerged as a powerful force not just at home but also in overseas conditions.
