Way behind China in production pace, warns IAF Chief

New Delhi, Oct 4: In a blunt assessment vis-àvis China, Indian Air Force (IAF) Chief Air Chief Marshal AP Singh on Friday said India needed to "catch up" on technology as on production speed of military equipment "we are way behind" the neighbour. On the much-delayed production timelines of the indigenous fighter jet programme, the Tejas, the IAF Chief, who was addressing a press conference ahead of the Air Force Day (October 8), said Hindustan Aeronautics Limited (HAL) needed to match the promise of making 24 jets every year. Air Chief Marshal Singh, who took over as IAF Chief on September 30, said, "In terms of quality of manpower, we are way ahead of them. As far as technology is concerned, we may not be so good, as of now. We were better than them, we need to catch up." On HAL and production of

indigenous jets, he said, "It made a promise that production rates will be increased to 24 aircraft per year. If that promise is kept, delays can be caught up with. HAL has a third production line at Nashik, which is yet to churn out an aircraft." On the dwindling fleet of fighter jets, the Chief said, "Our first jets. Deliveries were to start in March this year, but aim is not to let aircraft strength remain below 30 (squadrons)." Each squadron has 16-18 jets. The



Cabinet Committee of Security has laid down the need for 42 squadrons to tackle a simultaneous two-front threat from China and Pakistan. The IAF presently has 32 squadrons with several scheduled to be phased out over the next few years. The IAF has placed an order with HAL for 83 Tejas Mark-1A

ets, he said the force was looking at 97 more Tejas Mark-1A, and also six-seven squadrons each of Tejas Mark 2 and Advanced Medium Combat Aircraft (AMCA). Asked how to produce so many planes, he said, "Private players have to come in. I don't think we can continue relying only on one agency (HAL) that may have limitations of doing things in a specified time frame." On the future of a multi-role fighter aircraft (MRFA) pro-gramme that would plan to make 114 jets with a foreign partner and India partner JV producing jets in India, the IAF Chief said, " We needed the MRFA as of yesterday". "If the Tejas Mark 2 gets into production, as planned, by 2028, and MRFA is signed, we are not too badly off. If these timelines are getting pushed, we have to look at alterna-

tives," he said. On the current situation along the Line of Actual Control (LAC) in eastern Ladakh, the IAF Chief said, "The situation is the same as it was a year ago or so." "The Chinese are creating infrastructure on their side of the LAC at a rapid

EAM Jaishankar to lead Indian delegation to SCO Summit in Islamabad ST Correspondent

New Delhi, Oct 4: External Affairs Minister S Jaishankar will lead an Indian delegation to Islamabad, Pakistan, for the SCO (Shanghai Cooperation Organisation) Summit on October 15 and 16, marking the first high-level visit from India to Pakistan in several years. Ministry of External Affairs spokesperson Randhir Jaiswal confirmed on Friday that Jaishankar will head the

Indian delegation to the SCO Heads of Government meeting. SCO is multilateral body that includes Russia and China as members, with Pakistan hosting this year's sum-

mit. When asked if Jaishankar would meet his Pakistani counterpart, Jaiswal said he could not comment at this time. "The visit is specifically for the SCO meeting," he added. Regarding a potential meeting with Pakistani officials, Jaiswal stated that, so far, the minister's travel plans are limited to the SCO summit. "If there are any developments, we will let you know," he said.

Supreme Court junks review petitions against SC/ST subclassification verdict

New Delhi, Oct 4: The review petitions, considered in chambers by a seven-judge bench led by CJI Dhananjaya Y Chandrachud, were dismissed as the bench found "no error apparent on the face of the record" The Supreme Court has rejected a set of review petitions challenging its August 1 decision that allowed subclassifications within Scheduled Castes (SCs) and Scheduled Tribes (STs) for preferential reservations. The review petitions, considered in chambers by a seven-judge bench led by Chief Justice of India Dhananjaya Y Chandrachud, were dismissed as the bench found "no error apparent on the face of the record." "Having perused the review petitions, there is no error apparent on the face of the record. No case for review has been

established. The review petitions are, therefore, dismissed," stated the court order. In a brief order, the bench, which included justices Bhushan R Gavai, Vikram Nath, Bela



released on Friday. The review petitioners included several persons and organisations, including All Peoples Party leader Thumati Ravi, lawyer Jaishri Patil, Samvidhan Bachao Trust, Dr BR Ambedkar Global

Mission, All India SC/ST Railways Employee Association and National Federation of Dalit and Adivasi Organisation. On August 1, the Constitution bench of the Supreme Court delivered a 6-1 majority ruling, empowering state govern-

ments to create sub-classifications within SCs and STs for preferential reservations, provided these decisions are based on empirical evidence and rational criteria. The majority ruling overturned the 2004 EV Chinnaiah case, which had held that sub-classification within SC/STs was impermissible, treating these groups as homogeneous classes. Justice Trivedi was the sole dissenter on the bench. By allowing subclassification, the top court apparently opened the door

for states to identify and provide targeted benefits to the most disadvantaged subgroups within the broader SC/ST categories, provided they base their decisions on empirical evidence and rational criteria.

In a significant departure, the majority also supported the idea of excluding the "creamy layer" from SC/ST reservations, a concept previously applied only to OBCs. Authoring a separate judgment, justice BR Gavai, supported by CJI Chandrachud and others, emphasised, "The State must evolve a policy for identifying the creamy layer even within SCs and STs to achieve true equality as enshrined under the Constitution." The majority ruling acknowledged the social and economic diversity within SC/ST communities and allowed states to provide targeted benefits to the most disadvantaged subgroups, thereby promoting a more equitable distribution of affirmative action. Marking a significant shift in the landscape of reservation policies in India, the court held that the SC/ST communities are "not homogenous" but are a "socially heterogenous class" and that there are varying degrees of backwardness within these groups that ought to be addressed by the State for the fulfilment of the constitutional goal of social equality.

Amethi Dalit family murder Opposition slams Yogi Adityanath govt

Lucknow, Oct 4: Opposition leaders in Uttar Pradesh on Friday attacked the BJP-led

state government over the law and order situation in the state, citing murder of four members of a Dalit family, including two children, inside their house in Amethi. Sunil Kumar, 35, a government school teacher, his 32-year-old wife Poonam, and the couple's two daughters, Drishti and Suni, were shot dead in the Ahorwa Bhawani area of Amethi on Thursday. The brazen wipeout of the Dalit family has drawn widespread denunciation of the state government. "The incident of the brutal murder of four members of a Dalit family in Amethi district of UP is extremely sad

and worrying. The government should also take strict action against the culprits and the policemen there so that the criminals do not remain fearless," Bahujan Samaj Party chief Mayawati said on X in Hindi. UP Congress president Ajay Rai said the incident shows that in the poor law and order of the Yogi government, a person is not safe even inside the

house "The rule of law has been destroyed in the state. The flag of terror of goons, miscreants and criminals is flying high in UP and no step of the government is visible in the direc-



tion of ending this terror," Rai said. "The Yogi government should answer how much worse will Uttar Pradesh be made now?" he said on social media. "I am with the victim family in this hour of sorrow. I demand the immediate arrest of the criminals guilty of four murders," added the former UP minister. Azad Samaj Party chief Chandra Shekhar Aazad said, "The

incident in Amethi tells that there is no rule of law in Uttar Pradesh but jungle raj... The murder of the whole family in Amethi district is the real picture of the law and order of Uttar Pradesh. "The truth is that there is no guarantee of the life of Dalits in Uttar Pradesh, no one knows whose turn will come tomorrow, and the propaganda is that the law and order is very good," the Nagina Lok Sabha MP said in a long Hindi post on X. Aazad said the incident of the mass murder by barging into their house is extremely sad and punishable, besides being a testimony to the fact that the security of Dalits is in a "pitiable state" and there is no one to listen to them. "This is because if the police-administration had acted on Poonam Bharti's complaint of molestation and death threats a month-and-a-half ago, four lives would not have been lost today," he claimed. "The insensitivity of the policeadministration is also responsible for this mass murder," he said. Demanding immediate arrest of the accused, the MP warned to start a protest in Amethi over any delay. Chief Minister Yogi Adityanath had on Thursday expressed grief over the incident. In a post in Hindi on X, he said,

Haryana, where the BJP has been in power since October 2014, will vote in a single phase on Saturday. After voting concludes in the evening, news channels will come out with the results of exit polls conducted for them by professional pollsters to project the likely outcome and which party could win how many seats. People are asked who they voted for and projections are prepared on the basis of responses. A similar exercise is the opinion poll, conducted months or days before the election day. Here, people are asked who they intend to vote for. Opinion polls cannot be conducted after the schedule of an election is announced. This is to ensure an individual's choice of candidate is not influenced. On the election day, voting will be held from 7am to 6pm. From 7pm onwards, news channels will begin releasing their respective exit poll projections. You can watch these on TV or follow the exit poll blog of hindustantimes.com for live updates. It is possible for an exit poll to go wrong as voters may not have been truthful in revealing who they voted for. For example, for the 2024 Lok Sabha elections, nearly every agency predicted well over 350 seats for the BJP-led ruling NDA. However, the NDA won 293 seats, including 240 by the BJP.

Maharashtra subsidy for cows tops Gujarat, Madhya Pradesh and Rajasthan

- MUMBAI. Earlier this week, the poll-bound Mahayuti govt cleared a subsidy of Rs 50 per cow daily for desi cows housed in registered gaushalas (cow shelters). The scheme will cost the severely cash-strapped state Rs 230 crore per year. Significantly, the payout is higher than the daily subsidy given to cows in cattle shelters in other BJP-ruled states like Gujarat, Madhya Pradesh and Rajasthan, where it ranges between Rs 20 and Rs40.The cabinet cleared the subsidy even though it has two other schemes providing financial support to cattle shelters. In doing so, it overruled the state finance department, which opposed the additional subsidy and pointed out the duplication.
- has learnt that the animal husbandry department had proposed to the cabinet that a subsidy of Rs 30 per day per cow be allocated to registered gaushalas in the state in order to support desi cows, whose numbers were depleting. It had also said that gaushalas covered under the other two schemes should be excluded from the subsidy.
- However, after considering the proposal, the cabinet ended up clearing a subsidy of Rs 50 per cow per day, which is 66% higher than the figure proposed. This raised the annual outlay estimated from Rs 135 crore to Rs 230 crore per year. This change was made on the suggestion of animal husbandry minister Radhakrishna Vikhe Patil, sources said.

Custodial assault case: 5 Odisha cops brought to DFS for narcoanalysis, psychoanalysis

Nod for Kollam-Ernakulam special MEMU, service to start next week

KOCHI. The Southern Railway has approved a special MEMU service on the Kollam-Ernakulam route via Kottayam to resolve the travel woes of commuters caused by overcrowding in trains on the Kottayam-Ernakulam stretch during rush hours.

The special MEMU is scheduled to commence service next week and will run until January 3, excluding Saturdays and Sundays.As an interim solution to the travel issues along the Kollam and Ernakulam route, the Railways will operate the special service between Palaruvi Express and Venad Express. The eight-coach service will operate five days a week, departing from Kollam at 6:15am and arriving in Ernakulam at 9:35am. The train will depart from Ernakulam at 9.50am and reach Kollam at 1:30pm.

Delhi AQI rises postmonsoon; average 166 AQI recorded, several areas breach 200 mark

News box

NEW DELHI: Pollution levels in Delhi have risen with the retreat of the monsoon season. The city's average Air Quality Index (AQI) was recorded at 166 over the past 24 hours, indicating poor air quality. Areas such as Anand Vihar, Mundka, Loni, and the Delhi Institute of Tool Engineering reported high AQI levels of 231, 273, 201, and 243 respectively, marking them as unhealthy and hazardous. The PM2.5 concentration in Delhi is currently 5.5 times higher than the World Health Organization's recommended limit for a 24-hour period.Nearby regions are also experiencing increased pollution. Ghaziabad reported an AQI of 171, while Meerut and Noida both recorded an AQI of 184.

In response to the rising pollution, Shiromani Akali Dal leader Daljit Singh Cheema urged the Supreme Court to take action against Punjab and Haryana. "I appeal to the Supreme Court to take action against them...then they will start acting on it ... every time they can't blame farmers, they have to provide farmers with adequate facilities," Cheema stated.

The Supreme Court has criticized the Commission for Air Quality Management (CAQM) for inadequate efforts. "From the affidavit of compliance we find that no effort is being made by CAQM for implementation of its directions, not a single prosecution has been initiated and the last meeting was only held on August 29," the court observed. The Supreme Court has directed Punjab and Haryana to comply with CAQM's directions and submit an affidavit within a week. The case will be heard again on October 16.

Agra teacher dies after fraudsters claim daughter involved in 'sex scandal'

Agra: A government school teacher in Agra died from a cardiac arrest after receiving a threatening call from cyber fraudsters, her family reported on Thursday.

The incident occurred on September 30 when the fraudsters demanded Rs 1 lakh, claiming her daughter was involved in a sex scandal.Deepanshu Rajput, the deceased's son, said his mother, Malti Verma, aged 58, received a WhatsApp call at noon from someone posing as a police inspector. "Mother Malti Verma (58) was a government teacher at a Junior High School in Achhnera in Agra. On September 30, she got a WhatsApp call at 12



pm in which they said that her daughter was caught in a sex scandal and began threatening her for the future consequences of revealing her daughter's identity,"

Rajput said.

Rajput explained that when he checked the phone number, he realized it was a fraud call and informed his mother. "After that, I also talked to my sister and found everything normal. I asked my mother not to worry because she was a victim of cyber fraud, but she could not control her tension and her health deteriorated after that call," he added. Upon returning home from school, Verma experienced chest pain and anxiety. Her condition worsened, and she was taken to a hospital where she was declared dead due to cardiac arrest.

In biggest seat, prestige fight as veteran takes on two debutants

Gurgaon. A BJP heavyweight out to make a statement after a spell in wilderness, the wife of the popular local MLA looking to step into his shoes after his death, and the oldest political party being represented by a debutant. One of the marquee battles of the state election has primed up to its current stature in unexpected ways.

Badshapur is always a prestige fight, as a constituency that straddles most of Gurgaon's urban area and the city's MNC hub. With 5.2 lakh registered voters, it is the state's largest constituency by electorate size and area. But it's also challenging because of the diversity of the electorate, from new residents of the city who bring in different aspirations to the population living here much longer, settled largely in old Gurgaon and urban villages that abut the sectors. In this mix is veteran Rao Narbir Singh (62), the candidate who knows these intricacies best. For Narbir, who was the local MLA from 2014-19 but overlooked for a ticket by BJP in the last assembly polls, this is a bit of a grudge match, too, against detractors rather than political rivals.

MLA Narbir still has to contend with the

anti-incumbency BJP is facing. Which is also why his two principal rivals see wind in their sails. Kumudini Daultabad (44), widow of Rakesh Daulatabad who died of a heart attack during the Lak Sabha election earlier this year, is contesting as an Independent, hoping Rakesh's goodwill will translate into votes that will kickstart a political career for her.

Vardhan Yadav (33) has found his feet quickly, establishing a connection with the younger voter as he talks jobs and accountability.What's common among the candidates is promises of infrastructure development. Badshapur contributes the most to the state exchequer as it is a bustling corporate hub. An increase in flow of business and capital has gone hand-in-hand with an influx of new residents who have added to the demographic mix of the constituency that otherwise has the Ahir, followed by Jat and Gujjar as most dominant communities.Bad roads, poor garbage disposal and choked drains - problems that people here live with round the year have all found mention in the campaign.

With all his experience, though, three-time Narbir conceded that the pace of development has not kept up with the rate



at which the population has grown. "Development can only be achieved when the leadership is strong," he said, adding that he could guarantee voters he would ensure more infrastructure development work is carried out in Gurgaon than during 2014-2019 when he was a minister in the first Manohar Lal Khattar regime. "Highrise buildings and new sectors have been built here but the basic facilities that

support everyday life - from roads to drainage systems — are missing," Yadav said. He highlighted waterlogging, traffic

congestion and poor condition of roads as the most pressing issues in the constituency. "Many roads are in disrepair, and the newly developed sectors lack proper infrastructure. The Bandhwari landfill has become a significant environmental hazard, and its mismanagement has caused concern among residents," he said.Kumudini has released her own manifesto for the constituency. Key points in it are resolution of disputes on 24-metre (internal) roads, managing traffic, law and order and electricity, empowerment of RWAs, better sewage and stormwater drains and steps to bring relief to homebuyers.In addition to this, she has also promised to take up the toll plaza's removal, which resonates with people living in the new sectors as they are forced to pay a toll for driving from one point in the city to another. "We have been working in the constituency for years and we know the needs of the area. We have a plan for every problem faced by the constituency's residents," she said.After 2008, when the constituency came into existence, Congress and BJP won it once each, in 2009 and 2014, respectively.

Act against illegal dyeing units: NGT to pollution board

Gurgaon. Taking suo motu cognizance

of a TOI report that dyeing units were operating illegally in the city, the National Green Tribunal (NGT) last month directed Haryana State Pollution Control Board (HSPCB) to carry out a survey and take action accordingly. The NGT bench of chairperson Prakash Shrivastava, iudicial member Arun Kumar Taygi and expert member Dr A Senthil Vel on Sept 13 noted that the TOI report, titled 'Dead units on paper, but still dyeing', raised "substantial issues" on compliance with environmental norms.

The bench also issued notices to Union environment ministry, Central Pollution Control Board, HSPCB and Gurgaon DC to submit their responses at least a week before the next hearing

on Oct 16.

"The HSPCB is now tasked with surveying and taking action against these illicit units. The aforementioned news item indicates a violation of the provisions of the Water (Prevention and Control of Pollution) Act, 1974, and the Environment (Protection) Act, 1986," it said.TOI reported on Aug 22 that several dyeing units were officially closed, but continued to operate, specifically in Sector 103, Basai and Sector 36.Regulations dictate that only treated industrial waste can be released into the drain. But these units, which appear to be abandoned plots or warehouses, surreptitiously continue dyeing denims and hanging them out to dry."The article underscores that dyeing units

due to their high pollution levels, and these units are not authorised to operate outside industrial areas. However, they are found in proximity to residential areas, schools, and even the underconstruction Sheetla Mata Medical College and Hospital. Residents have long expressed grievances about the malodorous, discoloured water in the drain, which changes hue depending on the dyes used.

This pollution has rendered the lives of locals miserable, causing health issues such as asthma and skin rashes," the order said. The bench went on to cite the article for effects of exposure to heavy metals that are present in denim dyes, and previous orders to four Haryana districts — Gurgaon, Faridabad, Sonipat and Jhajjar - for surveying and inspecting dyeing units.

Campaign comes to close with road shows, padyatras

Gurgaon.Wrapping up their campaign for the Oct 5 polls, candidates across the four assembly seats in Gurgaon district held roadshows, padyatras, nukkad sabhas and went door-to-door to voters on Thursday.

Former minister and BJP's Badshapur candidate Rao Narbir Singh held a roadshow that covered Badshapur and Farrukhnagar. Addressing voters, Narbir Singh said the constituency witnessed development when he was elected as an MLA in 2014. The area lagged in development because of wrong candidate selection the last five years, he said. "Lotus will bloom on all four seats in Gurgaon. And the coming govt will be of BJP," Narbir Singh said.

He went on to urge voters to support BJP. "It's the era of social media. Everyone should promote BJP as much as possible through social media till voting takes place," he said. The Badshapur assembly seat was won by Independent MLA Rakesh Daultabad in 2019. His wife, Kumudini, is contesting from the seat, which was left vacant after the MLA died of an ailment earlier this year.

Up against Narbir Singh is Congress's Vardhan Yadav.

On Thursday, Yadav said at a roadshow that he was confident people will vote for Congress as BJP is grappling to counter antiincumbency. In the Gurgaon assembly seat, Congress's Mohit Grover held roadshows and said voters were fed up with BJP's governance over the past decade. "They have hope only in Congress. The clear reason for this is the potential formation of a Congress govt in the state, and local voters have always aligned with the ruling power... This election is one of change in Gurgaon," Grover said.BJP rebel Naveen Goyal, who decided to contest as an Independent candidate after being denied a ticket from the party, led a roadshow in Old Gurgaon on Thursday.Not too far from Goyal's contingent was BJP's candidate, wrestler-turned-politician Mukesh Sharma, who held a series of meetings and a roadshow in Old Gurgaon too. Criticising Congress for its policy of "divide and rule, Sharma said he had the support of 36

Man refuses to sell his plot, bludgeoned to death; 2 held

Gurgaon: A man and his son were arrested at Shyam Chowk for allegedly bludgeoning their neighbour to death in a lane near their home in Dhankot after he refused to sell a portion of his land to them, a police official said on Thursday. The accused, Anil, a 40-yearold private worker with a criminal record, and his 19year-old son, Akash, a housekeeping worker at a private firm, admitted during interrogation that they had asked the 48-year-old victim, Shashikant, a labourer, to sell part of his land."The accused said that their house was located behind Shashikant's residence, and they wanted to buy part of his land to widen the narrow three-foot passage connecting their house to the lane. When Shashikant refused, they called him to an open area near their homes and attacked him with sticks. After bludgeoning Shashikant in the lane, they fled the scene," said the police official.At 6 am on Wednesday, the Dhankot police post was alerted to a body lying on the road in Dhankot. "A police team, along with forensic experts, was sent to the crime scene," added the official. Based on a complaint lodged by the deceased's brother, Ramchandar, an FIR under Section 103(1) (murder) of the BNS was registered at Rajendra Park police station. "Anil called my brother outside the house on Tuesday at 11.45 pm, after which they murdered him," Ramchandar said in his complaint.

IT firm manager (35) hangs self from tree after 'spat with wife'

Ghaziabad. A 35-year-old man was found hanging from a tree near Vasundhara Farm in Sector 8 on Thursday morning.Police identified the deceased as Sandeep Singh, who lived with his wife and seven-year-old daughter in a rented flat at Swarn Ganga Apartments in Vasundhara. Israeli strikes kill 37 in Lebanon, Joe Biden rules out 'all-out war' in Mideast

World At least thirty seven people were killed, and over 150 were wounded in Israeli strikes on Lebanon in the past 24 hours, in what is considered one of the most violent raids since Israel intensified its campaign against the Iran-backed terror outfit Hezbollah. Dahiye, the area that houses Hezbollah's headquarters south of Beirut, was pummelled by Israeli bombs in an attack larger than the strike that killed Hezbollah chief Hassan Nasrallah a week ago. Some of Thursday night's strikes hit close to Beirut's international airport. The strikes in Beirut reportedly targeted Hashem Safieddine, Hezbollah's likely new chief, while he was in a discussion with other officials in an underground bunker, according to reports. His fate is currently unknown.US President Joe Biden said he did not believe there was going to be an "all-out war" in the Middle East. He added that more needes be done to avoid a Middle East war. "How confident are you it's not going to rain? Look, I don't believe there is going to be an all-out war. I think we can avoid it," he said.An Israeli strike in Beirut on Thursday targeted top Hezbollah official Hashem Safieddine, who is widely regarded as the successor to slain Hezbollah leader Hassan Nasrallah. Neither Israel nor Hezbollah has commented on the development, but Israel's Channel 13 reported that Israeli army sources believe the operation was successful. Iran's Supreme Leader Ayatollah Ali Khamenei is set to lead Friday prayers and deliver a public sermon today. This sermon,

the first in almost five years, assumes significance considering the volatile situation following the killing of Hezbollah chief Hassan Nasrallah and comes just three days before the one-year anniversary of the Israel-Hamas war in Gaza.

Series of loud explosions heard near Beirut airport: Report

- **Beirut**.Huge explosions shook the sky in the vicinity of Beirut's main airport in the early hours of Friday (October 4), minutes after the landing of an aircraft. Data from the Flightradar 24 website showed the flight to be Middle East airlines ME429 from Dubai.Live video from Reuters showed the sky lighting up with several loud bangs heard.Minutes earlier, an aircraft inbound from Dubai could be seen making its final approach and landing.
- The explosions did not appear to be within the confines of the airport, but were visible from Sin El Fil, 6.8 kilometres northwest of the airport.

Hurricane Helene becomes deadliest to hit US mainland since 2005 as 215 die

World Rescue crews and volunteers facing obstacles at every turn in North Carolina's remote mountains paddled canoes across swollen rivers and steered horses past mudslides in the rush to reach those stranded or missing by Hurricane Helene's rampage that killed more than 200 throughout the Southeast.Now a week since the storm first roared onto Florida's Gulf Coast, the search continued for people who have yet to be heard from in places where phone service and electricity were knocked out. Pleas for help came from people running low on medicine or in need of fuel for their generators. How many people are missing or unaccounted for isn't clear. The death toll soared to 215 people on Thursday as more victims were found, making Helene the deadliest hurricane to hit the mainland US since Katrina in 2005. Roughly half the victims were in North Carolina, while dozens more were killed in

South Carolina and Georgia.Each road presents a new challenge for rescuersAlong the Cane River in western North Carolina's Blue Ridge Mountains, rescuers from the Pensacola Volunteer Fire Department were cutting their way through trees at the top of a valley nearly a week after a wall of chocolate-milk colored water swept through for hours.Pensacola, which sits a few miles from Mount Mitchell, the highest point east of the Mississippi River, lost an untold number of people, said Mark Harrison, chief medical officer for the department."We're starting to do recovery," he said on Thursday. "We've got the most critical people out."Harrison was helping dispatch volunteers driving all-terrain vehicles on supply runs to people still on ridgetops. Many don't want to leave their houses, while others lost their vehicles and need help getting to town.Bradley Billheimer, who



hiked down to the fire station to access the internet, said he had just talked to his mom for the first time since the storm. He feared his house would be without power for months."I think we're going to walk out in a couple of days," he said.In another county that sits alongside the Tennessee state line, crews were just finishing clearing main routes and reaching side roads that wind through switchbacks and cross small bridges that can be tricky to navigate even in the best weather. Each road presented a new challenge"Everything is fine, and

then they come around a bend and the road is gone, and it's one big gully or the bridge is gone." said Charlie Wallin, a commissioner in Watauga County. "We can only get so far."Most people the crews come across turn out to be fine and just in need of water, but every day there are new requests to check on someone

requests to check on someone who hasn't been heard from yet, Wallin said. When the search will end is hard to tell, he said."You hope you're getting closer, but it's still hard to know," he said.A week into the search and rescue operations in Buncombe County, which includes the hard-hit tourist city of Asheville and where more than 72 have been killed, the county doesn't have an official tally of people who are unaccounted for or missing.The county sheriff said his office believes more than 200 people are missing.

Washington The US is discussing strikes on Iran's oil facilities as retaliation for Tehran's missile attack on Israel, President Joe Biden said on Thursday, while Israel's military pressed ahead with its campaign against Iran-backed armed group Hezbollah in Lebanon.As Israel weighs its options after its arch-foe Iran launched its largest ever assault on Tuesday, Biden was asked whether he would support Israel striking Iran's oil facilities.His comments contributed to a surge in global oil prices, and rising Middle East tensions have made traders worry about potential supply disruptions.

'There is nothing going to happen today," Biden said. On Wednesday, the president said he would not support any Israeli strike on Iran's nuclear sites.

Israel's UN Ambassador Danny Danon told CNN on Thursday his country has "a lot of options" for retaliation and would show Tehran its strength "soon".A US official said Washington does not believe Israel has decided yet how to respond to Iran.Israeli Prime Minister Benjamin Netanyahu has vowed Iran will pay for Tuesday's missile attack, and Washington said it would work with its longtime ally to ensure Iran faced "severe consequences."Iranian President Masoud Pezeshkian, speaking in Doha, said on Thursday that Tehran would be ready to respond."Any type of military attack, terrorist act or crossing our red lines will be met with a decisive response by our armed forces," he said.

G7 CALLS FOR RESTRAINT

Israel's military told residents of more than 20 towns in south Lebanon to evacuate their homes immediately on Thursday as it pressed on with a cross-border incursion and struck Hezbollah targets in a suburb of Beirut. - That hope proved fleeting.Over the following three decades, weapons continued to be fired across the Middle East, killing tens of thousands, and the region now risks descending into full-scale war as fighting rages between Israel and the Islamist movements Hamas and Hezbollah, backed by Iran.As soon as the 1994 prize was announced, protests erupted, with the choice of laureates -- especially Arafat -- harshly criticised.
- An hour after the announcement, one of the five members of the Nobel committee, Kare Kristiansen, co-founder of the Norwegian parliament's Friends of Israel group, tendered his resignation."Arafat's past is too tainted with violence, terrorism and bloodshed" to be worthy of a Nobel Prize, said the former Christian Democratic MP, who years later demanded an "apology" from the Nobel committee.As head of the PLO, Arafat, who died in 2004, personified the Palestinian resistance to Israel's occupation, ordering indiscriminate attacks even though he publicly distanced himself from terrorism. The day of the prize's announcement, Rabin was hunkered down in his office dealing with

- KOCHI. In a suspected case of suicide, the body of a 30-year-old woman was found with its throat slit at Mulavukad on Thursday, police said. The woman's three-year-old daughter, who was found alongside her mother with serious injuries, has been admitted to a hospital.
- The deceased is Dhanika Prabhakar, wife of Ramakrishnan K. The family resides at Mulavukad. The couple's daughter Ishani Ramakrishnan suffered a gash on her neck for which she is undergoing treatment in hospital.
- Officers said that a preliminary probe indicated that Dhanika killed herself after attempting to murder her daughter. Dhanika was reportedly taking medication for a psychological condition and the couple used to have frequent quarrels.Mulavukad panchayat president VS Akbar said, "The parents of the couple are from Tamil Nadu. Ramakrishnan works in a private bank in Kaloor. They constructed a new house in Mulavukad and have been staying there for the past six months. Before shifting to Mulavukad, they stayed in Vaduthala. The neighbours told us that there were frequent fights between the couple. Ramakrishnan and Dhanika slept in different rooms. Ishani was in Dhanika's room," he said.
- It was before 9 am that Ramakrishnan found a bleeding Dhanika lying unconscious in her room. A badly injured Ishani was found to be breathing. "Soon, Ramakrishnan alerted one of his colleagues and they rushed the daughter to a private hospital in Mulavukad. All attempts, including an emergency surgery, have been made to save her life,' Akbar said.

The Major Archbishop told us that he would be going to Rome to attend the Global Synod and once there, he would inform the church leaders of the current situation in the Archdiocese," said Mar Puthur.According to the Apostolic administrator, the priests serving in the Curia informed him and the Advisory Committee that if the current crisis is not resolved, it will be practically impossible to continue to carry on with their responsibilities due to the out-of-control protests.He said, "We should not find solutions to the crises in the church through unrelenting agitations. Efforts to solve problems, obedience to authority, and prayer for the special intervention of the Holy Spirit are required on the part of all of us.

Kodanad heist: two more witnesses questioned

COIMBATORE. The Special Investigation Team (SIT) of the CB-CID, probing the Kodanad murder-cum-heist case, questioned two witnesses at the Police Recruit School (PRS) premises in the city on Thursday.

The first witness Prabhakaran, is an employee at a private bank in Pondicherry. He was asked for transaction details of suspects in this case. We sought details from private bank authorities and their officer submitted it to us, a senior investigating officer said. The other witness was a priest-cum-helper namely Vignesh who had performed and assisted with poojas at former Chief Minister J Jayalalithaa's Poes Garden



residence before the heist. He was questioned about the suspects and their visit to Poes Garden.

"The SIT Team has recorded statements from over 350 witnesses from various

angles to strengthen the case. However, they have not retrieved digital records from the Call Detail Records (CDRs) and magnetic tapes. They expect that the process for this will commence soon based on a court order," the officer said. "Meanwhile, they are waiting for a response from Interpol to trace details of a seven-digit phone number through which an unidentified person contacted the prime suspects between April 27 and 28, 2017, after the heist and murder. We expect this to help us with the investigation."

'Can probe continue if complainants are hesitant?': Kerala HC to govt on Hema Committee report

KOCHI. Kerala High Court on Thursday noted that certain individuals have given statements alleging sexual abuse in the film industry before the Special Investigation Team probing the revelations in the report of the Justice K Hema Committee, but a few of them are unwilling to move forward with their complaints

The court asked the government to explain if there is sufficient evidence in the complaint, can the government, through the SIT, continue the investigation even when the complainants are no longer interested in pursuing the case?

There are persons who have given statements before the SIT. They have expressed that they do not want to pursue the matter. We have to respect their privacy. But at the same time, the government must look into the issue. Suppose there is enough material in the complaint against the named accused, can the government through

the SIT proceed further with the investigation since the complainant is not interested in proceeding?" asked the special bench.

The court, after going through the report, pointed out that the majority of victims who the SIT has contacted informed that they spoke about their experience confidentially only for the Hema Committee's study and that they do not want to proceed with it now.

What is to be done? The government can put in place strict safety measures to ensure that such things do not happen again. But there are persons against whom there are allegations but the complainants do not want to proceed against them, said the court.In an affidavit, the state government said it had constituted a committee to prepare a draft approach paper for film policy. Three Pakistani citizens nabbed in Bengaluru's Peenya for illegal stay in India

- BENGALURU. Three Pakistani nationals. including two women, were arrested by Jigani police on Thursday, just three days after the arrest of four other Pakistani nationals for staying illegally in India under fake identities. The accused have been identified as Syed Tarikh (51), alias Chavan, his wife Anila Tarikh, alias Deepali, and their daughter.
- All three had adopted Hindu names to conceal their identity during their stay in India. The arrests were made after interrogation of the four Pakistanis who were earlier arrested, who revealed information about the family staying in Peenya. Following this confirmation, police raided the family's rented house, where they had been living for four years. The family had entered India eight years ago through West Bengal. They were reportedly funded by the Mehdi Foundation International Jashan-e-Younus. The family, which preached Islam, managed to obtain fake Aadhaar cards, PAN cards and driving licences. Police seized fake documents and are currently questioning the suspects, who underwent a medical examination.A source revealed that police have formed four teams to trace Pakistani nationals living illegally in Bengaluru under fake identities. Following the arrest of Rashid Ali Siddiqui and his family, police learnt that their main objective was to propagate Islam across the country through the Mehdi Foundation. On Sunday, Jigani police had arrested Siddiqui and his family who had been staying in India illegally since 2014. Siddiqui (48), his wife Ayesha (38), and her parents Hanif Mohammed (73) and Rubina (61) had been staying in Rajapura village in Jigani, using fake Hindu identities. Police took them into custody until October 9.

GADAG. Residents of Battur, Kundrahalli, Kundrahalli Tanda and Shetty Kere villages in Lakshmeshwar taluk of Gadag district have been forced to stay indoors now for the fear of stray dogs. Many children, cows, sheep and goats have been bitten by stray dogs in these villages. But what has become a cause for concern is the death of many dogs in these villages in the past three months. Villagers are even

scared to drink milk, fearing that rabid dogs might have bitten their cows. A team of dog catchers led by a non-governmental organisation (NGO) from Bengaluru will visit the four villages on Friday and Saturday to catch the canines.

Meanwhile, health officials have launched a vaccine drive as a precautionary measure. Health camps are also being held to raise awareness against rabies among the people. In Battur village, 20 dog bite cases have been reported in the past 40 days. A cow died after it was bitten by a stray dog a few days ago.Villagers complained to health officials after the dogs started attacking their cows and goats. Referring to the death of dogs, some villagers said the

reason could be some unknown disease, but not rabies. They said they have appealed to their GP members to find a solution at the earliest.

"We are living in fear after a 17-year-old girl died recently. The girl, who was feeding a stray dog near her house, was bitten by

Iran trying to be more Palestinian than Hamas

THE barrage of over 180 ballistic missiles that Iran fired at Israel has heightened tensions in everturbulent West Asia. Initial reports do not speak of major casualties or damages in Israel. But escalation was on the cards for some time. Literally hours before the attack on Hezbollah leader Hassan NAmritsarallah's bunker last week, Israeli Prime Minister Benjamin Netanyahu cautioned the UN General Assembly: "There is no place — there is no place in Iran – that the long arm of Israel cannot reach. And that is true of entire Middle East."This is seen as a direct warning to the clergy leadership in Tehran. Indeed, shortly after the airstrike on the bunker in Beirut, but before the killing of NAmritsarallah was announced, reports indicated that Iran's Supreme Leader Ali Khamenei had been moved to a 'safer location.'The April assassination of Hamas leader Ismail Haniyeh in Tehran and of revolutionary guard commander Abbas Nilforoshan in Beirut, along with NAmritsarallah, were seen as immediate provocations for the Iranian offensive. Unlike the earlier airborne attack in April, this time Iran launched only ballistic missiles against Israel, and its proxies were conspicuously absent.

Haniyeh's killing, within hours after the inauguration of President Masoud Pezeshkianan event also attended by India's Union Minister of Road Transport and Highways Nitin Gadkari divided the Iranian leadership. While one section wanted an immediate and strong response, the other urged caution from possible reprisal and consequences for an alreadysanctioned economy. The latter group won.

There was no Iranian response for two months after the high-profile killing of Haniyeh. NAmritsarallah's assassination changed that cautious Iranian response. Hezbollah has been the main force in the proxy arsenal of promoting Tehran's interests not only in Lebanon but also in Syria. Iran's investment in Hezbollah ---financial and ideological support as well as a military arsenal — has enabled Tehran to emerge as a Mediterranean power, according to some Iranian gloating in conferences and academic exchanges. While the Iranian support for Hamas forms a part of its larger Islamic agenda, Hezbollah has been the most effective, efficient and cost-effective Iranian option against Israel.

Hezbollah has been more popular among Shias and more resourceful in Lebanese politics than its Amal competitor. It was able to shape confessional Lebanese politics through electoral participation.Since the Taif Accord of 1989, mediated by Saudi Arabia, there have been several efforts to 'disarm' Hezbollah. Even the UNSC Resolution of 1701 adopted in the wake of the Second Lebanon War of 2006 explicitly demanded "the disarmament of all armed groups in Lebanon, (and that) there will be no weapons or authority in Lebanon other than that of the Lebanese State." No one has been able to disarm the militant group.Emboldened by Iranian backing, Hezbollah has been pursuing a foreign policy that runs counter to the interests and welfare of the larger Lebanese population, Muslims and Christians alike.Indeed, the resistance tag that Hezbollah proudly claims is also questionable. Hezbollah emerged in the early 1980s as a response to the Israeli invasion and occupation of southern Lebanon. As it relentlessly fought the occupation and periodically attacked northern Israel, the Shia militant group made the occupation costly and domestically unpopular. This resulted in Prime Minister Ehud Barak — a key figure in Israel's Lebanon policy since the 1980s — pulling out

Keep science awards above politics

Instituted by the Centre last year, Rashtriya Vigyan Puraskar facing a credibility crisis

IN a bold and rare move, 175 scientists and academicians have expressed dismay over the politicisation of national science awards - the Rashtriya Vigyan Puraskar instituted by the Central Government last year. Soon after the inaugural set of awards was presented to the winners by the President a few weeks ago, murmurs of political interference in the selection process emerged. It so happened that the names of three scientists

who were chosen by the selection committee were missing from the final list of awardees. They were told about their selection informally by some committee members, only to get a shock later. It was feared that the scientists in question were denied national recognition because of their political views and the stand they took on certain important issues. The first red flag came from 26 Shanti Swarup Bhatnagar awardees in a letter to Principal Scientific Adviser (PSA) Ajay Sood, who heads the Rashtriya Vigyan Puraskar Committee (RVPC). They wanted to know if the panel's recommendations were accepted in their entirety or revised by the government and requested the PSA to reveal the criteria adopted in arriving at the final decision. Once the matter became public, the government altered the selection process, triggering the protest letter from 175 scientists. "The government has updated the selection criteria on its portal and the new version uploaded in the last couple of days adds a line that the RVPC chaired by you

submits its recommendations to the Minister of Science and Technology," the scientists wrote to the PSA on September 24. The change in the selection process paved the way for the political leadership to overrule or change the decision of the RVPC — which practically represents the Indian scientific community. Presidents of scientific academies as well as secretaries of scientific departments are its members.

The scientific community should have seen this coming. In the first place, it was absurd for the Ministry of Home Affairs to ride roughshod over all scientific departments and abolish dozens of awards, including the prestigious Shanti Swarup Bhatnagar Prize instituted by the Council of Scientific and Industrial Research in the 1950s and those given by autonomous science academies. Abolishing established and non-partisan ways of recognising good science and replacing them with a new government award which carries no cash component was a rude shock. Now, even the new awards are facing a credibility crisis. Leaving the final decision to a political functionary means that non-academic considerations will play a role in the selection of awardees.

The episode raises important questions about academic freedom and the governance of science in India, going beyond the awards. The letter of eminent scientists has rightly called the awards episode an 'unhealthy development for Indian science'. The scientists are




concerned that this could set a precedent for ministers to use 'unrestricted vetoes' to overrule recommendations of expert committees. Academics not in the good books of the government could be sidelined from not just awards but also scientific grants, recruitment promotions, etc, the letter has said. This is against basic tenets of science practice and does not augur well for the development of scientific research.

Scientific recognitions are supposed to be based on a fair review of one's contributions in a specific area of scientific research. This is generally done through the process of peer review. The now-discontinued Shanti Swarup Bhatnagar Prize was considered the gold standard as it recognised the very best of Indian science in different disciplines. The list of Bhatnagar awardees reads like a Who's Who of Indian science over the past several decades. Those awarded have gone on to head institutions, establish new ones and lead funding agencies as well as scientific departments. If the process of selection of the Rashtriya Vigyan Puraskar has been compromised in its very first year, will it be able to build

a lasting legacy like the Bhatnagar Prize?

The episode also highlights sustained erosion of the PSA's role in the past few years. Though the PSA's office was formed in 1999, India has had a framework for science advice for policymaking since Independence, beginning with the national committee for the coordination of scientific work in the 1950s. Subsequently, there were

scientific advisory committees to the government, the Cabinet and the Prime Minister. This framework of advice resulted in organising and reorganising scientific departments, the creation of new scientific ministries, the development of research institutes and academic bodies as well as several national policies and programmes. An independent science advice system has acted as a science-policy interface and as a clearing house of new ideas. The role of a science adviser is to advise on policy matters relating to science and technology as well as science-based policy solutions in general. In both cases, science is supposed to guide policy-making. Policymakers are not supposed to handle affairs related to science grants and awards. How far this balance can be achieved depends on the individuals who become science advisers.

In recent years, however, the office of the PSA has been reduced to a coordinating wing of scientific departments and tasked with work like any other government agency. For instance, it is not the job of a science adviser to prepare sundry dashboards or arrange publicity kiosks at airports. The PSA has also been asked to handle administrative work like screening proposals for the procurement of technology and technological products, reminiscent of the work the much-maligned Director General of Technology Development used to do at the height of the 'Licence Raj' in the 1960s and 1970s. Another responsibility thrust on the PSA was making a digital catalogue of technologies developed by public sector undertakings and an e-marketplace for such technologies to facilitate their procurement by government departments and the private sector. Such routine work can be handled by other agencies and departments. Entrusting such work to the PSA's office erodes its primary function of providing independent and autonomous advice on science to the government.

Why Indus Waters Treaty needs to be renegotiated In light of Pakistan's filibustering, it is appropriate to renegotiate the treaty to reflect contemporary realities.

GEN Pervez Musharraf, in his Royal College of Defence Studies (RCDS) thesis, inferred that water would be the casus belli for future wars between India and Pakistan. After the 2019 Pulwama attack, PM Narendra Modi gave a new twist to this with the statement: "Water and terror cannot be allowed to flow together."The continued intransigence of Pakistan and the resurgence of proxy warfare, despite the Balakot strikes, have brought back the focus on leveraging water as a coercive strategy. India has formally asked Pakistan to review and renegotiate the Indus Waters Treaty (IWT), which regulates water-sharing between the two co-riparian neighbours.

India has the lowest per capita freshwater availability globally and is facing looming water stress. It has 17% of the world's population, but barely 4% of its freshwater reserves. Even by optimistic projections, India has only 90 days of water reserves, compared to many other countries that have two years' worth of stored reserves. More importantly, Indians often fail to treat water as a scarce resource. In my lectures on the IWT, I've been questioned about the legitimacy of using water as a weapon. My response is: Why did we allow Ravi waters to flow to Pakistan when Punjab doesn't even allow the completion of the Sutlej-Yamuna Link canal to share water with Haryana? We are already experiencing domestic water wars over the Cauvery and Damodar rivers.

Invariably, the issue of the upper and lower riparian status and the potential blowback from China is raised. The relevant facts are: first, regarding the Brahmaputra (Tsangpo), 40-50% of the water originates from Tibet, and 70% flows to Bangladesh after accumulating in India. Therefore, the maximum impact would be on Bangladesh, especially during the lean season for flushing requirements. Second, the Indus sources only 5-8% of its water from Tibet and India's requirements

from it are minimal. Most importantly, China does not concern itself with lower riparian states, as evidenced by its actions in the Mekong Delta. We have already experienced the Chinese-triggered Pare-chu (Sutlej) deluge in 2000 and the Brahmaputra floods in 2020. China is proceeding with the Yarlung-Zangbo dam on the Tsangpo to create a 1,100-km channel to divert water to the Taklamakan Desert. The IWT, often touted as a has survived three and a half wars, proxy terrorism

and Pakistan's obduracy for over six decades. The Treaty was signed on September 16, 1960, and, according to recently leaked documents, was a double-pincer effort by the US and the World Bank to keep India in check.India was given full control of the eastern rivers (the Ravi, Beas and Sutlej) while Pakistan received the major share of the western rivers (the Indus, Jhelum, and Chenab). In effect, Pakistan got 135 MAF (80.2%), and India received just 33 MAF (19.8%). India also had to contribute £83 million to finance dams and replacement canals in Pakistan.India was permitted to create limited storage on the western rivers for power generation, flood control and general usage amounting to 3.6 MAF. However, India has failed to fully utilise this capacity and is now trying to catch up,

although such projects require decades of focused management. Of the assessed potential of 18,653 MW of power generation, projects with a capacity of only 3,264 MW (18%) have been commissioned so far. Additionally, while 1.34 million acres are permitted for irrigation, India is using only 0.792 million acres.On the eastern rivers, India has built major dams like Ranjit Sagar/Thein on the Ravi, Pratap Sagar (Pong) on the Beas and Gobind Sagar

(Bhakra-Nangal) on the Sutlej, ushering in the Green Revolution. This transformed India from a nation reliant on PL-480 grain shipments in 1960 to one of the world's leading grain exporters today.

Similarly, Pakistan constructed dams like Tarbela, Mangla and Panjnad, which feed irrigation canals in its Punjab province. However, it has failed to utilise water efficiently, and is suffering frequent floods, high salinity and gross underutilisation of resources. resilient agreement between two warring nations, India recently constructed the Shahpur-Kandi balancing reservoir as an adjunct to the Ranjit Sagar



Dam, which is essential to control the flow of the Ravi. In its absence, large amounts of water have flowed to Pakistan. The two-decade delay in the project was caused by inter-state bickering over power-sharing costs until the Central government took over the project. A major push came with the commissioning of the Baglihar Dam on the Chenab in 2016, following a protracted arbitration process and a largely favourable verdict with river

modifications. According to media reports, the filling of the reservoir resulted in 30% crop losses in Pakistan. Other projects on the Chenab — such as Pakkaldul, Lower Kalnai, Sawalkot, Rattle, and Bursar — are in the pipeline.

Even with these, India will only achieve around 62% of the potential 18,600 MW of power generation. Plans also exist for the Jhelum, including the Wullar Barrage for the Tulbul navigation project to ensure a minimum draft. The IWT has become outdated as it never accounted for climate change, water stress or

livelihood needs like navigation and salinity management in dams and reservoirs. As a result, the Salal Dam is choked with silt, posing a threat to the nearby town of Reasi. Efforts to desilt the dam have been met with resistance from Pakistan.

- Every Indian initiative is opposed in IWT meetings, which have become irregular following the Uri and Balakot strikes. Indian projects, even those in the permissible run-of-the-river mode, are opposed by Pakistan and dragged into arbitration, causing delays and increased costs
- Pakistan has also resorted to using multiple redress mechanisms, such as neutral experts and the Court of Arbitration

(COA), concurrently on the same issues. Since September 2023, India has boycotted the COA and responded only to neutral experts.

Singh, who has been at it for 20 years now, said kwash ink is used for highlighting and texturing the figurines. Animal masks and miniatures, all made from the same material, are also on display at the stall.

Hooghly

Ashok Jha has created his miniature fairground, comprising a merry-go-round, human figures and other fun rides, completely out of springs and bolts. The set, priced at '40,000, has a hi-tech look with a touch of ethnicity. The 37-year-old artisan from Bandel also has religious wall decorations, made with acrylic paint, wood and putty, on display - all priced between `4,000 and `16,000.

On the other hand, the imitation food dishes by Shibnath Barai, 49, are just mind-blowing! Barai - the creator of the Science City dinosaur exhibits — has used fibreglass to mould pieces of fish and chicken drumsticks and pigment colours to provide the texture. The dishes will leave you dearer by '300 and '700. Would you be interested to buy rotten fruits and eggs for '100 per pair? Well, he has these on offer too!

Shubhankar Bakshi, 44, on the other hand, makes fabulous miniatures, especially of monkeys, out of coconut shells. "I just use a plain knife to give shape to the coconut fibres. I don't tamper with the natural construct," he said. His other creations include coconut fibre crabs and other marine creatures and mini dolls made of mahogany fruits.

1984 anti-Sikh riots case: Victim's wife deposes against Jagdish Tytler

In her statement, the victim's wife said an eyewitness told her that Tytler had come to the place of the incident in a vehicle and incited a mob.

NEW DELHI. The wife of a victim to the 1984 anti-Sikh riots case in north Delhi's Pul Bangash Gurdwara on Thursday deposed before a Delhi court against Congress leader Jagdish Tytler.

Special Judge Rakesh Syal recorded the statement of Lakhwinder Kaur, the wife of Badal Singh who was one of the three killed by an irate mob that torched the Gurdwara during the riots. In her statement, Kaur said an eyewitness told her that Tytler had come to the

place of the incident in a vehicle and incited a mob. Kaur told the court that she met Surender Singh Granthi, who worked as a Granthi in the Gurdwara in 2008, who described the incident to her.



"Surender Singh told me he saw the incident from the roof of the Gurdwara. He told me that he saw my husband Badal Singh exiting from the Gurdwara and saw him being attacked by a mob who took out the kirpan of my husband and stabbed him to

death using the same. He told me that Tytler had come to the place of the incident in a vehicle and that he had gathered everyone,' she told the court. She added that Surender Singh told her that the mob engaged in violence upon the incitement of Tytler and her husband's body was put in a cart after he was killed and burnt by placing burning tyres on top of him. She, thereafter,

approached the court for investigation, Kaur said. Tytler's counsel opposed the deposition stating that the account of Granthi was hearsay and not admissible as evidence.



One dies of electrocution, seven hurt

- NEW DELHI. Ten months after a makeshift platform collapsed during an event at Kalkaji temple in southeast Delhi killing a woman and injuring 17 others, another tragedy struck the mandir on Thursday.

Delhi police bust syndicate involved in guaranteed returns investment fraud

Police said complaints by 29 victims against 'HIBOX' app were received at IFSO in which it was alleged that they had been lured to invest in the app with the promise of guaranteed returns.

NEW DELHI. The Intelligence Fusion and Strategic Operations unit of the Delhi Police has busted a syndicate that was allegedly involved in duping people on the pretext of providing guaranteed returns in the name of investment in Application Hibox and seized Rs 18 crore from different bank accounts.

Cops, who believe the scam is probably of more than Rs 500 crore, have issued notices to social media influencers, including Elvish Yadav, who promoted HIBOX app and lured investors to invest via the said application.

Sharing details, DCP (IFSO) Hemant Tiwari said the complaint of 29 victims against "HIBOX" app was received at IFSO on August 16 in which it was alleged that they had been lured to invest in HIBOX with the promise of guaranteed returns of 1% to 5% daily, amounting to 30% to 90% monthly. Many social media influencers and YouTubers viz. Saurav Joshi, Abhishek Malhan alias Fukra Insaan, Purav Jha, Elvish Yadav, Bharti Singh and Harsh Limbachiya, among others, promoted the application.

city of India? Isn't this a blatant disregard for law and order in the city? Why are doctors becoming easy targets in the hospitals? Our demand for central law is shunned on the rationale that other professionals like lawyers and accountants would also demand the same. Are other professionals being assaulted with the same frequency?" asked Dr Aviral

Mathur, president, FORDA. Dr Dhruv Chauhan, a national council member of the Indian Medical Association's (IMA) Junior Doctors Network, said the doctors' situation has become worrisome. "Doctors are now sitting on deathbeds. Anyone who comes to us for help could potentially be a threat, as

seen in this doctor's case. This is no longer just a doctor-versusassailants issue; it reflects a complete breakdown of law and order in our country," he said. The Federation of All India Medical Association (FAIMA) said despite the public outcry after the RG Kar incident, the attacks on healthcare professionals continue to surge.

The Delhi BJP on Thursday launched a city-wide campaign to highlight what it describes as the deteriorating condition of roads caused by the alleged corruption and incompetence of Delhi government. Party leaders, including state BJP President Virendra Sachdeva and several MPs, held protests at various

locations, displaying cut-outs on damaged roads with messages like "Congratulations Delhi! These are the potholes of the most corrupt government."



The campaign kicked off at Khari Baoli, Church Mission Road, and Old Delhi Railway Station Road, where Sachdeva, accompanied by MP Praveen Khandelwal, Delhi BJP Media Head Praveen Shankar Kapoor, and other senior leaders,

pointed to the poor state of infrastructure as evidence of the Kejriwal government's failure.

'The potholes on Delhi's roads are not just a result of one monsoon but represent a decade of corruption in road maintenance and construction," said Sachdeva, accusing the government of taking commissions as high as 35% for road projects. pollution. To ensure effective In a post on X, AAP shared the initiative's implementation, 11 teams have been formed to carry out the spraying process across the designated areas, he added. The bio-decomposer helps break down stubble, preventing farmers from resorting to burning crop residue, a significant



contributor to seasonal pollution.

progress, stating, "Another effective step... Today minister Gopal Rai inaugurated the spraying of bio decomposer mixture for decomposing stubble."As per the statement, the government has simplified the process for

farmers to avail free biodecomposer spraying by requiring only a form submission, with 841 farmers already participating. Rai emphasised that stubble burning is a major contributor to winter pollution and noted that bio-decomposer spraying, which was successful last year, has been reinitiated. The initiative, part of the government's 21-point

winter action plan, also improves soil fertility. Rai highlighted that Delhi has seen a 34.6% reduction in pollution since 2016, with fewer polluted days.

The bio-decomposer powder, sourced from the Pusa Institute, will be sprayed under government's supervision.

Sensex surges 800 points as IT, bank stocks power market rebound

New Delhi. Benchmark stock market indices bounced back sharply after a shaky start, driven by strong gains back shalp y and a shaky start, driven by strong gams in information technology and banking stocks. The S&P BSE Sensex climbed 801.11 points to reach 83,298.21 at 12:31 pm, while the NSE Nifty50 surged 195.15 points, trading at 25,445.25. Despite early losses spurred by heightened volatility from Middle East tensions, the broader market indices showed resilience, with most sectors rebounding.High-weightage Nifty IT led the sectoral indices, rising 1.8%, fuelled by strong performances in Infosys and Tech Mahindra. Nifty Bank, Nifty Pharma, and Nifty Financial Services also contributed to the rally, highlighting strength across key sectors

The top five gainers on the Nifty50 were Infosys, Tech Mahindra, Tata Motors, Axis Bank, and Sun Pharma, all posting solid gains in mid-day trade. Meanwhile, the top losers were Cipla, Hero MotoCorp, BPCL, Shriram Finance, and Apollo Hospitals.Earlier in the day, both the Sensex and Nifty50 faced significant losses amid market jitters driven by the ongoing Middle East conflict. However, the indices reversed course as volatility eased, and investors sought opportunities in IT and banking heavyweights.Meanwhile, international oil prices continue to rise, driven by escalating geopolitical tensions. This has kept market participants on edge, although the current rebound suggests that investors are cautiously optimistic about the domestic market's recovery. With the volatility index dropping, investors will likely keep a close watch on global developments, especially as the tensions in the Middle East remain a key factor in determining market movements in the near term.

Diffusion Engineers shares list at 12% premium: Hold or book profit

New Delhi Shares of Diffusion Engineers Limited made a decent debut on Dalal Street amid a market slump due to the growing Middle East conflicts on Friday, opening at a 12% premium over their initial public offering (IPO) price. While the listing was positive, it fell short of expectations. Before the market debut, Diffusion Engineers shares were trading at a premium of 35.52% in the grey market, leading investors to anticipate a stronger opening. She made this statement while speaking at the 3rd Edition of the Kautilya Economic Conclave on Friday. The finance minister highlighted that India is well on track to double its per capita income within a few years, largely driven

by economic and structural reforms implemented over the past decade.She said that the country has made significant economic progress, bouncing back from the effects of the Covid-19 pandemic. "While it took us 75 years to reach a per capita income of \$2,730, as per IMF projections, it will take only five years to add another \$2,000," Sitharaman said. She described the upcoming decades as 'period-defining', predicting that they will see a rapid improvement in the see a rapid improvement in the living standards of Indians."The upcoming decades will see the

steepest rise in living standards for the common man, truly making it a perioddefining era for an Indian to live in," she said.She further said that these improvements are being seen alongside declining inequality, citing data showing a decrease in the Gini coefficient. The Gini coefficient, which measures inequality in income and consumption,



has fallen for both rural and urban areas. For rural India, it declined from 0.283 to 0.266, and for urban areas, it fell from One of the key factors in India's future 0.363 to 0.314. The largest stakeholders and beneficiaries of the growth process towards Viksit Bharat will be the four major castes, namely 'Garib', 'Mahilayen', 'Yuva' and 'Annadata'. ITC allowed on construction costs for rental realty

NEW DELHI. In a landmark ruling, the Supreme Court on Thursday provided major relief to property owners by affirming that input tax credit (ITC) on construction costs for rental buildings can be claimed, likening such properties to "plants" in a factory

that generate economic output. This decision not only clarifies the interpretation of the goods and services tax (GST) Act but also promises to benefit thousands of taxpayers nationwide who have faced litigation from GST departments, ensuring that those who invest in rental properties can reclaim ITC on related expenses

without restriction.Safari Retreats, engaged in constructing shopping malls for leasing purposes, initiated a writ petition in the Odisha High Court, seeking eligibility for ITC on goods and services utilised in construction of immovable property, excluding plant and machinery. The HC interpreted Section 17(5)(d) to allow for the availability of ITC. In response, the central revenue department filed a special leave petition (SLP), arguing that GST rules don't permit claiming

ITC on immovable property.Subsequently, several petitioners approached the apex court to contest the constitutional validity of these provisions, as the HC had not addressed this issue. In 2023, the apex



court concluded the matter but reserved its orders, with Justice Abhay S Oka and Justice Sanjay Karol delivering the decision on Thursday.As per experts, further clarification is needed whether similar relief measures can be extended to additional sectors, such as ports, airports and data centres. 
