Voting peaceful, BJP faces 'tough fight' on all 5 seats in Karnal

Karnal, Oct 6: With the completion of the voting process on Saturday, the fate of 55 candidates contesting across five Assembly segments was sealed in the electronic voting machines at 1,181 polling booths. As many as 12 candidates were in fray from the Karnal Assembly segment, 15 in Nilokheri, 14 in Assandh, eight in Gharaunda and six in Indri. Around 62.5 per cent of the eligible voters cast their ballot across these five segments in the district. It was 64.6 per cent during the 2019 Assembly elections. Assandh Assembly segment witnessed a voter turnout of 63.9 per cent, Gharaunda 68.5 per cent, Indri 68.3 per cent, Karnal 53.5 per cent and Nilokheri Assembly segment 59.9 per cent. In the 2019 Assembly elections, the voter turnout was 64 per cent in Nilokheri, 72.8 per cent in Indri, 52.6 per cent in Karnal, 67.1 per cent in Gharaunda and 68.4 per cent in Assandh. In the recently held Lok Sabha elections, Gharaunda Assembly segment had recorded 66 per cent voting, Assandh 59.5 per cent, Karnal 57.9 per cent, Indri 68.7 per cent and

New Delhi, Oct. 6: External Affairs Minister S Jaishankar on Sunday took a critical view of the United Nations, saying it was "like an old company", not entirely keeping up with the market but occupying the space. During an interaction at the Kautilya Economic Conclave here, he also said that two very serious conflicts are going on in the world. "And where is the UN on them, essentially a bystander," the minister said. In response to a query on the possible outcome of the US elections, he said the US actually has "made a shift", geopolitically and in its economic outlook, and irrespective of the outcomes in November, many of these trends will "intensify" in the days to come. Jaishankar took part in the interactive session on 'India and the Globe' and spoke of India's role and


challenges amid changing global dynamics.

Suspicious boat spotted off coast in Maharashtra's Palghar, police issue advisory

Palghar, Oct 6: A suspicious boat was spotted off the coast in Maharashtra's Palghar district, prompting the police to issue an advisory, urging law enforcement agencies and the public to remain alert, and a search by the Coast Guard. Locals saw the boat around midnight on October 3 near Chikhle village in Dahanu taluka and reported the sighting to the police, said the advisory. The boat, which appeared larger and wider than typical vessels in the area, was near the shore. However, when locals used their mobile flashlights and two-wheeler headlights to guide it to the coast, it ventured deep into the Arabian Sea, said the advisory. The Coast Guard deployed helicopters to locate the suspicious green and white vessel, it said. The boat had a high front end and a large cabin at the rear, distinguishing it from local fishing vessels. Kolkata, Oct 6: Mamata Banerjee has ordered the Kultali rape-murder case to be registered under the POCSO Act, seeking capital punishment for the culprits within



Mamata Banerjee has directed the police to register the Kultali rape-murder case under the POCSO Act and ensure that the culprits receive capital punishment within three months. The case involves a 10-year-old girl who was found dead in a canal in South 24 Parganas' Kultali on Saturday. Banerjee, while speaking at the Kolkata police body guard lines after virtually inaugurating several Durga Pujas, said that crime has no colour, caste or religion. "I want the police to register the Kultali case under the POCSO Act and ensure that the culprits get capital punishment within three months... Crime is crime; there is no religion or caste. Strong action should be taken against the criminals," the chief minister said, PTI reported. Banerjee also said that media trials in rape cases should stop, as they could interfere with investigations. On Sunday, protests erupted in South 24 Parganas, with people demanding the harshest punishment for those responsible. The BJP also joined the protests. BJP state president Sukanta Mazumdar and leader Agnimitra Paul participated. Meanwhile, the West Bengal police detained a suspect in connection with the case. South 24 Parganas superintendent of police, Palash Chandra Dhali, said that the girl had gone missing in evening while returning from tuition. Bonai forest division on edge as man-elephant conflict boils over

ROURKELA: With rise in man-animal conflicts, authorities of Bonai Forest Division (BFD) are finding it tough to douse the ire of locals.A host of preventive measures including radio collaring of rogue elephants and drone surveillance seem falling apart. Sources said for the last couple of years, BFD has been witnessing an unprecedented rise in elephant depredation incidents. The division from April till now has witnessed at least eight human deaths along with substantial damage to houses and crops. In 2023-24 the division had reported at least 12 human casualties and BFD had to pay around Rs 1.5 crore in compensation for the deaths and loss of property. Two marauding solitary tuskers staying in Koida and Bonai forest ranges, both fitted with radio collars recently, are the biggest trouble markers. In the latest incident, one of the radio-collared tuskers killed an elderly villager in the wee-hours of Friday. A day earlier two forest employees tracking an elephant herd in Kulposh range were injured in an attack by an elephant.Koida-B zilla parishad member Ashok Naik said resentment is growing against the frequent elephant raids and failure of the Forest department to ensure safety of the poor and vulnerable villagers. Villagers living in mud houses in forest are at higher risk with elephants attacking mud houses attracted by the smell of country liquor or in search of

Orissa HC relief for 49 applicants barred from **OPSSB** posts

CUTTACK: The Orissa High Court on Friday directed the Odisha Police State Selection Board (OPSSB) to permit 49 candidates barred for upper age limit criteria to submit their application forms and participate in the recruitment process for 1,360 posts of sepoys/constables in 16 different battalions.

The OPSSB had invited applications for the posts with minimum 18 years and maximum 23 years age limit through an advertisement issued on August 29, 2024 and October 22 is the last date for submission of application forms.All the 49 candidates had filed a petition challenging the advertisement on the ground that though recruitment for the posts of sepoys/constables in 16 different battalions was last held in 2018, no upper age relaxation was given for those who had crossed the 23 years age limit during these six years. Appearing on behalf of the petitioners, advocate Rajib Rath sought direction to the OPSSB to permit them to submit their application forms and allow them to appear in the open competitive recruitment examination 2024-25.

Granting relief, the single judge bench of Justice Sashikanta Mishra on Friday ordered, "The petitioners shall be permitted to apply in the online/offline mode pursuant to the advertisement dated 22.09.2024 and also participate in the recruitment process."

Their results, however, shall not be declared without obtaining leave of this court, Justice Mishra said in the interim order and posted further hearing on the matter to November The petitioners belong to General, SEBC, SC and ST categories. While issuing notices returnable wthin four weeks, Justice Mishra took on record submissions of the petitioner counsel for relaxation of the upper age limit by amending and modifying eligibility clause in the August 29, 2024 advertisement by taking into consideration Covid-19 pandemic, Odisha Civil Service (Fixation of Upper Age Limit) Rules 1989 and Order 21 of Odisha Battalion Service (Method of Recruitment and Conditions of Service of Sepoys, Constables, Havildars and ASI (Armed) Order 2022), which provide relaxation clause.

NDA, YSRC getting ready for Guntur MLC poll

GUNTUR: With the voter enrolment for the Graduates Constituency of the erstwhile Guntur and Krishna Districts fast approaching, the TDP-led NDA and YSRC are eyeing to win the seat. The YSRC, with 11 seats in the Assembly of 175, has announced senior leader Punuru Gowtham Reddy as its candidate for the seat, while the ruling coalition is yet to announce the nominee though speculation about former Tenali MLA Alapati Rajendra Prasad is high. Alapati was reportedly promised MLC seat, after he was denied Tenali ticket in the general elections. Posters and banners of Alapati along with local TDP MLAs Nazeer and Galla Madhavi have been set up across the city by party cadres. The poll will be necessitated with the end of the term of MLC KS Lakshman Rao on March 29, 2025.

The district administration has issued a notice for voter enrolment. November 6 is the last date for submitting applications. The draft voter list will be released on November 23 and after addressing objections, the final draft will be published on November 30.Guntur District Collector S Naga Lakshmi recently held a review meeting with leaders of various political parties and officials on the MLC elections. She informed that people who graduated before November 1, 2021, and complete three years are eligible as voters for the graduate MLC election. Those who completed degree, and diploma after intermediate can also apply for their vote, she added. Voters should be residents of Guntur, Palnadu, NTR, Krishna, and selected mandals of Bapatla and Eluru districts and graduated from any institution in the country should submit Form-18 to register their vote.

Andhra Pradesh government allocates Rs 100 crore for Akhanda Godavari project

There is a tremendous opportunity to develop East Godavari into a tourist hub. She further mentioned plans for the upcoming Godavari Pushkarams in 2027. What are your plans for developing the

riverside towns in East Godavari? We are preparing for the upcoming Godavari Pushkarams in 2027. We are holding a series of meetings with various departments. Our focus is on setting up Pushkar Nagar, which

will be connected to railway stations and bus stands. With Kovvur now part of East Godavari after the district reorganisation, both towns, Rajamahendravaram and Kovvur, are under one administration. These towns, located along the Akhanda Godavari, are expected to see an influx of 2-3 crore people during Pushkarams. We plan to widen roads according to the master plan. We will enhance both old and new ghats.

What are your plans to develop East Godavari as a tourist hub?



We see a tremendous opportunity to develop East Godavari into a tourist hub, especially since Minister Kandula Durgesh hails from this area. Our plans include promoting river tourism, temple tourism, and spiritual tourism. Several star hotels are being planned under a public-private partnership model. Projects such as developing Bridge Island and Havelock Bridge as tourist spots are underway. The officials are also working on a boat tourism initiative along the canal to Kadiyapulanka, which is famous for its nursery gardens. Resorts are being set up in these areas, and the Akhanda Godavari project has been allocated Rs 100 crore for further development.

What is the current status of the sand policy in the district?

The district has seen significant pressure due to the large number of sand ramps on the Godavari River. We have established a task force to prevent illegal sand smuggling and we have registered 64 cases for violations. The sand policy is reviewed daily to address issues and improve enforcement.

What are your observations on the river Godavari floods and the rescue operations in the region?

When the Godavari River swells to a flow of 10 lakh cusecs, we issue the first flood warning and relocate villagers from three Lanka areas to relief centres. The threat of flooding often poses challenges for smooth drainage into Both State and Central governments have funded the construction of a sewage treatment plant to divert drainage away from the river and prevent pollution. In West Godavari, island villages are particularly vulnerable during floods. Last year, we saw 16 lakh cusecs of water released into the sea, and in 2022, it was as high as 25 lakh cusecs. We are constantly battling nature, and our official machinery remains on alert to protect lives and property from floodwaters.

What measures have you taken on preventing child marriages?

HC restrains illegal sand quarrying on waterbody in Muthoor, grants interim injunction

MADURAI: Taking into account that sand was being quarried beyond the permissible

limit from a land located near a waterbody in Muthoor village in Sivaganga district, the Madurai Bench of the Madras High Court granted an interim injunction on further quarrying operations.A division bench of Justices R Subramanian and L Victoria Gowri was hearing a public interest litigation (PIL) petition, filed by one C Perumal of Sivaganga district, seeking a direction to cancel the permission granted for sand quarrying in Kannakulam kanmoi in the village.According to the petitioner, residents of Muthoor village depend upon agriculture for their livelihoods, and a person, who owns

out illegal sand quarrying activities. Though permission has been granted for quarrying activities in



land near the waterbody, has been carrying Muthoor, the alleged person has been

involved in quarrying beyond the permissible limit, and sand was being removed from up to 10 feet in depth. If such

> quarrying activities are permitted to continue, it will adversely affect the waterbody, said the petitioner, who moved the high court seeking direction to revoke the permission granted for sand quarrying activities.earing the petition, the court observed that the documents and photographs produced, and prima facie found that the said person had quarried sand beyond the permissible limit. A 10-feet deep pit has been created due to the quarrying operations, said the court, and granted an interim injunction restraining further quarrying operations in the region. The case

has been adjourned by four weeks.

Wild animal menace sparks reverse migration of farmers to the plains in Kerala

KOCHI: Shelju Subramaniam, 40, whose grandfather migrated from Adimali to Kanthalloor, considered the vegetable bowl of Kerala, some 40 years back, has relocated from Idukki's high ranges to the plains of Muvattupuzha in Ernakulam.Reason: The wild elephants that have been destroyinghis farm for the past couple of years."I own 2.5 acres of land there (Kanthalloor), but I used to cultivate 20-25 acres after taking more land on lease. I have now decided to quit farming in Kanthalloor as animals have started venturing into human settlements and are destroying our crops. Everyone

seems to be leaving," says Shelju, two-time recipient of the state government's 'best farmer' award. He has purchased bout an acre near Muvattupuzha, where he has cut down rubber trees to grow crops suited to the area. Another farmer Sebastian, 57, says a big problem in Kanthalloor is the unhindered growth of eucalyptus grandis trees on the land purchased by ousiders who do not live there."They come here once every three or five years to cut down and sell the trees. These trees near human habitations are where elephants take shelter during the day and enter the farms at night," says Sebastian, adding that wild elephants destroyed his sabarjilli (pear) farms and motorcycle



recently.

"I have stopped farming now, and am going to a resort nearby to earn my livelihood," says Sebastian, who owns about 67 cents in Kanthalloor.Fr Stanley Pulprayil, the vicar of St Mary's Forane Church, Karimannoor near Thodupuzha, says his church has had 20-25 new families in the last five years or so, all of whom have vacated their properties on the hills due to wild animal attacks."The high ranges are getting vacant, slowly. The people are leaving, but without selling their properties. They go there once in a while to look after the property," Fr Stanley says. Alex Ozhukayil, chairman of Kerala Independent Farmers Association (KIFA), says wild animal attacks and the government's

indifferent attitude to deal with the issue are forcing people in the Malabar region too to leave their farms in the hills."Settlers of Koorachundu and Chakkittapara in Kozhikode, and Kottiyoor in Kannur, are looking to quit farming as wild animals, including elephants, wild boars and monkeys, continue to wreck their crops," Alex says.o, in a slow but obvious reverse migration trend in Kerala, families are returning to the plains more than 100 years after their forefathers from Central Travancore cleared the forests and tilled the soil in the hills of Idukki and Malabar

to grow a range of crops from paddy to tapioca, coconut to rubber, and pepper to cardamom.

While the first set of internal migration took place from 1829 when Travancore rulers encouraged farmers to settle in the high ranges of Idukki and cultivate cardamom, it accelerated during World War II (1939-1945), with food scarcity acting as the catalyst. This led the Travancore king to announce the 'Grow more food scheme' promoting migration. It is reckoned over 1 lakh people migrated to Malabar between 1945 and 1960, as their settlements helped in the establishment of roads, schools and hospitals in the high ranges. The trend may accelerate if the government continues to remain aloof, says M M Abbas, who has been carrying out organic farming on a 1-acre plot in Kanthalloor for the past 20 years."I will be forced to end cultivation in Kanthalloor due to wild animal menace.

106 & counting: Malaria cases in Noida highest in 3 years

Noida. Malaria cases have reached an all-time high in the city since 2022, with 106 people infected so far. Twenty-one cases were recorded over the last 10 days alone. Dengue cases, meanwhile, have also touched 128. The health department has initiated extensive screening and door-to-door surveys to identify hotspots and areas reporting waterlogging."Till date, over 150 notices have been issued to residential societies and households where mosquito larvae were detected," district malaria officer Sruti Kirti Verma said.In 2023, Noida recorded 44 malaria cases, while 104 were reported in the preceding year.

Ghaziabad has reported 21 malaria cases so far. The city has also seen 38 dengue patients this season, of them six are currently admitted to various hospitals. In Sept, one suspected dengue death case was reported from the city. Across the two NCR cities, hospitals have



flagged a rise in the number of patients visiting outpatient departments (OPDs) with flu-like symptoms, including high fever, cough, and runny nose. Doctors told TOI earlier that they are treating over 350 patients at OPDs, many presenting with low platelet counts — a common symptom associated with dengue — alongside gastrointestinal infections.

Health officials are urging residents to remain vigilant, take preventive measures, and report any stagnant water sources that could facilitate mosquito breeding.

Master plans approved by 3 boards, now await govt nod

Noida. UP's industrial development minister, Nand Gopal Gupta Nandi, reviewed the proposed Master Plan 2041 for Noida, Greater Noida, and Yamuna authorities in Lucknow. The master plans have been approved by their respective boards and await govt approval.

"These regions are set to become the most developed in the country over the next 50 years, with seamless connectivity between them," said Nandi.

Officials said the Jewar Airport will spur regional growth, and the plan includes mixed-use developments for hotels, restaurants, and workspaces. Shailendra Bhatia, OSD Yamuna Authority, informed the minister about the Authority's Master Plan 2041 proposal. "The plan now includes 226 villages with a total area of 769 square kilometres," he said. The Master Plan 2041 expands the airport and aviation hub area to 6,286.73 hectares and plans 98 sectors. New land-use categories for hospitality and industrial purposes have been introduced.In Mathura, the UP Braj Teerth Vikas Parishad proposed development plans. Meanwhile, Noida's strategy focuses on developing 30 villages in Gautam Budh Nagar and 60 in Bulandshahr, with 40% industrial, 18% green, and 18% residential zones.

At 55.5%, Faridabad sees its lowest turnout since 2009

Faridabad. The six assembly constituencies of Faridabad recorded its lowest turnout since 2009.According to data handed out by the local election office, Faridabad had recorded a turnout of 55.5% till 8pm on Saturday, down from 57.3% in 2019. The previous assembly poll — in 2014 — saw a turnout of 65.7% while it was 62.1% in 2009. Among 22 districts of Haryana, Faridabad had the lowest turnout till Saturday evening. Neighbouring Gurgaon fared a little better — registering 57.2%. The day started on a slow note. Till 9am, the six constituencies Prithla, NIT Faridabad, Badkhal, Ballabhgarh, Faridabad and Tigaon — had seen turnouts in single digits. Around an hour later, voting percentage improved somewhat. So, it was 8.3% in Badkhal, 10% in Ballabhgarh, 8.7% in Faridabad, 11.2% in NIT Faridabad, 13.5% in Prithla, and 9% in Tigaon.By evening, most of these seats had seen a dip in turnout from the last time. The turnout in Prithla dipped from 76.7% to 70.6%, while that in NIT came down from 61.4% to 60.1%. In Badkhal, it was 49.2% in 2019, but 48% this time. In Tigaon, it came down from 55.8% to 53.2%. The numbers, however, increased in Faridabad

Nuh women: 'No other demand, just give us water'

Nuh. Living in Ghasera, about 14km northeast of Nuh's main town, with two young daughters and her daily wager husband, Asma Khan (25) said life in the village was still a struggle for the basics, like water. On Saturday, she was among the first few to reach the polling booth to make sure that her vote counted.

"We don't have high aspirations. We are just asking for water. It is a basic requirement. My husband is a labourer, and our family cannot afford water tankers that usually charge over Rs 1,500," she said.

One of the remotest villages of Nuh, more than 15,000 residents here are yet to get a piped water supply and are still dependent on two watering troughs that are also used by cattle. Haseena (60), who also cast her vote early in the day, said access to water is a fundamental right everywhere, but in Ghasera it came at a cost. "We are forced to allocate a portion of our already limited resources to meet our daily water needs. The lack of free and readily available water for the poor highlights the stark inequalities present in society," she said.

Across Nuh, the situation is no different.

Tank water under scanner after 400 fall ill at condo, 10 kids in hosp

Noida: More than 400 residents of Supertech Ecovillage 2 in Greater Noida West, many of them children, fell ill allegedly after consuming contaminated water since Monday morning with many complaining of nausea, vomiting and diarrhoea. Residents claim the society's tanks were cleaned recently but suspect that chemicals may not have been flushed out properly, leading to widespread illness across the 12 towers of the society. There are around 3,500 residents in Ecovillage 2.The health department chipped in on Monday evening and set up a medical camp at the condominium after nearby pharmacies fell short of necessary medicines. Abhishek Singh, a resident of Tower C4, said his two-year-old son was admitted to intensive care at Yatharth Hospital after his health worsened on Tuesday morning. The child was taken to the hospital's OPD with a high-grade fever and nausea. "But his health deteriorated, and he began having seizures. So, the doctors at the hospital admitted him to ICU for special care," said. Abhishek's son is not alone. Currently, more than 10 children are admitted to various hospitals. Abhiram Singh, who lives in Tower C3, said his three-year-old son has been suffering from diarrhoea, fever and nausea since Monday and has been admitted to Surbhi Hospital since. Surbhi Rawat, a resident of Tower C2, whose two-year-old son is in ICU, said the toddler was in extreme pain. "He was crying all day. What if something bad happens to him? Who will take the responsibility? How can these people be so irresponsible?" she asked. Dr Jetavya Kushwaha, a paediatrician who runs a clinic at the society's marketplace, told TOI that since Monday evening a significant number of children had come in for a consultation with a similar set of symptoms — loose motion and vomiting. A few also had high-grade fever."All the children were from Ecovillage 2. By Tuesday morning, the symptoms were also visible among adults. I am told many have visited local pharmacies and hospitals for consultation today," he said. Alok Singh, a resident of Tower C7, said his family of four endured discomfort throughout Monday night. "We usually don't eat anything from outside. On Monday too, dinner was homecooked and simple. But we all experienced a severe stomach ache and nausea. We consulted a doctor on Tuesday," he said. Initially, most families thought these were isolated cases of dysentery or other stomach ailments, but as messages started circulating on the society's WhatsApp group, they realised the source of the contamination could be common — water.YG Estate, a private firm that is responsible for the society's maintenance for the last four years, told TOI that their team inspected the water tanks in all the towers soon after residents' complaints started to pour in."The health department has collected water

samples and sent them for testing. If any deficiency is found, it will be rectified. Action will also be taken against staffers if found negligent," Azeem, the society's maintenance team manager, said. GNIDA provides water to Ecovillage 2. With hundreds of residents switching to packaged water, many local shops and grocery delivery apps on Tuesday said they had run out of stock."As the water might be the source of contamination, I ordered two bottles of packaged water yesterday. But since this morning,

Islamabad in lockdown after Imran Khan's supporters clash with cops, internet cut

Islamabad. Pakistan's capital was locked down on Saturday, swarmed by security forces with mobile internet cut as supporters of jailed ex-prime minister Imran Khan attempted to seize the streets in protest. Sidelined by dozens of legal cases, Khan was barred from standing in the February elections that were marred by allegations of rigging.But his Pakistan Tehreek-e-Insaf (PTI) party has defied a crackdown to needle the government with regular demonstrations.PTI activists began driving to Islamabad on Friday from his powerbase in northwestern Khyber Pakhtunkhwa province, but were met with shipping container roadblocks and volleys of tear gas.

On Saturday, small and scattered convoys pressed in on Islamabad in defiance of the government, which approved troops for deployment on the streets -- citing the need to guarantee security ahead of a Shanghai Cooperation Organisation (SCO) summit due to open on October 15.Interior Minister Mohsin Naqvi later told local media that more than 550 people were arrested.

Protests were also due Saturday in Lahore, however the main motorway linking the eastern megacity to the capital was blocked.

"I am so proud of all our people," said a message from Khan posted on social media site X on Saturday afternoon. "You showed unfaltering resilience and courage as you came out yesterday and overcame unbelievable obstacles."Amnesty International said the communications cuts and road blockades "infringe on people's right to freedom of expression, access to information, peaceful assembly and movement". "These restrictions are part of a worrying clampdown on the right to protest in Pakistan," the rights group said. The social media site X -- formerly Twitter -- has also been blocked across Pakistan since after the election, when the mobile internet was likewise cut on polling day and PTI allege

Trump returns to rally at site of assassination attempt in Pennsylvania

Butler, Pennsylvania. Republican presidential candidate Donald Trump on Saturday returned to the rural Pennsylvania site where he was nearly assassinated, rallying a large crowd in the critical battleground state one month before the November 5 election." As I was saying," Trump said as he appeared on stage, pretending he was resuming the speech that was interrupted when he was grazed in the ear by a bullet on July 13. Trump saluted firefighter Corey Comperatore, who was shot and killed by the shooter, and two other people who were wounded. At 6.11 pm, the exact time when gunfire erupted on July 13, Trump called for a moment of silence. A bell then tolled four times, once for each of the four victims, including Trump

"He did not stop our movement, he did not break our spirit," Trump said of the attempted assassin, who was shot and killed by security sharpshooters. Trump ally Elon Musk, CEO of Tesla and owner of social media platform X, was scheduled to appear on stage at the rally, his first time at a Trump campaign event since he endorsed the former president after the July 13 assassination attempt. The crowd appeared to be in the tens of thousands, many wearing Trump regalia. Some chanted the "fight, fight, fight" slogan Trump used to rally his followers moments after he was shot.

"We're here to say, we can't be intimidated, we can't be stopped," Ohio Republican Senator JD Vance, Trump's vice presidential running mate, told the crowd. Vance rejected the argument from Vice President Kamala Harris and other Democrats that Trump represents a threat to democracy.

Several migrants die while trying to cross **English Channel: French** minister

Paris Several people, including a child, died trying to cross the Channel from France to England, French Interior Minister Bruno Retailleau said on Saturday. Attempts to cross the Channel in small, overloaded boats are frequent despite strong currents in what is one of the world's busiest shipping



lanes."Smugglers have the blood of these people on their hands and our government will step up the fight against these mafias that organise these deadly crossings," Retailleau said on X.A total of 14 people were on the boat. One was flown by helicopter to a hospital after a search and rescue operation was conducted on Saturday morning, local maritime authorities said. The incident was the latest in a series this year, including one last month in which 12 migrants died when their boat capsized in the Channel.

Tropical storm Milton forms in Gulf of Mexico, may hit Florida as hurricane

Miami. A storm system that was brewing in the Gulf of Mexico strengthened into Tropical Storm Milton on Saturday, and forecasters warned that it could intensify into a hurricane and slam into the west coast of Florida next week.

Tropical Storm Milton was about 245 miles (395 kilometers) north of Veracruz, Mexico, the National Hurricane Center in Miami said in an afternoon advisory. It had maximum sustained winds of 40 mph (65 kph) and was heading toward the north-northeast at 3 mph (6 kph).Florida Governor Ron DeSantis declared a state of emergency in 35 counties ahead of the storm's potential landfall. Since many of those counties are still recovering from Hurricane Helene, DeSantis asked the Florida Division of Emergency Management and the Florida Department of Transportation to coordinate all available resources and personnel to supplement local communities as they expedite debris removal. Though no coastal watches or warnings were in effect, the hurricane center said the Florida Peninsula, the Florida Keys,

Mexico's Yucatan peninsula and the northwestern Bahamas should monitor the system's progress. The storm is forecast to strengthen and bring the risk of life-threatening impacts to parts of Florida, with hurricane and stormsurge watches likely in effect from Sunday. Parts of the state are expected to have heavy rainfall beginning that day, threatening flash, urban, and areal flooding, along with some river flooding."There is an increasing risk of life-threatening storm surge and wind impacts for portions of the west coast of the

Florida Peninsula beginning late Tuesday or Wednesday. Residents in these areas should ensure they have their hurricane plan in place, follow any advice given by local officials, and check back for updates to the forecast," the center said. Farther east, Hurricane Leslie was moving over the open Atlantic and was posing not a threat to land, forecasters said.



The storm was located about 810 miles (1,305 kilometers) west-southwest of the southernmost Cabo Verde Islands and had maximum sustained winds of 80 mph (130 kph). There were no coastal watches or warnings in effect.Meanwhile, Hurricane Kirk remained a Category 4 major hurricane, and waves from the system were affecting the Leeward Islands, Bermuda, and the

Greater Antilles, forecasters said. The storm's swells were expected to spread to the East Coast of the United States, the Atlantic Coast of Canada and the Bahamas on S a t u r d a y n i g h t a n d Sunday.Forecasters warned the waves could cause lifethreatening surf and rip current conditions.Kirk was expected to weaken starting Saturday, the center said. Though there were no coastal warnings or watches in effect for Kirk, the center said those in the Azores, where swells could hit Monday, should monitor the storm's progress.Kirk was

about 1,140 (1,835 kilometers) northeast of the northern Leeward Islands with maximum sustained winds of 120 mph (195 kph). The storms churned as rescuers in the US Southeast searched for people unaccounted for after Hurricane Helene struck last week, leaving behind a trail of death and catastrophic damage.

Kamala Harris vows support for hurricane- How Israel's plan to boobyhit North Carolina, surveys destruction

Charlotte Democratic presidential nominee Kamala Harris pledged ongoing federal support and praised the "heroes among us" as she visited North Carolina on Saturday in the aftermath of Hurricane Helene, her second trip in four days to the disaster zone. The vice president was in Charlotte one day after a visit to the state by Republican Donald Trump, who is spreading false claims about the federal response to the disaster. Harris opened her visit by attending a briefing with state and local officials, where she thanked "those who are in the room and those who are out there right now working around the clock."She promised federal assistance would continue to flow and added praise for the "strangers who are helping each other out, giving people shelter and food and friendship and fellowship."Despite Trump's claims that the federal response



in the state has been "lousy," Democratic Governor Roy Cooper said the state was "deeply grateful for the federal resources that we have. FEMA has been on the ground with us since the very beginning,' he said, referring to the Federal Emergency Management Agency.

After her briefing, Harris helped pack toiletries into aid kits at a distribution center, where she met Angelica Wind from hard-hit Asheville, who was there to

volunteer with her daughter and a friend even though Wind said her own family was still without power and people were "just surviving." There's a lot of resilience," Wind told Harris, adding that, "We want to make sure people don't forget about us."Harris assured her the federal government was "here for the long haul."

Melissa Funderbunk told Harris about driving a truck carrying assistance to people in remote Morganton, "where people weren't coming."Earlier in the week, Harris was in Georgia, where she helped distribute meals, toured the damage and consoled families hard-hit by the storm. President Joe Biden, too, visited the disaster zone. During stops over two days in the Carolinas, Florida and Georgia, Biden surveyed the damage and met with farmers whose crops have been destroyed.

trap Hezbollah pagers took 9 years: Report

World Thousands of pagers and walkie-talkies used by Hezbollah, the Iran-backed militant group in Lebanon, exploded on September 17 and 18, killing over 30 and injuring thousands. New details have emerged revealing that this was part of a longcoordinated operation by Israel spanning years. For nearly a decade, Israel discreetly boobytrapped the devices, using them for eavesdropping while maintaining the capability to remotely detonate them. According to a Washington Post report, the first phase of the plan was initiated by Israeli spy agency Mossad in 2015, with the devices being covertly introduced into Lebanon.

'For nine years, the Israelis contented themselves with eavesdropping on Hezbollah, while reserving the option to turn the walkie-talkies into bombs in a future crisis. But then came a new opportunity and a glitzy new product: a small pager equipped with a powerful explosive," The Post reported, citing officials. The plan for the pager explosion operation emerged in 2022, more than a year before Hamas's October 7 attack, the report further said. The initial sale pitches of the Apollo AR924 pagers to Hezbollah were also sent two years ago.

The slightly bulky pagers and oversized battery that could offer long operational days were convenient for the Israeli experts to place the explosives. The "pagers' most sinister feature" was a two-step deencryption procedure that required the user's hands. That ensured most users would be holding the pager with both hands," when Mossad triggered the devices remotely on September 17, The Post reports."You had to pus two buttons to read the message", and in the ensuing explosion, the users would almost certainly "wound both their hands," and thus "would be incapable to fight," an official was quoted as saying.Mossad, which had spent years trying to penetrate Hezbollah through electronic monitoring and human informants, learned that one of the group's key concerns was having a surveillance-free communication method that Israel could not track.

Israel hits Beirut with 'very violent' strikes, claims Lebanese media

Beirut. Official Lebanese media said Israeli strikes hit south Beirut Saturday night into Sunday, some of them "very violent", with AFP correspondents hearing explosions for over two hours in one of the most intense barrages yet."Israeli enemy warplanes carried out four very violent strikes on (Beirut's) southern suburbs, and one strike on the Chweifat" area, with ambulances rushing to the site, Lebanon's National News Agency said.AFP correspondents heard explosions in south Beirut and its outskirts for more than two hours following the NNA's statement.AFP footage showed plumes of smoke rising from the targeted areas.In one south Beirut location a ball of flame rose into the air while flares shot up amid thick

smoke for about an hour.An AFP correspondent in the Sabra area close to Beirut's southern suburbs saw dozens of people on the streets, some carrying bags fleeing on foot or on motorbikes as explosions echoed in the background. The NNA said air traffic at Lebanon's only airport in Beirut, close to the targeted areas, was "ongoing despite the Israeli enemy's aggression on the southern suburbs. Several Middle East Airlines planes have just landed". The Israeli army said it was "currently striking terror targets belonging to the Hezbollah terrorist organisation in the area of Beirut" in a statement on its Telegram channel.Earlier Saturday night, the Israeli army announced a new call for residents to evacuate from

Beirut's southern suburbs, as it continued to target Hezbollah positions in the Lebanese capital."For your safety and that of your family members, you must immediately evacuate the designated buildings and those adjacent to them and move away from them at least 500 meters," said spokesperson Avichay Adraee on social media, alongside satellite images highlighting areas in the Burj el-Barajneh, Haret Hreik and Chweifat al-Amrussiya neighbourhoods.Lebanon's Hezbollah movement and its foe Israel have been exchanging near-daily cross-border fire for nearly a year in fallout from the Gaza war.But since September 23, Israel has launched devastating air strikes on targets in Lebanon that have killed.

Fight, fight, Vote, vote, vote: Elon Musk puts on a show at Trump rally

Elon Musk displayed his staunch support for Donald Trump as he shared a stage with the Republican presidential nominee, declaring that "nothing is more important" than voting for him.

World In a spirited display of support, billionaire tech magnate Elon Musk rallied behind Republican presidential nominee Donald Trump in Butler, Pennsylvania, the same venue where the former US President survived an assassination attempt in July. Musk, donning a black 'Make America Great

Again' (MAGA) hat, jumped up and down as he took the stage to a cheering crowd of Trump supporters on Saturday. The two warmly shook hands before Musk addressed the rally, telling them that "nothing is more important" than voting for Trump.The



wealthiest man in the world warned that "this will be the last election" if Trump doesn't win, peddling a false claim that Democrats aim to infringe upon Americans' rights, including free speech and the right to bear arms."I think this election is the most important election of our lifetime. This is no ordinary election," Musk said. "President Trump must win to preserve the Constitution. He must win to preserve democracy in America. This is a must-win situation, must win."In a jab at US President Joe Biden, Musk remarked that Biden is a man who "couldn't climb a flight of stairs," contrasting him with Trump, whom he praised for his resilience after narrowly escaping a shooting on the same stage on July 13The true test of someone's character is how they behave under fire, and we had one president who couldn't climb a flight of

stairs and another who was fist pumping after getting shot," he remarked. Invoking Trump's words from the moments

after the shooting, Musk chanted, "Vote, vote, vote. Fight, fight, fight."

This appearance marked the first time Musk attended one of Trump's campaign rallies, highlighting the growing alliance between the two men as the presidential election approaches. Musk, who heads Tesla, SpaceX, and X (formerly Twitter), endorsed Trump on the day of the assassination attempt, posting a video of the 78-year-old Republican's raised fist on his official X handle with the caption, "I fully endorse President Trump and hope for his rapid

Throughout the election cycle, Musk has consistently shown his support for Trump, establishing a super PAC to bolster the Republican nominee's campaign through extensive get-out-the-vote efforts in the crucial final months. The admiration seems mutual; Trump has mentioned plans to appoint Musk to a task force aimed at implementing "drastic" cuts to government spending if he's back in the White House.

Netanyahu's video message for Macron over call for arms embargo: Shame on them

■ Israeli Prime Minister Benjamin Netanyahu denounced French President Emmanuel Macron's proposal for an arms embargo on Israel, and questioned whether Iran had restricted weapons deliveries to its proxies.

World French President Emmanuel Macron's call to halt arms deliveries to Israel for use in Gaza was sharply condemned by Israeli Prime Minister Benjamin Netanyahu, who called the proposal a "disgrace". In a video statement on Saturday, Netanyahu denounced Macron's stance, stating that Israel was fighting a multi-front war against armed groups backed by Iran."As Israel fights the forces of barbarism led by Iran, all civilised countries should be standing firmly by Israel's side," Netanyahu said. "Yet President Macron and other Western leaders are now calling for arms embargoes against Israel. Shame on them."He pointed to Israel's battles on several fronts, including against Hamas in Gaza, Hezbollah in Lebanon, the Houthis in Yemen, Shiite militias in Iraq and Sria, and terrorists in the West Bank.Netanyahu sought to highlight the hypocrisy in the calls for a pause on arms shipments to Israel, asking whether Iran had restricted weapons to its allies."Of course not," the Israeli leader said. "This axis of terror stands together. But countries who supposedly oppose this terror axis call for an arms embargo on Israel. What a disgrace!"Despite the international pressure,



Netanyahu remained defiant, stating, "Israel will win with or without their support. But their shame will continue long after the war is won."Macron had earlier suggested in an interview that shipments of arms to Israel used in the conflict in Gaza should be suspended to facilitate a political solution and avoid further escalation."I think we are

not being heard," Macron said. "It is a mistake, including for the security of Israel," he added, expressing concerns that the war was breeding "hatred". He also noted that avoiding escalation in Lebanon was a priority, even as Israel pummelled Hezbollah targets in Beirut. "Lebanon cannot become a new Gaza," the French leader stated. Following Netanyahu's strong rebuttal, Macron's office issued a statement describing France as a "steadfast friend of Israel", while terming Netanyahu's remarks as "excessive and detached from the friendship" between the two nations.Qatar, a mediator in ongoing Gaza ceasefire talks, praised Macron's statement as an "important and appreciated step towards stopping the war."Jordan also welcomed the French president's comments, calling for a "complete ban on the export of weapons to Israel" and stressing the need for "real consequences" for Israel's actions.

'Fighting for women's rights assured under Constitution'

KOCHI: The 'Forum for Gender Equality Among Muslims' (FORGEM), a group of Muslim activists who wanted timely reforms in Muslim Personal Law, is not in any way opposing communal beliefs but merely demanding that the rights of women are guaranteed under the Constitution, the members said at the 'Equality Conference' held in Kochi on Saturday.In fact, the community has adopted many changes to the Muslim Personal Law (Shariat) Application Act, 1937, but certain areas, especially gender justice, failed to reflect the same, they pointed out.

"What we are fighting is the fact that there is no reform happening with respect to certain things in the religion that we deeply believe in, despite many changes being adopted (in the Muslim personal law) over the years. The provisions include those regarding marriage, divorce, maintenance, inheritance and adoption," said Dr Sheena Shukoor. Except for those governing inheritance, the changes happened in all others. What we're doing is asking for the rights. No one should be afraid of doing that because the Constitution gives you certain rights, that you can live with dignity and you will be treated equally. We'll highlight and fight for that equality right," Dr Sheena Shukoor added.

Interestingly, Dr Sheena's husband Advocate Shukoor, who had acted in the hit film Nna Thaan Case Kodu remarried his wife under the Special Marriage Act. The couple did this to make sure that their three daughters could inherit his properties, which was not guaranteed under the Muslim law of succession. The FORGEM was formed two years back to address the issues faced by women in the community. It held similar conferences in Kozhikode and Kodungallur in the previous years.

Sambalpur varsity researchers find supplement to combat malnutrition

Odisha. Researchers of the Department of Food Science Technology and Nutrition of Sambalpur University have developed a nutritional supplement comprising traditional and rare super food which can combat malnutrition, particularly among infants and children. The supplement 'Nutri Nest' is centre around Kalabati rice (black rice), a nutrient-rich variety of rice native to Odisha. It also comprises other ingredients including peanuts, ragi, soybean, jaggery and milk powder, creating a comprehensive dietary solution. The breakthrough formulation, developed over a period of one year, received patent in February. It was part of research scholar Payal Sharma's master's dissertation work under supervision of associate professor Aparajita Priyadarshini.

Most of the research was conducted at the Centre of Excellence - Natural Products and Therapeutics (COE-NPT), Department of Biotechnology and Bio-informatics of Sambalpur University under supervision of its coordinator Prof Pradeep Kumar Naik.The not-so-common Kalabati rice is known for its high content of Anthocyanin an antioxidant, essential vitamins and minerals. For the particular formulation, the rice is being sourced specifically from tribal dominated Jujumura block in Sambalpur.

In 30 years, Tamil Nadu got just one-third of Krishna water

CHENNAI: Tamil Nadu has not received its full share of 12 tmcft of Krishna water from Andhra Pradesh for the past three decades. Despite the neighbouring state's willingness to release water, TN has struggled to release its share due to a lack of storage facilities in and around Chennai, and alleged illegal water tapping from the open canal before it even reaches the state. According to Water Resources Department's (WRD) data accessed by TNIE, since 1996, the total water received (112 Tmcft) by TN is only one-third of its total entitlement (340 Tmcft).Under the inter-state agreement

signed on April 18, 1983, AP has to release 12 Tmcft of water to Tamil Nadu annually, excluding evaporation losses of 3 Tmcft. The agreement stipulates that 8 Tmcft should be released from July to October, and 4 Tmcft from January to April. Krishna water first reached Tamil Nadu at Uthukottai in Tiruvallurdistrict in September 1996.Illegal tapping of water from the opn canal is the main reason for Tamil Nadu unable to realise its share. "Water is released from the Kandaleru dam in Andhra Pradesh through an open canal. Due to illegal tapping, Tamil Nadu faces difficulties in receiving the full

supply. We have informed the Andhra Pradesh government several times, but no action has been taken yet," an official said. The official also mentioned that the state government, under the late CM J Jayalalithaa, had planned to lay pipelines in 2014 to prevent such issues. The project was dropped owing to financial constraints. Stressing on the need to increase storage capacity to meet future water demands, he pointed out that during the North-East monsoon, Chennai's reservoirs often fill up naturally, making it hard to store Krishna water, and gets diverted to the sea.

Asha claimed that her father expressed the desire to have a religious burial. However, Sajeevan maintained that Lawrence wanted his body to be donated to the medical college. The row between siblings over the donation of Lawrence's body had reached the Medical College principal to take a decision after hearing all persons concerned.According to Asha, Prathap kept her in the dark and denied her a

Lambasingi FPO ensures direct market access to tribal farmers

VISAKHAPATNAM: The Lambasingi Tribal Products Farmer Producer Company Limited (LTPFPCL), based at Raj Pakala village in Chintapalle mandal of Alluri Sitarama Raju district, is revolutionising the lives of tribal farmers by enabling them to sell products directly to consumers, bypassing intermediaries. Promoted by the Indian Institute of Millets Research (IIMR) and supported by the National Bank for Agriculture and Rural Development (NABARD), the initiative fosters self-sufficiency and better income for tribal farmers. Under the leadership of ICAR-IIMR Senior Scientist K Srinivasa Babu, the organisation has grown to include over 750 members.Tribal India Chamber of Commerce president Malli Bhaskara Rao has played a pivotal role in extending the reach of the farmers' products to both national and international markets,

eliminating the exploitation by middlemen that previously plagued these farmers. "Earlier, we used to sell our products at very low prices. Now, we are receiving fair prices, and our income has improved," said Pampana Kannababu, a farmer from Pedabarada village. Formed three years ago, LTPFPCL allows farmers to directly market products such as turmeric, coffee, honey, black pepper, millet, and home care items. The Farmers Producers Organisation (FPO) is operated entirely by the tribal community and managed by five directors and five promoters. The Bhagavatula Charitable Trust's Krishi Vigyan Kendra provides training on value addition techniques. Kuda Saroja, a tribal farmer from Siripuram village, highlighted the positive transformation, noting that their products are now reaching international markets. "We no longer depend on middlemen," she

added. The FPO, which has achieved a turnover of more than Rs 1 crore, has secured partnerships with the International Marketing Agency in Bengaluru and MST Exports in Chirala. Discussions with APEDA and NVision are underway to expand into markets in Vitnam, Thailand, Australia, and Europe.haskara Rao said, "I have seen the struggles of tribal people firsthand. There are many government schemes, but due to illiteracy and lack of knowledge, these communities often miss out. My goal, through the Tribal India Chamber of Commerce, is to empower them to become entrepreneurs and reach global markets for long-term stability."Srinivasa Babu stressed the importance of consumer demand in the FPO's success. "Initially, with fewer members, marketing was simple, but with growth, we needed expert help to expand," he said.



People need support to cope with sea erosion: Study

of the Indian coastline vulnerable to erosion, people living in coastal areas must be given the tools and knowledge to cope

with rising sea levels, suggested a study of two researchers from National Institute of Science Education and Research (NISER), Bhubaneswar.In their paper 'Navigating the sea level rise: Exploring the interplay of climate change, sea level rise, and coastal communities in India' published in Environmental Monitoring and Assessment, researchers Ansuman Das and Pranaya Swain of NISER said the coastal population must be involved in the decision-making process, preparation for disasters and creating strategies to adapt to

changes.Citing the 2023 report of the Ministry of Environment, Forest and Climate Change, the researchers said coastal erosion in India due to rising sea levels has resulted in loss of land, affecting

BHUBANESWAR: With over 33 per cent valuable agricultural areas and coastal communities. Around 33.6 per cent of the Indian coastline is vulnerable to erosion, while another 26.9 per cent is under



accretion. Between 1990 and 2016, India lost 235 sq km land to coastal erosion which is alarming. Citing another data, the researchers stated that the highest erosion rate is occurring in coastal areas of West Bengal, affecting 70 per cent of the coastline. It is followed by Kerala coast with 65 per cent erosion, Gujarat (60 per cent) and Odisha (50 per cent)."This loss threatens people's livelihoods and

homes, leading many to relocate voluntarily or in extreme cases, with government intervention. Immediate action is vital to ensure protection of these coastal areas and safety of communities," they said.

The researchers also suggested that India should invest in protecting its coasts by building sea walls, dams and coastal plantation which will help reduce the risks of erosion and flooding, especialy in more vulnerable areas.On sustainable coastal management, the researchers said the country needs to plan how it uses the coastal areas

by balancing development with environment protection. This includes getting input from the people who live there, monitoring how the coast is changing, and ensuring that land use practices are sustainable.

Iran-Israel war takes a dangerous turn

AFTER Israel killed Hezbollah leader Hassan Nasrallah and other leaders in Beirut on September 27, Iran fired around 200 missiles at Israel on October 1 without warning the USA. While most missiles were stopped by US and Israeli defence systems, a few hit Israel's Nevatim air base, damaging about 30 F-35 fighter jets. No one was killed, but a few people had minor injuries. Not to escalate the conflict further, the Biden administration is trying to belittle the success of the Iranian attack, urging Israel to be proportionate in its response. Israel, on the other hand, is angry that Iran had the audacity to lob missiles at its nuclear plant in Dimona (producing nuclear weapons) and three critical air bases. It is mulling a tough response.

Iran's attack came after a series of killings by Israel of the senior leadership of Hezbollah, other cadres in pager explosions, the bombing of Yemeni ports, power plants and Hamas leader Ismail Haniyeh in Tehran in recent months. Iran realised that its lack of response had whetted the Israeli aggressiveness in killing its proxies in Lebanon, Gaza, Yemen and Syria and it had to act

The Iran-Israel war has taken a dangerous turn as the two countries are now readying themselves for a direct fight, which they have avoided in the past. Iran reportedly looted an Israeli oil tanker in the Persian Gulf recently and Israel is contemplating an attack on its oil installations.

Iran has made it known that it does not want to attack Israel any further, but if the latter destroyed its oil facility, it would destroy oil wells of the pro-American Gulf states and US military bases in Middle East.Most US allies want a ceasefire and no further escalation of hostilities. Several Gulf states, including Saudi Arabia, the UAE, Bahrain. Kuwait and Qatar, have declared their neutrality in the war and assured Iran that they would not allow the USA to use military bases on their soil against her.

Israel does not have the capability to take on Iran and its proxies together on its own. Even the attacks on Hezbollah leaders in Lebanon and targets in Yemen and Syria were undertaken mostly by American fighters, with Israeli pilots playing a symbolic role.

The US can't allow Israel to lose and does not want a full-scale regional war at this time when it is readying for the presidential elections next month. Any Israeli loss will affect the support for Democratic candidate Kamala Harris as Republican candidate Donald Trump has promised to solidly rally behind Israel. Also, the US does not want to get involved in a major war in Middle East as it would affect its ability to prepare for a war against China in East Asia.

Israel can't allow Iran to walk away with a victory nor allow its "strategic superiority" against Iran to be weakened as it considers that crucial for the maintenance of peace and stability in the region. Iran has already suffered a huge fall in its prestige and military capabilities with the decimation of the top leadership of its proxies. Israel was keen to destroy Iran's nuclear facility, but that looks difficult as Iran has secured Russia's S-400 air defence system. However, Israel thinks that it has a golden opportunity now to weaken Iran by destroying its proxies and it must not let it go.

Russia is sympathetic to Iran, with the latter having supplied drones and missiles to her, but has its hands full with the Ukraine war. Russia and China will assist Iran to ensure that the USA gets bogged down in West Asia and damage its military capabilities. Russia is considering supplying long-range Onyx anti-ship missiles to Houthi rebels to attack western shipping in the Red Sea.Prime Minister Modi has been in touch with PM Netanyahu and has supported him in taking strong measures against the terrorist groups. But External Affairs Minister Jaishankar has cautioned Israel against taking any actions which could precipitate large-scale casualties, particularly of civilians. India favours a two-state solution to the Palestinian problem, which even the USA and other countries want, but Netanyahu does not favour ceding any land to them.

Looming air pollution crisis beckons urgent attention

Air pollution in north-west India is expected to exacerbate this year. Establishing a centralised body for collaboration and data integration is crucial for sustainable solutions and improved air quality.

AS winter approaches, air pollution is expected to worsen in north-western India, likely arriving earlier and with a stronger impact. This is made worse by bad weather, like low rainfall and weak winds. This situation is similar to the pandemic period when pollution decreased across most of India due to less economic activity, but pollution levels still rose in the north and central-west regions. Investigations spearheaded by the Aryabhatta Research

Institute of Observational Sciences highlighted increased ozone, nitrogen dioxide and carbon monoxide levels in these areas. Notably, when trapped near the earth's surface, these pollutants can exacerbate respiratory conditions. The looming issue of air pollution in nrth-west India can be traced significantly to farm practices, with the burning of crop residue at the forefront. Punjab and Haryana, crucial contributors to India's agricultural output, commonly burn the leftover stubble after paddy harvests. Although it is efficient for farmers to quickly clear their fields for the next crop, this method has severe repercussions on the regional air quality.Crop residue burning releases harmful pollutants into the atmosphere, including particulate matter (PM2.5 and PM10), carbon monoxide, volatile organic compounds and traces of heavy metals. These pollutants contribute to smog formation, degrading visibility and posing serious health risks to millions of residents in the Indo-

Gangetic Plains. The particles can penetrate the lungs, exacerbating respiratory diseases and other conditions. The plains are characterised by their flatness and high population density, which facilitate the trapping of air pollutants. The meteorological conditions prevalent in the winter, such as low wind speeds, temperature inversions and reduced vertical mixing, intensify the problem. Temperature inversion is when a layer of cooler air is trapped near the surface by a layer of warmer air above, effectively acting as a lid that prevents pollutants from dispersing vertically. As wind speeds drop during the colder months, the dispersal of pollutants is further curtailed, allowing them to accumulate in the lower atmosphere. This phenomenon is particularly noticeable in Delhi, which sits close to the source regions and is often blanketed in thick smog during the winter. The city, already grappling with vehicular emissions, industrial pollutants and construction dust, sees a dramatic increase in pollution levels due to these external agricultural activities.

The economic constraints that farmers face play a role in perpetuating this practice. Alternatives to burning, such as mechanical stubble removal and conversion into bioenergy, are either too costly or insufficiently incentivised, leaving many farmers with little choice but to continue with burning. Government initiatives and technological interventions to provide affordable and sustainable alternatives are crucial to mitigating this issue.he interplay between agricultural practices and geographical and meteorological factors creates a challenging environment for controlling air pollution.



Addressing this requires concerted efforts involving policy reforms, technological advancements and community awareness to transition towards more sustainable farm practices while considering the socioeconomic realities of the farmers.


Sophisticated satellite technology has transformed our ability to more precisely understand and analyse air pollution patterns. Researchers can now monitor air pollution with enhanced accuracy and granularity by leveraging data from the NASA and EUMETSAT satellites, complemented by ground-based measurements from instruments like the Compact and Useful PM2.5 Instruments with Gas Sensors (CUPI-Gs). These tools provide a comprehensive overview of the pollution metrics, capturing real-time fluctuations and pinpointing hotspots.In recent studies, extensive data collection efforts have focused on the NCR, where pollution levels have been notably severe. The analyses reveal that a significant portion of the air quality issues in this area originates from agricultural residue burning in the neighbouring states. By integrating satellite observations with local sensor data, scientists have been able to map out pollution sources and trace their contributions to the regional air quality. These advances underscore the critical necessity for monitoring and robust data collection to understand the dynamics of pollution dispersion. Such insights are essential for developing targeted interventions and policy measures. Continued investment in both satellite and ground-based observation technology is crucial for devising effective strategies to mitigate air pollution and protect public

> health in vulnerable regions. Delhi and its vicinity endure severe particulate matter (PM2.5) pollution levels, recording significantly higher metrics than other regions. Data from 2023 highlights that the NCR saw PM2.5 levels frequently surpassing the safe limits, with some measurements peaking at 218.4 µg/m³. This emphasises the influence of crop stubble burning and stagnant weather conditions in escalating the pollution levels.Meanwhile, regions like Bihar and Rajasthan have emerged as unexpected pollution hubs, indicating that smaller cities can rival metropolitan pollution challenges. The findings and patterns emerging from latest air quality studies necessitate a holistic approach to combating air pollution. Various national and

international projects, such as the National Clean Air Programme and the RIHN project, AAKASH, have made strides in mitigating pollution. However, an urgent call remains for immediate, coordinated efforts towards sustainable solutions. Recommendations include stricter enforcement of stubble burning regulations, enhancement of green energy alternatives and increase in public awareness about the health implications of pollution. Establishing a regional air pollution coordination body is vital for addressing air quality challenges. This entity would serve as a centralised authority to synchronise efforts across states, ensuring comprehensive policy implementation and resourcesharing. It should have representatives from government agencies, NGOs, scientists and community leaders. Its functions would include integrating data from various monitoring networks, facilitating cross-border dialogue on pollution sources and developing unified action plans. The body would also oversee public awareness campaigns and provide funds for innovative pollution reduction technologies. By fostering collaboration and accountability, it would be pivotal in improving the regional air quality.

Caste bias in jails

How many more deaths before safety is ensured



The judgment identified practices in prison manuals that mirrored untouchability. For example, in states like Uttar



Pradesh, Tamil Nadu and West Bengal, prison manuals explicitly directed that food be prepared by "suitable

castes" and that certain marginalised groups handle cleaning tasks. The SC rightly condemned these provisions, calling them unconstitutional and a violation of the fundamental rights to equality and dignity. The ruling also condemned the categorisation of denotified tribes as habitual offenders, reinforcing harmful stereotypes that further marginalised these communities. Such practices have long been criticised by human rights organisations for reinforcing caste hierarchies and stripping marginalised prisoners of their dignity.

As states revise their prison manuals within the mandated three months, this judgment represents a crucial shift toward dismantling the oppressive systems that continue to harm the most vulnerable. The decision reminds us that justice and equality must extend to all, including those behind prison walls, bringing India closer to the

constitutional promise of dignity for all its citizens.

When the dice rolls in Haryana

UNDER a hot, afternoon sun on Thursday in Haryana's Shahbad constituency, with mere hours to go before the campaigning for the Assembly polls formally drew to a close, BJP workers seemed somewhat downcast as they emerged from a meeting where Yogi Adityanath had just held forth for 20 minutes. But the applause for the UP chief minister had been weak and scattered, as if the fire in his belly had been missing and the response to it bewildered. Yeh to phir bhi baazi paltega," said one BJP worker, insisting that the party strongman would reverse the throw of the dice, which seemed insensibly stacked against the BJP. That despite the disarray in party ranks, even in this last moment, the party would be able to showcase all its splendid works — the roads, the subsidies, the schemes for men, women and farmers.But, the BJP worker and his friends also conceded that it was not going to be easy. For example, they said, the jealous rival to the official party candidate in Shahbad had openly undermined the latter's candidature. "Woh uske gale main maraa hua saanp daal ke bhag gaya hai," one said. (He has thrown a dead snake around the BJP candidate's neck and fled.) A third man, explaining the lack of a crowd at Yogi's meeting, pointed out that the citizenry were so angry with the outgoing BJP MLA's arrogance that they were determined to punish the current candidate for it.

"Uski gardan mein se sariya nikalna toh hai hi," a fourth man said. We have to remove the iron rod from the neck and spine of the BJP candidate.

If Shahbad is the model, then small wonder that the stakes for Haryana's 90 Assembly seats in Haryana switched on this bright Saturday morning, the equivalent of the fourth battle of Panipat will be joined — this time between the Congress party's Bhupinder Singh Hooda and outgoing chief minister Nayab Singh Saini, an affable enough man who should have replaced his guide and mentor Manohar Lal Khattar much earlier than the six months he was given in March. That's because, for nine-and-a-half years, no one could touch Khattar.

He ruled Haryana with an iron, arrogant hand, ever since PM Narendra Modi first waved the magic wand in 2014, because he and Modi went back a long way. As Modi recounted at a rally earlier this year, back in the 1980s, both he and Khattar often slept on the same durree and rode on the same bike all over Haryana as RSS pracharaks trying to spread the message. The story goes that Saini worked in the BJP office at the time, typing out notes and press releases, and ever since has owed his rise and rise to Khattar. The problem with Haryana is that the echo of history is so loud that it tends to drown the noise of the present. Saini is Khattar's protégé, who, in turn, is close to Modi — all best friends, determined to battle on the same side. And then you hear the dice roll. The sound of the EVMs pinging and the finger being

softly pressed on the button. The people of Haryana have decided. It's no longer about Saini or Khattar or Hooda — or even, Modi.

Then there's Jammu & Kashmir. And Maharashtra, in November. Haryana is no longer just 90 Assembly depending on how you see it, it is either the




How to make Slim Vada Pav

Chef Manu Chandra suggests 17 homegrown ingredients that can up the quotient of any plate

I think as one matures as a chef, intrinsically it becomes easier to look around oneself to be inspired and innovate rather than looking too far. Something similar has been happening with me despite my years working abroad and at some stellar restaurants at that. The depth and variety of what is available in our country is often overlooked by the restauranting ethos and instead most embrace hard-to-find western ingredients in the development of their menus and offerings.

While it would be unfair to say that some chefs haven't already attempted and been trying to champion Indian ingredients, I still feel that we have a very long way to go and being able to develop our brand of adopted cuisines (much like France, America, Australia have done).

Here's a list of 17 of perhaps hundreds of relatively unseen or underestimated ingredients, which I feel would add a lot of spunk to any menu, cuisine notwithstanding. Bon appetite.

1. Bathua: A seemingly wild growing green always found in certain parts of North India. Bathua is a fantastic replacement for spinach, which has always been associated with contamination. It's delicious, earthy and lends itself to many applications.

2. Kachampoli: Almost never heard of outside of Coorg, this is India's answer to Balsamic Vinegar even though it's neither sweet nor made with grapes. Watch it transform a non-vegetarian dish with it's deep dark colour and lip-smacking tang.

3. Singhara: This absolutely delicious water vegetable is barely seen on any menu. Peeled and sliced, it would make the most wonderful salad.

4. Makhana: Lotus seeds that have been dried are an incredible way to thicken sauces and gravies after frying and powdering. It's a great snack too, albeit a little heavy.

5. Bhetki: Despite the battle between the sea fish vs the fresh water fish lovers, the glorious Bhetki stands out as an outstanding fish. Its suppleness is a close second to the phenomenally expensive and imported varieties of bass. I would pass up a John Dory for a good Bhetki any day.

6. Melon seeds: So used are we to seeing pine nuts on menus, that we often forget how delicious roasted melon seeds can be. I've found them equally enticing on pastas, salads and even desserts. A must try.

7. Bhut Jhalokia: Also known as the Naga chili, I find myself reading more about this in foreign media than seeing it in our own restaurants. It's got a kick that will make

8. Gondhoraj lemon: By far one of my favorite citrus flavours, the perfumey fragrance from this north-eastern lemon can convert the simplest dish into a stunner. Infuse it in a little vodka, or try a sorbet with it. A lemon tart with some zest and juice from the gondhoraj can give key lime pies a run for its money.

9. Kalimpong Cheese: Almost Gouda like, this cheese from Sikkim probably has a very small production, but can fool the finest of gourmets. Watch it transform the most humble bake or a simple chili cheese toast, if you can get your hands on it, that is.

10. Rhododendron: Literally the rose tree, these beautiful flowers from the hills of Nainital and around, make for the most amazing drinks and coolers. Instead of lapping up artificial green apple syrups in martinis, it would be fabulous to see bartenders adapt to this refreshingly different ingredient.

11. Kashundhi: Bengali cuisine would be unimaginable Bengali cuisine. Try it in dressings, as a condiment on steaks and fish, or even a sandwich spread and English mustard may not seem so attractive after all.

some great dressings, sautes, marinades etc.

14. Aam Ada: This ginger root which has the most keen palates confused owing to its distinctively green mango flavour can be an amazing addition to soups, broths and relishes. It's again seen in very isolated cuisines, but I'm sure can gain a following as much as lemongrass if marketed well.

15. Indian Vanilla Bean: Many people will be unaware that some excellent Vanilla grows in the hills of Chikmaglur and Coorg and any place with coffee plantations. Substitute the sub par artificial essence with some caviar from a vanilla bean and watch a dessert move a step closer to Nirvana.

16. Golden Apple: As children one almost looked forward to apple season (yes, we ate seasonally as early as 20 years ago) for those incredibly juicy and sweet Golden Apples from Himachal. Today I'm hard pressed to find them. Instead I can easily settle for pretty, waxy and tasteless imported green and red apples. Eat an apple pie made from golden apples, and a whole generation may rethink the apple (edible)

17. Gulkand: A stalwart of the pan shop, gulkand in all its rosy and sweet avatar can be an amazing ingredient. It's mellow yet lucid on the palate. Try it with cheesecake or with nuts and honey on warm almond cookies.

Sleeping labourer attacked in Delhi, concerns over lack of police presence

New Delhi.A labourer sleeping outside a shop in Delhi's Model Town was brutally beaten up by a miscreant on the morning of October 4. The incident, which occurred around 9 am, was captured on CCTV and has since gone viral, raising concerns about the lack of police presence in the area. The video footage shows a man arriving on a motorbike. He dismounts, approaches the labourer sleeping



outside the closed shop, inspects his face, and then begins striking him with a stick. The attack continued for several seconds, while bystanders in a nearby park watched without intervening. The assault only stopped when a car approached the scene, prompting the attacker to flee. The incident took place just steps away from a police booth, yet the miscreant carried out the attack without any fear of police intervention. The absence of prompt action from the authorities has led to public outrage.

Despite orders from senior officials for officers to patrol the area on foot, such violent incidents continue to occur, raising serious concerns about the effectiveness of local police.

Probe agency arrests jaish operative in conspiracy case

NEW DELHI. The National Investigation Agency (NIA) has arrested Pakistan-based terror group Jaish-e-Mohammed (JeM) operative, Sheikh Sultan Salah Uddin Ayubi, also known as Ayubi, in a major conspiracy case. This arrest marks a significant breakthrough in the ongoing JeM investigation. The NIA conducted extensive searches across 26 locations in five states-Assam, Maharashtra, Uttar Pradesh, Delhi, and Jammu & Kashmir. The raids targeted



areas in Goalpara (Assam), Aurangabad, Jalna, Malegaon (Maharashtra), Meerut, Saharanpur (UP), Baramulla, Pulwama, Ramban (J&K), and Delhi.During the searches, investigators seized incriminating documents, electronic devices, pamphlets, and magazines. The suspects were found to be involved in radicalising individuals, spreading JeM propaganda, and recruiting young people for violent terror activities.

The investigation revealed plans to carry out terror attacks across India. Further investigations are underway. Earlier in July, the Jammu and Kashmir Police arrested two overground workers of JeM. According to the details, the two were arrested from Kathua in the Union Territory. Police said the arrested accused were linked to the terror attack on Indian Army vehicles in Kathua on July 8, which claimed the lives of five soldiers and injured five

fear across the area, attacking villagers and livestock. This particular wolf, the last of the pack, had evaded capture for over 24 days despite the forest department's continuous efforts.On September 10,



The death of the sixth wolf has finally brought relief to the villagers, who had been living in constant fear. The pack had killed nine children and one woman, leaving more than 50 people

New Delhi.The months-long reign of forest officials had successfully Ajit Singh, the Divisional Forest Officer (DFO) of Bahraich, stated that

they were alerted to the incident at around 8.30 pm on Saturday. By the time they reached the site, both the goat and the wolf lay dead.According to Singh, the sixth wolf cannot be confirmed as man-eating, as no attacks had occurred after the capture of the fifth wolf. However, it is believed to be a member of the same group that had terrorised the region. The forest department is conducting a thorough investigation and

plans to file an FIR related to the incident. Though the sixth wolf was likely separated from its pack after the capture of the others, its death marks the end of the wolves' threat in the

Cocaine worth Rs 10 crore seized in Amritsar linked to Delhi drug bust

New Delhi. The Delhi Police team probing the Rs 5,000-crore drug haul has seized cocaine worth Rs 10 crore from Amritsar, Punjab, after a raid, officials said on Sunday. The raid was based on information received from Jitendra Pal Singh, a UK resident arrested in Amritsar on October 4 in connection with the Delhi drug bust, according to sources.A Toyota Fortuner car was also seized during the raid, which was conducted in a village near Amritsar, close to the Nepal border.

On October 2, the Delhi Police made one of the biggest drug busts ever seen in the city, seizing over 560 kilograms of cocaine and 40 kilograms of hydroponic marijuana, estimated to be worth around Rs 5,620 crore, from Mahipalpur in South Delhi.The marijuana is suspected to have originated from Phuket, Thailand, and was brought to India via the air route. The cocaine is believed to have been sourced from West Asian countries and various Indian states. Officials added that the accused mostly paid in cryptocurrency to acquire the drugs and later sold them. Five people--Tushar Goyal (40), Jitendra Pal Singh, alias Jassi (40), Himanshu Kumar (27), Aurangzeb Siddiqui (23), and Bharat Kumar Jain (48)--were arrested, with Goyal identified as the

The investigation revealed that the gang was planning to sell large quantities of drugs at concerts, rave parties, and upscale localities in Delhi and other metropolitan cities. Goval was found to have international links. Goyal's connection with the Congress party has sparked a major political row, with BJP leaders, including Prime Minister Narendra Modi and Union Home Minister Amit Shah, criticising the opposition party. The mastermind's purported Facebook account features a profile picture with a tiger, and his bio mentions that he is the "Chairman of Delhi Pradesh RTI Cell of DYPC, Indian Youth Congress." NEW DELHI: In a step towards connecting Delhi to India's first Regional Rapid Transit System (RRTS), NCRTC commenced trial runs on the Sahibabad-New Ashok Nagar section of the Delhi-Ghaziabad-Meerut RRTS corridor on Saturday. This marked a milestone, as the Namo Bharat train service is now entering Delhi, linking the corridor's city section to the already operational section from Sahibabad to Meerut South.

NCRTC MD, Shalabh Goel was present on the occasion with senior officers to witness this moment. The train was



operated manually to check the civil structure compatibility in the trials.As testing advances, NCRTC will carry out comprehensive evaluations to assess the train's integrated performance and its coordination with various subsystems such as tracks, signalling, Platform Screen Doors (PSDs), and overhead power supply systems. Extensive trial runs, including high-speed tests, are planned over the next few months. This

12 km stretch of the corridor is going to connect Sahibabad RRTS station in Uttar Pradesh to New Ashok Nagar and Anand Vihar stations in Delhi. Once operational, it will offer commuters a fast and efficient travel option between New Ashok Nagar and Meerut, reducing the travel time to less than 40 minutes.

Anand Vihar RRTS station is expected to become one of the busiest commuter transit hubs, with significant daily footfall due to its proximity to the Anand Vihar Metro Station, which serves two Metro lines, a railway station, and two ISBTs one on the Delhi side and the other at Kaushambi, Uttar Pradesh. The NCRTC ensures the seamless integration of these various transit modes to provide commuters with effortless convenience and accessibility, making Anand Vihar RRTS station a odel for multi-modal integration.

The New Ashok Nagar RRTS station is located less than 100 meters from the New Ashok Nagar Metro Station. To integrate these two transport modes, the NCRTC will provide a footbridge (FOB) connecting the concourse level of the Metro station to the concourse of the RRTS station.

Additionally, two more FOBs will enhance accessibility at the New Ashok Nagar RRTS station: one will connect Chilla Village and Mayur Vihar Extension, while the other will be located near the Ancient Shiv Temple, facilitating easy access for New Ashok Nagar residents. Household debt up 26 per cent CAGR since '20

NEW DELHI. Financial liabilities/indebtedness of the households, which nearly doubled to 5.6 per cent of GDP in FY23, have grown at a compounded annual growth rate of 26 per cent between FY20 and FY23 as against 17 per cent in the pre-pandemic decade, while their savings grew at a much lower 9 per cent, down from 11 per cent, shows an analysis.

Households' share of savings in physical assets rose to 54 per cent in FY23 from 50 per cent pre-pandemic, while per cent in FY23 from 50 per cent pre-pandemic, while the share of savings in the form of precious metals remained relatively stable and minimal at 0.2 per cent of GDP.Major rise in financial liabilities was primarily driven by personal loans, particularly housing and unsecured loans. Personal loans from scheduled commercial banks grew at an annualised rise of 18.2 per cent since FY20, up 15.1 per cent in the pre-pandemic decade, as per a Care Ratings' weekend analysis.

While gross financial savings peaked at 15.4 per cent in FY21 due to the pandemic, net household financial savings have been on a southward-ho mainly due to a rise in financial liabilities.

Abhinandan Lodha floats 'plots-only' realty model

NEW DELHI. In the old days, especially in the smaller cities and towns, a 'developer' meant the chap who had the pluck to convert some agricultural land to 'residential use'. He would then divide it up, provide water and electricity connections and sell plots to families to build their own houses.

What came up was a bit of a mess, but that's how residential communities flourished. Over time, the definition of a 'developer' changed. By building row houses, or flats in multistorey buildings, the 'developer' added more value and increased his profit margin. For a buyer, it was a neater home without the hassle of putting brick and mortar together.

Now meet someone who has gone on reverse gear, moving from developing buildings and flats to selling plots in residential layouts. Abhinandan Lodha, a young 42-year old entrepreneur, son of the famous builder-politician Mangal Prabhat Lodha, has extricated himself from the shadows of his father and brother, Abhisheck Lodha, to build scale with 'plots-only' realty projects. Family break-up

I first met the young Abhinandan over a decade ago, when the Lodha Group had acquired Mumbai's Shrinivas Mills and

had launched the now famous 'World One' tower in Parel. It was a chance meeting at the office of a senior HDFC Realty officer. The Lodha scion was then negotiating a crucial Rs 500 crore loan for the Shrinivas project.

'We couldn't go ahead without the HDFC loan. Though it was sanctioned by the realty team, HDFC chairman Deepak Parekh said 'no'. It was the post-Lehman Brothers period of tight finance, and though I tried my best, Deepak Parekh refused," recounted Abhinandan in a recent

interview.For three days the young realtor sat outside Mr Parekh's Churchgate office. Abhinandan Lodha recounted his experience: "By the second day, the chairman asked me: You are still here? I said – Yes! Where will I go? I need the loan, sir. Deepak Parekh nodded and went inside his office, but then again found me where he left me when he was leaving in the evening. This went on. By the end of the third day, the chairman relented. He called his team and told them to draw up the papers!"In the early days when the Lodha Group, later rechristened Macrotech Developers, grew at a heady



pace, the younger Lodha remained in the background leaving his brother Abhisheck to be the front face of the company. However, he cut his teeth early negotiating a record FDI deal of USD 410 million with Deutsche Bank when he was just 25. A few years later he drove the Rs 5,700-core land purchase of the Wadala container terminal that today is a sprawling 30-acre gated community called 'New Cuffe Parade'.In-charge of sales, marketing and finance, Abhinandan seemed to be doing well. So why did he split from the family company? "I did not want to be someone's shadow," he said. To the question, whether father Mangal

Prabhat Lodha mediated to set things right with his brother Abhisheck, Abhinandan was diffident. He said the father was occupied with politics as an MLA and a major BJP functionary, and chose to stay away from the snarl. Was the separation bitter? "Let's say the separation was non-consensual; but it is not litigative either," responded Abhinandan.

New realty model

It was quite a struggle differentiating himself from the Lodha group and starting from scratch. He used the rather pompous title 'House of Abhinandan Lodha' or HoABL. He initially set up Lodha Ventures to incubate creative tech start-ups and also launched a private equity firm 'Capital Tomorrow'. But after all his first calling was that of a realtor. It all started with a fluke joint venture with his legal attorney, Bergis Desai, a senior partner in the solicitors firm, J Sagar Associates. A 100-acre property in Dapoli, in Maharashtra's coastal Konkan belt was acquired and developed in 2021 as a getaway resort called 'Isle of Bliss'. "With focused marketing, the majority of the plots – ranging from 450 to 20,000 sq ft – were picked up in 3 weeks.

How will China stimulus impact India

NEW DELHI. China's effort to revive its economy via a financial and monetary stimulus package is perceived to have a strong impact on India - positive as well as negative. While the initial impact is being felt on Dalal Street as the foreign institutional investors (FIIs) are seen "selling India and buying China", the success of the package might prove to be beneficial for India. Experts feel it may result in flight of higher foreign funds to India via emerging market route, negligible impact on "China + 1" and control of excessive dumping

of finished Chinese products.

The package is a bold set of interventions by the government. It will allay fears among foreign investors who were becoming sceptical about the Chinese government's ability to make big-bang reforms. The last time they conducted major reforms was in 2008, which ushered China into to a new league of development backed by large foreign investor participation, said Debopam Chaudhuri, chief economist of Piramal Group."I expect the Chinese investment instruments will gradually start to gain some of their lost sheen, starting with its equities followed by real estate," Chaudhuri added. As per him, this is piece of good news for India as well. "China serves as a lighthouse to foreign investors searching for emerging market (EM) opportunities. Reduction in uncertainties within China will attract higher capital allocation to EMs, and

India with its growth potential can attract a large share of that pie.

While India may attract higher funds via the EM basket in future, so far the local market, which saw its biggest weekly slump this week in more than two years, has seen an exodus of FIIs. This week alone, FIIs sold shares worth Rs 40,000 crore in the Indian market as they find the valuation of Chinese stock much more attractive. V K Vijayakumar, chief investment strategist, Geojit Financial Services, on Saturday said geopolitical

tensions in the Middle-East have become a worry for global equity markets. But the markets have, so far, shrugged off these tensions. The US market is resilient with 21 per cent returns year to date.

Even as crude has risen in recent days, there is no sharp spike so far. The situation will change if Israel attacks oil installations in Iran, he added."FIIs turned sellers in the Indian market in October...The selling has been triggered by outperformance of Chinese stocks. Hang Seng index shot up by 26% in last one month and this bullishness is expected to continue since valuations of Chinese stocks are very low and the Chinese

economy is expected to do well in response to the monetary and fiscal stimulus," Vijayakumar said."If the momentum in Chinese stocks continues, FIIs may continue to sell in India where valuations are elevated. It remains to be seen how long the optimism lasts. FII selling in financials, especially frontline banking stocks have made their valuations attractive. Long-term domestic investors may utilise this opportunity to buy banking

SBI declares MTNL loan as NPA due to payment default

NEW DELHI. The State Bank of India (SBI) has declared loans given to state-owned Mahanagar Telecom Nigam Limited (MTNL) as a sub-standard non-performing asset (NPA) due to default in re-payment.

According to a letter from SBI, MTNL's total outstanding loan balance was at Rs 325.52 crore as of September 30, with Rs 281.62 crore overdue, requiring immediate payment to regularise the account. SBI emphasised that failure to settle the overdue amount will lead to a penal interest rate on the outstanding

Your attention is also drawn to the term that in case the overdue(s) are not so liquidated, a penal rate of interest is chargeable on such outstanding," reads the letter.

This is not the first time MTNL has encountered issues with loan payments. Punjab National Bank downgraded the company to NPA in September, and both Union Bank of India and Bank of India have also classified MTNL loans as NPA. Union Bank of India has frozen all MTNL's accounts due to non-payment of dues. Currently, as of August 30, 2024, MTNL's total reported debt stands at Rs 31,944.51 crore. Earlier in August, MTNL informed the stock exchanges that it had defaulted on bank loan payments amounting to Rs 422.05 crore.

This included Rs 155.76 crore owed to Union Bank of India, Rs 40.33 crore to Bank of India, Rs 40.01 crore to Punjab & Sind Bank, Rs 41.54 crore to Punjab National Bank, and Rs 4.04 crore to UCO Bank.Meanwhile, MTNL has requested Rs 1,151.65 crore from the government to cover interest arising from sovereign guarantee bonds in the current fiscal year. In the budget, the finance ministry allocated Rs 3,668.97 crore for the payment of the principal amount of MTNL bonds. SBI has also sought details regarding MTNL's land monetisation plan and whether proceeds from such monetisation can be used to settle the dues. In its letter, State Bank noted that MTNL has signed a Memorandum of Understanding (MoU) with NBCC to jointly develop a 13.88 acre land parcel on Pankha Road, New Delhi, and requested information about the MoU and whether the proceeds from the project will be utilized to clear outstanding debts.

New Delhi Imagine a rivalry so intense that it not only tore apart a family but also divided an entire town, creating two iconic sports brands that are loved by many across the globe. In the quiet Bavarian town of Herzogenaurach, Germany, an unassuming laundry room became the birthplace of two of the world's most iconic sports brands: Adidas and Puma. Two brothers went from sharing childhood dreams to sparking one of the greatest corporate wars of all time. If you've ever sported Adidas or Puma, you've unknowingly taken a side in this bitter feud.Let's go through the story of how a feud between brothers sparked a corporate war that shaped the modern sports industry and left a lasting impact on a community.

Humble beginnings to Olympic glory The Dassler brothers were born into modest beginnings. Adolf, known as Adi,

Rudolf followed two years later, in 1898. Raised in Herzogenaurach, a small town of cobblers, the brothers grew up surrounded by shoe-making, a trade their father practised in a local factory. After World War I, the two brothers returned home with a desire to create a business. In

was born in 1900, and his older brother

1924, they established the Dassler Brothers Shoe Factory, making shoes for athletes.Adi, the more introverted of the two, was obsessed with functionality and design. His focus was on creating shoes that improved athletic performance. Rudolf, on the other hand, was outgoing and business-savvy, handling the sales and marketing side of the business. Their complementary skills helped the factory thrive, with one of their shoes gaining international attention at the 1936 Berlin Olympics, when American sprinter Jesse Owens won four gold medals wearing Dassler shoes. The success brought the Dassler brothers' company into the international spotlight, but while their brand was growing, so was the tension between the

The Breakup: Rift turns into a feud

The fissures in the Dassler relationship started during World War II. There are several stories about what caused the ultimate rift between Adi and Rudolf, but one of the most famous revolves around a misunderstanding during an air raid.

As the two families took shelter, Adi allegedly muttered, "Here come the bastards again," referring to Allied



bombers. Rudolf, however, believed the comment was directed at him and his family, sparking animosity that never truly dissipated. The brothers' differences extended beyond personal slights. Their contrasting personalities—Adi's focus on innovation and Rudolf's emphasis on bold marketing—led to disagreements about the direction of the company. Postwar tensions and personal grievances eventually boiled over, and in 1948, the brothers decided to split the company, marking the end of their partnership. Adi, remaining at the original factory, rebranded his company as Adidas, a combination of his nickname and surname. Thus began one of the most famous business rivalries in history.

Rudolf moved to the other side of the Aurach River, and established his own

shoe company, which he initially named Ruda before naming it Puma. Adidas vs Puma

The Dassler brothers' feud went beyond family—it created a competitive fire that would drive both companies to global prominence. Herzogenaurach became a divided town, with residents aligning themselves either with Adidas or Puma.

The division was so entrenched that the town earned the nickname 'the town of bent necks', because locals would glance down at someone's shoes to see whether they were from Adidas or Puma, effectively determining their loyalty.

The rivalry also spilled into local businesses, with restaurants, shops, and even schools taking sides. Families were torn apart as employees of Adidas wouldn't associate with those working for Puma, and vice versa. The Dasslers feud turned what was once a close-knit community into a town of stark divisions. From a business perspective, the competition spurred both companies to innovate rapidly. Adidas revolutionised football with the introduction of screw-in studs on its boots, a game-changing development for players.

New Delhi. England captain Ben Stokes explained the reason behind skipping the first Test against Pakistan in Multan. England begin their 3-match Test series on Monday, October 7, where they will not have the services of their talismanic all-rounder.

Speaking to Sky Sports, Stokes explained that he opted out of the first Test keeping the big picture in mind. Stokes suffered an injury during the men's Hundred competition in August and has been out of action since. Stokes missed the three-match home series against Sri Lanka in August-September 2024 and is now set to miss the first Test vs Pakistan as well."I tried my hardest to get myself fit for this first game, but I've taken the call to miss this one," he said in an interview with Sky Sports. "I've not quite managed to get gameready. There is a lot that has to go into my rehab program. We got to a certain point, but looking at the bigger picture and physically where I'm at, I'm not quite ready to play," he added.Despite travelling with the squad and participating in training sessions, Stokes has been careful with both bat and ball, raising



doubts about his fitness level. Last week Stokes hinted that he might not be able to bowl at the beginning of the series. Though there was optimism about his participation, it became evident that he hadn't yet reached full match fitness, prompting the decision to rest him for the first Test. Stokes originally injured his hamstring on August 11 while playing in
