CVoter projected the BJP was expected to get 27-32 seats out of 43 in the Jammu region while NC-Congress 11-15, Peoples Democratic Party (PDP) 0-2, others 0-1.

IAF seeks loitering UAV system to protect vital installations from attacks by long range swarm drones

Chandigarh, Oct 8: With drones playing an increasingly dominate role in warfare, the Indian Air Force (IAF) has asked



the industry to develop a multi-domain aerial system that can loiter overhead a sensitive installation and protect it against an attack by hostile swarm drones. Swarm drones are unmanned aerial vehicles designed to operate together as a single group controlled remotely or pre-pro-

grammed to operate autonomously to carry out surveillance of attack missions. There can be any number of drones in a

swarm and these are considered to be force multipliers. In the second edition of Acing Development of Innovative Technologies with Innovations for Defence Excellence (iDEX), released by defence minister Rajnath Singh on October 7, the IAF has listed out its requirements for a counter swarm drone system that can be carried and launched through multiple domains, such as individuals, vehicles, tubes, aerostats or balloons. Pointing out that long range swarm drones are a threat to vital installations and the intercep-

tion of these drones will require large infrastructure and high per weapon cost, the document adds that swarm drones carry distributed intelligence with some drones programmed for communication, warhead, dummy, navigation systems, etc.

New Delhi, Oct 8: President Droupadi Murmu on Tuesday presented veteran star Mithun Chakraborty the prestigious Dadasaheb Phalke Award and honoured other winners of the 70th National Film Awards, including music composer AR Rahman, actors Rishab Shetty, Nithya Menen and Manasi Parekh. 
Haryana result raises serious questions about integrity of democratic process: Jairam Ramesh

New Delhi, Oct 8: Alleging a conspiracy, the Congress on Tuesday said it would not accept the Haryana Assembly poll result as it raises "serious questions" about the integrity of the instruments of the democratic system. Congress general secretary Jairam Ramesh said the Haryana result is a victory of manipulations, and subverting the will of people. He also alleged that it is a defeat of the transparent and democratic processes. Ramesh claimed there were "serious issues" with the counting process and the functioning of the electronic voting machines (EVMs) in 14 constituencies and that the Congress would take up the matter with the Election Commission soon. "Results in Haryana are totally unexpected

and surprising. They go against ground reality and the sentiment of the people which was for change," Ramesh said at a press conference with Congress's media and publicity



department head Pawan Khera. "Under these circumstances, it is not possible for us to accept these results (in Haryana)....there are serious

issues raised by our candidates which we will raise with the EC," Ramesh said. "Victory has been snatched from us in Haryana....the results are against the sentiment of

the people which was for change. The Congress has been made to lose in Haryana and the chapter is not closed," Ramesh said. On the Jammu and Kashmir results, Ramesh said the people had defeated the "mischievous designs" of the BJP to muster a majority somehow. "People have given a befitting reply to those who trampled upon J-K's respect by taking away its

statehood. The NC-Congress government will make all efforts for the restoration of J-K's statehood," Ramesh said.

Don't panic, there's no hurry to get e-khata

BENGALURU. There is no deadline for property owners in Bruhat Bengaluru Mahanagara Palike (BBMP) limits to register for e-khatha, clarified Revenue Minister Krishna Byregowda, adding that there is no need for the public to panic, as helpdesks are being set up at Bengaluru One centres across the city.

- After a meeting with BBMP officials on Monday, and discussing the prevailing confusion regarding e-khatha, the minister said, "In some areas, middlemen have created confusion and extorted people by claiming the government has set a time limit to get e-khathas. However, the government has not fixed any time-frame. The public can get e-khatha without panicking and hurrying. Don't listen to speculation and get worried.
- He added that the e-khatha system has been implemented to prevent fake registration. "E-khatha is mandatory only in cases where properties are sold or purchased. Also, on the instructions of Deputy Chief Minister and Bengaluru Development Minister DK Shivakumar, discussions were held with the special commissioner of the corporation on appropriate steps to simplify the process, he informed. He added that there is no need for the public to visit offices to get the e-khatha. Instead, they can download the e-khatha from home, he said.

'Bengaluru has 21 lakh plots. BBMP has already uploaded details of these locations on its website. Property owners can get a permanent e-khatha from home without going to any office by looking at the dropdown menu and attaching the necessary documents on the website," he said. "Help desks have been opened in all Assistant Revenue Officer (ARO Office) offices under BBMP with immediate effect so that property owners can easily get e-khathas without any confusion.

BJP trying to usurp credit for Naveen's projects: Rohit Pujari

BHUBANESWAR. The BJD on Monday came down heavily on the BJP government for trying to take credit for the projects completed during the tenure of Naveen Patnaik, by affixing posters and banners of Chief Minister Mohan Charan Majhi.Former minister Rohit Pujari alleged posters with photograph of the CM have suddenly come up in front of the Samaleswari temple in Sambalpur. Similar posters and banners have been affixed at many places between Nelson Mandela and Chaurpur squares claiming credit for the bridge over Mahanadi at Chaurpur.Pujari said renovation of Samaleswari temple was completed when Naveen Patnaik was the CM. The Chaurpur bridge was also completed by the BJD government. "It seems to have become a pattern for the BJP government to claim credit for the work completed by Naveen Patnaik," he said.

63 houses to get Rs 10k each after flooding

BENGALURU. BBMP Chief Commissioner Tushar Girinath informed that the heavy rain on Saturday and Sunday flooded 63 houses in Mahalakshmi Layout apart from the Kendriya Vihar apartment complex in Yelahanka zone. As more damages have been reported at Mahalakshmi Layout, the zonal commissioner has been instructed to pay compensation to the affected houses.

Speaking to reporters on Monday, the Palike chief also mentioned that nearly 800 potholes have appeared in the city following the rain, and the BBMP will fix them soon.

Though Mahadevapura and Bommanahalli zones recorded low rainfall, they faced serious traffic issues. In Hampi Nagar in West zone, 108. 2 mm of rainfall was recorded in 2.5 hours on Saturday evening. Similarly, surrounding areas like Nandini Layout, Yelahanka and others recorded heavy rainfall, he said. "The apartment complex at

Kendriya Vihar came up outside



the Yelahanka lake bund. The wall that protected the complex from flooding collapsed and hence it was flooded. We have deployed West zone, heavy rainfall for an hour flooded 63 homes in

We cannot say if there is any encroachment in the area. In the past, the place was shown as an irrigation canal and did not have much width. And slowly houses started to come up. It was outside the planning area earlier and was added only recently. There will always be problems, but we will try to solve them. We will see if we have to make another canal,' Girinath said.

Palike is giving Rs 10,000 for each house under the direct benefit transfer from its fund. He also mentioned that during his night rounds during the rain, he found water stagnation at Hebbal service road only.

Acharya trying to safeguard his position in BJD, says BJP

BHUBANESWAR . Stung by the statement of BJD's deputy leader in the Assembly and former minister Prasanna Acharya that four persons are running the government in the state, the BJP on Monday said the leader of the regional party is yet to digest its defeat in the elections.Former president of state BJP Samir Mohanty told reporters here that the BJD is yet to accept the verdict of people. "Acharya seems to have forgotten that the BJD was not very keen to give him a ticket to contest the last election. I think his statement on the BJP government is to keep his party leader Naveen Patnaik in good humour and an attempt to safeguard his position within BJD," Mohanty said. The BJP leader further said, "It does not sound good when Acharya said the BJD government was run by Naveen and he was the only decision-making authority. People of the state knew well who was controlling the BJD and the government. He is well aware about the condition of previous BJD ministers, MLAs and leaders in the party."On Acharya's claim about the undiminished popularity of Naveen, Mohanty questioned, "Why did the former chief minister lose Kantabanji seat to the BJP candidate by a margin of 16,344 votes, if he is so popular?"He said Naveen lost the trust of the people for cheating them over the years. People voted BJD out of power as it failed to keep its promises in the last 24 years. "The BJD's internal conflicts are quite evident after it lost the election. Leaders of the party should introspect before making statements. As the BJP government has fulfilled its promises within 100 days of coming to power, the concerns of BJD leaders to the growing popularity of BJP are natural," Mohanty added.

Guidelines out for selection of PS & OSD to ministers

transparency in selection of officers attached to ministers and ensure their integrity, the state government on Monday issued guidelines for appointment of private secretary and officer on special duty (OSD) for them.

The guidelines assume importance as there was no clarity on appointment of private secretaries and OSDs during the previous regime. The BJP government, however, has sought to streamline

the process, and focus on performance of the officers who are required to play vital role in ensuring effective functioning of the ministers. The guidelines have accorded top priority to clean career record and honesty of the officer concerned. As per the norms, while processing appointments of officials



as private secretary or OSD, it should be ensured that no disciplinary proceeding is pending against him or her.

Besides, no Vigilance or criminal proceedings should have been registered and pending against the officer nor adverse remarks have been recorded in the

confidential character roll (CCR) and performance appraisal report. The guidelines stipulate that he/she must have been rated "very good" or "outstanding" for at least 36 of the preceding 60 months of CCR/PAR. However, any rating recorded as NRC (no remarks certificate) within the past 60month assessment period, will be excluded from consideration.

For periods, where an NRC rating has been recorded, the individual's performance evaluation from the

immediately preceding period (prior to the 60-month window) will be considered for assessment purposes, it added. Appointment to the post of PS to ministers will have to be made from among the officers in the rank of additional secretary

Won't tolerate derogatory remarks against any religion; can't allow violence too: Yogi

Lucknow: Days after controversial statements were made by Dasna temple chief priest Yati Narsinghanand. chief minister Yogi Adityanath on Monday said the govt would not tolerate any derogatory remarks against deities, revered figures, or saints of any caste, religion, or sect. However, he also warned that any protests against such remarks that may lead to anarchy, violence, or any kind of disruption would not be tolerated either. Reviewing the law and order situation in the state ahead of the festival season, the CM said there was a need to respect the beliefs of all sects and that action should be taken against anyone who showed disrespect to any faith.Without naming anyone or referring to any particular incident, Yogi said: "Every citizen should have a sense of gratitude towards great figures, but nobody can be forced to follow this nor should this be imposed on anyone. Anyone who tampers with faith or makes derogatory remarks against great men, deities, or sects will be dealt with strictly under the law and punished. People of all religions and sects must show mutual respect for each other's faiths." chief secretary, DGP, additional chief secretary home and other senior officials were present in the meeting that was held at the CM's residence in Lucknow.He also outlined that govt would not tolerate anarchy, vandalism, or arson in the name of protests, issuing a warning that anyone attempting such actions would face consequences. Overwhelmed to get a flat in which I invested life's savings'

Noida. After waiting for years, even a decade, 51 buyers of Amrapali Dream Valley Enchante in Greater Noida West finally received the keys to their apartments on Sunday. The National Buildings Construction Corporation (NBCC) began the handover process, four years after it was given charge of completing the stalled project. The remaining 800 homebuyers of this Amrapali project are likely to be handed over possession of their flats soon.

Shailendra Bhadauri (56), a single parent, had booked his 2BHK flat in 2013 for Rs 38 lakh. He took a loan of Rs 12 lakh to pay for it and currently gives Rs 18,000 as monthly installment to the bank. Employed in the public sector, Bhadauri fortunately has a govt accommodation in Delhi but would need to vacate it when he retires in three years. On Monday, the 56year-old said he was "overwhelmed" that he would finally get the flat he had invested in."Purchasing this flat took nearly all of my life savings and I still continue to pay loan installments for it. As an Amrapali buyer, I also found it difficult to get a loan because banks demanded an official letter from a court

Run-up to 50: Elevated roads to skywalk, infra to get push

Noida. Several infrastructure and beautification projects across the city are set to be expedited in the run-up to Noida turning 50 in 2026. At a press conference on Monday, Noida CEO Lokesh M told said projects to be fast-tracked include the Bhangel Elevated Road, Chilla Elevated Road, Golf Course in Sector 151A, and a Skywalk connecting sectors 51 and 52 metro stations.

Work on the much-awaited 5.3km six-lane Chilla Elevated Road project is set to begin in a month, with an updated cost of Rs 787.31 crore, the CEO said. The Authority and UP govt are sharing the project cost equally. The CEO also said that 70% of the work on the 420-metre Skywalk, which will connect the Aqua Line's Sector 51 station to the Blue Line's Sector 52 station has been completed. Initiated in Jan 2023 at a cost of Rs 25 crore, the Skywalk project aims to be completed by Dec 2024. At the conference, the Noida CEO also addressed the frequent traffic congestion from Film City Loop to Mahamaya Flyover, noting that an additional lane will be added to the loop soon.Meanwhile, plans are in motion to rent out the upper floors of the multi-storey City Bus terminal building in Sector 82 for commercial use, possibly as a hospital or hotel. The ground floor of the building, which was developed at a cost of Rs 157.9 crore, will continue to function as a terminal.

The CEO also gave updates on the Golf Course project in Sector 151A, which spans 113.9 acres and has a projected cost of Rs 140 crore. Work on the project began in July 2021, but faced delays due to funds. The Authority has since decided to finance the project from its own funds, with 64% of the work completed and a target completion date of June 2025. Work on the Authority's new office in Sector 96, encompassing 5.9 acres, is 73% complete and projected to be ready by Jan 2025 at a cost of Rs 304 crore. The 4.5km six-lane Bhangel Elevated Road, being built at a cost of Rs 608 crore, is 84% complete and is expected to be ready by Jan as well.Plans are also underway to develop two underpasses on the Noida Expressway. The first underpass, to be built at a cost of Rs 131 crore, will be 800m long and benefit residents of sectors 151, 153, 154, and 156. Its construction will commence in Dec this year. The second underpass, with a cost of Rs 106 crore, will be 731m long and ease commutes for residents of sectors 104, 105, 106, 107, 128, and 129.All these endeavours aim to enhance Noida's infrastructure and its aesthetic appeal as it approaches its 50th anniversary.

Upset at not being allowed to marry boyfriend, Pak girl poisons 13 family members

- Karachi. A girl was arrested on Sunday in Pakistan's Sindh province after 13 members of her family died due to the mixing of poison in their food as they were not ready to let her marry according to her choice, police said.
- The deaths took place on August 19 in Haibat Khan Brohi village near Khairpur.
- The girl got angry after her family did not allow her to marry the boy of her choice. She then conspired with her boyfriend to poison the family members, including her parents."All of the 13 members fell ill after having their food and were rushed to a hospital where all of them died. When the post-mortem was done it emerged that these people had died from poisonous food," senior police officer Inayat Shah said from Khairpur.
- He said when the police conducted a thorough investigation it was found out that the daughter and her boyfriend had put poison in the wheat used to make rotis in the house.
- Following the discovery, the police arrested her on Sunday."She was angry because, despite her efforts, her family was not ready to let her marry the boy of her choice," Shah said."The girl confessed to mixing poison in the wheat with the help of her boyfriend," he added.

Nobel Prize in medicine honors 2 scientists for their discovery of microRNA

- STOCKHOLM.Two scientists won the Nobel Prize in physiology or medicine on Monday for their discovery of microRNA, tiny bits of genetic material that serve as on and off switches inside cells that help control what the cells do and when they do it.
- If scientists can better understand how they work and how to manipulate them, it could one day lead to powerful treatments for diseases like cancer. The work by Americans Victor Ambros and Gary Ruvkun is "proving to be fundamentally important for how organisms develop and function," according to a panel that awarded the prize in Stockholm.Ambros and Ruvkun were initially interested in genes that control the timing of different genetic developments, ensuring that cell types develop at the right time. Their discovery ultimately "revealed a new dimension to gene regulation, essential for all complex life forms," the panel said. What is the Nobel Prize for?
- RNA is best known for carrying instructions for how to make proteins from DNA in the nucleus of the cell to tiny cellular factories that actually build the proteins. MicroRNA does not make proteins, but helps to control what cells are doing, including switching on

Lore Segal, esteemed Austrian American writer who fled the Nazis as a child, dies at

whose gift for words helped her family escape from the Nazis and who later drew upon her experiences as a Jewish refugee and immigrant for such fiction as "Other People's Houses" and "Her First American," died Monday at 96.Segal, a longtime resident of Manhattan's Upper West Side, died in her apartment after a brief illness, her publisher Melville House said in a statement. After settling in the US in 1951, Segal wrote novels, short stories, essays and children's books and translated the Bible and Grimms' fairy tales, which featured illustrations by her friend Maurice Sendak. Her life filtered through memory and imagination was her greatest muse. "Other People's Houses," released in 1964 and originally serialized in the New Yorker, closely followed her childhood in Austria, her years in foster care in London during World War II and her arrival in New York, where the growing familiarity with the city's sights and sounds — "charged thus upon the air" makes the "alien into a citizen."

NEW YORK. Lore Segal, an esteemed "Her First American" continued her early viennese American author and translator "experiences in the US, while "Lucinella" was a comic novella inspired by her time in the 1970s at the Yaddo artist retreat in upstate New York. Segal, who taught at Columbia University, Princeton University and several other schools, satirized academic life in "Shakespeare's Kitchen."In 2019, she compiled her fiction and nonfiction in the anthology "The Journal I Did Not Keep," in which she summarized the importance and imperfection of recapturing the past.

"I believe that the act of remembering and telling the story of what we remember will always be to some extent fatal to the thing remembered," she wrote. "So what really happened?"Her many admirers included such author-critics as Cynthia Ozick, Vivian Gornick and Alfred Kazin. In 2008, she was a Pulitzer Prize finalist for her novel "Shakespeare's Kitchen." The American Academy of Arts and Letters inducted her in 2023.Gornick would cite her "ironic intelligence" and "gift for detachment." In her fiction, Segal set a tone that was even, objective and occasionally cutting, like her

description of an artist in "Lucinella" who "tends to mumble her words inside her Besides her books, Segal wrote for The New mouth, so as to keep the option of eating them." She could also be intimate and familiar, with such recurring characters as her alter ego Ilka, a Viennese refugee; and Carter Bayoux, a Black intellectual with whom Ilka has an affair in "Her First American."Her narratives were often sustained through passages of overheard conversation, whether at a literary cocktail party in Harlem or a gathering of faculty members in Connecticut. Several stories in her 2023 collection "Ladies' Lunch" were structured around the midday meals of friends in advanced old age who share memories, regrets, fears and everyday concerns."I like writing dialogue," she told the online publication The Millions in 2019. "I like it better than explaining. I'd rather have a character develop and express him or herself through dialogue than explaining what they're thinking. It's a preference. I like how we discover and uncover ourselves through dialogue. I tell my students, you see any two people together, walk behind them,

listen, get the tone of their voice.'

However, Naik, who is wanted in India on charges of hate speech and inciting communal disharmony, said a situation like this would never occur in his home country.Naik arrived in Pakistan on October 1 and is scheduled to stay till October 28. He made these remarks while addressing supporters in Karachi."While I was coming to Pakistan, our baggage weighed about 1,000 kg. I spoke to the CEO of PIA. The station manager assured me that he would do anything for me. When I told him that I had 500 to 600 kg of extra luggage, with some six people travelling with me, he offered me a 50 per cent discount. I told him that I would bring four more people since it would get even cheaper. I asked him to give it for free or leave it. I rejected the discount," he said. The Mumbai-born preacher further claimed that when a non-Muslim sees him in India, they would let him go for free."This is India, where people see Dr Zakir Naik and readily waive 1,000 kg to 2,000 kg extra baggage. But in Pakistan, I am a guest of the government and state guest is written on my visa. And your (PIA) CEO is offering me 50 per cent discount?" he queried.

The controversial preacher also complained that the airlines charged him 101 Malaysian ringgit (Rs 2,137 approximately) for every 1 kg of extra baggage."I was so hurt that the PIA could not even allow me to carry 300 kg of extra baggage as a state guest," he lamented."I don't want your discount. I am saddened to speak the truth, but this is the state of affairs in Pakistan. In India, even when a Hindu sees me, they say 'Dr Naik will always speak the truth'. In today's date, India is not wrong, (Prime Minister Narendra) Modi is.

Hamas chief Yahya Sinwar, presumed killed in Israeli strike, is alive: Report

World Hamas leader Sinwar is alive and has secretly established contact with Qatar, Israeli media outlet The Jerusalem Post reported on Monday. The development came days after it was reported that Israel was investigating the possibility of Sinwar's killing in a rocket strike that hit a school sheltering displaced Palestinians in Gaza City.However, a senior Qatari diplomat, exclusively told the Jerusalem Post, that reports of direct contact were false. According to the diplomat, contact was established through Khalil al-Hayah, a senior Hamas figure. It further maintained that Qatari officials also previously stated that they believed Sinwar surrounded himself with hostages before going silent.Sinwar was



presumed to be killed in the September 21 Israeli strikes in Gaza, because he had not established contact with official channels for a long time. The Israeli military said the attack targeted a Hamas command centre, but Palestinian health He was arrested by Israel in the late 1980s authorities said that women and children were among the 22 people killed in the strike.In a report on September 22, the

Times of Israel said that officials were investigating the possibility that Sinwar was dead, following up on military intelligence, as reported by Israeli journalist Ben Caspit.

2023 driest year for global rivers in over three decades: WMO report

World According to the State of Global Water Resource report, the year 2023 marked the driest year for global rivers in over three decades, according to a new report coordinated by the World Meteorological Organization (WMO), which signalled critical changes in water availability in an era of growing demand.Currently, 3.6 billion people face inadequate access to water at least a month per year and this is expected to increase to more than 5 billion by 2050, according to UN Water, and the world is far off track Sustainable Development Goal 6 on water and sanitation. The last five consecutive years have recorded widespread below-normal conditions for river flows, with reservoir inflows following a similar pattern. This reduces the amount of water available for communities, agriculture and ecosystems, further stressing global water supplies, says the Report.Glaciers suffered the largest mass loss ever registered in the last five decades. 2023 is the second consecutive year in which all regions in



the world with glaciers reported ice loss.

With 2023 being the hottest year on record, elevated temperatures and widespread dry conditions contributed to prolonged droughts. But there were also a significant number of floods around the world. The extreme hydrological events were influenced by naturally occurring climate conditions - the transition from La Niña to El Niño in mid-2023 - as well as human induced climate change.

"Water is the canary in the coalmine of climate change," said WMO Secretary-General Celeste Saulo. "We receive distress signals in the form of increasingly extreme rainfall, floods and droughts which wreak a heavy toll on lives, ecosystems and economies. Melting ice and glaciers threaten long-term water security for many millions of people. And yet we are not taking the necessary urgent action," she further said.Human induced climate change resulted in rising temperatures which accelerated the hydrological cycle. It becomes more erratic and unpredictable, as it causes either too much or too little rain."A warmer atmosphere holds more moisture which is conducive to heavy rainfall. More rapid evaporation and drying of soils worsen drought conditions," she said. Long wait near bus station for hubby who never came in TN

- CHENNAI. Sivaranjini, the wife of Karthikeyan (34) who was among the five persons died at the Marina after the Indian Airforce's air show, had to wait for nearly two hours along with her three-year-old child near Muthamizh Arignar bus station at Anna Square, waiting for her husband who never turned up.
- Speaking to about the horror on Sunday, she said the three of them started early from the Marina, and Karthikeyan asked her to wait near the bus station before going to take the bike, parked near Napier Bridge.
- "I kept calling him, but couldn't reach him due to poor signal. Around 3.20 pm, someone answered the call and told me that he had fainted," she said. The passerby also sent her the location of where he was found. With the help of the police, she rushed to the spot and Karthikeyan was taken to Rajiv Gandhi Government General Hospital, where he was declared dead after 15 minutes.
- Karthikeyan's family members and friends who were at the hospital said his life could have been saved had the phones were reachable and he was taken to the hospital on time."He fainted on the way to take his bike. The ambulance also got stuck in the crowd and arrived at the spot late," they said, urging the government to provide a job to his wife so that she can manage the family.
- They also added that the doctors indicated that he could have died of dehydration or food poisoning and the report will take two weeks. The family of Karthikeyan initially refused to receive his body from Rajiv Gandhi Government General Hospital. However, they accepted it after officials spoke to them.

Teen dies after falling from train, run over by another train in Vellore

- VELLORE. A 17-year-old student at Nettur Technical Training Foundation (NTTF) in Vellore, died after allegedly falling off a train heading from Chennai to Mysore around 4 pm on Sunday. The victim, R Hashwanth from Tiruvallur was returning to college from his hometown.

The post suggested that had timely help been provided, the boy's life might have been saved. Teen dies after falling from train, run over by another train in Vellore

VELLORE. A 17-year-old student at Nettur Technical Training Foundation (NTTF) in Vellore, died after allegedly falling off a train heading from Chennai to Mysore around 4 pm on Sunday. The victim, R Hashwanth from Tiruvallur was returning to college from his hometown.

According to the railway police, Hashwanth met with the accident some 3 kilometres away from Katpadi Railway Station where he slipped and fell, landed on the adjacent track, and was run over by another train travelling in the opposite direction. A co-passenger alerted the Katpadi Railway police and handed over Hashwanth's bag as well. By the time the police arrived at the spot, Hashwanth was dead.Following a post-mortem at Adukkamparai government hospital, his body was handed over to



relatives, police said. No one offered help' Meanwhile, a viral post on X, featuring images from a Reddit post, claimed that students from a nearby university had witnessed the boy falling from the train

and that he was still alive afterwards. The post also claimed that the students had approached hostel wardens and guards for help but they were unwilling to assist. It further mentioned that there was enough time before the second train arrived.

However, when inquired about the incident none of the students were available for comment. The post suggested that had timely help been provided, the boy's life might have been saved. Despite repeated requests from , the university's public relations officer also did not respond to the issue till time of publication.

- BHUBANESWAR . As the Durga Puja revelry begins, residents of the state capital are bracing up for traffic snarls, a usual phenomenon during the festive season. Commuters are already experiencing traffic jams on most of the major routes like Cuttack-Puri Road, Kalpana, Rasulgarh, Vani Vihar, Saheed Nagar, Janpath, Acharya Vihar, Jaydev Vihar, Chandrasekharpur and others. As major pandals including the ones at Baramunda, Nayapalli, Saheed Nagar, Rasulgarh and Bomikhal are located on the side of main roads, the traffic woes will only deteriorate in the coming days.
- Alok Patra, a citizen, said, "It took me more than 30 minutes to reach Kalpana Square from Saheed Nagar via Satya Nagar on Monday afternoon. Usually, it takes less than 15 minutes to cover the same distance." He alleged that there is no traffic management in the city with the cops hardly making any effort to address the issue, especially during the evenings.
- Another route which witnesses major traffic congestion is the Jaydev Vihar-Nandankanan road. Long queues of vehicles moving at a snail's pace has become a regular affair on the road.A major cause of concern is the abrupt halting of inter-city buses on the flyover in front of Institute of Minerals and Materials Technology (IMMT) at Acharya Vihar and on National Highway-16 near Satsang Vihar, Rasulgarh and Palasuni. It's been three years since a humanitarian initiative to feed the needy and the homeless at Kannur Government Medical College Hospital got underway.Driven by the belief that hunger can be more serious than disease, Superintendent Dr K Sudeep launched the 'No to Hunger' project at the hospital aimed at feeding the needy

The initiative emerged when the community kitchen, which had been operating during the Covid lockdown, was discontinued. Hospital administrator Dr M V Bindu and Dr Sudeep, along with the wardens decided to do something to provide food for the poor.

They formed a WhatsApp group that included student volunteers, a health inspector, a representative from the Daya Charitable Society, and sociologists. Together, they organised the distribution of food to those in need.

Each day, food is brought from the girls' mess in the morning and the boys' mess in the evening. The responsibility for a week's food distribution rotates among students. Currently, the 2022 batch of students manage the task.

Steel tiffin boxes were donated by the Daya Charitable Society to assist in the effort. If food is unavailable from the mess, it is provided by Daya. Sociologists Mini and Shalini serve as coordinators. In the intensive care unit, food is delivered directly to patients without bystanders based on reports from ward nurses.

'During the COVID-19 lockdown, Kannur Medical College played a major role in providing free treatment to COVID-positive patients from northern Kerala. About 9,000 patients recovered under our care. During that time, a community kitchen provided free food to all patients, bystanders, and staff. Unfortunately, it was closed after the lockdown," said Dr Sudeep.

Unshackling prisons from caste prejudice

PRISONS are a microcosm of society, reflecting the disparities that prevail in it. A parallel world exists in prisons. It operates on the basis of both written rules framed by the State in the prison manuals and unwritten codes of the inmates and the staff.In India, prison is a state subject and each state has framed its own rules and regulations. The colonial legacy in terms of the Prison Act of 1894 is reflected in the prison manuals. While dehumanising practices such as whipping, mentioned in the Prison Act, had been declared unconstitutional, derogatory practices related to the distribution of work on caste basis still persist in prison manuals.

- The Supreme Court has, over the years, delivered significant judgments on prison-related matters that have ushered in reforms. It was in the Sunil Batra case in 1978 that the SC held for the first time that a person in prison does not become a 'non-person' and retains all human rights, except within the limitations of imprisonment. It was affirmed that the prisoners have a right to live with dignity. In its latest judgment in the case of Sukanya Shantha vs Union of India, the SC has directed the Union and state governments to ensure an end to the caste-based discrimination in prisons. Sukanya had highlighted how caste identities governed prison labour assignments, segregation in barracks and discriminatory treatment towards prisoners belonging to denotified tribes and habitual offenders. The apex court held that these provisions violate Articles 14, 15, 17, 21 and 23 of the Constitution. It declared that "the right to dignity is not forfeited upon incarceration". Caste-based bias within jails strips prisoners of their dignity.
- Nearly 17 states will need to make the necessary changes in their manuals. The SC has asked the Centre to modify its Model Prisons Rules to address caste-based segregation.Prisoners come from multiple vulnerable groups, ranging from Dalits to tribals and religious and ethnic minorities. The discrimination and marginalisation are further perpetuated and even embedded inside the prison.
- The SC held that the practice of assigning labour based on caste, where Dalits and members of denotified tribes were forced into menial tasks, such as cleaning toilets, must cease immediately. For instance, the Madhya Pradesh jail manual states that 'Mehtar prisoners' are responsible for handling human excreta in the toilets. Those who are at the bottom of the societal class pyramid would be required to do the menial work and those higher up would get other work, like legal documentation. While prisoners do get paid for the work, it is a paltry sum in many states. Remission is also earned by the convict inmates who work in the prison and the performance of maintenance work earns more remission. But who gets to do what work may be at the discretion of prison staff. The SC has declared that all labour assignments should be made on the basis of equality and non-discrimination.

"Prisons should not be spaces where historical wrongs are perpetuated. They must embody reform, rehabilitation and, most important, equality."The SC held that the provisions which allow for classification and segregation based on caste are unconstitutional. The states have been directed to do away with the provisions in prison manuals that perpetuate discrimination based on caste within three months and file compliance reports. The "caste" column and any references to the caste of jailed undertrials or convicted prisoners' registers inside the jails should be dered It is not for the right to equality has been found to be violated in various manuals and practices. It is a known fact that the highest class people get treated well everywhere, even in jail.Notably, the Punjab Jail Manual of 1996 made a distinction between 'better-class' and 'ordinary-class' prisoners on the basis of social status and education as well as whether the inmate was accustomed to a superior mode of living. 'Better-class' inmates got to stay in separate wards with furniture, had a separate kitchen and better diet and were not required to do menial tasks.

The growing threat of fake, substandard medicines

The Indian pharmaceutical industry is hampered by outdated regulations, weak penalties and slow prosecution.

THERE have been several disturbing reports about the quality of some commonly used drugs. The Central Drugs Standard Control Organisation (CDSCO), in its monthly report for August, declared more than 50 drugs as 'not of standard quality' (NSQ). They include the commonly used paracetamol, vitamins and calcium supplements, available over the counter. Medicines that failed the quality check also include anti-

ulcer drug pantoprazole, anti-diabetic drug glimepiride, hypertension medication telmisartan and some lifesaving antibiotics. Another five drugs were declared spurious, adulterated or misbranded. This raises safety concerns about the use of not only these drugs but also others. The CDSCO releases a list of drugs in the category of NSQ every month from amongst the drugs that are randomly checked in the pharmacies. In February 2023, as many as 1,251 drugs were checked and 59 were found to be NSQ. In March 2023, 48 of the 1,497 drugs tested were NSQ.Though it amounts to less than 0.05 per cent of all drugs tested, it is a serious matter for a country which claims to be the pharmacy to the world. India has the highest number of US-FDA-compliant plants outside of the USA and over 3,000 pharma companies, with a network of over 10,500 manufacturing facilities. The

country is the largest manufacturer of generic drugs and vaccines in the world.Drug manufacturing, distribution and sale in India are regulated by the Drugs and Cosmetics Act, 1940. The state drug regulatory bodies regulate the grant of licence, production, marketing and distribution of medicines while the central drug regulatory body is responsible for approving new drugs and clinical trials.From time to time, the Indian pharma industry has come under a cloud. A couple of years ago, there was international uproar over deaths in Africa following the ingestion of a cough syrup made in India. A similar episode had been reported in Uzbekistan. There The quality of drugs in India is dependent upon the sanctity was an instance of five deaths at PGI-Chandigarh due to the use of a substandard anaesthetic agent, propofol. About 15 years ago, Ranbaxy, a leading pharmaceutical company, was found by the US FDA to have falsified data and test reports at its manufacturing plants in India.

As per the CDSCO report, some drugs were found to be spurious, with the manufacturers claiming that they had not made them at their facilities. This raises the question of whether they have been made by some other manufacturer and marketed under a renowned brand. This would amount to the drugs being fake.One can imagine what would happen if intravenous drugs were made spuriously. They would cause instant reaction, shock and, even, death.Drug-manufacturing in India is supposed to be well regulated, with each manufacturer required to have basic infrastructure, trained manpower



and due licensing. However, getting a licence to start one's own production is not a difficult task. This is evidenced by the mushrooming of drug-making units like a cottage industry in many states.

At the same time, we have a category comprising state-ofthe-art units of major companies which comply with the US FDA norms. They conduct periodic inspections and verifications. The second category of units adheres to WHO standards, with periodic checks. The third category is the one which is certified to be following good manufacturing practices (GMP). There is a gradient of quality in these three types of manufacturing.

of the manufacturing processes followed by the company. Certain MNCs would rather destroy the whole batch of a questionable product than bring it to the market. That is not the case with some smaller companies. For them, profit-making supersedes patient safety. This is exemplified by third-party manufacturing by many companies. The active pharmaceutical ingredient (API) in each drug has to meet the purity standards laid down. But since most APIs are imported

and their cost depends upon the actual concentration of the compound, an element of cost-versus-quality exists. Then, the finished product has to meet the standards laid down in the Indian Pharmacopoeia, which include drug assay, dissolution and tests for particulate matter and pathogens etc. It is the job of drug inspectors to check the manufacturing processes at each facility periodically.


They also collect samples of drugs for analysis and enforce legal standards.

One of the main problems with ensuring the quality of drugs manufactured in India is the permissiveness in licensing drugmanufacturing units. The government gives licences to 15-20 companies to make the same drug from the same APIs. Many larger companies outsource some of their products to third-party manufacturers. Then, there are ghost manufacturers where the licensee may not have a manufacturing unit and gets the drugs made from another unit. The end result is a compromise on quality.To make matters worse, there are groups of chemists and doctors who set up their own units to make some fast-selling products. The recent directive of the government to prescribe generic medicines and the opening of Jan Aushadhi stores, which dispense cheaper generic medicines, has led to the mushrooming of small manufacturing units. This makes their regulation

difficult.The Indian pharmaceutical industry is hampered by outdated regulations, weak penalties and slow prosecution. Two years ago, the manufacturers of the substandard cough syrups were made to suspend manufacturing of only those drugs and allowed to continue with the rest of their activities. Earlier this year, the Drugs Controller General of India announced policy initiatives on three issues: recall guidelines, norms on good distribution practices and the use of similar brand names by pharma companies for their drugs. But the implementation of the remedial measures is tardy. The monthly alert report of the CDSCO is a positive initiative of the government, but a lot more is required to be done. There is an urgent need to make the raw material or the APIs in India. Currently, a majority of them are imported. At the ground level, a larger trained and skilled workforce is needed. The government should spare funds for technology for analysis and testing. Drug-unit licensing and regulations to run them should be more stringent. At the same time, stiffer penalties are required for defaulters.

Despair, dread a year after Hamas attack



Justice for the Palestinians and security for Israel are more elusive than ever

THE first anniversary of the brutal and surprisingly effective attack by Hamas against Israel comes with a sense of despair and foreboding. October 7, 2023, witnessed the slaughter of young men and women at a music concert, of residents of Kibbutz Be'eri and Nir Oz, and Jews young and old taken hostage. But after that, it's been a year of searing images from Gaza, of over 42,000 dead, of dismembered toddlers and grieving families, of caravans of hapless refugees moving from one bombed-out location to the next, of flattened neighbourhoods and a dystopian landscape that defies imagination. It has also been a year that exposed the utter hypocrisy of Western sermons about the sanctity of international law, of a rules-based order. And it's been a long year that has demonstrated the utter impunity of the powerful and the abject misery of the dispossessed in equal measure. West Asia today is teetering on the edge of a full-scale regional war, while justice for the Palestinians and security for Israel are more elusive than ever. So much has happened on so many fronts that without unpacking some of the key strands, it is easy to miss the woods for the trees.

Let's start with Israel. After the shock of multiple military and intelligence failures on October 7, the Israeli Defence Forces, along with intelligence agencies Mossad and Shin Bet, clearly regained their mojo. From the exploding pagers in Lebanon to the assassination of Hamas chief Ismail Haniyeh in Tehran, from the targeting of a senior IRGC (Islamic Revolutionary Guard Corps) commander at an Iranian embassy building in Damascus to the use of bunker-busting bombs that killed Hezbollah leader Hassan Nasrallah in Beirut, Israel has once again demonstrated its formidable intelligence, technical and military capacity. But the military successes have also given rise to a growing sense of hubris, with some influential Israelis openly

advocating a "reset of the Middle East" that would include a regime change in Iran and possibly in Lebanon. Saner voices in Israel do bring up the lessons of history, pointing to the folly of building up Hamas to undermine the Palestine Liberation Organisation, to the painful invasion of Lebanon in 2006, to the deliberate scuppering of the Oslo Accords and more. Their voices, though, are lost in the clamour for retribution. In politics, machismo evidently works and Prime Minister Netanyahu's approval ratings have shot up in recent weeks.Iran was hoping for its own reset, having surprised many by electing the relatively moderate Masoud Pezeshkian as

President in July with the hope of bringing a semblance of normalcy in the country's troubled ties with the West. Tehran displayed remarkable restraint after the affront of Haniyeh's assassination, but successive Israeli provocations have brought the hardliners back to the forefront. They see restraint as an abject surrender and they are baying for retaliation. The missile attack on October 1, 2024, was unleashed at least in part to assuage this lobby. Israel has vowed to respond and is reportedly looking at Iran's oil installations and nuclear facilities as possible targets. A major attack may well achieve the unintended objective of weakening a moderate government and strengthening the religious hardliners who are among Israel's most

implacable foes.Hezbollah under Nasrallah was Iran's most reliable and effective proxy in the region. Over the last two decades, its armed forces had grown to a point that it was virtually a state



within a state in Lebanon's fractured polity. The killing of Nasrallah and other top Hezbollah commanders by Israel in recent weeks is undoubtedly a blow to Iran and the influence that it had so assiduously cultivated in the region. But Israel's relentless aerial bombardment has already left over a thousand Lebanese dead, many of them innocent civilians. Relief over the emasculation of Hezbollah is offset by outrage over the impunity with which Israel is destroying civilian infrastructure as it targets Hezbollah facilities. The Houthis in Yemen, another of Iran's proxies in the region, have emerged as an unexpected actor in the wake of the October 7 Hamas attack. Their attacks on shipping in the Red Sea have affected global

supply chains and led to a costly detour around the Cape of Good Hope. This has raised freight and insurance costs and reduced Suez Canal revenues for the cash-strapped Egyptian economy by a

> quarter. Asserting their stout commitment to the Palestinian cause, they have also taken a few potshots at Israel and attracted their own share of disproportionate retaliation.

This brings us back to Palestine itself. The International Court of Justice in the Hague, by an overwhelming 14-1 majority, ruled that Israel's occupation of Gaza, the West Bank and East Jerusalem was unlawful and must cease immediately. Israel's Knesset perversely passed a resolution opposing the formation of a Palestinian state. Proceedings on a second case

accusing Israel of committing genocide in Gaza are underway. But that has neither curbed Israel from moderating its military campaign nor slowed down the runaway growth of illegal Jewish settlements in the Occupied West Bank that are now incentivised and protected by fanatics like National Security Minister Itamar Ben-Gvir and Finance Minister Bezalel Smotrich, key members of Netanyahu's ultra-right-wing government. They are systematically executing their plans to control all of the land from the Jordan river to the Mediterranean Sea, thereby closing every possible pathway to a two-state solution where an independent Palestinian state can co-exist with a secure Israel. And they make no secret of their designs.



New Delhi: Television actor Madhura Naik, on the occasion of Israel marking the one-year anniversary of the October 7 attacks, recalled her family's harrowing encounter with terrorists last year in Israel and termed it as "the darkest day."he actress, who is a Jew of Indian origin said that she lost her first cousin and her brother-in-law in a crossfire in Sderot during the attacks on Israel last year.Speaking at an event in New Delhi organised by the Israeli Embassy, Naik said, "We follow Judaism but along with that we also have adapted to Hindu traditions, thus proving that the Jews were always open to cross-cultures and adapted very well to new environments. My grandmother being the 14th child, 13 of her brothers and sisters moved back to Israel in the 70s. where they flourished back in their homeland along with their fellow Jews. It was more than just a sense of belonging. It was home for them. But unfortunately, on October 7, it was the darkest day for my family. ""They were the victims of October 7. I lost my first cousin and her husband in a crossfire in Sderot,



Israel. They were brutally murdered in front of their two daughters, six and three years old. The six-year-old, the last words before getting rescued by the Israeli police were, she said, Are you the Israeli police? Please save the kid next to me," she added. The actress said that hatred breeds terrorism and it knows no religion, race or gender."Imagine a sixyear-old having to experience the murder of her very own mother and her father and still being aware that she had to save the three- And hate breeds terrorism. And we must do year-old baby next to her. They were rescued by the Israeli police amidst a brutal crossfire that went on for a couple of hours. An Israeli

policeman was brutally injured during this rescue. The children were drenched in the blood of their own parents. This incident tore my family apart.

And there are things that we could never change and things that we'll never be able to replace. Also during this crossfire, an Arab Muslim man tried to save my sister and the kids to drive them out of the crossfire. But to his fate, they killed him too, regardless of his religion, his race, and that he was very much one of them, an Arab Muslim man. So their terror knows no religion, or race, or gender, nor age," Naik said, recounting the agony faced by her family.

"They now live under constant fear and threat of losing their lives, and we are under constant pressure to protect them. As far as I have seen in this long one year of struggle and war, hate breeds hatred. And hate breeds enmity.

National Conference-Congress **Alliance Takes Commanding** Lead In J&K Election

New Delhi: The Congress-National Conference alliance is all but certain to form the next elected Jammu and Kashmir government, after battling to a commanding lead in the 2024 J&K Assembly poll - the first in the former state since Article 370 was scrapped and the first since the 2014 election. At 2 pm - in what was supposed to be a tight race - the Congress-NC was leading in 52 seats. The BJP was ahead in 27 and the People's Democratic Party of ex Chief Minister Mehbooba Mufti - whose party allied with the former after 2014 but the two fell apart by 2018 was leading in two.

Independent candidates were in pole position in nine seats. Within the Congress-NC alliance, the former is leading in only eight of the 39 seats it is contesting. The big push is from the NC, which fielded candidates for 56 seats and is now ahead in 43. The results are a big positive change for the state party, which won only 15 in the last Assembly election in J&K. The big negative change is for the PDP, which won 28 seats in the 2014 poll.The Congress and the BJP are on course to just about match its past haul of 12 and 25

J&K Assembly Election Confirmed Wins

The NC, the Congress, and the BJP have also had confirmed wins in this J&K election. The NC has eight confirmed wins at this time, including party boss Omar Abdullah from Budgam; this was one of two seats - the other was the family stronghold of Ganderbal - he was contesting. The 54-year-old Omar Abdullah is nearly 9,000 seats ahead in that race. He has also been confirmed by his father as the new Chief Minister of J&K, assuming the Congress-NC alliance will retain its lead.

Other confirmed wins at this time are 11 for the BJP, two for the Congress, and one for the PDP.Two independent candidates - Payare Lal Sharma, Dr Rameshwar Singh, and Choudhary Mohammed Akram - have won the Inderwal, Bani, and Surankote (which is reserved for Scheduled Tribes) seats

Row Over 5 Nominated MLAs

The race to control the former state's 95 Assembly seats - of which five have been nominated by Lieutenant Governor Manoj Sinha in a controversial move - was predicted to be a close one.Exit polls gave the Congress-NC alliance a slight edge. An aggregate of three indicates the Congress-NC will win 43 seats and the BJP 26, with the PDP winning between four and 12.Exit polls, therefore, predicted a hung Assembly; J&K has 90 elected seats with the majority set at 46.As things stand the Congress and the NC will have little problem in staking claim to form a first elected government in Jammu and Kashmir in a decade. However, should exit polls - and they are sometimes right - ring true, the PDP could be a 'kingmaker' for the Congress-NC, but not for the BJP, which will also need support from non-aligned lawmakers.

Study Identifies Reason Behind Long-Lasting Covid-19 Symptoms

New Delhi: A new study on Tuesday showed that damage to the brainstem -- the brain's 'control centre' -is behind the long-lasting physical and psychiatric effects of severe COVID-19 infection.esearchers from the Universities of Cambridge and Oxford used ultrahigh-resolution scanners that can see the living brain in fine detail to observe the damaging effects Covid in the brains of 30 people who had been admitted to the hospital with severe infection early in the pandemic.

- Their results, published in the journal Brain, revealed how SARS-CoV-2 affects brainstem regions associated with breathlessness, fatigue, and anxiety. The brainstem is the critical junction box between our conscious selves and what is happening in our bodies," said Professor James Rowe, from the Department of Clinical Neurosciences, who co-led the research
- The ability to see and understand how the brainstem changes in response to Covid will help explain and treat the long-term effects more effectively," Rowe added.Fatigue, breathlessness, and chest pain were the troubling long-lasting symptoms among several patients admitted to the hospital early in the pandemic.
- The team hypothesised these symptoms were partly the result of damage to key brainstem nuclei, which persists long after the infection has passed. The study found that multiple regions of the brainstem -- the medulla oblongata, pons, and midbrain -- showed abnormalities consistent with a neuroinflammatory response. These appeared several weeks after hospital admission, and in brain regions responsible for



Global Tablet Market Up 15 Per Cent In Q2, Growth To **Continue This Year: Report**

New Delhi. Global tablet shipments grew 15 per cent (year-on-year) in the second quarter (Q2) this year, despite a slow period historically, a report said on Tuesday. The market witnessed a return to form in Q2 2024 as tech giant Apple and Samsung had new releases compared to none the previous year, while other market players also displayed strong numbers, according to Counterpoint Research's latest 'Global Tablet Market Tracker'. Research Associate Kevin Lee said the market leaders' return to normal model release schedules signals an optimistic outlook for 2024 and is an indication of recovering consumer sentiment, due to fresh releases from Apple and Samsung. Other than Apple and Samsung, Chinese original equipment manufacturers (OEMs) such as Huawei and Xiaomi manufacturers (OEMs) such as Huawei and Xiaomi also added to growth momentums offering an increasingly diverse range of model offerings in the tablet market, further stimulating demand," Lee added. The worldwide tablet market shipments look promising for the rest of this year, stacked with releases of the new Apple iPad and Apple iPad Mini, on top of Samsung's flagship S series, both expected to be launched in the latter half of the year.

"As improving macroeconomic conditions continue to restore demand to healthy levels, we expect to see an increasing contribution from emerging market regions for 2024," said Associate Director Liz Lee, commenting on the immediate outlook of the tablet market.Huawei retained its position among the top three with continued model releases. Xiaomi almost doubled its shipments, led by growth in emerging markets, especially the APAC and MEA regions.

"The continued launches from Apple and Samsung will drive growth momentum in H2 (second half) 2024," the Counterpoint report mentioned.

Advisory issued for airlines using Boeing 737 aircraft

NEW DELHI. The Directorate General of Civil Aviation (DGCA) has issued safety advisory to domestic carriers operating Boeing 737 aircraft regarding potential risks with the rudder control system. The advisory directs airlines to inform their flight crews about the risk of a jammed or restricted rudder control system and implement necessary mitigations."Appropriate measures must be communicated to help crews identify and manage such situations," said DGCA. Airlines have also been instructed to conduct a risk assessment for their Boeing 737 fleets and address the rudder control issue. The advisory mandates the suspension of Category III B operations, which include lowvisibility landings and autoland procedures, until further notice. The DGCA has asked airlines to hold discussions about potential rudder system issues a part of crew training. The issue will be included in Instrument rating/proficiency checks (IR/PPC) and pre-simulator briefings, where crews will practice handling scenarios involving rudder malfunctions.

Crude oil prices seem to stabilise as all-out war fears recede

New Delhi. Despite last week's crude oil price spiral, the situation seems to be stabilising with analysts expecting the market to cool off in the coming days. Tensions between Israel and Iran led to a 13 per cent sourt in Brent crude prices in 13 per cent spurt in Brent crude prices in the past seven days, with the benchmark crude hitting \$79.4 per barrel on October 7, up from \$70.2 just a week earlier. The Indian government is confident of shielding the country from any fallout in sneeding the country from any failout in case of crude oil supplies being hit by an escalation in the tensions. "Today there is more oil available in the world than there is consumption", said Hardeep Singh Puri, Union Minister for Petroleum and Natural Gas "frequence partice held head head Natural Gas."If some parties hold back on availability, there are new suppliers on the market also, in the short to medium term I do not see any shortage of oil in the world. Currently India imports 88 per cent of its crude oil requirements from 39 countries, leaving it exposed to the vagrancies of the market.According to energy market

expert Narendra Taneja, the situation could get hairy for India only if tensions escalate in the Gulf. "If Israel attacks oil installations in Iran, the situation will get out of control", said Taneja in a conversation with Business Today. He added that Iran in turn could block the added that Iran in turn could block the Straits of Hormuz and create a "massive disruption in supplies causing prices will go through the roof.'

Softening of crude prices

If the geopolitical situation does not worsen in the coming days, crude prices are seen softening with experts of the opinion that Israel and Iran are likely to pull back from the precipice as neither can afford the results of an all-out war."Benjamin Netanyahu has been very cautious about starting a war with Hezbollah", says Ian Bremmer, President and Founder, Eurasia Group, because Hezbollah is far better trained and armed than Hamas. He adds the likelihood of an all-out war is low.

"So, on one hand they want to get Hezbollah forces away from the Israeli border so that Israelis can come back to Oil markets stabilising



their homes and schools, on the other hand the likelihood of an all-out war is pretty low. That's the reason oil prices haven't moved since August and markets also do not believe that it is coming", says Bremmer.Sara Vakhshouri, President, SVB Energy International says, "Looking at where the prices will go, definitely it depends on where the destruction would be and how much oil is going to be taken off the market. But historically, we have seen that geopolitical factors, if the impact is not in a larger scale and could be mitigated, is not huge.'

The markets clearly reflect a sangfroid. Data from FactSet (in the table) shows Brent crude prices falling in the futures market. The trend displays the current tension bleeding off slowly in the next few months. A report by ANZ also helped cool down the market. Aside from stating that it did not see a drastic escalation in tensions with

drastic escalation in tensions with Iran, the report also flagged the possibility of enough supply buffers in the market, especially from the Organization of Petroleum Exporting Countries (OPEC), to offset supply disruptions in the Middle East.

Meanwhile, the Indian basket of crude oil, which comprises sour grade (Oman & Dubai average) and sweet grade (Brent dated) of crude oil processed in Indian refineries, averaged \$ 78.27 per barrel in August, down from \$ 84.15 per barrel the month before. Indian retail prices are calculated basis this basket. From April this year, when the price had hit a high of \$ 89.44 per barrel, the Indian basket has been on a declining trend.

Cognizant favoured H-1B holders over non-Indian workers, says US jury

Cognizant Technology Solutions has been found guilty of discriminating against non-Indian employees in favour of workers holding H-1B visas, a US jury has ruled, reported Bloomberg. The verdict, delivered in a Los Angeles court, found that the company engaged in unfair practices that harmed its non-Indian workers, leading to punitive damages for those leading to punitive damages for those affected .--- This case dates back to 2017 when a class-action lawsuit was filed against the IT giant, accusing it of bias in its employment practices. The lawsuit was brought forward by three employees who identified as 'Caucasian' and claimed they were unfairly treated. The employees said they were benched for five weeks without heirs essigned work and work without being assigned work and were eventually replaced by workers from India who were ready to take on USbased assignments. The case had previously gone to trial, but the jury had

failed to reach a verdict, resulting in a deadlocked jury. However, this time, the jury ruled in favour of the plaintiffs.

Cognizant The court found that Cognizant had

given preference to South Asian workers, many of whom were on H-1B visas, at the expense of non-Indian employees.Cognizant has expressed its disappointment with the jury's decision and plans to appeal the verdict.

In a statement, Jeff DeMarrais, a n a statement, Jeff DeMarrais, a spokesperson for the company, said, "We provide equal employment opportunities for all employees and have built a diverse and inclusive workplace that promotes a culture of belonging in which all employees feel valued, are engaged and have the opportunity to develop and succeed."Cognizant, based in Teaneck, New Jersey, is one of the largest IT services companies in the US and has been a major player in the H-1B visa program. According to US Citizenship and Immigration Services, from 2013 to 2019, Cognizant had the highest number of H-1B visas among US employers. The H-1B visa program allows US

companies to hire foreign workers for specialised roles, but it has also faced criticism for being used to replace local employees with lower-cost foreign labour

The case in Los Angeles, titled Palmer v. Cognizant Tech. Solutions Corp., focused on claims that non-Indian employees were unfairly treated when it came to job assignments and promotions. The plaintiffs argued that Cognizant systematically favoured Indian and South Asian employees, many of whom were on H-1B visas, when filling roles within the company.



Goldman Sachs recently advised investors to trust the People's Bank of China (PBoC), which is implementing

significant and unconventional support for Chinese markets. They said that the current situation is different from past market responses, suggesting that investors are finally receiving the support they have been waiting for. "The pullback risks may have risen after 30 per cent gains in 2 weeks, but policy (U-turn) provoked rerating trades have seldom stopped there," said Goldman Sachs.Despite some analysts hoping that foreign portfolio investment (FPI) outflows from

Morgan Stanley believes that the size and timing of the Chinese stimulus will be well-received by investors, as it shows the government's commitment to economic recovery through targeted policy actions. They anticipate that a stimulus of around 2 trillion yuan could be on the way, and they expect the positive market reaction in China to continue.

They comfortably reached the target with 11 balls to spare, with the game ending anticlimactically on a wide bowled by Imran Tahir.Saint Lucia's bowling had set up the match well. His brilliance extended beyond club football, as he became a Spanish national team hero, most notably scoring the winning goal in the 2010 FIFA World Cup final against the Netherlands, securing Spain's first-

ever World Cup triumph.

After leaving Barcelona in 2018, Iniesta enjoyed success in Japan with Vissel Kobe before joining Emirates for the final chapter of his illustrious career.

Exclusive: Paralympic champion Nitesh Kumar demands transparency from badminton body

Indian badminton won a total of 5 medals at the Paris Paralympics. While the Badminton Association of India announced cash prices for the medallists, gold medallist Nitesh Kumar says there is much to be desired from the BAI in terms of welfare of the athletes.

New Delhi. Badminton played a key part in India's historic medal tally in the Paris Paralympics. Out of the 29 medals won in Paris, Indian badminton accounted for 5, including one gold medal from Nitesh Kumar in the SL3 category. Nitesh beat Great Britain's Daniel Bethell in the final match, in a gruelling 3-game battle which lasted 80 minutes. Nitesh's victory was a massive

testament to his mental and physical strength, given he had a 0-9 record against Bethell before the match.Nitesh's medal was also a relief for India after their medal-less show in the Olympics just a few days back before the Paralympics began. Superstars Lakshya Sen, PV Sindhu, doubles duo of Satwiksairaj Rankireddy-Chirag Shetty returned without podium-finish from Paris, which was seen as a huge upset for this growing badminton nation. While 5 medals came from the Paris Paralympics, the reception from the Badminton Association of India was a quiet one. A spurned Nitesh Kumar - an IIT Mandi graduate and now a gold medallist - took to Twitter to vent his frustration, demanding the BAI to hand over the para-badminton administration to the Paralympic Committee of India.14 days after Nitesh's public tweet, BAI took cognisance of the matter and announced cash prizes for all badminton medallists. BAI announced that the gold medal winner,



Nitesh, will receive a purse of INR 15 lakh, silver medallists, Suhas and Thulasimathi, INR 10 lakh each and bronze medallists, Manisha and Nithya, INR 7.5 lakh apiece. However, Nitesh was not happy. In an exclusive interview with India Today, gold medallist Nitesh Kumar made three demands to the BAI, asking for more transparency, better communication and improved administration from the board. Nitesh said that even the cash reward that the

players have got might be a result of his tweet which went viral on social media.

After the tweet, they took some 20-25 days (14 days) and then the response we got was the announcement of the cash price, but not about our concerns. Like we are still waiting to hear from BAI and waiting for them to, you know, to try to get to know what our concerns are as a player and what issues we are facing," Nitesh Kumar told India Today in an exclusive interview.

NITESH KUMAR'S DEMANDS TO BAI Asked about the demands that he would like to make to the BAI, Nitesh said that the first one was the most basic one that he could make better administration. The player revealed that he is to play a tournament in Japan from October 22, for which he is yet to receive his travel details."The first one is the basic, administration, so that, you know, we get things done on time. Now we have a tournament coming up in Tokyo from 22 October and
