was found that the driver of the goods train had given information about placing a square iron angle on the railway track." The situation raises concerns amid a series of similar incidents reported in nearby states. Just days ago, police in Uttar Pradesh arrested a man for allegedly attempting to derail a train by placing iron rods on the tracks in Lalitpur district.

In 1991, he took the helm of the conglomerate when his uncle J.R.D. Tata stepped down - the passing of the baton coming just as India embarked on radical reforms that opened up its economy to the world and ushered in an era of high growth. Under Tata's leadership, the group launched the Tata Nano, the world's cheapest car, and expanded its software services arm, Tata Consultancy Services (TCS), into a global IT leader. Tata stepped down as

chairman in 2012 but was later named chairman emeritus of Tata Sons and other group companies, including Tata Motors and Tata Steel. He briefly returned as interim chairman in 2016 during a leadership dispute.

New Delhi, Oct 9: The Congress delegation handed over a memorandum to the Election Commission officials along with specific complaints from various constituencies in Haryana. Following a meeting with officials from the Election Commission of India (ECI), Congress leader Pawan Khera on Wednesday said they drew the poll body's attention to the electronic voting machines (EVMs) used in the recent Haryana Assembly elections. "We apprised the Election Commission about 20 complaints that have come to us, including seven written complaints from seven constituencies with some EVM machines functioning at 99 per cent battery capacity, while some EVM Machines were functioning below 60-70 per cent battery capacity," Khera told. He said

similar complaints had emerged from 13 other assembly constituencies, vowing to submit these grievances formally to the ECI. "We also told the EC that in the next 48 hours, we will make available to them other complaints that are being compiled," he said. A delegation of top Congress leaders comprising former chief ministers Bhupinder Singh Hooda and Ashok Gehlot and AICC leaders K C Venugopal, Jairam Ramesh, Ajay Maken and Pawan Khera, besides Haryana Congress chief Udai Bhan, met with top Election Commission officials. While ECI officials assured the delegation of a response to their concerns, Khera insisted that "assurances won't work" and called for tangible evidence and explanations to substantiate the integrity of the election process. "We need concrete answers supported and backed by evidence... What has the BJP got to do with it? This is between the Opposition and the Election Commission of India," he said. Congress claimed to have won seats where EVMs reportedly operated on batteries charged to only 60-70% while the BJP won several seats where EVMs showed 99 per cent battery. Earlier in the day, Rahul Gandhi, Leader of the Opposition, described the Haryana Assembly

Allies mock Congress over

AAP to go solo in Delhi polls, shuns Congress ST Correspondent

New Delhi, Oct 9: The Aam Aadmi Party will contest the upcoming Delhi Assembly elections alone against an "overconfident" Congress, a party member said on Wednesday. "In Delhi, AAP will contest alone We are capable of fighting the overconfident Congress and arrogant BJP alone," AAP spokesperson Priyanka Kakkar said. She blamed the Congress for not taking alliance partners seriously in Haryana and ultimately facing a rout due to its overconfidence. "The Congress has had zero seats in the Delhi Assembly for the past 10 years, yet AAP gave Congress three seats in the Lok Sabha polls; still they did not feel necessary to take allies along in Haryana," she said. Kakkar



claimed that Congress thwarted all efforts by the INDIA bloc to forge an alliance in Haryana and "didn't feel it necessary to take its ally along with them." The AAP and Congress failed to stitch up a pre-poll alliance due to differences over seat sharing. While the AAP lost all seats it contested in Haryana, the Congress fell well short of the majority mark, making way for the ruling BJP to return for a third consecutive time. The AAP and the Congress had fought Lok Sabha elections together in Haryana. In the election held earlier in the year, the AAP lost the sole seat it contested and the Congress won five out of 10 seats. Kakkar attributed the AAP's winning one seat in the Jammu and Kashmir to the party's development-driven politics. AAP national convener Arvind Kejriwal is scheduled to visit Jammu and Kashmir on Thursday, she said. The Aam Aadmi Party registered its first victory in assembly elections in Jammu and Kashmir on Tuesday when its candidate Mehraj Malik defeated nearest rival from the BJP in Doda constituency by a margin of over 4,538 votes. "Mehraj Malik is a very hard-working person, and he has been with the party since the time of the movement and struggle," Kakkar said. Malik, a District Development Council member, polled 23,228 votes against BJP's Gajay Singh Rana's 18,690 votes.

Haryana election debacle

Mumbai, Oct 9: The Congress on Wednesday came under severe criticism from its INDIA bloc allies after the party lost the Haryana assembly elections to the Bharatiya Janata Party. While Shiv Sena (UBT) questioned the Congress's decision to go solo in Haryana, the Trinamool Congress accused the party of "arrogance and entitlement". Shiv Sena (UBT) leader Sanjay Raut today said the Congress ignored the overtures of smaller parties thinking they could win the elections alone. He also praised the BJP. Class 7 boy falls into open stormwater drain in TN's Karur, dies

- **KARUR.** A 12-year-old boy drowned after falling into an open stormwater drain while returning from school on bicycle in Aravakuruchi in Karur district on Tuesday evening.
- The deceased M Mohammed Usman was a resident of Habeeb Nagar in Pallapatti in Aravakuruchi. He was a Class 7 student at a government higher secondary school in Pallapatti, said police.
- It was raining in Aravakuruchi when he was returning from school. While he was passing through Dindigul road he fell into a twofoot-wide open stormwater drain which was full due to the rain.
- A passerby, Jaffer, who witnessed the incident, attempted to rescue the boy but he was swept away by the strong current. Upon receiving information, police and personnel from the fire and rescue services rushed to the scene, conducted a search, and eventually located the boy's body floating in the Nanganchi River, where the drain merges.
- Police sent the body to the Aravakuruchi government hospital for postmortem. The Aravakuruchi police have registered a case and are conducting an inquiry.

Odisha horror: Woman ends life after drowning minor daughters

- JAGATSINGHPUR. In a shocking incident, a 32-year-old woman allegedly died by suicide after drowning her two differently-abled daughters in a pond of Janardanpur within Kujang police limits here.
- The victim, Subhadra Patra allegedly resorted to the extreme measures on Monday following torture over dowry and extreme poverty.Kujang police arrested the deceased's husband Lambodar Parida, treating it as a dowry-related crime.
- Subhadra threw her three-year-old daughter Saismruti, and two-year-old Samparna into a pond before hanging herself from a tree. Villagers rushed to the spot and took Subhadra to Kujang community health centre where the doctors declared her dead on arrival.Erasama fire brigade and ODRAF team launched a search and rescue operation in the pond, recovering the bodies of the two young girls over a period of 24 hours.
- Sources said, Subhadra was married to Lambodar from Pokhariapada in 2019.

13 years on, six convicted for trying to kill Dalit panchayat president in Tirunelveli

TIRUNELVELI. Six persons, including a notorious rowdy, were convicted on Tuesday in the 2011 a poramboke land.

"Despite the lack of sufficient funds with the panchayat, Krishnaveni sought assistance from a private cement company to fund the toilet's construction. She identified a land for the project, but the move was opposed by Subramanian, the then panchayat member, as the land was located near his house. He eventually prevented the construction work of the toilet," said sources.

They added on the day of the incident, as Krishnaveni was returning home from her panchayat office in an autorickshaw, a group of armed men, including Subramanian, ambushed her. "Before Krishnaveni could get down from the vehicle, the assailants attacked her with sickles, causing severe injuries. She lost part of her right ear and two fingers, and sustained deep cuts on her shoulder and neck. The attack left her in a pool of blood, and she was later rushed to Tirunelveli Medical College Hospital, where she underwent months of treatment. She was further transferred to Stanley Medical College Hospital in Chennai for a surgery," sources added.

The investigation of Thalaiyoothu police revealed that Subramanian, irked by Krishnaveni's persistence in getting the public toilet constructed, had conspired with his accomplices from various BC communities including the rowdy, Jacob, to murder her. The case was widely reported, causing widespread outrage across Tamil Nadu, with political parties staging protests demanding swift justice. Judge K Sureshkumar found the six accused persons guilty.

For the grand old party, the debacle has come at a time when it is putting high hopes on revival after its spectacular performance in 2024 Lok Sabha election in the state and its commendable performance at the national level.

The Congress has been looking to regain the support of the Christian-Muslim minority communities in the state so as to repeat the LS poll success in the coming LSG and assembly elections.

Similar to its recent strategy in the Haryana polls, the Congress has been banking on the anti-incumbency factor against the two-term LDF government and its CM Pinarayi Vijayan.However, in view of the Haryana setback, Congress leaders in Kerala have realised that a mere favourable political situation is not



enough to win an election in the new era. "Overconfidence is dangerous," CWC member Ramesh Chennithala, who is in Maharashtra for election preparation meetings, told.

"Electioneering is a different thing. I have told this to our leaders in Maharashtra," he said.He added that there is no guarantee that a party will win the elections based on favourable political conditions alone.

"A good candidate, evaluation of each constituency based on its specialties and many other things are crucial in winning the elections," Chennithala said. The Haryana verdict has indeed come as a severe jolt to Congress leadership in the state.

A section of leaders who have a difference of opinion with the style of functioning of Leader of Opposition V D Satheesan are wary there are similarities between the party's strategies in Kerala and the one that failed in Haryana."Here too we are waiting to cash in on the antiincumbency factor," a KPCC executive member told.

"The Haryana lesson teaches us that mere character assassination of a popular leader will not help win the hearts of people. The Congress-UDF has failed to take up a significant issue or subject after the K-Rail protest which had enjoyed popular support," he said. Close shave for crew as crane crashes on vessel

- PARADIP. At least 21 crew members of a vessel had a narrow escape after a shore harbour mobile crane (HMC) collapsed during cargo unloading at Paradip Port here on Tuesday.
- Carrying nearly 21,000 tonne of cargo, the vessel, MV AMNSI Maximus, had docked at the multipurpose berth of Paradip Port on Monday. Sources said a shipping services company had deployed its HMC shore crane to unload the cargo, which included limestone and dolomite, from the vessel. During the unloading process, the crane's rope snapped, causing its midsection to collapse on the vessel.
- Local workers said the mishap took place as the crane was attempting to lift cargo beyond its capacity. The excessive weight caused the rope to snap, leading to the collapse. The crane's lifting cylinder and parts of the ship were also damaged in the incident.
- On hearing the loud crash, panic spread among the 21 crew members on board the vessel. However, they escaped unhurt. The workers too escaped narrowly without any injury.
- A senior officer of Paradip Port Trust (PPT) confirmed the incident and said the crane's rope had weakened, resulting in its failure during the unloading process. Port and dock safety officials rushed to the mishap site to investigate the incident.
- He further said such mishaps are not uncommon during cargo operations at Paradip Port. While there have been no reports of any casualty, the full extent of the damage is yet to be assessed. The crane's grab also fell into the harbour water. The unloading operation has been suspended since morning.

CUTTACK. The Orissa High Court has expressed satisfaction over the new guidelines drawn up by the government to deal with the 1.31 lakh cases pending before the 40 different revisional courts for land disputes in the state.

Accordingly, the single judge bench of Justice BP Satapathy on Monday disposed of the petition regarding inordinate delay in admission of matters in the revisional courts. The petitioner Guruprasad Mohapatra, a resident of Odagaon area in Nayagarh district, alleged that petitions filed in 2022 were yet to be taken up for admission.

The high court was informed about the new guidelines by additional chief secretary Revenue and Disaster Management department Deoranjan Kumar Singh and member Board of Revenue CJ Venugopal in their respective affidavits filed in pursuance to the court's order issued on



September 25. The two affidavits said as per the new guidelines all the revisional courts shall hold courts for a minimum period of three days in a week, so as to streamline the functioning and reduce the pendency of cases thereby. Adequate number of law officers will also be appointed in the revisional courts.

The presiding officers and court officers shall ensure admission of at least 50 old cases per day till completion of the process of admission of all old cases and simultaneous admission of new cases will be taken up within six months," the affidavits stated. The presiding officers shall also take steps for analogous hearing of cases having similar prayers within a time bound manner, the affidavits stated while assuring to give natural justice to petitioners in old cases and remove defects within a month.

Endorsing the measures spelled out in the two affidavits, Justice Satapathy expressed hope that the authorities will ensure implementation of the steps planned to reduce the huge backlog of cases.Earlier, the member Board of Revenue had filed an affidavit stating that 1,31,532 cases in the matter of Orissa Survey & Settlement Act, 1958 and Orissa Consolidation of Holdings & Prevention of Fragmentation of Land Act, 1972 were pending before the revisional courts.

The UDYF leaders and supporters led a protest march from Spencer Junction to the assembly when the police blocked them in front of the War Memorial.Rahul and Firoz led the march highlighting the CM's controversial remark on Malappuram, the criminalisation of the police and also the ADGP-RSS meeting.

Initially, the police used water cannons against protesters from just one vehicle. But when the protesters numbering over 100 kept on throwing themselves against the barricades and hurling stones, footwear, sticks and even fruits, the police brought in a second water cannon and unleashed a jet of water at them.

The remanded women protesters include Muslim Youth League state secretary K Fathima Thahiliya, YC vice-president V K Shibina, YC state general secretaries Shamla Kasim and B S Subija, and YC Thiruvananthapuram district secretary Beena Mol. They were produced in court and sent to jail.

Cracker blast in Tiruppur house: Infant among three killed, 15 injured

TIRUPPUR. Three persons, including a 10month-old girl, were killed and 15 others injured on Tuesday after firecrackers, being illegally made for use in temple festivals, exploded inside a house in Pandian Nagar in Tiruppur town. Police have detained the house owner Karthik and his brother-in-law V Saravanakumar, the man behind the unauthorised cracker unit.

While two of the deceased were identified — Kumar (39) of Elumathur, in Nambiyur, Erode district and 10-month-old A Alia Shirin from Pandian Nagar — the third, a woman, remains unidentified. Police suspect she might be the wife of Kumar.

According to police, the two-floored house where the explosion took place is owned by Karthik from Ponnammal Nagar in Pandian Nagar. Three rooms on the first floor were rented out to knitwear workers from Bihar and Odisha. Karthik lived on the ground floor with his wife Sathyapriya and their

two college-going sons.

Karthik's brother-in-law Saravanakumar of Irungalur, in Nambiyur, Erode district, owns a firecracker manufacturing unit in the same area, sources said. According to the authorities, licence for the unit expired last December and Saravanakumar applied for renewal in July. However, he allegedly continued to manufacture firecrackers illegally and sold them for use in temple festivals in nearby villages, sources said. He used Karthik's house for this purpose and sent workers there everyday, they added.

On Tuesday morning, Karthik, his sons and the knitwear workers had gone out for the day, while Sathyapriya was at home. Kumar was engaged in making the firecrackers at the ground floor of the house when around 11.55 am they exploded. In the impact of the blast, the grocery story in front of the house was completely destroyed, and all houses



within 100m of the blast sustained damage. Thirumuruganpoondi police and fire and rescue services personnel from Tiruppur North and South stations rushed to the spot and embarked on rescue operations.

Kumar and Sathyapriya, who had been trapped were rescued after a two-hour effort. Both sustained serious injuries. Alia

Ahirwal show set to give Inderjit bigger say in state affairs

Gurgaon. He did not contest the assembly election, but proved he is the most powerful leader in the Ahirwal region.BJP's performance in the south Haryana districts of Gurgaon, Mahendergarh and Rewari where the party won 10 of 11 seats - once again highlighted Rao Inderjit Singh's influence over the region.According to political observers, nine of 11 candidates fielded here are believed to be close to the Inderjit camp. In the other two seats, BJP nominated heavyweight Rao Narbir Singh (Badshapur) and Abhe Singh Yadav (Nangal Chaudhry).

Yadav, according to analysts, lost Nangal Chaudhry despite being an MLA from there during the past two regimes. Internal rift is said to have hit him hard. Yadav is known to be close to former CM Manohar Lal Khattar.At 74, Inderjit, who has said earlier in meetings that "people want to see me as CM", is expected to be in the thick of things during govt formation.Inderjit, whose political career began in 1977, has won six of seven Lok Sabha elections. His close ties with the Yadav community, which comprises 55-60% of the electorate, has helped BJP win elections earlier too.BJP fielded Inderjit's daughter, Arti Singh Rao, from Ateli. Arti defeated BSP's Attar Lal by 3,085 votes. In Rewari, Laxman Yadav — another Inderjit ally — defeated Congress's Chiranjeev Rao, who is the son of Congress veteran Captain Ajay Singh Yadav.In the Narnaul assembly segment of Mahendergarh, BJP candidate Om Prakash Yadav emerged victorious for the third consecutive time. His win was also attributed to a strong campaign by loyalists of Inderjit.In Bawal, BJP was believed to have given preference to Dr Krishna Kumar over former minister Banwari Lal on Inderjit's insistence.

72-yr-old killed for asking man not to drink in park, 1 held

- Noida. Two months after a 72-year-old retired CDA officer was shot dead at a greenbelt near his residence in Greater Noida West, police have finally solved the blind murder case and arrested the accused on Tuesday. Police identified the accused as Malkit Singh, aka Loliya Don, a 32-year-old resident of Geeta Colony in Delhi who has a history of criminal activity
- Hari Prasad, who hailed from Agra, had retired as a senior auditor from the Controller of Defence (CDA) in 2015. At the time of the incident he was residing in Stellar Jeevan Society in Greater Noida West with his elder son, Praveen Kumar. Prasad had left home for his regular walk on Aug 7, when some of the guards spotted his body on a bench around noon.
- At the time, Prasad's family had no clue as to what could have happened. Over the course of the past two months, cops questioned over 60 people and checked CCTV footage from around 800 cameras to trace the suspect. Eventually, they were able to create a sketch of the accused based on witness accounts and available evidence, which finally led them to Singh.

According to DCP (Central Noida) Shakti Mohan Avasthy, Malkit Singh was passing by Surajpur when he stopped at the park near Prasad's society. He was consuming alcohol on a bench when Prasad approached him and told him to not drink there. Singh told cops Prasad hurled abuses at him and kicked his bottle, which enraged Singh. Singh approached Prasad from behind and shot him using a pistol he was carrying at the time. He then took Prasad's mobile phone and fled the spot. Police recovered Prasad's stolen phone along with the pistol and cartridges used in the crime from Singh's possession

Haryana election result: BJP takes Gurgaon 4-0 with 49% vote share

GURGAON. Waterlogging to waste, the city's festering civic problems did not show up in the assembly poll results on Tuesday, with BJP improving its tally from 3-1 in 2019 to a whitewash this time in the four assembly seats that are part of Gurgaon district. In doing so, BJP not nly wrested Badshapur, the largest constituency in Haryana which is also the main city seat, it also bagged 49% of the district's vote share, eight percentage points more than what it polled in 2019.BJP had also won Gurgaon 4-0 in 2014 when it formed the govt in Haryana for the first time.Congress managed to increase its vote share from just 8.5% in 2019 to 26.7% this time, but couldn't make a dent. Its Gurgaon candidate, in fact, finished third, behind a BJP rebel who contested as an Independent.In Badshapur — where the lack of civic infrastructure pinched the most - BJP heavyweight Rao Narbir Singh managed .4 lakh votes. He trumped Congress rival Vardhan Yadav by 60,705 votes.Badshapur, which had voted for Independent candidate Rakesh Daultabad in 2019, did not show the same support for his wife Kumudini Daultabad, who

joined the election fray after the death of her husband earlier this year.Kumudini managed the third place — with 30,885 votes. Congress, which received just 10,610 votes in Badshapur in 2019, jumped to 84,798 votes, but debutant Vardhan Yadav still ended up a distant second.For Congress, the contest was very different from that in the Lok Sabha polls merely four months ago, when it wrested five of 10 seats from BJP. In Gurgaon then, Congress's Raj Babbar ran Rao Inderjit Singh of BJP close, giving the party ample hope for the assembly election. But it ended in disappointment.

In the Gurgaon assembly seat, Congress was pushed to the third place. Mukesh Sharma of BJP received 1.2 lakh votes, defeating Independent candidate and party rebel Naveen Goel by 68,045 votes. Congress's Mohit Grover managed 46,947 votes.In Gurgaon, too, Congress doubled its vote share. The party garnered around 20,000 votes in the past state polls in 2019 and 2014. According to analysts,



both BJP and Congress would have had higher numbers were it not for Goel, who secured 54,570 votes.

In the run-up to the polls, Goel was a major cause for concern for BJP, which feared a considerable dent to its vote share from him.BJP's victory margin in Gurgaon seat was the highest among all four constituencies in the district.In Pataudi, Bimla Chaudhary of BJP received 98,519 vo- tes and trumped her nearest rival -

Congress's Pearl Choudhary — by 46,530 votes. Bimla took the lead from the morning itself, with the margin growing wider as the day progressed.Pearl secured 51,989 votes, nearly three times what the Congress candidate secured in 2019 (18,994).

In Sohna, political analysts had given Congress the upper hand during campaigning. But the results ended in favour of BJP here too, with Tejpal Tanwar defeating Congress rival Rohtas Khatana by 11,817

votes.Sohna witnessed a multicorner contest, which is believed to have helped BJP. Kalyan Singh, who contested as an independent after being denied a BJP ticket, received 21,703 votes and cut into the party's votes.But independent candidate Javed Ahmed (49,171) and BSP's Sunder Bhadana (15,454) are believed to have cut in Congress votes and helped BJP's cause. Congress, in Sohna, was at number 4 in 2019.

Tank water under scanner after 400 fall ill at condo, 10 kids in hosp

Noida: More than 400 residents of Supertech Ecovillage 2 in Greater Noida West, many of them children, fell ill allegedly after consuming contaminated water since Monday morning with many complaining of nausea, vomiting and diarrhoea. Residents claim the society's tanks were cleaned recently but suspect that chemicals may not have been flushed out properly, leading to widespread illness across the 12 towers of the society. There are around 3,500 residents in Ecovillage 2. The health department chipped in on Monday evening and set up a medical camp at the condominium after nearby pharmacies fell short of necessary medicines. Abhishek Singh, a resident of Tower C4, said his two-year-old son was admitted to intensive care at Yatharth Hospital after his health worsened on Tuesday morning. The child was taken to the hospital's OPD with a high-grade fever and nausea. "But his health deteriorated, and he began having seizures. So, the doctors at the hospital admitted him to ICU for special care," Singh said.Abhishek's son is not alone. Currently, more than 10 children are admitted to various hospitals. Abhiram Singh, who lives in Tower C3, said his three-year-old son has been suffering from diarrhoea, fever and nausea since Monday and has been admitted to Surbhi Hospital since.Surbhi Rawat, a resident of Tower C2, whose two-year-old son is in ICU, said the toddler was in extreme pain. "He was crying all day. What if something bad happens to him? Who will take the responsibility? How can these people be so irresponsible?" she asked. Dr Jetavya Kushwaha, a paediatrician who runs a clinic at the society's marketplace, told TOI that since Monday evening a significant number of children had come in for a consultation with a similar set of symptoms - loose motion and vomiting. A few also had high-grade fever."All the children were from Ecovillage 2. By Tuesday morning, the symptoms were also visible among adults. I am told many have visited local pharmacies and hospitals for consultation today," he said. Alok Singh, a resident of Tower C7, said his family of four endured discomfort throughout Monday night. "We usually don't eat anything from outside. On Monday too, dinner was homecooked and simple. But we all experienced a severe stomach ache and nausea. We consulted a doctor on Tuesday," he said. Initially, most families thought these were isolated cases of dysentery or other stomach ailments, but as messages started circulating on the society's WhatsApp group, they realised the source of the contamination could be common - water.YG Estate, a private firm that is responsible for the society's maintenance for the last four years, told TOI that their team inspected the water tanks in all the tow-

ers soon after residents' complaints started to pour in."The health department has collected water samples and sent them for testing. If any deficiency is found, it will be rectified. Action will also be taken against staffers if found negligent," Azeem, the society's maintenance team manager, said.GNIDA provides water to Ecovillage 2. With hundreds of residents switching to packaged water, many local shops and grocery delivery apps on Tuesday said they had run out of stock."As the water might be the source of contamination, I ordered two bottles of packaged water yesterday. But since this morning, due to heavy demand, the delivery apps have gone out of stock. We have no idea how to deal with

this situation. It is so traumatising," Mallika, a resident of B4 tower, told TOI. The homemaker said her eight-yearold daughter could not attend school for the last two days due to severe stomach ache. "Whatever I feed her, she is vomiting and crying. Since Monday, she has been on ORS and medicines," she added.Rajat, who lives in the same tower, said there has been complete chaos in the society since Tuesday morning.

After frog leg, now dead spider in samosa from RNE sweetshop

Ghaziabad. A man who had bought samosas from Shri Dhara Dairy, a local sweetshop in Ghaziabad's Raj Nagar Extension, allegedly found a dead spider in the fillings of the snack. Samples were collected by the Food and Drugs Safety Administration department on Tuesday.In a similar incident in Sept, a customer had allegedly found a 'frog's leg' stuffed inside a samosa he purchased from a popular sweet shop chain in Nyay Khand. Officials thoroughly examined the confectionery items and procured two samples for further analysis. "We have taken action against the owner for maintaining unsanitary conditions during food processing and manufacturing. We discovered flies swarming around the milk and curd products. We also imposed a fine on the shop owner, and a case will be filed against him in the ADM city court," said assistant food commissioner Arvind Yadav.

Soon, 3 multi-storey car parks to come up in city

Noida.Noida Authority is set to address the city's parking challenges by introducing an automated puzzle parking system— for the first time in the city— beginning with a facility outside its Sector 6 office. The first phase will feature a five-floor structure accommodating up to 50 vehicles. Following this, two additional multi-level facilities are planned for commercial areas, with a combined capacity of 100 vehicles. The automated puzzle parking system, designed to move cars up and down through a network of slots and stands, is expected to significantly reduce parking time. According to an official, "It will take only 3 to 6 minutes to park or retrieve a vehicle, compared to the 15 to 20 minutes required in traditional multi-level parking setups." Each floor of the five-floor system will hold five cars, maximizing space efficiency. The Authority has earmarked three locations for the project, near Fortis Hospital in Sector 62, outside its own office in Sector 6, and near Savitri Market in Sector 18. The compact design allows for a five- to six-floor parking facility to be constructed on minimal land. Additionally, the sensor-based system enhances security by reducing the risk of theft or damage to vehicles.Constructing each slot in the puzzle parking system will cost around Rs 8 lakh, with the total expenditure for a 50-slot facility estimated at Rs 4 crore. Since the system is fully automated, it will require minimal staffing.

7 killed after Israeli strikes hit residential building in Syria's Damascus

- Cairo. An Israeli airstrike targeted a residential building in the Mezuzah suburb west of the Syrian capital Damascus, killing seven civilians and injuring 11 others, Syrian state media reported on Tuesday.
- Preliminary reports said the seven civilians included women and children, state media reported citing a military source, adding it also caused "grave" material damage on private properties in surrounding areas.
- As per the cited source, the airstrike was conducted by three missiles coming from the direction of the Golan Heights. State media earlier reported that Syria's air defences had intercepted "hostile" targets in the vicinity of Damascus.Israel has been carrying out strikes against Iran-linked



targets in Syria for years but has ramped up such raids since last year's October 7 attack by Palestinian terrorist group Hamas on Israeli territory that sparked the Gaza war.

Ceasefire demand shows Hezbollah is on backfoot, getting battered: US

World Hezbollah's call for a ceasefire on Tuesday shows the militant group is on the back foot and "getting battered," US State Department spokesperson Matthew Miller told a regular briefing on Tuesday.Hezbollah's deputy leader Naim Qassem said in a televised address on Tuesday the Iran-backed group's capabilities were intact, and its fighters were pushing back Israeli ground incursions, despite the "painful blows" inflicted by Israel in recent weeks.Qassem said the group supported the efforts of Lebanon's Speaker of Parliament Nabih Berri, a Hezbollah ally, to secure a ceasefire, without providing further details on any conditions demanded by Hezbollah.For a year, you had the world calling for this ceasefire, you had Hezbollah refusing to agree to one, and now that Hezbollah is on the back foot and is getting battered, suddenly they've changed their tune and want a ceasefire," Miller said.

"We continue to ultimately want a diplomatic solution to this conflict," Miller said.Asked if the United States was talking to Berri about efforts in Lebanon to choose a new president, Miller said US officials were onversations with different players inside Lebanon, often through intermediaries."Those are ongoing," Miller said. "I don't think it's productive for me to read them out publicly.' Israel's offensive against Hezbollah in Lebanon has prompted a renewed bid by some Lebanese politicians to fill a two-year presidential vacuum, an effort to revive the paralyzed state as it grapples with an escalating conflict.

Brazil lifts ban on Elon Musk's X after complying with Supreme Court demands

Sao Paulo. The Brazilian Supreme Court's Justice Alexandre de Moraes on Tuesday authorised the restoration of social media platform Xôs service in Brazil, over a month after its nationwide shutdown, according to a court document that was made public.Elon Musk's X was blocked on August 30 in the highly online country of 213 million people - and one of X's biggest markets, with estimates of its user base ranging from 20 to 40 million. De Moraes ordered the shutdown after a months-long dispute with Musk over free speech, far-right accounts and misinformation. Musk had disparaged de Moraes, calling him an authoritarian and a censor, even though his rulings, including X's suspension, were repeatedly upheld by his peers.Despite Musk's public bravado, X ultimately complied with all of de Moraes' demands. They included blocking certain accounts from the platform, paying outstanding fines and naming a legal representative in the country. Failure to do the latter had triggered the suspension."The resumption of (X)'s activities on national territory was conditioned, solely, on full

compliance with Brazilian laws and absolute observance of the Judiciary's decisions, out of respect for national sovereignty," de Moraes said in the court document.

"X is proud to return to Brazil," the company said in a statement posted on its Global Government Affairs account. "Giving tens of millions of Brazilians access to our indispensable platform was paramount throughout this entire process. We will continue to defend freedom of speech, within the boundaries of the law, everywhere we

operate."Just two days before the ban, on August 28, X said it was removing all its remaining staff in Brazil "effective immediately," saying de Moraes had threatened with arrest its legal representative in the country, Rachel de Oliveira Villa Nova Conceiç£o, if X did not comply with orders to block accounts.Brazilian law requires foreign companies to have a local legal representative to receive notifications of court decisions and swiftly take any requisite action — particularly, in X's case, the



takedown of accounts. Conceiç£o was first named X's legal representative in April and resigned four months later. The company named her to the same job on September 20, according to the public filing with the Sao Paulo commercial registry.

In an apparent effort to shield Conceiç£o from potential violations by X — and risking arrest — a clause has been written into Conceic£o's new representation agreement that she must follow Brazilian law and court decisions, and that any legal responsibility she assumes on X's behalf requires prior

instruction from the company in writing, according to the company's filing.

As the second huge hurricane in as many weeks rumbled toward Florida's west coast, a sense of looming catastrophe spread as people raced to board up homes and flee."It's a matter of life and death, and that's not hyperbole," Biden said from the White House, urging those under orders to leave to "evacuate now, now, now."Biden's warning came amid a bitter pre-election quarrel, with his Democratic vice president Kamala Harris castigating her rival Donald Trump for peddling false claims that recovery efforts after the first storm, Hurricane Helene, were diverted away from Republicans.As of Tuesday, Milton returned to the maximum Category 5 designation, generating maximum sustained winds of 165 mph (270 kph), the National Hurricane Center said.

"Fluctuations in intensity are likely while Milton moves across the eastern Gulf of Mexico, but Milton is expected to be a dangerous major hurricane when it reaches the west-central coast of Florida Wednesday night," the NHC said.

- Federal Public Safety Secretary Omar Garcia Harfuch said four mayors requested protection on Monday, a day after Arcos' remains were found. The requests came from Guerrero and another violence-plagued state, Guanajuato. The situation in Guanajuato is



so bad that ahead of the country's June elections, at least four mayoral candidates were killed.Garcia Harfuch did not say why the mayors asked for protection. He also didn't give much detail on the investigations into Arcos' killing, saying only that the mayor had left his staff behind to attend a private meeting just before his death.Arcos had told local media he needed more protection, but Garcia Harfuch said no formal request had been received. State and federal governments can offer mayors bulletproof vehicles, additional bodyguards and emergency alert systems. The Prime Minister's appeal on Tuesday came hours after Israel expanded its ground operations in southern Lebanon, deploying more troops to begin "limited, localised, targeted operational activities" as part of the Jewish nation's 'Operation Northern Arrows' against Hezbollah.In his video address, Netanyahu said, "This is a message to the people of Lebanon. Do you remember when your country was called the pearl of the Middle East? I do. So, what happened to Lebanon? A gang of tyrants

and terrorists destroyed it. That's what happened.""Lebanon was once known for its tolerance, for its beauty. Today, it's a place of chaos, a place of war," he added.He also warned the people of Lebanon to save their nation "before it falls into the abyss of a



long war that will lead to destruction and suffering like we see in Gaza. It doesn't have to be that way"."Now you, the Lebanese people, you stand at a significant crossroads. It is your choice. You can now take back your country. You can return it to a path of

peace and prosperity. If you don't, Hezbollah will continue to try to fight Israel from densely populated areas at your expense. It doesn't care it Lebanon is dragged into a wider war."He also reiterated his vow to eliminate Hezbollah and claimed tc have killed thousands of its militants. including former chief Hassan Nasrallah and his likely successors." Israel has decided to put an end to this. We've decided to do whatever is necessary to return our people safely to their homes. Israel has a right to defend itself. Israel also has a

right to win! And Israel will win."Hezbollah however, has remained defiant despite Israel's steady advances and unabated strikes against Lebanon since the past three weeks that have led to deaths of over 1,400 people and displaced another 1.2 million.

US scrambled to urge Putin not to use nuclear weapons in Ukraine, Woodward book says

WASHINGTON. Months into Russia's war in Ukraine, the United States had intelligence pointing to "highly sensitive, credible conversations inside the Kremlin" that President Vladimir Putin was seriously considering using nuclear weapons to avoid major battlefield losses, journalist Bob Woodward reported in his new book, "War."

The US intelligence pointed to a 50% chance that Putin would use tactical nukes if Ukrainian forces surrounded 30,000 Russian troops in the southern city of Kherson, the book says. Just months before, in the far northeast, Ukrainian troops had stunned the Russians by recapturing Kharkiv, Ukraine's second-largest city, and were pivoting to liberate Kherson, strategically located on the Dnieper River not far from the Black Sea.National security adviser Jake Sullivan stared "with dread" at the intelligence assessment described as coming from the best sources and methods — in late September 2022, seven months after Russia's invasion, the book says. It caused alarm across the Biden administration, moving the chance of Russia using nukes up from 5% to 10% to now 50%. According to Woodward's account, President Joe Biden told Sullivan to "get on the line with the Russians. Tell them what we will do in response."He said to use language that was threatening but not too strong, the book says. Biden also reached out to Putin directly in a message, warning of the "catastrophic consequences" if Russia used nuclear weapons. The famed Watergate



reporter's latest book also details Donald Trump's conversations with Putin since leaving office, Biden's frustrations with Israeli Prime Minister Benjamin Netanyahu and more. The Associated Press obtained an

early copy of Woodward's book, which is due out next week. The book provides intriguing inside details about the U.S. assessment of the possibility of Putin deploying nukes, but the Biden administration's concerns that Russia might use tactical nuclear weapons in Ukraine were not secret. From the president on down, numerous officials warned Putin against it.

Putin and other Kremlin voices also have frequently threatened the West with Russia's nuclear arsenal. In a strong, new warning to the West late last month, Putin said any nation's conventional attack on Russia that is supported by a nuclear power will be considered a joint attack on his country

Wait ends, Cauvery Stage V launch on Oct 16



BENGALURU. The Stage V of the Cauvery project, which will supply drinking water to 110 villages under the Bruhat Bengaluru Mahanagara Palike (BBMP), will be inaugurated by Chief Minister Siddaramaiah on October 16, said DCM DK Shivakumar. This project has been undertaken at a cost of Rs 4,336 crore in partnership with Japan International Cooperation Agency (JICA). It can be recalled that in 2014, the government led by Chief Minister Siddaramaiah formulated and launched this project to provide adequate water to the villages newly added to Bengaluru. This project will supply additional 775 MLD of water to Bengaluru city and Cauvery water will be supplied to every corner. "50 lakh people will benefit from this," said Shivakumar.

Bengaluru Water Supply and Sewerage Board (BWSSB) Chairman Ram Prasat Manohar personally gave an invite and invited the CM. DCM said that he personally visited TK Halli recently, and gave necessary suggestions and instructions to the authorities for the speedy implementation of the said project. He said that Cauvery water will be adequately supplied to the houses of various villages of Bommanahalli, Byatarayanapura, KR Puram, Mahadevapura and RR Nagar assembly constituencies.

Court on Tuesday sentenced a 62-year-old man to 35 years of rigorous imprisonment for the sexual abuse of the five-year-old granddaughter of his younger brother.

Delivering the sentence, Justice R Rekha handed him a combined jail term of 102 vears under various sections, which shall run concurrently. The court also imposed a total fine of Rs 1.05 lakh. The judgment stated that the actions of the accused were extremely cruel, deserving no mercy. Given the nature of the crime, the judge emphasised that the accused must face the maximum possible punishment. The court ordered that the fine amount be given to the child. Or else, the accused will have to serve an additional two years and three months in prison, the judgment said.

The incident that led to the case happened

between November 2020 and February 2021. The accused is the elder brother of the child's maternal grandfather. The crime happened when the child visited the accused's house to play, during which he assaulted the child on three separate occasions. When the child cried in pain, the accused threatened her with further

her saying to her friends about the misdeeds of the accused. On further questioning, the child revealed the abuse. When the grandmother examined the child, she found severe injuries. The family immediately consulted a doctor and informed the Kadinamkulam police. The medical examination confirmed the injuries.Special Public Prosecutor R S Vijay Mohan and Advocate R Y Akhilesh represented the prosecution. They examined 14 witnesses and submitted 24 documents and three pieces of evidence. Sub Inspector Deepu K S and Inspector Bins Joseph from the Kadinamkulam police station carried out the investigation. The court also directed the Legal Services Authority to provide the child compensation.

KOCHI. What if a senior citizen goes out alone and suddenly becomes unconscious or develops a serious health issue? The Kochi corporation is planning to roll out Near Field Communicationenabled (NFC) Emergency Identity cards for the geriatric population in the city to help the elderly avail quick help in such situations.

As per the project blueprint, which has been developed by the corporation in association with voluntary organisations such as MAGICS and the Indian Medical Association (IMA), the speciallydesigned emergency identity cards can be used to store medical and contact information of senior citizens, which medical professionals can access in an emergency."The project is part of the agefriendly initiatives being implemented by the Kochi corporation, which goes a long way in making the life of senior citizens hassle-free. It now awaits the nod of the steering committee and the council," Mayor M Anilkumar said.

The NFC technology-enabled identity cards will also be helpful for those suffering from diseases like dementia. In normal situations, anybody can rush a senior citizen to a nearby hospital but the medical professionals would not know their medical history or the medicines they are taking or whether they are allergic to a particular medicine," said Dr Praveen G Pai, chairman, MAGICS NGO.

The Centre of Excellence for Developing Age-Friendly Communities (CEDAC), functioning under the corporation, is slated to implement the first-of its kind initiative in the country. "The project is in the pilot phase, with the NFC cards being provided to 100 persons, including councillors, to test the functional efficacy" he said.Explaining the functioning, Dr Praveen said all the details in the identity card can be accessed when the card comes in contact with a smartphone

'NFC technology enables the same. We're using the existing technology appropriately to extend care to senior citizens. Directions for the use of the cards will be written on them. Also, the information stored can be updated anytime. It will also help the police contact the relatives of such patients," he added.

Karnataka HC: Placing undertrial in 'andheri cell' unknown

BENGALURU. The Karnataka High Court observed that the axe that needed to have fallen on actor Darshan for allegedly sitting with a rowdy, Wilson Garden Naga and others, sipping coffee and smoking a cigarette in the Central prison in Bengaluru, had been extended to another accused, Pradosh S Rao, in the Renukaswamy murder case, though he was away from the company. The court directed the prison authorities to shift him from Belagavi Central Prison's 'andheri cell' to Central Prison in Bengaluru.

Placing an undertrial prisoner in such a cell is unknown to law, unless grave circumstances are ensured. Shifting of undertrial prisoners cannot be at the whim and fancy of the prosecution and such orders, when sought, magistrates ought to apply their mind. If shifting had to be done at all, it could be shifting of Darshan, as he was at the scene, in the company of others, sipping coffee and holding a cigarette. The petitioner, who is away in some cell, is Quashing the order, Justice M Nagaprasanna penalised for Darshan's act," said Justice M Nagaprasanna. It was alleged that

China ups the nuclear ante

FOR some time now, China has been signalling a change in its nuclear weapon policy. It usually makes no announcements or declarations. But, on September 25 — for the first time since 1980 - China tested a long-range strategic missile whose dummy warhead landed in the South Pacific Ocean, near the city of Bora Bora in French Polynesia, over 12,000 km away. In this case, China actually announced the test and provided the required notification to the sea and air traffic control. Most Chinese missile tests take place within Chinese territory, with missiles being fired into the Taklamakan desert in Xinjiang.According to the Chinese, the missile fired by the People's Liberation Army Rocket Force (PLARF) was part of a "routine arrangement in our annual training plan" and fell in an 'expected area' in the sea. The statement said it was "in line with international law and said it was "in line with international law and international practice, and is not directed at any specific country or target."

They said they had notified countries concerned about the test in advance and it was confirmed by the Philippine authorities that two NOTAMs (notice to airmen — sea and air navigational warnings) were issued prior to the launch. Analysts said the missile was in all likelihood fired from the Hainan region and passed through north of the Philippines. The US said it had received "some advanced notification" of the test. Japan complained that it had not been warned about it. The missile in question could be the DF-31AG, China's long-range weapon that can reach targets in the US. It is capable of being fired from mobile transporter-erector-launcher systems. There is a great deal of speculation as to why the Chinese conducted the test the way they did. It came amidst rising tensions among Japan, the Philippines, China and the US. Chinese and Philippine vessels have been involved in multiple collisions near Sabina Shoal, just 86 km from the Philippines' west coast; in June, there was an encounter at the Second Thomas Shoal nearby.Another factor may have been the recent US decision to deploy its new mid-range missile system known as the Typhon in the Philippines for an exercise; according to reports, the system remains deployed there. This may also be related to the large-scale purges that shook the Chinese rocket force on account of corruption. Last December, China had announced the dismissal of nine senior military officials of the PLA, many of them senior officers of the PLARF, for "serious violations of law and discipline"—a phrase used to refer to corruption. So, this could be seen as a reassurance of sorts for the Chinese public.Officially, China maintains a "no first use" policy relating to nuclear weapons, which it announced at the time of its first nuclear test in 1964. It has since reaffirmed this in its 2015 and 2019 defence white papers. India, too, has such a policy, which is based on not being the first to initiate a nuclear strike, and relying on the concept of assured retaliation.But unlike India, China has been expanding its nuclear arsenal rapidly. The 2023 China military power report of the US said Beijing had 500 operational nuclear warheads in May last year as compared to 400 the year before. The US believes that China will have more than 1,000 warheads by 2030 and is accelerating its intercontinental range ballistic missile programme. The US had disclosed the size of American holdings as of September 2023 -3,748 warheads that are in the process of being modernised. According to the Pentagon, the PLA is implementing a Launch-on-Warning posture under which a warning of a strike leads to a

How the IAF has strengthened India's strategic edge

As the IAF celebrates its 92nd anniversary, the challenges it faces include increasing combat potential.

AS the IAF completes another year of service to the nation, it is time to reflect on its achievements over the past year and the challenges that lie ahead as it moves forward in its centennial decade.

With just six aircraft and a handful of 'Hawai Sepoys' or 'airmen', the Indian Air Force took birth on October 8, 1932, just about two decades after the first manned airplane flight. The ninety-first anniversary of the IAF was celebrated at Prayagraj on October 8 last year, with an air power display and an impressive parade that mesmerised the audience in Allahabad, which is also home to the Central Command of the IAF.

In keeping with its recent tradition of dedicating a theme for itself every year to focus on its operational preparedness and training, the IAF had decided on 'Air Power Beyond Boundaries' for itself for the year 2023-24.On the Air Force Day last year, flashfloods in the Teesta river caused mayhem and destruction across Sikkim and West Bengal, disrupting communications, destroying roads and other infrastructure and leading to loss of precious lives across the two states. The IAF promptly swung into action, deploying its Chinook and Mi 17-1V helicopters, carrying out rescue and relief operations, dropping medicines, essential supplies and communication equipment and using its Garud commandos to facilitate the evacuation of more than 1,700 people, including tourists and foreign nationals.From November 12 to 28 last year, in response

to the Silkyara tunnel collapse in Uttarakhand, the IAF deployed its heavy lift C-17 Globemaster and C-130J Hercules aircraft to transport equipment and personnel, apart from Mi 17 and Chinook helicopters to evacuate rescued personnel to the nearest medical facility.


erving as the first responder when an earthquake struck Nepal in the first week of November 2023, the IAF launched a C-130J Hercules aircraft with essential supplies, providing medicines, relief material and trained personnel to assist in disaster relief. India also provided more than 70 tonnes of humanitarian aid and relief material to the people affected by the ongoing Israel-Hamas conflict by sending two C-17 aircraft on October 22 and November 19, 2023; these landed at the El-Arish airbase in Egypt, close to the Rafah border crossing between Egypt and the Gaza strip.Last year, the IAF participated in various bilateral and multilateral exercises — from Red Flag in the USA to Eastern Bridge with Oman, Pitch Black with Australia, Udara Shakti with Malaysia, Garuda with France and Desert Knight with UAE. All these exercises had other air forces participating, along with the forces from the host countries. The eagerness for the air forces of the countries across the world to participate in exercises with the IAF



bears testimony to its professional acumen and the growing heft of India as a nation in the emerging world order. The IAF also carried out Exercise Vayushakti on February 17, 2024, at the Pokhran range wherein it demonstrated its offensive capability by carrying out live firing that was witnessed by a diverse audience comprising the diplomatic corps of friendly foreign countries. The exercise witnessed the participation of the indigenous Tejas Mk1 aircraft and Dhruv and Prachand helicopters, apart from Jaguars, Rafale, Mig 29, Su 30 MKI, Mirage 2000, Hawk, C-130J, Apache and Chinook, which carried out day and night operations. Our indigenous surface-to-air weapon systems -Akaash and Samar - demonstrated their ability to track and shoot down intruding aircraft. It demonstrated the ability of the IAF to deliver weapons with precision on designated targets simultaneously from a number of bases.Under Exercise Gagan Shakti 2024, which commenced on April 1 this year, the entire air force was mobilised for operational contingencies in two phases, simulating the emergence of threats that might emerge from a two-front situation. With extensive flying day and night, with large force engagement exercises, the IAF tested all the key features of airpower: speed, precision, flexibility, reach and responsiveness, along with sustaining a high tempo of operations 24x7 for 10 days.The IAF successfully carried out the largest multilateral exercise 'Tarang Shakti 2024' that witnessed the participation of 11 countries with their flying assets and 27 countries as observers from nations representing all the continents. The exercise was carried out in two phases at Sulur and Jodhpur air bases and more than

Local solutions are key to global challenges The 21st century paradigm of governance has too much 'I' and too little 'we' and too many silos, with too little collaboration.

THE United Nations, set up after World War II to prevent further wars, has failed to prevent the Governance jurisdictions have been redrawn over the unfolding carnage in West Asia, which could lead to another world war. The World Bank, IMF and WTO have been unable to solve the global problems of climate change and inequitable finance and trade systems. The present architecture of the global institutions is based on the principle of vertical hierarchical control. Powerful nations on the top set the rules for the economic, political and environmental management systems around the world.A new architecture is required. It should be based on the principles of local management of complex systems and lateral cooperation among stakeholders to solve systemic problems that cross the boundaries of nations and cities.

Various combinations of the following three forces are leading to the breakdown of the governance systems: the concept of the sovereignty of the national governments, which is enshrined in the UN Charter; the rise of individual rights as an ideology; and the pressures of the global problems of climate change and societal and economic pathologies represented in the Sustainable Development Goals (SDGs), which cut across national boundaries.

The misalignment of the boundaries of the natural environmental systems, ethno-cultural social systems and constitutional governance systems is the root cause of the breakdown of global governance. Oceans separate continents and within the large Euro-Asian land mass, mountain ranges isolate the Indian subcontinent. The river systems on the continents define other natural boundaries. Ethno-cultural civilisational systems correspond roughly with these natural geographies.

centuries, crossing natural boundaries following wars spurred by religious and ethnic differences and ambitions of competing leaders. The seventeenth century Westphalian Peace Treaty sought to end wars in Europe by establishing the principle of inviolable national boundaries. The UN Charter is founded on this principle, according to which, countries should not interfere in others' internal affairs.Nevertheless, since the founding of the UN, western powers have created new countries which do not correspond with the natural geographical and ethno-cultural boundaries. For example, Pakistan and India, and Israel and Palestine.

Others, like Yugoslavia and Sudan, have been divided in attempts to align governance with ethnocultural realities. A war is underway to create new boundaries between the Ukrainians and Russians. The break-up of nations is justified by the principle of preservation of historical identities and the rights of all people to become what they want to be. Individual rights can translate into extreme liberalism, when individuals are given the freedom to change their histories and be whoever they like to be, including whatever sex they choose. 'I' can never be separated from 'we', as the African expression 'ubuntu' says ('I am because you are'). Individual identities cannot be divorced from the collective identities. The rights of individuals cannot be separated from the rights of the collectives in which they live.

The wellbeing of individuals depends on the wellbeing of their societies and environments.

Medical science has established that social and environmental conditions impact the health of individuals significantly. Bringing about improvements in social and environmental conditions is a less costly and more sustainable



solution for improving the citizens' health than doing so by the high-tech medical solutions focused on the biology of individuals.

These scientific insights call for changes in the designs of public policies and measurements of their outcomes. The policies should focus on the interventions in the conditions of social, environmental and economic systems in which citizens live rather than on the benefits to individuals. The impacts of public policies should be measured by how much they strengthen the local communities rather than by counting the individual beneficiaries of the government and philanthropy programmes. The top-down institutional structure of governance has failed because it is not based on the systemic view of the global problems. There are 17 SDGs. They are interlinked. None can be solved by itself. Moreover, they are not manifested in the same way everywhere. The problems of

environment and climate are not the same in Alaska and Barbados, nor in Uttarakhand and Kerala. The livelihood problems of the slums of New York are different from those of rural Bihar. Therefore, all problems must be solved locally.Forecasters estimate that the SDGs will be achieved only by 2087 if we persist with the present top-down and siloed approach of problem-solving. The aim was to achieve them by 2030. Everywhere, problems of at least seven of the 17 SDGs must be solved urgently. Let's do the maths. There can be 94 million different combinations of seven problems from a set of 17! Clearly, the one-size solutions developed by global climate scientists and health experts will not fit the local realities everywhere.

The 21st century paradigm of governance has too much 'I' and too little 'we' and too many silos, with too little collaboration. The prevalent way of organising on scale breaks up the systemic problems into parts, to be managed by specialists. Solutions arrived at in silos often harm the other parts of the system. Solutions to grow the economy with manmade infrastructure destroy the environment. Solutions for increasing the productivity of agriculture by applying more chemicals and replacing farmers with machines reduce the productivity of the soil. So, more chemicals are required, in a deathly spiral for the earth.

Not too far from Gorumara National Park lies Chapramari Wildlife Sanctuary, another hidden treasure of Dooars. A drive through some of the verdant tea gardens in the undulating plains of Dooars will take you to Chapramari. The area derives its name from two words-chapra (referring to a variety of fish found in north Bengal) and mari (meaning plenty). Covering an area of 9.6 sq km, the sanctuary boasts of a diverse range of flora and fauna that delights nature lovers.

Chapramari was declared a national reserve forest in 1895 and later, renamed as a wildlife reserve in 1939. After a few decades, in 1998, it was designated a wildlife sanctuary. The region is famous for its elephants that can be spotted easily. In addition, gaur is commonly found here. The sanctuary is also inhabited by Royal Bengal tiger, boars, deer, leopard, reptiles and various other animals. If you love birdwatching, do remember to carry a pair of binoculars to catch a glimpse of colourful birds like parrot, kingfisher and green pigeon, among many others. For accommodation, there are just a few options available in the area. Hence, whenever you visit Dooars, spend some time in this peaceful retreat in the foothills of the mighty Himalayas.

Buxa Tiger Reserve

A beautiful location in the lap of nature interspersed with the River Jayanti, mountains and dense forests-that's Buxa for you. The area is however more popular for Buxa Tiger Reserve, which is one of its kind in eastern Himalayas. Situated in Alipurduar, the reserve actually consists of the former Buxa Forest Division and a part of the Cooch

Behar Forest Division. It was set up in the year 1983 and was given the status of a national park in 1992.

The reserve's rich biodiversity has been attracting tourists for years now and has become a popular escape for tired souls who love to relax in the lap of nature. The area, approximately 760 sq km, encompasses a mix of different types of forests-riverine, savannah, evergreen, sal and others. The topography and climate not only supports a rich variety of plant species but also animals. Visitors can spot mammals, reptiles, amphibians and fishes, such as tigers, civets, red jungle fowls, leopards, elephants, gaurs, porcupines, rhesus macaque, mahseer, tortoise and butterflies.

Buxa is also an absolute delight for birdwatchers. Birds like red stars, wagtails, fork-tails, ibisbill, great pied hornbills, and the trans-Himalayan migratory goosander can be spotted here. A number of migratory birds too make Buxa their temporary home, such as gargani teal, common teal, white-eyed pochard and the large whistling teal at the Narathali Lake. The black-necked crane, which is a rarity in India, can be spotted in Buxa during winters. Besides, visitors can also explore other attractions of the region, such as



A fun way to witness the wilderness of Jaldapara National Park is by elephant safari. Another way to explore the flora and fauna of the region is to opt for jeep safari. For a close encounter, you can climb any of the many watchtowers in the park. Delhi: The Central Bureau of Investigation (CBI) chargesheet filed in the rape and murder case of a second year post graduate trainee doctor at Kolkata's RG Kar Medical College and Hospital has detailed the circumstances, nature of injuries, cause of death and evidence available against the accused. The CBI had on Tuesday submitted the chargesheet at a special court in Sealdah. It charged Sanjoy Roy, who used to work with Kolkata Police as a contractual staff, with the rape and murder of the on-duty woman doctor. The statements of about 200 people were recorded in the chargesheet, according to CBI sources. As detailed in the chargesheet, the CBI has largely followed the Kolkata Police's line of investigation and has relied on digital and material evidence collected by them along with to establish Sanjoy Roy's presence at the scene of crime at the time of the alleged rape-murder. CCTV footage has been used to establish the timings of his movement from 3.34 am onwards on the day of the crime (August 9), when he was seen at the entrance of the trauma centre building.

- At 4.03 am, the accused was seen "wearing a T-shirt and jeans, holding a helmet in his left hand with Bluetooth neckband earphones around his neck, moving from the right side of the camera towards the ward", as per the CBI chargesheet. At 4.32 am, he was seen emerging from the ward on the third floor, helmet in his left hand, but without the neckband earphones around his neckThe CBI further mentioned, "A Bluetooth neckband earphone was seized by local police from the scene of crime on 09.08.2024." This was used as a crucial piece of evidence by the Kolkata Police to nail and arrest Sanjoy Roy a day after the crime. The Customer Acquisition Form and Call Detail Records of the mobile number belonging to Sanjoy Roy also corroborated his presence at the hospital at the time of the crime, as per the chargesheet.
- Apart from earphones, physical evidence listed by the CBI included the victim's mobile phone and laptop, accused's mobile, accused's blood sample and blood and viscera examined during the autopsy. The chargesheet said the evidence was sent to the Central Forensic Science Laboratory Kolkata, New Delhi and Chandigarh. Further, forensic experts studied jeans, underwear, brassiere, kurti, blanket, bedsheets, a piece of cloth, synthetic cotton, nail cuttings and scrappings, blood sample, lip swab, endocervical swab, vaginal swab and pubic hair combing.

The victim then receives a video call from an individual posing as a police officer, who demands sensitive information like Aadhaar details and PAN card number. Exploiting fears of legal repercussions, the victim is then asked to transfer money. Once it is done, the fraudsters disappear. In certain cases, the victims are "digitally arrested", where they are forced to stay visible over video calls with the fake police officer until the money is transferred. The whole operation is done meticulously. The scammers also use studios to replicate police stations or government offices. They also wear uniforms similar to those of police officers.

Stock market rally: Sensex surges 600 points as RBI holds repo rate

New Delhi. Benchmark stock market indices rallied after RBI Governor Shaktikanta Das announced the monetary policy committee decision to keep key interest rates unchanged for the 10th consecutive time on Wednesday.

The S&P BSE Sensex added 591.46 points to 82,225.81, while the NIfty50 gained 197 points to 25,210.15 as of 10:55 AM.The Reserve Bank of India (RBI) has adjusted its stance to a neutral position. Shaktikanta Das said five members of the 6-member MPC voted in favour of keeping the policy repo rate unchanged at 6.5%.After evaluating the macroeconomic conditions and future outlook, the Monetary Policy Committee (MPC) decided, with 5 out of 6 members in agreement, to maintain the policy rate at 6.5%," he said.

Anu Aggarwal, Head of Corporate Banking, Kotak Mahindra Bank said that the RBI's shift to a 'neutral' stance marks a pivotal step in its approach, providing more flexibility in navigating the evolving economic conditions. With food inflation easing and the monsoon being favourable, this change signals optimism for India's inflation outlook. Globally, trends such as the US Federal Reserve's rate cut and easing monetary policies further support this shift. By adopting a more neutral position, the RBI is positioning itself to respond dynamically to future developments, while continuing to foster economic stability and long-term business confidence," she added.

New Delhi. Precious metals showed mixed trends in the Indian markets today. Gold is trading on the lower side of the Multi Commodity Exchange (MCX) while silver prices have recorded a hike on Wednesday, October 9.

A driver's test for autonomous vehicles A leading expert says US should have one

ANN ARBOR, Mich. At a time of growing concern about the safety of self-driving vehicles, a leading expert is calling on the federal government to develop a national driver's test that such vehicles would have to pass before they could travel on public roads. Such a regulation would set minimum standards to ensure that the vehicles display basic skills and competence in traffic situations where their manufacturers want to use them, said Henry Liu, who leads the University of Michigan's autonomous vehicle testing center. "Ensuring safety is important for consumers, for autonomous vehicle developers, for the federal government as well," Liu said in an interview. "The federal government has the responsibility to help set the minimum standard, to help provide guidance in terms of safety testing."

In recent years, autonomous vehicles have been involved in a number of high-profile crashes, and surveys have revealed widespread public uncertainty about their safety. Successful testing of the vehicles' ability to master a variety of traffic



situations, Liu suggested, would strengthen the public's confidence in them.Liu said significant research is still needed before autonomous vehicles could be rolled out safely nationwide. But he said he agreed with their manufacturers that in the long run, selfdriving vehicles could potentially save lives and improve the efficiency of the nation's transportation system.At present, no specific federal regulations cover self-driving vehicles, and only a few states have their own such requirements. The National Highway

Traffic Safety Administration, which is part of the Department of Transportation, has been gathering data about crashes involving autonomous vehicles. But it has so far issued only voluntary guidelines that don't include driving tests. Messages were left Tuesday seeking comment from the Transportation Department.Self-driving cars still must meet federal safety standards that apply to all passenger vehicles, which means the government investigates them only after serious incidents."Our current safety regulation for vehicles is reactive, so we depend upon self-regulation," Liu said.At the University of Michigan testing center, Liu runs a mock town, called Mcity, containing a traffic light and a roundabout that is used by companies and the government to test self-driving vehicles.A regulation, or perhaps a voluntary test, is needed because "we don't want to create a public hazard," said Liu, who made his remarks Tuesday and announced that Mcity can now be used by researchers remotely.Liu suggested that a

driver's test should be able to determine whether a self-driving vehicle can make a left turn at an intersection without the protection of a traffic light with a green arrow. He said it should also ensure that the vehicle will halt at a stop sign and detect and yield to a small pedestrian crossing a road.A test, he said, would prevent a poorly performing robot vehicle from being turned loose on society, much as a human driver's test would keep an incompetent driver off the road. But he acknowledged that no test could prevent all crashes involving self-driving vehicles.

The driver's tests, Liu said, would help robot vehicle developers "so that when they are moving in to deploy into the US, into certain cities, they will face less resistance from the cities."Tesla CEO Elon Musk has long complained that federal regulation is impeding innovation. Tesla is developing a robotaxi system called "Full Self-Driving," but the robotaxis cannot drive themselves, and Tesla owners who use them must be ready to intervene at any time.

She pointed out the diverging trends between wholesale mandi prices and retail prices are indicative of increasingly unwarranted margins that retailers are extracting out of the market dynamics."The trends are being closely tracked

The rudder rollout guidance actuator helps align an airplane's rudder with its nose wheel during takeoff and landing.

New Delhi The Reserve Bank of India (RBI) announced significant changes to the Unified Payments Interface (UPI) system during its latest Monetary Policy Committee (MPC) meeting. The central bank raised the transaction limits for two key UPI services—UPI 123Pay and UPI Lite—offering more convenience for millions of users."UPI has transformed India's financial landscape by making digital payments accessible and inclusive through continuous innovation and adaptation. To further encourage

wider adoption of UPI and make it more inclusive, it has been decided to enhance the per-transaction limit in UPI123Pay from Rs 5,000 to Rs 10,000; and increase the UPI Lite wallet limit from Rs 2,000 to Rs 5,000 and pertransaction limit from Rs 500 to Rs 1,000," said RBI Governor Shaktikanta Das.The RBI has increased the pertransaction limit for UPI 123Pay from Rs 5,000 to Rs 10,000, doubling the cap for feature phone users. Additionally, the limit for UPI Lite wallets has been raised from Rs 2,000 to Rs 5,000, aimed at simplifying small-value digital transactions for users. These moves are designed to improve the accessibility and efficiency of digital payments across the country, particularly for those without smartphones or access to high-speed internet.

What is UPI 123Pay?

Launched in March 2022, UPI 123Pay was created by the RBI and the National Payments Corporation of India (NPCI) to help the 400 million feature phone users in India access digital payments. Unlike regular UPI services, which



require smartphones and internet access, UPI 123Pay enables users with feature phones to make transactions through simple methods. This innovation supports the government's goal of financial inclusion by providing digital payment solutions for a larger population.UPI 123Pay works through four methods:IVR (Interactive Voice Response): Users can call a pre-set number and follow voice prompts in multiple languages to complete a payment.Missed Call Transactions: Users place a missed call to a merchantspecific number. They receive a call back to authenticate the payment using a UPI PIN.App-based Payments for Feature Phones: A simplified UPI app that

provides basic functionalities, such as sending and receiving money.Proximity Sound-based Payments: This feature allows users to tap their phone on a merchant device, using sound waves to facilitate contactless payments. How to Set Up UPI 123Pay

Feature phone users can set up UPI 123Pay by dialing *99#, choosing

their bank, and following the instructions to link their account. Users will need their debit card details to create a UPI PIN, after which they can start making secure, internet-free transactions.

UPI Lite was introduced to make smallvalue transactions more convenient. With the wallet limit now increased to Rs 5,000, users can store money directly on their devices. This feature eliminates the need to access a bank server for every transaction, speeding up payments for everyday purchases, such as groceries or transport fares. UPI Lite is expected to make frequent small transactions easier, especially in areas with limited internet connectivity.

Liverpool's Ibrahim Konate ready to support player strike over hectic schedule

Liverpool defender Ibrahim Konate has become the latest player to support a strike over the hectic football schedule. The ongoing season has seen an increase in games due to the remodelled European competitions and international matches.

New Delhi. France and Liverpool defender Ibrahima Konaté has joined the growing chorus of footballers voicing concerns over the increasingly congested fixture schedule, stating on Tuesday that he supports players' right to strike over the issue. His comments follow similar warnings from other top players and managers who have been critical of the relentless football calendar.

Last month, Manchester City's Rodri hinted that footballers could stage a strike if scheduling demands were not reduced. Shortly after his remarks, Rodri sustained a season-ending anterior cruciate ligament injury, further intensifying discussions about player welfare and the risks posed by such a gruelling schedule. Speaking to the



reporters, as quoted by Reuters, the Liverpool defender said that the players will be together if there is a strike."If this dynamic continues and the players decide to bang their fists on the table then we're all in this together," Konate, 25, told reporters when asked about whether he supported a strike."If tomorrow there's a movement that will lead to understanding, I'll be part of it. And I think all the players will follow suit."

This season, all three major European club competitions have been expanded to include 36 teams, exacerbating the situation. In July, global soccer players' union FIFPRO announced it would lodge a complaint with EU antitrust regulators, challenging FIFA's international match calendar.

England leads European leagues in terms of back-to-back fixtures, recording 87 last season, with Premier League teams averaging just 67.3 hours of recovery time between matches—one of the shortest in Europe.Konate felt that the hectic schedule is a subject that shouldn't be neglected as there is often news of clubs not wanting players to report to national duty as there is a fear of injury."It's a subject that shouldn't be neglected," Konate added. "You hear some clubs prefer their players to (not report for international duty) but you have to understand that too, there are so many games.

'The players are on the club's payroll, even if the national teams are just as important."

Once the current international break comes to an end, Konate and Liverpool will be in action in 7 games across 3 competitions with tough matches against Chelsea, Arsenal, Aston Villa lined up in the Premier League and Champions League games against Leipzig and Leverkusen.
