Civil defence volunteers to be re-engaged for anti-pollution measures from this week: Delhi CM

New Delhi, Nov 03: New Delhi, Delhi Chief Minister Atishi on Sunday announced

that the deployment of 10,000 civil defence volunteers removed as bus marshals last year will begin in the next 2-4 days to assist various agencies fighting air pollution. 'Consider Muslim sentiments': Jamiat to TDP, JD(U) on Waqf (Amendment) Bill

New Delhi, Nov 03: Jamiat chief Maulana Arshad Madani warned that if the legislation passes, the "two crutches" supporting the BJP-led government will face accountability. It also warned that if the legislation is passed, the "two crutches" supporting the BJP-led government at the Centre will not be able to evade responsibility. Jamiat chief Maulana Arshad Madani made this statement at the 'Save Constitution Convention' organised by the prominent Muslim group at the Indira Gandhi Indoor Stadium. Madani said that the people of the country defeated the BJP by rejecting their policies. He mentioned that the government depends on two crutches, one is Chandrababu Naidu, and the



other is Nitish Kumar from Bihar. Madani claimed that vice president, Nawab Jan. He expressed a positive view, believing that Jan would convey the sentiments of the large gathering of Jamiat functionaries and supporters present. "If the Waqf Bill is passed ignoring the emotions of the Muslims - it would be as much a responsibility of the crutches as it would be of other powers at the Centre," PTI quoted Madani as saying. The Jamiat has announced plans to organise a gathering of approximately five lakh Muslims in Chandrababu Naidu's constituency by the end of this month or in December, where they will present the concerns and sentiments of the Muslim community in detail. "If this bill is passed, the crutches on which the government is dependent would not be able to escape responsibility for it," he reiterated. Madani said the Waqf is established by "our ancestors and is a part of Allah's ownership, with mosques built on it." "You (government) should protect them because we live in this country and we have not come from outside. If a Hindu is a Gujjar, a Muslim is also a Gujjar...Hindus are Jats, Muslims are also Jats - They chant slogans saying that Hindus, Muslims, and Sikhs are separate, but we say that 'Hindus, Muslims, Sikhs, and Christians sab hai bhai," the Jamiat chief said. Madani said there are many mosques in Delhi, some of which are 400 to 500 years old.

Delhi's air quality continues to deteriorate, AQI above 400

New Delhi, Nov 03: Delhi's air quality continued to deteriorate on Sunday, with thick smog engulfing the city's skies. Air quality at Anand Vihar reached "severe" levels, with the Air Quality Index (AQI) reading 424 as of 9 p.m., as per the Sameer mobile app. Several locations in the city continued to witness higher air pollution post-Diwali. Fifteen monitoring stations recorded air quality levels in the 'severe' zone, having AQI readings over 400, reported news agency. Monitoring stations that reported air pollution in the "severe zone" were from Ashok Vihar, Bawana, Dwarka, Jahangirpuri, Mundka, NSIT Dwarka, Najafgarh, Nehru Nagar, Okhla Phase 2, Patparganj, Punjabi Bagh, Rohini, Wazirpur, and Vivek Vihar. The city's 24-hour average AQI, recorded at 4 pm daily, stood at 382, worsening from 316 the previous day. A temporary respite from pollution, with help from the winds, was short-lived, as air quality continued to worsen post-Diwali festivities when a complete cracker ban was widely flouted. The national capital also recorded its lowest nighttime temperature so far, as thick smog and haze make sunlight penetration almost impossible during the day. According to the weather department, Sunday's minimum temperature was 16.5 degrees Celsius, 1.2 degrees above normal, and the maximum temperature was 33.2 degrees Celsius, 2.7 degrees

Nawab Malik predicts this leader will be 'kingmaker' in Maharashtra after polls

'No UCC for tribals': What Amit Shah, BJP's Jharkhand election manifesto promised

He said the BJP government would provide homes to 21 lakh families. He said the party's government

will provide a ?2000 per month stipend to youths for two years. "To support youth in their careers, the BJP in its manifesto promises to provide a monthly stipend of ?2000 for two years," the party said. The

BJP promised to create 287,000 government jobs and offer 500,000 self-employment opportunities to combat unemployment. The Uniform Civil Code (UCC) Bill was a proposal to establish uniform rules for personal matters for all citizens. These matters include marriage, divorce, inheritance, and property rights. The BJP has promised the implementation of the UCC across the country in its general election manifesto. JMM leader Mahua Maji, meanwhile, rejected the BJP's manifesto. "No one will believe this manifesto because the public has seen their governments, neither Jharkhand nor Ranchi developed during their time. Trafficking of women was at its peak during the BJP's tenure...The central government has not yet given the coal royalty to the state government," she added. Special grievance meetings for PwDs to resume soon, say Vellore dist officials

VELLORE: District administration officials responsible for conducting special grievance redressal meetings told TNIE that such meetings for persons with disabilities (PwDs) would resume soon -- bimonthly under the collector and monthly under the deputy collector or revenue divisional officer. Since June, these meetings have been halted, leading to a backlog of issues, concerns over which were expressed by Tamil Nadu Association for the Rights of All Types of Differently Abled and Caregivers (TARADAC) district vice-president G Rajendran a few weeks ago. Rajendran listed several pending grievances, including the members not getting Antyodaya Anna Yojana (AAY) ration cards, the unavailability of jobs for the PwDs under the MGNREGS, and delays in the distribution of medical kits to people with spinal cord injuries, assistive devices and pensions. He said, "For over a year now, 6,800 PwDs in the district have not received the Rs 1,500 pension from the Department of Welfare of Differently Abled Persons and 873 severely disabled individuals have not received the Rs 2,000 pension via the District Differently Abled Rehabilitation Office (DDRO).

Though the state releases these funds, he said, the district administration could compile such grievances and forward them to the state for a quicker resolution. Several members of the association have reported difficulties in effectively conveying their issues during the weekly grievance redressal meetings, with the collector having to attend to scores of petitions simultaneously.

AIADMK stages protest against UT govt, seeks distribution of rice, essential items via PDS shops

PUDUCHERRY: AIADMK cadre organised a protest on Saturday near the Anna Statue in Puducherry, condemning the ruling AINRC-BJP alliance for not fulfilling their promises of providing free rice and sugar, and other essential items at a subsidised rate through PDS shops.Leading the protest, AIADMK Puducherry state secretary A Anbazhagan said, "The ruling government is cheating people even during the festival season, failing to fulfil their promises. Chief Minister N Rangasamy had announced 10 kg of rice and two kg of sugar for each ration card, along with 10 essential items at a subsidized price of Rs 500. He claimed these would be distributed through ration shops, but many of the shops were not opened."

Further, he alleged that free rice and sugar were distributed only in the constituencies of the CM, ministers, Assembly Speaker and the leader of the opposition. "They think people only live in those constituencies. Nothing has been distributed to the people in 20 constituencies, including Orleanpet, Muthialpet and Mudalirapet," he said, adding that people, with bags in their hands, are still looking for PDS shops providing the

Further, he alleged that it has become the norm for the CM to make welfare announcements that never reach the people. "The leaders say one thing, but officials act differently, leaving the public disappointed. Though these promises were made ahead of the festival, they are yet to be fulfilled, even after the festival ended," he said, urging immediate action.

Senior AIADMK leaders, including presidium chairman Anbanandham, treasurer Ravi Pandurangan, town secretary A Anbazhagan Udayar, and hundreds of cadre, participated in the protest.

No change in Polavaram height, says Nimmala Rama Naidu

VIJAYAWADA: The war of words between Water Resources Minister Nimmala Rama Naidu and former minister Ambati Rambabu has intensified as both accused each other of speaking lies on the status of Polavaram Irrigation Project.On Saturday, Nimmala asserted that there was no change in the height of Polavaram, and demanded that YSRC leaders come up with evidence while making allegations against the TDP-led NDA government. "Ambati is known for his expertise in spewing lies. He does it though aware of facts only to be in the good books of his leader," Nimmala charged. In the wake of recent posts of YSRC chief YS Jagan Mohan Reddy and Ambati alleging that the NDA government did not oppose the Centre's decision to reduce Polavaram height from 45.72 to 41.15 metres, Nimmala lashed out at the YSRC. Ambati demanded that did Nimmala get official confirmation from either the Prime Minister or the Jal Shakti Minister on the original height of Polavaram. Taking serious exception to Ambati's comments, Nimmala said, "One can wake up a person who is sleeping, but cannot wake up a person who is acting sleeping. Who told you that the height of Polavaram is being reduced? If you have evidence, disclose it."

Mocking the claims of Ambati, Nimmala questioned the sanity of the former minister. He also dared him to show evidence to the claim that '2,384 crore was diverted. "My sincere advise to Ambati and co. Give up your diversion politics," he said.

Amaravati Development Corporation Ltd (ADCL) Managing Director Lakshmi Parthasarathy Bhaskar highlighted Amaravati's potential as an economic

Beyond virtual booking, 10k more pilgrims to be allowed into Sabarimala

KOTTAYAM: Amid criticism from various quarters over its decision to discontinue spot booking for darshan at the Sabarimala temple, the state government on Saturday announced that 10,000 pilgrims will be allowed entry into the shrine, in addition to those booked through the virtual queue. Devaswom Minister V N Vasavan said that to accommodate these pilgrims, daily virtual queue bookings have been reduced from 80,000 to 70,000. Vasavan also announced that all pilgrims visiting the temple during the upcoming Mandala-Makaravilakku pilgrimage season will get free insurance coverage of Rs 5 lakh. In case of a death, the Travancore Devaswom Board which has introduced the insurance scheme will ensure transportation of the pilgrim's body back home, he said.Addressing reporters following the



final preparatory meeting of the Sabarimala pilgrimage season, Vasavan said: "Chief Minister Pinarayi Vijayan had announced in the assembly that no devotee arriving in Sabarimala will have to go back without darshan. This will be ensured strictly. ""If devotees arrive without a virtual booking, the government and devaswom board will provide them with

necessary facilities for darshan after verifying their documents, such as aadhar card or other identity cards. Rest assured, no devotee will be turned away without getting darshan," he said. The minister added centres will be set up at Pampa, Nilackal, and Erumely for document verification of devotees arriving without virtual queue bookings. Vasavan added that all necessary preparations have been made to ensure a smooth pilgrimage experience during the Mandala-Makaravilakku season.

Probe constructions on park land: Victims

SANGAREDDY: Victims from various colonies on Saturday once again appealed to the HYDRAA to conduct a thorough investigation of the lands of survey no. 6 and 12 in Patelguda village of Aminpur mandal and the lands of survey no. 153 in Venkataramana Colony.It may be noted that recently HYDRAA officials demolished 16 villas in Patelguda village, claiming they were constructed on government land. However, a farmer named Madhava Reddy claimed that the land did not belong to the government and explained to HYDRAA Commissioner AV Ranganath that the land was related to survey no. The victims appealed to the agency to conduct a comprehensive investigation in this matter and if necessary, conduct a full-scale survey. They said



that Madhava Reddy gave his land to two

contractors, Chandrasekhar and Koteshwar Rao, for the purpose of development but they split the land into plots and sold them.

The victims appealed to the commissioner to register cases against the people who cheated them and also provide compensation. They explained that the officials were saying the permissions given by the village panchayat officials for the construction of villas had been revoked in the past and the contractors had hidden this matter from them. The victims said that the commissioner has assured that officials will conduct a re-survey in Patelguda and if found that the villas were actually built on private land, the said land wouldbe returned to them. Meanwhile, the victims of Venkataramana Colony who bought plots behind the Pedda Cheruvu said that they fear losing due to the closure of the outlet of the Pedda Cheruvu in Aminpur mandal. They alleged that some politically influential leaders had closed the outlet to prevent water from flowing down into the Bandi Kunta pond. The victims demanded that an investigation be conducted on these lands as well, and complained that large apartments are being constructed in the park land.

Telangana government approves 116.4 km expansion for metro phase 2

Bus driver, conductor refuse to pay 'hafta', thrashed with rods

Gurgaon. A group of seven men allegedly assaulted the driver and conductor of a private bus after they refused to pay them protection money on Diwali eve. The gang attacked the duo with sticks and rods and forced them to pay up Rs 32,000 they had saved for changing tyres of the bus. Police said they were probing if the attackers were linked to any gang or were operating independently. Most gangs in Haryana — like those owing allegiance to jailed gangsters Lawrence Bishnoi and Kaushal — thrive on extortion from businessmen and other influential people. Police sources admitted such complaints of extortion usually increased during festivals and other important events. According to sources, this could well be the first instance of extortion from a bus operator in recent years.

On Oct 30, Narveer was ferrying a few passengers in his bus from Rewari to Pataudi with his nephew Ishu when the gang stopped them near Rewari Mor."The group of seven youths was being led by a man named Kala Khod. They asked for 'hafta (protection money)' and threatened to stop the bus service on our route if we didn't pay up. When we pleaded inability to pay, they attacked us with sticks and rods. Before leaving, they took away Rs 32,000 that I had in my pocket. We had kept that money aside to fix the bus tyres," Narveer said in his complaint. The bus driver and conductor were given first-aid at a nearby hospital. Following a complaint, a case was registered under sections 115 (voluntarily causing hurt), 126 (wrongful restraint), 190 (unlawful assembly), 191(2) (rioting), and 351(2) (criminal intimidation) of BNS.Police said they had initiated an investigation. "We are scanning CCTV footage and trying to identify the accused. We hope to make arrests soon," said a police official. The incident has, however, sparked concern among transporters. Several bus operators said they were feeling apprehensive about increasing extortion threats in the future. They urged the authorities to take swift and strict action against the culprits and ensure their safety.

Man leaves for office on bike, dies in hit and run

Gurgaon. A 26-year-old factory worker who was on his way to the office on a bike died in a hit-and-run in the Bilaspur area on Friday evening.Satyaprakash Srivastava, originally from Ballia in Uttar Pradesh, was on his way to his office in Binola when an unidentified vehicle hit him. The driver fled the scene after the accident, said an official on Saturday.

Locals alerted the police and rushed him to the nearest hospital, but he was declared dead on arrival by the doctors."A police team investigated the accident site and recorded statements from witnesses. The deceased's body, which remained unidentified until late Saturday, was sent for a post-mortem examination," added the official.

Satyaprakash lived in a rented accommodation in Fazilwas village with his brother, Girija Shankar.

Girija told the police that Satyaprakash, who had a night shift, left their apartment around 6pm on Friday. When he did not return home by the next morning and the office informed him that Satyaprakash had not reported for work on Friday, Girija began searching for him. Later on Saturday, Satyaprakash's colleague informed the family about the fatal accident. A case was registered against the unknown vehicle driver at the Bilaspur police station under sections 106 (causing death by negligence) and 281 (rash driving) of the BNS."We are examining CCTV footage from the area to identify the vehicle and its driver. The investigation is currently underway to trace the accused who fled the scene after the accident," said Sandeep Kumar, spokesperson for the Gurgaon police.

According to official data, more than 400 people die in road accidents in Gurgaon every year. Around 35% of those who die in road accidents in Gurgaon are bikers, while pedestrians account for 31%. More than 30% of fatal accidents occur on NH-48.

Running 3 years late, Bhangel Elevated Road is likely to be ready by Jan next yr

Noida. Bhangel Elevated Road — a six-lane, 5.5km stretch linking Agahpur with NSEZ on the Dadri-Surajpur-Chhalera (DSC) Road — is set for completion by the end of Jan next year, a month late from its original deadline.

According to officials, nearly 90% of the work was complete. This road aims at easing traffic on one of the city's busiest routes connecting Noida with Surajpur, Dadri, and Greater Noida. It passes through densely populated villages like Sadarpur, Chhalera, Agahpur, Barola, Salarpur, and Bhangel, as well as key sectors including 40, 41, 43, 47, 48, 49, 82, 88, 101, 106, 107, and 110.Officials said all necessary approvals had been secured, including those from IIT-Roorkee that endorsed adjustments to the road's alignment.

Two building are coming in the way of the Agahpur to Bhangel alignment, for which a 90m section (from piers 121 to 124) will be narrowed down by half a metre, with balcony adjustments for further clearance. UP State Bridge Corporation Ltd (UPSBCL), which is overseeing the construction, has faced difficulties completing pier-cap work in the area because of these buildings.Noida Authority CEO Lokesh M confirmed that the elevated road would be ready in a couple of months. "We are hoping the carriageway can be

opened for public in Feb next year," he added. Sandeep Gupta, the bridge corporation joint managing director, said, "During a meeting headed by chief secretary Manoj Kumar Singh in Aug this year, we were asked to ensure the work was ready by Jan next year. We are working in keeping with the schedule. At one section, some high-tension wires needed to be shifted. That has been done. Funds are an issue at times. As of now, Noida Authority is required to release over Rs 100 crore. We are managing the work, but if funds are hindered, the project might be delayed.

The project is already running three years late. Envisaged in 2013, the elevated road project was launched in June 2020 with a budget of Rs 468.3 crore. The bridge corporation was then given a deadline of Dec 2022.It received multiple extensions since then. Initially, an extension was granted till Dec 2023, but that too was missed. Subsequently, the target was shifted to Dec 31, 2024.

Winds drive quick AQI recovery in Gurgaon after Diwali, but it's unlikely to stay for long

Gurgaon. A day after touching 309 and falling in 'very poor' category post-Diwali, Air Quality Index (AQI) in city was 'poor' at 209 on Saturday. This improvement was attributed to dispersal of pollutants by a strong surface wind. The prevailing east-northeast winds, maintaining speeds between 8-10 kmph throughout the day, contributed to the better air conditions.At three out of the four monitoring stations AQI was in the 'poor' range, with Gwalpahari recording a reading of 223, Sector 51 of 201, and Vikas Sadan of 205. Teri Gram showed better air quality with an AQI of 197, categorised as 'moderate'. The Central Pollution Control Board (CPCB) classifies AQI between 0-50 as 'good', between 51 and 100 as 'satisfactory', between 101 and 200 as 'moderate', between 201 and 300 as 'poor', between 301 and 400 as 'very poor', and over 400 as 'severe'. According to the central govt's System of Air Quality and Weather Forecasting and Research (Safar), the air quality is likely to be in the 'very poor' category during the next six days. "Meteorological conditions are likely to be extremely unfavourable for the dispersion of pollutants," it



stated. Weather experts, too, cautioned that a dip in wind speed in the coming days might adversely affect pollution

Sachin Panwar, an independent air quality expert, suggested that this reprieve may be short-lived and conditions will soon worsen with shifts in wind direction and low winds persisting after Nov 4, affecting the dispersal of pollutants. "Strong winds allowed the effective dispersal of pollutants. However, the situation will change with the change in

wind directions and calmer winds thereafter. Air quality might reach "severe" levels after Nov 7," Panwar said. Meanwhile, measures to bring down pollution levels in the city continue to be implemented. These include regular water sprinkling on roads, strict monitoring of construction activities, and enforcement of dust control measures at

various sites. "Heavy vehicles will be diverted to the Kundli-Manesar-Palwal (KMP) Expressway to prevent them from entering the city, which should help urban areas," said Vijay Choudhary, regional officer of the Haryana State Pollution Control Board.

We are also identifying pollution hotspots where traffic congestion and dust are present in abundance, and these areas will be given priority for repairs. Additionally, anti-smog guns will be installed at ten high-rise residential locations along major routes such as Southern Peripheral Road, Sohna Road, and Golf Course Extension Road. These measures aim to bring down particulate matter levels, especially near densely populated areas where residents are most affected by poor air quality," he added.

The minimum temperature in the city dropped to 17.4 degrees Celsius on Saturday from the previous day's 19 degrees Celsius. The maximum temperature was recorded at 33.9 degrees Celsius. According to IMD forecast, the upcoming days will see mainly clear skies, and mornings will be misty. The minimum temperature is expected to hover around 16-17 degrees Celsius, while the maximum temperature will be around 32-33 degrees during the next

Govt plans multilevel parking at Udyog Vihar-4 to ease snarls in the corporate

Gurgaon. In an effort to tackle traffic and parking issues, Haryana State Industrial and Infrastructure Development Corporation (HSIIDC) is planning to construct a multilevel parking at Udyog Vihar-4.The parking lot will accommodate up to 500 cars and come up on 1.5 acres of land near Bihari Market. HSIIDC is in the process of finalising a consultant to conduct a technical and financial assessment for the project, which is estimated to cost around Rs 50 crore. This proposal now awaits final approval from the HSIIDC headquarters."We prepared a proposal for a dedicated parking facility at Udyog Vihar. We have received an inprincipal approval from the authority and have done a preliminary study. Now we'll engage a consultant. Once we get the approval, it will evaluate all aspects of the project, ensuring a self-



sustaining model for the facility. This multi-level parking project will be designed to relieve roadside parking congestion and improve traffic flow, said Arun Garg, deputy general manager, HSIIDC.Udyog Vihar currently has around 8-10 parking sites spread across its five phases. However, these are not enough for the daily footfall the area receives in the form of

corporate employees, visitors, and commercial traffic. The lack of an organised parking system here has led to roadsides becoming ad-hoc parking zones, causing frequent traffic snarls, especially during peak

This is not HSIIDC's first attempt at solving the parking crisis in Udyog Vihar. In 2004, former chief minister Om Prakash Chautala laid the foundation stone for a multilevel parking facility designed to house

4,000 cars on a 4-acre plot in Vanijya Kunj.However, despite its launch, the plan never progressed. The plot was ultimately auctioned in 2018 for Rs 1,496 crore from an 11-acre parcel that included the original parking site. Numerous other similar plans have been proposed over the years since then, but have remained largely on

Sohna emerging as key residential market, 16k homes planned in next 3 years

Gurgaon: Once known for affordable housing, Sohna is fast developing as a prominent residential market in Gurgaon. Homebuyers, among them techies and marketing professionals, are being drawn to Sohna as the area has made strides in improving infrastructure and competitive pricing.

Connectivity improvements make it a viable option," Rajput, who has booked a 2BHK in a Sohna project, said. Developers are also pivoting towards Sohna.Pradeep Aggarwal, founder and chairman of Signature Global, said "Sohna has emerged as one of the most soughtafter real estate destinations for both homebuyers and investors. The area is now seamlessly connected to Gurgaon's established Central Business Districts (CBDs) and other key locations, as well as to major national highway corridors like the Delhi-Mumbai route."Signature Global, Ganga Realty, Central Park Group, Silverglades, Ashiana and other realtors plan to build 16,000 housing units over the next three years in Sohna. Rajat Likhyani, principal partner at Square Yards Consulting, said demand for houses has surged in the area."Property prices increased 13% in 2024 from the previous year," Likhyani said, adding that costs are between Rs 7,500 and Rs 8,500 per sqft. Juvenile nabbed in fatal shooting of Delhi man, nephew

New Delhi: A juvenile was apprehended on Friday for his alleged involvement in

the shooting incident in Shahdara's Farsh Bazar area on Diwali evening in which a man and his teenage nephew were killed while his 15-year-old son was injured, police said. According to police officials, the juvenile, a distant relative of the victim, claimed during interrogation that he had a dispute with Akash Sharma involving Rs 70,000 which led him to hatch a conspiracy to kill him. The accused, who is around 17, had hired a shooter to commit the crime, a police officer said. CCTV footage purportedly of the shooting incident that surfaced on social media on Friday showed one of the two accused touching Akash Sharma's feet before the other opened fire at him. The clip showed Akash along with his nephew Rishabh Sharma (16), and son Krish celebrating Diwali outside their house in Bihari Colony when around 8 pm the two accused came there on a Scooty. One of the bike riders touched Akash's feet while the other, wearing a mask and with a bottle in hand, stood nearby. Suddenly the masked man started firing, the footage from a CCTV camera showed. The shooter started running as he kept firing at Rishabh and Krish, who chased him. The three victims were taken to a hospital where Akash and Rishabh were declared dead while Krish was undergoing treatment, police said. Deputy Commissioner of Police (Shahdara) Prashant Gautam said the juvenile accused, a distant relative of the victim, has been nabbed. "During interrogation, he said that he was having a financial dispute of Rs 70,000 with Akash. Investigations are still on and we are trying to nab the shooter," the DCP said. The officer said Akash had to return the money to the accused but was avoiding his calls and messages. According to the deceased's Bihari Colony when around 8 pm the two accused came there on a Scooty. One of the bike riders touched Akash's feet while the other, wearing a mask and with a bottle in hand, stood nearby. Suddenly the masked man started firing, the footage from a CCTV camera showed. The shooter started running as he kept firing at Rishabh and Krish, who chased him. The three victims were taken to a hospital where Akash and Rishabh were declared dead while Krish was undergoing treatment, police said. Deputy family, they had a rivalry with the accused and his kin over property and money. Akash's mother Shashi told reporters that they were getting threats for the past several days. "A day earlier, he came to our house with a packet of sweets. Since his family have an enmity with us, we avoided him," she said. "Because of that family, I lost my husband. Now my son and grandson have also been murdered," Shashi said. Another police officer said Akash used to run a cosmetics shop near his house and was booked several times in cases of gambling. The police said statements of the family members have been recorded and teams were formed to nab the shooter.

Indian movies, classical dances, yoga, and the Hindi language have gained considerable prominence across Uzbekistan, leading many local Uzbek women—from teenagers to adults as old as 72—to pursue learning these subjects at the Lal Bahadur Shastri Centre for Indian Culture (LBSCIC) in Tashkent.

BSCIC conducts over 40 weekly programmes showcasing Indian culture, which garners immense interest among the locals."There are over 1,500 students enrolled in various courses, including Kathak, yoga, and Hindi. Everything Indian is much loved and appreciated here,' Nigora, a translator at the Centre, told TNIE.

The Centre was established in 1995, three years after India established diplomatic ties with Uzbekistan. Initially known as the Indian Cultural Centre, it was renamed the Lal Bahadur Shastri Centre for Indian Culture in March 2005. It is regarded as the largest Indian cultural centre in Central Asia. "The students are very enthusiastic about the Kathak classes I teach, and they rarely miss a session. My oldest student is 72, and she's just as skilled as the others. I also teach them other group dances, like garba," said Nikita, the Centre's dance instructor.

Yoga, too, has gained prominence in Uzbekistan, and many students regularly enrol in classes at the Centre. International Yoga Day was observed at the LBSCIC on June 21. The Centre also houses a well-equipped library with books on India in English, Hindi, Russian, and Uzbek, along with a reading room that stocks major Indian newspapers and magazines. In an effort to reach out to more Uzbek youth, the Indian Council for Cultural Relations (ICCR) has established the 'India Chair' at the University of World Economy and Diplomacy in

Iran Vows 'Tooth-Breaking' Response To Israel As US Deploys B-52 Bombers In Middle East

World. Iran's Supreme Leader Ayatollah Ali Khamenei promised a "teeth-breaking" response to Israel and the United States after Israel targeted Iranian military sites in retaliatory strikes late last month.

'The enemies, both the US and the Zionist regime (Israel), should know that they will definitely receive a teethbreaking response for what they are doing against Iran and the resistance front," said Khamenei, referring to Iran-allied militant groups including Hamas and Hezbollah.He was speaking during a meeting with students on Saturday, ahead of the anniversary of the 1979 seizure of the US embassy in Tehran, Iran's staterun Press TV reported."We are certainly doing everything necessary to prepare the Iranian nation to stand against arrogance, whether in terms of military readiness, armaments, or political actions, and thank God, our officials are currently engaged in this," he added. Also this week, Iran said it could increase the range of its missiles, according to a report in state-run media. "If the Islamic Republic of Iran faces an existential threat, we will inevitably change the policy of our military doctrine," the head of Iran's Strategic Council on Foreign Relations, Kamal Kharrazi, told Lebanon's al-Mayadeen TV on Friday, per Press TV.He also said Iran is capable of producing nuclear weapons but remains curbed by a mandate by Supreme Leader Ayatollah Ali Khamenei against weapons of mass destruction, Press TV reported.

Khamenei's remarks come a week after Israel's latest round of strikes on Iran in response to the Islamic Republic's October 1 missile attack on the Jewish state, which itself was a response to the Israeli killing of leaders from Hamas and Hezbollah For the first time, Israeli officials admitted hitting targets on Iranian soil in a significant escalation of tensions, although Israel stopped short of hitting Iranian energy or nuclear

Top Hezbollah Commander, Responsible For Rocket Attack On Children, Killed In Lebanon: Israel

The Israeli military on Sunday said that it eliminated top Hezbollah commander Jaafar Khader Faour, responsible for multiple rocket attacks in Israel since October last year, including the July 2024 attack that killed 12 children on a soccer field. Faour was the commander of Hezbollah's Nasser Brigade rocket unit in southern Lebanon. Hezbollah did not immediately comment or confirm Faour's death. What did the IDF say about Faour's killing?

"The Commander of the Hezbollah Nasser Unit's Missiles and Rockets Array, Jaafar Khader Faour, was eliminated in the area of Jouaiyya in southern Lebanon. Faour was responsible for multiple rocket attacks toward the Golan, including an attack that



resulted in the deaths of Israeli civilians from Kibbutz Ortal, an attack on Majdal Shams which killed 12 children and injured many and the rocket attack on Metula last Thursday, which resulted in the deaths of 5 civilians," IDF tweeted. Additionally, Faour was responsible for terrorist attacks carried out from eastern Lebanon, from which the first rocket launches toward Israeli territory were fired on October 8, under his command," it added.12 children were killed in July this year as a rocket fired by Lebanon struck a soccer field in the Israeli-occupied Golan Heights on Majdal Shams. This was the deadliest attack in Israel by Hezbollah since the escalation between the two began in October 2023, soon after Hamas launched a deadly attack in Israel on the 7th of the month, killing hundreds and taking over 200 people hostage.

Sharing a childhood picture with her mother, Shyamala Gopalan Harris, she said in a post on X, "My mother, Dr. Shyamala Gopalan Harris, came to the United States from India alone at the age of 19. Her courage and determination made me who I am today."Harris has talked about her mother, who was a scientist, in several of

her speeches. The anecdotes about her mother have helped Harris to talk about feminism and racism. Notably, during her rally in Washington this week, the person she mentioned the most, after Republican presidential candidate and former US president Donald Trump, was her mother, according to a report by news agency AFP.She also talks about her mother's American experience as a woman of colour, a concept she hardly ever discusses as it pertains to her own life. Harris refrains from mentioning that she would become the first female US president if elected, as well as the first Black woman and person of South Asian descent to be the president.

In her first speech as the party's official presidential nominee, Harris talked about the journey of her mother, who left India at 19 years to do a master's degree in California.Kamala's mother, Shyamala Gopalan, went on to become a breast cancer researcher, who contributed to the development of treatments for the disease. Gopalan met Jamaican immigrant Donald Harris in the 1960s at the University of California in Berkeley, where he had



come to study economics. Kamala Harris was born to them in 1964.After her parents divorced when she was five, Kamala and her sister Maya were mainly raised by Shyamala."She taught us to never complain about injustice, but do something about it," Harris has said.Harris uses stories from her childhood to make a more personal connection with voters, and emphasise how she intends to work for middle-class



families that reflect her own upbringing. The US Vice President often talks about how her mother "worked long hours," and then sat late at night drinking tea with "a pile of bills in front of her." Harris also says that her mother kept a strict budget. She also talked about caring for her sick

Israeli forces capture senior Hezbollah operative in north Lebanon, Israeli military official says

BATROUN. Israeli naval forces captured a senior Hezbollah operative in north Lebanon, an Israeli military official said Saturday. Earlier on Saturday, Lebanese authorities said it was investigating whether Israel was behind the capture of a Lebanese sea captain who was taken away by a group of armed men who had landed on the coast near the northern town of Batroun Friday."The operative has been transferred to Israeli territory and is currently being investigated," the military official said, without providing the name of the person in detention. Two Lebanese military officials confirmed to the Associated Press that a naval force landed in Batroun, about 30 kilometres (18 miles) north of Beirut, and abducted a Lebanese citizen. Neither gave the man's identity or said whether he was thought to have links to Lebanon's Hezbollah group. They did not confirm whether the armed men were an Israeli force.Speaking to Lebanon's Al-Jadeed TV, Minister of Public Works and Transport Ali Hamie declined to go into details or answer questions about whether it was thought to be an Israeli operation. Three Lebanese judicial officials told AP the incident occurred at dawn Friday, adding that the captain might have links with Hezbollah. The officials said an investigation is looking into the man is linked to Hezbollah or working for an Israeli spy agency and an Israeli force came to rescue him. Both the military and judicial officials spoke on the condition of anonymity as they were unauthorized to share details about the incident or the ongoing investigation. Hezbollah issued a statement calling what happened a "Zionist aggression in the Batroun area." The statement did not give details or confirm whether one of Hezbollah's members was captured by Israel.

Israel has carried out in the past commando operations deep inside Lebanon to kidnap or kill Hezbollah and Palestinian officials. Residents of the apartment building where the man was seized said the armed group introduced themselves as state security."We were terrified. stake in an emerald mine in Zambia. For first time, Canada names India as 'adversary' in cyber threat report amid ongoing diplomatic crisis

CHANDIGARH. The Canadian government has, for the first time, labelled India as an "adversary" in its National Cyber Threat Assessment 2025-2026, published by the country's Centre for Cyber Security. The report comes at a time when diplomatic relations between both countries have hit rock bottom, following Ottawa's repeated accusations of New Delhi's involvement in campaigns targeting Sikh separatists inside Canada. India has rejected Canada's allegations, calling them "absurd."In its report released earlier this week, under the section 'Cyber Threat from State Adversaries', India has been listed alongside China, Russia, Iran, and North Korea. The report, in reference to India, states: "We assess that Indian state-sponsored cyber threat actors likely conduct cyber threat activity against Government of Canada networks for the purpose of espionage. We judge that official bilateral relations between Canada and India will very likely drive Indian state-sponsored cyber threat activity against Canada."The report continues: "India's



leadership almost certainly aspires to build a modernised cyber program with domestic cyber capabilities. India very likely uses its cyber program to advance its national security imperatives, including espionage, counterterrorism, and the country's efforts to promote its global status and counter narratives against India and the Indian government. We assess that India's cyber program likely leverages commercial cyber vendors to enhance its operations."At a recent press conference, Caroline Xavier, Chief of Canada's communications security establishment, had stated: "It is clear that we are seeing India as an emerging cyber threat actor." Meanwhile, the

group allegedly linked to India had conducted cyberattacks against Canadian websites following the onset of diplomatic tensions last year. 'Diplomatic tensions are also inspiring hacktivist activity. After Canada accused India of involvement in the killing of a Canadian citizen, a pro-India hacktivist group claimed to have defaced and conducted brief DDoS attacks against websites in

Canada, including the public-facing website of the Canadian Armed Forces," the report stated in the section titled 'Geopolitically Inspired Non-State Actors are Creating Unpredictability'.

This was in reference to Khalistani separatist Hardeep Singh Nijjar, who was shot dead in Vancouver on June 18, 2023. Four Indian nationals living in Canada have been charged with Niijar's murder and are awaiting trial.

Canadian Prime Minister Justin Trudeau said in September 2023 there were credible allegations that India's government had links to the killing. India denied the allegations at the time, calling them "absurd" and "motivated.

Still wrecked from past Israeli raids, northern Gaza hospitals face new attacks

JERUSALEM. They were built to be places of healing. But once again, three hospitals in northern Gaza are encircled by Israeli troops and under fire.Bombardment is pounding around them as Israel wages a new offensive against Hamas fighters that it says have regrouped nearby. As staff scramble to treat waves of wounded, they remain haunted by a war that has seen hospitals targeted with an intensity and overtness rarely seen in modern warfare. All three were besieged and raided by Israeli troops some 10 months ago. The Kamal Adwan, al-Awda and Indonesian hospitals still have not recovered from the damage, yet are the only hospitals even partially operational in the area. Medical facilities often come under fire in wars, but combatants usually depict such incidents But the focus on Shifa has overshadowed as accidental or exceptional, since hospitals enjoy special protection under international law. In its yearlong campaign in Gaza, Israel has stood out by carrying out an open campaign on hospitals, besieging and raiding at least 10 of them across the Gaza Strip, some several times, as well as hitting multiple others in strikes.It has said this is a military necessity in its aim to destroy

Hamas after the militants' Oct. 7, 2023 attacks. It claims Hamas uses hospitals as "command and control bases" to plan attacks, to shelter fighters and to hide hostages. It argues that nullifies the protections for hospitals.

"If we intend to take down the military infrastructure in the north, we have to take down the philosophy of (using) the hospitals," Israeli military spokesman Rear Adm. Daniel Hagari said of Hamas during an interview with The Associated Press in January after the first round of hospital raids. Most prominently, Israel twice raided Gaza City's Shifa Hospital, the biggest medical facility in the strip, producing a video animation depicting it as a major Hamas base, though the evidence it presented remains disputed.

raids on other facilities. The AP spent months gathering accounts of the raids on al-Awda, Indonesian and Kamal Adwan Hospitals, interviewing more than three dozen patients, witnesses and medical and humanitarian workers as well as Israeli officials.It found that Israel has presented little or even no evidence of a significant Hamas presence in those cases. The AP presented a dossier listing the

incidents reported by those it interviewed to the Israeli military spokesman's office. The military, which did not respond to a The office said it could not comment on specific events.Al-Awda Hospital: 'A death sentence'The Israeli military has never made any claims of a Hamas presence at al-Awda. When asked what intelligence led troops to besiege and raid the hospital last year, the military spokesman's office did not reply. In recent weeks, the hospital has been paralyzed once again, with Israeli troops fighting in nearby Jabalia refugee camp and no food, water or medical supplies entering areas of northern Gaza. Its director Mohammed Salha said last month that the facility was surrounded by troops and was unable to evacuate six critical patients. Staff were down to eating one meal a day, usually just a flat bread or a bit of rice, he said. As war-wounded poured in, exhausted surgeons were struggling to treat them. No vascular surgeons or neurosurgeons remain north of Gaza City, so the doctors often resort to amputating shrapnelshattered limbs to save lives."We are reliving the nightmares of November and December of last year, but worse," Salha said. "We have fewer supplies, fewer doctors and less hope that anything will

be done to stop this."

Last year, fighting was raging around al-Awda when, on Nov. 21, a shell exploded in the facility's operating room. KURNOOL: A rally was held on Saturday with the slogan of 'Save Kappatralla' by people from 10 villages in Devanakonda mandal in protest against the Centre's approval for uranium exploration in the Reserve Forest area. The rally was taken out by the villagers with the support of Left parties, civil organisations and students demanding the immediate stoppage of drilling in the forest area. Villagers from Kappatralla, P Kotakonda, Bethapalli, Chellela Chelimala, Madapuram, Gundlakonda, and other neighbouring areas attended meeting at the Koulutla Chennakesava Swamy temple to express their solidarity with the stir.

According to Kappatralla village Sarpanch Chenama Naidu, the area in question encompasses 468.25 hectares of land in the Pathikonda Section of Adoni Forest Range.

Telangana HC rejects plea by son of ex-MLA on order allowing probe into hitand-run case

HYDERABAD: Upholding the order by the XVII Additional Chief Metropolitan Magistrate in a hit-and-run case involving Mohammad Raheel Aamir, son of former MLA Mohammad Shakil Aamir, Justice K. Sujana of the Telangana High Court has permitted further investigation in case CC No. 3592 of 2022. The court's decision followed a thorough examination of the material facts. It noted that the respondents had filed a memo in the trial court requesting permission to conduct additional investigations, citing the absence of crucial evidence. The judge pointed out that since the trial had not yet commenced, allowing further investigation would not prejudice the accused. Citing Section 173(8) of the Cr.PC, the judge reiterated that the filing of a chargesheet does not prevent the police from conducting further inquiries. Counsel for Raheel argued that the order violated legal principles outlined in Section 173(8), asserting that the case was at the witness examination stage, and that further investigations would constitute an abuse of process. Counsel also claimed that the police's decision to modify the charge to one under Section 304(II) of the IPC was illegal and infringed upon Articles 14 and 21 of the Constitution.In response, the Government Pleader (Home) defended the magistrate's decision, stating that the order was lawful and justified. He referenced a counter-affidavit from the deputy commissioner of police, which highlighted shortcomings in the initial investigation and called for a dedicated team to reassess the case.

After reviewing both sides, the High Court found no illegality in the magistrate's order and allowed the prosecution to continue with its investigation.

Odisha govt to bolster emergency centres to tackle natural calamities

BHUBANESWAR: The Odisha government has decided to strengthen the state emergency operation centre (SEOC) and the district emergency units to respond to calamities and other emergencies more efficiently in the future.Officials in the Odisha State Disaster Management Authority (OSDMA) said the project will be implemented as one of the components of the World Bank-funded Odisha State Capability and Resilient Growth Programme (OSCRGP) in the state.Under the programme, the government plans to equip the SEOC with hotline service, a point-to-point direct communication link set up for its use in emergencies, for effective disaster management. This apart, it also plans a cell broadcasting system for the entire state to reach out to the population in specific zones or locations with early warning dissemination through the emergency operation centres.

The operation centres play a critical role during disasters for which it is essential to equip them in utilising early warning information to respond to emergencies more efficiently," said OSDMA executive director Kamal Lochan Mishra. These centres will be equipped with adequate tools and technology to enable them to have ready access to information. The SEOC serves as a



central command and control facility for coordinating disaster response and recovery efforts during emergencies. It also serves as a hub where information is gathered, decisions are made and resources allocated during emergencies such as cyclones, floods or any other natural or manmade disasters.

The emergency units set up in all 30 district headquarters also play an important role in effective multi-agency coordination and inter-governmental responses to disaster events on the ground. Considering their importance, six of the units have been made

functional in the coastal belt of the state round-the-clock.

OSDMA sources said strengthening of the SEOC and district emergency units will help in integrating impact-based forecast and risk-based early warning information to carry out seamless operations.

Mishra said the project will be implemented with the help of Odisha Computer Application Centre (OCAC) within a year. "The GIS Cell of OSDMA that provides technical support to the EOCs will also be strengthened with the help of OCAC," he added.

Newly married woman killed in group clash near Udangudi in Tamil Nadu

THOOTHUKUDI: A 20-year-old newly married woman was killed in the backdrop of a group clash, which involved her brother, at Satharakonvilai near Udangudi on Saturday. Sources said that Govindan (21), son of Sivan of Satharakonvilai, had stopped one Sakthikumar of Padukapathu and asked him to slow down while driving in the street on Tuesday. However, this turned into an argument, and Sakthikumar went to Govindan's house on the same day, with a group of 20 persons but he was not home. Odisha: In parched Ganjam, fight over irrigation water claims a farmer's life

BERHAMPUR: As Ganjam reels under poor rainfall and the spectre of hopelessness looms large for agricultural community, a 42-year-old farmer was allegedly murdered in what was believed to be escalation of a fight over irrigation water in a village within Dharkote police limits of the district. The incident took place in Kusarab village where Panchu Gouda was found dead near his farmland on Saturday morning. Sources said Panchu had left home last evening to irrigate his land. However, some other farmers who too wanted to irrigate their land reportedly had a fight with him which resulted in an attack that left the 42-yearold with critical injuries.

As he did not return, his family started a search but in vain. This morning, Panchu's body was found. Dhanei reservoir is the only exception with 87.46 pc storage.Despite scarcity, in emergency cases, water is being released through canals of barrages and diversion weirs to save the standing crop but much below than their capacity. While Gallery barrage is designed to discharge 18.40 cumecs, the actual discharge has been only

1.96 cumecs.

We have learnt nothing from 1984

IT was early 1985, perhaps the end of February. I saw a notice somewhere that Khushwant Singh was going to speak about the final days of Indira Gandhi's rule and its aftermath. The venue was the Press Club of India. In those days, Delhi had not surrendered its beautiful spring weather to smog and breathlessness. When I reached the Press Club, its lawn was already packed. I spotted the last few empty chairs shining in the late afternoon sun at the grassy lawn's edge.Khushwant delivered his long lecture in a steady, scholarly voice. His column 'With Malice Towards One and All' and his jokes had given him a popular profile, but those who knew about his two-volume history of the Sikhs were aware of his erudition. That evening, he took the silent audience through all the details of the shipwreck Delhi and the country had experienced over the previous few months. He said Indira's decision to choose a military solution to the Golden Temple crisis was deeply flawed.

Everyone in the audience knew how close and loyal he had been to Indira. He and many others had suggested alternative ways to deal with the situation. The riots that followed her assassination across the country had laid bare the vulnerable state of India's democracy, he said. The violence against Sikhs was politically inspired and the mass killings were publicly instigated in Delhi and other cities. Three years later, when Raj Thapar, Managing Editor of Seminar (it closed last year), died, Khushwant wrote in his column that the riots triggered her cancer.I agree with him. Witnessing the Delhi massacre was an experience like none other. From my balcony in a South Delhi flat, I saw a young Sikh crouching behind the water tank on his house's roof, his arms stretched across his two young children, while a howling crowd beat on the door downstairs. The younger sister of my old Sikh friend, a Hindi teacher in Madhya Pradesh, was staying with us. I didn't want our maid to know that she was merely a friend, so I told my two-year-old son to call her 'bua'. And I told her not to appear at the balcony. My parents had witnessed the Partition. They chose not to tell me anything they had seen. Shall I do the same?

Schools were shut for a fortnight in early November. When they reopened, I remember sitting in a Grade-6 English class at Bal Bharati School on Lodhi Road. As a supervisor of BEd trainees, my job was to sit in classes and write advisory notes on their lesson plan book. My student did what English teachers routinely do: wrote a few words used in the text on the blackboard and asked children to use them in their own sentences. One of these words was 'arrive'. A boy who instantly raised his hand had made this sentence: "When a Sikh arrived in Delhi, Hindus killed him." My student looked perplexed. She knew that the government had issued strict orders to avoid any mention of the riots in classes. The sentence using 'arrive' was grammatically correct. The class I attended next was a civics lesson. That day, the topic was 'The Rights and Duties of Governors'. Our system encourages teachers to mind their own business, i.e. teach their own subject. An English teacher, therefore, focuses on grammar. Civics teachers would not be expected to discuss riots. When I narrated the English-class episode in my book Learning from Conflict (current edition: Education, Conflict and Peace), some readers said they were shocked.

A student asked me what the trainee teacher could do when the school authorities didn't want anything 'real' to be mentioned, let alone discussed, in a class. Decades have passed, and I still hear stories of principals harassing teachers who dare take a stand on anything. They are supposed to act like robots. And if they are soon replaced by robots, we shouldn't be surprised. India's social sphere continues to witness public horror — lynchings, riots, rapes — but the teacher is supposed to stay silent, concentrating on the subject and the prescribed textbook. The bitter truth behind pretty-looking fruit

Good looks, dictated by what should be the perfect colour, curves in all the right places and a certain comph, do matter. In our appearance-obsessed society where women, and some men, work tirelessly to conform to an impossible idea of...

Good looks, dictated by what should be the perfect colour, curves in all the right places and a certain oomph, do matter. In our appearance-obsessed society where women, and some men, work tirelessly to conform to an impossible idea of beauty, how can our fruit and vegetables be treated differently? How can we be seen eating or gifting a not-so-perfect apple or mango? The quest for the reddest apples or bright yellow bananas or mangoes,

it seems, has almost been achieved.If you haven't noticed it already, something strange is happening to the fruit available in the market nowadays. Fruit stalls look bright and beautiful. However, consumers are becoming increasingly unsatisfied with the quality of the fruit they pick up from supermarkets or vendors. How often have you bought some beautiful apples only to find them tasteless and lacking in flavour or some of them developing a cottony texture within days? Discerning consumers have to search hard to find sweet and crunchy apples nowadays. The prettiest bananas are difficult to peel and tasteless to eat. Golden mangoes come with a strangely gooey core.

Meet ethephon, the hot new agro-pesticide in town that is doing much to enhance the looks of our fruit, even as its use affects their taste and flavour. Ever since the Food Safety and Standards Authority of India (FSSAI) approved its use for ripening fruit in August 2018, it has seduced farmers and invaded fields and orchards. Last year, the FSSAI banned the use of calcium carbide, which releases acetylene gas, commonly called 'masala'. Instead, it permitted ethephon in limited quantity, to be used in sachets on the condition that it should not come in contact with the fruit. The chemical, an organophosphorus pesticide, which goes under the innocuous description of 'plant growth regulator', generates the natural hormone ethylene in fruit to advance their maturity. The FSSAI has permitted its use only in the powder form, and only to generate ethylene gas for the artificial ripening of fruit. The permissible quantity is not more than 0.5 gm for 10 kg of fruit. Fair enough. After all, fruit has to be transported over long distances and this is possible only if it is plucked when still unripe. It needs a little help to become soft and sweet during the journey.

But ethephon's wonder (mis) use, as farmers have

discovered, is that if sprayed on unripe fruit that is still on the branch, ethephon promotes a stunningly good colour and shine on the outside, even when the fruit pulp inside is still unripe. For instance, in Some 10 years ago, Dr YS Parmar University of Himachal Pradesh, hundreds of gallons of ethephon, manufactured by leading chemical companies, are bought in July and August to be sprayed directly on the still green apples on the branches, to prepare them for early marketing in the mandis. Ethephon



increases the rate of anthocyanin synthesis, the pigment which gives the red apples and other fruits their colour. But these good looks, which are prized in the market, come at a price because apples sprayed with ethephon are tasteless and deteriorate faster than usual, making it harder to store them.


Traders are happy to offer a better price for the uniformly red, shiny apples. Unsurprisingly, the buzz in the mandi and retailer circuits is that fruit from Himachal Pradesh is not sweet any more. Plums, apples, pears, pomegranates, all are mostly sprayed with ethephon before harvesting.

Everyone is in on this secret, except the consumer. But who cares? The supply chain knows that the average customer still goes for the best-looking fruit in the vain hope that it will be tasty. In August, HP Chief Minister, Sukhvinder Singh Sukhu, drew attention towards the rising cancer cases in the state and urged the farmers to adopt chemical-free farming. A state which was once known to produce relatively clean and chemical-free vegetables and fruits no longer commands a spot in that space. Sukhu wants to expand natural farming in HP and has initiated steps for the certification, branding and marketing of natural farming products. But all the power that he wields cannot beat the allure of market forces driving the premium on good-looking produce.

Horticulture and Forestry in HP approved the use of 1 ml/per litre of ethephon in its package of practices (PoP) for apples. It is an accepted low dose. Ethephon was subsequently taken off the university's PoP, but farmers didn't stop. They are now using it in far larger doses of 4-5 ml/per litre, sprayed a week or 10 days before the harvest. The state Horticulture Department lacks the resources to monitor and stop its use, and watches its rampant misuse helplessly. The Jammu and Kashmir Government banned the use of ethephon in 2017 due to its harmful effects on human and plant health. It is a highly corrosive acid, which can cause serious health issues if consumed, including damage to the upper respiratory tract, oesophagus burns, neurological problems and liver toxicity. The ban was based on recommendations from the Sher-e-Kashmir University of Agricultural Sciences and Technology, Kashmir, and the Law Enforcement Directorate.In January 2022, the Telangana High Court, after hearing a petition that sought a ban on ethephon in that state, went along with the FSSAI recommendations. It held that if the chemical is kept in small pouches to generate ethylene gas, there is no conflict of the statutory provisions as contained in the Insecticides Rules or the Food Safety and Standards Act.Last March, the FSSAI noted in a press release that despite these directions, traders and handlers were misusing the approved sources of ethylene gas (read ethephon) by dipping fruit in ripening agent solutions, making the fruit unsafe for human consumption. Bananas and mangoes are dunked in tubs of ethephon solution to make them pretty and soft. Scientists have reported that regular consumption of artificially ripened fruit may cause dizziness, weakness, skin ulcer and liver-related diseases. Fruits harvested at proper maturity release ethylene gas naturally that aids in their ripening. But nobody wants to wait; everyone is in a hurry to take the fruit to the market. The buck, however, stops at the consumer's door. The day consumer decides that he/she will not allow good looks to trump taste and flavour, we might go back to the days when the taste of fruit felt real and natural.

A national framework that reflects a commitment to all citizens, regardless of state

politics, is needed.

Canada's charges are a grave diplomatic test

AS I write these lines, the government has not reacted to the truly unprecedented proceedings of the 126th meeting of the Canadian House of Commons Standing Committee on Public Safety and National Security of October 29. The theme of the...

AS I write these lines, the government has not reacted to the truly unprecedented proceedings of the 126th meeting of the Canadian House of Commons Standing Committee on Public Safety and National Security of October 29. The theme of the meeting was 'Electoral Interference and Criminal Activities in Canada of Agents of the Government of India'.

The officials who gave evidence before the committee, whose proceedings went on for over two hours, were the country's National Security and Intelligence Adviser Nathalie Drouin, Deputy Minister of Foreign Affairs David Morrison, Canadian Security and Intelligence Service Director Daniel Rogers, Public Safety and Emergency Preparedness Department's Associate Deputy Minister Tricia Geddes and Royal Canadian Mounted Police Commissioner Michael Duheme. A stronger panel of officials could not have been summoned to give an account on behalf of the Justin Trudeau government regarding its allegations against India.

In her opening statement, Nathalie Drouin gave a detailed account of Canada's version of the interaction between Canadian and Indian officials concerned after the murder of Hardeep Singh Nijjar in June 2023 in Surrey, Canada. She alleged that India's "refusal to cooperate led us to where we are today."Drouin's statement went far beyond the Nijjar murder in seeking to paint a picture of Indian interference and promotion of criminal activities in Canada. Her statement, the responses of the officials to the questions posed to them and the comments of some MPs who participated in the committee's proceedings were very negative from the Indian standpoint.In all, they constitute a grave diplomatic challenge which cannot go without a credible response.A muscular attitude that powerful states take extra-territorial action to defend their interests will not do because India has always projected itself, including during the tenure of the present dispensation, as a country which abides by international law. Further, it will no longer be sufficient to deny that Canada has not given evidence because the Canadian officials have emphatically stated that they had done so. Hence, India's diplomatic and security establishments will have to ensure that it shows that the material given to them by the Canadians was untenable. Drouin claimed that Canada had proceeded on two tracks: law enforcement and diplomatic. The former involved protecting Canadian nationals from Indian actions and the latter led to engaging India, which was Canada's significant international partner, with important people-to-people ties. However, Canada could not ignore attempts by the "agents of the Indian government" to promote coercion and violence and "undermine our democracy." She asserted that Canadian officials tried to keep the channels of communication open with their Indian counterparts and had held meetings in 2023 - August and September in Delhi, November in Dubai, December in Saudi Arabia —and 2024 — January in London and March in Dubai. Finally, a meeting was held on October 12 in Singapore.She said that her predecessor and other Canadian officials had met India's National Security Adviser on six occasions. She also met the Indian High Commissioner. She claimed that the Indian response was spreading the false narrative that Canada had shown them "no evidence and was ignoring its concerns on Khalistan."Drouin claimed that at the October 12th meeting, the two decided to reconvene by video on the 14th, but on the 13th, stories appeared in the Indian media that Canada had given no evidence. She asserted that India was using its diplomats and consular officers or their proxies to gather information on select Canadian nationals and that this



information was passed on to India, where senior officials used it to target Canadians with violence through the Lawrence Bishnoi gang. As part of its media strategy, it went to an international news outlet (The Washington Post) to brief it on what, according to Canada, India was up to.An MP asked if they had informed the newspaper that the senior official involved in these Indian actions was the Indian Home Minister. It was Morrison who said that the newspaper asked him if the senior official they had not named in their briefing was the Home Minister and he confirmed that he was. The hearing became a bit partisan between the government parties and the opposition, but, significantly, no opposition MP

supported India, except one, who asked if criminals in Canada targeted India and the RCMP chief conceded that it could be so. Despite political differences, the opposition does not wish to be labelled as uncaring for public security because the entire thrust of the Canadian officials was that all that they had done was to protect their people from the threat posed by Indian actions. Canada's record of disregarding India's concerns on Khalistan is undeniable. Canada's entire handling of the Kanishka bombing was racist in nature. Its laws abuse the concept of 'free speech' to permit even the glorification of the violent killing of Indira Gandhi and the calls for the establishment of Khalistan through violence. Its approach on the question of giving visas to Indian officials is intrusive and offensive. At the same time, it has given visas to criminals. All this will, however, not help in meeting the diplomatic challenge posed by the committee hearing. India cannot allow allegations against a senior minister stand. It cannot also allow allegations which are no longer limited to the Nijjar murder case go unanswered. Mere statements will not do.

To begin with, India should be able to show that the material given to it is untenable per se and especially so in a court of law. It also has to take diplomatic action even if that causes trouble to the diaspora and hurts trade. The Canadians have challenged the country's honour and what is left if honour is not defended, even if a cost has to be paid?Diplomacy always requires a cool-headed approach. That does not mean meekness. The Canadian accusations cannot be dismissed as those that are routinely made by inimical neighbours. India must now use all its diplomatic arsenal to respond to the atrocious charges made by Canada which, significantly.

'Don't stop or interrupt therapy': Kin of patients with rare diseases appeal to govt

► For patients with rare diseases, a Delhi **High Court order** with regard to smooth treatment and funding in October gave them hope -- a month on, nothing has changed.

New Delhi:From a seven-year-old in Srinagar to a 16-year-old in Delhi suffering from "rare diseases", a recent Delhi High Court verdict on ensuring uninterrupted treatment for patients like them came as a ray of hope. Since their diagnosis, patients of rare diseases defined by WHO as a debilitating, lifelong condition that affects 1 or fewer people in 1,000 - and their kin faced challenges in accessing life-saving medication, whose cost runs into lakhs, and issues with its supply. A total of 104 petitions were finally moved in court, with over 100 patients seeking relief.On October 4, the Delhi High Court directed that the Centre establish a National Fund for Rare Diseases and allocate Rs 974 crore for 2024-25 and 2025-26. This was to be approved and transferred in 30 days. It also said "treatment for all eligible... patients, as per an AIIMS report dated July 21, who are before the court in these batches of petitions shall commence in 45 days as per the NRDC (National Rare Diseases Committee) recommendations."The court directed NRDC to hold its first meeting in the week beginning October 21, where directions were to be issued



about ensuring procurement of rare disease drugs at reasonable prices, etc. It said "on the said date, cases of all petitioners shall be placed before the NRDC for approval and commencement of treatment". However, a committee member, speaking on condition of anonymity, said the meeting has not been held yet with no notification issued for it.

When contacted, Dr Madhulika Kabra, Professor, Division of Genetics, Department of Pediatrics at AIIMS New Delhi, who is part of the NRDC, said she would be unable to comment as she is on the panel. When the boy turned 10, his father noticed subtle changes in

how he walked - he would flail or fall over midway, and climbing a short flight of stairs became a task. The father then took him to AIIMS.In 2018, the boy was diagnosed with Duchenne Muscular Dystrophy (DMD), a rare disease that causes muscle weakness and degeneration. "At the time, doctors at AIIMS Delhi said there was no cure, no medicines were available, and it could only be managed through physiotherapy, supplements, and steroids. We also went to Sir Ganga Ram Hospital, where we were told the same thing," says the fathr, 39, a resident of Delhi's Patel Nagar.The boy went to school till Class IV before his ailment started taking over his life. Now wheel-chair bound, he cannot even lift a glass of water by himself, says his father. "Till Class IV, his school principal had made arrangements for him to attend classes on the ground floor but gradually, it became difficult..."Steroids prescribed for his treatment had side effects, making him gain weight and affecting his growth. His father rues that the drug that can help manage his son's muscle degradation is still under trial

New Delhi: Two troublemaker sisters living at a residential complex in east Delhi's Vasundhara Enclave were arrested after high drama on Friday, during which they threatened an elderly man, locked themselves in for hours and then drove their car rashly inside the campus, injuring people and damaging vehicles. Bhavya Jain and Charvi Jain, who allegedly assaulted a security guard of Anekant Apartments a month back, were blowing their car horn non-stop late on Friday night. Ashok Sharma, a 70-year-old retired police officer living in the complex, asked them to stop. They responded by damaging Mr Sharma's flower pots. They then entered his home and threatened him with a

Police were called in and by the time, they arrived, the sisters locked them inside their flat for hours. When they came out, they got into their car and drove rashly inside the society, damaging parked vehicles and injuring people. They hit a police vehicle and broke through the barrier at the gates of the residential society. This started a chase as the cops followed the car. The sisters also hit a scooterist standing on the road outside the residential complex. While the rider escaped, the sisters in their car dragged the scooter for quite some distance. Police eventually intercepted them at Noida Sector 20 and took them into custody.Joginder, the scooterist, said he was standing with his scooter outside the apartment complex when the speeding car with the sisters in it hit the two-wheeler and dragged it.Pradeep Chaurasia, the electrician of Anekant Apartments, was among those injured. "One of the sisters looked at all of us, got into the car and started driving. They were at a very high speed. My hand was injured," he said.

The sisters' family stays elsewhere in Delhi. Earlier, in September, the sisters were charged in a case of wrongful confinement and causing hurt after they allegedly beat up a security guard working at the residential complex.

The sisters had asked guard Akhilesh Kumar to visit their place because of a tapwater issue. When he said he would send a plumber instead, they insisted that he visit. When he went, he was beaten up and also burnt using a steam iron, Akhilesh alleged. He said that the sisters suspected him of sharing information about them with their parents. Police had been called in but the sisters locked them up and did not let the cops enter their home. A case was subsequently

CCTV shows rivals of Bishnoi gang's attack at Delhi's businessman home

New Delhi: The CCTV footage has surfaced from the October 26 shooting incident in Delhi's Rani Bagh, where two unidentified men, allegedly linked to the Bambiha gang, opened fire at a businessman's home. The attack, recorded on video, allegedly came after a Rs 15 crore extortion demand. The video revealed that two men on a motorcycle were approaching the businessman's residence. One of them is seen throwing a note inside, marked with "Bambiha Gang" and an international phone number. Moments later, the shooter fired multiple rounds, using his mobile torch to record



According to police sources, the footage was sent to Pawan Shokeen, a gangster based in the United States, who is believed to have ordered the attack at the behest of Kaushal Chaudhary. Chaudhary is currently lodged in the Gurugram jail and is also on the hit list of Lawrence Bishnoi. Chaudhary's gang is suspected of targeting businessmen in the Delhi-NCR area to fund their operations against Bishnoi's associates. Authorities stated that overseas gang leaders often recruit local shooters to carry out attacks, record them, and circulate the videos on social media. The Delhi Police Special Cell arrested both shooters two days later. Both shooters belonged to Uttar Pradesh.In an ongoing gang rivalry, Bishnoi has previously stated his intent to kill

Delhiites face breathing difficulty, AQI at 364

NEW DELHI: A thin layer of smog engulfed parts of the national capital on Sunday, and the Air Quality Index (AOI) continues to be in the 'very poor' category. Most areas in the capital recorded an Air Quality Index (AQI) over 350, raising health concerns for residents. The AQI of Delhi was recorded at 364 at 7 AM on Sunday, according to the Central Pollution Control Board (CPCB). At around 7.00 AM on Sunday, New Moti Bagh recorded an AOI of 352, RK Puram at 380, Vivek Vihar at 388, Dwarka Sector 8 at 385, and Lodhi Road at 330. All these areas reported 'very poor' air quality levels, posing significant health risks. The AQI in Nehru Nagar and Anand Vihar in the national capital remained in 'Severe" category on Sunday, with 431 and 427 AQI



recorded at 7.00 AM. In Burari, the AQI in the area stands at 385, categorised as 'Very Poor', as per the

An AQI is considered as "poor" between '200 and 300', "very poor" at '301 and 400', "severe" at '401-450" and 450 and above, is "severe plus.". Aditya, a resident of Delhi, said, " It is very difficult to breathe. This is not a time we can go out and do exercise; pollution is affecting our eyes."Meanwhile, Delhi Environment Minister Gopal Rai said that around 200 mobile anti-smog guns will be deployed across the national capital to combat dust pollution. Speaking to ANI on Saturday, Gopal Rai said that the Delhi government is continuously working on the ground to combat the rising pollution levels."Whether it is dust pollution, vehicle pollution or biomass burning, our teams are continuously working on targeting these three on the ground," he said.

ED chargesheet links Hong Kong, Thai scammers to cyber fraud racket in India

The chargesheet includes eight accused along with 24 related companies in connection with a digital arrest scam case, and cyber fraud involving proceeds worth Rs 159 crore.

New Delhi: The Enforcement Directorate (ED) found that individuals in Hong Kong and Thailand led a cyber fraud and money laundering scheme, with help from associates in India, in connection with the digital arrest scam case and cybercrime involving proceeds worth Rs 159 crore. These scammers worked with people in India to create digital signatures, set up shell companies, and act as dummy directors to open bank accounts, using fake documents sent through WhatsApp.The central probe agency filed a chargesheet on October 10, in the special court under the Prevention of Money Laundering Act (PMLA) in Bengaluru. The special court in Bengaluru took note of the chargesheet on October 29.

The chargesheet includes eight accused -Charan Raj C, Kiran S K, Shahi Kumar M, Sachin M, Tamilarasan, Prakash R, Ajith R, and Aravindan - along with 24 related companies. All the accused are in judicial



custody. The ED probe followed multiple First Information Reports (FIRs) from various law enforcement agencies across the Many companies were used as "mule" country, reporting schemes where cyber fraudsters allegedly tricked people with false stock market investments and fake digital arrests, leading victims to transfer funds to shell companies. The ED's findings show an organised cyber scam network in the nation, which reportedly used social media platforms like Facebook, Instagram, WhatsApp, and Telegram.Known as "pig-

butchering" scams, these schemes misled individuals with promises of high returns through fraudulent apps and stock market investments.Fake law enforcement scenarios were also used to coerce individuals into transferring money under false pretences. The central probe agency said that fraudsters created shell companies across states, including Tamil Nadu and Karnataka, primarily registered at coworking spaces without a real business presence. Fake documents were allegedly submitted to the Registrar of Companies.

AAP, BJP clash over Chhath Puja ghat at Delhi's Greater Kailash park

unfolded on Saturday between the Aam Aadmi Party (AAP) and the Bharatiya Janata Party (BJP) in New Delhi over a dispute regarding the establishment of Chhath Puja ghats in South Delhi's Greater Kailash for the widely celebrated Purvanchali festival.AAP leaders accused the BJP of obstructing local's efforts to set up the ghat at a park managed by the Delhi Development Authority (DDA) in Chirag Delhi. In response, the BJP levied similar accusations against AAP, alleging that the ruling party was hindering the creation of the Chhath ghat.BJP leader Suraj Chauhan usually organises the Chhath Puja at this location each year, and preparations were set to begin after obtaining permission from the DDA. However, AAP workers also sought to perform the Chhath Puja at the same site and secured approval from the Sub Divisional Magistrate (SDM), leading to a clash between the two parties.

New Delhi:An intense war of words As tensions escalated and leaders from both sides exchanged accusations, Delhi Chief Minister Atishi criticised the BJP for engaging in "cheap politics". She stated, "The BJP despises the people of Purvanchal. Their political tactics have degraded to the point of banning the Chhath Ghat in Greater Kailash through the DDA. Such despicable politics regarding Chhath, a revered festival of faith, will not be tolerated, and

the BJP will face the repercussions". Saurabh Bharadwaj, AAP leader and Urban Development Minister, who also serves as the local MLA for Greater Kailash, visited the site to stage a sit-in protest. He alleged that the "BJP-controlled DDA" was obstructing Purvanchali residents from establishing the ghat, claiming that the BJP coerced the DDA to halt its



construction and had the Delhi Police lock down the eight-year-old Chhath Puja site.

Bharadwaj further accused the BJP of being anti-Dalit, stating, "The Dalit community has used this 'Bhim Pulia' road for the past 300 years. Yet, for the last month, the BJP's DDA has closed this road, preventing people from celebrating Chhath Puja due to its anti-Dalit and anti-Purvanchali stance. Why are they doing the news agency PTI that a 6,000-square-meter area at Satpula Lake has already been designated for the Chhath Puja.Countering AAP's claims, BJP leader Shikha Rai accused a group of locals who arrived at the Satpula DDA Park to clean the ghat site of being prevented from doing so by "Bharadwaj's

She alleged, "The AAP workers issued threats and pressured the residents and BJP members to

leave." Rai added that in recent years, AAP workers had occupied the designated area days before the festival and imposed arbitrary conditions on its use. The Purvanchalis, who are Bhojpurispeaking individuals from Uttar Pradesh, Bihar, and Jharkhand, represent a significant voting bloc in Delhi, accounting for 30 to 40 percent of the city's approximately 1.5 crore electorate.

Marico net profit rises 20% to Rs 433 cr; revenue from ops up 7.6% to Rs 2,664 cr

NEW DELHI. Homegrown FMCG major Marico Ltd has reported an increase of 20.27% in consolidated net profit to Rs 433 crore for the September quarter.

It had reported a net profit of Rs 360 crore in the same quarter a year ago, Marico said in a regulatory filing.

Its consolidated revenue from operations rose 7.6% to Rs 2,664 crore during the quarter under review. It was at Rs 2,476 crore the previous year. Total expenses of Marico, which owns popular brands like Saffola, Parachute, Livon, etc, increased 7.65% in the September quarter to Rs 2,194 crore.Marico's total income, which includes other income, was up 9.22% to Rs 2,746 crore. Domestic revenue of the Harsh Mariwala-led company was up 8.02% to Rs 1,979 crore. Similarly, its revenue from the international



market was up 6.36% to Rs 685 crore. There is a "sequential uptick in growth in the domestic business" and the "international business continues robust show", said Marico in its earnings presentation. Shares of Marico Ltd on Tuesday settled at Rs 628.80 per scrip on the BSE, down 0.83 per cent from the previous close.

SBI Card net income declines 33% to Rs 404 crore

NEW DELHI. SBI Cards and Payment Services Ltd (SBI Card) on Tuesday reported a 33% decline in net profit to Rs 404 crore for the September quarter on increase in delinquency.

The pure-play credit card company, promoted by the country's largest lender State Bank of India (SBI), had reported a net profit of Rs 603 crore in the previous quarter a year earlier. However, the total income in the second quarter of the current fiscal year rose 8% to Rs 4,556 crore, from Rs 4,221 crore a year ago, SBI Card said in a regulatory filing. The interest income grew 20% to Rs 2,290 crore, while income from other sources declined 2% to Rs 2,131 crore. There was slight deterioration in the company's asset quality with the gross non-performing assets rising to 3.27% of the gross advances as of September, from 2.43% a year earlier.

Net NPAs (bad loans) also rose to 1.19% from 0.89% in the corresponding quarter of the previous year. Impairment losses and bad debts expenses increased 63% to Rs 1,212 crore in the September quarter as compared to Rs 742 crore a year earlier, it said. On capital adequacy, the company said the ratio fell to 22.1% from 23.3% at the end of September 2023.

Deepak Fertilisers profit soars 3-fold on robust sales

CPSE capex sees 11% fall during April-September

NEW DELHI. Capital expenditure by large public sector enterprises (with annual capex target of Rs 100 crore) has seen an 11% decline in the first six month of the current financial year. In the April-September period of the current financial year, large CPSEs have spent Rs 3.38 lakh crore in asset creation, which is 43.57% of the estimated expenditure of Rs 7.76 lakh crore for the full year.

In the same period FY24, these PSU companies had made Rs 3.79 lakh crore in capex. In FY24, these corporations spent Rs 8.05 lak crore in capex, 109% of the budget target of Rs 7.41 lakh crore.

The slowdown in CPSE capex is in line with overall drop in central government's capex in the first year of FY25. The central government has spent Rs 4.14 lakh crore in capex against the full-year target of Rs 11.11 lakh crore. In the first six months of the current financial year, the government capex fell by 15%. As per ICRA, to meet the FY25 budget target for exapex, the government needs to incur a capex of Rs 1.16 lakh crore a month during second half of the year, which entails a considerable expansion of 52% relative to previous year.

NEW DELHI. It was not that the warning signals were absent. Analysts have been saying it - that real incomes are shrinking; and consumption is slowing down. But it is when the big stakeholders get hit, it is time for everyone to wake up!

Nestle India experienced its slowest quarterly growth in 8 years when, for the second quarter this year, it reported a mere 1.4 per cent revenue increase yearon-year and a 1 per cent volume shrinkage. Articulating the frustration of the FMCG sector, which had taken robust growth at all price points for granted, Nestle MD Suresh Narayanan blamed his woes on the 'shrinking middle class'

In the most quoted of quotes in recent days, Narayanan said:
"Premium consumption still
continues to be fairly strong, but
the middle segment, which used to be the segment that most FMCGs used to operate in, seems to be shrinking.'

Another bellwether indicator, car buying, has been struggling after runaway growth in the post-COVID years. The Federation of Automobile Dealers Associations (FADA) admitted in August that inventories at factories and dealerships had soared to an alltime high of over 7 lakh units, valued at Rs 73,000 crore. Even the fast-

The magical figure then touted was a middle-class 450million strong that would drive growth and consumption in India.

When the dust settled, everyone realized the 450-million middle class was wishful thinking. Two decades later, the more realistic figure is about one-fifth the earlier estimate. The USbased Pew Research Centre projected the pre-Covid strength of the Indian 'middle class – defined as those earning between USD 10-USD 20 a day or Rs 25,000-Rs 50,000 a month – at about

How fragile the middle class's income and consumption is can be

gauged from the Pew Research's data that said about one-third of this segment fell out of the 'middle class' during the Covid freeze, effectively reducing it to about 66 million. Those numbers that fell out have probably been restored and the 'middle class' is now over 100 million strong.

But the estimates continue to differ wildly. Ridham Desai, MD of Morgan Stanley says: "...a hundred million new households, which is 450 million people, which exceeds the population of US and the whole of Europe, are becoming middle class in the next 10 years."

Bangladesh unrest: Indian garment exporters reaping benefits

NEW DELHI. Indian garment export is reaping the benefits of unrest in neighbouring Bangladesh. Garments exports from India in the first six months of the current financial year have registered an 8.5% increase compared to a 15% decline in the same period the year before. In September alone, India recorded a 17.3% year-onyear increase in apparel exports. The disruption caused by the political

turmoil in Bangladesh has resulted in a fall in exports from the country, a hub for textile supply across the globe. Bangladesh's apparel exports to the US, its largest export destination, fell 11% to \$3.40 billion in January-June 2024 as a graingt \$3.82 billion in the 2024 as against \$3.82 billion in the same period in 2023. Indian exporters seem to be benefiting from this disruption. Sabu Jacob, MD of Keralabased Kitex Garments, recently said unrest in Bangladesh has contributed to financial growth of not only the company but the entire garment industry in India. Kitex Garments has



reported its highest-ever turnover and profitability. Net profit of the Kochibased company, a manufacturer of infant garments, reached Rs 39.94 crore in Q2FY25, nearly tripling from Rs 13.21 crore in the corresponding period of the previous fiscal.Bengaluru-based Gokaldas Exports in its June quarter investors' presentation has cited the internal strife in Bangladesh as a long-term opportunity for the Indian garment industry. "Buyers seeking alternate production bases outside China, creating opportunities for major Asian suppliers like India. Bangladesh is

impacted by internal issues and Vietnam by high factor costs," it said in its investor presentation. As per Ajay Sahai, director general and CEO of Federation of Indian Export Organisations (FIEO), India's garment export sector has seen notable growth recently, benefiting from the political instability in Bangladesh, as a result many buyers have shifted to Indian manufacturers to meet demand, especially for time-

sensitive orders. "We expect that India could see a long-term increase of 10-20% in apparel export orders, potentially translating into an additional \$2-3 billion annually. This shift is expected to benefit India's established garment hubs," added Sahai. As per Ajay Srivastava, founder, Global Trade Research Initiatives (GTRI), international buyers have talked about moving 10-15% of their orders from Bangladesh to India, potentially adding \$300-400 million in monthly business for India.

Sebi Proposes Rs 1 Crore Minimum Investment, Mandatory Demat Form for Securitized Debt Instruments

NEW DELHI. IMarkets regulator Sebi has proposed a minimum ticket size or investment threshold of Rs 1 crore for the RBI-regulated originators and unregulated entities engaged in securitisation activities. The proposal also introduced limitations on the number of investors in private placements, allowing securitized debt instruments (SDIs) issued privately to be offered to a maximum of 200 investors. If this limit is exceeded, the issuance must be classified as a public issue. Public offers should remain open for a minimum of three days and a maximum of 10 days, with advertisement requirements aligned with Sebi's regulations for non-convertible securities. Additionally, the regulator has suggested that all securitized debt instruments should be issued and transferred exclusively in demat form.SDIs are financial products created by pooling together various types of debt — such as loans, mortgages, or receivables — and then selling them as securities to investors. This process, known as securitisation, allows the originator (such as a bank) to convert illiquid

Excuse me, you will be paralised for discont. That is incorporated. penalised for dissent. That is inappropriate behaviour; it is because of your actions that we changed the ball," umpire Shawn retorted. The seriousness of the balltampering allegations remains to be seen. 
