

# Sarma over Karimganj renaming

New Delhi, Nov 20: AIUDF general secretary Rafiqul Islam on Wednesday attacked Assam chief minister Himanta Biswa Sarma over the renaming of the Karimganj district, hinting that the name



was changed because it was linked to Islam. "They only see Muslims in Karim," Rafiqul Islam added. Himanta Biswa Sarma on Tuesday stated that the Karimganj district will be renamed to Sribhumi. "Over 100 years ago, Kabiguru Rabindranath Tagore had described modern-day Karimganj District in Assam as 'Sribhumi'--the land of Maa Lakshmi. Today the #AssamCabinet has fulfilled

this long-standing demand of our people," he wrote on X. Referring to Himanta Biswa Sarma steering the BJP's election campaign in Jharkhand, Islam said it is difficult to say that he is the chief minister of Assam. "The CM has nothing to do right now. He stayed in

Jharkhand for a month. It is difficult to say that he is the chief minister of Assam," he said. Reacting to Himanta Biswa Sarma's remark on Tuesday that there was no meaning of Karimganj in Assamese and Bengali dictionaries, the MLA said it was a historical name. "Karimganj is a historical name. So if those who are saying that the names that are not in the dictionary, which are not meaning-

ful, will change it, then thousands of names in Assam will have to be changed," he added. "When India-Pakistan was divided, at the time of the referendum, some people came together to split this district into two pieces and took the piece of Sylhet with Pakistan. But it remained in Assam. We speak in pride that our ancestors made efforts to keep Karimganj with India during partition," he added.

# 50% Delhi government employees to work from home due to air pollution: Gopal Rai

New Delhi, Nov 20: Delhi air pollution: Half of the staff in Delhi govern-

ment offices will work from home in view of the deteriorating air quality in the the national capital, environment minister Gopal Rai announced on Wednesday. will work from home," Rai wrote on X. Earlier, the Delhi government announced staggered office timings for its offices and the MCD. The timings of Municipal Corporation of Delhi (MCD) offices were

fixed from 8.30 am to 5 pm, while that of the "severe-plus" classification. An AQI Delhi government offices were 10 am to between 401 and 450 is classified as 6.30 pm. The air quality in Delhi and the



National Capital Region (NCR) remains in "alarmingly high" levels, prompting concerns about health and safety. Delhi logged a 24-hour average air quality index (AQI) of 460 at 4pm on Tuesday, lower than the record 494 clocked on Monday, but still in Delhi's air for days now.

# **Election Commission takes action** against policemen after Akhilesh Yadav



The Election Lucknow, Nov 20: Commission of India (EC) on Wednesday

ordered the suspension of two police personnel for violating its guidelines on checking of voters and stopping them from casting votes in the Uttar Pradesh bypolls. The action came after Samajwadi Party (SP) president Akhilesh Yadav raised the issue, urging the poll panel to act on video evidence showing police personnel hindering voters. Following the directive, district election officers and superintendents of police verified the complaints and suspended the accused personnel for their misconduct. Bypolls are currently underway in the nine assembly seats of Ghaziabad, Katehari, Khair, Kundarki, Karhal, Majhawan, Meerapur, Phulpur and Sisamau.

Taking serious note of social media reports by the Samajwadi Party alleging that certain communities were being barred from voting, chief election commissioner Rajiv Kumar directed

Uttar Pradesh election officials to ensure a fair and impartial voting process. They were told to take immediate cognisance of all complaints, and take prompt action and inform the com-



administration. He appealed to the Supreme Court and the poll body to take immediate cognizance of the matter and said, "All the police officers who are checking voter cards and Aadhaar IDs should be immediately suspended on the basis of the video. Police has no right to check Aadhaar ID cards or identity cards." After EC took cognizance of Yadav's complaints, the former UP chief minister took to X and said voters who cops earlier stopped should once again go and cast their votes. "The Election Commission has also become alert and now it is giving assurance that those who have been stopped from voting should go and cast their vote once again. Now no malpractice will be allowed," he

said. Yadav further wrote, "If anyone stops you again, then inform the Election Commission officials or people from political parties present there or complain directly to the Election Commission.

## Delhi HC questions forest official over plea for transplantation of trees from deemed forest

New Delhi, Nov.20: The Delhi High Court on Wednesday pulled up a forest department official for filing a plea seeking permission to transplant three trees from a "deemed forest" for the construction of a flyover. Justice Jasmeet



Singh asked the Deputy Conservator of Forest (DCF) concerned to file an affidavit explaining if the aspect of the area being a "deemed forest" was considered by him before filing the application for removal of the trees. In the application, the DCF said that the PWD had sought the transplantation of three trees for the construction of a flyover between Anand Vihar and Dilshad Garden and the removal of trees was necessary in that area to facilitate smooth flow of traffic. The amicus curiae, lawyer Gautam Narayan, and the counsel for the petitioner,

lawyer Aditya N Prasad, submitted that the stretch in question was a deemed forest, as disclosed in an affidavit filed by the city authorities in the Supreme Court, and the felling of trees, therefore, cannot be permitnted there. As the counsel for the applicant DCF sought the court's permission to withdraw the application, the court asked the authority to first file an affidavit in the matter. "You file an affidavit. I am not permitting you to withdraw today. How can you move an application for cutting trees in a deemed forest? First check, tell me was this inquiry done," Justice Singh asked. "Let a clarification be filed on affidavit indicating whether

this aspect was considered by the applicant before filing the application," the judge ordered. In August 2023, the court had ordered that no permission for felling of trees would be granted, while noting that the authorities were recklessly granting permission for cutting trees and there was total non-application of mind.

## as Andhra CM for another decade

Ranchi, Nov. 20: Andhra Pradesh Deputy Chief Minister Pawan Kalyan on Wednesday wished for TDP supremo N Chandrababu Naidu to continue as the chief minister of the state for another decade, considering his experience, guidance and visionary foresight for achieving USD 1 trillion GSDP. Asserting that he has 'complete' faith in Naidu, especially after seeing his governance over the first 150 days of the new NDA regime, the deputy CM highlighted that the southern state will become a USD 1 trillion economy 'soon'. Further, he thanked the CM wholeheartedly for his speech on the first 150 days of the government and noted that it instilled immense encouragement and faith in him for the future.

# Delhi HC stays trial court proceedings against P.Chidambaram

New Delhi, Nov 20: The Delhi high court on Wednesday stayed the trial court proceedings against former Union minister and senior Congress leader P Chidambaram in the Aircel-Maxis case lodged by the Enforcement Directorate. The Delhi High Court also issued notice to the Enforcement Directorate and sought its response on P Chidambaram's petition challenging the trial court's order taking cognisance of the charge sheet filed by the probe agency against him and his son Karti Chidambaram in the money laundering case. "Notice issued. Till the next date of hearing, the proceedings against the petitioner shall remain stayed. List on January 22,"

Justice Manoj Kumar Ohri said, adding that he will pass a detailed order later, news agencySenior advocate N Hariharan and lawyers Arshdeep Singh Khurana and Gupta, representing Р Akshat Chidambaram, contended that the special judge took cognisance of the charge sheet in the absence of any sanction for prosecution of the former Union minister who was a



public servant when the offence was allegedly committed. The ED raised a preliminary objection regarding the maintainability of P Chidambaram's petition, asserting that no sanction for prosecution was required as the allegations were unrelated to his official duties. As interim relief, P Chidambaram has sought a stay on trial court proceedings,

for the alleged offence of money laundering which are currently at the stage of charge consideration. The trial court had taken cognizance of charge sheets filed by the Central

Bureau of Investigation and ED in the Aircel-Maxis case on November 27, 2021, and summoned Chidambaram and his son Karti. Chidambaram's counsel argued that under Section 197(1) of the Code of Criminal Procedure (CrPC), prior sanction for prosecution is mandatory when allegations pertain to acts performed in an official capacity. They claimed that the ED had failed to secure this sanction, rendering the proceedings improper. The plea requested quashing the special judge's order, which took cognizance of offences under the

Prevention of Money Laundering Act (PMLA) without the necessary sanction. The ED and CBI alleged that Chidambaram, as Union finance minister in 2006, approved the Foreign Investment Promotion Board (FIPB) clearance for the Aircel-Maxis deal beyond his authority, benefiting certain individuals and receiving kickbacks.

#### 85,000 cr cleared to create 34,000 jobs in state

New Delhi, Nov. 20: Andhra Pradesh Chief Minister N Chandrababu Naidu on Wednesday said that the State Investment Promotion Board (SIPB) has cleared investments worth Rs 85,000 to create 34,000 jobs. Addressing the assembly, the chief minister noted that these investments were cleared in the first SIPB meeting held on November 19. "Cleared over Rs 85,000 crore investments in the SIPB (meeting), which will generate 34,000 jobs," said Naidu, and added that the government will offer more incentives to companies which create more jobs. As many as 10 investments were cleared, which includes Rs 61,780-crore joint venture between Arcelormittal & Nippon Steel at Bangarayyapeta near Nakkapalli to set up an integrated steel plant with a captive port. A Rs 5,001-crore investment by LG Electronics India Pvt Ltd, Kalyani Strategy Systems Ltd (Rs 1,430 crore), Tafe Faurecia India Pvt Ltd (Rs 76 crore). Philips Carbon Black (Rs 3,798 crore) and Azad India Mobility India Ltd (Rs 1,046 crore), among others. According to the CM, there is fierce competition among states over investments in the country and called on officials to handle this competition carefully to attract investments into Andhra Pradesh.

# BJP alleges 'scam' done on directions of Rahul, Sonia Gandhi

New Delhi, Nov 20: The Bharatiya Janata

Party on Wednesday intensified its attack on NCP (SP) leader Supriya Sule and Congress' Nana Patale over allegations of their involvement in the alleged Bitcoin scam. The two leaders are accused of using Bitcoin proceeds to fund Maharashtra elections by former IPS officer Ravindranath Patil. The Bharatiya Janata Party (BJP), which quickly latched onto the allegation, has also released purported voice notes. which they claim involve Sule and Patole in a conspiracy to encash Bitcoins to influence the electoral process. Supriya Sule and Nana Patole have denied the allegations and accused the Bharatiya Janata Party (BJP) of being behind it. Addressing a press conference, BJP spokesperson Sambit Patra claimed that the alleged misappropriation was done as per the directions of Congress leaders Rahul Gandhi and Sonia Gandhi. Patra also rejected

the Opposition's claim that his party was behind the "conspiracy" to target Sule and Patole. He claimed that the alleged cryptocur-



rency scam occurred years ago, and the Opposition's Maha Vikas Aghadi alliance used the money in previous elections as well. Patra claimed that about ?235 crore was involved in the alleged scam. "...There are 4 such audios of Supriya Sule... Today Supriya Sule is saying

that this is AI generated, this is not my voice whereas her own brother (Ajit Pawar) is saying that this is her voice. So very clearly we can

hear what instructions Supriya Sule is giving and not only Supriya Sule, you can also see Nana Patole how he is giving instructions to Amitabh Gupta who is the commissioner..." Patra was quoted as saying by ANI. "In the chat that has taken place in the chat box, in Signal app, apart from Supriya Sule and Nana Patole, there are some other big players. If there is any biggest player in this game of loot and corruption in this country, then it is Sonia ji and Rahul ji. And the way these things are happening allegedly and crores of rupees are involved in it,

235 crores rupees which we are hearing... We would like Rahul ji to hold a press conference on this and also give clarification from his side that did he not give instructions to Nana Patole?" he added. On her part, Sule has denied the allegations by accusing the BJP of resorting to "cheap politics".

## Bitcoin row: BJP targets Sule, Patole

New Delhi, Nov.20: The BJP on Wednesday intensified its attack on Maharashtra opposition leaders Supriya Sule and Nana Patole for their alleged involvement in using Bitcoins illegally to fund elections, and claimed their roles will surface during the probe. BJP spokesperson Sambit Patra also targeted Congress leaders Sonia Gandhi and Rahul Gandhi, and asked the Leader of Opposition in the Lok Sabha to hold a press conference on the issue. In a press conference, Patra rejected the opposition's claim that the BJP was behind the "conspiracy" to target them amid the Maharashtra polls as he claimed that the suspected crypto currency fraud occurred years back and the opposition alliance used the money in previous elections as well. It appears that the money involved so far in this scam is Rs 235 crore, he claimed. Sule has rejected the charges, including the audio records purportedly featuring her voice, as fake and said she has filed complaint with the Election Commission and the Maharashtra Police. "Familiar tactics of

spreading false information to manipulate the righteous voters," she said. She said on X, "The intent and mala fide actors behind it are amply evident, condemnworthy that such practices are taking place in a healthy democracy guided by the Constitution of India." Patra claimed that the matter came to light as Gaurav Mehta, a person involved in crypto currency trade and an alleged link to this case, decided to go public because he feared danger to his life after he encashed the Bitcoins to help opposition leaders. The BJP leader claimed that the matter has its roots in a crypto currency fraud in 2018, and a former IPS officer Ravindranath Patil, who had joined private sector and was tapped as an expert to help the investigation, ended up getting arrested for misappropriating a crypto currency wallet. Citing Patil's comments, Patra claimed two other IPS officers were involved in the missing wallet. Mehta had then given evidence against Patil and shared the alleged voice records of Sule and Patole, he noted.

### Vizag police arrest four youths in gang-rape case

VISAKHAPATNAM: Within hours after receiving the complaint, the Visakhapatnam city police arrested four individuals on charges of gang-raping a woman on Tuesday. The accused were identified as Batha Vamsi (27), a final-year LLB student and worked part-time as a Swiggy delivery agent, Boddu Jagadish (27), a fellow final-year LLB student, also worked as a Swiggy delivery agent, Polipalli Anand (28), worked parttime as a cashier and the fourth accused, Davulapalli Rajesh (23), a final-year LLB student from Chepaluppada, was engaged in rod-bending works. According to police, the victim, a third-year LLB student, had been in a relationship with Vamsi for over a year. He allegedly lured her into a room at Krishna Gardens on August 13, 2024. While the victim and Vamsi were in the room, Jagadish secretly filmed them through a window and later shared the video with Vamsi, Anand and Rajesh. The four accused used the video to threaten the victim and coerce her into sexual acts. The assault continued later that day in the same room. In another instance, Vamsi, Jagadish, and Rajesh took the victim to Thotlakonda, where they again threatened her with the video and sexually assaulted her in a secluded area.Unable to endure the repeated assaults and threats, the victim attempted suicide on November 18 at her house in Pedagantyada. She was saved by her father, to whom she disclosed the incidents. They subsequently filed a police complaint, leading to the arrests.A case was registered at the II Town Police Station under Crime Number 287/2024. The charges include sections of the Bharatiya Nyaya Sanhita (BNS) Act-2023 and the Information Technology (IT) Act. Visakhapatnam Commissioner of Police (CP) Shankabrata Bagchi confirmed the arrests

### Andhra: NTR Sports Stadium to undergo major revamp

- GUNTUR: In a significant move to rejuvenate sports infrastructure, officials from the Guntur Municipal Corporation (GMC) have announced plans to transform the Nandamuri Taraka Rama (NTR) Municipal Sports Stadium into a state-ofthe-art facility.
- Located in Brindavan Gardens, the stadium is Guntur city's sole sports hub and attracts 4,000 to 6,000 visitors daily, including athletes and walkers. However, years of neglect have left its courts, walking tracks, and other amenities in disrepair.GMC Commissioner P Srinivasulu, accompanied by Guntur West MLA Galla Madhavi and senior officials, recently inspected the stadium. They identified key issues, such as a damaged indoor stadium ceiling, leaks in structural slabs, a worn-out shuttle court and tennis court, and malfunctioning gym equipment. The swimming pool requires filter repairs, and new changing rooms for athletes are planned.

# **Remittances from Kerala make North's rural pockets rich**

PERUMBAVOOR: It's a hot Sunday afternoon at the Gandhi market in Perumbavoor, a town which is home to a large migrant population, mostly from West Bengal, Assam, Bihar and Odisha. Hundreds of migrant workers, who work in and around this small town near Kochi, have thronged the market to spend their weekly holiday -- purchasing cheap dresses, recharging their mobile phones, shopping groceries for the new week, or just catch up with their friends and relatives. But, perhaps the biggest

business in the market is something else -cash transfers.Tucked in a corner of the market's entrance is 'Mijanur Travels', an ordinary-looking shop run by Mijanur Rahman, in his 40s. Sunday is the busiest day in the week for Rahman, who hails from Murshidabad, West Bengal. People come here with the cash earned during the week gone by, and send it to their spouses or relatives back home in Guwahati, Nagaon, Bhubaneswar or Murshidabad.

"On a Sunday, I transfer anything between Rs 2-3 lakh for customers. There are some Sundays when Rs 4 lakh or more is transferred," he says. The remittances range from Rs 1,500 to 5,000, and even Rs 10,000 in some cases, and the small size of transactions means there could be as many as 100-150 such money transfers on a Sunday.



Rahman charges Rs 12 per Rs 1,000 remittances -- Rs 8 for the services provider (Pay World, BharatPe, Paytm. etc) and Rs 4 as commission.

Abhijul Islam of Assam Mobile Shop, a native of Nagaon, has been running a similar money transfer outlet inside the market for nearly three years. He says Assamese workers, who mostly work at plywood factories in the region, deposit the cash on a weekly basis while the Bengali workers, who are engaged in daily wage jobs in construction field, farms or other low-skilled works, deposit the money once in two or three days. Explains Lijin J, who runs a train and air-ticket booking shop in Perumbavoor: "For the migrant workers, who stay along with three the cash in the room. So, whenever they save Rs 3,000 or more, they immediately transfer the money back home."

There could be at least 30 shops in The business is booming, thanks to the high daily wages in Kerala and the shortage of workers in almost every sector that requires unskilled or semi-skilled workers.A 2021 study on 'In-migration, Informal Employment and Urbanisation in Kerala' by Dr Jajati Keshari Parida of Department of Economic Studies, Central University of Punjab, and Dr K Ravi Raman, member, Kerala State Planning Board, found that about Rs 7,500 crore is going out of Kerala annually as remittance to other states

Binoy Peter, executive director of Perumbavoor-based Centre for Migration and Inclusive Development (CMID), reckons this figure is a gross underestimation. "As per our conservative estimates, the migrant population in Kerala could be remitting at least Rs 17,000 crore per annum to their home states," he says. According to CMID's calculation, there are over 35 lakh migrant workers in Kerala, who are earning a total of Rs 49,000 crore here. "On a conservative basis, we have to assume that a migrant worker is earning Rs 700 per day, 20 days per month, for 10 months," he explains. or four persons in a room, it's not safe to keep Dr D Narayana, economist and former member of the Kerala Public Expenditure Review Committee, was involved in the first

comprehensive study on migrant population in the state, in 2012.

Perumbavoor engaged in money transfers. His report found that there was a 25-lakh strong migrant population during that time, growing at 8 % per year. "The migrant population in Kerala could be at least 48 lakh now," he says. There are no sectors where migrant workers are not present in Kerala, from construction to plantation, hotels to resorts, fisheries to grocery stores, and barber shops to high-end saloons. "Many sectors in Kerala would come to a standstill if migrant workers stop working," Dr Narayana says.Adds Planning Board member Raviraman: "While they are in Kerala, they become integral to what I would call 'right making/state making' process."According to Benoy, the resilience shown by rural India is due to the remittances by the migrant population, not just in Kerala, but also in other states. Significantly, the robustness of the informal Kerala economy is mainly due to the spending power of the migrant population on local goods and services here."While most of the Kerala households now depend on shopping malls or use e-commerce websites like Amazon and Flipkart for their purchases, and commute through Uber or their private vehicles, the small grocery shops, hotels, the private buses and autorickshaws largely survive on the spending by the migrant population here," he says.

# Parties deploy backroom mgrs, booth-level workers to ensure maximum turnout, avert thin margin wins

Mumbai: The campaign for assembly polls ended on Monday evening, but for this multi-cornered contest, political parties spent Tuesday focusing on getting their voters out in full strength on Wednesday.Political observers said the worry of thin margin wins or losses put Most netas and candidates were carrying the focus on voter turnout, as parties geared to get supporters to vote. They pointed out that compared with 2019, when there were only two prominent Congress-NCP and Shiv Sena-BJP alliances in the fray, this time there are six to seven major parties along with smaller parties fighting the polls. They said booth-level workers and backroom managers and their performance could make a difference between winning and losing."This makes it a multi-party contest, and margins are expected to be thin. In Lok Sabha, Shiv Sena's Ravindra Waikar won from Mumbai North West by just 48 votes, so this time candidates and poll managers don't want to take any

chances. Voter turnout and the party's voting machinery will be equally important as the popularity of the candidate or netas. All parties in Mumbai are now in backroom operations to get core voters out," said a political observer. out backroom operations, doing lastminute checks on booth management, and ensuring that their core voters come to the booths.

"After the tumultuous campaigning for the assembly elections ended, I spoke to BJP netas, booth chiefs, and booth workers from my South-West Nagpur constituency over the phone and took a detailed review of tomorrow's preparations. I also wished everyone a successful celebration of democracy," said BJP's Devendra Fadnavis in a post on X.A political analyst said with parties such as MNS and Vanchit Bahujan Aghadi (VBA) fighting over 200 seats, their vote-splitting ability will be tested.

"These candidates who are not in Mahayuti or MVA will make things more difficult for the bigger parties. After the split in the Shiv Sena and NCP, and one faction with each alliance, whose votes will be split because of the smaller parties and independents is very difficult to guess. So, the only way to counter this is to ensure maximum voting among core groups and supporters. Usually, enthusiasm among voters is lower in assembly polls compared to Lok Sabha polls, so it will be a challenge. The last day, last-minute voting machinery may prove to be pivotal," the analyst said.Rebels threatened to become a headache for the two major alliances. Close to 150 politicians from across parties filed nominations in defiance of their party's or multi-party alliance's official candidates. Later, many of them withdrew their nominations, and those who didn't were suspended or sacked by their parties.

## Tamil Nadu to implement biometric attendance for university staff to curb unauthorised absences

CHENNAI: To check unauthorised absence of faculty members and administrative staff, the higher education department has directed the universities to install biometric attendance marking systems on campuses.In a circular issued to registrars of all universities, the department said many teaching and nonteaching staff of the universities are coming to office late and leaving early without permission of the authorities concerned, with some also remaining on unauthorised absence from duty. "Such activities will bring an unpleasant impression on the institution and may lead to bitter relationships between students and staff," it said.

The department has also directed the universities to take measures to implement onboard e-office systems for submission of files, personal information systems. It has also directed the universities to update and maintain the university website on a regular basis.

V Thangaraj, president of Tamil Nadu All Government college UGC Qualified Guest Lecturers Association, said the move will help check exploitation of guest lecturers in universities."Guest lecturers are paid little but are burdened with work. In many universities and government colleges, the permanent faculty members don't come regularly or remain on unauthorised leave, and the guest lecturers are forced to do their share of work. After biometric attendance system is introduced, we hope that this practise will be eliminated," he said.Bharathiar University Registrar (in-charge) Rupa Gunaseelan told TNIE the university it will introduce the biometric attendance system on its campuses within two weeks. In another development, the higher education department has issued a G.O. stating teachers of government colleges, who retire in mid of the year will be retained until May 31, 2025, until closing of the academic year for the benefit of the students. ## Telangana HC strikes down GO 16 regularising contract jobs

HYDERABAD: In a landmark judgment, the High Court on Tuesday declared Section 10-A of the Telangana (Regulation of Appointments to Public Services and Rationalisation of Staff Pattern and Pay Structure) Act, 1994 unconstitutional while making it clear that the services of contractual employees who have already been regularised would not be terminated.

A bench of Justice Sujoy Paul and Justice Namavarapu Rajeshwar Rao was hearing a clutch of writ petitions filed by A Venkatram Reddy and others challenging the decision to regularise contract lecturers through Government Order (GO) 16 dated February 26, 2016. The GO amended the 1994 Act by introducing Section 10-A, allowing the state to regularise the services of contract lecturers who met specific criteria. The petitioners argued that the regularisation violated the principles of fair recruitment under Articles 14, 16, and 21 of the Constitution and Supreme Court precedents, particularly the Constitution Bench ruling in State of Karnataka v. Umadevi. They contended that the contractual appointments were made without following a transparent selection process and deprived eligible candidates of a fair chance.

The petitioners pointed out that over 5,540 lecturer posts in junior, degree and vocational colleges were regularised without advertising the vacancies. They argued that the move was arbitrary, contrary to public policy, and violative of the 1994 Act's objectives.

Gandhi University, Kakatiya University, Satavahana University, Palamuru University, and Telangana University remained closed, disrupting College owners say they are in no position semester exams and impacting over seven lakh students from 1,048 colleges.The Telangana Private Degree & PG College Management Association (TPDPMA) is demanding the release of at least half of



the Rs 1,300 crore dues, pending for more than three years.

The association stated that no meaningful progress has been made since their last meeting with officials in October. While colleges under Osmania University

The financial crisis has worsened, especially since 2018, and we have been struggling to sustain operations." He said that Rs 600 crore - Rs 450 crore for private colleges and Rs 150 crore for government colleges - was urgently needed.

Tokens for approximately Rs 1,200 crore were reportedly issued over the last 18 months, but the dues remain unpaid, Suryanarayana Reddy revealed. According to the association, 20% of dues for 2021-22, 70% for 2022-23, and 100% for the current academic year were still pending.

In the middle of the year, it will be difficult to make alternative arrangements for a retiring teacher. Hence, it has been decided to allow them to continue till completion of academic year," said an official of higher education department.

# Thiruvambady Devaswom's actions during Pooram suspicious, CDB in Kerala HC

KOCHI: The Cochin Devaswom Board (CDB) has told the Kerala High Court that certain actions of the Thiruvambady Devaswom during the Thrissur pooram had given rise to suspicions that they were aimed at aiding certain political parties to influence the Lok Sabha elections.Giving credence to the CPI's claim of a concerted effort to disrupt the pooram, the CDB, in a report submitted to the HC, said a series of incidents that occurred during a one-year period ahead of the

prestigious event supported the allegation of a conspiracy to undermine the festival."The Thiruvambady Devaswom's dubious actions included disrupting the pooram by involving in discussions individuals who had no connection to it or the festival. The involvement of BJP leaders B Gopalakrishnan and district president K K Anishkumar and RSS leader from Kannur Valsan Thillankeri has further strengthened these suspicions," the report



said.Adding to the controversy, Suresh Gopi, who was then BJP's candidate from Thrissur, openly intervened in the issue. "Despite it being a no-traffic zone, he broke the law by using a Seva Bharathi ambulance, allegedly to provoke anger that could force a stop to the festival midway, which could further his electoral interests. He also spread false information through channels and social media, claiming that the pooram was in disarray," the report said. It also stated that Gopi had spread the news that issues had been settled following his intervention.Public accusations and counter-allegations aired on channels and in newspapers by office-bearers have brought disgrace to the public discourse. "These incidents confirm suspicions about the Thrissur Pooram conspiracy," stated the report. According to the CDB report, one glaring example of the conspiracy is the delay of the fireworks display, which was scheduled for 3 am but was postponed until 7.15 am.

#### Pooram: Call to set up high-powered committee

This delay should be viewed as an unethical pressure tactic by the Thiruvambady Devaswom," it said. A list of 160 individuals-comprising 85 workers and 65 committee members-was submitted by Paramekkavu Devaswom seeking permission to stand on the highly regulated pooram ground during the fireworks. However, the ThiruvambadyDevaswom

initially refused to provide a similar list, the report said. Eventually, they agreed to participate in the fireworks display only on the condition that all individuals they nominated be allowed on the ground.

## Muck piles up on roads, residents protest

Noida: Residents of Sector 105 in Noida have raised complaints about sewage being dumped near the sector gate for several days. On Tuesday, they staged a protest against this illegal dumping and demanded immediate action from the civic body."There is a commercial property located to the right of our gate number 3, where sewage waste is being dumped. Several complaints have been made to the Noida Authority, but there has been no resolution, even under GRAP Stage 4, implemented to curb pollution. The accumulated sewage waste has now spread over an area of up to 1 km. More than 9,000 residents of Sector 105 are being forced to endure the foul stench caused by the dumping of sewage and garbage near the sector gate," said Deepak Sharma, RWA president of Sector 105.

Residents further alleged that when they wrote to the CEO of the Noida Authority, an attempt was made to cover the waste with soil.Rajeev Dublish, the RWA general secretary, added, "As per pollution regulations, the intersoil used should be non-biodegradable, but the sewage waste being dumped here is biodegradable. It is rotting and spreading a terrible stench. The smell persists as no permanent solution has been implemented. Many residents are already complaining of breathing issues due to pollution, and this foul smell is making the situation worse."Unable to find a permanent solution, residents of the sector organised a protest near the dumping site on Tuesday.A response from the Noida Authority is still awaited.

## 52 nabbed for cyber frauds in 4 months, 9 crore recovered

Noida: As many as 52 people were arrested by Noida police from various states in connection with cases of cyber fraud over the past four months. The cops also managed to recover Rs 9 crore that the accused had taken from targets. Apart from these, raids in five sham call centres led to the arrest of 71 people over a period of time. Officials said they had tracked down the accused cyber frauds to states such as Rajasthan, Maharashtra, Haryana, Punjab, Gujarat, Delhi, apart from UP, recovering Rs 9.4 crore in total. According to the officials, 23 of these cases were successfully prosecuted during this period.Noida police commissioner Laxmi Singh said police were regularly carrying out drives to raise awareness among people about cybercrime."We've intensified our efforts to alert residents about various cyber frauds, such as digital arrests, share trading, investment schemes, and utility bill-related crimes. Our outreach extends to RWAs in various sectors and educational institutions as well," she added.

Cyber cops have also set up a dedicated WhatsApp group with RWA representatives to share real-time updates about emerging threats and scams. Of late, they also conducted interactive sessions for university students in collaboration with Adobe."Our initiatives included lectures at cyber security school and expertled sessions," Singh said, adding, "the team participated on Cyber Security Day organised by Noida Industries' Association and maintained a presence at Greater Noida Expo to promote cyber safety." Police have also conducted extensive training sessions with major banking institutions, such as SBI, PNB, ICICI, HDFC, Bank of India, Bank of Baroda, and Bandhan Bank. These sessions emphasised on the importance of thorough customer verification processes and transaction monitoring to prevent largescale frauds.

# Man killed sister-in-law, infant niece as brother refused him 25k to fly to Dubai

Ghaziabad: A 24-year-old man who allegedly strangled his sister-in-law and her infant daughter in their house in Bamheta village on Monday was upset after his dream to work in Dubai was cut short when his brother refused to lend him Rs 25,000, allegedly on the insistence of his wife, to get a flight ticket. Mohamad Zeeshan was arrested early on Tuesday, barely hours after he sneaked back into the house, this time, to attack his brother to extract a "final revenge".DCP (rural) Surendra Nath Tiwari said the accused was hoping to start a job as a welder in Dubai and had paid an agent, Sanjar, Rs 1.30 lakh — an amount he had saved up from his job in Pune — for a passport, visa and ticket. While the agent had given him a passport, Zeeshan was to get the ticket and visa from the agent's Noida office and take a flight on Nov 9, the officer said.Once in NCR, Zeeshan went to stay with his brother in Ghaziabad. When he went to get his documents from the agent's Noida office, he was told that the flight was cancelled and was asked to pay up more money."Zeeshan asked his



brother Mohamad Burhaan to lend him Rs 25,000 after reaching the latter's house in Ghaziabad on Nov 7. Burhaan initially agreed to help but apparently went back on his words after his wife, Shaheen Parveen, refused to give him the money. Zeeshan blamed his brother and sister-inlaw for missing out on his dream job," the DCP said.Zeeshan, police said, also

nursed a grudge against his sister-in-law as her cousin, Afroz, had insulted him over some argument barely two months ago. It was Afroz who had later introduced Zeeshan to Sanjar.Police believe that Zeeshan blamed the trio, along with his brother, when his plan to get to Dubai did not work out and he lost his savings."On Monday, when Burhaan left for work and

his two sons, Ayan and Anam, went to school, Zeeshan strangled his Parveen with a scarf around 10.15 am. He then turned to his three-year-old niece and tried to grab hold of her, but the child managed to escape. He then strangled the three-month-old infant, lying on a cot, with his bare hands. After killing the two, Zeeshan stuffed his clothes in a bag and fled," the DCP said.During interrogation, the accused told cops that he went straight to the travel agency's office in Noida. "We found that he misbehaved with the employees there and snatched the receptionist's mobile and fled. Zeeshan used this phone number to make multiple calls to Burhaan. He allegedly threatened his brother, saying he wouldn't spare him either. Zeeshan claimed he returned to his brother's home later that night as he wanted to "teach him a lesson" too, but didn't find Burhan as he had left for the burial ground," he said.Zeeshan was arrested for murder (BNS Section 103) early on Tuesday from the Lal Kuan area by a team of cops from Wave City PS and sent to judicial custody.

Noida: The Noida Authority has started Noida-Ghaziabad Investment Region (DNGIR) – commonly referred to as New Noida. The Noida Authority CEO, along with other officials, carried out a preliminary survey on Monday in Bulandshahr before the land acquisition begins.Noida CEO Lokesh M said, "We inspected the proposed land in the Sikandrabad area of Bulandshahr. We also inspected the land in Jokhabad village for a temporary office of the Noida Authority, which will supervise the land acquisition and development works in the area. The officials have been directed to start

the land acquisition process. Soon, we will hold meetings with the local

Land measuring 209.11 sqkm across 80 villages from the Gautam Budh Nagar and Bulandshahr districts has been notified for this. Of these 80 villages falling under the DNGIR area, 63 are in Bulandshahr while the remaining are in GB Nagar. The Authority plans to develop the area in four phases - 3,165 hectares will be acquired in Phase 1 by 2027, 3,798 hectares in Phase 2 by 2032, 5,908 hectares in Phase 3 by 2037, and 8,230 hectares in Phase 4 by 2041.In Oct, the state govt approved the Authority's Master Plan 2041. Under this, the Authority has earmarked 40% of the acquired land for industrial purposes, 13% for residential purposes, 18% for green

other development projects. According to officials, the DNGIR area has been identified as one of the key proposed investment regions in the first phase of the Delhi-Mumbai Industrial Corridor (DMIC). This area has excellent connectivity through road and rail links to the rest of the state as well as the country. It will have Noida, Greater Noida, YEIDA area, and also the Noida International Airport in its vicinity. These adjoining urban areas have a well-evolved road network, state-of-the-art physical and social infrastructure along with some of the best residential, commercial, institutional, and entertainment areas, officials added

Noida: At least 17 persons were injured after multiple vehicles piled up on the Eastern Peripheral Expressway (ÉPE) as visibility reduced to only a few metres on a foggy Tuesday morning. The spate of accidents, police said, occurred around 5.15am near Dadupur village under the Ecotech 1 police station."Three vehicles were involved in the pileup-two trucks and a bus. A team was rushed to the spot after passersby informed us about the accident. Seventeen people were injured and were taken to a nearby hospital for treatment. Dense fog early in the day caused the series of accidents," said Anuj Kumar, the SHO of Ecotech-1 police station.Preliminary investigation revealed that a truck travelling from Kasna to Faridabad crashed into another from behind. Subsequently, a bus carrying passengers to Mathura from Panipat rammed the second truck, leaving many of its passengers injured."After sending the injured passengers to hospital, our primary task was to remove the damaged vehicles from the busy EPE. All the passengers suffered minor injuries and were discharged from hospital after treatment," Kumar said. With visibility a concern during winter, administrations in various districts of NCR come out with advisories with reduced speed limits on expressways and other major highways. Through this week, IMD has predicted foggy conditions for Noida and Ghaziabad.On Monday, the Noida administration issued a comprehensive road safety advisory to reduce the risk of accidents on speedways.

The measures include ensuring vehicles are equipped with functional fog lamps and wipers. The advisory, issued by deputy commissioner Ajay Kumar, referred to the GRAP IV notice of Commission for Air Quality Management, which stated that administrations in NCR



Gurgaon: NHAI requested GMDA to accelerate the payment of Rs 100.5 crore for relocating utilities as part of the renovation project at Hero Honda Chowk and Umang Bharadwaj Chowk last week. The development work covers a 2.2km segment of the Gurgaon-Pataudi-Rewari portion of NH-352W and are being carried out by NHAI, while GMDA is funding the project. According to estimates, shifting of a water supply pipeline will cost Rs 33.11 crore, while relocating sewer and stormwater drainages falling along this road will cost Rs 23.75 crore.Additionally, an estimate of Rs 43.63 crore has been prepared for the relocation of high-tension electrical lines.

An NHAI official said that they have to start the shifting works before the construction begins. "Since it is a busy stretch, we have to prepare a traffic diversion plan and service road so that there is minimal disruption during construction," the official added.Meanwhile, a GMDA official said a partial amount of the project cost was transferred to NHAI. This project was part of a broader plan, first approved in 2017, to widen and improve the 5.6 km stretch between Hero Honda Chowk and Dwarka Expressway.

While GMDA completed its work on the 3 km section between Umang Bharadwaj Chowk and Dwarka Expressway and NHAI operationalised the underpass on the expressway, the works on the 2.2 km stretch between Hero Honda Chowk and Umang Bharadwaj are yet to take off. The project was originally financed by GMDA, while HSVP was responsible for handing over the land required for the revamp of the 2.2 km stretch. The revamp plan underwent several revisions over the years. Initially, NHAI proposed to widen the road into six lanes with a flyover at Umang Bharadwaj Chowk, and the work for this was originally supposed to start in 2019. But later, it was decided that the project would be merged with the Gurgaon-Pataudi-Rewari Highway, pushing the start date to Nov 2021 and the deadline to Nov 2023.

Later in 2022, Gurgaon MP and Union Minister Rao Inderjit Singh insisted on the construction of an elevated road between Hero Honda and Umang Bharadwaj Chowk, citing demand from RWAs and industrial associations. The approval of metro expansion works cast a shadow of doubt on the project.



## Donald Trump chooses 'Dr Oz' to head US public health insurance programme



World. Donald Trump announced on Tuesday that he was appointing Mehmet Oz, a former surgeon and TV celebrity known as "Dr Oz," to lead the US's massive public health insurance programme. The 64-year-old heart surgeon was championed on daytime television by Oprah Winfrey before he entered politics with an unsuccessful bid for a Senate seat in 2022.Oz is the latest of Trump's eye-catching nominations to key positions, including Fox News host Pete Hegseth to be defence secretary, vaccine skeptic Robert F Kennedy Jr as health secretary and billionaire Elon Musk to head a government cost-cutting unit.

- "America is facing a Healthcare Crisis and there may be no Physician more qualified and capable than Dr. Oz to Make America Healthy Again," the president-elect posted on his Truth Social platform.
- The appointment puts a man whose health recommendations- especially on Covid and weight loss- have often been ridiculed by the medical community at the helm of the United States' Centers for Medicare and Medicaid Services (CMS). As CMS administrator, Oz will be in charge of a federal agency that provides health coverage to more than 160 million Americans- almost half the country's population. It employs about 6,700 people, had outlays of USD1.48 trillion last year and is one of the largest purchasers of healthcare services in the world.
- A son of Turkish immigrants, Oz has never held public office before, but has been a steadfast ally of Trump, who backed him in his unsuccessful Senate run in Pennsylvania.

## What would Robert F. Kennedy junior mean for American health?

- World. AS IN MOST marriages of convenience, Donald Trump and Robert F. Kennedy junior make unusual bedfellows. One enjoys junk food, hates exercise and loves oil. The other talks of clean food, getting America moving again and wanting to eliminate oils of all sorts (from seed oil to Mr Trump's beloved "liquid gold"). One has called the COVID-19 vaccine a "miracle", and the other is a long-term vaccine sceptic. Yet on November 14th Mr Trump announced that Mr Kennedy was his pick for secretary of health and human services (HHS).
- Public-health leaders have responded with horror and disbelief. "Robert F. Kennedy junior is not remotely qualified for the role," said Dr Peter Lurie, president of the Centre for Science in Public Interest, a publichealth watchdog, in a statement, adding that "nominating an anti-vaxxer like Kennedy to HHS is like putting a Flat Earther at the head of NASA." Industry types are similarly worried. Shares in vaccine-makers, such as Moderna and Pfizer, and biotech firms fell in response to the news.
- The panic is understandable. Mr Kennedy has a long history of promoting debunked health theories and claims about vaccines, most damagingly about the risks of inoculating children. He has said that "there's no vaccine that is safe and effective" and has advised parents not to follow guidance by the Centres for Disease Control and Prevention (CDC), one of the health agencies that could soon fall under his direction. He is a proponent of several unproven alternatives to mainstream medicine, ranging from the kooky but harmless to the actively dangerous. And he has promised to dismantle large parts of America's core public-health agencies-including the CDC, the Food and Drug Administration and the National Institutes of Health (NIH)-and purge them of the "smothering cloud of corporate capture". If he does make it into the job (he will have to survive confirmation by the Senate), what might that mean in practice? His Make America Healthy Again (MAHA) movement, which the Trump campaign embraced in the final phase of the election, gives clues to some of his public-health priorities.

# **Israel Seizes Weapons Found** Beneath Lebanese Schoolyard

Israeli soldiers seized weapons from a Hezbollah facility in southern Lebanon, while Netanyahu vows to prevent Hezbollah's strengthening.

WORLD. Israeli soldiers seized a weapons cache located beneath a schoolyard in southern Lebanon, the Israel Defense Forces disclosed on Tuesday. The weapons were found in an underground Hezbollah facility tens of meters long. Rockets, explosive charges, rocket-propelled grenades and other weapons were seized.

The army added that soldiers also captured rocket launchers, anti-tank missiles, military equipment, and intelligence documents in a nearby building.On Monday night, Israeli Prime Minister

Benjamin Netanyahu vowed not to allow the Iran-backed Hezbollah return to its pre-war strength."We will be required, in order to ensure our security in the north, to systematically carry out operations--not only against Hezbollah's attacks, which could come. Even if there is a ceasefire, nobody can guarantee it will hold. So it's not only our reaction, a preventive reaction, a reaction in the wake of attack but also the capacity to prevent Hezbollah from strengthening," said Netanyahu during an address to the Knesset.

Sarit Zahavi, president and founder of the Alma Research Center, told The Press Service of Israel in August that Hezbollah doctrine makes extensive use of civilian areas, where many more weapons, including ballistic missiles, are kept."Hezbollah stores their weapons everywhere, both between villages and within the villages themselves," she said. "By and large, every third house in the Shi'ite



villages of south Lebanon is used in some way by Hezbollah for military purposes, be it weapons storage, the entrance of a tunnel, or a launchpad for shooting rockets at Israel," she explained. Soldiers have even found cruise missiles inside homes ready for launch.After the Hamas attacks of October 7, 2023, Hezbollah began launching rockets and launching drones at

northern Israel communities daily. More than 68,000 residents of northern Israel are displaced from their homes. Hezbollah leaders have repeatedly said they would continue the attacks to prevent Israelis from returning to their homes.According to United Nations Security Council Resolution 1701, which ended the 2006 Second Lebanon War, Hezbollah is forbidden from operating in southern Lebanon south of the Litani River.At least 1,200 people were killed, and 252

Israelis and foreigners were taken hostage in Hamas's attacks on Israeli communities near the Gaza border on October 7. Of the 97 remaining hostages, more than 30 have been declared dead. Hamas has also been holding captive two Israeli civilians since 2014 and 2015, and the bodies of two soldiers killed in 2014.

## Health Secretary Supriya Sahu urges DCGI to ban online sale of addictive drugs like tapentadol

- CHENNAI: Health Secretary Supriya Sahu wrote to the Drugs Controller General of India (DCGI) requesting his intervention to ban websites that sell habit-forming (addictive) drugs, particularly tapentadol, in violation of existing laws. In her letter, Sahu pointed out the state police and the drugs control department have reported a worrisome trend of offenders procuring the drugs through online platforms.She said states have not been empowered to block such websites under current provisions of law, hampering its efforts to combat the menace effectively.In the letter dated November 12 to DCGI Dr Rajeev Singh Raghuvanshi, Sahu said the situation undermines the state's ongoing initiatives aimed at preventing drug abuse among students and the public.
- The sale of Schedule H and H1 medicines without a prescription from a registered medical practitioner and without the supervision is a clear violation of Section 18(c) of the Drugs and Cosmetics Act, 1940 read with rules 65(9)(a) and 65(2) of the Drugs Rules, 1945 respectively. The lack of transparency regarding the sellers' licence further exacerbates the issue, making it difficult to trace and monitor illegal transactions, Sahu added.She said the officers face considerable challenges in controlling the flow of these substances through online channels, which often evade regulatory scrutiny. "As the Drugs and Cosmetics Act, 1940 is a Central Act, I urge you to expedite the formulation of regulations governing the online sale of pharmaceuticals

# Fruit bats destroy Rudraksha yield, BJP leader Muraleedharan's remarks **BJP leader Muraleedharan's remarks** Kerala farmer sues forest dept

KOCHI: Fruit bats causing damage to crops is nothing new. But a farmer suing the forest department seeking a huge compensation for the loss he incurred owing to the flying mammals is not something common.C D Adarsh Kumar, whose main source of income were two Rudraksha trees in his orchard, was a successful farmer

until recently. He said he earned a handsome Rs 1 crore per year from his four-acre land until a few years back. He used to sell quality Rudraksha beads from the two trees.

However, a colony of bats that feed on unripe fruits have left him devastated. The resident of Kallekulam, Poonjar, has been unable to earn a penny from the farmland in the past three years, and landed in a debt trap.Facing recovery proceedings from banks, Adarsh has moved the Pala sub-court seeking a compensation of Rs 2.25 crore from the forest department. However, can the forest department be held responsible for the crop loss caused by fruit bats? Adarsh says the custodian of forest is responsible for the loss caused by protected wild animals that intrude into farmlands outside the forest."I developed a biodiversity park on my



four-acre farmland over the past 35 years, where I grow rare and exotic fruit trees. The fruit bats started attacking the trees since 2015-16, and I have not been able to earn even a penny in the past three years. I had to sell some trees to meet my family's expenses in the past couple of years. 'Some beads like Gauri-Shankar fetch fancy prices. Beads with five faces are common and are sold for '10 per piece. However, I can grow four saplings from a bead which I sell for `100 each. Besides, there are fruits like Durian,

Filosan, Borneo avocado and Rambutan in my orchard which provided me steady income. However, for the past three years, I haven't been able to harvest the yield as a big colony of bats is feeding on my crops regularly," he said. He said he has a liability of '1.67 crore with the Poonjar bank and a little over '1 crore with the Poonjar branch of Kerala Bank. "I also took a loan of `4 lakh in my wife's name. The banks will attach my property and my family will be on the streets soon. The fruit bats have devastated my life and the forest department has to pay me compensation," said Adarsh.Kerala Independent Farmers Association (KIFA) legal consultant advocate Jose J Cheruvil said fruit bats are a protected species categorised under Schedule I of the Wildlife Protection Act, 1972."If farmers kill them or fire gunshots to scare them, it will be considered an offence. However, wild animals should be restricted in the forest and as custodian of forests, the forest department has to be held accountable for the devastation caused by animals.As per the strict liability principle, the department is liable to pay compensation if wild animals stray into the property of farmers and destroy crops.

THIRUVANANTHAPURAM: Senior BJP leader V Muraleedharan on Tuesday courted a controversy after he claimed only three local body wards were washed away in the Wayanad landslides, not an entire region. "It is not right to say a region was washed away in the landslides.Only three wards in two panchayats were destroyed. Money can be sanctioned only according to the law," Muraleedharan had told reporters in response to questions over the delay in central aid to rehabilitate the victims of the July 30 calamity.Maintaining that the Union government had not said additional assistance won't be given to Wayanad, Muraleedharan accused political parties of using the disaster for political gains. He also termed the joint LDF-UDF hartal in Wayanad against the Centre's stand, "a drama to prevent BJP's victory in the bypolls."He also said there was no point in having emotional talks on the issue. "The state governemnt asked for Rs 214 crore from the Centre for rehabilitation. It is, however, not spending the Rs 788 crore it has in its possession for disaster relief," he said. His remarks stirred up a controversy with the CPM and Congress accusing him of trivialising the tragedy.Kalpetta MLA T Siddique accused Muraleedharan of insulting the victims, while Tourism Minister P A Mohamed Riyas, in a Facebook post, termed Muraleedharan a "disaster of a severe nature.

CPI state secretary Binoy Viswam said the former union minister's remarks could not be pardoned. "There are a lot of victims in Wayanad who do not have any information about their kin. Muraleedharan spoke against them. It is unpardonable," he said.LDF convener T P Ramakrishnan said Muraleedharan's analysis of the disaster was unrealistic

## Former CM YS Jagan flayed for Rushikonda splurge

VIJAYAWADA: A heated debate unfolded in the Andhra Pradesh Legislative Council between members of the ruling NDA government and the opposition YSRC over the buildings constructed at Rushikonda during the previous YSRC regime. The treasury benches criticised the previous government for demolishing the Haritha Resorts, accusing them of misusing over Rs 420 crore of public funds to build "palatial structures" for the Chief Minister's camp office. Meanwhile, YSRC leaders countered the claims, asserting that the buildings were constructed for official government use, not personal use by former CM YS Jagan. Leader of the Opposition in the Council, Botcha Satyanarayana, challenged the government to conduct an inquiry if they suspected irregularities in the construction process.On the same issue, Tourism and Culture Minister Kandula Durgesh accused the previous government of demolishing Haritha Resorts, which reportedly generated an annual income of Rs 16 crore, promising to replace them with superior facilities. Instead, he alleged, the YSRC regime constructed seven blocks and repurposed them as luxurious camp offices for the CM under the guise of improving infrastructure. Durgesh faced strong objections from YSRC MLCs as he made these statements.

# Pilot project on government school timings change from Wednesday

VIJAYAWADA: The State government's latest education reform to extend school hours sparked a heated debate among stakeholders. While parents have largely welcomed the move, teachers warn it could increase the burden on students, especially those in rural and tribal areas.Starting Wednesday, a 10-day pilot project will be launched in one high school or high school plus per mandal across the State. The project, ending on November 30, aims to gather feedback from stakeholders before deciding on permanent implementation.Under the proposed schedule, school timings will be extended by an hour, shifting from 9 am-4 pm to 9 am-5 pm. The assembly period will increase by 10 minutes, each of the Commissioner of School Education V Vijay



eight periods will be extended by five minutes, and two short breaks will be lengthened by five minutes each. The adjustment, designed to provide more time for syllabus coverage, keeps the current workload intact.

Rama Raju told that the reform addresses parents' concerns about student safety and aligns with private school schedules. "If the feedback is positive, the new timings will be implemented. If not, the assured.Parents, like M Sundara Venkatesam from Vijayawada, said, "The extended hours not only enhance academic engagement but also provide a safe space for children until working parents return home," he said. However, teachers have voiced strong opposition, emphasising the potential stress on students' mental and physical well-being. They argue that longer hours could rob children of personal time and opportunities for community interaction.

Comparisons with neighbouring States such as Kerala, Tamil Nadu, Telangana, and Karnataka, where school hours range between five and six hours, add fuel to the debate.

# Millers delay payments, tillers fear domino effect in Telangana

NALGONDA: Farmers in Nalgonda district are agitated by the delay in payment for their produce by millers. Millers, who are supposed to pay farmers within three to seven days after buying superfine variety paddy, are now saying they will make payments within a month from the date of purchase. As a result, rice mill managers are issuing stamped bills to the farmers.Farmers claim that the state government is yet to provide the Rythu

Bharosa payment for this Kharif

season. Additionally, as millers have not paid for the grain, farmers are now struggling to secure the necessary funds to plant crops for the Rabi season, which begins in the last week of November and the firs week of December.While the Union government has set the MSP for fine rice at Rs 2,320 at IKP centres and the state government has announced an additional bonus of Rs 500, many farmers are being forced to sell their rice at lower prices due to moisture content exceeding 17% and the lack of proper facilities for drying paddy dryingAdditionally, with the high demand for fine rice sales and a



large number of arrivals at the mills, farmers are complaining of delayed payments for the grain they have sold.Yaragani Somaiah, a farmer from Tipparty mandal told : The Rabi season begins in the last week of November and first week of December. However, the government has not yet released the Rythu Bharosa payment for the Kharif season and there is no indication of when it may be provided for the Rabi season. I own five acres of land and the cost of cultivating each acre is Rs 15,000. I am forced to borrow money at high interest rates to fund the next season's crops."Upon requests from farmers to

district officials to ensure that millers make payments for the grain they have purchased, the collector instructed millers to pay farmers within a week, but in vain. Many fear that if the situation persists, it could lead to an increase in farmer suicides, as has happened in previous seasons.In Nalgonda, fine rice was cultivated on about 3 lakh acres, yielding about 4 lakh metric tonnes. While civil supplies officials had expected 2.80 lakh metric tonnes to be delivered to IKP centres, only 650 metric tonnes had reached the 80 IKP centres set up in the

district.Speaking to over the delay in payments, a miller stated: "Farmers were not being pressured to sell their produce to them. We also informed them that if any miller pays them within one month, they can send their produce to them only. Additionally, farmers who sold their paddy 10 days ago had received payment in less than three days or a week, but due to financial constraints, we have extended the payment deadline to a month."District Civil Supplies Officer V Venkateshwarlu told TNIE that he has once again instructed millers to expedite payments to farmers.

## Western immigration curbs to affect remittances

- Migration of the workforce from India to various countries has increased since the mid-1990s, making the Indian diaspora the largest in the world. This has also resulted in the rise of remittances back to India, making it one of the highest recipients. The recent changes in immigration policies in Canada and potential changes in the USA are likely to affect India, especially the states from where emigration is taking place in large numbers. These states include Kerala, Gujarat, Punjab and Andhra Pradesh.
- In India's remarkable economic performance, the role of liberation, privatisation and globalisation (1991) is mentioned by many economists and global institutions. In this endeavour, the economic policy changes were accompanied by realignment of India's relationship with G7 countries. This was extended through India's effective participation in the G20 meetings. This has enabled India to attract a large amount of foreign capital, along with a high rate of domestic savings and investment. At the G20 meeting in Delhi last year, it was decided to build a rail link to Europe through Middle East countries as an alternative to China's Belt and Road Initiative.
- A large number of educated Indian skilled and semiskilled workers have also found jobs abroad. These developments have given a fillip to the Indian diaspora's expanding numbers, making it the largest and highest contributor to domestic remittances in the world in recent years. This has happened due to a balance in the economic policy and country's international engagements.
- The number of Indian immigrants has risen from 79 lakh in 2000 to 189 lakh in 2023. Indian immigrants send remittances back home, raising consumption standards of their families, as well as investment in housing and businesses. Their contribution to India's foreign exchange earnings is notable. The largest number of Indian immigrants are in the USA (44.60 lakh). The combined number of immigrants from the four close US allies is 86.49 lakh - Australia (4.96 lakh), Canada (16.89 lakh), New Zealand (2.40 lakh) and UK (17.64 lakh). This number rises to 189 lakh if immigrants to Europe are added.Another region which has a large Indian presence is the Middle East countries. The UAE, Saudi Arabia, Oman, Kuwait and Qatar have 85.77 lakh Indian immigrants. There is a major difference in the immigration policy of these two regions. The Western countries allow the immigrants to settle permanently and grant them citizenship. The Gulf countries do not allow this. This makes Western countries the most preferred destination for immigrants. The USA and its four close allies accounted for more than 35 per cent of the remittances received by India in 2023. The USA alone contributed 23 per cent followed by UK (6.8 per cent), Canada (2.4 per cent), Australia (1.9 per cent) and New Zealand (less than one per cent) of India's total \$120 billion remittances. The combined contribution of Western countries (including Europe) is slightly more than that from Gulf countries, whose share in Indian remittances stands at 42 per cent of the total. These two regions contribute more than 85 per cent of total Indian remittances, which help the country meet massive foreign trade deficits. State-wise data of remittances shows that Kerala tops the list, followed by Maharashtra, Karnataka and Tamil Nadu.Despite a large number of immigrants to various countries, Punjab still lags behind these states. This is due to the fact that Punjabi emigrants are largely concentrated in the UK, Canada, the USA, Australia and other countries where they have settled permanently, and over time the flow of remittances has

# India's policy change towards Taliban pragmatic

#### India's hopes of controlling movement of weapons and drugs from Afghanistan into Jammu and Kashmir and Punjab via Pakistan and Iran hinge on improved relations with Taliban

In late January 2024, Chinese President Xi Jinping received credentials from the envoy of Taliban Second, the Taliban rule over 40 million Afghans and regime raising eyebrows of other countries, which had avoided giving it diplomatic recognition in view of its refusal to allow women to receive higher education, respect human rights and broad-base its government. A Chinese Foreign Ministry spokesman subsequently clarified that China was merely engaging the new Taliban government to provide humanitarian aid and foster economic cooperation and by receiving the Ambassador, it had not given the diplomatic recognition to the new

government.Following the same approach, India has made a few changes in its policy towards the Taliban regime. First, some India-based personnel of its embassy in Afghanistan returned to Kabul in June 2022 as a "technical team" to monitor the delivery of its humanitarian assistance for the Afghan people. Second, India allowed the Taliban to take de facto control of its diplomatic missions in India in November 2023 and the Ambassador posted by the earlier Afghan government left India.

Earlier this month, a senior official of India's External Affairs Ministry, JP Singh, Head of Pakistan-Afghanistan Division, met Taliban Defence Minister Mohammad Yaqub Mujahid and Foreign Minister Amir Khan Muttaqi in Kabul to discuss ways to expand bilateral relations and accelerate the delivery of humanitarian assistance

using the Chabahar port, now being operated by an Indian company. India is also considering the request of the Taliban government to appoint a Second Secretary Ikramuddin Kamil in its Consulate in Mumbai.

There are a number of reasons for change in India's policy towards the Taliban regime. First, despite a policy of application of economic sanctions and withholding of recognition, the Taliban have not relented on providing higher education for women or respecting other human rights. There is a tussle between the ISIS and the Al Qaida (an associate of Taliban) on the declaration of the Caliphate, with the ISIS declaring itself as the Caliphate in the territory seized by the group in Iraq and Syria in 2014. Taliban's leader Mullah Haibatullah Akhundzada described the Islamic Emirate of Afghanistan (IEOA) as the 'first legitimate emirate' since the fall of the Ottoman caliphate in 1924. Al Qaida has pledged loyalty to IEOA accepting Akhundzada as

the "Commander of the Believers".

its government hosts 18 foreign embassies and maintains the same number of foreign embassies abroad. Most regional countries such as Pakistan, China, Russia, Central Asian states, Iran and others are maintaining resident embassies in Kabul and Taliban missions in their capitals. The earlier fear of the Taliban regime not being able to control the terror groups on its soil has proven exaggerated as it has successfully relocated various terror groups from the border to other areas, or has placed their



fighters among its units to control them. Only the Tehreek-e-Taliban poses some problems as it has considerable followers and independent support in the Pashtun areas bordering Pakistan. In that sense, its control of the territory of Afghanistan has improved.Third, its relations with Pakistan have worsened. The Pakistani terror groups no longer have uncontrolled access in the Afghan territory. Though, there have been isolated reports of movement of some terrorists, weapons and equipment left over by the Americans and drugs from Afghanistan into Jammu and Kashmir and Punjab via both Pakistan and Iran, our hopes of controlling these are better with improved relations with Taliban. India was working earlier on about 500 projects in road construction, supply of drinking water and medical facilities besides providing humanitarian assistance. These can be executed better with improved presence in Afghanistan.

ministers have expressed interest in "stronger bilateral political and economic ties and easier visas for Afghan businessmen to travel to India". They are also keen to reduce their dependence on Pakistan for economic, transport and other assistance. Its Deputy PM for Economic Affairs, Mullah Baradar, paid a visit to the Chabahar port in November 2023 and expressed interest in boosting trade with India via this port.Afghanistan is suffering extreme humanitarian crisis due to contraction of its economy by 27 per cent in 2021 following Taliban's takeover. The economy grew by 2.7 per cent in 2023-

24 with growth in agriculture, industry, and services contributing to the recovery. The humanitarian aid, inward remittances and custom duties provided the main revenues. The improvement in long-term economic prospects depend on internal policy reforms and resumption of external aid.

The Taliban leadership prefer to maintain their conservative orthodox policies as a result of which the western donors have not agreed to resume aid. The regime wants external investments and development of infrastructure, particularly roads, railways, drinking water, irrigation, agriculture and health but the lack of infrastructure facilities poses a major constraint.For the first time after coming into power, the Taliban sent a delegation to the ongoing

UN climate change talks in Azerbaijan to get some support from the international community to deal with extreme weather like erratic rainfall, prolonged droughts and flash floods. The Afghan delegation said it had prepared a national action plan to deal with climate change and it was ready to talk to the USA and other countries to discuss their mitigation and adaptation proposals. Though the security situation has improved with fewer attacks by the ISIS in the last two years, it has still not provided enough confidence to investors from other countries such as China to construct new roads, rail lines and exploit rich mineral resources in the country. While the western sanctions have eased with the grant of US exemptions in some cases, it is hard for foreign investors to get loans for building the infrastructure in Afghanistan. Still, many countries have concluded that it is better to engage the Taliban patiently rather than ostracise them to resolve the many problems they are facing.

# Money power trumps human values



The rich minority must listen to the poor majority to make the world a better place

THE election of Donald Trump as the US President a second time has stunned liberal democrats in the US and around the world. He says the US democratic system is rigged by his opponents. He claims that the liberal, elite establishment is against common, working people. He has risen again, lifted by forces of disenchantment that have been brewing for decades. A New York Times/Sienna College poll in October 2024 reveals that 45 per cent of the Americans believe that American democracy does not do a good job of representing the people. As many as 76 per cent believe American democracy is under threat from internal corruption (not Russian or Chinese interference). It is ironic that the US, the self-appointed defender of democracy around the world, is using its formidable military power and hegemonic control of the global financial system to undemocratically force Russia, China, Iran and Venezuela, which it claims are not democratic countries, into submission. There is no democracy today in international relations. Not even within the US, its citizens say. The world is trembling. Liberals seem unable to understand how their policies and beliefs have caused the rise of authoritarianism. A wider lens is required to analyse the beliefs that have shaped 21stcentury economic and social institutions. It reveals the excessive power of money to control institutions of governance at global and national levels. The concept of institutions' is commonly limited to formal 'organisations', such as the executive government, courts, and elected assemblies, and checks and balances between them. This limited view misses the beliefs and 'unwritten rules' that shape the formation and behaviour of formal institutions. A 'system' encompasses norms, written and unwritten rules of conduct, and all actors within the system whose interactions form its behaviour. Economists Douglass North and Amartya Sen, and systems thinkers in other fields, take this wider, systemic view of institutions. A systemic analysis of institutions explains the behaviour of systems at three levels. On the

top are the visible phenomena about which data is easy to obtain. Beneath these are the interacting institutions that produce the phenomena. Deeper below are the beliefs and norms that shape and guide the institutions. Systems scientists use the picture of an iceberg to explain forces within a system. Visible phenomena are represented in the smaller portion above the waterline. Deeper forces that cause those phenomena are in the larger portion underwater. Systems thinkers delve beneath the waterline to analyse these forces.Consider climate change. The consequences of climate change are visible in the unexpected heatwaves, hurricanes, floods and droughts being experienced around the world with greater severity. The proximate causes of global climate change are changes in the physics and chemistry of the environment - the accumulation of carbon in the atmosphere, reduction of green cover, pollution of rivers and oceans, etc. which climate scientists' model to predict global temperature changes. The causes of these material changes are patterns of human activities with more material consumption

and greater use of non-renewable energy. These increase the productivity and size of economies but create unsustainable pressure on the earth's limited resources. The ultimate cause of unmitigated climate change is the pursuit of economic growth as the goal of human progress, and limited, mathematised models of economies disassociated from social forces. Neither climate scientists nor economists, with their limited models, can provide systemic solutions for climate change. We must go deeper into root causes, in beliefs and values embedded in these models. Changes in three interconnected systems - systems of society, the economy, and governance - have caused the rise of



authoritarian governments around the world. They have also disabled global governance. The 'privatisation' of economies, a thesis of the Washington Consensus which ruled the world after the collapse of the socialist Soviet Union in 1991, has given enormous power to large private sector institutions in the financial and business sectors. Money power controls the economy and the governance of societies.

Financial investors have the right to sue democratically elected governments at international tribunals for infringement of their rights to make profits even when their contracts impinge on the rights of the country's own citizens. The G7 cabal of rich countries, with less than 10

per cent of the world's population, has been controlling the agenda of the global economy and setting the rules. These countries, led by the US, control the IMF and the WTO. The US, the leader of the Washington Consensus, also dominates the UN Security Council. It is holding COPs - the global climate summits - hostage: it is the global cop bullying the world into submission. He who pays the piper calls the tune in politics, the media, policy think tanks and even in academic institutions. Systems' analysis reveals why citizens, having lost faith in systems of electoral democracy, are electing authoritarian, 'undemocratic' leaders, even in the US. All three systems - of the economy, society and governance are infected with money. Money rules the economy. The 21st-century ideology of economic governance is minimum government. Private is good and public is bad. Flows of money and trade across national borders must not

be restricted. The value of human lives in societies is measured by how much money an individual can earn; the worthiness of a nation by its GDP. Money power has infected governance systems too. Competing candidates need money to pay for expensive election campaigns. Over \$16 billion was spent in the recent US presidential elections. Elon Musk, the world's richest man, gave the most money to support Trump. The latter has tasked him with reducing the size of the US government. Musk will assist the President in increasing the influence of the US abroad, cutting business deals with Russia and China, and keep US businesses, especially its powerful defence and tech industries, in control of global policies.

# Lokmanthan 2024: largest celebration of Bharatiya culture to begin in Hyderabad on November 21

NEW DELHI: The fourth edition of "Lokmanthan 2024," an international conference and cultural festival, is set to begin in Hyderabad on November 21 at Bhagyanagar. The event will continue until November 24 as the country's largest celebration of the "oneness" of Bharatiya culture.Lokmanthan is a biennial national colloquium of nationalist thinkers and practitioners. It serves as a platform where artists, intellectuals, and academicians from across the country come together to brainstorm on societal issues, with the aim of reshaping narratives and preparing the nation to play its civilizational role. Union Minister Kishan Reddy, at a media briefing on Tuesday, stated that the 4th edition of this international conclave is being organized by Pragna Pravah, New Delhi, and Pragna Bharati, Telangana, along with their associated organizations across the country. These include Itihaas Sankalan Samiti, Sanskara Bharati, Vijnana Bharati, Adhivakta Parishad, Akhil Bharatiya Sahitya Parishad, and Bharatiya Sikshana



Mandal. The main program will be held at Shilpa Kala Vedika, while an exhibition and cultural festival will take place at the adjacent Shilparamam. Previous editions of Lokmanthan were held in Bhopal, Ranchi, and Guwahati, focusing on themes such as decolonization and lok parampara. The theme for Lokmanthan 2024 is "Lok Avalokan. Lok Vichar - Lok Vyavahar Lok Vyavastha." Reddy, who is the Chairman of the Reception Committee for the event,

further mentioned that the President of India, Droupadi Murmu, will inaugurate Lokmanthan 2024 on November 22, while former Vice President Venkiah Naidu has consented to open the exhibition and cultural festival on November 21 at Shilpa Kala Vedika.Kishan Reddy, as Chairman of the Reception Committee of Lokmanthan 2024, which includes more than 120 people from Telangana and Andhra Pradesh, stated that more than 1,500 artists from across the

country and the world would be participating. He said the Bhagyanagar edition of Lokmanthan 2024 will feature conferences, art performances, audiovideo pavilions, exhibitions, and food courts.

NEW DELHI: With Delhi-NCR battling hazardous air pollution levels, daily wage laborers in the construction sector are bearing the brunt of restrictions imposed under Stage IV of the Graded Response Action Plan (GRAP). The ban on construction and demolition activities, aimed at curbing pollution, has plunged workers into a financial crisis, leaving many struggling to provide for their families.For Suman, a 45-year-old mother of two, the ban has dashed all hopes of survival. "If we sit at home, what will we eat? What will we feed our children?" she asked with despair etched on her face. Despite renewing her labour card in hopes of government aid, she claims no help has materialised. "We live on daily earnings. Without work, we have nothing," she said.

## Supreme Court questions delay in delimitation process for 4 Northeastern states

New Delhi: The Supreme Court has questioned the delay in carrying out the delimitation exercise in the Northeastern states of Nagaland, Arunachal Pradesh, Manipur and Assam despite the President's 2020 order rescinding the earlier deferment orders. On Tuesday, a bench led by Chief Justice of India Sanjiv Khanna questioned the Centre on what was done to "set the ball rolling" to conduct the exercise, considering that it had been 4 years since the presidential order, which it observed was enough to proceed with the process. The court told Additional Solicitor General KM Natraj, appearing for the Centre, that the delimitation exercise was a statutory mandate and had to be done.

It asked him to take instructions regarding the issue granting him further time to do the same and accordingly adjourned the case to January 2025. The counsel for the petitioner told the court that while delimitation took place in Assam last year, the exercise was yet to begin in the three other states.

In response, the Additional Solicitor General said consultation is ongoing for Arunachal Pradesh and Nagaland, but the situation in Manipur might not be conducive in the wake of the ethnic violence in the state.It was submitted on behalf of the Election Commission to begin delimitation. Directions from the Centre are required under the Representation of the People Act, 1950, referring to Assam where such directions were issued. The court was considering a petition filed seeking immediate implementation of the delimitation exercise in these states.

# No Baba Siddique, Son Zeeshan Shares First Voting Experience Without Him

Baba Siddique, a prominent NCP leader and former minister, was gunned down on October 12 near his son's office by attackers allegedly linked to the Lawrence Bishnoi gang.

Mumbai: Zeeshan Siddique, the NCP candidate from Bandra East, voted today in the Maharashtra Assembly elections and said that it was the first time he came to a polling booth without his father Baba Siddique.

Mr Siddique, a prominent NCP leader and former minister, was gunned down on October 12 near his son's office by attackers allegedly linked to the Lawrence Bishnoi gang.



"For the first time, I have come alone to vote. My father is no more. This is different but this will have to be done. I know that my father is with me. I started my day by visiting the graveyard in the morning...I think everyone must vote," Zeeshan Siddique said. The 32-year-old former Congress leader faces Varun Sardesai, Shiv Sena (UBT) Chief Uddhav Thackeray's nephew, in a high-stakes battle in Bandra East. Zeeshan Siddique joined the Ajit Pawar-led faction of the NCP in October. Mr Siddique will defend the

Bandra East seat he won in the 2019 election when he was with the Congress.

Maharashtra's single-phase assembly elections saw polling begin at 7 am across 288 constituencies, with voting set to conclude at 6 pm. Over 9.7 crore voters are registered to choose among 4,136 candidates contesting this year, marking a 28 per cent rise from 2019's 3,239 candidates.

The BJP-led Mahayuti alliance and the Congress-led Maha Vikas Aghadi (MVA) are vying for control of the assembly. The Mahayuti includes the BJP, Shiv Sena (Eknath Shinde faction), and NCP (Ajit Pawar faction), while the MVA brings together the Congress, Shiv Sena (UBT), and NCP (Sharad Pawar faction).Key figures in the elections include Maharashtra Deputy Chief Minister Ajit Pawar, contesting from Baramati against his nephew Yugendra Pawar, marking another compelling electoral contest.

The menu has 250 grams of almonds, 30 bananas, 4 kg of pomegranates, 5 kg of milk and 20 eggs. It also enjoys oil cake, green fodder, ghee, soybeans and corn. This specialised diet ensures that Anmol is always prepared for exhibitions and breeding.



Tnt Limited (TAFE), a division Bench of the Madras High Court has ordered status quo on the use of Massey Ferguson brand by the company.TAFE had moved Madras High Court against US-based agricultural equipment maker AGCO Corporation for trying to wrest the Indian company's rights to use the Massey Ferguson brand in India. While maintaining the status quo in favour of TAFE, the Court recognised TAFE's use of the brand for more than six decades. The Court has directed that ownership and other related issues will be decided by the Single Judge of the Madras High Court before whom the Applications are pending.

"The present status quo is in continuation of the status quo granted to TAFE as early as in April 2024, and the latest of several judicial orders protecting TAFE's rights to the use of the Massey Ferguson brand," TAFE said in a press statement. TAFE is a strategic investor and the largest single shareholder in AGCO, holding 16.3% stake.

The IPO will remain open for subscription until November 22, 2024, and is expected to list on both the BSE and the NSE on November 27
- The price band is set between Rs 102 and Rs 108 per equity share. Retail investors led the charge, with the retail portion subscribed 1.33 times on the first day. Non-Institutional Investors (NII) portion was subscribed 0.16 times, Reservation Portion and Employee Portion subscribed 0.57 times and 0.17 times, respectively. The qualified institutional buyer (QIB) portion is yet to gain traction. Ahead of the IPO, NGEL secured Rs 3,960 crore from anchor investors. # Food prices in focus amid inflation, interest rate call

**NEW DELHI:** The sharp spike in retail inflation rate in October to a 14-month high of 6.2% has triggered a fresh debate about the country's inflation targeting framework and whether food prices should be excluded while setting interest rates. Finance minister Nirmala Sitharaman has called for more discussion on using interest rates to control food prices and asserted that govt was taking steps to control food supply side issues. Her comments came

shortly after commerce and industry minister Piyush Goyal said targeting food prices through interest rates was an "absolutely flawed theory." Chief economic adviser V Anantha Nageswaran said that removing tomato, onion, potato, gold and silver from the calculation reveals a headline CPI rate of just 4.2% in October. Why are food prices in focus?Prices of tomato, onion and potato (TOP) have pushed the retail inflation higher and above the central bank's upper tolerance level of 6%. Supply side issues have been blamed for the price increase and there are expectations that the situation will reverse once supplies normalise. Food prices have led to



seasonal spikes, complicating the overall retail inflation situation. Economists say food inflation cannot be ignored as it has a high weight in the consumer price index (CPI) basket and persistent high food inflation raises inflationary expectations. Food inflation has remained high in the country over the past two years, complicating the policy choice. What is the Monetary Policy Framework?The RBI Act was amended in May 2016 for providing a statutory basis for rolling out the inflation targeting framework for five years. The Centre and RBI finalise the inflation target based on the consumer price index. It has set a 4% inflation target with the upper tolerance limit at 6% and the lower level at 2%. In March 2021, it has retained the target and the tolerance for the next five years up to March 31, 2026. How Economic Survey's views on re-examining the inflation targeting framework sparked the debate?

The latest Economic Survey had suggested excluding food prices from the inflation targeting framework. It had argued that higher food prices are, more often, not demand-induced but supplyinduced and short-run monetary policy tools are meant to counteract price pressures arising out of excess aggregate demand growth. "Deploying them to deal with inflation caused by supply constraints may be counterproductive. Therefore, it is worth exploring whether India's inflation targeting framework should target the inflation rate excluding food," said the document authored by Nageswaran.

It said that hardship caused by higher food prices for poor and low-income consumers can be handled through direct benefit transfers or coupons for specified purchases valid for appropriate durations. Why food inflation pressures cannot be ignored?RBI governor Shaktikanta Das in his monetary policy statement had said that the monetary policy committee's target is the headline inflation where food

& beverage inflation has a weight of around 46%. He had asserted that with this high share of food in the consumption basket, food inflation pressures cannot be ignored. Das had said that the public at large understands inflation more in terms of food inflation than the other components of headline inflation. "Therefore, we cannot and should not become complacent merely because core inflation (stripping out food and fuel) has fallen considerably," the governor had said. The governor had said that high food inflation adversely affects household inflation expectations, which have a significant impact on future trajectory of inflation. RBI is of the view that stubborn high food inflation and unanchored inflation expectations - if they materialise - could lead to spillovers to core inflation through pick-up in wages on cost-ofliving considerations."The MPC may look through high food inflation if it is transitory; but in an environment of persisting high food inflation, as we are experiencing now, the MPC cannot afford to do so. It has to remain vigilant to prevent spillovers or second round effects from persistent food inflation and preserve the gains made so far in monetary policy credibility," Das had said.

# India's GDP growth likely to slip at 6.5 per cent, maintains 7 per cent estimate for FY25: ICRA

**MUMBAI:** Domestic rating agency ICRA on Wednesday said India's real GDP growth for the September quarter is likely to decline to 6.5 per cent due to heavy rains and weaker corporate performance.The agency, however, maintained its FY25 growth estimate at 7 per cent on expectations of a pick up in economic activity in the second half of the fiscal. The estimates and commentary on the outlook come at a time when there are concerns

around the growth slowdown on a slew of factors like slowing down urban demand.

The RBI is sticking to its estimate of 7.2 per cent growth for the fiscal, but a majority of watchers expect it to be under the 7 per cent figure and many have been revising down in the last few weeks.Official data for the Q2 economic activity is expected to be published on November 30. In Q1, the GDP expansion had come at 6.7 per cent. ICRA said the dip in Q2 will be due to factors like heavy rains and weak corporate margins."While government



spending and kharif sowing have shown positive trends, the industrial sector, particularly mining and electricity, is expected to slow down," it said. The services sector is projected to improve, and a back-ended recovery is anticipated, leading to a full-year GDP growth of 7 per cent, it added.

"Q2 FY2025 saw tailwinds in terms of a pick-up in capex after the Parliamentary Elections as well as healthy expansion in sowing of major kharif crops. Several sectors faced headwinds on account of heavy rainfall, which affected mining activity,

electricity demand and retail footfalls, and a contraction in merchandise exports," its chief economist Aditi Nayar said.She said benefits of the healthy monsoons lie ahead, with upbeat kharif output and replenished reservoirs likely to lead to a sustained improvement in rural sentiment. There is considerable headroom for the GoI's capital expenditure, which needs to expand by 52 per cent in Y-o-Y terms in H2 FY2025 to meet the budget

estimate for the full year, Nayar added."We are watchful of the impact of a slowdown in personal loan growth on private consumption as well as geopolitical developments on commodity prices and external demand," the chief economist said.In Q2, investment activity improved over Q1, while remaining sluggish amid slow execution of infra projects owing to surplus monsoon rains, the agency said, adding that new project announcements witnessed a healthy rebound to Rs 6.7 lakh crore in Q2.

## Suits, saree dealers under GST dept lens

**NEW DELHI:** As the wedding season approaches, Central GST authorities have intensified their crackdown on lehenga, suits and saree dealers in Delhi's iconic Chandni Chowk market. The dealers are under investigation for alleged GST evasion and other malpractices.

Sources in the GST department claim many of these businesses conduct cash transactions during the year, which is at its peak in the highdemand wedding season, enabling them to evade GST on their outward supplies.Furthermore, it has been alleged that these dealers use fake invoices to claim input tax credits for transactions made through formal banking channels. The investigation has uncovered two primary methods of tax evasion -- evasion of GST on outward supplies and fraudulent availing of input tax credit. As per sources, many dealers accept cash payments for their goods but fail to report these transactions to evade GST liability. This practice is particularly rampant during the wedding season when sales volumes surge.For transactions made via cheques or other traceable payment modes, the dealers allegedly use fake invoices to claim input tax credits, reducing their overall GST liability. These practices not only result in significant revenue losses for the government but also create an uneven playing field for compliant businesses. GST authorities have been conducting search operations at many such businesses in last one month.Beyond tax evasion, the investigation has revealed troubling issues related to property disputes in Chandni Chowk and nearby areas such as Pusa Road. Several dealers, occupying rented premises, have allegedly refused to vacate the properties despite receiving legal eviction notices. These tenants are reported to pay a meager rent of as low as Rs 100 per month for properties valued in crores from where they do not even conduct businesses. Landlords have raised concerns about these dealers using intimidation tactics to retain possession of these shops.

New Delhi: The Income Tax Department expects to surpass the direct tax collection target of Rs 22.07 lakh crore fixed in the Union Budget for the current financial year, according to Central Board of Direct Taxes (CBDT) chairman Ravi Agarwal. Agarwal told journalists collections from corporate and noncorporate taxes have risen and the Income Tax Department believes that it will cross the budget target for the second year in a row. This reflects the strong fiscal position of the country driven by robust economic growth.

India's net direct tax collections, comprising corporate tax and personal income tax, shot up by a robust 15.4



per cent to Rs 12.1 lakh crore, from April 1 to November 10 during the current financial year, according to the latest figures released by the CBDT.On a gross basis, direct taxes surged by over 21 per cent to Rs 15 lakh crore on a gross basis during the period. The government issued tax refunds of Rs 2.9 lakh crore which is a 53 per cent increase over the same period last year. The government's target to collect Rs 22.07 lakh crore during the current financial year comprises Rs 10.20 lakh crore from corporate tax and Rs 11.87 lakh from personal income tax, non-corporate tax and other taxes.

Companies like KRN Heat Exchanger, Gala Precision Engineering, Premier Energies, and Bajaj Housing Finance

became money-spinning machines for investors. Some listings even doubled investors' wealth, making IPO investments appear like a guaranteed route to quick profits.

Recent weeks tell a different story, with high-profile listings stumbling at the start line. Even marquee names like Hyundai Motor India, Swiggy, and Afcons Infrastructure have failed to maintain the momentum. NTPC Green Energy's ambitious Rs 10,000



crore IPO's lukewarm response in the grey market signals growing investor fatigue.Gaurav Garg, Lemonn Markets Desk, points to the bigger picture: "Indian IPOs have had a notable year, raising approximately Rs 1.2 lakh crore, capitalising on favourable stock market conditions. However, recent trends reflect a shift in sentiment amid a market downturn and growing investor caution."So, what went wrong? According to Garg, the answer lies in ambitious CAUTIOUS SENTIMENTS

> Ritin Agarwal, Managing Partner, Fundvice, points to another challenge: "There does seem to be IPO fatigue in the market. The rapid influx of public offerings has stretched investor focus and capital thin, resulting in many IPOs receiving lukewarm interest and weak support."

#### **DON'T GO BY LISTING GAINS**

However, the story isn't over. Experts maintain an optimistic outlook for the IPO market's future. Singh believes investor interest remains intact, though more measured. "With regulatory changes and cautious sentiment, the market is undergoing a correction rather than a decline," he maintains.

## Brazil draw 1-1 vs Uruguay, Argentina beat Peru to close in on World Cup spot

**New Delhi.** Brazil and Uruguay battled to a 1-1 draw, while Argentina edged Peru 1-0 to strengthen their hold on the top of the standings in South American qualifiers for the 2026 FIFA World Cup. After the win, Argentina are on the brink of qualification, while Brazil faced mounting pressure in the race for a spot.

#### **BRAZIL SHARE POINTS**

- Playing at home, Brazil had to settle for a draw against a resilient Uruguay side. Real Madrid midfielder Federico Valverde broke the deadlock in the 55th minute with a spectacular low drive from outside the box. The visitors looked poised to take all three points until Flamengo's Gerson equalized just seven minutes later. The midfielder capitalized on a defensive error with a stunning volley, marking his first international goal.
- Brazil, the five-time World Cup champions, now sit fifth in the CONMEBOL standings with 18 points, trailing Colombia and Ecuador by a single point. Uruguay, on the other hand, remains second with 20 points, five behind Argentina. This was Brazil's second consecutive draw in the qualifiers, adding to concerns about their consistency heading into the crucial stages of qualification.

#### **ARGENTINA BEAT PERU**

In Buenos Aires, a second-half strike from Lautaro Mart-nez secured a narrow victory for Argentina over a struggling Peru side. Mart-nez found the net in the 55th minute, heading in a pinpoint cross from Lionel Messi. The goal brought Mart-nez level with Diego Maradona as Argentina's fifthhighest scorer in history. The win keeps Argentina firmly atop the standings with 25 points from 12 matches, five ahead of Uruguay. Peru, rooted at the bottom with just seven points, faces a steep climb to keep their World Cup hopes alive. Despite the victory, Messi's subdued performance mirrored his struggles in Argentina's previous 2-1 loss to Paraguay. Meanwhile, Julián lvarez hit the post in the 21st minute, highlighting the hosts' inability to capitalize on more chances.

Venezuela's Jefferson Savarino and Ruben Ramirez scored in a losing effort.

Rafael Nadal's legacy will be eternal: Alcaraz's emotional tribute to retiring star New Delhi. Carlos Alcaraz paid an emotional tribute to his 'idol' Rafael Nadal after the Spanish tennis great bid an emotional farewell to competitive tennis on Tuesday night in Malaga, closing the curtain on one of the sport's most illustrious careers. The 22-time Grand Slam champion and four-time Davis Cup winner could not secure a victory in his final match, falling 6-4, 6-4 to Dutchman Botic van de Zandschulp in the Davis Cup quarter-finals. Alcaraz paid a heartfelt tribute to the retiring legend, underscoring the profound impact Nadal has had on his career and the sport as a whole. "Rafa is one of the best ambassadors of tennis; his legacy will be eternal for sports in general," Alcaraz said during the post-match press conference. "This moment is difficult for me; I feel I must continue the legacy he leaves us. I can only have good words for him and the career he has had. He has been one of the players who helped elevate tennis to the highest level. He is a very important figure in my life."Despite Nadal's best efforts to inspire from the sidelines, the Spanish team ultimately fell short. Alcaraz delivered a strong performance, defeating Tallon Griekspoor 7-6(0), 6-3 to level the tie. However, in the doubles match, Alcaraz and Marcel Granollers narrowly lost to Wesley Koolhof and Van de Zandschulp, sealing a 7-6(4), 7-6(3) victory for the Dutch and ending Spain's Davis Cup campaign.

# Ricky Ponting not happy with IPL auction clash with Perth Test: 'Worst scenario'

The timing has forced Ponting, Justin Langer, and key personnel like Australia's bowling coach Daniel Vettori to prioritize their IPL commitments over the crucial series-opener. The Indian Premier League auction, scheduled for November 24 and 25 in Jeddah. Saudi

Arabia, will see Ponting (head coach of Punjab Kings), Langer (coach of Lucknow Super Giants), and Vettori (coach of Sunrisers Hyderabad) absent from significant portions of the Perth Test. Ponting and Langer will only be available for the opening day of commentary with Channel Seven before flying out for the auction.Ponting expressed his frustration with the timing, which disrupts the preparation and broadcast dynamics for one of cricket's most highly anticipated series.



"It's the worst possible case scenario for me and 'JL'," Ponting told this masthead. "We for the last couple of months felt that it was probably going to be in the gap between the Test matches. It takes all the pressure off the players from both teams, there's a lot of players in both teams in the auction.

'So I always thought it would've been in that gap because it just seemed better for everybody. But I don't know why they've chosen the dates they have - it might have something to do with the game. The auction actually starts on air almost immediately after the end of play. So it might be something to do with broadcast."I'm calling the first day then flying out late Friday night to Jeddah. If I prepare well, I can handle failure and move forward."Since his return,

Marsh has been a standout performer, becoming Australia's leading Test runscorer over the past year and contributing to a triumphant World Cup campaign in India. The MCG crowd, which once jeered him, offered rousing applause during his counterattacking 96 against Pakistan in the 2023 Boxing Day Test.In addition to his Test resurgence, Marsh has flourished in white-ball cricket, taking over as Australia's T20I captain and becoming a leader in the dressing room. Off the field, he recently embraced fatherhood, adding another joyful chapter to his life.Looking ahead, Marsh has rejoined the Australian squad for the upcoming Border-Gavaskar Trophy, where he is expected to resume bowling duties after a measured recovery. At 33, Marsh stands as a testament to resilience, proving that with determination and the right mindset, redemption is always within reach.
