

Will study US "chargesheet reports", act on it: Andhra CM

New Delhi, Nov. 22: Andhra Chief Minister Chandrababu Naidu on Friday said the state government is in possession of



the "chargesheet reports" filed in the US related to the alleged bribery scam involving the previous YSRCP government and the Adani Group, and "promised" to act on the irregularities. Business tycoon and Adani Group chairman Gautam Adani has been charged by the US Department of Justice over his role in an alleged years-long scheme to pay USD 250 million bribe to Indian officials in exchange for favourable terms for solar power contracts, an allegation refuted by the Indian conglomerate. The previous YSRCP regime is embroiled in the alleged scam with claims that government officials

received bribes from the Adani Addressing the Assembly, the Chief Minister said his government will study those charges and act on them. "I have all the chargesheet reports filed there (US). It is in the public domain. Will study it (the allegations and indictment) Will act on it and inform you,' said Naidu. He noted that over the past five months, the TDPed government has been dis cussing the alleged corruption

that took place between 2019 and 2024. The YSRCP had on Thursday dismissed the allegations made against the government headed by it and said there was no direct agreement with the Adani group. Highlighting that the allegations involving the YSRCP regime and Adani group, have hurt the prestige and brand image of the southern state, Naidu termed it as a "very sad development".

India never moved ahead with expansionist mindset: PM Modi

New Delhi, Nov. 22: India has never moved forward with the expansionist mindset and always stayed away from the feeling of grabbing others' resources, Prime Minister Narendra Modi said on Thursday. The prime minister's comments during an address at a special session of the Parliament of Guyana came amid growing global concerns over China's expansionist behaviour as well as conflicts arising out of territorial disputes. Modi, referring to geopolitical tensions, said it is time to identify the conditions leading to conflicts and remove them. "Today, there are so many challenges like terrorism, drugs, cybercrime, that only by fighting them, we will be able to shape the future of our coming generations," he said. "And this is possible only when we give centre stage to democracy first - humanity first. India has always spoken based on principles, trust and trans-

parency," Modi said. "If even one country, even one region is left behind, then our global goals will never be achieved. That is why India says every nation matters," he added. Showcasing India's foreign policy approach, Modi noted that India has never moved forward with selfishness. "We have never moved forward with the feeling of expansionism. We have always stayed away from the feeling of occupying resources, grabbing resources," he said. "I believe, be it space or sea, these should not be



subjects of universal conflict but cooperation. This is not the time for conflict for the world either," he said. The prime minister said, "This is the time to identify the conditions that create conflict and remove them". Highlighting India's priority to ensure the welfare of the developing nations, Modi said a unit-

ed voice of the Global South is crucial. "This is the time for the awakening of the Global South," he said, adding democracy is in "India's DNA, in our vision and our conduct". Modi said India stands in favour of

> global development in every way. "With this spirit, today India has also become the voice of the Global South. India believes the Global But many countries developed by harming the environment. Today, the countries of the Global South are paying the biggest price of climate change," he added. Modi asserted it is very important to get the world out of "this imbalance". "Whether it is India or Guyana, we have aspirations of development, dreams of giving a better life to our people. For this, a united voice of the Global South is very important," he said. "This is the time for the awakening of the countries of the Global South. This time is allowing us to come together and cre-

ate a new global order. And I see a big role of all you representatives of Guyana in this," he said. Delving into various issues, Modi said the world of the 21st century faces different kinds of challenges. "Today both our countries are strengthening democracy in

US charges against Adani, 7 others could lead to arrest warrants

New Delhi, Nov. 22: With the US filing civil and criminal charges against billionaire Gautam Adani and seven others over a multi-million-dol-

lar bribery scheme, a prominent attor ney here has said that the case could escalate significantly, potentially leading to arrest warrants and even extradition attempts. Adani, India's second-richest man, and seven others, including his nephew Sagar Adani, have been charged by the US Department of Justice with paying bribes to unidentified officials of state governments in Andhra Pradesh and Odisha to buy expensive solar power, potentially earning more than USD 2 billion in profit over 20 years Adani Group, however, denied the charges saying the allegations by US prosecutors are "baseless" and the conglomerate is "compliant with all laws" "US Attorney Breon Peace has the right

to get arrest warrants issued against Adani and seven others indicted and serve them on the nations where they reside," Indian-American attorney Ravi Batra told PTI on Thursday. He further said, "If that nation, as India does, has an extradition treaty then according to the bilateral contract between sovereign nations, the resident nation must turn over the person extradited by



the United States. There is a process that the resident nation must comply with, consistent with its laws." Batra noted that ultimately, extradition occurs "absent the rarest of circumstances", as in the case of former Chilean president Augusto Pinochet. The United Kingdom did not extradite him solely on humanitarian grounds. "It's hard to see the Pinochet precedent apply to this case involving Adani and seven

others," he said. The India-US Extradition Freaty was signed in 1997. Peace, the US Attorney for the Eastern District of New York, has announced a five-count criminal indictment against 62-year-old Adani, his nephew Sagar, an executive director at the conglomerate's renewable energy arm Adani Green Energy Ltd, and its former CEO Vneet S Jaain. The indictment charged them with conspiracies to commit securities and wire fraud and substantive securities fraud for their roles in a multi-billion-dollar scheme to obtain funds from US investors and global financial institutions based on false and misleading statements. The indictment also charged Ranjit Gupta and Rupesh Agarwal, respectively a former

CEO and former chief strategy and commercial officer of Azure Power Global, and Cyril Cabanes, Saurabh Agarwal and Deepak Malhotra, former employees of a Canadian institutional investor, with conspiracy to violate the Foreign Corrupt Practices Act.



MVA to keep all its newly-elected MLAs under one roof after poll results: Raut

Mumbai, Nov. 22: The Maha Vikas Aghadi constituents have decided to house all its newly-elected MLAs together in Mumbai after the Maharashtra election results, Shiv Sena (UBT) leader Sanjay Raut said on Friday, a move aimed at preventing poaching ahead of government formation. Talking to reporters here, Raut said MVA leaders, including himself, his party colleague Anil Desai, NCP (SP) state president Jayant Patil and Congress leaders Satej Patil and Balasaheb Thorat met on Thursday and carried out an assessment of every seat. "We have decided to bring all newly-elected MLAs to Mumbai. New MLAs have no provision to stay in Mumbai. So we have decided to make their residential



arrangements together," he said. The counting of votes for the November 20 Maharashtra assembly polls will take place on Saturday. Raut expressed confidence that the MVA would win 160 seats in the elections. Some independents, who have strong chances of victory, have expressed their desire to support the opposition bloc, the Rajya Sabha member said. "There is no formula for the CM's post. Everyone will choose the leader of the government," Raut said. Senior Congress leaders have to come to Mumbai with a mandate on the CM's post as NCP (SP) president Sharad Pawar and Shiv Sena (UBT) chief Uddhav Thackeray are in Mumbai. He also asserted that no power can stop the MVA from forming the next government in Maharashtra and that the decision on the top post will be taken only in Maharashtra. Fissures have emerged within the opposition MVA as well as the ruling Mahayuti on who will head the next government with constituents in both camps laying claim over the chief minister's post. While state Congress chief Nana Patole asserted that a MVA government will be formed in Maharashtra under the leadership of his party, Raut on Thursday insisted the CM face will be decided by all alliance partners jointly. Raut expressed fear that the BJP will try to obstruct the MVA through the governor's office in forming the government despite the opposition having the majority.

TMC leaders arrested after Mamata Banerjee's warning Nadda's letter to Kharge full of falsehoods

Kolkata, Nov 22: A police inspector was suspended and two local Trinamool Congress (TMC) leaders arrested in separate cases in Bengal's West Burdwan district on Thursday evening hours after chief minister Mamata Banerjee ordered a crackdown on criminal elements. "Manoranjan Mondal, the officer-incharge of Barabani police station was suspended on Thursday evening for allegedly neglecting his duty and indulging in activities not related to police work," said a district police officer who spoke on condition of anonymity. The action comes after a video, showing Mondal celebrating the birthday of a local TMC leader inside his police station, emerged on October 30. In another case, Aurobindo Nandy, a former Trinamool Congress (TMC) councillor and Rintu Panja, a former TMC community block unit vice-president, were arrested from Durgapur on charges of stealing iron and steel from a factory that closed down years ago. "Nandy and Panja were produced before a local court on Friday. The judge remanded them in police custody for three days. They have been accused of stealing goods from the premises of a factory," Rahul Deb Mukherjee, the lawyer of the two TMC leaders, said. "A police officer asked me to drop in at the police station for 10 minutes, saying he had something to discuss.

Who will be next Maharashtra CM? Mahayuti, MVA constituents drop different names

Mumbai, Nov. 22: Even before the first votes are counted in Maharashtra, fissures have emerged within the ruling Mahayuti and the opposition Maha Vikas Aghadi (MVA) on who will head the next government with constituents in both camps laying claim over the chief minister's post. After polling for the 288-member assembly ended on Wednesday evening, the ruling as well as opposition fronts have started claiming that mandate will be in their favour when votes are counted on November 23. Soon after polling, state Congress chief Nana Patole asserted an MVA government would be formed in Maharashtra under the leadership of his party. Voting trends suggest the Congress will get the maximum number of seats in the new assembly, he said. His remarks did not go down well with ally Shiv Sena (UBT), whose leader Sanjay Raut on Thursday insisted the chief ministerial face will be decided by all alliance partners jointly once the MVA

the Congress high command has told Patole that he will be the CM face then the national

partv's president Mallikarjun Kharge, and its top leaders Rahul Gandhi, Sonia Gandhi and Priyanka Gandhi Vadra should announce the same. The MVA, consisting of the Congress, Shiv Sena (UBT) and NCP (SP) and the Mahayuti, comprising the BJP, Shiv Sena and NCP, have

Karnataka country's second largest milk producer, claims CM Siddaramaiah

BENGALURU: Chief Minister Siddaramaiah, who was on a visit to New Delhi on Thursday, declared that Karnataka has emerged as the second-largest milk producer in India, after Gujarat."The state's 16 milk unions produce about 1 crore litres of milk daily. Karnataka has started supplying 2.5 lakh litres of milk daily to New Delhi, with plans to increase this to 5 lakh litres in six months. Creating a strong market for milk products is crucial for the growth of the dairy industry and wellbeing of farmers," he said.

Speaking at the launch of Nandini milk variants, organised by the Karnataka Milk Producers' Federation (KMF) and Mandya District Cooperative Milk Union, he credited the state's success to the strong support given to the dairy sector."We formed milk producers' associations to ensure farmers got fair prices and a permanent market for their produce," he said. He elaborated as the state produces 92-93 lakh litres of milk on a daily basis, out of which 2.5 lakh litres are sent to Andhra Pradesh and Maharashtra. Through the Ksheeradhare Scheme, milk is purchased at Rs 32 per litre, with an additional Rs 5 per litre incentive given by the government, he added. "When I became CM, I increased this incentive to Rs 5 per litre, the highest so far. The state spends Rs 5 crore every day on these incentives," he claimed.

Guntur GGH performs 90 heart surgeries in past five months

GUNTUR: Guntur Government General Hospital (GGH) has marked a significant achievement by performing more than 90 heart bypass and open-heart surgeries over the past five months. On Thursday, three patients who underwent bypass surgeries were discharged, highlighting the success of these life-saving procedures. The hospital plans to perform 30-40 bypass and openheart surgeries each month, along with keyhole heart surgeries, pending State government approval.GGH Superintendent Dr SSV Ramana revealed that the Cardiothoracic and Vascular Department, under the NTR Vaidya Seva scheme, successfully carried out 90 surgeries, including aortic and mitral valve replacements, all at no cost to the patients.

Dr Ramana noted that the hospital has also become a preferred destination for patients seeking high-quality treatment, with many travelling from private hospitals.Dr Harikrishna Murthy, head of the Cardiothoracic and Vascular Department, explained that the hospital had previously struggled with a lack of essential equipment for open-heart surgeries. However, thanks to the support of the State government and Dr Alla Gopalakrishna Gokhale, founder of the Sahrudaya Trust, the hospital was provided with equipment worth Rs 20 lakh, significantly improving the success rate of surgeries. The skilled nursing and medical staff have also played a key role in these successful outcomes

Heart bypass surgeries at GGH began in 2016 through a partnership with Sahrudaya Trust, supplied equipment and expertise However, after the MoU ended in 2019, followed by the COVID-19 pandemic, the surgeries were temporarily halted due to staff shortages. The Sahrudaya Trust resumed its support after requests from the health department.

Plan to levy EMC on Papikondalu boats from December 1

RAJAMAHENDRAVARAM: The Forest Department is set to launch the Clean Papikondalu National Park mission, introducing Environment Maintenance Charges (EMC) to curb pollution and fund conservation efforts. Checkposts will be set up at strategic locations within Papikondalu National Park to collect these charges, in line with Supreme Court guidelines and National Green Tribunal (NGT) directives. Conservator of Forests for the Rajamahendravaram circle, BNN Murthy, confirmed that EMC collection will begin on December 1. Speaking to TNIE, he emphasised the necessity of the initiative, citing environmental degradation caused by unchecked waste disposal.He said boat entry charges will be based on seating capacity in the Eluru, Rampachodavaram, and Chintur forest divisions. A fee of '2,500 will be charged per boat trip for seats counts below 50, '4,000 for boats carrying fewer than 100 passengers, and '6,000 for boats ferrying 100 passengers or more. Additionally, digital and professional cameras will incur a charge of '500. Of the 40 boats operating in the area, including two tourist vessels, each will pay EMC based on

Road traffic will also be subject to fees, with light vehicles charged '50 and heavy vehicles '100. Checkposts for fee collection are being set up at Maredumilli, Tulasipakala, and Darapalli on land, and at Gandipochamma temple and Pochavaram boating points along the river. To tackle waste accumulation, the department plans to recruit 50 'Swachh Sevakas' and fire watchers. Their duties will include removing plastic waste, liquor bottles, and other garbage from the Godavari riverbanks and areas surrounding Perantallapalli within the park.Murthy highlighted the urgency of the mission, saying, "As the manager of this protected area, I have to safeguard Papikondalu.

Wings of woe! Bird species decline in north and south Kerala, shows survey

KOCHI: Whither are our winged friends headed? The Wings survey, held simultaneously in Kochi, Kozhikode and Thiruvananthapuram and adjoining interior areas, has thrown up worrying fact: There has been a drop in the number of individual birds in some parts of the state. Though no new species were discovered, birders in Thiruvananthapuram and Kozhikode noted a decrease in the observed species count in their regions, while Kochi registered a slight increase.Last year, when the survey was called the Bird Race, Kozhikode, Thiruvananthapuram and Kochi counted 212, 193 and 187 bird species, respectively. This year, Kozhikode and Thiruvananthapuram saw a drop in the number of species, with just 201 and 183 counted, while Kochi region witnessed a jump with 192 species identified. Sivakumar AK, a birder from Thiruvananthapuram told TNIE, "The count cannot be termed foolproof, as it was carried out in inclement weather conditions. Rain and the presence of wild elephants prevented us from venturing out into some areas. Such areas might have



had at least four or five species of birds." According to Vishunpriyan Kartha K, secretary of the Cochin Natural History Society (CNHS), the survey and the interactive meet-up have been conducted in Kerala since 2007, with the exception being during covid-19. "It is usually conducted on or around the birth anniversary of legendary ornithologist Dr Salim Ali. The exhaustive process sees the participation of several institutions and organisations in Kerala, with over 500 people participating annually," he said."Participants range from students to

retired professionals and housewives, teachers, scientists, advocates and people from various other fields. In Kochi and central Kerala region, CNHS coordinates the event in collaboration with the College of Forestry - Kerala Agricultural University," said Kartha. Speaking about the process, Sathyan Meppayur, a birder from Kozhikode, said, "Participants form groups of three to five, led by an expert or senior birder, and explore a wide range of sites and habitats in and around every venue. This adds up to over 100 locations across the state. The teams then upload the checklists onto the eBird app, which helps compile the

The programme is coordinated at the pan-India level by Mumbai-based Sunjoy Monga, with the passionate support of local birders, he added.Meppayur said, "Of the bird species found in north Kerala, 54 are migratory while 14 are found only in the Western Ghats. In Kozhikode district, the census took the birders to Sarovaram Biopark, Mayoor wetlands, Kappad, Cherandathoor, and Vanaparvam Biodiversity Park.Birders also surveyed Madayipara, Chemballikundu, Ezhome, Cheruthazham Vayal in Kannur; Kadappuram, near Ponnani and Kakkadampoyil in Malappuram; and Manikunnumala in Wayanad. The Malabar Natural History Society, headquartered in Kozhikode, conducted the survey in the northern region in collaboration with Wings.""There has been a significant decrease in bird species in and around Kadalundi. Survey teams assessed a worrying decline in the number of whitebellied sea hawks in the Malabar region. It also came to light that previous havens for migratory birds such as Madayipara are no longer bird-friendly. The presence of tourists was found to affect the presence of birds. The team concluded that the situation is similar in Kadalundi and that the presence of fishing vessels in these places has adversely affected the arrival of migratory birds," he added. "Survey locations in Thiruvananthapuram included Punchakkari wetlands, Cityscape (paddy fields of Kesavadasapuram and Museum & Zoo premises, etc.)

Waqf Board issue of marriage certificates on hold, says Karnataka HC

BENGALURU: The Karnataka High Court on Thursday kept in abevance till the next date of hearing, the order passed by the state government on August 30, 2023, authorising the Karnataka State Waqf Board to issue marriage certificates to Muslim applicants. It is difficult to perceive that marriage certificates issued by the Waqf Board (WB) and its officers could be used for any official purpose, the court added. The division bench of Chief Justice NV Anjaria and Justice

K V Aravind passed the detailed interim order after hearing a public interest litigation filed by Alam Pasha, founder of The Helping Citizen and People's Court, a non-government organisation, questioning the legality of the impugned order issued by the state government in 2023, conferring powers to the Waqf Board to register Muslim marriages. Further hearing is adjourned to January 7. The court noted that prima facie reading of

the provisions of the WB Act, the Board



certificates. The impugned order, although operative for long, is clearly beyond the powers and amounts to usurping of powers which are not available under law, much less under the Waqf Act.Prima facie, it is difficult to justify the issue of marriage certificates by the Board. 273 local bodies in Kerala critical zones of human-wildlife conflicts, reveals study

THIRUVANANTHAPURAM: A comprehensive study by the forest department on human-wildlife conflicts has identified around 273 local bodies in the state as critical zones. Of them, 30 have been flagged as major hotspots. And of these 30, nine - seven of them in Wayanad alone – have been identified as highly critical, having reported a high number of conflicts and deaths. The state government is preparing a comprehensive master plan to mitigate the growing human-wild animal conflicts in Kerala, Forest Minister A K Saseendran said on Thursday. The forest department study looked at the humanwildlife conflicts over the past 10 years. As many as 840 people died in these conflicts. So far this year, wildlife attacks have claimed 39 lives. "A master plan with specific mitigation measures for respective hotspots will be drawn up to address the crisis," Saseendran said. As the first step, Kerala has been divided into 12 landscapes



based on conflict-prone regions. The plan is to devise landscape-level master plans, by devising solutions specific to the region, and consolidate them into a state-level action plan.On the occasion, Saseendran also launched the website of 'Safe Habitat Hack'-a hackathon being organised by the forest department in collaboration with K-DISC (Kerala Development and Innovation Strategic Council) to generate innovative ideas for mitigating humanwildlife conflicts. The plan is to invite

startups, agencies working in the field, researchers and other experts and come up with strategies for the master plan. Among other things, the hackathon aims to address inefficiencies in solar fencing and barriers, lack of advanced real-time monitoring devices, and practical challenges in implementing these technologies in forest areas. It will also look to find solutions for habitat degradation, and creating region-specific mitigation strategies.Participants can submit ideas and concepts until December 20. The shortlisted ideas will be featured at an event to be held on February 15, 2025, in Thiruvananthapuram.

Mission Fencing 2024

One of the key projects that would be taken up under the master plan is Mission Fencing 2024, which aims to repair and upgrade existing solar fences stretching 1,400-km across the state. The forest department will launch a month-long campaign to assess the present condition of

Minimum temp in Gurgaon rises to 11°C, but likely to drop by 2-4°C

Gurgaon: As the city woke up to a sunny day with light fog, the maximum temperature on Thursday reached 26.4 degrees Celsius, 1.2 degrees higher than Wednesday. The minimum temperature also increased slightly, settling at 11 degrees Ĉelsius. It was recorded at 10.8 degrees the previous day. The India Meteorological Department (IMD) withdrew its 'yellow' alert for 'dense' to 'very dense' fog in the region.According to IMD's forecast, the minimum temperature may plummet by 2-4 degrees Celsius over the next two days.

However, temperatures across the northern plains remain above the usual levels for this time of year, and this trend is expected to continue for the next fortnight, after which temperatures are predicted to decrease gradually.Meanwhile, Delhi recorded the coldest morning of the season on Thursday. The minimum temperature dipped to 10.2 degrees Celsius, two notches below normal, at Safdarjung, which is the city's base station. As north-westerly winds, which bring cold air, are prevailing in the region, the minimum is likely to remain around 10 degrees on Friday.Some stations saw a lower minimum temperature than Safdarjung. The North Delhi Ridge was the coldest with a minimum temperature dropping to 8.1 degrees Celsius, five notches below normal.It was followed by Lodhi Road, where the minimum settled at 9.2 degrees Celsius, two degrees below normal.IMD's data shows that since Monday, when the minimum temperature was recorded at 16.2 degrees Celsius, the mercury dipped by six degrees. Apart from north-westerly winds, the minimum temperature is witnessing a dip due to radiational cooling.

11 held for posing as tech support staff to cheat foreigners

Noida: Police have busted a sham call centre, operating out of Sector 117, that would hack computers, mostly of foreign nationals, by sending them viruses through pop-up messages and then offering to fix the glitchCops acted on a tip-off and rounded up 11 people, most of them in their 20s, working at the centre on Thursday even as the mastermind remained on the run. Police also seized 19 laptops, 20 mobile phones, 5 SIM cards and other computer eripherals from the centre.

The accused would usually send pop-up messages to a victim's computer. If people clicked on them, it would cause their system to crash. One of the accused would then connect with the victims posing as a Microsoft service team and offer to fix the glitch. Instead, they would hack the computers and wipe out their bank accounts. The money, police said, would be routed to their accounts through hawala channels.DCP Rambadan Singh said the mastermind is also wanted in a similar case registered in Dehradun, Uttarakhand.

Illegal health supplement mfg unit busted in Loni, 8 samples sent for testing

Ghaziabad: An illegal health supplements manufacturing unit, operating from the ground floor of a house in Loni, was busted by a police team on Wednesday. The manufacturing unit's owner did not have a licence for the factory. A total of eight samples of raw materials weighing over 100kg and 41 cans of finished products weighing 500gm each, used in the production of health supplements, were seized. According to assistant commissioner (Food) 2, Dr Arvind Yadav, the raid was carried out following a tip-off from local police.

The raid revealed that health supplements, particularly protein powder, were being manufactured in a room on the ground floor of the residence. The owner of the unit, Himanshu Bhardwaj, was questioned about the requisite licence for the food business."Bhardwaj



admitted to not possessing one. As per rules, health supplements are regulated as food by the Food Safety and Standards Authority of India (FSSAI) and an FSSAI licence is mandatory for the manufacturing and sale of such products," said Dr YadavOfficials found 41 cans of a mixture of muscle recovery and electrolytes, weighing 500gm each, which were being stored beyond their expiry date. "These were being used at the manufacturing unit to process protein powders using other raw materials. These were confiscated and have been sent for laboratory tests. Once their report is received, further action will be taken against the manufacturer under the Food Safety and Standards Act," Dr Yadav added.

He added that the manufacturer could not produce any records of where the raw material was sourced from."During inquiry, it was also found that the protein powder was being processed and packaged here in Ghaziabad and transported to a seller in Delhi where the labelling was done for retail sale. Further investigation is underway," said Dr Yadav.

AQI improves to 'poor' after 8 days

Noida: The region witnessed an improvement in air quality on Thursday, as wind speeds increased and AQI dropped to the 'poor' category in both Noida and Ghaziabad. Noida recorded an AQI of 253, a notable drop from Wednesday's 304 (very poor). Greater Noida recorded an even larger drop, recording an AQI of 212, against 304 the day before. In neighbouring Ghaziabad, AQI stood at 291, down from 328 the day before.Air monitoring stations in both districts recorded varying AQI levels ranging from 'moderate' to 'severe' across the two districts. In Noida, the Sector 62 air quality monitoring station - which covers the industrial and commercial areas off the DME – recorded 'very poor' air quality. At 4pm, the average AQI at the station was 320. The Sector 116 and Sector 125 stations, however, recorded AQI in the 'poor' category at 231 and 262 respectively. At 199 in the 'moderate' category, the Sector 1 station recorded the best air quality in the city.In Greater Noida, the Knowledge Park 3 and 5 stations recorded air quality in the 'poor' category with AQI recorded at 202 and 223, respectively.Ghaziabad's Loni recorded the worst air quality at 402 in the 'severe' category on Thursday, followed by Vasundhara (303) in the 'very poor' category and Sanjay Nagar (258) in the



'poor' category. Indirapuram recorded the best air quality in the district on Thursday at 200 (moderate). According to weather analysts, chances of smog formation will be slightly less due to dry westerly winds; however, the air quality may not see substantial improvement either."The winds may catch up marginally, the city will see westerly winds which are dry so the moisture levels will remain low. Thus, smog formation may drop as well. However, due to the drop in the temperatures, dispersion of pollution would be marginal as well," said Mahesh Palwat, Vice Chairman, Climate Change and Meteorology, Skymet.IITM forecast

predicted that air quality is likely to remain in the 'very poor' category from Nov 21 to Nov 24,As a haze of pollution blanketed the region, schools across NCR have been closed and classes turned to online mode for many. Offices have also turned to implementing work from home so employees can avoid stepping out under these circumstances. The district administrations of both Noida and Ghaziabad districts have issued an advisory for staggered timings at govt offices.On Nov 20, the Commission for Air Quality Management (CAQM) introduced a revised Graded Response Action Plan (GRAP) for the NCR and



UN Calls Use Of New Russian Missile In Ukraine "Worrying"

United Nations, United States. Russia's use of a new medium-range ballistic missile to strike Ukraine was a "worrying development," the spokesman for UN Secretary-General Antonio Guterres said Thursday."This is yet another concerning and worrying development. All of this (is) going in the wrong direction," said Stephane Dujarric, calling on all parties to de-escalate the conflict. He repeated UN chief Antonio Guterres's call for an end to the war in compliance with international law, and urged both sides "to protect civilians, not hit civilian targets or critical civilian infrastructure."Russian President Vladimir Putin said Thursday that his country's forces



had hit Ukraine with a new mid-range hypersonic ballistic missile, dubbed the "Oreshnik," in a "nonnuclear" configuration.Russia struck the central Ukrainian city of Dnipro with a barrage of missiles early Thursday. This week, the United States further ramped up aid to its Ukrainian ally by authorizing the supply of anti-personnel landmines, a major policy shift slammed by rights groups.

Asked about the US decision, Dujarric reiterated the UN's opposition to the use of those weapons."Our stand against the use of mines anywhere in the world remains the same," he said.

Trump Pick Matt Gaetz Withdraws As Nominee For **US Attorney General**

Washington. Scandal-plagued Matt Gaetz, who was nominated by President-elect Donald Trump to be US attorney general, on Thursday pulled out of the confirmation process in an early setback for the incoming administration. Gaetz was one of Trump's several eye-catching selections, including Fox News host Pete Hegseth as defense secretary, vaccine skeptic Robert F. Kennedy Jr. as health secretary and billionaire Elon Musk to head a government costcutting unit.A congressional panel had been investigating alleged illegal activity by Gaetz, including sexual misconduct with a 17-year-old girl -which he denies -- as well as drug use and misappropriating campaign funds. He was facing an uphill battle to win confirmation in the Senate for the top legal role of attorney general due to widespread opposition, including from within his own Republican Party.

I had excellent meetings with Senators yesterday. I appreciate their thoughtful feedback -- and the incredible support of so many," Gaetz said on X."While the momentum was strong, it is clear that my confirmation was unfairly becoming a distraction to the critical work of the Trump/Vance Transition."Gaetz was first elected to the US House of Representatives in 2016 and won reelection this month, but he resigned as a congressman shortly after Trump picked him to be attorney general." Matt has a wonderful future, and I look forward to watching all of the great things he will do," Trump said in response to his withdrawal. Several of Trump's nominations have triggered criticism, and the latest transition turmoil came as new lurid details emerged about Defense nominee Hegseth.

North Korea's Kim Accuses US Of Escalating Tensions, Warns Of Nuclear War

Seoul. North Korean leader Kim Jong Un has accused the United States of ramping up tension and provocations, saying the Korean peninsula has never faced such risks of nuclear war as now, state media KCNA said on Friday.In a speech at a military exhibition on Thursday in Pyongyang, Kim said his previous experience of negotiations with Washington only highlighted its "aggressive and hostile" policy against Pyongyang, KČNA said."Never before have the warring parties on the Korean peninsula faced such a dangerous and acute confrontation that it could escalate into the most destructive thermonuclear war," Kim said, according to KCNA."We have already gone as far as we can on negotiating with the United States, but what we became certain of from the result is not the superpower's willingness to coexist, but its thorough stance of power and aggressive and hostile policy toward us that can never change."

During US President-elect Donald Trump's first term, he and Kim held three unprecedented meetings in Singapore, Hanoi, and at the Korean border in 2018 and 2019. But their diplomacy failed to achieve any concrete outcome due to differences between US calls for North Korea to abandon its nuclear weapons and Kim's demands for sanctions relief.

Trump has long touted his ties with Kim, saying last month that the two countries "would've had a nuclear war with millions of people killed" but he stopped it thanks to their relationship. North Korean state media has not yet publicly mentioned Trump's reelection.Kim, in the speech, called for developing and upgrading weaponry into "ultra-modern ones" and vowed to continue advancing defence capabilities to bolster the country's strategic position, KCNA said. The event, called the Defence Development Exhibition, featured strategic and tactical weapons.

Beirut. Lebanon said Israeli strikes Thursday on the country's east and south killed 52 people, as raids also hit south Beirut and Hezbollah claimed its deepest attack on Israel in over a year. After World Court's Arrest Warrant, Netanyahu Invokes 1894 Dreyfus Trial

WORLD. Denouncing the International Criminal Court (ICC), Israeli Prime Minister Benjamin Netanyahu likened the court's arrest warrant against him to the infamous Dreyfus trial of 1894. The Dreyfus trial, which began in 1894, involved a Jewish French army officer falsely accused of treason based on fabricated evidence. The ICC's move accuses Netanyahu and former Israeli defence minister Yoav Gallant of war crimes in the ongoing Gaza conflict, a decision

Netanyahu lambasted as "anti-Semitic" and reflective of a "modern-day Dreyfus trial.""The anti-Semitic decision of the International Criminal Court is comparable to a modern-day Dreyfus trial and it will end in the same way,' Netanyahu declared, referring to the wrongful conviction of Alfred Dreyfus, a



Jewish French army officer, in a landmark case that exposed deep anti-Semitism in late 19th-century France.The Dreyfus Affair was one of the most controversial legal scandals of 19th-century France, marked by anti-Semitism and judicial corruption. Alfred Dreyfus, a French Jewish army captain, was wrongfully convicted of treason in 1894 based on

fabricated evidence. Stripped of his rank in a humiliating public ceremony and exiled to Devil's Island, a former penal colony in french Guayana, Dreyfus's plight became a symbol of systemic injustice and anti-Semitism.

French authorities accused Dreyfus of leaking military secrets based on a scrap of handwriting vaguely resembling his own. The trial, fueled by rampant anti-Semitism, resulted in a conviction despite evidence pointing to another officer, Ferdinand Esterhazy, as the true culprit. The case divided France, with prominent

intellectuals like Émile Zola denouncing the injustice in his famous open letter, J'accuse...!The ICC has issued warrants for Netanyahu and Gallant over alleged war crimes and crimes against humanity in Gaza following Hamas's brutal October 7 attacks on Israel. These attacks, which left over 1,400 Israelis dead and led to the kidnapping of hundreds, triggered a massive Israeli military response, resulting in immense loss of life and devastation in Gaza. The warrants mark the first time an Israeli head of state has been targeted by the court.Netanyahu rejected the ICC's actions as "absurd and false," accusing Chief Prosecutor Karim Khan of corruption and alleging the decision was an attempt to distract from accusations of sexual harassment against Khan - charges Khan has denied. Israeli President Isaac Herzog described the ICC's move as a "dark day for justice," while Foreign Minister Gideon Saar said the court had "lost all legitimacy."

Human rights group B'Tselem, however, welcomed the ICC's actions, urging international enforcement of the warrants. The group called the warrants "a critical step toward accountability for leaders responsible for crimes committed in the Israeli-Palestinian conflict."

21 get life term for killing Dalit woman 14 years ago

TUMAKURU: A local court here on Thursday sentenced 21 people, including two women, to life imprisonment for murdering a Dalit woman 14 years ago.Judge Nageereddy also ordered them to pay a fine of Rs 5,000 each. They murdered 'Dhaba' Honnamma, 45, at Gopalapura village in Chikkanayakanahalli taluk on June 28, 2010. The convicted are Ranganath GS, Majula, Raju alias Devaraju, Srinivasa, Swamy alias Anandaswamy, Venkataswamy, Venkatesh, Nagaraju, Rajappa alias Ramaiah, Meese Hanumanthaiah, Gangadhara alias Ganganna, Satyappa alias Satisha, Nanjundaiah, Chandrashekar alias Chandraiah, Ranganna alias Ramaiah, Umesha, Bulle Hanumanthaiah, Channamma alias Chinnamma, Jayanna alias Jayakumar alias Narasingaiah, KG Manju and Swamy. Six of the accused died when the trial was on. Tiptur DySP Shivarudraswamy investigated the case and filed the chargesheet against 27 accused. Honnamma had filed a complaint with Handanakere police against some of the accused for allegedly smuggling the logs she had collected to build her dhaba. She ran the dhaba along with her live-in partner. She had also unsuccessfully contested gram panchayat elections twice. She was an office-bearer of Chikkanayakanahalli taluk

AP Legislative Assembly resolves to provide 33 per cent BC quota

VIJAYAWADA: The AP Legislative Assembly on Thursday resolved to provide 33% reservation to Backward Classes (BCs) in the legislative bodies. In the afternoon session of the Assembly, Minister for BC Welfare S Savitha introduced the resolution.

Elaborating on the importance of 33% reservation for BCs, Chief Minister N Chandrababu Naidu said the TDP has been most supportive of BCs since its inception, and advocated their political empowerment.

'IT was our party founder NT Rama Rao, who emphasised social justice, had reserved 25% of seats in local bodies for BCs, which was enhanced to 33% when I became the Chief Minister," Naidu said. Elaborating on how the TDP has been following the policy of political empowerment of BCs within the party, he said several stalwarts like K Yerran Naidu, KE Krishnamurthy and Devender Goud were given priority. He further said though they did social engineering and ensured BCs were given party tickets during the recent elections, much more needs to be

"We should understand that BCs are dependent on traditional occupations for their economic survival. With traditional occupations slowly becoming wane, economic support is needed for such people. The government is making every effort to help out these sections," he asserted.

However, Naidu opined that justice can be done to BCs only when they have political representation by their population strength. Hence, the AP Assembly has resolved to provide 33% reservation to BCs in the legislative bodies. "We will also advocate similar reservation at the national level," he

Andhra Minister Lokesh tweet alerts officials to rescue child beggars

KURNOOL: Kurnool district authorities launched a swift operation to combat child begging after HRD and IT Minister Nara Lokesh responded to a viral video showing a child in a dazed state at Dress Circle in Kurnool city. The video, shared by netizen Santhosh Kumar, triggered public outrage and prompted the Minister's immediate intervention on the platform X (formerly Twitter). Expressing his concern, Minister Lokesh wrote, "This is heartbreaking. Every child deserves safety, love, and dignity. We will locate this child and ensure they receive protection and care. Those responsible will be held accountable." He also pledged to work with authorities to prevent such incidents and promote safe and nurturing environments for children.

Responding to the Lokesh's remarks, the district administration conducted a citywide drive to identify and rescue children involved in begging. Several children were traced and presented before the Child Welfare Committee (CWC) for assistance. Under the Juvenile Justice Act, the rescued children were placed in Child Care Institutes for rehabilitation, where they will receive necessary support and education.

CWC Chairperson S Zubaida Begum emphasised the importance of shielding vulnerable children from exploitation. "Our focus is on ensuring these children have a secure environment and opportunities for a better future," she said. She also appealed to parents to prioritise education over sending children to beg, highlighting that over 70% of child beggars belong to economically distressed families. As part of the operation, district officials counselled parents to understand the long-term harm of child begging and stressed the importance of education. Authorities pledged to intensify their crackdown on the issue while focusing on providing food, shelter, and access to schooling for affected children.

Three years after G.O, advisory panel in schools to curb sexual harassment non-functional

CHENNAI: Though the state's school education department issued a government order (G.O.) in June 2021 outlining safety guidelines to protect students from sexual harassment, the measures laid out in the order have largely remained on paper. The G.O. was issued after the schools in the state became the focus of the #MeToo movement, especially after allegations of sexual harassment against a commerce teacher in PSBB School.

In a recent incident, a physical education teacher of a private school in Thoothukudi was accused of spiking soft drinks with alcohol to harass female students. Interestingly, the state government swiftly issued a statement highlighting 'proactive measures' such as the formation of Student Safeguarding Advisory Committees mandated by the 2021 G.O. However, headmasters of both government and private schools spoke to said these committees are non-functional.The G.O. established a high-level committee, initially headed by the nowdefunct post of school education commissioner, with members including the school education director, police officers from the cybercrime and crimes against women and children wings, two educationists, and two psychologists. It is the committee that



mandated the formation of school-level committees with principal, two teachers, parents, a management representative, non-teaching staff, and optionally, an external person as members. The principal is a permanent member and half the committee members must be replaced annually.

The guidelines designate November 15 to 22 as Child Abuse Prevention Week. This week was chosen to align with November 19, observed as the World Day for Prevention of Child Abuse. When introduced in 2021, the initiative was actively led by School Education Minister Anbil Mahesh Poyyamozhi. In 2022, the directors of Elementary Schools and SCERT issued a circular instructing schools to observe the week with awareness programmes. However, no such circular was issued in 2023, and the initiative appears to have been forgotten this year as well.

Similarly, schools are mandated to conduct annual orientation programmes on sexual offences under Pocso Act, submit compliance reports to the government and carry out safety

Yet, these critical measures are largely neglected.At least 10 headmasters of higher secondary government schools said Student Safeguarding Advisory Committees, formed around 2021-22, are not being reconstituted

regularly. "The department issues circulars to form various committees. The guidelines are not clear on who should conduct the annual orientation programmes for the teachers.

Most committees are largely dysfunctional as we didn't receive any instructions to reconstitute them for the past two years," said a member of a government school headmasters' association. Activists criticised the lack of implementation of multiple G.O.s meant to ensure student safety and called for a holistic plan to prevent sexual harrasment incidents in schools.

Meanwhile, school education department said they have asked the officials to ensure the G.O. issued in 2021 is implemented. On the conduct of awareness week, they said they would conduct it in December as the students have examinations at present.

Kerala MPs to raise lack of Centre aid for Wayanad landslide rehabilitation



THIRUVANANTHAPURAM: MPs from Kerala on Thursday unanimously decided to raise the lack of entral assistance to survivors and relatives of the July 30 Wayanad landslides, as well as the demand to declare the disaster as L3 category, in the Parliament. An L3 disaster is a nearly catastrophic or very large-scale disaster that overwhelms state and district authorities. The decision was taken at the meeting called by the state government ahead of the start of the winter session of the Parliament on Monday.Chief Minister Pinarayi Vijayan, who chaired the meeting, told the MPs that not a single penny had been allotted to the state as aid even 100 days after the PM visited the disaster-struck areas. At the meeting, opposition MPs flayed the state government for making an unnecessary demand - to declare the landslides a national disaster – in its representation and memorandum submitted to the Centre.RSP MP N K Premachandran asked the rationale behind the government's demand when there was no provision to declare a disaster as such. The CM said since the state government had declared the landslides as a calamity of severe nature, all the MPs from Kerala could donate up to Rs 25 lakh from their MPLADS fund towards relief. None of the MPs responded to his statement.

Waterbodies brim across western Tamil Nadu, arrival of migratory birds dip in Coimbatore

COIMBATORE: According to the Coimbatore Nature Society (CNS), which conducted a study of wetlands in the district, the arrival of migratory bird species in Coimbatore is sharply declining. Experts say most waterbodies in western TN, due to rainfall, have a widespread availability of prey, which could be a reason for the birds not to converge at a single place. The study was conducted from November 12 - 17 by a team of 35 members from the society, and it was coordinated by senior bird watcher A Pavendhan. The study has revealed that only 25 migratory bird species were present in wetlands of Coimbatore compared to 47 species observed in January this year. According to the study,

migratory bird count declined to 1,060 individual birds from 2,816 recorded during January. Among 25 migratory bird species, eight are water birds and the remaining 17 are terrestrial birds. "Migratory waterfowl species are missing in most of the wetlands. In fact, Northern Shoveler was the only migrant duck species recorded during the study. Even waders like Sandpipers, plovers are missing or very low in number. Warblers are the ones who are usually the first ones to arrive but are largely missing and very few.Migratory raptors like Booted eagles, Greater Spotted eagles, Ospreys and Marsh Harriers are missing in most wetlands. Even resident birds like Pelicans, Eurasian Spoonbills, Ibises, storks are

very few in number," said G Prakash, a

senior bird watcher in CNS.

This year, we have experienced very good rainfall and almost all the wetlands are filled with water. This is not just true of Coimbatore, but our neighbouring districts as well. In a year of good rainfall, migratory birds have no reason to congregate in one place and tend to spread out. This could be one reason for less migratory birds. Upcoming January migratory bird estimate is expected to validate this," said A Pavendhan.

He added "Due to recent tank desilting work carried out in various tanks, the natural vegetation has been removed from lot of tank bunds.lso, the gradual gradient in tanks have been replaced by a steep gradient. This makes wetlands unsuitable for wading birds like sandpipers and migratory raptors like Booted eagles, Ospreys, Greater spotted eagles and Marsh Harriers."The study also revealed how the flow of untreated domestic sewage and industrial sewage into the wetlands has resulted in a decline in fish populations and kept off birds which feed on them.

Keep away please! Theyyam lovers unhappy with vloggers, call for curbs

KANNUR: Theyyam, the iconic ritual art form of north Kerala, has mesmerised people worldwide, thanks to social media. However, the increasing influx of vloggers, eager to capture the art form's vivid grandeur, is creating challenges for temple administrators. Sacred kavus (groves) now see crowds of 'influencers' vying for the perfect shot, often encroaching close to performers. The growing obsession with filming the vibrant art form has disrupted the sanctity of the ritual and left temple authorities struggling to control the crowd and maintain order. As the popularity of Theyyam continues to grow globally, enthusiasts and temple authorities are voicing concerns about the intrusive behaviour of vloggers and amateur videographers during these sacred rituals. Many are now calling for restrictions on close-range videography to preserve the sanctity of the art form. "It is true that social media has brought worldwide recognition to Theyyam. Earlier, only dedicated enthusiasts would visit the kavus to witness the art form. Now, with social media, people from across the globe can view performances being held even in the remote corners of Kannur," said Prabhakaran Kovoor, a Theyyam enthusiast and admin of the Theyyam Calendar WhatsApp group.He also acknowledges the weak side of the exposure. "Issues are cropping up with the rise of vloggers. Everyone, from visitors to casual spectators, carries a phone to record the rituals. Some even enter makeup rooms to capture the artists getting ready for their performances. Others get dangerously close to the Theyya kolams, disrupting the rituals. We are not asking for a total ban, but there should be restrictions to prevent such interruptions," he expressed.

Photographer and vlogger Priyesh M B, who has been documenting rare Theyyam performances for 13 years now, echoes similar sentiments." When I started Theyyam photography, only a few photographers visited kavus, and they respected the rituals and traditions. Now, anyone with a phone is a vlogger. They encroach on performance areas and even run alongside Theyyams for closeup shots," Priyesh shared.

He further warned of the dangers posed by such ignorance. "Some of these Theyyams are aggressive. Approaching them sans caution can trigger an unexpected reaction, creating panic among spectators. The only viable solution is to establish boundaries around the performance area to prevent vloggers from getting too close," Priyesh suggested. Temple authorities also face challenges in managing the growing issue. "It is nearly impossible to enforce restrictions with barricades or ropes, as they might worsen the situation. In nearby kavus, volunteers manage the crowd, including photographers. Since these vloggers often come from other districts, it is nearly impossible to take direct action against them," said Sumithran V P, secretary of Kadannapally Muchilottukavu.

No surge in vector-borne diseases in Telangana, says DPH

HYDERABAD: Clearing the air regarding the advisory issued by the US Centre for Disease Control and Prevention (CDC) in November for travellers returning from Telangana, the Health department on Thursday said that most of the chikungunya (a vector-borne disease) cases in the state were reported in August and September. The Director of Public Health & Family Welfare (DPH) said that most cases were reported during August and September and there was a sharp decline in the number after October. The DPH also made it clear that no chikungunya deaths were reported in the state so far. The DPH also said that the Health department took proactive measures well ahead of the monsoon season to prevent any outbreak of seasonal diseases.

These included state and district level convergence meetings with line departments, issuing timely health advisories, door-to-door fever survey in high risk areas, close monitoring of the situation, intensified surveillance and



reporting network, intensified integrated vector control measures like fogging/spraying and source reduction activities.

In addition, an adequate number of testing kits and essential medicines were made available in all health facilities across

the state. Health Commissioner RV Karnan told TNIE, "Instances of vector-borne diseases (VBD) reduced significantly in October and November in the state. We urge the public not to panic as all necessary measures are taken and the situation is effectively under control and there is no alarming situation as close monitoring through surveillance and availability of testing kits has been ensured by the government."

Meanwhile, doctors in Hyderabad said that there was a surge in respiratory tract infections related to the upper respiratory tract (URT), besides the post chikungunya arthritis, which comes with severe joint pains that can be experienced in patients for a duration of one to two months.Dr

Shiva Raju K, head of the medicine department, KIMS Hospitals, told: "Post chikungunya, body pains are observed in all age groups including younger people, but older age groups find it more intense. We are also seeing other viral fevers and the cases are likely to rise as the cold increases."

Remember to take nothing personally

In the late 1990s, two Laotian men walked into a Los Angeles bar where an Asian singer performed. After occupying their seats, they felt like sitting more comfortably and spreading their legs but did not realise that their feet were pointing towards the singer. When the bar closed, she followed them to the parking lot and expressed displeasure. Instead of admitting their mistake and apologising, the tourists started quarrelling with her. As the altercation turned ugly, the singer took out her revolver and killed one of them.

Perhaps this tragedy could have been averted had the lady not taken the two men's behaviour so personally and left them after expressing her displeasure. Similarly, the two men could have said that they did not mean any insult to her and apologised to assuage her feelings of hurt, but they did not. Why? Like most people, the two men and the lady could not separate people from their unpleasant words or behaviours and took these personally.

People often suffer more from their reactions and the negative emotions accompanying them than from others' behaviours that evoke these. Shifting your focus from judging what others are doing to you to observing how you respond to it and not taking anything personally can avert many undesirable consequences.

There will undoubtedly be times when others may misperceive who we are, misunderstand our intentions or motives, and knowingly or unknowingly say and do things that hurt us. Unless we distance ourselves from our ideas, beliefs, and behaviours (and separate others from theirs) and train ourselves to take nothing personally, we will feel attacked whenever our opinions or ideas are contradicted.

Unfortunately, most people are like ghostly gramophones playing and replaying the records of unconscious habits. They are oblivious to their behaviour the way a sleeping infant is when he kicks in her mother's face while sleeping by her side.People's behaviour reflects how their unconscious mind is programmed and how they have learnt to interpret life's experiences and express, respond to, or fulfil a need. It says a lot about what they have gone through and what life has taught them, but nothing about you.

Most meaningful discussions are either not initiated, aborted midway, or end unpleasantly while adversely impacting relationships because we are too attached to and inflexibly sure of our views. We have an evolutionary need to win arguments and prove our views and opinions factually or morally more correct, even when they may be wrong or ill-informed. As a result, we fritter away most learning opportunities.Driving a wedge between us and our ideas, beliefs, or opinions (or whatever else we say after the words "my" or "our") and not taking anything personally is being kind to ourselves and others.

Cancer calls for a coherent health system response

Cardiovascular disease, manifesting principally as heart attacks and brain strokes, is the leading cause of death globally. In India too, it emerged in recent decades as the top cause of adult deaths. However, an international collaborative study of 2,00,000 people in 27 countries reported in 2019 that cancer recently overtook cardiovascular disease in high income countries. The study noted cardiovascular disease remained the leading cause of death in low and middle income countries (LMICs).

Cancer is growing as a major cause of disease, disability and death in LMICs too, though it trails cardiovascular disease in the list of killer diseases. The rise in cancer burden in these countries is both due to increasing incidence of new cancers and inability of health services to provide timely detection and treatment. Cancer cases are rising due to higher levels of population exposure to unhealthy diets, physical inactivity, air pollution, environmental toxins, tobacco products and alcoholic beverages. An Indian Council of Medical Research study projected a 12.8 percent increase in the incidence of cancer cases in India between 2020 and 2025. In 2022, India had 14.1 lakh new cancer cases and 9.1 lakh deaths due to cancer. These estimates are likely to be short of the real cancer burden.

Decline in cardiovascular mortality rates in high income countries over the past four decades happened not only due to better diets, less smoking and more exercise but also due to many life-saving treatments. Effective therapies emerged from basic and clinical research. They

were widely applied, resulting in many deaths being averted. While many behavioural risk factors are common to cancer and cardiovascular disease, highly effective treatments were less visible and impactful in the cancer arena-till recently. However, the last decade has seen many advances in the diagnosis and treatment of cancer. Organ imaging as well as laboratory techniques in tissue histology and pathology have advanced greatly. Integration of clinical data with new molecular data (germ line genomics, tumour genomics, epigenomics, pharmacogenomics and circulating tumour DNA) greatly increased diagnostic precision and personalised approaches to treatment. Artificial intelligence is providing great support for enhancing these diagnostic capabilities. Novel treatments have emerged, through antibodies. Some of these antibodies can destroy the connection between the cell and proteins that promote cell growth. CAR-T cell therapies are providing a pathway for customising cancer therapy by collecting T-lymphocytes from the patient's own immune system and training them to attack cancer cells. Surgery, radiation therapy, chemotherapy, targeted drug therapies and immunotherapy have now become the five pillars of cancer treatment.

Despite these remarkable advances, access to cancer diagnostics and treatments is still limited for patients in low and middle income countries and for poor people in high-income countries. While treatments for childhood cancers have been shown to be remarkably successful, they are not benefiting many



children in low and middle income countries. The World Health Organization reports that while over 80 percent of children with cancer are cured in highincome countries, less than 30 percent in developing countries benefit. Poor cancer care results from late detection, lack of capacity in primary health care facilities, delayed referrals to more advanced healthcare facilities, limited availability of welltrained personnel and well-equipped cancer care facilities, high cost of tests and treatments, and gaps in follow-up care for treated patients. Palliative care for terminally ill patients is not widely available. Amongst the general public, there is a considerable lack of awareness of the causes, clinical manifestations, facilities and options for care. This results in delayed self-referral for evaluation, inadequate investigations, ineffective treatments and poor health outcomes.

outer wall of a cancer cell while others can block the All of these deficiencies are related to the design, resourcing and performance of the country's health system, which is a composite of public, private and voluntary healthcare providers. Central and state governments together provide the governance of this mixed health system. The central government shapes policy and states steer the services, with financial resources flowing from both.

From specialists in cancer diagnostics to frontline health workers and informal care providers, the range of people engaged in cancer care is large, while their numbers are short of need. Their geographic distribution is skewed across states and urban-rural divides. Inability to adopt a pluralistic approach to cancer care deprives the benefits that

can accrue from some traditional systems of medicine. While a national programme for cancer control exists, it has not kept pace with diagnostic and therapeutic advances, nor has it scaled up financial and human resources to needed levels. Primary care services must provide the platform for prevention, early diagnosis, timely referral and continuity of follow-up care. District and medical college hospitals must provide different levels of advanced diagnostic and therapeutic facilities. Private sector's capacity and skills may be engaged as needed, to supplement the public sector's capabilities.

As India shapes and strengthens its Ayushman Bharat programme, cancer care has to be firmly positioned amidst its range of publicly

financed healthcare services. Cancer-related diagnostics and treatments often become prohibitively expensive for patients and impoverishing for families. Much of the high cost is due to import of equipment, diagnostic reagents and drugs.Domestic capacity for their production has to be scaled up, including production of biosimilars of highly effective drugs. Pooled procurement of drugs can effectively reduce medicine costs. The National Cancer Grid, a network of over 250 cancer centres in India, piloted pooled procurement of 40 cancer drugs. Median savings of 82 percent were achieved (range: 23 to 99 percent), with an estimated cost saving of '13.2 billion. Such practices, if widely adopted, can greatly reduce the financial burden on governments, patients and families.

Skilled workforce, quality consciousness for manufacturing

India needs to spend big on creating more highly skilled manpower and foster a no-compromise-onquality environment in the country.

Tata Electronics has agreed to buy a majority stake in Apple iPhone contract manufacturer Pegatron, a Taiwanese company. Earlier, the Tata Group company had bought the Karnataka plant of another iPhone contract manufacturer, Wistron. With these acquisitions, the Tatas have become a major manufacturer of iPhones in India along with Foxconn, which remains the biggest manufacturer of Apple's flagship product.

It is indeed a big leap for mobile manufacturing in India. However, it also comes as a big responsibility for the Tatas to prove their credibility globally as a manufacturer of high-end electronic products. iPhone manufacturing in India has taken off with exports posting a 37 per cent growth to \$10.5 billion in the first seven months of the current financial year over the same period last year. But so far, most of it has been manufactured by Indian subsidiaries of Taiwanese firms. The Tatas have now emerged as a major Indian player vying for the iPhone manufacturing pie. Currently, iPhone manufacturing in



the country is mostly limited to last-stage assembling, which accounts for around 15 percent of the product's value. The government aims to increase this to 40 percent. For that to happen, local manufacturers like Tatas need to up their game. Apple has big plans for India that go beyond manufacturing 50 million iPhones a year- the world's largest consumer electronics company also sees the country hosting its entire production process from planning and designing to mass production. If the Tata Group can prove its credibility in precision engineering and high-end manufacturing, it could also open the market for more local players.

India, which is aspiring to be a global manufacturing hub focusing on semiconductors, mobile phones and defence equipment, would depend on these local companies to prove its dependability on the global stage. But to incentivise such manufacturing, only cash or tax incentives may not suffice. The country needs to spend big on creating more highly-skilled manpower, and foster a no-compromise-on-quality environment in the country. More and more countries are looking inwards while trying to revive local manufacturing. That is why developed countries are raising non-tariff barriers for goods from emerging markets. If India needs to get over these hurdles, it needs to think beyond incentives.

History of the ancient Pallava capital

Kanchipuram was the capital city of the Pallavas—an audacious race of seafarers and temple builders—even though the city existed much before the Pallava dynasty came to be.

I bought myself a Kamakshi Deepam last week after years of wanting one. This naturally led to thoughts of the Devi at Kanchipuram, and I remembered a nice story from the holy city's annals. Sometime in the 1960s, a poor bangle-seller wandered from place to place, selling his wares. One day, he wandered into the temple town of Kanchipuram. Somehow, nobody seemed interested in buying anything. Tired and dejected by late afternoon, he sat down at the doorway of the Kanchi Kamakoti Matham.

From deep within, the Kanchi Paramacharya, renowned for his frequently amazing omniscience, suddenly told an aide, "Give the bangle-seller at the gate food and buttermilk. Ask him to wait. Quietly tell the devotees who come for evening darshan to buy bangles for their womenfolk in Devi's honour." Of course, they did, and the bangle-seller went away feeling cherished and successful. Not everyone may be in a position to perform great deeds of service, but good thoughts and small, sweet acts of kindness could be the lamps we light.

But a little on Kanchipuram itself. As many know, it's located about a two hours' drive north of Chennai. But there is a larger, deeper context. As mentioned in an earlier column in this series, there are seven mokshapuri or salvation cities in India, namely Kashi or Varanasi, Avantika or Ujjain, Ayodhya, Haridwar, Mathura, Dwaraka and Kanchipuram. Out of these, Kanchipuram is the sole mokshapuri city present in

The present Kamakshi temple is variously attributed to



the Pallavas and the Cholas, to well over a millennium ago but its site and structure, according to literature, was even more ancient. The central image of the goddess is considered swayambhu or self-

manifested and of imponderable antiquity. Kanchipuram was the capital city of the Pallavas-an audacious race of seafarers and temple builders—even though the city existed much before the Pallava dynasty came to be. The earliest known mention of Kanchipuram is by Panini, the Sanskrit grammarian, in about 300 BCE. It has even featured

Some Ashokan edicts are said to refer to the kingdom of 'Satyaputta' or Satyaputra, besides those of the Chera, Chola and Pandya in the south. One of the several names borne by Kanchi city is 'Satyavaratakshetra' so Satyaputta is understood to mean Kanchipuram.

The old word kanchi literally means the gold girdle worn around the waist by women. In the northern texts of the Bhagavatam, the city is given the name, Kamakoshnipuri Kanchi.

In this salvation city, the Kamakshi temple is the physical hub. It is also one point of a Shakti energy-triangle encapsulated in the local prayer-phrase 'Kanchi Kamakshi, Madurai Meenakshi, Kashi Vishalakshi'. The gopuras or towers of almost all the important temples of the city, standing far and near, reportedly face the shrine of Kamakshi.

Three of the 63 Tamil Shaivite saints called Nayanmar-Tirunavukkarasar, Tirugnanasambandar and Sundarar-have apparently referred to the Kamakottam in their devotional songs. Of them, Sambandar, has

even spoken of 'Kanchi Kamakoti' or the locality of the Kamakshi temple.

Besides its glory as a 'mokshapuri' or salvation city, Kanchipuram is also revered as a shakti peetham, since this where the nabhi or navel of Sati Devi is believed to have fallen. There is a count of 51 shakti peethas across the subcontinent, marking where the dismembered body parts of Sati Devi fell after her corpse was cut down from a grieving Lord Shiva's shoulder by Lord Vishnu.

in numerous Tamil epics of the second century CE. The northwestern-most shakti peetham is at Hinglaj

Mata in Balochistan, where Sati's brahmarandhra or crown of her head fell, and the easternmost one is her yoni at Kamakhya Devi in Guwahati (Kamakhya means Kamakshi). So Kamakshi's temple in Kanchipuram is the southernmost shakti peetham. Here, Parasakti, having Saraswathi and Parvathi as her eyes, rules Kanchi as goddess Kamakshi.The temple sits on an area of about five acres. The vimanam of the sanctum is gold-plated. Around the complex, one can see its sannidhis and mandapas, rich in its architectural splendour.

The outer prakaram houses the temple kulam (tank), and several mandapas. It also offers imposing views of the golden vimanam, pierced with four entrances on all four sides.

There is a gold-plated pillar inside the sanctum of the Kamakshi temple with a small hole in it to represent Sati Devi's navel. Childless couples come and touch it reverently to ask for the boon of a child, and Kamakshi's reputation of centuries is that she answers their prayers She blesses those who love her and trust her with well-being, good health and trouble-free lives, Anyone who is heartsore, weary or troubled, can go to her without needing to observe rigorous fasts or perform complicated rituals. As Adi Shankara put it in the third verse of the Bhavani Ashtakam,

Na Jaanami Daanam Na Cha Dhyana-Yogam/Na Jaanami Tantram Na Cha Stotra-Mantram/Na Jaanami Pujaam Na Cha Nyasa-Yogam/Gatis-Tvam Gatis-Tvam Tvam-Ekaa Bhavani

This means, 'Neither am I able to practise great charity, nor am I proficient in meditation, I don't know spells, hymns and prayers, nor do I know the rules of worship nor am I an expert in yoga. You are my sole refuge, Mother Bhavani.' Indeed a comforting, untransactional relationship for devotees.

Supreme Court Notice To Gujarat Government On Rape Convict Asaram's Plea

New Delhi: The Supreme Court on Friday sought a response from the Gujarat government on a plea filed by jailed selfstyled godman Asaram seeking suspension of the life sentence imposed on him by a bench of Justices M M Sundresh and Aravind Kumar told the counsel appearing for Asaram that it would examine the issue only if there are medical grounds."We will issue notice, but we will consider only on medical conditions," the bench said while posting the matter for hearing on December 13.

The Gujarat High Court on August 29 had rejected Asaram's plea for the suspension of life imprisonment in the case by a Gandhinagar court in 2023.Refusing to suspend the

sentence and grant him bail, the high court had observed that no case for relief was made out. The sessions court in January 2023 convicted Asaram in the 2013 rape case, filed by a woman who was living in his ashram near Gandhinagar at the time of the crime. Asaram is currently lodged in



Jodhpur jail in Rajasthan in another rape

The high court had noted that his contentions about possible delay in the disposal of his appeal, his age and the medical condition were not relevant to the grant of relief. The court had also considered the antecedents, including alleged murder of two boys at his

witnesses and relatives of victims."At this stage, considering the totality of the circumstances, the ground of possible delay in appeal and medical ailment, as well as ten years completion in jail, in our view, may not be relevant in considering the prayer of suspension of bail," the court had

Asaram's plea had said he was the victim of a conspiracy, and the allegations of rape were false. The trial court committed an error while accepting the survivor's explanation for delay of 12 years in lodging the complaint, it submitted.

His appeal against the conviction in a rape case in Jodhpur is pending before the Rajasthan High Court. Asaram's application for suspension of sentence in that case was rejected by the Rajasthan High Court in January this year.

MCD clears encroachment on 53 km stretch

The removal of encroachments has restored several key stretches to their intended use, including improving access to densely populated and commercial areas.

NEW DELHI: The Municipal Corporation of Delhi (MCD) has carried out a major antiencroachment drive in parts of the capital, clearing a 53-kilometre-long stretch and seizing a total of 453 items in November so far.

The crackdown on unauthorised encroachments took place in the civic body's City SP Zone, covering key areas such as Shyama Prasad Mukherji Marg, Church Mission Road, Purani Delhi Railway Station, Khari Baoli, and Arya Samaj Road. In a significant move, five truckloads of items were seized during a recent drive. Five truckloads of items were seized during the drive, which was carried out with the support from the police. This included the removal of temporary structures and platforms that had occupied public spaces.

Deputy Commissioner of the City SP Zone, Abhishek Kumar Mishra, said that the MCD is committed to maintaining public spaces and ensuring community safety. "This initiative reflects our dedication to restoring public land for the benefit of the community. The operation has opened up vital public areas, promoting cleaner and safer spaces for residents," he said. The removal of encroachments has restored several key stretches to their intended use, including improving access to densely populated and commercial areas. Officials said that the operation is aimed at ensuring public land remains accessible to all and is not misused. Civic officials said that residents in the affected areas have reported a noticeable improvement in cleanliness and accessibility. The civic body has assured that monitoring efforts will continue to prevent future encroachments.

Illegal encroachments have long been a major problem for the civic body. Earlier this week, the National Green Tribunal (NGT) pulled up the corporation for its lack of transparency regarding encroachments at a public park in Hauz Khas. The green body was hearing a petition that raised concerns about illegal occupation and unauthorised constructions at Kaushalya Park in South Delhi.In May, the Delhi High Court instructed landowning bodies, including the Delhi Development Authority (DDA) and the MCD, to formulate regulations for imposing charges on individuals occupying public land illegally. Currently, there is no mechanism to recover user charges or impose penalties for encroaching on public spacesIn its order dated May 27, Justice Rajnish Bhatnagar emphasized the need for accountability, stating, "Encroachers must be held liable for the extent of the illegal encroachment they commit." Encroachments over drains were one of the major causes that led to the flooding of a basement library in Rajendra Nagar on July 27 which led to the deaths of three

Flight Mode, WiFi: How Baba Siddique Murder Accused Contacted Anmol Bishnoi

Using the mobile internet hotspot of a labourer named Balwinder working in his field, Gill used to also contact



other accused in the case, including Shubham Lonkar, Zeeshan Akhtar and alleged main shooter Shiv Kumar Gautam. Usage of the labourer's hotspot would help him hide his location, Gill told the Crime Branch during his interrogation after he was arrested from Punjab's Fazilka on November 16. The accused used to keep his phone in flight mode and connect to the internet using Balwinder's hotspot.

The crime branch is currently searching for Gill's mobile phone, which may provide important clues in the case.Gill's arrest was the 24th in connection with Mr Siddique's murder. Police said he has provided logistic support in the shooting. Meanwhile, a Mumbai court had extended till November 23 the police custody of Gautam, after the police said he was not cooperating with the probe, and the weapon used in the shooting has not been recovered as yet. The four others - Anurag Kashyap, Gyan Prakash Tripathi, Akash Srivastava and Akhilendra Pratap Singh - were arrested for allegedly sheltering Gautam and helping him flee to Nepal.

Delhi today woke up to another polluted morning with a thin layer of haze and smog engulfing the city. The air quality index (AQI), however, improved marginally but remained in the "very poor" category with particulate matter 2.5 (PM2.5) being the prominent pollutant, according to the Central Pollution Control Board (CPCB).

A thick layer of smog - a toxic blend of smoke and fog - has been enveloping the Delhi-National Capital Region (NCR) for the past few days. The AOI had plummeted to the "severe-plus" category earlier this week, forcing authorities to switch schools to online classes and invoke strict pollution control measures. An AQI between 0 and 50 is considered good, 51 and 100 satisfactory, 101 and 200 moderate, 201 and 300 poor, 301 and 400 very poor, 401 and 450 severe, and above 450 severe-plus.

BJP, Congress in letter vs letter spat over President's intervention in Manipur

New Delhi:A fresh war of words erupted between the BJP and Congress on Friday after the latter party's chief Mallikarjun Kharge wrote a letter seeking President Droupadi Murmu's intervention in Manipur due to the Centre and state government's "complete failure" in defusing the ethnic violence.Countering Kharge's allegations, BJP national president JP

Nadda accused the Congress of pushing an "incorrect, false and politically motivated" narrative on the issue of the violence that erupted between the Imphal Valley-based Meiteis and tribal hills-based Kuki-Zo ethnic groups in May last year. In his two-page letter to the President on Thursday night, the Congress chief alleged that the people have lost faith in both the Central and Manipur governments, adding that Prime Minister Narendra Modi's "refusal" to visit the violence-hit state was "beyond anybody's understanding".



"I and my party strongly believe that the deliberate acts of omission and commission, as indeed inordinate inaction on the part of both the Central and state governments, have resulted in complete lawlessness, absence of rule of law, violations of human rights, compromise of national security and suppression of fundamental rights of citizens of our country," he said. Referring to Congress MP Rahul Gandhi's visits to the state, Kharge said that the "Leader of the Opposition in Lok Sabha has been in Manipur thrice in the last 18 months and I,

myself, have visited the state in this period".On Friday, in his letter to Kharge, BJP national president Nadda accused the "complete failure and illadvised strategies" of the previous Congress governments at the Centre and in Manipur in dealing with similar issues in the past, whose repurcussions are being felt even today. He also said the Congress chief seemed to have forgotten that "not only did your government legitimise the illegal migration of foreign militants to India, the then home minister P Chidambaram

had signed treaties with them". These known militant leaders fleeing their country to avoid arrest were wholeheartedly endorsed and encouraged to carry on their destabilising efforts. This complete failure of India's security and administrative protocols under your government is one of the major reasons why militant and habitually violent organisations are

attempting to destroy the hard-won peace in Manipur and push it back several decades into the age of anarchy," the BJP chied said. Unlike the Congress, the BJPled NDA government will not allow this to happen at any cost, he stressed, and added that the governments at the Centre and in Manipur have been working to stabilise the situation and protect people since the initial violence.

Further escalating the war of words, Congress General Secretary Jairam Ramesh said the BJP national president's letter was "full of falsehoods and is a 4D exercise - denial, distortion, distraction, and defamation". Ramesh tweeted that the people of Manipur yearning for normalcy, peace, and harmony are asking four simple questions: "When will the PM visit the state? How much longer will the CM continue to be inflicted on the state, when a majority of MLAs are not in his support? When will a full-time Governor for the state be appointed.

Plants may experience heat shocks in this weather'"The heatwave is harsh on everyone. The hot air burn up the leaves, making them crisp. Low humidity levels add to the stress. Tropical houseplants suffer the most because they thrive best in humid areas. The current situation is causing browning of leaves, pre-mature shedding of flowers and stunted fruit growth. Plants may experience heat shock and fail to survive," says Aditi Khattar, an urban landscape designer and founder of The Greenish Affair.

Annu Sharma, a plant expert and content creator (@plantsjunkies), says, "This year, plants are either drying up or their leaves are getting burnt due to high temperatures and hot air. Just like humans, plants also experience garm-sard if water is given during the day, damaging their roots. Indoor

plants are also affected due to the excessive use of air conditioners that lower the humidity in the room. I suggest plant parents make DIY pebble trays, fill them with water, and let their plants sit on them to enjoy much-required

While paying extra attention is crucial, some plants like money plant, monstera, areca palm, ZZ plant are still doing well indoors. Snake plant, syngonium, cactus, dragon fruit, jade, aloe vera are faring well outdoors in this weather," adds plant expert Varun Sharma.

Sanchaita, plantscape designer and owner of Baagh Bagicha in Noida, says, "Leaves are getting scorched in Delhi

summers even if they are kept in places that don't get direct sun. Plants like traveller's palms and ficus, which enjoy direct sun, are suffering too. I suggest moving plants to shaded places, to prevent them from drying out quickly. Adding cocopeat to your pots will help the soil retain moisture.

Tending tipsCheck your watering schedule - water your plants in the early morning hours or late evening to ensure absorptionMulch the soil with organic materials like husk and coco peat to help the soil retain moisture. You can add organic kitchen scrap, wood chips or dried neem leavesIf your plants are getting sunburns, shift

them to a shaded arealf you have a sun-facing balcony or a terrace garden, use a green net providing 75% shadeKeep humidity-loving plants huddled together. Keep plants on top of pebble trays filled with water or use affordable, electric humidifiers to help plants stay healthySpray water on plants in the eveningsAvoid repotting plants, until necessary.

Plants take time to adjust after repotting and they may experience shock too, so it is not advised to repot plants during peak summersPrune dead branches and leaves regularly.

Shares in Adani Enterprises, his conglomerate's main listed unit, sank more than four percent in morning trade, with similar losses in its listed ports and power subsidiaries.

multiple trading halts and Adani Enterprises has now lost more than a quarter of its market capitalisation since the indictment was released.Adani Group issued a stiff denial of the charges against its directors on Thursday, describing them as "baseless" and announcing it would Congress leader Rahul Gandhi called for Adani's arrest after the indictment was announced, but said his relationship with Modi would shield him from scrutiny."We demand that Adani be immediately arrested. But we know that won't happen as Modi is protecting him," Gandhi told reporters in New Delhi. NEW DELHI: Capital markets regulator Sebi on Thursday did away with the requirement of a mandatory security deposit with the exchanges before a public issue in a bid to facilitate ease of doing business for issuer companies.

This measure has been taken with the aim of facilitating ease of doing business for issuing companies. The new rule effective immediately. Earlier, a company looking to launch a public issue had to deposit with the stock exchanges an amount equal to 1% of issue size. The deposit would go back to the company after the issue."In order to facilitate ease of doing business, the requirement to deposit 1% of the issue size available for subscription to the public with the stock exchange by the issuers under... Sebi (Issue of Capital and Disclosure Requirements) Regulations, 2018 (ICDR Regulations) has been dispensed with," Sebi said.

In February, the Securities and Exchange



Board of India floated a consultation paper proposing the requirement of 1% security deposit for public or rights issues should be done away with. Explaining the rationale behind the move, the regulator had stated that the requirement of 1% security deposit was put in place for public/rights issues so an issuer resolves investor complaints relating to transaction like for refund of application money, allotment of securities and dispatch of

certificates.

However, considering various reforms and present framework for public or rights issues like application via ASBA (Application Supported by Blocked Amount) UPI mode of payment, mandatory allotment in demat, among others, the concerns relating to postissue investor complaints regarding refund of application money, nondispatch of physical certificates does not arise, it had added.



round, which kicks off two weeks of commemorations for the beloved cricketer. Hughes, who passed away on November 27, 2014, after being struck on the neck by a bouncer during a domestic match at the SCG, was just days away from celebrating his 26th birthday. His death remains one of the darkest moments in Australian sport, and the 10th anniversary serves as an emotional milestone for those who knew him personally and professionally.As part of the commemorations, Hughes' former team, South Australia, will

face Western Australia in Adelaide starting Saturday. Meanwhile, Hughes' childhood team, New South Wales (NSW), will play Tasmania at the SCG on Sunday, with Queensland taking on Victoria at the Gabba. In all three matches, players will wear black armbands and a moment of silence will be observed on the fourth day of play. For the Sydney and Brisbane matches, the final day of play will coincide with the exact anniversary of Hughes' passing.



Cricket Australia has also chosen to honour Hughes during the upcoming Adelaide Test between Australia and India, which begins on December 6. This match, nearly 10 years after the first Test following Hughes' death, will feature a special celebration of Hughes' life and career, with a documentary filmed in collaboration with his family. The documentary will be aired before play begins, offering a reflective tribute to the cricketer who made an indelible impact on

We understand this will be a time of reflection for the many people who knew and admired Phillip Hughes," Cricket Australia CEO Nick Hockley said. "We wanted to ensure that the Hughes family, particularly, were comfortable with any commemorations and that we celebrate Phillip's life and incredible achievements appropriately.

"Hughes' sudden passing sent shockwaves through the cricketing world, and his death left a profound mark on the game. At the time, Hughes had been in line for a recall to the Australian team after a strong performance in domestic cricket. His tragic death left the cricketing

community grappling with how to move forward, but it also brought about significant changes to player safety, including improvements in head and neck protection.In a symbolic gesture, Hughes was posthumously named Australia's 13th man for the first Test following his death. At that match, a minute of applause was observed before play, marking the beginning of a long period of mourning and reflection within the cricketing world.

With a batting average of 42 in Australia and bowling spells that showcase control and consistency, Sundar's potential has made him a compelling choice. The absence of Ashwin and Jadeja is surprising for many Australian experts, given their consistent performances for India. Ashwin,

with 3,474 Test runs and over 470 wickets, and Jadeja, with 3,235 runs and 275 wickets, have been central to India's Test dominance over the years. Both players also offer significant depth to the batting lineup, making their exclusion notable. Former Australian cricketer Michael Hussey expressed surprise at the decision, noting, "Ashwin and Jadeja can help out with the bat as well. Their experience would have been valuable."

Sundar's selection reflects India's strategy to exploit Australia's left-handed-heavy batting lineup. Australia's top seven features five left-handers, including Usman Khawaja and Travis Head. Sundar's ability to turn the ball away from left-handers provides a tactical edge, especially on a track likely to assist spinners as the match progresses.
