80,000 more people to get old-age pension in Delhi: Kejriwal

New Delhi, Nov. 25: AAP supremo Arvind Kejriwal on Monday said an additional 80,000 people are now



raising the total number of such beneficiaries to 5.3 lakh. Kejriwal said at a press conference that the Delhi government is committed to social welfare and highlighted that the decision to pay old-age pension to more people is being implemented following Cabinet approval on Sunday. On Sunday, the Delhi government launched a portal for the elderly to apply for pensions. It has

already received 10,000 applications, Kejriwal claimed. "It is a sin to stop the pensions of old people, Kejriwal said, accusing the BJP of halting pensions during his impris-

onment. "After coming out, we not only restarted the halted pensions but also added 80,000 new beneficiaries," he said. After this addition, the total number of pensioners in Delhi is around 5.3 lakh, Kejriwal added. Kejriwal further claimed that Delhi offers the highest pension rates in the country, with Rs 2,000 provided to individuals aged 60-69 and Rs

2,500 for those aged 70 and above Delhi Chief Minister Atishi and Minister Saurabh Bharadwaj were also present at the press conference. Atishi reaffirmed the government's dedication to serving the people, while Bharadwaj announced plans to extend Rs 5,000 monthly pension to differently-abled individ-

Kharge on Opposition demand for discussion, JPC on Adani issue

New Delhi, Nov 25: Congress president Mallikarjun Kharge on Monday expressed dismay over the Chair in both Houses of Parliament disallowing the opposition to raise under Rule 267 the issue of corruption allegations against the Adani Group and said the government should "let the truth come out" as the matter is affecting the country's image. Bihar a failed state: Prashant Kishor tells Bihari diaspora in US

Washington, Nov 25: Jan Suraaj leader Prashant Kishor has said Bihar is "literally a failed state" which is in "deep shit" and tremendous efforts are required for its allround development. In a virtual interaction with the Bihari diaspora community after the launch of the US chapter of the Jan Suraaj, the former poll strategist exuded confidence that his party would win the 2025 Bihar Assembly polls and said that he would lift the ban on alcohol and use the revenue to improve school education. "We have to realise that this (Bihar) is a state which is in deep shit. If Bihar were a country, it would be the 11th largest country in terms of population in the world. We have just overtaken Japan in terms of population," Kishor told the gathering. He said the biggest challenge is that society has become "hopeless" about improving the situation of Bihar. "When you become hopeless, the immediate survival needs become so overpowering that nothing (else) matters," he said. "Some hope is definitely there because of what we have been doing in the last two-and-ahalf years. But to convert this into a tangible



electoral outcome and further into a governance outcome (will take time). Anyone who wants to be part of it has to be committed for at least five-six years," he said. "Even if the government (of the Jan Suraaj) is formed in 2025 and we continue to work hard with this intensity, it would be a big thing if Bihar becomes a middle-income state by 2029-2030. It is literally a failed state as it stands today on all developmental parameters," Kishor said. The characteristics of failed states are visible in the population here. For example, sometimes we think... why are people in Sudan fighting for 20 years in the civil war because when you are in that failed state, then people are not worried about how our children will study in Sudan. They are worried about who to shoot and where to capture. So that is the situation in Bihar too and we must be aware of it," he added. Kishor told the Bihari diaspora community that he was "not trying to scare them" but making them aware of the ground realities and the long road ahead. "The Jan Suraaj will win in 2025 (Bihar Assembly elections). There is no doubt about it. (Based on my) electoral understanding, I can clearly see that we will win," he said. Kishor said if the Jan Suraaj is voted to power, his top priority would be improving school education and this would be funded by the revenue generated after lift-

Those rejected by people trying to control Parliament: PM Modi

New Delhi, Nov.25: Prime Minister Narendra Modi on Monday slammed the opposition, saying those who were rejected by people 80-90 times were trying to control



their own political gains. Addressing reporters ahead of the start of the Winter Session of Parliament, Modi said such handful of people did not succeed in their intentions but people of the country observed their actions and punished them at an appropriate time. Modi's remarks came days after

the BJP-led coalition won the Maharashtra Assembly elections by a landslide, bagging 235 seats and relegating the opposition Maha Vikas Aghadi to a distant 49 seats in the 288member House. Earlier, the BJP registered a

surprise third consecutive victory in the Haryana polls, trouncing the Congress, which was billed as a pre-poll favourite. "There should be a healthy debate in the Parliament but, unfortunately, certain individuals are trying to control Parliament for their own political gains, resorting to disruptions and chaos," Modi said. "Though their tactics ultimately fail, the people watch their behaviour closely and deliver justice when the time comes," he added. Modi said he had been repeatedly urg-

ing opposition colleagues, and some also agreed that Parliament should function smoothly. "But those who have been continuously rejected by the public ignore the words of their colleagues and disrespect their sentiments and that of democracy," the prime min-

SC asks CAQM to consider restarting physical classes in school

New Delhi, Nov. 25: The Supreme Court on Monday asked the Commission for Air Quality Management (CAQM) in the national capital region and adjoining areas to consider restarting physical classes in schools and colleges noting many students lacked mid-day meals and infrastructure to attend online classes. A bench of Justices Abhay S Oka and Augustine George Masih said a large number of students did not have air purifiers at home and therefore there may not be a difference between children at home and those attending schools. The top court, however, refused to relax the anti-pollution GRAP-4 restrictions in Delhi-NCR and said unless it was satisfied that



there was consistent decrease in AQI levels, it cannot order curbs below GRAP-3 or GRAP-2. Noting that several sections of society, especially labourers and daily wagers, were adversely affected due to GRAP-4, the bench directed the state governments, where construction has been banned, to use funds collected as labour cess for subsistence to them. GRAP-4 restrictions specifically relate to restricting entry of trucks carrying non-essential goods into the national capital.First implemented in 2017, the Graded Response Action Plan (GRAP) was a set of anti-air pollution measures followed in the capital and its vicinity according to the severity of the situation.

Jailed MP Engineer Rashid moves court,

seeks interim bail to attend Parliament New Delhi, Nov 25: Jammu and Kashmir MP Engineer Rashid on Monday moved a Delhi court, seeking interim bail in a terror-funding case to attend the Parliament session. After Rashid urged Principal District and Sessions Judge Vimal Kumar Yadav to grant him the reprieve, the court asked the National Investigation Agency (NIA) to file a response by November 27. Engineer Rashid, appearing virtually in court from Tihar Jail, said, "I have been elected by my people. I was not allowed to attend the last session. With folded hands, I request that I may be granted interim bail.'

Hyderabad, Nov 25: Telangana Chief Minister A Revanth Reddy on Monday said the state government will not accept the Rs 100 crore donation announced by Adani Group chairman Gautam Adani for the Young India Skill University being set up in the state. The decision was taken since Adani's announcement gave rise to "unnecessary discussions" that it may appear favouring the state government or the CM, if the donation was accepted, he said while addressing a press conference. He said so far the Telangana government has not accepted a single rupee into its account from any organisation, including Adani Group. "I and my Cabinet colleagues do not want to be involved in unnecessary discussions and situations that would dent the image of the state government or my own. That is why, on behalf of the state government, our official Jayesh Ranjan wrote a letter (to Adanis)". "Due to the (present) situation and controversies, the Telangana government is not ready to accept the Rs 100 crore donation you (Adani) generously offered," Reddy said. He said the letter clearly requested the Adani Foundation not to transfer Rs 100 crore to the university. Sambhal violence toll rises to four; prohibitory orders issued, outsiders' entry barred till Nov 30

Lucknow, Nov.25: The toll in the clashes between police and protesters opposing a court-ordered survey of a Mughal-era mosque here rose to four following the death of one more injured person, officials said on Monday. The district administration has already imposed prohibitory orders and barred the entry of outsiders till November 30. Deputy Inspector General of Police (Moradabad) Muniraj said one person injured in the violence died during treatment. District Magistrate Rajender Pensiya said late on Sunday that the prohibitory order had been issued under provisions of the Bharatiya Nyaya Sanhita (BNS). "No outsiders, other social organisations or public representatives will enter the district border without the permission of the competent officer," said the order, which came into force with immediate effect. Violation of the order will be punishable under Section 223 (disobedience to now, we are engaged in maintaining peace order duly promulgated by public servant)

two women, have been detained and a probe has been launched, the official had said, adding that those accused in the violence would be booked under the stringent National Security Act (NSA). District Magistrate Pensiya had said, "The casualty count stands at three. The reason for the deaths of two is clear – bullet wounds from countrymade pistols. The reason for the death of the third person is not clear but it will be after post-mortem." Internet services were soon suspended in Sambhal tehsil for 24 hours and the district administration declared a holiday in all schools for Monday. Tension had been brewing in Sambhal since November 19 when the Jama Masjid was first surveyed on the court's orders following a petition claiming that a Harihar temple had stood at the site. On Sunday, trouble started early when a large group of people gathered near the mosque and started shouting slogans as the survey team began its work.

Inquiry launched after staff lock classroom with student inside for three hours at Chekkarapatti school in TN



DHARMAPURI: The school education department has launched an inquiry into the incident where a Class 2 student of Chekkarapatti panchayat union middle school was locked up for three hours inside the classroom by a staff accidentally on Thursday. Sources said the student had fallen asleep on the bench and the staff did not notice him and locked the room after school hours. As he did not return home even after a long time, the boy's parents went to the school to check on him and found the school locked.

His father contacted school staff who rushed to the school and opened the classroom to find the child unconscious. Parents rescued the child and after first aid, he was taken home. Sources in the School Education Department said, "The parents did not lodge a complaint regarding the incident as it was a inadvertent mistake. Teachers apologised to the parents and residents for the negligence. The department came to know about the incident on Saturday and has sought an explanation.'

Rare burning swing sacrificial monuments found in Karnataka's Koppal

KOPPAL: Two burning swing sacrificial monuments have been found near a lake at Bilagi village in Kushtagi taluk of Koppal district. The burning swing is called "Uri Uyyale" in Kannada. These rare monuments describe the sacrifices made by people around 1,000 years ago. According to historians, such monuments were found earlier in Mandya, Gadag, Dharwad, and Chamarajanagar.

In the past, people used to set themselves afire sitting or standing on a swing (offering themselves to Agnideva, the God of fire) to bless their childless rulers with sons or daughters. Some used to perform this ritual to attain moksha, according to inscriptions on the monuments. However, these are considered as sacrificial monuments. These rituals were performed in the temples of goddesses. People even performed these rituals for the victory of their kings in wars, according to historians.

TDB, Kerala government to identify land for recycling floral waste generated at hill shrine

THIRUVANANTHAPURAM: In a move to address environmental concerns posed by the large quantity of floral waste generated daily at Sabarimala temple, the state government and the Travancore Devaswom Board (TDB) is set to launch a first-of-its-kind initiative to convert the floral rejects into value added projects like agarbattis/incense stick. A Kanpur-based company has come forward expressing interest in giving eco-friendly solutions to address the floral waste menace. A meeting



stakeholders has decided to go ahead with the project. Suchitwa Mission executive director U V Jose told TNIE that the project would be implemented immediately. "The Devaswom Board authorities have been asked to provide the land for setting up the recycling unit," said

chaired by the Chief Secretary with the However, finding land in the Sannidhanam or Nilackal for setting up the recycling unit is impossible because the area comes under an ecologically fragile area. "There are hurdles while allocating land for any construction activities as it is a forest area and there are restrictions. There is no private land and all available land belongs to the forest department or the Devaswom

Board. But there are no restrictions for setting up temporary structures. Hence, we are exploring possibilities to set up the recycling unit on a temporary basis for a year," said an official source.

The Sabarimala temple has been witnessing an influx of tourists and the enormous quantity of floral offerings left by pilgrims each day has been a challenge. Currently, the floral rejects are being buried in the locality. Jose said the government is very particular about implementing the project without any delays.

There is an industrial estate in Pathanamthitta and we have asked the industries department to provide land there. We will get a response on Monday after their board meeting," said Jose. The initiative is expected to create employment opportunities also.

The agency is ready to roll out the project immediately after getting the land. They will submit a proposal soon and the scope of employment will be discussed afterwards," added Jose.

Tamil Nadu government tells all schools to observe awareness week on child abuse

CHENNAI: The School Education Department has directed schools across the state to observe awareness week against child abuse from November 25 to 29. This comes after had reported that initiatives mandated by a 2021 government order, including the formation of safety committees and awareness programmes, largely remain only on paper in many schools. As part of the awareness week, house heads will explain the Manavar Manasu scheme during the morning assembly. Under the scheme, complaint boxes have been placed in government schools for students to submit grievances anonymously. Schools have also been directed to ensure the Student Safeguarding Advisory Committee is functional. The

committee comprises headmaster, two

teachers, two PTA members or parents, a

school management committee member,

a non-teaching staff member, and



optionally, a member from outside the school. This committee must conduct a one-day awareness programme for parents on November 28 or 29 and compliance reports must be submitted to the chief educational officer. Grievances received in the complaint boxes should

also be addressed during these meetings. In cases of sexual abuse complaints received through the complaint box, the committee must immediately contact the helpline numbers 14417 or 1098.

The department has asked CEOs to submit reports with details on the number of schools that conducted committee meetings and action taken on complaint box grievances. Furthermore, all high and higher secondary headmasters in government and private schools in Chennai have to attend a legal awareness seminar on Pocso Act on November 26.However, activists said that the department should come up with a comprehensive school safety plan. "The department has to engage with child rights activists with the help of the social welfare department instead of conducting one-time events. Only this would help prevent abuse of children in government and private schools," said a child rights activist.

RTI reveals Polavaram height set by Andhra Pradesh govt in 2021 amid blame game

VIJAYAWADA: At a time when both the TDP and YSRCP are blaming each other responsible for the reduction in height of the Polavaram Irrigation Project, the Polavaram Project Authority (PPA) has made it clear that the Phase-1 concept emerged from the State government's proposal, and the Centre approved it at a review meeting held on April 10, 2023 that the focus should be on achieving benefits at the specific water level of +41.15 metres.

In reply to a query posed by RTI activist Inaganti Ravi Kumar of Bapatla, the PPA informed that the Andhra Pradesh government in its sixth meeting of Monitoring Committee for strengthening the process mechanism for Rehabilitation and Resettlement (R&R) of the Polavaram Irrigation Project (PIP) oustees held on July 29, 2021 mentioned that R&R works and shifting of Project Displaced Families (PDFs) would be taken up as per contour levels i.e up to +41.15 metres and +45.72 metres respectively, and focused to complete the R&R works up to +41.15

Woman (48)loses Rs 34 lakhafter 24-hour'digital arrest'

Noida: A 48-year-old woman was defrauded of Rs 34 lakh in Noida after being put under 'digital arrest' for 24 hours on Aug 8. However, Rs 10 lakh was recovered and returned to the Sector 41 resident, who is a project manager at an IT company. Police said the woman has refused to be identified."The caller introduced himself as an officer from the narcotics department. On the pretext of investigation, her call was transferred to another number, citing that the Mumbai Crime Branch will investigate the case," Cybercrime Branch station house officer Vijay Gautam said.

The SHO said, "Later, the fraudsters connected with the victim through Skype and threatened her to cooperate or end up in jail. On the pretext of an investigation, the suspect gathered all financial details of the victim and forced her to take an instant pre-approved loan of Rs 20 lakh."Later, the woman was directed to approach a bank and transfer Rs 20 lakh plus savings of Rs 14 lakh to a bank account provided by them. "As the money was transferred, the fraudsters disconnected all contact with her after she realised that she fell into a trap,' police said, adding that a case under sections 308(2) (extortion), 319(2) (cheating by personation), and 318(4) (cheating) of the BNS was registered at Cyber Crime Branch police station on Saturday and nearly Rs 10 lakh was recovered. Police said the victim alleged that on Aug 8 around 10 am, she received a call from an unidentified number about "a parcel containing illegal items having been returned to a parcel office in Mumbai"."When I mentioned that I sent no parcel, I was told that a parcel was sent from Mumbai to Iran and it contained five expired passports, two debit cards, two laptops, 900, 200 gm MDMA and that it had my Aadhaar Card copy as an ID proof," the FIR said.

Schools to remain closed, will hold online classes

Gurgaon: The district administration on Sunday extended its order to suspend all in-person classes in schools till Nov 25, Monday, because of little improvement in air quality in the region. The order, applicable for all private and govt run schools in the city, follows a notice from the directorate of secondary education, which asked deputy commissioners and district magistrates to take a call on reopening schools based on air quality index (AQI). The city recorded two 'severe' air days this month, and forecasts say pollution is here to stay till weather conditions improve.

"As the Air Quality Index (AQI) levels in almost all urban and rural parts of district Gurgaon is in severe category, therefore, in the interest of the health and safety of the children, it has been decided that in continuation of order no. 5483-86 dated 18.11.2024 of this office, all physical classes for students up to Class 12th will remain discontinued till 25.11.2024 in all areas (urban as well as rural) of district Gurgaon. Online classes will be conducted in lieu of physical classes..." the order by Ajay Kumar, deputy commissioner of Gurgaon, read. The previous order to discontinue physical classes was issued on Nov 18 and was applicable till Nov 23. Noida, too, has extended closure of schools till Monday. On Sunday, parents said they endorsed the district administration's decision to stop physical classes.

As residents of Gurgaon grapple with the smog and its health implications, the administration's swift actions underscore the pressing need for long-term solutions combat air pollution and ensure a healthier future for the community," said Palak Verma, a resident of Sector 90, whose 9-year-old son is a student at Saint

Daughter of Prem Mandir's founder dies in eway crash

Noida: The 75-year-old daughter of Jagadguru Shri Kripalu Maharaj — the founder of Prem Mandir in Vrindavan — died and seven others, including two of her sisters, were injured when a truck crashed into their Toyota Camry and Innova Hycross on the Yamuna Expressway early on Sunday. The accident occurred near '8km Mark' of Dankaur around 4am. The truck driver fled the scene, leaving the vehicle behind.Police said Vishakha Tripathi and the others were travelling from Mathura to her Dwarka home in Delhi when the truck crashed into their vehicles from behind. Those injured were her sisters — Krishana Tripathi (67) and Shyama Tripathi (69) — their driver Sanjay Malik (57) from Pratapgarh; and acquaintances Hansha Patel (56), Kashmira Patel (53), and Januka Khadka (40), all residents of Matura; and Deepak Patel (35) from Delhi. Arvind Kumar, ACP (Greater Noida-3), said a passerby called to inform police about the accident. A team reached the accident spot from Dankaur police station in a while and brought the occupants out of the mangled cars. All the passengers were taken to a nearby private hospital, where Vishakha succumbed to injuries during treatment and the others were admitted to the ICU.

As their condition deteriorated, the injured passengers were transferred to a private hospital in New Delhi. Till late on Sunday evening, police were yet to record their statements as they were still in the ICU. Consequently, there was no police complaint either.

Police are trying to find out if reduced visibility because of fog caused the accident. There is speculation that the driver of the truck may have fallen asleep at the wheel. The stretch of the expressway where the accident occurred is not covered by CCTV cameras."We haven't received any complaint yet, but have launched a comprehensive investigation to determine the cause of the accident. Preliminary probe suggests the truck driver may have fallen asleep. Three teams have been formed to apprehend him. We are analysing CCTV footage from nearby locations," ACP Kumar said.A spiritual leader, the Late Jagadguru founded the Prem Mandir in Vrindavan in Feb 2012. According to Jagadguru Kripalu Parishat (JKP) website, Vishakha, Krishana, and Shyama were its presidents.

Air foul as ever, but Noida spent only 11% of NCAP funds in 3 years

Noida: When deteriorating air quality levels have been raising health concerns, Noida Authority has been found to have utilised merely 11% of funds allotted for three years under National Clean Air Programme (NCAP) to fight pollution. The Central Pollution Control Board (CPCB) has responded to an RTI query, saying while the Authority received Rs 30.9 crore for the period between 2020-21 and 2023-24, it spent only Rs 3.4 crore during 2023-24 and 2024-25. Since the Authority failed to utilise NCAP funds over the past few years, no fresh allocation was made by the govt in the current session.CPCB data shows the Authority received disbursements of Rs 6.7 crore, Rs 15.3 crore, and Rs 8.9 crore during the financial years 2021-22, 2022-23, and 2023-24, respectively. However, the Authority's expenditure remained notably low — with only Rs 1.4 crore and Rs 2 crore spent in 2023-24 and 2024-25. According to the RTI response, the Authority used the funds to primarily

procure anti-smog guns, water sprinklers,



and machines for mechanised sweeping of roads. Amit Gupta, the Noida resident who filed the RTI query, expressed concern about the poor utilisation of funds and the use of machines that were bought with them.

"Noida Authority says it has invested Rs

3.4 crore in procuring sprinklers, antismog guns and mechanical sweepers. But outdated tankers continue to operate on roads, dispensing water using conventional methods. Despite raising this issue at meetings in the presence of the district magistrate, we haven't seen

raises serious concerns about the actual utilisation of funds," he said.Gupta also pointed out that the Authority's horticulture division had terminated dust-free maintenance agreements in many 7X sectors. "I raised this concern before the district pollution committee. Even the DM suggested developing a comprehensive strategy," he added.

Of 19 cities that were allocated NCAP funds, Noida is at the bottom of the list in terms of utilisation. Delhi, too, is among the bottom five, with 68% of its allocated Rs 42.7 crore lying unused.Ghaziabad, in contrast, has used 80% of its allocated funds, setting a better example among neighbouring cities. Asked about the dismal use of funds, SP Singh, the Noida Authority GM, said, "Some machines were included in the previous bid cycle, but they were yet to be awarded. We have submitted them again for bidding and hope for a higher likelihood of allocation this time. We expect to use up all the funds we have by March next year."

AQI a worry, discom pauses work on power infra upgrade

Noida: The discom has temporarily stopped power infrastructure development projects because of plummeting pollution levels in the NCR region. Meanwhile, the power department will provide consumers with partial payment and load enhancement facilities through the Nivesh Mitra portal. Harish Bansal, chief engineer of the Noida power department, PVVNL, said, "We were working on strengthening the power infrastructure on a large scale in the district under various business plans. For this, along with increasing the capacity of power lines, the capacity of power substations is also being enhanced. Additionally, transformers are being installed to reduce the load of

overloaded transformers. For this, we systematically took planned shutdowns in different areas. This was stopped temporarily. We will resume the work as soon as the pollution levels improve," he said.Meanwhile, the Uttar Pradesh Power Corporation Limited (UPPCL) offers a partial payment facility to consumers to avoid disconnections. Under this, a minimum limit of 10% of the outstanding amount or Rs 25,000, whichever is higher, is provided to lifeline in-service consumers. For other categories of service consumers, the facility is available with a minimum limit of 25% of the outstanding amount or Rs 1,000, whichever is higher.For temporarily disconnected connections,

the facility of partial payment is available with a minimum limit of 25% making a partial payment, there is a provision to mention both the bill amount and the amount of payment made on the payment receipt."To avoid disconnection of electricity, please pay your bills on time," said Pankaj Kumar, managing director of UPPCL.Further, the facility to enhance load capacity is also extended to the consumer through the Nivesh Mitra portal. For a permanent connection, the discom recommends application through the Nivesh Mitra portal, with load enhancement up to 20 kW, which can be automatically increased by going to

Accident waiting to happen? Culvert damaged by showers poses risk here

Ghaziabad: The soil around the drainage system between New Arya Nagar and Meerut road was damaged earlier because of the rain. The erosion has left the culvert's slab exposed and unsupported. This deterioration has weakened the culvert's foundation, making it unstable and susceptible to failure.

Several commuters drive through this slab everyday, if this slab gets broken any day, there will be a major accident. After the last rainfall, many of us have been com - plaining to the concerned authorities to do something about it but there has been no response as of now" said Sheetal Mahajan, a resident of the area.Residents living in the sec - tor said the problem has been persisting for several months now. They also added that several buses and big vehicles pass through the stretch, making it even more riskier. "The continuous flow of traffic across this slab has been causing deterioration daily. Locals and residents of this sector are aware of this problem and



inadequate street lighting in this area further adds to the problem, making it challenging for anyone to notice the hazard," said Sugam Mehta, another resident. Numerous culverts across the district have been left in similar

Carpentry, steel binding allowed under GRAP: UPPCB

of the total outstanding amount. While Noida: The state pollution control board has clarified that construction activities that are less polluting, such as steel binding and carpentry, are permitted under GRAP stages 3 and 4, provided strict dust control measures are followed. The clarification came in response to a complaint by CREDAI about enforcement officers in the city misinterpreting CAQM guidelines and imposing a blanket ban on all construction activities. The pollution board reiterated that only specific dustgenerating tasks, such as excavation and demolition, are prohibited under GRAP. In a letter dated Nov 22, CREDAI NCR secretary Gaurav Gupta highlighted that local enforcement officials were imposing a blanket ban on all construction and demolition (C&D) activities, contrary to CAQM's directives. CREDAI argued that less polluting tasks such as steel binding, shuttering, and carpentry work are explicitly allowed under CAQM guidelines, provided they adhere to dust prevention norms. The association claimed that the misinterpretation was causing significant delays in construction projects, distressing thousands of workers, and impacting homebuyers. CREDAI referenced CAQM orders issued on Sept 17, Nov 14, and Nov 17, which outline actions

under GRAP. The guidelines ban specific dustgenerating activities such as excavation, piling, and road construction but explicitly permit less polluting tasks under strict compliance with the Construction and Demolition (C&D) Waste Management Rules."This misinterpretation has led to undue stoppage of work, causing distress to thousands of construction workers in the NCR region and delays in critical projects, thereby causing irreparable losses and damages to homebuyers," Gupta wrote, urging the UPPCB to issue clear instructions to enforcement teams.

Utsav Sharma, UPPCB regional officer, reiterated that GRAP guidelines do not impose a blanket ban on all construction and demolition activities at any stage. During Stages 3 and 4, specific guidelines apply to construction sites to mitigate dust pollution."During Stage 4 of GRAP, all activities prohibited under Stage 3 shall continue to be prohibited. Besides this, as in the case of Stage 3, relatively less polluting/less dust-generating activities are permitted during this period as well, subject to strict compliance with C&D Waste Management Rules and directions," Sharma wrote.UPPCB urged all construction sites in Noida and Greater Noida to adopt specific measures to minimise dust pollution and comply with environmental guidelines. These measures include using water sprinklers, dust suppressants, and anti-smog guns to control airborne particles.Nikhil Hawelia, joint secretary of

Indonesia Flash Floods: 13 Killed, 18 Injured As Landslides Hit North Sumatra

JAKARTA. Landslides and flash floods that hit two regencies in Indonesia's North Sumatra province last week have claimed 13 lives with 18 others injured, said an official from the provincial disaster management and mitigation agency. According to Sri Wahyuni Pancasilawati, head of the emergency, equipment, and logistics unit of the agency on Sunday, the landslides and flash floods struck on Saturday night in Deli Serdang and Karo regencies,



Xinhua news agency reported.In Deli Serdang, six people were killed, and nine others sustained injuries after strong currents swept away four houses and a religious building. In Karo regency, a similar disaster left seven people dead and nine injured. The injured were taken to nearby hospitals and health clinics for treatment, she told Xinhua.

On early Saturday morning, landslides and flash floods had also stricken Padang Lawas and South Tapanuli regencies in the province, leaving six dead and seven injured. The Indonesian Meteorology and Geophysics Agency had issued warnings of extreme weather, forecasting above-normal rainfall intensity in the region. Efforts are underway to assist affected communities and mitigate further risks as authorities continue to monitor the situation closely.

Russian Plane Engine Catches Fire In Turkey, All 95 Passengers Evacuated

Istanbul. The engine of a Russian-made passenger plane caught fire after landing at southern Turkey's Antalya Airport on Sunday, the Turkish transport ministry said in a statement.

The ministry said landings at the airport were suspended until 0300 local time (0000 GMT) while authorities towed the plane from the runway. All 89 passengers and six crew were safely evacuated from the Sukhoi Superjet 100 passenger plane that had come from the Russian Black Sea resort of Sochi, the ministry said. A video shared on social media by Airport Haber news website showed emergency units responding at the site of the fire, with flames and smoke coming out of the aircraft's engine. Videos shared by the transport ministry following the incident showed the aircraft with fire extinguishing foam underneath as firefighters continued to spray the left-side engine to cool it down. According to the Antalya Airport website, an Azimuth Airlines plane from Sochi landed at 1825

Petition Calling For Fresh General Election In Britain Crosses 1.7 Million Signatures

WORLD.A petition calling for fresh general election in the UK has reached over 1.7 million signatures as the Labour government faces widespread disapproval regarding its policies and post-poll work. Even Tesla boss Elon Musk chimed in on the issue by reposting a message about the success of the petition. According to the guidelines, any petition that asks for a change to the law or to policies gets a response from the government after 10,000 signatures. After 100,000 signatures, petitions are considered for debate in the parliament."I would like there to be another General Election. I believe the current Labour Government have gone back on the promises they laid out in the lead up to the last election," the petition description

As of the last update, the petition had raked up 1,771,423 signatures and counting. The petition was started by Michael Westwood who runs Britain's 'cheapest pub'. He said he did not imagine in his wildest dreams that Mr Musk would quote post his petition."The General Election petition has now DESTROYED the 200k target within 6 hours-just after midnight in Britain. The British people are about to completely humiliate the Labour Party," read the post shared by Mr Musk.

Meanwhile, Mr Westwood, the owner of the Wagon and Horses pub where pints are sold for \$2.90, said the Labour government's actions looked "nothing like what was promised" in the manifesto."I think people have had enough, people have seen what's happened over in America as well, and I think that's had a knock-on effect that, actually, if people stand together and vote then we can make a change," Mr Westwood

Dwindling popularity

According to an Ipsos poll, the Labour government has seen its fortunes dwindle rapidly after the general elections earlier this year with Prime Minister Sir Keir Starmer's popularity taking a nosedive as well. Almost half (49 per cent) of the public views the Labour Party unfavourably which trails three points behind the Conservative Party. Meanwhile, two in five Britons think they are worse off since Labour came to power.

A significant majority (56 per cent) believes that Britain was heading in the wrong direction, compared to just 19 per cent who feel things are on the right track -suggesting there was widespread public pessimism.

Imran Khan Supporters Clash With Cops, Face Tear Gas On Way To Islamabad

A large convoy of Pakistan Tehreek-e-Insaf (PTI) supporters, led by Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur and opposition leader Omar Ayub, encountered heavy resistance from law enforcement as it made its way from Swabi to Islamabad via Punjab. The convoys encountered intense tear gas shelling near the Attock Bridge, Chach Interchange, and Ghazi Barotha Canal as police attempted to disperse the PTI supporters marching towards the capital, The Express Tribune reported.Starting from Swabi, the PTI convoys were initially met with calm progress as they entered Punjab territory. However, police deployed heavy tear gas near key checkpoints to

law enforcement aimed to halt the convoys, forcing the PTI supporters to face resistance before they could continue their journey. In his address to the crowd, Gandapur emphasised that the march would not stop until Imran Khan, the PTI founder, was released. "We must advance and not turn back until Imran Khan is released," he declared, rallying the supporters to press on despite the delays caused by police intervention. Later, addressing the group again at Ghazi, he urged them to prepare for further resistance."Prepare, as we will need to confront further resistance ahead," Gandapur said, reinforcing the commitment to the cause. The convoy, temporarily halted at Ghazi Bridge, faced mixed reactions from party members, as Chief Minister Gandapur advised them to rest before further confrontations. Bushra Bibi, the wife of Imran Khan, expressed frustration at the delays, urging the convoy

to move forward without further pause.

Despite the government's efforts, which include sealing key roads and setting up barriers around Islamabad, PTI leadership has remained firm in its stance. Gandapur declared, "We will bring our private machinery to remove obstacles and reach Islamabad," emphasising that nothing would deter their efforts to stage the protest at D-Chowk.

China balloon spotted near Taiwan amid rising tensions before presidential polls

WORLD. Taiwan's defence ministry on Monday reported that a Chinese balloon had been detected over the sea to Taiwan's north, the first time since April it has reported such an incident in what Taipei views as part of a pattern of harassment by Beijing. Taiwan, which China claims as its own territory, complained that in the weeks leading up to its presidential election in January, Chinese

balloon activity took place at an "unprecedented scale".It described the incidents as part of a Chinese pressure campaign - so-called grey-zone warfare designed to exhaust a foe using irregular tactics without open combat. Taiwan strongly objects to



China's sovereignty claims and says only the island's people can decide their future. The ministry, in its regular morning update on Chinese military activities over the previous 24 hours, said the single balloon was detected at 6:21 p.m. (1021 GMT) on Sunday 60

Taiwan's Keelung port.It then vanished some two hours later, having flown at an altitude of 33,000 ft (10,000 metres), but without crossing Taiwan itself, the ministry said. China's defence ministry did not respond to a request for comment.China has previously dismissed Taiwan's complaints about the balloons, saying they were for

meteorological purposes and should not be hyped up for political reasons. The potential for China to use balloons for spying became a global issue last year when the United States shot down what it said was a Chinese

surveillance balloon. China said the Israel, Hezbollah 'very close' to ceasefire deal, as Lebanese death toll surges

In a statement to CNN, Israel Prime Minister Benjamin Netanyahu's spokesperson "We are moving in this direction, but there are still some issues to address."

According to the draft agreement, a 60 day transition period has been sought during which the Israeli military will have to recede the ground in southern Lebanon, the Lebanese military will be deployed in border areas and artilleries to north of the Litani River.The reports added that a US led oversight committee will be tasked to get the deal implemented and address the violations, if any.

Donald Trump Planning To Remove Transgenders From US Military

WORLD.US President-elect Donald Trump has added to the growing fears of the LGBTQIA+ community in the US as he is reportedly planning an executive order that would lead to the removal of all transgender members from the US military. According to officials, the transgenders would be medically discharged, which means they would be "unfit" to serve, The Sunday Times reported. The 78-year-old leader had imposed a similar order during his first term as the US President - he had prevented transgender people from joining the armed forces but allowed those who were already serving their jobs. However, according to the report, this time, all those transgenders who are currently serving would also be removed. The executive order would reportedly come on his first day back as the President on January 20, next year.

There are reportedly around 15,000 transgenders actively serving in the US military presently. When President Joe Biden had lifted Trump's ban on transgenders in the military, around 2,200 service personnel were diagnosed with gender dysphoria, and several other personnel identified as a different gender than what they were born, the report said.

Trump, who has repeatedly dismissed the inclusion of transgenders in the community, has a key vision: To rid America of perceived "wokeness" and "left-wing indoctrination". Since his first term, the US President-elect has said that he would cut money to "any school pushing critical race theory, transgender insanity, and other inappropriate racial, sexual or political content on children". He also wants to keep transgender athletes out of girls' sports and to forbid classroom lessons on gender

be in charge of the US military - also has dismissive views of the transgenders. He has forcefully argued that steps to incorporate women and transgender personnel across the military are eroding the US security, reported The Washington Post. Leftist candidate Yamand Orsi wins close presidential election in Uruguay

WORLD.In a tightly contested runoff election, left-wing opposition candidate Yamandú Orsi emerged victorious on Sunday, defeating the conservative governing coalition and bringing a shift in leadership to the South American nation. With nearly all votes counted, The victory marks another setback for incumbent parties across the globe in a year of transformative elections. Álvaro Delgado, the centre-right ruling coalition's candidate, conceded the race as the vote count neared completion. "With sadness, but without guilt, we can congratulate the winner," Delgado told his supporters in Montevideo, as reported by Associated Press (AP).

Fireworks lit up the capital as Orsi, a 57year-old former history teacher and twotime mayor representing the Broad Front coalition, addressed a jubilant crowd. "The nation of liberty, equality and fraternity has triumphed once more," he said, pledging to unite Uruguay's 3.4 million citizens. Acknowledging the

narrow margin of victory, he added, "There are others in the country who feel differently today. We will need their help to build a better Uruguay."

electoral authorities reported Orsi secured just over 49% of the vote compared to Delgado's 46%, with the remainder casting blank ballots or abstaining. Turnout reached an impressive 90%, as Uruguay enforces compulsory voting. While voter disinterest

among younger citizens remained a challenge, Uruguay's campaign season avoided the populist fervour seen elsewhere, such as in Argentina and the United States. Instead, Orsi's moderate approach resonated after polls suggested a dead heat in the weeks leading up to the election.Outgoing President Luis Lacalle Pou, who was barred from seeking consecutive terms, confirmed the result



on social media: "I called Yamandú Orsi to congratulate him as President-elect of our country," he wrote on platform X, adding that he was ready to facilitate a smooth transition.

Orsi's victory reflects growing public dissatisfaction with post-pandemic economic challenges, a sentiment that has driven anti-incumbent votes globally. Despite this, Orsi's platform is not radical. It echoes the Broad Front's earlier

tenure (2005-2020), blending market-friendly policies with social welfare programmes. Under its previous leadership, Uruguay achieved sustained economic growth and progressive reforms, including legalising abortion, same-sex marriage, and marijuana sales.

José "Pepe" Mujica, a former Marxist guerrilla and ex-President renowned for these reforms, offered support to Orsi despite his advanced age and recent cancer recovery. "This is no small feat," Mujica said after casting his ballot, praising Uruguay's political

stability and respect for institutions. Orsi has pledged targeted reforms, such as tax incentives to attract investment, revitalising agriculture, and modest social security changes to lower the retirement age. These plans fall short of the sweeping union demands rejected in October's general election, where neither

major candidate won outright.

Telangana: Students forced to sleep on floor as hostel is in dilapidated state

HANAMKONDA: Over 38 boys are forced to stay in the dilapidated building of the Government Backward Classes (BC) Welfare Boys Hostel in Nallabelly mandal, Warangal district. The hostel rooms are in a dangerous condition, with parts of the building collapsing, causing fear among students. The rooms lack basic facilities like proper doors, windows and fans. Despite several representations requesting the relocation of the hostel, no action has been taken. The hostel, originally intended to accommodate outstation students, now only has one room and a hall for the students, while four other room are crumbling.

Additionally, two rooms of the four have been locked for two years now. Although the number of students has been increasing each year, the District Backward Classes (BC) Welfare officials have failed to provide adequate infrastructure for them to study.A staff member told TNIE, "We have raised concerns with the department authorities multiple times, asking for a new building or for the hostel to be relocated, but to no avail. The officials inspected the hostel and proposed relocating it, but the situation remains unaddressed. With no fans or beds in the hostel rooms, students are forced to sleep on the floor every day."When contacted Warangal District Backward Classes (BC) Development Officer A Pushpalatha admitted that the hostel building is in a dilapidated condition and stated that a proposal to shift the hostel has been

Pembarthy's artisans in Telangana battle for survival

JANGAON: The brass engraving artisans of Pembarthy village, located about 80 km from Hyderabad, are struggling due to a lack of support and demand for their traditional craft. The lack of governmental initiatives, including training programmes and subsidies, has led many artisans to abandon their ancestral profession for other means of livelihood.Pembarthy has long been renowned for its exquisite brass, copper and silver engraving, with skilled artisans garnering recognition across India. For decades, these artisans, many of whom belong to the Vishwakarma community, have been crafting intricate designs in metal. However, in recent years, the number of artisans has dwindled, with only around 100 families still engaged in the trade

Artisans alleged a lack of support from the government. Earlier, community members appealed to the Congress to give proper recognition to their craft and allocate funds for the establishment of a training centre in the village. Although two acres of land were allocated for the centre by the previous BRS government, the promise remains unfulfilled. The estimated cost of the centre was Rs 5 crore, but no progress has been made toward its construction.K Annapurna, a brass and copper engraving artisan, told TNIE that artisans from Pembarthy, once celebrated for their skill during the Kakatiya and Nizam eras, nave seen their craft dimi formation of Telangana. "We hoped for better support after the state's formation, but instead, we lost the little support we had. A training centre in the village would not only preserve our heritage but also provide opportunities for the younger generation to learn this craft," she said.

Airports authority of India nod for master plan to revamp HAL airport in Bengaluru

BENGALURU: City's HAL airport is all set for a major revamp. A master plan is ready and has been approved by the chairman of the Airports Authority of India (AAI), according to sources. This airport catered to the air traffic needs of the city until 2008, when operations were shifted to Kempegowda International Airport (KIA). Now, an average of 12 small aircraft, including those used by defence forces, VIPs and VVIPs and private firms, use the HAL airport daily. It has a single runway with 30 parking spots and is open 24x7.

A source told TNIE, "HAL's master plan, which will hold good till 2047, aims to cater to 40 lakh passengers per annum. It could handle a maximum of 2,500 passengers during peak hours. "In 2007-08 fiscal, just before it closed for passenger traffic, it handled over 10 lakh flyers.In the plan's Phase-I, the airport area will be extended to 32,000 sqm from 21,885 sqm. "The terminal building will be demolished and a new one constructed. It will have 'Arrivals' at one level and 'Departures' at another level. At present, both are housed together. There will be a multi-level car parking facility (ground plus six floors), where 500 cars can be parked."The two-lane road in front of the terminal will be expanded to a four-lane one, he said."There will be no change in the runway of the airport. It has a length of 3,306 metres and a width of 61 metres. It is among the best runways in the country, dimensionwise," said an airport official. Another source said, "The agreement on exclusivity with Bangalore International Airport Limited, which bars any other airport from operating within 150 km, ends on May 24, 2033. As per the concession agreement signed between HAL and the Centre through the Ministry of Civil Aviation in July 2004, our airport will be opened for civilian operations by May 2033. Bengaluru will have a second airport by then. But due to the explosive growth the city is witnessing, there will always be a demand for another airport. Hence, we are gearing up for the future.

Tamil Nadu, Pondy cops spar over raid at licensed arrack shop

PUDUCHERRY/CUDDALORE:

Conflict of jurisdiction led to a confrontation between Cuddalore and Puducherry police teams on Saturday after the former had raided a licensed arrack shop in Madukarai in Puducherry. The Nellikuppam police from Cuddalore arrested D Natarajan (65) of Panruti at the Pattampakkam-Madukarai Road checkpoint for possessing eight packets of arrack, upon whose information they raided

The Cuddalore police seized 40 litres of arrack stored in packets from the shop -- located near the Tamil Nadu-Puducherry border -- owned by R Sarala and managed by her husband Raja from Andiyarpalayam in Puducherry. The shop operates under a licence issued by the Puducherry Excise Department. As the Cuddalore team attempted to detain the cashier for inquiry, the Madukarai police arrived, objecting to the action, arguing that the former lacked authority to conduct raids in Puducherry without obtaining permission and informing them. As the argument escalated, the Puducherry police blocked the Cuddalore team's vehicle from leaving the spot.DSP M S Ruben Kumar from Cuddalore intervened, explaining the ban on the sale of liquor in packets in



Tamil Nadu and that tracing the source was necessary for enforcement. After discussions, the Cuddalore team handed over the seized arrack packets and the detainee to the Puducherry police, who requested the former to approach the Puducherry Excise Department for further action.

A senior officer from the Puducherry police team said they had not obstructed the actions of their counterparts and only asked them to follow procedure. An official from the

Puducherry Excise Department said, "We have requested a report from the Cuddalore police regarding the seizure. Since selling arrack in packets is banned in Puducherry as well, further action will be taken based on our inquiry."

Sources from the Nellikuppam police confirmed that two separate cases have been registered - one regarding the arrest of Natarajan and another in connection with the sale of arrack in packets at the Puducherry shop.

Long-awaited SCoR proj set to take off


VISAKHAPATNAM: As promised in the Andhra Pradesh Reorganisation Act, 2014, the long-awaited South Coast Railway (SCoR) Zone project, a cherished dream for the people of Andhra Pradesh, is now closer to becoming a reality.Union Railway Minister Ashwini Vaishnaw on Sunday announced the tender notice for constructing the zone's headquarters in Visakhapatnam, signalling a step in fulfilling a major commitment made during the bifurcation of the State. The announcement, made via a post on X, signals progress in the long-delayed railway project.

The tender involves the construction of a multi-storey general manager's office complex, including two basements, a ground floor, and nine additional floors (B2+B1+G+9), along with associated structures. Bidding for the Rs 149 crore project will commence on December 13, 2024, with a pre-bid conference scheduled for December 2, 2024. The last date for bid submission is December 27, 2024, and the construction is expected to be completed within 24 months after commencement of works. Following years of demand and political pressure for the fulfilment of the bifurcation promise, the Centre announced the formation of the SCoR Zone in February 2019, designating Visakhapatnam as its headquarters. However, progress has been slow. Despite the submission of a detailed project report (DPR) in August 2019 under the YSRCP government, the project stagnated due to unresolved land allotment issues and administrative delays. Prime Minister Narendra Modi's visit to Visakhapatnam in

November 2022, though significant, did not address the railway zone, leaving many people in North Coastal Andhra disheartened. In December 2023, Railway Minister Ashwini Vaishnaw, on his visit to Visakhapatnam, clarified that the delay was primarily due to non-allotment of land by the State government. After the formation of the TDP-led NDA government, headed by Chief Minister N Chandrababu Naidu, the required 52.22 acres of land at Mudasarlova has been allotted and cleared for the SCoR Zone project.

TN doctors allege ill-treatment by collectors, to go on stir

CHENNAI: The Tamil Nadu Government Doctors Association (TNGDA) has announced a boycott protest on Monday to draw the chief minister's attention towards the alleged mistreatment of doctors by certain district collectors, directors, and other officials of the health department. In its press release, TNGDA said that, of late, doctors are treated like criminals by Tiruchy, Virudhunagar, Thanjavur, Tiruvarur, Mayiladuthurai, Dharmapuri, and Tirupattur collectors. The directors of the directorates of the health department are also ill-treating the doctors. The most recent incident was during the review meeting with deans by the National Health Mission (Tamil Nadu)



mission director (MD-NHM). The doctors alleged that at the recent review meeting with deans and directors, the MD-

NHM said he will hold the head of department and the medical college dean responsible for even one maternal or fever death, and doctors who feel their salary is not sufficient can leave the job. He allegedly also said that doctors should work even if they are attacked at the hospital, else they can leave the job.

The doctors working in PHCs, ESI dispensaries, taluk, district, and medical colleges will boycott all meetings, whether online or in person. They will also exit from all official WhatsApp groups, the association said. All camps including Varumun Kappom will be stopped.TNGDA has also demanded to

fill over 5,000 vacancies and increase the doctors' strength in proportion to the number of patients. The monthly review meeting by collectors should be conducted during working hours. Further, there should not be a ranking system for doctors and hospitals based on medical index, which is done taking into account only a few aspects, they added.

If these demands of the doctors are not met, elective surgeries in obstetricians and gynaecology departments in DME, DMS and DPH, ESI hospitals will be stopped on Tuesday (November 26), the association said. The next course of action will be decided in the TNGDA state emergency committee meeting. Since MD-NHM has instructed to admit all one-day fever cases, TNGDA requested heads of the institutions to increase the number of beds.

Digital addiction claimed 19 children's lives in three years in Kerala resulting in cyber fraud," Ajeetha says.

THIRUVANANTHAPURAM: On November 17, a 15-year-old boy was found hanging at his house in Thiruvananthapuram city limits. On September 10, a 11-year-old boy was found dead in a similar fashion at his residence in rural parts of Thiruvananthapuram district. While unconnected, the two incidents have one thing in common: In both, the children allegedly ended their lives after they were reprimanded for continuously using mobile phones.Addiction to digital devices - dubbed digital addiction - has claimed the lives of 19 children in Kerala in the past three years, the state government records have revealed. The statistics prepared by the home department said another 22 children were found habituated to drug abuse and sexual offences after getting hooked to digital platforms during this period. Sources in the police said only a fraction of such cases come to the fore and the real



number of victims of digital addiction would be much higher.

Thiruvananthapuram Range DIG S Ajeetha Begum, who heads the social policing directorate that runs the digital de-addiction programme for children, says digital addiction results in exploitation of children as well."The children are targeted by adults for grooming even via certain gaming platforms. In certain instances, the predators, who befriend the children in digital spaces, lure them into sharing the bank account credentials of their parents, The DIG says the 'Chiri' helpline, launched to address mental distress among kids, has been getting thousands of calls each month."There are multiple reasons behind the stress. And digital addiction is a major one. We are taking concrete measures to address digital addiction.

However, the main solution lies at home and that is to maintain good communication with children and keep them engaged in other creative activities," Ajeetha says.Senior psychiatrist Dr C J John says digital addiction among children is growing as a silent epidemic, and parents remain largely unaware of this."The parents too are not role models as they themselves are addicted to gadgets. Digital addiction is as dangerous as substance abuse. The children are not indulging in multifaceted activities and rather get confined to the digital world," Dr John says.

Police yet to complete Cusat stampede probe; awaiting PWD report, says Kochi ACP

KOCHI: Even a year after the stampede, the police are yet to complete the investigation and file a chargesheet. Police say they are awaiting a report from the public works department (PWD), which carried out a structural study of the amphitheatre, and a report of the magisterial enquiry ordered by the district collector. The district administration and the Cusat management too had announced inquiries into the incident. A police officer who was part of the investigation team said they have probed all aspects of the stampede.

'Our probe revealed that the stampede occurred due to poor event organisation and the amphitheatre's structural issues. The students were given the charge of managing a crowd of around 3,000 persons. Only one entry point was used for such a large crowd. Also, the path from the entrance had steep descending steps. In their hurry, several

TTD digital makeover for hassle-free darshan

TIRUMALA: Tirumala Tirumala Tirupati Devasthanams (TTD) is undergoing a significant digital transformation, aimed at streamlining operations and providing hassle-free services to visitors.TTD Executive Officer J Shyamala Rao confirmed that the administration is integrating AI and custom-developed software into various departments, including IT, accounts, diary administration, and traffic management at key locations such as Alipiri and Garuda toll gates.

A key development in this digital facelift is the installation of a donation kiosk at the Annadhanam canteen complex. This kiosk allows devotees to make donations ranging from Rs 1 to Rs 99,999, with Rs 2 lakh raised within a week of installation. The majority of donations were smaller denominations such as Rs 10, Rs 51, and Rs 101, while the highest recorded donation was Rs 1,116.The digital initiative will see the deployment of similar kiosks across Tirumala, reducing reliance on manual operations.



These kiosks will provide information on temple programmes, queue lines, darshan timings, laddu purchases, tonsure and donation services, as well as details on transportation, cab services, and RO water availability. Devotees will also be able to book darshan tickets, reserve accommodation, and plan their pilgrimage through these kiosks. For example, pilgrims can purchase up to 25 laddus, based on availability, and collect them from designated counters upon receipt.

Life is uncertain, and you can never be sure what problem or pitfall you may have to face in the immediate or near future and this future is actually unpredictable. But insecurity should not grip us, leading to disruption of mental peace and pesky worry or tension. It will then play havoc with our personality and mar our productivity. Balancing the interests of State & Justice seekers

EDITORIAL

In some contexts, the court under CJI Chandrachud's leadership fell short of expectations. There is no point in creating physical spaces and amenities without upholding the essence of justice.

The soul of justice cannot be enclosed in worldclass brick and mortar structures just as the cause of liberty is not served by sermons in structured judgements. The constitutional protection to the right of privacy is not ensured by declaring it as a fundamental right but by holding 'unconstitutional' intrusive acts of the state through its enforcement agents. Upholding constitutional values is in the nature of a sacrament; any willful infraction or apparent insouciance in protecting those values makes the justice delivery system suspect in the eyes of the public. Over a billion people in our country are watching how our courts attempt to balance the interests of the state with the

interests of those seeking justice. For a polity as divisive as one prevailing since 2014, the constant vigil of the court is the only way to ensure our constitutional values are safe. Chief Justice D Y Chandrachud's tenure was high on optics and somewhat low on delivery. The court under his which he was ostensibly a champion. His majoritarian tilt, reflected in some of his judgements, was worrisome. At the heart of the justice delivery system is the ability of the court to stand up to the excesses of the executive; to speak truth to power. The court's record in that endeavour has been rather weak. Despite this, Chief Justice Chandrachud, who became a judge of the Supreme Court on May 13, 2016, has many landmarks to his credit. The frenetic energy he demonstrated over the years, especially during his tenure as the CJI since November 2022, in creating inclusive infrastructural facilities for the court and lawyers has won him accolades. Sensing the inadequacy of the existing infrastructure, he single-handedly facilitated the proposed construction of a new building within the Supreme Court premises, which will have world-class facilities both in terms of court rooms as well as space for practising lawyers and litigants seeking justice. He endeared himself to members of the Bar, in particular the younger members, by his exemplary conduct in court and the patience he demonstrated when hearing matters. His initiatives were transformational in many respects. For example, moving away from physical filing to digital record-keeping has transformed access to



justice, live-streaming of court proceedings in constitutional matters has brought it closer to people, and simultaneous translation of court proceedings has allowed for accuracy and contemporaneous recording, which facilitates lawyers to make their submissions with greater

stewardship often compromised even on liberty, of The cafeteria facilities for lawyers, modernisation of Oppressive statutory provisions relating to bail being facilities for the Bar, conceptualising a new building for resolution of disputes through arbitration are certainly initiatives for which he will be fondly remembered. The chief justice wondered about his own legacy. But what he should have wondered more about is the legacy of the court he left behind. In this context, the court under his leadership fell short of expectations.Part of the problem is the diktat of the Master of the Roster in assigning cases that concern our fundamental freedoms, the future not only of the polity but of the nation as well. Each one of us at the Bar is aware of the likely outcome of a case when assigned to a particular judge. Eyebrows were raised when certain cases dealing with fundamental freedoms were assigned to particular benches. That is one area where, I believe, the court requires to evolve a procedure that does not evoke suspicion or controversy. While the then chief justice must be given credit for deciding longpending constitutional matters, one felt that matters of political significance requiring urgent attention were not listed. The Shiv Sena matter was pending for over a year, giving legitimacy to a government that was constitutionally suspect. Eknath Shinde, Ajit Pawar and their lot should, I believe, have been disqualified long ago. The future of our democracy

depends on the quick disposal of such matters. Had those matters been heard, the outcome of Saturday's election results in Maharashtra would have been entirely different.

Despite the fact that the PMLA judgement was under review, the matter has been kept pending for years. The Enforcement Directorate has been merrily misusing its powers by continuing to destabilise many opposition-ruled state governments. Had the law been settled in time, the future of the polity of our nation might well have been different. Amendments to existing laws were carried out by including them in the Finance Bill, thereby terming them as 'money bills'. That matter too has not been heard for

years. Not deciding matters relating to the polity of our country indirectly benefited the government in power. That indeed is a matter of great concern. We have also seen, on many past occasions, that matters relating to defection were not heard for years till the term of the assembly was over.

upheld by court required to be revisited. That too did not happen. Rampant bulldozer justice, including open threats to the minorities, did not evoke a suo motu proceeding, nor did the open threat of violence by those at the forefront of the dharma sansads. The court, I believe, is an institution that can set right the course if events in the polity go astray. The real challenge India faces relates to the slow but steady diminishing of our syncretic culture. That's what needs protection. The onslaught of majoritarianism, induction of those committed to an ideology into the judicial system, destroys the very fabric of our country. The judge needs to be independent of a political ideology when administering justice.

The induction of such judges and transfer of judges who attempted to stand up to the executive at the same time does not bode well for our judiciary. The CJI who allowed this to happen must take the blame. He was the author of a judgement that held that no further intrusion into religious places of worship was to be allowed. The SC's emphasis on sensitising children and encouraging steps to curb such stereotyping reflects an essential shift in addressing societal issues through education. However, the problem extends beyond classrooms. Social media, rife with unchecked content, demands stronger regulation and accountability from various platforms. Humour must reflect a society that values respect alongside free speech. Creative expression does not necessitate the demeaning of a community. Sensitisation campaigns, digital content filters and penalties for offensive material could pave the way for a more inclusive environment.

I had occasion to revisit the Jatakas recently and was much struck by the ferocity of the Maha Sutasoma Jataka, which is Number 537 in the Pali canon. Why were such stark stories told, I wondered. But the answer was apparent at once. The Jatakas were cautionary tales meant to teach the dreadful consequences of vice and why destructive habits should be shunned. This story goes that the Buddha, in a previous birth as a Bodhisattva, was a prince and sent to study at Taxila university. His best friend there was the prince of Varanasi. The Bodhisattva was the topper and tutored his friend. Eventually, they both went home and became kings. The prince of Varanasi never ate a meal without meat and continued doing so as

king. One day, some dogs got into the royal kitchen and ate up all the meat. The terrified cook didn't know what to do. He rushed to a cemetery, cut off a part of a freshly-buried corpse, and cooked that.

The king found it so delicious that he questioned the cook closely and the cook confessed. But instead of being properly revolted, the depraved king told him to serve human flesh every day. The Jataka says this unnatural desire was because the king had been a goblin in his previous birth who frequently ate human flesh. The cook was ordered to source flesh from the prisoners in the city jail. This went on until the prison was empty. Then the cannibal king told his cook to



drop a bag with one thousand coins in the street and take anyone who picked it up to be cooked. But soon, people learned it was a trap and avoided all unclaimed bags—which sadly reminds us of warnings against terrorist bombs in unclaimed bags today. So, the king told his cook to hide by a road and kill people at random to obtain their flesh. The city fell into utter panic. A crowd of agitated citizens stormed into the palace courtyard and begged their king to find the killer. When he flatly refused to do anything, to their great dismay and puzzlement—was he not their king and protector?—they turned in despair to the senapati, the commander-in-chief of the army. The senapati himself had been waiting impatiently for

royal orders to catch the killer and was on the brink of taking it up with the king. He was shocked by the king's response and being a good man with a strong sense of public duty, he ordered his soldiers to hide throughout the city. They soon discovered and captured the cook. He was beaten up and confessed. When the cook was taken to face the king, the king had nowhere to hide.

Indian Navy's INSV Tarini embarks on second leg of expedition from Australia

▶The Indian Naval Sailing vessel INSV Tarini sailed out from Australia's Fremantle on November 24 for the second leg of the Navika Sagar Parikrama II expedition to Lyttelton in New Zealand.

New Delhi. The Indian Navy's INSV Tarini, which is undertaking a global circumnavigation expedition, Navika Sagar Parikrama 2, sailed out from Australia's Fremantle on November 24 for the second leg of the expedition to New Zealand's Lyttelton. According to the Indian Navy, INSV Tarini sailed out from Fremantle at

8.30 am (Indian time) for the second leg of the Navika Sagar Parikrama 2 expedition and was seen off by an enthusiastic crowd cheering for the safe passage to Lyttelton.

The expedition, with two intrepid women officers, Lieutenant Commanders Dilna K and Roopa A onboard the ship, was flagged off by Chief of the Naval Staff Admiral Dinesh K Tripathi on October 2 from Goa.

The voyage will cover 3,400 nautical miles (6300 kilometres) in approximately 20 days, and it will see the crew experience varied weather conditions, including frontal weather systems and dropping temperatures, the Navy said in a statement.

In Australia's Fremantle, INSV Tarini received a warm welcome by several dignitaries, including the Consul General of India at Perth, the Defence Advisor from Canberra, the Secretary of the Indian Navy Sailing Association (INSA), representatives from the Royal Australian



Navy, and Indian Naval veterans residing in Australia. At Fremantle and Perth, the crew engaged in various impactful activities showcasing the Indian Navy's contribution to promoting gender equality and global maritime cooperation. Fostering cultural and historical connections between the two countries and recognising their achievements, the crew were honoured as special invitees at the Western Australia Parliament where they interacted with parliamentarians and also attended a

session of the Parliament where a statement was made in the house, acknowledging the expedition and their journey thus far. During the stopover, Tarini also underwent checks of all systems and repairs to defects under the supervision of a shore support team from India and stocked up with provisions for the next leg. The crew was briefed by the team mentor, Cdr Abhilash Tomy (Retd) on the passage ahead, who also assessed the boat.

Serving as ambassadors of India's rich maritime heritage, the Navy officials interacted with the Indian diaspora at a vibrant event coordinated by the Consul General of India in Perth. They also visited the Royal Australian Naval Base HMAS Stirling and the Ocean Reef High School. Sharing their journeys and experiences with the students. Phase 2 of the expedition will see INSV Tarini cross Cape Leeuwin, the Great Australian Bight, Tasmania and the South Island of New Zealand before calling on at Lyttelton.

Booked for transporting 'fake' water purifiers, how Delhi tempo driver ran around for 7 years to clear his name

Speaking to The Indian Express, tempo driver Anwar Sheikh said he had agreed to transport the ROs for Rs 1,200. Sheikh said he knew he was transporting ROs -but he did not know that they were fake.

NEW DELHI: Booked for transporting duplicate ROs (water purifiers), tempo driver Anwar Sheikh ran around attending court hearings for the next seven years to prove his innocence. A case was registered against the 46-year-old and two others initially under sections of cheating and the Trademark Act. Later, three others were also named as accused in the case. In March 2017, Anwar was arrested by the Faridabad Police and spent three days in jail before he got out on bail.

Last month, a Faridabad court acquitted all six persons and came down heavily on the police. In its order, the court said there is not an iota of evidence to prove the alleged commission of offence as the evidence on the file clearly suggests that no such incident ever happened.

Speaking to The Indian Express, Sheikh, who lives in a one-bedroom house measuring 50 yards in West Delhi's Vishnu Garden, with his wife, five-year-old son, and mother-in-law, said he had agreed to transport the ROs for Rs 1,200. Sheikh said he knew he was transporting ROs — but he did not know that they were fake. "I was hired and told to take the tempo just till the Badarpur border. But when I got there, I was told to cross the border and go 3 km further for an extra Rs 300. Sometimes, I wonder what would have happened had I not been greedy for the Rs 300... but we are daily wagers so that amount mattered," said Sheikh. It was not just Sheikh who went through the ordeal but also his family. His wife Farhana (40) refuses to speak about it. "Jo tha bas khatam ho gaya (Whatever it is, it's over now). I just hope and pray it never happens to anyone," she said.

For Anwar, the three days in jail were the worst days of his life. "Never in my life did I think I'd be in jail. I cried every night, the blankets were so smelly that I would remove my shirt and stuff it in my mouth so no one could hear me cry. I have a liver issue and when my friend came to give me medicine, the cops asked him to drink it first before handing it over to me," he said.

During his battle to clear his name, he sold his tempo and took the Metro to attend court hearings. Now, he has a new tempo — and a different bond with the police. "Sometimes, I run into them while driving around... the cop who was there when I was in the police station is now in the Traffic unit. I met him once," added Sheikh.

What the court said

The accused in the case — Anwar, Laxmi Narayan, Mohd Intaj, Bijender Kumar, Naveen Kumar and Rajeev Singhal — were acquitted on October 3. The court order noted that the complainant in the case, Manoj, who had earlier claimed he received secret information regarding duplicate ROs, had failed in the cross-examination and even refused to identify the alleged accused. The complainant also mentioned that no recovery was effected in his presence and claimed police had taken his signatures on a blank paper.

MCD launches software for bulk waste generators

NEW DELHI: The MCD on Sunday announced the launch of an advanced software platform to streamline the registration and monitoring of bulk waste generators (BWGs) as required under the Solid Waste Management Rules, 2016. This move is part of the civic body's efforts to improve waste management practices and promote a cleaner and greener Delhi.

BWGs include residential complexes, commercial establishments, hotels, banquet halls, hospitals, and institutions generating more than 100 kilograms of



waste daily. The new platform offers a user-friendly system for BWGs to register, ensuring compliance with regulations like proper segregation, processing, and waste disposal at the source.

The MCD stated that the software would enhance its ability to monitor waste disposal practices effectively. It will also allow timely interventions to address challenges in waste management. This initiative is aimed at reducing pressure on overburdened landfills and improving the waste management system.BWGs are required to register on the platform via the 311 app or the designated portal. The MCD warned that noncompliance with registration or proper waste management practices could result in penalties under the Solid Waste Management rules.

DUSU Election Result 2024: Counting underway, Delhi University Students Union results expected by 4 pm.

NEW DELHI: The counting for the Delhi University Students Union (DUSU) elections was underway at the North and South campuses and the final results are expected by 4 pm on Monday. In the fray are candidates from RSS-affiliated Akhil Bharatiya Vidyarthi Parishad (ABVP), Congress-supported National Students' Union of India (NSUI), and a Left coalition comprising the All India Students' Association (AISA) and the Students' Federation of India (SFI). The candidates for the post of president are ABVP's Rishabh Chaudhary, NSUI's Rounak Khatri, and AISA's Saavy Gupta.

The candidates for the post of vice president are ABVP's Bhanu Pratap Singh, NSUI's Yash Nandal, and AISA's Ayush Mondal. Winners for the posts of treasurer and general secretary in the four-member body will also be declared on Monday. While voting took place in September, the counting was delayed after the Delhi High Court pulled up the varsity for rampant defacement during the campaign. The administration has now asked the candidates to sign an undertaking that the celebrations will be muted.

The candidates have signed an affidavit pledging to "not resort to roadshows and rallies after the declaration of results" and avoid celebratory activities such as using dhols, loudspeakers, firecrackers, or distributing pamphlets.Non-compliance with these measures could result in the nullification of a candidate's victory or removal from their elected position, as per the affidavit.

Till the last reports came in, NSUI presidential candidate Khatri had amassed 4,565 votes at the end of round four of counting, and the ABVP candidate was trailing with 4,072 votes. Whereas ABVP's Singh was leading the race for the post of vice president with 4,336 votes against the NSUI candidate's 3,441 votes.

Coast Guard seizes 5 tonnes of drugs in Andaman waters in 'biggest ever haul'

NEW DELHI: The Indian Coast Guard on Monday seized five tonnes of drugs from a fishing boat in the Bay of Bengal near the Andaman and Nicobar Islands. According to the defence officials, this is likely to be one of its biggest drug busts."The Indian Coast Guard has apprehended a huge consignment of around five tons of drugs from a fishing boat in the Andaman waters. This is likely to be the biggest ever drug haul by the Indian Coast Guard ever. More details awaited," said defence officials. This bust is the latest in a series of actions taken by anti-narcotics agencies targeting drug smuggling rackets and

Earlier this month, the anti-narcotics agencies seized about 700 kilograms of methamphetamine and arrested eight Iranian nationals in Indian waters off the Gujarat coast. The operation, called "Sagar Manthan-4," was based on intelligence inputs, the Narcotics Control Bureau (NCB) said in a statement. The Navy identified and



intercepted the vessel using maritime patrol assets. The operation was conducted jointly by the NCB, the Navy, and the Gujarat Police Anti-Terrorist Squad. Union Home Minister Amit Shah described the drug seizure as an example of the government's commitment and the coordination among its agencies. "The back-to-back major breakthroughs against illegal drugs in a single day demonstrate the

Modi government's unwavering resolve to build a drug-free Bharat. The NCB today confiscated 82.53 kg of high-grade cocaine in New Delhi," he tweeted. This year, anti-narcotics agencies have seized 3,500 kilograms of drugs transported through maritime routes and arrested 11 Iranians and 14 Pakistanis in three cases. The foreign nationals remain in jail awaiting trial, the NCB said.

Sambhal: Case against Samajwadi MP, MLA's son over deadly mosque survey clashes

NEW DELHI: Schools are closed today, mobile internet has been suspended and large gatherings are banned in Uttar Pradesh's Sambhal day after hundreds protesting against a court-ordered survey of a mosque clashed with the police, resulting in the deaths of four people and several, including cops, being injured.A case has been registered against Sambhal MP and Samajwadi Party leader Ziaur Rahman Barq and Sohail Iqbal, the son of local MLA Iqbal Mehmood who is also from Akhilesh Yadav's party. The two have been accused of orchestrating violence, mobilising crowds, and provoking unrest, officials said.

Violence broke out on Sunday after protesters opposed a survey of the local Shahi Masjid conducted by a court-appointed Advocate Commission following a petition claiming that Mughal-era mosque was constructed by demolishing a temple at the site. The crowd threw stones and set vehicles on fire prompting the police to respond with

tear gas shells. The tension that began at 7 am continued for hours. Four people died in the clashes; they have been identified as Nauman, Bilal, Naim, and Mohd Kaif. While there are allegations that the victims sustained bullet injuries, the police have said that the exact cause of death will be confirmed after autopsy.

Police said that shots were fired by some protesters and a police officer suffered a gunshot wound to his leg. Another officer was hit by pellets and 15 to 20 security personnel were injured in the violence. Another cop suffered a serious head injury, while the deputy collector fractured his leg. Videos showed protesters throwing stones at cops from buildings in front of the Shahi Jama Masjid. Later, police personnel were allegedly seen cornering and hitting people as they tried to disperse a large crowd in a narrow alleyway. The district administration suspended mobile internet services Sunday evening for 24 hours. All schools and colleges are shut today, and



prohibitory orders banning large public gatherings are in place. The administration has also banned purchasing or stockpiling stones, soda bottles, or any flammable or explosive materials. Any outsider, social organisation or public representative has also been banned from entering the area without permission till November 30.

Opposition parties slammed the BJP over the violence. The Congress alleged that the police directly fired on the protesters, describing it as the "horrifying result of a well-planned conspiracy" by Chief Minister Yogi Adityanath and the BJP- RSS. Samajwadi Party chief Akhilesh Yadav also criticised the BJP, accusing its government and administration of orchestrating the violence "to divert attention from electoral malpractice".

The BJP shot back alleging that the INDIA alliance had been trying to create unrest since the failure in the Lok Sabha polls. It said that those who do not agree with judicial orders should take legal recourse. A party spokesperson blamed what he called the "ghamandia alliance" (an alliance full of arrogance), a term BJP leaders have often used for the INDIA bloc, for the violence. Tension has been brewing in Sambhal since November 19, when the Jama Masjid was surveyed on the orders of a local court following a petition claiming that a Harihar temple once stood at the site. Police stated that the first survey was incomplete, prompting a second survey on Sunday. However, amid violence, the Advocate Commissioner completed the survey on

If consumed without liquid or water, it can form a concrete-like mass in your digestive tract, which can lead to them getting stuck, Dr. Wendi Lebret, a gastroenterologist at California's UCLA Health, told New York Post and advised people to not eat dry chia seeds. Dr. Lebrett cited a 2014 report from the American Journal of Gastroenterology, which

swallowing after ingesting a tablespoon of dry chia seeds. Tests revealed that the seeds had hydrated and formed a gel, causing an obstruction in his oesophagus.

Chia seeds can absorb up to 27 times their own weight in water and one should preferably have them soaked or in smaller quantities.



'Faceless' I-T assessment initiative struggles to deliver

NEW DELHI: The Faceless Assessment mechanism is aimed to revolutionise tax administration by enhancing transparency and efficiency. However, as the system has evolved, it has faced significant challenges that have hindered its effectiveness, raising concerns among taxpayers and tax professionals alike. One of the primary issues is the limited opportunity for real-time interaction between taxpayers and assessing officers. The absence of video conferencing for cases involving complex disputes has made it difficult for taxpayers to clarify factual nuances or rectify misunderstandings. This lack of direct communication often leads to arbitrary assessments and prolonged disputes, frustrating many taxpayers who find themselves unable to effectively present their cases."Taxpayers often struggle to clarify factual nuances or correct understandings, leading to arbitrary assessments or prolonged disputes,' says Punit Shah, Partner, Dhruva Advisors. According to him, technical difficulties have further complicated the assessment process. Taxpayers frequently encounter bulk upload errors, stringent size limits for document submissions, and various glitches within the system. These barriers prevent individuals from providing detailed evidence, undermining the goal of a fair and transparent assessment process.

Vivek Jalan, founder of Tax Connect Advisory Services, pointed out that large taxpayers face unique challenges as their extensive financial records can overwhelm assessing officers. The inability to have personalised discussions often leads to inflated demands that could be easily resolved in a manual hearing.

Market opens strongly as investors cheer Maharashtra election outcome

NEW DELHI: India's equity market made solid gains on Monday morning with the benchmark indices - BSE Sensex and NSE Nifty - opening higher by about 1.5% each. The gain is attributed to the landslide victory of the Bharatiya Janata Party (BJP)-led coalition in the Maharashtra Assembly elections and a strong rally seen in global markets.

At the start of the Monday session, Sensex stood at 80,344.78, gaining 1,227%, or 1.55%, while the Nifty 50 reached 24,277, up by 370 points, or 1.55%. The fresh rally comes after the two benchmarks had surged about 2.5% each—their highest single-day gain in nearly five months- on Friday.

BEL, Shriram Finance, ONGC, M&M, Adani

Enterprises and BPCL were among the gainers on the Nifty 50 pack, while JSW Steel was the major laggard. Shares of Zomato surged by more than 5% as the food tech company is set to replace JSW Steel in the BSE Sensex, effective from December 23.V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services said that this sharp upswing is assisted by the super NDA performance in Maharashtra. "The political message from this election is huge and highly positive from the market perspective. A significant feature of the Friday rally was the sharp spurts in many large-caps with some stocks shooting up by more than 4%. This clearly indicates short covering, whic will keep the market resilient today," he addedHe, however, added that whether the rally will continue beyond a couple of days remains to be seen since the earnings headwinds will continue to constrain the bulls. Banking and IT are on a strong wicket assisted by fair valuations and reasonable growth prospects. Watch out for capital goods, telecom and pharma stocks, he said.

RBI-Centre tussle: Is govt trying to guide interest rates?

MUMBAI: Mint Road observers were taken aback by the sudden calls from top two Union ministers to cut the interest rates, days ahead of the December 6 policy meeting and within a month of the governor Shaktikanta Das' six-year term ending. Are we going back to the days of bitter public spats that government and the Reserve Bank of India (RBI) had when Subbarao was at the helm which got lingered into the terms of Raghuram Rajan and Urjit Patel, though not on rates per se but on larger policy issues?

What has suddenly changed the honeymoon-dayslike cordial relationship between the RBI and government in the past six years? Das completes his near record six-year term on December 12—the longest tenure since Benegal Rama Rau's, who helmed the central bank for 7.5 years from 1949-57--and all indications signal that he's

going to keep the job for a year or two at least. First it was the chief economic advisor V Anantha Nageswaran who made a wildcard demand in the last economic survey—skin food items off the retail inflation basket-food items constitute as much as 45.9% of the weighting in retail inflation basket and their prices cannot be controlled by monetary policy as they are supply-driven. The issue got a silent response from the RBI at the next policy presser: RBI believes that food inflation is central to its prices control objectives.On November 14, just ahead of Das' speech at an industry event, commerce minister Piyush Goyal dropped the rate bomb—first time in six years: "I certainly believe the central bank should cut interest rates.

Growth needs further impetus. It's absolutely a flawed theory to consider food inflation while deciding interest rates." Since Das was the next speaker, when sought comments, he quipped: "the next monetary policy is coming up in the first week of December. I would like to reserve my comments for that."

Adani Group shares rise for 2nd straight session: 2 reasons behind bull run

Adani group shares: Adani stocks continued their upward movement, with Adani Energy Solutions being among the top performers.

NEW DELHI: Adani Group shares saw a rise in early trade on Monday, continuing their recovery from last week's turbulence. All 10 listed companies of Gautam Adani's conglomerate opened higher, with some stocks rising as much as 7% before paring gains as the session progressed. Rift in Australian team? Adam Gilchrist highlights Hazlewood's **Perth Test comments**

New Delhi.Former Australia wicketkeeper Adam Gilchrist has raised concerns about a potential divide in the Australian cricket team following comments by fast bowler Josh Hazlewood after a challenging third day in the Perth Test. Hazlewood, who returned figures of 28 for 1 from 21 overs as India declared their second innings at 487 for 6, appeared visibly frustrated during a press conference. His remarks came shortly after the dismissals of Nathan McSweeney and Marnus Labuschagne late in the day, which left Australia's chances of victory all but extinguished. When asked about the team's approach to turning the game around, Hazlewood shifted focus to the batting unit, saying, "You probably have to ask one of the batters that question... I'm probably looking mostly towards the next Test." The seamer's comments sparked debate amongst cricketing pundits, with Gilchrist leading the discussion on Fox Sports. "I wonder if there's a divide in Andrew McDonald's team between the batters and bowlers," Gilchrist remarked, noting the unusual tone of Hazlewood's remarks.

However, former England captain Michael Vaughan saw it differently, interpreting Hazlewood's words as indicative of internal strain. "Publicly, I've never heard an Australian divide the camp into batters and bowlers like that," Vaughan said. "It's unusual to hear an Australian cricketer publicly shift focus to the next game before this one is finished."Mohammed Siraj delivered two sharp morning spells, dismissing Usman Khawaja and an out-ofform Steven Smith, as Australia struggled to 104/5 by lunch on day four of the first Test against India. Chasing a daunting target of 534, Australia, starting at 12/3, slumped further to 17/4 when Khawaja's mistimed pull off Siraj (3/34 in 10 overs) was brilliantly caught by Rishabh Pant, running backward. Travis Head (63* off 72) launched a spirited counter-attack alongside Smith (17), who battled hard to break out of his slump.

Questions now loom over the state of the Australian dressing room. While some commentators like Ravi Shastri and Warner downplayed the idea of significant discord, others believe Hazlewood's comments reflect a deeper issue. As Australia prepares for the fourth day of a seemingly insurmountable Test, attention will be split between their on-field performance and the dynamics within the team.

World Chess Championship Final: D Gukesh aims to become youngest champion

New Delhi. The countdown has begun - just three days left until the highly anticipated World Chess Championship between India's rising star Gukesh D and reigning champion Ding Liren of China. For Gukesh, the challenge will be especially tough. Historically, Ding has had the upper hand in their classical encounters. To date, Gukesh has yet to defeat Ding in a classical game, with Ding leading their head-to-head record 2-0. But Gukesh has proven time and again that he's a fighter, capable of bouncing back from setbacks and making quick adjustments. This championship match presents him with the perfect opportunity to rewrite that narrative and achieve something truly extraordinary.

Gukesh's past losses to Ding Liren have been largely determined by Ding's choice of openings - two in particular that Gukesh struggled to handle effectively. The Berlin Defense is known for its solidity and flexibility, making it a popular choice among top-level players. Ding's preference for this opening stems from its ability to offer both flexibility and strategic depth.


