PM Modi condemns 'deliberate attack' on Hindu temple in Canada

New Delhi, Nov 04: Prime Minister Narendra

Modi on Monday condemned a "deliberate attack" on a Hindu temple in Canada, saying that he expected the Canadian government to ensure justice and uphold the rule of law. Taking a serious note of the clash between two groups of Indian-origin people inside the temple in Brampton, the Prime Minister said such acts of violence cannot "weaken" India's resolve. Modi put out a post on X saying that "I strongly condemn the deliberate attack on a Hindu temple in Canada". He added, "Equally appalling are the cowardly attempts to intimidate our diplomats. Such acts of violence will never weaken India's resolve. We expect the Canadian government to ensure justice and uphold the rule of law". Modi's post came just hours after the Ministry of External Affairs (MEA) condemned the violence at

the temple and said it was perpetrated by "extremists and separatists". The MEA statement said, "We condemn the acts of violence perpetrated by extremists and separatists at the Hindu Sabha Temple in Brampton, Ontario yesterday." It said

the "Government of Canada needs to ensure that "We have seen violent disruption today (Nov 3) all places of worship are protected from such attacks". "We remain deeply concerned about the



safety and security of Indian nationals in Canada," it added. Separately, on Monday morning, the Indian High Commission in Ottawa said its consular camp saw "violent disruption" on Sunday and blamed "anti-India" elements for the disruption. The High Commission put out a statement on X:

Mandir, Brampton, near Toronto." The statement of the High Commission was posted on Monday morning. Such camps are for the benefit and ease of "local life certificate" beneficiaries (both Canadian and Indian), the High Commission said. "On account of the prevailing security situation, the Canadian authorities had been requested well in advance to provide strong security measures for these events, which constitute routine consular work". 

New Delhi, Nov 04: The Supreme Court on Monday relaxed the bail condition imposed on Kerala journalist Siddique Kappan in a UAPA case saying he doesn't have to report to a Uttar Pradesh police station every week. A Bench of Justices P S Narasimhan and Sandeep Mehta relaxed the condition imposed by the top court on Kappan at the time of his bail in September, 2022. "The order dated September 9, 2022, is modified and it shall not be necessary for the petitioner to report to the local police station. The other prayers made in the present application can be agitated independently," said the Bench. Kappan was arrested in October, 2020 while on his way to UP's Hathras, where a Dalit woman had died after allegedly being sexually assaulted by a group of men. While granting bail to Kappan, the court had directed him to report to the police station concerned every week. The top court had on September 17 asked the state government to

the one directing him to remain in Delhi for the following six weeks after his release from prison and reporting to the Nizamuddin police station every Monday. "The appellant shall be



taken to the trial court within three days and shall be released on bail on conditions as deemed fit by the trial court," the Bench had said. The court had, however, allowed him to travel to Malappuram in Kerala, his home state, after six months maintaining that he would have to report to the local police station and

mark his presence there every Monday. Kappan was directed not to leave Delhi's jurisdiction without the permission of the court besides being ordered to attend the trial court every day either personally or through his

lawyer. "The appellant shall deposit his passport with the investigative machinery," added the top court. The case was registered against Kappan and three others under various provisions of the Indian Penal Code and the Unlawful Activities (Prevention) Act for allegedly having links with the Popular Front of India (PFI). The PFI had been accused in the past of funding protests against the Citizenship Amendment Act across the country and the police claimed that the accused persons had attempted to vitiate the law and order situation in Hathras. New Delhi, Nov 04: At least 23 people were killed after a Garwal Motors Users' bus fell into a 200-metre deep gorge near Uttarakhand's Kupi in Ramnagar at the Pauri-Almora border on Monday. A search operation is underway and the injured are being rushed to the hospital. The bus was going from Garhwal to Kumaon when the accident took place at Marchula in Almora, District Magistrate Alok Kumar Pandey said. So far seven deaths have been reported but the numbers may rise as there were at least 40 passengers in the bus at the time of the accident. "Received very sad



news of casualties of passengers in the unfortunate bus accident that took place in Marchula of Almora district The district administration has been instructed to conduct relief and rescue operations swiftly," he said on X. "The local administration and SDRF teams are working swiftly to evacuate the injured and take them to the nearest health centre for treatment. Instructions have also been given to airlift the seriously injured passengers, if required," he said.

IAF's MiG 29 fighter jet crashes near Agra

Agra, Nov 04: "A MiG-29 aircraft of the IAF crashed near Agra during a routine training sortie today, after encountering a system malfunction. The pilot manoeuvered the aircraft to ensure no damage to life or property on ground, before ejecting safely. An enquiry has been ordered by the IAF, to ascertain the cause of the accident," the Indian Air Force said in a statement. "During a routine night training mission in Barmer sector, an IAF MiG-29 encountered a critical technical snag, forcing the pilot to eject. The pilot is safe and no loss of life or property was reported. A Court of Inquiry has been ordered," the IAF said in an X post. Barmer SP Narendra Meena said that the incident took place away from the populated area. "No loss of human life was reported. The plane caught fire during the crash," he said. On June 4, IAF's Sukhoi 30 MKI fighter jet crashed near Shirasgaon village of Niphad tehsil in Maharashtra's Nashik district.

Court frames charges against prime accused Sanjay Roy, trial to begin on Nov 11

Kolkata, Nov 04: Eighty seven days after the heinous rape and murder of a junior doctor in the RG Kar Medical College in Kolkata, a city court on Monday framed charges against the prime accused in the case. Saniav Roy, who continues the claim that he has been framed in the murder case. The Sealdah Court in West Bengal framed charges against accused Sanjay Roy under section 103(1), 64 and 66 Bhartiya Nyay Sahita. The court further said that the day-to-day trial in the case will commence from November 11. Roy has been booked under Section 64 of the Bharatiya Nyay Sanhita (BNS) Section 66 (which pertains to punishment for causing death or resulting in a persistent vegetative state) and 103 (punishment for murder). While he was being led out of court, Sanjay Roy told reporters, "I have done nothing. I have been framed in this rape-murder case. Nobody is listening to me. The government is framing me and threatening me not to open my mouth." In its initial charge-sheet submitted last month, the Central Bureau of Investigation (CBI) identified Roy as the "sole prime accused" in the case. The CBI's chargesheet also acknowledged the possibility of a "bigger conspiracy" behind the crime.



EC must act against Sarma's 'communal rhetoric', campaigning by Odisha governor: Jairam Ramesh

New Delhi, Nov 04: Congress leader Jairam Ramesh on Monday hit out at the Election Commission for the "tone and tenor" of its recent letter to his party while also urging the poll body to act against "communal and incendiary rhetoric" allegedly used by Assam Chief Minister Himanta Biswa Sarma during poll campaigns. In an interview with PTI, the Congress general secretary in-charge communications also urged the Election Commission (EC) to take action against Odisha Governor Raghubar Das for campaigning in Jamshedpur. His remarks come days after the Congress slammed the EC after it rejected the party's allegations over irregularities in the Haryana Assembly polls. The opposition party had said if the poll panel's goal was to "strip itself of the last vestiges of neutrality", creating that impression. In its letter to the EC signed by nine senior leaders,



"We have carefully studied your response to our complaints. Not surprisingly, the ECI has given a clean chit to itself. We would normally have let it be at that. However, the tone and tenor of the ECI's

then it was doing a "remarkable job" at response, the language used, and the allegations made against the INC compel us to submit the counter-response." On the

Congress' letter to the EC, Ramesh said, "I don't want to say anything more than what we have already said. In fact, we met the EC on Haryana on 20 assembly constituencies on which we had specific complaints. We met the EC on October 9 and they gave a response on October 29 and we would have (left the matter at that)," Ramesh said. "We have exercised our democratic right, the EC heard us, they heard us patiently and they have responded but it is the manner in which they responded, the language that they used, the charges that they have hurled at us, giving a sense that they did us a favour by meeting a Congress delegation," he told. "Its job is to listen, that is what we took objection to, we took objection to the tone and tenor of the language, we took objection to the patronising and condescending manner in which the Election Commission was calling into question the democratic right of a political party to be heard and to represent," the Congress leader said. "We have to have our say, ultimately the EC will have its way and if you are still unhappy, we can go to court. So that is a separate issue," he added. Ramesh said the EC could not say that it had done a political party a favour by meeting it and that by raising questions "you are spreading unrest and anarchy". These are extraordinary statements to be made and put on record in writing to any political party, he said. "This is not the way the EC should be replying," he added. Ramesh is still hopeful that the EC is a constitutional body and should move on complaints. "It should move against the communal and incendiary rhetoric that is being used by the Assam chief minister and the Union home minister.



Salem man held for Rs 1.2 crore fraud 16 years after he went missing

ERODE: CB-CID police arrested a 51-yearold man who cheated several people to the tune of Rs 1.2 crore by starting a firm and promising lucrative returns on their investment 16 years ago. The suspect M Prabakaran (51), a resident of Gandhi Road in Salem, was arrested in Bengaluru on Friday based on a tip-off.

Sources said Prabakaran started a company in Erode in 2002 and put up an advertisement that if anyone paid him an advance and got data entry projects and completed the work, they would get double their invested amount. Believing that, many people invested in the company. Later, Prabakaran went into hiding. The victims complained to the Erode town police station. The case was later transferred to CB-CID. During the investigation, it came to light that Prabakaran along with five others including his wife Vandarkuzhali (50) had cheated people of Rs 1.2 crore.

A case was registered against the six and a trial was held in Erode JM 3 court. In 2008, Prabakaran went absconding without appearing for the trial following which the court issued an arrest warrant against him. However, the others were sentenced.

Police said, "On Friday, the CBCID received information that Prabakaran was in Bengaluru. A special team rushed to Bengaluru and arrested him. After investigation, he was produced before the concerned magistrate and was sent to jail on

Crop yields drop by 38 per cent in drought-hit Annamayya in Andhra

TIRUPATI/KADAPA: With the State Disaster Management Authority (APSDMA) recently declaring 54 mandals in five districts of Rayalaseema as drought-hit during the Kharif season, The New Indian Express interacted with farmers in Annamayya district to bring to light the issues faced by them due to the lack of water. In Kalakada, a severely drought-affected mandal in Annamayya district, dwindling water resources have impacted agriculture activity. With irrigation ponds and wells drying up. farmers are struggling to cultivate their lands. Known for producing tomatoes, groundnuts and paddy, the region has witnessed a sharp decline in acreage due to unfavourable conditions. This year, farmers cultivated groundnuts in 816 acres, tomatoes on 1,427 acres, and rice in 339 acres - which is around 38% to 45% less than the previous years. As a result, farmers have been facing severe losses, particularly with groundnut yield falling short of expectations. Additionally, livestock farmers are also struggling to provide fodder for their cattle.

SV Naidu, a ryot from Kalakada, rued, "I planted tomatoes in 25 acres and spent up to Rs 1 lakh. We have seen little rain this Kharif season. The quantity and quality of produce have also declined, further forcing me to sell it at a low price."

Several mandals reel under drought in Rayalaseema dists

The situation is dire in the entire Pileru constituency.identified in five Rayalaseema districts of Ananthapur, Sri Sathya Sai, Annamayya, Kurnool, and Chittoor. At 19, Annamayya district has the highest number of severely droughtaffected mandals. Heinous crime exposes ugly reality of horticultural nurseries in Andhra

RAJAMAHENDRAVARAM: With over 2,000 farmers cultivating horticultural crops on approximately 5,000 hectares and employing over 50,000 workers, the Kadiyam Nurseries are renowned across India for their extensive collection of flowers and gardens.Located 15 km from Rajamahendravaram, the cultural capital of Andhra Pradesh in East Godavari district, Kadiyam Nurseries has recently been in the spotlight as a preferred destination for various tourism development projects.

However, behind the fame of these flower gardens lies the challenging reality faced by nursery workers, who lack proper facilities, with an urgent need for enhanced security, especially for women. The lack of security came to light following the recent gang-rape and murder of a 43-year-old nursery worker by local farm workers in Burrilanka village.

Despite the large workforce and an estimated annual business of approximately Rs 800 crore, government officials from the labour and women and child welfare departments have yet to conduct a comprehensive study on the working conditions of female workers in the region.It is noteworthy that nearly 50,000 farm workers are employed in these gardens, about 25,000 of whom are women. Many of these workers have migrated from villages along the Andhra-Odisha border, North Andhra districts, and Chhattisgarh. Widespread criticism has been directed at nursery owners, who are accused of profiting significantly while neglecting.

'In a shambles': Sorry state of archives in Kerala has experts sounding alarm bells

Need for modern infrastructure, systemic reform, improved accessibility by focusing on digitalisation stressed

KOCHI: In 1993, the central government enacted special legislation for the conservation and preservation of 'public records' in the country. Several states followed it up with initiatives to protect the rich archival history they possess. In 2023, Kerala passed the Public Records Act. As a part of its implementation, inspections and public sittings by a special committee of officials, comprising the minister of archeology and archives, were held at all four state archive centres. According to experts, archives in the state need urgent protection and conservation."Archival material are treasures of national importance. They hold the history of the nation, and culture, and they answer many questions. Such materials in our possession are in a highly dilapidated state right now," Cherai Ramdas, an independent researcher and historian, told ."Archives once lost can never be retrieved. The condition of many of our records is saddening. On the racks of the archives we

see the sole evidence of our history torn,

withered, decayed, and even misplaced," he says, sounding the alarm bell.Retired archivist Abdul Majeed echoed the views. "It is not only the state of the archival materials. The whole system is in a shambles. It lacks systematic organisation at the very core. There are no proper racks, no catalogues and no qualified professionals to maintain the records," he

The Kerala State Archives, which was formed in 1962 as a section of the higher education department, became an independent department in 1964. The archives in Thiruvananthapuram and Ernakulam were established in the same year. In 1966, the regional archives in Kozhikode was set up. The state archives of Kerala has records from colonial era to pre-colonial times. It includes correspondence files, records on land ownerships, settlement registers, maps, gazettes, etc."We have a record named Fort St George Gazette. It includes all kinds of files from the colonial times, even



evidences like statements from the survivors of the wagon tragedy and such. All these are rapidly decaying right now," says Majeed.

Ramdas provides cases in point. "The documents that I had referred to 10 years ago cannot be found anymore. There are paper files termed 'brittle' and single sheet records and maintenance of such files have been neglected for years. Right now, I am dealing with files during the time of Rajarshi Rama Varma (ruler of Cochin from 1895 to 1914). The condition of

'Thathri Smarthavicharam,' a rare evidence of trials during old times, is no different. Over 800 pages of the files are missing

"He says the original copies of the Kesari newspaper, of Kesari Balakrishna Pillai. which he had handed over to the archives in 2010 for mending and safe-keeping, are going down the same path.

Attempts to digitise the records have been on for long. Earlier, many of the records at the Ernakulam archives were made into microfilms, but experts say none of that was well maintained. "Digitalisation of all these materials would be a revolutionary change," says Dr Sivadasan, a senior professor.

"Such democratisation of knowledge is vital in our society," he adds. As per the archive protection rules, the materials should be mended, laminated and preserved in airconditioned rooms, kept in steel racks that are not over seven feet, and should never be exposed to sunlight and other weather

Madras HC pulls up TN police over delay in probe in two cases

MADURAI: Displeased with the state police for delay in completing probe in two separate cases, one of which was a hit-and-run case, the Madurai Bench of the Madras High Court recently criticised that if not for the victim's situation, it would have permitted her to investigate the case along with the police."The state is the prosecuting agency and every victim of a crime depends upon it. If the police are not carrying out a proper investigation, the victims may not get a remedy," observed Justice B Pugalendhi, while passing two separate orders in petitions seeking expeditious investigations. The first petition was filed by S Kamala, who lost her husband in a hit-and-run incident eight months ago and the police are yet to identify the vehicle involved. The judge pointed out that as per



Section 2(h) of the CrPC and Section 2(j) of the BNSS, the power of investigation is also vested not only with a police officer but also with anyone authorised by a magistrate.But he said he refrained from permitting Kamala to conduct the probe along with the police, considering she is a young widow with two kids. He therefore suo motu impleaded the Dindigul

superintendent of police to the case and directed the officer to ensure the vehicle involved is identified and action is taken

Case pending at FIR stage for last 2 years

Equipped with advanced machinery, including 26 single-needle sewing machines, the unit has expanded its product range.

During the pandemic, the park gained renown for its 'Nightingale' brand of nighties, introduced with backing from the District Mission. Today, it manufactures not just garments but also ecofriendly cloth bags for Supplyco, besides national flags. By offering a price advantage compared to private manufacturers, the park's products have gained popularity at Kudumbashree's Onam fairs and Saras Melas. Soon, its products will be made available online through Kudumbashree's Pocket Mart platform.

After multiple discussions weighing the pros and cons, 40 members decided to take the plunge and launch the enterprise." Valsala also highlighted the initial challenges. "When we began, none of us knew stitching. We underwent four months of training in industrial-level stitching through the Kudumbashree Mission. In addition to the Rs 12.8 lakh bank loan, Kudumbashree provided Rs 4 lakh as capital subsidy and Rs 1.5 lakh as a revolving fund to upgrade machinery.

Stink no more! K-100 waterway network to be ready by January in Karnataka

BENGALURU: The Rs 179-crore K-100 waterway project, which runs from Shantala Silk Junction in Majestic to Koramangala in BTM and drains into Bellandur Lake, covering 12 km, is likely to be ready by January. The project is the initiative of Bruhat Bengaluru Mahanagara Palike (BBMP) with architect and urban expert Naresh Narasimhan of Mod Foundation helping in developing the concept. It was also supported by the Bangalore Water Supply and Sewerage Board (BWSSB) and other parastatals to ensure the 12-km drain remains free from sewage. It will become an urban green asset for the public, if all goes well."This major drain (K100) across the city can hold

water even if there is heavy rainfall up to 100 mm per hour. Over the years, drains have become choked with 30% occupied by hardened silt, 30% by sewage and 30% solid waste. Hardly 10% of drains have capacity for rainwater. To fix the problem, this project was taken up. Currently, this is the only Rajakaluve that does not cause



flooding in heavy rain. Once the BWSSB's intermediate stage pumping station in Shantinagar becomes operational, there will be almost zero sewage in the 12-km drain network. There is a pathway along the drain network and people can also take a walk from Double Road to Bellandur, during the non-rainy season," said Narasimhan.He also added

that technology like alert systems, water-level sensors and automatic gate closure to pathways have been

According to BBMP officials, initially, 130 million litres per day (MLD) of sewage was being let in and now it has been reduced to only 10 MLD and soon this will be stopped. Due to the reduction in sewage and the development of Rajakaluve, flooding incidents in areas of Shanthi Nagar, Richmond Town and parts of Koramangala and other places were avoided this rainy season. We are hopeful that the ISPS by

BWSSB will be ready in two months and the project is likely to be inaugurated by January. Once we complete, work on another drain network will also be taken up," said BS Prahalad, Principal Engineer, BBMP, and also incharge of the Stormwater Drain Network. According to Prahalad, the contractor engaged in the project has designed, built and will operate and maintain the project

Rain and ruin: Crops on 1.05 lakh hectares of land damaged

BENGALURU: Agriculture and horticulture crops on around 1.05 lakh hectares were damaged due to heavy rain since October 1. While a survey was done to ascertain the extent of damage, preliminary reports by officials indicate that agriculture crops on 74,994 hectares and horticulture crops on 30,941 hectares were damaged due to rain. TNIE takes a look at the impact of heavy rain across the state.

Dakshina Kannada: Arecanut, cocoa growers stare at loss

There are over 1.44 lakh registered arecanut growers who have suffered as tender areca fruits had

fallen due to fruit rot disease, following heavy rain in June and July. Central Arecanut and Cocoa Marketing and Processing Cooperative president Kishore Kumar Kodgi said this summer, extreme heat resulted in withering of the inflorescence. But heavy rain has worsened the condition, and farmers could not spray pesticide. Cocoa production was also affected across the district, with tender cocoa buds either rotting or blackening and



Gadag: Onion, chilli bring tears to farmers Many farmers who grew onion and chilli are in distress, with heavy rain leaving their crops damaged. Of 12,500 hectares, sowing was completed only on 2,760 hectares. Similarly, chilli was also sown in a few places. Besides this, farmers in Nargund, Ron, Gajendragad, Laxmeshwar, Shirahatti and Mundargi also saw a loss in maize, cotton and other crops. Farmers Prakash Beleri and Manjunath Konnur said,

"Abbigeri onions are famous across the state, and many farmers directly sell the onion crop to Tamil Nadu and surrounding states with the help of Yeshwantpur APMC market. But this year, Gadag's onion farmers suffered losses and got Pune and other onions at a high price.'

Hassan: Banana and ginger crops lost Recently, standing crops including maize,

ragi and horticultural varieties, including ginger, banana and vegetables, were destroyed due to rain. According to Ramesh Kumar, joint director of agriculture, crops sown on 2.50 lakh hectares, maize on 362 hectares and ragi on 132 hectares were damaged in the district so far. The highest loss was agricultural crops on 397 hectares in Holenarasipur taluk, followed by Arkalgud (175 hectares), Hassan (79 hectares), Channarayapatna (71 hectares) and Alur (56

hectares). Kodagu: Change in weather pattern

The changing weather pattern severely affected coffee cultivation in Kodagu, and the sector has recorded considerable loss this year due to untimely rain, said Coffee Board Deputy Director V Chandrashekar.

September's untimely rain resulted in dropping of coffee beans, which will affect productivity next year. "A crop loss survey was conducted jointly with the revenue, agriculture and horticulture departments. Coffee plantations in heavy rainfall zones have reported crop loss and a detailed report has been submitted to the district administration," he said. Alongside paddy, ginger farmlands in the district also suffered losses due to rain in September.

Gurgaon police file case against Lawrence Bishnoi's brother Anmol Bishnoi over death threats to Bhim Sena chief Satpal Tanwar

NEW DELHI. Gurugram police have filed a case against gangster Anmol Bishnoi, who is the brother of Lawrence Bishnoi, for allegedly threatening Bhim Sena chief Satpal Tanwar from abroad. Anmol Bishnoi is accused of making threatening calls to Satpal Tanwar from the US and Canada, using phone numbers from Zimbabwe and Kenya.Following Tanwar's complaint, a police team including members of STF, crime units, and cyber crime units has been formed to investigate the matter. Efforts are being made to bring Anmol Bishnoi to India. Tanwar received several threatening calls from Anmol Bishnoi on October 30. According to the complaint, the calls lasted a total of 6 minutes and 41 seconds and were answered by Tanwar's female secretary. The police filed the case at Sector 37 Police Station on Saturday under relevant sections. Anmol Bishnoi is believed to be hiding in the US and has a Rs 10 lakh reward on his capture, announced by the National Investigation

Cow menace: Streets littered with dung as cattle roam free in Sec 9A



Gurgaon. Residents of Sector 9A have raised concerns about illegal dairy operations in the area, due to which cows and buffaloes are left roaming freely around the sector. Herds are often seen wandering through residential streets and creating a nuisance, they said.

According to residents, dairy operators in the adjacent Surya Vihar and Devi Lal colonies allow their animals to wander into sector roads, obstructing traffic flow and posing safety risks for both pedestrians and motorists. This has led to unhygienic conditions and damage to green areas. The streets are often littered with animal waste, creating not only an unpleasant environment but also a health risk, they said."The streets are filled with animal waste and a constant filthy smell hangs in the air. Moreover, it's dangerous to navigate through the roads with these cattle blocking the way. They graze in vacant plots, damaging plants outside the houses," said Vinod Arora, RWA president of Sector 9A.A particularly alarming consequence of these operations is the disposal of cow dung, which is being carelessly thrown into the sewers, leading to the sewer line becoming clogged. Despite numerous complaints filed with the MCG, residents said there was no effective action taken against the illegal operation of dairies."Not only do we have to deal with the animals blocking the path, but the situation is compounded by the cow dung being thrown into the sewers, which causes frequent blockages and overflows in the area. We raised the matter with MCG but they are yet to enforce regulations against these illegal dairy operations. The health and safety of residents are at stake. Despite being illegal, they are mushrooming right under the nose of civic authorities," said Surj Bhola, RWA general secretary of Sector 9A.Meanwhile, MCG joint commissioner Pardeep Kumar told TOI, "All dairy operations across the city have been mapped out by the sanitation wing and zone-wise details have been submitted. All SSIs have been directed to issue challans to illegal dairy owners and submit weekly

In Raj Nagar Extn, waste burning causes severe damage to trees



Ghaziabad. Garbage burnt in the open near Brave Hearts society in Raj Nagar Extension and Omega Green Banquet has caused severe damage to trees in the vicinity."You can see mounds of soil on almost all roads in our area, which shows a lack of responsibility on GDA's end. It is particularly disappointing that the Authority failed to arrange basic cleaning services during Diwali, leaving the area littered with rubbish,' said Deepanshu Mittal, a resident of Raj Nagar extension. He added that the authorities have failed to address garbage burning in Ghaziabad, despite the city's air quality index (AQI) falling consistently in the very poor category. Locals have expressed concerns over waste accumulation and waste burning along roadsides, which pose significant health risks.

"Over the last several months, there has been a substantial increase in waste accumulation. The disposal site serves as the collection point for all rubbish gathered from our neighbourhood and surrounding localities. When the time comes, authorities blame farmers for the deterioration of AQI," said Manoj Kumar, another resident.

HC bins plea by residents, allows co to take over land handed yr ago

Noida. The Allahabad high court has allowed Experion Developers Pvt Ltd to take possession of 4.8 acres in Sector 45 that was allotted to it for a group housing project more than a year ago.

This court dismissed a petition filed by residents of the adjacent Kanshiram Yojana EWS colony claiming that the land should be used for building civic amenities and an approach road for them. The residents who moved the petition against the land allotted to Experion live in a colony that was developed by the Authority in 2008 for widows, those physically challenged and people living below the poverty line under the Manyavar Shri Kashi Ram Ji Shahari Gareeb Awas Yojana.

In Dec 2022, the Authority invited e-bids for the allotment of this plot. Experion secured the land after paying a premium of Rs 200 crore. The possession letter was issued to the company in July 2023.A group of residents, however, challenged the allotment, arguing that the land should have been reserved for a community



centre and an access road to the EWS colony.A few residents allegedly broke through the wire fencing surrounding the project site, trespassed on the land, staging protests, and halting construction work. Some even attempted to construct temporary structures on the site illegally, the Authority informed the court. While the residents moved three petitions against the land allotment, Experion moved one in response. During the course of the hearing, the court underscored that Noida Authority was well within its rights to allot the land to Experion because it was never considered a part of the EWS colony."Nothing has been brought on record to show that this land has ever been earmarked for future development or could be used as a road," the court observed. The HC also noted that the

compromise with the residents, offering to widen a 9m road to 12m by utilising land from the compound of a nearby water tank. The residents, the court observed, had agreed to the arrangement. However, during the hearing, one petitioner retracted from the settlement. The Authority argued that this single objection had stalled the entire project. It also argued that the petitioners, who were allotted houses free of cost, were "trying to extract additional concession". The court backed the Authority's decision to reach a compromise. "This court considers it to be a very positive gesture on the part of Noida Authority to allow or give benefit to the allottees of EWS colony, which was not earlier granted," read the Oct 25 order by Justices Mahesh Chandra Tripathi and Prashant Kumar. The court asked the Authority to ensure Experion was handed the land peacefully and could proceed with construction without any

Mercury drops to 15.9°C in city, season's lowest so far

Gurgaon. The city recorded its lowest minimum temperature this season, at 15.9 degrees Celsius on Sunday, as mercury fell over a notch in 24 hours. But it was still 1.5 degrees Celsius above normal for this time of the year.

Maximum temperature also fell to 32.1 degrees Celsius, almost two notches from the previous day. This too was 1.2 degrees Ĉelsius higher than normal.

Meteorologists said this delay in cold weather conditions is likely because of the effect of a neutral El Nino, a climate pattern that leads to warmer than normal sea surface temperatures in the equatorial Pacific Ocean. For India, El Nino is often correlated with warmer weather."The delay in the onset of cold weather conditions is also likely on account of the continued prevalence of neutral El Nino conditions in the equatorial Pacific Ocean. The probability forecast indicates a higher chance of La Nina conditions developing in November and December in a gradual manner," said Surender Paul, director of IMD-Chandigarh.La Nina, associated with harsher winter and more rainfall, causes a cold wave-like jet stream to flow across Afghanistan, Iran and the

Hindu Kush mountains. These strong, cold winds affect temperatures in India as well. The Met department had earlier forecast a potentially severe winter due to the effect of La Nina.But IMD's latest forecast says temperatures in northwestern plains will remain above normal for a fortnight, and thereafter, see a gradual fall."Different regions in India are expected to experience varying degrees of winter severity. Northern states like Himachal Pradesh, Uttarakhand, and Jammu and Kashmir may see especially frigid conditions, with temperatures potentially falling as low as 3°C. Additionally, the combination of colder weather and increased rainfall could impact agriculture, particularly in areas that rely on winter crops," IMD's forecast said.Meanwhile, Delhi recorded the lowest minimum temperature of the season on Sunday as the mercury dropped to 16.5 degrees Celsius, one degree above normal, at Safdarjung, which is the city's base station. However, the Ridge in north Delhi was the coldest station as the minimum temperature stood at 13.3 degrees Celsius, four notches below

normal.It was followed by Ayanagar in south Delhi, where the minimum dropped to 14.5 degrees Celsius, two degrees below normal. Clear skies during the daytime caused the night temperature to dip.The maximum temperature on Sunday was recorded at 33.2 degrees Celsius, three degrees above normal.Rain has been eluding Delhi for nearly one and a half months, and hence the city has been recording sunny days."The days are warm due to clear skies. However, as there is no cloudiness, the heat quickly dissipates at night, which causes a dip in temperature," a Met official said. The data shared by India Meteorological Department suggests that the last time the national capital logged rainfall was on Sept 19. Though the long-period average for Oct for normal rainfall is 15.1 mm, the city did witness rain activity for a single day. Mahesh Palawat, vice-chairman, Skymet Meteorology, said: "The minimum temperature saw a dip on Sunday mainly due to clear skies. However, it was still one degree above normal. The normal minimum temperature is 15.3 degrees Celsius for this time of the

35-acre site goes up in flames as illegally dumped trash fuels blaze

Gurgaon. A 35-acre area in Sector 21, which has become an illegal dumping ground over the years, went up in flames that took the fire department almost six hours to douse on Saturday night.

Officials said they suspect that the blaze began because of firecrackers being burst in the area. Inflammable items such as foam and plastics were dumped at the site, and likely fanned the fire.

Residents said they could see the flames a few kilometres away. Smoke continued to billow from the site till Sunday morning. Deputy director (technical) of the fire department Gulshan Kalra said on Sunday that they received a call about the fire at 9.06pm. Six fire tenders, four from Udyog Vihar and one each from Bhim Nagar and Sector 37, were pressed into action."Trucks took 30 rounds of water to the site. The operation concluded around 2:40am. Fortunately, no casualties were reported," Kalra said. Another official from the Udyog Vihar station said: "The fire might have been caused by firecrackers, and it quickly spread because of items such as plastics, cardboards and wires."Originally acquired by the Haryana Urban Development Authority (now HSVP) in the late 1970s, this 35-acre area was meant for developing the sector. No retaliatory challans in city on Raj roadways: Cops

Gurgaon: The Gurgaon traffic police have denied taking any retaliatory action against the Rajasthan Roadways buses. This comes in the wake of a recent video that went viral on social media in which a woman cop from Haryana refused to pay the fare in a Rajasthan Roadways bus. An ugly argument between the cop and the conductor of the bus ensued.Later, it was reported that Haryana police and Rajasthan police, in retaliation against each other, were issuing challans to roadways buses. However, DCP (traffic) Virender Vij issued a statement on Monday to clarify that "no retaliatory or targeted challans" were being issued by the police. "We are issuing challans without any attempt to target anyone," he said. Vij said such reports after the viral video were "incorrect". According to the traffic police, they are conducting a drive against lane driving in Oct. So far, 3,600 challans for lane driving have been issued, out of which only 400 challans were issued to buses. Vij said challans have been issued to all kinds of vehicles, including state road transport buses "Out of these 400 challans to buses, only 11 were issued to Rajasthan Roadways buses, while 150 were issued to Haryana Roadways buses, 41 to Delhi transport buses and 55 to school buses. Besides, more than 100 challans were issued to buses from other states. It is totally wrong to say that only Rajasthan Roadways buses are being challaned," the DCP said. Amid a series of challans — Haryana Police penalising RSRTC buses plying into the bordering state and Rajasthan Traffic Police retaliating a day later — senior RSRTC officials said they would examine the matter and discuss it with Haryana Police. Speaking to TOI, RSRTC managing director Purushottam Sharma said, "I have come across this information. I will examine the whole matter and seek a report. Thereafter, we will have a word with the authorities to resolve the issue. At the same time, the drivers have been instructed to follow every traffic rule to avoid challans." Though RSRTC did not offer further comment, officials said Rajasthan buses were "targeted" not only in Haryana but also in Delhi.Similar action followed in Rajasthan, with the state traffic police hauling up Haryana Roadways buses in Jaipur on Sunday. RSRTC officials said over 80 challans were issued to Haryana Roadways buses and their drivers. Israel says it carried out ground raid into Syria, seizing a Syrian citizen connected to Iran

JERUSALEM: The Israeli military said Sunday it has carried out a ground raid into Syria, seizing a Syrian citizen involved in Iranian networks. It was the first time in the current war that Israel announced its troops operated in Syrian territory.

Israel has carried out airstrikes in Syria multiple times over the past year, targeting members of Lebanon's Hezbollah and officials from Iran, the close ally of both Hezbollah and Syria. But it has not previously made public any ground forays into Syria.

The Israeli military said the seizure was part of a special operation "that took place in recent months," though it did not say exactly when it occurred. Syria did not immediately confirm the announcement, but a progovernment Syrian radio station, Sham FM, reported Sunday that Israeli force carried out a "kidnapping operation" over the summer targeting a man in the south of the country. The disclosure of the raid comes as Israel has waged an escalated campaign of bombardment in Lebanon for the past six weeks, as well as a ground invasion along the countries' shared border, vowing to cripple Hezbollah, On Saturday, an Israeli military official said naval forces carried out a raid in a northern Lebanese town, seizing a man they called a senior Hezbollah operative. The army identified the man it seized as Ali Soleiman al-Assi, saying he lives in the southern Syrian region of Saida. It said the man had been under military surveillance for many months and was involved in Iranian initiatives targeting areas of the Israeli-annexed Golan Heights near the border with Syria.Body camera footage of the raid released by the army showed soldiers seizing a man in a white tank top inside a building. The man was brought to Israel for interrogation, the military said. Israeli Prime Minister Benjamin Netanyahu visited the border with Lebanon on Sunday, saying his focus was trying to keep Hezbollah from rearming itself through the "oxygen lifeline" of Iranian weapons transferred to Lebanon via Syria. Israel says its campaign in Lebanon aims to push Hezbollah away from the border and put an end to more than a year of fire by the group into northern Israel.

Israel's strikes in Lebanon have killed more than 2,500 people over the past year. In Israel, 69 people have been killed by Hezbollah projectiles.

China's marriage registrations fall by almost a million in 2024

World. China has reported a significant drop in marriage registrations for the first nine months of 2024, amidst efforts to control its declining population. According to the ministry of civil affairs, only 4.747 million couples got married in this period. This decline follows 5.690 million marriage registrations during the same period in 2023, marking a year-on-year decrease of 943,000 registrations, as calculated by Reuters.

The latest figures, released on Friday, show that rising living costs and economic uncertainty are causing many young couples to delay marriage. This poses a challenge for lawmakers looking to address the shrinking population. In response to the situation, China has updated a draft law to make marriage registration easier but has made it harder to get a divorce. For the first three quarters of 2024, 1.967 million divorces were registered, a slight decrease of 6,000 compared to the previous year.

Earlier this year, China experienced its second annual decline in births, prompting initiatives aimed at encouraging a "new-era" culture of marriage and childbearing. Many young Chinese people are choosing to stay single or delay marriage because of job uncertainties and worries about the future. Chinese President Xi Jinping stressed the role of women in creating a "new trend of family."

Mount Laki-Laki volcano erupts in Indonesia; 9 killed

World. Mount Lewotobi Laki-Laki volcano erupted in eastern Indonesia on Sunday, killing at least nine people, launching massive plumes of lava, and forcing authorities to evacuate several nearby villages, according to officials."After the eruption, there was a power outage, followed by heavy rain and intense lightning, which caused panic among residents," said Hadi Wijaya, a spokesperson for the Center for Volcanology and Geological Hazard Mitigation (PVMBG), adding that authorities had raised the volcano's status to Level IV, the highest alert level, as reported by Reuters news agency. Hadi said fiery lava and rocks hit the nearest settlements around four kilometre (two miles) from the crater, burning and damaging residents' houses. The agency recommended a seven-kilometre (4.35 miles) radius to be cleared."We have started evacuating residents since this morning to other villages located around 20 kms (13 miles) from the crater," Hadi said.By Monday morning, at least nine people had died and the nearest villages were covered by thick volcanic ash, according to Heronimus Lamawuran, a local



official in the East Flores area. Indonesia lies on the "Pacific Ring of Fire," a region of intense seismic

activity where multiple tectonic plates converge. The eruption comes amid a series of volcanic eruptions across Indonesia. In May, Mount Ibu on the remote island of Halmahera erupted, prompting evacuations from seven nearby villages.After torrential rain on May 11, flash floods and cold lava flows from Mount Marapi in West Sumatra province swept through several nearby districts, leaving more than 60 people dead.

The 2024 poll was initially a rematch of 2020. However, it was upended in July when President Biden ended his campaign and endorsed Vice President Harris. Now, she is gearing up to become America's first female president and the first woman of colour for the top job.For Trump, the scenario was completely different. In 2020, Trump was battling for re-election in a



year shaped by the Covid-19 pandemic Fast-forward to 2024, Trump is now seeking a rare comeback, with the baggage of a host of controversies and the label of becoming the first US president -- former or current -charged with criminal activity.KAMALA HARRIS: FROM VICE-PRESIDENT TO FIRST BLACK WOMAN RUNNING FOR **PRESIDENT**

In 2020, Kamala Harris, who is of Indian-Jamaican heritage, initially ran for the Democratic presidential nomination. However, Biden won the race and chose Harris as his running mate, calling her "a fearless fighter". She was

chosen not only for her extensive legal and legislative experience, but also as a symbol of hope and representation for the 47.9 million Black Americans.In the run-up to the 2020 polls, Harris focused on core messages of unity and rebuilding America post the Trump era, in contrast to the more divisive tone of the Trump campaign. She focused on rallying African

American and minority communities, particularly in key swing states.Criminal justice reform was a key plank of her campaign, defined by the years she spent as a California prosecutor. Harris's appeal to younger and diverse voters was key in Biden securing a win, albeit narrow, in key swing states.Cut to 2024, with only a short period of campaigning ahead of her after Biden withdrew from the race, Harris had no time to waste. Coming out of Biden's shadow, Harris has spent much of her time trying to differentiate her role as vice president from what she planned to do if elected.

Japanese nuclear reactor that restarted 13 years after Fukushima disaster is shut down again

TOKYO: A Japanese nuclear reactor that restarted last week for the first time in more than 13 years after it had survived a massive 2011 earthquake and tsunami that badly damaged the nearby Fukushima nuclear plant was shut down again Monday due to an equipment problem, its operator said.

The No. 2 reactor at the Onagawa nuclear power plant on Japan's northern coast was put back online on Oct. 29 and had been expected to start generating power in early November.

But it had to be shut down again five days after its restart due to a glitch that occurred Sunday in a device related to neutron data inside the reactor, plant operator Tohoku Electric Power Co. said.

The reactor was operating normally and there was no release of radiation into the environment, Tohoku Electric said. The utility said it decided to shut it down to re-examine equipment to address residents' safety concerns. No new date for a restart was given. The reactor is one of three at the Onagawa plant, which is 100 kilometers (62 miles) north of the Fukushima Daiichi plant where three reactors melted following a magnitude 9.0 earthquake and tsunami in March



Pakistan shuts primary schools for a week in Lahore due to dangerous air quality

quality on Monday forced Pakistani authorities in the cultural capital of Lahore to close primary schools for a week, government officials said, after the air-quality index hit a record high over the weekend. The measures in Lahore were part of a larger effort to protect children from respiratory-related and other diseases in the city of 14 million people. The government said everyone in Lahore was required to wear a face mask.Fifty percent of employees

must also work from home as part of a 'green lockdown" in the city, the government said, adding that parbecuing food without filters was banned and motorized rickshaws restricted. Wedding halls must close at 10 p.m. and artificial rain is likely to be



used to combat the pollution. The airquality index in Lahore exceeded 1,000 over the weekend, a record high in Pakistan. Toxic gray smog has sickened tens of thousands of people, mainly children and elderly people, since last month when the air quality started of eastern Punjab province bordering India. The government has also banned areas and fined owners of smoke-emitting vehicles. Schools will remain closed for a week because of the pollution, according to a government notification.

The concentration of PM 2.5, or tiny particulate matter, in the air approached 450, considered hazardous, the Punjab Environment Protection

Department said.Lahore was once known as a city of gardens, which were ubiquitous during the Mughal era from the 16th to 19th centuries. But rapid urbanization and surging population growth have left little room for 2011, releasing large amounts of radiation

maximize use of nuclear energy and is pushing to accelerate reactor restarts to secure a stable energy supply and meet its pledge to reach carbon neutrality by 2050. Concern about the government's revived push for nuclear energy grew after a magnitude 7.5 earthquake hit Japan's Noto Peninsula on Jan. 1, 2024. killing more than 400 people and damaging more than 100,000

Violent rhetoric to wooing Arab Americans: Trump, Harris make final pitches

North Carolina. Democrat Kamala Harris made her closing pitch for the US presidency at a historically Black church and to Arab Americans in battleground Michigan on Sunday, while her Republican rival Donald Trump embraced violent rhetoric at a rally in Pennsylvania. Opinion polls show the pair locked in a tight race, with Vice President Harris, 60, bolstered by strong support among female voters while former President Trump, 78, gains ground with Hispanic voters, especially men. Voters overall view both candidates unfavorably, according to Reuters/Ipsos polling, but that has not dissuaded them from casting ballots.More than 78 million Americans have already done so ahead of Tuesday's Election Day, according to the University of Florida's Election Lab, opens new tab, approaching half the total 160 million votes cast in 2020, in which US voter turnout was the highest in more than a century. Control of Congress is also up for grabs on Tuesday, with Republicans favored to capture a majority in the Senate while Democrats are seen as having an even chance of flipping Republicans' narrow majority in the House of Representatives. Presidents whose parties fail to control both

chambers have struggled to pass major legislation."In just two days we have the power to decide the fate of our nation for generations to come," Harris told parishioners at Greater Emmanuel Institutional Church of God in Christ in Detroit. "We must act. It's not enough to only pray; not enough to just talk."Later in a rally in East Lansing, Michigan, she addressed the state's 200,000 Arab Americans, starting her speech with a nod to civilian victims of Israel's wars in Gaza and Lebanon."This year has been difficult, given the scale of death and destruction in Gaza and given the civilian casualties and displacement in Lebanon, it is devastating. And as president, I will do everything in my power to end the war in Gaza," Harris said to applause.Many Arab and Muslim Americans as well as anti-war activist groups have condemned US support for Israel amid the tens of thousands of civilian deaths in Gaza and Lebanon, and the displacement of millions. Israel says it is targeting militant groups Hamas and Hezbollah.Trump visited Dearborn, Michigan, the heart of the Arab American community, on Friday and vowed to end the conflict in the Middle East without saying how.Instead of mentioning Trump by name, Harris



chose to highlight her opponent's record during her last Sunday on the campaign

TRUMP GOES OFF SCRIPT

Trump, at his first of three rallies on Sunday, frequently abandoned his teleprompter with off-the-cuff remarks in which he denounced opinion polls showing movement for Harris. He called Democrats a "demonic party," ridiculed Democratic President Joe Biden and talked about the high price of apples.

Trump, who survived an assassination attempt in July when a gunman's bullet grazed his ear in Butler, Pennsylvania, on Sunday complained to supporters about gaps in the bulletproof glass surrounding him as he spoke and mused that an

assassin would have to shoot through the news media to get him."To get me, somebody would have to shoot through the fake news and I don't mind that so much," said Trump, who has long criticized the media and sought to rile public sentiment against them.Last week he suggested prominent Republican critic, former congresswoman Liz Cheney, should face gunfire in combat over her hawkish foreign policy, leading an Arizona prosecutor to open an investigation.Campaign spokesperson Steven Cheung issued a statement saying Trump's comment was not directed toward the media but rather, "It was about threats against him that were spurred on by dangerous rhetoric from Democrats."Trump later spoke in Kinston, North Carolina, and in Macon, Georgia, where he seized on last week's jobs report that showed the US economy only produced 12,000 jobs last month. He told a large crowd gathered in an amphitheater that the report showed that the United States was a "nation in decline" and he warned darkly without evidence of a potentially looming repeat of the 1929 Great Depression with "people jumping off buildings."

Delay in procurement leaves paddy farmers on edge in Warangal

WARANGAL: Farmers in the erstwhile Warangal district have begun harvesting paddy crops, bringing large loads to procurement centres in their respective mandals. However, they are anxious about selling their produce, alleging that the district administration and Civil Supplies department are delaying purchases.

In Bayyaram mandal, farmers have left their crops soaked in rainwater at an Indira Kranthi Patham (IKP) centre.

They are worried about delays, as their crops are ready for weighing and transportation to rice mills. Despite the inauguration of procurement centres, operations are yet to start fully.

Local farmers feel that negligence on the part of the state government and officials has allowed private rice mills to purchase paddy without checking moisture levels, worsening their situation.

Farmer Bhukya Ramesh from Bhayyaram Mandal expressed frustration over the lack of government action to facilitate proper procurement. With recent rains damaging their crops, he urged officials to expedite the purchasing process.

AP to resume ferry services from Nagarjuna Sagar to Srisailam soon

KURNOOL: Days after the Telangana

Tourism Department resumed ferry services from Nagarjuna Sagar to Srisailam in the Krishna River, its counterpart in Andhra Pradesh is gearing up to launch a similar service soon.As part of the plan, the State Tourism Department will operate two boats -one with a seating capacity of 100 and another with 150. However, only one boat is likely to be operated in the first phase. Ticket prices for one-way trip have been fixed at Rs 2,000 for adults and Rs 1,600 for children, and Rs 3,000 for adults and Rs 2,400 for children for round trips. Speaking to TNIE, Andhra Pradesh Tourism Srisailam unit manager B Penchal Reddy explained, "Due to ample water in the Krishna River, the services will begin in early or mid-November."Further, he highlighted that while the Telangana government has introduced only the transport services, AP Tourism has added special tourism packages that include transport, temple visits and accommodation. He recalled that the services were suspended last year due to the lack of sufficient water in the river and reservoir. However, following the incessant rains this year, the Krishna River is abundantly filled.Penchal Reddy stated that the special trips from Srisailam to Akka Mahadevi caves located in the Nallamala forest range in Telangana will also be facilitated. He mentioned that the trip features a minimum of four-hour-travel to reach the caves from Pathalaganga in Srisailam.

Five boats set aside for ferry services The Telangana government has fixed ticket prices, including forest entry fee, at Rs 650 for adults and Rs 520 for children.

Rs 1.5 lakh crore steel plant to come up in Andhra's Anakapalle, create 70,000 jobs

VIJAYAWADA: An integrated steel plant with a capacity of 24 million metric tonnes per annum is set to be established at Nakkapalle in Anakapalle district with an investment of Rs 1.5 lakh crore. AM/NS India, a joint venture of ArcelorMittal and Japan's Nippon Steel, will set up the plant. It is expected to create nearly 70,000 direct and indirect jobs. A formal announcement is likely to be made after the State Cabinet, scheduled to convene next week, discusses the proposal. In a post on X, the TDP termed the project 'biggest investment in India'. As per a document accessed by the TNIE, besides the integrated steel plant, a proposal has been submitted for a co-terminus captive port with a total of 17 berths. The project will be taken up in two phases with an investment of Rs 11,198 crore. It will create a total of 8,000 jobs. In the first phase, five berths will be built with a total handling capacity of 20.5 MMPTA.

According to official sources, the proposal to establish a steel plant augurs well for Andhra Pradesh as the steel sector is only next to textiles in providing jobs. Further, they explained that representatives of AM/NS contacted IT and HRD Minister Nara Lokesh a couple of months ago, and proposed to set up the steel plant at Nakkapalle. They emphasised that the location was strategic considering the geographical locations such as the proximity to the coast, road connectivity via NH-16, rail link to Chennai Grand Trunk and adequate water sources from the Polavaram Left Main Canal. Sources explained that the steel plant will be set up in two phases. In the first phase, the plant will produce 7.3 million metric tonnes of stainless steel per annum. Its capacity will be expanded to 24 million metric tonnes per annum in the second phase.

The compassion and unity displayed by people throughout this ordeal have shown us that solidarity is not just a word but a way of life. Strangers became friends and entire communities rallied to offer food, shelter and support. We witnessed countless acts of selflessness from citizens risking their safety to aid stranded individuals and volunteers wading through flooded streets to deliver essentials. It is this very spirit that defines our resilience that is woven deeply into the fabric of Tamil Nadu.

Brewed risks: Excessive coffee triggers anxiety disorders, high BP

BENGALURU: Coffee, often seen as a productivity booster, is silently fuelling a rise in anxiety disorders, according to doctors. Many patients reporting anxiety symptoms have excessive caffeine consumption in common because in workplaces, where 'free coffee' is readily available, employees often overconsume without realising it, doctors said, linking this habit to various disorders, including heightened anxiety, insomnia, increased stress and even blood pressure. Medical experts mentioned that the city's strong coffee culture, paired with high-pressure work environments, is driving anxiety levels higher, with many unaware of the connection between their daily cups and rising stress. One of the studies in General Hospital Psychiatry, a monthly health journal, found that excessive caffeine consumption can worsen anxiety and even trigger panic attacks in individuals prone to anxiety disorders while another research in the American Journal of Clinical Nutrition linked high caffeine intake to increased blood pressure, which elevates the risk of cardiovascular disorders. Doctors highlighted that while consuming up to three-four cups or 400 mg of caffeine is generally safe, individual tolerance varies, and factors such as age, underlying health conditions, and caffeine sensitivity play a role. Pregnant women, specifically, should be cautious as excessive caffeine can increase the risks of miscarriage and low birth weight. Moreover, coffee intake also increases sugar consumption directly.

Edwina Raj, Head of Services, Clinical Nutrition and Dietetics, Aster CMI Hospital, highlighted that excessive consumption can lead to various side effects, including increased blood pressure and it can also interfere with the absorption of essential micronutrients, causing iron and zinc deficiencies.

Cochin Devaswom Board urges devaswoms to find new waste disposal solutions for Thrissur Pooram

THRISSUR: While a decision on the rent for Thekkinkadu Maidan to conduct the Thrissur Pooram Exhibition remains pending, the Cochin Devaswom Board (CDB) has urged the Thiruvambady and Paramekkavu devaswoms to find a solution for disposing of the waste generated during the Thrissur Pooram starting in 2025.In a fresh notice, the CDB made it clear that Pallithamam Ground will no longer be available for processing Pooram waste. Every year, the waste is removed from Thekkinkadu Maidan after the Pooram as a collective effort, with the Thrissur Corporation's sanitary staff, including Haritha Karma Sena, taking the lead. Normally, the CDB-owned Pallithamam Ground is used to segregate and later dump organic waste in a pit.At the same time, it is unclear whether any construction is planned for Pallithamam Ground. According to norms, it is the responsibility of the respective local body to manage the waste generated within its limits. With the CDB withdrawing its support for waste management, the "Will the CDB do the same to political parties that organize additional burden on the organizers.



devaswoms will now need to discuss this with the corporation and other stakeholders to arrive at a decision.

Bengaluru Rural police arrest Asha Sweets owner, experts flag manual scavenging worries

BENGALURU: Bengaluru Rural police arrested Mayur, owner of Asha Sweets, for the death of two men allegedly engaged in manual scavenging at the company's factory in Sompura Industrial Area in Bengaluru Rural district. This brings the number of arrests to three, including the subcontractor and site in charge. Investigations revealed that the company, which has about 18 outlets in the city, allegedly did not adhere to clearances and regulations from various departments, including the Karnataka State Pollution Control Board.

The incident is a reminder of the dangers of manual scavenging, which continues to claim lives and inflict trauma. The Karnataka government has also failed to conduct a mandatory survey that was to start in March 2024 and conude by

August 2024. The case also highlights the authorities' failure to enforce the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013. It is registered under Sections 7 and 9 of the Act, apart from BNS Section

105 -- culpable homicide not amounting to murder. Section 7 prohibits employing individuals as manual scavengers, while Section 9 mandates local authorities to provide alternative livelihoods and enforce prohibition.

A senior official with Karnataka State Commission for Safai Karamcharis told TNIE that officials were directed to identify manual scavengers in each district, and the delay in starting the survey is due to the ongoing rehabilitation of manual scavengers.

Advocate Basavaraj said failure to comply with these provisions exposes workers to exploitation and health risks. While there are thousands of registered manual scavengers, there are many others doing the same work without officially being employed, or involved in cleaning sewage treatment plants (STPs).

TN may talk to Kerala as Siruvani dam's level nears restricted limit

COIMBATORE: With water level in the Siruvani Dam inching towards the restricted reservoir level of 44.63 feet set by the Kerala water resources and irrigation department, Tamil Nadu Water Supply and Drainage (TWAD)board officials plan to request authorities to initiate negotiations with Kerala and stop it from discharging water as the dam is the main drinking water source for Coimbatore city. As on Sunday evening, water level in the dam stood at 44.3ft.Siruvani Dam, located deep inside the reserve forest of the Kalladikodan Hill and

People representatives still believe that constructing bus stops, erecting streetlights and visiting voters during deaths and marriage functions are developmental activities. They don't talk about the town's lack of public transport, wider roads, new bypasses to ease congestion, proper sports recreation facilities or even a standard crematorium," pointed out A V Gopinath, former MLA and former DCC president.

The stadium bus stand, indoor stadium, reconstruction of the town hall, development of parks, etc., are all demands that have remained unaddressed. "Unlike in other towns or major constituencies in Kerala, there are no efforts in Palakkad to constitute a town development authority or expert committee to list out the advantages, opportunities, shortfalls in the constituency. In fact all the so-called developments are carried out only for the benefit of some monopoly establishments and individuals," said Palakkad United Merchants Association president Joby Chungath.

Muthikulam Hill in Palakkad district, is among the major sources of drinking water for Coimbatore city. The Kerala government has not allowed the water level to reach the FRL (full reservoir level) of 50 ft in the last nine years, allegedly citing safety of the structure as a concern.

Of Coimbatore city's total drinking water requirement of 265 MLD, 101.40 MLD is supplied by the Siruvani Dam. As per an agreement that was entered into by the Tamil Nadu and Kerala governments on August 19, 1973, Kerala should supply 1.30 TMC annually (July 1 to June 30) to the erstwhile Coimbatore Municipal Town for 99 years. The Kerala irrigation department is maintaining the water level in Siruvani Dam at a restricted reservoir level of 877.00m (44.61ft) instead of the FRL of 878.50m (49.53ft) as stipulated in the interstate agreement. Lowering the water level by 1.5m results in a shortage of 122.05 MCFT of water, which is 19% of the total storage. This creates difficulties in catering to the needs of Coimbatore city during summer.

Sources from TWAD, Siruvani division, told TNIE, "The dam is receiving good inflow thanks to incessant rainfall in the catchment areas. We shall intimate our higher officials to hold high-level talks with Kerala government to prevent it from releasing water once the level reaches 44.61 ft."

Food for thought from fauji kitchen

We are today grappling with intolerance, divisive narratives and trumped-up 'fassad' (tension/violence), mischievously described as 'food jihad'. Coupled with this is the advocacy for vegetarianism and forced abstention during specified periods, disregarding dietary preferences and livelihoods. As a disclaimer, having grown up in Rajasthan, I am to a great extent an "exception-tarian", or one who imbibes non-vegetarian food but only occasionally. Fauj did make me a "mauka-tarian", enjoying whatever is served with love, and in good faith.

My first experiment in culinary re-ordering was as the second-in-command, 63 Cavalry. A forced bachelor who would dine in the mess, I pointed out the skewed menu with a daily overdose of non-vegetarian dishes. I called for adhering to the age-old tradition of a chana-bhatura lunch on Tuesday and South Indian fare for the Sunday brunch. I was surprised to see the dining members ladling out pickle from jars with chana bhatura. We had three new pickles — chicken, mutton and pork! Pickle being an essential accompaniment, I was stumped. I simply gave up when they served keema dosa on SundayThe second effort was in trying to post our Sikh cook, Chanan Singh, from the headquarter squadron to the Sikh squadron and to move Mohanan, a South Indian, to the headquarters. The Sikh soldiers, having got addicted to Mohanan's tadkas, were literally up in arms and simply refused to part with him

When my wife Anita joined me, all married officers were invited for the much-awaited party. Unknown to us, the bachelors had taken the licence to shoot vermin. Shakeel served us the most relished pork chops. When I told him that he need not serve it, it was humbling to hear his response: "I am the host, you love it and I don't eat it."During another tenure, the mess cook in the Brigade headquarters, lovingly called Pandeyji, dished out the most delicious mutton rogan josh despite being a staunch vegetarian himself. In the same Brigade, we had the elite 18 Cavalry with three squadrons (equivalent of a company). Alpha squadron comprised Jats, who can drink but not eat mutton as per the squadron norms, though some did it surreptitiously. Bravo had Hindustani Muslims (HM). They eat their halal meat and are



not permitted alcohol. The Charlie squadron was of Rajputs, who were allowed both meat (but only jhatka) and drinks. The roof of the langar (cook house) of the Jats collapsed and they chose to set up a temporary langar with the Muslims.

Meat goes with rum so the Army issued it on meat days. As the Brigade Major, I was in the shared langar and a bit worried. The good old Muslim senior JCO walked up to me and, as if anticipating my thoughts, told me: "Sahib, don't worry, no Jat will be allowed to consume meat in our langar and break his dharma, but I can't guarantee about the headquarter squadron." The headquarter has a mixed, all castes' staffing on a deputation basis and some Jats do consume mutton there. The wise JCO's parting words still ring in my ears, "After all, we follow deen-imaan and dharma."I wish all of us could be true to ourselves, and let others be -to each his own. There's much food for thought

Tiger reserves and the arduous task of conservation

Return to pre-Galwan patrolling protocols is a prerequisite for satisfactory disengagement

The year was 1985. The late Shyam Sunder, then head of the Karnataka Forest Department, was camping in the Shettihalli forest resthouse of the Shivamogga division, deep inside the Western Ghats. As Deputy Conservator of Forests, Shivamogga, I accompanied him, along with the Conservator of Forests, for a field visit and camping. The resthouse had only two rooms. After dinner, I left for another resthouse at Sirigere, 15 km away. My half-an-hour journey was through a magnificent forest. No human, livestock, stray dog or wild animal was encountered on the way. The next morning, however, while returning on the same route to Shettihalli, my driver and I sighted a tiger crossing the road, 50 metres ahead of us. Spellbound, we watched the tiger for 10-15 seconds till it disappeared in the jungle. When I shared this experience with my seniors, they were thrilled. They said sighting a tiger was uncommon and many forest officers had retired without sighting a tiger in their entire service. With the help of state forest departments, an all-India tiger census was regularly carried out. Tiger numbers were assessed on the basis of pugmarks. States showed growth in numbers until the early 2000s, when it was found that the entire census was flawed and some departments had reported more tigers than they actually had. Tiger states came under heavy criticism and the Central government took strict action. The National Tiger Conservation Authority (NTCA) was constituted and the Wildlife (Protection) Act, 1972, amended in 2006. It coordinated with states to take legal and administrative action to revive the tiger numbers. Anti-poaching camps were established inside forests, staff were upskilled and legal training and assistance provided to ensure that the poachers who hunted tigers for skin and body parts were brought to justice. More forest areas were brought under the purview of the NTCA. Nine areas, originally included under Project Tiger in 1973, covering nearly 16,000 sq km, were increased to 53 tiger reserves (TRs) in 2024, covering approximately 75,000 sq km. The methodology for tiger estimation, which was earlier based on pugmark count, was made more robust by Dr Rajesh Gopal, who was member secretary, NTCA, from its establishment till 2014, with the assistance of scientists of the Wildlife Institute of India. The new methodology involved eight days' field protocol in all tiger-bearing forests, putting in use new data-gathering techniques. The




methodology is peer-reviewed globally and published in leading scientific journals. Using this methodology, the tiger number in the country, which was reported to be 10,000 in 2002, was found to be 1,411 in 2006. Thereafter, estimation was done every four years. The tiger numbers started growing – 1,710 in 2010, 2,226 in 2014, 2,967 in 2018 and 3,682 in 2022. The most worrying part has been the loss of area under tiger occupancy. Anthropogenic pressure, diversion of forests for infrastructure and mining projects, encroachment and forest fires account for rapid degradation and fragmentation of tiger habitats and the tigers do not survive in humandominated areas. This is the reason why the NTCA focuses on the relocation of families from the core areas of the tiger reserves. Though it is a long-drawn process and the Forest Rights Act, 2006, has come in the way, relocation of families is still progressing at a slow pace. Relocation of tribal families from core areas of TRs is done after taking their consent. The package is quite attractive; all male members above 18 years constitute a family and were provided Rs 10 lakh, which has been revised to Rs 15 lakh from 2018. The families not opting for cash had another

option and were provided agriculture land, houses and cash (20 per cent of the whole package) and relocated. While working as Chief Wildlife Warden, Karnataka, in 2010-11, I could relocate 19 out of 25 families in a tribal hamlet named Dalimbe Kolli in Nagarhole TR. Six families who did not give their consent were left out. It became difficult for the state to provide them the basic necessities like piped water, electricity, hospital and school. The families are now repenting. The state is also in a dilemma as the families have grown to 20 in number and there are cost overruns.

Tiger is a territorial animal and has to fight another tiger to gain territory. As habitats are lost, fragmented tigers get pushed out of the reserves and are exposed to human areas. They have to depend on livestock for prey, which is detrimental to both humans and tigers. Conservation efforts get a setback if human lives/livestock are lost. Often tigers are poisoned/shot by humans. The best forests in the country are notified and included in tiger reserves. We need to conserve tiger reserves for our own welfare as vast stretches of the forests provide origin and catchment of rivers.

Mid-air mess in HP

Strictly regulate paragliding to ensure safety



Paragliding is a popular adventure sport in Himachal, but the safety of fliers has been a matter of concern. Untrained

pilots and unregistered private paragliding schools - these are key factors that endanger the lives of paragliders. No guidelines have been laid down to regulate paragliding schools in the state. The state Tourism Department has worsened the mess by failing to make a government-funded paragliding school operational at Bir-Billing, even three years after it was set up at a cost of Rs 8 crore.

Attributing the mishaps solely to the recklessness of fliers reflects an evasive attitude. Paragliding should be suspended till foolproof security measures are put in place. There is a need to weed out unprofessional and unauthorised persons involved in this sport, for at stake is Bir-Billing's reputation as a paragliding paradise. Hosting the World Cup is a big achievement, but it's more important to work on improving flier safety throughout the year. All stakeholders must take urgent steps to ensure that the mid-air thrills

eclipse the perils.

GOOD SPORT: The very essence of life

Lessons from sportspersons must be learnt so that we become better at what we do

Everything in this life has a beginning and an end -Rafael Nadal's plain words, uttered when he announced his retirement recently, may appear far too trite, even banal, to mark the end of the greatest era in men's tennis, but they contain the essence of life. The greatest sportspersons do self-realisation the best; few people assess themselves with such brutal — vet clinical and forensic — honesty as, say, Rafael Nadal. "He was much better than me," Nadal would say after a loss; after a particularly bad show, he'd just say: "I did a disaster." Press conferences with sportspersons are exercises in banalities, but players such as Nadal, combining sensibility and rationality and honesty, provided nuggets of wisdom that contain life lessons for us mortals. Sportspersons are possibly the only professionals who try to improve their skills every day of their life; for this, they must be brutally honest with themselves — they must confront their faults, their weaknesses. On the other hand, most of us mortals, mired in careerism and an inflated sense of the self, can't even see our faults.

Eighteen and ebullient in 1989, Viswanathan Anand was the young tiger, ready to take on the world, for which he saw "thrilling possibilities" for himself. Fifty-five next month, Anand has run his race, he's made his reputation. Anand took on the world in an online chess game last week — and beat over 60,000 opponents. Chess — not even a sport, and certainly not a game that runs on adrenaline — appears to be ideal for the aged. But professional chess champions are young — Kasparov and Carlsen became world champions at 22, Karpov at 23; Ding Liren is something of an oddity, winning the crown at 31. His challenger, D Gukesh, is 18, and Arjun Erigaisi 21. Anand is ancient, but he's still the world No. 10 — Gukesh and Erigaisi are the other Indians in the top 10. Anand became the champion of the world in his



as the organisers of the November 2-9 World Cup,

which will feature participants from around 50 countries.

late 30s; Gukesh could well become a teenaged champion. Chess great Viswanathan Anand was the India No. 1 for close to four decades; when this writer asked him about the prospect of being deposed by players young enough to be his sons, Anand just laughed philosophically and said everything must end. Indeed. Nadal and Anand — and Virat Kohli, Rohit Sharma and Ravichandran Ashwin — would succumb to the vagaries of time; the spirit is willing but the flesh is weak, and even the spirit begins to waver with the passage of time.

Ashwin is 38, Rohit will turn 38 next year, Kohli will be 36 next week. The road ahead for them is much shorter than the road travelled — we're seeing the end of a golden era, during which India achieved possibly their greatest feat in Test cricket: two consecutive series wins in Australia. It doesn't get better than that. Now they've lost a Test cricket series at home after 12 years, and for the first time ever to New Zealand—the end of the greats is nigh.

In football, there was an end of an era, too — neither Lionel Messi nor Cristiano Ronaldo was nominated for the prestigious Ballon d'Or, presented to the best footballer in the world; the two had won the award 13 times in the last 16 years — eight for Messi, five for Ronaldo. The award this time went to Rodrigo Hernandez, a man who had admitted to his own frailties as "the lame one who never did anything"

during his days in university.

Rani Rampal, former India hockey captain, too, has life lessons for us — daughter of a cart-puller who earned Rs 80 a day, the girl who was rejected by a districtlevel coach for being malnourished, has gracefully walked away from the sport: "It's time for me to step off the field as a player and begin a new chapter... Hockey has been my passion, my life, and the greatest honour I could ever have asked for.'



Jamiat cautions TDP, JD(U), says even 'crutches' will not escape responsibility if Waqf bill passed

How a war 4,000km afar is fuelling a farm fire in Haryana

A war 4,000 kilometres away has got farmers in several districts of Haryana protesting. It is because of the Israel-Hamas war and its ripple effects on the Red Sea routes that has resulted in a big shortage of di-ammonium phosphate (DAP), a crucial fertiliser, before sowing of Rabi crops.

New Delhi: A group of farmers in Haryana's Sirsa blocked a city road, creating a long traffic jam on Sunday. They were demanding that they be provided with di-ammonium phosphate (DAP), a fertiliser crucial for sowing of Rabi crops like wheat and mustard. The shortage of fertiliser supply that has hit Haryana villages is because our interconnected world is a global village. A war 4,000 km away is one of the key reasons that is choking fertiliser supply to farmers in India.Last week, several districts in Haryana saw long queues of farmers at fertiliser distribution centres, with police being deployed to control any untoward situation. Congress MP Kumari Selja claimed that police lathicharged a group of farmers. As the Rabi season commences in India, farmers in Haryana, and states like Punjab, are grappling with a severe crisis that has its roots in the ongoing war in Eastern Europe and West Asia, particularly the Red Sea region.

The year-long war between Israel and Hamas has severely disrupted the global supply chain of diammonium phosphate (DAP) fertiliser, leading to a significant shortage in India.India, which primarily depends on imports for this essential fertiliser, is now facing an acute shortfall.

Here's a look at how the geopolitical turmoil and bloodbath, thousands of kilometres away, has resulted in a shortage of DAP and farming woes. While an estimated 1,139 people were killed in Israel, Palestinian health authorities say Israeli offensives have killed more than 41,500 people, since October 2023. Earlier in 2022 and 2023, the ongoing Russia-Ukraine war had also led to DAP shortages in India.

WHY DAP IS IMPORTANT FERTILISER FOR HARYANA FARMERS

DAP fertiliser, a vital one for Indian farmers in northern states like Haryana, Punjab and Uttar Pradesh, contains phosphorus, an essential nutrient for several key crops. It also fulfils the initial need for nitrogen and sulphur in the crops.DAP provides critical nutrients for crops such as wheat and mustard, that are usually sowed during the months of October and November."Every year, India consumes approximately 100 lakh tonnes of DAP, with the majority being met through imports," says Om Prakash, an agriculture expert with Kisan Tak, India Today Digital's sister media platform.

Indians spending more on premium shoes: ASICS head

NEW DELHI. Indians are spending more on shoes with the average price point increasing 10-15% in the last one year, said Rajat Khurana, Managing Director, ASICS India and South Asia. The Japanese sportswear brand, which competes with Adidas and Nike, has 111 outlets across the country and expects this number to go up to 200 by 2026.

"The average price point of our shoes when I compare it with 2023 has increased by 10-15% despite no major uptick in retail prices. It is consumers who are shifting to the premium segment," Khurana told TNIE.

Bullish on India, ASICS expects its sales here to grow by 26-27% in 2024 and then at a CAGR of 30% over the next 3 years. "The global management believes in India, because of its growing population, high disposable income and growing culture for fitness," Khurana, adding it is a very promising market.

The MD also informed that ASICS has now achieved 30% local sourcing norms and as per existing FDI norms they can now open company-owned outlets here. The first of such outlets will come in the next 24 months. "We plan to take localisation to 35-40% in the next 2-3 years. This 30% of the production caters to the leave to the modium price point and our more the low to the medium price point and our more premium products are still imported. We hope India will soon get the technology to produce high-end shoes," said Khurana.He added that they won't be shoes," said Khurana. He added that they won't be increasing their prices in tandem with an expected GST rate hike. The Group of Ministers (GoM) recently proposed to increase the GST rate on shoes costing over R15,000 from 18% to 28%. "If the proposal is implemented, we will take some hit and not pass all the price hikes to the consumers. Our lowest price point is R4,999 and goes as high as R21,999," he said. On demand coming from tier 2 and tier 3 cities. Khurana said that he could have never tier 3 cities, Khurana said that he could have never imagined 9 years back getting such a strong demand beyond metro cities. About 60% of ASICS stores opened in the last one year are in tier 2 and tier 3 cities. Khurana also said that performance-oriented running

shoes are growing at a faster pace than the industry and account for 55% of their total sales. The company recently reintroduced the SportStyle Skyhand OG sneakers after a gap of 30 years to increase its presence in the sneaker segment.

40% surge in car deliveries during festive season fuels strong demand

NEW DELHI. Car deliveries surged by 40 percent this festive season, with a notable increase in light motor vehicles, including cars and SUVs, sold in October.

As per the industry data, the spike highlights a significant rise in consumer demand for fourwheelers during the festive period, despite a modest year-on-year growth of just 1.8 per cent in the broader passenger vehicle sector, which recorded a total of 401,447 units. Industry insiders attribute the restrained growth in overall numbers to several carmakers deliberately limiting production to keep inventories balanced. The data underscores a notable shift in consumer preference towards four-wheelers, particularly during festive seasons, a trend that manufacturers and dealers may strategically leverage moving forward.Key cities like Bangalore, NCR, Hyderabad, and Pune saw substantial demand, with consumer preferences increasingly leaning towards automatic cars, SUVs, and flexible financing options--choices that align well with festive buying sentiments. According to Spinny data, automatic vehicle deliveries, for instance, rose by 57 per cent, reflecting a growing preference for convenienceoriented purchases. Meanwhile, Spinny's exchange program saw a 39 per cent increase as more buyers opted to trade in their older vehicles for newer models, a trend particularly prominent during Dhanteras as consumers embrace the tradition of upgrading assets. Petrol vehicles remained dominant, with a 50 per cent surge in demand, while SUVs and sedans experienced robust growth of 49 per cent and 46 per cent, respectively.

TGI Fridays ops in India unlikely to be impacted by US bankruptcy proceedings



NEW DELHI. Even as TGI Fridays Inc has filed for Chapter 11 bankruptcy in the US, its India operations may remain unaffected. The US-based company in a press statement has said that TGI Fridays has franchised the brand to 56 franchisees in 41 countries, and all these franchise locations, both domestic and international, are independently owned and therefore not included in TGI Fridays Inc's Chapter 11 process. They are open and serving customers as usual, reiterated the company in a press

'To ensure continuity of service to franchisees, TGI Fridays Franchisor, LLC has negotiated a Transition Services Agreement with – and provided interim funding to – TGI Fridays Inc to maintain support services for franchisees while TGI Fridays Franchisor, LLC works to implement a new longterm support structure," the company said.

On Saturday, it filed voluntary petitions under Chapter 11 of the US Bankruptcy Code in the Northern District of Texas. According to a statement issued by the company, it expects to use the time and legal protections made available through the Chapter 11 restructuring process to allow the company to explore strategic alternatives in order to ensure the long-term viability of the brand. The Company has secured a commitment for debtor-in-possession financing to support operations while proceeding through the Chapter 11 process.

It also filed motions with the Bankruptcy Court that, when approved, will allow the company to, among other things, continue its customer programs in the normal course. These motions are typical of the Chapter 11 process and are expected to be heard approved in the first days of the case.

Around 12:15 pm, the shares were up 9.49% at Rs 1,599.70, giving Azad Engineering a market capitalization of Rs 9,450

In a filing to the stock exchanges, the company confirmed it has signed a Long-Term Contract and Price Agreement (LTCPA) with Mitsubishi Heavy Industries, Japan. This contract involves supplying complex rotating and stationary airfoils for gas and thermal power turbine engines, addressing the increasing global demand in the power generation

industry. The current phase of the



contract is valued at approximately USD 82.89 million (Rs 700 crore) and is expected to strengthen the strategic relationship between the two companies. Azad Engineering debuted on the stock market in December 2023, launching at Rs 720 on the National Stock Exchange (NSE) and Rs 710 on the BSE, compared to an issue price of Rs 524. Since then, the stock has

increased nearly 220%. However, it has also faced a correction of about 20% from its 52-week high of Rs 2,080, reached in June. Analysts estimate an average target price of Rs 2,150 for the stock, indicating a potential upside of 34% from current levels. The consensus among two analysts is a 'Strong Buy recommendation

However, good financial habits can help you overcome the hurdle of learning complicated financial knowledge. Solid financial knowledge can do you no wrong. But, if you are new to investing and uninterested in learning about finance, you must focus on your actions. Those are things you can control. Many of you already do that by hanging on to tangible assets like real estate and gold. For a long time, it has been an issue of debate whether gold is an investment. The long-term returns on gold have been similar to those in the Sensex or Nifty over 20-year phases. That is a significant achievement for the precious metal as the global consumer and institutional demand remains strong. It is a natural hedge you use against inflation. That has rewarded Indian households estimated to have nearly 27,000 tonnes of the yellow metal. The value of that gold is nearly \$ 3 trillion at current prices. It is more than half the value of all shares traded on the Bombay Stock Exchange or the National Stock Exchange. Despite all that household hoarding, it is not a liquid investment. It is an asset with a lot of emotions attached. Most of you like to keep that gold in the form of jewellery that you sell or mortgage only in case of an emergency. Households are seen using gold for short-term loans. The rise of companies that offer only gold loans and their stock market success is a testimony to that behaviour. The dramatic surge in gold prices could also be due to the geopolitical risk due to international wars. At the same time, equity asset prices are record-high in many markets despite relatively slow growth. There is a perception of a risk of a sharp fall eventually. Fear is pushing many towards gold. Despite similar returns over 20-year phases, the price trajectory is not similar for gold and shares. It may be a good idea to split your investments into equity.

NEW DELHI Domestic investors were in Concerns mounted amid a volatile for a shock on Monday as stock markets declined sharply due to a mix of factors, especially persistent selling by foreign investors. The BSE Sensex dropped 1,433.61 points, to 78,290.51 at 11:15 am, resulting in a total market capitalisation loss of over Rs 8 lakh crore. The Nifty50 also fell sharply, down 458.45 points to 23,845.90 and most of the other broader market indices also tumbled sharply, leading to a bloodbath on Dalal Street.Major contributors to the decline included Reliance Industries, Infosys, ICICI Bank, HDFC Bank, and Sun Pharma, collectively accounting for a 420-point drop on the Sensex. Other significant laggards included L&T, Axis Bank, TCS, and Tata Motors. Sectoral indices for Nifty Bank, Auto, Financial Services, IT, Pharma, Metal, Realty, Consumer Durables, and Oil & Gas experienced declines ranging from 0.5% to 1.7%. Meanwhile, the India VIX, a gauge of market volatility, surged 5.2% to 16.73.

prompting foreign institutional investors (FIIs) to offload Indian stocks. Vijayakumar said, "The Indian market is grappling with headwinds from decelerating earnings growth. Nifty EPS growth, as indicated by Q2 results, may dip below 10% in FY25, making current valuations difficult to sustain. FIIs may continue to sell in this challenging earnings growth environment, restricting any market rallies."Rising oil prices: Oil prices surged by more than \$1 during early trading on Monday, following OPEC+'s announcement of a delay in a planned December output hike due to soft demand and increasing supply from outside the group.

Babar tried to go on to the backfoot to a ball that wasn't overly short and was beaten all ends up. He went for a flick, but saw his stumps rattled.Babar was also involved in a partnership of 39 runs for the third wicket with Mohammad Rizwan, the newlyappointed skipper of the Pakistan whiteball team. With Babar's dismissal, Pakistan lost their third wicket with 63 on the board in 17.4 overs.

Babar recently lost his place in the national Test team when Pakistan faced England in the three-match ODI series. Babar will be expected to score big in the last two ODIs in Adelaide and Perth.

Sunil Gavaskar urges India to play warm up game before Australia Test series

For the Yashasvi Jaiswals, the Sarfaraz Khans, the Dhruv Jurels, all these young batters. Even against an Australia A team or a state side like Queensland. Juniors must be given the opportunity to get used to the bounce and pitches in Australia," Gavaskar told Indian Express.Further speaking ahead, Gavaskar advised India to practice as much as they can and focus on playing regular bowling instead of throw downs.

Spooked by turn: Once India's strength, spin is now their kryptonite

India vs New Zealand: Indian batters can no longer dominate spin. By preparing rank-turners, India have been shooting themselves in their foot. The 0-3 humiliation in the recentlyconcluded home Test series raises concerning questions.

New Delhi. Spin to win" is no longer India's mantra at home. Whenever they have rolled out spin-friendly track, leave alone dust bowls, it has often been India who found themselves in trouble. This was starkly evident when New Zealand stunned India in Pune and Mumbai after initially troubling Rohit Sharma's men with pace in Bengaluru.A 3-0 result in favor of Indiaseemed like a foregone conclusion. Few could have imagined that New Zealand would inflict a whitewash on Indian soil.India's proud record of 18 successive Barring Rishabh Pant, no Indian batter scored series victories at home came to a sudden halt in one of the most sensational ways. The hunters became the hunted, as a resilient

group of New Zealand cricketers outperformed their Indian counterparts in every department of the game. One glaring deficiency was India's handling of spin. Over the past few years, it has been an open secret that India's dominance in spinfriendly conditions is fading-a reality that the Indian team management has been reluctant to fully acknowledge."There is a misconception that India is good at playing spin. They are like everyone else. Gone are the days of Sachin, Ganguly, or Dravid. Now, they struggle against good spinners. We saw that in the IPL; as soon as the ball started to spin, they began to falter," said former New Zealand bowler Simon Doull after the second Test in Pune.Before examining historical data, recent numbers from the three-Test series tell a compelling

... The Indian Premier League (IPL) mega auction is tentatively scheduled for November 24 and 25 in Saudi Arabia, though an official confirmation from the **Board of Control for Cricket in** India (BCCI) is still awaited.

New Delhi. The Indian Premier League (IPL) 2025 mega auction is expected to take place on November 24 and 25 in Rivadh, Saudi Arabia. Although the Board of Control for Cricket in India (BCCI) has yet to officially confirm the location or dates, sources indicate that final arrangements are in progress and an announcement is anticipated soon. However, scheduling complications have arisen, as the auction dates coincide with India's first Test match against Australia in Perth, set for November 22 to 26. Disney Star, which holds the broadcast rights for both the IPL and the India-



Australia Test series, is keen to avoid a direct overlap between the events. Thankfully, due to the time difference with Australia, the auction, if held in the afternoon (IST), would likely avoid clashes with the match broadcast.

With the IPL 2025 mega auction around the corner, anticipation is high as franchises prepare to make pivotal bids on high-profile players. Among the standout names are Rishabh Pant, Shreyas Iyer, KL Rahul, Arshdeep Singh, and Ishan Kishan, each renowned for their impact in the T20 format. These players bring a mix of batting prowess, leadership qualities, and sharp fielding, making them invaluable assets for any franchise aiming for a strong 2025 season. While several franchises have

already declared their retentions, these five players will undoubtedly be at the center of intense bidding wars. Teams are strategizing to secure the best players within their budget, and these star players are likely to command some of the highest prices. Pant's explosive wicketkeepingbatsman role, Iyer's dynamic leadership potential, and Rahul's consistency with the bat are especially appealing attributes in a fast-paced tournament like the IPL.Reports suggest that BCCI officials have already conducted preliminary visits

to Saudi Arabia to assess potential venues. A second delegation is expected to travel to the Gulf nation on Monday to finalize details. While Jeddah was initially considered, Riyadh, the capital, has emerged as the most likely host city for the two-day auction. The BCCI also explored other international locations like Dubai, Singapore, and even Vienna, but Saudi Arabia appears to have been selected as the ideal venue.

Given this move outside India, IPL franchises are urging the BCCI to finalize the venue and dates promptly to allow enough time for travel and logistical arrangements. With a retention deadline of October 31, teams are working to finalize their player lists before shifting focus to the upcoming auction.

Liverpool defender Ibrahima Konate downplays injury, says he won't miss game time

New Delhi. Liverpool's Ibrahima Konaté has reassured fans that the injury he sustained during the team's recent 2-1 victory over Brighton & Hove Albion will not keep him sidelined. The 25-year-old French international was substituted at halftime after suffering a knock to his arm but has since downplayed concerns over his fitness, confirming that he will be fit to play in Liverpool's next match.Konaté's injury initially raised fears of a serious issue, as he was taken off and replaced by Joe Gomez at the interval. However, following a medical scan on Sunday, Konaté shared a positive update on social media. "Thanks for all the messages of support. My injury isn't serious thankfully. I had a scan today and it confirmed there is no break. I'll be ready for the next game," he posted on Instagram, much to the relief of Liverpool fans.

The injury incident, which appeared to occur



after teammate Virgil van Dijk inadvertently stepped on Konaté's arm in a crowded goalmouth scramble, led to speculation of a potential fracture. However, sports physios have suggested that it may only be a minor bone bruise. "The recovery time for this would be less than a week," speculated a physio on social media, adding that Liverpool's medical team would likely monitor Konaté closely to avoid aggravating the injury. With Liverpool already managing a number of injuries, including those of Alisson Becker, Conor Bradley, Harvey Elliott, Diogo Jota, and Federico Chiesa, the news of Konaté's availability will be a welcome boost for the club as they prepare for their upcoming Champions League match against Bayer Leverkusen on Tuesday. This will be followed by a crucial Premier League clash with Aston Villa at Anfield on Saturday.

While Konaté has expressed his eagerness to play, Liverpool's medical team may still choose to exercise caution given his history with injuries. The team has depth in the form of Joe Gomez and promising youngster Jarell Quansah, who are both prepared to step in if Konaté's wrist requires further recovery time.

Aamir Khan Knows 'Nothing' About Son Azad's School, Reveals Kiran Rao: 'He Is A Very Busy Father'


