

disruptions in Indian Parliament Sanjay Kumar

New Delhi, Nov. 26: The US State Department refused to comment on the disruptions in Indian Parliament over the indictment of billionaire Gautam Adani in a US court on charges of bribery. "That is a law matter," enforcement State Department Spokesperson Matthew Miller told reporters at his daily news conference on Monday. He was responding to a question about Leader of Opposition in Lok Sabha Rahul Gandhi demanding the immediate arrest of Adani. "Is this something you support, such as the arrest and investigations, charges against Adani" he was asked. "I would defer to my colleagues at the Department of Justice to speak to it," Miller said. The US authorities have indicted Gautam Adani and seven others including his nephew Sagar Adani, for being part of an alleged USD 265 million bribery scheme. Lok Sabha and Rajya Sabha proceedings were adjourned for the day on Monday as opposition parties led by Gandhi's Congress tried to raise the issue of Adani's indictment. Last week, a five-count criminal indict-

ment was unsealed in federal court in Brooklyn charging Gautam Adani, Sagar Adani and Vneet Jaain, executives of an Indian renewable-energy company with conspiracies to commit securities and wire fraud and substantive securities fraud for their roles in a multi-billion-dollar scheme This was done to obtain funds from US investors and global financial institutions on the basis of false and misleading statements. The indictment also charges Ranjit Gupta and Rupesh Agarwal, former executives of a renewable-energy company with securities that had traded on the New York Stock Exchange. It charges Cyril Cabanes, Saurabh Agarwal and Deepak Malhotra, former employees of a Canadian institutional investor, with conspiracy to violate the Foreign Corrupt Practices Act in connection with a bribery scheme also perpetrat ed by Gautam Adani, Sagar Adani and Jaain involving one of the world's largest solar energy projects. The indictment further alleged that Cabanes, Saurabh, Malhotra and Rupesh conspired to obstruct the grand jury, FBI and US SEC investiga-

tions into the Bribery Scheme.

socialist democratic republic," he said. Justice, liberty, equality and fraternity are not just ideals or ideas, they are the way of life for 140 crore Indians, Kharge asserted. "Today, we recall the tremendous contribution of the Constituent Assembly and its prolific members. We are forever indebted to their

foremothers and forefathers is the lifeblood of our vision and wisdom," he said. Kharge said Pandit Jawaharlal Nehru, Babasaheb Dr BR Ambedkar, Sardar Vallabhbhai Patel, Maulana Abul Kalam

Azad, Dr Rajendra Prasad, KM Munshi, Sarojini Naidu, Alladi Krishnaswamy Ayyar, Rajkumari Amrit Kaur and several eminent personalities were not just revered national icons but inspiring personalities who became the torchbearers of hope for generations together. Supreme Court rejects plea for reverting to ballots in elections

New Delhi, Nov. 26: The Supreme Court on Tuesday dismissed a petition seeking to revert to ballot paper voting in elections in the coun-

try. "What happens is, when you win the election, EVMs (electronic voting machine) are not tampered. When you lose the election, EVMs are tampered (with), remarked a bench of Justices Vikram Nath and P B Varale. Apart from ballot paper voting, the plea sought several directions including a directive to the Election Commission to disqualify candidates for a minimum of five years if found guilty of distributing money, liquor or other material inducement to the voters during polls. When petitioner-in-person K A Paul said he filed the PIL, the bench said, "You have interesting PILs. How do you get these brilliant ideas?". The petitioner said he is the president of an organisation which has rescued over three lakh orphans and 40 lakh

widows. "Why are you getting into this political arena? Your area of work is very different," the bench retorted. After Paul revealed he had been to over 150 countries, the bench asked him whether each of the nations had ballot

Eknath Shinde resigns, Governor asks him to act as caretaker Chief Minister

Mumbai, Nov. 26: Maharashtra Chief Minister Eknath Shinde on Tuesday morning met Governor C P Radhakrishnan here and tendered his resignation following the results of the assembly elections. The governor asked



Shinde to act as a caretaker chief minister till the new CM is sworn in, as suspense continues over who would be the ruling Mahayuti coalition's choice for the post following its landslide victory. Shinde was accompanied by deputy Chief Ministers Devendra Fadnavis and Ajit Pawar as he visited the Raj Bhavan. The term of the outgoing Maharashtra assembly ends on November 26. Deepak Kesarkar, who served as a minister in the Eknath Shinde cabinet, told reporters, "The chief minister has tendered his resignation. The governor has asked him to act

> as a caretaker chief minister." To a question, Kesarkar said the new government will be sworn in at the earliest. Despite the Mahayuti alliance of the BJP, Shinde-led Shiv Sena and Ajit Pawar's NCP securing a massive victory, winning 230 seats in the 288-member assembly, consensus has eluded the ruling combine's leaders so far on who should be the next CM. When asked who will be the next CM, Kesarkar said, "Every political worker desires that the CM should from his or her party, but

whatever decision Prime Minister Narendra Modi and Home Minister Amit Shah take will be acceptable to all of us." "Shinde has told the senior leaders (apparent reference to Modi and Shah) that whatever decision they take is acceptable to him," the Shiv Sena leader added.

New Delhi, Nov. 26: Vice President Jagdeep Dhankhar on Tuesday invoked Dr BR Ambedkar to say that "our independence will be put into jeopardy" a second time if parties placed creed above country. Addressing an event to kick-start yearlong celebrations to mark the 75th anniversary of the adoption of the Constitution, he also cautioned that disturbance as a strategy threatened democratic institutions. In functioning of these organs of the state, domain exclusivity is quintessence to making optimal contributions in steering Bharat toward unprecedented heights of prosperity and equity, he asserted. President Droupadi Murmu, Prime Minister Narendra Modi, Lok Sabha Speaker Om Birla, Leader of the Rajya Sabha JP Nadda, Leaders of the Opposition Mallikarjun Kharge (Rajya Sabha) and Rahul Gandhi (Lok Sabha), Rajya Sabha Deputy Chairman Harivansh, and Parliamentary Affairs Minister Kiren Rijiju were present on the dais. Chinmoy Das in Bangladesh Bangladesh, Nov. 26: India on Tuesday

noted with "deep concern" the arrest and denial of bail to Hindu leader Chinmoy Krishna Das in Bangladesh, and urged authorities there to ensure the safety and security of Hindus and all minorities. Bangladesh police on Monday arrested Das, the leader of the Hindu group, Sammilita Sanatani Jote, from the Hazrat Shahjalal International Airport area in Dhaka. In a statement, the MEA said it has noted with "deep concern the arrest and denial of bail" to Das who is also the spokesperson of the Bangladesh Sammilit Sanatan Jagran Jote. "This incident follows the multiple attacks on Hindus and other minorities by extremist elements in Bangladesh," it said. There are "several documented cases" of arson and looting of minorities' homes and business establishments, as well as theft and vandalism and desecration of deities and temples, the MEA flagged. "It is unfortunate that while the perpetrators of these incidents remain at large, charges should be pressed against a religious leader presenting legitimate demands through peaceful gatherings," the statement said. The MEA also noted with concern the attacks on minorities protesting peacefully against the arrest of Das.

New Delhi, Nov 26: Prime Minister Narendra Modi hailed the Constitution on Tuesday as a "guiding light" at a time of transformation for India, asserting that his government has strengthened constitutional values by taking a host of welfare measures to bring social and financial equality. Addressing an event at the Supreme Court to mark Constitution Day, Modi described the Constitution as a "living stream" that has lived up to the needs and expectations of the country, including the challenge of Emergency, and said it will continue to guide the nation through the changing times. He also paid homage to the victims of the Mumbai terror attack, which occurred on this day in 2008, and said it is the country's resolve that all terror groups challenging its security will be given a befitting reply. Recalling the words of Rajendra Prasad in his concluding address to the Constituent



he had stated that India does not need anything more than a group of honest people who will keep the country's interests above

Assembly on November 26, 1949, Modi said their own. This sentiment of 'nation first' will keep alive the Constitution for cen-

turies to come," he said. Modi said the Constitution has now been fully implemented in Jammu and Kashmir and Constitution Day was celebrated there for the first time. "Our Constitution makers knew that India's aspirations, India's dreams will reach new heights with time. They knew that the needs of independent India and its citizens will change, challenges will change. That is why they did not leave our Constitution as just a mere book of laws. Rather, they made it a living, continuously flowing stream," Modi said. "Today every citizen of the country has only one goal -to build a developed India," he said at the event. India is going through a period of transformation and at such an important time, it is the Constitution of India that is "showing us the way and is a guiding light for us", Modi said. The prime minister cited a host of his government's welfare measures, including the opening of bank accounts for over 53 crore people, homes for over four crore poor families, the scheme to provide cooking gas cylinders to needy women, and health insurance scheme for the poor among others, to highlight the efforts to boost social and equal equality envisaged by the Constitution. Speaking in a lighter vein, he said he has tried to keep within the boundaries of the job assigned to him by the Constitution. "I have not tried any encroachment. I have tried to put forward my views within the boundaries. Only a hint is enough here, there is no need to say much," he said in what appeared to be comments made in the context of his speech, which followed the addresses of several speakers, including Supreme Court Bar Association president and opposition MP Kapil Sibal.

Building, layout approvals made easy: Andhra Pradesh Minister Ponguru Narayana

- VIJAYAWADA: Municipal Administration and Urban Development (MAUD) Minister Ponguru Narayana announced significant reforms to streamline the building and layout approval process.Addressing the media at the Secretariat on Monday, the minister revealed that the State government, led by Chief Minister YS Jagan Mohan Reddy, has approved key town planning reforms proposed by a designated committee.
- The minister stated that buildings up to 15 metres in height will no longer require prior permissions. From December 31, building permissions will be issued through a singlewindow approval system to simplify the process and avoid delays. To ensure faster approvals, the government plans to integrate the servers of various departments, including Revenue, Registration and Stamps, Fire, Mining, Railway, and Airport authorities, with the Municipal Administration server.
- The reforms follow a detailed review of the Municipal Administration and Urban Development Department by the Chief Minister, during which recommendations for town planning were provided. Minister Narayana highlighted that seven committees had studied practices in ten states and submitted their findings, which were instrumental in shaping the reforms. The minister explained that building permissions will be issued immediately after applications are uploaded online by licensed surveyors. He warned that surveyors engaging in illegal practices would face severe penalties, including license cancellation.

Foster+partners to design iconic towers in Amaravati

VIJAYAWADA: Minister for Municipal Administration and Urban Development (MAUD) Ponguru Narayana announced that Foster + Partners, the globallyrenowned architecture firm of Norman Foster, has bagged tenders for designing the five iconic towers, including the buildings for the Assembly and the High Court, in Amaravati.Speaking to mediapersons on Monday, he clarified that the architectural firm bagged the tenders for the projects after they were re-issued.Elaborating on the matter, he said, "The tenders for designs bagged by Foster + Partners were cancelled by the previous dispensation, forcing the firm to file an arbitration case. As a result, the State had to pay Rs 9 crore in compensation at the International Arbitration Centre. The re-tendering process was initiated to address the situation. Subsequently, the company once again secured the contract."The Minister asserted that orders for the final designs would be issued soon, paving the way for construction to commence in the capital region. He also stressed that there are no issues concerning the World Bank loan for Amaravati's development. The World Bank has already agreed to release funds in a phased manner to support the construction of projects in the capital city, he pointed out.Highlighting the

Anganwadi kids play waiting game for book, uniform in TN

An anganwadi worker that TNIE spoke to said that vacancy is a major factor and workers are unable to concentrate on imparting education activities.

COIMBATORE: Five months after enrolment, lakhs of children in anganwadi centres and kindergarten classes in government schools across the state have not yet got their activity workbooks and uniforms.Activity workbooks, designed by the Integrated Child Development Service (ICDS) of Tamil Nadu, are provided to children from two to five years of age, based on their age category. Titled "Aadi Paadi Vilaiyadu Pappa," the curriculum aims to create a stimulating environment for the children's holistic development and learning, through activity books, assessment cards, and preschool education kits, etc. These

activities are designed to be taught to children over 11 months.For instance, in November every year, children aged four to five should be able to name vegetables, sketch, and fill in suitable letters in words provided in the workbooks. Similarly, for each month, there are predetermined exercises which the children must be taught. But due to the delay in distributing workbooks, children are missing out on such activities, sources said.

P Kalaiselvi of Podanur told TNIE that her four-year-old child goes to an

anganwadi in the locality. She said, "Though the staff members take good care of the children by ensuring that they eat and drink water on time and are safe, the staff do not teach them workbook activities as per the syllabus."She added that if workers taught the activities, the children would learn something new and it would stimulate their thinking.

'No appointment of anganwadi workers since 2018'

As there are no activities related to the workbook, children fail to get proper fundamental education in Tamil letters, numbers, etc. Workbooks should be



provided quickly," said P Kalaiselvi of Podanur.A parent, K Sengodi, whose Only poor children face difficulties and lose daughter is studying in LKG at a corporation middle school in Coimbatore told TNIE that uniforms are yet to be provided to the children.An anganwadi worker that TNIE spoke to said that vacancy is a major factor and workers are unable to concentrate on imparting education activities.

"Except in a few places, workers have been forced to manage two or three centres simultaneously. Not only this, we have to cook, register the details of children's attendance, and items received, upload

children's height and weight, go for census work, etc. There is not enough time for us to impart education," she said.Tamil Nadu Anganwadi Oozhiyar and Udhaviyalar Sangam general secretary T Daisy told TNIE that there has been no appointment of new workers since 2018. She said that there are around 18,000 vacancies in 54,000 centres. The state has a total of 1.04 lakh centres, she said.Educationist Su Moorthy told TNIE that the RTE Act mandates that central and state governments provide early childhood care and education.

equal learning opportunities in getting a proper pre-primary education in anganwadi centres due to various reasons. When children come to primary classes with lack of pre-primary education, we can see differences such as learning loss in them," he said. Father, son murdered man in Coimbatore to avenge daughter's suicide

COIMBATORE: Two months after a woman killed herself over a failed relationship, her father, along with his son, stabbed the 27-year-old suspected lover of his daughter to death in broad daylight in Coimbatore on Monday to avenge her. The victim, Tamilselvan, son of Mahalingam of Pandalur in the Nilgiris district, was working as a driver at a private hospital at Thudiyalur in Coimbatore city for the past two years. His mother resides in her hometown of Ayyan Kollakondan village near

Rajapalayam in Virudhunagar district. According to police, Tamilselvan was in a relationship with Anandhi (25), daughter of Malaikani (45), who belongs to his mother's village, for three years. Tamilselvan was also allegedly involved with another woman from Udumalaipettai in Tiruppur district due to which he deliberately put off marrying Cops recover murder weapon from the Anandhi, the police said. Distressed by

Tamilselvan's reluctance to marry her, Anandhi allegedly died by suicide two months ago.

Blaming Tamilselvan for the death of Anandhi, her father Malaikani and her brother Rajaram (25) decided to avenge her. They travelled from Rajapalayam to Coimbatore on a two-wheeler on Sunday. spot

On Monday morning, they located Tamilselvan near the hospital where he worked, lured him to a deserted spot, and confronted him. A heated argument ensued, and the father and son allegedly attacked Tamilselvan with a knife, slit his throat and stabbed him in chest and stomach. Tamilselvan collapsed at the spot and the attackers fled the scene on their two-wheeler.Passersby, who found Tamilselvan lying in a pool of blood, alerted the hospital. Medical professionals rushed to the spot but declared him dead. Thudiyalur police

secured the crime scene, and sent Tamilselvan's body to Coimbatore Medical College Hospital (CMCH) for autopsy. The police also recovered the knife used in the murder. After actively searching for Malaikani and Rajaram, the Tiruppur police caught them and handed them over to the Thudiyalur police. The Thudiyalur police have arrested them for murder and further investigation is on.

1.3 lakh children malnourished in Karnataka, over 11,000 classified as severely acute

BENGALURU: Over 1.3 lakh children aged below five in Karnataka are malnourished. Of them, 11,674 have been classified as 'severely acute malnourished' (SAM), according to data from the Department of Women and Child Development. This issue is compounded by a Rs 300-crore cut in the 2024 budget for the Integrated Child Development Services (ICDS) programme, which supports nutrition initiatives. Currently, over 32.91 lakh children aged below five are associated with 65,911 anganwadi centres in Karnataka. The World Health Organisation (WHO) explains SAM as a condition where a child has an extremely



recently improved the Anganwadi meal menu by adding nutritious items such as millet laddus and khichdi to promote

Replica of Preamble to come up in ten Karnataka cities including Bengaluru

SHIVAMOGGA: As part of its efforts to create awareness of the Constitution, the Karnataka government has decided to install replicas of the Preamble in important parks in 10 cities, including Bengaluru.

The Social Welfare Department has taken up this first-of-its-kind initiative to create awareness and spread the message of the Constitution among the public and has set aside Rs 3 crore for this purpose. The replicas will come up in Bengaluru, Shivamogga, Ballari, Belagavi, Davanagere, Hubballi-Dharwad, Kalaburagi, Mangaluru, Mysuru, Tumakuru, and Vijayapura. In a government order, L Narasimhamurthy, Under Secretary, Social Welfare Department, said that each replica will be 10 ft high and 6 ft wide and will be in Kannada and English.Each city corporation has been granted Rs 25 lakh and the BBMP Rs 50 lakh to build the replicas and to take up awareness programmes on the Constitution.

KOCHI: It's been 20 years since the establishment of Infopark. In the two decades, the IT park in Kochi has grown steadily, from 100 acres with four companies in 2004 to 323 acres housing over 582 companies and 70,000 professionals within its 9.2 million sq ft built-up area by 2024.Infopark's growth gains significance when compared to Technopark in Thiruvananthapuram, which had a running start of 10 years. The IT park in the state capital, which started from two companies, 155 employees and a built-up space of 1.07 lakh sq ft in 1994, has, as of 2024, 768.63 acres with a builtup space of 12.72 million sq ft hosting 490 companies and over 75,000 employees.With the addition of another 300 acres in phase 3, Infopark is expected to see an upward growth trajectory.It all started in 2004, when the state government transferred 100 acres belonging to KINFRA at Kakkanad in Kochi to Infopark Kerala for setting up an IT Park. Infopark started operations by renovating the Standard Design Factory (SDF) Building that existed on the land transferred by KINFRA.Susanth Kurunthil, the CEO of Infopark, told TNIE, "The IT park is on the path of a transition from a real-estate player

to an ecosystem enabler. As Infopark turned 20 this year, we adopted a new logo and fresh tagline to emphasise the transition we are going through.

Susanth credited the skilled talent pool in Kerala, and Kochi being a Tier II city, for the park's growth. "More IT giants like NOV, Strada, HCL Tech, IBM and Baker Tilly-Pierian expanded their operations by setting up new offices on Infopark's Kochi campus recently. The IT product

companies show immense enthusiasm to operate from Infopark, which is a good sign. Of course, we are working towards bringing more IT/ITES companies to set up space in Kochi, Cherthala and Thrissur," he said.As for infrastructure development plans, Susanth said, "Construction of premium flexiworkspaces are on at Kochi Metro's Ernakulam South station complex. At the centre of a multi-modal transport hub, this upcoming facility aims to accommodate gig workers, women professionals, and employees of MNCs working from homes in Kerala."Furthermore, UST has laid the foundation stone for its upcoming campus in Infopark. It is expected to be finished in



2027. Another development is the widening of the road to Infopark Kochi Phase 2.Besides its Phase 1 and 2 campuses in suburban Kakkanad, Infopark has satellite centres at Koratty in Thrissur and at Cherthala in Alappuzha. Infopark Cherthala, situated in Pallippuram, was established in 2011, and lies a few km from NH 66; part of the IT corridor. It has one SEZ building (Chaithanya). There are 22 companies and over 250 employees on the satellite campus, which offers both plugand-play and bare-shell office spaces.Infopark Thrissur situated in Koratty was established in 2009 near NH 544. It consists of nine villas (non-SEZ buildings) and one IT complex (an SEZ building named 'Indeevaram'). There are

55 companies and over 2,900 employees. The campus offers both plug-and-play and bare-shell office spaces too.

3 of Pardi gang arrested

- Noida: Three men, allegedly part of the Pardi gang, were arrested on Monday. The suspects had been on the run since 2019 and two of them carried bounties of Rs 25,000 each, police said. Himanshu Verma (25), Mayur Kumar (33), and Virendra Kumar Verma (60)-natives of Agra-had been living in East Delhi under different identities, said Manish Kumar Mishra, additional DCP.
- "All three have a criminal history. Himanshu and Mayur also had bounties of Rs 25,000 each. They were nabbed by Sector 113 police and two illegal pistols were also seized from their possession," said Mishra.
- "In 2019, Noida police busted the Pardi gang and arrested several members of the gang. The gang would pretend to sell balloons in different neighbourhoods and scope out houses to break into. They operated in many states," said Mishra.Police are also investigating to find the whole nexus of the Pardi gang and nab more of its associates, he added.
- The gang, from Guna in MP, robs houses by dislodging window grills, irrespective of whether the premises are occupied or empty. Explaining the modus operandi, the ADCP said, "The gang would divide the members into three groups. One group would rob houses using weapons and rods, another would keep a watch outside for police, and the remaining group would flee with the valuables."

Nip in air: 15 shelter homes set up in city, bonfires soon

Noida: With the onset of winter, the district administration has set up 15 shelter homes to provide relief for the poor and homeless in Noida, Greater Noida, and Dadri. A total of 81 designated bonfire spots have also been arranged, with the disaster management department overseeing the efforts.Omkar Kulkarni, the district disaster expert, said that each shelter home can accommodate up to 100 people. More shelters will be added during peak winter if necessary. Key locations include Aamka Road near Budhababu Talab, Dadri Police Station intersection, Mamura Crossing in Sector 62, and



various community centres in sectors 135, 21A, and 12-22. Additional shelters are in Bilaspur, Dankaur, Jewar, and two in Greater Noida at Delta 2 and Pi 3.

DM Manish Verma, during a recent meeting, directed officials to ensure prompt arrangements. "Providing relief to the destitute and vulnerable is a top priority of the state govt. We are committed to ensuring no one has to sleep on the roads during harsh weather," he said.He instructed that shelters must provide basic amenities like mattresses, blankets, clean drinking water, and toilets free of charge. Bonfires will also be lit at designated spots near shelters for added relief. Verma emphasised that preparations should be completed immediately, with details of caretakers, bonfire locations, and photographic evidence submitted to the disaster management department. The administration plans to widely publicise the cold wave relief programs to ensure maximum reach among vulnerable populations.

Haryana farm fires 40% less than last yr, sharp drop in Punjab too

Gurgaon: As crop stubble burning season reduce stubble burning as it coincides nears an end, satellite data shows that at 1,315, Haryana has recorded a substantial decrease in farm fires in the Sept 15 to Nov 25 period this year than in the same period in the last four years.Data compiled by Indian Agriculture Research Institute (IARI) shows the number of recorded farm fires was 2,278 in 2023, 2,581 in 2022, 6,829 in 2021 and 4,036 in 2020, the last two being pandemic years. Compared to last year, farm fires have fallen 42% this year, and compared to 2020, the reduction is around 70%. While the rains not continuing late into Sept and Oct this year likely led to some farmers clearing their fields before the measurement window, steps on the ground like access to machinery, newer farming technologies being adopted, and stricter monitoring – with the state govt taking penal action against officials for not stopping farmers from burning stubble have begun to show their impact, experts said.For years, NCR states have been announcing a flurry of measures to

with the winter pollution season and adds harmful particles to the already toxic haze over northwestern India. Punjab, which usually has the highest number of farm fires among the states, has also recorded a sharp drop. Between Sept 15 and Nov 25, it recorded 10,682 cases of stubble burning, compared to 36,514 incidents in 2023, 49,810 in 2022, 71,215 incidents in 2021 and 82,702 in 2020."This year, the rains stopped in August, as a result of which farmers got enough time to manage straw and prepare their land for the next crop. Farmers are also getting help on the ground, and that is reflecting in the numbers." said Shubhansh Tiwari, research associate at Centre for Science and Environment (CSE)."It's true that fires in Haryana are at the best levels," said Hiren Jethva, senior research scientist at US space agency NASA, whose satellites capture farm fire data. The Harvana govt, ahead of winter, procured 90,000 machines that were given to farmers for in-situ paddy straw



management. It also appointed 10,000 nodal officers and set up dedicated teams to check stubble burning. Govt data suggests much of the straw left behind after paddy harvests was utilised or sold. 'This year, we started providing machinery to farmers in August. We also prepared a staggered harvesting schedule for paddy. Gram panchayats that achieved zeroburning targets will be awarded Rs 1 lakh or Rs 50,000," said Darshan Singh, technical assistant, Haryana agriculture department.Farmers said it was also a breather for them. "This year, we started the harvest season early. Industries bought large quantities of straw. We don't like to burn the residue either. Earlier it was difficult to get access to machinery,



Smog on the prowl: Speed limits to be reduced on Noida & Yamuna e-ways

- Noida: Barely 24 hours after two road crashes left one dead and 15 others injured, some of them grievously, traffic cops have cautioned motorists to drive carefully on the highways and said they will soon reduce the official speed limits of vehicles plying on the Noida and Yamuna expressways.
- From Dec 15, cops plan to cap speed limits for light vehicles at 75 kmph on both expressways. For heavy vehicles, the limit will be revised to 50kmph on the Noida expressway and 60 kmph on the Yamuna expressway. The revised timings, implemented each year during the annual winter fog season, will be in place till Feb 15. Currently, light vehicles can travel at



100 kmph and heavy vehicles at 60 kmph on the Noida expressway and 100 kmph and 80 kmph, respectively, on Yamuna Expressway. Over the last week, visibility across NCR has plummeted to 500-800 metres. On Sunday morning, the 75-year-old daughter of Jagadguru Shri Kripalu Maharaj - the founder of Prem Mandir in Vrindavan - died and seven others, including two of her sisters, were injured when a truck crashed into their Toyota Camry and Innova Hycross on the Yamuna Expressway. In another accident, eight people were injured after a canter hit two cars on the Yamuna Expressway on the route from Agra to Noida. "Driving at high speeds in foggy conditions is fraught with risks as it becomes difficult for drivers to see obstacles," DCP (traffic) Yamuna Prasad said.Noida Authority, meanwhile, plans to install new speed limit signs on the Noida Expressway, and Jaypee Infratech, the concessionaire, will do the same on the Yamuna Expressway.

Hong Kong's top court rules in favor of equal inheritance and housing benefits for same-sex couples

HONG KONG. Hong Kong's top court on Tuesday upheld earlier rulings that favored subsidized housing benefits and equal inheritance rights for same-sex married couples, in a landmark victory for the city's LGBTQ+ community. The Court of Final Appeal's dismissal of the government's appeals ended some yearslong legal battles over the differential treatment facing same-sex couples married overseas under Hong Kong's Housing Authority policies and two inheritance laws.

The unanimous decisions are expected to have a farreaching impact on the lives of same-sex couples, who have traditionally had fewer rights compared to their heterosexual counterparts in the global financial hub.Chief Justice Andrew Cheung said in his judgement that exclusionary housing policies were argued to be beneficial to opposite-sex married couples because they increase the supply of subsidized housing for them and thereby support the institution of traditional families.But Cheung said authorities failed to provide evidence showing the potential impact on opposite-sex couples if those policies were relaxed."The challenged policies cannot be justified," he wrote.On the inheritance laws, judges Roberto Ribeiro and Joseph Fok ruled that the disputed provisions are "discriminatory and unconstitutional" in their written judgement. Hong Kong does not recognize same-sex marriage, prompting some couples to marry elsewhere.Currently, the city only recognizes samesex marriage for certain purposes such as taxation, civil service benefits and dependent visas. Many of the government's concessions were won through legal challenges, and the city has seen a growing social acceptance toward same-sex marriage.In September 2023, the top court ruled that the government should provide a framework for recognizing same-sex partnerships. This ruling, along with other successful legal challenges brought by members of the LGBTQ+ community, made Hong Kong the only place in China to grant such recognition for same-sex couples.

White Florida woman sentenced to 25 years in prison for shooting Black neighbour in lengthy dispute

A white Florida woman who fatally shot a Black neighbour through her front door during an ongoing dispute over the neighbour's boisterous children was sentenced Monday to 25 years in prison for her manslaughter conviction.Susan Lorincz, 60, was convicted in August of killing Ajike "A.J." Owens, 35, by firing a single shot from her .380-caliber handgun in June 2023. She had faced a maximum of 30 years behind bars. Circuit Judge Robert Hodges opted for a slightly lesser term amid evidence that Lorincz had been abused as a child and had mental health problems."The shooting was completely unnecessary in this case," Hodges said during an afternoon hearing. "The shooting, I find, was based more in anger than in fear."
- The shooting was the culmination of a long-running argument between the two neighbors over Owens' children playing in a grassy area near both of their houses in Ocala, abot 80 miles (130 kilometers)

Israelis skipping army duty as fatigue of never-ending war deepens

World. A soldier by day, a father by night. Ari Krauss, a reservist in the Israeli military's elite Golani Brigade, would explode underground tunnels in broad daylight. After the sun set, Ari would try to find the network to FaceTime his infant daughter. Ari and other reservists enlisted in the war would turn to the hill in search for a stable network each night. The dual lives of Israeli reservists and their combat fatigue has been documented by The Washington Post.But their

lives had looked drastically different just a year ago. The memory looks distant now. Ari used to work for a company, and it was before the October 7 war between Israel and the Palestinian terror group, Hamas started, reported The Washington Post. When Hamas attacked Israel on October 7,

around 1,200 Israelis were killed. The war has lasted for more than a year now. After incessant rocket attacks from Hezbollah, the Israeli Defence Force (IDF) conducted



a massive offensive in Lebanon in mid-September. This added another chapter to the Israel-Hamas war. Amid this came two drone and missile attacks from Iran. There could be some relief on the Lebanese front as Israeli Prime Minister Benjamin Netanyahu has approved "in principle" a ceasefire deal with Hezbollah, a source told CNN.During the war, Ari's brigade wrote to his boss that he would be serving in the army.

'DISAPPEARING FOR WEEKS OR MONTHS, NO END'

"Once upon a time, I had my high-tech career and my family life, and I had to strike the balance," said Ari, who spent four months battling with Hamas terrorists."Now I have to enter into that equation the fact that I am disappearing for weeks, or months, no end."This act of disappearing is not just the story of Ari Krauss but also of the 80,000 Israeli reservists who had to leave their jobs and loved ones to fight for Israel in Gaza and Lebanon. This is because there is more

need for soldiers to continue the war but many who have been conscripted are not showing up.

350,000 ENLISTED OUT OF 10 MILLION ISRAELI POPULATION Several people do not show up to fight as they have been traumatised by the war. They are seeking individual and group therapy, reported Le Monde. Even horses are employed for therapeutic healing. They fear for their lives and are traumatised after several months of fighting. The army's

enlistment numbers have decreased by 15% since the war began when different sections had opted to fight for their nation. When a war is not ongoing, Israel retains a small army. It enlists reservists for a warlike situation which is mostly shortlived.In the first few months of the war, over 350,000 Israelis were asked to serve in the country with a population of less than 10 million. Now, more than a year later, reservists prepare videos where they say goodbye to their children and leave bank passwords for their spouses. This happened to Chava Landau Zenilman, whose husband died fighting the Hamas terrorists, recalled the fear after the attacks.

""We were imagining the terrorists coming into their house, to kill the kids in their beds," she said.Her husband had served before too. This time he had to serve."These dilemmas are our reality from before, but this war is extreme," she said. She barely ate or slept when he was in Gaza, she said, and tried to keep herself from imagining "the knock on the door".

31 Killed In 1 Day After Israeli Strikes, Says Lebanon

Beirut.Israeli strikes pummelled south Beirut on Monday, Lebanese official media said, and health authorities reported 31 people killed across the war-hit country, most of them in the south.

Israel's military said in a statement Monday afternoon it had hit "approximately 25 terror targets" belonging to Hezbollah across Lebanon, including in Nabatiyeh, Baalbek, the Bekaa Valley and southern Beirut and the city's outskirts.AFPTV images showed palls of smoke over the capital's southern suburbs after strikes that began in the

morning after successive Israeli military warnings to evacuate. Lebanon's state-run National News Agency (NNA) reported a fourth wave of Israeli raids in south Beirut on Monday evening, saying "enemy



Haret Hreik and Shiyah" districts. The attacks came after a weekend of heavy raids in the area, despite ongoing international ceasefire efforts.Early Saturday, a deadly strike on central Beirut's densely populated Basta neighbourhood killed at least 29 people, the health ministry said.Israel's army said Monday it had struck a Hezbollah command centre there, though an official with the Iran-backed

Five security personnel were killed, and dozens including police officers, were injured in Pakistan as supporters of jailed former Prime Minister Imran Khan marched toward the capital on Monday and continued their protest on Tuesday. As the protesters vowed to push further, the government deployed the army in Islamabad. The protest march spearheaded by Khan's wife Bushra Bibi, which began on Sunday and reached Islamabad by Monday evening, witnessed clashes with police and security forces. On Tuesday, the protesters resumed their march to the D-Chowk, close to several strategic buildings in the capital, where they plan to gather.According to local media reports, one police officer was fatally shot, and four paratroopers were run over by protesters. Dozens were injured as the city witnessed heightened tensions, a series of violence, attacks on police and torching of vehicles as Pakistan Tehreek-e-Insaf workers advanced towards the capital. Imran Khan, the PTI chief, had issued a "final call" for nationwide protests starting Sunday, rejecting what he described as a "stolen mandate". The party urged the public to join the demonstrations to "break the shackles of slavery". Protesters, led by Khyber-Pakhtunkhwa Chief Minister Ali Amin Gandapur and Bushra Bibi. began their march toward Islamabad on Sunday. The government blocked highways using shipping containers, concrete barriers, and barricades. However, protesters used lifting equipment and heavy machinery to remove the obstacles, pressing forward toward the national capital, leading to violent clashes.

Provincial police chief Usman Anwar confirmed that one police officer was shot dead, at least 119 others were injured, and 22 police vehicles were set on fire in clashes near Islamabad and across Punjab province. He then rushed towards the door, hitting the attendant as she attempted to block him.A passenger named Dough McCright, who saw the events unfolding in front of him, quickly assessed the situation and started planning his next move."I could tell that the conversation was not going Investigation underway very well," Mr McCright told Fox4, As the situation escalated, Mr McCright adding that the man ignored the flight attendant despite her repeated attempts to reason and talk sense. After the attendant signalled for help, Mr McCright jumped in and addressed the man."I said, 'Sir, she wants you to go back to your seat. You need to go back to your seat'. He turns and he says, 'I'm getting off this flight! I want off this flight!"

Japanese Bank Employees **Vow In Blood Against** Embezzlement

- World. A bank in Japan has implemented an extraordinary policy where employees have signed a pledge in blood, promising to take their lives if found guilty of embezzling funds. A viral post compared the Shikoku Bank's rigorous stance against financial misconduct with the comparatively lenient consequences often observed in other countries. The pledge, deeply influenced by Japan's feudal samurai code, demands a guilty employee return the stolen funds and perform seppuku - a traditional form of ritual suicide.
- Outlined on Shikoku Bank's official website in Japanese, the pledge reads, "Anyone employed by this bank who has stolen money or caused others to steal from the bank will pay for it with his or her property and then commit suicide."This pledge dates back to the Thirty-seventh National Bank, which preceded Shikoku Bank.
- It adds, "This pledge is part of a document signed and stamped in blood by all 23 employees, including President Miura, of the Thirty-seventh National Bank, the predecessor of Shikoku Bank, to ensure strict handling of banknotes."The bank's website describes the oath as a symbol of ethical conduct and social responsibility, not just as an employee but as a member of society, preserving it as a cherished legacy of Shikoku Bank.On social media platform X, the policy sparked wide-ranging reactions. Now it's clear why they all have so much cash on their balance sheets," a user wroteAnother said that "the pact is some WW2 vibes."

Guardian reported, while citing two sources familiar with the matter.rump's transition team is conducting interviews for the role on Monday night at his Mar-a-Lago club in Florida. This came after US Vice President-elect JD Vance, in a now-deleted social media post, revealed that he and the Presidentelect had been interviewing candidates for the role of FBI Director.Simultaneously, Patel's name is also under consideration for a high-profile position at the US Justice Department, top transition sources told Axios.

and Tulsi Gabbard as director of national intelligence, reflects the US Presidentelect's urge to appoint allies to key roles in law enforcement and intelligence agencies. evident. In 2017, he fired James Comey as director, citing Comey's refusal to shut



down an investigation into possible ties between Trump's campaign and Russia. Since then, Trump has frequently expressed frustration over what he sees as disloyalty within the bureau, including from its current director, Christopher Wray.Patel, a former aide to Representative Devin Nunes and a key figure in Trump's circle, has gained significant support among Trump's

allies, strengthening his prospects for key roles.Known for his aggressive self-promotion and outspoken criticism of the so-called deep state, Patel has become a prominent candidate for highranking roles in law enforcement and national security.

While his name is being considered to lead the FBI, speculations were running high that Patel may get the role of CIA director in the past. However, the position went to John Ratcliffe, another Trump loyalist.

Patel's loyalty was on display during the criminal investigation into

Trump's handling of classified documents. Initially, he refused to testify before a federal grand jury in Washington, invoking his Fifth Amendment right against self-incrimination.He eventually testified only after then-Chief US District Judge Beryl Howell granted him limited immunity at the Justice Department's request.



No money for bond, Koppal villagers still in jail

KOPPAL: Marakumbi's 98 villagers have got bail in Dalit atrocity case but most of them are still in jail. Reason: Many families are struggling to arrange Rs 50,000 for a bond that should be submitted to Dharwad High Court to get bail.In some families, 2-3 members are in jail. There is tension in the village which is wearing a deserted look. Many families in Marakumbi are working as daily wagers and they cannot forgo even a day's salary as they are all dependent on daily wages.Now, they have to arrange Rs 50,000 for bond. Some people are selling their gold ornaments while some are planning to raise hand loans.Nagamma (name changed), an elderly woman and a resident of Marakumbi village, is now sitting at home with no option. His only son, who was also a daily wager, is in jail now.She asked many people for money. Many elderly people in Marakumbi village are striving hard to bring out their family members from the jail. As of Monday, some family members have arranged money and have also met lawyers but still many families are trying to arrange money.Marakumbi villagers were arrested on October 23 and were sentenced to life imprisonment in a Dalit atrocity case. Later, on November 13, all 98, except accused 1.

First container hospital inaugurated in Parvathipuram-Manyam district

PARVATIPURAM MANYAM: In a major step towards improving healthcare in tribal areas, the Parvatipuram-Manyam district administration launched its first prefabricated health sub-centre, 'Giri Arogya Kendra,' in Salur mandal on Monday. Tribal Welfare Minister Gummadi Sandhya Rani inaugurated the centre at Karadavalasa village under the Tonam rimary Health Centre (PHC).Designed to make healthcare accessible in remote hilly regions, the initiative aims to end the reliance on makeshift stretchers, known as 'doli,' for transporting patients during emergencies. The Giri Arogya Kendra will serve over 2,000 residents across Karadavalasa and 10 neighbouring villages in Salur and Pachipenta mandals. The initiative addresses the chronic lack of healthcare access in a district marked by poverty and poor road connectivity.Despite 75 years of independence, many tribal villages in Salur, Pachipenta, Kurupam, Jiyyammavalasa, Gummalaxmipuram, Seethampeta, and Makkuva mandals remain without proper roads, often leading to fatal delays in emergencies.

District Collector A Shyam Prasad explained that these health centres are equipped with four beds, medical testing facilities for 14 conditions, including malaria, dengue, HIV, and tuberculosis, and 105 varieties of essential medicines. Additionally, medical officers from PHCs will conduct weekly outpatient visits, while 104 mobile medical units will operate twice a month. The Collector emphasised the initiative's transformative potential, stating, "The centre will replace the need for doli journeys by bringing healthcare closer to tribal communities. The facility is equipped to manage conditions such as diabetes, hypertension, and anaemia, offering medicines, iron injections, and routine immunisation.

Police disrupted Thrissur Pooram, Thiruvambady Devaswom tells Kerala HC

KOCHI: The Thiruvambady Devaswom has informed the Kerala High Court that the devotees who came to participate, witness, and celebrate Thrissur Pooram were prevented, and the festival abruptly brought to a grinding halt by the police personnel deployed at the venue.Last week, the Cochin Devaswom Board had told the HC that certain actions of the Thiruvambady Devaswom during the pooram had given rise to suspicion that those were aimed at aiding certain political parties in the ensuing Lok Sabha elections.Girish Kumar, secretary of the Thiruvambady Devaswom, stated in the affidavit that the 'ezhunnellippu' procession was disrupted by the police. "The public and devotees who had come to participate in the festival were prevented from doing so, and the festival was abruptly brought to a halt.Roads leading to the Swaraj Round were blocked, denying people the opportunity to view or participate in the 'ezhunnellippu'. Additionally, the 'Madathil Varavu' procession was reduced to a simple ritual due to unnecessary police intervention," he said

The affidavit further alleged that the police used physical force against members of the public and pooram

enthusiasts, leading to widespread discontent. The situation escalated to the verge of mob-like unrest, which was averted only by the timely intervention of Thiruvambady Devaswom authorities.

The affidavit also claimed that the police did not permit authorised personnel and workers of the devaswom, including licensed fireworks handlers, to access the 'magazine' for arranging fireworks. "No untoward incidents or crimes occurred during the pooram that necessitated such police action. The actions of the police were unnecessary, baseless, and without valid reasons," stated the affidavit.It added that the mahouts and their helpers were physically prevented from taking palm leaves to feed the elephants. This incident, the affidavit noted, was widely circulated on social media.

Though the HC had banned wearing footwear inside the temple, policemen were seen doing it. The devaswom was not aware of whether any duty briefing was conducted on the previous day by the police chief.

'But the action of the police, which was unnecessary and without any valid reasons, reveals that the policemen acted arbitrarily and in an immature manner which could be due to their inexperience and lack of knowledge about pooram and its rituals," it stated.

KSPCB to extend **BRSR** guidelines for companies

BENGALURU: The Karnataka State Pollution Control Board (KSPCB) is set to extend the guidelines of Business Responsibility and Sustainability Reporting (BRSR) to all companies, irrespective of their turnover.A senior KSPCB official told, "We are taking a policy decision to broaden the implementation of BRSR report guidelines. The Central government has outlined a climate action plan, requiring each government department to address climate change locally. Karnataka, including Bengaluru, has been experiencing worrisome weather conditions- prolonged spells of drought, short intensive rain spells, urban flooding and water crises. To address these challenges, KSPCB has initiated groundwork to develop tools and mechanisms for all companies, industries, apartments and commercial complexes to implement BRSR guidelines, irrespective of their turnover."

The official also noted that discussions with the environment department and state government are also being held. The initiative aligns with recommendations made by the Environmental Management and Policy Research Institute (EMPRI) during the recent interaction of KSPCB and EMPRI with stakeholders at the 'Sub-National Climate Action and Monitoring- Developing Policy Insights for Karnataka State Action Plan on Climate Change' (KSAPCC) that was held in the city.

A senior researcher from EMPRI explained that the BRSR report currently applies to companies with a turnover of Rs 150 crore or more. These companies are required to establish baselines for effective measures to be taken to mitigate climate change including reduction of greenhouse gas emissions, afforestation, use and reuse of water, waste management and so on. Presently, the top 100 companies listed by the Securities and Exchange Board of India (SEBI) are mandated to adopt these environmental measures and disclose their efforts publicly.Further, the KSPCB official said customised tool kits are necessary, along with a committee or an institution to monitor, and develop protocols and will have to work on the SEBI guidelines.

Tamil Nadu: Covid antibodies may neutralise dengue virus

CHENNAI: A seroprevalence study conducted by the State Public Health Laboratory, Directorate of Public Health and Preventive Medicine during Covid-19 in December 2021 has showed that the dengue disease burden was low during that period, possibly due to the IgG antibodies for Covid-19 that causes SARS CoV-2 virus having a neutralising effect against the dengue-causing

virus.The officials said further study is needed to prove the possible viral interference between SARSCoV-2 and dengue virus. The authors said the 2021 study will be helpful for the public health



officials to focus on one particular infectious disease during an outbreak, rather than focussing on less important ones. The statewide cluster-randomised community-based study conducted by the Directorate of Public Health and Preventive Medicine, led by Dr T

S Selvavinayagam, who is also the chief author, was published this month in PLOS Global Public Health, a journal for public health research.In community was found out by the seroprevalence. The study also found out the percentage of people in the population who have anti dengue antibodies, Dengue IgM which shows an ongoing infection at the time of study, and Dengue IgG antibodies, which shows past infection.

The study found that the seroprevalence of dengue was very low in the community with 4.12 % for Dengue IgM and 6.4% for Dengue IgG. Similarly only 3.76 % of the female Aedes mosquito pools were positive

for dengue virus. In comparison, a similar study conducted by ICMR-National Institute of Epidemiology, Chennai in 2017, showed Dengue IgG to be very high at 77%. the study, the dengue burden in the The anti-SARS-CoV-2 IgG antibody level meanwhile remained high (87.3%) during the 2021 study. The researchers said during Covid-19 when they saw low dengue cases, they thought it could be due to underreporting of cases.While there were a few studies earlier that said dengue cases were low during Covid-19, DPH officials said this is the first study to prove dengue cases were low in both humans and mosquitoes.

The researchers said this could be because of Covid-19 antibodies blocking the entry of dengue virus. Further, studies needed to prove this hypothesis, they added.

TN plans to study substance abuse among youth soon

CHENNAI: The Department of Children Welfare and Special Services will soon carry out a study to assess the prevalence and extent of substance and alcohol use among adults aged between 18 and 25 in the state. The study, funded by the central government under the National Action Plan for Drug Demand Reduction (NAPDDR), is carried out to help the department with policy making and start de addiction programmes.The study will focus on identifying the types of substances consumed, as well as the socio-economic and demographic profiles of users. It will also map hotspots where substance and alcohol use is prevalent and formulate evidence-based prevention policies and programmes. According to officials from the department, the findings will serve as a baseline for establishing de-addiction centres in identified hotspots."The health department is conducting similar large-



department. The department plans to hire an external agency to carry out the study. "Once an agency is selected, we will explore the possibility of expanding the study to include those aged 10 to 18, subject to fund availability. This is also crucial as many juvenile delinguents are reported to frequently use drugs or alcohol," the official added. According to a national level survey carried out by the central government in 2018 under NAPDDR, 14.2% drink alcohol in Tamil Nadu of which 4% are dependent. Among men aged 10-75, 28.5% drink alcohol. The national average of these numbers are 14.5% and 27.3% respectively. About 37 lakh people in the state need help for alcohol problems, the study had said. While the 2018 study can be used for broader details, we are doing demographic-specific studies to create an action plan to battle drug usage among children and young adults, added officials.

- VIJAYAWADA: Prakasam district police launched a manhunt to trace film director Ram Gopal Varma (RGV) after he failed to appear before the police for questioning in connection with a case pertaining to social media abuse.Searches were conducted at RGV's office and residences in Hyderabad on Monday. A team of Maddipadu police visited RGV's office in Navanirman colony, Jubilee Hills. Cops also carried out searches at his Shamshabad and Shadnagar farmhouses.Based on his tweet, a team was also sent to Coimbatore in Tamil Nadu.
- 'Since he failed to appear before the investigation officers twice, Prakasam SP instructed Maddipadu police to arrest him following due procedures," said a senior police official on the condition of anonymity.
- In a complaint, TDP mandal secretary Muthanapalli Ramalingaiah accused the film director of allegedly posting photographs of Chief Minister N Chandrababu Naidu, Deputy Chief Minister Pawan Kalyan and their family members in an "indecent" manner on social media.Subsequently, Maddipadu police booked a case against RGV and served notices on him to appear for investigation on November 19.

RGV ready to appear for questioning virtually

On the request of the film director, police gave him more time and instructed him to appear for questioning on November 25. With the director reportedly going off the radar from Saturday, police launched a manhunt to trace him.Speaking to mediapersons in Hyderabad, RGV's legal counsel Bala said the film director was willing to appear for questioning in virtual mode. LDF suffered significant vote loss in Wayanad, trailed NDA in 171 booths

KOZHIKODE: The LDF suffered a significant vote loss in the Wayanad Lok Sabha by-elections, marking a major setback to the ruling government. For the first time, the LDF trailed the NDA in 171 booths across all three assembly constituencies - Mananthavady, Kalpetta, and Sultan Bathery.Adding to the embarrassment, the LDF failed to secure a lead in Thirunelli, the home panchayat of its own minister, O R Kelu. where Congress leader Priyanka Gandhi maintained a lead of 241 votes. The LDF's defeat was comprehensive, as it failed to register a majority in even a single municipality or the 23 panchayats in the district. In Sultan Bathery municipality, UDF candidate Priyanka Gandhi secured a decisive victory with 14,315 votes, while NDA's Navya Haridas claimed second position with A similar pattern was observed in Pulpally, 4,217 votes, narrowly surpassing LDF's Sathyan Mokeri, who garnered 4,136 votes. The NDA outperformed the LDF by 81 votes and secured a lead of 135 votes in the 104th booth, despite trailing in 17 other booths. The LDF faced a significant setback here, with about 10,000 votes remaining unpolled.In Poothadi, the UDF maintained its



dominance with 10,116 votes, but the NDA demonstrated a strong presence by securing 4,106 votes, leading the LDF by 296 votes, which managed only 3,810. where UDF led with 9,542 votes, followed by the NDA with 3,118 votes and the LDF trailing by 2,921 votes. The trend continued in Mananthavady, the constituency of Minister O R Kelu, where the LDF fell to third place in 39 booths.Similarly, in Kalpetta, the LDF was relegated to third place in 35 booths, marking one of their worst performances in the history of the constituency. The defeat has triggered significant discontent within the LDF as it grapples with the implications ahead of the local body elections. Analysts and party insiders attribute the failure to a lacklustre campaign, minimal involvement of influential CPM leaders, and an inability to capitalise on issues like Rahul Gandhi vacating the constituency.Leaders have expressed frustration over the lack of strategic planning and pointed out the need for introspection.



KHAMMAM: With sand smuggling allowed to grow unchecked across Bhadrachalam, residents are accusing officials and political leaders, from the ruling and opposition parties, of allowing the illegal operation to flourish in the temple town.Rampant sand smuggling can be seen in the Godavari river near the bridge at Sarapaka, on the outskirts of Bhadrachalam. Smugglers, reportedly operating with the support of ruling party leaders, illegally transport sand using tractors at night, the locals explained. Despite repeated complaints from residents, no effective action has been taken to curb the illegal sand mining, the locals said.

G Ranga Rao, a resident of Burgampad village, alleged that some officials are complicit in the smuggling operations, as such large-scale activity would be impossible without their cooperation. He also claimed that leaders from both ruling and opposition parties are involved in the illegal transportation of sand.

Environmental concerns

Meanwhile, the residents have raised concerns about large holes being dug under the bridge, which poses a threat to the structural integrity of the bridge pillars. These activities are not only endangering the old and new bridges leading to Bhadrachalam but also causing environmental damage, they added.

N Krishna, a resident of Burgampad, highlighted that the smugglers are creating deep holes near the bridge pillars and transporting sand using tractors. B Shankar, a resident of Sarapaka, added that heavy earthmovers are being used for the excavation, making the situation more dangerous for the bridges. The locals have pointed out that smugglers have been aggressive in defending their operations. A few days ago, they allegedly attacked a revenue inspector from the Burgampad mandal revenue office who tried to stop the sand-laden tractors.

At this juncture, the residents are appealing to the state government to take immediate measures to stop the illegal sand transportation and ensure the protection of the bridges and the surrounding environment.

Mastering the art of leadership



- Leadership is the expected set of actions of a human being or a human institution that is characterised by assiduous adherence to values and principles of progress. A leader is supposed to show true direction to his team in the pursuit of a charted goal and demonstrate by personal example through action consonant with those values and principles. Leaders motivate and inspire.
- Good leaders are passionate about their mission and create the same passion in their followers or team members. A true leader commands the respect of his team members, who follow him with zeal and not out of fear. Leaders are supposedly the torchbearers of the norms, rules and values that drive an institution. They become the focal points of determined, collective action. They spearhead concerted action, formal or informal.
- The quality of leadership refers to the type of actions and behaviour that are exhibited by those in positions of power and authority over others in formal or informal institutions.
- Thus, the role actions of a father as the head of a family, principal of a college, captain of the national cricket team, chairman and managing director of a public sector undertaking, CEO of a corporate business house, general of the Army or the prime minister of a country, when subjected to scrutiny, will bring out the qualitative aspects of their leadership.
- The quality of leadership depends on how these leaders play their respective roles and how assiduously they adhere to the defined principles and values attached to those roles, in line with institutional objectives. How Opposition lost the Maharashtra plot

THE Congress got it wrong in Maharashtra from the outset. Seasoned party leaders who were appointed observers for the Assembly polls had no proficiency in the Marathi language, a prerequisite in the state. This galaxy of leaders told the party top brass that Maharashtra was heading for a hung House and that the Congress should make arrangements to shift MLAs of Maha Vikas Aghadi (MVA) to Bengaluru to avoid poaching and horse-trading. Three prominent hotels in Congress-ruled Karnataka were booked, while a chartered plane was on standby to airlift MLAs in the evening on November 23. All these preparations proved to be needless.

The enormity of the defeat of the grand old party and its allies — the Nationalist Congress Party (NCP-Sharadchandra Pawar) and the Shiv Sena (Uddhav Balasaheb Thackeray) — is glaring because INDIA

leaders, both collectively and individually, had not anticipated such a result. Most of the internal surveys had given the MVA an edge over the BJPled Mahayuti, predicting 140-plus seats for the alliance in the 288-member Assembly. Party chief Mallikariun Kharge and Rahul Gandhi had asked observers Ashok Gehlot, Bhupesh Baghel and G Parameshwara to head for Mumbai on the counting day so that talks on government formation and other issues were handled promptly. The performance of the Congress and its allies in Maharashtra is a sad commentary on the Opposition that failed and faltered at every stage of electioneering. Apart from fielding a battery of outsiders as campaigners and observers, the grand old party did little to build a narrative or counter Mahayuti's high-pitched campaign that stoked fear and insecurity. As an alliance, the MVA trio was simply missing from the ground.In most constituencies, the entire campaign revolved around the candidate rather than his/her party or the MVA. There were reports that over 50,000 RSS workers were going door to door, focusing on Dalits, Adivasis, OBCs, Marathas and others; they claimed that the majority community's change any constitutional provisions relating to caste-based quota in jobs and educational



institutions. Union ministers Kiren Rijiju and Bhupendra Yadav coordinated closely at block and polling booth levels. Interestingly, the RSS leadership asked its cadre to deliver Maharashtra in a grand manner as a 'gift' or a souvenir in the run-up to the organisation's centenary. The main INDIA parties had no control over smaller outfits such as the Samajwadi Party (SP), Vanchit Bahujan Aaghadi and the All India Majlis-e-Ittehadul Muslimeen. The 'others' bagged a staggering 17 per cent of the votes; the difference of nearly 11 percentage points in the vote share of the MVA and Mahayuti was just too big. The presence of SP candidates had an adverse impact as reckless Muslim clerics started making tall claims about promises of job quota for Muslims and exemplary punishment for those accused of blasphemy. While mischievous elements indulging in blasphemy or threatening public order deserve no sympathy or leniency, the rule of law entails that punishment can be delivered through the due process. In a nutshell, blasphemy was not a poll issue, but the BJP-Sena network feverishly circulated video and audio clips of Maulana Sajjad Nomani and others to instil a sense of insecurity.

later improvised by Prime Minister Narendra Modi as "ek hain to safe hain". It was baffling that the MVA and non-Mahayuti parties, in order to get the support of Muslims in 40-odd Assembly seats, ended up helping the BJP, even though the majority of the Muslim votes would have easily come their way. The MVA strategy was questionable. For the Congress, poll strategist Sunil Kanugolu, enjoying ministerial status in Karnataka, had reportedly begun preparations in January this year. Kanugolu had stayed away from the Congress' Lok Sabha campaign in order to focus on Maharashtra. Congress managers gave him a considerable amount to run the campaign. More than money, much like in the case of Haryana, Kanugolu was given a free hand. It is an open secret that his inputs and selection of party nominees had come under scrutiny during the Haryana Assembly polls. Yet, Rahul Gandhi and AICC functionaries let him run the Maharashtra

campaign.Accountability and transparency have always been in short supply in the Congress. The party panels appointed to look into the factors for the party's defeat in November-December 2023 Assembly polls in Madhya Pradesh, Rajasthan and Chhattisgarh are yet to submit their reports. The minutes of the Udaipur Chintan Shivir, held in May 2022, are still 'locked' in Jairam Ramesh's laptop without any deliberations in the Congress Working Committee. The grip of Ramesh, KC Venugopal, Randeep Singh Surjewala and Kanugolu over the organisation is so strong that it has started questioning the credentials of the Gandhis and Kharge. Agnipath shadow over India-Nepal defence relations

CHIEF of Army Staff (COAS) Gen Upendra Dwivedi's five-day visit to Nepal (November 20-24) — during which the honorary rank of General of the Nepal Army was conferred on him - was marked by efforts to improve military cooperation between the two countries. Sadly, unlike the pre-Agnipath times, the occasion attracted only routine attention in that country. A diplomatic void was created when India introduced restrictive terms of engagement under the Agnipath scheme in 2022, different from the traditional long-term service and pension in place since 1947. Nepal signalled its disapproval of the new arrangement, even as both sides have maintained a 'diplomatic lull', pushing the Indian Gorkha Brigade towards a cul-de-sac. Not a single Nepali Gorkha has been recruited since the Covid-19 pandemic.Strangely, Gen Dwivedi arrived at Tribhuvan International Airport in a Bhutan Air flight; in better times, chiefs would come in an IAF aircraft. Still, pomp and ceremony were provided by the Nepal Army. Its second Brahmin Army Chief, Gen Ashok Sigdel, hosted a private dinner for the Dwivedis. Nepali Army Chiefs have traditionally been Ranas, Chhetri Thapas and Thakuris.President Ram Chandra Paudel conferred the honorary rank of General on Gen Dwivedi, a ritual introduced in 1969 by then Army Chief, Field Marshal Sam Manekshaw, popularly known as Sam Bahadur. He created a Gorkha cell in the Army headquarters and initiated welfare measures, including treks by young Gorkha officers to recruitment areas of Nepal. Gen Sigdel will shortly visit New Delhi for an 'exchange ceremony' and will be feted just like Gen Dwivedi.Gen Dwivedi also flew to Pokhara, the hub

He addressed Gorkha veterans about welfare measures, steering clear of Agnipath. He flew to Muktinath Temple, where he rang the Bipin Bell installed by late COAS Gen Bipin Rawat, who was from the Gorkha regiment. Gen Dwivedi's predecessor, Gen Manoj Pande, when asked by Indian journalists after a similar visit to Nepal in 2023 about the future of Gorkha recruitment, had said: "If Nepal does not send Gorkhas, their vacancies will be given to others (non-Gorkhas)". That is precisely what is happening to fill the manpower shortfall from Nepal in 39 Gorkha battalions with Kumaonis, Garhwalis, Nagas and other hill tribes. A Gorkha battalion has 60 and 40 per cent Nepali and Indian-domiciled Gorkhas, respectively.In Pokhara, I met several ex-servicemen who expressed concern over the OROP (One Rank, One Pension) — which, after the five-year review, has increased the pension mainly below and including Havildar rank - and Agnipath. They want their wards to join Agnipath as the last resort - due to 25 per cent re-enlistment even after four years engagement — saying: "Something is better than nothing". A few even suggested taking the matter to court. Delegations of ex-servicemen have presented petitions to Chief District Officers in 77 districts of Nepal and met ministers who have maintained silence on Agnipath.Nepali journalists asked me how the stalemate could be broken. My view is that Nepal and India should immediately start a dialogue on Agnipath — which neither side has raised during bilateral talks. I suggested that India should make an exception for Nepal - ideally exempt it from



Agnipath (as certain specialists in technical and medical units have been) or at least raise the terms of engagement for Nepali Gorkhas to seven years and 50 per cent retention. A general review of Agnipath is in progress.

Agnipath does not create a level playing field for Nepali Gorkhas. Nepal's economy is small; its nationals have been barred since the 1970s from joining India's paramilitary forces, which have reserved jobs for demobilised Indian Agniveers. Nepal fears that demobilised soldiers will be an easy catch for dormant insurgent groups. In Nepal's Parliament, former ministers called India's unilateral alteration to the terms of engagement a violation of the 1947 tripartite treaty on recruitment between Nepal, UK and India, which legally it is not. India could have been gentle and diplomatic about the bolt from the blue. A Nepali ex-serviceman, who is also a politician, told me that India wants to terminate recruiting foreign nationals into its Army to undo the

colonial legacy and also have leverage with Nepal. Many believe NSA Ajit Doval was the architect of the project. Nepali communist politicians have long wanted to stop recruitment in foreign armies, and as they represent the majority in Parliament, Agnipath appears to be a closed issue. This is not the first time India has sought to stop Gorkha recruitment. In the 1970s, a proposal was mooted but quickly rejected by then PM Indira Gandhi on the recommendation of then Army Chief Gen GG Bewoor, who belonged to 11 Gorkha Rifles. The present Chief of Defence Staff, Gen Anil Chauhan, was also with Gorkha Rifles. The Nepal Army celebrates its Raising Day annually in Delhi, recalling joint India-Nepal military activities with an audio-visual presentation including PM Modi's 2014 statement in Nepal's Parliament: "In all the wars India has fought, Nepalis have shed their blood." His words are the greatest tribute to Nepal and its Gorkhas. But the Agnipath scheme is a rollback of that strategic sentiment.Some former Indian ambassadors to Nepal have asserted, many of them in writing, that Gorkha ex-servicemen in Nepal constitute a pro-India constituency at a time when China is buying up strategic space with Leftleaning Nepali governments. Gorkha ex-servicemen, at times, have acted as a foil to anti-India sentiments. The recruitment of Nepali Gorkhas is not simply the hiring of foreign soldiers but creating a strategic bond between two sovereign countries and providing a foundation for defence cooperation between their armies, which the two Army Chiefs periodically sanctify. Gen Dwivedi just did this. But with Nepal, India's political leadership needs to go beyond rituals.

Kids with disability don't affect couple's Divorce Risk

Couples raising a child with developmental disabilities do not face a higher risk of divorce, especially if they have larger families, as compared to those couples raising typically developing kids, new research has found.

Parenting a child with a developmental disability involves challenges and rewards that are unique to each family and prior research has shown that parents of a child with a developmental disability tend to experience greater marital stress compared to peers raising typically developing children. As a result, there has been "a conception that, in general, parents of children with disabilities are more likely to experience divorce, and we wanted to test that assumption", said first author of the study Eun Ha Namkung from University of

Wisconsin-Madison, in the US. The team used data from the Wisconsin Longitudinal Study that has been following more than 10,000 men and women who

graduated fro



m Wisconsin high schools in 1957 and some of their siblings for more than 50 vears.

The researchers found that about 22 percent of parents with a child with developmental disability experienced divorce over the span of the study.

They also found that among couples with children without any disabilities, the risk of divorce was lowest for couples with one child and increased with each successive child

In contrast, the risk of divorce for parents of children with developmental disabilities remained unchanged with increasing family size.

"Our results clearly show that the effects of having additional children are different for families of individuals with developmental disabilities compared to the effects on the

Rashmi Raja who owns a six-year-old pug, said, "A festive day like Diwali also means one has to be more attentive towards one's pet."

For my pet's sake There are some people who prefer a cracker-free Diwali. Pradeep Tiwari who owns a three and a half year old German Shepherd, said, "Ever since Sheru became part of our family, we have not burst crackers in order to ensure that he is comfortable. We keep the windows closed to create a protected environment and never leave him unattended." Meghna Kumar who owns a Pomeranian, said, "My Pom, Goli,



is very disciplined. She feels comfortable with my mom and stays with her during the festive period. However we only buy a packet of phuljhhadi and chakri so that our pet is not hassled by the noise. In fact Goli sits besides my mom while we burst the

crackers. We ensure that she remains at a specific distance to avoid accidents."

Feed them and keep them in a protected room

Most festivals bring in lot of engagements that might lead to pets staying unattended at times. So it is essential to ensure that the pet does not starve while you are busy attending to guests. From Arun Jaitley to Ajay Maken, Power with Parliament: Supreme Court upholds 'secular', 'socialist' in Preamble

►The Supreme Court rejected petitions challenging the inclusion of 'socialist' and 'secular' in the Preamble, affirming Parliament's authority to amend the Constitution under Article 368.

New Delhi. The Supreme Court on Monday refused to entertain petitions challenging the inclusion of the words 'socialist' and 'secular' in the Preamble to the Constitution The court further addressed the argument of India through the Constitution (Fortysecond Amendment) Act of 1976.A bench led by Chief Justice of India (CJI) Sanjiv Khanna observed that the writ petitions did

not warrant detailed adjudication as the flaws and weaknesses in the arguments were evident and manifest. The court noted that the expressions 'secular' and 'socialist', along with the word 'integrity', were incorporated into the Preamble through the Forty-second Amendment Act of 1976.

"Article 368 of the Constitution permits the amendment of the Constitution. The power to amend unquestionably rests with Parliament and extends to the Preamble. Constitutional amendments can be challenged on various grounds, including violations of the basic structure doctrine. However, the fact that the Constitution was adopted, enacted, and given to themselves by the people of India on November 26, 1949, does not limit or restrict the power conferred under Article 368," the court said.

regarding retrospectivity, noting that if such an argument were accepted, it would equally apply to amendments made to any part of the Constitution. It emphasised that



Parliament's authority under Article 368 is incontrovertible and unchallenged.The bench also observed that while the Constituent Assembly initially did not include the terms 'socialist' and 'secular' in the Preamble, the Constitution is a living document, and Parliament has been empowered to amend it in accordance with Article 368. Highlighting the delay in filing the petitions, the court pointed out that the challenge came 44 years after the words 'socialist' and 'secular' were added to the Preamble. It noted that these terms have since been widely accepted, with their

meanings clearly understood by "We, the people of India". The court stated that the additions to the Preamble have neither restricted nor impeded legislation or policies pursued by elected governments, provided such actions did not infringe upon fundamental or constitutional rights or violate the basic structure of the Constitution."There is no legitimate cause or justification for challenging this constitutional amendment after nearly 44 years," the court remarked.Regarding secularism, the court explained that India has developed its unique interpretation, where the State neither supports any religion nor penalises individuals for practicing their faith. This principle is enshrined in Articles 14, 15, and 16 of the Constitution, which prohibit discrimination on religious grounds while ensuring equal protection of laws and equal opportunities in public employment. The Preamble's original ideals-equality, fraternity, justice (social, economic, and political), and liberty (of thought, expression, belief, faith, and worship)-align with this secular ethos.

NEW DELHI: From Arun Jaitley to Ajay Maken, the presidency of the Delhi University Students' Union (DUSU) has served as a launchpad for many political leaders.Jaitley, the late veteran BJP leader, was elected DUSU president in 1974 during the politically charged Emergency era. An Akhil Bharatiya Vidyarthi Parishad (ABVP) candidate, his tenure was marked by a resistance against authoritarianism. Decades later, as Union finance minister, Jaitley spearheaded transformative economic policies, including the introduction of the Goods and Services Tax (GST). Six years after he won the president post at DUSU in the 1970s, Jaitley joined the BJP.Another ABVP stalwart, Vijay Goel, who served as DUSU president in 1977, also carved a niche in Delhi's political scene. Goel was the former Union sports minister and a four-time Member of Parliament.

The younger generation of ABVP leaders includes Nupur Sharma, who was DUSU president in 2008. Sharma became the BJP's spokesperson but was suspended from the party over her alleged comments on the Prophet.

From the Congress-backed National Students' Union of India (NSUI), Maken stands out as a trailblazer. After serving as DUSU president in 1985, Maken rose through the ranks to become a Union minister by holding charge of the Ministry of Housing and Urban Poverty in 2012-13. Maken was elected as a member of the Delhi Assembly after he won the DUSU president post in 1985.

In recent times, Rocky Tuseed, who won the DUSU presidency in 2017 as an NSUI candidate, was given a ticket to contest the Delhi Assembly election from the Rajinder Nagar constituency in 2020. Though he finished third behind the Aam Aadmi Party's Raghav Chadha, Tuseed remains one of the recent DUSU leaders to have contested a major election. Tuseed is now serving as national secretary of the Congress's youth wing. The DUSU election threw up a split verdict this year with two seats each on the central panel going to the NSUI and the ABVP. The NSUI clinched the coveted post of president as well as joint secretary, ending its seven-year dry spell at the helm of the students' union.

Stray Bull Injures 15 In Uttar Pradesh, Caught **After 3-Hour Chase**

New Delhi: In Jalalabad, a town in Uttar Pradesh, people are petrified of bulls. They have seen the horror unfold - a stray bull chasing people, hitting them with horns and picking and throwing them. Though the bull is caught, the fear resides within. Are you wondering, what happened?In Jalalabad town, a bull was seen following a man, in the middle of traffic. The bull hit the man from behind, making him fall to the ground. Before he could get up, the bull hit him again on his hips. He jumped, rolled and fell flat on the ground. The



man was injured in the eye. In a now-viral video, the man is visibly injured, with blood around his left eye. He is not alone. The bull entered the streets, caused a stampede and attacked and injured 15 people. After an hour of horror, the Jalalabad Municipal Council laid a ap to catch the bull. However, it managed to dodge the Municipal Council's vehicle and escape. But the efforts to catch hold of the wild bull continued for three hours till it was finally caught.In a similar incident earlier this month, a bike rider was injured after a bull ran into the bike near Supertech Oxford Square, Sector 16-B in Greater West. A video of the incident, which went viral, showed a biker riding in his lane at a decent speed. Suddenly, a black bull comes in front of the bike and hits it with his head. The biker loses control of the vehicle and falls.

Sambhal violence Godhra-like conspiracy, arrest Samajwadi MP: Union Minister

NEW DELHI: As the political blame game over the violence in Uttar Pradesh's Sambhal amid a mosque survey intensifies, Union Minister Giriraj Singh on Tuesday said that the incident is part of a larger conspiracy and called for the arrest of Samajwadi Party MP Ziaur-Rahman Warq.He compared the incident to the 2002 Godhra train torching, which killed 59 Hindu pilgrims and karsevaks."This incident happened because of the opposition. It is a pre-planned strategy by the

opposition, similar to the Godhra incident. This was not just an attack on the survey team but an attack on the Constitution of India and democracy," the Union Minister of Textiles said.He further alleged, "They want to burn the country. They want to turn Sambhal into Bangladesh. Those who died were shot by the attackers, not the police. This has been confirmed by the postmortem report. The country won't tolerate this," Singh said.He also demanded the arrest of Sambhal MP



and Samajwadi Party leader Zia-ur-Rahman Warq, who has been named as the primary accused in a case related to the violence that killed on Sunday. Why are Akhilesh Yadav and Rahul Gandhi silent on this incident?" he asked.On the Samajwadi Party's plan to send a 12-member delegation to Sambhal, Singh described it as an attempt at provocation."An attempt is being made to provoke once again by sending a political delegation to Sambhal. Akhilesh Yadav and Rahul Gandhi always indulge in politics over such incidents," Giriraj Singh said.Massive violence broke out on Sunday when a large crowd opposed a court-ordered

survey of the Shahi Jama Masjid. The survey was initiated based on a complaint claiming that an ancient temple had been demolished to build the Mughal-era mosque.The mob clashed with police, pelting stones, and the police opened retaliatory fire, leading to over three hours of chaos.Police allege that Samajwadi Party MP Warq incited the violence, citing his

remarks two days before the incident. However, Warq and his party rejected the allegations. Warq claimed the survey was conducted without prior notice and accused the district administration and police of being responsible for the violence.The district authorities and police have denied these allegations, asserting that advance notices were issued on time. The Samajwadi Party chief Akhilesh Yadav accused the BJP and the Yogi Adityanath government of "creating the riots" to divert attention, while the BJP claimed the opposition has been inciting violence.

After SC rap, Delhi Police urge people to avoid firecracker use in wedding season

New Delhi. Even as the Supreme Court measures under Stage 4 of the Graded Response Action Plan (GRAP) to deal with air pollution in Delhi will continue for the time being, Delhi Police officials said they are sensitising people against the use of firecrackers in the ongoing winter wedding season."We are sensitising the public and briefing owners of marriage venues and banquet halls to avoid firecrackers," Ankit Singh, Deputy Commissioner of Police (DCP), Dwarka, said. Other police officials said they have yet to receive any formal complaints about the use of firecrackers during weddings in the national capital. Delhi's air quality index (AQI) has fluctuated between the 'very poor' and 'severe' categories ever since the GRAP-IV was enforced on November 18. And despite the ongoing ban on firecrackers in

Delhi had no 'good' air day this year, none expected until December-end

NEW DELHI:Delhi breathed its cleanest air this year in August when the average Air Quality Index (AQI) was 52. Yet, it fell short by two points required for a 'good' day, as per national standards. According to the Central Pollution Control Board (CPCB), a 'good' air day is when the AOI is below 50. Delhi has not had a single 'good' air quality day so far this year. With the current pollution levels and the air quality fluctuating between 'severe' and 'very poor' so far this month, it is unlikely the Capital will have a good day before next year.On Monday, after a brief respite, Delhi's AQI returned to the 'very poor' category from 'poor' by noon. With an AQI of 349, the city was the second most polluted, closely behind West Bengal's Durgapur (AQI of 360).

- Notably, this is the first year after 2018 when Delhi recorded no 'good' air days. There were no 'good' air days in 2016, too.Since 2016, the lockdown year of one in March and four in August. However, by 2021, this number had come down to one day in October but improved a tad to three 'good' days - one in September and two in October - in 2022. However, 2023 saw only a single clean-air day, in September.
- Delhi reports the cleanest air during the monsoon season compared to the rest of the year, according to CPCB data. This explains the concentration of 'good' air days between August and October. Meteorological factors can lead to a lowering of pollution levels in pre-winter months.According to the India Meteorological Department data, Delhi received no rain so far this month. In contrast, there were four rainy days in 2023. Further, since 2016, there have been instances of November rain in 2018, 2019 and 2020.As per AQI trends over the past 10 years, the AQI at best has fallen to around 130, and not less in November and December. As a result, the year-end months record only 'moderate', 'very poor', 'severe' and 'severe plus' AQI days.

"Ego Issues": Top Army Officer's **Controversial Review Of Women Colonels**

New Delhi: Nearly two years after the Army promoted 108 woman officers to the rank of Colonel after Supreme Court's landmark judgment, a top general has listed "mundane ego issues" and "lack of empathy" among what he calls "serious Lt General Puri has said that the Colonelconcerns" in his review of eight Colonelrank women officers under his command. Lieutenant General Rajeev Puri, who completed his tenure as commander of 17 Mountain Strike Corps on November 20, has written to General Officer Commanding-in-Chief, Eastern Command, Lt General Ram Chander Tiwari, listing findings of a vastly critical "in-house review".Defence sources, however, have told that the Army is committed to the induction of women officers and that the senior officer's suggestions are meant to improve training standards.Lt General Puri has pointed to "serious concerns regarding interpersonal relations" and a "lack of tact and understanding" among the Colonel-rank women officers. The report also noted an "exaggerated tendency to complaint" and

"mundane ego issues which spiral out of control".Woman officers now command units such as air defence, signals, ordnance, intelligence, engineers and service corps

rank women officers have a "my way or highway kind of approach to decision making" and are "not trained to be commanders"."During the last one year, there has been an increase in the number of officer management issues in units commanded by women officers. These are indicative of serious concerns regarding interpersonal relations. Most cases pertain to lack of tact and understanding of the personal requirements of unit personnel, especially officers. The emphasis is more on conflict termination through might, rather than conflict resolution through mutual respect. A prejudice and mistrust was evident in few of the cases in the recent past," the senior officer wrote in the letter dated October 1. This, he said, was leading to "high levels of stress in the units. Lt



General Puri also highlighted "an uncontrollable urge to make derogatory statements regarding junior officers to usurp credit rather than attributing it to subordinates and encouraging them is routine". He also noted a "serious misplaced sense of entitlement" in some women officers and said they sought "immediate gratification for minor achievements". A Supreme Court in 2020 cleared permanent commission for women in the Army and paved the way for them taking up command roles. In

February last year, a special selection board was put together to promote 108 women officers to the rank of selectgrade colonel.In his letter, Lt General Puri has called for a focus on "gender neutrality" instead of "gender equality" to address the concerns he has raised about the Colonel-rank woman officers. The senior officer noted that the postings of these women Colonels did not expose them to command roles. The woman officers have not been exposed to operational tasks and this has led to a "lack of understanding of hardships and resultant lack of compassion for the troops involved in these tasks".Explaining the factors that contribute to this approach, Lt General Puri has written, "The desire to prove oneself in a field which was supposed to be a male bastion is likely a driver behind the over-ambitiousness in some women COs... In order to be perceived as strong individuals and avoid being judged as soft-hearted, women COs handle HR issues with a firmer hand than their male counterparts."

A new study has found that kids from <u>high socioeconomic</u> background are more likely to rely on parental help as adults.

uthor Anna Manzoni of the North Carolina State University said that she wanted to know how young adults become independent of their parents, adding that she ended up focusing on what he called 'partial independence,' when people don't live with their parents but still get financial support from them.

In the study, Manzoni looked at data on 6,471 people between 18 and 32 who participated in the National Longitudinal Study of Adolescent to Adult Health and found that 41.4 percent of the participants who were between the ages of 25 and 32 when the study conducted its most recent interviews in 2008 still relied on financial support from parents.

Manzoni said that those who attended four-year colleges and those from higher socioeconomic backgrounds were much more likely to be partially independent in their early 20s. However, people who attended college were more likely to become financially independent as they reached their late 20s and early 30s.

She said that this was especially true for people who paid their own way through college, adding people whose parents supported them financially throughout college were also more likely to move back in with their parents at some point.

Even if your five-year-old kid does not know what money can buy for him or her, the moment he or she gets to know the value of it, chances are the knowledge may make him or her less philanthropic in nature, says an interesting research.

"Money is a double-edged sword. It produces good outcomes in terms of concentration and effort but bad outcomes when it comes to helping, taking, and donating." said professor Kathleen Vohs from the University of Minnesota and co-author of the study. For this, the researchers conducted five experiments and one study involving 550 children (ages three-six) in Poland and the US.

In one experiment, the children were asked to either sort

Amazon Japan raided over alleged anti-monopoly violation

- TOKYO. Amazon Japan's offices were raided by authorities Tuesday over an alleged anti-monopoly law violation, a source said, with the e-commerce giant accused of abusing its industry dominance to drive down prices. The Japan Fair Trade Commission conducted an on-site inspection of Amazon's Japanese subsidiary in Tokyo, reportedly its third probe into the company over domineering behaviour. This time, the focus was on what is known as the "buy box" -- a coveted spot on the Amazon.co.jp website that allows products to be featured prominently.
- Competition for the spot is intense, with sellers offering the same product treating it like a "matter of life and death", the source, who declined to be identified, told AFP."We've been told that whether they can secure the 'buy box' makes a huge difference in terms of sales," he said Sellers have been pressured to lower prices to give Amazon a competitive edge over rival e-commerce sites, or forfeit their right to the buy box, the source said. The US company is also accused of using the buy box to make sellers use inhouse logistics services for everything from packing to order processing and shipping. Such tactics can constitute "abuse of a dominant position" and "transactions with binding conditions", both banned by Japan's anti-monopoly law, the source said.

Amazon Japan told AFP that it will "fully cooperate with the Fair Trade Commission's investigation".

Globally, Amazon last year reported net profit of more than \$30 billion on revenue of \$575 billion, powered by its online retail operation and its cloud computing division. Amazon's businesses include retail, advertising, and streamed movies and music -- a model that also has the 30-year-old company facing a US government lawsuit, accused of expanding an illegal monopoly and otherwise harming competition.

Byju's under scrutiny again: Government launches new investigation into finances

FDI inflows surge 38% to \$14.3 bn in first half of current financial year

NEW DELHI. The net foreign direct investment (FDI) inflows in the current financial year rose from \$10.4 billion in the first half of FY24 to \$14.3 billion in the same period of FY25, a year-on-year increase of 37.6%, as per a finance ministry report.

Significant contributions came from sectors such as manufacturing, financial services, electricity and energy, and communication services, which collectively made up nearly two-thirds of the gross FDI inflows. Singapore, Mauritius, the Netherlands, the UAE, and the US were sources for about threefourths of the flows. "Though cumulative net FDI inflows in H1 of FY25 were greater than those in the



same period of the previous year, there was an outflow of net FDI in September 2024 due to a significant increase in repatriation and disinvestment, which exceeded the gross FDI inflows during that month," the report said.

Meanwhile, the report cited heightened geopolitical tensions and recent developments in China for the withdrawal of significant funds from Indian equities. After seeing net inflows for five consecutive months, foreign portfolio investors became net sellers in October, it stated.During FY25, rupee was recognised as one of the most stable currencies, remaining within a narrow range of 84.3 to 84 per dollar from April to October 2024, it said. While the Adani Group has denied the charges, calling them 'baseless' and announced plans to pursue legal remedies, the fallout from global deals has been swift and widespread.

Seven all out! Ivory Coast record lowest ever men's T20 international score

New Delhi. Nigeria routed Ivory Coast by a staggering 264 runs in a T20 World Cup Sub-Regional Africa Qualifier Group C match on Sunday. The Ivory Coast's total of just seven runs shattered the record for the lowest-ever score in men's T20 international cricket, surpassing the previous mark of 10 runs, jointly held by Mongolia and the Isle of Man.Playing at Lagos' Tafawa Balewa Square Cricket Oval, Nigeria's Selim Salau lit up the stage with a blistering knock of 112 off just 53 balls, studded with 13 fours and two sixes. Supported

by half-centuries from Sulaimon Runsewe (50 off 29 balls) and Isaac Okpe (an unbeaten 65 off 23 balls), Nigeria posted an imposing 271 for 4 the highest score of the tournament so far.In response, Ivory Coast's batting unravelled spectacularly. Opener Ouattara Mohamed was the only batter to manage a meaningful contribution,



scoring four runs. The rest of the lineup folded in just 7.3 overs, with six batters falling for ducks. Left-arm spinner Isaac Danladi and pacer Prosper Useni claimed three wickets apiece, with Peter Aho and Sylvester Okpe chipping in to complete the rout. This historic capitulation marked the first single-digit total in men's T20Is. The 264-run defeat is now the third-largest margin in the format, trailing Zimbabwe's 290-run win over Gambia in October and Nepal's 273-run triumph over Mongolia at the 2023 Asian Games.

In contrast, McSweeney, 25, has just debuted in Tests, with fewer domestic appearances across formats."Chappell praised the role of Rahul Dravid, who has been instrumental in shaping India's junior cricket programs. Under Dravid's leadership, India's focus on red-ball cricket at the grassroots level has paid dividends. "India's system prioritises longform cricket at the youth level. This ensures players are well-versed in the nuances of the game.
