10 arrested in major crackdown on terror networks in J-K's Kathua

Jammu, Nov 27: Ten over ground workers (OGWs) of terror groups were arrested on Wednesday during a massive crackdown aimed at dismantling the terror ecosystem in Kathua district of Jammu and Kashmir, police said. The sweeping operation at 17 locations was jointly conducted by police and CRPF in general area of Malhar, Bani and upper reaches of Billawar besides border areas of Kana chack, Haria chack, Spral Pain and Chack Wajir Lahbju to uncover networks providing logistic and financial aid to terrorist groups, a police spokesperson said. He said meticulously planned raids in connection with three FIRs related to terror incidents registered at police stations Malhar, Billawar and Bani led to the identification and arrest of 10 OGWs and terrorist suspects. A number of electronic devices were also seized during the searches, the spokesperson said. Recently, three foreign terrorists affiliated with Jaish-e-Mohammad (JeM) outfit were killed in two different encounters with security forces in the upper reaches of Kathua district and its fringe area with Basantgarh in Udhampur district, causing serious setback to terror groups who have stepped up their activities in the district this year. Over the past few days, police in Jammu region had intensified its crackdown on terror networks linked to JeM and Lashkar-e-Taiba (LeT) by conducting over 56 raids in various other districts including Rajouri, Poonch, Udhampur and Reasi. The large-scale operation resulted in the arrest of several OGWs and terror suspects, along with the recovery of incriminating materials, including electronic devices, documents, unaccounted cash, weapons and ammunition. "Investigations will continue based on the material and information gathered during the raids. Further operations are planned to target any remaining elements attempting to disrupt peace in the region,' Additional Director General of Police (ADGP) Jammu Zone, Anand Jain had said.

Hemant Soren to take oath as Jharkhand's 14 CM today

Ranchi, Nov 27: Hemant Soren will take oath as the 14th chief minister of Jharkhand at the Morabadi Ground today. Adani denies bribery charges by US court: Rahul

New Delhi, Nov 27: Fresh controversy erupted on Wednesday on billionaire Gautam Adani's indictment in the US court for alleged bribery with the industrialist denying all corruption allegations. The Congress hit back asking whether Adani was expected to accept the accusations. "Do you expect Adani to accept the charges," Leader of Opposition in Lok Sabha Rahul Gandhi said outside Parliament just hours after Adani Green in a fresh listing at the Bombay Stock Exchange and National Stock Exchange denied all bribery allegations. Referring to reports alluding to the US court indictment of Adani over bribery, Adani Green said at BSE on Wednesday: "The reports which state that certain of our directors namely Mr. Gautam Adani, Mr. Sagar Adani and Mr. Vneet Jaain have been charged with violations of the U.S. Foreign Corrupt Practices Act ("FCPA") in the indictment are incorrect. Mr. Gautam Adani, Mr. Sagar Adani and Mr. Vneet Jaain have not been charged with any violation of the FCPA in the counts set forth in the indictment of the US DOJ or civil complaint of the US SEC. These directors have been charged on three counts in the criminal indictment namely (i)



Ahead of that crucial meeting in New Delhi tomorrow, caretaker chief minister of Maharashtra and Shiv Sena chief Eknath Shinde spoke to the media and said he had phoned Prime Minister Narendra Modi and Amit Shah and told them that his party will go by what they decide about the CM. "I told both PM and Amit Shah that I will not serve as an obstruction in the path of government formation and



that the Shiv Sena will accept whatever decision the top BJP leadership takes," Shinde said in Mumbai today He, however, made it clear that the final decision on the Chief Minister-ship will be taken once "Mahayuti allies meet Amit Shah tomorrow and hold detailed discussions before a final call is taken on the matter." Shinde also called himself a people's Chief Minister today and said he worked for common citizens of Maharashtra.

Opposition members storm out of Waqf panel meeting

New Delhi, Nov 27: Opposition members on Wednesday stormed out of the meeting of the joint parliamentary committee examining the Waqf (Amendment) Bill, alleging that its proceedings had become a mockery. They, however, returned to attend the meeting after an hour amid indications that the committee chairperson would seek an extension in its term. Sources said the panel's tenure might be extended till the first week of the Budget Session, adding that a final decision would have to be taken by the Lok Sabha. Earlier in the day, Gaurav Gogoi of the Congress, A Raja of the DMK, Sanjay Singh of AAP and Kalyan Banerjee of the TMC protested the conduct of committee chairperson Jagdambika Pal, alleging that he was keen to wrap up its proceedings by the November 29 deadline without completing due process. Lucknow, Nov 27: Uttar Pradesh Government on Wednesday removed Jhansi medical college's principal and suspended three staff members after a four-member committee submitted its report on the November 15 fire incident that claimed lives of 10 children. The action was taken by Deputy Chief Minister Brajesh Pathak, who also holds responsibility of the Health department. Based on the report of the four-member committee, constituted on the instructions of Pathak, the principal of Maharani Laxmi Bai Medical College in Jhansi district has been removed, officials said. "Based on the committee's investigation, college principal Dr Narendra Singh Sengar has been removed from the post. He has been attached to the Directorate General of Medical Education Department. Chief Medical Superintendent Dr Sachin Mahur was given a charge sheet," they said. The college's junior engineer (electrical) Sanjeet Kumar, NICU ward's nursing sister in charge Sandhya Rai and chief superintendent Dr Sunita Rathore were immediately suspended, they said.

SC rules against religious conversion for quota benefits

New Delhi, Nov 27: In a significant verdict, the Supreme Court has said religious conversions undertaken solely to avail reservation benefits without genuine belief amounted to a "fraud on the Constitution". Justices Pankaj Mithal and R Mahadevan passed the verdict on November 26 in a case filed by one C Selvarani and upheld a Madras High Court decision of January 24 denying a scheduled caste certificate to a woman who converted to Christianity but later claimed to be a Hindu to secure benefits. employment Justice Mahadevan, who wrote the 21-page verdict for the Bench, further underscored that one converted to a different religion, when they were genuinely inspired by its principles, tenets and spiritual thoughts. "However, if the purpose of conversion is largely to derive the benefits of reservation but not with any actual belief in the other religion, the

same cannot be permitted, as the extension of benefits of reservation to people with such ulterior motives will only defeat the social ethos of the policy of reservation," he noted. The evidence presented



ly demonstrated that the appellant professed Christianity and actively practiced the faith by attending church regularly. "Despite the same, she claims to be a Hindu and seeks for a SC community certificate for the purpose of employment," it noted. "Such a dual claim made by her," said the Bench "was untenable and she cannot continue to identify herself as a Hindu after baptism". The top court, therefore, held the conferment of sched-

uled caste communal status to the woman, who was a Christian by faith, but claimed to be still embracing Hinduism only for the purpose of availing reservation in employment, "would go against the very object of reservation and would amount to fraud on the Constitution". The top court underlined a religious conversion solely to access reservation benefits, without genuine belief in the adopted religion, undermined the fundamental social

objectives of the quota policy and her actions were contrary to the spirit of reservation policies aimed at uplifting the marginalised communities. Selvarani, born to a Hindu father and a Christian

mother, was baptised as a Christian shortly after birth but later claimed to be a Hindu and sought an SC certificate to apply for an upper division clerk position in Puducherry in 2015. While her father belonged to the Valluvan caste, categorised under scheduled castes, he had converted to Christianity, as confirmed by documentary evidence. The verdict said the appellant continued to practice Christianity, as seen by the regular church attendance, making her claim of being a Hindu untenable. The Bench noted individuals converting to Christianity lose their caste identity and must provide compelling evidence of reconversion and acceptance by their original caste to claim SC benefits. The judgement said there was no substantial evidence of the appellant's reconversion to Hinduism or acceptance by the Valluvan caste. Her claims lacked public declarations, ceremonies, or credible documentation to substantiate her assertions, it pointed out.

Hema Committee report: Kerala HC directs SIT to appoint nodal officer to prevent witness intimidation

KOCHI. The Kerala High Court has directed the Special Investigation Team probing cases registered after the publication of the Justice Hema Committee report to appoint a nodal officer. The victims and witnesses shall contact the officer in cases of harassment by the accused or any other individuals.A Division Bench comprising Justice AK Jayasankaran Nambiar and Justice CS Sudha also directed the SIT to give



adequate publicity to the name and contact details of the nodal officer. The move will help the victims or witnesses to immediately report instances of threat or intimidation during the pendency of the investigation. The Court issued the order when the counsel representing the Women in Cinema Collective (WCC) submitted that many of the victims faced such issues. WCC also expressed that there is a need for a mechanism to ensure the safety of witnesses and victims."The SIT shall also file a report regarding the steps taken and the action taken by the nodal officer, if any. The nodal officer acts as the first point of contact," said the Bench.

Kerala cops' photoshoot on holy steps kicks up row; ADGP seeks report

PATHANAMTHITTA. A group of police officers on duty at Sabarimala has triggered a controversy posing for a photograph on the 18 holy steps at the hill shrine.ADGP S Sreejith, chief police coordinator, Sabarimala, sought a detailed report on the incident on Tuesday. The incident occurred on Sunday when a group of 30 cops posed for a photograph standing on the steps with their backs to the sanctum sanctorum. The photoshoot went viral and triggered widespread criticism. A group of netizens accused the cops of disrespecting the sanctity of the shrine. Sources said the photo shoot of the cops stationed at the sacred steps happened around 1.30 pm on Sunday after the temple was closed after the rituals. It was taken at the end of the officers' duty, just before a new team assumed responsibilities. t appears that the photo was captured by a

mediaperson present at Sannidhanam. Preliminary inquiries suggest negligence on the part of the officers involved," a source said.Later, Sannidhanam Special Officer K E Baiju was tasked to file a report on the episode following the ADGP's directive.

Hindu organisations up in arms Soon after the controversy, several Hindu organisations have accused the police of breaching the traditions upheld at Sannidhanam. Vishwa Hindu Parishad criticised the act of police personnel alleging that the officers standing with their back to the sanctum sanctorum, was viewed as a disrespectful act.Kerala Temple Protection Samiti state secretary V K Chandran said that



even the head priests and other seniors move backwards, facing the deity, after closing the sanctum sanctorum. He demanded that the authorities should appoint only officers who are Ayyappa devotees for Sabarimala duty.Meanwhile, the Kerala High Court also raised concern over the photoshoot. The High Court said such things cannot be accepted.Meanwhile TDB president P S Prasanth said in Thiruvananthapuram that the incident in which police officers posed atop the Holy Steps at Sabarimala temple was unfortunate. "The Holy Steps are sacred and have ritualistic importance. The young policemen carelessly stood over it," he told TNIE.The president said that the policemen posed for the photograph after completing their ten-day duty at the shrine.

"They were posted on the Holy Steps to help the devotees climb it. They were the best ever batch of policemen deputed for this duty in recent years. During their tenure, an average of 80 devotees climbed the steps in one minute. Sometimes as many as 85 persons climbed the steps," he said.

When asked, Prasanth said the temple thantri has not raised any complaint. The board has not raised any complaint with the police as well.TDB LIKELY TO INCREASE SPOT BOOKING COUNTERS

PATHANAMTHITTA: The Travancore Devaswom Board (TDB) is considering increasing the number of real-time booking counters at Sabarimala due to a large number

of pilgrims failing to show up for their virtual bookings. With around 10,000 virtual slots going unused daily, the board aims to accommodate more pilgrims by expanding spot booking options. Currently, the cap for spot bookings at Pamba, Erumeli, Vandiperiyar, and Sathram is set at 10,000 pilgrims. This limit could be raised if additional counters are opened, according to TDB president P S Prashanth. In addition, the board is exploring the possibility of providing a direct darshan for pilgrims immediately after they climb the 18 Holy Steps. A decision on this will be made before the next annual season, Prashanth said.

HC SEEKS REPORT ON SECURITY ARRANGEMENTS

KOCHI: The Kerala High Court has directed the chief police coordinator, Sabarimala, to file a report concerning security arrangements at the hill shrine in a sealed cover. The court also directed the executive officer, Sabarimala, to inform it about the implementation on the decision to ban the use of mobile phones at Thirumuttam and near the sreekovil. Walking pneumonia' cases rise amid seasonal flu spike in Mumbai

MUMBAI. With temperatures dropping and the season of sniffles setting in, city doctors are reporting a rise in an unusual entity in the city-walking or mild pneumonia-in the past couple of weeks. Walking pneumonia seems like a persistent cold and cough, and patients can continue with their routines. However, a small percentage of these patients could develop full-fledged pneumonia, which typically needs hospital admission and care.

"Right now, I am seeing children and adults coming in with community-acquired bacterial infection that is known as walking pneumonia," said infectious diseases specialist Dr Vasant Nagvekar. Walking pneumonia is also called atypical pneumonia as it is caused by the bacterium Mycoplasma pneumoniae and not usual bacteria, viruses, and fungi; walking pneumonia also cannot be treated with the usual antibiotics, and needs stronger

It's not easy to detect, but the availability of certain rapid tests in the last couple of years has changed that. "Affluent patients



that can detect organisms affecting them, said a senior doctor. "Moreover, these tests give results in a couple of hours, resulting in patients starting on the right medication at the earliest." Walking pneumonia is not

coming to well-known hospitals don't mind worrisome, but doctors in the city don't spending Rs 10,000 to Rs 15,000 on tests suspect the condition as it's not usually seen in patients here. Delhi, with its high level of air pollution, has been reporting it for a few years.Dr Nagvekar said X-ray reports of a few of his patients showed an infection of the upper lung lobes that is typical of

tuberculosis. "But further tests revealed that it wasn't the TB bacillus but Mycoplasma pneumoniae," he said. Meanwhile, data released by the state health department showed that Mumbai has the highest cases of influenza A (caused by H1N1 or swine flu and H3N2) this year, followed by Pune and Nashik. According to the health department, 2,325 influenza patients were found in the state between Jan 1 and Nov 21; of these, 57 people died. Around 45% of these cases (1,055) were from the Mumbai Metropolitan Region, but the region hasn't reported a single

A doctor from a civic hospital said hygiene and hydration would be the best ways to reduce the risk of flu. While the flu vaccine is known to reduce the risk of an infection, there has been poor interest in flu vaccination. The state govt has distributed 45,000-plus flu vaccines in various districts this year for pregnant women and patients with chronic diseases such as diabetes and hypertension, but only 2,608 people have taken them so far.

Agriculture dept to soon launch Ashraya centres for Kerala farmers



THIRUVANANTHAPURAM. In a first of its kind in the country, the state agricultural department has formed 'Ashraya centres' in line with the Akshaya centres in the state. Through the Akshaya centres' essential services are provided to the public, the new initiative Ashraya centres are aimed at providing all digital services related to agriculture to farmers. The government has issued an order in this regard. Though already two digital services are there to help the farmers - a mobile application and a web portal - the government decided to start the Ashraya centres as part of the hundred-day programme. Through this the department intends to provide all digital services to farmers quickly. A nominal fee equal to the fees charged by the Akshaya centre would also be charged in Ashraya centres too. The centres would be started with the help of farmers' groups, Krishisree centres, agro service centres and Karshika Karma Sena.

Infopark connectivity in Kochi set to get major boost

KOCHI. A major complaint raised by Infopark techies is inadequate public transportation facilities, which in turn, leads to issues like insufficient parking space at the IT park. However, things appear brighter for the IT park as a host of infrastructure projects, including the Kochi Metro and phase-2 of the Seaport-Airport Road, are set to become a reality in the near future.Kochi Metro has speeded up construction of its phase 2 extension, the 11.2-km-long Pink Line from its Jawaharlal Nehru Stadium station to Infopark, and promises to meet the August 2026 deadline. It has already started the process to further extend metro connectivity to Infopark phase 2."We're preparing a Detailed Project Report (DPR) for the extension to phase-2 campus. The draft has been finalised," a senior Kochi Metro Rail Ltd (KMRL) official said. The Pink Line, having

11 stations, is expected to be the most financially viable section for the KMRL as per the DPR. The highest number of commuters are expected to travel in the section when it gets operational."The construction works are progressing from both ends. Even in the Vazhakkala stretch, the widening activities are nearing completion. We'll erect the barricades once the same is over, and start metro construction works, which will be in full swing in a couple of weeks," the official said. Meanwhile, techies will get a major relief from congested roads and traffic blocks when KMRL introduces the e-feeder service, connecting the Kakkanad Water Metro terminal with Infopark in a week."Currently, registration and testing of 15 new e-feeder buses are progressing and the services will be launched soon. The feeder buses will connect the airport (Aluva-Kochi airport), Medical

College (Kalamassery-Medical College, Infopark-Kakkanad water metro terminal and other destinations that lack transportation," a KMRL spokesperson said. The same will let techies take the water metro from Vyttila hub and reach Infopark in 40 minutes - the time includes the 20-25 minute boat travel allowing them to avoid the congested roads and reach the destination in half the time taken otherwise. "We'll increase the frequency to 20 minutes in the Vyttila-Kakkanad section soon when the second pontoon at Vyttila terminal is built," said another official in charge of the water metro, adding that efforts are also on to connect Infopark phase-2 in the near future. The techies, meanwhile, are looking forward to the e-feeder services. "The feeder buses have been our long-pending demand, and once the buses are deployed, a large number of employees will shift to water

transport. Currently, last mile connectivity is the main issue," said Anish Pandalani, the state president of Progressive Techies, a socio-cultural and welfare organisation of IT employees. However, he rued that bus connectivity is inadequate, and batted for more KSRTC services. "Currently, except for one or two buses, the KSRTC is operating long-haul services only on Fridays. Car runs over toddler playing on road, 1 held

Gurgaon. A two-year-old girl was run over by a pickup van while she was playing in front of her house at Indira Colony in Sector 52 on Monday. The victim, Srishti Basor, was immediately rushed to the hospital, where doctors declared her dead. The driver, Ramjeevan, was arrested after the incident. According to victim's father, Durgesh, the van driver was driving rashly, and alleged driver's negligence caused the accident. "My daughter lost her life due to the rash and negligent driving of the accused," he stated in his complaint."When we were alerted about the incident, our team reached the emergency room of Artemis Hospital, where the victim's father met us. The girl suffered a severe head injury in the accident. She was declared dead on arrival," Sector-53 PS Inspector Sukhbir Singh said.A case was registered under sections 281 (rash driving on a public way) and 106 (causing death due to negligence) of the Bharatiya Nyaya Sanhita (BNS). The body of the girl was handed over to the family after autopsy on Tuesday. "We have seized the pickup van from the accident spot. The accused driver, Ramjeevan Bairwa from Indira Colony-1, was arrested on Monday, and an investigation is underway," police said.

52 bulk waste generators get MCG notices for violations

Gurgaon. MCG has issued notice to 52 bulk waste generators for failing to comply with the solid waste management (SWM) rule. This came after the cell inspected 70 BWGs and found 52 at fault. The body also registered 27 new bulk waste generators on the MCG's portal, bringing the total number of registered BWGs to 248.MCG additional commissioner, Balpreet Singh, said, "The MCG formed BWG Monitoring Cell to inspect bulk waste generators and ensure compliance with waste management rules. Retired colonel Sanjay Pandey has been appointed this cell's chief officer. One inspector has been appointed for each of the four zones in the BWG cell. Over the past week, the cell inspected 70 BWGs, issuing notices to 52 for non-compliance with the rules. The BWGs within the municipal limits that have not registered on the online portal should do so promptly to avoid a fine of Rs 25,000."In July, MCG revised the criteria for identifying BWGs per the Union Ministry of Housing and Urban Affairs guidelines. According to the new guidelines, waste generators that produce "100 kg or more waste daily" will be classified as BWGs against the previous limits of 59 kg or more.MCG officials issued new guidelines to ensure compliance with the sixuid trade of the state of t ministry's directives. 8,749 waste generators in the city produce over 50 kg of waste, including 1,531 residential societies, 1,959 educational institutions, 222 religious institutions, 177 industrial units, 860 welfare societies, etc. However, the MCG has yet to evaluate the waste generators as per the latest guidelines for waste generators.

Why child rescue is a complex task for helpline in city of gated societies

Noida. Earlier this month, a one-and-a-half-year nightmare finally ended for an eight-year-old girl who was rescued from torture by her employers at a flat in Blossom County by a Child Helpline team that was tipped off by another resident of the society. This was a rare operation that went off smoothly in a city of highrises and gated societies that makes the job of child s logistically difficult because tip-offs are hard to follow up since entry into societies isn't straightforward and the perpetrators are part of the 'educated elite'. Child Helpline 1098 is a 24-hour, tollfree phone service for children in need of care and protection. It's a project of the ministry of women and child development. The city team has eight members, whose basic job description is to be available 24x7. And each rescue brings with it unique challenges. Adnan Usmani, the district coordinator, said a tip or complaint first goes to the Delhi head office from where it is transferred to Lucknow, which passes on the information to the Noida team. Information can also come from police's Dial 112. Just from housing societies, the Child Helpline has received 12 tips in the last one year. Two of them could not be rescued because an inspection of their school marksheets revealed they had turned 18. "From the other 10, we managed to rescue 5 children, of whom two were who were being assaulted and tortured. In the other cases, the employers of the children most likely managed to hide them, so we were not able to rescue them," a helpline worker told TOI. "The educated class, aware of labour laws, often rationalises their actions by claiming they are helping the child.

Sector 18 traders say business hit by curbs

Noida. Traders at Sector 18 market say have seen a nearly 20% drop in customers over the past few weeks because of restrictions on cars and people working from home because of high pollution levels. According to the Confederation of All India Traders (CAIT), NCR, restrictions under GRAP stage 4 on vehicular movement have further affected businesses. Consumers, they said, were prioritising health over non-essential shopping. Most queries and purchases have been focussed on mitigating pollution. Around 25 units of air purifiers and nebulisers — priced between Rs 10,000 and Rs 50,000 — are sold daily, said Neeraj Maheshwari of Rhythm House."But sales of garments, footwear, and home furnishings have declined," said SK Jain, president of Sector 18 market association. Jain said restrictions on diesel vehicles have disrupted supply chains, delayed goods transportation, and raised logistics costs as well. Small and medium enterprises are feeling the brunt, he said, especially as pollution curbs coincided with festive and wedding seasons. "The city's business sector is bearing the double burden of pollution and regulatory restrictions," Jain said. Under 'digital arrest', 55-yr-old man made to go from Faridabad to Bihar

Gurgaon. A 55-year-old man who believed a CBI warrant had been issued against him in a money laundering probe, agreed to transfer all his money in a local account for what he believed was an RBI verification and took a train from Faridabad to Bihar to do the same for another bank account before he realised he had been scammed. The plight of the bank clerk, who was put under 'digital arrest' for 56 hours, is yet another example of the hypnotic spell that cyber crooks can put people under by inducing fear and comes a day after police in Mumbai revealed the longest known 'digital arrest' case, of a 77-year-old woman who was asked to stay connected on a call continuously for a month by being similarly targeted with a moneylaundering case and made to transfer money in batches over days. The 55-year-old bank clerk who lives with his family at a condominium in Sector 80, Faridabad, has previously served in the air force. Late night on Oct 5, he had returned home after election duty (the Haryana assembly election was held that day). He received a phone call "from CBI", around 9.50am

had gone to a temple. It was a video call. but at the other end were two male voices. One identified himself as a CBI officer – a DCP - the other as an officer with TRAI (Telecom Regulatory Authority of India). The two told him that another phone number had been activated using his Aadhar card, through which several offences had been committed."I was told on the video call that a warrant was issued against me in a Rs 6.6-crore money laundering case in which a wanted criminal, Nawab Malik, was involved. I was asked to go to the CBI office in Delhi in two hours. When I expressed my inability to do so within that short period, the man posing as a CBI officer threatened to arrest me for noncooperation," according to the police complaint filed by the victim. This scared him, and fearing the worst, he agreed to the alternative – which was to cooperate and do exactly as this 'officer' said. The first step was to check into a hotel to buy himself privacy during the 'probe' and be spared of the humiliation of the family getting to know that CBI was looking into him. The clerk checked into a hotel in



there till the next morning, under 'digital arrest' with the phone call going the entire time. By Oct 7, he had revealed to the 'officer' that he had Rs 5 lakh available in his Punjab National Bank account. He was given an account number and asked to transfer the entire sum there for an investigation. "I was told RBI would verify if the money transferred by me was linked to money laundering, and if they cleared it, the amount would be reverted to my account," the victim told

police. Under continuous pressure, he had also told the 'officer' about another account he had with State Bank of India at Madhubani in Bihar. Since he could not operate this account from Faridabad, he was instructed to immediately go to Bihar. He did."I was asked to visit my native place in Madhubani to initiate another set of fund transfers from my home branch of SBI as I could not do the same from SBI's branch in Faridabad. I reached my native place by train on Oct 8 but could not do the transfer that day. All this while, the fraudsters stayed in continuous contact through video call, the victim said in the complaint. The

stupor broke when some villagers took hold of his phone and called a family member. He returned to Faridabad on Oct 10 and lodged a police complaint. After an initial probe, the cyber police registered a case under section 318 (4) (cheating and dishonestly inducing delivery of property) of the BNS on Nov 25. "We are analysing the details of the bank transactions and phone calls between the victim and the fraudsters to identify them," said a cyber police officer.

Displaced people return to south Lebanon as ceasefire appears to hold

World. Long-displaced residents of south Lebanon started returning to their homes amid celebrations hours after a ceasefire between Israel and the Hezbollah militant group took effect early Wednesday

The ceasefire has brought relief across the tiny Mediterranean nation, coming after days of some of the most intense airstrikes and clashes since the war began, though many wondered if the agreement to stop fighting would hold. Israel has said it will attack if Hezbollah breaks the ceasefire agreement, which was announced Tuesday. Hundreds of cars made their way into southern Lebanon, defying a warning from the Israeli military to stay away from previously evacuated areas.At least 42 people were killed by Israeli strikes across Lebanon on Tuesday, according to local authorities. Hezbollah also fired rockets into Israel on Tuesday, triggering air raid sirens in the country's north. The Israel-Hezbollah ceasefire marks the first major step toward ending the regionwide unrest triggered by Hamas' attack on Israel on Oct. 7, 2023, but it does not address the devastating war in Gaza. Hezbollah began attacking Israel a day after Hamas' attack. The fighting in Lebanon escalated into all-out war in September with massive Israeli airstrikes across the country and an Israeli ground invasion of the south.In Gaza, more than 44,000 people have been killed and more than 104,000 wounded in the nearly 14-month war between Israel and Hamas, according to Gaza's Health Ministry.

Will Trump's White House return lead to new wave of bestselling books

NEW YORK. As she anticipates her estranged uncle's return to the White House, Mary Trump isn't expecting any future book to catch on like such firstterm tell-alls as Michael Wolff's million-selling "Fire and Fury" or her own blockbuster, "Too Much and Never Enough.""What else is there to learn?" she says. "And for people who don't know, the books have been written. It's all really out in the open now."

For publishers, Donald Trump's presidential years were a time of extraordinary sales in political books, helped in part by Trump's legal threats and angered tweets.

According to Circana, which tracks around 85% of the hardcover and paperback market, the genre's sales nearly doubled from 2015 to 2020, from around 5 million copies to around 10 million. Besides books by Wolff and Trump, other bestsellers included former FBI Director James Comey's "A Higher Loyalty," former national security adviser John Bolton's "The Room Where it Happened" and Bob Woodward's "Fear." Meanwhile, sales for dystopian fiction also jumped, led by Margaret Atwood's "A Handmaid's Tale," which was adapted into an award-winning Hulu series.But interest has dropped back to 2015 levels since Trump left office, according to Circana, and publishers doubt it will again peak so highly. Readers not only showed little interest in books by or about President Joe Biden and his family — they even seemed less excited about Trump-related releases.

Mary Trump's "Who Could Ever Love You" and Woodward's "War" were both popular this fall, but neither has matched the sales of their books written during the first Trump administration."We've been there many times, with all those books," HarperCollins publisher Jonathan Burnham says of the various Trump tell-alls. He added that he still sees a market for at least some Trump books — perhaps analyzing the recent election — because "there's a general, serious smart audience, not politically aligned in a hard way," one that would welcome "an intelligent voice.""It's like the reboot of any hit TV show," says Eric Nelson, publisher and vice president of Broadside Books, a conservative imprint of HarperCollins that's released books by Jared Kushner, Florida Gov. Ron DeSantis and Trump Cabinet nominees Pete Hegseth and Sen. Marco Rubio."You're not hoping for ratings like last time, just better ratings than the boring show it's replacing."

Trump promised mass deportations; educators worry fear will keep immigrants' kids from school

World. Last time Donald Trump was president, rumors of immigration raids terrorized the Oregon community where Gustavo Balderas was the school superintendent. Word spread that immigration agents were going to try to enter schools. There was no truth to it, but school staff members had to find students who were avoiding school and coax them back to class."People just started ducking and hiding," Balderas said.

Educators around the country are bracing for upheaval, whether or not the president-elect follows through on his pledge to deport millions of immigrants who are in the country illegally. Even if he only talks about it, children of immigrants will suffer, educators and legal observers said.If "you constantly threaten people with the possibility of mass deportation, it really inhibits peoples' ability to function in society and for their kids to get an education," said Hiroshi Motomura, a professor at UCLA School of Law.

That fear already has started for many.

'The kids are still coming to school, but they're scared," said Almudena Abeyta, superintendent of Chelsea Public Schools, a Boston suburb that's long been a first stop for Central American immigrants coming to Massachusetts. Now Haitians are making the city home and sending their kids to school there.

'They're asking: 'Are we going to be deported?'" said Abeyta.Many parents in her district grew up in countries where the federal government ran schools and may think it's the same here.

Pakistan government's midnight crackdown ends protest by Imran Khan's party in Islamabad

ISLAMABAD. A midnight crackdown by the security personnel forced the supporters of jailed former prime minister Imran Khan to evacuate the D-Chowk and its adjacent main business district of the capital ending their protest, which his party on Wednesday described as a "massacre under the fascist military regime."Police sources said about 450 protestors were arrested in the crackdown and more arrests are expected while Khan's Pakistan Tehreek-e-Insaf (PTI) said it was a violent assault on protesters by security forces firing live rounds with the intent to kill as many people as possible. Earlier on Tuesday evening, PTI supporters battled law enforcing agencies and succeeded in reaching the D-Chowk for a sit-in till their leader told otherwise as part of their protest march to Islamabad that started on Sunday. The supporters' clash with police killed six security personnel and injured dozens.Khan's wife, Bushra Bibi, who was leading the march to Islamabad from Peshawar along with Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur, announced that the protestors would not go

away until Imran Khan, who had given the final call for protest, was released from jail even as security personnel continued their efforts to move them from the area.

Video footage showed Khan's supporters facing tear gas and climbing on the shipping containers placed on the roads leading to D-Chowk, which is located close to several important government buildings: the Presidency, the PM Office, the Parliament, and the Supreme Court.

Around midnight, police and Rangers launched an operation to clear the Blue Area business area, forcing the protestors to move away along with Bibi and Gandapur.Police sources said that about 450 protestors were arrested in the crackdown and more arrests are expected after the end of the protest. Special teams have been formed to arrest PTI leaders, the sources added.Addressing a press conference later at D-Chowk, Interior Minister Mohsin Naqvi said Gandapur and Bushra Bibi had fled away."They ran away in front of you, not one or two or three but thousands of people ran away," he said He said it was a priority to restore the roads



that were closed for traffic in the capital. He also announced that schools would reopen on Thursday."Mobile and internet services will be restored by morning. You will find all roads in working condition by morning," he said, adding that the administration would try to remove all containers by morning.PTI Information Secretary Sheikh Waqas Akram said in a post on X that that "Gandapur and Bibi are safe," according to the information he received from sources he did not disclose. Geo News, however, reported that Bibi and

Gandapur have reached Peshawar, while the party has ended its protest. Information

Minister Atta Tarar also claimed in a press conference that Gandapur and Bibi fled away. "Sadly I must say this was not a final call but a miscall," he said mockingly referring to the 'final call' of Khan for protest." You will not believe how they've run away from here. They've abandoned their cars, sandals and some even their clothes here," he claimed.He alleged that documents were also found detailing a plan to enter the Red Zone to attack

parliament and government property, and target state officials. Tarar said the whole route at D-Chowk was clear and roads were reopening as well.PTI, in a reaction to the crackdown, blamed the government for using violence and killing hundreds of its workers."A massacre has unfolded in Pakistan at the hands of security forces under the brutal, fascist military regime led by the Shehbaz-Zardari-Asim alliance. Israel and Lebanon's Hezbollah start a ceasefire after nearly 14 months of fighting JERUSALEM. The ceasefire between

Israel and Lebanon's Hezbollah militants began early Wednesday as a region on edge wondered whether it will hold. The ceasefire announced Tuesday is a major step toward ending nearly 14 months of fighting sparked by the ongoing war in Gaza between Israel and Hamas.Israel has said it will attack if Hezbollah breaks the ceasefire agreement. The ceasefire calls for an initial twomonth halt to fighting and requires Hezbollah to end its armed presence in southern Lebanon, while Israeli troops are to return to their side of the border. An international panel led by the United States will monitor compliance. The ceasefire began at 4 a.m. Wednesday, a day after Israel carried out its most intense wave of airstrikes in Beirut since the start of the conflict that in recent weeks turned into

all-out war. At least 42 people were



killed in strikes across the country, according to local authorities. The ceasefire does not address the devastating war in Gaza, where Hamas is still holding dozens of hostages and the conflict is more intractable. There appeared to be lingering disagreement over whether Israel would have the right to strike Hezbollah if it believed the militants had violated the agreement, something Prime Minister Benjamin Netanyahu insisted was part

of the deal but which Lebanese and Hezbollah officials have rejected.Israel's security Cabinet approved the U.S.-France-brokered ceasefire agreement after Netanyahu presented it, his office said. U.S. President Joe Biden, speaking in Washington, called the agreement "good news" and said his administration would make a renewed push for a ceasefire in Gaza. The Biden administration spent much of this year trying to broker a ceasefire and hostage release in Gaza but the talks repeatedly sputtered to a halt. President-elect Donald Trump has vowed to bring peace to the Middle East without saying how.Still, any halt to the fighting in Lebanon is expected to reduce the likelihood of war between Israel and Iran, which backs both Hezbollah and Hamas and exchanged direct fire with Israel on two occasions

Indian-American Jay Bhattacharya is Trump's pick to lead USA's top health institute

WASHINGTON. US President-elect Donald Trump has picked Indian-American scientist Jay Bhattacharya as the director of the National Institutes of Health, the country's top health research and funding institutions.

With this, Bhattacharya becomes the first Indian-American to be nominated by Trump for a top administrative position. Earlier, Trump picked Indian-American Vivek Ramaswamy to lead the newly created Department of Government Efficiency along with Tesla owner Elon Musk. However, that is a voluntary position and does not need confirmation from the US Senate.

"I am thrilled to nominate Jay Bhattacharya, MD, PhD, to serve as Director of the National Institutes of Health. Dr. Bhattacharya will work in cooperation with Robert F. Kennedy Jr. to direct the Nation's Medical Research and to make important discoveries that will improve Health,

and save lives," Trump announced."Together, Jay and RFK Jr. will restore the NIH to a Gold Standard of Medical Research as they examine the underlying causes of, and solutions to, America's biggest Health challenges, including our Crisis of Chronic Illness and Disease. Together,



they will work hard to Make America Healthy Again," he said. Bhattacharya is a profssor of Health Policy at Stanford University, a research associate at the National Bureau of Economics Research, and a senior fellow by courtesy at the Stanford Institute for Economic Policy Research, Stanford Freeman Spogli Institute, and the Hoover Institution, according to Trump. He directs Stanford's Centre for Demography and Economics of Health and Aging.

His research focuses on the health and well-being of vulnerable populations, emphasising the role of government programmes, biomedical innovation, and economics.Bhattacharya is a co-author of the Great Barrington Declaration, an alternative to lockdowns proposed in October 2020. His peer-reviewed research has been published in Economics, Statistics, Legal, Medical, Public Health, and Health Policy Journals. He holds an MD and PhD in Economics from Stanford University, Trump said.Trump also nominated Jim O'Neill as the deputy secretary of Health and Human Services to work alongside Robert F. Kennedy Jr.

"He (O'Neill) will oversee all operations and improve Management, Transparency, and Accountability to, Make America Healthy Again," he said.O'Neill previously served as the principal associate deputy secretary of HHS. He led reforms at the FDA to overhaul Food Safety Regulations and implemented the FDA Amendments Act, which improved Drug and Medical Device Safety, and ensured greater protection for Public Health, according to Trump.

Australia's House of Representatives passes bill that would ban young children from social media

MELBOURNE. Australia's House of Representatives on Wednesday passed a bill that would ban children younger than 16 years old from social media, leaving it to the Senate to finalize the world-first law. The major parties backed the bill that would make platforms including TikTok, Facebook, Snapchat, Reddit, X and Instagram liable for fines of up to 50 million Australian dollars (\$33 million) for systemic failures to prevent young children from holding

The legislation passed 102 to 13. If the bill becomes law this week, the platforms would have one year to work out how to implement the age restrictions before the penalties are enforced.Opposition lawmaker Dan Tehan told Parliament the government had agreed to accept amendments in the Senate that would bolster privacy protections. Platforms would not be allowed to compel users to provide government-issued identity documents including passports or driver's licenses. The platforms also could not demand digital identification through a government system."Will it be perfect? No. But is any law perfect? No, it's not. But if it helps, even if it helps in just the smallest of ways, it will make a huge difference to people's lives," Tehan told Parliament.Communications Minister Michelle Rowland said the Senate would debate the bill later Wednesday. The major parties' support all but



guarantees the legislation will pass in the Senate, where no party holds a majority of seats. Lawmakers who were not aligned with either the government or the opposition were most critical of the legislation during debate on Tuesday and Wednesday.Criticisms include that the legislation had been rushed through Parliament without adequate scrutiny, would not work, would create privacy risks for users of all ages and would take away parents' authority to decide what's best for their children.Critics also argue the ban would isolate children, deprive them of

children to the dark web, make children too young for social media reluctant to report harms they encountered and take away incentives for platforms to make online spaces safer.Independent lawmaker Zoe Daniel said the legislation would "make zero difference to the harms that are inherent to social media.""The true object of this legislation is not to make social media safe by design, but to make parents and voters feel like the government is doing something about it," Daniel told Parliament."There is a reason why the government parades this legislation as world-leading, that's because no other country wants to do it," she added.T he platforms had asked for the vote on legislation to be delayed until at least June next year when a government-commissioned evaluation of age assurance technologies made its report on how the ban could been enforced.Melbourne resident Wayne Holdsworth, whose 17year-old son Mac took his own life last year after falling victim to an online sextortion scam, described the bill as "absolutely essential for the safety of our children." 'It's not the only thing that we need to do to protect them because education is the key.

Trump team claims Israel-Hezbollah ceasefire deal brokered by Biden is actually Trump's win

WASHINGTON. The Biden administration kept President-elect Donald Trump's incoming administration closely apprised of its efforts to broker the ceasefire deal between Israel and Hezbollah that is slated to go into effect early Wednesday, according to the outgoing Democratic administration. Trump's team, meanwhile, was quick to spike the football and claim credit for the rare spot of good news for a Democratic administration that's been dragged down by the grinding Mideast conflict."Everyone is coming to the table because of President Trump," Florida Rep. Mike Waltz, Trump's choice for his national security adviser, said in a post on X on Tuesday, shortly before the Israel Cabinet signed off on the agreement."His resounding victory sent a clear message to the rest of the world that chaos won't be tolerated. I'm glad to see concrete steps towards deescalation in the Middle East."

The Biden administration's reported coordination with Trump's team on its efforts to forge the ceasefire in Lebanon is perhaps the highest-profile example of cooperation in what's been a sometimes choppy transition period. Trump's transition team just on Tuesday reached a required agreement with President Joe Biden's White House that will allow transition staff to coordinate with the existing federal workforce before Trump takes office on Jan.20. There has been some coordination on high levels between the outgoing Biden and incoming Trump teams, including talks between Biden's national security adviser Jake Sullivan and Waltz.Biden in Rose Garden remarks on Tuesday cheered the ceasefire agreement as a critical step that he hoped could be the catalyst for a broader peace in the Mideast, which has been shaken by nearly 14 months of war following Hamas' attack on Israel on Oct.7, 2023."This is designed to be a permanent cessation of hostilities," Biden said."What is left of Hezbollah and other terrorist organizations will not be allowed. I emphasise, will not be allowed, to threaten the security of Israel



again."White House officials are now hopeful that a calm in Lebanon will reinvigorate a multi-country effort at finding an endgame to the devastating war in Gaza.Biden said the US, as well as Israel, will engage in talks in the coming days with officials from Egypt, Qatar and Turkey to try to get Gaza talks back on track. But during Biden's moment of success in a conflict that has roiled his reputation at home and abroad, the specter of the incoming Trump administration loomed large. Trump's senior national security team was briefed by the Biden

administration as negotiations unfolded and finally came to a conclusion on Tuesday, according to a senior Biden administration official. The official, who briefed reporters on the condition of anonymity on a call organised by the White House, added that the incoming Trump administration officials were not directly involved in the talks, but that it was important that they knew "what we

were negotiating and what the commitments were."Trump's team and allies, meanwhile, said there was no doubt that the prospect of the Republican president returning to power pushed both sides to get the agreement done. Waltz, in addition to giving Trump credit for the ceasefire deal coming together, added a warning to Iran, Hezbollah's chief financial backer."But let's be clear: The Iran Regime is the root cause of the chaos & Damp; terror that has been unleashed across the region. We will not tolerate the status quo of their support for terrorism," Waltz said in his

Thrissur lorry accident: 'All that I remember was screams,' says Ponnamma, who lost her dear ones

THRISSUR. The victims of the Nattika mishap were in deep sleep when the lorry driven by a drunk person ran over them. While five persons lost their lives and many were injured, those who had a providential escape from the tragedy recalled the horrendous momets of the chilling accident.

"It was in the wee hours. I woke up to the noise of the vehicle crashing onto the median, and loud screams that followed. What I saw was the shattered parts of my family members, who were sleeping next to me. My husband who woke up hearing the melee asked me to get up and run away. I didn't know then what happened as it took a moment to grasp what went wrong," said Ponnamma, who was struggling to control her tears as she waited for the mortal remains of her beloved family members.

Grumbling about the ill-fated moment, Ponnamma said that even though they shouted to stop the vehicle, the lorry didn't stop, crushing those who were in deep sleep. The project was initially called 'Scholor' and then changed into 'Sakhi'.

success of Project Sakhi, an eight-year holistic development programme for adolescent girls. "It is a long-term project where we work with girls, especially from underserved and underprivileged backgrounds, and help them become



resilient and learn skills, which will help in a smoother transition into adult life," says Sameen Almas, director of projects, NalandaWay Foundation.

Unconventional learning

The programme has three phases — first, girls between the ages of 13 and 15 are taught about menstrual health, at 16 and 17, they are imparted sex education, and as they enter adulthood, 18 to 20 years, they are introduced to financial planning. "It is not as structured as the school syllabus but certain topics should be addressed at certain ages. We have a common repository, accessible by every Sakhi facilitator," adds Sameen. These facilitators or mentors are the project's anchor. They have seen the girls grow as an individual, who know their fears. They remain with the group as they move ahead, as after spending an hour thrice a week, for many years, there is also a possibility that the girls will fall back on them. "In many

independent decision-making. The conversations and discussions during the classes lead to the point that the girl has to make the decision herself," she notes.

Eniya, a student in the programme, says, Through Sakhi, I learnt who I am. I understood that I am a person who can keep a room alive and interactive. I can make people laugh and I am happy to know that." Another student, Shobana, says, "I have learnt dancing, miming and other crafts through this project. I also understand about menstruation and I wish to teach it to my juniors."

By juniors, Shobana means the children from the Child Care Institution. Under the same programme, there is a unit called 'SEVA'.

Sameen says, "The girls are going to these homes and working with the children there, to help them learn life skills and others they have learned through the project. We are trying to create a ripple of change and ensure it is a value of what they have received in five years. They should be able to reach out to five more in each of their surroundings."

Under the influence of a cyclonic storm brewing in the Bay of Bengal, heavy rains are likely to lash South Coastal and Rayalaseema districts in the State for the next three days, according to the India Meteorological Department (IMD). 'Number 1' warning has been issued at all ports in Andhra Pradesh.The Deep Depression over the Southwest Bay of Bengal moved northnorthwestwards with a speed of 12 kmph



during the past six hours and lay centred at about 520 km south-southeast of Nagappattnam, 640 km south-southeast of Puducherry and 720 km south-southeast of Chennai at 17:30 hours IST on Tuesday. It is very likely to continue to move northnorthwestwards and intensify further into a cyclonic storm on November 27. Thereafter, it will continue to move north-northwestwards towards the Tamil Nadu coast, skirting the Sri Lanka coast during the subsequent two days.

The Cyclone Warning Centre in Visakhaptnam forecast heavy rains in Nellore and Tirupati districts on Wednesday and in Annamayya, Prakasam, Chittoor, Nellore, and Tirupati on Thursday. Moderate to heavy rains are likely in isolated parts of North Coastal districts.

Home and Disaster Management Minister Vangalapudi Anitha reviewed the situation and directed senior officials to take measures to ensure there is no loss of life or property. 

Arrest illegal': Bombay HC orders Rs 2 lakh payout to cop

MUMBAI. The Bombay high court declared illegal, the March 2013 arrest of a police inspector Sambhaji Patil a recipient of the President's medal, for a faulty probe in a murder case and directed the State to compensate him with Rs 2 lakh. Patil sought an inquiry against the additional superintendent of police, Satara, who had arrested him.In 2004 Patil had also Director General of Police insignia for rendering excellent service.

Pronouncing the judgment on Monday, a division bench of Justices AS

Chandurkar and Rajesh Patil held that the arrest was indeed in violation of the 52 year old police officer's fundamental rights. The HC disposed of Patil's petition that was filed in 2013, when he was 52 years old.The HC after hearing both sides and perusing all the record, held that after arresting Patil "without an arrest warrant" the officer



A police officer arresting without a wrrant is required to take the person arrested before a magistrate or before the officer in charge of a Police Station, without unnecessary delay. Additional SP Amol Tambe, who had effected Patil's arrest did not, the HC noted and directed State to compensate him in eight weeks. The HC said the State may recover the Rs 2 lakh pay out from officers found derelict in their duty

120kg of dried shark fins, seahorses seized in Tamil Nadu; two held

CHENNAI. The Directorate of Revenue Intelligence (DRI), Chennai zone, seized 95 kg of shark fin and 25 kg of sea horse, both in dried form, from a location in Tiruvottiyur in north Chennai and arrested two people on Friday.According to sources, the case was transferred to the forest department for further investigation as it is believed to be part of a bigger operation. Though the exact estimates were not given, the consignment is believed to be priced upwards of Rs 50 lakh. The products were found inside sacks.Follow-up searches were conducted at a firm's office in Triplicane and later in Ramanathapuram as well, sources added. Investigation is underway to find out the source of supply and the intended destination. Seahorses and some species of sharks are covered under Schedule 1 and 2 of the Wildlife Protection Act. Possession of shark fins would amount to hunting them and hence is prohibited under the Act.

Each truck reportedly paid Rs 700 to Rs 2,000 depending on the load they were carrying. After gathering evidence, Golanthara police registered a case and arrested the three agents and two officials. They were later produced in court. The SP said further investigation is underway and efforts are on to nab other agents and staff of Transport department involved in the illegal act.

Ominous escalation in Russia-Ukraine war

THE Russia-Ukraine war crossed the 1000-day mark on November 19 and the conflict entered a higher level of fire-power escalation on November 17, when US President Joe Biden finally gave the authorisation for the US Army Tactical Missile System (ATACMS) to be used by Ukraine. While this decision is being interpreted as a case of Uncle Joe finally showing 'spine', albeit rather late in the day, the potential for sudden and dangerous escalation — either accidental or deliberate — has increased in a visible manner.

Kyiv had long sought such approval for the use of long-range western origin missiles, but this had been withheld by Washington as a measure of prudence and restraint to keep the conflict limited and confined to the two adversaries. It is pertinent that this green signal has been given when the Biden presidency is in what is described as its 'lame-duck' phase. This is the period after the US election results for the White House are announced (usually early November) and January 20, when the new incumbent assumes office — in this case, President-elect Donald Trump.

Kyiv lost no time in using its new weaponry and launched the ATACMS missiles against targets in Russia on November 20 and followed this offensive with the Storm Shadow missiles supplied by the UK. Earlier, Russia was accused of inducting North Korean troops into the conflict and also using drones supplied by Iran—thereby widening the scope of the war from a binary conflict (Russia-Ukraine) and according it a wider multinational nature. This has pitted Ukraine, supported by the US and some of its allies, against Russia, which is receiving tangible military assistance from North Korea and Iran.

Moscow retaliated almost immediately and on November 21. Russian President Vladimir Putin announced that his military had carried out an attack on the eastern Ukrainian city of Dnipro. using "a new conventional intermediate-range missile." Classified as Oreshnik, this has been identified as an experimental medium-range ballistic missile. Putin stated: "In response to the use of American and British long-range weaponry, on 21 November this year, the Russian armed forces carried out a combined strike on one of Ukraine's military-industrial complex sites. The sub-text of the use of the hypersonic Oreshnik missile was that if the US-led alliance chose to escalate the lethality of the conflict, Russia would respond in an assertive manner. Putin added that Russia was "ready for any developments and if anyone still doubts this, they shouldn't. There will always be a response.

Will this response be nuclear? This is the worst-case scenario that many European nations fear and Putin has stoked this anxiety by revising Russia's nuclear doctrine to cater to a wide range of exigencies that go beyond pristine deterrence.

Russia's earlier nuclear doctrine was framed in the traditional template that was limited to the core mission, meaning that the nuclear weapon was meant only to 'deter' the adversary (the USA) from even contemplating the use of such apocalyptic capability. The second condition was to repel a conventional military attack that threatened the existence of the state. However, the revised November doctrine announced by Moscow has expanded the spectrum and states that any attack by a non-nuclear power supported by a nuclear power would be considered a joint attack. It further adds that any attack by one member of a military bloc (in this case, the US-led alliance) would be considered an attack by the entire alliance. Moscow has drawn attention to its nuclear capability since the early stage of this war that began in February 2022 and this has been repeated many times. However, the received wisdom is that Russia would not cross the red line and some western commentary has dismissed this as mere posturing. But such complacency may be misleading and dangerous

It merits recall that the 1962 Cuban missile crisis between the USA and the former USSR that began in mid-October that year almost plunged the world into a nuclear war. This apocalyptic eyeball-to-eyeball brinkmanship was averted by the last-minute sagacity and prudence of the two leaders—US President John Kennedy and Soviet President Nikita Khrushchev. They decided to 'blink' together on November 20, 1962.

How PPP model can propel Punjab's economic growth

Public-Private Partnerships (PPPs) have the potential to revolutionise infrastructure development and services delivery by blending private sector capital and expertise with public sector oversight. For Punjab, which has over 147 PPP projects worth Rs 59,358 crore in critical sectors like...

Public-Private Partnerships (PPPs) have the potential to revolutionise infrastructure development and services delivery by blending private sector capital and expertise with public sector oversight. For Punjab, which has over 147 PPP projects worth Rs 59,358 crore in critical sectors like roads, bridges, healthcare and education, this model could be the key to unlocking sustained economic growth. However, despite the scale of these projects, systemic inefficiencies, governance issues and a narrow strategic focus have hindered their transformative potential. To fully leverage the power of the PPPs, Punjab must embrace a comprehensive reset, aligning these initiatives with the state's

reset, aligning these initiatives with the state's long-term economic and social goals. Punjab's track record in executing PPP projects has often fallen short. High-profile failures, such as the Ludhiana-Talwandi NHAI (National Highways Authority of India) project and the stalled food storage silo initiatives, reveal deep-rooted inefficiencies. Even as demand for modernised grain storage facilities grows, no silos have been built since 2021. Similarly, three commercial complexes in Amritsar, Mohali and Ludhiana—requiring an investment of over Rs 500 crore—remain incomplete. These missed opportunities reflect a broader issue: the state is struggling to

follow-through on significant infrastructure investments, resulting in wasted resources.

A fundamental problem lies in the skewed risk allocation. Private sector entities often shoulder the burdens of land acquisition delays, regulatory uncertainties and incomplete infrastructure, which discourages investment and delays projects. This imbalance undermines the core principle of risksharing in PPPs. Punjab's focus on "showcase" projects has often diverted attention away from addressing critical systemic needs. For example, the proposed medical colleges in Gurdaspur and Pathankot have made little progress, reflecting a disconnect between investments and challenges faced by the healthcare sector. Punjab's reliance on viability gap funding (VGF) further underscores a lack of financial confidence in the private sector's ability to execute projects without subsidies, raising concerns about the sustainability of its PPP mode. Moreover, the PPP landscape has focussed on traditional infrastructure projects like roads, bridges and silos, while emerging sectors such as renewable energy, education, food processing and circular

economy remain underexplored. This narrow focus limits the potential of PPPs to address the socio-economic challenges. Governance bottlenecks, such as procedural delays, opaque decision-making and weak contract enforcement, exacerbate the issues, undermining investor confidence and outcomes.

To overcome these challenges, Punjab must adopt a more strategic, diversified and transparent approach. First, the state must recalibrate risk allocation. Risks must be distributed more equitably between the public and private sectors. Private entities should manage risks related to construction and service delivery, while the government should



address land acquisition issues, regulatory challenges and policy alignment. This would ensure a fairer balance and encourage more private sector investment. Second, Punjab must explore innovative revenue models to make projects financially viable and socially impactful. One such model is payment for environmental services (PES), successfully implemented in Costa Rica to incentivise forest conservation through revenue generated by carbon credits and biodiversity offsets. It could be adapted in Punjab's Kandi belt for afforestation and environmental preservation, with potential revenue sources that align economic growth with sustainability. Further output/outcome-based payments (OBP), which link funding to improved healthcare or educational outcomes, could incentivise high-quality service delivery and ensure that projects produce measurable societal benefits.

Expanding the scope of PPPs into high-growth sectors is equally crucial. Renewable energy offers tremendous potential, as Punjab seeks to meet rising energy demands while reducing dependence on fossil fuels. Similarly, education-focused PPPs

could help modernise schools and colleges, emphasising vocational training to address the skill gaps in the workforce. Circular economy initiatives in waste management, recycling and sustainable practices could provide both environmental and economic benefits. Moreover, the food processing industry, with its potential to add value to farmers' produce, should be prioritised as a critical area for PPPs.None of these initiatives can succeed without strengthening the governance and regulatory frameworks. Updating the Punjab Infrastructure Act is essential to modernise the state's regulations, ensuring transparency, streamlined processes and

rigorous enforcement of state support agreements. The Surat Municipal Corporation's wastewater recycling project is an example of how robust governance, clear demand forecasting and innovative financing can ensure long-term sustainability and investor confidence.

Engaging citizens, private sector players and experts during the planning and execution stages will help ensure that projects meet public needs while delivering tangible, impactful results.Recent Budget announcements indicate that Punjab recognises the importance of PPP in driving growth. The 2023 Budget emphasised developing tourist destinations through PPP, while the 2022 Budget highlighted sports infrastructure projects. However, these initiatives need to be integrated into Punjab's long-term development strategy. For example, eco-tourism projects should prioritise sustainability and community participation, while sports infrastructure should balance grassroots development with highperformance facilities.

Punjab stands at a crossroads in its PPP journey. While it has recognised the transformative potential of these partnerships, inefficiencies, governance challenges and limited strategic focus continue to hold it back. Punjab must recalibrate its risk-sharing models, adopt innovative financing mechanisms, diversify into high-growth sectors and strengthen governance frameworks. By embracing these reforms, Punjab can modernise its infrastructure, foster sustainable economic growth and improve public welfare. A transparent and inclusive approach will set a new benchmark for PPP success, enabling Punjab to harness the transformative power of these partnerships and pave the way for a brighter, more sustainable future.

This shift wasn't necessarily a vote for AAP, but a tactical alignment against the

For the Congress, retaining Barnala offers a faint silver lining in an otherwise disappointing performance. Kuldeep Singh Dhillon's victory highlights the party's ability to capitalise on internal discontent within AAP, amplified by rebel candidates splitting votes. However, the loss in Gidderbaha—despite intense campaigning by state chief Amrinder Singh Raja Warring for his wife, Amrita

Warring, the Congress candidate — underscores deeper



issues of leadership disconnect and ineffective voter engagement. This setback is particularly damaging as Warring's singular focus on Gidderbaha came at the

expense of other constituencies, further diminishing the party's overall appeal across Punjab. The BJP, meanwhile, remains an outsider in Punjab's rural political landscape, unable to overcome the damage caused by the farm laws. These results come against the backdrop of AAP appointing Aman Arora as its state president, signalling a shift towards consolidating urban and Hindu votes. However, the ruling AAP, facing a midterm reality check, must tread carefully. Issues like drug abuse, economic instability and agricultural distress remain critical and mere electoral wins cannot substitute for policy solutions. The bypoll outcomes offer lessons not only in electoral strategy but also in the

pressing need for a governance model that addresses systemic challenges and resonates with the state's aspirations.

The Constitution has kept the nation united

November 26 is celebrated as Constitution Day of India

In 2015, on the occasion of the 125th birth anniversary of Dr BR Ambedkar, the government decided to celebrate November 26 as the Constitution Day to highlight the importance of the event and commemorate its chief architect.

On this day in 1949, the Constituent Assembly had adopted the Constitution of India which came into effect on January 26, 1950. This is when the foundation for the world's largest democracy was laid. For 75 years, this document has been serving as the guiding light for the running of the country. Among its many remarkable features, the principles of secularism and pluralism stand out as cornerstones of India's democratic identity.

of India's democratic identity.

Secularism in the Indian Constitution

A unique model unlike the western model of complete separation between religion and state, the Indian Constitution adopts a model of "equal respect for all religions", ensuring that the state neither favours nor discriminates against any religion. What makes the constitution secular is its key features, namely, freedom of religion (Articles 25-28), equality of all before the law (Articles 14 and 15) and neutrality of the State in matters of religion (Articles 27-28) guarantee the right to freedom of religion, allowing every individual to profess, practice, and propagate their faith. At the same time, these provisions protect individuals from being coerced into following a particular religion. Article 14 guarantees equality before the law and prohibits discrimination based on religion, caste, or gender. Article 15 specifically forbids discrimination on religious grounds. Neutrality of the state is ensured by Article 27 which prohibits the use of public funds for promoting or maintaining any religion and Article 28 that prohibits religious instruction in governmentrun educational institutions. Pluralism and diversity are the next distinguishing features of the country mandated by the Constitution which reinforce secularism. India is home to over 1.45 billion people, speaking 22 official languages listed in the Eighth Schedule and practising a multitude of religions. Ethnologue, an encyclopedic reference work cataloging all of the world's 7,111 known

This ensures the preservation of cultural identity.Universal adult suffrage is another important feature that empowers every section of society with right to vote to all adults regardless of caste, religion, gender, or economic status. For protection of the marginalised communities, the Constitution includes provisions for affirmative action, ensuring political, educational, and employment opportunities for Scheduled Castes, Scheduled Tribes, and Other Backward Classes. The coexistence of

secularism and pluralism are two basic features that are central to India's unity in diversity. By respecting minority rights, the Constitution prevents the dominance of any single group over others, while pluralism fosters inclusivity, ensuring that all communities feel valued and represented in the nation-building process.

I have often said that India is secular because Hindus are secular and the living proof is our constitution.

When the country was partitioned in the name of religion, Pakistan became an Islamic republic whereas India chose to be secular unanimously in the Constituent Assembly where an overwhelming majority (82 per cent) of members were Hindus! The reason India is looked upon by the world community with awe and respect is its unique plural and secular



identity which has kept the exceptionally huge and diverse country united. It is noteworthy that the word "secular" was added to the Preamble of the Indian Constitution by the 42nd Amendment Act, 1976, during the Emergency under Prime Minister Indira Gandhi's government. The amendment inserted the words "secular" and "socialist" into the Preamble, making the description of India as: "Sovereign Socialist Secular Democratic Republic." The

necessity of adding the term "secular" has been debated extensively, especially in the last couple of decades. Was it really necessary when secularism oozes from most articles? One section of the population is fighting for its deletion from the Preamble, especially because it was brought in by their bete noire Indira Gandhi and that too during the

much despised emergency. They overlook the fact that it would not alter the secular character of the Constitution one bit. While some think it is redundant, for others it is reinforcement. Either way the debate is superfluous.Secularism and pluralism are considered parts of the basic structure of the Indian Constitution, as affirmed by various judgments of the Supreme Court. The basic structure doctrine, established in the landmark Kesavananda Bharati v State of Kerala (1973) case, identifies certain fundamental principles of the Constitution that cannot be amended by Parliament, even through its constitutional amending power under Article 368. In the case of SR Bommai v Union of India (1994), the Supreme Court explicitly recognised secularism as a part of the basic structure. The Court ruled that: Secularism means that the state must

maintain neutrality in matters of religion and ensure equal treatment of all religions. Any law or amendment that undermines secularism would be unconstitutional.

Like secularism, pluralism is also a part of the basic structure. Pluralism refers to the coexistence of diverse cultural, linguistic, religious, and social groups in harmony. It is intrinsic to India's identity as a multicultural society.

The senior lawyer said Congress must put out credible evidence before demanding a JPC probe

New Delhi: Senior lawyer and former Rajya Sabha MP Mahesh Jethmalani said the Congress is "reading too much" into the indictment against the Adani Group in the US for "purely political purposes". He said the Opposition party must provide credible evidence before demanding a parliamentary probe. Mr Jethmalani said the US Department of Justice indictment does not have evidence of any act of bribery carried out in India. "All this noise the Congress has made is completely misconceived. What is the evidence which proves that there was any conspiracy to

solar energy contracts? (there is) nothing in the indictment," he said. Congress party is blindly relying on an indictment against an Indian conglomerate which has undertaken extremely useful businesses in India and abroad. This is not in India's interest, and to blindly follow a US court indictment which gives no evidence and does not suggest that any of the Adanis or the company which issued the bonds, Adani Green, have done any wrong in India.

Congress is reading too much into the indictment for purely political purposes. And they have been aided, as is revealed by the timing of this indictment, by the Democratic deep state "Mr Jethmalani said. The Democratic Deep State, the senior lawyer said, was weaponising US courts to destabilise India's economic rise. The senior lawyer said that he doesn't know what evidence the judge is the US who issued the indictment acted upon.Slamming the Congress, he said, "This is a conspiracy to

The standard line is innocent unless proven guilty. At another level, when India is being celebrated across the globe as a bright

spot on the economic side, we need to consider whether comments that come from the political class are broadly trying to shake confidence in India's story. Lakhimpur Kheri violence: SC tells Ashish Mishra to respond to allegation of threatening witnesses

At the outset, a counsel appearing for one of the complainants in the case told the court that he has filed a plea in which he has said that witnesses were threatened by Mishra.

NEW DELHI: The Supreme Court on Wednesday directed former Union minister Ajay Mishra's son Ashish Mishra to respond to allegation that witnesses were being threatened in the 2021 Lakhimpur Kheri violence case that claimed eight lives. A bench of Justices Surya Kant and Ujjal Bhuyan asked senior advocate Siddharth Dave, appearing for Mishra, to file an affidavit clarifying his stand after he refuted the allegations.At the outset, a counsel appearing for one of the complainants in the case told the court that he has filed a plea in which he has said that witnesses were threatened by Mishra.

Dave denied the allegations and said this is an "endless process.""It's not me in the photographs. This is not for this court, this is for outside," Dave said. The top court then asked Mishra to file an affidavit denying the allegations within four weeks. On July 22, the top court had granted bail to Ashish Mishra and restricted his movement to Delhi or Lucknow.On January 25 last year, the top court had given Ashish Mishra interim bail in the "unfortunate ghastly incident." It had also granted bail to four farmers -- Guruwinder Singh, Kamaljeet Singh, Gurupreet Singh and Vichitra Singh -- in the case and directed the trial court to expedite hearing.

On October 3, 2021, eight people, including four farmers, were killed in Tikunia in Uttar Pradesh's Lakhimpur Kheri district. The violence erupted when farmers were protesting against Deputy Chief Minister Keshav Prasad Maurya's visit to the area. Four farmers were mowed down by a sports utility vehicle. A driver and two BJP workers were then allegedly lynched by angry farmers.

A journalist also died in the violence. The apex court in February had extended Ashish Mishra's interim bail and asked its registry to obtain a report from the trial court on the progress of the case. The Supreme Court on January 25 last year had said Ashish Mishra should not stay in Uttar Pradesh or Delhi during the period of interim bail. This was done with a view to avoid any influence on witnesses in the case.Later, on September 26, the apex court relaxed his bail conditions to enable him to visit and stay in the National Capital Territory to look after his ailing mother and for the treatment of his daughter.

On December 6 last year, the trial court framed charges against Ashish Mishra and 12 others for the alleged offences of murder, criminal conspiracy and under other penal laws in the case of the farmers' deaths, paving the way for

5 doctors dead as Scorpio collides with divider, hits truck on Agra expressway

New Delhi: Five doctors were dead, and an individual was seriously injured in a road accident on the Lucknow-Agra Expressway in Uttar Pradesh's Kannauj district, early on Wednesday (November 27). According to police, the accident occurred around 3 am when a speeding Scorpio SUV, en route from Lucknow to Agra, lost control and collided with a divider. The vehicle then veered into the opposite lane and was hit by an oncoming truck. Superintendent of Police Amit Kumar Anand confirmed that all five



victims died on the spot. The lone survivor, identified as Jaiveer Singh (39), a postgraduate student at Saifai Medical College, was rushed to Dr Bhimrao Ambedkar Medical College in Tirwa and is undergoing treatment.

The victims were identified as Dr Anirudh Verma (29) from Agra, Dr Santosh Kumar Maurya (46) from Bhadohi, Dr Arun Kumar (34) from Kannauj, Dr Nardev (35) from Bareilly and Rakesh Kumar (38). The group, affiliated with the Uttar Pradesh University of Medical Sciences in Saifai, was returning from a wedding in Lucknow when the accident occurred. Circle Officer Dr Priyanka Bajpai said that the bodies have been sent for postmortem, and an investigation into the accident is underway.

Counter-terrorism force NSG to be stationed in Jammu amid rising attacks: Sources

New Delhi. A special task force of the National Security Guard (NSG), the country's counter-terrorism unit, will be stationed in Jammu in view of the recent spike in terror attacks in the region, sources told .The counterterrorism unit force will be stationed in the city based on the instructions of the Ministry of Home Affairs, sources said. Sources also said that NSG's special task force will be stationed permanently in Jammu city so that they can reach any spot in case of an emergency or

The Jammu region comprises the districts of Jammu, Doda, Kathua, Ramban, Reasi, Kishtwar, Poonch,



Rajouri, Udhampur and Samba. This year, the Jammu region has witnessed a significant surge in terror attacks, affecting eight out of 10 districts, and 44 people have been killed in such incidents, including 18 security personnel, 14 civilians and 13 terrorists. The Rajouri-Poonch belt, which had seen a significant decline in terror activities over the past decade, has again become a focal point of terror attacks. Since October 2021, the region has witnessed deadly attacks targeting Army vehicles, resulting in the deaths of over 100 people, including 47 security personnel, 48 terrorists and seven civilians. To counter the rising terror threat, the army, police, and central armed police forces have intensified their operations.

Vaishnaw warned that algorithms driving digital platforms often prioritise content that maximises engagement by amplifying sensational or divisive narratives. This dynamic, he asserted, posed societal risks and necessitates solutions that balance engagement with ethical considerations.

BENGALURU. Food delivery platform Zomato's CEO Deepinder Goyal will forgo his annual salary of Rs 3.5 crore until FY26. Its qualified institutional placement (QIP) documents revealed Goyal has voluntarily waived his salary for a period starting from April 1, 2021 till March 31, 2026. Earlier in FY21, the CEO had said he would forgo his salary for about 36 months till the end of FY24. The company will raise Rs 8,500 crore via QIP and has set a floor price of Rs 265.91 for the issue, as per the filings with the exchanges. This comes at a time when quick commerce players are investing in dark stores. Zomato also has plans to increase the number of warehouses that are used for Blinkit.

Adani, nephew not charged under US Foreign Corrupt Practices Act: Adani Green informs stock exchange

Adani Green Energy Ltd, which is at the centre of the bribery allegations, said reports claiming that the three have been charged with FCPA violations "are

NEW DELHI. Billionaire Gautam Adani, and his nephew Sagar have not been charged with any violation of the US Foreign Corrupt Practices Act (FCPA) in the indictment that authorities filed in the New York court in the alleged bribery case, the Adani Group said on Wednesday. They have been charged under securities fraud that involves levy of monetary penalties.Gautam Adani, founder chairman of the ports-to-energy conglomerate, Sagar Adani and another key executive, Vneet Jaain, have been charged by the US Department of Justice with being part of an alleged scheme to pay USD 265 million in bribes to Indian officials to win contracts for supply of solar electricity that would yield USD 2 billion profit over a 20-year period.In a stock exchange filing, Adani Green Energy Ltd -- which is at the centre of the bribery allegations -- said reports saying the three have been charged with FCPA violations "are incorrect."They are charged for offences that are punishable with a monetary fine or penalty."Gautam Adani, Sagar Adani and Vneet Jaain have not been charged with any violation of the FCPA in the counts set forth in the indictment of the US DOJ or civil complaint of the US SEC," the filing said."These directors have been charged on three counts in the criminal indictment, namely (i) alleged securities fraud conspiracy, (ii) alleged wire fraud conspiracy, and (iii) alleged securities fraud," it continued. Adani Group has denied all allegations as "baseless" and



said it will take all possible legal recourse to defend itself. The United States Department of Justice (US DoJ) and the United States Securities and Exchange Commission (US SEC) have issued a criminal indictment and brought a civil complaint in the US District Court for the Eastern District of New York, against Gautam Adani, Sagar Adani and Vneet Jaain -- all directors of Adani Green Energy Ltd. "The indictment does not specify any quantum of any fine/penalty," the company said. The civil complaint alleges that the executives violated certain sections of the Securities Act of 1933 and the Securities Act of 1934, and to have aided and abetted Adani Green

Energy's violation of the Securities Act of 1933 and the Securities Act of 1934. "Although the complaint prays for an order directing the defendants to pay civil monetary penalties, it does not quantify the amount of penalty," it added.DoJ has alleged that between 2020 and 2024, senior executives of Adani Green, Azure Power, and CDPQ (Caisse de dépôt et placement du Québec -- a Canadian institutional investor and Azure's largest shareholder) participated in a scheme to bribe Indian government officials to ensure the execution of lucrative solar energy supply contracts with Indian government entities.During the same period, senior executives of Adani Green conspired to misrepresent the company's anti-bribery practices (to US-based investors and international financial institutions) and concealed from those investors and institutions their bribery of Indian government officials to obtain billions of dollars in financing for green energy projects, including the corrupt solar energy supply contracts.

Maxwell was in awe of Bumrah's accuracy and explained how difficult it is to face him. Having faced Bumrah quite a lot in his cricketing career, Maxwell said that it is really difficult to pick and differentiate whether he would bowl a length ball or a bouncer. He also praised India's rising star Yashasvi Jaiswal and made a bold prediction about his career in Test cricket."It almost feels like his bouncer and his length ball are very similar to where his release point is, and it's really hard to pick up the difference between those and ball always feels like it's coming back into you and he's got the ability to take the ball away, which just makes it extremely difficult. Bumrah is going to go down as potentially the best fast bowler of all time, maybe not with the amount of wickets he takes in every format. But for the guys that have played against him, it is just so difficult,



so difficult. He's just got such unique action, unique ability with the ball. He seems like a complete package," Maxwell said on the Grade Cricketer Podcast.Bumrah captained India in the 1st Test vs Australia of the Border Gavaskar Trophy series. He won the player of the match award for taking 8 wickets in the contest, including a five-wicket haul in the 1st innings. India became the 1st team to beat Australia at the Optus Stadium in Perth. India beat Australia by 295 runs to register their biggest-ever win on Australian soil.

Maxwell predicted Jaiswal to score 40 Test hundreds and break many records on his way to glory."Jaiswal as well, doesn't seem to have many weaknesses, plays a short ball well, drives well, plays spin unbelievably well and can absorb pressure for periods of time. He's a guy that's probably gonna get more than 40 test hundreds and re write some different records as well," he added.Jaiswal scored a scintillating hundred in the opening Test as he scored 161 in 2nd innings to lay the foundation for India's win.

Shubman Gill Doubtful For Pink Ball Test In Adelaide: Report

Shubman Gill is dealing with a thumb injury that he suffered while fielding in the slips during India's match simulation in the buildup to the first Test in Perth.

New Delhi. Star Indian batter Shubman Gill, who missed the first Test of the ongoing fivematch series between India and Australia at Optus St adium in Perth due to a thumb injury, is likely to miss the second Test as well. The second Test between India and Australia will be a day-night game and will be played with a pink ball from December 6 to 10 at Adelaide Oval. According to a report in the Times of India on Wednesday (November 27), the 25-year-old righthanded batter, who made his Test debut for India on December 26, 2020, against Australia in Melbourne, is doubtful for the match in Adelaide. He is all set to miss the two-day pink ball warm-up match in



Canberra from November 30."Gill was advised a 10-14 day rest by the medical specialist after suffering that injury. He won't play in the practice match on the weekend and is doubtful at the moment for the second Test too. Let's see how much his injury has healed and how his finger feels. Even after it has healed, he'll need some quality practice before playing a Test match," a source was quoted as saying. Gill suffered the injury while fielding in the slips during the match simulation in the build-up to the first Test.Recently, former Mumbai and India selector Jatin Paranjape had said that Gill could end up missing "two to three Tests" due to the injury.

Jacob Bethell has got something very special: Stokes praises England Test debutant

New Delhi. Ben Stokes backed Jacob Bethell's selection for England's opening Test against New Zealand, starting November 28 at the Hagley Oval in Christchurch. Earlier, the Three Lions named their playing XI and handed Bethell his maiden Test cap. Bethell also became the first English batter since Mike Gatting in 1978 to make his Test debut without a first-class hundred to his name. Obviously they've got Andy there and Mo Bobat [as director of cricket], and I'm really looking forward to playing under them. 63 not out: Remembering Phil Hughes on 10th death anniversary

New Delhi. November 27 marks the 10year anniversary of the untimely death of Australian cricketer Phillip Hughes, a moment that shook the cricketing world to its core. Hughes, a tale s old when he passed away after being struck by a bouncer during a domestic Sheffield Shield match on November 25, 2014. Playing for South Australia against New South Wales at the Sydney Cricket Ground, Hughes was on 63 runs when a short-pitched delivery from Sean Abbott hit him on the neck. The impact caused a rare vertebral artery dissection, leading to a brain haemorrhage. He collapsed on the field and was rushed to St. Vincent's Hospital, where he underwent emergency surgery. Tragically, despite the best medical efforts, Hughes succumbed to his injuries two days later. The cricketing fraternity was left in shock and grief. Tributes poured in from across the globe, with players, fans, and officials mourning the loss of a bright young talent.
