Ranchi, Nov 28: Hemant Soren took oath as 14th Chief Minister of Jharkhand in a grand cer-

emony in Ranchi on Thursday. The swearing-in ceremony was attended by a host of prominent political leaders, including Congress president Mallikarjun Kharge, Leader of Opposition Rahul Gandhi and West Bengal Chief Minister Mamata Banerjee. Jharkhand Governor Santosh Kumar Gangwar administered the oath of office and secrecy to Soren. This marks the 49-yearold JMM leader's fourth term as Chief Minister. Soren retained his Barhait seat in the recent assembly elections, defeating BJP's Gamliyel Hembrom by a margin of 39,791 votes. Lashkar terrorist, with case in Bengaluru, deported from Rwanda to India

Mumbai/New Delhi, Nov 28: A wanted terrorist, with links to the Lashkar-e-Taiba (LeT) and a terror case filed against him in Bengaluru, has been deported to India from



Thursday. He is identified as Salman Rehman Khan, wanted by the National Investigation Agency (NIA) and Central Bureau of Investigation (CBI) against whom the Interpol had issued a Red Corner Notice. Khan's return was coordinated by

Bureau, Kigali (Rwanda's capital) in central East Africa. The NIA had lodged a case against him last year pertaining to criminal conspiracy, for being a member of the dreaded terror organisation (LeT) and sup-

> porting it, slapping him with offences related to the Arms Act and Explosive Substances Act. the NIA, CBI and Interpol National Central SC issues notice to Yasin Malik, others on CBI's plea to transfer trial in two cases

New Delhi, Nov 28: The Supreme Court on Thursday sought response from J-K separatist leader Yasin Malik and others on a plea by the Central Bureau of Investigation to transfer the trial in two cases from Jammu to New Delhi. A Bench of Justices Abhay S Oka and Augustine George Masih issued notice to Malik and other accused and directed them to file response by December 18. During the proceedings, Solicitor General Tushar Mehta told the Bench that Malik need not be physically taken to Jammu court for trial in the kidnapping case as Tihar jail has a court with video-conferencing facilities.

"We have filed applications for amending the cause title. We have also placed on record the fact that there already exists a fully functional court in the jail itself with all the facilities of video conferencing also, if needed. And in the past proceedings have taken place in that courtroom in jail," SG Mehta submitted



CBI plea against the September 20, 2022 order of a Jammu trial court that directed Malik, serving life term in Tihar jail, to be produced before it physically to cross-examine the prosecution witnesses in the kidnapping case of Rubaiya Sayeed, daughter of politician Mufti Mohammad Sayeed. Observing that even Mumbai terror attack convict Ajmal Kasab was given a fair trial, the bench had earlier said that it could order trial to take place inside the jail besides asking the judge to come to the national capital for the proceedings. Mehta had said Malik physically appearing in the Supreme Court had raised security concerns previously. In 2023, Mehta wrote to then Union Home Secretary Ajay Kumar Bhalla flagging a "serious security lapse" after Malik was brought to the Supreme Court to appear in a case. Malik, serving life sentence in a terrorfunding case, was brought to the highsecurity apex court premises in a prison van escorted by armed security personnel without the court's permission. Voicing surprise at his presence, Mehta informed the apex court there was a procedure for high-risk convicts to be allowed into the courtroom to argue their case personally.

Constitution copy in hand, Priyanka Gandhi takes oath as LS MP

New Delhi, Nov. 28: Holding up a copy of the Constitution, Congress leader Priyanka Gandhi Vadra took oath as a Lok Sabha MP on Thursday to begin her journey as an elected representative of the people five years after she joined active politics. The 52-year-old, who joins her mother Sonia and brother Rahul as an MP in what is a rare instance of three members of a family together in Parliament, took affirmation in Hindi. The MP from Wayanad in Kerala held up a red and black copy of the Constitution, which Rahul Gandhi has been displaying at his public meetings, as she took her oath. Dressed in a cream Kasavu saree from Kerala, Priyanka Gandhi rose to take oath amid cheers of 'Jodo Jodo, Bharat Jodo' from the Congress benches. She took oath with Congress president Mallikarjun Kharge, her mother and Congress Parliamentary Party (CPP) chief Sonia Gandhi, husband Robert Vadra, son Raihan and daughter Miraya watching from the galleries. Congress MPs earlier met at the CPP office in the Parliament premis-

es where Priyanka Gandhi was greeted and congratulated by leaders. After taking oath,

Priyanka Gandhi completed the formalities and then shared a warm hug with her brother and Leader of Opposition in the Lok Sabha Rahul Gandhi. Ravindra Chavan (Congress), who won the Nanded bypoll also took oath in Marathi in the name of god. The bypoll was necessitated following the demise of his father Vasantrao Chavan recently. The House was adjourned after the oaths as opposition members came to the Well of the House and raised slogans, demanding a discussion on the Adani issue and the Sambhal violence. pain of her father Rajiv Gandhi's assassination and her mother's grief, she steered the Congress' campaign during the general election, adroitly walking the tightrope between striking a familial chord and discussing national-level issues. She proved to be a strategist, orator and mass mobiliser - all rolled into one. Most of her speeches are akin to a conversation with the crowd, establishing a connect and giving people the impression that here was a person who was known to them, someone sharing her feelings and thoughts with them. As star campaigner and strategiser, Priyanka Gandhi helped the Congress make impressive gains in some states as well as in the Lok Sabha polls held earlier in the year. Her campaign helped the Congress get 99 seats in the general election, up from 52 in 2019. Priyanka Gandhi has often been projected as a possible challenger to Prime Minister Narendra Modi from Varanasi and also as a successor to Congress veteran Sonia Gandhi in the family pocket borough of Rae Bareli, However, soon after the Election Commission announced the Wayanad bypoll, the Congress declared that Priyanka Gandhi would be its candidate from the seat in Kerala. Rahul Gandhi, it decided, would retain the Rae Bareli parliamentary constituency in Uttar Pradesh and vacate the Wayanad seat he won for the second consecutive time.

Tiger killed by snare set up by poachers in Tamil Nadu's Gudalur, three arrested

NILGIRIS. A three-year-old tiger that was caught in a snare (clutch cable) died due to suffocation near a tea estate at Chelukadi reserve forest in Gudalur on Tuesday night.

Estate workers noticed the carcass on Wednesday morning and informed forest department. A team led by Gudalur District Forest Officer N Venkatesh Prabhu reached the spot at 9:30 am and commenced an investigation.

They suspect that poachers may have placed the snare to trap wild boars. However, the tiger got caught in it, probably on Tuesday night, and died. "Nails, skin, teeth, and other parts of the animal are intact. We have picked up three persons from Chelukadi village who have previous history of theft and housebreaking cases in the Gudalur police station limit. This is the first time they are committing the wildlife offense. We are investigating with them, and they will be arrested," an official said.

"The animal may have got caught in the snare on Tuesday night since the carcass was fresh. We noticed marks in the ground as the animal struggled before it died. We will be sending organ samples to SACON and Toxicology lab in Coimbatore for analysis," the official added.

Postmortem examination was carried out by veterinary assistant surgeons Rajesh of Theppakkadu and Naveen Kumar of Cherambadi, following which the carcass was burned. According to sources, a total of 112 tigers died due to various reasons across the country this year so far. Of this, three deaths were reported in Gudalur forest division. Out of the three, two tigers (male sub adult and female adult) died due to suspected poisoning in Bitherkadu on

After giving approval, BRS now opposing its establishment: Congress on ethanol factory

HYDERABAD. The ruling Congress has accused the opposition BRS of "double standards" over the ethanol factory. The ruling party claimed that the BRS, now opposing the factory, had previously approved its establishment when it was in power. The Congress also alleged that the ethanol factory was owned by the family members of former BRS minister Talasani Srinivas Yadav.

Panchayat Raj and Rural Development Minister Dansari Anasuya accused the pink party of using the factory issue to stir unrest. She stated that former chief minister K Chandrasekhar Rao and former IT ministet KT Rama Rao, along with the BJP government at the Centre, had given green signal to the ethanol factory. The BRS government had issued a Letter of Intent (LoI) on April 3, 2023, and allocated

Irrigation Scheme for the factory, the minister added. TPCC chief B Mahesh Kumar Goud alleged that the opposition party adopted anti-people and anti-farmer policies during its tenure. He clarified that the Congress government had no involvement in approving the ethanol factory and would assess its pros and cons before making a final decision.

Meanwhile, former minister Talasani Srinivas Yadav said that he or his family had nothing to do with the ethanol factory. He denied the ruling party's allegations linking his family with the issue. He advised the Congress leaders to verify facts before speaking and stated that he was ready to transfer the ownership of the factory if the Congress leaders prove their allegations.



Amid low state-wide acceptance, tribal districts of Odisha lead in male sterilisation

BHUBANESWAR. Amid low acceptance for vasectomy as an alternative mode of family planning in Odisha, tribal districts have led the way in terms of male sterilisation adoption as compared to more developed and literate coastal districts.

Official sources said, districts like Koraput, Rayagada and Sundargarh emerged frontrunners in male sterilisation services in the state while Khurda, Cuttack, Ganjam and Balasore lagged behind.

According to the latest data, the highest 307 vasectomy cases were recorded in Koraput, followed by 282 in Sundargarh and 264 in Rayagada in 2023-24. During the same time, Khurda reported 26 cases followed by



Cuttack (28), Ganjam (69) and Balasore (80). Malkangiri and Nabarangpur performed better than some of the coastal districts with 54 and 31 cases respectively. Several districts such as Sambalpur, Nayagarh, Angul and Dhenkanal recorded vasectomy cases in single-digit

while no men came forward for the procedure in Deogarh district.

Although low as compared to other states, there has been a steady growth in vasectomy adoption in Odisha - from 719 cases in 2020-21 to 991 in 2021-22, 1,569 in 2022-23 and 1,792 in 2023-24. The number of tubectomy cases, which went up from 82,152 in 2021-22 to 92.529 in 2022-23, dropped the

following year with the state reporting about 79,583 cases. Additional director of family planning Dr Muralidhar Padhi said the active participation of local health workers, ASHA and anganwadi workers in spreading awareness about the benefits of vasectomy

significantly helped overcome cultural taboos in tribal areas."Male sterilisation is low in many districts as people are shy and reluctant about it. If health workers can convince people in tribal districts for the procedure, why can't coastal districts follow the lead? It is a matter of perception," he said. Padhi informed that coastal districts performed better in the first half of this financial year due to concerted efforts by health workers."Balasore has already conducted 235 cases of vasectomy with Remuna block topping the list with 78 cases during the April-September period. Jagatsinghpur and Kendrapara districts are also performing well.

Need regional airshed approach to improve Mumbai's air quality, recommends pan-India study

Mumbai. While While the city has focused on controlling local sources of air pollution, a pan-India study has proposed that Mumbai be integrated into a coastal airshed, which includes all its satellite cities, to effectively address and manage urban and non-urban emission sources. In this process, the regional airshed will foster cooperation among the urban local bodies, which are influencing each other's air

An airshed is a geographic area where air pollution is measured and managed as a whole. It recognises that air pollution doesn't stop at city or state borders-pollutants can travel across regions. As a result, effective pollution management requires cooperation between cities, states, and even neighbouring Mumbai's air quality worsens significantly countries. The newly published study, Designating Airsheds in India for Urban and Regional Air Quality Management, highlights the urgent need for a coordinated approach for effective control instead of tackling it in bits and pieces. This peerreviewed study, published in MDPI's Air journal, recommends dividing India into 15



regional airsheds, each tailored to the specific climatic and pollution patterns of its region. This approach, the study indicates, could significantly improve Mumbai's air quality by tackling pollution from both inside and outside the city.

during the winter months, driven by a combination of meteorological factors and pollution sources from both within and beyond the city limits. According to the World Air Quality Report 2023, Mumbai's PM2.5 levels rose by 23% in Jan 2023 compared to the same period in 2022, making it one of the worst-affected cities

globally during the winter season.

Sarath Guttikunda, lead author of the study, said: "Mumbai is a significant regional contributor to air pollution. While the city can gain considerable benefits from managing pollution within its immediate surroundings, this relationship is reciprocal; the surrounding satellite cities also stand to benefit greatly from efforts to control emissions originating in Mumbai. Coordinated management across Mumbai and its neighbouring areas could create a positive feedback loop, enhancing air quality and health outcomes for the entire Western airshed."

The study identified 11 airsheds as crucial for overall air quality management, with the Indo-Gangetic Plains (IGP) and the plateau region between the Eastern and Western Ghats emerging as priority areas. The IGP alone, which accounts for 16% of India's landmass and 41% of its population, bears a high pollution burden due to extensive industrial activity, agriculture, and energy production."While regions like the IGP bear the brunt of industrial and agricultural pollution, contrary to popular belief, coastal cities like Mumbai have also witnessed a spike in pollution levels, particularly in winter, despite the benefits of land-sea breezes. In an urban regional airshed, the participating members would include a broad institutional setup, involving urban local bodies, state officials, ministries, and regional stakeholders. This larger collaboration is essential to addressing shared air quality issues in coastal cities like Mumbai," Guttikunda said. The study concludes by recommending the establishment of a national system that integrates both regional and urban airsheds under a centralised air quality management framework. "A centralised system would enable better coordination between cities, states, and airsheds, helping us monitor progress and ensure that everyone is working towards the same clean air goals," Guttikunda said. "Air pollution isn't just an environmental challenge-it's a public health crisis. By creating a coordinated airshed approach, we can make significant progress in improving the air quality for cities and rural areas across India," he

CBI books port officer in Rs 70 lakh corruption case in Tamil Nadu

CHENNAI. The Central Bureau of Investigation (CBI) conducted searches at the residences of accused persons in a bribery case in Chennai, Tiruvallur, Thanjavur and Kanniyakumari and recovered Rs 27 lakh cash and incriminating devices, and documents on Tuesday, the agency said in a statement.

CBI had registered a case on October 25 against K Pugalendi, the then Senior Deputy Director of Research (P&R Cell), Traffic Department, Chennai Port Trust Authority, and five others - S Raghul Chakravarthy, M Ludwin Rajiv, R Madhan Kumar, N Mydheen Raja and Rajalingam - who serve as proprietor, working partners and mediators of Chennai-based RS Enterprises.

This was based on a complaint by the Chief Vigilance Officer of Chennai Port Trust, which was later inquired by CBI.

It was alleged in the complaint that Pugalendi demanded and obtained Rs 70 lakh bribe for awarding the tender for four tugs with spares and 'Annam' (oil recovery vessel) from the five other suspects in 2019 and 2020. It was also alleged that Pugalendi provided a fake order issued by the Chennai Port Trust. A case under sections for cheating, forgery and corruption, was registered against the accused.

Safety boost: HAL Airport instals new systems

BENGALURU. To facilitate safe landing of aircraft, the HAL Airport installed a new Instrument Landing System (ILS) on its premises recently. The replacement, done after three decades, is to plan for its future growth as well as enhance the present safety standards. It had recently installed a new radio navigation system to facilitate landing of planes safely. In October, 1,301 flyers had made use of HAL Airport. An average of 12 small aircraft, military aircraft, training, VIPs and VVIPs and a few private firms regularly use it.

The flight calibration for commissioning the ILS has been completed and approvals are awaited to commission it. It costs Rs 10.55 crore," K Anbarasu, Airport Director, HAL,



told TNIE. The key components of the ILS are Localiser, Glide Path and Distance Measuring Equipment (DME).

"ILS is a precision approach aid used by aircraft to land safely, especially in poor visibility. It provides accurate lateral and vertical guidance to pilots ensuring a safe and

aligned descent to the runway," Anbarasu elaborated. The system being replaced has the same features as the earlier one as both are Category-I type. The runway visibility would be 550 m or more and the minimum decision height is 200 ft.

While the Localiser provides lateral guidance by transmitting signals that help alight the aircraft with the runway's centre guidance by ensuring the aircraft descends at the correct angle, usually around three degrees. "DME provides the distance to the touchdown point on the runway," he added.

indispensable tool in global air

transportation. In another safety addition

recently, the Doppler Very High Frequency Omnidirectional Range (DVOR)/DME, a radio navigation system used by aircraft, was replaced with a new one and commissioned on May 1, 2024 at a cost of Rs 6.12 crore.

"DVOR is used by aircraft to determine their position and stay on course. DME provides the slant range distance between the aircraft and the ground station,"the Director said.

"The DVOR provides Azimuth information (the direction to or from the station) to aircraft. This helps pilots and onboard navigation systems determine their position relative to the DVOR station," Anbarasu added.

Karnataka HC questions state govt over withholding civic staffer's pension

The petitioner had stated that he was surviving on borrowed money, but there has been a stony silence from the side of officials.

BENGALURU. Questioning the State Government for withholding the pension and all terminal benefits to be paid to a 72-year-old employee of a Directorate of Municipal Administration till now, though he retired in 2012, the Karnataka High Court directed the state government to pay him all benefits with interest and cost. To date, the government did not conduct an inquiry into alleged charges of misconduct against him.

Imposing cost of Rs 50,000 on the state government to be paid to the petitioner, Sadashivappa, residing in Thalaghattapura in the city, the division bench of Justice Krishna S Dixit and Justice CM Joshi said, "It pains us that this is not the first case where a pensioner has been put to untold hardship and cruelty at the hands of the government, which extracted his sweat if not blood for more than 33 years of service." Directing the urban development department to

sanction and release regular pension and all terminal benefits to the petitioner within two months, with interest at the rate of 1 percent per month from the day it has been withheld, the court said the interest and costs may be recovered from erring officials of the departments concerned, in accordance with the law.

The court observed that since a retired employee holds his body and soul together with the periodic pension regularly paid, withholding the same amounts to suspending the means of livelihood, which offends the fundamental right to life.

1.1k govt buildings in city to go solar under PM scheme

Gurgaon. To maximise renewable capacity and reduce dependence on electricity, all govt buildings in the city are set to have rooftop solar systems. A survey conducted to install solar units on 1,070 govt buildings found that about 50 megawatts of solar energy plants would be required to fulfil the state's power requirements. The solar units will be installed under the PM Suryaghar Scheme, which provides a subsidy of 60 percent of the solar unit cost for systems up to 2 kW capacity and 40 percent of additional system cost for systems between 2 to 3 kW capacity. Ajay Kumar, deputy commissioner, said Haryana Renewable Energy Development Agency (HAREDA) will carry out the installation project. The PM Suryaghar initiative was launched in February 2024 by Prime Minister Narendra Modi. "Around 3.5 lakh households from Haryana have registered under the PM Surya Ghar Yojana so far, and the Haryana power department is expected to install solar rooftop systems on 5 lakh houses by 2030," said an official from the energy department.Kumar said that, according to the govt's directives, one village in each district will be made a solar village. Households will receive a subsidy of Rs 30,000 for installing a solar plant with a capacity of two kilowatts and Rs 78,000 for installing a solar plant with a three-kilowatt or more capacity, he said.

He added that antyodaya families (with an annual income of less than Rs 1.8 lakh) applying under this scheme would get an additional subsidy of Rs 50,000.

GMDA to build master drain on key roads

Gurgaon. GMDA will construct a master stormwater drain to tackle waterlogging in sectors 37 C, D, and the key arterial stretches of Pataudi Road at an estimated cost of Rs 30 crore. HSVP did not plan the stormwater drain at the time of development of these sectors. The construction of this drain is crucial to mitigate waterlogging during the monsoon. An RCC box-type drain will be built till Badshapur drain at Gadoli.

According to a GMDA official, a detailed project report is being prepared. Once the DPR is finalised, GMDA will soon float the tender for the drain's construction.

It already received administrative approval in June 2022, but GMDA has now increased the project's scope."Earlier, the plan was to construct the drainage network in sectors 37C and D, but now we have also included the stormwater channelisation on the stretch for Umang Bharadwaj Chowk to Gadoli on Pataudi Road, as it is a low-lying area. It will address the persistent waterlogging issues in the vicinity," a senior official of GMDA said.Residents said it was long overdue as they encountered damaged roads due to severe flooding during the monsoon. Suraj Bhola, RWA general secretary of Sector 9A, said, "Severe waterlogging every monsoon damages the roads and makes commuting difficult. For the last two months, the main road of Sector 37C has been flooded, unmotorable, and unrepaired. Dropping off and picking up my children from their school in Sector 37C has become a daily ordeal. The GMDA should at least repair the road till the time they construct the drain,

Rs 422cr plan: 10k new CCTV cameras to watch over city

Gurgaon.GMDA has created a roadmap to initiate the third phase of its CCTV surveillance network, which will involve installing 10,000 cameras at 2,000 locations that are likely to include areas near malls, roads and other public places. Currently, there are 1,200 CCTV cameras installed along main roads in the city. These were put up as part of phase 1 of the project for better safety. The second phase, under which 2,722 cameras are to be installed at 258 spots in the city and Manesar, is ongoing. The authority has shortlisted five bidders after floating a tender and will seek financial approval from a govt committee for purchasing the cameras. Its estimated cost is Rs 160 crore. After the tender is awarded, work is expected to take another 18 months to be completed for this phase. The company will also have to maintain all equipment and manage operational expenses for five years. Phase 3, officials said on Friday, will expand the surveillance network beyond main roads, and will cover high-traffic areas, govt buildings and community areas. High resolution cameras with night vision and wide-angle lenses will be installed every 200 metres on a road network spanning 400km. Each junction will have 4-12

Fbd student's murder: New lynching section of BNS slapped on vigilantes in

Gurgaon. Police have invoked the section of lynching — which was introduced in India's criminal laws this year after Bharatiya Nyay Sanhita (BNS) replaced IPC in July — in its charge sheet on the murder of a 20-year-old student who was chased and shot dead by cow vigilantes this Aug. Aryan Mishra, a resident of Faridabad's NIT-5, was in a Duster that was chased by the vigilantes, who were in a Swift with a 'lal-neela' beacon, for 29km, according to the charge sheet. Anil Kaushik, the main accused who was at the time a member of Faridabad's cow protection task force (Haryana has one in each district), and his four accomplices had claimed they were acting on a tip-off that the Duster was being used for cattle smuggling. The crime branch filed the charge sheet before a judicial magistrate's court in Faridabad, ACP Aman Yadav confirmed. The 600-page document names Kaushik, Adesh Kumar, Varun, Saurav Sharma and Krishan and details statements of 30 witnesses, including Aryan's co-passengers, in the car.In the FIR registered after the incident, the five accused were booked under Section 103(1) (murder) of BNS. The charge

sheet replaces this with BNS Section 103(2), which specifies punishment for a group of five or more that commit murder on the grounds of "race, caste, community, sex, place of birth, language, personal belief or any other similar ground".

IPC did not have a specific section for lynchings. This will be among the earliest cases in the country to see BNS 103(2) being invoked. Faridabad police also added two more offences against the accused in the charge sheet - BNS Section 61(2A) for criminal conspiracy, and 238 (2) for intentionally concealing evidence. Other FIR charges for unlawful assembly and rioting with deadly weapons along with provisions of the Arms Act were retained in the charge sheet.According to the investigation, Aryan left his house in Faridabad's NIT-5 around 1.30am on Aug 24 to go out to eat with his landlady Sujata Gulati, her sons Harshit and Sagar alias Shanky, and their neighbour Kriti Sharma. The Duster was being driven by Harshit when Kaushik and his associates started chasing them."The group went out to have



noodles that night, but before they could reach the eatery, the Swift tried to intercept them in Sector 21C. Thinking it was police who wanted to arrest Shanky, wanted in an assault case, Harshit hit the pedal and the accused started chasing them," a crime branch officer told TOI.

They tailed the group till Palwal on Delhi-Agra highway and fired at the car. Aryan, who was in the passenger seat, was hit by two bullets."Anil Kaushik fired six to seven rounds during the chase. The first two were fired near Badkhal flyover. Two or three more rounds were fired before Gadpuri toll plaza, and another round was fired after the toll barricade," a police source said, citing the accused's statements given during their interrogation. The source said a bullet hit Aryan on his head near the left ear. "Harshit stopped the car on noticing that Aryan was bleeding. The vigilantes stopped too. Anil Kaushik said he got out of the Swift and again fired at Aryan because he didn't step out of the Duster. Anil suspected that someone in the Duster may retaliate. This bullet hit Aryan on his chest," the source said. It was

only when the two women in the Duster started screaming that the vigilantes realised they had chased the wrong group, the officer said, adding that they got back into the Swift and drove off.

Aryan was taken to SSB Hospital in Faridabad, where he succumbed to his injuries. Police were alerted and the accused were arrested on Aug 29 and 30.

Asked why Kaushik shot Aryan from close range, the crime branch officer cited above said it appeared he "wanted to stop smugglers" and "gain popularity" among cow vigilantes, but "things didn't go as per his plan".

They alerted police, and a team from the Rewari Sadar station rushed to the spot. The woman was identified as Sarita, a member of the Pataudi Bar Association, they said. "Sarita's family members confirmed that the body was

Canada is already examining tariffs on certain US items following Trump's tariff threat

TORONTO. Canada is already examining possible retaliatory tariffs on certain items from the United States should President-elect Donald Trump follow through on his threat to impose sweeping tariffs on Canadian products, a senior official said Wednesday.

Trump has threatened to impose tariffs on products from Canada and Mexico if the countries don't stop what he called the flow of drugs and migrants across southern and northern borders. He said he would impose a 25% tax on all products entering the U.S. from Canada and Mexico as one of his first executive orders.

But Trump posted Wednesday evening on Truth Social that he had a "wonderful conversation" with new Mexican President Claudia Sheinbaum and she "agreed to stop Migration through Mexico." "Mexico will stop people from going to our Southern Border, effective immediately. THIS WILL GO A LONG WAY TOWARD STOPPING THE ILLEGAL INVASION OF THE USA. Thank you!!!" Trump posted.It was unclear what impact the conversation will have on Trump's plan to impose tariffs.

In Canada, a government official said Canada is preparing for every eventuality and has started thinking about what items to target with tariffs in retaliation. The official stressed no decision has been made. The person spoke on condition of anonymity as they were not authorized to speak publicly.

When Trump imposed higher tariffs during his first term in office, other countries responded with retaliatory tariffs of their own. Canada, for instance, announced billions of new duties in 2018 against the U.S. in a titfor-tat response to new taxes on Canadian steel and aluminum. Many of the U.S. products were chosen for their political rather than economic impact. For example, Canada imports \$3 million worth of yogurt from the U.S. annually and most comes from one plant in Wisconsin, home state of then-House Speaker Paul Ryan. That product was hit with a 10% duty.

He's trying to kill me!': Florida man charged with murder after beating golfer to death

World. A 36-year-old man faces a first-degree murder charge after police say he beat a golfer to death with the victim's clubs at a local golf course, USA Today reports. The attack happened Monday afternoon at Sandhill Crane Golf Club, northwest of West Palm Beach. Police identified the suspect as Junior Boucher and the victim as 65-year-old Brian Hiltebeitel. Witnesses told police Boucher hit Hiltebeitel with a golf club near the first hole. He then chased Hiltebeitel to a pond. The attack continued in the water. Witnesses heard Hiltebeitel yell, "He's trying to kill me!" Police say Boucher choked Hiltebeitel before leaving the pond and walking, halfnaked, toward a wooded area. Officers arrived shortly after and found Hiltebeitel's body in the pond. Despite efforts to revive him, he was pronounced dead at the scene. Boucher was soon spotted fleeing the area and was arrested after police used an electronic control device to subdue him.Palm Beach Gardens police officer Javier Garcia told USA Today that authorities are still investigating the case, saying, "Detectives have not discovered a motive as of yet, as this appears to have been a random act of violence."

Officers used an "electronic control device" to arrest Boucher before taking him to a hospital for a medical check-up. He was then transported to jail, where he remains without bond. Boucher, a West Palm Beach resident, refused to speak with detectives without an attorney present. He is set to appear in court on December 26 to face the murder charge.

White House pressing Ukraine to draft 18-yearolds so it has enough troops to battle Russia

WASHINGTON. President Joe Biden's administration is urging Ukraine to quickly increase the size of its military by drafting more troops and revamping its mobilization laws to allow for the conscription of those as young as 18.

A senior Biden administration official, who spoke on the condition of anonymity to discuss the private consultations, said Wednesday that the outgoing Democratic administration wants Ukraine to lower the mobilization age to 18 from the current age of 25 to expand the pool of fighting-age men available to help a badly outnumbered Ukraine in its nearly three-year-old war with Russia. The official said "the pure math" of Ukraine's situation now is that it needs more troops in the fight. Currently, Ukraine is not mobilizing or training enough soldiers to replace its battlefield losses while keeping pace with Russia's growing military, the official added.The White House has pushed more than \$56 billion in security assistance to Ukraine since the start of Russia's February 2022 invasion and expects to send billions more

to Kyiv before Biden leaves office in less than months.But with time running out, the Biden White House is also sharpening its viewpoint that Ukraine has the weaponry it needs and now must dramatically increase its troop levels if it's going to stay in the fight with Russia. White House National Security Council spokesman Sean Savett in a statement said the administration will continue sending Ukraine weaponry but believes "manpower is the most vital need" Ukraine has at the moment. "So, we're also ready to ramp up our training capacity if they take appropriate steps to fill out their ranks," Savett said. The Ukrainians

have said they need about 160,000 additional troops to keep up with its battlefield needs, but the U.S. administration believes they probably will need more than that

More than 1 million Ukrainians are now in uniform, including the National Guard and other units. Ukrainian President Volodymyr



Zelenskyy has been hearing concerns from allies in other Western capitals as well that Ukraine has a troop level problem and not an arms problem, according to European officials who requested anonymity to discuss the sensitive diplomatic conversations. The European allies have stressed that the lack of depth means that it may soon become untenable for Ukraine to continue to operate in Russia's Kursk

Kursk has become further complicated by the arrival of thousands of North Korean troops, who have come to help Moscow try to claw back the land seized in a Ukrainian incursion this year.

The stepped-up push on Ukraine to strengthen its fighting ranks comes as Ukraine braces for Presidentelect Donald Trump to take office on Jan. 20. The Republican said he would bring about a swift end to the war and has raised uncertainty about whether his administration would continue the vital U.S. military support for Ukraine."There are no

easy answers to Ukraine's serious manpower shortage, but lowering the draft age would help," said Bradley Bowman, senior director of the Center on Military and Political Power at the Foundation for Defense of Democracies. "These are obviously difficult decisions for a government and society that has already endured so much due to Russia's invasion.

President-elect Donald Trump's team reports bomb threats to cabinet nominees

WASHINGTON. Several members of Donald Trump's incoming administration have received threats including bomb alerts, a spokeswoman for the president-elect said Wednesday.

"Last night and this morning, several of President Trump's Cabinet nominees and Administration appointees were targeted in violent, unAmerican threats to their lives and those who live with them," said transition team spokeswoman Karoline Leavitt in a statement. Without saying who was targeted, Leavitt said these incidents ranged from bomb threats to "swatting," the practice in which police are summoned urgently to someone's house under false pretenses. The FBI said in a statement that it is "aware of numerous bomb threats and swatting incidents targeting incoming administration nominees and appointees, and we are working with our law enforcement partners. We take all potential threats seriously, and as always, encourage members of the public to immediately report anything



they consider suspicious to law enforcement."Elise Stefanik, a Trump loyalist congresswoman tapped to be UN ambassador, said her residence in New York was targeted in a bomb threat.In a statement she said she and husband and small son were driving home from Washington for the Thanksgiving holiday when they learned of the threat.In Florida, meanwhile, the Okaloosa County sheriff's office said in an advisory posted on Facebook that it "received notification of a bomb threat referencing former Congressman Matt Gaetz's supposed mailbox at a home in the Niceville area around 9 a.m. this morning."While a family member resides at the address, they said "former Congressman Gaetz is NOT a resident. "The mailbox however was cleared and no devices were located. The immediate area was also searched with negative results."Gaetz was Trump's initial pick to serve as attorney general, but he withdrew from consideration amid allegations that he paid women for sex and slept with underage women. Gaetz has vehemently denied any wrongdoing and said last year that a Justice Department investigation into sex trafficking allegations involving underage girls had ended with no federal charges against him. As he prepares to return to the White House in January, Trump has already swiftly assembled a cabinet of loyalists, including several criticized for severe lack of experience. The Republican, who appears set to avoid trial on criminal prosecutions related to attempts to overthrow his 2020 election loss, was wounded in the ear in July in

Hindu American groups seek sanctions against Bangladesh over attacks on minorities

WASHINGTON. Condemning attacks on minorities in Bangladesh, several Hindu American groups have sought that US aid for the South Asian country be made contingent on its government taking measurable action to protect these populations. Bangladesh's minority Hindus, which constitute only about 8 per cent of the 170 million population, have faced over 200 attacks in 50-odd districts since the fall of Sheikh Hasina's Awami League government on August 5.

Things took a turn for the worse this week after Hindu spiritual leader Chinmoy Krishna Das was arrested in a sedition case. He was later denied bail by a court, triggering protests by community members in various locations, including the capital Dhaka and the port city of Chattogram. Das was a member of the International Society for Krishna Consciousness (ISKCON) and was recently expelled. Vishva Hindu Parishad America (VHPA) president Ajay Shah said the news of Das' arrest, vandalism of Kali Mandir in Chittagong and the rising attacks on Hindus across Bangladesh are disconcerting." Is this the human rights legacy the Biden administration wants to be remembered for," he asked.VHPA general secretary Amitabh Mittal said, "The silence of global media regarding the ongoing atrocities against minorities in Bangladesh is deafening. The recent arrest of an ISKCON priest and the violent attacks on Hindu temples underscore the

Court noted that Section 65 of the Act mandates that either the adjudicating officer or the court must provide compensation to the victim or their legal heirs within six months of the incident. Given that the petitioner's daughter died in 2022, the statutory timeline appears to have been violated.

Passengers configure safety features to activate based on time or location, such as night-time journeys or rides from specific localities.

Punjab's road initiative shows the way to safer highways

To tackle road safety issues and the alarming number of road fatalities in the state, one of the major challenges of Punjab, Chief Minister Bhagwant Mann held a meeting of the Chief Secretary, Transport Minister, Director General of Police (DGP), ADGP (Traffic) and Traffic Adviser, Punjab, in April, 2023. Around 12 to 13 persons die in mishaps every day. An innovative and determined approach to reduce the accidents was decided upon.he Punjab Road Safety and Traffic Research Centre (PRSTRC) was directed to identify accident-prone routes using a real-time data-driven approach. The PRSTRC mapped 144 critical routes spanning 4,100 km, where at least 60 per cent of the mishaps happened, usually between 6 pm and midnight, when the enforcement was lean. With only 1,800 traffic personnel for over 1.3 crore vehicles, 180 cities and towns and more than 72,000 km of highways, Punjab's 15-year-old highway patrol system, with its ageing fleet and outdated gadgets, was illequipped to handle the rising challenges.

Determined to find a speedy solution, the financial and procedural obstacles were cleared by the CM. On August 11, 2023, the Cabinet approved the creation of the Sadak Surakhya Force (SSF). Designed for 24/7 patrolling on the identified high-risk routes, the SSF was set up with 1,600 personnel in its first phase, including 1,255 fresh recruits. They underwent a rigorous six-month training. The SSF team has an average age of 22, with women constituting 28 per cent of the strength, marking a significant step towards gender equality in law enforcement.

Women were earlier excluded from vehicle driving and maintenance training due to outdated norms. The SSF became the first Punjab Police unit to have 350 women in motor transport training. Incidentally, all of them had volunteered for it. A 12-module course was introduced, covering crash investigation, emergency response, road engineering basics and advanced navigation technology. Conducted at the in-service training centre in Kapurthala, it focused on imparting practical skills.Data from the National Crime Records Bureau reveals that 650 to 700 police and paramilitary personnel lose their lives every year while on duty and 80 to 90 per cent of these fatalities are due to road accidents. These numbers underscore the critical need for improved road safety, especially for those enforcing it. To address this issue, uniforms and vehicles were designed for enhanced visibility and safety, particularly for night operations. The uniforms feature retroreflective piping and jackets with reflective bands. The vehicles, Toyota Hilux models, selected for their safety standards and off-road capabilities, are also equipped with retroreflective markings and painted in white, red and yellow colours, ensuring maximum visibility in foggy and low-light conditions, commonly experienced during the winter months. The SSF was officially launched in January this year. Operational since February 1, it has been providing round-the-clock patrolling in all 144 high-risk routes. Each team has four members, including at least one woman, and stationed every 30 km to ensure that accident victims receive medical care within 15 minutes.

Strategic halting points, that have been determined by using three years' accident data, ensure optimal coverage and response time. Patrolling routes and schedules (morning, evening, late night and lean hours) are planned using crowdsourced data from Google Maps and TomTom, ensuring near-real time response and comprehensive coverage. The second phase will focus on enforcing violations such as speeding, drunk driving, use of mobile phone while driving and non-compliance with helmet and seatbelt laws. The SSF vehicles are equipped with nightvision speed guns and public address systems to guide the road users. This evidence-based datadriven strategy has shown immediate results. Within eight months, the SSF has reduced the average emergency response time to just six minutes and 41 seconds, saving numerous lives.

Why scaling back troops on LAC is risky

A key outcome of the talks was the initiation of Coordinated Joint Patrolling along the Line of Actual Control (LAC).India's stance on its relationship with China in recent years has been firmly anchored in the principle of resolving friction points along the LAC as a precondition for any meaningful progress. Experts have long stressed the importance of a structured approach to normalisation, involving de-escalation, disengagement and the eventual de-induction of troops from sensitive border areas.

However, given the deep trust deficit between the two Asian powers, any move to revert the troop levels to the pre-2020 conditions poses significant risks for India.Recent weeks have seen a substantial momentum in multilateral diplomacy, with platforms like the Shanghai Cooperation Organisation (SCO) summit and the G20 meetings

fostering an environment conducive to breakthroughs between the two nations. Agreements reportedly under discussion include the resumption of direct flights, reciprocal accreditation of journalists and improved visa facilities, signalling a potential thaw in bilateral relations. While these developments are welcome, they represent only the low-hanging fruit. Any temptation to scale back troop deployments to the pre-2020 levels must be resisted as such a move could prove disastrous. This caution is rooted in China's history of violating border agreements, including the Five Principles of Peaceful Coexistence (1954), the Border Peace and Tranquillity Agreement (1993), the Agreement on Confidence-Building Measures (1996), the Protocol for the Implementation of Military Confidence-Building Measures (2005) and the Working Mechanism for Consultation and Coordination (2012). Despite 31 rounds of talks under the Working Mechanism for Consultation and Coordination framework and 21 Corps Commander-level discussions yielding some progress, these mechanisms have failed to prevent incidents like the 1962 war, the 1967 Nathu La conflict, the 1975 firing incident and the more recent



confrontations at Sumdorong Chu, Chumar, Depsang, Doklam, Galwan and Yangtse. This history underscores the need for continued vigilance in managing bilateral relations and securing the LAC. The critical question for India is how much trust can be placed in Xi Jinping's leadership. Time and again, China has embarrassed India by expanding its claims to previously undisputed areas. For instance, Galwan Valley, once considered uncontroversial, became a flashpoint. Similarly, in Bhutan, China arbitrarily raised the Sakteng Wildlife Sanctuary as a disputed area to pressure India. Disputes along the LAC are categorised as either contested areas or zones of differing perceptions of the boundary. Beyond territorial issues, China's "grey zone" tactics include cyberattacks - India is the second-most targeted country in Asia after Taiwan — causing losses amounting to billions of dollars. Moreover, China actively interferes in India's neighbourhood, straining relations with Nepal, Bangladesh, Sri Lanka, the Maldives and, to a lesser extent, Bhutan.

Instances like its near-success in turning the Maldives against India, gaining port access in Sri Lanka, and suspected military activity on Myanmar's Coco Islands highlight China's strategic

manoeuvring to contain Indian influence in the Indian Ocean region.In this complex and highstakes environment, it is difficult to trust China's overtures or confidence-building measures. India must ask: What assurances, if any, has Xi Jinping provided to guarantee that China will not engage in future conflicts? Without credible commitments, any premature de-induction of troops could embolden Beijing to initiate further incursions, forcing India into a settlement on unfavourable terms.At a time when trust between India and China is at its nadir and China holds an upper hand in economic, military, intelligence and technological domains, troop de-induction from the LAC must not be entertained under any circumstances. For the first time since Independence,

Chinese troops are deployed outside their peacetime accommodations in the challenging high altitudes of the Great Himalayan ranges. This has created significant challenges for Beijing, including backlash from families due to the one-child policy, high sickness rates among Han Chinese soldiers and the need to recruit local troops better suited to the harsh conditions of Tibet and Xinjiang.Despite efforts at theaterisation, the Tibetan and Xinjiang military regions remain distinct, reflecting Beijing's logistical and organisational challenges. India must maintain consistent military and diplomatic pressure to compel China to resolve the border issue on favourable terms. Any haste to normalise relations by withdrawing troops will only encourage China to launch another major incursion (the Big One), further undermining India's position. While economic ties with China - India's largest trading partner - offer short-term benefits, these gains should not come at the cost of national security and military readiness.

This holistic tactic underscores the need for behavioural reform rather than mere retribution. In schools, innovative methods are gaining ground. For example, rowdy students in UP schools are assigned such tasks as organising books or assisting peers. Meanwhile, creative punishments like rewriting lessons or engaging in debates channel energy constructively and emphasise growth over reprimand.



Discipline should not be about just imposing consequences

but also guiding young minds toward self-awareness and societal contribution. Restorative justice, community service and counselling are replacing outdated corporal punishment, which often leaves emotional scars. Nevertheless, these reforms require collective commitment. Policymakers must institutionalise such practices, educators must adopt empathetic approaches and parents must support these efforts. Experts from NIMHANS (National Institute of Mental Health and Neurosciences) have stressed the importance of balancing love and limits at home to complement schoolbased initiatives. Constructive discipline reflects the society's recognition that youth's missteps often stem from immaturity, not malice. By transforming mistakes into learning experiences, we not only shape better individuals but also foster a more compassionate community. It's time to make responsibility the cornerstone of discipline, steering youth away from chaos and towards civic-mindedness.

The rat race is ruining education

RECENTLY, I read an illuminating piece written by Henry Giroux — one of the finest educationists of our times. While reflecting on the grand victory of Donald Trump in the US presidential election, Giroux examined the crisis in education. If..

RECENTLY, I read an illuminating piece written by Henry Giroux - one of the finest educationists of our times. While reflecting on the grand victory of Donald Trump in the US presidential election, Giroux examined the crisis in education. If education is reduced to a set of "instrumental skills needed to compete in the global economy" or if it continues to privilege "standardised tests over critical thinking", as he reminded us, it will lose its radical and emancipatory potential. His complaint is that even the democrats or liberals in America have failed to recognise what education ought to be - "not merely a service or a tool for economic adaptation, but the very foundation of democratic life". As the prevalent practice of education seeks to produce "compliant workers rather than active/informed citizens," argues Giroux, "Americans find themselves in a world where ignorance is weaponised and truth is under siege". No wonder he sees with deep anguish the rise of "a band of white supremacists, neo-Nazis, radical Christian nationalists and cruel band of misogynists and neoliberal fascists" in the US. Moreover, as neoliberal universities tend to prioritise "profit over democratic values, civic responsibility and critical thought", we see the invasion of 'pedagogical terrorism' that suppresses critical thinking, distorts history, stifles dissent and dehumanises the oppressed.Indeed, in the age of 'fascist dreamworlds', as Giroux argues passionately, "what is needed is a collective determination to reshape mass consciousness through critical pedagogy".

It seems that we, too, can draw a couple of lessons from his insights and his plea for a creatively nuanced critical pedagogy. In fact, the rise of Trump is not an

isolated phenomenon in the age of right-wing nationalism. Even our own country, despite the ritualisation of periodic elections, is not altogether free from the monologues of 'populist/charismatic' leaders, the tyranny of majoritarianism, the celebration of hyper-masculine nationalism and some kind of Hindu supremacist

thinking. In this context, I will make two arguments.

First, in India too, we are witnessing some sort of 'pedagogical terrorism'particularly, the way our children are getting increasingly deprived of the taste of self-reflexive, libertarian education. Yes, their formative years are primarily spent preparing for standardised tests like JEE, NEET and CUET. As this sort of coaching centredriven instrumental strategy becomes more important than the joy of creative learning, critical thinking and the aspirations for a just and humane world, it becomes exceedingly difficult for them to celebrate a vision of life beyond careerism, consumerism and economic productivity. It destroys all alternative strivings, kills the power of the imagination and makes them

accept that the ultimate destiny of life is to become 'compliant workers' rather than politically awakened, culturally sensitive and active citizens in search of a democratic living. Second, we are witnessing the systematic decay of our public universities. In recent times, the organised attack on

some of our leading public universities indicates that it is becoming increasingly difficult to retain the spirit of academic freedom, the culture of nuanced debates and conversations and the ethos of cultural pluralism. Is it, therefore, surprising that, according to the 2023 Academic Freedom Index, India is ranked



161st out of 179 countries? Imagine the fate of a university if the authorities get panicky when a professor plans to organise a seminar on the Palestine crisis or the way Israel violated all sorts of international laws, engaged in war crimes, didn't spare even schools, hospitals and residential buildings and killed no less than 43,000 people over

While the vibrancy of critical thinking is repressed, universities are asked to engage in an absurd game the strategic act of pleasing the 'ranking agencies' through the production of largely meaningless research papers, seminars and projects. What do you

> do with a 'top-ranking' university if it loses its soul and conscience, robs education of its transformative potential and produces only a bunch of conformists? In fact, together with the decline of public universities, we are also seeing the corporatisation of universities. These corporate/neoliberal universities sell education as a 'product' to their rich and affluent 'clients'

> or instance, a fancy private university in India charges more than Rs 12 lakh per year for an undergraduate programme. Even if the university claims that it wants to help students become "well-rounded individuals who can think critically", the fact is that, barring exceptions, young learners from an elitist/exclusivist/corporate university are likely to miss what, as my experience as a faculty member at Jawaharlal Nehru University suggests, a sensitive student from an inclusive public university experiences. This

includes the empathy that an exposure to cultural diversity generates, the art of listening to the tales of caste/class/ethnic/gender violence that some of his/her friends might have experienced and hence the art of resistance against casteism, religious fundamentalism, majoritarianism, patriarchy and gross economic inequality.

Probe Agency Team, Investigating Cyber Fraud Case, Attacked in Delhi

New Delhi: An audio clip, exclusively accessed by India Today, has revealed how more people were mobilised with weapons during the violence that broke out in Sambhal over a court-mandated survey of a mosque. The violence, during which a mob clashed with police, resulted in the death of five people. The investigation team recovered the audio clip from mobile phones that were seized from the suspects. In the clip, an unidentified person can be heard giving a call for more people to be mobilised near the Mughal-era Shahi Jama Masjid."Saman lekar aa masjid ke paras, mere bhai ka ghar hai (bring weapons and come near the mosque, my brother's house is nearby)," the person can be heard saying. The police have arrested 25 people so far and registered seven FIRs. Samajwadi Party MP Zia-ur-Rehman Barq and local MLA Iqbal Mehmood's son Sohail Iqbal are named in the FIRs.In its FIR, police alleged that Barq visited the Shahi Jama Masjid days before the violence and made provocative remarks that led to the incident. Tension started in the Uttar Pradesh city after a local court ordered a survey of the Shahi Jama Masjid following claims that a working to track down the attackers. temple previously stood at the site. Violence erupted on Sunday as protesters gathered near the mosque and

The violence saw stones being pelted at security personnel and arson. Vehicles were torched, and over 20 police personnel were injured. Earlier this week, the Uttar Pradesh police released images of the suspects involved in the violence. The government said pictures of the accused would be put up in public places, and those helping identify the suspects would

Nuclear-capable ballistic missile tested from INS Arighaat: Sources

New Delhi. India has tested a nuclear-capable submarinelaunched ballistic missile (SLBM), designed for a strike range of 3,500 km, from the newly commissioned nuclear-powered submarine INS Arighaat, sources said. Sources said the test, which took place off the coast of Visakhapatnam, involved the K-4 missile, a solidfueled SLBM. This was the first test of the K-4 missile from the INS Arighaat, which was commissioned into the Indian Navy in August. The K-4 has so far only been tested from submersible pontoons over the last several years.India had issued a Notice to Airmen (NOTAM) and a public warning for an intermediate-range missile test over a 3,490-km flight corridor between November 27 and 30.

A detailed analysis of the test results is underway to



determine whether the missile successfully met its trial parameters and objectives, sources said. The K-4 missile was developed by Defence Research and Development Organisation (DRDO) to arm the country's nuclear-powered submarines. Countries like the US, Russia and China already have over 5,000-km range SLBMs. The 6,000-tonne INS Arighaat is India's latest nuclear-powered submarine, strengthening the country's second-strike capability. The first nuclearpowered submarine, INS Arihant, which was commissioned into service in 2016, is armed with only 750-km range K-15 missiles.

The third of these submarines, which will have a displacement of 7,000 tonne, is set to be larger and more capable than the current two submarines. It is likely to be inducted next year.Last month, the Cabinet Committee on Security (CCS) approved the construction of two more nuclear-powered attack submarines to boost India's presence in the Indo-Pacific.

The NIA took over the case on October 25, 2023, and identified Khan as a critical operative responsible for facilitating the transportation of arms, ammunition, and funds to Bengaluru-based terror modules. The case gained momentum when Interpol issued a Red Notice on August 2 this year at the CBI's request. Following intelligence inputs, he was tracked to Rwanda. A security team from the NIA brought him back to India for prosecution. This is the third wanted criminal to be extradited by the CBI this month.On November 14, Barkat Ali Khan, wanted in a rioting and explosives case registered in Mumbai, was extradited from Saudi Arabia. The CBI had issued a Red Notice against him in December 2022.Raihan Arabikkalalarikkal, accused of raping a minor in Kerala, was also tracked to Saudi Arabia. He was brought back on November following a Red Notice issued in December 2023. Since 2021, the CBI has coordinated.

Cyclone Fengal set to intensify, heavy rainfall in several Tamil Nadu districts

Cyclone Fengal is expected to intensify and cross Tamil Nadu-Puducherry coasts by November 30. The Indian Navy is actively preparing for relief and rescue operations to mitigate the storm's impact.

New Delhi: Cyclone Fengal is expected to intensify and cross Tamil Nadu-Puducherry coasts by November 30. The Indian Navy is actively preparing for relief and rescue operations to mitigate the storm's impact.

With heavy rain lashing the region for the second consecutive day, over 1,200 residing in low-lying and vulnerable areas in the coastal delta districts were shifted to

shelters and temporary relief camps on Wednesday. The cyclonic storm led to heavy rainfall and disrupted normal life in Cuddalore districts, especially coastal areas which were severely affected with rough seas and waves rising over 10 feet. In Nagapattinam, where an orange alert was issued, people from low-lying areas were accommodated across 12 camps in the district. While most were moved as a precaution, others were moved to safety following flooding in vulnerable areas. The deep depression currently over the southwest Bay of Bengal, is on track to intensify into a cyclonic storm, named Cyclone Fengal. In its 5.30 am IST weather update, India Meteorological Department (IMD) stated the system was centered near latitude 9.1°N and longitude 82.1°E, approximately 110 km eastnortheast of Trincomalee in Sri Lanka, 310 km southeast of Nagappattinam, 410 km southeast of Puducherry, and 480 km south-southeast of Chennai. The storm was moving north-northwest at a slow pace and is expected to skirt the Sri



Lankan coast over the next 12 hours. It is projected to make landfall as a deep depression with wind speeds of 50-60 kmph, gusting up to 70 kmph, between Karaikal and Mahabalipuram on the CYCLONE NAMING AND morning of November 30. There is potential for it to briefly intensify into a cyclonic storm with winds reaching 65-75 kmph and gusts up to 85 kmph by November 29.On November 28, orange alert was issued for Kancheepuram, Chengelpattu, Villupuram and Cuddalore district and Pondicherry with forecast of heavy to very heavy rainfall. Anticipating potential impacts, the Indian Navy's



down. According to some research, resting metabolism, which is the number of kilojoules used by the body at rest, increases rather than decreasing as people gain more weight. As someone gains more weight from storing fat, the body needs to support that extra weight so more muscle is added. So, the conclusion is, the more muscle you have, the higher your metabolic rate tends to be even at



Myth 4: You need to exercise in the 'fat

Tim says, 'the truth is, you need to exercise at a low-to-moderate level of intensity to burn fat. Yes, it is true that the body burns the greatest percentage of fat at lower intensities of aerobic exercise, but at higher intensities you burn way more total kilojoules - and more fat kilojoules overall. If you do low intensity workouts, it will help promote weight and fat loss; but you need to do them for a longer period.

Myth 5: You gain weight when you stop

The truth is, when you check over a long period of time, smokers do not control their weight any better than nonsmokers. In fact, according to

studies, very heavy smokers gain more weight than light smokers. Tim says, the 'thin smoker' image arises because thin people are more likely to take up the habit in the first place. Once they start

smoking, they gain just as much, and sometimes even more, weight as the rest of the non-smoking population.'

To control cholesterol, turn to pistachios

Simple dietary changes like adding pistachio nuts to the diet can lead to multiple health benefits -- diabetes could be controlled, and the propensity for heart disease may be reduced in Indians, a new study has found.

The study, the first of its kind with a trial period of six months, was carried out by the Diabetes Foundation of India (DFI) and the National Diabetes, Obesity and Cholesterol Foundation. The results of the study were released Monday, even as

the prevalence of obesity and diabetes are rapidly rising Nuts (mainly pistachios, almonds and walnuts) have

been shown to have beneficial effects on glycemic and lipid parameters.

Pistachios have a low glycemic index, are naturally cholesterol free, and are source of protein, fibre and antioxidants, the study found.

These properties make consumption of pistachios potentially useful for those at risk for obesity and heart

"Pistachios are part of the traditional Indian diet.

However, the health effects have not been clearly understood. This study shows multifaceted beneficial effects of pistachios suitable for the Indian body type, for the alleviation



of multiple risk factors," said Anoop Mishra, chairman, Fortis Centre of Excellence for Diabetes Metabolic Diseases and Endocrinology (CDOC).

Seema Gulati, research head at the National Diabetes, Obesity and Cholestrol Foundation, said: "Based on this study, we can say that pistachios provide an excellent snack option, especially for those at risk of metabolic problems and diabetes. They provide a beneficial effect in two ways: One, by displacing energy from other unhealthy sources, and second, due to their own intrinsic nutritional properties".

Diabetes has taken epidemic proportions in India, and emerged as one of the most serious healthcare problems.

The stock of Adani Total Gas soared 18.58 per cent, Adani Power zoomed 11.44 per cent, Adani Energy Solutions jumped 9.99 per cent and Adani Green Energy surged 9.99 per cent on the BSE

Shares of Adani Enterprises climbed 5.32 per cent, NDTV (3.35 per cent), Adani Wilmar (3.17 per cent), Adani Ports (2.25 per cent) and Sanghi Industries (2.19 per cent). Adani Energy Solutions and Adani Green Energy also hit their highest trading permissible limit for the day.

However, ACC and Ambuja Cements were trading marginally lower. The BSE benchmark Sensex traded 688.82 points lower at 79,545.26 and the NSE Nifty quoted 222.20 points lower at 24,052.70.

On Wednesday, shares of all Adani Group firms ended sharply higher, with Adani Total Gas and Adani Power soaring nearly 20 per cent.Embattled billionaire Gautam Adani and his aides have not been charged under the US Foreign Corrupt Practices Act, an Adani Group entity said on Wednesday, adding that they faced three other charges, including securities and wire fraud that are punishable with monetary fines. The US Department of Justice's (US DOJ) indictment filed in a New York Court last week does not mention Gautam Adani, founder chairman of the ports-to-energy conglomerate, his nephew Sagar, or Vneet Jaain in any count related to conspiracy to violate the FCPA, Adani Green Energy Ltd (AGEL), said in a stock exchange filing.

AGEL is at the heart of the allegation of USD 265 million bribes being paid to Indian officials to secure solar power sale contracts that could bring in USD 2 billion of profits over a 20-year period to the firm.

The three -- executives at AGEL -- have only been charged with securities fraud conspiracy, wire fraud conspiracy, and securities fraud, the company said.

In general, the penalties for such charges are less severe than bribery.Adani Group had last week denied all allegations as baseless, and said it would seek legal recourse to defend itself.

SoftBank CEO meets startup founders

BENGALURU: SoftBank CEO Masayoshi Son on Wednesday discussed Artificial Intelligence (AI), Gen AI potentials, investments and collaborations with portfolio start-up founders. Over 10-12 founders including Paytm's Vijay Shekhar Sharma, Flipkart CEO Kalyan Krishnamurthy, Lenskart's co-founder Peyush Bansal, Ola's Bhavish Aggarwal and InMobi founder Naveen Tewari were present, and the meeting was focused on AI and its future, sources aware of the meeting said.Later, he met a few founders one-on-one including Tewari and Aggarwal, among others. Sources said Tewari discussed works of InMobi and Glance in GenAI space. SoftBank made its first investment in InMobi in 2011. The consumer tech company leverages AI to drive growth and in 2019, InMobi built Glance, the AI-based software company.In 2011, SoftBank invested \$200 million and InMobi became the first start-up in the country to turn into a unicorn. Sources added Son was excited to know about Glance and it looks like in future the Japanese firm might invest in Glance, which currently counts Google and Jio Platforms as its investors. Aggarwal also had a meeting with Son and shared the picture on X and said, "Always amazing to meet @masason.. Such an energising discussion on AI, AGI, Energy and India. We will make the future here in India together."

Son visited India last year and SoftBank's India portfolio consists of close to 27 start-ups including Swiggy, Ola Electric, First Cry, InMobi and Lenskart, among others. Earlier, as per reports, Son had met Reliance Industries' Mukesh Ambani. Apart from InMobi, SoftBank's other portfolio company OfBusiness is also targeting to go public next year.Reports claimed Microsoftbacked OpenAI is allowing its employees to sell \$1.5 billion worth of shares to SoftBank.

The Japanese investor, posted \$7.7 billion profit in September quarter, has been betting big on AI and investments in India. It has invested about \$15 billion in Indian firms. Sources said he spoke about India's opportunity in chip design and also made collaboration commitments and that the firm might invest more in the country.

As inflation pinches, govt mulls reducing food weightage in CPI. Here's why

The govt is exploring a reduction in food's weight in the Consumer Price Index to reflect changing consumption patterns and manage inflation, as food prices remain volatile and seasonally driven

NEW DELHI The government is reportedly considering reducing the weight of food items in the Consumer Price Index (CPI) basket to address inflation concerns. The move follows findings from the Household Consumption Expenditure Survey (HCES) 2022-23, which highlighted a decline in household spending on food.

According to The Economic Times, the weightage of food items in the CPI basket could be reduced by up to 6.5 percentage points in rural areas and 3.4 percentage points in urban areas. This proposal comes amid rising calls to adjust how food items impact inflation data. The 2023-24 Economic Survey suggested excluding food from inflation calculations, with Chief Economic Adviser V Anantha Nageswaran citing volatile food prices as a primary driver of inflation spikes. Removing highly volatile commodities like tomatoes, onions, and potatoes could reportedly lower retail inflation to 4 per

Why does food dominate CPI in India? Historically, food has been a dominant component of CPI in India for several reasons: • A significant portion of household income, particularly in rural areas, has been spent on food.• The agricultural base of India ties consumption patterns directly to food prices. • Food prices are highly volatile, influenced by monsoon dependency and supply chain disruptions.



However, recent government initiatives, such as the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY), have provided free rations to over 80 crore people, reducing the burden of food costs for many households. A report by the Economic Advisory Council to the Prime Minister revealed a sharp decline in food's share of household spending. In rural areas, it fell from 53 per cent in 2011-12 to 46.5 per cent in 2022-23. Urban areas saw a drop from 42.7 per cent to 39.2 per cent over the same period. How food items impact inflation

Food and beverages currently account for 45.9 per cent of the CPI basket, with over

120 food items included. The weight differs between rural and urban centres:In October, food inflation surged to a 15-month high of 10.9 per cent, pushing overall retail inflation to 6.2 per cent. The 2023–24 Economic Survey noted significant contributions to inflation from cereals (33.3 per cent), vegetables (30.6 per cent), spices (18.3 per cent), and milk (14.3 per cent).

Plans to update the CPI base year

Experts have called for updating the CPI base year, last revised in 2012, to reflect current consumption patterns more accurately. The government is reportedly considering 2024 as the new base year. Additionally, some outdated items like horse cart fares and video cassette prices may be removed from the index.

RBI's stance on interest rates

The RBI has held the repo rate steady at 6.5 per cent since February 2023, citing the risks of premature rate cuts. RBI Governor Shaktikanta Das recently cautioned that a rate cut would be "very risky," despite calls from the industry to reduce rates to spur growth.

India not playing cricket in Pakistan is unacceptable: PCB chief Mohsin Naqvi

New Delhi. Pakistan Cricket Board chairman Mohsin Naqvi has hit out at India once again ahead of the Champions Trophy 2025. Speaking at a press conference on Thursday, November 28, Naqvi said that it was not acceptable that India do not come to play an ICC tournament in Pakistan, despite the Pakistani side travelling to India for the 2023 ODI World Cup.Naqvi, who is struggling to keep the Champions Trophy entirely in Pakistan due to political differences between the two countries, said that he will do what is best for Pakistan cricket. Naqvi said that he was in touch with the ICC delegates on the matter and that the PCB was clear that they wanted to host the entire tournament in Pakistan.

'I promise we'll do what is best for Pakistan cricket. I'm constantly in touch with the ICC chairman and my team is talking to them constantly. We're still clear in our stance that it's not acceptable that we play cricket in India, and they don't play cricket here.



Whatever will happen, will happen on the basis of equality. We've told the ICC very clearly, and what happens next we'll let you know," Mohsin Naqvi said in the press conference on November 28.Naqvi further confirmed that they had not received any written communication from the Board of Control for Cricket in India (BCCI) about not travelling to Pakistan."Whatever we do, we will make sure the best outcome for Pakistan is achieved," Naqvi said. "But I repeat, and I am sure you know what I mean, it's not possible that Pakistan play in India, and they don't come here."The ICC is set to hold its board meeting on Friday, 29 November, to discuss the Champions Trophy and finalise the schedule for the eight-team event, which is slated to take place early next year, India Today has learnt. The announcement of the fixtures for this marquee ODI tournament has been delayed.

Pakistan holds the hosting rights for the Champions Trophy, but India's decision not to send its cricket team to play in Pakistan has created an impasse. The PCB has been adamant about not adopting a hybrid model, which would involve hosting some matches at a neutral venue.




Takes Back 'Death Wish' On Karanveer Mehra? Says 'He Made Personal Comments...'
