

Dhankhar says adjournment notices being 'weaponised' as mechanism of disruption

New Delhi, Nov 29: Rajya Sabha Chairman Jagdeep Dhankhar on Friday said adjournment notices under Rule 267 of the House are being



"weaponised" as a mechanism of disruption before adjourning the proceedings till Monday amid Opposition parties protest over corruption allegations against the Adani Group, and other issues. Like the previous three sittings of the ongoing Winter Session, the House could not take up scheduled business on Friday as well and the House proceedings were adjourned within minutes of the Assembly.

Opposition MPs started the protest soon after the chairman announced that he had accepted their 17 notices for suspension of scheduled business and take up issues related to corruption allega-

tions against the Adani Group, violence in Uttar Pradesh's Sambhal, and Manipur. "...these issues have been raised repeatedly during the week with the result that we have already lost three working days. These days should have been committed by us for public cause," Dhankhar said. The chairman said the loss of time, opportunity and question hour has given enormous setbacks to the people at large. "Now, I find honourable mem-

bers and I call upon you for deep reflection. Rule 267 is being weaponised as a mechanism of disruption and disruption from our normal working. There are very senior members," he said. The statement led to further protests, with some Opposition members raising slogans against Prime Minister Narendra Modi and the Adani Group. Expressing "deep anguish", Dhankhar said, "Our actions are not people-centric.

New Delhi, Nov 29: Prime Minister Narendra Modi on Friday said the BJP was the party of

people's choice because of the commitment to welfare and development, adding that the trend started by Odisha was followed by Haryana and now Maharashtra. Speaking of the BJP-led NDA returning to power at the Centre for a record third time, Modi, speaking in Bhubaneshwar, said, "Where ever I go in the world, people wonder how a large country like India with 140 crore citizens continues to vote the same party term after term." The Prime Minister said the impact of BJP's 2024 win is several times higher than in 2014 and 2019. "Haryana, Maharashtra results have revealed the scale of trust the country has in the BJP. Odisha voted BJP and then Haryana and Manarashtra followed. BJP's hallmark is people's trust," Modi said. The Prime Minister said Opposition parties

This statement comes after the party's unexpected defeats in Haryana and Maharashtra. Kharge made these remarks during the Congress Working Committee meeting at the AICC headquarters in New Delhi. He stressed that the party needs to learn from its recent electoral losses and make tough decisions to strengthen its organisation. Kharge expressed concerns over the reliability of electronic voting machines (EVMs), stating that they have made the electoral process "suspect". He urged the Election Commission

to ensure free and fair elections in the country. The ongress chief also slammed factional lights within the party, saying that a lack of unity has harmed the party more than anything. "We must fight elections together, stop making statements against each other, and focus on defeating our opponents," Kharge said. Kharge acknowledged that the party's performance in the Lok Sabha poll had filled them with new enthusiasm, but the results of the elections in three states held thereafter were not as expected. He stressed that the party needs to learn from these results, correct its weaknesses, and strengthen its organisation up to the booth level. "INDIA parties formed the government in two out of the four states. But our performance was below expectation. The result is a message as well as a challenge for the future," he said. The Congress chief also highlighted the need for the party to fine-tune its strategy for contesting elections in every situation. He emphasised that the ways of contesting elections have changed, and the party needs to make its "micro-communication" strategy better than its rivals. "We will have to learn to convert the atmosphere into results. What is the reason that we are not able to take advantage of the atmosphere?" he questioned. Kharge asserted that despite the party's electoral losses, issues like unemployment, inflation, and economic inequality remain burning concerns in the country. He also stressed the importance of the caste census.

Himachal CM Sukhu seeks special industrial package to boost state's economy

Shimla, Nov 29: Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu met with Union Minister for Commerce and Industry Piyush Goyal in New Delhi, seeking a special industrial package for the state. Sukhu emphasised the need for balanced regional development, citing the state's unique challenges due to its hilly terrain. 

J-K LG fires two govt employees for alleged terror links

Jammu, Nov. 29: Jammu and Kashmir Lieutenant Governor Manoj Sinha on Friday terminated two government employees from service for their alleged terror links, officials said. The fired employees have been identified as Abdul Rehman Naika who worked as a pharmacist in the health department, and Zahir Abbas, a teacher in the school education department, they added. Sinha invoked Article 311 (2) (c) of the Constitution to terminate the two employees after a probe by the law enforcement and intelligence agencies "clearly established their terror links". officials said. The LG has ordered termination of several government employees over the past few years under the same provision. Naika, a resident of Devsar in Kulgam district, was appointed as a medical assistant in 1992. "His links with Hizbul Mujahideen was unearthed after the police launched a probe into the killing of Ghulam

Hassan Lone, a staunch nationalist in only in Kulgam, but also in the neighbour-Devsar whose three sons are serving in security forces. "Lone was killed by terrorists in August 2021. The probe revealed that Naika was one of the plotters of killing



rity among the patriotic people," officials said. The investigation revealed that Naika played a key role in nourishing, strengthening and proliferating a conducive ecosystem for secessionism and terrorism, not ing Shopian and Anantnag districts, they added. After Lone's murder, the police tracked the footprints of the overground workers (OGWs) providing logistical support to the terrorists, they said. Naika and

his associates were nabbed with hand grenades and AK 47 ammunition. During interrogation, he confessed to have received direction from his handlers in Pakistan to carry out a terrorist attack in Kulgam by lobbing grenades on security forces and political persons, officials said. "He also admitted that as an OGW, his job was to conduct reconnaissance of targets. In the killing of Lone, Naika and his associates kept a watch on his movement and on the day of the murder, he mounted surveillance in the area to provide a safe passage to the attackers," they added. During investigation, "his role as an Hizbul Mujahideen aide facilitating attacks on police personnel was also unearthed", officials said. "Naika was a

rabid OGW and a hardcore terror associate for various outfits, in particular the Hizbul Mujahideen, and used his privilege as a government employee to target people, police and political leaders," they said. The second employee to face action -Abbas – is a resident of Badhat Saroor area in Kishtwar district. "A graduate from Aligarh Muslim University, Abbas was posted as a teacher at the government high school in Bugrana in 2012. He was arrested in September 2020 for harbouring three active Hizbul terrorists in Kishtwar. He is currently lodged at the Kot Bhalwal prison," officials said. During investigations into terror activities in Kishtwar, Abbas' role as a hardcore OGW came to light. "After his arrest, Abbas gave inputs of hideouts where arms and ammunition were stored, besides identifying two OGWs - Gulzar Ahmad and Mohammad Hanief," they said. Abbas was also providing critical information about force movements to his handlers in Pakistan, they

India tells Bangladesh to protect all minorities

New Delhi, Nov 29: India on Friday said the interim government in Bangladesh must live up to its responsibility of protecting all minorities as it expressed serious concern over the "surge" of extremist rhetoric and increasing incidents of violence against

Hindus as well as attacks on temples in the neighbouring country. New Delhi also hoped that the case relating to Hindu monk Chinmoy Krishna Das, arrested in Bangladesh on sedition charge, will be dealt with in a just, fair and transparent manner. External Affairs Minister S Jaishankar told Parliament that India has taken a serious note of incidents of violence against minorities in Bangladesh and that it is the primary respon-

sibility of Dhaka to protect the life and liberty of all the citizens, including minorities. The relations between India and Bangladesh have come under strain after the interim government headed by Nobel laureate Muhammad Yunus came to power following the resignation of Prime Minister Sheikh Hasina in August amid unrest. India has been expressing concern over attacks on minorities, especially Hindus, in that country. "The primary responsibility for the protection of life and liberty of all citizens of Bangladesh, including



minorities, rests with the government of Bangladesh," Jaishankar said, adding that the Indian high commission in Dhaka continues to monitor the situation related to minorities in that country "closely". Separately, the Ministry of External Affairs (MEA) called upon Bangladesh to take all steps for the protection of minorities and hoped that the case involving arrested Chinmoy Krishna Das will be dealt with in a just, fair and transparent manner. MEA spokesperson Randhir Jaiswal said India has consistently and strongly raised with the Bangladeshi government the threats and targeted attacks on Hindus and other minorities. "Our position on the matter is very clear—the interim government must live up to its responsibility of protecting all minorities," Jaiswal said at his weekly media briefing. "We are concerned at the surge of extremist rhetoric, increasing incidents of violence and provocation. These developments cannot be dismissed only as media exaggeration. We once again call upon Bangladesh to take all steps for the protection of minorities," he added. Responding to a question in the Lok Sabha, Jaishankar said India is concerned over incidents of violence against Hindus and other minorities, their homes and business estab lishments and attacks on temples and religious places. "The government has taken a serious note of these incidents and shared its concerns with the government Bangladesh."

Big mystery why govt not resisting Parl adjournments, it has much to feel defensive

New Delhi, Nov 29: With Parliament facing repeated adjournments, the Congress on Friday said the big mystery is why the government is not resisting the interruptions and



INDIA parties especially on the Adani issue. Congress general secretary in-charge communications Jairam Ramesh said the government has much to feel defensive and apologetic about. "Yet another day of a washout in the Parliament on the Modani issue. Both Houses adjourned today after only a few minutes. The big mystery is why the government is not resisting the adjournments," Ramesh said in a post on X. "On the contrary, the government is facilitating the aggression of the INDIA parties on Modani especially - as also on Manipur, Sambhal, and Delhi's law and order. Clearly it has much to feel defensive and apologetic about," the Congress leader said. His remarks came soon after Rajya Sabha proceedings were adjourned for the day on Friday as opposition MPs protested the rejection of adjournment notices for a discussion on allegations against the Adani Group, and the violence in Manipur and Sambhal. Soon after laying of listed papers in the morning session, Chairman Jagdeep Dhankhar said he had received 17 notices for adjournment of scheduled business under Rule 267 of the House. This led to a protest by several opposition MPs who began raising slogans. Expressing anguish, Dhankhar said, "I call upon you (MPs) for deep reflection. Rule 267 is being weaponised as a mechanism of disruption". The remark was protested by opposition MPs including those belonging to the Congress.

Teacher accuses Karnataka Congress leader of sexual abuse, he calls it 'baseless'

Bengaluru. police have registered an FIR against B Gurappa Naidu, General Secretary of the Karnataka Pradesh Congress Committee (KPCC) and Chairman of BGS Bloom Field School in Thyagaraja Nagar, for allegedly sexually harassing a former teacher.

The 38-year-old complainant, who worked at the school from March 2021 to August 2023, alleged that Naidu repeatedly summoned her to his office, made inappropriate advances, and verbally abused her when she resisted. She also accused him of recording explicit videos of victims and using them to intimidate and silence them.The teacher claimed Naidu targeted multiple women from vulnerable backgrounds and created a climate of fear within the school. "Since the women are from poor backgrounds, they were afraid to come forward," the FIR quoted her as saying. She lodged a complaint at Channammanakere Achukattu police station on November 26, after confiding in her mother and quitting her job. The police have booked Naidu under relevant sections related to sexual harassment, intimidation, and insulting a woman's modesty. Speaking to reporters, DCP (South) Lokesh Jagalasur confirmed that an investigation has been initiated.Naidu, however, dismissed the allegations as "baseless" and part of a conspiracy by RTI activists. "These are fake cases filed by individuals with vested interests. I hardly visited the school, and we have a principal and administrator who handle its operations. I will hold a press conference soon to address this," Naidu said. The police are continuing their investigation to verify the claims and gather evidence from the school and its staff.

Cyclone Fengal: Deep depression heads to Puducherry coast, schools remain shut

→Deep depression will cross Tamil Nadu-Puducherry coast near Puducherry tomorrow

- Minimal chances of it itensifing into Cyclone Fengal but will bring heavy rain and winds, IMD said
- Schools are shut, and fishermen are warned to avoid the sea until landfall

Chennai The deep depression over the Southwest Bay of Bengal, which initially raised concerns of Cyclone Fengal, is not expected to intensify into a cyclone, the India Meteorological Department (IMD) said. However, the Regional Meteorological Centre, Chennai's latest updates indicate that the system could still strengthen into a cyclonic storm by 1 PM today, November 29. The deep depression over the Southwest



Bay of Bengal is expected to cross the north Tamil Nadu-Puducherry coast between Karaikal and Mahabalipuram, close to Puducherry, on the morning of November 30, according to the India Meteorological Department (IMD). The IMD predicts that the system will bring winds ranging from 55 to 65 kmph, with gusts reaching up to 75 kmph when it makes landfall. Coastal regions of Tamil Nadu and Puducherry are

already experiencing gusty winds, and residents have been advised to remain cautious. Heavy rainfall is expected across central and northern Tamil Nadu. On November 29, districts like Nagapattinam, Villupuram, and Chengalpattu are likely to see significant rainfall, while Chennai, Tiruvallur, Kancheepuram, Chengalpattu, and Tiruvannamalai are forecast to receive intense showers on November 30.

In anticipation of the storm, schools in Chennai and Chengalpet districts were closed on Friday, and fishermen have been advised to avoid venturing into the sea until the system has passed.

It is likely to continue to move north-west wards and cross north Tamil Nadu-Puducherry coasts between Karaikal and Mahabalipuram close to Puducherry as a cyclonic storm with a wind speed of 70-80 kmph gusting to 90 kmph during the afternoon on 30th November, the IMD said.Explaining why the system did not develop into a cyclone, IMD Regional Director S. Balachandran said that while initial conditions seemed favorable, they changed over the past few days. "The lowerlevel convergence, which was strong on November 26 and 27, weakened by Thursday. This reduced cloud formation and prevented the system from organizing into a cyclone," he said.Balachandran added that for a cyclone to form, the atmospheric vortex needs to align in both the lower and upper levels. In this case, the alignment was inconsistent, reducing the system's intensity. While the possibility of the depression intensifying into a cyclone is now minimal, the IMD continues to monitor its progress closely and will provide timely

4 killings on trains, teen's rape-murder: Serial killer caught in Gujarat

Ahmedabad/Vapi A 29-year-old man's arrest for a teenager's rape and murder in Gujarat has unearthed a string of similar crimes committed across five states in a span of just over a month.

The man, identified as Rahul Singh Jat from Haryana's Rohtak, was arrested from Gujarat's Vapi for allegedly raping and murdering a 19-year-old girl near railway tracks in Valsad earlier this month.During questioning and following subsequent investigations, police managed to establish his involvement in four other murders, including one rape committed on trains in Maharashtra, Karnataka, West Bengal and Telangana. Jat's last

murder - of a woman in Telangana was committed just two days before his arrest, police said. Jat was arrested at Vapi railway station in Gujarat as part of an investigation that began after the body of a 19-year-old girl was found near the tracks close to Udvada railway station on November 14. Police said the victim was returning home from tuition in the evening that day when she was attacked from behind, raped and murdered. According to police sources, Jat attacked the girl who was talking on

the phone while she was returning home. He then raped the girl and strangled her. Even after the teen died, the man raped her corpse and committed the gruesome act several



times for nearly two hours. When Jat felt hungry, he went to the nearest shop and had his breakfast. He also bought a water bottle and a cold drink and returned to the spot, intending to continue the horror act. However, he saw people gathering near the body and fled the spot, leaving his belongings behind. Valsad Superintendent of Police (SP) Karanraj Vaghela said the tshirt and the bag left by Jat at the crime scene became important clues for the police, adding that it was difficult for the police to catch him since he changed locations frequently." Jat was arrested from the parking lot of Vapi railway station in Valsad on Sunday night in a joint operation carried out by

> local and railway police. Jat travelled extensively and kept changing his location. We have found that he is involved in at least four cases of loot and murder on trains and at railway stations in Karnataka, West Bengal, Telangana and Maharashtra," the SP said.Police said Jat had raped and murdered a woman on a Kanyakumari-bound train near Solapur railway station in Maharashtra between

October 17-21. On October 25, he strangled a passenger in a disabled train compartment in Karnataka. On November 19, he stabbed to death an elderly man on a Katihar Express train near Howrah railway station in West Bengal. On November 24, Jat looted a woman and murdered her on a train near Secunderabad railway station.He was nabbed after a massive search operation involving police units from Haryana, Rajasthan and Karnataka and checking the footage of 2000 CCTV

cameras in Vapi, Valsad, Surat and Udvada, the SP said.Police said Jat looted people whenever he found them alone and raped women, especially in the coaches for differently-abled passengers. They also said that nabbing him was tough since he kept moving and mostly slept at railway stations and on trains." Jat travelled on trains and committed loot and murder. He visited Surat, Valsad and Vapi four to five times in the past one year. He had come here to collect his salary from a hotel where he worked. He raped and murdered the 19-year-old girl during this visit," the SP said.SP Vaghela said Jat had more than a dozen cases registered against him in Haryana, Rajasthan and Uttar Pradesh as well and confessed to committing five murders in a month. The SP also said that the serial killer was jailed in 2018-19 and 2024 in cases related to truck theft and illegal arms smuggling in Rajasthan, Haryana, Uttar Pradesh and Uttarakhand. He raped and murdered the teen in Vapi after being released from jail, police said. Jat has studied till Class 5 and has been involved in theft and criminal activities since childhood. Troubled by his habits, the family had broken their ties with him.

UP Waqf Board claims ownership of 115-year-old Varanasi college, stokes row

Varanasi. A controversy has erupted in Uttar Pradesh's Varanasi after the state Waqf Board claimed ownership of the 115-year-old Udai Pratap College. The claim, originally made in 2018, has resurfaced amid the ongoing debate on the Waqf Amendment Bill. The Uttar Pradesh Central Sunni Waqf Board has asserted that the college land, spanning over 100 acres, is Waqf property linked to a historical mosque within the campus. However, the college administration has strongly refuted this, saying that the land belongs to a charitable endowment and cannot be transferred or sold. In December 2018, the

Waqf Board sent a notice to the college, claiming that the Choti Masjid and the associated property within the college were endowed to Waqf by the Nawab of Tonk, and therefore should come under the board's control.Responding to the notice at the time, the college authorities



stated that Udai Pratap College was established in 1909 under the Charitable Endowment Act, and rejected the Waqf Board's claims. The college currently has over 17,000 students. According to the college management, no further move was taken by the board for years after their reply. However, in 2022, there was an attempt by the Waqf Board to carry out construction at the mosque, which was halted by the police following a complaint from the college, Udai Pratap College Principal DK Singh said. The principal also alleged that the electricity supply to the shrine was cut off because the power being used there was "illegally stolen" from the college.

Schools, Colleges In Manipur's Imphal Valley, Jiribam Reopen After 13 Days

Imphal. Schools and colleges in Manipur's Imphal Valley and Jiribam district resumed classes on Friday after a hiatus of 13 days, officials said. Students in their school uniforms and parents were seen waiting for buses in the state's capital Imphal with the law and order situation improving in the valley districts. The Directorate of Education Schools and the Higher and Technical Education Department had on Thursday ordered the resumption of classes in Imphal East, Imphal West, Bishnupur, Kakching, Thoubal and Jiribam districts. K Biken Singh, a central government official whose two children study in a private school in Imphal, said, "It is a great relief that schools have reopened. Final exams of my children, who are in Class 6 and Class 7, were scheduled to

start from the second week of December and parts of the syllabus are yet to be completed. Reopening of schools will allow the teachers to interact with their students."Educational institutes in the valley districts and Jiribam have remained closed since November 16 after the dead bodies of three women and three children in Jiribam were recovered from the Jiri and Barak rivers in Manipur and Assam respectively. Meanwhile, the state government ordered relaxation of curfew from 5 am to 4 pm on Friday in all five valley districts and Jiribam to enable people to purchase essential items and medicines, according to an official order."Due to the developing law and orders situation in the districts, there is a need to relax restrictions on the movement of people to facilitate the



public to purchase essential items including medicines and food items. Restriction of movement of people outside their residences More than 250 people have been killed and is hereby lifted for Friday from 5 am to 4 pm" according to a government order.District Magistrates of Imphal East, Imphal West, Bishnupur, Kakching and Thoubal issued the

order separately."The relaxation, however, shall not include any gathering/ sit-in/ rally without obtaining approval through the competent authority," the order read. Tests underway, new substation to be operational in Greater Noida in December

Noida. A 33/11 kV substation that will supply power to Ecotech 10, an industrial sector, is currently undergoing technical testing and charging and is likely to be operational by Dec. Built by Noida Power Company Limited (NPCL) as part of the plan to strengthen the power infrastructure of Greater Noida, the new substation will benefit sectors Ecotech 9, 10 and 11, Techzone 2 and surrounding villages.

According to officials, due to the expansion of urban areas and industrial development in Greater Noida, the demand for electricity is continuously increasing by an average of 8% to 10% every year. In view of this, emphasis is laid on strengthening the power supply infrastructure.NPCL, which faces a power demand of 550 MW on average, catered to over 770 MW demand earlier this summer. This demand usually increases to 650-700 MW in the months of July, Aug and Sept. The new substations will provide an additional capacity of about 150 MW, which will help bring the total capacity to around 800 MW.For this, a work plan was prepared to increase the number of new substations along with upgrading the old power substations. The Ecotech 10 substation was built under this plan.

Sarnath Ganguly, NPCL's senior vice president (Operations), said, "This development is part of our ongoing efforts to strengthen power infrastructure and ensure uninterrupted power to our consumers," he said.

After homecoming miracle, strange world greets Ghaziabad man enslaved for 31 years in Rajasthan

NOIDA. Home after 31 years, Bhim Singh has finally found family and love. The rest, for him, is a strange world. On Thursday afternoon, their first full day with him since he was a nine-year-old boy, his parents and sister had a tough time convincing Bhim to eat.Fruits looked alien to him, and the sight of a gulab jamun put him off so much that he refused to eat it till his mother pleaded with him to try. Kept chained and confined at an animal farm in Jaisalmer, where he was made to toil as a slave since he was abducted from Noida in Sept 1993, Bhim had no contact with the outside world till he was rescued last week by a Delhi-based businessman who happened to be passing by, noticed him tied to a tree at the farm and brought him back with him.So, everything Bhim sees - from smartphones to cars - is a discovery. The only foods he knows of are roti. dal and chai, which is all he would be given at the farm.

"When I offered him a gulab jamun, he frowned and asked, 'ye kya hai?' (what's this) When he finally agreed to eat it, he found it delicious. He loved apples and mangoes as a child. Now, he can't recognise any fruits,' his mother Leelawati told TOI at the family's house in Shaheed Nagar.Leelawati was in tears when she first met Bhim at Khoda police station earlier this week. "He may have these problems from years of captivity and torture, but recognised me instantly. As soon as he saw me, he said, "Meri ma aa gayi (my mother has come). It took a while to sink in, but it was my son who was standing in front of me. I could picture his childhood face," she said."It didn't even take me a second to recognise her. My mother's face hasn't changed, she only looks old now," Bhim said

Other than Jaisalmer, Bhim has no clue where he was. The only concrete lead about the place is a name -Sairam - that he knew his captor by. When he was still a boy, the death of a goat had enraged this man so much that Bhim received a severe beating that left him with a broken jawbone and a fractured right hand. He was never taken to a doctor and healed in his chains. resulting in a permanent deformity on the right side of his face. His right hand does not function properly either, and his speech is affected.

Bhim, who was tied up when he wasn't toiling at the farm, said he was beaten almost daily. "I tried to escape, but there was no road beyond a point," he said.

22-year-old man murders his live-in partner, held

Noida. A 22-year-old man was arrested for murdering his live-in partner, who refused to cancel her arranged marriage, said police. The accused, Suryakant Shakya of Sector-63, met Khusboo (26) on social media. They were sharing the same space for one year, said the official, adding that the couple fought over marriage issues and the accused fled after he strangulated her to death.CP Shakti Mohan Avasthy said Khusboo's body was recovered on Nov 27. Her family registered a case at Sector 33 station, prompting an investigation into the case that revealed her relationship with Shakya.

"The accused and Khushboo met on Instagram and were living together for one year. Recently, Khushboo's marriage was fixed with her aunt's son, Javed," said

Police said that Khusboo maintained her relationship with Shakya while staying committed to her marriage plans with Javed. Her regular phone calls with Javed annoyed the accused, leading to the crime. "On Nov 26, Shakya and Khushboo had another fight over the matter, and he strangled her. After she died, he fled the spot," said Avasthy.Officials stated that the accused now faces prosecution under Section 103 (murder) of

Boy runs across road, crushed by a truck

Ghaziabad. A three-year-old boy died after he was allegedly crushed to death by a pickup truck in Shankar Vihar Colony in the Lal Kuan area on Thursday morning. According to police, Aarav, son of a roadside vendor, was playing outside his house at the time of the incident. A 35-second video of the incident, which has been shared on several social media platforms, shows children playing by the road. One of them suddenly dashed across the street and came under the wheels of a white truck approaching fast.ACP Wave City Lipi Nagayach said Aarav was seriously injured in the incident. He was rushed to a nearby hospital but succumbed to his injuries during treatment. "Initial investigation revealed Aarav suddenly came in front of a passing pickup truck. The driver could not apply brakes on time and ran over Aarav.

Encroachments stall 11km road linking Dwarka e-way & Delhi-Gurgaon e-way

Gurgaon. A detailed project report (DPR) on revamp of a crucial stretch that links Dwarka expressway to Delhi-Gurgaon expressway has been ready for nearly a year but the project remains in limbo. The plan includes upgrading the stretch from IFFCO Chowk to Dwarka expressway via Sukhrali, Mahavir Chowk, Old Railway Road, and Basai Road.

While approval for the project was received in Oct 2022, GMDA has not been able to start the work, mainly due to land constraints and encroachments along the way. At Basai, the road width has been reduced to 40m from 60m as residents have illegally extended their structures and these need to be demolished. However, GMDA said that the demolition drive could face stiff opposition from owners and further delay the project. In addition to this, GMDA is also facing land constraints for constructing a parallel rail over bridge beside the existing one.

There are some challenges that need to be worked out before we move ahead with the plan, including the illegal encroachments and land constraints. However, we are making efforts to



revamp this stretch to smooth the movement of traffic in the old part of Gurgaon. An estimate for the project is being prepared," said a senior official of GMDA.Meanwhile, residents argue that unless GMDA finalises a timeline, the delay will only result in more

inconvenience to the public and an increased budget. "Every day we experience a traffic jam on this stretch. There have been talks of the civic authorities redeveloping this stretch, but no progress has been made in this regard," said Harsh Bhola, a resident of Sector

arterial roads- IFFCO Chowk to Mahavir Chowk (4.8km) and Old Railway Road to Dwarka Expressway (6.5km) and runs through densely populated areas covering unplanned colonies, wholesale markets, and commercial entities. Unlike new Gurgaon's wide, planned roads, the older parts of the city grapple with narrow roads, frequent traffic jams, illegal road cuts, and poorly managed traffic. Under the project, GMDA has identified areas where it plans a grade separator to streamline the traffic flow. Besides the strengthening and widening of the road, the revamp plan also includes the provision of on-street parking, footpath infrastructure, and a utility duct to prevent unnecessary digging. Once the project is complete, it will provide alternative connectivity, especially to those coming from Jhajjar into the city and vice versa. At present, most commuters travel through Basai flyover and then take Hero Honda Chowk. Apart from this, it will also provide an additional connection of Dwarka expressway to NH-48.

In 2nd conviction, rapist-killer gets RI for life. First sentence was death

Gurgaon: Sunil Kumar, whose arrest in 2018 led to the discovery of a series of morbid crimes in which allegedly sexually assaulted and murdered children in different cities, was on Friday sentenced to rigorous life imprisonment by a sessions court, his second conviction this year. He was sentenced to death in the first case. Charged in four cases here, Sunil, who led a vagabond's life, doing odd jobs and eating at bhandaras, unleashed the horrifying attacks on children he found on the streets, most of his victims girls below eight old whose heads he smashed with bricks to prevent them from being recognised. His trail of perversion extended to cities in Madhya Pradesh, from where he came to Gurgaon. Prosecutors said he faces more cases in the central Indian state. The latest conviction is for the rape and murder of a five-year-old girl in the city in 2017. The victim in the other case in which he has been convicted was a three-year-old girl. The two other cases filed in the city are in trial. Three of the crimes in the city, according to police, were committed between 2016 and 2018 and another in 2013. He had left the city after 2013 and returned after three years. Sunil was arrested in Nov 2018 during a probe into the rape and murder of the three-yearold girl. During the investigation, he claimed he had committed 15 such crimes in Gurgaon, Delhi, Gwalior, and Jhansi over several years. Anju Rawat Negi, counsel for the five-year-old girl's family, said that on Jan 6, 2017, her father filed a complaint at Civil Lines police station that she had gone to a bhandara in Civil Lines to take prasad but did not return home. The decomposed body of the child was found several days later near Rajiv Chowk. Brazil's Bolsonaro hoping Trump will aid political comeback: Report

WASHINGTON. Brazil's ex-president Jair Bolsonaro is hoping that incoming US leader Donald Trump will support his political comeback in 2026 elections, according to an interview published Thursday, despite facing charges over an alleged coup plot.

The Wall Street Journal reported that Bolsonaro is banking on Trump pressuring Brazilian judges to delay enforcing a court ruling that bars him from office until 2030 for baselessly trashing Brazil's voting system ahead of the 2022 elections he lost.

Trump is back, and it's a sign we'll be back too," said Bolsonaro, who the newspaper reported had been in close contact with the Republican since his US election victory in early November.A spokesperson for Trump's incoming administration did not respond to a request for comment, the Wall Street Journal said.

Bolsonaro -- a hard-right populist widelydubbed the "Tropical Trump" during his 2019-2023 term -- has remained politically active since leaving office, recently campaigning for the right-wing Liberal Party ahead of October municipal elections. Like Trump, he has blamed his legal issues on apparent political persecution.Brazilian police have accused Bolsonaro of participating in a 2022 plot to prevent President Luiz Inacio Lula da Silva from taking office, and of being aware of an alleged plan to assassinate the incumbent.He is accused alongside 36 other people named as co-conspirators in a police report made public this week. Brazil's attorney general is examining the allegations to see if the evidence supports the charges.

Taiwan Reports Surge In Chinese Military Activity, **Detects 33 PLA Aircraft**

World Taiwan's Ministry of National Defense (MND) on Friday reported an increase in Chinese military activity around the island, detecting over 30 PLA aircraft and 8 PLAN vessels around Taiwan.

The details were shared in a post on X.

"33 PLA aircraft and 8 PLAN vessels operating around Taiwan were detected up until 6 a.m. (UTC+8) today. 21 of the aircraft crossed the median line and entered Taiwan's northern, southwestern and eastern ADIZ. We have monitored the situation and responded accordingly."Chinese incursions around Taiwan have increased recently. In response, Taiwan has stepped up security along its maritime borders. Taiwan's armed forces conducted a comprehensive air defense drill on Thursday as China reportedly prepares for its third large-scale military exercise, Joint Sword-2024C, near Taiwan. The drill, which involved air, naval, and missile defense units, was conducted to strengthen readiness against potential aerial and missile threats, according to Taiwan News.The Air Force Command stated that the exercise took place from 5 am to 7 am, deploying fighter jets, naval vessels, and air defence missile systems. Aircraft such as the Indigenous Defence Fighter (IDF), Mirage 2000, F-16, and C-130 transport planes were utilised, along with ground-based air defence missile units.Recently, Taiwanese President, Lai Ching-te attended the completion ceremony for the #ROCN Shuei-Sing Barracks. The base will serve as the new home for the Taiwanese Navy Underwater Operations Unit and enhance its training capabilities. Taiwan President Lai Ching-te convened a high-level

national security conference in which he assured the public about the government's commitment to neutralising any threat to Taiwan's democracy and security after China staged a large-scale military drill around the island. He made his remarks in response to the Chinese People's Liberation Army's (PLA) announcement of military drills, named "Joint Sword-2024B," in the Taiwan Strait and surrounding areas, which were described as a "stern warning" to advocates of Taiwan independence, according to the

Putin: Russia will use all weapons at disposal if Ukraine gets N-arms

World President Vladimir Putin said Thursday that Russia would use all weapons at its disposal against Ukraine if Kyiv were to acquire nuclear arms. The NYT reported last week that some unidentified Western officials had suggested US President Joe Biden could give Ukraine nuclear weapons before he leaves office. If the country which we are essentially at war with now becomes a nuclear power, what do we do? We will use all means of destruction available to Russia," Putin said at a presser in Kazakhstan. "If officially someone were to transfer something, then that would mean a violation of all the nonproliferation commitments they have made," Putin said. He also said it was practically impossible for Ukraine to produce a nuclear weapon, but that it might be able to make some kind of "dirty bomb", a conventional bomb laced with radioactive material. In that case, Russia would respond appropriately, he said.Putin also said that Russia may use its new Oreshnik hypersonic missile to attack "decisionmaking centres" in Kyiv in response to Ukraine's firing of Western missiles at Russian territory. Russia has not so far struck Ukrainian ministries, parliament or president's office in the 33-month war.

Kyiv is heavily protected by air defences, but Putin says the Oreshnik, which Russia fired for the first time at a Ukrainian city last week, is "incapable of being intercepted". "At present, the ministry of defence and the general staff are selecting targets. These could be military facilities, defence and industrial enterprises, or decision-making centres in Kyiv."Putin praised US Prez-elect Trump as an experienced and intelligent politician, but said he did not believe he was safe. Putin said he had been shocked by the way the US election campaign had unfolded.

Saudi Arabia to host UN talks on drought, desertification

Saudi Arabia is aiming to restore 40 million hectares of degraded land.

RIYADH. Saudi Arabia will host the COP16 UN conference on land degradation and desertification next week as the top oil exporter pitches itself as an environmental defender despite criticism of its role at climate talks.UN Secretary-General Antonio Guterres has called the meeting for the United Nations Convention to Combat Desertification (UNCCD) a "moonshot moment" to protect and restore land and respond to drought. Activists accused Saudi Arabia, the world's biggest oil exporter, of trying to water down calls to phase out fossil fuels at last week's COP29 UN climate talks in Azerbaijan.

However, the subject of desertification is

close to home for the Gulf kingdom, which has one of the biggest deserts on the planet."We are a desert country. We are exposed to the harshest mode of land degradation which is desertification," deputy environment minister Osama Faqeeha told AFP."Our land is arid. Our rainfall is very little. And this is the reality. And we have been dealing with this for centuries."Land degradation disrupts ecosystems and makes land less productive for agriculture, leading to food shortages and spurring migration.Land is considered degraded when its productivity has been harmed by

deforestation. Desertification is an extreme form of degradation. The last gathering of parties to the convention, in Ivory Coast in 2022, produced a commitment to "accelerating the restoration of one billion hectares of degraded land by 2030". But the UNCCD, which brings together 196 countries and the European Union, now says 1.5 billion hectares (3.7 billion acres) must be restored by decade's end to combat crises including escalating droughts.Saudi Arabia is aiming to restore 40 million hectares of degraded land, Faqeeha told

a hard won \$300 billion climate finance deal that poorer nations most at risk of worsening disasters dismissed as insultingly low.UNCCD executive secretary Ibrahim Thiaw told AFP he hoped

COP16 would result in an agreement to

accelerate land restoration and develop a "proactive" approach to droughts."We have already lost 40 percent of our land and our soils," Thiaw said. "Global security is really at stake, and you see it all over the world. Not only in Africa, not only in the Middle East."Faqeeha said he hoped the talks would bring more global awareness to the threat posed by degradation and desertification."If we continue to allow land to degrade, we will have huge losses," he said."Land degradation now is a major phenomenon that is really

happening under the radar."Saudi Arabia's high oil production, resulting in eyewatering profits for oil giant Aramco, routinely draws the ire of climate activists.But its exposure to desertification could give it more credibility during the Riyadh talks."With the desertification fight, (Saudi Arabia is) not necessarily directly contributing to the problem, whereas with climate change, it obviously is," said Patrick Galey, senior fossil fuels investigator for Global Witness.

"Saudi Arabia can, with some legitimacy, claim to be standing up for the little guy when it comes to desertification, because it is directly affected."

No Minority Feels Safe In Bangladesh': Former USCIRF Commissioner Says Muhammad Yunus Is 'Failing'

Washington DC. Johnnie Moore, former Commissioner of the United States Commission on International Religious Freedom (USCIRF), has slammed the Bangladesh interim government over the situation of Hindus and other minorities in Bangladesh, saying "there isn't a minority in the country that doesn't feel under threat right now" and that "Muhammad Yunus is failing."

In an interview with ANI, Moore said it is the government's first responsibility to protect those under threat. He also said that this is a moment of "existential threat not only for the minorities of Bangladesh but for the entire country". Moore criticised the arrest of priest Chinmoy Krishna Das by Bangladesh Police and said perception among minorities is "if they'll go after him, they'll go after any of us". The former USCIRF Commissioner said the global Christian community stands with the Hindu community in Bangladesh.

'Bangladesh isn't just a Muslim country. It's a Muslim-majority country that has many, many minorities. There isn't a minority in the country that doesn't feel under threat right now. That's been globally evident in recent days as this high-profile arrest has taken place of not just a leader of the Hindu

Bangladeshi community, but really a very serious religious figure. I think the perception is if they'll go after him, they'll go after any of us. I want to be crystal clear, that the global Christian community stands with the Hindu



community in Bangladesh. It is the first responsibility of a government to protect those under threat. The religious minorities of Bangladesh are really feeling it now and they deserve our support," he said. We're not sure who's really doing this, but let me just say, the way I see it, Muhammad Yunus is failing. That's what's happening in Bangladesh now. As, the leader of the country, as the interim leader of the country, there are no aspirations for the Bangladeshi people. If you can't manage a very, very simple component

of civil society, which is you have to protect people, people have to be safe. If the rule of law becomes so inefficient that instead of getting due process, a lawyer is killed. This is unbelievable, I was astonished by the response of Mr Yunus in the Bangladeshi government. They are saying this is exaggerated. They're saying that this isn't as big a deal as it seems," he added.

Moore said the visuals and the reports that are coming out of Bangladesh show that how a Hindu priest was first arrested then he was denied bail by the local court. "Then the lawyer defending the priest was killed amid protests outside the court where the lawyer was hacked to death by protesters, dragging him out of his chamber. It's become a major rallying point in the country," Moore said.

Donald Trump's call for 'energy dominance' is likely to run into real-world limits

WASHINGTON. President-elect Donald Trump is set to create a National Energy Council that he says will establish American "energy dominance" around the world as he seeks to boost U.S. oil and gas drilling and move away from President Joe Biden's focus on climate change. The energy council — to be led by North Dakota Gov. Doug Burgum, Trump's choice to head the Interior Department — will be key in Trump's pledge to "drill, drill, drill" and sell more oil and other energy sources to allies in Europe and around the globe.he new council will be granted sweeping authority over federal agencies involved in energy permitting, production, generation, distribution, regulation and transportation, with a mandate to cut bureaucratic red tape, enhance private sector investments and focus on innovation instead of "totally unnecessary regulation," Trump said.

But the president-elect's energy wishes are likely to run into real-world limits. For one, U.S. oil production under Biden is already at record levels. The federal government cannot force companies to drill for more oil, and production increases could lower prices and reduce profits. A call for energy dominance — a term Trump also used in his first term as president — "is an opportunity, not a requirement," for the oil industry to move forward on drilling projects under terms that are likely to be more favorable to industry than those offered by Biden, said energy analyst Kevin Book. Whether Trump achieves energy dominance however he defines it — "comes down to decisions by private companies, based on how they see supplydemand balances in the global marketplace," said Book, managing partner at ClearView Energy Partners, a Washington research firm. Don't expect an immediate influx of new oil rigs dotting the national landscape, he said. Trump's bid to boost oil supplies – and lower U.S. prices — is complicated by his threat this week to impose 25% import tariffs on Canada and Mexico, two of the largest sources of U.S. oil imports. U.S. The oil industry warned the tariffs could raise prices and even harm national security." Canada and Mexico are our top energy trading partners, and maintaining the free flow of energy products across our borders is critical for North American energy security and U.S. consumers," said Scott Lauermann, speaking for the American Petroleum Institute, the oil industry's top lobbying group. American Fuel & Petrochemical Manufacturers, which represents U.S. refineries, also opposes potential tariffs, saying in a statement that "American refiners depend on crude oil from Canada and Mexico to produce the affordable, reliable fuels consumers count on every day."Scott Segal, a former Bush administration official, said the idea of centering energy decisions at the White House follows an example set by Biden, who named a trio of White House advisers to lead on climate policy. Segal, a partner at the law and policy law firm Bracewell, called Burgum "a steady hand on the tiller" with experience in fossil fuels and renewables.

Israel launches airstrike on Lebanon day after ceasefire, says Hezbollah violated truce

Israel said they were violating the ceasefire agreement, without providing details. Lebanon's state-run National News Agency said two people were wounded.

BEIRUT. The Israeli military on Thursday said its warplanes fired on southern Lebanon after detecting Hezbollah activity at a rocket storage facility, the first Israeli airstrike a day after a ceasefire between Israel and Hezbollah took hold. There was no immediate word on casualties from Israel's aerial attack, which came hours after the Israeli military said it fired on people trying to return to certain areas in

southern Lebanon.Israel said they were violating the ceasefire agreement, without providing details. Lebanon's state-run National News Agency said two people were wounded. The back-to-back incidents stirred unease about the agreement, brokered by the United States and France, which includes an initial twomonth ceasefire in which Hezbollah militants are to withdraw north of the Litani River and Israeli forces are to return to their side of the border. The buffer zone would be patrolled by Lebanese troops and U.N. peacekeepers.

On Thursday, the second day of a ceasefire after more than a year of bloody conflict between Israel and Hezbollah, Lebanon's state news agency reported that Israeli fire targeted civilians in Markaba, close to the border, without providing further details. Israel said it fired artillery in three other locations near the border. There were no immediate reports of casualties.An



Associated Press reporter in northern Israel near the border heard Israeli drones buzzing overhead and the sound of artillery strikes from the Lebanese side. The Israeli military said in a statement that "several suspects were identified arriving with vehicles to a number of areas in southern Lebanon, breaching the conditions of the ceasefire.' It said troops "opened fire toward them" and would "actively enforce violations of the ceasefire agreement."Israeli officials have said forces will be withdrawn

gradually as it ensures that the agreement is being enforced. Israel has warned people not to return to areas where troops are deployed, and says it reserves the right to strike Hezbollah if it violates the terms of the truce.A Lebanese military official said Lebanese troops would gradually deploy in the south as Israeli troops withdraw. The official spoke on condition of anonymity because they were not authorized to brief media. The

ceasefire agreement announced late Tuesday ended 14 months of conflict between Israel and Hezbollah that began a day after Hamas' Oct. 7, 2023 attack out of Gaza, when the Lebanese militant group began firing rockets, drones and missiles in solidarity.Israel retaliated with airstrikes, and the conflict steadily intensified for nearly a year before boiling over into allout war in mid-September. The war in Gaza is still raging with no end in sight.

Imphal. The Manipur government has strongly criticised the "constant meddling in the internal affairs" of the violence-hit state by the Mizo National Front (MNF), a Mizoram-based political party led by a former chief minister who was defeated in the last assembly election. The Manipur government in a statement on Thursday said the MNF has been pushing an "anti-national, pro-Myanmar refugee propaganda" and maintaining an "anti-Manipur stance."

The statement came after the MNF in a press note issued by its general secretary of outreach VL Krosehnehzova called for the resignation of Manipur Chief Minister N Biren Singh, who is from the ruling BJP.The Manipur government in the statement said the MNF has consistently opposed the Centre's efforts to secure the border with Myanmar to curb illegal immigration, arms trafficking, and drug smuggling. It said these measures seek to go into the root causes of Manipur's challenges, including illegal immigration and drug-related issues originating from Myanmar.

The Manipur government reminded the public of the MNF's historical secessionist movement in the erstwhile Mizo district of

MNF chief and former Chief Minister Zoramthanga was a member of a Mizo militant group that declared independence from India in 1966. The MNF, founded by Laldenga, waged a two-decade-long militancy against India for independence for a sovereign Mizo nation. Zoramthanga

MNF until the centre and the MNF signed a peace agreement in 1986. The ongoing crisis in Manipur is the result of illegal immigrants from Myanmar, whose economy, driven by illicit poppy cultivation, was severely disrupted by the Chief Minister's War on Drugs," the Manipur government said. The Manipur government attributed narratives of religious policy as a factor behind the state violence to propaganda by the MNF and other vested interests at both domestic and international levels. The

state government criticised the MNF for ignoring funding by "narco-terrorists" behind the conflict on the Kuki tribes' side. It pointed out a significant increase in the number of villages in Kuki-dominated districts between 1969 and the present - an abnormal rise compared to Naga-dominated districts. The government questioned the MNF's awareness of the reasons behind this dramatic increase, particularly in forested areas. The Manipur government reminded the MNF that the Mizoram government itself has taken measures to prevent Myanmar nationals from buying land, running businesses, or getting official documentation such as Aadhaar and voter identity cards

It questioned why the MNF opposed similar efforts by Manipur to tackle illegal immigration. The press statement highlighted Mizoram's implementation of a



1950 cut-off date for defining indigenous and non-indigenous persons under the Inner Line Permit (ILP) system. Manipur adopted a similar approach with a 1951 cut-off date under the Manipur People Bill, later revised to 1961. It cited concerns raised by members of the Kuki tribes regarding the impact of these measures on tribal population, urging the MNF to reflect on the scale of illegal immigration since 1951.

The Mizo National Front is reminded that the Mizoram government, in view of similar concerns of pressure on land, livelihoods and resources, had instructed Myanmar nationals not to purchase land and run business without prior permission from the state government. In addition, the foreigners should also not enrol for Aadhaar, voter list or obtain driving licence, amongst others. Why should the MNF oppose the decision of the Manipur government to tackle the issue of illegal immigration similarly in Manipur?" the

Manipur government said. The Manipur government outlined its successes in the 'War on Drugs' campaign, including the destruction of drugs worth ? 60,000 crore in the international market, the seizure of vast quantities of narcotics, and the eradication of 16,787 acres of illicit poppy cultivation.

It noted a 60 per cent decline in poppy cultivation between 2021 and 2023. In contrast, the statement alleged Mizoram has emerged as a transit route for illegal arms and drugs between India and Myanmar. The MNF should focus on the looming threat on Mizo society from the

drugs trade instead of passing unwarranted comments on legally justified acts of the government of Manipur to combat drugs trafficking. If requested by the MNF, the government of Manipur will extend all assistance to the efforts of the state of Mizoram towards curbing drugs," the Manipur government said.he state government detailed its efforts to restore peace and normalcy, including providing food and shelter to over 60,000 people in relief camps, conducting combing operations to recover looted arms, and prosecuting lawbreakers. Sensitive cases have been handed over to central agencies like the National Investigation Agency (NIA) and the Central Bureau of Investigation (CBI) for impartial investigation, and a retired Supreme Court judge is heading a commission of inquiry into the origins of the ethnic conflict.

Two teams returned to the village around 2 am while another team lit fire and waited for dawn break. The presence of elephant herds in the area had made the search operation risky.On Friday morning, the forest department relaunched the search using drone and thermal scanning equipment to locate the missing women.

DRI flags smuggling of poppy seeds through Indian ports including Chennai, Thoothukudi

CHENNAI. The Directorate of Revenue Intelligence (DRI) has recently flagged a nation-wide alert regarding the smuggling of poppy seeds from Malaysia and other southeast Asian countries through ports across India, including Chennai and Thoothukudi, by either misdeclaring the cargo or concealing it in some other consignment.Obtained from the poppy plant which is also the source of opium, poppy seeds are commonly used for cooking in Indian households, but there is a restriction in place for its import. Indian norms permit the import of poppy seeds only from 16 countries.

In addition, the importer has to produce a certificate from the competent authority of the exporting country, showing the Opium poppy has been grown legally in that country. All import contracts would also have to Narcotics, Gwalior. This is part of the Indian government's measures to protect the business of poppy cultivators in Madhya Pradesh, Rajasthan and Uttar Pradesh. The legal

import of poppy seeds also attracts a 25% customs duty. According to official sources, all these reasons drive its smuggling, which causes a loss to the government exchequer. Poppy seeds cost around '1,300 per



kilogramme.

Odisha to have South Asia's first elephant centre for species survival

BHUBANESWAR. In a first-of-itskind initiative that would support conservation of elephants in South and Southeast Asia, Odisha government has accepted a proposal for establishment a Centre for Species Survival (CSS) of Asian Elephants near Bhubaneswar.he centre will be set up at Chandaka wildlife division. A letter of agreement with the International Union for Conservation of Nature Species Survival Commission (IUCN-SSC) and Wildlife Trust of India (WTI) was signed by the Forest, Environment and Climate Change department in this regard. The centre will not only enhance the protection of Asian elephants across 13 range countries in South and South East Asia including India but also be in line with Government of India's 'Act East

Policy' launched in 2014 to promote country's economic, strategic and cultural relations with the Asia-Pacific region. Establishment of the species survival centre of elephants in India is also being seen as vital as the country is home to over 60 per cent of wild Asian elephant population. While India has emerged as a global leader in Asian elephant conservation, addressing challenges of securing elephant corridors, mitigating human-wildlife conflict, training frontline forest staff, rescue and rehabilitation, creation of community-conserved areas, top sources in the Wildlife Wing said, the centre will facilitate integration of scientific and cultural knowledge and promote collaboration among different stakeholders including

communities and public to bolster conservation efforts for Asian elephants. The establishment of the centre will also bring significant international support, funding as well as expertise for the protection of elephants in the country including Odisha. It will also go a long way in resolving the human-elephant conflict which has been a raging issue for many states.For effective management of the centre, a seven-member governing council headed by the PCCF (wildlife) was notified by the state wildlife headquarters on Thursday. The governing body will be led by the PCCF (wildlife) as its chairman while chief conservator of forests, regional CCF (Bhubaneswar circle), WTI Chandaka DFO and.

Riverine discharge from Godavari ups dead zones in Bay

Apart from the UoH, scientists from the CSIR-NIO in Visakhapatnam and King Abdullah University of Science and Technology in Saudi Arabia also took part in the research published in the Frontiers in Marine Science journal. It highlighted that Godavari could have significant impact on the intensification of ODZ, besides major rivers like the Ganga and Brahmaputra.Researchers analysed the river discharge data from the Godavari at the Dowlaiswaram barrage, World Ocean Atlas 2018 data and high-resolution biogeochemistry recorded Array for Real-Time Geostrophic Oceanography (ARGO) buoys in the Bay of Bengal off Godavari

The study found that during the monsoon season, when the Godavari experiences peak discharge, large amounts of organic matter from dead trees, plants or soil are carried into the Bay of Bengal. In addition to this, river water also carries huge amounts of nutrients to the coast that enhance phytoplankton production.A mentor to the lead author, Prof K Ashok, told TNIE, "This is the first time that the effect of Godavari on the Bay of Bengal has been studied. Fish cannot thrive in ODZs. The study found that Godavari flow could also be contributing to a decrease in the oxygen levels in some zones in the Bay of Bengal, affecting fishing activity. COP29 deal has let the world down

COP29, the latest round of climate negotiations at Baku, ended with a contested deal. The central theme was supposed to be climate finance. It refers to local, national or transnational financing that seeks to support mitigation and adaptation actions that will address climate change. For decades, developing countries have been demanding additional funding to help them take effective measures to meet the challenge of climate change. They have been demanding that rich countries shoulder a greater responsibility because primarily they are responsible for the current crisis. It is historical emissions from the Global North since the Industrial Revolution that have led to the climate crisis. The quantum of climate finance and its source have been a sticking point between developed and developing nations for a long time.It was against this backdrop that the Baku negotiations raised expectations and hope for a good deal. The outcome sets a goal of at least \$300 billion of climate finance every year by 2035 for developing countries. The money will come from a wide variety of sources — public and private, bilateral and multilateral, including alternative sources. In providing this funding, developed countries will take the lead and developing nations will be encouraged to make contributions voluntarily. The finance goal set at Baku falls much short of the target and the timeframe developing countries had demanded trillion in finance every year to be mobilised by developed countries starting 2025. Not only is the figure much below the quantum but the timeframe is far off. This is by now a familiar tactic of the Global North — fix a watered-down target and a much longer timeframe to avoid any immediate commitments. Moreover, the promised funding will not come solely from the rich. Developing countries, too, will have to contribute to the kitty. Predictably, this has upset developing countries. At the end of the negotiations, India, Bolivia and Nigeria voiced their concerns over the weak deal, officially called the New Collective Quantified Goal on Climate Finance. India has also accused the presidency of the Conference of Parties (COP) of pushing through the deal without following the norms of multilateral talks held under the aegis of the UN.Developing countries need finance and technology to meet the challenge of climate change. Money is needed for mitigation — largescale investments are required to significantly reduce emissions. This means funding to support renewable energy projects, energy efficiency, managing living natural resources and land use, protection of terrestrial and aquatic biodiversity, clean transportation, etc. The second major requirement of additional funding is for adaptation — resources needed to adapt to the adverse effects and reduce the impacts of a changing climate. This would, for example, include funding to build infrastructure that can withstand storms and flooding, financing the relocation of infrastructure projects away from areas with rising sea levels, developing and supplying drought-resistant seeds, etc. In addition, climate finance is required for a third category of actions known as 'loss and damage' to help countries cope with natural disasters accentuated due to climate change.

Over the years, several mechanisms and funds have been devised for climate finance under the United Nations Framework Convention on Climate Change (UNFCCC). These include the Global Environment Facility, Green Climate Fund, Special Climate Change Fund, Least Developed Countries Fund, Adaptation Fund, etc. However, in effect, very little money has flowed into these funds and made available to developing es For instance the Green Climate has supported 243 projects across 129 developing countries totalling \$13.5 billion during the 2020-23 period. The Adaptation Fund has committed \$1.2 billion for 183 adaptation projects in several developing countries since 2010. The flow of funding from other mechanisms is even more miniscule. Overall, the finance available from UNFCCC-promoted funds and mechanisms is far below the requirement. Hence, the demand at Baku was to enhance the quantum as well as quality of finance.

Manipur a test of govt's ability to manage unity in diversity

AS euphoric celebrations over Maharashtra state elections lead to a 'masterstroke' discourse and headlines, the continuing agony of Manipur has been relegated again. A brief mention of rushing an additional 10,000 CAPF (Central Armed Police Forces) soldiers towards addressing the spiralling Manipuri violence seemingly satisfies the national consciousness. Official figures peg the death toll at about 258, with about a lakh displaced. The substantially higher unofficial figures are automatically pooh-poohed. News coming out of the troubled state is patchy, if any. The complete breakdown of Manipur is a mere footnote in news.

Manipur is a microcosm of India with religio-ethnic diversities, polarised assertions and a deeply contested history that tests the ruling dispensation's ability to manage the constitutionally aspired unity in diversity. Manipur hosts an amalgamation of Hindus (Vaishnavite Meitei), Christians (Kuki-Zo, Nagas), Muslims (Pangals), Buddhists and tribals and it even had Jews (B'nei Menashe) once upon a time. Therefore, the erstwhile Kangleipak state (Meitei-ruled Manipuri state) has always had to deal with underlying disaffection among its non-Meitei populace, especially in the hills dominated by Kukis and Nagas. But a certain geographical arrangement and understanding of respecting the local turfs and sensibilities of the various diversities ensured a semblance of normalcy. In a way, Manipur mirrors the challenges that had beset the newly independent India. It, too, had required the celebration of the commonality of differences as opposed to insisting on the homogeneity of the 'land of the pure' or Pakistan. The foundational and constitutional 'idea of India' was a direct contrast to the majoritarian 'idea of Pakistan'as India was fundamentally predicated on inclusivity, secularism and a deliberate accommodation of 'others'.

Therefore, the 'idea of India' always beseeched a large-hearted outreach, protection and affirmation of those whose voice could get naturally diluted in a democratic majority. Ultimately, as numbers matter in a democratic contest, those with lower numbers (read minorities) could get lost. It is this imagined vulnerability of the minorities that led to societal dissonance in regions with higher numbers of minority denominations, like Jammu and Kashmir, Punjab or the Northeast states.

The integration of many of these regions, such as Jammu and Kashmir's accession to India in 1948, or

agreement in 1949, were by themselves complicated events. Obviously, the forces inimical to India fanned the situational dissonance towards secessionism. It had taken Delhi to course-correct many of its missteps and admit to some excesses whilst signing the peace accords in places like



Punjab and Mizoram to trigger the end of insurgent movements. Finally, the 'Idea of India' had triumphed by convincing the restive diversities, especially minorities, on the genuineness of Delhi in honouring the foundational spirit of unity in diversity. Sadly, along with Jammu and Kashmir, Manipur has the dubious distinction of facing the longest continuing insurgency and the maximum number of insurgent groups. Groups like the People's Liberation Army of Manipur (PLA), People's Revolutionary Party of Kangleipak and Kangleipak Communist Party represent the societal grouping in the state. Other prominent insurgent groups include Naga groups like the National Socialist Council of Nagaland-Isak-Muivah and National Socialist Council of Nagaland-Khaplang as also the Kuki National Army representing the Kuki ethnicity. These groups have separate, specific, and, often, conflicting agendas that seek to protect their respective turfs and arrangements.

These armed groups could either be pursuing purely secessionist movements, such as the PLA, or protectionist agendas to defend their communities from seceding space in the delicate arrangement from usurpation or diminishment. Many groups have fought violently in the past, like the Kuki forces against the Naga groups, or, like now, the Meitei multitude against the Kukis.

the Maharaja of Manipur's signing of the merger Delhi always had a difficult task in addressing each group and challenge uniquely, without resorting to blanket narratives or presumptions. Therefore, while it is relatively peaceful in the once-troubled places like Nagaland, Mizoram and Assam, the divergence of competing interests in the Manipuri cauldron have failed to end the insurgent movements therein. Although till about 2022, the broadly respected arrangement of various groups ensured relative peace, but not completely. Delhi had to tiptoe around the armed aspirations to not be seen as favouring any group or community.

The local arrangement among the Manipuri divide was given to a sudden fracture, with the local courts suggesting affirmative action that seemed to suit one group over the other perceptively. This move, coincidentally, fitted well with the thrust of majoritarian politics that had entered the region and spurred the ruling dispensation in Delhi into power even in Imphal for the first time in 2017. The fact that this winning partisan thought had successfully conflated religion with nationalism, it axiomatically led to 'othering' or aspersions of 'anti-national' on to communities that did not fit the formula.

Dangerously, the perception gained credence that Delhi had made a choice among the restive groups that threatened the traditional set piece of local arrangement. The supporting rhetoric was typically one-sided, with murmurs of one side having foreign support, gunrunning, smuggling, territorial denialism and even aspirations of a 'Christian state' It didn't help matters that the actions of the law and order agencies also seemed to favour one side. The absence of the the Prime Minister's visit despite the scale of tensions and bloodshed only deepened the distrust amongst the proverbial 'others' in the conflict. The new narrative may have electorally benefited the ruling dispensation in the region, but it has also brutally polarised the communities and allies, like the regional National People's Party, had no choice but to throw in the towel. It is true that conflict-ridden regions like Jammu and Kashmir and Manipur have very little impact on national government formation, with just three seats for the former and two for the strife-torn state. However, these regions with substantial number of minorities or 'others' test the sincerity and commitment of the ruling government to the constitutional morality of unity in diversity.

The arrest, coupled with the denial of bail, has sparked widespread protests, both in Bangladesh and across the border in India. The context of this unrest lies in a troubling pattern of minority persecution. Despite constitutional assurances of equality, Bangladeshi Hindus, who constitute around nine per cent of the population, frequently endure violence, vandalism and social exclusion. Reports of mob attacks on Hindu homes and temples are alarmingly common, especially during political transitions — as has been seen since Sheikh Hasina's ouster — or communal tensions. While the current unrest ostensibly revolves around Das' arrest, it underscores the



broader insecurity experienced by minorities in a state where Islam is the official religion.

India's official response to the incident — urging the

interim government led by Muhammad Yunus to ensure minority safety and uphold freedom of expression and assembly — reflects its concerns for the region's stability. However, Bangladesh must recognise that addressing these issues is not merely about appeasing international pressure. The long-term solution lies in fostering inclusivity, ensuring swift justice for victims of communal violence and protecting the fundamental rights of its citizens, irrespective of faith. The onus is on Dhaka to restore trust by heeding the calls of groups like the Sammilit Sanatan Jagran Jote, which advocate for special tribunals to expedite justice for victims of persecution. Failing this, the cycle of unrest threatens to escalate, undermining Bangladesh's image as

a progressive democracy. Peace and security for all minorities must be a lived reality.

What message was POTUS giving to the world? Was he in charge of the regime change of Moscow and judge, jury and arbitrator, with powers of the world supercop on the prowl? Or, was he heading the sole superpower state? For a minute, however, POTUS acted like a non-state actor of a tinpot dictatorship!

True, Biden was referring to the wrong and illegal Russian invasion of the sovereign Ukraine. But, did he remember the plethora of worse wrongdoings of his own country committed in the 21st century? Again, it's true that two wrongs cannot make one right, yet one has to be rational, restrained and reticent while uttering words to make a point on an international platform dealing with such crisis situations as the Russia-Ukraine conflict.

Russia was wrong on all counts to invade Ukraine on February 24, 2022, and under no stretch of the imagination can the Moscow aggression be defended. It's a naked 18th -20th century imperialtype aggression by the powerful to conquer the weak. Moscow had no business to trample upon Ukraine's sovereignty. Nevertheless, on closer scrutiny, it is seen that the Russian invasion of Ukraine was born of a ceaseless twodecade-plus shameless US-led NATO and EU provocation, which posed a dire and direct existential threat to Moscow's geography through her underbelly of Kiev.

Hence, despite Russian President Vladimir Putin being wrong, he had reason to be wrong, and reason to be not right. It's the blatant West-plotted expansion towards the East that Russia couldn't have ignored beyond a point. All the more so because the once-sovereign USSR had already been broken into 15 states in December 1991, with Russia being one of the new states. The

shrunkened and weakened Russia, thus, constituted a fresh opportunity for the traditional imperialist powers of the West to get back to their favourite pastime: Of expanding territory, controlling resources and subjugating local manpower to subservience to bolster their own economy and multiply their growth chart, the way it zoomed from the 17th to the 20th century.

Today, the Russia-Ukraine war is more than a local conflict of the Balkan-Black Sea belt. The outgoing POTUS, Biden, has suddenly escalated the war, which could be potentially disastrous for Europe if it remains just a conventional conflict. However, in the unlikely event of the use of nuclear wares, one cannot predict the conflict's outcome. Indeed, whatever the



future course of the Ukraine war, Biden (the Anglo-Saxon who hates Russia), for sure, will go down as a would-have-been hero who fell as a tragic villain in the history of the USA in general and the history of European warfare in particular for escalating the war zone into a potential Armageddon.

Ironically, the villain should have been Putin for initiating the war. But the role has been diametrically reversed as Biden seems to have taken over the mayhem mantle from the Moscow man.

And August 2021 is a bad dream come true for the new POTUS. The retreat after the 20-year war made Biden a bitter man. The October 2024 escalation of the present Ukraine war is the right punch for Biden to deliver as a revenge trophy to Trump, his 2021-predecessor-cum-2025-

successor. The short of the long story, therefore, is the revival of Anglo-Saxon versus Russia rivalry on the fringe of Europe. The imperial sea powers of the West would prefer to continue with the proxy conventional war in land owing to their inherent discomfiture to take a direct fight with a monstrous land power which has traditionally thrived on protracted conflict away from the water. The Anglo-Saxons may like to think that the long war on land would weaken the Slav Russia both economically and demographically, but

that may not turn out to be so. The dynamics of political alignments are changing rather fast, with land powers uniting to take on the comparatively smaller sea powers with diminishing demography and challenging economy.

22-year-old Harsh was arrested on Thursday from the Delhi airport, where he arrived to arrange for another fake passport, officials said.

The fake passport accessed by NDTV shows that Harsh's name was written as Pradeep Kumar and it was issued from Punjab's Jalandhar on March 26.According to the police, Harsh left India on June 9 from Amritsar Airport and flew to Sharjah before heading to Azerbaijan on August 27, where he remained for several months.

Sambhal case: Supreme Court pauses trial court action until High Court's order

The Supreme Court's order comes days after violence broke out in Sambhal, killing five people, following a courtmandated survey of the Mughalera Jama Masjid.

NEW DELHI. The Supreme Court on Friday asked the trial court in Uttar Pradesh's Sambhal not to proceed with the mosque survey case till the Shahi Idgah committee of the Jama Masjid moves the High Court. The top court's order comes days after violence broke out in Sambhal, killing five people, following a court-mandated survey of the

A bench of Chief Justice of India (CJI) Sanjiv Khanna and Justice PV Sanjay Kumar also directed that the report of the commissioner, who conducted the survey of the mosque, should be kept in a sealed cover and should not be opened in the meantime.

"Let this be pending. We want peace and harmony. You (petitioner) approach the High Court. Till then, let the trial court not take any action," CJI said. The Supreme Court's order came on a plea filed by the Sambhal Shahi Jama Masjid Committee challenging the order passed by the trial court



commissioning the survey of the mosque. The trial court order came following claims that the mosque was built by Mughal emperor Babar in 1526 after demolishing a temple that stood there. The top court said the petition filed by the mosque committee before the High Court should be listed within three working days. The Supreme Court, however, kept the committee's plea before it pending and ordered it to be listed in the week starting January 6, 2025."We clarify we have not expressed any opinion on the merits of the matter. We are not disposing of the present plea. Re-list in the week commencing January 6, 2025," the court said.

Appearing for the mosque committee, senior advocate Huzefa Ahmadi told the top court that the trial court order was capable of causing "great public mischief". "Ten suits are pending across the length and breadth of the country... the modus operandi is on the

first day only, the surveyor is appointed," he said. The Supreme Court asked the trial court to not take any steps till January 8 while asking the district administration to ensure peace and harmony. "We do not want anything to happen. See Section 43 of the mediation act... the district should form mediation committees. We have to be absolutely neutral," the court further said.

Cameras In Corbett National Park Being Misused To Intimidate Women: Study

New Delhi. Cameras and drones originally planted in Corbett National Park for conservation activities, such as monitoring animals, are being deliberately misused by local government officials and men to surveil women without consent, a study has found.

The study, published in the journal Environment and Planning F, revealed that forest rangers intentionally flew drones over local women to scare them and prevent them from collecting natural resources, despite their legal entitlement to do so. A total of 270 residents around the Corbett Tiger Reserve in Uttarakhand, including women, were interviewed over 14 months by researchers from the University of Cambridge, UK.

We argue that the use of digital technologies for forest governance, such as camera traps and drones, tends to transform these forests into masculinised spaces that extend the patriarchal gaze of society into the forest," the authors wrote in the study.Researcher and lead author Trishant Simlai reported that the women,

who had previously found sanctuary in the forest away from their mendominated villages, told him they felt watched and inhibited by camera traps, causing them to talk and sing much more quietly. This, he said, increases the chances of surprise encounters with potentially dangerous animals, such as elephants and tigers. The national park is known to provide respite to women, who, in addition to gathering firewood, spend long hours there to escape difficult situations at home, such as violence and alcoholism. They often share their stories and

express themselves through traditional songs, the researchers said. The women told Simlai that new surveillance technologies, deployed under the guise of wildlife monitoring projects, were being used to intimidate and exert power over them -- by monitoring them as well."A photograph of a woman going to the toilet in the forest -- captured on a camera trap supposedly for wildlife monitoring -- was circulated on local Facebook and



WhatsApp groups as a means of deliberate harassment," Trishant Simlai, a researcher at the University of Cambridge's Department of Sociology, said.

Simlai discovered that local women form strong bonds while working together in the forest, singing while collecting firewood to deter attacks by elephants and tigers. When women see camera traps, they feel inhibited because they don't know who's watching or listening to them, resulting in them behaving differently,

often becoming much quieter, which puts them in danger, he added.One woman he interviewed has since been killed in a tiger attack, Simlai said. "Nobody could have realised that camera traps put in the Indian forest to monitor mammals actually have a profoundly negative impact on the mental health of local women who use these spaces," Simlai said.Coauthor Chris Sandbrook, a conservation social scientist and professor of conservation and society at the University of

Cambridge, said, "These findings have caused quite a stir in the conservation community. It's very common for projects to use these technologies to monitor wildlife, but this highlights the need to ensure they're not causing unintended harm." Surveillance technologies that are supposed to track animals can easily be used to watch people instead - invading their privacy and altering the way they behave, Sandbrook said.

New Delhi. Enviro Infra Engineers made a strong stock market debut on Friday, listing at a premium of nearly 49% over the issue price.

The shares opened at Rs 220 on the National Stock Exchange (NSE), marking a 48.64% jump from the IPO price of Rs 148. On the Bombay Stock Exchange (BSE), the stock listed at Rs 218, reflecting a 47.29% premium. This is even better than what the grey market premium had indicated. The Rs 650-crore IPO, priced between Rs 140 and Rs 148 per share, was open for subscription from November 22 to November 26 and saw overwhelming demand.It received bids for 2,76,83,13,747 shares against the 3,07,93,600 shares on offer, translating to an overall subscription of 89.90 times. The portion reserved for qualified institutional buyers was subscribed 157.05 times, while non-institutional investors subscribed 153.80 times. Retail investors' portion was subscribed 24.48 times. Ahead of the IPO, the company raised Rs 195 crore from anchor investors. The offering included a fresh issue of 3.87 crore equity shares and an offer for sale (OFS) of 52.68 lakh shares by promoters. The fresh issue proceeds will be used to address several financial needs: Rs 181 crore for working capital, Rs 100 crore for debt repayment, and Rs 30 crore to fund its subsidiary, EIEL Mathura Infra Engineers, for the construction of a 60-millionlitre-per-day sewage treatment plant in Mathura, Uttar Pradesh.

Air India facing delays in Boeing aircraft deliveries: **CEO Campbell Wilson**

NEW DELHI: Air India CEO and MD Campbell Wilson said on Wednesday that the airline is experiencing delays in receiving aircraft deliveries from Boeing, largely due to a strike at the aircraft manufacturer's U.S. factory. Wilson revealed that the delivery of 50 "white tail" aircraft, initially expected to be completed by December this year, has been pushed to June 2025. "50 white tail aircraft, all of them were to come by December this year... They will stretch up to June next year and that in itself has a little bit of impact...," he said, adding that the two factors - a slowdown in production by Boeing and the strike – are likely to have contributed to the delay.

"It is not clear for how long the impact will be. Six months is reasonable for some aircraft...," Wilson added.Out of the total 50 white-tail Boeing 737 MAX aircraft, at least 35 have joined Air India's fleet. aircraft, at least 35 have joined Air India's fleet. These planes are being operated by Air India Express. Generally, white-tail planes are those that were originally manufactured for a particular airline and later taken by another airline. Currently, the Air India Group operates a fleet of around 300 aircraft. It is expected to add 100 new planes between 2026 and 2027 However Wilson noted that deliveries in 2025. 2027. However, Wilson noted that deliveries in 2025 will be slower compared to 2024. The CEO also highlighted the importance of domestic and shorthaul international markets for Air India's growth in 2025, as the airline expands its narrow-body fleet while sending its older wide-body aircraft for retrofitting. "We had hoped to start retrofit of 787s and 777s by now. Unfortunately, the global supply chains in some areas are still recovering and seats in particular area challenge. Once it (retrofit) cterts in particular are a challenge...Once it (retrofit) starts in 2025, we will be doing 3-4 aircraft every month until the full legacy 40 wide-body aircraft are completed," Wilson said. "So, we took the view that there is an opportunity, appetite for growth in the market and that we should take it. On balance, we have taken millions of people on these aircraft. People are happy that the service exists," he noted

Vivek Pandya, leading insights analyst at Adobe Digital Insights told AFP that as compared to previous years, 2024 holiday shoppers are "even more preoccupied and very focused around value and discounts.""We do see stronger price sensitivity on the part of the consumer and they are very responsive to deals and event-tie deals," he said. This year, consumers have eagerly participated in special discount events like Memorial Day sales and Amazon's "Prime Day."

Black Friday, marking the beginning of the gifting season, falls the day after Thanksgiving and kicks off a busy shopping weekend that also includes "Small Business Saturday" and "Cyber Monday."
To combat the ever evolving concern of inflation,

major retailers like Target have shifted their "Black Friday" promotions to October or even earlier. Consumer prices on average were 22 percent higher in August 2024 compared with January 2020, according to Pew Research, and popular discontent with inflation is one reason Donald Trump won the US presidency in November. In August 2024, prices surged by an average of 22 percent compared to January 2020, according to Pew Research. Inflation is also believed to have played a role in Donald Trump's victory in the November elections.

No delays in banking, Aadhaar OTP messages due to new traceability rules: TRAI

As the new deadline approaches, a video circulating on social media claimed that OTP and banking messages could be delayed due to the introduction of the new technology.

NEW DELHI. The Telecom Regulatory Authority of India (TRAI) has assured consumers that there will be no disruptions in the delivery of essential net banking and Aadhaar OTP messages starting December 1, as the new traceability rules are implemented.

To combat the growing issue of cybercrime, TRAI had introduced a rule



on October 1 requiring telecom service providers to establish a system for tracking the origins of bulk messages. The original deadline for implementing these measures was set for October 31 but was later extended to November 30 due to technical challenges faced by operators. As the new deadline approaches, a video circulating on social

media claimed that OTP and banking messages could be delayed due to the introduction of the new technology. In response, TRAI clarified that there will

be no delay in the delivery of any messages. "This is factually incorrect. TRAI has mandated the Access Providers to ensure message traceability. It will not delay delivery of any

message," said TRAI, in a social media post. The TRAI has directed telcos, including Reliance Jio, Bharti Airtel, and Vodafone Idea, to implement message traceability in their systems. This measure aims to identify the source of bulk SMS traffic and is designed to curb the spread of fraudulent messages. Once the system is in place, authorities will be able to take action against the originators of such schemes. Initially, telecom companies expressed concerns about the technical complexities involved in deploying new system. However, TRAI has emphasized that the implementation of message

traceability will not cause any delays in message delivery. In August, TRAI also took several steps to curb promotional calls, including penalties for offenders, such as the disconnection of telecom resources, blacklisting for up to two years, and restrictions on obtaining new resources during that period.

New Delhi. Star England batter Joe Root endured a bitter milestone in his storied career during the first Test against New Zealand at Hagley Oval. Root, playing his 150th Test match, was dismissed for a fourball duck by New Zealand debutant Nathan Smith.Root's dismissal, his 13th in Test cricket and eighth in the World Test Championship (WTC) era, elevated him to an unenviable list of batters with the most ducks in the WTC, surpassing the likes of Virat Kohli and Steve Smith, both of whom have seven. This lean patch continues a difficult run for Root, who has scored just 90 runs in five innings since his double-century against Pakistan in Multan.

Smith, a debutant seamer, had a dream start, dismissing England's Jacob Bethell and Root in the same over, reducing the visitors to 45/3 after Zak Crawley's early exit. England's struggles were compounded by Ben Duckett's dismissal, leaving them reeling at 71/4. However, a resilient 103-run stand between Ollie Pope (59*) and Harry Brook (54*) brought some stability, with England reaching 174/4 at tea, still 174 runs behind New Zealand's first-innings total of



Root's duck in his milestone 150th Test match places him in an exclusive yet undesirable club, joining Australian legends Steve Waugh and Ricky Ponting as the only batters to record ducks in their 150th Test appearances.Earlier in the day, England dismissed New Zealand for 348, with Glenn Phillips (58*) anchoring the tail after Kane Williamson's composed 120 on Day 1. England's bowlers Brydon Carse (4/64) and Shoaib Bashir (4/69) excelled, but the visitors faced immediate setbacks in reply. But when you look at the slots that we needed, the players that we have got fitted into those roles perfectly," Ponting reacted to the criticism.

"To have Marcus Stoinis and Glenn Maxwell back to Kings is huge as they have both played here in the past. A couple of new guys, including Xavier Bartlett, Aaron Hardie, and Josh Inglis, are coming into the IPL for the first time, which is also really exciting for us," added Ponting. Ponting adding Australian players to the roster is nothing new. In the 2024 edition of the Indian Premier League, Ponting introduced Jake Fraser-McGurk, who was a massive hit in the tournament.

New Delhi. Former World No.1 tennis player Simona Halep slammed the International Tennis Integrity Agency over their double standards while dishing out doping bans. In a lengthy Instagram post, Halep slammed the agency for trying to ruin her career, and being partial against her. Halep's comments came after the ITIA handed a one-month ban to Iga Swiatek after she tested positive for a banned substance. Halep pointed out at the discrepancy between her ban and the current World No.1's and said that she was left frustrated at the twilight of her career due to the unfair treatment. "I'm sitting and trying to understand, but it's really impossible for me

to understand something like this. I stand and ask myself, why is there such a big difference in treatment and judgment? I can't find and I don't think there can be a logical answer. It can only be bad will from ITIA, the organization that has done absolutely everything to destroy me despite the evidence," Simona Halep wrote on Instagram."I really wanted to destroy the last years of my career, I wanted something that I could never have imagined would be wanted. I always believed in good, I believed in fairness, I believed in goodness. It was painful, is painful and maybe the injustice that was done to me will always be painful. How is it possible that in identical cases

fail a doping test this year after Italy's Jannik Sinner, the men's top-ranked player, also tested positive for anabolic agent clostebol.

However, Sinner was cleared of wrongdoing by an independent tribunal ahead of the U.S. Open, which he went on to win. The World Anti-Doping Agency (WADA) has appealed to the Court of Arbitration for Sport (CAS) against the tribunal's finding of "no fault or negligence". Gill, who had been out due to a thumb fracture, was spotted in the India nets at Canberra ahead of the tour game against Prime Minister's XI.India are set to play their second Test match against Australia in Adelaide. The team will take on Australia in a Pink Ball Test match - traditionally a big strength for Australia in the 5-match series. Shubman, who had not been in action due to his rehabilitation process was seen leaving the ball well in the nets. Gill got hurt while fielding on the second day of the intra-squad match simulation ahead of the Perth Test. He was seen in considerable pain and immediately left the field for further scans. India Today had learnt at the time that Gill had fractured his left thumb and had been ruled out of the opening game.In case the batter does return to the playing XI, the visitors have to rejig their entire line-up. India captain Rohit Sharma is poised to



return to the playing XI, which will displace KL Rahul from his spot. With Shubman Gill expected to return to the line-up, Rahul might have to drop further down the order, possibly at No.5 or No.6.

Apart from Gill, India captain Rohit Sharma was also spotted in the nets. The India captain had started his practice midway through the Perth Test match. He was seen in good touch on Friday.

Don't want 'confident' Virat Kohli for rest of series vs Australia: Allan Border

New Delhi. Former Australian captain Allan Border has called out Australia's failure to contain Virat Kohli during the first Test in Perth, warning that the star Indian batter's resurgence could jeopardise the Pat Cummins-led side's chances in the Border-Gavaskar Trophy (BGT). Kohli, who had gone 18 months without a Test century, silenced his critics with an unbeaten 100 in the second innings, helping India clinch a commanding 295-run victory.Border criticised Australian captain Pat Cummins for field placements and tactics, arguing they allowed Kohli to regain his confidence far too easily. "I was really disappointed in the way we let Kohli roll on to a hundred without much resistance," Border told SEN radio on Friday morning. "We don't want this guy full of confidence for the rest of the series."

Border's concerns were echoed by Matthew Hayden and Mark Taylor, who criticised Cummins for failing to apply early pressure on Kohli. Former Australian batters pointed out that the lack of close-in fielders allowed Kohli to settle in easily and regain his form."They missed a few tricks with Virat



Kohli in the early part of his innings. Nathan Lyon had mid-on back, one on the off-side catching and a mid-wicket. I felt like it was so easy for him to get off strike," Hayden had told Channel 7 after India's win.

You can't cut a sucker an even break when a bloke is under pressure as he was. The field we actually finished with - two slips, no point, a man straight - it offered up the outside edge of his bat as well. He found it a little more frustrating. When he got the bit between the teeth, it was too late. Hayden also highlighted missed opportunities during India's earlier batting partnerships, particularly with Yashasvi Jaiswal, who looked susceptible to short-pitched deliveries. He criticized the delayed use of such strategies and pointed to Australia's "shell-shocked" approach following their subpar batting performance in the first innings.

Europa League: Man United fight back for Amorim's 1st win, Spurs drop points vs Roma

New Delhi. Manchester United staged a thrilling comeback to defeat Norwegian side Bodo/Glimt 3-2, securing their first Europa League victory under new manager Ruben Amorim. Meanwhile, Tottenham Hotspur were denied all three points dramatically as AS Roma salvaged a 2-2 draw with a last-gasp goal on Thursday.

United's Resilience at Old Trafford

New Delhi. Former Australia batter Michael Hussey has thrown his support behind underfire batsman Marnus Labuschagne, attributing his recent slump in form to mental adjustments rather than technical flaws. Labuschagne, widely regarded as one of the world's premier batsmen, has endured a

torrid run of form, managing only 123 runs at a paltry average of 13.66 across his last 10 Test innings. His struggles were on full display during the first Test against India in Perth, where he registered scores of just 2 and 3 as Australia succumbed to a crushing 295-run defeat.Critics have questioned Labuschagne's technique, but Hussey believes the root of the problem lies in his approach to the game. "I actually went back and had a look at some of his highlights of some of his great innings from a few years back. It was just to see if I could see anything different than what we've been seeing in the last week or so," Hussey told SEN.

Hussey suggested Labuschagne's attempts to shoulder greater responsibility as a senior player may have led to an overly cautious mindset. "From a technical perspective, there's actually not a lot of difference from when he was playing really well in scoring a lot of runs compared to the last Test match



against India. The biggest difference I've noticed is just his intent to score. He's probably looking at it thinking, 'I'm a senior player now, I've got to take responsibility, I've got to bat time, be there for the team, soak up the pressure and all of that'. That gets you into a tentative defensive frame of mind of batting time, being there and being patient. Whereas when I watched some of those

highlights from a few years back, he was just confident and decisive in everything he did, even in defence and when he was letting the ball go he was getting into really strong positions."The 29-year-old Labuschagne took a proactive step to address his form on Thursday, returning to the basics with an intense nets session alongside a close friend. Hussey is optimistic that a mental shift can help Labuschagne rediscover his touch.

'I feel as though it's something that can be fixed really quickly just with a mindset shift," Hussey said."If he can just change that mindset of just looking to occupy the crease ... into, 'Whatever I do, I'm going to do it confidently, decisively and be a little bit more positive with an intent to score'. I feel like he can turn it around really quickly.'

Australia will hope Labuschagne regains his form ahead of the second Test against India, starting December 6 at the Adelaide Oval. A strong performance from their No.3 will be crucial as the hosts aim to level the series.


