Union Minister booked after police officer probing mining case alleges threat

Bengaluru, Nov 05: A case has been registered against Union Minister H D Kumaraswamy based on a complaint by a senior police officer who alleged that the JD(S) leader had threatened him in connection with a mining case probe against him. Kumaraswamy termed the FIR as "ridiculous and malicious." The Inspector General of Police M Chandra Sekhar charged the Union Steel and Heavy Industries Minister Kumaraswamy with threatening him - a government servant - to prevent him from discharging his duties. The complainant noted that he was heading the Special Investigation Team probing a mining case in which Kumaraswamy is an accused. The probe against Kumaraswamy pertains to allegations that he illegally approved a 550-acre mining lease to Sri Sai Venkateswara Minerals (SSVM) in Ballari district in violation of law, during his tenure as Karnataka Chief Minister from 2006 to 2008. "The SIT, after preparing the investigation report and having found substantial evidence and material to prosecute the accused (Kumaraswamy), had written to H.E. Governor of Karnataka seeking sanction for prosecution against the accused Sh. H.D. Kumaraswamy on 21/11/2023," Sekhar said in his complaint lodged at Sanjay Nagar police station. "I have read the FIR and the complaint's content. It is completely ridiculous and clearly malicious. The complainant has stated that I allegedly made accusations against him in a press conference and has asked for action. Did I provide false information about him? He can review my press conference video if he wants,' Kumaraswamy was quoted as saying in a statement issued by his office. He alleged in the November 13 by-election

Assembly Channapatna, in which his son Nikhil Kumaraswamy is the NDA candidate, the Congress government is targeting him "out of sheer ani-mosity." "When they (Congress) realised their deceit in Channapatna was becoming apparent, they resorted to new tactics. We have faith in Saheb Ambedkar's Constitution and the law, and trust in the people of Channapatna.

CJI DY Chandrachud's remarks on Krishna | 'Have to stop at some point'; Sharad **Iyer Doctrine spark controversy**

New Delhi, Nov 05: Chief Justice of India DY Chandrachud's remarks on legendary

former Supreme Court judge VR Krishna Iyer that his doctrine did a "disservice" to the broad and flexible spirit of the Constitution has invited criticism from Supreme Court Judges BV Nagarathna and Sudhanshu Dhulia. While pronouncing the majority verdict on interpretation of Article 39(b) of the Constitution to decide if private properties can be considered "material resources of the community" and taken over by the State to subserve the "common good", the CJI noted that the interpretation of Article 39(b) adopted Justice Iyer was rooted in a particular economic ideology and the belief that an economic

structure which prioritises the acquisition of private property by the state is beneficial for the nation. "The doctrinal error in the Krishna Iyer approach was, postulating a

rigid economic theory, which advocates for greater state control over private resources. as the exclusive basis for constitutional governance," the CJI said, overruling his verdict



in Shri Ranganatha Reddy case (1978) which was affirmed by subsequent verdicts in Sanjeev Coke Manufacturing Company case (1982) and Mafatlal Industries Ltd (1996). Justice Nagarathna said the CJI's observations were "unwarranted and unjustified" while Justice Dhulia termed it harsh and avoidable. She wondered if the top court's which interpreted

Constitution to be compatible with the policies of the State then be considered to be "a disservice to the broad and flexible spirit of the Constitution" and the authors of the said judgments being cri-tiqued today. Justice Dhulia wrote, "Before I conclude, I must also record here my strong disapproval of the remarks made on the Krishna Iyer Doctrine as it is called. This criticism is harsh, and could have been avoided. The Krishna Iyer Doctrine, or for that matter the O Chinnappa Reddy Doctrine, is familiar to all who have anything to do with law or life. It is based on strong humanist principles of fairness and equity. It is a doctrine which has illuminated our path in dark times. The long

The Nationalist Congress Party faction headed by Sharad Pawar has given ticket to Yugendra, who would be taking on his uncle and Deputy Chief Minister Ajit Pawar in Baramati in the November 20 Maharashtra assembly elections.



Marchula (Uttarakhand), Nov 05: A packed beyond capacity bus carrying passengers returning to work after Diwali fell into a deep gorge in Uttarakhand's Almora district on Monday, killing at least 36 of the over 60 people on board. Twenty-six people were injured, four of them critically, when the 43-seater bus, operated by the private Garhwal Motor Owners Union, was on its way from Pauri in Garhwal region to Ramnagar in Kumaon, about 250 km away. The accident took place around 8 am, almost the fag end of the overnight journey, said District Magistrate Alok Kumar Pandey. The bus plunged into a 200 metre gorge in Almora's Marchula area 35 km before its destination of Ramnagar, he said. Visuals from the area pointed to the magnitude of the accident, with the vehicle reduced to a mangled mess as it rolled down the forested, rocky slope and stopped just short of a stream. Rescuers could be seen working to pull out passengers. The rescue operation lasted around five hours. Of the 36 killed, 10 are women. Twenty-eight people died on the spot and eight succumbed to injuries in the Ramdutt Joshi Joint Hospital in Ramnagar. A magisterial probe has been ordered and the assistant regional transport officers of Pauri and Almora suspended. "The news of the death of many people, including women and children, in a road accident in Almora, Uttarakhand is heart-rending. I express my condolences to the bereaved families and pray for the speedy recovery of those injured," President Droupadi Murmu wrote on X. PM Narendra Modi,

plea seeking transfer of **MUDA** case to CBI

Bengaluru, Nov 05: The Karnataka High Court on Tuesday issued notice to Chief Minister Siddaramaiah and others on a writ petition filed by RTI activist Snehamavi Krishna seeking a direction to transfer the MUDA site allotment case to CBI. Justice M Nagaprasanna, who also issued notice to Siddaramaiah's wife Parvathi B M, brother-in-law Mallikarjuna Swamy, Union of India, the State government, CBI and Lokayukta, directed the Lokayukta to place on record investigation conducted in the case so far. Meanwhile, the Lokayukta police have summoned Siddaramaiah, who is accused number one in the case, for questioning on November 6. They had on October 25 questioned his wife, who is the accused number two in the case. The CM is facing allegations of illegalities in the allotment of 14 sites to his wife by the Mysuru Urban Development Authority (MUDA). Siddaramaiah, his wife, Swamy and Devaraju - from whom Swamy had purchased a land and gifted it to Parvathi - and others have been named in the FIR registered by the Mysurulocated Lokayukta police establishment on September 27. Swamy and Devaraju have also deposed before the Lokayukta police.

Not all private properties can be termed 'material resources of community'

New Delhi, Nov 05: Amid the raging debate over redistribution of wealth, the Supreme Court on Tuesday ruled that not all private properties can be termed "material resources of the community" under Article 39(b) of the Constitution and taken over by the state to subserve the "common good". A nine-judge Constitution Bench led by CJI DY Chandrachud said, "Not every resource owned by an individual can be considered a 'material resource of the community' merely because it meets the qualifier of 'material needs'." Writing the verdict for himself, Justice Hrishikesh Roy, Justice JB Pardiwala, Justice Manoj Misra, Justice Rajesh Bindal, Justice SC

Sharma and Justice AG Masih, however, said, "Theoretically, the answer is yes, the phrase may include privately owned resources' even as it sought to emphasise that "this Court must not tread into the domain of economic policy, or endorse a particular economic ideology while

undertaking constitutional interpretation". Justice Nagarathna wrote a partially concurring verdict while Justice Dhulia delivered a dissenting judgment. To decide if a particular private



resource was a "material resource, the court must determine if its distribution would subserve "common good", the CJI said while pronouncing the verdict. "Whether the resource in question falls within the ambit of Article 39(b) must be context-specific and subject to a nonexhaustive list of factors such as the nature of

the resource and its characteristics; the impact of the resource on the well-being of the community; the scarcity of the resource; and the consequences of such a resource being concentrated in the hands of private players," the CJI said, adding, the public trust doctrine evolved by this top court may also be applied to identify resources which fall within the ambit of the phrase "material resource of the community". It said, "In some cases, the mere vesting of the resource in the hands of the government serves the 'common good', while in other cases, a resource may be distributed amongst private players to achieve this purpose. To illustrate, a large privately owned pond may be acquired and put in control of a governmental agency or a cooperative society so that the pond is preserved. "Similarly, the material resource of spectrum may be auctioned to the highest bidder who may be a private company, who would then utilise the spectrum along with their technology to best sub-serve the common good. These are questions of economic and social policy which fall outside the ambit of judicial inquiry," it noted. "To hold that the term

"distribution" cannot encompass the vesting of a private resource would amount to falling into the same error as the Justice Krishna Iyer doctrine, ie, to lay down a preference of economic and social policy," the CJI said in his majority verdict, disapproving of observations made by Justice Iyer in a 1978 verdict. In the run-up to the 2024 Lok Sabha polls, Congress leader Rahul Gandhi had talked about growing inequality and the need for wealth redistribution. "First, we will conduct a caste census to know the exact population and status of backward castes, SCs, STs, minorities and other castes. After that, the financial and institutional survey will begin. Subsequently, we will take up the historic assignment to distribute the wealth of India, jobs and other welfare schemes to these sections based on their population," he had said. However, the majority verdict rejected this line of constitutional thinking. "India's economic trajectory indicates that the Constitution and the custodians of the Constitution - the electorate - have routinely rejected one economic dogma as being the exclusive repository of truth. As participants in a vibrant multi-party

'economic democracy', the 'People of India have voted to power governments which have adopted varied economic and social policies. based on the country's evolving development priorities and challenges. "The foresighted vision of our framers (of Constitution) to establish an 'economic democracy' and trust the wisdom of the elected government has been the backbone of the high growth rate of India's economy, making it one of the fastest-growing economies in the world. To scuttle this constitutional vision by imposing a single economic theory, which views the acquisition of private property by the state as the ultimate goal, would undermine the very fabric and principles of our constitutional framework," the CJI said in his majority verdict. The nine-judge Constitution Bench was asked to decide whether private properties can be considered "material resources of the community" within the meaning of Article 39(b) of the Constitution and consequently, taken over by the state to sub-serve the common good. Landslide causes TN villagers to walk several km for basic amenities

THENI: Residents of Agamalai village were forced to walk several kilometres to Periyakulam for basic amenities, after rubble from landslides obstructed the way in multiple locations from Agamalai to Periyakulam Road. Villagers claimed that the rubble was cleared off the road only two days after the landslide on Monday. Officials said that sporadic rain caused the delay and remaining minor works will be completed soon.Sources said, earlier on Friday, following sporadic rainfall in the Western Ghats, a landslide occurred in nearly 10 places in the mountain road connecting Periyakulam to Agamalai. As the roads were not motorable, villagers had to opt walking several kilometres for basic amenities for two days, till Monday. Agamalai village is situated in the mountains above Sothuparai Dam. Though the area is situated close to Periyakulam in Theni district, the village comes under the Bodinayakanur panchayat. There are nearly 10 villages including Pattur, Parambur, and Karunparai near Agamalai, which uses the same road to commute to Periyakulam for work and school.

'Officials have been clearing debris for the last two days. As Deepavali holidays are over, children have to walk several kilometres to go to school. For purchasing basic amenities, locals have to walk all the way down from the mountain for transport. We request officials to restore the road as soon as possible," said Subbaiah, an Agamalai resident. When contacted, a senior official from Theni district said that the particular road is maintained by the highways department and following the landslide, a team was immediately deployed to clear the

Forest guard drowns while escaping from tusker attack in Karnataka

MYSURU: In a tragic incident, a 22-year-old forest guard drowned in the Kapila river while trying to escape from a tusker attack at Bandipur Tiger Reserve on Sunday evening. According to foresters, Shashank, a resident of Kalaianahall village and a forest guard serving in the Kakanakote forest area as outsource staff, drowned in the Kapila river coming under the Gundre forest range in HD Kote taluk. Forest guards Shashank P C and Rajanna P were on foot patrolling in the forest area at Aaramalleshwara near forest IB when a tusker attacked them at 4.45 pm. As the tusker was behind a huge bush, the forest guards, who did not notice the animal, had walked close to it. The tusker which rushed towards them attacked the guards.

As the tusker attacked the guards, they tried to run for their lives towards the river at Kannegala. As both received minor injuries during the attack, they jumped into the river While Rajanna managed to swim back to shore and saved his life, Shanshak drowned in the river. Rajanna managed to run towards the village and informed forest officers and villagers regarding the incident. RFO Amruthesh along with the staff rushed to the spot and managed to fish out the body out of the water. HD Kote MLA Anil Chikkamadu, who visited the spot, assured Rs 30 lakh compensation to the victim's family members. He handed over Rs 5 lakh as immediate relief to the victim's mother

Hasanamba temple in Karnataka nets Rs 12.64 crore in nine days

HASSAN: In nine days, Hasanamba temple recorded a revenue of Rs 12.64 crore, a significant increase compared to previous years. The temple also saw a record number of devotees in 2024; 20.68 lakh devotees from different parts of the state and abroad thronged the temple.According to Maruti, the administrator of the Hasanamba temple committee, Rs 7.41 crore was collected by selling Rs 1,000 tickets, Rs 1.81.crore collected by selling Rs 300 tickets, Rs 76.77 lakh collected by selling Laddu prasadam and Rs 6.84 lakh was earned through online tickets."The temple also earned Rs 2 lakh by selling of sarees while Hasanamba hundi (Cash collection box) got Rs 2,55,97,567. Rs 13,47,780 was collected in the hundi of Siddeshwara temple and the rest of money from donations, Tulabhara and advertisement," he added.

Apart from cash, 51 grams of gold ornaments, 913 grams of silver ornaments and 500 grams of copper items were found in the hundi. For the first time, the temple administrative committee has not disclosed contents of the letters dropped by devotees. Sources said that most of the devotees prayed for marriage, settlement of land disputes, family problems and jobs. Sources also said that a pamphlet related to Channapatna bypoll was also found in the cash collection box. Over 1,000 different handwritten letters, foreign currencies, small garland, wrist watch, banned Rs 1,000 and Rs 2,000 notes were also found in the hundi. 500 officials

Berhampur's ODF status questioned as public toilets remain neglected

BERHAMPUR: Berhampur city was declared open defecation-free in 2018. Two years later, the Berhampur Municipal Corporation (BeMC) was awarded ODF++ ranking in the Swachhata Sarvekshan (cleanliness survey) conducted by the Centre.But the acute shortage of functional public toilets and garbage strewn in the open belie the very notion of sanitation.

The city has a population of 6 lakh, excluding a floating population of over one lakh. While most households in the city have their own toilets, people residing in slums use embankments of ponds to defecate. However, it's those who come to the city for work on a daily basis who suffer the most. In the absence of functional public toilets, people are forced to urinate in the open. The BeMC has constructed a considerable number of community toilets across the city and keeps adding to the number every year but many of the toilets remain closed due to lack of maintenance, particularly shortage of water. As expected, women suffer the most as they have no option but to relieve



themselves in the open.

The BeMC has spent crores of rupees on various projects to keep the city clean. But several toilets including the one at Canal Street, have been razed and the authorities are not even aware of it. Santosh Behera, a resident of Canal Street rues that a toilet. constructed in 2015, was locked two years back. It has now been demolished. The

ones still standing are locked and the ones that are functional lie in a dilapidated

The civic body was reportedly sanctioned over Rs 1 crore in the first phase of Swachh Bharat Mission. The civic body initially constructed 23 toilets and the number went up to 62. Eight more public toilets are in the pipeline. But the state of

affairs depicts a sorry picture with urinals at several locations including Bijipur, Bada Bazaar and Zenana Hospital demolished for reasons best known to the civic body officials. What's interesting is that BeMC officials have no record of toilets that no longer exist.

As per records, BeMC spends over Rs 5 lakh per month for maintenance of 40 community toilets which is carried out by self-help groups. This apart, the civic body pays around Rs 3 lakh to Sulabh International, a social service organisation. Apart from paying for the public toilets, BeMC has its own around 12 sanitation staff who are paid over Rs 4 lakh towards salary.

A look at the figures suggests the civic body spends over Rs 12 lakh per month on maintenance and upkeep of community toilets some of which do not even exist.BeMC commissioner, Bhabani Shankar Mishra said, so far, he has not received any complaint about public toilets and if any is received, appropriate action will be taken.

Wastewater emerges as threat to Meghanada Prachira of Shree Jagannath in Odisha BHUBANESWAR: Waste water,

especially the discharge from Ananda Bazaar, has emerged as a threat to the Meghanada Prachira of Shree Jagannath temple in Puri, slowly damaging the 12th-century shrine's boundary wall made of laterite and sandstone blocks. The absence of a proper channel to drain out water from the shrine premises has resulted in ingress into the Meghanada Prachira on three sides of the boundary wall - east, north and west. For the convenience of devotees visiting the 12thcentury shrine, the temple administration has installed RO systems, one each at the drinking water points in the south and north sides besides the premises of Ananda Bazaar where thousands of devotees partake 'Mahaprasad' everyday. The existing old drainage channel (dry masonry) in Ananda Bazaar has been lying in a dilapidated condition for a long time and is unable to drain out excess water from the RO system along



with the tap water used to wash hands by devotees before and after partaking the

'Mahaprasad'. While there are water points in the north, east and south parts of the boundary wall, there is a washroom for sevayats on the west side which they use to wash their hands and legs before entering the shrine. Drainage channels near every water point in all the directions of Meghanada Prachira except south are damaged and need to be repaired or reconstructed failing which, percolation of water into the boundary wall cannot be stopped, sources

said. The responsibility of the shrine and Meghanada Prachira's protection, preservation and conservation lies with the ASI while devotees' amenities and drainage are looked after by the temple

ASI Puri circle head DB Gadnayak said the matter has been taken up with the Shree Jagannath Temple Administration (SJTA) in the past. In August this year, the ASI had written to the temple administrator (development) to take steps for the water leakage from the walls of Meghanada Prachira on east, west and north sides alongside the

damaged drain, washroom and pipeline.A tender was called by the temple administration for the purpose but could not be finalised. Temple administrator Arvind Padhee said there are six drainage channels on the shrine premises which have already been cleaned for smooth flow of waste water. The works section of the temple has been directed to go ahead with temporary measures to address the drainage issues, particulary at Ananda

6,845 RTI applications and appeals pending with State **Information Commission**

THRISSUR: Introduced in 2005 to ensure transparency in governance, the Right to Information (RTI) Act is considered a powerful tool against corruption, empowering ordinary citizens to question those in power about their actions. While the increasing number of applications is becoming a major challenge for the bureaucracy, it seems the very intent of the law is being undermined when applications remain pending for so long. According to data, as of August 9, a total of 6,845 RTI applications, including newly filed applications and appeals, are pending in the office of the State Information Commission (SIC). Over seven years, from 2018 to 2024, 1,641 applications remain unanswered, while 5,204 appeals are still pending with the SIC.

Criticizing the commission for not fulfilling the purpose of the law, Satheesh P. B., director of the Nerkazhcha Association in Thrissur, said the delay in gathering and disseminating information benefits officers, particularly in incidents related to custodial deaths and police cases.In an application filed by Satheesh to retrieve CCTV footage from a police station, the Information Commission has yet to make a final decision on the appeal. When asked about the number of appeals pending at the SIC after evidence collection and hearings, but before final orders were issued, it appears the commission does not keep such data. In another RTI application filed by Idukki native Sharon Thomas, the Chief Information Commission rejected the appeal, citing the applicant's failure to attend the sitting in Thiruvananthapuram on the scheduled day.

Sharon had sought information regarding the facilities provided in Kerala's prisons for religious studies and whether there was a ban on religious studies in jails. The department concerned has not yet replied to the two questions for which the appeal was filed."Isn't it unfair to reject the RTI appeal just because the applicant, based in Idukki, didn't attend the commission's sitting in Thiruvananthapuram?" asked Satheesh. He also criticized the common practice in which the Chief Information Commission refrains from issuing orders on important topics, leaving the matter for their successor after retirement.

Property dealer opens fire at another in Gurgaon's Sector 4,

Gurgaon. The crime branch arrested a 36-year-old property dealer on Monday for allegedly attempting to kill another property dealer by firing at him in Sector 4. A case was registered at New Colony police station, and the accused was arrested within hours of the incident. The victim, Jatin, did not suffer any injuries. A licensed firearm was recovered from the accused, police said. They added that they received an alert about the shooting at Sector 4/7 Chowk near Dreams Mall. "Our team rushed to the spot and met the complainant. A bullet fired by the accused was found pierced in the seat of the car," said ACP Crime II, Manoj Kumar. Jatin told police that around 12.05am, he was headed towards Dreams Mall with three friends and had stopped near Sector 4/7 Chowk to attend to some personal work."The accused, Abhishek Gaur (36) came from behind in another car and asked Jatin to move his vehicle. During this, the accused referred to Jatin as 'chotu,' leading to an argument," the ACP said. "The accused opened fire at Jatinand fled the scene."A case was registered against Abhishek under BNS sections 109(2) (attempt to murder), 3(5) (common intention), and the Arms Act.

Stay away from corrupt practices or face action: Cabinet Minister Rao Narbir Singh warns MCM staffers

Gurgaon. Cabinet Minister Rao Narbir Singh held a meeting at Municipal Corporation of Manesar (MCM) on Monday and issued a warning to engineering and taxation department officials against corruption, saying he was aware of their "rates".He stressed on the importance of better service delivery and directed officials to improve their performance within six months. According to sources, he named four taxation department officials, including a top officer and two clerks, and said, 'Your rates are fixed, and I know your rates."He then directed them to relinquish additional responsibilities that impacted their performance and ensure that public doesn't face any issues related to property ID matters. The Cabinet Minister also pulled up the officials for failing to ensure sewerage network was functional in certain villages even after the lines were laid during his last tenure in 2019. He said it was concerning that despite laying these sewer lines around five years ago, they remained unconnected to the main network. According to sources, he gave officials six months to finish works on the sewerage network. Officials, especially those in the engineering wing, were directed to spend more time in the field rather than the office to better understand people's problems. The meeting also included a detailed discussion on the sanitation system in the corporation area. Officials reported that untreated sewage from various societies was being discharged openly through tankers. The Cabinet Minister directed them to identify such societies and take strict action against them. He also ordered an inspection of the sewage treatment plants (STPs) installed in societies to make sure they were functional.Moreover, the minister instructed officials to build service roads along both sides of the intersection after evaluating the traffic congestion at Rampura Chowk on the national highway. At the meeting, he also said his goal was to include Gurgaon among the top 10 cities in the country. He urged the officials of the MCM and Gurgaon to ensure highquality construction work at a low cost and to invest public money for the public's welfare. He also directed the officials to work towards freeing govt land from encroachment and completely banning

Ghaziabad bypoll now on Nov 20, parties rush to tweak campaign plans

Ghaziabad. The Election Commission has rescheduled bypolls to nine assembly seats in UP, including Ghaziabad, from Nov 13 to Nov 20. In a statement, the poll panel cited "large-scale social, cultural, and religious engagements" for its decision.

Apart from UP, dates of polls to certain seats in Kerala and Punjab were changed as well. "Subsequently, representations have been received in the Commission from various recognised National and State political parties (including BJP, INC, BSP, RLD) and some social organisations for a change of date of poll in some Assembly Constituencies having by-elections on 13th November 2024, considering large-scale social, cultural, and religious engagements on that day which may cause inconvenience to a large number of people, give rise to various logistic issues and may lead to reduced voter participation during the poll," the commission said in a statement. Frontline parties like BJP and SP are planning to make the most of this time extension, tweaking their campaign schedules to bring in senior leaders to hold roadshows and public meetings.For BJP, chief minister Yogi Adityanath is set to hold a rally on Nov 8."He will attend a roadshow in Vijay Nagar. According to the earlier schedule, polls were supposed to be held on Nov 13, which meant we had time only till Nov 11 for campaigning. Now that the commission has given a time extension, we are planning another such programme by Yogi Adityanath," said Pramod Chaudhary, BJP's media in charge in Ghaziabad. As part of preparations, BJP state president Bhupendra Singh Choudhary also held a meeting of party workers on Monday."It was attended by about 1,000 booth-level workers. The agenda of the meeting was to increase voter turnout. Choudhary also stressed the need to shed off complacency even though Ghaziabad is considered a safe seat for BJP," the media in-charge said.BJP has fielded Sanjeev Sharma from Ghaziabad, which fell vacant after Atul Garg was elected to the Lok Sabha.SP, too, is not leavingary stone unturned."Party chief and former CM Akhilesh Yadav will be in Ghaziabad on Tuesday, when he will address about 500 workers from the INDIA bloc on ways to garner maximum votes for alliance candidate Singhraj Jatav. Hand over flats to buyers in 3 months and compensate for delays, H-Rera tells 4 builders

Gurgaon. H-Rera has ordered four prominent developers — Raheja Developers, Ramprastha Developers, Tashi Land Developers, and Sunrays Heights — to deliver flats to their buyers within 90 days and pay approximately 11% annual interest on investments. Rera also issued a warning that non-compliance will result in legal proceedings. The regulator's investigation of individual cases revealed that investors, who had paid amounts ranging from Rs 13 lakh to Rs 1 crore, experienced substantial delays beyond the contractually agreed delivery dates. In the first case, H-Rera penalised Raheja developers as they failed to hand over a Rs 74 lakh flat to Delhi residents Dharampal Singh and Manjeet Kaur Swami. They bought the flat in Shilas, Sector 109, in 2010 and paid Rs 66 lakh, but did not

Washington, The voices of the Indian American community are expected to be crucial in the US presidential polls across many states, including the battleground states, Neera Tanden, senior advisor to US President Joe Biden, said in an exclusive conversation with India Today as she analysed the pre-election scenario. According to her, this election could be the culmination of long-standing efforts to ensure that Indian American voices are heard, as Democratic nominee Kamala Harris and her Republican rival, Donald Trump, are set for a razor-thin contest on November 5.We've all lived through periods where there's more bias and anger. And then there's periods where we feel more welcome. And I just think, you know, we stand at a moment where Indian American voices will not just be heard, but will roar in this election,' Tanden said as he explained Harri's campaign addressing various communities. She noted that Kamala Harris's deep understanding of India and her perspective will be a significant asset in fostering stronger US-India relations if she is elected to power."If we elect Kamala Harris tomorrow, we will have the first president ever who visited India as a child who has Indian relatives who experience what it's like, that really knows India from that perspective, not just as a geopolitical ally, but really from the bottom up," Tanden said. She stressed, "I think her added understanding of India from that perspective will be an unfathomable asset in the bilateral relationship between the United States and India. And I think India will be very proud to have a daughter of India as President". She further noted that a lot of people in the Indian community in the US feel a sense of pride that Kamala Harris is actually on the cusp of being president. "And I just see that there's a lot of, you know, just energy out there. So our Indian Americans are a crucial voting bloc. They are one of the largest ethnic minorities in Pennsylvania, for example, a very important state. But

Canadian police officer suspended for attending pro-Khalistan protest outside Hindu temple

OTTAWA. A Canadian police officer has been suspended for participating in a pro-Khalistan protest outside the Hindu Sabha temple in Brampton, according to a media report.On Sunday, protestors carrying Khalistani flags clashed with people at the Hindu temple and disrupted a consular event co-organised by the temple authorities and the Indian Consulate. There were unverified videos circulating on social media about the protest.

The videos appeared to show demonstrators holding banners in support of Khalistan, as reported by the Canadian Broadcasting Corporation. The Peel Police is "aware of a video circulating on social media which shows an off-duty Peel Police officer involved in a demonstration," said Media Relations Officer Richard Chin in an email to CBC News."This officer has since been suspended in accordance with the Community Safety and Policing Act," he said. "We are investigating the circumstances in totality depicted in the video and are unable to provide further information until such time that this investigation is complete."Peel police previously said three people have been charged after violence erupted as Indian consular officials visited the Hindu Sabha Mandir temple Sunday. Videos circulating on social media show demonstrators holding banners in support of Khalistan, the CBC report added.

Later in the day, demonstrators made their way to the Westwood Mall in neighbouring Mississauga, according to the World Sikh Organisation of Canada.

A short time after, a third protest was held outside the Malton gurdwara, a Sikh place of worship on Airport Road in Mississauga, the report added."Although these demonstrations occurred at three different locations, they appear to be related to one another. Several incidents between protestors and worshippers broke out," police said in a news release.India on Monday condemned the attack on the temple with an expectation that those indulging in violence "will be prosecuted".

In a statement, the Ministry of External Affairs said that New Delhi remains "deeply concerned" about the safety and security of Indian nationals in Canada.

US election: When will we know who won

WASHINGTON. As Americans prepare to vote on Election Day Tuesday, officials are calling for patience as they tally ballots in what could be a historically close presidential race -- and warning that it could take days to find out who has won.

Under the US system, citizens do not vote directly for their leader. Instead, their ballots elect the 538 members of a group called the Electoral College, which then elects the president and vice president.

Each state casts its Electoral College votes for the candidate that won its popular vote. Bigger states, with more representatives in the US Congress, get a larger share of the 538 Electoral College votes on offer.Democratic Vice President Kamala Harris and her Republican rival Donald Trump will be vying to get to the all-important 270 votes that pushes them past the halfway mark and guarantees them the keys to the Oval Office.But with this year's race going down to the wire, experts point to a growing risk of delays and complications like legal challenges over the vote count. Around 81 million people have voted ahead of Tuesday, over half of the total ballots cast in 2020. How long is the count?

The first polls close at 6:00 pm Eastern Time (2300 GMT) but when the race is tight, it could take days before a victor is projected.In 2020, US media declared Democratic candidate Joe Biden the winner on Saturday November 7, although polls closed the Tuesday before.

In 2016 and 2012, voters had a shorter wait.

After votes are cast, local election officials, who may be appointed or elected, process and count them. Tallying methods vary from one location to the next.

Missouri sues US Justice Department to block it from sending poll monitors

The Republican-led state of Missouri asked a judge on Monday to block the US Justice Department from sending lawyers to St. Louis on Election Day to monitor for compliance with federal voting rights laws, even after the city's election board agreed to permit it.

He has urged his supporters to turn out at polling places to watch for suspected fraudY

Missouri is one of 27 states the Justice Department said on Friday it would send staff out to monitor voting locations, as it has done regularly during national elections.

The only location in Missouri it is sending poll monitors to is St Louis, which in January 2021 reached a settlement with the Justice Department over concerns about architectural barriers and other problems that could have hindered voting by people with disabilities. As part of that settlement, the city's Board of Election

Commissioners agreed to allow the Justice Department to monitor for compliance. This included the

monitoring of polling places on Election Day. The settlement was completed at the very end of the Trump administration, when Eric Dreiband previously served as the Assistant Attorney General for the Civil Rights Division. The Justice Department declined to comment on the lawsuit. While some of the locations the Justice Department will monitor on Election Day include key counties in the seven battleground states expected to help decide the election, the Justice Department is also sending personnel to a variety of other locations such as counties in Texas, Massachusetts, Alaska, South Dakota and New

Missouri is not one of the seven battleground states. The Justice Department is responsible for enforcing a variety of federal voting rights laws, such as one that requires states to accommodate voters with disabilities and another that requires states to allow US citizens and

military members who reside overseas to vote by absentee ballot in federal elections.In 2022, both Florida and Missouri resisted efforts by the Justice Department to send poll monitors to locations including Miami-Dade and Broward County, Florida.Florida, in a letter to the Justice Department that year, said state law prohibited department employees from being inside polling places unless they were on a list of permitted personnel.In response to the concerns, the Justice Department had its staff stationed outside polling locations in Florida and Missouri for the 2022

The 7 states that will swing the fate of Kamala Harris and Donald Trump

With the 2024 US presidential election set to go down the wire, it will be up to the seven swing states to determine the fate of Democratic candidate Kamala Harris, 60, and her Republican rival and former President Donald Trump, 78. These pivotal states --Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania, and Wisconsin -have 93 electoral votes and are the primary battlegrounds as both candidates vie for the 270 of the total 538 electoral votes required to secure the presidency. Swing states, or battleground states, are those that can shift between Democratic and Republican support depending on the election. These states, with historically



narrow voting margins and varied outcomes over time, draw significant attention from candidates, who focus their campaigns there to sway voters and secure crucial electoral votes. On the final day of campaigning, both Harris and Trump held marathon rallies

in Pennsylvania, the largest of the swing states with 19 electoral college votes. While all seven states are essential to either campaign, three states in particular --Pennsylvania, Michigan, and Wisconsin -- are crucial for Harris's path to victory. Known as the "Blue Wall", these states were reliable Democratic strongholds until Trump flipped all three in 2016, breaking the

Democrats' winning streak in the region. In 2020, Joe Biden reclaimed these states for the Democrats, but by narrow margins, highlighting their competitive nature and making them

Bad things can happen: Trump on possibility of losing to Harris amid close race

Former President and Republican presidential candidate Donald Trump stated that he could imagine the possibility of losing the election to Vice President Kamala Harris. However, he emphasised that he currently holds "a substantial lead" and predicted that the outcome of the election would likely be clear by election night.

Speaking to ABC News, when asked whether he thinks there's any way he could lose the election, the former president said, "Yeah, I guess, you know". "I guess you could lose, can lose. I mean, that happens, right?...But I think I have a pretty substantial lead. But, you could say--yeah, yeah, you could lose. Bad things could happen. You know, things happen, but it's going to be interesting," Trump elaborated. The US is going to the polls on November 5 to elect its next president in what is predicted to be the closest race in American history. While some polls suggest an edge for Harris at the national level, others predict a Trump upper hand in key

When asked to comment on what the Indian-American voters

thought of the 2024 election cycle, Jagannathan said it was not only members of the Indian community, but groups of people from other minorities coming together to Harris's aide.Regarding her message to Indian-



American voters who were still undecided on which candidate to choose as President, the actor said that the decision "depends on who they are as a person". There is a big divide right now between Indian-American women and Indian-American men. For Indian-Americans in general, you have to remember where we came from and who we are. We may be perceived as the minority or immigrants who are not threatened when Trump sends Diwali messages. But don't be fooled," she warned."What happens to one immigrant group will affect us as well. This is exactly what we saw after 9/11. There was so much Islamophobia, it

The actor also mentioned abortion rights, one of the most contentious issues in this year's election, and said that it not only affects women but men as well.

The list includes top musicians like Beyonce, Taylor Swift, Bruce Springsteen, Stevie Wonder, Eminem; actors Julia Roberts, Kerry Washington, Samuel L Jackson, Arnold Schwarzenegger; and NBA stars LeBron James and Magic Johnson.

Elon Musk's lawyer admits \$1 million giveaway to voters was not random

World Elon Musk's pro-Trump group does not choose the winners of its \$1 million-aday giveaway to registered voters at random, but instead picks people who would be good spokespeople for its agenda, a lawyer for the billionaire said on Monday.

"The only people protected by Pennsylvania law are in Pennsylvania," said Richard

Musk lawyer Chris Gober was trying to persuade a Pennsylvania judge that the giveaway was not an "illegal lottery," as But in courtroom testimony, Krasner Philadelphia district attorney Lawrence Krasner alleged in a lawsuit seeking to block the contest ahead of Tuesday's US presidential election."There is no prize to be won, instead recipients must fulfil contractual obligations to serve as a spokesperson for the PAC," Gober said in the hearing before Judge Angelo Foglietta. The hearing in the battleground state comes

President Kamala Harris and Republican former President Donald Trump will square off in the tightly contested race. Musk and his political action committee are backing Trump.Tesla CEO Musk's offer is limited to registered voters in the seven states expected to decide the election - Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania and Wisconsin. protection laws.A lawyer for Krasner's office, John Summers, called Gober's comments a "complete admission of liability."

'We just heard this guy say, my boss, my client, called this random," Summers said. "We promised people that they were going to participate in a random process, but it's a process where we pre-select people."Summers later showed the court a clip of Musk at an Oct. 19 Trump rally telling attendees that America PAC would "randomly" award \$1 million to people who sign the petition every day until the

election. In the video, Musk also said "all we ask" is that the winners serve as spokespeople for the group.

"This was all political marketing masquerading as a lottery, albeit an illegal lottery," Krasner said. Philadelphia is the largest city in Pennsylvania, one of seven battleground states likely to determine the outcome of the race between Trump and Harris. Whichever candidate wins, the state will receive its 19 electoral votes out of a total of 270 needed to win. The giveaway falls in a grey area of election law, and legal experts are divided on whether Musk could be violating federal laws against paying people to register to vote.

The US Department of Justice has warned America PAC the giveaway could violate federal law, according to media reports, but federal prosecutor have not taken any public action. Musk has so far given nearly \$120 million to America PAC, according to federal disclosures. The Trump campaign is broadly reliant on outside groups for canvassing voters, meaning the super PAC founded by Musk, the world's richest man, plays an outsized role in what is expected to be a razor-thin

Industrialists, organisations want new railway division in Coimbatore

COIMBATORE: Various Industrialists and social organisations met Railway Minister Ashwini Vaishnaw during his visit to Coimbatore on Monday. An entrance to the northern side of the Podnaur station should also be given as there is an adequate space on the existing road and it will give easy access for passengers from the central part of the city.'

Shabarish accepted the challenge. They lit the "paper bomb" firecracker and placed a cardboard box on it. As soon as Shabarish sat on the box, the "paper bomb" exploded, injuring his private parts. He was immediately rushed to Victoria Hospital, where he died on Saturday, the police said. The police said the CCTV footage obtained from near the spot shows Shabarish sitting on the box placed on the "paper bomb", while his friends run for cover. Moments later, the box explodes, leaving Shabarish seriously injured. The police said they arrested Shabarish's six friends after receiving a complaint on Sunday. They have been booked under Sections 105 (culpable homicide not amounting to murder) and 288 (negligent conduct with respect to explosives substance) of BNS.

Sirpur BJP MLA launches fast, demands suspension of forest officials for alleged thirddegree torture of six farmers

ADILABAD: Sirpur BJP MLA Palvai Harish Babu launched a hunger strike in front of the Sirpur (T) range office in Kumurambheem-Asifabad district on Monday, demanding that the government suspend the forest officials who, he alleged, subjected six farmers to thirddegree torture.He said that the forest officials tortured the farmers from the Bengal camp and one farmer from Heerapur in the district for allegedly killing a wild boar. Traffic stops in Bhubaneshwar to have solar sheds for commuters



BHUBANESWAR: Bhubaneswar will soon get solar sheds at major traffic intersections to protect commuters from the blazing sun during summer and fulfil the electricity requirement of the city's infrastructure from renewable energy sources.A proposal to this effect has been submitted by the Bhubaneswar Municipal Corporation (BMC) to the Odisha Renewable Energy Development Agency (OREDA). Bhubaneswar mayor Sulochana Das said, "Initially, we have planned to pilot the project at two major traffic intersections -AG square and Kalinga Hospital Square. After studying their feasibility, these sheds will be installed at other traffic intersections in the city."

Das said during the summer this year, BMC had installed temporary sheds at traffic intersections to protect commuters from the scorching sun. The civic body was widely appreciated for the initiative. "Subsequently, we decided to go for solar sheds to get rid of the needless expenditure on installing temporary structures every year."

The sheds will be permanent structures with onetime investment. "Apart from providing shelter to commuters from the sun, the sheds fitted with solar panels on the roof will supply power to street lights on the road medians and other energy infrastructure," the mayor added.A BMC official said the sheds will be made climate resilient to make them withstand strong winds. Besides, these structures will be planned in such a way that they don't affect the proposed metro project.

He said the proposal will also be in line with the 'Green Energy and Solar City' plan envisioned by the Ministry of New and Renewable Energy (MNRE) for the state capital. Under the plan, around 42 stretches of the road network have already been identified by the OREDA and TPCODL in coordination with BMC where solar power integration of street lights will be carried out in phases.

Air quality takes a hit in Bengaluru's Hebbal, Jigani

Ambient noise levels too saw a notable rise, impacting residents' health and well-being, especially those with respiratory issues.

MYSURU: As Bengaluru celebrated Deepavali last weekend, the city's air quality took a significant hit, according to data obtained by Continuous Ambient Air Quality Monitoring Stations (CAAQMS) from a few key locations. The air quality index

(AQI) surged dramatically, with Hebbal and Jigani stations in Bengaluru experiencing some of the most pronounced increases in pollution levels. Ambient noise levels too saw a notable rise, impacting residents' health and well-being, especially those with respiratory issues.

On the day before Deepavali, Hebbal's AQI reading was relatively

low at 75, indicating a "satisfactory" air quality level, with only minor discomfort possible for sensitive groups. However, as festivities commenced, the AQI levels soared.On the first day of Deepavali, Hebbal recorded an AQI of 263, plunging the quality of air to the "poor" category, posing breathing risks for most

people on prolonged exposure. Although the AQI dipped to 227 on the second day and to 65 on the third, Hebbal's three-day average AQI was an alarming 185 marking a 146.7% increase from pre-Deepavali levels.In Jigani, similar



patterns emerged. The station, which reported an AQI of 55 on the eve of the festival, saw this increase to 123 on the second day, with the third day AQI of 81, averaging 136 over the three days. This constituted a 147.3% rise in pollution levels.Meanwhile, Kasturinagar's AQI soared from 67 pre-Deepavali to an

average of 141 over the festivities, a spike of 110.9%.

The situation was no different in other districts. Davanagere reported a staggering 217.2% increase, from a 31 AQI level pre-Deepavali to an average of 97 during the

> festivities.Dakshina Kannada, known for its relatively cleaner air, saw a 114.8% surge from 36 to 77 AQI, while Hassan's AQI rose by 131.2%, averaging 106 during Deepavali compared to prefestival's AQI of 45. Pre-Deepavali, Mysuru recorded 40 and its threeday average was 68.Raichur, similarly, saw a significant jump, with AQI levels reaching

an average of 118, a 126.9% increase. Noise pollution levels also saw substantial increases. Basaveshwarnagar's Nisarga Bhavan recorded an 11.3% rise in ambient noise levels, with readings increasing from 73.1 decibels pre-Deepavali to 81.3

High global stakes in a bitter US election

difference between US Democrats and Republicans was like the contrast between Coke and Pepsi. Now, it seems both have lost the fizz and represent two conflicting worldviews and distinct approaches amid wildly differing expectations. The mild common effervescence is replaced by bitter froth. For voters in the US, the concerns are unemployment, inflation, immigration, disproportionate growth in income levels, and reproductive healthcare. Pollsters are busy projecting the future based on the way they gauge popular moods; betting syndicates ogle at their desired outcome. The US electorate grapples with this tug of war; the world waits for the outcome, and its implications for other regions and global geopolitics. West Asia has to be a priority of the US administration, given its share of 40 per cent in global oil exports and America's reliance on the region for oil security. West Asia plays a crucial role in balancing oil demand and supply globally. The issues of oil and regional security, the US relationship with Saudi Arabia and the repercussions of the Israel-Gaza conflict on the region are important. There seems to be uncertainty about who between Donald Trump and Kamala Harris can impact the situation in West Asia in a positive way, especially as dissatisfaction might grow if there is loss of territory in Gaza or West Bank. The other region that is likely to be impacted is Latin America, which has witnessed the growing influence of China. Earlier considered a preserve of the US, China's role in Latin America has grown rapidly, led by its state firms investing in the region's energy, infrastructure and space industries. China now ranks as South America's top trading partner, with free trade agreements with Chile, Costa Rica, Ecuador and Peru, and 21 Latin American countries signing the Belt and Road Initiative of China.China has invested about \$73 billion in Latin America's raw material sector, including by building refineries and processing plants in countries with significant amounts of coal, copper, natural gas, oil and uranium. China has also invested in lithium production in Argentina, Bolivia and Chile and financial ports, airports, highways and railway projects. What could be worrying for the US is China's concentration on building 'new infrastructure', such as artificial intelligence, cloud computing and 5G technology, and its strong bid to strengthen cooperation in the space sector.

For Latin America, the major issue is immigration, which is clearly on the rise as witnessed by the number of people detained at the border. The US administration's war on drugs also affects Latin American countries, which may not be producers, but serve as corridors for drug and human trafficking to the US. According to Colombian journalist Diana Duran, the US administration needs to realise the importance of Latin America for the US economy. The question of the US-Russia relationship came up during the presidential debate in September. What seems to bother the US is that after the breakup of the Soviet Union, there was hope that the new Russia would be liberal, democratic and helpful to its neighbours. The emergence of Russia, especially under Putin, as a country working to be a superpower has belied US expectations, turning potential cooperation into a possible conflict. While America cannot ignore Russia, the latter seems unconcerned about the US elections. According to some experts, Harris is relatively unknown to Russians. Although she is expected to continue the Biden approach, Trump is known to be a 'friend' and is preferred. Bob Woodward's latest book, War, refers to secret conversations between Trump and Putin, giving rise to the apprehensions that Trump might make concessions to Russia. This may help Russia in dealing with the Ukrainian crisis, besides adding to its growing importance in influencing global economy because of its energy resources, due to which it has been able to consolidate its position with many Asian and European countries despite

Landmark SC ruling targets menace of child marriage

Good looks, dictated by what should be the perfect colour, curves in all the right places and a certain oomph, do matter. In our appearance-obsessed society where women, and some men, work tirelessly to conform to an impossible idea of...

In a recent landmark ruling, the Supreme Court issued a slew of directives to the Centre and state governments to eradicate the social evil of child marriage. The court also ordered the creation of special police units to firmly address the evil.

However, the challenge is daunting. Child marriage is an age-old practice. Various social, cultural and economic factors came into play in the need to protect unmarried girls from foreign invaders. Hence, early marriage was preferred and it later became a rigid social custom. The problem was

further compounded by the dowry system. The fear of payment of a heavy dowry for the marriage of a girl after puberty made the practice common, particularly among the poor sections of society. In rural areas of some states, if the girl is not married before she is 17 years old, the entire family is ostracised.For the girl, early marriage leads to inadequate socialisation, discontinuation of education and great physiological damage owing to repeated pregnancies. Evidence shows that the maximum maternal deaths take place between 15 and 16 years, when a girl is unprepared for marriage.

Under the amended Child Marriage Restraint Act of 1978, the minimum legal marriageable age was raised to 18 years for women and 21 years for men from the original Act of 1929 that

provided for the marriageable age for girls at 14 and boys at 18. The Prohibition of Child Marriage Act, 2006, replaced the 1978 Act with the same minimum age limits. The Prohibition of Child Marriage (Amendment) Bill raised the age of marriage for females to 21 years. This Bill is yet to be passed. The Council for Social Development, New Delhi, conducted a study on child marriages in Rajasthan and Andhra Pradesh and concluded that this legislation remained a dead letter because of the prevalent social and religious customs, poor economic conditions and ineffective enforcement machinery. Hundreds of girls below 18 years are married on the occasion of Akshaya Tritiya in Rajasthan, Bihar, Andhra Pradesh and Tamil Nadu.A study conducted by the council for the Union Ministry of Social Welfare has dealt with the perception of women themselves on the issue of child marriage. Many women look at early marriage as protection against sexual molestation. Also, when a girl grows up, it is difficult to get a suitable match for her as the dowry demand also goes up. Further, child marriage is actually a betrothal, as the 'gauna' or real marriage takes place when the girl is much older. Discussions with women also reveal another negative side of the issue. Boys who marry young usually abandon their wives and get married again



when they grow older.

After a news report was published in an English daily that mass marriage would be solemnised in Rajasthan on April 29, 1998, on Akshaya Tritiya, the National Human Rights Commission (NHRC) issued a notice to the state Chief Secretary and called for a detailed report to know the action taken by the state government to prevent child marriages. It also sent a team to Rajasthan for an investigation. Senior officers visited Bikaner and Jodhpur and witnessed a number of child marriages being solemnised with fanfare, and without any objection from the authorities or the public. The commission pointed out to the state government that it was a statutory obligation on its part under the Child Marriage Restraint Act to prevent child marriages and take appropriate action in accordance with the

provisions of the Act. It called for a report from the Rajasthan Government on the prevalence of child marriages in the state. The NHRC also undertook a study of the Child Marriage Restraint Act and felt that some amendments to the Act were needed. As the offences under the Act are not cognisable, no arrest could be made without the order of the Judicial Magistrate. The commission felt that the Act had to be amended to make the offence cognisable, non-bailable and triable by the sessions court. Powers should be given to the Executive


Magistrate and police officers for the effective implementation of the Act.Sadly, the present situation regarding child marriages remains as horrifying and shameful. According to the UNICEF, one-third of the world's child brides live in India and nearly 23 per cent of young women in India are married before their 18th birthday. The states with the highest number of child marriages include Uttar Pradesh, Bihar, Madhya Pradesh, Maharashtra and West Bengal.

Economists, applying the law of demand and supply, have recommended that a reduction in the number of women would enhance their status. They should, however, look at the hard anthropological evidence, which shows that states in India with extremely adverse sex ratio, including Bihar, UP and Rajasthan, are notorious for crimes against women such as polyandry, gang-rape and dowry killings.

The Supreme Court, in its recent directives, ordered the appointment of child marriage prohibition officers at the district level. They would be responsible for the enforcement of laws protecting the affected children. The court has also called for the establishment of police units dedicated to prevent child marriage. This can be a gamechanger only if these units are adequately staffed and empowered. Often, it has been seen that such officers and special units have not been purposefully utilised.However, legal deterrents alone will not eliminate the scourge of child marriage. Social conscience needs to be stirred against this evil practice. Voluntary groups should be encouraged to mobilise public opinion and create an atmosphere of stern social disapproval of the traditional practice of child marriage.

two-pronged approach — targeting large drug networks alongside local peddlers — has yielded significant success, with seizures totalling 790 kg of heroin, 860 kg of

more impactful strategy would involve publicly exposing major traffickers and demolishing the notion of impunity associated with the trade. At the same time, the authorities need to strike at the threat of cross-border trafficking, which has intensified with the increasing use of drones to smuggle narcotics. This year alone, the Border Security Force (BSF) seized 183 drones along the Punjab border, a significant rise from 107 in 2023. These drones, primarily from Pakistan, represent a sophisticated smuggling method that demands stronger countermeasures, though the BSF has put in place some anti-drone systems. As Punjab battles this deeplyrooted crisis and tries to reclaim

communities from the grip of narcotics, a robust, multiagency collaboration is called for to reinforce border security and intercept such high-tech threats.

SAD faces a crisis of legitimacy

The party has been unable to comprehend concerns of the Sikhs and Punjab's agrarian economy

THE Shiromani Akali Dal (SAD) occupies a distinctive place in the history of India's regional and democratic politics. Born out of a popular movement in 1920, it is among the oldest political parties of the subcontinent. Over the past 104 years, it has confronted many challenges and seen many changes. From the Partition in 1947 to Punjab's reorganisation in the 1960s and the militant Khalistan movement of the 1980s, the SAD has been through many difficult times and survived.

Though its control over the SGPC remains, the SAD's appeal among the Sikh masses has been on the decline. Though a regional party that is also identified with the Sikh community, its leadership has often been at the forefront of articulating national-level concerns, particularly those related to questions of federal politics. It was also among the few political parties in India with a cadre base of jathedars and local-level organisations.

The SAD's distinctiveness also lay in the fact that it represented a range of interconnected interests and identities: the regional aspirations of Punjab; the representative face of the Sikh community; and the economic interests of the landowning agrarian class. As a regional paty, it has been the sole voice of Punjab.Likewise, though not all Sikhs have voted for the party, they have looked up to the SAD to be the institution that represents their sense of distinctive identity and interests - as a Panthic institution. Sikhs living outside Punjab, too, have had a sense of ethnic identification with the SAD. After the reorganisation of Punjab in 1966, the party also emerged as a custodian of agrarian interests, with its leadership positions being almost exclusively occupied by individuals coming from the agrarian, rich, landowning caste of the Jats. The success of the SAD leadership lay in its ability to cruise through these diverse axes of Punjab politics — region, community and class/caste — which helped it emerge as a regionally hegemonic actor. Even when its leadership chose to aggressively raise Panthic issues, it was hard to brand it as a communal or a sectarian party. Its electoral allies have ranged from local communist parties to the right-wing Bharatiya Jana Sangh and the BJP. The early generation of its leadership also worked from within, or alongside, the

Congress. Likewise, despite the narrow social base in terms of caste and class, it connected with all sections of the Sikh community. Even some non-Sikhsof Punjab have been voting for its candidates. The SAD has been a part of the mainstream political culture in yet another way. Like many other regional parties, it has recently seen a growing hold of one family, the Badals, and has been marred by internal schisms and factional divisions. Over the past 50 years, many of its senior leaders have left the party and formed offshoots of the SAD, often positioning themselves as the radical Panthic alternative. But rarely has their political appeal been lasting. It is mostly the mainstream outfit, led by the Badals for nearly three decades, that has continued to dominate.

However, that seems like old hat. The challenges that the SAD confronts today are unprecedented. With the growing hold of the Badal family, the party has seen an erosion of its cadre base and organisational structure. Though its control over the SGPC remains, its appeal among the Sikh masses has been on the decline. There has been a growing perception that the

SAD leadership has intentionally prioritised its electoral arithmetic over Panthic sentiments/issues. The victory of two 'radical' Sikhs in the 2024 Lok Sabha elections was a clear signal to the SAD that the common Sikhs no longer trusted it with their communitarian and religious concerns.

To broaden its electoral appeal, the Badals-led SAD has given up on being a Sikh-only party and opened up its



suggest that such a 'secular-regionalist' turn has found traction among the non-Sikhs of the state. On the contrary, its prolonged proximity to the Hindu nationalist party, the BJP, has only eroded its federalist credentials. Perhaps the biggest blow to its social and electoral base has come from its most secure social base, the rural-agrarian constituency. With a weakening cadre base, the SAD leadership

appears to have lost connect with the emerging crises of the agrarian economy.

This was visible during the year-long farmers' protest on the borders of the national capital against the three farm laws introduced by the Narendra Modi government. It was only when its leaders felt the heat due to the growing anger among Punjabi farmers that they raised objections to the Central laws. They had all along been party to the 'reforms' that the Modi

government had been working on. The party's decision to quit the NDA government could not restore the loss of trust. Interaction helps toddlers develop Language

Next time you read to your baby, pay attention to the babbling as interaction is the key to language development during reading, reveals a new study.

The researchers found that babies made more speech-like sounds during reading than when playing with puppets or toys. They also discovered mothers were more responsive to these types of sounds while reading to their children than during the other

activities. "A lot of research shows that book reading even to infants as young as six months of age is important to language outcomes, but I am trying to explain why by looking at the specifics, which could be responding to speech-like sounds," said study

co-author Julie Gros-Louis from University of Iowa in the US. "If we know what specific

interactions are occurring between care-giver and child and we can link that to language outcomes, then it would not just be telling parents, 'Read a lot of books to your kids,"" Gros-Louis added.

The study looked at how mothers responded to their 12-month-olds during book reading, puppet play, and

Researchers observed the interactions of 34 mothers and their 12-month-olds during three 10-minute periods of



different activities: puppet play, toy play, and book reading.

The babies were seated in a high chair to control proximity to their mothers and to prevent them from getting up and moving around the play room.

The study also found that no matter the context, mothers' responses to speechlike sounds were often imitations or an expansion of the sound.

"The current findings can contribute to understanding how reading to preverbal infants is associated with language outcomes, which is not well understood in contrast to reading interactions with older toddlers," according to the study.

UP Madarsa Education Act valid, Supreme Court says High Court erred in order

► A bench comprising Chief Justice of India DY Chandracuhd, and Justices JB Pardiwala and Manoj Misra gave the verdict against the High Court's March 22 judgement striking down the Madarsa Education Act 2004 as "unconstitutional".

madarsa students in Uttar Pradesh, the Supreme Court on Tuesday upheld the constitutional validity of the Madarsa Education Act 2004, cancelling the Allahabad High Court order that struck down the law on grounds that it violated the principles of secularism.A bench comprising Chief Justice of India DY Chandrachud, and Justices JB Pardiwala and Manoj Misra gave the verdict against the High Court's March 22 judgement that declared the Act as "unconstitutional" and violative of the principle of secularism. The High Court had also asked the Uttar Pradesh government to accommodate madarsa students in the formal schooling system.

During the hearing on Tuesday, the Supreme Court bench said, "We have upheld the validity of UP Madarsa Education Act. The statute can be struck down if a state lacks legislative competence.""The Allahabad High Court erred in holding that the madarsa law had to be struck down for violating basic structure, which is the principle of secularism. The legislative scheme of the Uttar Pradesh Board of Madarsa Education Act was to standardise the level of



education being prescribed in madrasas," it added. The Supreme Court further said that madarsas granting 'fazil' and 'kamil' degrees beyond class 12 cannot be recognised by the Uttar Pradesh Madarsa Board as these are in conflict with the UGC Act and to that extent it was unconstitutional. Tuesday's ruling means that madarsas would continue to function in Uttar Pradesh with the state regulating the education standards. The Supreme Court further said that the Act does not interfere with the day-to-day working of the madrasas."The Act is to protect the rights of a minority in Uttar Pradesh and is consistent with the positive Among the recognised madarsas, 560 are funded

by the Uttar Pradesh government.Before its verdict today, the Chief Justice-led bench heard a number of lawyers on behalf of eight petitioners, including Anjum Kadari, besides Additional Solicitor General KM Natraj, who appeared for the Uttar Pradesh government, for almost two days. On October 22, the Supreme Court reserved its judgement on the Allahabad High Court order. The top court emphasised that "secularism means to live and let live" and also highlighed the importance of accommodating diverse religious instruction in education. New Delhi:Not all privately owned properties qualify as community resources that the State can take over for the common good, the Supreme Court said in a landmark verdict today. The ninejudge Constitution bench led by Chief Justice of India DY Chandrachud delivered the judgment on the vexed issue with an 8-1 majority.

Three judgments were authored -- the Chief Justice wrote one for himself and six colleagues, Justice BV Nagarathna wrote a concurrent but separate judgment and Justice Sudhanshu Dhulia dissented. The judges on the bench were Chief Justice DY Chandrachud, Justice Hrishikesh Roy, Justice Nagarathna BV, Justice Sudhanshu Dhulia, Justice JB Pardiwala, Justice Manoj Misra, Justice Rajesh Bindal, Justice SC Sharma and Justice AG Masih.

The case relates to Article 31C of the Constitution that protects laws made by the State to fulfill directive principles of state policy -- guidelines the Constitution lays down for governments to follow while making laws and policies. Among the laws that Article 31C protects is Article 39B. Article 39B lays down that the State shall direct its policy towards ensuring that the ownership and control of the material resources of the community are so distributed as best to subserve

On this, the Chief Justice remarked, "Does material resource of a community used in 39B include privately owned resources? Theoretically, the answer is yes, the phrase may include privately owned resources. However, this court is unable to subscribe itself to the minority view of Justice Iyer in Ranganath Reddy. We hold that not every resource owned by an individual can be considered a material resource of a community only because it meets the qualifier of material needs.""The enquiry about the resource in question falls under 39B must be contest-specific and subject to a non-exhaustive list of factors such as nature of resource, the characteristics, the impact of the resource on well-being of the community, the scarcity of resource and consequences of such a resource being concentrated in the hands of private players, the public trust doctrine evolved by this court may also help identify resources which fall under the ambit of material resource of a community," he

In 1977, a seven-judge bench had ruled with a 4:3 majority that all privately owned property did not fall within the ambit of material resources of the community. In a minority opinion, however, Justice Krishna Iyer held that both public and private resources fell within the ambit of 'material resources of the community" under Article 39(b).In her separate judgment, Justice Nagarathna disagreed with the Chief Justice on his observations on the ruling by Justice Iyer.

"Can We Castigate...": An Objection To Chief Justice's Remark On Past Judge

New Delhi: Judges should be mindful of not castigating past judges only because they reached a different outcome while deciding a case, Justice BV Nagarathna said today. The remark was made as the Supreme Court ruled that all privately owned property does not qualify as community resources that the State can take over for the common good.

The landmark verdict was delivered by a nine-judge Constitution bench led by Chief Justice of India DY Chandrachud and comprising Justice Hrishikesh Roy, Justice Nagarathna BV, Justice Sudhanshu Dhulia, Justice JB Pardiwala, Justice Manoi Misra, Justice Rajesh Bindal, Justice SC Sharma and Justice AG Masih. The bench passed the ruling with an 8-1 majority. Three judgments were authored -- the Chief Justice wrote one for himself and six colleagues, Justice BV Nagarathna wrote a concurrent but separate judgment and Justice Sudhanshu Dhulia dissented. One of the past verdicts referred to extensively during today's judgment was the 1977 ruling in the State of Karnataka vs Ranganath Reddy case. This case addressed the issue of nationalisation of private transport companies and the extent to which the State can intervene in private enterprises. The matter had come up when the then Karnataka government brought a law to nationalise private bus services. A seven-judge bench had then ruled with a 4-3 majoritythat all private property did not fall within the ambit of material resources of the community. Justice VR Krishna Iyer, one of the judges in the minority, had contended that both public and private resources fell within the ambit of "material resources of the community" under Article 39(b) of the Constitution.

We have been guided by the thought that an all-too-large gap between the law and public needs, arising out of narrow notions, must be bridged by broadening the constitutional concepts to suit the changing social consciousness of the emerging Welfare State. Institutional crises and confrontations can be and should be avoided by evolving a progressive interpretation, discarding over-sensitivity to under-valuation when private property is taken for public good," Justice Iyer

Upcoming Wedding Season Will Generate 6 Lakh Crore Business: Traders' Body

New Delhi: The upcoming wedding season in India which will extend from November 12 till December 16 is likely to generate business worth nearly ₹ 6 lakh crore from 48 lakh weddings which constitutes a 41 per cent increase over the corresponding figure of ₹ 4.25 lakh crore recorded for 35 lakh weddings last year, according to a study carried out by the Confederation of All India Traders (CAIT).

From 11 auspicious dates the previous year, this year's season would have 18 dates which is expected to fuel the business growth, with Delhi alone expected to see ₹ 1.5 lakh crore business across 4.5 lakh weddings this year, estimates compiled by CAIT show.CAIT estimates 10 lakh weddings involving spending of ₹ 3 lakh per wedding, 10 lakh weddings with ₹6 lakh per wedding, 10 lakh weddings with ₹ 10 lakh per wedding, 10 lakh weddings with ₹ 15 lakh per wedding, 7 lakh



weddings with ₹ 25 lakh per wedding, 50,000 weddings with ₹ 50 lakh per wedding, and 50,000 weddings with ₹ 1 crore or more per wedding.CAIT's Veda and Spiritual Committee convenor Acharya Durgesh Tare said the auspicious wedding dates for this season are November 12, 13, 17, 18, 22, 23, 25, 26, 28, and 29 and December 4, 5, 9, 10, 11, 14, 15, and 16. Following this period, there will be a pause of about a month before the season resumes from mid-January to March 2025.

Dear parents, you may have to stop favouring your child in every situation, as according to a study, mothers supporting their child's negative emotions may impact their social adjustment and social interaction in school.

According to a study, mothers, who are more supportive of their children's negative emotions, rate their children as being more socially skilled and these same children appear less socially adjusted when rated by teachers.

Specifically, mothers' supportive reactions predicted fewer socio-



emotional skills and more behaviour problems, according to children's thirdgrade teachers.

These contrasting patterns suggest a potential downside to mothers' supportiveness of children's negative



emotions for third-grade children's social adjustment in school.

Co-author of the study Dr. Vanessa Castro said that it's not clear, if the parents are causing these problems by hovering or providing too much support when less support is needed or if the parents are rightfully providing more support because their children are experiencing these social and emotional problems, or if the children are exhibiting very different emotional and social behaviors at home than they are at

The researchers found that people who reported having even a few close friends or family members to talk to outside of their marriage experienced lower levels of stress when marital conflicts arose."Even everyday conflict takes a toll on people physiologically," Neff said.

"But we found that the association between marital conflict and cortisol responses completely disappears when people are happy and satisfied with their available social network,"

NEW DELHI. Benchmark stock market indices opened the trading session on a weak note on Tuesday as investors remained cautious ahead of the US presidential elections. The S&P BSE Sensex was down 125.73 points to 78,656.51 at 10:17 am, while the NSE Nifty50 fell 36.20 points to trade at 23,959.15 points.All the other broader market indices were trading in negative territory as volatility remains on the higher side. Nifty Metal was the only significant gainer among sectoral indices, while some auto stocks also gained. The top five gainers on the Nifty50 were Tata Steel, IndusInd Bank, JSW Steel, Tata Motors and Maruti.

On the other hand, the top losers were Adani Ports, Trent, HDFC Life, Apollo Hospitals and ITC.

While US elections have kept Indian stock markets on the edge, experts believe there are other domestic factors at play as well.Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said, "With all attention focused on the outcome of the US presidential election, perhaps the more important domestic economic issue is not getting the importance it deserves." It is important to understand that India's underperformance is striking: while S&P 500 is up 20.45% YTD Nifty is up by only 10.36% YTD. Clearly, domestic issues are weighing on markets. With two thirds of Nifty 50. are weighing on markets. New Delhi With wedding bells ringing across the country, Maruti Suzuki India is revving up its engines for what it hopes will be a bumper month of sales.fter a record-breaking October, where the company clocked in retail sales of 202,402 units—the highest for any October—Maruti is betting that the wedding season in starting November will keep the momentum going. "We are made to understand that some 'few lakhs' marriages are being planned across the country (in November). So we are pretty

hopeful that it will also give us good traction in terms of our retail sales," Partho Banerjee, Senior Executive Officer of Marketing and Sales, told news agency PTI.With a wedding season that looks to be packed, Maruti is counting on those joyful celebrations to translate into car sales.Banerjee noted that this November is could have an alltime high of about 11 or 12 wedding days. "We are hopeful that in November, since so many marriages are there, the momentum will carry and that's what we are looking forward to," he added.

The festive season already provided a much-needed boost, and Maruti Suzuki is optimistic about maintaining its growth trajectory of 4-5% for the current fiscal year. The company reported a cumulative growth of 4% from April to October, with a stellar 22.4% growth in October alone. If this wedding season proves fruitful, Maruti could be cruising towards a solid

finish for the year. In the wake of the robust October sales, Maruti has also trimmed inventory levels significantly—by over 40,000 units. Their network stock is now comfortably around one month, a far cry from the overflowing lots of the past. "We have corrected our network stock by more than 40,000 units. We calibrated our production supplies, and now our network stock is almost one month. We

have been able to bring network stock to 30 days," Banerjee explained.

On the subject of discounts, Maruti has adopted a more personalised approach, allowing regional teams to determine pricing strategies based on local demand. "What we have done is that we have made it very marketspecific. Now we are not controlling it from the head office. We have allowed our field team to take the calls based on the market needs as each market behaves in a

different way. We need to respect the customer's viewpoint, and accordingly, we need to act actually," he said. As for potential price hikes in January, Banerjee hinted, "Our finance team is examining that, but it's too early to comment." Pay 250 million dollar quickly: Adani to Bangladesh

NEW DELHI: Amid delay in payment of dues by the Bangladesh government, it is said that an immediate payment of \$200-250 million is crucial for Adani Power continuing with power supply to the government.

Sources said ahead of the November 7 deadline, the government has fast-tracked the payment of the outstanding dues. Quoting a Bangladeshi official, news agency Reuters has said the country has cleared \$96 million last month and opened a credit line of \$170 million.Sources told TNIE the

Bangladesh government owes Adani Power about \$900 million, which is due since April this year. Of the \$900 million, \$840 million is the amount due for power supplies and \$170 million for an additional credit line opened by the government this month. As per company sources, Adani Power immediately needs money to procure coal from Australia for its ultra-supercritical power project at Godda



that supplies electricity to Bangladesh. The sources said that since the Godda power project is ultra-supercritical, coal for the same is not available in India, and Adani Power needs to import the coal either from Australia or Indonesia. Though Adani Group owns coal mines in Australia's Carmichael Project and is transported to India as well, sources said that coal is not enough for supplies to the Godda

In November 2017, Bangladesh Power Development Board (BPDB) executed a long-term Power Purchase Agreement (PPA) with APL's wholly-owned subsidiary Adani Power Jharkhand Limited (APJL) to procure 1,496 MW net capacity power from 2X800 MW ultra-supercritical power project at Godda.Adani is expected to commission its second 800 MW unit soon.Bangladesh has been facing a serious shortage of dollars since 2022 due to high crude oil prices after the Russian attack on Ukraine. The situation

aggravated after the political turmoil that broke out in the country leading to the ouster of former prime minister Sheikh Hasina on 5 August this year.

Adani sources said that the interim government has been trying to make the payment but has been struggling due to dollar shortage. Bangladesh's forex reserves have fallen to less than \$20 billion at the end of September 2024.

Sebi asks Embassy REIT to sack CEO Aravind Maiya for 'harming' Coffee Day investors

This follows the findings by the National Financial Reporting Authority (NFRA) of serious lapses and gross negligence leading to market fraud by Maiya

MUMBAI. Market regulator Sebi has ordered Embassy REIT's manager to immediately sack its CEO Aravind Maiya for "harming ordinary investors" of Coffee Day and also appoint an interim CEO in his place. This follows the findings by the National Financial Reporting Authority (NFRA) of serious lapses and gross negligence leading to market fraud by Maiya while leading the statutory auditors of Coffee Day Enterprises during FY19 as their engagement partner.Embassy Office Parks Management Services is the manager of Embassy REIT, which is owned by the Embassy Group of Jitu

Virwani, whose commercial tenants include IBM, Microsoft, Fidelity, TCS, Rolls Royce, Mercedes Benz, Yahoo, Goldman Sachs and Swiss Re. Embassy Office Parks REIT is the first listed REIT in the country and the largest office REIT in Asia by area.

Sebi said Maiya was debarred for the maximum permissible period by the NFRA.Sebi had passed an order on Coffee Day in January 2023, in which it noted that Rs 3,535 crore was transferred from Coffee Day's subsidiaries to its related party, Mysore Amalgamated Coffee Estates, without obtaining

the necessary approvals from the board of directors or the audit committee. There were other violations too, such as the non-disclosure of material subsidiaries leading to glaring audit omissions, failure to maintain adequate internal controls over its finance functions, and failure to carry out adequate due diligence and exercise independent judgment, the Sebi order said. All of this resulted in the diversion of Coffee Day's funds for the benefit of promoter entities. During Sebi's investigations, it was revealed that the statutory auditor had a role in facilitating the fraud. Taking note of Sebi's observations, the NFRA started



its investigations and passed an order in August 2024. The NFRA order, The order notes that Sebi had according to Sebi, "brings out knowing violations of applicable audit norms which failed to flag a massive fraud at a listed company while Maiya was in a special position to discern given his professional assignment and domain knowledge."The interim order passed by whole-time member Ashwani Bhatia further said, "The order also leads to a

reasonable inference that Maiya failed to act in public interest. Instead, he acted in a manner that harmed ordinary investors and shareholders."The order said, "The NFRA order raises sufficient

doubt regarding Maiya's competence, ethical behaviour and reputation to warrant disqualification under clause 3 of schedule II of the intermediaries regulations, at least till his name is cleared at an appellate forum, by way of overturning or stay of the NFRA order."

The market regulator's latest order also raises concerns around the conduct of Embassy REIT's manager, Embassy Office Parks

Management Services. communicated several times with Embassy REIT's manager that Maiya was ineligible to continue in his post. But it refused to replace him.

As the Sebi order notes, "It is a matter of concern that irrespective of e-mails, meetings and a specific instructions in this regard, the manager has tried all means to retain Maiya as CEO."

Former Australian wicketkeeper Ian Healy sharply criticized Australia's poor batting in their first ODI against Pakistan at the MCG, where they scraped a twowicket win, chasing 204 in 33.3

New Delhi Former Australian wicketkeeper Ian Healy slammed Australia's unconvincing batting performance in their opening ODI against Pakistan at the Melbourne Cricket Ground (MCG). Despite securing a two-wicket win and chasing down Pakistan's modest target of 204, Healy expressed frustration at Australia's approach, calling it "schoolyard cricket.""We have a lot to learn," Healy stated on SENQ, highlighting that Australia's preparation for the Champions Trophy is running out of time. "We're gearing up for the Champions Trophy, so there aren't many opportunities left before a final team has to be selected. We should be playing these games properly, but



schoolyard."Australia managed to achieve the target in just 33.3 overs, but Healy was unimpressed, pointing out their lack of discipline. "The disregard for conditions was unacceptable," Healy said, referencing the unpredictable pitch, which bowlers like Mitch Starc noted was two-paced with uneven bounce. "So what do we do? We try to slog the Pakistani bowlers all over the place. The batters didn't learn anything from what the bowlers told them; they didn't respect the opposition enough."Healy also emphasized how Pakistan's bowlers, led by Haris Rauf, gained momentum as Australia

faltered, underscoring his frustration with what he called "the Australian boys' egos." Healy insisted that they couldn't "set aside [their egos] for even half an hour."

Pat Cummins, Australia's skipper, emerged as the hero, steadying the chase with a calm 32 off 31 balls. Coming to the crease at 155 for 7, Cummins managed the final stages with his trademark composure, adding to his record of clutch performances. Together with tailender Mitchell Starc, he led Australia to victory, hitting the winning runs in the 34th over. Cummins also shone with the ball, claiming two wickets and demonstrating his all-round skill. Starc was

Pakistan's openers and finishing with figures of 3-42, setting the tone in the first innings.

Pakistan's innings had mixed fortunes, as they stumbled early with Saim Ayub and Abdullah Shafique falling cheaply to Starc. Captain Mohammad Rizwan led the scoring with 44, while Babar Azam, returning after missing key Tests, added 37 before a mistimed shot saw him bowled by Adam Zampa. Late contributions from Naseem Shah (40) and Shaheen Afridi (24) pushed Pakistan past 200. Australia's chase, however, stumbled. Openers Matt Short and Jake Fraser-McGurk failed to capitalize, while Steve Smith (44) and Josh Inglis (49) added stability before Pakistan's Rauf triggered a collapse, dismissing Marnus Labuschagne and Glenn Maxwell in successive balls. With Australia teetering, Cummins took control, guiding them home.

The victory secured a 1-0 lead in the threematch series, yet Healy's comments underscore the need for improvement. "Inglis and Smith showed restraint, and then Pat Cummins had to as well," Healy remarked, stressing that the team must bring more respect and focus in the upcoming matches. The series will continue with the second ODI in Adelaide on Friday, followed by the final ODI in Perth on Sunday, before concluding with three T20 matches.

With key players missing, Guardiola knows that maintaining the high standards fans expect may be out of reach."I know our standards, but we've only lost one game," Guardiola said on Monday. "We could lose again in the Premier League against Brighton, Tottenham, or Liverpool," he said, acknowledging the calibre of their



upcoming opponents. City currently trail Liverpool by two points in the league. Despite a strong start in the Champions League, Guardiola warned that this season would be tougher, given the injuries plaguing the squad. "Sometimes, to win the treble, everything has to align perfectly. This season, it hasn't," he said, underscoring the

importance of an injury-free roster for success at the highest levels. City will be missing Ballon d'Or winner Rodrigo and emerging talent Oscar Bobb for an Kohli's major records in international cricket extended period, while John Stones, Jack Grealish, and Ruben Dias are also sidelined and will not make the trip to Portugal. Manuel Akanji, Nathan Âke, and Kyle Walker, though in the squad, are nursing various fitness issues. Legendary India cricketer Sunil Gavaskar in an exclusive conversation with India Today, dissected India's series loss against New Zealand and the spoke about the future of senior players.

New Delhi. Legendary India cricketer Sunil Gavaskar in an exclusive conversation with India Today dissected India's 0-3 whitewash against New Zealand on home soil. The Rohit Sharma-led side faced a shambolic 0-3 series loss for the first time in their Test history which has posed several questions on the current lot of players and the team management.

Reflecting on India's loss, Gavaskar delved deep into the technical shortcomings of the Indian batters, future of batting stars Virat Kohli and Rohit Sharma and also shared his

prediction for the upcoming Border Gavaskar Trophy. Here's the full excerpt from the interview:Is this a new low for the Indian team?"It is a new low because of the way this Indian cricket team has been performing at home over the last so many years. Over the last so many years they have come back from behind. They've won matches against England and Australia, who have always been thought of as being even better and sterner opponents than what New Zealand could be. And that is the reason why, you know, this was totally unexpected, against Australia against England, one could have said, yeah, they've got, they've got the team, they've got the players. But against this New Zealand team, therefore, it was not expected that India would lose all three test matches," said Gavaskar.

Collective failure of batting brought the downfall

"I think it's a failure of the batting. Everybody, you know, literally, I think, struggled with the bat on pitches where there was help for



the bowlers. So I think that was probably the main reason the batters didn't score enough runs, particularly in Pune and in Mumbai,' Gavaskar told India Today.

Impact of white-ball cricket on Test batting

Yes, I think it's been a situation ever since the White ball game has come in. The white ball game encourages batters to play with hard hands, where you're looking to push at the ball to get the ball away. Now on pitches where the ball is doing something, whether it is seam swing turn, I think you need to be playing with at least one soft hand, if not two

soft hands. And therefore you know that bat speed, which can be then controlled, where the edges, which are now going to the slip fielders would fall just a little short if you played with soft hands. So it's the bat speed that has been the cause, because India is now playing a lot more of the white ball game than test matches," he added.

Need to use the feet effectively vs spinners

'Yes step out and get to the pitch of the ball and drive. I know Ian Chappell used to say the sweep is played by batters, the regular orthodox sweep is played by batters who who can't use their feet. And it's just like, you know, get out of jail kind of shot if it comes out great. If it doesn't come out, you're, you know, backpack in the pavilion. So, while the reverse sweep was not very much in fashion during our time when it is played well, I think it is one of the finest shots that one can see. I really love watching the reverse sweep being played by being played properly. You know, whether it's hit in the air and into the stands or the way they control it with the.
