"Even a US under Donald Trump will make a distinction in immigration and mobility - that for them economically justified mobility will have to be fostered, while those where the economic value is less or neg-

ative will have to be managed," Jaishankar said at a roundtable with CEOs in Sydney, Australia. These trends are part of a move towards a more integrated global workplace, Jaishankar said, pointing out that India itself is home to 1,800 global capability centres that generate exports worth \$150 billion.

restore Delhi Ridge?

New Delhi, Nov 07: The Supreme Court on Thursday asked the DDA about the measures undertaken to restore the Delhi Ridge area, where several hundred trees were allegedly felled illegally, and sought the extent of plantation done by the authorities. Observing it would introduce a monitoring system to ensure planted trees were surviving, a bench of Chief Justice D Y Chandrachud and Justices I B Pardiwala and Manoj Misra wondered if any independent mechanism was in place to ascertain the number of trees planted. Saying it would pass necessary directions on October 8, the top court asked the DDA counsel and the petitioner to inform it about the status of trees felled, consequential actions and the monitoring mechanism. It has been divided into four zones south, south-central, central and north for administrative reasons. These four zones make up a total area of around 7,784 hectares. The bench was dealing with a plea seeking action against erring officials for the alleged illegal tree felling in the area. "What are you doing to restore the ridge?" asked the bench, adding, "We want to know how many trees were cut and what is being done to restore the eidge and carry out afforestation."

MEA flags threat to Indian diplomats in Canada

No physical education teachers in over 50 per cent govt schools in Dindigul district

DINDIGUL: Of the 170 government higher secondary schools in Dindigul district, 93 lack physical education teachers while 30 schools have no playgrounds, an RTI reply revealed.Dindigul district is divided into 15 education divisions - Atoor, Bathlagundu, Dindigul City, Dindigul Rural, Kuzhiyamparai, Kodaikanal, Natham, Nilakottai, Ottanchatram, Palani Rural, Rediyar Chatram, Shanarpatti, Thomppampatti, Vadamadurai, Vedasandur.

Speaking to TNIE, RTI activist K Rathispandian said, "When the Chief Minister's Trophy Games 2024 were held, there was poor response from the schools which lacked physical education teachers and playgrounds. There are many government lands available in the villages near the government schools.

About 1-3 acres of land is enough for sports training. But, the education department and headmasters have not taken any steps to help the students. Many schools do not have a physical education period either.I do not know why the education department does not care about the importance of physical education, as it promotes fitness, overall health and well-being. Lack of physical education during school hours causes potential friction among students and paves the way for low self-esteem."An official from the district education department said, "Many parents and students are upset with the issue. Besides, there is no space available in most of the schools for playgrounds.

These are long pending issues and we have informed our superiors. The vacancies will be filled based on deputations and transfers. We are using the help from the district sports office to conduct various sporting events."

New parameters to test liquor quality soon

VIJAYAWADA: Excise and Prohibition Minister Kollu Ravindra has said the State government will introduce new standards and procedures to ensure the quality of liquor.As many as 13 parameters will be introduced to test the blending, and extraneutral alcohol and gas chromatography tests will be made available at the regional excise laboratories in Visakhapatnam, Guntur, Chittoor, Kurnool and Kakinada to ensure that all types of liquor is tested as per the guidelines and regulations of the Bureau of Indian Standards (BIS) and the Food Safety and Standards Authority of India (FSSAI).In an official release on Wednesday, Excise Minister Kollu Ravindra said the existing testing process, which is limited to testing only extra-neutral alcohol (ENA) based on six parameters, will be modernised and more quality parameters will be added.

Until now, regional excise laboratories used to test extra-neutral alcoholbased on basic parameters such as ethyl alcohol, acidity, aldehydes, methanol and water content. Till now Indian Made Foreign Liquor (IMFL) used to be tested before bottling, and alcohol strength (percentage) was the only parameter. "From now onwards, the government will make comprehensive changes in the system, adopting advanced technology, and will conduct a few more tests to ensure the quality of liquor," he explainedAs part of modernisation of the system, 13 parameters have been set for testing ENA, and nine parameters for testing blended liquor such as whisky, brandy, vodka and gin before bottling. "The new quality standards will help prevent chemical reaction," he added.

Food poisoning case reported at Mancherial Tribal Welfare Girls' School, 12 students hospitalised

ADILABAD: While the food poisoning incident at the Wankidi Tribal Welfare Girls' Residential School is yet to fade from memory, a fresh case has now been reported from the Tribal Welfare Girls' Residential School (Ashram school) in Mancherial district. Twelve Class 10 students reportedly experienced vomiting and stomach pain after eating breakfast in the hostel mess on Wednesday. The school staff shifted the affected students to a Mancherial hospital for treatment. Doctors said that all students were in stable condition, according to Mancherial Collector Kumar Deepak.

The district collector visited the hospital, interacted with the students, and discussed their health condition with the doctors. He confirmed that food safety officials collected samples of the food and water served at the school and sent them to a laboratory for analysis. A medical camp was also set up at the school to treat other students exhibiting similar symptoms

The collector asserted that purified drinking water is supplied through an RO plant at the school. Additionally, samples of pickles brought by students from home have been sent for testing. In the Wankidi Mandal Tribal Welfare Girls' Residential School, the recent food poisoning incident led to the hospitalisation of 78 students, of whom 10 are still receiving treatment at various hospitals, including the Nizam's Institute of Medical Sciences (NIMS), Hyderabad. Three students remain at NIMS, and four more were transferred there on Wednesday for better care. Three others are being treated in Mancherial.

Ration shops in Kerala on the brink of closure as govt commissions fail to cover expenses

KOCHI: ARD-1, the first fair price shop (FPS) in Changanassery taluk, shut down on March 31, 2023, marking the end of an era. Established when rationing began in Kerala, this FPS in Kurishumoodu was operated by Joseph Kunju's family for decades. Kunju's children urged him to close the shop to curb losses. Now dependent on them for livelihood, Kunju reflects, "Leaving my lifelong career was painful, but dwindling returns and rising operational costs made running the shop unsustainable."Kunju's story echoes the plight of FPS dealers statewide, highlighting the challenges facing this once-essential institution. This isn't an isolated case. Many FPSs, or ration shops as they are known commonly, once vital in feeding thousands, now struggle to sustain themselves.Government commissions fail to cover expenses and delayed payments add to the woes, according to the Kerala State Retail Ration Dealers' Association, the umbrella organisation of FPS dealers. High wages and rent are dealing a heavy blow, says association president G Krishnaprasad. This sentiment is echoed by many dealers struggling to make ends

meet. Unless the commission paid to dealers is significantly increased, many FPS owners may be forced to shut down their shops, he adds. The association estimates that more than 150 shops have downed shutters in the recent past.

N Shijeer, the organising secretary of the association, told TNIE that the current commission structure for FPS was formulated in 2018, when electronic point of sale (E-PoS) machines were introduced, and has remained unchanged since."The existing structure ensures a monthly commission of Rs 18,000 for selling 45 quintals of foodgrain," Shijeer explains. "This comprises Rs 8,500 in government support and Rs 220 per quintal."Despite repeated requests, the commission structure has not been revised in the last six years, he says. For shops selling above 45 quintals, the additional income works out to Rs 180 per quintal. While there are some shops in Wayanad and Malappuram, which have more than 2,000 rations cards, a majority of the FPSs in the state have 200 to 300 cards on average. Shijeer points out that the



payments are often delayed for months, putting the dealers under severe stress. Food and Civil Supplies Minister G R Anil acknowledges that there are payment delays and issues affecting dealers. He avers the government is working to address these problems. To improve the financial viability of FPS owners, the government is upgrading FPS into K-stores, which will provide better returns, he says. "According to a study conducted by the department, around 2,000 FPSs face difficulties due to income crises, but some shops with over 2,500 cards earn more than Rs 1 lakh in commission. The government recognises

Kerala's high standard of living and aspirations, but notes that increasing commission payments for FPS owners is constrained by the fact that the public distribution system (PDS) is a service,' Anil says. To enhance earnings for FPS dealers, the government plans to introduce additional services, such as retailing bottled drinking water, which can generate good commissions, the minister points out.

'A further expansion of services under FPS aims to ensure that dealers receive decent returns," he adds.Policy experts point out that before moving to a targeted PDS system in 1997, Kerala was recognised for having the best PDS in the nation, catering to almost all of its citizens and making a significant impact on nutrition.

A drastic reduction of the above poverty line (APL) subsidy led to these households leaving the PDS, shrinking the customer base of ration shops and leading many of them to closure. Computerisation of the system also dealt a blow to the FPS operators as it reduced the scope for the diversion of grains into the black market.

Eluru police launch Abhaya App

Initiative aims to provide a platform to women to report crimes anonymously

VIJAYAWADA: In a major step towards improving women's safety, the Eluru district police launched a mobile application named 'Abhaya' on 🚂 Wednesday. The app aims to provide a safe and secure environment for women across the district. Speaking at the launch, District Superintendent of Police (SP) K Pratap Shiva Kishore emphasised that the Abhaya initiative represents a significant commitment by the police to protect women and prevent violence against them. SP Kishore praised the contributions of women in the police force, calling them the 'real heroes' and citing Kiran Bedi, India's first female Indian Police Service (IPS) officer, as a key inspiration for the programme. According to the SP, the app was developed to act as a 'beacon of hope and protection,' especially in emergency situations. "Through this app, women can find critical resources and support when they face threatening situations," he said. "Our aim is to create an environment



where women can feel safe and are assured that the police are there to protect them." The Abhaya app allows women to report crimes or incidents anonymously, offering a layer of confidentiality to encourage more women to come forward. An online form available https://formurl.com/to/abhaya allows women to report incidents directly to the police, ensuring a quick response under the SP's direct supervision. "Often,

women hesitate to report incidents due to fear of backlash or further problems," he explained. "The anonymity feature removes this barrier, enabling more women to come forward without hesitation."For additional support, a dedicated helpline number, 9550351100, has been set up for women in distress. The SP also highlighted the key role of Village Women Protection Secretaries in the initiative.

These officers maintain close connections with local communities, enabling them to gather information quickly and relay it to police authorities. This ground-level support is crucial for proactive crime prevention, SP Kishore noted. To strengthen the initiative, the SP encouraged female officers to take on active roles in police stations. "We want women officers to listen to complainants with respect and respond promptly. We're also creating opportunities for women to serve as writers in police stations, helping them grow professionally," he said.

Limited resources at Jangaon government hospital affect quality patient care



JANGAON: The absence of facilities and staff shortage at the Jangaon District Government Hospital has reportedly affected the ability of doctors and other healthcare staff to provide quality care to patients. In the meantime, private diagnostic centres in the town are of essential equipment in the government hospital.Recently, with the announcement of a government medical college in the

district, the existing government hospital

was converted into a teaching hospital. Sources said that for the past seven years, the CT scan room and other laboratories have been locked. Due to inadequate funding, severe staff shortages and a lack of essential equipment, the hospital is now on the brink of closure, the sources added. capitalising on the gap created by the lack Despite these conditions, poor patients from remote villages continue to seek treatment at the Jangaon District Government Hospital. With the CT scanner out of order, doctors are referring patients to

government hospital currently provides only basic first aid to accident victims. Patients are advised to go to hospitals in Hyderabad, including OGH and Gandhi, or other private facilities for emergency treatment. This entails a journey of at least 90 kilometres, taking around three hours. Ambulances with ventilator support charge approximately '15,000 for a oneway trip. The government hospital treats between 600 and 700 outpatients daily and has inpatient services with 125 beds. 10 trolleys to help carry transformers faster after faults

Noida. The power department has received approval to acquire 10 new transformer trolleys, supplementing the district's existing four. These trolleys are crucial for efficiently replacing and installing new transformers of up to 400 kVA capacity during breakdowns or malfunctions. Incidents of transformer overheating and burning increase during peak summer months, often taking up to 5-6 hours to resolve. However, the additional trolleys are expected to reduce repair time to just a couple of hours. In cases of supply disruption, these mobile transformers can provide temporary power until permanent repairs are completed.

The district has over 10,000 transformers across urban and rural areas, with around 4-5 breakdowns reported weekly during peak summer. According to Harish Bansal, chief engineer of the Noida power department (PVVNL), the department sought 10 new trolleys to ensure uninterrupted power for consumers. "This will help provide an uninterrupted supply in case of transformer breakdowns or replacements," he said.

A power department official highlighted the frequent summer breakdowns, explaining, "On average, four to five cases of transformer blowouts are reported weekly. Replacing a single transformer typically takes at least two to three hours and can extend up to five or six hours, causing extended power cuts." Officials also noted that the district's 10,000 transformers include around 7,000 in urban areas and about 6,000 in rural areas, including Greater Noida. Rural areas often rely on smaller transformers, typically 25 and 16 kVA, especially those connected to tubewell systems.

With the new trolleys, officials anticipate faster responses to overloads and heating issues, ensuring quicker power restoration during high-demand summer periods.

YEIDA to hire co to help identify investors for medical device park

Noida. YEIDA is planning to hire a consultant for its medical device park. The consultant will be responsible for monitoring the project, identifying potential investors, conducting meetings, providing

knowledge support, and ensuring progress.

Spread over 350 acres in Sector 28 off the Yamuna Expressway, the park is being billed as north India's first such facility. It is conceptualised to address key concerns of manufacturers, access to cost-effective testing and scientific facilities. The project's strategic importance is enhanced by its proximity to the Noida International Airport, which is set to be operational in April next year. According to RFP by YEIDA, the consultant will also offer knowledge support, develop concept notes, and conduct policy benchmarking. They will organise promotional and outreach programmes aimed at attracting investments for the park. An official said the private agency would have to promote the project through webinars involving investors and industry associations. Meetings will also have to be organised with leading corporate houses at both national and international levels during these

Woman dies after truck crashes into e-bike, driver held

Noida. A 34-year-old woman died, and her sister sustained injuries after a truck allegedly struck their electric scooter from behind near the Botanical Garden on Wednesday morning. The driver was arrested, and the truck was seized, police said. The woman, Neelima, worked at a private firm and was the sole breadwinner for her family. She regularly commuted from Badarpur to the city. Her sister, who suffered minor injuries in the accident, is currently receiving treatment at a nearby hospital. According to eyewitnesses, the accident occurred during peak morning traffic.Neelima was riding her electric scooter with her sister as a pillion passenger when the truck collided with them, throwing both off the vehicle due to the impact.

Passersby quickly alerted emergency services and the police. Officers arrived within minutes and found Neelima critically injured. Despite rapid assistance from emergency services, she succumbed to her injuries at the hospital."A case was registered against the driver, Rakesh Kumar, under relevant Section 106 (causing death by negligence) of the BNS, and he was taken into custody at the scene. All sites over 500sqm must be on pollution portal, says DTCP

Gurgaon. In a significant move to curb pollution levels across NCR, the department of town and country planning (DTCP) has mandated registration of all construction and demolition (C&D) sites over 500 square metres on the Haryana State Pollution Control Board's (HSPCB) dust portal. This directive follows a similar order recently issued by the Haryana Shahari Vikas Pradhikaran (HSVP), which instructed sixteen developers to register their ongoing projects on the same platform to help monitor and control dust emissions. The decision, aimed at improving air quality, is part of the state's adherence to the Graded Response Action Plan (GRAP), a framework designed to tackle pollution in NCR's most affected areas.

Rising levels of dust and particulate matter, largely originating from C&D activities, put people's health at risk, making them vulnerable to respiratory and cardiovascular conditions. As the number of infrastructure projects continues to grow in urban centres like the city and other areas of NCR, residents have raised concerns over declining air quality and its adverse health impacts. Commenting on the department's decision, a senior DTCP official said, "The mandatory registration of all construction and demolition sites on the dust portal is a step towards enforcing stricter environmental standards.

Birds not in sight even with binoculars, red faces at eco-tourism event in Okhla

Noida. A govt eco-tourism event at Okhla Bird Sanctuary ended in many red faces as the main attraction – water birds – were missing conspicuously. At the bird sanctuary, whose natural aviary is far from its chirpy self this year, visitors strained to spot one, even with binoculars. One of them was state PWD minister Brijesh Singh, who launched the programme and picked up binoculars, which officials handed over to him, to take in the sights. The minster looked closely, in different directions, before quietly saying he was unable to spot any. Later, the minister made a push for eco-

tourism and encouraged nature lovers to visit the sanctuary. "I would like more and more people to come with their families (to Okhla sanctuary). This way, people will be able to breathe good air amid the increasing pollution in Delhi-NCR," Singh said.Bird watchers and environmentalists criticised the event, saying it showed the degeneration of the bird sanctuary because of poor maintenance. Projects like 'eco-tourism', they said, had further affected the natural

habitat, by relentlessly driving up footfall — which touched nearly 70,000 last year — and building watch towers and trails to draw more people, at the cost of the sanctuary's natural wealth, its host and visiting bird species."Due to gross mismanagement, the wetland here goes dry every year, once in March and then in Oct. This has catastrophic consequences for the entire ecosystem which is dependent on water. When the first waterfowl arrive for winter, they are greeted by a dry habitat at Okhla. This is probably a key reason for poor bird diversity and low numbers," birder Jaswinder Waraich said. Over the years, he claimed, birders have flagged gaps in management and suggested ways to plug these, but the wildlife department has been unresponsive. "It is as if they want the sanctuary to die a slow death."Winter migratory birds, among them Common Teal, Northern Shoveler, Northern Pintail, Gadwal, Common Pochard, and Bar-headed Geese, which usually start reaching the sanctuary by Oct, have not made a pit stop at Okhla this year



yet."The transformation of Okhla Bird Sanctuary into an entertainment venue, While there was a boost in species diversity under the label of eco-tourism, by the forest division has severely impacted its ecosystem. This commercialisation, single-mindedly aimed at revenue generation, has significantly degraded the avian habitat," said ecologist and ornithologist TK Roy.DM Manish Verma, however, told TOI that it was not that birds were nowhere to be seen at the sanctuary. The Okhla Bird Sanctuary has seen a sharp decline in both water bird species diversity and population over the past four years, as revealed by the latest Annual Waterbird Census (AWC).In 2024, only 32 bird species and 3,380 individual birds were observed, a substantial decrease from 2020 when 62 species and 8,776 birds were recorded.

in 2021, with 73 species reported, the number of individual birds dropped slightly to 8,068. However, in 2022, the sanctuary recorded a significant drop in species diversity, down to 47 species, despite an increase in the bird count to 9,143, marking the highest population recorded over the last four years. In 2023, the trend of declining diversity continued, with only 36 species and 6,083 birds

Cost shoots up 100cr for roads to airport, YEIDA seeks govt nod

Noida. The Yamuna Expressway Industrial Development Authority (YEIDA) submitted an updated cost estimate of Rs 178.4 crore to the state govt for two critical road projects that are linked to the Noida International Airport.Initially, the projects were estimated at Rs 77 crore, but the decision to entrust the construction to the National Highways Authority of India (NHAI), rather than YEIDA constructing them directly, led to an increase of over Rs 100 crore.

The projects include an 8.2km peripheral road along the airport's northern and eastern boundaries, as well as an 800m secondary access road connecting the Yamuna Expressway to the airport, intended for emergency and VIP access.In July this year, following a decision to sign an MoU with NHAI, YEIDA tasked NHAI with handling the execution, and NHAI

subsequently provided the revised cost estimates. As per NHAI's updated calculations, around Rs 159 crore was allocated for the peripheral road; which will run adjacent to the airport's boundary, facilitating access to the multimodal cargo hub.YEIDA had initially estimated this road's cost to be around Rs 64.3 crore, a figure that was approved by the Civil Aviation Department. However, NHAI's design revisions — incorporating wider carriageways, soil stabilisation, RCC drainage systems, and additional bridges — significantly raised the cost. Similarly, the cost for the secondary access road increased from Rs 12.8 crore to Rs 19.4 crore due to enhancements in the width of the main carriageway. This secondary access road will work in conjunction with a 750m public access road currently being built by NHAI, which will link

the Yamuna Expressway directly to the Noida International Airport. As part of a 31km corridor that will connect the Yamuna Expressway to the Delhi-Mumbai Expressway near Ballabhgarh in Ĥaryana, this public access road is advancing rapidly and is expected to be operational before the airport begins commercial activities in April next year. YEIDA CEO Arun Vir Singh said that the revised estimates have been submitted to govt and are now awaiting approval, with Yamuna Expressway Authority bearing the full costs of the project."The design changes were necessary to meet NHAI's specifications and to ensure smooth cargo vehicle access," said Singh. "In July 2024, YEIDA proposed that NHAI manage these projects under an MoU, with NHAI responsible for the reports and final

FIR late, no med report, court convicts two for gang rape on teen's statement

Gurgaon: A Pocso court in Panipat handed 20 years' rigorous imprisonment to two persons for the gang rape of a teenager in 2021 case that saw a 17-day delay in registration of an FIR.As police did not present a medical report either, the court relied on the statements of the 18-year-old survivor and her mother to convict the accused. The judge observed that a survivor's statement is enough for conviction "if it inspires confidence of the court". The judge also pointed out there was no variation in the statements of the girl and her mother from the time the FIR was registered and during the course of the hearing."No self-respecting girl would come forward in a court just to make a humiliating statement about her honour such as is involved in the commission of rape on her," the court observed. According to Kuldeep Dhull, the public prosecutor, the girl whose mother was away at her village in Bihar — was gang-raped on Dec 11, 2021. Around 8pm that day, one of her neighbours called her home to help him with some work as his wife was away. As the girl stepped into his house, the neighbour closed the door and pounced on her. He then gagged her with a piece of cloth and raped her along with his friend, with whom he had already been drinking at home. The accused threatened to kill her if she told anyone about the crime. The girl stayed confined to her home — until her mother returned from her native village on Dec 18, 2021.A case was eventually registered at Panipat City police station on Dec 28 that year under sections 376D (gang rape), 342 (wrongful confinement) and 506 (criminal intimidation) of the IPC against the neighbour and his friend.Dinesh Garg and Rachit Saini, who represented the accused in court, argued that the prosecution had based the case on "assumption and presumption", and failed to bring all possible evidence to corroborate the survivor's version. The lawyers also argued that both clients were at their workplace on the day the incident was believed to have happened and also pointed out the delay in filing the FIR.Additional judge of the fast-track Pocso court,

Wildfires spread across Southern California, destroying homes and prompting evacuations

CAMARILLO. California was lashed by powerful winds Wednesday that fed a fast-moving wildfire, which destroyed dozens of homes and forced thousands of residents to flee as forecasters warned of the potential for "extreme and life-threatening" blazes.

Northwest of Los Angeles, the Mountain Fire exploded in size and prompted evacuation orders for more than 10,000 people as it threatened 3,500 structures in suburban communities, ranches and agricultural areas around Camarillo, according to a statement from Gov. Gavin Newsom. The area east of the Pacific coast city of Ventura will receive federal assistance after a request from Newsom was granted, the Federal Emergency Management Agency said Wednesday. The blaze was burning in a region that has seen some of California's most destructive fires over the years. A thick plume of smoke rose hundreds of feet into the sky Wednesday, blanketing whole neighborhoods and limiting visibility for firefighters and evacuees. The fire grew from less than half of a square mile to 16 square miles (62 square kilometers) in little more than five hours. Ventura County Fire Captain Trevor Johnson described crews racing with their engines to homes threatened by the flames to save lives. "This is as intense as it gets. The hair on the back of the firefighters' neck I'm sure was condition and "the said thrives". standing up," he said during a news conference Wednesday afternoon.At one spot, flames licked the burning remains of a home. Its roof was reduced to only a few charred shingles. Two people suffered apparent smoke inhalation and were taken to hospitals, fire officials said. No firefighters reported significant injuries. The erratic winds and limited visibility grounded fixed-wing aircraft, and gusts topped 61 mph (98 kph), said weather service meteorologist Bryan Lewis. Water-dropping helicopters were still flying.

First responders pleaded with residents to evacuate. Deputies made contact with 14,000 people to urge them to leave as embers spread up to 2.5 miles (4 kilometers) away and sparked new flames.

'This fire is moving dangerously fast," Ventura County Fire Chief Dustin Gardner said. Aerial footage from local television networks showed dozens of homes in flames across several neighborhoods as embers were whipped from home to home. Other footage captured horses trotting alongside evacuating vehicles.

Man Attempts Ramming Attack In East Jerusalem, Shot Dead By Israeli Police



World. A suspect was shot and killed after he attempted a ramming attack in Anata, East Jerusalem, early Thursday, Israeli authorities said. According to police, the driver accelerated towards officers and ignored orders to stop. Fearing for their safety, Border Police fired at the vehicle, neutralising the suspect. There were no reports of any injuries from the incident, the Jerusalem Post reported. More than a year into a war that has ricocheted across the Middle East, Israeli troops are still battling Hamas in the most heavily destroyed and isolated part of the Gaza Strip. In northern Gaza, Hamas militants carry out hit-and-run attacks from bombed-out buildings.

Since its Oct. 7 attack on Israel that sparked the war in Gaza, Hamas has taken heavy losses. The recent killing of its top leader, Yahya Sinwar, was viewed as a possible turning point, yet the two sides do not appear any closer to a cease-fire, and Hamas, which still holds scores of hostages, remains the dominant power in Gaza. The conflict has drawn in militants from Lebanon to Yemen, and their key sponsor, Iran, has inched closer to all-out war with Israel. But in northern Gaza, the war seems stuck in a loop of devastating Israeli offensives, followed by Hamas fighters regrouping. More than 43,300 Palestinians have been killed in more than a year of war in Gaza,

Canada orders TikTok's Canadian business to be dissolved but won't block app

TORONTO. Canada announced and on the advice of Canada's security Wednesday it won't block access to the popular video-sharing app TikTok but is ordering the dissolution of its Canadian A TikTok spokesperson said in a business after a national security review of the Chinese company behind it.

Industry Minister François-Philippe Champagne said it is meant to address risks related to ByteDance Ltd.'s establishment of TikTok Technology Canada Inc."The government is not blocking Canadians' access to the TikTok application or their ability to create content. The decision to use a social media application or platform is a personal choice," Champagne said.

Champagne said it is important for Canadians to adopt good cybersecurity practices, including protecting their personal information. He said the dissolution order was made in accordance with the Investment Canada Act, which allows for the review of foreign investments that may harm Canada's national security. He said the decision was based on information and evidence collected over the course of the review

and intelligence community and other government partners.

statement that the shutdown of its Canadian offices will mean the loss of hundreds of local jobs."We will challenge this order in court," the spokesperson said. "The TikTok platform will remain available for creators to find an audience, explore new interests and for businesses to thrive."TikTok is wildly popular with

young people, but its Chinese ownership has raised fears that Beijing could use it to collect data on Western users or push pro-China narratives and misinformation. TikTok is owned by ByteDance, a Chinese company that moved its headquarters to Singapore in 2020.TikTok faces intensifying scrutiny from Europe and America over security and data privacy. It comes as China and the West are locked in a wider tug of war over technology ranging from spy balloons to computer chips.Canada previously banned TikTok from all



government-issued mobile devices. TikTok has two offices in Canada, one in Toronto and one in Vancouver.

Michael Geist, Canada research chair in Internet and E-commerce Law at the University of Ottawa, said in a blog post that "banning the company rather than the app may actually make matters worse since the risks associated with the app will remain but the ability to hold the company accountable will be weakened." Canada's move comes a day after the

election in the United States of Donald Trump. In June, Trump joined TikTok, a in the White House. It has about 170 million users in the U.S. Trump tried to ban TikTok through an executive order that said "the spread in the United States of mobile applications developed and owned" by Chinese companies was a national security threat. The courts blocked the action after TikTok sued.

Both the U.S. FBI and the Federal Communications Commission have warned that ByteDance could share

user data such as browsing history, location and biometric identifiers with China's government. TikTok said it has never done that and would not, if asked. Trump said earlier this year that he still believes TikTok posed a national security risk, but was opposed to banning it.U.S. President Joe Biden signed legislation in April that would force ByteDance to sell the app to a U.S. company within a year or face a national ban. It's not clear whether that law will survive a legal challenge filed by TikTok or that ByteDance would agree to sell.

US pollsters underestimate Trump support - again

WASHINGTON.Opinion polls underestimated the level of Donald Trump's support for the third US presidential election in a row, predicting a neck-and-neck race with Kamala Harris when in the end the Republican edged the vice president across battleground states. Trump's win involved surging support in a number of demographics and regions, but experts said pollsters failed to accurately predict races in states where the results differed significantly from the last election in 2020."They did fine in battlegrounds, but... they failed to provide the essential information that Trump was surging across the board," said Michael Bailey, a professor of political science at Georgetown University. More than 90 percent of US counties voted in higher numbers for the Republican billionaire than they did in 2020, according to The New York Times.Overall, the polls had predicted razor thin margins in races in the seven battleground states that decide close US elections. As of Wednesday, Trump was projected to win five of those states by between one and three percentage points. The former president was well on his way to sweeping all seven states, according to those projections.

'Trump may have been mildly underestimated but I think the polls ended up doing pretty well, collectively -- this was not a huge miss," said Kyle Kondik, a political analyst at the University of Virginia."The polls suggested Trump had a decent chance to win, and he won." Small margins

The pollsters' performance was under the microscope this year, after two big misses in succession: they had failed to anticipate Trump's victory in 2016, and had overestimated the margin by which President Joe Biden won against him in 2020."Trump was underestimated by said Pedro Azevedo, Head of US polling at AtlasIntel.In Pennsylvania, the latest polling average from RealClearPolitics put the Republican in the lead by 0.4 percentage points. As of Wednesday, he was ahead by two points.

In North Carolina, polls predicted a 1.2-point margin for Trump, and he won by three points over Harris.In Wisconsin, the vice president was given a 0.4-point lead, but the projected results showed Trump leading the count by 0.9 points. Unable to adjust The main problem has not changed since Trump's arrival on the US political scene about a decade ago: a fringe of his electorate refuses to take part in opinion polls, and firms have failed to be able to accurately gauge their impact.In the most recent polls conducted by The New York Times with Siena College, "white Democrats were 16 percent likelier to respond than white Republicans," NYT data analyst and polling guru Nate Cohn wrote two days before the election.

Hurricane Rafael strikes Cuba, knocks out power grid and triggers widespread damage

HAVANA. Cuba was left reeling Thursday after a fierce Category 3 nurricane tore across the island knocking out the country's power grid.

The full extent of the damage remained unclear through the early hours of the day, but forecasters warned that Hurricane Rafael could bring "lifethreatening" storm surges, winds, and flash floods to Cuba after battering parts of the Cayman Islands and Jamaica.On Wednesday evening, massive waves lashed Havana's shores, while sharp winds and rain whipped through the historic cityscape, leaving trees scattered on flooded roads. Much of the city was dark and deserted.

As it moved across Cuba, the storm weakened to a Category 2 hurricane, churning into the Gulf of Mexico near northern Mexico and southern Texas, according to the National Hurricane Center in Miami. However, many Cubans were left picking up the pieces



from the night before, with a strange sense of déjà vu after a turbulent few weeks in the Caribbean nation.In October, the island had already been struck by a one-two punch. First, Cuba was rocked by island-wide blackouts that lasted for days, a consequence of the country's ongoing energy crisis. Shortly afterward, another powerful hurricane hit the eastern part of the island, killing at least six people. The storm deepened discontent already simmering in Cuba, where an ongoing economic crisis has prompted many to

migrate.While the U.S. State Department issued a travel warning for Cuba in light of the storm, the Cuban government also raised an alarm, urging citizens to hunker down.Classes and public transport were suspended in parts of the island, and authorities cancelled flights in and out of Havana and Varadero. Thousands of people in the western part of the

island were evacuated as a precautionary measure, and many more. like Silvia Pérez, a 72-year-old retiree living in a coastal area of Havana, scrambled to prepare.

This is a night I don't want to sleep through, with the battering wind and the falling trees," Pérez said. "I'm scared for my friends and family."

Germany's Chancellor Olaf Scholz fires finance minister, collapsing coalition government

BERLIN. Germany's centre-left Chancellor Olaf Scholz announced Wednesday he was firing Finance Minister Christian Lindner, signaling the collapse of the ruling three-party coalition that relied on Lindner's probusiness party. Scholz announced the move at a news conference following weeks of disputes among the coalition partners over ways to boost the country's ailing economy. He said he would seek a vote of confidence in January that he said might lead to early elections that otherwise would be due next September. "I feel compelled to take this step to prevent

damage to our country. We need an effective government that has the strength to make the necessary decisions for our country," Scholz said.Lindner, from the pro-business Free Democrats, had rejected tax increases or changes to Germany's strict self-imposed limits on running up debt.Scholz's Social Democrats and the environmental Greens, who are also part of the coalition, wanted to see massive state investment and rejected the Free Democrats' proposals to cut welfare programs.Lindner responded to his dismissal by accusing Scholz of failing "to recognize the need for a new economic awakening in our country. He has played down the economic concerns of the citizens."He said the chancellor's proposals to reenergize the economy were "dull, unambitious and make no contribution to overcoming the fundamental weakness of our country's growth."Scholz said about Lindner that 'he has broken my trust too often. He even unilaterally canceled the agreement on the budget. After we had already agreed on it in long negotiations. There is no basis of trust for further cooperation. Serious government work is not possible like this."He accused Lindner of publicly



calling for a fundamentally different economic policy, including what Scholz said would be tax cuts worth billions for a few top earners while at the same time cutting pensions for all pensioners. "That is not decent," Scholz said. Scholz said he would seek the vote of confidence in Germany's Bundestag, or parliament, on Jan. 15, which would "allow the members of the Bundestag to decide whether to clear the way for early elections.'

The election could then "take place by the end of March at the latest, in compliance with the deadlines set out in constitution,' he said. The regular election is scheduled for September 2025. Germany's economy is expected to shrink in 2024 for the second year in a row, or at best stagnate, battered by external shocks and homegrown problems including red tape and a shortage of skilled labor.

Scholz's center-left Social Democrats, Vice Chancellor Robert Habeck's environmentalist, left-leaning Greens and Lindner's pro-business Free Democrats — a party that in recent decades has mostly allied with conservatives — set out in 2021 to form an ambitious, progressive coalition straddling ideological divisions that would modernize Germany. The government can point to achievements: preventing an energy crunch after Russia cut off its gas supplies to Germany, initiating the modernization of the military and a series of social reforms. But the impression it has left with many Germans is of deepening dysfunction. Ahead of the vote of confidence in January, Scholz said he would reach out to opposition leader Friedrich Merz of the center-right Christian Democrats to confer on possible ways of strengthening the economy and defense."I will now very quickly seek talks with the leader of the opposition," Scholz said. He said he wants to offer Merz the possibility of working together on issues "that are crucial for our country, on quickly strengthening our economy and our

Madras HC allows vet's plea to check on ailing monkey at Vandalur Anna zoo

CHENNAI: Madras High Court allowed a veterinarian to visit an ailing monkey currently lodged at the Arignar Anna Zoological Park in Vandalur near Chennai on Wednesday for checking its health conditions. Justice C V Karthikeyan passed the orders permitting Dr V Vallaiappan, president of Prani Mithran, to see the monkey-a bonnet macaque-and check its health conditions on November 9. The judge directed the authorities of the Forest department to file a report on the matter. Vallaiappan petitioned the court for interim custody of the animal, which he had treated for paralysis and other ailments suffered due to dog bites at Sholingur in Ranipet district, where he held a camp for animals on December 4, 2023.

He stated that a forest department staff member brought the premature baby monkey to the camp as it was fighting for survival due to multiple injuries inflicted by strays. After providing treatment for about 10 months, the forest department officials took custody of the animal and lodged it at the zoo.

He sought the court to order interim custody, arguing the monkey still requires continued treatment, as the authorities concerned had not taken any positive action even after submitting a representation in this regard.

One more held in Mumbai girl's rape, abduction case

PUDUCHERRY: One more person from Chennai has been arrested in the abduction and rape case of a minor girl who came to Puducherry from Mumbai along with her parents. The suspect has been identified as Chittaranjan, and has been arrested from Chennai. He was remanded in judicial custody on Wednesday.

The police have already arrested an auto driver, Khwaja Moinuddin, and three others -Dinabandhu, Ramesh and Pankaj from Chennai. All the four from Chennai are in their 30s and are employees of a construction company in Chennai. They have been booked under Pocso Act.ources said the four had come to Puducherry during the Deepavali holidays and had taken the girl, abandoned by the auto driver, to Chennai in their car. Subsequently, she was dropped by a cab on the Beach road.

Earlier when the girl left home on October 30, the auto driver, under the pretext of taking her around Puducherry, gave her alcohol and took her to his home in Kottakuppam. She was allegedly raped several times before being abandoned on the East Coast Road. The girl was handed over to her parents after physical examination and counselling, the police added.

Kerala faces rising snake bite threat, demand grows for viper anti-venom

the backdrop of deaths resulting from pit viper bites in Kasaragod and Idukki districts, demands are rising to develop anti-snake venom for a variety of vipers found in the state. While the vipers in question --Anamalai pit viper (APV), humpnosed pit viper (HNPV), Travancore pit viper and Malabar pit viper -- are not highly venomous, they come under the category of venomous snakes.Experts claim that the recent deaths after HNPV and APV bites happened because of other ailments consequent to the snake bites. At the same time, the fact is that the current

polyvalent anti-snake venom is only for the big four among snakes -- spectacled cobra, common krait, Russell's viper and saw-scaled viper -- but not for other snakes. Initially, the vipers found in south India were categorised into five species --Malabar pit viper, bamboo pit viper, horse-shoe pit viper, large-scaled pit viper and hump-nosed pit viper.Later, the Malabar pit viper was reclassified into three species -- Travancore pit viper (found in Thiruvananthapuram and Kollam), Anamalai pit viper (from Pathanamthitta to Nelliyampathy in Palakkad) and Malabar pit viper (Palakkad gap to northern Western Ghats). While there are genetic differences, they look the same to an untrained eye. Hence, they are



categorised according to the location.

Over the past few years, Kerala has been seeing a spurt in the number of deaths due to HNPV bites. On October 24, Manjeshwar resident Ashok, 43, died at a private hospital in Mangaluru following an HNPV bite. The next day, an APV bite case was reported in Kallar in Idukki. According to the Facebook group 'Snakes of Kerala', over the past fortnight, at least half a dozen people were fortunate to have spotted vipers in the nick of time.According to Dr Sandeep Das, a leading herpetologist, polyvalent anti-snake venom is neither effective nor advisable in the event of a venomous or highly venomous snake bite. "When a patient bitten by a snake is taken to the hospital, the doctor there treats them symptomatically. Anti-

venom is effective only for the big four in India. So, administering anti-snake venom for pit viper bites is useful but at times it can also cause anaphylaxis (a lifethreatening allergic reaction). Research is on to develop antisnake venom for pit viper bites, especially HNPV bites, and it should bear fruit in the near future," said Dr Sandeep, a Science and Engineering Research Board national postdoctoral fellow with the Calicut University's department of zoology.Dr P Jayesh Kumar, professor and HOD, general

medicine, Kozhikode Medical College, said if snakebite deaths were earlier caused by Russell's viper and sawscaled viper, now HNPV bites have taken centre stage. "We won't give antisnake venom for HNPV or APV bite cases, but provide supportive treatment. The symptoms shown are inflammation in the bitten area and coagulant failure. Renal failure doesn't happen. It's high time anti-snake venom for pit vipers is produced to save lives," he said.Research is on at the Indian Institute of Science, Bengaluru, on pit viper venom and probable treatment techniques. The development of antisnake venom in Kerala would help bring down the chances of geographical variation, experts said.

The Speaker highlighted that Andhra Pradesh is fostering civic engagement by telecasting Assembly sessions live. However, he acknowledged that there is still scope for improvement in ensuring full transparency, especially in House committee meetings. He suggested that there is a need for a comprehensive governance approach to make the committee proceedings accessible to the public.

Another key point discussed at the CPC was the limited time legislators have to deliberate on crucial proposals due to their active involvement in addressing local issues. He felt that if every government department fulfils its responsibilities effectively, legislators will have more time for legislative activities. Ayyanna also observed that while legislative procedures like Zero Hour and Question Hour are designed to keep the government accountable, the effectiveness of such measures is impacted by the limited number of legislative sessions.

He proposed a minimum of 70 Assembly working days a year to address this gap. He concluded by emphasising that the Andhra Pradesh Legislative Assembly is moving towards a paperless system through ICT adoption, setting an example as a technologically forward-thinking State.

Plea to book Revanth for 'abusing' leaders rejected

Justice B Vijaysen Reddy of the Telangana High Court on Wednesday dismissed a writ petition filed by BRS leader Errolla Srinivas seeking a direction to the Banjara Hills police station to register a case against Chief Minister A Revanth Reddy for allegedly using offensive language against pink party leaders during a public meeting in March 2024. Srinivas, a former SC, ST Commission chairman, alleged in his petition that Revanth made threatening comments during a public meeting at Palamuru on March 6.

According to the petition, the chief minister also used crude and offensive language, including a threat to "pull out the intestines" of prominent BRS leaders like former chief minister K Chandrasekhar Rao. KT Rama Rao and T Harish Rao. The petitioner argued that such statements from a sitting chief minister were inflammatory and could incite violence and lead to law-and-order problems in the state. However, the high court, while considering the petition, noted that the writ was not maintainable and that Srinivas lacked the standing (locus) to file the petition.

Midnight police raid sparks political uproar in Palakkad

PALAKKAD: Kerala's highly charged political scene reached a boiling point on Wednesday after an early morning police raid at a Palakkad hotel where Congress leaders were staying for a bypoll campaign. A few CPM leaders and BJP

workers were also staying in the hotel. The police claimed they were acting on a tip-off about black money transactions for UDF candidate Rahul Mamkootathil, but Congress leaders alleged it was a planned attempt to implicate them, and gain advantage ahead of the November 20 byelection. As police searched the premises, tension escalated into chaotic confrontations between leaders and

Congress. The three-hour search, which concluded at 3:30 am, yielded no illegal funds, police said. Clashes erupted between Congress workers and police, with MPs Shafi Parambil and V K Sreekandan attempting to defuse the situation.Leader of Opposition V D Satheesan alleged conspiracy, while CPM and BJP workers claimed

Mamkootathil was present during the raid. The CPM accused Congress workers of deliberately enacting a melee to facilitate his escape. Congress leaders disputed this, stating the candidate had left to meet with religious leaders.

However, the Congress swiftly countered, accusing CPM of spreading false information and overstepping their brief by doing the police's job. Mamkoottathil questioned how CPM got the video, which was actually collected by police.Following the raid and ensuing commotion, UDF

Should heads roll Ball is in BCCI court

THE whitewash by New Zealand in a Test series in India has triggered Indian cricket's greatest crisis. This calls for a befitting response.Let us first put the result of the just-concluded India-New Zealand Test in context. The Kiwis, now nicknamed Black Caps, were, for decades, minnows among Test-playing sides. When they first visited India in the winter of 1955-56, the hosts won 2-0, marking India's first-ever series victory — 23 years after their Test debut.India's maiden series win abroad was also against New Zealand in the form of Tiger Pataudi's team triumphing 3-1 in 1967-68. The Black Caps didn't win a series against India until 1981, which was largely because of a singular fast bowling feat at the Basin Reserve in Wellington by Richard Hadlee.New Zealand did indeed beat India in the inaugural World Test Championship (WTC) final in 2021. But the trend of the former never winning a series in India persisted, until the outcome on Sunday. The impregnable bastion that India had become at home, with the might of Australia, England and South Africa tumbling repeatedly had crumbled like sandcastle! That, too, at the hands of a squad without their two best players batsman Kane Williamson and left-arm fast bowler Trent Boult. Given the fact that Sri Lanka had thrashed New Zealand on subcontinental soil just prior to the Black Caps taking on India, there was not unjustified expectation that the home side would produce a brown-wash, thereby rendering the upcoming five Tests in Australia inconsequential in terms of India qualifying for a third consecutive WTC final.

Horror of horrors! Indian batsmen could not cope with the tourists' spin trio. Earlier generations of Indian wielders of the willow could play slow bowling with their eyes closed — even on rank turners. So, what is it that has happened since India humbled England 4-1 eight months ago?

In the delirium that the BCCI has existed in lately, obsessed with phenomena like the Twenty20 Indian Premier League, certain fundamentals have been forgotten. That it's not the BCCI's bank balance but India's display on the field which matters most. That while lifting the Twenty20 World Cup this year wasn't insignificant, wearing the WTC crown is the ultimate prize in a game conceived as an even contest between bat and ball. The BCCI boasts that its net worth is greater than the combined wealth of the rest of the cricket boards. But it is the Aussies with far less funds who hold the WTC and World Cup trophies.

The BCCI constitution empowers its president considerably. On major matters, he is looked upon as being the face of the organisation, its spokesman. Yet, the present president, Roger Binny, a former international cricketer, the bowler of the tournament in India's dizzying 1983 World Cup, has been missing in action.

Whether he has been a mover and shaker behind the scene, one doesn't know. But it astonished many that he was present at the T20 WC final at Barbados in June; but absent at the post-match presentation ceremony. The BCCI secretary, and not Binny, represents the BCCI on the International Cricket Council board unprecedented in the catalogue of Indian cricket. Was there a backroom deal between the genial and gentlemanly Binny and the Bharatiya Janata Party (BJP), which seemingly remote-controls the BCCI?Binny and the BCCI secretary cannot be absolved of being party to a policy failure. Binny is guilty of apparently abdicating a proactive role as president. His secretary has underlined that enthusiasm is not a substitute for expertise.Jay Shah, son of the Union Home Minister, with no cricketing background, calling the shots manifested in the shape of Gautam Gambhir, a BJP Lok Sabha MP, being appointed as India's head coach with a degree of haste. From the heights of Rahul Dravid, a globally recognised authority on batsmanship, the critical responsibility was transferred to a man with a limited track record in Tests.

Women's woes on the labour front

ILO study shows caregiving activities keeping 53 per cent of them out of the workforce in India

THE perennial mystery of the abysmally low number of women in India's labour force seems to have been solved to some extent. The reason for this has been partially attributed in the past to a heavier domestic burden, but now there is more certainty on the issue. The International Labour Organisation's (ILO) latest global study on the impact of care responsibilities on women's labour participation shows that gender roles are completely skewed in favour of men. It finds that 53 per cent of the women in this country remain outside the labour force for this reason. The solution to the problem, it rightly

suggests, is more investment in the care economy. This is not to say that there are no care facilities for children here, at least as far as the youngest age group is concerned. The anganwadi scheme is probably the world's largest network of centres to provide nutritional and medical support for children up to the age of six years. The programme was expanded a few years ago to convert it into an anganwadi-cumcrèche scheme. But there seems to be a lack of urgency about ensuring that the plan to make crèches widely available for working women becomes a reality in urban and rural areas. The Niti Aayog has reportedly highlighted flaws in this scheme, which seems to be progressing slowly. The fact is that programmes involving infrastructure and industrial development are carried out with much greater zeal by government agencies rather than schemes to promote women and child development. The issue



The issue of toilets is a similar one, with those involved in policymaking apparently impervious to the discomfort faced by women in areas where public toilets are not readily available. The Swachh Bharat campaign, with defined targets for making towns and cities open defecation-free (ODF), has made a significant difference, but there is still vast room for improvement. For instance, poor quality toilets remain the bane of railway travel for women and are a direct consequence of the lack of priority for this critical sanitation matter. Recently, Road Transport

and Highways Minister Nitin Gadkari highlighted the ramshackle condition of toilets at highway fuel stations. The ILO report flags the gender imbalance in India; it notes that compared to 53 per cent of the women involved in unpaid caregiving, only 1.1 per cent of the men stay outside the labour force due to such responsibilities. India is in the same boat as countries like Iran, Egypt, Jordan and Mali, which also have over 50 per cent of the women outside the labour force for the same reasons. In sharp contrast, countries like Belarus, Bulgaria, Latvia and Sweden have only 10 per cent of the women away from



regular employment due to this factor.

A parallel report released recently relating to schoolgoing children shows that the trend of women being saddled with heavy domestic work begins at a young age and ends up affecting their education. This UNICEF study shows that young girls are spending far greater time on unpaid domestic activities than boys of the same age. As compared to Both these reports need to be studied with care so that 32.9 per cent of the girls, only 9.1 per cent of the boys are engaged in such work. The study, based on the 2019 Time Use Survey of the Programme Implementation Ministry, says this is impacting the learning process for girls and preventing them from doing homework or taking part in sports.

Another disturbing finding is that at least 20 per cent of the children in the age group of 6-17 years are engaged in unpaid domestic work. It must be recognised that some domestic work is done by all children as they learn to do chores to prepare them for adult life. But this should not be such that it affects their educational process in any way. The study also finds that the impact is confined largely to girls. It seems to presage the ILO report with regard to women being kept out of the workforce due to caregiving activities.

The solution, according to the UNICEF study, is to raise investment in services that reduce domestic household work burdens, such as easier access to water and power, especially in rural areas. Affordable child care services, social protection programmes and schemes to promote gender equality are among the other recommendations.


> These are positive ideas to set right the glaring gender imbalance impacting girls who are not able to focus sufficiently on their education. But these are also issues that should have been recognised long ago by political leaders and bureaucrats alike while formulating policies to bring more women into the workforce. In this context, it must be noted that female labour force participation is reported to have risen from 23 to 37 per cent from 2017-18 to 2022-23, with the rise largely due to an increase in agriculture-related activities in rural areas. There can be no comfort in the fact that the ILO data shows

that northern Africa and Arab nations have an even higher percentage of women outside the workforce due to caregiving responsibilities. Significantly, eastern Europe has the lowest rate (11 per cent), which can be directly attributed to the substantial state support given for child care services.

remedial measures can be taken as soon as possible. The first step must be to strengthen and expand the existing anganwadi-cum-crèche scheme. Secondly, urban areas should have specialised child care facilities, which need not be subsidised entirely. While the pattern of European child care cannot be replicated here, the best practices can certainly be adapted to the Indian context. The outcome of such widespread child care schemes will be to unleash the potential of women at the workplace and this, in turn, can help India reach the goal of becoming a developed economy sooner rather than later.

Boost to madrasas

It is hoped that the SC ruling will help in curbing the brazen vilification of madrasas. These institutions are being targeted on the pretext that they are breeding grounds for religious fanatics and terrorists. Weeding out the black sheep is no doubt important, but attempts to dismantle the entire madrasa system reek of intolerance and hatred. Such nefarious moves are undermining the secular credentials of

India, aptly described by the Supreme Court as a melting pot of cultures, civilisations and religions.

Punjab by elections a litmus test for Mann government

All political parties must share the responsibility for this situation. Certificates of progress by successive govts attest the hypocrisy of our politics.

IN a never-ending 'festival of democracy', another round of elections has been announced, including the four by elections to the Punjab Vidhan Sabha. Clearly, much is at stake in these elections for the Bhagwant Mann government. An electoral reverse in the bypolls after its disappointing performance in Haryana could demoralise the ruling party's cadres and raise doubts about its future.

The government's immediate challenge, therefore, is to demonstrate its political dominance in the state by winning the byelections in a stiff challenge from the Congress and the BJP. Midway into its present tenure, its real test will be at the end of the government's present term when its performance will be judged on the touchstone of whether its policies and performance have earned it the willing allegiance of the people. For the present, the land of the Gurus and the five rivers, known as the granary of India and the sword arm of the nation, finds its people in distress. The hopelessness of the marginalised masses, crushed by penury and the resultant loss of dignity, rampant drug addiction, a crumbling public infrastructure and widening social divides heightened by unconscionable economic disparities, have scarred the soul of Punjab.An understaffed constabulary tasked to address the stirrings of radicalism, political violence, gangsterism, a perpetual face-off between the government and the dominant farming community and the large-scale migration of unemployed youth to foreign lands in search of an elusive future, foretells the story of a state in decline. The continuing slide in several development indices presents a harsh but irrefutable reality.

A look at the Niti Aayog's Sustainable Development Goal (SDG) rankings for Punjab for 2023-24 speaks for itself. For instance, on SDG-8 related to decent work and The state's debt burden on account of the fiscal profligacy of successive governments is more than Rs 3.51 lakh crore, as of March 2024 (India Policy Forum, 2024, Economic Development of Punjab, India Prospects and Policies). According to the Niti Aayog's Multidimensional Poverty



Index for 2023, 4.75 per cent of Punjab's population lives in abject poverty. All political parties must share the responsibility for this situation. Self-serving certificates of progress and development by successive governments attest the hypocrisy of our politics. The renewal of the state demands a cooperative endeavour premised upon a broad democratic consensus on the way forward.

For this, a necessary first condition is the eschewing of politics of vendetta against political rivals. To rescue Punjab from the vicious cycle of economic stagnation and secure the state's future, the incumbent government, with an unprecedented legislative majority, must own responsibility for sound policy decisions. It could start with the fine-tuning of its agricultural policy, including crop diversification and rationalisation of water consumption given the precarious water situation in the state, both in terms of its quality and future availability. A report by the Global Commission on the Economics of the link between unsustainable subsidies and the imprudent water use for agriculture in India. The diminishing availability of potable water in several districts of Punjab and frightening forecasts in this regard present an existentialist crisis. 

The Bhagwant Mann government has the time and opportunity still to deliver upon its promises and vindicate its much asserted claim of being a government with a difference. In its endeavours to pull the state out of the morass in which it finds itself, it is entitled to necessary support from the Central Government in a spirit of cooperative federalism.



Waqf row: Parliament panel chief visits Karnataka amid BJP's land jihad charge

Waqf Bill parliamentary panel chief Jagdambika Pal is in Karnataka on a solo "fact-finding" mission to address concerns from local farmers alleging their land was improperly claimed as Waqf property.

New Delhi: The Chairman of the Joint Parliamentary Committee on the Waqf (Amendment) Bill, Jagdambika Pal, met with farmer delegations in Karnataka on Thursday following claims that some lands in the state were marked as Waqf properties without the owners' consent. The BJP has labelled these actions as 'land jihad'. Pal said he's in the southern state "for a fact-finding visit". BJP MP Tejasvi Surya, who petitioned Pal to address the farmers' grievances, had announced the visit on social media. The visit includes stops in Hubballi, Vijayapura, and Belagavi to meet with affected farmers and other



stakeholders.nataka...they handed over one memorandum saying that a piece of land which was belonging to them, Waqf Board is claiming it is theirs," Pal told news agency ANI. He added that some farmers claimed to have held these lands for "more than 50-70 years.

Karnataka Deputy Chief Minister DK Shivakumar dismissed the BJP's 'land jihad' charge against the Congress government and protests over it as "political drama" and claimed, "BJP themselves started this in 2019â€æBut my government is committed, we will not change any record... The flight, which was scheduled to depart at 8:45 pm, was delayed by another half an hour, Chidambaram said. The former Finance Minister said he is a frequent Air India traveller and criticised the national carrier for lacking "competent managers at different levels" to deal with emergencyrelated issues." Chief Justice scraps summer breaks in Supreme Court days before his retirement

According to the amended rules, which came into force immediately, the partial working days will begin from May 26, 2025 and full working days will resume from July 14, 2025.

New Delhi: With just days left for his retirement, Chief Justice of India DY Chandrachud has scrapped summer breaks in the Supreme Court. He said now there would only be "partial court working days". The court calendar for 2025 designates summer holidays as 'partial working days'. According to the amended rules, which came into force immediately, the partial working days will begin from May 26, 2025 and full working days will resume from July 14, 2025.



The Supreme Court will sit for these two terms annually -the first commences with the partial working days which would end on the day immediately preceding the winter

The second term will commence from the end of the winter holiday. Meanwhile, the duration of the partial working days will be decided by the Chief Justice, who will also appoint one or more judges to hear cases during this period.

The judges will take up all admission matters, after notice matters, regular matters or matters of urgent nature. Chief Justice Chandrachud, who assumed office on November 9, 2022, will demit office on November 10. Justice Sanjiv Khanna, who is currently the seniormost judge in the top court, will be the next Chief Justice of India and assume the position on November 11.

Cabinet nod to easy education loan scheme for families with Rs 8 lakh income

New Delhi: The Union Cabinet has approved the PM-Vidyalaxmi scheme, aimed at providing financial support to meritorious students pursuing higher education in both public and private institutions. Announced on Wednesday, the scheme is designed to offer collateral-free, guarantor-free education loans to students who secure admission to one of the top 860 Quality Higher Education Institutions (QHEIs) in India. This includes both government and private institutions, making it accessible to a wide range of students.

The PM-Vidyalaxmi scheme is expected to benefit around 22 lakh students. It allows them to take loans that will cover the full cost of tuition fees and other related expenses for their courses. For loans up to Rs 7.5 lakh, students will receive a 75% credit guarantee, making it easier for banks and financial institutions to approve and disburse loans. This provision is aimed at

(CAQM) Act of 2021. The new rules may be called the Commission for Air Quality Management in National Capital Region and Adjoining Areas (Imposition, Collection, and Utilisation of

Environmental Compensation for Stubble Burning) Amendment Rules, 2024, an official notice stated.

As part of the new measures, complaints related to pollution will be handled by the pollution control boards and the CAQM, with clear guidelines for conducting enquiries and addressing grievances. The increase in fines follows sharp criticism from the Supreme Court, which had previously described earlier penalties as ineffective in curbing the practice.

The court noted that previous fines were "toothless" largely due to delays in appointing adjudicating officers and setting up a proper regulatory framework for enforcement. The top court had also recently criticised the Delhi government over the blanket ban on firecrackers. The court observed that the ban was "hardly implemented" and directed the Delhi top cop to file an affidavit stating the measures that were taken to enforce the ban in the national

capital. The government's move is aimed at addressing the severe air pollution that annually plagues Delhi and its surrounding areas. On Thursday, the air quality was recorded in the 'severe' category in many areas. Anand Vihar, Bawana, Mundka and Wazirpur recorded air quality in the 'severe' category, while other areas were in the 'very

In the south, Mangalore in Karnataka also ranks high for its clean air. Since Diwali, Delhi's Air Quality Index (AQI) has consistently remained above 300, reaching around 350 recently. This places it in the 'very poor' category, posing serious health risks for residents. Just recently, the Supreme Court tore into the Delhi government over the blanket ban imposed on the bursting of firecrackers. The top court observed that the ban was "hardly implemented" and pulled up the Delhi top cop over the measures taken by the police to enforce the ban in the national capital.The Supreme Court directed the AAP government and Delhi Police Commissioner to file affidavits stating steps taken to implement the ban

Close behind Gangtok is Aizawl, the capital of Mizoram, which reported an AQI of just 34 on Wednesday. Although its primary pollutant is PM10, the pollution levels remain far below those in Delhi and

SOUTHERN CITIES ALSO EXCEL INAIR QUALITY

Southern India has also made notable strides in air quality. Among the cleanest is Mangalore in Karnataka, with an AQI of 32 on November 6. Unlike cities plagued by particulate matter, Mangalore's main pollutant is carbon monoxide, reflecting its cleaner air profile.In contrast, Bengaluru, Karnataka's capital, recorded a 'moderate' AQI of 110, facing challenges due to PM10 and PM2.5, largely from vehicle emissions. However, several southern cities, including Udupi (AQI 45), Tirunelveli (35), Thrissur (46), Tuticorin (46), Kolar (40), Kollam (48), Kalaburagi (41), and Chamarajanagar (40), have achieved 'good' air quality status. While meteorological and geographical factors certainly influence pollution levels, a significant factor distinguishing polluted and nonpolluted cities is the management of local pollution sources.



known stone ring, is a composite structure built during three periods from 3100 to 1100 BC. Constructed with massive stones weighing as much as twenty-five tons and transported from quarry locations hundreds of miles away, Stonehenge was a structure with multiple purposes. It was a monument of nearly imperishable nature located at a specific site of terrestrial energetic power and celestial significance. It was an astronomical observation device used to predict, in advance of their occurrence, particular

periods in the annual cycle when the earth energies were most highly influenced by the sun, moon and stars. It was a temple, built by and for the people, in which festivals of renewal were held at those energetic periods determined by astronomical observations. It was a structure built with certain types of stones, positioned according to sacred geometry, which functioned as a sort of battery for gathering, concentrating and emanating the earth energies of the site. It was also an eclipse predictor of astonishing



There are two enormous ancient temple complexes in Southeast Asia: Bagan in Burma and Angkor in Cambodia. Both sites are remarkable for their expanse of sacred geography and the number and size of their individual temples. For many visitors Bagan is the more extraordinary because of its wonderful views.

Scattered across a vast dusty plain may be seen scores of exotic Buddhist temples. The kingdoms of Bagan date to the early 2nd century AD, yet the region entered its golden age during the reign of King Anawrahta in 1057 AD. From this time, until it was overrun by Kublai Khan's forces in 1287 AD, more than 13,000 temples, pagodas and

other religious structures were built. Today, seven centuries later, approximately 2,200 temples remain standing. The river Irrawaddy has washed away nearly one-third of the original city area, thieves have torn apart many temples in search of treasures, while earthquakes and the ravages of

Empire. The Romans, however, did not have the engineering or construction skills necessary for the carving and placement of the enormous blocks of stone which underlie their own constructions. The courtyard of the Jupiter temple, completed around 60 AD, is situated upon a

of stonework ever crafted in the world. Why these stones, as large as 69 feet long by 14 feet wide, are such an enigma to contemporary scientists is that their method of quarrying, transportation and placement is beyond the technological ability of any known ancient or modern builders. These great blocks of stone show extensive evidence of wind and sand erosion that is absent from the Roman temples, indicating their construction dates from a far earlier age. Finally, the stones of Baalbek show stylistic similarities to other cyclopean stone walls at verifiably pre-Roman sites such as the Acropolis foundation in Athens, the foundations of Myceneae, and the megalithic constructions of Ollyantaytambo in Peru and Tiahuanaco in Bolivia.

Canterbury Cathedral

sculptures and sold them to the British Museum. The name Parthenon refers to Athena Parthenos, the daughter the many and massive of Zeus. Patroness of Athens, she represents spiritual development, intellect and understanding, and is the symbol of the human aspiration for wisdom. The character of Athena represented these qualities yet it was the sacred geographical location, the astronomical orientation and the sacred geometry of the temple which actually generated the qualities for which Athena was known. In the Greek religious tradition particular geographical locations were known to have and express specific energetic characteristics. Therefore, while Greek sacred architecture praises the qualities of certain deities, it was understood that the deities themselves were metaphors for unique natural powers which already existed before the temples were constructed. COP29: What are the main issues at the UN climate summit in Baku

New Delhi. This month's U.N. climate summit -COP29 in Baku, Azerbaijan - has been dubbed the "climate finance COP" for its central goal: to agree on how much money should go each year to helping developing countries cope with climate-

That discussion could be tough following Tuesday's re-election of former U.S. President Donald Trump, a climate denier whose campaign vowed to remove the top historic greenhouse gas emitter and leading oil and gas producer from the landmark 2015 Paris Agreement to fight climate change for a second time.

COP29 delegates will also be looking to advance other deals made at previous summits. That refers to the new annual climate financing target, which is meant to kick in when the current \$100 billion pledge expires at the end of this year.

Wealthy nations have only sometimes met that annual goal since 2020, leading to growing mistrust among the world's climate-vulnerable nations. As COP29 aims to set a much higher target for the years ahead, wealthy nations insist the money cannot come entirely from their budgets.Instead, they are discussing a far more complex effort that would involve reforming the global multilateral lending complex in ways that de-escalate climate-linked financial risks and encourage more private capital. It is unclear how much of the total annual target would be offered by rich nations. Also unresolved is whether fastdeveloping nations like China or the Middle East Gulf oil states should also contribute, a position championed by the United States and European

By reforming the global banking system, countries hope to drive up the annual climate finance sum. U.N. agencies estimate that trillions of dollars are needed yearly, but officials with the COP29 host Azerbaijan said that a number in the "hundreds of billions" has a more realistic chance of being approved by consensus.FOSSIL FUEL TRANSITION

Last year's COP28 summit in Dubai ended with countries agreeing for the first time to "transition away from fossil fuels in energy systems.'

Since then, however, both fossil fuel use and export sales have continued to rise globally, while new areas have been approved for oil and gas production in countries like Azerbaijan, the United States, Namibia, and Guyana. With countries and companies unclear in their resolve to quit coal, oil and gas, negotiators said COP29 was unlikely to deliver timelines or stronger language on fossil fuels, though some countries might push for a halt in new coal plant permitting.

Countries will also be discussing progress in their pledge to triple renewable energy capacity and double energy efficiency, as a way of easing demand for fossil fuels. RULES FOR CARBON

Sensex drops 900 points as Trump euphoria fades, focus shifts to Fed rate decision

Stock market today: Sensex and Nifty fell sharply during Thursday's intraday trading session as investors turned cautious ahead of the US Federal Reserve's rate decision.

New Delhi. Benchmark stock market indices tumbled sharply on Thursday, as the initial euphoria following Donald Trump's victory in the US presidential election fizzled out. The benchmark BSE Sensex dropped over 900 points in early

At 10:41 am, the Sensex was down 858.03 points to 79,520.10, while the Nifty50 tumbled 281.10 to trade at 24,202.95. This U-turn came after the indices surged by over 1% on Wednesday, marking their biggest single-day gain in more than six Trump's election win, which was seen as positive for domestic equities.

However, Thursday's losses were fuelled by investors turning their focus to the US Federal Reserve's upcoming rate decision, which is expected to provide more clarity on the future trajectory of US interest rates.Key stocks on the Sensex took a hit with financial giants like HDFC Bank, Reliance Industries, and ICICI Bank among the top contributors to the losses. Sector-wise, Nifty Metal was down 1.3%, dragged by Hindalco, Adani Enterprises, and Vedanta. Other sectors, including Nifty Bank, Auto,

Financial Services, Pharma, and Consumer Durables, also opened lower, reflecting broader market weakness. Only two stocks on the Nifty50 were

trading in positive territory. Apollo Hospitals share price surged nearly 7% hitting its all-time high after reporting a

63% YoY jump in net profit for Q2FY25, driven by strong performance in its hospital business. Tata Steel was also up nearly 2% after the company reported a profit in the quarter ending September 2024, reversing a loss from the same period last year. The shift in sentiment from Trump's victory to concerns over monetary policy has left analysts divided. VK Vijayakumar, Chief Investment

Services, cautioned that the 'Trump trade,' which had lifted US markets sharply, is unlikely to have the same positive impact on Indian markets. "Indian market valuations are high, and with concerns over earnings slowdown, investors should stick to quality and value stocks in this uncertain period," he advised.

Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd highlighted the fact that foreign institutional investors continue to offload their investments from Indian markets, noting that they having pulled out Rs 1.14 lakh crore from Indian stocks in

US elections: Why renewable energy stocks tumbled after Donald Trump's win

New Delhi. Donald Trump's pledge to halt renewable energy projects on his first day in office has sent shockwaves through the industry, causing renewable energy stocks to fall sharply. Trump promised to end offshore wind farms, stating, "We are going to make sure that that ends on day one."As a result, shares of major players like Orsted, the world's largest offshore wind developer, plunged by as much as 14%, while wind turbine makers Vestas and Nordex saw declines of 11% and 7.5%, respectively. This is not Trump's first confrontation with renewable energy. During his previous campaign, he argued that solar panels require vast spaces, such as entire deserts, to generate energy. However, according to the Solar Energy Industries Association, utility-scale solar projects today typically occupy less than 600,000 acres—far less than Trump suggested.If Trump follows through on his pledge, the renewable energy sector could face severe challenges. He may



seek to eliminate or scale back tax credits for renewable projects, which could hinder the industry's growth.

Additionally, Trump could dismantle environmental regulations set by the Biden administration, potentially easing the regulatory burden on fossil fuel companies.A Trump presidency could shift energy policy, favouring fossil fuels over renewable sources. Trump has also vowed to end the electric vehicle mandate, which would impact the EV industry and its

His stance on electric vehicles has shifted dramatically after initially calling them a "hoax," he recently softened his position, partly due to support from Tesla CEO Elon Musk. Trump now claims to be "for electric cars," though his support is qualified, seeing them as suitable for a "small slice" of the population. While Trump's ability to make these changes would depend on congressional backing and potential pushback from businesses and activists, his proposed energy policies have already sparked uncertainty, causing concern among renewable energy investors.Renewable energy stocks, particularly in the solar sector, have taken a hit, with fears that a second Trump presidency could threaten the Inflation Reduction Act, which is an essential piece of legislation that has driven growth in clean energy by providing tax incentives for solar

New Delhi. Ola Electric Mobility shares saw a slight rebound on Thursday, rising by 1.41% to Rs 75.45, after two consecutive sessions of losses. The stock briefly surpassed its IPO price of Rs 76, but it remains volatile, with concerns over ongoing consumer complaints. Despite today's gain, the stock is down more than 52% from its all-time high of Rs 157.53.

The uptick in the stock price is attributed to Ola Electric's recent inclusion in the MSCI Small Cap Index, which could boost its trading volume and liquidity. Additionally, the company is set to report its Q2FY25 results tomorrow, which may also be influencing investor sentiment. A couple of days ago, Ola Electric shares plummeted over 8%, falling below their IPO price for the first



time since the lock-in period ended, hitting a

While Ola Electric has gained market share, profitability and breakeven remain key focus areas. The company has also been facing servicerelated issues, leading to increased scrutiny from the Centre. The Central Consumer Protection Authority (CCPA) issued a showcause notice to the company, further complicating its outlook.

A few days ago, Kranthi Bathini, Director of Equity Strategy at WealthMills Securities told Business Today that the stock is likely to remain weak in the medium term, though investors with a higher risk tolerance might consider holding the stock. "For those looking to enter, it may be worth waiting for lower levels, but only with a long-term view," he added.From a technical standpoint, analysts indicate the stock remains weak, with some suggesting it could fall toward Rs 70. Ravi Singh, Senior Vice-President at Religare Broking, described the stock as being in a "no-trade" zone, while AR Ramachandran, a SEBI-registered research analyst, believes it is oversold and could find support at Rs 59.4, advising buying only if the stock closes above Rs 80.3 for a potential target of Rs 100.



October CPI number is going to be very high than September: RBI Governor Das

Reserve Bank of India Governor Shaktikanta Das on Wednesday said the consumer price-based index (CPI) which accelerated to 5.5 per cent in September, is likely to escalate further in October. The Governor stated that the change in monetary policy stance in the October policy to 'neutral' from 'withdrawal of accommodation' should not be interpreted as a cut in the repo rate in the next policy, dampening hopes of the much-awaited reduction in the key policy rate. He was responding to a question that there has been some disconnect between the RBI's change in stance in the October 2024 policy and his subsequent statements in various speeches that there are "significant upside risks to inflation"."I had said in my monetary policy statement (on October 9, 2024) very clearly that in September and October, the inflation prints are expected to be higher. September came at 5.5 per cent, I reiterate today that the October CPI number is again going to be very high, perhaps higher than the September (CPI) number," he said at the BFSL Insight Summit, organised by the Business Standard newspaper.Retail inflation surged to a nine-month high of 5.49 per cent in September from 3.65 per cent in August, mainly due to a rise in food prices especially of fruits and vegetables, data released by the National Statistical Office (NSO) showed. The October CPI print will be released by the NSSO next week. The repo rate, which has been steady for 20 consecutive months, currently stands at 6.5 per cent. While a majority of economists have pencilled in a repo rate cut in the December 2024 monetary policy meeting, a section of analysts expects a reduction in the February 2025 policy meeting. To a query on

the change in monetary policy stance in October policy and his statements indicating inflation remains a significant risk, Das said the RBI's communication has been very consistent that a change in the stance gives the banking regulator optionality and flexibility to decide the future course of action.
