Children of infiltrator father and adivasi mother to be denied tribal rights

Ranchi, Nov 10: Union Minister and BJP National President J.P. Nadda during a public meeting ahead of Jharkhand Assembly elections, at Bishrampur in Palamu district on November 9, 2024.Bharatiya Janata Party president Jagat Prasad Nadda asserted that if the saffron party is voted to power in Jharkhand, it will not allow tribal rights to children of infiltrator father and local Adivasi mother. Addressing an election rally at Bishrampur in Palamu district, Nadda alleged that the JMM-led government has given shelter to Bangladeshi infiltrators and they would be driven out. "Children of Bangladeshi infiltrator father and Adivasi mother will be denied tribal rights if the BJP is voted to power in Jharkhand. It will not allow infiltration to continue," Nadda said. He alleged that "corrupt people and thieves" are part of the JMM-led government in the state. "Time has come to oust the single-engine government from Jharkhand and form a double-engine government here for all-round development," the BJP chief said. "US President-elect Donald Trump describing PM Modi as his close friend reflects India's changing image," he said. India ranks second in steel manufacturing and fifth in the mobile phone market globally. The budget for highways was increased by 50 per cent under Modi , he said. Nadda claimed that the Prime Minister worked to bring tribals into the mainstream of society. The budget for tribal welfare was increased by three times, for Eklayva model schools 21 times while around 1.5 crore toilets were built for tribals out of 11 crore toilets across the country. Addressing another rally in Bishrampur in Palamu district, he claimed that the people of Jharkhand are fed up with the JMM-led government, which is involved in corruption and appeasement politics. Justice Sanjiv Khanna be sworn in as 51st CJI today

New Delhi, Nov 10: Almost 48 years after legendary Justice HR Khanna's supersession; his nephew Justice Sanjiv Khanna will be sworn in as the 51st Chief Justice of India today. President Droupadi Murmu will administer the oath of office to Justice Sanjiv Khanna at Rashtrapati Bhavan in a ceremony at 10 am. He will succeed Justice DY Chandrachud, who retired. Appointed as a Judge of the Supreme Court of India on January 18, 2019, Justice Khanna will have a six-month tenure as the CJI. He will retire on May 13, 2025. The Centre had notified his appointment as the next CJI on October 24 following Chief Justice Chandrachud's recommendation on October 16. There has been a convention of the CJI recommending the senior-most judge of the Supreme Court as his successor. Only twice, it was not followed - Justice AN Ray was appointed the 14th CJI on April 25, 1973 superseding three senior-most judges and Justice MH Beg was appointed the 15th CJI on January 29, 1977 superseding Justice HR Khanna. Justice HR Khanna was denied the appointment as the CJI by the Indira Gandhi Government for his sole dissenting opinion in ADM Jabalpur versus Shivkant Shukla (1976) on suspension of fundamental rights during Emergency. BSF catches 200 drones at border, says Pak trying to 'destablise' India with drugs

Navdeep Singh Sahni New Delhi, Nov. 10: BSF recently recovered four more drones within the last 24 hours, the total number of rogue drones seized from Pakistan along this border now exceeds 200. Drone interceptions along the Punjab International Border have surged to 200 as Pakistani networks persist in smuggling narcotics and weapons, aiming to "destabilise" India by promoting drug addiction among youth and "disintegrating" social harmony, according to the Border Security Force (BSF), cited by news ageny PTI. The BSF announced in a statement on Saturday that with the recent recovery of four more drones within the last 24 hours, the total number of rogue drones seized from Pakistan along this border now exceeds 200. The BSF is responsible for guarding 2,290 km of the western border along India, including a 553 km stretch along Punjab. This borBorder (IB), continues through Jammu tion of advanced technical countermea-(in Jammu and Kashmir), as well as Rajasthan and Gujarat. The BSF report- intensified anti-drone tactics, delivering



ed that it seized 107 drones along the Punjab border in 2023, which has nearly doubled this year. Calling the uptick in drone captures a "significant landmark" and a "remarkable milestone," the BSF attributed this success to "enhanced antidrone strategies" and the implementa- across the border.

tion from locals. Most of these drones, according to the officer, are Chinesemade and typically carry drugs, firearms, and ammunition. Among the various payloads, drugs constitute the largest share of items being transported

It also promises a strict law to bring forced conversions to zero. No compromise on education policy for central funds: Minister Poyyamozhi

RANIPET: Tamil Nadu will not compromise on its education policy in order to receive union government funds, School Education Minister Anbil Mahesh Poyyamozhi said on Saturday. He was speaking to reporters after conducting an inspection at Panchayat Union Middle School in Arakkonam."The union government's three-language policy is against the state's education policy. We are also against conducting public examination for classes 3, 5 and 8. Tamil Nadu will not compromise on its education policy at any cost to receive funds from Delhi. We can manage all our requirements, including classrooms and laboratories, with state funds," Poyyamozhi said.

The minister also shared updates on initiatives being taken for government school students. "Under Chief Minister MK Stalin's directive, a total of 3,192 new teacher appointments have been finalised. Enrolment in government primary schools is on the rise. In fact, a recent union government report indicates that 98.8% of students in the state have been enrolled in government schools," Povyamozhi said. Dharmapuri-Morappur rail project works in slow lane

DHARMAPURI: Residents and rail passenger associations have raised concerns that the Dharmapuri-Morappur railway line project has been treading water, despite the centre allocating Rs 100 crore in the budget during the 2023-2024 fiscal. Establishing a rail link between Dharmapuri and Morappur has been a 25-year-long demand.ailway Passenger and Social Welfare Association (RPSWA) district secretary Mathialagan said a 36-km railway line between Dharmapuri and Morappur existed during the British period -- built in 1906 and discontinued in 1941. He told that the line, intact at most parts, would connect Dharmapuri with Chennai and could be critical for the district's development. "At present, we have no trains from Dharmapuri Junction. To board Chennai trains, we need to reach Morappur which is 30 kilometres away," he said. Dharmapuri resident K Gopal said, "Railways Minister Piyush Goyal, during his visit in 2019, announced the project with an estimate of Rs 358.95 crore. However, in 2023-2024 union budget, Rs 100 crore was allotted. 13 revenue officials were appointed to oversee the construction and land acquisition. Since then, there has been no update." K Balan, an RPSWA member, said the fund allocated for the project was reduced to Rs 49.37 crore earlier this year. However, speaking to, officials from the South Western Railway attributed the delay in progress solely to hitches in land

People's Democratic Party to continue its support for Left front in upcoming bypolls

KOCHI: The People's Democratic Party (PDP) will continue to extend its support to the LDF in the upcoming Wayanad, Chelakkara and Palakkad bypolls.

Sky's the limit for Marut Drones

HYDERABAD: While the recent Series A funding of \$6.2 million for drone tech firm Marut Drones will help it establish itself as a nationwide provider of comprehensive drone technology, the DGCA-certified company for manufacturing drones and training operators is still prioritising agricultural productivity. This apart, the Hyderabad-based firm is eyeing expansion into the defence, surveillance and disaster management sectors.In Telangana, drones made by the firm have proven invaluable across sectors: they assist the GHMC in mosquito control for

dengue and malaria prevention, aid reforestation efforts with the Forest department and provide the Hyderabad police with surveillance capabilities during major festivals. In an interaction with TNIE, Marut Drones co-founder and CEO Prem Kumar Vislawath shares that the company is looking to leverage this amount to expand the channel and dealer network across the country. "We want to increase the accessibility and build more service centres in order to address onsite technical issues near the customers' farms. We are also looking to improve infrastructure for manufacturing model drones with upgraded technology. Presently, we have a



manufacturing capacity of 50 drones per month. We will be scaling it to 100 to 300 drones per month with a target of building 3,000 in a year," Vislawath, who cofounded the company in 2019 along with IIT-Guwahati batchmates Sai Kumar and Suraj Peddi, says. The firm, with a team of around 200 members, also plans to hire more senior professionals. With five drone training centres - in Maharashtra, Madhya Pradesh, Uttar Pradesh, Haryana and Andhra Pradesh - for drone pilot licencing valid for up to 10 years, Marut Drones plans to augment the number to at least 15 by March 2025, particularly in Tier-II and III cities. In Telangana, there is a centre at NIPHM, Hyderabad, and another one in pilots across 14 states."The idea to set up centres in rural areas is to reduce the expense for our customers. By setting up centres near them, we feel that we can bring more people into the sector, especially farmers who can get drone service in their villages," explains Vislawath.Detailing how drones help farmers, he says, "It helps in spraying [different additives] in fields with thorns or crops like sugarcane where there are snakes and mosquitoes, among others. Moreover, they can cover 20-30 acres in 10 to 12 minutes.

To train 500 women by March

Marut drones have already imparted training in spraying pesticides and crop monitoring to 180 women from various SHGs, including 90 from Prayagraj and 60 from Motihari. The firm has an initial target of training at least 500 women by March 2025. Women from Karnataka and Tamil Nadu

SHGs were also trained in Hyderabad this year," Vislawath says. "Fertiliser companies like IFFCO and KRIBHCO manage them and provide work. The women from SHG groups use drones to assist farmers with spraying. Farmers pay for the fertiliser and the fertiliser companies pay the women for their services."

Warangal. At present, the company has a Nurturing 'village-level entrepreneurs'

fleet of 750 drones and over 1,000 drone Vislawath points out that their focus is not on getting farmers to buy drones, but on encouraging unemployed youth or those who have completed their education in Industrial Training Institutes (ITIs) to act as mediators or, as he calls them, village-level entrepreneurs.

> "Generally, we discourage farmers from buying drones and instead ask them to use the service. A majority of farmers have 5 acres of land or less. So, rather than handling it themselves, we encourage them, and also suggest at agricultural exhibitions, that unemployed youth, ITI graduates, existing tractor drivers, harvesters, or autorickshaw drivers take up the role. We help them purchase drones through loans and subsidies, allowing them to provide services to multiple farmers and generate revenue for themselves," he says. Currently, the three drone models manufactured by Marut Drones - AG365H, AG365 and AG365S - cost around '10 lakh on average and weigh around 30 kg with a payload ability of 10-15 kg.

IAS officers spar over attendance, FB post lands Prasanth in trouble

In his first post on the day, Prasanth explained his version of the allegations against him. He made another post saying that Jayathilak was serving as a "special reporter" to the daily which published the news report.

'I'm compelled to reveal some facts about senior IAS officer Jayathilak who prepares adverse reports against me and promptly submits them to the daily. I am forced to reveal some facts about him which the public should know," Prasanth posted.He added: "Though I don't like discussion on government files in the public domain, I have no other option. I intend to reveal things that would be available under the Right to Information Act. He is a great person who himself proclaimed that he would be the next chief secretary. So, one should have fear and respect towards him."

Worker charred to death as massive fire engulfs factory in Bengaluru

BENGALURU: A 25-year-old man was charred to death when a massive fire broke out at Sri Ram and Co. wood factory in Attibele Industrial Area on the Hosur-Bengaluru Main Road early on Saturday morning. The deceased has been identified as Govind Kumar of Gorakhpur in Uttar Pradesh. He was reportedly sleeping inside the factory at the time of the incident. Around 25 labourers work in the factory and stay in sheds. After the fire broke out, all of them came out, except Kumar. His body was found near a wood pressing machine.Factory owner Harshad Patel told the police that the fire was noticed around 3.30 am. The fire department received the call to their control room at 3.52 am. Fire stations at



Sarjapur and Anekal, including others in the vicinity, were immediately alerted and more than six fire tenders were rushed to the spot. The fire was brught under control after about five hours. Timber stacks, machines and other materials were completely gutted in the incident. The flames were contained before they could spread to the adjacent food factory. The fire was brought under control after about five hours. Local water tankers were also used to douse the fire."The exact reasons for the fire are not known yet. An electrical short circuit is being suspected. The loss is estimated at around Rs 5 crore. The owner has stated that there were no lapses from his side and they have all the required permission. Housing project for SC/ST, pourakarmikas yet to get approval

BENGALURU: The Bruhat Bengaluru Mahanagara Palike (BBMP) pourakarmikas and eligible SC/ST community members who were selected among 1,110 applicants for the allotment of sites measuring 20x30 feet in Dasanapura Hobli in Bengaluru North and Kengeri Hobli (Bengaluru Urban) expressed frustration over delays by the BBMP welfare department and Urban Development Department in forming layouts and allotting these sites. Secretary of Bahujan Vimochana Chaluvali

Gangadhar launched a scathing attack against the BBMP and the state government, stating, "The BBMP and revenue department has contributed nothing in identifying land. Activists have been persistent, securing 29 acres in 2008, yet eligible beneficiaries have struggled for years as the Palike delayed layout formation."Gangadhar also alleged that



Rs 42 crore has been allocated from BBMP's consolidated (Special Component Plan and Tribal Sub Plan SCP/TP) fund of 450 crore but the file for approval is pending before the administrator."The BBMP welfare department has proposed to construct a complex and allot houses but we rejected the proposal, as our community has long fought for land rights. Once the BBMP

gets the administrator's approval for the formation of the layout with Rs 42 crore allocated under the Special Component, community members will begin constructing their houses," said Gangadhar. Of the total land, 22 acres were designated in Dasanapura Hobli and 7 acres in Kengeri Hobli. In 2018, the Urban Development Department, Bengaluru directed BBMP to fence these areas. However, due to the assembly elections, the land process was delayed.

'In 2023, we raised the issue with Chief Minister Siddaramaiah and Deputy Chief Minister (DCM) and Bengaluru Development Minister DK Shivakumar. "Despite the DCM's directive to expedite the process, progress is very slow. The money has been already sanctioned by the BBMP accounts department and the proposal has been sent to the administrator. 40 days have passed with no approvals," said a pourakarmika

Waqf issue needs deft handling, not rabble-rousing

BENGALURU: Most political issues have a shelf life. They peak during elections and taper off soon after that. However, the Waqf land controversy, which has raised a political storm in Karnataka and created ripples in other poll-bound states, is unlike others. If the allegations made by the BJP leaders and claims by farmers are anything to go by, this could have serious repercussions on people who are apprehensive about losing their properties as well as on the social fabric.

In the run-up to the November 13 bypolls to three assembly segments in Karnataka, and fiercely fought assembly polls in Maharashtra and Jharkhand, leaders from Congress, BJP, and other political parties are engaged in a bitter political slugfest over the Waqf Board's notices to farmers and changes in the land records. Beyond elections, the issue could have far-reaching consequences. When the Waqf Amendment Bill 2024 was proposed by the NDA government in August this year, the Congress-led opposition termed it as "vendetta politics" against minorities. However, the aggressive stance by the state government and Waqf board put Congress on the back foot and weakened its larger strategy to oppose the Bill at the national level. As the notices about land records left several farmers aggrieved, it also raised

questions if the Congress and its government's attitude had emboldened officials to go overboard with their actions. In some cases, changes were made in land records without even issuing notices.

While the Joint Parliamentary Committee (JPC) on the Waqf Amendment Bill 2024 is looking into the amendments to the law, on its part, the State Government had not anticipated such a backlash to its aggressive measures.Now, after farmers started expressing concerns and opposition BJP raised the matter in Karnataka and other states, the Siddaramaiah government has gone into a damage control mode.Although it announced

that the notices served to farmers would be withdrawn and no genuine landowners would be evicted, new cases of people noticing changes in land records are coming to light from many parts of the state.

As JPC Chairman Jagadambik Pal put it, complaints were pouring in from many districts and there was a 38% increase in issuing of notices in the last two months after the parliamentay committee was formed.Pal, who visited Karnataka earlier this week to meet the aggrieved persons, also claimed that modifications to the land records could not have been done without



the complicity of state officials. The state government criticized the JPC chief's visit, terming it an attempt to mislead people. Purely going by the procedural aspects of the functioning of the JPC, its chief's visit to the state to meet aggrieved persons may be unusual. However, since Karnataka has become the epicentre of the controversy, one has to consider its possible impact on the JPC's exercise. The committee will soon be submitting its report.

Karnataka Minister for Housing, Minority Welfare and Waqf, BZ Zameer Ahmed Khan, and his department may be asserting the provisions of the law to deliver benefits to the community. Of the 1.08 lakh acres of Waqf property, nearly 85,000 acres have been encroached, the minister claimed during a Waof Adalat in Kalaburgi

SUV breaks toll barrier, 3 held for thrashing staff

Noida: Three men who allegedly crashed their SUV through a toll barrier on the Yamuna Expressway on Nov 7 and assaulted toll plaza workers were arrested on Saturday, cops said. Police are on the lookout for two other men who were also in the car. The men -SUV's owner Abhishek Nagar, his friends Anshul Chandila of Kherli village and Anuj of Junaidpur village — ploughed through the toll barrier near the 11km milestone of the speedway around 11.30pm. The men later got down from their car and assaulted two plaza employees with sticks.A CCTV grab of the incident, circulating on social media, shows the toll plaza staffers trying to stall off the attack by trying to force shut the booth's doors. On Saturday, a police team from Dankaur detained Nagar and Chandila near Galgotia underpass and Anuj in Junaidpur.

Additional deputy commissioner of police(Greater Noida) Ashok Kumar said they are looking for two more culprits.An FIR was lodged under various Bharatiya Nyaya Sanhita (BNS) sections for rioting, attempted murder, causing harm, intimidation and vandalism."The SUV has been seized", an official said.

Illegal stalls, kiosks razed in Basai

Gurgaon: MCG enforcement team conducted an antiencroachment drive in Sector 37 and Basai on Saturday, against temporary encroachments like stalls, kiosks, tin sheds and similar structures on roads and side-walks. Encroachers were given a stern warning against committing the offence."We are taking action against encroachments under a zero-tolerance policy. Encroachments on roads result in traffic congestion. Similarly, encroachments on side-walks force pedestrians to walk on the road, which exposes them to the risk of accidents," said MCG commissioner Ashok Kumar Garg.MCG enforcement teams conducted a similar anti-encroachment drive in Oct last week in areas along Sohna road and the road connecting sectors 27 and 28.

The enforcement teams demolished temporary and permanent food stalls, shanties, tin-shed structures and kiosks that were illegally occupying public spaces. MCG and GMDA, in a joint operation in Oct, removed street vendors and illegal structures along roads and footpaths of Agrasen Chowk and Sector 12 bus stand.

Biker on way home dies in hit & run

Gurgaon: A man on his way home from office on a bike died after he collided with a truck in Bilaspur on Thursday evening. Dharmendra, an auto driver from Kalwadi village in Nuh, said he was headed home when a young biker moving ahead of him was hit by a truck coming from the opposite direction around 8.30pm on Thursday.

Dharmendra said he stopped his auto-rickshaw and realised that the biker hit by the truck was Rahul from his village. As the truck driver fled, he took an injured Rahul to the hospital in his auto, but doctors declared him dead on arrival. A case was registered against the accused at Bilaspur police station under sections 106 (death by negligence) and 281 (rash and negligent driving) of the Bharatiya Nyaya Sanhita (BNS) following a complaint from Dharmendra.Rahul worked with a manufacturing unit in Bilaspur."The body was handed over to his family after an autopsy. We have initiated efforts to track the truck driver," said a spokesperson for Gurgaon police.

2 bros die as their car rams truck parked near landfill

Gurgaon: Two brothers died after their car crashed into an MCG garbage truck parked near Bandhwari landfill on Gurgaon-Faridabad road early on Saturday.Rahul (30) and Kuldeep (26) were on their way to Gurgaon with two friends in their Volkswagen Polo when they rammed the truck from behind just 100m from the Faridabad-Gurgaon toll plaza. The truck, police said, did not have any indicators on, making it difficult for the victims to see it from a distance at night. Rahul was driving the Polo, his brother was seated beside. Their friends Rajat (27) and Satender (25) were in the back seat. All four were pulled out of the mangled car and rushed to BK Hospital in Faridabad, where Rahul and Kuldeep were declared dead on arrival. Rajat and Satender were shifted to another hospital after their condition deteriorated."The car was speeding on a deserted road when it crashed into the stationary garbage truck. It was carrying garbage to the landfill in Bandhwari," an officer said.

"The truck did not have any lights on, which is why the four friends could not spot it from a distance. We have registered a case and launched an investigation into the circumstances leading to the accident," he added.

The accused truck driver fled the spot, leaving the vehicle behind. A case was registered against him under sections 106 (causing death by negligence), 285 (danger or obstruction in public way or line of navigation), 125(a) (causing hurt by act endangering life or personal safety of others) 125(b) (causing hurt by act endangering life or personal safety of others) and 324(4) (mischief causing damage to the amount of Rs 20,000 and more but less than Rs 1 lakh) of BNS at DLF Phase-1 police station."An investigation is underway to find out why the dumper carrying garbage was parked on the road when the landfill was so near," said Sandeep Kumar, a police spokesperson.

It was only on Diwali that Kuldeep opened a restaurant at NIT Five colony. The restaurant was a family project, with both Rahul and their father actively supporting

Rahul, who married two years ago, was helping establish the family business while also managing his own responsibilities. The family was making preparations for Kuldeep's wedding."They are originally from Etah in UP, but moved to Faridabad four decades ago. The parents are distraught, unable to cope with the loss of their sons in an accident," a relative said. Residents raised concern about rising accidents on city roads because of illegally parked vehicles. It's more of a concern at night. People drive fast and are unable to see these parked vehicles from a distance. By the time they do, it's too late. The situation will get worse during winter, when visibility is heavily compromised," a resident said.

Decade after NGT ban, old cars an unsolved pollution problem

Noida: End-of-life vehicles (ELVs) are among local reasons that worsen air pollution around you due to a combination of outdated technology and increased emissions.But their extended run on NCR roads, because of slack enforcement and unwillingness of vehicle owners to let them go, is an aspect of the fight against pollution that has received little attention.

Winter or summer, vehicular pollution remains the predominant contributor to high PM2.5 levels in the Delhi air shed. In Noida and Ghaziabad, ELVs make up around 20% of all vehicles registered, so their share in total emissions will be no insignificant one.ELVs, defined in Delhi-NCR as petrol vehicles that are more than 15 years old and diesel vehicles above 10, were banned by an order of the National Green Tribunal (NGT) in 2015. But scrapping has been slow, and without a tracking system that is monitored end to end, police and the transport department don't quite know the status of ELVs.Gĥaziabad has four scrapping centres - Seven Star Auto Scrap, Saral Auto Scrapping India, MSSS Enterprises and Herwin Motors Industries Pvt Ltd - while Gautam Budh Nagar has Maruti Suzuki Toyotsu India in Noida (Sector 80) and Mahindra MSTC Recycling in Ecotech-1 (Greater Noida).

If vehicles come to these centres, then the regional transport office will know. Problem is, very few come. So far, going by RTO estimates in Noida, around 25,000 vehicles have been scrapped. This is only around 15% of the 1.86 lakh ELVs identified from vehicles registered in the city. Some may have gone to unauthorised scrap workshops and some sold or shifted to

residents living outside NCR where the NGT ban does not apply. But it's likely that a large number of these ELVs are still on roads.Nawab Khan, owner of Seven Star Auto Scrap, told TOI there is lack of awareness among vehicle owners due to which the pace of authorised scrapping is slow. "We scrap only 10-15 vehicles per month. If the govt takes up this initiative and raises awareness, then the number of vehicles that are brought here will certainly go up," he said. Khan has been



running his facility for one and a half years.Between Noida and Ghaziabad, these are 4.2 lakh ELVs. Of these, around 90,000 are relatively higher polluting diesel vehicles. Noida has 1.5 lakh petrol ELVs and around 39,000 diesel ELVs while Ghaziabad has 2.9 lakh petrol ELVs and around 50,000 diesel ELVs.

For authorised scrapping, ELV owners need to submit a form on the Parivahan portal, share vehicle details, select the scrapping centre, and submit the form. The scrapping centre evaluates the vehicle

and quotes a price for the ELV. If the owner agrees to the price, the staff come to pick the vehicle up. Then a certificate is issued to the ELV owner, which can be submitted to the ARTO to deregister the vehicle.Udit Narayan Pandey, assistant regional transport officer (ARTO-enforcement), Noida, admitted "the pace of scrapping is slow"."The transport department is conducting a drive targeting ELVs in compliance with GRAP (graded response action plan) and directives from NGT," he said. The transport department has decided to take data from toll plazas to track ELVs. "We

will take details of vehicles from toll plazas in Jewar and the Noida-Delhi borders. Teams will issue fines if they are caught on the spot," he added.

PK Singh, regional transport officer of Ghaziabad, said a similar drive is on in the city. "We will further expedite the process," he said. Last month the UP govt announced a 75% tax exemption for vehicles registered before 2003 and a 50% rebate for those registered before 2008 upon scrapping.

Need more info: 85% property ID complaints sent back to owners

Gurgaon: Around 85% of complaints filed by residents regarding rectification in their property IDs have been returned for lack of documents and information, data sourced from municipal corporations have shown. Across the state, there are 74,227 complaints that are yet to be resolved despite being filed months ago. Of these, the NCR districts of Gurgaon and Faridabad account for 30%. At almost 90%, the number of applications returned to property owners is even higher in these two districts. Ashok Garg, who assumed office as Gurgaon municipal commissioner on Tuesday, expressed concern at the sheer number of applications rejected by civic bodies."The high number of objections being returned to property owners raises significant concern. This should not have happened. I will examine the process and initiate improvements wherever required," he told. And it's not just Garg. Chief minister Nayab Singh Saini had also expressed concern over the high volume of unresolved complaints in a closeddoor meeting with officials, sources said. Property IDs — which are a must

paying taxes or even issuing water bills were made mandatory by Haryana govt to bring transparency in the system. But in the run-up to the recent assembly elections, it came under severe criticism of opposition parties, who claimed that the documents were riddled with errors and mismatches and caused much inconvenience to people.Most of the complaints were returned to owners over lack of clarification and documentary evidence. For example, an application that sought to fix property dimensions in govt records was sent back to the owner, seeking documents that proved the claim. The applicant is required to submit the documents online. Officials said there were many who were not even aware that their complaints had been sent back, causing significant delays."It's ironic that this online system was actually designed for effective delivery of services, but is now posing a major challenge. Not all residents are tech-savvy. When complaints are sent back to residents, many of them do not follow up on them. This adds to the pendency list," a

for executing registries, sale deeds, The 74,000-odd complaints weren't only filed online. Some of these application forms were filled in Samadhan Shivir camps in the presence of govt officials, raising questions on their efficacy.

Among the aggrieved residents is James Lobo of Sushant Lok-3. Lobo applied for a property ID a year and a half ago, but is yet to get one."All of a sudden, I discovered that MCG records suggest that I have dues worth Rs 12,000. Moreover, details of the property seller are incorrect. I am concerned about paying Rs 12,000 against wrongly listed sellers, particularly for a newly constructed property. Plus, there is discrepancy in the property size as well. Records show it's 350 sq yards, but the actual measurement is 300 sq yards," he added. What's more of a concern is that another resident of my tower has successfully obtained a property ID despite pending dues. So, how are complaints being addressed? Despite numerous online submissions and visits to the MCG office, my complaints are being sent back without any resolution," Lobo said. Sachin Kalra, a resident of Sector 52, attended several camps to register a complaint

Industry body will cancel land allotment if lease deed delayed

Ghaziabad: Uttar Pradesh State Industrial Development Authority (UPSIDA) board has approved a proposal to annul residential land allotments if lease deeds are not executed within two years. In its recent meeting, the board also gave a nod to a proposal to impose additional charges if allottees fail to start construction on plots allotted to them even after two years. Once implemented, several of the over 5,000 allottees in Tronica City may lose their plots or cough up hefty extension fees — to be levied at the rate of 1% of a plot's cost for the first year and an additional 1% for each year thereon till the fifth year. Thereafter, one will have to pay 4% of the prevailing land rate in the respective sector per



The Trans-Delhi Signature City in the Tronica area bordering Delhi, conceived in 2000, is spread over 1,700 acres. Around 5,200 residential plots were carved out at the housing society at the rate of Rs 24,000/sqm. Over the years, the Authority allotted 5,013 plots, while 187 plots are yet to be sold."Several of the 5,013 allottees are yet to get the lease deeds executed. Construction is yet to start at several others," UPSIDA project officer Sharmila Patel said.

Patel told that UPSIDA will give allottees additional time to execute lease deeds if they do not do so within the first 90 days of allotment. If lease deeds are executed within the first 90 days of allotment, the plot buyer will get a waiver on the interest levied for the documentation process too.

'An allottee will have to pay interest if the lease deed is executed within the next 90 days, that is between the 91st day to the 180th day," Patel said. Allottees will have to apply for the paperwork and pay an extension fee too — 1% of the plot's total cost for the first year, which will go up to 2% of the land's rate, if an extension for executing the lease deed is sought for the second year."If allottees fail to apply for an extension for lease

Columbia. One of 43 monkeys bred for medical research that escaped a compound in South Carolina has been recovered unharmed, officials said Saturday. Many of the others are still located a few yards from the property, jumping back and forth over the facility's fence, police said in a statement. The Rhesus macaques made a break for it Wednesday after an employee at the Alpha Genesis facility in Yemassee didn't fully lock a door as she fed and checked on them, officials said.

The monkeys on Friday were exploring the outer fence of the Alpha Genesis compound and were cooing at the monkeys inside. The primates continued to interact with their companions inside the facility on Saturday, which is a positive sign, the police statement said.

Alpha Genesis CEO Greg Westergaard relayed that efforts to recover all the animals will persist throughout the weekend and for as long as it takes, the statement said. The monkeys are about the size of a cat. They are all females weighing about 7 pounds (3 kilograms). Alpha Genesis, federal health officials and police all said the monkeys pose no risk to public health. The facility breeds the monkeys to sell to medical and other researchers. Alpha Genesis provides primates for research worldwide at its compound in Yemassee, about 50 miles (80 kilometers) northeast of Savannah, Georgia, according to its website.

Smog enveloped Lahore and Multan region in Pakistan after the air quality index rose to 760 and 1,914 respectively, reported news agency ANI.Multan has become the world's most polluted city, due to which authorities are trying to find aways to control the pollution levels. On Friday morning, Multan's AQI crossed the 2000 mark on Air Quality Index reading, as per Dawn.

Authorities had not applied any methods to control the smog until now and citizens reportedly failed to wear their masks as well.In Lahore, heavy smog led to wide-scale road closures for the second day consecutively as several points on roads were blocked for traffic. At least 9 people were injured in a road accident near Kalashah Kako on GT Road, Mureed K when a van crashed into a truck due to low visibility, reported ANI.All markets and trade activities are closed today based on directives by the Lahore high court. On other days of the week, markets have been instructed to wrap up by 8 pm. The situation in Pakistan's Punjab s even worse, with the government implementing measures to bring down pollution levels and issuing a high alert. The state has closed parks and museums till November 17. The Punjab education department has ordered the closure of tuition centres and academies as well as private and public schools up to the higher secondary level across

affected districts until November 17 too. The concentration of PM2.5, a fine particulate matter in the air that negatively impacts health, was 947 micrograms per cubic metre, which is 189.4 times above the WHO guideline, as per IQAir. The global health body considers anything over five micrograms per cubic metre as hazardous.

Donald Trump wins Arizona, clinches all 7 swing states in US election victory

Donald Trump won the battleground state of Arizona, completing a sweep of all seven battleground states in the 2024 US presidential election.

World. Donald Trump completed a clean sweep of all seven swing states in the US presidential election, securing victory with a projected win in Arizona. The Grand Canyon State, which holds 11 electoral votes, was the last battleground to declare its result, putting Trump's total at 312 electoral votes against Vice President Kamala Harris's 226. Trump's dominance in swing states—including Pennsylvania, Michigan, and Wisconsin—proved decisive in handing him the presidency for the second time. Arizona, which had leaned Democratic in recent years, was the cherry on top.In 2020, President Joe Biden narrowly won the state, becoming the first Democrat to do so since Bill Clinton in 1996. Trump's victory this year represents a significant shift, flipping Arizona back to the

Republican column. During his campaign, Trump talked up issues of border security, immigration, and crime involving illegal immigrants, topics that resonated strongly in Arizona following a record migrant influx in 2023.He tied Harris and the Biden administration to rising inflation and record-high illegal border crossings, promising to tackle these challenges with mass deportations and a

planned hiring of 10,000 additional border agents. Trump also pledged to reallocate portions of the military budget to strengthen border security.

These promises appeared to sway voters, particularly in a state with marked demographic shifts. Arizona is home to the fourth-largest population of Hispanic voters, a demographic with which Trump made notable gains in 2024, according to polling data. The win in Arizona marks the sixth state that Trump has flipped from Biden's Electoral College victory in 2020.

Other Biden-won states where Trump prevailed this year include Georgia, Michigan, Nevada, Pennsylvania, and Wisconsin. Trump also secured North Carolina, a state he eked out a win in last time but which Harris had fiercely contested in this election.On Saturday, The Associated Press called Nevada, another battleground state, for Trump, awarding him the state's six electoral votes. He was declared the winner after it became apparent that there weren't enough uncounted ballots in the state's strongest Democratic areas to overcome the Republican's 46,000-vote lead over

Beating projections of a close contest, Trump clinched a second term early on Wednesday when Wisconsin pushed him past the 270 electoral votes needed to win. He also won the popular vote, a first for him in his three runs for the White House. Trump will take office on Inauguration Day, January 20, 2025, on Capitol Hill, in Washington.

Canada's Brampton Hindu Temple Suspends Priest Allegedly Fueling Clashes

Ottawa: The priest of a Hindu temple in the Canadian city of Brampton has been suspended for spreading "violent rhetoric" during recent clashes between protesters carrying Khalistani flags and the people present there. On November 3, the protest occurred at the Hindu Sabha temple in Brampton and unverified videos circulating on social media appeared to show demonstrators holding banners in support of Khalistan. The videos showed fist fights and people striking each other with poles on what appears to be the grounds surrounding the temple.

The protestors carrying Khalistani flags clashed with people and disrupted a consular event co-organised by the temple authorities and the Indian Consulate. On Wednesday, a statement from the Hindu Sabha Mandir said the suspension was due to the priest's "controversial involvement" with protesters on Sunday, but did not elaborate, the Canadian Broadcasting



Corporation reported. Taking to X, Brampton Mayor Patrick Brown said the priest spread "violent rhetoric," asking the community not to respond to violence and

"Remember we all have more in common than what divides us. In tense times, we can't let the agitators fuel the flames of division. The leadership of both Sikh and Hindu communities in the GTA do not want this division, hate and violence. I am asking everyone in the community to not respond to violence and hate. Law enforcement will be there to respond.

This is their job. We must continue to be the country where the rule of law is followed," the post further read.

The violence initially broke out at the Hindu temple in Brampton on Sunday afternoon after members of a group called Sikhs for Justice held a protest while Indian consular officials were visiting. Officers were dispatched to the property around noon, Peel police said. The Sunday incident was condemned by Canadian Prime Minister Justin Trudeau who said every Canadian has the right to practise their faith freely and safely. Trudeau thanked the local authorities for the swift response to protect the community and probe this incident.

India condemned the attack with an expectation that those indulging in violence "will be prosecuted".

In a statement, the Ministry of External Affairs said that New Delhi remains "deeply concerned" about the safety and security of Indian nationals in Canada. The relations between India and Canada came under severe strain following Prime Minister Justin Trudeau's allegations in September last year of a "potential" involvement of Indian agents in Khalistan extremist Hardeep Singh Nijjar's killing. New Delhi rejected Trudeau's charges as "absurd". India has been maintaining that the main issue between the two countries is that of Canada giving space to pro-Khalistan elements operating from Canadian soil with impunity.

RAJANNA-SIRCILLA: Unable to bear the burden of mounting debts, a powerloom owner and his wife allegedly hanged themselves to death at their residence in Vempeta, Sircilla town, on Saturday afternoon. According to sources, the victims - Bhairi Amar, 48, and Sravanthi, 45 were under financial distress owing to the downturn in the powerloom sector and did not have any work orders from the government or private organisation for months. They are survived by their three children.A local BRS leader, Diddi Raju, who is also a part of the weavers community, told reporters that Amar was buried in debt due to a lack of work orders and had already sold four of his looms to a scrap dealer to sustain himself and his family. "According to Amar's relatives, the couple had borrowed'95 lakh, including a housing loan from a bank," Raju said, urging the government to intervene in the matter and prevent such incidents in the future."Otherwise, the entire powerloom sector will be finished in the region," the BRS leader said. He claimed that the situation has left the powerloom weavers and owners gripped by fear and uncertainty. Railway revises Dasapalla to Sonepur stretch for movement of wildlife

BHUBANESWAR: A major bottleneck concerning the long-pending Khurda-Balangir railway line is likely to be resolved soon as the Indian Railways has agreed to create additional structures on the Dasapalla-Sonepur stretch and sought the state government's consent to share 50 per cent cost.Sanctioned in 1994-95, the 301 km project was stuck due to many issues like court cases, land acquisition and forest clearance. After the forest clearances obtained for the 68 km Dasapalla-Purunakatak, it has been decided to create additional facilities for movement of wildlife as the 140 km Dasapalla-Sonepur stretch passes through hilly terrain and reserve forests. Accordingly, the East Coast Railway (ECoR) has revised the estimate for the 140 km stretch to Rs 3,284.19 crore, excess by Rs 1,297.7 crore as compared to its earlier estimate. The excess estimate includes additional facilities like tunnels, bridges and animal over and under passes worth Rs 640.8 crore and the rest due to price escalation.Dasapalla-Sonepur stretch was sanctioned at a cost of Rs 1,986 crore in June 2016. The state Forest department and the Ministry of Environment, Forest and Climate Change had recommended to create facilities to safeguard the forest envelope and protection of wild animals including elephants during the approval. Source said, the ECoR has revised the estimate by incorporating several changes like construction of tunnels, viaducts (bridges), new bridge openings, elephant over and under passes in compliance with the forest and wildlife clearance. As the Dasapalla-Purunakatak stretch passes through dense forest and Baisipalli wildlife sanctuary, it involves 597 hectare of forest land. Five tunnels with a combined length of 10.11 km will be dug at a cost of Rs 200 crore for smooth passage of animals while reducing the disturbance to the habitat as well as forest cover. Around one lakh trees will be saved due to the tunnels.

Women end the judiciary gender skew in Kerala

KOCHI: Gone are the days when the judiciary was a male bastion that women found hard to break into. And, Kerala is leading the charge, with the gender spread in the state's district judiciary reflecting the change. The number of women serving as judicial officers, including magistrates and session judges, in the state's district judiciary is rising. The reply to an RTI application filed by TNIE reveals that out of the 539 serving district judicial officers, 260, or just over 48%, are women as on September 12, 2024.Of the 36 officers who recently completed their one-year induction training for civil judges (junior division) at Kerala Judicial Academy, 26



of India DY Chandrachud had highlighted the development in a recent speech.Women excelled in the Kerala Judicial Service Examination, 2023, with 75 candidates securing a spot in the rank list. Fifty candidates have been appointed from the latest Kerala Judicial Services Examination rank list as civil judge (junior division) trainees. There are currently 36 female candidates among the 50 trainees undergoing the one-year pre-induction training at the judicial academy. Appointment of civil judge officers in the judicial service will take place only after the completion of training, the RTI reply from the Kerala High Court said. The picture is different when it comes to the Kerala High Court, Among the 45 judges, only four are women.

Experts said the trend points to a progressive shift, highlighting the expanding role of women as key contributors to the judiciary's future.

'68 women district and sessions judges in state, says RTI reply

(72%) were women. Former Chief Justice S Vijayakumar, former NIA/CBI special

judge, told TNIE women form almost half of the total population in India but their presence and percentage in vital fields of society has been meagre or insignificant. However as time advances their numbers come up. Kerala judiciary is no exception, said Vijayakumar.

"In the recent past, the number of women judges in the district judiciary, especially at the entry level here, has been skyrocketing. When judges in court are women, those who suffer issues of discrimination on account of themselves being women will have the confidence and self worth to get access to justice. Their judgeship would enhance public confidence in seeking redressal of

grievances. Women judges will have more accuracy and tact in accessing the standards of ordinary prudent man which is the sole standard in proving the truth of a fact as per the Indian Evidence Act," said Vijayakumar. "Let's hope that their extensive role, presence and participation in the justice system will ultimately lead us to the long cherished goal of more equitable dispensation of justice, gender neutrality," Vijayakumar added.The RTI reply also revealed that there 68 women district and sessions judges in the state. Welcoming the recent increase in women representation in the judicial services, N Leelamani, a former judge, said it was their hard work and focus on people service that paved the way to the increase in the number of women officers in the district judiciary. "Gender equality is an important factor in all fields.

Bengaluru jeweller goes to Gujarat, servants flee with Rs 15.15 crore worth of valuables

Surendra Kumar Jain (46), who owns the reputed Arihant Jewellers in Vidyaranya Nagar on Magadi Road, filed a complaint with the police on Thursday after finding 8 kg of gold, 212 gram of diamond ornaments, Rs 40.80 lakh in cash and other valuables missing from his house. The incident happened between November 1 and 7, when the Jain family had gone

The suspects, identified as main accusedd Namraj, his wife Sushmitha, Dyankaran and Rajesh, are suspected to have escaped to Nepal. The accused couple had been working for Jain - the husband as a security guard and his wife as domestic help - for the last six months and were staying in the

In the complaint, Jain stated that there are seven workers in his shop, where Namraj worked as a security guard. Namraj also worked as a gardener in Jain's residence. Jain's five sisters, who had also gone to Gujarat, had kept all their gold ornaments at his house since there was a security guard."Jain and his family returned home around 3.30 am on Thursday and found out about the theft. When they went to the servant's room, Namraj and his wife were missing and their mobile phones switched off.

Ignore wrong portal entry, compensate Gaja-hit ryots in full: Madras High Court

CHENNAI: The Madras High Court has ordered an insurance company to pay full compensation amount to farmers affected by Gaja cyclone irrespective of the wrong entry made on the web portal concerned.A division bench of Justices of SS Sundar and AD Maria Clete passed the orders recently allowing an appeal filed by the Kumbakonam Central Cooperative Bank challenging a single judge's order.

The case pertains to 52 farmers belonging to six villages of Nagapattinam district enrolled with the Thittachery Primary Agricultural Cooperative Credit Society, who suffered crop loss in the 2018 cyclone. Since they had insured their crops with the New India Assurance company



under Prime Minister's Fasal Bhima Yojana for the Rabi season of 2017-18 and paid the premium, they made representations for compensation.

Subsequently, an assessing team held inspections and recorded the quantum of loss which ranged from 51.35% to 91%.

However, the assessment team made a wrong entry of 8.23% on the web portal concerned. The central cooperative bank found the mistake and duly informed the insurance company. However, the latter did not accept the submission, instead, disbursed meagre compensation for only 8.23% of loss.As a result, all the 52 farmers filed a writ petition in the high court. A single judge, after hearing the case, ordered the bank to pay the remaining amount of compensation and held that the insurance company could not

be held responsible to pay, agreeing with the company's contentions on the relevant clauses of the operational guidelines governing payment of compensation.

Disapproving the contentions of the insurance company, the division bench held that subclause 2 of Clause XVII of the operational guidelines cannot be understood to mean that any error in uploading the actual damage caused cannot be rectified as the error is due to inadvertence or a clerical mistake."We are unable to appreciate the contentions of the insurance company on the interpretation of the operational guidelines, to wriggle out of its contractual obligations," the bench said. The bench set aside the order of the single judge saying that he had not considered the relevant provisions of the operational guidelines in a proper perspective with respect to the admitted facts and the circumstances.

It directed the insurance firm to disburse the exact compensation within six weeks along with 12% interest per annum from the date of filing of the writ petition.

Why the Uber-IAF deal is problematic

On October 17, the Indian Air Force (IAF) signed an MoU with Uber to "provide reliable, convenient, and safe transportation services for IAF personnel, veterans and families." The services provided would be for official travel and daily commutes. In September 2023, the Indian Navy had signed a similar MoU with Uber. Service members must provide their names, email IDs and mobile numbers and similar details of their family members to avail themselves of Uber's services. Many cybersecurity experts have raised serious concerns over the potential risks of entrusting sensitive data of military movements to a private, foreign company. Beyond basic personal details, over a period of time, the data could reveal travel patterns, place of posting, realtime geolocations, family and dependents' place of work and routines. There are major security repercussions when a single company holds personally identifiable information of thousands of military personnel. The Indian Air Force has sought to justify the signing of the MoU. The Sunday Guardian has reported that highly placed sources have stated that such agreements with foreign-based entities are planned in a holistic manner, ensuring that no data breach could happen while the data is being stored using Advanced Encryption Standard (AES)-256-bit encryption. Arguments have also been made that the personal data of military persons is already held with a host of companies like Amazon, Zomato, Blinkit, etc, and, therefore, there is no additional risk with Uber.In analysing this dispassionately, two key questions must be answered. First, what is the link between personal data and national security? Second, what do we know about how private companies handle personal data? We often look at personal data from the lens of privacy, but it has significant national security implications. Every click, search, purchase and social media post creates personal data. The smartphone is a repository of biometrics, health data, real-time location, financial transactions and secret conversations. All of this data is analysed to create a psychographic profile of individuals, with deep insights into people's personalities, values, beliefs, ideologies and emotional triggers. Technology companies monetise this data by using it to create detailed profiles that enhance ad targeting, personalise services and improve product offerings. Hostile powers use this data to design highly effective disinformation and influence campaigns.

At an individual level, adversaries could mount psychological operations harassing specific military personnel and their families to sow fear or create stress within the ranks, potentially undermining morale and operational readiness. Collectively, specific demographics and ideologies could be targeted to develop tailored messages that resonate with particular groups, turning small societal divides into chasms.

In the 2016 US elections, Russia's Internet Research Agency used Facebook and other social media to target specific groups, exploiting data to craft divisive messages on sensitive topics like race, gun rights and immigration. Personalised ads reached susceptible individuals, amplifying divisions and swaying public sentiment.

Similar tactics have been observed in events worldwide, such as during Brexit, the incitement of violence against the Rohingya in Myanmar in 2017, misinformation on vaccines during the Covid-19 pandemic and the Hong Kong protests of 2019. According to experts surveyed for the World Economic Forum's 2024 Global Risk Report, the number one risk identified for India was misinformation and disinformation.

We now turn to the second question on data handling. Data breaches are common. Uber has suffered data breaches in 2014, 2016, 2020, 2022 and 2023. While encryption is essential to protect data, it does not provide fail-safe security. According to Verizon's 2023 Data Breach Investigations Report, 74 per cent of the breaches involved the human element, which includes social-engineering attacks. Social-engineering in hacking refers to the use of psychological manipulation to trick individuals into revealing sensitive information, granting access to restricted systems and encrypted data.

Loving to hate Modi & Trump too much

THE GREAT GAME: Electoral ecstasy vs sullen resentment is the hallmark of polls both have fought

THE return of Donald Trump to the White House is evoking in America these days a similar intensity of So let's face the facts today. The fact is, Harris lost emotion that India has experienced over the last decade each time Narendra Modi has won power. The so-called "liberal press" has gone out of its way to paint a dark, doomsday scenario, while the socalled "conservative media" — led by Elon Musk's X—is clothing the man from Mar-a-Lago in knightin-shining-armour material. It is uncanny that India's emotional mix vis-à-vis Modi has been so similar to that meted out to Trump. Electoral ecstasy versus Messy democracies like the US and India would rather sullen resentment has been the hallmark of all three

elections that Modi has won, in 2014, 2019 and 2024. Certainly, it is clear that the happy middle in India, just like in America, has largely disappeared under the weight of both polarising personalities, Modi and Trump.The larger question is, why the media, as well as pollsters in both countries, have been getting it increasingly wrong. Do we love to hate both Modi and Trump so much that we are refusing to really see and hear what the people, whose thoughts and desires and anxieties we claim to articulate, are really saying? Just like in America — where pollsters had the race down to a dead heat, and respectable newspapers like The New York Times refused to concede that Trump had won, much after he had made his

victory speech in Florida — in India, too, many of us have allowed our heart to take over our head, incredibly in both directions. In 2014 and 2019, we couldn't believe Indians were voting for Modi with both their hands and feet; in 2022, we refused to believe Yogi Adityanath had swept Uttar Pradesh weren't the thousands of deaths during Covid-19 proof that God himself had turned against him, we said? In 2024, we were equally shocked that the same Uttar Pradesh had refused to fully deliver itself to the BJP.In all these cases, we poured ourselves so deeply into the story that we refused to heed the reality on the ground. Worse, once these mandates were in front of us, many of us still refused to squarely accept them. Something remains wrong with Modi and Trump, we insisted — which may or may not have been true. Worse, we refused to apply the same tough yardstick to either Rahul Gandhi or

Kamala Harris. because she did not stand for anything — no matter that Trump was a convicted felon, a womaniser or

worse, at least he promised to end immigration (bad for India) and bring jobs back to America. As for Rahul, the fact remains that people like me will heartily agree with many of his ideas across a dinner table, but we remain embarrassingly unconvinced about what he's willing to die for.

elect Trump and Modi because they are able to



simplify the chaos that are begotten by societies in either decline or in transition. We will overlook the dark patches in the lives of the leaders we elect — the January 6, 2021, assault on the US Capitol as well as the 2002 Gujarat riots in which more than a thousand people were killed — because we are comforted by their present assurances that they will make our difficult lives better today. They speak to us simply. We disbelieve them less than we believe their opponents. One of the reasons voters said why they voted Trump — some Black districts in the pro-Democrat, southern US state of Georgia shifted almost entirely to him, besides improving his Latino vote by 14 per cent – is because they said that Democrats tend to take their voters for granted.

Sounds familiar? Certainly sounds like Rahul's Congress, especially those complaining that the EVMs were fixed in Haryana. The voters punished

Harris, just like they did Bhupinder Singh Hooda, when he refused to take along recalcitrant leaders in his party, like Kumari Selja, Randeep Surjewala and Rao Birender Singh. Like the BJP which focused on the non-Jat vote in its micro-management of every constituency in Haryana, data shows that Trump has won more non-White votes than any other Republican candidate in the last 40 years.

Worse, the Congress refused to stop crowing when the BJP lost 29 seats in UP and therefore its majority in the 18th Lok Sabha. Modi, on the other hand, understood that there was no such thing as being

> half-pregnant; as PM, he could do exactly what he had done when he had a full majority. And that the only route to consolidate power — and avenge UP — was to win the state elections coming up. Haryana. Maharashtra. Jharkhand.

Different rules though, it seems, are being applied to Punjab — to a state which had stood up to Modi and forced him to withdraw the three farm laws. So many questions are being asked these days about the immense difficulty in the procurement of paddy these last few weeks — could this not have been averted, considering Punjab, a sensitive border state, significantly depends on agriculture? Could the Centre have been more understanding in the evacuation of

paddy from Punjab to other parts of the country? And why is it only this year that the FCI has discovered that Punjab has sold soiled rice to Arunachal Pradesh and Karnataka? Perhaps, some of this sounds like a conspiracy theory gone viral. Another way to answer these beleaguered questions is that both Modi — and dare I say it, Trump understand the nature of power. That politics is not a kitty party, or an NGO. That if voters won't vote for you beyond a certain number — for example, more than 18.3 per cent of the votes won by the BJP in Punjab in the 2024 Lok Sabha elections — then other measures need to be taken. Among them, $divide \ and \ rule \ -- \ the \ oldest \ rule \ in \ the \ book.$

Now that Trump has taken America, it's time to focus at home. Alongside Maharashtra, let's start with the four bypolls in Punjab coming up on November 20. Let the games begin.

Shielding children

Australia for ban on social media access



for profiting from engagement algorithms that expose children to harmful content. A tough stance is, indeed, needed to protect vulnerable youngsters. At the same time, an outright ban could push children towards darker, unregulated corners of the Internet. An industry expert has called Australia's approach a '20th-century' solution. Blocking access risks alienating young users from essential online resources and support networks. The expert suggests that ageappropriate platforms, digital literacy and better safeguards are more effective solutions.

Australia's proposal highlights a global dilemma: how to balance children's safety online with nurturing responsible digital engagement. If effectively implemented, this policy could set an important standard in the matter. Safeguarding children requires cooperation among governments, tech companies and parents, with a shared commitment to addressing social media's risks while fostering

healthy online habits.

Use of reapers adds to the problem of air pollution

Lessons from sportspersons must be learnt so that we become better at what we do

Over the past many years, at the onset of winter, the National Capital Region has been experiencing air pollution. Delhi's Air Quality Index deteriorates due to the combined effect of pollution from various sources — industrial sector, vehicles, construction dust, bursting of firecrackers and burning of paddy straw in fields of Haryana, Punjab and western Uttar Pradesh in October. The pollution issue is repeatedly taken up by the Supreme Court and the National Green Tribunal every year and instructions given to the Central and the state governments to control farm fires and take remedial measures. As per some reports, the industrial sector accounts for 52 per cent of the pollution, transport services 27 per cent, agriculture sector 10 per cent and other factors 11 per cent. The Union and state governments have been providing subsidy and machinery to farmers for the past several years to check stubble burning. During the past five years, in addition to giving a large number of equipments, including zero till drill, rotavator, happy seeder, mulcher, MB plough, super seeder, surface seeder and baler machines, the Department of Agriculture and Farmers Welfare, Punjab, has conducted various activities and awareness campaigns to educate the farmers on not resorting to stubble burning. Though the incidents of farm fires have decreased in the past couple of years, no concrete solution has been found to stop this practice completely. Policymakers must seriously consider why farmers are burning stubble when they, too, equally suffer from the pollution caused by fires. The toxicity of the fumes is far more serious for them as they live in closer vicinity of these farm fires.

Burning of standing stubble began only after the use of tractor-driven reapers came into practice. Farmers reap standing stubble with these machines. As this stubble is not dry, its burning causes environment pollution. If these machines were not there, it would not have been possible for farmers to cut stubble in any way. Before these machines came into practice, farmers would set ablaze only the loose straw, which is dry and lighter in weight, thus producing less smoke as compared to the standing stubble.

Now, subsidies are being given to the farmers by the Union and the state governments to encourage the

use of reapers, which has added to the problem of air pollution. If the government banned such reapers in the paddy-producing states, it would get rid of up to 80 per cent of the toxic smoke produced after stubble burning. Field experiments conducted by me over the years have revealed that two types of straw are formed after paddy harvesting by the combine harvester. One is the 'loose straw' that comes through combine after separation of grains. It is only 20 per cent by weight and the other is the standing stubble which is 80 per cent by weight. The burning of loose straw produces only 20 per cent smoke as compared to the standing stubble when both the standing stubble and the loose straw are burnt together after operating reapers. Therefore, the governments must ban reapers during the

harvesting season, which will certainly help reduce air pollution. However, if any farmer wants to make bales of his paddy straw, he could be given permission to use the reapers by issuing permit and imposing certain riders on its operation. In 2009, the Punjab Government enacted the Punjab Preservation of Subsoil Water Act, 2009, to save underground water. One cannot overlook the fact that after paddy harvesting, not much time is left to prepare the field for sowing the next crop of wheat, mustard, potatoes, etc. So, farmers use reapers to cut the standing paddy

heads (stubble), which are wet. The quantity of smoke produced after burning wet stubble is much more, and when it gets mixed in the air, it turns into smog, which causes severe air pollution. The farmers who do not use reapers, plough and prepare their fields for the next crop by mixing the standing stubble in the soil. Only some farmers have complained of a few problems — where the upper



soil crust is hard, most likely due to certain soil conditions. By and large, the production is the same as that of farmers who use reapers and burn stubble. Therefore, the stubble could be uprooted and mixed in

the soil before sowing the wheat or other crops. It also helps in protecting the seedlings or plants of wheat, potato and mustard crops from frosty weather conditions in January and February, which is a good sign for the overall growth of the plants as well as soil health.Straw weighing about two and a half tonnes is produced in one acre of land under paddy. Of this,

two tonnes comprises the standing stubble and the rest loose straw. It is the loose straw spread on the standing stubble across the fields that causes some problems in sowing the next crop, not the standing stubble. This loose straw can be easily managed while preparing the fields to sow the next crop.

Moreover, farmers can sow their wheat crop within the standing stubble by using the tractor-drawn zero till

drill machine. However, farmers use reapers and burn both stubble and loose straw, causing heavy pollution. Plus, while using reapers, the dust particles from the fields fly and mix in the air, which is also one of the causes of the emergence of smog at the advent of the winter season. Till now, there is no machine which can easily prepare fields for sowing the next crop when loose straw and standing stubble are present in the area. Last year, there were many problems in sowing wheat with the surface seeder. As a result, the farmers have not shown much interest in this technique.Due to the practical problems being faced by farmers, agricultural universities, experts, engineers and

governments must consider and conduct

extensive research on developing a cost-effective machine that can help in smooth and efficient stubble management at the time of sowing the next crop without burning the crop residue.

A majority of the farmers are small and marginal. They cannot buy expensive machines or big tractors. Small implements like balers that can collect only loose straw and plough the standing stubble simultaneously must be developed and their use encouraged in the farming operations to address the increasing problem of air pollution.

Bulldozer justice unacceptable: DY Chandrachud's final verdict as Chief Justice

➤ Chief Justice of India DY Chandrachud warned against the danger of selective demolitions as acts of reprisal and called for accountability of state officials involved in such actions. He argued that this unlawful 'bulldozer justice' should lead to disciplinary and criminal actions.

New Delhi:In his final judgment before retiring as Chief Justice of India, Justice DY Chandrachud held that citizens' voices must not be silenced through threats of property destruction and emphasised that 'bulldozer justice' is unacceptable in a society

governed by the rule of law.He underscored that the safety and security of a citizen's home are fundamental rights deserving of protection. Consequently, the state is obligated to follow procedural safeguards and ensure due process before taking action against alleged illegal encroachments or constructions."Justice through bulldozers is unknown to any civilised system of jurisprudence. There is a grave danger that if high handed and unlawful behaviour is

permitted by any wing or officer of the state, demolition of citizens' properties will take place as a selective reprisal for extraneous reason," the Chief Justice said in a verdict in a case related to the demolition of a house in Uttar Pradesh's Maharajganj in 2019.

The top court stressed, "Citizens' voices cannot be throttled by a threat of destroying their properties and homesteads. The ultimate security which a human being possesses is to the homestead". The Supreme Court has been addressing numerous cases concerning the use of



bulldozers to demolish properties allegedly associated with individuals accused of criminal activities. This practice, often referred to as 'bulldozer justice,' has sparked widespread controversy and drawn significant criticism from opposition parties. Calling 'bulldozer justice' "simply

unacceptable", the Chief Justice called for action against officials involved. The November 6 verdict, which was uploaded on the court's website later, proposed to lay down certain minimum thresholds of procedural safeguards which must be fulfilled before taking action against

law before taking action to remove illegal encroachments or unlawfully constructed structures. Bulldozer justice is simply unacceptable under the rule of law. If it were to be permitted, the constitutional recognition of the right to property under Article 300A would be reduced to a dead letter,' Justice Chandrachud added. "Officials of the state who carry out or sanction such unlawful action must be proceeded against for disciplinary action. Their infractions of law must

invite criminal sanctions. Public accountability for public officials must be the norm. Any action in respect of public or private property must be backed by due process of law," the CJI said.

The current case before the Supreme Court involves the demolition of journalist Manoj Tibrewal Akash's ancestral home, which was allegedly torn down in 2019 without proper notice or fair compensation.Justice Chandrachud officially retires on November 10, concluding a distinguished tenure at the Supreme Court. He assumed office as the 50th Chief Justice of India in

New Delhi:Hindu and Sikh activists held a demonstration outside the High Commission of Canada in New Delhi on Sunday to protest against the attack on a Hindu temple in Canada's Brampton by a pro-Khalistan mob. To maintain law and order, security was beefed up in front of the High Commission of Canada in the diplomatic enclave of Chanakyapuri following calls for protests from various Hindu organisations. Delhi Police deployed a large number of personnel and erected multiple layers of barricades in front of the Canadian



Delhi Man Kills Mother, 50, For Not Allowing Him To Shift To Canada: Cops

New Delhi: A 50-year-old woman was stabbed to death by her son allegedly after she did not allow him to shift to Canada for work, police said on Saturday. The incident took place in Molarband village in southeast Delhi's Badarpur area, they said. After killing his mother on the evening of November 6, the accused, Krishna Kant (31), called his father Surject Singh (52) and asked him to come home, they said.

When Singh reached home, Krishan Kant said "sorry" to him and asked him to go upstairs and see for himself what he had done, Deputy Commissioner of Police (southeast) Ravi Kumar Singh said. Upon reaching the first floor of the house, Singh found his wife Geeta lying in a pool of blood with multiple stab injuries on her body, he said, adding that during this the accused managed to flee.Singh immediately took Geeta to Apollo Hospital, where she was declared dead, the police said. The DCP said Singh has two sons. While his younger son, Sahil Bholi (27), works in a bank. Krishan Kant was jobless and a drug addict.

Both sons are unmarried and at the time of incident only Geeta and the accused were present at home," the officer said.Krishan Kant was later arrested from the same area and a case of murder has been registered against him, the officer added. During interrogation, he revealed that he wanted to migrate to Canada but his family wanted him to marry first. On the day of the murder, the argument between the mother and son flared up and Krishan Kant ended up stabbing Geeta with a knife he bought sometime back, the police said.

Delhi HC orders government to launch online Muslim marriage registration portal The ruling, delivered by Justice Sanjeev Narula, mandates the Delhi chief secretary to personally oversee the establishment of the registration system.

NEW DELHI: The Delhi High Court has instructed the city government to introduce an online registration system specifically for Muslim marriages on its official platform. This directive comes with a strict timeline, emphasising the importance of expeditious

The ruling, delivered by Justice Sanjeev Narula, mandates the Delhi chief secretary to personally oversee the establishment of the registration system. The decision stems from a petition by a couple who wed under Islamic Sharia law on October 11, 2023, and sought to register their marriage for visa purposes required by certain countries. Due to the current system's limitations, which only accommodates marriages under the Hindu Marriage Act, 1955, and the Special Marriage Act, 1954, the couple was compelled to register under the latter.

Representing the petitioners, advocate M. Sufian Siddiqui argued that the city government's marriage registration system effectively excluded Muslim marriages, violating fundamental rights enshrined in Articles 14, 21, and 25 of the Constitution. He further contended that the absence of an alternative under the Delhi (Compulsory Registration of Marriage) Order, 2014, imposed a statutory framework on the petitioners contrary to their beliefs. Highlighting the couple's case, the Court noted that after their marriage under Islamic Sharia law, they executed a Mubarat Nama—an Islamic mutual divorce deed—on July 9. The couple, seeking to respect their religious practices, asserted that they should not have been bound by the Special Marriage Act, which led to procedural

In its order issued on November 6, the Court annulled the marriage registration certificate initially issued under the Special Marriage Act by the city government's Revenue Department.It also directed that the record be amended accordingly. Further, the Court expressed concern over the lack of action following an earlier judgment on July 4, calling on the government to initiate steps for compliance.

India to receive first stealth frigate **Tushil from Russia in December**

New Delhi:India will finally receive the stealth frigate Tushil from Russia in December 2024 after a long delay. Defence Minister Rajnath Singh will induct the guided-missile warship on December 9 at the Yantar Shipyard in Russia's Kaliningrad.According to the sources, the delivery of the first of four state-of-the-art frigates which are under construction for the Indian Navy was delayed due to supply constraints following the pandemic and the Russia-Ukraine war. The induction

As the first in a series of four such frigates, the ship will pave the way for a more robust Indian Navy capable of projecting power and protecting strategic interests in increasingly contested waters. According to sources, the second frigate of the project will be delivered by the first four months of

mission.Several activists of the Hindu Sikh Global Forum, who were marching to the High Commission, attempted to climb over the police barricades and toppled them. They raised slogans and bore placards that read 'Hindus and Sikhs are united' and 'Indians will not tolerate the insult of temples in Canada'.

The protests come after a number of Khalistani supporters attacked devotees outside the Hindu Sabha Mandir in Brampton, Canada, when a consular camp was underway on November 4. The incident sparked widespread condemnation, including from Prime Minister Narendra Modi, who denounced the "deliberate attack" and "cowardly attempts to intimidate" Indian diplomats. Following the attack, massive protests erupted outside the Brampton temple, with demonstrations also taking place in Mississauga. A Canadian police officer, Harinder Sohi, was suspended for participating in a pro-Khalistan protest where anti-India slogans were chanted.

Canadian authorities have arrested four individuals in connection with the violence and subsequent demonstrations. The latest arrest is of Inderjeet Gosal, a top operative of Sikhs for Justice (SFJ), a banned organisation in India.Gosal, who was an associate of slain Khalistani terrorist Hardeep Singh Nijjar, has been charged with assault with a weapon.

Coordination Gap With Colleague Caused Railway Employees' Death, Says Probe

New Delhi: A lack of coordination between two rail employees during a shunting operation led to one of them getting stuck in the buffers of the engine and a power car, causing his death in the Barauni Junction of Bihar on Saturday, a preliminary inquiry has found. The joint report, signed by five rail officials, said the two pointsmen -- Amar Kumar and Mohd Suleman -failed to properly coordinate with each other due to which Suleman gave the wrong signal to the loco driver, resulting in 25-year-old Kumar's death. designed to reduce the impact of collisions between bogies. According to the joint report, the 15204 Lucknow-Barauni Express terminated at Barauni Junction at 8:10 am and the station master assigned the task of detaching the engine from the power car and the rest of the train to Kumar and Suleman.

"While detaching the engine and the power car, pointsman Kumar got stuck between the two and died on the spot," the report said.After reviewing footage from CCTV cameras installed at the station, they found that the accident occurred around 8:29 am.Kumar's body was retrieved after separating the engine and the power car at 10:15 am and sent for post-mortem.

Delhi air quality remains 'very poor', thick layer of smog engulfs city

New Delhi: A dense layer of smog engulfed Delhi on Sunday morning as several parts of the capital city grappled with severe air pollution even 10 days after Diwali.Air quality in Delhi was adjudged as 'very poor' with an AQI of 335 at around 8 am on Sunday, a Central Pollution Control Board (CPCB) data showed. Visuals showed a thick blanket of smog covered areas near the All India Institute of Medical Sciences (AIIMS) in south Delhi, with the air quality being recorded in the 'very poor' category. Also, a layer of smog engulfed the Red Fort and surrounding areas as the AQI was recorded at 207, categorised as 'poor', around the iconic monument, the CPCB said. According to data issued by the System of Air Quality and Weather Forecasting and Research (SAFAR-India), several pockets in the city also witnessed very poor air quality

on Sunday morning. Some of the areas worst-affected by air pollution included, New Moti Bagh (AQI 394), Bawana (AQI 383), RK Puram (AQI 368), Wazirpur (AQI 366), Mundka (AQI



358), Kartavya Path (357), and Anand Vihar (AQI 351).

Also, Dwarka Sector-8 and Najafgarh recorded an AQI of 341, Okhla Phase-2 and Lodhi Road had 319, as per SAFAR-

India data.In many parts of the city, buildings, monuments, offices, flyovers, roads, and bridges were hardly visible as they were covered by a thick layer of smog. had AQI of 339, Mathura Road had 323, In addition to air pollution, drone videos showed toxic foam floating on the

Yamuna River in the Kalindi Kunj area, apart from an air quality which was recorded in the 'very poor' category in the vicinity.Meanwhile, doctors have urged citizens to stay indoors as much as possible and take other precautions, warning that even people with no history of respiratory diseases may face breathing

'Apart from the regular patients, those who haven't had any respiratory issues in the past are having symptoms such as runny nose, sneezing, coughing and increasing difficulties in breathing," Apollo Hospital's Dr Nikhil Modi was quoted as saying by ANI.

The doctor further advised that the government should order the closure of schools for some days as children continue to be vulnerable.An AQI between 201 and 300 is considered to be 'poor', while an AQI from 301 to 400 is rated as 'very poor'. An AQI of 401 to 500 falls under the 'severe' category, and it is termed as 'Severe+', if numbers are anywhere between 501 and 600.

Restaurant review: The Chatterhouse

Leveraging on the Nehru Place Metro Station's new found identity one of a 'food mall', this new watering hole touted to be Delhi's first gastro-pub holds promise to take the local pub culture a notch higher. The Chatterhouse tucked away in the far end of the lower ground floor of Epicuria (the food mall) drowns out the clamour of the food court making way for some peaceful unwinding and conversations.

Decor: For a resto-pub in a metro station-cum-food mall, you'll find Chatterhouse quite spacious and tastefully upholstered. Reminiscent of a typical English pub, the interiors are dark wood and leather accentuated with graphics on its brick walls and a bool table in one corner. At its heart is a rustically done up bar facing a giant screen for telecasting football matches surrounded by high stools. Its 110 covers extend to the outdoors too amid

a finely manicured garden with a burning wood fire on one end for tossing out delicious thin crust pizzas. And unlike a typical pub which is mostly crammed, the seating here is divided into booths and open tables with bar stools to ensure you some quiet time without having to overhear others.

Food: The drink menu here has been crafted to go with that of the food, and not the other way round. Comprising a



veritable mix of Italian, Lebanese, Continental, Indian and traditional pub classics, you have the option of customising the offering with your choice of beers and burgers to go with French fries. The wood fire pizzas too move very quickly here, and would be even better to find a seat in the garden next to the oven on a cold day. The place exudes the warmth you crave for on a glum winter day by gratifying you with its comfort food, and drink. From linguine aglio olio to penne with vodka, the choices in pasta are decadent, but not abundant.

At any point, the gaze of the restaurant doesn't narrow only on the young crowd, which it ensures by serving up rock classics from the 70s and 80s, and by keeping hookah out of the menu altogether. True to its philosophy of offering a comfortable space to everyone with a taste for good life and food, you, at the end of the day, wouldn't really mind

bringing your folks along. But in the same breath, the pub doesn't lean heavily on ambience alone, for the gastronomic offering here is every bit lip-smacking providing a bang for your buck. Starters and main course: Begin with the in-house favourite, the

Apple sets up design, R&D subsidiary in India to broaden local value addition

NEW DELHI. Even as smartphone maker Apple works on broadening its manufacturing base in India, it has also laid the ground for conducting research and development, and design operations in the country, in a bid to increase local value addition while tapping into India's skilled engineering base. The company has set up a wholly-owned subsidiary called Apple Operations India which will "engage in business of procurement management, developing, manufacturing support and other related operations such as processing, undertaking research and development and design relating to science, engineering, technology and applied technology, computer and information technology programming, research, and systems, and related technical support and technical testing and analysis," as per filings with the Registrar of Companies. The company currently has no design base in India, and carries out such operations in countries like the United States, China and Israel.

The development comes as the central government has been pushing companies like Apple to conduct research and development and design operations in India as they broaden their assembly and manufacturing base in the country. India is a major design hub for various global electronics companies, particularly those in the semiconductor space. Most smartphone companies are yet to design in India, however."The government sees designing and R&D as a major part of local value addition in the electronics sector. As companies move more of their assembly operations to the country, having a design unit will help India in creating a larger space within the research ecosystem, we have a big pool of design engineers in the country because of which all major chip companies carry out R&D here. We expect a similar development for the smartphone sector," a senior government official said.

Steadily, Apple has been laying the groundwork for having an expansive presence in India, which includes assembly operations on the manufacturing side, and official stores on the consumers' side. It is also one of the beneficiaries of the government's production linked incentive (PLI) scheme for mobile phone manufacturing.

Foreign investors withdraw approximately Rs 20,000 crore in last 5 trading sessions

NEW DELHI: Foreign investors continued to be net sellers as they withdrew approximately Rs 20,000 crore from the Indian equity markets in the past five trading sessions from November 4-8, primarily due to higher stock valuations and reallocation to China. Total FPI outflows in the equity market have reached Rs 13,401 crore this year. Earlier, the FPI's withdrew record Rs 94,017 crore in October.VK Vijayakumar, chief investment strategist at Geojit Financial Services said tha, Q3 results and leading indicators showing earnings recovery could alter this scenario, potentially converting FPIs from sellers to buyers.

Sunil Damania, chief investment officer at MojoPMS, said that domestic factors will primarily influence the Indian market's short-term direction, including Maharashtra assembly election results, corporate earnings reports, and retail investor responses to the October-November decline. Meanwhile, September 2024 saw the highest foreign investment of Rs 57,724 crore. Since June, FPIs maintained consistent equity purchases after withdrawing Rs 34,252 crore in April-May.

Himanshu Srivastava from Morningstar Investment Research India explains that FPIs are favouring China due to its attractive valuations and growth potential, supported by recent stimulus measures. Abhishek Banerjee of Loutusdew cautions that this shift towards China might be a value trap despite its deep value appeal.

Additionally, the appreciation of US dollar and Treasury yields has attracted FPI investments, anticipating a stronger US economy. However, despite recent outflows, November witnessed 40-50 new FPI registration applications, according to Manoj Purohit from BDO India, following Sebi's relaxation allowing increased NRI participation and simplified entry procedures. In the debt market, FPIs invested Rs 599 crore in the general limit and Rs 2,896 crore in the voluntary retention route during this

Russian oil finds its way to Europe via India; India now biggest exporter of fuel to EU

NEW DELHI: India's export of fuels like diesel to the European Union jumped 58 per cent in the first three quarters of 2024, with a bulk of them likely coming from refining discounted Russian oil, according to a monthly tracker report.

The EU/G7 countries in December 2022 introduced a price cap and an embargo on the imports of Russian crude oil in a bid to cripple Kremlin's revenue and create a vacuum in its

funding for the invasion of Ukraine. However, a lack of a policy on refined oil produced from Russian crude meant that countries not imposing sanctions could import large volumes of Russian crude, refine them into oil products and legally export them to the price-cap coalition countries.India has become the second biggest buyer of Russian crude oil since the invasion, with purchases rising from less than one per cent of the total oil imported in the pre-Ukraine war period to almost 40 per cent of the country's total oil purchases. The rise was primarily because Russian crude



oil was available at a discount to other internationally traded oil due to the price cap and the European nations shunning purchases from Moscow.Fuel exports were, however, at full price."Capitalising on the refining loophole, India has now become the biggest exporter of oil products to the EU. In the first three quarters of 2024, exports to the EU from the Jamnagar, Vadinar (in Gujarat) and new Mangalore refinery - which are increasingly reliant on Russian crude saw a 58 per cent year-on-year rise further," the Centre for Research on Energy and Clean Air (CREA) said its latest report.Reliance Industries Ltd has oil refineries at Jamnagar while Russia's Rosneft-backed Nayara Energy has a unit at Vadinar.

Mangalore Refinery and Petrochemicals Ltd (MRPL) is a subsidiary of the state-owned Oil and Natural Gas Corporation (ONGC). This, it said, amplified "the fact that EU Member States continued imports are expanding the refining loophole and Russian revenues from crude exports to third

countries". Europe typically imported an average of 1,54,000 barrels per day (bpd) of diesel and jet fuel from India before Russia's invasion of Ukraine.

This has almost doubled. While CREA did not give an absolute number for imports, the European think tank had in a previous report stated that Euro 8.5 billion of price cap coalition countries' imports of oil products in 13 months to December 2023 were made from Russian crude. These imports in 13 months were equivalent to 68 per cent of the EU's annual commitment to aid Ukraine between 2024 and 2027."In the 13 months since the oil price cap took effect (in December 2022), over one-third of India's exports of oil products to sanctioning countries was derived from Russian crude (EUR 6.16 billion or USD 6.65 billion)," the Finlandbased CREA had said in the previous

While there are no restrictions or sanctions on buying/using Russian crude oil and exporting fuels like diesel derived from it, the Group of Seven (G7) rich nations, the European Union and Australia - called the price cap coalition countries - first set a crude price cap of USD 60 per barrel starting December 5, 2022, and later on products like diesel to keep the market supplied while limiting Moscow's revenue.CREA in the latest report said India, the world's third largest oilconsuming and importing nation, in October bought Euro 2 billion worth of crude oil from Russia, down from Euro 2.4 billion in the previous month.China has bought 47 per cent of Russia's crude exports (in October), followed by India (37 per cent), the EU (6 per cent), and Turkey (6 per cent)," it said.

Singapore Airlines To Invest Additional Rs 3,195 Crore In Air India Post-Vistara Merger

NEW DELHI. Singapore Airlines will make an additional investment of Rs 3,194.5 crore in Tata Groupowned Air India post-merger of Vistara in November. The merger, announced on November 29, 2022, and set to be completed on November 11, 2024, will result in Singapore Airlines having a 25.1 per cent stake in the enlarged Air Îndia.Full-service carrier Vistara, which started flying on January 9, 2015, is a joint venture between Tatas and Singapore Airlines, where the latter holds a 49 per cent shareholding.

Singapore Airlines (SIA) Group on Friday said its consideration for the merger comprises the 49 per cent interest in Vistara and Rs 20,585 million (Rs 2,058.5 crore) in cash in exchange for a 25.1 per cent equity interest in the enlarged Air India.

Post-merger, SIA expects to recognise a non-cash accounting gain of around 1.1 billion Singapore dollars and also start equity accounting for its share of Air India's financial results. According to a



release on Friday, the merger includes an agreement for SIA to contribute its share of any funding previously provided by Tata prior to the completion of the merger, together with relevant funding costs up to Rs 5,020 crore that would allow it to maintain 25.1 per cent stake in Air India. "SIA's additional capital injection is expected to be Rs 31,945 million (equivalent to SGD 498 million), based on Tata's funding to Air India to date. This will occur after the completion of the merger and within November 2024 through subscription to new Air

"Future capital injections will be considered based on Air India's requirements and available funding options," according to the release issued while announcing the airline's financial performance for the six months ended September 2024. The merger of Vistara with Air India will mark a major consolidation in the fast-growing Indian aviation space. SIA said the merged entity will have a

significant presence across all key Indian air travel segments, including domestic, international, full-service, and low-cost operations. This will strengthen SIA's multi-hub strategy, allowing it to continue participating directly in India's large and fastgrowing aviation market," it added.Recently, Air India and SIA recently agreed to significantly expand their codeshare agreement, adding 11 Indian cities and another 40 international destinations to their

Why is RBI bringing gold reserves back to the country

MUMBAI: The Reserve Bank has been on a localisation spree in recent years when it comes to storing 854.7 tonne of its gold assets/reserves. Of the total, 510.5 tonne are now stored in the different vaults of the central bank, mostly in the Mumbai vaults. It has also been on a gold-buying spree since between April 2022 and September 2024, it has added close to 100 tonne to the

In just two years ending September 2024, the RBI has quietly brought back 214 tonnes of gold. In FY23, the monetary authority had brought in only 5.3 tonne back to the country, taking the domestic storage to 301.1 tonnes. In FY24, the number went up by 106.8 tonne, taking the local storage to 408.3 tonne. In the first six months of the current financial year, the central bank brought back 102.2 tonnes, taking the total to 510.5 tonne.Of the rest of the reserves, 314 tonne are with the safe vaults of Bank of England, 10 tonne are with the Bank for



FPIs Withdraw Nearly Rs 20,000 Crore From Equities In Last 5 Trading Sessions

NEW DELHI. The exodus of foreign investments from Indian equity markets continued unabated, with FPIs pulling out nearly Rs 20,000 crore in the last five trading sessions or higher valuations of domestic stocks and shifting their allocation to China.As a result, foreign portfolio investors (FPIs) have turned net sellers in the equity market, with total outflows reaching Rs 13,401 crore for

Going ahead, the FPI selling trend is likely to continue in the near term till data indicate the possibility of a trend reversal. If the Q3 results and leading indicators reflect a recovery in earnings, the scenario can change with FPIs reducing selling and even turning buyers. Investors will have to wait and watch for the data, VK Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said. With the newly elected US president not assuming office until January 2025, the Indian



market's near-term direction will be more influenced by domestic factors like the Maharashtra assembly election results, corporate earnings commentaries, and retail investor behaviour in response to the October and early November downturn, Sunil Damania, Chief Invstment Officer, MojoPMS, said. According to the data, FPs recorded a net outflow of Rs 19,994 crore so far this month, comprising five

trading sessions from November 4-8. This came following a net withdrawal of Rs 94,017 crore in October, the worst monthly outflow. Before this, FPIs withdrew Rs 61,9/3 crore from equities in March 2020.In September 2024, foreign investors made a nine-month high investment of Rs 57,724 crore.

Since June, FPIs have consistently bought equities after withdrawing Rs 34,252 crore in April-May. Overall, FPIs have been net buyers in 2024, except for January, April, May and October, data with the depositories showed. While the immediate uncertainty over the US Presidential election and interest rates in the US has been addressed, several drivers of the foreign flows into the Indian equity markets continue to remain unfavourable.One of the primary reasons for FPIs exiting Indian equities is their newfound affinity towards China, given its attractive valuation and potential for generating higher growth.

Despite all his rambling at rallies, Donald Trump hammered out his ugly rhetoric on one, and only one thing - America being swamped by the 'great unwashed'; and the Biden administration failing to do anything about it. The picture he painted extended from falsely accusing Haitian immigrants of eating pet cats and dogs in a small Ohio town of Springfield, to spreading lies that American universities had been taken over by jihadists "who want to blow up our streets, our malls and everything America stands for". Never mind the ludicrous story of cats and dogs. Scapegoating migrants struck a chord even among Latinos, themselves 'immigrants' years ago.

He played on the worry that the demography of the country was changing, that peoples jobs, whatever they had, would be taken away. Lizelle Lee hits 150 to set new record for highest score in Women's Big Bash history

Hobart Hurricanes opener Lizelle Lee set a new benchmark in the Women's Big Bash League (WBBL) on Sunday, smashing a record-breaking 150* to claim the highest individual score in the league's history. Lee's remarkable innings helped her side secure a commanding victory over the Perth Scorchers at the Sydney Cricket Ground, marking a historic moment in women's franchise T20 cricket. The Scorchers' innings quickly faltered as Molly Strano dismissed Sophie Devine on the first ball, followed by a run-out that left them at 0/2. Chloe Piparo was dismissed shortly after, and wickets continued to tumble as Heather Graham and Strano kept the pressure on, ultimately dismissing Perth for

Eder Militao tears ACL as Real Madrid suffer 3 more injuries in 4-0 win vs Osasuna

Real Madrid defender Éder Militão ruptured the ACL in his right leg, while forward Rodrygo also sustained an injury earlier. Right-back Lucas Vázquez was substituted at halftime due to a visible leg issue.

New Delhi. Real Madrid's dominant 4-0 victory over Osasuna in La Liga on Saturday was marred by a devastating injury blow, with star defender Eder Militao suffering a torn anterior cruciate ligament (ACL). The Brazilian center-back is set to undergo surgery, sidelining him for several months in what marks his second extended injury

seasons. Militao's injury occurred early in the game as he attempted to clear a rebounding ball but hyperextended his knee, immediately signalling distress as he went down in visible pain. The 26-year-old was helped off the pitch, visibly emotional as he faced the reality of yet another longterm setback.Real Madrid confirmed the severity of the injury in a statement, revealing that Militao sustained a "complete rupture of the anterior cruciate ligament with both menisci involved" in his

right leg. Surgery has been scheduled for the coming days, and his absence adds to a worrying trend for Los Blancos as they deal with a growing list of sidelined players.

In addition to Militao, Real Madrid manager Carlo Ancelotti was dealt further blows on Saturday as Lucas Vázquez and forward Rodrygo were both forced off the field with injuries. Already short on defensive options,

Ancelotti faces the challenging prospect of managing an increasingly stretched squad with key matches in LaLiga and the Champions League looming. With Militao's absence, Real Madrid is left thin in defense, as the team was already missing the likes of Dani Carvajal, Thibaut Courtois, Aurelien Tchouameni, and David Alaba. Ancelotti expressed his frustration but noted that he would rely on the club's youth academy to transfer window opens in

T'm not thinking about signings right now because we have to prepare for games with the players we have," Ancelotti said in his post-match press conference. "Three injuries in the first half is quite rare. The demanding schedule doesn't allow the players to rest and be fresh."The manager praised the contributions of academy defender Raul Asencio, who came off the bench to help see out the game, and Federico Valverde, who filled in ably as

a full-back. "We did well last year when we had injuries, and we'll do the same this year," he added. With Antonio R1/4diger, Ferland Mendy, and Fran Garc-a now the only fit, experienced defenders in the squad, Ancelotti has a challenging few months ahead. Border-Gavaskar Trophy: Gilchrist wants Inglis to open for Australia in India Tests

New Delhi.Former Australian wicketkeeper Adam Gilchrist has publicly backed Josh Inglis as a candidate to open the batting in the highly anticipated Border-Gavaskar Trophy series against India, questioning whether selectors are staying true to their philosophy of fielding the nation's six best batters. Gilchrist's endorsement of Inglis follows the announcement that Nathan McSweeney will open alongside Usman Khawaja for the series opener at Perth Stadium.Cricket Australia confirmed on Sunday that McSweeney, who has yet to open at the first-class level aside from a recent Australia A match against India A, would debut as Australia's 467th Test cricketer. The decision, endorsed by chief selector George Bailey, prioritizes McSweeney's steady transition from No. 3 to an opener role, despite his lack of experience at the top order. Meanwhile, Inglis, known for his prolific contributions in Australia's white-ball squads, was listed as the reserve batter after an exceptional start to the Sheffield Shield season, scoring 297 runs at an average of 99.00 in just two matches. Gilchrist, a fellow West Australian, contends

that Inglis' current form warrants a spot in the top six batters, echoing the selectors' approach last year, when they prioritized skill over specialist roles. During the West Indies series, Cameron Green was chosen as an additional batter, prompting Steve Smith to shift to opener."Inglis is in that squad as a reserve batter, which isn't traditionally what Australia does in home conditions," Gilchrist commented on Fox Cricket. "I think McSweeney will open â€æ but do they stick with the policy they had last year when we want our six best batters in Australia playing in the top six?"Gilchrist went on to highlight Inglis' experience facing the new ball in white-ball cricket, suggesting that his aggressive style would suit the demands of Test cricket. "If they stay with that policy, for me, I would say put [Inglis] at the top of the order. I don't see it as too much of a challenge for him," he said.

While selectors see McSweeney's more defensive approach as potentially better suited to opening, Gilchrist argued that Inglis' offensive game could also prove valuable. "Nathan McSweeney's a finelooking player â€æ they see that his game is a little bit more suitable for opening the batting, whereas Josh Inglis knows how to attack. Offense is probably his best form of defense," he explained.

Sanju Samson should play all three formats for India: AB de Villiers

New Delhi. Former South African captain and legendary batter AB de Villiers has backed wicketkeeperbatter Sanju Samson to play all three formats for India. Samson, who has been on a spectacular run of form, recently scored two consecutive T20I centuries, with a blazing 111 off 47 balls against Bangladesh in Hyderabad on October 12, and an impressive 107 off 50 balls in the first T20I against South Africa on November 8 at Kingsmead, Durban.In a video on his YouTube channel following Samson's

remarkable performance, de Villiers emphasized that the Kerala-based batter possesses the skill to succeed across all formats and in varied conditions. "Sanju Samson, who scored a massive 100. Backto-back T20 hundreds, absolutely incredible. Am incredibly proud of the guy, I say proud because I do have a personal connection with him. We have been in touch for a number of years now. I have always been a big fan of Sanju Samson, I just love the way he plays, and I always want him to do well," AB de Villiers said on his YouTube



channel."He scored a 100 once at the Chinnaswamy Stadium against RCB, I was on the park and I realised that day, that this guy is something special and he is proving me right. For those of you who have followed Sanju Samson, I haven't often seen him bat at a strike rate of more than 200, he is generally more conservative, he is usually between 140-160 and both these hundreds he has scored back-to-back have been very very fast and especially this last hundred, he added.

Reflecting on Samson's transformation as a

player, de Villiers mentioned that Samson previously played with a more "conservative" approach, typically striking at 140-160. However, his recent centuries have displayed an aggressive side, with strike rates soaring over 200. "Something has triggered there, something has clicked in his game which is absolutely great to watch. The thing about him is that he makes it effortless out there. I don't see much experimentation going out there. Not a lot of creativity in terms of funny shots, doesn't seem that he wants to entertain the crowd and please

someone, he just sticks in his little bubble and he just is easy on the eye," said de Villiers.De Villiers expressed hope that Indian selectors would take notice and include Samson in Test and ODI sides too. "Sanju has upped the gear in his game. I hope the selectors are watching this for all the formats. I want to see this guy play all the formats. I think he is someone who is really really special, someone who can play all the formats, in all conditions around the world. I think there is another gear, a sixth gear, I want to see it unfold," he added.


