# Rahul Gandhi's challenge to 'little sister' Priyanka Vadra

New Delhi, Nov 11: The Wayanad by-election, Priyanka Gandhi Vadra's maiden electoral battle, will be held

Monday. "Priyanka Gandhi ji is the MP candidate. She is also my little sister, so I have the right to complain about her to the people of Wayanad,' Gandhi, who now represents Uttar

Pradesh's Raebareli in the Lok Sabha, said at a poll rally in Sultan Bathery, two days before the polling. "I would also like to challenge my sister to make Wayanad the best tourist destination. When people think of Kerala, the first destination should be Wayanad. This will benefit the people of Wayanad and its economy, and the world will get to know its beauty," the ex-Congress chief remarked.

In July, the Kerala district was hit by landslides that claimed more than 200 lives. The Wayanad by-election was necessitated as Rahul Gandhi chose to keep the Raebareli constituency after winning both seats in the Lok Sabha polls. The 54-year-old politician had won Wayanad five years ago, when he was defeated by BJP's Smriti Irani from the Congress' bastion of Amethi in Uttar Pradesh, a seat that he had held since 2004.

# Justice Sanjiv Khanna sworn in as 51st Chief Justice of India

New Delhi, Nov 11: Justice Sanjiv Khanna was on Monday sworn in as the 51st Chief Justice of India. President Droupadi Murmu administered the oath of office to Justice Khanna at a brief swearing-in ceremony held at the Rashtrapati Bhavan at 10.30 AM. Justice Khanna succeeds Justice D Y Chandrachud, who demitted office on Sunday on attaining the age of 65 years. Vice-President Jagdeep Dhankhar, Prime Minister Narendra Modi, Defence Minister Rajnath Singh, Law Minister Arjun Ram Meghwal ,outgoing CJI DY Chandrachud, ministers, sitting and former judges attended the five-minute ceremony. Appointed as a Judge of the Supreme Court of India on January 18, 2019, Justice Khanna will have a six-month tenure as the CJI. He will retire on May 13, 2025. The Centre had notified his

appointment as the next CJI on October 24, following Chief Justice Chandrachud's recommendation on October 16. Reducing pendency of cases and speeding up justice delivery are said to be his priorities. There has been a convention of the CJI recommending the senior-most judge of the

Supreme Court as his successor. Only twice, it has Shukla (1976) on the suspension of fundamental not been followed — Justice AN Ray was appointed the 14th CJI on April 25, 1973, superseding three



senior-most judges, and Justice MH Beg was appointed the 15th CJI on January 29, 1977, superseding Justice HR Khanna. Justice HR Khanna-his uncle-was denied the appointment as CJI by the Indira Gandhi-led government for his sole dissenting opinion in ADM Jabalpur versus Shivkant

rights during Emergency. The majority had declared that the government could suspend funda-

mental rights and detain citizens without following due process during Emergency. Justice HR Khanna had resigned after the government notified the appointment of Justice HM Beg — a junior judge — as the CJI. Son of Justice DR Khanna, a former Delhi High Court judge, Justice Sanjiv Khanna has been a part of many Constitution Bench verdicts, including the ones upholding the abrogation of Article 370 and the scrapping of electoral bonds scheme. He headed the Bench which upheld the use of electronic voting machines (EVMs) in elections amid the 2019 Lok Sabha poll. A Bench led by him had granted an interim bail to former Delhi CM Arvind Kejriwal to enable him campaign in the 2024 Lok Sabha poll. Born on 14th May, 1960, Justice Khanna got enrolled as an advocate with the Bar

Council of Delhi in 1983 and initially practised in the District Courts at the Tis Hazari complex, Delhi, and later in the High Court of Delhi and tribunals in fields as diverse as constitutional law, direct taxation. arbitration, commercial law, company law, land law, environmental law and medical negligence.

# Congress claims India faces 'demand crisis' due to income stagnation

New Delhi, Nov.11: Congress on Sunday claimed India was facing a "demand crisis" due

to sustained and said the 'double engine' of private investment and mass consumption that powered the UPA's decade of sustained GDP growth has been "derailed" in the last ten years of the Modi government. Congress general secretary in-charge communications, Jairam Ramesh, urged the government to accept what the Congress has been proposing - raising MGN-REGA wages to a minimum of Rs 400 per day, guaranteeing MSP and a loan waiver for farmers, and a monthly income support scheme for women - to kickstart income


growth in rural India. He said that with each passing day, the tragedy of India's dying consumption story becomes more evident. Last week, several CEOs from India Inc raised the alarm over the 'shrinking' middle class and now, new data from NABARD's All India Rural Financial Inclusion Survey (NAFIS) 2021-22 adds to the evidence that India's demand crisis is a result of sustained income stagnation, he said in a statement. Citing key takeaways from



the survey data, Ramesh said the average monthly household income for Indians is Rs mate Rs 2,886 per month - less than Rs 100 a day. The vast majority of Indians therefore have very little money for discretionary consumption beyond that of basic necessities," Ramesh said, citing the data. "This is hardly the exception - nearly every piece of evidence points to this same damning conclusion: that the average Indian can buy less today than they could 10 years ago. This is the ultimate root cause for India's consumption slowdown," he claimed. Citing Labour Bureau's Wage Rate Index data, Ramesh said real wages for labourers stagnated between 2014 and 2023, and in fact declined between 2019 and 2024. Further, he cited the Ministry of Agriculture's Agricultural Statistics data to state that under Dr Manmohan Singh, real wages for agricultural labourers grew at 6.8 per cent each year, he said. "Under Mr Modi, real wages for agricultural labourers declined by 1.3 per cent each year," Ramesh said. Citing Periodic Labour Force Survey Series data, Ramesh said the average real earnings over time have stagnated between 2017 and 2022 across all employment types - salaried workers, casual workers, and self-employed

# Yasin Malik ended hunger strike, being provided with necessary medical aid

New Delhi, Nov 11: The Tihar Jail authorities informed the Delhi High Court on Monday that convicted separatist leader Yasin Malik ended his hunger strike on November 8, and was being provided with the necessary medical



treatment. The respondent authorities, including the Centre, opposed the petition filed by Yasin Malik, who sought admission to AIIMS due to his alleged deteriorating health. The respondents requested additional time to review the medical status report submitted by the jail authorities before filing a response. The court of Justice Jasmeet Singh after noting the submissions, scheduled the next hearing for November 18. Meanwhile, it directed the jail authorities to ensure that Malik receives appropriate medical care. The lawyer representing Malik expressed dissatisfaction with the rescheduling of the hearing, stating that the legal team will visit Malik at Tihar Jail today to verify the claims made by the jail authorities. The Delhi High Court on Friday issued a notice to the Centre, the Director General of Tihar Jail and other relevant authorities in response to a plea filed by Malik. He claimed that he had been on a hunger strike since November 1 as he was allegedly denied of necessary medical treatment. In his plea before the Delhi High Court, Malik seeks appropriate directions from the court to ensure that he is referred for proper and necessary medical care at AIIMS or any other super-speciality hospital, either in New Delhi or in the Kashmir region. Additionally, Malik has asked the court to direct the authorities to produce him before the courts in the National Capital Territory (NCT) of Delhi whenever his presence is required. After considering the submissions, the court sought a medical status report of Malik from the concerned iail superintendent.

# fully imposing cracker ban

New Delhi, Nov 11: Calling it a mere "eyewash", the Supreme Court came down heavily on the Delhi police for failing to comprehensively implement the firecracker ban in the national capital and only seizing raw materials. A bench of Justices Abhay S Oka and Augustine George Masih therefore directed the Delhi police commissioner to immediately inform all the stakeholders concerned about the ban order and ensure no sale and manufacture of crackers. "We direct Delhi police commissioner to form a special cell to ensure effective implementation of the ban on fire crackers. We direct Delhi police commissioner to file a personal affidavit putting on record the steps taken by them to enforce ban," it said. The top court wondered why the Delhi government delayed imposition of the ban on fire crackers till October 14, when the order of ban was issued. "The right to live in a pollution-free atmosphere is a fundamental right under Article 21 of the Constitution. Prima facie, we are of the view that no religion promotes any activity that promotes pollution or compromises with health of the people," remarked the bench. The top court further asked the Delhi government to decide before November 25 on a "perpetual" firecracker ban after consulting stakeholders.

# SC raps Delhi police for not fully imposing cracker ban India tells Russia to remove tariff barriers, trade in national currencies

New Delhi, Nov 11: Just four months after Prime Minister Narendra Modi and Russian President Valdimir Putin held the annual India-Russia inter-governmental summit, increased bilateral opportunities in trade and investment are being worked upon by the two sides. In Mumbai on Monday, External Affairs Minister S Jaishankar, while speaking at the India-Russia Business Forum, asked Russia to remove tariff barriers to allow Indian products greater access to the Russian market and suggested that doing trade in national currencies was of great importance. Modi and Putin met in Moscow in July and tasked officials on either side to "prepare a programme for the development of promising areas of Russian-Indian economic cooperation till 2030". In New Delhi, the Russian Embassy said on Monday that a 'business centre' is to open in the national capital on Tuesday. Its main objective is to develop business ties between the two countries and

the India-Russia Inter-Governmental Commission will be meeting



in Delhi to take stock of the bilateral cooperation. Jaishankar said, "Mutual settlement of trade in national currencies is of great importance, especially in the current circumstances.... Special rupee-vostro

promote export cooperation. Also, on accounts are an effective mechanism right now. But in short term, a better trade balance with national currency settlements is

the answer." The minister said the India-Russia bilateral trade was today at \$66 billion and the goal was to take it to \$100 billion by 2030. He then sought Russia to relax some tariffs. "The balance of trade, however, needs urgent redressal since it is so one-sided. It is imperative that nontariff barriers and regulatory impediments are speedily addressed for this to happen.... A growing Russian appreciation of 'Make In India' as a programme to deepen business will certainly help to take forward our cooperation in many domains," he said. India, said Jaishankar, would grow at 8 per cent annually for multiple decades ahead and Russia was a key natural resources provider and a major technology leader. India would be

major player in oil, gas, coal or uranium and this applied to fertilizers too, the minister said. Jaishankar referred to the annual summit at Moscow in July and the interaction Modi and Putin had last in Kazan.

# CM Yogi Adityanath calls SP a haven for criminals

Lucknow, Nov.11: Speaking at a rally at Tilak Inter College in Hanumanganj, Phulpur, to support BJP candidate Deepak Patel, Adityanath alleged that prominent mafia figures like Atiq Ahmed, Mukhtar Ansari, and Khan Mubarak were all associated with SP. Referring to past high-profile crimes, he stated, "daylight murders of leaders like Krishnanand Rai and Raju Pal took place during SP's reign." He added that during previous SP rule, public funds were funneled to the SP family and their allies, turning the state's administrative bodies into a "production house for rioters." He further remarked, "Today's SP has strayed from the values it was originally founded upon. It has become a refuge for



mafia and criminals." Adityanath also questioned the Congress party and the INDIA alliance's stance on Article 370, highlighting a recent Jammu and Kashmir government proposal calling for its reinstatement. He alleged that "Congress and its allies want to reinstate Article 370 to promote terrorism." Adityanath assured voters that under the Modi administration, the move would never be allowed, and India would continue with "one flag, one Constitution." Addressing a crowd alongside BJP leaders and local dignitaries like BJP candidate Deepak Patel, MPs Praveen Patel and Nand Gopal Gupta Nandi and Mayor Ganesh Kesari, Adityanath honored Prayagraj's cultural and spiritual heritage, calling it a land blessed by the Ganga. He mentioned the special significance of 2025, when Prayagraj will host the Mahakumbh, an event recently recognised as a cultural heritage by UNESCO, thanks to efforts by PM Modi. Highlighting a decade of progress, Adityanath credited PM Modi's government for transforming the country's image and destiny. He pointed out that UP has also seen "double-engine government." "Earlier, UP was known for anarchy and riots; women were unsafe, farmers were ignored, and youth couldn't find jobs," he said. Under SP rule, he claimed, "even government jobs were auctioned off beforehand, and farmers and the poor did not receive necessary benefits.

# 1984 riots: Delhi HC says murder trial to continue against Jagdish Tytler his plea read. Senior advocate H S Phoolka,

New Delhi, Nov 11: Justice Manoj Kumar Ohri was hearing a plea filed by Tytler seeking a stay on the trial proceedings taking place against him in a Delhi court. The court would continue with the hearing on November 29. "It is made clear the trial will continue. Same will be subject to the outcome of the present proceedings,' the judge ordered. Tytler's counsel submitted the case was listed for the recording of evidence of a prosecution witness before the trial court on November 12 and the trial court be asked to not proceed till the high court decided his plea against the framing of charges order. Tytler's plea challenging the framing of murder and other charges against him is listed on November 29 but he moved court with the plea to stay the trial. His plea said the evidence of the prosecution witness was recorded by the trial court and her cross-examination by the defence counsel was scheduled for November 12. "The criminal revision petition (of Tytler)

raised substantial questions upon the motivation of the prosecution and the investiga-



tion conducted by the CBI. Therefore, an order/direction from this court for the trial court to not proceed with the captioned matter till the pendency of the revision petition is expedient in the interest of justice,"

representing the victims, opposed the plea arguing the witness was old and suffered from various ailments and being subjected to multiple court appearances. She would be appearing in court for the fourth time, he said. Tytler has claimed being a victim of a "witch-hunt" and contended the trial court's order framing charges against him was "perverse, illegal and lacked application of mind". "Trial court has erroneously framed charges against the petitioner overlooking the settled principles of law on the point of charge," his petition stated. While Tytler's counsel raised the plea of alibi, claiming his absence at the time of the incident, the counsel for the CBI and victims argued the plea of alibi had already been decided and rejected by the high court. Tytler said there was no credible evidence to corroborate the allegations against him and the trial court's order was "misconceived" passed "mechanically" and liable to be set aside. He alleged it was a case of harassment wherein he was made to face the trial for alleged crimes committed more than four decades ago, and referred to being 80-years old and suffering from several ailments, including heart disease and diabetes. The trial court on September 13 framed charges against him after he pleaded not guilty. Besides murder, the trial court ordered the framing of charges pertaining to unlawful assembly, provocation, rioting, murder, promoting enmity between different groups, house trespass, and theft, among others. The CBI on May 20, 2023, filed a chargesheet against Tytler in the case saying he "incited, instigated and provoked the mob assembled at Pul Bangash Gurdwara Azad Market" on November 1, 1984. The mob, the agency claimed, provoked by Tytler, set a gurdwara ablaze and killed three men - Thakur Singh, Badal Singh, and Gurcharan Singh. Anti-Sikh riots erupted in several parts of the country in the aftermath of the assassination of then Prime Minister Indira Gandhi by her Sikh bodyguards on

October 31, 1984.

## Farmers concerned over Water Minister's statement on desilting Mettur reservoir

CHENNAI: Farmers have expressed concern over Water Resources Department Minister Duraimurugan's recent statement that it may not be scientifically feasible to desilt Mettur and other reservoirs, months after a government order (GO) was issued to desilt four reservoirs. On July 26, the government approved a project to restore the original capacity of the Mettur, Vaigai, Pechipparai, and Amaravathy reservoirs, which includes removing 13.75 million cubic meters of sediment from Mettur over four years. A project estimate of Rs 3.6 crore was prepared to obtain environmental clearance.

However, Duraimurugan stated that reservoirs are not desilted anywhere in the world and that sand would naturally wash away with the water flow.Farmers are concerned whether the state intends to abandon the desilting of Mettur Dam, which has not undergone maintenance since its construction in 1934.

KV Elankeeran, president of the Federation of Cauvery Delta Farmers Association, said, "Farmers have been urging the government to desilt Mettur reservoir to increase its capacity, which is essential for agriculture in the region." Meanwhile, the Water Resources Department (WRD) on Sunday issued a release stating that the tenders to desilt Vaigai and Amaravathy will be floated on November 13 and 20, respectively. Additionally, the tenders for Mettur and Pechipparai have already been opened.

# Woman tries to save aged mom, both fall into well and drown


TIRUPPUR: An 87-year-old woman and her 65-year-old daughter drowned after they slipped and fell into a 50-foot-deep well in their farmland in Ponnamara Thottam in Alangiyam on Sunday morning. The daughter had gone near the well to keep her elderly mother from accidentally falling into the well, said the police. The deceased were identified as S Mayilathal and her daughter M Pushpavalli Nayagi. Police said after the death of Mayilathal's husband Subbiah six years ago, she had been living with her three

According to police, Mayilathal had been suffering from mental health issues for the last few months. The elderly woman left the house on Sunday morning but did not return for a long time. Pushpavalli went in search of her mother and found her standing near the farm well. While attempting to keep her mother away from the well, the duo accidentally fell into the well and drowned. Mavilathal's youngest daughter Bhuvana

Sundari alerted the family, who called the villagers for help. Fire and rescue personnel from Dharapuram recovered the bodies after an hour of effort. The bodies were then sent to Dharapuram Government Hospital for post-mortem examination. The police registered a case and initiated an

## Kerala man dies in custody in Udupi, CID to probe case

UDUPI: A 45-year-old labourer died in police custody in Brahmavara on Sunday after he was arrested the previous day for allegedly harassing a woman and her children. The deceased, Biju Mohan, was a migrant from Kollam in Kerala. Udupi Superintendent of Police Dr Arun K said the Bramhavara police received a call at 7.45 pm on Saturday from Cherkady village, saying an unidentified man was allegedly harassing a woman and



her children. The victim, accompanied by her brother, also filed a complaint, stating that the man entered her home and harassed her and her children

A case was subsequently registered, and the accused was taken into custody. At 3.45 am, a sentry noticed Biju sitting motionless, with his head resting against the wall. He was immediately shifted to the Brahmavara Community Health Centre, but was declared brought dead. The SP said Biju's family has been informed and they are expected to arrive soon. "A case will be registered based on their complaint. Since this is a case of a lock-up death, the CID will probe the case as per law. A postmortem will be carried out by two medical teams and video recorded, and the inquest will be overseen by a judicial magistrate. All procedures will be followed as per rules and suitable action will be taken," he added.

# Wayanad: Down-to-earth issues plague high-profile constituency

Thamarassery Ghat road, which connects Kozhikode and Wayanad, is an exercise that calls for much patience and pluck. The stretch is prone to traffic blocks that can take hours to clear. The situation gets worse on weekends or holidays when travel plans can get totally disrupted. Lok Sabha elections in Wayanad used to be a tame affair until Congress leader Rahul Gandhi decided to run from the constituency in 2019. This placed Wayanad in the national spotlight. Priyanka Gandhi Vadra's decision to contest the seat vacated by her brother, following his second win in the general election earlier this year, has accorded the constituency wider recognition, given that this marks her foray into electoral politics. And Priyanka has signalled that she is up to the challenge, surprising even her campaign managers with unscheduled

house visits and interactions with people from all walks of life. Although such actions have generated a wave of goodwill and hope, the glitter and glamour of a high-profile campaign threatens to submerge the real issues of the constituency.

Chief among them is the rehabilitation of the victims of the July 30 landslides in Chooralmala and Mundakkai, which left a trail of destruction in three wards in Meppadi panchayat. People who lost everything in the tragedy are still living in rented houses or estates identified to relocate them approaching courts, official rehabilitation plans have been put on hold."Everyone is focused on the by-elections, and this includes the government and the media. The search for the bodies of missing persons has been halted and problems related to issuing of death certificates for the missing victims haven't been resolved. There are a lot of issues that require the urgent attention of officials, including speeding up procedures to debt write-off and comprehensive rehabilitation projects," said Shajimon, a Chooralmala native who now resides in Ambalavayal and is the convenor of the Chooralmala Jana Shabdham Action Council.

# Polavaram Project: New D-Wall design approval likely by this Nov 25

VIJAYAWADA: Designs for the new Diaphragm Wall of the Polavaram Irrigation Project are expected to be approved by November 25 this year and the works are likely to commence from the end of December or January next year. According to sources, the new D-Wall, which is estimated to cost around Rs 900 crore, will be executed by German company Bauer Group and it is expected to be completed by March 2026, if not December 2025.Polavaram project officials expect that if climate permits, the works can be executed swiftly. They are expecting normal flood days in the Godavari River next season. However, to be on the safe side, the increase in flood days is also taken into consideration before finalising the work schedule.

The international experts' team which studied the scoured portions of the project and other aspects, is likely to examine and submit its recommendations to the Central Water Commission (CWC) for its approval for the Earth Cum Rock Fill (ECRF) Dam by February. Works for Gap 1 of the ECRF Dam are likely to be taken up in March next year and Gap 2 in November. In other words, both the D-Wall and the ECRF of the project will be taken up simultaneously. # Andhra Pradesh experiences 60 days of extreme weather

VISAKHAPATNAM: Andhra Pradesh experienced extreme weather conditions on 60 days out of the 274day period from January 1 to September 30, 2024, according to a report by the Centre for Science and Environment (CSE) titled 'Climate India 2024: An Assessment of Extreme Weather Events'. The adverse conditions led to 60 human casualties in the State, while agricultural, residential, and livestock losses were also substantial.

During this period, the State recorded significant damage to crops and homes. Crops covering 2,62,840 hectares were In Andhra Pradesh, specific extreme events reported as damaged, while 85,806 houses sustained partial or total damage, marking Andhra Pradesh as the State with the highest number of affected homes in the country. Additionally, 501 animals were reported dead as a result of these extreme weather events. Throughout India, extreme weather was observed on 255 out of 274 days, affecting 3.2 million hectares of crops, causing damage to 2,35,862 houses, and resulting in 3,238



human deaths. Nationwide animal losses stood at over 9,457 during this time.

were also highlighted in the report.Lightning and storms occurred on The authors highlighted that the frequency 12 days, leading to the loss of 17 lives. Heavy rainfall, floods, and landslides affected the State for 33 days, resulting in 43 fatalities. Additionally, the State experienced three warm nights - defined as nights when minimum temperatures remained 4 - 6.4°C above normal-in the months of March through June. The report distinguished between 'very heavy' and

'extremely heavy' rainfall, noting that such events were classified as extrme only when they caused damage. Heatwaves, recorded on 19 days in the State, were also a concern. The report defined a heatwave as an increase in maximum temperature by 4.5 - 6.4°C above normal, while a severe heatwave represented a rise of more than 6.4°C. They cautioned that, without meaningful measures against climate change, the impacts of extreme weather will likely intensify. In its analysis, the report observed that India experienced extreme weather events for over 90% of the first nine months of 2024.

of extreme weather events, previously expected once every century, are now occurring every five years or less. "This frequency overwhelms the most vulnerable populations, who lack the resources to adapt to this relentless cycle of loss and damage," the report added, stressing the urgent need for enhanced climate resilience measures.

## None to water them for three months, trees & plants are wilting here

Noida. Residents of sectors 51, 62, 31 and others complained about lack of upkeep of green areas for the past three months. As plants, trees, and grass dry up, residents are questioning why the Noida Authority fails to renew tenders before expiration, ensuring consistent upkeep.In Sector 51's Children's Park, trees have begun drying out, leading to growing concerns among residents. "Not even a drop of water has been given to these trees for the last three months. Due to this, even tall trees have started drying up and falling," said Sanjeev Kumar, RWA general secretary for blocks C to F of Sector 51."Trees and plants also have life, and by neglecting them, we are essentially killing them. Residents are upset and continually report that greenery is dying," he added.Gopal Verma, RWA general secretary of Rajat Vihar in Block C, Sector 62 had similar complaints. He expressed frustration over the deteriorating state of local parks. "All the parks in C block of Rajat Vihar have been ruined due to lack of proper upkeep. We're still waiting for the authority to address the issue," he said. In Sector 31, overgrown trees and grass add to residents' dissatisfaction. "I've been contacting Noida Authority senior officials continuously on the matter," said Devender Chauhan, a resident of Sector 31. "But every time, I get only assurances with no work." Residents say that calls to Noida Authority officials go unanswered. Vidya Sagar Virmani, RWA president of D block, Sector 20, shared, "Some senior officials have stopped answering phone calls. They forward you to their voicemail, saying they're busy. If they don't take calls, how will they address it?"Recognising the rising concerns, Yogendra Sharma, president of the FONRWA, assured residents that he would bring the matter to senior officials.

Responding to this, Anand Mohan Singh, deputy director of the Noida Authority's horticulture department, acknowledged the issues, promising prompt action. The electrical panel at Sector 51 park was damaged, and after installing a new panel, irrigation will resume. We had issued a tender earlier, but no contractor qualified in the first round. The retendering process is ongoing and may take another 15 days," said Singh.

## Diwali long gone, but garbage yet to be picked up since then

Noida. Over 10 days have passed since Diwali, but garbage remains uncollected in Sector 3, Greater Noida West, prompting residents to voice concerns about health risks and escalating sanitation issues.

On Sunday, residents said that household waste has not been collected since the festival, leaving garbage to pile up outside homes. Adding to the problem, a water pipeline leak in some parts of the sector has worsened the situation, with stagnant water, now mixing with uncollected waste."Household waste collection has not taken place since Diwali," said Laxman Singh Chamyal, a resident of Sector 3. "Waste collectors have not been coming to the sector for the past 10 days, and the house is filled with garbage, posing a health hazard."Other residents, like Mukesh Vashishth, noted the strange absence of the garbage collection van. "We can hear the jingle of the garbage collection van, but it hasn't entered our lane in the past week," Vashishth said. Aruna Shukla, another resident of Sector 3, said, "Water has been leaking in front of Janta flat D 533 for the last month. Authority staff came and dug a pit, but then left. Any incident could happen due to this pit, and we request the concerned authorities to take action immediately." Sandeep Sagar, the technical supervisor of the water department at GNIDA, assured that the issue is being addressed. In the city, the Diwali aftermath has taken a different shape, with idols, flowers, garlands, and diyas, discarded on roadsides, in parks, temples, and under trees across several sectors. This seasonal debris, left behind by celebrations, clutters public spaces, creating an unsightly mess for days following the festival. Local volunteers stepped up to tackle the issue. Members of Yuva Manch Jagran Samiti (YMJS), a local social organisation, collected Diwali puja materials from sectors 22, 30, and 31, immersing them in a temporary pond created in Muradnagar and sprinkling Ganga water over it as part of the ritual.

## Gr Noida set to ready a 15year master plan for drain network

Noida. Greater Noida Industrial Development Authority (GNIDA) is planning to develop a comprehensive 15-year master plan and detailed project report (DPR) for water, sewer and stormwater drains. A consultant will be hired to assess the current systems, forecast future needs, and align with GNIDA's master plans for 2021 and 2041. The Authority aims to upgrade and modernise Greater Noida's essential utilities to meet the city's growing demand across residential, industrial and commercial

The project is expected to revamp existing systems for water supply, sewerage and drainage, along with continuous (24x7) water supply, water auditing, GIS mapping, and establishing operation and management systems.GNIDA issued a tender and invited consultancy firms with expertise in large-scale urban infrastructure projects. Selection will follow a qualitycost based selection (QCBS) model, with 70% weightage on technical expertise and 30% on financial considerations. A pre-bid conference has been scheduled for Nov 14, followed by the deadline for bid submissions on Nov 28. Technical bids will be opened on Dec 2 and financial bids will be considered subsequently for qualifying bidders.

"With this master plan and DPR, we are laying the groundwork for a resilient and sustainable infrastructure system that can meet Greater Noida's needs through 2041 and beyond," a GNIDA official said. The consultant will study all existing water sources, storage facilities and distribution networks in the city. This includes data verification, on-site assessments and closing data gaps to build a complete understanding of the network from sources to endusers. The consultant will evaluate the Ganga water treatment plant and current disinfection methods, forecast demand for 2041, and design a water supply scheme that addresses leftover areas. The consultant's work will unfold in two main stages.

# 5 of a family die after car crashes into truck parked on Noida e-way

Noida: Five members of a family died after the WagonR in which they were travelling crashed into a truck parked on the Noida expressway on Sunday morning.The accident occurred near Sector 146 metro station in Greater Noida around 6am when the five were returning from Child PGI hospital, where the daughter of a relative is admitted. The truck parked on the expressway had flat tyres - and its driver had gone to look for a mechanic, leaving the vehicle by the side of the road without any warning signs. Aman, a daily wager, was driving the WagonR – HR 51BY 1774 – back home to Ghodi Bacheda village in Dadri with his father Devi Singh, mother Rajkumari and two maternal aunts Vimlesh and Kamlesh when he crashed into the truck from behind.Police suspect he had dozed off after staying awake the previous night at Child PGI. "Since the expressway was empty that early in the morning, the car was being driven at high speed. So, the impact was severe when the WagonR rammed the truck. The car was mangled and its occupants were trapped inside," said Ashok Kumar, additional deputy commissioner of police, Greater Noida.Informed by passersby, a team

arrived from Knowledge Park police station. Four of the occupants were brought out of the car and rushed to a nearby hospital, where they were declared dead on arrival.

Aman, who was behind the wheel, was stuck inside the mangled car. The police team had to cut open the vehicle to bring him out. Two hours had already passed by then and Aman had died on

He is likely to have dozed off at the wheel, causing the car to swerve towards the left and crash into the parked truck. The truck had broken down merely half an hour earlier after two of its tyres were flat. The driver had gone to get a mechanic when the accident occurred," said a senior police officer at Knowledge Park police station. Since it was a Sunday and most offices stayed shut, a traffic snarl was spared on the expressway. "We cleared the vehicles using a crane. The bodies were handed over to the families after an autopsy," Kumar said. It was merely a week ago that tragedy struck the family. Aman, the primary earning member, lost his twoyear-old daughter to illness a day before Diwali."He was the backbone of his



family. This tragedy is unimaginable," said Sunil, Aman's friend who arrived at the hospital to take the bodies back.Back home in Ghodi Bacheda village, Aman's wife collapsed after hearing the news of her husband's death. She has two children

aged five and seven years - to raise."Aman's younger brother Sonu studies in Class 11. He wanted to pursue higher studies so that he could bring the family out of poverty. But it seems he will now have to look for a job to augment the family income," Sunil said.An FIR was

registered against the truck driver under Section 106 (death due to negligence) of BNS. Parking isn't allowed on the expressway because of the sheer speed at which vehicles pass by. "The truck driver is untraceable. We are scanning CCTV footage and gathering inputs to track him down," said a senior officer.arlier in the day, chief minister Yogi Adityanath asked officials to reach the spot and expedite relief work. # Submit affidavit on trees to be cut for kanwar route, UP told

**Ghaziabad.** The National Green Tribunal (NGT) has asked UP govt to submit an affidavit from the additional chief secretary (environment), specifying the exact number of trees that will be felled for the kanwar corridor.In an earlier order, the NGT had asked the Surveyor General of India to submit satellite images of 2018 and 2024 to make a comparison of the environmental damage done in the intervening six years in the area. The images were supposed to have been sourced from the National Remote Sensing Centre (NRSC) in Hyderabad.On Oct 4, the SGI informed the tribunal that satellite imagery of the region was available only for this year, but not 2018.

So, the bench of chairperson Prakash Shrivastava, Arun Kumar Tyagi, and expert member A Senthil V ordered a drone survey of the area and sought a report in 30 days. The Centre has allowed 1.1 lakh trees to be cut for the project."The Surveyor General of Survey of India has stated that he can conduct an aerial survey using UAV/drone to generate orthorectified images of the area to capture the present ground situation and to

identify the extent of trees cut on both sides of the (upper Ganga) canal. He has submitted that this exercise can be completed within a period of 30 days and the report can be submitted before the Tribunal," the bench said on Oct 4. Along with this report, drone survey images covering a linear stretch of the 100km-long corridor on both sides of the canals were also submitted with the NGT this Thursday. But comparing the images was difficult because of the varying resolution."The report does not reflect what attempts were made by the Survey General of India to find out the satellite imagery of the area concerned," read the NGT order on Saturday. The tribunal then gave the additional chief secretary two weeks' time to file the affidavit. The next hearing was scheduled for Nov 25.

# **US Supreme Court Justice** Sonia Sotomayor has no plans to resign amid Trump's victory

World After the US presidential election results, talks in the legal corridors of the United States have been about resignations of liberal judges but reports suggest that Justice Sonia Sotomayor is not scheduled to resign before her term due to poll verdict. Presidentelect Donald Trump has warned regarding the rushed appointment of judges to the court before he is inaugurated on January 20. Justice Sotomayor, 70, is the third-most oldest judge of the Supreme Court and suffers from Type-1 diabetes.Democrats have been urging Justice Sotomayor to resign as Trump returns to the White House after defeating Vice President Kamala Harris and it'll also give President Joe Biden an opportunity to appoint a younger replacement to the Supreme Court."This is no time to lose her important voice on the court, she takes better care of herself than anyone I know," a source told the Wall Street Journal. A CNN report stated "She's in great health, and the court needs her now more than ever.'

Vermont Senator Bernie Sanders, in an interview with NBC News, acknowledged that he has heard "little bit" about Justice Sonia Sotomayor being asked to step aside but Sanders added that such demands for Sonia to resign are not "sensible". Even if Sotomayor agrees to resign and the Biden administration plans to successfully confirm another judge as replacement before the January 20, 2025 inauguration is logistically impossible.

The average retirement age of judges in the judicial system in the United States is 75 while Sotomayor, who is 70 as of now, remains in good health and has five years in the account. Though judges in the US are appointed for life and have generally chafed at public pressure campaigns to step aside. Post inauguration, Trump may have further opportunities to reshape the Supreme Court. The two Conservative Justices Clarence Thomas and Samuel Alito are aged 76 and 74 years old respectively.

# Indian American Democratic fundraiser receives racist messages

World An Indian American Democratic Party fundraiser and Vice President Kamala Harris supporter has been subjected to racist and threatening mobile messages demanding his departure to India.

A text message received on Sunday from an unidentified number told Ajay Jain Bhutoria: "You claim that you are doing what's best for Americans, but you aren't doing anything for Americans and you don't care about America. You are Indian. You only care about Indians. You do what's best for India. Why are you here? Stop being a beggar in America and become a leader in India.

Currently serving as the Deputy National Finance Chair DNC and National Finance Committee member for the Harris-Walz campaign, Bhutoria also holds a position as Commissioner on the President's Advisory Commission on Asian Americans, Native Hawaiians, and Pacific Islanders. His work has been significant in addressing various legal immigrant community concerns. Bhutoria told news agency PTI: "Trump supporters asking me to go back to India to fight for green card backlog."The text messages, some of which Bhutoria shared on social media platforms, included statements like "Stop being a beggar in America and to be a leader in India."

# Pakistan Railways suspends train services to and from Quetta station after explosion

World. Pakistan Railways has implemented a temporary suspension of train services to and from Quetta station, after an explosion that claimed 26 lives and injured 62 people. The suspension will be in effect from November 11 to November 14 to ensure passenger safety, according to ARY News.

Railway authorities have confirmed that Quetta railway station will cease operations during this period.

Train services will resume gradually, with the Bolan Mail operating from Karachi to Quetta on November 16, followed by its return journey to Karachi on November 18.The Jaffar Express service will commence from Peshawar to Quetta on November 14, with its return journey scheduled for November 15. Police officials confirmed that the explosion occurred during the Jaffar Express departure when the station was crowded with passengers.

Railway authorities indicated that two trains, the Chaman Passenger and Jaffar Express, were scheduled to depart from Quetta for Chaman and Peshawar respectively. Passengers for both services were present on the platform during the incident.

Prime minister Shehbaz Sharif has requested an investigation report into the incident, stating, "Terrorists will pay a heavy price for their heinous act."Interior minister Mohsin Naqvi stated that terrorists intend to create instability in Pakistan, adding, "The nation will foil their designs."

# Sri Lanka's President vows to stop Tamil Nadu fishermen, assures steps to return Tamil land taken by govt

At his first rally in Jaffna since becoming president, Dissanayake said political prisoners will be freed but refrained from discussing enforced disappearances, a key issue for many seeking justice.

JAFFNA. Sri Lankan President Anura Kumara Dissanayake, who addressed his first public meeting in Jaffna since coming to office in September, on Sunday took a firm stance against Indian fishermen "illegally" fishing in Sri Lankan waters. He also assured Tamils that their land occupied by the Sri Lankan government would be returned to them. Dissanayake was in the city a day before the campaign for the Sri

Lankan parliamentary elections, scheduled for Thursday, comes to an end to canvas votes for his Janatha Vimukthi Peramuna (JVP)-led National People's Power (NPP) alliance.In a well-attended meeting, he said Indian fishermen were destroying the marine resources that belong to the Tamil-populated northern region of Sri Lanka. Stating that his government will ensure that such exploitation of marine resources does not happen and will protect the rights of Sri Lankan fishermen, he asked, "Should we not?"To which the crowd responded with a resounding yes. His speech comes in the backdrop of the arrest of 23 fishermen from Rameswaram and the detention of three Indian trawlers by the Sri Lankan Navy on Sunday for illegally fishing in Lankan waters. This is the latest in a series of arrests. In a letter to the Union government on October 23, urging its intervention in the release of the fishermen, Tamil Nadu Chief Minister MK Stalin had pointed out that 128 fishermen and 199 boats were in Sri Lankan custody. While expectations were high on what the new president would promise to Tamils in the



north and east, who face several problems even 15 years after the end of the civil war, Dissanayake made significant assurances-for the first time-on two important issues vis-à-vis land and political prisoners. He said steps would be taken to gradually return land still occupied by the Lankan government, especially the military, to the rightful owners. He also said political prisoners still lodged in prisons will be released. The two announcements drew the loudest cheers from the mostly Tamil crowd during the rally. However, the president did not speak about enforced disappearances, for which thousands of people are seeking justice in a democratic manner. Although many Tamil parties have asked the NPP to clearly spell out its stance

on a political solution for Tamils in terms of devolution of more powers, Dissanayake refrained from the topic. Instead, he said his alliance will ensure "full freedom" of Tamils. Highlighting the opening of a new road that had been under military control since the war, the Sri Lankan President said such measures will be done continuously through talks with the defence department to ensure the freedom of Tamils. Elections for the provincial councils will also be conducted soon, he said.

Acknowledging the concerns Tamil people have about his alliance, he said they will be cleared through the positive measures his government will implement gradually.

Dissanayake's speech stressed on his alliance's broader theme of "nation building" without creating divisions between the Sinhalese, Tamils and Muslims, as well as economic development and tackling corruption. He also said his government will focus on building the rural economy and tourism in the north.Stating that drug abuse had increased in northern Sri Lanka, Dissanayake blamed politicians for the prevalence and said he would control it.

# Young Black, Latino men say they chose Trump because of the economy and jobs. Here's how and why

WASHINGTON. Brian Leija, a 31-year-old small-business owner from Belton, Texas, was not surprised that a growing number of Latino men of his generation voted for Donald Trump for president this year. Leija had voted for the Republican in 2016 and 2020.Leija's rationale was simple: He said he has benefited from Trump's economic policies, especially tax cuts."I am a bluecollar worker," Leija said. "So, tax breaks for small businesses are ideal for what I do."For DaSean Gallishaw, a consultant in Fairfax, Virginia, a vote for Trump was rooted in what he saw as Democrats' rhetoric not matching their actions. "It's been a very long time since the Democrats ever really kept their promises to what they're going to do for the minority communities," he said. Gallishaw, 25, who is Black, also voted for Trump twice before. This year, he said, he thought the former president's "minority community outreach really showed up."Trump gained a larger share of Black and Latino voters than he did in 2020, when he lost to Democrat Joe Biden, and most notably among men under age 45, according to AP VoteCast, nationwide survey of more than 120,000 voters. Even as Democrat Kamala Harris won majorities of Black and Latino voters, it wasn't enough to give the vice president the White House, because of the gains Trump made. Economy and jobs made men under age 45 more open to TrumpVoters overall cited the economy and jobs as the most important issue the country faced. That was true for Black and Hispanic voters as well. About 3 in 10 Black men under age 45 went for Trump, roughly double the share he got in 2020. Young Latinos, particularly young Latino men, also were more open to Trump than in 2020. Roughly half of young Latino men voted for Harris, compared with about 6 in 10 who went for Biden.Juan Proaño, CEO of LULAC, the nation's largest and oldest civil rights organization for Hispanic Americans, said the election results make it clear that Trump's messaging on the economy resonated with Latinos."I think it's important to say that Latinos have a significant impact in deciding who the next



president was going to be and reelected Donald Trump," Proaño said. "(Latino) men certainly responded to the populist message of the president and focused primarily on economic issues, inflation, wages and even support of immigration reform."The Rev. Derrick Harkins, a minister who has served Abyssinian Baptist Church in New York, has overseen outreach to Black American religious communities for more than a decade. He said that Trump's hypermasculine appeal worked to win over some younger men of color."I

think that Trump with this bogus machismo has been effective amongst the young men, Black, white, Hispanic," Harkins said. "And I think unfortunately, even if it's a very small percentage, you know, when you're talking about an election like we just had it can be very impactful."Black and Latino voters' priorities changed from 2020

While about 4 in 10 young voters under 45 across racial and ethnic groups identified the economy as the top issue facing the country, older white and Latino voters were likely to also cite immigration, with about one-quarter of each saying that was the top issue.A clear majority of young Black voters described the economy as "not so good" or "poor," compared with about half of older Black voters. Majorities of Latino voters, regardless of age, said the economy is in bad shape. That belief made it more difficult for Harris to highlight the actual numbers in the economy, which show that inflation has receded dramatically, unemployment remains low and wages have risen.

## Four arrested in Thenmala moral policing case

KOLLAM: In a suspected case of moral policing, the Thenmala police have arrested four individuals for allegedly assaulting a young man. The suspects, identified as Sujith, Rajeev, Sibin, and Arun, have been accused of stripping Nishad, a resident of Edamon, tying him to an electric post, and assaulting him. The police have indicated that the incident stems from a family dispute between Sujith and Nishad. The police said in addition to the four arrested individuals, they are also searching for a fifth person connected to the incident. Nishad is currently receiving treatment at Punalur Taluk Hospital. According to the police, the assault occurred around 11pm on last Thursday. Nishad had arrived at his friend Pramila's house in Anoor, Thenmala, when the suspects arrived with the intent to attack him. Upon realising the presence of the assailants, Nishad attempted to flee. However, the suspects managed to overpower him, dragging him onto the road where they assaulted him with a rod and a machete.

Nishad suffered injuries to his head and both legs, with his left leg being fractured. After the attack, the suspects stripped Nishad and tied him to an electric pole. They continued to assault him and filmed the ordeal, later sharing the footage on social media.

## Tracker-tagged vulture found near Kadamba Naval Base

HUBBALLI: A vulture, which had a GPS tracker and was found in the vicinity of the Kadamba Naval Base in Karwar of Uttara Kannada district, created a flutter on Sunday as security officials wondered whether the bird was being used for espionage purposes.

But their suspicion was unfounded as the GPS tag on the bird was found to be fitted by the the Bombay Natural History Society (BNHS). "The vulture was tagged for research purposes and there are records that similar GPS-tagged birds flying around Karwar. Its said that the vulture had been released from the Tadoba-Andhari Tiger Reserve. The transmitter on its back bears the website address mahaforest.gov.in," a district administration official said. Naval base authorities had been tracking the bird and on Sunday, they managed to take its photos and videos and the GPS tag. Local residents along the riverbank in Karwar had taken photographs of the bird and informed naval authorities a day earlier.

Naval authorities tried to catch the bird, but it flew away. Naval Base authorities are on a heightened level of alert as recently, five people, including officials and local labourers, were arrested for passing on sensitive information to enemy nations on Phase 2 of the Kadamba Naval Base and warships. Later, a drone was spotted flying over the Naval Base at night. The sighting of the bird only further pushed security officials to the edge."The locals informed the authorities as the Kaiga nuclear power plant and the Naval Base are situated here. The Karwar police, forest department and state and central intelligence agency officials arrived at the scene. When we zoomed in on the tracker with the camera, the details on the tracker could be seen," a district official said.

# **GGH Cancer Centre to** get Rs 18 crore PET-CT scan and 90 more beds

GUNTUR: Following the overwhelming response from the cancer patients, the officials of the NATCO Cancer Care Centre, located in the Guntur Government General Hospital premises, are chalking out plans to extend services by bringing in advanced equipment and improving necessary infrastructure to cater the needs of growing patients.It may be noted that the State government has recently announced the facility as Level-1 Cancer Centre and also allotted 35,000 sq.ft land beside the existing institute to NATCO Trust for construction of an additional block, thereby increasing total bed count to 200 from 110. The government is planning to develop the facility as the State Cancer Institute.

Additionally, a PET-CT scan worth Rs 18 crore will be procured for the benefit of the patients. The officials have already made an order. PET-CT scan (Positron emission tomography-computed tomography) is a nuclear medicine imaging test that is important for diagnosing, staging, treatment planning, treatment monitoring, prognosis, radiation therapy planning and detecting lymph node diseases in cancer patients. With its addition, the Guntur GGH will become the first government hospital in the State to offer these services. The 1.6acre NATCO Cancer Care Centre boasts advanced medical equipment such as Varian Vitalbeam Linear Accelerator worth Rs 12 crore, BrachyTherapy, and CT Stimulator worth Rs 5 crore, a mammography machine worth Rs 2 crore.

The facility has become a one-stop solution for free cancer treatment and the centre offers services in the domains of radiation, medical and surgical oncology, nuclear medicine, and radiotherapy. It has over 25 oncology professors, assistant doctors, and junior assistant doctors providing superspecialty treatment to the patients.

# For Kerala women, migration a chance to break free

The peer-reviewed paper written after in-depth interviews with prospective students highlights that parents, too, are driven by the social benefits of migration

KOCHI: Women in Kerala view migration as an opportunity to challenge patriarchal norms and pursue personal growth, including the choice of partner and age of marriage, a recent study has revealed. The study, "Middle-class Indian students: Migration recruiters and aspirations" by Anand Panamthottam Cherian of George Mason University, US, and S Irudaya Rajan from the International Institute of Migration and Development (IIMD), also highlights Kerala's migrationfriendly ecosystem, where over 50% of surveyed students aspire to move abroad.Rajan, chair of the IIMD and former professor at Centre for



Development Studies (CDS), told TNIE that female students take migration as an opportunity to escape from peer and cultural pressure of getting married and having children. "Going abroad makes it easy for women to choose partners of their liking and settle as per their choice. Parents are also accommodating of the choice of partners when their girl child is

The peer-reviewed paper written after indepth interviews with prospective students in Kochi, Thiruvananthapuram, and Kozhikode highlights that parents, too, are driven by the social benefits of migration, with many recognising its potential to elevate their family status. For instance, middle-class parents encourage children to migrate abroad, citing the respect and high social standing it would bring, it says.

According to the study, women wish to migrate as they want to come out of the dependence they have had over the years and to avoid surveillance from family and relatives-from going out to deciding what to wear. Many wish for a transition from a 'village girl to a cosmopolitan girl', it says.

KMS 2023 supports trend of rising female migration'

Migration helps, especially women students, acquire the ability to provide new gendered possibilities for experimenting with speech and attire. It provides agency to women in a

patriarchal society in a way that facilitates their empowerment," says the study.Rajan noted that the Kerala Migration Survey (KMS) 2023 supports the trend of increasing female migration, particularly among students. The survey reveals that 54.4% of student emigrants from Kerala are males while 45.6% are females. This shows a narrower gender disparity among student emigrants compared to the overall emigrant population from Kerala, where males comprise over 80%.KMS-2023 also reveals a significant surge in student migration from Kerala, with the number almost doubling in just five years. It adds that Kerala is poised to become one of the top states in terms of students pursuing education abroad. This reflects the Kerala students' desire for high-quality education and better career opportunities. The survey estimates that 2.5 lakh student migrated from Kerala as

## Man held for sending obscene pics to Delhi woman nine years ago

DINDIGUL: The cyber crime wing of Delhi police with the help of Dindigul police have arrested a 34-year-old software engineer for allegedly sending obscene pictures to a woman in New Delhi nine years ago using the SIM card of a DMK functionary. According to police, Chinna, a local functionary of DMK, lost his SIM card at a political meeting in 2015. A few weeks later, a team of police personnel from New Delhi arrived at his doorstep for allegedly sending obscene pictures using the lost SIM card to a woman living in Delhi.

The police said the woman had complained about receiving messages rom Chinna's number and an FIR had been filed, the police said.Chinna's advocate, who appeared at the Delhi High Court, submitted evidence of his client losing the SIM card at an event. Chinna also registered a complaint with Batlagundu police in this connection in 2015.Last week, the cyber crime wing of the Delhi police began investigating the case again. With the Dindigul police's help, they traced the SIM card to a location in Theni and arrested Hari Pradeep (34), a software engineer, from a house. He was produced before Nilakottai Judicial Magistrate (Dindigul) and sent to New Delhi for investigation.

# Are BBMP multi-level car parks turning into white elephant?

BENGALURU: While parking remains a Mobility Expert Professor Ashish Verma, major challenge in Bengaluru, BBMP's Multi-Level Car Parking (MLCP) facilities across the city, including those on JC Road and the one recently opened at Freedom Park, remain largely unused. As BBMP explores ways to boost usage, the 'low occupancy' raises broader questions about the need for such facilities, especially with all MLCPs in the city facing similar issues. Raghavendra P, a worker at the Freedom Park

MLCP mentioned that the problem is especially evident during evenings and weekends when these spaces are almost entirely empty. "Many motorists continue to park illegally, without considering using the MLCPs," he said, pointing out that the facility is only making Rs 6,000 to Rs 7,000 daily, far below expectations.

who also heads the transportation engineering research lab at the Indian Institute of Science (IISc), highlighted that MLCPs are not sustainable solutions to traffic congestion. He explained that such infrastructure projects often fail because of lack of location review. "If the MLCP location does not offer connections to key areas, it will only encourage greater use of personal vehicles, which eventually spill onto the roads, making traffic conditions worse," he said, adding that simply providing more parking spaces encourages people to continue using private vehicles rather than shifting to public transport or other alternatives. Professor Verma highlighted that the government must evaluate whether an area actually

needs an MLCP. "For example, if an MLCP is placed in a congested area like Freedom Park or JC Road, but people need to travel to another congested area like Chickpet with no proper connectivity, the facility will be pointless. Without proper links to key areas,

the MLCP will likely be underused or

abandoned," he highlighted. The expert stressed that unless policies are designed to promote connectivity and prioritise mobility options, these measures will only worsen the problem. What's needed, he argued, is a comprehensive mobility strategy that reduces dependence on private cars and focuses on improving public transport and other sustainable

Parking problems should be solved by demand management interventions managing how many people need parking rather than supply side interventions like creating more parking spaces. The real issue is traffic movement, so focusing on reducing the number of cars on the road and encouraging better public transportation options is key, the mobility expert added.

# Madras High Court orders action plan to stop sewage flow into Thamirabarani river

# Andhra Pradesh govt to table budget for last quarter of FY25 on November 11

Corporation covers an area of 108 sq. km VIJAYAWADA: The State government is set to table the budget for the last four months of the financial year 2024-25 (December-March) in the Legislative Assembly on Monday. The Business Advisory Committee (BAC) will decide the duration of the Assembly session.After getting approval from the State Cabinet on Monday, Minister of Finance Payyavula Keshav will present the budget in the Assembly. According to sources, the outlay of the full-fledged budget is expected to be between Rs 2.7 lakh crore and Rs 2.9 lakh crore, with a focus on covering expenditures for the last quarter of the current fiscal year. Allocations for welfare programmes and promises made in the election manifesto, including the Super Six guarantees, are likely to be announced. Budgetary provisions will also be made for Deepam 2.0 scheme, which was launched on Diwali day (October 31). Additionally, significant allocations are expected for Amaravati, Polavaram, and other crucial infrastructure projects. Ahead of the elections, the previous government, led by YS Jagan Mohan Reddy, had introduced a vote-onaccount with an outlay of Rs 2.86 lakh crore. A sum of Rs 1,09,052 crore was approved for the period from April to July.

> An ordinance was promulgated on July 31, allowing the TDP-led NDA government to allocate funds for four months from August 1 to November 30. With an outlay of Rs 1.29 lakh crore, the Andhra Pradesh Appropriation (Voteon-Account No. 2) Ordinance, 2024 covered grants allocated to 40 government departments.Besides the budget, key bills, including Land Grabbing Act (Prohibition) 1982 Repeal Bill, AP Judicial Preview Act Repeal Bill, new Land Grabbing (Prohibition) 2024 Bill, are likely to be tabled during the Assembly session.

He had observed that as the value of lands in the State increased, land grabbers and encroachers also increased. It has been learnt that since the new government took over, 80% of the complaints received by the Revenue Department were related to land.

# Mango kernel deaths: A bitter cost of hunger and failing governance

MANDIPANKA (KANDHAMAL): The scar left by the death of two women after consuming mango kernel is starkly visible in Mandipanka village of Kandhamal district. The village atmosphere is unusually silent despite the rush of administration officials, politicians, NGOs and activists after the October 31 tragedy, which has brought back the haunting memories of the infamous 2001 Rayagada district incident, when 24 tribals had succumbed under similar situation. On the path in front of the asbestos-roofed house of Anil Patamajhi stand two plastic chairs covered in white sheets with garlanded photographs of both the victims on them. A few feet away, Anil struggles to tend to his six-month-old daughter, who has just lost her mother with grandmother battling the consequences at MKCG Medical College and Hospital in Berhampur.

On October 31, his wife Ramita (28) and a neighbour Runu Majhi (30) died while six others were hospitalised after they consumed the fatal gruel. Though three of the six injured, including Anil's sister-inlaw have been discharged after treatment, his mother is still admitted at MKCG MCH and two other neighbours at SCB Medical

College and Hospital in Cuttack."This mango kernel took the life of my wife. Had there been sufficient rice, we would not have consumed the mango kernel gruel," said Anil Patamajhi pointing his finger towards the leftover kernels kept in a polythene carry bag. Describing the fateful day, he said, Runu had recooked the leftover gruel kept in open for two-three days and distributed among the women members of the three families. "We had taken fermented water rice while the children had gone to Anganwadi centre where they had food. This saved our and

# The permanence of our loss

Much like how vaccines work, loss too operates, though just a bit differently. Once you have taken a vaccine, the next time your body senses the disease, it knows the drill. Just a bit similarly yet disease, it knows the diffi. Just a bit shiffially yet differently, once you have gone through loss, the next time you witness loss, your body recognises it, even though it does not ever learn to deal with it. Loss bruises you again, and you learn to sense loss, every time. The stalwart Dr Bibek Debroy died last week, and he had penned his obituary four days before he passed away which was four days before he passed away, which was published in a national daily. The news of his passing made me feel a profound sense of what Dr Debroy terms 'social loss', but it was definitely reading his self-obituary that catapulted me into feeling loss at its very atomic form. While I did not know Dr Debroy personally, I do know loss personally, for it is a shared feeling, though it looks different to and for each of us — much like living, we all know what it is to live, though in our own ways. While reading Dr Debroy's note, I was spurred into exploring my detachment with life, for two of Dr Debroy's thoughts echoed consistently — whether on his possible passing away permanent loss will accrue (except one personal loss), and his concluding sentence on whether the mind will or can heal from the experience undergone.

On loss, Dr Debroy wrote, 'not much social loss', 'possible private loss', finally concluding with 'no permanent loss'. And so I wonder, what is loss, beyond the dictionary? Is loss just the future loss of the social value we create, the networks we might have enriched in the future? Is loss quantified as the missing ideas that someone would have ideated had life not been cut short? Is loss seen as the empty seat at the dining table that speaks of the love that once flowed? Is the absence of grieving an indicator of the impermanence of loss? I borrow ink from CS Lewis and Madeleine L'Engle who called the death of a beloved 'an amputation'. You indeed feel like you have lost a limb when you lose someone you love. The pain, searing at first, persistent yet fading as time passes, and as the months go by, the dull ache of loss, the bottomless pit in your being that talks of your loss, all the time. The loss is permanent but you learn to live with the loss. Does it mean the loss is lost? Maybe not. We are so adept at adapting, we learn. Yet, the loss is potently permanent. You cannot tell someone to stop missing their arm, or their leg, you cannot tell someone to stop missing someone they loved. Like the vaccine response, my muscle memory invokes my sense of personal loss on losing my father. As we step out of the festive season, for one going through the loss of a loved one, this time of the year is that intrusive thought that keeps scraping off the scab every time, and any hopes of living with a healed scar are lost. And so was it for us as a family, this year.

Navigating a melange of emotions, my mind was occupied with what Chimamanda Ngozi Adichie, in her deeply felt memoir 'Notes on Grief', wrote, "I am writing about my father in the past tense, and I cannot believe I am writing about my father in the past tense". This sentence remained with me ever since, for this parting sentence of the book carves an abyss so deep where even silence does not reach. I realised I will choke if I told myself the meaning of Chimamanda's sentence, and so I just read it like it is, literally. Is this loss not permanent? I have learnt to live with the loss of my father whom I loved dearly, but is routine akin to forgetting? I affirm, no. If Chimamanda could not bear the thought of writing about her father in the past tense, was loss really impermanent? Dr Debroy concluded his note wondering whether the mind will or can heal from the experience undergone. This nudged me to think whether the very act of writing our own obituary can be termed as an inflexion point in the trajectory of our lives, for a self-obituary is not just a reflection on how we lived life, but a blueprint of how we intend to live life. Dr Debroy spoke with detachment of the vast body of work he leaves behind, but the intangible aspects of loss and detachment are what he leaves for us to think. What if we write our own obituaries at some point in our lives, will we be able to add meaning to the years lived, and the moments to be lived?Dr Debroy, in writing your obituary, you have etched the permanence of our loss.

# The fascinating world of agama, the reclusive lizard

Lizards have long suffered from an undeserved negative image in popular culture

Walking in the high mountains or lush tropical forests, often a splash of bright colour or a sudden movement catches the eye, and more often than not, it turns out to be an agama, quietly basking in its surrounding, still as a statue or scurrying across to safety at great speed, scared out of its reverie by an intruder. The diverse world of reptiles is often overshadowed by fear and misunderstanding, yet it holds creatures that are crucial to the delicate balance of our ecosystem. Among these are the agamas — a family of small to medium-sized lizards belonging to the family agamidae, widespread in Asia, Africa and Australia.

Known for their sturdy build, powerful legs and a range of vibrant colours, they are highly adaptable creatures, occupying a wide range of habitats from deserts and mountains to rainforests, and often close to human settlements as well. Despite being coldblooded or ectothermic like most reptiles, unable to regulate their body temperature internally and relying on external sources of heat, they can survive at an elevation up to 5,000m.

Agile hunters of inects and other small invertebrates like ants, termites and beetles, they play an important role in controlling their populations in the ecosystem. Some species that consume plants and fruits also play an important role in seed dispersal.

India is home to a fascinating variety of agamid species, each uniquely adapted to the country's diverse climates and landscapes. Some well-known species include the Himalayan Rock Agama (paralaudakia Himalayana), Peninsular Rock Agama (psammophilus dorsalis), Fan-throated Lizard (Sitana ponticeriana) and the commonly seen Oriental Garden Lizard (calotes versicolor), each with their own unique appearance and ecological role. Agamas possess a fascinating array of physical and behavioural adaptations that make them unique. One of the most captivating aspects of these lizards is their ability to change colour, especially in response to different environmental and social stimuli. The Oriental Garden Lizard, for example, displays a striking red colouration during the breeding season, with dominant males often showing off this brilliant hue to attract mates or warn rivals while the Fan-throated Lizard does the same with a thin flap of skin called a gular appendage between its throat and abdomen. This colourchanging ability is not only visually remarkable but also serves as a form of communication within the species. At the same time, they are masters of



camouflage as well, blending seamlessly into their surroundings. Despite their ecological value, agamas face a number of threats that ieopardise their population and the larger ecosystems they support. Habitat loss is a major issue, as urbanisation, deforestation and agricultural expansion encroach upon the natural habitats where they thriveMany species such as the Peninsular Rock Agama rely on specific rocky or arid environments that are increasingly being destroyed or fragmented by human activities. As natural habitats shrink, agamas are forced into smaller, fragmented areas, which can lead to decreased genetic diversity and increased vulnerability to environmental changes.


Climate change further exacerbates these threats by disrupting the delicate environmental cues that guide agamas' breeding, feeding and hibernation patterns. Rising temperatures, altered rainfall patterns and the increasingly erratic availability of food can place tremendous stress on these small lizards, leaving them vulnerable to population decline. Another significant threat is human hostility rooted in misunderstanding. Lizards, in general, have long suffered from an undeserved negative image in popular culture, with many people associating them with danger or disease. Agamas are no exception, often viewed with fear or disgust, and people go to great lengths to remove them from homes, gardens and public spaces.

In reality, agamas are shy, reclusive creatures that avoid human contact, making them unlikely to harm anyone. The simple act of allowing agamas to coexist peacefully actually offers effective pest control in our surroundings without the need for harmful pesticides or insecticides.

Promoting a greater appreciation for agamas and reptiles, in general, is essential, not only for their preservation, but also for the overall health of ecosystem. Educational initiatives that raise awareness about their harmlessness to humans and importance in the ecosystem can go a long way in dispelling misconceptions. Simple actions — such as letting agamas coexist in gardens and parks within cities — can allow them to continue their ecological functions while enthralling us with their vibrant social behaviours. Agamas remind us of the intricate and delicate web of life that sustains our planet, and it is up to us to protect and cherish every thread.

# **Consumer Rights: Diagnostic centres liable for negligence**

Given the increasing dependence of medical professionals on a variety of scans for diagnosing ailments and abnormalities, any negligence on part of a scanning centre or a radiologist could play havoc with the physical and mental well-being of the victim...

Given the increasing dependence of medical professionals on a variety of scans for diagnosing ailments and abnormalities, any negligence on part of a scanning centre or a radiologist could play havoc with the physical and mental well-being of the victim and the family. A recent order of the apex consumer court in Shrivari Sono Scans vs Sureshan highlights one such case where a resident of Kasargod in Kerala had to undergo a series of unnecessary tests and suffer immense anxiety, thanks to an erroneous report given by a diagnostic centre. It all began with TM Sureshan consulting a doctor for a stomach ache, way back in 2019. The abdominal and pelvic scan showed such serious complications in the liver and gall bladder that the doctor advised treatment from a specialist. Two days later, Sureshan travelled 100 km to Mangalore and consulted doctors at the Kasturba Medical College. Further tests carried out showed no abnormality. A repeat scan showed the first scan to be false. The National Consumer Disputes Redressal commission here upheld the order of the lower commissions awarding compensation of Rs 25,000 and costs of Rs 3,000 to Sureshan.

There have been instances where the consequences have been extremely grave. In Udayan vs Imaging Point, failure of the ultrasound scans to detect foetal anomalies denied the parents an option to terminate the pregnancy and prevent lifelong suffering for the child and themselves. The scanning centre argued that diagnosing genetic anomalies required a level 2 scan or a target scan, which neither the gynaecologist nor the patient asked for. All four scans were basic scans that could not detect such abnormalities.

After referring the issue to an expert panel from the All India Institute of Medical Sciences, the commission



held the gynaecologist as well as the radiologist guilty of negligence. Considering that the patient was 37 years old and suffered from gestational diabetes, the doctor should have asked for a target scan but failed to do so. The radiologist, too, had an ethical and legal duty to take the history of the patient, ascertain the gestational age and perform the relevant ultrasound scan, which he failed to do. Besides, limb anomalies such as presence or absence of arms, legs and feet should be checked in all standard obstetric ultrasound examinations performed in the second trimester and documented by the radiologist. The report of the scanning centre did not comment on the limbs at all, the commission observed. It directed the doctor and the scanning centre to jointly and severally pay Rs 1.25 crore as compensation and Rs 1 lakh as cost (May 25, 2022, case filed in 2009).

Last year, the Kerala State Commission awarded a compensation of Rs 50 lakh, with 8 per cent interest calculated from the date of complaint (2015) in a similar case. Here again, the baby was born with no lower limbs and hips but several scans done during the pregnancy did not reveal this. The commission held the doctors guilty of negligence for not recommending a level 2 scan and the hospital that conducted the scans equally liable for routinely reporting the increase in the length of the femur in every report, while the baby did not have legs at all. (Jayesh JR vs St Luke Hospital). Given the enormous

financial burden such negligence puts on the victims and the mental pain they undergo, consumer justice should be quick and compensation fully commensurate with the suffering. Unfortunately, in all these cases, the final orders have taken years, exacerbating the victims' suffering. Award of steep punitive damages by consumer courts and strict disciplinary action by the regulator are also necessary to prevent such carelessness by diagnostic centres.


# Simple lessons learnt well

I am writing this column days after the momentous US presidential election results. Enough has been written about them for us to be able to see the deep fault lines between the 'woke', left-leaning academic elite and the rest of middle-class America. I am, perhaps, not the only Indian who sees a similar divide here between our two main political groupings.

So, let me make this more personal. Our family moved to Allahabad in 1963 from Nainital, and it seemed to us hillbillies like no other town we knew. Perhaps, this was because we saw and savoured many new sights and sounds in a 'big city' for the first time. Vegetables such as tinda (which I first thought were raw tomatoes), parval and kundru were discoveries to us simple pahari folk nourished on greens, radish and many varieties of gobhi till then. that we spent years in Allahabad without ever going there. Once, during the 1966 Kumbh Mela, my two older sisters and I were allowed to go all alone to spend a night at the camp of the mela officer (an uncle). # 'Sky Is Just The Beginning': Vistara Bids Goodbye

New Delhi: The song 'Kal Ho Na Ho' played as Vistara's Goa-Bengaluru flight landed at its destination on Sunday, invoking nostalgia among crew and members a day before the carrier's time in the Indian aviation landscape was to come to an end.

The full-service carrier Vistara, which is a 51:49 per cent joint venture between Tata Sons and Singapore Airlines, is all set to merge with Air India on November 12. In an Instagram post, the airline said, "As the plane ascends, so do our dreams; let's glide toward the future, where the sky isn't the limit, but just the beginning."

#### Why Is Vistara Merging With Air India?

Singapore's flagship carrier announced a plan to merge the decade-old Vistara and Tataowned Air India in November 2022, in a bid to create a dominant full-service airline in the domestic and international markets. The merger process, however, was anything but smooth, with problems like pilot shortages causing widespread flight cancellations and Vistara crew protesting over plans to align their salary structures with Air India pving to be hurdles. As the merger concludes on Monday, Vistara's 49 per cent owner Singapore Airlines will have a 25.1 per cent stake in Air India. Singapore Airlines will



make an additional investment of ? 3,194.5 crore in Tata Group-owned airline.

How Is Air India Orchestrating The Transition For Fliers?

Air India has deployed additional resources, including help desk kiosks, at touch points and airports to ensure a smooth experience for Vistara passengers. There will be "customer support staff wearing 'How may I assist you?' Air India x Vistara branded tshirts for support". The staff will work with airport security to guide customers with old Vistara tickets to the nearest help desk or to Air India customer support staff and deploy advisory on self-service kiosks. In due course, Vistara airport ticketing offices and check-in terminals will become that of Air India. Vistara aircraft will be identified by a

special four-digit Air India code beginning with the digit '2'. Over the last few months, 2,70,000 customers who had booked Vistara flights have been migrated to Air India, and more than 4.5 million Vistara loyalty programme members are being migrated to Air India's loyalty programme. Further, customers calling the Vistara contact centre will be automatically directed to Air India representatives, who will ensure a seamless experience during this transition. The integrated entity will have a fleet of more than 200 planes, offering connectivity to 90 domestic

and international destinations. Air India's narrowbody fleet continues to be upgraded with new aircraft being delivered, legacy aircraft being refitted with entirely new interiors and Vistara's catering now also extended to Air India.Air India's widebody fleet has also been augmented with the entry of six A350 aircraft that have started to fly between Delhi and London, and Delhi and New York, the airline said. In the first month after the merger, nearly 1,15,000 passengers who had purchased Vistara tickets premerger are expected to fly on unified Air

Integration Officer for the merger of the two entities, will continue in the latter role postmerger. Besides, he will be a member of the management committee and report directly to Air India CEO Campbell Wilson, a company statement said.

Meanwhile, Vikas Agarwal, the current CFO of Air India Express, will move to a new role in Air India. Senior vice president for flight operations at Vistara Hamish Maxwell has assumed an advisory role to Air India Express CEO Aloke Singh while Pushpinder Singh, Chief Operations Officer of Air India Express, returns to flying, as per the statement. A successor for Singh will be announced in due course. Deepa Chadha and Vinod Bhatt, senior vice president HR & Corporate Affairs and Chief Information Officer of Vistara respectively, will take on senior roles at other Tata group companies, the statement said adding that Vistara CFO Niyant Maru, who had continued beyond his superannuation date to see through the completion of the merger, will retire at the end of his current term.

## **Justice Sanjiv Khanna** takes oath as 51st Chief Justice of India

A large number of activists, mainly from the Hindu Sikh Global Forum, gathered outside the High Commission of Canada in Delhi on Sunday to protest against the recent attacks on Hindu temples in Canada.

New Delhi: Justice Sanjiv Khanna took oath as the 51st Chief Justice of India at the Rashtrapati Bhavan on Monday, following the retirement of his predecessor, Justice DY Chandrachud.President Droupadi Murmu administered the oath of office to Justice Khanna at a ceremony attended by Prime Minister Narendra Modi, Vice President Jagdeep Dhankhar, Defence Minister Rajnath Singh, Minister of Parliamentary Affairs Kiren Rijiju, Minister of Power Manohar Lal Khattar, former Chief Justice DY Chandrachud, and other important personages.ustice Khanna's name was recommended by Justice Chandrachud, who retired from the post on November 10 at the age of



65. He will serve as the Chief Justice till May 13 next year.

Born on May 14, 1960, Justice Sanjiv Khanna studied law at the Campus Law Centre of Delhi University. He was a third-generation lawyer before being appointed as judge of the Delhi High Court. He also served as the executive chairman of the National Legal Service Authority (NALSA).Justice Khanna was appointed to the Supreme Court in January 2019. During his tenure as a top court judge, he headed the benches of several politically sensitive cases, including hearing the bail applications of Aam Aadmi Party (AAP) leader and former Delhi chief minister Arvind Kejriwal in the liquor policy case.In a decision described as one-of-its kind, Justice Khanna's bench granted interim bail to Kejriwal in May, specifically for campaigning during the Lok Sabha elections. The bench referred the case to a larger bench and granted interim bail to the former Delhi chief minister again in July, to explore the need for additional grounds for arrest under the Prevention of Money Laundering Act (PMLA) to prevent misuse of the law. As part of the Constitution Bench, Justice Khanna has also contributed to several judgments, including the revoking of Article 370 and the electoral bonds case. Justice Khanna's bench also dealt with issues related to the electronic voting machines (EVMs) and Voter Verified Paper Audit Trails (VVPATs).

# Navy to test new anti-ship ballistic missile with 1,000 km range soon

New Delhi:India will test its new anti-ship ballistic missile, which will be able to strike targets at a range of over 1,000 km in a major step towards bolstering firepower of the defence forces. The missile test is scheduled to be held in the next few days, which would be done from the eastern coast of the country, top sources told . The missile system will help the Navy to create a strong inventory of ballistic missiles, which are being used by countries engaged in conflicts. The missiles would enable the Navy to hit targets from both surface ships and shore-based locations.

The Defence Research and Development Organisation (DRDO) is also making hypersonic missiles for the defence forces. The decision to create a rocket force is aimed at strengthening India's medium-range striking capability, a feature already possessed by neighbouring countries Pakistan and China. As per the authorities, the Pralay missiles, which are currently being mass-produced, are expected to be ready for operational service soon.

These missiles, powered by a solid-propellant rocket motor and equipped with other novel technologies, have a range of 150 to 500 kilometres. The rocket force project would provide a significant boost to the armed forces' efforts to develop a strategic rocket force. The forces have been working on the creation of a rocket force to counter border threats.

# "Blatant Lie": 10 Kuki-Zo MLAs Say Never Met Manipur Chief Minister Since May 2023

New Delhi: The 10 Kuki-Zo MLAs in Manipur who have been calling for a separate administration carved out of the state in a statement on Monday termed as a "blatant lie" a top government lawyer's submission to the Supreme Court that Chief Minister N Biren Singh has been meeting all "Kuki MLAs" in an effort to bring peace. In a statement signed by the 10 Kuki-Zo MLAs including Paolienlal Haokip, who is a fierce critic of Biren Singh, the MLAs said they came to know that during a Supreme Court hearing on November 8, the Solicitor General of India submitted that the "Chief Minister is meeting all Kuki MLAs and [is] trying to bring the [Manipur] situation down to get peace."The MLAs said the top government lawyer's submission was "a blatant lie and tantamount to misleading the Supreme Court" as they have not met the Manipur Chief Minister in the last 18 months since ethnic violence broke out between the valleydominant Meitei community and the Kuki tribes dominant in some hill areas of Manipur.

We further clarify that we have never had any meeting with Chief Minister, Shri N Biren Singh since May 3, 2023, nor have any intention to meet him in future as he is the mastermind behind the violence and ethnic cleansing of our people from Imphal valley, which is continuing till today, the latest being the brutal killing and burning of Mrs Zosangkim Hmar on November 7, 2024," the 10 Kuki-Zo MLAs said in the statement.A woman from the Meitei community, Sapam Sophia Leima, who was working in her low-lying paddy field in Bishnupur district, was also shot dead by suspected Kuki militants from the nearby foothills on Saturday.

Some Manipur MLAs had visited Delhi in October to attend a meeting called by the Intelligence Bureau and monitored by Union Home Minister Amit Shah. Those among the 10 Kuki-Zo MLAs who attended the meeting had held separate sessions with Home Ministry officials, and not with the other MLAs.

Monday's statement from the 10 Kuki-Zo MLAs came after the Supreme Court on Friday directed a Kuki organisation to submit material to indicate authenticity of some leaked audio clips on the basis of which the organisation had filed a petition seeking a court-monitored special investigation team (SIT) probe into the alleged role of the Manipur Chief Minister in the ethnic violence. The tapes have been submitted to a Commission of Inquiry formed by the Home Ministry.

# **Even Ganga's Originating Point Is** Polluted, Green Tribunal Told

New Delhi: The National Green Tribunal has been informed that according to an Uttarakhand government's report on pollution in Ganga, even the "originating point" of the pious river is polluted by sewage treatment plant (STP) discharge. The submission was made during the proceedings about the prevention and control of pollution in Ganga in Uttarakhand. The tribunal had earlier sought a report from the state and others.

A bench of NGT Chairperson Justice Prakash Shrivastava noted the submissions of the advocate of one of the intervening applicants, who referring to the state's report, pointed out that a faecal coliform having the most probable number (MPN) of 540/100 ml was found in the sample collected from the 1 million litres per day (MLD) capacity sewage treatment plant (STP) at Gangotri.Faecal coliform (FC) levels show pollution from the microbes from the excreta of humans and animals. According to the Central Pollution Control Board (CPCB) water quality criteria, an MPN of less than 500/100 ml is desirable for



"organised outdoor bathing".

In the order passed on November 5, the NGT bench also comprising judicial member Justice Sudhir Agarwal and expert member A Senthil Vel noted, "She (the advocate) has submitted that even the originating point of the pious river Ganga is polluted by the STP discharge." The tribunal also noted CPCB's report about the compliance of norms and functionality of the STPs and said that out of 53 commissioned STPs, only 50 were functional and 48 were not complying with the norms, including FC levels, biochemical oxygen demand (BOD) removal efficiency range and utilisation capacity. Comparing the state's report with the CPCB report, it said, "We find that

disclosures which have been made by the state of Uttarakhand in his latest report are doubtful." "Thus, we require the Chief Secretary to duly look into the matter and ensure that a proper status report with due compliance is filed," it added. The tribunal also noted deficiencies in

the state's report about the STPs.It said, "Many of the STPs are either underutilised (Dehradun, Uttarkashi, Pauri, Chamoli) or receiving the excess quantity of sewage against their designed capacity (Haridwar, Tehri) and there is no mention of inundation of STPs during flooding/backflow." Regarding the status of drains in the states, the tribunal noted that 63 untapped drains were directly discharging untreated sewage into the Ganga and its tributaries."We also find that in towns of Kashipur, Bazpur and Kitchha of district Udham Singh Nagar, all the drains are untapped," it said. "The next report of the state needs to clarify action to be taken in a time-bound manner to ensure that no sewage carrying (BOD) load and FC joins Ganga or its tributaries," the tribunal

# Jadavpur University professor found dead with throat slit in Uttarakhand hotel

New Delhi: A 44-year-old professor from Jadavpur University in Kolkata was found dead with his throat slit at a hotel in Uttarakhand, where he had arrived with two friends a few days prior. The bloodied body of Mainak Pal, a professor in the Philosophy Department, was discovered on November 8, lying in the washroom with deep cuts on his neck and hands, according to a report by the news agency PTI, which cited police sources.

Pal, who is survived by his wife, daughter, and parents, was expected to return on November 8. When his family was unable to

reach him, they contacted the hotel authorities, who broke into his room and discovered his body.Based on the preliminary autopsy report, Uttarakhand



Police have not ruled out the possibility of suicide, as indicated in initial police Before joining Jadavpur University, Pal had communications, according to a university official. A detailed report is pending.In a condolence message, the Jadavpur

# How not to miss chances to create wealth

New Delhi. In the world of investments, your biggest enemy is the inflation. As you work hard to earn a meaningful living, you constantly strive for more because the prices of things keep rising. The official consumer price inflation data may say one thing, but inflation is the daily price for consumption. You know things to do to ensure that you are not letting that demon eat into your wealth.

You must ensure that equity and equity-linked assets are always in your portfolios. A primary reason is equity assets outperform all other asset classes convincingly to give you the highest return. If you invested R50,000 yearly since 1994, you put around R14.40 lakh. That money is worth R58.8 lakh today if you had invested in a fixed deposit and R70.2 lakh if you had invested in a public provident fund. If you had put the same money in gold, it would have been worth R1.2 crore. You would feel pleased about that. However, an investment in the Nifty 50 index would have propelled your R14.4 lakh into R2.8 crore.

At an average 6.3% inflation rate in those 30 years, you must adjust your savings by R47 lakh for inflation. With fixed deposits and PPFs, you are barely adding to your wealth. While gold has given you a decent return, it is probably not enough to pay for retired life. The data underscores the need to add that equity muscle to your portfolio.

However, financial markets are about future returns. Very few experts anywhere in the world argue against India's steady economic growth and consistent profit growth of Indian companies. Stock market returns typically follow the trend in profit growth.

In 1994, your awareness of equities was minimal, and your participation in equity markets was barely anything. Today, there is a surge in the demat accounts, trading accounts, and investor accounts for stock market trading. The National Stock Exchange recently celebrated ten crore investor accounts. That number will likely continue as it is a fraction of the potential.

# How Zomato's 'Food Rescue' will work, what's in it for delivery workers, restaurants

NEW DELHI. Zomato has launched a new feature called Food Rescue - that will allow customers to buy a cancelled order at a discounted rate, a fix the company says could work towards reducing food

Every month, around 4 lakh food orders on their way to the customers are cancelled on Zomato, as per the company. With the new feature, which is currently being scaled up, such cancelled orders will show up on the Zomato app of nearby users, who can purchase them at a lower value, in its original packaging, the company's CEO Deepinder Goyal said in a post on X on Sunday. While the company said it will not keep any proceeds from the sale except the required government taxes, the feature could boost the app's usage and user retention, as people are likely to be scouring through the app, waiting for a cancelled order to pop up. The company said its delivery workers will be compensated fully for the entire trip, from the initial pickup to the final drop-off at the new customer's location. How does the 'Food Rescue' feature work on Zomato?

Once the initial purchaser of a particular food item cancels the order, it will show up on the app of users within a three kilometre radius of the delivery worker carrying the order. The option to claim the order will only be available for a few minutes, which Zomato says is essential to ensure the freshness of the food. To prevent any abuse of the system, the original customer and those in their immediate vicinity will not receive the option to claim the order. Customers who prefer vegetarian food will not see non-veg

# Senior TCS employees receive lower variable pay



BENGALURU. Senior employees of TCS saw significant reductions in their quarterly variable pay for the Sept quarter, receiving 20-50% of the payout even though they fulfilled the mandatory office attendance criteria."HR has told us that they are not aware of why this has happened. For all other grades, the QVA depends on their unit's business performance. This is in line with our standard practice across quarters." Earlier this year, TCS implemented a policy linking variable pay to office attendance. TOI first reported this development.

# Rupee plunges to all-time low of 84.38 against US dollar

**New Delhi.** The rupee hit a record low against the US dollar on Monday, as concerns surrounding the recent victory of Donald Trump in the US elections put Asian currencies under pressure. Continuous outflows from Indian stocks further weakened the rupee, sparking a wave of caution among traders and investors alike. The rupee dropped to a new low of 84.3875 in early trading, surpassing its previous record set last Friday. It was trading at 84.37 by 9:40 a.m. Despite these pressures, traders noted that the Reserve Bank of India (RBI) intervened to prevent further losses.

# ASIAN CURRENCIES HIT BY STRONGER DOLLAR

Across Asia, most currencies saw declines between 0.1% and 0.4% on Monday. The US dollar index, which measures the dollar's value against a basket of major currencies, remained near its four-month high at 105, following Trump's win. This strength in the dollar has contributed to the rupee's recent struggles, pushing the currency into a difficult position in the



RBI INTERVENTION HELPS STABILISE THE RUPEE

The RBI has been actively intervening to curb the rupee's slide, according to traders. State-run banks were reportedly selling dollars on Monday, possibly on behalf of the RBI, to reduce the impact on the rupee. The central bank has regularly

stepped in over the past week, preventing the rupee from facing sharper declines. These interventions, however, have come at

a cost. India's foreign exchange reserves dropped for the fifth consecutive week, hitting a two-month low of \$682.13 billion as of 1 November. While this action helps in the short term, it puts pressure on the country's reserve levels,

which are meant to safeguard against global uncertainties.

FOREIGN INVESTORS PULL MONEY FROM INDIAN STOCKS

Foreign investors have been offloading Indian stocks at a notable pace, adding further pressure on the rupee. November alone has seen net outflows of approximately \$2.5 billion from Indian equities, following a significant outflow of \$11 billion in October. This capital flight has weakened the local currency and contributed to the underperformance of Indian markets. Major stock indices, the BSE Sensex and the Nifty 50, were down slightly on Monday, marking a fifth week of decline in the last six weeks. Market experts say the rupee could remain weak until there is a shift in the dollar index or a reduction in foreign institutional investor (FII) outflows.

Amit Pabari, Managing Director at CR Forex, told Reuters, "The rupee is likely to remain under pressure unless there is a softening in the dollar index or a slowdown in FII outflows.

# Singles' Day shopping festival loses its shine under China's lagging economy

HONG KONG. Merchants and consumers alike found the Singles' Day shopping festival Monday less shiny than in years past as ecommerce firms look abroad for growth. The annual event named by the numeric form of its Nov. 11 date was started by e-commerce platform Alibaba, which offered attractive discounts to entice shoppers to spend big. The extravaganza has since expanded to other platforms like JD.com and Pinduoduo in China as well as abroad. While Singles' Day was previously a one-day event, shopping platforms in China now kickstart the festival weeks ahead to drum up sales volume. The festival has also traditionally been regarded as a barometer of consumer sentiment.But amid China's lagging domestic economy, dragged down by a real estate crisis and deflationary pressures, consumers no longer go all out on purchases during the shopping extravaganza."I only spent a few hundred yuan on daily necessities," said Wang Haihua, who owns a fitness center in Beijing. Wang said that the prices offered on e-commerce platforms during Singles' Day are not necessarily cheaper than



usual."They're all tricks and we've seen through it over the years," she said. Zhang Jiewei, a 34-year-old who runs a barber shop in Xi'an city, echoed Wang's sentiments, saying that he no longer trust Singles' Day promotions as some merchant tend to raise the usual price of a product before offering a discount, giving consumers the illusion they are getting a deal."I used to buy a lot two or three years ago and I even purchased a mobile phone (during Singles' Day)," he said."I stopped doing that following the pandemic because of less income. I am not going to buy anything this year," Zhang added.Some experts say that Beijing's recent stimulus measures have had little impact to boost consumer confidence. "People are not interested in spending and are cutting back on big-ticket

items," said Shaun Rein, founder and managing director of China Market Research Group in Shanghai. "Since October 2022, the weak economy means that everything has been on discount year-round, 11.11 is not going to bring in more discounts that the month before."Rein said he expects low growth for the Singles' Day shopping festival as consumers tighten their spending in anticipation

of difficult economic times ahead.Categories such as sportswear and fitness, however, have been doing well as customers "trade down a Gucci bag for Lululemon sportswear," he said.Platforms like JD.com and Alibaba, which operates e-commerce platforms Taobao and Tmall, previously used to publish the value of transactions made during the festival, but have since stopped revealing the total figure. While yearly growth used to be in the double digits, estimates of recent figures have dwindled to low single-digit growth.Syntun, a data provider, estimated that last year's gross merchandising volume sales across major e-commerce platforms grew just 2% to 1.14 trillion yuan (\$156.40 billion), a far cry from doubledigit growth before COVID-19.

## Large caps are better than fairly valued: Bajaj Finserv AMC CEO

NEW DELHI. Bajaj Finserv AMC, a one-year-old mutual fund company, is trying to grow in what looks like an already crowded place - there are already 44 mutual funds in India with top 10 mutual funds in asset size accounting for 77% of the industry assets. CEO Ganesh Mohan in an interaction with TNIE explains the AMC's strategies to grow assets under management

What are the strategies to grow assets in the crowded AMC business?

The advantage we had was that we were setting the fund house from scratch, and our investment team started with a new investment philosophy. We put together all the three possible sources of alpha. And they are the information edge, which is better quality information than the crowd; a quantitative edge, which is better tools, models, analytical tools to assess the data; and behavioural edge, which is, how do you make the right decisions based on the same information and tools

Can you explain the behavioural edge that you claim you have?

Everybody has access to the same information, so it's a very thin edge. Even the quantitative edge, while today there is some room to differentiate, my own assessment is, in three to five years, this is going to become a pretty standard, the way technology is developing. AI, ML-way of new modelling will get commoditised very soon. Then the third edge becomes important to really generate alpha, which is your behavioural edge. Explain the uniqueness of your existing funds?

Every single active equity fund that we launch, we will look to bring something that is differentiated from the underlying benchmark. And there are two big weaknesses that a benchmark has -- One, benchmarks cannot look into the future. Companies come into the index after they have performed, and companies that are in the index but are underperforming continue to stay in the index till they exit. If you can have a strategy which looks at what are the future growth prospects of individual companies, and have a systematic way of doing that, then you can outperform the index. So, that was what our first fund - a flexicap fund -- was based on. The second fund - a large and mid-cap fund -- that we launched was on moat-based investing. Companies that have a strong defensive moat can protect their earnings very well and for a longer period of time, that justifies a higher valuation with higher multiples.

The third fund – a large-cap fund -- is one of the toughest ones to generate alpha, because you have only 100 companies. if you keep out, maybe 10-15 stocks for different reasons -- governance concerns, etc -- you're left with maybe 80-85

# Bitcoin rallies past \$81,000. What's driving the surge

New Delhi. Bitcoin soared to a new record high, crossing the \$81,000 mark on Monday. This rally is fuelled by the potential of a favourable regulatory environment following Donald Trump's recent election victory in the US. With this sharp rise, Bitcoin was trading at \$81,119.61 as of 11 AM, giving it a market cap of \$1.6 trillion.

Trump's pro-crypto stance during his campaign has been a major driver of this surge. He promised to make the US the "crypto capital of the planet" and proposed policies such as building a national Bitcoin reserve and appointing regulators to support the industry. These promises have sparked optimism among investors, with expectations that his administration could introduce cryptofriendly regulations.

BITCOIN HITS NEW RECORD HIGH Many in the market believe Trump's plans for Bitcoin and other digital assets have set the stage for the recent surge. His win has increased hopes for a friendly environment for digital assets, which many investors see as a shield against inflation and traditional market swings.

Sumit Gupta, co-founder of CoinDCX, sees Bitcoin's \$81,000 milestone and \$1.5 trillion market cap as a sign of renewed optimism."Bitcoin's recordbreaking surge is backed by strong

fundamentals and signals from the recent US election that suggest procrypto policies may be on the horizon. This shows Bitcoin's strength as a hedge against regular market ups and downs, he said.Gupta also highlighted how growing interest from large institutions and the introduction of Bitcoin ETFs (exchange-traded funds) have played a key role in Bitcoin's rise."With favourable regulatory support, we could see even more adoption from institutions, which may mark the end of the 'crypto winter' and strengthen the digital asset market further," he added. Gupta explained that the \$100,000 mark

is now the next big target for Bitcoin, which could be reached with continued institutional backing, expanding ETF markets, and supportive regulations.

"Bitcoin's unique qualities like its scarcity, decentralisation, and increasing acceptance make it an appealing choice in a diversified portfolio," he noted. WHAT'S DRIVING THE RALLY?

One of the significant factors behind Bitcoin's rising value is the growing interest from institutional investors. The approval of Bitcoin ETFs in the US earlier this year has made it easier for these institutions to invest in Bitcoin

legally, which has increased demand.

ETFs provide a regulated way for both individual and institutional investors to gain exposure to Bitcoin without needing to directly buy or manage the



cryptocurrency. Edul Patel, CEO of According to Patel, Bitcoin's support Mudrex, believes Bitcoin's all-time high is a result of several factors."Firstly, the approval of Bitcoin spot ETFs by the US SEC has been a game-changer, making it simpler for institutions to enter the market. Secondly, rate cuts in major regions, including the US, EU, and China, have led to higher cash flow, with more people willing to invest in alternatives like cryptocurrencies," he explained.

Patel also said that Trump's pro-Bitcoin stance has led more institutions to purchase Bitcoin in anticipation of friendlier regulations. He pointed out that nearly 30-40% of Americans already hold crypto, and a supportive stance from the government could lead to a significant boost in demand. "With

> this, the general mood among investors has improved greatly, he added. The current investor sentiment around Bitcoin remains high, with the BTC fear-greed index, which tracks market sentiment, now indicating "Extreme Greed." This positive sentiment has also resulted in an increase in long positions in Bitcoin futures, with an estimated \$2.8 billion in contracts betting on Bitcoin reaching \$90,000.

Hopefully he's going to be available, but everything we're going to get to know at the start of the series," Gambhir said at a press-conference before the team's departure to Australia.India's squad is departing for Australia in two separate batches, with the first group having left on November 10 and the second set to depart today. Gambhir has acknowledged the importance of contingency planning in case Rohit is unavailable, mentioning that both Abhimanyu Easwaran and KL Rahul are in the squad and ready to step up as opening options.

'Obviously there is [Abhimanyu] Easwaran and there is [KL [Rahul] there. So we will take a call closer to the first Test match if Rohit is not available," Gambhir said. "There are options there, it's not that there are no options there. There are quite a few options in the squad.
