village. Former MLA Dinakar Mane is contesting as the Sena (UBT) candidate from Ausa constituency. The Shiv Sena (UBT) posted a video on X, in which Thackeray is heard talking to the election staffers standing at the helipad, seeking to know their names and postings and also asking them to show their appointment letters. During his interaction, the Sena (UBT) chief is heard

asking them, "How many people have you searched so far?" On their response that he is the first one, he said, "Why am I always the first customer?" Referring to Prime Minister visit to Narendra Modi's Maharashtra during the day, he said, "Modi is coming today and I will send you to Solapur airport, which is shut (in view of the visit). Narendra Modi should also be subjected to this kind of checking."

Cong has double PhD in stalling projects: PM Modi

NAGPUR Nov 12: Prime Minister Narendra Modi on Tuesday launched a sharp attack on the Maha Vikas Aghadi (MVA) on Tuesday, labelling the opposition's coalition in Maharashtra as the "biggest players of corruption" and asserting that the people should vote for the Mahayukti candidates if they wanted to see rapid development in the state. Prime Minister Narendra Modi during a public meeting ahead of Maharashtra Assembly elections, at Chimur in Chandrapur district PM Modi said that if the Congress and its allies come to power in Maharashtra, the state's development projects would come to a grinding halt. "The Congress has a double PhD in stalling projects. If you want rapid development to continue, re-elect the Mahayuti candidates," PM Modi told an election meeting in Chimur in

eastern Vidarbha's Chandrapur district. PM Modi also accused the Congress of dividing people, saying it had been the mentality of the Congress's 'shahi parivar' (royal family) that it was born to rule the country. "This is the reason that after Independence, the Congress never allowed Dalits,

backward classes and Adivasis to progress." Modi Party (NCP), and is hoping to retain power in a highsaid. "It is a dangerous game of the Congress to

break your unity. If a tribal society gets divided into



castes, its identity and strength will be lost," Modi said at the rally ahead of voting on November 20. "If you do not remain united, then the Congress will snatch away your reservation," he added. The Bharatiya Janata Party leads the Mahayuti alliance, with the Shiv Sena and the Nationalist Congress stakes contest. The MVA, which comprises the Congress, the Shiv Sena (Uddhav Balasaheb

Thackeray) and the NCP (Sharadchandraji Pawar), is aiming to replicate its performance in the Lok Sabha elections, when it won 30 of the state's 48 seats. PM Modi described the BJP's "Sankalp Patra" poll manifesto as a commitment to Maharashtra's development. "The rapid development of Maharashtra is beyond the reach of the Aghadi. They have only mastered the art of hindering growth," he proclaimed. "Aghadi means the biggest player of corruption," Modi asserted, positioning the coalition as "masters in breaking growth." Maharashtra had seen unprecedented development in the past two-and-a-half years under the "Mahayuti" regime, despite obstacles from the Congress and the Aghadi, he said, describing Maharashtra as a favoured destination for foreign investment in the country. PM Modi

also raised the resolution in the Jammu and Kashmir assembly for the restoration of Article 370 of the Constitution, which used to grant special status to Jammu & Kashmir before it was scrapped in 2019. "Just a few weeks ago, we saw what happened in Jammu and Kashmir.

New CJI Sanjiv Khanna outlines vision to make courts approachable

New Delhi, Nov 12: New Chief Justice of India Sanjiv Khanna laid out his vision to make courts "approachable and userfriendly" and termed the judiciary an integral, yet distinct and independent, part of the governance, news agency ANI reported. The Constitution trusts upon us the role of constitutional guardian, protector of fundamental rights, and responsibility to fulfil the important task of being a service provider of justice," said the chief justice. Justice Sanjiv Khanna identified the need to tackle the case backlog and simplify complex legal procedures. He also emphasised that litigation needs to be affordable and accessible. The top judge

said he also aims to reduce the trial dura- criminal case management. "Justice tion by adopting a systemic approach and aligning the justice delivery mechanism



so that the legal process is "not gruelling for the citizens." The CJI said his approach will be receptive and responsive while also being self-evaluative. He also emphasised the need to reform

delivery framework in terms of providing equal treatment necessitates fair opportunity to succeed to all, regardless of status, wealth or power, and a just and unbiased adjudication. These mark our core principles," Justice Khanna said. "The responsibility entrusted upon us affirms our commitment as protectors of citizens' rights and as dispute resolvers. It is our constitutional duty to ensure easy access to justice to all citizens of our great nation," added the CJI. Justice Sanjiv Khanna (64) took oath as the 51st Chief Justice of India on Monday, succeeding Justice DY Chandrachud. Expected to retire on May 13, 2025, he will have a tenure of six-months. Justice Khanna has been part of several landmark judgments, including upholding the sanctity of Electronic Voting Machines (EVMs), declaring Electoral Bonds scheme unconstitutional. He was also part of bench that upheld the abrogation of Article 370 in Jammu and Kashmir and granted interim bail to former Delhi chief minister Arvind



ED raids 17 locations in Jharkhand. West Bengal over illegal Bangladeshi infiltration ST Correspondent

New Delhi, Nov 12: In a money laundering probe connected to illegal Bangladeshi infiltration, the Enforcement Directorate searched poll-bound Jharkhand on Tuesday The Enforcement Directorate on Tuesday raided multiple locations in poll-bound Jharkhand, apart from West Bengal, in a money laundering investigation linked to alleged illegal infiltration of Bangladeshi nationals. A total of 17 places are raided covered in the two neighbouring states by the Jharkhand office of the federal probe agency. The Jharkhand assembly elections are scheduled to begin on Wednesday, November 13, with the first round of voting. The following phase will take place on November 20. By elections for six Bengal assembly



seats are also set for tomorrow. In September, the agency filed a case under the Prevention of Money Laundering Act (PMLA) to investigate the infiltration and trafficking of certain Bangladeshi women into Jharkhand, which resulted in the production of claimed slush money. The case was filed on the complaint of a lady who reportedly sneaked into the nation from across the India-Bangladesh border with the help of touts to find work, had allegedly listed about five to six women as culprits who were apprehended during a raid at a local resort. The lady who submitted the complaint escaped a comparable institution and arrived at the police station. One of these ladies was also found to be in possession of a "fake' Aadhaar card. Prime Minister Narendra Modi and other BJP leaders have accused the state government of aiding such infiltration leading to the altering of the demographic landscape of the tribal-dominated areas of Santhal Pargana and Kolhan regions during the recent poll campaign. A High Court decision to form an impartial panel to look into the flood of Bangladeshi immigrants was met with criticism from Modi for the Jharkhand government's refusal to accept the infiltration problem. The first phase of the Assembly polls is slated for 43 constituencies on Wednesday, while the second for 38 seats will be held on November 20.

Govt to reconstitute development boards under the GTA

Kolkata, Nov 12: West Bengal chief minister Mamata Banerjee said on Tuesday that the state government will reconstitute the 16 development boards under the Gorkhaland Territorial Administration (GTA) within the next one-and-half-month and set up a cell to monitor their functions. "The boards will be reconstituted after seeking suggestions from various quarters within one-and-half-month. A monitoring cell to look into their functioning headed by Anit Thapa will be set up," she told reporters. Banerjee, who is in on a fiveday visit to north Bengal districts, held a meeting with GTA chief executive Anit Thapa, chairpersons of the various development boards and senior government officials. The Gorkha community boards were formed by the state government after the TMC came to power in 2011. The move, to form development boards, was construed by some as an attempt to weaken the functioning of the semi-autonomous and elected GTA, then headed by Bimal Gurung. The GTA came into existence in 2012. Gopal Lama, the TMC Lok Sabha candidate in the last Lok Sabha election from Darjeeling, has been appointed chairman of the Tamang Development Board replacing Sanjay Moktan. Ex-IAS officer appointed to probe KKRDB irregularities

KALABURAGI: The Karnataka government has appointed retired IAS officer Sudhir Kumar to relook at the recommendations made by former additional chief secretary EV Ramana Reddy on alleged irregularities in the Kalyana Karnataka Region Development Board and Kalyana Karnataka Manava Sampanmula, Krushi Haagu Samskrutika Sangha (Human Resource, Agriculture and Cultural Association). Sudhir Kumar will conduct a further inquiry and investigate alleged irregularities. The government issued the order on Kumar's appointment on Monday. He has to submit the report within six months.

Kumar has been tasked to look into alleged irregularities in spending Rs 300 crore allocated to KKRDB between 2020-21 and 2022-23 and released to Kalyana Karnataka Manava Sampanmula, Krushi Haagu Samskrutika Sangha. Kumar should also probe allegations of misappropriation in the purchase of medicines and equipment by KKRDB during Covid.He should inquire into sanction of Rs 50,000 to private school teachers, who died during Covid, expenditure of Rs 326.40 crore to care of local cows, though it was not under KKRDB's purview, misuse of Rs 310.59 crore for planting one crore saplings in six districts of the region and spending Rs 50 lakh in addition to the sanctioned amount to celebrate Kalyana Karnataka Vimochana

Dinacharane, violating the transparency Act. Ramana Reddy completed the probe and submitted the report to the government a few months ago. As no action was taken for long, Rural Development and Panchayat Raj Minister Priyank Kharge put out a note on this issue. Based on that, the government appointed Sudhir Kumar as the inquiry officer afresh.

Odisha government warns of strict action against employees over lobbying for posts

BHUBANESWAR: Expressing serious concern over lobbying and using extraneous pressure for transfer and posting by employees, the state government on Monday warned that such practice will no longer be tolerated and stern action will be taken against those indulging in it.Official sources said the government had to issue such a warning as it was found that some employees were exerting extraneous pressure for transfer and posting. In a letter to secretary of all departments and district collectors, chief secretary Manoj Ahuja said it has come to the notice of the government that some employees are attempting to influence their transfer and posting to different posts by exerting extraneous influence. This is a clear cut violation of Rule 23 of the Odisha Government Servants' Conduct Rules, 1959. Any attempt to violate the rules will be viewed seriously and attract disciplinary action, he said. The Rule 23 states, "No government servant shall bring or attempt to bring any influence whether official or nonofficial to bear upon any authority to further his interests in respect of matters pertaining to his appointment under government, promotion, pay and other service

Odisha government to compensate 16,500 fishermen affected by fishing ban

KENDRAPARA: The Fisheries and Animal Resources Development department will provide a compensation of Rs 15,000 to around 16,500 fishermen affected by the fishing ban imposed at Gahirmatha marine sanctuary in Kendrapara district, Rushikulya river mouth in Ganjam and Devi beach in Puri for arrival and mass nesting of Olive Ridley sea turtles. Deputy director (marine) of the department Rabi Narayan Patnaik said, in 2016, the department for the first time had provided a yearly compensation of Rs 5,000 to 2,000 fishermen of Kendrapara as they are



barred from fishing in Gahirmatha marine sanctuary. "Last year, we provided compensation of Rs 15, 000 to 15,000 fishermen," he said.President of Odisha Traditional Fish Workers' Union Prasanna Behera said at least 50,000 fishermen of Kendrapara and Jagatsinghpur are affected due to the ban which was imposed from November 1 and will continue till May 31 next year."We have been demanding an alternative source of livelihood during the ban and adequate compensation for the losses incurred by the fishermen.

There exists a clause in the Central Empowerment Committee's directives, which states there should be an alternate source of income before a fishing ban is imposed on fishermen. However, the officials are not providing any alternative livelihood options to us during the sevenmonth-long fishing ban. The meagre amount of Rs 15,000 compensation for only 16,500 fishermen will not be of much help," he said.

Kerala tourism charts new course

KOCHI/IDUKKI : A new chapter opened in the history of the state and its tourism sector when a 17-seater seaplane took off from the Bolgatty Palace Waterdrome in Kochi on Monday. With the successful completion of the trial flight of the seaplane 'de Havilland Canada-6 Twin Otter' to the Mattupetty reservoir in Munnar, doors have been thrown open for tourists to venture out to hitherto unexplored destinations, in comfort.The development comes at a time when those in tourism industry have been repeatedly pointing out the necessity of improving connectivity and thereby reducing travel time.

The ambitious project was first envisaged during the 2011-16 Oommen Chandy government. However, it was ditched following serious objections by fisherfolk community who were against using lakes and water bodies to set up waterdromes. This time, though, with Chief Minister Pinarayi Vijayan taking on the onus, the project has gained wings. The trial flight was flagged off by Tourism Minister P A Mohamed Riyas. The plane took less than an hour to reach Mattupetty. "The project will work towards boosting the state's tourism sector," Rivas said. He said steps will be taken to ensure the



project is people-friendly so that all can enjoy the facility. With the government having decided to turn it into a water reservoir-plane project, the vision is to begin services initially from large dam sites like Banasura Sagar in Wayanad and Mattupetty in Idukki."However, other dams located in strategic destinations can also be used for seaplane services connecting all destinations with the four international airports in the state," Riyas said.Industries Minister P Rajeeve said tourism has been a significant contributor in Kerala's rapid progress in industrial development. "Kerala has the largest number of five-star hotels in India,

and four world-class hotel chain projects will soon start in Kochi alone," Rajeeve said. A tourism department official said the seaplane service is provided under UDAN, the ministry of civil aviation (MoCA)'s regional connectivity scheme (RCS). "There are variations to the seaplane, based on seating capacity. The seaplane that arrived for the trial flight

was a 17-seater, unlike the nine-seater

announced earlier," the official said. The

seaplane has 9, 15, 20 and 30-seater varieties too, the official said."A Switzerland-based private company and SpiceJet jointly run the services involving de Havilland Canada seaplanes. While SpiceJet operates the services, Canadian aircraft manufacturer De Havilland offers engineering expertise and assists with technical and logistical challenges," he said. At the same time, no decision has been taken on either the date of launch or service schedule. "A committee with representatives from the tourism department, Inland Waterways Authority and other associated departments will be formed to arrive at an action plan. Once the plan is formulated, the government will come up with a policy framework. That will happen in the coming months," the official said. Permanent landing spots for the seaplane too have to be

decided, the official pointed out. "The

lakes, like Punnamada. All these will be decided by the committee," he said. As for the service provider, the official said. "This was just a trial flight.

The department will be calling for expressions of interest from other players in the sector before deciding on the operator," he said.Once the services become operational and multiple flights are chartered, CIAL ca serve as the control room, he added.

Heavy rain likely in Chennai and delta districts till November 15

CHENNAI: The Regional Meteorological Centre (RMC) on Monday said that heavy rain may lash Chennai, its surrounding districts and parts of delta districts till Friday. According to the RMC, under the influence of upper air cyclonic circulation over southwest Bay of Bengal, a low-pressure area has formed over the region on Monday afternoon. It is likely to move slowly westwards towards Tamil Nadu/Sri Lanka coasts. As per the forecast, heavy rain is possible in isolated places

in Chennai, Tiruvallur, Kancheepuram, Chengalpattu, Cuddalore, Mayiladuthurai, Nagapattinam, Thanjavur, Tiruvarur, Villupuram districts, and Puducherry and Karaikal regions till November 15.This apart, heavy rains are expected in isolated places in Ranipet, Madurai, Virudhunagar, Sivaganga and Thoothukudi districts from Wednesday to Friday. A similar forecast



has been issued for Tiruvannamalai, Kallakurichi, Theni, Tenkasi, Tirunelveli, Kanniyakumari, and Dindiul districts for Thursday and Friday.

Pudukkottai, Ramanathapuram and In addition, The Nilgiris, Coimbatore, and Tirupur districts are likely to receive heavy rain on Thursday, while Vellore is expected to experience heavy rainfall on Friday. In areas for which heavy rainfall is predicted, a yellow alert has been issued and the rainfall is expected to be around 7

to 11 cm.In a separate forecast for Chennai, the RMC said that the condition is likely to be partly cloudy. Moderate to heavy rain with thunderstorms and lightning is likely to occur in some areas. Maximum temperature is likely to be 32-33°C and minimum temperature is likely to be around 25°C, it added.Meanwhile, independent weather bloggers said that northern TN districts and delta districts can expect to get good rainfall this week. They added that heaviest spell might be on Tuesday and it could rain

up to 20 cm in four days."A low-pressure area is expected to form in the next 24 hours gradually from Monday night and rains are expected to return over north Tamil Nadu and south Andhra Pradesh, including Chennai. 18 years on, parents get murder victim's remains

KASARGOD: A murder most foul can leave a haunting legacy. The possessions of loved ones who have departed can hold a value that raises existential questions. And, the remains of a long-lost victim of foul play can amount to more than just closure.On November 11, the skeletal remains of Safiya were handed over to her parents on the direction of the District Principal Sessions Court. These included a portion of Safiya's skull, which was used for the superimposition process to identify her, and the mandible, which had been kept as evidence. Judge Sanu S Panicker ordered the release on a petition filed by the then public prosecutor C Shukur.The daughter of Moidu and Ayesha, of Aiyangeri, in Karnataka's Kodagu district, Safiya was a teenager when her life was brutally cut short, leaving behind a tale of exploitation and injustice. And it was Ayesha's determination that brought the culprits to light. The tragic chain of events was set in motion in 2006 when 13-year-old Safiya



was hired by civil contractor K C Hamza and his wife Maimoona to work as a maid at their home in Kasaragod. Following their subsequent relocation to Goa, the family took Safiya along, a decision that would ultimately seal her fate.A few months later, Hamza contacted Moidu with news that Safiya would be brought back to Kasaragod. When Moidu reached Kasaragod to receive his daughter with her favourite Indian gooseberries he was told that she is missing. The girl's father and Hamza proceeded to file a complaint with Adhur police.

According to Shukur, "Moidu had to raise money from neighbours to travel to Kasaragod. The police investigated the case for more than a year. During that time, an action committee was formed and Safiya's mother staged a 90-day protest in Kasaragod town, demanding justice for her daughter. Crime branch took over the case after one-and-a-half years and solved the mystery."The investigation unravelled a web of lies, as Hamza's claim of Safiya's disappearance was exposed as a desperate attempt to cover up the gruesome truth. She had been brutally murdered, dismembered, and buried near a dam site in Goa after suffering severe burns. Hamza was arrested in 2008"I am eternally grateful to the countless individuals who stood by us and played a crucial role in our quest for justice ," Moidu said.In July 2015, Hamza was sentenced to death by the Kasaragod Sessions Court. However, the sentence was commuted to life imprisonment by the Kerala High Court in 2019.

10 per cent dip in distance education enrolment, Madras University's cash cow takes a hit

CHENNAI: The Institute of Distance Education (IDE) of the University of Madras, one of the major sources of revenue for the cash-strapped state varsity, may register a 10% drop in enrolment this year as the number of admissions for the academic year 2024-25 - which closes on November 15 - stands at 25,421 compared to 28,209 in 2023-24. In 2022-23, the IDE had admitted 30,157 students, up from 29,811 in 2021-22. Prolonged delay in appointing a vicechancellor to the university and lack of new courses seem to have affected the popularity of the IDE, sources said."We are expecting the figure to go up marginally by the time the deadline closes, but it will definitely be lesser compared to last year," a university official said.

Given that the IDE had generated over Rs 100 crore in course and examination fees last year, officials acknowledge the university's heavy dependence on IDE's revenue. In order to improve the income, the IDE has to attract more students by offering new, skill-oriented and emergent courses, however, the absence of a vice-chancellor has thrown a wrench into the works. As is, the IDE is struggling to run eve the existing courses, university officials added."It is difficult to start new courses without a V-C. The convener committee only manages the day-today affairs, they do not get into the more complex issues," said a faculty member.

'More courses soon after V-C appointment'

"We received NAAC A++ grade accreditation and Category I status recently. It is the right time to cash in on the opportunity as we could start new courses without UGC approval. Unfortunately, we are unable to utilise it," said another faculty

Another factor attributed to the downward trend in IDE's enrolment figures is that other state universities are strengthening their distance education wings. "Since then other state universities have bolstered their distance education departments. Earlier, we received students from across the state through our 64 learner support centres in various districts, but now most them are only from in and around Chennai," said an IDE official.

S Aravindhan, director of IDE, told, "We are taking steps to increase enrolment. We have selected a few courses and they will be introduced soon after the appointment of a vice-

Only one teacher in 6,158 government schools in Karnataka

BENGALURU: About 6,158 government schools in the state have just one teacher each, responsible for 1.38 lakh students, while 530 schools, with zero enrollment -- no students at all -have 358 teachers. This shows a serious flaw in the system. While some schools have only a few teachers (one in many cases), others have excess staff despite having zero enrolment. The department, however, has said that teachers from zero-enrollment schools have been transferred to wherever there is requirement. The total number of singleteacher schools in the state decreased by 202, from 6,360 in 2023-24 to 6,158 in 2024-25. However, the enrollment also dropped by 33,794, which experts link to a rise in dropout rates.Lack of subject teachers is driving students away. As in many cases, teachers are assigned only to teach Kannada or social studies and not core subjects such as mathematics and science or even English. At the same time, to maintain the "100% pass rate," schools often "push academically weaker students out", according to experts. Child rights activist and executive director of Child Rights Trust Vasudev Sharma said teachers

social studies. "Parents, understandably, want their children to attend schools where maths and science are taught. As a result, many opt for aided or private schools," he said. Moreover, by the time a student reaches the upper primary level, schools deliberately push out those who are not academically strong to maintain "the 100% pass rate" in Class 10, a figure that, he argued, does not reflect real education standards, but hides the system's failure.

He said no one questins why dropout rates surge between Classes 7 and 8, and Class

in these schools only teach Kannada or 'Karnataka to hire 5k teachers across



state'

"There is no record of where these children go -- whether they join other schools or not. Some of these children are forced to work even as the government claims there is no child labour, while others become victims of child marriages. The departments concerned, however, insist that no child marriage takes place," Sharma said.Moreover, teachers often use their influence to get transferred to schools in cities or towns, the experts said. In many cases, even teachers do not report for work in schools in remote areas, leaving students without a teacher.

10 yrs lost, bypass project to unclog RNE gains steam now

Ghaziabad. Ten years in the works, the Ghaziabad Development Authority (GDA) has decided to relaunch a bypass road project to unclog Rajnagar Extension, one of the city's fastest growing townships. The 6km stretch will connect Rajnagar with Hapur Road,

providing relief to thousands of commuters who are stranded in snarls daily during rush hours. Although conceived a decade ago, the bypass road

project failed to take off because GDA could not acquire the 900sqm required for it for various reasons. The development authority has now resumed the process of acquisition.

"Given the daily snarls tat commuters have to face, GDA decided to revisit the project and initiate land acquisition again. The stretch that will eventually be built will be 45m wide and will alleviate snarls by allowing commuters to actually skirt the Rajnagar Extension roundabout towards Hapur Road," a GDA official said. The bypass can also be used by residents of the proposed Harnandipuram township when it comes up. The need for a bypass was felt years ago as booming real estate made Rajnagar Extension its home and thousands of people began shifting to new societies that came up there.

Developed in the early 2000s, Rajnagar Extension is now home to over 1 lakh residents. But as population grew, so did traffic. Today, the area is one of the city's notorious choke points.Rajnagar Extension is connected with Loni, Mohan Nagar, Indirapuram, Delhi, and Noida. The Hindon Elevated Road offers the township a direct connectivity with trans-Hindon areas, Noida, and Delhi, GDA had, in 2018, designed a rotary to cater to traffic coming from three directions Rajnagar Extension Road, Karhera Road, and a stretch leading to GT Road. Among measures taken to decongest the Rajnagar Extension roundabout, UP Bridge Corporation constructed a flyover in 2019, providing respite to commuters. But it was short-lived.

3 more substations to boost power infra in Vasundhara

Ghaziabad. Vasundhara is set to receive three new substations of 33/11 kV capacity each. These substations will be built in Sectors 2, 3, and 7 by Vasundhara Awas Vikas Yojna (VAVY). The Sector 7 substation is expected to be delivered by Dec this year, while the other two will be ready by mid-2025, officials said.In addition to these three, a 220 kV substation which is currently under construction in the area, will be ready by Oct 2025. The substation, which TOI previously reported on in July, is being built under the public-private partnership (PPP) model by the Jewar Transmission Limited (JTL). Together, the four new substations will help alleviate issues related to overloading, distribution networks, and power demands of over 20,000 consumers in Vasundhara and nearby Vaishali and Sahibabad. Currently, Vasundhara's power demand is being met by 400 kV substations in Indirapuram and Muradnagar.

'With the increasing electricity demand, the discom has planned to build a 33/11 kV substation in nearly every sector of Vasundhara. Under this, three new substations of 33/11 kV are being built in Sectors 2, 3, and 7," Amit Saxena, executive engineer, Ghaziabad power department, told TOI. According to Saxena, a proposal for the land and construction of the three 33/11 kV substations has been accepted by VAVY. Land has been designated for the same in sectors 2, 3, and 7. A fourth 33/11 kV substation is proposed to come up in Sector 5, for which approval is awaited. Each substation is being built at a cost of around Rs 8 crore to 10 crore.

Operation 'Eagle': How Delhi Police swooped down on gunrunners

NEW DELHI. Arjun cleaned rooms and swept floors in a five-star hotel. But beyond this mundane existence and unbeknownst to his employers, the 25year-old also supplied illegal arms to criminals. Ajay, 23, too had a secret life. He worked at a hair-cutting salon but his real business was selling guns. The two men are among the 18 individuals arrested by Delhi Police's crime branch in a one-of-its-kind operation against gunrunners.Other accused include some labourers, a painter, salesman, security guard and a farmer, even a BA student, all driven by the hope of easy money.

According to special commissioner Devesh Shrivastava, the arrested men, many of whom have prior criminal records, were involved in a range of offences, including murder, attempted murder, dacoity, robbery, extortion, burglary, riot, theft and violations of the Arms Act. Police recovered a substantial cache of illegal firearms and ammunition, including four semi-automatic pistols, eight country-made pistols, one rifle, 33 live cartridges and a stolen car. "The arrests mark a significant disruption to the illegal arms supply chain in Delhi and NCR," said Shrivastava.The operation, codenamed Eagle and conducted under additional CP Sanjay Bhatia and DCP (Crime) Bisham Singh, targeted the gunrunners operating in Delhi-

164 condos surveyed, 90% have defunct water harvesting pits

Noida. The groundwater department conducted inspections of rainwater harvesting systems within residential societies across Noida and Greater Noida last week. The survey revealed that 140 of the 164 societies had nonfunctioning rainwater harvesting systems, while 10 societies lacked any such facilities. A mere 14 societies were found to have operational rainwater harvesting systems. Officials noted that the 140 societies

with non-operational systems had rainwater harvesting pits that were filled with stagnant water and accumulated debris, which was contributing to groundwater contamination. According to hydrologist Ankita Rai, from the harvesting systems are compulsory installations in all residential complexes and government structures. "Whilst authorities verify these systems prior to granting OC and CC certificates, subsequent maintenance often lapses after certification," she said.

Iran on Monday said the "world is waiting" for Donald Trump's incoming US government to stop Israel's wars with Hamas and Hezbollah, as it condemned a wave of Israeli assassinations as "organised terrorism.""The American government is the main supporter of the actions of the Zionist regime (Israel)," First Vice President Mohammad Reza Aref told a joint Arab League and Organisation of Islamic Cooperation summit in Riyadh."The world is waiting for the promise of the new government of this country to immediately stop the war against the innocent people of Gaza and Lebanon."Since Hamas's October 7, 2023, attacks triggered the war, Israel has killed a number of senior opponents, including Hamas chief Yahya Sinwar and Hassan Nasrallah, Hezbollah's long-time leader. Israel is also widely believed to have carried out the killing of former Hamas leader Ismail Haniyeh in the Iranian capital Tehran. How Singles' Day in China evolved into one of the world's largest shopping event

World While the Western world is gearing up for Black Friday and Cyber Monday, China has already celebrated its biggest shopping extravaganza—Singles Day. Often overshadowing other global shopping events, Singles Day has grown from a niche celebration to a retail phenomenon, surpassing the likes of Prime Day and Black Friday.Originating as a light-hearted holiday to honour singlehood, it has evolved into a massive online shopping festival. This year, the event began on October 14 and culminated on November 11, marking the longest Singles Day sales period ever.

The concept of Singles Day traces back to 1993 when it was first celebrated at China's Nanjing University, initially dubbed "Bachelor's Day."

On this day, single individuals would treat themselves to gifts, often accompanied by social gatherings.
What started as a modest celebration has transformed into a retail juggernaut, attracting millions of shoppers eager to grab deals. The event's popularity soared after Alibaba, China's e-commerce giant, adopted it in 2009, turning November 11, or "11.11," into a day synonymous with discounts and deals. Over the years, other major platforms like JD.com and Pinduoduo joined the bandwagon, transforming Singles Day into a country-wide shopping spree.

Last year's Singles Day saw Chinese consumers spending a staggering 1.14 trillion yuan (\$156.4 billion), according to Syntun data, reported by the news agency Reuters. This figure dwarfs the \$38 billion spent during the US's Cyber Week, which includes Black Friday and Cyber Monday.

However, despite the impressive numbers, growth has been slowing down. The sales increase last year was just 2 per cent, the slowest in its history, reflecting changing consumer behaviours and market saturation. Analysts suggest that this year's sales could reach an estimated 1.2 trillion yuan (\$167 billion), reflecting a potential 15 per cent rise. However, experts remain cautious, noting that the increase may come with caveats as many shoppers bulk-buy to hit discount thresholds, often leading to returns, which can erode profits. In recent years, Singles Day has seen a shift in consumer spending patterns. While previous years featured splurges on luxury goods and big-ticket items, last year saw a trend towards necessities like tissues, handwash, and pet food as shoppers turned frugal. This shift could be attributed to economic uncertainty and the lingering effects of China's stringent Covid-19 measures.

Trump names former Rep. Lee Zeldin to lead EPA, adviser Stephen Miller to be deputy chief of policy

WASHINGTON. President-elect Donald Trump on Monday named former New York congressman Lee Zeldin to lead the Environmental Protection Agency as he continues to build out his future administration with loyal supporters.

Zeldin, a Republican who mounted a failed bid for governor of New York in 2022, will "ensure fair and swift deregulatory decisions that will be enacted in a way to unleash the power of American businesses," Trump said in a statement. Zeldin also will maintain "the highest environmental standards, including the cleanest air and water on the planet," Trump added.Zeldin, who left Congress in January 2023, was a surprising pick for the role. His public appearances, both in his own campaigns and on behalf of Trump, often involved him discussing issues such as the military, national security, antisemitism, U.S.-Israel relations, immigration, and crime. He was among the Republicans in Congress who voted against certifying the 2020 election results. While in Congress, he did not serve on committees with oversight of

environmental policy and had a lifetime score of 14% from the League of Conservation Voters during his eight years in Congress.In the 2022 governor's race, Zeldin vowed to reverse a fracking ban imposed by Democrats.In an interview Monday on Fox News Channel, Zeldin, 44, said that he will seek to ensure that the United States can "pursue energy dominance ... bring back American jobs to the auto industry and so much more."He's excited to implement Trump's economic agenda, Zeldin said, adding, "I think the American people are so hungry for it. It's one of the big reasons why they're sending him back to the White House."In 2016 Zeldin pushed to change the designation of about 150 square miles of federal waters in Long Island Sound to state jurisdiction for New York and Rhode Island. He wanted to open the area to striped bass fishing. Zeldin said at the time that he wanted to restore local control and common sense to fishery management. He later pushed to allow striped bass fishing in an amendment to a federal spending bill. Environmental groups criticized the amendment, which

Soaring inflation helped lead Trump to victory — here's why some of his policies might drive prices higher again

World President-elect Donald Trump owes his political comeback in large part to voters' concerns over the soaring price of everything from gasoline and housing to coffee and bagels. Inflation has since come down to levels close to normal thanks in large part to a steep rise in interest rates. But in an ironic twist, some of Trump's own policies – which he heavily promoted on the campaign trail – could send inflation soaring once more if enacted. Specifically, economists caution that his proposed policies on tariffs, immigration and taxes may do more to exacerbate inflation than curb it. In my introductory economics classes, I teach my students about the unintended consequences of policies and how they can sometimes be counterintuitive. Common-sense economics often falls short, and this is evident in several policies proposed by Trump, where the expected outcomes may not align with their actual impacts.Exit poll data reveals that Americans felt the sting of rising prices in recent years, as inflationadjusted wages strained household budgets.

Even as the Federal Reserve has managed to bring inflation much closer to its 2% target, many Americans continue to describe prices as "too high," an echo of the past several years' cost increases that persistently outpaced wage growth. When inflation outpaces wage growth, the purchasing power of each dollar erodes, leaving workers struggling to afford the same goods and services. This erosion has been felt particularly hard in recent years, but it's part of a longterm trend of sluggish wages. Inflation-adjusted wages have been largely stagnant for decades, with certain metrics revealing a dismal reality. For example, the federal minimum wage, created in 1938 and set at US\$7.25 since 2009, is now worth less than half of what it was over 50 years ago. Back in the late-1960s, the minimum wage was worth the equivalent of \$14.50 per hour in today's money after adjusting for inflation.Median weekly earnings paint a similarly bleak picture. Today's median weekly real earnings for men, adjusted for inflation, are below their level from the mid-1970s. This stagnation has been a critical factor in voters' recent concerns, with inflationary pressures intensifying the burden on lowand middle-income households. Trump's campaign promised swift action to end what he called the "inflation nightmare." But the following three Trump's economic policies may have the opposite effect of what his supporters hope for.1. Tariffs: Americans usually pay the billProtectionist policies, such as tariffs on imported goods, tend to increase costs for consumers by limiting supply and raising prices.In Trump's first term, tariffs on Chinese imports caused domestic prices to increase across various sectors, from consumer electronics to agricultural products. His renewed interest in protectionism could exacerbate inflation by restricting competition and limiting the availability.

US president-elect Trump ramps up transition moves with key appointments to his administration

WASHINGTON. US President-elect Donald Trump has moved quickly to staff up his incoming administration, naming loyalists to several key posts within days of his election victory and signalling his desire to have some seated without a Senate confirmation process. The staffing picks are the subject of intense speculation and scrutiny, with Trump vowing that his second administration will oversee a radical shake-up of the federal government. The 78-year-old Republican tycoon said Sunday he would tap hardline immigration official Tom Homan as the country's "border czar," while US media reported the nod for UN ambassador as going to New York congresswoman Elise Stefanik, a vocal Trump ally. Stephen Miller, another fierce critic of illegal immigration who served in Trump's first administration, has been tapped for deputy chief of staff. The picks signal movement on a number of Trump's key campaign messages, with Homan's hardline immigration stance making him a loyal hand in carrying out the incoming president's deportation promises, while Stefanik, who has voiced strong support for Israel, will

grapples with the ongoing wars in Gaza and Lebanon.Stefanik's nomination would need approval by the Senate, but Trump is hoping to bypass Congress by making appointments while the chamber is in recess. He has turned the issue into a loyalty test, insisting that any Republican seeking to be the leader of the Senate "must agree" to recess appointments. Trump asks Mike Waltz, China hawk, to be his national security adviser

WASHINGTON. President-elect Donald Trump has asked U.S. Rep. Michael Waltz, a retired Army National Guard officer and war veteran, to be his national security adviser, a person familiar with the matter said Monday. The nod came despite simmering concerns on Capitol Hill about Trump tapping members of the House, where the final tally is still uncertain and there are worries about pulling any GOP members from the chamber because that would force a new election to fill the empty seat. The person spoke on the condition of anonymity to discuss the matter before Trump made a formal announcement.

The move would put Waltz at the forefront of a litany of national security crises ranging from the ongoing effort to provide weapons to Ukraine and escalating worries about the growing alliance between Russia and North Korea to the persistent attacks in the Middle East by Iran proxies and the push for a cease-fire between Israel and Hamas and Hezbollah.Waltz, a three-term GOP congressman from east-central Florida, was the first Green Beret elected to

the U.S. House and easily won reelection last week. He has been chairman of the House Armed Services Subcommittee on readiness and a member of the House Foreign Affairs Committee and the Permanent Select Committee on Intelligence.Waltz is an ardent Trump advocate who backed efforts to overturn the 2020 election. He is considered hawkish on China, and called for a U.S. boycott of the 2022 Winter Olympics in Beijing due to its involvement in the origin of COVID-19 and its ongoing mistreatment of the minority Muslim Uighur population.

He has been a sharp critic of the chaotic U.S. withdrawal from Afghanistan and has called on the U.S. to hold accountable those who bear responsibility for the deaths of the 13 U.S. service members at Abbey Gate and for "thousands of Americans and allies behind enemy lines."He has also repeated Trump's frequent complaints about a socalled "woke" military that the former president has derided as soft and too



focused on diversity and equity programs.In a statement last year, Waltz said that as head of the readiness subcommittee: "I am ready to get to work to better equip our military and turn our focus away from woke priorities and back to winning wars. Our national security depends on it." A graduate of Virginia Military Institute, Waltz was a Green Beret. He served in the active-duty Army for four years before moving to the Florida Guard. While in the Guard he did multiple combat

tours in Afghanistan, the Middle East and Africa and was awarded four Bronze Stars, including two with valor. He also worked in the Pentagon as a policy adviser when Donald Rumsfeld and Robert Gates were defense chiefs."President-Elect Trump will begin making decisions on who will serve in his second Administration soon," said Karoline Leavitt, a spokesperson for the Trump transition. "Those decisions will be announced when they are made."Richard Goldberg, who served at the National Security

Council during Trump's first term, called Waltz an impressive pick whose background as an elite U.S. service member and experience on Capitol Hill will be of great value to Trump.

TNPDC orders 12L singlephase meters to meet rising demand

CHENNAI: The Tamil Nadu Power Distribution Corporation (TNPDC) has ordered 12 lakh single-phase meters from six private suppliers to address the rising demand for electricity meters. The new meters are expected to arrive in phases, with the entire batch to be delivered by December.

A senior TNPDC official told TNIE, "The corporation, which serves over 2.7 crore domestic consumers and around 40 lakh commercial consumers, has a continuous demand for new meters. With such a large customer base, we need a steady supply of meters to ensure accurate billing and uninterrupted service."The official said that since there are limited suppliers in South India, TNPDC is procuring these meters from companies in the north, which has led to minor delivery delays. Currently, there are around 2 lakh single-phase meters and 1 lakh three-phase meters that are waiting to be replaced due to defects. The official pointed out that until these faulty meters are replaced, some consumers may continue to be billed based on previous average usage, potentially leading to revenue loss for TNPDC. "Once smart meters are introduced for all consumers, it will help resolve complaints related to defective meters," the official said.

Another TNPDC official noted that reaching every consumer's doorstep to replace defective meters immediately is a challenge. "To ease the process, we recently advised consumers to purchase new meters from registered vendors, if needed. This is an additional option, and consumers must inform the local TNPDC office before installing the new meters," the official added.

Rs 8,945-crore budget boost to Home Department

VIJAYAWADA: In what could be a major boost to the Home Department, which had been starved of funds to meet minimum expenditure and take up capacity-building projects, the TDP-led NDA government has allocated a whopping Rs 8,945 crore to it in the State Budget for 2024-25, presented by Finance Minister Payyavula Keshav.Home Minister Vangalapudi Anitha expressed her happiness over the budget allocation for the Home Department on Monday. Concerns rise over household survey as residents question collection of sensitive financial, personal data in Telangana

HYDERABAD: As questions related to Aadhaar, bank account, properties, income tax details, caste and other related information are part of comprehensive household survey (Kula Ganana), the enumerators are facing opposition from the people. They are taking serious exception to giving out the sensitive data. During the process of data collection, some residents are expressing concerns over potential removal of their names from ration cards and other welfare schemes using the data. There is a reason for the residents to worry about the questions posed at the survey as they are seeking financial information of the households. The questions to which there is resistance are those related to family income. The enumerators are asking for details of the sources of income of all the family members, like the income on the land they possess, salary of the family members if they are employed and the details of income tax returns. Even though the Congress government has declared that the data will be useful in implementing welfare and development schemes, the people are worried that it may be used in rendering them ineligible for welfare schemes.At some places, the enumerators were asked why the government wanted to know such details. Some residents went to the extent of recording videos as the enumerator was seeking sensitive financial information."Why do you want to know my caste? Why do you want to know my bank details?" are some of the questions being put to the enumerators. These questions could be heard in the videos that are flooding the social media. There is not much opposition in urban areas for such questions but in rural areas, the people are looking at the survey teams with suspicion.

Waqf land dispute escalates to wider areas

Catholic Church intensified its protests in the Munambam land dispute, the issue has been escalating to wider areas with Waqf Board sending notice to five families in Thavinjal grama panchayat near Mananthayadi in Wayanad. The notices ere issued following a complaint received on October 10, stating 4.7 acres in 5.77 acres of Waqf land had been encroached upon by the five families. They have been asked to submit relevant documents by November 16. This apart, a video

circulating in the Catholic Church's YouTube channel alleged that Waqf is now staking claim on around 250 acres of land in Taliparamba in Kannur as well as land owned by a Musilm family in Thalassery in Kannur, which is under the threat of eviction due to Waqf's claims.

Meanwhile, the Catholic Church has decided to intensify its demand for the implementation of the Waqf Amendment Bill 2024. The Church is of the view that bringing specific amendments to the Waqf Act is the key to resolving the disputes related to land rights.

Fr Antony Vadakkekkara, public relations officer of the Syro-Malabar Church, expressed the Church's desire for an amendment in the Act to ensure equal justice for all. "Munambam is just one piece of a larger puzzle. Now the dispute at Thavinjal panchayat in Wayanad has come out. According to reports available,



Waqf land issues persist in 23 locations across Kerala with Munambam ranking 15th on the list. It is concerning to see individuals who had legally purchased and owned land for many years are now facing potential eviction due to claims made by Waqf, warranting proper amendments to ensure equal justice for all," he said. The Church has also put forth a demand to political parties to support the Waqf Amendment Bill, in view of Waqf land disputes being reported from more areas, including the latest one at Thavinjal panchayat in Wayanad district. The Church has also started a campaign through social media .The Kerala State Waqf Board has issued targeting the UDF and LDF MPs who opposed the amendments to the Bill during their speeches in Parliament. Can encroachers be given free alternative houses, Madurai Bench of Madras HC asks TN govt

MADURAI: Hearing a batch of cases filed by residents of BB Kulam area in Madurai against eviction notices issued to them by the state for encroaching the waterbody, the Madurai Bench of the Madras High Court on Monday sought response from the government whether the alternative accommodation, which it is planning to provide, could be offered free of cost. A special bench of Justices GR Swaminathan and B Pugalendhi orally pointed out that the government also shared part of the blame as it was the Tamil Nadu Slum Clearance Board (TNSCB) which sold or allotted the properties to a majority of the

Additional advocate general Veera Kathiravan said the government is ready to provide alternative houses, each worth Rs 8.5 lakh at a subsidised cost Rs 1.5 lakh, to the encroachers at the housing area created by the Tamil Nadu Urban Habitat Development Board (TNUHDB) in Rajakoor village. But the judges opined that some of the encroachers may not be able to pay even the said amount. Some of the counsels appearing for the petitioners further objected to shifting to Rajakoor housing area and requested the court to direct the government to choose an alternative location. They also argued that the government should let them continue to reside in BB Kulam, considering it was the TNSCB which had given the properties to them. The BB Kulam Mullai Nagar Kudi Irupor Nala Sangam stated in its plea that most residents have been living in the area for more than five decades and have perfected their title by adverse possession. The judges directed the AAG to get the state's response to their suggestion and adjourned the matter to Friday for further hearing.

Crisis in Chavakkad as 200 families face threat

THRISSUR: While more than 600 families at Munambam in Ernakulam are protesting for their rights on the land in which they have been living for years, over 200 families in Chavakkad in Thrissur are facing a similar crisis as the Waqf Board has staked claim on their land. Though the residents filed a complaint with the Chief Minister's Office, they are yet to get a favourable response. Now, the residents of this coastal region have approached the High Court seeking intervention.Many residents are

awaiting documents of their land from the village office. But the revenue authorities are not issuing the same as the Waqf Board has staked claim on the land.



Valiyakath Haneefa, who resides in the area, recently approached Manathala village office to secure documents related to his 6 cents of land for availing a loan to conduct his daughters' marriage. However, the

revenue authorities told Haneefa that they were unable to issue the documents as the land originally belonged to Waqf Board. The village officer told him that there is a directive not to issue ROR (Record of Rights) certificate for those who currently occupy the land. Anmol Mothi, a local BJP leader, said: "More than 200 families, mainly belonging to Muslim community, are facing similar issues. They are worried about their future as they cannot legally claim ownership of the land in which they have been

residing for a long time.' It is learnt that several families living in the surroundings of Manathala mosque have been facing the same issue. Manathala

mosque and the annual Nercha festival are famous in Central Kerala. The houses in the region are situated close to each other.

People who have been living here since their grandparents' time, people who bought land here and even those who received title deeds from the state government are also among the affected," said Anmol. He added that the issue would be brought to the attention of the Centre.

According to Sheeja Prasanth, Chavakkad municipality chairperson, "the residents are in a panic as Waqf Board has staked claim on land in various parts of the state. The residents have been living there for years. From what I came to know, they have filed a complaint with the district collector and authorities concerned."

One student in critical condition as many fall ill after food poisoning at Ashram school in Telangana

HYDERABAD: One of the three girl students from Ashram High School in Wankidi mandal in Kumurambheem Asifabad district, suffering from food poisoning, is struggling for life after having been hospitalised in NIMS for a week now.More than 50 tribal girl students had fallen ill after having dinner at the hostel on October 30, three of whom were admitted to NIMS hospital for treatment. The students, E Mahalakshmi (14), K Jyothi (13) and C Shailaja (16) had developed acute gastroenteritis, which led to dehydration and kidney issues and were admitted to NIMS for treatment. As per the NIMS administration, Shailaia

was admitted on November 5 while she was suffering from dehydration. She later developed a kidney issue (increased Serum Creatinine secondary to dehydration) and a lung infection for



which she was put on a ventilator on November 5. Subsequently, she was put on special dialysis i.e., Continuous Renal Replacement Therapy from November 5 to 9.She was off the ventilator on November 8 and showed signs of improvement after recovering from a lung infection, she was put on an oral diet and was able to talk and move.

However, on Monday morning, she had a respiratory arrest for which she was put on a ventilator again and dialysis was being continued and her condition was said to be critical. The condition of the other two girls, who were admitted on November 3, improved. Mahalakshmi is fit to be discharged, while Jyothi is stable and under observation. Meanwhile, Health Minister Damodar Rajanarsimha visited NIMS hospital on Monday to enquire with the doctors about the condition of the three girl students. The minister said that all three patients were given free of cost treatment and free food was provided to the girls and their attendants, in addition to free accommodation in the private ward.

Panchayats get Rs 16.7k crore for sustenance



VIJAYAWADA: The TDP-led NDA government, which believes that Gram Panchayats were given a raw deal during the previous YSRC regime, has made a budgetary allocation of Rs 16,739 crore for the Panchayat Raj and Rural Development Department.Finance Minister Payyavula Keshav mentioned that the government has taken initiatives to revive the past glory of the Panchayat Raj system by promoting local self-governance in its true spirit. The government is committed to bringing every poor family in rural areas above the poverty line. "Our government is actively supporting the livelihood of SHG (Self-Help Group) members by aligning with various central schemes such as the PM Employment Generation Programme, PM Formalisation of Micro Food Enterprises, PM SVANidhi, and PM Vishwakarma. This convergence aims to increase income levels and boost informal employment opportunities for SHG members. Additionally, by promoting Open Network Digital Commerce, our government is enabling SHG women to expand their businesses. This strategic approach will foster sustainable income growth for SHG members," he said. VIJAYAWADA: In a major boost to strengthen Andhra Pradesh's education sector, Finance Minister Payyavula Keshav has announced an allocation of Rs 29,909 crore for the School Education Department for 2024-25 fiscal.The budget also made allocations for the Super Six guarantee-Thalliki Vandanam scheme, which offers financial assistance to mothers of children studying from Class I to XII in both government and private schools. Allocation of

Rs 5,387.02 crore has been made under SC, ST, BC, and Minority components, aiming to reduce dropout rates by addressing financial barriers to education."Our government is undertaking comprehensive reforms to improve school infrastructure and enhance student learning outcomes," Kesav asserted and added that one of their administration's first priorities was the Mega DSC recruitment drive to fill 16,347 vacant teacher positions which is expected to bring new energy and expertise to the educational workforce. Additionally, the



TDP-led NDA government has reduced administrative burdens on teachers by limiting app-based requirements, enabling them to focus more on teaching. The government also announced the renaming of key educational schemes in honour of renowned figures like Sarvepalli Radhakrishnan and Dokka Seethamma.In the higher education sector, an additional Rs 2,326 crore has been allocated for the 2024-25 fiscal year. As part of the Swarna Andhra @ 2047 vision, the State government is committed to strengthening State universities and establishing Tirupati, and Visakhapatnam. Furthermore, the government also intends launch faculty development programmes to train 18,000 faculty over the next three years. To enhance students' employability, the government has partnered with organisations such as NASSCOM, EduSkills, Salesforce, and Microsoft to provide internships for over 2.5 lakh students, starting in December 2024. While the budget allocations have been well-received by some, concerns about funding adequacy and

transparency persist. "The previous government allocated Rs 6,500 crore for Ammavodi, and the current government's promise of Rs 15,000 per student under Thalliki Vandanam needs nearly Rs 11,000 crores, however, the State government allocated only Rs 5,387.02 crore," S Narahari, President of the Parents' Association of Andhra Pradesh, told .Sulluru Yachendra, State President of the ABVP Students' Union, also voiced reservations, urging the government to increase education sector funding as per the Kothari Commission.

Challenge for India, US to keep defence ties on track

THE US will have Donald Trump as the new incumbent in the White House on January 20, 2025; he will be sworn in as the 47th President. He is returning to the Oval Office after four years.

Based on Trump's track record in the first term, disruptive and transactional are terms associated with the US President-elect. Allies, partners, adversaries — all the interlocutors of the US will be fastening their seat belts, and India, like other nations, would have to brace itself for the churn that may be triggered. The India-US bilateral relationship has steadily become more robust and consolidated since the 2008 breakthrough over the festering nuclear nettle. The defence vertical has acquired considerable traction, both by way of content and directivity. Will this relationship be reviewed, disruptively rearranged and adversely impacted in Trump 2.0?On current evidence, it may be averred that after 2008, there has been an essential continuity in India-US ties across the board (political, economic, defence and societal), and that this orientation will continue notwithstanding discordant issues that surface periodically and test the resilience of the relationship. The Gurpatwant Singh Pannun case, in which aspersions have been cast on Indian intelligence agencies, is illustrative.

A brief recap provides the context to this changing texture of the India-US defence/security relationship. After India's 1974 PNE (peaceful nuclear explosion), the bilateral was described as bitterly 'estranged' and India placed under severe US-led technological and related sanctions. It took three decades for a rapprochement that began after India conducted the May 1998 nuclear tests and President Bill Clinton visited India in March 2000. By 2008, a modus vivendi was reached over the nuclear issue and this was possible because of the resolve and sagacity demonstrated by President George W Bush and PM Manmohan Singh. From political estrangement and seemingly intractable dissonance over security and strategic issues, the bilateral defence relationship acquired traction in a steady manner. Following the acquisition of the landing ship USS Trenton in 2006 (it was commissioned as INS Jalashwa in January 2007) defence sales from the US to India increased Almost \$20 billion worth of American military inventory has been contracted since 2008.

In October, India concluded a deal to acquire highaltitude, long-endurance (HALE) armed drones estimated to cost \$3 billion, indicating that the US is emerging as an important arms supplier for Delhi.Most of these inventory items have been acquired under the FMS (foreign military sales) and financing framework, and it is instructive that the last such sale by the US to India was in 1965. Over the previous 15 years, India has acquired transport and maritime reconnaissance aircraft (C-130J Super Hercules, C-17 Globemaster III and P-8I Poseidon); transport, naval and attack helicopters (CH-47F Chinooks, MH-60R Seahawks and AH-64E Apaches); Harpoon anti-ship missiles and M777 howitzers. With these acquisitions, India, while not being a military ally, is now the largest operator of C-17 and P-81 military aircraft outside of the US.In 2016, India was designated as a "Major Defence Partner" thereby enabling a higher degree of defence, trade and security cooperation privileges. Furthermore, in June 2023, the US and India launched a bilateral Defence Acceleration Ecosystem (INDUS-X) to expand strategic technology and defence industrial cooperation. This framework for cooperation in strategic technology has considerable relevance for India, but as always, no nation parts with or shares such hi-tech Progress in this domain will not be wrinkle-free, and how this is taken forward by both nations will be an indicator about the qualitative texture and directivity imparted o the India-US defence relationship. This issue comes into focus with the decision taken in June 2023 regarding jet engines. A major US defence company, General Electric (GE) signed a \$716-million agreement with India's public sector entity HAL to jointly produce the F414 jet engine. This was heralded as a 'breakthrough' and was announced when PM Modi visited the US.

Delay in holding Senate polls bodes ill for PU

We must remember that PU has stood the test of time for over 130 years and we must trust its form of democratic academic governance.

ON October 31, 2024, the term of the Senate, the governing body of Panjab University (PU), which has a legacy of 132 years, came to an end without much ado. The Senate is the apex body that has superintendence over the affairs, concerns and property of the university.

At present, the university is running sans any governance framework, without a Syndicate — the executive arm of the Senate — and there are no deans. It seems that nobody — the stakeholders, former university fellows, faculty, students and public — has any inkling about the fate of this unique and inclusive governance structure, which has been a matter of pride for the region's informed citizenry. A delay in the election process has been witnessed only once earlier: in 2020. The compelling constraint of the pandemic was a good enough reason for that delay. Then, the constitution of the Senate was completed by October 2021 and it ran for its shrunk tenure of three years: from 2021 to 2024. A plea to extend the tenure by one year and not to count it from the point of time when it didn't exist (2020) was made in the Punjab and Haryana High Court, but no interim relief was granted.

This year, though, the normal process of declaring the polls 240 days before the election day (of the graduate constituency), i.e. in February 2024, was given the go-by. The period has been allowed to elapse without giving any valid reason or putting in place any alternative. Notably, no hullaballoo was raised for this unreasonable departure from practice and if it is being done now, it is too little, too late.

The PU Senate has 91 members, including 36 fellows nominated by the Chancellor (Vice-President of India), two from the Punjab Assembly and six exofficio members. The remaining 46 members are elected from 10 sections of the university and its vast flotilla of 200 affiliated colleges. Thus, representation is given to different groups of principals and faculty from colleges and registered graduates. Only four positions are earmarked for university teachers. This is a strange arrangement as decisions about the university, faculty recruitment and promotions, impacting the core functioning of its academic departments, are taken by the majority of the college faculty and non-teaching members. The constituency of registered graduates is the largest one. Voting for it is conducted at hundreds of polling booths set up across Punjab, Haryana, Delhi and Himachal Pradesh. The idea of its large size can be gauged from the fact that it includes every person who has, over the years, graduated from PU or its affiliated colleges.

In 2021, there were 3.61 lakh eligible voters. A budget of Rs 2.10 crore was allocated for the Senate elections. There is no system of deletion of deceased voters' names and no revision of voter lists is done; only an addition of new members is made. One lakh voters were registered in Ludhiana alone, where 48 polling booths were established. However, the voter turnout was a mere 14.57 per cent. This fact, makes this election an easy-to-win number game. Voters of denominational institutes and organisations, such as banks, traders' bodies and other unions, are easy to

capture for en bloc voting. Historically, the representation of women, people with disabilities, minorities, reserved categories or other marginalised groups in the Senate has been dismal. The trope of dynastic politics is quite visible.


The Panjab University Senate election is a significant event in north-west India as the university has been the prime institute of higher learning in the region since the pre-Partition times. With almost 100 departments on the campus and 200 colleges spread across Punjab, it has been touching the lives of a substantial cross-section of people. The Senate holds immense powers over the management of PU affairs. Its fellows enjoy huge clout over the students, parents, faculty, staff and societal stakeholders. Thus, the elections are taken seriously, with people spending a lot of time, effort and money in their bid to get into the board. For some members, retaining their seats for decades is a prestige issue.

Peculiar calendar rules ensure that a senator can go on to become the Dean of Faculties. Despite the senators having no experience of research or academics and belonging to entirely different professions, they could grace this position. The world over, this post is reserved for the highest ranking academicians responsible for shaping the academics of the disciplines. Though voices for reform of the PU Senate's functioning have been raised, they have been resisted by the senators. The public perception of a PU senator is one of a powerhungry, arrogant person, as in recent years, some have been in the news for the wrong reasons. However, we need to remind ourselves of the fact that this institution has stood the test of time for more than 130 years and we must trust this form of democratic academic governance. This system took the university to the pinnacle of higher education institution rankings. PU is a NAAC A++ university, 46 of its faculty members figure among the top two per cent scientists of the world and its illustrious alumni are scattered around the globe. The democratic structure of the Senate — with the number of elected members being more than the nominated ones and representatives from varied sections — makes it difficult for external forces with ulterior agendas to destabilise the university or intervene in decisions that are taken after brainstorming by its members.

Research studies in academic administration indicate that large executive bodies are a deterrent to sound decision-making.

Hurtling towards a climate apocalypse

Gospel of capitalism continues to seduce us to buy more, use more and thereby cause more pollution

THESE days, I often congratulate myself for having resisted the temptation of buying a car. In fact, I love to walk, and it makes me feel good that there is no carbon emission from this simple act, and I am playing at least a minimal role in combating the threat of climate emergency. However, a pedestrian like me is being perceived as an obstacle or a hindrance. After all, our highways, lanes/bylanes, it seems, exist only for cars, motorbikes and other vehicles.

No wonder it is becoming increasingly difficult to walk peacefully or cross the road without anxiety. See the paradox: if you seek to play a role — even a minimal one — for reducing carbon emissions, you are not wanted! Even though scientists and environmentalists are repeatedly reminding us that because of the ceaseless burning of fossil fuels, the world is in a state of climate emergency, we are never tired of cutting trees, constructing mega expressways, glorifying speed and mobility, buying cars — more and more bigger ones — and designing towns/cities in a way that walking or cycling becomes almost impossible. The Delhi Statistical Handbook 2023 is frightening. The total number of vehicles registered in the national capital stood at 1.2 crore, of which 33.8 lakh were private ones. The game goes on, even though vehicular emissions account for about 38 per cent of Delhi's pollution. The entire thing is self-defeating. Imagine, for instance, the fate of Bengaluru — the transformation of a peaceful city into a noisy zone known for its notorious traffic congestion. Yes, with more than 23 lakh private cars, as a report says, commuters spend an average 30 minutes to cover merely 10 km!We seem to be caught in a vicious cycle: more cars, more traffic congestion, more flyovers, more expressways, more pollution. Yet, the lobby of techno-capitalists, contractors and politicians has begun to glorify yet another expressway to be inaugurated soon. Yes, this 264-km Delhi-Dehradun Expressway will enable you to travel between these two cities in just 2.5 hours!And as usual, we will be tempted to buy the latest model of a fancy car, drive along this sleek expressway and feel the thrill of what our hyper-modern times worship — speed and more speed. And we can safely forget that because of this expressway, as statistics provided by the National Highways Authorities of India suggest, 7,555 trees have already been felled! Who bothers about the pain of trees and the resultant human tragedy?Likewise, the speed/mobility inherent in the modernist project of development has led to a tremendous growth of the domestic air passenger traffic in India; it is expected to cross 150 million passengers in 2024. Amid

million passengers in 2024. Amid these tales of 'progress', do we bother to contemplate and understand that air travel is the most carbon-intensive activity an individual can undertake? It seems we are willing to pay the price. We inhale polluted air in our metro cities, quarrel with our neighbours over parking space and live with hypertension and diabetes because of constant exposure to speed and noise. And I feel like resisting this obsession with speed and mobility that our expressways and airports symbolise. I cherish the rhythm of 'slowness'.

There is yet another consequence of our fascination with speed — the cult of consumerism. "Buy one, get



one free"—the market-driven mantra tempts us to buy and consume more, be it latest electronic goods, a fancy garment, a packet of potato chips or detergent powder, or, for that matter, a new smartphone. This normalisation of consumption further pollutes the environment. For these products, massive amounts of energy are required to power manufacturing facilities and transportation. This leads to carbon emissions. Likewise, textile production generates millions of tonnes of waste each year, and very few fabrics ever get recycled. Moreover, as e-commerce has increased our reliance on packed items, millions of packages wrapped in plastic create humongous amounts of waste. We should not forget that plastic

exposes living beings to harmful chemicals which might cause cancer and other health problems. Likewise, electronics contain rare metals that often end up in landfills. Moreover, plastic waste is likely to land in the ocean, causing severe damage to marine species. Yet, the gospel of capitalism continues to seduce us to buy more, consume more and thereby cause harm to the earth's ecosystem. As you visit a shopping mall, receive messages of special 'offers and discounts' and regard shopping and buying as mass entertainment, you realise that consumerism is the most cherished religion of our times. Yet, I seek to become a 'minimalist'. I know that my 'slow living' or 'minimalism' is no answer to what is happening around us - the visible presence of a climate emergency with all its devastating consequences: the constant emission of greenhouse gases causing the rise of the

average world temperature by 1.1-1.2°C, melting of glaciers, more and more heatwaves, frequent and intense floods, cyclones, wildfires and the loss of human lives. We need to strive for a massive structural transformation for which world leaders, policymakers and corporate elites have to take the historic Paris Agreement seriously and rethink development and economic growth to substantially reduce global greenhouse gas emissions. But then, no big revolution is possible unless you and I also try to alter our life projects for reducing carbon emissions, exert pressure on the government and initiate a movement for saving our earth from a catastrophe.

Just like humans, dogs have the remarkable ability to remember and recall events from the past even when the canines do not expect to be rewarded, a new study has found. "The results of our study can be considered as a further step to break down artificially erected barriers between non-human animals and humans," said Claudia Fugazza of MTA-ELTE Comparative Ethology Research Group in Hungary.

"Dogs are among the few species that people consider 'clever,' and yet we are still surprised whenever a study reveals that dogs and their owners may share some mental abi lities despite our distant evolutionary relationship," Fugazza said.

In the new study, the researchers took advantage of a trick called 'Do as I Do'. Dogs trained to 'Do as I Do' can watch a person perform an action and then do the action themselves. For example, if their owner jumps in the air and then gives the "Do it!" command, the dog would jump in the air too.

The fact that dogs can be trained in this way alone was not enough to prove episodic memory. That is because it needed to be shown that dogs remember what they just saw a person do even when they were not expecting to be asked or rewarded.

To get around this problem, the researchers first trained 17 dogs to imitate human actions with the 'Do as I Do' training method. Next, they did another round of training in which dogs were trained to lie down after watching the human action, no matter what it was. After the dogs had learned to lie down reliably, the researchers surprised them by saying "Do It" and the dogs did.

The dogs recalled what they had seen the person do even though they had no particular reason to think they would need to remember. They showed episodic-like memory.

These are some of the solutions in geriatric expert Dr VS Natarajan's new book 'Generation Gap' that was released on Wednesday

The senior geriatrician, who says he drew inspiration from his many of his patients opening up to him about their children, includes several real stories. One of them is about a rich elderly woman in Purasaiwalkam, Natarajan's patient for many years. She sought his advice after her only son threatened to poison her if she did not transfer properties to

his name."The reasons could be that children look at their personal happiness above the welfare of their parents. With real estate boom, children want to sell off their parents' properties and make money. These are only my hypothesis," he said.

Dr Natarajan, the author of 30 medical books, had penned a book with the same title in 2015, analysing the abuse of elderly at home.

Natarajan advises senior citizens to lead independent lives and be aware of laws protecting them from mistreatment, while urging at the same time children to spend quality time with their parents. "It not just food and shelter that old people need. They need love and care too," he said.

"They have to remember that what they do to their parents will be repeated in their old age," he added.

Delhi Transport Commission employees Conducts Searches To Probe plan strike from November 13

NEW DELHI: Public bus service in the capital is expected to be hit severely from November 13 as workers of Delhi Transport Commission (DTC) will begin an indefinite strike to press their demands, including regularisation of contractual staff, timely salary and specified duty hours among others. The members of DTC Employees Unity Union are reaching out to everyone appealing for cooperation. They are contacting all the bus drivers and conductors of Delhi to join the protest at the DTC headquarters this week. Employees of Delhi Transport Corporation (DTC) and Transport Department have been fighting for a long time for their various demands. Now, the employees of DTC and Transport Department are preparing for a big strike on November 13 in Delhi.According to Lalit Chaudhary, president of DTC Employees Unity Union, thousands of employees demonstrated last month at the DTC headquarters pressing similar demands but no heed was paid to their demands by the authority."A memorandum was also given to the senior officials of the Transport Department regarding their demands. On



October 29 as well, the problems were explained to the officials by giving a memorandum again, but till now there has been no meeting on these problems. Now, our union has decided to hold a massive protest on November 13," he said. After the metro, buses are considered the second lifeline in the capital operating currently with a fleet of 7,400 buses. About 41 lakh people commute daily with these buses.

The strike is set to cause massive inconvenience to the passengers. According to the DTC union, the conductors working on contracts for a long time should be regularised and their services should be made permanent.

"The union has also demanded to have 60% permanent and 40% contract employees in the DTC department as per the rule under the Company Act, but at present 100% conductors are working on contract," the memorandum of demands read."DTC contract employees should be given travel allowance (TA) and 15 days of Class IV Leave (CL) as is given in DIMTS Company. Also, employees should be paid for

In a move to enhance public transport options in outer areas, the city government has inaugurated a new bus route, 972E, from Auchandi Border to Uttam Nagar Terminal and extended the route 990C to Auchandi Border.Route 972E will be served by five low-floor electric buses operated by the Delhi Integrated Multi-Modal Transit System (DIMTS), covering a distance of 36.6 km in about 2 hours and 39 minutes. Route 990C will also see five low-floor, air-conditioned electric buses managed by the DTC on its 20 km

Anti-Terror Agency Al-Qaida's Terror Activities

The crackdown at nine locations, linked with individuals suspected of supporting and funding the activities of the proscribed terrorist organisation Al-Qaida, started early in the morning in Jammu and Kashmir, Karnataka, West Bengal, Bihar, Tripura and Assam, it said.

New Delhi: The National Investigation Agency (NIA) on Monday conducted extensive searches at multiple locations across the country in connection with the activities promoted by some Bangladeshi nationals as part of terror group Al-Qaida's conspiracy to destabilise India, according to an official statement. The crackdown at nine locations, linked with individuals suspected of supporting and funding the activities of the proscribed terrorist organisation Al-Qaida, started early in the morning in Jammu and Kashmir, Karnataka, West Bengal, Bihar, Tripura and Assam, it said. The searches led to the



recovery of incriminating documents showing detailed banking transactions, digital devices including mobile phones, and other evidence related to terror funding activities, the statement issued by the NIA said.

As per NIA investigations, the suspects whose premises were raided are sympathisers of a Bangladesh-based Al-Qaida network. The searches were part of NIA's ongoing investigations into a 2023 case pertaining to a conspiracy orchestrated by Bangladesh-based Al-Qaida operatives in collaboration with the arrested individuals, it said. The conspiracy was aimed at propagating Al-Qaida's terrorist activities and radicalising gullible youths in India, the probe agency said. In November last year, NIA had filed a charge sheet against five accused, including four Bangladeshi nationals -- Mohd Sojibmiyan, Munna Khalid Ansari alias Munna Khan, Azarul Islam alias Jahangir or Aakash Khan, Abdul Latif alias Mominul Ansari, it added.

The fifth accused, Farid, is an Indian national.NIA investigations into their antecedents had revealed that the accused had procured forged documents to carry out their activities covertly. They were actively involved in radicalising and motivating vulnerable Muslim youth in India, spreading Al-Qaida's violent ideology, collecting funds, and transferring these funds to Al-Qaida, the

Dense smog in Delhi, many stations record AQI close to 350

NEW DELHI: Delhi's air quality worsened early Monday, as the city was blanketed in dense smog and the air quality index (AQI) dropped to 347, according to Central Pollution Control Board (CPCB) data at 7 am. This placed the city in the "very poor" category, with the AQI reading 334 on Sunday at 4 pm. Around a dozen monitoring stations recorded AQI levels close to 350, also within the "very poor" range. In the ITI Jahangirpuri area, the AQI rose to 377, which is classified as "severe" under CPCB guidelines.

Monday saw Delhi's maximum temperature reach 31 degrees Celsius, slightly above the seasonal average, following a weekend high of 32.5 degrees Celsius. The minimum temperature was 23 degrees Celsius, which is three degrees above normal, according to CPCB data. Various locations in the city, such as India Gate, Akshardham, and Bhikaiji Cama Place, also showed very poor air quality. Out of 39 monitoring stations in Delhi, two-Bawana and Jahangirpuri-reported "severe" air quality, with AQIs of 401 and 412, respectively. Other areas like Jawaharlal Nehru Stadium and Akshardham had AQIs of 316 and 378, which are also considered very poor. To combat pollution, the Delhi government has rolled out initiatives like the "EV as a Service" programme, which was launched on Sunday with Union Power Minister Manohar Lal Khattar leading

Delhi HC approves counting of votes in DUSU polls with rider

NEW DELHI: The Delhi High Court on Monday gave the green light for counting of votes for the 2024 Delhi University Students' Union (DUSU) elections, conditional on satisfactory cleanup efforts across the campus.A bench, comprising Chief Justice Manmohan and Justice Tushar Rao Gedela, had previously halted the process after observing defacement of university and public property due to election campaigning. The bench directed the university to resume counting on or before November 26, provided that all remaining campaign material and



graffiti are cleared from the vicinity."The matter is closed with a direction to DU to undertake the counting process... if it is satisfied that the [remaining] sites... are cleaned," the bench said, emphasising that the intent behind the proceedings was corrective rather than punitive. The counsel representing the candidates assured the court of their commitment to removing any lingering campaign materials from affected areas.

Most colleges and faculties in the North and South campuses were cleaned, but images submitted to the court revealed campaign-related posters and graffiti still lingering on properties near the campus. The court proceedings were initiated by advocate Prashant Manchanda, who filed a plea seeking accountability from candidates and student organisations for allegedly defacing public spaces.

Supreme Court extends Kerala actor Siddique's interim bail in rape case

The actor, through his counsel, informed the Supreme Court that the police repeatedly demanded his phone and laptop from the time of the alleged crime. Justice Satish Chandra Sharma questioned how someone could be expected to provide a phone used in 2016.

New Delhi:The Supreme Court on Tuesday extended the interim anticipatory bail of Malayalam actor Siddique in a rape case filed by a fellow actor, following the release of the Justice Hema Committee report, which highlighted incidents of sexual harassment in the Malayalam film industry. The 62-year-old actor had previously been granted interim bail, and the bench of Justices Bela M Trivedi and Satish Chandra Sharma extended the bail further by a week. A case was filed against Siddique in August this year based on a complaint by a young actor, who accused him of raping her in a hotel in 2016 after inviting her for a preview of his movie. The complaint also alleges that he had attempted to sexually assault her at a theatre earlier that same year, prior to the rape incident. The actor, through his counsel Senior Advocate Mukul Rohatgi, submitted before the top court on Tuesday that the police kept asking for his phone and laptop used in 2016, questioning, "How will I give it?"Senior Advocate Ranjit Kumar,



appearing for the state, told the court that though the actor was appearing before the probe team, he was not cooperating with the investigation and was giving evasive responses.Justice Satish Chandra Sharma questioned how a person can be asked to hand over a phone used in 2016. Ensuring Easy Access To Justice To All Our Constitutional Duty: Justice Sanjiv Khanna

New Delhi: Chief Justice of India Justice Sanjiv Khanna on Monday said that ensuring easy access to justice and equal treatment to citizens regardless of their status is the constitutional duty of the judiciary.Justice Sanjiv Khanna, who was sworn in as the 51st CJI by President Droupadi Murmu at the Rashtrapati Bhavan, expressed deep honour in leading the judiciary, the third pillar of democracy, and outlined a citizen-centric agenda for judicial reforms."Judiciary is an integral, yet distinct and independent part

of the governance system. The Constitution trusts upon us the role of constitutional guardian, protector of Fundamental Rights, and responsibility to fulfil the important task of being a service provider of justice," the CJI said in his first

He said, "The justice delivery framework in terms of providing equal treatment



necessitates fair opportunity to succeed to all, regardless of status, wealth or power, and a just and unbiased adjudication. These mark our core principles." "The responsibility entrusted upon us affirms our commitment as protectors of citizens' rights and as dispute resolvers. It is our constitutional duty to ensure easy access to justice to all citizens of our great nation," he said.Chief Justice Khanna

identified pressing challenges facing the judiciary, including the need to reduce case backlogs, make litigation affordable, and simplify complex legal processes.Recognizing that the justice system must cater to all citizens, he outlined a vision to make courts more approachable and userfriendlyThe CJI aimed to adopt a selfevaluative approach which is receptive and responsive to feedback in its working, the apex court said in a statement." Making judgments comprehensible to the citizens and promoting mediation will be a priority," it said. With a focus on

criminal case management, the CJI pledged to prioritise reducing trial durations, adopting a systematic approach, and ensuring that legal procedures are not gruelling for citizens. He also highlighted the importance of promoting mediation to resolve disputes efficiently and provide timely justice.

As Chief Justice Khanna steps into his new

role, he brings a vision of a judiciary that is not only a protector of rights but also a service-oriented institution committed to enhancing accessibility and ease of justice for all citizens. Earlier in the day, Justice Khanna heard 45 cases on his first day as the CJI and thanked lawyers and bar leaders for wishing him well.

He received a rousing welcome by the bar leaders, lawyers including former attorney general and senior advocate Mukul Rohatgi.

CJI Khanna took the oath in English "in the name of God". Born on May 14, 1960, CJI Khanna will serve on the post for a little over six months and demit office on May 13, 2025 up on attaining the age of 65.He succeeded Justice D Y Chandrachud who demitted office on Sunday. Vice President Jagdeep Dhankhar, Prime Minister Narendra Modi, Defence Minister Rajnath Singh, Union Law Minister Arjun Ram Meghwal and former CJIs Chandrachud and J S Khehar were among those present on the occasion.

RBI, Sebi issue framework for reclassifying FPI investments as FDI

MUMBAI. The Reserve Bank of India (RBI) and the Securities and Exchange Board (Sebi) have directed foreign portfolio investors (FPIs) to obtain necessary approvals from the government and concurrence from the investee companies in cases of acquisition of equity holdings beyond the prescribed limits. The direction better aligns with the Fema rules, the regulators said in separate notifications Monday and helps lift the current 10 percent cap on such investments, with prior government nod.

The regulators have issued an operational framework for the reclassification of overseas investments by FPIs to foreign direct investments (FDI), outlining the process to be followed in case of breach of the thresholds. The Foreign Exchange Management Act (Fema) norms prescribe 10 percent threshold for investments made by FPIs in the total paid-up equity capital of a company. Any FPI breaching this limit has the option to divest its holdings or reclassify them as FDI, subject to several conditions. The rules provide a window of five days from the settlement of trades to do the same.

The notifications further say that investors have to obtain prior government approval before making the additional investments. Further, FPIs have to explain the intention to reclassify the investment as FDI, too. However, the facility for reclassification from FPI to

FDI is not permitted in certain prohibited sectors.

'Necessay approvals from the government, as applicable, including approvals required in the case of investment from land-bordering countries, must ensure that the acquisition beyond the prescribed limit is made in accordance with the provisions applicable for FDI. This means that the investment should adhere to the entry route, sectoral caps, investment limits, pricing guidelines, and other attendant conditions for FDI under schedule I to the rules," said the circulars.

Following reclassification, the entire investment of an FPI in a company can be considered an FDI and will continue to be classified as such even if it falls below 10 per cent. The regulators have also separately breaches and reclassification by the FPIs and custodians."After ensuring that the reporting for reclassification is complete in all aspects, the custodian shall unfreeze the equity instruments and process the request. The date of the investment causing the breach in such cases shall be considered the date of reclassification," said the circular.

Zomato, Swiggy say complying with CCI rules



MUMBAI: Amid a CCI investigation into anticompetitive practices, Zomato has emphasised its adherence to competition laws, while competitor Swiggy has affirmed its dedication to following local regulations.

Both Zomato and Swiggy called reports about the Competition Commission of India's (CCI) probe "misleading". They pointed out that the CCI has not yet made final decision on claims of unfair business practices like giving special treatment to restaurant partners. In a regulatory announcement, Zomato said the CCI had issued a preliminary order on April 4, 2022. This order instructed the Office of the Director General of the Commission to look into breaches of the Competition Act. "Since the intimation of April 5, 2022, the CCI, on merits, has not passed any order. The aforementioned news article is misleading,' the company said."We will continue to work with the CCI to explain why our practices are in compliance with the Competition Act and they don't have any adverse effect," Zomato added. As per Swiggy, media reports of CCI's probe into Swiggy confuse investigative process with final outcome and are misleading."Based on order of the CCI dated April 5, 2022, the Director General probed certain aspects of the conduct of our business and its inquiry and report of March 2024 is a preliminary step in an ongoing probe by

Trump has vowed to make the US "the crypto capital of the planet," promising supportive policies, including

the establishment of a national Bitcoin reserve. These pledges have boosted investor confidence, with analysts eyeing Bitcoin's next major target of \$100,000.Market analysts attribute this surge to a mix of macroeconomic trends and recent policy developments. The U.S. Federal Reserve's 25 basis points rate cut in November has directed investor sentiment toward alternative assets like Bitcoin."If history is any guide, Bitcoin could easily finish the year around \$100,000," noted Kyle Rodda, a senior financial analyst at Capital.com. The rate cut signals an accommodative approach,

easing inflation concerns and making Bitcoin more attractive as a hedge. Bitcoin ETFs have also contributed

significantly to its recent gains. Approval of these ETFs earlier this year has allowed institutional investors easier, regulated access to Bitcoin, expanding demand.Edul Patel, CEO of Mudrex,



called the ETF approval a "gamechanger," adding that rate cuts in major economies have also increased cash flow into alternatives like Bitcoin.

Himanshu Maradiya, Founder of CIFDAQ, said the Fed's rate cut has catalyzed this shift in sentiment, as investors seek out Bitcoin's unique qualities of scarcity and

Will Trump's win force India to rejig corp taxcritical Illness Insurance

NEW DELHI. As discussions around potential cuts in the US corporate tax He says that India does not need rate gain momentum post-Donald Trump's presidential victory, India may find itself at a critical juncture, needing to reassess its own corporate tax framework to remain competitive in attracting foreign investment.

However, experts are of the view that the dynamics of tax rates are complex and influenced by various factors beyond mere comparison with US rates. The government announced a significant cut to the corporate tax rate for domestic companies from 30% to 22% in 2019, and for new manufacturing companies, the rate was set at 15%. Despite these reductions, India's corporate tax rates remain relatively high compared to some ASEAN and OECD economies. Akhilesh Ranjan, Advisor with PwC and Former Member of the Central Board of Direct Taxes (CBDT), points out that while India has already reduced its corporate tax rates in recent years to foster economic growth, the global investment landscape is dynamic."A competitive corporate tax regime is crucial, but it must be complemented by improvements in infrastructure, regulatory frameworks, and labour

market conditions," Ranjan said.

reconsider its approach to tax policy as the current strategy to stabilise the tax regime aims to provide predictability for investors. Surajkumar Shetty, Partner at JSA Advocates and

To continue attracting FDI, India may consider moderate and gradual tax rate reductions while ensuring stable and predictable tax policies, faster dispute resolution, and reduced tax administration complexities will play an even greater role in attracting investment, he said. Aashish Kasad, Tax Partner, EY India, concurs with Thingana. She says to safeguard its position as a premier investment destination, India might need to recalibrate its corporate tax rates, striking a delicate balance between attracting foreign investment and fostering a sustainable revenue system. Meanwhile amid fears that the minimum tax under Pillar 2 is in peril under the Trump regime, Ranjan said, "India currently does not appear to be in a hurry to implement the minimum tax under Pillar 2, as the likely revenue gains may not justify the high costs

associated with its administration.

This is despite the fact the market was at its monthly worst in year, losing over 6% from September peak.

As per the Association of Mutual Funds (Amfi) data, fund inflows into open-ended equity funds stayed in positive zone for the 44th month in a row, taking total assets under management of mutual funds to Rs 67.25 lakh crore in October, marginally up from Rs 67.09 lakh crore in September, making it an all-time high.Despite massive inflows, the bleeding market has ensured that all equity mutual fund categories had negative returns in the reporting month, with the automotive sector suffering the most significant decline. Meanwhile, mutual fund folios rose to an all-time high of 21,65,02,804 in the month. Of this, retail folios also rose to an alltime high at 17,23,52,296.Of the Rs 67.25 lakh crore, total AUM, retail fell to Rs 39,18,611 crore as against Rs 40,44,098 crore in September. Number of new SIPs registered stood at 63,69,919 and their AUM is stood at Rs 13,30,429.83 crore. SIP contribution stood at an all-time high of Rs 25,322.74 crore as against Rs 24,508.73 crore in the previous month. Inflows to others categories, including index funds and ETFs, surged 620% to Rs 23,428 crore, while inflows to hybrid funds reached Rs 16,863.3 crore and inflows to exchange-traded funds (ETFs) reached Rs 13,441.8 crore.

Dhruv Jurel looks class: Tim Paine backs India youngster to impress in Australia

New Delhi. Former Australian Test captain Tim Paine has tipped Dhruv Jurel as a standout prospect for India in the upcoming Border-Gavaskar Trophy series. Jurel's impressive performance in the second unofficial Test match between Australia A and India A at the iconic Melbourne Cricket Ground (MCG) caught Paine's attention, particularly due to the young Indian's ability to handle the pace and bounce that Australian pitches notoriously present. Jurel showcased his skills with scores of 80 and 68 across his two innings in the four-day clash at the MCG. His assured batting under challenging conditions has fueled Paine's belief that Jurel could be a surprise package in the highly anticipated Test series against Australia. Speaking to SEN Tassie, Paine said, "There's a guy who has wicket-kept in a few Test matches for India. He averages 63 across the three Tests he's played, and his name is Dhruv Jurel. Watching him bat, it was evident he has the temperament and skill for the longer format. Even though he's



primarily a wicketkeeper, I'd be surprised if he doesn't feature in the series in some capacity."Jurel, who has already made three Test appearances against England earlier this year, scored 46, 90, 39 not out, and 15 in those outings, averaging 63 with the bat. His technique and posses in Melbourne, facing the Australian bowling lineup on a notoriously bouncy surface, impressed the former Aussie skipper, who also coached Australia A in the match. "He's 23, and he looked a class above all his teammates on this tour," Paine noted. "A lot of players from the subcontinent find it difficult to adjust to our conditions, but Jurel looked right at home. He's someone who handled the pace and bounce extremely well, which is unusual for an Indian batter at the MCG."

Paine's high praise comes as India gears up to face Australia's formidable fast-bowling trio of Pat Cummins, Mitchell Starc, and Josh Hazlewood. Though Rishabh Pant is expected to don the gloves for the visitors, Paine believes Jurel's potential with the bat may warrant a role as a specialist batsman if he doesn't keep wickets. Paine added, "Keep an eye out for him this summer. I think he's going to impress a lot of Australian fans.


