WHAT IS THE BELAGAVI DISPUTE?

The Belagavi border issue dates back to 1957 when states were reorganised on linguistic lines. Maharashtra laid claim to Belagavi, which was part of the erstwhile Bombay Presidency,

as it has a sizeable Marathi-speaking population, and over 800 Marathi-speaking border villages that are currently a part of Karnataka.Karnataka maintains that the demarcation done on linguistic lines as per the States Reorganisation Act and the 1967 Mahajan Commission Report is final.

To assert that Belagavi is an integral part of the state, the Karnataka government built the 'Suvarna Vidhana Soudha' here, modelled on the Vidhana Soudha, the seat of the state Legislature and Secretariat in Bengaluru.

New Delhi.RJD chief Lalu Yadav stirred controversy on Tuesday with a sexist remark directed at Bihar Chief Minister Nitish Kumar's Mahila Samwad Yatra, saying that they are going to "letch at women."

This remark came as Nitish Kumar announced plans to launch the Mahila Samwad Yatra, a state initiative aimed at directly engaging with women. Rajiv Ranjan, a senior leader of the Janata Dal (United), strongly criticised Lalu Yadav's comments on Nitish Kumar's women rally. Ranjan said, "Lalu must not know how the people of Bihar tolerated him in the past. These are people with a deplorable mindset. Their true character has now been revealed."

Samrat Chaudhary, Bihar's Deputy Chief Minister, also condemned Lalu Yadav's remarks. Describing them as "unfortunate", Chaudhary said that the use of such language raises concern. "Lalu Yadav should consider going to a hospital,"

BIMS deaths: Private hospitals inflate prices

BALLARI. Allegedely taking advantage of the five maternal deaths reported in a span of a month at Ballari Institute of Medical Sciences (BIMS), some private hospitals have started exploiting patients by jacking up charges for admitting pregnant women.

The five deaths had allegedly taken place after banned IV fluid was administered to the patients by BIMS doctors and staff. Following these incidents, many patients who were admitted in BIMS and other government hospitals, have been shifting to private hospitals from the last 15 days.Parents and relatives of pregnant women are demanding that the district administration should take immediate action against private hospitals to are charging more and ensure that they don't fleece patients.

Nagashekar Reddy (name changed), a resident of Kampli, said, "After the five deaths were reported, I decided to shift my daughter, who was also admitted in BIMS Hospital, to a private hospital. Earlier, one of my relatives who had undergone delivery in that private hospital was charged about Rs 30,000. But when when I admitted my daughter in the same private hospital, they demanded Rs 50,000.All her reports are normal but the hospital is saying that there are no vacant beds available as many pregnant women have got themselves admitted in the

Lokayukta police conduct raids against nine officials in Karnataka

BENGALURU. The Karnataka Lokayukta

police on Tuesday conducted raids on nine state government officials for allegedly possessing disproportionate assets (DA) relative to their known sources of income. According to an official statement, the accused officials are Lokesh Babu, Superintending Engineer (Electrical), Bengaluru East Circle, Bescom; Suresh Babu, Revenue Inspector, Ward No. 197, Bommanahalli Range of BBMP; Krishnappa, Tax Inspector, Yelahanka Zone, BBMP; M. C. Sunil Kumar, District Health Officer, Health Department, Bengaluru Rural; Nanjundaiah, Deputy Superintendent of Police (Armed), Police Training School, Channapatna; Laxman, Second Division Assistant, Executive Engineer's office, Gadag; Ramappa, Superintendent Engineer (Development), Mahanagara Palike, Kalaburagi; Ramesh, Excise Inspector, Excise Department, Koppal taluk; and Suresh, Assistant Conservator of Forest, Hiriyur Sub Division. Sources stated that teams of officials simultaneously raided the offices and residences of the accused early Tuesday morning. During the searches, they seized valuables, including cash and documents related to the properties owned by the accused. The exact amount of DA possessed by each official will be determined later in the day after the conclusion of the searches.

Munambam land is waqf property: IUML

KOZHIKODE. Pushed by its own leaders, including national organising secretary E T Muhammad Basheer, state secretary K M Shaji and MLA M K Muneer, the IUML has finally stated that the disputed land at Munambam is indeed waqf property.Until now, the party leadership, including state president Panakkad Syed Sadiq Ali Shihab Thangal and national general secretary PK Kunhalikutty, had been playing hide-andseek, without clearly coming out on the exact nature of the land. They didn't contradict Leader of Opposition V D Satheesan's repeated assertion that the land is not waqf property. The leadership had remained silent when some legal personalities close to the IUML hinted that the Munambam land was given to the Farook College management under a gift deed and therefore it cannot be considered as waqf.But close on the heels of Shaji stating that IUML does not share Satheesan's view on Munambam land, Basheer told reporters in New Delhi that Munambam is indeed waqf land."At no point had the party said it was not waqf property. All documents prove this fact," he said. Though Basheer said he doesn't want to contradict Satheesan's claim, it But an impression has been created that was very clear that all in the party are not happy with the leader of Opposition's stand.IUML had placed Sadiq Ali Thangal at the centre of the fire-fighting mission to douse the communal flare-up between communities over the land. Thangal had met the Latin Catholic bishops as part of his mission, but many in the IUML



believed that the peace mission should not be taken up by concealing the facts about the land and by compromising the waqf claim. Also, the suggestion of the Muslim Coordination Committee that met under the leadership of Thangal in Kozhikode last month was to find a lasting solution without forsaking the waqf claim.

No more remarks on Munambam, says Thangal

Muslim organisations have no problem in giving up the land unilaterally. The mood of the community was to go for a compromise without forfeiting the claim. Sadiq Ali Thangal and Kunhalikutty were hoping that they could sweep the discussion on waqf under the carpet and work towards a rapprochement, which

was sabotaged by their own party leaders. Driven to the wall, Kunhalikutty on Monday clarified that the party never said the land is not waqf property. He said none who raised different voices in the party wanted to evict the people currently residing at Munambam. He blamed the government for inordinately delaying a solution to the issue. Sensing the danger of the emergence of differing voices within the UDF, Thangal asked the party leaders not to carry the discussions on the issue forward. Addressing a press conference in Malappuram, Thangal said there will not be any further remarks from the party leaders on the issue."Everyone admits that Babri Masjid stood at waqf land. Organisations like Muslim Personal Law Board said that it is for the Supreme Court to take a decision.

Group clash erupts at Cuttack college over smoking ganja

CUTTACK. Tension prevailed at the Netaji Subhas Memorial City College in Rajabagicha here on Monday after a clash broke out on campus between two groups of students allegedly over smoking ganja. At least three students sustained injuries in the incident. While one group involved some Plus III and former students, the other comprised mostly Plus II. Police sources said some Plus III students accompanied by a few outsiders allegedly forced the others to smoke ganja. However as they refused, an argument broke out between both the parties which escalated into a clash. As per sources, some former and Plus III students of the college besides outsiders run a WhatsApp group in the name of 'Black Brothers'. The group members allegedly engage in various antisocial activities including eve-teasing and creating nuisance on the campus.

On the day, members of 'Black Brothers' allegedly called some Plus II students near the cycle-stand of the college and forced them to smoke ganja besides urging them to join their group. However, when they refused, a war of words ensued between the two parties which soon took the form of a clash with each assaulting the other. Some other students present at the spot filmed the entire incident and posted it on social media.

On being informed, Badambadi police reached the spot and sent the injured to hospital for treatment. ACP Swastik Panda said as per preliminary investigation, the scuffle occurred as one group forced the other into smoking ganja."We have taken suo motu cognisance of the matter and started interrogating students involved in the incident. The college authorities are also being questioned and the video footage is being examined. Action will be taken accordingly," he added.

Women volunteers of Makkalai Thedi Maruthuvam scheme seek job permanency, higher pay

TIRUNELVELI. Women Health Volunteers (WHV) of the Makkalai Thedi Maruthuvam scheme submitted a petition with District Collector Dr KP Karthikeyan, demanding job permanency, increase in salary, and reduction in workload, during the grievance redressal meeting held here on Monday. The petition submitted by nearly 100 WHVs from across the district highlighted that around 200 WHVs have been serving under the scheme, since the Covid-19 pandemic, to identify non-communicable diseases such as hypertension and diabetes among rural populations. Despite their critical role, the WHVs alleged that they are burdened with excessive tasks beyond their job description and are being paid a meagre Rs 5,500 as salary, inclusive of travel allowances. The volunteers stated that they often use personal two-wheelers to transport



medical supplies to remote villages as public transport is inadequate, resulting in significant out-of-pocket expenses for fuel. They added that they were recently assigned additional responsibilities, including identifying infectious

diseases and collecting biological specimens, such as sputum samples for tuberculosis diagnosis. Emphasising that their families are struggling with financial hardships, they urged the state government to absorb them as permanent staff and provide adequate remuneration, and requested immediate intervention to ensure fair compensation and job security. Further, Kamarajar Samooga Nala Peravai members submitted a petition with the collector urging the state government to allow the victims, who were cheated through the investment scheme of the PACL, to register the land of the company in their name. Meanwhile, based on the complaints of the district administration, the Tirunelveli city police registered four cases against some petitioners who allegedly disturbed other petitioners with the unpermitted protests in front of the collectorate.

Polavaram diaphragm wall works to begin in January

VIJAYAWADA. Once Chief Minister N Chandrababu Naidu releases the work schedule for the Diaphragm Wall of the prestigious Polavaram Irrigation Project on December 16, the construction of the D-Wall will commence in the first week of January.According to highly placed sources, the construction of the 1,400metre-long D-Wall will be taken up in a phased manner as per the recommendation of the committee of experts. The new D-Wall designs were approved by the Central Water Commission (CWC) in the last week of November. The new D-Wall, which is estimated to cost around Rs 900 crore, will be constructed by MEIL, in collaboration with Bauer Group of Germany, and it is expected to be completed by March 2026, if not by December 2025.

Tribunal orders Rs19L damages for cyclist who lost leg in crash

Gurgaon. A rider whose leg had to be amputated after a truck hit his cycle and ran over him in Manesar in April 2021 was awarded compensation of Rs 18.9 lakh by the Motor Accident Claims Tribunal, Gurgaon, earlier this month. Compensation will have to be paid by the insurance company. Judge Tarun Singal, in the Dec 5 order, said that Jitesh Kumar Jha was 21 years old at the time of the accident and was the only earning member of his family."His condition is not likely to improve in the future. His happiness is lost forever. He will have to be continuously dependent upon others in all walks of life..." the judge said, awarding compensation. On April 1, 2021, Jitesh -- who worked as a record keeper with a private company in Manesar - was heading back to his rented accommodation in Rampura village. He had reached Minda Company Chowk when a truck rammed his bicycle. As he fell to the ground, his right leg was crushed under the wheel of the truck. He was rushed to ESIC Hospital in Manesar's Sector 3 for treatment, but his leg had to be amputated. Jitesh in 2022 filed a plea before the tribunal, seeking compensation of Rs 60 lakh. He argued that he used to earn monthly salary of Rs 16,000, and after becoming a victim of rash and negligent driving, he was left differently abled for life.

negligent driving, he was left differently abled for life. Police investigation found that the truck belonged to Balaji Cargo Moving Transport, and the driver was Amin Khan. The driver and owner of the truck told the tribunal they were falsely implicated in the case, but did not produce any evidence to support the claim.

The tribunal noted that they had not filed any complaint before the authorities for false implication and the petitioner had no motive to do so. Awarding compensation of Rs 18.9 lakh, the tribunal said that Jitesh's injuries will reduce his life expectancy and standard, other than causing hardship to his family.

Thank brisk winds & showers, Gurgaon's air turns 'moderate' again after 1 'poor' day

Gurgaon: The city experienced improved air quality on Monday, shifting from "poor" to "moderate" category, with a 24-hour AQI reading of 156, down from Sunday's 232. The enhancement was attributed to strong winds and scattered rainfall across NCR late Sunday evening. Monitoring stations across the city showed AQI levels within the "moderate" range on Monday. The readings were — Gwalpahari 126, Teri Gram 136, Vikas Sadan 114, and 199 at Sector 51.SAFAR forecasts a decline in air quality to "poor" level. Its report indicates northwest winds below 8 kmph during morning hours, with smog and moderate fog. Wind speeds may increase to 12 kmph by Tuesday afternoon. The ventilation index below 6000 m²/s and average wind speeds under 10 kmph create unfavourable conditions for pollutant dispersion. Wind speeds increased to 7 kmph on Monday from 3 kmph on Sunday, facilitating pollutant dispersal.

According to Sachin Panwar, an independent air quality expert, light rain across NCR on Sunday night helped clear the airshed. However, he warns that cooling temperatures and thermal inversion could trap particulates near ground level, potentially increasing pollution during mornings and evenings. Weather specialists anticipated a decrease in temperature in coming days, potentially leading to pollutant build-up. People with respiratory conditions have been advised to exercise caution during early mornings and evenings when pollution peaks due to lower temperatures and weak wind speed.Despite "moderate" overall AQI, PM2.5 levels remained concerning. Sector 51 station recorded 345 µg/m³, exceeding WHO's limit of 15 µg/m³ by 23 times. Teri Gram showed 303 µg/m³, Gwalpahari 290 µg/m³, and Vikas Sadan 162 μg/m³.

Meanwhile, widespread rain in northwest India, accompanied by strong winds, on Sunday night cleaned Delhi's air. The city recorded the fourth 'moderate' day in Dec as the Air Quality Index (AQI) improved to 186 on Monday. This month has recorded the highest number of 'moderate' days in Dec ever.

A320 lands & takes off from Noida airport in passenger flight trial

Noida. An Airbus 320 — operated by IndiGo — was the first flight to touch down and take off from the runway of Noida International Airport on Monday, successfully conducting a trial in the runup to commercial operations by April next year.

The flight — with officials from the Directorate General of Civil Aviation (DGCA) and Airports Authority of India (AAI) as passengers on board—landed in Noida at 1.25pm to a water cannon salute, accompanied by claps and cheers from airport staff and hundreds of workers who toiled on the project over the past couple of years. Before it landed, the Airbus circled above the airport for an hour and a half to assess operational readiness and air traffic protocols. It took off again around 2.45pm. As the flight landed on the newly built runway, Union civil aviation minister KR Naidu, along with senior officials from UP govt, marked the occasion by breaking coconuts and greeting the pilots and crew. The minister and officials declared the validation flight a success, saying this would pave the way for the airport's concessionaire to apply for an aerodrome licence.So, what did the validation exercise include? Officials said the trial included a test of the required navigation performance (RNP) and lighting systems. RNP allows aircraft to follow highly precise flight paths, ensuring optimal safety and efficiency."Today's aircraft had specialised equipment to perform critical manoeuvres, such as landing, takeoff, and taxiing along the runway. These tests evaluated the runway's performance, including surface conditions, length, and lighting systems. The navigational aids, such as instrument landing system (ILS) and precision approach path indicator (PAPI), were tested for accuracy. Communication protocols with air traffic control were assessed as well. Emergency simulations, including scenarios like engine failure and adverse weather conditions, were conducted," an official said.

Another tower unsafe, all of Chintels Paradiso in Gurgaon now faces demolition

Gurgaon. The last of Chintels Paradiso's towers to be assessed for structural defects was declared unsafe for habitation on Monday, closing a 34-month loop that has seen all nine residential towers of the condominium where flats sold for at a range of Rs 75 lakh to Rs 1 crore when it went to the market in 2012.In its latest report, Central Building Research Institute (CBRI) has found that Tower B has severe structural flaws, including widespread cracks, corroded reinforcement bars and substandard concrete, findings similar to those in the other towers. What this means is that Tower B will also have to be evacuated and Paradiso will become perhaps the first modern condominium in the country - Paradiso was completed in 2011 - that will be brought to the ground, another dubious first for NCR, which has already seen the razing of the Supertech twin towers in Noida. The structural assessments of Paradiso's towers began after a vertical collapse of living rooms of flats across five floors in Tower D on Feb 10, 2022 led to the death of two residents, which was followed by days of protests

on the compound, with residents accusing the developer of not reacting on time to concerns like sagging balconies that they had raised. Tower D was evacuated immediately after the cave-in. The other towers followed over the months, a process that was slow but had an air of inevitability about it as tower after tower was found to have the same defects."Corrosion in reinforcement bars. poor concrete quality, and significant structural deterioration were identified as critical safety risks. Experts also noted visible puffing of tiles, bulging floors and damaged balconies, with many elements showing signs of advanced corrosion. The building is beyond repair and recommended demolition is the only feasible solution," the CBRI report says of Tower B.Read the report on any of the other towers (A-J, the condominium has no Tower I) and the inference is similar poor concrete and corrosion. The condominium, where possession of flats began from 2014-15, has a total 532 flats. Developer Chintels India, which wants to rebuild the condominium, has now written to the district administration,



urging it to expedite evacuation of Tower B and towers A and C, where families continue to live.In its letter, Chintels highlighted the urgent need for demolition to prevent potential disasters. The letter also noted that the administration had previously applied the National Disaster Management Act to six towers-D, E, F, G, H, and J- and ordered their demolition in April 2024 after they were declared unsafe. Chintels has announced a one-time shifting allowance of ?40,000 for each flat owner in towers A, B and C. Edifice Engineering, the company that brought the twin towers down, has been engaged to demolish Paradiso and Chintels has revised its contract to include Tower B. The company,

which has given a buyout option to residents who sought a refund, said owners of flats in Tower B would be entitled to the same, based on current market value of their flats and interior costs at rates determined in collaboration with the administration.In Feb 2022, the administration had called IIT-Delhi to assess the structural safety of the towers. Subsequently, towers E and F were declared unsafe in March 2023, G in June 2023, H in July 2023, J in Jan 2024, C in Aug 2024 (done by CBRI), A in Oct 2024 (CBRI), and finally B (also CBRI). Towers D, E, F, G, H and J have been fully vacated. A total of 56 residents remain in flats in tower A, 54 in B, and around 30 in C. So far, the district administration has officially declared towers D, E, F, G, H and J as unsafe and ordered demolition. The administration has assured residents demolition will be carried out in a phased manner to minimise disruption. Mukesh Singhal, a resident of tower B, said, "I am a retired person with no pension or any other source of income. We are being asked to vacate the flat for no fault of ours.

27.6k fined Rs4.4cr for seat belt, phone violations till Nov in Gurgaon

Gurgaon. Around 24,000 commuters in the city were fined Rs 2.4 crore for not wearing seat belts, and 3,664 were issued challans worth Rs 2 crore for using mobile phones while driving between Jan and Nov this year.

Police said not wearing a seat belt is among the most common traffic violations in the city. On average, 400 people die in road accidents in Gurgaon every year. Though the number of challans for flouting traffic norms has gone up over the years, little has changed on the ground.

DCP (traffic) Virender Vij on Monday urged commuters to wear seat belts.

In many accidents, airbags fail to deploy because the driver was not wearing a seat belt, leading to fatalities. Using a seat belt can significantly enhance driver safety in case of accidents," the DCP said.



Vij said traffic police will continue to keep up surveillance and checks. "This will ensure safe, smooth and orderly traffic management, and this special campaign will continue in the future," he said.TOI had reported last week that challans issued for wrong-side driving till Nov this year were almost three times more than fines issued for

the offence in 2019, which was – until now – the highest annual count recorded by traffic police. According to traffic police, 1.46 lakh challans were issued for wrong-side driving and Rs 10.3 crore was recovered as fines from commuters till Nov 30 this year.Cops also identified 38 spots in the city, where commuters tend to drive on the wrong side of the road. These include Sheetala Mata Road, Signature Tower Chowk towards Huda, Sohna

Road near Iris Tech Park, Subhash Chowk, Basai Chowk, Galleria Market to Golf Course Road, Guru Dronacharya Metro station, Hero Honda Chowk, Hero Honda Chowk to Rajeev Chowk, IFFCO Chowk, Kadipur main bus stand, MDI Chowk, Sadar Bazar, Pataudi Road and others.

Discom staff to wear black bands in stir against privatisation

Gurgaon. GMDA is planning to develop a new bus terminal in Sector 29 to strengthen the city's public transport infrastructure and provide better connectivity for commuters. The metropolitan authority might discuss the matter in the upcoming meeting with the Haryana chief secretary this week.

Around three acres of land have been identified for the project. The land, however, currently lies with the transport department, and the metropolitan authority is now seeking its transfer to proceed with its plan. If GMDA has its way, the bus terminal will be built near Millennium City Centre metro station, which is expected to benefit daily commuters by offering easy access between buses and metro. Moreover, another metro station is also being planned near the existing one as part of the city's metro expansion. The proposed terminal will accommodate up to 50 buses at a time and will also have charging stations to support the operation of e-buses. A senior GMDA official said they sought



UP set to build Dudheswar Nath temple corridor for yatra ease

Ghaziabad. On the backburner for nearly three years, UP govt has initiated a survey to expedite work on the Dudheswar Nath temple corridor on the lines of Varanasi's Kashi Vishwanath temple project.

he corridor is proposed to have a 70m entrance gate, an internal pathway and zoning for better organisation. Located in one of the most populous areas of the Old City, the temple draws lakhs of devotees during the annual kanwar yatra. It leaves the already overcrowded lanes leading to the temple complex in the throes of intense traffic congestion. Currently, the boundary wall of the temple is defaced with various posters, while autos, e-rickshaws, roadside vendors and stray cattle eat into every inch of the road. Overhead wires – utility poles threaded together by thick power cables - are a common sight too. 'The proposal is to develop a comprehensive development plan to restore the Dudeshwar Nath temple complex's significance as a major

spiritual destination. The survey of the complex will focus on creating dedicated zones improving

spiritual destination. The survey of the complex will focus on creating dedicated zones, improving connectivity and infrastructure, and removing squatters," said an official from the district administration. "The temple can be accessed from GT Road on one side and Vijay Nagar on the other. These roads and bylanes are to be widened as per the proposal," the official added. According to the proposal, Rs 2.2 crore will be spent on the development of the entrance gate,

which is a good 70 metres from the temple. The estimated cost for the development of the internal pathway leading to the temple will be Rs 58.2 lakh, while Rs 24.7 lakh will be spent on murals. Facade lighting of the temple will come up at a cost of Rs 1.2 crore. The final estimates are to be drawn up once the survey is completed.

Garbage finds new home in city: Dwarka Eway

Gurgaon. Less than a year since its inauguration, the eight-lane Dwarka Expressway is lined with heaps of garbage being dumped along the high-speed corridor illegally. The matter was raised by the National Highways Authority of India (NHAI), which last week wrote to MCG, seeking urgent intervention by the corporation to clear up garbage dumps along the expressway.

NHAI said in the letter that the right of way (ROW) along the expressway had turned into a dumping ground, and local bodies and street vendors were adding to the mess. Despite deploying additional teams to maintain cleanliness, NHAI said, the situation has become unmanageable for them.ROW is open area along the carriageways, and is kept for maintenance and providing related road infrastructure."This constant dumping undermines efforts to maintain cleanliness along the expressway, affecting its usability and aesthetic appeal. Moreover, it further compounds issues of choked drains and the presence of stray animals along the corridor, creating a road safety hazard," an NHAI official told TOI on Monday, adding that

the expressway was an infrastructure project of national importance.



The waste problem isn't new. NHAI had flagged similar concerns earlier this July about waste falling off uncovered and overloaded trucks onto the expressway.

The 18.7km Gurgaon section of the Rs 9,000-crore expressway was inaugurated by Prime Minister Narendra Modi in March this year, almost 18 years after Haryana govt conceived the idea of building a link road between Delhi and Gurgaon.MCG, asked about NHAI's

concern, assured action. "We will activate enforcement in the area to keep a check on illegal dumping of waste along the expressway. These dumps are because of illegal waste vendors operating in the area," said MCG commissioner, Ashok Kumar Garg.Residents of new sectors along the expressway said waste dumping reflected a systematic failure of authorities in managing garbage.

"It is ironic that a world-class infrastructure project is flanked by piles of garbage. While this area is still developing, the lack of proper enforcement and waste management is creating a mess," said Prakhar Sahay, convener of the Dwarka Expressway Gurugram Development Association. He also pointed out that illegal scrap businesses were mushrooming in the area. "These businesses operate without oversight, adding to the chaos," he said.

Earlier this year, Haryana govt declared solid waste exigency in Gurgaon and formed a panel to specifically implement what it called SWEEP -- Solid Waste Environment Exigency Programme.

Since then, more panels have been formed in the city to monitor its garbage crisis, which is alwayslooking to annex more areas. Still, residents say

waste collection from their homes is erratic and the corporation is struggling to scale up capacity to clear Bandhwari landfill, where all of the city's civic waste is dumped.Sunil Sareen, a resident of Sector 102, said waste dumping is polluting the area along the expressway. In A First, Israel's PM Set To Testify In Bribery, Corruption Trial

World Israeli Prime Minister Benjamin Netanyahu is set to testify on Tuesday in his bribery, fraud, and breach of trust trial. The hearing will begin in an underground room at the Tel Aviv District Court, moved from Jerusalem due to security concerns. Netanyahu is expected to testify three times a week for at least two weeks, according to local reports. This is the first time a sitting Israeli PM has been charged with a crime, IANS reported citing Xinhua news

The trial began in early 2020 and involves three cases against Netanyahu. He is accused of bribery, fraud, and breach of trust. Netanyahu, Israel's longestserving prime minister, denies the charges. He claims the trial is a politically driven 'witch hunt.' On November 24, the court partially granted Netanyahu's legal team a 15-day postponement for his testimony. However, it dismissed a recent plea for a delay from 12 ministers in Netanyahu's cabinet. The trial was earlier paused for over two-months due to Israel-Hamas conflict. If convicted, Netanyahu could face severe penalties, including jail time. This would make him the first sitting Israeli prime minister to be sentenced for criminal charges.

Netanyahu's trial is further complicated by ICC arrest warrants issued in November. The warrants, targeting him and former Defence Minister Yoav Gallant, accuse them of "crimes against humanity and war crimes" committed between October 8, 2023, and

4-day workweek in Tokyo from next year: Is population decline reshaping Japan's workforce

World The Tokyo administration found a new way to address the country's low birth rates and that is to implement a four-day workweek scheme for its staff. Tokyo's Governor Yuriko Koike has declared that from April onwards, metropolitan government staff will have the choice of a three-day off each week.

"We will review work styles ... with flexibility, ensuring no one has to give up their career due to life events such as childbirth or child care," she stated during her policy address at the Tokyo Metropolitan Assembly's fourth regular session, NBC news reported. This initiative aims to encourage procreation amongst Japanese couples, as the country's fertility rate has reached an unprecedented low. According to the Ministry of Health, Labor and Welfare, last year's rate fell to 1.2 children per woman during her reproductive years, despite increased governmental efforts to promote family formation. Population stability requires a minimum rate of 2.1.Koike introduced an additional measure allowing parents of elementary school pupils to reduce their working hours in exchange for a proportional salary adjustment.

'Now is the time for Tokyo to take the initiative to protect and enhance the lives, livelihoods and economy of our people during these challenging times for the nation," she declared.

Japan registered only 727,277 births last year, as reported by the Health, Labor and Welfare Ministry. This low figure may be attributed to the country's overtime work culture, which often forces women to choose between professional advancement and motherhood.

Asked at Monday's arraignment whether he needed a public defender, Mangione asked whether he could "answer that at a future date." Mangione was arrested in Altoona, Pennsylvania, after the McDonald's customer recognized him and notified an employee, authorities said. Police in Altoona, about 233 miles (375 kilometers) west of New York City, were soon summoned. They arrived to find Mangione sitting at a table in the back of the restaurant, wearing a blue medical mask and looking at a laptop, according to a Pennsylvania police criminal complaint.

He initially gave them a fake ID, but when an officer asked Mangione whether he'd been to New York recently, he "became quiet and started to shake," the complaint says.

Benjamin Netanyahu said Monday that the Golan Heights, occupied by Israel for almost 60 years, would remain Israeli "for eternity". Speaking at a press conference in Jerusalem, Netanyahu thanked US President-

elect Donald Trump for recognising Israel's 1981 annexation of the territory during his first term and said "the Golan will be part of the State of Israel for eternity." Israel's Foreign Minister Gideon Saar said Monday that his country's military takeover of the buffer zone along its border with Syria was a temporary move, after Islamist-led rebels took control in Syria.

'This is a limited and temporary step we took for security reasons," Saar said in a press conference at the foreign ministry in Jerusalem.Israeli Prime Minister Benjamin Netanyahu announced on Sunday that he had ordered the army to "take control" of the zone -- on the east of the Israeliannexed Golan -- after the fall of Syrian president Bashar Al-Assad the same day.Saar and an Israeli government spokesman both confirmed that Israeli troops had moved beyond the demarcated buffer zone onto the slopes

JERUSALEM. Israeli Prime Minister Israeli troops that have moved into the buffer zone on the edge of the Israeliannexed Golan Heights "constitute a violation" of the 1974 disengagement agreement between Israel and Syria, a UN spokesman said Monday.

The UN peacekeeping force deployed in the Golan Heights, known as UNDOF, "informed the Israeli counterparts that these actions would constitute a violation of the 1974 disengagement agreement," said Stephane Dujarric, spokesman for Secretary-General Antonio Guterres.He said that the Israeli forces that entered the zone were still present in at least three locations. Israeli Prime Minister Benjamin

Netanyahu announced on Sunday he had ordered the army to "seize" the demilitarized zone in the Syriancontrolled part of the Golan Heights after rebels swept Syrian president Bashar al-Assad from power.

Most of the Golan Heights plateau has been occupied since 1967 by Israel,

which later annexed it in a move not recognized by most of the international community.In 1974 a buffer zone was established to separate the Israeli-held and Syrian territories, with UN peacekeepers stationed there. Amid the downfall of Assad, Israel announced a troop deployment to the Golan Heights citing "the possible entry of armed individuals into the buffer zone."Israeli

forces "will continue to operate as long as necessary in order to preserve the buffer zone and defend Israel," it added.Israeli troops "have entered the area of separation and have been moving within that area where they remain in at least three locations throughout the area of separation," Dujarric said."There should be no military forces or activities in the area of separation. And Israel and Syria must continue to uphold the terms of that 1974 agreement, and preserve stability in the Golan," he said.

French President Macron eyes broad alliance to form new government

PARIS. French President Emmanuel Macron on Monday called cross-party talks aimed at "forming or making possible a government of national interest" after the ouster of Prime Minister Michel Barnier triggered a political crisis. Party leaders were invited to Macron's Elysee Palace office on Tuesday, the presidency said, in a departure from Macron's previous method of meeting leaders individually.

France's parliament has been divided almost evenly between a left alliance, Macron's centrists and the far right since snap elections in July, producing deadlock.

The president took almost two months to name conservative Barnier as premier in September. But the PM was toppled last week in a no-confidence vote over a cost-cutting draft budget for 2025 meant to tackle France's yawning deficit. Macron's office said that only those who had "shown they placed themselves in a framework of compromise" had been called upon for Tuesday's talks -- appearing to exclude the far-right National Rally (RN) and hard-left France Unbowed (LFI). Cobbling together any compromise between centre-left, centrists and conservatives will be tricky as all have been clashing fiercely since Macron's first presidential win in 2017.

Initial talks would aim "to make progress on an agreement about the method" to find consensus, the Elysee said. Macron's call for a broad-based meeting suggests a new executive will not be put together quickly, disappointing calls to move fast from allies including parliament speaker Yael Braun-Pivet.

"Each of us will have to take a step towards the other," Green Party chief Marine Tondelier had said earlier Monday as she arrived for talks with Macron -- adding that it was up to the president "to offer something that isn't just a continuation of his policies".

Some have called for Macron, 46, to himself resign and trigger a new presidential poll.

But a defiant Macron last week said that he planned to serve out the remainder of his term, vowing to produce "30 months of useful action" and promising to name a new prime minister in the "coming days."The weekend reopening of Paris's Notre Dame cathedral, refurbished after a devastating 2019 fire, offered a brief respite from the political crisis as he hosted world leaders including US president-elect Donald Trump and Ukrainian President Volodymyr Zelensky.Macron is now under huge pressure to form a government that can survive a no-confidence vote and pass a budget for next year in a bid to limit political and economic turmoil.

Ex-Assad Regime Syrian Officials Indicted In US For War Crimes Against Americans

World A US federal indictment has charged two former senior Syrian intelligence officials from the regime of former President Bashar al-Assad with "war crimes against Americans and other civilians," the Department of Justice announced. The indictment accuses Jamil Hassan, 72, and Abdul Salam Mahmoud, 65, of conspiring to commit war crimes by subjecting detainees, including US citizens, to cruel and inhuman treatment at detention facilities such as the Mezzeh Military Airport prison near Damascus, according to the justice department. Warrants for their arrest have been issued, though both remain at large, the statement read on Monday. The perpetrators of the Assad regime's atrocities against American citizens and other civilians during the Syrian civil war must answer for their heinous crimes," Attorney General Merrick

982 male health assistants terminated after HC verdict

VIJAYAWADA. A total of 982 Multi-Purpose Health Assistants (MPHAs-Male) were terminated from service by District Medical and Health Officers (DMHOs) across Andhra Pradesh after the High Court's final judgment in a decades-long legal dispute.Addressing the media persons on Monday at Secretariat, Special Chief Secretary (HM&FW) M.T. Krishna Babu informed that the recruitment process for 2.324 MPHA (Male) vacancies, initiated in 2002 for the combined state of Andhra Pradesh, faced prolonged litigation over qualifying criteria. The original notification specified SSC with a one-year MPHA (M) training as the qualification. However, interim court orders allowed recruitment based on Intermediate qualifications, leading to inconsistencies and numerous legal challenges.

The Supreme Court, in 2011, upheld SSC as the required qualification, prompting the termination of 1,200 MPHAs recruited with Intermediate qualifications. However, these candidates were reappointed in 2013 under GO Rt. No. 1207 after serving for nearly nine years, which sparked further litigation.

In its latest verdict on November 29, 2024, the High Court deemed the reappointments under GO 1207 as backdoor entries and dismissed WP No. 38060/2013, invalidating the recruitment of an additional 216 MPHAs. Consequently, 766 MPHAs recruited under GO 1207 and 216 appointed through interim court orders were terminated. Special Chief Secretary (HM&FW) M.T. Krishna Babu noted that this judgment resolves a 22-year legal battle involving 299 writ petitions and contempt cases. He highlighted the complexities caused by conflicting court orders and the significant administrative resources spent on the issue. The High Court acknowledged the long tenure of terminated employees but upheld the legal principle of adhering to recruitment norms. The government has now complied with the judgment, marking a decisive end to one of the most protracted recruitment disputes in Andhra Pradesh's history, he added.

Police conduct raids at 18 spas in Guntur, 10 women rescued

Speaking to TNIE, ASP Supraja explained that under the instructions of Guntur district SP Sathish Kumar, special teams -- comprising DSPs, CIs, SIs, and women constables -- identified unlawful activities at a spa in Lakshmipuram. The owner of the spa, manager and three customers were arrested for indulging in illegal activities and flesh trade. The police also rescued 10 victims.

One of the spas where inspection was conducted has been sealed. Cases have been booked under relevant sections. Pattabhipuram police are investigating whether the spa centres have permissions and licenses to operate. While some of the employees were reportedly from Thailand, few others hailed from various parts of the State. The women employees were shifted to rescue homes. According to sources, as many as four women from Thailand were working in another spa where raids were conducted. However, the police did not file any case against them as there was no evidence that they were involved in illegal activities. During the raids, cops observed that majority of the spa owners in the city were operating their businesses without permissions. Stating that more raids will be conducted, ASP Supraja warned of severe action if owners are found to be indulging in

COIMBATORE. Over 30,000 sanitary workers who clean toilets in government schools in rural areas across the state have not been paid salary for more than six months in this academic year allegedly because the department of Rural Development and Panchayat Raj stopped releasing funds. When asked about it, director of Rural Development and Panchayat Raj P Ponniah said that the directorate has taken steps to release the funds soon.

Spell out plan to tackle pollution at Thamirabarani origin point: Madurai Bench of Madras HC

MADURAI. Shocked with the findings that the Thamirabarani is polluted even at the source at Agasthiyar Falls, the Madurai Bench of the Madras High Court on Monday told officials to inspect and file a report on the causes of pollution, and sought an action plan to eradicate or prevent the same. The court issued the directions to the deputy director of forests, Kalakkad Mundanthurai Tiger Reserve, the joint chief environmental engineer of the Tamil Nadu Pollution Control Board (TNPCB) and the Tirunelveli collector.

A special bench of Justices GR Swaminathan and B Pugalendhi further directed additional advocate general Veera Kathiravan to obtain instructions on whether the state government has any proposal to call upon the Ministry of Jal Shakti to seek funds for the rejuvenation of the Thamirabarani. The directions were issued on a batch of petitions, including a contempt petition, filed by one S Kamaraj alias Muthalakurichi Kamaraj,



alleging that sewage water flows into the Thamirabarani. The main petition was already disposed of by the court in March this year, by issuing a series of directions to various listed periodically for reporting compliance. In the previous hearing, the judges mentioned the findings of their inspection of the river on November 10, and sought a report from the collector and corporation commissioner on

NIA court orders Viyyur prison in Kerala to keep cells unlocked for three hours daily

The court observed that being an inmate in a high-security facility does not justify the denial of basic rights afforded to prisoners in other jails.

Investigation Agency (NIA) court in Kochi has directed the authorities at Vivyur High-Security Prison, where individuals accused in terrorism-related cases are detained, to keep the cells unlocked for three hours a day. The order comes in response to a petition filed by Mohammed Azarudeen, the prime accused in the 2019 ISIS Coimbatore module case. Azarudeen had alleged that under-trial prisoners detained under the Unlawful Activities (Prevention) Act

(UAPA) were being kept in solitary confinement for 24 hours a day, which he argued violated Kerala Prison Rules. Azarudeen claimed he had orally raised the issue with the jail superintendent but received no response. He described the conditions



intervention to end the practice.In response, the court instructed the jail authorities to submit a report. The superintendent's report stated that individuals accused in terrorism cases were remanded by the Special Court and placed in High-Security Prisons under special departmental orders. as inhumane and sought the court's According to the report, the jail houses 225 inmates, including 13 linked to Maoist groups, 14 with suspected ties to the Popular Front of India (PFI), 19 accused in other NIA cases, and others detained under the Kerala Anti-Social Activities Prevention Act (KAAPA). For security reasons, the prison has a policy of not allowing inmates to interact freely. Cells are unlocked in rotation from 6:30 am to 5:30 pm. Inmates can engage in recreational activities such as badminton and volleyball for one hour daily.

Waqf, Panchamasali quota issues rock Houses

BELAGAVI. Both Houses witnessed heated debates on the Waqf issue and the demand to increase reservations for the Panchamasali Lingayat community on Monday. As soon as the session began, MLAs from the ruling and opposition parties traded accusations and blamed each other over the demand for increasing reservations for Panchamasalis, Assembly Speaker U.T. Khader adjourned the House for an hour.

The Upper House also witnessed noisy scenes during the debate on the demand for more quotas for Panchamasalis. Chairman Basavaraj Horatti adjourned the House temporarily as his efforts to pacify the irate members failed. Given the first day's developments, both Houses are likely to witness heated debates on Tuesday as well.According to sources in the BJP, their legislators are prepared to target the ruling

Congress over the Waqf issue when it comes up for discussion, particularly in the Lower House.In the Council, the discussion on the Waqf issue was allowed under Rule 68 after opposition members appealed to Horatti, stating that many landowners, particularly farmers, had been affected by the Waqf Board's notices claiming rights over their lands. Leader of Opposition in the Council, Chalavadi Narayanaswamy, claimed that landowners, especially farmers, were living in fear of losing their lands. He alleged that the problem started when the then-Prime Minister Jawaharlal Nehru gave unchecked powers to the Waqf Boards.

Congress MLC B.K. Hariprasad countered this claim, stating that the law was initially framed during British rule in 1913 and came into force in 1923. "Don't mislead people by



suggesting the Act was formulated by the Congress government," he said.Rural Development and Panchayat Raj (RDPR) Minister Priyank Kharge accused BJP legislators of spreading false information on the Waqf issue. Ministers Dinesh Gundu Rao and Kharge, along with other Congress

MLCs, presented documents showing that several notices had been issued to farmers and other landowners by the Waqf Board during the BJP's rule.

The House descended into chaos when BJP MLC C.T. Ravi alleged that the UPA government had amended the Waqf Act, granting unchecked powers to the Waqf Boards.Congress MLC B.K. Hariprasad raised a point of order, objecting to Ravi's statement and asserting that no such amendment was made by the UPA government. Congress MLCs Abdul Jabbar and Nasir Ahmed challenged Ravi, stating they would resign if he proved his claim. "If you don't prove it, you should resign," Nasir told Ravi. Deputy Chairperson M.K. Pranesh attempted to restore order but was unsuccessful. Eventually, the House was adjourned for the day.

Opacity continues to afflict India-China relationship

A comprehensive White Paper that builds on the External Affairs Minister's detailed statement in Parliament would be a much-needed first step.

The positive tenor in the post-Galwan India-China relationship was enabled by a brief meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping on the sidelines of the BRICS Summit in Kazan, Russia, in late October. It received considerable official comment and caused parliamentary discord in early December.

External Affairs Minister (EAM) S Jaishankar made a detailed statement in Parliament on December 3. He traced the history of the unresolved territorial-cumborder issue from 1958 right up to the most recent thaw in the relationship at Kazan in a lucid, albeit selective, manner. He unequivocally stated: "We are clear that the maintenance of peace and tranquillity

in border areas is a prerequisite for the development of our ties. In the coming days, we will be discussing both deescalation as well as effective management of our activities in the border areas."Regrettably, the EAM's statement resulted in the Opposition members staging a walkout, since a discussion was not allowed. This legislative discord was avoidable. The EAM's statement was followed by the 32nd meeting of the Working Mechanism for Consultation and Coordination (WMCC) on India-China Border Affairs in Delhi on December 5 between officials from both countries.

The Ministry of External Affairs' (MEA) readout regarding the outcome of the WMCC meeting was brief and intriguing. The most significant assertion is the line that reads: "The two sides positively affirmed the implementation of the most recent disengagement agreement which completed the resolution of the issues that emerged in 2020."Does this imply

that the disengagement process is complete and that the seemingly intractable issues, which emerged in 2020 (the Galwan setback), have reached satisfactory resolution? The second question is whether the use of the word 'agreement' has been accepted by the Chinese side and if this is a reference to a written document or is the agreement an oral understanding?

After the initial fumble and obfuscation that took place in the immediate aftermath of the Galwan clash in June 2020 (the statement by PM Modi that there was no intrusion) — the Indian position gradually crystallised with two major objectives. One, that there has to be a return to the April 2020 status quo as regards the patrolling protocols along the Line of Actual Control (LAC); and two, that all agreements signed between India and China regarding the unresolved territorial/border issue would be respected.An objective review of the tactical situation after the Galwan incident revealed that India had forfeited certain patrolling rights along the LAC in Ladakh. Furthermore, concerns were voiced that buffer zones were being created along the LAC, which would inhibit both Indian patrolling and grazing rights that existed in April 2020. Was this a case of China imposing a 'new normal' along the LAC? The most recent official statements do not India's first Prime Minister Jawaharlal Nehru was at



shed any light on these issues. One presumes that they will be addressed by the Special Representatives at their next meeting later this month. Dissonance in the MEA statements was highlighted by Ashok Kantha, former Ambassador to China, in a series of tweets on social media. He added: "The MEA statement that 'all issues that emerged in 2020' have been resolved is baffling to someone who was a border negotiator with China for nearly a decade." This is a welcome intervention in the public domain by an astute China expert. Hopefully, the statements from the MEA will be harmonised with the final military objective that was reiterated by Army Chief Gen Upendra


Dwivedi, who noted (on October 23) that both armies need to restore trust and "go back to the status quo of April 2020". The MEA statement after the WMCC talks also noted: "Both sides reviewed the situation in border areas, and reflected on the lessons learnt from the events of 2020 in order to prevent their recurrence."The reference to 'reflecting' on lessons learnt warrants a zoom out for Delhi, which has been grappling with this unresolved border problem for well over 65 years. India was surprised by the October 1962 Chinese attack and the limited border war that ensued; and much the same pattern unspooled in June 2020 at Galwan.

the helm in October 1962. There were many defence policy blunders and omissions on his part. Yet, Nehru did not prevent the debacle from being discussed in Parliament. A few Opposition MPs, including a young Atal Bihari Vajpayee, sought a special session of Parliament. This was held on November 8 — when the war was still being prosecuted and India was on the defensive. And when it was suggested that this be a 'secret session', Nehru rejected the proposal, stating that the issues before the House were of "high interest to the whole country".On December 10, 1962, a full session was devoted to the Chinese invasion in the Lok Sabha; the comprehensive proceedings have been recorded in 145 pages. Yet, even Nehru was reluctant to let the Henderson Brooks report (which was tasked with reviewing the military lapses of the October 1962 war) from being placed in the public domain. This opacity continues to plague the post-Galwan period of the troubled India-

China relationship. Tensions between the two Asian giants have been festering for decades. Complex geopolitical factors and domestic political compulsions on both sides have further exacerbated the situation. Sunlight is often the best disinfectant, and ensuring transparency about what has transpired would be highly desirable. Democratic India would be better served by allowing this vital national security issue to be discussed both in Parliament and the media. A comprehensive White Paper on the India-China relationship that builds on the EAM's detailed statement in Parliament would be a muchneeded first step.

Rumblings in INDIA

Opposition alliance faces leadership crisis



Pawar, who has called her a "prominent leader" of the nation.It's apparent that Rahul Gandhi, Leader of the



Opposition in the Lok Sabha, is losing ground as the face of INDIA. There are three Gandhis in Parliament nowwith Priyanka being the latest entrant — but this dynastic

milestone has not enthused the Congress' allies. Though party president Mallikarjun Kharge is also the chairperson of the bloc, it is no secret that the Gandhi family is calling the shots. But this arrangement is strengthening neither the Congress nor INDIA.

The Congress has no option but to pay heed to its partners. Overconfidence cost it dear in Haryana, where it chose to give short shrift to fellow INDIA members. Uddhav Thackeray's Shiv Sena has not helped matters by hailing those who demolished the Babri Masjid, triggering a backlash from the Samajwadi Party, which has a sizeable Muslim vote bank in Uttar Pradesh. Mutual respect and accommodation must be the way

forward if the bloc has to remain intact. Otherwise, this alliance might implode sooner or later, leaving the field open for the BJP and PM Modi.

The cost of GST & fiscal crises in states

If the Indian Union has to be protected, evidence suggests that the GST 'experiment' must be abandoned.

MORE than seven years since its introduction, the Goods and Services Tax (GST) regime, hailed as a game-changing innovation at the time of its launch, is still being sustained with hype. From the point of view of performance, the regime, while not yielding the revenue gains its "efficiency" was supposed to deliver, is proving to be the final factor driving most state governments to bankruptcy. The Central Government has sought to conceal this reality by reporting the nominal values of GST collections every month and comparing them with the previous month or the corresponding month of the previous year.It is to be expected that so long as the GDP growth is positive, revenues from taxation, especially indirect taxation, are likely to increase in nominal terms. But even this "natural" trend has been broken by multiple monthly figures that point to a lower yield of revenues than in past periods chosen for comparison.

To make up for that bad news, the Centre has tended to make much of those months when nominal or current price figures are higher than in the past, advertising "record" collections in hyped press releases. A sober and reasoned assessment points to the following: If we exclude the period from the GST's inception in August 2017 till March 2022, allowing sufficient time for the system to have overcome its "teething troubles", we have net collections of Rs 880 billion in April 2022. Between that month and October 2024 — a period of 31 months — there have been only three months when the aggregate figure exceeded that sum. These, too, are 'nominal' receipts. Besides the growth of the economy, another reason why receipts from taxation should rise because of inherent "buoyancy" is the impact of inflation. It takes more money for a government to do the same thing when the prices are higher. The trend rate of monthly growth in receipts from the GST between April 2022 and October 2024 was just 0.86 per cent. Adjust for inflation, and the growth rate of "real" receipts falls to exactly half of that: 0.43 per cent. That is near-stagnation. This has hit the state governments particularly hard because they are the ones who ceded a substantial share of their taxation rights to the GST Council, which is dominated by the Centre. With the shift to the GST, the share of state taxes that were subsumed under the new tax regime (44 per cent) was much larger than that of the Central taxes (28 per cent).

The loss of that revenue stream occurred during a period in which the Centre had squeezed the volume of its own receipts that it devolved to the states. It did that by relying increasingly on imposts that are not included in the divisible pool of resources to be shared with states based on the recommendations of the Finance Commission. The most egregious instance of this is the reliance on surcharges and cesses that are not shareable. The share of surcharges and cesses to Gross Tax Revenue of the Centre, which was 9.5 per cent in 2013-14, rose to 14.8 per cent in 2023-24 (it was as high as 20.5 per cent in 2020-21). The other factor inflicting losses on the states is the large direct tax concessions given

to friends in the corporate sector by the Centre, which reduces the size of the divisible pool. The question does arise as to why the states agreed to cede their taxation rights and reduce their own fiscal



autonomy. One reason was their own embrace of the neoliberal ideology. Value-Added Tax (VAT), to which species the GST belongs, is the preferred means of taxation in neoliberal environments that privilege corporate profits (with lower taxes) and mobilise revenue through indirect taxes like VAT, the burden of which falls disproportionately on the poor and middle classes. This "regressive" character is sought to be papered over by claiming that these taxes are more "efficient". In India's case, that argument was fortified by the claim that a system that "harmonised" taxes across states was also efficient. Why states at different levels of development and very different economic structures should have the same structure of

taxation across commodities is, of course, not addressed.Based on such arguments, it was projected that the GST regime would not just be "revenue-neutral", but also, in fact, deliver

substantial increases in revenues. The states bought into this spurious argument. In fact, they were also cajoled into accepting the major shift in regime with the promise that in case revenues accruing to the states from the GST fell short of a level that reflected a 14 per cent annual increase relative to the pre-GST collections from taxes that were subsumed under the regime, they would be compensated by the Centre. That promise was for five years, by which time the "game-changing" GST was supposed to deliver on its promises. Those promises have been completely belied. The

annual average revenue realised from taxes subsumed under the GST from 2012-13 to 2016-17 is estimated at Rs 7.70 lakh crore. If that is taken as the base from which the 14 per cent growth in revenues from the GST is calculated, the actual collections reflect a significant shortfall relative to the 'promised' revenues. Not surprisingly, compensation for the shortfall financed with the compensation cess was crucial for the states.

But that came to an end after five years, much to the surprise of the states. They are now more than ever dependent on the patronage of the Centre for revenues that match the expenditures associated with the developmental responsibilities they constitutionally shoulder.

If children are allowed to go to school on their own either by walking or cycling, they are more likely to possess greater decision-making abilities as well as have better safety perception, finds a new study. Children who travel to school

without the assistance of elders are more likely to possess greater self-confidence, self-governing skills, decision-making abilities and improved perception about the safety of the route.

In addition, active commuting such as walking or cycling can foster a healthy lifestyle in these kids.

"This increases physical activity and cardiovascular health in children that commute actively, especially in those that go cycling," said Manuel Herrador, researcher at the University of Granada in Spain.

Previous studies have also derived a link between active commuting and an enhancement in the cognitive skills and



academic performances.

Teen online friendships as valid as actual ones

Online contact enhances companionship between friends via conversations that can continue throughout the day and night without disrupting others and it also allows more time to control emotions.



Are you worried about your teenage child engaging in online activities with their friends? Stop worrying, as online friendships in teenagers are just as intimate and have similar characteristics as offline relationships.

Researchers have found that digital behaviours serve the same purpose and encompass the same core qualities as face-to-face relationships.

"Many contacts between adolescents are mediated through technology and can provide additional opportunities for friends to spend time together, share thoughts and display affection than in offline spaces alone," said Stephanie Reich, associate professor at the University of California, Irvine (UCI).

Reich, along with the lead author Joanna Yau,



identified six core characteristics of offline friendships — self-disclosure, validation, companionship, instrumental support, conflict and conflict resolution — and their digital parallels.

For each quality, they noted ways in which online interfaces corresponded with or differed from inperson communication.

They found digital exchanges offer more benefits

in some areas and carry increased risks in others. On the plus side, online contact enhances companionship between friends via conversations that can continue throughout the day and night without disrupting others and it also allows more time to control emotions and calm down before crafting and sending a response to something

Conversely friendships can be damaged by gossip and rumours, which spread much faster and farther through cyberspace.

Digital communication may increase the ramifications of conduct

due to the permanence of information and the speed at which it travels, but at the core, friendships seem to have the same key characteristics.

"The majority of adolescents interact electronically most often with individuals they consider friends offline. So rather than reducing intimacy in these relationships, technologymediated communication may provide additional benefits to teens as connections occur both face-toface and online." Reich added.

Developing resilience may help kids combat bullying

Resilient kids are those, who for a variety of reasons, are better able to withstand external pressures and setbacks and are less negatively impacted in their attitudes and actions than their less-equipped peers when facing this type of victimisation.

Ever wondered why bullying has a serious effect on some kids, while others recover easily from the trauma? Researchers, led by one of Indian origin, found that the capacity to recover quickly depends on the characteristic trait of "resilience".

The study says that resilience

buffers and protects the children against internalising the harm intended through situations of adversities like bullying both at home or school as well as online

"Resilience is a potent protective factor, both in preventing experience with bullying and mitigating its effect," said Sameer Hinduja,

Professor at the Florida Atlantic

University in Florida. "Resilient kids are those, who for a variety of reasons, are better able to withstand external pressures and setbacks and are less negatively impacted in their attitudes and actions than their less-equipped peers when facing this type of victimisation," Hinduja added.

Although, the ability to be resilient comes naturally, it needs to be nurtured through social and environmental factors. as it enables kids to "bounce back" and successfully adapt to stressful

situations, the researchers noted. The study, published in the journal Child Abuse and Neglect, stated that instead, of constantly seeking to protect and insulate children, parents should help bolster their self-confidence, problem-solving ability,

autonomy, and sense of purpose -



which are all innate strengths.

The researcher studied over 1,204 youth between 12-17 years by a validated biopsychosocial 10item resilience scale including various questions of tackling bullying and related stress.

The results demonstrated that students with higher levels of resilience were bullied at school or online less often.

Their experience with various forms of interpersonal peer harm also varied inversely with the students' self-reported level of

When SM Krishna abandoned Congress after 46 years, said party had no future

Veteran politician SM Krishna, who passed away on Tuesday, resigned from the Indian National Congress in 2017 after 46 years of association. Krishna, who is known as the 'Architect of Brand Bengaluru', said the Congress had no future and mentioned how he took the hard decision to protect his self-respect and dignity.

New Delhi. At 84, veteran Congressman SM Krishna faced a day unlike any other. It was the winter of 2017 and after 46 years with the Congress, he announced that he was severing ties with the party he had devoted his life to. It must have been a very tough decision to make, but Krishna was a man of self-respect and dignity who once served as Karnataka's Chief Minister and India's Foreign Minister. Known as the 'Architect of Brand Bengaluru', the visionary behind India's IT capital, left the Congress quietly, consulting no one but his wife. Seven years later, the leader who reshaped Karnataka and helped grow India's global footprint passed away in the early hours of Tuesday. He was 92.

"I have taken the decision, however painful, I am going out of the house with which I have been so familiar, including its doors and windows,' lamented Krishna in March 2017. SM Krishna's move was driven by a combination of factors, including the future of the party drifting and him being "sidelined" due to his age. The veteran politician was ready with his diagnosis for the party, but there was no one to hear him out.

Mindful of his "self-respect and dignity", SM Krishna did what he had to do -- he moved on.

"I have resigned from Congress to protect my selfrespect and dignity after serving it for 46 years, as the high command has sidelined me because of my age," an emotional 84-year-old Krishna told reporters."I did not consult anyone about leaving the party. And except my wife, I did not tell anyone that I was resigning from the party, though it is a painful moment in my life," he added in the 2017 press conference he had called with a heavy heart.

WHY SM KRISHNA LEFT CONGRESS, SAID **PARTY HAD NO FUTURE**

A day after SM Krishna resigned from the Congress, he lashed out at the party saying it didn't need mass leaders, but wanted only managers."The Congress doesn't need mass leaders these days, they only want managers who can handle a situation," he said. "I am not retiring from politics though I have quit Congress, as its future is not bright. Disillusionment with the party started from 2012 onwards. There is a way of getting rid of political leaders. The party should learn the art of being graceful. They (party leaders) could have told me I was not required. It would have been a graceful exit," added Krishna. "I toured the state during the last elections and nobody thought I was old. Suddenly, they have discovered that I am old and need rest. I felt the Congress did not need me".

Create more jobs instead of only providing free ration: Supreme Court to Centre

New Delhi. The Supreme Court on Monday (December 9), while hearing the matter pertaining to providing food under the Food Security Act, called on the Centre to focus on employment generation instead of only providing free ration to poor people.

The top court said that if the ongoing practice of providing ration at such a large level continues, the state governments may keep on issuing ration cards to appease the people, since they know that the liability to provide the grains rests with the Centre. "If the states were asked to provide free ration, many of them would say they cannot, citing financial crunch, and hence the focus should be on generating more employment," the

The court also questioned whether the states should be made to pay for the ration if they keep on issuing ration cards. The Centre's counsel, Solicitor General Tushar Mehta, apprised the court that the government provides free ration in the form of wheat and rice among other essential commodities to 80 crore poor people under the National Food Security Act 2013. However, petitioner Advocate Prashant Bhushan contended that, despite that, around 2 to 3 crore people have still been left from the scheme. The court was considering a plea highlighting the problems and the plight of migrant workers, where it had earlier directed that those eligible and entitled for ration cards/food grains under the NFSA and have been identified as such by the respective states/Union Territories, must be issued ration cards before November 19, 2024.

There was a heated exchange between SG Mehta and petitioner Bhushan during the court proceedings on Monday. While pointing out that the case was initiated by the Supreme Court back in 2020 due to the Covid pandemic, the Solicitor General remarked that Bhushan was trying to run the government and frame policies

Mahayuti cabinet expansion likely on December 14, big names may be dropped

New Delhi. After Chief Minister Devendra Fadnavis's government secured the trust vote in the Maharashtra Assembly on December 9, all eyes are now on the much-anticipated cabinet expansion of the Mahayuti alliance. The expansion is expected to be announced on December 14, ahead of the winter assembly session beginning December 16. Sources indicate that the National Democratic Alliance (NDA) central leadership is firm on maintaining a clean image for the new cabinet. There is a strong speculation that many heavyweight names in the last cabinet are likely to be nixed due to their bad performance and reputation, according to sources.

MINISTERS LIKELY TO BE DROPPED

The upcoming Mahayuti alliance cabinet expansion in Maharashtra is expected to exclude several current ministers due to their alleged poor performance or tarnished reputations. From the Shiv Sena (Eknath Shinde faction), three key ministers are likely to be dropped. Sanjay Rathod, who currently handles the FDA and Water Resources department, Abdul Sattar from the Minority and Marketing department, and Tanaji Sawant from the Health department are expected to lose their positions, according to sources.In the NCP (Ajit Pawar faction), Dilip Walse Patil (Co-operation department) and Hasan Mushrif (Medical Education department) are likely to be

The BJP may also see changes, with Suresh Khade (Labour department) and Vijaykumar Gavit (Adivasi Welfare department) expected to be dropped.

PROBABLE NEW MINISTERS The reshuffle is set to bring in several new faces across the three alliance partners, reflecting a focus on clean governance and fresh leadership. From the Shiv Sena, probable names include Uday Samant, Shamburaj Desai, Dada Bhuse, Gulabrao Patil, Sanjay Shirsat, Bharat Gogawale, Pratap Sarnaik, Ashish Jaiswal, Rajesh Khirsagar, and Arjun Khotkar. The NCP is likely to see prominent figures like Chhagan Bhujbal, Dhananjay Munde, Dharmarao Baba Atram, Aditi Tatkare, Sanjay Bansod, Narhari Zirwal, Datta Bharne, Anil Bhaidas Patil, and Makrand Aba Patil taking up ministerial roles.

Boy, 5, trapped in 150-foot-deep borewell in Rajasthan's Dausa, rescue ops on

A five-year-old boy fell into an open borewell in Rajasthan's Dausa district on Monday afternoon. The child is believed to be trapped at a depth of approximately 150 feet.

New Delhi. A large-scale rescue operation is ongoing in Rajasthan's Dausa district after a five-year-old boy fell into an open borewell. The incident occurred on Monday afternoon in Kalikhad village when the child, Aryan Meena, was accompanying his mother to a nearby field.

Aryan is believed to be trapped approximately 150 feet below the surface, officials said. Oxygen is being supplied to him through a pipe, and a camera has been inserted into the borewell to monitor his condition.

Asaduddin Owaisi's party fields 2020 Delhi riots accused for Assembly polls

-AIMIM announced that expelled AAP councillor Tahir Hussain will contest the upcoming Delhi elections from Mustafabad, despite his controversial past linked to the 2020 riots. The move drew sharp criticism from BJP's Kapil Mishra.

New Delhi. Asaduddin Owaisi's All India Majlis-e-Ittehad-ul-Muslimeen (AIMIM) announced the candidature of expelled AAP councillor Tahir Hussain from the Mustafabad constituency in the upcoming Delhi elections. Hussain had faced accusations related to the 2020 Delhi riots.

Owaisi confirmed the move, saying, "MCD Councillor Tahir Hussain joined AIMIM and will be our candidate from Mustafabad Assembly Constituency in the upcoming Delhi Vidhan Sabha elections. His family members and supporters met with me today and joined the party.'

The announcement was met with criticism from Kapil Mishra, a BJP leader, who said, "Owaisi has aligned himself with the man responsible for the murder of Ankit Sharma, the one whose house was found with bombs



and stones, and who attempted to kill hundreds of Hindus in Delhi. Owaisi should remember that if another riot happens in Delhi under Tahir Hussain's name, the consequences will be remembered by his seven generations.'

Hussain recently received relief from the Delhi High Court, which quashed an FIR against him in connection with the Delhi riots. The FIR, filed on February 27, 2020,

accused him of rioting and vandalism on the first floor of a building. The court noted that Hussain was already facing charges in another case related to the same incident.

The court observed that a prior FIR had been registered for the same incident on February 24, 2020. It stated that the chargesheet filed by the Delhi police in the present FIR would be treated as supplementary to the original case. Hussain had been elected as a councillor from the Nehru Nagar ward on an AAP ticket. During a November hearing, the court noted that evidence from both FIRs showed that rioters had first broken into a parking area, set vehicles on fire, and then moved to the first floor of the building, where food was being prepared for a wedding. The rioters caused significant damage to property.

Farming yields Rs 4,500 a month, less than what you'd splurge on a dinner date

Farmers in India aren't a pampered lot as they are perceived to be. A farming family ends up earning just Rs 4,500 a month from agriculture, according to a Nabard study. Even after resorting to all other avenues, including non-farm jobs, a farming household manages just Rs 13,600 a month.

New Delhi. While critics target tax-free income and 'flashy-big-vehicles' of farmers, suggesting they are affluent and a pampered lot, the reality for the majority of farmers in India is starkly different. A recent report by the National Bank for Agriculture and Rural Development (Nabard) has revealed that farmers in India are earning just Rs 4,476 a month from agriculture. The amount that farmers earn from farming would be less than what families spend on an evening out or thousands spend on a dinner date.

t needs to be understood that the farmers shown driving luxury vehicles in Punjabi songs are a fraction of the farming community. Millions of farmers in India are share-croppers with very little or no landholding. By just farming, they wouldn't be able to even manage their household.

While the average monthly income of a farming household, the Nabard survey revealed, is just Rs 13,661, it is left with a meagre Rs 1,951 in savings, equivalent to Rs 65 per day. As shocking as it may sound, income from agriculture made up just Rs 4,476, or 33% of the total monthly income, meaning farming households make less than Rs 150 per day just from cultivation of

The total earning of a farming household when all sources of income are considered work out to Rs 13,661 a month, which is Rs 445 a day. This is way lower than the government-mandated minimum wage for unskilled workers in India, which is Rs 783 per day.

Come to think of it, Rs 4,476 that a farming household makes wouldn't even suffice to pay for the education in most private schools in tier-I cities.In light of the Nabard report, let's have a look at what it reveals about the farmers' income and their wellbeing in India. Also, we would try to probe if all the farmers are this poor.



MUCH DO FARMING HOUSEHOLDS EARN? HOW MUCH IS FARMING CONTRIBUTING TO

According to the Nabard report, the average monthly income of a farming household from all sources in 2021-22 was only Rs 13,661, out of which Rs 11,710 was said to have been spent, leaving just Rs 1,951 as savings. What is most shocking is that earning from agriculture constituted just Rs 4,476 or 33% of the total monthly

income, meaning farming households earn less than Rs 150 per day from cultivation. The grim financial realities of farmers in India, as highlighted in the Nabard report, also underscore their reliance on alternative sources of income.

In the case of inadequate farming yields, the survey revealed that farmers depended on other sources such as animal husbandry (12%), wage labour (16%), government and private jobs (23%), and other enterprises (15%) to sustain their

livelihoods. Basically, to compliment the income from

farming, an average farming household relied on these avenues. It is no secret that most farmers with small landholdings work as labourers. The report also noted that the average monthly income of households of farmers increased during the five-year period from Rs 8,059 in 2016-17 to Rs 12,698 in 2021-22, an increase of nearly 57%.

Reliance eyes \$3 billion in India's largest loan deal since 2023: Report

NEW DELHI. Reliance Industries is in talks with several banks to secure a \$3 billion loan, reported news agency Bloomberg. The funds are intended to refinance debt that is due next year, as per sources mentioned in the report. The Indian conglomerate led by billionaire Mukesh Ambani is engaging with about half a dozen banks to finalise the loan, which is expected to be syndicated to the broader market in the first quarter of 2025. Discussions are ongoing, and the terms of the loan are yet to be confirmed. The final structure could change as negotiations progress, according to people cited in the report.

Reliance Industries has nearly \$2.9 billion in debt maturing in 2025, including interest payments, as per data compiled by Bloomberg. The company has not issued an official statement on the matter yet.

If the deal materialises, it will mark Reliance's re-entry into the offshore borrowing market after a gap since 2023. In that year, Reliance and its subsidiary, Reliance Jio Infocomm, raised over \$8 billion through loans. These facilities attracted approximately 55 lenders, as banks sought to participate in high-quality credit deals.

The current loan could be the largest borrowing by an Indian company since 2023. The loan comes at a time when the Indian rupee has been under pressure, recently hitting a record low against the US dollar. This decline has been driven by persistent outflows from Indian equity markets. Despite this, Reliance Industries' strong credit profile continues to make it a preferred borrower in global markets.Reliance Industries holds a credit rating that is one notch above India's sovereign grade, a distinction achieved by very few companies. Moody's recently reaffirmed Reliance's Baa2 rating, citing its solid credit metrics, which are expected to remain stable despite high capital expenditure.

The company's strong financial position and diversified business model make it one of the most reliable borrowers in India. Its businesses span energy, telecommunications, retail, and technology, contributing to its resilience and ability to secure large-scale funding.

Government may extend laptop, PC import deadline beyond Dec 31

NEW DELHI. The government is likely to extend the deadline of the import authorisation scheme for laptop and personal computers beyond December 31, 2024, said a senior government official.

According to officials, the Commerce Ministry is expected to issue a notification shortly to announce the extension. "The government is not looking to cause disruption — no disruption has been caused so far through import authorisation scheme," he said.India launched an import management system in November 2023, which required companies to register with the government the quantity and value of their laptop and tablet imports. Before this, on August 4, the government had announced ban on laptops, personal computers and tablets.

Later in the day, it had clarified that there was no ban but electronics manufacturing companies needed a licence or required to register on import management system to import these items starting November 1, 2023.he government said the purpose of the decision was to encourage the companies to start production in India. However, the reports indicate India reversed the laptop licensing policy following lobbying from US officials concerned about New Delhi's compliance with WTO obligations and potential new regulations. Then India extended the deadline for approving imports of servers, laptops, PCs and tablets from September 30 to December 31. It means, electronics companies like Dell, HP, Apple, Samsung and Lenovo will need to obtain fresh approvals to import laptops and tablets in India starting next year, as per a government notification. As per Counterpoint estimates, India's laptop and personal computer market is valued at \$8 billion annually.

VIL to raise Rs 1,980 cr through preferential issue

NEW DELHI. Vodafone Idea (VIL), the country's third-largest telecom service provider, announced on Monday that its Board of Directors has approved the issuance of up to 176 crore equity shares on a preferential basis to raise Rs 1,980 crore.

The telco will issue these shares to Omega Telecom Holdings Private Limited (Rs 1,280 crore) and Usha Martin Telematics Limited (Rs 700 crore), both Vodafone Group companies. The shares will be issued at a price of Rs 11.28 per share, which represents a premium of nearly 40% over the closing price of Rs 8.11 on December 9, 2024.

'Up to 1,755,319,148 equity shares of face value of Rs



10 each at an issue price of Rs 11.28 per equity share (including a premium of Rs 1.28 per equity share) for an aggregate consideration of up to Rs 1,980 crore," said the company in a stock exchange filing. Vodafone Group holds a 22.56% stake in VIL, while the Aditya Birla Group holds 14.76%. The government is the largest shareholder with a 23.15% stake. The telco will convene an extraordinary general meeting to seek shareholder approval for the preferential issue. Last week, the parent company of VIL, Vodafone Group, announced sale of its remaining 3% stake in Indus Towers for over \$300 million (approximately Rs 2,540 cr) in a block deal.

The share price opened at Rs 385, higher than its previous close of Rs 368.10. It climbed as much as 9.8% during intraday trading, touching a record high of Rs 404.

By 10:30 am, ITI shares were trading 7.42% higher at Rs 395.40 per share on the NSE.ITI shares have been on an exceptional run, gaining 15% in Monday's session and over 13% the day before. Over the last three days, the



stock has risen approximately 42% becoming a standout performer in the market. This sharp rally follows months of gradual recovery. ITI hit its 52-week low of Rs 210 on 25 October this year but has since experienced significant

gains. With the stock touching Rs 404 today, it has surged over 92% in less than two months.

The ITI stock has seen significant growth recently. On a monthly basis, it has surged by 38% in December, building on a 27% rise in November. This upward trend in November ended a threemonth losing streak for the stock.

Looking at its performance over a longer period, ITI shares have climbed 34% over the past six months. Over the last three years, the stock has delivered an impressive gain of 235%, highlighting its strong long-term

Boeing layoffs: Hundreds in Washington and California face job losses

New Delhi. Boeing, one of the world's largest aerospace companies, has laid off hundreds of workers in Washington state and California as part of a larger plan to reduce its workforce, reported news agency Associated Press. These layoffs are part of Boeing's efforts to manage financial challenges and align with its operational priorities.

The report mentioned that nearly 400 employees in Washington state and more than 500 in California were let go. This is part of a larger reduction that aims to cut around 17,000 jobs from Boeing's global workforce. Boeing had previously announced its intention to reduce its workforce by 10% in the coming months. This decision is part of the company's recovery strategy, which includes managing the financial and operational setbacks it has faced in recent years. The company is working to restore production of its popular 737 MAX aircraft, which was disrupted by a nearly two-month strike involving over 33,000 West Coast workers. While the strike impacted the production of most of Boeing's commercial aircraft, CEO Kelly Ortberg said that the layoffs were not caused by the strike. Instead, they were attributed to overstaffing in various roles.

IMPACT ON EMPLOYEES

The recent round of layoffs affected a range of positions, including engineers, recruiters, and analysts. These cuts have affected Boeing's commercial, defence, and global services divisions. Notices of the layoffs were filed with state employment agencies, with the first round reportedly impacting around 3,500 employees nationwide.Boeing has assured that most laid-off employees will remain on the payroll for about two months. In addition, they will receive severance pay, career transition assistance, and subsidised health insurance benefits for up to three months." As announced in early October, we are adjusting our workforce levels to align with our financial reality and a more focused set of priorities," Boeing spokespeople said in a statement. The layoffs come as Boeing continues to face financial difficulties stemming from multiple crises. The company's troubles began with two fatal crashes of its 737 MAX jetliner in 2018 and 2019, which claimed 346 lives and led to the aircraft being grounded support its operations and recovery plans.

Alpha Wave Global, formerly Falcon Edge and a Tiger Global Management spinoff, has submitted a binding proposal to acquire a portion of Haldiram Snacks Food, India's premier snack and convenience foods manufacturer. According to informed sources, this transaction could rank amongst India's largest private-equity deals.Last week, two additional investor groups submitted firm offers for a 15% to 20% stake in Haldiram. The first consortium comprises Blackstone, GIC of Singapore and ADIA, whilst the second features Bain Capital partnering with Temasek. The US-based investment firm has joined these competing groups.

Sources told ET that the bidders have assessed the enterprise value between Rs 75,000-Rs 80,000 crore (\$8.8 billion -\$9.4 billion).

The Blackstone and Bain-led groups have separately engaged in periodic discussions with the Agarwal family, the founding promoters, for approximately a table of approximately 25% or management rights that would ensure been considering various strategic alternatives. Fulton, at Rs 21.7 lakh per month is highest paid foreign coach in Olympics sports

Here's a look at how some of the foreign coaches of Olympic sports are getting paid in India

CHENNAI. Going by the sports ministry's response in the Rajya Sabha, Craig Fulton is the highest-paid foreign coach engaged by a National Sports Federation in the country. Fulton, the sports ministry revealed while replying to a query on the engagement of foreign coaches, draws an amount of Euro 24,286 (?21.7 lakh) a month. The head coach of the men's team has been drawing the salary since April 26, 2023, and his contract runs until December 31, 2028, after the Los incurred" on foreign coaches, the ministry says, "The National Sports Federations (NSFs) are allowed to hire foreign experts on their own within the budget allocated by the Government."The South African's contract was extended after India's bronze medal at the Paris Olympics. Interestingly, Fulton draws double the amount any other foreign

coach engaged in the country. Fulton's predecessor Graham Reid was getting USD15,000 per month. Union Sports Minister Mansukh Mandviya was responding to a query by Rajya Sabha MP Anil Kumar Yadav Mandadi on December 5. While it is not clear since when Fulton has been drawing this amount, this could be after the Paris Olympics. Take for instance Klaus Bartonietz, the German biomechanic specialist who has helped Neeraj Chopra win multiple medals (gold and silver) at successive Olympics and World Championships. The foreign coach was drawing USD 10,101 (?8.57 lakh) per month. He has been attached with Neeraj since his injury in 2019. Meanwhile, Scott Simmons, the middle and long-distance coach, was drawing more USD 11,364 (?9.64 lakh) per month.

Angeles Olympics. As for the "expenditure" At USD 10,732 per month, Jason Dawson, sprints coach, was drawing more than Klaus. Athletics had engaged some ten foreign coaches, masseurs and recovery experts. One Dr Silva, a recovery expert, was drawing \$10,000. All their contracts were until the Olympics this year. Most of their contracts, according to the Rajya Sabha reply, were until Olympics 2024. South Korean coach Take for instance Rhett Halkett, analytical



Baek Woongki, who felt humiliated for not being given accreditation to accompany the archers inside the Games Village at the Paris Olympics, was drawing USD 10,000 (?8.43 lakh) per month. The coach left after the Paris Games where the players missed his expertise and had to rely on Indian coaches. If athletics engaged some ten coaches and other experts, hockey topped the charts. Over a period of three-four years, (period extending from 2021), they have engaged about a dozen foreign experts, including coaches. The salary increased too. According to the "Details of foreign coaches engaged along with expenditure incurred" presented in the Rajya Sabha, there has been an increase in salary for the new set of support staff of

coach, whose contract runs until December 31 (from April 2023) is getting paid USD 11428.57 (?9.7 lakh) per month. Earlier, when Reid was the head coach, his analytical coach was drawing USD 9000 per month. Scientific advisor to the men's team Alan Tan is drawing USD 9000 and his contract runs until the end of the year. The Hockey India and SAI will be appointing a new analytical coach soon and it needs to be seen if Tan will continue.Dave Smolenaars, analytical coach of the women's team is engaged for USD 10,000 per month until December 2028. Former women's head coach Janneke Schopman was getting USD 9750 before she left the job. Former High-Performance Director (HPD) in boxing Bernard Dunne had to leave mid-way because of a fight between the Boxing Federation of India and him. Dunne was getting paid Euro 11250 (?10 lakh). Interestingly, the Rajya Sabha reply says he was paid till September 2024 whereas he left India in February/March. The sport has fired blanks at the Paris Olympics. Dimitry Dimitruk, the other coach is paid Euro 7500.Badminton, another sport that went blank at the Paris Olympics, engaged around eight coaches in the last two to three years until the Olympics.

players, because of the bounce. It is the kind of bounce you get in Australia, you have to be good player of bounce. You need to have a good backfoot game. Some of the players may not have liked my style. I am serious, I can be intense.
