### Siddaramaiah suggests CBI probe into 'Waqf scam' as BJP denies allegations

Karnataka Chief Minister Siddaramaiah accused BJP state chief BY Vijayendra of attempting to bribe ex-Minority Commission chairperson Anwar Manippady to suppress a Wagf scam report.

Bengaluru. Karnataka Chief Minister Siddaramaiah on Sunday said that his allegations 'Waqf scam' against the state BJP chief were based on evidence and urged the Central government to order a CBI probe into the matter if the saffron party's claims of innocence are true.

These remarks came after the Karnataka BJP president, BY Vijayendra, dismissed Siddaramaiah and ruling Congress leaders' charges that he attempted to "bribe" former state Minority Commission chairperson Anwar Manippady to hush up his report on the Waqf encroachments. "I made the statement based on his video where he spoke

valid anger over the welfare of the people have now turned into points of debates. I don't want this to create a rift between us."

He stated that because he didn't want any "unnecessary debates on open forum", he decided to resign from VCK. Aadhav also stated that he would

continue to question this and sought Thirumavalavan's blessings. Aadhav Arjuna created a political storm when, at a book launch on December 6, he allegedly targeted DMK when he said that a party which claimed to be the champion of social justice was following monarchy."Tamil Nadu will no longer allow monarchy to flourish. A Chief Minister should not be appointed based on birth," Aadhav had said. The comment was widely interpreted as a direct jibe at Chief Minister MK Stalin, who took over the state's top post after his father M

Following the remark, Aadhav also claimed responsibility for DMK's victory in the state elections. The party, however, distanced itself from Aadhav's comment, and led to his suspension from VCK for six months. Meanwhile, VCK chief reacted to Aadhav's resignation. "My blessings are always with him. In public life, patience and tolerance are essential. I expected him to get that opportunity in Viduthalai Chiruthaigal Katchi. This also seems to be (his) urgent decision," Thirumavalan said. Even before the monarchy comment, Aadhav courted controversy when he claimed that alliance parties couldn't be content with only seat sharing, they needed power sharing.

### Return Nehru's letters taken by Sonia Gandhi: PM Memorial writes to Rahul Gandhi

In a letter to Congress leader Rahul Gandhi, the Prime Ministers' Museum and Library urged him to return Jawaharlal Nehru's personal letters, which were allegedly taken by Sonia Gandhi during the UPA regime.

New Delhi. The Prime Ministers' Museum and Library (PMML) has formally requested the return of personal letters written by India's first Prime Minister, Jawaharlal Nehru, which were sent to Congress leader Sonia Gandhi in 2008 during the UPA regime.

In a letter dated December 10, PMML member Rizwan Kadri wrote to Congress MP Rahul Gandhi, urging him to retrieve the original letters from Sonia Gandhi or provide photocopies or digital copies. This follows a similar The collection includes correspondence request made to Sonia Gandhi in September.

The letters, considered to be of immense historical importance, were initially entrusted to the Nehru Memorial ibrary (now PMMI) by



the Jawaharlal Nehru Memorial in 1971. However, they were reportedly packed into 51 boxes and sent to Sonia

Gandhi in 2008. between Nehru and prominent figures such as Edwina Mountbatten, Albert Einstein, Jayaprakash Narayan, Padmaja Naidu, Vijaya Lakshmi Pandit, Aruna Asaf Ali, Babu Jagjivan Ram, and Govind Ballabh Pant, among

others.In his letter to the Gandhi scion, Kadri mentioned that Nehru's private papers were given to the PMML by his daughter and former PM Indira Gandhi since 1971 "for safekeeping rather than an outright gift". He also cited the minutes of a 2008 meeting which mentioned that Sonia Gandhi took away 51 cartons of the donated papers.

As the letters "provide invaluable insights into a critical period of Indian history", the PMML sought their return to the institution's archives."We understand that these documents may hold personal significance for the 'Nehru family.' However, the PMML believes that making these historical materials... more widely accessible would greatly benefit scholars and researchers," the letter stated.

#### Friend in social sense: Shashi Tharoor's clarification as old Soros post surfaces

New Delhi.Congress MP Shashi Tharoor firmly denied having any financial or political ties to US investor George Soros after social media users dug up a 15-year-old tweet of his in which he refers to the billionaire as an "old friend". In a post on X (earlier Twitter), Tharoor called the controversy over a 15-year-old tweet "absurd" and the product of "unhealthy curiosity." The Thiruvananthapuram MP and former UN diplomat described his relationship with Soros as purely social. "Since there is so much unhealthy curiosity about this tweet, I knew Mr Soros well in my UN days as an upstanding internationalminded resident of New York. He was a friend in the social sense: I have never received or solicited a penny from him or any of his foundations for myself or any institution or cause I supported," Tharoor wrote on





Sunday. His remarks come at a time the BJP has accused tor Congress leaders of colluding with Soros to destabilise India. The Congress has refuted the charge as baseless. Tharoor clarified the two had very limited interactions, and that he had only met Soros once since the tweet - at a dinner hosted

by Hardeep Singh Puri, then India's Ambassador to the United Nations and now a BJP Minister. "Amb Puri had invited a number of prominent Americans for a dinner discussion with me (and that was entirely appropriate). I have not been in touch with Mr Soros since," he added.

The Congress leader hit back at detractors for sensationalising a 15-yearold "innocuous tweet" and ridiculed the "troll factory" amplifying the narrative. "I hope this clarifies matters to those misguided enough to make an absurd allegation out of a fifteen-year-old innocuous tweet. But knowing how the troll factory works, I have no doubt it won't!" Tharoor said. The controversy over Soros exploded in Parliament last week after BJP leaders accused former Congress president Sonia Gandhi of being aligned with the billionaire investor, whom they allege is attempting to undermine India's democratic institutions.

### Manmohan Singh as PM doomed Congress's return to power: Mani Shankar Aiyar

Mani Shankar Aiyar argued that Congress's decision to retain Manmohan Singh as Prime Minister despite his declining health led to governance paralysis and ultimately doomed the party's chances of forming UPA-III.

New Delhi. Veteran Congress leader Mani Shankar Aiyar asserted that the decision to retain Manmohan Singh as Prime Minister, despite his declining health, hindered the party's prospects of returning to power for a third term.

In his new book, Aiyar proposed that Pranab Mukherjee should have been appointed as Prime Minister, while Manmohan Singh could have been elevated to the presidency when the Rashtrapati Bhavan became vacant in 2012.

Such a move could have prevented the "paralysis of governance" that plagued UPA-II, the 83-year-old Aiyar argues in A Maverick in Politics.

He claims that the decision to retain Manmohan Singh as Prime Minister and move Pranab Mukherjee to Rashtrapati Bhawan ultimately "doomed" the Congress's chances of securing a third consecutive term with UPA-III."In 2012, the prime minister (Manmohan Singh) underwent operations for multiple coronary bypasses. He



never quite recovered physically. It slowed him down and this showed up in governance. As for the party, there was no official announcement about the Congress president's health when she took ill at about the same time as the PM," Aiyar says. The diplomat-turned-politician observed

that both the Prime Minister's Office and the party president's position soon slipped into a state of stasis, marked by a noticeable lack of governance. He notes that several crises, particularly Anna Hazare's 'India Against Corruption' movement, were either mishandled or left unaddressed altogether."The choice of Rashtrapati: Manmohan Singh or Pranab Mukherjee. #### **New trend: Cybercriminals target** public mobile charging stations toz steal data

BENGALURU. In a concerning trend, cyber criminals are now targeting public mobile phone charging stations to steal users' sensitive data, cyber security experts warn. The growing threat involves the use of USB charging ports, commonly found in public places such as airports, bus stands, railway stations, cafes and hotels. USB ports are often used for both power and data transfer, creating an opportunity for hackers to exploit. Even the state police are creating awareness on the USB charger scam, cautioning people against using public phone charging stations.Dr Harsha, a cyber security expert, said that if public USB charging stations are not configured properly, cyber criminals can misuse the ports to steal data. Since most charging stations use USB ports and the charging cables as a two-way street -to send the power to device and also transfer data - cyber criminals have more opportunities to steal data. The scam is all about stealing data or leaving malware in devices. If a person's mobile phone battery is low, he or she does not think of security as he/she just wants to charge the defice. Frauds take this as an advantage, he said.Cyber criminals try to steal data in two main ways. First, when a device is plugged into a public USB port, a hacker can compromise that port to infect the device. This could lead to the theft of data such as financial information, passwords, banking details and personal files, which can result in identity theft or financial loss. The hacker can use a crawler program to search for sensitive data on the device. Secondly, cyber criminals may use USB ports to install malware or viruses on devices. These malicious programs can clone phone data and transfer it to the hacker's device, he said.

#### Karnataka man impersonates Upalokayukta, held

BENGALURU. The Anekal police arrested a man, who claimed to work in the Karnataka Lokayukta and misused the name of Upalokayukta Justice B. Veerappa on a caller ID application. The accused tried to threaten the deputy tahsildar of Anekal to complete work by misusing the Upalokayukta's name. The accused has been identified as Anand Kumar, a native of Kolar. The police said that Kumar met the Deputy Tahsildar of Anekal, Kariya Naik, claiming he was employed in the Karnataka Lokayukta office in Bengaluru and was a relative of Upalokayukta Justice B. Veerappa.

He requested Naik to change the name of the owner of a one-acre land in Sarjapur to his brother's name, though the land belonged to some other person. When Naik ignored his request, Kumar approached him again and handed him a phone, claiming that a senior police officer with the Lokayukta was on line. The person on the other end also pretended to be a Lokayukta official. Kumar allegedly threatened and harassed Naik, pressuring him to complete the work without delay.

He also saved his number as "Upalokayukta B Veerappa" on a caller ID application and used the number to contact Naik. Suspicious of Kumar's claims, Naik shared his number and photo with Lokayukta officials.

#### Policeman shoots himself dead with service gun in Malappuram

MALAPPURAM. A Special Operation Group (SOG) commando allegedly shot himself dead at the MSP camp in Areekode on Sunday night. The deceased has been identified as Vineeth, 36, a resident of Thekkumthara, Wayanad. Vineeth was immediately rushed to a nearby private hospital but succumbed to his injuries before reaching there. Preliminary reports suggest that he allegedly took his own life due to prolonged denial of leave, even during critical personal circumstances

### With eye on polls, AIADMK to revive Youth Brigades

CHENNAI. With an eye on the 2026 Assembly polls, AIADMK has decided to strengthen its youth wing to garner the support of the young voters and inject young blood into the party apparatus. At the party's general council meeting at Vanagaram on Sunday, AIADMK general secretary Edappadi K Palaniswami directed office-bearers to strengthen the Youth Brigades (Ilaignar Pasaraigal) by enrolling more youngsters into it. Besides, a separate sports wing will be created to encourage sports aspirants. The Youth Brigades was launched by former chief minister J Jayalalithaa in September 2008, when AIADMK was out of power, as part of its strategy to win the 2011 Assembly elections. Those who were in the age group of 18-25 were allowed to become members in these brigades. Reviving the Youth Brigades assumes significance as the party is leaving no stone unturned to win the next Assembly elections. At the GC meeting, Palaniswami directed the office-bearers from district secretaries to village-level functionaries to enrol youth below the age of 30 in these brigades. Palaniswami also announced that he would be undertaking a statewide tour from the last week of January to expose the DMK government and visit all 234 Assembly constituencies. He also assured that, taking into consideration the expectations of party members, a mega alliance headed by AIADMK will be formed for the elections. "You may think the general secretary gave the same



assurance for the Lok Sabha elections and (that has not become true). But I say Lok Sabha elections and Assembly elections are entirely different in nature. #### Works for Hyderabad Old City Metro expedited

HYDERABAD. .The land acquisition process for the construction of the Metro in the Old City has been expedited following the orders of Chief Minister A Revanth Reddy, covering nearly seven-and-a-half-kilometers between MGBS and Chandrayangutta, announced Hyderabad Airport Metro Limited (HAML) Managing Director NVS Reddy on Sunday. As many as 1,100 properties ae likely to be affected. He revealed that requisitions for 900 properties have already been submitted to the district collector under the Land Acquisition Act. Preliminary notifications have also been issued for 800 properties in phases, while 400 properties have received preliminary declaration.

Compensation awards for 200 affected properties are expected to be finalised by the end of December,

### A celebrated Siva temple with many unique features

village near Thiruvarur, has a Siva temple, wherein the principal deity (Siva Lingam) is worshipped as Akshayalinga Svami and Kediliyappar. This temple is a Padal Petra Sthalam or shrine praised in the Tamil verses of the Nayanmars or important Siva devotees, totally numbering sixty-three. Appar and Thirugnanasambandar, the famous Nayanmars visited this temple in the 7th century CE.The Sthala-Puranam or traditional story of this temple records that Subramanya worshipped his father Siva here and established this temple with the help of God Indra. It is said that Subramanya performed tapas (penance) here to kill Tarakasura and then had a bath in the pushkarini (temple-tank) called Saravana Poigai, which he created by piercing his vel (spear) into the ground. This pushkarini is seen near the main entrance. Since this deity was a tapasvi in Kizhvelur, his images of Balasubramanya and Arumugasvami are not flanked by consorts, Valli and Devasena. Interestingly, Balasubramanya here has the elephant vahana instead of the peacock. This temple, which has three prakarams (enclosures), has a majestic gopuram,

covered with sculptures, on the east. The main sanctum, which has a narrow open prakaram around it, houses the small Siva Lingam worshipped as Akshayalinga Svami, which is said to be Svayambhu (self-manifested). An interesting image of Nataraja dancing in Chatura Tandava on the left foot is worshipped closeby. A flight of steps leads to the main sanctum which is at an elevation, earning this temple the name 'mada kovil'. There are several such 'mada-kovil' built by a Chola ruler named Kochenganan who was also a Nayanmar. Goddess Parvati is called Vanamulai Nayaki or Sundarakuchambikai in this temple.Small sanctums for each of the Siva Lingas in the Pancha Bhuta

Sthalams (Prithvi, Ap, Thejus, Vayu and Akash in Kanchipuram, Thiruvannaikka, Thiruvannamalai. Srikalahasti and Chidambaram) are in the second prakaram and also a rare shrine for Kubera, the God of wealth as this deity is said to have helped a poor devotee here.

Another unique sanctum is for Anjuvattathu Amman, or Parvati, who, wanting to protect Subramanya and his penance, covered the four directions and also the sky. Interestingly, the images of the Navagrahas are in a single row just as in the Thyagaraja Svami temple in Thiruvarur.A couple of Chola inscriptions have been found here, one unfortunately mutilated and the other mentioning a grant of land.

# Stormwater pools in Tiruchy junction station subway, poor renovation blamed

TIRUCHY . Stormwater pooled in the subway connecting platforms at Tiruchy railway junction on Saturday, forcing many passengers to avoid using it. This subway has been facing the situation from 2020 onwards with sources blaming infrastructural renovation work at the station taken up in 2019.

The Southern Railway spent roughly over Rs 20 crore for the infrastructural upgrade here, but every monsoon the subway gets flooded, exposing poor drainage, they said. Although the authorities often conduct temporary measures to drain out the water, passengers stressed the need for

a permanent solution. "I have been boarding trains from this station for the past 20 years. This station's subway faced this kind of situation only after the infrastructural renovation during 2019 to 2022. It left us a beautiful station with poor storm water management. What is the point in having a beautiful granite-laid subway pooled up with storm water?

None can use it during the monsoon. I had several times noticed water rushing out from the gaps of stairs in the subway. I don't know how many crores the railway has to spend to stop this pooling of water in this underpass," said B Anandanarayan, a



resident and state government official working in Thanjavur.

Some passengers demanded an inquiry against those who conducted the

infrastructural renovation works at the station. "I am a regular railway passenger, and I request the administration to start an inquiry into the works executed at this station. Second, the railway should also come up with a permanent solution.Last year, we faced the same issue, and authorities failed to come up with a solution to avoid such a situation," said Syed Ibrahim, a senior citizen and a passenger. Meanwhile, a senior railway official said, "We used two high-power motors to drain out the water. The railway team will take measures for a permanent solution."

#### Gurgoan hospital treats Iraqi man with rare spinal condition

Gurgaon: A 40-year-old Iraqi man underwent a rare spine surgery at Artemis Hospital.

Mohanad Adnan Mohamed from Baghdad endured a rare spinal condition causing acute neck pain and progressive weakness in his right arm. After unsuccessful treatments in Iraq, he sought specialised medical intervention in India.

The surgery was performed under Dr Hitesh Garg's supervision. He performed a minimally invasive procedure called Anterior Cervical Decompression and Corpectomy of C5 with fixation at C4-C6. The operation encompassed the removal of the prolapsed disc, and decompression of the spinal cord and nerve roots, followed by stabilisation through vertebral fusions, which proved remarkably successful.

The patient was discharged within 48 hours post-surgery and departed for Iraq following a 20-day recuperation period in India, experiencing complete restoration of mobility and strength. Mohamed expressed his satisfaction, noting complete alleviation of neck pain, substantial recovery of arm strength and sensation, alongside a swift return to routine activities.

#### Then a vacant plot, now a dumpsite near housing societies in Crossings

Ghaziabad. Residents of several housing societies in Crossings Republik have raised concerns about the unauthorised disposal of plastic and sewage waste at a private plot next to their condominiums.

The menace doesn't end there. "The situation worsens when the dumped waste is set on fire, resulting in smoke and spiked air pollution levels. Earlier, people used to burn the waste at night, but now, they do it during the day too," said Prateek Singh, a resident of Exotica Eastern Court."Putting rules in place isn't enough. Enforcement of norms and monitoring are essential to ensure that waste management happens properly," he added. Residents said during the monsoon, the ground gets filled with muck after a few spells of rainfall. They have made numerous complaints, but officials of concerned authorities are yet to address the problem. Prateek Royal Cliff, Skytech Merion Residency 2, and Exotica Eastern Court are some of the societies around the plot.

"All efforts and norms against illegal disposal of waste



have ultimately fetched no results here since garbage and sewage waste still lie open close to our houses, said Anuranjan Srivastava, a resident of Skytech Merion Residency 2.Locals highlighted that landowners and developers should be responsible for regular maintenance of their vacant properties.

'Now and then we are exposed to the foul odour from the dumping ground. Given regular exposure to smoke and pollution, it pains us to imagine the health adversities it could result in," said another resident.

#### 6 arrested in credit card scam

Noida. Six people were arrested from Sector 37 on Sunday for cheating over 50 people on the pretence of increasing their credit card limits. Another member of the gang is on the run. Manish Mishra, ADCP of Noida, said the gang would make phone calls to credit card holders and offer to increase their card limits. They would ask the victims to download an app from a fabricated website. Once downloaded, the victims would then be asked to fill a form with their credit card details, email id, PAN card, Aadhar card, current limit of credit card, expiry date, CVV, etc, the accused told their interrogators."Using the obtained information and OTPs, they used to buy expensive items like mobile phones, gold and silver coins from ecommerce websites with the victims' credit cards," he

### Drains choked, sewage floods roads, 'pollutes potable water' in Gurgaon's Sushant Lok 1

**Gurgaon.** For the past 10 days, sewage has been overflowing on roads of Sushant Lok 1 near Lilv Park and Peach Tree Hotel in C Block. The situation in the area has now worsened, with residents complaining about contaminated water supply as well, leaving them with no choice but to rely on water tankers.

The contract for operation and maintenance of the sewer system expired on Nov 15, they said, but MCG failed to make alternative arrangements, exacerbating the crisis. They further alleged that greyish, foul-smelling water was now flowing through their taps, making it unsafe for daily use. Jay Shankar Yadav, a resident, said, "The sewer that has been overflowing near Lily Park for 10 days is yet to be fixed. The stench is unbearable, and now this sewage is mixing with our water supply. We have no option but to use water tankers for our daily needs."

Spread across over 700 acres, Sushant Lok was taken over by MCG in 2019. However, residents claim that little has been done to upgrade the area's deteriorating infrastructure. The sewer system, laid more than three decades ago,

#### Ukraine Slams FIFA For Map **Omitting Crimea From Its** Territory: "Are you OK

World. Ukraine has lashed out at FIFA after the governing body of world football showed a map that seemingly omitted Crimea as part of the country. The incident took place last week when FIFA held a European qualifier draw for the 2026 World Cup that is being jointly hosted by the US, Mexico and Canada. The map was intended to show countries that cannot be drawn to play against each other for geopolitical reasons, such as Ukraine vs Belarus, Armenia vs Azerbaijan, Spain vs Gibraltar, Kosovo vs Serbia, and Kosovo vs Bosnia and Herzegovina.

In the middle of the presentation, FIFA excluded Crimea from the Ukrainian region, instantly leading to backlash from Kyiv. Notably, Crimea has been under Russian occupation since 2014 with only a handful of countries recognising the peninsula as Russian territory.

Ukraine Foreign Ministry spokesman Heorhiy Tykhy took to X (formerly Twitter) and tagged FIFA while questing it for "redrawing" the international map.

"Are you OK, @FIFAcom? By redrawing international borders in yesterday's broadcast, you not only acted against international law, but also supported Russian propaganda, war crimes, and the crime of aggression against Ukraine," said Mr Tykhy.

'We fixed the map for you and expect a public apology," Mr Tykhyi added while sharing the correct map. Ukraine FA writes letter

The Ukrainian Football Association also wrote a letter to FIFA expressing its concerns. "We write to express our deep concern regarding the infographics map of Europe displayed during the television broadcast of the European Qualifiers draw for the FIFA World Cup 2026 on December 13, 2024," read the letter.

Taking into account a number of official decisions and resolutions adopted by the Fifa Council and the UEFA executive committee since 2014....we emphasize that today's version of the cartographic image of Ukraine is completely unacceptable and looks like an inconsistent position of Fifa and UEFA," it added.

In response to the outrage expressed by the Ukrainian Football Association, FIFA also issued a statement acknowledging the issue. "FIFA is aware of an issue that affected one of the graphics shown during the draw and has addressed the situation with the Federation. The segment has been removed."

#### Clothing Brand Founder Releases 'Most Wanted CEOs' Playing Cards

World. James Harr, founder of Comrade Workwear, a self-described "socialist apparel" brand, has courted controversy with his latest project -- a deck of cards featuring "most wanted CEOs" complete with names, faces, and illustrations of gun range targets.

Harr, known for his anti-capitalist rhetoric and controversial social media posts, introduced the project days after the killing of UnitedHealthcare CEO Brian Thompson in New York. On his Instagram and TikTok accounts, which collectively have over 109,000 followers, Harr shared his plans for the deck, adding the idea was inspired by the Iraq war-era card decks. He claimed the deck would help people identify the CEOs he believes are responsible for harming the public. The deck will be divided into suits representing various industries, according to Harr's posts. Clubs will feature pharmaceutical and chemical company CEOs, Hearts will represent retail and real estate, Diamonds will cover tech, finance, and media, and Spades mean oil and war company

The cards' reverse sides will display the phrase "mostwanted CEOs" alongside a red human silhouette gun range target, and the front will show black-and-white close-ups of each CEO's face, name, affiliation, and QR codes labelled "why they're evil," leading to web pages outlining their alleged wrongdoings. Harr asked his followers to suggest more CEOs to feature in the deck, and many pledged to buy the deck as soon as it was available. One commentator even asked if the deck would include addresses.In response to criticism. Harr insisted the deck was not a call to violence. "I'm not suggesting anyone should cause any physical harm to anyone," he told The NY Post. "But I do want people to know who is making their life harder, who is stealing from them, who is deciding that a couple more percentage points of profit is worth more than the life of your loved ones.S

#### Taiwan receives 38 US-made Abrams tanks amid China threat

World. Taiwan's defense ministry announced Monday the arrival of 38 M1A2 Abrams tanks from the United States, a move aimed at strengthening the island's defenses against a potential attack from China. These tanks represent the first of 108 ordered

The tanks arrived Sunday according to AFP and were transported to an army training base in Hsinchu, as confirmed by the defence ministry. Currently, Taiwan's tank arsenal comprises approximately 1,000 units, including locally manufactured CM 11 Brave Tiger and American M60A3 tanks, which are considered dated. The remaining tanks are scheduled for delivery in 2025 and 2026.

The US is Taiwan's main ally and arms supplier. China claims Taiwan as its territory and opposes such arms sales. Taiwan's government budgeted over \$1.2 billion for the Abrams tanks.

China has not ruled out using force to take control of Taiwan. While Taiwan develops its own defense systems, it relies heavily on US arms sales for security. Delays in arms deliveries to Taiwan have occurred due to supply chain issues and US weapon shipments to Ukraine and Israel. Taiwan's 2024 defense budget is a record \$19 billion, and next year's is expected to be even higher, reflecting the island's focus on bolstering its defenses. China has intensified military activities around Taiwan, including recent large-scale maritime drills.

### 'Definitely several hundred' killed as Cyclone Chido devastates French territory of Mayotte

authorities said Sunday that the likely death toll from cyclone Chido's passage across Mayotte was "definitely several hundred" though the disruption means reaching an exact count will be difficult.

Rescue workers and supplies are being rushed in by air and sea, but their efforts are likely to be hindered by damage to airports and electricity distribution in a territory where even clean drinking water was already subject to chronic shortages.

A previous toll shared with AFP by a security source had confirmed only 14 deaths.

"I think there will definitely be several hundred, perhaps we will come close to a thousand or even several thousand" deaths, prefect François-Xavier Bieuville said on broadcaster Mayotte la Premiere.

He added that it would be "very difficult to reach a final count" given that most residents are Muslim, traditionally burying their dead within 24 hours. The mayor of Mayotte's capital Mamoudzou, Ambdilwahedou Soumaila, had earlier told AFP that nine people were gravely wounded and fighting for their lives in injured."The hospital is hit, the schools are hit. Houses are totally devastated," he said, adding that the hurricane "spared nothing". Mayotte's 320,000 residents had been ordered into lockdown Saturday as cyclone Chido bore down on the islands around 500 kilometres (310 miles) east of Mozambique with gusts of at least 226 kilometres per hour. Electricity poles were hurled to the ground, trees uprooted and sheet-metal roofs and walls torn off improvised structures inhabited by at least one-third of the population.Information from the locked-down population, in shock and largely cut off from water and electricity supplies, is slow to filter out, a source familiar with the recovery effort told AFP.One local resident, Ibrahim, told AFP of "apocalyptic scenes" as he made his way through the main island, having to clear blocked roads for himself.

World. Prince Andrew, the younger brother of King Charles III, has become the subject of yet another scandal after an alleged Chinese spy used him to get access to the heart of the British establishment. According to The Guardian, the businessman, identified only as "H6" for legal reasons, had gained unusual level of trust from the senior royal. However, in a rare statement, issued by Andrew's office, the royal insisted that he "ceased all contact" with the alleged spy after concerns were raised, and that "nothing of a sensitive nature was ever discussed".

The Guardian quoted court documents to report that the businessman was so close to the Duke of York, he was authorised to act on his behalf in an international financial initiative with potential partners and investors in China.

A March 2020 letter written to him by Dominic Hampshire, a senior adviser to Prince Andrew, was also found in the alleged spy's phone, which referred to him being invited to the duke's birthday party. "Outside of his closest internal confidants, you sit at



### New York Pet Stores Rush To Sell Pets At Discounted Rates Before Sales Ban

World. Pet shops across New York City can no longer sell dogs, cats, or rabbits. The Puppy Mill Pipeline Act, signed two years ago by Governor Kathy Hochul, came into effect on Sunday.

It aims to stop the flow of animals bred in inhumane puppy mills and promote adoption from overcrowded shelters.

The act to curb abusive breeding practices has turned New York into a buyer's market for prospective pet owners. Pet stores scrambled to clear their inventory, offering steep discounts on animals in a lastditch attempt to sell before the ban.Many took advantage of

price reductions over the weekend. Ingrid Rodriguez, 25, bought a 10week-old Pomeranian for \$1,300 (Rs 110,084) down from \$1,450 (Rs 122,482) – at Astoria Pets in Queens. "I was just walking by with my mom when we saw the sign. We went in, and you know, holding the dog up to her chest," she told The NY Post. Despite her mixed feelings about the law, Ms Rodriguez supports reducing illegal breeding."I never thought I'd buy a dog,

but if they didn't get sold, they were going to the shelter," said Krisjan Polonia, 31, who purchased a blackand-white shih tzu-bichon mix for \$650 (Rs 55,082) – down from \$2,800 (Rs

237,104). "Kids make you do crazy things," he added, explaining the dog was a gift for his son. On the other side of the debate, pet shop owners like Don D'Alessio of 'Astoria Pets' are frustrated with the law. A veteran of the industry for 42 years, Mr D'Alessio has always adhered to the city's regulations, ensuring that he only bought from licenced breeders. "We've never had a

violation here, look at the paperwork.

Fifteen years of paperwork, not one

violation," he said. Despite following

the rules, he is now forced to close his doors. "I can't last selling supplies that are cheaper online... We're not going to survive. We're done," he said, pointing out that over 120 businesses like his are

expected to shut down across the state, affecting around 2,500 employees.

Mr D'Alessio, 73, had no choice but to sell the 21 dogs in his store over the weekend, fearing that any unsold animals would be sent to shelters. He explained that many customers couldn't afford the dogs even at their discounted prices, which led him to give some of the animals to loyal clients.

Despite the challenges faced by pet shop owners, animal rights groups are celebrating the law as a victory for animal welfare. Rise Weinstock, president of the New York Animal Care Centers, praised the bill for ending a cruel supply chain. "For too long, pet stores have been the final stop in a system that treats living beings as commodities," she said. Activists argue that pet shops often source their animals from puppy mills, where dogs are bred under inhumane conditions.

She claimed Nobel laureate Yunus was leading an "undemocratic group" that was "secretly supporting anti-liberation extremistcommunal forces" and the main aim of his dispensation was to suppress the spirit of the Liberation War and the pro-liberation forces.Ms Hasina's remarks were part of her statement to commemorate the defeat of Pakistani forces in Bangladesh's Liberation War of 1971. Bangladesh celebrates December 16 as 'Bijoy Dibosh' or Victory Day.On December 16, 1971, then Chief of Pakistani forces General Amir Abdullah Khan Niazi, along with 93,000 troops, surrendered to the joint forces of the Indian Army and 'Mukti Bahini' after the 13-day war following which East Pakistan became Bangladesh.In a statement posted on her party's official X account, Ms Hasina highlighted the role of her father, Sheikh

Mujibur Rahman, and the Awami League in the struggle that culminated in the emergence of Bangladesh. She also noted the developmental work done by the Awami League government and its vision for Bangladesh under her leadership. Talking about the events leading to her ouster, Ms Hasina said, "Anti-national groups illegally and unconstitutionally seized state power through domestic and foreign conspiracies.""This undemocratic group, led by fascist Yunus, has no responsibility towards the people.

They are obstructing all public welfareoriented work by seizing power. About 50 million people in the country were under the social security system. They were given various allowances. It has been alleged that most of the allowances have been stopped. The family cards of 4.3 million families under the TCB have been cancelled. The people of the country are suffering from the



hardships of rising commodity prices. Hungry people are picking food from dustbins," she said. Ms Hasina, who fled to India after resigning as the prime minister in August in the face of massive antigovernment protests, claimed that since Mr Yunus-led interim government was not democratically elected, it has no responsibility towards the people. "Their main goal is to create resentment against

the spirit of the Liberation War and the forces supporting the Liberation War and to silence them. On the contrary, they are secretly supporting the antiliberation extremist-communal forces. The lack of sensitivity of the officials of this government, including the fascist Yunus, towards the Liberation War and its history is proven by their every step," she stated.

Ms Hasina alleged that the Mr Yunus-led dispensation was following the "rituals of the responsible group" Pakistan in an attempt to erase "progressive ideals," the

history and spirit of the Liberation War. "If they could, they would have presented a different narrative and erased the traces of the great Liberation War from every aspect of national life. They would have turned this great glorious event of the collective achievements of the Bengalis into a

disgrace," she added.

#### Upkeep of CRMP roads goes for a toss in Hyderabad city

HYDERABAD. With an end to the five-year agreement between two GHMC zones -Serilingampally and Kukatpally maintenance of the main road over 810 kilometres under the Comprehensive Road Maintenance Programme (CRMP) by private agencies hangs in balance. For the remaining four GHMC zones, including Khairatabad, Secunderabad, LB Nagar and Charminar, the agreement is going to expire



next month. The GHMC has not taken any decision to float fresh tenders for the maintenance of CRMP roads nor given any extension to the agencies which are currently maintaining them. Meanwhile, the GHMC has invited bids from the agencies to provide truck-mounted mechanical sweeping services through compact heavyduty vacuum sweepers to clean large flat paved areas on CRMP road stretches in Kukatpally and Serilingampally till June 2025. The agreement was handed over to private agencies in November 2019 which were entrusted to take up sweeping roads, laying bitumen and concrete roads, and developing road infrastructure at regular intervals. The agreement had mentioned that 50% of the roads should be recarpeted in the first year, 30% in the second year, and the remaining 20% in the third year, and maintenance responsibilities should be taken care of for another two years.

### Heavy rain likely over Tamil Nadu delta districts on Dec 17, 18

CHENNAI. Close on the heels of the recent weather system that brought significant rainfall to Chennai and the delta districts, along with extremely heavy downpours in the southern districts of Tamil Nadu, the Regional Meteorological Centre (RMC) on Sunday announced that a new low-pressure area is likely to form over the southeast Bay of Bengal on Monday. The system is expected to bring heavy to very heavy rainfall to the delta districts on Tuesday, it stated. The low-pressure area is to be formed under the influence of an upper-air cyclonic circulation, which was located over the South Andaman Sea and adjoining areas on Saturday and subsequently moved to the South Andaman Sea and the adjoining Bay of Bengal by Sunday. It is likely to become more marked and move west-northwestwards towards the Tamil Nadu coast in the next two days.

As per the RMC's forecast, an orange alert (heavy to very heavy rains) has been issued to Cuddalore, Mayiladuthurai, Nagapattinam and Tiruvarur districts and Karaikal area for Tuesday. Heavy rain is likely to occur at isolated places over Chengalpattu, Villupuram, Kallakurichi, Ariyalur, Perambalur, Tiruchy, Thanjavur and Pudukkottai districts and Puducherry.

On Wednesday, heavy to very heavy rains are likely in isolated places over Cuddalore and Villupuram districts and Puducherry. Heavy rain is likely to occur at isolated places over Tiruvallur, Chennai, Chengalpattu,



Kancheepuram, Ranipet, Tiruvannamalai, Kallakurichi, Mayiladuthurai, Nagapattinam and Tiruvarur districts and Karaikal area, the forecast stated. Weather blogger K Srikanth said that there is an increasing consensus among the weather models about the lowpressure area becoming well-marked and its potential slow movement due to presence of a ridge over peninsular India.

Any stall or slow movement could turn the rainfall event into widespread heavy rainfall over the northern Tamil Nadu coast.

The potential for westerly/easterly interaction near south coastal AP or north coastal TN is

increasing and it could bring an extreme rainfall event between Marakkanam and Sriharikota. The stretch between Pondicherry and Nellore may see heavy to very heavy rains during this period, he said.

After intensification, the well-marked lowpressure region will approach the north TN coast and then move along southern AP coast, potentially bringing moderate to heavy rainfall on December 18 and 19, lasting for 24 to 36 hours, subject to real-time tracking. In the 24 hours ending at 8.30 am on Sunday, Papanasam in Tirunelveli district recorded the highest

### BDA scraps plan to demolish Hebbal flyover's KR Pura ramp

BENGALURU. In a significant step in connection with the Hebbal flyover augmentation project undertaken by the Bangalore Development Authority (BDA), it has now decided not to demolish the ramp leading from KR Pura to the city. This follows a step initiated by the Bangalore Metro Rail Corporation Limited (BMRCL) to shift its line slightly from the present alignment, said BDA officials. In another change of plan, it has also decided to effect changes in the existing Tumakuru loop. These moves will significantly reduce the time taken to complete the project by many months. The much-delayed flyover project by BDA is being carried out a cost of Rs 106 crore. With the convergence of Metro and suburban rail projects at the spot, the need to



accommodate various agencies delayed it considerably. The latest deadline for the project is June 2025 for Phase-I and December 2025 for full completion.A senior official told TNIE, "Initially, the BDA planned to demolish the KR

Pura ramp to make way for the Metro line. However, until Metro work began, we decided to use the ramp temporarily by making some adjustments. To facilitate this, a portion of the ramp, particularly at the turn was removed."Two Metro lines go via the Hebbal flyover, the Kempapura to JP Nagar IVth Phase (Orange Line, Phase-3) and the Sarjapura to Hebbal (Phase-3A), the officials explained. "Metro officials recently informed us that they were shifting the alignment of their pillars slightly.

This gives us some additional space. Hence, we decided at a crucial meet on December 11 that we will not demolish it but instead align it with the route towards the city. This also helps us

#### Uber eyes Bengaluru for its shuttle bus services BENGALURU. With its shuttle bus service performing

well in Kolkata and Delhi, Uber is actively engaging regulatory approval for introducing the service in KOCHI. Even before the break of dawn on Bengaluru. The ride-hailing company plans to introduce the shuttle service but is still awaiting the nod from the government. It plans to operate 200 air-conditioned buses along the city's tech corridor on the Outer Ring Road, aiming to reduce congestion by offering commuters an alternative to personal vehicles. #### UniVerse: Your true legacy as a doer

How will posterity see my legacy? This question has recently been raised by no less a person than the retired Chief Justice of India. This reminded me of a story recorded by the Hindi scholar Hazari Prasad Dwivedi in an essay titled 'Bhishma Ko Maaf Nahin Kiya Gaya' (Bhishma Was Not Forgiven). Once, during their regular evening walk on the premises of Kala Bhavan, Rabindranath Tagore had posed an interesting question to him: "Why was Bhishma Pitamah, the grand old warrior, patriarch of the eminent royal clan of Kurus, not anointed as an avatara after his death, but two Yadava brothers, Krishna and Balrama, from a much humbler rural background, were?"The poet said he thought it was so because such questions are decided historically by how posterity views your true legacy as a doer. Hazari Prasadji mulled over it and agreed. After the Mahabharata war, he writes, Balrama, the great farmer warrior, earned the right to be revered as an avatara because he refused to take sides in what he foresaw as a terrible fratricidal war and chose instead to go into the forest for his remaining days.

When the Pandavas and Balrama's younger brother Krishna, the great statesman, asked him to take up arms, he had the guts to stand up and tell the warring royals that whatever the dharma, he shall not participate in a war for throne that will ruin mankind and make the land sterile.

Krishna participated in the war only because of his loyalty to Arjuna, his friend, as his unarmed charioteer and refused to shed blood. When Gandhari cursed him for the death of her sons later, he told her bluntly: "You can curse me all you want, but O Kshatriya queen, it was your own upbringing that led to this."In India, people have always preferred an outspoken karma yogi to an orator. One who throws caution to the winds, swings into action to protect the greater common good and restore sanity of the nation. So what if it meant losing public face and risking ridicule? A later karma yogi, Mahatma Gandhi, whose grand



legacy makes even his political critics bow to him, showed the same presence of mind and daring after the Chauri Chaura violence and stopped the Satyagraha in its tracks. A peaceful movement, he felt, could not be allowed to degenerate into violence. There was criticism from hot heads, but he did not relent. It is not hard to make out the public perception of a man to whom the nation has turned again and again to sort out its moral dilemmas. Bhishma was one such figure of authority — celibate, morally irreproachable and a great warrior. But he let clansmen like the Kauravas misbehave with his granddaughter-inlaw, Draupadi, in public. Even when the three abducted princesses — Amba, Ambika and Ambalika — appealed to him that he marry them instead of his impotent brother, he kept quoting his great vow of celibacy and examples and precedents from scriptures and history, but did nothing. When divisions in Bhishma's psyche surfaced again and again at crucial points, resulting in the denial of justice to men, women and clans, his claim to join the pantheon of great avataras shrank in public perception.

Bhishma's case proves that history remembers great heroes less by their recorded speeches and more by prompt, though risky, acts that cause personal loss of reputation, but go on to ensure justice and relief to millions of sufferers.

### Hidden migration of tiny songbirds from Siberian Tundra

#### Chandigarh is uniquely positioned to welcome migratory birds with its mix of diverse habitats

The mention of bird migration immediately conjures up images of ducks and geese forming the V-shaped skeins across the autumn sky, along with a host of other waterfowls and waders. These large, conspicuous birds are eagerly awaited, heralding the changing season. However, a parallel migration goes largely unnoticed. At the same time as these large waterfowls traverse the sky, tiny non-descript songbirds make an equally arduous journey of more than 6,000 km from their breeding grounds in the Siberian Tundra to the northern plains of India. Both groups use the same Central Asian Flyway, yet their experiences are starkly different. While ducks and geese fly at high altitudes to avoid predators and other vagaries of nature, small songbirds fly at low altitudes, usually under 2,000 m above the sea level. Their route winds through countries like China, Kazakhstan, Mongolia, Kyrgyzstan and the Himalayan foothills, using the valleys and forests to enter India, and spread out throughout the northern plains.Most migrating birds lose their vibrant breeding plumage before embarking on this annual journey. They arrive in their wintering grounds bearing a dull visage. While helping them to blend into their surroundings, their earthy plumage also renders them easy to overlook. The perseverance of these little heroes often goes unheralded. Chandigarh is uniquely positioned to welcome these birds with its mix of diverse habitats forests, riverine tracts, grasslands, wetlands, agricultural fields, gardens and parks. The Taiga Flycatcher, the Bluethroat and theRubythroat are striking examples of these inconspicuous yet fascinating migrants. They are 'robin-like' in appearance — small in size, with cocked-up tails and wings drooping down the sides. The Taiga Flycatcher prefers dense vegetation. It adjusts its migratory route to stay close to forested areas and natural cover flying up to 300 km daily. This small bird finds refuge in the lush gardens and parks of Chandigarh. Its predominantly brown plumage is punctuated by the bright orange patch on its throat, almost like a human thumbprint. With bright inquisitive eyes, this bird spends much of its time perched on the lower branches of a tree, surveying its surroundings. Its stationary, almost meditative, appearance can galvanise into sudden action at the sight of a moth or some innocent bug fluttering nearby. It dives to the ground to grab its prey, revealing the white edges to its tail before returning to its perch. Unlike the Taiga Flycatcher, the Bluethroat is a bird of the marshes and wetlands, skulking in reeds and bushes encircling water bodies. During its breeding season in the Tundra,



this bird builds its nest on the ground in shrubby areas. The Bluethroat is a shy bird, which is often out of sight while it forages in the thick reeds. In birding parlance, it is deemed a skulker! The Bluethroat is well known for its skill in mimicry. In Norway, this talent has earned it the sobriquet of 'Nightingale of the North'. It is capable of mimicking more than 50 different species of birds! At first glance, the Bluethroat appears as another 'little brown bird', but a closer look reveals a spectacular blue patch at its throat, adorned with a rust-coloured spot in the centre. During courtship display, it puffs out the throat feathers, revealing the beautifully hypnotic circle. This vibrant patch, coupled with the bird's special ability at mimicry, is enough to attract mates. The Bluethroat also communicates through frequent tail flicks, revealing orange tail patches that serve as alarm signals. Common names of birds are usually descriptive and the Siberian Rubythroat is no exception. The ruby-red teardrop at its throat glows against its otherwise greyish-brown plumage. This small secretive bird is often hard to spot, preferring to hide in dense shrubs and vegetation, its presence

revealed only when it flashes the red patch. During the breeding season, the melodious song and fluttering dance display of the Rubythroat is spectacular. Its ability to mimic other birds shows a degree of vocal versatility. However, in its wintering habitat around Chandigarh, it is silent and its occasional appearance in the thickets adds a touch of While these God's little creatures brighten up our winter landscape, we are oblivious to the incredible dangers and hardships the migratory birds face. Crossing vast landscapes and navigating diverse ecosystems pose significant challenges. En route, the migrating birds rely on stopover habitats to rest and recuperate. These sites are critical in providing food and shelter to enable the birds to continue their journeys. Climate change, habitat loss and violent human conflict along the Central Asian Flyway can disrupt migration patterns. Conservation of stopover habitats, thus, becomes a global responsibility to ensure the survival of these delicate, yet tenacious, travellers.— The writer is president of the Chandigarh Bird Club.

### 10 yrs of a unique classical library

#### Murty Classical Library is unique initiative with a 100-year plan to publish the English translations of some of the greatest literary works of India from the past two millennia

Entrepreneur and computer scientist Rohan Narayana Murty's ambitious plans for the Murty Classical Library are more or less on course. The Library 'opened' in 2010 and started publishing, after five years, the English translations of some of the greatest literary works of India from the past two millennia. It's probably the only publishing house with a 100-year plan to publish 500 manuscripts of authors ranging from Kalidasa to Mir Taqi Mir.To mark the first 10 years, the Library rcently released 'Ten Indian Classics', an anthology featuring ghazals and devotional poems, journeys of nirvana by women Buddhist followers, words of Sikh Gurus and poets, and epic Ramayana's hero Ram's battle for justice and honour. This English edition captures almost 2,500 years of literary tradition, translated by experts and richly introduced by poet and art critic Ranjit Hoskote.

The Murty Library books are available worldwide in bookstores and on conventional e-commerce platforms. Rohan founded the Library by making a generous contribution (around \$5.2 million, according to some media reports) to Harvard University, the institution from where he earned his PhD. With close to a century's experience in publishing bilingual editions (both for Greek and Latin classics), Harvard appeared the perfect choice. For the firm believers in India's glorious past, the Murty Library may appear as another visionary idea from a family (father NR Narayana Murthy and mother Sudha Murthy) with a remarkable success record. For many modernists though, the Library is a brave attempt to reboot India's humanities education programme, long

hijacked by the IIT brigade. Subjects like philosophy, literature and history are often viewed in India as "future-less", compared to the STEM (science, technology, engineering and mathematics) fields. Humanities degrees are less pursued though they are more likely to stir students towards critical thinking and ethical reasoning. Rohan's dream is simple. He imagines students in schools and colleges to read

classical Indian poets like Kalidas and Tulsidas, besides consuming Shakespeare or Homer. "I dream of a day when students across India will voluntarily read these texts," he says. The Library, he believes, has done a commendable job, having already published close to 50 volumes translated from more than 10 classical languages like Hindi, Kannada, Marathi, Pali, Persian, Sanskrit, Urdu and Sindhi. The author list includes Guru Nanak, Bulle Shah, Kalidas, Surdas and Nandi Timmana. For the first time, it is pointed out, a wide international audience is reading these texts in English. "Several universities around the world have started incorporating these texts into their classrooms," he says. For Murty Library, the Harvard University Press, with a team of distinguished scholars, editors and translators, has published English translations of great Indian classics that include 'The Sea of Separation: A Translation from the Ramayana of Tulsidas' by 16th century poet Tulsidas; 'Theft of a Tree, A Tale by the Court Poet of the Vijaynagara Empire' by Telugu poet Timmana; 'The Kannada Mahabharata V.1' by 15th century Kannada poet Kumaravyasa, and 'God at Play V.1', the oldest extant Marathi work by 13th century biographer Mhaimbhat.

Rohan finds it difficult to pick his favourites from the impressive selection, but says he often revisits Raghavanka's 'The Life of Harishchandra' (Kannada) and Shah Abdul Latif's 'Risalo' (Sindhi).

Sharmila Sen, Editorial Director and Director of Special Initiatives, Harvard University Press, says, "To publish original books that instruct and delight in equal measure is never easy." Book trade in North America, Europe and Asia varies, and only complicates the task for them. She claims that compared to Greek and Latin translations, their publications are far more complex, varied, richer and more alive to literary tradition.

Indeed, the task has been demanding as Murty Library does not reproduce previously published translations



and every work is originally commissioned. It produces the original Indic text in the relevant script on the verso (the left-hand side of the books). It has also faced some criticism in the past, mostly from the Indian scientist community and strong believers of India's glorious past,

regarding the choice of certain editors (like distinguished Sanskrit scholar Sheldon Pollock) of the Library. Rohan has treated the attacks merely as "noise". According to a media report, he likened the attacks to people throwing empty shells in a "peanut gallery". Defending Pollock, he declared that nationality, gender, race, creed or colour will not decide who the editors shall be.Rohan says he has envisioned a "living library" that continuously interacts with its readers and is not shackled by the ivory towers of an academic project. He claims he does not micro-manage the project and "it relies little, if at all, on any single individual"

He has planned for the centenary of Murty Library. Those who will celebrate it may not have been born yet, but both Rohan and Team Murty believe they are doing their bit in "elevating Indian classics as first-class members of world literature".

When he did, all he said was: "The world has lost a very fine person."While this is something unclear, the connection with Champa Mangat Rai, if any — and certainly tenuous — may have gone back to Lahore where my grandfather was teaching both at the university and at Kinnaird College. Chennai. Tamil Nadu Chief Minister MK Stalin has strongly criticised the BJP-led Union government's push for a "One Nation, One Election" policy, calling it an antifederal move that threatens India's democracy and diversity.

In a post on X, Stalin accused the BJP of attempting to impose a unitary form of governance under the guise of electoral reform."INDIA will resist the anti-federal & impractical 'One Nation, One Election' as it will push the country into the perils of a unitary form of governance, killing its diversity and democracy in the process," Stalin stated. The Chief Minister further alleged that the BJP's ultimate aim is to usher in a Presidential form of governance, which he said contradicts the spirit of the Indian Stalin accused the BJP of advancing the Constitution. Stalin argued that the proposal, if passed, would eliminate the system of periodic state elections, thereby undermining regional sentiments and destroying India's diversity. He emphasised that periodic elections serve as crucial checks and balances in the democratic process, as envisioned by



the Constitution's framers. "The proposed bill, if passed and implemented, will remove Stalin was amongst the first to criticise the the legal checks and balances put in place... to prevent the country from slipping into anarchy and totalitarianism," he warned.

#### Delhi freezes as temperature dips to 4.5°C, cold wave grips North India

Delhi Weather: People of Delhi-NCR woke up to a chilly morning on Monday with the minimum temperature slipping below 5 degrees Celsius for the second time in a row. The Air Quality Index (AQI) also deteriorated to the 'very poor' category.



New Delhi. Delhi-NCR residents on Monday woke up to another cold morning as the average minimum temperature dropped below 5 degrees Celsius for the second consecutive day. According to the India Meteorological Department (IMD), the national capital registered a minimum temperature of 4.5 degrees Celsius at 5.30 am. The temperature in certain areas of Delhi went even below 4.5 degrees Celsius. The minimum temperature in Pusa was recorded at 3.5 degrees Celsius, while in Ayanagar, the minimum temperature was recorded at 4 degrees Celsius.

At Najafgarh, the minimum temperature was slightly higher, at 6.2 degrees Celsius. Earlier on December 15, Delhi-NCR also witnessed a minimum temperature of 4.9 degrees Celsius.

In the coming days, Delhi may witness a further increase in the cold wave with shallow fog in various parts due to calm winds and high humidity, as the IMD. The weather department has also issued a cold wave warning for certain states of northern India, including Jammu and Kashmir, Punjab, Haryana, and western Uttar Pradesh, among other states.

A cold wave is officially declared in the plains when the minimum temperature falls to 4 degrees Celsius or below, or when it registers a drop of 4.5 to 6.4 degrees from normal. With temperatures hovering around these thresholds, the capital has seen biting cold mornings, forcing residents to bundle up against the chill.

Amidst the intense cold conditions, the air quality in Delhi and surrounding areas also deteriorated to the 'very poor' category on Monday due to unfavourable weather conditions and low wind speeds. According to the Central Pollution Control Board, the overall Air Quality Index (AQI) for the national capital was recorded at 334 at 4 am on Monday. The air quality slipped to the 'very poor' category on Sunday evening, with the AQI climbing to 307, up from 294 just hours earlier, which was at the higher end of the 'poor' category.

An AQI between zero and 50 is considered 'good', 51 and 100 'satisfactory', 101 and 200 'moderate', 201 and 300 'poor', 301 and 400 'very poor', and 401

#### Hollow gimmick: Jagan Reddy slams Chandrababu Naidu's 'Vision 2047'

Andhra Pradesh. YSR Congress Party (YSRCP) chief YS Jagan Mohan Reddy launched a scathing attack on Andhra Pradesh Chief Minister Chandrababu Naidu's 'Swarna Andhra 2047' vision, terming it a "publicity stunt" devoid of realistic goals.

In a social media post on Sunday, Jagan accused Naidu of using Vision 2047 as a ploy to mislead people. "There is no place for the state's needs, people's needs, and above all reality in Chandrababu's document," the former Chief Minister alleged.

Criticising Naidu's past plans like Vision 2020 and Vision 2029, Jagan described them as "failures" that brought no tangible benefits



to the state. He claimed Vision 2020 led to "farmer suicides, mass migrations, and rising unemployment," while Vision 2029 'did not deliver a single impactful

project". "Did he build a single medical college, hospital, or school? Did he create ports or improve agriculture? Did he generate jobs or invest in Andhra Pradesh's future? The answer is no," Jagan asserted.

The YSRCP supremo also dismissed Naidu's projection of achieving a USD 2.4 trillion GSDP by 2047 as baseless. He accused Naidu of causing consistent revenue deficits during his tenure and selling public assets under the guise of privatisation. Jagan contrasted his government's focus on welfare schemes and poverty eradication with what he called Naidu's attempts to "dismantle welfare schemes" and deepen societal

#### Delhi Assembly elections: BJP to take a leaf out of Maharashtra book on 30 SC seats



NEW DELHI. Encouraged by the success of its strategy in Haryana and Maharashtra elections, the BJP central leadership has solidified its plans for the upcoming crucial Delhi Assembly elections scheduled for February 2025.

As part of a carefully crafted strategy for Delhi, the party has developed a targeted approach to attract Scheduled Caste voters, who played a decisive role in shaping the results in over two dozen assembly constituencies. At the same time, the BJP's central electoral think tank is working to mobilize voters from the Poorvanchal region (Eastern Uttar Pradesh and Bihar), who have settled in across many assembly segments and are obtaining voting rights.

On Sunday, a senior party leader said, "Around 29-30 assembly segments have a significant presence of SC voters. They have been direct beneficiaries of free rations and other benefits from the Narendra Modi government. We are reaching out to them about how the BJP has supported their progress and will continue to do so if we replace the AAP in Delhi."

Another party leader said, "In the 70-member Assembly, 12 seats are reserved for SCs. The turnout of Dalit voters significantly influences the results in 17-18 other assembly seats. So our party will certainly need to extend its outreach to them.'

Sources said the BJP has appointed representatives from the SC community to win support. "A nameplate campaign, covering 60,000 houses, is now on," said a senior functionary. A source said the BJP recognises that 30 out of the 70 assembly seats have Dalit voters, comprising between 17% and 44% of the electorate. Outreach to these voters could alter the narrative against the ruling AAP in this election.

who was scheduled to pronounce the judgment on Monday (December 16), deferred the decision. "The next date for the verdict is January 8," the judge said. Kumar, currently lodged in Tihar Jail, attended

the hearing via video conference. The court had earlier framed charges under multiple sections of the Indian Penal Code (IPC), including 302



(murder), 147 (rioting), 395 (dacoity), and 436 (arson), after concluding that there was sufficient evidence to establish a prima facie case against the accused. According to the prosecution.

### AIADMK slams Centre for naming laws in Hindi, calls it indirect language

-AIADMK accuses the Centre of Hindi imposition through law names, and urges naming all laws in English. Opposition party criticises DMK on governance issues and vows to bring Palaniswami back as chief minister in 2026. Chennai. Tamil Nadu's main Opposition party, the AIADMK, on Sunday accused the central government of indirectly imposing Hindi by naming laws in Hindi and Sanskrit. In its executive committee and general council meeting held in Chennai, the party passed a resolution condemning the Centre's practice of renaming laws, urging that they be named in English instead.

The resolution pointed out that Hindi is only one among the 22 languages listed in the eighth schedule of the Constitution. In Tamil Nadu, the state continues to follow the two-language formula of Tamil and English.

"Under the circumstances, the central government naming laws in Hindi and Sanskrit can be considered only as an indirect imposition of Hindi. It is very condemnable that the Centre changed the



names of the three criminal laws that were already in English," the resolution read. The party further demanded that all laws enacted by the Union government should have English names.

The AIADMK also passed 16 other resolutions during the meeting. One of the key resolutions called for the subject of education to be brought back under the state list of the Constitution. The party also urged

the central government to ensure financial allocations to Tamil Nadu without any bias. The Opposition party took aim at the DMK government, accusing it of failing to fulfill promises made during the 2021 Assembly elections. AIADMK leader Edappadi K Palaniswami, in his address, slammed the DMK for holding Assembly sessions for only 113 days since coming to power, despite its promise of conducting proceedings for 100 days each year.

The DMK government should have conducted sessions for 400 days by now. This failure shows their fear of the AIADMK," Palaniswami said. He also questioned why the state government had not implemented its assurance of live broadcasting Assembly proceedings and accused it of "blacking out" speeches by AIADMK legislators.

#### Sensex, Nifty open lower as IT stocks drag; bearish trends continue

Benchmark stock market indices opened lower on Monday, dragged by a decline in IT stocks after having witnessed a very volatile session on Friday when it recovered after having lost nearly 1,200 points.The S&P BSE Sensex was down 279.70 points to 81,853.42, while the NSE Nifty50 lost 74 points to 24,694.30 as of 9:35 AM.

#### Wadia illegally sold 8.69% Tata Sons stake'

MUMBAI. A public interest litigation has alleged that Bombay Dyeing group chairman Nuslli Wadia has misappropriated 8.69% stake that FE Dinshaw Ltd owned in Tata Sons since the 1920s, and transferred the shares to the Shapoorji Pallonji group in the 1970s soon after he was made the administrator of the Indian trust, which owned the

Though the petition could not calculate the actual value of the share transaction, given that the Tata group is worth over \$150 billion today, the value involved could be around \$14 billion or R1.2 lakh crore. Dinshaw Trust, which was established by Edulji Dinshaw, the son of the senior Dinshaw, willed all its assets to two New York-based American charities.

The Indian assets of the trust included the 8.69% holding it had in Tata Sons, and over 1,000 acres of land around Malad in the northwestern suburb of the megapolis. Wadia claimed ownership over all these assets following an agreement on 1 August 2003. The petition also alleges that the agreement is



fraudulent since Bachoobai Woronzow, one of the three children of FE Dinshaw, a leading Parsi industrialist of the times, was fatally ill in a New York hospital on that day. She died on 12 August 2003. The trust was registered in New York because after the senior Dinshaw passed away in 1940, the two of his three surviving children—the son Edulji, and the daughter Bachoo-settled down in New York in the mid-1940s. Dinshaw Trust was founded by Edulji, and held a majority stake in FE Dinshaw Ltd, the company founded by his father.

The 8.69% shares of Tata Sons were held by FE Dinshaw Ltd, the company which acquired equity in Tata Sons following non-repayment of a R2 crore loan to the Tatas in the 1920s. The petition further contends that it is for the Serious Fraud Investigation Office (SFIO) to ascertain how the stake of Dinshaw Trust in FE Dinshaw was passed on to the Mistrys by Wadia and for what consideration. FE Dinshaw Ltd was renamed as Cyrus Investment in 2008, and is now the main investment arm of the Shapoorji Pallonji group, which began as a construction contractor with most of the orders coming in from FE Dinshaw.

The petition further alleges that Wadia has forged three key documents to transfer the assets of the Dinshaw Trust to himself. The Economic Offenses Wing of the Mumbai Police, which is investigating the matter under the supervision of the Bombay High Court, has found prima facie evidence of forgery.

#### We see an explosion of **MSME** credit this decade: UGRO MD

NEW DELHI. Shachindra Nath, Vice Chairman and MD, UGRO Capital, a tech-enabled small business loan platform, in an interaction with Dipak Mondal, says that the decade will see an explosion of MSME credit.

Why do you think South India is such a big market for NBFCs – be it SME finance companies, microfinance or gold loan companies?

Small businesses are an outcome of three things -one, prospering business, and second is stable governments, which are progressive. The third is the lending culture, the repayment behaviour. So, the repayment behaviour of, say, in Tamil Nadu or Telangana or Karnataka is much better than say a Punjab, UP or MP. Tamil Nadu is a bipolar political state, so it shifts between two parties. But the underlying economy actually continues to grow at a fast pace, irrespective of political dispensation. As for repayment behaviour, people take their loan fairly seriously in the South.

I keep saying that India is not one country purely from a lending perspective – South is a different market from the north. But that is now changing. There is this perception that the government at the

Centre is more focused on creating large corporations instead of focusing on small businesses?MSMEs are the largest employer of the country, after agriculture. And for India to continue growing, or even for the governments to stay in power, they have to provide employment. And that's why MSMEs are important for governments. If you look from 2014 to 2024, every year there have been some or other changes in policy to support MSME. During COVID, the government came up with schemes like an emergency credit line and partial credit guarantee -- all the schemes would support MSME. It was largely small businesses which received support from the government during Covid. There is a massive focus on MSMEs.

What are the factors helping expansion of credit to MSMEs?Credit to MSME is possible because of formalization. Before demonetisation, MSMEs generated large cash income without any proper formal record of the revenue. With the demonetisation, there has been a psychological shift. People now fear that having too much of income in cash is risky. Then when GST got implemented, it started forcing people to get their turnover side of the data into the formal system. The third factor (helping MSME credit) is democratisation of Indian banking with digital payments. On one side, small businesses are getting formalized, on the other side, lenders have the ability to look at this kind of data, and do credit. And that's why we keep saying that you will see an explosion of credit to MSME in this

### Withdrawal of EPF from ATM may take time

NEW DELHI. The plan for allowing withdrawal of employee provident fund (EPF) claims through ATM has a long way to go.Labour ministry sources have said that this is just an idea floated by the labour minister, and it needs a lot of deliberations between the labour ministry, EPFO and the banking regulator before it could be implemented.

The idea is to have a hassle-free claim settlement process as high rejection rates are becoming a headache for individuals, who keep their life savings with EPFO (Employee Provident Fund Organisations) for use after retirements or during emergency fund requirements.

However, the idea of allowing EPFO members to withdraw from ATM is not happening in the immediate future. The ministry has a vision to ease the claims process, and the idea is at a very early stage, says a labour ministry source. "Without the approval of the RBI, the banking regulator, the idea cannot be implemented. Besides, there are other several issues like frequency and limit of withdrawal that the EPFO needs to figure out before going ahead with the project," the labour ministry source told TNIE.

The ministry is also exploring the possibility of introducing a digital wallet, where the claimed amount could be kept and withdrawn from. "These ideas, including issuing ATM cards, cannot be implemented without a strong backing from the banking regulator and banks, the ministry source said, adding that anything like this is not possible in the immediate future.

Improving digital infra The EPFO has been trying to improve its digital infrastructure and ease the claims



process. Early this year, the EPFO implemented the first of the six modules of Central IT System (CITS) 2.01. This facility will reduce the time and effort while providing facilities such as online submission of application, validation of applications and transfer of past accumulations of the member.CITS 2.01 will replace the earlier system of physical submission with voluminous documents and allow the establishment to track its application with a tracking ID. More modules of CITS 2.01 are likely to be implemented from 1 January 2025.

The EPFO has reduced the rejection of claims to 25% till November 2024. In 2022-23, the combined rejection and return ratio was 34%, while in the year before, the claim rejections had touched 35%. Claims are rejected when the claimant is not eligible for the type of advance or withdrawal. Claims are returned if there is any deficiency. Returned claims can be resubmitted after corrections.

The labour ministry has claimed that the implementation of CITS 2.01 has increased the number of claims settled in the current financial year. During 2023-24, EPFO settled 4.45 crore claims

for an amount of R1.82 lakh crore. In the current financial year, 3.83 crore claims have already been settled for more than R1.57 lakh crore, the CBT was informed.

In FY25, 1.15 crore claims have been settled in auto mode, whereby requests for withdrawals for education, marriage and medical purposes are settled automatically. The limit for auto claims settlement facility has also been extended to R1 lakh from R50,000 which has also been extended to advances for housing, marriage and education.

#### NZ vs ENG: Ben Stokes faces fresh injury concern after limping off the field

New Delhi England Test skipper Ben Stokes faced a fresh injury scare after he limped off the field clutching his left hamstring on Day 3 of the third Test against New Zealand. The injury is particularly concerning as it involves the same hamstring he had torn earlier this year, which sidelined him from cricket for two months. England confirmed that the all-rounder had sustained a hamstring injury and his availability for the rest of the Test is still uncertain.

Stokes, bowling the 56th over of New Zealand's second innings, pulled up in visible pain after delivering just two balls, with the second delivery being hit for a boundary by Rachin Ravindra. After bowling the ball, Stokes immediately went



down clutching his left hamstring. The England skipper left the field limping, sparking immediate concern in the England camp. The painful expression on his face as medical staff treated him heightened fears about the severity of the injury. This incident marks another setback for Stokes, who only returned to international action in October during England's Test series against Pakistan. He had previously torn the same hamstring on August 11, 2024, while playing for Northern Superchargers in The Hundred. At the time, his injury had prompted widespread discussions about limiting his bowling workload to prevent further strain, especially given his importance as an allrounder. England's situation in the third Test has compounded the concern surrounding Stokes' injury. Despite leading the series 2-0, the visitors found themselves under immense pressure in Hamilton. New Zealand scored a commanding 347 runs in their first innings, while England's batting collapsed for just 143. The Black Caps, led by Tom Latham, extended their lead to a massive 474 runs before Stokes left the field.

Key contributions from Will Young and a century by Kane Williamson ensured that New Zealand dominated the proceedings, leaving England with a monumental task ahead. Stokes' absence will not only affect England's already struggling bowling attack but could also impact their chances of pulling

### AUS vs IND: Sunil Gavaskar suggests Sachin Tendulkar lesson to struggling Virat Kohli

New Delhi. Kohli appeared intent on being disciplined at the start of his innings on an overcast morning. However, he was lured into playing at a wide delivery from Josh Hazlewood, resulting in a thick edge safely pouched by wicketkeeper Alex Carey. Australia have consistently trapped Kohli with the line outside the off-stump during the series, exploiting his tendency to HOW TENDULKAR DELETED THE push and poke at deliveries away from the

Speaking to the broadcasters, Gavaskar recommended that Kohli study how Tendulkar decided to eliminate the cover drive from his game during the Sydney Test in 2004, which helped him tackle a similar happens in the middle is different. 

instance, a liability. Australian bowlers, particularly Brett Lee, Andy Bichel, and Jason Gillespie, devised a plan to exploit his off-side game, luring him into errors. Recognising this, Tendulkar made the unconventional decision to avoid playing the cover drive entirely throughout his innings. This required extraordinary mental strength, as it meant sidelining one of his signature shots. Tendulkar adjusted his technique and mindset, focusing on playing straight down the ground, working the ball off his pads, and prioritising leg-side scoring. By consciously eschewing the risky drive, he nullified

Australia's primary tactic to dismiss him. The results were spectacular. Tendulkar scored an unbeaten 241, one of the finest innings of



Virat Kohli began the current series in Australia with a century in Perth,

New Delhi Manchester City manager Pep Guardiola took full responsibility for his team's continued struggles after a late collapse led to a 2-1 defeat against Manchester United in the Premier League on Sunday. City had been leading until the 88th minute, when Bruno Fernandes equalised from the penalty spot. Just two minutes later, Amad Diallo stunned the reigning champions with a decisive goal, handing United a dramatic comeback victory.The result deepens City's alarming slump, as



last 11 matches across all competitions—a crisis that has left fans, players, and pundits alike searching for answers."I don't have a defence. I'm the boss, I'm the manager and I'm not good enough," Guardiola said, as quoted by Reuters. "I have to find a solution and I don't find a solution. It is as simple as that. I am not doing well, that is the truth.'

Guardiola, who had previously cited the relentless fixture schedule as a factor behind his team's mounting injury list, chose not to lean on excuses in an emotional and introspective post-match press conference. Instead, he acknowledged the need for

Mitchell Starc struck early, dismissing opener Yashasvi Jaiswal on just the second ball of the innings. Starc soon sent Shubman Gill packing with help from a stunning catch by



Mitchell Marsh, leaving India's top order in tatters. Adding to their troubles, Virat Kohli fell for a mere 3 runs, continuing his troubling pattern of nicking deliveries outside offstump—a trend increasingly exploited by Australian bowlers.

The setbacks didn't stop there for India. Rishabh Pant, the hero of previous Gabba heroics, managed just 9 runs before falling to Pat Cummins. This marked the third time out of five that Cummins had dismissed Pant in the ongoing Border Gavaskar Trophy, further amplifying India's struggles.he rain interruption following Pant's dismissal provided India with a brief respite to reassess their approach, though their position remained precarious. The repeated disruptions, however, broke the momentum for both sides, adding to the irritation visible on players' faces.th the score heavily tilted in Australia's favor and conditions testing everyone's patience, the weather added an unwelcome challenge to an already intense

# WI vs BAN: Mahedi, Mahmud star as Powell's heroics go in vain in 1st T201

Rovman Powell's heroic innings went in vain as Mahedi and Mahmud bowled Bangladesh to a 7-run win in St. Vincent on Sunday, December 9. Mahedi picked up 4 wickets and scored a vital 26 runs to help secure the win for his side.

New Delhi. Bangladesh edged out West Indies in a thrilling finish, holding on for a 7-run victory in the first T20I at the Arnos Vale Ground. Hasan Mahmud emerged as the hero, defending nine runs in the final over to secure the win in West Indies' first international match in St Vincent in a decade. Chasing 147, West Indies found themselves in trouble early on, reduced to 38 for 5 after a brilliant four-wicket spell from Mahedi

Hasan. Rovman Powell, however, kept the hosts in contention with a blistering 35-ball 60 that included four sixes and five fours, but his efforts fell just short. In the tense final over, West Indies needed 10 runs to win. Mahmud delivered under pressure, dismissing Powell and Alzarri Joseph to seal the game. Powell was caught behind off the first ball, handing Bangladesh captain Litton Das his fifth dismissal of the match. With eight runs required off the last two deliveries, Mahmud bowled Joseph to clinch Bangladesh's first T20I win against West Indies in six years, a victory that coincided with the celebration of Bangladesh's Victory Day back home. The game seemed to be slipping from Bangladesh's grasp midway through the chase. Powell, joined by Romario Shepherd at 61 for 7 in the 12th over, orchestrated a dramatic fightback. The duo hammered 15 runs off Rishad Hossain in



the 14th over before Powell exploded in the next over, taking Taskin Ahmed for three sixes in a 23-run assault. Powell's sixes showcased his range, with one over extra cover, another over point, and a third straight down the ground. With the asking rate reduced to eight runs per over, Tanzim Hasan conceded 12 runs in the 16th over, during which Powell reached his half-century off just 28 balls. Shepherd joined the act, hitting

a six off Rishad, but his dismissal in the 17th over, caught at deep midwicket off Taskin, put the pressure back on West Indies. Shepherd scored a quick 22 off 17 balls, but his departure left Powell with too much to do.

Bangladesh had earlier seized control of the match with a superb start. Taskin Ahmed struck with his first delivery, dismissing Brandon King for a duck.

Mahedi Hasan then removed Nicholas Pooran, who was stumped for 1, before accounting for Johnson Charles, who had hit two sixes in a costly over from Tanzim Hasan. Mahedi's impact continued in his final over as he removed Andre Fletcher, caught behind, and Roston Chase, who inside-edged a reverse sweep. He finished with exceptional figures of 4 for 13, leaving West Indies reeling and setting the stage for a dramatic finish.
