Simultaneous poll bills unlikely to be passed in Parliament: Digvijaya

New Delhi, Dec. 22: Congress Rajya Sabha member Digvijaya Singh has said he is doubtful that the 'one nation, one election' bills will be passed in Parliament. Talking to reporters in Madhya Pradesh's Agar Malwa district on Saturday night, Singh also denied the allegations against Leader of Opposition in the Lok Sabha Rahul Gandhi of "pushing and shoving" BJP MPs on Parliament premises on Thursday. The two 'one nation, one election' (ONOE) bills, including one requiring an amendment in the Constitution, lay down the mechanism to hold simultaneous elections and were introduced in the Lok Sabha on Tuesday after a fiery debate. The Lok Sabha on Friday referred the two bills on simultaneous polls to a joint committee of Parliament (JPC). To a question on the ONOE bills, Digvijaya Singh said, "The JPC has been constituted and I don't think that it will be passed." On Thursday, an FIR was registered against Rahul Gandhi at Parliament Street police station following the BJP's complaint, accusing him of physical assault and incitement after MPs Pratap Chandra Sarangi and Mukesh Rajput were injured. The Congress has strongly rejected the claim, alleging that BJP MPs pushed Congress chief Mallikarjun Kharge "physically manhandled' Gandhi. Asked about the accusations against Gandhi of "pushing and shoving" the BJP MPs, Singh termed them as completely false. "This is absolutely wrong. There was pushing and shoving between BJP leaders," the former state chief minister claimed. "One BJP MP fell on another. Both were injured. The one who fell said that Rahul Gandhi was standing in front of him. If he was standing in front, could he have pushed him?" he asked. Notably Rashtriya Swayamsevak Sangh chief Mohan Bhagwat recently expressed concern over the resurgence of several temple-mosque disputes and said certain individuals, after the construction of Avodhva Ram temple, seem to believe they can become leaders of Hindus by raking

Doorstep registration for women, elderly welfare schemes to begin on Monday: Kejriwal

New Delhi, Dec 22: AAP supremo Arvind Kejriwal announced that registration for the Delhi government scheme under which women will be provided a monthly assistance will begin on Monday. He also said registration for the Sanjeevani Yojana which will provide free treatment to people above 60 years of age will also begin along with it. In its 2024-25 Budget, the Delhi government had announced the Mukhya Mantri Mahila Samman Yojana scheme to provide Rs 1,000 per month to all women aged above 18. However, Kejriwal recently announced that the amount would be raised to Rs 2,100 if his party returns to power in the assembly elections, slated for February next year. Reacting to the announcement made on Sunday, the Delhi unit of the BJP said Kejriwal was "sell-

ing false dreams" as the AAP had made simi-

lar promises ahead of the Lok Sabha polls in

Delhi and assembly elections in Punjab but has not delivered them. Addressing a press conference, Kejriwal said, "The registration for the scheme will start tomorrow, and women don't have to go anywhere for registration. Our volunteers will come to your home and complete the registration." "There are to your doorstep. Across every area of Delhi, AAP has many daughters whose college education is interrupted after class 12 due to financial constraints. With this

Rs 2.100, they will be able to continue their studies and also help them pursue higher education," he added. The beneficiaries will need to show their voter identity cards, and all eligible women voters in Delhi will receive the benefits, he said. "You don't need to stand in any queues or waste your time. We will come created thousands of teams. These teams will come to your home and will do registration of all the women of

the house and give them a registration card (Kejriwal Kavach Card)," an official statement said. Kejriwal also announced that registration for the Sanjeevani Yojana will start on Monday, and elderly people will be registered at their homes by AAP volunteers. Earlier, the AAP supremo announced that the Sanjeevani Yojana would be launched to provide free treatment to people aged above 60 years after his party returns to power in Delhi. Delhi Chief Minister Atishi said on X, "I believe that around 35 to 40 lakh women may benefit from the 'Mahila Samman Yojana.' Similarly, I estimate that around 10 to 15 lakh senior citizens could benefit from the 'Sanjeevani Yojana.' This is a big step, and I encourage everyone to take full advantage of these schemes." On Monday, Kejriwal, party leader Manish Sisodia, and CM

Atishi will go to different areas of Delhi and fill the registration forms of the people, the party statement added. "The launch of the 'Kejriwal Kavach Card' is a guarantee of self-respect for every mother, sister, and daughter, care of the elderly, and a secure future for every family," Sisodia said in a post on X.

Tejashwi meets protesters, writes to Nitish for BPSC exam cancellation

Patna, Dec. 22: RJD leader Tejashwi Yadav on Sunday wrote to Bihar Chief Minister Nitish Kumar, seeking the cancellation of competitive exams conducted recently, under controversial circumstances, by the state's Public Service Commission. The former deputy chief minister, who had on late Saturday night visited the site in the state capital where candidates have been carrying out a roundthe-clock protest, shared on X a screenshot of the two page letter addressed to his ex-boss. Yadav, who is now the Leader of the Opposition, warned "many of the protesters I met last night have fallen ill. If anything untoward happens, the blame shall be on the government and the BPSC Chairman". Yadav had visited Gardani Bagh



locality where he was told by the protesters that they were opposed to the decision of the Bihar Public Service Commission to order re-exam only at Bapu Pariksha Parisar, one of the over 900 centres where, on December 13, the combined competitive exams were held. The young leader had told the protesters, "Be steadfast in your resolve. Rest assured that for every step you take, Tejashwi shall move forward with four paces." In his letter to the JD(U) supremo, the RJD leader said he agreed with the protesting candidates' contention that if an exam for some aspirants was held "on a different date, with a different set of question papers" there will be "no levelplaying field". Notably, hundreds of aspirants at the Bapu Pariksha Parisar had boycotted the tests, alleging that question papers had been leaked. The allegation met with a strong denial from the Bihar Public Service Commission (BPSC), which claimed the disruptions were caused by "anti-social elements" who had turned up as part of a "conspiracy" to get the exams cancelled. The commission, however, has ordered re-examination for about 5,000 candidates who were assigned to the examination centre. Yadav also drew the attention of the chief minister to the Iqbal Singh, who suffered a heart attack at the Bapu Pariksha Parisar and died on his way to a hospital, prompting the local administration to blame protesting candidates for the death and recommending that they be charged with murder.

INX Media case: Delhi court allows Congress MP Karti Chidambaram to travel abroad New Delhi, Dec 22: A Delhi court has grant-

ed permission to Congress MP Karti Chidambaram, an accused in the INX Media case, to travel to Austria and the UK between January 4 and 12, noting that he had never abused the liberty granted to him in the past. In an order passed on December 17, Special Judge Kaveri Baweja allowed Karti Chidambaram to travel to Vienna (Austria) and the UK to attend events related to his company and meet his daughter. "It is a matter of record that the applicant had sought permission of the court to travel abroad on numerous earlier occasions and the same was always granted to him even by the Supreme Court, as well as by this court and he never abused the above concession or liberty granted by the court," the judge said. The Enforcement Directorate (ED), represented by special public prosecutor NK Matta, opposed Karti Chidambaram's application, saying he might misuse the liberty. The Central Bureau of Investigation (CBI) had registered a case on May 15, 2017, alleging irregularities in a Foreign Investment Promotion Board clearance granted to the INX Media group for receiving overseas funding of Rs 305 crore in 2007 when Karti Chidambaram's father P Chidambaram was Union finance minister.

Modi govt's 'calibrated erosion' of EC's integrity: Kharge

New Delhi, Dec. 22: Congress president Mallikarjun Kharge on Sunday hit out at the government for tweaking an election rule to prevent public inspection of certain electronic documents, alleging it is part of the Modi government's "systematic conspiracy" to destroy the institutional integrity of the Election Commission. Kharge also said the Modi government's "calibrated erosion" of the ECI's integrity is a frontal attack on the Constitution and democracy. The government has tweaked an election rule to prevent public inspection of certain electronic documents such as CCTV camera and webcasting footage as well as video recordings of candidates to prevent their misuse. Based on the recommendation of the Election Commission of India (ECI), the Union law ministry on Friday amended Rule 93(2)(a) of the Conduct of Election Rules, 1961, to

restrict the type of "papers" or documents open to public inspection. Reacting to the development, Kharge said, "Modi government's audacious amendment in the Conduct of Election



Rules is another assault in its systematic conspiracy to destroy the institutional integrity of the Election Commission of India." "Earlier, they had removed the Chief Justice of India from the Selection

which appoints Election Commissioners, and now they have resorted to stonewall electoral information, even after a High Court order," he

said in a post on X. Everytime the Congress party wrote to the ECI, regarding specific poll irregularities such as voter deletions and lack of transparency in EVMs, the ECI has responded in a condescending tone and chosen not to even acknowledge certain serious complaints, Kharge said. "This again proves that the ECI, even though it is a quasi-judicial body, is not behaving independently," he said. "The Modi government's calibrated erosion of ECI's integrity is a frontal attack on the

Constitution and Democracy and we will take every step to safeguard them," Kharge said. Congress general secretary in-charge communications Jairam Ramesh had said the party would legally

challenge the amendment. Lok Sabha MP and Congress general secretary (organisation) KC Venugopal said the poll panel had chosen opacity and a progovernment attitude in its dealings thus far. According to Rule 93, all "papers" related to elections shall be open to public inspection. The amendment inserts "as specified in these rules" after "papers". Law ministry and ECI officials separately explained that a court case was the "trigger" behind the amendment. While documents such as nomination forms, appointment of election agents, results and election account statements are mentioned in the Conduct of Election Rules, electronic documents such as CCTV camera footage, webcasting footage and video recording of candidates during the Model Code of Conduct period are not covered. "CCTV coverage, webcasting of polling stations are not carried out under Conduct of Election Rules but are the result of steps taken by the ECI to ensure a level playing field," a former ECI official explained.

Akhilesh Yadav calls for PDA unity to secure political power, protect constitution

Lucknow, Dec. 22: Samajwadi Party president Akhilesh Yadav on Sunday underscored the need for unity among backward classes, Dalits, and minorities to secure political power and form a government committed to protecting the Constitution. He asserted that

those disrespecting Dr B.R. Ambedkar and his ideals must be ousted from power permanently. Amid nationwide protests against Union Home Minister Amit Shah's alleged derogatory remarks about Dr. Ambedkar, Yadav shared a pamphlet on a post on X, titled 'Discuss Baba Saheb's Dignity, Now PDA's message should reach every household.' In the pamphlet, Yadav accused "Prabhutvawadi takat" (dominant forces) of repeatedly disrespecting Dr Ambedkar and his legacy. "The pichre, Dalit and alpashankhak (PDA) community is determined to end

this cycle of humiliation and will unite to gain political strength, form their own government, and remove those who demean Baba Saheb and reject the Constitution," Yadav said. He highlighted that Dr. Ambedkar's advocacy for equality, emphasising that the Constitution he crafted dismantled exploitative and regressive ideologies. "The dominant classes have never accepted Babasaheb's principles of equality because as it challenged their monopoly over power and wealth," he added. The SP



leader accused the dominant classes of opposing reservation policies that empowered marginalized communities and gave them a sense of dignity. "Baba Saheb not only fought for the oppressed but also provided them with a protective shield in the form of the Constitution," Yadav said. He further alleged that these forces labelled the Constitution as "abhartiya" (un-Indian) and "against civilization" because it challenged their traditional hegemony and uplifted the 90 per cent oppressed population. Yadav said, "The reservation system united PDA communities by addressing centuries of exploitation and injustice. However, the dominant classes and their allies have consistently opposed it and hatched conspiracies to undermine it under the guise of reviewing the Constitution." Yadav expressed confidence that the PDA community's unity would pave the way for a fair caste census, equitable distribution of resources and an inclusive society. Search ongoing for leopard which killed 24-year-old in Vellore

VELLORE. Carcasses of goats left unburied may have lured the leopard, which killed 24-year-old S Anjali, into Drhuvam village near Veerichitipalli reserved forest area, said forest officials. They added that a search is ongoing to capture the leopard. Speaking to TNIE, the Assistant Conservator of Forests (ACF) S Manivannan said that more drone cameras are being deployed and neighbouring areas are being thoroughly inspected."In the course of the search, we found that villagers had left the carcasses of goats exposed, without burying them. This might have attracted the leopard to the village. We have informed the villagers that they must properly bury the goats," the ACF said. Once the leopard is captured, higher officials will determine

DPR for tunnel road to solve Bandipur night traffic ban

BENGALURU. Issues pertaining to the night traffic ban on the 24.7 km stretch passing through the Bandipur Tiger Reserve (BTR) have resurfaced again.

The ministry of road transport recently sought a Detailed Project Report (DPR) for constructing a tunnel road passing through BTR to ensure there is unhindered, round-the-clock traffic from Wayanad to Mysuru on the National Highway -212 (now called National Highway-766). The directions were issued after Union Minister for Road Transport Nitin Gadkari's meeting with John Brittas, a Member of Parliament from Kerala.

This has started a debate among conservationists and others on prioritising development over environment.National Highways Authority of India (NHAI) sources said they heard of the work, but are waiting for an official communication to start work on preparing the Detailed Project Report. A senior forest official, wishing anonymity, said, "The proposal to construct a tunnel road is not new. It was discussed two years ago after the idea of constructing an elevated road on the stretch was shelved due to environmental and financial

reasons."He said there is a need to find a permanent solution as it is regularly raised by the Kerala government. "Traffic volume has increased, but there is already a well-developed alternative route," the official said.In 2019, the Supreme Court issued orders banning the movement of traffic from 9 pm to 6 am on the 24.7 km stretch. The Karnataka High Court and SC acknowledged.

Golden Chariot chugs with slim crowd after six years

BENGALURU. After a gap of six years, the state's own luxury express train - Golden Chariot - chugged off from the Yeshwanthpur Railway Station's Platform-6 to Kochi on Saturday. The trip -Jewel of the South - was flagged off by Karnataka Tourism Minister HK Patil with 38 international tourists on board, while the train has 80-bed capacity. It is operated by the Karnataka State Tourism Development Corporation (KSTDC) along with the Indian Railway Catering and Tourism Corporation (IRCTC) and Indian Railways. IRCTC, which is marketing the train, has priced the ticket at Rs 67,961.79 (\$800).The five-night-sixday circuit will cover Bengaluru, Mysuru, Kanchipuram, Mahabalipuram, Thanjavur, Chettinad/ Karaikudi, Kochi and Chertala/ Mararikuluam in Kerala and back to Bengaluru. Patil told the media that Golden Chariot is a special train for South India as it showcases the culture, tourism, history, nature, wildlife and heritage of Karnataka, Tamil Nadu and Kerala."The train's operations had been stopped from 2018 due to financial reasons. Now it has been started in cooperation with agencies from the central government. We have entered into a partnership with the Railways and hope to make profits," he said.An IRCTC official said three special customised trips were made in 2020 and 2021, but the occupancy was very poor. "As a new feature, we have introduced a provision for people/.

Parcel bomb explosion injures three in Gujarat's Sabarmati

AHMEDABAD. Three men suffered injuries when a parcel delivered to the house of a Gujarat high court lawyer's clerk in the Sabarmati area on Saturday morning exploded at the time of delivery. Police said a personal dispute is the reason behind the blast at the house of Baldev Sukhadia in the Shivam Row House Society on the IOC Road.He worked with Hetal Barot, the wife of the prime suspect, Rupen Barot, also a resident of Sabarmati.Additional commissioner of police, Sector-1, Neeraj Badgujar, said Gaurav Gadhavi, the person who delivered the parcel, was also injured in the blast and was arrested. "As Gadhavi wanted to hand over the parcel to Sukhadia, the receiver noticed smoke coming out of the packet. Soon, the parcel exploded, leaving Gadhavi, Sukhadia and his cousin, Kirit Sukhadia, with injuries," Badgujar said.DCP, Zone-2, Bharat Rathod, said that the incident took place between 10.30am and 10.45am on Saturday. "Gadhavi said that his friend Rohan told him to deliver the parcel that he had received from Rupen Barot," said Rathod.In his complaint with Sabarmati police, Baldev Sukhadia, 56, said that a man last night came to his house to deliver a parcel, but as Sukhadia was not present, the delivery boy returned."My wife informed me about this, and today, around 10.45am, a delivery boy came to my house and told me he had a parcel for me. Since I hadn't ordered anything, I was suspicious and didn't accept the parcel. The delivery boy said that someone named Suresh had sent the parcel, but as I didn't know any Suresh, I asked for his and Suresh's phone numbers so I could verify. He said his phone was with someone in a rickshaw outside. While we were talking, smoke started



coming out of the bag," said Baldev Sukhadia in the FIR. Sukhadia told him to step back and talk, and at that moment, the bag exploded. "That blast blinded both me and my wife temporarily. After a while, I saw the man still standing there, and I caught him. He was injured in the hands due to the blast, and my cousin, Kirit, who was outside his house, also suffered injuries on his face. I received a minor injury on my left leg," said Baldev Sukhadia. People soon gathered on the spot. "Pieces of the bag, white clay fragments, razor blade pieces, cardboard pieces, and wires from a blue battery were found at the place," said a police official.

Sukhadia further said in the FIR, "I have been working for Hetal, an advocate at the Gujarat high court, for six years. Hetal married Rupen Barot, who lives in Godavari Apartments in D-Cabin, about 12 years ago. Rupen suspects an extramarital relationship between Hetal and me, leading to frequent arguments with her and

threats to me over the phone."Since March 2024, Hetal has been living with her father at Padmaprabhu Society on the IOC Road, Chandkheda, and has filed for divorce against THIRUVANANTHAPURAM. her husband in a family court. This has made Rupen angry with Baldev Sukhadia, stated the FIR.Sabarmati police registered a case of attempt to murder, causing grievous hurt, criminal conspiracy, and criminal intimidation under Bharatiya Nyaya Sanhita along with charges of the explosives act against Rupen and Gadhavi. After the blast took place, a team from the city crime branch searched the prime accused, Rupen Barot's house in Godavari Apartments, D Cabin locality. They found weapons, including explosive materials, blades, nails, two country-made pistols, and an ignition switch for the blast. A senior police officer said that one country-made pistol was in the making, and cops found a small manufacturing unit in Barot's house. Sources also said that Barot was there at the time of the incident, and he was sitting in an autorickshaw from where he might have ignited the remotely operated bomb.

A team of forensic experts was also called to Barot's house. The parcel blast in Sabarmati gave a chilling reminder of a similar blast that took place in Sabarkantha in May this year.

In that case, a man named Jayanti Vanzara, 34, also a photographer and a farm labourer from Karunda village in Sabarkantha's Khedbrahma taluka, killed 32-year-old Jitendra Vanzara and his 12-year-old daughter Bhumika over suspicion that Jitendra was having an affair with his wife. In that case, an autorickshaw driver dropped a parcel at Jitendra's house, which contained a bluetooth speaker.

Lack of facilities, 'public resistance' land Kerala in grip

of medical-waste crisis

Kerala is grappling with a medicalwaste crisis as incidents of illegal dumping in neighbouring states become a major concern. The dumping of medical waste in Tamil Nadu has landed the state under the scanner of the National Green Tribunal (NGT), which has reiterated its call for urgent measures to address the critical issue.According to sources, only 70 tonnes of medical waste generated daily in the state are being handled scientifically. And the fact that the health department and the state government have no clue as to the actual number of medical-waste generators is exacerbating the situation, they add.Currently, Kerala Enviro Infrastructure Ltd (KEIL) and Indian Medical Association's Image are the two agencies in the state processing medical waste. According to the IMA, only 60% of the total medical waste generated in the state is being managed scientifically, as per rules and regulations stipulated under the Biomedical Waste Management Rules 2016.

The state requires more medical waste management facilities, Image chairman Dr Abraham Varghese pointed out. "As per rules mandated by the National Pollution Control Board (PCB) and state PCB, Kerala has only two accredited agencies for managing biomedical waste. And 30-40% of medical-waste generators are managing their refuse illegally through unauthorised service providers," Dr Abraham told TNIE. According to available information, only 28,000 establishments avail the services of KEIL and Image.

In an effort to ensure the scientific handling of medical waste, the state government, jointly with the IMA, has moved to set up another plant in Adoor with the capacity to treat around 15 tonnes of medical waste daily."The process for execution of the project has been completed, including public

Significant errors have been found in the beneficiary list for the Wayanad landslide rehabilitation project, including the exclusion of many affected families and duplication of names, triggering protests by survivors. According to the Disaster Victims' Strike Committee, which is leading the protest, many genuine victims said they were left out of the list. The committee members alleged that the district administration data showed no survivors from 17 affected families, which is not the case. The errors and lapses have raised concerns about the integrity of the process, they said.Prepared by the sub-collector and published on Friday, the draft list of beneficiaries for the first phase of the rehabilitation project comprised 388 families. "We lost everything to the landslides - our home, land, and peace. And now we find our names missing from the list. It feels like we are invisible to the authorities," said Ahamed Koya from Mundakkai, who lost his house and



property in the July 30 landslide."In one ward, the same names appear twice, while our family's name doesn't appear at all. Is this what we deserve after surviving such a tragedy? They say they will fix the errors within 15 days. But how can we trust them when such big mistakes were made in the first place? We need justice, not just promises," he said. We've been protesting for days now, but it feels like no one truly understands our pain.

Greater Chennai Corporation floats bids for upkeep of 595 parks

CHENNAI. The Greater Chennai Corporation (GCC) has floated tenders for the maintenance of 595 parks across the city. The contracts, divided into three packages, cover 122 parks in the northern, 215 in central and 258 in southern regions. The estimated cost for maintenance over next three years is Rs 46 crore. The move comes after the earlier contracts expired some months ago. The initiative aims at elevating the parks by integrating advanced technology, eco-friendly practices and proper maintenance. The agency bagging the contract will be responsible for works like cleaning, gardening, sanitation and security arrangements. The bidder will develop an AI-integrated web-based mobile app to enhance monitoring and transparency. The app will feature pre and post-cleaning status updates with images and videos uploaded every day. It will also alert the personnel deployed about deficiencies in



services. Security service will operate 24/7, ensuring safety, regulating access and preventing unauthorised activities. Biometric attendance for staff and QR codes at park entrance for visitor feedback will be established. Eco-friendly practices such as composting garden waste and using biodegradable materials will be prioritised. As many as 3,461 personnel, including sweepers, gardeners, security staff and electricians, will be deployed across the parks.

This ancient art is not only empowering local communities but also attracting significant attention from across the country, with demand for this silk soaring.In the erstwhile Adilabad district, the government is actively encouraging landless farmers, particularly tribals who depend on forest resources, to take up Tasar silkworm rearing as a sustainable livelihood.Mancherial district has emerged as the leader in Tasar cocoon production in Telangana, with its natural flora spread across 2,100 hectares, providing the perfect environment for rearing silkworms.

Tasar silk is gaining recognition for its natural colour and lustre, making it a sought-after and eco-friendly fabric.For landless tribal farmers living on the fringes of forests, Tasar cultivation offers a lifeline. With no investment required, these

farmers are earning between Rs 30,000 and Rs 40,000 annually from silkworm rearing. The district supports 575 farming families, with Kotapally mandal leading the way at 1,100 hectares involving 325 families. Other notable contributions come from Vemanpally (400 hectares, 80 families), Chennur (589 hectares, 125 families), Nennel (10 hectares, five families) and Kannepally (100 hectares, 40

SUV crashes into eway divider after track rams it; 1 held

Gurgaon. A truck bearing a Rewari registration number crashed into an SUV on Dwarka Expressway on Saturday. The accident occurred near Sector 37D, where the truck driver, while attempting to overtake other vehicles, collided with the black SUV.

Although the SUV's occupants escaped with minor injuries, their vehicle suffered significant damage after hitting the divider. A police official said the truck, which was traveling from Hayatpur, was cruising at over 80kmph.Police launched an immediate search and intercepted the runaway truck on the Delhi-Jaipur highway. Both the vehicle and its driver were taken to Kherki Daula police station for further investigation.

According to police, several other vehicles had to swerve sharply to avoid a collision with the truck, the screeched to a halt after the collision. Police said they had initiated legal proceedings against the truck driver. "Charges are being filed for reckless driving, endangering public safety, and causing damage to property," an official said.

Staffer arrested for stealing Rs 3.5L from DLF Mall's outlet

Noida. A 19-year-old employee of an outlet in DLF Mall was arrested for allegedly stealing Rs 3.5 lakh on Saturday. In a complaint, the shop's owner Amit Kumar claimed he found money missing around 6.30 pm on Friday while checking a locker where cash is usually kept.Police registered a case under BNS Section 305A (theft in a dwelling house, place of worship, or means of transportation) at Sector 20 police station after a complaint was filed and checked surveillance footage that showed a man, allegedly one of the employees, Anish, using a key to open the shop's shutter and taking the money. The police traced Anish to Khoda Colony in Ghaziabad and arrested him."The suspect was identified after a thorough analysis of CCTV footage, said additional DCP (Noida) Manish Kumar Mishra. E-comm delivery exec held for mobile thefts after gunbattle

Noida. A 23-year-old man, allegedly behind a series of mobile thefts in the city, was arrested following a gunfight near Sector 83 metro station on Saturday.

The suspect, Sumit Gupta, who suffered a leg injury during an exchange of fire with police, works as an ecommerce delivery executive. Police recovered a .32 bore unlicensed pistol with ammunition, three stolen mobile phones, and a black Splendor Plus motorcycle without registration plates, allegedly used in the crimes.According to police, a team from Phase 2 police station, conducting vehicle checks near Yakubpur red light, had flagged down Gupta as he was riding an unregistered motorcycle. The accused allegedly tried to dodge the cops. When cops chased him to Sector 83 metro station road, he abandoned the bike and fled on foot."The suspect fired at the police in an attempt to escape. Officers responded in selfdefence, injuring him in the leg. Gupta is originally from Badaun district and is at present residing in Bhangel," DCP (central Noida) Shakti Mohan Awasthi said. Preliminary investigations also revealed Gupta worked as a delivery agent for a quickcommerce company. Police believe Gupta's arrest could help solve several recent mobile theft cases in the recovered devices, potentially resolving recent complaints of theft under similar circumstances.

DCP Awasthi confirmed Gupta's history of criminal activities, including two prior cases registered at Phase 2 police station under BNS Section 303(2). "We are investigating his potential links to a larger mobile theft network in the region," Awasthi added.

Forest Cover Down, But City Bit Greener

New Delhi. A marginal increase of 4.9 sq km has taken Delhi's green cover to 371.3 sq km, according to India State Forest Report 2023, released on Saturday. The forest cover reduced by a tiny fraction but tree cover improved, leading the report to state that 25% of Delhi's total geographical area of 1,483 sq km was under green cover in 2023. The biennial report by the Forest Survey of India was released by Bhupender Yadav, Union minister for environment, forest and climate change. The report found that the city's forest cover saw a slight reduction in 2023 by 0.1 sq km compared with 2021, going down to 195.28 sq km in 2023 from 195.36 sq km two years earlier. However, the city's tree cover rose from 171.1 sq km in 2021 to 176 sq km in 2023, thus putting around 11.9% of the geographical area of Delhi under tree cover. Forest cover has been defined as all areas having tree cover with canopy density more than or equal to 10% and above, and area more than or equal to one hectare. Tree cover is the area covered by trees outside the recorded forest areas. The report changed its methodology this year and revised data for 2021 too, so while tree cover and forest cover in the report released in 2021 showed forest and tree cover at 147 sq km and 195 sq km, respectively, the 2023 report modified the data.

In Sept, the Supreme Court pulled up Delhi govt's forest department for not apprising it of any comprehensive measures taken to enhance the capital's green cover. According to the report, Maharashtra has the maximum tree cover (14,524.9 sq km) followed by Rajasthan (10,841.1 sq km) and Uttar Pradesh (8,950.9 sq km). However, in terms of percentage of geographical area, Chandigarh had the maximum tree cover (18.6%) followed by Delhi (11.9%) and Kerala (7.5%).Of Delhi's forest cover of 195.3 sq km, very dense forest comprised 6.5 sq km, moderately dense 53.6 sq km and open forest, 135.3 sq km in 2023. Among the 11 districts, New Delhi, with a forest cover of 48.6 sq km in 2023, reported the highest reduction by 0.9 sq km from 2021. A very dense forest is one with a canopy density of 70% or more. Moderately dense forests have a canopy density between 40 and 70%, while open forests have a canopy density between 10 and 40%. A forest official said, "he green cover in Delhi has increased to 25% of the geographical area. Efforts, including plantation drives and compensatory plantation, have borne fruit."Experts, however, expressed concerns about the methodology.

Upset with physical classes, 12-yr-old sends bomb threat mail to school

Gurgaon. Police have identified a 12-year-old student who allegedly sent a bomb threat to his own school in Sector 65, hoping it would switch to online classes.

The threat, sent via email on Dec 18, prompted imme diate police action and investigation.ACP (cyber) Priyanshu Diwan said after they traced the email's IP address, it led them to house of the student. Asked why he had sent the threat mail, the boy apparently told the cops he was upset about physical classes and wanted them to be switched to the online mode.After the mail last week, the school authorities informed the Cyber Crime police station (south), prompting an immediate search of the compound. Over the past few days, multiple schools across Delhi NCR have received bomb threat mails, all of which were found to be hoax. Scholarship For DalitsIn City To Study Abroad

New Delhi. As part of his series of "guarantees" being announced ahead of the assembly elections in the capital AAP national convener Arvind Kejriwal on Saturday announced 'Dr Ambedkar Samman Scholarship Yojana promising to cover the entire cost of travel, accommodation and tuition fees, besides other costs, for Dalit stu dents from Delhi pursuing higher education at top inter national universities. Addressing a press conference Kejriwal said the scholarship will be a comprehensive ini tiative. "I don't want any child from the Dalit community 08252 Ex. Varanasi on 27.01.2025 (Monday) to be deprived of higher education because of shortage of funds...Delhi govt will cover all their expenses, including tuition fees, travel and other costs," the AAP chief said. This is Kejriwal's fourth guarantee ahead of the assembly polls, which are likely to be held in Feb. The former Delhi CM has already promised insurance and other financial assistance for auto-rickshaw drivers, Rs 2100 for women and free treatment for Delhi voters aged above 60 in private and state-run hospitals if AAP forms govt again. Kejriwal said the scheme will also be applicable to Dalit children of govt employees, who cannot afford to send their children abroad for education without a scholarship. He added that despite financial constraints, Ambedkar earned two doctorates from foreign university ties where it is extremely tough to get admission even today. Referring to a statement by Union home minister Amit Shah in Parliament earlier this week, the AAP chief alleged that the BJP leader had "insulted and made fun" of Babasaheb Dr Ambedkar. "Crores of people who love Ambedkar were deeply pained....This is our way of empowering the Dalit community and honouring Babasaheb Ambedkar's legacy," Kejriwal said, speaking to reporters at the AAP headquarters."

Applauding the scheme, chief minister Atishi said Kejriwal had consistently allocated 25% of Delhi's budget to education in the past 10 years. "He made govt schools better than private schools, gave children from poor families an opportunity to clear competitive exams such as JEE and NEET and enabled students in Delhi govi schools to go abroad to study and learn French," she said. Senior AAP functionary and former education minis ter Manish Sisodia posted on X that Dr Ambedkar Samman Scholarship was "not just a scheme but a historic step, laying the

Seven Indians injured in German Christmas market attack

World. Seven Indians have been injured in the deadly car-ramming attack in the eastern German city of Magdeburg and the Indian embassy in Berlin is providing them all possible assistance, official sources said on Saturday night. A 50-year-old man drove his car into crowds at a Christmas market on Friday evening in Saxony-Anhalt state's Magdeburg, leaving at least five people, including a nine-year-old, dead and nearly 200 injured, according to German authorities. Three out of seven injured Indians have been discharged from hospital, the sources cited above said. The Ministry of External Affairs (MEA), condemning the "horrific and senseless" attack, said the Indian mission in Germany is in contact with Indians injured.

It, however, did not specify the number of injured Indians. The Indian embassy in Berlin said it is maintaining close contact with Indians who have been injured.In a statement, the MEA condemned the attack and said the Indian mission is rendering all possible assistance to the Indians injured in the incident."We condemn the horrific and senseless attack at a Christmas market in Magdeburg, Germany," the Ministry of External Affairs (MEA) said."Several precious lives have been lost and many have been injured. Our thoughts and prayers are with the victims.""Our Mission is in contact with Indians who are injured, as well as their families, and rendering all possible assistance," the MEA said.

Two US pilots shot down over Red Sea in 'friendly fire' incident: military

WASHINGTON. Two US Navy pilots were shot down over the Red Sea early Sunday in "an apparent case of friendly fire," the American military said

Both pilots were recovered alive but "initial assessments indicate that one of the crew members sustained minor injuries," the United States Central Command said late Saturday local Florida time -where CENTCOM is headquartered."This incident was not the result of hostile fire, and a full investigation is underway."CENTCOM said the guided missile cruiser USS Gettysburg "mistakenly fired on and hit the F/A-18" fighter aircraft, which was flown by the Navy pilots off another ship, the USS Harry S. Truman. The potentially disastrous mistake underscores the dangers of a mission the



United States has been involved in for more than a year as Yemen's Houthi rebels have repeatedly targeted merchant vessels in the Red Sea and Gulf of Aden that they say are Israeli-linked.On Saturday the United States said it struck targets in Yemen's rebelheld capital, hours after a Houthi rebel missile wounded people in Israel's commercial hub Tel Aviv.American forces also shot down multiple Houthi drones and an anti-ship cruise missile over the Red Sea, it said.

At Least 10 Killed In Church Stampede In Nigeria's Capital

Abuja. At least 10 people, including four children, were killed in a stampede during a relief item distribution at a local church in the Maitama district of Abuja, the Nigerian capital.

Josephine Adeh, spokesperson for the police in the Federal Capital Territory, said in a statement that eight others sustained varying degrees of injuries when the distribution of relief items, including food and clothing ahead of Christmas celebrations, turned chaotic Saturday at the Holy Trinity Catholic Church in Maitama. "Four of the injured had been treated and discharged, while the remaining victims are currently receiving medical care," Adeh said, noting the police



successfully evacuated "a crowd, numbering over a thousand." Padre Mike Nsikak Umoh, spokesperson for the Catholic Secretariat of Nigeria, earlier told reporters that the event attracted more than 3,000 people from nearby villages and low-income suburbs. Following the "tragic incident," the "palliative distribution" was suspended, he said. According to witnesses, many attendees arrived as early as 4 a.m. local time, despite the event being scheduled to start between 7 a.m. and 8 a.m. Saturday, Xinhua news agency reported. In a separate statement, Nigerian President Bola Tinubu confirmed another stampede Saturday morning in Okija, a town in the southeastern state of Anambra, where a philanthropic initiative to distribute rice to locals also turned fatal. "The two tragedies claimed many lives and left many others injured," Tinubu said, canceling his official duties for the day in honor of the victims. Highlighting an earlier stampede in the southwestern city of Ibadan on Wednesday, which claimed at least 35 lives and left six critically injured, the Nigerian leader called on states and local authorities to implement strict crowd control measures nationwide.

Bangladesh commission finds India's 'involvement in enforced disappearances'

DHAKA. An inquiry commission formed by Bangladesh's interim government has said that it has found India's 'involvement' in incidents of 'enforced disappearances' during deposed prime minister Sheikh Hasina's regime, the state-run news agency BSS reported on Saturday.

The Bangladesh Sangbad Sangstha (BSS), quoting the Commission of Inquiry on Enforced Disappearance, said that the Indian involvement in Bangladesh's system of enforced disappearances is a matter of public record. The news report said that according to the five-member commission headed by retired Supreme Court judge Mainul Islam Chowdhury, there was a 'persistent suggestion in law enforcement circles' that some prisoners might still be languishing in Indian jails.

We recommend the Ministries of Foreign and Home to extend their best efforts to identify any Bangladeshi citizens who may still remain incarcerated in India. It is beyond the jurisdiction of the commission to follow this trail outside Bangladesh," the commission said. The commission said it found intelligence information about the practice of captive exchanges between India and Bangladesh and the possible subsequent fate of detainees. The commission cited two highly publicised cases that provide valuable insights into how such operations were carried out.

"One was the case of Shukhranjan Bali, who was abducted from the Bangladesh Supreme Court premises and resurfaced subsequently in an Indian jail, and the other was of Bangladesh Nationalist Party (BNP) leader Salahuddin Ahmed," the commission said. The commission said BNP leader Ahmed's case exemplifies certain practices of the Bangladesh-India rendition system. It said that while hiding at a house in Dhaka's Uttara area in 2015, he recounted being imprisoned in a barren cell, where a hole in the ground served as a toilet."The blanket provided to him bore the letters "TFI", indicative of "Task Force for Interrogation," it added.During that period, the commission said the only operational TFI centre that they knew of was managed by Rapid Action Battalion (RAB) Intelligence Wing working under the aegis of RAB Headquarters.



The commission said that since then, they visited this location and confirmed that RAB Intelligence Wing still controls access to it."However, the interior of the facility was thoroughly decimated some time ago, the news report said quoting the commission.Last week, the five-member commission submitted an interim report titled "Unfolding The Truth" to Chief Adviser Professor Muhammad Yunus.

The commission estimated that there would be more than 3,500 enforced disappearances. Besides the chairman, the commission comprises Justice Farid Ahmed Shibli, rights activist Nur Khan, private BRAC University teacher Nabila Idris and rights activist Sajjad

Hossain. Hasina, 77, fled to India on August 5 after unprecedented anti-government protests. The student-led Monsoon Revolution under the banner of 'Students Against Discrimination' succeeded in toppling Hasina's 16-year regime, propelled by fervent demands for change and accountability. The chief adviser's press wing had claimed the commission also found the involvement of the deposed prime minister's now absconding defence adviser, retired major general Tarique Ahmed Siddique, a now sacked major general and two senior police officers and several other senior officials in the cases of enforced disappearance. The news report said that the police's elite anti-crime Rapid Action Battalion (RAB), which draws men from army, navy, air force and regular police and other law enforcement agencies had collaborated with each other to pick up, torture and keep victims in detention.

The commission simultaneously proposed the abolition of the RAB alongside scrapping or thoroughly amending the Anti-Terrorism Act, 2009.Commission member and rights activist Sajjad.

Russia's Tatarstan Declares Emergency After Ukrainian Drone Attacks

Moscow. Russia's Tatarstan Republic declared a state of emergency for government bodies and emergency response units to manage the aftermath of Ukrainian drone attacks. "The head of Tatarstan has signed an order imposing a special emergency mode for government agencies and the Ministry of Emergency Situations. This status is necessary to swiftly handle the consequences of the attacks in accordance with the law," the press service of Tatarstan President Rustam Minnikhanov said on Saturday. "The order applies exclusively to those involved in the response efforts and does not affect the general population." On Saturday, eight drone strikes were reported in Tatarstan's capital city of Kazan, six of which targeted residential buildings. Preliminary reports indicated there were no injuries,

Xinhua news agency reported. Tatarstan's governor, Rustam Minnikhanov, confirmed six drones

struck residential buildings, one hit an industrial site, and another was shot down over a river.

The attacks, which Ukraine didn't acknowledge in keeping with its security policy, come after a Ukrainian attack on Friday on a town in Russia's Kursk border region using US-supplied missiles killed six people, including a

France Jails 8 Accused Who **Beheaded Teacher For Showing** Prophet's Caricature

Paris. A French court sentenced eight people to prison terms ranging from one to 16 years for their roles in a hate campaign that culminated in the murder of a teacher who had shown caricatures of the Prophet Mohammad in class, local media reported.

Days after Samuel Paty, 47, showed his pupils the caricatures in October 2020, an 18-year-old Chechen assailant stabbed and beheaded him outside his school in Conflans-Sainte-Honorine, near Paris. The assailant was shot dead by police moments after.

Among those convicted on Friday was the father of a student whose false account of Paty's use of the caricatures triggered a wave of social media posts targeting the middle-school teacher. The court sentenced Brahim Chnina to 13 years in prison for criminal terrorist association, according to broadcaster Franceinfo. Chnina had published videos

Both had denied wrongdoing, according to Franceinfo.Last year, a court found Chnina's daughter and five other adolescents guilty of participating in a premeditated conspiracy and helping prepare an ambush.Chnina's daughter, who was not in Paty's class when the caricatures were shown, was convicted of making false accusations and slanderous comments. French media reported that the 13-year-old made the allegations after her parents questioned why she had been suspended from school for two days.

According to the Washington-based lender, the 500-



million-dollar Second Bangladesh Green and Climate Resilient Development Credit will support reforms to help the country's transition to green and climate-resilient development, Xinhua news agency reported. The 379-million-dollar Health,

Nutrition, and Population Sector Development Program-For-Results will help improve access to quality health and nutrition services and build resilient health systems in Sylhet and Chattogram divisions. The 280-million-dollar

Chattogram Water Supply Improvement Project will provide safe water through new and rehabilitated piped water connections to over 1 million people in Chattogram. It will build about 200,000 new household water connections and provide improved sanitation services to about 100,000 people in low-income communities. This project is part of a World Bank South Asia regional initiative or program of programs to provide Water, Sanitation and Hygiene (WASH) services to about 100 million people across the region by 2035. Woman kills son by slitting throat, attempts suicide in Chennai

CHENNAI. A 31-year-old woman allegedly slit the throats of her two sons aged four and one-and-a-half, before attempting to die by suicide in Kilpauk on Saturday. While the younger son, Punith Kumar, succumbed to his injury, Divya and Lakshan Kumar are receiving treatment at Kilpauk Medical College (KMC).According to the police, Divya married Ramkumar, an employee of a private courier firm, in September 2019. They had some differences and the woman along with their two sons, moved out from their house in Perungalathur two months ago. They had since been living with Divya's parents in Kilpauk.

Divya took her sons and locked themselves up in a room on Saturday immediately after



a phone conversation with Ramkumar, a police source said. Sensing something amiss, her aunt Padmavathi tried to open the door forcefully.

Incessant downpour affects paddy crops, Odisha Government seeks report

BHUBANESWAR. Even as paddy procurement is underway in many districts, the low-pressure induced incessant rains have caused widespread damage to standing paddy and vegetable crops in large parts of the state. Maximum rain-related loss is apprehended from coastal pockets where vast stretches of farmlands with harvest-ready paddy crops are waterlogged.

While reports on crop situation from the districts are still awaited, principal secretary of Agriculture and Farmers' Empowerment department Arabinda Padhee took stock of the situation on Saturday and asked district officials of the department to send in their report by Sunday, official sources said. The meeting was informed that rainfall warning was issued to Ganjam, Gajapati, Kendrapara and Jagatsinghpur with an advisory to farmers on measures to be undertaken to protect the crops and their

Khurda district which received the maximum rainfall of 75 mm in the last 24 hours reported maximum crop damage followed by Ganjam, Jagatsinghpur, Kendrapara, Puri and Cuttack districts. The unseasonal rains also damaged vegetable crops particularly cauliflower and recently planted potato seeds. However, the showers will help groundnut crops the most, sources in the department said.

Meanwhile, the state government has assured that compensation will be paid to farmers whose paddy got damaged at the mandis during the procurement process.

Kerala officials transport waste from Tamil Nadu villages back to their state

TIRUNELVELI. In a historic move, Kerala officials, including those from the Kerala State Pollution Control Board (KSPCB) and Thiruvananthapuram Corporation, visited six sites in Tirunelveli villages where Kerala's biomedical, plastic, food, and other wastes had been illegally dumped. The officials began emoving the waste with 16 Kerala-based trucks to transport it back to their state, following directives from the Southern Bench of the National Green Tribunal (NGT), which took suo motu case based on TNIE's report. This marks the first time in history that the waste dumped in Tamil Nadu by Kerala is being sent back to its original state. The Kerala team, led by Dr Gopukumar, Public Health Officer of Thiruvananthapuram Corporation, arrived at the Government Girls' High School in Nadu Kallur at 8.55 am for discussions with Tamil Nadu officials, including Cheranmahadevi Sub-Collector Arpit Jain, Tirunelveli Assistant Collector (Training) Ambica Jain, tahsildars, block development officers, and police inspectors. Officials from both states formed six teams to visit the sites where the waste was dumped. At 9.50 am, excavators began loading the waste onto trucks. The illegally dumped waste was discovered in Kodaganallur, Palavoor, two sites in Kondanagaram, Sivaniyapuram.

Two teens, thousands of books, mission to rewrite futures

MADURAI. In the urban jungle of Chennai, where childhood dreams often wither under the scorching sun of inequality, two teenagers rose to defy the odds. Aditi Srivatsan and Neha Govindarajan knew the stakes were high. Failure was not an option. Their weapon of choice: books, each page a seed of hope, ready to blossom in the most barren of landscapes.

In 2023, Aditi and Neha, both 17 years old and residents of Chennai, set out to bridge the educational divide for underprivileged children. This passion culminated in the Blue Lilac Foundation, a movement devoted to collecting and distributing books to schools that lacked resources. Collaborating with local organisations and homeowners' associations, they managed to collect and donate around 4,700 books.he seed for this initiative had been planted years ago in Neha's heart. "My grandmother was forced to abandon her education after the fifth grade due to societal pressures," Neha recalled.

"She would often share her unfulfilled thirst for learning. That stuck with me, making me realise how many children still lack access to basic resources." It was from these reflections that the idea of the Blue Lilac Foundation was born. When Aditi proposed collecting books for underprivileged children, Neha initially hesitated. "But Aditi reminded me that one doesn't need to wait until their thirties to engage in social service. So, we decided to act," Neha explained. Their first step took them to Lancor Apartments in Sholinganallur, a posh housing complex. Nervous at first, they nevertheless approached residents to collect books, explaining their vision. To their delight the residents responded enthusiastically, donating



generously. By June 2023, they had amassed 350 books, ranging from textbooks to fiction, which they donated to Sarojini Varadappan Girls School in Chennai.For Aditi, the inspiration came from her grandfather, AR Sridhar, a retired officer from the Reserve Bank of India, who instilled in her a lifelong commitment to giving back. One day, while sorting through old books on his bookshelf, Aditi realised that over 100 of her schoolbooks were gathering dust. That's when she knew they had to do something bigger.

The duo's efforts didn't stop at one book drive. Their next milestone was a visit to the New Hope New Life Orphanage, home to girls from marginalised communities, including daughters of farmers and daily wage workers. Aditi recalled one moment that left a lasting impression. A young girl, barely seven, eagerly asked them a flurry of questions. "Who invented the telephone?" "Why do elephants

weigh so much?" "Who made the first light bulb?" "Her curiosity was boundless," Aditi said. "It reminded us why we started this journey."The impact of their work didn't stop with books. Recognising the need for more, Aditi and Neha decided to tackle two critical issues: English proficiency and financial literacy. "Many students in government-aided schools struggle with English," Neha explained. "But it's not just about knowing the language — it's about building confidence. These girls often hesitate to speak for fear of making mistakes.

We want to change that." They are working with educators to develop an English curriculum that emphasises conversational skills and practical usage. Financial literacy became another area of focus. "The ability to manage money wisely can change lives," Aditi said. "We're teaching them how to budget, save, and identify scams. These lessons can protect them from exploitation and empower them to secure their futures."This initiative has inspired many students from local schools to organise their own book drives, creating a ripple effect that promises to reach even more children.

'It's incredible to see how one idea can spark so much action," Neha said. The response from the community has been overwhelming. In the weeks following their initial book drive, local schools and apartment complexes began reaching out to Aditi and Neha, eager to get involved.As Aditi and Neha continue their journey, they are not just turning pages in books but also rewriting the stories of countless lives. Each book becomes a doorway to new opportunities, and every child represents a spark of potential waiting to ignite.

Golden Chariot chugs with slim crowd after six years

BENGALURU. After a gap of six years, the state's own luxury express train - Golden Chariot chugged off from the Yeshwanthpur Railway Station's Platform-6 to Kochi on Saturday.

The trip - Jewel of the South - was flagged off by Karnataka Tourism Minister HK Patil with 38 international tourists on board, while the train has 80-bed capacity. It is operated by the Karnataka State Tourism Development Corporation (KSTDC) along with the Indian Railway Catering and Tourism Corporation (IRCTC) and Indian Railways. IRCTC, which is marketing the train, has priced the ticket at Rs 67,961.79 (\$800).The five-night-six-day circuit will cover Bengaluru, Mysuru, Kanchipuram, Mahabalipuram, Thanjavur, Chettinad/ Karaikudi, Kochi and Chertala/ Mararikuluam in Kerala and back to Bengaluru.

Odisha's forest size grows but tribal districts lose green sheen BHUBANESWAR. Odisha is among the forest cover reduced to 2,376.91 sq km that reported a decline in their green

overall growth in forest size but the positive news fails to betray the fact that a number of tribal districts have lost green cover. The India State of Forest Report (ISFR) 2023, which was released on Saturday, reveals that Odisha's forest size, excluding the tree cover, increased to 52,433.56 sq km in 2023 from 52,281.67 sq km in 2021, registering a growth of 151.89 sq km during the

As per the report, the state's forest and tree cover that stood at 58,038.44 sq km in 2021 increased to 58,597.01 sq km in 2023, posting a growth of 558.57 sq km over the previous assessment. With this increase, Odisha's current forest and tree cover stands at 37.63 per cent of its total geographical area of 1,55,707 sq km. A total 33,040.47 sq km forest cover falls under recorded forest area, while the remaining 19,393.09 sq km is outside the recorded forest area of the state, the report stated.

However, a comparison drawn between two biennial reports, ISFR 2021 and 2023 shows that at least 12 districts, mostly the tribal-dominated, have recorded a decline in their forest cover. Kalahandi reported the highest 61.94 sq km drop in its forest cover over the previous assessment. From 2,438.96 sq km in 2021, the western Odisha district's

Chautala was an amiable ally, a fierce opponent

WITH the death of former CM Om Prakash Chautala, an era in Haryana politics has come to an end. Known for his strong likes and dislikes, 'OPC', as he was known to many, was equally amiable when he chose to be. He could be a fierce critic of his political opponents at one moment and dining with them the next moment, if it suited his interests. He would often say there are no permanent enemies or friends in politics. He put this philosophy to use on several occasions.

In 1998, his party, the Indian National Lok Dal (INLD), contested the Lok Sabha elections in alliance with the Bahujan Samaj Party (BSP) in Haryana. He assured the BSP supremo Mayawati that he would never go with the BJP or the Congress. But immediately after the elections, he extended support to BJP leader Atal Bihari Vajpayee.Chautala had a strong reason to do so. At that time, Bansi Lal's Haryana Vikas Party (HVP) was heading the government in the state in alliance with the BJP. Chautala hoped that his support to Vajpayee would lead to collapse of the Bansi Lal government. But due to Sushma Swaraj's firm support to Bansi Lal, the BJP continued its alliance with the HVP.

Within months, however, Chautala got another opportunity when after 13 months the Vajpayee government collapsed. In the 1999 General Election, Chautala's party won five seats. The Vajpayee government was again short of the majority mark.Shiromani Akali Dal (SAD) leader Parkash Singh Badal played a crucial role in persuading Chautala to again extend support to Vajpayee. Badal and Chautala's father, Devi Lal, shared a very close bond. They were known to be 'pag watt (exchanging of turbans)' brothers. OPC and the entire Devi Lal clan used to treat Badal like the patriarch of their family. However, this time Chautala agreed to support Vajpayee only after getting a written assurance from him that the BJP would withdraw its support to the Bansi Lal government within a few months. Soon, the INLD formed the government in Haryana in alliance with the BJP and a few defectors from the HVP.

Chautala was known for his strong-arm tactics. He would often say a chief minister is of no use if a sleeping person does not jump out of his bed on hearing his name. In 1999, Chautala, however, worked hard to change this image, at least for the first few months. Once I jokingly told him "Chaudhry sahib aap ki yeh shaleenta aap ko suit nahin karti (this modestly does not suit you)". He laughed and said one changes with time.OPC called for a midterm Assembly poll in 2000 and gained absolute majority. After that he was back to his old self.In 1991, when Chautala became the Chief Minister after his father Devi Lal became the Deputy Prime Minister, OPC had to become a member of the Assembly within six months to meet a constitutional requirement. Two byelections, Meham (Rohtak) and Thanesar (Kurukshetra), were due. Several delegations from Kurukshetra met Chautala and urged him to contest from their constituency. In Meham, his protégé Anand Singh Dangi, who had fallen out with him, challenged him to contest from there. When Chautala visited Ambala where I was then posted, I asked him why he was not contesting from Thanesar from where his victory was assured. The GT Road belt had never got a chief minister from the area and its people were yearning for one. He said: "Nyota to vapas karna padta hai (Challenge has to be answered)." When I insisted that in that case why not contest from both the constituencies, his reply was what is the use of causing another byelection later. However, after the infamous mayhem in Meham, Chautala contested from two places to become an MLA.

Whenever he was extremely polite with someone, it used to be an indication that the person was in for trouble. Once durings an Assembly election, Karan Singh Dalal, a fierce critic of Chautala, crossed him to go to the Speaker's podium. Chautala politely asked Dalal how was his elder brother. Dalal was very surprised at the courtesy. It was only after Dalal came out of the Assembly that he learnt that his brother had been booked in a murder case.

Why agri draft policy is not inclusive or progressive

support the government will provide to bridge the gaps between marketing and auxiliary infrastructure and carry out institutional reforms.

Suggestion to roll out a 'price insurance scheme' to insure the farmers' income at the time of sowing is apprehended to apply to contract farming by corporates or FPOs operated by them. What will be the basis for compensation—the MSP or contracted price and how the government will ensure it in a The farmers' concerns about the weakening of the



deregulated market? The experience of Pradhan Mantri Fasal Bima Yojana in this context has not been encouraging for the farmers. The process of making payments to the farmers is also not trustworthy in an unregulated market.

Given this background, the effectiveness of an 'empowered agricultural marketing reform committee' is dubious. This appears to be a mechanism where all BJP-ruled states will be forced to accept the government's proposals so that any resistance at the nationl level due to genuine issues can be sidelined. The draft envisages making intense efforts to bring all farmers under one or other farmers' organisations i.e. cooperatives, FPOs, selfhelp groups, etc, to reduce their inaccessibility to market and price uncertainty. However, it has been observed that in many cases, the primary processing alone is not sufficient to enable the FPOs or other farmers groups to gain substantial income for their members. However, the provision related to value chain centric infrastructure (VCCI) does not commit firmly to providing all-out support to FPOs to set up

the VCCI. The 'ease of doing agri-trade' at the expense of protection of farmers' interests and 'promotion of contract farming' again reek of revival of the earlier farm laws. A narrative is building up among the farmers and other stakeholders that the reintroduction of basics of the repealed laws by the government under a new guise should be resisted.

marketing infrastructure of markets, regulated by agricultural produce market committees (APMC) over time, are also not ill-founded. The policy draft suggests that the states consider allowing the buying of contracted produce outside the mandi yard and waive off the market fee when produce is bought for the purpose of processing and export to give impetus to these sectors. Organised retailers, processors, exporters and bulk buyers will be able to make direct purchases from the farm gate or at deemed market yards where they can initially offer higher prices to the farmers due to lower taxes. It will also affect the income of APMC markets due to lower arrivals. Thus, over time, these will become unviable.

Though the draft policy takes cognisance of the fact that agricultural marketing is a state subject under the Seventh Schedule in the Constitution, its mere glimpse

brings out the government agenda of addressing the long-standing challenges in agricultural marketing through a unified national approach. To allay the fears of farmers and to make it inclusive, the policy framework should be redrafted after public consultations with farmer unions and meaningful engagement with state governments and experts. Public investment in agro-processing and cold chains for supply and storage should be increased to strengthen the agricultural marketing infrastructure. Indian agriculture is facing a series of crises — income crisis due to the falling or stagnant incomes; degradation of natural resources; adverse impact of climate change, and last but not the least the loss of interest of the younger generation in agriculture. An inclusive and progressive agricultural marketing policy can go a long way in meeting these challenges by addressing major issues like the MSP, higher public investment and a participatory quick response system for responding to changes in the international market.

IAF training hiccups

CAG red-flags glaring deficiencies

THE highlight of the Indian Air Force's (IAF) 92nd Raising Day celebrations in October this year was a typically spectacular air show, whose theme was 'Bhartiya Vayu Sena Saksham, Sashakt, Atmanirbhar (potent, powerful and self-reliant)'. Those three words were supposed to reflect the IAF's "unwavering dedication to safeguarding the nation's airspace". The ground reality however, is not all that rosy. In a report tabled in Parliament on Wednesday, the Comptroller and Auditor General (CAG) of India has flagged deficiencies in the training of IAF pilots. Under intense scrutiny is the Pilatus PC-7 Mk-II aircraft, which is being used to impart Stage-1 flying training since 2013. The performance audit has noted that 25 per cent of

these aircraft reported 38 snags due to engine oil leaks between 2013 and 2021. No less worrying are the delays in



the IAF's aircraft modernisation plans that have affected stages 2 and 3 of pilot training for transport and helicopter Outdated equipment is another area of concern. The world's fourth-largest air force cannot afford to compromise on the upgrade of training simulators and aircraft. Trainee pilots need state-of-the-art technology to hone their skills. Issues such as engine oil leaks can dampen the spirits of aspirants who want to soar high and protect India's skies. Lowering the bar can prove to be a recipe for

There are problems not only in terms of quality but also quantity. The shortage of pilots has risen from 486 to 596 in about six years, as the recruitment has fallen short of the targeted intake. The CAG has done its job. Now it is up to the IAF and the government to take corrective action on priority. Bhagwat offers balm to the soul

THE GREAT GAME: It has taken the RSS chief to remind his own govt about the nation's diversity

AS the year turns, it may not be a far cry to say that 2024, in many ways, has belonged to RSS chief Mohan Madhukar Rao Bhagwat. The RSS chief's latest comments on Thursday in Pune, during a lecture on "India — the Vishwaguru" at the Sahjeevan Vyakhyanmala lecture series, seem startling enough to provide balm to the soul. To say that "mandir-masjid disputes are unacceptable"; that "after the construction of the Ram Mandir, some people think they can become leaders of Hindus by raking up similar issues in new places and that this is not acceptable"; to ask, "who is a minority and who is a majority" and answer that question himself, "everyone is equal." erhaps Bhagwat realised that the competitive politics over who is a better Hindu leader had to be properly nipped

agwat's comments, 75 years after the Constitution guaranteed a secular republic, should have been par for the course. Instead, they are the stuff of relief — and headlines. It has taken the RSS chief to remind his own government that the nation consists of folks with bewilderingly diverse views, traditions, customs, religions, language. And that if this 'khichri' has to retain its distinctive flavour, then maybe there's no point trying to stuff it into the One Nation One People straitjacket. Predictably, those on the political left are looking for a chink in the armour of his Pune speech maybe something is lost in translation, since Bhagwat spoke in his native Marathi. Not so predictably, those on the political right are perhaps also wondering why Bhagwat is unhooking the saffron flag from its stump, especially since Hindutva's victory over Muslims is hovering around the horizon. It's not clear when the penny dropped and what caused Bhagwat to make the comments he did in Pune. After all, for him to say that "we need to stay together" - Hindus, Muslims, Christians, all — mere weeks after the RSS began the year-long celebration of its 100th anniversary and on

the eve of Christmas (which the Modi government marks as "good governance day", a working day to boot) — is both singular and interesting.

Perhaps Bhagwat realised, after five people were unnecessarily killed in police firing after the communities clashed over the architectural antecedents of the Sambhal mosque a few weeks ago, that the competitive politics over who is a better Hindu leader had to be properly nipped in the bud.Perhaps he saw that India's 200 million Muslims, as much as 14 per cent of the population, had to live peaceably and equably with the rest, and that even contemplating another partition of the country was beyond the realm of contemplation. Perhaps he recognised the dangers lurking closer than anyone else. Perhaps he looked around himself and saw how — and why — Islamic nations like Syria

and Afghanistan and Palestine had fallen, like ninepins, in the past couple of years. Where would India's Muslims go if they were not allowed to live like equal citizens in their own country by bulldozer hotheads determined to raze their self-respect to the ground?

After all, back in 2018, Bhagwat had told reporters in Delhi that "without Muslims, Hindutya is incomplete." And last year, when the single Bench of the Allahabad High Court allowed a survey of the Gyanvapi masjid to see whether it had once been a temple and TV journalists began to palpitate over the implications of the decision, Bhagwat calmly said, "Why look for a shivling beneath every mosque?" Certainly, it is nobody's case that the RSS chief and PM Modi are not peas in the same pod or that the RSS has not benefited enormously from the BJP being in power over the last



decade. Of course, it has. The RSS knows that if not for Modi, there would be no Ram temple in Ayodhya or its expansion in 39 countries worldwide. The RSS chief is clear that all Indians of all religions are "Hindus", because once upon a time they were that.

In his Vijaya Dashami address earlier in October, Bhagwat made it clear that he had no time for "wokeism and cultural Marxism". He pointed out that Bangladeshi Hindus needed help from India. "Even the Gods do not care for the weak... What happened in Bangladesh should be a lesson for Hindu society. Weakness is a crime," he added.But Bhagwat's RSS is interesting in many more ways. It is credibly said that Sangh cadres, who often tip the scales between winning and losing, did not enthusiastically campaign for BJP candidates in the 2024 General Election like they had done previously


one key reason for the party's lack of majority in Parliament. And that the RSS later decided to reverse course and pull out all the stops in the Haryana and Maharashtra polls. Certainly, the BJP is far more strengthened having Bhagwat as the wind in its sails.

ignificantly, the RSS chief's comments come within days of Chief Justice Sanjiv Khanna ordering courts not to accept any fresh suits or pass orders on existing petitions seeking the survey of mosques and whether any temple structures lie beneath. Khanna pointed out that the Supreme Court was separately hearing petitions on reopening the 1991 Places of Worship Act, which had sealed the character of the place of worship as it existed on August 15, 1947. For the time being,

Khanna has shut down all legal conversation on whether mosques-were-once-temples. At least for the moment, Bhagwat is also trying to calm down his aroused flock — be satisfied with the Ram Mandir, he's saying, no need to take over Kashi or Mathura or dig under the Sambhal shahi masjid or the Ajmer Sharif dargah.It's more than likely that Bhagwat knows the inside story of the mediation that took place between Hindu and Muslim groups which resulted in the 2019 Supreme Court verdict that gave the 2.77 acres constituting the Ram Janmabhoomi sanctum sanctorum to the "Hindu side". Bhagwat probably knows the giveand-take that took place over months, why the Muslims gave up what they did and what they were promised in exchange.

Government to check commercial viability of D2M tech

NEW DELHI. After the "reasonably successful" preliminary trials of direct-to-mobile (D2M) technology - telecast of live TV channels on smartphones without an internet connection -Prasar Bharati has sent a detailed proposal with findings to the government to seek approval for initiating large-scale testing to check its commercial feasibility.

The Ministry of Information and Broadcasting officials said the proposal is considered "seriously" and a go-ahead is expected within two months. Initial short-term technology trials have "reasonably" been successful, and now it is only a matter of time before the commercial viability is established, they added.

Short-term trials of D2M have been completed. We need to carry out large-scale trials, which will take two to three years. The project plans will have to be worked out accordingly. The detailed proposal to check commercial viability of the technology has already been sent to the government. With large-scale trials, commercial viability will be tested. That is a major step, so a policy decision is required. The proposal sent by Prasar Bharati is being seriously considered. It will take another two months to get approval," said officials privy to the matter. After the policy decision, the tendering process for the selection of agencies to conduct trials will begin. The officials, however, said that actual field work might start in the next 8-10 months depending on decision at the government level.Initial trials were conducted in different cities, including Delhi, Noida and Bengaluru last year in collaboration with Indian Institute of Technology (IIT) Kanpur and Saankhya Labs. On the significance of second-stage 'long-term' trials, the officials said that during the small-scale trials, by and large, there are no difficulties as they are technology-focused trials. "Small-scale trials give you, by and large, an idea whether the technology will work or not because it has already been tested in the laboratory. In largescale trials, you get a chance to check commercial viability. On that basis, people make investments," said an official.

The duration of the large-scale trial is only decided after an assessment, which will be undertaken by the agencies that will participate in the trial. "For trials, critical mass of people are required. They will not come overnight. One lakh people will not join or get the devices. It will be checked if people are actually using the devices. This takes time," the official said.

Live broadcasting of content directly to mobile devices is done using broadcast signals like television and radio, bypassing traditional cellular or internet data networks. For this, the phones or devices require specific hardware to receive and decode broadcast signals.

Delhi may get rain for 3 days next week, relief from pollution likely

New Delhi. Delhi and its neighbouring states, including Uttar Pradesh, Punjab, Haryana and Rajasthan will likely see rainfall after Christmas from December 26 to 28. If the forecast holds, it could provide a respite for the people in these places, particularly Delhi, which has been seeing pollution levels ranging between 'very poor' and 'severe' for the past few days.

The rain is expected due to the interaction of a western disturbance in the region and a low-pressure area over the Bay of Bengal. Western disturbance refers to a storm originating in the Mediterranean region that brings sudden winter rain to the northwestern parts of India and its neighbouring countries. It will likely enter India on December 26. The western disturbance will form a cyclonic circulation over Rajasthan and other states on December 27.

The interaction of the two wind systems is expected to facilitate high moisture from both the Arabian Sea and the Bay of Bengal, and may persist until December 28. This will likely result in rainfall and snowfall over the western Himalayan region, particularly peaking on December 27 and 28. The plains of northwest India, including Delhi, and adjoining central areas will also experience rain on these dates. Thunderstorms accompanied by hailstorms are expected across Punjab, Haryana, western Uttar Pradesh, Rajasthan and Madhya Pradesh on December 27 and 28.

1 killed, another injured in Patna shooting, victims were returning from funeral

The men were on their way back from a cremation ceremony when the attack occurred in Patna. One of the men died on the spot while other was rushed to a hospital in critical condition.

New Delhi. A man died while another one was critically injured after being shot by unidentified assailants in Patna on Saturday, December 21.According to the police, the incident happened in Pethiya Bazaar area in Patna's Danapur when the two men, identified as Gorakh Rai and Ranjit Rai alias Dahi Gop, were returning after attending the last rites of a person when the incident happened.

Gorakh Rai succumbed to his injuries on the spot, while Ranjit Rai, who is a former Deputy Chairman of Danapur Cantonment, was rushed to a hospital in a critical condition.



A Forensic Science Laboratory (FSL) team was called to the spot and some cartridges were recovered from the crime scene. Speaking about the incident, Patna Police's Additional Superintendent of Police (ASP) Bhanu Pratap Singh said "Two people have been shot at in Pethiya Bazaar which comes under the jurisdiction of Danapur Police Station. One of the persons has been referred to Paras Hospital for better treatment. Meanwhile, the second person, Gorakh Rai, has succumbed to his injuries. The FSL team has been called and some cartridges have been recovered. Further investigation is underway."

Earlier in August this year, a BJP leader was shot dead near his house in the Bajrangpuri area of Patna by two bike-borne assailants. Ajay Sah, who was the General Secretary of the Patna District BJP, was shot dead when he was sitting inside his milk parlour, which he operated close to his residence.

Delhi's Air Quality In 'Very Poor' Category As Cold Wave Grips National Capital

New Delhi. Delhi witnessed vet another day of toxic air on Sunday, with the Air Quality Index (AQI) remaining in the 'very poor' category for the second consecutive day. At 6 am, the overall AQI was recorded at 386, as per data from the Central Pollution Control Board (CPCB). Parts of the city were covered by a dense layer of smog, reducing visibility and enforcing the strict implementation of GRAP Stage IV measures.

Delhi highlighted the severity of the situation: Okhla Phase 2 (388), Alipur (407), Rohini (423), ITO (382), Ashok Vihar (339), Wajipur (432), Shadipur (387), Mundka (426), Jahangirpuri (437), Narela (472), DTU (352), R.K. (377), and Punjabi Bagh (417). Notably, several locations approached or exceeded the "severe" threshold of



AQI readings from various parts of The India Meteorological Department (IMD) reported a slight rise in Delhi-NCR's minimum temperatures, ranging from 7 degrees Celcius to 9 degrees Celcius, with maximum temperatures hovering between 21-23 degrees Celcius.

Puram (462), Anand Vihar (423), Pusa The IMD warned that the smoggy conditions may persist in the coming days, with a potential intensification of the cold wave. Early mornings are expected to witness reduced visibility and chilly conditions.

While the AQI has slightly improved from the 'severe' to 'very poor' category, a significant improvement appears unlikely due to unfavourable weather conditions. Prolonged exposure to such air poses serious health risks, especially for vulnerable groups. The wind speed on Saturday evening was four

kmph making it difficult for pollutants to disperse. In the coming days, Delhi may experience continued poor air quality due to cold waves and unfavourable weather conditions. Authorities have urged residents to minimise outdoor activities and adhere to anti-pollution measures. The CPCB emphasised the health hazards of AQIs above 400, warning of grave consequences for all residents if pollution levels persist.

New Delhi. A 250-foot-deep stepwell, revolt, was found on Saturday during a survey in Uttar Pradesh's Sambhal. The matter came to light when Sanatan Sevak Sangh's state publicity chief, Kaushal Kishore, wrote to Sambhal District Magistrate (DM) Rajendra Pensia that Laxman Ganj used to house the royal family of Sahaspur and also had a stepwell.As per locals and historical accounts, the stepwell dates back to the era of the First War of Independence in 1857. Kishore urged



the DM to excavate and beautify the site. Following this, the DM ordered an excavation at the site in Laxman Ganj. Two bulldozers were used in the operation and dug up the spot, following which the stepwell was discovered.

"During digging, a two-storey building and Rani ki Bawdi were seen, which is there in historical records. Excavation is currently underway," an official told. The digging was halted at night due to

visibility issues. The DM said that site where the stepwell was found would be removed by giving notice to them.On Friday, the Archaeological Survey of India (ASI) conducted carbon dating at the Kartikeya Temple in Sambhal, which was reopened on December 13 after remaining locked for 46 years. The temple had been shut since 1978, following communal riots that displaced the local Hindu community, according to local accounts.

Officials conducted carbon dating and examined five pilgrimage sites in the vicinity, including Bhadrak Ashram, Swargdeep and Chakrapani, along with an inspection of 19 wells. Authorities had earlier said that the temple was discovered during an anti-encroachment drive. Officials described the discovery as unplanned, claiming they "stumbled"

At PM-UDAY camps, residents from Delhi's unauthorised colonies line up for 'pakka kaagaz'

NEW DELHI. Girish Sharma, a 41-yearold autorickshaw driver from Karawal Sharma explains why these documents are Nagar, is giddy with happiness. He just got his property registered, fulfilling his dream to finally own his house. Sharma is at a camp organised by the Delhi Development Authority (DDA) in Mandawali under the PM-UDAY scheme, which aims to assist residents of unauthorised colonies secure ownership rights to their houses. The DDA is organising camps across the Capital's throughout December.

The camp on Saturday saw several people about to finally get legal documents that prove they own the properties where they have resided for long, since generations in some cases. Following the registry or conferment of ownership rights, residents can sell their properties, avail loans against them, and also get plans approved if they want to make changes in the current building or construct structures in a vacant plot for which they have received ownership

so important. "In a few years, I am going to get my daughter married and will need a loan for the wedding. If I didn't have registry papers for my house, the bank wouldn't have given me a loan against it."He is thankful to Prime Minister Narendra Modi. "Unki wajeh se humare pakke kaagaz ban gaye (We have proper documentation due to

unauthorised colonies on the weekends Modi and L-G V K Saxena's faces adorn the banners of the PM-UDAY scheme. The L-G had directed DDA to expedite PM-UDAY applications in November after the scheme did not see a high number of property registrations for over four years. According to a reply given by the Union Housing Minister in Parliament in July, of the 1,22,729 applications, only 23,811 have been granted ownership rights under the scheme. The push to the scheme comes at a critical time, just ahead of the Delhi elections. The approximately 50 lakh



residents in Delhi's 1,731 unauthorised colonies form about one-third of the Capital's electorate.

"This time, it seems government officials are under pressure to work," says Navratan Goel (64), who owns a general store. He is about to get his house registered at a camp in East Vinod Nagar. "Earlier, officials used to delay and postpone. Now, they are saying all problems will be resolved and the process will be over today."However, not everyone shares their optimism.

Shankar Pandey (65), who installed dental chairs in clinics till 2016, is now retired. Residents of nearby Ganesh Nagar, he and his wife Sunita Pandev have a power of attorney dating back to 1981 for the house where they stay, but it was not accepted as proof of ownership at the Mandawali camp on

The findings showed that rats on the prebiotic diet spent more time in non-rapideye-movement (NREM) sleep, which is restful and restorative and is dreamless, than those on the non-prebiotic diet.

"We found that dietary prebiotics can improve non-rapid eye movement (REM)

sleep, as well as REM sleep after a stressful event," said lead author Robert Thompson, post-doctoral student at University of Colorado - Boulder.

"Given that sufficient NREM sleep and proper nutrition can impact brain development and function and that sleep problems are common in early life, it is possible that a diet rich in prebiotics started in early life could help improve sleep, support the gut microbiota and promote optimal brain/psychological health," added Monika Fleshner, Professor at University of Colorado - Boulder.

For the study, published in the journal Frontiers in Behavioural Neuroscience, the team fed three-week-old male rats a diet of either standard chow or chow that included prebiotics. They then monitored the rats' body temperature, gut bacteria and sleepwake cycles -- using EEG, or brain activity testing -- over time.

After being exposed to a stressor, the rats on the prebiotic diet also spent more time in rapid-eye-movement (REM) sleep.

REM sleep is believed to be critical for promoting recovery from stress -previously been shown to reduce healthy diversity of gut bacteria.

But rats on the prebiotic diet were buffered from the impact, maintaining a healthy and diverse gut microbiota and normal temperature fluctuations even after stress exposure, the study said.

Britannica didn't just survive. It's an Al company now

NEW DELHI. For nearly 250 years, the Encyclopaedia Britannica was a bookshelf-busting series of gilt-lettered tomes, often purchased to show that its owners cared about knowledge. It was the sort of physical media expected to die in the internet era, and indeed, the encyclopedia's publisher announced that it was ending the print edition in 2012. Skeptics wondered how Britannica the company could survive in the age of Wikipedia. The answer was to adapt to the times.Britannica Group runs websites, including Britannica.com and the online Merriam-Webster dictionary, and sells educational software to schools and libraries. It also sells artificial intelligence agent software that underpins apps like customer service chatbots and data retrieval. Britannica has figured out not only how to survive, but also how to do well financially. Jorge Cauz, its CEO, said in an interview that the publisher enjoyed pro forma profit margins of about 45%. The company is weighing an initial public offering, in which it could seek a valuation of about \$1 billion, according to a person with knowledge of the deliberations. That could provide a sizable return for the company's owner, Swiss financier Jacob E Safra, who acquired the publisher in 1995 and, in a lawsuit filed in 2022, cited an investment bank in valuing Britannica at \$500 million. The company says its websites draw over 7 billion annual page views a year, with users in more than 150 countries.

Britannica has come far from its origins in the 18th century as the publisher of a reference work put together by three Scottish printers. Over the years, the Encyclopaedia Britannica became a heavyweight of the knowledge business, both literally - the 32volume 2010 edition, the last to run in print, weighed 129 pounds - and figuratively, drawing on contributions from thousands of experts. It also became an aspirational status symbol, with customers paying nearly \$1,400 for that edition.

By the time the last Encyclopaedia Britannica was printed, the company had already started its suite of websites and educational software. Now it sees even greater opportunity in the growth of generative AI tools, which the company says can help make learning more dynamic - and therefore more

Cauz said Britannica had experimented with the technology over the past few decades. It acquired Melingo, the company that makes its AI agent software, in 2000 because of its strength in natural language processing and machine learning. And it has two technology teams, based in Chicago and in Tel

Ex-finance minister Arun Jaitley had given go-ahead to clean up bad loans, says Raghuram Rajan

MUMBAI. Former finance minister Arun Jaitley had encouraged Raghuram Rajan to take decisive action on cleaning up bad loans of Indian banks, the former RBI governor said in a recent interview to a news portal and asserted that the build-up of non-performing assets (NPAs) in the banking sector, worsened by corruption, delayed clearances, and the global financial crisis, had necessitated a comprehensive review.

"When I discussed the need to clean up the system with Jaitley, he said, 'fine, go ahead'... We did it," Rajan told a digital news platform. However, he highlighted the slow pace of recapitalisation by govt, which hindered resumption of lending by banks. Rajan was RBI governor from 2013 to 2016."We had problems in India over and above the global financial crisis which was that there were corruption scandals and therefore permissions started getting delayed a lot, projects weren't getting land, projects weren't getting environment permissions... they were building NPAs in the financial system," Rajan said. In a 2014 interview with TOI, Rajan had spoken of the need for "forensic skills" in RBI supervision to identify "where the bodies are buried" in banks. The RBI initiated an asset quality review (AQR) in 2015, which exposed significant bad loans that had been carried as performing assets. Rajan said, "Many loans became NPAs after the crisis and delays in projects. During my predecessor's time, a moratorium was allowed on terming them nonperforming, but it only prolonged the problem."

While the system eventually stabilised, he emphasised the importance of avoiding a repeat of past mistakes, particularly in retail and MSME loans. The AQR turned out to be the biggest cleanup in Indian banking history with lenders posting losses worth crores and facing lending curbs.

Google proposes fix to solve search monopoly

WASHINGTON. Google said Friday what it thought should change to address a ruling that it had illegally maintained a monopoly over online search: not much.

It follows the landmark ruling in Aug by judge Amit P Mehta of the US district court for the district of Columbia, who said Google had illegally maintained a monopoly in online search by paying companies like Apple and Samsung to be the search engine that automatically appears when users open a web browser or a smartphone. The govt then asked the judge to force Google to sell Chrome, the world's most popular browser, among other remedies.

In Google's own proposal to fix the search monopoly, it asked Mehta to allow it to continue to pay other companies for its search engine to get prime placement. But it said those agreements should be less restrictive than in the past.

Apple, for example, could select different search engines to come up automatically for iPhone and iPad users, said Lee-Anne Mulholland, the company's VP of regulatory affairs, in a blog post. Cellphone makers using Google's popular operating system, Android, could also install multiple search engines and could install other Google apps without installing its search tool or its Gemini artificial intelligence assistant product.

Central PSUs Record 47 Per Cent Jump In Net Profit For 2023-24, Market Cap Doubles

New Delhi. Overall Net Profit of operating Central Public Sector Enterprises (CPSEs) rose to Rs 3.22 lakh crore in FY24 as against Rs 2.18 lakh crore in FY23 showing an increase of over 47 per cent, according to an official report. The market capitalisation of CPSEs more than doubled in Fiscal Year 2024-25 as compared to Fiscal Year 2023-24, the report said. The major contributors to the increase in market cap are NTPC Ltd, Oil & Dil & Amp; Natural Gas Corporation Ltd, Hindustan Aeronautics Ltd, Coal India Ltd and Indian Railway Finance Corporation Ltd. A major proportion of the increase in profit of Rs 0.89 lakh crore was contributed by the Petroleum (Refinery & Darketing) group, according to the report compiled by the Public Enterprises Department of the Finance Ministry. Within the Petroleum (Refinery & amp; Marketing) group, the major contribution towards the increase in Overall Net Profit is contributed by Indian Oil Corporation Ltd (Rs 0.31 lakh crore). The profitability of the



Petroleum (Refinery & amp; Marketing) group has impacted the overall profitability," the survey said.Net Loss of loss-incurring CPSEs was Rs 0.21 lakh crore as against Rs 0.29 lakh crore showing a decrease of over 27 per cent. New GST Invoicing: A step forward or backward

New Delhi. The Goods and Services Tax (GST) framework in India has undergone several changes since its inception in 2017. One of the most significant updates is the introduction of the Invoice Management System (IMS) by the Goods and Services Tax Network (GSTN), launched in October 2024. This new system aims to enhance the accuracy and transparency of invoices, making it easier for businesses to claim Input Tax Credit (ITC) while improving overall compliance with GST regulations.

Although the IMS promises to streamline the invoicing process, it also raises several concerns regarding administrative burden, legal validity, and operational complexity.

the highest component which One of the major concerns surrounding the new system is its legal foundation. The IMS introduces processes similar to those proposed in the now-abandoned GSTR-2 and GSTR-3 forms, which were scrapped due to complexity. Many businesses are questioning whether IMS has legal backing, mainly since it revives aspects of an eanlier defunct system. This raises risk of legal disputes as businesses may challenge the system's validity. It will be important to note that IMS provisions are not part of statutory framework as of now even as made optional by GSTN.

Acceptance of wrong invoices

The deemed acceptance provision introduces the risk of businesses inadvertently accepting incorrect invoices. If a business fails to review an invoice within the specified timeframe, it may passively accept discrepancies, which could lead to incorrect ITC claims and potential disputes with suppliers. This could become a significant issue for businesses with high transaction volumes, as the manual effort required to review each invoice may be considerable.

Confusion for recipient

One of the more complex aspects of the IMS is the requirement for recipients to reassess invoices when suppliers modify them. If a recipient has already acted on an invoice and the supplier subsequently makes changes, the recipient's original action is nullified, and they must reevaluate the invoice. This could create confusion and add to the compliance burden, as businesses need to constantly monitor and track

supplier modifications. Tracking pending invoices

Another major concern is the need to track pending invoices in IMS separately from accounting systems like SAP or Tally.

Pegasus: 300 of 1,400 users from India, why ruling may re-open tapping debate

New Delhi. For the first time, a court in the US has held Israel's NSO Group liable for its intrusive spyware Pegasus, which could set up a measure of accountability for the company that it has, for long, allegedly downplayed.

The decision came in a case filed by Meta-owned WhatsApp against the NSO Group, with the judge in the case, Phyllis Hamilton, holding that the Israeli spyware maker was liable for targeting the devices of 1,400 WhatsApp users, and violating sections of the Computer Fraud and Abuse Act (CFAA), a federal cybersecurity law, and a similar state law in California called the California Computer Data Access and Fraud Act (CDAFA).

Victims of Pegasus's use included senior government officials, journalists,

human rights activists, political dissidents and diplomats. The devices in India, including those allegedly belonging to journalists, politicians, Union Ministers, besides members of the civil society. In the US, President Joe Biden's administration put the NSO Group on a blacklist in 2021 and forbade US government agencies from purchasing its products. Pegasus has been implicated in hacks by authoritarian governments across the world. The alleged Pegasus targeting in India, Centre's denial In 2021, it was reported that Pegasus was used on more than 300 Indian mobile numbers, including that of two serving ministers in the Narendra Modi government, three Opposition leaders,

one constitutional authority, several journalists and business persons. installation of Pegasus also extended to The revelations raised evebrows over the Central Government and state government's involvement in the attacks, since NSO Group has repeatedly said that it only deals with

governments and government agencies. However, it should be noted that as part of the WhatsApp vs NSO Group case, unsealed documents had shown that NSO Group, for years, downplayed its role in the deployment of Pegasus. Through interviews and an assessment of subpoenaed documents, WhatsApp contradicted this claim, alleging that Pegasus customers had "minimal role" in its deployment, with NSO Group managing a substantial part of the process.

GST Council Meeting Highlights: Key Recommendations To Provide Relief To Individuals And Businesses

Jaisalmer. From reducing the GST rate on fortified rice kernel (FRK) to fully exempt GST on gene therapy, the 55th GST Council meeting, chaired by Union Finance Minister Nirmala Sitharaman, on Under goods category, the meeting decided Saturday made some key recommendations to provide relief to individuals and businesses.

The Council recommended exemption of GST on contributions by general insurance companies from third-party motor vehicle premiums for the Motor Vehicle Accident Fund. It also recommended no GST on the transaction of vouchers as they are neither a supply of goods nor supply of services. The provisions related to vouchers is also being simplified.GST Council clarified that no GST is payable on 'penal charges' levied and collected by banks and NBFCs from borrowers for non-compliance with loan terms. The Council recommended reduction of payment of pre-deposit for filing an appeal before the Appellate Authority in respect of an order passed which involves only penalty amount.It recommended reduction in GST rate on fortified rice kernel (FRK), classifiable

under 1904, to 5 per cent, as the commodity is supplied to the weaker sections of society through the public distribution system (PDS).

to extend IGST exemption to systems, sub-systems, equipment, parts, sub-parts, tools, test equipment, software meant assembly/manufacture of LRSAM system. It also recommended to reduce the rate of Compensation Cess to 0.1 per cent on supplies to merchant exporters at par with GST rate on such supplies and exempt from IGST imports of all equipment and consumable samples by Inspection Team of the International Atomic Energy Agency (IAEA) subject to specified conditions. The GST members also recommended to extend the concessional 5 per cent GST rate on food inputs of food preparations under "HSN 19 or 21" that are supplied for food preparations intended for free distribution to economically weaker sections under a government program subject to the existing conditions. Under the Services category, the GST Council recommended to bring supply of the sponsorship services

provided by the body corporates under Forward Charge Mechanism and exempt GST on the contributions made by general insurance companies from the third-party motor vehicle premiums collected by

This fund is constituted for providing compensation/ cashless treatment to the victims of road accidents including hit and run cases. It recommended to increase the GST rate from 12 per cent to 18 per cent on sale of all old and used vehicles, including EVs other than those specified at 18 per cent like sale of old and used petrol vehicles of engine capacity of 1200 cc or

more and of length of 4000 mm or more; diesel vehicles of engine capacity of 1500 cc or more and of length of 4000 mm and

The Council also clarified that Autoclaved Aerated Concrete (ACC) blocks containing more than 50 per cent fly ash content will fall under HS 6815 and attract 12 per cent GST. It further clarified that pepper, whether fresh green or dried pepper and raisins when supplied by an agriculturist, is not liable to GST.

t also clarified that ready-to-eat popcorn which is mixed with salt and spices are classifiable attracts 5 per cent GST, if supplied as other than pre-packaged and labelled, and 12 per cent GST if supplied as pre-packaged and labelled.

However, when popcorn is mixed with sugar thereby changing its character to sugar confectionary (eg caramel popcorn), it would attract 18 per cent GST. The Council has approved an amendment to the definition of prepackaged and labelled items intended for retail sale. The step is aimed at clarifying the definition for all goods as currently there is a lot of confusion on the issue.
