Benegal's cinema contemporaries, colleagues and younger generations of actors and artists accompanied wife Nira and daughter Pia in paying their last respects to the icon, whose movies captured the many realities of India. Naseeruddin Shah, Rajit Kapoor, Kulbhushan Kharbanda, and Ila Arun, who starred in many of Benegal's films, were present to bid adieu to the director. Also present were actor Ratna Pathak Shah, her son Vivaan Shah, writer-poet Gulzar, director Hansal Mehta, lyricisit-writer Javed Akhtar, actors Divya Dutta, Boman Irani, Kunal Kapoor and Anang Desai. Shivendra Singh Dungarpur, whose Film Heritage Foundation recently restored Benegal's 1976 "Manthan" for a screening at the Cannes Film Festival, was also present. 

The government is committed to supporting the well-being of dependents by giving preference to widows and orphans in providing employment on compassionate grounds, he said and added that various aspects would be viewed to benefit the maximum number of applicants. 

Vajpayee's legacy lives on as country marks his birth centenary

New Delhi, Dec 24: Delivering one of his more famous speeches at BJP's inaugural convention at Shivaji Park in Mumbai, Atal Bihari Vajpayee predicted on December 30, 1980 with his signature flourish: 'Andhera chhatega, suraj niklega, kamal khilega' (darkness will end, the Sun will rise, lotus will bloom). As his birth centenary arrives, his words have aged well, with BJP returning to power for a third straight term at the centre and lotus in full bloom. If Prime Minister Narendra Modi made BJP's cultural agenda the centre of national politics, Vajpayee helped the party occupy this centre when its cultural agenda was considered an anathema. A statesman politician and a peerless orator, India's first non-Congress prime minister to have served a full term commanded respect and affection from across the political aisle and stood tall with his innate democratic spirit, honed through decades in

opposition, in a politics crowded with powerful satraps. The three-time prime minister was the original builder of coalition politics at the national level, successfully running an alliance government for a full term



national crises, including the plane hijack in 1999 and the terror attack on Parliament in 2001, both with direct links to Pakistan. His government's measured handling of

quarters, including right wing organisations considered ideologically affiliated to BJP but less than friendly to him for not pushing their cultural and economic agenda, but his standing ensured that he faced no political threat or popular backlash. And

even as he was still smarting from the fall of his government by one vote in the Lok Sabha in April 1999, his firm military and deft diplomatic response to Pakistan's intrusion into Kargil as the head of a caretaker government earned him plaudits and powered the BJP-led National Democratic Alliance to a more stable majority, ensuring him a full term at the helm. Ashok Tandon, media adviser to Vajpayee during his sixyear stint as PM, said besides

being an outstanding parliamentarian who did his bit in "strengthening the roots of parliamentary democracy" after entering the Lok Sabha for the first time in 1957, he brought "good governance" at the centre of agenda as the head of government. "Good governance was his landmark contribution. He headed a diverse coalition of parties and kept them together, while pursuing policies which helped the country in every field," he said, citing the launch of Sarva Shiksha Abhiyan, PM Gramin Sadak Yoina and the Golden Quadrilateral highway project under his stewardship. It was his boost to reforms, disinvestment and infra projects that made the idea of 7 to 8 per cent growth rate possible and his government legislated fiscal prudence through the FRBM Act in 2003. However, the fruits of reforms came a little too late and this coupled with BJP's political missteps, especially in the crucial state of Uttar Pradesh, and the Congress-led UPA's harnessing of rural distress delivered a shock defeat to Vajpayee in 2004 amid a decline in his health. His public appearances were limited, he campaigned last for his party in the 2007 assembly polls in Uttar Pradesh before slowly fading away from the public

Wrong to compare 5 PM voter turnout data with final polling data: EC

New Delhi, Dec. 24: The Election Commission on Tuesday asserted that there were no arbitrary addi-

tions or deletions of voters in Maharashtra where assembly polls were held recently. In its response to the Congress, the poll authority also said it would not be correct to compare 5 PM voter turnout data with final polling data. The Congress had approached the poll panel in November flagging various concerns related to the Maharashtra assembly polls. Coming out with a detailed note and frequently asked questions (FAQs), the poll authority told the Congress that increase in voter turnout from 5 PM to 11:45 PM was normal, being part of the process of aggregation of voter turnout. It said there can be bona fide but inconsequential differences in votes polled and votes counted. The EC asserted that it is impossible to change actual voter

turnout as statutory Form 17C giving details of voter turnout is available with authorised agents of candidates at the time of close of poll at the polling station itself. It said rule-based process was followed with

transparency in Maharashtra electoral roll preparation and there were no irregular pattern in voter deletions in the state. It told the Congress that due process was followed, including participation of

Congress representatives in preparation of electoral rolls. The commission told the party that its complaint of an average addition of 50,000 electors between July and November in 50 assembly seats, out of which 47

have been won by the Mahayuti, is factually incorrect and misleading. It said the fact is that only six assembly constituencies had total additions of over 50,000 electors during the period. Hence the question of winning in 47 seats on this basis does not arise. While detailing the well laid out mechanism with sufficient checks and balances and disclosures, the EC emphasised that the watertight statutory scheme ensures that deletion and addition of voters is done strictly according to rules with fullest involvement of political parties at every stage. It underlined that there were no bulk deletions or unusual deletion patterns of noticed across all assembly seats. Deletions of an average of 2,779 electors per seat happened on account of death or shifting and duplicate entries after following due process, including participation of party representatives. The Commission also listed out nearly 60 instances of proactive involvement of political parties or candidates during the entire electoral process. The Commission reiterated that political parties, being key stakeholders, are involved scrupulously at each and every stage of the election process from 'Roll to

Poll' (preparation of electoral rolls to completion of

Bangladesh launches \$5 billion graft probe against Sheikh Hasina in nuclear power plant case

Dhaka, Dec. 24: An antigraft panel in Bangladesh has launched an investigation against former prime minister Sheikh Hasina and her family in connection with the allegations of embezzling USD 5 billion in the Rooppur nuclear power plant, according to a media report. Indian companies are participating in constructing the Rooppur nuclear power plant which is being built by Rosatom, Russia's state-run corporation, in Bangladesh. The first Bangladeshi nuclear power plant, the Russian-designed Rooppur, is being built 160 km west of the Bangladeshi capital of Dhaka. Along with Hasina, her son, Sajeeb Wazed Joy, and Tulip Siddiq, her niece and the UK's Treasury minister, were questioned, BDNews reported on Sunday. There are accusations of embezzling USD 5 billion in the Rooppur Nuclear

Power Plant project, the report added. The development came two days after the High Court issued a rule asking why the Anti-Corruption Commission's (ACC) inaction over an alleged transfer of USD 5 billion from the Rooppur Nuclear Power Plant project to a Malaysian bank by Hasina, Joy, and Tulip should not be declared illegal, the report added. According to ACC documents, the allegations of corruption in the Rooppur Nuclear Power Plant project were brought to light by Bobby Hajjaj, chairman of the National Democratic Movement (NDM). Hasina, 77, has been living in India since August 5 when she fled the country following a massive student-led protest that toppled her 16-year regime. Her sister Rehana accompanied her. Joy resides in the US, while her niece Tulip is a member of the British parliament.

Factories pay less for leaves, Kundha tea planters protest

NILGIRIS. Condemning tea factories for paying Rs 3 less per kg than the committee-fixed price of Rs 24.59 for green tea leaves, small plantation owners in Kundha launched a strike on Monday. The planters also did not send leaves that have already been plucked to eight tea factories. "In October, MSME Minister TM Anbarasan assured that green tea leaves would be procured as per the committee fixed price but till date it has not been implemented," said Manjai V Mohan,



founder of Badagesa Party which is supporting the protest.

The committee consisting of the district collector and tea board executive director fixed Rs 24.59 for green tea leaves from small scale farmers. However, eight state owned factories are paying them Rs 3 less. Sources in the INDCOSERVE which is managing the eight factories said they are facing a financial crisis and are unable to provide the price. "We are aware of the protest. The difference in the amount could be between Rs 1.5- Rs 1.7 crore and the government is aware of it. It's upto the state government to pay the price," said an official

Human interaction posing threat to lion-tailed macaques, finds study

Feeding of the animals by humans has increased, leading to potential health risks among species

KOCHI. An increase in human interaction is posing a threat to the already endangered lion-tailed macaque. The primate, endemic to the Western Ghats, is classified as endangered on the IUCN Red List. With a population of just over 4,200, the species faces threats from habitat loss, fragmentation and human encroachment.

A study by Sheheer T A and Dr Peroth Balakrishnan, researchers at the Kerala Forest Research Institute (KFRI), and Prof Mewa Singh of the University of Mysore, published in the journal 'Primate

Conservation,' reveals that increased food provisioning and habituation to human activity are jeopardising the survival of the

"Lion-tailed macaques (LTMs) adapted to the dense evergreen forests of the

Ghats and remained isolated from human habitations, till recently. But some behavioral changes are being noticed, where LTMs are seen accepting food offered by humans and consuming discarded food. It seems the salt content in human food is attracting the primates. This shift is detrimental to their health, increasing the risk of disease transmission, malnutrition, and dependency on unnatural food sources," said Dr Peroth, head of the department of Wildlife Biology at KFRI. The researchers surveyed roads passing through LTM habitats at eight key

locations along the Western Ghats, including Anamalai Hills, Nelliyampathy, Nilambur Ghats, Sholayar, Gavi, Sabarimala, Vallimalai Hills and Agumbe. Approximately 25% of the LTM population in these areas engages in interactions with humans, representing about 12% of the species' total estimated

population. The distribution of LTMs is limited to 47 sub-populations across seven landscapes with an estimated total population of about 4,200 individuals. The interactions include behaviours such as



accepting food from tourists, raiding roadside waste, competing for human food with other species and venturing into human settlements.

The feeding of wildlife has become a popular form of human-wildlife interaction, but it comes with serious risks. While humans have interacted with wildlife throughout history, this modern

practice often disrupts natural behaviour and ecosystem. Feeding, especially along roadsides or during ecotourism activities, can change wildlife behaviour, ecology, population dynamics, sometimes

leading to conflicts with humans. Additionally, feeding wildlife can attract unusually high concentrations of animals to specific areas, altering natural ecological balances," said Dr

The research paper recommended immediate intervention, including public awareness campaigns, to educate tourists and locals on the dangers of feeding wildlife. Strict regulations should be enforced to prohibit food provisioning and littering in macaque habitats. Steps should be taken to provide a safe and natural habitat to LTMs by expanding and reconnecting fragmented habitats. There is a need

to continuously track macaque populations and interactions to inform adaptive conservation strategies, it said."We must balance human activity with wildlife conservation. Sustainable tourism practices and habitat protection are essential to ensure the survival of LTMs in the Western Ghats," said Dr Mewa

Thieves eat, smoke before cleaning up Rs 28L jewellery from teacher's house

TNSTC terminates 100 temporary workers in Kovai

COIMBATORE. Around 50 temporary drivers and conductors working in the Tamil Nadu State Transport Corporation (TNSTC) gathered at the collectorate and submitted a petition to Collector Kranthi Kumar Pati seeking intervention as they were asked to stop coming for work from December 17.

TNSTC officials said as per the norm services of crew who have completed 100 duties would be terminated and a a fresh batch of workers will be recruited.N Somasundaraj, a temporary driver for

TNSTC, Coimbatore, said, "We have been working in TNSTC for the last two years. During festival season, during special bus operations, and strikes by regular staff, we are given work at Rs 700 for eight hours of work. All of a sudden, 100 temporary drivers and conductors have been told not to come for work without giving any reason."



Naveen, another temporary staff, said, "TNSTC officials said they will provide us work until we get confirmed as permanent staff. Now, they have told us to collect our original certificates from the concerned depot and leave. Despite multiple efforts, Coimbatore division TNSTC officials refused to meet us."When contacted S Sreedharan, General Manager of TNSTC, Coimbatore Division, he said, "As per norms, temporary workers are given only 160 duties. After that, TNSTC offers jobs to a new batch. We did not give them any assurance of permanent jobs."

Supreme Court appointed Amicus curiae visits Maradu demolition sites

KOCHI. On a visit to locations in Maradu where four flat complexes were demolished in 2020, the Supreme Court-appointed amicus curiae on Monday asked the municipality to hand over a report with details of authorised buildings existing on

The amicus curiae, Gaurav Agarwal, and his team visited the locations on the directive of the apex court to analyse the viability of reconstruction of apartment complexes at the same sites, following the request of flat

Four high-rise buildings -- Holy Faith H2O, Alfa Serene, Jain Coral Cove and Golden Kayaloram -- were demolished on the order of the Supreme Court in January 2020, on

finding that the apartments violated coastal regulation zone (CRZ-2) rules, which prohibit any construction within 200m of the high-tide line of waterbodies.

Later, it was brought to the notice of the SC that the sites that comprised the complexes fell under CRZ-3 norms and not CRZ-2, therefore reducing the restrictions from 200m to 50m. This allows high-rise buildings such s those that were demolished to be constructed in the area. "The purpose of today's (Monday) visit was to analyse the viability of construction of new apartment buildings in the sites they were demolished earlier. We have sought details on authorised buildings existing on the plots from Maradu municipality. Only after receiving this data

can we analyse the distance from the waterbodies and size of buildings that can be built. After we receive the details, Kerala Coastal Zone Management Authority Maradu municipality chairman Antony (KCZMA) officials will again visit the sites before submitting the report to the apex court," said P Kalaiarasan, environmental engineer with the directorate of environment and climate change of KCZMA. The team also comprised KCZMA officials, district collector N S K Umesh, the chief town planner, the district town planner, the government pleader, the deputy collector and municipality officials. Around 343 owners lost their flats in the demolitions. In September, a three-judge SC bench asked the state government to consider "some relief"

for flat owners, and orally remarked that the entire dispute could have been settled by imposing heavy fines.

Ashanparambil said the civic body supports the construction of new apartment complexes. "The three-member committee appointed by the Supreme Court comprising the then principal secretary, district collector and municipality chairperson presented a misleading report in 2019, leading to the demolitions. It was a wrong move on the part of the state government. Police should have also taken action against the then panchayat president, who was responsible for false documentation that led to the demolitions,"

Kerala police look to boost anti-narcotic operations using drones; tender floated

Recently, the **Cyber Operations** Wing of the Kerala Police issued a tender to procure 20 drones, for an estimated total cost of Rs 60 lakh, under the scheme.

KOCHI. The Kerala Police are enhancing their anti-narcotic operations with the procurement of drones for surveillance, search, and tracking purposes. The drones will be part of the police's 'Yodhav' scheme, aimed at combating the growing drug menace in Kerala.Recently, the Cyber Operations Wing of the Kerala Police issued a tender to procure 20 drones, for an estimated total cost of Rs 60 lakh, under the scheme.

"Surveillance plays a crucial role inantinarcotic operations. Drug peddlers often operate in isolated areas. The mere arrival of police officers alerts the peddlers, who then escape and hide the contraband. The drones will help in the surveillance of the suspects and assist in search and tracking operations," a As per the police department, the drones need to police officer explained. He said they have only



floated a tender for the drones at present. "The procurement will proceed once we receive bids from suppliers," the officer said.

ability to perform vertical take-off and landing, a minimum flight time of 20 minutes, a 2 km range, and ability to fly at altitudes of not less than 400m.

Additionally, the drones should also be able to record and transmit high-resolution videos equip the District Anti-Narcotic Special Action Force (DANSAF) units in each police district with drones. Besides narcotics control, the drone technology will also be integrated into police stations for maintaining law and order," the officer said.

DANSAF is the police's specialised unit focused on monitoring drug peddlers and gathering intelligence for anti-narcotic operations. In 2023, the Kerala Police registered 30,697 cases under the Narcotic

Drugs and Psychotropic Substances (NDPS) Act, while 22,643 cases under the Act have already been registered until October this year.Last year, Kerala became the first state in India to implement drone surveillance units in all police districts.

and capture photographs. "The plan is to Additionally, 25 cops were trained in drone operations at the Indian Institute of Technology Madras. Moving a step further toward strengthening security, the police are also set to acquire an anti-drone system capable of neutralising hostile drones.

Yodhay scheme

The Yodhav scheme, launched in 2022, aims to tackle drug menace through collaboration with multiple agencies and local bodies. The police also launched the Yodhav app, which allows citizens to report drug-related activities.

Rs 230 cr green damages not collected, NGT serves notice to Haryana

Gurgaon. The National Green Tribunal (NGT) last week issued notices to the Haryana govt and the state's pollution control board after a petition argued that Rs 230 crore, which was imposed on entities or individuals who had violated environmental norms, was yet to be recovered and utilised to make up for the damages. The bench of judicial magistrate Sudhir Agarwal and expert member Dr A Senthil Vel on Dec 20 gave the state govt and Haryana State Pollution Control Board (HSPCB) a month to reply

The tribunal was hearing a plea filed by Delhi resident Varun Gulati, who argued that govt and HSPCB's "inefficiency" in recovering environmental compensation was harming the environment by preventing restoration, remediation and rejuvenation efforts."Allegations made in the application in our view give rise to substantial questions relating to environment arising out of implementation of enactments mentioned in Scheduled-I of NGT Act, 2010. We, accordingly, issue notices to respondent no.1 - State of Haryana and respondent no.2 - Haryana State Pollution Control Board," the order said. The tribunal scheduled the next hearing in the case for Feb 13. The petitioner told TOI on Monday that "it was imperative for authorities to act swiftly to enforce the principle of 'polluter pays', and ensure that the necessary restoration efforts are carried out"

Asked about the plea, an HSPCB official said the board was taking immediate steps to recover compensation from polluters."We acknowledge the concerns raised by NGT and are committed to ensuring the recovery and effective utilisation of environmental compensation. Our efforts will be directed towards restoring and rejuvenating the damaged environment,"

MCG forms panels to prepare tender docus on sewage ops and maintenance in Gurgaon

Gurgaon. MCG has formed a committee to prepare comprehensive tender documents concerning sewerage operation and maintenance in the city. The committee has received directives to incorporate stringent regulations, terms and substantial financial penalties for any breach of contractual obligations. The decision was made in a meeting held recently to discuss sewerage-related complaints.

"The panel has been instructed to draft tender documentation by Dec 30. During the discussion, it was proposed that the organisation's track record should be evaluated in the bidding process, and any organisation penalised above 20% should be barred from participating in the tender," MCG commissioner Ashok Kumar Garg said. According to Garg, data suggests that sewage-related issues constitute 90% of grievances lodged at the samadhan camps. Moreover, the commissioner also issued directives for all officers to respond to public calls without fail. Any complaints received through WhatsApp groups must be promptly addressed, and updates should be shared within the group. Officers failing to answer calls will face departmental proceedings, Garg said in the meeting. He emphasised that work-related negligence is unacceptable, and recurring complaints will trigger disciplinary measures against the responsible officer.

A structured penalty system has been established for the same. The first complaint results in a warning, followed by a show-cause notice on the second complaint. The third complaint invokes action under Rule-8 of the Harvana Civil Services (Punishment and Appeal) Rules, 2016, while the fourth leads to Rule-7 proceedings. He further specified that officers with multiple complaints against them could potentially face termination from service.

2 held for house break-ins, Rs 7.7 lakh recovered

Noida: Police arrested two members of an inter-state gang that allegedly breaks into houses to steal money and jewellery on Sunday night. Police recovered Rs 7.7 lakh in cash, along with stolen goods and jewellery.

According to police, on Dec 16, the accused stole cash and jewellery along with other valuables from a house in Jagriti Apartment in Sector 71. On Dec 18, they broke into a house in Mamura, Sector 66 and stole cash and jewellery.ADCP (central Noida) Hirdesh Katheriya said that, on Sunday, a team from Phase 3 police station took action on the basis of beat policing and confidential/electronic information. Accused Jitendra alias Golu and Rajesh alias Ganja were arrested from the service road near Gandhi roundabout the same night. An FIR has been registered against the two under Section 305(A) (theft) of the BNS.

"During interrogation, the accused revealed that they used to carry out reconnaissance of the area by removing the number plate on their bikes. Then they targeted locked houses and opened them with the help of a 'master key'. After committing the theft, they used to leave by putting the number plates back on their



vehicles," the ADCP said. The accused, along with their accomplices, would steal jewellery from people's locked houses and then immediately have the items cleaned with chemicals to sell it.


"They keep some jewellery after cleaning it for their own use. The thieves themselves clean the jewellery with chemicals so that the victim may be unable to identify it," Katheriya said. According to Phase 3 SHO Dhruve Bhushan Dubey, police recovered around Rs 7.7 lakh in cash along with gold and jewellery from the accused's possession.

Groundwater levels fall in Gzb, Loni is worst affected

Ghaziabad: Not unlike its neighbour Noida, urban and densely populated parts of the city are fast losing groundwater due to excessive use.Groundwater in Loni, according to an analysis by Ghaziabad's groundwater department, plummeted almost 15 metres between 2018 and

Data was collected through piezometers at five blocks of the city before and after monsoon.Post-monsoon figures for Loni were relatively better. Groundwater, which was detected at a depth of 18.8 metres, dropped to a depth of 27 metres, recording a decline of over 8 metres over the six years.Ghaziabad block, which covered areas such as Vaishali and Vijay Nagar, followed Loni in witnessing the highest groundwater losses.

The average decline in Ghaziabad preand post-monsoon was around 7 metres, the department found. The largest depletion within Ghaziabad block was seen in Vijay Nagar, which recorded a fall of 8.6 metres pre-monsoon, and 6.7 metres in post-monsoon assessments between 2018 and 2024. Another



station at Shri Guru Nanak Kanya Inter College saw groundwater availability decline by over 12 metres in the same Officials said Ghaziabad's water supply timeframe. At Vaishali station, the fall was 6.2 metres in calculations taken ahead of monsoon in 2018 and 2024.

The third block, Razapur, saw a relatively lower depletion, though it was still significant, at over 6 metres both preand post-monsoon. The losses in Bhojpur and Muradnagar blocks were the lowest.

The city's daily water demand is around 345 million litres, while GMC's supply is 320 MLD, a Residents said piped Ganga water supply was promised to Vijay Nagar almost a decade ago, but it is yet to reach the houses there. Officials said funds are to be released, and work to get river water there would take another four months after that.

Water scarcity is severe here, especially during the summer. It affects around six lakh residents. Groundwater level is one of the lowest in the district, and we have been demanding Ganga water for years. The Pratap Vihar Ganga water treatment plant is on the other side of the road, and still, our demands have not been met," said Manish Verma, a resident of Vijay Nagar.TOI had reported earlier this year that Ghaziabad extracted an alarming 123% of water it recharged last year. This extraction rate surpassed that of 75 districts in UP, where the average was significantly lower at 70.8%, according to an assessment ordered by the Central Ground Water Board. Ghaziabad was also ranked among India's 151 water distressed districts, according to central

Middle-east war: Israeli's defense minister accepts killing Hamas leader Ismail Haniyeh

World srael's defense minister has confirmed that Israel assassinated Hamas' top leader last summer and is threatening to take similar action against the leadership of the Houthi rebel group in Yemen.

The comments by Israel Katz appeared to mark the first time that Israel has acknowledged killing Ismail Haniyeh, who died in an explosion in Iran in July.

Israel was widely believed to be behind the blast and leaders have previously hinted at its involvement.

In a speech Monday, Katz said the Houthis would meet a similar fate as the other members of an Iranian-led alliance in the region, including Haniyeh.

He also noted that Israel has killed other leaders of Hamas and Hezbollah, helped topple Syria's Bashar

Assad and destroyed Iran's anti-aircraft systems. "We will strike (the Houthis') strategic infrastructure and cut off the head of the leadership," he said.

"Just like we did to Haniyeh, Sinwar and Nasrallah in Tehran, Gaza and Lebanon, we will do in Hodeida and Sanaa," he said, referring to Hamas and Hezbollah leaders killed in previous Israeli attacks. The Iranianbacked Houthis have launched scores of missiles and drones at Israel throughout the war, including a missile that landed in Tel Aviv on Saturday and wounded at least 16 people.

Israel has carried out three sets of airstrikes in Yemen during the war and vowed to step up the pressure on the rebel group until the missile attacks stop.

Like other northern traditions such as the Yule Lads of Iceland, this visitor gave gifts but only to well behaved children.

That image built on but sanitised the more grotesque European folklores of elves, gnomes and other supernatural creatures who either brought or demanded gifts.But standardising Santa's appearance did not settle where he actually lived and worked. Low Birth Rates, Ageing Population Make South Korea 'Super-Aged Society'

Seoul, South Korea. South Korea has become a "superaged society", with 20 percent of its population aged 65 or older, official data showed on Tuesday, a gloomy trend driven by an alarmingly low birth rate.

Asia's fourth-largest economy recorded just 0.7 births per woman late last year -- one of the lowest birth rates in the world and far below the replacement rate of 2.1 needed to sustain the current population.

That means South Korea's population is ageing and shrinking rapidly. Those aged 65 and older "account



for 20 percent of the 51.2 million registered population, numbering 10 million", the interior ministry said in a news release on Tuesday, placing South Korea alongside Japan, Germany and France as a "super-aged society".t also means the elderly population has more than doubled since 2008, when it numbered fewer than five million, according to the ministry. Men account for 44 percent of the current 65and-older group, the data showed. The government has poured billions of dollars into encouraging more births, with Seoul authorities offering subsidies for egg freezing in one recent effort. However, such efforts have failed to deliver the intended results and the population is projected to fall to 39 million by

2067, when the median population age will be 62. Experts say there are multiple causes for the twin phenomena of low marriage and birth rates, ranging from high child-rearing costs and soaring property prices to a notoriously competitive society that makes securing well-paid jobs difficult.

A treaty was signed between the United States and Panama under which the canal would be constructed and managed by the US. After 10 years of engineering works round-the-clock, the Panama Canal became a reality in August, 1914 with the

SS Ancon becoming the first ship to pass through the canal. The US continued to control and operate the canal and its surrounding areas until a new agreement was signed between Panama and the US called the Torrijos-Carter Treaty in 1977. This provided for the handover of the canal to Panama after joint operations for nearly two decades. The Panamanian government took full control of the canal in 1999.DONALD TRUMP vs

"The United States supports a prosperous, stable, and democratic Bangladesh, and offers continued assistance in addressing the challenges it faces," the White House

Bangladeshi Traders "Forced" To **Import From Pakistan Amid Growing Maritime Ties: Report**

Dhaka.In a concern for India, trade and maritime ties between Pakistan and Bangladesh seem to be getting stronger, with a second cargo vessel from Karachi reaching the Chittagong port this week. The Panamaflagged ship 'MV Yuan Xiang Fa Zhan' entered Bangladeshi waters on Sunday afternoon, according to Bangladeshi media reports. The vessel, which travelled via Karachi, Pakistan, and Dubai, United Arab Emirates, is carrying a substantial load of 811 containers of essential industrial materials such as soda ash, dolomite, and marble blocks, along with goods like garments raw materials, sugar, and electronic products, Dhaka Tribune and Daily Observer reported. The development came a day after Bangladesh's interim leader, Professor Muhammad Yunus, met Pakistan's Prime Minister Shehbaz Sharif in Egypt's Cairo, where Dhaka and Islamabad "agreed to strengthen relations."

Quoting sources, The Economic Times reported that traders in Bangladesh are being forced to import goods from Pakistan. It also said that some officials in Bangladesh's shipping ministry are suggesting to review of the India-Bangladesh shipping pact, which gave India access to Chittagong and Mongla ports.

Concern For India

Chittagong Port is a strategically located docking site in the Bay of Bengal. Over the years, India has used its relationship with ousted premier Sheikh Hasina to keep an eye on the activities at Chittagong port, where in 2004, around 1,500 boxes of Chinese ammunition were confiscated.

The consignment, worth an estimated USD 4.5-7 million, was allegedly masterminded by Pakistan's intelligence agency, the Inter-Services Intelligence (ISI). The consignment was allegedly meant to be delivered to banned terrorist outfit ULFA (United Liberation Front of Asom) in India. New Delhi worries a resurgence of Islamist extremism in Bangladesh could target India and support insurgent groups in northeastern states. Adding to India's worries, Bangladesh, in September, removed the clause which required the port authorities to physically inspect cargo from Pakistan on arrival. This makes it easier for Pakistani vessels to use the maritime routes without the physical inspection of cargo. Earlier, the restrictive trade policy under Ms Hasina required cargo from Pakistan to be offloaded in Malaysia, Singapore, or Sri Lanka and then transferred to other vessels that carried them to Bangladesh. Indian officials kept a watchful eye on sea routes that connect Chittagong. Bangladesh-Pakistan Ties

Muhammad Yunus, the 84-year-old Nobel laureate, who took over as leader of Bangladesh's interim administration in August, is a staunch opponent of Ms Hasina's policies, which were fundamentally pro-India and anti-Pakistan. Since he came to power, one of his areas of focus has been improving relations with Islamabad. A major development in this regard was to initiate direct maritime connectivity between the two previously hostile Muslim-majority nations, which were once one country.

Blogs To Bluesky: How Social Media Changed Our Response To Disasters

Jakarta, Indonesia. The world's deadliest tsunami hit nations around the Indian Ocean two decades ago before social media platforms flourished, but they have since transformed how we understand and respond to disasters -from finding the missing to swift crowdfunding.hen a 9.1-magnitude quake caused a tsunami that smashed into coastal areas on December 26, 2004, killing more than 220,000 people, broadcasters, newspapers and wire agencies were the main media bringing news of the calamity to the world. Yet in some places, the sheer scale took days to emerge.Survivor Mark Oberle was holidaying in Thailand's Phuket when the giant waves hit Patong beach, and penned a blog post to fend off questions from family, friends and strangers in the days after the disaster."The first hints of the extent were from European visitors who got text messages from friends back home," said Oberle, adding people initially thought the quake was local and small, when its epicentre was actually near western Indonesia, hundreds of miles away."I wrote the blog because there were so many



friends and family who wanted to know more. Plus I was getting many queries from strangers. People were desperate for good news tales," said the US-based

physician, who helped the injured. The blog included images of cars ploughed into hotels, water-filled roads and locals fleeing on scooters because rumours produced "a stampede from the beach to higher ground".Bloggers were named 'People of the Year' by ABC News in 2004 because of the intimacy of first-hand accounts like those published in the days following the tsunami.But today billions can follow major events in real-time on social media, enabling citizen journalism and assistance from afar, despite the real risk of rumour and

misinformation.During Spain's worst floods for decades in October, people voluntarily managed social media accounts to assist relatives trying to locate their missing loved ones. After Turkey's devastating earthquake last year, a 20-year-old student was rescued thanks to a post of his location while buried under

Two decades ago, the online social media landscape was vastly different.

Facebook was launched early in 2004 but was not yet widely used when the tsunami hit.One of YouTube's founders reportedly said an inspiration for the platform's founding in early 2005 was an inability to find footage of the tsunami in its aftermath.Some tsunami images were posted on photo site Flickr. But X, Instagram and Bluesky now allow for instant sharing. Pakistan May Get 40 5th-Gen Stealth Fighter Jets From China Within 2 Years

World.In a game-changing proposition, China is reportedly in talks with Pakistan for Islamabad to procure 40 advanced stealth fighter jets from Beijing. The J-35A is China's most advanced military aircraft.

If the deal is finalised, Pakistan will be the squadron of the stealth J-35A multi-role fighter jets outside of China. It will also mark the first export of China's most advanced military aircraft by Beijing.

The J-35A is China's second fifth-generation stealth fighter jet. After United States, China is the only other country in the world to have two 5th-gen military aircraft. Pakistan is looking to replace its ageing fleet of US-made F-16s and the French Mirage fighters. As per a report in the Hong Kong-based South China Morning Post, which further quotes the Pakistani media, China will deliver all 40 stealth fighter jest in less than two years. China's entire defence industry is already set up for mass production as it does not depend on any other country for any part of the aircraft. The report also states that Pakistan's Air Force has already approved the purchase of these

jets. Though there is no confirmation from Beijing, should such a deal materialise, it will provide Pakistan a massive boost to its air defence and has the potential to tilt the regional dynamic as Islamabad will acquire stealth technology.

first and only country globally to have a WHAT IS KNOWN ABOUT THE CHINESE J-35A STEALTH

The Shenyang J-35A stealth fighter is a twinengine, single-seater, supersonic, airsuperiority, multi-role fighter jet that can carry out missions on land and at sea. The J-35A is the second fifth-generation stealth fighter China has developed after the J-20.

The J-35A's design is similar to the US Lockheed Martin F-35, the only difference is that the former is twin-engine and the latter has a single engine. China is known for copying the design of several US aircraft - The J-20 and the US F-22 Raptor are very similar in design except for canards that are present in J-20. The Chengdu J-10, also known as the "Vigorous Dragon", is yet another Chinese aircraft which seems to be a copy of the US F-16 fighter jet. According to a report by the Global Times, the



mouthpiece of the Chinese Communist Party, "J-35A functions within both stealth and counter-stealth combat frameworks. Its mission focuses on gaining and maintaining air superiority, eliminating hostile fourth/fifth generation fighter jets and ground/surface air defence forces, as well as intercepting aerial hostile targets including fighters, bombers and cruise missiles." The article was published the day China unveiled the jet for the first time last month.China plans to induct the aircraft into the Air Force and the Navy, exactly the way the F-35 is used by the United States,

having three variants - The F-35A for the Air Force, F-35B for the Marine Corps and F-35C for the US Navy.

PAKISTAN'S ECONOMIC CRISIS

Despite a severe economic crisis in the country, Pakistan, which is surviving on bailout packages by the IMF and World Bank, is reportedly going ahead with the deal. It is not clear though, how such a massive deal will get financed. According to defence experts, it won't come as a surprise should China decide to extend another loan which Pakistan won't able able to pay back. Pakistan has already accumulated so much debt from Beijing that it is not financially possible for Islamabad to pay it back. Many experts believe that at some point Pakistan will have to sell national assets and maybe even parts of the country to be able to settle the debt. Though the buzz is ripe in Islamabad, Beijing has not confirmed the sale of its stealth fighter jet in any official communication. Neither has it mentioned it in the passing. When the J-35A stealth fighter was first displayed publicly by China at the annual air show at Zhuhai city.

TN teachers in provisional list file petition to fill up vacant posts

DHARMAPURI. Candidates selected in the 'Provisional Selection List for appointment of BT and BRTE teachers' filed a petition with the district collector, urging the state government to appoint teachers to vacant posts in the School Education Department.

Teachers' Eligibility Test (TET) in February and after concluding certificate verification in June, they released a 'Provisional Selection List' in July where about 3,192 teachers were selected. While certain departments like Adi Dravidar schools and the Greater Chennai Corporation schools have appointed teachers, the School Education Department has not made any appointment."C Shankar, another teacher said, "Most people who took the exam were employed in private schools before the list was released. After it was announced, private schools asked teachers to resign as they did not want them to leave in the middle of a term. For six months, teachers in the 'Provisional Selection List' are without jobs."Dharmapuri administration officials said, "We will forward the petition to the concerned department and they will take necessary steps. There is nothing we can do in this matter.

Zeenat on the run: 130 staff from three states wait and watch to dart the cat

A decent opportunity to dart the dispersing cat to relocate it back to Similipal Tiger Reserve (STR) appears to be the only option with Zeenat continuously on the move.

BARIPADA/BHUBANESWAR. As it explored new forest landscape in neighbouring West Bengal, tigress Zeenat continued to keep staff of three states on their toes while Odisha wildlife wing banked on tranquilising the three-year-old big cat to bring it home.

A decent opportunity to dart the dispersing cat to relocate it back to Similipal Tiger Reserve (STR) appears to be the only option with Zeenat continuously on the move.

About 130 forest personnel including a tiger squad from Mayurbhanj and expert team from Sundarbans have joined the search operation for the tigress that managed to escape the surveillance on multiple occasions, keeping forest officials of Odisha, Jharkhand and West Bengal on tenterhooks



for the last two weeks. The tigress first moved into Jharkhand forests and was later traced to a jungle in Belpahari range of Jhargram forest division in West Bengal early Friday. Sources said it has now moved to a forested area of Bandwan in Purulia via Lalgarh. The forest officials have made multiple attempts to tranquilise it but in

The forest officials tracking the movement of Zeenat reportedly faced difficulties as the big cat roamed the landscape, covering about 25 km to 30 km area in a night. Prior to its entry into West Bengal, the tigress had also reportedly covered around 26 km a day.

The alleged disruption in transmission of signal from the radio collar is also reportedly making the big cat incommunicado at times.

'The forest team sent to Jharkhand to track Zeenat was immediately mobilised to West Bengal for constant monitoring in the neighbouring state," said PCCF (wildlife) Prem Kumar Jha. Three teams, two from West Bengal and one from Odisha, are now tracing it and waiting for an enabling environment to carry out the tranquilisation,

The teams from West Bengal include The female tigress, brought to STR from specialists from Sundarbans to assist officials for darting of the tigress, Jha said.

The PCCF (wildlife), however, said the disruption in transmission of signals did not persist long and they have been receiving signal about its location on an hourly basis. Similipal field director Prakash Chand Gogineni said a strategy is underway to tranquilise the tigress and bring it back to the

Tadoba-Andhari Tiger Reserve (TATR) in Maharashtra, entered Jharkhand after exiting Similipal landscape on December 9.Jamuna, the first tigress relocated to STR from TATR in October, also moved out of STR core and is now roaming in adjoining Kuldhia wildlife sanctuary. Jha said their teams are also tracking the movement of the 31-month-old tigress since last Sunday.

Samagra Shiksha to maintain data of migrant kids

COIMBATORE. Due to rising dropout rates among migrant students, Samagra Shiksha has planned to create a separate common pool in the Education Management Information System (EMIS) portal to maintain their data in order to track them.



This data will help officers understand whether students from TN or other states have higher dropout rates.An official from district Samagra Shiksha department told that details of all dropout students are maintained in a common pool within EMIS

"Based on common pool data, educational officers from Samagra Shiksha and school headmasters will trace students who have dropped out due to migration, child labour, or other reasons through a

Then they can take steps to bring these children back to school," he added.

"However, compared to the children from the state, those from Odisha, Bihar, etc are mostly dropping out of school as per the common pool. Hence, the overall dropout in the common pool is high and when these details are sent out, people think that a number of students from Tamil Nadu are dropping out.

For instance, the common pool shows 9,219 students have dropped out of school from Coimbatore. Through surveys, it was found that 7,162 students are from other states and they migrate with their family for work occasionally. Out of 7,162 students, 889 are Tamil students who have been re-enrolled to government schools, and remaining students studying in private schools

NCC camp shut after nearly 80 students suffer food poisoning

Thrikkakara was shut down early on Tuesday after nearly 80 students were admitted to various hospitals following food poisoning at the camp, which was attended by around 600 cadets from various colleges in the state. The students were attending the NCC camp at KMM Arts and Science College in Thrikkakara, where they developed

Around 600 students attended the camp at the college. Of them, around 70 reported illnesses suspected to be caused by food poisoning. We visited the spot and collected samples of the food and water served at the college. So far, the condition of the students is satisfactory. No complications have been reported," said a health official



from Thrikkakara Municipality. Following the mass hospital admissions,

parents and residents of the area held protests at the college."The parents of the students and a few residents of the area arrived at the college after learning about the incident. They have been protesting in front of the college. The camp was cancelled, and the students were sent back home," said an official from Thrikkakara Municipality.Students from different colleges in the district had been at the college for the past three days. "From our interactions with the students, we

from various health issues for the past two days. We suspect that the food served at the college caused the spread. We have sought an explanation from the college management, and the police have started an investigation into the issue," the officials added. Kerala HC flays state over dumping of medical waste in Tamil Nadu

KOCHI. Coming down heavily on the state government over the dumping of biomedical waste from Kerala in Tamil Nadu, the Kerala High Court on Monday directed the secretary of the local self-government department to file an affidavit with details of the agencies engaged in collection and disposal of waste from local authorities and other bulk waste generators, including hospitals. The High Court also called for information on the

measures initiated to track the mode and the manner in which such agencies dispose of the collected waste.A division bench comprising Justice Bechu Kurian Thomas and Justice Gopinath P issued the order after noticing media reports regarding the illegal dumping of Kerala's biomedical, plastic, food, and other waste in Tirunelveli, Tamil Nadu."Quite often, we have been indicating to the Kerala government the necessity to keep track



of the mode in which the waste is being disposed of by agencies that collect waste. It is an alarming situation that the waste generated in Kerala is disposed of in the neighbouring state, haphazardly and contrary to legal requirements. Such instances should be avoided," the court said.

HC demands govt to explain steps

When a suo motu case registered earlier concerning the waste management issue in the state came up for hearing, the court questioned whether the government was keeping track of the place where the waste was being disposed of. The government consistently claims that it is monitoring the situation. However, it appears that it does not know about the final disposal of waste, it observed. The court stated that it wanted to identify who was at fault in the Tamil Nadu incident and demanded that the government explain the concrete steps it has taken to address the issue.

The New Indian Express had visited the spot in Tirunelveli and brought out the issue. Later, the Southern Bench of the National Green Tribunal (NGT) initiated a suo motu case based on the report of TNIE. The NGT issued an order to the Kerala government to take appropriate action. Based on the order, the officials removed the waste using 16 Kerala-based trucks to transport it back to the state. The court will hear the matter on January 10.

This includes 508 MW of ground-mounted, 58 MW of rooftop and 42 MW of off-



potential aggregating to over 200 GW across deployment technologies, it stated adding, the state is blessed with abundant solar resources with over 300 days of uninterrupted sunshine and average solar radiation of about

5.3kWh per square metre.Citing the data of National Institute of Solar Energy (NISE), it stated that Odisha has the potential to generate 138 GW ground-mounted solar power utilising only 7 per cent of the wasteland. Sundargarh, Angul, Balangir, Jharsuguda and Dhenkanal have the highest potential for the same.Around 33.5 GW floating solar potential could be harnessed across 670 sq km of feasible water body area. Odisha's building footprint area can also support up to 10 GW of rooftop solar capacity, the organisation revealed in its findings.

The Investor Conclave deliberated on the 7.5 GW solar capacity that Odisha

aims to achieve by 2030 as part of its larger plan of generating 10.95 GW renewable energy by the period. Speaking at the conclave, deputy chief minister KV Singh Deo said the state will harness the solar potential across all sectors for the progress of its renewable energy sector. "Solar energy is a key driver for the state's growth. Our investment climate is conducive and we also have a robust system in place to harness its potential," he added. The deputy CM further said the conclave is a precurser to the upcoming Utkarsh Odisha 2025 where the state government is hopeful of getting huge investment intent in the sector.Energy secretary Vishal Dev

said Odisha is on the cusp of a transformative energy transition and the conclave is a testament to the state's commitment to clean energy. GRIDCO managing director Trilochan Panda said a large chunk of renewable energy will come from floating solar, rooftop solar and PM Kusum scheme in the coming days. "A lot of incentives have been given by the state to promote renewable energy," he added.

iFOREST president and CEO Chandra Bhushan said the potential of renewable energy will expand in the next five years. It will also help states in developing a low-carbon pathway and encourage green environment and

Police reform augurs well for Himachal

HIMACHAL Pradesh is set to usher in a change for its police force. The newly introduced Himachal Pradesh Police Amendment Bill 2024 proposes transitioning police constables from a district cadre to a state cadre. This means that instead of individual districts conducting their own recruitments, a state-level Police Recruitment Board will handle this job. This is in line with the practice followed by states such as Uttar Pradesh, Bihar, Madhya Pradesh, Rajasthan, Andhra Pradesh and Telangana. Supporters aver that centralised recruitment insulates the process from parochial pressures and ensures a more uniform and transparent means of selecting police personnel. A centralised exam eliminates the advantage held by candidates residing near district recruitment centres. The arm's length process also opens the door to a larger talent pool to recruit from. Others, though, feel that it does nothing to level the playing field as urban candidates often have the benefit of better education and accessible coaching facilities than rural folk.

The new amendment also allows for the subordinate police to be deployed outside their district anywhere in the state. Normally, they would stay put in the district they had been recruited from. This has always sparked a debate, with both potential benefits and drawbacks for recruitment, ground-level policing and the constabulary itself.

Proponents argue that a single state cadre for police constables allows for more efficient man management. The government can easily transfer officers to address manpower shortages, respond to emergencies and quickly redress vacancies or gluts across districts as circumstances demand. Quick and fluid deployment is particularly valuable in a state with seasonal tourist influxes.

On the other hand, there is concern that the much used and abused power to shift biased, corrupt or otherwise 'inconvenient' personnel from one place to another, while touted as being in aid of administrative necessity, will tighten executive and legislative hold over the establishment and tend to increase the chance of politicisation. Nevertheless, the change addresses a long-standing grievance of the constabulary: limited promotion prospects within a district cadre. A state cadre system offers more opportunities for advancement, as constables can compete for promotions anywhere across the state. This could boost morale and incentivise better performance. A side benefit: it may reduce litigation born out of perceived injustice in promotions and the like.

The flip side is the potential disruption to personal lives. Constables transferred to new districts often face challenges finding accommodation and adjusting to unfamiliar cultural environments. This could create a sense of instability and distances can fracture family lives and children's education. However, inter-district transfers are much more prone to the dangers of familial disruption and disorientation in large states than a compact one like Himachal. Unlike in big and heavily urbanised states, some of these risks may be minimal in Himachal's case. Police housing arrangements already involve a mix of Police Lines, government-provided housing and private residences. Housing is more easily available and affordable than in big metropolises. Thoughtful postings that send personnel to districts closest to where their families stay could go a long way in maintaining work-life balance. Concerns also exist about the impact on community policing. Critics argue that constables stationed outside the communities they have been born and brought up in may lack the cultural understanding and local knowledge necessary to effectively engage with new communities. This could hinder trustbuilding and communication, essential for effective ground-level policing.

To foster better police-public relations, some police stations in Himachal have already initiated community policing forums, elsewhere beat policing in specific areas help establish more stable engagement and frequent awareness programmes. Regular meetings and workshops help dispel misconceptions.

Manipur conflict not just a local crisis

It is a microcosm of the broader challenges of managing diversity in a pluralistic society

THE conflict in Manipur, now in its 19th month, shows few signs of an early resolution. In his address on Vijay Diwas on December 16, Chief Minister Biren Singh blamed the unrest on 'certain agencies' that are attempting to destabilise the state. He further cited the role of politically motivated and one-sided information as a major contributor to Manipur's instability. He also claimed that misinformation had been conveyed to Central leaders, creating confusion regarding the appropriate course of action.

In evaluating the situation in Manipur, it is helpful to reflect on how the Indian State has effectively managed insurgencies across the Northeast and why Manipur has now diverged as an exception. The Northeast has long been a battleground of ethnic assertions, with armed movements emerging soon after Independence. These movements, primarily fuelled by tribal groups asserting their identities, have raised demands ranging from secession to calls for greater autonomy. The Indian State has adopted a two-pronged approach to address them: overwhelming military force to establish control and sagacious accommodation of ethnic aspirations.

The Army initially adopted harsh measures, like the forcible relocation of villages, large-scale cordonand-search operations and retributive punishments. The military's role in suppressing insurgencies has often drawn criticism for human rights violations, yet it succeeded in establishing the writ of the State. Alongside, the government displayed great foresight in addressing the concerns of different ethnic identities. The states of Nagaland, Mizoram and Meghalaya were carved out of Assam, while Manipur and Tripura went from UTs to statehood. Articles 371A, 371C and 371G were incorporated in the Constitution, providing special provisions for the tribal communities. Autonomous councils under the Sixth Schedule further empowered ethnic groups like Bodos, Dimasas, Karbis, Khasi, Garos and Chakmas, giving them legislative and administrative control over land and local customs.

A concerted effort was made to get the armed cadre to eschew violence through generous surrender programmes. One criticism of this was that the cadre remained in designated camps and were never absorbed into civil society through rehabilitation and, thus, retained their militant group identity. While not perfect, the dual strategy of control and accommodation was successful in significantly reducing violence in the Northeast, with terror-related deaths dropping from over



1,000 in 2008 to just 13 in 2022. Manipur represents a volatile blend of three major communities — Meiteis, Nagas and Kukis — each with distinct cultural traditions. All groups maintain armed militant factions, often regarded as crucial for safeguarding their identity in a multi-ethnic landscape. The Meiteis, as the majority community residing in the central valley, have traditionally held significant political power in Manipur. However, they lack the constitutional safeguards available to the tribal Nagas and Kukis, such as quotas in education, jobs and land rights. This imbalance has long been a source of tension. Frequent blockades by tribal groups to press their political demands also affected the Meiteis by disrupting daily life, deepening economic woes and worsening inter-community ties.

On the other hand, the tribal communities view the special provisions as essential protections against cultural erosion — protections that they argue are necessary due to their minority status. State and Central governments have sought to balance a complex interplay of differing types of accommodation — political power for the Meiteis and special safeguards for the tribals. While this meant that some grievances of the Meiteis remained unaddressed, a fragile status quo was maintained. In a sensitive ethnic environment, self-aggrandising politicians can exacerbate conflict by using ethnic

identities as a tool to mobilise support, portraying themselves as the protectors of one group while demonising another.

This is what happened in Manipur when the CM's rhetoric against the Kukis became strident. While he justified his actions as acting against illegal immigrants, drug traffickers and encroachers on forest land, they sparked alienation among the Kukis. In March 2023, the state government withdrew from the Suspension of Operations agreements with the Kuki National Army and Zomi Revolutionary Army, signalling an end to negotiated peace efforts.

David Lake and Donald Rothchild, in their seminal work Containing Fear: The Origins and Management of Ethnic Conflict, argue that "stable ethnic relations can be understood as based upon a 'contract' between groups. Such contracts specify, among other things, the rights and responsibilities, political privileges and access to resources of each group... ethnic contracts channel politics in peaceful directions."Any

perceived imbalance in this contract can ignite conflict. In Manipur, this imbalance was exacerbated by exploitative politics and ethnic activism that created a deep polarisation between the Meiteis and Kukis. Violence appeared inevitable, and the spark came in May 2023 when the Manipur High Court directed the state government to recommend granting ST status to the Meiteis. Today, the geographical and psychological divide between the Meiteis and Kukis is nearly complete. The state forces appear to be helpless actors as armed civilian gangs from both sides roam the countryside in search of defenceless victims. Amid the civil war in Myanmar and instability in Bangladesh, the situation in Manipur is acquiring a larger national security dimension. We must learn some lessons. Manipur's conflict is not just a local crisis but a microcosm of the broader challenges of managing diversity in a pluralistic society. India's ethnic mosaic is both its strength and a vulnerability. Handling ethnic diversity is not about sharpening differences, but embracing them within the framework of mutual respect and shared aspirations. The Northeast experience shows that peace is possible when governance is inclusive, leadership responsible and ethnic harmony treated as the foundation of a resilient

Blow to transparency

Tweaking of poll rule raises eyebrows

WHEN the Supreme Court declared the electoral bonds scheme unconstitutional in February this year, it emphasised the voter's inalienable right to information — including the right to know the details of individuals and companies making donations to political parties. The landmark verdict also served as a reminder to the Union Government, which had backed the controversial scheme to the hilt, that there should be no compromise on transparency as the integrity of the entire electoral process was at stake. The Centre seems to have conveniently forgotten the SC's ruling. Based on a recommendation of the Election Commission of India (ECI), the Law Ministry has amended Rule 93(2)(a) of the Conduct of Election Rules in order to prevent public scrutiny of electronic documents such as CCTV and webcasting footage as well as video recordings of

webcasting footage as well as video recordings of candidates. The unconvincing argument is that such material, if made accessible to one and all, can be misused to the detriment of votage and concerns the detriment of votage and conc



to the detriment of voter safety.
Such fears and concerns just don't hold water in the age of

social media. Footage of voters coming out of polling stations is widely available. In many cases, electors themselves share their photos and videos on digital platforms. The CCTV cameras installed at polling stations merely keep an eye on the poll officials – they do not violate the secrecy of the ballot. There is no camera that records the voter pressing a certain button on the EVM. Still, the ECI is losing sleep over this non-issue.

The timing of the amendment is a dead giveaway. It comes in the wake of the Punjab and Haryana High Court's order that all documents related to the Haryana Assembly elections be shared with the petitioner in the 'Mehmood Pracha vs ECI' case, including CCTV camera footage as permissible under Rule 93(2). The ECI would

be well advised to lift the veil of secrecy in the best interest of electoral democracy.

Academic institutions must raise the bar to be future-ready

As foreign universities set up campuses in India, the existing domestic beacons of literacy face many challenges.

THe National Education Policy has offered opportunities for progressive institutions to step into the new dynamics of millennial academics. Subsequent statutes have envisaged an era where collaborative uplift, shared synergies, global partnerships and Vision-2050 shall define the academics of tomorrow. As foreign universities set up campuses in India, partnering with local organisations or embarking on singular forays, the existing domestic beacons of literacy face many challenges. Some institutions of faith had long back acquired significance and developed into arenas of higher learning. They include Banaras Hindu University, Aligarh Muslim University and Khalsa College, Amritsar. Khalsa College did not get the status of a university by default because of its non-cooperative attitude towards the British. Its pro-Independence stance led to its stagnation. That discrimination, however, did not stop in independent India either. Its aspiration of graduating into a university has been stalled at many junctures in its history since 1892.

Meanwhile, the Anglo-Vedic college network of DAV institutions grew at an aggressive pace, delivering sanatan-accented education across the northern region. In 2016, both Khalsa College and the DAV, along with nine other private bodies, were granted university status by the Akali-BJP government in Punjab.However, within months of this development, the subsequent Congress government singled out the Khalsa institution and repealed the Act under which it was set up. By then, it had 180 masters and PhD scholars on its rolls. They had to run helter-skelter to continue their courses. The fact that Khalsa University, independent of the Khalsa College, eventually came into being and was rescinded, was a body blow to the Khalsa College Charitable Society. It had aspired for this honour and nurtured

many other universities from within its campuses. However, in October this year, after a six-year delay, the

Supreme Court gave a landmark judgment, setting aside an Act of legislature and adjudicated status quo to the 2017 formation. This victory for academic institutions has laid bare the illogical stance of politics.

Meanwhile, despite these adversities, the Khalsa society had made significant progress in the last two decades. It had set up professional colleges of pharmacy, nursing, law, veterinary sciences, education, engineering and others, while consolidating and increasing the number of students in the legacy institutions. A hospital and medical college is also in the offing.

The role of faith institutions in the field of school education, too, has been colossal. Over 55,000 Christian missionary schools are catering to 25 million children of all faiths in India. It is said that the majority of Indian Prime Ministers have received convent education at some point in their lives. In contrast, there are only around 24,010 madarsas and some 4,500 Vedic gurukuls in the country. In the Sikh community, the Guru

Harkrishan Public School movement and SGPC schools number just a few hundred. Various faiths follow an inclusive and secular approach to primary education, while Islamic institutions run on the strict madrasa system with a religious and ideological approach to learning. Though the higher echelons of learning are more transparent, the appetite for openness is limited. The Economic Survey 2024 has highlighted serious gaps in the education system, wherein 52.8 per cent of the graduates were found to be 'unemployable'. This is a telling comment on systemic failure and necessitates introspection. For academic institutions,

especially those with extensive networks, the time has come to either make it in the business of literacy or be left behind. Vice-President Jagdeep Dhankhar recently termed the quest for overseas education a 'new disease' which has caused a \$6-billion hole in our foreign



exchange kitty. Now, the global village itself is planting seeds of competition in our midst.

To stem academic procrastination within India, the Central Government has opened its doors not just to the Cambridges and Harvards of the world, but also any institution that has substantive prowess and history of excellence in the field of knowledge. It has, perhaps, set

a purposeful cat among the pigeons.

The question, thus, shall be of leadership and educational acumen of institutions. It shall be a test of the managements — whether they can ride the change or will go under. Some faith organisations have built-in

systems of governance to improve their competence and service delivery. Anglo-Vedic institutions have a policy of bringing on board stalwarts like retired Army Generals, judges and government servants.

Christian missionary institutions have incorporated structures to ensure that new blood is nurtured. A case in point is the succession strategy of Christian Medical College. It selects its leadership five years in advance. The person is nurtured for the task at hand and even sent for an executive training programme to the IIM-Ahmedabad to hone his/her

The future of successful enterprises in higher learning, thus, hinges on whether they can forsake nepotistic tendencies, political encumbrances and leadership fatigue. They must adopt a professional approach. The managements will be tested for their wisdom as well as the acumen and dynamism of their executive teams and educators. The latter will need to be open to unlearning and relearning the art of teaching. Their goalpost should be the placement and successful careers of their wards. The alumni

base is an unmatchable asset of any school. It will also be required to be primed for participation in this onward march.GenNext cannot be given short shift if we are to convert the nation's demography into a dividend. While India@75 has fallen way short of its target of having a fully productive generation, India@100 will require a larger number to be serviced along with more options and opportunities as well. It is the learners who will, henceforth, have the option to choose from a wider bouquet of academic institutions, of faith or otherwise. The deliverer of knowledge will need to compete and be future-ready. Otherwise, it is likely to be in for a future shock.





7 ways to keep your kid Stress-free

Your child is appearing for boards, but you're the one popping a stress vessel? 7 ways to keep it together for your kid.

Rohan aspired to study abroad and much of his hopes were pinned on the exams and the impending results. He dreamt of nothing less than a 90 per cent. Poonam found herself completely engulfed with the idea and took on the mantle to fulfil his desire. It wasn't just the examination that caused her anxiety -the thought of her son's dream of studying abroad crumbling, should his percent not be up to the mark, made her go off the deep

Poonam found her solace in Buddhist chanting. Each time she felt her anxiety levels soaring, she would gather with her friends and chant, "I realised I was passing on my anxiety to my son, which would frustrate him," she recalls. "So

much so, each time he would find me getting anxious, he would tell me, 'mama, please go chant". While examination patterns have evolved, experts claim, parents -when confronted, literally, with testing situations like the pressing board exams -haven't. Nearly a fortnight ahead of the HSC board exam (the first among the many important examinations that will follow), our panel of experts suggest seven ways you can avoid being the nagging monster and be a support system, instead.

Just stay calm

Displaying your nervousness to the child is quite common with parents. But it doesn't help. In a case like this, either the child turns into a complete rebel and deliberately does not study, or gets so nervous because of their parents' mounting pressure, that he/she will simply not able to perform. Clinical psychologist, Salma Prabhu shares, "Children often get exasperated, if parents continuously

tell them what to do and how to do it. This not only disturbs them, but also leaves a feeling of anxiety and insecurity regarding the upcoming exams. They may lose their confidence." Your best bet? Keep calm and let your child carry on. If you're unable to, seek counselling.

Leave your old-school ideas behind

"When I was preparing for my boards more than a decade ago, everyone was concerned about marks," says Azmin Mistry, an English teacher with a south Mumbai school. "But we now realise that these marks don't matter. If we are kinder towards exams, exams will be kinder to us." Enjoy the process. Tell your child to study to expand his/her knowledge. If you only focus on the grades, it puts undue pressure on them. "Besides, those who do well in school may not necessarily do well in Many parents feel anxious when their children life, and the reverse is also true. So, don't

Bombay Psychiatrist Society, Dr Kersi Chavda. "One is 15 or 16 when appearing for these exams, and parents must understand they have a whole life ahead of them. Doing poorly in an exam is not a sign that they are a failure in life."

Be a support system You don't have to put your life on hold for your child's exams. Continue with your job and social activities through the year. It's only around the time of the examinations that you may choose to be home to make things comfortable and easy for them. Be around to keep the house calm and peaceful, keep the fragrance pleasant and speak of only positive outcomes. Ensure that they are sleeping well, eating adequately and exercising daily, as these three factors help alleviate stress levels. Don't simply nag them to study. Learning is about absorbing, and that can only happen if the child is sufficiently relaxed and rested. Trying to memorise and learn new concepts till the end may result in memory loss or tiredness during the time of actual performance. "And know that exams are a bit about luck," points out Dr Chavda. "If your child has studied diligently and is still unable to perform for some reason,

spare the rod." Know the child's capacity

Popular Delhi restobar Bohca directed to stop serving liquor

New Delhi. The excise department has suspended the liquor licence of Bohca restobar in Delhi's Qutub Hotel and issued a show-cause notice and order, asking the management to explain why the licence should not be cancelled.

Stating that the tourism certificate, on the basis of which an L-16 liquor licence was given to Bohca, had expired in July, the excise department gave the licensee 15 days to explain why the licence should not be cancelled for the lapse.

Messages and calls to the restobar management went unanswered. "...the Licensee (Bohca) has not submitted a renewed certificate from the Tourism Department till date and by non renewal of the certificate...the Licensee has violated the provision of Rule 51 (10) of Delhi Excise Rule 2010, and therefore, the license (of Bocha)...is hereby suspended with immediate effect for the above said lapse," the order dated December 20

'In the meanwhile the Licensee (Bohca) is directed to cease the operation of service of liquor with immediate effect," read the order. It also directed Bohca to submit its reply, pointing out that failing this, it would be presumed that "the licensee is not in possession of certificate from Ministry of

Panchkula hotel shooting: Mitraon village in spotlight again, victims were uncle & nephew, their houses locked

New Delhi. The death of two persons from South West Delhi's Najafgarh in Panchkula's Pinjore, in what police believe is the fallout of a gang war, has brought the spotlight back on the Mitraon village in the area. Police said 30-year-old Vineet was a resident of the village, which has seen bloody shootouts in the past.

According to the villagers, the 17-year-old shot dead alongside Vineet was his nephew. The houses of the two, close to each other's, were locked on Monday evening. Speaking about the minor, a neighbour said, "He was a good kid... I heard that he was going to Chandigarh when he died... there's no one at their house." Pointing to her grandson, she added, "They were friends." The boy, silently listening to the conversation, refused to comment. Another neighbour added, "The boy had recently completed class 12. He used to play here in these streets along with others... We got the news in the afternoon. The other victim was his maternal uncle."Villagers said the family had left for their native village of Luksar in Haryana's Jhajjar. At Luksar, three villagers sat under the light of three dim bulbs. They had heard about the incident but said the families had lost touch decades ago. Also, the families of the two victims rarely ever came to Luksar, they added."There has been some sort of estrangement, so they no longer come here... We also came to know of the incident through WhatsApp messages and YouTube...,' said a man stationed at a temple in the village as a night guard. Najafgarh's Mitraon village is no stranger to shootouts or gang wars. Over the past three decades, it has borne the brunt of bloody

Delhi Records Above-Average Minimum Temperature For Second Consecutive Day; Air Quality Remains Near 'Severe' Category

New Delhi. North India is experiencing severe cold weather as temperatures drop across several states. In Delhi, the minimum temperature was recorded at 7 degrees Celsius on Tuesday, with parts of the city covered in a thin layer of fog. On Monday, the city registered a minimum temperature of 8 degrees Celsius, while the maximum reached 20 degrees Celsius. To cope with the cold, residents of Delhi were seen gathering around bonfires, while some sought shelter in night homes as temperatures declined further. Delhi experienced above-average minimum temperatures for the second consecutive day, with cloudy skies contributing to the trend. On Monday, the Safdarjung weather station, which represents Delhi's overall climate, recorded a minimum temperature of 9.9 degrees celsius, 2.4 degrees celsius above normal-compared to 8.6 degrees celcius the previous day. Other areas, like Palam, reported even higher minimum temperatures, with 10.4 degrees celsius, which is 2.5 degrees celcius

Meanwhile, air quality remained close to the "severe" category. At 9 a.m. on Tuesday, the city recorded an Air Quality Index (AQI) of 400 ("very poor"), slightly better than Monday's 24-hour average of 406 ("severe") and Sunday's 409 ("severe"). The maximum temperature on Tuesday is expected to reach around 19 degrees celcius. Tuesday is expected to reach around 19 degrees celcius.

An official from the India Meteorological Department (IMD) attributed the rise in temperatures to persistent cloudy skies. "The heat from the earth's surface is trapped at night due to cloud cover, causing temperatures to rise," the official explained. On Monday, Srinagar recorded a minimum temperature of minus 7 degrees Celsius and a maximum of 7 degrees Celsius, according to the IMD. The IMD defines a cold wave as when the minimum temperature is 10 degrees Celsius or below in plains and 0 degrees Celsius or lower in hilly areas. The IMD has predicted a severe cold wave in Jammu and Kashmir starting December 24. Dense fog wave conditions are also expected Rajasthan, Punjab, Haryana, Uttar Pradesh, and other states from December 23 to 25.

Kuldeep Sengar's interim bail extended by four weeks, asked to surrender on January 20

NEW DELHI. Kuldeep Sengar, a former BJP MLA serving a 10-year prison sentence for the custodial death of the Unnao rape survivor's father, has been granted an extension of his interim bail.

Justice Manoj Kumar Ohri of the High Court, while considering Sengar's plea for medical relief, noted that a division bench had already extended his suspension of sentence in the related Unnao rape case till January 20. The court order specifies that Sengar must surrender on January 20 following the extension. On December 20, a bench comprising Justices Prathiba M. Singh and Amit Sharma extended Sengar's interim bail in the Unnao rape case.

The court imposed conditions on him, including restricting his movements to his residence, except for medical visits to AIIMS, and prohibiting him from leaving Delhi. The division bench justified the extension by considering Sengar's health issues,



including recovery from eye surgery, and other ailments. It emphasised that this would be the final extension and no further relief would be granted.

Earlier, on December 5, the court had granted a temporary suspension of Sengar's sentence till December 20. In the custodial death case, the single judge aligned with the division bench's decision, extending Sengar's sentence suspension until December 20 and providing him 10 days of interim bail.

Sengar was convicted in December 2019 for raping a minor and sentenced to life imprisonment. He has appealed against the trial court's verdict and sought to overturn the sentencing. The case pertains to a 2017 incident where Sengar allegedly kidnapped and raped the minor survivor. In a separate judgment in March 2020, Sengar was sentenced to 10 years of rigorous imprisonment for the custodial death of the survivor's father, who was arrested on fabricated charges under the

On Sunday, a senior police officer said that 175 individuals have been identified as suspected illegal Bangladeshi immigrants during an extensive verification drive conducted in outer Delhi. The Delhi Police launched a drive for identifying illegal Bangladeshi immigrants on December 11, a day after L-G Secretariat ordered



a crackdown on such persons residing in Delhi. Ravi Kumar Singh, DCP (South East Delhi), had said that 916 people were verified in South East Delhi till December 13 and eight illegal immigrants had been detained, including six Bangladeshi nationals. Two of them - Abdul Ahad, 22, and Mohammad Azizul, 32, were arrested

on December 10 and 12, respectively, from Hazrat Nizamuddin for illegal stay in India, the officer said. The police had produced both

Ved Pal and Assistant Divisional Officer Udai Vir Singh, both Group A officers, facing allegations of negligence in issuing a fire safety certificate to the coaching centre despite knowing that it was illegally using its basement as a library, a note from the L-G office said.

The L-G has directed the suspension of the officers, categorising the action as an initial step toward ensuring accountability. The matter will now be



referred to the National Capital Civil Service Authority for further disciplinary measures against Ved Pal

TRAI asks telcos to offer tariff vouchers for calls, SMS

NEW DELHI. The Telecom Regulatory Authority of India (TRAI) has directed telecom service providers to offer separate special tariff vouchers (STVs) for voice calls and SMS services.

With this change, telcos such as Reliance Jio, Vodafone Idea, and Bharti Airtel are now required to offer tariff plans that include only voice and SMS services, not necessarily bundled with data.

The TRAI has introduced these amendments to the telecommunication tariff order (TTO) and the Telecom Consumers Protection Regulations (TCPR). This change will allow consumers to pay only for the services they use, offering greater flexibility in telecom spending. The move is beneficial for rural users and elderly, who may predominantly use voice and SMS services and may not require data services. Introduction of these vouchers aims to cater to users who prioritise voice communication, offering them a cost-effective solution without the need for data features. The TRAI said the change is beneficial for elderly people, especially in rural areas, who do not use data services due to limited understanding of technology. Families with broadband at home may also find it burdensome to pay for data services that they don't require.

Moreover, data collected from telcos indicate about 150 million users still rely on feature phones, highlighting a continuing demand for voice and SMS-only plans, as these users typically require basic telecomm services. The new regulations introduce an extension of the validity period for STVs and combo vouchers. The validity period has been raised from the previous 90 days to 365 days, giving users more flexibility in how they recharge their accounts. TRAI has done away with the colour coding of vouchers, which was earlier used for physical forms, in response to the growing prominence of online recharges.

Women now represent 20 per cent of HNI investors: Crypto exchange CoinDCX

BENGALURU. With increasing adoption of cryptocurrency, women are now representing 20 per cent of crypto exchange CoinDCX's HNI (high networth individual) customers. With 28.3 per cent, Delhi, Lucknow (19.16 per cent), and Hyderabad (16.5 per cent) are driving this trend, with ETH, BTC, MATIC, and DOGE, among their preferred tokens, says the crypto exchange in its Annual Report for 2024. The report highlights a significant shift in investor behaviour and how cryptocurrencies are widely being used in tier-2 cities as they accounted for 40 per cent of nationwide crypto activity. Delhi and Mumbai led with a combined 22 per cent.

With over half of investors now holding Bitcoin and Altcoins in their portfolios, the exchange points out that Indian crypto traders are maturing, becoming more strategic in their asset allocation, and embracing the transformative potential of digital assets.

From its all-time high of USD 1,07,000 last week, Bitcoin (BTC) has been fluctuating and on Monday it fell to about USD 96,056.

CoinDCX said that about 51.5 per cent of investors'



portfolios are now held in BTC, and Altcoins, indicating a strong shift toward long-term investment strategies. Altcoins lead with a 34.5 per cent allocation, driven by rising confidence in projects like DeFi, Layer 2 solutions, and decentralized applications. Interestingly, there has been a 253.33 per cent surge in SIP adoption.aThe crypto exchange also said that post-US election, which is from November 5 to December 10, investments in crypto elimbed to USD 1.2 billion in just 24 days with a climbed to USD 1.2 billion in just 34 days, with a daily average of USD 35.3 million. Between January 1 and November 5, total investments reached USD 2.94 billion, averaging USD 9.5 million daily.

NEW DELHI. People buy general insurance to cover for emergencies so that they do not have to make out-of-pocket hefty payments. They do not just put their money in, but trust while paying premiums. However, not all claims get approved. A recent report reveals that the claim-to-settlement ratio, which shows how many claims were honoured by insurers, in 2022-23 at 86%, which is down from the 87% in Fy22. The detailed report by the Insurance Brokers

from data presented by insurance companies reveals that claims repudiation ratio rose to 6% for general insurance, which includes coverage for motor, health, fire and marine cargo. This is the claim rejected by an insurance company as a proportion of the total claims made by its policy buyers.Public sector insurer New India Assurance has the lowest claims repudiation ratio of 0.2%.Other big private insurers with lower rates of

claims rejection are HDFC Ergo, Future Generali, Aditya Birla Health and Shriram.Insurance watchdog IRDAI makes it mandatory for insurance companies to put out settlements and rejection data on their websites. The IBAI has collated the data from insurers and put it in a report, which could help people make informed choices about a company's track record while buying insurance policies.In the Policyholder's



Handbook, the IBAI has classified the general insurers into four categories --Public Sector General Insurers, Large Private Sector General Insurers, Other Private Sector Insurers, and Standalone Health Insurers.In the health insurance category too, New India Assurance came on top among the public insurers with a claim-settlement ratio of 95%. Aditya Birla Health, with a claim settlement ratio of 95%, was the best among standalone health insurers.Iffco Tokio and Bajaj

private sector general insurers with the best claims-to-settlement ratio of 90% or more, according to the IBAI

What has to be remembered in the case of health insurance is that it is combined data for group (corporate) and individual policies.
