Dhaka/Agartala, Dec 03: Security personnel keep vigil amid heightened security at the Bangladesh Assistant High Commission after protests erupted in Tripura over alleged attacks on Hindus in Bangladesh Bangladesh on Tuesday summoned the Indian envoy to its Foreign Office while announcing the suspension of consular services at its mission in Agartala, a day after the premises were breached by protesters over the arrest of a Hindu monk in the neighbouring country. There was drama too at a court in Chattogram, where monk Chinmoy Krishna Das' bail plea was to be heard. But no lawyer appeared for him, and his supporters later claimed that his advocates are under threat. Tuesday's developments marked another low in ties between the two countries following the ouster of Sheikh Hasina as prime minister in August. New Delhi earlier called the breach at the Agartala mission "deeply regrettable". Tripura Police said seven people have been arrested and action taken against four policemen over the incident. ### 80 earthmovers to clean city drains

BENGALURU. Due to the Cyclone Fengal devastation in the neighbouring state Tamil Nadu and Union Territory Puducherry, and warning of an impact in Karnataka by India Meteorological Department, Bruhat Bengaluru Mahanagara Palike (BBMP) Chief Commissioner Tushar Girinath on Monday held a meeting with zonal commissioners and directed them to take precautionary measures.

Addressing the media, Girinath said that although the city may not receive heavy rainfall as per the predictions, instructions have been given to deploy 80 earthmovers at low lying areas prone to floods. The engineers have been asked to clear silt from the drain, and ensure the waste is cleared and does not clog the drain during rain.

The Commissioner also stated that, although the warning has been given to neighbouring states, BBMP has taken precautions. The engineers have been asked to be on alert from Sunday onwards even if it was a holiday. The Palike also put all 28 tree cutting teams on alert to ensure uprooted trees and branches are cleared.

The Chief Commissioner also informed that, due to Fengal impact, it has become difficult to close all the potholes in city and engineers have been instructed to use cold mix and when the rain stops, more asphalt should be

According to IMD, the city logged 14.5 mm rainfall from 8:30 am to 8:30 pm on Monday, and it predicted moderate to heavy rain and generally cloudy sky for the next 36 hours. The temperature may be 23 degrees Celsius max and 19 degrees Celsius minimum.

BBMP Chief Commissioner Tushar Girinath said 21,369 e-Khatas have been issued so far and 14,000 are still pending with Assistant Revenue Officers (AROs). By end of this week, majority of them will be cleared. Six lakh properties are in the draft e-Khata list and all owners will have to move to e-khata,

### SWM drivers and loaders launch hunger strike for regularisation

BENGALURU. Hundreds of drivers and loaders associated with Solid Waste Management (SWM) started hunger strike from Monday, demanding regularisation of service and Pourakarmika status.

Thyagaraj, President, Praja Hakkugala Vedike said these demands have been put forth before the palike several times, but the palike is yet to reciprocate. About 10,000 members engaged as drivers / loaders have to be recognised as Pourakarmikas as per IPD Salappa Commission Report. BJP leaders like former DyCM Dr CN Ashwath Narayan, opposition leader in Karnataka Legislative Council Chalavadi Narayanaswamy and former Safai Karmachari Commission Chairman Jagadish Hiremani visited and assured to prevail upon the state government to get justice to protesting members, he added.

Speaking to TNIE, Thyagaraj said, "Until and unless the government does not respond, the strike at Freedom Park will continue.

The protesting drivers and loaders said, that they are the one who are in the forefront to clear the city's waste and ensure the beautification, and it is the responsibility of the government and BBMP to treat them with respect, recognise and absorb them into palike.

Chalavadi Narayanaswamy, who visited the spot and spoke to the protesting members, said, when BJP was in power, 14,000 pourakarmikas were made permanent employees. Now drivers and loaders, who are also equally working, need to be regularised. "The government and BBMP can at least remove the contractors and absorb these sections under 'Direct Payment' segment," said Narayanaswamy.

### Madras HC grants conditional bail to four students in murder case

CHENNAL Madras High Court on Monday granted conditional bail to four students of Pachaiyappa's College who were arrested in a case relating to the murder of a student of the Presidency College.

Justice A D Jagadish Chandira issued the orders for enlarging N Chandru, Eswar, Yuvarai and Eswaran on bail with the condition of rendering service at the trauma ward by two each at the Rajiv Gandhi Government General Hospital (RGGGH) and the Kilpauk Medical College Hospital for a week from 9 am to 2 pm.

The Periyamet police arrested the four on October 4 on the charges of attempt to murder, after they had allegedly attacked Presidency College student Sundar, who succumbed later at RGGGH. Subsequently, the police altered the FIR to register a murder case against them.

During the previous hearing, the judge had expre-ssed concern over the recurring incidents of student groups attacking each other without being aware of their family conditions and their future. He suo motu impleaded the Higher Education Secretary and subsequently, the principals of the two colleges were impleaded in the case to find a lasting solution to the issue. The Students Federation of India (SFI) and Sattha Panchayat Iyakkam, an NGO, filed petitions as intervenors to submit their proposals for working out the solution. Adjourning the case to December 20, the judge directed the college principals to appear in court on the same date.

The CM, in his letter to the PM, said according to the initial assessment of these damages, Rs 2,475 crore is required for temporary restoration efforts. He also requested Modi to depute a central team at the earliest to undertake a comprehensive assessment of the damages. "Based on their findings, I seek your kind consideration for further financial assistance to address the unprecedented adverse impact on infrastructure, agriculture and livelihoods in the affected districts," the CM said and expressed confidence that the centre will support Tamil Nadu at this crucial moment to overcome this crisis and quickly restore normalcy.

### Kerala govt data busts vaccine death myth; no rise in mortality post-Covid

While there have been no substantial studies on premature deaths in the state, the available mortality data confirms health experts' claims that the vaccines are safe.

THIRUVANANTHAPURAM. The death of youngsters, especially when it Debunking the popular notion that Covid-19 vaccinations have led to an increase in deaths among young adults, state government data shows no significant change in the death rate in the 35-44 age group between 2019 and 2023.

Mortality rates in this group have remained relatively consistent, at 3.30% in 2019 and at 3.13% and 3.23% in the postvaccination years of 2022 and 2023 respectively.Reports of heart attack in young people, often attributed to the side effects of the vaccine, appear to be unfounded. The data does not support any correlation between vaccinations and death rate in this age group.

While there have been no substantial studies Dr B Ekbal, public health activist and head on premature deaths in the state, the available mortality data confirms health experts' claims that the vaccines are safe. In Kerala, 1,29,45,396 individuals aged 18-44 have received the first dose of the Covid-19 vaccine, of which 1,08,60,254 went on to complete the second dose.

"The death rate is likely to remain steady or increase as there are several reasons for people in the age group to die. They are at risk of death due to non-communicable and infectious diseases. Experts agree that premature deaths should be thoroughly investigated to determine their true causes. "The number of young patients visiting hospitals for heart-related issues has not dramatically increased.

### R Ashoka warns against eviction of farmers over Waqf Board notices, accuses Congress of appeasement

MYSURU. Leader of the Opposition in the Legislative Assembly, R Ashoka, on Monday warned the state government against evicting farmers and owners of various institutions from their lands in light of notices issued to them by the Waqf Board, claiming rights over their properties.

He was speaking after visiting Muneshwara Colony, where notices have been issued to 101 families, claiming that their lands belonged to the board. A notice has also been issued by the board, claiming rights over a Basava mandir in the colony, he said. Ashoka said the BJP would not be responsible if the state witnessed a law and order situation over the Waqf issue. Thousands of farmers, who have been residing on and tilling their lands for decades, have been issued notices. Accusing the Congress



government of indulging in appeasement politics to garner the votes of the minority community, he blamed former PMs and Congress leaders Jawaharlal Nehru and Manmohan Singh for the issue, alleging

that they granted extraordinary powers to the board. He said the seer of Basavanjali Mutt

and residents of Muneshwara Colony had expressed fears of eviction from their lands. Stating that the previous BJP government had released Rs 60 lakh for the mutt, Ashoka said the residents had now been forced to appear before the Waqf Committee in Bengaluru.

KOCHI. Kerala High Court has directed the state government to remit the amounts received as application fees for the conversion of paddy land collected under the Kerala Conservation of Paddy Land and Wetland Act, 2008 to the Agricultural Promotion Funds

It should be done by the State Audit Department, and the result should be published on the website of the department concerned."The drop in paddy cultivation has decreased employment opportunities for farm workers and rural women, increased

### HC orders reopening of 3 **HSVP** offices, sets May deadline for compliance

Gurgaon. The Punjab and Haryana High Court on Monday directed reopening of three HSVP offices in the city that it had ordered sealed on Friday after the authority failed to comply with its orders in a land compensation case. HSVP had failed to pay compensation to owners whose lands were taken over by the authority without carrying out the acquisition process. The offices of land acquisition collector, as well as the estate officer I and estate officer II, HSVP, were sealed. The HC has now extended the time till May 2025 for compliance with its order. The double bench of the Punjab and Haryana High Court, comprising Justices Sureshwar Thakur and Sudeepti Sharma, stayed the order dated Nov 29 after considering the submission by the authority seeking more time to pay the compensation. Around one acre of land in Narsinghpur Kasan village was acquired in 2010 by HSVP for constructing roads across sectors 81 to 95. While taking possession of this land, HSVP had also taken possession of another 0.6 acre of land owned by the petitioners, without following the proper acquisition process. The possession proceedings were carried out in the year 2011.

Though the landowners were awarded compensation for the 1-acre land, none was provided for the 0.6 acre, despite the villagers repeatedly demanding the same from HSVP. They approached the HC in 2017, and in April 2024, the court directed HSVP to provide the compensation to the landowner in four months from the date of the order. HSVP failed to comply with the order, and a contempt petition was filed in Sep 2024, following which the authority sought more time for acquisition and release of compensation from the court.

### Sex test centre busted, two arrested; portable USG machine, meds seized

Ghaziabad. Two people were arrested for conducting illegal foetal sex determination at their ultrasound centre in Lal Kuan. Police recovered an ultrasound machine, medicines, an MTP (medical termination of pregnancy) equipment box, and a car on Monday after the health department raided the illegal sex determination centre. This is the first such portable ultrasound device, resembling a laptop, that has been seized by officials in the city. Two sealed envelopes containing Rs 22,000 and a pen drive, a bill book, 10 blank prescription slips, and a medical certificate from the hospital, among other objects, were also recovered."The two persons who were arrested are Mamta, the broker who used to bring the customers, and Nazim, a class 10th pass boy who used to conduct the ultrasound process. They were held from Shiva Hospital, Bharat Dharam Kanta in Lal Kuan," said Dr Anurag Sanjog, deputy CMO of Ghaziabad.

According to a senior police official, the two accused used to bring women for tests and charged them Rs 25,000 to 40,000."In case it was a girl, they used to perform her abortion with the MTP kit," said the official."The two were arrested under BNS sections 61(2) (criminal conspiracy) and 318(4) (cheating), as well as sections 3, 4, and 5 of the Medical Termination of Pregnancy Act, 1971, and Pre-Conception and Pre-Natal Diagnostic Techniques Act, 1994," said Sanjog.

Just a day before this incident, three men were arrested after UP and Haryana health departments conducted a joint operation with a pregnant woman as a decoy. The teams found the illegal foetal sex tests were being done through a portable ultrasound machine resembling a laptop, set up in one of the rooms of the

## Pilot project for 24x7 water supply to be launched soon in Delhi's Vinay Marg area

NEW DELHI. The New Delhi Municipal Council has worked out a plan for launching its pilot project of 24x7 water supply in the Vinay Marg area and will begin work on it by March next year. While the consultant for the project has submitted its report in this regard, the civic body is finalising the finer points of the project.The current pipes will be replaced with those of varying diameters and additional pipes will be laid. Pumps, accessories and panels for optimal water flow will be installed while leakages will be fixed to minimise water loss. Two new underground storage units will be created near Sarojini Nagar Navyug School and Talkatora cricket ground to enhance water supply.NDMC vicechairman Kuljeet Chahal said that depending on the results of the pilot project, 24x7 water supply will be extended to other areas. "We have a network of 470km of water pipes. The pilot phase will cover govt accommodations on Vinay Marg, Sewa Basti, the market and some offices,' revealed Chahal. "The original plan was prepared in 2023, but we recently reworked it to add more features and new



technologies to tap leakages." The initial project cost of Rs 1.8 crore has been revised to Rs 3 crore.

Chahal added, "The consultant made a comprehensive presentation to NDMC, which led to further refinements and clarification of cost-benefit analyses," said Chahal further. In Phase I of

augmenting the water supply in Lutyens' Delhi, NDMC will provide individual piped water connections in 32 slum clusters, where around 46,930 people live. "This project is undertaken on the basis of the Prime Minister's Har Ghar Jal initiative under the Jal Jeevan Mission and will benefit approximately 9,386

households in 32 slum clusters. The total estimated cost for this project is Rs 12.7 crore, with an average cost of Rs 13,562 per household. NDMC has requested funds for this from the AMRUT ministry," said Chahal.

For the successful completion of this project, NDMC has divided all JJ clusters into three categories - north of Rajpath in the first, embassies and Sarojini Nagar in the second, and Lodhi Colony, Bharti Nagar, Khan Market, etc., in the third part. "This division was essential for efficient management and timely execution of the project," said Chahal. "Planning for the first two categories is in progress, with work expected to commence on or before March 2025. For the third category, the preparation of the tendering process is under way and work in these colonies is expected to also start soon."

In addition to work under the 24x7 water supply project, NDMC will also upgrade water pipelines along Subramanium Bharti Marg, in Pandara Park and other key locations to ensure seamless water supply throughout the area and to prevent any waste of water due to leakage in the

Investigators revealed that fraudsters were employing increasingly sophisticated tactics to evade detection and launder stolen funds. One common strategy involves dispersing the stolen money across numerous digital wallets, making it difficult for law enforcement to trace the original source of the funds. This rapid dispersal prevents the cops from focusing on the primary account from which the money was originally sent. To further complicate matters, the criminals often withdraw the funds through multiple ATMs, further obscuring the money trail. Additionally, they exploit the bank accounts of vulnerable individuals, such as those living in poverty or with limited financial literacy.By offering small sums of money, they acquire access to these accounts and use them as conduits for transferring the stolen funds."Even if the investigators follow the money trail and reach the account holder, they will never get to know who the real mastermind of the scam is. The person who allowed the use of his or her bank account get arrested," one investigator said. Another officer said, "The fraudsters also transfer funds to their overseas associates by converting the stolen money into cryptocurrency or purchasing gift cards." This method allows them to move funds across borders and circumvent traditional banking systems.A senior officer said that during various investigations, police found that the scammers adopt different modus operandi to obtain bank accounts."They approach villagers who live in remote areas and are illiterate. Citing the names of various benefit schemes, they ask such villagers to open bank accounts, promising them financial benefits. As soon as the accounts are opened, the scammers obtain the account details by offering them small amounts of money. These details are then sold to other scammers, both domestic and international," the officer revealed. The city has witnessed a surge in cybercrime cases, with a wide range of illicit activities being reported, according to police data. ### **US PRESIDENT BIDEN Biden Admin Approves Sale** Of USD 1.17 Billion Worth **Helicopter Equipment To** India

Washington. The Biden Administration on Monday notified the Congress of its decision to approve the sale of MH-60R Multi-Mission Helicopter Equipment and related ones at an estimated cost of USD1.17 billion. The proposed sale will improve India's capability to deter current and future threats by upgrading its anti-submarine warfare capabilities, the Defense Security Cooperation Agency said in a notification to the Congress. The Biden administration's approval of sale of major defense equipment to India comes weeks ahead of its completion of its four-year term. Presidentelect Donald Trump would be sworn in as 47th president of the United States of America on January 20, 2025.

According to the notification, India has requested to buy 30 Multifunctional Information Distribution System-Joint Tactical Radio Systems (MIDS-JTRS). It also included advanced data transfer systems; external fuel tanks; AN/AAS 44C(V) forward looking infrared (FLIR) systems; an operator machine interface assistant; spare containers; facilities study, design, construction and support; support and test equipment; munitions; and integration and test support.

The principal contractor will be Lockheed Martin Rotary and Mission Systems.

Implementation of this sale will require travel of up to 20 US Government or up to 25 contractor representatives to India on a temporary basis for program technical support and management oversight, it said.

### Elon Musk's \$56 billion pay package for Tesla blocked again by Delaware judge

World. Tesla CEO Elon Musk's compensation package of \$56 billion has been blocked again by a Delaware judge despite the shareholders of the EV company voting to reinstate the pay package in June. Musk's pay package was earlier rescinded in January

by the same judge, Chancellor Kathaleen McCormick of the Court of Chancery, who called it excessive. It also surprised the investors and now Musk's future at the world's most valued carmaker remains uncertain. The \$56 billion compensation for Musk has now become \$101 billion based on Tesla's closing share price on Monday, and it is made up of 303 million Tesla stock options, reported CNN.In January, Judge McCormick ruled in favour of one of the shareholders in the suit who had argued that "Musk and the Tesla board bore the burden of proving that the compensation plan was fair, and they failed to meet their burden." Tesla opposed the verdict by the judge and posted on X, "A Delaware judge just overruled a supermajority of shareholders who own Tesla and who voted twice to pay Elon Musk what he's worth. The court's decision is wrong, and we're going to appeal. This ruling, if not overturned, means that judges and plaintiffs' lawyers run Delaware companies rather than their rightful owners – the shareholders."Tesla and Musk can appeal against the verdict in the Delaware Supreme Court as and when the final order by the judge comes out. However, the appeal could take a year to play out, reported Reuters. Tesla in its court filings argued that the judge should acknowledge the voting held in June by the shareholders of the company, who voted in favour of the pay package for Musk.Judge McCormick said that Tesla's board was not entitled to hit a "reset" for Musk's compensation. "Were the court to condone the practice of allowing defeated parties to create new facts for the purpose of revising judgments, lawsuits would become interminable," she said.

### Hunter Biden pardon sparks criticism, raising questions about Biden's legacy

World. President Joe Biden's decision to pardon his son, Hunter Biden, has drawn widespread criticism and raised questions about his legacy. The pardon comes weeks before Hunter's sentencing for tax evasion and firearms-related charges and reverses Biden's earlier pledge not to intervene in the case.

The sweeping pardon not only covers the charges Hunter faced but also precludes prosecution for any federal offenses committed between 2014 and 2024. Biden justified the move by stating the prosecution was politically motivated and a miscarriage of justice. Critics, including members of Biden's own



party, expressed concerns. Colorado Governor Jared Polis called the decision a "bad precedent" that tarnishes Biden's reputation. Democratic Representative Greg Stanton highlighted that Hunter was convicted by a jury, countering claims of political interference in the case. White House press secretary Karine Jean-Pierre reiterated Biden's stance, stating the president believes politics infected the process. Meanwhile, Republicans, including President-elect Donald Trump, have condemned the pardon, with Trump calling it a "miscarriage of

This is not the first time that Trump has addressed the conflict in Gaza and the fate of the remaining hostages. He has told Netanyahu that he wants the war in the enclave to end before he returns to the White House. And at the Republican National Convention in July, he said that he wanted the hostages returned and that captors "will be paying a very big price".

His latest warning came after Hamas released a propaganda video showing the American-Israeli hostage Edan Alexander, 20, pleading with Trump to secure his release.

**World.** For the first time since the ceasefire took place between Israel and Hezbollah, the militant group has fired two projectiles toward Israelioccupied territory amid repeated strikes by Israel, bringing the ceasefire agreement under shadows.

The Lebanese authorities reported that at least 11 people died and three were left injured from Israeli strikes as Tel Aviv's military said it struck dozens of Hezbollah targets throughout Lebanon.

Beirut residents even told Reuters that they heard drones flying overhead at low altitudes in the eveningBoth sides have accused each other of ceasefire violations while the



Hezbollah projectiles targeted Israeli military's positions in Shebaa Farms area and the Iran-backed militant group termed it as "defensive warning strike."The Israel Defense Forces (IDF) on Monday said that "Strikes were in response to several acts by Hezbollah in Lebanon that posed a threat to Israeli civilians, in violation of the understandings between Israel and Lebanon."Israeli Prime Minister Benjamin Netanyahu also termed Hezbollah's strike "a serious violation of the ceasefire" and vowed to retaliate against it in a statement. But CNN reported that the US and French government have warned Israel against the violations of the ceasefire deal terms. According to a statement from a source in the United Nations peacekeeping force in Lebanon, UNIFIL, Israel's violation of the ceasefire agreement with Lebanon goes up to "approximately 100" times, reported CNN.Israeli Foreign Minister Gideon Sa'ar posted on X, "The presence of Hezbollah operatives south of (Lebanon's) Litani is a fundamental violation of the agreement and they must move north."

## Stampede at football match in Guinea kills at least 56

CONAKRY. Chaos erupted at a soccer game in Guinea after fans protested a referee's call and thousands of panicked spectators tried to flee the stadium, leaving at least 56 people dead in the West African nation, officials and witnesses said Monday.

Amid the confusion, security forces used tear gas, local news website Media Guinea reported. Many of the dead were crushed as they tried to escape through the stadium gates, a journalist covering the game for a local sports website told The Associated Press."The gates, that's where the stampede happened," said Cissé Lancine, who got away by climbing over one of the stadium walls. "I was saved because I did not rush towards the exit."The world's latest sports crowd disaster unfurled on Sunday in the second-largest city in a military-run nation where information is sparse and government-controlled at the best of times. It was not immediately clear how much the death toll could grow. Lancine said between 20,000 and 30,000 people were present at the Third of April stadium to watch the local Labe and Nzerekore teams compete in the final of the first national tournament honoring military leader Mamadi Doumbouya.



Checkpoints were set up Monday throughout Nzerekore, a city of about 200,000 that was at a standstill as soldiers guarded the hospital where victims were being treated. Most shops were closed.

Video, apparently from the scene, showed shouting fans protesting the refereeing. People ran as they tried to escape the

VIJAYAWADA. In a move to address growing traffic congestion, Vijayawada City Police launched a joint public-police initiative, 'Traffic Ambassadors,' on Monday. The programme aims to streamline vehicular movement and improve road safety with active community participation.

NTR District Commissioner of Police (CP) Rajasekhar Babu inaugurated the initiative, commending the traffic wing for engaging citizens from diverse backgrounds. He lauded the 380 volunteers already enrolled, urging them to stay vigilant, particularly during peak hours.

'We didn't expect such a large turnout of volunteers. Achieving congestion-free traffic is only possible with public involvement," said Babu, encouraging more residents to join the cause. He emphasised that real-time alerts from traffic ambassadors could help manage emergencies efficiently. Traffic ambassadors will report issues via a dedicated WhatsApp group, ensuring quick responses from local police teams. The CP highlighted the importance of integrating advanced technologies into traffic management. He noted a significant improvement since introducing the AI-based system ASTraM. In November, the average congestion decreased to 72 km, a sharp drop from 112 km in October. "With drones and artificial intelligence, we're tackling traffic issues head-on," Babu stated. The system uses Google Maps data, analysed in a centralised command centre, to issue on-the-ground instructions to traffic personnel. This integration enhances response times and ensures smooth traffic flow across the city. DCP Gowthami Sali reinforced the positive impact of technology-driven enforcement. She reported a marked improvement in traffic conditions over the past two months. "ASTraM's automated detection, using Google Maps, alerts officers to congestion hotspots. For instance, Mahanadu Junction saw congestion reduced from 80 kilometers to just 40," she explained.

Fifteen huts were destroyed, 10 partially damaged, and livestock losses included four cows and 16 calves. The administration has sought interim relief of Rs 100 crore from the centre.



Visakhapatnam metro rail. According to Secretary K. Kanna Babu, metro rail works under phase-I will be taken up at an estimated cost of Rs 11,498 crore (excluding land costs). This will include three corridors totaling 46.23 km. Corridor-1 will connect Steel Plant Junction and Kommadi (34.40 km), Corridor-2 will connect Gurudwara and Old Post Office (5.08 km), and Corridor-3 will connect Tadichetlapalem to Chinna

Waltair (6.75 km).

As part of phase-II, a fourth corridor will connect Kommadi to Bhogapuram (30.67 km). The total cost of the project, spanning 76.90 km, has been pegged at Rs 14,309 crore. The project will follow a Viability Gap Funding (VGF) Public-Private Partnership (PPP) model, with 40% funding from the Central

government and 60% from a private developer.

Phase-I of the Vijayawada Metro Rail Project for submission to the Centre. As



part of phase-I, Corridors 1A and 1B, spanning 38.40 km, will be developed at an estimated cost of Rs 11,009 crore, with Rs 1,152 crore allocated for land acquisition by the State government. Corridor 1A will cover Gannavaram to PNBS, while Corridor 1B will connect PNBS to Penamaluru. ## Imran's street politics hardens battlelines in Pak

PAKISTAN witnessed another socio-political crisis as a protest by former Prime Minister Imran Khan's supporters, who came out in thousands and marched towards Islamabad's D-Chowk, turned violent last week. The protesters demanded the release of the Pakistan Tehreek-e-Insaf (PTI) leader and other party functionaries. Rallies, sit-ins and protests have been a signature move for the cricketer-turned-politician, who is incarcerated in Rawalpindi's Adiala Jail and is embroiled in over 150 cases. Imran had issued a 'final' call to his supporters for a protest on November 24; this time, the faces behind the protests were Bushra Bibi, Imran's wife, who, till now, had abstained from public appearance, and Ali Amin Gandapur, Khyber Pakhtunkhwa Chief Minister and a close aide of Imran. The protesters faced a severe crackdown by the security forces. There have been conflicting reports on the number of people dead and arrested as a result, but the fact remains that it was the use of brute force that resulted in the protesters' retreat.

Imran enjoys immense popularity and support within Pakistan and has demonstrated great resilience by not opting to go into exile, which has been a customary conduit for former political (and military) leaders in Pakistan. Imran's mass appeal has been driven by his unwavering claim and position to stand for Pakistan against the corrupt dynastic politics and his blatant challenge to the all-powerful Pakistan military, which has been held responsible for most of the economic and political woes of Pakistan.

This is ironical since Imran's tenure as Prime Minister from August 2018 to April 2022 was marked by glaring misjudgments, witch-hunting of opponents, lack of governance, faulty decisions/projections, economic downfall and misconstrued foreign policy choices. Imran was the military's favourite at one point and its choice for the 2018 General Election, when he enjoyed the full patronage of the military to win the elections and trounce Nawaz Sharif. In 2018, Imran was projected as a clean and corruptionfree leader, driven by a welfare agenda, and one who would alter the course of Pakistan's growth and its image on the global stage. Eventually, his strains with the deep state resulted in his scandalous exit from the Prime Minister's office in 2022. After his exit, he has kept the momentum of his support base going, even when he was not allowed to contest the 2024 elections and his party was denied the election symbol. His support base has expanded from the urban middle class to all levels of society, where the masses see him as fighting for Pakistan, even though his track record demonstrates a complete inability to manage Pakistan's complex political, economic and security challenges.

The current crisis is primarily a fight between Imran and the Army chief, Gen Asim Munir. They have a well-known history of hostility. The controversial and much-debated 2024 elections brought the Sharifs in power and they currently enjoy the trust and support of the military establishment. The weak civilian regime in Pakistan, which lacks credibility, has no intention of asserting itself against the military's writ and will prioritise its own survival in power. Critical constitutional changes have been made with the passing of the recent 26th Amendment Act, with the intention to manage the functioning of the judicial system and ensure Imran's political solation. Gen Munir, the most powerful man in the country, has got an extension and he will continue to serve till 2027, if not beyond.

he protests have resulted in the resignations of the top brass of the PTI and the faultlines within the party are expected to deepen. Frustrations within the party will grow, given the arrests of PTI workers. Imran might seem to have limited options left after his call for the November 24 march. But given his obsession with street politics, he is unlikely to give up soon and his next call for a protest might not be far away.

However, critics view this as a 'patchwork' approach, saying policing by guardians is more effective than government-imposed rules as they are better positioned to manage their children's online presence. Further, the law fails to tackle the fundamental issue of ensuring that social media companies properly remove harmful content. Also, concerns about enforcement arise as the law leaves age verification methods open-ended, potentially relying on government documents or technologies like facial scanning or behavioural tracking, which raise privacy issues. The Covid-19 pandemic led to an increased screen time among children, leading to behavioural and health issues and delinquency, as highlighted by various studies. UNESCO's 2023 report calls for a global school ban on smartphones, citing research that shows

their mere presence can disrupt learning and that children take up to 20 minutes to regain focus after engaging with non-academic content. The US Surgeon General's 2023 advisory warns that social media can harm adolescent brain development, affecting emotional regulation and impulse control. It proposes warning labels on platforms, similar to those for cigarettes. The algorithm-driven content of social media fosters a form of digital addiction. As in drug problems, effective regulation should focus on supply-side measures as controlling individual behaviour (demand-side) is challenging.

In 2022, India reported 32 per cent increase in cybercrime against children with 1,823 cases, including cyber pornography (1,171 cases) and cyberstalking (158). Offline crimes against children also saw a worrying increase, with over 1,62,000 cases reported, up by nearly nine per cent from the previous year. This highlights a broader, concerning trend of rising crime against children that is not solely tied to the Internet. The overall surge in both online and offline crimes calls for a comprehensive approach to child protection across all environments. Similarly, in the UK, a rise in

cybercrime among children aged 10-16 shows that some children, often unknowingly, are engaging in illegal activities, underscoring the need for both preventive and educational measures.

for children or impose stricter regulations on platforms. An alternative to a ban on platforms involves implementing robust age verification for content moderation, which could be enforced at specific barriers to restrict access to harmful content. Restricting children's Internet access entirely may seem like a protective measure, but it is impractical in today's digital age. Instead, the focus should be on promoting safe online practices, digital literacy and tools that foster responsible Internet use that would let children access general features while saving them from harmful content, offering a more targeted and feasible solution.

A strong parallel exists in the case of a rise in cybercrime across all sectors, involving adults and businesses. Banning specific websites is a short-term fix that overlooks the broader issues, such as digital literacy, cybersecurity awareness and effective online monitoring. A comprehensive solution is necessary to target its root causes, not just limit access to the Internet. Implementing such a ban for those under 16 in India will face major challenges due to the country's large population and technological diversity, making enforcement

difficult. Teenagers could bypass such bans using VPNs, fake credentials, proxy websites or lesser-known platforms.n the Indian context, the 2020 report from the Singapore-based DQ Institute serves as a crucial resource for enhancing child online

safety, with its survey covering 63 per cent of the global population. This think tank has established standards for digital intelligence to ensure safety, empowerment and wellbeing. Its Child Online Safety Index (COSI) evaluates digital safety across six key areas: cyber risk, disciplined digital use, digital competency, guidance and education, social infrastructure and connectivity.ndia ranks highly in several categories, securing the second place in tackling cyber risk, third in disciplined digital use, first in digital competency and second in guidance and education. India also tops the rankings for its children's ability to cope with cyberbullying, highlighting their resilience in handling online threats. While India

lags in connectivity, its strong performance in managing cyber risks and online safety education provides a window of opportunity to enhance its COSI as connectivity improves, without resorting to bans. India's children excel in online safety education, scoring 68/100 — 30 per cent higher than the global average of 52/100.

Interestingly, lower-income countries tend to score better in online safety education (55/100 on average) than high-income nations (51/100 on average), emphasising the crucial role of education in helping children navigate online dangers. However, the data is biased towards public schools, so India must focus on improving online safety education in government schools and rural areas.

Despite efforts to limit children's screen time, modern life offers fewer opportunities for real-world experiences. Playgrounds are rare, academic pressures high and social structures more impersonal due to nuclear families. This trend leaves children valuing their devices for connection. Limiting technology alone won't restore the outdoor play and socialisation earlier generations enjoyed, unless broader societal issues are addressed.

The manufacturing sector, traditionally a growth driver, is at the heart of this slowdown, grappling with declining output and subdued demand. The decline in Gross Value Added (GVA) in manufacturing to 2.2% from 14.3% a year ago highlights the sector's vulnerability to inflation and weak consumer spending. While the Chief Economic Adviser has downplayed concerns, brushing off this dip as a "one-off", there is need to remain cautious. Private final consumption and gross fixed capital formation together shaved off 1.5 percentage points from the overall growth, signalling waning confidence in household and



business spending.On the brighter side, the services sector expanded by 7.1% and the agriculture sector grew

by 3.5%, driven by improved rural demand. However, these gains were not sufficient to offset the drag from manufacturing and exports, which slowed to 2.8%, reflecting global uncertainties and weaker petroleum exports.

The government's underwhelming capital expenditure — just 37% of the budgeted target for the first half — adds another layer of concern. Public spending is critical to kickstarting private investments, particularly when high borrowing costs stifle corporate growth. As India faces the dual challenge of sustaining growth while managing inflation, a robust fiscal push is imperative. Without increased public investment and strategic support for manufacturing, the risk of falling below the projected 6.5% annual GDP growth looms large. The upcoming fiscal policy decisions will thus be crucial in steering the economy back on a stable growth trajectory.

### **Empower military with strategic heft**

A significant development that has gone unnoticed and uncommented upon is the involvement of military commanders in trying to ostensibly resolve the 54-month-old standoff at the Line of Actual Control (LAC) that forms the de facto border between India and...

Beginning June 6, 2020, Indian and Chinese military commanders held talks in the Chushul-Moldo region following the violent confrontation on May 5, 2020, between Indian and Chinese troops in Pangong Tso. The second round of talks between Lt Gen Harinder Singh and Maj Gen Liu Lin, Commander of the South Xinjiang Military District, were held on June 22, 2020, in the wake of the unfortunate Galwan conflagration. Since then, 19 more rounds of talks have been held till February 19, 2024. The 22nd round has still not been scheduled.

This was perhaps after a long time that the military was so overtly involved as a concurrent track in efforts to resolve the question of Chinese transgressions into Indian territory or our perception of the LAC. Of course, there have been flag meetings on India's borders with the frontier forces or militaries of the neighbouring countries. Over the past 54 months, the Ministry of External Affairs has been issuing readouts on a regular basis after each round of talks.

Is this a good or a bad thing? If one looks towards the past for guidance or even at the practice that is followed in other countries, one would find that the military has been intrinsically embedded in politico-military strategic diplomacy. The military representatives of India and Pakistan met in Karachi from July 18 to 27, 1949, under the auspices of the truce sub-committee of the United Nations Commission for the establishment of the ceasefire

line in Jammu and Kashmir. The Indian delegation consisted of Lt Gen SM Shrinagesh, Maj Gen KS Thimayya and Brig SHFJ Manekshaw, while the Pakistani side was represented by Maj Gen WJ Cawthorn, Maj Gen Nazir Ahmad and Brig M Sher Khan. Bureaucrats and Foreign Office functionaries were only observers. HM Patel and V Sahay C from the Indian side and M Ayub and AA Khan from Pakistan made up the quorum of the civilian component.On December 11, 1972, senior military commanders of India and Pakistan met at Suchetgarh to sign and exchange maps delineating the 800-km Line of Control in J&K, extending from the Chhamb sector to the Partapur sector, in accordance with Paragraph 4 (II) of the Simla Agreement dated July 2, 1972. This agreement was a sequel to the understanding reached between the Army Chiefs of India and Pakistan at their second meeting in Lahore on December 7, 1972, where Pakistan conceded to India's claim that Thako Chak formed a part of the International Border and that it should withdraw its troops from there. The maps were exchanged between Lt Gen PS Bhagat on behalf of India and Lt Gen Abdul Hamid Khan representing Pakistan.It is noteworthy that there was a summit-level meeting between Prime Ministers Indira Gandhi and Zulfikar Ali Bhutto, followed by a meeting between then Chief of the Army Staff Gen Manekshaw and his Pakistani counterpart Gen Tikka Khan before the operational-level exchange of maps between Lt Generals Bhagat and Hamid Khan.

After that, the role of the military in the politicostrategic-diplomatic arena was either recessed or took a back seat till the time it briefly seemed to have



in his book, How India Sees the World: Kautilya to the 21st Century: "When the CCS meeting was held on the eve of the defence secretary-level talks, [Mr] Narayanan launched into a bitter offensive against the proposal, saying that Pakistan could not be trusted, that there would be political and public opposition to any such initiative and that India's military position in the northern sector vis-à-vis both Pakistan and China would be compromised. Unlike in India, the military is embedded in the politico-military hierarchy of democracies around the world. Though under very strict civilian control, the six US theatre commanders report directly to the American President through the Secretary of Defence. Though the Chairman of the Joint Chief of Staff in the US is the Principal Military Adviser to the President, he has no executive authority to command combatant units. This enmeshes various streams

of the military into the political decision-making process on critical questions of national security.In China, the theatre commanders report directly to the Central Military Commission that is headed by the Chinese President and the General Secretary of the Chinese Communist Party, thus institutionalising their role in the strategic decision-making process. Similarly, in the Russian system, the Chief of the General Staff does not exercise direct operational control over Russian forces; the superintendence is vested in the President in terms of Articles 4 and 13 of the Federal Law on Defence.It is, therefore, imperative that beyond the CCS (Cabinet Committee on Security) paradigm, the role of the military in the national security decision-making framework is also formalised, given that India has a Chief of Defence Staff and is moving towards theatre commands, though the only functional and integrated theatre command as yet is the Andaman and Nicobar Command.

## Akali Dal's Sukhbir Badal, on wheelchair, serves punishment at Golden Temple

≥On August 30, Akal Takht Jathedar, Giani Raghbir Singh, along with four other high priests, had declared Sukhbir Badal a 'tankhaiya' (guilty of religious misconduct).

New Delhi. Sukhbir Singh Badal, who resigned as president of the Shiromani Akali Dal (SAD) last month, arrived at the Golden Temple in Amritsar in a wheelchair to serve a religious punishment after the Akal Takht, the supreme temporal authority of the Sikhs, found him guilty of taking "wrong political decisions" when his party was in power in Punjab from 2007 to 2017.

The former Deputy Chief Minister of Punjab was also wearing a plaque around his neck acknowledging his "misdeeds" and holding a spear. On August 30, Akal Takht Jathedar, Giani Raghbir Singh, along with four other high priests, had declared Sukhbir Badal a 'tankhaiya' (guilty of religious misconduct).

And on Monday, the Sikh authority directed the former Deputy Chief Minister and other senior SAD leaders to serve the penance.

As part of the punishment, the SAD leaders have been directed to clean washrooms, wash utensils, and undertake other religious duties to atone for their actions, which included



granting a pardon to controversial Dera Sacha Sauda chief Gurmeet Ram Rahim Singh in 2015. A video is also doing the rounds on social media of SAD leader Bikram Singh Majithia washing utensils as part of his penance.

The Jathedar directed Akali leaders Sucha Singh Langah, Hira Singh Gabria, Balwinder Singh Bhundar, Daljit Singh Cheema and Gulzar Singh Ranike to clean washrooms from noon to 1 pm today, and then clean utensils at the community kitchen after taking a bath. They will also listen to 'kirtan' for one hour.

Jagir Kaur, Prem Singh Chandumajra, Surjit Singh Rakhra, Mahesh Inder Singh Grewal, Charanjit Singh Atwal and Adesh Partap Singh Kairon, were also told to clean washrooms at the Golden Temple for an hour. Citing the same controversies during the Akali regime, the Akal Takht has also withdrawn the prestigious title of 'Fakhre-e-Qaum' (Pride of the Community) conferred on former Chief Minister and Sukhbir Badal's Parkash

Singh Badal, who died in April 2023. The punishments came after days-long proceedings by Akal Takht in which Sukhbir Badal admitted to playing a role in the controversial pardon granted to Gurmeet Ram Rahim, a decision that sparked widespread criticism within the Sikh community. In view of the Sikh authority's religious interests, the SAD Working Committee had unanimously decided not to contest recent by-elections to four Assembly seats in Punjab.

New Delhi. The Supreme Court Advocate-on-Record Association (SCAORA) has written to Chief Justice of India (CJI) Sanjiv Khanna, seeking the removal of the recently installed glass partitions in the corridors of the Supreme Court. The association has also reiterated its request for relocating the National Judicial Museum and Archive (NJMA) to a lower-security zone within the court premises.

In its letter, SCAORA expressed concerns over the two changes introduced during former Chief Justice DY Chandrachud's tenure, asserting that they may not fully align with the historical ethos, functional needs, and legacy of the Court.

The association emphasised that the glass partitions, while part of an effort to modernise and provide centralised air-conditioning, were implemented without consulting stakeholders or representatives of the Bar. "The corridors, as they once were, embodied the grandeur and timelessness of the Court's legacy. Reinstating the older, open design would not only preserve the historic character of the building but also foster a sense of openness and accessibility," the letter stated.

SCAORA also highlighted safety concerns regarding the glass panels, which have reportedly sustained damage and developed cracks, posing a potential hazard to lawyers and litigants. It urged the Chief Justice to



prioritise creating a safe environment for all individuals within the Supreme Court's walls. The association further called for the relocation of the National Judicial Museum and Archive, arguing that its current location in a high-security area within the main premises violates established security practices.

According to SCAORA, the museum occupies valuable space that could be better utilised for the welfare of the Bar and the broader legal community. The letter underlined that allowing visitor access to a high-security zone contradicts the Court's long-standing practice of strictly segregating security areas and controlling

### Kashmir braces for La Nina: Heavy snowfall and harsh winter ahead

New Delhi. Kashmir is preparing for a particularly harsh winter this year, with weather experts predicting frequent spells of heavy snowfall and sub-zero temperatures, largely influenced by the La Nina climate phenomenon. La Nina, which occurs when ocean surface temperatures in the central equatorial Pacific cool significantly, disrupts atmospheric circulation patterns, often leading to extreme weather conditions across the world. Dr. Mukhtar Ahmed, Director of the India Meteorological Department (IMD) for Jammu and Kashmir, confirmed that the La Nina effect is set to intensify as the winter progresses.

Speaking to India Today, he explained, "La Nina has previously brought significant snowfall to Kashmir. This year, it is intensifying, and we expect frequent snowfall spells and colder temperatures, much like the traditional Kashmir winter." This prediction has led to expectations of above-normal precipitation in the region, along with colder-than-usual temperatures for Kashmir, Jammu, and Ladakh.

The Kashmir Valley has already experienced signs of the coming harsh winter. November, traditionally the onset of the cold season, saw three moderate snowfall events, primarily in the mountainous regions. Early snowfall has caused temperatures to dip dramatically, with nighttime temperatures consistently hovering between 0°C and -5°C.

The weather experts are forecasting that the intensity of snowfall will increase as the winter advances, resulting in a more severe and prolonged cold season.

The region has been grappling with extreme weather variations in recent years, with long dry spells and increased temperatures, a trend that experts attribute to global warming and climate change. However, this year, the La Nina phenomenon, the opposite of last year's El Niño, is expected to bring significant snowfall and colder temperatures to the Valley.

### Delhi air quality stays 'poor' for second consecutive day



NEW DELHI. Delhi experienced a much-needed break from hazardous air as its AQI remained in the "poor" category on Monday, recording a 24-hour average AQI of 280 at 4 pm. This marked a slight improvement from Sunday's reading of 285 and was the second consecutive day of AQI below 300, a threshold the city had struggled to breach for over a month.

The air quality deteriorated to "very poor" on October 30 and frequently fluctuated between the "very poor" and "severe" categories throughout November. Sunday's improvement was attributed to dry northwesterly winds and ample sunlight.

Data from the city's 38 monitoring stations revealed varied air quality levels. While 12 stations reported "very poor" air, 25 recorded "poor" levels, and one station recorded "satisfactory" results, according to the Sameer app. PM2.5 remained the dominant pollutant, with levels at 106 μg/m3 at 3 pm. These fine particles, capable of entering the bloodstream through the lungs, pose serious health risks. The Central Pollution Control Board (CPCB) classifies AQI as "good" (0-50), "satisfactory" (51-100), "moderate" (101-200), "poor" (201-300), "very poor" (301-400), and "severe" (above

While vehicular emissions are typically a significant contributor, data from the Decision Support System (DSS) for Air Quality Management had not been updated for the weekend or Monday, with Friday's data

showing a 21.4% contribution to the city's pollution. According to the Air Quality Early Warning System, surface winds from the northwest at speeds below 8 kmph were observed in the morning, with predictions of smog and shallow fog during the evening and night. Clear skies and "poor" air quality are expected to persist from Tuesday to Thursday.

Here, he shares advice on how to work away from the maddening crowd and convince your boss and clients to be okay with it.

#### Strong conviction

There's always a strong current in your favour when moving from your hometown to a big city for work. But the current is against you when you move back. You need unwavering conviction as a family to complete this journey. In my case, the realisation came from a comparison of the first 20 years of my life and the last 20 years. The first 20, a life surrounded by nature, spirituality, farms and many generations of family and friends, prepared me to perform well in the professional world during the last 20. I was convinced that the opportunity to give those first 20 years to my children - without giving up my professional life -

was a goal worth pursuing.

#### Double-up on your back-up


Working from home requires a lot of positive energy, and discipline. Let your family and friends know that you are working from home, not at home. Importantly, if you plan to relocate to a small town, ensure that your office is well versed with technology - use instant messenger for realtime interaction, online and video conferencing, desktop sharing, and remote access. You must also have easy travel connectivity to your base office.

Keep in mind that at God's own office, you are your own Chief Information Officer. It is your decision to work from home and not your employer's, so the onus is on you to make sure you are able to work without interruption. In an office, the onus is on the IT department to ensure digital connectivity. Plan your back-ups well broadband connection and power supply. I work with a physical cable, a state telecom

Five years after returning to India, I gave up my job at Microsoft. Later, I was at a dinner when I wondered why chefs didn't use jackfruit known as "vegetable meat" - instead of mushroom in vegetarian dishes. That is how I struck on the business idea. But, before you make your switch, study the business model and identify areas where you have significant strength and areas where you don't have expertise. I leveraged my marketing skills, professional networks, cash-flow

management and outsourcing experience for the venture. I clearly lacked experience in food processing and hence, outsourced that to a reliable partner. I leveraged my contacts and got various chefs at 5-stars to try new dishes using jackfruit.

For the consumer business, I used an onlineonly model. This allowed me to offer my product across India; more importantly, they pay first, then materials are dispatched.

### Study the risk

There are risks involved in having a niche product like jackfruits. I analysed the overall scope for a jackfruit industry in India to see if it was worth my time. On the supply side, I learned that jackfruit worth Rs 2,000 crore is wasted in India every year. On the demand side, my trials with chefs convinced me that jackfruit can easily replace potato and apple in almost all dishes. The market for potato and apple is bigger than the total supply of jackfruits in India. These data points gave me the confidence to launch JackFruit365.

### The financial aspect

I needed to keep in mind whether I could m the financial commitments of my family and the new venture till I was able to draw a salary from the business. My cost of living

had come down by 30 per cent by moving from Bangalore to my village in Kerala. In four years, I was able to set aside a fund from this additional saving to cover both financial commitments. For the first few years, I managed the business with tight cash flow management, repositioned jackfruit from an inferior food to superior one with the help of the chefs, and through the social media marketing I ran.

### Exploit social media

While I was working for Microsoft, I started mentoring three start-ups from the Kochi Start-up village and I have firsthand experience observing how these youngsters bring new business ideas to the market with relatively low capital investment. Mentoring them taught me how to leverage social media, crowd sourcing and e-commerce retail channels to keep my investments low at all levels. Mindhelix taught me how to use social media and blogs to reach consumers, WOW Makers taught me the power of crowd sourcing, (JackFruit365's logo and mascot was designed through their CrowdStudio venture), and Yummybay taught me the power of ecommerce (Yummybay is JackFruit365's online retail partner).



NEW DELHI. Both gold and silver prices recorded a hike on the Multi Commodity Exchange (MCX) on Tuesday, December 3, 2024. Gold futures, maturing on February 5, 2024, stood at Rs 76,764 per 10 grams on the MCX, after recording a jump of Rs 77 or 0.10 per cent. The previous close was recorded at Rs 76,687. Meanwhile, silver futures, maturing on March 5, 2024, witnessed a marginal hike of Rs 322 or 0.35 per cent and were retailing at Rs 91,132 per kg on the MCX against the previous close of Rs 90,810. The gold and silver prices in India depend on several factors, including the value of the rupee against the dollar. Global demand also plays a key role in determining the trends observed in the rate of precious metals.

Gold prices were steady on Tuesday as investors took a cautious stance ahead of the upcoming U.S. economic data that could provide insights into the Federal Reserve's interest rate path, news agency Reuters reported. According to the latest metal report, spot gold stood nearly unchanged at \$2,636.50 per ounce, as of 0156 GMT, while, U.S. gold futures stood flat at \$2,659.00.

### Bangladesh halves power buying from Adani citing low winter demand: Report

**NEW DELHI.** Bangladesh has halved the power it buys from Adani Power, citing lower winter demand, government officials told Reuters on Monday, amid disagreements over dues running into hundreds of millions of dollars. Adani, whose founder has been accused by US authorities of being involved in a bribery scheme in India, charges which he has denied, halved supply to Bangladesh on October 31 over payment delays as the country battles a foreign exchange shortage. Subsequently, Bangladesh told Adani to keep supplying only half the power for now, officials said, although it will keep paying its old dues. We were shocked and angry when they cut our supply," said Md. Rezaul Karim, chairperson of the state-run Bangladesh Power Development Board (BPDB). "Winter demand is now down, so we have told them there is no need to run both units of the plant."Adani has been supplying power under a 25-year contract signed in 2017 under ousted Prime Minister Sheikh Hasina, from a \$2-billion power plant in Jharkhand that has two units, each with a capacity of about 800 megawatts. A document seen by Reuters showed the plant ran at only 41.82 per cent capacity in November, the lowest this year, with one unit shut since November 1.

Two BPDB sources said Bangladesh had bought about 1,000 MW a month from Adani last winter, adding that Adani had asked the board when it would resume normal purchases, but had not received a definitive answer.An Adani Power spokesperson said the firm was continuing to supply Bangladesh, although mounting dues were a significant concern, making plant operations unsustainable.

'We are in constant dialogue with senior officials of BPDB and the government, who have assured us that our dues will be cleared soon," said the spokesperson. The firm was confident Bangladesh would fulfil its commitments, just as Adani had upheld its contract obligations, he added.Karim said Bangladesh owed Adani about \$650 million, and paid about \$85 million last month and \$97 million in October.An Adani Power source, speaking on condition of anonymity, said the dues had jumped to about \$900 million, hurting its debt profile and risking a higher cost of funds.Bangladesh wants to sharply lower prices under the Adani deal, unless it is cancelled by a court, which has called for an investigation into it, the de facto minister for power and energy told Reuters on Sunday. The Adani Power spokesperson said the firm had no indication that Bangladesh was reviewing its power purchase pact. Adani charges the highest rate of all Indian suppliers to Bangladesh, a government document seen by Reuters showed. Its cost per unit was 14.87 taka during the fiscal year that ended on June 30, 2024, compared with an average of 9.57 for all Indian suppliers.

# GST on cigarettes, tobacco, aerated drinks may rise to 35%: Report

**GST News: The Group of** Ministers (GoM), led by Bihar Deputy Chief Minister Samrat Choudhary, met on Monday to finalise the proposed rate adjustments.

**NEW DELHI.** The Group of Ministers (GoM) on GST rate rationalisation has proposed increasing the tax on products such as aerated beverages, cigarettes, and other tobacco-related items to 35%, up from the current rate of 28%, reported news agency PTI. This decision may be a part of a broader effort to adjust tax rates on certain goods to enhance revenue collection.GST RATE CHANGES

DISCUSSED

The GoM, led by Bihar Deputy Chief Minister Samrat Choudhary, met on Monday to finalise the proposed rate adjustments. Alongside the hike for "sin goods," changes to the GST structure for apparel and other items were also discussed.

Costing up to Rs 1,500: Taxed at 5%. Between Rs 1,500 and Rs 10,000: Taxed at 18%

Above Rs 10,000: Taxed at 28%. The GoM has proposed tax changes

for 148 items in total, with the expectation that the adjustments will have a positive impact on revenue. The GoM's report will be presented to the GST Council on December 21, 2024. The council, chaired by the Union Finance Minister and including state finance ministers, will make the final decision on the proposed changes.

'The GoM has agreed to propose a special rate of 35% on tobacco and related

products and aerated beverages. The existing four-tier tax structure of 5%, 12%, 18%, and 28% will remain, with the addition of the new 35% rate," said an official as quoted by PTI.

**EXISTING GST STRUCTURE** 

Under the GST system, essential items are either exempt or taxed at the lowest slab, while luxury and demerit goods are taxed at higher rates. Luxury goods, such as cars and washing machines, and demerit goods, including aerated beverages and tobacco products, also attract a cess in addition to the highest slab rate of 28%.

The GoM's recommendations will help the council assess whether there is further scope for rate rationalisation. The council may also decide to extend the GoM's mandate for periodic reviews of GST rates.

PREVIOUS GOM PROPOSALS In its last meeting in October, the

GoM made several other raterelated suggestions:Packaged Drinking Water (20 litres and above): Reduce GST from 18% to 5%.

Bicycles costing less than Rs 10,000: Reduce GST from 12% to 5%.

Exercise Notebooks: Reduce GST from 12% to 5%. Shoes costing above Rs 15,000 per pair: Increase GST from 18% to 28%. Wristwatches above Rs 25,000: Increase GST from 18% to 28%



### Govt scraps windfall tax on ATF, crude oil products, petrol, diesel NEW DELHI. Finance ministry on

Monday announced the scrapping of the windfall tax or special additional excise duty (SAED) on aviation turbine fuel (ATF), crude oil products, petrol and diesel. The windfall tax, which targeted unexpected profits from domestic crude oil production, was first imposed in July 2022. As per the notification, the tax on the production of petroleum crude and the export of ATF, petrol, and diesel will no longer be levied. This move is expected to benefit oil producers and refiners such as Reliance Industries and ONGC, potentially improving their refining margins. Shares of Reliance Industries rose following the announcement. ONGC shares closed at '257.65, up by 0.37%, while Reliance Industries shares closed at `1,310.60, up by 1.42%. The decision to roll back windfall tax followed a review by the



Prime Minister's Office (PMO), the Revenue Department, and the petroleum ministry. It was also accompanied by the withdrawal of the Road and Infrastructure Cess (RIC) on the export of petrol and diesel. The windfall tax was introduced in July 2022 in response to surging crude oil prices caused by the Russia-Ukraine war and Western sanctions on Russia. The tax rates were revised every fortnight based on international crude oil prices. However, with global crude oil prices stabilising around \$70-\$75 per barrel, the government decided to eliminate the levy. The rollback is believed to be a response to declining government revenues from tax, which fell from '25,000 crore in FY23 to about `6,000 crore in FY25.The windfall tax was last revised on August 31, when it was set at `1,850 per tonne for crude petroleum. Export duties on diesel, petrol, and jet fuel had already been reduced to zero as of September 18, signalling the government's intent to phase out the levy. Since its levy, the windfall tax has been a subject of controversy. While it initially sought to balance government revenue amid fluctuating oil prices, industry players argued it negatively impacted profitability and disincentivised production. For private and foreign players, it brought in an element of

## Intel CEO Pat Gelsinger's 'Bittersweet' response after being forced out

NEW DELHI Intel Corporation's Chief Executive Officer, Pat Gelsinger, has been forced to step down after the company's board lost faith in his plans to revive the struggling chipmaker, reported Bloomberg. This marks a major shake-up at one of the most prominent technology companies in the worldThe board's decision followed a tense meeting last week where Gelsinger discussed Intel's efforts to regain market share and compete more effectively with rivals like Nvidia Corporation. According to

sources, quoted in the report Gelsinger was presented with two options: announce his retirement or face removal. He chose to retire, ending his career at the company.

Intel's Chief Financial Officer, David Zinsner, and Executive Vice President, Michelle Johnston Holthaus, have taken over as interim co-CEOs while the board searches for a permanent replacement. Meanwhile, Frank Yeary, the independent chair of Intel's board, will act as interim executive chair. The company said that the leadership team is focused on stabilising operations and restoring investor confidence.

GELSINGER'S JOURNEY WITH

Pat Gelsinger, 63, had a long history with Intel, beginning his career there as a teenager. After spending decades at the company, he left in 2009 to lead VMware Inc. He returned to Intel in 2021 with the ambitious goal of regaining its manufacturing dominance, which had been surpassed by competitors such as Taiwan Semiconductor Manufacturing Company (TSMC). Gelsinger also sought to expand Intel's reach by producing chips



for other companies, directly competing with TSMC and Samsung Electronics. Under Gelsinger's leadership, Intel unveiled a bold plan to expand its factory network, including a major new facility in Ohio. This project received federal funding through the Chips and Science Act. Despite these efforts, Gelsinger's strategies faced challenges due to stiff competition, industry shifts, and rising costs. News of Gelsinger's departure initially pleased investors, causing Intel's shares to rise by 6% during Monday's trading. However, the gains were shortlived, and the stock ended the day down 0.5% at \$23.93. This brings the company's total decline for the year to 52%, reflecting ongoing struggles in a **COMPETITION FROM NVIDIA** 

One of Intel's major hurdles has been the rise of artificial intelligence computing, an area dominated by Nvidia. Once considered a niche player, Nvidia has transformed its graphics chips into essential tools for AI and data centres, making it the world's most valuable publicly traded semiconductor company. market have not yet gained significant traction.In a statement, Gelsinger expressed mixed emotions about his departure. "Today is, of course, bittersweet as this company has been my life for the bulk of my working career," he said. He acknowledged the difficulties of the past year but defended the tough decisions made to adapt to market demands.Frank Yeary, Intel's interim executive chair, highlighted the importance of focusing on the company's core products."We know that we have much more work to do at the company and are committed to restoring investor confidence," he said. "Our customers demand this from us, and we will deliver


