

### visit Bangladesh next week Sanjay Kumar

Dhaka, Dec 04: Indian Foreign Secretary Vikram Misri is likely to visit Bangladesh next week for a foreign secretary-level meeting, amid

tensions between the two countries after the interim government headed by Muhammad Yunus came to power. Foreign Adviser Md Touhid Hosain said the scheduled Foreign Secretary-level Foreign Office Consultation (FOC) between Bangladesh and India will take place in Dhaka on December 9 or 10, the state-run BSS news agency reported. It will be the first high-level visit by a senior Indian government official to

Bangladesh since the interim government came to power on August 8 after the ouster of Sheikh Hasina as prime minister. "It is very clear that we want a good relationship (with

India)," Hosain told reporters at the Foreign Ministry here. However, he emphasised that relations between Bangladesh and India must be built on a reciprocal basis. "Both sides need to want that and should work for it." Hosain said while the FOC is scheduled for December 10, it might be held a day earlier, on December 9. During the high-level consultation, Foreign Secretary Md

Jashim Uddin and Indian Foreign Secretary Misri will lead their respective delegations, the news agency said. The discussions are expected to cover a range of bilateral issues, including the potential extradition of Hasina and visa-related matters, it said. Hasina is facing trial in Bangladesh's International Crimes Tribunal for alleged involvement in mass killings during the July-August uprising

New Delhi, Dec 04: Maharashtra CM-designate Devendra Fadnavis on Wednesday met Governor CP Radhakrishnan to stake claim to form the government in the state.

Fadnavis accompanied by deputy chief minister-designate Eknath Shinde of Shiv Sena and Ajit Pawar of NCP, handed over letters of support of NDA parties and MLAs to the governor who invited the alliance to form the government. "We have met the Governor and handed over the letter of support to stake claim to form the government in the state. The Governor has invited us for the oath ceremony today at 5.30 pm," Fadnavis said after the meeting. He was flanked by Shinde and Ajit Pawar. Earlier on Wednesday, Fadnavis, 54, was unanimously elected leader of the BJP legislature party in Maharashtra, paving the way for his return as the chief minister of India's richest state. Fadnavis was elected by all 132

Speaking to reporters outside Parliament in New Delhi, Tewari said, "It is very sad and condemnable. Shri Akal Takht is the highest temporal seat of the Sikhs and if they have taken action Sukhbir Singh Badal was humbly atoning for his mistakes. This attack on him is very sad." "This attack should be probed and the one responsible should be punished," Tewari said. Sukhbir Badal was shot at by Narayan Singh Chaura, a former Khalistani militant, while he was performing duty of





#### 'sewadar' outside the Golden Temple in Amritsar Condemning the attack, senior BJP leader Capt Amarinder Singh expressed relief that Sukhbir was safe. The city has 113 cooperative societies with nearly 15,000 flats. During the ongoing Lok Sabha session, city MP Manish Tewari sought to know whether the government planned to revise the Chandigarh Housing Board's method to calculate conversion charges for cooperative societies. while societies under the Estate Office were exempt from such charges. To this, the minister replied, "The board has sought a clarification on the applicability of GST charges from the Authority of Advance Ruling with the GST Department." The city MP also asked about the steps being

taken by the government to expedite the issuing of completion certificates for cooperative housing societies, some of which were awaiting approval since 2001. The minister said of the 113 such societies under the Estate Office, occupation certificates had been issued to 88 while 13 never applied for it. He added that two cases were rejected. "Ten applications are pending due to non-

rectification of deficiencies by the applicant societies," he said. JJ Singh, president of a cooperative housing society in Sector 48, RS Thapar, president of a cooperative housing society in Sector 49, and

housing building society in Sector 50-D, stated that they had been raising various issues faced by residents of cooperative housing flats. They said many societies had not been issued completion certificates despite a March 2, 2016, order of the then UT Adviser. All these years, residents were made to pay not only double charges for water as penalty. Despite sanctioning of water connection, the water bill was being calculated at 50 kl per month and not on actual consumption, which was around 20 kl per month, they said. For want of completion certificate, leasehold societies could not apply for conversion to freehold. The land rate, which was Rs 1,710 as per the 1996 conversion policy, has been hiked to Rs 84,227, almost 50 times, in 2017, they stated. The Estate Office had agreed in a meeting to take over works related to the housing societies from the board as recommended by them, but no official action was taken on it so far, they claimed.

# Supreme Court raps MP HC for ignoring woman judge's miscarriage before sacking her

New Delhi, Dec 04: Wish men have menstruation, the Supreme Court has remarked, censuring the Madhya Pradesh High Court's decision to sack a woman judge in the state based on performance and not considering her predicament due to a miscarriage. A bench of

Justices BV Nagarathna and N Kotiswar Singh sought a clarification from the high court on the criteria for the termination of civil judges. "I hope such criteria is also imposed on male judges. I have no hesitation in saying this. The lady, she has got pregnant and she had miscarriage. The mental and physical trauma of a lady who has undergone a miscarriage. What is this? I wish men have menstruation. Then they will know what it is," remarked Justice Nagarathna, questioning the assessment of the woman judicial

officer which had ignored the mental and physical trauma endured by her due to the miscarriage. On November 11, 2023, the top court took a suo motu (on its own) cognisance of the termi-

nation of six women civil judges by the state government over their alleged unsatisfactory performance. However, a full court of the MP high court reconsidered its earlier resolutions on August 1, and decided to reinstate four officers, namely, Jyoti Varkade, Sushri Sonakshi Joshi, Sushri Priya Sharma and Rachna Atulkar Joshi on certain terms and conditions leaving out the



other two Aditi Kumar Sharma and Sarita Chaudhary from the exercise. According to a report submitted by the high court, Sharma's performance dropped from "very good" and 'good" ratings during 2019-20 to "average" and

"poor" in the subsequent years. In 2022, she had about 1,500 pending cases with disposal rate below 200, it was stated. The judge, on the other hand, informed the high court about suffering a miscarriage in 2021, followed by her brother's cancer diagnosis. While taking cognisance of the termination, the bench issued notices to the high court registry and the judicial officers who had not approached it against the termination. The judges were terminated despite the fact that a quantitative assessment of their work could not be done on account of the Covid outbreak, the court noted. "The officers along with three other women officers were appointed in judicial services in the state of Madhya Pradesh. They are alleged to be terminated from service primarily on account of disposal not being up to the standards set," the office report stated. The termination orders were passed in June, 2023 by the state law department after an administrative committee and a full court meeting found their performance during the probation period "unsatisfactory". An impleadment plea of one of the judges, filed through advocate Charu Mathur, argued despite a four-year unblemished service record and no adverse remarks, she was terminated without following any due process of law.

## Rakesh Tikait detained by Aligarh Police

Aligarh, Dec 04: BKU leader Rakesh Tikait was detained by the Aligarh Police on Wednesday while on his way to Greater Noida to participate in a meeting of farmer leaders, a police official said. The Bharatiya Kisan Union's influ-



ential spokesperson and his associates were taken to the Tappal police station in a bus after they were stopped from proceeding on the Yamuna Expressway. When contacted, an official spokesman of the Aligarh Police confirmed that Tikait had been "detained" but "not arrested". Tikait told reporters that the police were preventing farmers from going to Noida in Gautam Buddh Nagar by forcing them to stay in their respective houses. "How long will you detain us? If you keep us locked, then with

whom will you talk to?" he said. He warned that if this approach of the authorities continued, the agitation of the farmers would intensify. The BKU had on Tuesday convened an emergency meeting at the Kisan Bhawan in Sisauli village of Muzaffarnagar under the leadership of its chief Naresh Tikait and resolved to extend support to the farmers in Noida and Greater Noida who are agitating over the issue of land com-

pensation and other demands. The BKU had called on its workers and members from western Uttar Pradesh districts to gather at the Zero Point in Greater Noida on Wednesday, according to the union's youth wing president Anuj Singh.

#### Many blackspots in Alappuzha, yet rectification work slow: Officials

KOCHI. Alappuzha's poor road-safety record was underscored by Monday night's accident near Kalarkode, an area which traffic experts have termed as "accident-prone"

- While several such stretches have been identified in the district, which topped the state in terms of fatal mishaps last year, agencies concerned have failed to carry out rectification of blackspots identified by the National Transportation Planning and Research Centre (Natpac).In the wake of Monday's fatal accident, the Alappuzha Regional Transport Officer (RTO) on Tuesday submitted a report to the collector, recommending the implementation of four measures on the stretch on a war footing. The team found the section lacking road markings and adequate lighting, among others.
- "The section of road has no border markings which makes it difficult for drivers to judge the edges of roads. Then, there is the issue of poor lighting, for which streetlights should be installed. We have recommended the removal of a large tree near the accident site which channels water onto the road during rain. Waterlogging on roads can cause hydroplaning,"Alappuzha RTO Dilu AK told TNIE.

'Kalarkode stretch accident-prone'

A road-safety expert who had worked with Alappuzha police to help decongest roads in 2022 said the stretch near Kalarkode junction is an accident-prone area. According to Upendra Narayan, there are two major traffic junctions in the area with no specific speed limits for vehicles."It is a narrow stretch and often during daytime vendors line the road. There is also no proper signage cautioning motorists about upcoming junctions.

# Hyderabad: Peripheral ULBs, GPs to get improved drinking water supply

## ... Thousands of households in Rangareddy, Medchal-Malkajgiri and Sangareddy districts are set to benefit from the move

HYDERABAD. With the commissioning of 19 water reservoirs, consumers in the peripheral Urban Local Bodies (ULBs) and Gram Panchayats (GPs) outside the Greater Hyderabad Municipal Corporation (GHMC) limits but within the Outer Ring Road (ORR) under the Hyderabad Metropolitan Water Supply and Sewerage Board (HMWS&SB) are set to receive improved drinking water supply.

The project is expected to benefit thousands of households in mandals such as Saroornagar, Maheshwaram, Shamshabad, Hayathnagar, Ibrahimpatnam, Ghatkesar, Keesara, Rajendranagar, Shamirpet, Medchal, Qutubullapur, RC Puram, Patancheru and Bolarum. The initiative includes the construction of 19 Ground Level Surface Reservoirs (GLSRs) and Elevated Level Surface Reservoirs (ELSRs) along with the laying of approximately 554.77 km of water pipelines at a cost of Rs 188.11 crore. These reservoirs are distributed across Medchal (seven), Maheshwaram (six), Patancheru (four) and Rajendranagar (two)

Assembly constituencies. Each consumer is expected to receive the water supply on alternate days with 135 litres per capita per day (LPCD).

Sewerage infrastructure In addition to water supply, six Sewerage Treatment Plants (STPs) with a combined capacity of 527 million litres per day (MLD) have also been commissioned. These STPs aim to prevent sewage flows in the catchment areas, achieving 100% sewage treatment in the GHMC area by December 2025. Part of a Rs 3,866-crore project funded by the state government, this initiative focuses on enhancing urban sanitation and protecting

local water bodies from untreated sewage. The treated water will be released into tanks and water bodies in compliance with standards, preserving hydrology and



improving hygiene in and around the catchment areas.

Sources said that to ensure adequate drinking water for ULBs and GPs within the ORR and outside GHMC limits, the state

government allocated Rs 1,200 crore in September 2021. Under the ORR Phase-II project, HMWSSB is constructing 71 ELSRs/GLSRs with a total capacity of 138 ML across 12 mandals. Of these, 61 reservoirs have been completed, while 10 are nearing completion. Additionally, 2,728 km of the planned 2,764 km of inlet, outlet and distribution pipelines have been laid.Out of the 20 STPs planned for the GHMC area with a total capacity of 1,106 MLD, 10 STPs with a combined capacity of 653 MLD have been commissioned, including those at Kokapet (15 MLD), Durgam Cheruvu (7 MLD), Nalla Cheruvu (86.5 MLD), and Pedda Cheruvu (17.5 MLD). The remaining 10

STPs, with a total capacity of 453 MLD, are under construction and are expected to be operational by December 2024 or January 2025.

# Heavy rain, inexperience of driver led to accident Iskcon flyover tragedy: Court that killed five students: MVD officials

Overcrowded vehicle, poor visibility also cited . Car lacked safety features such as ABS, airbags . Vehicle veered after brakes were applied and rammed the bus

ALAPPUZHA. Heavy rain and an inexperienced driver, according to officials, are believed to have caused the accident that claimed the lives of five students of Alappuzha Medical College. The incident occurred at Changanassery junction in Kalarkode, Alappuzha, around 9.20pm on Monday. The deceased are Devanandan, 19, of Kottakkal, Malappuram; Sreedeep Valsan, 19, from Shekharipuram, Palakkad; Ayush Shaji, 19, of Kavalam, Kuttanad; Muhammed Ebrahim P P, 19, from Androth Island in Lakshadweep; and, Muhammad Abdul Jabbar, 19, of Muttom, Kannur. The six other students in the car, Anand Manu, Krishadev, Alvin, Muhsin, Gouri Shankar, and Shane, sustained injuries. The first three are in critical condition. The group was travelling to see a movie in Alappuzha town from their hostel in a rented car owned by Shamilkhan, of Valanjavazhi, Alappuzha. The driver lost control of the car when he applied brakes and the vehicle collided side-



on with an oncoming KSRTC bus bound for Kavamkulam. Motor vehicle department (MVD) officials said the accident was caused by reckless driving on the part of the

anti-lock braking. When he applied the brakes, the vehicle veered and rammed into the bus," said A K Dilu, RTO, Alappuzha.The seven-seater car was carrying 11 people at the time

summoned him for questioning. There was heavy rain at the time of the accident and it may obstructed the vision of the driver. Steps would be initiated to suspend the driving licence of the driver," RTO said.Meanwhile, Transport Commissioner C Nagaraju said that the Alappuzha accident resulted from a combination of factors, including an inexperienced driver, overcrowded vehicle and poor visibility. The incident involved 11 students travelling in a 2010-model seven-seater Tavera. "When a vehicle is overcrowded, the driver's ability to manoeuvre is compromised. The partial damage to the vehicle suggests that overspeeding may not have been the cause, though we will confirm this through scientific analysis," Nagaraju said. He added that a joint report from the MVD police and NHAI will be submitted on the accident, and the National Transportation Planning and Research Centre (Natpac) will also conduct an accident analysis.

# denies bail to Tathya Patel

Ahmedabad. A rural court here on Tuesday rejected the regular bail plea of Tathya Patel, who is accused of recklessly driving a car and causing the death of nine people on the Iskcon flyover in July last year. The principal sessions judge of the Ahmedabad rural court, K M Sojitra, rejected the bail plea and observed that the accused was charged with a serious offence in which nine people lost their lives. The court further observed that Tathya had a habit of causing accidents; hence, releasing him on bail was not justified.With the

sessions court rejecting Tathya's bail plea, it is likely that he may approach the Gujarat high court for bail. Tathya was in jail for rash driving and causing the death of nine people.On July 20, 2023, Tathya allegedly drove his Jaguar car at high speed (over 142.5 kmph) on the Iskcon Bridge, running over nine people and killing them on the spot.Tathya

was in jail since then as his bail pleas were rejected or disposed of by different courts. His father, Pragnesh Patel, who is a co-accused in the case, was granted bail by the Gujarat high court in Nov last year on the condition that he would not enter Ahmedabad except to attend court hearings. Tathya's advocate argued in court that the police completed the investigation and filed a charge sheet; hence, there was no possibility of tampering with evidence. He added that the court had the authority to grant bail, and his client was willing to comply with all conditions if released on bail. However, the chief public prosecutor, Pravin Trivedi, argued that Tathya was accused of killing

Due to absence of an English teacher in the school, the subject was completely ignored, they said.

The school runs under the Scheduled Caste and Scheduled Tribe, Minorities and Backward Classes department under the supervision of Kaptipada ITDA in the district. The girls left the hostel at around

4 am, while the school warden, watchman, and other staff were asleep. They exited through the main gate and began their journey towards Baripada to meet the collector. ## Spat over fare leads to guard's murder in Gurgaon, auto driver nabbed

News box

Gurgaon. An auto driver was arrested for allegedly stabbing a security guard to death with broken pieces of a beer bottle during an argument over auto fare.

According to police, the victim, Satpal alias Ramu (24) of Faridabad, along with his roommate, Govind, was at the IMT traffic signal to book an auto to reach a private hospital in the city to meet a family member admitted there. An argument broke out between Satpal and the auto driver, who asked for Rs 600 to take them to Ballabgarh, police said. Cops added that the security guard had offered Rs 300. While Satpal was arguing with the driver, the latter's friend, Sonu, who shares driving duties, reached there with a beer bottle and joined the argument. He suddenly attacked Satpal on the head with the bottle and stabbed him in the chest with the broken pieces of the bottle after which the duo fled from the scene, police said. The victim succumbed to injuries while undergoing treatment at the hospital on December 1.Based on a complaint filed by Satpal's brother, Bhupender Singh, a case was registered against Sonu and his associate under sections 103 (1) (murder), 3 (5) (common intention), and section 3 of the SC&ST (POA) Act at Sadar Ballabgarh police station.On Dec 2, Sonu, a resident of the Chandawali area, was arrested and police recovered the autorickshaw and pieces of the beer bottle from his possession.

## Untreated waste flowing into stop at Surajpur

Noida. Untreated industrial waste that continues to find its way into Surajpur wetland through drains is not just

damaging its flora, but also keeping waterbirds away. The wetland usually sees the first few winter migratory birds - Red-crested Pochard, Ferruginous Pochard, Bar-headed Goose, Greylag Goose, Common Teal, Northern Shoveler and Gadwall - arrive from the start of Oct. With migration season already underway, the waterbody is still covered with effluents.

Wildlife photographer Nitin Bhandari, who visited the wetland last week, said the water had turned "pitch black" with chemical residue and oil floating on its surface."The foul odour was unbearable, and no birds were visible. A few foreign visitors, who were at the wetland at the time, were donning masks to escape the



stench. They left within minutes," Bhandari said. Loud noise from construction projects nearby was also disrupting the tranquillity in the habitat. Bird enthusiasts confirm the number of winter migratory birds has plummeted to under 400 this year — the lowest recorded count.

'Species like bar-headed geese and lesser whistling ducks are completely absent," Shekhar, a regular visitor to the wetland, said. "This decline has been evident over the last four years and the current situation is the worst yet."The Hawaliya drain, which flows into the wetland, is suspected to be the primary source of the pollution, carrying untreated sewage and industrial effluents.Dr Ritesh Kumar, director of Wetlands International South Asia, said, "Wetland rules strictly prohibit direct discharge of sewage or industrial waste. The contamination will not only devastate local flora and fauna but also pose a threat to groundwater quality. "DFO Pramod Srivastav said the pollution control department has been alerted. "We've requested immediate testing of water samples and an investigation. Officials from the pollution department and the Greater Noida Authority will inspect the site on Wednesday. This is the first time we've encountered such an intense smell from the wetland," he said.

# **GRAP** restrictions, cold weather: Road repairs suffer twofold blow

Gurgaon. Despite GMDA's allocation of funds and approval for road recarpeting work in the city, residents may have to wait longer to see improvements as Graded Response Action Plan (GRAP) restrictions will delay commencement of the projects.Letters of acceptance were issued to the contracted agencies last week and the agencies are currently in the process of submitting bank guarantees, which need to be done before work orders can be issued. However, implementation of GRAP stage IV, which restricts construction activities to curb air pollution, will not allow any immediate groundwork.Even if GRAP measures are eased, the project will remain stalled as extreme winter is unsuitable for road recarpeting work as rapid cooling of the bituminous mix prevents proper compaction and bonding. Low temperatures hinder adhesion between bitumen and aggregates, leading to weaker surfaces prone to damage. The moisture from fog also affects the binding process."Agencies have been awarded special repair works of the master roads and service roads covering over 80km. They are in the process of submitting bank guarantees and once the process is complete, they will start mobilising



manpower and machinery. While challenges like GRAP and weather conditions are there, procedural requirements must be followed and we are confident that the works will be completed within the stipulated timeframe of 9 months after works orders are issued," a senior official of GMDA

said. The works were initially supposed to begin earlier this year, but before GMDA could issue the tenders, dates of Lok Sabha elections were announced, and the model code of conduct (MCC) came into effect. This delayed the process till June, until the election results were announced, as no new projects could be undertaken

before that.GMDA floated the tenders for road repairs and revamp in mid-June, but before contracts could be awarded, the dates for Haryana assembly elections were announced in Aug. The projects got financial approval from the govt only in Nov. This delay in commencement of the repair works has caused inconvenience to commuters, especially those of the new sectors.Praveen Malik, president of United Association of New Gurugram, said, "Most of the roads in sectors 81-95 haven't been repaired for nearly a decade, despite our repeated complaints. GMDA officials are aware that no road works can be started till Feb end.

They should at least fill up the potholes on these roads to ease the suffering of commuters. Broken roads are also adding to dust pollution in the vicinity."Among the projects pending are repairs of stretches between Krishna Chowk to Rezang La Chowk and Mahavir Chowk to Atul Kataria Chowk. The New Railway Road, Old Railway Road, and Civil Lines Road, master roads for new sectors including 90-93, 92-95, 91-92 and 92-95 among others along the Dwarka expressway and inter-sector roads are to be repaired as well.

#### IIT-Delhi vets project, IT City to get Rs 40cr STP soon; 4 more in Gr Noida too


Noida. Greater Noida Authority is likely to set up five more sewage treatment plants (STPs) to improve wastewater recycling in the township. Currently, the city has four STPs, the largest of them is a plant with a capacity to treat 137 MLD wastewater in Kasna.

Officials said a 45MLD plant is set to come up in Sector 1, a 12MLD plant in IT City, a 50MLD plant in Knowledge Park V, a 42MLD plant in Ecotech VI, and a 72MLD plant in Sector MU Recreational Green.

The Authority recently approved Rs 40 crore for the STP in IT City, which will treat sewage from areas such as Gharbara, IT City and Mursadpur.

Work on the project, which received in-principle approval from CEO Ravi Kumar NG after it was vetted by IIT-Delhi, is expected to start in three to four months The Authority has issued the process to hire a firm for the construction of the Rs 80-crore STP in Sector 1. The construction of the remaining three will be taken up in the next phase, officials said.Besides the Kasna plant, Greater Noida has operational STPs at Ecotech III with a capacity to treat 20 MLD wastewater, Ecotech II (15 MLD), and a smaller plant in Badalpur (2 MLD). Treated water from these units is used for irrigation and construction activities.

According to officials, the new sewage plants aim to accommodate the township's growing sewage treatment needs while ensuring water conservation and pollution control.CEO Ravi Kumar NG said, "Keeping future needs in mind, the Greater Noida Authority is focused on enhancing all basic facilities. Building STPs is a step in that direction. These facilities are essential not only for preventing water pollution but also for maintaining Greater Noida's cleanliness."

## South Korea lifts president's martial law decree after lawmakers reject military rule

**SEOUL.** The president of South Korea early Wednesday lifted the martial law he imposed on the country hours earlier, bending to political pressure after a tense night in which troops surrounded parliament and lawmakers voted to reject military rule.President Yoon Suk Yeol, who appeared likely to be impeached over his actions, imposed martial law late Tuesday out of frustration with the opposition, vowing to eliminate "anti-state" forces as he struggles against opponents who control parliament and that he accuses of sympathizing with communist North Korea.Police and military personnel were seen leaving the grounds of parliament following the bipartisan vote to overrule the president, and the declaration was formally lifted around 4:30 a.m. during a Cabinet meeting.Parliament acted swiftly after martial law was imposed, with National Assembly Speaker Woo Won Shik declaring that the law was "invalid" and that lawmakers would "protect democracy with the people."In all, martial law was in effect for about six hours. The president's surprising move harkened back to an era of authoritarian leaders that the country has not seen since the 1980s, and it was

immediately denounced by the opposition and the leader of Yoon's own conservative party.Lee Jae-myung, leader of the liberal Democratic Party, which holds the majority in the 300-seat parliament, said the party's lawmakers would remain in the Assembly's main hall until Yoon formally lifted his order. Woo applauded how troops quickly left the Assembly after the vote.

Even with our unfortunate memories of military coups, our citizens have surely observed the events of today and saw the maturity of our military," Woo said.

While announcing his plan to lift martial law, Yoon continued to criticize parliament's attempts to impeach key government officials and senior prosecutors. He said lawmakers had engaged in "unscrupulous acts of legislative and budgetary manipulation that are paralyzing the functions of the state."Jo Seung-lae, a Democratic lawmaker, claimed that security camera footage following Yoon's declaration showed that troops moved in a way that suggested they were trying to arrest Lee, Woo and even Han Dong-hoon, the leader of Yoon's People Power Party.Officials from Yoon's office and the Defense Ministry did not respond to



requests for comment early Wednesday. Seemingly hundreds of protesters gathered in front of the Assembly, waving banners and calling for Yoon's impeachment.

Some protesters scuffled with troops ahead of the lawmakers' vote, but there were no immediate reports of injuries or major property damage. At least one window was broken as troops attempted to enter the Assembly building. One woman tried unsuccessfully to pull a rifle away from one of the soldiers, while shouting "Aren't you embarrassed?"Under South Korea's constitution, the president can declare martial law during "wartime, war-like situations or other comparable national emergency states" that require the use of military force to maintain peace and order. It was questionable whether South Korea is currently in such a state.

When martial law is declared, "special measures" can be employed to restrict freedom of press, freedom of assembly and other rights, as well as the power of courts. The constitution also states that the president must oblige when the National Assembly demands the lifting of martial law with a majority vote.ollowing Yoon's announcement

of martial law, South Korea's military proclaimed that parliament and other political gatherings that could cause "social confusion" would be suspended, South Korea's Yonhap news agency said. The military said anyone who violated the decree could be arrested without a warrant.In Washington, the White House said the U.S. was "seriously concerned" by the events in Seoul. A spokesperson for the National Security Council said President Joe Biden's administration was not notified in advance of the martial law announcement and was in contact with the South Korean government.

## Hamas, Fatah near agreement on who will oversee postwar Gaza

CAIRO. Palestinian officials say Fatah and Hamas are closing in on an agreement to appoint a committee of politically independent technocrats to administer the Gaza Strip after the war. It would effectively end Hamas' rule and could help advance ceasefire

talks with Israel. The rival factions have made several failed attempts to reconcile since Hamas seized power in Gaza in 2007. Israel has meanwhile ruled out any postwar role in Gaza for either Hamas or Fatah, which dominates the Western-backed Palestinian Authority.A Palestinian Authority official on Tuesday confirmed that a preliminary agreement had been reached following weeks of negotiations in Cairo. The official said the committee

would have 12-15 members, most of them from Gaza.It would report to the Palestinian Authority, which is headquartered in the Israeli-occupied West Bank, and work with local and international parties to facilitate humanitarian assistance and reconstruction.A Hamas official said that Hamas and Fatah had agreed on the general terms but were still negotiating over some details and the individuals administered by local Palestinians who would serve on the committee. The official said an agreement would be announced after a meeting of all No Palestinians have publicly Palestinian factions in Cairo, without providing a timeline.Both officials

## **US President-Elect Donald** Trump's Lawyers Urge Judge To Toss His Hush **Money Conviction**

World. President-elect Donald Trump's lawyers formally asked a judge Monday to throw out his hush money criminal conviction, arguing continuing the case would present unconstitutional "disruptions to the institution of the Presidency."In a filing made public Tuesday, Trump's lawyers told Manhattan Judge Juan M. Merchan that dismissal is warranted because of the "overwhelming national mandate granted to him by the American people on November 5, 2024."They also cited President Joe Biden's recent pardon of his son, Hunter Biden, who had been convicted of tax and gun charges. "President Biden asserted that his son was selectively, and unfairly, prosecuted,' and treated differently," Trump's legal team wrote. The Manhattan district attorney, they claimed, had engaged in the type of political theater "that President Biden condemned."Prosecutors will have until Dec. 9 to respond. They have said they will fight any efforts to dismiss the case but have indicated a willingness to delay the sentencing until after Trump's second term ends in 2029. In their filing Monday, Trump's attorneys dismissed the idea of holding off sentencing until Trump is out of office as a "ridiculous suggestion." Following Trump's election victory last month, Merchan halted proceedings and indefinitely postponed his sentencing, previously scheduled for late November, to allow the defense and prosecution to weigh in on the future of the case. He also delayed a decision on Trump's prior bid to dismiss the case on immunity grounds. Trump has been fighting for months to reverse his conviction on 34 counts of falsifying business records to conceal a \$130,000 payment to porn actor Stormy Daniels to suppress her claim that they had sex a decade earlier. He says they did not and denies any wrongdoing. Taking a swipe at Bragg and New York City, as Trump often did throughout the trial, the filing argues that dismissal would also benefit the public by giving him and "the numerous prosecutors assigned to this case a renewed opportunity to put an end to deteriorating conditions in the City and to protect its residents from violent crime."Clearing Trump, the lawyers added, would also allow him to "to devote all of his energy to protecting the Nation." The defense filing was signed by Trump lawyers Todd Blanche and Emil Bove, who represented Trump during the trial and have since been selected by the president-elect to fill senior roles at the Justice Department.A dismissal would erase Trump's historic conviction, sparing him the cloud of a criminal record and possible prison sentence.

Rome. It has probably been centuries since Romans have been so feverish about happenings at the Colosseum, and it is not because of the recent release of the Ridley Scott "Gladiator" sequel. A plan by the Colosseum and Airbnb to give a select few people the chance to unleash their "inner gladiator" at the most visited site in Italy has caused an uproar among many Romans who say its demeans a treasured cultural icon.

Over two nights in May, a total of up to 32 people will learn the art of gladiator fighting at the ancient arena, taught by Roman history buffs who specialise in historical re-enactments. The project is a partnership between the Colosseum Archaeological Park and Airbnb, the accommodations booking platform, which donated \$1.5 million to spruce up a permanent exhibit inside the arena. The aim, Airbnb said. "was to support the Colosseum's ongoing conservation work to find new ways to inspire and educate visitors on the historical significance of this bygone era."But some Romans and cultural leaders have given the initiative an emphatic thumbs down. (Footnote: While the emperor made such a gesture to condemn a fighter in the original "Gladiator" movie, scholars are uncertain about the direction thumbs actually pointed in ancient arenas for such purposes.) "We're against transforming the Colosseum into a theme park," said Massimiliano Smeriglio, a member of Rome's City Council. "We're all in favour if a company decides to sponsor a monument or a restoration," he said, "but it shouldn't be necessary to get anything in exchange." Federico Mollicone, a lawmaker with the Brothers of Italy party of PM Giorgia Meloni, dismissed the criticism as the views of a "radical chic" element in Rome that treated the arena "as something sacred". The Colosseum, he pointed out, had been built for rough-and-tumble entertainment. The center-right govt this year passed a law that supports the promotion of historical reenactments.

Critics also raised questions about Airbnb's involvement at a time when many European cities are struggling to balance the needs of locals with a booming postpandemic tourist industry facilitated by accommodation platforms. This summer, the backlash against mass tourism saw protests in many cities, including Barcelona, Spain, and Athens, Greece.While Romans are frequently incensed by many issues in their city - everything from uncollected garbage to potholes - they can be particularly sensitive about the Colosseum. A kerfuffle erupted last year after Elon Musk challenged Mark Zuckerberg on social media to "a cage match", and it was rumored that the Colosseum could be the venue.

## Trump's pick Chad Chronister withdraws from DEA nomination, cites commitment to local duties

added.Chronister expressed gratitude for the nomination and vowed to continue serving as sheriff. However, the announcement has sparked mixed reactions. District 1 Lake County Commissioner Anthony Sabatini called the withdrawal a "huge win for liberty," while Republican Congressman Thomas Massie of Kentucky criticised Chronister's past actions during the COVID-19 pandemic."This sheriff ordered the arrest of a pastor for holding services during the COVID panic. # Gazans walk miles for bread and flour amid war shortages

World Faced with major food shortages A small child, her face covered in tears, after nearly 14 months of war, Palestinians describe long days hunting for flour and bread in the conflict-ravaged Gaza Strip.Every morning crowds form outside Nothing in markets"I walked about eight the few bakeries open in the Palestinian territory, as people desperately try to get a bag of bread at distribution points. Since the outbreak of war in Gaza last year, charities and international aid organisations have repeatedly warned of crisis levels of hunger for nearly two million people.A United Nations-backed assessment last month warned of famine looming in the northern Gaza Strip amid a near-halt in food aid after

Israel launched an offensive in the area.Essential goods like water, fresh produce and medicines are also scarce. Gazans across the territory have told AFP in

recent months how they wake up at the crack of dawn just to ensure they can get some flour or bread, with current availability reaching an all-time low.

In the southern city of Khan Yunis, AFP photographers saw dozens of people at a distribution point, bodies pressed against each other. Over each other's heads, everyone tries to reach out as far as possible to grab the round bread.

them several weeks before the war."There is no flour, no food, no vegetables in the markets," Nasser Al-Shawa, 56, said, who, like most residents, was forced to leave his home because of the bombings and lives with his children and grandchildren in central Gaza.Shawa, who now lives in a friend's house in Deir el-Balah, says a 50kilogram bag costs between 500 and 700 shekels (\$137 and \$192).Before the war, it cost around 100 shekels.Inside Gaza where more than half of the buildings have been destroyed, the production is at an almost complete standstill. Flour mills, warehouses storing flour and industrial bakeries are unable to function because they have been so heavily damaged by

strikes.Bullet to the headHumanitarian aid is trickling in but aid groups have repeatedly slammed the many constraints imposed on them by Israel, which the country denies. In the latest blow, the UN agency supporting Palestinian refugees (UNRWA) announced Sunday it was halting aid deliveries to Gaza via a key crossing point with Israel.UNRWA said delivery had become impossible, partly due to looting by gangs.

For Layla Hamad, who lives in a tent with her husband and seven children in southern Gaza's Al-Mawasi, UNRWA's decision was "like a bullet to the head".She said her family had regularly received "a small quantity" of flour from UNRWA.Every day, I think we will not survive, either because we will be killed by Israeli bombing or by hunger," she said. "There is no third option."The majority of private companies that Israel had in the past allowed to bring in food to Gaza say they are no longer able to do so. The war in Gaza broke out after Hamas's October 7, 2023, attack on southern Israel, which resulted in the deaths of 1,208 people, mostly civilians, according to an AFP tally based on official data.

#### Kadi engineer, others lose Rs 8.58cr to investment fraud

Ahmedabad. A 35-year-old mechanical engineer, Hardik Patel, lodged a complaint with Kadi police against three persons for running a fraudulent investment operation, resulting in losses of Rs 8.58 crore for him and others. The cheating occurred between 2018 and 2023.

In 2017, Hardik relocated with his family to New Shyam Dharti City Society in Kadi. The following year, he encountered Kanaiyalal Patel, a teacher at Shobhasan Primary School, who claimed expertise in tobacco investments. Hardik's initial investment of Rs 4 lakh generated annual returns of Rs 72,000 until 2022. Subsequently, Kanaiyalal, accompanied by his wife Sudha and brotherin-law Kanaiyalal Sankabhai Patel, began seeking investments from various people for property and land ventures. They claimed to invest in Visakha Group projects, Royal Dream Construction, and GIFT City land in Gandhinagar.Believing the notarised agreements and verbal commitments. Hardik and others invested their money. However, the accused failed to honour repayment schedules and offered various excuses.Investigations indicated that the accused utilised the fraudulent funds to acquire properties in Ratanpur and invest in mills across Gandhinagar and Ahmedabad, among other ventures.

According to the complainant, the accused shut their office, became uncontactable, and issued fraudulent notices to avoid repayments. When confronted about the money, Sudha reportedly threatened legal consequences.Initial investigations indicate the accused duped several people of Rs 100-125 crore. The Kadi police have registered the case and begun investigation.

KOCHI. Residents of Pizhala, a small island on the outskirts of Kochi city, have given an ultimatum to the Goshree Islands Development Authority (GIDA) to complete the much-delayed approach road project by December 7, failing which the residents threatened to complete the pending construction work themselves.

our protest, they resumed the construction activities, but it was stopped again two weeks back after the contractor expressed reluctance to proceed with the work as the assistant engineer got transferred," said Arun Augustine, a member of Pizhala Approach Road Action Council.

Meanwhile, the authorities promised to wrap up the project in a week's time during a meeting convened by District Collector N S K Umesh, who visited the site on Sunday.

We were about to carry out the construction work by ourselves from December 3, and even took measures to purchase the raw materials like coal and tar. However, the collector's visit the other day prompted the authorities to suddenly resume the work.

We couldn't even walk through the road earlier but following the collector's visit they levelled the stretch overnight. Hence, we gave GIDA time till December 7, a deadline committed by the authorities in a meeting convened by the collector," said Maglin Phenomena, a resident.

The residents rued that the delay in the work has made their lives difficult. "People are forced to negotiate

## Cyclone Fengal effect: Mumbai's minimum temperature shoots up 7.5°C in 4 days



MUMBAI. Four days after the city recorded the second coldest Nov night in a decade at 16.5°C which also marked the arrival of winter - the minimum temperature rose to 24°C on Tuesday.

The surge was accompanied by overcast skies all through the day. Weather experts attributed the change to cyclone Fengal, which made landfall in Tamil Nadu over the weekend.

They said the cyclone brought moisture to Mumbai and Maharashtra, altering the wind nattern from chilly, dry northerlies to humid east-southeasterlies. The minimum temperature is expected to drop from Dec 8. Tuesday's 24°C at Santacruz observatory was 4° above normal, while the Colaba station recorded

24.5°C, 2° above normal. On Monday, Santacruz logged 20.6°C.

Rain & thunderstorms likely in southwest Maha, KonkanCyclone Fengal has pushed plenty of moisture over Mumbai and Maharashtra and has also changed the wind direction to eastsoutheasterly," said weather enthusiast Athreya Shetty. "Thus, we've seen an increase in humidity and cloudy weather that keeps night temperatures high. The remnant of the cyclone has crossed over and re-emerged in Arabian Sea as a depression off Karnataka coast, which will continue to influence our weather till this weekend.

Amateur weather forecaster Abhijit Modak said the cy clone transitioned into a well marked low pressure system in the Arabian Sea, positioned off the Mangaluru coast. This led to Mangaluru receiving 156mm of rain in 24 hours on Tuesday, accompanied by thunderstorms.

"The system has brought moist easterly winds over Maharashtra, causing a sharp rise in minimum temperatures," Modak said. "As the dry northeasterly winds are replaced by the moist southeasterlies, scattered rain or thunderstorms are likely to occur over southwest Maharashtra and along the Konkan coast over the next three days," he added

bring this vision to life, said sources. Further

action will be taken after approval from Delhi."The initiative not only aims to offer a unique recreational space for Amdavadis but also contribute to biodiversity conservation efforts and environmental education. One of the key highlights of this project is the focus on biodiversity. The parks will showcase a diverse range of tree species and create natural habitats for various animal species. HYDERABAD. # Courts letting ancient sores erupt afresh

WHEN in a hole, stop digging further — thus goes the familiar proverb. After the Ayodhya temple judgments, Indian courts are now sought to be engaged in a frenetic digging up of ancient religious grievances of a similar nature.

The underlying primary assumption is that many mosques were built upon temples that had been demolished by invaders. The second assumption is that notwithstanding the passage of centuries of time, there is today a legal right to restore the old temple by demolishing the existing mosque if necessary. The third assumption is that any court anywhere in India can grant executable decrees of change of character of a place of worship of one faith, to a worshipper of another faith.None of these assumptions was upheld by the five-judge Constitution Bench that passed the Ayodhya verdict. The judgment refutes the claim that a temple was brought down to build a mosque in medieval India. It awards decrees to both religions as having established their rights of worship at the spot. However, using the Supreme Court's special powers under Article 142 of the Constitution, it imposed a majoritarian peace by pushing away the mosque to an alternative site and letting a temple be built on the original site.

Thus, all three assumptions listed above stood legally negated by the judgment that ran into over a thousand pages. Implicit in the judgment was the acceptance that the resolution of the Ayodhya dispute was to be treated as a one-off event and not as a precedent for further claims. However, the message that percolated down to the public was that the Supreme Court had upheld the building of a temple where a mosque once stood. Public perception, therefore, was that all mosques were, henceforth, fair game for conversion.What the courts did soon thereafter only added to the public perception. The Ayodhya judgment had barely been delivered that cases were filed for the conversion of mosques in Mathura and Varanasi. The mosque committees responded that the suits had to be dismissed because the Places of Worship (Special Provisions) Act of 1991 prohibited the change of character of any place of worship that existed as on August 15, 1947. The Act of 1991 had been upheld unanimously in the Ayodhya judgment.

Thus, in the fresh Gyanvapi dispute, when an order of the courts in Varanasi was carried to the SC, the court had an opportunity to nip the trouble in the bud. That was not to be. It was an ill-considered remark by presiding judge DY Chandrachud that the courts could still inquire into what the exact character of the place was on the first day of Independence — that gave a fresh life to the suit and let loose the dragon seeds of fresh hatred.

Running parallel to the Varanasi dispute was the dispute regarding the Eidgah in Mathura. Both suits were allowed by the SC to proceed and work their way through the court system. Some interim orders were also passed, depriving the Muslim side of the use of some portion of the facilities and allowing surveys to be done by the Archaeological Survey of India and various court commissioners. The upshot is that courts are now instruments of an Ayodhyaesque kar seva.

It may well be that the judges of the Supreme Court felt it to be safer for public passions to be expended in the long process of the Indian litigation. They possibly thought that the legal process would help a nation resolve uncomfortable questions from the past. What they did not perceive was that disputes about religious sites are not about religions but about nationalism itself. Are we a nation of unity in diversity or are we a unitarian civilisation?Journalist and author Nilanjan Mukhopadhyay, in his book on Ayodhya, The Demolition and the Verdict, writes: "...'inclusive' or 'multiple sub-nationalisms' (region and religion) were amalgamated into pan-Indian nationalism by the Congress, especially with the advent of Gandhi.

New Delhi has expressed strong concerns about these incidents to Dhaka, saying that the primary responsibility for the safety and security of "all citizens of Bangladesh, including minorities,

rests with the Government of Bangladesh". Developments in the country can be seen in two

ways. First, after the iron hand of Hasina's Awami League government has been lifted, the country is reverting to a situation of semianarchy, with the Islamists and Pakistan's ISI (Inter-Services Intelligence) holding sway and the Hindu minority being persecuted. The second approach would be to consider that Bangladesh is going through a temporary phase in which the country, which did not have real democracy for the past decade, is trying to find its feet under the aegis of an interim government.

angladesh is perhaps the most consequential neighbour of India in South Asia, being 'India-locked' — of its 4,367-km land boundary, just 271 km is with Myanmar and the remaining 4,096 with India. It borders Tripura, Mizoram, Assam, Meghalaya and West Bengal and holds the key to the economic development as well as security of our northeastern region.

Given the nature of the Bangladesh border, it is difficult to completely seal it; as a result, the

policies of various governments of the country have had a vital bearing on our security. India's relations with Bangladesh have seen ups and downs. Beginning with India's role in helping Bangladesh emerge as an independent nation, it has been a rollercoaster ride for bilateral ties as dictators Ziaur Rahman and HM Ershad encouraged the Islamicisation of the country in a bid to maintain their control. As in Pakistan, the Jamaat-e-Islami (JeI) has played a significant role and grown in the process, despite the fact that it fought against the freedom movement of the country.But what happens in Bangladesh is not just about India but the wider region, including China, Myanmar and South-East Asia. The creeping radicalisation of its large Muslim population could have wider global consequences. Besides the JeI, there are other

radical groups, like the Harkat-ul-Jihad-al-Islami and the Jamaat-ul-Mujahideen Bangladesh, as well as elements of the al-Qaeda and the Islamic State. A network of madarsa leaders, Hefazat-e-Islam, too, wants Sharia rule in the country and is opposed to the establishment of a secular polity there. The JeI's alliance with the Bangladesh National Party (BNP), headed by Begum Khaleda Zia, has been a major



problem. As a result, her tenures as Prime Minister in 1991-96 and 2001-06 have been marked by problems arising out of the virtually free rein given to the ISI and the sanctuary provided to an assortment of insurgent groups active against India in the North-East.

The India-Bangladesh relationship stabilised with the establishment of Hasina's government in 2009. Most importantly, it helped check the use of Bangladeshi territory by anti-India elements, be it the ISI or various north-eastern insurgent groups. This led to the reopening of land routes connecting the two nations and signing of the Motor Vehicles Agreement by BBIN (Bangladesh, Bhutan, India and Nepal) to promote regional movement of traffic.China has developed significant interest in Bangladesh both as part of its larger policy of containing India as well as exploiting the country's

location at the head of the Bay of Bengal, next to the Rakhine state of Myanmar, where it has important investments and from where a pipeline carries oil from the port of Kyaukpyu to Yunnan in China, bypassing the Malacca Strait. Beijing has invested large amounts of money in constructing bridges, roads and power plants in Bangladesh and has also emerged as the biggest military supplier to the

country.For many of the reasons cited above, New Delhi needs to handle things with care in Bangladesh. It is true that the situation is extremely volatile and can go out of control, resulting in negative consequences for India. The situation is compounded by the fact that the ISI is likely to be working overtime to impose an anti-India narrative on the popular movement there.

ndia needs to draw lessons from its successful handling of strained ties with neighbours recently. By providing financial succour to Sri Lanka during its economic crisis, it has bought considerable goodwill, which is paying dividends with the government of Anura Kumara Dissanayake. Likewise, by calmly dealing with President Muizzu of Maldives, New Delhi has managed to blunt his "India out" strategy.

Similar dividends are visible in Nepal — the nominally anti-India Prime Minister

KP Sharma Oli, who is on an official visit to China, had made it clear beforehand that his country would not sign any new loan agreement with Beijing under the Belt and Road Initiative (BRI). Indeed, the Nepalese want to sign a new agreement with China that will narrow the scope of BRI in their country.

With Bangladesh, too, India needs to adopt a policy of strategic patience. Bangladesh is a country in transition. New Delhi needs to support the process of restoring democracy there. There has been a tendency to exaggerate the attacks on Hindus. After an initial upsurge, such attacks have come down. We also must understand that our one-sided support to Hasina has resulted in suspicion about our motives and there is need to provide a corrective to our Bangladesh policy.

What holds back Punjab's draft agricultural policy

## IAM often asked about my tenure as the Chairman of the Punjab State Farmers' & Farm Workers' Commission (April 6, 2017-September 20, 2021). On the very first day, without even a hint of guidance on what my work entailed, flummoxed...

IAM often asked about my tenure as the Chairman of the Punjab State Farmers' & Farm Workers' Commission (April 6, 2017-September 20, 2021). On the very first day, without even a hint of guidance on what my work entailed, flummoxed but undeterred, I sent a letter to the Department of Agriculture, asking it to provide information on pesticide, seed and fertiliser sample failures in the state.

The data — that would have taken a few hours to put together in the private sector — took two years of dogged perseverance and persuasive cajoling to get. It took six months just to get an officer from the department to assist the commission in its work. Having never worked in the government, the chase taught me a vital lesson: the real problem is not the government, it is the bureaucracy. That was lesson number one.o cut the long story short, the commission found many instances of pesticide, fertiliser and seed sample failures where no cases had been filed for the past 10 years or had been timebarred. Consequently, around 150 officers were charge-sheeted. I was informed that the officers had threatened to go on strike. However, the commission's aim was not to penalise anyone, which it ensured, but thereafter, compliance become 100 per cent.The same happened a little later when we proposed that the government create a price stabilisation fund for milk, food and vegetables by imposing a 20 per cent fee on the charges received by the arhtiyas for the procurement of grains for the FCI. The arhtiyas arrived, flexing their muscles. I told them that if they were to agitate at my doorstep, it would do good for the commission's image. However, they easily convinced the government to

ignore my advice.nitially, different departments were to brief me on their working and issues so as to understand how the system worked. Instead, the commission decided to visit all departments and meet the officers and junior staff in their respective offices. It proved to be an eye-opener. It led to the next

awakening: "inept governance" holds back progress. Consequently, in the draft agricultural policy, the first chapter is on 'governance'. It was the first-ever policy of any kind to identify governance as a problem and a solution. It was not palatable for many but, with time, my stand was vindicated. The commission only has an advisory role. Yet, I have regrets — not for the work I did, but about the decisions I did not make or was dissuaded from taking. It is hard to quantify all the work in brief here, but some laws that got enacted during my tenure were pathbreaking. I was doubtful that the then state Chief Minister, Capt Amarinder Singh, would agree to banning truck unions, but his administrative acumen being outstanding, truck unions were

banned. Though they kept operating in some places like Bathinda. That was the third learning: never be afraid to punch above your weight. On regulating the electricity subsidy to the economically better farmers, the CM was persuaded by his office not to tread the politically contentious path, even though the farmers' unions had concurred with this suggestion.

I must acknowledge that farmers' union leaders were supportive of the commission's efforts in policy formation. Making the draft of Punjab state farmers' policy taught us the fourth valuable lesson: a transparent consultation process is a fundamental requirement for achieving positive policy outcomes. Additionally, we ensured that Punjab banned the sale of herbicide glyphosate, the only state to do so.




measly Rs 2,000 per acre for supporting agriculture. On finding out that the land was not being used for the purpose, the commission submitted a report on the issue, based on which the group returned the land without litigation to the state. That was the fifth takeaway: success is only possible if one works as a team as the commission did; not as individuals.

My own experiences derived from my farm at Abohar helped me in my work at the commission. Agriculture college students train at our farm as a part of their degree course. Their practical knowledge is left wanting in many aspects. After joining the commission, I was shocked to learn that unlike medical colleges that are regulated by the Union Government, agriculture colleges were not regulated. Agriculture is a state subject and the state did not have any such law. On the commission's suggestion, the state government enacted the Punjab State Council

for Higher Education Act 2017.Out of the 112 colleges in the state, the Punjab State Council for Higher Education (PSCAE) asked students to avoid taking admission in colleges offering BSc (agricultural) which were not fulfilling conditions under the Act. It also released a list of the institutes that complied with the minimum standards prescribed. The list had only 15 names.The farm experience had also taught me about the difficulty of viably operating a greenhouse. We decided to list each greenhouse subsidised by government agencies. To its shock, the commission documented that over 90 per cent greenhouses had stopped operating within three to four years.There were many other

such instances. The commission had a similar experience on the suo motu inquiry report on canal water pollution in the Beas river from the Chadha distillery spill. The sixth learning was that the system tends to turn a blind eye to failures and evidencebased research should influence the policy and action. We, thus, recommended that actual beneficiaries be allowed to assess the programme outcomes. When the commission reached out to district headquarters to follow up on the rehabilitation of families affected by farmers' suicide, it found that, like other laws, it was not even on their agenda.

## Security remains 'unsatisfactory' at Delhi hospitals: AIIMS RDA chief

NEW DELHI. Months after junior doctors across the country went on strike following the brutal rape and murder of a female colleague in Kolkata, security measures at Delhi's government hospitals remain inadequate. The tragic incident sparked nationwide outrage and calls for a central law to protect healthcare workers, alongside demands for better security, workplace conditions, and swift legal action against those who harm medical professionals.

- In Delhi, the Resident Doctors Associations (RDAs) of seven government hospitals led the protests. However, despite several promises from authorities, doctors continue to express dissatisfaction with the progress made."The improvement in security measures is far from satisfactory, even after four months," said Dr Rajat Sharma, president of the RDA at Guru Teg Bahadur (GTB) Hospital. Recent incidents highlight the risks healthcare workers still face.At Safdarjung Hospital, an IPS officer verbally assaulted a resident doctor, while at GTB Hospital, a crowd barged into the duty room and threatened to kill a medical intern.
- 'Just a few days ago, the administration fast-tracked a proposal to enhance security measures, but only after repeated reminders. This reflects their lack of seriousness in addressing workplace violence," Dr. Sharma added.
- Dr Sarada Prasad Sahoo, president of the RDA at Lady Hardinge Medical College, echoed similar concerns. While there has been a slight increase in the number of security guards, key demands, such as the deployment of marshals or bouncers in high-risk areas, remain unmet, said Sahoo."Merely increasing guards isn't enough. We have consistently asked for marshals, CCTV cameras, well-lit corridors, and female security staff for women doctors. Yet, the authorities' standard response is, 'the file is in process,'" the doctor added.Doctors continue to call for decisive action to ensure their protection, emphasizing that their ability to save lives depends on working in a safe and secure environment.



The ponds in question include Shangushar, Guga, Johdi, Guhli, and the historic Shishuwala Talab. The NGT had ordered a joint committee of the Central Ground Water Authority, Delhi Pollution Control Committee, and District Commissioner, West Delhi, to report on the issue.

NEW DELHI. Finance minister Nirmala Sitharaman on Tuesday said the Indian banking system is critical to the growth of the nation and the government in the last 10 years has been extremely cautious so that banks remain stable."The intention is to keep our banks remain stable. The intention is to keep our banks safe, stable, healthy, and after 10 years you are seeing the outcome," the finance minister said while replying to a debate on the Banking Laws (Amendment) Bill, 2024 in Lok Sabha.Today the banks are being professionally run, the public sector banks are safe, stable and healthy, and have performed avantionally wall in recent wars. Sha performed exceptionally well in recent years. She added that the metrics of the banks are healthy so they can go to the market and raise bonds, raise loans and run their business accordingly.

She informed the lower house of parliament that total bank branches of scheduled commercial banks have increased by 3,792 in a year to reach 16,55,001 in September 2024. Out of this 85,116 branches are of public sector banks.

#### 5.5 million customers port numbers to BSNL after private telcos hiked tariff

**NEW DELHI.** Nearly 5.5 million mobile users (till October 2024) ported their numbers to the stateowned Bharat Sanchar Nigam Limited (BSNL) after the tariff hikes announced by private telecom service providers in June 2024.

As per data from the Department of Telecommunications (DoT), there was a major rise in customer migrations from other telcos to BSNL from July to October 2024 period. In July 2024, BSNL saw 1.5 million users joining its network from Reliance Jio, Bharti Airtel, and Vodafone Idea (VIL). This number rose to 2.1 million in August, 1.1 million in September, and 0.7 million in October 2024.In contrast, BSNL experienced only 63,709 port-ins in June 2024, prior to the tariff hikes. At the same time, the number of customers leaving BSNL to switch to other networks had been higher in June 2024, with nearly 0.4 million users porting out. Following the tariff hikes, the rate of customer churn significantly decreased. By July 2024, only 0.31 million users left BSNL, and this number further dropped to 0.26 million in August, 0.28 million in September, and 0.51 million in October 2024.

Overall, the number of customers joining BSNL far outpaced those leaving the network during this period, with many consumers opting for the staterun operator. Additionally, BSNL experienced a surge in new SIM card sales. The company sold just 790,000 SIM cards in June 2024, but this number jumped to 4.9 million in July 2024, 5 million in August 2024, 2.8 million in September, and 1.9 million in October 2024.Meanwhile, the telecom industry saw a decline in subscriber numbers. As per the Telecom Regulatory Authority of India (TRAI), telcos collectively lost 10 million users in September 2024. Jio lost 7.9 million, Airtel lost 1.4 million, and VIL lost 1.5 million subscribers during the month. Robert Ravi, Chairman and MD of BSNL, stated that the company has no plans to increase its tariffs in the near future.

# IndiGo takes Mahindra to court over use of '6e' name

NEW DELHI. IndiGo has filed a trademark infringement suit against Mahindra Electric Automobile, objecting to the latter naming its upcoming EV as BE 6e as "6E" is the airline's flight code. Mahindra launched the electric car on Nov 26, with company officials insisting then there is no copyright infringement with use of 6e.Indigo went to the court within days. Titled Interglobe Aviation (IndiGo parent) vs Mahindra Electric Automobile, the case was on Tuesday listed to be heard in the court of Justice Amit Bansal. However, the judge recused himself from hearing the matter. The next hearing is scheduled for Dec 9. Appearing for IndiGo, senior advocate Sandeep Sethi informed the court that Mahindra had initiated discussions with the airline to address the issue.In a statement, IndiGo said: "6E mark is an integral part of IndiGo's identity for the past 18 years and is a registered trademark that holds strong global recognition. The 6E mark,



whether standalone or in its variants and formative forms, is extensively used by IndiGo for its offerings and for goods and services provided in collaboration with trusted partners."The airline further said, "Any unauthorised use of the '6E' mark,

whether standalone or in any form, constitutes an infringement of IndiGo's rights, reputation and goodwill. IndiGo is committed to taking all necessary and appropriate steps to safeguard its intellectual property and brand identity." Mahindra said it revealed EV SUVs - the BE 6e and XEV 9e - late last month. "Mahindra has applied for trade mark registration under class 12 (vehicles) for 'BE 6e' a part of its electric origin SUV portfolio. We hence don't see a conflict as Mahindra's mark is 'BE 6e,' not the standalone '6E.' It differs fundamentally from IndiGo's '6E,' which represents an airline, eliminating any risk of confusion..." The distinct styling further emphasises their uniqueness. We have taken on board the concerns that InterGlobe Aviation Limited have to infringement of their goodwill, which was not our intention. We are engaged in discussions with them to find an amicable solution."This

is the second time IndiGo is locked in a legal battle with some other company using a name associated with it. In 2015, the airline had a trademark dispute with Tata Motors which then used to sell its sedan under the name IndiGo.

## Swiggy likely to increase delivery charge on Instamart orders: Report

NEW DELHI. Food and grocery delivery platform Swiggy is considering increasing the delivery fees for its quick commerce arm, Instamart, reported moneycontrol.com.The move aims to improve profitability, according to Chief Financial Officer (CFO) Rahul Bothra, who discussed the plan with analysts after the company announced its Q2 FY25 results on December 3.

Currently, Swiggy subsidises delivery fees through its loyalty program, Swiggy One, and discounts for new users. While delivery is free for Swiggy One members, other customers pay a dynamic fee. Bothra indicated that the company plans to raise these charges



gradually but did not specify a timeline. The competitive quick commerce sector includes players like Zomato-owned Blinkit and Zepto. Unlike Swiggy, Blinkit does not offer free delivery for any orders, while Zepto waives fees for loyalty program members.Bothra also highlighted additional measures to boost margins,

including increasing platform fees for food delivery orders and monetising Instamart through advertisements.

Swiggy has already raised its platform fee fivefold, from Rs 2 to Rs 10 per order, in the past 18 months. The company intends to improve its take rates (commissions) for Instamart from the current 15% to 20-22%.Instamart recorded adjusted revenue of Rs 513 crore in Q2 FY25, more than double the Rs 240 crore earned in the same period last

year. However, it still trails Blinkit, which reported revenue of Rs 1,156 crore during the quarter.

At the company level, Swiggy's revenue rose 30% year-on-year to Rs 3,601.5 crore for Q2 FY25, while its losses narrowed to Rs 625.5 crore from Rs 657 crore a year earlier.

## NTPC Green Energy shares climb 44% post-listing. What's driving the rally

NEW DELHI. Shares of NTPC Green Energy, a subsidiary of NTPC Limited, have witnessed a commendable surge in prices since their listing.

The stock, which debuted on the stock exchanges on November 27, has climbed steadily and is now trading 44% higher than its IPO price of Rs 108, with a fresh all-time high of Rs 155.35 per share on December 4. NTPC Green Energy shares had hit the 10% upper airwit limit in the proving hit the 10% upper circuit limit in the previous session.NTPC Green Energy shares were trading at Rs 147.45, up 3.76%, at the time the article was being written.Despite starting off modestly on its listing day, NTPC Green Energy shares have quickly gained momentum in subsequent trading sessions. Analysts attribute the rally to the company's strong fundamentals and its prominent position in India's renewable energy sector, which is poised for good growth.

#### Market To Reach Rs 67 Lakh Cr By 2030, Demand At 31.2 Mn Units

India's Affordable Housing

New Delhi. India's affordable housing market is projected to reach Rs 67 lakh crore by 2030, with cumulative demand likely to be 31.2 million units, a report showed on Wednesday. The existing shortage as well as upcoming demand for the affordable housing segment in India is estimated to be 30.7 Mn units by 2030 and the opportunity to finance these units is calculated to be Rs 44 lakh crore, according to the report by Knight Frank India and CII.

- Led by factors such as urbanisation and employment opportunities, 22.2 million units of housing will be required in urban centres in the country. Almost 95.2 per cent of this demand, equivalent to 21.1 million units, will be concentrated in the affordable housing segment, the report mentioned.
- A predominant share of 45.8 per cent of the demand will be concentrated among the economically weaker section (EWS) households as there is already an existing shortage of 10.1 million units. The current portfolio of the affordable housing loan market in India is estimated to be Rs 13 lakh crore, with Housing Finance Companies (HFCs) constituting Rs 6.9 lakh crore and Scheduled Commercial Banks (SCBs) holding a share of Rs 6.2 lakh crore.
- 'As urbanisation accelerates and income levels rise, affordable housing is positioned to play a pivotal role in shaping the country's real estate landscape," Knight Frank India Chairman and Managing Director, Shishir Baijal, said.
- Addressing this demand will require innovative strategies, including public-private partnerships, policy interventions, and advancements in construction technologies, making affordable housing not just a social imperative but also a critical driver of economic growth, he added. The loan market in this category is anticipated to experience significant expansion due to the escalating potential demand for affordable housing. The issue was priced at the upper end of the price band (Rs 70 per share) and Rs 44.87 crore was raised through the issue.

After the closure of the issue and allotment of shares, a complaint was received by

Welfare Association - SIREN which alleged that the objects of the issue by the company included purchase of software valued at Rs 17.70 crore from a vendor which had questionable financials and failed to file its annual financial statements with the Ministry of Corporate Affairs. The BSE then in consultation with the SEBI deferred the listing of the shares of the company."Based on the findings, it is reasonable to conclude that the third-party vendor (TPV) in question is a 'shell entity'. significant blow to New Zealand's campaign.Ben Stokes' Insta storyA points deduction has pushed the inaugural WTC champions down from joint fourth to fifth place in the standings, leaving them with a reduced points percentage of 47.92%. Even if New Zealand secures wins in both of their remaining Tests against England, their maximum possible points percentage rises to just 55.36%. This leaves the Black Caps in a precarious position, needing more than just back-to-back victories. They must rely on favorable outcomes in other matches to keep their slim hopes of reaching the final alive, making their path to qualification a daunting one. The penalties arose as both sides were found to be three overs short of the target after accounting for time allowances. Under competition rules, teams are penalized one championship point for each over they fall short.Captains Tom Latham (New Zealand) and Ben Stokes (England) admitted to the offense and accepted the sanctions, negating the need for a formal hearing.
