

cuts GDP forecast to 6.6% Sanjay Kumar

New Delhi, Dec. 6: The Reserve Bank of India on Friday decided to keep the policy rate unchanged for the 11th time in a row but sharply

lowered the GDP growth forecast to 6.6 per cent for the current fiscal, as against earlier projection of 7.2 per cent. The Reserve Bank of India (RBI) maintained the status quo on interest rate despite July-September quarter GDP growth falling to 7quarter low of 5.4 per cent, as against its own projection of 7 per cent. The rate increase cycle was paused in April last year after six consecutive rate hikes, aggregating to 250 basis

points since May 2022. Announcing the fifth bi-monthly monetary policy for the current financial year, RBI Governor Shaktikanta Das said the Monetary Policy Committee (MPC) has decided to keep the repo

rate unchanged at 6.5 per cent while keeping policy stance unchanged at neutral. He said MPC will remain watchful of incoming macroeconomic data for future action. The RBI sharply cut the GDP growth projection to 6.6 per cent from the earlier level of 7.2 per cent, while raising inflation target to 4.8 per cent from the previous projection of 4.5 per cent for the current fiscal. In a bid to

make available more money with banks for lending so as to boost economic activity, the RBI slashed Cash Reserve Ratio to 4 per cent from existing 4.5 per cent. This would lead to release of Rs 1.16 lakh crore to banks and improve their lending capacity. The CRR is the percentage of a bank's total deposits that it is required to maintain in liquid cash with the RBI.

Modi govt will purchase all farm produce at MSP: Shivraj Singh Chouhan



New Delhi, Dec 06: Union Minister Shivraj Singh Chouhan speaks in the Rajya Sabha

during the Winter session of Parliament, in New Delhi, The Narendra Modi government will purchase all farm produce at minimum support price, Union Agriculture Minister Shivraj Singh Chouhan said in Rajya Sabha on Friday. He gave the assurance while answering supplementaries during Question Hour on the issue of MSP to farmers. The assertion came on a day when farmers embarked on a foot march to Delhi with a charter of demands, which includes a legal backing to MSP. "I want to assure the house through you that all produce of farmers will be purchased at minimum support price. This is the Modi government and the guarantee to fulfil Modi's guarantee," Chouhan told the house. 'When our friends from the other side

were in power, they had stated on record that they cannot accept the M S Swaminathan Commission recommendations, especially on giving 50 per cent more than the cost of produce. I have the record," he said. He cited former MoS Agriculture Kantilal

Bhuria, Agriculture Ministers Sharad Pawar, and decided to calculate the minimum support price by K V Thomas to back his claim. After his remarks, Chairman Jagdeep Dhankhar asked him to place



on record the documents to substantiate his claim, which Chouhan agreed to. "They have never honoured the farmers and never gave a serious consideration to farmers' demands for remunerative prices. I want to assure the house through you that since 2019 Prime Minister Narendra Modi has giving 50 per cent profit on cost of production to farmers," the minister claimed. He also claimed

the Modi government is already giving remunerative prices to farmers, saying that paddy wheat, jowar, soyabean were being purchased at 50 per cent above the cost of production from three years ago. He also cited intervention in changing export duties and prices whenever rates of commodities fall. Asked by Congress member Jairam Ramesh on his thoughts on MSP, Chouhan said, "I have a clear thought about MSP. We will fix MSP at more than 50 per cent profit and purchase the produce of farmers too." He added, "You did not purchase the farmers' produce, we will purchase that and fix higher MSP... When Congress was in power, they never purchased farmers' produce at MSP and farmers shed tears of blood, but for me 'kisan ki sewa' is like 'bhagwan ki pooja'."

Ramesh then recalled the words of the Chairman. who holds a constitutional post, to the minister to speak to farmers on MSP Chairman Dhankhar said he had travelled with the agriculture minister and was assured of his commitment towards farmers.

Rajya Sabha grapples with a suspicious bundle of currency found on Abhishek Singhvi's seat

New Delhi, Dec 06: The information regarding the suspicious bundle, detected by Parliament security during a routine anti-sabotage drill in the House, was shared with MPs by Chairman Jagdeep Dhankhar. The House of Elders found itself grappling

Dhankhar said during routine anti-sabotage checks after the adjournment of the House yesterday, a wad of currency notes was recovered by security officials from seat no. 222 allotted to Congress's Singhvi, elected from Telangana for the term from 2024 to 2026. "The matter was brought to my notice and I felt it expedient as per practice to ensure investigation takes place in accordance with the law and the same is under way. "It was my duty and I am obliged to inform the House.



Kharge dissolves entire **Uttar Pradesh Congress unit** ST Correspondent

Dec 06: Congress President Mallikarjun Kharge during a press conference, in New Delhi, Thursday, Feb. 8, 2024.Congress president Mallikariun Kharge has dissolved the pradesh, district, city and block committees of the party's Uttar Pradesh unit with immediate effect. The move came late last night, months after the Lok Sabha polls and days after bypolls in the state in which the Congress did not field any candidates, supporting the Samajwadi Party and INDIA bloc allies in the nine Assembly seats. Apparently, the move to dissolve the party units in the state is aimed at restructuring the party organisation

India asks Pakistan to take strong action against Masood Azhar

New Delhi, Dec 06: India on Friday demanded strong action from Pakistan against Jaish-e-Mohammed chief Masood Azhar, after a report emerged that he delivered a speech recently at a public gathering in Bahawalpur. Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal said if the report is correct, it has exposed Pakistan's "duplicity" in containing terrorist activities. "We demand that strong action be taken against him (Azhar) and he should be brought to justice. There has been denial that he is not there in Pakistan, Jaiswal said. "If the reports are correct, then it exposes the duplicity of Pakistan. Masood Azhar is involved in cross-border terror attacks on India and we want that strong action be taken against him," he added Jaiswal made the remarks in response to a question at his weekly media briefing.

march to Delhi on Sunday

New Delhi, Dec. 6: Protesting farmers on Friday suspended their march to Delhi for the day after a few of them suffered injuries due to teargas shells lobbed by security personnel,

according to farmer Punjab Sarwan leader Singh Pandher. Six protesters were injured on Friday Haryana after Police and paramilitary forces lobbed teargas shells at agitating farmers at

the Shambhu border. Teargas shells were fired by the security personnel after the protesters were heading towards the barricades at the border. A group of 101 farmers, named 'Marjeevda Jatha', began its foot march to Delhi from their protest site at the Shambhu border, but was stopped a metres away by a multilayered barricading. Citing prohibitory order clamped under Section 163 of the Bharativa Nagarik Suraksha Sanhita. Harvana Police asked farmers not to proceed further. Meanwhile, Delhi Police have tightened security at borders ahead of the farmers' march to the National Capital. The farmers are marching to force the Centre for a legal guarantee for minimum support price for crops.

Civil society asks Parliament to discuss pollution

New Delhi, Dec. 6: A petition highlighting India's worsening air pollution crisis was submitted in Parliament on Thursday, in which civil society members called on the lawmakers to convene a joint session to address the issue. The petition sought immediate measures to address what it described as an "unprecedented environmental and public health disaster". Clean air is a fundamental human right under Article 21 of the Constitution, which guarantees to life, it said, adding that deteriorating air quality in North India, particularly in Delhi-NCR, posed a grave threat to this right. The petition addressed to all the members of Parliament claimed that according to the Central Pollution Control Board (CPCB), Delhi's Air Quality Index (AQI) has remained in the "poor" or "very poor" category since September 2023, with "hazardous" levels of 1,500 to 2,000

also outlined the "devastating" impact of air pollution on public health, citing data that attributes 1.7 million deaths annually in India to pollution-related problems, accounting for 18 per cent of all fatalities.



In Delhi, the average life expectancy is reduced by up to 12 years due to pollution, while across the country, 3.57 years of life expectancy is lost to air pollution, surpassing the gains of curing all cancers,

recorded during the winter months. It the petition claimed. The health of children is particularly at risk, with 30 per cent of Delhi's kids suffering irreversible lung damage, according to a 2022 report by the Lung Care Foundation, the petition said. The petition also highlighted the

enormous economic toll of pollution, which it claimed is costing the country Rs 77 lakh crore annually, equivalent to 3 per cent of its GDP. This financial burden is twice the nation's public health expenditure, driven by premature deaths and illness caused by toxic air, the petition claimed. It also identified the key contributors to the pollution crisis in Delhi-NCR, including perennial sources such as vehicular emissions, construction dust, indus-

trial pollution, and open burning of garbage. Episodic sources like stubble burning and firecrackers during festivals further exacerbate the problem, it said. Highlighting these issues, the petition called for a joint session of both the Houses in Parliament to formally recognise air pollution as a national crisis. It also demanded the strengthening of the Air (Prevention and Control of Pollution) Act, 1981, with stricter standards for pollutants, enhanced air quality monitoring, and tougher penalties for violators. Batting for empowering the pollution control boards with additional resources and authority, the petition suggested the formation of a joint parliamentary panel to oversee the reforms and implement legally-binding air quality targets. The petition also recommended establishing a dedicated healthcare fund to address the medical consequences of pollution, urging the government to formulate a multi-ministerial strategy to combat the crisis. Emergency measures, such as promoting regional public transport, providing incentives to farmers to prevent stubble burning, and mandating cleaner vehicle standards, were also stressed in the plea.





NEWS BOX New Gunadala railway station set to commence

commercial ops soon

VIJAYAWADA. The under-construction Gunadala Railway Station, part of the South Central Railways' (SCR) Vijayawada division, is being developed swiftly under the Amrit Bharat Station Scheme (ABSS). Railway officials led a media tour on Thursday to highlight the project's progress and amenities.Additional Divisional Railway Manager (Infrastructure) PE Edwin and Gati Shakti Deputy Chief Engineer PV Ramana Rao briefed reporters on the developments.

Approximately 25% of the construction is complete, including platform extensions, waiting halls, modular toilets, and BiPV solar panels. Officials aim to finish the project at high speed to aunch commercial operations soon. The station's upgrade, with a cost of Rs 35.5 crore, aims to transform Gunadala into a satellite station to reduce congestion at Vijayawada Junction. The station, previously used only for operational purposes, is being developed to hadl increased passenger traffic.During the media tour, officials showcased ongoing infrastructure work, including roof-mounted BiPV solar panels. These will make Gunadala an energyneutral station, capable of sustaining its electrical needs.

Future plans include expanded passenger facilities and enhanced infrastructure to accommodate growing demand.Officials emphasised that the development aligns with Prime Minister Narendra Modi's vision under the ABSS, which targets the upgrade of 22 stations in the division. Gunadala's strategic location will enhance regional connectivity, benefiting commuters and boosting the local economy. The project focuses on providing modern passenger amenities such as spacious waiting halls, improved flooring, and platform covers.

Sathanur Dam flood alert failure? Tiruvannamalai villagers left in chaos after sudden release

TIRUVANNAMALAI. The sudden release of water to the tune 1.8 lakh cusecs from Sathanur dam in Tiruvannamalai district on Sunday night may have triggered the flooding in many areas along the Thenpennai river in Tiruvannamalai, Villupuram, and Cuddalore districts, but lack of specific details about the level of flooding or pointed instruction to move to designated relief shelters, during the initial hours of the calamity, seem to have put the residents to avoidable trouble.hile the Tamil Nadu government had said that it did everything as per the standard operating procedure and alerted the people along the banks of the river, a visit by TNIE to many of these villages showed that a majority of the residents either did not receive proper alerts or the communication was insufficient.N visited Puthur Chekkadi, Rayandapuram, Thiruvathanur, and Kolamajanur villages, all of which were included in the fifth and final flood warning sent by the Assistant Executive Engineer of Sathanur Dam Sub-Division of Water Resources Department in the early hours of Monday to the Tahsildars of Thandarampet, Chengam, Tiruvannamalai and Tirukoilur taluks.All these villages were affected in the floods. Most of villagers said that this was the worst flooding they have seen in their living memory, while some of the elderly people



recalled a similar flooding in the early 1970s.S Venkatesan from Puthur Chekkadi, which is home to over 500 houses, said that only a few people in the village received SMS alerts from the Tamil Nadu State Disaster Management Authority, that too on Monday morning, when the village was already flooded. The message read, "Water is being released from Sathanur Dam. People living on the banks of Thenpennai river are advised to move to safer places."He further said that the village did not receive any alert over the four days preceding the flooding by any revenue official about the possibility of release of water. We had to rely on neighbours and our personal social networks to secure ourselves on Sunday night."Despite our efforts, the flod caused extensive damage," he told

TNIE.Residents of Rayandapuram, which has around 100 houses, said they received alerts between November 25 and November 30, but alleged that the warnings lacked specific details or pointed instructions to move to any designated relief shelter."They asked us to move but there was no mention of the extent of possible flooding. After witnessing the intensity of the rainfall on Sunday, we predicted the worst and shifted. However, there was no specific warning about release of such a huge quantity of water on Monday morning," said Ramaraj R, a 32-year-old resident of Rayandapuram. The lack of alerts has left many villagers devastated, especially since they were unable to save their cattle, one of their primary sources of livelihood.

Five years on, Srinivasapuram tenements' reconstruction proposal gains momentum

CHENNAI. In the wake of 22-year-old S Syed Gulam's death, the proposal to reconstruct TNUHDB Srinivasapuram tenements has again gained momentum. This structure was one of the 61 scheme areas recommended for reconstruction by a technical committee, considering their age and waning structural stability. However, even five years after the recommendation was made by the panel, no headway was made. Sources said after the technical team recommended the reconstruction of all 1,356 tenements in Srinivasapuram, a Central Sanctioning & Monitoring Committee (CSMC) approval was obtained under PMAY (U)-Housing For All (HFA) programme in 2019 for rebuilding the area with an additional 660 houses at a cost of Rs 262.08 crore. The project was later dropped and officials attributed the decision to resistance from families."There was resistance from the families, who were opposed to shifting to the high-rise structures that were proposed to be constructed as they



were used to a maximum of G+4 blocks. They also wanted the additional 660 houses to be allotted to their heirs instead of outsiders," an official said. Hence, the proposal was dropped and the CSMC was suitably notified in 2020. Officials said that following Syed Gulam's death on Wednesday night, the residents have become more receptive to the reconstruction proposal. "We will begin biometric enumeration of the houses on Monday and complete it in the next two days," an official said. The reconstruction is expected to be completed in about 18 months. The residents are entitled to a one-time shifting allowance of Rs 24,000.

The officials have now assessed a requirement for 3,000 houses, including units for 1,000 'encroachers' residing in temporary structures and huts. The Srinivasapuram scheme now has 1,356 tenements in 68 blocks in the G+1, G+3 and G+4 categories. According to TNUHDB records, the construction of these tenements began in 1972 and ended in 1977. Meanwhile, the state government in a press release said that eviction notices were issued to the residents in January and March 2022. Further, several rounds of discussions were held with residents in September and November 2024. However, no consensus was reached in these discussions regarding their eviction and reconstruction of tenements.

Construct check dams on Chinnar river basin to address water scarcity': Palacode residents

DHARMAPURI. Residents of P a l a c o d e u r g e d t h e administration to construct more check dams in the Chinnar rier basin to address water scarcit.

Chinnar is a rain-fed river which flows across Palacode and Pennagaram taluk. It has its water c a t c h m e n t a r e a s i n Bettamugilalam, Namagiri , Perungadu and Sastri Mutlu hills in the district and reaches the Chinnar dam. Every year the surplus water drains into Cauvery River. Citing this, r e s i d e n t s u r g e d t h e administration to construct more check dams in the Chinnar river basin and store water.

S Arumugam, a resident of Palacode, said, "Chinnar water flows all the way to Dharmapuri feeding dozens of water bodies in Palacode, Pennagaram and Dharmapuri. During heavy rain, most of the water in the river drains into the Cauvery and becomes unusable. To ensure that this water benefits the farmers in



Palacode, we urge the administration to take steps to construct more check dams wherever possible."

Another resident R Kumar said, "Right now, the Chinnar river is not the only river that is revived by the rains from Fengal. Thollagathu river which drains into the Chinnar has also revived, these waters are wasted every year. During summer farmers are not able to irrigate sugarcane, banana plantations. The administration must take steps to identify such water bodies and build check dams to store more water."he said.

Officials in the PWD (WRD) department said they assured to look into the matter.

Odisha HC grants bail to Mob assaults family, stakes claim to property in Whitefield, Bengaluru

BENGALURU. There was high drama in front of a sprawling house on Borewell Road in Whitefield, with a group staking claim to a large piece of property,

Educational institutions exempt from Consumer Protection Act: SCDRC

THIRUVANANTHAPURAM. Students' grievances against educational institutions, except coaching institutes, will not come under the purview of the Consumer Protection Act, the State Consumer Disputes Redressal Commission has ruled. The SCDRC set aside an order passed by the



Kasaragod District Consumer Disputes Redressal Commission against a Bengaluru-based dental institute. The SCDRC's order came on an appeal filed by the Karnataka Examinations Authority (KEA) against the district commission's order. It was based on a petition by a Kasaragod student alleging a deficiency of service on the part of a dental institute in Bengaluru. The case followed a dispute between the student and the institute over relieving him from the institute after he secured admission at another institution.

In its order, the district commission directed the institute, which was the second opposite party in the case, to refund an amount of Rs 52,500 and pay Rs 10,000 as compensation.

CUTTACK. The Odisha High Court on Wednesday granted bail to four persons on a condition that they must plant 50 to 100 saplings and maintain them for two years. The single judge bench of Justice SK Panigrahi passed the orders on bail petitions filed by Soumya Rajan Palai accused of attempt to murder, Purnanda Nayak accused of rape, cheating and extortion, Budhadev Das accused in case of his wife's murder and Nirmal Sana accused in an NDPS case. The criminal cases against them are pending in courts at Tangi, Bhubaneswar, Keonjhar and Malkangiri respectively. Justice Panigrahi directed these courts to release them on bail on stringent terms and conditions."The petitioner shall plant saplings (50 in two cases and 100 in the other two) of local varieties like mango, neem, tamarind, etc. around his village over government land/community land/private land, if it is in the possession of the petitioners or their family members," said Justice Panigrahi in identical orders on the four petitions."Violation of the above condition shall entail cancellation of the bail. The inspector-in-charge of the police station concerned in coordination with the local forest officer shall monitor whether the petitioner has planted the saplings or not," Justice Panigrahi also specified in the orders.Justice Panigrahi further directed the petitioners "to file before the local police station affidavits after plantation of the saplings assuring that they will maintain those plants for two years". The cases were registered at Tangi police station (2024), Mahila police station, Bhubaneswar (2023), Turumunga police station (2024) and Malkangiri police station (2020).

Last-mile connectivity: The key to unlocking Metro Rail's potential

BENGALURU. Urban mobility is at the heart of building resilient and sustainable cities. The MAP (Multisectoral Actions Pathways) Declaration for Resilient and Healthy Cities, launched at COP29, underscores the urgent need for multilevel and multisectoral action to combat climate change in urban areas.

his declaration highlights urban sustainable transport as a critical area for collaboration, alongside climate resilience, green construction and urban climate finance.At the High-Level Opening on Multilevel and Multisectoral Climate Action, global leaders emphasized the transformative potential of integrating climate action into city planning, with COP29 President Mukhtar Babayev, Azerbaijan's Minister for Ecology and Natural Resources, highlighting the MAP Declaration as a catalyst for cross-sector collaboration. Among these efforts, investments in public transport - particularly metro rail systems - have emerged as a cornerstone of sustainable urban development.India, for example, has invested over \$25 billion in metro systems since 2010, spanning 17 cities with nearly 1,000 kilometers of operational networks. However, the success of metro systems depends on more than the network itself. Seamless access to and from the metro (lastmile connectivity) is essential to ensuring that the benefits of these systems are fully realized.A WRI India study shows metro users predominantly rely on walking or lowcost shared last-mile modes, reflecting their high price sensitivity.hile on-demand options like ride-hailing services are available, their higher costs make them unviable for a significant portion of commuters. Instead, shared paratransit modes such as autorickshaws and shared erickshaws play a crucial role in bridging the



gap.WRI India research highlights that metro systems like Bengaluru's Namma Metro face some of the highest last-mile costs in the country. This cost burden disproportionately affects price-sensitive demographics, making affordable shared solutions critical. However, existing lastmile options often fail to meet user expectations, especially regarding reliability and frequency.Frequency is a key determinant of last-mile mode choice. For instance, users are unlikely to prefer modes with waiting times exceeding 10 minutes, highlighting the need for consistent and frequent service.

Additionally, fare structures for existing lastmile options often do not accommodate gendered travel patterns, such as tripchaining, where multiple stops are made during a single journey. This mismatch between user needs and available options drives up costs for commuters who seek faster, more convenient modes of transport. Government incentives and innovative financing models are accelerating EV adoption.

For instance, the FAME (Faster Adoption and Manufacturing of Hybrid and Electric Vehicles) scheme and state-level subsidies are making e-autos increasingly accessible to operators.

4 'moderate' days, city sees cleanest start to Dec in 4 yrs

Noida. City saw the cleanest start to Dec in nearly four years with air quality being recorded in the 'moderate' category at 116 on Thursday, for the fourth consecutive day. A steady breeze, experts said, has aided the dispersal of pollutants.Between Dec 2 and 5, the air quality index (AQI) oscillated between 178 and 110, while it was at the lower levels of the 'poor' category on Dec 1 (at 215). This is the first time since 2020 when the city, as well as Greater Noida, recorded 'moderate' AQIs in Dec — a month that typically sees a toxic haze. CPCB data shows that last Dec, the city saw three 'poor' and two 'very poor' air days. In 2022, AQI in the first five days were 'very poor'. AQI oscillated between 'severe' and 'poor' during this period in 2021 and 2020.



While Ghaziabad saw one 'moderate' air day on Dec 5 last year, this too was the city's cleanest start to the month with four 'moderate' AQI days and one 'poor' day on Dec 1. According to CPCB's 4pm data, Noida's AQI on Thursday was recorded at 116, marginally up from 110 the day before. The Sector 1 air monitoring station recorded the best air quality in the city at 101, followed by Sectors 116 (109) and 62 (139). Sector 125 AQI was not recorded.Greater Noida saw a slight deterioration in air quality but recorded AQI in the 'moderate' category as well, with AQI slipping to 142 from 129 the day before. Neighbouring Ghaziabad saw a negligent change in air quality on Thursday, recording an AQI of 104, against 102 the day before.

Noida. Noida Authority cancelled on Thursday the allotment of nearly 14,000 sqm land parcel to Docile Buildtech Pvt Ltd, a Logix Group subsidiary, over

MCG set to link demolition waste fee, bldg permits to streamline processing of debris

Gurgaon. MCG proposed the integration of the construction and demolition (C&D) waste collection and processing fee with the building plan sanctions last week.The corporation submitted a proposal to the urban local bodies (ULB) department suggesting that the collected fees be distributed to respective ULBs handling waste collection, transport, and disposal operations. According to MCG officials, this integration would eliminate the need for the corporation to conduct site inspections or monitoring for C&D waste charges. It would also reduce enforcement responsibilities while improving the speed and efficiency of waste collection and disposal services. Moreover, having govt departments collect the fees instead of making private contractors responsible for waste management would reduce the

risk of corruption. The fee should be assessed based on the sanctioned Floor Area Ratio (FAR) or the super area of the proposed building,



rather than estimating waste quantities, MCG proposed, adding that rates or charges should be notified in advance, based on the FAR, to provide transparency to all stakeholders.

The proposal is made to streamline the process of C&D waste collection and processing, especially in cities like Gurgaon where the C&D waste management is in complete disarray.

"We have proposed that the C&D waste fee should be linked with the building plan approvals to streamline the entire system. Fee collection will be done upfront by the authority sanctioning the building plan instead of by postconstruction site inspectors. This will reduce administrative burdens on the municipal corporations, while ensuring prompt and effective waste disposal," said the MCG joint commissioner (Swachh Bharat Mission) Akhilesh Yadav.Officials added that the collection of debris charges in advance

enables local authorities to secure the required funding for waste collection and disposal operations, eliminating the need for subsequent financial evaluations. By treating all construction and demolition waste equally without distinguishing between claimed and unclaimed materials, local bodies can achieve comprehensive waste management and maintain cleaner surroundings, they added. Moreover, authorities will develop separate systems to address waste from non-sanctioned building works as this system focuses on waste from approved construction activities, officials said.

As a stop-gap arrangement in the absence of a dedicated agency for C&D waste management, the corporation currently engages private agencies for waste collection, which collect waste and dump it at the Basai C&D waste plant. The firm operating the Basai plant also collects waste from within a 15 km radius around the plant.

City sees 3 'moderate' days this week, but 'poor' air is not so far

Gurgaon. The city's air quality remained in the 'moderate' category for the second consecutive day on Thursday, with the air quality index (AQI) going up to 144 from the previous day's 140.

All four air quality monitoring stations in the city recorded AQI within the 'moderate' range, with Vikas Sadan being 114, Gwalpahari 122, Teri Gram 141, and Sector 51 196.Experts attributed the improvement in AQI to steady north-westerly winds that helped disperse accumulated pollutants and clear the airshed. Extended restrictions under the Graded Response

Action Plan (GRAP) stage-IV also contributed significantly to maintaining better air quality.However, the System of Air Ouality and Weather Forecasting and Research (SAFAR) predicted that air quality is likely to become 'poor' and very poor' in the coming days. "The predominant surface winds are likely to come from the northwest direction, with a speed of less than 8 kmph on Friday morning. Smog and mist are likely in the morning. The wind speed



will increase thereafter, becoming less than 14 kmph, during the afternoon. It will become less than 6 kmph during the evening and night," stated SAFAR. Sachin Panwar, an independent air quality expert, said, "While local emissions and construction activities may gradually resume following the relaxation of GRAP measures, pollution levels are unlikely to reach severe levels in the immediate future. Morning hours may continue to see pollutant accumulation, but afternoons are expected to offer

better ventilation as warm air disperses pollutants."

Meanwhile, PM2.5 concentrations remained high with Teri Gram at 276 μ g/m³, nearly 18 times the permissible limit of 15 μ g/m³, as set by the World Health Organization (WHO). Gwalpahari followed at 273 $\mu g/m^3$, Sector 51 at 272 $\mu g/m^3$, and Vikas Sadan at 144 µg/m3.

For PM10, Gwalpahari topped the list with 203 μ g/m³, nearly five times the WHO's safe limit of 45 μ g/m³. Sector 51 recorded 193 μ g/m³, while Teri Gram and Vikas Sadan did not record PM10 levels. These figures far exceed the CPCB's permissible annual limits of 60 μ g/m³ for PM2.5 and 100 μ g/m³ for PM10.

Hodal-Nuh-Pataudi Road to turn into 4-lane highway, Hry allocates 616cr

Gurgaon: Haryana govt on Thursday approved a budget of Rs 616.1 crore to upgrade the Hodal-Nuh-Pataudi Road into a four-lane highway that is expected to boost regional connectivity and bring with it economic benefits for bridging the urbanrural gap. This 71-km corridor will also interlink national highways, including NH-248A (Gurgaon-Nuh-Rajasthan), which is part of the Delhi-Mumbai Expressway, and NH-8 (Delhi-Jaipur).

The decision to sanction the project's budget was taken at a meeting of the standing finance committee chaired by chief minister Nayab Singh Saini in Chandigarh on Thursday. Public works department minister Ranbir Gangwa said the project, once completed, will become the backbone of regional connectivity in Haryana, and it will integrate the state's highway with national highways.

non-payment of Rs 130 crore dues. The plot in Sector 143, which saw no construction over the last six years since it was allotted, was sealed after the company failed to respond to multiple notices.

Logix Developers were allotted 1 lakh sqm at Sector 143 for a group housing project in 2011. A portion of this plot was subdivided and registered in favour of Docile Buildtech on Oct 30, 2018."Despite repeated notices, the company did not deposit the outstanding amount. On Oct 22, the Authority issued a final 15-day notice to Docile Buildtech, but it went unheeded. So, the allotment of 13,961 sqm was cancelled and the registry terminated," Noida Authority CEO Lokesh M said.Officials said a case has been filed against Docile Buildtech in the National Company Law Tribunal (NCLT), but insolvency proceedings are yet to be initiated. Logix Developers too are undergoing insolvency proceedings in the tribunal.

According to officials, the Sector 143 plot was initially allotted at a rate of Rs 23,550 per sqm, totalling Rs 32 crore. At the time of registration, the company paid Rs 3.2 crore but failed to make any subsequent payments. Over the years, the outstanding amount, including penal interest, touched Rs 130 crore. The current market value of the land is estimated to be Rs 450 crore. The Authority now plans to re-allot the plot to a new developer to recover its revenue.Last month, the Authority lodged a complaint with the Delhi Police's Economic Offences Wing (EOW) against the promoters of Logix City Developers for unrealised dues and missed delivery timelines for its Blossom Zest housing project in Sector 143. The promoters -Devendra Mohan Saxena, Shakti Nath, Vikram Nath, and Meena Nath - are accused of creating third-party rights and misappropriating funds collected from homebuyers while failing to clear the Authority's dues.

Delhi's cloud seeding plan 'not feasible': Union environment ministry to Rajya Sabha

NEW DELHI. The Union environment ministry on Thursday indicated that cloud seeding, as an emergency measure to improve Delhi's air quality, may not be a feasible option. This is because the specific cloud conditions required for seeding are generally absent during the capital's cold and dry winter months, and there are concerns about the "uncertainties, efficacy, and potential adverse effects of the chemicals". The ministry, in response to a Parliament question, told the Rajya Sabha that it shared the views of experts with Delhi govt which urged the Centre to consider the option of artificial rains through cloud seeding. Quoting experts, the ministry in a written response said, "Winter clouds in the region are primarily formed due to western disturbance, which are short-lived and travel from West to East. When low clouds form due to WDs, they typically result in natural ra-infall over Northwest India. eliminating the need for cloud seeding.

World Bank Announces **Record \$100 Billion Support** For World's Poorest Countries

- Washington, United States. The World Bank announced Thursday that it had raised close to \$24 billion to provide loans and grants for some of the world's poorest nations, which it can leverage to generate a record \$100 billion in total spending power. Donor countries committed \$23.7 billion to replenish the bank's concessional lending arm, known as the International Development Association (IDA), a World Bank spokesperson told AFP, marking a slight increase from the roughly \$23.5 billion pledged during the last fundraising round three years ago.
- The Bank can use this money to borrow on financial markets, allowing it to leverage the amount raised by around four times, unlocking around \$100 billion in new loans and grants, up from \$93 billion in 2021.
- "We believe the historic success of this IDA21 replenishment is a vote of confidence and support from donors and clients," a World Bank statement read, referring to the current IDA funding round.
- "This funding will be deployed to support the 78 countries that need it most," World Bank President Ajay Banga said in a separate statement, referring to the developing countries that are eligible for IDA support. It would, he added, help provide "resources to invest in health, education, infrastructure, and climate resilience," as well as helping to stabilize economies and create jobs. The World Bank's announcement follows two days of talks in the South Korean capital, Seoul, a city still reeling after President Yoon Suk Yeol declared martial law late on Tuesday local time, before backtracking under pressure from lawmakers. IDA has become the single largest source of concessional, or below-market, climate finance, and around two-thirds of all IDA funding over the past decade has gone to support countries in Africa, according to the World Bank. IDA replenishment is a crucial part of the Bank's operations, and happens once every three years, with much of the funding coming from the United States, Japan and several European countries including the United Kingdom, Germany and France. This year, the United States announced ahead of time that it would commit a record \$4 billion in new funding to the IDA, while other countries -- including Norway and Spain -- also significantly stepped up their financial support.
- Thirty-five former recipients of IDA assistance have graduated from developing economy status in recent decades, including China, Turkey and South Korea, with many of them now donors to the fund.

French President Macron Vows To Stay In Office Despite No-confidence Vote, Pledges To Appoint New PM Soon


Paris. French President Emmanuel Macron vowed to continue his five-year mandate despite the recent noconfidence vote that led to the resignation of Prime Minister Michel Barnier. Macron also emphasised his responsibility to ensure the continuity of the state, the proper functioning of institutions, and the protection of the French people. The remarks by the French President came while he addressed the nation on Thursday from the Elysee Palace. "Finally, the mandate that you democratically entrusted to me is a five-year mandate, and I will exercise it fully until its end. My responsibility requires ensuring the continuity of the State, the proper functioning of our institutions, the independence of our country, and the protection of all of you." He added, "I have been doing this from the beginning, at your side, through social crises, the Covid-19 epidemic, the return of war, inflation and so many trials that we have shared," Elvsee said. He said, "From today, a new era must begin where everyone must act for France and where new compromises must be built. Because the planet is moving forward, because the challenges are numerous and because we must be ambitious for France. We cannot afford divisions or inaction." 'This is why I will appoint a Prime Minister in the coming days. I will charge him with forming a government of general interest representing all the political forces of an arc of government, who can participate in it or at least who undertake not to censor it. The Prime Minister will have to lead these consultations and form a tight government at your service," Macron said.

Bangladesh To Remove Sheikh Mujibur Rahman's Image Off Currency Notes

Dhaka. Months after the ouster of Sheikh Hasina as prime minister, Bangladesh has begun the process of erasing the image of Sheikh Mujibur Rahman -- her father and the iconic figure behind the founding of the country -- from its currency notes. Bangladesh Bank is printing new notes,

including in them features of the July uprising, the Dhaka Tribune reported Thursday, referring to the student-led



protests that forced Hasina to flee to India on August 5. Nobel laureate Muhammad Yunus took charge as Chief Adviser, the head of an interim government.

According to the central bank, banknotes of Taka 20, 100, 500, and 1,000 are being printed on the instructions of the interim government."The new notes will not include image of 'Bangabandhu' Sheikh Mujibur Rahman," the paper reported, quoting the bank.Religious structures, Bengali traditions, and "graffiti" drawn during the July uprising will be included, it said."I hope the new note could be

released in the market within the next six months," it quoted Bangladesh Bank executive director Husneara Shikha as saying.

- According to the paper, officials from the bank and the Ministry of Finance said the leader's image will be removed from the current notes. Initially, the design of the four notes is being changed, and the others will be redesigned in phases, they said.
- The Finance Ministry's Finance Institute Division submitted a detailed design proposal for the new notes in September.

The legacy of Mujibur Rahman - often called the Father of the Nation - came under attack during the protests, which were initially against a controversial job quota. His statues and murals bearing his image were targeted as his daughter fled to India, and is reported to be still living there.She has directly targeted Yunus in recent remarks, accusing him of failing to protect the minorities, including Hindus. Bangladesh's International Crimes Tribunal has termed her remarks as "hate speech",

and the country's leaders said a smear campaign is on against the Yunus government.

Police release new photos as they search for gunman who killed UnitedHealthcare CEO

NEW YORK. The masked gunman who stalked and killed the head of one of the largest U.S. health insurers had the words "deny," "defend" and "depose" emblazoned on his ammunition, echoing a phrase used by industry critics, two law enforcement officials said Thursday.

The words were written in permanent marker, according to one of the officials, who were not authorized to publicly discuss details of the investigation into the shooting early Wednesday outside a Manhattan hotel and spoke to The Associated Press on the condition of anonymity.

With the gunman still at large, police also released photos of a "person of interest" wanted for questioning in connection with the killing of UnitedHealthcare CEO Brian Thompson. The images, showing an unmasked man in the lobby of a Manhattan hostel, add to a collection of photos and video that have circulated since the shooting including footage of the attack itself, as well as still frames of the suspected gunman stopping at a Starbucks beforehand. Thompson, 50, died in a dawn ambush as he walked from his midtown hotel to the company's

Student's Science Project With **Bird Poop Leads To Discovery** Of Cancer-Fighting Compound

World. Young school students from the James R Jordan Boys and Girls Club in Chicago made a groundbreaking discovery while studying goose poop in a local park. The school students, under the supervision of researchers from the University of Illinois and Professor Brian Murphy at Chicago, identified a potential cancer-fighting compound. The students participated in a STEM program that turned them into bona fide biomedical scientists before they even started high school. Students carefully isolated a bacterium from the goose poop that showed antibiotic activity. The findings were published in the journal ACS Omega, with student Camarria Williams credited as a co-author. Professor Murphy's research laboratory is focused on discovering antibiotics from natural sources, and the cohort of young scientists participated by supplying environmental samples from their local communities. According to a press release by the American Chemical Society, one of the 14 samples of goose poop collected from the Garfield Park Lagoon contained a strain of bacteria called Pseudomonas idahoensis. The students interpreted the bacterium's bioassay data and concluded it had antibiotic activity





and produced a never-before-seen compound.

Then, the university researchers determined the compound's molecular structure using nuclear magnetic resonance and mass spectrometry, named it orfamide N after the family of molecules it belongs to, and investigated its biological activity.

Although orfamide N was not responsible for the antibiotic activity that the team initially observed from P idahoensis, the compound inhibited the growth of human melanoma and ovarian cancer cells in culture tests. Further studies could reveal other advantageous properties of this newly characterised molecule, as per the ACS release. The researchers say that this work proves that it's possible to combine educational outreach with natural product discovery research, and it emphasises the importance of a strong relationship between universities and their local communities.

These school students' work is an inspiring example of how curiosity and learning can lead to significant breakthroughs, even in unexpected places. Camarria Williams, a student, was listed as a co-author on the findings, which were published in the journal ACS Omega

Mr Martin released the last book in the series, A Dance with Dragons, 13 years ago when the first episode of GoT aired the same year. While the TV series may have concluded with its rather rushed and disappointing ending, the fans of the books have been waiting for Mr Martin to come up with the instalment to give his take on the ending. However, speaking to Hollywood Reporter, Mr Martin for the

first time, expressed doubt that he'll ever finish writing the next entry in the series. Unfortunately, I am 13 years late. Every time I say that, I'm [like], 'How could I be 13 years late?' I don't know, it happens a day at a time," said Mr Martin.

"But that's still a priority. A lot of people are already writing obituaries for me. [They're saying] 'Oh, he'll never be finished.' Maybe they're right. I don't know. I'm alive right now! I seem pretty vital!" he added.Quizzed about retirement, Mr Martin said that he could never retire as he's "not a golfer".Social media users were

left disappointed by the update from Mr Martin with some saying they had made peace with the fact that he may never finish the book series.

Hezbollah Vows Support For Syrian Govt Amid Rebel Offensives

Beirut. Hezbollah will support the Syrian government amid escalating offensives by rebel forces, Hezbollah leader Sheikh Naim Qassem said in a televised speech.

- While Qassem did not clarify the form of support, he assured on Thursday that Hezbollah would "do what it could". Qassem accused the US and Israel of instigating aggression against Syria due to their failure in Gaza. He also claimed that "terrorist groups" sought to shift Syria's alignment from supporting the resistance to backing Israeli occupation, Xinhua news agency reported. "We face a very dangerous Israeli project against the Middle East," he warned.
- His comments came hours after Syrian opposition forces captured the strategic city of Homs in central Syria, marking a significant advance in their offensive that started on November 27. The rebels had previously seized Aleppo, Syria's second-largest city, in earlier assaults. The United Nations World Food Program reported that more than 280,000 people had been displaced by the recent violence, according to a post on X.

The clickety-clack legacy of a typewriting institute

THIRUVANANTHAPURAM. As one ascends the wooden stairs of Fort Technical Institute, the clickety-clack of typewriters - once the soundtrack of ambition and hustle - starts to dominate the air. For 105 years now, the institution in Pazhavangadi has been tutoring students on typewriting skills and, in the process, keeping alive a legacy. "The institute was started by my grandfather Appu Iyer with just two typewriters in 1919," recalls Subramanya Iyer, the institute's custodian. It has remained relatively untouched since, save for, of course, very necessary modifications."He was a typist at the government Secretariat," Subramanya continues. "He started this as a means for my grandmother's sister, a widow, to earn a living."When it began, there were no other typewriting institutes in the area and so, students came from even distant places to learn. "Between 1980 and 1986, about 600 students were learning here in multiple batches," Subramanya says. Back then, typewriters were imported from foreign countries and brands like Royal Typewriter and Imperial Typewriter were the vogue. "Only English typewriting was available at the time. There were no options for Malayalam or Hindi. Later, companies like Remington, Halda and Godrej started producing typewriters in India, bringing more options," he adds.Malayalam typewriters were introduced later. But many of them had different keyboard layouts. To standardise it, a proposal was submitted to the government, which eventually led to the creation of a uniform Malayalam keyboard layout. However, today, typewriter production has waned because offices no longer orders them. During its heydays, classes at the institute were conducted every day except Sundays, from 6 am to 8 pm, with each batch having an hour-long session.

CPM men erect stage on busy road near Vanchiyoor; leaves public livid

THIRUVANANTHAPURAM. Making a mockery of the law, CPM workers erected a stage on a busy stretch of road near Vanchiyoor junction on Thursday, throwing traffic out of gear and causing immense inconvenience to commuters. Woman dies, son injured as crowds throng theatre for 'Pushpa 2' screening in Hyderabad

HYDERABAD. A woman died and her son was hospitalised due to asphyxiation as crowds "jostled" at a film theatre here during the premier show of actor Allu Arjun's "Pushpa 2: The Rule", police said on Thursday.

The incident took place on Wednesday night when a large number of fans thronged the cinema hall to have a glimpse of the actor, they said. There were no arrangements by the theatre management or prior information about the arrival of the actor and other



members of the film, police said. A heavy crowd rushed ahead and the woman and her son, who were trying to enter inside the theatre suffocated and fell unconscious apparently after being pushed by the crowd,

police said, based on preliminary investigation.

A police official pointed out that the theatre was small, and it could not accommodate such a massive crowd. Police personnel conducted Cardiopulmonary Resuscitation (CPR) on the woman and her son and shifted them to a hospital, where the woman died and her son is undergoing treatment, a senior police official said. To control the situation, police used mild force to disperse the surging crowd.

Hope for a reset in Akali politics

- DECEMBER 2, 2024, will be remembered as an important day in the contemporary history of the Sikhs and the regional politics of Punjab. It saw the Sikh religious seat of power, the Akal Takht, reasserting its authority over the Shiromani Akali Dal (SAD). The five Jathedars summoned nearly the entire party leadership, asking it to admit the criminal misdeeds (gunaah) it had committed while in power and seek forgiveness. Speaking clearly and sharply, they highlighted these 'misdeeds' and how they had seriously hurt the Sikh sentiment, interests and wellbeing. Perhaps the most serious of these misdeeds, they proclaimed, had been their indifference and glaring failure to prevent incidents of disrespect (be-adabi) for the Guru Granth Sahib.
- The 'main accused' who appeared before the Takht was former SAD president Sukhbir Singh Badal. But he was not the only one who was held responsible for the criminal wrongdoings. The Jathedars asked all those who had worked with him while he was the Deputy Chief Minister of Punjab to also own up to their involvement and seek forgiveness. They also held the late Parkash Singh Badal, then Chief Minister, equally responsible for these misdeeds and withdrew the honour of Panth Rattan Fakhr-e-Quam bestowed upon him by the Takht in 2011. Given the nature of their authority, the Jathedars pronounced a range of nominal punishments for all those found 'guilty', which the accused 'humbly' accepted. They also directed that the SAD be dissolved, along with its parallel or dissident offshoots. The Jathedars announced the formation of a committee and assigned it the task of rebuilding the political party. The Sikh political system, as we know it today, evolved during the 1920s as an offshoot of the popular movement for the liberation of historic gurdwaras from the control of 'corrupt mahants'. The movement came up with the idea of managing gurdwaras democratically through a body to be elected by common Sikhs, which came to be known as the Shiromani Gurdwara Parbandhak Committee (SGPC). It was under the aegis of the SGPC that the SAD came into being as its political wing. The colonial state gave it formal recognition in 1925 as the sole custodian of all historic gurdwaras of Punjab. The SGPC continues to have legal status in independent India.
- The history of the Akal Takht, the throne of the timeless one, goes back to the sixth Guru, who established it as a seat of temporal authority (miri). facing the Darbar Sahib (often referred to as the Golden Temple), the seat of its spiritual authority (piri). The Takht became the site for the Sikhs to assemble and discuss the political challenges facing the community. After its formation, the SGPC appointed five Jathedars to collectively deliberate upon and decide on issues of politics and justice. Over the years, the electoral political process acquired a kind of autonomy and ascendancy over Sikh religious institutions. The SAD emerged as the power centre and its leadership started controlling the affairs of the SGPC as well. Though members of the General House of the SGPC are separately and independently elected by the Sikh electorate, they have tended to be subservient to their political bosses in the SAD. On April 19, 2024, The Times of Israel, quoting Channel 12, said that an "emergency discussion"

was held at the Prime Minister's Office to decide how to "fend off" the potential warrants. The paper also said that Netanyahu had raised this possibility with visiting Britain Foreign Secretary David Cameron and Germany's Foreign Minister Annalena Baerbock and "sought their help"

The same paper said on April 28 that Netanyahu was "under unusual stress" over the prospect of an arrest warrant against him by the ICC "which would constitute a major deterioration in Israel's international status." Hence, steps were taken to give a "rare briefing on Shabbat" to the international media through Israeli Defence Force (IDF) spokesman Nadav Shoshani on the government's support to the Americansponsored temporary humanitarian pier

off Gaza. Their worry was heightened when another UN body, the International Court of Justice (ICJ), started hearing the genocide case against Israel, launched by South Africa on December 29, 2023. The ICJ, the principal judicial organ of the United Nations (UN), was established in 1945 under the UN charter for adjudicating disputes between states and fixing responsibility of a state under international law after inquiring whether a state party to the case has breached it. It can issue 'provisional measures" to preserve those rights until the case proceedings are completed. In this case, to genocide and to allow relief materials were passed on January 26, 2024. On July 19, 2024, the ICJ, in a different context, gave its advisory opinion that Israel's occupation of the Gaza Strip and the associated settlement regime, annexation and use of natural resources was unlawful. This was on a reference made by the UN General Assembly in 2022. The ICJ mandated Israel to end its occupation, dismantle its settlements, provide full reparations to Palestinian victims and facilitate the return of displaced people. The ICC, established in 2002 by the "Rome Statute", is different from the ICJ as it seeks to establish individual criminal responsibility for serious international crimes. Through its



prosecutor, who has the power to carry out investigations of crimes within the jurisdiction of the ICC, the court can issue arrest warrants for individuals.

December 31, 2000, after considerable reluctance, although in the 1940s, the Jews were ardent supporters of such a court, having suffered under the Nazi regime. The procedure is that either the UN Security Council or any of the 124 member states of the Rome Statute can refer a situation to the court, asking the prosecutor to conduct a preliminary investigation. The prosecutor can also launch an investigation on his own initiative.

provisional orders to prevent and punish incitement The court does not have a police force, but all states that have signed are obliged to comply with a requested arrest warrant. Hearings are conducted as a criminal trial, with prosecution and defence counsels before a tribunal of judges.

West Bank, including East Jerusalem, along with the Israel complained to the ICC on October 5 that its prosecutor Karim Khan did not give it an

opportunity to investigate "his allegations before seeking arrest warrants against its leaders, which was a fundamental principle of the ICC's founding charter."ccording to it, the prosecutor should have, under Article 18 of the Rome Statute, provided "sufficiently specific information to the state under investigation about the crimes that they are investigating" to examine whether that country was willing to launch prosecutions against the errant

individuals. It alleged that Khan relied upon a 2018 notification sent to Israel about alleged crimes "relating to Israeli settlement policy and claims raised in previous hostilities in Gaza" and not on the Israeli operations consequent to the Hamas attack on October 7, 2023. US Secretary of State Antony Blinken and two US senators supported this, saying that Khan "rushed" to get the warrants "to politically target Israel."As things stand, it is not clear what the signatories, especially from Europe of the Rome Statute, would do. America, Israel, Russia, China and India have not ratified the Rome Statute. President Joe Biden has said that America had rejected the ICC decision. Incoming Republican leader John Thune has urged the Senate to pass a Bill that was cleared by the House of Representatives, under which the US would impose sanctions on people "engaged in any effort to investigate, arrest, detain or

prosecute any protected person of the United States and its allies.

There are many imponderables here. While Britain, supported by EU's foreign policy chief Josep Borrell, originally said that it would honour the treaty obligations, there are reports that France is reconsidering its earlier stand by Prime Minister Michel Barnier that the country was bound to abide by all treaties. On November 27, Israeli newspaper Haaretz quoted the Quai d'Orsay (French foreign office) to reveal that Netanyahu and Yoav Gallant could be entitled to immunity from arrest warrants issued by the ICC. This was after the Israel-Lebanon ceasefire, helped by French President Emmanuel Macron.

At the same time, western powers led by America are apprehensive that any dilution of the ICC's powers might boomerang on the ongoing investigations against Argentina and Russia, which they want to pursue.

Punjab's predicament is worsened by delayed subsidy payments, with the pending bill crossing Rs 4,500 crore. The Punjab State Power Corporation Limited is struggling with a dip in collection efficiency, dropping from 106% to 73%, and soaring transmission losses. Attempts to raise revenue, including recovering dues from defaulters and government departments, have yielded little relief. With the state

Centre must aid states on new criminal laws

Making rules for ensuring the implementation of a number of new concepts, as envisaged in the BNSS, is the key to success.

PRIME Minister Narendra Modi dedicated the successful implementation of the new criminal laws to the nation at a grand function in Chandigarh on December 3. Home Minister Amit Shah complimented the Chandigarh police for being the first unit to enforce the new legislations, and meticulously. He hoped that the laws would become operational fully throughout the country within three years — the time needed to create infrastructure and integration of database with several portals for the purpose of coordination between the various wings of the Criminal Justice System (CJS), which are timeconsuming processes. The Home Minister stated that 11,34,698 policemen had been imparted training and more than 11 lakh criminal cases registered after July 1, 2024 under the new provisions of laws; 9,500 of them had already been decided upon. Such is the impact of these new procedures that the Chandigarh police have achieved 85 per cent conviction rate in the cases decided following the new scheme.

It was a historic moment for the people to be witness to the new-era penal legislations adopting the Indian soul, which subscribed to the people-centric and justice-oriented approach. They replaced the colonial laws as standposts of suppression and retribution, said the PM.The occasion offered an opportunity to the professionals in the field of justice delivery to undertake an operational audit of the working of the new laws to identify bottlenecks and shortcomings and suggest measures for credible performance in future. It is said that laws do not operate in isolation.

Police investigating officers have started applying the new sections of the criminal laws in all cases. The successful implementation, though, would mean much more than that. It requires the creation of

electronic and digital infrastructure and the recruitment and training of staff for the proposed digitalisation of CJS. The enactment of a large number of subordinate legislations by the states in the form of rules, operating procedures, forms and formats, etc is essential to bring the laws in full operation. Upgrading of the software relating to Crime and Criminal Tracking Network System (CCTNS) and Inter-Operable Criminal Justice System (ICJS) for linking between the stakeholders is necessary for proper coordination between the enforcers. Making rules for ensuring the implementation of a number of new concepts, as envisaged in the Bharatiya Nagarik Suraksha Sanhita (BNSS), is the key to success.Implementing provisions relating to the e-registration of first information report (FIR), e-service of summons and warrants, zero FIR, witness protection schemes,

community service, trial in absentia, seizure and forfeiture of proceeds of crimes, time-bound disposal of case properties, sharing of forfeited proceeds of crimes with the victims of crimes, commutation of sentence, storing of videography footage, etc would not be a reality unless the operational protocols and rules are framed by the states immediately. In their absence, these novel concepts would remain on paper only.

The Home Minister called the forensic experts the 'fifth pillar of CJS.' The network of forensic science



laboratories (FSLs) is scanty. To ensure mandatory visits of forensic experts on all scenes of crimes entailing punishment of more than seven years, as per the new laws, the FSLs would require extension up to the police station level. Given the limited availability of forensic experts, it is a huge task. Integrating the main pillars of criminal justice — the police (CCTNS), courts (e-courts), jails (e-prisons), forensic lab (e-forensic) and prosecution (eprosecution) — through the ICJS is a Herculean task. The work has just begun. It cannot be completed unless all other related works falling in the domain of

state agencies is accomplished. The time-bound disposal of case properties is a welcome feature of the new procedural law. Unfortunately, this provision had not found favour with the courts till now - perhaps, for want of urgency on the part of law enforcers or due to lack of infrastructure.One of the striking features of the Bharatiya Nyaya Sanhita, 2023, (BNS) is contained in Section 48, which criminalises the abetting of offences in India by terrorists and gangsters sitting in foreign countries. Section 107 of the BNSS provides for the forfeiture of the proceeds of crimes. Section 356 of the BNSS pertains to the concept of 'trial in absentia' for bringing absconders of law to justice. It is intriguing that none of the criminals operating from outside the country could be nailed down under these provisions so far.Community service

as a sentence is included in the list of punishments under the BNS, but no identified apparatus and protocols are in place to execute it. Moreover, the sentence of community service has just a cosmetic effect in the new criminal laws as offenders involved only in six petty crimes out of all the offences contained in the BNS are punishable with this sentence. There is a case to extend the scope of this punishment for all first-time petty offenders. Some other noticeable anomalies are also there in the new laws, which need appropriate resolution.

Know how much you should water your plant

Every plant is different and while some need a good amount of water, others need their soil to dry out between watering sessions. A common mistake people make is to water the plant every day, which could inadvertently kill some types of plants.

Drainage

Since you might often give your plant too much water, be sure to create a proper draining system in the pot. The best way to do this is to have a layer of pebbles of around 2.3-four cm at the bottom of the pot. The pebbles will keep the roots of the plant away from any excess water at the bottom of the pot. If the plant is placed in the balcony, you could even buy a pot that has a draining hole.

Dust the leaves

Make sure you don't let dust settle on the plant's leaves because if too much dust gathers, your plant could have difficulty in breathing. You can fix this problem by taking a soft towel or a paintbrush and sponging both sides of the leaf each week.

Delhi triple murder: Police recover murder weapon

NEW DELHI. Delhi Police on Thursday recovered the murder weapon, an army knife, which was used by a 20-year-old man to murder his entire family of three people in southwest Delhi's Neb Sarai area. Apart from the knife, the police also recovered the bloodstained clothes from a nearby forest which were worn by the accused, said officials.

Twenty-year-old Arjun Tanwar, a second-year BA student at Delhi University, was arrested on Wednesday for allegedly killing his parents and elder sister. Exarmyman Rajesh Kumar (51), his wife Komal

(46) and their daughter Kavita (23) were found dead at their house in Deoli village on Wednesday morning.

According to the police, Tanwar did not have good relations with his parents, who he claimed favoured his sister Kavita in all



aspects of life.

The police recovered his blood-stained sweatshirt and the army knife which he used for killing his parents and sister from Sanjay Van late Wednesday night. During interrogation, Tanwar told the police that he first slit his sister's throat who was sleeping on the ground floor.

Then he went to the first floor where he found his father in a deep sleep, while his mother had already woken up and was inside the washroom. Arjun slit his father's throat and moved on to his next target, his mother. As she came out, Arjun first smothered her and then stabbed her neck repeatedly, till she died on the spot. Tanwar then changed his blood-stained clothes, put them in his gym bag and went to Sanjay Van where he dumped the bodies, they added. After returning home, he tried to clean the blood spots in the

washroom and other articles in the house, the officials said.

Tanwar then provided a false alibi to the police, claiming he had been at the gym when the crime took place. The accused was a trained boxer. He represented Delhi in a state boxing event, where he won silver.



He also assured that he would continue to be part of the party and take on any responsibilities assigned to him.

NEW DELHI. Delhi Assembly Speaker and AAP MLA from Shahdara, Ram Niwas Goel, announced his retirement from active electoral politics on Thursday, citing advancing age as the reason for his decision. Reacting to Goel's retirement, Delhi BJP spokesperson Praveen Shankar Kapoor said, "Goel has been a staunch supporter of Kejriwal for the last 10 years, but after the party's recent developments, including the entry of Shunty, he had no option but to retire."

AAP MLA Naresh Balyan sent to oneday judicial custody in MCOCA case

NEW DELHI. Delhi's Rouse Avenue Court on Thursday sent AAP's Uttam Nagar MLA Naresh Balyan to a day's judicial custody in connection with a case lodged against him under the Maharashtra Control of Organised Crime Act (MCOCA) as arguments on the police plea seeking his remand for interrogation remained inconclusive. Earlier in the day, the Dwarka court dismissed the police's application seeking 10 days of custody for Balyan; however, the court rejected it.Additional Sessions Judge Vandana Jain, presiding over the case at the court, rebuked the prosecution for its approach."I do not have the power to transfer the case. Show me a precedent where this has been done. What was the need to come here? This is a sheer waste of my time," said Judge Jain. She granted liberty to the Investigating Officer (IO) to seek custody before the appropriate MP/MLA court. According to the Delhi Police, Balyan is allegedly linked to a crime syndicate led by gangster Kapil Sangwan. The prosecution claimed Balyan facilitated organised crimes, specified targets, and invested money on behalf of the syndicate.

Delhi HC asks govt to clarify stand on illegal dog breeding, questions lax enforcement

> The court is hearing a PIL seeking stringent control over illegal dog breeding in Delhi, a plea that has been pending for six years.

NEW DELHI. The Delhi High Court urged the Delhi government on Thursday to clarify its position on the existence of dog breeders in the city amid allegations of illegal breeding operations.

A bench comprising Acting Chief Justice Vibhu Bakhru and Justice Tushar Rao Gedela directed the state government to submit a status report detailing measures against violators of the Prevention of Cruelty to Animals Rules, 2017 and 2018.

The court expressed scepticism over the claim that there are no breeders in Delhi, citing the broad definition of "breeders" under the relevant laws. It instructed the Delhi government to file an affidavit explicitly stating its stance and outlining steps to identify and regulate breeders within the National Capital Territory (NCT)."It is contended that there are no breeders in

2020 riots: Delhi HC quashes one of two FIRs against AAP councillor Hussain

- NEW DELHI. The Delhi HC has quashed an FIR against former AAP councillor Tahir Hussain, linked to 2020 Delhi riots, citing the existence of a prior FIR covering the same incident.
- Justice Subramonium Prasad ruled that the chargesheet filed in the quashed FIR would be treated as a supplementary chargesheet in the earlier case, allowing the trial to proceed without prejudice to the victims.
- The court noted that the second FIR, registered on February 27, 2020, detailed allegations of rioting and arson on the first floor of a building, while the first FIR, dated February 25, 2020, pertained to similar offences on the ground floor of the same building." A perusal of the two FIRs shows that the rioters first broke open the shutters of



Pradeep Parking and set fire to vehicles parked there, and then proceeded to the first floor, where they destroyed goods prepared for a marriage ceremony. Both incidents are part of the same episode," the court stated.

Acknowledging

that the victims in both FIRs were different, the court emphasised that quashing the second FIR outright could deny justice to the aggrieved parties. It observed that nine eyewitnesses and 23 additional witnesses were common in both cases, ensuring that there was no prejudice if the chargesheet from the second FIR was integrated into the first case.

'The mistake of the prosecution in filing two FIRs for an incident within the same building cannot result in injustice to the victims. This court is inclined to quash FIR 116/2020, dated February 27, 2020, registered at Police Station Khajuri Khas, with a direction that its chargesheet be treated as a supplementary chargesheet in FIR 101/2020," the court ordered.

NEW DELHI. The Congress is making a series of promises to appeal to voters from the lower middle-income class during the final leg of its Dilli Nyay Yatra.

Among the key promises are doubling free electricity units, granting property rights to homeowners in resettlement colonies, implementing the Street Vending Act of 2014, and renewing auto rickshaw licences. The law, passed by the Congress-led UPA government at the Centre, aims to protect the rights of urban street vendors and regulate street vending activities.

"During the Delhi Nyay Yatra, we came across



thousands of street vendors who shared their struggles with us," Yadav said.

'They complained about facing constant harassment from the police and MCD officials due to the absence of designated vending zones and licenses."

Additionally, Yadav promised to resume the registration of auto rickshaws, providing permits to end black marketing and

benefiting over 4 lakh people in the national capital. Currently, 93,654 auto rickshaws are registered in Delhi.

"After AAP's victory in 2014, Kejriwal announced several initiatives, such as increasing auto fares based on inflation, ending police harassment, raising the number of auto permits to one lakh and building at least 300 auto stands across the city. However, Kejriwal failed to fulfill any of these promises, betraying auto rickshaw drivers," Yadav said. On the issue of property rights for residents of resettlement colonies, Yadav stressed that these rights would allow residents to access bank loans for education, marriage, and other necessities. 

Outdoor classes make students more open to learning: study



Teaching science subjects outdoors instead of within closed classrooms can increase students' motivation to learn and participate, a study has found. The study by the Technical University of Munich (TUM) and the University of Mainz advises offering more outdoor instruction at the lower secondary level. About 300 students participated in a programme called "researcher weeks" aimed at getting pupils excited about the natural sciences.

Students were prepared for a one-week stay in the classroom. This was then continued on site during the research week, culminating in a two-day research expedition with experiments. Both before and after the course the students

and after the course, the students completed a questionnaire on their satisfaction and overall motivation. At the end of the week, the students again shared their experiences during the outdoor class. Basic psychological needs to experience autonomy and competence as well as positive social relationships exert the primary influences on motivational behaviour, researchers said.

The study showed that motivational behaviour in both contexts was influenced equally strongly by these three needs,

albeit at different levels. Basic needs are met to a significantly higher degree during outdoor instruction than in the classroom. A sense of achievement particularly increases motivation during outdoor instruction. On the other hand, the studentteacher or student-student relationships had little or no influence on this increase. Nor did gender have any influence on the results.

The study, published in the journal Frontiers in Psychology, found that outdoor instruction with explorative learning methodology significantly promotes the attitudes of students toward learning, ie. their intrinsic motivation. 'Explorative' means nothing more than simply giving students the freedom to discover the subject matter through independently organised experiments. These outdoor dynamics, which provide a strong boost to more situational interest for science and engagement with the subject, can be evoked in occasional About 300 students participated in a programme called "researcher weeks" aimed at getting pupils excited about the natural sciences. "Whether it involves rural study centres away from school or forms a part of the science curriculum, or both, this statistical analysis demonstrates that regular outdoor teaching is an appropriate strategy to meet the

challenges of the 21st century," said Ulrich Dettweiler, associate professor at the University of Stavanger in Norway. "Such models might even be suitable to bridge the existing gap between science education and environmental education in the long term," said Dettweiler, who was at TUM at the time of the study.

You May Soon Draw PF Money Through ATMs; Amazing Feature Likely **Coming In EPFO 3.0 Next** Year

New Delhi. In order to improve services for EPFO members, the Employee Provident Fund Organisation (EPFO) intends to update to a new version, EPFO 3.0. One of the most significant aspects of EPFO 3.0 is that subscribers will get the option to withdraw Provident Fund (PF) from ATMs, ET Now has reported. To make withdrawals easier, the EPFO is coming up with a new initiative that will allow subscribers to withdraw their PF money directly from the ATMs, ET Now has said. An ATM card, akin to a debit card, would be issued by the labour ministry to enable members to take out PF money directly from ATMs. Nevertheless, the maximum amount that can be taken out will be 50% of the entire deposit. This feature might be implemented somewhere between May and June of 2025, it added. At the moment, it takes seven to ten days for the withdrawal amount to be credited to the bank account that is linked to the EPF account. The updated feature will streamline the withdrawal process by enabling members to take out their PF amounts straight from ATMs. The prevailing 12% contribution cap may be lifted by the government. This will allow employees to contribute as much amount as they want. On the other hand, the employer's contribution will be fixed based on the employee's salary, and therefore the employer will not be burdened.

Vishal Mega Mart's Rs 8,000 crore public offer to open on December 11

MUMBAI. Leading supermarket player Vishal Mega Mart's Rs 8,000 crore initial public offer will be opening on December 11.

The company is yet to announce the price band for the mega issue. The issue is entirely offer for sale (OFS) by promoter Samayat Services, and has no fresh issue of shares, therefore, no money from the issue will go to the company, according to the final IPO papers filed with the capital market regulator Sebi on Thursday.Currently, Samayat Services holds 96.55% stake in the Gurugram-based supermart major. Vishal offers apparel, general merchandise and fast-moving consumer goods (FMCG) categories through its 626 stores and the mobile application and website.Vishal Mega Mart competes with Mukesh Ambani's Reliance Retail, Tata Group's Trent and grocery retailer Avenue Supermarts, which runs the D-Mart labelled supermatkers chain and is owned by leading stock broker Damani, among others. Vishal is among the two leading offline-first diversified retailers in terms of same-store sales growth.

The updated draft filing was filed in October after Vishal's confidential offer document was approved by Sebi late September. The company filed its offer document in July through the confidential pre-filing route. The retailer had strong financial performance in the past years, with consolidated net in financial year 2023-24 growing 43.8% to Rs 461.9 crore on a revenue of Rs 8,911.9 crore, a growth of 17.5% over financial year 2022-23.

CEA calls for striking balance between corporate profitability, workers' income

NEW DELHI. The anemic growth in private consumption has started to give jitters to the government as the chief economic advisor (CEA) to the Ministry of Finance Dr V Anantha Nageswaran on Thursday called for a balance between corporate profitability and workers' income growth.

Speaking in an event organized by Assocham, the CEA noted that even as corporate profitability was at a 15year high in FY24, much of this income was diverted by companies to reduce their leverage. Bitcoin beats regulatory hurdles, hits \$100K level

NEW DELHI. Despite regulatory uncertainties around the globe, Bitcoin prices on Thursday breached the psychologically important level of \$100,000, surging nearly 133% over the last one year. The rise in cryptocurrency was hastened by the victory of Donald Trump in the US presidential election.

Bitcoin prices have risen by over 50% since the US presidential Election Day (5 November 2024) in anticipation that the Trump administration will ease regulatory hurdles and create a more favourable environment for digital assets. The market cap of Bitcoin is now a massive \$2 trillion. The rise in Bitcoin prices beyond \$100,000 mark is a testament to the resilience and adoption of Bitcoin, says Sumit Gupta, co-founder, CoinDCX.

The psychological breakthrough will prompt institutions, companies, and countries to take Bitcoin and crypto more seriously. Retail investors may now view it as a validated, stable asset class, and we could see deeper integration of bitcoin into mainstream investment products," added Gupta.Bitcoin is the first decentralised cryptocurrency invented in 2008 by a yet unknown person named Satoshi Nakamato. Its use began in 2009. Ever since, bitcoin prices have seen many ups and downs with bouts of heart-stopping volatility.

Yet over the long-term, the digital currency has given eye-popping returns. In the last five years, prices of Bitcoins have surged 1,263% or 13 times its price. "This growth is still shy of the levels we experienced during the peak of 2021, underscoring the untapped potential in the ecosystem as we steadily move toward brighter times," says Balaji Srihari, business head, CoinSwitch.

MUMBAI. The credit card industry seeing a sharp 50% year-on-year decline in new card issuances to a meagre 7.8 lakh in October as against 16 lakh cards issued in the same month last year.In November 2023, the Reserve Bank, fearing a bubble build-up in the unsecured loans segment, which has been growing at three times the other loans for nearly two years, asked credit card issuing banks to set aside 25 percentage points more money as risk capital, taking the total to 150%.Still, banks continued to aggressively push credit cards and since the second quarter almost all lenders have begun to report higher delinquencies. The worst affected ones are Kotak Mahindra Bank, RBL Bank, and Axis Bank, among others.Domestic brokerage Anand Rathi



stated that the industry; led by HDFC Bank with about 24% market share followed by SBI Card with close to 20%, ICICI Bank and Axis Bank; has added only 7.8 lakh new credit cards in October. May 2024 was the lowest in many years when the industry added just 7.6 lakh customers.But on an annulaised basis, the October numbers as much as 45% less than what the industry did last year. Despite this decline, net additions in October 2024 were higher than in June 2024, contributing to a 16% quarter-on-quarter rise in cards in force, the report said. Mumbai. The Reserve Bank on Friday announced a raise in the interest rate caps on the diaspora's foreign currency deposits, in a move aimed at attracting more capital flows amid pressures on the rupee.Announcing the fifth bi-monthly monetary policy for the current financial year, RBI Governor Shaktikanta Das said it has been decided to increase the interest rate ceilings on Foreign Currency Non-Resident Bank deposits or FCNR (B) deposits as per tenors. It can be noted that the move comes at a time when rupee has been hitting lifetime lows against the dollar, and the Reserve Bank of India (RBI) seems to be deploying forex reserves to contain the volatilities, as seen in the sharp fall in the kitty over the last few weeks.Starting from Friday, banks have been now permitted to raise fresh FCNR (B) deposits of 1 year to less than 3 years maturity at rates not exceeding Overnight Alternative Reference Rate (ARR) plus 400 basis points, as against 250 basis points earlier.Similarly, deposits

with maturity between 3 to 5 years can be paid an interest of ARR plus 500 basis points, as against the 350 basis points ceiling earlier, Das said. The relaxation will be available only till March 31 next year, he said.It can be noted that India, which is the largest beneficiary of remittances in the world, has introduced sweeter deals to NRI deposits in the past episodes of rupee coming under pressure.Das said the rupee has



depreciated by 1.3 per cent mainly on strengthening of the US dollar and selling pressure from foreign portfolio investors in October and November, and added that the volatility was less when compared to peer emerging markets.

Stressing that the RBI's exchange rate policy has been consistent to let the markets determine the levels, Das said foreign exchange reserves are used judiciously to mitigate undue volatility,

maintain market confidence and preserve overall financial stability.

Meanwhile, the Governor also announced an Expansion in the reach of forex-Retail Platform through linkages with Bharat Connect on Friday.

Das said with the objective of bringing greater transparency and fairness in the pricing of foreign exchange for users, especially for individuals and the Micro, Small and

Medium Enterprises, the Clearing Corporation of India Limited (CCIL) launched the FX-Retail platform in 2019.Presently, the FX-Retail platform is accessible through an internet-based application, he said, adding that it is proposed to facilitate the linking of the FX-Retail platform with Bharat Connect (earlier known as Bharat Bill Payment System) operated by the NPCI Bharat Connect.

Big blow to India as shooting, hockey out of **2026 Youth Olympics**

NEW DELHI. In a significant setback to India's medal prospects, the International Olympic Committee (IOC) executive board has removed shooting, weightlifting, and hockey from the roster of medal sports for the much-anticipated 2026 Youth Olympic Games (YOG) in Dakar, Senegal. The decision was made during a meeting held in Lausanne on December 3, where the IOC confirmed the events and athlete quotas for the Games, scheduled to take place from October 31 to November 13, 2026.

- The IOC announced that all 35 International Federations (IFs) would maintain official involvement in Dakar 2026, with 25 sports included in the competition programme and 10 designated as part of the engagement programme. The engagement programme will showcase non-medal sports, including canoe-kayak, golf, hockey, karate, modern pentathlon, shooting, sport climbing, surfing, tennis, and weightlifting.
- Dakar 2026 will feature one discipline from each of the 25 medal sports, which include athletics, aquatics, archery, badminton, baseball, basketball, boxing, breaking, evolution forming forming forming cycling, equestrian, fencing, futsal, gymnastics, handball, judo, coastal rowing, rugby sevens, sailing, skateboarding, table tennis, taekwondo, triathlon, beach volleyball, beach wrestling, and wushu.
- This marks a sharp contrast from the 2018 Youth Olympics in Buenos Aires, where India won 13 medals, including three golds, nine silvers, and one bronze. Shooting alone contributed four medals, including two contributed four medals, including two golds and two silvers, while hockey and weightlifting added two silvers and one gold, respectively. The absence of shooting, weightlifting, and hockey from the medal events is likely to impact India's performance significantly. In 2018, star shooter Manu Bhaker secured gold in the girls' 10m air pistol and silver in the mixed girls' 10m air pistol and silver in the mixed 10m air pistol, while Simran Kaur earned a silver in the girl's freestyle 43kg wrestling. However, in Dakar 2026, wrestling will only feature as beach wrestling. The IOC emphasized that the excluded sports would still hold a presence through interactive activities on-site and digital platforms, highlighting their importance as integral components of the Youth Olympic Games.
- The Dakar YOG will feature 151 events, a reduction from the 241 events held during the Buenos Aires edition, with an equal distribution of 72 events each for men and women, alongside seven mixed-gender events. The total athlete quota has been set at 2,700.The IOC noted that full gender equality would be achieved for the first time in Summer YOG history, not only in the overall athlete quota but also across every sport, discipline, and event. This decision aligns with the IOC's commitment to delivering a streamlined and efficient programme while maintaining the competition's elite nature.

As National Wrestling Championships begin on December 6, WFI to discuss RSPB's decision to skip event in AGM

CHENNAI. Even as the National Wrestling Championships begins in Bengaluru on Friday, all eyes will be on the annual general meeting (AGM) of the Wrestling Federation of India (WFI) scheduled on the last day (Sunday).

As the Railway Sports Promotion Board (RSPB) has decided not to field its wrestlers, the championship, as reported by this daily, will not see participation from most of the country's elite wrestlers including the Paris Olympics bronze medallist Aman Sehrawat. A similar situation arose last year when the WFI held the nationals in Pune while the adhoc panel, which was then running the dayto-day affairs of the federation, organised it in Jaipur with the RSPB being the hosts. "This is the second time, the RSPB is not sending its wrestlers for the nationals. The reason is said to be the sports ministry's order wherein it suspended the WFI. But if that is the case then the Services Sports Control Board (SSCB) should also not have sent the entries for the Bengaluru event. This issue will be discussed in the AGM," a WFI source told this daily.

Coincidentally, Prem Chand Lochab, secretary of the RSPB, is also secretary-general of the wrestling federation. He had told this daily that the Railway wrestlers were not competing in the nationals as the federation has been suspended by the sports ministry

The source, however, said this decision has been depriving several wrestlers from competing in the nationals. "As many as 12 RSPB wrestlers took part in the state championships of a few states to qualify for the nationals. They will be representing states like Chandigarh, Haryana, Madhya Pradesh, Punjab, Rajasthan and Uttar Pradesh. This shows how the wrestlers are



desperate to compete but their employer is

not allowing them," added the source. Former national champion Sandeep Mann, who has switched his weight category, is one of such RSPB employees. He will represent his home state Punjab in the 86kg. "Yes, I have won gold in the state championship and qualified for the nationals. The RSPB has neither prevented us nor asked us to compete in the nationals. As I am on leave, I will

compete at the event representing Punjab," Mann told this daily.

Another issue which might be discussed in the AGM is devising a criterion to prevent wrestlers from changing their states frequently in their bid to qualify for events like nationals. "Given the tough competitions in the states like Haryana and Maharashtra, fringe wrestlers from these states compete in other units like Delhi and Chandigarh. It has become quite normal but it hurts the chances of wrestlers from these adopted states. The WFI will try to curb this practice by coming up with a criterion," said the source.Meanwhile, the nationals will begin with competitions in the men's freestyle on Friday followed by bouts in Greco-Roman and two weight categories of women's

wrestling the next day. The last day will witness competitions in the remaining eight categories of women's wrestling apart from the AGM.s top wrestlers from the RSPB are missing the championship, the tournament will provide a chance to the upcoming wrestlers to win medals in their respective weight categories and stake their claims for the national camp.

England all out for 280 after sizzling Brook century

WELLINGTON. Harry Brook smashed a century before England were dismissed for 280 on day one of the second Test against

New Zealand in Wellington on Friday. Brook top-scored with 123 after the tourists were put in to bat on a green Basin Reserve pitch and he put on a key partnership with Ollie Pope to rescue an England innings which was teetering at 43-4.Brook was run out on the last ball of the second session after powering England out of trouble to 259-7, before the final three wickets fell quickly after tea. The in-form Brook registered his eighth century in just 23 Tests and his dismissal was a major boost for the home side after he and wicketkeeper Pope (66) counter-punched with a stand of 174 off just 158 balls. The partnership was reminiscent of the first Test in Christchurch when the same pair combined for a rapid 151 to rescue their first innings and set up an eight-wicket win for the tourists.Brook went on to score 171 at Hagley Oval and unfurled another sparkling knock at the Basin Reserve, where he scored 186 when the teams met here last year.



The lanky 25-year-old's power once again couldn't be contained by New Zealand's seam-heavy attack, striking five sixes and 11 fours from his 115 balls faced before his concentration slipped.

He set off for a single to short midwicket but Chris Woakes didn't respond and Brook was caught short when bowler Nathan Smith hit the stumps in his follow-through.

It took Brook just 91 balls to bring up three figures, his second-fastest century, with his
