Maha Govt swearing-in on Dec 5; Sena hints at Shinde's 'big decision'

New Delhi, Dec 01: Maharashtra president Chandrakant Bawankule made the announcement saying the new Chief Minister would



take oath on December 5 at 5 pm in the presence of Prime Minister Narendra Modi, top BJP central brass and NDA leaders. There was no official word on who the CM would be or from which party, though BJP's Devendra Fadnavis appears to be the frontrunner. BJP leaders said they could not wait endlessly for the Shiv Sena to break the deadlock on the

power-sharing deal offered by Union Home Minister Amit Shah, "Already, the previously scheduled swearing-in on December 2 has had to be postponed," an NDA source said. Shinde

did not make an appearance even today and continued to be at his native Dara village in Satara district of Maharashtra. Shiv Sena's Sanjay Shirsat said Shinde could take a "big decision soon". "Whenever Shinde goes to his village, he takes a major decision," said Shirsat. He reiterated the Shiv Sena's demand that Shinde be allowed to stay CM for two and a half years to enable consolidation of gains made. Shirsat said Shinde's Ladki Behna Yojana had swung the mandate in the NDA-Mahayuti's fayour in the state. The Tribune has learnt that the Shiv Sena has demanded the CM's post for Shinde and alternatively plum portfolios, including Home. 'Madam is busy': When Sonia kept Najma Heptulla waiting for an hour

New Delhi, Dec 01: After being elected president of the Inter-Parliamentary Union (IPU) in 1999, Najma Heptulla rang up the then Congress chief Sonia Gandhi from Berlin to convey the news but had to hold the phone line for an hour as a staff told her that "Madam is busy". The former deputy chairperson of Rajya Sabha, who had left the Congress after reported differences with Gandhi and joined the BJP in 2004, mentions this incident in her just-released autobiography "In Pursuit of Democracy: Beyond Party Lines". Heptulla says the IPU presidency was a "historic first and a great honour, marking the pinnacle of my journey from the Indian Parliament to the world parliamentary stage". "When he heard the

news, he was delighted, first because the honour had come to India, and second, it had come to an Indian Muslim woman. "He said, 'You come back and we will celebrate.' I could also connect to the vice-presidential office instantly," she writes. However, when she "rang up Sonia Gandhi, Congress Party President and my leader, one of her staff first said, 'Madam is busy.' When I pointed one full hour. Sonia never came on the line to speak



to me". Heptulla says she was truly disappointed. "After that call, I did not tell her anything. Before forwarding my name for the post of IPU president, I had taken her permission, and at the time, she had given her blessings," the former governor of Manipur writes. RG Kar ex-principal Sandip Ghosh helped two cartels procure hospital contracts: CBI

New Delhi, Dec 01: Former principal of Kolkata's RG Kar College and Hospital Sandip Ghosh allegedly helped two cartels in procuring hospital contracts, the Central Bureau of Investigation has said in its recently filed chargesheet. The special court has taken the chargesheet on record but it is yet to take its cognisance because the West Bengal Government has not provided sanction to prosecute Ghosh and other accused. Ghosh had resigned as the principal of the state-run institute on August 12 in the aftermath of the rape and murder of a trainee doctor on its premises. The CBI has named Ghosh, former House Staff of the medical college



of Maa Tara Traders, Suman Hazra of Hazra Medical and Afsar Ali Khan of Eshan Cafe, in the charge sheet "This case was registered in compliance with the directions of Hon'ble High Court at Calcutta relating to financial irregularities in RG Kar Medical College & Hospital at Kolkata," the CBI Spokesperson said. The CBI has alleged that Ghosh and Pandey appointed several doctors as house staff in violation of the rules, they said. Ghosh helped two cartels - one run by Singha and Hazra and the other by Khan - in procuring several contracts of the hospital, the CBI has alleged in its chargesheet filed before a Special CBI court in Alipore. "On careful perusal, it manifested that sanction order of the competent authority not yet received. Accordingly, cognisance is not taken sans sanction. Let it be kept with the record," the Special Judge said. The Hospital hogged media attention when a trainee doctor was found dead in the chest department auditorium on August 10. It surfaced that she was allegedly raped and killed by a civic volunteer Sanjay Roy in the intervening night of August 9-10. Ghosh was also under scanner in the case for alleged delay in the probe. In between, the Calcutta High Court ordered a probe into alleged financial irregularities in hospital during his tenure. The High Court order came on a petition by the former deputy superintendent of the facility,

Parliamentary panel seeks details of properties in 'unauthorised' occupation of state govts

New Delhi, Dec 01: The Parliamentary committee scrutinising the Waqf (Amendment) Bill has sought details from various state governments about the veracity and updated details of Waqf properties which, according to the Sachar committee, they had occupied in an unauthorised manner, sources said. The Parliamentary committee, whose tenure has been extended by Lok Sabha till the last day of the next Budget Session, has also sought from the states details of the properties claimed by Waqf boards exercising Section 40 of the Waqf Act. Section 40, an amendment effected during the Congress-led UPA government's tenure in 2013, is one of the most hotly contested features of the existing law as it has given Waqf boards the power to decide if any property belongs to the Waqf or not. The proposed law, which has faced flak from opposition parties and various

Muslim groups for its alleged attempts to

interfere in religious matters, has sought to curb this power while making a slew of other changes in the existing Act. Sources said the Parliamentary panel has decided to get an update on the points made by the

update this Committee in detail," a source said, citing the communication. State governments have also been urged to share details of the cases where their agencies are involved in a legal dispute with Waqf

boards over ownership or possession of any property, with the panel noting that the Sachar Committee had stated its list was not exhaustive. The UPA government constituted the Sachar Committee in 2005 to study the social, economic and educational status of the Muslim community in India. It submitted its report in 2006 highlighting the poor status of Muslims on all these indicators as it recommended a host of measures. Lok Sabha had on November 28 adopted a resolution to extend the tenure of the Joint Committee on the Waqf (Amendment) Bill till the last day of the Budget session of Parliament next year. The Parliamentary panel's meetings have become a political battleground, with the ruling BJP and opposition members vociferously debating the changes proposed by the government. Opposition members had been calling for extending its tenure, which was to end on November 29, and the committee took a unanimous decision to seek more time despite Pal's earlier assertion that he was ready with the draft report.

Sambhal, Dec 01: Amid tight security, members of a judicial commission on Sunday visited the Shahi Jama Masjid here and other areas that witnessed violence over a court-ordered survey of the Mughal-era mosque. Panel head

retired Allahabad High Court judge Devendra Kumar Arora and retired IPS officer Arvind Kumar Jain were the two members of the three-member commission who visited the areas that witnessed violence on November 24. The panel's third member, ex-IAS officer Amit Mohan Prasad, was not present during Sunday's visit. The commission members did not respond to any media queries during the visit in the morning. They were accompanied Moradabad Divisional Commissioner Aunjaneya Kumar

Singh, Deputy Inspector General (DIG) Muniraj G, Sambhal District Magistrate Rajendra Pensiya and Superintendent of Police Krishan Kumar. Later, speaking to reporters, Moradabad Divisional Commissioner Singh said, "Today the chairperson of the inquiry commission and one other member visited the site. Their primary purpose was to inspect the location. They visited the areas where the disturbance occurred, examined the site and the structure, and spoke to some of the people




present there." The team will visit again and a complete schedule for its visit will be announced, he said. "The situation here is gradually returning to normal and it is being closely monitored. Conditions are stabilising rapidly.

As of now, the district magistrate's orders remain in effect until December 10 and after that, there will be no restrictions on anyone. We are in the process of collecting evidence and have so far identified 400 individuals involved (in the violence)," he said. Singh was referring to an order that prohibits the entry of outsiders, including politicians, social organisations or public representatives, in the violencehit Sambhal till December 10 without permission from the competent authority in order to maintain law and order. "The team stayed for about 15 minutes and inspected the mosque,' said Shahi Jama Masjid Imam Aftab Hussain Warsi. Mosque secretary Masood Farooqui said, "The team did not ask us anything. They mentioned that they were only here to see the Jama Masjid and visited the site of the incident. They said they would take statements later." Meanwhile, Samajwadi Party MLA from Sambhal Iqbal Mehmood met the families of the victims of the violence. His son Sohail Iqbal is one of the suspects in the case, according to police, who have also booked SP's Sambhal MP Zia ur Rehman and more than 2,750 others, most of them unidentified.

KOCHI: Robbers linked allegedly to the Kuruva gang have been keeping some pockets of Kerala and the state police on edge. Accounts of the violent nature of their crimes have left many puzzled. An attempt to address this curiosity is currently in the works in Kolkata, West Bengal, in the form of a play detailing the history, life and works of these gangs, without downplaying the dread its members have spread.Playwright and director Ravi Thykkat said 'Oru Kuprasidha Gramam - A Notorious Village' was developed with the help of police officers, who had visited Thiruttu Gramam - the base of the gang - as part of investigations into cases of robbery."Even now no outsider is allowed into the village," Ravi pointed out, adding, "The art of thievery is ingrained in the blood of everyone born into the community."

Flash flood alerts in Nellore, Chittoor, Kadapa districts

TIRUPATI. Heavy rains lashed parts of Nellore, Tirupati, Chittoor and erstwhile Kadapa district on Saturday under the influence of Cyclone Fengal. A flash flood warning has been issued for Nellore, Chittoor, and Kadapa districts. People in low-lying areas also have been put on alert. Authorities have issued a sixth-level danger warning at Adani Krishnapatnam Port, indicating the severity of the

According to the India Meteorological Department (IMD), Fengal made landfall as a cyclonic storm on the north Tamil Nadu-Puducherry coast between Karaikal and Mahabalipuram, near Puducherry with wind speeds of 70-80 kmph, gusting to 90 kmph, on Saturday evening.

yellow alert has been issued for Rayalaseema, Coastal Andhra and Yanam as heavy to very heavy rainfall is predicted in these districts over the next 24 hours. As a precautionary measure, two NDRF (National Disaster Response Force) teams have been deployed in Nellore, while one SDRF (State Disaster Response Force) team each has been deployed in Tirupati and Kurnool districts.

Heavy rains disrupt normal life in Nellore, Tirupati districts

Normal life was disrupted in urban areas like Tirupati, Nellore, Sullurpeta, Kavali, and Naidupet. Tirupati district administration declared a holiday for all educational institutions from Saturday afternoon, prioritising public safety. Nellore district was also severely affected. Both district administrations are on high alert to mitigate potential damage and safeguard residents. Rainfall statistics show a significant impact across both districts.Four flights operating from Tirupati Airport to Hyderabad, Visakhapatnam, and Bengaluru were cancelled, leaving passengers stranded due to the adverse weather conditions.

While Indukurupeta and Muthukur mandals in Nellore recorded the highest of 8 cm rainfall, Doravarisatram in Tirupati logged 6 cm rainfall.

Vakadu, Varadaiahpalem, and Chittamur mandals in Tirupati recorded 5 cm. In Nellore, Podalakuru, Dagadarthi, and Venkatachalam mandals saw 4 cm of rainfall as of 4 pm on Saturday.

Vistarakulu tradition empowers tribal women in Andhra's Alluri Sitharama Raju flowering and yield

Over 20 women make eco-friendly leaf plates and cups at Van Dhan Vikas Kendra in Paderu of Alluri Sitharama Raju district

VISAKHAPATNAM. Harnessing traditional knowledge and sustainable resources, tribal women in Alluri Sitharama Raju (ASR) district are turning a long-standing practice into a source of livelihood. Producing and selling "Vistaraku," eco-friendly dining plates made from Bauhinia Vahlii leaves, locally known as "Addakulu," the women have found a way to be self-employed while discharging environmental responsibility.

This initiative, supported by the Paderu Integrated Tribal Development Agency (ITDA) through Van Dhan Vikas Kendra (VDVK), has helped in increasing incomes of tribal communities. Launched in February 2024 by the then Collector Sumit Kumar and ITDA Project Officer (PO) V Abishek, the VDVK Vistharaku Centre at Paderu has brought together women from surrounding villages to make these biodegradable plates and cups."Up to 20 women work flexibly, stitching leaves at home or using Sundays. They decide their schedule on their own," said DRDA Project Director V

Currently, 20 women are actively crafting plates and cups, producing around 2,000 pieces daily in five varieties, including thick-lined buffet plates, regular plates, hand-stitched plates, and cups of two sizes. These women have crafted biodegradable plates for daily use for generations, a skill now adapted for broader markets.

"This is something we have always done. Now, it helps us earn a steady income," said B Santhi, adding that the best leaves are collected in May and June, though off-season leaves are usable if handled carefully. She further noted that they procure leaves from tribals at weekly shandies and occasionally collect them themselves or receive them directly from some collectors.

Grape farmers in TN's Theni face losses as rain disrupts

THENI: Continuous rain over the past two months, coupled with weather changes, has caused distress to grape farmers in Theni. With flowers failing to mature and turn into fruit, the price of grapes has dropped from Rs 60 per kg to Rs 15. Theni is a major producer of the Muscat Hamburg variety of grapes, also known as panneer thiratchai, a GI-tagged variety that is extremely popular among farmers because of its quick growth and yield cycle. Unlike many other varieties, the panneer thiratchai is available throughout the year, and the region's soil and water enhance its sweetness. However, the grape variety's yield has taken a drastic hit owing to rain and other climatic factors. Speaking to Periyar Vaigai Irrigation Farmers Association president and Kaamayam Thiratchai Vivasayigal Sangam coordinator Pon Katchi Kannan said over 300 farmers in Cumbum Valley cultivate panneer thiratchai on nearly 5,000 acres. "While it is blooming season currently, few flowers have matured into fruits due to continuous rain.

Flowers fail to pollinate and the crop is largely affected by downy mildew, powdery mildew and grey mould. Although farmers generally harvest around 6 tonnes per acre, the yield has reduced to a tonne per acre. The cost of production remains unchanged and farmers spend Rs 2 lakh per acre," he pointed out. Cyclone Fengal: Water level in Chembarambakkam reservoir surges 10-fold in 10 hours

CHENNAI: The water level in Chembarambakkam reservoir, a key drinking water source for Chennai, sharply increased on Saturday due to the impact of rainfall brought by Cyclone Fengal.By 8pm, the inflow to the reservoir was almost up 10-fold in 10 hours from 479 cusecs to 5,610 cusecs.

A senior official from the Water Resources Department (WRD) told TNIE, "There are no plans to open the surplus shutters as the reservoir still has enough storage capacity. As of now, Chembarambakkam holds 2.368 tmcft of water out of its total capacity of 3.645

He further clarified, "The reservoir has a storage capacity of 24 feet, and the current



water level stands at 19.31 feet as of 4 pm. According to guidelines, we can safely store Another WRD official also shared updates water up to 21 feet, so the current level is within the safe zone. We are monitoring the situation continuously."Future decisions will

depend on rainfall in the catchment areas and further inflows into the reservoir, the official added.On Saturday evening, Kancheepuram district monitoring officer KS Kandasamy and collector Kalaiselvi Mohan inspected the reservoir. Travel dreams turned nightmare: Gang in Noida sector 63 takes many for a ride with holiday packages



NOIDA. A fake travel company operating out of Sector 63 was busted on Saturday and 32 people, including 12 women, were arrested for cheating customers with lucrative holiday packages. The arrests came after a woman alleged that she was promised a nine-day vacation to Kerala but eventually conned of Rs 84,000. The accused, employees of Country Holiday Travel India Pvt Ltd, a city-based travel company, would allegedly obtain customer information through the dark web. They would then offer lucrative holiday deals and build trust through in-person visits and persuasive presentations, police said

"Once the payments for the bookings were made through cash or bank transfers, no services would be provided. Refund requests would also be ignored," said DCP (central Noida) Shakti Mohan Awasthi. "The company representatives lured customers through cold calls, offering attractive travel deals. It operated on a fake membership model, promising exclusive benefits that were never fulfilled. Earlier, complaints about the company had surfaced in Bengaluru and Raigad, Maharashtra, where its accounts were frozen," the DCP added. The investigation began on Nov 28 after a victim reported the scam. Subsequently, police raided the company's Sector 63 office on Nov 29, recovering laptops, iPads, routers, and documents.

Those arrested, aged 19 to 37, include senior officials and team leaders accused of orchestrating the operation, police said. The accused have been charged under Sections 316(2) and 318(4) of BNS. An investigation into the matter is underway.

1 dead, 2 injured after section of under-construction tunnel part of Delhi-Mumbai Expressway collapses in Kota

NEW DELHI. One worker lost his life and two others sustained ijuries when a section of an underconstruction tunnel on the Delhi-Mumbai Expressway collapsed in Rajasthan's Kota district, police reported

Week after murder, another Delhi cop stabbed by criminal

NEW DELHI. In another brazen attack on a man in uniform, a Delhi Police head constable was stabbed by a criminal in northeast Delhi's New Usmanpur on Saturday. The attack came a week after a constable was stabbed to death in Govindpuri in southeast Delhi. While the assailant in the earlier case was later shot dead by the Special Cell, the accused in Saturday's incident, Mohammed Adil, was shot in the leg and apprehended late the same day. Head constable Azad Akhtar was on patrol when he received information about Adil hiding at Third Pushta Khadar. According to witnesses, Akhtar intercepted Adil in suspicious circumstances. Adil's brother, Bawla, and three women accomplices arrived on the scene and thrashed Akhtar, even tearing his uniform. The known criminal then attacked Akhtar with a sharp weaponPolice rushed the head constable to hospital and started an investigation. "The cops received information about Adil hiding at Third Pushta Khadar and sent a team in pursuit," an officer said. "Adil fired two shots at his pursuers. We retaliated in self-defence and a bullet hit

In a letter to the Congress, the ECI stated that it had followed a transparent process involving candidates and their agents at every stage of the voting process. However, addressing the Congress's apprehensions regarding the voting percentage in the Maharashtra elections, the poll body extended an invitation for a detailed discussion. This follows similar concerns raised by the party regarding the EVM process after the Haryana Assembly polls. The letter further mentioned that the ECI would review all legitimate concerns raised by Congress and provide a written response after hearing the delegation.

NGT slams MoEF for 'stalling action' over asbestos sheets in educational institutions

New Delhi. Leading social worker, being committed on minorities and Prime Minister Mohammad Yunus NEW DELHI: The National Green Tribunal (NGT) has strongly criticised the Union Ministry of Environment, Forest and Climate Change (MoEFCC) for obstructing its proceedings by failing to provide a decisive response regarding the health risks posed to students by asbestos sheets in educational institutions. The tribunal called the ministry's inaction a "serious obstruction" to its functioning. A bench comprising Justice Sudhir Agarwal and expert member Afroz Ahmad noted that the MoEFCC had ignored prior directives to hold a scientific study on the potential hazards of asbestos exposure in schools. The NGT had earlier sought clarity on whether the health risks for students differed from those faced by industrial workers exposed to asbestos. Despite being asked to submit a report after forming a multi-disciplinary expert committee, the ministry failed to deliver any substantive findings. The tribunal expressed frustration ver the lack of compliance, stating, "The environmental ministry's inaction has paralysed the tribunal's ability to proceed. This amounts to a direct impediment caused by the ministry itself."During the proceedings, the ministry's advocate revealed that a 12-member committee had been constituted but admitted that no study had been conducted to address the NGT's concerns. The absence of any ministry official to explain this failure further aggravated the situation. Given the ministry's repeated noncompliance, the tribunal has now directed a senior MoEFCC officer, not below the rank of joint secretary, to appear personally in the next hearing.

London. Kate, Britain's Princess of Wales, says love is the greatest gift people can give each other in a message to guests who will attend her annual Christmas carol service next week at London's Westminster Abbey.

The December 6 carol concert, the fourth she has hosted, marks Kate's most prominent return to royal engagements since she underwent a course of preventative chemotherapy for cancer.

In a letter to the 1,600 invited guests, Kate, 42, the wife of heir to the throne Prince William, returned to themes of love and the need for empathy about which she has spoken in previous very personal statements and video updates on her health.Christmas, her letter said, was not only a time for celebration, but also for reflection and relief from the pressures of daily life.

She said the Christmas story reflected "our own vulnerabilities", and how much people needed each other despite their differences."Above all else it encourages us to turn to love, not fear," she wrote. "It is this love which is the greatest gift we can receive. Not just at Christmas, but every day of our lives," she said. William, who earlier this month said the year had been "brutal" for the royal family with Kate's treatment coming in the wake of his father King Charles' own cancer diagnosis, will give a reading at the service. Six-time Olympic track cycling champion Chris Hoy, who revealed he had terminal cancer himself in October, will light a candle. The "Together At Christmas" service will be broadcast on Britain's ITV on Christmas Eve.

Hindu Spiritual Leader's Arrest Being 'Misconstrued': Bangladesh To UN Forum

United Nations. The arrest of a Hindu leader in Dhaka has been "misconstrued" and he was arrested on specific charges, Bangladesh has told a UN forum on minority issues, claiming that there has been no systematic attack on minorities in the country. Hindu priest Chinmoy Krishna Das, a former member of International Society for Krishna Consciousness (ISKCON), was arrested from Dhaka's Hazrat Shahjalal International Airport on Monday. He was denied bail and sent to jail by the Chattogram's Sixth Metropolitan Magistrate court in a sedition case on Tuesday. With utter dismay, we note that the arrest of Chinmoy Das has been misconstrued by some speakers, although he was actually arrested on specific charges. The matter is being dealt with by our court of law," Ambassador and Permanent Representative of Bangladesh to the UN Offices and other international organisations in Geneva Tareq Md Ariful Islam said.Islam made the statement during the 17th session of the Forum on Minorities Issues that took place in Geneva on November 28-29. After Das, the leader of the Hindu group Sammilita Sanatani Jote, was sent to prison, it triggered protests by Hindus in various locations, including the capital Dhaka and the port city of Chattogram. India has noted the developments with deep concern even as a diplomatic row has erupted between the two South Asian neighbours.

During the session, some Bangladeshi NGOs and individuals spoke about the situation in the country. Secular Bangladesh (IFSB) said that the situation right now in the country is "very alarming" and a "very burning issue." Referring to Das' arrest, the representative said that ISKCON is a very popular and peaceful organisation but the former ISKCON leader has been arrested with "nothing accused against him. He was arrested three days before in Dhaka and now Bangladesh every day the police, army ... every day, they are torturing the minority."

Islam said that Bangladesh reaffirms that every Bangladeshi, regardless of religious identity, has the right to practice their respective religion or express views freely. "Ensuring safety and security of every citizen, including from the minority community, remains the cornerstone of the interim government of Bangladesh," Islam said.

Taiwan President Gets 'Red Carpet' Welcome In US, China Reacts

Honolulu, United States. Taiwan President Lai Chingte was feted with a red carpet, garlands of flowers and "alohas" as he kicked off his two-day stopover in Hawaii on Saturday, part of a Pacific tour that has sparked fiery rhetoric from Beijing.

China claims Taiwan as part of its territory and has responded to Lai's first overseas trip as president with threats to "resolutely crush" any attempt for independence. Looking relaxed in a Hawaiian shirt, Lai flitted around the US island state, visiting a Pacific island history museum, an emergency management centre and the USS Arizona Memorial in Pearl Harbour. Earlier, he was given the "red carpet treatment" on the tarmac of Honolulu's international airport, according to his office, which said it was the first time a Taiwanese president had been given such a welcome.

He was met by Ingrid Larson, managing director in Washington of the American Institute in Taiwan, Hawaii Governor Josh Green, and others. At every turn, Lai was presented with garlands of brightly coloured flowers or leaves known as leis, greetings of "aloha", and other Hawaiian gifts. In the evening, Lai is expected to deliver his first public speech of the week-long trip at a dinner attended by US government officials and Taiwanese people living abroad. Beijing opposes any international recognition of Taiwan and its claim to be a sovereign state and especially bristles at official contact between the island and the United States.Like most countries, Washington does not recognize Taiwan diplomatically but is its most important backer and biggest supplier of arms.In a statement, China's foreign ministry said it "strongly condemns" the United States for Lai's stopover and that it had "lodged serious protests with the US".

Hamas Releases Footage Of Crying Israeli Hostage, His Mother Reacts

World.Palestinian group Hamas released a video on Saturday featuring an American-Israeli hostage, Edan Alexander. Held in Gaza since the devastating October 7, 2023 attack on Israel, Alexander directly addresses US Presidentelect Donald Trump in English and Israeli Prime Minister Benjamin Netanyahu in Hebrew, pleading for intervention and urging Israelis to pressure their government

for the release of hostages. The video, released by Hamas's military wing, the Ezzedine al-Qassam Brigades, has not been independently verified for authenticity or date. Yael Alexander, Edan's mother, spoke at a rally in Tel Aviv the same evening.

"This video has upset me, but beyond the hope it gives us, it shows how bad the situation is for Edan and the other hostages and how much they are crying out and hoping to be saved now," she declared. She revealed that she had spoken directly with



Netanyahu, urging him to honour his commitment to secure the hostages' release. "You must keep your promise and free them. This state is strong enough to end the war and bring them all back, including my Edan," she said. Netanyahu's office later confirmed the conversation, reiterating that Israel remains resolute in its determination to bring back all hostages. Describing the video as "cruel psychological warfare," the Prime Minister said that such tactics would not deter Israel from its mission. The Hostage Families Forum, an advocacy group for those captured, also weighed in, stating that the only viable solution for the return of hostages lies in a negotiated agreement. "One vear after the first and only deal, it's clear to everyone: returning the hostages is only possible through a deal," the group's statement read. The October 7 attack, which sw 1,207 deaths-mostly civiliansresulted in the kidnapping of 251 hostages. Around 97 hostages remain in Gaza, including 34 whose deaths

have been confirmed but whose bodies have not been returned. A brief truce in November 2023 led to the release of 80 Israeli hostages in exchange for 240 Palestinian prisoners, alongside the release of 25 predominantly Thai captives. However, efforts since then to broker further exchanges or a ceasefire have largely faltered. Israel's military response has claimed the lives of 44,382 people in Gaza, according to figures from the Hamas-run health

Syrian rebels enter Aleppo, President Bashar al-Assad vows to defeat them

Thousands of Syrian insurgents took over most of Aleppo on Saturday, establishing positions in the country's largest city and controlling its airport before expanding their shock offensive to a nearby province. They faced little to no resistance from government troops, according to fighters and activists. A war monitor, the Syrian Observatory for Human Rights, said the insurgents led by Hayat Tahrir al-Sham seized control of Aleppo International airport, the first international airport to be controlled

by insurgents. The fighters claimed they it. Thousands of fighters also moved on, facing almost no opposition from government forces, to seize towns and villages in northern Hama, a province where they had a presence before being expelled by government troops in 2016. They claimed on Saturday evening to have entered the city of Hama.

Turkish security officials said a limited offensive by the rebels was planned to stop government attacks and allow civilians to return, but the offensive expanded as Syrian government forces began to retreat from their positions. The insurgents, led by the Salafi jihadi group Hayat Tahrir al-Sham and including Turkey-backed fighters, launched their shock offensive on Wednesday. They first staged a two-

pronged attack in Aleppo and the Idlib countryside, entering Aleppo two days later and securing a strategic town that lies on the highway that links Syria's largest city to the capital and the coast. By Saturday evening, they seized at least four towns in the central Hama province and claimed to have entered the provincial capital. The insurgents staged an attempt to reclaim areas they

controlled in Hama in 2017 but failed. **PREPARINGA COUNTERATTACK**

Syria's armed forces said in a statement Saturday that to absorb the large attack on Aleppo and save lives, it redeployed troops and equipment and was preparing a counterattack. The statement acknowledged that insurgents entered large parts of the city but said they have not established bases or checkpoints. Later on Saturday, the armed forces sought to dispel what it said were lies in reference to reports about its forces retreating or defecting, saying the general command was carrying out its duties in "combatting terrorist organisations."

Migratory Harriers skip Thamirabarani basin as infrastructural growth ruins habitat

.ATREE's senior scientist Dr T Ganesh told that the arrival of Harriers have declined all over India may be due to the loss of their habitats.

THOOTHUKUDI. The arrival of migratory Harriers, the raptor birds, to Thamirabarani river basin has witnessed a gradual decline due to the destruction of their habitats in the grasslands of the river basin. According to researchers associated with the Ashoka Trust for Research in Ecology and the Environment (ATREE), the development of housing plots in the grasslands, industries, windmills and increasing stone quarries have adversely affected the birds' habitat in the basin.Harriers, which are ground roosting birds hailing from Eurasian countries, visit the grasslands of Vagaikulam, Peroorani, Vallanadu and Vanchi Maniyachi in Thoothukudi, Koonthankulam,

Paruthipadu in Nanguneri, and Samugarangapuram in Radhapuram region during the migratory season (September and March). Though there are 16 different Harrier species, only three species - Montagu's harrier (circus pygargus), pallid harrier (circus macrourus) and Eurasian marsh harrier (circus aeruginosus) - visit the southern parts of Tamil Nadu. According to ATREE researchers, these raptors prey on grasshoppers, birds, and rodents;

whereas jungle cats, small indian foxes and dogs are their major predators. The typical character of the Harriers is to wait nearly 100m away from the roosting site to check for any disturbance before they roost, said M Mathivanan, coordinator, ATREE.

Speaking to, ATREE research associate A Saravanan said that the developing housing plots on grasslands, industries, windmills and the increasing stone quarries have adversely affected the birds' habitat. "We could not find large roosts of Harriers at the Paruthipadu grassland after eucalyptus trees were cultivated in the landscape," he said.Moreover, an annual census conducted by the ATREE researchers recorded only 91 Harriers during a survey in 2022-23. "Previous census results have also shown a declining trend in the sighting of Harriers with 398 in 2015-16, 276 in 2016-17, 387 in 2017-18, 198 in 2018-19, 212 in 2019-20,

Probe launched into poor quality of food at Acharya Nagarjuna University in Andhra

GUNTUR: Taking serious note of the poor-quality food served to students at Acharya Nagarjuna 🎚 University, the Education Department has initiated an investigation into the matter. The issue surfaced on Friday night when a large group of students staged a dharna at the Vice-Chancellor's office on the university premises.

The students alleged that frogs and insects were found in the rice and sambar served during lunch in the girl's hostel mess earlier that day. They raised slogans demanding better food quality in the girl's hostel. Addressing the media, a female student revealed that insects had been found in the food for the past three days."We complained to university officials and even submitted written complaints, but



no action was taken," she asserted. Another student stated that many girls had stopped eating in the hostel mess and attended classes on empty stomachs, as their grievances were ignored by the officials and hostel staff. According to local sources, when the girls tried to leave the hostel to protest, the staff locked the gates to prevent them from going outside. However, the students eventually gathered in large

numbers, forced the gates open, and staged a protest on Friday night. University Rector Acharya Simhachalam and police officers rushed to the scene to pacify the protesters. The Rector assured the students that immediate action would be taken to improve food quality by Saturday.He inspected the preparation of breakfast on Saturday morning. background. The focus now remains on the IV solution used at Ballari District Hospital, where doubts persist. The batches supplied there have been sent for anaerobic testing, to determine whether the solution contributed to the deaths of the postpartum women. The minister said the test results are expected within a week, and a final decision on the use of the solution will be made based on these findings. "Until

we receive clarity, the use of IV Ringer's lactate has been completely stopped across the state as a precautionary measure," he said, adding that hospitals have been instructed not to use the solution, though certain batches were found to meet quality standards.

Upalokayukta takes up suo motu

Based on findings, a suo motu case was registered against doctors of both institutions, with notices seeking their explanation.The Ballari DC, Ballari ZPCEO, and health commissioner have been instructed to provide a detailed report within a month.

KOCHI. Bogged down by financial crisis, the Kerala Kalamandalam, the Deemed to be University of Art and Culture under Kerala government, issued an order to discontinue the service of around 130 temporary employees, including teachers, hostel wardens, drivers and cooks. The order issued by Kalamandalam registrar on Saturday said the service of temporary employees will remain suspended from December 1, 2024 until further orders.Responding to the news, Cultural Affairs Minister Saji Cherian told TNIE that he has given instruction to the varsity registrar to withdraw the order immediately."The government

will look into the grievances of the university and try to solve the issue. Retrenchment of employees is not the policy of the government, and we will address the issues faced by the university," he said. Though Registrar P Rajesh Kumar and Vice Chancellor B Ananthakrishnan were unavailable for comments, a senior officer said the university was forced to retrench the temporary employees as the institution was not receiving adequate non-plan funds for distribution of salary. The peril of allowing disputed mosque surveys

THE dispute over the Shahi Jama Masjid in Sambhal is the most recent instance in a spate of petitions in courts, seeking directions to survey existing mosques to determine temple remains. This is part of a concerted attempt to intensify disputes over mosques in Varanasi, Mathura and, now, the Shahi Jama Masjid in Sambhal, which enjoys the official status of a 'protected monument' and has been earlier declared a 'monument of national importance.'Over the past few years, these disputes have been escalated with the active encouragement of politically affiliated rightwing groups, aimed at weaponising faith and puffing up interreligious conflicts. After the Supreme Court delivered the verdict in favour of the Hindu parties in the Ayodhya case, it was widely believed that conflicts over disputed sites would cease and communal mobilisation would, henceforth, abate.Contrary to this, the Ayodhya judgment opened up the pathway for petitions demanding access to mosques on grounds that there was a temple beneath it. There is an expectation that given the prevailing political climate, the courts will respond favourably. The template is clear a court-mandated archaeological survey and a judiciary which privileges the faith of the majority in interreligious disputes.It was to prevent such attempts to change the character of the places of worship in the name of correcting perceived historical wrongs that Parliament enacted the Places of Worship (Special Provisions) Act, 1991. This law essentially lays down that the religious character of all places of worship would remain the same as it was on August 15, 1947, barring the Ram Janmabhoomi in Ayodhya, and that no person shall convert any place of worship of any religious denomination into one of a different denomination or section. This, however, couldn't stop proceedings in the Gyanvapi case from taking a swift turn after five Hindu devotees moved a Varanasi civil court, seeking permission to offer daily prayers at the Gyanvapi mosque, which they claimed housed several Hindu deities.

This was followed by an order of a district curt directing the Archaeological Survey of India (ASI) to determine if a mosque was superimposed on a pre-existing temple. The Anjuman Intezamia Masjid, which manages the affairs of Gyanvapi, had argued in the apex court that the survey of the mosque premises would defeat the spirit of the 1991 Act. But this was set aside. The Supreme Court allowed the right-wing groups to proceed with the litigation. The survey was subsequently carried out by the ASI.

Claims to the Gyanvapi mosque are a re-enactment of the events in Ayodhya. As in the case of Ayodhya, this dispute is not about law, nor history, but about politics and pushing the farright project of Hindu supremacy, with courts coming up with ingenious legal justifications to circumvent the Act. The former Chief Justice of India (CJI), DY Chandrachud, set the ball rolling by his observation that changing the 'religious character' of a place of worship may be prohibited under the Act, but 'finding the nature of the religious place' was not. This opened the way for resurrecting dozens of historical disputes as there was nothing barring courts from trying to ascertain the 'religious character' of a particular place of worship. In line with this approach, the Supreme Court refused to stay the Allahabad High Court's order allowing a survey to be conducted at the Shahi Idgah mosque in Mathura to examine whether it was built on a temple.Not only can this train of events be used to alter the character of the place of worship, but it also allows the right-wing to rake up issues around disputed sites of worship nationally and dredge up religious sentiments locally to keep the communal pot boiling. The mosque management committees in Varanasi and Mathura cases challenged the survey exercises based on the Places of Worship (Special Provisions).

Why women vote matters, not mandir-masjid

THE landslide nature of the victory of the BJP-led NDA in the 2019 Lok Sabha polls captured so much attention that pundits virtually forgot a historical milestone. For the first time ever since the Lok Sabha elections were held in 1952, the female voter turnout surpassed the male turnout. So focused was everyone on the 'Balakot' effect that not much attention was paid to tens of millions of women who thanked the then ruling party for toilets, gas cylinders, pucca houses, electricity connections, Jan Dhan accounts and Mudra loans by voting in droves for the BJP. How do you think the BJP vote share jumped from about 31 per cent in 2014 to almost 38 per cent in 2019?Interestingly, the gap between

cent in 2009 to 1.5 per cent in 2014. And the BJP became the first party in 30 years to win a Lok Sabha majority. Even more interesting: the female voter turnout dropped significantly in the 2024 Lok Sabha elections as compared to 2019. And the BJP lost its majority. The message is stark: even misogynist politicians can no longer afford to underestimate the power of the female voter to make a decisive difference in elections. Mandal and mandir are considered to be turning points in the Indian electoral history, having irreversibly changed politics and elections in India. The growing role and power of the female voter, too, can be described as a historical turning point in Indian politics. Gradually, yet irreversibly, the female voter is no longer willing to follow the

diktats of a panchayat or a patriarch on whom and which party to vote for. She may not be as noisily aggressive as the female voter in the United States, but is still quietly enjoying her own agency.

For decades, savvy marketing professionals have realised that it is the woman who can make her family choose your brand. Savvy politicians, too, are now realising and recognising this reality. Caste, ethnic and religious identity do matter even today. But the female voter is demolishing these silos. A CSDS (Centre for the Study of Developing Societies) survey of the Maharashtra Assembly elections found that close to a quarter of Muslim women have voted for the Mahayuti. Another CVoter post-poll survey of Jharkhand has revealed that a large proportion of the upper-caste women

have voted for the "tribal" party, the Jharkhand Mukti Morcha (JMM).It is not just the Lok Sabha elections whose outcomes now depend on what women think and how they decide to vote. They, perhaps, play an even bigger role in determining the outcome of the Assembly elections in the states. And they do snub and reject the BJP if they are convinced that there is a better alternative. When the Assembly elections were held in Haryana in October, Congress candidate and champion wrestler Vinesh Phogat became a symbol of the resurgence of the Congress in the state. The outcome seemed a foregone conclusion, with almost everyone expecting a Congress sweep.

male and female voter turnout dropped from 4.5 per Unfortunately for the Congress, the 'silent' female



voter had other ideas. She seemed to have prioritised her satisfaction with the incumbent on important issues than get swayed by the Jat machismo. In the end, the BJP won 48 seats while the Congress had to be content with just 37 in a House of 90.

But the real impact and power of the female voter reverberated when the Assembly elections were held in Jharkhand and Maharashtra. In both states, analysts talked about strong anti-incumbency and anger at food inflation that eroded household budgets. Other analysts argued that the ruling incumbents in both states had played a trump card by implementing direct cash transfer schemes for women. It was the Ladki Bahin scheme in Maharashtra and the Maiya Samman Yojana in Jharkhand. In the end, these female welfare and

empowerment-oriented cash transfer schemes played a decisive role. What many analysts forget is that 'bribing' voters has been a factor in Indian elections since long. These were mostly confined to cash and liquor to males who would then 'decide' which way the family voted. Bypassing males and directly helping females is a relatively new phenomenon and is clearly paying rich dividends.

There is another factor that is being missed by most analysts while arguing about the growing power of the female vote. Almost all of it seems confined to just the impact of direct cash transfers. It is almost as if the female voter is concerned only with the cash in her bank account when she decides whom to vote for. That she is not concerned about other issues that

> would engage a male voter. At best, such an analysis is deeply patriarchal. Women have agency. They think independently. And while they do prioritise money in the bank (who doesn't), they also think about other issues. Once again, Jharkhand and Maharashtra provided telling examples. CVoter surveys in Jharkhand had been repeatedly showing that the arrest of Chief Minister Hemant Soren by the ED had backfired politically. Many local voters considered it to be an assault on their identity and pride. This added a multiplier effect to the Maiya Samman Yojana and the JMM-led alliance romped home.

Add to this the Kalpana Soren factor. Kalpana went out of her way to campaign for her husband Hemant Soren when he was in jail. A simple housewife, when asked to fill the vacuum of leadership in her party not only rose

to that occasion but also became the most potent and lethal campaigner in the moment of crisis. Yes, India remains a patriarchal society. The representation of women in the Lok Sabha and Assemblies is still abysmal. But while they are still to get elected in large numbers, they now decide who gets elected. Ten years back, they became one of the deciding factors of the election mandates. After the current round of elections, they have arrived as the dictating factor of the mandate. Now just wait for the 33 per cent reservation to become reality, and the politics of India will be forced to go beyond the realms of Mandal and kamandal. It is not a question of 'if' anymore but just a question of 'when' that will happen. Well, that 'when' actually happened

Priyanka consolidates Gandhi fief

THE glacial silence in the Congress party following its decimation in the Maharashtra Assembly polls last week tells you why Prime Minister Narendra Modi and his BJP continue to wield power across the country.In one word, it's because the Congress enables them to do so.Photos by The Tribune photographer Mukesh Aggarwal of a Congress Working Committee meeting in the capital on Friday unerringly captures this unwitting state of play in the grand old party. One photo shows the elderly president Mallikarjun Kharge, wrapped in his trademark muffler, obsequiously showing his younger colleague Rahul Gandhi, also in his trademark white T-shirt, a sheet of paper — instead of it being the other way round. Over the last six days, the airwaves have been full of tugs and pressures within Maharashtra's Mahayuti alliance on who is going to be the next chief minister, Devendra Fadnavis or Eknath Shinde. In contrast, the Congress seems to have rolled over and gone back to sleep. Some talk about Uddhav Thackeray exiting from the MVA alliance is roiling the state, but much of the sound and fury between the alliance constituents had actually come before the poll results had come in when they argued about who would be the chief minister of Maharashtra. Certainly, it's a remarkable state of affairs. The Congress and Rahul Gandhi regularly accuse the BJP of promoting Modi to demigod status – a fact the PM himself acknowledged in an interview to News18 in the run-up to the Lok Sabha election in Varanasi, when he said he "was convinced God had sent (me), as this energy cannot be from my biological body" — but the fact remains

that although it continues to lose one election after another, and Jharkhand is the exception rather than the rule, the Congress has simply refused to look inwards. The astonishing fact remains that the Congress' refusal to squarely point the finger at Rahul Gandhi's leadership allows Modi and the BJP to consolidate themselves in state after state. When the BJP lost its majority in Parliament this summer, it closely examined what happened, including why the RSS hadn't helped out. In the Haryana and Maharashtra polls that followed, it ensured it learnt from its mistakes — so it micro-managed every Assembly seat in Haryana to pull the rug from under the feet of an overconfident Congress and romped home in Maharashtra with the help of schemes like Ladki Bahin that guaranteed to put money directly into the bank accounts of women. In sharp contrast, the Congress has blamed the EVMs and put down its failure to "large-scale fraud". Instead of acknowledging failure, like all good leaders, Rahul led the charge in celebrating the win of his very charismatic sister from Wayanad — all very sweet, especially as the young lady showed up in Parliament in a traditional Kerala kasavu sari to take her oath as an MP in impeccably spoken Hindi.But look at it, really. There are now three Gandhis in the house mother Sonia in the Rajya Sabha, children Rahul and Priyanka in the Lok Sabha, he from the heart of Uttar Pradesh in Raebareli, she from the stunning southern hill district of Wayanad. Make no mistake, the family fief has gotten even stronger. The control of the Gandhis over the Congress has become even tighter. The anti-dynasty argument has been long



closed in Indian politics — every political party today, not just the Congress, is littered with the sons and daughters of their mothers and fathers supposedly fighting the good fight. We know the argument by now. That the people of India are so smart that they won't accept you, however entitled you are, if you don't work hard enough for them. The problem with the Congress is no longer dynasty. It is the fact that the Gandhis continue to insist on a 'mukhauta,' a man with a mask, a puppet, really, while the Family pulls the strings from behind. With her elevation to the Lok Sabha, Priyanka has joined the ranks of the puppeteers. As her mother, a remarkable woman who held the family together in the awful aftermath of her husband's assassination in

that tragic summer of 1991 and went on to give the Congress 10 years under the remarkable chairmanship of Manmohan Singh, fades from public life, her daughter has stepped up to the plate.It's irrelevant who the baton has been passed to, whether Sonia's son or daughter. Just the incredibly magnetic presence of the newest Gandhi in the House is enough warning that the Gandhis are no pushovers. That's why Priyanka matters. She may charge up the party and shake up politics. When she speaks in Parliament, she is sure to electrify the free-floating ions. She is unlikely, though, to rock the boat, because it is her brother who is steering it. This means that the Rahulled Congress would rather undermine the vote, both in Maharashtra and Haryana. Or that the brothersister duo are okay with cracks in the INDIA bloc as the Trinamool Congress pleads that Parliament be allowed to function this winter session — rather than climb down from Rahul's Adani-fuelled bugbear.

All this would be fine if the Congress had won a few states — after all, everyone loves a winner. But when it continues to lose and lose, the question why the Gandhis are so special and cannot be challenged like the G23 once thought it could, to its detriment has still not been properly answered. Certainly, no one will be more pleased with this development than Modi. He knows that when he taunts the Congress for its lack of inner-party democracy, he strikes a chord in millions of Indians. He knows and the country knows that the days of 'India is Indira' are long over, and if the Gandhis refuse to take responsibility, the grand old party will slowly wither and the mothballs take over.

An experiment was conducted in Sweden with nurses at a care home in Gothenburg. Initial reports said that nurses were happier and were more productive during a sixhour shift. However, when the timings were stretched to eight hours, they were relatively more tired, as reported by BBC.

It's not just the timings but also the continual work regime, without taking a break. Writing for the Huffington Post, Tony Schwartz quoted sleep researcher Nathaniel Kleitman, who discovered something called 'basic rest-activity cycle'. It suggests that our bodies work on a 90-minute period at night, shifting

Harassing employees may cut your well-being: Study

Communicating with workers may help supervisors by releasing negative emotions through sharing, receiving social support and gaining relational energy from their co-workers.

Are you a boss who bullies and belittles juniors? Beware, your well-being may be at risk, new research suggests. The researchers have found that supervisors who were abusive felt a sense of recovery because their boorish behaviour helped replenish their mental energy and resources."The moral of the story is that although abuse may be helpful and even mentally restorative for supervisors in the short-term, over the long haul it will come back to haunt them," said Russell Johnson, associate professor at Michigan State University (MSU).

According to the study published in the Academy of Management Journal, employees may not immediately confront their bosses following abusive behaviour, over time they may react in negative ways, such as engaging in counterproductive and aggressive behaviours and even quitting the job.



Researchers conducted multiple ield and experiments on abusive bosses in the US and China,

verifying the results were not culturespecific. They collected daily survey data over a four-week period and studied workers and supervisors in a variety of industries including manufacturing, service and education. The benefits of abusive supervision appeared to be shortlived, lasting a week or less. After that, abusive supervisors started to experience decreased trust, support and productivity from employees — and these are critical resources for the bosses' recovery and engagement.To prevent abusive behaviour, the researchers suggest supervisors take well-timed breaks, reduce their workloads and communicate more with employees.Communicating with workers may help supervisors by releasing negative emotions through sharing,

the researchers added

Delhi HC to CBI: Appoint officer in coaching centre deaths

NEW DELHI. The Delhi high court has directed the Central Bureau of officer to regularly monitor the investigation into the UPSC aspirants' death case at RAU's IAS Study Circle in Old Rajinder Nagar area. The directive

came in response to a petition filed by Dalvin Suresh, the father of one of the deceased students Nevin Dalvin, who had raised concerns over the fairness of the ongoing investigation.Justice Dinesh Kumar Sharma, in his order dated November 27, emphasised the need for balanced oversight."In order to balance the rights, director CBI is requested to appoint a senior officer to have regular monitoring of the investigation being conducted by the CBI. This court hopes and trusts that the CBI will maintain the faith of the petitioner," stated the court. The court

also acknowledged the petitioner's apprehensions about the investigation's integrity but refrained from issuing further directives. The petitioner had earlier approached the high court after his plea for replacing the investigation officer (IO) was dismissed by the Additional Chief Judicial Magistrate (ACJM), Rouse Avenue Courts.

Investigation (CBI) to appoint a senior The HC also remarked on the ACJM's observation that magistrates cannot monitor investigations under Section 156(3) of the Criminal Procedure Code.Justice Sharma clarified that while



magistrates cannot compel the CBI to register an FIR, they possess the authority to oversee investigations once initiated by the CBI."This Court considers that this observation of the learned MM [Metropolitan Magistrate] may not be in accordance with the law. Once the CBI has registered the case and is conducting an investigation, the concerned Court will have all the power to monitor the investigation in line with established legal principles," the court noted.Advocate Abhijit Anand, representing Dalvin Suresh, argued that the investigation lacked thoroughness, citing critical gaps

such as the failure to seize the building site plan and CCTV footage. He also alleged noncompliance with earlier high court directions."An impartial and comprehensive investigation is a fundamental right of the petitioner," the counsel said, urging the court to consider appointing an independent officer of at least Inspector General rank. The CBI refuted allegations of bias, maintaining that the investigation was conducted in a fair and lawful manner under

close supervision.It informed the court that two status reports had already been submitted to a division bench in sealed cover. Highlighting its internal monitoring mechanisms, the CBI assured the court that the investigation was being closely overseen by senior officials and monitored by the Secretary of the Central Vigilance Commission (CVC), following prior judicial directives. While dismissing the petition, Justice Sharma said, "This Court is conscious of the genuine concerns of the petitioner but trusts that the CBI will uphold its commitment to justice."

Everything changed the day I lost my son': For 3 women whose loved ones died cleaning sewers in Delhi, justice out of reach

New Delhi: Rajkumari, Ram Kali and Salesh Devi have each lost a loved one - a husband, a son on the job. The job? Cleaning Delhi's sewers. For one of them, promises of compensation have gone unfulfilled. For all three, justice remains elusive. They are not alone. The lives lost are among the 94 sewer deaths over the past 15 years in Delhi, but in 75 of those deaths, for which records are available, only one case has led to conviction in court, according to an investigation of RTI records by The Indian Express.The Indian Express tracked down and met the three women to know how their lives changed overnight and where their case stands it found a swell of despair and helplessness.

Case: Died cleaning a sewer in Rohini Sector 18 in 2011Case status: Accused (a junior engineer) acquittedCompensation: Rs 10 lakh received from the government"This system where people like us are expected to take up these jobs, it's unfair. But what can we do? We don't have the education to get better jobs or money to study further," Rampal's wife Rajkumari (50s), who lives in Delhi's Haiderpur village, said.

According to records, Rampal, who worked as a safai karamchari at a housing society, earning Rs 8,000 a month, died cleaning a sewer in front of the complex in Rohini's Sector 18 in 2011. In October 2018, the Rohini Metropolitan Magistrate Court acquitted the accused, a junior engineer (JE), citing a lack of evidence. It noted that the sewer had not been maintained by the Delhi Development Authority (under whom the area falls) and there were no witnesses to confirm Rampal was instructed to clean it under the JE's supervision.Rajkumari said she was unaware of the court's decision until now. "I was angry (about the way Rampal died) at first, but we just want to move on now," she said.

After Rampal's death, Rajkumari, who earned around Rs 5,000 working as a house cleaner, was left to raise their four children - Ravi, Rinki, Shivam, and Aditya — alone. Rinki completed a degree in Arts and works at a bank. The sons were forced to leave school after Class X to support the family, she said. Shivam works as a cleaner in a nearby society. Aditya is now a driver. Everything changed that day'

The police, who were passing through the area, decided to investigate further. Upon questioning the young man, he initially claimed to be a



member of the Indian Army but could not produce his ID card when asked.

He then stated that he had forgotten it at home. His evasive answers raised further doubts, leading to his detention and questioning at the police station. During the investigation, the man, identified as Sanjay Dodiya, a 10th-grade pass, confessed that although he had appeared for the army exam, he did not succeed. Driven by a strong desire to join the army, he began wearing a fake uniform, complete with a nameplate, and roamed around pretending to be an army officer. The police confirmed that he had not attempted to deceive anyone or use his fake identity for malicious purposes.Dodiya was arrested on charges of impersonating a public officer. Delhi Weather: November Warmest In 5 years, Temperature Dip Likely Next Week

The average minimum <u>temperature</u> tor November has been <u>14.9</u> degrees Celsius.

New Delhi. Continuing the trend of warmeremerged as the warmest in the last five years, with the highest day and night temperatures.

This is the most delayed dip below 10 degrees Celsius since 2019, when this happened on December 1, according to the India Meteorological Department (IMD) data.The average minimum temperature for November has been 14.9 degrees Celsius, nearly 2 degrees Celsius above the long-period average (LPA) of 13 degrees Celsius.Similarly, the average maximum temperature stood at 29.5 degrees Celsius, 1.1 notch above the LPA, marking this as the warmest November since 2019. The sharp decline in minimum temperature began on November 25, when it stood at 14 degrees Celsius and dropped steadily due to strengthened cold northwesterly winds and clear nighttime skies. The temperature fell to



11.9 degrees Celsius on November 26, 10.4 degrees Celsius on November 27 and 10.1 degrees Celsius on November 28, before dipping below the 10-degree Celsius mark on Friday for the first time this season. Speaking over the weather conditions, IMD officials said while the current cold spell is typical for late November, the season has been characterised by overall warmer-than-usual conditions due to a lack of significant rain

and snowfall. A temporary rise in nighttime expected over the weekend due to a western disturbance influencing northwest India, with another dip likely early next week as snowfall occurs in the northern hills.Meanwhile, October too had been warmer than usual, as the city recorded its warmest October this year since 1951, with both days and nights recording nearly 2 degrees Celsius higher than normal on average. The average monthly maximum and minimum temperatures in October were 35.1 degrees Celsius and 21.2 degrees Celsius respectively, the highest since they were 36.2 degrees Celsius and 22.3 degrees Celsius respectively in 1951, according to the data.Additionally, on Friday mercury dipped below the 10-degree Celsius mark for the first time this winter season, with Safdarjung, which is representative of Delhi's weather, recording.

Reinstating bus marshals: Contentious issue that has spilled into AAP's 2025 Delhi poll campaign

NEW DELHI. The termination of services of over 10,000 bus marshals last November on grounds of improper recruitment has become a contentious

issue between the AAP government and the Opposition BJP, triggering protests and heated exchanges in the past year. More recently, it has led to disruptions during former chief minister Arvind Kejriwal's campaign rallies, making it a focal point during the Delhi polls slated for early next year. At a rally in Burari on Friday, Kejriwal's speech was interrupted by Mukesh Pal Singh, a bus marshal, as he

raised slogans and pleaded for his reinstatement.After inviting him to the stage, Kejriwal said, "This brother is a bus marshal. I and my party are the ones fighting for you; no one else will. In Gujarat, even police officers are on temporary contracts. The BJP never makes anything permanent."

On Saturday, a man named Ashok Jha, who police said was a bus marshal from



Khanpur depot, attempted to "attack" Kejriwal while he was greeting the crowd during a padyatra at Malviya Nagar in Greater Kailash.Sachin Bharwal, a representative from the Bus Marshal Pratinidhi Mandal, said: "In the fight to take credit for the redeployment of bus marshals, our futures are at stake. Both parties are deliberately creating hurdles for each other, and an issue that could have been easily solved is being delayed. Even

among bus marshals, many people have started taking sides of parties, which will only weaken our movement.'

o prevent incidents of misbehaviour towards women in DTC buses, the bus marshal scheme was introduced in 2015. Initially, 3,356 civil defence volunteers (CDVs) were deployed as marshals, and following a 2019 recommendation by a task force on women's safety, the vacancies were increased to over 13,000,

with over 10,000 appointed in subsequent years. However, in November 2023, the services of these 10,000 bus marshals were abruptly terminated after the Revenue and Finance departments said that their deployment as bus marshals did not align with the Civil Defence Act, 1968. Since then, the dismissals have fueled a blame game between the AAP-led Delhi government and the Centre-appointed L-GVK Saxena.

Claim rejections have come down to 25% till November: **EPFO**

NEW DELHI. The Employee Provident Fund Organisation (EPFO) has reduced the rejection of claims to 25% till November 2024, the organisation informed the Central Board of Trustees (CBT) in its meeting on Saturday in New Delhi"As of 26 November 2024, the combined rejection and return ratio was 21.59%. This includes 13.77% inadmissible claims, and returns (deficiency in claims) stood at 7.82%. The final withdrawal claims reflect 11.92% rejections and 13.44% return cases," the EPFO recently said in a post on social media platform X.In 2022-23, the combined rejection and return ratio was 34%, while in the year before, the claim rejections had touched 35%. Claims are rejected when the claimant is not eligible for the type of advance or withdrawal. Claims are returned if there is any deficiency. Returned claims can be resubmitted after corrections. The Board appreciated the fact that rejection ratio (excluding returns) has come down to 14% in November 2024. During the 2023-24, EPFO settled 4.45 crore claims for an amount of Rs 1.82 lakh crore.In the current financial year, 3.83 crore claims have already been settled for more than Rs 1.57 lakh crore, the CBT was informed. FPIs' selling spree continues in Nov at Rs 21,612 crore

Foreign investors pulled out Rs 21,612 crore (USD 2.56 billion) from the Indian equity market in November, mainly due to the rising US bond yields, strengthening dollar and expectation of a slowdown in the domestic economy. While the sell-off continues, the quantum of net outflow significantly reduced compared to October, when FPIs recorded a massive withdrawal of Rs 94,017 crore (USD 11.2 billion). With the latest pull out, Foreign Portfolio Investors (FPIs) have experienced total net outflow of Rs 15,019 crore in 2024 so far. Looking ahead, the flow of foreign investments into Indian equity markets will hinge on several key factors. These include the policies implemented under Donald Trump's presidency, the prevailing inflation and interest rate environment, and the evolving geopolitical landscape, Himanshu Srivastava, Associate Director Manager Research, Morningstar Investment Research India, said.

Additionally, the third-quarter earnings performance of Indian companies and the country's progress on the economic growth front will play a crucial role in shaping investor sentiment and influencing foreign inflows, he added.According to the data, FPIs recorded a net outflow of Rs 21,612 crore in November. This came following a net withdrawal of Rs 94,017 crore in October, which was the worst monthly outflow. However, in September, foreign investors made a nine-month high investment of Rs 57,724 crore.Market analysts attributed the latest outflow to the rising US bond yields, strengthening dollar and expectation of a slowdown in the domestic economy. Overall, November experienced net outflow but FPIs staged a notable reversal at the beginning of the week ended November 29, due to lecisive victory of the BIP-led Mahayuti alliance in the Maharashtra Assembly elections. The resulting political stability appears to have strengthened investor confidence, Srivastava said.

Another factor that contributed to his buying activity is the rebalancing of MSCI's key indices, which added few select Indian stocks in its index. Further, a glimmer of hope for ceasefire between Israel and Lebanon may have also positively influenced market sentiment, particularly from a geopolitical standpoint, he added. A perplexing feature of the recent FPI activity is their highly erratic nature. For instance, during November 23-25, FPIs were buyers, however, in the next two days they again turned massive sellers having sold equity worth Rs 16,139 crore, V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said.

Real estate developers' luxury push continues even as launches below Rs 2.5 crore slow down

NEW DELHI. After growing at a robust 52 per cent annually since the Covid-19 pandemic, residential launches across India's top real estate markets fell by 2 per cent in the first three quarters of 2024 compared to the same period in 2023. This marks the sector's first slowdown since the post-2020 boom, with just one ticket size bucking the trend-luxury units priced above Rs 2.5 crore.

The growing premiumisation of India's residential real estate sector amidst easing demand is also evident in sales, which fell by 3 per cent year-on-year (y-o-y) between April and September 2024, while the average ticket size of units sold grew by 23 per cent, an analysis of data from Anarock showed. In the Delhi-NCR market, where demand for luxury housing is especially pronounced, sales fell by 0.6 per cent while the average price of units sold surged by 56 per cent. The first signs of a slowdown in residential real estate mirror recent concerns around waning urban demand across sectors, from automobiles to consumer goods. Major developers have announced plans to transition away from affordable housing as they no longer see a business opportunity in the segment. Even in the upper-end Rs 1.5-2.5 crore segment, launches fell by 15 per cent yo-y in the first three quarters of 2024, as against doubling each year between 2020 and 2023.

Catching fast: Quick commerce is here to stay

BENGALURU. A few years ago, when the concept of quick commerce, a business model where goods are delivered within 10 minutes to 1 hour, started gaining Also, for FMCG companies, q-commerce traction, venture capitalists and even a few start-up founders raised questions on the model and wondered whether it is scalable, and do customers really require 10 minutes delivery.But in 2024, all major ecommerce companies are betting big on quick commerce as customers' preferences have changed over years. Not just groceries, major q-commerce players such as Blinkit and Zepto have extended their services in many categories and have introduced new features. From LEGO sets to sports, gym equipment, yoga needs and travel bags, Zomatobacked Blinkit delivers everything in 10 minutes.Now, Amazon India mulls foraying into the quick commerce space early next year with Tez. Swiggy shares got listed on the exchanges on November 13 at around Rs 420. Swiggy said in its draft offer documents filed with SEBI that the assortment of non-grocery items available on Instamart has been growing. The category contribution to the assortment has increased from 18.20% in

FY22 to 25.28% in June quarter of this year. This shows non-grocery items' growth and popularity among users.

emerges as a fastest growing channel. Nestle India recently said that qcommerce is 50% of its e-commerce business and that it is the fastest channel of growth. Tata Consumer saw its festive sales increase through q-commerce.

According to a Nielsen IQ Shopper Trends 2024 Report, 31% of Indian shoppers now rely on quick commerce for their main grocery needs, while 39% use it for top-up purchases.Among the popular categories, 42% of shoppers use quick commerce for Ready-to-Eat meals, and 45% for Salty Snacks."Like any other sector, FMCG companies are also experiencing significant benefits from the rise of q-commerce, focusing heavily on ultra-fast deliveries. This shift is being driven by changing consumer expectations and the need for speed in delivery, leading to substantial growth in e-commerce sales," says Somdutta Singh, angel investor, Founder and CEO of Assiduus.Singh adds that quick commerce enables FMCG brands to

penetrate urban micro-markets.For instance, by utilizing local warehouses or dark stores, companies can ensure faster deliveries and better serve densely populated areas."This strategy not only improves service speed but also allows brands to access new customer bases that value quick service. The immediacy of qcommerce encourages impulse purchases, as consumers are more likely to buy items on a whim when they know they can receive them almost instantly," she says."This can significantly boost average order values, particularly in categories like snacks and personal care products. Also, quick commerce allows FMCG companies to reduce reliance on traditional retail channels, streamlining their supply chains and potentially increasing profit margins by eliminating intermediaries," Singh explains.

Expansion of dark stores

A strong network of dark stores (which is a retail distribution centre for online orders) is essential for quick commerce players, especially to increase its market share. Quick commerce companies are raising money to invest in dark stores. In just six months, Zepto announced three

fundraising rounds and in the latest round, it raised \$350 million.Quick commerce logistics enabler Blitz recently raised Rs 40 crore in Series A funding led by IvyCap Ventures to enhance its 60-minute delivery infrastructure and expand its dark store network across the country's top 20 cities. Yash Sharma, Co-founder of Blitz told TNIE that Blitz is committed to empowering marketplaces and brands with 60-minute delivery capabilities, setting the stage for 10x growth in FY25. "Quick commerce in India is currently a \$3 billion market, representing just 5% of the total e-commerce space. Having grown 3x in the past two years, it is projected to become a \$30 billion industry within five years," he said.

Talking about various challenges, he said many brands lack the infrastructure to enable quick commerce on their platforms, resulting in lost sales. Nearly 30% of customers abandon carts due to slow delivery timelines, highlighting a critical gap. Vikram Gupta, Founder and Managing Partner, IvyCap Ventures, pointed out that they are seeing opportunities in this space as the market is expected to grow significantly.

COP29 in Baku: Oil and money stain climate talks

NEW DELHI. It is indeed ironical the UN Climate Conference, also known as the Conference of Parties (COP), chooses to hold their jamborees in capitals that are the hub of fossil fuel interests. The World, desperately fighting Climate Change and global warming, held its 200-nation gathering in December 2023 in Dubai; and now COP29 has just concluded in Baku, Azerbaijan - the oldest oil exploration town existing since 1840!

The President of Azerbaijan, Ilham Aliyev, opened COP29 on 11 November, The Baku conference seemed doomed from embarrassingly referring to the country's oil wealth as "the gift of God" to his people. What could he say? Oil represents 90% of Azerbaijan's exports.

It was billed as a 'finance conference'. The focus of the summit this year was to get the developed world to agree to a new target of funding pegged at \$1.3 trillion a year. It was to help the poorer nations to move away from fossil fuels and to repair the climate change havoc wrought on communities around the world.

There's been a history of skirmishing between the rich and poor nations on who will pay for the environmental damage.

With much back-and-forth, a deal was finally reached in 2009 at the Climate Conference in Copenhagen when the rich nations agreed to raise \$100 billion by 2020.Expectedly, the developed world reneged from its commitments, and it was only in 2022 that the target was met when funding touched \$106 billion. Much of this was disguised low-interest loans, something the poor nations had not bargained for.

Poor compromise

the start. The demand for \$1.3 trillion a year by the Global South was met with derision by the rich nations. At one point, representatives for the Alliance of Small Island States (AOSIS) walked out of the summit, after dismissing an offer of \$250bn from richer countries. It seemed the climate catastrophe was not registering. Tuvalu, a small south Pacific island nation, was facing submergence with rising tides, but who cares?

In this melee of spats and protests, by 24 November, when the conference was supposed to close, there was no agreement. The differences were so sharp



that Mukhtar Babayev, the Azerbaijan environment minister, also president of the Conference, had two speeches in hand when he walked up for his closing remarks. But the rich nations, with a push from China and India, finally delivered. The gavel came down with the adoption of the rich nations' proposal to raise \$300 billion a year by 2035.It was a bitter compromise for the poor natins. Most environmental groups said it would have been better not to have any deal at all; but a deal is always better than no deal, as it let's one build on it.

India and China

India led the developing countries at COP29, and continued to reiterate the demand for raising funding to \$1.3 trillion

\$300 billion, India's delegate Chandni Raina, in a fierce speech called the deal "paltry" and "nothing more than an optical illusion", and unable to "address the enormity of the challenge we all face."

However, as the world's third biggest emitter and fifth biggest economy, India has been caught in a cleft between advocating renewable energy and continuing a legacy of electricity generation that relies heavily on coal power plants. India generates 80% of its electricity from coal-fired plants, and it is rising. In January 2024, coal-fired electricity generation in India reached a record high of 115 terawatt hours (Twh), a 10% increase from the same month in 2023. This was reflected in India's ambivalence at COP29 - fierce public opposition to the final deal, but not pressing too many objections in the intervening days at the conference. India was keen for a deal as climate finance could bolster its transition to a cleaner economy. In the process, though it slammed the "paltry" \$300 billion, it did not veto the deal; and.

2nd Test: Shadman hits fifty, West Indies drop 3 catches on raintruncated day 1

New Delhi. Kemar Roach gave the West Indies a strong start on the rain-affected opening day of the Kingston Test, dismissing two Bangladesh batters early. However, sloppy fielding cost the hosts crucial breakthroughs, as three dropped catches allowed Bangladesh to recover and end the day at 69 for 2. Shadman Islam, who reached an unbeaten 50, and Shahadat Hossain, not out on 12, capitalised on the missed opportunities to stabilise the innings after an initial collapse

The match began five hours late due to a damp outfield, forcing a 3 p.m. local time start under sunny skies. Bangladesh, sent in to bat by captain Mehidy Hasan Miraz, found themselves in early trouble as Kemar Roach struck twice within the first seven overs. Roach, who continued his dominance over Bangladesh, dismissed Mahmudul Hasan Joy for two with a sharp edge caught by wicketkeeper Joshua Da Silva and then induced another edge from Mominul Haque, who departed for a duck — his fourth in the West Indies. These early blows left Bangladesh reeling at 10 for 2. However, Shadman Islam (50 not out) and Shahadat Hossain (12 not out) dug in to steady the



innings. Shadman was the beneficiary of two dropped chances, first by Alick Athanaze at slip on 15 and later by Kraigg Brathwaite at short cover on 35. Shahadat also enjoyed a reprieve on 8, thanks to a comical double-drop in the slip cordon involving Athanaze and Kavem Hodge. The slow, rain-affected outfield further hampered scoring, with several boundaries thwarted just short of the ropes. Shadman, however, managed to bring up his fifty off 100 balls, laced with three fours and a six, while Shahadat played cautiously, adding just one boundary in his 63-ball stay.

For the West Indies, Roach (2-19) was the standout performer, reaching the milestone of 50 wickets against Bangladesh. However, the home side's lackluster fielding undid much of the pressure created by their bowlers. Rain remains a looming threat fr the rest of the match, with forecasts predicting interruptions on each of the remaining days. Bangladesh will hope their overnight pair can build on the modest foundation, while the West Indies will need to regroup and capitalize on any further opportunities that come their way.

Gautam Gambhir's stint as India coach shouldn't be judged too soon: Ajay Jadeja

New Delhi. Former Indian batter Ajay Jadeja has urged critics to exercise patience with Gautam Gambhir, the newly appointed head coach of the Indian cricket team, amidst the backlash following India's 0-3 home Test series loss to New Zealand. Jadeja, however, believes it is premature to critique Gambhir. "I think you are being unfair to him... If you will start judging



people on the basis of their coaching role or whatever way it is being looked at, it is too short a time for people to be judged," Jadeja remarked. The former middle-order batter, who amassed over 5000 ODI runs, further elaborated, "There are phases in cricket. Sometimes you win, and sometimes you lose. Gambhir has always been a straightforward individual, and what you see now is what was expected of him. It's not time to judge him; it's time to enjoy his approach."India's morale received a significant boost with a dominant 295-run victory over Australia in the first Test of the Border-Gavaskar series in Perth, following the New Zealand debacle. Jadeja highlighted that this win showcases the team's resilience and stressed that Gambhir's leadership should be evaluated over a more extended


