# Iron Age began in Tamil Nadu, says Chief Minister MK Stalin

The Tamil Nadu government announced groundbreaking archaeological research that revealed iron production origins in the state. **According to Chief Minister** MK Stalin, the latest research challenged existing historical understanding of the Indian subcontinent.

Tamil Nadu. Tamil Nadu Chief Minister MK Stalin, on Thursday, revealed that the Iron Age began in the region, much earlier than previously believed. The Chief Minister made the announcement in Chennai at the launch of 'Irumbin Thonmai' (meaning Antiquity of Iron), a book on the beginning of Iron Age in Tamil Nadu.

"I'm making an important announcement," he said during the event. "Based on research, the introduction of iron has been pushed back to 4000 BC, with specimens sent to prominent research

centers in Pune, Ahmedabad, and a renowned international research facility in Florida."

"â Melting iron was introduced in Tamil Nadu 5300 years ago.. . â These research findings



were sent to scholars who are also present here and they have appreciated Tamil Nadu government's efforts," he said.

Precise dating indicates iron was first introduced in the region in 3345 BC. Stalin emphasised this finding to be pivotal to understanding the historical timeline of the Indian subcontinent. "I'm constantly saying that the history of India will

be written from Tamil Nadu," Stalin stated, highlighting the research's potential to reshape historical narratives. The Chief Minister urged Minister Thangam Thennarasu and relevant officials to continue this groundbreaking research, which he believed provided new enthusiasm to scholars studying ancient technological developments.

He also made the same announcement on X."Based on results from world-renowned institutions, the use of iron in Tamil Nadu dates back to the beginning of 4th millennium B.C.E., establishing that iron usage was prominent in South India over 5,300 years ago," he wrote in a post on the social media platform.

Stalin, on Wednesday, had created suspense about a "significant archaeological discovery" through a post on social media platform X.

"An important announcement will be made tomorrow (Thursday)," he wrote in the post,

Those who can, please attend. Others, watch it live online." The Chief Minister was reposting a message by the Finance and Archaeology Minister Thangam Thennarsau.

## Revanth Reddy aims to secure projects worth Rs 1 lakh crore at Davos summit

New Delhi. Telangana Chief Minister Revanth Reddy addressed the state's progress in securing investments since his last visit to the World Economic Forum in Davos, where he signed proposals worth Rs 40,000 crore. In an interview with India Today TV, Reddy also took a swipe at BRS working president KT Rama Rao by calling him an IT employee with a "worker mindset".

Speaking to India Today News Director Rahul Kanwal, Reddy said, "Fourteen companies have signed MoUs with the Telangana government for 18 projects. Of these, 17 are in the pipeline, while one, the Adani pump storage project, is pending. After securing Rs 40,000 crore in investments last time, we have returned to Davos with an aim to secure projects worth Rs 1 lakh crore.'

Asked about Chandrababu Naidu's presence in Davos, Reddy dismissed any notion of rivalry. "Sunil Gavaskar and Sachin Tendulkar are legends, but the time has come for Virat Kohli now. Times have changed, and so has the leadership," he said. "I do not compete with Andhra Pradesh,



Maharashtra, or Karnataka. My competition is with global cities like New York, Tokyo, Dubai, and Singapore." Highlighting Telangana's appeal to global investors, Reddy pointed to Hyderabad's ecosystem. "Any investor seeks protection for their investment and profits. Hyderabad offers a

proven environment for business. It is centrally located, providing connectivity, and excels in IT, pharma, and AI sectors. Our policies and ecosystem are designed to foster business growth," he said. On what sets Telangana apart, Reddy mentioned amendments to investment policies and focusses on areas like green energy, defence, AI, and quantum computing. "For example, three COVID-19 vaccines were developed in India. and one was produced in Telangana. Former Prime Minister PV Narasimha Rao, who initiated liberalisation, privatisation, and globalisation, was from Telangana," he said.

When asked about political opposition, Reddy downplayed challenges from the BRS and BJP. "Elections are four years away. For now, my focus is solely on development," he said.

On this year's achievements at the World Economic Forum, Reddy said the focus was on data centres, green energy, and AI. "Davos is not just a place for securing investments but also for learning," he

Mumbai. The event, held at the statue of Bal Thackeray in Fort, Mumbai, saw a massive turnout of party workers and supporters who offered floral tributes. The Thackeray father-son duo garlanded the statue and paid respect to Bal Thackeray, who earned the epithet 'Hindu Hriday Samrat' for his staunch advocacy of

Hindutva and Marathi pride. Prime Minister Narendra Modi and Home Minister Amit Shah also joined the tributes. In a post on X, PM Modi stated, "I pay homage to Balasaheb Thackeray Ji on his birth anniversary. He is widely respected and remembered for his commitment to public welfare and towards Maharashtra's development. He was uncompromising when it came to his core beliefs and always contributed towards enhancing the pride of Indian culture."



Amit Shah echoed the sentiment, tweeting in Hindi. "Devoted throughout his life to Sanatan culture and nationalism, respected Balasaheb Thackeray ji always gave priority to patriotism in his work. Bal Thackeray's birth anniversary also took on political overtones, with the two Shiv Sena factions—one led by Uddhav Thackeray and the other by Maharashtra Chief Minister Eknath Shinde—set to organise separate rallies. Both groups are looking to assert their claim over the Shiv Sena supremo's legacy ahead of the upcoming civic elections in the state, including for the Brihanmumbai Municipal Corporation (BMC), which the party controlled for nearly three decades.

Born on January 23, 1926, Bal Thackeray was a cartoonist turned firebrand leader who founded the Shiv Sena in 1966 to champion the rights of Marathi-speaking people and advocate Hindutva. Under

his leadership, Shiv Sena grew into a dominant political force in Maharashtra. Balasaheb's larger-than-life persona, uncompromising stance on issues, and fiery oratory earned him devoted followers and the title of "Hindu Hriday Samrat." New Delhi. The Election Commission of India (ECI) officially granted the status of 'recognised political party' to Andhra Pradesh Deputy Chief Minister Pawan Kalyan's Jana Sena party. The party made this announcement on social media platform X on Wednesday (January 22). The party now has "glass tumbler" as the permanent official election symbol of the party, as reserved by the ECI. The communication about the recognition was done via a letter on

Tuesday, the Jana Sena party revealed. 'Jana Sena emerged as a recognised regional political party. The Election Commission has issued orders recognizing the glass symbol as a permanent symbol of Jana Sena Party,

which created history with the historic victory achieved in the last elections. The struggle (of) Pawan Kalyan for over a decade culminated in the Jana Sena Party being acknowledged as a recognized political party," it

said in a statement posted on X. This is a first for the Jana Sena Party. So far, it was only registered as a political party in Andhra Pradesh. Now 10 years after its inception in March 2014, it has the recognition as a state political party. Jana Sena achieved this recognition by securing 100 per cent success in the recent elections: both Lok Sabha as well as the Assembly polls. It won all 21 state constituencies and the two Lok Sabha constituencies it

## S Jaishankar's one-liner on front row seat at Trump's swearing-in

New Delhi. External Affairs Minister S Jaishankar was at his quippy best when asked about his prime front-row seat at Donald Trump's inauguration as the 47th President of the United States on January 20. 'Special Envoy of Prime Minister Narendra Modi is naturally treated very well," Jaishankar said with a smile during a press conference in Washington DC on Thursday. The 70-year-old diplomat represented India at the swearing-in ceremony at the invitation of the US government and carried a letter from Prime Minister Narendra Modi to Trump. He described the gesture as a reflection of the Trump administration's eagerness to bolster India-US ties.



"I would say, one, it was very clear that the Trump administration was keen to have India present at the inaugural itself, and they're clearly prioritising the bilateral relationship," Jaishankar said.

During his three-day visit to Washington, Jaishankar engaged in high-level meetings, including bilateral talks with Secretary of

State Marco Rubio and National Security Advisor Mike Waltz. He also participated in the first Quad ministerial meeting of the new Trump administration alongside counterparts from Australia, Japan, and the United States."Clearly there is an interest in taking the relationship forward," Jaishankar said.

The Prime Minister had a very early phone call with President Trump, and I had come last month and made the initial contact with the NSA. So, it should give you a direction in which the relationship is going."

laishankar said it was evident that the White House under Trump was willing to build on the foundation established during his first term, and that at present, there is a "very strong degree of trust" and "high level of convergence of interests" between India and the United States."Between us and the Trump administration, we approach the world both with a clear sense of our national interest belief," he

# Jalgaon train tragedy eyewitness recounts how tea seller spread fire rumour

> Dozens jumped off the Pushpak **Express after** a tea seller spread a rumour that the train had caught fire, an eyewitness recalled.

New Delhi. In a tragic incident in Maharashtra's was passing, and tragically lost their lives as Jalgaon district, 13 people were crushed to death after several passengers of the Pushpak However, the situation could have been even Express jumped off their coach due to a suspected fire and were struck by another train. An eyewitness claimed that the panic was sparked by a tea seller who falsely claimed there was a fire and pulled the train's emergency chain, prompting passengers to jump off the train in fear. The accident DETAILS OF THE ACCIDENT occurred when passengers aboard the 12533 The accident occurred between Maheji and Lucknow-Mumbai Pushpak Express, fearing a fire, jumped off their coaches and were run over by the Karnataka Express, which was passing on an adjacent track.

An eyewitness, Babadeep Shobharam Paswan, recounted the chaos, saying, "A tea seller started the rumour by claiming the train had caught fire. He himself pulled the emergency chain, and as the train slowed down, passengers began jumping out in a desperate attempt to save their lives.'

He further said, "Some people jumped directly onto the track where the Bangalore Express

worse, as the eyewitness noted that dozens of other passengers who jumped in the opposite direction were saved because there was no track there. "If they had jumped on the track side, the death toll would have been

## even higher," he added.

Pardhade stations near Pachora town in North Maharashtra around 4:45 pm on Tuesday, when the Pushpak Express came to a halt after someone pulled the emergency chain. Central Railway officials confirmed the details of the incident.

Dilip Kumar, Executive Director of Information and Publicity at the Railway Board, denied that any spark or fire inside the coach prompted the passengers to pull the alarm. "Based on the information we have received, no fire or spark was observed inside the coach," Kumar stated



#### 13 KILLED, AID ANNOUNCED

The death toll rose to 13 on Wednesday, as several of the injured passengers succumbed to their injuries. Special Inspector General of Police Dattatraya Karale confirmed that eight of the 13 victims had been identified, including two through their Aadhaar cards.

The Commissioner of Railway Safety for the Central Circle will conduct an investigation into the circumstances that led to the deaths.

"Of the 13, we have identified eight bodies so far, including two from their Aadhaar cards," Special Inspector General of Police Dattatraya Karale told media. The Commissioner of Railway Safety, Central Circle, will probe the circumstances leading to the mowing down of the 13 passengers.

Prime Minister Narendra Modi offered his condolences over the tragic train accident in Jalgaon. "Anguished by the tragic accident on the railway tracks in Jalgaon, Maharashtra. I extend my heartfelt condolences to the bereaved families and pray for the speedy recovery of all the injured. Authorities are providing all

possible assistance to those affected," the Prime Minister's Office stated in a post on X. The Railway Ministry announced ex gratia of Rs 1.5 lakh each for the kins of the deceased in

the Jalgaon train accident. 'Ex gratia of Rs 1.5 lakh each has been announced for the kins of the deceased in the Jalgaon train accident, Rs 50,000 to the people who are seriously injured and Rs 5,000 to the people who have sustained minor injuries," as per an official statement from Railway

#### Aero India: No meat ban around Yelahanka, claim hoteliers

BENGALURU. After backlash from hoteliers against Bruhat Bengaluru Mahanagara Palike's (BBMP) order of shutting down hotels and outlets serving non-vegetarian food for 26 days ahead of Aero India 2025, Bangalore Hotels Association claimed that BBMP Chief Commissioner Tushar Girinath has withdrawn the order. While there was no official ban withdrawal order issued from the BBMP on Wednesday, sources in the Palike said their request is under consideration and no official decision has been taken on revoking the ban

The air show is set to be held at Air Force Station at Yelahanka from February 10 to 14 and as a regular practice, a ban on meat is enforced in areas around the venue to prevent bird strikes, as discarded meat and food waste will attract scavenger birds that



pose a serious threat for aircraft operations. In a press release issued on Wednesday, the association urged Girinath to revoke the order, highlighting that the closure of over 5,000 hotels, restaurants, pubs and bars in Yelahanka from January 23 to February 17 would significantly impact the public.

President of the Bangalore Hotels Association PC Rao said Girinath withdrew the closure order after their appeal.

#### Orissa HC quashes FIR against 5 students, orders jail visit for reform over assault case

CUTTACK. The Orissa High Court has quashed an FIR against five students on the condition that they will visit a jail, observe living conditions of the prisoners and submit a report. The FIR was registered against the five, all students of a college in Cuttack city, for assaulting and threatening to kill a classmate. In the order, Justice Sibo Sankar Mishra said subjecting the petitioners who are young students pursuing their graduation 'to the rigors of the trial would be a futile exercise', and quashed the FIR subject to conditions."The petitioners shall visit Choudwar Jail, Cuttack within two weeks from today, compile a report regarding the hygiene maintained on the jail premises and suggest positive measures regarding the same. They must furnish their suggestions to the jail superintendent and obtain a certificate from him to be filed before this court within four weeks from today," Justice Mishra said in his January 16 order, while quashing the FIR. The FIR was registered at Madhupatna police station on the basis of a complaint filed by the victim's father on December 30, 2024. The petitioners were directed by the HC to tender unconditional and unqualified written apologies to the informant, father of the victim and file those written apologies before the court within 10 days."By visiting the jail premises, they need to realise the living condition of the prisoners in the jail; that experience will impel them to come out from the cocoon of their comfort to perceive the hard reality of life, and value human dignity and nudge into a positive direction and reform themselves into a good citizen," Justice Mishra observed. The five students and the victim's father appearing before the HC jointly prayed for quashing of the FIR. Replying to the court's query, the victim's father stated that he lodged the FIR to teach the students a lesson so that in future they would not indulge in such activities.

# Marching rivers snatch away livelihood, displace villagers in Odisha's Aul and Rajkanika

KENDRAPARA. Kharasrota and Brahmani rivers are fast devouring vast tracts of land, snatching away livelihoods and displacing a large number of people in Aul and Rajkanika blocks of the district. Over the decades, villagers have been helplessly watching the marching rivers consume their agricultural land and houses with an accelerated pace.

Mahendra Patra of Ichhapur village in Aul used to live in a three-room thatched house. Six months back, the house was devoured by Kharasrota river. "Only a small portion of our house remains. Considering the intensity of the river erosion, the whole village may disappear from the map within a few years," said Mahendra.

Rajendra Mallick of Bijaynagar said he lost two acre of land to Kharasrota five years back. "The river has rendered me landless and snatched away my livelihood," he rued. Villagers said Kharasrota has already devoured many villages in the last three decades. Absence of stonepacked river embankments is the main reason behind the increased erosion, they claimed.Similar is the situation of villagers residing near Brahmani river. Brajakishore Rout of Bajapur village in Rajkanika said, "Brahmani flows just 200 metre away from our house. We lost our farmland 10 years back due to river erosion. Now, our house is facing the threat."The river has reportedly gobbled up 70 per cent of Bajapur, nearly half of Siko and 60



per cent of Singirimukha village. It has also devoured around 90 per cent of Pandurikoli village in Rajkanika block.Senior Congress leader and former Aul MLA Devendra Sharma said river erosion is causing mass migration in the region. A large number of villagers are forced to leave their native place to save themselves from the marauding rivers. Many have also lost their livelihoods, he claimed.

Superintending engineer of Irrigation department, Kendrapara Umesh Sethi admitted that river erosion was a serious problem in the riverside villages. "The authorities have already completed stone-packing works to protect some of the villages from the onslaught of the rivers. We will stone-pack the river embankments in other villages after getting funds from the government," he added.

Additional district magistrate (ADM) Nilu Mohapatra said at the natural calamity meeting held a few months back, the administration chalked out plans including stone-packing of embankments to protect the villages affected by

# APSRTC earns Rs 23 crore on single day sans fare hike during Sankranti

VIJAYAWADA. The Andhra Pradesh State Road Transport Corporation (APSRTC) operated an unprecedented 9,100 additional buses during the Sankranti festival season to meet soaring passenger demand, ensuring smooth travel across the State and neighbouring States.

This massive operation, conducted between January 18 and January 20, resulted in an all-time high single-day revenue of Rs 23.71 crore, according to APSRTC Vice Chairman and Managing Director (VC and MD) Ch Dwaraka Tirumala Rao. With an advanced strategy to accommodate the festival rush, APSRTC deployed 7,200 special services initially and added 1,900 more buses during peak travel days such as Saturday and Sunday. Rao highlighted the efforts of the entire RTC



team, including drivers, conductors, and depot staff, for efficiently managing the operation.He said, "Our primary goal was to ensure that no passenger faced inconvenience during this period." The Sankranti season saw over 60% of travellers heading to Hyderabad, while the rest

opted for destinations like Bengaluru and Chennai.Many passengers, especially software and private sector employees, favoured APSRTC buses due to their fair pricing compared to private operators, who reportedly doubled ticket costs during the festive season. He said the role of a passenger demand survey conducted in advance, which allowed the corporation to optimise routes with high demand.Real-time monitoring and coordination at bus stations played a crucial role in the seamless execution.

While the revenue figure of Rs 23.71 crore on January 20 turned heads, the overall income during the festival season is estimated to exceed Rs 150 crore, marking a major achievement for

### Disappearance of Odia navy officer shrouded in mystery

BERHAMPUR.A young officer of the Indian Navy has reportedly gone missing under mysterious circumstances after he left his home at Berhampur for Kochi Naval base on January 19. The 25year-old navy officer, identified as Saurabh Kumar Patra, is a resident of Gate Bazaar area in Berhampur.

Saurabh's uncle Amulya Jena lodged a complaint with Berhampur Town police on Tuesday alleging that the navy officer boarded a train to Visakhapatnam from where he was supposed to catch a flight to Kochi to join his duty as an acting leading communicator at INS Garuda.

However, he did not reach his workplace at INS Garuda. While his mobile phone was switched off, the last recorded location from the device was Visakhapatnam. Worried family members reached out to their relatives at different places and even enquired at the Naval base at Kochi but could not trace Saurabh.Saurabh's younger brother Sagar said the navy officer was sent off by their mother and uncle at Berhampur railway station. "We enquired with the airport authorities at Vizag. But Saurabh did not check in."He urged police and Indian Navy authorities to intensify efforts to locate his brother. The family apprehends that the navy officer might have been kidnapped. Saurabh joined the Indian Navy in 2019 and was at home on leave since December 28.

IIC of Berhampur Town police station Soubhagya Swain said, "After receiving the complaint, we sent the navy officer's photographs to various police stations. During investigation, it was found that his mobile phone was switched off at Ichchapuram railway station."Police on Wednesday collected the footage of CCTV cameras at Ichchapuram railway station. The footage shows that Saurabh got down from the train and went outside the railway station.A senior police officer said some documents of the navy officer have been recovered from Lanjipalli area of the city. Besides, the personal tablet of Saurabh was found at his home. The device and the documents are being

### IMD warns of fog in North Karnataka, urges motorists to exercise caution

BENGALURU. The India Meteorological Department CHENNAI. In the midst of an (IMD) forecast a dry spell and fog or mist over most parts of North Karnataka from January 23 to 28. It has cautioned motorists to regularly check highway fog alerts, especially during early morning and evening hours, while taking up their journeys.India Meteorological Department stated that some regions of Karnataka, especially north and north-interior parts, are recording a poor visibility of as low as 50-100 metres. In some villages and pockets, it dips to 20 metres, it cautioned. IMD said that increasing road accidents are not just because of poor road conditions or irresponsible driving by people, but also poor visibility."Weather updates with fog alerts are uploaded on various weather



platforms periodically. Citizens should check them, India Meteorological Department Bengaluru, directorin-charge, N Puviaranan told The New Indian Express. He said it is a misconception among people that a dip in temperature causes fog. But they are two separate things. Fog occurs during winters, but there should also be a dry spell."We have forecast a dry spell and fog over most parts of the state for the next five days. Citizens are advised to exercise caution.

## Trawlers spotted amid Olive Ridley deaths in Chennai, NGT warns of complete ban

alarmingly high number of Olive Ridley turtles beaching in and around Chennai this nesting season, four trawl boats were spotted 2-3km off the shore at Thiruvanmiyur beach at 3.30 pm on Wednesday. Trawlers were also spotted off the shores of Neelankarai and Kalpakkam. The southern bench of the National Green Tribunal (NGT), which has taken suo

motu cognisance of the issue based on a report, warned that it will order a complete ban on trawling during nesting season if the fishing regulations are not complied with. The Tamil Nadu Marine Fisheries Regulation Act, 1983, prohibits fishing by mechanised vessels within five nautical miles of identified nesting and breeding sites during nesting season. In 2017, the state fisheries department submitted a Standard Operating Procedure (SOP) before the Madras High Court that reiterated the ban on trawlers, motorised country crafts and those using mechanised fishing techniques within five nautical miles from the coast during nesting and breeding season of sea



turtles — January to April — in coastal areas of Chennai, Kancheepuram, Cuddalore, Villupuram, Nagapattinam, Ramanathapuram, Thoothukudi and Kanniyakumari districts. However, in reality, the rules are frequently violated. State government pleader D Shanmuganathan told the NGT bench that draft replies from the forest and fisheries departments indicate the turtles died due to trawling, but sought more time to submit a report.

Referring to a Iarticle, the bench, comprising Justice Pushpa Sathyanarayana and expert member K Satyagopal, said the fisheries department has to answer why it did not strictly enforce the regulations and the Excluder Devices.

'If this is the case, we will ban trawling during nesting season," the bench warned and posted the case for January 31.S Aparanjeetha, a resident of Thiruvanmiyur, said she spotted 4-5 trawler boats operating close to the shore and added this has been a regular sighting for the past two weeks.K

Bharathi, president of the South Indian Fishermen Welfare Association, told that it is true that trawlers are violating the rules and urged the state government to take a firm stance on bottom trawling, considering the impact on the nesting season this year. He said that although bottom trawling is not a sustainable practice, the government continues to provide diesel subsidies to these vessels despite their violations. According to sources, Olive Ridley turtles have been congregating closer to the shores where there is good catch of shrimp and fish. The trawlers are also chasing catch near the shore as the deep sea has been rough due to the northeast monsoon, they

**HYDERABAD.** Justice PC Ghose, heading the Commission of Inquiry on the Kaleshwaram Lift Irrigation Project, firmly told V Prakash Rao, former chairman of the Telangana Water Resources Development Corporation, to avoid political commentary and technical lectures while testifying about the damaged piers of the Medigadda barrage."I am not a politician and am not worried about politics. Do not give political lectures. Engineering is not your cup of tea, simply share your opinion on what can be done with the damaged piers of Medigadda barrage without delving into technical

details," Justice PC Ghose said during the hearing.Prakash Rao, who appeared as witness number 101, deposed for the third time before the Commission. When questioned about the change in the intake point from Tummadihatti to Medigadda, Rao began explaining the political background leading to the formation of Telangana. Justice Ghose interrupted, stating: "I am not a politician. Do not give political lectures".Rao responded that he was supporting the Commission by giving details, to which Ghose replied: said that he did not require anybody's support and the



documents themselves would speak the facts. "I do not require anyone's support. The documents themselves will speak the facts. People may speak untruths, but documents and GOs cannot lie."When asked

for his views on repairing the damaged piers of Medigadda, Rao began discussing technical matters. Justice Ghose intervened again, saying, "Engineering is not your cup of tea. That is the job of engineers. Just share your broader view." Rao then stated that the piers could be repaired and restored. Prakash Rao, who served as chairman of the Water Resources Development Corporation from March 2017 to December 2023, used "our government" during the cross-examination. Justice Ghose objected, prompting Rao to clarify by referring to the "then BRS government."

## Wind speed picks up, but Gurgaon's air quality 'poor' for 4th day in a row

Gurgaon. Higher wind speeds seemed to have brought respite on Wednesday morning when the air quality index (AQI) recorded 'moderate' levels. By the afternoon, however, it slipped into the 'poor' category for the fourth day in a row. At 201, the AQI was slightly lower than the previous day's reading

The last time the air was 'moderate' was on Jan 18 (131). Of the four monitoring stations in the city, Teri Gram recorded the highest AQI (259) followed by Gwalpahari at 204 — both 'poor'. Vikas Sadan's AQI was 106 (moderate). AQI was not recorded at Sector 51 due to insufficient data. The city witnessed a wind speed of 8kmph on Wednesday, up from the previous day's 4kmph. It enhanced the dispersion of pollutants, leading to a better AQI in the morning.

According to the System of Air Quality and Weather Forecasting and Research (Safar), the AQI may worsen over the next three days. Predominant surface



wind from the northwest is expected in Delhi-NCR with a speed of 8-11kmph till Friday.HSPCB officials said local issues are responsible for the deteriorating AQI for most part of the year. They cited

factors like suspension of road dust due to vehicular traffic, surge in construction activities, and waste burning as concerns that have increased the pollutants. The minimum temperature on Wednesday

was 9.4 degrees Celsius, a notch below Tuesday's 10.6 degrees. The maximum temperature, recorded at 23 degrees Celsius, also witnessed a one-degree plunge from 22 degrees recorded on the previous day. The India Meteorological Department predicts a mainly clear sky for the next five days. The maximum temperature is likely to stay in the range of 22 and 23 degrees Celsius while the minimum temperature may hover around 6 and 7 degrees. There are no alerts for the region for the next five

New Delhi, meanwhile, saw a rise in its maximum temperature that brought the second hottest day of the month on Wednesday. The maximum temperature at the base station, Safdarjung, was 25.6 degrees Celsius, five notches above normal, with no rain till late evening. At 25.8 degrees Celsius, Pitampura was the warmest place in the

city. A day earlier, the maximum temperature was 24 degrees Celsius.

## In works for over 2 yrs, logistics hub may get GDA board approval next wk

Ghaziabad. The draft proposal for developing a logistics hub on nearly 300 hectares of land near Dasna village along the Delhi-Meerut Expressway (DME) is likely to get the GDA board's approval in its Jan 27 meeting. In the works for over 2 years, the logistics hub is part of the Authority's long-term traffic management plan to prevent heavy vehicles heading towards the capital or other adjacent industrial clusters in NCR from entering the city's limits, and, at the same time, facilitate the smooth movement of raw materials and goods to its industries clusters.GDA officials earlier told TOI the city's roads at night are choked with heavy vehicles ferrying goods and construction materials to its various factories. They said the logistics hub would be planned on the city's outskirts so that trucks would no longer need to enter the city. Across its 10 industrial clusters, spread across Sahibabad, Bulandshahr and GT Road, the city has 1,09,842 micro industries,

### Yemen's Houthi rebels release crew of commercial vessel seized in Red Sea in November 2023

DUBAI. Yemen's Houthi rebels said Wednesday they released the crew of the Galaxy Leader, a vehicle carrier seized in November 2023 at the start of their attacks on shipping in the Red Sea corridor over the Israel-Hamas war. The move by the Iranian-backed Houthis marks their latest effort to de-escalate their attacks following a ceasefire in Gaza. It also comes as U.S. President Donald Trump likely weighs whether to reinstate a terrorism designation he made on the group that had been revoked by President Joe Biden. The rebels said they released the sailors after mediation by Oman, a sultanate on the eastern edge of the Arabian Peninsula that's long been an interlocutor with the Houthis. Oman did not immediately acknowledge the release, though an Omani Royal Air Force jet took a flight to Yemen earlier Wednesday and took off again about an hour after the Houthi announcement. The Houthis also said Hamas separately requested the release of the ship's crew of 25, who included mariners from the Philippines, Bulgaria, Romania, Ukraine and Mexico."This step comes in support of the ceasefire agreement in Gaza," the Houthis said in a statement on rebel-controlled SABA news agency. Vessel's link to Israeli billionaireThe Houthi rebels said they hijacked the Galaxy Leader over its connection to Israel. They then had a campaign targeting ships in international waters, which only stopped with the recent ceasefire in Israel's war on Hamas in the Gaza Strip.A representative for the Galaxy Leader's owners had no immediate comment on Wednesday.

The Bahamas-flagged vessel is affiliated with an Israeli billionaire Abraham "Rami" Ungar, who is known as one of the richest men in Israel. The Houthi attack on the Galaxy Leader saw the rebels launched a helicopter-borne raid. Propaganda footage of the raid has been played constantly by the Houthis, who even shot a music video aboard the ship at one point.On Monday, the Houthis signaled they now will limit their attacks in the Red Sea corridor to only Israeli-affiliated ships after a ceasefire began in the Gaza Strip, but warned wider assaults could resume if needed. However, it likely won't be enough to encourage global firms to reenter the route that's crucial for cargo and energy shipments moving

### Jaishankar US Visit: EAM **Expresses Concern Over** Attack On Indian Consulate In San Francisco, Calls It 'Very Serious Matter'

EAM Jaishankar In US. Expressing concern over the attack on the Indian consulate in San Francisco, External Affairs Minister S Jaishankar dubbed it a "very serious matter". He said that India expects accountability for the incident and those responsible to be held accountable. While speaking at a press conference in Washington DC on Wednesday (local time), the EAM said, "The arson attack on our consulate in San Francisco is a very, very serious matter, and it is something for which we expect accountability. We would like to see that people who did it are held responsible". Futher, Jaishankar also stated that "he had a brief discussion on Bangladesh" with US Secretary of State Marco Rubio, but didn't share any further details at the presser. "We had a brief discussion on Bangladesh...I don't think it's appropriate. I get into more details," he said. Notably, the Consulate General of India in San Francisco was attacked on March 19, 2023, by a group of assailants who committed criminal trespass, damaged public property, and attacked officials of the Consulate.Before this attack, on the same day, some attackers attempted to set the Consulate building on fire by sprinkling inflammable substances early in the morning. A video surfaced on social media in which suspected pro-Khalistani protestors were seen gathering outside the Indian consulate in San Francisco, shouting slogans and heckling staff as they abandoned the diplomatic mission.

#### Charge South Korea's Yoon With Insurrection, Abuse Of Power: Investigators

Seoul, South Korea. South Korean investigators recommended Thursday that impeached President Yoon Suk Yeol be charged with insurrection and abuse of power, as they handed over the results of their probe into his ill-fated declaration of martial law to prosecutors. The official charges against Yoon were "leading an insurrection and abuse of power", the Corruption Investigation Office said after a 51day probe into his December 3 attempt to suspend civilian rule. The CIO said it "decided to request the Seoul Central District Prosecutors' Office file charges against the sitting President, Yoon Suk Yeol, in connection with allegations including leading insurrection". Yoon had "conspired with the former Minister of National Defense and military

commanders on December 3, 2024," it said. The leader, currently suspended from duties, "declared martial law with the intent to exclude state authority or disrupt the constitutional order, thereby inciting riots". Under the South Korean legal system, the case file of the suspect -- identified as "Yoon Suk Yeol: president" -- will now be handed to prosecutors, who have 11 days to decide whether to charge him, which would lead to a criminal trial. The prosecutors' office has "complied with the CIO's request for a case transfer," the investigators said. Yoon was arrested in a dawn raid last week on insurrection charges, becoming the first sitting South Korean head of state to be detained in a criminal probe.

# Mexican border states prepare migrant shelters as Trump begins deportation campaign

CIUDAD JUÁREZ. Mexico raised sprawling tents on the U.S. border Wednesday as it braced for President Donald Trump to fulfill his pledge to carry out mass deportations. In an empty lot tight against the border with El Paso, Texas, cranes lifted metal frames for tent shelters in Ciudad Juárez.Enrique Serrano, an official in Chihuahua state, where Ciudad Juárez is located, said the tents erected for Mexican deportees were just the initial phase of a potentially larger operation, and something authorities would scale up if the number of migrants gathering on the border continued to mount. He suggested migrants from other countries expelled from the U.S. would be relocated to Mexico City or southern regions of Mexico as they've done previously. Workers begin the installation of a temporary shelter for possible deportees from the United States, in Ciudad Juarez, Mexico, Wednesday. Nogales, Mexico — across from Nogales, Arizona — announced that it would build shelters on soccer fields and in a gymnasium. The

Negras have launched similar efforts.At a border crossing in Tijuana, Mexico, on Tuesday night, one man shouted to journalists that he was being deported in a group that was arrested that morning in farm fields near Denver. Another man said he was in a group that had been brought from Oregon. Everyone carried their belongings in a small orange bag. Neither man's account could be independently confirmed. The number of people deported Tuesday was lower than the daily average of about 500 last year, Mexican President Claudia Sheinbaum noted at her daily press briefing. And many border shelters that have long offered refuge to migrants remained comparatively empty to the soaring levels of migrants seen just a year before. Still, heads of those migrant shelters like José María Garcia, director of the Tijuana shelter Movimiento Juventud 2000 were bracing for what could come."Mass deportations in the United States and the arrival of thousands of migrants from the



south could overwhelm the city of Tijuana and other border cities, creating a crisis," he said. Though quickly ramping up deportations — as Trump pledges — faces logistical and financial challenges. The Mexican government is building nine shelters in border cities to receive deportees. It has said that it would also use existing facilities in Tijuana, Ciudad Juarez and Matamoros, to take in migrants whose appointments to request asylum in the U.S. were canceled on Inauguration Day. Sheinbaum has said that Mexico will

from other countries whose asylum appointments were cancelled, as well as those sent to wait in her nation under the revived policy known as Remain in Mexico. Mexico wants to eventually and voluntarily return them to their nations, she has said.Mexican Foreign Affairs Secretary Juan Ramón de la Fuente and the new U.S. Secretary of State Marco Rubio held their first telephone conversation in their new positions."It was a very good

conversation, very cordial, they talked about migration and security issues," Sheinbaum said. After pledging to dramatically shift border and immigration policies, on Monday Trump scrapped the program known as CBP One that allowed asylum seekers to schedule appointments on their phones before arriving at the border, providing a degree of order. On Wednesday, the Pentagon announced it was sending up to 1,500 active-duty troops to

## Elon Musk clashes with OpenAI CEO Sam Altman over Trump-supported Stargate AI data centre project

WASHINGTON. Elon Musk and OpenAI CEO Sam Altman are publicly clashing over the Stargate artificial intelligence infrastructure project, a venture heavily promoted by President Donald Trump. The feud, rooted in a longstanding rivalry between the two tech billionaires, is now testing Musk's influence within Trump's venture involving OpenAI, Oracle, and SoftBank, with plans to invest up to \$500 billion. The project aims to develop advanced AI technology through new data centers and renewable energy infrastructure, starting with an initial private investment of \$100 billion. Trump described the venture as "a resounding declaration of confidence in America's potential" under his leadership.However, Musk, a close adviser to Trump and the head of a government cost-cutting initiative, questioned the validity of the investment. "They don't actually have the money," Musk wrote on his social platform, X. "SoftBank has well under \$10 billion secured. I have that on good

Wednesday, refuting Musk's claims and inviting him to visit the first construction site in Texas. "This is great for the country. I realize what is great for the country isn't always what's optimal for your companies, but in your new role, I hope you'll mostly put (America) first," Altman wrote, using an American flag emoji.

administration. Trump announced the Stargate initiative on Tuesday, a joint dispute that began during Musk and Altman's time on OpenAI's board. Musk, an early investor in OpenAI, sued the company last year, accusing it of abandoning its nonprofit mission to prioritize profits. He has since escalated his legal claims, seeking a court order to halt OpenAI's transformation into a for-profit entity. A hearing is scheduled for February in a California federal court.Musk, who launched his own AI company, AI, last year, has accused OpenAI and its partner Microsoft of creating unfair competition. Microsoft has provided substantial computing resources for OpenAI's AI systems, including ChatGPT. AI is reportedly building its own data center in Memphis, Tennessee, to compete with OpenAI's infrastructure.Stargate has been in development for several months. Tech news outlet The Information first reported on the project in March 2024. Crusoe Energy Systems, along with energy tech firm Lancium, announced a large AI data center in Abilene, Texas, last July, powered by renewable energy

The project, initially described as a multibillion-dollar investment, has now been revealed as the first phase of Stargate. Abilene Mayor Weldon Hurt said construction began about nine months ago, with the project expanding far beyond initial expectations. Oracle co-founder Larry Ellison confirmed that the Abilene facility is the first of 10 planned data centers, with the possibility of growing to 20. The region's energy resources, including solar, wind, oil, and gas, make it an ideal location for the development.

Missing from Trump's announcement was Microsoft, a longtime OpenAI partner that has invested billions into its AI infrastructure. Microsoft is reportedly involved in Stargate alongside Nvidia and Arm but emphasized that its OpenAI partnership is evolving to focus on research and model training.

## **U.S House passes immigrant** detention bill that would be Trump's first law to sign

WASHINGTON. The Republican-led House on Wednesday gave its final approval to a bill that requires the detainment of unauthorised immigrants accused of theft and violent crimes, marking the first legislation that US President Donald Trump can sign as Congress, with some bipartisan support, swiftly moved in line with his plans to crackdown on illegal immigration.

Passage of the Laken Riley Act, named after a Georgia nursing student who was murdered last year by a Venezuelan man, shows just how sharply the political debate over immigration has shifted to the right following Trump's election victory.

Immigration policy has often been one of the most entrenched issues in Congress. Still, a crucial faction of 46 politically vulnerable Democrats joined with Republicans to lift the strict proposal to passage on a 263-156 vote tally."For decades, it has been almost impossible for our government to agree on solutions for the problems at our border and within our country," Senator Katie Britt, an Alabama Republican, said.

She called the legislation "perhaps the most significant immigration enforcement bill" to be passed by

## Over 50,000 under evacuation orders or warnings as wildfire imperils homes north of Los Angeles

CASTAIC, Calif. More than 50,000 people were under evacuation orders or warnings Wednesday as a huge and fast-moving wildfire swept through rugged mountains north of Los Angeles, but fire officials said a rapid ground and air assault was giving them the upper hand. The Hughes Fire broke out in the late morning and within six hours charred about 15 square miles (39 square kilometers) of trees and brush near Lake Castaic, a popular recreation area about 40 miles (64 kilometers) from the devastating Eaton and Palisades fires that are burning for a third week. Though the region was under a red flag warning, winds were not as fast as they had been when those fires broke out, allowing for firefighting aircraft to dump tens of thousands of gallons of fire retardant."The situation that we're in today is very different from the situation we were in 16 days ago," Los Angeles County Fire Chief Anthony Marrone said Wednesday evening. There were no reported homes or other structures burned."This fire had a robust response today, and as you can see

behind us, the responders are doing great work to try to contain this fire," Joe Tyler, director of Cal Fire, said. "Certainly, we are not out of the woods yet." More than 31,000 people have been ordered to evacuate, and another 23,000 are under evacuation warnings, LA County Sheriff Robert Luna said. Parts of Interstate 5 that had been closed started to reopen Wednesday evening. A 30-mile (48kilometer) stretch of the major north-south artery had been closed for emergency vehicles, to move equipment and to prevent accidents due to smoke billowing across the freeway. Crews on the ground and in water-dropping aircraft tried to prevent the wind-driven fire from moving across the interstate and toward Castaic. Marrone said that because winds were not as strong as they were two weeks ago, aircraft crews were able to drop fire retardant on the south side of the fire, where the flames were moving, he said. Winds in the area were gusting at 42 mph (67 kph) in the afternoon but were expected to increase to 60 mph (96 kph) by later in the evening and Thursday,



the National Weather Service said on the social platform X.Kayla Amara drove to Castaic's Stonegate neighborhood to collect items from the home of a friend who had rushed to pick up her daughter at preschool. As Amara was packing the car, she learned the fire had exploded in size and decided to hose down the property."Other people are hosing down their houses, too. I hope there's a house here to return to," Amara said as police cars raced through the streets and flames engulfed trees on a hillside in the distance. Amara, a nurse who lives in nearby Valencia, said she's been on edge for weeks as major blazes devastated Southern

California. "It's been stressful with those other fires, but now that this one is close to home it's just super stressful," she said. To the south, Los Angeles officials began to prepare for potential rain even as some residents were allowed to return to the charred Pacific Palisades and Altadena areas. Gusty weather was expected to last through Thursday and precipitation was possible starting Saturday, according to the National

Weather Service. "Rains are in the forecast and the threat of mud and debris flow in our fire-impacted communities is real," Supervisor Kathryn Barger said during a Wednesday morning news conference. Fire crews were filling sandbags for communities while county workers installed barriers and cleared drainage pipes and basins.Red flag warnings for critical fire risk were extended through 10 a.m. Friday in LA and Ventura counties. Officials remained concerned that the Palisades and Eaton fires could break their containment lines as firefighters continue watching for hot spots.

#### KSRTC mechanic sets wife on fire in HD Kote over dowry, infidelity suspicions

MYSURU. A KSRTC depot mechanic allegedly doused his wife with petrol and set her on fire in front of their son. The incident had taken place on January 20 in Hanumanthanagar of HD Kote town. The police said Mallesh Naik poured petrol on his wife Madhura (28) and set her ablaze. Currently, Madhura is fighting for her life in



a private hospital in Mysuru. Mallesh had married Madhura eight years ago. It has been alleged that the accused had been harassing his wife for dowry and also suspected her fidelity for the past six or seven years. Every day, he would come drunk and argue with his wife, demanding for a site as dowry. Meanwhile, a few days ago, Madhura had gone to her hometown for a couple of days and had returned recently. Infuriated by her visit to parents house, Mallesh picked up a fight with her and poured petrol on her before setting her afire in front of her son.

#### Plea seeks directions to stop imposing jallikattu conditions for manjuvirattu events

MADURAI. The Madurai Bench of the Madras High Court on Tuesday sought a counter affidavit from the state government on a Public Interest Litigation (PIL) petition seeking directions to stop imposing jallikattu conditions for manjuvirattu events in the state, and conduct the latter in its true form.

The litigant, S Muruganantham of Sivaganga, stated in his petition that the government has failed to understand the differences between jallikattu and manjuvirattu. While jallikattu requires bulls to be confined in enclosures and released one at a time to a select group of people who have to try and hang on to the bull without falling, manjuvirattu involves the release of about 5-10 bulls simultaneously in open grounds.

In jallikattu, the tamers are not allowed to touch the bulls beyond the distance of 100 metres, but in manjuvirattu, the tamers are allowed to touch the bulls only after 100 metres from the release point, he added.

Despite several such differences, the government has fixed the same standard operating procedures for both events by mandating creation of arena-like points, wearing uniforms, etc for manjuvirattu events as well, Muruganantham added. "The essence and foundation of manjuvirattu will be destroyed and people will be conducting only jallikattu by the said conditions," he added and sought the above direction.

A bench of Justices MS Ramesh and AD Maria Clete issued notice to the authorities concerned and adjourned the case for filing of counter affidavit.

### Karnataka High Court rejects woman's plea to transfer matrimonial case, emphasises gender-neutral approach

BENGALURU. The Karnataka High Court rejected a woman's request to transfer her matrimonial dispute case pending before a trial court at Narasimharajapura in Chikkamagaluru district, to Hosanagara in Shivamogga district. It observed that the inconvenience projected by her will not be greater than the inconvenience faced by the husband if the case is transferred, as he was looking after their young children, aged 9 and 7.

Constitutionally, a female has got equal rights as that of a male. As a matter of fact, women are the primary victims in most situations, but that does not mean men are not affected by the cruelty of women. There is a necessity for a gender-neutral society.

Such a society aims to prevent the separation of duties according to gender. It will focus on equal treatment of men and women both in domestic affairs and workplaces... we should not overlook the challenges encountered by men," said Dr Justice Chillakur Sumalatha. When disputes arose between the 28-year-old woman and her husband, they began residing separately.

The husband filed for dissolution of the marriage, which was pending before the trial court in Narasimharajapura, while she was living in Hosanagara, around 130km away. She claimed she faced many difficulties travelling to attend court. The husband argued that she had developed an illicit relationship and left home. He was looking after the two children, and had to cook, feed them and send them to school, and then attend court. If the case was transferred, he would face much difficulty, he argued.

## Resentment growing in Kerala over offshore sand mining

KOCHI. Amid allegations of opening up the fisheries sector to corporates, the Union government's move to allow offshore mining of construction sand has triggered resentment in Kerala. While various fishers' unions have threatened to launch a united agitation, the state government has conveyed its disapproval, stating that it will affect the livelihood of the fisherfolk.Meanwhile, marine geologists have termed it a huge opportunity as Kerala will be earning a huge income through shipping, trade, and GST collection.

The Centre decided to conduct offshore mineral exploration based on a study by the Geological Survey of India which reported 745 million tonnes of sand deposits suitable for construction activities in Kerala's coastal sea. The Centre has decided to auction sand blocks for offshore mining in five sectors: Ponnani, Chavakkad, Alappuzha, Kollam North, and Kollam South.

The decision to conduct sand mining in the Kollam sector has shocked the fishers as the region is a traditional fishing ground. The Kollam Parappu or Kollam Bank is one of the most productive fishing grounds on the southwest coast of India. The bank has a depth range of 275 to 375 metres. It extends to an area of 3,300 km2 off the coast of Kollam and Alappuzha districts.

The region is rich in marine biological diversity, including pink perch, trevally, shrimp, lobster, pomfret, mackerel, oil sardine, Jewfish and Indian salmon.B Madhusoodana Kurup, a fisheries researcher and founder-vice chancellor of the Kerala University of Fisheries and Ocean Studies (KUFOS), recalled a study carried out two decades back on the impact

The Centre's move infringes on the state's rights. Allowing corporates in the offshore mining sector can hamper the livelihood of the fishermen," he said

.However, experts at the Geological Survey of India (GSI) said the concerns are unnecessary and unwarranted. "There is no need to be worried about the environmental aspect of the offshore sand exploration as the auction is only for a composite licence which includes exploration and extraction. The decision to auction the blocks was taken based on a G3level exploration conducted by the GSI.

The complainant, Vishwanath Pujari, had invested in stocks through ARSSBL. An agreement for a loan against shares was entered into between him and the petitioners. The complainant is said to have defaulted in clearing the loan after four years, and the petitioners sought his stocks worth Rs 1.04 crore to be liquidated.

The complainant filed a suit seeking an injunction against the petitioners not to liquidate the amount towards the loan, and approached the Investment Grievance Redressal Cell under SEBI for redressal on October 27, 2016. He registered a complaint on January 28, 2017. His suit was dismissed in 2019 saying the arbitration clause was part of the Investigation continued and CID filed a 'B' report in 2019. The magistrate referred the matter for further investigation. On June 30, 2021, police filed a second 'B' report. The complainant filed a protest petition in July 2022. The magistrate rejected the 'B' report and took cognisance of the offences against the petitioners, who moved the high court.

The magistrate recorded that reports by the investigation officer are not supported by cogent reasons and allegations of misappropriation of funds by the accused in share trading and account of the complainant. The team also collected samples of paddy brought by farmers to Direct Procurement Centres (DPC) for testing their moisture content in a laboratory. According to sources, over 3.40 lakh hectares of paddy crop across the region is yet to be harvested and the crops face the risk of being rejected at the procurement centres if the moisture norms are not relaxed by the union government, sources said. Farmers want the moisture norm for paddy to be hiked from 17% to 22% to qualify for government procurement and minimum support price.In Thanjavur and Tiruvarur districts, of the 2.73 lakh hectares of samba and thalady paddy crops, 2.25 lakh hectares are yet to be



harvested. I Similarly, 1.18 lakhs hectares of paddy out of 1.31 lakh hectares in Mayiladuthurai and Nagapattinam is yet to be harvested. Livelihood of lakhs of farmers in the region is at stake, sources said. KANNUR. Memories of the 'thali case,' a landmark legal battle that resonated across the British empire, have been reignited as Thalassery court prepares to move to its new premises. The pivotal episode, rooted in the boycott of foreign clothing during India's freedom struggle, has been artistically captured by Ponniam Chandran in a painting that will now adorn the walls of the court's new building. The case centred around Kamala Bai, a Thalassery native

and Congress leader, who was married to freedom fighter L S S Prabhu. Along with several women activists, Kamala was arrested for participating in the anti-colonial boycott movement. A British magistrate at Thalassery court sentenced her to six months in prison and imposed a hefty fine of Rs 1,000. When she refused to pay, officials confiscated her thali chain, a sacred symbol of marriage.

The incident caused an uproar in British Parliament, leading to a rare intervention. Resummoned to court, Kamala was offered back her thali. However, she refused, citing Hindu customs that forbade a woman from wearing a thali touched by another man. This act of defiance became a symbol of resistance and sparked further outcry against British rule."The Thalassery court has been operational for 220 years. As the court relocates to its new multi-storey building, I chose to depict the 92-year-old Thali case because it represents our history, freedom struggle and legal heritage," said Chandran. Chandran's acrylic painting vividly portrays the drama linked to the case. The lower half features spinning wheels, symbolising the Swadeshi movement, alongside scattered Gandhi caps and the faces of freedom fighters. # 40 per cent of Kazipet station redevelopment works completed

HYDERABAD. The South Central Railway (SCR) is redeveloping Kazipet Railway Station under the Amrit Bharat Station Scheme (ABBS) at a cost of Rs 24.45 crore. The project aims to enhance passenger comfort and modernise facilities, with 40% of the work already completed. Works are expected to be completed by the end of this financial year. The proposed enhancements include: a redesigned station building façade with an entrance portico, a 12-metre wide Foot Over Bridge (FOB) equipped with two lifts and two escalators, platform improvement, additional covered areas, upgraded toilets including facilities for differently-abled passengers.

Further improved waiting halls, landscaping, traffic circulating improvements and art and culture depictions in station areas, enhanced passenger friendly signages, train indication boards and coach indication boards. Established in 1888 as part of the Nizam's Guaranteed State Railway (NGSR), Kazipet Railway Station lies on the Secunderabad-Delhi line and historically served as a hub for transporting coal, cotton and other goods. It remains a crucial junction connecting Warangal and neighbouring areas like Hanamkonda to major cities across India, with an average footfall of 24,269 passengers per day and annual earnings of Rs 41.36 crore. The station falls under the Secunderabad-Balharshah section and hosts 98 train halts, including important superfast trains to destinations like New Delhi, Howrah, Chennai, Vijayawda, Visakhapatnam, Secunderabad and Tirupati.Kazipet is one of the 40 stations in Telangana being developed under ABSS,



which envisions long term modernisation of Indian Railways with world-class facilities. Across Telangana, redevelopment costs around Rs 2,737 crore. Significant projects include redevelopment of Secunderabad and Charlapalli stations as an alternate terminal to ease congestion in the Hyderabad metropolitan area. Launched by the Ministry of Railways, ABSS focuses on masterplanned station upgrades to accommodate increasing passenger needs and transform railway hubs into regional growth centers. The initiative received a boost with Prime Minister Narendra Modi's foundation stone-laying ceremonies in August 2023 and February 2024.

# Lives, not machines: Human cost of overwork

While Infosys founder Narayana Murthy keeps advising the young generation—the bunch of software engineers and other techno-managersto work for 70 hours a week, Larsen and Toubro chairperson SN Subrahmanyan has begun to plead for a 90-hour workweek, including Sundays, to promote competitiveness and efficiency.

Never mind that, as far as the findings of the International Labour Organisation are concerned, India ranks 13th among the world's most overworked countries! Furthermore, 62 per cent of the Indian employees experience severe burnout—three times the global average. And this is one of the top occupational risk factors contributing significantly to disease and early death. Have these corporate bosses forgotten so early the tragic tales of the death of Anna Sebastian Perayil—a 26-year-old Ernst and Young employee in Pune — because of workrelated stress? No, it is not an aberration. As the 'Healthy Work Survey' conducted by the US-based Centre for Social Epidemiology reveals, there are more than 1,20,000 deaths caused by work stress every year in the world. There are three reasons why we must resist this sort of insensitivity, or the act of reducing a human being into a mere 'resource' for enhancing the mythical 'productivity'. First, as the kind of work most of us are compelled to do for survival or economic mobility, far from being inherently fulfilling and creative, causes alienation, estrangement and existential anguish. Converse with a software engineer sitting in front of the laptop in a tiny cubicle, fulfilling the ever-expanding 'targets' and, thereby, spending sleepless nights; engage with an employee in a crowded bank, counting cash from 9 am to 5 pm without a breathing space; or, for that matter, talk to a delivery boy running like a horse to supply — quickly and instantly what the affluent classes from their gated societies order.It is quite unlikely that they will say that they are happy with what they do. They do it because they have to survive, pay the house rent, give their medical insurance premium or send their kids to schools. In fact, asking them to work more, or to teach them the lessons of 'hard work' is the worst form of psychic violence the insensitive corporate elites can inflict on them. The fact is that most of us are psychologically wounded and feel extreme form of alienation and boredom in our workplaces. However, for these business tycoons, it seems, we are nothing but mere 'resources', to be extracted continually till we break down. Second, when these corporate elites lecture on long working hours for India's economic prosperity, they safely forget to mention that without distributive justice, the nation's prosperity will mean essentially the prosperity of the select billionaires, or a tiny section of the upwardly mobile professional class, like techno-managers, doctors in private hospitals, and real estate entrepreneurs. Thanks to an Oxfam report, we know that the top 10 per cent of Indian population holds 77 per cent of national wealth. Is it, therefore, surprising that India has 185 billionaires — the third largest in the world after the US and China? Keep your eyes open and see the manifestations of this gross inequality.

For instance, while Narayana Murthy's net worth is not less than \$520 crore, the estimated total package for a fresher at Infosys is Rs 3-to-5 lakh per annum. While the Ambanis can spend Rs 5.000 crore for their son's lavish wedding, it is exceedingly difficult for a construction worker to earn more than Rs 700 per day, or a delivery boy Rs 13,000 per month. Is it because they are lazy? Or, is it because the system that the corporate elites seek to hide is inherently violent and exploitative?In this context, I must say that it is equally important for people like us - I mean middle class, university-educated professionals who are complaining against this kind of long working hours — to look at ourselves critically, accept our hypocrisy and admit that we, too, do not necessarily behave nicely, eg with the entire brigade of domestic helps. Quite often, we pressure them to work even on holidays or in festive seasons

## Budget shouldn't disappoint as economy is on an even keel

The govt still has to keep financing capital investment and infrastructure. It should give up the thought that it can step back so that the private sector can take over.

THE Union Budget looks ahead for several key pointers: signals for key sectors of industry and agriculture; public investment in foremost infrastructure sectors like electricity, roads and railways; how the fiscal scene (the government's own finances) is likely to fare during the year; and, of course, the average citizen's keenness to find out if the income tax burden will go up or down.

With inflation under control and growth going steady at 6 per cent plus, there is no serious concern over the economy and the tax collection. There are, however, some imponderables. Will we be able to keep buying Russian oil at a decent price with US sanctions being tightened?But the overarching concern and the

greatest imponderable is the way in which the country and the world will cope as the planet gets hotter and extreme climate events like drought and floods keep coming. And what it will do to agriculture, from which many poor people eke out an existence. The expectation is that the fiscal deficit in the coming financial year will be pitched lower at 4.5 per cent from the likely deficit in the current fiscal of 4.8 per cent. This will bring the number in line with the medium-term fiscal goal. From this, it is clear that we are looking at a small realignment and not a serious overhaul. As against this, a sharper change will be sought and expected in capital expenditure, seeking to take it

up by 12-13 per cent to Rs 11 lakh crore. This is because where the capital spending goes matters a lot to roads, highways and railways. Plus, there is an expectation that interest-free loans for capital expenditure will continue to be passed onto the states so as to raise regional infrastructure growth.Capital expenditure will be delivered because the revenue part will be expected to coast along evenly. This will be enabled by indirect taxes growing at 8.8 per cent, with the GST (goods and services tax) expected to grow by 10.5 per cent, reflecting a resilient domestic consumption.Direct tax revenue, in good part from taxes paid by companies out of their profits, will grow healthily at 11.8 per cent as the base of companies will grow, with the economy growing healthily and corporate profitability remaining stable. With the economy

expected to remain on an even keel, let us examine what individual industries have mentioned in their wish lists as they have met government representatives so as to build a castle firmly anchored in the ground and not in the air. Technology moves forward with funding and incentives for research and development (R&D). The tech sector, which is rolling in money, still seeks government support as hugely important new sectors are emerging, like artificial intelligence, block chain and quantum computing. These can transform daily life as well as businesses and enable future growth.Right behind is the healthcare sector. without whose robustness the people will not be



healthy or be able to provide the skills that will be the sinews of technology. And the way to begin is at the bottom, with rural healthcare facilities. These will have to be revolutionised by telemedicine, which will deliver better care at controlled costs. If we jump to the top of the sector, the aspects we see before us are pharmaceuticals and medical equipment. India is already the global leader in affordable medicines, which have to go up the ladder as new chemicals or molecules are invented all over the world. These must be made in India and these will have to be offered at the village level itself, through prescriptions generated by telemedicine. And there will have to be cameras and scanners to capture the images which will have to be generated. This will need the government to help out. To transform countryside education, it must go hand in hand with

healthcare. Students of high schools and colleges should be able to access the digital knowledge world and download e-books so that the age of the photocopier is left far behind. The government must to develop the IT backbone and take it to villages so that youngsters can use their smartphones, which will have to work as mini libraries. And, of course, the smartphones will perform with signals from towers or satellites. The need for power and signals for smartphones brings us back to infrastructure. Along with power, the villages will need roads, which must lead to highways and railway lines so that youngsters can easily go to coaching schools to prepare for competitive examinations and those who


do well can go and live in towns where better jobs are offered.In sum, the government still has to keep financing capital investment and infrastructure. It should give up the thought that it can step back so that the private sector can take over. Here, the Budget will have a critical role to play. In the old days, the Budget presentation, through which the country came to know about it, was overblown. The country stopped to pause to hear or see the Finance Minister through radio or TV and the media spent endless hours trying to highlight a few aspects of the Budget. This gave the minister a chance to do a good bit of grandstanding. Today, the Budget papers are released online, allowing the media, analysts and

corporates to pore over the numbers quickly to come to their conclusions.

But some of the mystique still remains, particularly for the layman, who wants to know whether he will have to pay more or fewer taxes and turns to the tax accountant to find out if his tax bill will go up or not. The layman forgets that since the time when Manmohan Singh, as Finance Minister, transformed the economy, incomes tax rates for individuals have gone down. But the layman does not notice it as he sees his tax bill going up and forgets that his income has gone up much more. What he also does not notice is that the present dispensation has introduced the revolutionary GST regime, which has lowered taxes that consumers have to pay through sales tax and excise duty; he thinks he is paying a lot more as GST, when, in fact, he is consuming a lot more.

## Letdown for Abhaya

CBI must dig deeper into rape-murder case



Circumstantial evidence seems to have proved Roy's guilt beyond any doubt. Thus, it's baffling that the Abhaya case

was not regarded as the "rarest of the rare". The controversial judgment has left several questions unanswered: Was this really a 'lone wolf' incident? If not, who were the convict's accomplices and what was their role in the crime? Has the CBI thoroughly probed all aspects of the case? And what about the lapses on the part of the hospital authorities?

Even as the CBI must get to the bottom of the matter, the unsavoury political slanging match should be avoided. Chief Minister Mamata Baneriee has claimed that had the case been handled by the Kolkata Police, the death penalty would have been a certainty. The BJP, in its turn, has demanded an investigation into the alleged role of then Kolkata Commissioner and the CM in the destruction of vital evidence. This is an unfortunate turn of events. One thing is clear: Abhaya deserves nothing less than complete justice. This must be ensured for the

sake of every daughter of the nation.

## **Empower CAPFs** with designated roles for a safer India

### The CAPFs must have their own integral cadres, like the Coast Guard. The army, too, should yield control of the Assam Rifles.

The spurt in terrorist incidents in Rajouri-Doda-Kathua last year was blamed on gaps in the security grid caused due to pulling out of the army division for the more pressing task of beefing up deployment to combat the Chinese build-up on the northern border. Even after this much-belated rebalancing, described as RB-1.0, we have just around 30 per cent force level deployed against China, our main adversary on the northern borders. Out of the balance, 30-40 per cent is deployed to combat the proxy war in J&K.

Notwithstanding the recent agreement on the restoration of patrolling in Depsang and Demchok, it is imperative to maintain vigil and enhance the deployment levels. The army is reportedly working on RB-2.0. The critical determinant for such rebalancing is whether the designated forces — the Central Armed Police Forces (CAPFs) and police would rise to the challenge and free the army for addressing the primary challenge. The CAPFs, with around 10,45,750 personnel, comprise seven formidable forces for maintaining law and order, internal security (IS) and counter-insurgency (CI) and protecting the borders. They can be broadly grouped as per their functions. The Central Industrial Security Force (CISF) is meant for industrial and airport security. The Ministry of Railways also has a 75,000-strong Railway Protection Force (RPF). The question is whether the overburdened Ministry of Home Affairs (MHA) should give control of the CISF to the designated ministries of aviation and industry, like the RPF.The Central Reserve Police Force (CRPF) is mandated to beef up the state police forces for maintaining law and order and internal security. It was created as a reserve to the state police forces. Besides the regular constabulary, most states have around 10 armed police battalions, funded by the Central government, with a shared understanding on their deployment. These are also referred to as the Rapid Action Force (RAF). Then, there are the Border Security Force (BSF), the Indo-Tibet Border Police (ITBP), the Sashastra Seema Bal (SSB) and the Assam Rifles (AR). Their mandate is border management (BM). The Kargil Review Committee in 1991 had enunciated the principle of 'one border, one force' for border management and it recommended

that the CRPF be dedicated for internal security. Consequently, rationalisation was attempted: the BSF for Pakistan and Bangladesh, the ITBP for China, the SSB for Nepal and Bhutan and the AR for Myanmar.

Each border has its own challenges. There is the problem of narcotics delivery by drones in Punjab, cattle and human trafficking on the Bangladesh border and terrorist intrusions in J&K. The Pakistan border is properly fenced in the International Border (IB) sector and has a modified fencing along the Line of Control (LoC). The Bangladesh border is approximately 80 per cent fenced, but it has treacherous riverine and jungle stretches. Except for the 60-odd km out of 1,643 km, the border with Nepal, Bhutan, Tibet — the Line of Actual Control (LAC) — and Myanmar is unfenced.Border management has two categories: border guarding or patrolling on

settled borders and border defence on active frontiers (LoC and LAC), where the BSF and ITBP work in supportive role with the army.

The Assam Rifles is dual-tasked for the Myanmar border and the counter-insurgency role in the NE. It is paramilitary in nature as the officer cadre is from the army on a deputation basis. The challenges of managing internal security and counter-insurgency are such that battalions of the CRPF, BSF, ITBP, SSB

and AR are deployed in Manipur, reflecting the firebrigade response of mustering whatever and whoever is available.

The force mix in J&K is similar, though the Rashtriya Rifles (RR), CRPF and J&K Police have become the main components. However, the recent induction of Assam Rifles units in J&K is indicative of the firefighting approach. The reputation of the AR — the



original mainstay of North-East — has been tarnished in Manipur. It is not only unfortunate but also shortsighted. If there are black sheep in a force, fix them by all accounts, but why trash the 189-yearold legacy? The National Security Guard (NSG) or Black Cat Commandos are on the other end of the spectrum. They do specialised counter-terrorism work, including hostage rescue. The combined strength of the CAPFs and the armed police battalions matches that of the army in numbers. They also enjoy similar benefits in pay and perks and wear a similar uniform. They have recently even created similar sounding HQs, like the Command HQ, further adding to confusion. The first and foremost requirement is empowerment of the CAPFs for their designated roles. It is predicated on the implementation of the police reforms recommended

> by the Prakash Singh Committee. They have been duly reiterated by the Supreme Court. While the states have not implemented the suggested reforms, the Union government can set the pace for empowering the CAPFs and police in states ruled by NDA governments.Next, the CAPFs have roles that require specialisation and force ethos. The use of the CAPFs as a cadre management avenue for senior ranks in the IPS needs to be reviewed. Para-dropping in CAPFs at apex ranks and shifting of DGs degrade cadre cohesion. The CAPFs must have their own integral cadres, like the Coast Guard. The army, too, should yield control of the Assam Rifles.

Regarding the border defence role, the BSF on the LoC and the ITBP on the LAC should operate under the undiluted

operational control of the army. Additionally, the large-scale deployment of the CAPFs for elections has impacted their availability for other mandated tasks. The electoral process should be made less dependent on the CAPFs, with the police and Home Guards shouldering the challenge.

The influx of infiltrators as an electoral issue has resulted in the counter-accusation that border management is ineffective and porous.

### Ten years of underinvestment': Germany's crisis-hit economy casts shadow over election

LUDENSCHEID. Auto industry jobs have long been the lifeblood of the German town of Luedenscheid but now, a trade union official says, the sector's woes have sparked fears it will turn into an "open-air industrial museum."Insolvencies and layoffs have cast doubt on the town's future prosperity, echoing wider anxieties in Europe's biggest economy as it heads toward February 23 elections. ### Sebi moots mini SIPs at Rs 250 a month

MUMBAI. Seeking to increase financial inclusion among the under-served sections and inculcate the habit of systematic saving, capital markets regulator Sebi has proposed that fund houses launch sachet-sized systematic investment plans (SIPs) starting Rs 250. These small-ticket SIPs would be offered at lower costs but the discounted rates would apply only for three plans per investor. According to Sebi's consultation paper, released on Wednesday, the scheme is to help small investors who are new to the mutual fund industry.



large SIPs would be excluded. The proposal caps annual investment at Rs 50,000 per investor, per mutual fund, without PAN. However, Aadhaar verification is mandatory. Investors are expected to make a commitment for five years (60 instalments), though there will be no restriction on closing the plan early. The paper also suggests ways to help the asset management companies (AMCs) to recover the additional costs they incur by subsidizing these sachet-sized SIPs. It says the AMCs can be compensated from the investor education and awareness fund maintained by the mutual fund industry. Sebi estimates that AMCs will be able to break even within two years.

Among the possibilities are boosting purchases of US whiskey, steel, and oil, as well as lowering tariffs on products like bourbon and pecan nuts.India was the US's largest trading partner last financial year, data from India's commerce ministry shows. The government is planning to reduce duties on the goods that are imported to India which are



He could be the best buddy of yours one day, and you're out the following day," said Wolf.He further talked about how India remains to gain from the Trump administration as, by and large the new US President is expected to not have good terms with China."It's pretty clear that the general orientation will be



hostility to China, and that's an opportunity that the Indian government and India can still exploit," said Wolf. However, he also suggested caution in trying to leverage the 'China Plus One' opportunity and said, "Though perhaps the Indian government should think about how successful can we afford to be, because maybe Mr Trump at some stage will turn on us."Talking about the tariff

threat and the attempt of Trump to weaken the BRICS, he said that the new US President does not like the growing power of the BRICS nations."He sees the BRICS as a vehicle for Russian and bubble Chinese power and influence. And the more they coordinate because they're big together, the more it weakens the American position. So he wants to fragment these, and I think he'll work quite hard to fragment them, to fracture them," said Wolf. The economic expert also suggested that Trump might offer India a deal in his attempt to weaken the BRICS."For India, there are things to think of in both sides. You want to be in every important place. So India might decide, and you might do something different. I can imagine Trump going to India. Say, let's do a great deal together. You leave the BRICS," said Wolf.

The announcement followed a meeting of top financial officials including ministries in charge of pensions and the central bank."Implementing the plan's various measures will further enhance the equity allocation capacity of medium- and long-term funds, steadily expand the scale of investment, improve the supply and structure of funds in the capital market, and consolidate good conditions for the capital market's recovery," Wu said. The ruling Communist Party announced this move just ahead of China's biggest holiday of the year, the Lunar New Year, which begins on Wednesday, Jan. 29. It's a time when families tend to splash out on food and travel and little red packets of money for children and young adults, a time of wishes for good fortune. Markets in Hong Kong and Shanghai rose early Thursday after the announcement, with the Shanghai Composite index gaining 1.4%. It's great to see him fit and back in the side,' Suryakumar said on Tuesday.Shami himself said that he was eager to make India comeback. "The hunger to play for the country should never end. If you love it, you will always fight back, no matter how many injuries you face," Shami said at a Cricket Association of Bengal event.

We thought it was some copassenger who needed their bags."She added, "When we landed, that gates weren't opening, and we were kept waiting for about an hour. Outside the window, we could see all of these cop cars and there were ambulances, cars with the lights and stuff like that. We started wondering what's going on, and then the pilot said there was some slight safety concern. When they finally opened the gate, they made us take out all our hand luggage and placed it at a centre. We waited for about an hour to get our stuff back and our terminals were changed mid-air. When we reached the gate, another checking and screening happened. They even took handwriting tests from us all. It took about three to four hours. So, a flight which was supposed to take 45 minutes, lasted close to five hours.

Avantika further said, "I'd rather have them take time and follow protocol than cut corners." When asked what was going on in her mind during this time? "Honesty, I had been reading that there have been an increase in the numbers of such fake stories.
