

## Delhi Assembly polls: Can Kejriwal bathe in Yamuna, asks UP CM Yogi Adityanath

**Yogi further** criticised the AAP for creating "false narratives" and focusing more on spreading lies than addressing the public's needs.

New Delhi. Uttar Pradesh Chief Minister Yogi Adityanath took aim at Arvind Kejriwal and the Aam Aadmi Party (AAP) during his first public address in the Delhi Assembly election campaign on Thursday.Addressing BJP candidates Bajrang Shukla (Kirari), Dushyant Gautam (Karol Bagh), and Ashish Sood (Janakpuri), Yogi criticised the Delhi government's handling of the Yamuna and the city's overall infrastructure. Yogi said, "As Chief Minister, I bathed with my 54-member cabinet at



the Sangam in Prayagraj. Can Arvind Kejriwal and his team bathe in the Yamuna? The person who turned Yamuna into a dirty drain should not be forgiven by the people." He went on to highlight the progress Uttar Pradesh has made in recent years under his leadership.Referring to the ongoing Kumbh Mela in Prayagraj, Yogi said, "Over 10 crore devotees have bathed at Sangam between January 13 and 23. The city now boasts improved infrastructure with better roads, electricity, rail and air connectivity. The UP and central governments jointly invested Rs

7,500 crore for the Maha Kumbh, generating over Rs 2 lakh crore for the state's economy and creating thousands of jobs." The CM accused Arvind Kejriwal of being the "biggest criminal" responsible for Delhi's decline. He stated, "Except for the MDMC area, the rest of Delhi is suffering from worsening road conditions, sewage issues, and poor sanitation. The roads are riddled with potholes, garbage is rampant, and sewage flows freely on the streets. The tanker mafia exploits the city's

drinking water crisis. The people of Mathura and Vrindavan are also suffering due to Kejriwal's mismanagement."Yogi further criticised the AAP for creating "false narratives" and focusing more on spreading lies than addressing the public's needs.

"Had they focused on development as much as they do on falsehoods, Delhi would have transformed in the last decade. Instead, they have turned Delhi into a garbage dump," he added. The CM also accused the AAP of playing a role in instigating unrest in Delhi.

## Ajit Pawar Attends Meet, Rearranges Seating For 'Distance' From Sharad Pawar

Pune. Maharashtra Deputy Chief Minister Ajit Pawar on Thursday attended the annual general body meeting of Vasantdada Sugar Institute (VSI) for the first time since the NCP split in 2023 but sat at an arm's length from NCP(SP) chief and the institute's chairperson Sharad Pawar. Ajit Pawar is a member of the Pune-based VSI, a prominent research institute of the sugar industry. While the two were supposed to sit next to each other as per the initial arrangement, the Deputy Chief Minister moved his nameplate one chair away, allowing state cooperation minister Babasaheb Patil to sit between them. "Babasaheb wanted to speak to Pawar saheb. I can speak to him (Sharad Pawar) anytime. Even if I sat one chair away, my voice is loud enough for someone further away to hear," the deputy Chief Minister explained when asked about this seat rearrangement

The NCP chief also held a closed-door meeting with Sharad Pawar and other leaders, including



NCP MLA Dilip Walse Patil. Asked about his absence from the annual general body meetings of VSI over the past two years, Ajit Pawar attributed it to his work commitments, adding in a lighter vein that he was "busy thinking about how to get the maximum number of my members elected".

The closed-door meeting centred on issues of the sugar industry and was attended by representatives from agriculture, excise, cooperation, and energy departments, all of which are closely associated with the sugar sector, he pointed out.

NCP (SP) MLA Rohit Pawar said "the two captains coming together for a discussion must be welcomed". Queried about this meeting, Maharashtra BJP chief and state minister Chandrashekhar Bawankule said he did not know if the discussion was political in nature. "If it was political, then Ajit dada had to discuss it among the Mahayuti. If it was personal, then it was purely a family affair," Mr Bawankule said.

During his speech at the meeting, Ajit Pawar suggested increasing the prize money of two awards from Rs 10,000 to Rs 1 lakh. The suggestion was accepted and an announcement to this effect was made by Sharad Pawar during his address. Sharad Pawar, a former Union agriculture minister, addressed the gathering despite being unwell. He was seen coughing during his 18-minute address.

The whole building has been sanitised, and the cyber cell is also trying to trace the email's origin," a

senior police official told. While cops have confirmed that there are no credible threats associated with these events, the Vadodara Police have emphasised that ensuring public safety remains at the top of their priorities. Further updates will depend on the findings from the cyber team's ongoing probe into the threat mails, police added.

#### N Biren Singh slams Congress for criticising his handling of Manipur situation

Imphal. Chief Minister N Biren Singh on Thursday slammed the Congress for its criticism of his government's handling of the present crisis in Manipur, and for also raising its fingers at Prime Minister Narendra Modi. Singh accused the Congress of indulging in unnecessary politics and said the party failed to prioritise Manipur's interests when it was in power in the state. "Did Prime Minister PV Narashima Rao visit Manipur during the 1992-97 ethnic clashes between Nagas and Kukis? Did the PM visit the state when ethnic clashes took place between Paites and Kukis which cost more than 300 people their lives, during 1993-97? So why are they playing politics", Chief Minister Biren Singh asked.

Speaking at a media briefing at the Chief Minister's Secretariat on Thursday, he questioned the sincerity of the opposition."We want a concrete resolution to the ongoing conflict. This is not a mere political issue. It's a chronic problem created by Congress. They are the ones who caused these issues and are now blaming us. Not just



God, even people won't forgive them," Singh claimed.

The Delhi Assembly election will be held on February 5 and results for the city's 70 seats will be announced three days later - on February 8.

New Delhi. The Aam Aadmi Party and the Bharatiya Janata Party went head-to-head Friday with the Delhi Assembly election less than two weeks away. The clash, though, wasn't over public infrastructure, education, health services, or cost of living in the national capital; it was over the Punjab Police withdrawing additional security cover for AAP boss Arvind Keiriwal.

The police force from the neighbouring state which is also ruled by the AAP - had been providing the ex-Chief Minister with a security detail, in addition to that from Delhi Police.

But it withdrawn last night after Delhi cops complained to the Election Commission. "Following directions from Delhi Police and Election Commission, we have withdrawn ... " Punjab Police chief Gaurav Yadav said, adding details of any threats would be shared with his Delhi counterparts. Arvind Kejriwal is assigned a AAPvs BJPOn Punjab Cops' Security Z+ protection detail, which consists of 63 security All of this has led to a furious spat between the two



officers, including a pilot, escort teams, an inner ring of guards, and search-and-frisk units. In addition, 15 uniformed personnel from the Central Armed Police Forces, or the CAPF, are deployed for his protection. The Punjab Police's escort was over and above this security detail.

parties. The BJP has accused the AAP of "making an issue out of nothing" and has asked, "Are Delhi cops incapable of providing security?"

The AAP, meanwhile, has accused the BJP - which controls the Union Home Ministry, to which office the Delhi Police answer - of having "forcibly removed" Arvind Kejriwal's security. Mr Kejriwal, the party has pointed out, has faced four 'attacks' in as many months, including one in Delhi's Hari Nagar neighbourhood just hours after the Punjab Police escort was removed.

Delhi Chief Minister Atishi issued a fierce statement on X, accusing the BJP and its two senior-most leaders - Prime Minister Narendra Modi and Home Minister Amit Shah - of "playing with the life" of her party leader. She also slammed the EC for being a "mute spectator".

"Shameful. On the instructions of Amit Shah, Delhi Police today forcibly removed Arvind Kejriwal's Punjab Police security.

Kiren Rijiju, the Chief Minister Singh noted that not everyone is fully aware of the complexities of the state's situation. He emphasised that those

closely dealing with the issue, such as Union Home Minister Amit Shah, understand the realities on the ground.N Biren Singh described Rijiju's comments as his personal opinion and a general observation. Last week, Union Minister Kiren Rijiju said the problem in Manipur was not an uprising against the BJP-led centre but ethnic clashes between two dominant groups- Meiteis and Kukis.

In a bid to deal with misinformation that could flare violence in the state, N Biren Singh issued a stern warning to social media users, urging them to act responsibly or face consequences under the "law of the land," which he stated could have long-lasting effects on their lives. He emphasised that the government will not tolerate hate speech, content inciting communal tensions, or any material that infringes on someone's personal life and negatively impacts families. It's my earnest appeal to all social media users in Manipur to behave responsibly, ensuring no misunderstandings are created unnecessarily in the state due to irresponsible statements or posts", Biren said, adding that legal action will be taken against violators.

## Prove I had non-veg on sacred hill or quit, **Muslim League MP dares Annamalai**

IUML MP from Ramanathapuram Navas Kani challenged Tamil Nadu BJP chief K Annamalai to prove allegations of consuming non-vegetarian food at Thiruparankundram Murugan temple or resign. New Delhi. An Indian Union Muslim League MP, accused of eating non-vegetarian food atop a hill housing the famous Thiruparankundram Murugan temple in Tamil Nadu's Madurai district, dared the state BJP chief K Annamalai to prove the charge or resign

"He (Annamalai) made false accusations. He said that I went to Thiruparankundram



temple and ate biryani. I never went to the hill or ate non-vegetarian (food)," Navas Kani, the MP from Ramanathapuram said. The IUML MP asserted that he was being falsely accused. "BJP leaders Annamalai, L Murugan and Vanathi Srinivasan are falsely accusing me of having non-vegetarian food in temple premises," he told India Today, adding, "If Annamalai is unable to prove his allegation, is he

willing to resign?" When asked if someone who accompanied him ate nonvegetarian food he said: "I didn't go to the hill. Nobody came with me. Nobody ate non-vegetarian food who accompanied me."

However, this was a marked change from what he told India Today the previous day. On Thursday, he said he didn't eat non-vegetarian food, but someone else did. The controversy of non-vegetarian food erupted after the police stopped animals from being transported to the Thiruparankundram hill, on which Sikandar Badusha Dargah is also located, apart from the Arulmigu Subramaniyaswamy Temple.

As a result of the blast, a roof collapsed with 12 people stuck inside. While two have been rescued, ten people are still stuck inside, according to district officials. "After the accident blast in Ordnance Factory Jawahar

Several ambulances and firefighters have been rushed to the site. Fire department personnel, police officials, the land revenue officer, and other administrative officials reached the spot of the blast. The State Disaster Response Force (SDRF) has also been deployed. Reacting to the ordnance factory blast, Maharashtra Congress chief Nana Patole said, "This is the failure of the Modi government." The cause of the explosion is not yet known. An investigation is underway.

#### BMRCL fare hike likely by February 1

BENGALURU. Though the Bangalore Metro Rail Corporation Limited (BMRCL) continues to treat the impending fare hike as a highly confidential matter, state government sources have confirmed that the fare hike is set to happen from February 1 and it would be 41 per cent over the present fare. Metro token fare ranges between Rs 10 and 60 now with a 5 per cent discount on Metro cards.A reliable source told, "The committee formed to revise the prices has issued a Fare Determination Order which proposed a 41 per cent hike. Under the Metro Railways (Operation and Maintenance) Act 2002, the order issued by the Fare Fixation Committee (FFC) is binding on the specific Metro Rail. Hence, the BMRCL Board has given its nod for the move.

A nod from the chairman of the Board Srinivas Katikithala, who is the Secretary of the Urban Development Affairs is equivalent to getting a nod from the Centre. The hike cannot be stopped now by anyone," he said. Apart from the 5 per cent discount during travel during off-peak hours, the usage of the National Common Mobility Card will also be given a 5 per cent discount, similar to that of Metro smart cards, he added.BMRCL was supposed to hold a press briefing but chose to postpone it. It will be held next week before the hike comes into effect, said a Metro official.

Another official said that one option that BMRCL could consider would be to emulate the Delhi Metro. "In 2017, its minimum fare was hiked by Rs 2 and the maximum fare was doubled from Rs 30 to 60.It implemented the fare hike in two phases

#### Pudukkottai farmer, female drone pilot invited to President Murmu's tea party in Delhi on Republic Day

TIRUCHY. Two individuals, including a farmer from Pudukkottai district, have been invited to attend a tea party hosted by President Droupadi Murmu in Delhi on January 26 to mark Republic Day.Ponnaiya (41), the president of the Parambur Big Tank Water User Association, and M Amutha (47), a female drone pilot, have been recognised for their exceptional contributions to agriculture and water management.Parambur village, located in the Annavasal block of Pudukkottai district, is home to the Parambur Big Tank Water User Association. Established in 1978, the association comprises 281 farmers who have been efficiently utilising rainwater to irrigate 268 acres of farmland.

The association also facilitates the sale of produce through a government-direct paddy procurement centre without any commission, ensuring transparency and fair trade for its members.In a bid to ensure proper water management, the association uses CCTV cameras to monitor water levels in the Parambur Big Tank. As police forces of both Odisha and Chhattisgarh remain vigilant against possible retaliatory attacks by the banned CPI (Maoist) following the Gariaband encounter, identification of the 16 neutralised Naxals reveal that four of them were top cadres.Out of the 16 Maoists, security forces confirmed the identities of at least seven so far.

They include central committee member Chalapathi who was carrying a bounty of Rs 1 crore, a divisional committee member and two area committee members.Sources in the State Police Headquarters said it is not the numbers of the red ultras killed but the quality of the top leaders who were eliminated in the operation which is a setback for the outlawed outfit.

As it is a major blow to the Naxals, Odisha and Chhattisgarh police forces are wary the red ultras may be desperate to



launch a counter-attack as soon as they get an opportunity. To discuss their further strategy, seniors officers of Odisha and Chhattisgarh police held detailed discussions on Thursday, first time after the operation was launched on January 19 night in neighbouring Gariaband district, which is only five km away from Nuapada border.

During the discussions, it was decided to remain on alert to thwart any counterattack or infiltration bid by the Naxals. At the same time, operations will be intensified in the coming days along the Odisha-Chhattisgarh border, said police sources."With Centre's determination

to end Naxalism by early 2026 and the menace being mostly wiped out from Andhra Pradesh and Jharkhand, it is important Odisha and Chhattisgarh police do not lower their guards and simultaneously step up the anti-Naxal operations," said a senior police officer. state's Kularighat reserve forest area in As part of their strategy, senior officers started visiting company operating bases (COBs) of the Central Reserve Police Force and Border Security Force in Nuapada along the bordering areas of Chhattisgarh.

## **People of eight panchayats of Umerkote in** Odisha join hands, seek new block status

Podagarh village where block chairperson Sushila Majhi and vice chairperson Shyamal Sarkar were present.Later, a memorandum was submitted to the collector for establishment of a new block. The villagers said the state government should open a new block office in Podagarh for the development of these panchayats. Their demand stems from the backwardness of the cluster villages where basic amenities of health, education, drinking water, and transportation have remained absent. There are 26 panchayats in the Umerkote block and natives of Bhandariguda, Sinsari, Mundiguda, Rajpur, Neura, Benara, Karagaon and Torenga



panchayats have rallied together seeking their areas be clustered and carved out of Umerkote as a new block. The total population of these eight panchayats stands at 75,000.Currently, the block headquarters is about 40 kilometers from these

panchayats and majority of the residents belong to poor, tribal and oppressed communities. The villagers who took part in the meeting said basic services are absent, while irrigation has become a dream for the people of the eight panchayats. For higher education, students have to go to its nearby towns like Dhodra, Umerkote, Jharigaon and Dabugaon. They said, due to lack of educational institutions, more than half

of the students drop out of school. Due to absence of income-generating opportunities and irrigation, people from these panchayats are forced to migrate to other states for work

## MCG sets 4-month deadline to process waste at Bandhwari

Gurgaon. After waste treatment stopped over two months back, the Haryana govt has selected two agencies to process 14 lakh metric tonnes of legacy waste at Bandhwari landfill. The Rs 90.1-crore project assigns 9 lakh metric tonnes to one agency at Rs 645 per tonne and 5 lakh metric tonnes to another at Rs 642 per tonne.Operations are expected to begin within a month following approval from the High-Powered Purchase Committee (HPPC). Officials said they aim to finish the processing in four months from the beginning of the work."The agencies require a minimum of 15 days to organise their resources before starting work. Given our four-month timeline to process the legacy waste, we have instructed all participating agencies to adhere strictly to this schedule to ensure complete treatment of all legacy waste," MCG commissioner Ashok Kumar Garg told TOI.Waste treatment at Bandhwari stopped two months back as the contract with the agencies deployed for the duty ended.Around 2,200 tonnes of waste from Gurgaon and Faridabad are dumped daily at the Bandhwari landfill.

A Dec 16 affidavit that MCG submitted to

the National Green Tribunal (NGT)

stated that around 8.8 lakh metric tonnes of legacy waste - which was supposed to be cleared by Dec 31 last year remained untreated.The civic body's action plan, submitted on Dec 16, mentioned that fresh waste processing would continue at Bandhwari until alternative solutions, including a torrefied charcoal plant, were implemented. When fresh waste is not processed for

30 days, it is classified as legacy waste. The charcoal plant project is scheduled for commissioning by Dec 16 next year.Hearing petitions filed on Dec 17 by a resident, Poonam Yadav, and environmentalist Vivek Kamboj, an NGT bench — headed by chairperson Prakash Shrivastava and expert member A Senthil Vel — identified major deficiencies in MCG's handling of legacy waste at Bandhwari landfill."Progress has been very slow in the remediation of legacy waste and setting up waste processing facilities," the tribunal observed in its



Dec 17 order.NGT said MCG's affidavit lacked crucial information, including analytical evidence confirming the safety of bio-soil distributed among farmers and that used in low-lying areas. The bio-soil, extracted from the area where legacy waste was removed, was handed out to farmers, which they could use for levelling. The tribunal also highlighted the absence of detailed information regarding quantities of refuse-derived fuel (RDF) that were transported to cement plants and waste-to-energy facilities. Additionally, MCG failed to provide specifics about expenditure on waste remediation and the extent of land freed after removing trash.Meanwhile, the municipal corporation plans to engage a private contractor for services including design, engineering, procurement, construction, installation, testing, and commissioning of the two DTRO units.After a panel of Haryana State Pollution Control Board (HSPCB) pointed out that two disk tube reverse osmosis (DTRO) units at

theBandhwari landfill site were nonfunctional, MCG recently started the process to acquire new DTROs. The project, estimated to cost around Rs 10 crore, will establish facilities capable of processing 200 kilolitres per day. The HSPCB committee had found out that the two DTROs were non-functional during its visit to the site on Dec 2, 2024. The leachate generated at the site, however, was being taken to sewage treatment plants for its processing, MCG officials said.

#### Gurgaon's CO level 100 times higher than safe limits, reveals CPCB data

Gurgaon. Carbon monoxide (CO) concentrations in the city have surpassed permissible thresholds by over 100 times during the past 23 days, according to Central Pollution Control Board (CPCB). Between Jan 1 and 23, CO levels fluctuated between  $110\mu g/m^3$  and  $170\mu g/m^3$ , substantially exceeding the acceptable limit of  $1.7\mu g/m^3$ , revealed the data. The surge poses significant health risks to residents, potentially causing respiratory and cardiovascular issues. Experts attribute the alarming rise to waste burning, particularly plastic and rubber, and traffic congestion. However, to tackle the situation, Commission of Air Quality Management (CAQM) has mandated stringent punitive measures and directed HSPCB to prompt MCG to inspect waste burning hotspots and report on enforcement actions, case status, and strategies to eliminate open waste burning."Between Jan 1 and 23, 2025, CO levels in Gurgaon exhibited notable variations across locations. 2 cattle smugglers held after 5km chase on Delhi-Mumbai eway Gurgaon: Two suspected cattle smugglers were arrested

after cops in Ferozepur Jhirka intercepted a truck carrying 24 cows — eight of them dead — following an intense 5km chase on Delhi-Mumbai Expressway around Wednesday midnight. Tariq from Salaheri village and Zafru from Piparoli — the two men carrying the cows - continued to drive the truck even after its front tyres burst, creating a trail of sparks as the vehicle rode on its rims.he operation began when a Crime Investigation Agency (CIA) team, patrolling near Ghata Shamshabad village, received a tip-off about cattle being transported for slaughter."We had specific information about cows being moved from Haryana to Rajasthan through the expressway," a senior police official said.Signalled to stop at a police blockade, the suspects rammed through the barricade, initiating a high-speed pursuit by a team of cops. The chase ended near Bhakdoji village when the two men abandoned their vehicle and attempted to escape through a nearby green belt. Both were caught after a brief chase.

Over the past few years, cattle smuggling has often led to communal tension and vigilantism in Haryana, Rajasthan and other neighbouring states. According to police records, Harvana reported over 200 cases of cattle smuggling in 2022, marking a 15% increase from the previous year. In Feb 2023, cow vigilante Monu Manesar was named in an FIR in connection with the murder of two men in Rajasthan's Bharatpur, Nasir and Junaid. Manesar, who gained notoriety through social media posts showing violent confrontations with alleged cattle smugglers, was later arrested in Sept 2023. The animals rescued after the 5km chase on Wednesday night were found in deplorable condition and transferred to a local gaushala for medical attention and care. "The surviving animals showed signs of severe distress and trauma, said a veterinarian attending to the cattle there.

Police investigation revealed Tariq and Zafru were repeat offenders in cattle smuggling cases.An FIR was registered against them and the owner of the vehicle under relevant sections of the Prevention of Cruelty to Animals Act and provisions of the Haryana Gauvansh Sanrakshan and Gausamvardhan Act, 2015.

"This operation demonstrates our unwavering commitment to preventing cattle smuggling. We are investigating possible links to larger trafficking networks operating in the region," a police spokesperson said

#### Multiple checkpoints set up on Delhi-Gurgaon eway ahead of R-Day trigger long tailbacks

Gurgaon. Multiple checkpoints on Delhi-Gurgaon Expressway, installed to divert Delhi-bound heavy commercial vehicles ahead of Republic Day celebrations, caused daylong traffic congestion on NH-8 on Thursday. Travel times increased significantly, with typical 20-minute journeys taking over an hour during non-peak hours. From 5pm on Jan 22 to 1.30pm on Jan 23 and from 5pm on Jan 25 to 1.30pm on Jan 26, medium and heavy commercial vehicles were not allowed to enter Delhi in view of the Republic Day preparations.



#### More than 250 Bangkok schools close over air pollution

THAILAND. More than 250 schools in Bangkok were closed on Thursday due to pollution, authorities said, as officials urged people to work from home and restricted heavy vehicles in the city.Seasonal air pollution has long afflicted Thailand, like many countries in the region, as colder, stagnant winter air combines with smoke from crop stubble burning and car fumes.Level of PM2.5 pollutants -- cancer-causing microparticles small enough to enter the bloodstream through the lungs -hit 122 micrograms per cubic metre. The World Health Organization recommends 24hour average exposures should not be more than 15 for most days of the year.Bangkok authorities said earlier this week schools in areas with elevated levels of PM2.5 could choose to close. And by Thursday morning, 194 of the 437 schools under the Bangkok Metropolitan Authority had shut their doors, affecting thousands of students.st since 2020, when all schools under BMA authority closed over air pollution.Another 58 schools out of the 156 under the Office of the Basic Education, a central government body, had also decided to close by Thursday. There are several other schools in

the capital under different authorities, and private establishments, but figures for them were not available.

Children are especially vulnerable to the impacts of air pollution, but rights advocates warned that closures disproportionately affect the most vulnerable students.

#### After Trump withdrawal order, UN says US to exit WHO by January 2026

World. The United States will leave **World.** The United States will leave the World Health Organisation on January 22, 2026, the United Nations said on Thursday, after being formally notified of the decision by President Donald Trump, who has accused the agency of mishandling the pandemic and other international health crises.Trump announced health crises.Trump announced the move on Monday, hours after he was sworn in for a second four-year term. The WHO said on Tuesday that it regretted the move from its top donor country. Trump must give a one-year notice of US withdrawal from the Geneva-based body and pay Washington's dues under a 1948 joint resolution of the US Congress. The United States is by far the WHO's biggest financial backer, contributing around 18% of its overall funding. WHO's most recent two-year budget, for 2024-2025, was ÚSD 6.8 billion. It was not immediately clear how much the US owes. 'I can confirm we have now received the US letter on the WHO withdrawal. It is dated January 22, 2025. It would take effect a year from yesterday, on January 22, 2026," said deputy UN spokesperson Farhan Haq.The US departure will likely put at risk programs across the organisation, according to several experts inside and outside the WHO, notably those tackling tuberculosis, the world's biggest infectious disease killer, as well as HIV/AIDS and other health emergencies.The withdrawal order signed by Trump said the administration would cease negotiations on the WHO pandemic treaty while the withdrawal is in progress.

## Progress made on massive fire north of Los Angeles as new blazes ignite in southern California

LOS ANGELES. Evacuation orders were lifted Thursday for tens of The Palisades Fire was more than threequarters contained, and the Eaton Fire was 95% under control Thursday. The two fires have killed at least 28 people and destroyed more than 14,000 structures since they broke out Jan. 7. Rain was expected to start Saturday, according to the National Weather Service. Officials welcomed the wet weather, but crews also were shoring up hillsides and installing barriers to prevent debris flows as residents returned to the charred Pacific Palisades and Altadena areas.

The California fires have overall caused at least \$28 billion in insured damage and probably a little more in uninsured damage, according to Karen Clark and Company, a disaster modeling firm known for accurate p o st - c at a st r o p h e d a m a g e assessments. On the heels of that assessment, California Republicans are pushing back against suggestions by President Donald Trump, House Speaker Mike Johnson and others

that federal disaster aid for victims of wildfires should come with strings attached. The state Legislature approved a more than \$2.5 billion fire relief package Thursday, in part to help the Los Angeles area recover from the fires. Trump plans to travel to the state to see the damage firsthand Friday, but it isn't clear whether he and Democratic Gov. Gavin Newsom will meet during the visit.thousands as firefighters with air support slowed the spread of a huge wildfire churning through rugged mountains north of Los Angeles, but new blazes erupted in San Diego County, briefly triggering more evacuations.Southern California is under a red flag warning for critical fire risk through Friday.

The area has been facing constant challenges in controlling the fires, as dangerous winds gained strength again Thursday.The Hughes Fire broke out late Wednesday morning and in less than a day charred nearly 16 square miles (41 square kilometers) of trees and brush near



Castaic Lake, a popular recreation area about 40 miles (64 kilometers) from the devastating Eaton and Palisades fires that are burning for a third week.Crews made significant progress by late afternoon on the Hughes Fire, with more than onethird of it contained.Two new blazes were reported Thursday in the San Diego area. Evacuations were

ordered but were later lifted after a brush fire erupted in the late afternoon in the wealthy enclave of La Jolla near the University of California, San Diego, School of Medicine.

Further south, near the U.S.-Mexico border, another blaze was quickly spreading through the Otay Mountain Wilderness, home to the endangered Quino checkerspot butterfly and other unique species.

In Ventura County, a new fire briefly prompted the evacuation of California State University Channel Islands in Camarillo. Water-dropping helicopters made quick progress against the Laguna Fire that erupted in hills above the campus of about 7,000 students.

The evacuation order was later downgraded to a warning.Rain is forecast for the weekend, potentially ending Southern California's monthslong dry spell. Winds are also not as strong as they were when the Palisades and Eaton fires broke out, allowing for firefighting aircraft to dump tens of thousands of gallons of fire retardant.

That helped the fight against the Hughes Fire in the Castaic area north of Los Angeles, allowing helicopters to drop water, which kept it from growing, fire spokesperson Jeremy Ruiz said."We had helicopters dropping water until around 3 a.m. That kept it in check," he said.

## 'Blatantly unconstitutional': Federal judge blocks Trump's executive order redefining birthright citizenship

<u>Decision prevents Trump</u> <u>administration from taking</u> <u>steps to implement</u> <u>executive order for 14 days.</u> <u>Meanwhile, parties will</u> <u>submit further arguments</u> <u>about merits of Trump's</u> order.

**SEATTLE.** A federal judge on Thursday temporarily blocked President Donald Trump's executive order redefining birthright citizenship, calling it "blatantly unconstitutional" during the first hearing in a multi-state effort challenging the order.The 14th Amendment to the Constitution promises citizenship to those born on U.S. soil, a measure ratified in 1868 to ensure citizenship for former slaves after the Civil War. But in an effort to curb unlawful immigration, Trump issued the executive order just after being sworn in for his second term on Monday.

The order would deny citizenship to those born after February 19 whose parents are in the



state document recognizing citizenship for such children.Trump's order drew immediate legal challenges across the country, with at least five lawsuits being brought by 22 states and a number of immigrants rights groups. A lawsuit brought by Washington, Arizona, Oregon and Illinois was the first to get a hearing."I've been on the bench for over four decades. I can't remember another case where the question presented was as clear as this one is," U.S. District Judge John Coughenour told a Justice Department attorney. "This is a blatantly unconstitutional order."Thursday's decision prevents the Trump administration from taking steps to implement the executive order for 14 days. In the meantime, the parties will submit further arguments about the merity

l o n g t e r m a s t h e c a s e proceeds.Coughenour, 84, a Ronald Reagan appointee who was nominated to the federal bench in 1981, grilled the DOJ attorney, Brett Shumate, asking whether Shumate personally believed the order was constitutional."I have difficulty understanding how a member of the bar could state unequivocally that this is a constitutional order," he added.Shumate assured the judge he did — "absolutely." He said the arguments the Trump administration is making now have never previously been litigated, and that there was no reason to issue a 14-day

temporary restraining order when it would expire before the executive order takes effect. The Department of Justice later said in a statement that it will "vigorously defend" the president's executive order, which it said "correctly interprets the 14th Amendment of the U.S. Constitution.""We look forward to presenting a full merits argument to the Court and to the American people, who are desperate to see our Nation's laws enforced," the department said. The U.S. is among about 30 countries where birthright citizenship — the principle of jus soli or "right of the soil" — is applied. Most are in the Americas, and Canada and Mexico are among them. The 14th Amendment was ratified in 1868, in the aftermath of the Civil War, to ensure citizenship for former slaves and free African Americans.

## How Microsoft powered Israel's war machine in Gaza: Report

World. Leaked internal documents reveal Microsoft's role as a major purveyor of cloud services and artificial intelligence (AI) technology to the Israeli military, with its support picking up pace after Hamas's October 7 attack on Israel ignited the Gaza conflict.A joint investigation by the Guardian, +972 Magazine, and Local Call details how Microsoft bolstered its relationship with Israel's defence establishment following the unprecedented Hamas assault, signing deals worth at least \$10 million. These agreements reportedly provided thousands of hours of technical support, alongside expanded computing and storage services. The Israel Defense Forces (IDF), facing increased demand for computing power after launching its offensive in Gaza, turned to tech companies to scale its infrastructure, triggering a "gold rush". As firms vied for military contracts, Microsoft offered steep discounts to edge out rivals.According to one military commander who spoke to the Guardian, this marked a shift toward "the wonderful world of cloud providers."The documents, first obtained by Drop Site News, show the IDF's reliance on Microsoft, Amazon, and Google for data storage and intelligence analysis grew sharply. Between June 2023 and April 2024, Microsoft's cloud storage usage within the military surged by over 155 per cent, peaking before the Rafah offensive in May 2024. Microsoft's Azure platform and ChatGPT-maker OpenAI's language model tools accounted for nearly 75 per cent of the IDF's usage. These services supported combat and intelligence activities, including projects with Unit 8200, the IDF's elite surveillance division, and Unit 81, which develops advanced spy technology. The tech behemoth was frequently involved in sensitive and highly classified projects. It played a role in maintaining "Rolling Stone," a system that tracks the movement of Palestinians in the West Bank and Gaza. During the military operation in Gaza, Ofek, an air force unit responsible for managing databases of targets for strikes, relied on Microsoft's communication and messaging systems. The leaked files also detail Microsoft's provision of AI tools like Lavender, which reportedly analysed data on 2.3 million Gaza residents to identify potential Hamas connections. The system flagged about 37,000 Palestinians as suspects, according to Tel Avivbased +972 Magazine. The revelations come as Google also ramped up its support to Israel's Defence Ministry, offering increased access to its AI technologies.

#### Living in a cage': Checkpoints in Israeloccupied West Bank proliferate after Gaza ceasefire

**TAYBEH.** Father Bashar Basiel moved freely in and out of his parish in the occupied West Bank until Israeli troops installed gates at the entrance of his village Taybeh overnight, just hours after a ceasefire began in Gaza.

We woke up and we were surprised to see that we have the iron gates in our entrance of Taybeh, on the roads that are going to Jericho, to Jerusalem, to Nablus," said Basiel, a Catholic priest in the Christian village north of Ramallah.

All over the West Bank, commuters have been finding that their journey to work takes much longer since the Gaza ceasefire started."We have not lived such a difficult situation (in terms of movement) since the Second Intifada," Basiel told AFP in reference to a Palestinian uprising in the early 2000s.He said he was used to the checkpoints, which are dotted along the separation barrier that cuts through much of the West Bank and at the entrances to Palestinian towns and cities. country illegally. #### Massive LA wildfires slow down after days of devastation

**World.** Evacuation orders in Los Angeles were lifted for thousands of residents on Thursday after firefighters succeeded in slowing down the spread of massive fire. The hilly region still remains under a red flag warning for critical fire risk until Friday, with strong winds challenging containment efforts. The Hughes Fire, which erupted near Castaic Lake on Wednesday, quickly engulfed a vast green patch of almost 41 square kilometres of trees and brush.

Firefighters had made significant effort by Thursday afternoon, containing about a quarter of the blaze.The lake, a popular recreation spot situated at the distance of 64 kilometres from the sites of the weeks-old Palisades and Eaton fires, also remains under threat.Meanwhile, two new fires broke out in San Diego County on Thursday. A blaze in La Jolla, near the University of California, prompted temporary evacuations before being brought under control. Another fire near the US-Mexico border spread rapidly through the Otay Mountain Wilderness, home to endangered species like the Quino checkerspot butterfly.Rainfall, which is forecasted for the weekend, has ignited hopes of relief from the months-long dry spell."We had helicopters dropping water until around 3 a.m., which kept the fire in check," said fire spokesperson Jeremy Ruiz. While nearly 54,000 residents in the Castaic area remain under evacuation warnings, no homes or structures have been reported damaged. Among those affected was Kayla Amara, a nurse

from Valencia. She rushed to a friend's home in Castaic's Stonegate neighbourhood to retrieve belongings but found herself hosing down the property as the fire grew.

'It's been stressful with those other fires, but now that this one is close to home it's just super stressful," she said. The Palisades Fire is now almost 75 per cent contained, while Eaton Fire is 95 per cent under control. These two devastating blazes, which began earlier this month, have claimed 28 lives and destroyed more than 14,000 structures.California officials are preparing for potential debris flows as rain approaches, particularly in the Pacific Palisades and Altadena areas, where damage is extensive.

Statewide, the fires have caused an estimated \$28 billion in insured damage, with additional losses likely uninsured, according to disaster modelling firm Karen Clark and Company.In response, the California Legislature approved a \$2.5 billion fire relief package on Thursday to assist recovery efforts in Los Angeles and other affected areas.President Donald Trump is set to visit the state on Friday to assess the damage, though it remains unclear whether he will meet with Democratic Governor Gavin Newsom during the trip.

## Syria's economic pains are far from over despite Assad's ouster

**DAMASCUS.** Samir al-Baghdad grabbed his pickax and walked up a wobbly set of stairs made of cinderblocks and rubble. He is rebuilding his destroyed family house in the Qaboun neighborhood near Damascus.

The traditional building, which once housed his family, parents and some relatives, had a courtyard decorated with plants and tiled floors where guests were received. But the house, like scores of others nearby, has been reduced to heaps of rubble during years of civil war.Al-Baghdadi can't afford to hire workers or rent a bulldozer to clear the debris and fix the house. He makes just about enough money as a mechanic to feed his family. But he's desperate to rebuild it because he is struggling to pay skyrocketing rent for an apartment.

"Economic opportunities are basically nonexistent," al-Baghdadi said, sitting on a pile of rubble and debris where the house's entrance used to be. "So we're going to slowly rebuild with our own hands."Although Syrian President Bashar Assad was toppled last month in a lightning insurgency, the country's dire economic conditions that protesters decried have not changed. The economy has been battered by corruption and 13 years of civil war. Coupled with international sanctions and mismanagement, inflation skyrocketed, pulling some 90% of the country into poverty. Over half the population—some 12 million people—don't know where their next meal will come from, according to the UN World Food Program.With no sign of a full-scale withdrawal of international sanctions and continuing caution among potential overseas investors, the honeymoon period for the country's new rulers could be short-lived.

Qaboun, just a stone's throw away from the city center, and other eastern Damascus neighbourhoods became rebel strongholds in 2012, when the country's mass protests against Assad spiraled into all-out war.It suffered government airstrikes and artillery fire, and at one point Islamic State group extremists. In 2017, government forces reclaimed the neighbourhood, but when al-Baghdadi tried to return in 2020, security forces kicked him out and forced him to sign a pledge to never return, saying it was a security zone that was off limits. After Assad's fall, al-Baghdadi was finally able to return. Like many, he was euphoric and hoped it would pave the way for better times despite the many challenges that lay ahead, including rampant power cuts and fuel shortages. For years, Syrian

families have relied on humanitarian aid and remittances from family members living abroad to survive.n top of the gargantuan costs of rebuilding the country's destroyed electricity, water and road infrastructure,



money is needed to restore its battered agriculture and industrial sectors to make its hobbled economy productive again. The United Nations in 2017 estimated that it would cost at least \$250 billion to rebuild Syria. Some experts now say that number could reach at least \$400 billion. Wealthy Gulf countries have pledged to build economic partnerships with Syria's new interim rulers, while Washington has eased some restrictions without fully lifting its sanctions. The US Treasury Department issued a six-month license authorizing some transactions with Syria's interim government. While it includes some energy sales, Syrians say it isn't enough. Sinan Hatahet, an economic researcher at the Washington-based Atlantic Council think tank, said the US actions were the "bare minimum" needed to show good faith to Damascus and aren't enough to help Syria jumpstart its economy. "It doesn't help the private sector to engage," Hatahet said.

"The restrictions on trade, the restrictions on reconstruction, on rebuilding the infrastructure are still there."While countries are hesitant to make more impactful decisions as they hope for a peaceful political transition, many Syrians say the economy can't wait. "Without jobs, without huge flows of money and investments ... these families have no way of making ends meet," Hatahet said.The executive director of the World Food Program echoed similar sentiments, warning Syria's neighbors that its food and economic crisis is also a crisis of security. "Hunger does not breed good will," Cindy McCain said in an interview during her first visit to Damascus.

#### Domestic aide, friend awarded life term for kidnapping child in 2019

CHENNAI. A mahila court in Chennai on Wednesday sentenced a domestic aide and her male friend to life imprisonment for kidnapping a three-and-a-half-year old child the worker was taking care of in 2019 from her house in Aminjikarai police station limits.The child was rescued from the convicts identified as Kaleemullah Sait (30) and M Ambika (24) within 24 hours after she was kidnapped. The girl was kidnapped soon after her return from school right in front of her mother's eyes in the western part of the city. The parents of the child, a doctor and an IT professional, received a ransom call for Rs 60 lakh with a threat to kill the child. The ransom was reduced to Rs 30 lakh but it eventually wasn't paid as the child was rescued by the police. A few clues proved to be vital in solving the case and securing the conviction.One was a red car owned by Kaleemullah which was used to transport the child to a resort on East Coast Road. The second was tracking of the contact number through which the ransom call was made by Sait. The number and the phone was being used by Ambika and on the day of the incident, it was recovered from Sait. The court was convinced with the prosecution's evidence to prove that Sait and Ambika had booked a room in the resort, where they kept the child till her rescue. When confronted by the police, Ambika had claimed that the child's mother had asked her to take her to the resort, which was deemed to be false. Detailed call data record entries and location histories of the accused helped prove the case in court.Convicting the duo under Section 364A of the IPC which deals with kidnap, the court sentenced.

#### Jail staff may face PC Act for Darshan's special treatment

BENGALURU. In fresh trouble for jail officials of Bengaluru Central Prison, the police have proposed invoking the Prevention of Corruption Act (PC Act) against them for allegedly extending preferential treatment to actor Darshan Thoogudeepa and his associates who were lodged there in connection with the Renukaswamy murder case.Police officers investigating the case revealed that the probe established the role of jail officers, including medical staff, in giving special treatment to the actor and others. "The investigation revealed that 13 jail officers, including jail doctors, were involved in providing preferential treatment to Darshan, rowdy-sheeter Naga and other inmates by supplying mobile phones, cigarettes and other items to them. While an FIR is already registered against them, we have proposed to invoke the provisions of the Prevention of Corruption Act against some of the them," a senior officer said.Meanwhile, the police have written to the government seeking sanction of prosecution against 13 officials, including two superintendents and six assistant superintendents. Once prosecution sanction is accorded, the police will submit a chargesheet against the accused officials.

Globally, I've participated in the Save the Children movement. I also worked with the Youth Advisory Council at COP26 and engaged with international working groups advocating for climate action. These experiences have strengthened my belief in the power of collective action.Uttarakhand, she witnessed the devastating effects of flash floods and landslides, which inspired her to act. At the age of nine, Ridhima sued the Union government for failing to uphold its climate commitments under the Paris Agreement and filed complaints with the United Nations (UN) to hold global leaders accountable. I started asking my mother about the causes of such disasters, and as I grew older, I understood how human actions like deforestation and poor environmental policies, contribute to such tragedies. That traumatic experience motivated

me to take action. Filing a public interest litigation with the National Green Tribunal was my way of pushing for systemic change. You were part of the UN initiative when Greta Thunberg delivered her famous speech. What was that experience like?I was 11 years old when I attended the event at the Unicef headquarters as one of the youngest petitioners in a group of 15.Standing among such passionate young activists was empowering, but what truly stood out was Greta's speech. Her words were incredibly powerful, and her

determination was evident. It was a defining moment for me.Vandana Shiva's boldness, audacity, and clarity in her speeches are qualities I deeply admire. I also draw inspiration from the activists of the Chipko Movement, like Gaura Devi and Sunderlal Bahuguna.I've also learned a lot from Shashi Tharoor's speeches, which have helped me improve my own public speaking skills.I want to pursue a degree in environmental sciences. For many, environmental activism is a hobby or a side activity, but for me, it's my purpose. By gaining formal education in the field, I hope to enhance my credibility and ensure my work is taken seriously.I've been part of various campaigns since 2019, including efforts to reduce plastic pollution and ban single-use plastics.

#### Kakatiya University students protest PhD admission delay with petrol bottles

Most of the women work as maids or cooks in the four apartment blocks in the area, and have to report for duty at odd morning hours. They leave late in the evenings," said a resident.Having come to Bengaluru from Jharkhand, Odisha and West Bengal, they have little support in the city, and refrain from approaching local police stations too, she said. They share their experiences with their employers but are unwilling to pursue the matter legally. The harassment has become frequent now, with two new bars opening up on Railway Parallel Road, said a resident. "It was only one bar earlier. Drunkards and drug addicts prowl the area," she said.Earlier this week, two teenage girls from a posh apartment were touched inappropriately by a harasser on a twowheeler, which then raced away.

'The girls have not even told their parents as they fear they will not be permitted to step outside their homes in future," she said. Young men performing wheelies often try to snatch mobiles from young girls. "If the women resist, they slap them on their back or grope them and speed away," said an employee at one of the apartments. "I have chased these

scooty but they ride at great speed and escape. Molesting women and getting away with it gives them some kind of thrill," he added. "They also do stunts with wheelies creating much noise and it alarms the elderly walking around," he said.

After the incident involving the elderly woman on Tuesday (January 21), a group of residents visited the Kodigehalli police station to brief them about the situation on

Wednesday. "A hoysala visited the area late at night and five rounds of patrolling was done by the cops on the 12th Main Road and surrounding areas," said an apartment resident. An apartment owner confided what her maids had told her, "Men sometimes stand nude on the tracks. What can they do but bend their heads and cross.

'MLA Krishna Byre Gowda had visited the area a few months ago and assured residents that CCTV cameras would be installed for overall safety, but it never happened.

## **MoEFCC** raises concerns over Odisha Mining **Corporation's plan for drilling near Khandadhar**

BHUBANESWAR. The Ministry of Forest, Environment and Climate Change (MoEFCC) has flagged serious environmental concerns on the Odisha government's proposal for exploratory drilling in Khandadhar sub Block-B iron ore mining area in Sundargarh district by Odisha Mining Corporation (OMC).

Deferring its decision to grant approval for diversion of forest land for exploration by core drilling, the Forest Advisory Committee (FAC) of the ministry has asked the state government for a detailed scientific study to ascertain the impact of mining on the eco-sensitive area and also obtain the views of the National Tiger Conservation Authority (NTCA). The state government

had sought the approval of the Centre under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for exploration/prospecting in 0.779 ha of forest land within the total prospecting lease area of 432.8 ha covered under prospecting license in favour of OMC in Sundargarh district. While the entire area granted for the prospecting lease is forest land and no non-forest land is involved in the proposal, a total of eight bore holes of four-inch diameter up to 70-metre depth have been proposed to be drilled in the forest land. The experts committee has asked the state government to conduct a scientific study to ascertain the impact of ongoing mining activities in Bonai forest division



and its impact on the water regime of the area along with flow of water in the waterfall in its catchment. Since the area proposed for prospecting is an elephant habitat and the presence of tiger has been noticed in recent times, the committee also sought the comments of the NTCA in this

regard.Besides stating that fresh construction activity is visible within the area of prospecting lease as per decision support system (DSS) analysis, the FAC asked the state to revisit the proposal and submit well-reasoned comments on the issues that have been raised.

The proposed exploration area is in the vicinity of the Khandadhar waterfall, which is the lifeline of the tribal and local communities. They depend on the waterfall for cultivation, livelihood, tourism, cultural practices. It is considered as an important natural heritage of the state.During the site inspection by the forest officials, it was observed that the proposed area comes under a very dense forest category. "

#### Our Constitution an ode to consensus

During times of peace, it is relatively easy to be democratic; the test arises when we are faced with social and political turmoil.

By the end of 1948, rocked by the Partition and the ensuing communal violence, anxieties about social fragmentation and separatism were tangible within the Constituent Assembly and outside it. In this demanding situation, Šardar Vallabhbhai Patel set a new benchmark for what a democracy is and should aspire to be.As the chairman of the special sub-committee set up to re-examine political safeguards for religious minorities, he said: "I was anxious that the representatives of the minorities on the Committee should have adequate time both to gauge public opinion among their people, and to reflect fully on the amendments proposed, so that a change, if affected, would be one sought voluntarily by the minorities themselves", and "not imposed on them by the majority community".Patel's words echoed the framers' commitment to democracy. A high-powered committee, with Jawaharlal Nehru, Rajendra Prasad, KM Munshi and BR Ambedkar as its members, had recommended the withdrawal of separate representation for religious minorities. The Sikh representatives were reluctant to accept this recommendation and wanted more time to consult and reflect on the proposed changes. The political stature of the members of the subcommittee should itself have elicited compliance. But this did not happen. There was political urgency to settle the issue. Yet, Patel, along with the committee members, did not force a consensus. They heard and respected the wishes of even this small group of representatives. To give Sikhs more time, he adjourned the meeting.

The majority of the representatives, including members of other minorities, had accepted the recommendations of the special sub-committee. Even most of the Muslim representatives agreed that separate representation for religious minorities be abandoned. It was the need of the hour. Under these conditions, the sub-committee could easily have ignored a few Sikh voices. After all, numbers were on their side. They could also have appealed to national interest. But this did not happen. Despite the extenuating circumstances and the weight of the numerical majority with them, Patel offered a political reasoning that defined what it means to be democratic. He did not want a major decision to be imposed upon a community. This was a spectacular lesson in what democracy entails. Today, democracy is associated with elections and rule by elected representatives. For analysts, leaders and students of political science, elections are the peg around which democracies are anchored. A few other elements - separation of powers, rule of law, respect for human rights — are thrown in for good measure, but it is winning or losing elections that matters the most. Probably because we believe that winners decide the course of things to come: they determine the policies that will be formulated. The future rests in their hands.

Against this myopic vision of what democracy is, Patel and the leadership of the sub-committee presented a grand alternative. They did not simply espouse an ideal of deliberation, they stood by it and acted upon it; showed us that democracy requires the willingness to trust and walk the mile to meet those who disagree. The moral power of this gesture compelled the other side (the dissenting voices) also to take the committee's reasoning seriously, and they too agreed to accept the recommendations. Eventually, the subcommittee on minorities voluntarily accepted the decision to withdraw separate representation for religious minorities. The members of the Constituent Assembly functioned with exemplary patience in a situation of extreme political urgency. They listened to each other, to similar, and at times, the same arguments, being presented again and again, in a sub-committee, then in the larger body, when specific provisions were being discussed, and again when the entire draft of the Constitution was discussed. In doing so, they taught the world what it means to live in a democracy and live by the idea of democracy. The issue before the special sub-committee was political safeguards for minorities. Hence, in his statement, Patel alluded to religious minorities.

## Bangladesh's resilience amid turmoil

Policymakers, basking under the success of the twin pillars of garments and remittances, have delayed serious economic reforms for the last 15 years.

Bangladesh has seen a sharp decline in projected economic growth after the recent upheavals stemming from the 'Monsoon Revolution", leading to the replacement of former Prime Minister Sheikh Hasina's government with an interim administration led by Chief Adviser Muhammad Yunus. But the country has not plunged into an economic crisis, which may have surprised some people.Yet, those who have followed Bangladesh's development trajectory know better. Unlike Pakistan or Sri Lanka, which have struggled to maintain economic stability, Bangladesh has some solid sources of economic resilience - garments, remittances and decent social sector delivery mechanisms. The political protests in July and August 2024 and their aftermath have certainly had an impact. The uprising led to repression and violence, internet shutdowns and transport disruptions, among other issues. Communications with buyers were cut off for a while.All this affected the economic activity, with official estimates of the GDP showing a growth of only 1.8 per cent during the quarter July-September 2024. The World Bank, in its latest Bangladesh Economic Update, has reduced its base case GDP growth forecast for FY25 (Bangladesh's fiscal year is July to June) to 4 per cent, down from an annual average of about 6 per cent during the previous three years. The IMF forecast, at 3.8 per cent, is in the same range.While there is much uncertainty about the future, there are also positive sentiments around the firm action taken to repair the financial sector and expectations about other reforms related to governance and the investment climate. Thus, the FY26 growth is expected to bounce back to 5.5 per cent while the IMF projects an even higher 6.7 per cent.Notably, the recent White Paper on the State of the Bangladesh Economy has questioned, among other things, the reported growth rate of the economy in the last 15 years. However, the core arguments of this essay will remain largely unaffected by any resultant corrections that the current or future governments of Bangladesh may undertake.Steady export growth over the last two decades — driven by the garment industry - has been one pillar of the Bangladesh economy. This stands in contrast to Pakistan and Sri Lanka and has helped Bangladesh to preserve macroeconomic stability and lower its vulnerability to external shocks.Within exports, the readymade garments sector stands out, accounting for about 85 per cent of goods exports. Bangladesh remains the world's second largest exporter of garments, with exports valued at \$38 billion in 2023. While the factory closures and communication disruptions did impact exports, the industry seems to be recovering quickly.In fact, over the period July to December 2024, garment exports rose by 13.3 per cent compared to July-December 2023, a number that does not suggest an industry in trouble!Bangladesh has strong fundamentals that enable it to dominate the low-cost apparel segment, including cost competitiveness, the



ability to service large orders and longstanding engagement with global apparel brands. None of these is going to change. As an aside, India or, indeed, other South Asian countries, are not an alternative to Bangladesh in this sector. They simply do not have Bangladesh's factory scale and cost competitiveness. For example, India's apparel exports were a mere \$15 billion in 2023. The other pillar of Bangladesh's economic resilience is its steady flow of remittances, which account for 4.7 per cent of the GDP.Remittances not only help stabilise the balance of payments but also contribute significantly to consumption and poverty reduction. This is especially critical for poor households, given that inflation has hovered around 9-10 per cent over the last two years.Despite the political upheaval or, perhaps, because of it (people send more money to their families when the need arises), remittances continued to grow at a rapid clip, rising 27.6 per cent during July-December 2024.Bangladesh's economic resilience has been accompanied by relatively strong social sector outcomes, where it outperforms India on several counts, including infant mortality, life expectancy, stunting, child immunisation and so on. Much of this performance can be credited to the country's robust non-governmental organisations, starting with BRAC, the world's largest NGO.Of course, this story of economic resilience is one

side of the narrative. Bangladesh has some glaring limitations as well. They are reflected in, among other things, insufficient job creation - the underlying reason for the student protests.Policymakers, basking under the success of the twin pillars of garments and remittances, have delayed serious economic reforms for the last 15 years and more despite clarion calls by economists.

Now, for the good of Bangladesh and its people, these reforms should be urgently prioritised.

The policy package needs to promote export diversification, address banking sector vulnerabilities, increase tax collections, encourage foreign investment and improve the quality of education, all underpinned by a concerted effort to improve state capacity.Bangladesh is a resilient economy. It should be able to ride over its current travails and possibly emerge economically stronger if the current dispensation is able to kickstart some of the muchneeded economic reforms.But Yunus has a delicate balancing act ahead: initiating some of the economic reforms; setting a timetable for elections, hopefully going back to a more neutral electoral arrangement (like a caretaker government); and doing this while retaining his administration's legitimacy and restoring social harmony. It is in the interests of India, South Asia and, indeed, the global community that Bangladesh navigates this tricky transition successfully.

In a tearing hurry to Make America Great Again, Trump bombarded his country and the rest of the world with a slew of executive orders on Monday. His own handling of the coronavirus catastrophe was dreadful - over 3,50,000 deaths were reported in the US in 2020, the final year of his first term — but those glaring lapses are of no consequence to him now. He has washed his hands of international collaboration to combat any future pandemic. Frump also signed America's withdrawal from the Paris climate agreement, whose main goal is to limit global warming to 1.5°C above preindustrial levels. Last year ended as the planet's hottest on record, and the target looks even more improbable now

If Trump is to be believed, America's golden age has begun (any resemblance to India's Amrit Kaal is purely coincidental). The incident was a big blot on American democracy, but the President has chosen to reward his supporters for their loyalty by pardoning them. 
with the US jumping ship. But the US President couldn't care less as he is himself adept at turning up the heat on any foe, real or imaginary. No wonder he has warned that

Mexico border a "national emergency". It's America First for him — and the world must brace itself for the worst.

## **Rarest of the rare: A legal lottery on life and death**

From a sessions judge's pen to the hangman's noose, there are many files and procedures that may delay or divert the ultimate execution of a death sentence.

Justice Frankfurter of the US Supreme Court once wrote: "A phrase begins life as a literary expression; its felicity leads to its lazy repetition; and repetition soon establishes it as a legal formula, undiscriminatingly used to express different and sometimes contradictory ideas." The phrase, rarest of the rare, when applied to capital punishment cases, has suffered the same fate.On the day a court in Kerala ordered the death penalty for Greeshma, who had poisoned her boyfriend, a court in Kolkata ensured that Sanjay Roy, who was convicted of the rape and murder of a young doctor at Kolkata's RG Kar Medical College and Hospital, escaped the noose. This brings us to the question of what exactly is a "rarest of the rare" case that warrants the death sentence. The phrase comes from the 1982 judgment of the Supreme Court in Bachan Singh vs Punjab, which upheld the constitutionality of death sentences. Justice RS Sarkaria, writing for the majority, concluded: "A real and abiding concern for the dignity of human life postulates resistance to taking a life through law's instrumentality. That ought not to be done save in the rarest of rare cases when the alternative option is unquestionably foreclosed."In the 40-odd years since the Bachan Singh judgment, the rarest of the rare formula has resulted in what judges have called a lethal lottery in executions. It is a rare sessions judge who resists the local outcry in cases that have attracted media attention.But a sessions judge's verdict of the imposition of the death penalty is subject to confirmation by a high court. Any death sentence so confirmed is invariably appealed to the Supreme Court.Even if such appeal is dismissed by the Supreme Court, the court has, by a judgment in the Mohammed Arif case, bound itself to orally hear for at least half an hour a review petition in open court.



It is only after every court option is closed that Thus, from a sessions judge's pen to the hangman's executive powers of remission and pardon are invoked. The presidential power of pardon has often been coloured by the incumbent of the office. Presidents APJ Abdul Kalam and Pratibha Patil were not inclined to reject pleas for mercy and simply refused to clear such files. President Pranab Mukherjee, however, went by ministerial advice and routinely signed clemency files without exercising any personal discretion. The decadal delay in disposing of clemency applications resulted in the Supreme Court interdicting several executions in the Shatrughan Chauhan case of 2014.

noose, there are a multiplicity of files and procedures that may delay or divert the ultimate execution of a death sentence.Faced with these vagaries, the Supreme Court came out with a third way in a case that I had argued for the prosecution. In the 2009 case of Swamy Shraddananda, Justice Aftab Alam, writing for a three-judge Bench, took note of the fact that many life sentences were commuted after 14 years of imprisonment. While a death sentence may not be warranted, 14 years was simply inadequate in particularly heinous murders. The judgment records: "A far more just, reasonable and proper course would

be to expand the options and to take over what, as a matter of fact, lawfully belongs to the Court, ie the vast hiatus between 14 years' imprisonment and death. It needs to be emphasised that the Court would take recourse to the expanded option primarily because in the facts of the case, the sentence of 14 years' imprisonment would amount to no punishment at all."It is in the above background of Supreme Court judgments that one must read and applaud Judge Anirban Das, who ruled, "Given these considerations, it would be inappropriate to accede to the prosecution's request for the death penalty. While acknowledging the immense grief and suffering of the victim's parents, for which no sentence can provide complete solace, the court's duty is to pass a sentence that is proportionate, just and in accordance with established legal principles. In conclusion, this case calls for a carefully considered and appropriate sentence that balances the gravity of the crime with the principles of justice, rehabilitation and the preservation of human dignity. The court must resist the temptation to bow to public pressure or emotional appeals and instead focus on delivering a verdict that upholds the integrity of the legal system

and serves the broader interests of justice."Following an announcement by Chief Minister Mamata Banerjee, the West Bengal government has approached the Calcutta High Court, seeking imposition of the death sentence to Sanjay Roy.In the Kerala case, the death sentence awarded to Greeshma will be subject to a reference to the high court. I would be surprised if the life of either accused ultimately ended on the hangman's noose.

But then, the lethal lottery of life and law has its own way of surprising practitioners and petitioners alike.

- The other broader market indices were trading marginally higher as high volatility continued to keep investors on the edge.While most of the Nifty sectoral indices were trading in positive territory, none registered a big gain in early trade. On the other hand, Nifty Pharma was down over 1.5%
- The top gainers on the Nifty50 were BPCL, Powergrid, Shriram Finance, Coal India, NTPC and Tata Steel.Pharma stocks such as Dr Reddy's, Apollo Hospitals, Sun Pharma, Cipla were among the top losers.Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said, "Nifty may face a volatile session today, with a strong chance of closing below the psychological 23000 mark as uncertainty around President Donald Trump's tariff plans persists.""Technically, Nifty is trading well below its 200-day moving average of 23982, and a bearish pattern continues to emerge on the daily charts. Major headwinds include record outflows from Foreign Institutional Investors, amounting to Rs. 66,321.70 crores this January, and ongoing tariff threats," he added.
- He advised market investors to keep an eye on key upcoming events, like the FOMC meeting and the Union Budget as they can influence market direction."Among stocks, UltraTech Cement surged 7% despite a 17% profit decline, while KEI Industries reported strong earnings. Also, watch out for Q3 results from JSW Steel, DLF, and Indigo today," he added.Meanwhile, Dr VK Vijayakumar, Chief Investment Strategist, Geojit Financial Services, indicated that foreign institutional investors (FIIs) will continue to sell, putting pressure on large-cap banking stocks.

#### Capex allocation may not rise much

NEW DELHI. Mansukh Mandaviya, Minister of Labour and Employment, recently said India must increase allocation for infrastructure spending to Rs 15 lakh crore from the present Rs 11.11 lakh crore.

- However, given the fiscal constraints and the likely inability of the government to fully spend the Rs 11.11 lakh crore allocation for capital expenditure (capex) in the current financial year, it is unlikely that the government may hike capex allocation much in the coming budget. Most analysts expect capex allocation to rise by 10-12% over actual capex in FY25.Analysts have projected the capex allocation for FY26 in the budget to be at the same level as was budgeted for the current financial year - Rs 11.11 lakh crore. Some of them have even lowered the capx allocation to below current year's budget target -- the reason being sharp fall in Capex spending in FY25 by the central government.
- Rating agency ICRA expects the capex allocation for FY26 to be Rs 11 lakh crore, Nomura pegs the capex allocation at Rs 10.7 lakh crore. Morgan Stanley estimates capex allocation in the budget to be Rs 11.2 lakh crore. Aditi Nayar, chief economist, ICRA Ratings says: "...a likely dip in revenue deficit would allow for a capex target of Rs 11 lakh crore for

Further, HUL will invest approximately Rs 45 crore directly into Minimalist.

After the deal is completed in the first quarter of FY26, the startup will see multiple exits.

Minimalist's founders, Rahul Yadav and Mohit Kumar Yadav, Peak XV, and Surge, which provided the seed investment, along with Twenty Nine Capital Partners will exit the startup.

It is expected that the co-founders of Minimalist will sell 57.35% of their stake for nearly Rs 1.500 crore. Also, in two years, the remaining 9.5% of Minimalist would be purchased by HUL. Minimalist's founders will supervise the

#### US sanctions start to impact supplies from Russia

NEW DELHI. The US sanctions on Russian oil sector have started to show impact on India's nearterm oil flows with state-owned Bharat Petroleum Corporation Ltd (BPCL) saying not enough cargoes are available from Russia for March 2024. BPCL Director (Finance) Vetsa Ramakrishna Gupta stated during an analyst call on Thursday that BPCL had booked Russian crude for January and February, but for March, "We are not getting sufficient cargoes."He also noted that Russian oil's share in the company's overall crude oil basket has decreased to 20% in March from 31% in the October-December quarter.At the start of the current financial year in April 2024, Russian oil accounted for 34-35% of BPCL's processed oil. This significant share was primarily due to Russian crude being available at a discount to other internationally traded oil, resulting from the price cap and European country's shunning purchases from Moscow. Gupta mentioned that the discounts on Russian oil have narrowed to \$3-3.2 per barrel from \$3.5-4 at the start of the current financial year and \$8.5 in the 2023-24 financial year.

Gupta assured that there is enough oil available in the market and the company would explore alternative sources such as the Middle East to replace the lost volumes from Russia. Russia accounted for just 0.2% of India's total oil imports in the year ending March 31, 2022.

However, India became the second-largest buyer of Russian crude oil after Moscow invaded Ukraine in February 2022, with purchases rising to almost 40% of the country's total oil purchases. The US imposed sweeping sanctions targeting the Russian energy sector on January 10, including sanctions on oil producers Gazprom Neft and Surgutneftegas and curbs on various entities involved in Russian energy exports. This month India has decided to avoid deliveries made by tankers sanctioned by the US in the latest round.

## NPAs may rise 25% in this and next fiscals over FY24 on rising stress in unsecured retail books

#### Rapid growth in retail lending in recent years, particularly in

#### unsecured loans, has increased medium-term risks, according to rating agency Fitch.

NEW DELHI. The increasing stress levels in unsecured retail loan books of banks can spiral out of control and create asset quality risks this fiscal to the tune of 25 percent over the past fiscal's level, the international rating agency Fitch has warned.Private sector banks like HDFC Bank, Kotak Mahindra Bank among other which have declared their Q3 earnings have reported massive spike in their retail, agriculture and MFI books."We forecast the banks' impaired-loan ratio to fall by 40 bps to around 2.4% for the current financial year and by another 20 bps next fiscal, despite expecting new bad loans in FY25 and FY26 to be around 25 percent higher than in FY24" Fitch Ratings said in a report Thursday.

Rapid retail lending growth in recent years, particularly unsecured loans, has heightened medium-term risks, the agency said, adding "however, we still expect the impaired-loan ratio to fall in FY25 and FY26, driven by robust loan growth, as well as recoveries and write-offs, which are expected to offset the increase in fresh bad loans.

The Reserve Bank expects the impairedloan ratio to trough in FY25 before rising to around 3 percent in FY26, from the 2.6 percent in the first half of FY25.

We believe the difference from our forecast partly reflects variance of opinions on the timing and extent of risk crystallisation, banks' exposure at risks, loan growth and the country' overall economic performance," the agency said.Unsecured personal loans and credit card borrowings grew at 22% and 25 percent, respectively, in each of the past three years to FY24, but slowed to 11 percent and 18 percent, respectively in the first half of the current fiscal, after the RBI hiked the risk weights attached to unsecured lending by 25 percentage points in November 2023

Although household debt remains low

compared to many Apac emerging markets, at 42.9 percent of GDP as of June 2024, stress in unsecured retail loans has been rising, making up roughly 52 percent of new bad retail



loans in the first half of this fiscal.

The impact of defaults on unsecured loans can be amplified as around 50% of borrowers reportedly hold at least one other, often high-value secured retail loan, such as a housing or vehicle loan, which could also be affected in the event of default, the report said.Currently, lending stress appears to be concentrated in unsecured personal loans of under Rs 50,000."Large banks' exposure to such riskier loans may be proportionally lower than the system's,

but they are not completely insulated, given their high loan growth appetite and increased digital lending in recent years. Banks may also have indirect exposure through funding to non-banks and fintechs, which are more exposed to low-income borrowers. Low-income borrowers, or those without income disclosure, constitute slightly over onethird of the system's outstanding consumer credit," the report said, adding this fast emerging risks could spill over to the higher income categories in a market downturn, given the correlation between rapid unsecured personal loan growth and increased retail participation in financial markets since FY20.

The report said exposure to unsecured personal and credit card loans banks it rates ranges between 2 percent and 15 percent of total loans. Accelerated write-offs, particularly private banks that are more aggressive lenders to this segment, likely played a role in keeping the bad-loan ratio in this segment muted at 1.7 percent in the first half of this fiscal, compared to the overall retail bad loan ratio of 1.2 percent, which includes lower-risk housing and vehicle loans, the report concludes.

However, it also led to friction with teammates, including Tiwary, who described Gambhir's behaviour as unnecessarily harsh and, at times, hurtful. Tiwary revealed that their disagreements often escalated to the point where others

had to intervene. He recalled one specific incident when KKR's then bowling coach, Wasim Akram, had to step in to prevent a war of words between the two."I would get scolded without any reason. I couldn't understand why he would target me. In fact, when I came to KKR in 2010, he and I got along nicely. But then he would lose his cool at me out of the blue. He would use very hurtful words. Then, when I started thinking about it, I realised that out of all the local boys at KKR, I was the one who used to perform consistently. And since I was a promising youngster, the media was giving me attention. So, he didn't react to it well. That is what I believe," Tiwary said on Lallantop."Once, we had a heated argument about my batting position at the Eden Gardens. I was upset and had gone to the washroom. He barged in and said 'This attitude won't work. Tujhe kabhi khilaunga nahi (I won't give you a game). This and that.



I never liked such words. He was giving me a threat. Aaj ke baad, tujhe kabhi khilaunga nahi. Wasim Akram also came in. He was our bowling coach, so he calmed things down. He said 'You are the captain. Cool down' He understood, he knew what was happening. He had said good things about my talent a few years ago," Tiwary said.Gambhir, who now serves as India's head coach, has often been a divisive figure in cricket. His no-

nonsense attitude and strict approach have drawn criticism from players and commentators alike. Recently, Tiwary openly criticised Gambhir's appointment as head coach following India's Test series defeats to New Zealand and Australia. He questioned Gambhir's credentials for the role, labelling him a "hypocrite" who fails to practise what he preaches. Tiwary argued that Gambhir lacks clarity in his coaching philosophy and has yet to establish a distinctive style that benefits the national team.Gambhir's uncompromising approach has also been evident in his current role as head coach.
