Rahul Gandhi finds special mention in AAP's list of dishonest people

For the first time, Congress leader Rahul Gandhi's picture appears on one of AAP's posters, with the party terming him "dishonest" alongside PM Modi, Home Minister Amit Shah, and Delhi BJP leaders.

NEW DELHI. The Aam Aadmi Party on Saturday escalated its poster war ahead of the Delhi Assembly elections, taking aim at rivals Congress and the BJP. For the first time, Congress MP Rahul Gandhi was featured prominently in the Arvind Kejriwal-led party's campaign posters. The poster, which bears the provocative tagline "Kejriwal's honesty will outweigh all the dishonest people" also features photos of Prime Minister Narendra Modi, Home Gandhi had previously alleged that Kejriwal was Minister Amit Shah, Uttar Pradesh Chief

The BJP also released a new poster on social media, renewing its 'aapda' (disaster) attack on

the ruling party in Delhi. "On 5th February, people of Delhi will teach a lesson to AAP-da gang of big thugs full of goons and criminals!" it captioned the post. The Delhi Assembly election, scheduled for February 5 with results on February 8, is shaping up to be a triangular contest. Despite being allies in the INDIA opposition bloc, AAP and Congress are contesting the polls separately. AAP leaders have dismissed Congress as "irrelevant" in Delhi's political landscape, accusing it of colluding with the BJP.With the stakes high, Kejriwal's party has sought to frame the election as a battle between its "honest governance" and what it calls the failures of both national parties.

HC upholds order against petition seeking AIMIM's de-registration

NEW DELHI: The Delhi High Court has upheld the dismissal of a petition seeking quashing of the registration granted by Election Commission of India (ECI) to All India Majlis-e-Ittehadul Musalimeen (AIMIM) as a political party.

A division bench comprising Acting Chief Justice Vibhu Bakhru and Justice Tushar Rao Gedela rejected the appeal moved by Tirupati Narashima Murari challenging the dismissal of the plea by a single judge in November last

Before the single judge, Murari had challenged a circular issued by ECI in 2014 granting recognition to AIMIM as a State level party in the State of Telangana

Upholding the single judge order, the division bench rejected Murari's contention that AIMIM does not fulfil the conditions laid down under Section 29A of the Representation of the People Act, 1951. It was submitted by Murari that the object of the party was to further the interest of only one religious community. It was also contended that AIMIM does not spouse secular values and, therefore, grant of registration was violative of the Section 29A of the RP Act. The Bench said that AIMIM had amended its constitution to conform to the provisions of Section 29A(5) of the RP Act and thus, Murari's argument did not survive. "We find no infirmity with the conclusion of the learned Single Judge that the requirements of Section 29A(5) of the Act are fully satisfied. Therefore, there is no ground to de-register AIMIM as a political party on the ground that its constitution does not conform to Section 29A(5) of the RP Act," the

Vande Bharat train's 1st trial run on world's highest rail bridge in J&K

Indian Railways conducted the first trial run of Vande Bharat train from Shri Mata Vaishno Devi Katra station to Srinagar station on Chenab Bridge.



Srinagar. India's prowess in railway technology was on full display on Saturday as it conducted the first trial run of Vande Bharat train from Shri Mata Vaishno Devi Katra station to Srinagar station on Chenab Bridge, the world's highest railway bridge. The train will also pass through Anji Khad Bridge, India's first cable-stayed railway bridge.

Climate adaptability has also been factored in while designing the train, keeping in mind the comfort of the passengers when it comes to travelling in cold climatic conditions of the Valley. The train can operate at a temperature as low as -30 degrees Celsius

The chair-car train boasts advanced heating systems to keep water from freezing and bio-toilet tanks.

What did Pawar do as agri minister for 10 yrs, asks Shah

MUMBAI. Union Home Minister Amit Shah on Friday attacked NCP (SP) president Sharad Pawar, saying he failed to do anything for the cooperative sector during his 10-year tenure as the agriculture minister in the UPA government at the Centre. Shah said the soldiers and farmers are important for the country, adding that Prime Minister Narendra Modi created the cooperatives department for the development of farmers. "Farmers are now being developed through the cooperative department. Sharad Pawar was the agriculture minister at the Centre for 10 years, what he did for the country? He could not even make a separate cooperative department for the farmers," Shah said while inaugurating a soil-testing centre for farmers at Ajang in Nasik.

What did Mr Pawar do for sugar factories, farmers, cooperatives? He only marketed himself as a leader of the co-operative sector. But what did he do for this sector? It's easy to become a leader through marketing, but you have to work on the ground. PM Narendra Modi

is working to connect farmers with multinational companies and develop them," he said.

'Lal Bahadur Shastri had given the slogan 'Jai Jawan Jai Kisan'. Modi gave the slogan 'Jai

Jawan, Jai Kisan and Jai Vigyan'. Agriculture becomes profitable if cooperation and science are combined. When Modi started soil testing, farmers understood which crops to grow on which soil. They get information about the pH level of water, whether to add sulfur or not...Agriculture and science together will usher prosperity and better livelihood to farmers," Shah said.

'The money generated by selling agricultural products by establishing an organic corporation will go to the farmers' accounts," Shah said, appealing to farmers to produce products with organic certificates. New Delhi: Prabowo Subianto, the President of Indonesia, was formally welcomed at Rashtrapati Bhavan in New Delhi on January 25,

His visit marks his first State Visit to India since assuming office in October 2024, and he is the Chief Guest for India's 76th Republic Day celebrations. The ceremonial welcome highlights the significance of the visit and sets the stage for enhanced diplomatic discussions between India and Indonesia.

Prabowo met with Indian President Droupadi Murmu and Prime Minister Narendra Modi at Rashtrapati Bhavan. Their meeting focused on strengthening the bilateral relationship between the two nations, with discussions on political, security, defence, and trade coopera-

During his visit, President

Prabowo expressed his gratitude and highlighted the longstanding friendship between the two countries. He said, "...Indonesia considers India a very great friend. India was one of the first countries, maybe the first country to recognise our independence, to support us in our struggle for independence, we will never forget what India did to help us. I am very honoured today and I am doubly honoured that tomorrow I will be the chief guest at your Republic Day parade...I'm committed to promoting closer cooperation, closer partnership with India. That is my determination."

This State Visit, from January 25 to 26, 2025, is an opportunity for both countries to review their bilateral relations and discuss regional and global issues of mutual concern. Indonesia, a Comprehensive Strategic Partner of India, plays a

vital role in India's "Act East" policy, aimed at strengthening relations with East Asia and enhancing India's influence in the Indo-Pacific region.

India and Indonesia share a rich history of cultural and commercial ties dating back over two millennia. The exchange of Hindu, Buddhist, and Muslim traditions from India to Indonesia has shaped the cultural landscape of both nations, fostering strong and enduring ties.

Indonesia's first Republic Day guest, President Sukarno, was honored in 1950, and both countries have supported the independence movements of Asian and African nations, exemplified by their roles in the Bandung Conference and the formation of the Non-Aligned Movement.

Kerala ration traders to hold indefinite stir from January 27

KOCHI. Lakhs of ration card holders are likely to miss out on their January quota of food items, as ration traders in Kerala gear up for an indefinite strike from January 27 demanding revised wage package and in protest against the Centre's direct payment system. The strike is expected to worsen the already-dwindling stocks in most ration shops across the state, which have been impacted by a three-week-old strike by



contractors distributing essential items. The Ration Traders Coordination Committee took the decision after talks with Finance Minister K N Balagopal and Food and Civil Supplies Minister G R Anil failed.Its members said the current wage package, approved in 2018, was unviable and was not reviewed despite the chief minister's suggestion to do so within six months.

N Shijeer, the organising secretary of the committee, said the current commission structure for ration shops, formulated in 2018, ensures a monthly commission of Rs 18,000 for selling 45 quintals of food grains."This breaks down to Rs 8,500 in government support and Rs 220 per quintal. Despite repeated requests, the commission structure has not been revised in six years,"

GSLV-F15/NVS-02 to launch on January 29: ISRO

BENGALURU. The Geosynchronous Satellite Launch Vehicle (GSLV)- F15/ Navigation with Indian Constellation-2 Satellite (NVS-2) Mission will launch from Satish Dhawan Space Centre, Sriharikota on January 29 at 6.23am.Researchers from the Indian Space Research Organisation (ISRO) said that the satellite was flagged off to Sriharikota on January 5, 2025.

This is the 17th flight of India's GSLV and the 11th flight with indigenous cryostage. It is also the eighth operational flight of GSLV and with an indigenous Cryogenic stage and the 100th Launch from the India's Spaceport



Sriharikota. GSLV-F15 payload fairing is a metallic version with a diameter of 3.4 meters. ISRO also took to X- platform to announce the date announced that people can register through its online platform to view the launch from the Sriharikota centre.

The GSLV-F15 will place NVS-02 satellite into a Geosynchronous Transfer Orbit. The NavIC is an independent regional navigation satellite system designed to provide accurate Position, Velocity and Timing services. The NVS-02 uses a combination of indigenous and procured atomic clocks for precise time estimation.ISRO shared, the NVS-02, is the second satellite in the NVS series and is configured with Navigation payload in L1, L5 and S bands in addition to ranging payload in C-band like its predecessor-

Commission appointment on Munambam land issue 'looks like an eyewash': **Kerala High Court** KOCHI. The Kerala High Court on

Friday observed orally that the appointment of a commission headed by Justice C N Ramachandran Nair to inquire into the Munambam land issue looks like an eyewash."There is no proper application of mind in the order appointing the commission. Looks like an eyewash. What is the state government's authority to appoint the inquiry commission? In a matter that has already been concluded by a civil court judgment, and affirmed by a High Court in the appeal, can a commission of inquiry come up and arrive at a different conclusion," asked Justice Bechu Kurian Thomas. The court made the observation when a petition filed by the Kerala Waqf Samrakshana Vedhi, Ernakulam, seeking to quash the order appointing the commission, came up for hearing. The court adjourned the hearing to January 29. A civil court had earlier ruled that the land was Waqf property and the High Court later upheld it.

"It is a settled proposition that once the title or right of a property is settled, no other court, including the High Court, can interfere with it," the court said, adding that if the commission is going to consider the title of the property, then it is "intruding into the rights already settled". The commission cannot say that despite the land being Waqf property, the government can pass an order cancelling the titles of the property. If the commissions arrive at a different conclusion, "it would open a Pandora's box", the court stated. The court said the government did not exclude the waqf property from the notification. It also noted that the Waqf Commission had gone into the issue of waqf land in 2010 and its findings were approved by the government. "None of these matters had been considered while appointing the new commissionThe terms of reference of the commission did not say that the inquiry would be confined to the land other than the Waqf property. As such, the appointment of a commission to inquire into the waqf property will affect the rights of the parties concerned.

NIT-Calicut suggests upgrades for Akkulam Glass Bridge

THIRUVANANTHAPURAM. The controversial Akkulam Glass Bridge -touted as the longest bridge in the state - is all set to get more safety upgrades with the National Institute of Technology-Calicut (NIT-C) submitting recommendations after a safety assessment. It is learned that the safety assessment report has recommended to provide beadings for glass panels to enhance the safety of the glass bridge. The bridge constructed at a cost of Rs1.2 crore was expected to be thrown open for the public in March last year.

However, the opening of the bridge was delayed inordinately after the glass bridge developed cracks raising serious concern over the quality and safety standards of the infrastructure. The recurrence of cracks in the glass bridge had put the tourism department in the dock.

The adventure tourism activities at the Akkulam Tourist Village are jointly implemented by Vattiyoorkavu Youth Brigade Entrepreneurs Cooperative Society (VYBeCOS) and the



District Tourism Promotion Council (DTPC). The glass bridge was constructed by VYBeCOS under the BOT (Build Operate Transfer) model. The 45-metre-long glass bridge has been constructed at a height of 75 feet. An official source said that the NIT submitted the report two days back.

'The report with recommendations has been handed over to VYBeCOS. They have already initiated steps to execute the recommendations. After the implementation of the safety upgrades one more expert agency will review the safety and then only the government will open the bridge for the public," an official source said. A series of controversies erupted following the incident on the previous experience and expertise of the agency executing the project. According to VYBeCOS, after safety upgrades, they are hoping to hand over the bridge to the tourism department within two months."There are no issues with the structure and the NIT has only given recommendations for safety upgrades.

We have started the preparations and the work will be completed very soon," said Ratheesh C S, president of VYBECoS.Meanwhile, the DTPC is planning to introduce nightlife in the tourist village. "Tourism Clubs are already active at the park and we are planning to hold more cultural events during the evenings to keep the visitors engaged and spend more time in the village.

Six kids injured in Anganwadi NIT-R team comes up with AI-based system to ease traffic woes ceiling collapse in Telangana

SANGAREDDY. As many as six children were injured when a pieces of the roof collapsed at an Anganwadi centre in Venkatapur, Narayanakhed mandal on Friday. Among them, two girls sustained serious injuries. According to sources, about 15 children were playing inside the Anganwadi centre when pieces of the roof suddenly fell. Panicked and confused, the children started crying and ran out of the room. The staff rushed the injured children to the government hospital for treatment. All of them were below five years of age. Harika and Mounika received head injuries, while Ankitha, Pranay, Avinash and Rayanika received minor injuries. Upon learning about the incident, Collector Valluri Kranthi and MLA Dr Sanjeeva Reddy visited the hospital to meet the children and their parents. The collector immediately ordered an inquiry into the incident and warned of strict action against those found



responsible.SANGAREDDY: Taking serious note of the incident, Collector Valluri Kranthi suspended the incharge Child Development Project Officer (CDPO) Sujatha and Anganwadi teacher Ambika with immediate effect. The collector also instructed the District Women and Child Welfare Officer to submit a detailed report on the condition of Anganwadi centres across the district and ensure that such incidents do not recur.

ROURKELA. Researchers

at National Institute of Techology-Rourkela (NIT-R) have developed an AIbased multi-class vehicle detection (MCVD) model and light fusion bidirectional feature pyramid network (LFBFPN) tool to help improve traffic management.Led by associate professor in department of Electronics & Communication Engineering (ECE) Santos

Kumar Das, the research team has leveraged an intelligent vehicle detection (IVD) system, which uses computer vision to identify vehicles in images and videos.

To address the challenges of Indian road conditions with complex and mixed traffic, Das and his team have developed a new MCVD model which uses video de-interlacing network (VDnet) to efficiently extract key features from traffic images, even when vehicles vary in size and shape. They have used LFBFPN to further refine the extracted details.Das said, "What makes LFBFPN unique is that it uses a simpler method, reducing the complexity of the model without sacrificing its accuracy. The system then processes the details through another tool called modified vehicle



detection head (MVDH), which helps accurately detect and classify vehicles in all kinds of traffic situations."

he MCVD model demonstrates an improved accuracy compared to existing methods. The team tested the model using the heterogeneous traffic labelled dataset (HTLD) which includes data from several cities across India available for public use.

The model's real-time performance was also evaluated on edge computing device Nvidia Jetson TX2 where it maintained strong speed and accuracy even under challenging weather conditions and with low-resolution images."By overcoming the limitations of older models and addressing the unique challenges of mixed traffic, the MCVD model offers a scalable option for real-time vehicle detection in developing countries. Its use could help improve traffic systems, reduce congestion and enhance road safety," said Das.

A research paper on the findings co-authored by Das and his team of research scholars Prashant Deshmukh and Krishna Chaitanya Rayasam along with Prof Upendra Sahoo from ECE, NIT-R and Prof Sudhan Maihi from

IISc Bangalore has been published in the prestigious journal IEEE Transaction on Intelligent Transportation Systems.

According to Das, the traditional IVD model including sensor systems such as radar and light detection and ranging (LiDAR) work well for developed countries with organised traffic. However, these systems face challenges in developing nations with mixed traffic comprising bicycles, two-wheelers, cars, trucks, rickshaws, animal carts and pedestrians often operating in close proximity, and struggle in adverse weather condition besides being too expensive, he added. The research team is further working on developing a traffic control system based on this idea and also planning to commercialise it through a start-up.

In its reply on January 13, the NMC stated, "The matter has been transferred to the legal section UGMEB, NMC, and as per available information, the matter is sub judice." The Undergraduate Medical Education Board (UGMEB) determines standards of medical education at the undergraduate

The NMC listed the names of the institutions on its website, including Delhi's Maulana Azad Medical College, Atal Bihari Vajpayee Institute of Medical Sciences, and Dr. RML Hospital, only after the Supreme Court ordered them to submit the details of the stipends paid to the medical interns and residents.

Dr. Babu, who also filed an RTI in 2023 on this matter, said, "In an RTI response in 2023, they refused to share the details of college managements, which took back the stipend paid to 1,228 PGs, invoking third-party information. To date, there is nothing in the public domain about any action taken against those colleges.'

In a letter dated November 28 last year, NMC Secretary Dr. B. Srinivas said that the "defaulting medical colleges are directed to furnish the data relating to payment of stipends during 2023-24 on the dedicated email ID stipend23-24@nmc.org.in immediately and within the next 3 days from the issue of this show-cause notice.'

Max temp touches 23.7°C, foggy weather leads to flight delays in Delhi; moderate AQI recorded

The weather department has forecast clear skies for Saturday with predominant surface winds expected from the northwest direction.

NEW DELHI. The city woke up to a thin layer of fog on Friday morning as the foggy weather again led to extended flight delays at the Indira Gandhi International Airport, causing inconvenience to air travellers.

Meanwhile, Delhi recorded a maximum temperature of 23.7 degrees Celsius, according to the weather department, IMD. The minimum temperature stood at 9.8 degrees Celsius, 2.3 degrees above average, with humidity levels fluctuating between



90 and 58% during the day.Delhi weather conditions are likely to remain the same in the next two to three days, with persistent fog conditions during the morning hours. The IMD has predicted foggy weather conditions and a nominal reduction in the temperature for the next four days. The weather department has forecast clear skies for Saturday with predominant surface winds

expected from the northwest direction. Moreover, the 24-hour average Air Quality Index (AQI) was recorded in the 'moderate' category at 199, according to the Central Pollution Control Board (CPCB). An AQI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500 "severe".

Noida sees this year's first 'satisfactory' air

Noida. Air quality in Noida and Ghaziabad improved from 'moderate' to 'satisfactory' on Friday. Noida recorded an AQI of 80 from 135, Greater Noida 99 from 189, and Ghaziabad 92 from 164 compared to the previous day. It marks the first time in Jan that both the cities recorded a 'satisfactory' AQI.Before this, Noida and Ghaziabad recorded 'satisfactory' AQI readings of 100 and 83, respectively, on Dec 30 and Greater Noida (90) on Dec 28. The AOI at Noida monitoring stations in sectors 125 and 116 was 80 and 79, respectively. The details of stations at sectors 62 and 1 were not available.

In Greater Noida, Knowledge Park V recorded 111 (moderate), and Knowledge Park III recorded 88 (satisfactory).Of the four monitoring stations in Ghaziabad, only Indirapuram recorded a 'moderate' AQI (105). The AQI at Loni (96), Vasundhara (92), and Sanjay Nagar (76) remained satisfactory.

According to a bulletin issued by the Indian Institute of Tropical Meteorology (IITM), the predominant surface wind from the northwest prevailed at less than 12kmph until evening before plummeting below 8kmph on Friday night.Residents may witness shallow fog in the morning on Saturday, with the predominant surface wind from the northwest at a speed of less than 8kmph. Wind speed will gradually increase thereafter, becoming 12-14kmph from the northwest during the afternoon.

Yoshitha Rajapaksa, son of former Sri Lankan president, arrested on corruption charges

COLOMBO. Former Sri Lankan president Mahinda Rajapaksa's son Yoshitha Rajapaksa was arrested by police on Saturday on corruption charges in a property purchase case.Ex-navy officer Yoshitha was arrested from their home territory of Beliatta over the investigation of alleged misconduct in the purchase of the property during the term of his father's presidency prior to 2015.

Yoshitha is the second among Mahinda Rajapaksa's three sons. His uncle and former president Gotabaya Rajapaksa was also quizzed by the police last week on the same property - a holiday home in the southern religious resort of Kataragama. The arrest came as Mahinda Rajapaksa filed a fundamental rights petition on Friday in the Supreme Court seeking its intervention to reinstate his security, which was significantly reduced by the government last month. Since the formation of a new government led by President Anura Kumara Dissanayake in November last year, Mahinda Rajapaksa's eldest son and legislator Namal Rajapaksa was quizzed by the police over another property case alongside an employee of Mahinda Rajapaksa. The new government in the run-up to elections had vowed to arrest everyone accused of wrongdoing during Mahinda Rajapaksa's presidency between 2005 and

Polio Returns To Pakistan, Afghanistan As Vaccinations Stall

World Poliomyelitis was responsible for paralysing and killing up to half a million people every year before the development of the poliovirus vaccine in 1955. By 2000, through mass vaccination campaigns of oral polio vaccines, the world had almost eradicated poiliovirus barring a few regions.

However, the global fight against polio has encountered a significant setback, as cases of the disease have begun to rise again in Pakistan. Despite being on the brink of eradication in 2023, with only six reported cases of the wild form of the virus, the number of cases has surged to 73 in 2024. This alarming trend has prompted concerns among health experts, who point to the ongoing conflict in Afghanistan as a major factor contributing to the spread of the disease.Per data from the WHO, infectious diseases such as pneumonia, dengue fever and measles have also been on the rise in Afghanistan since the last six months. Zulfiqar Bhutta, a renowned expert on child immunisation strategies in conflict zones, said that the genetic strains of wild poliovirus in Pakistan are all from Afghanistan, per a report on Deutsche Welle.Bhutta, who has worked extensively in the region, attributes the resurgence of polio cases in Pakistan to the spillover of the virus from Afghanistan. "It has spread to all districts of Pakistan. We've snatched defeat from the jaws of victory," Bhutta lamented."It's a virus that does not want to be eradicated, so give it an inch and it will take a yard," Bhutta said. The challenges facing polio eradication efforts in the region are multifaceted. Bhutta cites the poor sanitary conditions, and regional insecurity as significant obstacles. The lack of reliable data on poliovirus cases in Afghanistan further complicates efforts to combat the disease.

Ex-Sri Lankan President's Son Arrested By Police Over **Corruption Charges**

Colombo.Former Sri Lankan president Mahinda Rajapaksa's son Yoshitha Rajapaksa was arrested by police on Saturday on corruption charges in a property purchase case.Ex-navy officer Yoshitha was arrested from their home territory of Beliatta over the investigation of alleged misconduct in the purchase of the property during the term of his father's presidency prior to 2015. Yoshitha is the second aong Mahinda Rajapaksa's three sons. His uncle and former president Gotabaya Rajapaksa was also quizzed by the police last week on the same property - a holiday home in the southern religious resort of Kataragama. The arrest came as Mahinda Rajapaksa filed a fundamental rights petition on Friday in the Supreme Court seeking its intervention to reinstate his security, which was



significantly reduced by the government last month. Since the formation of a new government led by President Anura Kumara Dissanayake in November last year, Mahinda Rajapaksa's eldest son and legislator Namal Rajapaksa was quizzed by the police over another property case alongside an employee of Mahinda Rajapaksa. The new government in the run-up to elections had vowed to arrest everyone accused of wrongdoing during Mahinda Rajapaksa's presidency between 2005 and

Israel, Hamas are set to swap more hostages for prisoners in another test of the Gaza ceasefire

The conflict began with a cross-border attack led by Hamas on Oct. 7, 2023, when Palestinian militants killed some 1,200 people, mostly civilians, and took around 250 others, hostage.

DEIR AL-BALAH. Israel and Hamas were expected to swap more hostages for Palestinian prisoners on Saturday, the second such exchange since a ceasefire began in the Gaza Strip last weekend and another test for the deal. The truce is aimed at winding down the deadliest and most destructive war ever fought between Israel and the militant group. The fragile deal has so far held, quieting airstrikes and rockets

and allowing for increased aid to flow into the tiny coastal territory. When the ceasefire started Sunday, three hostages held by the militants were released in exchange for 90 Palestinian prisoners. On Saturday, four hostages are expected to be freed for 200 prisoners, including 120 who are serving life sentences after being convicted of deadly attacks on Israelis. They will likely be released into Gaza or sent abroad. The four Israeli soldiers, Karina Ariev, 20; Daniella Gilboa, 20; Naama Levy, 20; and Liri Albag, 19, were captured in Hamas' Oct. 7, 2023

attack that ignited the war. They were taken from Nahal Oz base near the border with Gaza when Palestinian militants overran it, killing more than 60 soldiers there. The female abductees had all served in a unit of lookouts charged with monitoring threats along the border. A fifth female soldier in their unit, Agam Berger, 20, was abducted with them but not included in the list. After the swap, Israel is expected to begin pulling back from the

dividing Gaza in two — and allowing displaced Palestinians in the south to return

What Americans think about Trump and Musk's plans for the federal government

WASHINGTON. Americans see the federal government as rife with corruption, inefficiency and red tape but they're less sure about whether Elon Musk is the right person to fix it.

A new poll from The Associated Press-NORC Center for Public Affairs Research shows that only about 3 in 10 U.S. adults strongly or somewhat approve of President Trump's creation of an advisory body on government efficiency, which Musk is helming. About 4 in 10 disapprove, while the rest were neutral or didn't know enough to say. (The poll was conducted before Vivek Ramaswamy announced he would no longer be involved in the group.) The goal of the advisory body, the Department of Government Efficiency, or DOGE, is to expose fraudulent and wasteful spending across the federal bureaucracy, and its leaders have floated a range of possible ways to cut costs, including eliminating entire agencies. But although most agree that the federal government is facing major problems, many Americans also have an unfavorable view of Musk and are hesitant about the Republican president relying on billionaires for advice about

government policy. As the plans take Americans see a broken federal more concrete shape, the poll shows that Americans are ambivalent about some of the changes that Trump and his team have mentioned in the past few months — including eliminating large numbers of federal jobs and moving

US Senate confirms former Fox News co-host Pete Hegseth as defence secretary

WASHINGTON: The US Senate narrowly confirmed former Fox News co-host Pete Hegseth as Pentagon chief on Friday, despite allegations of alcohol abuse, sexual misconduct and other fears about his ability to lead the world's most powerful military.

Three Republican senators voted against Donald Trump's pick as secretary of defence, resulting in a 50-50 tie that required J.D. Vance to cast the deciding ballot -- only the second time in history a vice president has had to intervene to save a cabinet nominee.

The razor-edged result underscored concerns about Hegseth, who will take over the Pentagon with war raging in Ukraine, the Middle East volatile despite ceasefires in Lebanon and Gaza, and as Trump expands the military's role in security on the US-Mexico border. The 44-year-old is a former Army National Guard officer who until recently worked as a co-host for Fox News --

one of Trump's favored television channels. Hegseth has a combative media personality, fierce loyalty and telegenic looks -- common hallmarks in Trump's entourage. Supporters say Hegseth's deployments in Afghanistan and Iraq give him the insight to run the Defense Department better than more



experienced officials who would normally be considered for the job.He has pledged to focus the military on "lethality" and to bring back "warrior culture" to the Pentagon.In confirming him, Republicans brushed aside his lack of experience leading an organization anywhere near the size of the Defense Department -- the country's largest employer with some three million personnel. They also approved Hegseth despite allegations of financial mismanagement at veterans' nonprofits where he previously worked, reports of excessive drinking, and allegations that he sexually assaulted a woman in California. Asked during his confirmation hearing last week about criticism he has faced, Hegseth said there was a "coordinated smear campaign" against him, and that he is "not a perfect person, but redemption is real." Trump has stood by him, telling reporters Friday: "Pete's a very, very good man."

Hamas names the four hostages it plans to release on Saturday in latest Gaza ceasefire exchange

TELAVIV: The Hamas militant group on Friday published the names of four hostages it said it would release the following day as part of the ceasefire in the Gaza Strip. There was no immediate confirmation of the names from Israel. The hostages are to be freed on Saturday in exchange for the release of dozens of Palestinians imprisoned or detained by Israel.Relatives of hostages still being held by militants in Gaza had earlier Friday called on Israeli Prime Minister Benjamin Netanyahu to ensure that all remaining captives are freed, while also appealing to U.S. President Donald Trump to continue pressing for their release. As a fragile six-week ceasefire between Israel and Hamas entered its sixth day, Israelis were waiting anxiously for the names of the next four hostages who will be released from among the more than 90 still held in Gaza.In the Palestinian

enclave, civilians in the central and southern part of the Gaza Strip faced an agonizing wait before they can return to the remnants of their home in the battered north.Israel believes about a third, or possibly as many as half, of the more than 90 hostages still in Gaza have died. Hamas has not released definitive information on how many captives are still alive or the names of those who have died."Dear President Trump, first of all we want to say thank you for the happy moments we felt this week. But we want to tell you we still have 94 hostages, we need them all at home," said Ayelet Samerano, whose son Yonatan Samerano is among those still being held. "Please do not stop. Please continue to press and do everything so that all the 94 hostages will come home immediately."In the first phase of the ceasefire deal, 33 hostages are expected to be released gradually in return for hundreds of Palestinian prisoners held by Israel. The first three Israeli hostages were freed in exchange for 90 Palestinian prisoners on Sunday, the first day of the ceasefire that has halted the 15-month war that has devastated Gaza. Wide swathes of the territory have been destroyed, while more than 47,000 Palestinians have been killed, according to Gaza health authorities, who do not differentiate between combatants and civilians but say more than half are women and children.According to the deal, on Friday Hamas was to announce the names of the next four hostages to be released on Saturday, after which Israel will also release a list of which Palestinian prisoners will be freed. The hostages were among about 250 men, women and children captured by militants who burst across the border into Israel on Oct.

The US intends to leave the World Health Organization. What happens next

World The US intends to leave the World Health Organization. What happens next? Donald Trump's plan to withdraw the United States from the World Health Organization (WHO) has been met with dismay in the public health field. Some have called one of the US president's first executive orders "a grave error" and "absolutely bad news".

What does the WHO do? The WHO is a United Nations agency that aims to expand universal health coverage, coordinates responses to health emergencies such as pandemics, and has a broad focus on healthy lives. It does not have the power to enforce health policy, but influences policy worldwide, especially in low-income countries.

The World Health Organization plays an essential coordinating role in surveillance, response and policy for infectious and noninfectious diseases. In fact, infectious diseases have the most pressing need for global coordination. Unlike noncommunicable diseases, infections can spread rapidly from one country to another,

just as COVID spread to cause a pandemic. We have much to thank the WHO for, including the eradication of smallpox, a feat which could not have been achieved without global coordination and leadership. It has also played a leading role in control of polio and HIV.

Why does the US want to withdraw?

The reasons for withdrawing include: the mishandling of the COVID-19 pandemic ... and other global health crises, its failure to adopt urgently needed reforms, and its inability to demonstrate independence from the inappropriate political influence of WHO member states. The executive order also cites the disproportionately higher payments the US makes to the WHO compared to China. In 2024-25, the US contributed 22% of the organisation's mandatory funding from member states compared to about 15% for China. President Trump initiated withdrawal from the WHO over similar concerns in 2020. But this was reversed by President Biden in 2021. What happens

next?The withdrawal may take a year to come into effect, and may need approval by the US Congress. How this will play out is unclear, but it seems likely the WHO will lose US funding. The US withdrawal may also be the final nail in the coffin for the WHO Pandemic Agreement, which faltered in 2024 when member states could not agree on the final Trump's executive order states all negotiations around the pandemic agreement will cease. However, the order hints that the US will look at working with international partners to tackle global health. The US Centers for Disease and Control (CDC) already has such international partners and could feasibly do this. It already convenes a global network of training in outbreak response, which could provide a model. But to move in this direction needs finessing, as another objective of the new US government is to reduce or cease international aid. The WHO also convenes a range of expert committees and networks of reference laboratories. One among many

network of laboratories is for influenza, comprising more than 50 labs in 41 member states. This includes five "super labs", one of which is at the CDC. It's unclear what would happen to such networks, many of which have major US components.

With the threat of bird flu mutating to become a human pandemic these global networks are critical for surveillance of pandemic threats.WHO expert committees also drive global health policy on a range of issues. It is possible for the WHO to accredit labs in non-member countries, or for experts from non-member countries to be on WHO expert committees. But how this will unfold, especially for US governmentfunded labs or experts who are US government employees, is unclear.

Another potential impact of a US withdrawal is the opportunity for other powerful member nations to become more influential once the US leaves. This may lead to restrictions on US experts sitting on WHO committees or working with the organisation in other ways.

'Convert Red Fort into medical museum

CHENNAI. The 1965 batch of Madras Medical College alumni has requested that the state government convert the 128-yearold red-brick heritage structure known as 'Red Fort' into a medical museum. Built in 1897, the structure was later classified as a Grade I heritage building by the Justice E Padmanabhan Committee on Heritage Structures. The alumni said that though the government earlier said the structure would be converted into a museum once restoration work was over, it has not been done even eight years since completion of work.Dr J Balasubramanian, a member of MMC Heritage Committee and an alumnus, said the red-brick structure constructed by the British in Indo-Saracenic style housed the Department of Anatomy for several decades.

The doctors said that MMC is the second oldest college in the country, the first being the Kolkata Medical College. The heritage committee members have preserved some old medical equipment and photographs, including 120-year-old group photos of students with British doctors.

The alumni said these can be displayed at the museum along with other rare specimens.Dr N A Jayavelan, another member of committee, said Rs 1.97 crore was allotted in December 2017 by the then state government for the heritage structure's renovation. The work was completed in 2018. The 1965 batch alumni said the museum can be thrown open to the public and students so that they can learn about the evolution of modern medicine in the country and the history of the institution.

Metro rail signs MoU with EVZIP for last-mile connectivity in Hvderabad

HYDERABAD. In the next five 5-10 years, Indian cities will be sitting on a powder keg due to rapid urbanisation and a huge increase in the number of vehicles. The only solution is to have a rail-based mass rapid system with multi-modal integration, and first and last-mile connectivity, Hyderabad Metro Rail Limited (HMRL) Managing Director NVS Reddy said.

On Friday, he participated in the signing of an MoU between L&T Metro Rail (Hyderabad) Limited (L&TMRHL) and EVZIP."Chief Minister A Revanth Reddy has a grand vision for Hyderabad and wants to make the city a one trillion dollar economy. Presently, the wealth of Hyderabad is about 250 billion dollars with three existing cities, Hyderabad, Secunderabad and Cyberabad.

The CM is planning to build a fourth city in the south of the Airport and call it Future City which will house top-notch transport facilities to reduce the use of private vehicles," he explained. He further said the metro rail is being expanded in all directions and the plan is to expand to the stretch of 200 km from the initial length of 69 km.

Karnataka to formulate bill to rein in microfinance firms

BENGALURU.The state government is planning to formulate 'Karnataka Microfinance Institutions (Regulation of Money Lending) Bill' to rein in microfinance companies. This is in view of the increasing number of complaints accusing such companies of harassing those unable to clear loans taken from them.

Disclosing this to reporters here on Friday after a cabinet meeting, Law and Parliamentary Affairs Minister HK Patil said the Reserve Bank of India (RBI) and other central finance agencies are not able to control microfinance companies."We are tabling the Karnataka Microfinance Institutions (Regulation of Money Lending) Bill at a meeting convened by Chief Minister



Siddaramaiah on Saturday," Patil said. The meeting will discuss measures to be taken to stop such lending companies from harassing borrowers, especially farmers, in rural areas, he said. Asked if finance companies can't be controlled under existing laws, Patil said they are not strong. Police have limited powers to handle such cases. "We have to plug the loopholes," he added. He said the state government has taken the issue seriously and a special law is expected soon to control such lending companies.

New land acquisition model puts Kochi Seaport-Airport Road development on track

KOCHI. The second phase development of the Seaport-Airport Road - involving a 14.3km stretch from the HMT Road in Kalamassery to the Kochi airport in Nedumbassery – had been in the cold storage for over two decades, before receiving a new lease of life last year.

What has paved the way for unlocking the land acquisition deadlock, especially that of the land belonging to HMT, is a new model put forward by the state government, under which the government would deposit the cost of the disputed land (Rs 37.90 crore) with the court to proceed with land acquisition. The court had permitted the government to remit the cost in a nationalised bank. The much-touted project - a

25.7km road from Irumpanam near Tripunithura to Nedumbassery – is expected to provide easier access to the airport and is being implemented in two phases. The implementing agency, the Roads and Bridges Development Corporation of Kerala (RBDCK), had completed the first phase - an 11.3km stretch from Irumpanam to Kalamassery - in 2003. However, the work on the second phase got delayed. The government had provided land to HMT at Kalamassery for free to facilitate its industrial activities. But HMT demanded compensation when the state wanted it back for the road project. The government took a stand that the land was given for a purpose and can be taken back if it was not used for that. HMT challenged the same in the court. While a single



bench ruled in favour of HMT, the government moved the division bench, which pronounced a verdict in the latter's favour.HMT then went to Supreme Court, which stayed the land acquisition proceedings. "To take the project ahead, the state government filed an affidavit before the apex court stating that it will deposit the disputed amount (land value demanded by HMT) before the court first and then proceed with land acquisition. Later, the amount can be given to HMT or returned to the state as per the final verdict. The court accepted the same and directed the government to deposit the amount in a nationalised bank in the name of High Court Registrar. We've handed over the amount to the tahsildar who now has to deposit the same in the Registrar's name. After that, we can acquire the said land," a senior RBDCK official told

TNIE.An amount of Rs 37,90,96,662 needs to be deposited. The state recently allocated Rs 19.39 crore for the purpose, as a sum of 18.75 crore was already there in the tahsildar's account. The second phase includes three sections - HMT Road-NAD Junction to Mahilalayam Junction, Mahilalayam Junction to Chowara, and Chowara to Airport Road.In the 2.7km stretch from

Kalamassery to NAD, construction has been completed on the land available (1.5km) while the land belonging to NAD is yet to be acquired."The NAD land is ready for acquisition. We've handed over the required amount ('23.06 crore) to the tahsildar, who will now issue award enquiry notes to landowners. As they produce the documents, the land will be acquired by handing over the compensation," the official said.

The authorities hope to complete the acquisition of HMT land on a war-footing."The NAD-Mahilalayam stretch has over 400 landowners. It will take at least six months to complete the process, but we can start acquiring the entire HMT land after depositing the amount required as there is only a single landholder," the official

Rachakonda Police Commissioner G Sudheer Babu on Friday said that they would take help from experts from other parts of the country to crack the gruesome murder of a woman at Meerpet allegedly by her husband.Ex-serviceman Gurumurthy, 39, allegedly killed his wife Putta Venkatamadhavi chopped her body into pieces and boiled the parts in a pressure cooker before dumping the remains at an undisclosed location. The police are looking for police officials with expertise in solving similar cases across the country to use their experience in nailing the accused.

A source revealed that the ex-serviceman carried out the macabre operation of cutting the victim's body into pieces and boiling it between 10.30 am and 6.30 pm on January 15. "Later, he supposedly stuffed the remains in a bag and took them away somewhere for disposal without anybody

noticing him," the source added. Meanwhile, a police official who is monitoring the case said that whatever Gurumurthy claimed appeared false. "Because even a person with past experience in carrying out such gruesome murders cannot do what the ex-serviceman claims to have done," the official added. Even investigators are baffled at the dexterity with which the exserviceman carried out the whole operation without leaving much evidence. "It is astonishing that he left no stains on any object in his house after murdering her. It appeared that he washed away all the blood stains only with water," the source mentioned.

The major challenge before the officials is that they are yet to find the remains of the body of the woman though Gurumurthy has already been picked up.Addressing a press conference, the Rachakonda Commissioner said the issue is



still being treated as a "missing case". "She (the victim) was not seen for some time. So a case has been registered. Since she has been missing and later on this kind of information came to us, we are working on that. So far nobody has been found. So there is a different way of investigating the

As of now, it is a missing case. We are investigating the case and we are involving experts not only from our state but also other parts of the country," he said. While some horrified tenants in the building where the alleged murder took place at New Venkateshwara Colony at Jillelaguda, vacated others have moved out temporarily.

As per the FIR registered on January 18, Madhavi had left home after a quarrel with Gurumurthy. The source said that the police were collecting evidence by using infrared (IR) light and other modern technology to build a

watertight case. A forensic team reportedly found hair and blood samples from the bathroom. "The officials found blood stains on the bathroom flush," the source said.

Why India's good economics is corrupted by bad politics

Three current events in Delhi reveal widening cracks in the 'liberal' ideology that has ruled the country's economics since the 1991 economic reforms: the upcoming elections in Delhi; the national Budget; and the Central government conceding, reluctantly again, that it must negotiate with farmers objecting to the imposition of 'free market' agriculture reforms and demanding that the government ensure they get fair prices for their produce. The strategy of all political parties competing in the Delhi elections is to promise more 'freebies' to citizens. This may be good politics, but it is bad economics, lament economists advising the Finance Minister, who must balance the Budget without increasing taxes on corporations and the rich.

The government finds it hard to agree with the famers because their demands run counter to the ideology of liberalisation of the economy, which is minimum government and maximum governance by the 'invisible hand' of capitalist markets.

The government's overall strategy to make India a 'developed country' by 2047 is to increase the GDP more rapidly, with the expectation that the top line growth of wealth of the rich will trickle down to the bottom line of incomes for people in the lower half of the economic pyramid.

Before pressing harder on the liberal reforms' accelerator to boost the GDP, the policymakers must pause and objectively examine how well the Indian economy has done since the 1991 economic reforms. Economists on the liberal right side defend their theories by comparing the performance of the pre-1991 'socialist' economy with the post-1991 'liberated' economy. By this yardstick, liberal economists of both the UPA and the NDA can agree that the economy has been on the right track since 1991. They disagree only about whether employment and incomes increased faster whenever their side was in power, a contest they are trying to settle with dubious statistics.A scientific way to settle the ideological debate about the best economic strategy for India is by a comparison of how much growth of the GDP has increased incomes of the poorest people in other developing economies since the 1990s.Compare India and China, two countries with over a billion citizens, both of whom were very poor until the 1980s, both opening their economies around the same time to increase foreign trade and private investments. And Vietnam, which was even poorer in the 1980s, and has now emerged as another Asian tiger, competing with India to draw away investments from China, where labour costs have increased with its remarkable economic success.

The box above illustrates the comparative growth in GDP per capita of China, Vietnam and India from 1989 to 2023. It shows that Vietnam and China experienced significantly higher increases than India during this period. Why have China and Vietnam's economies done six times better than India's in lifting incomes at the bottom over the same period? India's economy reformers should examine this scientifically and non-ideologically.

For one, China and Vietnam did not give up the communist-socialist moorings of their economic policies after the collapse of the communist Soviet Union in 1991, when the Washington Consensus around liberated financial capitalism swept the world. Russia was persuaded by US economists to switch from communism to capitalism with a 'big bang', with disastrous consequences. Crony capitalists gouged the country's wealth, became extremely wealthy, bought mansions in London and yachts in the Mediterranean and corrupted Russian politics. China and Vietnam joined the global economic system on their own terms in the 1990s.Deng Xiaoping adopted 'Socialism with Chinese Characteristics', incorporating features of capitalism into central planning to enhance the welfare of the people. US economists complain China cheated when it was admitted into global markets because China did not give up socialism and state planning. It protected its public sector and nurtured private sector giants, now being sanctioned by the US — the champion of free markets — which is destroying multi-lateral trade and financial institutions ..

Our Constitution an ode to consensus

Its framers pursued the exemplary path of respectful listening and accommodating others

During times of peace, it is relatively easy to be democratic; the test arises when we are faced with social and political turmoil. By the end of 1948, rocked by the Partition and the ensuing communal violence, anxieties about social fragmentation and separatism were tangible within the Constituent Assembly and outside it. In this demanding situation, Sardar Vallabhbhai Patel set a new benchmark for what a democracy is and should aspire to be. As the chairman of the special sub-

committee set up to re-examine political safeguards for religious minorities, he said: "I was anxious that the representatives of the minorities on the Committee should have adequate time both to gauge public opinion among their people, and to reflect fully on the amendments proposed, so that a change, if affected, would be one sought voluntarily by the minorities themselves", and "not imposed on them by the majority community". Patel's words echoed the framers' commitment to democracy. A high-powered committee, with Jawaharlal Nehru, Rajendra Prasad, KM Munshi and BR Ambedkar as its members, had recommended the withdrawal of separate representation for religious minorities. The Sikh representatives were reluctant to accept this recommendation and wanted more time to consult and reflect on the proposed changes.

The political stature of the members of the subcommittee should itself have elicited compliance. But this did not happen. There was political urgency to settle the issue. Yet, Patel, along with the committee members, did not force a consensus. They heard and respected the wishes of even this small group of representatives. To give Sikhs more time, he adjourned the meeting. The majority of the representatives, including members of other minorities, had accepted the recommendations of the special sub-committee. Even most of the Muslim representatives agreed that separate representation for religious minorities be abandoned. It was the need of the hour. Under these conditions, the subcommittee could easily have ignored a few Sikh voices. After all, numbers were on their side. They could also have appealed to national interest. But this did not happen. Despite the extenuating circumstances and the weight of the numerical majority with them, Patel offered a political reasoning that defined what it means to be

democratic. He did not want a major decision to be imposed upon a community. This was a spectacular lesson in what democracy entails. Today, democracy is associated with elections and rule by elected representatives. For analysts, leaders and students of political science, elections are the peg around which democracies are anchored. A few other elements separation of powers, rule of law, respect for human rights — are thrown in for good measure, but it is winning or losing elections that matters the most.



Probably because we believe that winners decide the course of things to come: they determine the policies that will be formulated. The future rests in their hands. Against this myopic vision of what democracy is, Patel and the leadership of the subcommittee presented a grand alternative. They did not simply espouse an ideal of deliberation, they stood by it and acted upon it; showed us that democracy requires the willingness to trust and walk the mile to meet those who disagree. The moral power of this gesture compelled the other side (the dissenting voices) also to take the committee's reasoning seriously, and they too agreed to accept the recommendations. Eventually, the subcommittee on minorities voluntarily accepted the decision to withdraw separate representation for religious minorities.

The members of the Constituent Assembly functioned with exemplary patience in a situation of extreme political urgency. They listened to each other, to similar, and at times, the same arguments, being presented again and again, in a sub-committee, then in the larger body, when specific provisions were being discussed, and again when the entire draft of the Constitution was discussed. In doing so, they taught the world what it means to live in a democracy and live by the idea of democracy.

The issue before the special sub-committee was political safeguards for minorities. Hence, in his statement, Patel alluded to religious minorities. However, his reasoning addressed all of us: future

generations of leaders, assemblies of representatives and each of us in our individual capacity and places of work and collective existence. Differences and disagreements are unavoidable, and if we stand committed to a democratic way of life, we need to make space for them, listen to them and work to build a consensus. The Constituent Assembly left us with this thinking at a time when theories of deliberative democracy were not on the scene and ideas of a well-functioning democracy few and far between. America was seen at best as a polyarchy, and Carl Schmitt's advice that real politics requires a distinction between friends and foes resounded in Europe. In this environment, the political leaders who shaped our republic and framed the Constitution stood alone and stood tall. They may have toured various countries and read their constitutions and

laws closely, but they shaped the process of deliberation and decision-making in accordance with their convictions about the value of democracy. Individual clauses and provisions were the product of negotiations and sometimes even compromise. In that too, they taught us that democracy requires this willingness to move away from our initial position and find a way to take everyone along. Even though there have been several amendments to the Constitution, it still remains a precious document, reminding us that the process matters and it gives substance to the idea of democracy. As we celebrate 75 years of our republic, it's for each of us to see if we have lived up to the standards the framers of our Constitution set for us and our democracy. They pursued the exemplary path of respectful listening and accommodating others. What better way can there be to remember them and commemorate the momentous event of giving India her Constitution than to follow their

Sustaining hope

Rekindle the Beti Bachao Beti Padhao spark

WHEN the Beti Bachao Beti Padhao (BBBP) programme launched in Haryana in 2015, it was a beacon of hope for states like Punjab and Haryana, long plagued by gender imbalances. A decade later, the initiative boasts successes, but the enthusiasm of its early years seems to have waned. Harvana's sex ratio at birth saw a commendable rise from 871 girls per 1,000 boys in 2015 to 910 in 2024. Yet, this progress has been uneven, with districts like Gurugram a similar story, especially in rural areas where early marriages and school dropouts continue to derail girls' futures. While institutional deliveries have increased, a deeper societal change remains elusive. The scheme's first few years thrived on community-driven efforts and robust campaigns. However, as

enthusiasm dimmed, so did its transformative potential. A glaring issue was the heavy allocation — 78 per cent of



funds between 2016 and 2019 - towards media advocacy instead of long-term investments in education and healthcare. Slogans like "Beti Khilao" following Haryana's success in sports sparked hope, but the lack of sustained support for girls' higher education and careers has left aspirations unfulfilled.What's needed now is a revival of that early spark. Punjab and Haryana must look beyond awareness campaigns and tackle patriarchal mindsets head on. Gender-sensitisation programmes in schools, involving men as allies in the fight for equality, and providing vocational training for girls can breathe new life into the programme. Accountability through better fund utilisation and district-level monitoring is crucial. BBBP began as a movement of hope. To keep that hope alive, it must

evolve into a relentless push against gender inequity one that uplifts not just numbers but also lives.

Trump hits WHO where it hurts

America's withdrawal has far-reaching implications for global health security


Among the executive orders signed by Donald Trump soon after taking over as the US President is the one about America pulling out of the World Health Organisation (WHO). The order says that the decision follows the WHO's "mishandling of the Covid-19 pandemic that arose out of Wuhan, China, and other global health crises, its failure to adopt urgently needed reforms, and its inability to demonstrate independence from the inappropriate political influence of WHO member states". The order adds that America has been supporting the WHO "far out of proportion" compared to countries like China — which has a population of 1.4 billion but pays a tiny sum. Trump's decision has farreaching implications not just for America but for global health security. Trump's disdain for the WHO was obvious during his first term when the world reeled under the impact of the Covid pandemic. He squarely blamed the health agency for its so-called mishandling of the situation. Trump suspended America's contributions to the agency as it battled the worst global health emergency in a century. He also initiated the process for America's eventual withdrawal from the agency, but before it could happen, he was voted out. His successor, Joe Biden, reversed the order and restored America's financial support to the WHO. The executive order issued now means America will cease its financial support to the agency in a year. At present, America contributes about 18 per cent of the WHO's overall funding. The agency's budget for two years (2024 and 2025) is \$6.8 billion. The WHO was formed as a specialised UN agency after World War II to address important matters of health and diseases. It was mandated to act as a technical agency with an international network of scientists, medical experts and health policymakers. One of its key functions was to launch

coordinated action on new infections emerging through surveillance and sharing of information. The WHO provides technical assistance to poor countries 3 per cent of the agency's funding. In recent years, and helps build their capacity to tackle health challenges. Over the decades, the agency's work has led to the eradication and control of diseases such as smallpox, yaws, yellow fever, leprosy and polio. The global action on HIV/AIDS through a new agency, UNAIDS, too was noteworthy. Now, its focus is on ending tuberculosis. The agency's work has come into sharp focus since 2000 with the emergence of new infections and re-emergence of old ones SARS, bird flu, MERS, Ebola, Mpox and Covid-19. In a globalised, hyper-connected and interdependent world, health security is intertwined with the economy. The decision to withdraw from WHO is bad for the US as well as the global community. It will deny America access to critical data on disease outbreaks and health emergencies that the WHO shares with all member states. Several US pharmaceutical companies and laboratories depend on the 'WHO Pandemic Influenza Preparedness Framework' for information on new influenza virus samples for research and development. The decision also entails America's withdrawal from ongoing negotiations for the global pandemic treaty and other mechanisms like the International Health Regulations. Dozens of American experts working with the WHO will also be recalled and reassigned. Two American institutions — the Centre for Disease Control and the National Institutes of Health engage with the WHO on critical issues. The ending of such partnerships will be mutually harmful.

For the WHO, the loss of its biggest donor comes as a severe blow at a time when national contributions from governments are already dwindling. After

America, the next largest national donor is Germany, contributing around

contributions from some non-state donors to the WHO have gone up substantially. The Bill and Melinda Gates Foundation tops this list, followed by the European Commission and the World Bank. The Gates Foundation supports work in areas like polio eradication and vaccines. If national funding to the WHO does not go up after America stops its financial



help, the WHO's dependence on donors like Gates might rise. This is not such a good thing for the independent functioning of the UN agency. Critics have pointed out that private funding comes with strings attached, which, in turn, influences the global health agenda. The call for reforming the functioning of the WHO to make it far more efficient, transparent and responsive is valid. In the wake of the pandemic, India also raised the issue at multilateral for alike the G20 and BRICS summits in 2020. It suggested that

the WHO should devise objective criteria and parameters for declaring a public health emergency like Covid-19. Other countries have made similar demands. Being a UN body, the WHO is open to criticism and there are platforms to pursue the idea of reforms, but disbanding it or starving it of funds is not the solution. Responding to the demand for reform, the WHO has said that it has implemented the largest set of reforms in its history, covering "accountability, cost-effectiveness and impact in countries". Besides

disrupting global health security, Trump's reckless move — together with his decision to withdraw from the Paris climate change agreement and appoint a vaccine sceptic as the Health Secretary — severs public policies from evidence-based science and erodes the influence of science. Like the WHO, climate change treaties have been a favourite punching bag for Trump.

His support to the fossil fuel industry is bound to exacerbate climate change and result in an adverse impact on public health as well as livelihoods, among other things. His decisions on the WHO and climate change show

that Trump is questioning the value of evidence and science while undermining multilateralism. These are not just internal policy matters of America but can have global implications, as already witnessed in the last round of climate talks where industrialised countries used Trump's re-election to stall further climate action. Health security and climate change are interlinked, and if the world is going to scale down its response to both, it will be a disaster for the health of the planet and humankind.



New Delhi. An indigenously-developed system to identify and block international spoofed calls that display Indian mobile numbers has significantly brought down such calls to about 4 lakh per day, the government has informed.

Further, the government asked Indian Telcos to initiate drive against foreign carriers or aggregators who are handing over spoofed international calls, and they have blocked more than 20 such carriers to date.

The Department of Telecommunications

(DoT) recently launched an indigenouslydeveloped International Incoming Spoofed Calls Prevention System, along with all telecom service providers (TSPs). The tool proved to be a formidable barrier that blocked 90% of all the incoming international calls which were identified as spoofed calls approximately 1.35 crore, in just 24 hours, indicating that the system's success in tackling the issue of cyber-crimes using spoofed calls from abroad.

Fraudsters were earlier using international



spoofed calls that displayed Indian mobile numbers (+91-xxxxx) to deceive Indian citizens and carrying out cyber-crimes and financial frauds. Though these calls appear to originate from within India, they are actually made from abroad through manipulation of the Calling Line Identity (CLI), commonly referred to as phone number.

With the successful implementation of the system, scammers abroad changed their modus operandi and now they have started spoofing using international numbers. To counter this, DoT has asked telecom service providers to display "International Calls" on all calls coming from outside India.

This helps the citizen to understand that since the incoming calls is an "International Call", it cannot be from organisations like DoT, TRAI, police, RBI, customs, UIDAI etc.One of the major service providers has already implemented this in its network and others are in process of doing so, according to Ministry of Communications. In order to further tackle the menace of international spoofed calls from reaching Indian citizens, DoT has asked telecom service providers

(TSPs) to block traffic from such international carriers, which are repeatedly sending spoofed CLI call traffic to India.Providers like Airtel and BSNL have blocked more than 20 such carriers/aggregators who were handing over spoofed international calls."The recently launched Sanchar Saathi App has placed the convenience of reporting fraudulent calls at the fingertips of the citizens. It immensely enhances the ease of reporting any suspected fraud communications by allowing citizens to report such incidents directly from their mobile phone call logs," said the DoT.

India says keeping an eye after Pakistan sends ISI agents to Bangladesh

New Delhi. Pakistan sending its top army officials and spies to Bangladesh have put New Delhi on alert. India on Friday said that it is closely monitoring the recent developments and "will take appropriate steps" when it comes to national security."We keep an eye on all activities around the country and in the region, as well as all activities affecting national security, and the government will take appropriate steps," External Affairs Ministry Spokesperson Randhir Jaiswal said at a weekly media briefing.

These remarks come right after a high-profile delegation from Pakistan's Inter-Services Intelligence (ISI), led by Major General Shahid Amir Afsar, concluded its four-day visit to Bangladesh on Friday. The visit follows the recent trip made by top Bangladeshi military officials to Pakistan where they had met with the three service



chiefs. Since the turmoil following former Prime Minister Sheikh Hasina's ouster, Muhammad Yunus-led Bangladesh has grown comfortably closer to Pakistan, raising a red flag in India.Bangladesh's decision to grant a visa to any Pakistani citizen without security clearance has raised eyebrows, with experts warning of an increase in ISI and Jamaat activities in India's backyard."There have been recent reports of eased travel restrictions for Pakistan ISI and Jamaat elements to Dhaka," a security analyst had earlier told .However, India has been ready to put its differences aside and work towards a "democratic, progressive and inclusive" Bangladesh."We support a democratic, progressive and inclusive Bangladesh. We want to strengthen our ties so that the people of India and Bangladesh can prosper," Jaiswal further said at the media briefing.On Bangladesh raising objection to India's border fencing along the border, Jaiswal said that it is aimed at stopping the illegal movement of humans

Maintenance of indoor plants

- Most indoor plants do best in partial shade, which works out well since indoor areas don't usually get direct sunlight. Keep this in mind before you decide to put a potted plant in a place where it will get hours of direct sunlight; you may end up exposing it for too long.

- One must select the right size of the pots. For indoor plants, go for pots either 4 inches or 6 inches in size. Allow enough space for the roots to grow. Make sure the pots are light and strong, so as to hold the plant for a long time.

- Place plastic saucers under the pots to avoid soil and water spillage.

- Ficus Elastica, Areca Palm, a variety of philodendron or dracaena are best suited for indoors. These plants can do without sunlight for 7-10 days with minimum requirement of

Water the plants carefully

"Water the plants as and when required. Many first-time gardeners or potted plant owners water plants more than necessary, believing that the more water the plant gets, the better they grow. While it holds true for certain plants, it can kill others," suggests Dr SL Rahman, consultant at Agri-Horticultural Society of India.

Kitchen garden in pots

If you thought a kitchen garden only works n bigger houses, you are highly mistaken. Get creative. Don't throw away buckets, containers etc. Use them along with hanging baskets for smaller plants. You can even grow vegetables in the little balcony of your apartment.

- Do not use soil from the garden. It can be filled with weed seeds, insects, and fungal diseases. It is better and easier to buy readymade potting soil (a mixture comprising clay, bone dust, vermicompost, neem cake and mustard cake) from the local nursery. You can also go for coco peat, which are made from coconut husks and is a medium for growing plants.

Get various seedlings from the nursery. Remove the plants from its nursery container. Never pull a plant out by its stem. If it is stuck, tap the sides of the pot to loosen it. Gently tease the ends of the roots free before planting it in the bigger pot.

- For the proper growth of vegetables in your balcony, the pot size should be between 8-10

- Make one or more drain holes in the pot. Place small chips right over them so that they don't clog and excess water can pass through. - Do not pile soil on top of the plant; make

sure the stem is completely above the surface. Leave about an inch between the soil surface and the rim of the pot.

- All vegetable plants need constant moisture. Some plants need water on a daily basis.

Veggies for beginners

Coriander: How many times did you get sad looking at half-dried coriander leaves (dhania) in the market? Coriander is something that is used in everyday cuisine to spice it up. And that makes it a must-grow for every kitchen garden. The seed is technically a fruit containing two seeds in it. When split, it increases the germination rate since it scarifies the seed. Take a tray with potting mix filled up to half inch from the top. Then make rows by drawing a line with your index finger or a stick. Simply sow the split coriander seeds in each row. Once done, water them and wait! It starts germinating between 5-7 days.

Potatoes: Plant potatoes during late February and March. When the green shoots begin to appear above the soil, cover them with more compost. You only need remember to water them. After 10 to 20 weeks, dig around in the soil to collect your home-grown potatoes!

Peas: It's a trouble-free crop that enjoys cooler weather. Sow them in the pots between March and June. Erect some sticks or posts for support. You'll be amazed at how good fresh peas taste and the more that you pick them, the more they produce!

Tomato: With a little water and a lot of sun, tomato plants are quick to grow. Roots of a tomato plant grow deeper into the soil. So, choose a bush variety like 'Cherry Cascade' that can be planted in hanging baskets and window boxes. Just cut a tomato into four pieces and bury it about 1/2 an inch into the soil. Wait for 3-4 weeks for the seeds to start sprouting.

Cucumber: These grow best when the soil is warm. Cucumber plants tend to sprawl all over. Provide your plants with ample space to stretch their roots. Again, since these are climbers, you must get a proper support. Go for smaller varieties if there's less space.

Green chilli: These are good companion plants for tomatoes and coriander. Just take two or three dried red chillies. Slit them open and sprinkle the seeds in a pot filled with soil and a little manure, available in the nurseries. Ensure the seeds don't go too deep. Cover it with little soil and water it. It takes about a week or so for the seeds to sprout. If the pot is not large enough, you can replant the sprouts into a bigger pot. You may need to tie up the chili plant to a pole to let it grow and avoid bending.

Winter blossom

- According to Nirupom Sen, secretary-cum-CEO, Agri-Horticultural Society of India, if you have a garden without flowers, you have got to do something about it. So, before deciding where to plant your flowers, you should know when the best time to grow flowers is. "During winter, the best flowers to grow in Indian climate are Petunia, Cockscomb, Antirrhinum, Cineraria, Zinnia, Calendula, Chrysanthemum, Marigold and Dahlia," he says.

- Flower plants need up to 5 inches deep soil. So take an earthen pot of 6-8 inches in height. Dig a hole in the potted soil. Bury the seed about 2 inches deep. Flowers do not need to be smothered with the soil. Do not bury them too deep. After 6 weeks, you will see the seeds sprout into saplings.

- The after-care is very essential. Sprinkle water as and when required.

Terrace talk

- As the main element of a terrace garden comprises watering of plants and keeping the soil wet, it is important that the best quality water-proofing material is selected.

One has to bear in mind that the area selected to build a terrace garden should have a slight slope, so that it can drain water easily and has the capacity to bear the load.

- It is always advisable to pick plants which don't grow big in size.

- You can install a separate tank to store water or have a mechanical watering arrangement. But most often, people love to water their garden themselves and see the plants grow.

Preparing the potting mixture & sowing seeds 'These days, one can easily get exotic and hybrid seeds of capsicum, chilly, cabbage, broccoli, coriander, tomatoes, brinjal, basil and parsley. The potting mixture should have 20% of leaf mould, 40% sand and 40% soil. You can add mustard cake and cow dung cake as fertilizers. After the seeds are sown, one should cover the soil with a layer of fine sand. Sand makes the soil porous and helps the roots grow.

Keeping insects away 'Use neem-based organic pesticides. Or you can take 100 gram of chillies, 4-5 cloves of garlic and a few bulbs of turmeric, paste it and mix it in 1 litre of water. Pour the liquid in a container and simmer it till it is reduced to half. Refrigerate it and use it

whenever necessary. All you need to do is take out about 20 ml or the concentrated paste, mix it in a litre of water and sprinkle it on the plants. However, if insects or diseases do strike your plants, go for the safest botanical or microbial pesticides'

Government E-Marketplace Surpasses Rs 4 Lakh Cr GMV Within 10 Months This Fiscal

New Delhi. Setting a new benchmark, the government e-Marketplace (GeM) has surpassed last years' gross merchandise value (GMV) of Rs 4 lakh crore within 10 months this fiscal (FY25).

The GeM clocked a GMV of Rs 4.09 lakh crore as on January 23, which marks a growth of nearly 50 per cent over the corresponding period last fiscal, according to Ministry of Commerce and Industry.In terms of segment-wise GMV, the services segment accounted for Rs 2.54 lakh crore (62 per cent of the total GMV), whereas product segment accounted for Rs 1.55 lakh crore (38 per cent of the total GMV). The growth of the services

Start-ups expect simplified tax regime

Experts call for strengthening SIDBI's Fund of Funds for Startups

BENGALURU. With the abolition of angel tax in the previous budget, the country's start-up ecosystem saw a boost in early-stage investments, and now in the upcoming budget, they expect tax reforms, simplification of ESOP (employee stock option plans) taxation and extended tax holidays.

India, which has the third largest start-up ecosystem in the world, boasts over 1.59 lakh start-ups that are recognised by the Department for Promotion of Industry and Internal Trade (DPIIT) as of January 15, 2025.

Ashwani Singh, MD of 35 North Ventures, an early-stage AIF focused on empowering start-ups, said that the current taxation structure, taxing ESOPs at time of vesting and the high tax



burdens on capital gains for angel investors, hinder progress in the employee retention and funding landscape. He anticipates tax reforms in the upcoming budget to tackle these hurdles - simplifying ESOP taxation, streamlining capital gains tax structure across asset classes or introducing tax exemptions for angel investors and aligning them with global standards to capital into the start-up ecosystem.

Apoorva Ranjan Sharma, co-founder & MD of Venture Catalysts, said, a simplified tax regime for start-ups could be of great help, mainly for enterprises in Tier 2 and 3 cities. "A reduction in compliance burdens and extended tax holidays could provide the necessary impetus for these start-ups to scale rapidly," he said.

Fund of Funds for Startups (FFS). "The FFS program has been instrumental in catalysing start-up growth, but further enhancements are needed. Renewing SIDBI's allocation with an additional Rs 10,000 crore will ensure continued support for startups," said Anirudh A Damani, Managing Partner, Artha Venture

He said that beyond FFS, the country requires a sovereign-backed fund of funds anchored by SIDBI, which allows contributions from banks, insurance companies, and global sovereign wealth funds. "A \$5 billion to \$10 billion anchor fund, with SIDBI contributing 20%, could unlock significant start-up capital, fostering long-term partnerships and global investor confidence," he added. The current DPIT start-up classification limits eligibility to companies under 10 years of age or with revenue below Rs 100 crore. Experts call for including start-ups registered up to 20 years old and revising the revenue cap.

SC stays order in Tiger Global treaty abuse case

NEW DELHI: The Supreme Court on Friday stayed a Delhi High Court order granting Tiger Global fund relief in a treaty 'abuse' case. The Supreme Court in its order said that the issue has pan-India implication and needs thorough attention.In August 2024, the Delhi High Court delivered a judgment in favour of Tiger Global International III Holdings, a Mauritius-based entity, concerning the applicability of the India-Mauritius Double Taxation Avoidance Agreement (DTAA) to capital gains arising from sale of shares. This ruling had overturned an earlier decision by the Authority for Advance Rulings (AAR), which had denied treaty benefits to Tiger Global.

Southern states fall behind in fiscal health; Andhra, Kerala at the bottom

NEW DELHI.Most South Indian states have been performing poorly in managing their finances, Niti Aayog's Financial Health Index 2025 showed. Three states - Andhra Pradesh, Kerala and Tamil Nadu - in particular have been performing the worst among southern states as they scored below 30 out of 100 in the Index.

These states were not among top 10 states in terms of the fiscal performance. Andhra Pradesh and Kerala were among worst performers along with Punjab and West Bengal - each of them, according to Niti Aayog, is facing major fiscal challenges. Kerala and Punjab struggle with low quality of expenditure and debt sustainability, while Andhra Pradesh has high Fiscal deficits, noted Niti Aayog. Tamil Nadu has a better score when it comes to state own revenue/total expenditure, but it has fared poorly on quality of expenditure and fiscal deficit.In case of Tamil Nadu during 2022-23, committed expenditure as percentage of the revenue expenditure was 52%. 'The upward trend on Committed Expenditure since 2018-19, which grew at an annual rate of 9.9%, may have left the Government with lesser flexibility for developmental spending," noted



the Aayog. Subsidies form a high proportion of non-committed expenditure for the state.

Karnataka rank dropped from 3 in 2014-15 to 2021-22 to 10 in 2022-23, primarily due to subdued performance under Quality of Expenditure and Debt Sustainability. Among the Southern states, Telangana was the best among the Southern states due to better revenue mobilization and fiscal prudence. The Fiscal Health Index (FHI) evaluates states on expenditure quality, revenue mobilisation, fiscal prudence, debt index and debt sustainability. The composite fiscal health index for 18 major states has been calculated using the data from the Comptroller and Auditor General of India (CAG). The period of the analysis is Financial Year 2022-23.Odisha excels in the fiscal health Index with the highest overall index score of 67.8. Chhattisgarh and Goa follow, with scores of 55.2 and 53.6, respectively.

ESIC Adds 16.07 Lakh Employees In Nov, 47 Per Cent Are Youngsters

Corporation (ESIC) reveals that 16.07 November last year out of which over 47 per cent are young employees up to the age group of 25 years, which is a good indicator of new jobs being created in the economy. Adani Group denies cancellation of Sri Lanka wind power project

The Sri Lankan government has decided to review the 484 MW project amid local opposition, environmental concerns, and a bribery probe against the group.

NEW DELHI. The Adani group has refuted reports that the Sri Lankan government has cancelled the 484 MW wind power projects in Mannar and Pooneryn.As per local media reports, Sri Lanka's Cabinet, led by President AnuraKumara Dissanayake, has decided to revoke the power purchase agreement with the Group. Report citing officials from Sri Lanka's Ministry of Energy said the government has cancelled the deal and established a panel to review the entire project.

An Adani Group spokesperson said the project has not been cancelled and the government's decision to review the



process is part of a"standard review process. It said the company remains committed toinvesting \$1 billion in Sri Lanka's green energy sector, driving renewable energy and economic growth. The decision to cancel the pact comes amid ongoing bribery probe by the US authorities against Adani Group. On 19 November 2024, the group faced charges in the US for allegedly making

bribe payments and concealing transactions from US investors. The group has dismissed these allegations as baseless. The government, under then President RanilWickremesinghe, in May 2024 signed a pact with the Group to procure electricity at a rate of \$0.0826 per kWh.

The Group had planned to builda 484 MW wind power plant in coastal areas of

Mannar and Pooneryn. Local reports say the project faced major opposition in Sri Lanka due to concerns over pricing. The rate set by the Group was much higher than what local bidders had offered, fuelling criticism of the deal. Environmental groups, including Wildlife and NatureProtection Society and Environmental Foundation, voiced strong objections, citing concerns over potential harm to migratory birds and an inadequate Environmental Impact Assessment (EIA). Local communities, led by Bishop of Mannar, protested, warning that the project could disrupt local industries and threaten livelihoods. President Dissanayake had pledged during his election campaign to cancel the deal, promising to invite global tenders for wind power development in Sri Lanka. Though the original pact was under review by the SL Supreme Court, with a hearing scheduled for March 2025, revocation removes the matter from judicial

However, wrist spinner Chahal was nowhere to be found having last represented the country in the 50-over format back in January 2023 during the ODI series against New Zealand.Since then, he hasn't played the format and was also ignored for the ODI World Cup held the same year. Recently, Harbhajan questioned Chahal's absence from the squad and mentioned how selectors could've picked him in the team to add variety to the spin attack as Jadeja and Patel are similar kind of bowlers. "Sanju isn't there. Yuzvendra Chahal isn't there, too. You've picked four spinners, two of them are left-armers. You could've included a legspinner for variation, too. Chahal is a superb bowler. I don't know what wrong he did, that



he doesn't fit in this team," Harbhajan told Switch.In 72 ODI matches played in his career so far, the 34-year-old has picked 121 wickets at an average of 27.13 and an economy of 5.26 with two five-wicket hauls to his name. Chahal was last selected in the Indian team for the T20 World Cup 2024, where he unfortunately warmed the bench for the entire tournament with Axar Patel, Ravindra Jadeja and Kuldeep Yadav being preferred over him in the playing XI.Furthermore, the former off-spinner also expressed dejection at Sanju Samson's snub from the team and argued that his batting suits the format, mentioning his stellar numbers in ODIs.

He has an average of 55-56, but he isn't even there as a second wicketkeeper. When we talk about selecting him, people ask, in whose place? Places can be made," he

added.Samson has been in remarkable form of late, having scored three centuries in his last six T20I innings. He also slammed a brilliant ton in his last ODI outing against South Africa in December 2023. The 30year-old boasts an average of 56.66 after 14 innings in ODI cricket with 510 runs to his name at a strike rate of 99.60. He has registered one hundred and three fifties in his career so far, but still his performances haven't been enough to impress the selectors, with Rishabh Pant getting preference over him.

the Women's Championship -- a 10-team tournament in which all teams played eight three-match series, four at home and four away -- the top six teams, including hosts India, secured direct qualification for the World Cup.Bangladesh and New Zealand were tied on 21 points each after 24 matches. However, New Zealand secured the higher position in the standings due to an extra win. Australia topped the Championship with 39 points, while India finished a close second with 37. England (32), South Africa (25), and Sri Lanka (22) are the other teams to have secured direct berths for the World Cup.Bangladesh (21), West Indies (18), Pakistan (17)

and Ireland (eight) will be joined in the Cricket World Cup Qualifier by Scotland and Thailand, the two other highest ranked teams as of 31 October 2024. The ICC is yet to announce the dates for the Cricket World Cup qualifier, in which two spots will be up
