Chandigarh, Jan. 10: Punjab farmer leader Jagjit Singh Dallewal targeted the BJP for seeking the Akal Takht's intervention for ending his fast-unto-



death, and said they should instead approach Prime Minister Narendra Modi and press him to accept farmers' demands if they want him to call off the strike, which entered day 46 on Friday. ### Supreme Court refuses to entertain pleas challenging 33% reservation to women

New Delhi, Jan. 10: The 'Nari Shakti Vandan Adhiniyam' got the President's assent on September 28, 2023 after a special session of the Parliament was called to pass the law. The Supreme Court on Friday refused to entertain petitions challenging the law providing 33% reservation to women, stating that the petitioners are free to approach the high court to contest the validity of the provision. The top court made the observations while hearing petitions filed by Congress leader Jaya Thakur and non-profit National Federation of Indian Women (NFIW) against the bill preceding the Constitution (106th Amendment) Act, 2023, which introduced 33% reservation for women in Parliament and state assemblies. The twin pleas sought striking down of a specific provision which made conduct of census and 🌉

implement the reservation as they argued for its immediate roll-out. "We are not inclined to interfere under Article 32," the bench headed by justice Bela M Trivedi said. The said provision in the Constitution allows citizens to approach the

> have to do with granting reservation? This is a violation of Article 14 (right to equality) of the Constitution. We are challenging that part which makes implementation subject to delimitation," Bhushan said. The bench observed, "There is no violation of Article 14," referring to the long history of legislative interventions to provide reservation for women in Parliament and Assemblies that failed to translate into law. "So far it was never brought into effect. Now it is implemented. If you find any unconstitutionality in it, you may challenge it in the high court," the court added. Representing the Centre, advocate Kanu Agarwal informed the bench that the timing of the implementation of the law is part of legislative policy, and no judicial review can lie in this regard. However, he slammed the petitioners

for raising a challenging to a Constitution Amendment Act without pointing out how the basic structure of the Constitution is affected by this law. The bill on women reservation in Parliament and assemblies was introduced in 1996, 1998, 1999 and 2008 but it failed to fructify into a law.

### Shiromani Akali Dal accepts Sukhbir Badal's resignation as party chief

Chandigarh, Jan. 10: Sukhbir Badal had tendered his resignation as the party chief on November 16 last year but the party's working committee did not accept his resignation. The working committee of the Shiromani Akali Dal (SAD) on Friday accepted the resignation of Sukhbir Singh Badal as party chief, Badal's resignation was accepted in the working committee meeting held at the party's headquarters in Chandigarh. The move came over a month after Akal Takht Jathedar Giani Raghbir Singh had asked the SAD to implement the December 2 edict at the earliest. On December 2, the Akal Takht had ordered the SAD working committee to accept the resignation of Sukhbir Singh Badal, who had been declared tankhaiya



(guilty of religious misconduct) for the mistakes commit ted during the SAD regime in Punjab. It had also formed a panel to appoint new delegates and hold elections for the post of SAD president and other office-bearers within six months. After his resignation was accepted, Sukhbir Singh Badal thanked party workers and leaders for their support. Badal had tendered his resignation as the party chief on November 16 last year but the party's working committee did not accept his resignation, appealing to him to reconsider his resignation otherwise the entire committee would resign en masse. While pronouncing the religious punishment for Badal and other leaders for the "mistakes" committed by the SAD and its government in Punjab from 2007 to 2017 on December 2, the Akal Takht also directed the SAD's working committee to accept the resignation of Badal as party chief and other leaders. Badal was declared 'tankhaiya' (guilty of religious misconduct) by the Akal Takht, the highest temporal seat of Sikhs, on August 30 last year. He had undergone religious punishment. Also Read Don't drag your feet, accept Sukhbir's resignation, jathedar Giani Raghbir Singh tells SAD On December 4, a former militant Narain Singh Chaura had fired at Sukhbir from close range - while the latter was undergoing tankhah (religious punishment) for the "mistakes" of his party - but had missed the shot as he was overpowered by policemen in plain clothes and later arrested.

#### Rajiv Bajaj jumps in on '90-hr work week' debate New Delhi, Jan 10: Amid an online outrage

over Larsen & Toubro (L&T) chairperson's "90hour work week" remarks, Bajaj Auto's managing director Rajiv Bajaj has said that the quality of work done matters much more than the hours. In an interview with CNBC TV18, Rajiv Bajaj said that if one wants a 90-hour work week, it should start from the top. "If you want a 90-hour week, start from the top," Rajiv Bajaj told CNBC-TV18. "Number of hours of work doesn't matter, the quality of work does. We need a kinder, gentler world more than ever before." Bajaj also said that companies must move away from adopting regressive policies like a fixed number of working hours. He also addressed the importance of work-life balance and weighed upon the cost of a 70 or 90-hour work week. "Even if someone works 70 or 90 hours a week, their life remains interconnected with other aspects-family, health, and well-being. Ignoring this interconnectedness will come at a cost," he said in the interview. Larsen and Toubro chairman SN Subrahmanyan triggered an online outrage after he asked people to work for 90 hours a week. "I regret I am not able to make you work on Sundays. If I can make you work on Sundays, I will be happier, because I work on Sundays," Subrahmanyan was quoted as saying in an undated video circulating on social media.

### SC issues notice in Sambhal Shahi Jama Masjid well dispute, orders status quo

New Delhi, Jan. 10: The Supreme Court on Friday issued a notice on a plea by the Sambhal's Jama Masjid management committee, and ordered status quo with regard to a private well located near the entrance of the mosque. A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar directed that no steps be taken regarding the well without its permission and instructed the authorities to file a status report within two weeks. The plea filed by the Committee of Management of Shahi Jama Masjid challenged a November 19, 2024 order by the Sambhal Senior Division Civil Judge that allowed the appointment of an advocate commissioner to survey the mosque. It was argued that the survey led to violence and loss of life, prompting the urgent intervention of the top court. Senior Advocate Huzefa Ahmadi, representing the Committee of Management, emphasised the historical been drawing water from the well since

over a notice referring to the site as "Hari Mandir" and plans for starting religious activities there. "No such activities will be permitted. Please file a status report," the

significance of the well, stating, "We have CJI said. The bench said the status quo must be maintained concerning the well, and no notices related to it would be given

effect. Advocate Vishnu Shankar Jain, representing the Hindu side, said the well is outside the mosque's purview and has historically been used for worship. Ahmadi said the well is partly within and partly outside the mosque premises, citing a Google Maps image to support the claim. "Pass an appropriate direction to the District Magistrate, Sambhal to ensure that status quo is maintained with respect to the private well situated near the stairs/entrance of the Mosque and not to take any steps/actions with regard to the same without due permission from this Hon'ble Court," the plea said. The mosque committee said it has filed the plea against a November 19, 2024 order of the Civil Judge, Senior Division, Sambhal at Chandausi, in a case. The local court allowed an application seeking appointment of an Advocate Commissioner to survey the Shahi Jama Masjid.

### Donald Trump gets unconditional discharge in hush money case

New York, Jan, 10: In a singular moment in US history, President-elect Donald Trump faces sentencing Friday for his New York hush money conviction after the nation's highest court refused to intervene. Like so much else in the crim-

inal case and the current American political landscape, the scenario set to unfold in an austere Manhattan courtroom was unimaginable only a few years ago. A state judge is to say what consequences, if any, the country's former and soon-tobe leader will face for felonies that a jury found he committed. With Trump 10 days from inauguration, Judge Juan M. Merchan has indicated he plans a nopenalty sentence called an unconditional discharge and prosecutors aren't opposing it. That would mean no jail time, no probation and no fines would be imposed, but nothing is final until Friday's proceeding is done. Regardless of the outcome, Trump will become the first person con-

victed of a felony to assume the presidency. Trump, who is expected to appear by video from his Mar-a-Lago club in Florida, will have the opportunity to speak. He has pilloried the case, the only one of his four crim-



possibly the only one that ever will. The judge has indicated that he plans the unconditional discharge - a rarity in felony convictions - partly to avoid complicated constitutional issues that would

arise if he imposed a penalty that overlapped with Trump's presidency. The hush money case accused him of fudging his business' records to veil a \$130,000 payoff to porn actor Stormy Daniels. She was paid, late in Trump's 2016 campaign, not to

tell the public about a sexual encounter she maintains the two had a decade earlier. He says nothing sexual happened between them, and he contends that his political adversaries spun up a bogus prosecution to try to damage him. "I never falsified business records. It is a fake, made up charge," the Republican president-elect wrote on his Truth Social platform last week. Manhattan District Attorney Alvin Bragg, whose office brought the charges, is a Democrat. Bragg's office said in a court filing Monday that


Trump committed "serious offenses that caused extensive harm to the sanctity of the electoral process and to the integrity of New York's financial marketplace." While the specific charges were about checks and ledgers, the underlying accusations were seamy and deeply entangled with Trump's political rise. Prosecutors said Daniels was paid off — through Trump's personal attorney at the time, Michael Cohen — as part of a wider effort to keep voters from hearing about Trump's alleged extramarital escapades. Trump denies the alleged encounters occurred. His lawyers said he wanted to squelch the stories to protect his family, not his campaign. And while prosecutors said Cohen's reimbursements for paying Daniels were deceptively logged as legal expenses, Trump says that's simply what they were. "There was nothing else it could have been called," he wrote on Truth Social last week, adding, "I was hiding nothing." Trump's lawyers tried unsuccessfully to forestall a trial. Since his May conviction on 34 counts of falsifying business records, they have pulled virtually every legal lever within reach to try to get the conviction overturned, the case dismissed or at least the sentencing postponed.

### No disputed structure should be called mosque: Yogi

Lucknow, Jan. 10: "The day we stop calling such a structure a mosque, people will stop going there too. It is also against the principles of Islam to hurt anyone's faith and build a mosque-like structure there and any kind of worship at such a place is not acceptable even to God," he said at a conclave organised by a private news channel at Airavat Ghat in Mahakumbh mela area ahead of the formal start of Mahakumbh-2025. "When the God does not approve of such worship, why should we worship there in vain. Also, it is not necessary to build a structure for worship in Islam, while it is very much so in Sanatan Dharma." the CM added. "Sanatanis will go to temple for worship but so is not in Islam. In such a situation, we should not insist on calling any structure a mosque. This is the time to move forward with thinking about a new India. We should pay attention to this," he said. Yogi further said the installation of Ram Lalla in Ayodhya a year ago and the Mahakumbh being held at such an auspicious time after 144 years, were due to the grace of God. He said sadhus from some states of Northeast along with South India were not able to come to


Kumbh-2019 whereas this time, the picture of 'Ek Bharat, Shreshtha Bharat' will be seen in Mahakumbh-2025. "Sadhus and devotees



from everywhere will be present here. The third largest population of the world will take a dip in the Triveni of Prayagraj in the next 45 days," the CM added. "I have come here many times. I have come to the banks of Sangam and seen the water and its quantity. I have also bathed in the water and sipped it. My health did not deteriorate. Some people have taken a contract of spreading propaganda," Yogi said. "Currently, there is more than 10,300 cusec of water only in the Ganga and the Yamuna. Such a large amount of water has never been seen at the Sangam in independent India," he added. "It is so clean that you can take a dip and also do 'aachman' (sip) without any hesitation. I do it myself and this is also my belief,"

### Congress takes dig at PM Modi over 'I'm not a God' remark in podcast with Nikhil Kamath

New Delhi, Jan. 10: The Congress party on Friday reacted to Prime Minister Narendra Modi's "I'm not a god" remark during a podcast with Zerodha co-founder Nikhil Kamath. In the over two-hour-long



podcast, which was released on Friday on YouTube, the Prime Minister said that everyone makes mistakes, including him. Recalling a speech he had delivered as chief minister of Gujarat, Modi told Kamath: "When I became the chief minister, I gave a speech in which I said, 'I will not shy away from hard work' and 'I will not do anything for myself' and 'I am human who can make mistakes, but I will never do anything wrong with bad intentions.' This is my life's Mantra. Everyone makes mistakes, including me. After all, I am a human being, not

some God," Modi said in the podcast. Reacting to the remarks, Congress MP Jairam Ramesh said that the statement is coming from the Prime Minister who had "proclaimed his non-biological status" before the 2024 Lok Sabha election. Ramesh was referring to a remark by Modi in an interview that he had been "sent by God". "This from a man who proclaimed his non-biological status just eight months back. This is clearly damage control," Ramesh wrote on X, while sharing a clip of PM Modi's old interview. "Until my mother was alive, I used to think I was born biologically. After her demise, when I look at my experiences, I am convinced that I was sent by God. This strength is not from my body. It has been given to me by God. That's why God also gave me the ability, strength, pure-hearted-

ness, and inspiration to do this.



### **BBMP** fines Rodic Consultants for major error in Tunnel Road project report

BENGALURU. The Bruhat Bengaluru Mahanagara Palike (BBMP) and the state government have been left red-faced following the 'error' in the Detailed Project Report (DPR) for its ambitious Tunnel Road project. Table 15 of the Executive Summary on page 29 of the DPR has details of cities like Nashik and Malegaon in Maharashtra instead of Bengaluru. Taking serious note of the same, BBMP imposed a penalty of Rs 5 lakh against New Delhi-based Rodic Consultants Limited. Chief engineer, BS Prahlad took to X and informed that the agency has apologised for the error, which he attributed to a compilation mistake. "Rodic Consultants Limited has tendered



its apologies for the mistake. A penalty of Rs 5 lakh has been imposed.BBMP looks forward to more constructive public participation," he wrote. The mistake drew sharp criticism from activists and the opposition BJP, who labelled it as 'copy paste' work for a project worth Rs

### Rajagiri's green zone is so much more!

KOCHI. Kakkanad, once synonymous with everything IT, has in recent years been relegated to 'trash talks' after a fire at the waste treatment plant in Brahmapuram on March 2, 2023, left a greater part of Kochi gasping for breath for weeks. The incident threw light, among many things, on the fast-depleting green cover in the city as it makes giant strides to become a metropolis. Though several 'band-aid' campaigns have been launched since then, the Rajeevani initiative of Rajagiri College in Kakkanad deserves special mention.

The programme has seen a section of the campus designated as an 'Oxygen Zone' in 2014. Lush with greenery, this space improves air quality and enhances the overall well-being of the campus community."It was Fr A J Saviance's vision that helped shape this project," says Lakshmi K Raghavan, a Rajagiri faculty member."Every year, we introduce new initiatives to further augment this programme. Now, it is spearheaded by the college's Nature Club.""The Oxygen Zone also comprises Rajeevanam, an ecofriendly herbal orchard with ayurvedic medicinal plants.

There are 284 plant varieties here, including 28 found on the IUCN Red List and considered endangered, such as rudraksham," says Annu James, a faculty member and coordinator of Nature Club.In addition, there are 130 mahogany and 100 mango trees, a 'pachakkari thottam', a fruit garden, and a special section called Nakshatravanam (star forest) wherein specific trees co-relating with the 27 birth stars as per Indian astrology are planted.

The initiatives undertaken by the students include millet farming, creating biodiversity and fauna registers, and organising sapling distribution to nearby neighbourhoods.

### KSRTC to deploy 800 buses during Makaravilakku

THIRUVANANTHAPURAM. In view of the heavy rush during the Makaravilakku, KSRTC has decided to deploy over 800 buses for Sabarimala pilgrims.Buses will be pooled from different depots for chain services, special services and long-distance services. The elaborate arrangements come in the backdrop of a High Court direction to ensure that no pilgrim travels standing. A meeting held by the KSRTC management evaluated the arrangement of buses and their parking causing minimal disruption to other pilgrims visiting Pampa. There are currently 245 buses in the Pampa-Nilakkal chain service, long-distance services from Pampa and parking circular services.In addition, 228 buses are also operating from various special centres, including Pathanamthitta, Chengannur, Kottayam, Erumeli, Kumily, Kottarakkara, Punalur and Ernakulam. Besides, 400 more buses will be brought for special service on Makaravilakku day. The buses will be arranged for the pilgrims to reach Nilakkal after the Makara Jyothi darshan on January 14. The officials said that the long-distance services and chain services from Pampa to Nilakkal will be operated only in a controlled manner.

### Air quality in Chennai improved by 43 per cent, says report

CHENNAI. Chennai may have made progress in its fight against air pollution, as per an analysis by environmental think tank EnviroCatalysts. The report states that the city's annual average PM2.5 levels have dropped from 49 µg/m3 in 2017, the baseline year for the National Clean Air Programme (NCAP), to 28 µg/m3 in 2024, marking a 43% improvement in air quality. However, insufficient monitoring stations and data gaps continue to raise concerns. Ideally, a city of Chennai's size should have 30 continuous ambient air quality monitoring stations (CAAQMS). However, it currently has only nine. Only seven of these nine stations had data for the full year of 2024. The remaining two in Ennore and Manali, both industrial regions, didn't have data for nine and seven months respectively. The analysis also reveals uneven progress across Chennai's neighbourhoods. Alandur Bus Depot reported the highest annual PM2.5 concentration at 45 µg/m3, while Kodungaiyur recorded the lowest at  $13 \mu g/m3$ . Four stations reported concentrations at or below 25 µg/m3, meeting India's National Ambient Air Quality Standards (NAAQS), which set the annual PM2.5 limit at 40 μg/m3. With this, however, Chennai has achieved the NCAP's set goal of reducing pollution levels by 40% by 2024.

Experts believe the city must now target WHO's interim standard of 15 µg/m3 and eventually strive for the guideline value of 5 µg/m3 to ensure healthier air for its residents.Sunil Dahiya, founder of EnviroCatalysts, said, "No doubt Chennai has made some progress, but these numbers do not represent the entire city



since the number of CAAQMS are less compared to other metro cities. But given the challenges posed by industrial emissions, vehicular pollution, and high levels of fuel combustion, these results are remarkable, and being a coastal city helps as pollutants get dispersed quickly." Dahiya pointed out that cities like Delhi, which struggle with annual PM2.5 levels nearing 100 µg/m3, can learn from Chennai's efforts..He added that better progress could be achieved through stricter industrial emission standards, modernisation of public transportation, and a transition away from fossil fuels in the energy and transport sectors. These measures could help Chennai meet WHO's interim and long-term air quality

targets.quality targets.Prabhakaran Veerarasu of Poovulagin Nanbargal, however, warned against removing Chennai from the NCAP list, arguing that doing so could disrupt the flow of resources critical for further improvement, such as air quality monitoring infrastructure and pollution control initiatives. Prabhakaran said the government must continue financing air quality management programmes and expand the network of monitoring stations to ensure comprehensive and accurate data collection. He highlighted Chennai's unique opportunity to become the first Indian city to meet WHO air quality guidelines by 2030, given its geographical advantages and current

### 3,580 govt schools in Karnataka lack functional loos: Report

**BENGALURU.** While toilets are considered a basic necessity, more than 3,580 government schools in Karnataka lack functional toilets while nearly 4,000 schools do not have hand wash facilities. The sorry state of government schools, which reflects on lack of functional toilets in 2,648 boys' or co-educational schools and 937 girls' or co-educational schools, was highlighted in the recently released Unified District Information System for Education (UDISE) 2023-24 report, highlighting a glaring neglect of basic infrastructure in the state's education system.

Experts question what is stopping the government from providing basic facilities in schools and argue that the government must halt its focus on promoting modern practices in schools and universities until it fixes these critical infrastructure issues in government schools.Development Educationist Professor Niranjanaradhya stated that the figures are 'underestimated' and fail to represent the ground reality. "The availability of toilet facilities is far worse than what the report indicates. The actual numbers are likely three to four times more," he lamented. Providing basic facilities like functional toilets and drinking water are fundamental development rights, but development rights require adequate funding—something the state government seems unwilling to prioritise, he said.Prof Niranjanaradhya stressed that the Right to Education (RTE) Act, which mandates these facilities, has been in place since 2010.

'Fifteen years later, in 2025, if the government still cannot fulfil these bare minimum standards, what hope do we have for achieving anything beyond this?" he questioned. Child rights activist Vasudev Sharma highlighted the dire state of washrooms, particularly in rural areas. He noted that many do not have running water, lack proper latches, or are located at inconvenient distances, making them inaccessible and unsafe for children. Further, he

also questioned the government of why it makes improvements in urban areas alone. Sharma said that during every child rights Gram Sabha, the first demand raised is always for proper, functional toilets. "Why is the government turning a deaf ear to such a basic and urgent need?" he questioned. He called this not just a severe violation of the RTE Act, but also a betrayal of every child in government

These reports expose the truth, yet the government refuses to act on them. How long will they continue to ignore these findings?" he asked.Nagasimha G Rao, director of Child Rights Trust, criticised the government, for claiming to work for children, asking, "Where is the proof of this? Such figures only highlight the blatant neglect."Rao said that the government should examine the figures and identify where the gaps are being ignored. It must ensure that basic facilities are provided, creating an environment.

### A night walk through the spooky lanes of Fort Kochi

KOCHI.People have witnessed many tourist locations and monuments in Fort Kochi. And many know that Kochi decked up for Christmas and New Year. What about Kochi at night?Food anthropologist Oneal Babu's spook trail through Fort Kochi lanes is an interesting heritage walk that introduces the lore, myths, history and horror stories of Kochi to visitors.Oneal came across the concept of a spooky trail while he was studying in Edinburgh, Scotland."A man there used to hold a spooky trail with stories of witches and sorcery. Many of those lore sounded just like Harry Potter," he recalls. When he returned to Fort Kochi, his hometown, inspired by the Edinburgh spook trail, he set up his own night walk, filled with spooky tales and history talks. He named the initiative Phantasma - Colonial Crawlies."The first edition of Phantasma was through Jew Town, a lesser-known location in Fort Kochi. ### Sanitation workers boycott work, Bhubaneswar cleaning stalled

BHUBANESWAR. Cleanliness activities were crippled in the state capital as hundreds of sanitation workers of the Bhubaneswar Municipal Corporation (BMC) staged a mass protest seeking justice for the family of their association leader Sahadev Nayak who was brutally murdered near Rasulgarh on Wednesday. Boycotting street sweeping, door-to-door waste collection and other cleaning work, the workers gathered at Sishu Bhawan Square and demanded capital punishment for those involved in the gruesome murder of their leader in broad daylight. "Our protest will continue till justice is delivered to Sahadev," said one of the agitating workers.

The agitation brought city's sanitation activities to a grinding halt, prompting BMC to look for an alternative to ensure the ongoing Pravasi Bharatiya Divas (PBD) was not impacted. A senior officer of BMC said demands of the workers were justified but efforts are on



to ensure sanitation work is not affected by the agitation. "Accordingly, alternative arrangements have been made for waste collection and disposal in the priority road network during the PBD convention," he added. The BMC also urged the sanitary workers to resume their work at the earliest. Earlier, mayor Sulochana Das had termed Sahadev as a messiah of the sanitation.

Office, and banks nearby were the backbone of our business," says P M K Premnath, the current owner of the shop.P M Krishnan, father of Premnath, moved from Thalassery to Thiruvananthapuram, to establish the Santha Bakery, and continued the legacy of the renowned Mambally family of Thalassery. This family is famous for Bapu, who is credited with creating the first Christmas cake in India

Over the years, Santha Bakery has become a beloved destination, attracting famous personalities who visit to taste its special makes."EMS Namboodiripad, A K Gopalan, P Krishna Pillai, and many others, had a close connection to my father through their involvement with the Communist movement, so they would often drop by. Sometimes, they would just sit and have friendly conversations here. People like Sivaji Ganesan, Gemini Ganesan, Sathyan, Sukumari, and writers such as S K Pottekkatt have also visited the shop to buy things in the past,' Premnath says. Santha Bakery was the first to introduce new tastes to Thiruvananthapuram, such as the doughnut in the 1970s, which people humorously referred to as 'Inippu vada' (sweet vada) at the time. They also offered hand-kneaded bread, apple cake, and many other firsts.

### Two more held in BMC staff killing, drug cartel angle emerges

BHUBANESWAR. A day after the brutal murder of sanitary supervisor Sahadev Nayak rocked Bhubaneswar, police on Thursday arrested two more assailants even as the victim's family alleged a bigger brown sugar smuggling network was behind the incident.

On the day, another couple Laxmi Nayak and Rakesh Nayak were nabbed in connection with the crime on the day, taking the total arrests to five. Prime accused Lipika Nayak, her husband Laxmidhar Nayak along with an associate Rocky Nayak had been held on Wednesday.Police said the murder was over previous enmity of Sahadev with the two couples and carried out by six persons. Briefing mediapersons, Bhubaneswar DCP Pinak Mishra said, one more accused identified as Sushant Nayak is still at large

and police are trying to nab him.

The arrested five, he said, had assembled at Sushant's house in Dumduma on Tuesday evening to hatch a plan to kill Sahadev over personal enmity. As part of their plan, Lipika, Laxmidhar, Rocky and Sushant intercepted Sahadev near Rasulgarh overbridge when he was returning after dropping his daughter at her school."The four attacked Sahadev with two swords and killed him on the spot. They then went to Daya river and disposed of the weapons along with their clothes. They fled to Lipika's native village within Sarankul police limits in Nayagarh district," said

The victim as well as the accused belonged to Kedarpalli slums. Sahadev who was a sanitary supervisor with the Bhubaneswar



Municipal Corporation was also a police volunteer. Even as police stuck to the personal enmity angle, the victim's family alleged there was a bigger conspiracy to eliminate him as he was strongly opposed to drug peddling in Kedarpalli. Sahadev's family members including his wife Sunita met Mancheswar police on the day and alleged that he was killed since he had confronted drug suppliers in his locality."Sahadev was against the brown sugar trade as he was concerned about the future of youths in the locality. He had even confronted some peddlers in the past for selling the contraband," said the victim's uncle, Bijay Nayak. Since Sahadev was a police mitra and shared

information with police, his family suspect a bigger conspiracy was hatched to eliminate him as he was opposed to the kingpin of the drug ring, reportedly a woman.

Noida. The air quality recorded marginal improvement but remained in the 'moderate' category in Noida and Ghaziabad on Wednesday. The city's AQI improved to 161 from 189 recorded on Tuesday, Greater Noida's AQI dropped to 177 from 182, while Ghaziabad's improved to a 'moderate' AQI of 198 from 202 in the 'poor' category a day ago. Noida's Sector 1 recorded a reading of 203 in the "poor" category, Sector 116 was at 161 and Sector 125 registered an AQI of 135 - both 'moderate'. Data from the air monitoring station of Sector 62 was not available. In Greater Noida, Knowledge Park V station had a 'poor' AQI at 222. Knowledge Park III recorded 144 in the 'moderate' category.In Ghaziabad, Indirapuram and Vasundhara recorded AQI readings of 270 and 219 - both 'poor', while Loni and Sanjay Nagar registered 183 and 144, in the 'moderate' category.

According to a bulletin of the Indian Institute of Tropical Meteorology (IITM, the predominant surface wind came from the north-west direction with a wind speed of less than 12 kmph on Wednesday evening. The wind speed decreased thereafter, becoming less than 6 kmph during the night. On Thursday, the wind speed is likely to decrease, becoming 4-6 kmph from the north-west direction during the afternoon. It will further decrease thereafter, dropping below 2 kmph from the variable direction during the evening and night. The India Meteorological Department said on Wednesday, the visibility ranged from 50 metres to 200 metres till 8.30am. Cold day conditions will continue to prevail in Noida and Greater Noida on Thursday.

### Noida to get its second clock tower at Sec 128

Noida. Noida Authority is set to build a 25-foot-tall clock tower at Sector 128 roundabout. This will be the city's second clock tower. A 75ft tall clock tower is under construction near GIP Mall in Sector 18. Estimated at Rs 1.8 crore, this project is expected to become a major attraction in the city. The Sector 128 clock tower will have two floors, surrounded by landscaped gardens, and will be constructed with granite and bricks. Situated along the Noida Expressway, Sector 128 is a hub for residential projects, IT, and corporate offices.

Deputy director (horticulture) Anand Mohan Singh of the Noida Authority said, "This is part of the Authority's efforts to beautify key areas and provide iconic structures for residents. Many tourists use the Noida expressway to travel to Agra and Mathura. The tower will not only cater to city residents but also to these commuters." Meanwhile, the Sector 18 clock tower near GIP Mall draws inspiration from the Lal Chowk clock tower in Srinagar. Unlike its inspiration, the one in Sector 18 will not have multiple floors. Instead, it will feature a peak-like top with the Indian tricolour hoisted above it. This location was strategically chosen for its connectivity to Delhi and its proximity to the commercial hub of Sector 18 on one side and GIP Mall on the other. The clock will display Roman numerals and run on solar power. The company constructing the tower is also responsible for installing the clock mechanism.

The red-coloured structure will showcase elements of Uttar Pradesh's cultural heritage, offering visitors a glimpse into the state's traditions. A green belt will surround the Sector 18 clock tower. The area will also have sitting benches and a selfie point.

This project aligns with the Authority's broader vision to create a unique cultural identity for Noida. In the past, Noida Authority CEO Lokesh M instructed the development of such structures in the city's downtown area, marketplaces, and other civic hubs to serve as focal points of urban planning.

### Study finds 22 Haryana cities have PM10 levels above national standards; Gurgaon and Faridabad top list

Gurgaon. The concentration of pollutant PM10 exceeded the maximum level considered safe in all 22 cities of Haryana where researchers carried out a study

Gurgaon and Faridabad were the most polluted, and Narnaul and Ambala the least in the group of 22, according to the Centre for Research on Energy and Clean Air (CREA). In Gurgaon, the study recorded average PM10 levels over 2024 at 186 µg/m³, more than three times the limit of 60 µg/m<sup>3</sup> set by the National Ambient Air Quality Standards (NAAQS).

Faridabad, the only city in the state that has been tagged as 'non-attainment' under the National Clean Air Programme, wasn't far behind, with an average of 171 μg/m³ PM10 levels. On 280 days of the year – 76.5% -- PM10 concentration in Faridabad exceeded the daily NAAQS limit.Gurgaon's count was even higher, at 290 days.PM10, or particulate matter with a diameter of 10 micrometers or less, can penetrate deep into the respiratory system, causing or exacerbating breathing ailments and cardiovascular diseases. Prolonged exposure can also lead to chronic health conditions, especially among children, the elderly, or people with existing ailments. The pollutant is released from industries, vehicles, waste burning and construction dust. "It is alarming that all 22 cities that were monitored for PM10 were found to be breaching the national limit. Even after six years (of being part of NCAP), Faridabad has seen slight improvement in PM10 levels between 2019 and 2024," said Manoj Kumar, analyst at CREA.

NCAP, an initiative introduced in 2019, shortlisted 130 Indian cities where the air quality did not meet NAAQS limits from 2011 to 2015. Funds are provided to these 'non-attainment' cities to achieve clean air targets.Kumar said the govt should consider expanding the scope of NCAP. "The current NCAP misses a critical health component and primarily focuses on PM10. NCAP 2.0 should address this gap by prioritising PM2.5, as it poses a greater threat to human health," he said. Another poor performer in CREA's study was Ballabgarh, which recorded an annual PM10 average of 168 µg/m<sup>3</sup> and saw 275 days when the concentration of the pollutant exceeded safe limits in 2024.

Akshit, the ACP said, is absconding and they are trying to get more details about Sumit and Ankit from those targeted in cybercrimes. "We will try to get in touchwith the Nagpur resident who was cheated of Rs 65 lakh," the ACP

### "False": International Fact-Checking Network On Zuckerberg's Censorship Claim

Washington, United States. Meta founder and CEO Mark Zuckerberg's claim that the fact-checking program on Facebook and Instagram has veered into censorship is "false", the International Fact-Checking Network said Thursday. "This is false, and we want to set the record straight, both for today's context and for the historical record," said the global network of fact-checking organizations, including AFP, after Zuckerberg announced an end to Meta's US program. In announcing the significant rollback of Meta's content moderation policies on Tuesday, Zuckerberg said the program had made "too many mistakes and too much censorship". While Meta's



decision to scrap fact-check operations currently only applies to the United States, the International Fact-Checking Network warned of the potentially devastating impact if the group were to end its worldwide programs covering more than 100 countries. "Some of these countries are highly vulnerable to misinformation that spurs political instability, election interference, mob violence and even genocide," the network said.

'If Meta decides to stop the program worldwide, it is almost certain to result in real-world harm in many places," it added.AFP currently works in 26 languages with Facebook's fact-checking program, in which Facebook pays to use fact-checks from around 80 organizations globally on its platform, WhatsApp and Instagram.

In that program, content rated "false" is downgraded in news feeds so fewer people will see it and if someone tries to share that post, they are presented with an article explaining why it is misleading.

### Malibu Ocean-Front Hollywood Stars' Homes Wrecked In LA Wildfires

Pacific Palisades, United States. Flying south through smoky skies down the famous Malibu coast, at first the burnt-out mansions are the exception -- solitary wrecks, smoldering away between rows of intact, gleaming beachfront villas.

But draw closer to Pacific Palisades, the ground zero of Los Angeles's devastating fires, and those small scorched ruins become sporadic clusters, and then endless rows of charred, crumpled homes. From the air, the extent of the devastation wrought by the Palisades Fire on these two neighborhoods is starting raisades Fire on these two neighborhoods is starting to come into focus: whole streets in ruins, the remains of once-fabulous houses now nothing but ash and memories. Access to this area of utter devastation has been largely closed to the public and even to evacuated residents since the fire began Tuesday. The biggest among multiple blazes covering Los Angeles, the inferno has now ripped through over 19,000 acres (7,700 hectares) of Pacific Palisades and Malibu. A preliminary estimate of destroyed and Malibu. A preliminary estimate of destroyed structures was "in the thousands," city fire chief Kristin Crowley told Thursday's conference.

There have been at least two separate reports of human remains found in this fire alone, though officials have yet to confirm the fatal toll."It is safe to say that the Palisades Fire is one of the most destructive natural disasters in the history of Los Angeles," said Crowley.For AFP reporters surveying the scenes from a helicopter Thursday, it was hard to argue with

On some of these highly coveted Malibu oceanfront plots, beloved by celebrities, skeletal frames of buildings indicated the lavish scale of what has been destroyed.Other multi-million dollar mansions have vanished entirely, seemingly swept into the Pacific Ocean by the force of the Palisades Fire.

And looming above Malibu, a thin sliver of luxurious waterfront property, is Pacific Palisades itself -- an affluent plateau of expensive real estate, now deserted. Not the entire hilltop is blackened. Several grand homes stand unscathed. Some streets have been spared entirely. But toward the southern end of the Palisades, grids of roads that were until Tuesday lined with stunning homes now resemble makeshift

### Deaths In Gaza During First 9-Months Of War 40% Higher Than Recorded: Lancet

Paris, France. Research published in The Lancet medical journal on Friday estimates that the death toll in Gaza during the first nine months of the Israel-Hamas war was around 40 percent higher than recorded by the Palestinian territory's health ministry.

The number of dead in Gaza has become a matter of bitter debate since Israel launched its military campaign against Hamas in response to the Palestinian militant group's unprecedented October 7, 2023 attack.Up to June 30 last year, the health ministry in Hamas-run Gaza reported a death toll of 37,877 in the war. However the new peer-reviewed study used data from the ministry, an online survey and social media obituaries to estimate that there were between 55,298 and 78,525 deaths from traumatic injuries in Gaza by that time. The study's best death toll estimate was 64,260, which would mean the health ministry had under-reported the number of deaths to that point by 41 percent.

That toll represented 2.9 percent of Gaza's pre-war population, "or approximately one in 35 inhabitants," the study said. The UK-led group of researchers estimated that 59 percent of the deaths were women, children and the elderly.

The toll was only for deaths from traumatic injuries, so did not include deaths from a lack of health care or food, or the thousands of missing believed to be buried under rubble.AFP is unable to independently verify the death toll.On Thursday, Gaza's health ministry said that 46,006 people had died over the full 15 months of war.In Israel, the 2023 attack by Hamas resulted in the deaths of 1,208 people, mostly civilians, according to an AFP tally based on official

Israeli figures.

### Grant Visa To Afghan Businessmen, Students: Taliban Urges India

World. Afghanistan has assured New Delhi that it does not pose a threat to any nation and expressed hope for raising the level of diplomatic relations with India, which it described as "a key regional and economic player."In a statement issued after the first publicly acknowledged engagement between Kabul and New Delhi after the Taliban government came to power, Afghanistan's Foreign Ministry urged raising the level of diplomatic relations, and easing the visa regime for Afghan businessmen, patients and students.

Afghanistan's acting Foreign Minister Mawlawi Amir Khan Muttaqi and Indian Foreign Secretary Vikram Misri met in Dubai on Wednesday.Muttaqi underlined a desire of strengthening political and economic relations with India as a key regional and economic player, in line with Afghanistan's balanced and economycentric foreign policy, the Afganistan statement said in Kabul." Assuring the Indian delegation that Afghanistan does not pose a threat to any nation, FM Muttaqi expressed hope for raising the level of diplomatic relations, and easing the visa regime for Afghan businessmen, patients and students," the statement said.

The Afghanistan Foreign Ministry statement said that during the Wednesday's meeting, Afghanistan's Deputy Ministers of Commerce & Transport were present and comprehensive talks were held on political, economic

and people-to-people relations between the Appreciating Afghanistan's efforts in

ensuring security, and combating narcotics and corruption in the country, the Indian Foreign Secretary emphasised India's interest in expanding political and economic relations with Afghanistan, and promoting trade through the Chabahar

Port," it added.

After the meeting in Dubai, the External Affairs Ministry (MEA) in a statement in New Delhi said on Wednesday it would consider engaging in development projects in Afghanistan and provide material support to the country in the health sector.

The meeting saw the Afghan side underlining its "sensitivities" to India's security

The Misri-Muttaqi talks came two days after India "unequivocally" condemned Pakistani airstrikes in Afghanistan that killed dozens of civilians.India has not yet recognised the Taliban set-up and has been pitching for the formation of a truly inclusive government in Kabul. ### Dubai's New Rs 85,000 Crore Project: 2 Buildings Connected By A "Sky Pool"

World. Two new skyscrapers, each standing at 591 feet, will soon be added to Dubai's skyline as part of a \$1-billion (around Rs 85,879 crore) luxury development at Marasi Marina. The twin towers will be connected by a 43-foot infinity pool perched on the rooftop, but access to this feature will be restricted to a private ultra-penthouse, reported CNN.The project is named Regent Residences Dubai, and it's expected to be ready by 2027. Developed in partnership between real estate

company Sankari and IHG Hotels & Resorts, it will comprise 63 luxury apartments, with each unit occupying an entire floor and offering views of the Burj Khalifa and Dubai Creek.Described by the architects as an "ultra-penthouse," the project's signature rooftop pool won't be accessible to most residents. The penthouse, spanning 35,000 square feet, will feature six bedrooms, a private gym and a personal elevator. While the exclusive pool



remains out of reach for others, all apartments in the development will come with private swimming terraces and access to an 82-foot indoor lap

Architectural firm Foster + Partners, which designed the project, said the towers' exterior was inspired by cascading water. Renderings show pool terraces extending from the buildings' facades. The architectural design splits the structure into two towers, both sharing the "same design language," said Foster + Partners in a

statement. This layout allows for one expansive apartment on each floor, maximising natural light and ventilation.In addition to offering panoramic views of the Burj Khalifa, each apartment is carefully positioned to take in the stunning sunrises and sunsets over the city."At the highest level, an ultra-penthouse bridges the two towers and features a spectacular sky pool," read the statement. Beyond luxury residences, Regent Residences Dubai will offer a wide range of facilities, including tennis and padel courts, outdoor lounges, a private cinema and a virtual golf simulator. The project will also feature 10 floating homes, referred to as "water villas."

The towers' podium will include green spaces, retail outlets and dining options. The skyscrapers are part of a broader redevelopment initiative at Marasi Marina in Business Bay, a waterfront neighbourhood south of Dubai's downtown area. The project aims to transform the area into a hub for

### Sri Lankan Navy arrests 10 fishers from TN, Puducherry for crossing IMBL

NAGAPATTINAM. Ten fishermen from Puducherry's Karaikal and TN were arrested by the Sri Lankan navy on Wednesday night for allegedly crossing the International Maritime Boundary Line (IMBL) and fishing in the island nation's waters. The mechanised boat in which the crew went for fishing is registered in the name of P Selvamani from Keezhakasakudimedu in Karaikal, said sources. The crew included three from Vanagiri, one from Perumalpettai and one from Vellakoil in Mayiladuthurai district; one from Samanthanpettai in Nagapattinam district; and two from Keezhakasakudimedu and two from Karaikalmedu in Karaikal.Sources said the fishermen ventured into sea from the Karaikal on Tuesday. They were fishing southeast of Kodiyakarai (Point

### Walayar case: CBI arraigns parents of victims

KOCHI. In a dramatic twist in the Walayar case, the CBI, in a supplementary chargesheet, has arraigned the parents of the victims in the rape and death of two sisters, aged 9 and 13, that rocked the state in 2017. As many as six chargesheets were filed before the Ernakulam CBI court in the case, and in all of them, the parents of the victims were indicted. They were accused of abetting rape and not reporting the rape incident to the police, sources said. They were charged with offences under IPC and the Protection of Children from Sexual Offences (POCSO) Act.

The CBI investigation found that the parents deliberately concealed the facts that their daughters were raped by the accused persons. Similarly, the investigation agency also found that accused persons abeted the rape.

Earlier, CBI filed six chargesheets related to the rape and suicide deaths of two sisters. The accused in the cases are Valiya Madhu, Shibu, Pradeep and Kutti Madhu for the death of the elder girl. Similarly, Valiya Madhu and a minor boy were accused of abetting the murder of the younger girl.Kutty Madhu was later found dead in a closed private factory in Binanipuram near Aluva in October 2023. Another accused, Pradeep was found hanging in his Cherthala residence on November 4, 2020. While Valiya Madhu and Cheriya Madhu were close relatives of the girls, Shibu, a resident of Rajakkad in Idukki, had been living with the family for several years and frequently engaged in masonry work with them. The incident took place in 2017 when the two girls were found dead within a span of two months in Walayar, in Palakkad. The siblings were found hanging in the same fashion in a shed near their house. Walayar police had come to the conclusion that the girls were sexually abused for nearly a year until they were forced to end their lives.The CBI took over the probe following the directive of the Kerala High Court in April 2021 after ordering.

### At 12.8°C, Ahmedabad sees second coldest morning of 2025

AHMEDABAD. Amdavadis woke up to a crisp winter morning as the mercury touched 12.8 degrees celsius on Thursday, bringing a fleeting chill that has been rare this season. While temperatures dipped below 13 degrees for the second time in 2025, the trend of warmer-than-usual winters continues, with average minimums staying above normal since Nov.The temperature rollercoaster is set to continue, as winds shifting to easterly and south-easterly directions are expected to drive temperatures higher. Though Thursday was cooler than usual, the minimum temperature was still 0.5 degrees higher than normal. This comes after a week where minimum temperatures climbed to 15.1 degrees celsius. Since Nov, the city's lowest recorded temperature was 11.8 degrees celsius on Dec 17. However, the overall trend shows a warmer winter, with minimum temperatures averaging 1.8 degrees above normal in Nov and 1.4 degrees higher in Dec.Meanwhile, a change in wind direction from easterly to south-easterly is likely to cause a rise in temperature in the city and state from Friday.The India meteorological department (IMD) predicts a rise in minimum temperatures by 2-3 degrees celsius over the next two days,

### ACB questions KTR for over seven hours on alleged misuse of funds in Formula-E race

HYDERABAD. A team of ACB officials, comprising the agency's joint director Ritira, DSP Majid Ali Khan and deputy director SVN Shivaram, on Thursday grilled former Municipal Administration minister KT Rama Rao for over seven hours as part of the investigation into the allegation of corruption in organising the Formula-E car race in 2023.

Rama Rao, accompanied by senior advocate J Ramachandra Rao, reached the heavily barricaded ACB office at Baniara Hills at 10:10 am. According to sources, Rama Rao was reportedly asked whether he was aware of the alleged illegality in the transfer of funds to a foreign firm, the reason behind the payment at a time the Model Code of Conduct (MCC) was in force, and why no prior approval from the Cabinet or RBI was obtained.

He was also questioned about whether IAS officer Arvind Kumar or former HMDA chief engineer BLN Reddy informed him about the procedures and the reason behind the withdrawal of Ace Nxt Gen Pvt Ltd as a sponsor from the race. Additionally, he was asked if there was any proof to back his claim that the state earned about Rs 700 crore from the event and several questions based on the statements of Arvind Kumar, Accused No. 2 in the case.According to sources, Rama Rao countered some of the ACB's questions with his own while clarifying others. When asked why the file related to the Formula-E race was signed but not forwarded for Cabinet approval, the former minister responded that he signed the file to promote Telangana's reputation and facilitate the race in Hyderabad.He told the



ACB that Business Rules related to government operations and the movement of files fall entirely under the purview of the chief secretary.Regarding allegations of corruption, Rama Rao stated that since the funds sent by the government reached FEO, the issue of corruption does not arise.

He pointed out that the FIR itself clearly outlines the flow of funds and leaves no room for allegations of misuse. "The charges are baseless, and the case is illegitimate," the former minister reportedly told the ACB.He pointed out that all communications regarding the Formula-E race are stored in the official email account assigned to him as a minister, which is now under the state government's control. The former minister reiterated his authority to make policy decisions as part of the government.On the issue of Cabinet approval,

Rama Rao asserted that the chief secretary and senior officials oversee Business Rules. The former minister argued that the ACB did not have the authority to question policy decisions. Noting that both state and Union governments often make policy decisions to organise sports events, he cited Andhra Pradesh's hosting of the Afro-Asian Games as an example. The interrogation reportedly focused on the same six or seven questions. ### Kerala Government extends suspension of IAS officer Prasanth by 120 days THIRUVANANTHAPURAM.

The state government has extended the suspension period of IAS officer Prasanth N by 120 days, effective from 10 January, following recommendations from the suspension review committee.

rasanth, who had failed to reply to the charge memo served on him, has been granted 15 days to submit his response. The IAS officer was suspended from his role as Special Secretary in the Agriculture Department in November last year for making social media posts against his senior, Additional Chief Secretary A. Jayathilak, and former Industries Director K. Gopalakrishnan.According to the charge memo, Prasanth had attempted to "build a narrative against other IAS officers among



the public" and tarnish the reputation of the government. The memo concluded that Prasanth's actions, including attempts to justify his stance through the press and social media, constituted a breach of the All India Services (Conduct) Rules, 1968.In an earlier move, Prasanth had served a legal notice through his counsel to Chief Secretary Sarada Muraleedharan, A. Jayathilak, and K. Gopalakrishnan.Meanwhile, the suspension review committee has revoked the suspension of IAS officer K. Gopalakrishnan, who was embroiled in a controversy regarding the creation of a WhatsApp group allegedly formed on religious lines. The committee observed that there were "no substantive grounds necessitating the continuation of the officer under suspension" and recommended that the disciplinary authority lift the suspension pending finalisation of disciplinary action.In another development, Principal Secretaryrank IAS officer B. Ashok has been relieved from his position as Agriculture Production Commissioner and Agriculture Secretary.

## The pitfalls of elevating CDS to five-star rank

An incipient debate is underway in defence and security circles on further streamlining the stature and responsibilities of the Chief of Defence Staff (CDS). The CDS was first appointed five years ago to construct jointness and integration amongst the armed forces. One of these deliberations centres on whether the CDS should be accorded the rank of a five-star officer to elevate his authority and reinforce his role at the apex of India's military hierarchy. The current CDS, General Anil Chauhan, and Gen Bipin Rawat before him were four-star appointees three service chiefs. Proposals to upgrade the rank are aimed at enhancing its operational clout and aligning its standing with international practices.

India has traditionally reserved five-star ranks for those who have rendered extraordinary military service, like Field Marshals Sam Manekshaw and KM Cariappa and Marshal of the Air Force Arjan Singh. Consequently, a cross-section of service veterans argues that bestowing such an elevated status upon a CDS might just end up 'diluting' its exclusivity during peacetime. But the possibility of such an event transpiring anyhow augurs a mix of opportunities, challenges and many implications for the armed forces and civil-military ties. The CDS' position came into being nearly two decades after the Kargil Review Committee recommendations, which emphasised the need for a single-point military adviser to the government and to forge military 'jointness'. The CDS also doubles as the Permanent Chairman of the Chiefs of Staff Committee in addition to heading the Department of Military Affairs, established under the Ministry of Defence (MoD). Additionally, he executes numerous other tasks, like force modernisation and prioritising materiel purchases. However, despite these myriad responsibilities, the CDS is equal in rank to the service chiefs, albeit deemed the first among equals. Many insiders believe that this creates internal and, at times, antagonistic ambiguities in his authority. Hence, elevating him to a five-star rank could provide the CDS overarching clout to enforce decisions across the services and augment his capacity to ensure smoother execution of joint operations and reforms, particularly in the ongoing endeavour of establishing Integrated Theatre Commands (ITCs). The inference is that as a five-star officer, he could mitigate interservice rivalries and be an effective interlocutor between the armed forces and political leadership, ensuring that military advice featured adequately in governmental strategic decisions.But such an elevation is not without complications and the potential of disrupting delicate service hierarches, which are still in the process of familiarising themselves with a CDS. Perforce, it would generate further trepidation among the three service chiefs. They would perceive it as a further diminishment of their long-established autonomy which, in any event, was likely to be notably reduced merely to recruiting and training of manpower and providing logistic support under the proposed ITC model, at present under governmental review. Consequently, many veterans, fearful of a rupture in inter-service cooperation, maintain that the challenge in this regard lies in ensuring that a higher ranked CDS does not morph into 'over-centralisation' of power, thereby endangering collaborative decision-making. Many argue that this needs political oversight and sagacity on the part of both the government and Opposition, which though presently non-existent, could emerge in the future with tactful management. Critics of creating a fivestar CDS argue that such an elevated rank would operational effectiveness. This, in any case, would be managed by ITC heads, who, too, are expected to be four-star officers. The naysayers also contend that the CDS' ability to institute reforms and foster integration depends less on his stars and more on institutional support, consensus-building, resource allocation and political will. And, though a five-star designation would add lustre to the post, it could also detract focus from the substantive challenges of swift modernisation that confronts India's military.

### Perils of a Chinese mega dam

#### India must seek suspension of work until there is mutual understanding about the project

XINHUA reported on December 25 that the Chinese Government had approved the largest-ever hydropower project in the lower reaches of the Yarlung Tsangpo river in Tibet. This announcement, reportedly made without informing India, a lower riparian state, is a reminder of the complexity of rebuilding relations with the northern neighbour. The proposed project, under preparation for several years and closely tracked by India, has major negative implications for India. As an upper riparian state, China has an unfortunate record of reluctance Equally, there will be an ever-present danger of to cooperate, show transparency and safeguard interests of downstream states, as it is obliged to do.

We have, therefore, another major irritant emerging in an already difficult relationship.Xinhua lauded the venture as a "green project" without offering details. However, a report in Hong Kong-based South China Morning Post (SCMP) said the total investment in the dam could exceed 1 trillion yuan (\$137 billion). It is expected to generate nearly 300 billion kilowatt-hours (kWh) of electricity annually, more than thrice the designed capacity (88.2 billion kWh) of the Three Gorges Dam in China, presently the largest in the world.

According to the SCMP report, this would be the world's largest infrastructure project and involve drilling four to six 20-km tunnels and diversion of half the river's flow. Yet, the Chinese Foreign Office spokesperson claimed that it would have no negative impact on downstream countries (India and Bangladesh)!The proposed project is likely

to be at a site in the Big Bend area of the Yarlung Tsangpo, where the river takes a U-turn and enters India just over 20 km downstream. The adverse consequences of the project for us will manifest in many ways. It will disrupt water flows in the Siang, as the river is called after entering India and is the main channel of the Brahmaputra river system. According to an Assam Government website, the catchment area of the Brahmaputra is 2,93,000 sq km in Tibet; 2,40,000 sq km in India and Bhutan; and 47,000 sq km in Bangladesh. The bulk of the waters of the river flowing in India are generated within our territory, but this mega project will significantly impact the river flows and consequently, livelihoods of residents downstream. This writer recalls emergency management by a group headed by the Cabinet Secretary when an artificial lake had formed in 2004 on the Parechu river, a tributary of the Sutlej, in Tibet.

Given the relatively good relations with China at that time, we could get advance notice and data, augmented by information generated by our geospatial resources and other means. The lake did not burst before freezing over, and drained partly the next year with only limited damage downstream in India due to preventive measures. Risks stemming from the planned project will be exponentially

larger, even if we do not talk of weaponisation of stored waters, as some experts are doing. It is with patient diplomacy that we have been able to put in place limited collaborative arrangements with Beijing, including three memoranda of understanding (MoUs) on the provision of monsoon season data by China for the Brahmaputra, on monsoon season data for the Sutlej (signed after the Parechu scare) and on "strengthening cooperation on trans-border rivers". The first two MoUs are renewed every five years and have now lapsed. No project has been possible under the umbrella MoU. The Chinese are niggardly in extending cooperation,

> not even agreeing to provide lean season data, let alone discussing broader cooperation like sharing of waters of trans-border rivers.A similar approach characterises China's dealings on trans-border rivers with other neighbours. It takes full advantage of its status as a predominantly upper riparian state vis-à-vis its coriparians. Neither China nor India is a signatory to the United Nations Convention on the Law of the Non-Navigational Uses of International Watercourses (1997). However, two key principles of the Convention — "equitable and reasonable utilisation" of shared waters and the "obligation not to cause significant harm" to downstream states — have broad

relevance. India has been a responsible upper riparian state, even providing generous terms to Pakistan under the Indus Waters Treaty despite troubled bilateral relations. Unfortunately, the same cannot be said of China.

A spokesperson for the Ministry of External Affairs remarked on January 3, "As a lower riparian state with established user rights to the waters of the river, we have consistently expressed, through expert level as well as diplomatic channels, our views and concerns to the Chinese side over mega projects on rivers in their territory. These have been reiterated along with the need for transparency and consultation with downstream countries following the latest report."

This redefinition of eligibility dilutes the academic integrity of university leadership. While the draft abolishes the outdated quantitative Academic Performance Indicator (API) system, replacing it with qualitative assessments, the implementation remains opaque. Criteria such as innovation, societal contributions and digital content creation are commendable but lack clear evaluation mechanisms, opening the door for favouritism.

t is argued that these changes will foster flexibility and inclusivity, yet the draft's rushed timeline for feedback — 30 days — raises concerns about genuine stakeholder engagement. Such sweeping reforms demand careful deliberation to safeguard academia from being reduced to a political battleground or a marketplace for short-term contracts. India's higher education institutions are pillars of intellectual and

cultural progress. The UGC must ensure that reforms strengthen, rather than erode, their academic foundations. Anything less risks undermining the very purpose of education.

### India needs its own Draghi report

### We should assemble our best economists & diplomats to work on our 'foreign economic policy'

European Union (EU) has turned the spotlight on its readiness to adapt and succeed in a world already in the throes of unprecedented and wide-ranging change. It commissioned a former president of the European Central Bank, Mario Draghi, to prepare a comprehensive report on 'The Future of European Competitiveness', which was released in September 2024. Its Part A is a summary, while there is a detailed Part B running into more than 320 pages. I have read Part A and my comments are based on that document. It is for our accomplished economists to read and digest the longer document, which contains rigorous analysis based on detailed data.

In presenting the document to the European Commission, Draghi explained the backdrop to its preparation: "The starting point is that Europe is facing a world undergoing dramatic change. World trade is slowing, geopolitics is fracturing and technological change is accelerating. It is a world where long-established business models are being challenged and where some key economic It should come as no surprise that Draghi urges dependencies are suddenly turning into vulnerabilities."These words well define the challenges that India, too, confronts today. The election of Donald Trump as US President has heightened these risks significantly.

Draghi is brutal in his diagnosis of why Europe, despite its advanced economy, intellectual capital and sophisticated finance and banking sectors, is falling relentlessly behind the US and China. It suffers from an innovation gap, it no longer leads in cutting-edge technologies and is dependent on critical minerals and inputs from a relatively small number of source countries, with which the EU is "not strategically aligned". In a contested become vulnerabilities, threatening the security and compounded by demographic decline, which immigration is not able to offset. In any event, immigration is politically toxic.

The report focusses mainly on how the EU compares with the US and China in respect to various metrics of development, but centred on technology as its key driver. Draghi says that EU has missed the digital revolution and is falling behind in artificial intelligence. It has maintained its lead in clean-tech, but China's challenge is unrelenting. It is interesting that Draghi proposes a possible trade-off in this sector: "China may offer the cheapest and most efficient route to meeting our decarbonisation targets. But China's state-sponsored competition also represents a threat to our productive clean-tech and automotive industries.'

autonomy of Europe. These challenges are Why is it important to study this report and follow its implementation?One, India has all along seen an integrated Europe as a potential and relatively autonomous pole in its preferred multi-polar world order. A powerful Europe, exercising relatively



independent agency in world affairs, would be a better prospect for India than a bipolar world dominated by the US and China. There would be a strong incentive for India and the EU to work closely together to sustain multi-polarity.

Two, how can India locate itself as a key component in the "foreign economic policy" proposed by Draghi? India does not figure at all in the report. It is not seen as a possible partner in the EU's quest to stay relevant

in the emerging world order. And yet in terms of each component of this policy, India could be a significant partner. There could be partnerships in building up stockpiles of critical minerals or in scaling up cleantech. The Global Capability Centre model could work with European entities as well as it has with the US. Three, in clean-tech, India has ambitious plans

> for scaling up its renewable energy sector, including a future hydrogen economy. In addition to its strengths in clean-tech, the EU has a significant electrolyser industry that could boost this potential energy source of the future. The Draghi report could be the basis for working together with the EU to identify areas where synergy is possible, benefiting both sides.For India, Europe will remain a significant source of both technology and capital as it pursues higher but quality growth. If a trade-off to dependence on China is an option, surely India can offer that trade-off.

Finally, I think India should undertake its own economic strategy exercise on the lines of the Draghi report. We need a

critical evaluation of our current economic and market strategies to determine whether they are aligned to the nature and scale of challenges that we will confront, just as the EU will. One should assemble some of our best economists and diplomats to work on our own "foreign economic policy". Flying blind in the gathering storm may stall India's growth story and, in the process, increase our geopolitical vulnerabilities.

### Outdoor classes make students more open to learning: study



Teaching science subjects outdoors instead of within closed classrooms can increase students' motivation to learn and participate, a study has found. The study by the Technical University of Munich (TUM) and the University of Mainz advises offering more outdoor instruction at the lower secondary level. About 300 students participated in a programme called "researcher weeks" aimed at getting pupils excited about the natural sciences.

Students were prepared for a one-week stay in the classroom. This was then continued on site during the research week, culminating in a two-day research expedition with experiments. Both before and after the course, the students completed a questionnaire on their satisfaction and overall motivation. At the end of the week, the students again shared their experiences during the outdoor class. Basic psychological needs to experience autonomy and competence as

well as positive social relationships exert the primary influences on motivational behaviour, researchers said.

The study showed that motivational behaviour in both contexts was influenced equally strongly by these three needs,

albeit at different levels. Basic needs are met to a significantly higher degree during outdoor instruction than in the classroom. A sense of achievement particularly increases motivation during outdoor instruction. On the other hand, the studentteacher or student-student relationships had little or no influence on this increase. Nor did gender have any influence on the

The study, published in the journal Frontiers in Psychology, found that outdoor instruction with explorative learning methodology significantly promotes the attitudes of students toward learning, ie. their intrinsic motivation. 'Explorative' means nothing more than simply giving students the freedom to discover the subject matter through independently organised experiments. These outdoor dynamics, which provide a strong boost to more situational interest for science and engagement with the subject, can be evoked in occasional

teaching is an appropriate strategy to meet the

challenges of the 21st century," said Ulrich Dettweiler, associate professor at the University of Stavanger in Norway.

"Such models might even be suitable to bridge the existing gap between science education and environmental education in the long term," said Dettweiler, who was at TUM at the time of the study.



### Supreme Court says no third attempt for JEE (Advanced), but leeway for dropouts

granted relief to students who challenged the decision to reduce the number of attempts for the Joint Entrance Examination (Advanced) from three to two, ruling that petitioners who dropped out of their courses between Nov. 5, 2024, and Nov. 18, 2024. will be allowed to take the exam. However, the court refused to interfere with the decision of the authorities to reduce the number of attempts for JEE (Advanced). Senior Advocate K Parmeshwar, representing the petitioners, argued, "Initially, it was decided to allow three attempts, but within thirteen days, it was revoked, which is arbitrary. On Nov. 5, you held out a promise that students would be eligible. Decisions have been made based on that, which are irreversible.'

Solicitor General Tushar Mehta, appearing for the Joint Admission Board (JAB), defended the move."The decision was taken after it was found that students who had enrolled in regular engineering courses were focusing on JEE exams instead of their B.Tech



coursework. This decision was made in the students' interest and is a pure policy decision," he told the bench.

After hearing the arguments, a bench of Justices BR Gavai and Augustine George

Masih noted: "In the press release dated Nov. 5, 2024, a clear promise was made to students that those who appeared for the Class 12 exam in 2023, 2024, and 2025 would be eligible for JEE (Advanced). If

withdrew from their courses believing they would be entitled to appear, the withdrawal of this promise on Nov. 18, 2024, cannot work to their detriment." In the peculiar facts and circumstances, without commenting on the merits of JAB's decision, students who withdrew from their courses and dropped out between Nov. 5, 2024, and Nov. 18, 2024, will be permitted to register for JEE (Advanced)."The court clarified that it was not questioning the wisdom of the authorities. "For valid reasons, if respondent No. 2 [the JAB] restricted the zone of consideration to two years instead of three, no fault could be found with it," the order stated. The court's order came in response to a plea by aspirants challenging the reduction in the attempt limit for JEE

On Nov. 5, 2024, the JAB announced that students would be allowed three attempts at the exam. However, just 13 days later, on Nov. 18, 2024, the decision was reversed, reducing the attempt limit to two.

### Why blinding fog paralyses North India every winter

North India is engulfed in blinding fog, causing flight delays, train disruptions, and accidents. Let's discuss why the region experiences dense fog every winter.

NEW DELHI. On Friday morning, Delhi and its surrounding areas were enveloped in one of the densest fogs of the season. Satellite imagery revealed the entire Indo-Gangetic Plain-encompassing parts of India, Pakistan, Nepal, and Bangladesh--blanketed by a thick layer of fog. This recurring phenomenon occurs annually as winter arrives in the region each December and January. Here are six main reasons why the Indo-Gangetic Plain experiences dense fog every year, leading to reduced visibility and disruptions.

Temperature Inversion: During winter, the nights are longer, and the ground cools down quickly, especially in rural areas where there is less urban heat island effect. This cooling leads to a temperature inversion where the air near the ground is colder than the air above it, trapping moisture and pollutants close to the ground.

High Humidity: The proximity to the Himalayas and the rivers like the Ganga, the Yamuna, Brahmaputra, and Indus means there's a high level of moisture in the air. When the temperature drops, the relative humidity increases, leading to condensation and fog formation. Western Disturbances: Occasionally, western disturbances (moisture-laden systems from the Mediterranean sea) move into north India, bringing cooler air and sometimes rain, which can further contribute to foggy conditions by adding more moisture.

Stagnant Air Masses: The region often experiences calm or very light wind conditions in winter, which do not disperse the fog. For example, on Friday the wind speed was less than 4 km/h in Delhi. The lack of wind means that the fog does not get blown away but instead lingers over the area. Air Pollution: High levels of pollution from various activities including vehicular emissions, industrial pollution and agricultural burning (like stubble burning in parts of Punjab and Haryana) contribute to the formation of dense smog, which is a combination of smoke and fog. Pollutants act as condensation nuclei around which water droplets form, enhancing fog density.

Topography: The Indo-Gangetic Plain is a vast, flat area surrounded by the Himalayan range to the north. This topography can trap moisture and pollutants, reducing the flow of air which would otherwise dissipate the fog. In addition to causing significant disruptions in transportation, particularly affecting air, rail, and road travel, the fog also poses health risks due to its interaction

NEW DELHI. Work 70 hours, even 90, don't take an off on Sundays and definitely don't work from home. CEOs of major corporations often take to the internet to share advice on being the employee of the month. Recently, SN Subrahmanyan, Chairman of Larsen and Toubro (L&T), joined the league of honchos who want Indians to work more. Well, Indians are the world's second-most overworked people, according to International Labour Organisation (ILO).

Subrahmanyan sparked a controversy by advocating for working even on Sundays. Questioning how people spend their Sundays, he made remarks that have led to debates about India's work culture." I regret that I am not able to make you work on Sundays. If I could make you work on Sundays, I would be happier," Subrahmanyan said during a meeting with employees. He further asked, "What do you do sitting at home? How long can you stare at your wife?"

CEOs and chairman's of big corporates, such as Infosys co-founder Narayana Murthy, who advocated for a 70hour work week. Even Tesla's boss, Elon Musk, has been a strong proponent of all work and no play. But Indians are paying a heavy cost for overworking.

#### HOW INDIANS OVERWORK, PAY WITH BURNOUT

India's work culture comes with significant consequences. Reports indicate that Indians are among the most overworked people in the world, with burnout rates alarmingly high.Actor Deepika Padukone addressed this issue on social media, criticising such statements for their potential impact on mental health.She posted, "Shocking to see people in such senior positions make such statements. #mentalhealthmatters (sic).

This is true for a country which is the second-most overworked.According to the International Labour Organization (ILO), India ranks as the second most overworked country globally, with 51% of employees working 49 hours or more per week.

The ILO recommends a maximum 48-hour work week, with no more than eight hours a day. However, many Indians far exceed these limits. Indians have also reported burnout symptoms.A 2023 survey by the McKinsey Health Institute revealed that 59% of Indian respondents reported burnout symptoms-the highest rate globally. Moreover, 62% of Indian workers reported experiencing workplace exhaustion, the highest among all countries surveyed.

### Supreme Court Pauses Rs 746 Crore Fine On Rajasthan Over Waste Management

New Delhi. The Supreme Court on Friday stayed a hefty penalty of Rs 746 crore levied by the National Green Tribunal (NGT) on the Rajasthan government over noncompliance with waste management regulations.A division bench, comprising Justices Abhay S Oka and KV Vishwanathan, heard the matter.

Additional Advocate General Shiv Mangal Sharma informed that the NGT had not only directed payment of ₹113.10 crore within a month but also issued show cause notices for prosecution against the Chief Secretary and Principal Secretary/Additional Chief Secretary of Urban Development. He argued before the Supreme Court that the



penalty was arbitrary and ignores significant compliance made by the state.The decision, Mr Sharma argued, caused widespread concern in the state government, which was working seriously to ensure compliance with environmental regulations. He also informed the court that the state has invested Rs 4712.98 crore in liquid waste crore in solid waste management since 2018.

The bench acknowledged the efforts of Rajasthan and said that such a huge financial penalty and the possibility of criminal prosecution may hamper the environmental protection efforts of the state.

The fine was imposed on September 17 last year. The NGT had highlighted the state's

gross negligence in handling environmental concerns related to untreated waste, adding that it poses serious risks to public health and ecological balance. The tribunal found that the state generates approximately 6,523 tons of solid waste daily, yet only 63.19 per cent of this waste is properly processed.

### How strong is the Indian passport on Henley Index topped by Singapore's

The strength of a passport indicates the number of destinations its holders get visa-free access to. India's ranking in the Henley Passport Index 2025 dropped to 85 from 80 in 2024. This is how others stack up.

New Delhi. The strength of India's passport dipped five places to land at the 85th spot in the recently released Henley Passport Index. The strength of a country's passport indicates how many countries allow its holder visa-free access.India shares the 85th spot on the Henley Passport Index with Equatorial Guinea and Nigeria. Indian passport holders, like those of the other two countries, get visa-free access to 57 destinations. The Singapore passport emerged the topper on the index, with Singaporeans getting visa-free access to 195 destinations.

Japan's passport was the second-strongest, with Japanese citizens getting visa-free access to 193 destinations. The third spot was shared by six countries -- Finland, France, Germany, Italy, South Korea and Spain -- with their respective passport holders getting visa-free access to 192 countries. The Henley Passport Index ranks 199 countries, using exclusive data from the International Air Transport Association (IATA), the India's ranking, which moved up from 84th largest, most accurate travel information database.

#### WHERE DO THE BRICS COUNTRIES STAND?

Among the original BRICS countries, Brazil is ranked 18th, with Brazilians getting access to 171 destinations without



prior visa, Russia at 46th (116 destinations), China 60th (85 destinations) and South Africa 48th (106 destinations). China is also among the big gainers. Its passport has jumped from 94th place in 2015 to 60th now.

in 2023 to 80th in 2024, dipped to 85th in 2025, on the Henley Passport Index.India's passport was ranked 71st most-strongest when the ranking began in 2006. It dipped to the lowest ever (90th) in 2021, a year that saw Covid lockdowns and travel restrictions. Other

The US passport is in the ninth position with Americans getting access to 186 visa-free destinations. It was ranked No 1 in 2014.In fact, the US passport is the second-biggest loser after Venezuela's. The UAE is the only Arab country in the Top 10 on the Henley Passport Index. The UAE passport is ranked 10th and its holders get visa-free access to 185 destinations.

At the 106th spot, Afghanistan is at the rock bottom of the list. People of the Talibanruled country get to travel to just 26 destinations without prior visa approval.

Neighbouring Pakistan's passport is ranked 103rd, with Pakistanis getting visa-free access to 33 countries. Interestingly, in a recent meeting with India's foreign secretary, Afghanistan's acting foreign minister requested New Delhi to grant visas to Afghans for education.

Every plant is different and while some need a good amount of water, others need their soil to dry out between watering sessions. A common mistake people make is to water the plant every day, which could inadvertently kill some types of plants.

Since you might often give your plant too much water, be sure to create a proper draining system in the pot. The best way to do this is to have a layer of pebbles of around 2.3-four cm at the bottom of the pot. The pebbles will keep the roots of the plant away from any excess water at the bottom of the pot. If the plant is placed in the balcony, you could even buy a pot that has a draining hole.

#### **Dust the leaves**

Make sure you don't let dust settle on the plant's leaves because if too much dust gathers, your plant could have difficulty in breathing. You can fix this problem by taking a soft towel or a paintbrush and sponging both sides of the leaf each week.



### How to store your boots

Give your boots a scrub. If they have stains, use a soft-bristled toothbrush and a solution of water and vinegar to remove them. Use a leather cleaner to clean any remaining spots.

He said attrition is within its comfort range and going forward, they anticipate reduction in the quarterly attrition.

He said the company continues to invest in employee upskilling and overall well-being. Speaking about the new government in the US, K Krithivasan, chief executive officer and managing director, said once the government comes, the policies will be clear."We expect discretionary spending to pick up in healthcare and manufacturing. We are waiting for some clarity," he said.

Meanwhile, the company also announced its proposed acquisition of two wholly owned subsidiaries of Tata Realty and Infrastructure Limited-TRIL Bengaluru Real Estate Five Limited and TRIL Bengaluru Real Estate Six Limited-for Rs 1,625 crore.

The ministry has said that the discrepancy in the numbers was primarily due to migration of data transmission mechanism from SEZ to Indian Customs Electronic Gateway (ICEGATE)."...it was noticed as the system was calculating both imports into SEZ and subsequent clearance into Domestic Tariff Area (DTA) as separate transactions after the migration," a statement from the commerce ministry explained.It must be noted that the Directorate General of Commercial Intelligence and Statistics



(DGCI&S) on Wednesday revised India's India's gold import figure for November 2024 from \$14.8 billion to \$9.9 billion - a decline of 33%. For April-November, gold imports were revised 24% down from \$49 billion to \$37 billion. Revisions were also made in cases of silver (revised downward by 29%) and electronics imports (by 4%). According to the ministry, DGCI&S receives trade data from approximately 500+ locations and about 2.5 lakh transactions every day from different sea ports, land

ports, airport and inland container depots. The EXIM data from more than 100 SEZs was earlier captured by SEZ Online System and EXIM data for all other ports (non-SEZ locations) was captured by ICEGATE system. Both systems (ICEGATE and SEZ Online) were transmitting the EXIM data separately to DGCIS for publishing foreign trade statistics. After the decision to shift EXIM declarations from SEZ Online to ICEGATE system, the EXIM data pertaining to SEZs as well as all other ports is being captured and transmitted by ICEGATE to DGCIS. The ministry said that owing to persistence of certain technical glitches, the migration is still not complete. Both SEZ Online and ICEGATE are still capturing and transmitting mutually exclusive EXIM data to DGCIS.

### Iga Swiatek felt 'awkward' making excuses for absence during doping ban

**→** Iga Swiatek described her doping ban as the worst time in her life and revealed she had considered publicly disclosing her positive test for the banned substance trimetazidine but chose to wait until authorities resolved the case.

New Delhi .Iga ÅšwiÄ...tek, World no. 2 and five-time Grand Slam champion, has described the emotional turmoil and uncertainty she faced during her recent doping ban, calling it "the worst time in my life." Speaking ahead of the Australian Open, Swiatek revealed her struggles in dealing with the situation and the reasoning behind her decision to remain silent about the positive doping test until the case was resolved.Swiatek tested positive for the banned substance trimetazidine in August and was provisionally banned the following



month. During this period, she attributed personal matters and fatigue. However, it was later disclosed that her withdrawal was due to a one-month doping suspension after the International Tennis Integrity Agency (ITIA) confirmed the positive test. The Polish star denied knowingly taking the banned substance, explaining that it had entered her system through contaminated non-prescription sleep medication. Following her successful appeal, the ITIA accepted this explanation, allowing her to return to competition in October. Swiatek's provisional ban officially ended on December 4, factoring in time already served.

In her remarks to the Polish media, Swiatek shared her internal conflict about whether to publicly address the issue while the case was ongoing. "For a long time, when I was in Warsaw and couldn't play, I wondered if it would be better to say publicly what happened," Swiatek said. "But the truth is that with no source at the time and no decision from the ITIA yet, we would be only half-informing that I had a doping case, and that would have caused me more stress and problems."

### Australian Open: Defending champion Jannik Sinner still in dark about doping ban

New Delhi.Defending Australian Open champion Jannik Sinner revealed on Friday that he remains uncertain about the outcome of his doping case, which continues to loom over his preparations for his title defense at Melbourne Park.Sinner, who failed two drug tests in March due to low levels of the anabolic steroid clostebol, was initially cleared by an independent tribunal in August after the body accepted his explanation of unintentional contamination. However, the World Anti-Doping Agency (WADA) appealed the ruling at the Court of Arbitration for Sport (CAS) in September, leaving the Italian still facing the possibility of a two-year ban.

Speaking to reporters ahead of the Australian Open, Sinner admitted there was little clarity about the ongoing proceedings.

"I know exactly as much as you guys know. We're in a stage where we don't know many, many things," Sinner said. "Yeah, you think about this, of course. I would lie if I said I forget. It's been with me for quite a long time. But it is what it is. I'm here trying to prepare for the Grand Slam. Let's see how it goes."Despite the ongoing uncertainty, Sinner was able to keep his focus last season,



enjoying a standout year that saw him win his second Grand Slam title at the U.S. Open. The handling of Sinner's case, as well as that of Iga Swiatek, by tennis anti-doping authorities has faced criticism from some players, including Australian Nick Kyrgios, who called the situation a "horrible look" for the sport. However, Sinner refrained from engaging with Kyrgios or other critics. "I haven't done anything wrong," he stated. "That's why I'm still here, that's why I'm still playing. I don't want to respond to what Nick said or what other players say."Sinner begins his Australian Open campaign against Chile's Nicolás Jarry.

SWIATEK OPENS UPON DOPING World No.1 Iga Swiatek talked about the

struggles she went through amid the doping controversy she was involved in. Last year, the Pole served a one-month ban after testing positive for a banned substance, named trimetazidine (TMZ), which is used as a heart medication. Swiatek was provisionally suspended on September 12, 2024 before she missed three tournaments: the WTA 500 Hana Bank Korea Open, WTA 1000 China Open and WTA 1000 Dongfeng Voyah Wuhan Open. Recalling the tough times, Swiatek revealed that she was prosecuted and treated like a liar.

You can be at peace with yourself that you didn't do anything wrong, but no one actually treats you like that ... Especially the people that are kind of prosecuting you. Even when you're telling the truth, you feel like they treat you like a liar," Swiatek told Tennis Insider Club."I fought for everything so hard the past years. I was home at the time and still there were people coming for autographs or for a selfie. And I was like 'Well, are you going to do that in one month?" Swiatek
