Dozen illegally built houses demolished in antiencroachment drive in Jammu

Srinagar, Jan. 11: A dozen illegally built houses and four plinths were demolished in a major encroachment drive here on Saturday, leading to retrieval of 10 kanals of the land belonging to the Jammu Development Authority (JDA), a senior government official said. The successful drive was conducted by the JDA in close coordination with the Jammu Municipal Corporation (JMC), Jammu district administration and police at Sidhra, Majeen and Rangoora areas, the official said. He said the areas with large-scale recent encroachments, including Dingyali, Gulshan Nagar, and Asrarabad in revenue villages Majeen and Ragoora, Sidhra, were identified for the drive. Despite issuing notices or warning in such areas, the land mafia along with a team of contractors with labourers continued their activities. During the drive, 12 illegal houses and four plinths were demolished, retrieving 10 kanals of the JDA land on the spot, the official said, adding besides giving a strong message to all encroachers and other builders in the area that no one will get away with impunity. The drive was a success, not only in removing illegal encroachments but also in raising awareness among residents about the importance of knowing the procedure for carrying out construction on the land with clear title under ownership as the government or the IDA land shall be

Nagpur, Jan. 11: Amid a blame game over the Maha Vikas Aghadi's rout in the state assembly elections, key constituent Uddhav Thackeray-led Shiv Sena (UBT) on Saturday announced to contest local bodies polls solo, a move raising question mark over the opposition bloc's unity. Shiv Sena (UBT) leader Sanjay Raut cited the lack of opportunities for workers of respective parties in an alliance and the right to organisational growth as the major considerations for contesting solo. Two days back, the Uddhav Thackerayled party announced its support for Arvind Kejriwal's AAP in the February 5 Delhi Assembly elections, in a snub to the Congress. Reacting to Raut's announcement, a Congress leader said the party's central leadership will take a call on whether Congress will contest solo or otherwise in local body polls, the schedule of which is yet to be declared. Sharad Pawarled NCP (SP) said the Sena (UBT)'s decision will impact the poll prospects of all three constituents of the MVA coalition. Dark web, cryptocurrency, drones continue to be challenge: Amit Shah

New Delhi, Jan. 11: Union Home Minister Amit Shah said on Saturday that dark web, cryptocurrency, online marketplace and drones continue to be a challenge for the country and these have to be checked by strict measures. Chairing a regional conference on 'Drug Trafficking and National Security' here, Shah also asserted that the country will not allow even a single kg of drugs to be smuggled in or out of the country. He said the government has not only been successful in eliminating many networks of drugs, but the terrorism linked with them too was also destroyed. He said many cases of narco-terrorism were busted in Jammu and Kashmir, Punjab, Gujarat and Uttar Pradesh and these were major achievements. "The use of dark web, cryptocurrency, online marketplace, drones continue to be a challenge for us even today," he said. Shah said a technical solution to these problems have to be found through joint efforts by the states and the central government and technocrats for the country's security and development. He said the fight against drugs has gained a new strength under Prime Minister Narendra Modi's leadership. "In the last 10 years, there has been a sevenfold increase in the seizure of drugs which is a major

achievement. The Modi government has given a strong message of destroying the entire ecosystem of drugs through strict action," he said. The home min-



16,914 crore, the Narcotics Control Bureau (NCB) and police across the country took the biggest action against drugs, which is a significant step in making a drug-free society. "No country can move forward on the path of development with a young generation suffering from drug addiction. It is our responsibility that we all fight this challenge together and make all efforts to win this battle," he said. Shah said that during 2004-14, a total of 3.63 kg of drugs were seized while during 2014-24, altogether 24 lakh kg of drugs were seized - a seven-fold increase as compared to the previous decade. He said drugs worth Rs 8,150 crore were disposed off in 2004-14 but in 2014-24, drugs worth Rs 54,851 crore were destroyed -? eight times more than the previous decade. The conference, organised by the NCB, aims to address the growing concern of drug trafficking and its impact on national security, with a special focus on eight states and Union Territories of northern India. Shah also launched the drug disposal fortnight starting from Saturday to January 25. He said that during this period, one lakh kg of narcotics worth Rs 8,600 crore will be destroyed. The home minister also inaugurated the new office complex of the NCB's Bhopal zonal unit and extension of the MANAS-2 helpline to all 36 states and UTs. The main focus of the conference is on the sharing of real-time information from the National Narcotics Helpline 'MANAS' portal with the Anti-Narcotics Task Force (ANTF) of states and UTs, evaluating the progress of states in combating drug trafficking, and assessing the effectiveness of the Narcotics Coordination Mechanism (NCORD).

Raghubar Das rejoins BJP, vows victory in Jharkhand

Ranchi, Jan. 11: Former Jharkhand chief minister Raghubar Das on Friday rejoined the BJP here and asserted that the party will return to power in the state. Das had earlier resigned from the post of Odisha governor on December 24 last year to return to active politics after the party's debacle in the assembly elections, in which it failed to dislodge the JMM-led coalition from power in the state. Das was given a warm welcome into the saffron fold at the BJP's state headquarters in the presence of the party's state unit president Babulal Marandi, working president Ravindra Rai, Union minister Sanjay Seth, and hundreds of supporters. Speaking on the occasion, Das said that he was happy to take the membership of the party for the second time since 1980 and he would serve the people. He had to quit the party after assuming the position of the Odisha governor in 2023. "In the 2024 assembly polls, all party members, right from the state

president to booth level workers made their honest effort but we did not get the desired results. We should not be disheartened by the results. We will come back soon," Das said. The party faced a major setback in the 2024 Jharkhand assembly elections, managing to win only 21 seats, despite an all-out blitz. The JMM-led alliance stormed to power for the second consecutive term, winning 56 seats in the 81-member assembly. "People of Jharkhand have given their mandate to the alliance government. We respect the mandate and hope the government will fulfill the promises made to the people. We will give two-three months to them to fulfill their promises. If the government fails to do it, we will launch our struggle on the streets," he said. Das, who was the first nontribal chief minister of Jharkhand from 2014-2019, was appointed the governor of Odisha on October 18, 2023 after the party's defeat in the 2019 assembly polls in the state.

Kerala HC mulls ban on plastic bottles in hill stations

KOCHI. Kappad beach in Kozhikode, has once again earned the prestigious Blue Flag certification, Residents argue that the Blue Flag status has marking the fourth consecutive year it has achieved this honour. Awarded by the Denmark-based Foundation for Environmental Education (FEE), the certification signifies that the beach meets stringent international standards for cleanliness, environmental sustainability and safety.

This recognition places Kappad beach in an elite category of environmentally conscious and well-maintained tourist destinations, however, locals remain

sceptical about the tangible benefits of this accolade. The Blue Flag certification is awarded to beaches that meet 33 criteria under categories such as environmental education and information, water quality, safety and services, and proper waste and environmental management. Kappad beach underwent significant development in 2020, including installation of solar-powered lights, bio-toilets, and disabled-friendly pathways, to c o m p l y w i t h t h e s e requirements. While the Blue Flag certification is undoubtedly a

feather in Kappad Beach's cap, the challenge lies in translating this recognition intotangible benefits for the local community.

not translated into increased tourist footfall. While beaches like Varkala, Kovalam, and Marari have witnessed a steady influx of both domestic and international tourists, Kappad remains relatively underwhelming in attracting visitors. According to them, many potential tourists, even within India, are unaware of the Blue Flag certification and its significance. There has been minimal effort to promote Kappad beach as a Blue Flag destination, especially in global

markets. Moreover, limited public transport options and absence of direct rail or air connectivity make it challenging for tourists to visit Kappad. While the beach is clean, locals point out the lack of sufficient restaurants, accommodation options and recreational facilities that would entice travellers to stay longer. "We were hopeful that the Blue Flag certification would bring more tourists, but nothing has changed," says Rameshan Nair, a fisherman and longtime resident of Kappad. "We still struggle to find customers for our boats and stalls.

"The beach looks better, no doubt, but tourists don't come in big numbers. If they did, we'd all benefit," she said.

Kappad beach holds historical significance as the site where Portuguese explorer Vasco da Gama first landed in India in 1498. Despite the rich heritage, the beach has failed to capitalise on its historical and ecological appeal.Neighbouring states like Goa and Karnataka have successfully leveraged such certifications to boost tourism. For instance, Karnataka's Padubidri beach, another Blue Flag-certified

site, has gained popularity due to aggressive marketing campaigns and improved tourist facilities.

According to experts, without strategic investments in tourism promotion and infrastructure, the beach risks remaining a hidden gem, admired from afar but seldom visited. They suggest a multi-pronged approach to maximise the potential of Kappad beach by launching targeted campaigns highlighting the beach's Blue Flag status and historical importance, and introducing shuttle services from Kozhikode city and nearby airports. They emphasised ensuring local participation in tourism activities will help boost the

Customs probe revealed substantial cash deposits in the accused's bank account

CHENNAI. The Directorate of Vigilance and Anti-Corruption (DVAC) on Thursday registered a corruption case against a section officer in the Tamil Nadu Home Department for possessing disproportionate assets, suspected to have been amassed using proceeds from gold smuggling, involving her son, an Indigo Airlines staff member in Chennai. The DVAC's FIR alleges that S A Shahira Banu, an assistant section officer in the Goondas section of the Home, Prohibition and Excise Department, possessed disproportionate assets worth Rs 21.27 lakh during the check period between September 2021 and August 2024. The case stems from a letter dated August 9, 2024 by Chennai Customs to the Tamil Nadu government, following a probe into a smuggling case where 12.6 kg of gold worth Rs 8.5 crore was smuggled by Barkatullah, an Indigo Airlines staff member, at Chennai

Karnataka ASHA workers call off strike after CM announces Rs 10,000 monthly honorarium, incentives

BENGALURU. ASHA workers from across Karnataka on Friday withdrew their indefinite strike after Chief Minister Siddaramaiah announced a fixed honorarium of Rs 10,000 per month, effective from April, and that the government would consider their other demands.

The CM, after a detailed discussion with health department officials and representatives of the ASHA Union, confirmed that workers will get a fixed honorarium of Rs 10,000 per month. Additionally, workers will be granted incentives for the extra tasks they undertake as part of their duties. Another major outcome of the meeting was the provision of

three months of paid leave in the event of hospitalisation due to serious illness.Other decisions included the assurance of monthly leaves for ASHA workers and a commitment to review retirement compensation in the coming days. The announcement was made by Health Commissioner

CAG slams Karnataka government for poor monument conservation, fund misuse, staff shortages

BENGALURU. The Comptroller and Auditor General (CAG) has rapped the Karnataka government over preservation and conservation of monuments and antiquities. Nonutilisation of funds, encroachment of monuments, delay in digitisation, poor preservation, acute staff shortage and inadequate civic amenities are among the key issues, the CAG cited in its report.The report, "Performance Audit on Preservation and Conservation of State Protected Historical Monuments and Antiquities in Karnataka," was tabled in the state Legislative Assembly on December 12,2023.

Article 49 makes it binding on the state to protect every monument or place of object of artistic or historic interest from spoliation,

disfigurement, destruction, removal, disposal or export as the case may be, the



report stated. The shocking aspect was the inadequacies in utilisation of funds allocated for five years from 2017. The

report said, "As against the budget allocation of Rs 146.81 crore, the department utilised only Rs 81.58 crore towards core activities such as preservation and conservation. The remaining amount went towards administrative, maintenance and grants to heritage authorities."The primary function is to conserve and maintain heritage sites and only a small outlay needs to be spent on administration. However, 30% had been spent on administration, the report said.

Encroachments around monuments'

A sum of Rs 23.16 crore remained unspent, including Rs 7.9 crore meant for Shortage of caretakers years, the digital documentation of antiquities is in progress at the museum and the art gallery in Bengaluru. As against the budget allocation of Rs 13.3 lakh for e-documentation of all antiquities during the three financial years (2017-2020), the department incurred an

expenditure of only Rs 1.19 lakh during 2018-2019. There has been rampant encroachment on sites around monuments, the report said.

Though the department of archaeology conducted village-wise survey in 19 taluks under Samrakshane Scheme and identified 9,552 monuments, the same was not mentioned on the website. Conservation of Responding to the report, Ravi Korisettar, 239 paintings of Roerich at the Museum and Venkatappa Art Gallery in Bengaluru has not been completed as the expert committee responsible for clearance of payments has not been reconstituted by the government (until June 2022).

conservation works. Even after five Caretakers are responsible for the maintenance of protected monuments, including clearance of vegetation, cleaning, dusting, sweeping and regulating visitors. During a joint inspection, it was found that 72 monuments had no attendants, the report said. Moreover, there is a shortage of manpower (53%) in the

technical wing. As against 53 sanctioned posts, it has only 27. Thirty posts are vacant.

"The technical posts are essential for the upkeep of ancient monuments," the report said. "Though the department requested the government to fill vacant posts, it took no action," the report said.

archaeologist and adjunct professor at the Institute of Advanced Studies, said, "The annual grants earmarked should be utilised by the Department of Archaeology, Museums and Heritage, for conservation, excavation and public outreach activities. A Joint inspection of seven museums and one art gallery in six districts revealed the following instances of non-compliance. The government had given its response to each of these aspects, but the report said they were not satisfactory. CAG has recommended long-term, medium-term and annual conservation plans to protect and conserve the identified monuments.

Noida's air quality improves, but remains in 'poor' category

Noida. City's average air quality index showed a marginal improvement at 240 on Friday, from 259 recorded a day ago, but remained in the 'poor' category. While a thick fog shrouded the city in the morning, in some pockets, the AQI improved to 'moderate' level as the day progressed.

CPCB's data for air quality monitoring stations showed that at 4pm, the AQI at Sector 125 station was 195, which is in the moderate category. During the same period, the average AQI at Sector 1 station was 282 and Sector 116 was 224, both in the poor category. The readings of Sector 62 station were not available.In Greater Noida, the average AQI was recorded at 214, down from Thursday's 270. Knowledge Park V, which covers Greater Noida West, recorded 242 in the poor category, and Knowledge Park III recorded 175 in the moderate category.Ghaziabad too saw a marginal improvement with an AQI of 293 (poor), from 332 (very poor) recorded the previous day. , Indirapuram recorded 327 and Vasundhara recorded 305-both in the very poor category-while Loni recorded 258 and Sanjay Nagar recorded 222-both in the moderate category

Delhi's AQI deteriorated to 397 on the day, from Thursday's 357, both 'very poor'. A bulletin issued by Indian Institute of Tropical Meteorology (IITM) on Friday stated wind was blowing from the southeast with a speed of less than 6 kmph until evening. It dropped below 4km during the night.

Jewar CHC to start C-arm Xray & ultrasound facilities soon

Noida. A new C-arm X-ray facility will soon be inaugurated at the Jewar community health centre (CHC) in January. After the district hospital, Jewar will be the only govt CHC in the district where patients will get the facility of a C-arm X-ray machine in addition to ultrasound, officials said. Both machines were provided to the hospital through a CSR project at a cost of around Rs 35 lakh. These machines were installed by the Shipping Corporation of India (SCI), and a demo on how to operate them was given earlier in

"Earlier, patients used to visit either district hospitals or private hospitals for ultrasound. However, the distance from Jewar to Noida is very far. Thus, this facility will be a boon for all the residents of Jewar and nearby districts," said a senior official at the CHC.

According to doctors, at least 10 pregnant women visit Jewar Community Health Centre every day for checkups and delivery. However, due to a lack of facilities so far, many cases, especially those that were complicated, were referred to district hospitals or other private hospitals.

"Now we can easily diagnose with the help of the machines," said a doctor at the CHC. The facility will be available free of cost." Many times, accident victims have to undergo surgery if they have fractures in their arms and legs. With the help of a C-arm machine, surgeons can get information about the exact condition of the bone while performing bone surgery, which increases the success and quality of the surgery. This facility was also only available at the district hospital until now," a doctor said.

Meanwhile, the general X-ray machine, which was installed by the state govt in the CHC in May last year, is now in use."In the first week, the X-ray facilities were started, and we have already received several responses from the patients. The other two machines will also start soon," said the official.

8 months gone, repairs on Hero Honda Chowk flyover set to start next week in Gurgaon

Gurgaon. Brace for a jam at the congested Hero Honda (HH) Chowk as one side of the HH Chowk flyover will remain closed to traffic for the completion of repair work from the next week. Traffic on one side of the flyover will be restricted for over a month. Traffic coming from the Jaipur side and heading towards Delhi will be diverted through Dwarka Expressway.

This comes after DCP (Traffic) Virender Vij held a meeting with the officials of the National Highways Authority of India (NHAI) on Friday regarding the repair of the damaged portion of the Hero Honda flyover. The portion of the flyover has been damaged for the last eight months, affecting traffic movement and compromising the safety of commuters.

Recently, traffic police commented that in case of any untoward incident due to the damaged flyover, police would register a case against National Highways Authority of India (NHAI). On Friday, DCP (Traffic) Virender Vij inspected the flyover and NHAI claimed it would take around a month to complete the repair work.During the meeting, NHAI officials said they would need at least a month to complete the repair work."During the repair work, traffic on one side of the Hero Flyover will be restricted," the DCP said.

The DCP (Traffic) said a board would be installed for traffic diversion for vehicles coming from the Jaipur side and heading towards Delhi.

The cut under the flyover will also be closed. The DCP said traffic coming from the Jaipur side and heading towards Delhi will not use the flyover and instead use the surface road. Vehicles going to Delhi from Jaipur will be diverted through Dwarka Expressway to reduce the traffic flow at Hero Honda Chowk.

Traffic coming from Basai Chowk and Himgiri Chowk heading towards Manesar via Hero Honda Chowk will use the underpass, take a U-turn in front of Hero Company and head towards Jaipur. The damage was first seen in May last year when a 20-metre portion of the flyover sank in, prompting NHAI to cordon off one lane and deploy marshals there.

An expert committee subsequently recommended hiring a specialised agency to assess any structural problems and repairs.

2 Airtel managers held for issuing virtual numbers to cyber fraudsters abroad in Gurgaon

Gurgaon. Two Airtel managers were arrested for allegedly issuing virtual phone numbers to Indonesian and Chinese cyber fraudsters. Site inspection manager Neeraj Walia and his senior at Airtel's office in the city, Hemant Sharma, were apprehended following a complaint by a victim of cyber fraud. Officials at Airtel said the two employees were suspended.Probe into the case began last week when a woman alleged she lost Rs 10,000 to fraudsters who contacted her with a work-fromhome offer. The number used to call her had an STD code of Gurgaon. "The victim was initially paid Rs 200 for posting hotel reviews on a webpage. Later, she was added to a Telegram group and instructed to transfer money to various bank accounts. This was a prepaid task, for which she was promised high returns," said cyber inspector (east) Amit.

Although the victim's virtual account showed funds were increasing after each transfer, the fraudsters allegedly blocked when she attempted to withdraw the money.

A joint team of city police and personnel from Indian cybercrime coordination centre (I4C) traced the virtual phone number to a sham company -Ekamdarsh Services Pvt Ltd — whose documents showed the address somewhere in Dundahera. When cops visited the address, they found no such

company.Probe revealed the virtual number used to call the victim was issued by Neeraj and Hemant. "Neeraj handled site verification, which is a must for issuing phone numbers at Airtel. Hemant was his team leader. They issued a DID (direct inward dialling) virtual landline number to the fake company, violating TRAI regulations," said ACP Priyanshu Diwan, who led the investigation. The cops later came to



know that the duo had issued around 530 virtual numbers to one Indonesian company.

Several such numbers were provided to Chinese cons as well. Virtual phone numbers are issued by telecom providers to companies and call centres that need to make multiple calls to customers in a day. For instance, the number that flashes on your cellphone screen when you get a call from - say Uber or Zomato - is a virtual number. These numbers,



American, African American and woman as the Vice President of the country.In the summer of 2024, after a disastrous presidential debate with Donald Trump in Atlanta, Biden withdrew from the race and went ahead to endorse Harris for presidency. Harris soon became the Democratic Party's presidential nominee. However, Harris lost to Trump in the November 5th presidential election. Harris has not announced her future plans

Rudy Giuliani held in contempt of court over 2020 Georgia election lies

World. Former New York City Mayor Rudy Giuliani has been held in contempt of court for the second time in a week after continuing to spread false claims about two Georgia election workers, Wandrea "Shaye" Moss and her mother, Ruby Freeman. The pair previously won a \$148 million defamation case against him.US District Judge Beryl Howell in Washington, DC, ruled on Friday that Giuliani had violated orders prohibiting him from making defamatory remarks about Moss and Freeman. The judge ordered Giuliani to review trial evidence from the case and warned that he could face jail if he continued to flout the court's instructions.

The lawsuit stems from Giuliani's claims that Moss and Freeman engaged in election fraud during the 2020 presidential election. These accusations led to severe harassment and threats against the two women. "Mr Giuliani began lying about the plaintiffs in December 2020 and refused to stop, even after being repeatedly told his claims were baseless, malicious, and dangerous," said their lawyers, reported by Associated Press (AP).

During the hearing, Giuliani laughed and shrugged off the judge's remarks. Judge Howell, who was appointed by President Barack Obama, described his actions as "outrageous and shameful." She added, "This takes real chutzpah, Mr Giuliani."

Before the hearing. Giuliani criticised Judge Howell in a social media post, calling her "bloodthirsty" and biased. After the court session, he referred to the proceedings as a "farce" and called the judge "completely prejudiced", AP reported.

Although the judge did not impose an immediate fine, she warned Giuliani he would face daily fines of \$200 if he failed to confirm compliance within 10 days. This ruling follows a December 2023 jury decision, awarding Moss and Freeman \$75 million in punitive damages and an additional \$73 million in other damages. The pair testified that Giuliani's false claims caused them to live in fear, with Moss saying she rarely leaves her home and suffers from panic attacks. Giuliani's legal troubles continue to mount. Earlier this week, another judge in New York held him in contempt for failing to provide evidence in a separate case involving his Palm Beach property. He is also facing criminal charges in Georgia and Arizona related to efforts to overturn the 2020

India-US relationship where it stands today a significant achievement of Biden administration: Sullivan

We are continuing to work through that, and we've done that in a way that I think shows the maturity and depth of our bilateral relationship, while also standing up for our principles and our values," Sullivan said in response to a question.

Mark Zuckerberg orders removal of tampons from men's bathrooms at Meta: Report

World. Meta CEO Mark Zuckerberg has made sweeping changes to the company's policies in recent days. Among the reported shifts was the removal of tampons from men's bathrooms in the tech titan's offices, according to The New York Times

Facilities managers across Meta's Silicon Valley, Texas, and New York offices were instructed to remove tampons and sanitary pads, which had been provided for non-binary and transgender employees who might require them, two employees told NYT.

The move is seen as part of a broader effort by Meta to reshape its internal and external policies to align with the new political regime's values, a process described in the NYT article 'Mark Zuckerberg's sprint to remake Meta for the Trump era'. Earlier this



week, Zuckerberg announced the company would end its fact-checking practices and lift restrictions on speech across its platforms, including Facebook and Instagram, to "restore free expression"."Our content moderation practices have gone too far," Zuckerberg

By Friday, Meta had ended major diversity, equity, and inclusion (DEI) programmes and removed transgender and non-binary themes from its Messenger app, according to employees. The policy overhaul also loosened rules to allow posts containing statements of hatred against certain races, religions, or sexual orientations, as well as claims about mental illness based on gender or sexual orientation.

According to the NYT report, the changes have sparked internal discord. On Workplace, Meta's internal communication platform, employees in the @Pride group, which supports LGBTQ+ issues, voiced concerns. At least one employee announced their resignation, and others indicated plans to leave. Alex Schultz, Meta's chief marketing officer, reportedly defended the moves in a post to the @Pride group, saying that issues like Looser restrictions on speech in Meta's apps would allow societal debate, Schultz wrote, citing Roe v Wade, the landmark abortion rights law overturned by the US Supreme Court, as an example of issues being politicised instead of fostering public discourse.

In an interview with popular podcast host Joe Rogan, Zuckerberg denied that the changes were made to appease the incoming Trump administration but admitted that the election influenced his thinking."We got to this point where there were these things that you couldn't say that were just mainstream discourse," the Meta boss said.

The changes have been met with approval from President-elect Donald Trump and conservatives, censure from President Joe Biden, and concerns from LGBTQ+ advocacy groups about increased harassment online and offline.

Malaysian Doctors Fined Rs 11 Crore After One Left For Drinks, Leading To Woman's Death

World. Two doctors in Malaysia have been ordered to pay 6 million ringgit (Rs 11.42 crore) to the family of a woman who bled to her death after one of them left the hospital to grab a drink, according to a report in South China Morning Post (SCMP). Of the Rs 11 crore in damages, Rs 95 lakh was for the dead woman's pain and suffering, Rs 1.9 crore for each of her two children, and Rs 57 lakh for each of her parents.

Delivering the verdict, Justice Norliza



Othman said the two specialist doctors had failed to ensure that Ms Mohan was out of danger as she began to experience severe bleeding after her placenta was removed. Justice Othman added that although the nurses were not qualified by the health ministry, they were tasked with monitoring the patient's condition."The deceased's mother found that her daughter was bleeding heavily, and the nurses tried to

stop it by using cotton. The patient was later transferred to Hospital Tengku Ampuan Rahimah Klang (HTAR) in critical condition," read

Justice Othman added that the "tragic incident could have been prevented" if the two doctors had acted swiftly by "transferring her to HTAR and closely monitoring the patient's condition"."Instead of leaving her in the care of nurses while Dr Ravi went out for a drink. This level of neglect is unforgivable as it contributed to the death of a healthy mother," the judge

The judge pointed out that the two doctors failed to consider common complications associated with childbirth, such as eclampsia and placenta-related issues leading to postpartum haemorrhage (PPH).

Hush money case: US judge sentences Presidentelect Donald Trump, declines to impose jail term

NEW YORK. A judge sentenced Donald Trump to an unconditional discharge Friday for covering up hush money payments to a porn star despite the US president-elect's last-ditch efforts to avoid becoming the first felon in the White House.The judge spared Trump prison or a fine even though the 34 counts of falsifying business records on which he was convicted in May 2024 carried potential jail time.

Instead New York judge Juan Merchan handed down the mildest criminal sanction available, an unconditional discharge -- a relatively uncommon measure."Never before has this court been presented with such a unique and remarkable set of circumstances," said

The only lawful sentence that permits entry of a judgment of conviction without encroaching on the highest office of the land is an unconditional discharge."Trump attended his lawyers and media packed into the scruffy Manhattan courtroom that was the backdrop to the trial's high drama,



legal wrangling and vitriolic personal attacks by the divisive Republican."This has been a very terrible experience. I think it's been a tremendous setback for New York and the New York court system," Trump said before the discharge was passed.

Andhra issues tenders for Palnadu water grid project

GUNTUR. In a major relief for the droughtprone Palnadu region, the State government has invited tenders for the long-awaited water grid project. The Rs 1,200-crore project, funded jointly by the Union and State governments, aims to draw water from Nagarjuna Sagar and pump it to Vijayapuri South, ensuring safe drinking water for the region. The State government has issued tenders, which can be submitted online between January 10 and 24. Narasaraopet MP Lavi Krishna Devarayulu has played a pivotal role in securing necessary approvals and expediting the project. Although schemes like the Jal Jeevan Mission and AMRUT are progressing to provide tap connections to every household, the declining groundwater levels and high fluoride content necessitated the water grid project to ensure a sustainable and safe water supply for the people of

Wild animal fear: Forest fringe villages in Kerala face matchmaking crisis

Frequent news reports about wild animal attacks have created a stigma that has been discriminative and has devastated their lives.

KOCHI. The social sigma attached to gender bias, casteism, mental illness and poverty has been deeply rooted in our culture. However, the families living on forest fringes are facing another challenge.

The families are not ready to discuss the issue, but people are selling their landholdings at modest rates and migrating to towns nearby. But there are poor families with small landholdings who have no other option but to battle the wild animals and live in poverty. Who will dare marry off their daughters to areas where elephants Congres global director Fr Philip Kaviyil.

Real estate value has crashed, he says."It is not a simple issue. During Christmas, I visited a hamlet in Kannur where people said wild elephants are roaming the village day and night. However, they don't want to discuss the issue in public as it will affect their social lives. People have stopped venturing out after nightfall. Churches in forest fringe areas witnessed a lean crowd for Christmas midnight mass due to a fear of wild animals," he says. More than the decline in land vlue, it is the social impact of the wild animal menace that has devastated lives, says Rajesh, a farmer in Wayanad."As the news about wild animal attacks spreads, people stop visiting us and reject marriage proposals. People are ready to sell off their land and migrate but the prices have hit rock bottom. We will not be able to purchase a house with the price offered for our landholdings," Rajesh says.

The forest department has installed AI cameras, digital display boards and sirens in 12 hamlets to alert villagers about the presence of wild animals."After a few months, the digital display in a village was found damaged. During the probe, the villagers said the digital display and siren were stopping outsiders from visiting the village. They said people are refusing marriage proposals and the land value has declined," says a forest officer.



The human-wildlife conflict is more a sociocultural, economic and political issue which requires a deep debate, says Chief Wildlife Warden Pramod G Krishnan. "There are 750 human settlements surrounded by forests in Kerala. Those living in such settlements have to pass through forest stretches to reach the outside He says a lack of fodder drives elephants to world. Among the eight deaths reporting to be from wild elephant attacks during the past nine months, five occurred inside the forest. People should be cautious while moving through forest areas," he says.

Kerala has a 16,000km-long forest boundary and it is impossible to barricade the entire area, the officer says."A rail fence costs Rs 2.5 crore per km while the hanging solarpowered fence costs Rs 8 lakh per km. The human-wildlife conflict in Kerala is a complex issue and it needs a multi-faceted solution. We have to improve habitat quality and reduce human-wildlife interactions. Looking from a Kerala perspective, I feel the human-wildlife conflict is not just an ecological issue, as addressed with stress on the human angle," Pramod says.

From Urulanthanni in Kothamangalam to Chinnakanal in Idukki and Vadakkanad in Wayanad, people are fleeing the forest fringes because of the wild elephant menace.

"The social stigma caused by the elephant menace is a reality and the stories of the struggles of farmers are heartwrenching," says Kerala Independent Farmers Association chairman Alex Ozhukayil."There are multiple reasons for the increasing elephant menace, including forest degradation caused by the destruction of grasslands and the growth of invasive species."

Many villagers said agents of lenders allegedly harassed the defauters for not paying monthly installments and also not clearing their loans on

time. In some cases, children have discontinued their studies and joined their parents to work in farms and plantations in neighbouring districts and states, fearing the alleged harassment by the agents, they said. Mohan, a student, has appealed to the government to allow him to sell one of kidneys to clear the loan taken by his father. The agents abused his mother in foul



language whenever they visited their house, he alleged.

The agents also visited the houses of defaulters at night and allegedly harassed them in the presence of their children, the villagers said. People from Heggawadipura alleged that the microfinance companies disbursed loans at 24% interest. A few companies were run by some trusts. Companies from neighbouring

Tamil Nadu also operated in the district. The companies lend money not only to individuals, but also to women's self-help groups, they said.

Children of a few defaulters said that their parents sometimes spoke about committing suicide as they were unabe to repay their loans.Meanwhile, Deputy Commissioner Shilpa Nag has appealed to the defaulters not to leave their

villages. She said the defaulters may approach her or the assistant commissioner for help. They may also approach tahsildars or local panchayat officials. Four teams have been formed to visit villages and submit a report. The district administration has plans to hold special panchayat meetings to educate people, she said.

18-year-old reveals more than 60 people sexually abused her over five years

PATHANAMTHITTA. In a shocking revelation, an 18-yearold girl has said she was sexually abused by more than 60 people over the past five years in Pathanamthitta. She revealed the ordeal to the Child Welfare Committee (CWC) members, who in turn informed the police.According to the police, the initial investigation indicated that there are more than 60

accused, as stated by the girl.Elavumthitta police have so far arrested five accused in the case -Subin, 24, S Sandeep, 30, V K Vineeth, 30, K Anandu, 21, and Sreeni alias S Sudhi Sreeni, 24, all residents of Chenneerkara in Pathanamthitta. The girl identified 40 others who abused her from the photos on the mobile phones of the arrested persons. Police said when the girl was 13, Subin, a neighbour and the son of her father's friend, lured her by showing obscene visuals on his



mobile phone. He also took the girl's nude pictures on his phone. When the girl was 16, Subin took her to a secluded place in their locality and assaulted her sexually. He also recorded videos of the act on his phone. This was followed by regular sexual abuse, the police said.

The probe revealed that the visuals were shared among Subin's friends, who also abused her sexually. The girl, whose academic performance suffered following the repeated abuse, revealed the matter first before a women empowerment collective during a counselling session.

More accused to be identified as investigation progresses' Considering the seriousness of the

case, the collective informed the CWC. Following this, the girl, along with her mother, narrated the entire incident to CWC members.According to the police, the case, a rarest of rare among the POCSO (Protection of Children from Sexual Offences Act) cases due to the number of accused involved, will include SC/ST Act as the girl belongs to a scheduled caste community.A case has also been registered at the Pathanamthitta police station in connection with the incident. Police said more accused are likely to be identified as the investigation progresses in different stations. Among the accused, Sudhi is currently in jail in a POCSO case registered by the Pathanamthitta police earlier.

Karnataka HC orders re-exam for KPCL posts; calls post-test qualifying marks unfair

Setting a 50-mark minimum qualifying score after conducting the Kannada language test, despite the notification prescribing a maximum of 150 marks, is neither fair nor transparent, the HC observed.

BENGALURU. The Karnataka High Court has directed Karnataka Power Corporation Limited (KPCL) to re-conduct the Kannada language test for Junior Engineer (Mechanical) and Assistant Engineer (Mechanical) posts under the Hyderabad-Karnataka and Non-Hyderabad Karnataka quotas, citing the unilateral prescription of minimum qualifying marks postexam as a substantive eligibility alteration.

While the recruitment notification clearly prescribed a maximum of 150 marks for the Kannada

language test, the subsequent unilateral fixation of a minimum of 50 marks as qualifying marks after the examination that had already been conducted cannot be considered a fair or transparent action. It falls squarely within the first category Eligibility Criteria for Candidates Seeking Employment-and not the second category, which pertains to the method or manner of selecting suitable candidates. By introducing this qualifying criterion after the fact, KPCL has effectively changed the rules of the

game," the court said.Justice Sachin Shankar Magadum passed the order recently while allowing the petition filed by Geetha Chavan from Vijayapura district as her candidature was rejected on the ground that she scored 36 marks in the Kannada language test as against a minimum of 50 marks, which was fixed after conducting the examination which is contrary to the regulations Karnataka Power Corporation Limited Service (Cadre, Recruitment, Probation, Promotion and Seniority) Rules,



Why China has made new units in Aksai Chin

China has just announced the creation of two new counties in Xinjiang: He'an and Hekang. These counties will cover the entire Aksai Chin plateau, including the 38,000 square km area claimed by India. Hongliu (Dahongliutan) is being announced as the capital of He'an and Xeyidula (Shahidullah) of Hekang.On December 27, 2024, Xinhua reported that the decision to create two new counties out of Hotan (Khotan) and Pishan counties had been approved by the Central Committee of the Communist Party of China and the State Council. The move comes after the Indian and Chinese troops completed the disengagement process along the LAC on October 28, 2024. The reason for Khotan's division is not clear. Gaustana or Godaniya, which translates to 'land of the cows' in Sanskrit, is Hotan's original name. It was called Ling-yul by the Ladakhis and Yu-ten by the Chinese. Before the Chinese arrived here in the ninth and tenth centuries, Khotan was an important point on the Silk Road, with a flourishing Indian culture. It was the centre of the ancient Buddhist Saka Kingdom. Khotan was ruled by Mirza Abu Bakr Dughlat before Gazi Sultan Syed Khan established the Yarkand Khanate in 1510.Khotan became a county in 1913 after the collapse of the Qing Empire. In 1919, the Karakax/Moyu county was separated from Khotan. In 1933, Muhammad Amin Bughra, a local Amir, declared Khotan an Emirate. The People's Liberation Army entered Hotan on December 22, 1949. In 2013, a Muslim uprising in Hanerik resulted in the death of hundreds of people. The greater part of Aksai Chin, which includes the picturesque Aksai Chin Lake or Amtogor Tso, will be included in the new He'an county, with Hongliu as its capital. Southeast of the Lingzi-Thang plains is Surigh Yilganing Kol, also called Salikyaili Genzhi Tso, from where Indian nomads collected salt until the 1950s to trade with other areas. India's claims line encompasses the strategically crucial Tianshuihai, which is also called by Ladakhis as the Thalda Basin or Mapothang. Tianshuihai is situated east of the Lakh-Zang range and northwest of the Aksai Chin Lake, which separates the Aksai Chin plateau from the Lingzi-Thang plains in the south and the Kunlun plains in the north. The 1962 clash between India and China took place in these locations. Tianshuihai and Tianwendian are major military sites in the PLA area, which is traversed by China's G315 and G219 highways.

The LAC is situated near Hongliu town, which is also called Dahongliutan. The place was earlier a barren stop for trucks travelling on the G219 highway. The area has become a hot spot for rare metal mining due to the abundant resources of lithium, rubidium, beryllium, tantalum and niobium. The Chinese have been developing infrastructure to make use of the abundant pegmatite resource in Dahongliutan, which is believed to have more than 2 million tonnes of lithium. It's possible that Hongliu's new administrative town is being constructed to promote mining. There are almost no villages in the region. It is inevitable that Aksai Chin, which is uninhabited, will eventually be subjected to a colonising mission. With large-scale investments by China in infrastructure and mining, Han migrants could enter the area claimed by India. China is possibly aiming to turn this deserted and prone-to-war frontier area into an economic outpost by connecting it to the global network as part of the Belt and Road Initiative.

It appears that the Hekang county, with Xeyidula (Shahidullah) as its capital, is being created from Karakash (Black Jade) river flows north into Khotan and becomes closer to Karakoram. Shahidulla in the Karakash Valley was a vital point of entry and location for the British, Russian, Chinese and Kashmiri empires during the Great Game. The Hindu Tash region in the Kunlun range was the extent of India's dominance at that time. Sumgal (meaning "three fords" in Ladakhi), which used to be the main route between Karakash and Khotan, is located between the Hindu-Tash mountain and the Aksai Chin plains.

When the annals are compiled of how women entered the forbidding portals of the Indian armed forces, at first hesitantly, then with more confidence when they found that the judiciary was prepared to call the system's bluff, the names of a handful of courageous women will be right up there. Smartly dressed women leading parades at Rajpath, flying aircraft or serving in militancy-infested areas are seen as India's pride. They are frequently brought out on display during ceremonial occasions as evidence that women do have an equal opportunity of employment as enshrined under the Constitution.

Few, however, know of the odds they have battled to reach there. They have battled gender discrimination, patriarchy, prejudice, stereotypes and humiliation only because, as an honourable judge notes, "they were women."

The recent controversy over a leaked letter by a Corps Commander to his superior officer, the Eastern Army Commander, that contained adverse comments about the performance of eight women commanding officers under him give us a rude insight into what the Army's top brass really thinks about having women working alongside them in command and other assignments. The worthy general did not feel the need to do a similar evaluation of the 40-odd male commanding officers in his command. Be that as it may, the women corps will probably dismiss the general's slights with a wry smile because it is just one among the many hurdles they have overcome. The trajectory of women's participation in the armed forces has been charted in an anthology, appropriately titled 'In Her Defence'. It tells the story through essays and commentaries by jurists and academics. Edited by military lawyer Navdeep Singh and Shivani Dasmahapatra, it also busts several myths or 'urban legends', as advocates like to call the falsehoods that have grown around the issue. Chief among the falsehoods is that women have been clamouring for entry into frontline combat arms like the infantry or the armoured corps — areas that are barred for them as a matter of policy.

They have never done so. In fact, even the Supreme Court, which has pushed for gender parity in the armed forces, has desisted from interfering in the government's decision to keep women away from combat arms because "it was "conscious of the limitations of security and policy."So, what were the

A government notification of January 30, 1992 first made women eligible to become officers in some cadres, like the Army Postal Service, the Judge Advocate General's Department (JAG), the Army Education Corps (AEC) and some branches of the Army Ordnance and Army Service Corps. A year later, they began to be inducted into the Signals and Intelligence Corps as well as the Corps of Engineers, the Electrical and Mechanical Engineering and the Regiment of Artillery.

They were initially commissioned for five years and later, their service was extended to 14 years under the Women Special Entry Scheme, a Short Service



Commission (SSC) scheme. There is an SSC scheme for male officers, too, and some of them get permanent commission (PC), depending on their performance.In 2003, an advocate, Babita Puniya, through a public interest litigation (PIL) in the Delhi High Court, demanded that women appointed as SSC officers should be considered for PC, like their male colleagues. During the PIL's pendency, the government announced PC prospectively to women officers in only the JAG and AEC. Those commissioned earlier were excluded. Two serving officers, Major Leena Gaurav and Major Sandhya Yadav, joined the battle. The landscape of gender equality within the armed forces was about to change.In a landmark judgement, on March 12, 2010, the Delhi High Court, while upholding the women's contention, held that if women officers were deprived of PC while male officers were granted the opportunity for the same, it would be a violation of the principle of equality protected by the Constitution. The judgement was challenged before the SC by the Central government, but the SC did not stay its operation. The government dug in its heels for nine years, till February 2019, when it granted PC to SSC women officers in eight branches, with the caveat that they will be employed only in "staff appointments".

Another obstacle still lurked around the corner.

The SC found that the government's proposal to grant PC to women officers envisaged only those who had been in service for less than 14 years. Was it the women's fault that they had finished serving for 14 years and had to go home, while the government resisted implementing the Delhi High Court's 2010 order to grant them PC? The SC again cracked the whip and said that it was the Union government's

> failure to comply with the high court order, which had not been stayed by the SC. This forced the reluctant government to give PC to all women who had been employed as SSC officers and also opened the doors for them to assume command assignments.

But, hold on to the slow claps.

Around the same time, 17 SSC women officers of the Navy were also fighting it out for PC. One of the objections of the government before the courts was that as officers are required to serve on ships, it could not permit women to get PC

because "there is an absence of toilet facilities for

women" on board Naval ships!

Now that gender parity has been achieved, the real battle for women officers is to be prepared for gender-neutral norms, where they will be called on to deliver equal performance in all aspects of military service. For all these years, women officers have largely been seen as cosmetic appendages, handled with kid gloves and kept away from hard tasks, contributing to much angst among the male colleagues. Lt Col Anila Khatri pointed out recently how she was feted for doing 89 para jumps while male officers with more than 3,000 jumps found no mention. If viewed objectively, beyond the prism of women's rights, Lt Gen Rajeev Puri — whose letter created the controversy — was pointing out just that. He has recommended that there should be a policy on gender neutrality that covers postings and selections. "Gender neutrality lays emphasis on equality in dealing and progression irrespective of gender," he said in his letter.

Alcohol intake entwined with cancer risk

It's critical to guard against industry lobbies that try to stall health-related regulations

The new year has begun with a new health warning. America's Surgeon General Vivek Murthy has released an advisory, pointing to a direct link between alcohol consumption and increased cancer risk. Alcohol consumption is the third leading preventable cause of cancer in the US. Alcohol, the advisory says, increases risk for at least seven types of cancer (breast, colorectum, esophagus, liver, oral cavity, throat and voice box), regardless of the type of alcohol consumed. As much as 16.4 per cent of the breast cancer cases in the US are attributable to alcohol consumption. For certain cancers, such as breast, mouth and throat, the advisory warns that "the risk of developing cancer may start to increase around one or fewer drinks per day". Even small amounts of alcohol can contribute to chronic conditions like liver cirrhosis. An individual's risk of developing cancer due to alcohol consumption, however, depends on several biological, environmental and social factors. The advisory follows the 2023 statement of the World Health Organisation (WHO) on the risks and harms associated with drinking alcohol, based on a systematic evaluation of scientific evidence. Alcohol is responsible for a substantial disease burden directly, and accounts for a sizeable number of alcohol-related road accidents. The WHO statement published in The Lancet Public Health concluded, "When it comes to alcohol consumption, there is no safe amount that does not affect health."

Back in the 1980s, the International Agency for Research on Cancer classified alcohol as a 'Group 1 carcinogen'. This is the highest-risk category of cancer-causing substances that includes tobacco, radiation and asbestos. Ethanol causes cancer

through biological mechanisms as it breaks down in the body. Therefore, any beverage containing alcohol (be it beer, wine or whiskey) poses a health risk. In its statement, the WHO pointed out that the risk increases substantially with the amount of alcohol going up. This evidence busts the myth that some alcoholic drinks, particularly red wine, are beneficial for health if consumed in moderation. For decades, the alcohol industry has propped up cardiologists to promote the idea that wine in moderation is good for the heart's health without any credible scientific study to back such claims.On the other hand, data from the WHO's European Region shows that half of all alcohol-attributable cancers are caused by what is generally considered 'light' and 'moderate' consumption like a bottle of wine or two bottles of beer per week. As per the WHO, there are no studies that demonstrate beneficial effects of light and moderate drinking on heart disease or diabetes or studies that outweigh the cancer risk associated with such levels of consumption. Carina Ferreira-Borges, an expert on alcohol and illicit drugs at the WHO, has said, "The only thing that we can say for sure is that the more you drink, the more harmful it is. In other words, the less you drink, the safer it is." When there is scientific evidence about the ill effects of a commonly produced and consumed commodity that also yields substantial revenue for governments, what are the available options to reduce the harm? The WHO's statement on alcohol distils available scientific evidence and also presents policy options available to governments. It is for the governments to act. One of the most obvious options to reduce alcohol consumption is to make people aware of the potential

harm through warning labels on alcohol bottles. This is among the measures Murthy has suggested for the US and what some European countries are planning to do. Murthy has also called for a reassessment of the guideline limits for alcohol consumption to account for cancer risk.



The warning labels under consideration by various countries are of many types — with messages against general harm to health, harms of excessive use and abuse and those for specific groups (underage people, pregnant women, etc.). For instance, the warning Ireland plans to introduce in 2026 says, "Drinking alcohol causes liver cancer". In 2019, India mandated more generic warnings that say "Consumption of alcohol is injurious to health" for hard liquor and "Be safe, don't drink and drive" for low-alcohol beverages. Apart from warning labels, restrictions on alcohol marketing are in place in India. Alcohol advertising is banned in newspapers, radio and television, though surrogate advertising continues in many ways, taking advantage of loopholes in advertising regulations. In recent years,

surreptitious advertising through social media and digital platforms is posing new challenges. Like in the case o warnings on tobacco labels, industry and pro-industry groups argue that health warning labels are of little use in reducing consumption. But available evidence — as reported in a recent review published in The Lancet — points out that warning labels on alcohol products are useful in many ways. They can enhance awareness of alcohol-related harms, contribute to the denormalisation of alcohol use and help people make informed decisions, thereby promoting public health. The effectiveness of health labels depends on their design and content. At present, there is no standardisation of health warning labels and the content is very general, which may not help people make informed decisions. India has implemented regulations on warning labels on alcohol products for about five years now. We are yet to know how effective this exercise has been. We need continuous research on the design and content of warning messages, and consumer feedback on the same. Unlike tobacco products, where health warnings occupy a good part of the packaging and are more graphic, warnings on liquor bottles occupy tiny space and are vague. Along with health warnings, additional measures like regulation of alcohol sale on highways, curbing sale to underage consumers and drunken driving need to be implemented more stringently. It is critical to guard against industry lobbies that are constantly trying to stall health-related and other regulations in India. We need more champions of public health like Murthy to reduce the healthcare burden due to alcohol. Remember, the first warning on tobacco's link with cancer, too, came from a Surgeon General in 1964.



NEW DELHI. The Health and Family Welfare Department of the Delhi government has directed the recruitment of over 1,400 nurses and paramedical staff on an outsourced basis for its public hospitals, sparking controversy over alleged violations of the Model Code of Conduct (MCC). The order, issued on Thursday, mandates the recruitment of 701 nursing and 762 paramedical staff through outsourcing, utilizing third-party agencies. This comes at a time when the MCC is in force in the city, prohibiting government departments from floating new tenders or awarding work orders

without prior approval from the election authority."...the MS/MD/HOD of the departments, including hospitals/medical institutions, are directed to fill the vacant posts of nursing and paramedical staff on an outsourced basis from any Central/State PSUs



such as ICSIL, NICSI, BECIL, HLL, etc., by limited tender," the order copy accessed by this newspaper read. However, officials from the Chief Electoral Office, Delhi, flagged the move as a potential breach, citing the absence of any representation from the screening body before the order was passed.

The All India Government Nurses Federation (AIGNF) has strongly opposed the decision, criticising the government's preference for outsourcing critical healthcare positions. Anita Panwar, President of AIGNF, called the practice "dubious" and expressed concern over its long-term implications.

The government's decision to outsource nursing roles undermines the quality of healthcare and creates instability in the workforce. Outsourcing lower-level positions disrupts the feeder cadre necessary for promoting skilled staff to higher posts, which is vital for the smooth functioning of hospitals," Panwar said. She further pointed out that the practice violates a 2016 policy by the Ministry of Health and Family Welfare,

which prohibits outsourcing of nurses in hospital setups. "These outsourced nursing officers may lack essential skills, compromising patient care standards. The Delhi government is obligated to adhere to central rules on service matters," she added.

JNU fines 2 students Rs 1.79 allowing outsiders

New Delhi. Jawaharlal Nehru University (JNU) has penalised two hostel students for allegedly allowing outsiders into their rooms, consuming alcohol, and using hookah, among other violations -- the combined fines amounting to Rs 1.79 lakh. The students have been asked to deposit the fines within five days, as per official notices issued to them on January 8.

The first notice read, "12 unknown individuals were found in your room consuming alcohol and creating a disturbance on the hostel premises in your absence. This behaviour constitutes a serious violation of hostel rules."

A fine of Rs 80,000 has been imposed on the student, including Rs 60,000 for unauthorised entry of outsiders, Rs 2,000 for drinking, Rs 6,000 for possessing an induction stove and heater, Rs 2,000 for hookah use, and Rs 10,000 for aggressive behaviour, interference in official matters and intimidation of hostel staff. The second notice alleges that on December 22 last year and January 5, several outsiders were present in another



student's room, where alcohol was consumed. It further claims, "The Warden Committee and security personnel attempted to open your room at

that time, but you did not open the door." The student was fined Rs 99,000 -- Rs 85,000 for allowing unauthorised individuals on two occasions, Rs 2,000 for drinking, Rs 2,000 for possession of a hookah, and Rs 10,000 for aggressive and disruptive behaviour. Both notices caution the students that failure to pay the fines within the stipulated time could result in further disciplinary action, including eviction from the

'Any future complaints or violations will result in your immediate eviction from the hostel without prior notice," the notices warn. Former president of Sutlej Hostel, Kunal Kumar, criticsed the fines, calling them an act of extortion.

How toilets at home, cash in hand and literacy added 1.8 crore women voters

New Delhi. Small changes in everyday lives can provide a big boost to democracy. Implementation of women-centric social welfare schemes of sanitation, Mudra loans, literacy and housing, have helped crores of women to come out and vote in India, according to a new study. The 2024 Lok Sabha elections saw an additional 1.8 crore women voters compared to 2019, largely due to the rollout of womenfocused welfare programmes, according to a report by SBI Research. The study used data from the Election Commission of India.A 1% rise in literacy contributed 45 lakh more female voters, while house ownership, particularly under the Pradhan Mantri Awas Yojana, added 20 lakh women to the voter turnout.

We empirically establish that states have witnessed an incremental women voter turnout of 18 million (1.8 crore) in 2024 over 2019 primarily because of implementation of women-centric schemes, at least one or more, that also includes income transfer schemes, HOW WOMEN WELFARE SCHEMES

houses under the Pradhan Mantri Awas Yojana being owned by women, either solely or jointly.Sanitation schemes have contributed to around 21 lakh more female voters in the 2024 elections, showing a crucial role in shaping socio-political priorities.

While electricity access and improved drinking water accessibility show a positive impact on female voter turnout, their effects are not statistically significant, the report noted.Despite the encouraging

trends, the SBI Research report warned against unchecked expansion of welfare schemes. It recommended limiting welfare spending to 1% of Gross State Domestic Product (GSDP).

Additionally, it also urged the Election Commission to implement a comprehensive absentee voting system for people who were unable to vote.



Indian Economy Likely To Be 'A Little Weaker' In 2025: IMF MD

NEW DELHI. The Indian economy is expected to be "a little weaker" in 2025 despite steady global growth, IMF Managing Director Kristalina Georgieva has said. Georgieva also said she expects quite a lot of uncertainty in the world this year mainly around the trade policy of the US.In her annual media roundtable with a group of reporters on Friday, she said global growth is expected to be steady in 2025, but with regional divergence. Georgieva said she expects the Indian economy to be a little weaker in 2025. However, she did not explain it any further. The World Economy Outlook update week will have more details about it.

"The US is doing quite a bit better than we expected before, the EU is somewhat stalling, (and) India a little weaker," she said. Brazil was facing somewhat higher inflation, she said. In China, the world's second-largest economy, the International Monetary Fund (IMF) was seeing deflationary pressure and ongoing challenges with domestic demand, she said.

"Low-income countries, despite all the efforts they are making, are in a position when any new shock can affect them quite negatively," Georgieva said. "What we expect in 2025 is to have quite a lot of uncertainty, especially in terms of economic policies. Not surprisingly, given the size and role of the US economy, there is keen interest globally in the policy directions of the incoming administration, in particular on tariffs, taxes, deregulation and government efficiency,"

Factory output growth hits 6month high of 5.2% in November: Govt data

NEW DELHI.India's factory output, as measured by the Index of Industrial Production (IIP), rose to a six-month high of 5.2 per cent in November from 3.7 per cent in October, mainly due to a favourable base effect along with a pickup in manufacturing, capital goods, and consumer durables.

It had grown by 2.5 per cent in November 2023. Cumulatively so far in the financial year 2024-25, industrial growth has been recorded at 4.1 per cent during April-November as against 6.5 per cent in the year-ago period. Manufacturing, which accounts for 77.6 per cent of the weight of the IIP, surged to an eight-month high of 5.8 per cent in November from 4.4 per cent in October and 1.3 per cent in November 2023 primarily due to a pickup amid the festive season. "Quite clearly the needle appears to have turned during the festival season which is a good sign. The manufacturing sector in particular has fared well with growth of 5.8 per cent over 1.3 per cent last year. Besides the low base effect, there has been a revival of both capital goods and consumer durable goods," Madan Sabnavis, Chief Economist, Bank of Baroda said.

Mining output picked pace to 1.9 per cent in November from 0.9 per cent in October even though it was lower than 7.0 per cent growth in the year-ago period. Electricity output grew by 4.4 per cent in November from 2.0 per cent in October. It had grown by 5.8 per cent in the year-ago period.

On the basis of use-base classification, the primary goods output grew by 2.7 per cent in November as against 2.5 per cent in October and 8.4 per cent in the year-ago period. Capital goods segment, a key indicator of the investment sentiment, grew 9.0 per cent in November as against 3.1 per cent growth in October and a contraction of 1.1 per cent in the year-ago period.

Private insurers show 239% jump in motor commission payouts to Rs 16,578 crore

NEW DELHI. Despite concerns raised by the Insurance Regulatory and Development Authority of India (IRDAI), private sector general insurers reported a 239 per cent jump in commission expenses in the motor insurance segment in fiscal ended March 2024. Interestingly, private insurers lagged behind public sector counterparts with a low claims ratio. Private insurers shelled out a whopping `16,578 crore to motor insurance service providers (MISPs) as commission during the fiscal ended March 2024 as against '4,890 crore in FY2023 while securing fresh businesses. Interestingly, public sector insurers kept away from the 'commission game' and reported only 31.59 per cent rise in commission expenses at '3,099 crore in FY2024 as against '2,355 crore in FY2023, according to the Annual Report of the IRDAI.

When it comes to incurred claims ratio, public sector insurers led with 99.57 per cent while private players were far behind with a figure of 73.30 per cent, according to the IRDAI report.

Incurred claim ratio refers to the total claim amount paid by the insurance company in ratio to the total premium amount collected in a financial year. For instance, if the incurred claim ratio of an insurance provider is 75 per cent, then it means that the insurer pays `75 towards claim payment for every `100 of premium collected and the remaining '25 is considered as profit for the insurance company.

Meanwhile, earlier this year, IRDAI had repealed its guidelines capping the commission for long-term motor insurance policies, aligning these policies with the standard one-year motor insurance policies. Insurers can now offer commissions within the expense of management for long-term policies. Total commission expenses incurred by private players for all categories, including health, motor, marine and fire, were at '26,235 crore in FY24 as against '10,192 crore. PSU players' expenses were at'7,359 crore (`6,340 crore).MISPs were reportedly charging high commissions of over 50 per cent for new private car insurance policies. What is significant is that high commission to MISPs will inflate the insurance premium being paid by the car buyers. If an MISP charge '45,000 insurance on a '12 lakh car, the same policy could cost just Rs 20,000 if taken from the

The notices were issued against alleged tax evasion by these companies. However, the companies had moved courts against the notices disputing tax demand.As per lawyer Abhishek Rastogi, this stay not only provides immediate respite to gaming companies from potential coercive action but also safeguards the interests of revenue authorities. Explained: Why Infosys has filed counter lawsuit against Cognizant

NEW DELHI. IT giant Infosys has filed a counterclaim against Cognizant in a Texas federal court, alleging anti-competitive practices and targeted poaching of its key Reuters. The Bengaluru-based firm accused its US-based rival of contractually restricting clients from awarding IT services to competitors and withholding software training, which Infosys claims hindered its ability to compete. The lawsuit comes after Cognizant's subsidiary TriZetto sued Infosys in August last year, accusing the Indian IT giant of misappropriating trade secrets related to its healthcare insurance software. TriZetto's Facets and ONXT platforms,

widely used by healthcare insurers to automate administrative tasks, were central to the initial legal dispute.

Jannik Sinner doping case hearing fixed for April: CAS

New Delhi . World number one Jannik Sinner is set to face the Court of Arbitration for Sport (CAS) in a doping case hearing scheduled for April 16-17. The hearing will address the World Anti-Doping Agency's (WADA) appeal, which seeks to impose a one-to-twoyear ban on the Italian tennis star. Sinner, 23, tested positive for low levels of the anabolic steroid Clostebol in two separate tests conducted in March last year. In August, an independent tribunal cleared him after accepting his explanation of unintentional contamination. Sinner claimed the banned substance entered his system through a massage from a trainer who had used Clostebol to treat a finger injury. The tribunal ruled that the contamination was accidental, sparing him from suspension. Despite this, WADA filed an appeal with CAS in September, challenging the tribunal's decision. If the appeal is successful, Sinner could face a ban of up to two years. "No parties requested a public hearing, and it will be conducted behind closed doors," CAS said in a statement about the two-day hearing.

The CAS hearing will take place behind closed doors at its headquarters in Lausanne, Switzerland. Neither party requested a public hearing. While CAS has not provided a specific timeline for its decision, a fast-track verdict may be requested to ensure the ruling is made before the French Open begins on May 25. The doping case has cast a shadow over Sinner's remarkable 2023 season, during which he won the U.S. Open. News of his positive test, initially kept confidential, was revealed after he successfully appealed against a provisional ban.

As Sinner prepares to defend his Australian Open title in Melbourne, he has faced scepticism from fellow players. Notably, Novak Djokovic has questioned whether Sinner received preferential treatment from tennis authorities.

In a statement on Friday, Sinner expressed frustration over the uncertainty surrounding the case, saying he remains focused on his preparation for the Australian Open but is eager for clarity.WADA maintains that the presence of Clostebol in Sinner's system constitutes a doping violation, regardless of the explanation. The agency is pushing for a suspension of at least one year to uphold the integrity of anti-doping efforts.

The outcome of the CAS hearing will be pivotal not only for Sinner's career but also for broader perceptions of fairness and consistency in tennis. If banned, Sinner risks missing key tournaments, including the French Open and Wimbledon. Conversely, a verdict in his favor would vindicate his claims of accidental contamination and allow him to continue his rise in the sport.

They play a lot of matches in SENA (South Africa, England, New Zealand, Australia) countries, so it is fair to be judged to the highest standards.



This 'generational slump' is inevitable for all teams. It's what we know as the transition phase and among the best teams in the world, I believe it affects India the most," Emotions run high and those in positions to Manjrekar wrote in his column.

The one foremost reason behind this is the icon culture we have in India and the hero worship of certain players. 
