### EC orders transfer of AAP candidate's voter ID to Delhi: Kejriwal

New Delhi, Jan. 13: The Election Commission of India (ECI) has approved the transfer of AAP leader Awadh Ojha's name from the voter



rolls in Greater Noida to Delhi, enabling him to file his nomination for Patparganj, AAP chief Arvind Kejriwal said on Monday. The development came after a delegation of AAP, led by Kejriwal, met ECI officials to address the issue. "The good news is that Awadh Ojha's vote will be shifted and the commission has issued order to transfer his vote, and he will be able to file the nomination," Kejriwal said. Earlier in the day, Kejriwal alleged

irregularities in the electoral process, claiming that Ojha had filed Form 8 to transfer his vote on January 7- the official deadline. He also accused the Delhi Chief Electoral Officer of unlaw-

fully advancing the deadline to January 6. Kejriwal said the move as an attempt to "deliberately debar" Ojha from contesting the upcoming elections, saying it was against the law. Kejriwal also made serious accusations against the BJP's candidate from the New Delhi constituency, Parvesh Verma, alleging distribution of cash, liquor and other items such as bedsheets, shoes and glasses to

sway voters. He further alleged that local authorities, including the District Magistrate (DM), were complicit in covering up these actions. The AAP chief claimed that the Election Commission had assured him of appropriate action against the New Delhi DM following these complaints. The political battle between the AAP and BJP is intensifying and both parties are trading allegations, with assembly polls in Delhi just weeks

ter before a division bench presided by Chief Justice T S Sivagnanam, the petitioner prayed for the constitution of a special investigation team to probe the alleged use of contaminated or expired intravenous fluid in West Bengal's Medinipur Medical College and Hospital. The petitioner's lawyer, Phiroze Edulji, informed the court that the company supplying the intravenous fluid had been red-flagged in March 2024 by another state government and banned the firm from supplying the product for three years. Edulji prayed that the investigation be transferred to the Central Bureau of Investigation from West Bengal Police to ensure impartiality and transparency. The division bench, also comprising Justice Hiranmay Bhattacharyya, said the matter would be taken up for hearing on Thursday. The court directed the petitioner's lawyer to notify the state Advocate General's office to ensure representation by the West Bengal government during the hearing. A woman died and four others fell critically ill after childbirth at the hospital allegedly due to the administration of expired intravenous fluid, prompting the health department to order an investigation. The state government has formed a 13-member panel to investigate the matter. Three of the four women were brought to Kolkata on Sunday night and admitted to state-run SSKM Hospital for further treatment.

### Orange alert for isolated dense fog in Delhi-NCR

New Delhi, Jan 13: The Indian Meteorological Department (IMD) predicted cold wave conditions and rainfall activity at isolated places in Delhi on Monday. Dense fog Conditions are very likely in the Delhi/NCR region at isolated places and an orange alert was issued regarding the same. Morning walkers during a cold and foggy morning at Lodhi Garden in New Delhi, India. Delhi's maximum temperature on Sunday was 17.3 degrees Celsius, two notches below the seasonal average. The maximum and minimum temperatures in Delhi are expected to settle around 19 degrees Celsius and 7 degrees Celsius on Monday, respectively. A fresh western disturbance from Tuesday night will bring isolated to scattered rainfall/snowfall activity likely over Jammu-Kashmir, Himachal Pradesh, and Uttarakhand over the next three days. The IMD said in its bulletin that the weather system will also bring isolated rainfall activity with thunderstorms and lightning over Punjab, Haryana, Chandigarh, the Delhi-NCR region, and Uttar Pradesh on January 15 and 16. A gradual fall in minimum temperatures by 2-3 degrees Celsius is likely over Northwest & Central India during the next 48 hours and a gradual rise by 2-4 degrees Celsius during the subsequent 3 days.



# Council speaker questions CID probe into Ravi-Hebbalkar row

New Delhi, Jan 13: Legislative council speaker Basavaraj Horatti has expressed reservations about the Criminal Investigation Department (CID) being tasked with probing the altercation between Bharatiya Janata Party (BJP) MLC CT Ravi and minister Lakshmi Hebbalkar during the recent winter session in Belagavi. Horatti conveyed his concerns in a letter addressed to state home minister G Parameshwara. "The House has the sovereign power to discuss, conclude, and decide on incidents within its premises. It is unclear why this case has been handed over to the CID. The speaker holds the authority to maintain discipline in the House, and any decisions regarding its proceedings are final," Horatti wrote on Saturday. He criticised the move, describing it as a potential constitutional conflict that undermines the powers vested in the legislature and the speaker. "Both the executive and the legislature must respect each other's roles and avoid unnecessary clashes. I trust



with the Constitution and preserve the sovereignty of the House," he added. The issue stems from an incident on December 19, the last day of the Belagavi winter session. During a heated debate, Hebbalkar accused Ravi of using obscene language against her. Following her complaint, Ravi was arrested the same evening at Suvarna Vidhana Soudha, where the session was held. He was later released on directions from the Karnataka high court. The state govern-

ment handed over the case to the CID to ensure a thorough investigation. Speaking to the media on Sunday, Parameshwara defended the decision. "We will examine the speaker's letter and consult legal advisors before proceeding. The law applies equally to everyone, and the CID's involvement aims to prevent unnecessary confusion," he said. Meanwhile, the CID is investigating multiple facets of the case, including an anonymous threat letter addressed to Ravi. Chikkamagaluru superintendent of police Vikram Amathe confirmed the registration of a case concerning a letter threatening Ravi and his son. "An anonymous letter has been received, and an investigation is under-

way to trace its origin and verify its content," Amathe said. The letter reportedly demands Ravi's apology for his alleged use of derogatory language against Hebbalkar, warning of harm if he fails to comply within 15 days. Police sources suggested that the letter does not explicitly name Hebbalkar, but is believed to be linked to the legislative council incident. The controversy has sparked a political war of words. Reacting to the threat letter, deputy chief minister DK Shivakumar dismissed it as fabricated. "Ravi has become a 'drama master.' He should have apologised for his remarks against a woman minister instead of weaving lies,' Shivakumar said. Union minister Pralhad Joshi criticised the state government for its handling of the case. "This is vengeance by the government. They should identify the culprits behind the letter within hours and take swift action." he said. Ravi has denied the allegations and claimed police misconduct during his arrest. He has also written to the governor seeking additional security, citing con-

# My heart says PM Modi will very soon fulfil J-K statehood restoration promise: Omar Abdullah

Srinagar, Jan. 13: Jammu and Kashmir Chief Minister Omar Abdullah Monday praised Prime Minister Narendra Modi for his efforts in bridging the gap between "Dil (heart) and Delhi" and holding assembly polls in the Union Territory while exuding confidence that the statehood restoration promise would soon be fulfilled. Addressing a gathering after the prime minister inaugurated the 6.5-km Z-Morh tunnel renamed 'Sonamarg Tunnel' in the Ganderbal district, the chief minister began his speech by paying tributes to the seven people who died in a terrorist attack near the tunnel site on October 20 last year. He said terrorism will be defeated to ensure peace and development besides safeguarding democracy in Jammu and Kashmir. "Prime minister, when you came to Srinagar for a programme after getting a third term (in office), people started believing your words. You talked about three important things which included your efforts to bridge 'Dil ki duri aur Delhi se duri', and you have proved it by your

work. "This is your second function in Jammu gramme as chief minister." Referring to Modi's and Kashmir within 15 days after inaugurating (virtually from Delhi) the separate Jammu Railway Division (on January 6)," Abdullah said. In the presence of PM Modi, the Jammu

and Kashmir chief minister said, "You also promised (assembly) elections within four months and you stayed true to your words. People got an opportunity to take part in the voting and today I am participating in this pro-

speech during his visit to Srinagar on International Yoga Day last year, the chief minister said, "My heart says that very soon, you will fulfil your third promise to the people of

Jammu and Kashmir which is the restoration of statehood to the Union Territory." The chief minister's statehood remark in the presence of the prime minister was welcomed by the audience with a round of applause. This was Prime Minister Modi's first visit to Jammu and Kashmir after the formation of the Omar Abdullah-led government nearly three months ago. Abdullah said the inauguration of projects like the 'Sonamarg Tunnel' tunnel would definitely bridge the gap

between Jammu and Kashmir's "dil' (heart)' and Delhi. He said the biggest positive of the election was that there was no complaint of rigging, misuse of official machinery or repoll anywhere and "the credit for it goes to you, your team and the Election Commission of India". The chief minister said people, including his colleagues, ask him about statehood restoration. "I tell them that the prime minister kept his promise of elections and so my heart says that very soon, you will fulfil your third promise as well and Jammu and Kashmir will once again get the status of a state." Abdullah read out the names of the seven victims in last year's terror attack near the tunnel and said they sacrificed their lives for this project and the development of Jammu and Kashmir and the country. "I belong to a political regime whose thousands of leaders and workers have been killed in the last 35 years because we were... Not ready to see the country being divided," the chief minister said. He said the prime minister's presence in the tunnel inauguration programme is a testament to the fact that those who carried out the attack do not want the development of this region and the country. "They do not want a peaceful atmosphere and democracy. But they can never be successful. They will always have to face defeat here and we will never allow them to cause any

harm to democracy," he said. Abdullah said there were many challenges in building the tunnel and the work on the project was also halted. "The people of Jammu and Kashmir have been waiting for this tunnel for a very long time. Because of this tunnel, the people will not have to come to the lower parts. We will be able to develop Sonamarg as a tourist destination and this tunnel will also facilitate speedy work on the under-construction Zojila tunnel (to provide all-weather connectivity to Ladakh)," he said. He thanked Prime Minister Modi for visiting Kashmir in the cold weather and said, "We hope that you will come again and again, and join in our happiness." The twolane bi-directional road tunnel between Gagangir and Sonamarg in Ganderbal district in central Kashmir has been built at a cost of over Rs 2,700 crore. It is equipped with a parallel 7.5-metre-wide escape passage for emergencies. Situated at an altitude of over 8,650 feet above sea level, the tunnel will enhance allweather connectivity between Srinagar and Sonamarg en route to Leh, bypassing landslide and avalanche spots.

### Kerala's widest single-pillar flyover in Kasaragod set to open in February

KASARAGOD. The widest single-pillar flyover in Kerala is now in its final phase of construction. Concrete work on the 1.13 km-long, 28.5 metre-wide project with 29 spans has been completed. The overbridge, which extends from Kasaragod fire station, near Karandakkad, to the Ayyappa temple, near the new bus stand, is expected to ease traffic congestion in the city.

With the completion of concrete work on the final span, construction has entered the final leg. The bridge is expected to be opened to traffic in February, after the removal of slabs. Construction is being carried out by the Uralungal Labour Contract Cooperative Society (ULCCS) Ltd."We should be able to open the bridge in February, based on the completion of the approach road," a ULCCS official said.

'One of the main challenges of constructing a single-pillar flyover is maintaining engineering precision, and the bends in the Kasaragod project added another level of difficulty. Nearly 95% of the construction work has been undertaken. The final stage, involving surfacing and installing protective railings, is all what is left," the official said.

The bridge is a testament to modern urban aesthetics and a showcase of engineering prowess. The monumental project is poised to dramatically transform the landscape of Kasaragod. The single-pillar design allows for more space under the bridge. The structure will not only alleviate traffic congestion in Kasaragod but also serve as a catalyst for the district's overall development," the official said.

### Record passports issued in Karnataka, thanks to demand from Tier 2, 3 cities

BENGALURU. The desire to travel abroad from residents of Karnataka, particularly those in the Tier 2 and 3 cities, has kept the Regional Passport Office extremely busy last year. It has broken all past records with 8,83,755 passports issued in 2024.

"This figure bests our previous high recorded in 2023 by 34,000 passports thereby recording a 4% increase. What is driving the growth is the surge in applications received from the Tier 2 and 3 cities in Karnataka," Regional Passport Officer, Bengaluru, Krishna K told The New Indian Express.Karnataka has 23 Post Office Passport Seva Kendras (POPSKs). "Post Covid-19, we have witnessed a surge in applications from POPSKs in these cities. An average of 700 to 800 applications are submitted to us through them daily,' Krishna added.Post-Covid-19, international travel has bounced back and hence the demand for passport services has been growing steadily, he said. There is a surge in Indians travelling abroad for work, education or for sightseeing purposes.

Krishna said 4,88,509 men, 3,95,236 women and 10 transgenders were issued passports in 2024.Interestingly, a 100-year-old person was among those who got their passport last year. Eight individuals in the age category of 96-99 and 8,668 people in the 76-95 years category too got them, reveals data. The maximum number of passports - 3,88,453 - were issued to those in the age category of 16-35. Surprisingly, the highest number of passports were issued in a single month - 78,416happened in February which had the least number of days. Among other services rendered by the Passport department is the issuance of Police Clearance Certificates (PCCs), a mandatory requirement to work in certain countries. Revealing a trend of the most sought after countries job-wise, Kuwait was the most sought after workspot with 7,284 PCCs issued.

### Private hospitals halt Aarogyasri services over Rs 1,200 crore

HYDERABAD. With talks between the Aarogyasri Trust and the empanelled private hospitals becoming inconclusive, small and medium hospitals resorted to calling off Aarogyasri services for beneficiaries for four days, including EHS and JHS, despite the Trust stating that the services would continue as usual.By Sunday, 368 hospitals across the state had joined the strike, demanding the government release dues amounting to over Rs 1,200 crore, which have been pending for more than a year.

While members of the Telangana Aarogyasri Network Hospitals Association (TANHA) had met with Aarogyasri Trust CEO Shiva Shankar Lotheti earlier in the week, the talks reached a deadlock, as the association refused to accept the assurances given by the Trust. The CEO had assured the clearing of the dues, but the members said that mere words would not make them return to their jobs.TANHA state president Dr. Vaddiraju Rakesh told, "The major concerns and demands we have proposed to the Trust are: redrafting of the unilateral MoU between hospitals and the Trust, revision of both Aarogyasri and EHS/JHS packages based on a scientific approach, regular payment of dues, clearing of pending dues, cancellation and deduction of approved packages by up to 30%, and a redressal mechanism for our grievances.

# ISRO to reassess strategy after space docking trial put on hold, yet again

an inevitable achievement in the early hours of Sunday, was put on hold by Indian Space Research Organisation (ISRO) scientists, who are closely observing and controlling the two spacecraft of the Space Docking Experiment (SpaDeX) mission.After bringing the two spacecraft -SDX01 and SDX02 - as close to 230 metres on Saturday evening, at 3:11 am Sunday, the ISRO team posted on 'X' that the two satellites were close to each other and were spotted from an intersatellite distance of 105 metres.Later, at 5:17 am, ISRO

noted that the Chaser and Target spacecraft were clearly visible 15m apart, and posted, "We are just 50 feet away from an exciting handshake.'

The news brought cheer among space science enthusiasts who are hoping for a successful maiden docking mission by ISRO.At 6.19am, the ISRO team shared the news that the two SpaDeX satellites had been put on hold position at 15 metres, along with photographs of the craft clearly visible at close range.

However, at 7:06 am, the scientists decided to put on hold the docking exercise until further analysis. They said they were successful in bringing the spacecraft just 3m from each



However, the scientists did not divulge the reason for moving the spacecraft away from each other to a 'safer distance', after they were close to complete the docking experiment, which is crucial for future Gaganyaan and Bharatiya Antariksh

ISRO took to X to say: "A trial attempt to reach upto 3m from 15m is done. Moving back the spacecraft to safer distance. The docking will be done after analysing data further."

SpaDeX mission taken up at cost of Rs 370cr Many experts, however, are speculating the reasons. While some said the two were not aligned accurately for the docking to take place, others said the

said. The stampede occurred as hundreds of devotees jostled to secure Vaikunta Dwara Sarva Darshan tokens, in which six people were killed. Among the deceased, four were from the erstwhile Visakhapatnam district. They

included 33-year-old K Santhi from Gandhi Nagar in Kancharapalem, 47year-old G Rajini from Maddilapalem, and 38-year-old S Lavanya from Thatichetlapalem, all residents of Visakhapatnam city. The fourth victim, 55-year-old B Naidu Babu, hailed from Boddepalli in Narsipatnam of Anakapalle district.

On Thursday, Chief Minister N Chandrababu Naidu announced an ex gratia of Rs 25 lakh to each of the families of deceased, along with a contract job for one from each family, Rs 5 lakh compensation for two critically injured pilgrims, and Rs 2 lakh compensation to 33 injured pilgrims.

### In this Kadapa temple, men perform puja, no entry for women

KADAPA. A rare and intriguing tradition unfolds every year in Thippayapalle, a village in Pullampet mandal of Kadapa district. On the Sunday before Sankranti, the village celebrates a grand festival dedicated exclusively to men. This unique event revolves around the Sanjeevaraya Swamy temple, where men take centrestage in offering prayers and preparing a traditional dish, Pongal, for the presiding deity.

Men, irrespective of where they live, return to their native village for the occasion. They come together to cook Pongal and offer it as Naivedyam to Lord Sanjeevaraya as per the tradition that has been passed down for generations. Women, however, are strictly prohibited from entering the temple or consuming Prasadam.

The age-old custom dates back to hundreds of years. According to locals, a wandering sage once lived in the village and accepted food only from men. Before leaving, he installed a sacred stone and instructed the villagers to worship it as Lord Sanjeevaraya. He also laid down specific rituals, including the exclusion of women from temple activities. The villagers, believing the sage to be a divine incarnation, continue to honour these practices to this day. Interestingly, the temple does not have a sanctum sanctorum. Instead, devotees worship inscriptions on the sacred stone as the embodiment of the deity. Another popular belief suggests that the stone was installed by a Brahmin to counter the misfortunes and poor harvest that once plagued the village. Since then, the villagers claim, prosperity has returned, reinforcing their faith in the tradition.

On the festival day, men bring cooking ingredients in baskets from their houses and prepare pongal within the temple premises. After offering it to the deity, Prasadam is distributed among the men. Women can only witness the proceedings from outside the temple premises. Speaking about the tradition, Subbarayudu and Srinivasulu, local residents, explained, "We believe these rituals keep evil forces at bay and protect the health and prosperity of our village. Which is why devotees from neighbouring villages, apart from locals, flock to the temple during the festival."

# Kerala police purge 28,724 websites, block 21,000 social media accounts in 2024 cyber fraud crackdown

THIRUVANANTHAPURAM. The state police purged 28,724 websites and 21,000 social media accounts involved in financial fraud from cyberspace in 2024, official documents have revealed. The websites were removed after the


cyber police wrote to the domain registrar highlighting the portals' role in scamming people.The removed websites included e-commerce sites, trading websites, fake job portals and sites that hosted malicious applications, enabling fraud by stealing login credentials and data

theft. The social media accounts connected to

the scams were mostly identified on Meta and X, and were removed after the cyber police issued notices to the

This apart, the police also blocked close to 36,000 bank accounts that were found involved in organised cyber scams. The accounts were used by both domestic. The state police had earlier wrote to the and international fraudsters to move Reserve Bank of India and the Ministry

funds swindled from their victims. Sources said hundreds of the bank accounts blocked were found to have been used by rackets operating from Southeast Asian countries such as Cambodia, Laos and Myanmar. They



included current bank accounts, used for channelling swindled cash.

A majority of the accounts was found acquired by scamsters through fraudulent ways, including paying the account holder a fixed amount as commission for each transaction.

of Home Affairs seeking their intervention in preventing misuse of the bank accounts by cybercriminals.State Police Chief Shaik Darvesh Saheb had urged the MHA and the RBI to rein in the unfettered use of current accounts of

Indian banks from other countries. He had also sought a cap on the number of electronic gadgets using which digital transactions could be done. He had suggested that credibility scores be introduced for each account as it would enable users to identify fraudulent accounts.

13,877 SIM cards blocked The police action also resulting in the blocking of 13,877 SIM cards that were used by scammers to

contact the potential victims. This apart, 20,482 smartphones were permanently locked after it was found that they were used to place scam calls. The Department of Telecom locked the phones by blacklisting their International Mobile Equipment Identity (IMEI), unique to each phone, by acting on the state police's request.

# 283 areas in Nilgiris district landslide-prone

CHENNAI. A nine-member technical expert committee has identified 283 locations in the Nilgiris district prone to landslides due to the heavy rainfall during the southwest and northeast monsoons, revealed an affidavit submitted on Friday by the Nilgiris collector Lakshmi Bhavya Tanneeru before the southern bench of the National Green Tribunal (NGT). The committee was constituted to carry out the study in Nilgiris district and approve roadwidening projects only after stringent evaluation, it said. The judicial body had sought reports from the district administrations of Nilgiris, Dindigul and Coimbatore in the aftermath of the Wayanad landslide tragedy that claimed 254 lives and injured several others in Kerala on July 30.To prevent landslides and soil erosion in



the Nilgiris - known for its hilly terrain and ecological fragility - the administration has implemented slope stabilisation techniques, including soil nailing, on key roads such as the Coonoor-Mettupalayam stretch of NH 67 (now NH 181). Similar measures were adopted on state highways, including critical

locations along the Ooty-Kotagiri-Mettupalayam route.

Besides completed projects, new works are in progress under the Comprehensive Road Infrastructure Development Programme (CRIDP) 2024-25, flood restoration initiatives, and special repair schemes. The government has allocated funds, with preparatory estimates in progress for additional locations, mentioned the affidavit.A further complicating factor to all the efforts is encroachment. In the Nilgiris, encroachments in Wellington Town were removed in March 2023, and actions were taken to identify and clear illegal structures in areas such as Burliar, Marapalam, Mel Gudalur, and Thorapalli.

### Three among minor held for killing grandfather in Ghaziabad

Ghaziabad. A 15-year-old and his two friends were nabbed for allegedly killing his 68-year-old grandfather. According to police, the deceased who worked as a rickshaw puller, was attacked by the youths after he caught them stealing money and iewellery from his house.

Suryabali Maurya, ACP, Loni, said the teen used to work as a labourer and is the son of the rickshaw puller's elder daughter who was initially living with his grandfather but due to his stealing habit, he was thrown out of the house."Knowing all these facts, he became our prime suspect, and two teams were formed to nab him. Today, we arrested him from Loni," police said. The accused told police he wanted his grandfather's money that he had obtained after selling a plot and he planned to steal it with the help of his friends.

On Saturday, the 68-year-old caught the youths as they were leaving the house after theft, but one of the accused attacked the elder on the head with an iron rod, and the other two strangled him to death. They fled from the scene and even took away cash from the deceased's pocket, said police.

The accused were arrested on Saturday, and a case was registered against them under sections 103 (2) (punishment for murder) and 309 (robbery) of BNS at the Loni police station, said police. "Rs 4,000 cash, a gold-coloured ring, and silver anklets have been recovered from their possession. The iron rod used to strike the man on the head was also recovered,"

### Spat leads to knife attack, vendor arrested in Gurgaon

Gurgaon. A footwear vendor was arrested for attacking two men at Sushant Tower in Sector-56 during an argument on Saturday night. The victims, Mahesh Pathak and Azad suffered injuries on their faces in the assault, said police. According to police, the accused, Sohail and Sahil were arguing with a vegetable vendor in a drunken condition at Sushant Tower when one of the victims, Azad, who was at the spot, waiting to meet his brother, intervened in the argument, and Sohail left the place with his friend only to return after some time. Explaining the incident, Azad said, at around 8 pm when he was standing with his brother Surva Prakash, his wife Jyothy, and their common friend Mahesh in front of Sushant Tower, Sahil suddenly came and picked up an argument with them. He alleged that they misbehaved with him and Sohail.

"Suddenly, Sohail attacked Mahesh on the face, and when I tried to intervene, I was also attacked. After the assault, the accused dropped the knife at the spot. Both of them fled from the scene," Azad said.Mahesh suffered a deep cut on his right cheek, and Azad suffered a cut on his left ear.A case was registered against Sahil and Sohail on Sunday morning under sections 115(2) (voluntarily causing hurt), 118(1) (voluntarily causing hurt or grievous hurt by dangerous weapons or means), 351(2) (criminal intimidation), 110 (attempt to commit culpable homicide), and 3(5) (common intention) of the BNS.

"The victims are out of danger. Actin on the complaint, we arrested the main accused, Sohail, from Gurgaon. We are trying to nab the second accused also," ASI Chandan Singh said.

### Leopard spotted at highrise off Sohna Road in Gurgaon, rescued & released

Gurgaon. A leopard who had strayed into an apartment complex on Sohna Road was captured and released into the Aravalis after a three-hour operation by the wildlife department in the early hours of Sunday. Just before 2am, Ashiana Anmol's maintenance team got an alert from the security guards of an adjacent society that a leopard was seen crossing the boundary wall and entering the

Minutes later, a resident of Ashiana Anmol spotted the big cat in the basement parking lot.

"After the call from Central Park (society), our team started a search operation. Meanwhile, a resident, Nitu Rathore, spotted the leopard in the basement. She quickly informed the RWA. All of us, 50-60 residents, went down. It was a fearful atmosphere," said Ram Gautam, Ashiaana's RWA president.Gautam said most of the residents in the apartment complex were fast asleep at the time. "We informed the police and the wildlife department," he added.

Around 300 families are settled in Ashiana Anmol. The area around it has some schools, a university, villages and societies a few kilometres away. A sixmember team of the wildlife department arrived soon after to rescue the big cat. Officials said the five-year-old male leopard may have ventured into the society in search of food. Ashiana Anmol is surrounded by the Aravalis, which are home to the big cat species. In the society's basement, a security guard saw the leopard entering the sewage treatment plant room, and he quickly locked the grilles to confine the big cat there.

The wildlife team cordoned off the basement and initially planned to tranquilise the leopard. "But we were concerned that the leopard could fall into the sewage treatment plant and get injured. Eventually, they decided to cut a patch of the iron grilles and attach a gate to the opening, so the leopard could be guided into it," said RK Jangra, wildlife divisional forest officer. Around 4.30am, the team ignited some firecrackers, but the leopard remained inside the STP room."We decided to use water to startle the leopard. This proved to be effective. The big cat rushed towards the portion of the grille opening into

# Noida airport takes off in 4 months But, how do you reach Jewar?

**NOIDA.** Noida International Airport is only four months away from launch. But even before you take the first flight from there, the question that is unlikely to have escaped your mind already is — how do I get to the airport in the first

Jewar, where the airport is located, is around 90km from IGI Airport in Delhi, 70km from Connaught Place, 60km from Noida City Centre and 40km from Pari Chowk in Greater Noida, the last point on the metro grid.

The airport's feasibility will depend on its first phase footfall, for which the target is 5-6 million passengers in the first year. For this to happen, the next few months will have to be hard work on the ground because there is no public transport to Jewar, barring a handful of private and UP Roadways bus routes that already exist. There are multiple transport projects in the pipeline — a 72km rapid rail corridor and a Delhi Metro route connecting with the Airport Express line are among those on the drawing board.



But these are long-term ones — not before 2030 at least.

Realising this, NIA recently announced an airport taxi service in collaboration with Mahindra Mobility. Noida, Greater Noida and the Yamuna authorities have also come together to form an SPV to start a city bus service that will provide a steady connection to the airport.But with the clock ticking, pieces of the jigsaw will have to fall into place quickly for the new airport to be connected with the rest of NCR.Intercity cabs are an option, but the amount passengers are likely to spend on them from any of the NCR cities could account for almost half of

their domestic flight fares.

"If I have to spend so much just to get to the Noida airport, I would rather book a flight from Delhi. I just need to take the metro to get there," said Rajeev Singh, a resident of Indirapuram in Ghaziabad. Around 6.30pm on Jan 11, a one-way trip with Uber Go to the airport from Noida Sector 52 showed Rs 1,365 on the app. The fare was Rs 1,324 from Botanical Garden metro station and Rs 893 from Pari Chowk. The first two journeys would be around two hours long while the trip from Pari Chowk would take around 65 minutes.

Stakeholders agreed that spending almost half the plane fare on a cab ride was not likely to look attractive to potential flyers. And lack of reliable transport options would only make the airport in Jewar a lot less attractive," a real estate promoter said. The connectivity challenge also raises questions on the airport's preparedness to handle international passengers who might prefer Noida over IGI because of its proximity to tourist destinations like Agra and Mathura.

"This will only tarnish the airport's image as a world-class facility," the promoter said. While the rapid rail and metro links are unlikely before 2030, questions have also cropped up regarding the cost of the all-electric airport taxi service — for which the project concessionaire has tied up with Mahindra. According to the plan, cabs will pick up and drop off passengers from and to the airport. Bookings will be available through a mobile app, website, call centres, and airport kiosks.

Not just cost, will they have enough cabs to take bookings from passengers boarding a flight from Jewar? Moreover, where will these cabs have their hub? Will they come all the way from the airport to pick you up," a resident asked. Concerns have also surrounded the rapid rail and metro project, with the Centre recently seeking a fresh design of the alignment. So, the only viable option for passengers now is a 200-fleet bus service that the authorities plan to start on six

### Man dressed as firefighter caught looting homes in Los Angeles amid deadly fires

World.Los Angeles Police on Sunday arrested a man impersonating a firefighter while robbing homes in fire-stricken Los Angeles. This arrest comes amid a surge in looting-related crimes as wildfires rage across the region.Los Angeles County Sheriff Robert Luna confirmed that at least 29 arrests were made on Sunday (January 12), according to the New York Post. Of these, 25 arrests occurred in the Eaton Fire area, while four were reported near the Palisades Fire region."I saw a gentleman who looked like a firefighter, and I asked if he was OK because he was sitting down. I didn't realize we had him in handcuffs. He just got caught burglarising a home," Sheriff Luna recounted the incident.

Authorities also revealed that two arrests were made for curfew violations near Vice President Kamala Harris's residence in Brentwood early Saturday.In response to the rising crime, 400 National Guard troops have been deployed to the affected areas to enhance security and deter looting.

The Los Angeles Police Department Chief Jim McDonald emphasised that the 6 pm to 6 am urfew remains in effect through Monday. At least 24 people have died, and 16 others were reported missing due to the wildfires in Los Angeles as firefighters raced to contain the inferno for the sixth day on Monday. Over 12,000 structures have been destroyed due to the wildfires so far, according to officials.

### Zelensky Offers To **Exchange North Korean** Soldiers With Captive Ukrainians

Kyiv, Ukraine. Ukrainian President Volodymyr Zelensky said Sunday he was ready to hand over captured North Korean soldiers to Pyongyang in exchange for the return of Ukrainian POWs held in Russia. Zelensky's offer came hours after South Korea's National Intelligence Service confirmed Ukraine's announcement from the previous day that it had captured two North Korean soldiers.

Kyiv said Saturday they had been wounded fighting Ukraine's troops in Russia's Kursk region, but at the time did not provide any proof of their nationality.But on Sunday, the NIS told AFP it had "confirmed that the Ukrainian military captured two North Korean soldiers on January 9 in the Kursk battlefield in Russia". In a post on X Sunday, Zelensky said: "Ukraine is ready to hand over Kim Jong Un's soldiers to him if he can organize their exchange for our warriors who are being held captive in Russia." There would "undoubtedly be more" North Korean soldiers captured by Kyiv, he added.

"For those North Korean soldiers who do not wish to return, there may be other options available," said Zelensky."In particular, those who express a desire to bring peace closer by spreading the truth about this war in Korean will be given that opportunity."

### Russia-North Korea ties

Ukraine, the United States and South Korea have accused nuclear-armed North Korea of sending more than 10,000 soldiers to help bolster Russian forces. Neither Moscow nor Pyongyang has acknowledged that North Koreans have been deployed to fight against Ukraine. The two countries have boosted their military cooperation since Russia launched its 2022 invasion of Ukraine."There should be no doubt left in the world that the Russian army is dependent on military assistance from North Korea," said Zelensky. The Ukrainian president posted a video of an interrogation of the two North Korean prisoners of war, one of whom is lying in a bunk bed and the other is sitting up in bed with a bandage around his jaw.

One man can be heard speaking to a Ukrainian official through an interpreter, saying in translated comments that he did not know he was going to fight in a war with Ukraine and that his commanders "told him it was just training".

In translated comments, one of the men says he wants to return to North Korea. The other says he will do what he is told but, if given the chance, wants to live in Ukraine.

### 'Significant losses'

South Korea's confirmation Sunday added weight to Kyiv's account, confirming details released by Ukraine the previous day.

### Three killed in Israeli Airstrike In Lebanon

Beirut. Three people were killed in an Israeli airstrike that targeted a group of people near the Shebaa Farms in southern Lebanon, a Lebanese military source said.

The source, speaking on condition of anonymity, told Xinhua on Sunday that an Israeli drone fired an air-toground missile at the Bastra area south of the town of Shebaa, resulting in the fatalities.

The Israel Defense Forces said in a statement on Saturday that its air force had identified and attacked three "suspects" near the Israeli-annexed Shebaa Farms area, Xinhua news agency reported. Lebanon's General Directorate of Civil Defence announced on Sunday it had retrieved two bodies in the Lebanese town of Khiam, the bodies and remains of eight people in the town of Naqoura, two bodies in the village of Biyyadah, and one body in the village of Tayr Harfa.

Meanwhile, Israeli warplanes launched airstrikes on Sunday night, targeting areas surrounding Baalbek city in eastern Lebanon for the first time since the ceasefire between Hezbollah and Israel went into effect on November 27, 2024. Lebanon's National News Agency (NNA) reported that the raids hit the town of Jenta in the Baalbek-Hermel district, but did not provide information on whether there were any casualties. Meanwhile, in southern Lebanon, Israeli warplanes conducted six intense airstrikes targeting

several areas, according to NNA. The ceasefire, brokered by the US and France, was meant to end nearly 14 months of fighting between Israel and Hezbollah. The terms of the agreement include Israel's withdrawal from Lebanese territory within 60 days, with the Lebanese army taking over security along the Lebanese-Israeli border.

# Drugged, gang-raped, burned alive: 5 cases reveal horror of UK grooming gangs

World. A girl from Rotherham in England had been raped from the age of 13 to 15 and believed her mother would be the next victim. A 15-year-old was told at all times that she was a bullet away from death. Sometimes beaten with claw hammers, other times brutally raped and silenced. Several white girls in the UK were befriended by young Muslim men and then passed on to older men who would become their boyfriends. What followed was gang rapes and several degrees of other forms of violence. These stories of grooming gangs, operating in the UK since the 90s, could send a chill down anyone's spine. The grooming gangs and their nefarious activities made headlines due to the remarks by Tesla boss, Elon Musk, who called out UK Prime Minister, Keir Starmer, for not acting against them.

These grooming gangs had a pattern: girls as young as 10-year-old girls in Rotherham, Oldham and other areas were lured by

Pakistani-origin men, then taken to older men who would control and manipulate them. These young girls would then be gang-raped by these men and their relatives and friends for years. The authorities also did not act when these women reported their abuse as they allegedly tried to avoid hurting cultural senstivities in the UK.

Investigations by counties, accounts by survivors and media reports have revealed the extent of sexual abuse and violence used by the members of the grooming gangs, who were predominantly Pakistani

men. However, people are demanding a probe across the UK to find out the real extent of the crimes of these gangs. Here are five cases that reveal the horrors perpetrated by grooming gangs in the UK. 1. THE HUSSAIN BROTHERS WHO

TRAUMATISED MANY Jessica (name changed), 14, was first abused by Arshid Hussain, 24. At first, he was gentle and kind to her, but what gradually

followed were many forms of manipulation—control, isolation, and coercion."It became like the only person in even convinced her that her family against her and were jealous of her. She believed in what he said.

But then there was anger and violence. There were times when she felt that he would kill her at any moment. Raped, tormented, and scared, Jessica and many women lke her had lost all hope. The victims even had long-term impacts from the abuse.One girl only undressed in the dark because she had started hating her body, suffered from depression, and had eating disorders.

# Blue Origin Or SpaceX? Amazon Boss Bezos On Musk's Influence On Trump

Washington. Jeff Bezos said he does not think SpaceX CEO Elon Musk will use his close ties with US President-elect Donald Trump to undercut his space company Blue Origin, adding he feels "very optimistic" about the incoming administration's space agenda."Elon has been very clear that he's doing this for the public interest and not for his personal gain. And I take him at face value," Bezos, founder of Blue Origin which rivals SpaceX in the space industry, told Reuters in an interview on Sunday.

Bezos spoke with Reuters in Cape Canaveral, Florida where he will watch the debut launch of Blue Origin's New Glenn, a 30 story-tall rocket that is expected to chip away at SpaceX's market dominance and kick start Blue Origin's long-delayed entrance in the satellite launch business.Musk, who spent more than a quarter billion



dollars to help elect Trump, has had the president-elect's ear on space matters.Last month he said the US should send missions straight to Mars instead of going to the moon first, fueling industry concerns of a major shakeup to NASA's space exploration

My own opinion is that we should do both - we need to go to the moon and we should go to Mars," Bezos said, when

Washington D.C. Japanese Foreign Minister Takeshi Iwaya said on Sunday he planned to attend Donald Trump's inauguration as US president on January 20, as Prime Minister Shigeru Ishiba's government hopes to maintain close ties with its security ally.

We aim to build a relationship of trust with the Trump administration," Iwaya told a talk show on public broadcaster NHK. He said he was seeking a meeting with Senator Marco Rubio, Trump's pick to be Secretary of State.India and Australia also said their foreign ministers would attend the swearing-in ceremony as Trump returns to the White House.

It will be Iwaya's first visit to the US since he became foreign minister in October. Japan, a longtime US ally that had good relations with Trump during his first administration, is keen to get off to a good start for his second. Ishiba is looking into visiting the United States as early as the first half of February for his first meeting with Trump, Japan's Yomiuri Shimbun newspaper reported on Sunday.




# UK Tech Minister Says Children Should Be Allowed To Use ChatGPT For Homework

Mr Starmer's administration has been largely optimistic regarding the technology with its ministers claiming that if AI is "fully embraced", it could bring £47 billion to the economy every year. With the private sector set

to invest £14 billion in the field as well, it could bring around 13,000 jobs. Though the complete details of the AI plans are not yet clear beyond rumours of a "sovereign AI team", it is already evident that the Labour Party is taking a stance that is radically different from its Conservative predecessors.

As per Mr Kyle, the Labor administration will implement a "course correction" on AI safety, after former PM Rishi Sunak placed an overbearing amount of attention, spooking the public in the the incoming administration to lay the groundwork for an Ishiba visit.Indian Foreign Minister Subrahmanyam Jaishankar will attend the inauguration at the invitation of the Trump team and meet members of his incoming administration, his ministry said in a statement.

Penny Wong, foreign minister of fellow US Pacific ally Australia, said on Sunday she would also attend the inauguration, calling it "an important opportunity to discuss how we can advance the benefits of our strong economic and security partnership and expand our cooperation". She has said Australia's centre-left Labor government was confident of its alliance with the United States, its biggest security partner, under the incoming Republican administration. Australia, India, Japan and the United States, which form the Quad security group, have started making arrangements to hold a four-way foreign ministers' meeting in Washington following Trump's swearing-in, Japan's Nikkei business daily said. China has objected to the Quad grouping as an effort to encircle Beijing and ramp up conflict, while the four member nations say they are like-minded democracies seeking to bolster stability in the Indo-Pacific region.

# Biden speaks to families of 3 Americans detained in Afghanistan since 2022

Washington D.C. US President Joe Biden spoke on Sunday with the families of three Americans detained in Afghanistan by its Taliban rulers since 2022, and emphasised his commitment to bringing home Americans wrongfully held overseas, the White House said. Biden's administration has been negotiating with the Taliban since at least July about a US proposal to release the three Americans - Ryan Corbett,

George Glezmann and Mahmood Habibi in exchange for Muhammad Rahim al-Afghani, a high-profile prisoner held in Guantanamo Bay, Reuters reported last week, citing a source familiar with the discussions. Efforts to secure the release of the Americans continue, a second source familiar with the initiative said on Sunday.



Corbett and Habibi were detained in separate incidents in August 2022 a year after the Taliban seized Kabul amid the chaotic US troop withdrawal. Glezmann was detained later in 2022 while visiting as a tourist.Ahmad Habibi, Mahmood Habibi's brother, who was on the call on Sunday, welcomed the discussion with Biden."President Biden was very clear in telling us that he would not trade Rahim if the Taliban do not let my brother go," he said. "He said he would not leave him behind. My family is very gratefl that he is standing up for my brother."The Taliban, which denies holding Habibi, had countered the US proposal with an offer to exchange Glezmann and Corbett for Rahim and two others, one of the sources told Reuters last week. The White House noted that Biden has brought home more than 75 Americans unjustly detained around the world, including

from Myanmar, China, Gaza, Haiti, Iran, Russia, Rwanda, Venezuela and West Africa. His administration also brought home all Americans detained in Afghanistan before the US military withdrawal, it said.

President Biden and his team have worked around the clock, often in partnership with key allies, to negotiate for the release of

Americans held hostage or unjustly detained abroad so that they can be reunited with their families, and will continue to do so throughout the remainder of the term," it added.

A Senate intelligence committee report on the agency's so-called enhanced interrogation program called Rahim an "al Qaeda facilitator" and said he was arrested in Pakistan in June 2007 and "rendered" to the CIA the following month.He was kept in a secret CIA "black site," where he was subjected to tough interrogation methods, including extensive sleep deprivation, and then sent to Guantanamo Bay in March 2008, the report said.Biden last week sent 11 Guantanamo detainees to Oman, reducing the prisoner population at the detention center in Cuba by nearly half as part of its effort to close the facility as the president prepares to leave office on Jan. 20.

### Tension flares after miscreants cut udders of three cows in Bengaluru's Cottonpet

BENGALURU. Tension flared up in the Cottonpet area in Bengaluru West on Sunday morning after unidentified miscreants inflicted injuries on the udders of three cows on Pension Mohalla Road behind Vinayaka Theatre. A large number of people gathered as the news spread, leading to tension. The police said the incident came to light early on Sunday morning when a local resident noticed a pool of blood at the place where the cows were tied to a post on the roadside. He found injuries on the udders of three cows and alerted the cow owner. Karna, who stays 500 metres away from the spot.Karna immediately informed a veterinary doctor and also called the police. The police visited the spot, recorded statements. Based on Karna's complaint, a case was registered under Section 325 (mischief by killing or maiming animals) of BNS and Prevention of Cruelty to Animals Act.

A senior police officer said that over six cows were tied on the roadside and of them, three had injuries."While two cows had slash marks on their udder, the other's udder was mutilated. It is suspected that the accused used a blade to inflict injuries," he said. The police are analysing CCTV footage and are said to be questioning some suspects.

### AP transport dept slaps Rs 1 crore fine on private bus operators for charging excess

VIJAYAWADA. The Andhra Pradesh Transport Department has slapped a fine of around Rs 1 crore on private travel bus operators for violating rules, and charging exorbitant fares from travellers during Sankranti festival season. Following complaints from public on the exorbitant fares, State Transport Commissioner Manish Kumar Sinha directed the RTA to initiate action against the private bus operators, who resorted to encashing the

Acting on the Commissioner's instructions, transport officials have cracked the whip on private bus operators, and registered over 800 cases in the past two days for charging exorbitant fares and violating the RTA norms.As many as 50 teams were deployed in all the districts on Saturday for conducting surprise inspections. They checked passenger documentation, permits and adherence to fare regulations. Dedicated enforcement squads were also posted at specific locations to ensure continuous monitoring of private buses. The RTA raids on private bus operators will continue till January 19."Cases have been registered against private bus operators charging exorbitant fares by creating artificial scarcity of tickets during Sankranti season. It has been detected that the majority of private bus operators are collecting exorbitant fares. Notices have been served on the errant bus operators, besides slapping fines on them for violating RTA rules," a senior official said. Speaking to TNIE, Manish Kumar Sinha said private bus operators have been directed to strictly adhere to RTA norms and other safety regulations, and avoid charging exorbitant fares from travellers.

### SRSP canal breach inundates SC colony in Mannemapally

KARIMNAGAR. Sudden flooding inundated the Scheduled Caste (SC) Colony of Mannemapally village in Thimmapur mandal early on Sunday. The incident occurred when the bund of the Sriramsagar Project (SRSP) D-4 canal breached near the Peechupally cross regulator, causing water to gush into the colony and submerge houses.Former sarpanch Medi Anjaiah alerted irrigation authorities about the situation. Superintending Engineer (SE) of Irrigation Circle-2, P Ramesh, along with staff and local police, rushed to the site. Manakondur MLA Kavvampally Satyanarayana also visited the area to assess the situation and check on the affected residents.

SE Ramesh explained to the media that water was being released into the SRSP canal system from the Thotapally reservoir. He suspected that downstream villagers or farmers had released excess water from the main canal into a minor canal. This led to an overload, causing the bund to collapse.

"The canal has a designed capacity of 200 cusecs, but it was overwhelmed by a flow of 300 cusecs, which caused the breach,' Ramesh stated, noting that the ongoing release of water from reservoirs into canals for the Rabi crop season contributed to the situation.Restoration work on the breached bund is currently underway, but the SE emphasised that full restoration cannot be completed until the canal is emptied of water.

# Free dhotis, sarees for Pongal at many ration shops Polavaram D-Wall work begin after Sankranti in Tirunelveli, Tenkasi yet to reach beneficiaries

TIRUNELVELI/DINDIGUL. A section of ration card holders in several parts of Tirunelveli and Tenkasi districts alleged that they were not provided with the free dhotis and sarees promised for Pongal, whereas in Dindigul the PDS shops are left with just half stocks required for distribution.

While blackboards displaying messages indicating lack of stock have been put up at the ration shops in Tirunelveli's Udayarpatti and Thirugnanasambanthar Street, ration card holders urged the authorities concerned to prioritise the distribution."Officials should prioritise distributing dhotis and sarees to elderly and impoverished people instead of using the token system," said A Manohar, a ration card holder in Tirunelveli.

Another beneficiary claimed that she had not received clothes for the second consecuive year in Tirunelveli. "Last year, the ration shop staff promised I would get them after Pongal, but I never did," she said. Besides, allegations are cropping up about the misuse of the clothes meant for free distribution in the previous years. A devotee, A Shanmugavel, highlighted spotting dhotis, meant for Pongal distribution, being sold at Kerala's Padmanabhaswamy Temple some days back. It may be noted that similar incidents have been reported since 2015. Further, a large quantity of dhotis and sarees purchased for Pongal 2024 distribution was muddied during the December 2023 floods in Tirunelveli. These clothes were found stored



at the Palayamkottai Tahsildar office last

Speaking to TNIE, CITU District Cooperative Workers Union Secretary (Dindigul) Sadiq Ali said, "We believe just 50% of the sarees and dhotis arrived at PDS shops through the civil supplies department in Dindigul." Condemning the poor state of distribution, several customers also staged a protest in Nilakottai taluk on Friday. An official from the Civil Supplies Department (Dindigul) said, "We received only a few lakhs of sarees and dhotis from the state government, and we immediately distributed them among the PDS

shops throughout Dindigul district. We expect more numbers within two days, and the whole process of distribution in the district will be completed in one week."When contacted, M Murugesan, Joint Registrar of Cooperative Societies (Tirunelveli region), told TNIE only 57% of the dhotis had reached shops in the district as of Sunday morning. "Distribution will continue until January 30, and we will ensure that all beneficiaries receive their allotment," he added. Meanwhile, an official, on condition of anonymity, said that around 59% of the beneficiaries across Tamil Nadu received dhotis and sarees as of Sunday.

# Stray dog menace escalates in Tiruchy's Manapparai, residents seek action

TIRUCHY. The stray dog menace has been steadily increasing in all the 27 wards of the Manapparai Municipality, posing a threat to municipality has failed to take any action to control the stray dog population. On Friday night alone, over 15 individuals were bitten by stray dogs within the town limits.

# Polavaram D-Wall works to

VIJAYAWADA. The construction of a new Diaphragm Wall (D-Wall) at the Polavaram project, costing an estimated Rs 990 crore, is expected to commence after Sankranti.The delay is due to pending clearance from the Central Water Commission (CWC), which is reviewing recommendations from an international experts' panel on the plastic concrete composition for the wall. According to sources, the project contractors and officials submitted three different compositions of plastic concrete for evaluation. The panel, after an indepth review, forwarded its recommendations to the CWC, which is likely to decide within three to four days.

Initially, Chief Minister Nara Chandrababu Naidu had announced that construction would commence on January 2, but technical requirements, including the final approval of the concrete composition, caused a postponement. Preparatory and investigative works for the project began in November. Project officials stated that the plastic concrete would be prepared onsite under the supervision of experts from Bauer, a German company. This self-hardening, waterproof material prevents water seepage in underground spaces. Unlike rigid concrete, plastic concrete's ductile properties make it resistant to cracking under pressure, ensuring its effectiveness in preventing seepage. A senior engineer explained that cracks in rigid structures allow water leakage, whereas ductile materials withstand pressure and maintain integrity.

The proposed 1,400-metre-long D-Wall addresses seepage issues, with bentonite being a critical component to enhance the concrete's plasticity and workability. The new wall will incorporate expert recommendations and be constructed six metres upstream of the existing structure, which was damaged by floods in 2019 and 2020. Project authorities revealed that the sub-surface wall will extend up to two metres into the rock strata beneath the riverbed, with depths ranging from 40 to 90 metres depending on the riverbed's geological composition. The CWC approved the wall's new design in late November, and construction will proceed in phases based on expert committee guidelines.

### Leopard, cubs spotted in Bengaluru's Banashankari VI Stage, residents panic

BENGALURU. A leopard and its cubs were found prowling in the First Block of Banashankari 6th Stage recently, causing panic among residents. Videos of the animals have been captured by the CCTV cameras of an apartment and mobile phones of some residents.

The leopard is said to have entered from the Turahalli Forest which is adjacent to the area.

Prakash RM, a resident of Banashankari, said, "Some days ago, another resident told me that he spotted a leopard near his home.

I didn't believe him. But after I saw the CCTV footage from the apartment, I was convinced. Now, I am scared to go around the area post sunset."TS Mahesha, president of Banashankari 6th Stage Resident Welfare Association, said, "As Banashankari 6th Stage is adjacent to Turahalli Forest, leopards often venture into the residential area and then go back into the forest. We have complained to the Kaggalipura Forest Division about the leopard sighting.'

Assistant Conservator of Forest Ravindra said, "So far, there is no photographic or CCTV evidence that a leopard with cubs has been sighted. We are checking the area to ascertain it. One leopard was sighted sitting on a rock in Turahalli Forest from the window of an apartment. That was around a fortnight ago and it was a

'Another forest official on the ground said that if a leopard with cubs is wandering, citizens are requested not to disturb them and not to panic. They will go back to the forest. "We request the residents not to pick up the cubs or to have any human imprint on them. We are combing the area for pug marks and any other signs," he added.

# 88% in rural, 75% in urban Kerala die in hospitals, doubling European average: Study shows

KOCHI. Around 88% of people in rural Kerala and 75% in urban Kerala spend their final moments in hospitals, as per a new study. This is nearly double the European average and points to the

alarming rise in end-of-life healthcare expenses in the state. In sharp contrast, only 40% die in hospitals in other states

"Kerala seems to be more medicine-centric than the US, where 80% of deaths occur in hospitals," said D Narayana, economist and former director of Gulati Institute of Finance and Taxation (GIFT), who is now professor of eminence of School of Social Sciences, M S Ramaiah University of Applied

Sciences, Bengaluru.He collated the numbers on hospital deaths from the Sample Registration System Statistical Report 2020 by the Office of Census Commissioner 2024. The figure does not ensure quality of death even as it would see a massive rise in healthcare expenditure." Most people wish to die at home. However, due to several reasons, they are not allowed to. Hospital stay

before death cannot ensure quality end of life. It also adds to healthcare expenditure," Narayana said, adding that the number of corporate hospitals in the state also contributes to the



situation.

The all-India average for hospital deaths in rural areas is 44.6% while that in urban areas is 61.5%. Experts for promoting living will to reduce unnecessary treatmentDr Joy Elamon, former director general of the Kerala Institute of Local Administration (KILA), and a distinguished doctor, said the increased healthcare awareness has contributed o the situation in Kerala.

'Healthcare awareness among eralites is high. Also, our health-seeking behaviour is advanced. This, along with the availability and universal and uniform distribution of healthcare

> facilities, leads to a situation where relatives tend to seek medical help or ICU and ventilator support even if they know there is no hope," he said, adding that age groups of the persons dying in Kerala hospitals would give a clearer picture on the trend.

> Another reason cited by Dr Elamon is that Kerala has a strong public health system that enables even people from poor financial backgrounds to approach medical colleges or general hospitals.M M Abbas, general secretary of the

Organic Kerala Charitable Trust, said it is evident from the Census Commissioner's report that healthcare is high towards the last year or the last quarter of one's life."Especially high is the spending when death takes place in hospital. Does Kerala fall into this category of high bed and physician supply leading to a high proportion of death in hospitals," he asked.

# Alappuzha to make it to union government's water metro list after Edakochi, Kollam

KOCHI. While the central government's move to include Kollam and Edakochi to its list of probable locations that can host water metro services opens avenues to further tap the state's inland water facilities, the Kochi Water Metro Ltd (KWML) plan to suggest Alappuzha's name could see Kerala becoming an even greater beneficiary of the transportation system.

The Union government has directed KWML to conduct a feasibility study of other possible locations for implementing the rban transport system.TNIE had, in November 2023, reported on KWML plans to introduce operations on Ashtamudi Lake. The service was proposed to be operated on three routes:



Munroe Island, Alappuzha and Varkala. The Union government's decision to include Edakochi and Kollam in the feasibility study group was based on the direction of the ministry of ports, shipping and waterways to

assess the potential for replicating the successful Kochi Water Metro model in 18 locations across the country."We are exploring whether water metro terminals such as Kumbalam and Varappuzha can be The other cities currently under consideration converted into hubs, which will allow for extension of services to places such as Kodungallur and Cherthala. This is part of the scope of the feasibility study," a senior KWML official said.

However, KWML authorities plan to suggest Alappuzha, instead of extending services to satellite towns, as many hurdles exist to linking them with Kochi. "Besides the issue of navigability due to shallow routes, travel time is a challenge. Otherwise we'd have to operate fast ferries, which would result in protests by residents and fishermen. We'll suggest to the ministry the inclusion of Alappuzha," the official added.

# SC verdicts hold out hope for India's vexed democracy

At a time when the nation's fractious political discourse is loaded with conflicting and competing perspectives on constitutionalism, the Supreme Court's role as the arbiter of constitutional conscience assumes heightened significance. Invested with a wide judicial review jurisdiction, the apex court has earned the nation's respect for its wisdom in charting the course of balanced constitutionalism in testing times.

This is so notwithstanding the occasional errors of judgment. The court's acknowledgment of its fallibility and a demonstrated willingness to correct itself has added to its weight as the ultimate forum for judicial justice. In the context of some of its past decisions perceived as equivocate and flawed for want of a clear statement, its recent pronouncements signal a welcome affirmation of liberty and human dignity as the nation's core constitutional values, holding out hope for India's vexed democracy in 2025. Some recent decisions that have quietly found their way into the lexicon of human rights jurisprudence and inspire confidence in the resilience of our constitutional institutions deserve mention. These include the Surender Panwar [2025] case, in which the Supreme Court declined to interfere with the observations of the Punjab and Haryana High Court terming the 14 hours 40 minutes' long custodial interrogation of the accused as "not heroic" and "against the dignity of a human being."The decision is a resounding judicial rejection of tortious custodial interrogation. It draws attention to the imperative of fair investigation in accordance with international human rights norms laid down by the UN.

The decision is particularly significant in the context of India's much-delayed ratification of the UN Convention Against Torture (UNCAT), which it had signed in 1997. While the Supreme Court has consistently treated all forms of torture as violative of the individual's right to dignity under Article 21 of the Constitution [DK Basu (1997), Tusharbhai Rajnikantbhai Shah (2024) et al], it has been inexplicably ambivalent in nudging the government to legislate a comprehensive legislation against torture in line with the UNCAT as a necessary step towards the elimination of all forms of custodial torture. Having proclaimed the unconstitutionality of tortious investigative measures, the court is expected to proactively facilitate the enactment of a comprehensive legislation against torture. Its power to do so stems from the willing allegiance of the people to its commands anchored in legal integrity and reflecting the 'community's coherent conception of justice and fairness' (Ronald Dworkin, Law's Empire, 1986). Treading on the libertarian pathin a correction of past aberrations and restoring the constitutional balance, the highest court, speaking through Justices Abhay Oka and AG Masih in Atharv Parvez [2024] has ruled that the restrictions on bail under a stringent penal statute needed to be harmonised with powers exercisable under the constitutional jurisdiction. It affirmed that long incarceration of the accused without bail is an infraction of Article 21 and that the criminal law doctrine of presumed innocence of the accused is not displaced by the seriousness of the crime with which the accused is charged. The same Bench declared in Parvinder Singh Khurana [2024] that a stay of the order granting bail can be passed only rarely and for reasons indicated in the statute. The underlying premise of these judgments is the supremacy of the libertarian philosophy of the Constitution, reaffirmed in Sidhant [2024], in which the court granted bail to the accused despite stringent statutory conditions. It is hoped that the libertarian judicial approach will determine the fate of detenues, such as Umar Khalid, who has been in detention since September 2020. Another significant decision of the Supreme Court in Urmila Dixit [2025], that emphatically asserts the right to dignity and succour for the elderly, merits the nation's fulsome commendation for a compelling moral dimension. Authored by Justice Sanjay Karol, the judgment, in a purposive interpretation of Section 23 of the Maintenance and Welfare of the Parents and Senior Citizens Act, 2007, declared that the 'tribunals under the Act may order eviction [of the donee/children] if it is necessary and expedient to ensure the protection of the senior citizen' and.

### **Diversify MSP to empower farmers**

**EDITORIAL** 

### A restructured MSP would broaden safety nets and encourage sustainable practices, empowering farmers to thrive amidst challenges.

The minimum support price (MSP) system was a significant policy intervention for ensuring food security and protecting farmers from market fluctuations. However, it has begun to show limitations and is now a source of unrest among farmers. Its narrow focus on a few crops has drawn criticism as today's agricultural challenges are evolving, with rising costs, ecological concerns and the need for viable alternatives. While the MSP system successfully stabilised wheat and paddy production, it inadvertently discouraged crop diversification, leaving farmers vulnerable to market volatility and climate impacts. The demand for reform is escalating, with farmers advocating for a legal MSP framework that encompasses a broader range of crops, backs sustainability and enhances economic security. Opponents of an expanded MSP, including many economists, argue that such a system is impractical and financially unsustainable for the government, which they believe should not be obligated to purchase all crops. They argue for a more liberated agricultural market, similar to other economic sectors. However, the agricultural market is not as free as it might seem; government regulations to maintain affordable food prices sometimes create opacity and most of the small and marginal farmers cannot compete against powerful traders and intermediaries. Moreover, there is no demand requiring government purchases at MSP. Yet, it is crucial that MSP serves as a price floor ensuring market prices do not drop below it. Reforming the MSP to align with free-market principles requires creative thinking from policymakers, economists and legal experts.A promising approach is the establishment of a diversified MSP. Expanding coverage beyond wheat and paddy to include pulses, oilseeds, millets and horticultural produce would create a more inclusive and dynamic system, responsive to farmers' needs. This will not only secure farmers financially but also promote sustainable practices. For instance, millets need less water than paddy, making them ideal for drought-prone areas, while pulses can enrich soil quality. To successfully implement a diversified MSP, five key elements are essential:1. Dynamic pricing: MSP rates should adapt to regional needs, market trends and environmental conditions to ensure equitable compensation and promote sustainable practices.2. Robust infrastructure:

Significant investments are necessary to enhance storage, transportation and processing facilities, helping reduce post-harvest losses.3. Legal safeguards: Farmers must have legal protections to secure fair prices and mechanisms to deter exploitation.4. Technological integration: Utilising digital platforms can aid in transparent price discovery and facilitate direct sales between farmers and consumers.5. Education: Training and awareness campaigns are crucial to inform farmers



about the benefits of diversification. The demand for reformed and expanded MSP is justified because in the last over five decades, states have not evolved any sustainable alternative marketing intervention for the farmers. The Government of India made special financial provisions for MSP as a marketing intervention to meet the challenges of food security. The food credit limits sanctioned to the Green Revolution states were not included in their public borrowings. This special dispensation, often termed special central assistance, was crucial for these states. However, during all these years, innovative market access systems should have been developed to give farmers alternative options. In the absence of any other alternatives, the farmers' dependence on MSP and their demand for its expansion is appropriate. However, it is never too late. Both the Central and state governments need to evolve alternative market mechanisms for the farmers that assure them of good remuneration while maintaining the floor process for the produce. There are good examples to emulate. Some countries have implemented agricultural support mechanisms that could inspire MSP reforms in India. For example,

the US employs a combination of direct payments, crop insurance and market loans to support its farmers. These steps ensure that farmers have multiple safety nets and are not overly dependent on any single policy. The US Farm Bill includes provisions for price loss coverage and agricultural risk coverage, which help stabilise farmers' incomes during price drops. Similarly, the European Union's Common Agricultural Policy (CAP) offers subsidies and incentives for sustainable farming practices,


which can be adapted to Indian conditions to promote crop diversification and environmental conservation. Further, farmer cooperatives have shown promise in providing market stability and better bargaining power for small farmers. These cooperatives can be leveraged to aggregate produce, negotiate better prices and reduce dependency on middlemen. Examples fro countries like Israel and the Netherlands illustrate how cooperative models can significantly enhance the profitability and sustainability of farming communities. In Israel, cooperative societies like Tnuva have helped farmers secure better market access and fairer prices through collective marketing and distribution

networks. While government intervention is crucial in determining MSP for crops, a collaborative approach that includes private sector involvement in procurement could alleviate the financial load on public systems. Incentivising private companies through tax benefits to procure products at or above MSP can enhance market competitiveness and opportunities for farmers. This model has seen success in the contract farming system in Thailand, where private companies provide guaranteed prices to farmers, ensuring stable incomes.

Further, connecting farmers directly to consumers or industries through digital platforms can bypass intermediaries, resulting in fairer prices. Initiatives like e-NAM (National Agriculture Market) in India are steps in the right direction. They promote a unified online trading platform for agricultural commodities. Investing in training for young farmers and providing transport support to target markets is vital for achieving better pricing. Digital literacy programmes and mobile-based applications can empower farmers with real-time market information, enhancing their decision-making capabilities.

### **Online lies**

The proliferation of falsehoods and in India's case, hate speeches as well, not only weakens people's access to trustworthy information, but also the ability to confront their political leaders. The notion of a 'WhatsApp university' that consistently misrepresents facts and twists history has come to denote the pitfalls of giving free rein to social media

platforms. Toxic floods of lies need more fact-checkers, not less. Their absence can only mean an open invitation to spread falsehoods and misinformation, with zero accountability.

# Dr Singh deserves a befitting memorial

### The scams reported during his second term in office were a result of his reluctance to discipline colleagues

Resuming my column after the Xmas break, I look back at the happenings in our country during the past few weeks. The distinct brand of democracy that is taking root in India was on display within the new Parliament building and outside. Elected members came to blows, a feature of some parliaments in the Far East.Outside the building's precincts, a Virat Kohli-like shove was attempted by Rahul Gandhi on a BJP elder. Virat's target on the cricket ground resumed his innings after the encounter. Rahul's opponent found himself in a hospital, chattering about the strengt of the younger man pitted against him. While the country watched the antics of our elected representatives, their party bosses got into a slanging match in poll-bound Delhi. The verbal duel has graduated to a poster war between the BJP and AAP, with the two opponents denigrating each other in print. We are amused and disgusted simultaneously, and in equal measure.

Mercifully, there was the proverbial silver lining. Priyanka Gandhi Vadra delivered her maiden speech in the Lok Sabha. In fact, she opened the Opposition's arguments on disrespect to the Constitution. She also mentioned the vituperative attacks on her great-grandfather, Jawaharlal Nehru, the bête noire of the present dispensation. She spoke well and sensibly too. She resurrected a flicker of hope for the return of decency and substance to proceedings in Parliament, as was prevalent in the times of Pandit Nehru. An extremely decent human being, who was our Prime Minister for a decade, breathed his last in a hospital in Delhi. Dr Manmohan Singh was truly respected not only in Punjab and the North, from where he hailed, but also in other parts of the country where perceptive citizens ferret out decent and credible leaders when they perceive the existence of such a rare specimen. It was not as a Sikh but as a Congress leader and the Prime Minister that Manmohan Singh apologised to the Sikh community for the injustices heaped upon them after Indira Gandhi's assassination in 1984. Such a gesture of humility and contrition was not attempted by the Congress government in Maharashtra after the slaughter of Muslims in Mumbai in 1993 or by the BJP in Gujarat in 2002.

I had occasion to interact with Dr Singh during my years in service and later. Two such occasions remain etched in memory. The first arose when the IPS Officers' Association asked me to meet the PM to plead its case when the Pay Commission's recommendations were being considered by the Union Government. had retired by then and set up home in Mumbai, the city of my birth. I asked the officer who had spoken to me on the phone why that was necessary when the PM's own son-in-law was a member of our service. The officer replied that the son-in-law would not dare to broach the subject to the PM. In a country where nepotism is an accepted evil, the thought that the PM was beyond such weaknesses was certainly exhilarating. After the 2008 Mumbai terror attacks, famous lyricist and screenwriter Javed Akhtar and influential Marathi journalist Kumar Ketkar asked me to accompany them to Delhi to meet the PM to discuss the repercussions of this incident for the polity.Dr Singh listened carefully to each of us. I spoke about inter-community relations and how civil society in my city was involved in finding acceptable solutions. He obviously took my suggestions to heart because when I arrived back at Mumbai's airport, the Chief Minister sent an emissary to request me to drive straight to his residence to discuss with him the suggestions I had made to the PM.Dr Singh was an attentive listener. He acted on ideas if he perceived some merit in them. He was not merely humble; his credibility was high. It is true that his sense of decency sometimes worked against him. The scams that were reported during his



second term in office were a result of his reluctance to discipline colleagues, especially those from other political parties which were part of the coalition government. Narendra Modi scores much better than him in the ability to manage coalition partners.

An unseemly row has erupted between the Congress and the BJP about the site of a memorial to honour the former PM's contribution to the country and its people. Dr Singh was the only non-politician to rise to this pedestal. He did not command a following

among citizens like other Prime Ministers did to a larger or smaller degree. But he deserves a monument in marble to remind us of the man who opened our economy and lifted crores of Indians to the ranks of the middle income groups from nearpoverty levels. In Maharashtra, the BJP-led coalition is wrestling with the financial downside of the Ladki Bahin project, which literally took Mahayuti over the finishing line in the 2024 Assembly elections. A massive exercise is afoot to ascertain the eligibility of crores of applicants whom the scheme was not supposed to cover. Half of the would-be beneficiaries will find themselves deprived of the promised largesse. They are bound to grumble. In the meantime, the Agriculture Minister is finding it hard to pacify farmers who were promised loan waivers, which the treasury cannot accommodate at present.

Grumbling' was the word most in evidence when the state's Cabinet was to be formed. The number of aspirants for ministerial status exceeded the figure permitted by law. The 41 MLAs belonging to Ajit Pawar's NCP faction and the 57 from Eknath Shinde's Shiv Sena had a tough time concluding who should be in and who could be left out. This is a common occurrence that has been experienced earlier, but this time around, the aspirational levels had risen so sharply that it took a month after the election results to arrive at a solution.

The police establishment will be forced to part with many more personnel to provide security (status, really) to the 40-odd Ministers. Status and importance are what they all crave for. Some, of course, are in search of 'creamy' portfolios! It will be difficult for CM Devendra Fadnavis to please them all. I reckon it will be a test of his leadership skills.

# Union Budget May See Fiscal Consolidation But Rural, Welfare, Subsidies May Go Up: Report

The report highlighted that the upcoming budget will be crucial for balancing growth and fiscal discipline.

New Delhi. With the Union Budget for FY26 scheduled to be presented on February 1, 2025, a report by Goldman Sachs underlined two key concerns for policymakers, the pace of fiscal consolidation and the government's spending priorities. The report highlighted that the upcoming budget will be crucial for balancing growth and fiscal discipline as India stands out for its high levels of public debt and fiscal deficit as compared with other emerging markets.

Goldman Sachs noted that the government is likely to keep the fiscal consolidation path intact, driven by the need to manage high public debt-to-GDP ratios. However, the report cautioned that this fiscal tightening could act as a drag on economic growth in the upcoming fiscal year.

The report also highlighted a slowdown in public capital expenditure (capex). It mentioned that the fastest growth phase in public capex is now behind us, with future capex growth expected to align with or fall below nominal GDP growth rates. Welfare



spending, too, is unlikely to see significant increases, although pre-pandemic trends in such spending are expected to continue. The report noted that India is currently experiencing a cyclical growth slowdown, the report said, primarily due to fiscal tightening and slower credit growth as a result of the Reserve Bank of India's macro-prudential measures to control consumer loans. The central government's fiscal deficit is expected to be targeted at between 4.4-4.6 per cent of

per cent for FY25. The reduction reflects the government's focus on fiscal consolidation amid elevated public debt It said, "We think elevated public debt-to-

GDP is likely to keep the fiscal consolidation path intact, and we expect the government to target fiscal deficit at 4.4 - 4.6 per cent of GDP in FY26 (from 4.9 per cent of GDP in FY25)".In the ongoing fiscal year FY25, robust tax collections, particularly from direct taxes, have provided the government some leeway to

increase current expenditures. However, capital expenditure has remained subdued. The budget is also likely to make an overarching statement about the long-term economic policy of the government towards 2047. The focus will be on job creation through labourintensive manufacturing, credit for MSMEs, promoting rural housing programs, and sustained focus on the domestic food supply chain and inventory management to control price volatility.

New Delhi. The Army Day Parade this year will see the participation of an all-girl marching contingent from the National Cadet Corps (NCC) and the showcasing of four thematic tableaux, including one based on the force's Mission Olympics Wing.

An all-women Agniveer contingent from the Corps of Military Police (CMP), Centre and School at Bengaluru, and a set of marching 'robotic mules' will also register their presence at the prestigious annual parade for the first time, defence sources said. The Army Day Parade will take place at Bombay Engineering Group (BEG) and Centre in Maharashtra's Pune on January 15 which comes under the Army's Southern Command.In the amme called 'Gaurav Gatha' is planned to be held showcasing the evolution of welfare from ancient period to the contemporary era. Defence Minister Rajnath Singh is likely to grace this event, the sources said.

The theme for the 77th Army Day celebrations is 'Samarth Bharat, Saksham Sena', and the focus this time is to demonstrate the capabilities of the Army contributing to a stronger nation.

### Parents visit IIT-Kharagpur to meet son, find him hanging in his room

New Delhi. A 21-year-old IIT-Kharagpur student was found dead inside his hostel room by his parents who had come to meet him on Sunday, police said. Shawn Malik, a third-year Electrical Engineering student at IIT-Kharagpur, was staying in the Azad Hall of Residence of IIT-Kharagpur. According to IIT officials, Malik's parents and the institute's security guards had to forcibly open the door of the hostel room after he did not respond to repeated calls."The reason for the extreme step was not clear. We have not received any suicide notes. The boy's parents came to meet him with food. Like they do every Sunday. They were the first to see the body hanging. The boy was very good at his studies," IIT Kharagpur Director Amit Patra said.

Nothing suspicious was found. Malik had good relations with the teachers. He didn't tell anyone about the rest. A lab assistant died a few days ago. But there's no connection to it," he said. After the incident, Malik's body was recovered and sent for autopsy to Medinipur Medical College for postmortem. The police are investigating, Patra said. A senior police officer said the post-mortem had been completed, and the process was videographed. An investigation is underway, he said.

IIT-Kharagpur has seen several incidents of student deaths in recent years. In June 2024, another IIT-Kharagpur student, Devika Pilai, was found hanging on the college campus. In October 2023, a fourth-year Electrical Engineering student, K Kiran Chandra, was found dead. Prior to this, in 2022, another IIT student, Faizan Ahmed, was found dead on the campus.

### From Humble Start To Cutting-Edge Tech, IMD Leads Weather Race At 150

New Delhi. From a few rain gauges in 1875 to rivalling the world's best weather agencies, the India Meteorological Department (IMD) has weathered its way to becoming a global leader in forecasting. Born out of calamities -- a devastating cyclone in 1864 and monsoon failures in 1866 and 1871 -- the IMD, turning 150 on January 15, has transformed from a humble setup into a cutting-edge hub of weather science."HF Blandford, the first Meteorological Reporter to the then Government of India, prepared the first rainfall map of the country (undivided India) using data from 77 rain gauges... The IMD has come a long way since its modest start," IMD Director General Mrutyunjaya Mohapatra told PTI.

According to its 2023 report, the IMD operates 39 Doppler Weather Radars, INSAT 3D/3DR satellites providing 15-minute cloud updates, and a robust network of 806 Automatic Weather Stations, 200 Agro-AWS, 5,896 rain monitoring stations, 83 lightning sensors and 63 Pilot Balloon Stations. The IMD's key advancements include rapid severe weather assessments (2015), 6-minute cyclone scans (2018) and upgraded satellite systems.

Its advanced numerical weather prediction models now deliver seamless forecasts from a few hours to an entire season, backed by high-resolution global models and seasonal forecast systems introduced between 2016 and

Mohapatra said improvements in observations, communication, modelling and infrastructure have significantly enhanced weather and climate services.

"Forecast accuracy for severe weather events improved by about 50 per cent in 2023 compared to 2014. This has significantly reduced the loss of lives and property during extreme weather events," he said. By 2023, the accuracy of five-day forecasts matched the one-day forecast accuracy of 2017. Cyclone landfall forecasts have become highly precise, with zero error in most cases (20 km for 24-hour forecasts).

The 24-hour forecast accuracy stands at 80 per cent for heavy rainfall, 86 per cent for thunderstorms, and 88 per cent for heat and cold waves. To make this information accessible to the public in simple language, the IMD has launched several mobile applications, including 'Mausam', which provides weather forecasts for every location in the country. The IMD achieved all this despite India's complex weather patterns compared to many developed countries.

M Ravichandran, Secretary, Ministry of Earth Sciences, said India's tropical weather is characterised by extreme variations, making it more challenging to predict than Europe's relatively stable weather patterns.



### Trading platform Groww plans IPO at \$6-8 billion valuation: Report

NEW DELHI Trading platform Groww is preparing to file for its initial public offering (IPO) within the next 10 to 12 months, reported TechCrunch.Quoting sources familiar with the company's plans, the report suggested that the Bengaluru-based trading platform aims to raise its valuation to between \$6 billion and \$8 billion. This marks a significant jump from its last funding round in October 2021, which valued the company at \$3 billion. If successful, Groww's listing will mark the first IPO by a digital trading platform in India, adding a new chapter to the rapidly expanding fintech landscape. The company has already begun discussions with investment banks and is expected to select advisors for the IPO soon, added the report.

To strengthen its position, Groww also made strategic moves last year by shifting its domicile to India from the U.S., aligning itself with local market regulations in preparation for the public offering.

Backed by major investors such as Peak XV, Tiger Global, and Alkeon, Groww has firmly established itself as a leader in India's competitive retail investing market. The platform boasts 13.2 million active users as of December, significantly surpassing its closest rival, Zerodha, which has 8.1 million users, according to National Stock Exchange data.

Groww's growth trajectory has also been impressive, having added between 325,000 to 550,000 new users each month, which is more than double that of its

### **HCLTech share price flat** ahead of Q3 earnings. What to expect

NEW DELHI. Shares of HCL Technologies fell slightly ahead of its Q3 earnings announcement later in the day. At 12:34 pm, HCLTech shares were trading marginally lower by 0.17% at Rs 1,992.20.

The IT giant is set to report its quarterly results with expectations of a modest rise in profit and revenue despite challenges in key business segments.

As investors wait for the results, here's a look at what brokerages are forecasting for the company.Brokerage firm Prabhudas Lilladher predicts a 3.9% year-on-year (YoY) increase in HCL Tech's net profit, which is expected to reach Rs 4,520 crore, up from Rs 4,350 crore in the same quarter last year. Revenue is anticipated to rise 6% YoY to Rs 30,200 crore, compared to Rs 28,450 crore in Q3 FY24. However, the brokerage expects a slight contraction in the EBIT margin, projecting a decrease of 54 basis points to 19.2%, down from 19.7% in the previous year.

Despite this, the brokerage firm forecasts a sequential improvement in the margin, which should grow by 62 basis points from the 18.6% recorded in the September quarter.

JM Financial is more optimistic, projecting an 8.5% YoY increase in profit to Rs 4,593.5 crore, along with a 5.3% rise in revenue to Rs 30,393 crore.

The brokerage expects the EBIT margin to reach 19.1%. It notes that the quarter's results will benefit from a \$20 million contribution from the one-month consolidation of CTG, along with anticipated 1.5% growth in IT Services and ERS/Product & Platform businesses in USD terms. However, wage hikes are expected to be a headwind, potentially impacting margins.

Brokerage firm Nuvama anticipates a 13.1% YoY increase in profit to Rs 4,790 crore and a 4.3% YoY rise in revenue to Rs 30,110 crore for Q3.

It also expects the company to slightly upgrade its FY25 revenue growth guidance to 4-5% CC YoY growth, from the earlier forecast of 3.5-5%.

# China's exports in December up 10.7 per cent, beating estimates as higher US tariffs loom

HONG KONG. China's exports in December grew at a faster-thanexpected pace as factories rushed to fill orders in anticipation of higher tariffs threatened by U.S. Presidentelect Donald Trump once he takes office.Exports rose by 10.7% compared to the same month last year, surpassing economists' expectations of a 7% increase. Imports, on the other hand, rose by 1% year-on-year, defying analysts' forecasts of a 1.5% decline. As exports outpaced imports, China's trade surplus surged to 104.84 billion dollars.

Trump has pledged to raise tariffs on Chinese goods and close loopholes that exporters currently use to sell products more cheaply in the U.S. If these plans are enacted, they are expected to increase prices in the U.S. and squeeze sales and profit margins for Chinese exporters. However, Zichun Huang of



exports will remain strong in the near term as businesses rush to front-run the anticipated tariff hikes. "Outbound shipments are likely to stay resilient, supported by further gains in global market share, thanks to a weak real effective exchange rate," Huang wrote in a note. Nonetheless, she warned that exports could weaken later in the year if Trump follows through on his tariff

Officials in Beijing reported that the total value of China's imports and exports reached a record 43.85 trillion yuan (nearly \$6 trillion) in 2024, marking a 5% increase from the previous year. China remains the world's largest exporter and the primary trading partner of over 150 countries and regions, according to Wang Lingjun, deputy directorgeneral of the Customs Administration. Despite a slowdown in other sectors of China's economy, partly due to the pandemic and a

downturn in the housing industry, exports have surged. Under President Xi Jinping, the ruling Communist Party has been promoting the upgrading of factories and a shift towards high-tech manufacturing. The report highlighted that China's export of mechanical and electrical products increased by nearly 9% in 2024, with exports of high-end equipment growing by more than 40%. Specific sectors saw impressive growth, with exports of electric vehicles rising by 13%, 3D printers jumping almost 33%, and shipments of industrial robots surging 45%. E-commerce trade, including sales from companies like Temu, Shein, and Alibaba, reached 2.6 trillion yuan (\$350 billion), more than double the level seen in 2020. While China aims to increase its imports, the value of imports still lagged behind exports, partly due to lower prices for key commodities such as oil and iron ore. Officials noted that there is still significant room for growth in imports, citing China's large market capacity and vast potential. However, China is blocked from importing some products due to trade restrictions, particularly in strategically sensitive areas such as advanced semiconductors and military-

revolutionise India, fraudsters are Cyber experts reveal that scammers manipulate victims by creating urgency and using emotional appeals, such as



fabricated emergencies. These tactics exploit human psychology, making even financially savvy individuals vulnerable to fraud.

### Karma hit me: Stefanos Tsitsipas reflects on shock Australian Open first-round loss

Melbourne. Eleventh seed Stefanos Tsitsipas suffered a shock first-round exit at the Australian Open on Monday, January 13. The 2023 finalist was defeated by 20-year-old American Alex Michelsen, 5-7, 6-3, 2-6, 4-6, in a match lasting 2 hours and 43 minutes at John Cain Arena in Melbourne. The Australian Open has traditionally been a successful tournament for Tsitsipas, with the Greek star having reached the semi-finals three times before making the final in 2023. Explaining his shock defeat - the first big upset of Australian Open 2025 - Tsitsipas attributed it to a lack of match practice in the new season. The World No. 12 had withdrawn from the doubles competition, where he was scheduled to partner his brother, Petros Tsitsipas, in a bid to conserve energy for the singles event.

"It's quite ironic. My whole idea was to try to go deep into the Australian Open. I knew the



first thing I had to consider was not playing doubles," Tsitsipas said after his defeat.

"I guess karma hit me. I was not able to deliver or play the way I had hoped to at this year's event. The whole purpose was to conserve energy and be fresher for the later stages of the tournament."The match saw fluctuating fortunes for both players. Michelsen dominated early, securing a 7-5, 6-3 lead, but Tsitsipas rallied to win the third set 6-2. As Michelsen edged closer to victory, nerves set in; the American committed three double faults and surrendered two service breaks in the fourth set. Despite his struggles, Tsitsipas, who appeared dejected throughout, doublefaulted at 5-all to hand back a crucial break.
