Attack on Saif serious incident, but wrong to brand Mumbai as unsafe: CM Fadnavis

Mumbai, Jan. 16: Maharashtra Chief Minister Devendra Fadnavis on Thursday said the attack on Bollywood actor Saif Ali Khan by



an intruder at his home was a serious incident, but it would be wrong to call Mumbai unsafe because of it. Police were taking action, and the government will take steps to make the country's financial capital safer, said Fadnavis, who holds the home portfolio. Saif Ali Khan suffered grievous injuries after an intruder stabbed him with a knife repeatedly at his 12th floor flat in Mumbai's

Bandra area early Thursday morning. The actor was out of danger, according to the doctors who operated on him to remove the knife from his back. "I think Mumbai is

the safest among mega cities in the country. It is true that some incidents take place sometimes, and they must be taken seriously. But to say that Mumbai is unsafe due to such incidents is not right," Fadnavis reporters. "Mumbai's image gets maligned (due to such comments). But, to make

the city safer, the government will certainly make efforts," he further said. He was talking to the media after attending a special screening of Kangana Ranaut-directed film "Emergency". Opposition leaders including state Congress chief Nana Patole have targeted Fadnavis over the attack on Saif Ali Khan, demanding his resignation as home minister.


Congress's KC Venugopal moves Supreme Court to defend Places of Worship Act

New Delhi, Jan 16: The Indian National Congress (INC) has filed an application in the Supreme Court to oppose petitions challenging the constitutional validity of the Places of Worship (Special Provisions) Act, 1991. The party emphasised that the Act is a cornerstone of India's secular framework and warned that the challenges against it are malicious attempts to undermine established principles of secularism. The intervention application, filed by Congress general secretary KC Venugopal, highlighted that the Act reflects the mandate of the Indian people, as it was enacted during the Congress-led government in collaboration with Janata Dal. The Congress's intervention comes in response to a public interest litigation (PIL) filed by Ashwini Kumar Upadhyay, a Bharatiya Janata Party (BJP) leader, challenging the validity of the Act.

Upadhyay's plea claimed the law discriminates against Hindu, Sikh, Jain and Buddhist communities by freezing the religious character of places of worship as of August 15, 1947, with the sole exception of the Ram Janmabhoomi-Babri Masjid site in

Ayodhya. The application by Congress underscored law risks jeopardising India's communal harmony that the 1991 Act was essential to maintain commu-



tects the religious character of places of worship as they existed on the cut-off date and prevents the rekindling of historical disputes, it argued. "The present challenge is not only legally baseless but also appears to have been filed with questionable motives," the party said, adding any alteration to this and secular fabric, potentially threatening the sovereignty and integrity of the nation. The Congress also

pointed out that the Supreme Court, in its andmark 2019 Ayodhya verdict, recognised the Act as a critical safeguard for secularism and a reflection of constitutional values. Refuting claims of discrimination, Congress stated: "The Act does not favor any religious group but promotes equality. It applies uniformly to all communities, ensuring that no group is disadvantaged or accorded special treatment." The party also dismissed allegations that the law restricts Hindus, Sikhs, Jains and Buddhists while exempting others, asserting that it was designed to preserve the status quo and prevent disputes over religious sites from escalating. The 1991 Act has become a focal point in legal and political debates. Several Hindu litigants argue that it infringes on the fundamental rights of certain religious

groups, particularly Hindus, to reclaim places of worship allegedly destroyed during historical invasions. Prominent challenges have come from BJP leaders like Subramanian Swamy and Upadhyay, along with members of royal families, including Kumari Krishna Priya of the Kashi royal family.

'Family friend' Supriya Sule dials Karisma Kapoor after Saif Ali Khan attacked

Mumbai, Jan 16: Hours after a robber intruded into Bollywood actor Saif Ali Khan's home in Mumbai Bandra's area and allegedly stabbed him, Nationalist Congress Party (Sharad Pawar faction) leader and member of parliament Supriya Sule expressed concern over his safety and said the attack was "worrisome" Supriya Sule is a friend of Saif Ali Khan's wife and Bollywood actor Kareena Kapoor's family, PTI reported. After being informed of the attack, she talked to Kareena Kapoor's sister Karisma Kapoor over a phone call. However, she refused to share details of the conversation and asked the media to wait for an official



statement from the family. "Saif is safe and in hospital Wait for the official statement from the family and the police," she said. According to the PTI report, Karisma Kapoor apparently told Supriya Sule that Kareena had returned home while Saif was still in the hospital. She also talked to Karisma about how the intruder barged into Saif and Kareena's home. Earlier in the day, Shiv Sena (Uddhav Thackeray faction) leader Priyanka Chaturvedi also raised concerns over the safety of people in Bandra. "What a shame that Mumbai sees another high profile attempt on life, the attack on Saif Ali Khan yet again raises questions on Mumbai Police & the Home Minister," Priyanka Chaturvedi said in a post on X. Delhi riots accused Tahir Hussain files nomination from Mustafabad

New Delhi, Jan 16: The former AAP councillor is Asaduddin Owaisi-led All India Majlis-e-Ittehadul Muslimeen's (AIMIM) candidate from Mustafabad for the Delhi election 2025. Delhi riots accused Tahir Hussain filed his nomination papers from the Mustafabad constituency on Thursday and returned to Tihar Jail, officials said. The former Aam Aadmi Party (AAP) councillor is the candidate of Asaduddin Owaisi-led All India Mailise-Ittehadul Muslimeen (AIMIM) from Mustafabad for the February 5 assembly polls. Hussain filed his nomination and returned to custody at 2:16 PM after leaving Tihar Jail earlier in the day to complete the process, a source said. "He was released from jail under heavy security provided by Delhi Police. He left the jail around 9:15 AM," the source added. The party may announce its other candidates later in the day. Speaking to PTI, AIMIM's Delhi president Shoaib Jamai said, "We will not contest all seats but, wherever we do, we will leave no stone unturned. Our candidates will be strong, like Tahir Hussain from Mustafabad and Shafa-ur-Rehman from Okhla. Both are currently iailed in cases related to the CAA-NRC

Actor Saif Ali Khan stabbed by intruder at Mumbai home, out of danger

Mumbai, Jan. 16: Bollywood star Saif Ali Khan was repeatedly stabbed with a knife by an intruder inside his 12th floor apartment in upscale Bandra early

Thursday in a shocking attack that raises intriguing questions about security, motive, and celebrity life. Khan, 54, was "out of danger" following an emergency surgery, said the doctors at the Lilavati Hospital where he was rushed following the incident that took place around 2.30 am at his house in 'Satguru Sharan' building. The intruder fled from the spot. Dr Nitin Dange, neurosurgeon at Lilavati Hospital, said Khan had sustained major injury to his "thoracic spine." "Surgery was performed to remove the knife and also to repair the leaking spinal fluid....Khan is completely stable now. He is in a recovery mode and is completely out of danger. We will shift him

out of ICU tomorrow morning," Dr Dange

added. The actor's representatives

described the incident as an "attempted burglary" though police were yet to comment on it. No person has been arrested so far, a senior police official said. Earlier in the day, Lilavati Hospital's COO Dr Niraj Uttamani in a statement said Khan was



stabbed by an unidentified person at his Bandra home and brought to the medical facility at 3.30 am. "Saif has six stabs and two are deep. Of this one is close to spine," he said, adding the actor was operated upon by a team of doctors led neurosurgeon Dr Nitin Dange, cosmetic surgeon Dr Leena Jain and anaesthesiologist Dr Nisha Gandhi. "He sustained six injuries, two are minor, two intermediate and two deep injuries, one of the injuries is on the back

which is close to spine. A neurosurgeon was involved in the surgery," Dr Uttamani told PTI. The wrist wound is also deep. It's on the left hand and requires a plastic surgeon to repair it, he added. "There was an attempted burglary in Saif Ali Khan and (his wife and actor) Kareena Kapoor Khan's residence last night. Saif had an injury on his arm for which he is in hospital, undergoing a procedure. The rest of the family is doing fine," Kareena

Kapoor's team earlier said in a statement. "We request the media and fans to be patient and not speculate any further as the police is already doing their due investigations. Thank you all for your concern," the

statement said. Saif Ali Khan's public relations representative also in statement said there was an "attempted burglary" at his residence. "We request the media and fans to be patient. It is a police matter. We will keep you updated on the situation," the representative said. A police official said that as per initial information, an unidentified person entered Saif Ali Khan's house and both of them had a scuffle. Some family members of the actor were present in the house at the time of the incident, he said. The actor was injured in knife attack by the intruder. He was taken to the Lilavati Hospital in Bandra and was reported to be out of danger, the official said. Asked if there was a robbery attempt at the actor's house by the intruder, a senior police official did not elaborate and said an investigation was on. The Bandra police reached the spot after receiving information and launched a probe into the incident. Saif Ali Khan is known for his performances in films like "Omkara", "Dil Chahta Hai", "Kal Ho Naa Ho" and "Tanhaji

Indonesian President Prabowo Subianto will be R-Day chief guest

New Delhi, Jan. 16: Indonesian President Prabowo Subianto will be the chief guest at India's 76th Republic Day celebrations on January 26, the Ministry of External

Affairs (MEA) announced on Thursday. Subianto will visit India from January 25 to 26 in his first trip to the country as president. As a comprehensive strategic partner, Indonesia is an important pillar in India's Act East Policy and its vision of the Indo-Pacific, the MEA said. "At the invitation of Prime Minister Narendra Modi, President of the Republic of Indonesia Prabowo Subianto will pay a state visit to India during January 25-26," the MEA said, "President Prabowo will also be the Chief Guest for India's 76th Republic Day celebrations," it said in a statement. "India and Indonesia share warm and friendly ties spanning over millenia," it said. The MEA said the

forthcoming visit of the Indonesian President will provide an opportunity for the leadership of the two countries to undertake a comprehensive review of bilateral ties as well as to discuss regional and global issues of mutual interest. Every year, India invites world leaders to attend its Republic Day celebrations. Last year, French President Emmanuel Macron was the Republic Day chief guest while Egyptian President Abdel Fattah El-Sisi graced the occasion in 2023. There was no Republic Day Chief guest in 2021 and



2022 in view of the COVID-19 pandemic. In 2020, then Brazilian President Jair Bolsonaro was the chief guest at the Republic Day celebrations. In 2019, South African President Cyril Ramaphosa was the chief guest at the Republic Day parade, while in 2018, leaders of all 10 ASEAN countries attended the celebrations. In 2017, Crown Prince

of Abu Dhabi Sheikh Mohamed bin Zayed Al Nahyan was the chief guest at celebrations, while then French President Francois Hollande graced the occasion in 2016. In 2015, then US President Barack Obama watched the parade. In 2014, then Japanese Prime Minister Shinzo Abe was the chief guest at the celebrations, while Bhutan king Jigme Khesar Namgyel Wangchuck attended the parade in 2013. The heads of state and government who have attended the Republic Day celebrations include Nicolas Sarkozy, Vladimir Putin, Nelson Mandela, John Major, Mohammed Khatami and Jacques Chirac. The then British Prime Minister John Major had attended the celebrations in 1993, Nelson Mandela participated as then South African President in 1995 while South Korean President President Lee Myung Bak witnessed the parade in 2010. In 2008, Sarkozy participated in the celebrations as French President, while another French President Chirac graced the occasion in 1998. Other world leaders who have attended the celebrations include Nepal's King Birendra Bir Bikram Shah Dev in 1999, Iran's then President Mohammed Khatami in 2003, then Indonesian President Susilo Bambang Yudhoyono in 2011 and President of Maldives Maumoon Abdul Gayoom in 1991.

ISRO sucessfully docks satellites as part of SpaDeX Mission

Bengaluru, Jan. 16: ISRO on Thursday successfully performed the docking of satellites as part of the Space Docking Experiment (SpaDeX) and the space agency



two satellites as a single object was successful. "India docked its name in space history! Good Morning India ISRO's SpaDeX mission accomplishes historic docking success. Proud to witness this moment!", ISRO said in a post on 'X'. With the successful docking of satellites, India has become the fourth country after US, Russia and China to accomplish the feat. Prime Minister Narendra Modi in a post on 'X' greeted the scientists for the achievement. He said: "Congratulations to our scientists at @isro and the entire space fraternity for the successful demonstration of

space docking of satellites. It is a significant stepping stone for India's ambitious space missions in the years to come." Further, ISRO said: "Post docking, control of two satellites as a single object is successful. Undocking and power transfer checks to follow in coming days." Earlier on January 12, ISRO brought the two spacecraft to three metres and then moved them back to safe distance in its trial attempt to dock the satellites. ISRO had successfully launched the Space Docking Experiment (SpaDeX) mission on December 30, 2024. The PSLV C60

rocket carrying two small satellites, SDX01 (Chaser) and SDX02 (Target), along with 24 payloads, had lifted off from the first launchpad of the Satish Dhawan Space Centre in Sriharikota, and about 15 minutes after liftoff, the two small spacecraft weighing about 220 kg each were launched into a 475-km circular orbit as intended.

81-year-old's balancing act with Pongal seer wins hearts in Pudukkottai

PUDUKKOTTAI. For Chellathurai of Vadakku Kothakottai in Alangudi of the district, Pongal day for the past 12 years has been incomplete without a visit to his daughter's, who resides about 14 km away from the village with her husband and children. Wild elephant tramples woman to death in Kerala's Malappuram, second this month

MALAPPURAM. A 52-year-old woman, belonging to the Kattunayakan tribal community, was killed in a wild elephant attack on Wednesday. The deceased is Sarojini, alias Neeli, of Uchakulam tribal village. Her family lives on the forest boundary.Sarojini and three other women from her neighbourhood went to the forest side to collect forest resources and graze the goats in the morning. "There was a group of four wild elephants, including a tusker, a female elephant and baby elephants. We did not notice the tusker charging at us. When we saw the elephant nearby, the four of us ran in different directions. Sarojini got in front of the herd of elephants and was attacked by the tusker. We saw her lying dead only after the elephants had left," said Ammini, her neighbour. Sarojini died on

Sarojini was first taken to the Nilambur District Hospital. Later, the residents staged a protest and refused to release the body for postmortem procedures. The authorities assured the Uchakulam residents that a compound wall be built around their habitat for protection from wild animals. They also assured the residents that trenching works and fencing will be completed at the forest boundary soon.Once the residents released the body, it was taken to Manjeri Medical College Hospital. The funeral will be held on Thursday. Meanwhile, the SDPI has called for a dawn-to-dusk hartal in Nilambur on Thursday. "Humans should be protected from wild animals. We appeal to the public to cooperate with the hartal being held to protest the authorities' apathy," said SDPI Nilambur constituency president N

NTB will help increase turmeric production in TG, AP: Union Minister Piyush Goyal

NIZAMABAD. Stating that the National Turmeric Board (NTB) would address turmeric-related issues to enhance the income of farmers. Union Minister for Commerce and Industry Piyush Goyal said its establishment fulfils a 40-year-old demand.

There is immense potential for increasing the productivity of turmeric in Andhra Pradesh and Telangana, he noted

The NTB in Nizamabad was virtually inaugurated by Goyal, along with Minister of State for Home Affairs Bandi Sanjay Kumar and Nizamabad MP Arvind Dharmapuri, from New Delhi on Tuesday. Joining the event from Nizamabad were NTB chairman Palle Ganga Reddy, Spice Board officials and MLAs Paydi Rakesh Reddy and Dhanpal Suryanarayana Gupta. Turmeric farmers and officials from various parts of the country also participated in the event.In

his address, the Union minister recalled that Capitalising on favourable trend Prime Minister Narendra Modi, during his visit to Nizamabad in October 2023, had promised to establish the NTB in the district. Although its establishment was delayed due to the Model Code of Conduct (MCC), the promise was fulfilled on the auspicious occasion of Makar Sankranti in 2024, he

added.Goyal highlighted that India, where the rhizome is grown in 20 states, produces 70% of the world's turmeric. Currently, turmeric farming covers around 3 lakh hectares and yields 11 lakh tonnes annually across 30 varieties.



The NTB is envisioned as a transformative body that will support turmeric farmers by focusing on value-added products, establishing processing units, boosting exports, conducting market-based research and promoting the medicinal benefits of turmeric. It will also address logistics and

turmeric consumption had risen during the Covid-19 pandemic and that the NTB would work to capitalise on this trend. Goyal reiterated the prime minister's vision of strengthening India's rural economy to

> bolster the country's overall economic growth. He asserted that NTB's activities would align with these goals and expedite efforts to position Indian turmeric products in global markets. Addressing the gathering, Sanjay called the NTB's establishment "a boon for turmeric farmers" and a catalyst for "unprecedented economic development in the region". He commended MP Arvind for his relentless efforts to make the NTB a reality. Meanwhile, Arvind hailed the NTB as a game-changer, marking the beginning of a new chapter in the region's development. In a

gesture of gratitude, he felicitated Goyal with a turmeric garland. Dharmapuri also thanked Union Home Minister Amit Shah for his role in establishing the NTB.

The event was attended by farmers, BJP activists, and supporters, who expressed optimism about the NTB's potential to revolutionise the turmeric industry.

Karnataka HC directs Lokayukta police to continue with MUDA scam probe

BENGALURU. The Karnataka High Court on Wednesday allowed the Lokayukta police to continue its investigation into the alleged irregularities in the allotment of sites to Chief Minister Siddaramaiah's wife B M Parvathy by the Mysuru Urban Development Authority (MUDA). The court also directed the Inspector General of Police of the anti-corruption body to oversee the investigation and the Additional Director General of Police to peruse the probe report to be placed before the court on the next date of hearing.

Justice M Nagaprasanna adjourned the hearing to January 27 after hearing the arguments of senior counsel Maninder Singh, appearing for the petitioner, Snehamayi Krishna, who moved the high court seeking directions to entrust the investigation to the Central Bureau of Investigation. The court also sought the report of the investigation done till date from December 19,

Singh argued that the investigation



must be fair and independent, which should inspire confidence in the public, but the government is protecting the accused. If higher officials and politicians are involved, the court has to exercise reasonable discretion to consider the request of the petitioner to hand over the probe to the independent investigating agency.

Schools reopen after winter break, shut again due to fog

Due to the cold wave and worsening air quality in Noida, classes from nursery to 8 are suspended till January 17, and classes 9 and 11 will operate in hybrid mode. The decision follows the CAQM's Stage IV restrictions under GRAP. Visibility dropped to zero in the morning, and primary schools report less than 20% attendance.

Noida. The district administration issued a notification to suspend classes from nursery to 8 till Jan 17 due to cold wave conditions. Classes 9 and 11 will shift to hybrid mode of learning after the Commission for Air Quality Management (CAQM) reimposed Stage IV restrictions under the GRAP in Delhi-NCR as air quality worsened in On Wednesday, govt schools reopened for the region. The directive may come as a relief to students many of whom struggled to make their way to school on Wednesday amid the dense morning fog visibility across Noida dropped to

extended following an order from the basic education department as cold wave conditions intensified. Govt schools reported less than 20% attendance on the day while private schools saw 60% turnout.Basic education officer Rahul Pawar said on Wednesday that primary schools started after 9 am, but after reviewing the conditions a notice was issued in the evening to reschedule

classes from 10 am from Thursday. However, after the CAQM revised the GRAP stage restrictions, a new notice was issued by DM Manish Verma.

"The AOI in Delhi soared to 396 on January 15, nearing the hazardous 400 mark, with conditions predicted to worsen further. The CAOM has implemented GRAP 4 restrictions. In view of this order, all schools of the district Gautam Buddh Nagar are directed to follow the implementation of the above Graded Response Action Plan Stage IV order by operating in hybrid mode due to poor air quality from preschool to Class 9 and 11," the statement said.

The order states the choice of online learning would rest with students and their guardians. On Nov 27, a similar order was issued when GRAP Stage IV was imposed in the region. In Ghaziabad, primary schools are closed until Jan 18 following an earlier order owing to the cold conditions. For senior classes, the district inspector of schools. Dharmendra Sharma, issued orders for switching to hybrid learning. "Classes 9 and 11 will operate in hybrid mode, while Classes 10 and 12 will continue with physical classes," the order stated.

NYPD's new rules on highspeed chases focus on public safety

NEW YORK. New York Citys police department is curbing its use of high-speed chases after finding that about one-quarter of more than 2,200 initiated by officers last year led to a collision, property damage, physical harm or death.A new policy effective Feb. 1 will limit vehicle pursuits to only the most serious and violent crimes, barring them for traffic infractions, violations and nonviolent misdemeanors.Officers will also have to take into account whether a pursuit would pass through a residential neighborhood or near a school or playground, Commissioner Jessica Tisch said. They will have discretion to terminate chases if they do not feel it can be continued safely.

Last October, a bicycle rider was struck and killed by a pickup truck that police were chasing after a suspected robbery in Queens. The NYPDs enforcement efforts must never put the public or the police at undue risk, and pursuits for violations and low-level crimes can be both potentially dangerous and unnecessary, Tisch said in a statement. The advanced tools of modern-day policing make it possible to apprehend criminals more safely and effectively than ever before, making many pursuits unnecessary.Of 2,278 pursuits last year, about twothirds involved a vehicle fleeing a traffic stop. Many of those would not be allowed under the new policy, the NYPD said. The department said it will train all uniformed officers in the new policy and conduct monthly reviews to ensure it is being followed. It will also issue an annual report tracking compliance.

According to 911 data obtained by the website Streetsblog NYC, vehicle chases spiked from 15 in January 2022 to 227 in January 2024. Police made more than 100 pursuits each month from July 2023 to September 2024, the last month for which data was available, according to the site.

Cuba starts freeing prisoners a day after the US said it would lift terror designation

HAVANA. Cuba started releasing some prisoners Wednesday as part of talks with the Vatican, a day after President Joe Biden's administration announced his intent to lift the US designation of the island nation as a state sponsor of terrorism.

More than a dozen people who were convicted of different crimes and some of them were arrested after taking part in the historic 2021 protests, were released during the day, according to Cuban civil groups following the cases of detainees on the island. Among those freed was tattooist Reyna Yacnara

Barreto Batista, 24, who was detained in the 2021 protests and convicted to four years in prison for attacks and public disorder. She was released from a prison in the province of Camaguey and told The Associated Press that eight men were also freed along with her. On Tuesday, the US government said it notified Congress about the intent to lift the designation of Cuba as part of a deal facilitated by the Vatican. Cuban authorities would release some of them before Biden's administration ends on Jan. 20, officials said. Hours later, the Cuban foreign ministry said the government informed Pope Francis it would gradually release 553 convicts as authorities explore legal and humanitarian ways to make it happen.

Havana did not link the prisoners' release to the US decision on lifting the designation but said it was "in the spirit of the Ordinary Jubilee of the year 2025 declared by His Holiness," referring to the Vatican's once-every-25-year tradition of a Jubilee, in which the Catholic faithful make pilgrimages to Rome.

The Cuban Observatory of Human Rights, one of the civil groups, said that by 4 pm EST, 18 people had been released, including Barreto Batista.

"At three in the morning they knocked," Barreto Batista told the AP over the phone. "I was sleeping (in the cell) and they told me to gather all my things, that I was free."She said that she and the eight men were warned it was not a pardon or forgiveness and that they had to be on good behavior or they could be sent back to prison."I am at home with my mother," she said. "The whole family is celebrating."

World. For years, the World Monuments Fund has sought to draw attention and resources to endangered cultural heritage sites including Machu Picchu in Peru, temples in Cambodia and the old city of Taiz in Yemen. But this year's list of at-risk sites goes much further afield: to the moon.

The moon seems so far outside of our scope," said Benedicte de Montlaur, the organisation's president and chief executive. "But with humans venturing more and more into space, it is the right time to get ourselves organised."

Concerned that the space race could exacerbate space debris and expand tourism in orbit and beyond, the group named the moon as one of the 25 endangered sites on its 2025 World Monuments Watch. The other sites on the list, endangered by challenges like climate change, tourism, conflict and natural disasters, include Gaza, a damaged historical building in Kyiv, and eroding coastlines in Kenya and the US. With a growing number of wealthy people going to space and more govts pursuing human spaceflight, the group warns that more than 90 important sites on the moon could be harmed. In particular, researchers are worried about Tranquillity Base, the Apollo 11 landing site where astronaut Neil Armstrong first stepped onto the moon's surface.

The moon doesn't belong to anybody," de Montlaur said. "It is a symbol of hope and the future." For almost 30 years, the World Monuments Fund has received nominations for its watch list from heritage experts around the world. The list is an educational and promotional tool serving the nonprofit's other efforts to preserve cultural heritage.

Speaking from the Oval Office as he prepares to hand over power Monday toPresident-elect Donald Trump, Biden seized what is likely to be his final opportunity to address the country It marked a striking admonition by Biden, before he departs the White House to spotlight the accumulation of power and wealth in the US among just a small few."Today, an oligarchy is taking shape in America of extreme wealth, power and influence that literally threatens our entire democracy, our basic rights and freedoms, and a fair shot for everyone to get ahead," Biden said, drawing attention to a dangerous concentration of power in the hands of a few ultra-wealthy people. Dangerous consequences if their abuse of power is left unchecked."

warnings about the military-industrial complex when he left office in 1961, Biden added, "I'm equally concerned about the potential rise of a tech-industrial complex that could pose real dangers to our country as well."Biden used his 15-minute address to offer a model for a peaceful transfer of power and without mentioning Trump by name raise concerns about his successor.

US inflation rises for third straight month, grows at fastest pace since July

Washington. US inflation accelerated last month as prices for gas, eggs, and used cars rose, yet underlying price pressures also showed signs of easing, bolstering hopes that the Federal Reserve could still cut its key interest rate this year. The consumer price index rose 2.9% in December from a year ago, Wednesday's report from the Labor Department showed, up from 2.7% in November. It was the third 3 1/2 year low of 2.4% in September. Yet excluding the volatile food and energy categories, so-called core inflation declined to 3.2% after remaining frozen at 3.3% for three months. Economists pay close attention to core prices because they typically provide a better guide of inflation's future course. The report presents a mixed picture, with consumers still grappling with high prices for essentials such as groceries, housing, and some services such as air fares. At the same time, increases in apartment rental prices are slowly easing and clothing costs barely rose last month. If core

prices continue to match December's



pace, inflation should move closer to the Fed's 2% target.

straight increase after inflation fell to a The report shows that core inflation "is on the downslope," said Mike Skordeles, head of US economics at Truist, a bank. "If the trends continue, the Fed might still end up cutting at some point."Some likely one-time price spikes pushed up overall inflation, with gas prices jumping 4.4% just in December. Prices at the pump have risen by much less since then, moving up 7 cents on Wednesday from last month to \$3.09 a gallon.Grocery prices had slowed for most of last year but began accelerating in the fall, rising 0.4% in September, 0.5% in November and 0.3% last month. Egg prices jumped 3.2% in December and are up 36.8% from a year ago. An outbreak of avian flu is

decimating many chicken flocks, reducing egg supply.On a monthly basis, consumer prices rose 0.4% in December, the biggest increase since last March. Core prices climbed just 0.2%, after four months of 0.3% increases, a positive sign that some price pressures could be cooling a bit.

The slowdown in core price increases was greeted with relief on Wall Street, with the Dow Jones industrial average surging nearly 700 points, or 1.6%, in early trading. Many economists and investors are worried that inflation has become stuck above the Fed's 2% target after a steady decline in 2023 and for much of last year. Such concerns have sent interest rates on Treasury securities higher, which has also pushed up borrowing costs for mortgages, cars, and credit cards, even as the Fed has cut its key rate. The increase in overall consumer prices underscores that inflation remains sticky, even as the threat of potentially inflationary policies from the Trump administration, such as universal tariffs and mass deportations of unauthorized migrants, looms.

At least 1,200 people were killed, and 252 Israelis and foreigners were taken hostage in Hamas's attacks on Israeli communities near the Gaza border on October 7. Of the 95 remaining hostages, more than 30 have been declared dead. Hamas has also been holding captive two Israeli civilians since 2014 and 2015, and the bodies of two soldiers killed in 2014.

"That day is today."Since its founding in 2017, Hindenburg Research has gained a reputation for exposing fraud, corruption, and mismanagement across industries. Reflecting on the firm's achievements, Anderson shared, "We shook some empires that we felt needed shaking.'

Anderson described starting the firm without a traditional finance background, financial resources, or industry connections. "When I started this, I doubted I was capable," he admitted."I didn't have a traditional finance background. None of my relatives are in this field. I went to a state school. I'm not a

slick salesperson. I don't know any of the right clothes to wear. I can't play golf." financial difficulties that left Anderson on the brink of eviction, with a newborn child at home."It is very easy to succumb to negative thoughts and believe what others think of you, especially when things feel low. But it is possible to shatter all of that. I was passionate about this, and I let that carry me forward despite my fears and insecurities."He credited his resilience and the support of his family, friends, and a dedicated team of 11 for transforming Hindenburg into a powerhouse of financial

"They are all smart, focused, and fun to work with. Little to no ego," he said, describing his colleagues as "ruthless assassins" when it came to their work but kind and collaborative otherwise. Anderson described the intensity and allencompassing nature of running the firm, often finding himself consumed by



investigative threads and edits even in his sleep. While deeply fulfilling, the relentless pressure led him to realise the need for a

Ultimately, Anderson explained, the decision to close Hindenburg was a deeply personal one. "There is not one specific thing-no particular threat, no health issue, and no big personal issue," he clarified.Instead, he cited a desire for relief and the need to move on to new chapters. "Early on, I felt I needed to prove some things to myself. I

have now finally found some comfort with myself, probably for the first time in my life."Anderson also shared plans to open-source the knowledge and processes Hindenburg developed over the years. "In the past several years we've been flooded with thousands of messages from many of you asking how we do what we do," he said.

'So over the next six months or so, I plan to work on a series of materials and videos to open-source every aspect of our model and how we conduct our investigations."In closing, Anderson expressed gratitude to his wife, family, friends, team, and readers who supported him along the way."To my wife, you have been so patient with me. To my family and friends, I'm sorry for the times I have ignored you while I let my attention be drawn away. Lastly, I want to express how grateful I am to our readers. Your messages of kindness and encouragement through the years have gone a long way to helping give us the strength to continue," he said.

Seven CoEs being set up to bolster higher education in Kerala: Minister R Bindu

KOCHI. In a bid to bolster the higher education sector in Kerala, the state government has given an administrative sanction to set up seven Centres of Excellence (CoE). The announcement was made by Higher Education Minister R Bindu at the concluding session of the International Conclave on Next-gen Higher Education at Cusat in Kochi on Wednesday. According to the minister, another step to be taken towards reforming the higher education sector in the state is presentation of a bill for necessary amendments to acts of various universities in the state. She said that the bill will enable realisation of ideas like constituent colleges and college clusters.

As for the seven CoEs, she said, "Besides administrative sanction, funds also have been allocated for the preliminary activities of the centres of excellence."The seven centres are the Kerala Institute for Science, Technology and Innovation (KISTI), Kerala Institute for Advanced Studies for Social Science and Humanities (KIASSH), Kerala Network for Research Support in Higher Education (KNRSHE), Institute for Gender Equity, Centre of Excellence for Teaching, Learning and Training, Centre for Indigenous People's Education and Kerala Language Network. Bindu further said that the CoEs are being set up based on the recommendations made by the Syam Menon Commission.

Kerala court's rare bail condition for accused in drug case

KASARAGOD. In a rare move, a court in Kasaragod granted bail to a man nabbed for MDMA possession on the condition that he display a placard against drug abuse in public for five days. The Kasaragod District Sessions Court set what would be its rarest bail condition yet, granting bail to Abdul Safvan, 29, a resident of Kurunthoor in Kanhangad village.

He was arrested by the Hosdurg police on May 18 last year with 3.06g of MDMA at Myyath Road in Kanhangad and booked under the Narcotic Drugs and Psychotropic Substances Act, 1985. While granting him bail, Judge Sanu S Panicker said he must appear before the



investigating officer at 10 am on January 14, hold a placard in his hand and stand at a place suggested by the officer within his jurisdiction from 10 am to 1 pm for five days. As per the court order, the placard should read: "You should abstain from alcohol and drugs, because through drugs you will lose yourself, your friends, and your family." The court asked the police to submit a report after implementing its

BWSSB cuts service to 100 buildings, sewage floods roads

BENGALURU. The Bangalore Water Supply and Sewerage Board (BWSSB) has disconnected its services to around 100 illegal and unauthorised buildings in the Whitefield ward. This is in accordance with the Supreme Court direction against such buildings and Lokayukta notices to civic agencies like BWSSB and BESCOM to take necessary action against unauthorised structures. As a result, raw sewage from these buildings is now flooding BBMP's side drains and main roads. BWSSB officials said that BBMP officials now have to take action and raze such illegal buildings or face criminal contempt charges."We are going by the rules. There is a Supreme Court direction to take action against illegal buildings. The Lokayukta also is watching the developments, and not taking action will lead to dereliction of duty and also criminal contempt of court. Once we have confirmation about the illegal status of a building, we send notices and disconnect services," said a BWSSB official.

BWSSB Executive Engineer Mirza Anwar said the onus of taking action, like demolishing unauthorised buildings, is on BBMP engineers.Residents said that ECC Road, Borewell Road and other streets in Whitefield have been flooded with sewage over the last few days. "The city administration has not been able to provide basic facilities. The situation is created because of BBMP officials, who allowed such illegal buildings to come up," they lamented.

"Had the BBMP zonal commissioner or joint commissioner and ward engineers stopped these unauthorised constructions at least three years ago, the area would not have been flooded with raw sewage now," said a resident.

Man sets dog and scooter on fire over mobile row

NELLORE. A shocking incident of cruelty has surfaced at Chemudugunta Panchayat in Venkatachalam mandal of Nellore district, where a man, Sk Farid, allegedly set a pet dog and a scooter on fire following a dispute over a damaged mobile phone. The incident, captured on CCTV, occurred late Tuesday night and has drawn widespread condemnation from locals and animal welfare groups.

The victim, Dachuru Narasimha, a car driver, reportedly handed over a mobile phone belonging to Farid's friend. Farid accused him of damaging the phone's display and left in anger. Hours later, Farid returned with petrol packets, poured petrol on Narasimha's scooter and his tied-up pet dog,



and set them ablaze at the victim's gate. Hearing the dog's cries, Narasimha's family rushed out, rescuing the injured animal while the scooter was completely destroyed. The dog sustained severe injuries but survived.

CTV footage showed Farid pouring petrol and igniting the fire, prompting Narasimha to file a police complaint at Venkatachelam police station. Animal rights activists have demanded Farid be charged under the Prevention of Cruelty to Animals Act, 1960, along with other criminal charges.Locals have strongly condemned the act, calling for strict punishment. "If he can set fire to a living being and property, what would he do to humans?" questioned a resident, urging authorities to act decisively.

Telangana grants one-year fire NOC abeyance to 217 private junior colleges

HYDERABAD. The state government has granted a one-year abeyance of the mandatory No Objection Certificate (NOC) from the fire department to over 200 private junior colleges, allowing them to continue operations. The NOC is a key requirement for these institutions to function. This decision provides relief to 217 private colleges located in Hyderabad, Rangareddy, and Medchal-Malkajgiri districts, collectively accommodating around 65,000 to 75,000 students

Initially, the abeyance for the fire NOC was granted for the 2020-21 academic year and subsequently extended to 2021-22. From 2022 to 2024, a two-year abeyance was in effect. In response to a request by the Telangana Private Junior College Managements Association (TPJMA) for a further two-year extension, the government has extended the abeyance only for the academic year 2024-25. On Wednesday, the



government issued an order clarifying that no further extensions will be granted. From the 2025-26 academic year onwards, private colleges must secure the mandatory fire safety NOC to continue operations.

The order also mandated implementation of

temporary fire safety measures, including the placement of adequate fire extinguishers in every room.As per GO 20, colleges up to 15 meters in height and operating in mixedoccupancy buildings are required to obtain an NOC from the fire department. However, college managements have repeatedly requested abeyance due to challenges such as poorly maintained buildings and outdated infrastructure, which make compliance with fire safety norms difficult.TPJMA President Gouri Satish told: "We are thankful to the government for allowing the abeyance on the fire NOC for the year 2024-25. We are fully prepared to implement fire safety measures for the academic year 2025-26. A meeting with the Chief Minister and senior officials will be held soon to address various issues for the next academic year, based on which further actions

Madurai rural police to come under city police limits after corporation merger

MADURAI. The extension of the Madurai city police limits will commence only after the merger of new areas with the Madurai city corporation limit is completed, a senior police officer told TNIE on Wednesday.Sources said the Madurai city corporation is the second largest corporation by area, and was established in 1972 while the city police commissionerate was formed in the 1990s. There were around 72 wards in 2011 under the Madurai corporation before nearby panchayats/town panchayats were merged and the number increased to 100 wards. The state is now planning to merge 16 nearby panchayats and one town panchayat with the corporation, which may lead to additional wards and an additional zone in the corporation limits.

Areas that were merged with the corporation in 2011 were later brought under the city police limits, and police stations in areas such as Avaniyapuram, Thiruppalai, Koodal Pudur, Thiruparankundram and Thirunagar fell under the city police limits.

A police officer said that in a few areas, residents are not willing to merge with the corporation. Areas under the station limits of Nagamalai Pudukottai, Karuppayurani, Othakadai and Perungudi come under the Madurai rural police. Once the corporation merger is completed, the work to bring the new areas under the city police limits will commence. A police officer from the rural area said that as per the norms, the merger of a police station with the city police will also add to the strength of the city police. Madurai rural police stations have not been upgraded for the last few years.

"Of nearly 35 police stations, about five police stations have a station house officer (SHO) of the inspector rank. while 12 inspectors are working as circle inspectors.

No fisherman assaulted, sailor was abducted, freed, says Indian Navy

KARWAR. The Indian Navy has rubbished media reports of its sailors assaulting fishermen who were allegedly agitating against two Navy personnel, whose vehicle collided with a fisherman's scooter. It alleged that a sailor was abducted in a fourwheeler, and rescued by his fellow colleagues who gave chase. Now, Uttara Kannada district police is planning to write to naval higher-ups regarding the incident, involving fishermen and staff of INS Kadamba. The accident at Mudga, near Karwar, on Sunday involved two Naval staff on a bike who rammed Srinivas (50) on his scooter. Both parties sustained minor injuries. The sailors helped the injured fisherman, but things took a turn for the worse and the matter reached Karwar Rural Police. The sailors lodged a complaint, saying a group of civilians had gathered and there was a scuffle. "The sailors ensured the injured civilian received timely medical treatment. They escorted him to Pikle's Nursing Home in Karwar... But shortly after the accident, 4-5 civilians gathered and despite the sailors' efforts to deescalate the situation, a minor scuffle ensued," read the complaint, a copy of which is available with."We left the scene, but the civilians pursued us and demanded an additional Rs 50,000 in compensation. My friend was then coerced into a fourwheeler and taken towards Amdalli. He managed to share his live location with friends, who intercepted the vehicle and rescued him," said Yogesh Kumar, the

complainant. Coordination meet between Navy, fishers? 'The civilians abandoned the vehicle and fled. The incident was promptly reported to local



police through the Naval Police, and the vehicle key was handed over to the authorities," the complainant added. The matter did not end here. On Monday morning, a group of villagers from Amdalli staged a protest and blocked the gate of NCHC Amdalli."The protesters demanded action. The situation was addressed by the civil administration and local police. Senior

Naval personnel of Naval Base Karwar, the local tahsildar and Deputy SP engaged with the protesters and defused the situation by 12.45pm," a Navy release said. While the matter is under investigation, a few media reports blamed Navy personnel for the incident and local politicians also extended support to the agitators. The Navv responded, saying, "A lot of unverified and false statements are being made by reputed media houses. A minor incident occurred in Karwar, mainly to defame the Navy...The Navy remains committed to maintaining harmonious relations with the local community." Keep Taliban close, Afghan people closer

THREE-AND-A-HALF years after their takeover of Afghanistan, the Taliban are no longer the only militant group to have wrested control of an entire country from its legitimate government. The Syrian Hay'at Tahrir al-Sham (HTS) is the second fundamentalist Sunni group, also a designated terrorist group, to take over a country. Somalia's al-Shabaab was beaten back with Ethiopia's help, else there might have been three of them, but it's still not ruled out. The difference between Afghanistan and Syria is that the world is lining up already at the door of the HTS leader and de facto head Ahmed al-Sharaa. The French and German foreign ministers were first up. Known better by his nom de guerre Abu Mohammed al-Julani, he has quickly shed his combat gear for tailored suits, and has talked down the extremism associated with HTS, and his own al-Qaeda past, allaying fears — at least for now — of a second Afghanistan, a theocratic state, though the last word on this is yet to be spoken. America willing, HTS may soon lose its terrorist tag. The US has already removed its \$10-million bounty for him.

On the other hand, even by the duplicitous standards and shifting goalposts of geopolitics, no government has been able to find a good enough justification to put lipstick on the Taliban's gender apartheid. So, while many countries have diplomatic engagement with the regime, and some have full-fledged diplomatic representation, the Taliban might yet be beaten by HTS to formal recognition. In the end, it boils down to what the international community, and individual countries, decide to believe. At this point, India believes that the Taliban hold the keys to its security concerns on its north-western borders. That is why Delhi, which was silent on the Israeli strikes in Gaza that have now killed nearly 45,000 Palestinians, flattened homes, hospitals and schools alike, has found its tongue to condemn Pakistan's December airstrikes inside Afghanistan, apparently aimed at militants of the Tehrik-e-Taliban Pakistan (TTP), but killed 45 civilians instead.No doubt Pakistan-Afghanistan tensions helped the juices flow and set the stage for a "constructive" meeting two weeks later in Dubai between Afghanistan's acting Foreign Minister Amir Khan Muttaqi and India's Foreign Secretary Vikram Misri, the highest level of contact that India has offered the Taliban so far.But let's also keep our memories long. For all their apparent defiance of Pakistan, the Afghan Taliban retain many links to their first patron. Muttaqi, who grew up and obtained his Islamic education in Pakistan, and was part of the Balochistan-based Quetta Shura of the Taliban, continues to be personally invested in that country in several ways. So too other members of the de facto government.

Delhi's channels to the Haqqani network, which is blamed for the 2008 bombing of the Afghan embassy, may be out of a spy thriller, and inevitable, given Sirajuddin Haqqani's status as Afghanistan's interior minister. But the arrivals at the new international airport in Khost in Haqqani land are... who exactly? The Taliban's supreme leader Hibatullah Akhundzada, based in Kandahar, is in touch with the who's who of Pakistan. And despite the hostility, Pakistan's links with sections of the TTP go back a long way. So why did Pakistan take the extreme step of bombing Afghanistan's border badlands? Those who have observed the Pakistan military for years believe that the Army chief, Gen Asim Munir, is desperate to rekindle US interest in the AfPak region, the Pakistan military's cash cow for four decades until it dried up in the summer of 2021. ISI chief Muhammad Asim Malik's very public visit to Tajikistan, where the anti-Taliban Northern Alliance is based, and his meeting with President Emomali Rahmon may have been another smokeand-mirrors move that seems to have riled the Indian media more than anyone in Afghanistan. The Muttaqi-Misri photo op has similarly hit the intended audience. In the graveyard of empires, everyone is playing their own game, including the Taliban.

IMD at 150: Precision, progress & promise

EDITORIAL

The effect of climate change on the Indian monsoon is apparent more on the micro scale, like cloudbursts, intense precipitation, landslides, lightning strikes and urban flooding. The IMD needs to tackle these issues.

MANY government organisations are engaged in scientific research and several work directly for the welfare of the people. The India Meteorological Department (IMD) is unique in that it is mandated to do both. Another exclusive feature that distinguishes the IMD from other organisations is that it is required to make accurate predictions of the future. By 1875, India had 86 meteorological observatories The time scale ranges from the next few hours to days, months, years or decades and the space scale ranges from an airport or a village to a district, state, country, continent or ocean.

Established on January 15, 1875, the IMD has strived to harness the science of meteorology for the service of the nation through weather-monitoring and science-based weather and climate

Its activities have helped enhance farm outputs, manage water resources, ensure aviation safety and mitigate disasters. The IMD touches the lives of individuals, influences policy and helps envisage the future world. The IMD has, indeed, come a long way in its journey of 150 years. In the last decade, in particular, there has been a perceptible increase in the scope and precision of IMD's forecasts on all space and time scales. This is a visible outcome of the augmentation of IMD's techno-scientific base of advanced models supported by radars, satellites and supercomputers. The loss of life associated with tropical cyclones has been reduced from several thousands to near zero. Droughts and floods that are recurrent features of the monsoon have now become fully manageable.India's

prediction.

British rulers had a natural fascination for observatories: astronomical, seismological, geomagnetic and, of course, meteorological. For nearly 80 years before IMD came into being, local governments, railways and port authorities were weather. There were also numerous individuals who pursued astronomy and meteorology as a serious hobby. These included civilian and army officers, doctors, professors, geographers, sailors, surveyors and missionaries, who meticulously maintained meteorological records.n an exception, one of the earliest observatories in India was established at

Trivandrum not by the British but by the Maharaja of Travancore. India is, therefore, fortunate to possess meteorological records that span two centuries, constituting a valuable resource for climate change

and it was time to bring them together under the umbrella of a single agency. The Government of India decided to call it the India Meteorological Department, with a jurisdiction extending from Quetta to Rangoon and Leh to Colombo. It was to be



headed by the Imperial Meteorological Reporter to the Government of India. The designation was later changed to Director General of Observatories and again to Director General of Meteorology, reflecting the changing responsibility that the post carried.

setting up observatories for recording the It goes to the IMD's credit that it never worked in colonial style. Indian scientists were recruited by the IMD as early as in 1885 and Indians were occupying most of the senior positions by 1920. Much before India got independence, the IMD had an Indian as its head. Many British meteorologists in the IMD made seminal contributions to our understanding of the monsoon and tropical cyclones and several Indian

meteorologists in the IMD helped build new scientific institutions. The Sanskrit words 'Adityat Jayate Vrishtih' incorporated in the IMD's logo are taken from India's age-old wisdom literature. They assure us that as long as the sun shines, we will have our monsoon rains. However, it is also true that while the monsoon comes every year and has never failed to do so, it does not always give us its best.

Returning to the present times, it is of significance that the 2024 monsoon yielded an 8 per cent excess rainfall for the country as a whole, and it was very close to the IMD prediction. What is also important is the fact that since 2017, the monsoon rainfall has

> been normal, meaning that it has consistently remained within the margin of plus or minus 10 per cent of the long-term average. The year 2024 was the eighth year in this series of good or satisfactory monsoons.In parallel, India's annual foodgrain production shot up from 275 mmt in 2017 to a record-breaking 330 mmt in 2023 and is expected to surpass this figure in 2024. From the viewpoint of the nation's food security, this rise is very substantial.It is, of course, a result of sustained efforts in multiple areas, but it has once again highlighted the fact that the monsoon continues to hold a strong grip on Indian agriculture and, through it, on the overall economy. It also needs to be noted with caution that long epochs of successive good monsoon years have been very few historically. It will, therefore, be worthwhile to


attempt predictions of monsoon rainfall over longer time scales, like a decade or two, so that long-term policy decisions can be taken.

While the monsoon is under the constant shadow of climate change and concerns are expressed about its future, it seems to have been doing well so far in the overall scenario.

The effect of climate change on the Indian monsoon is apparent more on the micro scale. Situations like cloudbursts, extremely intense precipitation, landslides, lightning strikes and urban flooding are occurring with increasing frequency, causing severe damage to crops and property and loss of life.

ndia's most ambitious museum project will both be a challenge and a historic moment to showcase 'the timeless and eternal India.'

SOON, the burra sahibs of the British Raj, once ensconced in the North and South Blocks atop the What is a museum? It comes from the Greek word magnificent Raisina Hill, will squirm in their graves as their crown-crested chairs will be replaced by iconic Indian antiquities, like the Dancing Harappan Girl and the Chola Nataraja, among myriad others.

The upcoming National Museum (replacing the existing one) of India, to be called Yuga Yugeen Bharat (meaning 'the timeless and eternal India') Museum (YYM), is set to come up at the North and South Blocks as part of the Central Vista Redevelopment Project in New Delhi. The museum, making adaptive reuse of the existing structures, spreading over 1,54,000 sq m and having 950 rooms, will be the largest museum in the world. "It will be bigger than the British Museum in London and the Grand Louvre in Paris, which covers around 70,000 square metres," says a government note. This magnum opus would make India sit on the high table of culture in the world. However, the humungous task of setting up of such an ambitious and gigantic museum is at once exciting and challenging. It's not a simple task of commissioning a new building designed to a programme. It's a project to retrofit two separate blocks that have been built in hybrid neoclassical styles and for use as offices by our colonial masters. Converting them into a world class state-of-the-art national museum is a daunting task.

The challenges are at multiple levels, both functional and aesthetic. They entail massive architectural modifications and refurbishing of interior spaces to function as museum galleries. They will call for the best Indologists, museum exhibitors, art scholars, interior designers and numerous other related art experts to curate the content, to tell the narrative in an engaging, imaginative and interactive mode.

mouseion. It was used for ancient temples dedicated to the Muses, the patron goddesses of arts and sciences. The concept of the museum as a place for the public developed slowly. "Enlightenment ideals

and values — critical scrutiny of all assumptions, open debate, scientific research, progress and tolerance — have marked the museum since its foundation," says Susan A Sternau, an art historian.

There are numerous examples across the world of existing spaces being converted into museums. The two most iconic museums — the Louvre and Musee d' Orsay of Paris — were originally a palace and a railway station, respectively. While the Louvre is famous for its star exhibit of Mona Lisa painting by Leonardo da Vinci, the Orsay is redolent with its biggest collection of Claude Monets, Camille Pissarros and other world famous Impressionist artists. The Tate Modern at London, standing along River Thames, was created by converting an old derelict power station into an imaginative museum by architects Herzog

and de Meuron.

Before the 20th century, the preferred style for museums was neoclassical or Renaissance, celebrating grandeur and ceremonial language to convey its role as a temple of art. Museum design is a specialised field and some architects of the 20th century have created masterpieces of modern architecture. Museums, like the Guggenheim in New York designed by iconic architect Frank Lloyd Wright and the one at Bilbao by Frank Gehry, are works of sculptural art by themselves. For the YYM

project, let's examine the advantages first. The location is near perfect. For, what can be a symbolically more powerful message than that India holds its cultural and civilisational richness at the highest level, above the axis of state power, at Kartavya Path? The seat of Imperial hubris will now



be a temple of art, culture, democracy and diversity. Anyone passing by Vijay Chowk will view the YYM looming large, like a latter day Acropolis, as an embodiment of antique, beautiful and civilisational jewels of India.It will be the biggest gesture of decolonisation and dismantling of the erstwhile ensemble of brute Imperial power by the soft power of a nation aspiring to be Vishvaguru to a world torn asunder by wars, conflicts and confrontations.

It will also equip the high-security, 'no-entry' zone of the North and South Blocks with a magnificent plaza between the two, which will be accessible to the public, enabling an upfront view of the magnificent Indo-Saracenic hybrid architecture of Edwin Landseer Lutyens and Herbert Baker. The present cold space of state power will become a people's plaza — alive with art, colour and vibrancy that museum precincts the world over generate. The

imposing challenge of the project will be the retrofitting of the nearly 100-year-old buildings, ensuring structural safety for the country's jewels of antiquity and civilisational wealth for another 100 years. All building services will need to be upgraded to the-stateof-the-art levels, without tampering with or damaging the heritage interiors. Many clusters of smaller office rooms and warrens of service areas will have to be merged to create larger gallery spaces to showcase the priceless exhibits.

The YYM agenda is ambitious. Union Minister of Culture and Minister of Tourism Gajendra Singh Shekhawat states that it will "transcend the traditional museum experience and embody the spirit of inclusivity. It will be a museum of

the people, centring community narratives — a testament to India's legacy as the mother of democracy." In this context, the ministry recently organised an inter-ministerial stakeholder consultation and capacity-building workshop. India and France have signed a Memorandum of Understanding (MoU) for the development of the project as France is renowned for its expertise in such projects — exemplified by the Louvre, the Grand Palais, and the Hotel de la Marine.

Museums are integral to our cultural imagination and national identity. Let's not get this one wrong. May the timeless and eternal India shine.





Thick layer of fog, biting cold grip Delhi amid worsening air

NEW DELHI. The national capital woke up to dense fog and poor visibility, which disrupted operations of over 100 flights and 26 trains. While the minimum temperature dropped to 6oC, the maximum hovered around 18oC, the India Meteorological Department (IMD) said. Due to the severe cold, government schools that were scheduled to reopen on January 15 after the winter break remained closed. Amid sharp dip in air quality, GRAP-IV restrictions were reimposed.

Departures were briefly put on hold at the IGIA early in the



morning as low visibility conditions impacted operations. However, an update from the airport operator DIAL on X at 2.20 pm stated, "Runway visibility at Delhi Airport is improving, and flight operations are gradually resuming."

Several airlines, including IndiGo, Air India and SpiceJet, issued advisories, urging passengers to check their flight status before heading to the airport. Visibility significantly reduced during the morning hours, improved slightly during the day, but declined as the evening approached.On Tuesday, the MeT office issued an orange alert for dense fog and predicted rain, with cold weather expected to intensify

in Delhi, Noida, and Gurugram. The IMD indicated that similar conditions are likely to persist on Thursday morning, with a possibility of light rain in the evening or

Sisodia bungalow dispute: Delhi HC junks plea seeking action against CM Atishi

NEW DELHI. The Delhi High Court on Wednesday rejected a PIL that sought action against incumbent Chief Minister Atishi for permitting senior AAP leader and former Deputy Chief Minister Manish Sisodia and his family to continue using a government-allocated bungalow.A division bench comprising Acting Chief Justice Vibhu Bakhru and Justice Tushar Rao Gedela dismissed the PIL filed by Sanjeev Jain, who identified himself as a social worker and RTI activist. The court noted that if any regulations were breached in this matter, relevant authorities are fully empowered to take appropriate action when necessary."We do not find it appropriate to issue any orders in this petition. If any rules have been violated, the competent authorities are



fully capable of taking the necessary action as required. The petition is dismissed," the court stated.

The PIL referred to a government bungalow initially allocated to Sisodia, and later reassigned to Atishi in March 2023 after Sisodia's arrest in connection with the liquor policy case. The petitioner alleged that allowing Sisodia's family to remain in the government property amounted to a "clear misuse of government property", arguing that the action was "blatant violation" of established rules regarding the allocation and vacation of government properties. The plea suggested that Atishi's actions were possibly aimed at gaining favor within the party by showing loyalty to Sisodia, "a mentor in her political career." The plea claimed such practices involve misuse of government resources for personal and political benefit.

Delhi govt initiates drive to trace those not claiming Ladli Yojana benefits

NEW DELHI. The Women and Child Development (WCD) Department of the Delhi government has launched a

targeted initiative to ensure girl children enrolled in the Ladli Yojana, a flagship financial assistance scheme, receive their dues. The campaign focuses on tracing beneficiaries who have either not claimed their payments or failed to renew their applications.

Introduced on January 1, 2008, the Ladli Yojana aims to uplift girl children born in the national capital by offering term deposits at key milestones. These include Rs 11,000 for

hospital births, Rs 10,000 for home births, and Rs 5,000 upon enrollment in classes one, two, six, nine, and ten.A WCD department official revealed that nearly 1.86 lakh individuals enrolled in the scheme did not claim the benefits, In response, officials across Delhi's 11

ISRO's SpaDeX Mission Successful, 2 **Indian Satellites Dock In Space**

Organisation, the Indian space agency, Docking is a very complex process and succeeded in docking or mating two Indian satellites in space Thursday morning. This is part of the Space Docking Experiment or SpaDeX. This was the fourth attempt when Indian scientists finally hit Bullseye. At about 10 am ISRO announced Docking Success. "Spacecraft docking successfully completed! A historic moment. Let's walk through the SpaDeX docking process: Manoeuvre from 15m to 3m hold point completed. Docking initiated with precision, leading to successful spacecraft capture. Retraction completed smoothly, followed by rigidisation for stability. Docking successfully completed. India became the 4th country to achieve successful Space Docking. Congratulations to the entire

ISRO attempted it cautiously doing several trials over a fortnight.India used the indigenously developed Bhartiya Docking System to achieve this feat just before docking the satellites moved closer to each other at a speed of 10 millimeters per second.

ISRO succeeds in docking two Indian satellites in space orbiting at 475 kilometers above Earth. India becomes the fourth country after Russia, USA and China to have successfully learnt to dock. India launched the SpaDeX mission on December 30, 2024 using the PSLV rocket. Docking is an enabling technology for future missions like Chandrayaan-4 and Bhartiya Antariksha station.On January 12, 2025, when the last attempt was made, the satellites were moved had described as an "exciting handshake" of the two satellites in space. Then two Indian satellites came as close as three metres in a trial attempt for space docking and are now moving back, the Indian space agency said this morning.

"A trial attempt to reach up to 15 m and further to 3 m is done. Moving back space crafts to a safe distance. New Delhi. Jai Anant Dehadrai, the lawyer who last year accused a Trinamool MP of accepting bribes to 'target' the Adani Group, reacted Thursday to news Hindenburg Research - the United States-based short seller that alleged, with no apparent evidence, financial impropriety by the business giant - will be disbanded. before Trump takes office, the message couldn't be clearer: the attacks on Prime Minister Modi, the Adani Group, and India's stock market regulator (the Securities and Exchange Board of India) were not just about profit - they were part of a calculated and synchronised effort to sow instability in India," Mr Dehadrai alleged."But here's where it gets truly interesting. With (Hindenburg founder) Nate Anderson now fully exposed and in retreat - who were the crooked puppets in India who tried spinning a conspiracy-theory around the above mentioned entities?""Will the former MP who orchestrated many of these attacks in India, particularly against the Prime Minister, be fully investigated and subjected to a rigorous custodial inquiry and global financial audit?" he continued, claiming, "The money-trail from this individual will lead to some of the most notorious criminal entities to have ever existed - worldwide.

Woman dies by suicide, family alleges harassment by husband over English skills

NEW DELHI. A 19-year-old college student, Shahana Mumthaz, was found dead at her home in Kerala's Malappuram district, on the morning of January 14. Her family has alleged that harassment by her husband and in-laws over her complexion and limited English proficiency drove her to take her own life.Shahana, a firstyear BSc Mathematics student, had married Abdul Wahab, an Abu Dhabi-based worker, in May last year. According to her family, the couple



spent 22 days together after their wedding before Wahab returned to the UAE.

Shahana's uncle, Abdul Salam, claimed that

Wahab later began ignoring her calls and harassed her through text messages, allegedly criticising her appearance and language skills.

The family claimed that Shahana had sought support from her mother-in-law, who dismissed her concerns and suggested that Wahab deserved a partner who was "more mature and fair". Shahana was discovered dead at her residence on January 14. The Kondotty police have registered a case under Section 194 of the Bharatiya Nagarik Suraksha Sanhita (BNSS) and are investigating the circumstances surrounding her death.Shahana's last rites were held on January 15. The investigation is ongoing, and police have yet to comment on the allegations made by the family.

The story of how the two national parties got their new headquarters reveals not just their history, but their priorities. The BJP was in 1985 allotted a Type-VIII bungalow It was in 2016 that the BJP "begun to build at 11, Ashoka Road, which continued to be its head office till it shifted to the fivefloor building at Deen Dayal Upadhyay Marg in February 2018.

It took the BJP, which first tasted power in Delhi in 1996, less than four decades since its inception in 1980, to build a headquarters that took care of its modern-day needs, while the Congress kept adding rooms illegally to the 24, Akbar Road bungalow to house its functionaries. The appearance of the Congress office has "changed dramatically" over the years, and "its eight rooms have expanded to 34", writes veteran journalist and political commentator Rasheed Kiwai in his book 24 Akbar Road.

Lutyens' Bungalow Zone building, are illegal, writes Kidwai, "but successive political regimes have looked the other way". As the BJP was growing electorally, it felt the need for modern offices to facilitate

Can sadness leave you obese, diabetic or hypertensive? Yes, say doctors, whose research proves that heartbreak, career slumps and bereavement can kill

She started out dreaming of a bright career and love. At 25, she hanged herself. In her last letter, actor Jiah Khan wrote of the pain a failed relationship had caused, how it had "destroyed every bit of me, destroyed my soul" and why she was "running away from everything". Khan encountered a frightening enemy - the grief following a romantic breakup and stunted career - and found that she was unable to battle it. In a first of its kind study on the motivations for suicide, published in the official journal of the American Association of Suicidology, two were found to be universal: hopelessness and overwhelming emotional pain. Heartbreak, divorce, the loss of a job, terror attacks, communal riots and accidents - the modern world is fraught with incidents that leave you grieving. The reaction to it tends to be commonly marked by anguish, numbness, guilt and deep sorrow. Health professionals are concerned about the absence of adequate support the urban resident faces to cope with grief, thus jeopardising not just his mental but physical health, too.

Hidden risks

While anxiety and depression have been associated with grief, doctors warn that lifethreatening diseases like obesity, cardiovascular disease and diabetes are possible fallouts, too. An Italian study published in 2011 in the International Journal of Psychiatry in Medicine suggests a link between the death of a parent in childhood and obesity in adulthood.

Holly G Prigerson has spent more than 20 years studying grief. The director at the Centre for Psychological Epidemiology and Outcomes Research, Harvard Medical School says that empirical evidence demonstrates that intense grief (yearning for a dead loved one, dwelling in the past and failing to reengage with life) that persists for more than six months is an invitation for an adverse health outcome. "It can include a significant increase in alcohol and tobacco consumption, changes in eating and sleeping patterns, skipping work, high blood pressure, and even the incidence of cancer," she says in an email interview. In extreme cases, she has seen it leading to hospitalisation after a heart attack. "There is some evidence that grief affects blood clotting and predicts high blood pressure, which explains the heightened risk of heart attack," she says.

The mortality project

Dr Toni Miles, director at the Gerontology

Institute at University of Georgia, is heading an initiative called the Mortality Project, which trains the spotlight on life after death more specifically, health after death. "Our project asks, 'If you experience the loss of someone else, what does that do to your

Grief is now a public health issue, Dr Miles warns, in much the same way that infectious diseases are. "It is a mistake to separate negative emotion from physical illness. Depression causes changes in our body, and these are measureable. I suspect that being depressed for an extended time causes the injury. In our survey, we found that newly bereaved persons are more likely to be hospitalised during the year after a death." Which is why her claim that "(grief) kills people" has been recognised. Prolonged grief will now be listed as a new disorder in the International Classification of Diseases 11 (ICD 11). "Prolonged Grief Disorder is essentially a social attachment disturbance where those separated from a highly significant other feel intense emotional pain, abandonment and a yearning, craving to be reunited (explaining the suicide risk)," she

Call in support staff

Social support is one of the most important factors in recovery from grief. This can come from partners, family, friends, relatives, a

spiritual leader or a support group. "Indians shy away from seeking professional help. Seeing a behavioural expert is not the first move they'd consider. That's a mistake. If you sense you are unable to deal with your grief, and even close ones can't help, it's time to look outside," says Nagpur-based psychiatrist Dr Tushar Shinde.

Confirming perception that men and women handle grief differently, research suggests that men, who are used to emotional restraint, are more reluctant to address feelings of pain than women. In a paper published in The Review of General Psychology in 2001, psychologists at the University of Utrecht in the Netherlands revealed that widowers display a higher incidence of mental and physical illness, disabilities, death and suicide than widows. Women who lost their husbands spoke of "feeling abandoned or deserted", while men spoke of their loss as "dismemberment".

The way ahead

What will help cut down the sense of loss? The answer to that one lies in identifying the 'accurate' process of dealing with grief. Dr Shinde says processing grief needs time, patience and care. "Accept the loss, work through the pain, and learn to be without (the person, circumstance)."

Dr Miles raises a red flag when she says, "Often, people say there is nothing new about loss and depression. That grief is natural.

There is nothing to be 'done'. Our research proves there are several strategies to diminish the ill health effects of loss. Our goal is to identify effective ones."

Do it like Kia

Kia Scherr was in Florida for Thanksgiving when she heard that the Oberoi Hotel ir Mumbai had been attacked by terrorists. Her husband, Alan, 58, and daughter, Naomi, 13 were staying there. Hours later, she heard that both had been killed. A few days on, she stunned the world by saying in a press interview that she had forgiven the terrorists and felt compassion for those "so separatec from humanity that they would kill". Schen shares her 4 steps to tackling grief guideline.

I was open

Find support. I had multiple levels of it family, friends, and so many people whom had not met, but empathised. Everyone's wishes were sincere and heartfelt, and I felconnected to the world as a family. Even the funeral was taken care of for me. Things hi me only after everybody went home. I was left to deal with the pain.

> I didn't let it linger

Lingering grief is a private matter; unless you have gone through it, no one completely understands it. Emotion has a life of its own Grief can fester. You can numb it through alcohol or drugs, or you can try distraction (work, television etc). I understand why people go down that path. But repressing painful feelings does damage - it may seen good in the short term, but over the long run

I sought professional help

Grief doesn't go away on its own. You have to seek help. I went in for counselling sessions and meditation. My healing process started with setting up One Life Alliance, a peace organisation, but pain continues to engulf me at times. That I decided to return to Mumba was part of the healing process. My mother died of lung cancer two years ago, and I was with her through it. This may be ar experience that almost all of us go through a parent's death - but that doesn't mitigate the pain or loss.

> I connected with others like me Support groups are helpful because they bring together people who have suffered loss Life goes on for others, but someone who has experienced terrible grief needs support and

encouragement. Often, the loss is so immense that you have no words to express it. It's someone's presence that makes the difference. Be there for the person, show your love. Love makes all the difference; it has the power to make you sai through the roughest times.

US markets rallied on Wednesday."Wall Street rallied overnight following cooler-than-expected core December CPI data, with the US 10-year benchmark rate falling to 4.68 per cent from its recent high," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.Foreign Institutional Investors (FIIs) offloaded equities worth Rs 4,533.49 crore on Wednesday, according to exchange data.

Kalyan Jewellers shares under bear grip; fall 30 per cent in two weeks

NEW DELHI. Despite reporting a healthy outlook and strong business update for the recently concluded December quarter (Q3FY25), shares of Kalyan Jewellers, one of India's largest Jewellery firms, have come under a severe bearish grip.

The scrip has fallen about 30% in two weeks and on Wednesday it plummeted more than 10% intraday before settling 8% lower at R550 apiece. The sudden fall in share price has left many surprised. While most analysts believe that investors are booking profit after two years of strong run, a senior analyst said that there can be a possibility of shorting the shares by one or more than one entity based on the information that is not public.

To calm investors' nerves, Kalyan on Tuesday held an investors call. The Kerala-based firm reiterated that its business operations are sound and there is no FIR (First Information Report) filed against any of its promoters. The company attributed the decline in share price to market factors and emphasised that it has no direct influence on these fluctuations.

'With the stock having a stellar run in the past two years, the profit booking is evident from the shareholding pattern and also the monthly fact sheets of mutual fund houses which have been booking profit in the counter," said Akriti Mehrotra, Research Analyst, StoxBox.

TRAI proposes cut in broadband rates for public Wi-Fi



NEW DELHI. The Telecom Regulatory Authority of India (TRAI) has proposed reducing broadband connection rates for Public Data Offices (PDOs) under the PM-WANI scheme. According to TRAI's recommendation, the broadband tariff for PDOs should not exceed twice the rate

applicable for retail broadband services. This initiative aims to address the high costs that have hindered the growth of public Wi-Fi hotspots, which have fallen short of the government's targets. PDOs, typically local shops, retailers, and storekeepers are key players in deploying

public Wi-Fi hotspots under the PM-WANI program. "The Authority proposes a revised Draft Telecommunication Tariff (71st Amendment) Order, which prescribes that the broadband tariff (FTTH) for PDOs under the PM-WANI scheme should not exceed twice the tariff applicable for retail broadband (FTTH) services of corresponding capacity offered by service providers," TRAI stated in a press note.Launched in 2020, the PM-WANI scheme aimed to set up public Wi-Fi hotspots across the country through PDOs, which could even include

local kirana shops. The goal was to democratise access to the internet by offering affordable broadband through public hotspots. However, the program has struggled to reach its full potential due to the high cost of leased line connections charged by Telecom Service Providers (TSPs) and Internet Service Providers (ISPs) to PDOs.As of July 22, 2024, India has seen the deployment of

207,642 PM-WANI hotspots, along with 199 PDO Aggregators (PDOAs) and 111 app providers. Despite this progress, the number of hotspots remains far below the targets set in the NDCP 2018 and the Bharat 6G Vision documents. According to TRAI's calculations, internet leased lines (100 Mbps) cost 40 to 80 times more annually than retail broadband connections (100 Mbps).

Exports down for the second month in a row in December 2024

NEW DELHI.India's merchandise exports contracted 1% year-on-year even as imports rose 4.9% in December 2024, government data released on Wednesday showed. The trade deficit narrowed to \$21.94 in December month-on-month compared to \$32 billion in November as gold imports halved to \$4.7 billion. In November 2024, gold imports had surged 186% year-on-year to \$9.9 billion. In December 2023, the merchandise trade deficit was \$18.76 billion. Services exports during the month rose by 3.25% year-on-year, while imports grew 12%. Total trade deficit (merchandise plus services) widened to \$6.78 billion in December 2024 compared to \$2.76 billion in the year-ago period. Merchandise exports during April-December 2024 were \$321.71 billion compared to \$316.65 billion during April-December 2023. Merchandise imports during the period were \$532.48 billion compared to \$506.39 billion a year ago. Merchandise trade deficit during the nine-month period of the current financial year widened to \$210.77 billion from \$189.74 billion a year ago.

Career Beginnings After completing his studies, Anderson entered the world of finance and data analysis. His first role was as a factchecker at a financial data company, where he honed his skills in identifying inconsistencies and mistakes. This attention to detail would become crucial in his future career, particularly in his work as an investigative researcher.

Anderson's career also took him to Israel, where he worked for a technology company involved in financial data. This experience broadened his understanding of global markets and gave him valuable insights into how companies can sometimes exploit vulnerabilities. These early experiences laid the groundwork for his later work in identifying corporate fraud.

The Road to Hindenburg Research

In the early stages of his career, Anderson started a brokerage firm catering to hedge funds. The firm focused on offering due diligence services and fraud assessments. However, by 2017, the firm faced significant financial challenges, amassing just \$58,382 in net capital, and Anderson's landlord initiated eviction



proceedings. This financial strain led Anderson to make a pivotal decision: he decided to forgo his brokerage license and founded Hindenburg Research.The name "Hindenburg Research" was chosen deliberately, drawing inspiration from the 1937 Hindenburg airship disaster. The name symbolised Anderson's aim to uncover companies that were at risk of disaster, whether due to fraud, mismanagement, or deceitful practices. The firm's mission was clear: to act as a watchdog, ensuring that public companies were held accountable and

Under Anderson's leadership, Hindenburg Research became known for its aggressive and thorough investigations into companies, particularly focusing on fraud and corporate malfeasance. While Anderson's work has earned him a reputation as a financial truth-teller, he has also faced criticism. Once he learnt the news, Sanjeev didn't even give himself enough time to recover. Instead, with the Senior Women's One Day Trophy on the horizon, he began taking Shafali for practice. Now, yet again, at Rohtak, Sanjeev ensured her daughter got back on her feet immediately.

populous cities: report



very fourth child in the 10 most-populous Indian cities has stunted growth and development due to malnutrition, according to a report released on Wednesday.

Across the 10 most populous cities, the prevalence of stunting is 22.3 per cent and of being underweight (low weight for age) is 21.4 per cent among under five children. Overall, 13.8 per cent children below five years are wasted (low weight for height) and 15.7 per cent newborns have low birth weight at less than 2.5 kg.

In an example of 'double burden of malnutrition' (coexistence of undernutrition and obesity or dietrelated non-communicable diseases), 2.4 per cent of children were found to be overweight.

The prevalence of overweight children ranges from from 0.7 per cent in Hyderabad to 3.7 per cent in Chennai, higher among children from the highest wealth quintile.

The Urban HUNGaMA (Hunger and Malnutrition) Survey Report was released by the Citizens Alliance, led by young parliamentarians, and the Naandi Foundation on Wednesday. The survey is based on a systematic sampling methodology covering 12,000 households and was conducted during April-July 2014 across Mumbai, Delhi, Bengaluru, Hyderabad, Chennai, Kolkata, Pune, Surat, Ahmedabad and Jaipur.

The city-wise data shows that Chennai fares relatively better across all three indicators. The prevalence of stunting ranged from 14.8 per cent in Chennai to an alarming 30.6 per cent in Delhi. Mumbai has the highest proportion of wasted children at 19 per cent, Jaipur has the lowest at 10.8 per cent; Hyderabad has the highest number of underweight children at 25.8 per cent and Chennai the least at 13.5 per cent.

The study shows that overall malnutrition is significantly higher among children whose mothers had five years of schooling or less and among households in the lowest wealth quintile. Rohini Mukherjee, who led the survey team for Naandi Foundation, said that the existing NHFS 4 (National Family Health Survey) district-level data does not have disaggregated data for urban and rural areas within each district.

"We therefore had to undertake a fresh survey covering a random sample of 12,286 mothers and 14,616 children under five years," she said. Manoj Kumar of Naandi Foundation said that the three underlying reasons for the prevalence of malnutrition are "the poor status of women, prevalence of household poverty and lack of government service delivery centres." BJP MP Poonam Mahajan, who was present at the release, said while it was always known that malnutrition was chronic in districts such as Palghar and Thane, it was shocking that even Mumbai fared so
