Hasina has been living in India since August 5 last year when she fled Bangladesh following a massive student-led protest that toppled her Awami League's 16-year regime. "I am suffering, I am without my country, my home, everything has been burned,"

said Hasina. Hasina survived several attempts on her life including that of the August 21, 2004 grenade attack on a party rally where she was addressing as the opposition leader. Twenty-four people were killed in the attack. In 2000, Hasina, then the prime minister of Bangladesh, was scheduled to speak at a rally in Kotalipara Upazila, Gopalganj District when police discovered a time bomb weighing 76 Kg 50 feet from the stage.

New Delhi, Jan. 18: The Delhi election campaign is tinged with saffron as a jostle is on between the ruling AAP and the opposition BJP to become the biggest benefactors of the priests and the like. So far in the run-up to the February 5 election, the Aam Aadmi Party has been seen to be coasting along a religious course, in an apparent bid to force the BJP, a Hindu hardline party, to defend its turf. The Arvind Kejriwal-led AAP recently announced a monthly honorarium of Rs 18,000 to temple priests and the granthis of gurdwaras under a "Pujari Granthi Samman Yojna" - to be implemented if the party returns to power in Delhi. The BJP, in its turn, is likely to announce 500 free units of electricity monthly to worship places, including temples and gurdwaras. Both parties have accused each other of shortchanging the poor and marginalised Hindus while patronising the illegal migrants to beef up a vote bank. Recently, while addressing a rally at the city's JLN stadium on the first anniversary of the consecration of the Ram temple in Ayodhya, Union Home Minister Amit

Shah raised the slogan "Jai Shri Ram" and urged was verifying voters in the Valmiki Mandir area but the slum dwellers to become Delhi's "liberators" by changing the government. The BJP accused the



ruling party of filing applications for the deletion of the names of 44 voters in the Valmiki Mandir area, accusing Kejriwal of being "anti-Dalit." On January 14, BJP's Parvesh Verma, pitted against Kejriwal from the New Delhi constituency, alleged that the Election Commission "at the instance of Kejriwal,"

Former Delhi deputy chief minister Manish Sisodia, after being fielded from Jangpura went on a visit to several prominent shrines, including Vaishno Devi in Jammu. He too sought the blessings of Kali before filing his nomination papers. Sisodia started his campaign in Jangpura after a Hanuman Chalisa recital at Anguri Devi Mandir in the Kilokari area of the constituency. All these temple visits were widely publicised through social media by the party.

The AAP has also appointed office bearers for the "Sanatan Sewa Samiti," which is supposed to oversee the implementation of its grant scheme. The BJP has fielded its Mandir Prakoshth head, Karnail Singh, from Shakur Basti against AAP leader and former minister Satyendar Jain.

UP govt proposes 'no helmet, no fuel' policy to curb road accidents ST Correspondent

Lucknow, Jan 18: The Uttar Pradesh Transport Department has proposed a strict 'no helmet, no fuel' policy across cities in the state in an effort to reduce road accidents and fatalities involving two-wheelers. Transport Commissioner Brajesh Narain Singh issued an official letter on January 8, directing the fuel station operators not to sell fuel to two-wheeler riders, who were not wearing helmets, including the pillion. The letter sent to the District Magistrates of all 75 districts in the state and also marked to the Divisional Commissioners, emphasising the urgency of the measure, citing data that showed a significant number of two-wheeler accident victims did not wear helmets. It also highlights directions issued by Chief Minister



Uttarakhand's first modern madrasa to offer NCERT curriculum

Dehradun, Jan. 18: The Uttarakhand Waqf Board has set up the state's first modern madrasa offering general education under the NCERT curriculum with Sanskrit as an optional subject besides Arabic. Dr APJ Abdul Kalam Modern Madrasa has been developed by the board at a cost of around Rs 50 lakh and will commence classes from the next academic session in March, Uttarakhand Waqf Board Chairman Shadab Shams said. The madrasa located at the Muslim Colony near the railway station in Dehradun, he said. Shams said of about 10 madrasas located in the areas around the colony, this madrasa, has been improved with infrastructure, including well-equipped classrooms, furniture, computers and smart boards. Students from the nearby madrasas will be brought here for consolidated education, the chairman said. He said the Waqf Board plans to modernize eight to 10 madrasas in the state by the end of the year and the smaller madrasas in the surrounding areas will be merged into a central facility located at the best location. He said, "This will streamline the management and the Waqf Board will be able to use the vacant properties to increase its income."

Suspect detained at Chhattisgarh's Durg railway station

Raipur, Jan 18: A 31-year-old man suspected of stabbing Bollywood actor Saif Ali Khan has been detained by the Railway Protection Force (RPF) at Durg railway station in Chhattisgarh, officials said. A picture of Akash Kanojia, who has been detained on Saturday from Chhattisgarh's Durg railway station in connection with actor Saif Ali Khan attack case. Khan, 54, was attacked multiple times by an intruder during an attempted robbery at his 12th-floor residence in Mumbai's Bandra area early Thursday morning. Doctors treating Khan have reported that the actor is recovering from his injuries. The suspect, identified as Aakash Kailash Kannojia, was travelling aboard the Jnaneshwari Express, which operates between Mumbai Lokmanya Tilak Terminus (LTT) and Kolkata Shalimar. What went inside court room where Sanjoy Roy was held guilty

Kolkata, Jan 18: Sanjoy Roy, who was standing in the witness box on the right side of court room facing the judge, pleaded innocence and maintained that he was being framed. Kolkata: A court in Kolkata pronounced Sanjoy Roy, the only accused in the August 9 rape and murder of a trainee doctor at RG Kar Medical College and Hospital, as guilty on Saturday. The quantum of sentence would be announced on Monday afternoon. Police personnel and media persons wait outside Sealdah court ahead of RG Kar rape-murder case accused Sanjoy Roy's appearance, in Kolkata on Saturday. The maximum punishment for sections 64 (rape), 66 (inflicting injury leading to death or cause the woman to be a persistence vegetative state) and 103 (1) (murder) of the Bharatiya Nyaya Sanhita (BNS) under which Roy has been found guilty could be life imprisonment or death. "You have been accused of attacking the victim in the RG Kar Hospital, throttled and strangulated her to death. You have sexually assaulted her. Charges have bene framed. After taking into account of witnesses and documents it has been proved. The court finds you guilty," Justice Anirban Das, additional district and sessions

judge said in a packed room. Roy, who was standing in the witness box on the right side of court room facing the judge, however, pleaded



innocence and maintained that he was being framed. "I am innocent. I have a Rudraksh garland around my neck. Had I committed the crime it would have snapped that day. I am being framed. Others who were there have not been questioned," said a visibly agitated Roy, as his counsel intervened to calm him down. The

court declined to hear Roy saying that he would be heard at 12.30pm on Monday before the quantum of sentence is read out around 2.30pm

later that day. Roy, who wasn't keen on stepping down from the witness box, had to be forcefully taken out by the police from the court room. "The CBI and the advocates have been able to

prove that you are guilty. You have to face the punishment. The quantum of punishment will be announced on Monday," the judge said. Roy, who was wearing an ashcoloured hoodie, was brought to the Sealdah

amid tight security with hundreds of policemen forming multiple layers of barricades. People who had gathered outside the court could be heard debating in a hushed tone whether Roy was the real guilty or being made scape goat and whether he could be pardoned if he moves the higher court. Court room number 210 on

the second floor of Sealdah court, where the hearing was scheduled to be held, was packed with lawyers, policemen and media. The judge, on entering the court room around 2.15pm directed that the accused be brought to the room. As cops were having a tough time to make space for the accused, the judge warned that if he would be forced to hold the proceedings in-camera as the safety and security of the accused was a priority. Roy was brought inside the court room around 2.23pm. Soon after the proceeding started the judge first asked the counsels of all sides whether there was any stay on the case by the Calcutta high court or Supreme Court. The proceedings started at 2.30pm as scheduled when the counsels answered in a negative. The judge also said that the order has been prepared with his observations under various subheads dealing with profile of the victim, who discovered the body, cause of death, whether she was murdered and sexually assaulted, whether one or more persons were involved. "In some portions I have also criticised the role played by the police and hospital authorities. The case stands on circumstantial evidence. The chain of events and some activities by the hospital authorities raised some confusions in my mind. I have addressed them in the order," the judge said during the proceeding which lasted for just 5 minutes. The victim's parents who were seated on a bench in the court room stood up after the verdict was pronounced and Roy was taken away by the cops. The victim's father thanked the judge with folded hands as he broke into tears. "Judge saheb we had kept our faith on you. You have kept its honour. We want to thank you," the victim's father told the judge. "We had charged Roy under sections 64, 66 and 103 (1) of the BNS. The court has found him guilty under all the sections. The sentence will be announced on Monday," said Partha Sarathi Dutta, CBI's counsel. Under section 64 of the BNS the minimum punishment is not less than 10 years of rigorous punishment which may extended up to life imprisonment. The punishment for crime under section 66 may go up to life imprisonment or death and for 103 (1) is either life imprisonment or death. Junior doctors, who had ceased work and held a hunger strike for more than a month last year demanding justice for the victim, said that justice won't be meted out until all the questions and allegations are answered. "We still believe that more than one person was involved and evidence was tampered during the investigation.

Seven-year-old boy with special needs found dead in Bengaluru lake

BENGALURU. A seven-year-old boy with special needs, who went missing from his Gempark Layout residence in Sarjapur in Bengaluru Rural district on Thursday afternoon, was found dead in a nearby lake around 11.30 am on Friday.

Elvin D'Souza was riding his cycle outside his house around 2.30 pm on Thursday. His mother was with him, but she went inside the house as a washing machine technician had come for repair. When she came out around 3 pm, she could not find her son. She and her mother started searching for



him in the locality. As he was not found, his father filed a missing complaint in Sarjapur police station. The police checked the CCTV footage of where he was last seen in the vicinity, near Pushpam Lush County Recreational Area in Gudigattanahalli, which was close by to his house. He was seen near a water tank till 2.44 pm. Later he could not be sighted. The boy's pictures were also circulated on social media in an effort to trace him, asking public to contact his parents if they found the boy. The Sarjapura police, who have registered a case of unnatural death, are checking if there was any foul play behind the death. Further investigations are on.

PIL on stampede: Andhra Pradesh HC posts matter next week

VIJAYAWADA. The Andhra Pradesh High Court bench of Justice Kanchireddy Suresh Reddy and Justice Kuncham Maheswara Rao on Friday upheld the court registry's objections over inclusion of names of the Chief Minister and the Governor's Secretary in the Public Interest Litigation (PIL) seeking the court's intervention for a judicial inquiry into the Tirupati stampede, in which six devotees were killed and 40 injured. The bench posted the matter next week for further hearing and instructed the petitioner to submit the updated petition removing the names.A farmer from Pandurangapuram village in Kurnool district has filed the PIL urging the court to issue necessary orders for a probe.

Siva Prasad Reddy, the petitioner's counsel, presented his arguments requesting the court to allow the petition as the lunch motion petition as this was the second incident where people died in stampede during the TDP government, headed by Chief Minister N Chandrababu Naidu.He also held that Naidu should take moral responsibility for the stampede. However, the bench upheld the exclusion of names of the Chief Minister and the Governor's Secretary from the list of respondents in the petition.

Study reveals low helmet compliance among adult motorists in Tamil Nadu, with only 1 in 4 wearing helmets

CHENNAI. Only one in four adult motorists riding two-wheelers in seven districts of Tamil Nadu, including Madurai and Tiruchy, wears a helmet, a study has found.

Tiruvarur and Tiruvannamalai are the other five districts where helmet compliance among adults is below 25%, according

to the study conducted by Citizen 🍃 Consumer and Civic Action Group (CAG)

The highest compliance of around 75% was observed in Coimbatore and Tirunelveli, while in Chennai and Salem, the compliance rate was above 50%. The highest rate of compliance among children was observed in Salem and Tirunelveli districts, the report said. According to the study, the overwhelming belief by the riders on their ability to avoid road accidents

and the general perception that helmets were unnecessary for short trips are the major reasons for the non-use of helmets. Parents transporting children to schools displayed the lowest compliance, the report said. The CAG carried out the study at two traffic intersections each in 11 districts of Tamil Nadu in November 2024. In absolute numbers, 1,729 adults were observed in Chennai, of them, 1,023 were found wearing helmets. In Coimbatore, 2,565 of the 3,320 observed adults wore helmets.

However, the numbers were drastically low in

districts like Madurai where only 242 of 2,034 observed adults wore helmets. Besides Madurai, compliance was also lower in Kancheepuram and Tiruvannamalai districts. Chengalpattu, Kancheepuram, Cuddalore, The low compliance among adults directly influences the low or nearly non-existent helmet use among children, the study



said. The compliance among children was negligible in Tiruchy, Madurai, Chengalpattu and Kancheepuram districts. In Chennai, too, Fact file it is below 25%, said the report.

'Only 63% pillion riders follow regulations' Contradicting the Greater Chennai Traffic Police reports of substantial helmet compliance rate among motorists, the study mentioned that only 63% of the people riding pillion adhere to the regulations. Though Chennai recorded 3,654 road accidents involving two-wheelers in 2024, the fatalities due to non-usage of helmets was only nine of the 504 deaths, said the report. The highest fatalities due to non-use of helmets was reported from Cuddalore (84), followed by Kancheepuram (31), Chengalpattu (15) and Coimbatore (15), it added.Enforcement of regulations, coupled with educational initiatives significantly enhances the

effectiveness. Conducting joint campaigns was found to be eight times more effective than enforcement and 12 times more effective than education, CAG said. The report suggested that the state must ensure standard helmets are widely available and affordable, especially in rural and low-income areas. Likewise, standards must be developed for lightweight and climateappropriate helmets that can address common complaints about discomfort, it added.Strategies to overcome resistance to helmet use in India include promoting helmet designs suitable for Indian

weather conditions, the report added.

TN witnessed a daily average of 50 fatalities due to road accidents.Two-wheelers accounted for 44.22% of all road accident fatalities.A total of 29.9% of such fatalities involved individuals not wearing helmets.

Coimbatore, Tirunelveli, Salem and Chennai districts have the highest helmet compliance levels among adults.Salem and Tirunelveli districts have the highest helmet compliance levels among children.

India's banking sector needs market-friendly reforms: New York University don Viral Acharya BENGALURU. India's banking

sector must undergo marketfriendly reforms instead of reforms that favour incumbents, said Professor Viral V Acharya, CV Starr Professor of Economics at New York University Stern School of Business, during his keynote address at IIM Bangalore on Friday. Speaking at the inauguration of the IMR Doctoral Conference 2025, Prof Acharya laid out a roadmap for the future of India's banking system, stressing the importance of addressing both economic and political factors in driving long-term reforms.

Prof Acharya emphasised that while the economic backdrop plays a significant role in shaping the banking sector, it is the political economy that also drives its trajectory. "The banking system in India is steered not by the economic backdrop alone, but by the political economy of banking as well."He explained that the nationalisation of banks was not solely a measure for financial inclusion, but also a political strategy. "It is a misconception that banks in the country got nationalised for financial inclusion, there was the realisation of political objectives as well. Very often, banks are used by the government to achieve delivery of populist expenditure."

Discussing the evolution of India's banking sector, Professor Acharya outlined how the system had stabilised over the past decade following the financial excesses of the preceding years, especially after the Global Financial Crisis.

One of the key points in his address was the discussion on digital finance, where he commended India's approach. "India got this right from the very beginning. Digital finance got a big boost post-Covid," he said.

Furning to broader economic concerns, Prof Acharya addressed the issue of concentrated wealth in India, particularly the 'savings glut of the rich.' He explained how the wealth gap has led to an imbalance in economic benefits.

Poor app engagement 'times out' Supplyco's delivery service

KOLLAM. Supplyco has discontinued its Supply Kerala delivery service introduced to offer doorstep delivery of essential goods. The service was phased out due to limited customer engagement with the app for online purchases.Launched by the civil supplies department, the Android app aimed to ensure fast delivery of essentials, particularly in rural areas. However, it garnered just three orders and fewer than 500 downloads over the past three years. Via the app, customers could place orders by selecting their nearest Supplyco outlet. The distribution network of over 500 Supplyco supermarkets across the state was expected to create job opportunities for more than 10,000 youth.Additionally, the app provided information on newly launched products. Despite these features, the app was removed from the Play Store after failing to gain traction among users.

"In the past three years, we have received only three orders through the app. After the first six

garbage collection after Pongal holidays

COIMBATORE. The Coimbatore City Municipal Corporation (CCMC) has been caught napping as a majority of sanitation workers are yet to report for work after the Pongal holidays. As a result, garbage collection and disposal work have been severely affected. With door-to-door garbage collection also affected, residents slammed the civic body for not making alternative arrangements during the holidays.The CCMC engages more than 3,000 sanitary workers in door-to-door collection in 100 wards of the city, but a majority of them did not report for work on Thursday after the festival holidays. Due to this, garbage has not been collected and waste has piled up on the roads in several localities, including Kavundampalayam, Vadavalli, Ramanathapuram and Kuniyamuthur.

Many residents said the problem is a recurring issue during festival seasons. "This happens every year. It's not just about the holidays; it's the lack of preparedness by the CCMC," said K Ramesh, a resident of Kavundampalayam. "We are paying taxes which includes dedicated charges for garbage collection and disposal



services. But garbage collection is often neglected. It's unbearable to live near these garbage dumps.Sanitary workers haven't shown up in our area for the past four days."

Adding to the woes, the delayed resumption of waste collection services has disrupted the daily lives of traders and they have raised concerns. "Customers avoid coming to our shops because of the stench. If this continues, it will hurt our livelihoods," lamented S Kavitha, a shop owner on Raja Street.Health experts have also warned about the potential outbreak of diseases

due to the unhygienic conditions. As the garbage piles grow, residents hope for swift action from the civic body to restore cleanliness and prevent similar situation in future.When contacted, CCMC Commissioner M Sivaguru Prabakaran said, "I was told that a few sanitary workers hadn't returned to work after the festival which has affected the garbage collection work. I've instructed them to report back to their duty immediately. They will all return tomorrow (Saturday) and the problems will be addressed in the next two days."

Demolition of building housing Ernakulam KSRTC bus station to begin soon

KOCHI. The demolition of the over fivedecade-old building that still houses the Ernakulam KSRTC bus station will get under way soon, and a new terminal, to be modelled after the Vyttila Mobility Hub, will be set up on 2.9 acres of land at Karikkamuri.

However, no ownership of land will be exchanged with the Vyttila Mobility Hub as decided earlier. This was decided at a high-level meeting led by Industries Minister P Rajeeve and Transport Minister K B Ganesh Kumar in Thiruvananthapuram."The order directing demolition of the old building will be issued next week. The tender process will be completed on a war footing and the demolition will begin thereafter," said P Rajeeve, who is the minister in charge of the district. However, it was decided that the ownership of land at Karikkamuri and Vyttila



won't be exchanged.Earlier, it was agreed that the right of possession of the proposed land at Karikkamuri, owned by KSRTC, would be given to the Vyttila Mobility Hub, and in exchange the corporation would get certain land at the Vyttila Hub.

The change will be incorporated in the Memorandum of Understanding as well," he said.A new swanky bus terminal will be set

up in the adjacent Karikkamuri on the model of the Vyttila Mobility Hub. For this, 2.9 acres of land there will be handed over to the KSRTC. The KSRTC will be exclusively given the rights over six bays in the new terminal, which will also have facilities like Station Master's Office and the facilities for employees. The KSRTC will be exempted from paying the user fee. All revenue modes will be explored to generate income from the new terminal. The new building will have a waiting area, various kiosks for medical shops and refreshment stalls, a drop-off area for passengers, separate entry and exit points for private vehicles, and proper drainage facilities, besides other facilities for passengers. At Vyttila hub, the KSRTC will be given the right of operation and also the facilities for the Station Master office. The new terminal can be accessed by both private

and KSRTC buses.

Exams just wks away, 800 students left in lurch as FIITJEE centre shuts

Ghaziabad. The sudden closure of a FIITJEE coaching centre at Rajnagar District Centre has left more than 800 engineering aspirants in a precarious situation, with crucial JEE (Mains) and board examinations merely weeks away. On Monday, an FIR was registered against the chairperson and three other officials

of the coaching centre following allegations that the facility was operating without proper registration before shutting down unexpectedly — leaving hundreds of students stranded in the middle of their syllabus.

Parents who have paid substantial advance fees upto Rs 5 lakh — are now concerned about their children's academic future, with an additional financial burden to secure an admission for them in alternative coaching centres.

Ashish Tyagi — a resident of Raj Nagar whose son Aarush is scheduled to appear for JEE Mains on Jan 23 and board examinations on Feb 15 - expressed concern about whether the student could complete his syllabus and obtain

adequate practice."My son is anxious since his teachers left the coaching centre last month. While one teacher has been kind enough to assist him personally, we cannot depend entirely on this arrangement," said Tyagi, who invested Rs 3.6 lakh in a two-year programme at FIITJEE.Ridhima Arora



from Raj Nagar Extension, who paid Rs 5 lakh for her daughter's four-year classroom package last year, said, "The institute collected a lumpsum for four years. I'm waiting for the management's response before deciding on alternative arrangements."Some local coaching

institutes are offering mid-session admission options for the affected students, but at a considerable expense. Manish Gupta, whose son is in Class 11, was equally worried. "We paid Rs 4 lakh for four years, and now my son's preparation is completely disrupted. Most established institutes have already

completed their syllabus by now. But here, we are left with limited options," he added.Cherry Kansal, another affected parent from Raj Nagar who paid Rs 3.6 lakh to FIITJEE, has filed a complaint with the consumer forum, hoping to recover the fees."The coaching centre management never informed us about the situation. We learnt about it only when some senior teachers announced their plans to leave the institute last Friday," she added

HR Kapoor, who invested Rs 3.5 lakh for his two children's education at FIITJEE, highlighted the financial strain. "Finding alternative coaching at this stage is both expensive and challenging. Most institutes are asking for full-year fees even for midsession admissions. Plus, there's uncertainty about recovering our money

from FIITJEE," said Kapoor, a Shastri Nagar resident.

Dharmendra Sharma, the district inspector of schools, said it was up to police now to take action against the officials.

We have already filed a complaint with police and got an FIR registered against four senior officials. We have 42 registered coaching centres in Ghaziabad. We plan to conduct a district-wide survey to identify unregistered institutes," he added.A senior officer at Kavinagar police station said they had initiated an investigation. "As of now, we are recording the statements of parents. We will take action in keeping with the findings of the investigation," he added.

Ashish Gupta, the FIITJEE centre incharge, told TOI the company's legal team was looking into the allegations. "We are cooperating with police in their investigation."The Ghaziabad Parents Association (GPA), meanwhile, has reached out to the chief minister, seeking action against coaching centres running without papers. "We have requested the formation of a committee under the district magistrate to regulate coaching centres and ensure compliance with rules," said Vivek Tyagi of the association.

News box Short circuit in 1 parked car burns down 3

Ghaziabad. Three cars parked on a vacant plot in Masuri's Kushaliya village were gutted in a fire that broke out early on Friday morning. The cars — two Balenos and one Brezza - belonged to a former village pradhan, Sahid Umar Khan, and his brother Kabir, and were parked next to each other. The other vehicles parked nearby were not damaged in the blaze. A complaint was submitted by the brothers claiming foul play.

Sahid told TOI his family, like many other neighbours, usually parked their vehicles on the plot next to their house. "Around 11.30 pm, I had seen off some guests and then retired to bed with the rest of the family. About an hour later, a

neighbour woke me up and informed me about the fire. We alerted the fire department and, in the meantime, tried to douse the fire using water



from a submersible," he said, adding that only three cars belonging to his family was gutted in the fire, while the other cars were untouched.ACP Masuri Siddharth Gautam said they received a complaint and subsequently an FIR was registered against an unknown person under BNS Section 324 (4) (mischief causing damage to the amount of Rs 50fifty rupees)."The forensic analysis indicates the fire was sparked by a short circuit in the Baleno, which was parked between two other cars. The flames spread quickly and engulfed the adjacent vehicles," the ACP said.Chief fire officer Rahul Pal said the fire was doused completely within an hour.

Three Chinese men held for overstaying in Noida

Noida. Three foreign nationals were arrested on Friday for illegally residing in the country after their visas expired. The arrested individuals were allegedly staying at a mobile phone company's underconstruction plant in a Greater Noida village.

Additional deputy commissioner of police Ashok Kumar said, "The visas of the suspects - Wu Xingbo, Chen Chao and Peng Shao - expired a few months ago. All of them are Chinese nationals. They were arrested and information is being sent to the embassy in Delhi for necessary action."Kumar said the suspects were arrested by officials from the Noida SWAT Team, FRRO Team and Rabupura police station personnel."Officials from the SWAT Team and Rabupura police were conducting checks in Kheri Bhav village and found the foreign nationals residing at the plant being built there," he said.

Police told TOI that the arrested suspects are construction engineers and arrived in the country about two years ago. One of them worked with a mobile phone company and then they all moved to a construction company, Sausam, tasked with building the new mobile phone company plant in Kheri Bhav village. They were still working and living at the plant even though their visas expired three or four months ago, police said.

Guzzling groundwater: Gurgaon extracted from aquifers double of what it recharged last year

GURGAON. The city withdrew more than double the amount of groundwater it could naturally replenish last year, extracting 212% of the permissible limit, data released by the National Compilation on Dynamic Groundwater Resources of India showed.

While the city's sustainable annual groundwater extraction limit is 20,333 million-hectare metres (ham), it ended up withdrawing 43,262 ham in 2024. This extraction rate was the third highest in Haryana, following Kurukshetra (228%) and Panipat (222%). Kaithal (190%) and Faridabad (180%) were close behind. Palwal demonstrated better resource management with an extraction rate of 94.5%, significantly lower than neighbouring Faridabad. Other districts showing critical levels Only 36 units (25.1%) fell within the

included Fatehabad (177%) and districts such as Hisar (88.6%), Panchkula (62.3%), and Rohtak (51.1%) maintained safer extraction levels.

The state's overall groundwater extraction rate showed a slight increase from 135.7% to 136% over the past one year. Canada ups the ante, warns of 'biggest trade war' over Trump tariff threat

Canadian PM Justin Trudeau said that if a "worst-case scenario" trade war ensues between the US and Canada, Ottawa won't hesitate to take strong retaliatory measures.

World. Canadian Prime Minister Justin Trudeau vowed to hit back if incoming US President Donald Trump follows through on his threat to impose punishing tariffs on Canadian imports, warning that such a move could trigger the biggest trade war between the two countries in decades."No

one wants to see US tariffs imposed on our goods. But Canada will be ready with a national response if we need one,' Trudeau said on Friday at a meeting of the newly created Canada-US Relations Council.

The 18-member body, composed of representatives from the auto industry, unions, agriculture, and other sectors, was assembled to bolster Canada's strategy in dealing with Trump's policies.

We've brought leaders in business, labour, and policy to the table. People from different fields, parties, and parts of the country - all on Team Canada," added Trudeau, who recently resigned as Prime Minister.Canada sends 75 per cent of its exports to the US, and the proposed tariffs could have a devastating economic impact on both countries. Trudeau stated that if a "worst-case scenario" trade war ensues, Canada won't hesitate to take strong retaliatory measures."If push comes to shove, we will be strong and unequivocal in



our defence of Canada and Canadians," he said.Canadian Foreign Minister Mélanie Joly echoed the stern sentiment, warning of immediate counter-tariffs. "The Americans would be starting a trade war against us. We are ready to put maximum pressure," she said during a press meet in Washington.

We have a series of measures that are already prepared, certainly, tariffs linked to imports," Joly said. "If the President goes ahead on Monday, we will be ready. And we are ready for a second round and a third round."According to a report by Radio Canada, the Trudeau government is

planning a first round of reciprocal tariffs that could be unveiled as soon as Trump is sworn in on January 20. An initial round of counter-tariffs will reportedly target \$37 billion in US goods, with additional measures prepared to affect up to \$110 billion if necessary. The countermeasures are designed to minimise harm to the Canadian economy while demonstrating the cost of a trade war to the US. Trump, set to return to the White House next week, has made clear his intention to impose 25 per cent tariffs on Canada as part of a broader economic policy targeting key trading partners like Mexico, China and India. He argues the measures are necessary to tighten border security and curb entry of drugs like fentanyl into the United States.

Trudeau has dismissed the premise, maintaining that less than 1 per cent of irregular migrants and fentanyl flowing into the US come from Canada. Ottawa also recently announced a C\$1.3 billion (\$909 million) border security plan in response to Washington's concerns.

Biden commutes sentences of 2,500 non-violent offenders in a day, sets record

Washington. President Joe Biden on Friday commuted the sentences of nearly 2,500 people convicted of nonviolent drug offences in what the White House called the largest single-day act of clemency in US history. Those whose sentences were commuted were serving "disproportionately long sentences" compared to what they would receive today, Biden said in a statement.He called the move "an important step toward righting historic wrongs, correcting sentencing disparities, and providing deserving individuals the opportunity to return to their families.""With this action, I have now issued more individual pardons and commutations than any president in US history," Biden said, adding that he may issue further commutations or pardons before he hands over power to President-elect Donald Trump on Monday. The outgoing president said



those receiving clemency had received lengthy sentences based on now-discredited distinctions between crack and powder cocaine, which have disproportionately impacted the Black community.



Israel Approves Gaza Ceasefire Deal, Set To Begin Today

Jerusalem. Israel's cabinet voted to approve a Gaza ceasefire and hostage release deal on Saturday, the office of Prime Minister Benjamin Netanyahu said, ending days of uncertainty about whether the truce would go into effect this weekend. The ceasefire, set to begin Sunday, would halt fighting and bombardment in Gaza's deadliest-ever war. It would also enable the release of hostages held in the territory since Hamas's October 7, 2023 attack on Israel in exchange for hundreds of Palestinian prisoners from Israeli jails."The government has approved the hostage return plan", Netanyahu's office said early Saturday morning after the cabinet held its vote. The justice ministry published a list of 95 Palestinians to be freed starting Sunday, "subject to government approval". They include 69 women, 16 men and 10 minors.

Israeli strikes have killed dozens since the ceasefire deal was announced, with the military saying Thursday it had hit about 50 targets across Gaza over the previous 24 hours. The truce is to take effect on the eve of the inauguration of Donald Trump, who claimed credit for working with outgoing Two far-right ministers had voiced US President Joe Biden's team to seal the deal. It was earlier approved by Israel's

security cabinet, with Netanyahu's office saying it "supports achieving the objectives of the war". Palestinian President Mahmud Abbas said the Palestinian Authority has completed preparations "to assume full responsibility in Gaza" after the war.Even before the truce begins, displaced Gazans were preparing to return home."I will go to kiss my land," said Nasr al-Gharabli, who fled his home in Gaza City for a camp further south. TN liquor sales hit a high, up by **Rs 47 crore this Pongal**

CHENNAL Liquor sales by the Tamil Nadu State Marketing Corporation (Tasmac) saw a slight increase during Pongal this year and the days leading up to it, when compared to the corresponding period last vear.

From January 12 to 16, Tasmac earned Rs 725.56 crore in sales, compared to Rs 678.65 crore during the same period last year, according to the data accessed by From January 1 to 16, Tasmac recorded sales of Rs 2,462.97 crore, up from Rs 2,300.23 crore during the same period in 2024, marking an increase of Rs 162.74 crore (7.07%).A senior Tasmac official said, "Liquor sales in Chennai and its outskirts saw a decline during the Pongal festival as many people had travelled to their hometown for the holidays. However, other outlets across the state recorded regular seasonal sales."

He added 12 districts, including Kanniyakumari, Nagapattinam, Tiruvarur, and Ramanathapuram, also saw a slight decline in sales. "We have instructed district managers to identify the reasons for the decrease in sales in these areas," the official said.In terms of district-wise (as per Tasmac's classification) increase in sales, Perambalur reported the highest of 15.26%, followed by Cuddalore (10.41%) and Villupuram (9.62%). Perambalur also topped in beer sales, with 27,047 cases sold compared to 22,435 last year in the district, a 20.56% increase.

Vulture which flew 4,000 km to reach Pudukai electrocuted

CHENNAI. A juvenile white-rumped vulture, a critically endangered species listed on the IUCN Red List, was electrocuted near Thirumayam in Pudukottai The one-year-old vulture, part of the Jatayu Conservation Initiative, was GPS-tagged and released in July 2024 from Tadoba-Andhari Tiger Reserve in Maharashtra, by the state's forest department and the Bombay Natural History Society (BNHS). This is the fifth such electrocution-related death among 25 vultures, including 10 long-billed and 10 white-rumped vultures released under the programme.

The bird, which had travelled an impressive 4,000 km across states over five months, was found dead after coming in contact with a live wire. The vulture had made pit stops in several areas, including Chennai, before reaching Pudukkottai. It was last seen scavenging on a dog carcass near an electric wire.S Bharathidasan, founder of Arulagam, an NGO that works towards conserving vultures in the Nilgiris, said, "I monitored and fed the bird for three weeks, hoping it would take longer flights. The bird was healthy, but due to the easy availability of food in human habitats, it was not flying long distances."

Insurance barriers restrict patients' Kerala: Neyyattinkara Gonan's burial held and access to mental health treatment

THIRUVANANTHAPURAM. Insurance companies are increasingly using patients' mental health treatment records to deny them claims for unrelated medical conditions.

Treatments for conditions like depression or obsessive-compulsive disorder (OCD)

are being used as reasons to reject insurance claims for procedures such as cataract or heart surgeries. The practice has sparked opposition, especially after actor Archana Kavi shared her own struggles with a claim denial.

Hospitals known for mental health services are witnessing a wave of complaints from patients over claim denials, despite the fact that the Mental Healthcare Act, 2017, mandates equal treatment for mental and physical illnesses. The trend not only deepens the stigma surrounding psychiatric care but also discourages people from seeking help or disclosing their mental health struggles. While the Insurance Regulatory and Development Authority of India (IRDAI) mandated that all health insurance policies include

coverage for mental health conditions starting November 2022, its implementation has been inconsistent. Ajinas, a resident of Ernakulam, was taken aback when his mother's cataract surgery claim was rejected."I took my mother for cataract surgery at a well-known hospital in Perinthalmanna. Since I was aware of the cashless claim process, I instructed the hospital's insurance team to notify the

insurance company for approval. However, when they did, the firm responded with questions about my mother's depression history," Ajinas said."They kept asking about her depression treatment and ultimately denied



the claim. How can a cataract surgery be denied due to depression treatment? The two are unrelated. It feels like the insurance company is intentionally trying to avoid covering a legitimate claim," he said.

Vivek Raj (name changed) from Alappuzha faced a similar battle when his claim was rejected due to his history of bipolar disorder. Even after approaching the IRDAI, he could not get a

favourable ruling."Mental illness is still seen as a high-risk category, so insurance policies include specific clauses related to it. If people don't disclose their mental health history, it can lead to claim rejection during document verification," said Dr Ushus Kumar, director of Optimus Medical Services Pvt Ltd, which conducts third-party verification for several insurance companies.

New challenge

A new challenge has emerged as insurance companies, despite the legal obligation to cover mental health conditions on par with physical issues, have created policies that complicate matters for patients.

One such policy requires applicants to prove at least a 40% mental health disability to qualify for coverage. The clause has sparked criticism from health experts, as it contradicts the intent of providing equal coverage for mental health issues."By linking the Mental Health Act with the Rights of Persons with Disabilities, the burden is placed on patients to obtain a certificate proving 40% disability. This is rare for mental health conditions. Patients with OCD, depression, or even stabilised schizophrenia would struggle to get such a certificate. The policy seems designed to make it difficult for people with mental health histories to access insurance coverage," said Dr C.J. John, senior psychiatrist at Medical Trust Hospital and a member of the State Mental Health Authority.

Gopan's burial held amid probe THIRUVANANTHAPURAM.

Amid ongoing investigation to ascertain the exact cause of his death, Neyyattinkara Gopan Swami's burial rites were completed by Friday.The ceremonies began at 4 pm in a newly constructed tomb near his house in Aralummoodu. The burial rituals were conducted by monks from various ashrams.His sons, Sananthan and Rajasenan, along with other family members, performed the ceremonies. The body was brought home from a private hospital in Neyyattinkara in a ceremonial procession led by Hindu organisations.It was transported on an open vehicle, where the body was seated on a platform, dressed in saffron robes. The face was covered during the procession.

The newly constructed tomb has been named Rishipeedom. The new tomb, made of bricks, was filled with ash, camphor and fragrant materials before the body was lowered into the pit. It was then covered with more ash and camphor, and a slab was placed on top to seal the tomb.

The family said that prayers led by monks would be conducted at the site for the next 41 days. VSDP, All India Nadar Association and other Hindu groups coordinated the event.Heavy police deployment, led by the Neyyattinkara DySP, was present from the hospital to the house. The family constructed a new tomb to lay Gopan Swami to rest near the earlier burial site, which the police had opened on Thursday. Stones were placed inside the tomb for the burial.The tomb was opened on Thursday and the body was exhumed for a postmortem at medical college hospital. The police carried out the exhumation after the High Court rejected a plea by Gopan's wife and sons to stay the order. The body had been buried with camphor, ash and other ritual materials filled up to the chest.The preliminary postmortem report showed no external injuries or any foul play. The cause of death remains unclear. Police are waiting for results from chemical analysis, forensic lab tests, and histopathological examinations to determine if there were internal injuries or substances in the lungs. The police may question Gopan Swami's family members again as part of the investigation.

Hyderabad to introduce pod taxi system for seamless connectivity in IT corridor

HYDERABAD. The state government is planning to introduce a Personal Rapid Transit (PRT) or pod taxi system to improve last-mile connectivity in areas like Knowledge City, Hitech City and Kondapur, bringing an end to the frequent traffic jams in the IT corridor.

The PRT system will initially come up in two corridors, linking Metro stations with key office hubs, multinational companies and high-rise buildings in Raidurg, Madhapur, Kondapur and nearby areas. The 8.8 km-long Corridor-I with 28 stops will cover Raidurg-ITC Kohenur-Knowledge City and is estimated to cost Rs 880 crore. Corridor-II, on the other hand, will have 27 stops over 6 km. It will cost Rs 600 crore and cover Raidurg-Tech Mahindra-Hitech City/Kondapur.HMRL has commissioned a DPR which will be submitted to the government by the month-end.

PRT can handle 10,000 pax per hour



The PRT system is expected to end traffic jams by offering a seamless connection from Metro stations to offices and other destinations. It will provide faster, smoother transit while reducing reliance on conventional road transport. The PRT system will consist of small, batteryoperated, driverless pods travelling on

elevated, guided tracks. Each pod can carry 6-8 passengers and will operate under centralised control. After boarding, passengers would have to select their destination on a touch panel, and the pod would travel directly to the designated stop. Pods can also be hired privately for uninterrupted travel. The system is designed to handle 10,000 passengers per hour during peak times, with a daily capacity of 1 lakh commuters. A similar pod taxi system is being developed in Mumbai's Bandra-Kurla Complex. The Hyderabad project, once operational, is poised to become a model for urban transportation in India's growing metropolitan areas. The state government expects that the new system will significantly improve connectivity in Hyderabad's IT and business districts, contributing to a more streamlined urban infrastructure.

He had requested the forest department and BNHS to relocate the bird to Moyar Valley where there is an established population of vultures, but was turned down.Experts have raised concerns about the increasing risk vultures face due to poorly managed infrastructure near their habitats.

Relook at Roerich Estate ecotourism plan: Activists

BENGALURU. Conservationists and Conservationists and experts have penned a letter to the Union Ministry of Environment, Forests and Climate Change (MoEFCC), demanding it take a relook at the proposal drawn by the Karnataka tourism department to make Devika Rani and Roerich Estate on Kanakapura Road, on the outskirts of Bengaluru, an eco-tourism destination.

- They demanded the ministry to review the project and the departments concerned to obtain prior approval under the Forest Conservation Act, 1980.
- The letter sent to the ministry is based on the article - Roerich estate is forest land, ecotourism tough in jumbo corridor - published in The New Indian Express in its January 10, 2025, edition. The letter, dated January 16, 2025, stated that the property, also called Tataguni Estate, is a dry deciduous forest and is one of the last remaining lung spaces of the fast developing Bengaluru city, which is losing its green cover at an alarming pace. The estate is spread over nearly 470 acres, of which around 100 acres is notified as a reserve forest and remaining area is notified as a deemed forest by the Karnataka government.

Any non-forestry activity on forest land attracts the provisions of Forest Conservation Act, 1980 and diversion of forest land for eco-tourism involving permanent structures is impermissible as per the Sustainable Eco-Tourism in Forest and Wildlife Areas 2021 guidelines issued by the MoEFCC in October, 2021."The estate adjoins UM Kaval State Forest and is strategically located between Bannerghatta National Park and Savandurga Forest which is also an elephant corridor. Apart from elephants, the estate area is home to smooth coated otter, deer, rusty spotted cat, muntjac etc. based on a study conducted by Sanjay Gubbi and his team from Nature Conservation Foundation in 2017," the letter said.

BENGALURU. Nearly 24,000 quintals of jowar worth Rs 6 crore stored in the godown of the Karnataka State Warehousing Corporation (KSWC) in Ballari was found unfit for consumption. However, this worminfested jowar was supplied to fair price shops in and around Ballari district. This came to light when Upa Lokayukta Justice B Veerappa visited the godown of Unit-2 of KSWC on Friday.

In all, 48,000 bags of jowar, each weighing 50kg, were found worm-infested. When Justice Veerappa, accompanied by deputy registrar Aravind NV and others questioned, Sharavathi, manager of the Ballari unit of the KSWC, and Sakina, deputy director of Food and Civil Supplies, said they obtained a certificate from the Food Corporation of India (FCI) on March 29, 2024, that "jowar is fit" for consumption. Jowar was sent to Haveri and other districts for distribution through fair price shops. The Upa Lokayukta told the officials that it was not fit even for animals to consume. In all, 48,000 bags of jowar were wasted because of negligence on the part of the officials concerned, he said. Upset by Justice He emphasised that NISG, a non-profit Veerappa's confrontation, Sharavathi asked him to provide a photo linking to GPS for confirmation of his visit to the godown.

Enraged by her conduct, Justice Veerappa told the media that the manager sought proof of his visit. "This shows they have reached a stage of even questioning us," he said."This is unfortunate. The minister concerned has to take action against the officials," he said. He said jowar was procured using taxpayers' money and it should not be wasted this way. "We will definitely take action under the Karnataka Lokayukta Act", he said.

Centre announces Rs 11,440 crore package for Visakhapatnam Steel Plant's revival

VIJAYAWADA. The Central government has announced a financial package of Rs 11,440 crore for the revival of the Visakhapatnam Steel Plant (Rashtriya Ispat Nigam Limited). The announcement was made by Union Minister of Information and Broadcasting Ashwini Vaishnaw on Friday and was later confirmed during a Cabinet Committee on Economic Affairs (CCEA) meeting chaired by Prime Minister Narendra Modi. Visakhapatnam Steel Plant is a Schedule-A Central Public Sector Enterprise (CPSE) under the Ministry of Steel, with a current installed capacity of 7.3 million tonnes per annum (MTPA). The The equity support will allow RINL to address revival package includes an equity infusion of Rs 10,300 crore and the conversion of Rs 1,140 crore of working capital loans into 7% non-cumulative preference share capital, redeemable after 10 years, to ensure RINL

India-Afghan relations beyond Pakistan's shadow

The upscaling of India's relations with Afghanistan is not sudden and Pakistan-centric. The 90-minute warm exchanges between Indian Foreign Secretary Vikram Misri and Afghan Acting Foreign Minister Amir Khan Muttaqi last week in Dubai in the aftermath of the deteriorating Afghanistan-Pakistan relations were a coincidence. The Afghan Foreign Office stated that the meeting conformed to its determination to strengthen political and economic ties with India "as a significant regional and economic partner." India is equally determined to continue to connect with Afghans and prevent the hiatus that existed from the mid-1990s to 2001 (during the factional warfare within the Mujahideen government and the rule of the Taliban) when the Indian embassy and consulates remained shut. The Indian decision to step up India-Afghanistan relations is in line with India's progressive engagement with the Taliban. JP Singh, Indian government's point person for Afghanistan, pursued this periodically through contacts with the relevant Afghan authorities. Over time, both sides felt the need to expand their relations beyond humanitarian assistance from India in foodgrains, pesticides, vaccines, medicines and de-addiction and relief materials. Although the Taliban regime is noninclusive and mistreats minorities and women, the law-and-order situation has improved and opium cultivation has almost gone. Isolating the Taliban is unlikely to moderate them.

The conspiracy-obsessed Pakistani social media is viewing the Dubai meeting as a plot hatched against it. Its commentators invariably see any growing closeness between India and Afghanistan as two sides of a nutcracker trying to crush Pakistan. They disregard India's stake in Afghanistan's stability, the traditional connection between Indians and Afghans and the Indian security consideration (to assure itself that Afghan territory is not used by terrorist groups against India). India meets its strategic objective if Afghanistan can stand on its feet and make its own decisions. The establishment of the Islamic Emirate of Afghanistan led to triumphalism in Pakistan. The Taliban bristles at the suggestion that it is a Pakistani puppet. The Pakistani euphoria has since turned to disquiet because of the refusal of the Taliban leadership to accept its tutelage. To pressure the Taliban, Pakistan has pushed back Afghan refugees at a time when the authorities in Kabul cannot handle the numbers. Pakistani actions have resulted in unfriendly relations with three of its five neighbours - Afghanistan, India and Iran.Prime Minister Shehbaz Sharif described the recent Pakistani cross-border military strikes as a "teeth-breaking response" to the Taliban's perceived non-cooperation in curbing the activities of the Tehrik-e-Taliban Pakistan. Besides, Pakistan has a grudge against the Afghan refusal to acknowledge the Durand Line as the frontier between Afghanistan and Pakistan. Following border skirmishes between the two, Pakistani aerial bombardment of 83 locations in Afghanistan led to many civilian deaths, including women and children. The Pakistani punitive strikes have been "unequivocally" condemned by the Indian External Affairs Ministry spokesperson. The former army chief of Pakistan, General Ashfaq Parvez Kayani, altered the erstwhile Pakistani idea of establishing 'strategic depth' in Afghanistan — propounded by one of his distant predecessors, General Mirza Aslam Beg by qualifying that Pakistan should do so without control over Afghanistan. The Pakistani establishment has done the opposite - not just eschewing the quest for control but also engaging in aggression against Afghanistan. No wonder, the Afghan reaction is fierce. Acting Deputy Foreign Minister Sher Mohammad Abbas Stanikzai reminded Pakistan that though Pakistan had named its missiles Ghaznavi, Abdali and Babur, it should remember that Afghanistan had.

Political lessons of AAP's Delhi school model

India's education system is in urgent need for reform, yet in the rough and tumble of electoral promises, education rarely makes an appearance.

One of the biggest puzzles about Indian politics is the near absence of political competition around public goods like education (and health) in the electoral battlefield. It simply does not get as much public debate as it deserves, This is particularly puzzling because Indians care deeply about education and recognise it as the path to better jobs and mobility.

India achieved near-universal enrolment in elementary education in the mid-2000s and it has stayed steady since; enrolment in secondary schools has been growing, as has the market for private schools and private tuitions. Between 2000 and 2022, the number of people with secondary education or higher levels doubled. However, most students are receiving an education of shoddy quality. At the elementary level, as ASER reports repeatedly remind us, just about 50 per cent (pre-Covid) of students in Class V can read a Class II textbook. This figure increases at the secondary level. The intense competition and scandals around competitive exams for higher education and the increasing unemployment rates amongst educated youth in India are testimony to this.India's education system is in urgent need for reform. Yet, in the rough and tumble of electoral promises, education rarely makes an appearance. While parties compete over subsidies and cash transfers, their silence on public goods like education is conspicuous. This is where the Aam Aadmi Party (AAP) in Delhi stood out. Soon after coming to power in 2015, the government announced its mission to 'revolutionise' education in Delhi. Despite the ups and downs through its decade in power, the party repeatedly deployed education as its key differentiator, the lynchpin of its "Delhi model". The party stood out because it made education an electoral issue.Today, a lot of this is being lost in the ugliness that has become the norm in election campaigns. The AAP, too, is shifting focus. It is looking more like its peers, doling out direct benefit cash transfers to women and playing the Hindutva game. Elections are a time to reflect on the big shifts that parties have engendered. The AAP's work on education was not without critique, but it was substantive. It offers a site to engage with the challenges of our education system.For several years, I had the opportunity, along with a team of researchers, to observe AAP's education reforms as they unfolded in Delhi's elementary schools (classes VI-VIII). In a recently published book, 'Lessons in State Capacity from Delhi's Schools', we reflect on what we had learnt. Most discussions on Delhi's education revolution focus on enhanced budgetary provisions and improvements in school infrastructure.But to me, what really stood out was the willingness to acknowledge and open a political dialogue on the fundamental challenge confronting the Indian education system: the obsession with mastering examinations through rote-learning. This is a system



obsessed with syllabus-completion rather than subjectmastery, with the goal of ensuring that the best students are made exam-ready. For teachers, pass percentages are the key metric to which they are held accountable by both the school system and parents. Rote-learning is the primary means to this end.I refer to this as the classroom consensus. It works for the best students, but for those left behind, the tyranny of syllabus completion and pass percentages has meant that the classroom simply does not cater to them. As Manish Sisodia, the architect of Delhi's school reforms, has said, the classroom is a victim of the curriculum, syllabus and textbooks.Much of what the Delhi education revolution did was aimed at disrupting the classroom consensus by experimenting with ways to ensure that basic, foundational literacy and numeracy skills were imparted to all students. It included infrastructure upgradation, building a cadre of mentor teachers, improving in-service training and exposure visits around the world, infusing campaigns to build foundational literacy and numeracy skills, along with aligning classrooms within a grade according to student learning levels (how close students were to curriculum level expectations).None of this was unchallenged. In schools, amongst teachers and educationists, questions were asked, debates held and ideas critiqued.Moreover, versions of these reform ideas have been tried out in some other states and in different ways, but rarely as a political project and never for long enough to disrupt the classroom consensus.Change was hard. There was confusion, resistance and active pushback at the school level. The spectre of syllabus-completion and examinations loomed, causing confusion in the messaging. Over time, a subtle but important shift took place. Consistent engagement

was held with schools on the dynamics of the classroom. Teachers were exposed to different ways students could acquire basic skills outside the framework of the syllabusexamination nexus. Regular "missions" that focussed on improving basic literacy and numeracy were infused. All this shifted the conversation. Teachers still spoke about students in terms of their exam-readiness, but now the gaps in student learning levels and the distance between curriculum expectations and the student in the last row of the classroom had entered the conversation, preparing the ground for a deeper change. There are lessons in this package of reform efforts for other states on how to improve foundational literacy and numeracy in primary schools, which is a key goal of the Union government's New Education Policy, 2021. Throughout the early years, a consistent attempt was made to make parent-teacher dialogue on student learning a routine through widely publicised mega parent-teacher meetings. Such engagement in government schools is rare. The quality of the mega parent teacher meetings was variable, but the political support they received and the stated goal of shifting the societal dialogue on education was important and a first for India. With the AAP's political battles in Delhi, the momentum for reforms in the government's second term slowed down.But it is important to recognise that in a political culture where welfare obligations of the state have been reduced to cash handouts, where bigotry, hate and the worst forms of identity politics are the primary offerings that politicians take to the hustings, for the first time, education was brought into the political discourse. This was significant and deserves attention in the cacophony of ugly, coarse political rhetoric that is now the norm in our electoral discourse.

Simultaneously, agriculture is a major contributor to climate change, with intensive farming practices releasing greenhouse gases (GHGs), such as carbon dioxide, methane and nitrous oxide into the atmosphere. The challenges facing agriculture in India are multifaceted: demand for fair crop prices and assured procurement, effective stubble management, deteriorating soil health, lack of crop diversification, depleting water levels and rising food demand, driven by a growing population.

Addressing these challenges requires innovative solutions that safeguard farmers' livelihoods, boost incomes and reduce environmental harm. farmers to boost their incomes while contributing to a carbon-neutral and sustainable future. The benefits of carbon-negative farming extend far beyond individual farms. By improving soil health, strengthening food security and addressing stubble burning and climate change, it tackles critical global challenges. Adopting sustainable agriculture reflects a collective commitment to securing a healthier planet and a better future for generations to come.

6. DON'T OVER-ABBREVIATE:

Don't invoke abetment of suicide mechanically, cops should be sensitised: Top court

The Supreme Court on Friday said the offence of abetment of suicide under the Indian Penal Code should not be invoked mechanically against individuals only to soothe feelings of the distraught family members of the person who has died. A bench of Justices Abhay S Oka and KV Viswanathan said the investigating agencies should be sensitised so that people were not subjected to the abuse of the process of a totally untenable prosecution.

Section 306 IPC appears to be casually and too readily resorted to by the police. While the persons involved in genuine cases where the threshold is met should not be spared, the provision should not be deployed against individuals, only to assuage the immediate feelings of the distraught family of the victim," said the bench.

The conduct of the proposed accused and the victim," the court went on, "their interactions and conversations preceding the unfortunate death of the victim should be approached from a practical point of view and not divorced from day-to-day realities of life. Hyperboles employed in exchanges should not, without



anything more, be glorified as an instigation to commit suicide."The top court said the trial courts also should exercise "great caution and circumspection" and should not adopt a "playit-safe syndrome" by mechanically framing charges, even if the investigating agencies in a given case showed utter disregard for the ingredients of Section 306

The judgment came on a plea filed by one Mahendra Awase challenging an order of the Madhya Pradesh High Court, which declined his prayer to discharge him from the offences

punishable under Section 306 of the IPC.According to the records, a person died by suicide and left a note in which he mentioned he was being harassed by Awase.Apart from the suicide note, the statements of witnesses were recorded that indicated the person who died was disturbed as Awase was harassing him over the repayment of a loan. The top court said, in order to bring a case within the purview of Section 306 of the IPC, there must be a case of suicide and in the commission of the said offence, the person alleged to have abetted the commission of suicide, must have played

an active role by an act of instigation or by doing certain act to facilitate the commission of suicide. The bench said it was convinced that there were no grounds to frame charges under Section 306 IPC against the appellant."A reading of the suicide note reveals that the appellant was asking the victim to repay the loan guaranteed by the victim. It could not be said that the appellant, by performing his duty of realising outstanding loans at the behest of his employer, can be said to have instigated the victim to die by suicide," the court said.

Probe Agency Restores Properties Worth Rs 290 Crore in Maharashtra Bank Scam

New Delhi. The Enforcement Directorate (ED), Mumbai Zone, has restituted immovable properties worth Rs 289.54 crore to the Competent Authority, MPID appointed by the Government of Maharashtra in the case of M/s Pen Co-operative Urban Bank Ltd, an official said on Friday.A statement mentioned that the assets were provisionally attached by ED under Section 5 of Prevention of Money Laundering Act (PMLA), 2002 as the erstwhile office bearers had cheated the banks and siphoned off the bank funds for private investments.

The investigation was initiated based on the FIR registered by Pen Police Station, District Raigad, Maharashtra. It was alleged by the LEA in its chargesheet that office bearers of the bank entered into criminal conspiracy with the then Auditors of the Bank willfully and intentionally manipulated the books of accounts of Pen Bank and fraudulently reported profit and caused a loss of Rs. 651.35 Crore to the bank.ED investigations revealed that the proceeds generated out of crime of forgery and cheating was diverted and routed through the bogus cash credit accounts opened in the said bank using the services of cheque discounters in the market. The statement further read that part of such Proceed of Crime (POC) was utilised for purchase of immovable properties at different locations in Raigad District of Maharashtra in the names of third parties (Benami properties)."These Benami properties measuring 70.9 acres worth Rs. 25.20 Crore were attached u/s 5 of PMLA on 26.05.2014 and 03.12.2014. Further Prosecution Complaint dated 20.06.2018 has been filed in the subject case before Hon'ble Special Court, PMLA and the trial is underway," it read."In the meantime, a Criminal Writ Petition bearing was filed by one of Depositor of Pen Urban Cooperative Bank Ltd before the Hon'ble Bombay High Court praying for release of the properties attached under the PMLA. The Hon'ble Bombay High Court vide order dated 07.10.2016 directed the ED to hand over the properties to MPID. Against the said order, ED filed a SLP before the Apex Court vide order dated 03.11.2017 which granted a stay on the order of Hon'ble Bombay High Court. MPID authorities filed an application u/s 8(8) of PMLA dated 01.02.2019 before Hon'ble Special Court (PMLA), Mumbai to confiscate the attached property to MPID for its restitution," it further mentioned.

These families, predominantly migrants from West Bengal, Bihar, and Uttar Pradesh, live off the refuse of a city that seems to have forgotten them. Despite political promises and high-profile visits, the towering mound of garbage remains an unrelenting source of misery.As Delhi gears up for another election

cycle, political parties are ramping up their campaigns. Yet, for the residents of Ghazipur, including Mullah Colony and Rajbir Colony, the rhetoric rings hollow. Promises made by former chief minister Arvind Kejriwal and even Prime Minister

Narendra Modi have yet to translate into tangible improvements. The landfill's toxic shadow continues to loom large over their lives.Satbir, 32,



who has known no other home, articulates the perpetual health crises faced by the community. "Cough, fever, and respiratory diseases are constants here," he shares. The landfill's fires during the scorching summers release

noxious fumes, exacerbating health issues. During the monsoons, clogged drains and overflowing sewage compound their woes.Raghunath, 41, another resident, bears visible

scars of the environmental neglect. "People fall sick and don't even realise it's due to the landfill's pollution. I've suffered from a persistent fungal infection," he laments. His words echo the collective despair of a community abandoned by its representatives. "We vote, but

our issues remain," he says. Sriniwas, 71, a resident of over four decades, recounts the worsening conditions.

"Respiratory problems have become a part of life here. During rains, the streets become rivers of filth," he says, holding up his medical prescriptions. His plea for a cleaner environment has long fallen on deaf

Delhi University announces honorarium hike for staff working late or on holidays

- NEW DELHI. The Delhi University on Friday announced a revision to its honorarium policy for staff working beyond regular hours or on closed days. The amendment, approved during the varsity's executive council (EC) meeting, provides increased payments for employees who report before 7:30 am, leave after 7:30 pm on working days, or work more than seven hours on Saturdays or closed days (over 60 days in a year).Under the new policy, Group A officers will receive Rs 400 for late sitting and Rs 800 for working on Saturdays or closed days.
- Group B officials will be compensated Rs 300 for late sitting and Rs 600 for working on Saturdays/closed days, while Group C officials, including drivers, will receive Rs 250 and Rs 500, respectively. Additionally, the EC authorised prof Anil Kumar Aneja, Head of the Department of English and university representative on the governing body of St. Stephen's College, to facilitate communication between DU and St. Stephen's College to resolve any issues related to the college's operations, in line with the University's statutes, regulations, and UGC guidelines. Vice Chancellor Prof. Yogesh Singh also appointed two additional EC representatives, Aman Kumar and Raj Pal, to the committee to address these matters.
- The EC also decided that the UGC NET scores from June 2024 and December 2024 will be considered for the second phase of PhD admissions for the academic session 2024-25. Candidates with a NET + JRF qualification will be given preference. Moreover, the EC approved an increase of 20-25% in PhD seats compared to the previous round of admissions. Moreover, DU employees will now have access to medical facilities at the Northern Railway Hospital.

Parties cite public service to justify candidates having criminal cases: Report

New Delhi. Political parties have given reasons, such as "strong administrative capacity", "commitment to public service" and claims of cases being "politically motivated", for selecting candidates with criminal records in the 2024 Maharashtra and Jharkhand Assembly elections, poll rights body ADR said on Friday.

In many cases, the parties dismissed alternative ability to connect with voters, using these explanations to side-step questions about their choices, the Association for Democratic Reforms (ADR) said. The ADR has analysed Form C7 of 1,286 candidates, who contested the Maharashtra and Jharkhand Assembly polls. Form C7 requires candidates to declare their



criminal antecedents, if any.

candidates as lacking experience or the An ADR report revealed that such reasoning often failed to meet the Supreme Court's directive requiring detailed, merit-based justifications for selecting candidates with criminal backgrounds. Instead, statements like In Maharashtra, the NCP-Sharadchandra "the candidate is young and energetic" or "cases were filed due to public agitation" were repeatedly used. Despite these assertions, 29 per cent candidates

in Maharashtra and 20 per cent in Jharkhand had no justification published for their selection, a direct violation of the Supreme Court's orders.For instance, in Maharashtra, Digamber Rohidas Aagwane of the Rashtriya Samaj Paksha, facing 35 criminal cases, was described as an "influential leader" dedicated to the poor, with no viable explanation for bypassing candidates without criminal records.Similarly, the selection of Congress's Sanjay Chandukaka Jagtap and Bunty Baba Shelke, facing 27 and 26 cases respectively, as candidates was justified on grounds of administrative experience and alleged political victimisation. The report also highlighted non-compliance with mandatory disclosures.

Pawar faction and the Shiv Sena (Uddhav Balasaheb Thackeray) failed to provide justifications for any of their candidates with criminal cases.Similar lapses were noted in Jharkhand, where the Jharkhand Mukti Morcha (JMM) did not disclose reasons for selecting any of its candidates with criminal records. The ADR has called for urgent reforms, including deregistration of the non-compliant parties, disqualification of candidates with serious criminal charges and stricter monitoring by the Election Commission (EC).In Maharashtra, 48 per cent of the analysed candidates (503 out of 1,052) declared criminal cases, with 32 per cent facing serious charges.In Jharkhand, 45 per cent candidates (105 out of 234) declared criminal cases, with 35 per cent facing serious charges.BJP candidate Babulal Marandi, facing 15 cases, was praised for his social service credentials and allegations against him were dismissed as politically driven. The report criticised political parties for prioritising "winnability" over integrity and accused the EC of failing to enforce compliance effectively.



8th Pay Commission: What were the big changes in 7th and 6th Pay Commissions?

The Government has approved the formation of the 8th Pay **Commission for central** government employees and pensioners. Here is a look at the salary hikes under the 7th and 6th Pay Commissions.

NEW DELHI. The Union Cabinet recently approved the formation of the 8th Pay Commission, which is set to revise salaries for lakhs of central government employees and pensioners.Union Minister Ashwini Vaishnaw suggested that the commission will likely be formed The 7th Pay Commission also The 6th Pay Commission, which was soon, and its recommendations will come into effect on January 1, 2026.

The announcement comes just days before the Union Budget 2025 and aims to align salaries with current economic conditions and inflation rates. As the anticipation around the 8th Pay

Commission grows, here is a look at the major changes that were part of the 7th and 6th Pay Commissions.

SALARY AND PENSION HIKE IN 7TH PAY COMMISSION

The 7th Pay Commission came into effect on January 1, 2016. It introduced many major changes for central government employees.One of the most critical aspects was the fitment factor, which was set at 2.57. What this meant was that the basic

pay would be multiplied by 2.57, leading to increased salaries across all levels

amongst central government staff. recommended a minimum basic salary of Rs 18,000, marking an increase from the

previous Rs 7,000 under the 6th Pay Commission.In addition, pensions saw a decent increase. For pensioners, the minimum basic pension rose to Rs 9,000, up from Rs 3,500 under the 6th Pay



Commission.

implemented in January 2006, introduced modest changes but still improved salaries and pensions. The fitment factor under the 6th Pay Commission was 1.86. Therefore, the minimum basic salary was revised to Rs 7,000, up from Rs 2,750 in the 5th Pay



The IMF added, "In India, growth is projected to be solid at 6.5 percent in 2025 and 2026, as projected in October and in line with potential." The global body noted a slowdown in the Gross domestic product (GDP) growth rate adding that growth in India also slowed more than expected, led by a sharper-thanexpected deceleration in industrial activity."India's economic growth slowed in the second qurter of the current fiscal as it expanded only by 5.4 per cent whereas in the second quarter the GDP growth rate was recorded at 6.7 per cent. PSU steel manufacturer RINL gets Rs 11,440-crore lifeline from government

NEW DELHI. The debt-laden Visakhapatnambased public sector company -- Rashtriya Ispat Nigam Limited (RINL) -- has got a new lease of life after the Central government on Friday approved a revival package of Rs 11,440 crore for the company. Of the Rs 11,440 crore, Rs 10,300 crore will be in the form of fresh equity infusion and Rs 1,140 crore will be for converting the working capital loan into preferred share capital."With this revival package, many of the historical legacy problems that RINL used to face will be resolved. Simultaneously, a lot of effort is going to be put in securing the raw material for RINL and the modernisation of the plant," said Ashwini Vaishnaw, Minister of Railways, Information & Broadcasting, and Electronics & Information Technology. The minister said that very soon RINL will start functioning with two glass furnaces, and by August this year, all the three glass furnaces would be operational. Vaishnaw further said that RINL has a very special position in the entire steel industry -- it is one of those plants, which is located at the coastal Andhra Pradesh in Vizag, and is very important for the overall steel sector of the country.

INL has been under financial distress for quite some time, reporting losses and mounting debt for almost a decade now. In FY24, the company posted net losses of Rs 4,850 crore compared to Rs 2,850 crore in the previous year. The company's total debt at the end of FY24 was at Rs 17,000 crore. The Navratna PSU company has over 13,000 employees. The company has a

In the upcoming Budget 2025 session of Parliament, the government is likely to introduce a new income tax bill to simplify the current I-T law, make it comprehensible and reduce the number of pages by about 60 per cent, news agency PTI has reported."The new Income Tax law will be introduced in the Budget session of Parliament. It will be a new law and not an amendment to the existing Act. Currently, the draft law is being vetted by the law ministry and it is likely to be brought in Parliament in the second half of the Budget session," according to the PTI report citing a source.

The Budget session is scheduled from January 31 to April 4. The first half (January 31-February 13) will start with President Droupadi Murmu's address to the joint sitting of Lok Sabha and Raya Sabha followed by the tabling of the Economic Survey for 2024-25. The Union Budget for 2025-26 will be presented on February 1. Parliament will reconvene on March 10 and will sit through April 4. Sitharaman in her July Budget had announced a comprehensive review of the six-decade old Income Tax Act, 1961, within six months. Pursuant to the Budget announcement by Sitharaman for a comprehensive review of the I-T Act, 1961, the CBDT had set up an internal committee to oversee the review and make the Act concise, clear, and easy to understand, which will reduce disputes, litigation, and provide greater tax certainty to taxpayers. Also, 22 specialised sub-committees were established to review various aspects of the Act.

- Public inputs and suggestions were invited in four categories - simplification of language, litigation reduction, compliance reduction, and redundant/obsolete provisions.

NEW DELHI. The Ministry of Finance has announced the approval of 1,646 food processing projects, including food testing labs and R&D initiatives, under various sub-schemes of the PM Kisan Sampada Yojana. These projects, approved until December 18, 2024, are valued at Rs 31,830.23 crore, with the potential to attract Rs 22,722.55 crore in private investment.Implemented by the Ministry of Food Processing Industries (MoFPI) since 2016-17, the PM Kisan



Sampada Yojana aims to increase processing and preservation capacity by 428.04 LMT per annum, create 13.42 lakh jobs, and benefit 51.24 lakh farmers. The government is committed to driving growth in agriculture and food processing by encouraging both private and public investments in areas such as aggregation, modern storage, efficient supply chains, processing, and marketing.

This push is aimed at increasing the level of food processing and enhancing the export of processed foods by creating modern infrastructure with efficient supply chain management from farm gates to retail outlets.

PMFME Yojana: First Scheme for the Unorganised Sector

The PM Formalisation of Micro Food Processing Enterprises (PMFME) Yojana, a centrally sponsored scheme implemented by MoFPI since 2020-21, provides financial, technical, and business support for upgrading micro food processing enterprises. It is the first-

ever scheme for the unorganised sector. Inder the PMFME Yojana, over 3.10 lakh SHGs have received seed capital support, and 1,14,388 individuals have benefited from credit linkage subsidies as of December 18, 2024. The Ministry of Finance also provided updates on financial support for the establishment of 50 multi-product food irradiation units in the MSME sector, as announced in the 2024-25 budget.

An Expression of Interest (EOI) was issued in August 2024 inviting proposals for the establishment of multi-product food irradiation units under the Integrated Cold Chain and Value Addition Infrastructure Scheme of PMKSY. So far, 20 project proposals have been received, and they are under scrutiny or evaluation in accordance with the scheme guidelines.

PLI Scheme Update:

Regarding the PLI scheme for the food processing industry, the finance ministry reported that 133 companies are currently covered under the programme. Investments totalling Rs 8,910 crore have been attracted so far, and incentives worth Rs 1,084 crore have been disbursed in 85 eligible cases.

The United legend scored 237 goals for the club in 404 appearances and is the club's thirdhighest goalscorer behind Wayne Rooney and Sir Bobby Charlton. Along with Charlton and George Best, Law formed one of the most feared footballing partnerships of all time, which was fondly dubbed as the 'holy trinity' by the Manchester United fans. Law is the only Scottish player to win the Ballon d'Or and the European Player Of The Year awards as he got the honours in 1964.



Law's family issued a statement through United announcing the demise of the legend on Friday."It is with a heavy heart that we tell you our father Denis Law has sadly passed away. He fought a tough battle but finally he is now at peace," a family statement shared by United said."We would like to thank everyone who contributed to his wellbeing and care, past and much more recently.""We know how much people supported and loved him and that love was always appreciated and made the difference. Thank you."United would also release a statement of their own, saying that everyone at the club are mourning the loss of one of the club's greatest players of all time.

"Everyone at Manchester United is mourning the loss of Denis Law, the King of the Stretford End, who has passed away, aged 84," United added in a statement."He will always be celebrated as one of the club's greatest and most beloved players. The ultimate goal-scorer, his flair, spirit and love for the game made him the hero of a generation."
