#### Nitish Kumar raised issue of caste census, Rahul kept mum

New Delhi, Jan 19: The Janata Dal (United) on Sunday accused Rahul Gandhi of hypocrisy on the issue of caste census, charging him with maintaining silence when Bihar CM Nitish Kumar raised the matter in INDIA bloc meetings. The party also asked why the Congress government in Karnataka has not released the state's caste data. JD(U) working president and MP Sanjay Jha's attack on the Congress leader came a day after Gandhi slammed the caste survey carried out by the Kumar-led government as a fake exercise at an event in Patna, while pitching for a nationwide caste census. Speaking to PTI, Jha said, "There cannot be a bigger hypocrisy than this. I was a witness to Gandhi maintaining silence while Kumar strongly and logically spoke in favour of caste census at INDIA bloc meetings in several places." Kumar-led JD(U) was part of

the INDIA bloc before he snapped ties with the opposition alliance and joined hands with the BJP. Incidentally, Bihar's caste survey was carried out and its findings released when the Congress was a partner in the government led by Kumar. #### Bangladeshi national who attacked Saif Ali Khan arrested

Mumbai, Jan. 19: Mumbai police on Sunday said a 30-year-old Bangladeshi national has been arrested for allegedly stabbing actor Saif Ali Khan at the latter's residence here. Preliminary investigation suggests that the man was unaware that he had entered a Bollywood star's house and his intention was theft, a senior police official told reporters. He said the attacker was nabbed at Hiranandani Estate on Ghodbandar Road in neighbouring Thane district. The official said the man had changed his name, Shariful Islam Shehzad Mohammad Rohilla Amin Fakir, to Vijay Das after he entered India. He said the accused, who hails from Jhalokati in Bangladesh, had been living in Mumbai for more than five months, doing petty jobs and was attached to a housekeeping agency. The police have registered a case against the accused under sections 311 (robbery or dacoity with the intent to cause grievous hurt or death, 331(4) (house-breaking) and other relevant provisions of the Bharatiya Nyay Sanhita and Passport Act, 1967, the official said. Police are trying to collect the documents the accused used to enter India illegally. The official said the accused was brought to Khar police station, where interrogation is underway to find out how he reached the actor's flat and other details.

#### **Shifting Yasin Malik's terror** trial from Jammu to Delhi

New Delhi, Jan 19: The Supreme Court will on Monday take up the CBI's petition challenging a Jammu court's order for the physical production of Kashmiri separatist leader and JKLF chief Yasin Malik to face trial in a case related to the murder of 4 Indian Air Force (IAF) personnel in 1989. The matter is listed before a Bench led by Justice Abhay S Oka which had on December 18 asked six co-accused to respond to



the CBI's plea. "All the accused have to be heard if the trial is to be transferred," the Bench had said after it was told that one of the 10 accused has died while others have not filed their replies. The CBI has challenged a Jammu court's order for the physical production of Malik to face trial in the case. Currently lodged in l'ihar Jail in Delhi, Malik insisted on being physically present in Jammu to cross-examine witnesses.

#### Assam police chief appointed as CRPF's new director general

New Delhi, Jan 19: The Centre has appointed Assam Police chief Gyanendra Pratap Singh as the new director general (DG) of the central reserve police force (CRPF). An order issued late on Saturday by the department of personnel and training (DoPT) read that the appointments committee of the cabinet (ACC) approved the union home ministry's proposal to appoint Singh as the new head of the country's largest paramilitary force. ACC has approved the proposal of the ministry of home affairs for the appointment of Shri G.P. Singh, IPS (AM) 1991, as director general, CRPF," the order issued by the DoPT said. Singh will serve as the CRPF chief until further orders or until his superannuation on January 31, 2027. The new CRPF DG has previously served in the special protection group (SPG) and the national investigation agency (NIA), among other senior roles in the state police. Last month, the ministry of home affairs (MHA) issued an order assigning the additional charge of CRPF DG to 1993-batch IPS officer Vitul Kumar following the retirement of incumbent Anish Dayal Singh on December 31. With a strength of nearly 300,000, the CRPF is India's largest paramilitary force.

# Fasting Dallewal given medical aid after govt invites protesting farmers for talks

New Delhi, Jan 19: Protesting farmers had accused the Centre of adopting an "indifferent attitude" to their demands and expressed concern over Dallewal's deteriorating health. Fasting farmer leader Jagjit Singh Dallewal, the convener of Samyukta Kisan Morcha (Non-Political), was given medical aid on Sunday on the intervening night of Saturday and Sunday. This came as Dallewal agreed to take medical aid after the Centre invited the protesting farmers to a meeting in Chandigarh on February 14 to discuss their demands. A team of government doctors administered Dallewal IV fluids. The farmer leader, however, continues his fast-untodeath protest. The 70-year-old leader has been protesting at the Khanauri border since November 26 to press the Centre to accept the farmers' demands, including a legal guarantee of minimum support price (MSP) for crops. Besides a

legally guaranteed MSP, the protesting farmers have been demanding a farm loan waiver, pension for farmers and farm labourers, no hike in the electricity tariff, withdrawal of police cases and "justice" for



violence, reinstatement of the Land Acquisition Act, 2013 and compensation to the families of the farmers who died during a previous agitation in 2020-21. Earlier, the protesting farmer leaders had accused the Centre of adopting an "indifferent attitude" to their demands and expressed concern over Dallewal's deteriorating health. During the deadlock, the Punjab government had expressed its inability to force Dallewal to accept medical aid. The top

court is hearing a contempt petition against the state chief secretary and the director general of police for non-compliance with the December 20 order to provide medical aid and hospitalisation to Dallewal. The discussions between the Centre, Punjab government, and farmer representatives will occur at the Mahatma Gandhi Institute of Public Administration in Chandigarh's Sector-26. ensure your presence on time," read a letter issued by the Union agriculture ministry joint secretary Priya Ranjan. Representatives from the Sanyukt Kisan Morcha and Kisan Mazdoor Morcha have

# Uniform Civil Code key to national integration, need consensus for implementation: Ex-CJI Gogoi

Surat, Jan 19: Former Chief Justice of India Ranjan Gogoi on Sunday called the proposed Uniform Civil Code (UCC) a "very important" step towards national integration and social justice, stressing the need to build consensus before its implementation. Speaking at the 'Surat Litfest 2025' here, the Rajya Sabha MP supported the 'One Nation, One Election' idea and said frequent polls affect governance, strain the administration and finance, and cause election fatigue. "I see Uniform Civil Code as a very progressive piece of legislation which will replace diverse customary practices that have evolved into laws," the former CJI said. If implemented, UCC would establish a single set of personal laws for all citizens, regardless of their faith. It would apply to matters like marriage, divorce, adoption, inheritance, and maintenance. "Now, I think it is a very important step towards national integration to achieve social justice, and let us be clear on one thing - it does not come into conflict with Articles 25 and 26, which is the right to religion," he said during a session where he discussed various issues with Prafulla Ketkar, the editor

number one reason why I support it is governance. Every year some election is going on ...Every year the country gets into election mode, which means MCC (mode code of conduct). The ministers have to perform their electioneering duties and the adminis-

tration stops. All these affect governance," he said. Money is spent by political parties and the administration in some states is caught

up in election duties for six months every year, he said. Election fatigue due to frequent polls is among the other reasons why he backs the idea, Gogoi said. The ex-CJI called the huge pendency of cases plaguing the judiciary a solvable problem, but rued that "nobody seems to be nterested in doing anything about t". With 5 crore pending cases, there are 9 crore litigants, and with each having a family of five, 45 crore Indians are stuck in legal cases, he said. "Has anybody realised this? Has this issue been raised in any forum," the Rajya Sabha member asked. The judicial system is not about collegium, which has the power of appointment, said Gogoi,

adding that about 45 crore Indians are stuck in perpetual litigation and one doesn't have to wait till 2047 to find a solution. "You have to get it tomorrow," he stressed. Discussions about the judiciary on any forum and in the media revolve around the collegium system

of appointment, the power of the judiciary, its overreach, and who is supreme between Parliament and the judiciary, but not pendency of cases, he said. "How to resolve the pendency of 5 crore cases has not been discussed, no white paper has been published, and nobody seems to be, pardon me, interested. But, to my mind, it is a solvable problem, and I think the head of the judicial family, the Chief Justice of India, should take the initiative," he said. He emphasised the need to get "good people" to become judges to improve the justice delivery system. "There are 24,000 judges in the country. Raise this to one lakh and get good people out of 140 crore. People who mean business. You have never endeavoured to find out what this man's true character is. Is he compassionate, kind? Is he a good man? Does he have a mission in life," he asked. As far as the new criminal laws are concerned, they have both "good and bad features", Gogoi said. Some of the positive features are provisions of community service for petty offences, some crimes being made gender neutral, setting up of a director of prosecution in every district, and expert evidence getting more credence, he said.

#### Karnataka ministers demand fair share of union funds; accuse **Centre of injustice**

BENGALURU. After Chief Minister Siddaramaiah, it was the turn of Revenue Minister Krishna Byre Gowda to seek more funds from the Union government.After a meeting with Union Agriculture Minister Shivraj Singh Chauhan, Byre Gowda demanded that Karnataka be given its fair share of funds.

He said injustice is being done to Karnataka when it comes to release of funds and urged the Union government to rectify the same."Why should we be denied our fair share of funds? We've sought funds for Karnataka, which have to be rightfully given to us. This is based on the work we have done. Funds should be released without any further delay," he said.

The revenue minister, however, expressed confidence that the Centre would set right the imbalance in terms of fund release.

"However, speaking defensively, Union minister Chauhan said the state government should first utilise the funds the Centre had already provided. The Union government would provide funds without any delay. He urged the state government to effectively utilise the funds already released and promised that additional resources would be made available. "We will work on increasing the allocation for staff and the ATMA scheme," Chauhan said.On Friday, Siddaramaiah accused the Union government of betraying the state in terms of allocation of funds.

#### **Polavaram irrigation project:** Construction of new D-Wall works begin

VIJAYAWADA. The construction of the new Diaphragm Wall (D-Wall) of the Polavaram Irrigation Project on the Godavari River commenced on Saturday. After performing special puja, the excavation work was taken up using cutters. The new D-Wall will be constructed at an estimated cost of '990 crore. The new D-Wall was necessitated after the old D-Wall was damaged by floods in 2019 and 2020. After the NDA government was formed in the State, Chief Minister N Chandrababu Naidu gave topmost priority to the Polavaram project, and the Centre approved the construction of the new D-wall following recommendations from the committee of international experts.

According to the project officials, a 1,400metre-long D-Wall will be constructed in parts called panels. There will be approximately 371 panels, and once the entire construction of D-wall is constructed, it will be one single large structure. Using giant cutters, soil will be excavated in 2.8 metres width and depth up to 2 metres below rock strata beneath the riverbed, with depths ranging from 40 to 90 metres depending on the riverbed's geological composition. After excavation, concrete work will be taken up. The Central Water Commission has finalised the T5 type composition out of the two types recommended by the panel of international experts. On an average, construction of each panel will take three days.

#### **Mandatory financial course for** undergraduate engineering students in TN likely soon

CHENNAI. With an aim to improve financial literacy among engineering students, Anna University is likely to offer a mandatory financial education course for its undergraduate students. Varsity officials said the academic council has approved the proposal and the syndicate has given it the go-ahead."The proposal to offer a course on financial education as a mandatory course to all UG students was discussed in detail at the last syndicate meeting," said a faculty of the university.

Director-academic courses have been informed to explore suitable avenues for implementing it in the pre-final semester. the faculty added. The course is likely to be implemented from next academic year in the varsity and for its affiliated colleges. A senior faculty told that the low level of financial awareness among students prompted the proposal and hence the course is likely to be compulsory."Discussions are on to chalk out the contents of the course. We are planning to prepare a course which will serve as a complete guide on financial education," said the faculty.

Varsity officials said engineering students with financial knowledge are in demand and that it may enhance their employment opportunities

The idea to offer financial education was mooted with more students opting for entrepreneurship these days after completing engineering degrees. The audit courses will cover topics like auditing principles, risk assessment and internal control which will help engineering students-turned- entrepreneurs have a better control on their business ventures.

"Nowadays, basic financial education has become a necessity. If students are aware financially, it will be much easier for them to build their businesses and take decisions. One of the major reasons for failing businesses is poor financial decisions," a senior faculty said.

# India emerging as major pole for global economy: Singapore President Tharman Shanmugaratnam

BHUBANESWAR. President of Singapore Tharman Shanmugaratnam on Saturday said India is emerging as a major pole for the global economy and poised to move up the ladder due of its demographics, development process and

significant potential as an export economy.Interacting with the media during his visit here, Tharman said, in a multi-polar world, India aspires to be a pole in its own right, "that's true geopolitically and also economically.'

Tharman said India and Singapore are now on a new plane of cooperation. "India is a nation that we would like to collaborate with," he said wrapping up his two-day visit to Odisha with a visit to Bharat Biotech vaccine

manufacturing unit in Bhubaneswar. Semiconductor ecosystem, skill infrastructure and sustainability are major priority sectors between the two nations but connectivity is another area of focus too. During his meetings with the leadership in India, he said it came out clearly there is keenness to expand the air services agreement that benefits both the economies."It was revised about 10 years ago but we are now at the 10-year point to look at the next 10 years. Aviation as a tool has potential for India to emerge as a player in the maintenance, repair and overhaul (MRO) business," he said.Prime Minister Narendra Modi had raised it during his September visit to Singapore which has companies ranked as global leaders.



Talking about the strong bilateral relations between the countries, President Tharman said it is not just about specific industries but about working on projects that continue to build trust between the two countries. "Trust is in short supply internationally, and Singapore and India can show how it is possible to build trust in today's world, even in today's uncertain and fractious world," he said.

He pointed out that for Singapore to do well in the future, it must engage closely with ASEAN neighbours such as India with China. "That's where the opportunities are and that's where we also develop our sense of being contributors to Asia's growth, sustainability and stability," he added.During his two-day visit to Odisha, at least eight MoUs were inked between Odisha

government and Singapore companies across varied sectors. The President said Odisha is poised for a new stage of development and must start working on the enablers. "I decided to come to Odisha at this stage because the east is rising in India and it's a priority for the Indian government," he said.Starting off from a lower level of income compared to other states, the Singapore President felt Odisha is aspiring to move on, and with the right focus on education and skills. "Chief Minister Mohan Charan Majhi and Union Minister for Education minister Dharmendra Pradhan visited

Singapore along with their officials. They are very keen to work with us on specific projects," he said referring to skilling, ITES, industrial parks and semiconductor sectors.

He also mentioned that Odisha has clear strengths in petrochemicals and Singapore companies are looking at contributing to development of the sector. Tharman who interacted with students at the World Skill Centre, established with support from Singapore, said he found them full of hope and optimism."I come away, feeling optimistic about Odisha," he added.

#### Retd inspector, subedar killed in road mishap near Odisha Raj Bhavan



BHUBANESWAR. In a tragic incident, two persons were killed after their motorcycle was hit by a speeding hatchback car in front of Raj Bhavan within Capital police limits here on Saturday evening. The deceased have been identified as Goura Chandra Nayak and Rabi Chandra Nayak, both of whom were retired inspector and subedar respectively. They were reportedly relatives. Police said while Rabi was riding the motorcycle, Goura was seated behind him. The duo was going towards AG Square from Surya Nagar when they were hit by the speeding car coming from Power House Square. Due to the impact of the collision, both the motorcycle and the car jumped on the roundabout in the area.

The accident, which took place on a very busy stretch, reduced their two-wheeler to a mangled wreck. While Goura was declared received dead in the hospital, Rabi was rushed to a private healthcare facility where he succumbed after a few minutes. Police said the car was being driven by one Lalatendu Barik and he had also hit two other persons travelling on a motorcycle. One of them sustained serious injuries in the accident and is undergoing treatment in a hospital

Sources said Lalatendu's alcohol examination was conducted immediately but he tested negative. He reportedly told the investigators that he suffers from an underlying neurological disorder which triggers seizures in his body."The car was seized and the accused driver has been detained. Further probe into the matter is continuing to ascertain the reason behind the accident," said Capital police station IIC, Dayanidhi Nayak.Sources said Barik is a native of Raghunathpur area and works with an IT company here. On January 13, two persons including a pedestrian were killed after being hit by an SUV in Janla area on the outskirts of the city.

# Customs arrest Kerala native with hydroponic weed worth Rs 7 crore in Bhubaneswar airport

BHUBANESWAR. Continuing its crackdown against mules engaged in transporting hydroponic weed, Customs (Preventive) Commissionerate on Saturday arrested a Kerala native from Biju Patnaik International Airport (BPIA) and seized 7 kg of the contraband from him. The highly potent variety of ganja is said to be worth about Rs 7

Acting on a tip-off, the customs officers stopped the person after he arrived here from Bangkok. During scanning of his check-in baggage, they found 7 kg of hydroponic weed concealed inside snacks packets. He was then arrested under the Narcotic Drugs and Psychotropic Substances Act. The arrest comes four days after another Kerala native was nabbed from BPIA on Tuesday with 4 kg hydroponic weed valued at Rs 4 crore. He too had arrived here from Bangkok.Sources said both the persons are reportedly linked to each other and lured by

#### Number of full irrigation tanks in Tamil Nadu doubled to 5,445 compared to last year

CHENNAI. In the last four months, the number of tanks that have reached their full capacity in Tamil Nadu has risen from 450 to 5,455, thanks to the copious rainfall during the northeast monsoon season. This is almost twice the number compared to the same period last year (January 2024), when only 2,914 tanks were full. The Tamil Nadu Water Resources Department (WRD) manages 14,410 irrigation tanks across the state. Currently, 3,751 tanks have water levels ranging from 76% to 99%, while 182 tanks are bone dry. Officials said that a lack of water inflow due to encroachments of inlets may have led to the drying of these tanks.

'Compared to the previous monsoon, the state has sufficient water storage in irrigation tanks this year. In 22 districts, including Chengalpattu, Tiruvannamalai, Villupuram, and Pudukkottai, there are zero dry tanks," a senior WRD official told TNIE. The official added that improved water storage will help recharge groundwater in dry regions. The official, however, said that of the estimated 5,000 tanks in Chennai, Tiruvallur, Kancheepuram, and Chengalpattu districts, WRD now manages only 1,551 tanks, as the remaining ones have been encroached upon. "We are taking legal steps with the support of revenue and police officials to retrieve the tanks," the official said. The state government has also instructed authorities to identify old tanks using revenue records, he added.K. Balasubramani, state secretary of Tamil Nadu Vivasayigal Sangam, said, "Sufficient water in irrigation tanks will enable farmers in delta districts and the western region to cultivate short-term crops such as black gram, green gram, and millets, boosting foodgrain production in the coming months." ## Farmers block road in Odisha's Upalada demanding purchase of discoloured paddy

BERHAMPUR. Vehicular movement between Paralakhemundi and Berhampur was disrupted for several hours on Saturday as hundreds of farmers staged road blockade at Upalada demanding procurement of discoloured paddy at mandis in Gajapati district. The agitating farmers said last month, Chief Minister Mohan Charan Majhi visited the district to take

stock of the damage to crops due to unseasonal rains. The CM had assured immediate disbursement of crop damage assistance to the affected farmers. While not a single farmer has received the promised assistance, several mandis are only accepting FAQ paddy, they claimed.

The district administration started paddy procurement in Gajapati from December 7. Farmer leader Suryanarayan Patnaik said as the administration is yet to finalise the list of millers to participate in the procurement process, farmers are waiting at mandis with their paddy stocks. As mandis don't have storage facility, farmers are compelled to guard



their paddy under the open sky."Making matters worse, mandi officials are only allowing FAQ paddy due to which several farmers are returning home with their discoloured paddy stocks. Protesting this attitude of officials, farmers blocked the state highway with their paddy," said Patnaik.

On being informed, the civil supplies officer (CSO) of Gajapati, local tehsildar and deputy registrar of cooperative societies reached the protest site. However, they were detained by the irate

The agitators said they will continue the blockade and not release the detained officials until the administration gives them a written assurance of receiving their paddy within three days.

Later, police reached the spot and held discussion with the farmers. The officials were released after giving in writing that discoloured paddy would be received at mandis in three days.CSO Prafulla Behera said this year, a target has been fixed to procure 5.85 lakh quintal of paddy from farmers in

# Ghaziabad's first automated driving centre hits legal roadblock before launch

GHAZIABAD. The city's first Automated Driving and Training Centre (ADTC), slated to begin operations on Friday, January 17, encountered a roadblock before its launch due to the cancellation of its operating licence to a private company. This action followed an advocate's letter to the transport secretary citing an Allahabad High Court order, which states that only the central govt, not state govts, has the authority to establish rules for licensing and regulating motor driving training

The cancellation order, issued on January 11, 2025, by the Transport Department's Principal Secretary L Venkateshwarlu, revoked the previous licence granted on December 31, 2024, by the former transport commissioner. "Advocate Neeraj Mishra wrote a letter stating that the setting up of the Ghaziabad ADTC is against the rules. Investigation also revealed that there are some irregularities in the transport



commissioner's order, and hence that order stands cancelled," Venkateshwarlu said.

The Allahabad High Court order, dated October 25, 2024, stated that only the central govt has the authority to establish rules for licensing and schools. This was in response to a PIL filed in the court after the Uttar Pradesh govt issued an order in 2023 laying down Standard Operating Procedure (SOP) for private motor driving training schools and their operation.

Advocate Mishra also alleged irregularities at existing ADTCs in other places, claiming licences were being issued without proper testing for a fee of Rs 6,000.

#### Body of 5-yr-old girl found in Ghaziabad drain, teen held for rape & murder

Ghaziabad. A 19-year-old youth was arrested for allegedly raping and murdering a 5-year-old girl after a gunfight with police near Kaushambi bus terminal on Saturday morning. His arrest came within hours of the girl's body being recovered from a drain, days after she was reported missing from outside her house on Jan 15. Originally from Madhepura in Bihar, Noor Alam — the arrested accused — worked as a helper in a private school bus in Noida.

According to Rajneesh Upadhyay, assistant commissioner of police (ACP) in Sahibabad, the girl disappeared around 10pm from outside her house on Jan 15. Her family filed a missing person's complaint the next afternoon at Link Road police station.

Police teams reviewed footage from over 75 CCTV cameras in the area and spotted a man in a white hoodie walking with the girl. But they couldn't zero down on Noor then because his face wasn't clearly

The breakthrough, however, came when the girl's grandmother and neighbours revealed they had last seen the 5-year-old with Noor, who had been actively participating in search operations and police investigation until then. His shoes also matched the ones worn by the man in the footage.

"When cornered near Kaushambi bus terminal on Saturday, Noor fired at the police team and tried to escape. He was, however, injured in retaliatory firing," said Upadhyay.

"After his arrest, Noor confessed to raping the girl in the school bus — where he usually slept at night — and then strangling her to death. He packed the body in a sack and disposed it of in a nearby drain," the ACP added. The girl had a complex family history, which had led her to living with her grandmother. After her parents got a divorce, her father moved to Mumbai to work with a private firm while her mother married another man. She left the child with her grandmother, visiting her occasionally.

On the day of the incident, the girl was on her way home with her grandmother when they met Noor. The child approached Noor for Rs 5 to buy toffee, and started following him when he refused.

#### Police to now use tech to map snatching hotspots

Israel-Hamas Hostage Deal. Israeli Prime Minister Benjamin Netanyahu has said that Israel will not be able to move forward with an agreed framework in connection to the implementation of the ceasefire deal in Gaza until Hamas provides the list of hostages to be released. He asserted that any violations of the agreement will not be tolerated.

In a post on social media platform X, the Office of the Israeli PM quoted Netanyahu and said, "We will be unable to move forward with the framework until we receive the list of the hostages who will be released, as was agreed. Israel will not tolerate violations of the agreement. Hamas is solely responsible.'

This comes after the Israeli government on Saturday gave its approval to the ceasefire and hostage release deal with Hamas by a vote of 24-8, according to a report by Times of Israel. TRÊNDING NOW

Earlier on Friday, the Israeli security cabinet had approved the hostage release-ceasefire deal with Hamas and recommended the government to adopt it.The Israel government's hostages and missing persons coordination unit on Friday notified the families of the 33 Israeli hostages expected to be set free in the first phase of the Gaza ceasefire deal.Israel has not been told how many of the 33 are alive, though it expects the majority are. Israel will receive a full status report on all those on the list seven days into the ceasefire. The order of release is not yet known. The identities of those set to return are expected to be provided 24 hours before each release, as reported by the Times of Israel.

Beyond the 33 hostages set for release in phase one, Israel says 65 more hostages are currently held in Gaza, including the bodies of at least 36 confirmed dead. As the first phase progresses, talks will focus on the release of remaining hostages, ending the war, and Gaza's future reconstruction.

# Thousands rally in Washington for rights, abortion access before Trump's inauguration

**WASHINGTON.** Thousands of people from around the United States were rallying in the nation's capital Saturday for women's reproductive rights and other causes they believe are under threat from the incoming Trump administration, reprising the original Women's March days before Presidentelect Donald Trump's second inauguration. Eight years after the first historic Women's March at the start of Trump's first term, marchers said they were caught off guard by Trump's victory and are determined now to show that support remains strong for women's access to abortion, for transgender people, for combating climate change and other issues.

The march is just one of several protests, rallies and vigils focused on abortion, rights, immigration rights and the Israel-Hamas war planned in advance of inauguration Monday. Around the country, over 350 similar marches are taking place

in every state. Jill Parrish of Austin, Texas, said she initially



bought a plane ticket to Washington for what she expected to be Democratic Vice President Kamala Harris's inauguration. She wound up changing the dates to march in protest ahead of Trump's swearing-in instead, saying the world should know that half of U.S. voters didn't support Trump.

Most importantly, I'm here to demonstrate my fear, about the state of our democracy," Parrish said.Demonstrators staged in squares around Washington ahead of the march, pounding drums and yelling chants under a slate-gray sky and in a chilly wind. Protesters then marched to the Lincoln Memorial for larger rally and fair, where organizations at the local, state and national level will host information

They held signs with slogans including, "Save America" and "Against abortions? Then don't have one" and "Hate won't

There were brief moments of tension between protesters and Trump supporters. The march paused briefly when a man in a red Make America Great Again hat and a green camo backpack walked into a line of demonstrators at the front. Police intervened and separated him from the group peacefully as marchers chanted "We won't take the bait."

As the protesters approached the Washington Monument, a small group of men in MAGA hats walking in the opposite direction appeared to draw the attention of a protest leader with a megaphone. The leader veered closer to the group and began chanting "No Trump, no KKK" through the megaphone. The groups were separated by high black fencing and police officers eventually gathered around.

Rick Glatz, of Manchester, New Hampshire, said he came to Washington for the sake of his four granddaughters: "I'm a grandpa. And that's why I'm marching.

Minnesota high school teacher Anna Bergman wore her original pink pussy hat from her time in the 2017 Women's March, a moment that captured the shock and anger of progressives and moderates at Trump's first win. With Trump coming back now, "I just wanted to be surrounded by likeminded people on a day like today," Bergman said.Rebranded and reorganized, the rally has a new name — the People's March as a means to broaden support, especially during a reflective moment for progressive organizing after Trump's decisive win in November. The Republican takes the oath of office Monday. Women outraged over Trump's 2016 presidential win flocked to Washington in 2017 and organized large rallies in cities throughout the country, building the base of a grassroots movement that became known as the Women's March.

A ceasefire in Gaza between Israel and Hamas is set to come into effect on Sunday morning with a hostage release to follow hours later, opening the way to a possible end to a 15-month war that has upended the Middle East.The agreement followed months of on-off negotiations brokered by Egypt, Qatar and the United States, and came just ahead of the Jan. 20 inauguration of U.S. President-elect Donald Trump.

The three-stage ceasefire will come into effect at 0630 GMT on Sunday. Its first stage will last six weeks, during which 33 of the remaining 98 hostages women, children, men over 50, the ill and wounded - will be released in return for almost 2,000 Palestinian prisoners and detainees. They include 737 male, [1] female and teen-aged prisoners, some of whom are members of militant groups convicted of attacks that killed dozens of Israelis, as well as hundreds of Palestinians from Gaza in detention since the start of the war.

Three female hostages are expected to be

released on Sunday afternoon through the Red Cross, in return for 30 prisoners each. After Sunday's hostage release, lead U.S. negotiator Brett McGurk said, the accord calls for four more female hostages to be freed after seven days,

#### Accused in STR melanistic tiger poaching case were in contact with three middlemen



BHUBANESWAR. The special enforcement wing of the Similipal South wildlife division probing the melanistic tiger poaching case has found that the accused arrested so far were in contact with at least three middlemen, indicating a possible racket involved in wildlife crimes in the area. "During interrogation, the accused revealed names of three middlemen they were in touch with after killing the rare melanistic tiger," said an STR official privy with the development.

He said that they are taking the help of police in apprehending these middlemen to further ascertain if any organised or inter-state racket is active in the region. All these middlemen named by the accused belong to Odisha, the official said.

Meanwhile, STR officials said they have intensified their search operation to apprehend prime accused Rabindra Naik of Baniadara village, who is still absconding. The special wing had on January 12 seized the melanistic tiger hide from one of the 10 accused from Tentula village.

In a heart-wrenching incident, a 10-year-old Class IV student of Bagapatia Upper Primary School in Jajpur district, Odisha, tragically lost his life after falling off a concrete slide on the school premises during school hours. #### After sun sets, abandoned buildings in Mathur MMDA turn hub for anti-socials

CHENNAI. At least 20 buildings in Mathur MMDA, developed in the 90s by the Tamil Nadu Housing Board (TNHB) and the Madras Metropolitan Development Authority (MMDA), continue to remain unused for decades. Intended to house primary and nursery schools, police station, fire station, and electrical substation, these structures are now hotspots for anti-social activities, especially after the sun sets, say residents.

Due to TNHB's alleged failure to transfer or sell them to the respective departments or interested buyers, the facilities did not serve their purpose, but remained unused, deteriorating over the years. "These buildings, which were meant to educate children and prevent crime, have ironically become hubs for illegal activities, affecting the same children," said M Raja Rajan, president of TNHB Colony Welfare Association. Women residents said that these abandoned structures



increased safety concerns.

"I've been here for over two years, and the situation has worsened last year. Every night, groups of boys aged 15-25 gather in the abandoned school building on my street to consume alcohol. Returning from my night shift at 11:30 pm is terrifying. Sometimes, they ring our doorbell repeatedly," said Kamala (name changed), a 26-year-old IT professional and resident of MMDA 29th

ration shop has no compound wall. Around 20 boys, aged 15-18, often hide behind the building to consume alcohol. Recently, a drunken boy threw stones at an electrical junction box, forcing us to call the police," said Usha B, a resident of First Main Road, MMDA 46th Street, adding that there have been instances where these boys harass women and run away.

These abandoned sites have also become garbage dumping grounds, increasing mosquito population and posing health risks. While police have increased patrolling in the area, residents insist on permanent solutions. They urged authorities to demolish these buildings and replace them with functional The CWC approved the D-Wall's schools, hospitals, parks, and community halls. "Several vacant lands earmarked for purposes such as a theatre, religious spaces, and a market also remain unused. No action has been taken so far to initiate these constructions," said R S Babu, secretary of Mathur MMDA Welfare Association.

BHUBANESWAR. Odisha has the fifth highest number of unrecognised schools - mostly private Odia and English medium - in the country. The Ministry of Education has detected 1,052 unrecognised schools in the state. These schools currently have 91,895 students with 8,285 teachers. Although these schools are functioning with a Unified District Information System for Education Plus (UDISE+) code assigned by the ministry to keep a track of their academic performances, they are not recognised by the state government.

As per the ministry's report, while Jharkhand has the highest 5,879 such schools, it is followed by Bihar (4,915), Assam (3,630), West Bengal (3,380) and Odisha. On the whole, there are 22,298 such schools in the country. Secretary of the department of School Education and Literacy Sanjay Kumar had recently written a letter to the states asking them to either recognise such schools by March-end this year or take appropriate action against them. As per the Right of Children to Free and Compulsory Education (RTE) Act, 2009, no school can be established or operated without obtaining recognition from the government. Section 19 of the Act states that the schools established before the commencement of the Act and not fulfilling the norms shall take steps to fulfil them within three years from the date of commencement of the Act.It also mandates that if such schools fail to fulfil the norms, the recognition shall be withdrawn and they will cease to function. In spite of these provisions, 1,052 unrecognised schools in the state are continuing in UDISE+ till date.In his letter, Sanjay Kumar highlighted that many unrecognised schools were included in the UDISE+ list with the condition that they.

**BENGALURU.** A section of employees from a few government departments are not getting salaries on time for various reasons. For no fault of theirs, those who have taken loans from the Karnataka Government Insurance Department (KGID), or have to pay

their monthly contributions to KGID policy, have ended up paying ''penalty interest" for delays in their payments. Now they have approached senior authorities in the state government to rectify levying more interest for delayed payments.Government employees of a few departments in some districts, including Zilla and Taluk Panchayat, Health, Education Women and Child

Welfare and Rural Development and Panchayat Raj, have not been receiving salaries on time. In many cases, it is delayed by days, in many others by months. This issue has been continuing over several years.

The government-sanctioned posts are 7.7

lakh, of which around 5.4 lakh posts are filled. The shortage has resulted in the government depending on a large number of contract employees, especially guest lecturers, CS Shadakshari, President, Karnataka pourakarmikas and others, who too are

not getting salaries on time.



'Employees pay additional loan interest due to delayed salary'

The state government spends more than Rs 1 lakh crore and with 7th Pay Commission recommendations, it increased by at least Rs 22,000 crore to Rs 25,000 crore, including for salaries and pensions. "The government is struggling to manage this and this is one of the reasons for delays in payment of salaries," said a senior official requesting anonymity.

State Employee Association, said KGID, a government-owned body,

gives loans for lesser interest. "The loan amount is deducted on a particular date every month. But when the salaries are delayed, many are unable to pay the interest on time. The salaries are delayed for various reasons. But for no fault of theirs, they are paying additional interests," he said.

He has written to the Additional Chief Secretary (Finance), urging him to make changes in the software

of KGID that deducts additional interest for delayed payments. "Employees who are facing inconvenience have approached me. It is not just loan interest payment, even KGID monthly contributions are also paid late," he said.

#### MUDA scam case: ED attaches 142 properties worth Rs 300 crore involving Siddaramaiah

BENGALURU. After the Directorate of Enforcement (ED) attached 142 immovable properties worth Rs 300 crore on Friday under the Prevention of Money Laundering Act (PMLA) in connection with the MUDA case against Chief Minister Siddaramaiah and others, all eyes are now on the Lokayukta report on the alleged MUDA site allotment scam.The Karnataka High Court has directed the Lokayukta Police, probing the alleged scam in which Siddaramaiah and his wife BM Parvathi are accused No 1 and accused No 2, to submit its report by January 27. Siddaramaiah was booked under Sections 9 (bribing public servant by a commercial organisation) and 13 (criminal misconduct by a public servant) of the

Prevention of Corruption Act (PCA), Indian

Penal Code (IPC), and Prohibition of

Benami Transaction and Land Grabbing

Acts. Under the PC Act, the Lokayukta Police



are investigating whether there was any criminal intent (mens rea) behind the allotment of premium sites worth around Rs 56 crore to Parvathi at Vijayanagar, an upscale locality in Mysuru, in 2022 for 3.16 acres of land acquired from her by MUDA at Kesare village in Mysuru, which was worth around Rs 3.25 lakh. "Under the PC Act, the Swamy and land owner Devaraju have been Lokayukta Police are probing whether there was any conspiracy to wield influence (by

the accused) to get the premium sites allotted and whether they were the recipients of any illegal gratification," said sources. The ED, which has launched an investigation into the alleged scam based on the FIR registered by the Lokayukta Police, unearthed several violations, including alleged benami and other illegal transactions. During the investigation, it was found that 3.16 acres of land was reportedly denotified and converted illegally.

The land parcel was allegedly transferred to Siddaramaiah's brother-in-law Mallikarjun Swamy in 2005 and he reportedly gifted it to Parvathi in 2010. Since the land was acquired by MUDA to develop a layout, Parvathi was allotted sites in Vijayanagar with higher circle rates in violation of norms. named as the third and fourth accused in the FIR, which was registered on September 27, 2024, by the Lokayukta SP, Mysuru, on the direction of the special court for elected representatives in Bengaluru, which took cognisance of a complaint filed by RTI activist Snehmayi Krishna. The latter has named Siddaramaiah as the prime accused and his wife as the second accused. Siddaramaiah has repeatedly claimed that the land was transferred to his wife in accordance with law and that the BJP government was in power in 2021 when the plots in Vijayanagar were allotted to her.

The case also relates to alleged violations by MUDA in which many people were illegally allotted alternative sites than they were entitled to in lieu of their land acquired under a 50:50 scheme, which was introduced in November 2020 and scrapped by Siddaramaiah in 2023. Under the scheme, land losers were entitled to 50% of the developed sites, while the other half was retained by MUDA.

# Producing biochar a profitable alternative to stubble burning

Agriculture, the backbone of global food security and economies, sustains billions of lives. However, the excessive use of fertilisers and pesticides since the Green Revolution has significantly degraded soil, depleting its carbon levels, a key indicator of soil health. Simultaneously, agriculture is a major contributor to climate change, with intensive farming practices releasing greenhouse gases (GHGs), such as carbon dioxide, methane and nitrous oxide into the atmosphere. The challenges facing agriculture in India are multifaceted: demand for fair crop prices and assured procurement, effective stubble management, deteriorating soil health, lack of crop diversification, depleting water levels and rising food demand, driven by a growing population. Addressing these challenges requires innovative solutions that safeguard farmers' livelihoods, boost incomes and reduce environmental harm. Recognising their role in shaping a sustainable future, farmers are willing to adopt eco-friendly practices like carbon-negative farming, provided their profits remain intact.

Carbon-negative farming involves practices that remove more GHGs from the atmosphere than they emit. It surpasses carbon neutrality, which merely balances emissions with removals. This approach uses natural methods to capture carbon dioxide and store it in the soil, which is the best place for carbon. Practices like agroforestry, cover cropping and biochar enable this transformation, with biochar emerging as particularly effective. Biochar is a carbon-rich material produced by heating crop residues through pyrolysis, a hightemperature, low-oxygen process that sequesters carbon in the soil for centuries. Globally, Bhutan, Suriname and Panama are recognised as carbonnegative, with Sikkim leading as India's first carbon-negative state. These examples highlight the feasibility and impact of sustainable practices at both global and local levels. Carbon credits, a key driver of carbon-negative farming, offer farmers an opportunity to earn additional income. Each carbon credit certifies the removal of one metric tonne of carbon dioxide. These credits, calculated by using remote-sensing and AI-driven satellite data, enable farmers to monetise the carbon sequestered in their fields. As corporations strive for carbon neutrality, the demand for carbon credits is increasing rapidly. Private players are enrolling farmers in programmes that reward sustainable practices with carbon credits, positioning carbon-negative farming as both an environmental solution and a profitable venture.Crop residue management is one of agriculture's most pressing challenges. In Punjab and Haryana, stubble burning has escalated into a crisis, releasing massive GHGs and causing hazardous air pollution. This practice harms public health, degrades soil and pollutes the environment.A sustainable solution lies in producing biochar from stubble, unlike burning, which releases carbon into the atmosphere. Biochar locks carbon in the soil, transforming waste into a valuable resource. The concept of biochar is not new. It dates back to ancient Amazonian agriculture, where it was used to create fertile "Terra Preta" soils that remain productive even today. Modern science has revived this practice, demonstrating its ability to improve soil health, enhance water retention, boost nutrient availability and reduce reliance on fertilisers. Farmers who adopt biochar often report increased yields and greater resilience to climate stresses within a single growing season. However, scaling biochar production and adoption remain a significant challenge. In this context, the pyrolyser, a portable and automated machine developed by Applied Carbon, is transforming crop waste management by converting it into biochar directly in the field. The pyrolyser employs a high-temperature, low-oxygen process powered by syngas, a byprouct of pyrolysis, making it self-sustaining.

#### Nehru-bashing bodes ill for India

Nehru's 'Idea of India' was a united country where caste and creed would not matter.

I belong to a generation of Indians that grew up idolising the Mahatma and Jawaharlal Nehru. One was the 'Father of the Nation' and the other the country's first Prime Minister. Tales of their heroic deeds to free our land from foreign rule were what we were told by our elders and what we liked to hear. Soon after the country was freed and the British had left our shores in August 1947, an extremist, steeped in an ideology to which very few in the country subscribed, shot dead our beloved Mahatma. Nehru died a natural death many years later. It is only in the past decade since the Modi-Shah government took charge in Delhi that the denigration of our two most respected leaders began. Extremist Hindutva leader Pragya Singh Thakur was given the BJP ticket for the Lok Sabha elections. As an MP, she lauded Nathuram Godse, who had assassinated the Mahatma. The hostile reaction of people to that statement forced our Prime Minister to chide his party's representative, who is incidentally separately facing prosecution in a terror case.

But the subtle and not-so-subtle, sometimes strident, vitriol against Nehru continues to be spouted by Hindutva elements. It is sickening to hear their laments and accusations that obviously are based on the visceral hatred of the minority Muslim community. These laments and accusations have not cut ice with a large majority of the country's majority Hindu population. In fact, Nehru's standing in the freedom struggle and in people's hearts has not suffered even a tiny bit. Yet the core followers of the majoritarian philosophy continue their tirade!

These brainwashed men and women in saffron want Nehru's contribution to getting his countrymen free from the colonial yoke to be obliterated from our history books. To that end, their favoured historians are busy rewriting textbooks for students in schools and colleges.

Nehru differentiated between Muslim conquerors who crossed the Khyber Pass to enslave India and European invaders who came by the sea route. According to him, the former settled down and planted roots in our country. Over the years, they have been assimilated into Indian society. Like Jews and Parsis, who sought refuge on the western coast of India and were welcomed, they are to be counted as part and parcel of the country and its people.

On the other hand, the Portuguese, the French and the British were sea-faring people whose sole intent was to benefit their own people back home through trade and expropriation of the country's natural resources. Hindutva stalwarts reject Nehru's arguments and paint the Muslim and European conquerors with the same brush. They refuse to acknowledge the descendants of Muslim conquerors as one of their countrymen. Narendra Modi has often said in his speeches that India's subjugation to foreign rulers began a thousand years ago. We agree with him on one score, but wonder why he refuses to differentiate between colonialism and plain conquests



that are a feature of recorded history in many countries. There is a thin but clear line between the two forms of servitude. The fact that the remnants of the conqueror's armies settled in India and were assimilated has, to my mind, to be accepted. There was also conversion of natives to the religion of the conquerors. The converted can under no stretch of imagination be considered foreigners since they have not known any other country that they could call their own. The communal angle is the one that plays prominently on the minds of the adherents of Hindutva.

They also cite faulty decisions by Nehru on the course the economy should have taken. They blame his Eton and Cambridge education and the fact that he was influenced by the thoughts of leftist philosopher Harold Laski.Prof Aditya Mukherjee, a historian who taught at Jawaharlal Nehru University, has put up a spirited defence of the economic path followed by Nehru as the first Prime Minister of India. In his book Nehru's India — Past, Present and Future, Mukherjee argues that two principles were non-negotiable for Nehru — democracy and sovereignty. In the pursuit of development after the departure of the British, he only allowed these two prime concerns to guide his thinking. Hence, his choice of the public sector to fill the yawning gaps in the economy.

The commanding heights of the economy, Nehru decided, could not be placed in the hands of foreigners, who were


bound to slip in if industrial development was left to the private sector. His commitment to sovereignty was evident in this decision. The Prime Minister's commitment to democracy, Mukherjee says, meant that labour needed to be consulted in the pursuit of any grand design. If labour was to be a partner and not merely a performer on command, its consent had to be obtained through democratic consultations. Nehru's 'Idea of India' was a united country where caste and creed would not matter. That would cover the entire population. Hindutva's agenda is to unite 80 per cent of the population that professes Hinduism or other religions like Buddhism, Jainism and Sikhism that originated in India, to form the bulwark against any threat to the primacy of Hinduism.

Personally, I have no quarrel if the intention is to build up the pride of the Hindu in his or her religion. Why should she or he not be proud of following an ancient religion that has stood the test of time and is now being studied by seekers of spirituality in Europe and other advanced societies of the world? My objection is to the spread of fear and hatred against followers of other creeds and creating dissensions in society that did not exist earlier.

The demonisation of Nehru is a manifestation of the divisiveness that is spreading throughout the country because of an ideology that is fast turning viral. My view is that this will do more harm than good to India and its place in the minds of people all over the world.

Nothing weakens the national character more than a social sanction to graft and an official stamp, as it were, to the right to cheat. All organs of democracy are to

blame. If you truly desire change, revitalise the institutions. Else, expect a more shrivelled moral and ethical fibre in an average Indian.

#### India, China and the Malacca Strait game

Any blockade of the Malacca Strait could result in the Chinese invasion of Taiwan. The reverse is also possible: a blockade of Taiwan by China could lead to the closure of the Malacca Strait.

FROM the 48th floor sea-facing room at Oakwood Hotel in Sri Racha, Thailand, overlooking the Gulf of Thailand, I see an oil refinery being built by some 200 Indian employees of the multinational, Petrofac. Unlike in the adjoining dispute-ridden, China-claimed South China Sea, the Thai Gulf is tranquil. The growth of China, the world's second biggest economy, depends on an uninterrupted supply of energy, which suffers from a Malacca dilemma. During his marathon briefing on Monday, eve of Army Day, Chief of Army Staff, Gen Upendra Dwivedi said the LAC was sensitive but stable (earlier it was unpredictable). China calls the shots there; India reacts. Time it turned the tables elsewhere: possibly the Malacca Strait in the Indian Ocean where India has the upper hand for now. Along the narrow neck of southern Myanmar and Thailand, connecting the Malaysia peninsula to the Asian mainland, is the Isthamus of Kra, called Devil's Neck, like our own Chicken's Neck in the Siliguri corridor which is being hedged under the Kaladan Multi-Modal project through Sittwe port in Myanmar. Across Kra, Thailand, prodded by China, had sought to make a canal; now a 90-km land bridge is to join the Andaman Sea in the Indian Ocean with the Gulf of Thailand in the South China Sea/Pacific Ocean to bypass the Malacca Strait.An alternative passage avoiding the Malacca Strait will inflict severe strategic and economic loss on Malacca's custodians — Singapore, Indonesia and Malaysia — and alter maritime dynamics in the Indo-Pacific: depriving India of a strategic choke point in the Indian Ocean to offset its diminished deterrence against China along the LAC. China's Malacca dilemma is the stuff of legend. At a Chinese Communist Party meeting in 2003, the then President Hu Jintao mentioned the lack of alternative routes and vulnerability of the Malacca Strait to naval blockade. As much as 90 per cent of China's trade is by sea, including 80 per cent of oil and 60 per cent of gas.

The Strait of Malacca is 80 km long, 65-to-150 km wide and 2.8 km at its narrowest point.From Malacca town, I could see the other side. Around 250 ships use it daily; it is congested with cargo ships and will reach its capacity by 2030. A closure of Malacca by accident or design will cost \$85 million a week. During the Gulf War, Indian warships escorted US shipping through the Malacca Strait.China has weighed its Malacca diversion options: alternative routes, a new passage and enhancement of detterence to use the existing route. Alternative routes are available further south of the Malacca Strait through Sunda, Lombok and the Macassar Strait. These are shallow for submarines

and involve two-to-three days of additional sailing (1500 nm), incurring added cost, which a Thai estimate puts at an astounding \$200 billion a year. The Maritime Silk and Belt and Road initiatives launched in 2013 were designed to protect China's land routes and sea lanes of communication for energy. Three land corridors were envisaged: the \$65-billion China-Pakistan Economic Corridor (CPEC) from Gwadar to Xinjiang; the China-Nepal Economic Corridor (CNEC), which is at the design stage, and the \$7-billion partly developed China-Myanmar Economic Corridor (CMEC) from Kyaukphyu to Kunming, containing road,

rail and oil and gas pipelines with SEZs.

China is acquiring military bases and access to ports and airfields to dominate the Indian Ocean Region — the Djibouti military base, Gwadar (Pakistan), Hambantota (99-year lease in Sri Lanka), Kyaukphyu and Coco



island (Myanmar) and Ream (Cambodia) in the Gulf of Thailand. Negotiations are on with Madagascar, Comoros, the Seychelles and Mauritius for use of/access to military facilities.

India, too, is creating strategic assets in Mauritius, the Seychelles and Myanmar, coupled with bilateral and multilateral partnerships in the Indo-Pacific. China is a loner.In November 2023, the then Thai Prime Minister Srettha Thavisin presented the design to bypass the Malacca Strait and ports in Singapore and Malaysia, with a land bridge from Ranong and Chumphon, both deep sea container ports in the Andaman Sea and the Gulf of Thailand. In September 2024, Transport Minister Suriya Jungrungreangkit said the South-Eastern Corridor connecting Bimstec and Asean countries with the Indo-Pacific would come into effect in September 2025, the construction would commence in 2026 and the project

completed in 2030. In August 2024, PM Paetongtarn Shinawatra confirmed that Thailand would seek Chinese investment for the \$27-35-billion project.

For enhancing deterrence in the Indian Ocean, Beijing had shifted the military focus from the PLA to the PLA Navy (PLAN). It is now the fastest growing naval armada in the world, transforming from a brown-water navy to a blue-water one, crossing the First Island Chain and implementing the Two-Oceans Strategy — the Indian and Pacific Oceans. By 2035, it will be a 390-ship navy with seven aircraft carriers, frontline warships and submarines, hugely surpassing the US navy.

In the event of a blockade of the Malacca Strait by the US and/or India, which is an act of war, China may not attempt to break the blockade as it has three months of strategic oil reserves, with plans to make it last for 18

months and replenishing from Uzbekistan and Russia. Any blockade of the Malacca Strait could result in the Chinese invasion of Taiwan. The reverse is also possible: a blockade of Taiwan by China could lead to the closure of the Malacca Strait. Further, a blockade or invasion of Taiwan independent of action against Malacca will also harm India's economy.In such contingencies, as per the India-US cooperative deterrence — the Indo-Pacific Strategy — New Delhi should align its maritime domain expertise and naval capability in the Indian Ocean while the US focus should be in the Pacific Ocean. As PLAN's blue-water proficiency would take a decade to manifest, India should exploit more imaginatively China's Malacca dilemma to alter the adverse balance along the LAC. Or, will the Kra land bridge become China's hedge?





When applying for a job, women seek positions with fewer applicants than men - a factor that could partly explain why we see fewer of them in the corporate boardrooms, new research suggests.

The size of a competition - such as the number of applicants to a particular job or the number of people vying for a monetary reward - shapes who enters the competition. Women prefer smaller competitions, whereas men seek larger competitions, which are typically associated with higher monetary rewards, the study said.

"These patterns of findings can contribute to a better understanding of gender inequality in the workforce," said Kathrin Hanek, the study's lead author from University of Michigan in the US.

"The gender difference in preferences may in part explain pay gaps and the underrepresentation of women in particular fields or at the helm of large organisations," Hanek noted.

The findings appeared in the Journal of Applied Psychology.

The difference between the genders can be partially attributed to women feeling more comfortable in smaller competitions. The researchers found consistent gender

differences in the preference for smaller versus larger competitions across a variety of different competition contexts.

For instance, one study examined women's and men's real decisions to enter a small (10 competitors) or large (100 competitors) word-formation task competition.

#### Woman strangled by boyfriend in Delhi, murder staged as suicide

NEW DELHI. A 23-year-old woman was murdered by her boyfriend in northwest Delhi's Bharat Nagar on Friday. Police said the accused suspected she was having an affair with someone else, leading to an argument at her home. He allegedly strangled her. The accused, who has been arrested, attempted to disguise the murder as a suicide but failed.

The accused, Shakir (26), lived in Om Nagar, Dhobi Ghat, and worked as a delivery boy in Sadar Bazar. On Jan 17 police received information about a suspected suicide. The caller claimed his niece had hanged herself.

A team from the local police station rushed to the scene, where they found a woman on the floor, identified as Saniya. She used to give tuition to children.

Deputy commissioner of police (Northwest) Bhisham Singh said that a ligature was tied around Saniya's neck, and a dupatta was attached to the ceiling fan. However, the ends of the dupatta were untied. The district crime team and the Forensic Science Laboratory (FSL) team inspected the crime scene, and CCTV cameras in the vicinity were thoroughly analysed.

The circumstances were staged to appear as a suicide. However, certain facts and circumstantial inquiries raised serious doubts about this projection," said Singh.

Upon further investigation, the team recreated the crime scene and concluded that someone entered secretly from the roof, killed Saniya, and then fled. A case under section 103(1) (murder) of BNS was registered at Bharat Nagar police station.

Acting on secret information, a team led by SHO (Bharat Nagar) arrested Shakir. During interrogation, Shakir confessed to dating Saniya for five years and claimed she was cheating on him for the past three months. This allegedly led him to plan her murder. "When he was trying to hang her on the ceiling fan, someone knocked on the door. This frightened him, and he fled through the roof," police added.

#### German national caught with banned GPS device at airport, seventh case this month

New Delhi. A banned GPS device was recovered from the baggage of a German national at IGI Airport, marking the seventh such case this month. A case was registered, and the individual was bound down. Police investigations revealed that foreign nationals caught with these devices often claimed they brought them for research or navigation purposes. The incident was reported on Jan 13 when security officials identified an unspecified device in the passenger's baggage.

The German citizen, en route to Ahmedabad, arrived at IGI Airport around 10.24 am and submitted his hand baggage for screening. During the screening, CISF personnel noticed a suspicious image of an electronic device in the passenger's hand baggage, prompting a physical check. Upon inspection, a GPS device was discovered. The passenger did not have the necessary permission from the Union ministry of home affairs (MHA) or the department of telecommunications to carry the device in India.

A case was registered under Section 42(3)(d) of the Telecommunications Act of 2023 at IGIA police station. Earlier this month, similar cases were reported involving nationals from New Zealand, Switzerland, Tanzania, Tokyo, the UK, and the US. An assistant professor from a university in Varanasi was also found with a banned GPS device. To "be bound down" means being required to appear before an investigating officer on a specified date. Police sources explained that satellite phones are banned in India to mitigate security risks and unauthorised surveillance.

Some of the most successful people started off peeling stacks (and stacks) of potatoes, skinning chickens, washing dishes and clearing tables. They didn't get disheartened by the work required, as they knew that it was just a steppingstone onto bigger and better things. As a start, here are the top ten fundamentals that all recruiters want fresh grads to know:

→ It's never to early to start researching the company companies you want to work with and for the position you want. Do your background research regarding the company and the requirements for the position you want when you graduate (size, global presence, \$ value, any recent news, follow them on social media, etc.). If possible, try and talk to someone who already works there; they will be able to give you a much more accurate picture on the company's culture, work environment, etc. so that you have all the information required to make an informed decision.

Have a professional resume and cover letter. Just ensure that both your resume and cover letter portray an accurate image of you and tell the story that you want them to tell (in the best possible way). Ensure the resume is crisp and highlights the points you want the recruiter to notice. Get second opinions when possible.

Manage your social media effectively. Think of yourself as a brand and all your social media as advertising your "personal brand". Just as you are going to be researching the companies/employees where you are applying, they will be doing the same to you. Ensure there isn't anything online that you aren't comfortable sharing with a room full of strangers (aka employers). Where possible have restricted profile

access or screen the information you share online. Ensure you have a LinkedIn profile. Even if you don't have any prior work experience, try and highlight internships, leadership positions, how you ranked in your school and your technical skills.

When you do manage to get an interview with the company/companies that you want, apart from ensuring that your background research on the company itself is updated and accurate, try and gather as much information about the recruiters and the selection criteria process as possible. This will be invaluable in

ensuring that you appear well informed and are adequately prepared at the time of the interview.

Practice, practice, practice. Practice mock interviews with a friend/mentor where they ask you potential interview questions, ranging from predictable ones like, "Tell us about yourself" or "Why do you think you are the right person for this job" to slightly unique ones like "What classes were your favorite and why" or "What's your favorite website" or "Who's your real life hero?" Try and make these mock interview sessions as realistic as possible with quiet locations, appropriate attire and timing the entire process.

Maintain eye contact always (depending upon the number of people in the panels). Prior to leaving, thank them for their time; ask them for their business card as well as the next steps in the

interview process. Ensure that you are prompt and respectful in your follow up.

As a summary, while the hiring criteria may vary depending on company, industry, etc., recruiters are typically looking for graduates who exhibit confidence (not over confidence). They are looking for consistency in your "personal brand".

Do your communication skills, overall appearance, attitude and personality match your resume? They're also asking themselves if you really want to work in their company or is it just one of the many open positions that you are applying for? Does your intellect and previous success record match what they envision for this role?

# Firms set terms and perks by seniors' personality traits

Companies appear to structure compensation contracts and incentive pay based on seniors' personality traits and not just firm characteristics, a team of US researchers, including an Indian-origin scientist, has found.

Companies offer incentive-heavy compensation contracts to overconfident CEOs to "exploit" their positively biased views of the firms' prospects, the

researchers noted.
"There are divergent views on the use of options and stock in CEO compensation contracts: Do they appropriately incentivise managers and enhance shareholder value and if so, why is there much varieties in their use coroses.

variation in their use across firms?" said Vikram Nanda from Naveen Jindal School of Management in the US. The notion is that if managers and shareholders -- represented by the board -- have a different take on a firm's prospects and CEO talent, there will be greater use of incentive pay that the managers value highly but the board

regards as less costly.
"When you think about incentive contracts, you don't usually think about the personality of the individual being a factor in the contract," Nanda added in the

paper published in the Journal of Financial Economics.

Using the compensation data of CEOs between 1992 and 2011, the researchers identified managers who were exhibiting behaviour that was overconfident compared to other CEOs.

"You don't usually hear about how two profitsharing agreements are going to look different because the personalities and the beliefs of the individuals are

The team conducted empirical tests to explore the relationship between CEO overconfidence and incentive

coming into play," Nanda

The researchers found that CEO overconfidence increases the proportions of total compensation that comes from both option grants and equity grants, compared to other executives.

Overconfident CEOs receive even greater option and equity intensity in innovative and risky firms.

"Overconfident CEOs are prone to overestimate returns to investments and underestimate risks. They may use extremely positive words in the media or tend to invest more than a typical manager in the industry," Nanda stated.

# EPFO New Rule! BIG Update On Personal Details And EPF Transfers — All You Need To Know

New Delhi. The Employees' Provident Fund Organisation (EPFO) has introduced a new online feature that allows its 7.6 crore members to easily update their personal details such as their name and date of birth without requiring employer verification or EPFO approval. Members with Aadhaar-seeded e-KYC accounts can now file their EPF transfer claims directly using an Aadhaar OTP, eliminating the need for employer involvement. Union Labour & Employment Minister Mansukh Mandaviya on Saturday launched two new services aimed at improving the experience for EPFO members. The minister noted that approximately 27 per cent of the grievances are related to profile or KYC issues. With the introduction of these services he expects reduction in such complaints. He also highlighted that large employers, who handle a high volume of such requests would benefit from this process.

The minister stated that the EPFO has simplified the process of joint declaration



on the EPFO portal by allowing employees to self-correct most common errors in personal details like name, date of birth, gender, nationality, father/ mother's name, marital status, spouse name, date of joining and date of leaving, without any verification by employer or approval by EPFO.

This facility will be available for members, whose UAN (universal account number) was issued after October 1, 2017 (when Aadhaar matching was made mandatory). No supporting document is required in such cases, the minister informed. If the UAN was issued prior to October 1, 2017, the employer can correct details without

the EPFO's approval.Requirement of supporting document has also been The simplification would provide relief to simplified for such cases. Only where UAN is not linked with Aadhaar, any correction would have to be submitted physically to employer and after verification forwarded to EPFO for approval, he explained.

UAN registration is done by employer for the employee at the time of joining. For many employees, mistakes were committed by employers in recording father/spouse name, marital status, nationality and service details during the registration process or later. In order to correct these errors, the employee had to make a request online with supporting documents. The request would have to be verified by the employer and then forwarded to EPFO for approval before any change could be effected. This process was called Joint Declaration. Out of the 8 lakh requests that were forwarded to EPFO by employers in FY 24-25, it was seen that only 40 per cent were sent within 5 days, 47 per cent were sent after 10 days and the average time taken by employer

employees in 45 per cent of cases through immediate correction through Aadhaar OTP verification and in the balance 50 per cent of cases through the employer itself. If any member who can self-approve has already filed his request which is pending with the employer, the member can delete the already filed request and self-approve as per simplified process. This will benefit nearly 3.9 lakh cases pending with employer as on date. About the simplification of process of claims for transfer of EPF account, the minister said EPF members with fully compliant e-KYC EPF accounts can file their Online Transfer Claims with Aadhaar OTP directly with EPFO without any need for intervention of employer.If number of claims filed (1.3 Crore) during FY 2024-25 is considered more than 94 per cent claims (1.2 crore) will instantly reach EPFO. The turnaround time of EPF transfer claim processing will be considerably reduced since it does not require approval by the employer.

bhishek Bachchan, a seasoned entrepreneur, recently opened up about his journey in business and how it influenced his acting career. Speaking to CNBC TV18, the actor revealed there was a time when he signed films solely to fund his sporting ventures, but he has since changed that approach, prioritizing creativity over financial necessity."I have been pitched several businesses. In the early days, when you were naive, you would get impressed by these numbers. And having run 2-3 successful sporting teams, you realise that projections are just that, they are just on paper," Abhishek explained. Reflecting on his Pro Kabaddi League team and other ventures, he admitted that his earlier strategy of financing business ventures through his acting earnings took a toll on his creative work.

Thankfully, I have moved on from that thought process. I realised, about 2-3 years into kabaddi and football, that signing innumerable films to finance my love for sport and the business of sport was not something which I was very happy doing," he said. While this approach was financially sustainable, Abhishek found it creatively stifling.

'It is sustainable, it might not be a lot of fun. And then what happens is that you stop making creative choices, you start making financial choices. And I think in a creative field, that's harakiri," he said, adding, "I wanted my films to be a creative choice. Not because I had to fill the bank balance to support my, at that point of time, hobby." Abhishek now takes a more structured approach to his investments through his "family office." He shared, "I started up my family office, streamlined the finances, investment portfolios etc. It's taken me about seven years, but thankfully, now we have a balance sheet and allocated funds through my family office that I can run a sporting business." He further emphasized, "It is a passion for me but it is not something I am willing to lose money on and I will turn heaven and earth upside down to make sure it's profitable."Abhishek also recalled a pivotal moment from the 1990s when he quit college in Boston to support his father, Amitabh Bachchan. during a financial crisis. Speaking to Ranveer Allahabadia, he said, "He had to borrow money from his staff to put food on the table. I just felt morally obliged to be with him. I called him and I said 'You know, dad, I think I want to leave college half-way and come back and just be with you, try and help you in whatever way.'
