The move reflects further alienation of the Congress within the Indian Developmental Inclusive Alliance (INDIA) led by it during the Lok Sabha polls last year. The AAP and the Congress - sharing four and three of the seven Lok Sabha seats in Delhi - had fought together against the BJP in last year's general elections but are pitted against each another in the Assembly polls. Fissures appeared in the opposition alliance last vear when several parties in it supported the idea of TMC supremo and West Bengal Chief Minister Mamata Banerjee heading the grouping, currently led by Congress president Mallikarjun Kharge.

# **Tragedy at Maha Kumbh** extremely saddening: PM Modi

New Delhi, Jan. 29: Prime Minister Narendra Modi on Wednesday offered his deepest condolences to the devotees who lost their family members in the stampede at the Maha Kumbh, describing the tragedy as extremely saddening. In a post on X, he said the local administration in Prayagraj is giving all possible help to the victims and wished a speedy recovery to the injured. He said, "I have been speaking to Chief Minister Yogi ji and am in constant touch with the state government." A stampede broke out at the Sangam area of the Maha Kumbh early Wednesday as crores of pilgrims jostled for space to take a holy dip on the occasion of Mauni Amavasya. Several casualties are feared. The incident took place between 1 am and 2 am when some devotees climbed over the barricades at Akhara marg, Adityanath said. Uttar Pradesh Chief Minister Yogi Adityanath on Wednesday held a highlevel meeting at his residence here on Wednesday after a stampede at the

Maha Kumbh and said some people ment called 'Triveni Yog' is occurring chaos subsided, some searched franti-

## RG Kar case: SC asks hospitals to regularise doctors' absence during protests

New Delhi, Jan. 29: The Supreme Court on Wednesday directed hospitals, including AIIMS New Delhi, to regularise the unauthorised absence of doctors who were part of protests against the rape and murder of a doctor at RG Kar Hospital, Kolkata. A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar took note of the submissions of a doctors' body that some hospitals had regularised the absence of the doctors following its August 22, 2024 order but a few others, including AIIMS Delhi, decided to treat

# JPC adopts amended Waqf bill as Opposition slams its provisions as 'unconstitutional'

New Delhi, Jan. 29: The Joint Committee of Parliament scrutinising the Waqf (Amendment) Bill on Wednesday adopted its report and the amended version of the proposed law with a majority vote, the panel's chairperson Jagdambika Pal

said. Opposition members voiced their strong criticism of the adopted Bill, which was approved with 15-11 votes, alleging that it was "unconstitutional" and will destroy the Waqf board by allowing for the government's interference in the religious matters of Muslims. Pal, however, claimed that many of the amendments approved by the committee have addressed several concerns of opposition members as well, adding the Bill once enacted will help Waqf board in discharging its duties transparently and more effectively. For the first time, "pasmanda" (backward) Muslims, the poor, women and orphans have been included among beneficiaries of the Waqf, endowment made by

Muslims for charitable religious purposes, he added. The seasoned BIP member said the report will be submitted to Lok Sabha Speaker Om Birla on Thursday. It is now for him and Parliament to decide the next course of action, he told reporters when



asked if the Bill will be passed in the Budget Session starting from January 31 The committee held 38 meetings in the national capital since its constitution on August 8 last year and toured across the committee as it

consulted stakeholders to arrive at its conclusions Opposition MPs, including from the Congress, DMK, TMC, AAP and the AIMIM, maintained their sharp criticism of the committee's functioning under Pal and the approved version of the Bill. Some of

them submitted their dissent and others will be doing do by the 4 PM deadline on Wednesday. They said the report running into 655 pages was circulated to them on Tuesday night, and they were given little time to study it and prepare their dissent. TMC MP Kalyan Banerjee claimed the observation and recommendations of the committee are "wholly perverse". Owaisi said the propsoed law will destroy Waqf boards and make way for the government's interference in its functioning. Congress MP Syed Naseer Hussain slammed the amendments as "unconstitutional", alleging that the Bill is aimed at targeting minorities. DMK's A Raja echoed

their view and said his party will challenge the proposed law in the Supreme Court once Parliament, where the BJP-led NDA has a comfortable majority in both Houses, passes it. Rejecting the criticism, BJP MP Tejasvi Surya said the proposed law aims to bring transparency and accountability in Waqf boards. This will empower the Muslim community, he claimed. While the adopted Bill accepts the government's stand of removing the "Waqf by user" clause in the existing law, it has added that no cases will be reopened against such properties on a retrospective basis provided these are not in dispute or belong to the government. In its 655-page draft report, the Joint Committee on Waqf Amendment Bill made it clear that the provisions to omit the 'Waqf by user' definition of a Waqf property will be with prospective effect. It has also endorsed the government's move to include non-Muslims in Waqf boards, saying they can be "beneficiaries, parties to disputes, or otherwise interested in Waqf matters", sources said on Tuesday.

#### Police can't serve notices to accused through WhatsApp or electronic modes

New Delhi, Jan 28: The Supreme Court has said police cannot serve notices to accused persons through WhatsApp or other electronic modes under the Criminal Procedure Code or Bhartiya Nagrik Suraksha Sanhita, 2023. A bench of Justices M M Sundresh and Rajesh Bindal directed all states and union territories (UT) to issue appropriate directions to police for issuing notices under Section 41A of CrPC, 1973 or Section 35 of BNSS, 2023 only through the mode of service permitted under the law. "All the states/UTs must issue a standing order to their respective police machinery to issue notices under Section 41-A of CrPC, 1973/Section 35 of BNSS, 2023 only through the mode of service as prescribed under the CrPC, 1973/BNSS, 2023," the bench said on January 21. The top court went on, "It is made amply clear that service of notice through WhatsApp or other electronic modes cannot be considered or recognised as an alternative or substitute to the mode of service recognised and prescribed under the CrPC, 1973/BNSS, 2023." The direction came when the court accepted a suggestion by senior advocate Sidharth Luthra, appointed amicus curiae in the matter.

Maha Kumbh stampede: Cong slams Centre & Yogi govt.



New Delhi, Jan. 29: The Congress on Wednesday hit out at the Centre and the Uttar Pradesh government over the stampede at the Sangam, with Rahul Gandhi saying that mismanagement and administration's special focus on VIP movement instead of common devotees were responsible for this tragic incident. Gandhi also said "VIP culture" should be reined in and the government should make better arrangements to fulfil the needs of common devotees at the Maha Kumbh in Prayagraj. Multiple casualties were feared after a stampede broke out at the Sangam on Wednesday amid the ongoing Maha Kumbh, as millions of pilgrims turned up for a holy bath on Mauni Amavasya, officials said. In view of the incident, the akharas called off their traditional 'Amrit Snan' for Mauni Amavasya, even as devotees in large numbers continued to take a dip at Sangam and other ghats in the Mela area. Congress president Mallikarjun Kharge said the news of "many people losing their lives" and many people getting injured due to the stampede on the banks of the Tirthraj Sangam during the Maha Kumbh is extremely heartbreaking.

### ASI conducts 3D survey of Vijaya Vittala Temple

HOSAPETE. The Archaeological Survey of India (ASI), Hampi Circle, began the 3D survey of Vijaya Vittala Temple. The work is being carried out for the conservation of the monument in association with a private agency. Over the next few days, officials will get full digital information of the monument, and tourists are banned from entering areas when the survey is being conducted. The officials are using drones and other advanced technology to know if there is any damage to the monument.

This is for the first time that such advanced technology is being used to assess the health of the monument. The work is important to preserve the temple that was built by the Vijayanagara empire between 13th and 16th century. A trial of the 3D survey was conducted last year.A senior ASI official, requesting anonymity, said the Differential Global Positioning System (DGPS) and Light Detection and Ranging (Lidar) survey are being done at Vijaya Vittala Temple gopura for creating a 3D model. This will help the officials to get a horizontal positioning of the structure and give a 3D model of the Gopura.It will be accurate down to a centimetre.

This will not only reduce human effort, but also give a detailed picture of the structure. This survey also provides the exact condition of the gopura to plan the repair work. "We are doing this with the help of an agency from Bengaluru. This is the first time ASI is using this technology in Hampi.

# National Waterways from Akkulam to Chettuva likely to open soon

THIRUVANANTHAPURAM. The state's ambitious National Waterways project is set to attain a significant milestone with the commissioning of a 235-km stretch from Akkulam in Thiruvananthapuram to Chettuva in Thrissur soon. Official sources said the stretch will be made navigable and commissioned by April or May this year."The actual deadline

was March 2025. Unfortunately, the work was halted multiple times at Varkala owing to local dispute. Now, the work is progressing rapidly at Kadinamkulam and Varkala.

Widening of the canal is on at five locations in Varkala. We hope to complete the work in the next two months," a source said. An official with the Kerala Shipping and Inland Navigation Department told TNIE that economic development opportunities will be explored to tap tourism, cargo movement and water transportation."Tourism enhancement will be key. We have wrapped up economic development opportunity studies in certain areas and the same will be pitched at the upcoming investors meet in Kochi.

1,254 square metres adjacent to the existing centre.An MoU was signed on February 27, 2024, for the construction of an additional block spanning 30,000 sq.ft to accommodate 150 more beds, increasing the total to 260. The State government is also procuring an 18-crore PET-CT scanner, set to be operational by April 2025

Union Minister of State for Rural Development and Communications Dr Pemmasani Chandra Sekhar will lay the foundation stone for the new block on January 30. The centre, located on 1.22 acres in Guntur GGH premises, was set up with state-of-the-art infrastructure, including an ICU department, ten outpatient wards, a comprehensive lab, surgical operating rooms, and a conference hall.

In the past three years, the services available at the hospital expanded to radiation, medical, and surgical oncology, nuclear medicine, and radiotherapy.

### Karnataka HC: Getting maintenance through court not extortion

Only rural areas were covered in the survey.

Among Class 3 students, 12% (13.2 in government schools and 9.4 in private schools) were able to read Class 2 level text in 2024, an improvement from 4.8% in 2022 and 10.2% in 2018. Similarly, 27.7% (27.6% in government schools and 28.2 in private schools) of students could perform subtraction in 2024, compared to 11.2% in 2022 and 25.9%



in 2018."The gains in government schools were high compared to private schools, with an increase in 8.5 percentage points in reading and 18.3 percentage points in arithmetic between 2022 and 2024. Tamil Nadu recorded an improvement of 16.5 percentage points in arithmetic during this period, outperforming neighbouring states and the national average," said G Kumaresan, ASER associate.For Class 5 students, 35.6% were able to read Class 2 level text in 2024, up from 25.2% in 2022, though still below the 40.8% recorded in 2018. Similarly, 20.7% of Class 5 students could solve division problems in 2024, an improvement from 14.9% in 2022 but short of the 25.6% recorded in 2018.

While these improvements indicate progress, learning levels have not yet fully recovered to pre-COVID standards. The percentage of increase (11%) in the category is also higher than the national average," Kumaresan added.However, it should be noted that while the gains are better than other states, states like Himachal Pradesh, Punjab and Andhra Pradesh perform better when it comes to learning levels.

Preschool enrolment for children aged 3 has reached near-universal levels in Tamil Nadu, with 94.3% enrolled in 2024. Enrolment in government institutions for this age group rose from 62.3% in 2018 to 78.7% in 2024, although this marks a slight decline from 79.2% in 2022. The proportion of children not enrolled in school remains low, with only 1% of Class 4 students and 0.6% of Class 5 students not enrolled. Among children aged 15 to 16 years, the non-enrolment rate was 1.8%, with boys at 2.6% and girls at 1.2%.Tamil Nadu also recorded a decline in government school enrolment in 2024, dropping to 68.7% from 75.7% in 2022, as private school enrolment returned to pre-COVID levels.

# Steps on to run metro systems on solar power

KOCHI. The Kochi Metro Rail Ltd (KMRL) has initiated major steps, including the setting up of a solar plant on 50 acres in Kasaragod district, to harness solar energy in line with its ambitious plan to be fully energy neutral by 2030."We've to go for solar power for the Water Metro. But we'll do it for Kochi Metro on a war footing. Sooner or later, we'll have to run these two modern transport systems on solar energy. The sooner the better," KMRL managing director Loknath Behera told.

While KMRL is in the process of setting up a solar plant in Kasaragod, it has initiated talks to acquire 90 acres in Kuttanad in Alappuzha district."We're acquiring 50 acres in Kasaragod. It has



almost been finalised. We now have to entrust an agency like INKEL to implement it," Behera said.On getting the land, it will take nearly six to eight months to put up the solar plant, he said. "If everything goes as per plan, we can implement the project by the end of this year. Also, talks are on with the forest department to get some land, around 90

acres, in Kuttanad," he said. The Kochi Metro, operational since 2017, is one of the first metro rail networks in India to run on solar energy, with 55% of its power sourced from solar plants. The Water Metro, launched in 2023, aims to connect 10 islands along a network of routes spanning 78km. It uses energy-efficient, battery-operated boats, thereby

reducing emissions and enhancing connectivity. Complementing these efforts are the introduction of electric feeder buses and extensive nonmotorised infrastructure, including pedestrian-friendly zones and cycle tracks.

However, the missing links have continued to impede the full functionality of the road, leaving commuters to navigate alternate narrow revenue roads. The GMDA only got possession of the land parcel from HSVP in July last year. Subsequently, the development authority invited bids for the construction of the missing links.

### 8-year-old bludgeoned to death after spat between 2 groups of children in Faridabad

GURGAON. An 8-year-old girl, who was attacked with a cement pipe after a spat between two groups of children in Faridabad's Sirohi village escalated, died while being treated for head injuries at the Safdarjung Hospital on Monday.Police said they have registered a murder case. The accused, three men of a neighbouring family, are on the run. The incident, police said, occurred around 6pm on Jan 23. Sakir's daughter Nazees and his son Oberan were playing in front of their house in the village, and so were the children from the neighbourhood.

Sakir said in his complaint that kids from another family had an argument with Nazeez and Oberan. "The other group of children went home and returned with their uncles - Wajid, Sharukh, and Roben. They came with a six-feet-long cement pipe and attacked my daughter on the head. Sharukh also slammed my daughter against



the floor. I went to the terrace after hearing my son crying. The accused fled from the spot on hearing me scream," Sakir said.Sakir (40), whose family operates trucks for construction work, said he rushed Nazeez to the nearby Alfala Hospital, from where she was referred to Safdarjung Hospital in Delhi."Her condition was critical. While undergoing treatment, she succumbed to the head injury on Monday," Sakir said. Sakir told police that the three accused had an "old enmity" with him. Cops said based on Sakir's complaint, an FIR was registered at Dhauj police station under sections 103(1) (murder) and 3(5) (common enmity) of the BNS against Wajid, Sharukh and Roben.Inspector Rajbir Singh said that the accused may have mistaken Nazeez for Sakir's elder son."At the time of the assault, she was wearing boy-ish clothes.

Gurgaon.Despite construction of an additional tank at the boosting station in Sector 9A and installation of motors over four years ago, capacity of the facility remains the same, with no enhancement of water supply, residents said.MCG has failed to install a transformer required to power the motors, they said, adding that RWA members were running from pillar to post to get the issue resolved. The existing boosting station caters to three areas - Sector 9, Sector 9A, and the housing board colony - but struggles to meet the rising water demand. This, residents said, prompted MCG to construct an additional tank to meet the water requirements, especially in Sector 9A. Irregular water supply and low pressure, particularly during the summer months, at the tail-end houses is common in the area. Adding to the woes, residents highlighted that the water pipeline works connected to the boosting station was stalled, with only 80% of the project being completed in the last four years. Estimated to be built at Rs 2.15 crore in Jan 2020, the project had a completion timeline of six months but has dragged on till now."More than four years have passed, but MCG was not able to commission the new tank at the boosting station. The delay in procuring the transformer and completing remaining 20% of the pipeline work rendered the entire effort futile," said Suraj Bhola, RWA

### Mayors of Hiroshima, Nagasaki invite Trump for 80th anniversary of World War II atomic bombings

World The mayors of Hiroshima and Nagasaki have invited US President Donald Trump to visit this year for the 80th anniversary of the World War II atomic bombings, officials said Wednesday. In a joint letter to Trump, the mayors urge him to come and "listen to the testimonies of the hibakusha (bomb survivors) in person, take to heart their fervent wish for peace, and deepen your understanding of the inhumanity of nuclear weapons"."It is our sincere hope that you will break away from the notion of nuclear reliance and take strong leadership in the abolition of nuclear weapons and the realization of lasting world peace," said the January 28 letter shared with AFP on Wednesday. The United States dropped an atomic bomb on each Japanese city on August 6 and 9, 1945 -- the only times nuclear weapons have been used in warfare. Days later Japan surrendered.Around 140,000 people died in Hiroshima and some 74,000 others in Nagasaki including many who survived the explosions but died later from radiation exposure. Washington has never apologised for the bombings.

- US ambassador John Roos in 2010 became the first US representative to attend the annual Hiroshima commemoration and went to the Nagasaki event two years later.Barack Obama became the first sitting US president to come to Hiroshima in 2016, followed by Joe Biden in 2023.Trump did not make the trip during his first term, despite the two mayors inviting him according to Japanese media.
- Last year, Nagasaki's mayor Shiro Suzuki sparked a furore by not inviting Israel's ambassador to the ceremony.Suzuki insisted the decision was "not political" but to avoid possible protests related to the Gaza conflict.The ambassadors of the US, Israel, Britain and others snubbed the ceremony in protest and attended a smaller memorial event in Tokyo instead.Last year's Nobel Peace Prize was awarded to Nihon Hidankyo, a grassroots movement of Hiroshima and Nagasaki survivors pushing for a nuclear weapons ban.

### No food, nothing': Famine grips Sudan

- **World** In the span of just two months, the Sudanese mother watched helplessly as severe malnutrition killed her 10-year-old daughter, Rania, and her eightmonth-old son, Montasir, in the famine-stricken Zamzam displacement camp."I could only hold them as they faded away," Ibrahim, 40, told AFP via video call, sitting outside her straw-and-plastic shelter near North Darfur state's besieged capital El-Fasher.
- Rania was the first to succumb. In El-Fasher's only functioning hospital, understaffed and unequipped, she died in November just three days after being admitted with acute diarrhoea.Her baby boy Montasir followed weeks later, his tiny body bloated from severe malnutrition.El-Fasher, under paramilitary siege since May, is only one grim battlefield in the 21-month war between the Sudanese army and the Rapid Support Forces (RSF).

# Study says climate change made conditions that fed California wildfires more likely, more intense

**WASHINGTON.** Human-caused climate change increased the likelihood and intensity of the hot, dry and windy conditions that fanned the flames of the recent devastating Southern California wildfires, a scientific study found.

But the myriad of causes that go into the still smoldering fires are complex, so the level of global warming's fingerprints on weeks of burning appears relatively small compared to previous studies of killer heat waves, floods and droughts by the international team at World Weather Attribution. Tuesday's report, too rapid for peer-review yet, found global warming boosted the likelihood of high fire weather conditions in this month's fires by 35% and its intensity by 6%.Once-in-a-decade super strong Santa Ana winds, a dry autumn that followed two very wet years that caused rapid growth in flammable chapparal and grass, hot weather, dry air and vulnerable houses in fire-prone areas all were factors in the fast-moving fires that destroyed thousands of homes and killed at least 29 people, study authors said. But the climate attribution team was only able to quantify

issues that dealt with the fire weather index, which are the meteorological conditions that add up to fire danger. The fire weather index — which includes measurements of past rainfall, humidity and wind speed — is where the team looked and found markers

of climate change that they could quantify. The team used observations of past weather and computer simulations that compared what happened this month to a what-if world without the 1.3 degrees Celsius (2.3 degrees Celsius) of human-caused climate change that Earth has had since industrial times. That allowed them to come up with a calculation for warming's contribution to the disaster. It's a method that the National Academy of Sciences says is valid. Even though these rapid studies aren't yet peer-reviewed, nearly all of them are published later in peer-reviewed journals without significant changes, said World Weather Attribution co-lead scientist Friederike Otto."The number (35%) doesn't sound like much" because unlike dozens of its past studies, the team looked at a small area and a complex meteorological measurement in the fire weather index that



would generally mean there would be large uncertainties, said Otto, a climate scientist at Imperial College London. But in this case the climate change fingerprint is big enough that it stands out, she said. Those conditions are part of what makes California attractive to 25 million residents, said study co-author John Abatzoglou, a climate and fire scientist at the University of California Merced.Southern California has "some of the best climate, best weather on the planet — except when you get a combination of conditions that occurred here," Abatzoglou said. "You get the trifecta of dry windy and warm conditions. Those three things, in combination with dry fuels and ignitions, are the perfect recipe for fire disasters."Abatzoglou said it's like a bunch of switches — dryness, fuels, high temperatures, wind and ignition — that all need to be turned on "for conditions to really take off." Think of it as switches for a light bulb to illuminate — "and so you can think about the artificial warming due to human-caused climate change making

the light brighter," added co-author Park Williams, a UCLA fire and climate scientist. The study also found California's dry season has increased by 23 days and the lack of rain in October, November and December was more than twice as likely now than in pre-industrial times, but because of limitations on the data, researchers couldn't statistically pinpoint these to both climate change and the specific fires this month, Otto said. But she said "the rains are decreasing — that is because of human-induced climate change.

# Who can share seedsAs climate change and counterfeits hurt Kenyan farmers, it's a growing question

**KIKUYU.** Tucked away in a lush, forested area of central Kenya's Kikuyu town, the National Seed Bank stands as a crucial safeguard for the future of the country's agriculture. Inside two chilly rooms of a government building, more than 50,000 seed varieties are cataloged and stored. The bank was established in 1988 after the realization that some traditional varieties of seeds were being lost, an occurrence that is

becoming nose, an occurrence that is becoming more common with climate change. It aims to conserve seeds for research and reintroduction to farms. We realize that some of the traditional varieties that we had abandoned then are actually more resilient to climate change, so when you introduce them especially in marginal areas, those varieties outperform the improved varieties," said the director of the Genetic Resources Research Institute that operates the bank, Desterio Nyamongo, referring to hybrid seeds that must be bought every planting

that must be bought every planting season.He said the some of bank's seeds also were found to be more resistant to diseases and pests and were high-yielding.This gives hope to a country that relies heavily on rain-fed



agriculture instead of irrigation, leaving it more vulnerable to climate shocks like drought. The sector contributes a third of Kenya's GDP.

Kenya is not alone facing food security pressures. According to a U.N Food and Agriculture and Organization report in 2023, over a billion people across the African continent are unable to afford healthy diets, and the number of hungry people is increasing.

But in Kenya, another complication has emerged. Farmers in recent months suffered losses in the millions of shillings (tens of thousands of dollars) H after planting counterfeit seeds bought from private sellers.Kenyan officials have acknowledged that the seed sector is critical.During the country's first international seed quality conference in

# August, the agriculture ministry's permanent secretary, Paul Rono, said Africa has limited capacity to produce high-quality certified seeds that are subjected to quality standards.

The head of the Eastern Africa Farmers Federation, Stephen Muchiri, said the vigor of crops in Kenya has become low, and he believes that the main reason is a flawed seed breeding and propagation program.But some farmers say efforts to improve the seed system in Kenya have been limited by a 2012 law banning seed sharing, which is what millions of farmers did every planting season to cut their production cost. The government has said the law is meant to prevent the circulation of uncertified seeds and protects farmers, but it faces a court challenge from more than a dozen farmers across Kenya who say it's expensive having to buy new seeds every planting season. The next hearing in the case is in March.

Francis Ngiri is one of the farmers who filed the case. He runs an indigenous seed bank for the local community on his five-acre farm in the semi-arid Gilgil area located 120 kilometers (74 miles) from the capital, Nairobi.

### North Korean leader Kim inspects nuclear facility as Pyongyang pressures Trump administration

**SEOUL, South Korea.** North Korean leader Kim Jong Un inspected a facility that produces nuclear material and called for bolstering the country's nuclear fighting capability, state media reported Wednesday, as the North looks to increase pressure on the United States following the inauguration of President Donald Trump.Kim's visit suggests a continued emphasis on an expansion of North Korea's nuclear arsenal, though Trump has said he's willing to talk to Kim again to revive diplomacy. The official Korean Central News Agency reported that Kim visited the nuclear-material production base and the Nuclear Weapons Institute. Discovery of brutal mass graves in Syria

**DAMASCUS, Syria.** The charred remains of at least 26 victims of the Bashar Assad government were located Tuesday by Syrian civil defense workers in two separate basements in rural Damascus. The discovery adds to the growing tally of mass graves unearthed since the fall of the Assad government in December. The remains, which are believed to include men, women and children, showed evidence of gunshot wounds and burning. Members of Syria's White Helmets, a

volunteer civil defense group, exhumed the fragmented, weathered skeletal remains from the basement of two properties in the town of Sbeneh, southwest of the capital. Wearing hazmat suits, they carefully logged and coded each set of remains before placing them into body bags, which were then loaded onto trucks for transport.Since Nov. 28, the White Helmets have uncovered "more than 780 bodies, most of unknown identity," Abed al-Rahman Mawwas, a member of the rescue service, told The Associated Press. He said many were found in shallow graves uncovered by locals or dug up by animals. The bodies are transferred to forensics doctors to determine their identities, time of death and cause of death, as well as to match them with possible family members.

"Of course, this takes years of work," he said.Mohammad al-Herafe, a resident of one of the buildings where remains were uncovered, said the stench of d e c o m p o s i n g b o d i e s w a s overwhelming when his family returned to Sbeneh in 2016 after fleeing because of fighting in the area during the country's uprising-turned-civil war that began in 2011. He said they found the bodies in the basement but chose not to report it out of fear of government reprisals. "We could not tell the regime about it because we know that the regime did this."The Assad government, which ruled Syria for over two decades, employed airstrikes on civilian areas, torture, executions and mass imprisonment, to maintain control over Syria and suppress opposition groups during the country's 13-year civil war.Ammar al-Salmo, another Civil Defense member dispatched to the second basement site, said further investigation is needed to identify the victims.We need testimonies from residents and others who might know who stayed behind when the fighting intensified in 2013," he told the AP.

# White House opens doors to 'new media', allocates seats in press briefing room

WASHINGTON. The Trump Administration has announced that it will allocate seats in the White House press briefing room to representatives from "new media" outlets, including podcasters, social media influencers, and content creators.

This move, spearheaded by Press Secretary Karoline Leavitt, aims to provide representation to groups that have not previously had a presence in the briefing room."Millions of Americans, particularly young people, have shifted away from traditional television and newspapers to consume news through podcasts, blogs, social media, and other independent platforms," Leavitt said on Tuesday during her first daily press briefing."It is crucial for our team to share President Trump's message widely and adapt the White House to the evolving media landscape of 2025," Leavitt said.At just 27 years old, Leavitt is the youngest White House press secretary in history.She invited independent journalists, podcasters, social media influencers, and content creators to apply for White House press credentials through the newly launched website, whitehouse.gov/newmedia.S he also revealed that a frontrow seat in the briefing room, traditionally reserved for the press secretary's staff, will now be designated the "New Media Seat."Applications will be reviewed by Leavitt's team, and credentials will be granted to those who meet the criteria and pass the US Secret Service's security requirements.During her first briefing, Leavitt fielded questions from new media representatives, including outlets that rank among the most-viewed news websites in

the country but have never had a seat in the briefing room. When asked about the initiative, Leavitt reiterated the administration's commitment to upholding the First Amendment." It's a fact that Americans, especially young people, are consuming news from a variety of platforms. As the youngest press secretary in history, thanks to President Trump, I take



great pride in opening this room to new media voices to ensure the president's message reaches as many Americans as possible," she said.

She added, "We will ensure that respected outlets like Axios and Breitbart have a permanent seat in this room every day. We also encourage anyone in the country whether you're a TikTok creator, blogger, podcaster, or any other type of content producerto apply for press credentials if you are producing legitimate news content, regardless of the platform."

The move marks a significant shift in the White House's approach to media engagement, reflecting the changing ways Americans access and consume news in the digital age.Leavitt also emphasised the administration's commitment to the First Amendment, announcing plans to reinstate press passes for 440 journalists whose credentials were revoked

under the previous administration.

"This White House strongly believes in the First Amendment, which is why we are working diligently to restore press passes to journalists who were wrongly denied access.Additionally, we are opening this briefing room to new media voices that produce news-related content but currently lack representation here," she explained.

#### Hyderabad to get two new IT parks

#### HYDERABAD. IT and Industries Minister D Sridhar Babu on Tuesday announced plans to create two new IT parks similar to the Hitech City in the suburban areas of Hvderabad.

- The announcement came following a meeting with representatives of US-based Dew Software, which proposed to invest Rs 100 crore. Over the next five years, this investment is expected to create 900 job opportunities for IT professionals.
- 'Hyderabad has emerged as a fast-growing IT hub, attracting significant investments from leading global companies. To maintain this growth, we have decided to develop two additional IT parks," Sridhar Babu stated.
- On the challenges faced by industries in acquiring land, the minister unveiled plans for a dedicated land allocation policy. "Currently, there is no specific policy for allocating land to industries, which has created hurdles for entrepreneurs. The new policy will allocate land based on the scale of investment and the number of jobs created," he explained. A detailed study is underway to identify the optimal locations and land required for the new IT parks. "We are evaluating suitable areas in the city's outskirts to ensure seamless connectivity and accessibility for employees and investors," he added. The proposed IT parks will feature world-class infrastructure and essential amenities tailored for professionals.

#### Tamil Nadu forest staff given training to shoot wild boars, 91 take part

COIMBATORE. A special camp organised by the forest department to sensitise staff to behaviour of wild boars and give them training to shoot them down began at the Tamil Nadu Forest Academy campus on Tuesday. Principal chief conservator of forests and head of the forest force Srinivas R Reddy inaugurated it. A total of 91 foresters and forest guards are taking part.Speaking on the occasion, Reddy said the camp is being organised after the government issued a GO to kill wild boars if they come three kilometres out of forests boundaries. The state government has allocated Rs five crore for the project, and advanced guns have been procured from the ordnance factory in West Bengal, he added. Traps will also be procured to



capture the animals alive, he added.

We have instructed staff to capture boars using traps if they are within three kilometres from the forest boundary and release them back into the forests. We will not kill pregnant and young boars. We will shoot and kill animals that enter areas which are not notified as forests," Reddy said. The participants were trained in handling rifles by members of special task force (STF) and police personnel at TNFA's shooting range in Madukkarai. "Each of us shot three rounds using a 7.62 x 39 mm rifle. In the next class, the type of rifle will be changed. Most of us have already undergone similar training at Vaigai dam in Theni district," said a participant.

'Officials told us to try not to kill the boars because they play a key role in forest ecosystem. Only boars that cause problems to farmers by ravaging crops will be identified and killed," said another participant.

#### Boyfriend in police custody after 20-year-old found seriously injured at her house in Chottanikara

- KOCHI. A youth has been taken into custody after a 20-year-old woman, a survivor of a 2021 rape case, was found severely injured and unconscious at her residence in Chottanikkara on Sunday. The police have detained a native of Thalayolaparambu, who is suspected to be the victim's boyfriend.
- According to the police, the victim was discovered by her uncle on Sunday evening, lying unconscious with severe injuries at her home. There was a knot on her neck, and she was partially stripped. It is suspected that she had been lying unconscious for hours, as ants were found on her wounds. She was rushed to Ernakulam General Hospital and later shifted to a private hospital in Kochi, where she remains on ventilator support.
- Based on a complaint from her mother, the police have registered a case of rape and attempted murder.
- The police investigation revealed that the victim's boyfriend had arrived at her residence on Saturday night. A friend had dropped him off at the house at around 9 am, and he reportedly left on Sunday morning."We are interrogating the person in custody. The facts he revealed have to be cross-checked. We are checking whether this person has any criminal history. He is one of the suspects now. We suspect that the victim was physically assaulted," said V. T. Shajan, DySP Puthencruz.
- The victim had survived a rape case in 2021 when she was a minor. Two individuals were arrested in connection with that case, and the trial is still pending in court.
- Her mother revealed that she had only recently become aware of her daughter's relationship with the suspect and had warned her to maintain distance. The victim's father, a retired military officer, passed away two years ago.

Authority of India (FSSAI) licence of a restaurant. **ROURKELA**. For seamless connectivity popular for selling biryani at Rs 20 in Thoothukudi, has been temporarily suspended by the food safety department on Tuesday, citing unhygienic preparation and selling of food in the name of chicken biryani without chicken pieces.

The action follows a complaint lodged with District Collector K Elambahavath seeking to verify the quality The upcoming steel corridor to connect of the biryani served at the restaurant for Rs 20. Subsequently, officials headed by district food safety designated officer Dr Mariappan inspected the shop and its production house at Davispuram near Thalamuthunagar. In a statement, Dr Mariappan said the chicken meat had no extraneous matter or foul smell. However, the kitchen environment was unhygienic, as cats and dogs were found wandering inside. A sample of the meat has been collected for laboratory analysis and action would follow based on the results, he added.

The officer further stated that the biryani parcels had only crushed chicken and not pieces, thereby misleading the public by terming it "chicken biryani". Hence, the chicken meat supplier will also be summoned for Member of Zonal Railway Users' inquiries, the statement read.

Holding that the cooking environment was not hygienic, and had no bills and receipts for the purchase of raw materials and sales, Dr Mariappan issued an order to temporarily suspend the food safety licence of the restaurant. It may be noted that the restaurant owner can get the suspension revoked after satisfying the food safety conditions prescribed under the Food Safety Standards Authority of India Act.

and faster movement of freight, the Indian Railways has reportedly chalked out a transformative plan to lay wide network of new rail lines connecting mining belts of Sundargarh and nearby regions with industrial hubs and ports.

the iron ore-rich Koida belt of Sundargarh and Barbil in Keonihar along with the adjacent West Singhbhum district of Jharkhand envisages to drastically cut freight travel time to Paradip, Dhamra, Gopalpur and Haldia ports and industrial hubs of Rourkela, Kalinganagar, Angul, Jharsuguda and others.In 2024, the proposal for Karampada-Gua line of 24.4 km was sanctioned to connect the triangular mining regions Sundargarh, Keonjhar and West Singhbhum as part of the proposed steel corridor.

Consultative Committee and senior BJP leader Ramesh Agarwal said the proposed steel corridor further envisages to lay multiple new rail lines to connect the mining belts with existing operational lines. Key new rail lines under the steel corridor would involve around 181 km of new lines for Sanindpur-Dholtapahar, Barsuan-Nuagaon, Barbil-Bhadrasahi-Banspani



and Basuan-Banspani new sections. He said other proposals include Kiriburu-

Barbil new line (17.73 km), Dumerta-Bimlagarh (3rd & 4th lines) and Lathikata-Kalunga (20 km) besides He further said a separate proposal is also track doubling of Bimlagarh-Kiriburu and Bimlagarh-Barsuan sections.

Agarwal said the Barkote-Deogarh-Kuchinda-Jharsuguda new line has also been mooted to connect the proposed steel corridor. Work for the Talcher-Bimlagarh new line (149.780 km) is already in progress. Final location survey of most of the proposed lines of

the steel corridor have been completed and allocation of necessary funds against these proposals is likely to be made in the upcoming budget.

# Karnataka Panchayat Raj department issues circular to ensure respect for gram panchayat representatives

BENGALURU. Panchayat Raj department authorities have sent a circular warning all taluk and district chief executive officers (CEOs) to treat Gram Panchayat members, presidents and vice-presidents with respect. "We have learnt that elected representatives from panchayats are treated as servants. This has to be stopped," the circular issued by Panchayat Raj Director N Nomesh Kumar stated.In Karnataka, there are close to 6,000 gram panchayats with over 91,000 elected representatives. After the Panchayat Raj department received a complaint from Karnataka State Gram Panchayat Members' Federation about the

disrespectful behaviour of CEOs of a few zilla panchayats and taluk panchayats, the state government decided to warn senior officials to behave with respect.

The circular, a copy of which is available with The New Indian Express, says that as per Article 234B of the Indian Constitution, panchayats are local bodies providing self-government for

rural areas. Panchayat presidents are on par with CEOs of panchayats. "Some CEOs of zilla panchayats and taluk panchayats ill-treat presidents and other members when they visit their office.



The Federation has complained that senior officials of zilla and taluk panchayats do not treat members as elected representatives, but as servants," it stated. The circular also stressed that CEOs of taluk panchayats have to

convene meetings once in two months with gram panchayat presidents and Panchayat Development Officers to discuss issues of their panchayat. "If there are any grievances, they have to be resolved," the circular said. Zilla panchayat CEOs have to convene similar meetings once in three months, and treat them with respect at all times, the circular added. A senior department official, on condition of anonymity, said it is basic culture to treat anyone who comes home or to office with respect. "It is unfortunate that some senior officials are treating panchayat members, including presidents and vicepresidents, as their servants.

# 26/11 probe gets a new lease of life

It is an irony that the US has decided to extradite Canadian national Tahawwur Hussain Rana to India for his supporting role in the Mumbai terror attacks that killed 166 people in November 2008, but has refused to part with one of the primary perpetrators - Daood Gilani aka David Coleman Headley. Rana, a doctor who had deserted from the Pakistan Army, and Headley were old friends and classmates at the Hassan Abdal military academy near Islamabad. Both were tried on 12 counts by a US court and sentenced to 15 and 35 years in jail, respectively, in 2013.etails of the Rana-Headley connection come to us from their indictment and trial in the US on terrorism charges. These were confirmed by the interrogation report of Headley by the National Investigation Agency in June 2010.In September 2023, the Mumbai police filed a 400-page supplementary chargesheet that came up with a surprise revelation: Rana had visited Mumbai a week ahead of the attacks. The US court documents did not have this information, which suggest that he may have had a more sinister role to play in the attacks.Rana came into the picture when Headley met him in Chicago in 2006 and told him about his Lashkar-e-Taiba (LeT) links and his decision to change his name to conceal his identity. He also told him about his association with Pakistan's Inter-Services Intelligence (ISI) and his assignment to conduct surveillance in Mumbai. He asked Rana whether he could set up a branch of his First World Immigration office there, and Rana agreed.

- After subsequent visits in 2007 and 2008, Headley kept Rana abreast of his activities there, including video surveillance of Taj Mahal hotel and surveying a possible landing site. He also briefed him on his conversations with Sajid Mir and Major Iqbal, two Pakistani ISI operatives. At least twice in his five visits to Mumbai, Headley received money from Rana at a bank close to the Oberoi hotel.Count 12 of the US indictment noted that since 2005, the two had "knowingly provided" material support - personnel, currency, tangible property, and false documentation and identification — to the LeT.
- Despite this, Rana was actually acquitted on the counts relating to the Mumbai attacks. His conviction was on count 11 connected to the subsequent plot, of which Headley was also a part, to target Danish newspaper Jyllands-Posten and on count 12 for providing material support to terrorists.Rana's defence counsel claimed that he was "easily the least culpable of all the members of the plot". But there are many gaps in the American proceedings and this is what the Indian authorities hope to fill after they obtain Rana's custody.
- Headley was not extradited to India because of his plea agreement with the US, which barred a death sentence and extradition to either India or Denmark. # Why UGC fondness for Governors is unhealthy

#### The role of state governments in the appointment of VCs has been eliminated, though education is a state subject and under the Concurrent List.

First formulated in 2010 and amended from time to time since then, the University Grants Commission (UGC) has again revised its rules on the "minimum" qualifications for appointment of teachers and other academic staff in universities and colleges and measures for maintenance of standards in higher education."The draft regulations 2025 have triggered a mixed response from academic circles as the intended modifications in certain contentious issues have far-reaching consequences on appointments, service conditions and promotions of teachers as well as the autonomy and control of the state on higher educational institutions (HEIs). With the aim of achieving the goals of National Education Policy (NEP) 2020, emphasis has been laid on the use of Indian languages, societal engagement and teaching, learning and research in the Indian knowledge system. The numerical score-based academic performance indicator (API) system for the recruitment and promotions of teachers has been replaced with a subjective evaluation system that involves contributions towards teaching, research and digital content creation. This system has inherent limitations, which have been already experienced prior to the API system era. Emphasis has been laid on non-measurable accomplishments, to be considered by selection committees. The new system lacks transparency, leaves room for irrational evaluation and manipulation, which is of serious concern.Apparently envisioned to promote academic flexibility, allowing teachers to teach subjects based on their highest specialisations without having degrees in the same subjects at the lower academic levels may create problems in case of collaborative multi-disciplinary studies and discourage the much-needed interdisciplinary research approaches. The draft document lacks a transparent mechanism for foolproof and acceptable implementation of its provisions to eliminate suspicion, partiality and undue preference to subjective evaluations. It is feared that de-capping of the limit on contractual appointments of teachers will encourage this practice, compromising the quality and creation of committed and innovative professionals. Such appointments need to be curtailed as they are only an emergent temporary solution. The minimum qualifications and procedure for the selection of vice-chancellor (VC) have been revised. Now, absolute powers are vested in chancellors (governors in case of state universities)

to select VCs through search-cum-selection It will open the VC's post to persons with political and committees. The VC's post has also been opened for non-academicians from the industry, public administration and public policy. This is a cause of disappointment and discouragement for distinguished and accomplished



academicians. These ill-conceived, unsustainable solutions have probably been envisioned due to the recent rows between some opposition-ruled state governments and their governors over the appointment of VCs. The role of state governments in the appointment of VCs has been eliminated though, constitutionally, education is a state subject and under the Concurrent List.Being contrary to the federal principles of governance, the Tamil Nadu and Kerala governments have rejected the draft document. The document is also unacceptable to the All-India Federation of University and College Teachers Organisation. Some other quarters may also oppose it. Views have been expressed against making the VC's post open to non-academicians. Questions like whether we appoint businessmen as civil surgeons have been raised in this context. AVC is essentially an academic leader and scholastic role model for the faculty, staff and students. The HEIs are neither factories nor business franchises. They are institutions where excellence in teaching and learning is ensured and young minds are groomed for free thinking in a research-undertaking environment. These values cannot be appreciated by non-academic paratroopers or persons not exposed to the rigorous academic ecosystem of HEIs and lacking in academic and research knowledge and orientation, no matter how expert they may be in their field of specialisation.

ideological affiliations, compromising the eminence, propriety and commitment to academic excellence that is expected from this position. The appointment of non-academicians as Professors of Practice in universities with similar expectations, too, is yet to show tangibly beneficial results.

It would be in the interest of the nation to avoid such experimentations with HEIs. A balance of the role of state governments and governors in the selection of VCs is needed. Further, it should be provided that none of the selection committee members is below the rank of a VC; that a non-academician is not appointed VC even as a stop-gap arrangement; and that the post does not stay without a regular VC for a long time.Instead of inviting applications, nominations may be invited from current and former VCs, directors of institutions of importance, acclaimed intellectuals, etc, elucidating the achievements, integrity and calibre of the aspirant.

Though questionable, the draft regulations are mandatory in nature and impose stringent penalties on their violations. The penalties include debarring the institution from getting UGC schemes and disqualifying it not only from offering any degree but also the institution as a whole.

hese regulations, ostensibly asserted as "measures for maintenance of standards in higher education", are, in fact, a blatant effort to erode the autonomy of universities, impose Central control, compromise the quality of education, curtail academic freedom, undermine academicians and overstep the UGC mandate. The UGC Act of 1956 does not clearly contain any provision related to VCs' selection. Having no regulation till 2010, introducing the UGC nominee on the search panel in 2010, withdrawing it in 2013, reintroducing it in 2018 and expanding it for greater control over HEIs in 2025 reflects that the UGC itself is not clear about its role in VCs' appointments. The regulations will lead to academic chaos and put the state universities in a disadvantageous position. The UGC must not go ahead with the disruptive revisions.

Especially so, when the formation of an umbrella organisation — the Higher Education Commission of India (HECI) - as envisaged in NEP-2020, subsuming the ÚGC, is in the pipeline. The HECI would have responsibilities, like maintaining academic standards and specifying the eligibility criteria and mode for selection of VCs.

## Fight for the eyesight of premature babies



### Using unmonitored, high-concentration supplemental oxygen in newborn care units undoubtedly saves lives, but often at the cost of blindness.

Oxygen is the elixir of life, and this was brought home during the Covid-19 pandemic when millions of lives perished because of the worldwide scarcity of the much sought-after oxygen cylinders. However, it is not widely known that oxygen is also a double-edged sword. When given to yet-not-fully-developed babies born too soon, high-concentration oxygen may devastate their eyesight.

An estimated 18,000 babies thus go blind for life every year in India alone. Using unmonitored, highconcentration supplemental oxygen in newborn care units undoubtedly saves lives, but often at the cost of blindness. The blindness results from the consequences of scarring and unfettered growth of abnormal blood-supplying vessels in the immature retina. It is now known as retinopathy of prematurity (ROP). Babies mature in the womb for 40 weeks before entering the world. The eye's lightsensitive layer, the retina, is fully matured only if the baby attains at least 2,000-gm weight. If born before 31 weeks, several vital organs, especially lungs and retina, are not fully developed. A vast swath of the retina remains without a blood supply, especially in babies weighing less than 1,250 gm.Around the turn of the 20th century, doctors realised that babies born too soon could be saved if given oxygen. In the early 1940s, Dr Theodore Terry from Boston (USA) first flagged the issue of a visible white reflex due to massive scar tissue seen in the eyes weeks after birth of premature babies, all of whom weighed less than three pounds at birth. For several years, exposure to light was wrongly blamed. It was a pathologist in London, Norman Ashton, who fortuitously discovered that the retina of the kitten till three weeks of birth was similar to that of a human

baby born too soon. He created an ROP-like picture by first exposing these kittens to high-concentration oxygen and returning them to room air. Arnall Patz at Johns Hopkins was to discover almost simultaneously that if oxygen delivery in premature babies was monitored, they did not develop ROP.According to Dr Sourabh Dutta, Professor at the



Neonatology Department, PGI, Chandigarh, India is experiencing an epidemic of ROP-induced blindness due to increased survival of premature babies, unregulated oxygen use, lack of pulse oximeters and oxygen blenders in the newborn care units mushrooming all over urban India. Highly skilled manpower is required to care for these babies and counsel the parents. Although at-risk babies continue to be born, albeit in small numbers, in high-income countries of Europe, North America and Southeast Asia, hardly a baby goes blind from ROP because of the advanced infrastructure in the neonatal intensive care unit (NICU). Almost four decades after what led to ROP was understood, experts reached a consensus on grading the stage and severity of ROP and

developed guidelines for treating the immature retina in these babies. While many early-stage cases resolve without treatment, some babies may require laser therapy or injections into the eye of drugs to block the abnormal retinal vessel development. If treated appropriately, success rates exceed most medical procedures. This protocol has also become the most cost-effective procedure by saving sight for the rest of life.Dr Joy Lawn from the London School of Hygiene and Tropical Medicine and colleagues estimated that nearly 15 million babies worldwide are born too soon (less than 37 weeks). With India topping the charts, almost eight million babies are born too soon in resource-limited middle- and lowincome countries. Those born too soon in lowincome countries with poor resources barely have any chance of survival.

Timely detection, staging and treatment within 48 hours of at-risk babies is the key to saving their sight. The American Academies of Paediatrics and Ophthalmology recommend screening babies born with a birth weight of less than 1,500 gm, gestational age of 30 weeks or less, or any newborn with a higher weight (up to 2,000 gm) who received oxygen even for a few days.Dr Praveen Kumar, head of the Neonatology Department in PGI, however, recommends that Indian babies born before 34 weeks or weighing less than 2,000 gm or even higher if oxygen support is required must be screened for ROP. Starting at 28 days of age or discharge from NICU, whichever is earlier, the eye surgeon needs to monitor the newborn until the retina is fully matured. Training thousands of eye surgeons and equipping them with the necessary skills nationwide to screen and treat these tiny babies is a herculean task. Dr Subhadra Jalali in Hyderabad and Anand Vinekar in Bangalore, both PGI alumni, have devoted their careers to saving the right of sight of these hapless babies.More than 50 years ago, Prof ON Bhakoo set up a modern neonatal intensive care unit (NICU) in the PGI, Chandigarh, and started training super specialists (DM) in neonatology. They were successful in saving the lives of very low birth weight babies. I remember Dr Anil Narang, who trained at Oxford and followed Professor Bhakoo, asking me the big question — who among us would undertake the onerous task of examining and treating those at risk of ROP in these tiny incubator-bound babies?

Dr Mangat Dogra, fresh from his training in the US, volunteered. As they say, the rest is history. Applying a cold probe at -80° Celsius (cryotherapy) to the retina that lacked blood supply was the standard of care back then if these babies had to have any eyesight in their lifetime. The babies had to be put under general anaesthesia. I remember the long hours he spent in NICU, examining babies, selecting those requiring treatment, and chasing anaesthetists, who, in those days, had little experience in giving anaesthesia to 1,000-1,200-gm babies. He would regularly share the day's story with me. I remember the pride on his face, a million-watt smile, announcing that the baby would see as the ROP had regressed.Over the decades, cryotherapy was supplanted with lasers and injections that do not require anaesthesia. In the last 35 years, Dr Dogra has treated the retinas of hundreds of premature babies and trained many ophthalmologists across India, including Anand. Happily, many of the same teenyweeny babies he saved the sight are having babies with normal sight.

# **North Delhi for** erita overs Ambedkar University Campus

This is not your usual university campus with a main building surrounded by graffiti-ridden walls and some academic blocks. The single-storeyed sprawling building that serves the Ambedkar University today is steeped in history and has been witness to all its turmoil. It's ageold trees have an impressive canopy of their own and can boast of many a historical figures taking sanctuary under their branches. Built in the 1900s, the building was initially the IG Block in British rules India. As the British were looking to develop more structures of governance, before the Parliament was built, Civil Lines, beginning from Kashmere Gate right up till Majnu Ka Tila, was going to be the scene of action.

As a result, since the time of the British and after that, this campus has housed many educational institutions including the Kashmere Gate Polytechnic, the Woodcraft Institute and the Delhi College of Engineering, the latter has now moved to Bawana.

On the outskirts of the erstwhile walled city of Delhi was an area frequented by invaders, scheming wazirs and power hungry emperors.

What is left today are structural landmarks, memories and many legends about what could have transpired two action-packed centuries ago. Beginning with the monuments that were built by the British for the purpose of governance including Town Hall and Vice-Regal lodge to

those structures that were meant for surveillance-Flagstaff Tower, Barracks and finally the memorials-Tis Hazari, Mutiny Memorial, the area is peppered with many must visit landmarks.

the bungalow has some lighting for people to be able to walk along a portion of this. Since most of the elaborate tunnel networks under Red Fort are either broken down or inaccessible, this tykhana is an interesting opportunity to explore if you'd fancy a peek into history and the scandalous

ancient scriptures within the reach of Persian scholars. A lot of his own texts reflect a confluence of both Sufi and Vedantic schools of thought.

The library building is a short drive into the Ambedkar University campus, accessible on weekends as well. In the British period, the building served as the residence of the Mughal Viceroy of Punjab, Ali Mardan Singh. Thereafter, the Government College, the District School and the Municipal Board School operated from these premises.

The building has a huge lawn on the back side of the premises that probably served as a play area for the children at that time. Today, the Department of Archaeology of Ambedkar University operates from here.

#### Old Post Office

The oldest post office of Delhi dating back to 1885; this is where the story of India Post began. Despite the age, the building is in good shape due to adequate maintenance and the fact that this is still an operational post office.

Its double-storeyed structure is located a quick walk down from the Ambedkar University entrance, on the way from Kashmere Gate to Red Fort. The Old Delhi Railway Station is a stone throw's away, a convenient location for all the post coming in at the time when snail mail was the only way of communication. The building has five bays with semi-circular arched doorways, typical of architecture of this

As per the official version of the Hindu Rao Hospital, the main building of the hospital goes back to 1911. It was built by Sir Edward Cole Brook as a 16 bedded nursing home. However, other accounts of this structure, particularly those of noted author William Dalrymple have referred to the Hindu Rao House as a structure built by William Fraser in the early 19th century who also resided here. After his death in 1835, the house was acquired by Hindu Rao, a Maratha nobleman and brother in law of Maharaja Daulat Rao Scindia of Gwalior and the name has since stuck.

The house premises was turned into the British head quarters during the time of the 1957 Revolt, probably because of the vantage point that it offers, thanks to its elevation and thick green cover. Incidentally, this was also the spot where Timur the Lame camped and looted Delhi in 1398

#### Qudsia Bagh and Masonic Lodge

The Qudsia Bagh complex that separates ISBT from Civil Lines has been in and out of news for various reasons. The story goes back to the 18th century when the palace of Qudsia Begum-mother of mughal emperor Ahmad Shah Bahadur and wife of Mughal king Mohammed Shah Rangila, stood at this very point. After the revolt of 1857, much of the palace was destroyed and what remains today is a mosque, an archway and a hunting lodge and some remains of the corner facade

#### William Fraser's Bungalow Referred to as a 'white mughal' by noted

author William Dalrymple, William Fraser was a civil servant in the times of British ruled India and the reign of the last Mughal ruler, Bahadur Shah Zafar. His bungalow, today the site of the Railway office, was built next to the Yamuna in 1803 when he was the deputy resident of Delhi. Fraser was murdered outside this bungalow and has been buried in the grounds of the neighbouring St. James' Church. The rather wellmaintained structure of William Fraser's bungalow is also the recipient of DDA's Adaptive Urban Heritage award in 1998. The building comprises of two separate structures that have been joined together. Architecture is in the Indo-Saracenic style, also known as Indo-Gothic or Hindu-Gothic. The building was greatly damaged during the revolt of 1857 and has since then been restored hence the alteration in architectural styles. What is most interesting is that the building stands on a tykhana, or a dungeon, that has three tunnels, one leading up to Red Fort, the other to the Yamuna river and the third to a corner of the bungalow's huge campus. This network of tunnels was meant to facilitate clandestine passage of sepoys as well as prisoners, not to mention their execution. Often, prisoners were sent from

the Red Fort, decapitated in one part of the dungeon and their bodies thrown into the nearby Yamuna river without anyone getting to know.

The Yamuna river's waters came right up to the dungeons at the time that the waters had not receded. This is probably why these dungeons reek of a dank odour even today. A part of the tunnel accessible from behind could have taken place here.

#### Dara Shikoh's Library

The more well known and revered son of emperor Shahjahan, Dara Shikoh was known to have keen intellectual pursuits. The library established by him in the year 1637, stands in the grounds of the Ambedkar University to this day, a testimony for this interest, although few of the prince's original works are accessible. Dara Shikoh was involved in the translation of the Upanishads and had already completed the translation of 50 Upanishads from Sanskrit to Persian in a bid to bring these time. There are semi-circular tapering pilasters between each bay.

Once you are in the area, you can also check out some other British era buildings in the vicinity; the St. James' Church, Ambedkar University building that was earlier used as the IG Block during the British governance and houses Dara Shikhoh's library and William Fraser's Bungalow that is today the Railway office.

#### Bara Hindu Rao Hospital

Overlooking a quaint roundabout on the North Delhi Ridge, with the Ashokan Pillar on one side and the Delhi University North Campus to the other, stands the Hindu Rao Hospital. The sprawling campus of the biggest hospital of the North Delhi Municipal Corporation has quite a few shards of history tucked away in various

of the erstwhile palace.

The mosque is an ASI protected monument. Built with lakhori bricks, the ASI is still working to restore this to its days of glory. Some of the initial work has been patchy and looks as if sepia paint has been slapped on the structure in a hurry. The mosque is already giving in to encroachment despite notices prohibiting the same.

In the same complex is the Masonic Club and the mason's lodge. While the club is now closed since it would attract mostly those who would come across to enjoy highly subsidised liquor, the mason's lodge has recently been painted and restored, freed of all the broken furniture that had been piled up here for decades.

The historical structures notwithstanding, the real story lies in the resurrection of the park complex itself. Built in the char-bagh style, the Qudsia lawns sprawling over 50 acres were dishevelled and gradually deteriorating into a den for miscreants. Ever since the upkeep of these lawns was taken over by the Qudsia Bagh Welfare society, a body comprising mainly of local residents, the area has been converted into a walker's and horticulturist's paradise. A neat 1-km walk-way has been carved out of the lawns' periphery so that even the remote corners are now accessible to all. Almost 550 trees, 42,500 shrubs and 450 bamboo plants were planted recently.

This has only added to the already existing green treasures of this area; a few 200 year old Pipal trees that were probably planted in the Mughal era, two of the largest specimens of Cycus Palms in the city going back almost 80 years and many other old trees that are now neatly labeled for those who care to observe as they go about their morning walk. The complex is flanked by the ring road on one side and Palna-an orphanage-on the other side.

Way back in the 18th century, when the palace of Qudsia Begum stood on this grounds, the river Yamuna was flowing right next to the mosque. The river has now receded many metres and is barely visible from here today. However, you must pay a visit to the area and witness the wonders that can materialize when ownership comes from the ground up, from residents and not just an alienated municipal body.

# Delhi, Haryana war over water gets political colours ahead of elections

NEW DELHI. The battle for water between Delhi and Haryana has resurfaced amid the fervent campaign for the February 5 Assembly elections in Delhi. AAP chief Arvind Kejriwal has accused the

BJP-led Haryana government of contaminating the river, labelling it as an attack on Delhi's drinking water.

Incumbent Chief Minister Atishi went further, accusing Haryana of "water terrorism."In a letter to the EC, she cited a Delhi Jal Board report, which flagged dangerous ammonia levels in Yamuna water from Haryana, rising to seven parts per million - 700% above treatable limits - due to untreated sewage and industrial waste.Haryana Chief Minister Nayab Singh Saini dismissed these Legal battles began in 1995 when the Supreme allegations, demanding an apology from Kejriwal and threatening a defamation suit. Saini countered that Haryana reveres the Yamuna as a sacred river, asserting that the accusations tarnished its honour.

This clash is the latest episode in a decades-long feud between the two states over the Yamuna, which has been fought in courts and political arenas since 1995, shortly after Delhi got its

However, tensions escalated quickly, with contempt petitions filed against Haryana for alleged violations of the top court

order. In 1996, the court ruled that Delhi's water supply must remain uninterrupted, irrespective of the MoU.

Despite the directives, disputes persisted. In 2018, the DJB alleged Haryana was supplying only a third of Delhi's rightful share, prompting the apex court to urge dialogue between the states. Later that year, Haryana offered to release additional water if Delhi withdrew pending legal cases, but the issue remained unresolved.

Conflict erupted again in 2021, with DJB accusing Haryana of ignoring the 1996 Supreme Court ruling by allowing water levels in Delhi's reservoirs to drop. Haryana,

in turn, blamed Delhi's internal mismanagement. That same year, AAP leaders accused Haryana and neighbouring states of polluting the river, depriving Delhi of clean water.In 2023, the rivalry took a different turn when a severe flood hit Delhi. AAP accused Harvana of deliberately releasing water from the Hathnikund Barrage to inundate the capital. This barrage, central to the 1994 MoU, regulates Yamuna water allocation among states

### How many cases filed over triple talaq? Supreme Court seeks data from Centre

New Delhi. The Supreme Court, on Wednesday, directed the Central government to provide data about the criminal cases registered under the Muslim Women (Protection of Rights on Marriage) Act, 2019 for the pronouncement of triple talaq. The court was hearing a batch of petitions filed by Muslim organisations challenging the constitutionality of the 2019 Act.A Bench of Chief Justice of India Sanjiv Khanna and Justice PV Sanjay Kumar, while hearing 12 petitions challenging the constitutionality of the 1991 Muslim Women (Protection of Rights in Marriage) Act, also asked about the pending triple talaq cases and any challenges pending before the High Courts against the enactment.

'Parties to file written submissions on both sides. Check up and give us data on the number of FIRs registered," the Supreme Court ordered. The petitioners argued that the law has introduced penal legislation specific to a class of persons based on religious identity. It is causative of grave public mischief, which, if unchecked, may lead to polarisation and disharmony in society.

They further contended that since the Supreme Court had already declared the practice of instant triple talaq as unconstitutional in the Shavara Bano case, the law serves no purpose. It has been argued that the intent behind the Act is not the abolition of triple talaq but punishment of Muslim husbands. The Court also remarked that the petitioners were only challenging the criminalisation of the practice and not defending the practice itself.

"I am sure none of the lawyers here are saying that the practice is correct, but what they are saying is that whether it can be criminalised when the practice is banned and no divorce can take place by uttering talaq three times at once," CJI Khanna remarked.

The Sri Lankan diplomat was told that use of force is not "acceptable" under any circumstances whatsoever.

'Our High Commission in Colombo has also raised the matter with the Ministry of Foreign Affairs of the Sri Lankan government," External Affairs Ministry said in a statement."An incident of firing by the Sri Lankan Navy during the apprehension of 13 Indian fishermen in the proximity of Delft Island was reported in the early hours of this morning," the MEA said.

Out of the 13 fishermen who were on board the fishing vessel, two have suffered serious injuries and are currently receiving treatment at the Jaffna Teaching Hospital."Three other fishermen received minor injuries and have been treated for the same. Indian Consulate Officials in Jaffna have visited the injured fishermen at the hospital to seek their welfare and are extending all possible assistance to the fishermen and their families," the statement said. ### the two governments should be strictly followed Balance privacy with need for DNA test in paternity dispute cases: Supreme Court

NEW DELHI. Courts must be mindful of the collateral infringement of privacy of the child and the parents while permitting an enquiry into somebody's paternity by a DNA test, the Supreme Court said on Tuesday.A bench of Justices Surya Kant and Ujjal Bhuyan, said that forcefully undergoing a DNA test would subject an individual's private life to scrutiny from the outside world. The ruling brought the curtain down on a twodecade-old dispute over paternity by a person from Kerala."That scrutiny, particularly when concerning matters of infidelity, can be harsh and can eviscerate a person's reputation and standing in society. It can irreversibly affect a person's social and professional life, along with his mental health," the bench said.

- Laying down the procedure of when a court can order a DNA test to ascertain an individual's paternity, the top court said that courts should assess the eminent need for a DNA test and there should be a balancing of interests.
- 'On one hand, courts must protect the parties' rights to privacy and dignity by evaluating whether the social stigma from one of them being declared 'illegitimate' would cause them disproportionate harm. On the other hand, courts must assess the child's legitimate interest in knowing his biological father and whether there is an eminent need for a DNA test," the bench said.
- The bench pointed out that the effects of social stigma about an illegitimate child making their way into the lives of parents and there could be scrutiny owing to alleged infidelity.
- Casting aspersions on a married woman's fidelity would ruin her status, dignity and reputation, and she would be castigated in society, it added."First and foremost, the courts must, therefore, consider the existing evidence to assess the presumption of legitimacy. If that evidence is insufficient to come to a finding, only then should the court consider ordering a DNA test," the court said. Once the insufficiency of evidence is established, the court must consider whether ordering a DNA test is in the best interests of the parties involved and must ensure that it does not cause undue harm to the parties. There are thus two blockades to ordering a DNA test: (i) insufficiency of evidence; and (ii) a positive finding regarding the balance of interests," it added.

After hearing Safiya's plea, the apex court sought a response from the central government within four weeks.A threejudge bench led by Chief Justice Sanjiv Khanna and comprising Justices Sanjay Kumar and KV Viswanathan said, "We The petitioner said she has a daughter, will hear this plea after we receive the reply." 



One of the oldest living cities in the world, Varanasi is situated on the western banks of the Ganga and extends beyond the riverbank into a labyrinth of alleys. Filled to the brim with temples and teeming with pilgrims, the city is a magnet for travel enthusiasts. From witnessing vibrant evening prayers at Varanasi's oldest ghat to touring one of the most significant Hindu temples in India—here is a guide to making the most of your two-day trip to this spiritual city.



#### Breakfast at Kachauri Gali


Dotted with weathered, blackened cauldrons bubbling with hot oil, Varanasi's Kachauri Gali is one of the city's main landmarks near the ghats. The Vishwanath Gali transforms into the Kachauri Gali as soon as you pass the famous Vishwanath temple. This is where the famous kachauris are fried and served fresh with chana and imli chutney. Arrive as early as 7 AM to beat the rush and dig into the hot fried kachauris. Make sure you

their homage to Lord Shiva in the form of a huge lingam situated under a peepal tree. To most visitors to Varanasi, it's known for being a place where long-term foreign students, researchers and tourists live. It was at Assi Ghat where the famous Indian poet, Tulsi Das had written the much-celebrated Ramcharitmanas and the ghat can accommodate about 22,000 people at once during festivals like Shivratri. In the evenings, around 7 pm, a full-fledged aarti takes place here and many visitors prefer watching it from the boats that can be hailed from the ghat.

#### Dashashwamedh Ghat

One of the oldest and most important ghats, the Dashashwamedh Ghat is also Varanasi's liveliest. Two Hindu mythologies surround the ghat, one being that Lord Brahma created it to welcome Lord Shiva and another where he sacrificed ten horses during the yajna performed here. Around dusk the Dashashwamedh Ghat comes to life with the evening Ganga Aarti. Performed by young pundits dressed in saffron, the aarti is an elaborate ceremony complete with puja, dance and fire. The riverbank lights up with flaming lamps and the smell of sandalwood envelops the ghat. Close to the ghat, overlooking the Ganga, lies the Jantar Mantar-an observatory built by Maharaja Jai Singh of Jaipur.

#### Breakfast at Phulwari

A gang of playful monkeys keeps you company till the food arrives at Phulwari. Situated in the backdrop of an ancient kaali temple with massive graffiti on the main wall, Phulwari is as much a visual delight as a culinary one. The pizzas and yoghurt muesli are especially delicious.

#### Head to the Sri Kashi Vishwanath Temple

Not far away from the Ganga is one of the oldest temples in Hinduism, Sri Kashi Vishwanath Temple. Deriving its name from the city Kashi, the temple was built in 1780 by the Late Maharani Ahilya Bai Holkar of Indore and is one of the twelve Jyotirlingas, the holiest of Shiva

temples. The main deity housed within its premises is known by the name Vishwanatha or Vishweshwara, both translating to mean 'ruler of the universe.' The temple is also the starting point of the sacred Panchkoshi

Yatra-a 88.5 km long barefoot walk encircling Kashi.

#### Explore the Ramnagar fort and museum

A repository of the history of the kings of Varanasi, the Ramnagar fort and museum is located opposite


Mughal style of architecture and the most important construction inside the fort is the famous 'Durbar hall' which is a hall dedicated to the public audience.

#### Lunch at Shree Café

If you're staying close to Dashashvamedh ghat, this is going to be your constant choice for meals. The cosy cafe dishes out the most delicious Indian, Middle Eastern, Chinese and continental vegetarian fare. The owner, Santosh Ji's interest in photography has resulted in the cafe's bright walls being adorned with brilliant Varanasi themed pictures. You can never go wrong with ordering the lemon nana and the special thaali.

#### Sarnath

The Buddhist pilgrimage, Sarnath lies 10 km from Varanasi, and is yet another attraction that appeals to people from all around the world. This is the place where Gautum Buddha first gave his sermons on Dharma. The main deer park complex and



a number of other Buddhist temples can be seen here. The Mulgandha Kuti Vihar temple, the Archaeological Museum, the Dhamek Stupa, the Chaukhandi Stupa and ruins of monasteries are the key highlights here. Other modern structures like the Japanese & Korean temples have been added to the Sarnath topography in the last few decades. Go early so you can beat the rush of tourists through the day and enjoy the tranquil ambience of these Buddhist relics.

Kick-start your day with the Taj Mahal The Taj Mahal is considered by many, to possess architectural beauty unsurpassed by any other structure in the world. Constructed over a period of 22 years, employing twenty thousand workers, it was completed in 1648 C.E. and cost a whopping 32 million Rupees. Built entirely of white marble, it almost seems to glow in the moonlight, with the shimmering Jamuna river situated just across. 



This is the best place for shopaholics, and probably one of Agra's most popular shopping areas. In close proximity to the Taj Mahal and Agra fort, Sadar Bazaar is a bustling marketplace that houses hundreds of tiny shops selling everything from ethnic clothes and accessories to leather goods and shoes.

#### **Dinner** at Dasaprakash

Something of an institution in the city, Dasaprakash dishes out the most authentic and delicious south Indian cuisine. Despite being jam-packed with both locals and tourists at all times of the day, the service is quick and the food's served hot and fresh. You could go with the dosa-idli combination, or alternatively try the thali, which is loaded with south Indian staples.



### **Dutch airline KLM** scraps 250 jobs in costcutting drive

The Hague. Dutch airline KLM said Wednesday it was shelving 250 jobs as part of cost-cutting efforts it hopes will lead to a boost in operating profit of around 450 million euros (\$469 million).

The firm said it would try to avoid forced lay-offs to achieve the cuts, but admitted it could not rule that out. The 250 jobs would come from "nonoperational" roles, said KLM chief executive Marjan Rintel in a statement.



"It is crucial for our future to structurally lower costs, which involves making painful choices," said Rintel. Other cost-cutting measures already announced by KLM include postponing the construction of a new HQ, as well as other maintenance buildings. The firm is also seeking to shelve non-core activities and bolster productivity by at least five percent, via automation, mechanisation and reducing absenteeism.KLM, allied with Air France, together posted a sharp drop in net profit for the third quarter of last year.

The Franco-Dutch group reported a profit after tax of 824 million euros, down 13 percent from the same three-month period last year.

### Sebi rejects Danny Gaekwad's offer to buy 26% in Religare

NEW DELHI. Sebi has rejected the competing open offer for Religare Enterprises by Florida, USbased investor Digivijay 'Danny' Gaekwad.

Market regulator Securities and Exchange Board of India (Sebi) responding to the Gaekwad's letter has said: "The letters submitted by Digvijay Laxmansinh Gaekwad are being returned since the same is not an exemption application in terms of Regulation 11 of SEBI (SAST) Regulations, 2011." The content of the letter was part of an exchange filing by the New Delhi-headquartered company.Gaekwad on January 24 had made a counter offer in cash for the company at Rs 275 a share as against Rs 235 apiece made by the Burman Family of the FMCG major Dabur group.

The offer was made in a letter addressed to the Chairperson of the market regulator, according to a filing made by Religare to the BSE.Gaekwad, in the letter, had said its offer of Rs 275 per equity share represents a 17% premium to the open offer price offered by the Burmans and a 24% premium to the 60-day volume weighted average price of Religare's shares calculated with a reference date of September 22, 2023, of Rs 221. We believe that the Burmans' Open Offer price of Rs 235 per equity share grossly undervalues the real worth of Religare and is to the detriment of public shareholders.At the time the offer was made on September 25, 2023, the offer price was already at a discount of 15% to Religare's prevailing market price of nearly Rs 271 per share. Even considering the closing price of Religare shares on January 22, 2025, the Burmans' Open Offer price is at a steep discount of 7%," the letter stated.

# Budget 2025 income tax: Why standard deduction should be hiked under new tax regime

NEW DELHI. Budget 2025 income tax expectations: With Finance Minister Nirmala Sitharaman set to deliver the Budget 2025: Why standard deduction Union Budget 2025 speech on February 1. 2025, salaried and middle class taxpayers are looking to the Modi 3.0 government for income tax relief, especially under the new income tax regime. The new income tax regime, introduced in

FY 2020-21, has steadily seen changes with more favourable income tax slabs and rates, introduction of standard deduction and benefits for NPS. In Budget 2024, FM Sitharaman announced a hike of Rs 25,000 in standard deduction from Rs 50,000 to Rs 75,000 under the new income tax regime. The standard deduction under the old income tax regime, however, continues to be the same at Rs 50,000.Standard deduction is a flat deduction available on the salary income that helps reduce the taxable income of a taxpayer. With the new income tax regime being the default tax regime, and the government pushing for its adoption, taxpayers are looking to FM Sitharaman to increase the standard deduction limit further.

should be hikedPersonal tax experts are of the view that since no major exemptions and deductions are available under the new income tax regime, there is a strong case to hike the standard deduction to encourage further adoption. One expert even recommends considering standard deduction as a fixed percentage of income.Sundeep Agarwal, Partner, Vialto Partners says, "With rising living costs, the standard deduction under the new tax regime should be increased from Rs 75,000 to Rs 1,00,000. This hike would make the new income tax regime more attractive, considering no other deductions/exemptions are allowed."

According to Agarwal, raising the standard deduction would provide relief across income groups while keeping the tax system simple. "It would enhance disposable income, stimulate spending, and support economic growth while addressing inflationary pressures," he tells TOI.Kuldip Kumar, Partner,



Mainstay Tax Advisors LLP also believes that raising the standard deduction from Rs 75,000 to Rs 100,000 could provide relief to the salaried class."There is merit in this demand, as professionals/businesspeople can claim actual expenses incurred against the income they earn from their profession/business. Even those eligible for presumptive taxation benefit from a large amount of assumed expenditure, as a much lower amount is presumed to be their income for taxation purposes," he tells TOI."In comparison, salaried class taxpayers under the new tax regime have no deductions available, except for the standard deduction or the employer's

contribution to the NPS. This does not result in equitable treatment for salaried taxpayers compared to others," he adds. Sudhakar Sethuraman, Partner, Deloitte India says that the government can also consider providing standard deduction as a fixed percentage to the income like that of standard deduction of 30% on rental income. "Allocating fixed percentage brings equity across various income levels," he tells TOI.Surabhi Marwah, Tax Partner, EY India says that since there are no major deductions or exemptions available under the new tax regime, there is a strong case for increasing the standard deduction further to make the new tax regime attractive. "An increase could potentially lower taxable income, providing significant relief, particularly for individuals in lower to middle-income brackets," she says.Tax experts are also of the view that any

# Wall Street tech stocks recover a day after DeepSeek selloff hit Nvidia

Nvidia, which lost 17% in Monday's session, the biggest one-day loss in market history, rose 8.9% on Tuesday as investors looked for buying opportunities.

New Delhi Technology stocks on Wall Street saw some recovery on Tuesday, after the losses suffered the previous day when Nvidia saw its market value fall by \$593 billion.The massive selloff in Nvidia's stock was triggered by the rise of Chinese AI startup DeepSeek, which introduced a low-cost AI assistant that investors feared could disrupt the dominance of US companies in the artificial intelligence sector.Nvidia, which lost 17% in Monday's session, the biggest one-day loss in market history, rose 8.9% on Tuesday as investors looked for buying opportunities. Other tech stocks, including semiconductor, power,

and infrastructure companies linked to AI, also regained ground after collectively losing over \$1 trillion in market value a day earlier.

#### US TECH STOCKS GAIN GROUND

Much of Tuesday's gains in the tech sector were driven by major companies like Apple and Microsoft. Apple rose 3.7%, making it the second-biggest boost for the Nasdaq after Nvidia.Microsoft gained 2.9%, recovering from losses earlier in the week. Meta Platforms, the parent company of Facebook, added 2.2%, marking its seventh straight day of gains despite the AI-driven market turmoil. The overall technology sector rose 3.6% on Tuesday after falling 5.6% the day before. The Philadelphia semiconductor index, which tracks major chip companies, gained 1.1% after suffering a 9.2% drop on Monday, the steepest one-day percentage fall since March 2020.

Investors began to question whether DeepSeek's AI model could truly live up to its claims of lower costs and efficiency. 'Yesterday was an initial reaction. Today investors are asking if anybody did any sort of homework and made sure DeepSeek is exactly what they say it is. Can we have more proof that they really built it for so much less?" said JJ Kinahan, president of brokerage firm Tastytrade, in an interview with Reuters.Nvidia closed Tuesday at \$128.99 per share, still lower



than its Friday close of \$142.62. Other major tech stocks also showed signs of recovery.Oracle, which had dropped 13.8% on Monday, ended the session up 3.6%. Marvell Technology, which had fallen 19%, rose 3.5%, while chipmaker Broadcom recovered 2.6% after Monday's 17.4% drop.EXPERTS BULLISH ON AI STOCKSDespite Monday's selloff, some investors see the rise of DeepSeek as a positive sign for the

AI industry.Steven Cohen, founder of Point72 Asset Management, said at a conference in Miami on Tuesday that DeepSeek's breakthrough is "actually bullish because it advances the move to

artificial intelligence," as reported by Reuters.Traders also showed renewed interest in Nvidia. While the stock suffered a historic drop, options traders quickly returned, betting on a recovery.Cody Acree, a semiconductor industry analyst at Benchmark Company, told Reuters that the emergence of cheaper AI models would not reduce the need for high-performance chips. While companies like DeepSeek may develop cost-effective AI software,

they still require powerful hardware to train and operate their models.OpenAI CEO Sam Altman called DeepSeek's model "impressive" but added that competition is a good thing."We will obviously deliver much better models, and also it's legit invigorating to have a new competitor!" Altman said in a social media post.US President Donald Trump commented on DeepSeek, calling it "a wake-up call for our industries."

We'll make a final decision on what the XI looks like over the next little period ... but I feel like I'm ready to go, so we'll wait and see what happens," Healy said in the pre-match press conference."The final XI hasn't quite been decided upon just yet, but I'm standing here in front of you without a moon boot, saying I'm ready to go," Healy said.

#### 'Have done everything possible'

- Healy has had her fair share of troubles with a foot injury after she missed a few games in the Women's T20 World Cup where Australia crashed out in the semi-final. She also missed the WBBL due to a left knee injury. Before the upcoming Test, Healy took laps of the ground and also participated in fielding drills."The medical staff have been really supportive of (giving me) the opportunity to even push to play in this Test match. We've done everything we possibly can to get myself in a position to put my hand up and say, 'I'm ready to go'," Healy added.

# Neymar returns to Brazilian club Santos after termination of contract in Saudi Arabia

RIO DE JANEIRO. Neymar has agreed to return to Santos nearly 12 years after he left the Brazilian team, club president Marcelo Teixeira said Tuesday. The Brazil striker confirmed earlier that his contract with Saudi Arabian club Al-Hilal had been terminated by mutual consent. He had an injury-marred spell at Al-Hilal, where he played only seven matches and scored once.Neymar won six titles with his boyhood club Santos, including a Copa Libertadores trophy in 2011. Santos is a beachfront city outside São Paulo."It is the time (to come back), Neymar. It is time for you to come back to your people. To our home, to the club in our

hearts," Teixeira said in his social media channels. "Welcome, our boy Ney! A boy of Vila (Belmiro, Santos' stadium). Come back to be happy again with the white and black shirt. The Santos nation awaits you with open arms."Neymar, once hailed as one of the world's best players, spent much of his time in Saudi Arabia on the sidelines due to an ACL injury he picked playing for Brazil in October 2023.São Paulo media reported that the former Barcelona and Paris Saint-Germain star is expected to return to Brazil this week and reintroduce himself to Santos fans within days.Neymar became the most expensive player in soccer history when he transferred from Barcelona to PSG for 222 million euros (then \$262 million) in 2017.

'(My father) must be taking bicycle kicks in heaven after finding out that our boy is coming back home," Nascimento said on Instagram. Pelé died in December 2022.

A video published by Al-Hilal on Tuesday evening shows Neymar giving a farewell speech."Today I am very happy to be able to go, return home. "To Saudi, thank you for giving me and my family a new home and new experiences. I now know the real Saudi and have friends for life."Despite Neymar's injury, Al-Hilal still managed to win last season's Saudi league. The Brazilian's contract was due to expire after this year's FIFA Club World Cup, which will be played between June 15 and July 13 in the United States. The striker joined the Saudi club from PSG in August 2023 for 90 million euros (\$94 million).
