Sanjay Kumar New Delhi, Jan 30: Finance minister Nirmala Sitharaman will table the highly anticipated Economic Survey 2024-25 on Friday, providing an official assessment of

the performance of the economy in the ongoing financial year, a day before the presentation of the Union Budget for the fiscal year 2025-26. The Economic Survey, which has been prepared under chief economic advisor V Anantha Nageswaran, would give an insight into the Indian economy and the government's fiscal agenda for the coming financial year. The Economic Survey 2025 will be tabled on Friday (January 31), marking the onset of the Budget Session of Parliament. The Budget Session will commence at 11 am on Friday and the Economic Survey will be tabled shortly after President Droupadi Murmu's address to the joint session. Finance minister Nirmala Sitharaman will table the

Economic Survey in the Lok Sabha and the Rajya Sabha separately after the President's address. The presentation of the Economic Survey will be live-streamed across major social media platforms and key government channels. The key government handles such as Sansad TV and PIB India will broadcast the event. As India gears up for the Union Budget FY26, the Economic Survey will set the stage, offering crucial data and

analysis that will inform the government's fiscal policies in the coming year. Other significant purchases include equipment for power plants such as nuclear reactors and boilers, electrical machinery and equipment, aircraft and parts and medical equipment. India has also been importing military equipment from the US as it diversifies away from Russia. India's exports to the US include petroleum proddrug formulations, ucts, pearls, precious/semi-precious stones, telecom instruments, electrical machinery, apparel and cotton fabrics and electronic components. India's exports to the US rose rapidly after the Covid disruptions of 2020. Trump wants India to lower tariffs on American goods and also

He further criticised the presence of political dignitaries in Mahakumbh. "At such times, VIPs should stay away. The entire area was shut down for a day each for the Defence Minister, Home Minister, and other Central Ministers. This led to a chaotic situation," he said. He further alleged that there was "no system in place, no ambulances, no medical facilities," adding that "several Mahamandaleshwars suggested handing over the arrangements to the army. Raut also alleged that Mahakumbh was "politicized for propaganda," which ultimately resulted in increased fatalities." He stated that the Yogi government is responsible for the chaotic situation at the Mahakumbh. "The count of injured hasn't been done yet; many people are missing, including many women. Who is responsible for this? The central government is responsible. The Yogi government of Uttar Pradesh is responsible," he said. Raut also raised concerns over the allocation of funds for the event, claiming, "The budget for the Kumbh Mela was Rs10,000 crore, but reports suggest less than Rs1.000 crore was spent."

## Arvind Kejriwal accuses Congress of collaborating with BJP ahead of Delhi poll

New Delhi, Jan 30: Days ahead of the Delhi Assembly elections, Aam Aadmi Party (AAP) national convenor Arvind Kejriwal launched a scathing attack on the Congress on Thursday, accusing the party of "collaborating" with the Bharatiya Janata Party (BJP) to ensure AAP's defeat in the polls. Arvind Kejriwal, the national convenor of the Aam Aadmi Party (AAP), attacked the Congress harshly on Thursday ahead of the Delhi Assembly elections, claiming that the party was "collaborating" with the Bharatiya Janata Party (BJP) to guarantee the AAP's loss. "Congress is not contesting elections in Delhi to win, but they are collaborating with the BJP so that AAP loses," Kejriwal said in a video address. Referring to his recent meeting with Congress supporters, the former Delhi Chief Minister claimed that Congress lost the Haryana elections despite having a strong chance of winning, due to internal conflicts within the party. "A few days ago, some people came to meet me, who were supporters of Congress since inception. Even though



they said they would vote for Congress, they were also disappointed. They told me that Congress leaders are involved in infighting. They lost the Haryana elections that were in their corner," Kejriwal said. Appealing to Congress supporters to vote for AAP, he argued that Congress leaders never speak against BJP leaders but constantly slam AAP, and added that if

the BJP comes to power, they will discontinue the welfare schemes introduced by the AAP government in Delhi. "They told me that Congress leaders don't say a 3116 word against BJP leaders, but they are only busy criticising AAP. I told them that I had worked for them as well and not only for AAP. I told them I provided free electricity and made government schools better. I told them if they vote for Congress, the BJP will form the government (in Delhi). They will shut mohalla clinics, and free bus


services for women. I appeal to every Congress supporter that if they vote for Congress, the BJP will benefit. New Delhi, Jan 30: He spoke to HT about his journey, the power of compassion, and the significance of his work in the fight against child labour and slavery Children's rights activist and Nobel Prize winner Kailash Satyarthi is set to launch his autobiography, Diyasalai at the Jaipur Literature Festival on Thursday. He spoke to HT about his journey, the power of compassion, and the significance of his work in the fight against child labour and slavery. The title of your autobiography, Diyasalai (matchstick), is quite symbolic. What does it represent?The idea behind Diyasalai is deeply personal. I grew up in a home without electricity, relying on lanterns for light. A matchstick, though small, has the power to ignite countless candles and lamps. But it must be willing to burn itself first. To me, this is the essence of activism one must be ready to sacrifice in order to bring change. This metaphor has shaped my life's work. I believe every person carries an ocean of light within them; they just need to take that first step to ignite it. When I started working for the

most marginalised and neglected children, it was an uphill battle. For decades, the



world did not acknowledge their suffering. Even the United Nations did not have a convention on children's rights until the 1990s. When I began in the late 1970s, fighting for child dignity and freedom was

seen as utopian or idealistic. But I persisted, knowing that even a single spark can

light up the darkest corners of the world. While writing your autobiography, were there any moments that stood out or gave you new realisations?Writing this book made me relive some of my most difficult experiences. One of the most defining moments was my first rescue operation in 1981. A man Wasal Khan named came to me with a copy my magazine, of Struggle Shall Continue, pleading for help. His 15year-old daughter, Sabo, was about to be sold into

a brothel. She had been born into bonded labour at a brick kiln. I was a journalist at the time, writing about slavery, but that day, I asked myself - if Sabo were my sister or daughter, would I just write about it? No, I had to act. With a small group of friends, I went to rescue her and others. We were brutally attacked and left beaten. But we didn't give up. We approached the Delhi high court and ultimately freed 36 children, women, and men, including Wasal Khan's family. The most powerful realization came when I saw these children running on the streets, laughing, unable to comprehend their newfound freedom. I had always heard of India's freedom struggle, but that was the first time I truly understood what liberation meant. That moment changed my life forever. You've fought for children's rights for over four decades. How do you view the global progress on this issue?There has been progress, but not enough. No government, UN agency, or corporation can now ignore children's issues. However, we are still failing them. A UN report during the pandemic revealed that between 2016 and 2020, child labour increased for the first time in decades, from 152 million to 160 million. This was shocking and unacceptable. We live in a world that has more wealth, technology, and knowledge than ever before.

Yet, we are failing to solve even basic human problems. Conflicts such as those in Ukraine and Gaza have shown us that children remain the worst victims of war. This is why I have expanded my mission beyond just children's rights-I want to globalize compassion. You mentioned the need to "globalise compassion." Can you elaborate on that?We have globalised markets, economies, and data. Now, we must globalise compassion. The problems we face today - inequality, violence, climate change -- cannot be solved without a fundamental shift in leadership. We need compassionate leadership in politics, business, academia, and civil society. During the pandemic, I reflected deeply on this and began working with social scientists, neuroscientists, and psychologists to develop the concept of a Compassion Quotient (CQ) - a way to measure and enhance compassion in individuals and societies. We already have IQ (intelligence quotient) and EQ (emotional quotient); it is time we recognise CQ as a critical factor in decision-making and leadership. I hope to launch this concept globally this year.

### IISc researchers working on antivirals for mosquito-borne diseases

BENGALURU. Vaccines and antiviral although not very effective are there for flu virus, however there are none which are clinically approved for mosquito borne viral diseases like Dengue, Zika and Chikungunya.Realising the need for them in the era of global warming and with rising incidents in mosquito borne viral diseases, a team of researchers from the Department of Microbiology and Cell Biology at the Indian Institute of Science's (IISc's) Centre for Infectious Disease Research laboratory are working on antivirals for mosquito borne viral diseases.Speaking to The New Indian Express, Shashank Tripathi, assistant professor, from the department said earlier these viral diseases were more prevalent regions in the global south. But now because of global warming, incidents of mosquito borne viral diseases are also being reported from norther hemisphere region in the last decade."Mosquito borne viruses are always around us. Their increase or decrease of cases is seasonal. While there are vaccines for influenza, there is nothing for mosquito borne viral diseases, only symptomatic treatment is given. There is no specific drug for the treatment. Our lab is undertaking early discovery and preclinical development of antivirals for mosquito borne viruses like Dengue, Zika and JEV. Hopefully clinical trials in future," he said.

VILLUPURAM: An archaeological survey conducted in the Thenpennai River near Enathimangalam, Pidagam, Kuchipalayam, and Thalavanur near Villupuram has led to the discovery of an ancient terracotta doll, ring wells, and a pot with a narrow spout. The field study was carried out by archaeologists and research scholars C Immanuel, along with R Gopinath from the History Department of Arignar Anna Government Arts College, Villupuram, and postgraduate students K Saravanan and P Rahul from the same college.During the survey, the team identified a Sangam-era terracotta doll, ring wells, and a pot with a narrow spout on the riverbed."The doll was a finely crafted terracotta peice. The doll, found in a seated position, exhibits intricate detailing that reflects the artistic sensibilities of ancient people. However, its head, left hand, and leg were found broken. This discovery highlights the artistic skills of the ancient inhabitants of this region," said archaeologist Immanuel.

Two types of ring wells have been identified-one with stacked rings and another with inserted rings. In the Thenpennai River near Thalavanur, two stacked ring wells were also discovered"These wells were made by shaping clay into circular rings and firing them in a kiln before stacking them. They played a crucial role in providing water during dry seasons and preventing sand erosion," said Immanuel.

He added that ring wells have been in use from the Sangam period to recent times for drinking water and domestic purposes. Constructing such wells near lakes, ponds, and riverbanks was a long-standing practice in ancient settlements.

The Sangam-era literary work Pattinappalai mentions the presence of ring wells in the city of Poompuhar. Similar structures have been found in Tamil Nadu at Keeladi, Agaram, Poompuhar, Arikamedu, and Mamallapuram. In Villupuram district, they have been discovered in Tirukovilur, Thiruvamathur, Thalavanur, and near Panruti in places.

two-wheelers with two pillion riders and also some of them performing wheelies with no action taken by the city 731 formers registered in the state 7 police are causing a nuisance in the city, while also resulting in accidents and deaths, said the Karnataka High Court on Wednesday, directing the authorities to submit their response on the issue.A division bench of Chief Justice NV Anjaria and Justice MI Arun passed the order during the hearing of a public interest litigation filed by Dr Archana Bhat K, Associate Professor and Head of the Department of Psychology, Kateel Ashok Pai Memorial College in Shivamogga over implementing the law concerning wearing of safety harnesses and crash helmets by children starting from the age of nine months to four years who ride the pillion on two-wheelers. The court Speaking to the media, Marketing orally asked the government advocate about implementing the existing rules on helmets. It orally said that in Bengaluru, it finds youngsters and teenagers riding triples and doing wheelies in certain areas, but police not taking any action against them. The court asked what the government was doing against this nuisance. "Anybody living in Bengaluru will know about it. It's causing a huge nuisance in Bengaluru and there have been reported accidents and deaths because of that, which is public knowledge. Therefore, the government has to submit its response about implementing the existing laws," the court said.In the order, the court stated that the approach of the court may not be confined only to the issue of the petition concerning safety measures like safety harnesses and crash helmets while carrying a child, but the court may require the state authorities to redress the implementation of the safety rules concerning the two-wheeler riders including the pillion riders and the number of persons to ride on such two-wheelers.

Moreover, the impacts on various

shrines and religious institutions due to the project should be considered and addressed in a favourable manner.

In addition to this, the committee also acknowledged the suggestion in the SIA report to prioritise job opportunities for current residents of the project area during both the construction and operational phases of the airport. The SIA report, prepared by a team from the School of Social Work at Bharata Mata College, highlights that the airport project will directly affect the livelihoods of 238 families in the Cheruvally Estate and require the relocation of 352 families. Additionally, the project will involve the acquisition of seven places of worship, two schools, a hospital, a canteen, a ration store, and a labour office. With the completion of the SIA proceedings, a new notification for land acquisition will be issued under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act-2013 soon.

### **Tension grips Cuddalore village** as government starts clearing agriculture land, 25 held

CUDDALORE. Villagers of Malayadikuppam, Kodikanpalayam, and Pethankuppam under Vellakarai panchayat staged a protest on Wednesday against the acquisition of agricultural land for industrial purposes when the revenue officials, accompanied by over 100 police personnel, arrived with earth movers to clear the land at Malayadikuppam.The government had issued a notice on December 19, stating the land had been encroached upon and must be vacated within 15 days. Villagers claim they have been residing there for over 100 years, cultivating cashew crops. They had previously submitted petitions seeking pattas for their residential and agricultural land, but officials informed them around 150 houses and cashew plantations would be removed.During the two-hour-long protest, PMK Cuddalore East district secretary S



Muthukrishnan, BJP East District president Agni Krishnamurthy and Tamil Nadu Farmers' Association members held talks with sub collector Abhinaya. The villagers requested a three-month extension to harvest their cashew crops, but officials insisted on a written assurance the land would be handed over after three months. The farmers refused, stating they would not give up their lands.With negotiations failing, police attempted to disperse the protestors and arrested over 25 people and took them to a private wedding hall in Vellakarai.

731 farmers registered in the state. lakh 81 thousand 447 metric tonnes of soybean have been purchased from 3 lakh 69 thousand 114 farmers, which is the highest purchase compared to other states.Maharashtra has purchased the highest amount of soybean in the country, surpassing Madhya Pradesh , Rajasthan , Karnataka, Gujarat and Telangana, informed Marketing Minister Jayakumar Rawal.

Minister Shri. Rawal said , many districts have fulfilled their procurement target. Instructions have been given to the system to expedite the procurement process of soybeans so that the soybean producing farmers do not face any problem and to take swift action so that the amount reaches the farmers' accounts within two to three days.Since the procurement will continue till January 31, 2025, there will be a big increase in the procurement figures of soybeans. However, if there is a need to extend the procurement period of soybeans, an extension will be requested from the Central Government, he also said.Marketing Minister Shri. Rawal said that soybean procurement is underway in the state through six state-



level nodal agencies under NAFED and NCCF. Registration of soybean producing farmers was started from October 1, 2024. Accordingly, physical procurement has been started at 562 procurement centers in the state from October 15, 2024. Due to technical difficulties encountered during registration, the registration period was extended once. After that, initially the soybean procurement period was till January 12, 2025, but since many farmers did not purchase soybeans within this period, Chief MinisterDevendra Fadnavis requested Union Agriculture Minister Shivraj Singh Chauhan and extended the procurement period till January 31, 2025.Maharashtra has purchased the most soybeans compared to the major soybean producing states of Madhya Pradesh, Rajasthan, Karnataka, Gujarat

of these six states including Maharashtra has been 18 lakh 68 thousand 914 metric tons, of which Maharashtra has purchased 7 lakh 81 thousand 447 metric tons. The highest amount of soybeans in the state has been purchased in Nanded district, 1 lakh 290 metric tons, from 57 thousand 528 farmers.

This is followed by 60 thousand 989 metric tons purchased from 29 thousand 764 farmers in Hingoli district. Minister Shri. Rawal said that the procurement process is still going on at a fast pace after resolving all the technical difficulties encountered in the initial phase.The Central Government has declared a minimum support price of Rs 4,892 per quintal for soybean for the year 2024-25 and procurement is underway accordingly.

This rate is Rs 292 per quintal higher than the minimum support price of the previous year. The area under cultivation in the year 2024-25 is 50.51 lakh hectares and the production is expected to be 73.27 lakh metric tonnes. Minister Shri. Rawal has also informed that the Central Government has approved 14 lakh 13 thousand 270 metric tonnes (19.28 percent) for the procurement of PSS.

## How cracking a murder case unmasked a serial killer

Kerala. During another wave of lockdown in February 2022, for the people of Thiruvananthapuram, as equally nervewracking as the news of a rampaging new Covid variant was the brutal murder of a woman voung near Ambalamukku.Nedumangad native Vineetha Mol, a staff at a plant nursery here, was found dead with three deep slashes on her neck. The 38-year-old's body was tucked under a flex banner, seemingly to keep it hidden. By the time it was found, the murderer had already vanished.

With little evidence to go on, the Peroorkada police, led by then CI V Sajikumar, relied on a grainy CCTV clip from the area. The footage showed a man, who had not been seen before in the area, walking along the Ambalamukku-Kuravankonam road. He wore a full-sleeved shirt, trousers, a cap, and because it was Covid, a mask. One other

detail stood out - his left hand hung limp as if injured."This was our first lead," recalls Sajikumar. "Also, the missing four-sovereign gold chain that Vineetha used to wear suggested that it was robbery-turned-murder. Further analysis of the footage revealed that the killer had entered the nursery around 11am and left 20 minutes later," the officer adds.After leaving the nursery, the suspect boarded an autorickshaw to Muttada. Police tracked down the driver, who remembered the man because of his limp hand.

The driver also noted that the man spoke broken Malayalam, suggesting he wasn't a native of Kerala. With no name or confirmed identity, the police released a sketch and launched a citywide search, focusing on migrant labourers and even more CCTV footage. Then came a breakthrough. A local



man sitting on his terrace reported seeing someone matching the suspect's description. The stranger had approached him, asking mostly through gestures if a nearby pond was safe for bathing.Shortly after, a new CCTV clip showed a man resembling the suspect but wearing different clothes, hitchhiking on a bike.

## NCR dists among lowest in govt school enrolment, but very few out of edu

Noida. Enrolment in govt schools in UP's NCR districts in 2024 was among the lowest in the state, the Annual State of Education Report (ASER) has found. Ghaziabad and Gautam Budh Nagar, however, also had among the smallest percentage of kids not enrolled in any school.Govt school enrolment for children in the 6-14 age group was 33.1% in Gautam Budh Nagar (65th spot among 70 districts) and 33.8% in Ghaziabad (63rd spot). This was marginally better than the 23.3% and 31.4%, respectively, in the two districts in 2022 when the survey was last conducted. In overall enrolment, the picture totally changes, with only 1.3% and 0.2% of the kids surveyed in GB Nagar and Ghaziabad, respectively, not enrolled in any school. In 2022, this was 1.9% for Gautam Budh Nagar and 2.3% for Ghaziabad.The numbers do not come as a surprise because of better availability of private

schools in the two districts but underscore the need for all-round improvement in govt schools, which are much cheaper, to get more parents to admit kids there. Education experts say higher per capita income in GB Nagar and Ghaziabad is among key factors behind higher enrolment in private schools that offer better facilities and quality of education. In UP, Noida has the highest per capita income at Rs 6.1 lakh. Ghaziabad's per capita income is Rs 95,216, according to the district administration.Praveen Sharma of primary government school teachers' union in Noida said enrolment at govt schools during the Covid pandemic increased as many people lost their jobs. But once the lockdown was lifted and the financial condition of families improved to pre-Covid levels, there was a shift towards private schools."Ensuring enrolment of students is not the ultimate

The ASER report also highlights that 65% of students of classes III to V in govt schools could read a Class II level textbook and do basic arithmetic with proficiency. In 2022, only 53.6% of kids showed adeptness in reading and

60.8% in maths.Ghaziabad, however, saw a decline in reading proficiency for the age group — from 53.8% in 2022 to 51.0% in 2024. Arithmetic skills improved marginally in Ghaziabad, from 56.8% in 2022 to 60.6% in 2024. OP Yadav, the district's basic education officer, said, "We are working to improve the learning outcomes of the children enrolled at govt schools in the district."Among older students (Classes VI to VIII), reading proficiency in Noida slightly declined from 84.3% in 2022 to 82% in 2024, whereas Ghaziabad showed an improvement from 72.4% in 2022 to 75.1% in 2024. In terms of mathematical ability, the percentage of students in the age group who could do division dropped slightly in Noida from 63% in 2022 to 60.6% in 2024. Ghaziabad, however, recorded an improvement, rising from 48.6% in 2022 to 63.3% in 2024.Noida basic education officer Rahul Panwar said.

After waiting for him until late in the evening, his father, Premchand, filed a complaint with Sector 10 police on Tuesday night. A missing case was registered under section 127 (6) of BNS.

### 70 check posts, cams & 650 home guards to protect Aravalis soon

Gurgaon: Seventy check posts — all equipped with 24x7 CCTV coverage - across seven district areas where the Aravalis lie will be established. Around 650 home guards will also be positioned in seven districts of Haryana. The new check posts, with round-the-clock surveillance, aim to deter illegal mining and other unauthorised activities in the region. The Haryana govt hopes that this measure, along with other planned interventions, will help restore and preserve the Aravalis, ensuring their ecological health for future generations.Divisional forest officer Raj Kumar said, "In Gurgaon, we will set up 20 check posts. We are likely to have 150-160 home guards to monitor the Aravalis." This initiative comes in response to directions from National Green Tribunal (NGT) to develop a comprehensive restoration plan for the region that has been severely impacted by decades of mining and concretisation. The Aravali hills have faced significant environmental degradation over the years, not only from mining but also from construction activities such as the building of roads, farmhouses and other infrastructure as urban areas expand rapidly. The



unchecked exploitation of these hills has led to the flattening of the terrain, threatening the ecological balance of the region. In Nov 2023, a committee formed by NGT reported to the tribunal that there were 38 illegal mining sites in the Aravalis of Gurgaon and Nuh, as evidenced by FIRs filed over the years. Some of these sites showed fresh signs of stone quarrying, highlighting the ongoing challenges in curbing illegal activities.In 2023, Haryana govt formed the sevenmember Aravali Rejuvenation Board to deal with complaints on illegal mining and protecting the hills. Haryana State Pollution Control Board is the nodal agency to coordinate the board's action plan.ssNGT in Nov 2023 had expressed its frustration with Haryana govt, saying that authorities were not taking the bench's orders "seriously" to crack down on amining. The tribunal was hearing a petition by the Aravalli Bachao Citizens Movement, alleging rampanta quarrying of

## Gurgaon AQI turns 'very poor' after a month, GRAP-III invoked

Gurgaon. The Commission for Air Quality Management (CAOM), on Wednesday, imposed Stage-III restrictions of the Graded Response Action Plan (GRAP) in Delhi-NCR after pollution levels rose to the 'very poor' category.Gurgaon's air quality index (AQI), recorded at 312 (very poor) on Wednesday, deteriorated sharply from the previous day's 'poor' reading of 238. Experts attributed this to poor dispersion of pollutants due to lower wind speeds. The last time Gurgaon grappled with 'very poor' air was over a month back on Dec 27 with an AQI of 349.Similarly, Delhi's AQI worsened to 365 (very poor) from 276 (poor) on Tuesday. The GRAP subcommittee of CAOM convened an emergency meeting and invoked GRAP-III, noting the spike in AQI due to variable wind directions, smog, and low ventilation for pollutants. This is in addition to the measures enforced already under stages I and II of GRAP.Stage-III measures include a comprehensive nine-point action plan to curb pollution. These steps include strict restrictions on earthwork, piling, demolition, and other dust-generating activities across the NCR. Only essential projects such as railways, metro services, airports, national security, hospitals, and sanitation projects can continue, subject to strict compliance with dust control norms. The use of BS-III petrol and BS-IV diesel cars is restricted under this stage. The CAQM order mandated hybrid classes - both physical and online mode (wherever feasible) - for children up to class 5 in Delhi, Gurgaon, Faridabad, Ghaziabad, and Gautam Budh Nagar.Of the four monitoring stations in Gurgaon, Sector-51 was the worst hit at 330, followed by Teri Gram which was just a few points away from the 'very poor' category at 295. Gwalpahari and Vikas Sadan stations did not record AQI readings due to insufficient data. The wind speeds dropped to 5kmph on Wednesday from the previous day's 12kmph, hampering the dispersion of pollutants, experts said. The System of Air Quality and Weather Forecasting and Research (Safar) predicted further deterioration of air quality over the next three days with wind speeds likely to go below 5kmph. "Smog or mist fog is likely in the evening and night with mainly clear sky on Jan 31," Safar stated.

A ventilation index lower than 6000 m2/s and an average wind speed less than 10kmph is unfavourable for dispersion of pollutants. The level of PM2.5 -- a toxic particulate matter that reaches the blood via the lungs -was the worst at Sector-51 (354  $\mu$ g/m<sup>3</sup>), followed by Gwalpahari (312 µg/m<sup>3</sup>).

## Israeli strike kills at least 10 people in the West Bank, officials say

WEST BANK. Palestinian health authorities said an Israeli airstrike in the northern West Bank killed at least 10 people late Wednesday.Israel's use of a jet fighter to strike the rural village of Tamoun late Wednesday marked the latest escalation in its intensifying crackdown on Palestinian militants in the occupied territory.Residents of Tamoun said that the airstrike hit a house in a crowded neighborhood. The Palestinian Health Ministry cautioned that the death toll was likely to rise.In a statement, Hamas mourned the men killed in Tamoun but did not claim them as members. It called on Palestinians across Israel and the occupied West Bank to mobilize against Israel in hopes of making it "pay the price for its crimes."The tenuous ceasefire between Israel and Hamas is aimed at ending the war in Gaza and securing the release of dozens of hostages held by the militant group, as well as hundreds of Palestinians imprisoned or detained by Israel. The truce does not apply to the West Bank.Under the ceasefire, hundreds of thousands of Palestinians have jubilantly returned to northern Gaza over the past three days. However, their homecoming has been bittersweet as nearly everyone has friends or relatives who died, and many northern neighborhoods have been transformed into an apocalyptic landscape of devastation by more than 15 months of war.

### 2 dogs get new homes after surviving plane crash that killed rescue flight pilot

World Two dogs that survived an animal-rescue flight crash that killed the pilot have found new homes as the late aviator's friends work to honor him by helping more pets, a shelter director said Wednesday.

The Nov. 24 crash in New York's Catskill Mountains killed Seuk Kim of Springfield, Virginia, a dedicated volunteer who transported cats and dogs from disaster areas and overcrowded shelters to rescue groups. He was bringing three dogs to an Albany, New York-area organization called the Animal Shelter of Schoharie Valley when his 1986 Mooney M20J went down.Kim told air traffic controllers that he hit moderate to heavy turbulence at 5,000 feet (1,520 meters), but then he descended to about 4,300feet (1,311 meters) and reported that conditions improved to light to moderate turbulence, according to the National Transportation Safety Board's preliminary report on the crash. The report said he didn't contact air traffic control again or make any distress calls. Two of the dogs, a Labrador-mix puppy named Whiskey and a young Yorkshire terrier mix called Pluto, survived. Pluto was internally bruised, while Whiskey was found huddled in the snow with two broken legs. The Lab pup subsequently underwent surgeries at Pieper Memorial Veterinary emergency and specialty hospital in Middletown, Connecticut.After those procedures and lots of physical therapy, 6-month-old Whiskey is on his feet and playing at his foster home in Middletown, and the family that took him in has decided to keep him, said Maggie Jackman Pryor, the executive director of the Animal Shelter of Schoharie Valley.Pluto, meanwhile, recovered duickly and was adopted a few weeks into a home in Averill Park, a community near Albany, Pryor said. The remains of the third dog, a little one named Lisa, went to Kim's relatives at their request.

## West Virginia white couple convicted of forced labor, human trafficking of adopted black kids

CHARLESTON, W.Va. A West Virginia couple accused of neglect and forced labor involving their adopted children was convicted by a jury on Wednesday after eight hours of deliberations.Jeanne Kay Whitefeather and Donald Ray Lantz went on trial in mid-January and each faced over a dozen counts, including forced labor, civil rights violations, human trafficking and child neglect. The couple, who are white, were accused of mistreating their children — all of whom are Black — by locking them in a shed, forcing them to sleep on the floor and use buckets as toilets, and more. The Kanawha County Circuit Court jury convicted Whitefeather on all 19 counts against her, including the civil rights violations. Lantz was found guilty on 12 counts out of 16. He was acquitted of four counts of civil rights violations. Both showed little emotion as the verdict was read.Kanawha County Prosecuting Attorney Debra Rusnak said she cried as she heard the word "guilty" repeated again and again."These cases mean a lot to us -we take a lot of this personally," she said at

a news conference afterward. "This is our community, and these are the children of our community. If we're not going to fight for them, then who will?"Whitefeather and Lantz adopted the five siblings while living in Minnesota, moved to a farm in Washington state in 2018, and then brought the family to West Virginia in May 2023, when the children ranged in age from 5 to 16. The couple was arrested in October 2023 after neighbors saw Lantz lock the oldest girl and her teenage brother in a shed and leave the property. A deputy used a crowbar to get them out.Inside the main residence, a 9-year-old girl was found alone crying in a loft with no protection from falling, according to a criminal complaint. A fourth child was with Lantz when he eventually returned. Deputies were later led to the couple's youngest daughter. The children were found in dirty clothes and smelling of body odor, deputies said, and the eldest boy was found barefoot with what appeared to be sores on his feet. All five were turned over to Child Protective Services after the couple's arrest.During

the trial, neighbors in Sissonville testified they never saw the children play and witnessed Lantz make them stand in line or perform difficult chores around the yard, including lifting heavy items. After Lantz noticed the curious neighbors, the children mostly stayed indoors. The couple's eldest

daughter, now 18, testified that the outdoor work occurred mostly in Washington and that some of them were forced to use their hands for digging. She also said the children were fed a steady diet of peanut butter sandwiches at scheduled times, some left over from a previous meal. Some kids were

forced to stand in their rooms for hours and keep their hands on their heads. The oldest girl and boy shared a room, including the same bucket for using the bathroom while the other held up a sheet for privacy. The couple and their attorneys pushed back on the accusations, with Lantz testifying that the chores were assigned to teach the children responsibility.Whitefeather called the shed the children were found in a "teenager hangout" and said

free to leave as they pleased. Whitefeather's attorney said the oldest boy had attempted to run away from home and the lock on the shed was meant to keep him from trying again. Testimony showed the children didn't know where a key was — detectives found one out of sight on a cabinet in the shed.Prosecutors said the couple's tactics were less about teaching responsibility and instead about control."The whole point of treating them this way is they become less than human," Kanawha County Assistant Prosecutor Chris Krivonyak said.

## Newly spotted asteroid has a tiny chance of

**CAPE CANAVERAL, Fla.** A newly discovered asteroid has a tiny chance of smacking Earth in 2032, space agency officials said Wednesday.

hitting Earth in 2032

Scientists put the odds of a strike at slightly more than 1%."We are not worried at all, because of this 99 percent chance it will miss," said Paul Chodas, director of NASA's Center for Near Earth Object Studies. "But it deserves attention."First spotted last month by a telescope in Chile, the near-Earth asteroid — designated 2024 YR4 — is estimated to be 130 to 330 feet (40 to 100 meters) across.

Scientists are keeping close watch on the space rock, which is currently heading away from Earth. As the asteroid's path around the sun becomes better understood, Chodas and others said there's a good chance the risk to Earth could drop to zero.

The asteroid will gradually fade from view over the next few months, according to NASA and the European Space Agency. Until then, some of the world's most powerful telescopes will keep monitoring it to better determine its size and path. Once out of sight, it won't be visible until it passes our way again in 2028.



### US passenger jet with 64 aboard collides with Army helicopter near Washington, several feared dead

- ARLINGTON. A jet carrying 60 passengers and four crew members collided Wednesday with an Army helicopter while landing at Ronald Reagan National Airport near Washington, prompting a large searchand-rescue operation in the nearby Potomac River.

## House—so far—couldn't be more different

Donald Trump sounds the same, but his White

NEW YORK. The marathon O&A sessions are back, along with the cream Oval Office rug and the Diet Coke button on the Resolute Desk. So, too, are the late-night social media posts that ricochet across the globe and the barrage of executive orders.But in 10 days, Donald Trump has frozen federal spending and hiring, offered buyouts to more than two million government workers, and ended federal diversity and transgender-rights efforts.

He's fired nearly two dozen independent inspectors general, rewritten American maps, pardoned Jan. 6 protesters who assaulted police, announced plans to detain migrants at Guantánamo Bay, and undone years of his predecessors' actions with the stroke of his Sharpie pen.Trump 2.0 looks and sounds a lot like he did during his first go-around. But this time, the president is far more experienced and surrounded by a team that's spent years planning for its White House return, unleashing a fusillade of action that is testing the bounds of presidential power, sowing confusion and drawing fury from Democrats unsure how to stop him.

"He seems much more comfortable, almost relaxed in how he's doing the job," according to Sean Spicer, Trump's first White House press secretary, who said Trump is showing a new "level of confidence," having spent four years in office."I think he has the people, the policies and the process down. He knows who can get his agenda done, who he wants to surround himself with, the policies he wants to advance, and the process to get that enacted," said Spicer, who now hosts a show on YouTube.US President Donald Trump answers questions from reporters as he

Trump no longer needs to worry about reelection. The Constitution bars a third term. He faces little resistance from a unified Republican Congress, which controls both chambers. The Supreme Court, a third of which he nominated, has ruled that he and future presidents have expansive immunity from legal consequences.But beyond that, Trump has lived through a stunning four years, surviving a pair of assassination attempts, including one in which a would-be assassin's bullet grazed his ear. He was indicted four times, became the first former president to be convicted of a crime-and.

The potential impact would occur on Dec. 22, 2032. It's much too soon to know where it might land if it did hit Earth. The good news, according to NASA, is that for now, no other known large asteroids have an impact probability above 1%.

## Robert F Kennedy Jr's nomination signals new era of anti-intellectualism in American politics

World The many controversial people appointed to the Trump administration, from Elon Musk to Robert F. Kennedy Jr., Skepticism, false assertions have at least one thing in common: They dislike and distrust experts. While antiintellectualism and populism are nothing new in American life, there has hardly been an administration as seemingly committed to these worldviews.

Take President Donald Trump's decision to nominate Kennedy, a well-known vaccine skeptic, to lead the Department of Health and Human Services. Kennedy, whose Senate confirmation hearing is Jan. 29, 2025, epitomises the new American political ethos of populism and anti-intellectualism, or the idea that people hold negative feelings toward not just scientific research but those who produce it.Antiintellectual attacks on the scientific community have been increasing, and have become more partisan, in recent years. For instance, Trump denigrated scientific experts on the campaign trail and in his first term in office. He called climate science a

"hoax" and public health officials in his administration "idiots."

This rhetoric filtered into public discussion, as seen in viral social media posts mocking and attacking scientists like Dr. Anthony Fauci, or anti-mask protesters confronting health officials at public meetings and elsewhere.Trump and Kennedy have cast doubt on vaccine safety and the medical scientific establishment. As far back as the Republican primary debates in 2016, Trump falsely asserted that childhood vaccines cause autism, in defiance of scientific consensus on the issue.

Kennedy's long-term vaccine skepticism has also been well documented, though he himself denies it. More recently, he has been presenting himself as "pro-vaccine safety," as one Republican senator put it, on the eve of Kennedy's confirmation hearing. Kennedy has mirrored Trump's antiintellectual rhetoric by referring to government health agency culture as "corrupt" and the agencies themselves as



"sock puppets." If confirmed, Kennedy has vowed to turn this anti-intellectual rhetoric into action. He wants to replace over 600 employees in the National Institutes of Health with his own hires. He has also suggested cutting entire departments. During one interview, Kennedy said, "In some categories, there are entire departments, like the nutrition department at the FDA, that are - that have to go."Populism across political spectrum

In lockstep with this anti-intellectual movement is a version of populism that people like RFK Jr. and Trump both

espouse.Populism is a worldview that pits average citizens against "the elites." Who the elites are varies depending on the context, but in the contemporary political climate in the U.S., establishment politicians, scientists and organizations like pharmaceutical companies or the Centers for Disease Control and Prevention are frequently portrayed as such.For instance, right-wing populists often portray government health agencies as colluding with multinational pharmaceutical companies to impose excessive regulations, mandate medical interventions and restrict personal freedoms.Left-wing populists expose how Big Pharma manipulates the health care system, using their immense wealth and political influence to put profits over people, deliberately keeping lifesaving medications overpriced and out of reach all of which has been said by politicians like Bernie Sanders. The goal of a populist is to portray these elites as the enemy of the people and to root out the perceived "corruption" of the elites.

### **R-Day tragedy: Villagers lock** Malabiharpur high school seeking action against three teachers

- CUTTACK. Ever since the death of a Class X student of Government High School, Malabiharpur in a road mishap on Republic Day, local residents have locked the institution's gate demanding that stringent action be taken against three teachers they hold responsible for the incident and compensation paid to the deceased's family with their six months' salaries.On Wednesday, the villagers submitted a memorandum addressed to the CM and School and Mass Education department threatening to intensify stir if action is not taken within five days. Holding three teachers responsible for the road accident, the villagers demanded that they be immediately suspended or transferred.
- \*Since the pick-up van meant for carrying goods had no insurance and other valid documents, the deceased student's family will be deprived of availing the insurance benefit. Hence we are demanding that the owner of the vehicle pay '50 lakh to his family," they said.A Class X student Soumya Ranjan Behera was killed and 24 others suffered injuries when the pick-up van in which they were travelling to take part in the Republic Day parade at Saranda overturned at Kaligodi on Malabiharpur-Ansupa Road. Six injured students who were undergoing treatment at SCB MCH were shifted to ICU after their condition deteriorated.

### Man wanted by TN cops for financial fraud arrested in Kolkata airport based on Interpol red notice

- CHENNAI. A man wanted by the Tamil Nadu police for financial fraud was arrested at the Kolkata airport based on a red corner notice issued against him by the Interpol, CBI said on Wednesday.The Global Operations Centre of CBI closely coordinated with Tamil Nadu police, the Indian embassy in Bangkok and immigration authorities at the Kolkata airport to arrest the accused, Janarthanan Sundaram, the agency said.
- The Economic Offences Wing (EOW) in Chennai had registered a case in 2022 related to the offences of criminal conspiracy, criminal breach of trust, cheating, default in repayment of deposits/interest and offences committed under the Banning of Unregulated Deposit Schemes Act, 2019, and the Tamil Nadu Protection of Interests of Depositors Act, 1997.Sundaram, along with other accused, had cheated depositors of Rs 87.5 crore, CBI said.Based on a request by TN police, CBI got a red corner notice issued against him by the Interpol on June 21, 2023, and circulated it to all Law Enforcement Agencies (LEAs) globally for tracking him down.He had travelled to Bangkok on

### **Telangana HC dismisses** Delay in Nallamala - Seshachalam corridor project poses grave threat to leopards, tigers missing I&A certificate

NELLORE. The prolonged delay in creating a crucial wildlife corridor linking the Nallamala and Seshachalam forests has led to another tragic incident where a leopard was fatally struck by a vehicle near the proposed corridor site.

This recent hit-and-run case underscores the pressing need for safe animal crossings to protect wildlife from increasing road accidents.The corridor, envisioned as a vital route for wild animals, including tigers, leopards, and deer, was designed to provide seamless connectivity between the two forests.

However, bureaucratic delays and lack of funding have left the project in limbo, forcing wildlife to venture onto highways and human settlements in search of food and water.

Wildlife casualties have become distressingly frequent. In March and January 2022, three leopards died in separate accidents on National Highway 565. Numerous incidents involving deer and wild boars have also been reported, with a deer being the most recent victim near Bujabuja Nellore. In June 2022, another leopard was severely injured in a road accident.Speaking on the issue, a senior forest official said, "We have already submitted proposals for underpasses on national highways.

To support wildlife during the summer, we have established water pits and are installing warning boards. Once the underpasses are



completed, wildlife accidents will decrease significantly."The corridor's development is crucial not only for wildlife safety but also for biodiversity conservation. Tigers occasionally travel from Nallamala to Seshachalam but return due to the lack of continuous forest cover. The absence of the corridor has hindered potential reintroductions of tigers and put other species at risk

Spanning nearly 400,000 hectares across four districts, the proposed corridor is seen as a solution to reduce human-wildlife conflict. Conservationists argue that without swift action, more wildlife fatalities are inevitable. Efforts to expand the Nagarjuna Sagar-Srisailam tiger zone by an additional 500,000 acres have also come to a halt.

Forest officials note increasing tiger activity between Nellore and Kadapa districts, further emphasising the need for uninterrupted

connectivity.In response to rising concerns, authorities have implemented temporary measures, such as installing CCTV cameras, raising awareness, and creating water troughs to keep wildlife within forest boundaries. However, activists contend that these steps are insufficient without the corridor's completion.

Nellore district, home to over 1,030 square km of forest, faces significant wildlife threats due to three national highways passing through its borders. Vehicle collisions are

a common occurrence, with 15 leopard deaths reported in the region in 2022 alone. Three of those fatalities occurred within Atmakur Range.Proposals for underpasses along NH 565 and the Mumbai road, as well as plans for a long flyover to facilitate safe wildlife crossings, remain unfulfilled.

The Penusila Nrisimha Sanctuary is the only exception where conservation measures have progressed. Without timely action and adequate funding, officials fear the grim pattern of wildlife fatalities will persist, endangering biodiversity and threatening the region's fragile ecosystem

.Conservationists continue to urge the government to prioritise the wildlife corridor and related projects for the long-term preservation of Andhra Pradesh's forest heritage.

Telangana. The Telangana High Court on Wednesday dismissed a writ appeal filed by T Thirupathi, ruling that eligibility for the Economically Weaker Sections (EWS) category was determined only when the Income and Asset (I&A) certificate for the relevant financial year was produced. In this case, the appellant failed to

furnish the required certificate for the financial year 2021-22. The appeal sought to modify an interlocutory order dated November 19, 2024, in WP of 2024, wherein a single judge of the high court issued notice before admission and ordered that any selection for the post of Hostel Welfare Officer Grade-II under Notification No.25 of 2022 issued by the Telangana State Public Service Commission (TSPSC) would be subject to the outcome of the writ petition. The TSPSC issued a notification on December 23, 2022, for filling various posts in the Tribal Welfare department. Thirupathi applied for the position on January 26, 2023. After scrutiny, he was issued a hall ticket and appeared for the written test on June 28, 2024, scoring 193.19 marks. As per the notification, a 10% reservation for EWS candidates was provided under GO Ms. No. 65, dated May 19, 2021. Further, it mandated that candidates must submit an I&A certificate issued by a competent authority. The appellant, however, was unable to obtain the EWS certificate for the financial year 2021-22.The Telangana High Court on Wednesday gave the Home Ministry a final opportunity to file its counter in a PIL filed by Heaven Homes Society (HHS), a non-profit organisation for women and child welfare, against the failure of the authorities to file chargesheets or final reports in relation to FIR No. 67 of 2017 dated February 20, 2017, and FIR No. 1005 of 2013 dated January 12, 2013. The society urged the bench of Acting Chief Justice Sujoy Paul and Justice Renuka Yara to direct the respondents to establish special guidelines or restrictions to regulate the sale of spy cameras, ensuring that such devices are sold only through authorised.

## Forest department launches Mission FFW to reduce human-wildlife conflict in Kerala

KOCHI. The forest department has launched Mission FFW (food, fodder and water), to improve wildlife habitat and ensure availability of water in the forest in an attempt to reduce human-wildlife conflict in forest fringe areas of the state. The project will be implemented in three phases from January 1 to the beginning of Monsoon season. During the first phase, forest teams will identify rivers, streams, waterholes, natural ponds, man-made ponds, checkdams, grasslands and open areas in

forest areas and map them. The waterbodies will be segregated into those that have dried up and ponds that never dry up. These activities will be completed before February 10. During the second phase that extends from February 11 to April 30, the forest department will construct brushwood checkdams across narrowing

## Unmarked speed bumps on newly laid Red Fields road pose danger to motorists

COIMBATORE: The lack of reflective markings on speed breakers on the newly-laid Red Fields Road near Puliakulam in Ward 66 of the city poses a threat to motorists, especially two wheeler riders. The riders are not able to spot the speed bumps and lose balance while passing over them suddenly.Stating that the problem is acute at night, road users have urged the Coimbatore City Municipal Corporation to take action and ensure safety. "This is a busy road, and the absence of markings on the speed bumps is dangerous. Two-wheeler riders find it difficult to spot the bumps, which puts them at risk of



streams. All check dams and ponds will be desilted to ensure availability of water. All invasive plant species will be removed from the area and damaged checkdams will be repaired. All grasslands and open areas in the forest will be mapped and protected to ensure availability of fodder for These activities will be completed before April 30. The third phase will start from May 1. The department will ensure that checkdams do not hamper the movement of fish species from rivers to streams for breeding during the rainy season. All invasive plants will be removed before they start flowering.

The grasslands will be divided into strips and controlled early burning will be conducted to avoid forest fire. The early burning will be conducted during morning and evening and forest staff will ensure that there are no birds or wild animals in the area. Overgrowth on either side of forest roads will be removed to a distance of 5.5 m to improve visibility and to avoid accidents.

### Amaravati ORR works gain momentum

- VIJAYAWADA. As the State government aims to complete the works in Amaravati, the National Highways Authority of India (NHAI) has expedited the alignment works for the six-lane outer ring road (ORR), which is estimated to cost Rs 16,310 crore. Originally proposed in 2015 to facilitate efficient transportation around the capital region, the ORR will connect five
- districts-NTR, Krishna, Eluru, Guntur, and Palnadu - spanning 189.4 kilometres. The project, which was stalled during the previous YSRCP administration, resumed on October 1, 2024. The NHAI is now preparing for land acquisition, following alignment approvals from both the State and Central governments.
- The six-lane ORR, which will be 70 metres wide, will connect six highways. It will include two bridges over the Krishna River, three tunnels, 51 major bridges, 78 small bridges, seven underpasses, and three road over bridges (ROBs).As part of resuming the works, Detailed Project Report (DPR) consultants were reappointed, and a fresh drone survey was conducted.
- The survey identified nine locations obstructing the existing alignment. The revised alignment plan was submitted to the State government for approval and later forwarded to the Alignment Committee of the Ministry of Road Transport and Highways (MoRTH), which recommended four modifications. The Union Ministry has deemed the Vijayawada Eastern Bypass unnecessary, as it runs parallel to the ORR and only connects Chinnakakani.After incorporating these changes, the updated alignment was resubmitted for final approval. The government has decided to exempt GST on cement, steel, bitumen, and other materials used in the ORR construction.

BENGALURU. Governor Thaawarchand Gehlot promulgated the Bangalore Palace (Utilisation and regulation of land) ordinance, 2025, passed by the state government, and it was published in the state's gazette (extraordinary) on Wednesday, With this, the utilisation and regulation of land of Bangalore Palace, belonging to the erstwhile Mysuru royal family acquired under the Bangalore Palace (Acquisition and Transfer) Act, 1996 (Karnataka Act 18 of 1996), now vests with the state government.

The cabinet on Friday had decided to promulgate the ordinance in the wake of a Supreme Court order dated December



10, 2024 that the government has to pay Rs 3,014 to the royal family as compensation to utilise 15 acres 17.5 guntas of land to widen the Jayamahal and Ballari road on a 2 km stretch. If that order had to be honoured, it would burden the state's exchequer, the government argued.

It is interesting to see if the government resumes the road widening work or waits for SC's final judgment. The ordinance explains that the total value of the entire extent of 472 acres and 16 guntas of Bangalore Palace has been determined in accordance with the Act at Rs 11 crore. Its constitutional validity has been upheld by the High Court, and there is no stay on the operation of the

Court. However, the Supreme Court in a contempt case (No. 688 of 2021 etc) has directed the government to grant Transferable Development Rights (TDR), valuing the part of the Bangalore Palace earmarked for the purpose, in accordance with the prevailing guidance value of

adjoining areas in accordance with section 45B of the Karnataka Stamp Act, 1957 (Karnataka Act 34 of 1957).The civil appeals relating to the constitutional validity of the act are pending consideration of the Supreme Court and the grant of the TDR will be an irreversible process, which will have a severe ramification on the state, it added.Since the Assembly and Council are not in session, the governor is satisfied that the circumstances exist which render it necessary and expedient to exercise powers under Article 213 (1) of the Constitution, and promulgated the Ordinance which shall come into force on Jan 27, 2025, the gazette notification stated.

## Karnataka High Court declares ED raid on ex-MUDA chief illegal

BENGALURU. The High Court of Karnataka on Wednesday declared that the Enforcement Directorate's (ED) raid on the residence of Natesha DB, former MUDA commissioner, in connection with the alleged irregularities in allotment of 14 sites to BM Parvathy, wife of CM Siddaramaiah, during his tenure, as illegal, unwarranted and abuse of law.

Interestingly, the court said mere possession of a site that was allegedly illegally allotted to an accused in a criminal case cannot be considered an offence under the Prevention of Money Laundering Act, 2002 (PMLA), unless it attracts the provisions of Section 3 of the Act. The high court said the search conducted on the premises of Natesha in the guise of investigation when there is no prima facie evidence to establish the offence under Section 3 of PMLA, is an abuse of process of law. The court said ED

cannot give the elements of procedural fairness contained in PMLA a go by in the course of its administration. The right to liberty and privacy of individuals cannot be trampled upon and any curtailment of civil liberties is subject to the due process of law.

Allowing Natesha's petition challenging ED's proceedings, Justice Hemant Chandangoudar said the impugned search and

seizure conducted at the residence of the petitioner on October 28 to 29, 2024, and the subsequent statement recorded under Section 17(1)(f) of PMLA are vitiated on the grounds of absence of 'reason to believe' and is hereby declared invalid and illegal.

The judge said the statement recorded under Section 17(1)(f) of PMLA is ordered to be



retracted and the impugned summons of October 29, 2024, and November 6, 2024, issued under Section 50 of PMLA, and the statement recorded under Section 50 of the Act are quashed.

Referring to the reasons adduced by ED in the sealed cover, the court said they indicate no specific allegation against Natesha, except that of improper allotment of sites in favour

of Parvathy, and that he is close to realtors

The reasons recorded do not in any manner, whatsoever, indicate the involvement of the petitioner in any act of money laundering or to be in possession of proceeds of crime involved in money-laundering, or to be in possession of any records or property related to money laundering or crime, respectively. Reasons recorded do not in any manner, whatsoever, indicate the

The court reserved the liberty with the petitioner to initiate action under Section 62 of PMLA against the officer.

## The political & social cost of climate crisis

- We are fully aware of the consequences of advancing climate change on our planet's ecology, on our economies and our energy, health and food systems. The political and social consequences of unabated climate change and irreversible global warming are less understood and appreciated. These consequences are already changing societies. They are changing political dynamics.
- Both within countries and beyond, climate change is exacerbating income and wealth inequalities. There are increasing differences in the capacity to cope with higher temperatures, for example, through expensive air-conditioning, the ability and wherewithal to move from more inclement to relatively less affected regions and to corner increasingly depleted resources to maintain unsustainable lifestyles longer, even if eventually a ravaged planet will sink all humanity.
- Some assume that the use of artificial intelligence will find a way to tackle climate challenge. This is hubris of the worst kind. Time and again, the forces of nature have overwhelmed human artifice and will continue to do so with even greater intensity as the delicate threads that hold life together on our planet are snapped by human exploitation.
- ur earth is a tiny speck in the vastness of our Milky Way galaxy. And our galaxy is a speck in the unbounded vastness of the cosmos. Planetary extinction will be an insignificant episode in cosmic time. It is the humility that this should engender among humans which is missing and this lies at the heart of the ecological crisis, of which climate change is only an acute manifestation.
- How does climate change alter societies? Climate change is changing weather patterns and vast areas of productive farmland. For example, farmlands in Africa, are becoming arid deserts. This triggers large population movements within countries and across borders. Families are disrupted, children suffer from malnutrition and irreparable psychological damage and the whole social fabric begins to disintegrate. Their vulnerability exposes them to violence and exploitation by a powerful minority, which itself is contested by other such groups. Coercive power becomes the only instrument for holding a community together through fear.hose who migrate across borders are no less exposed to violence and exploitation and the migration issue becomes, as it has in many western societies, an instrument of political mobilisation through fear of the "outsider." The stability of societies in both source countries as well as target countries, is disturbed. As families disintegrate and scatter, their members lose their anchor and identity.Unstable societies are unequal societies; they are victims of oppression and injustice, they are often violent and cannot sustain a democratic polity. Stability does not mean stagnation. It means orderly change and aspirational societies. A sense of threat from the unfamiliar and fear of the outsider justifies authoritarian governance.People become complicit in the limitation and even suspension of their own rights even as they applaud the violation of the rights of those they consider "outsiders". Populism is an expression of this pathology.
- There is no doubt that the climate crisis as also the larger ecological crisis the world confronts today is the inevitable consequence of the fossil fuelbased pattern of economic development spawned by the industrial revolution of the 18th century. This has progressively become more resource- and energy-intensive and is mainly responsible for

## A child's failure in school exams is the system's failure

#### The role of state governments in the appointment of VCs has been eliminated, though education is a state subject and under the Concurrent List.

A 10-year-old child in class V must be held responsible for her learning outcomes. If her learning outcomes do not meet the 'benchmark' or 'expected level of learning', she must be 'detained'. What should be regarded as the failure of the pedagogy, curriculum and the collective system of schooling has, in effect, been shifted onto the child or the individual learner. The systematic dilution of the Right to Education (RTE, 2009) through successive amendments and the National Education Policy (NEP-2020) is a testament to this shift. The first amendment granted local governments the authority to 'ensure class-level learning', prompting

19 state governments to wholly reject the 'no-detention' policy. The recent abrogation of this policy for centrally governed schools is merely another step toward its inevitable denouement.

Over six decades ago, John Holt authored the seminal work, 'How Children Fail'. Since then, the discourse surrounding education has evolved, gradually acknowledging that no learner, irrespective of his/her situation, is intrinsically unwilling to learn - he/she simply does not wish to be 'taught.' A child cannot, with deliberate intent, choose not to learn

The educational narrative has also moved, to some extent, away from solely emphasising intelligence quotient in favour of a broader understanding of multiple intelligences.

There is no child who is inherently 'slow', 'weak', or a As Bourdieu and countless sociologists and 'failure'. Rather, it is the inadequacy of the learning environment that prevents the child from realising his or her full potential. In this sense, it is the failure of the system, not the failure of the child.Examinations should never serve as instruments of exclusion. Yet, each time we design an exam, we do so with a fixed understanding of merit, deeply rooted in the belief in the 'normal probability curve'. This framework tends to measure and categorise the learner based on rigid, prescriptive standards. Once a student is marked as below average' or labelled a 'failure', she is relegated to repeating the grade and the collective gaze of teachers, parents and peers begins to regard her as 'undeserving' or 'fit to fail'.

Multiple studies have revealed that repeating a grade does little to enhance a child's 'learning outcomes' or 'learning abilities'. The promise of additional resources or strategies for improvement - beyond the superficial provision of 'special' attention or reducing the learner to an object of pity - remains murky at best. Simply revisiting the same syllabus for another year fails to address the core needs of the learner, reinforcing only the hollow logic of 'meritocracy'.

What is considered merit is often dictated by those perched in positions of power. If monkeys were to define 'ability' as the capacity to climb a tree, all fish would inevitably fall short. In much the same way, a learner's abilities are shaped not merely by innate potential but also by their 'cultural capital'.



psychologists have pointed out, the learner's capacity to learn is intricately tied to their sociohistorical, economic and cultural background --factors over which they have little, if any, control.

Access to quality education, a rich curriculum and effective pedagogy is often determined by the learner's 'social assets'. In India, these assets extend beyond gender and physical abilities to encompass religion, caste, language and geography. The growing clamour for a uniform system of one nation, one education, one curriculum and one examination will only amplify the struggles faced by the already marginalised learners. Take, for instance, a differently-abled, tribal, Muslim girl in a conflict zone. Her ability to meet the prescribed learning expectations under the 'normal probability curve' is not a matter of will or intellect but of a convergence of obstacles beyond her control.India, with its vast

network of over 15 lakh schools and a student population exceeding 25 crore, paints a paradoxical picture of promise and neglect. Among these, 1.17 lakh schools operate with a single teacher, while a staggering two crore students remain deprived of access to what can truly be called 'quality' education. The teacher-student ratio is alarmingly skewed in several states, with recent reports revealing that 16 per cent of teacher posts lie vacant. This figure includes the patchwork addition of 'contractual' teachers.If salaries and recruitment processes were indicators of teaching quality, the disparities would be nothing short of scandalous: 23 per cent of

> schools lack the requisite number of teachers and even more suffer from a deficit of professionally trained educators.Despite lofty proclamations of education as an 'investment', budgetary allocations have persistently missed the mark, falling far below the recommended six per cent of the GDP. The numbers are stark - 79 per cent gross enrolment at the secondary level, vet 3.6 crore children remain out of school. To compound this, 11 per cent of the schools function without electricity and 13 per cent are without libraries, eroding the infrastructure critical for holistic learning. The abolition of the nodetention policy is, therefore, not merely an epistemic injustice, it is also a grave

social betrayal. The children who are envisioned as the architects of a developed India by 2047 are, in reality, ensnared in a system that fails them at every level.

This is not a call to abandon the procedures that assess learning, but rather an invitation to reimagine the very constructs of 'pass' and 'fail', of 'retention' and 'detention'. To declare that 'schools are no longer centres of learning but merely mid-day meal distribution hubs' is not only a dismissal of the crushing poverty faced by our people but also a betrayal of the profound human aspiration to cultivate knowledge within these spaces.

The delicate interplay between being a learner and a knower - a dynamic already fragile - risks being irreparably blurred with the dismantling of the nodetention policy. A child may 'fail' as a learner, but under no circumstance should her inherent agency as a knower be stripped away.

On the domestic front, slowing demand has led to tepid financial results for corporates. The stock markets are volatile, with bears being rampant for the first time in several years. Both Sensex and Nifty have fallen by about 12 per cent since September, largely due to an outflow by foreign institutional investors (FIIs).rowth seems to be sluggish, with the first advance estimates of national accounts projecting 6.4 per cent for FY 2025 as against a healthy 8.2 per cent in FY 2024. The geopolitical outlook also remains dismal amid an uneasy truce in the Israel-Hamas war, while the conflict in Ukraine shows little signs of ending soon. Moreover, US President Donald Trump looks set to upend American policies in a wide swathe of areas, especially trade, and this could affect India. However, there is a ray of hope. The slowdown in the

first half of the current fiscal is now being made up for with reports of rising rural consumption owing to higher agricultural output and the impact of direct benefit schemes. Urban demand continues to be laggard, but it is here that budgetary policies could make a significant impact. Providing income tax relief at the lower end of the spectrum could bring more money in the hands of the urban middle class. It is this segment that has provided buoyancy in direct tax revenues in recent years. A calibrated reduction in the lower tax slabs could give a much-needed fillip to urban consumption. The urgent need to bring about greater simplification and rationalisation of direct taxes cannot be overemphasised. Much has been done in recent years on this score, but an even greater paring of tax rules and regulations is required.

Shifting income tax filing to the online route was a major leap in this direction; government websites need to be upgraded to world-class levels as well, given the enormous information technology expertise available in this country. The Goods and

Services Tax (GST) must also be rescued from the maze of Byzantine regulations that are now even being commented upon by the global media. Popcorn tax slabs, symptomatic of the tax bureaucracy's overzealousness, hit the headlines. It may not strictly come under the purview of the Budget, but a signal of intent on ironing out complexities would be welcome.

The focus of Finance Minister Nirmala Sitharaman must be, however, on stimulating economic growth in view of the slowdown in FY2025. The slump in the second quarter was largely due to sluggish public spending during the General Election. The effort should be to make up for this in FY2026 by ensuring that capital expenditure remains on track so that the engine of growth is revved up yet again. It may ultimately be followed by a much-awaited cut in

interest rates by the Reserve Bank of India, thereby providing an even greater momentum to the economy. There are two key sectors that can also contribute to a revival in the coming financial year and need greater support. These are micro, small and medium enterprises (MSMEs) and export-linked industries. The MSME sector, one of the most vibrant segments of the economy, faced serious challenges during the Covid-19 pandemic. Credit assistance provided at the time did not ameliorate conditions adequately for these enterprises, which also had to face crippling payment delays from both public and

private sectors. A package of measures to provide easier credit and repayment facilities would revitalise a sector that generates an enormous number of jobs. The export-oriented sector poses greater challenges in the light of the Trump



administration's plans to raise tariffs. The extent of tariff hikes on imports are not known yet, but an As for the volatility in equity markets, the budgetary increase seems inevitable. While tariffs may go up higher for countries like China, there is no certainty that Indian goods will benefit in terms of getting a comparative advantage. Export units need to be given assistance to be able to compete with economies, again like China, where heavy state subsidies are the norm.

It is also a good time to gradually bring down tariff walls built in recent years to protect the domestic industry in view of the 'Make in India' programme.

This is not merely to blunt the attack from the US over high tariffs, but also to align these levies with international levels. Such a move could go a long way towards plugging this country into global supply chains.In contrast, Trump's new policy directive on

oil is likely to have a positive outcome for this country. His exhortation to the American oil industry to drill more could result in higher output and lower prices. World crude rates have already fallen from \$80 to \$78 per barrel since he made these comments. Any price softening will come as a relief by reducing the huge oil import bill and thereby the current account deficit as well. The proposals should also provide a conducive climate for higher investment, both from domestic and foreign sources. A critical element needing greater attention is the ease of doing business. Even the recent annual corporate summit at Davos became an occasion for several economists to highlight the urgency of improvement in this area. Undoubtedly, much has been done in recent years to cut red tape, but much more work is needed to make it easier to invest and run a business.

proposals may not curb short-term trends of FIIs pulling out and moving to places giving higher returns, like the US. But a stimulus to growth will underscore the fact that the India story is there for the long term. It would also ensure that the more viable foreign direct investment flows pick up significantly. The Finance Minister's aim must be to push growth to the range of 7-8 per cent. Only then will it be possible to come closer to the target of becoming a developed economy by 2047.

## Market hoping for capital gains tax cut

**NEW DELHI**. Foreign portfolio investors (FPIs) have been pulling out of the Indian equity markets in droves -- FPIs have been net sellers to the tune of R1.74 lakh crore since October

Several factors are attributed to capital outflow including Trump's policies, overheated Indian market and a relatively poor economic forecast. However, many in the market believe India's aggressive tax policies have not helped either.

The government in last year's budget increased tax on short-term capital gains from equities from 15% to 20%, and on long-term capital gains from 10% to 12.5%. With the budget around the corner, the investor community is hoping against hope for a possible cut in capital gains tax or removal of securities transaction tax (STT). It must be noted that STT was brought in 2004 after removing the long-term capital gains tax on equities.

In 2018 when the government brought back LTCG tax, it did not remove STT (currently at 0.1% on delivery-based sale and purchase of shares). Sameer Arora, founder and fund manager, Helios Capital Management, in a recent post on X said one way to show how wrong the FPIs are in selling Indian stocks is to cut long-term capital gains tax rate to 10%. While Arora's post reads like a lighthearted response to well-known investor Shankar Sharma's angsty column on how India has failed to stop foreign investors from exiting Indian markets, the general sense among investors is that the government was wrong in increasing capital gains tax in the first place. Venkat Nageswar Chalasani, chief executive the Association of Mutual Funds in India (AMFI), says the industry hopes the Budget would prioritise investor confidence by restoring indexation benefits for debt funds and rationalising the capital gains tax regime.

## Chinese-made AI model DeepSeek safe for use in India, says government source

Some of these deductions that are not available include:

THOUSE RENTALLOWANCE (HRA)

This is given by the employer to employee for expenses incurred toward rented accommodation. While caluclationg taxable income under the old regime, the sum of HRA exemption is deducted from taxable income, thereby allowing individuals to save on taxes.

INTEREST INCURRED ON HOME LOAN It is another popular deduction available under Section 24(b) in the old tax regime. A tax exemption of up to Rs 2 Lakh can be claimed towards interest incurred on home loan. LEAVE TRAVEL CONCESSION (LTC)

### Government unveils Rs 100 crore credit guarantee scheme to strengthen MSME manufacturing sector

- **NEW DELHI.** Government on Wednesday approved a Mutual Credit Guarantee Scheme aimed towards improving the credit availability for micro, small and medium manufacturing sectors, aligning with the goals set under the Make in India Union Budget 2024-25 for the MSME sector. The scheme will offer 60 per cent guarantee coverage through the National Credit Guarantee Trustee Company Limited (NCGTC) to Member Lending Institutions (MLIs) for loans up to Rs 100 crore, helping eligible MSMEs finance the purchase of equipment and machinery.
- This credit will enable MSME industries to purchase plant, machinery, and equipment, giving a boost to the sector and strengthening the Make in India initiative.The finance ministry, in a press release, revealed that the manufacturing sector currently contributes 17 per cent to India's GDP, providing jobs to more than 27.3 million workers. It further added that PM Modi's vision of 'Make in India, Make for the World' aims to increase this share to 25 per cent of GDP.
- Features of the scheme
- The borrower should be an MSME with valid Udyam Registration Number and the loan amount guaranteed should not surpass Rs 100 crores.
- Though the project cost could be higher, 75 per cent of it should be utilised for the equipment and machinery. In case the loan amount is Rs 50 crore or less, the borrower can repay it over a maximum of 8 years. ## Kerala startup Graamyam helps artisans go global with handmade, eco-friendly products

<u>Highlighting the problems</u> plaguing the sector, she says lack of revenue makes the younger generation ditch craft work.

**KOCHI.** Products from Kerala artisans have great demand in the international market. But these artisan communities struggle for visibility as they are unable to feature their products on a global platform.Aiming to help change this situation, Biju George — a mechanical engineer by training but with more than 20 years of experience in the IT field — and Rakkee Thimothy — a researcher from the Jawaharlal Nehru University shared a dream of developing a business model that would improve the reach of Indian craft in the global market.That was the time they were relocating to Kerala.

And they founded a social startup,

Graamyam, which is now bringing joy

into the artisan communities across the state. "We wanted to make a change in the lives of rural craftspeople," Rakkee tells TNIE.

Highlighting the problems plaguing the sector, she says lack of revenue makes the younger generation ditch craft work.

"Another major issue with traditional crafts is the absence of innovation in design and process. The laborious processes make the products costly and unaffordable to a large section of society," she adds.Further, the artisans are unable to generate interest in modern society for traditional crafts. "The sector also suffers from poor awareness in society about the quality and value of a traditional handicraft. Over the years, we have lost many valuable crafts because of a lack of patronage. Even now, many crafts are going through an existential crisis," Rakkee points out.

But what does Graamyam do? "Graamyam is an e-commerce platform that

exclusively deals with handmade, ecofriendly, and sustainable products. At Graamyam, we partner with the communities to introduce new designs and markets, thereby providing the artisans with better prices for the products," she says. The platform works with more than 70 craftspersons in 15 communities across Kerala.

"We work with handloom weavers, potters,



and ethnic communities crafting natural fibre and bamboo into home decor products," she say.Graamyam also has special initiatives for women to ensure they continue in the trade.

"For example, Killimanagalam mats are made by a group of women weavers. The unit was in a terrible condition. The first thing we did was to fund the maintenance of the building to ensure a safe working place for the women. We continued to use the same model for other communities too," Rakkee says. And the fact that the initiative has touched the lives of these artisan communities is evident in the

feedback of Sudhakaran, the secretary of Killimangalam Mat Weaving Society. "If Graamyam hadn't reached out to us, closing the unit would have been the only option left before us," he says. The platform features over 150 products ranging from terracotta, bamboo, wood, natural fibre and handloom cotton to metal items. "We are a very young startup, founded in 2019. We help the artisans create innovative designs to appeal to the aesthetics of modern society," Rakkee says. Currently, they are in the process

of establishing production lines and links with craftpersons in Kerala. "We will diversify to other southern states soon and then cover craft communities in other parts of the country," she says.

With plans in place to make Graamyam a global brand for home decor, the founders are in talks with big lifestyle chains in the US.

A goal-stacked night of 18 simultaneous kickoffs in the final group matchday of the competition's new format, eventually ended as the traditional format usually ended - with all the big guns still alive.Liverpool and Barcelona were the only teams already guaranteed a place in the top eight and automatic progress to the round of 16 and they stayed first and second respectively despite Liverpool losing 3-2 to PSV Eindhoven and Barca drawing 2-2 with Atalanta.Joining them are Arsenal, Inter Milan, Atletico Madrid, Bayer Leverkusen, Aston Villa and Lille, who produced the performance of the night to thrash Feyenoord 6-1.Although they eventually progressed reasonably comfortably, it was anything but for Man City at the Etihad. The 2023 European champions were exposed just before halftime when Raphael Onyedika Lille began the day in 12th but ended in brilliantly finished off a Brugge sweeping move.Mateo Kovacic pulled one back for

Dembele thrashed in another superb effort shortly after half-time to snuff out Stuttgart's unlikely comeback hopes.Stuttgart pulled one back after 77 minutes when Willian Pacho scored an own goal, but the damage was already done, with PSG keeping their hopes of a first Champions League trophy alive."There was a lot to be proud of,' Dembele told Canal Plus. "We've been doing well for some time now, controlling matches and winning our games."There are players who want to win things here with PSG, who run and fight for the shirt. 
